ON PLANE AlGEBRAIC CURVES PASSING THROUGH n-INDEPENDENT NODES

Abstract

Let a set of nodes $\mathcal X$ in the plain be *n*-independent, i.e., each node has a fundamental polynomial of degree n. Assume that $\#\mathcal{X} =$ $d(n, k) + 3 = (n + 1) + n + \cdots + (n - k + 5) + 3$ and $4 \leq k \leq n - 1$. In this paper we prove that there are at most seven linearly independent curves of degree less than or equal to k that pass through all the nodes of X . We provide a characterization of the case when there are exactly seven such curves. Namely, we prove that then the set $\mathcal X$ has a very special construction: all its nodes but three belong to a (maximal) curve of degree $k - 3$. Let us mention that in a series of such results this is the third one. At the end an important application to the bivariate polynomial interpolation is provided, which is essential also for the study of the Gasca-Maeztu conjecture.

1 Introduction

Denote the space of all bivariate polynomials of total degree not exceeding $n \times$

$$
\Pi_n = \left\{ \sum_{i+j \le n} a_{ij} x^i y^j \right\}.
$$

We have that

$$
N := N_n := \dim \Pi_n = (1/2)(n+1)(n+2).
$$

Denote by Π the space of all bivariate polynomials.

Consider a set of s distinct nodes $\mathcal{X} = \mathcal{X}_s = \{(x_1, y_1), (x_2, y_2), \ldots, (x_s, y_s)\}.$ The problem of finding a polynomial $p \in \Pi_n$, which satisfies the conditions

$$
p(x_i, y_i) = c_i, \quad i = 1, \dots, s,
$$
\n(1)

is called interpolation problem.

A polynomial $p \in \Pi_n$ is called a fundamental polynomial for a node $A \in \mathcal{X}$ if $p(A) = 1$ and $p|_{\mathcal{X} \setminus \{A\}} = 0$, where $p|_{\mathcal{X}}$ means the restriction of p on X. We denote this *n*-fundamental polynomial by $p_A^* := p_{A,X}^*$. Sometimes we call fundamental also a polynomial that vanishes at all nodes of X but one, since it is a nonzero constant times a fundamental polynomial.

Definition 1.1. The interpolation problem with a set of nodes \mathcal{X}_s is called n-poised if for any data (c_1, \ldots, c_s) there is a unique polynomial $p \in \Pi_n$ satisfying the interpolation conditions [\(1\)](#page-0-0).

A necessary condition of poisedness is $\#\mathcal{X}_s = s = N$.

Proposition 1.2. A set of nodes \mathcal{X}_N is n-poised if and only if

 $p \in \Pi_n$ and $p|_{\mathcal{X}_N} = 0 \implies p = 0.$

Next, let us consider the concept of *n*-independence (see $[1, 2]$ $[1, 2]$).

Definition 1.3. A set of nodes \mathcal{X}_s is called n-independent, if all its nodes have n-fundamental polynomials. Otherwise, it is called n-dependent.

Fundamental polynomials are linearly independent. Therefore a necessary condition of *n*-independence for \mathcal{X}_s is $s \leq N$.

1.1 Some Properties of n-Independent Nodes

Let us start with the following

Lemma 1.4 (Lemma 2.2, [\[3\]](#page-23-2)). Suppose that a set of nodes \mathcal{X} is n-independent and the nodes of another set Y have n-fundamental polynomials with respect to the set $\mathcal{Z} = \mathcal{X} \cup \mathcal{Y}$. Then the set \mathcal{Z} is n-independent too.

Denote the distance between the points A and B by $\rho(A, B)$. Let us recall the following (see [\[4,](#page-23-3) [5\]](#page-23-4))

Lemma 1.5. Suppose that $\mathcal{X}_s = \{A_i\}_{i=1}^s$ is an n-independent set. Then there is a number $\epsilon > 0$ such that any set $\mathcal{X}'_s = \{A'_i\}_{i=1}^s$, with the property that $\rho(A_i, A'_i) < \epsilon$, $i = 1, \ldots, s$, is n-independent too.

Next result concerns the extension of *n*-independent sets.

Lemma 1.6 (Lemma 2.1, [\[2\]](#page-23-1)). Any n-independent set X with $\#\mathcal{X} < N$ can be enlarged to an n-poised set.

Denote the linear space of polynomials of total degree at most n vanishing on $\mathcal X$ by

 $\mathcal{P}_{n,\mathcal{X}} = \left\{ p \in \Pi_n : p \big|_{\mathcal{X}} = 0 \right\}.$

The following two propositions are well-known (see, e.g.,[\[2\]](#page-23-1)).

Proposition 1.7. For any node set \mathcal{X} we have that

$$
\dim \mathcal{P}_{n,\mathcal{X}} = N - \#\mathcal{Y},
$$

where $\mathcal Y$ is a maximal n-independent subset of $\mathcal X$.

The following result is well-known.

Proposition 1.8. If a polynomial $p \in \Pi_n$ vanishes at $n+1$ points of a line ℓ , then we have that $p = \ell r$, where $r \in \Pi_{n-1}$.

A plane algebraic curve is the zero set of some bivariate polynomial of degree ≥ 1 . To simplify notation, we shall use the same letter p, say, to denote the polynomial p of degree ≥ 1 and the curve given by the equation $p(x, y) = 0.$

In the sequel we will need the following

Proposition 1.9 (Prop. 1.10, [\[3\]](#page-23-2)). Let \mathcal{X} be a set of nodes. Then the following two conditions are equivalent:

i) There is no algebraic curve of degree k passing through all the points of a set \mathcal{X} ;

ii) There is a k-poised subset of \mathcal{X} .

Set $d(n, k) := N_n - N_{n-k} = (1/2)k(2n + 3 - k)$. The following is a generalization of Proposition [1.8.](#page-2-0)

Proposition 1.10 (Prop. 3.1, [\[6\]](#page-23-5)). Let q be an algebraic curve of degree $k \leq n$ without multiple components. Then the following hold:

i) any subset of q containing more than $d(n, k)$ nodes is n-dependent;

ii) any subset \mathcal{X}_d of q containing exactly $d = d(n, k)$ nodes is nindependent if and only if the following condition holds:

$$
p \in \Pi_n \quad and \quad p|_{\mathcal{X}_d} = 0 \Longrightarrow p = qr, \text{ where } r \in \Pi_{n-k}.
$$
 (2)

Thus, according to Proposition [1.10,](#page-2-1) i), at most $d(n, k)$ nodes of X can lie in a curve q of degree $k \leq n$. This motivates the following

Definition 1.11 (Def. 3.1, [\[6\]](#page-23-5)). Given an n-independent set of nodes \mathcal{X}_s with $s \geq d(n,k)$. A curve of degree $k \leq n$ passing through $d(n,k)$ points of \mathcal{X}_s is called maximal.

We say that a node A of an *n*-poised set X uses a curve $q \in \Pi_s$, if the latter divides the *n*-fundamental polynomial of A, i.e., $p_A^* = qr$ for some $r \in \Pi_{n-s}.$

Let us bring a characterization of maximal curves:

Proposition 1.12 (Prop. 3.3, [\[6\]](#page-23-5)). Let a node set \mathcal{X}_N be n-poised. Then a curve μ of degree k, $k \leq n$, is a maximal curve if and only if it is used by all nodes in $\mathcal{X}_N \setminus \mu$.

Next result concerns maximal independent sets in curves.

Proposition 1.13 (Prop. 3.5, [\[5\]](#page-23-4)). Assume that σ is an algebraic curve of degree k without multiple components and $\mathcal{X}_s \subset \sigma$ is any n-independent node set of cardinality s, $s < d(n, k)$. Then the set \mathcal{X}_s can be extended to a maximal n-independent set $\mathcal{X}_d \subset \sigma$ of cardinality $d = d(n, k)$.

Below a replacement of a node in an n -independent set is described such that the set remains *n*-independent.

Lemma 1.14 (Lemma 6, [\[7\]](#page-23-6)). Assume that X is an n-independent node set and a node $A \in \mathcal{X}$ has an n-fundamental polynomial p_A^* such that $p_A^*(A') \neq$ 0. Then we can replace the node A with A' such that the resulted set $\mathcal{X}' :=$ $\mathcal{X} \cup \{A'\} \backslash \{A\}$ is again n-independent. In particular, such replacement can be done in the following two cases:

i) if a node $A \in \mathcal{X}$ belongs to several components of σ , then we can replace it with a node A′ , which belongs to only one (desired) component of σ;

ii) if a curve q is not a component of an n-fundamental polynomial p_A^{\star} then we can replace the node A with a node A' lying in q.

Finally, let us bring a well-known

Lemma 1.15. Suppose that m linearly independent curves pass through all the nodes of X. Then for any node $A \notin \mathcal{X}$ there are $m-1$ linearly independent curves in the linear span of given curves, passing through A and all the nodes of \mathcal{X} .

2 A series of results and main results

Let us start with the first result:

Theorem 2.1 (Th. 1, [\[8\]](#page-23-7)). Assume that $\mathcal X$ is an n-independent set of $d(n, k - 1) + 2$ nodes lying in a curve of degree k with $k \leq n$. Then the curve is determined uniquely by these nodes.

The second result in this series is the following

Theorem 2.2 (Th. 4.2, [\[5\]](#page-23-4)). Assume that $\mathcal X$ is an n-independent set of $d(n, k - 1) + 1$ nodes with $2 \leq k \leq n - 1$. Then at most two different curves of degree $\leq k$ may pass through all the nodes of X. Moreover, there are such two curves for the set $\mathcal X$ if and only if all the nodes of $\mathcal X$ but one lie in a maximal curve of degree $k - 1$.

Next result is the following

Theorem 2.3 (Th. 3, [\[7\]](#page-23-6)). Assume that $\mathcal X$ is an n-independent set of $d(n, k-2)+2$ nodes with $3 \leq k \leq n-1$. Then at most four linearly independent curves of degree $\leq k$ may pass through all the nodes of X. Moreover, there are such four curves for the set $\mathcal X$ if and only if all the nodes of $\mathcal X$ but one lie in a maximal curve of degree $k - 2$.

Now let us present the main result of this paper:

Theorem 2.4. Assume that X is an n-independent set of $d(n, k-3)+3$ nodes with $4 \leq k \leq n-1$. Then at most seven linearly independent curves of degree $\leq k$ may pass through all the nodes of X. Moreover, there are such seven curves for the set $\mathcal X$ if and only if all the nodes of $\mathcal X$ but three lie in a maximal curve of degree $k-3$.

Let us mention that the inverse implication in the "Moreover" part is straightforward. Indeed, assume that $d(n, k-3)$ nodes of X are located in a curve μ of degree k–3. Therefore, the curve μ is maximal and the remaining three nodes of X, denoted by A, B and C, are outside of it: $A, B, C \notin \mu$. Hence we have that

$$
\mathcal{P}_{k,\mathcal{X}} = \{p : p \in \Pi_k, p\mathcal{X} = 0\} = \{q\mu : q \in \Pi_3, q(A) = q(B) = q(C) = 0\}.
$$

Thus we get readily that dim $\mathcal{P}_{k,\mathcal{X}} = \dim \{q \in \Pi_3 : q(A) = q(B) = q(C) = 0\}$ $=\dim P_{3,\{A,B,C\}} = 10-3 = 7.$ Note that in the last equality we use Proposition [1.7](#page-2-2) and the fact that any three nodes are 3-independent.

We get also that it is enough to prove only the "Moreover" part. Indeed assume that the "Moreover" part is proved. Then assume that there are \geq 7 linearly independent curves satisfying the conditions mentioned in Theorem [2.4.](#page-4-0) Then as we proved above we have that $\dim \mathcal{P}_{k,\mathcal{X}} = 7$, i.e., there are no more such curves, Q.E.D.

Let us mention that in the proof of Theorem [2.4](#page-4-0) we find some interesting generalization of Theorem [2.3,](#page-4-1) where we increase by one the number of nodes and decrease by one the number of linearly independent curves:

Theorem 2.5. Assume that X is an n-independent set of $d(n, k - 2) + 3$ nodes with $3 \leq k \leq n-2$. Then at most three linearly independent curves of degree $\leq k$ may pass through all the nodes of X. Moreover, there are such three curves for the set $\mathcal X$ if and only if all the nodes of $\mathcal X$ lie in a curve of degree $k-1$, or all the nodes of X but three lie in a (maximal) curve of degree $k-2$.

3 Some preliminaries

Before we start the proof of Theorem [2.4,](#page-4-0) i.e., the proof of the "Moreover" part, we need to do considerable preliminary work.

Lemma 3.1. Assume that the hypotheses of Theorem [2.4](#page-4-0) hold and assume additionally that there is a curve $\sigma \in \Pi_{k-2}$ passing through all the nodes of X. Then all the nodes of X but three (collinear) lie in a maximal curve μ of $degree k - 3.$

Proof. First note that the curve σ is of exact degree $k-2$, since it passes through more than $d(n, k-3)$ n-independent nodes. This implies also that σ has no multiple component. Therefore, in view of Proposition [1.13,](#page-3-0) we can extend the set X till a maximal n-independent set $\mathcal{Z} \subset \sigma$, by adding $d(n, k-2) - d(n, k-3) - 3 = n - k + 1$ nodes, i.e.,

$$
\mathcal{Z} = \mathcal{X} \cup \mathcal{A}, \text{ where } \mathcal{A} = \{A_0, \ldots, A_{n-k}\}.
$$

In view of Lemma [1.14,](#page-3-1) i), we may suppose that the nodes from A are not intersection points of the components of the curve σ .

Next, we are going to prove that these $n - k + 1$ nodes are collinear together with $m \geq 3$ nodes from X. To this end denote the line through the nodes A_0 and A_1 by ℓ_{01} . Then for each $i = 2 \ldots, n - k$, choose a line ℓ_i passing through the node A_i , which is not a component of σ . We require also that each line passes through only one of the mentioned nodes and therefore the lines are distinct.

Now suppose that $p \in \Pi_k$ vanishes on X. Consider the polynomial $r = p\ell_{01}\ell_2\cdots\ell_{n-k}$. We have that $r \in \Pi_n$ and r vanishes on the node set Z, which is a maximal *n*-independent set in the curve σ . Therefore, we obtain that $r = \sigma s$, where $s \in \Pi_{n-k+2}$. Thus we have that

$$
p\ell_{01}\ell_2\cdots\ell_{n-k}=\sigma s
$$
, where $s\in\Pi_{n-k+2}$.

The lines ℓ_i , $i = 2, ..., n - k$, are not components of σ . Therefore, they are components of the polynomial s. Hence we obtain that

$$
p\ell_{01} = \sigma\gamma
$$
, where $\gamma \in \Pi_3$.

Now let us verify that ℓ_{01} is a component of q_{k-1} . Indeed, otherwise it is a component of the cubic γ and we get that

$$
p \in \Pi_k
$$
, $p|_{\mathcal{X}} = 0 \implies p = \sigma \beta$, where $\beta \in \Pi_2$.

Therefore, we get dim $\mathcal{P}_{k,\mathcal{X}} \leq 6$, which contradicts the hypothesis.

Thus we conclude that

$$
\sigma = \ell_{01} q_{k-3}, \text{ where } q_{k-3} \in \Pi_{k-3}.
$$
 (3)

Now let us show that all the nodes of A belong to ℓ_{01} . Suppose conversely that a node from A, say A_2 , does not belong to the line ℓ_{01} . Then in the same way as in the case of the line ℓ_{01} we get that ℓ_{02} is a component of σ . Therefore the node A_0 is an intersection point of two components of σ , i.e., ℓ_{01} and ℓ_{02} , which contradicts our assumption.

Thus we get that $A \subset \ell_{01}$. Next, let us verify that when extending the set $\mathcal{X} \subset \sigma$ till *n*-maximal set one has to locate the added nodes outside the component q_{k-3} . Indeed, what was proved already implies that the only possible location of such a node in q_{k-3} is an intersection point with ℓ_{01} . But in the latter case, by using Lemma [1.14,](#page-3-1) we can replace the node with one belonging only to the component q_{k-3} , which is a contradiction.

Hence, in view of Proposition [1.13](#page-3-0) we get that $\mu = q_{k-3}$ is a maximal curve for X. Therefore, it vanishes at exactly $d(n, k-3)$ nodes of X. The remaining three nodes, according to [\(3\)](#page-5-0), belong to the line ℓ_{01} . \Box

Lemma 3.2. Assume that $p_1, p_2 \in \Pi$, and p_1 has no multiple factors. Then, for sufficiently small ϵ , the polynomial $p_1+\epsilon p_2$ has no multiple factors either.

Proof. Assume by way of contradiction that there is a strictly decreasing sequence ϵ_n such that

$$
p_1 + \epsilon_n p_2 = q_n r_n^2, \text{ where } q_n, r_n \in \Pi \text{ and } \epsilon_n \to 0. \tag{4}
$$

We have that $\deg(p_1 + \epsilon_n p_2) \leq \max(\deg p_1, \deg p_2)$, and hence

$$
\deg q_n + 2\deg r_n \le \max(\deg p_1, \deg p_2).
$$

We deduce from here that there is a subsequence n_k such that

$$
\deg q_{n_k} = m_1 = const.
$$
 and
$$
\deg r_{n_k} = m_2 = const.
$$

Without loss of generality assume that this condition holds for all the sequence, i.e.,

$$
\{\epsilon_n\} \equiv \{\epsilon_{n_k}\}.\tag{5}
$$

Thus we have that

$$
q_n = \sum_{i+j \le m_1} a_{ij}^{(n)} x^i y^j, \quad r_n = \sum_{i+j \le m_2} b_{ij}^{(n)} x^i y^j.
$$

In view of [\(4\)](#page-6-0), by a normalization of r_n , i.e., by multiplying it by a constant c and dividing q_n by c^2 , we may assume that

$$
\max |b_{ij}^{(n)}| = 1 \,\forall n. \tag{6}
$$

Now, let us denote $M_n := \max |a_{ij}(n)|$.

Case 1. Assume that (a subsequence of) M_n is bounded: $M_n \leq M$. Note that in the case of the subsequence we may use again a replacement [\(5\)](#page-6-1) and have that the whole sequence M_n is bounded. In this case, by using the Bolzano–Weierstrass theorem, we have for a subsequence ${n_k}$ that

$$
a_{ij}^{(n_k)} \to a_{ij}^0
$$
 and $b_{ij}^{(n_k)} \to b_{ij}^0$, $\forall i, j$.

Here, we use the fact that number of the coefficients a_{ij} and b_{ij} is finite.

By setting $n = n_k$ in [\(4\)](#page-6-0) and tending $k \to \infty$ we obtain that

$$
p_1 = q_0 r_0^2,
$$

where

$$
q_0 = \sum_{i+j \leq m_1} a_{ij}^0 x^i y^j, \quad r_0 = \sum_{i+j \leq m_2} b_{ij}^0 x^i y^j.
$$

This contradicts the hypothesis for p_1 .

Case 2. By taking into account a replacement [\(5\)](#page-6-1) it remains to consider the case $M_n \to +\infty$.

In this case we have that for some subsequence $n = \{n_k\}$, we have that

$$
|a_{i_0j_0}^{(n_k)}| = \max_{i,j} |a_{ij}^{(n_k)}| \text{ and } |b_{i_1j_1}^{(n_k)}| = \max_{i,j} |b_{ij}^{(n_k)}| = 1 \ \forall k. \tag{7}
$$

Here, we use again the fact that number of the coefficients a_{ij} and b_{ij} is finite. Also, in the last equality we take into account [\(6\)](#page-6-2).

Now, let us set $n = n_k$ in [\(4\)](#page-6-0) and divide both sides by M_{n_k} to get

$$
\frac{1}{M_{n_k}}p_1 + \frac{\epsilon_{n_k}}{M_{n_k}}p_2 = \left(\frac{1}{M_{n_k}}q_{n_k}\right)r_{n_k}^2.
$$
 (8)

Evidently, the left hand side here tends to zero. For the right hand side we have that the coefficients of the polynomials $\frac{1}{M_{n_k}}q_{n_k}$ and r_{n_k} are bounded by 1. As above by using the Bolzano–Weierstrass theorem and passing to a new subsequence $\{n'_{k}\}\subset\{n_{k}\}$ we have that

$$
\frac{1}{M_{n'_{k}}}a_{ij}^{(n'_{k})} \to a_{ij}^{*} \text{ and } b_{ij}^{(n'_{k})} \to b_{ij}^{*}, \ \forall i, j.
$$

In view of [\(7\)](#page-7-0) we have that

$$
|a_{i_0j_0}^*| = 1 \text{ and } |b_{i_1j_1}^*| = 1. \tag{9}
$$

Now, by setting $n = n'_k$ in [\(4\)](#page-6-0) and tending $k \to \infty$ we get that

$$
0=q_*r_*^2,
$$

where

$$
q_* = \sum_{i+j \le m_1} a_{ij}^* x^i y^j, \quad r_0 = \sum_{i+j \le m_2} b_{ij}^* x^i y^j.
$$

In view of [\(9\)](#page-7-1) this is a contradiction.

Remark 3.3. In the same way one can prove the following statement:

Assume that $p_1, p_2 \in \Pi$, and p_1 is not reducible. Then, for sufficiently small ϵ , the polynomial $p_1 + \epsilon p_2$ is not reducible either.

 \Box

Proposition 3.4. Suppose that σ_i , $i = 0, \ldots, 6$ are seven linearly independent polynomials from Π_k passing through all the nodes of the set X given in Theorem [2.4.](#page-4-0) Then, without loss of generality, one may assume that each of these polynomials is of exact degree k and has no multiple factors, or, alternatively there are three linearly independent polynomials from Π_{k-1} passing through all the nodes of \mathcal{X} .

Proof. Clearly we may assume that a polynomial, say σ_0 , is of exact degree k. Indeed, assume conversely that the degree of each of these seven polynomials is less than or equal to $k-1$. Then the conclusion of Proposition takes place (or we have also that this clearly contradicts Theorem [2.3\)](#page-4-1).

Then we may assume that all the polynomials $\sigma_i, 0 \leq i \leq 6$ are of exact degree k. Indeed, it suffices to replace these polynomials with the seven polynomials σ_0 and $\sigma_i + \epsilon \sigma_i$, $1 \leq i \leq 6$, for a sufficiently small ϵ .

Next, we may assume that a polynomial, say σ_0 , has no multiple factors, or, alternatively there are three linearly independent polynomials from Π_{k-1} passing through all the nodes of X. Indeed assume conversely that each of these seven polynomials has a multiple factor. In view of Lemma [3.1](#page-5-1) each of these multiple factors is a line with multiplicity two. Thus, we have that

$$
\sigma_i = \ell_i^2 q_i, \ 0 \le i \le 6
$$
, where $\ell_i \in \Pi_1, \ q_i \in \Pi_{k-2}$. (10)

Then we replace these polynomials with the seven polynomials $\check{\sigma}_i = \ell_i q_i \in$ Π_{k-1} , $0 \leq i \leq 6$, which clearly vanish at the node set X. Let us verify that among these latter seven polynomials there are at least three linearly independent ones. Conversely assume that the seven polynomials are linear combinations of two of them, say $\check{\sigma}_i = \ell_i q_i$, $i = 0, 1$. Then we get readily that the seven linearly independent polynomails in [\(10\)](#page-8-0) are linear combinations of the following six polynomials:

$$
\ell_i q_i, x \ell_i q_i, y \ell_i q_i, i = 0, 1,
$$

which is a contradiction. Indeed, assume that $\ell_i = A_i x + B_i y + C_i$. Then for $i = 1, 2$ we have that

$$
\ell_i^2 q_i = (A_i x + B_i y + C_i)\ell_i q_i = Ax\ell_i q_i + B_i y\ell_i q_i + C_i \ell_i q_i.
$$

While, for $i = 2, 6$ by assuming $\ell_i q_i = a_i \ell_0 q_0 + b_i \ell_1 q_1$, we have that

$$
\ell_i^2 q_i = (A_i x + B_i y + C_i)\ell_i q_i = (A_i x + B_i y + C_i)(a_i \ell_1 q_1 + b_i \ell_2 q_2)
$$

$$
= a_i A_i x \ell_1 q_1 + a_i B_i y \ell_1 q_1 + a_i C_i \ell_1 q_1 + b_i A_i x \ell_2 q_2 + b_i B_i y \ell_2 q_2 + b_i C_i \ell_2 q_2.
$$

Finally, by assuming that σ_0 , has no multiple factors, let us replace the seven polynomials $\sigma_i, 0 \leq i \leq 6$, with the seven polynomials σ_0 and $\sigma_i + \epsilon \sigma_i, 1 \leq i \leq 6$, for a sufficiently small ϵ . This, in view of Lemma [3.2,](#page-6-3) \Box completes the proof.

Proposition 3.5. Suppose that σ_i , $i = 0, \ldots, 6$, are seven linearly independent polynomials from Π_k passing through all the nodes of the set X given in Theorem [2.4.](#page-4-0) In addition suppose that each of these polynomials is of exact degree k and has no multiple factors. Then there is a polynomial in the linear span of σ_i , $i = 1, \ldots, 6$, which has no multiple factors and differs from σ_0 with a factor of degree at least three.

Let us prove first

Lemma 3.6. Suppose that σ_0 , s_1 , s_2 are linearly independent polynomials of degree k. In addition suppose that each of these polynomials has no multiple factors. Suppose that any polynomial in the linear span of s_i , $i = 1, 2$, differs from σ_0 with a factor of degree at most two. Then we have that

$$
\sigma_0 = \tilde{\sigma}_0 \beta_0, \quad s_1 = \tilde{\sigma}_0 \beta_1, \quad s_2 = \tilde{\sigma}_0 \beta_2, \text{ where } \beta_i \in \Pi_2. \tag{11}
$$

Moreover, if β_0 has a common factor with β_1 as well as with β_2 then following alternative takes place: either,

(i) $\beta_i = \ell \ell_i$, $i = 0, 1, 2$, i.e., they have a common linear factor,

(ii) β_0 and $\beta_1 + \epsilon \beta_2$ are relatively prime $\forall \epsilon > 0$.

Furthermore, $\tilde{\sigma}_0$ is uniquely determined from the first two relations in [\(11\)](#page-9-0), if β_0 and β_1 are of degree two and relatively prime.

Proof. Consider the polynomials σ_0 , s_1 and s_2 . In view of the hypotheses and Lemma [3.2](#page-6-3) for sufficiently small ϵ we have that

$$
(s_1 + cs_2)\beta(c) = \sigma_0 \beta'(c),\tag{12}
$$

where $\beta_c, \beta_c' \in \Pi_2$ are relatively prime.

Note that $\beta(c)$ is a linear or conic component of σ_0 . Suppose that σ_0 has k such components. By considering $k+1$ sufficiently small values of c we derive that there are constants c_1 and c_2 such that $\beta(c_1) = \beta(c_2) =: \beta_0$.

Then we readily get from [\(12\)](#page-9-1) that

$$
s_1\beta_0 = \sigma_0\beta_1 \text{ and } s_2\beta_0 = \sigma_0\beta_2,\tag{13}
$$

where $\beta_1, \beta_2 \in \Pi_2$.

In the case when β_0 is relatively prime with β_1 or β_2 then it clearly divides σ_0 . Note that this evidently takes place if β_0 is linear. Then by denoting $\sigma_0 = \tilde{\sigma}_0 \beta_0$ we get that

$$
\sigma_0 = \tilde{\sigma}_0 \beta_0, \quad s_1 = \tilde{\sigma}_0 \beta_1, \quad s_2 = \tilde{\sigma}_0 \beta_2. \tag{14}
$$

It remains to consider the case when β_0 is a reducible conic and has a common linear component with β_1 as well as with β_2 . Thus suppose that $\beta_0 = \ell_0 \ell'_0$. After a cancellation with a linear polynomial in [\(13\)](#page-9-2) two cases are possible:

Case 1. $s_1 \ell_0 = \sigma_0 \ell_1$ and $s_2 \ell'_0 = \sigma_0 \ell_2$

Case 2. $s_1 \ell_0 = \sigma_0 \ell_1$ and $s_2 \ell_0 = \sigma_0 \ell_2$

In Case 1 $\beta_0 = \ell_0 \ell'_0$ again divides σ_0 and we get [\(14\)](#page-9-3).

In Case 2 $\beta_0 = \ell_0$ divides σ_0 and we get [\(14\)](#page-9-3), where β_0 therefore β_1 and β_2 are linear. Thus [\(11\)](#page-9-0) is proved.

Now, consider the "Moreover" case, i.e., each pair in β_i , $i = 1, 2, 3$, has a common factor. Assume that $\beta_0 = \ell \ell_0$ and $\beta_1 = \ell \ell_1$. Then we have that either $\beta_2 = \ell \ell_2$, or $\beta_2 = \ell_0 \ell_1$. The first case reduces to the item (i). Let us consider the second case. In is easily seen that the polynomials $\beta_0 = \ell \ell_0$ and $\beta_0 + \epsilon \beta_2 = \ell_1(\ell + \epsilon \ell_0)$ have no common factor.

Finally note that if β_0 and β_1 have no common factor then $\tilde{\sigma}_0$ is the greatest common divisor of σ_0 and s_1 . Hence it is uniquely determined from the first two relations in [\(11\)](#page-9-0). \Box

Now we are in a position to present

Proof of Proposition [3.5.](#page-9-4) Assume by way of contradiction that any polynomial from

 $S :=$ Linear span $\{\sigma_1, \ldots, \sigma_6\},\$

differs from σ_0 with a factor of degree at most two.

According to Lemma [3.6](#page-9-5) for the polynomial σ_0 and any two polynomials from S the relation (11) takes place.

Case 1. Assume that there is a polynomial $s_1 \in S$, say it is $s_1 = \sigma_1$, for which the relation [\(11\)](#page-9-0) holds with β_1 having degree two and beeing relatively prime with β_0 .

Then, according to Lemma [3.6,](#page-9-5) $\tilde{\sigma}_0$ is determined uniquelly.

Now, we apply Lemma [3.6](#page-9-5) successively with the triples of polynomials $\sigma_0, \sigma_1, \sigma_i, i = 2, \ldots, 6$, and get that

$$
\sigma_i = \tilde{\sigma}_0 \beta_i, i = 0, \ldots, 6
$$
, where $\beta_i \in \Pi_2$.

Clearly the seven polynomials β_i here, and consequently the seven polynomials σ_i are linearly dependent, which contradicts our assumption.

Case 2. Now, assume that for any triple of polynomials $\sigma_0, s_1 :=$ $\sigma_i, s_2 := \sigma_j$ the relation [\(11\)](#page-9-0) holds with β_0 has a common factor with β_i as well as with β_i and all three have degree two.

If for some triple the alternative (ii) holds then we easily arrive to Case 1 with $s_1 := \sigma_i + \epsilon \sigma_j$.

Thus we conclude that the case of alternative (i) holds:

 $\beta_0 = \ell \ell_0, \beta_i = \ell \ell_i, \beta_j = \ell \ell_j.$

In this case [\(11\)](#page-9-0) holds also with β 's beeing linear polynomials:

 $\sigma_0 = \hat{\sigma}_0 \ell_0, \sigma_i = \hat{\sigma}_0 \ell_i, \sigma_j = \hat{\sigma}_0 \ell_j, \text{ where } \hat{\sigma} = \tilde{\sigma} \ell.$

Thus we conclude that for all triples $\sigma_0, \sigma_i, \sigma_j$ [\(11\)](#page-9-0) holds with linear βs. In this case $\tilde{\sigma}_0$ is uniquely determined from the first two relations in $(11).$ $(11).$

Now, we apply Lemma [3.6,](#page-9-5) successively with the triples of polynomials $\sigma_0, s_1 := \sigma_1, s_2 := \sigma_i, i = 2, 3, \text{ and get that}$

$$
\sigma_i = \tilde{\sigma}_0 \ell_i, i = 0, \ldots, 3
$$
, where $\ell_i \in \Pi_1$.

Clearly the four linear polynomials ℓ_i here, and consequently the four polynomials σ_i are linearly dependent, which contradicts our assumption. \Box

4 The existence of three curves of degree $k-1$

Proposition 4.1. Assume that the hypotheses of Theorem [2.4](#page-4-0) hold. Then, there are three linearly independent curves of degree $k - 1$ passing through all the nodes of the set \mathcal{X} .

Proof. Let $\sigma_0, \ldots, \sigma_6$ be the seven curves of degree $\leq k$ that pass through all the nodes of the *n*-independent set X with $\#\mathcal{X} = d(n, k-3) + 3$.

In view of Proposition [3.4,](#page-8-1) without loss of generality, assume that each of these polynomials is of exact degree k and has no multiple factors.

Step 1. Here we will prove that there is at least one curve of degree $k-1$ passing through all the nodes of the set X.

We start by choosing two nodes $B_1, B_2 \notin \mathcal{X}$ such that the following two conditions are satisfied:

i) the set $\mathcal{X} \cup \{B_1, B_2\}$ is *n*-independent;

ii) the line through B_1 and B_2 does not pass through any node from \mathcal{X} ;

Let us verify that one can find such nodes. Indeed, in view of Lemma [1.6,](#page-1-0) we can start by choosing some nodes $B_i = B'_i$, $i = 1, 2$, satisfying the condition i). Then, according to Lemma [1.5,](#page-1-1) for some positive ϵ all the nodes in ϵ neighborhoods of B'_i , $i = 1, 2$, satisfy the condition i).

Finally, from these neighborhoods we can choose the nodes B_i , $i =$ 1, 2, satisfying the condition ii) too.

Denote by ℓ_0 the line passing through B_1 and B_2 .

Next we find one more node $B_3 \in \ell_0$ such that the set $\mathcal{X} \cup \{B_1, B_2, B_3\}$ is n-independent. Indeed, if there is no such node then we obtain that

$$
p \in \Pi_k
$$
, $p|_{\mathcal{X} \cup \{B_1, B_2\}} = 0 \Rightarrow p|_{\ell_0} = 0$.

Therefore $p = \ell_0 q$, where $q \in \Pi_{k-1}$ and $q|_{\mathcal{X}} = 0$.

Hence, if there is no B_3 then, according to Lemma [1.15,](#page-3-2) there are five linearly independent polynomials $p \in \Pi_k$ satisfying the condition $p|_{\mathcal{X} \cup \{B_1, B_2\}} =$ 0. Therefore, there are five linearly independent $q \in \Pi_{k-1}$ satisfying the condition $q|_{\mathcal{X}} = 0$.

Next, we find successively two nodes $B_4, B_5 \in \ell_0$ such that the set $\mathcal{X} \cup \mathcal{B}_5$ is *n*-independent, where $\mathcal{B}_5 := \{B_1, B_2, B_3, B_4, B_5\}.$

Indeed, if one cannot find the nodes B_4 or B_5 , then, in the same way as above, there are four or three linearly independent polynomials $q \in \Pi_{k-1}$ satisfying the condition $q|\chi = 0$, respectively.

Next, in view of Lemma [1.15,](#page-3-2) there are two curves of degree at most k, which pass through all the nodes of $\mathcal{X} \cup \mathcal{B}_5$.

Denote these curves by σ_0, σ'_0 . Consider the curve σ_0 . Notice that σ_0 passes through more than $d(n, k-3)$ nodes and, therefore, its degree equals either to $k-2, k-1$ or k.

The case of degree $k - 2$ can be excluded in view of Lemma [3.1.](#page-5-1)

If the curve σ_0 or σ'_0 is of degree $k-1$ then we are done.

Then, if a curve σ_0, σ'_0 has a multiple factor then by throwing away the excessed factor we get again a polynomial from Π_{k-1} vanishing on $\mathcal{X},$ Q.E.D.

Thus we may assume that both curves σ_0 and σ'_0 are of degree k and have no multiple factors.

Consider again the curve σ_0 . In view of Proposition [1.13,](#page-3-0) we can extend the set $\mathcal{X} \cup \mathcal{B}_5$ till a maximal *n*-independent set $\mathcal{Z} \subset \sigma_0$, by adding $d(n, k)$ − $(d(n, k-3) + 3) - 5 = 3(n - k) + 1$ nodes, i.e.,

 $\mathcal{Z} = \mathcal{X} \cup \mathcal{B}_5 \cup \mathcal{A}$, where $\#\mathcal{A} = 3(n-k)+1 = [3(n-k-1)-1]+5$.

Let us start with the description of the choice of $3(n-k-1)-1$ nodes from A.

By using Proposition [3.5](#page-9-4) we find a curve σ in the linear span of σ_i , $i =$ $1, \ldots, 6$, which has no multiple factors and differs from σ_0 with a factor of degree at least three:

 $\sigma = \gamma q$, $\sigma_0 = \gamma_0 q$, $q \in \Pi_{k-d}$ with $d = \deg \gamma = \deg \gamma_0 \geq 3$. We have that γ and σ_0 are relatively prime.

Consider a line ℓ_1 intersecting γ_0 at three different points, say A_1, A_2 and A_3 , which do not belong to $\sigma \cup \ell_0$. By using a continuity argument we may assume that the line ℓ_1 is not parallel to any line component of σ_0 . Let $\ell_i, i = 1, \ldots, n - k - 1$, be lines parallel to ℓ_1 and enough close to it so that each of them intersects γ_0 at three different points, which do not belong to $\sigma \cup \ell_0$. We assume also that these intersection points are different from the nodes of $\mathcal{X} \cup \mathcal{B}_5$. Let us dismiss an intersection point, say A_1 and denote the desired set of the remaining $3(n - k - 1) - 1$ intersection nodes by $\mathcal{A}(-1)$.

Let us prove that the set $\mathcal{Y} := \mathcal{X} \cup \mathcal{B}_5 \cup \mathcal{A}(-1)$ is *n*-independent.

We have that the set $\mathcal{A}(-1)$ is a subset of Berzolari-Radon construction of degree $n - k - 1$. Hence it is $(n - k - 1)$ -independent. Now suppose that $p_{A,\mathcal{A}(-1)}^{\star}$ is a fundamental polynomial of a node $A \in \mathcal{A}(-1)$ of degree $n-k-1$. Then the polynomial $\sigma \ell_0 p_{A,\mathcal{A}(-1)}^*$ is an n-fundamental polynomial of the node A for the set $\mathcal Z$. Thus, according to Lemma [1.4,](#page-1-2) the set $\mathcal Z$ is n-independent.

Finally, according to Proposition [1.13,](#page-3-0) we extend the set $\mathcal{Y} \subset \sigma_0$ with the last 5 nodes till a maximal *n*-independent set $\mathcal{Z} \subset \sigma_0$. The set of these 5 points we denote by \mathcal{A}_5 .

Thus the set $\mathcal{Z} := \mathcal{Y} \cup \mathcal{A}_5$ is a maximal *n*-independent set in σ_0 . We have also that $\mathcal{A} = \mathcal{A}(-1) \cup \mathcal{A}_5$.

Now suppose that $\sigma^* \in \Pi_k$ vanishes on X and \mathcal{A}_5 . According to Lemma [1.15](#page-3-2) there are $2 = 7 - 5$ such polynomials. Consider the polynomial

$$
p = \sigma^* \ell_0 \ell_1 \cdots \ell_{n-k-1}.
$$

We have that $p \in \Pi_n$ and it vanishes on the constructed maximal nindependent set $\mathcal{Z} \subset \sigma_0$. Therefore, we have that

$$
\sigma^* \ell_0 \ell_1 \cdots \ell_{n-k-1} = \sigma_0 s, \text{ where } s \in \Pi_{n-k}.
$$

The lines ℓ_i , $i = 1, ..., n - k - 1$, are not components of σ_0 . Therefore, they are components of the polynomial s. Thus we obtain that

$$
\sigma^*\ell_0 = \sigma_0\ell, \text{ where } \ell \in \Pi_1.
$$

Since there are two linearly independent polynomials σ^* therefore $\ell_0 \neq \ell_1$ ℓ and we have that ℓ_0 is a component of σ_0 :

$$
\sigma_0 = \ell_0 q, \text{ where } q \in \Pi_{k-1}.
$$

We conclude from here that q vanishes on \mathcal{X} .

Step 2. Here we will prove that there are three linearly independent curves of degree $k-1$ passing through all the nodes of the set X.

We find a line ℓ_0 and collinear nodes $B_1, \ldots, B_4 \in \ell_0$, as in the Step 1, such that $\ell_0 \cap \mathcal{X} = \emptyset$ and the set $\mathcal{X} \cup \mathcal{B}_4$ is *n*-independent, where $\mathcal{B}_4 :=$ ${B_1, B_2, B_3, B_4}.$

Recall that if one cannot find the nodes then there are four linearly independent curves of degree $\leq k-1$ passing through all the nodes of X.

Next, in view of Proposition [1.15,](#page-3-2) there are three linearly independent curves of degree at most k , which pass through all the nodes of the set $\mathcal{X} \cup \mathcal{B}_4$.

Denote these curves by $\sigma_0, \sigma'_0, \sigma''_0$.

If a curve here, say σ_0 is of degree $\leq k-1$ and has no multiple components then instead of given triple of curves we consider the curves $\ell_0\sigma_0$, $\ell_1\sigma_0$, $\ell_2\sigma_0$, where the lines ℓ_i are chosen such that these three curves are linearly independent and have no multiple factors.

Next, if a curve σ_0 , σ'_0 , σ''_0 has a multiple factor then by throwing away the excessed factor we get again a polynomial from Π_{k-1} vanishing on $\mathcal{X} \cup \mathcal{B}_4$, i.e., we are in the situation considered in the previous paragraph.

Hence, we may consider only the case when each of the given three polynomials is of exact degree k and has no multiple components.

Now consider the curve σ_0 . In view of Proposition [1.13,](#page-3-0) we can extend the set $\mathcal{X} \cup \mathcal{B}_4$ till a maximal *n*-independent set $\mathcal{Z} \subset \sigma_0$, by adding $d(n, k)$ − $(d(n, k-3) + 3) - 4 = 3(n - k) + 2$ nodes, i.e.,

$$
\mathcal{Z} = \mathcal{X} \cup \mathcal{B}_4 \cup \mathcal{A}, \text{ where } \# \mathcal{A} = 3(n-k) + 2 = [3(n-k-1) - 1] + 1 + 5.
$$

We find the set of $3(n - k - 1) - 1$ points from A in the same way as in Step 1 and denote it again by $\mathcal{A}(-1)$.

Then, in the same way as in Step 1, we prove the independence of the set $\mathcal{Y} := \mathcal{X} \cup \mathcal{B}_4 \cup \mathcal{A}(-1)$.

Next, we choose a node $\tilde{A}_1 \in \ell_1$ such that $\tilde{A}_1 \in \sigma_0 \setminus q$, where q is one of the two polynomials of degree $k-1$ vanishing on \mathcal{X} , found in Step 1. We assume also that \tilde{A}_1 does not belong to the line ℓ_0 .

Now let us prove the independence of the set $\mathcal{Y}' := \mathcal{Y} \cup \{\tilde{A}_1\}$. For this end, in view of Lemma [1.4,](#page-1-2) it sufficrs to find a fundamental polynomial of the node \tilde{A}_1 with respect to the set \mathcal{Y}' .

We readily obtain that

$$
p_{\tilde{A}_1,\mathcal{Y}'}^{\star} = q\ell_0\ell_2\cdots\ell_{n-k-1}\ell'\ell'',
$$

where ℓ' and ℓ'' are lines different from ℓ_1 and pass through the nodes A_2 and A_3 , respectively. Recall from Step 1 that these latter two nodes belong to $\mathcal{A}(-1) \cap \ell_1$.

Finally, as in Step 1, we extend the set $\mathcal{Y}' \subset \sigma_0$, according to Propo-sition [1.13,](#page-3-0) with the set of last 5 nodes, denoted by A_5 , till a maximal *n*-independent set in σ_0 .

Thus the set $\mathcal{Z} := \mathcal{Y}' \cup \mathcal{A}_5$ is a maximal *n*-independent set in σ_0 .

Now suppose that $\sigma^* \in \Pi_k$ vanishes on X and the 5 nodes of \mathcal{A}_5 . According to Lemma [1.15](#page-3-2) there are at least two such polynomials. Consider the polynomial $r = \sigma^* \ell_0 \ell_1 \cdots \ell_{n-k-1}$. We have that $r \in \Pi_n$ and r vanishes on the node set Z, which is a maximal *n*-independent set in the curve σ_0 . Therefore, we have that

$$
\sigma^* \ell_0 \ell_1 \cdots \ell_{n-k-1} = \sigma_0 s, \text{ where } s \in \Pi_{n-k}.
$$

The lines ℓ_i , $i = 1, ..., n - k - 1$, are not components of σ_0 . Therefore, they are components of the polynomial s. Thus we obtain that

$$
\sigma^*\ell_0 = \sigma_0\ell, \text{ where } \ell \in \Pi_1.
$$

Since there are two linearly independent polynomials p therefore $\ell_0 \neq \ell$ and we have that ℓ_0 is a component of σ_0 .

Thus we conclude that

$$
\sigma_0 = \ell_0 q_{k-1}, \text{ where } q_{k-1} \in \Pi_{k-1}.
$$

In the same way by considering the curves σ'_0 and σ''_0 we get

$$
\sigma'_0 = \ell_0 q'_{k-1}
$$
, where $q'_{k-1} \in \Pi_{k-1}$.
\n $\sigma''_0 = \ell_0 q''_{k-1}$, where $q''_{k-1} \in \Pi_{k-1}$.

Thus we obtain three linearly independent curves $q_{k-1}, q'_{k-1}, q''_{k-1} \in \Pi_{k-1}$ vanishing at all the nodes of \mathcal{X} . п

5 Proofs of Theorems [2.4](#page-4-0) and [2.5](#page-4-2)

Let us start with

Proof. Proof of Theorem [2.5.](#page-4-2)

Assume by way of contradiction that there are four curves passing through all the nodes of the set \mathcal{X} . Then, according to Theorem [2.3,](#page-4-1) all the nodes of X but three belong to a maximal curve μ of degree $k-2$. The curve μ is maximal and the remaining three nodes of X, denoted by A, B and C, are outside of it: $A, B, C \notin \mu$. Hence we have that

$$
\mathcal{P}_{k,\mathcal{X}} = \{p : p \in \Pi_k, p_{\mathcal{X}} = 0\} = \{q\mu : q \in \Pi_2, q(A) = q(B) = q(C) = 0\}.
$$

Thus we get readily that dim $\mathcal{P}_{k,\mathcal{X}} = \dim \{q \in \Pi_2 : q(A) = q(B) = q(C) = 0\}$ $\dim \mathcal{P}_{2,\{A,B,C\}} = 6-3=3$, which contradicts our assumption. Note that in the last equality we use Proposition [1.7](#page-2-2) and the fact that any three nodes are 2-independent.

Consider the three curves $\sigma_i \in \Pi_k$ i = 0, 1, 2, passing through all the nodes of $\mathcal X$. If one of them is of degree $k-1$ then the conclusion of Theorem is satisfied and we are done. Thus, we may assume that each curve is of degree k and has no multiple component.

Now consider the curve σ_0 .

By using Proposition [1.13](#page-3-0) let us extend the set $\mathcal X$ till a maximal nindependent set $\mathcal{Z} \subset \sigma_0$. Since $\#\mathcal{Z} = d(n, k)$, we need to add a set of $d(n, k) - (d(n, k-2) + 3) = 2(n-k) + 2$ nodes, denoted by

$$
\mathcal{A} := \{A_1, \ldots, A_{2(n-k)+2}\}.
$$

Thus we have that $\mathcal{Z} := \mathcal{X} \cup \mathcal{A}$.

In view of Lemma [1.14,](#page-3-1) i), we require that each node of A may belong only to one component of the curve σ_0 .

Case 1, $n = k + 2$, $\mathcal{A} := \{A_1, \ldots, A_6\}.$

Consider 5 nodes from A and a conic β^* passing through them. Denote the sixth node by A^* .

We have three polynomials from Π_k vanishing on X. By using Lemma [1.15](#page-3-2) we get two linearly independent curves denoted by σ^* , of degree at most k, that pass through all the nodes of X and the node $A^* \in \mathcal{A}$.

Thus we may consider a curve σ^* by assuming that $\sigma^* \neq \sigma_0$. Now, notice that the polynomial $\sigma^* \beta^*$ of degree n vanishes at all the nodes of $\mathcal{Z} \subset$ σ_0 . Consequently, according to Proposition [1.10,](#page-2-1) σ_0 divides this polynomial:

$$
\sigma^* \beta^* = \sigma_0 \beta, \quad \beta \in \Pi_2. \tag{15}
$$

We have that $\beta^* \neq \beta$ since $\sigma^* \neq \sigma_0$.

Hence if β^* is irreducible then it divides σ_0 .

Now suppose that β^* is reducible: $\beta^* = \ell_1 \ell_2$, where $\ell_i \in \Pi_1$.

Then we have that both lines ℓ_1, ℓ_2 cannot divide β , hence we obtain that either both lines are component of σ_0 or only one of the lines ℓ_1, ℓ_2 is a component of σ_0 .

Let us consider the latter case. Suppose that only the line ℓ_1 is a component of σ_0 and ℓ_2 is a component of β . Then we get from [\(15\)](#page-16-0) that

$$
\sigma^* \ell_1 = \sigma_0 \ell, \text{ where } \ell \in \Pi_1. \tag{16}
$$

Now, we have that $\sigma_0 = \ell_1 \bar{\sigma}_0$, where $\bar{\sigma}_0 \in \Pi_{k-1}$.

Therefore we get from[\(16\)](#page-16-1) that $\sigma^* = \ell \bar{\sigma}_0$.

From the last two equalities we conclude that $\mathcal{X} \subset \bar{\sigma}_0 \cup \{E\}$, where $E = \ell_1 \cap \ell$.

Therefore all the nodes of \mathcal{X} , except possibly E , belong to the curve $\bar{\sigma}_0 \in \Pi_{k-1}$. Here $\bar{\sigma}_0 \in \Pi_{k-1}$ is a component of σ_0 and E belongs to a line component of σ_0 .

We briefly express the above conditions by saying that the line component ℓ_1 of σ_0 satisfies (-1) node condition for X.

At the end we will see that if this property holds for all three given curves then we can readily complete the proof of Theorem.

Therefore, from now on we may assume that the equality [\(15\)](#page-16-0) implies that $\deg \beta^* = 2$ and β^* is a component of σ_0 . We obtain also that β^* is determined uniquely by the 5 nodes from \mathcal{A} .

Next, we are going to prove that there is a conic passing through all the six nodes of A. Assume by way of contradiction that there is no such conic. Denote by β_i the conic passing through the five nodes of $\mathcal{A}_6 \setminus \{A_i\}, i = 1, 2$.

We readily get that these two conics are different. Then, by the above argument, we have that β_1 and β_2 are components of σ_0 . First assume that one of these two conics, say, β_1 , is irreducible. Then consider a common node of β_1 and β_2 , say, A_3 . It is easily seen that A_3 belongs to two different components of σ_0 . One is β_1 and another is β_2 if it is irreducible or a line component of β_2 if it is reducible.

Now, assume that both β_1 and β_2 are reducible:

$$
\beta_1=\ell_1\ell_1',\quad \beta_2=\ell_2\ell_2'.
$$

Wihout loss of generality assume that

$$
\ell_1 \neq \ell_2, \quad \ell_1 \neq \ell'_2. \tag{17}
$$

Now we have that ℓ_1 passes through at least one of the common nodes A_3, \ldots, A_6 , say A_3 . Then A_3 belongs either to ℓ_2 or ℓ'_2 . In both cases, in view of (17) , we have that A_3 belongs to two different line components of σ_0 , which is a contradiction.

Thus we proved that $A \subset \beta_0$, where $\beta_0 \in \Pi_2$. Next let us show that β_0 divides σ_0 or the conclusion of Theorem holds.

Consider a polynomial $\sigma \in \Pi_k$ that vanishes on X. Notice that the following polynomial $\sigma \beta_0$ of degree $k + 2 \leq n$ vanishes at all the $d(n, k)$ nodes of $\mathcal{Z} \subset \sigma_0$. Consequently, according to Proposition [1.10,](#page-2-1) σ_0 divides this polynomial:

$$
\sigma \beta_0 = \sigma_0 \beta, \quad \beta \in \Pi_2. \tag{18}
$$

This is a type [\(15\)](#page-16-0) equality which, as we mentioned above, implies that deg $\beta_0 = 2$ and β_0 is a component of σ_0 :

$$
\sigma = \beta_0 q, \quad q \in \Pi_{k-2}.
$$

We conclude also that β_0 is uniquely determined by any 5 nodes from A.

Thus we get that when completing the set $\mathcal{X} \subset \sigma_0$ till a maximal nindependent set $\mathcal{Z} = \mathcal{X} \cup \mathcal{A}$ we have to add all the six nodes of \mathcal{A} to the conic β_0 . Let us verify that the added nodes cannot belong to another component q. Indeed, suppose conversely that a node belongs to $\beta_0 \cap q$. Then, in view of Lemma [1.14,](#page-3-1) we can move the node to $q \setminus \beta_0$ such that the resulted set is also n-independent. This is a contradiction, since now clearly the six nodes do not belong to a conic. Indeed, the five nodes determine a unique conic and the sixth node is outside of it. This shows that the factor $r \in \Pi_{k-2}$ to which one can not add a new independent node is merely maximal with respect to X. This means that r passes through exactly $d(n, k)$ nodes of X.

Case 2, $n > k + 3$.

Consider a subset of A of cardinality 4 and denote it by A_4 . Denote also by $\mathcal{A} := \mathcal{A} \setminus \mathcal{A}_4$. We have that $\#\mathcal{A} = 2(n-k) - 2$.

We have three polynomials from Π_k vanishing on X. By using Lemma [1.15](#page-3-2) we get two linearly independent curves denoted by σ^* , of degree at most k, that pass through all the nodes of $\mathcal X$ and an arbitrary node $A^* \in \mathcal A$, which will be specified below. We call this latter node associated with σ^* . Thus we may assume that $\sigma^* \neq \sigma_0$.

We associate another node $A' \in \overline{A}$ with the set A_4 and denote by β' a conic that passes through the four nodes of \mathcal{A}_4 and A' .

For any line component ℓ of σ_0 denote by r_{ℓ} the polynomial from Π_{k-1} for which

$$
\sigma_0 = \ell r_\ell \tag{19}
$$

holds.

Assume that a line component ℓ of the curve σ_0 , passes through exactly m nodes from \mathcal{X} , at which r_{ℓ} does not vanish. Then we obtain from [\(19\)](#page-17-0) that $r_{\ell} \in \Pi_{k-1}$ vanishes at the all nodes of the set X except m nodes, which belong to ℓ .

Thus, either for a line component we have that $m \leq 1$, or for all line components of σ_0 we have that $m \geq 2$, meaning that the following condition takes place:

(C) Any line component of the curve σ_0 , passes through at least two nodes from \mathcal{X} , at which r_ℓ does not vanish.

It is easily seen that the condition $m \leq 1$, for ℓ means that the line component ℓ of σ_0 satisfies the (−1) node condition for χ .

Later, by using the condition (C) , we intend to divide the set of nodes $\bar{\mathcal{A}}$ into $n - k - 2$ pairs such that the lines $\ell_1, \ldots, \ell_{n-k-2}$, through them, respectively, are not components of σ_0 . The remaining two nodes denoted by A^* and A' we associate with the curve σ^* and A_4 , respectively.

Now, let us continue the proof by assuming that the above-described division of \overline{A} is established.

Notice that the following polynomial $\sigma^* \beta' \ell_1 \ldots \ell_{n-k-2}$ of degree n vanishes at all the $d(n, k)$ nodes of $\mathcal{Z} \subset \sigma_0$. Consequently, according to Proposition [1.10,](#page-2-1) σ_0 divides this polynomial:

$$
\sigma^* \beta' \ell_1 \ell_2 \dots \ell_{n-k-2} = \sigma_0 r, \quad r \in \Pi_{n-k}.
$$
 (20)

The distinct lines $\ell_1, \ell_2, \ldots, \ell_{n-k-2}$ do not divide the polynomial $\sigma_0 \in \Pi_k$, therefore, all they have to divide r . Hence, we get from (20) :

$$
\sigma^* \beta' = \sigma_0 \beta, \text{ where } \beta \in \Pi_2. \tag{21}
$$

Now, we have that $\beta' \neq \beta$ since $\sigma^* \neq \sigma_0$. Then, in the same way as in the Case 1 we obtain that β' divides σ_0 :

$$
\sigma_0 = \beta' q \text{ where } q \in \Pi_{k-2}.\tag{22}
$$

Next, we are going to prove that there is a conic passing through all the nodes of A. Assume by way of contradiction that there is no such conic. Then, in view of Proposition [1.9,](#page-2-3) we have that there is a set of six nodes, say $A_6 := \{A_1, \ldots, A_6\} \subset A$, that does not lie in a conic, i.e., it is 2-poised.

Now, let us choose three noncollinear nodes in A_6 , say A_1 , A_2 , A_3 , and consider the following sets of four nodes:

 $A_1, A_2, A_3, A_4; A_1, A_2, A_3, A_5; A_1, A_2, A_3, A_6.$

Now, consider these three sets with the respective associated nodes:

$$
A_1, A_2, A_3, A_4, A'; \quad A_1, A_2, A_3, A_5, A''; \quad A_1, A_2, A_3, A_6, A'''.
$$
 (23)

We have that the three conics through these sets are components of σ_0 . Since \mathcal{A}_6 is 2-posed we obtain that these three conics cannot coincide. Hence there

are two different conics, say the conics $\beta', \beta'',$ passing through the first two sets in [\(23\)](#page-18-1), respectively.

First assume that one of these two conics, say, β' , is irreducible. Then consider a common node, say, A_1 . It is easily seen that A_1 belongs to two different components of σ_0 . One is β' and another is β'' , if it is irreducible too, or a line component of β'' , if it is reducible.

Next, assume that both β' and β'' are reducible:

$$
\beta' = \ell_1 \ell'_1, \quad \beta'' = \ell_2 \ell'_2.
$$

Without loss of generality assume that

$$
\ell_1 \neq \ell_2, \quad \ell_1 \neq \ell'_2. \tag{24}
$$

Note that ℓ_1 passes through at least one of the common nodes A_1, A_2, A_3 , say A_1 . Indeed, if ℓ_1 passes through only A' and A_4 then we obtain that ℓ'_1 passes through the three nodes A_1, A_2, A_3 . This is a contradiction since these three nodes are not collinear. Now, we have that A_1 belongs either to ℓ_2 or ℓ_2' . In both cases, in view of [\(24\)](#page-19-0), we have that A_1 belongs to two different line components of σ_0 , which is a contradiction.

Thus we proved that $A \subset \beta_0$, where $\beta_0 \in \Pi_2$. Next, in the same way as in Case 1, we show that β_0 divides σ_0 :

$$
\sigma_0 = \beta_0 q, \quad q \in \Pi_{k-2}.
$$

Also we have that β_0 is uniquely determined by the nodes of $\mathcal{A}\setminus\{A\}$, $\forall A \in \mathcal{A}$.

Indeed, assume that β_0 is not uniquely determined by the nodes from $A \setminus \{A_0\}$, where $A_0 \in A$. Therefore there are infinitely many conics β_0 passing through the nodes of $A \setminus \{A_0\}$. Recall that for (any) A_0 one can find a curve, denoted by σ^* , of degree at most k, that passes through all the nodes of $\mathcal X$ and is different from σ_0 .

Then, as in Case 1, we readily get $\sigma^* \beta_0 = \sigma_0 \beta$, where $\beta \in \Pi_2$. This implies that β_0 is a component of σ_0 . Hence we get that σ_0 has infinitely many components, which is a contradiction.

Thus we get that when completing the set $\mathcal{X} \subset \sigma_0$ till a maximal nindependent set $\mathcal{Z} = \mathcal{X} \cup \mathcal{A}$ we have to add all the nodes of \mathcal{A} to the conic β_0 . Let us verify that added nodes cannot belong to another component q. Indeed, suppose conversely that a node $A_0 \in \mathcal{A}$ belongs to $\beta_0 \cap q$. Then, in view of Lemma [1.14,](#page-3-1) we can move A_0 to $q \setminus \beta_0$ such that the resulted set A remains *n*-independent. This is a contradiction, since now clearly the nodes of A do not belong to a conic. Indeed, the nodes $A \setminus \{A_0\}$ determine a unique conic and the moved node is outside of it. This shows that the factor $r \in \Pi_{k-2}$ to which one cannot add a new independent node is merely maximal with respect to X. Therefore r passes through exactly $d(n, k)$ nodes of \mathcal{X} .

At the end, before establishing the division of the set A , it remains to consider the case when the division may be not possible for all three curves σ_0 , i.e., the case when the condition (C) does not hold. Then, we obtain three curves q_i , $i = 0, 1, 2$, which are components of degree $k - 1$ of the curves σ_i , $i = 0, 1, 2$, respectively, passing through all the nodes of X except possibly one. Since $\#\mathcal{X} = d(n, k-2)+3$ we get that deg $q_i = k-1, i = 0, 1, 2,$

Assume that q_i passes through all the nodes of $\mathcal X$ except $E_i, \in \mathcal X, i =$ 0, 1, 2.

First assume that two of these three nodes are different, say $E_0 \neq E_1$. We have that q_0 and q_1 pass through all the nodes of the set \mathcal{Y} := $\mathcal{X} \setminus \{E_0, E_1\}, \# \mathcal{Y} = d(n, k-3) + 1.$

If $q_0 \neq q_1$ then, according to Theorem [2.2,](#page-3-3) all the nodes of $\mathcal Y$ except one belong to a (maximal) curve μ of degree $k-2$. Thus all the nodes of X except three belong to μ .

Now assume that $q_0 = q_1 =: q$. Then we have that $E_0 = E_1$, contradicting our assumption.

It remains to consider the case $E_0 = E_1 = E_2 =: E$.

Then we have that q_0, q_1 and q_2 pass through all the nodes of the set $\mathcal{Y} := \mathcal{X} \setminus \{E\}, \# \mathcal{Y} = d(n, k-2) + 2$. We get from Theorem [2.1](#page-3-4) that $q_0 = q_1 = q_2 =: q.$

Next, in view of the condition (C), we get that $\sigma_i = \ell_i q$, $i = 0, 1, 2$, where $\ell_i \in \Pi_1$. This contradicts the linear independence of σ_i , $i = 0, 1, 2$, since we have that $E \in \ell_i$, $i = 0, 1, 2$. \Box

5.1 The division of the set $\bar{\mathcal{A}}$

Next let us establish the above mentioned division of the node set A in the case $n \geq k+3$. Note that this is the case when we need the diision.

Recall that each node of A belongs only to one component of the curve σ_0 . Particularly, the line components of σ_0 do not intersect at the nodes of A.

By using induction on m one can prove easily the following

Lemma 5.1. Suppose that a finite set of lines \mathcal{L} and $2m$ nodes lying in these lines are given. Suppose also that no node is an intersetion point of two lines. Then one can divide the node set into m pairs such that no pair belongs to the same line from $\mathcal L$ if and only if each line from $\mathcal L$ contains no more than m nodes.

Thus the above mentioned division of the node set A into $n - k - 2$ pairs is possible if and only if no $n - k - 1$ nodes of $\bar{A}_0 := A \setminus \{A^*, A_0\}$ are located in a line component of σ_0 , where the nodes A^* and A_0 are the nodes associated with the curve σ^* and \mathcal{A}_4 , respectively. Observe also that we may associate any two nodes A^* and A_0 of A with σ^* and A_4 ,

Now notice that, in view of $\#\mathcal{A}=2(n-k-1)$, there can be at most two undesirable line components for the set \overline{A} , i.e., lines containing at least $n - k - 1$ nodes from it. In this case a node from each line we assign as associated and leave in the two lines $\leq n - k - 2$ nodes.

Then assume that we have one undesirable line component for the set $\overline{\mathcal{A}}$, containing $\leq n-k$ nodes from it. In this case two nodes from this line we nominate as associated and leave in the line $\leq n - k - 2$ nodes.

Finally consider the case of one undesirable line component ℓ of σ_0 with $m \geq n - k + 1$ nodes. We have that

$$
\sigma_0 = \ell r_\ell, \text{ where } r_\ell \in \Pi_{k-1}.
$$

Now we are going to move $m - n + k$ nodes, one by one, from ℓ to the other component r_{ℓ} such that the set $\mathcal{Z} := \mathcal{X} \cup \mathcal{A}$ remains n-independent. Again, in view of Lemma [1.14,](#page-3-1) i), we require that each moved node belongs only to one component of the curve σ_0 .

To establish each described movement, in view of Lemma [1.14,](#page-3-1) ii), it suffices to prove that during this process each node $A \in \ell \cap \mathcal{A}$, has no *n*-fundamental polynomial for which the curve r_{ℓ} is a component. Suppose conversely that $p_A^* = r_\ell s, s \in \Pi_{n-k+1}$. Now, we have that s vanishes at $\geq n-k$ nodes in $\ell \cap \mathcal{A} \setminus \{A\}$. Indeed, the nodes of the set A in the line ℓ do not belong to another component. Therefore, r_{ℓ} does not vanish at these nodes and hence s vanishes. According to the condition (C) r_{ℓ} does not vanish also at least at two nodes from $\ell \cap \mathcal{X}$, and hence s vanishes there too. Thus the number of zeroes of s in the line ℓ is greater or equal to $n - k + 2$ and s together with p_A^* vanishes at the whole line ℓ , including the node A, which is a contradiction.

It remains to note that there will be no more undesirable lines, except ℓ , in the resulted set \mathcal{A} , after the described movement of the nodes, since we finish by keeping exactly $n - k$ nodes in $\ell \cap A$ and outside of it there are only $n - k - 2$ nodes.

Proof of Theorem [2.4.](#page-4-0) It is easily seen that Theorem [2.4](#page-4-0) follows from Proposition [4.1](#page-11-0) and Theorem [2.5.](#page-4-2)

6 An application to bivariate interpolation

Recall that a node $A \in \mathcal{X}$ uses a line ℓ means that ℓ is a factor of the fundamental polynomial $p = p_A^*$, i.e., $p = \ell r$ for some $r \in \Pi_{n-1}$.

A GC_n -set in the plane is an *n*-poised set of nodes, where the fundamental polynomial of each node is a product of n linear factors. The Gasca–Maeztu conjecture states that any GC_n -set possesses a subset of $n+1$ collinear nodes.

It was proved in [\[9\]](#page-23-8), that any line passing through exactly 2 nodes of a GC_n -set X can be used at most by one node from X.

Next, it was proved in [\[8\]](#page-23-7) that any used line passing through exactly 3 nodes of a GC_n -set X can be used either by exactly one or three nodes from \mathcal{X} .

In [\[7\]](#page-23-6) was proved the following result concerning the lines passing through exactly 4 nodes.

Corollary 6.1. Let X be an n-poised set of nodes and ℓ be a line, which passes through exactly 4 nodes. Suppose ℓ is used by at least four nodes from X . Then it is used by exactly six nodes from X. Moreover, if it is used by six nodes, then they form a 2-poised set. Furthermore, in the latter case, if $\mathcal X$ is a GC_n set, then the six nodes form a GC_2 set.

Below we consider the case of lines passing through exactly 5 nodes.

Corollary 6.2. Let $\mathcal X$ be an n-poised set of nodes and ℓ be a line which passes through exactly 5 nodes. Suppose ℓ is used by at least seven nodes from X . Suppose ℓ is used by at least seven nodes from X . Then it is used by exactly ten nodes from X . Moreover, if it is used by ten nodes, then they form a 3-poised set. Furthermore, in the latter case, if $\mathcal X$ is a GC_n set then the ten nodes form a GC_3 set.

Proof. Assume that $\ell \cap \mathcal{X} = \{A_1, \ldots, A_5\} =: \mathcal{A}$. Assume also that the seven nodes in $\mathcal{B} := \{B_1, \ldots, B_7\} \in \mathcal{X}$ use the line $\ell : p_{B_i}^* = \ell q_i, i = 1, \ldots, 7$, where $q_i \in \Pi_{n-1}$.

The polynomials q_1, \ldots, q_7 , vanish at $N-12$ nodes of the set $\mathcal{X}' :=$ $\mathcal{X} \setminus (\mathcal{A} \cup \mathcal{B})$. Hence through these $N - 12 = d(n, n - 4) + 3$ nodes pass seven linearly independent curves of degree $n - 1$. By Theorem [2.4](#page-4-0) there exists a maximal curve μ of degree $n-4$ passing through $N-15$ nodes of \mathcal{X}' and the remaining three nodes denoted by C_1, C_2, C_3 , are outside of it. Now, according to Proposition [1.12,](#page-2-4) the nodes C_1, C_2, C_3 , use μ :

$$
p_{C_i}^* = \mu r_i, \ r_i \in \Pi_4, \ i = 1, 2, 3.
$$

These polynomials r_i have to vanish at the five nodes of $A \subset \ell$. Hence $q_i = \ell \gamma_i$, $i = 1, 2, 3$, with $\gamma_i \in \Pi_3$. Therefore, the nodes C_1, C_2, C_3 , use the line ℓ :

$$
p_{C_i}^* = \mu \ell \gamma_i, \ i = 1, 2, 3.
$$

Hence if seen nodes in $\mathcal{B} \subset \mathcal{X}$ use the line ℓ then there exist three more nodes $C_1, C_2, C_3 \in \mathcal{X}$ using it and all the nodes of $\mathcal{Y} := \mathcal{X} \setminus (\mathcal{A} \cup \mathcal{B} \cup \{C_1, C_2, C_3\})$ lie in a maximal curve μ of degree $n-4$:

$$
\mathcal{Y} \subset \mu. \tag{25}
$$

Next, let us show that there is no eleventh node using ℓ . Assume by way of contradiction that except of the ten nodes in

$$
S := \{B_1, \ldots, B_7, C_1, C_2, C_3\},\
$$

there is an eleventh node D using ℓ . Of course we have that $D \in \mathcal{Y}$.

Then we have that the seven nodes B_1, \ldots, B_6 and D are using ℓ therefore, as was proved above, there exist three more nodes $E_1, E_2, E_3 \in \mathcal{X}$ (which may coincide or not with B_7 or C_1, C_2, C_3) using it and all the nodes of $\mathcal{Y}' := \mathcal{X} \setminus (\mathcal{A} \cup \{B_1, \ldots, B_6, D, E_1, E_2, E_3\})$ lie in a maximal curve μ' of degree $n-4$.

We have also that

$$
p_D^{\star} = \mu' q', \ q' \in \Pi_4. \tag{26}
$$

Now, notice that both the curves μ and μ' pass through all the nodes of the set $\mathcal{Z} := \mathcal{X} \setminus (\mathcal{A} \cup \mathcal{B} \cup \{C_1, C_2, C_3, D, E_1, E_2, E_3\})$ with $|\mathcal{Z}| \geq N - 19$.

Then, we get from Theorem [2.1,](#page-3-4) with $k = n - 5$, that $N - 19 =$ $d(n, n-5) + 2$ nodes determine the curve of degree $n-4$ passing through them uniquely. Thus μ and μ' coincide.

Therefore, in view of [\(25\)](#page-22-0) and [\(26\)](#page-23-9), p_D^{\star} vanishes at all the nodes of \mathcal{Y} , which is a contradiction since $D \in \mathcal{Y}$.

Now, let us verify the last "moreover" statement. Suppose ten nodes in $S \subset \mathcal{X}$ use the line ℓ . Then, as we obtained earlier, the nodes $\mathcal{Y} := \mathcal{X} \setminus (\mathcal{A} \cup \mathcal{S})$ are located in a maximal curve μ of degree $n-4$. Therefore the fundamental polynomial of each $A \in \mathcal{S}$ uses μ and hence ℓ :

$$
p_A^\star = \mu \ell q_A, \text{ where } q_A \in \Pi_3.
$$

It is easily seen that q_A is a 3-fundamental polynomial of $A \in \mathcal{S}$.
