### A CARTAN–HARTOGS VERSION OF THE POLYDISK THEOREM

Abstract. We extend the Polydisk Theorem for symmetric bounded domains to Cartan– Hartogs domains, and apply it to prove that a Cartan–Hartogs domain inherits totally geodesic submanifolds from the bounded symmetric domain which is based on, and to give a characterization of Cartan–Hartogs's geodesics with linear support.

### 1. Introduction and statement of the results

For a bounded symmetric domain  $\Omega$  endowed with (a multiple of) its Bergman metric  $g_B$ , the celebrated Polydisk Theorem due to J. A. Wolf [\[29\]](#page-17-0) (see also [\[17\]](#page-16-0)) shows that given any point  $z \in \Omega$  and any direction  $X \in T_z\Omega$ , there exists a totally geodesic complex submanifold  $\Pi$  passing through z with  $X \in T_z\Pi$ , biholomorphically isometric to a polydisk  $\Delta^r$  of dimension equals to the rank r of  $\Omega$ . Moreover, the group of the (isometric) automorphisms Aut $(\Omega)$  of  $\Omega$ , acts transitively on the space of all such polydisks, and denoting by  $\text{Aut}_z(\Omega)$  the isotropy subgroup of Aut $(\Omega)$  at z, one can realize  $\Omega$  as union over  $\gamma \in \text{Aut}_z(\Omega)$  of  $\gamma \cdot \Pi$ .

In this paper, we prove the analogous of the Polydisk Theorem for Cartan-Hartogs domains in terms of Hartogs-Polydisk (see [\(3\)](#page-1-0) below). For  $\mu > 0$ , Cartan–Hartogs domains are defined as the 1-parameter family:

$$
M_{\Omega}(\mu) = \left\{ (z, w) \in \Omega \times \mathbb{C} \mid |w|^2 < N_{\Omega}^{\mu}(z, z) \right\},\tag{1}
$$

where  $\Omega$  is a bounded symmetric domain not necessarily irreducible and  $N_{\Omega}(z, z)$  is its generic norm. Observe that originally [\[30\]](#page-17-1) the domain  $\Omega$  the Cartan–Hartogs is based on is a Cartan domain, i.e. an irreducible bounded symmetric domain. Here  $\Omega$  is allowed to be not irreducible, namely  $\Omega = \Omega_1 \times \cdots \times \Omega_m$  is a product of the Cartan domains  $\Omega_1, \ldots, \Omega_m$ , and accordingly its generic norm  $N_{\Omega}$  is the product of the generic norms of each factor:

$$
N_{\Omega}(z_1,\ldots,z_m,z_1,\ldots,z_m)=N_{\Omega_1}(z_1,z_1)\cdots N_{\Omega_m}(z_m,z_m).
$$

We consider on  $M_{\Omega}(\mu)$  the Kobayashi metric  $\omega(\mu) = \frac{i}{2} \partial \bar{\partial} \Phi_{\Omega,\mu}$ , where:

$$
\Phi_{\Omega,\mu}(z,w) = -\log \left( N_{\Omega}^{\mu}(z,z) - |w|^2 \right). \tag{2}
$$

We say that a Cartan–Hartogs  $M_{\Omega}(\mu)$  domain is of *classical type* if  $\Omega$  is product of Cartan domains of classical type. When  $\Omega$  is a polydisk  $\Delta^n := \{z \in \mathbb{C}^n \mid |z_1|^2 < 1, \ldots, |z_n|^2 < 1\}$ , the associated Cartan–Hartogs is the *Hartogs-Polydisk*:

$$
M_{\Delta^n}(\mu) = \left\{ (z, w) \in \Delta^n \times \mathbb{C} \mid |w|^2 < \prod_{j=1}^n (1 - |z_j|^2)^{\mu} \right\},\tag{3}
$$

whose Kobayashi metric is defined by the Kähler potential:

$$
\Phi_{\Delta^n,\mu}(z,w) = -\log\left(\prod_{j=1}^n (1-|z_j|^2)^{\mu} - |w|^2\right).
$$

Observe that when  $\mu = 1$  and  $\Omega = \text{CH}^1$ ,  $M_{\Omega}(\mu)$  reduces to be a complex hyperbolic space. In all the other cases it is a nonhomogeneous domain that inherits symmetric peculiarities from the symmetric bounded domain it based on. For this reason Cartan–Hartogs domains represent an important class of domains in  $\mathbb{C}^n$ , and since their first apparence in [\[30\]](#page-17-1) they have been studied from different points of view, see e.g. [\[2,](#page-16-1) [6,](#page-16-2) [7,](#page-16-3) [12,](#page-16-4) [13,](#page-16-5) [25,](#page-16-6) [27,](#page-17-2) [31,](#page-17-3) [32\]](#page-17-4).

The main theorem of this paper is the following Hartogs version of the Polydisk Theorem. As his classical counterpart, which led to several applications, e.g. N. Mok and S.-C. Ng's rigidity and extension results for holomorphic isometries [\[18,](#page-16-7) [19,](#page-16-8) [20,](#page-16-9) [21,](#page-16-10) [26\]](#page-16-11) (see also [\[10,](#page-16-12) [22,](#page-16-13) [23\]](#page-16-14) where the Polydisk Theorem is used to study the diastatic exponential and the volume and diastatic entropy of symmetric bounded domains), we expect it to be a useful tool to solve geometric problems related to Cartan–Hartogs domain, improving our knowledge of nonhomogeneous domains.

<span id="page-1-1"></span>Theorem 1 (Hartogs–Polydisk Theorem). *Let* Ω *be a bounded symmetric domain of classical type of rank* r *and let*  $M_{\Omega}(\mu)$  *be the associated Cartan–Hartogs domain. For any point*  $(z, w) \in$  $M_{\Omega}(\mu)$  and any  $X \in T_{(z,w)}M_{\Omega}(\mu)$  there exists a totally geodesic complex submanifold  $\Pi$  through  $(z, w)$  with  $X \in T_{(z, w)} M_{\tilde{\Pi}}(\mu)$ , such that  $\Pi$  is biholomorphically isometric to the Hartogs-Polydisk M∆<sup>r</sup> (µ)*. Moreover,* Aut(Ω) *acts transitively on the space of all such Hartogs-polydisks, and*  $M_{\Omega}(\mu) = \bigcup \{ \gamma \cdot \Pi : \gamma \in \text{Aut}_{z}(\Omega) \}.$ 

We apply the Hartogs-Polydisk Theorem to prove the following two results. The first one states that any totally geodesic Kähler submanifold of the base domain  $\Omega$  is a totally geodesic submanifold of its associated Cartan–Hartogs:

<span id="page-1-2"></span>**Theorem 2.** Let  $\Omega' \subset \Omega$  be a totally geodesic Kähler submanifold of a bounded symmetric *domain of classical type. Then*

$$
C_{\Omega'} = \big\{ (z, w) \in M_{\Omega}(\mu) \mid z \in \Omega' \big\}
$$

*is a totally geodesic Kähler submanifold of*  $M_{\Omega}(\mu)$  *biholomorphically isometric to the Cartan-Hartogs*  $M_{\Omega}(\mu)$ *.* 

The second one gives a characterization of geodesics with linear support in  $M_{\Omega}(\mu)$ :

<span id="page-1-3"></span>**Theorem 3.** If  $M_{\Omega}(\mu)$  admits a geodesic with linear support passing through ( $\zeta$ ,0), then up *to automorphisms either the geodesic is contained in*  $\Omega = M_{\Omega}(\mu) \cap \{w = 0\}$  *or in* CH<sup>1</sup> =  $M_{\Omega}(\mu) \cap \{z=0\}, \text{ or } M_{\Omega}(\mu) \simeq \mathbb{C} \mathbb{H}^{d+1}.$ 

The paper is organized as follows. In the next section we recall basic facts about classical Cartan domains and we describe explicit polydisks totally geodesically embedded. In Section [3](#page-4-0) we show how the totally geodesic Kähler immersions of such polydisks into the Cartan domains lift to totally geodesic Kähler immersion of Hartogs–polydisks into Cartan–Hartogs domains and prove Theorem [1.](#page-1-1) The last three sections are devoted respectively to the proofs of theorems [2](#page-1-2) and [3.](#page-1-3)

## 2. Explicit polydisks in Cartan domains

In this section we are going to give an explicit totally geodesic Kähler (i.e. holomorphic and isometric) immersion of a polydisk into each one of the four irreducible classical domains. All the isometries here are intended respect to the hyperbolic metric on  $\Omega$ , i.e.  $\omega_{hyp}^{\Omega} := -\partial\bar{\partial}\log N_{\Omega}(z, z)$ (one has  $\omega_B^{\Omega} = \gamma \omega_{hyp}^{\Omega}$ , where  $\omega_B^{\Omega}$  is the Bergman metric on  $\Omega$  and  $\gamma$  is its genus). Throughout this section we use the Jordan triple system theory, referring the reader to [\[4,](#page-16-15) [10,](#page-16-12) [11,](#page-16-16) [15,](#page-16-17) [16,](#page-16-18) [22,](#page-16-13) [23,](#page-16-14) [24,](#page-16-19) [25,](#page-16-6) [28\]](#page-17-5) for details and further applications.

<span id="page-2-3"></span>2.1. Cartan domain of the first type. Consider the first Cartan domain of rank  $r = m$  and genus  $\gamma = n + m$ :

$$
\Omega_1[m, n] = \{ Z \in M_{m,n}(\mathbb{C}) \mid \det \left( I_m - Z Z^* \right) > 0, n \ge m \}.
$$

Its generic norm is given by:

<span id="page-2-1"></span>
$$
N_{\Omega_1}(Z, Z) = \det \left( I_m - Z Z^* \right). \tag{4}
$$

A totally geodesic polydisk  $\Delta^m \stackrel{\varphi}{\hookrightarrow} \Omega_1[m,n]$  is given by

<span id="page-2-2"></span>
$$
\varphi(z_1,\ldots,z_m) = \text{diag}(z_1,\ldots,z_m) = \begin{pmatrix} z_1 & & 0 \\ & \ddots & \\ & & z_m & 0 \end{pmatrix} . \tag{5}
$$

Since  $\det(I_m - \varphi(z)\varphi(z)^*) = \prod_{j=1}^m (1 - |z_j|^2)$ ,  $\varphi$  is clearly a Kähler immersion. Moreover it is easy to check that  $\varphi_*(T_0\Delta^m)$  define a sub-HJPTS of  $(T_0\Omega_1[m,n], \{,\})$ , where

$$
\{U, V, W\} = UV^*W + WV^*U\tag{6}
$$

<span id="page-2-0"></span>(see e.g.  $[4, (16)]$ ), we conclude, by the one to one correspondence between sub-HJPTS e sub-HSSNT (see [\[4,](#page-16-15) Proposition 2.1]), that  $\varphi$  is totally geodesic. Recent application

<span id="page-2-4"></span>2.2. Cartan domain of the second type. Consider the second Cartan domain of rank  $r =$  $[n/2]$  and genus  $\gamma = 2n + 2$ ,

$$
\Omega_2[n] = \{ Z \in M_n(\mathbb{C}), Z = -Z^T, \det(I_n - ZZ^*) > 0 \}.
$$

A parametrization is given by:

$$
u = (u_1_2, \ldots, u_{1n}, u_2_3, \ldots, u_{2n}, \ldots, u_{n-1n}) \mapsto Z(u) = \begin{pmatrix} 0 & u_1_2 & u_1_3 & \ldots & u_{1n-1} & u_{1n} \\ -u_1_2 & 0 & u_2_3 & \ldots & u_{2n-1} & u_{2n} \\ \vdots & \vdots & \vdots & \vdots & \vdots & \vdots \\ -u_{1n} & -u_{2n} & -u_{3n} & \ldots & -u_{n-1n} & 0 \end{pmatrix}
$$

Its generic norm is given by:

<span id="page-3-0"></span>
$$
N_{\Omega_2}(u, u) = \det^{1/2} (I_n - Z(u)Z^*(u)).
$$
\n(7)

A totally geodesic polydisk  $\Delta^{\left[\frac{n}{2}\right]} \stackrel{\varphi}{\hookrightarrow} \Omega_2[n]$  is given by:

<span id="page-3-1"></span>
$$
\varphi(u) = \begin{pmatrix} 0 & 0 & \cdots & 0 & u_{1\left[\frac{n}{2}\right]} \\ 0 & 0 & \cdots & u_{2\left[\frac{n}{2}\right]-1} & 0 \\ \vdots & \vdots & \vdots & \vdots & \vdots \\ 0 & -u_{2\left[\frac{n}{2}\right]-1} & \cdots & 0 & 0 \\ -u_{1\left[\frac{n}{2}\right]} & 0 & \cdots & 0 & 0 \end{pmatrix},
$$
(8)

where  $u = \left(u_1\left[\frac{n}{2}\right], u_2\left[\frac{n}{2}\right] - 1, \dots, u_{\left[\frac{n}{2}\right]} \right]$ . Since

$$
N_{\Omega_2}(\varphi(u), \varphi(u)) = \det^{1/2} (I_n - \varphi(u)\varphi^*(u)) = \prod_{j=1}^{\left[\frac{n}{2}\right]} (1 - |u_{j\left[\frac{n}{2} - j + 1\right]}|^2),
$$

 $\varphi$  is a Kähler immersion, moreover it is easy to check that  $\varphi_*(T_0\Delta_m)$  defines a sub-HJPTS of  $(T_0\Omega_2[n], \{ , , \} )$ , where the triple product is given by  $\{U, V, W\} = UV^*W + WV^*U$ , namely the restriction to  $T_0\Omega_2[n]$  of the triple product of  $T_0\Omega_1[n,n]$  given in [\(6\)](#page-2-0), we conclude, by the one to one correspondence between sub-HJPTS e sub-HSSNT (see [\[4,](#page-16-15) Proposition 2.1]), that  $\varphi$  is totally geodesic.

2.3. Cartan domain of the third type. Consider the Cartan domain of third type of rank  $r = m$  and genus  $\gamma = n + 1$ :

$$
\Omega_3[m] = \{ Z \in M_m(\mathbb{C}) \mid Z = Z^T, \det(I_m - ZZ^*) > 0 \},
$$

whose generic norm is given by:

<span id="page-3-2"></span>
$$
N_{\Omega_3}(z, z) = \det \left( I_m - Z Z^* \right). \tag{9}
$$

As can be proven in a totally similar way as done for the first and second type domains, a totally geodesic polydisk  $\Delta^m \stackrel{\varphi}{\hookrightarrow} \Omega_1[m]$  is given by:

<span id="page-3-3"></span>
$$
\varphi(z) = \text{diag}(z_1, \dots, z_m) = \begin{pmatrix} z_1 & & \\ & \ddots & \\ & & z_m \end{pmatrix}.
$$
 (10)

<span id="page-3-4"></span>2.4. Cartan domain of the fourth type. Consider the fourth type domain of rank  $r = 2$ and genus  $\gamma = n$ :

$$
\Omega_4[n] = \left\{ z = (z_1, \ldots, z_n) \in \mathbb{C}^n \; \bigg| \; \sum_{j=1}^n |z_j|^2 < 1, \; 1 + \left| \sum_{j=1}^n z_j^2 \right|^2 - 2 \sum_{j=1}^n |z_j|^2 > 0, \; n \ge 5 \right\}.
$$

whose generic norm is given by:

<span id="page-4-2"></span>
$$
N_{\Omega_4[n]}(z, z) = 1 + \left| \sum_{j=1}^n z_j^2 \right|^2 - 2 \sum_{j=1}^n |z_j|^2.
$$
 (11)

Let  $\varphi : \Delta^2 \to \Omega_4[n]$  be the map:

<span id="page-4-3"></span>
$$
\varphi(z_1, z_2) = \left(\frac{1}{2}\left(z_1 + z_2\right), \frac{i}{2}\left(z_1 - z_2\right), 0, \dots, 0\right). \tag{12}
$$

Since:

$$
N_{\Omega_4[n]}(\varphi(z_1, z_2), \varphi(z_1, z_2)) = (1 - |z_1|^2)(1 - |z_2|^2) = N_{\Delta^2}(z_1, z_2),
$$

<span id="page-4-0"></span> $\varphi$  is Kähler. Moreover  $\varphi(\Delta^2)$  is the set of points of  $\Omega_4[n]$  fixed by the isometry  $(z_1,\ldots,z_n) \mapsto$  $(z_1, z_2, -z_3 \ldots, -z_n)$ , thus  $\varphi$  is totally geodesic.

## 3. The Polydisk Theorem for Cartan-Hartogs domains

Let us begin with the following lemma.

<span id="page-4-1"></span>**Lemma 1.** Let  $\Omega$  be a Cartan domain and let  $\varphi : \Delta^r \to \Omega$  be a Kähler immersion fixing the *origin, i.e. a holomorphic map satisfying*  $\varphi^* \omega_{hyp}^{\Omega} = \omega_{hyp}^{\Delta^r}$  and  $\varphi(0) = 0$ . Then:

$$
f: M_{\Delta^r}(\mu) \to M_{\Omega}(\mu), \quad f(z, w) = (\varphi(z), w),
$$

*is a K¨ahler immersion.*

*Proof.* Observe that  $-\log(V(\Omega)N_{\Omega}(z, z))$  and  $-\log(V(\Delta^r)N_{\Delta^r}(z, z))$  are the diastasis functions respectively for  $(\Omega, \omega_{hyp}^{\Omega})$  and  $(\Delta^r, \omega_{hyp}^{\Delta^r})$ , where  $V(\Omega)$  (resp.  $V(\Delta^r)$ ) is the total volume of  $\Omega$ (resp.  $\Delta^r$ ) with respect to the Euclidean measure of the ambient complex Euclidean space (see  $[12, Prop. 7]$  $[12, Prop. 7]$ ). Since the diastasis is a Kähler potential invariant by isometries (see [\[3\]](#page-16-20) or also  $[14]$ , one has:

$$
V(\Omega)N_{\Omega}(\varphi(z),\varphi(z))=V(\Delta^r)N_{\Delta^r}(z,z).
$$

Since  $\varphi(0) = 0$  and  $N_{\Omega}(0,0) = 1$  for any  $\Omega$ , we get  $V(\Omega) = V(\Delta^r)$  and thus  $N_{\Omega}(\varphi(z), \varphi(z)) =$  $N_{\Delta r}(z, z)$ . Then, it follows easily that:

$$
\Phi_{\Omega,\mu}(f(z,w)) = -\log (N_{\Omega}((\varphi(z),\varphi(z)) - |w|^2) = -\log (N_{\Delta^r}(z,z) - |w|^2) = \Phi_{\Delta^r,\mu}(z,w),
$$

and we are done.

By this lemma the totally geodesic Kähler immersions described in the previous section induce Kähler immersions of Hartogs–polydisks into Cartan–Hartogs domains. We prove now case by case that such maps are also totally geodesics.

3.1. Cartan–Hartogs domain of the first type. By [\(1\)](#page-0-0), [\(2\)](#page-0-1) and [\(4\)](#page-2-1), the Cartan-Hartogs domain associated to a first type Cartan domain is:

$$
M_{\Omega_1[m,n]}(\mu) = \left\{ (z,w) \in \Omega_1[m,n] \times \mathbb{C} \mid |w|^2 < \det^{\mu} (I_m - ZZ^*) \right\}.
$$

and its Kobayashi metric is described by the Kähler potential:

$$
\Phi_{\Omega_1,\mu}(z) = -\log \left( \det^{\mu} \left( I_m - Z Z^* \right) - |w|^2 \right).
$$

<span id="page-5-1"></span>**Lemma 2.** Let  $\varphi : \Delta^m \to \Omega_1[m,n]$  be the map in [\(5\)](#page-2-2). Then  $f : M_{\Delta^m}(\mu) \to M_{\Omega_1[m,n]}(\mu)$ ,  $f(z, w) = (\varphi(z), w)$ , is a totally geodesic Kähler immersion.

*Proof.* From Sec. [2.1](#page-2-3) the map  $\varphi$  is a Kähler immersion, thus by Lemma [1](#page-4-1) also f is.

It remains to prove that f is totally geodesic. Let  $Z = (z_{ik})$ . From the expression of f and [\(5\)](#page-2-2),  $\{\partial_{z_{jj}}, \partial_{z_{kk}}, \partial_w\}$  is a basis for  $Tf(M_{\Delta^m}(\mu)) \subset TM_{\Omega_1[m,n]}(\mu)$ . Thus, it is enough to show that:

<span id="page-5-0"></span>
$$
\nabla_{\partial_{z_{jj}}}\partial_{z_{kk}}, \nabla_{\partial_{w}}\partial_{z_{kk}} \in Tf(M_{\Delta^m}(\mu)) \quad j, k = 1, \dots, n. \tag{13}
$$

Recalling that the covariant derivative in terms of Christoffel symbols reads:

$$
\nabla_{\partial_{z_{jj}}}\partial_{z_{kk}} = \sum_{s=1}^m \sum_{r=1}^n \left( \Gamma_{jj\,kk}^{sr} \partial_{z_{sr}} + \Gamma_{jj\,kk}^0 \partial_w \right) \quad \text{and} \quad \nabla_{\partial_w}\partial_{z_{kk}} = \sum_{s=1}^m \sum_{r=1}^n \left( \Gamma_{0\,kk}^{sr} \partial_{z_{sr}} + \Gamma_{0\,kk}^0 \partial_w \right),
$$

where we use the index 0 for the w-entry, [\(13\)](#page-5-0) is equivalent to  $\Gamma^{sr}_{j j k k} = \Gamma^{sr}_{0 k k} = 0$  for  $s \neq r$ . In order to compute the Christoffel symbols let  $A = I - ZZ^*$  and denote by  $A_{r_1r_1r_2,\dots,r_s1r_s2}$  the matrix obtained from A by removing the  $r_{11}, \ldots, r_{s1}$ -th rows and the  $r_{12}, \ldots, r_{s2}$ -th columns. If  $j \neq r_{11}, \ldots, r_{s1}$  we have

$$
\frac{\partial \det A_{r_{11}r_{12},...,r_{s1}r_{s2}}}{\partial z_{jk}} = \sum_{\ell} \epsilon_{j\ell} \det \widetilde{A}_{r_{11}r_{12},...,r_{s1}r_{s2},j\ell} \overline{z}_{\ell k},
$$

where  $\epsilon_{j\ell}$  is an opportune constant equal to 1 or -1. Clearly if the hypothesis  $j \neq r_{11}, \ldots, r_{s1}$ is not satisfied the derivative is zero. Similarly if  $j \neq r_{12}, \ldots, r_{s2}$  we have

$$
\frac{\partial \det \widetilde{A}_{r_{11}r_{12},...,r_{s1}r_{s2}}}{\partial \overline{z}_{jk}} = \sum_{\ell} \epsilon_{\ell j} \det \widetilde{A}_{r_{11}r_{12},...,r_{s1}r_{s2},\ell j} z_{\ell k},
$$

zero otherwise. Thus we have

$$
\frac{\partial \Phi_{\Omega_1,\mu}}{\partial \overline{z}_{rs}} = -\frac{\partial \log(\det^{\mu} A - |w|^2)}{\partial \overline{z}_{rs}} = \frac{\mu \det^{\mu-1} A \sum_{\ell} \epsilon_{\ell r} \det \widetilde{A}_{\ell r} z_{\ell s}}{\det^{\mu} A - |w|^2},
$$

$$
\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial w \, \partial \overline{z}_{rs}} = \frac{\overline{w}\mu \det^{u-1} A \sum_{\ell} \epsilon_{\ell r} \det \widetilde{A}_{\ell r} z_{\ell s}}{\left(\det^{\mu} A - |w|^2\right)^2}
$$

and

$$
\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{jk}\partial \overline{z}_{rs}} = \frac{\mu(\mu - 1) \det^{\mu - 2} A \sum_{\ell} \epsilon_{j\ell} \det \widetilde{A}_{j\ell} \overline{z}_{\ell k} \sum_{\ell} \epsilon_{\ell r} \det \widetilde{A}_{\ell r} z_{\ell s}}{\det^{\mu} A - |w|^2} + \frac{\mu \det^{\mu - 1} A \left( \sum_{\ell, t} \epsilon_{\ell r} \epsilon'_{j\ell} \det \widetilde{A}_{\ell r, j\ell} \overline{z}_{\ell k} z_{\ell s} + \epsilon_{j r} \det \widetilde{A}_{j r} \delta_{k s} \right)}{\det^{\mu} A - |w|^2} - \frac{\left( \mu \det^{\mu - 1} A \right)^2 \sum_{\ell} \epsilon_{\ell r} \det \widetilde{A}_{\ell r} z_{\ell s} \sum_{\ell} \epsilon_{j\ell} \det \widetilde{A}_{j\ell} \overline{z}_{\ell k}}{\left( \det^{\mu} A - |w|^2 \right)^2}.
$$

In particular

$$
\left(\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial w \partial \overline{z}_{rs}}\right)_{|Z=\text{diag}(z_{11},...,z_{mm})} = 0 \quad \text{for } r \neq s.
$$

and

$$
\left(\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{jk}\partial \overline{z}_{rs}}\right)_{|Z=\text{diag}(z_{11},...,z_{mm})} = 0 \quad \text{for } r \neq s \text{ and } (j,k) \neq (r,s).
$$

Therefore, for  $(Z, w) \in f(M_{\Delta^m}(\mu))$ , and  $s \neq r$ , we have

$$
\Gamma_{0kk}^{rs} = \sum_{\ell} g^{rs,\overline{\ell}} \frac{\partial g_{kk,\overline{\ell}}}{\partial w} = g^{rs,\overline{rs}} \frac{\partial g_{kk,\overline{rs}}}{\partial w} = 0,
$$

where the last equality is easily deduced from [\(19\)](#page-8-0). It remains to prove that for  $(Z, w) \in$  $f(M_{\Delta^m}(\mu))$ , and  $s \neq r$ , we have

$$
\Gamma_{jj\,kk}^{rs} = \sum_{\ell} g^{rs,\overline{\ell}} \frac{\partial g_{kk,\overline{\ell}}}{\partial z_{jj}} = g^{rs,\overline{rs}} \frac{\partial g_{kk,\overline{rs}}}{\partial z_{jj}} = 0,
$$

i.e.  $\frac{\partial^3 \Phi_{\Omega_1,\mu}}{\partial z \cdot \partial z \cdot \partial z}$  $\frac{\partial^2 \Psi_{\Omega_1,\mu}}{\partial z_{jj} \partial z_{kk} \partial \overline{z}_{sr}} = 0$ . Assume  $s \neq r$ , we have

$$
\left(\frac{\partial^3 \Phi_{\Omega_1,\mu}}{\partial z_{jj} \partial z_{kk} \partial \overline{z}_{sr}}\right)_{|Z = \text{diag}(z_{11},...,z_{mm})} = \frac{\partial}{\partial z_{jj}} \left(\frac{\mu(\mu - 1) \det^{\mu - 2} A \epsilon_{kk} \det \widetilde{A}_{kk} z_{kk}}{\det^{\mu} A - |w|^2} + \frac{\mu \det^{\mu - 1} A \left(\epsilon_{sr} \epsilon_{kk} \det \widetilde{A}_{sr,kk} z_{ks} + \epsilon_{kr} \det \widetilde{A}_{kr} \delta_{ks}\right)}{\det^{\mu} A - |w|^2} - \frac{\left(\mu \det^{\mu - 1} A\right)^2 \epsilon_{sr} \det \widetilde{A}_{sr} z_{ss} \epsilon_{kk} \det \widetilde{A}_{kk} \overline{z}_{kk}}{\det^{\mu} A - |w|^2}\right)_{|Z = \text{diag}(z_{11},...,z_{mm})}
$$

$$
= \left(\frac{\mu(\mu - 1) \det^{\mu - 2} A \epsilon_{kk} \det \widetilde{A}_{kk} z_{kk} \epsilon_{sr} \frac{\partial \det \widetilde{A}_{sr}}{\partial z_{jj}} z_{ss}}{\det^{\mu} A - |w|^2} + \frac{\mu \det^{\mu - 1} A \left(\epsilon_{sr} \epsilon_{kk} \frac{\partial \det \widetilde{A}_{sr,kk}}{\partial z_{jj}} \overline{z}_{kk} z_{ss} + \epsilon_{kr} \frac{\partial \det \widetilde{A}_{kr}}{\partial z_{jj}} \delta_{ks}\right)}{\det^{\mu} A - |w|^2} - \frac{\left(\mu \det^{\mu - 1} A\right)^2 \epsilon_{sr} \frac{\partial \det \widetilde{A}_{sr}}{\partial z_{jj}} z_{ss} \epsilon_{kk} \det \widetilde{A}_{kk} \overline{z}_{kk}}{\left(\det^{\mu} A - |w|^2\right)^2}\right)_{|Z = \text{diag}(z_{11},...,z_{mm})}

concluding the proof.  $\Box$ 

3.2. Cartan–Hartogs domain of the second type. By  $(1)$ ,  $(2)$  and  $(7)$ , the Cartan–Hartogs associated to the second type Cartan domain is:

$$
M_{\Omega_2[n]}(\mu) = \{ (u, w) \in \Omega_2[n] \times \mathbb{C} \mid |w|^2 < \det^{(\mu/2)}(I_m - Z(u)Z(u)^*) \},
$$

and a Kähler potential for its Kobayashi metric is:

$$
\Phi_{\Omega_2,\mu}(u,w) = -\log \left( \det^{\mu/2} (I_n - Z(u)Z(u)^*) - |w|^2 \right).
$$

<span id="page-7-3"></span>**Lemma 3.** Let  $\varphi: \Delta^{\frac{n}{2}} \to \Omega_2[n]$  be the map in [\(8\)](#page-3-1). Then  $f: M_{\Delta^{n/2}}(\mu) \to M_{\Omega_2[n]}(\mu)$ ,  $f(u, w) =$  $(\varphi(u), w)$ *, is a totally geodesic Kähler immersion.* 

*Proof.* From Sec. [2.2](#page-2-4) the map  $\varphi$  is Kähler, thus by Lemma [1](#page-4-1) f also is. Let us use the parametrization described in Sec. [2.2.](#page-2-4) In terms of the Christoffel symbols, since:

\nabla_{\partial_{u_{j\,n+1-j}}\partial_{u_{k\,n+1-k}}} = \sum_{s,r=1}^n \Gamma_{j\,n+1-j,\,k\,n+1-k}^{sr} \partial_{u_{sr}} + \Gamma_{j\,n+1-j,\,k\,n+1-k}^0 \partial_w,
$$

and

$$
\nabla_{\partial_w} \partial_{u_{k\,n+1-k}} = \sum_{s,r=1}^n \Gamma_{0,k\,n+1-k}^{sr} \partial_{u_{sr}} + \Gamma_{0,k\,n+1-k}^0 \partial_w,
$$

the map  $f$  to be totally geodesic is equivalent to:

\Gamma_{j\,n+1-j,k\,n+1-k}^{sr} = \Gamma_{0,k\,n+1-k}^{sr} = 0,\tag{15}
$$

for  $s \neq n + 1 - r$  and  $1 \leq j, k \leq n/2$ . Observing that  $\Phi_{\Omega_2,\mu}(u, w) = \Phi_{\Omega_1,\mu}(Z(u), w)$  once substituted  $\mu$  with  $\mu/2$  in the second term, we have:

\frac{\partial \Phi_{\Omega_2,\mu}}{\partial \overline{u}_{rs}} = \frac{\partial \Phi_{\Omega_1,\mu}}{\partial \overline{z}_{rs}} - \frac{\partial \Phi_{\Omega_1,\mu}}{\partial \overline{z}_{sr}} = -\frac{\partial \log(\det^{\frac{\mu}{2}} A - |w|^2)}{\partial \overline{z}_{rs}} + \frac{\partial \log(\det^{\frac{\mu}{2}} A - |w|^2)}{\partial \overline{z}_{sr}}
$$

$$
= \frac{\frac{\mu}{2} \det^{\frac{\mu}{2} - 1} A \left( \sum_{\ell=1}^n \epsilon_{\ell r} \det \widetilde{A}_{\ell r} z_{\ell s}(u) - \sum_{\ell=1}^n \epsilon_{\ell s} \det \widetilde{A}_{\ell s} z_{\ell r}(u) \right)}{\det^{\frac{\mu}{2}} A - |w|^2},
$$

$$
\frac{\partial^2 \Phi_{\Omega_2,\mu}}{\partial w \partial \overline{u}_{rs}} = \frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial w \partial \overline{z}_{rs}} - \frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial w \partial \overline{z}_{sr}} \n= \frac{\overline{w}_{2}^{\mu} \det^{\frac{\mu}{2}-1} A \left( \sum_{\ell=1}^{n} \epsilon_{\ell r} \det \widetilde{A}_{\ell r} z_{\ell s}(u) - \sum_{\ell=1}^{n} \epsilon_{\ell s} \det \widetilde{A}_{\ell s} z_{\ell r}(u) \right)}{\left( \det^{\frac{\mu}{2}} A - |w|^2 \right)^2}.
$$
\n(16)

For  $(u, w) \in f(\Delta_{\lbrack n/2 \rbrack})$  and  $r \neq n+1-s,$  we get

$$
\frac{\partial^2 \phi_2}{\partial w \partial \overline{u}_{rs}} = \frac{\frac{\mu}{2} \det^{\frac{\mu}{2}-1} A\left(\epsilon_{n+1-rr} \det \widetilde{A}_{n+1-sr} z_{n+1-ss}(u) - \epsilon_{n+1-ss} \det \widetilde{A}_{n+1-rs} z_{n+1-rr}(u)\right)}{\det^{\frac{\mu}{2}} A - |w|^2} = 0.
$$

= \frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{jk}\partial \overline{z}_{rs}} + \frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{kj}\partial \overline{z}_{sr}} - \frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{kj}\partial \overline{z}_{rs}} - \frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{jk}\partial \overline{z}_{sr}}.

If we take  $\overline{u}_{rs}$  with  $r \neq n + 1 - s$  and  $u_{jk}$  with  $(j, k) \neq (r, s)$ , then the indexes of  $\partial^2\Phi_{\Omega_1,\mu}$  $\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{jk} \partial \overline{z}_{rs}},\ \frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{kj} \partial \overline{z}_{sn}}$  $\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{kj} \partial \overline{z}_{sr}}, \frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{kj} \partial \overline{z}_{rs}}$  $\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{kj} \partial \overline{z}_{rs}},\ \frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{jk} \partial \overline{z}_{sn}}$  $\frac{\partial^2 \Psi_{\Omega_1,\mu}}{\partial z_{jk}\partial \overline{z}_{sr}}$  in [\(17\)](#page-7-0) must satisfies  $r \neq n+1-s$ ,  $(j,k) \neq (r,s)$  and  $(k, j) \neq (r, s)$ . Under this conditions on the indexes, it is just a straightforward computation to prove that  $\left(\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{jk} \partial \overline{z}_{rs}}\right)_{|(u,w)\in f(\Delta_{[n/2]})}$  $=\left(\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{kj}\partial\overline{z}_{sr}}\right)_{|(u,w)\in f(\Delta_{[n/2]})}$  $=\left(\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{kj}\partial\overline{z}_{rs}}\right)_{|(u,w)\in f(\Delta_{[n/2]})}$ =  $\left(\frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{jk}\partial \overline{z}_{sr}}\right)_{|(u,w)\in f(\Delta_{[n/2]})}$ = 0, and in particular that  $\left(\frac{\partial^2 \Phi_{\Omega_2,\mu}}{\partial u_{jk} \partial \overline{u}_{rs}}\right)_{|Z(u)\in\Delta}$ = 0. \Gamma_{0,k\,n+1-k}^{sr} = \sum_{\ell} g^{rs,\overline{\ell}} \frac{\partial g_{k\,n+1-k,\overline{\ell}}}{\partial w} = g^{rs,\overline{rs}} \frac{\partial g_{k\,n+1-k,\overline{rs}}}{\partial w},
$$

and

$$
\Gamma_{n+1-jj,n+1-k}^{sr} = \sum_{\ell} g^{rs,\overline{\ell}} \frac{\partial g_{n+1-kk,\overline{\ell}}}{\partial u_{n+1-jj}} = g^{rs,\overline{rs}} \frac{\partial g_{n+1-kk,\overline{rs}}}{\partial u_{n+1-jj}}.
$$

Deriving [\(16\)](#page-7-1), we can see that  $\frac{\partial g_{k[n+1-k],\overline{rs}}}{\partial w} = 0$ , which readily implies that  $\Gamma_{0,kn+1-k}^{sr} = 0$ . It remains to prove that, under the above conditions  $\frac{\partial g_{n+1-k,k,\overline{rs}}}{\partial u_{n+1-j,j}} = 0$  (or equivalently that  $\partial^3\phi_2$  $\frac{\partial^{\alpha} \phi_2}{\partial u_{n+1-j}j} \frac{\partial u_{n+1-k}}{\partial u_{n}} = 0$ . We have

\frac{\partial^3 \Phi_{\Omega_1,\mu}}{\partial z_{j\,[n+1-j]}\partial z_{k\,[n+1-k]}\partial \overline{z}_{rs}} = \frac{\partial}{\partial z_{j\,[n+1-j]}} \left( \frac{\partial^2 \Phi_{\Omega_1,\mu}}{\partial z_{k\,[n+1-k]}\partial \overline{z}_{rs}} \right)
$$
\n
$$
= \frac{\partial}{\partial z_{j\,[n+1-j]}} \left( \frac{\frac{\mu}{2}(\frac{\mu}{2}-1) \det^{\frac{\mu}{2}-2} A \epsilon_{kk} \det \widetilde{A}_{kk} \overline{z}_{k\,[n+1-k]} \epsilon_{n+1-sr} \det \widetilde{A}_{[n+1-s]r} z_{[n+1-s]s}}{\det^{\frac{\mu}{2}} A - |w|^2} + \frac{\frac{\mu}{2} \det^{\frac{\mu}{2}-1} A \left( \epsilon_{[n+1-s]r} \epsilon'_{kk} \det \widetilde{A}_{[n+1-s]r, kk} \overline{z}_{k\,[n+1-k]} z_{[n+1-s]s} + \epsilon_{kr} \det \widetilde{A}_{kr} \delta_{[n+1-k]s} \right)}{\det^{\frac{\mu}{2}} A - |w|^2} + \frac{\left( \frac{\mu}{2} \det^{\frac{\mu}{2}-1} A \right)^2 \epsilon_{[n+1-s]r} \det \widetilde{A}_{[n+1-s]r} z_{[n+1-s]s} \epsilon_{kk} \det \widetilde{A}_{kk} \overline{z}_{k\,[n+1-k]}}{\left( \det^{\frac{\mu}{2}} A - |w|^2 \right)^2} \right). \tag{det\frac{\mu}{2}A - |w|^2}

If we assume that  $(u, w) \in f(\Delta_{[n/2]})$ , we obtain

hence if we also assume  $s \neq n+1-r$  and  $1 \leq j, k \leq [n/2]$  we see that  $\frac{\partial^3 \Phi_{\Omega_1,\mu_2}}{\partial z_{j} [n+1-j]} \frac{\partial^3 \Phi_{\Omega_1,\mu_2}}{\partial z_{k} [n+1-j]}$  $\frac{\partial^2 \Psi_{\Omega_1,\mu}}{\partial z_{j\,[n+1-j]}\,\partial z_{k\,[n+1-k]}\,\partial\overline{z}_{rs}}=0.$ Thus [\(15\)](#page-7-2) holds true, concluding the proof.  $\Box$ 

3.3. Cartan–Hartogs domain of the third type. By [\(1\)](#page-0-0), [\(2\)](#page-0-1) and [\(9\)](#page-3-2), the Cartan–Hartogs associated to a third type domain is given by:

$$
M_{\Omega_3[m]}(\mu) = \{ (Z, w) \in \Omega_2[n] \times \mathbb{C} \mid |w|^2 < \det^{\mu}(I_m - ZZ^*) \},
$$

and its Kobayashi metric is described by the Kähler potential:

$$
\Phi_{\Omega_3,\mu}(Z,w) = -\log \left( \det^{\mu} (I_m - ZZ^*) - |w|^2 \right)
$$

.

<span id="page-9-0"></span>**Lemma 4.** Let  $\varphi: \Delta^m \to \Omega_3[m]$  be the map in [\(10\)](#page-3-3). Then  $f: M_{\Delta^m}(\mu) \to M_{\Omega_3[m]}(\mu)$ ,  $f(z, w) =$  $(\varphi(z), w)$ *, is a totally geodesic Kähler immersion.* 

*Proof.* The proof is similar to those of Lemma [2](#page-5-1) and Lemma [3](#page-7-3) and therefore is omitted.  $\square$ 

3.4. Cartan–Hartogs domain of the fourth type. By  $(1)$ ,  $(2)$  and  $(11)$ , the Cartan–Hartogs associated to a fourth type domain is given by:

$$
M_{\Omega_4[n]}(\mu) = \left\{ (u, w) \in \Omega_4[n] \times \mathbb{C} \mid |w|^2 < \left(1 + \left| \sum_{j=1}^n z_j^2 \right|^2 - 2 \sum_{j=1}^n |z_j|^2 \right)^{\mu} \right\},\,
$$

and a Kähler potential for the Kobayashi metric is:

$$
\Phi_{\Omega_4,\mu}(z,w) = -\log\left( \left(1 + \left|\sum_{j=1}^n z_j^2\right|^2 - 2\sum_{j=1}^n |z_j|^2\right)^{\mu} - |w|^2 \right).
$$

<span id="page-9-1"></span>**Lemma 5.** Let  $\varphi: \Delta^2 \to \Omega_4[n]$  be the map in [\(12\)](#page-4-3). Then  $f: M_{\Delta^2}(\mu) \to M_{\Omega_4[n]}(\mu)$ ,  $f(z_1, z_2, w) =$  $(\varphi(z_1, z_2), w)$ *, is a totally geodesic Kähler immersion.* 

*Proof.* From Sec. [2.4](#page-3-4) the map  $\varphi$  is a Kähler immersion, thus by Lemma [1](#page-4-1) f also is. It remains to prove that f is totally geodesic, which is equivalent to  $\Gamma_{jk}^{\ell} = 0$  for  $\ell > 2$  and  $0 \le j, k \le 2$ , where:

\nabla_{\partial_{z_j}} \partial_{z_k} = \sum_{\ell=1}^n \Gamma_{jk}^{\ell} \, \partial_{z_\ell} + \Gamma_{jk}^0 \, \partial_w, \qquad \nabla_{\partial_w} \partial_{z_k} = \sum_{\ell=1}^n \Gamma_{0k}^{\ell} \, \partial_{z_\ell} + \Gamma_{0k}^0 \, \partial_w.
$$

We have

$$
\frac{\partial \Phi_{\Omega_4,\mu}}{\partial \overline{z}_k} = \frac{-\partial \log \left( \left( 1 + \left| \sum_{\ell=1}^n z_{\ell}^2 \right|^2 - 2 \sum_{\ell=1}^n |z_{\ell}|^2 \right)^{\mu} - |w|^2 \right)}{\partial \overline{z}_k}
$$
\n
$$
= \frac{-\mu \left( 1 + \left| \sum_{\ell=1}^n z_{\ell}^2 \right|^2 - 2 \sum_{\ell=1}^n |z_{\ell}|^2 \right)^{\mu-1} \left( 2 \overline{z}_k \sum_{\ell=1}^n z_{\ell}^2 - 2 z_k \right)}{\left( 1 + \left| \sum_{\ell=1}^n z_{\ell}^2 \right|^2 - 2 \sum_{\ell=1}^n |z_{\ell}|^2 \right)^{\mu} - |w|^2},
$$
\n
$$
\frac{\partial^2 \Phi_{\Omega_4,\mu}}{\partial w \partial \overline{z}_k} = \frac{-\mu \left( 1 + \left| \sum_{\ell=1}^n z_{\ell}^2 \right|^2 - 2 \sum_{\ell=1}^n |z_{\ell}|^2 \right)^{\mu-1} \left( 2 \overline{z}_k \sum_{\ell=1}^n z_{\ell}^2 - 2 z_k \right) \overline{w}}{\left( \left( 1 + \left| \sum_{\ell=1}^n z_{\ell}^2 \right|^2 - 2 \sum_{\ell=1}^n |z_{\ell}|^2 \right)^{\mu} - |w|^2 \right)^2},
$$

and

$$
\frac{\partial^2 \Phi_{\Omega_4,\mu}}{\partial z_h \partial \overline{z}_k} = \frac{-\mu(\mu-1)\left(1+|\sum_{\ell=1}^n z_\ell^2|^2 - 2\sum_{\ell=1}^n |z_\ell|^2\right)^{\mu-2}\left(2\overline{z}_k\sum_{\ell=1}^n z_\ell^2 - 2z_k\right)\left(2z_h\sum_{\ell=1}^n \overline{z}_\ell^2 - 2\overline{z}_h\right)}{\left(1+|\sum_{\ell=1}^n z_\ell^2|^2 - 2\sum_{\ell=1}^n |z_\ell|^2\right)^{\mu} - |w|^2} + \frac{-\mu\left(1+|\sum_{\ell=1}^n z_\ell^2|^2 - 2\sum_{\ell=1}^n |z_\ell|^2\right)^{\mu-1}\left(4\overline{z}_kz_h - 2\delta_{hk}\right)}{\left(1+|\sum_{\ell=1}^n z_\ell^2|^2 - 2\sum_{\ell=1}^n |z_\ell|^2\right)^{\mu} - |w|^2} + \frac{\mu^2\left(1+|\sum_{\ell=1}^n z_\ell^2|^2 - 2\sum_{\ell=1}^n |z_\ell|^2\right)^{2\mu-2}\left(2\overline{z}_k\sum_{\ell=1}^n z_\ell^2 - 2z_k\right)\left(2z_h\sum_{\ell=1}^n \overline{z}_\ell^2 - 2\overline{z}_h\right)}{\left(\left(1+|\sum_{\ell=1}^n z_\ell^2|^2 - 2\sum_{\ell=1}^n |z_\ell|^2\right)^{\mu} - |w|^2\right)^2}.
$$

Hence for  $(z, w) \in f(M_{\Delta_2})$ ,  $2 \ge j, h \ge 1$  and  $k > 2$ , we have

$$
\Gamma^{k}_{0h} = \sum_{\ell} g^{k,\overline{\ell}} \frac{\partial g_{h\overline{\ell}}}{\partial w} = g^{k,\overline{k}} \frac{\partial g_{h\overline{k}}}{\partial w}
$$

and

$$
\Gamma_{j\,h}^k = \sum_{\ell} g^{k,\overline{\ell}} \frac{\partial g_{h\overline{\ell}}}{\partial z_j} = g^{k,\overline{k}} \frac{\partial g_{k\overline{h}}}{\partial z_j},
$$

where we used that for  $(z, w) \in f(M_{\Delta_2}) = \{(z, w) \in M_{\Omega_4[n]} \mid z_3 = \cdots = z_n = 0\}, k > 2$  and  $k \neq \ell$  we have  $g^{k,\ell}(z,w) = 0$ . It is straightforward to check that under this conditions  $\partial^3 \Phi_{\Omega_4,\mu}$  $\frac{\partial^3 \Phi_{\Omega_4,\mu}}{\partial w \partial z_h \partial \overline{z}_k}(z,w) = 0$  and  $\frac{\partial^3 \Phi_{\Omega_4,\mu}}{\partial z_j \partial z_h \partial \overline{z}}$  $\frac{\partial^2 \Psi_{\Omega_4,\mu}}{\partial z_j \partial z_h \partial \overline{z}_k}(z,w) = 0$ , namely that  $\Gamma_{jk}^{\ell}(z,w) = 0$ . Therefore  $f(M_{\Delta_2})$ is totally geodesic in  $M_{\Omega_4[n]}$ . The proof is complete.

3.5. The proof of the Hartogs–Polydisk Theorem. We need two further preliminary results.

#### <span id="page-10-0"></span>Lemma 6. *Let* Ω *be a bounded symmetric domain.*

*(1)* If  $\phi: \Omega \to \Omega$  *is an isometric automorphism of*  $\Omega$  *then*  $\phi$  *lifts to an isometric automorphism*  $\tilde{\phi}: M_{\Omega}(\mu) \to M_{\Omega}(\mu)$  *defined by* 

$$
\tilde{\phi}(z,w) = \left(\phi(z), e^{\mu h_{\phi}(z)}w\right),\,
$$

*for an appropriate holomorphic function*  $h_{\phi}: \Omega \to \mathbb{C}$ *.* 

*(2) If* φ: Ω → Ω *is an automorphism of* Ω *which fix the origin, then* φ *lifts to an isometric*  $automorphism \tilde{\phi}: M_{\Omega}(\mu) \rightarrow M_{\Omega}(\mu)$  *defined by* 

$$
\tilde{\phi}(z,w) = (\phi(z),w) .
$$

*Proof.* Let  $\phi : \Omega \to \Omega$  be an isometric automorphism of  $\Omega$ . Then  $\phi$  satisfies:

$$
\partial \overline{\partial} \log \left( N \left( \phi(z), \overline{\phi(z)} \right) \right) = \partial \overline{\partial} \log \left( N \left( z, \overline{z} \right) \right),
$$

and hence  $N(\varphi(z), \overline{\varphi(z)}) = N(z, \overline{z}) e^{h_{\varphi}(z) + \overline{h}_{\varphi}(z)}$  for an opportune holomorphic function  $h_{\varphi}$ :  $\Omega \to \mathbb{C}$ . The holomorphic map  $f : M_{\Omega}(\mu) \to M_{\Omega}(\mu)$  defined by:

$$
f(z,w) = \left(\phi(z), e^{\mu h_{\phi}(z)}w\right),\,
$$

is well defined, as  $\left|e^{\mu h_\phi(z)}w\right|^2 < \left|e^{\mu h_\phi(z)}\right|^2 N(z,\overline{z}) = N\left(\phi(z),\overline{\phi(z)}\right)$ , and it is an isometry of  $M_{\Omega}(\mu)$ , since:

$$
\partial \overline{\partial} \log \left( N^{\mu} \left( \phi(z), \overline{\phi(z)} \right) - \left| e^{\mu h_{\phi}(z)} w \right|^2 \right) = \partial \overline{\partial} \log \left( N^{\mu} \left( z, \overline{z} \right) - |w|^2 \right).
$$

For the second part, it is enough to recall that automorphisms of  $\Omega$  that fix the origin preserves the minimal polynomial  $N_{\Omega}$  (see e.g [\[1,](#page-16-22) Prop. III.2.7] or [\[25,](#page-16-6) Section 2.2]), thus in this case  $h_{\phi}=0.$ 

<span id="page-11-0"></span>**Proposition 1.** Let  $\Delta^r \subset \Omega$  be an r-dimensional totally geodesic polydisk of a bounded sym*metric domain of classical type of rank* r*. Then*

$$
C_{\Delta^r} = \{(z, w) \in M_{\Omega}(\mu) \mid z \in \Delta^r\}
$$

*is a totally geodesic Kähler submanifold of*  $M_{\Omega}(\mu)$  *biholomorphically isometric to*  $M_{\Delta}(\mu)$ *.* 

*Proof.* By (1) of Lemma [6](#page-10-0) we can assume without loss of generality that  $\Delta^r$  passes through the origin. Observe that  $N_{\Delta^r} = N_{\Omega|_{\Delta^r}}$  (see [\[28,](#page-17-5) Proposition VI.2.4 and VI.3.6]). Now the proof is an immediate consequence of lemmata [2,](#page-5-1) [3,](#page-7-3) [4,](#page-9-0) [5,](#page-9-1) [6](#page-10-0) and the Polydisk Theorem that assure us that  $\text{Aut}_0(\Omega)$  acts transitively on the set of the r-dimensional totally geodesic polydisk through the origin of  $\Omega$  (see also [\[28,](#page-17-5) Theorem VI.3.5]).

*Proof of Theorem [1.](#page-1-1)* Let  $X \in T_{(z,w)}M_{\Omega}(\mu)$  be a fixed tangent vector. Consider the decomposition  $X = X_1 + X_2$ , where  $X_1 \in T_z\Omega$  and  $X_2 \in \mathbb{C}$ . From the Polydisk Theorem we know that there exists a totally geodesic polydisk  $\Delta^r \subset \Omega$ , through z, such that  $X_1 \in T_z \Delta^r$ . By Proposition [1](#page-11-0) we know that  $\{(z,w) \in M_{\Omega}(\mu) \mid z \in \Delta^r\}$  is the Cartan-Hartogs  $M_{\Delta^r}(\mu)$  realized as a totally geodesic Kähler submanifold of  $M_{\Omega}(\mu)$ . The proof is complete by observing that by construction  $X \in T_0 \Delta^r \times \mathbb{C} \cong T_{(z,w)} M_{\Delta^r}(\mu)$ .

## 4. Proof of Theorem [2](#page-1-2)

In order to proof Theorem [2](#page-1-2) we need the following lemma, which generalize Proposition [1](#page-11-0) to polydisks of dimension less than the rank of  $\Omega$ .

<span id="page-11-1"></span>**Lemma 7.** Let  $\Delta^r \subset \Delta^n$  be a totally geodesic r-dimensional polydisk of an n-dimensional *polydisk. Then*

$$
\{(z,w)\in M_{\Delta^n}(\mu) \mid z\in \Delta^r\}
$$
\n(20)

*is a totally geodesic Kähler submanifold of*  $M_{\Delta^n}(\mu)$  *biholomorphic isometric to*  $M_{\Delta^n}(\mu)$ *.* 

*Proof.* Let us first show that the inclusion  $i_j : \mathbb{CH}^1 \to \Delta^n$  of  $\mathbb{CH}^1$  in the j-th factor of  $\Delta^r$ , is a holomorphic and totally geodesic immersion of CH<sup>1</sup> in  $\Delta^n$ . Let us denote by  $K^{CH^1}$  and  $K^{\Delta^n}$ the holomorphic sectional curvatures of  $\mathbb{C}H^1$  and  $\Delta^n$  respectively. We have (see [\[9,](#page-16-23) Propostion IX.9.2]),

$$
K^{\text{CH}^1}(X) = K^{\Delta^n}(i_{j*}X) = \sum_{\ell=1}^n K^{\Delta^n}\left(a_{\ell}\frac{\partial}{\partial z_{\ell}}\right), \qquad \forall X \in T_z\mathbb{C}H^1,
$$

where  $i_{j*}(X) = \sum_{\ell=1}^n a_\ell \frac{\partial}{\partial z_\ell}$  $\frac{\partial}{\partial z_i}$ . We conclude that all but one of the  $a_1, \ldots, a_n$  are forced to be zero. We can therefore assume, without loss of generality, that  $\mathbb{CH}^1 \times \cdots \times \mathbb{CH}^1 = \Delta^r =$  $\{z \in \Delta^n \mid z_j = 0, j > r\}.$  Clearly  $(z_1, \ldots, z_r, w) \stackrel{f}{\mapsto} (z_1, \ldots, z_r, 0, \ldots, 0, w)$  defines an holomorphic isometric immersion of  $M_{\Delta^n}(\mu)$  in  $M_{\Delta^n}(\mu)$ , in order to complete the proof of the lemma we are going to prove that it is also totally geodesic.

Let  $\nabla$  be the Levi-Civita connection of  $M_{\Delta^n}(\mu)$ , let us denote  $\frac{\partial}{\partial z_0} = \frac{\partial}{\partial w}$  and let  $\Gamma_{ij}^k$  be the associated Christoffel symbols defined by  $\nabla_{\frac{\partial}{\partial z_i}}$ ∂  $\frac{\partial}{\partial z_j} = \sum_{k=0}^n \Gamma^k_{ij} \frac{\partial}{\partial z}$  $\frac{\partial}{\partial z_k}$ . In order to prove that f is totally geodesic we need to show that  $\Gamma_{ij}^k = 0$  for  $0 \le i, j \le r$  and  $k > r$ . For  $k, \ell > 0$  and  $k \ne \ell$ , we have

$$
g_{k\overline{\ell}} = -\frac{i}{2} \partial_{z_k} \partial_{\overline{z}_\ell} \log \left( \prod_{j=1}^n (1 - |z_j|^2)^\mu - |w|^2 \right)
$$
  
\n
$$
= \frac{i}{2} \partial_{z_k} \frac{\mu z_\ell (1 - |z_\ell|^2)^{\mu-1} \prod_{j=1, j \neq \ell}^n (1 - |z_j|^2)^\mu}{\prod_{j=1}^n (1 - |z_j|^2)^\mu - |w|^2}
$$
  
\n
$$
= \frac{i}{2} \frac{\mu^2 z_\ell \overline{z}_k (1 - |z_\ell|^2)^{\mu-1} (1 - |z_k|^2)^{\mu-1} \prod_{j=1, j \neq \ell}^n (1 - |z_j|^2)^\mu \prod_{j=1, j \neq k}^n (1 - |z_j|^2)^\mu}{\left( \prod_{j=1}^n (1 - |z_j|^2)^\mu - |w|^2 \right)^2}
$$
  
\n
$$
- \frac{i}{2} \frac{\mu^2 z_\ell \overline{z}_k (1 - |z_\ell|^2)^{\mu-1} (1 - |z_k|^2)^{\mu-1} \prod_{j=1, j \neq \ell, k}^n (1 - |z_j|^2)^\mu}{\prod_{j=1}^n (1 - |z_j|^2)^\mu - |w|^2}
$$

and

$$
g_{0\overline{\ell}} = -\frac{i}{2} \partial_w \partial_{\overline{z}_\ell} \log \left( \prod_{j=1}^n (1 - |z_j|^2)^\mu - |w|^2 \right)
$$
  
= 
$$
\frac{i}{2} \partial_w \frac{\mu z_\ell (1 - |z_\ell|^2)^{\mu-1} \prod_{j=1, j \neq \ell}^n (1 - |z_j|^2)^\mu}{\prod_{j=1}^n (1 - |z_j|^2)^\mu - |w|^2}
$$
  
= 
$$
\frac{i}{2} \frac{\overline{w} \mu z_\ell (1 - |z_\ell|^2)^{\mu-1} \prod_{j=1, j \neq \ell}^n (1 - |z_j|^2)^\mu}{\prod_{j=1}^n (1 - |z_j|^2)^\mu - |w|^2}.
$$

Therefore, for  $k > r$  and  $z_k = 0$ , we get

$$
\Gamma_{ij}^k = \sum_{\ell} g_{k\overline{\ell}} \frac{\partial g_{j\ell}}{\partial z_i} = g_{k\overline{k}} \frac{\partial g_{j\overline{k}}}{\partial z_i} = 0,
$$

for any  $i, j \neq k$ . The proof is complete.

*Proof of Theorem [2.](#page-1-2)* As  $\Omega'$  is a totally geodesic Kähler submanifold of the bounded symmetric domain  $\Omega$ , it is an HSSNCT and therefore can be realized as a bounded symmetric domain  $\Omega' \subset \mathbb{C}^m$ , where  $m = \dim(\Omega')$ . With a slight abuse of notation, let us denote by  $f : \Omega' \subset \mathbb{C}^m \to$  $\Omega' \subset \mathbb{C}^n$  the totally geodesic Kähler immersion of  $\Omega'$  in  $\Omega$ . Without loss of generality (up to automorphisms of  $\Omega$  and  $\Omega'$ ) we can assume  $f(0) = 0$ . Once observed that  $N_{\Omega'} = N_{\Omega_{|\Omega'}}$  it is easy to verify that  $\tilde{f}: M_{\Omega}(\mu) \to M_{\Omega}(\mu)$  given by  $\tilde{f}(z, w) = (f(z), w)$  defines a Kähler embedding, with  $C_{\Omega'} = f(M_{\Omega'}(\mu)) \simeq M_{\Omega'}(\mu)$ .

It remains to prove that  $C_{\Omega'}$  is totally geodesic in  $M_{\Omega}(\mu)$ . Let  $p \in C_{\Omega'} \subset M_{\Omega}(\mu)$  and let  $X \in T_pC_{\Omega'} \subset T_pM_{\Omega}(\mu)$ . We want to prove that the geodesic  $\gamma$  of  $M_{\Omega}(\mu)$  with  $\gamma(0) = p$  and  $\gamma'(0) = X$  is also a geodesic of  $C_{\Omega'}$ . By Theorem [1](#page-1-1) and Proposition [1,](#page-11-0) we know that there exist t.g. Kähler immersed polydisks  $\Delta^{r'} \subset \Omega'$  and  $\Delta^r \subset \Omega$  such that the associated Hartogs-Polydisk  $C_{\Delta^{r'}} \subset M_{\Omega'}(\mu)$  and  $C_{\Delta^r} \subset M_{\Omega}(\mu)$  are totally geodesics (here  $r'$  and  $r$  are the ranks of  $\Omega$  and  $\Omega$  respectively). Using similar argument to that used in first part of the proof of Lemma [7](#page-11-1) we can see that  $\Delta' \cap \Delta$  is a t.g. polydisk of  $\Omega'$  (and therefore of  $\Omega$ ). By Lemma [7](#page-11-1) we conclude that  $C_{\Delta' \cap \Delta} = \{(z, w) \in M_{\Omega}(\mu)\}\$ is a totally geodesic Kähler submanifold of  $C_{\Omega'}$  and  $M_{\Omega}(\mu)$  at the same time. It is a simple observation that  $p \in C_{\Delta' \cap \Delta}$  and  $X \in T_p C_{\Delta' \cap \Delta}$ , hence  $\gamma$  is a geodesic of  $M_{\Omega}(\mu)$  as wished.

# 5. Proof of Theorem [3](#page-1-3)

We start this section giving the explicit expression of a holomorphic and isometric immersion f of  $(M_{\Delta^r}(\mu), \omega_{\Delta^r}(\mu))$  in  $(l^2(\mathbb{C}), \omega_0)$ .

<span id="page-13-0"></span>**Lemma 8.** *The holomorphic map*  $f: M_{\Delta}(\mu) \to l^2(\mathbb{C})$  given by:

$$
f(z, w) = (\psi_1, \ldots, \psi_r, \Psi),
$$

*where for*  $j = 1, \ldots, r$ :

<span id="page-13-1"></span>
$$
\psi_j := \sqrt{\mu} \left( z_j, \dots, \frac{z_j^k}{\sqrt{k}}, \dots \right),\tag{21}
$$

<span id="page-13-2"></span>
$$
\Psi := \left(\dots, \frac{1}{\sqrt{a}} \sqrt{\binom{\mu a + k_1 - 1}{k_1}} \cdots \binom{\mu a + k_r - 1}{k_1} z_1^{k_1} \cdots z_r^{k_r} w^a, \dots\right),\tag{22}
$$
\n
$$
\text{for } k = (k_1, \dots, k_r), \ |k| = 0, 1, 2, \dots, \text{ and } a = 1, 2, \dots, \text{ satisfies } f^* \omega_0 = \omega_{\Delta^r}(\mu).
$$

*Proof.* We have:

$$
\sum_{j=0}^{\infty} |f_j|^2 = \mu \sum_j \sum_{k_j} \frac{|z_j|^{2k_j}}{k_j} + \sum_{k,a} \binom{\mu a + k_1 - 1}{k_1} \cdots \binom{\mu a + k_r - 1}{k_r} |z_1|^{2k_1} \cdots |z_r|^{2k_r} \frac{|w|^{2a}}{a},
$$

(to avoid confusion the sums are always taken in the parameters' range) and:

$$
\sum_{j} \sum_{k_j} \frac{|z_j|^{2k_j}}{k_j} = -\sum_{j=1}^r \log(1 - |z_j|^2) = -\log\left(\prod_{j=1}^r (1 - |z_j|^2)\right),
$$
  

$$
\sum_{k,a} {\mu a + k_1 - 1 \choose k_1} \cdots {\mu a + k_r - 1 \choose k_r} |z_1|^{2k_1} \cdots |z_r|^{2k_r} \frac{|w|^{2a}}{a} = \sum_{a=1}^\infty \frac{|w|^{2a}}{a \prod_{j=1}^r (1 - |z_j|^2)^{\mu a}}
$$
  

$$
= -\log\left(1 - \frac{|w|^2}{\prod_{j=1}^r (1 - |z_j|^2)^{\mu}}\right),
$$

which imply:

$$
\sum_{j=0}^{\infty} |f_j|^2 = -\log \left( \prod_{j=1}^r (1 - |z_j|^2)^{\mu} - |w|^2 \right),
$$

as requested.  $\Box$ 

We use Lemma [8](#page-13-0) to obtain geodesic equations for  $M_{\Delta^r}(\mu)$ . From [\(21\)](#page-13-1), deriving twice  $\psi_i(\gamma(t))$ w.r.t. t gives:  $\sqrt{2}$ 

$$
\psi_j(\gamma)'' = \sqrt{\mu} \left( \ddot{u}_j, \dots, \frac{k(u_j^{k-1}\dot{u}_j)'}{\sqrt{k}}, \dots \right),
$$
  
and, denoting by  $A(\mu, a, k) := \frac{1}{\sqrt{a}} \sqrt{\binom{\mu a + k_1 - 1}{k_1} \cdots \binom{\mu a + k_r - 1}{k_1}}, \text{ from (22) we get:}$   

$$
\Psi(\gamma)'' := \left( \dots, A(\mu, a, k) (u_1^{k_1} \dots u_r^{k_r} u_w^{a})'', \dots \right).
$$

The tangent space  $T_{f(\gamma)}f(M_{\Delta^r}(\mu))$  is spanned by

$$
\nabla f(\gamma) = (\partial_1 f, \dots, \partial_r f, \partial_w f)(\gamma),
$$

and the condition for  $\gamma$  to be a geodesic is equivalent to the system:

$$
\langle f(\gamma)'', \partial_1 f \rangle = \dots = \langle f(\gamma)'', \partial_r f \rangle = \langle f(\gamma)'', \partial_w f \rangle = 0, \tag{23}
$$

namely:

$$
\langle f(\gamma)'', \partial_w f \rangle = \sum_{k,a} a A^2(\mu, a, k) (\bar{u}_1^{k_1} \dots \bar{u}_r^{k_r} \bar{u}_w^{a})'' u_1^{k_1} \dots u_r^{k_r} u_w^{a-1} = 0, \qquad (24)
$$

<span id="page-14-2"></span>and for  $s = 1, \ldots, r$ :

$$
\langle f(\gamma)'', \partial_s f \rangle = \mu \sum_{k=1}^{\infty} u_s^{k-1} (\bar{u}_s^k)'' +
$$
  
+ 
$$
\sum_{k,a} k_s A^2(\mu, a, k) (\bar{u}_1^{k_1} \dots \bar{u}_r^{k_r} \bar{u}_w^a)'' u_1^{k_1} \dots u_s^{k_s-1} \dots u_r^{k_r} v^a = 0.
$$
 (25)

Let us now prove Theorem [3.](#page-1-3)

*Proof of Theorem [3.](#page-1-3)* Let  $\gamma$  be a geodesic with linear support in  $M_{\Omega}(\mu)$ , passing through  $(\zeta, 0)$ with direction ξ. By Lemma [6](#page-10-0) up to automorphisms we can assume  $\zeta = 0$  and by the Hartogs polydisk Theorem  $\gamma$  is contained in an Hartogs polydisk  $M_{\Delta r}(\mu)$  passing through 0 with direction ξ. Then  $\gamma$  is a geodesic with linear support passing through the origin in  $M_{\Delta}(\mu)$  and conclusion follows by Lemma [9](#page-14-0) below.

<span id="page-14-0"></span>**Lemma 9.** *If*  $\gamma(t) = (\xi_1 v(t), \dots, \xi_r v(t), \xi_0 v(t))$  *is a geodesic in*  $M_{\Delta}(\mu)$ *, then either*  $\gamma \subset \Delta^r$  $M_{\Delta^r}(\mu) \cap \{w = 0\}$  *or*  $\gamma \subset \text{CH}^1 = M_{\Delta^r}(\mu) \cap \{z = 0\}$  *or*  $r = 1 = \mu$ *, i.e.*  $M_{\Delta^r}(\mu) \simeq \text{CH}^2$ .

*Proof.* A geodesic in  $M_{\Delta}(\mu)$  must satisfy [\(24\)](#page-14-1) and [\(25\)](#page-14-2). Plugging  $\gamma$  respectively into (24) and  $(25)$  gives:

<span id="page-14-3"></span>
$$
\bar{\xi}_0 \sum_{k,a} a A^2(\mu, a, k) |\xi_1|^{2k_1} \cdots |\xi_r|^{2k_r} |\xi_0|^{2a-2} (\bar{v}(t)^{|k|+a})'' v(t)^{|k|+a-1} = 0,\tag{26}
$$

<span id="page-14-4"></span>
$$
\mu \bar{\xi}_s \sum_{k=1}^{\infty} |\xi_s|^{2(k-1)} v(t)^{k-1} (\bar{v}(t)^k)'' +
$$
  
+ 
$$
\bar{\xi}_s \sum_{k,a} k_s A^2(\mu, a, k) |\xi_1|^{2k_1} \cdots |\xi_s|^{2(k_s - 1)} \cdots |\xi_r|^{2k_r} |\xi_0|^{2a} (\bar{v}(t)^{|k|+a})'' v(t)^{|k|+a-1} = 0.
$$
\n(27)

for  $s = 1, ..., r$ ,  $|k| = 0, 1, 2, ...,$  and  $a = 1, 2, ...$  Evaluating at  $t = 0$  we get:

$$
\xi_0 \ddot{v}(0) = \mu \xi_1 \ddot{v}(0) = \cdots = \mu \xi_r \ddot{v}(0) = 0,
$$

and since  $\xi_0, \xi_j, j = 1, \ldots, r$  cannot be all vanishing, it implies  $\ddot{v}(0) = 0$ .

Taking into account that  $v(0) = \ddot{v}(0) = 0$  and  $\dot{v}(0) = 1$ , deriving [\(26\)](#page-14-3) and [\(27\)](#page-14-4) once with respect to t and evaluating at  $t = 0$  gives:

<span id="page-15-0"></span>
$$
\bar{\xi}_0 \left( v'''(0) + 2|\xi_0|^2 + 2\mu \sum_{j=1}^r |\xi_j|^2 \right) = 0 = \mu \bar{\xi}_s \left( v'''(0) + 2|\xi_s|^2 + 2|\xi_0|^2 \right). \tag{28}
$$

If  $\xi_0 = 0$  or  $\xi_s = 0$  for all  $s = 1, \ldots, r$  then, since by Theorem [2](#page-1-2)  $M_{\Delta}r(\mu) \cap \{z = 0\}$  and  $M_{\Delta^r}(\mu) \cap \{w = 0\}$  are totally geodesic in  $M_{\Delta^r}(\mu)$ ,  $\gamma \subset \Delta^r = M_{\Delta^r}(\mu) \cap \{w = 0\}$  or  $\gamma \subset \mathbb{C}H^1$  $M_{\Delta}(\mu) \cap \{z=0\}.$  Thus, assume that  $\xi_0 \neq 0$  and at least one between the  $\xi_j$ 's is different from 0. From [\(28\)](#page-15-0) we get:

<span id="page-15-1"></span>
$$
\mu \sum_{j=1}^{r} |\xi_j|^2 = |\xi_s|^2, \quad \text{for any } s = 1, \dots, r,
$$
\n(29)

which implies that all the  $\xi_s$ 's are equal in module, and thus  $r\mu = 1$ .

To conclude that  $r = \mu = 1$ , we need to consider the third order derivative of [\(26\)](#page-14-3) and [\(27\)](#page-14-4) evaluated at  $t = 0$ . Observe first that:

$$
[(v(t)^{2})''v(t)]'''(0) = 26v'''(0), \quad [(v(t)^{3})''v(t)^{2}]'''(0) = 36,
$$

and recall that from [\(28\)](#page-15-0) we get  $v'''(0) = -2(|\xi_0|^2 + |\xi_s|^2)$ . Deriving three times [\(26\)](#page-14-3) with respect to t and evaluating at  $t = 0$  we get:

$$
\bar{\xi}_0 \left[ v^{(v)}(0) + \left( |\xi_0|^2 + \mu \sum_{j=1}^r |\xi_j|^2 \right) 26v'''(0) + 36 \left( |\xi_0|^4 + 2\mu |\xi_0|^2 \sum_{j=1}^r |\xi_j|^2 + \mu(\mu - 1) \sum_{j=1}^r |\xi_j|^4 + \mu^2 \sum_{j,k=1}^r |\xi_j|^2 |\xi_k|^2 \right) \right] = 0,
$$

which by  $(29)$  reads:

<span id="page-15-2"></span>
$$
\bar{\xi}_0 \left[ v^{(v)}(0) - 16 \left( |\xi_0|^2 + |\xi_s|^2 \right)^2 + 36(\mu - 1)|\xi_s|^4 \right] = 0. \tag{30}
$$

On the other hand, [\(27\)](#page-14-4) gives:

$$
\mu \bar{\xi}_s \left[ v^{(v)}(0) + 26 \left( |\xi_s|^2 + |\xi_0|^2 \right) v'''(0) + 36 \left( |\xi_s|^2 + |\xi_0|^2 \right)^2 + 36 |\xi_0|^2 \left( \mu \sum_{j=1}^r |\xi_j|^2 - |\xi_s|^2 \right) \right] = 0,
$$

i.e.:

<span id="page-15-3"></span>
$$
\mu \bar{\xi}_s \left[ v^{(v)}(0) - 16 \left( |\xi_s|^2 + |\xi_0|^2 \right)^2 \right] = 0. \tag{31}
$$

Comparing [\(30\)](#page-15-2) and [\(31\)](#page-15-3) we get  $\mu = r = 1$  and we are done.
