A DIRECT PROOF OF STAHL'S THEOREM FOR A GENERIC CLASS OF ALGEBRAIC FUNCTIONS

ABSTRACT. Under the assumption of the existence of Stahl's S-compact set we give a short proof of the limit zeros distribution of Padé polynomials and convergence in capacity of diagonal Padé approximants for a generic class of algebraic functions. The proof is direct but not from the opposite as Stahl's original proof is. The generic class means in particular that all branch points of the multi-sheeted Riemann surface of the algebraic function are of the first order (i.e., we assume the surface is such that all branch points are of square root type).

We do not use the relations of orthogonality at all. The proof is based on the maximum principle only.

1. INTRODUCTION

1.1. The seminal Stahl's Theory (see [\[12\]](#page-7-1), [\[13\]](#page-7-0), [\[1\]](#page-6-0) and the bibliography therein) on the convergence of diagonal Pad´e approximants for the multivalued analytic functions consists of two parts. Namely, geometrical part and analytical part. In the first part it is proven that for a multi-valued function there exists a unique admissible compact set S possesses Stahl's symmetric property. Traditionally it is refereed to as an S-compact set or briefly S-curve (see [\[12\]](#page-7-1) and [\[9\]](#page-7-2) for details). In the original Stahl's Theory it is supposed that the set of singularities of a multivalued analytic function is of zero (logarithmic) capacity. Here we restrict our investigation to the case of finite number of singular points only. Note that a short proof of the existence of an S-curve for a multivalued analytic function with a finite number of singular points was proposed by E. Rakhmanov in 1994 in the unpublished paper [\[8\]](#page-7-3) (see also [\[6\]](#page-6-1)). Rakhmanov's proof is based on the connection between capacity and potential of equilibrium measure of a compact set.

In the second part of the Stahl's Theory it is proven that there exists zeros limit distribution of Padé polynomials and convergence in capacity of the diagonal Padé approximants takes place as well. The original Stahl's proof of the existence of limit zeros distribution of Padé polynomials is based on the method of proof from the opposite. In the current paper we give a short and direct proof of the second part of Stahl's Theory for a generic class of algebraic functions and under the assumption that the first geometrical component is valid. We do not use the relations of orthogonality at all. The proof is based on the maximum principle only (cf. $[7]$ and $[11]$).

Let introduce a generic class $\mathscr F$ of admissible multivalued functions which was mentioned above.

We set that $f \in \mathscr{F}$ if the following conditions are satisfied:

(1) f is an algebraic function with all the branch points of the first order (i.e., we assume that all the branch points are of square root type);

(2) S-curve of f consists of a finite number of non-intersected closed analytic arcs each of which contains exactly two branch points of f – the ends of the arc. Some discussion on this assumptions are given in Section [3.](#page-6-2)

1.2. Let $f \in \mathscr{F}$, $f_{\infty} \in \mathscr{H}(\infty)$ and $S = S(f_{\infty})$ be the corresponding Stahl's compact set. Let λ_S be the probability equilibrium measure supported on S and $V^{\lambda_S}(z)$ be the corresponding logarithmic potential of λ_S :

 $g_S(z,\infty)$ is the Green function for the domain D with the logarithmic singularity at the infinity point $z = \infty$ and γ_S is the Robin constant for D.

Set $\mathbb{P}_n := \mathbb{C}_n[z]$ be the set of all algebraic polynomials with complex coefficients of order $\leq n$. For arbitrary polynomial $Q \in \mathbb{C}[z]$, $Q \neq 0$, we denote by $\chi(Q)$ the zero counting measure of $Q: \chi(Q) := \sum_{\zeta} \delta_{\zeta}$, where each zero of Q is $\zeta:Q(\zeta)=0$

represented with respect to its multiplicity.

For $f_{\infty} \in \mathcal{H}(\infty)$ and arbitrary $n \in \mathbb{N}$ Padé polynomials $P_n, Q_n \in \mathbb{P}_n$, $Q_n \not\equiv 0$, are defined (non-uniquely) from the following relation:

 $R_n(z)$ is the so-called error function.

The following result holds (see [\[12\]](#page-7-1), [\[13\]](#page-7-0)).

Theorem 1. Let $f \in \mathcal{F}$ and $f_{\infty} \in \mathcal{H}(\infty)$. Then as $n \to \infty$

Set $Q_n(z) = z^{k_n} + \cdots$, then as $n \to \infty$

\left|f(z) - [n/n]_f(z)\right|^{1/n} \stackrel{\text{cap}}{\longrightarrow} e^{-2g_S(z,\infty)} \quad \text{inside } D. \tag{5}
$$

Recall that the existence of an S-compact set for a function $f \in \mathscr{F}$ follows from $[8]$.

2. Proof of Theorem [1](#page-1-0)

2.1. For two positive sequences $\{\alpha_n\}$ and $\{\beta_n\}$ the relation $\alpha_n \simeq \beta_n$ means that $0 < C_1 \le \alpha_n/\beta_n \le C_2 < \infty$ for $n = 1, 2, \dots$ and some constants C_1, C_2 which do not depend on n. For two sequences $\{\alpha_n(z)\}\$ and $\{\beta_n(z)\}\$ of functions holomorphic in a domain Ω the relation $\alpha_n \simeq \beta_n$ means that for each compact set $K \subset \Omega$ and $n = 1, 2, ...$ $0 < C_1 \leqslant |\alpha_n(z)| / |\beta_n(z)| \leqslant C_2 < \infty$ for $z \in K$ where the constants C_1, C_2 depend on K but do not depend on n and $z \in K$. Evidently that for such pairs of sequences and functions we have that $|\alpha_n/\beta_n|^{1/n} \to 1$ as $n \to \infty$.

Since $f \in \mathscr{F}$, we have that $S = S(f) = \bigcup_{r=1}^{p} S(r)$ $j=1$ S_j , where $S_j = \arctan(a_{2j-1}, a_{2j})$. Set $w^2 = \prod^p$ $j=1$ $(z-a_{2j-1})(z-a_{2j})$. Then the two-sheeted hyperelliptic Riemann surface (RS) $\mathfrak{R}_2(w)$ of the function w is the RS associated with $f_\infty \in \mathscr{H}(\infty)$, $f \in \mathscr{F}$, in accordance with Stahl's Theory. Point **z** on $\Re_2(w)$ is given by $\mathbf{z} = (z, w)$. The RS $\mathfrak{R}_2(w)$ may be considered as a two-sheeted covering of the Riemann sphere $\widehat{\mathbb{C}}$ with the canonical projection π , $\pi \colon \mathfrak{R}_2(w) \to \widehat{\mathbb{C}}$, $\pi(\mathbf{z}) = z$. Let $\Gamma := \pi^{-1}(S)$. Then Γ shares $\mathfrak{R}_2(w)$ into two domains, We shall call them the (open) sheets of $\mathfrak{R}_2(w)$. The function w is a single-valued function on this RS and has opposite signs on the sheets. We denote by $\mathfrak{R}_2^{(0)}$ $u_2^{(0)}$ the sheet of $\Re_2(w)$ where $w(z)/z^p \to 1$ as $z \to \infty$ and refereed to it as zero sheet. Another sheet will be denoted by $\mathfrak{R}_2^{(1)}$ $\frac{1}{2}$ and refereed to as first sheet of $\Re_2(w)$. Then we have $\Re_2(w) = \Re_2^{(0)} \sqcup \Gamma \sqcup \Re_2^{(1)}$ $2^{(1)}$. Points on the sheets will be denoted by $z^{(j)}$, $j = 0, 1$, respectively. Evidently $\pi(\mathfrak{R}_2^{(j)})$ $_{2}^{(J)}$) = D. We shall identify $\mathfrak{R}_2^{(0)}$ with the Stahl's domain $D = \widehat{\mathbb{C}} \setminus S$ and $\infty^{(0)}$ with ∞ and consider the germ f_{∞} as the germ $f_{\infty}(0)$. In general $\Re_2(w)$ is not the Riemann surface of f and thus f is not a single-valued on $\mathfrak{R}_2(w)$. But since $f \in \mathscr{F}$ the germ $f_{\infty(0)}$ can be extended from the infinity point $\infty^{(0)}$ to the whole zero sheet $\mathfrak{R}_2^{(0)}$ 2 and even more to a small enough neighborhood $V^{(0,1)}$ of Γ , $V^{(0,1)} \cap \mathfrak{R}_2^{(1)}$ $_2^{(1)} \neq \emptyset$. In accordance with Stahl's Theory (see also [\[8\]](#page-7-3)) the Green function $g_S(z,\infty)$ of D can be lifted to RS $\mathfrak{R}_2(w)$ as $g(\mathbf{z})$ with the following properties: $g(z^{(0)}) = g(z, \infty)$, $g(z^{(1)}) = -g(z^{(0)}) < 0$. From now on we shall suppose that $V^{(0,1)}$ is such that $\partial V^{(0,1)} \cap \mathfrak{R}_2^{(1)} = \{z^{(1)} : g(z,\infty) = \log R\}, R > 1.$ Set $\mathfrak{D} := \mathfrak{R}_2^{(0)} \cup V^{(0,1)}$ be a domain on $\mathfrak{R}_2(w)$ and $f_{\infty^{(0)}}$ continues in $\mathfrak D$ as a meromorphic (analytic and single-valued) function, $f \in \mathcal{M}(\mathfrak{D})$. The function $R_n(z)$ is also extended to \mathfrak{D} as a meromorphic function $R_n(\mathbf{z})$. Let a polynomial $q_m(z) = z^m + \cdots$ is such that the set of its zeros coincide with the projection of poles of f in \mathfrak{D} . Then $\tilde{f}:=q_nf$ and q_mR_n are holomorphic functions in \mathfrak{D} .

2.2. For each $\rho \in (1,R)$ we denote by $\Gamma_{\rho}^{(1)}$ the set of points $z^{(1)}$ such that $g_S(z,\infty) = \log \rho$ as $z^{(1)} \in \Gamma_\rho^{(1)}$. Clearly we have $g(z^{(1)}) = -\log \rho$. The set $\Gamma_\rho^{(0)}$ is defined similarly and we have on that set $g(z^{(0)}) = \log \rho$. For $\rho \in (1, R)$ let $D_{\rho}^{(1)}$ be a subdomain of \mathfrak{D} with $\partial D_{\rho}^{(1)} = \Gamma_{\rho}^{(1)}$, $\infty^{(0)} \in D^{(1)}$. Similarly $D_{\rho}^{(0)} \subset \mathfrak{D}$, $\partial D^{(0)} = \Gamma_{\rho}^{(0)}, \, \infty^{(0)} \in D^{(0)}$. Set

u_n(\mathbf{z}) := \log |q_m(z)R_n(\mathbf{z})| + (n+1-m)g(\mathbf{z}), \quad \mathbf{z} \in \mathfrak{D}.
$$

Function u_n is a subharmonic function in \mathfrak{D} . Thus for each $\rho \in (1, R)$ we have that

u_n(\mathbf{z}) \leq \max_{\zeta \in \Gamma^{(1)}_{\rho}} u_n(\zeta), \quad \mathbf{z} \in D^{(1)}_{\rho}.
$$

From [\(7\)](#page-2-0) it follows that

$$
\left| R_n(z^{(0)})q_m(z) \right| \leqslant \frac{1}{\rho^{2n+2-2m}} M_{n,1}(\rho), \qquad z \in \Gamma_\rho. \tag{8}
$$

where we set $M_{n,1}(\rho) := \max_{z \in \Gamma_\rho} |R_n(z^{(1)}) q_m(z)|$. Relations [\(6\)](#page-2-1) and [\(7\)](#page-2-0) imply that for $1 < \rho_1 < \rho_2 < R$ we have

M_{n,1}(\rho_1) \leqslant \left(\frac{\rho_2}{\rho_1}\right)^{n-m+1} M_{n,1}(\rho_2). \tag{9}
$$

The following identity holds true:

R_n(z^{(0)}) = Q_n(z)f(z^{(0)}) - P_n(z) = Q_n(z)f(z^{(1)}) - P_n(z) + Q_n(z)[f(z^{(0)}) - f(z^{(1)})]

R_n(z^{(1)}) + Q_n(z)[f(z^{(0)}) - f(z^{(1)})], \quad z \in \Gamma_\rho.
$$

From (8) and (9) it follows that

$$
\max_{z \in \Gamma_{\rho}} |Q_n(z)[f(z^{(0)}) - f(z^{(1)})]q_m(z)| = M_{n,1}(\rho)(1 + \varepsilon_n), \quad \varepsilon_n \to 0. \tag{11}
$$

From now on we shall consider only such $\rho \in (1, R)$ that $|q_m(z)[f(z^{(0)})-f(z^{(1)})] \ge$ $C(\rho) > 0$ as $z \in \Gamma_\rho$ (clearly, $f(z^{(0)}) - f(z^{(1)}) \not\equiv 0$). Set $m_n(\rho) := \max_{z \in \Gamma_\rho} |Q_n(z)|$. Then from [\(11\)](#page-3-1) it follows that

m_n(\rho) \asymp M_{n,1}(\rho). \tag{12}
$$

Since deg $Q_n \leq n$, then Bernstein–Walsh theorem gives us the inequality:

|Q_n(z)| \leq e^{n g_{\Gamma_{\rho_1}}(z,\infty)} m_n(\rho_1), \quad z \in \Gamma_{\rho_2}, \quad \rho_2 > \rho_1,\tag{13}
$$

where $g_{\Gamma_{\rho_1}}(z,\infty)$ is the Green function for the domain $g_S(z,\infty) > \log \rho_1$. Clearly, $g_{\Gamma_{\rho_1}}(z,\infty) = g_S(z,\infty) - \log \rho_1$. From [\(13\)](#page-3-2) we obtain the estimate

m_n(\rho_2) \leqslant \left(\frac{\rho_2}{\rho_1}\right)^n m_n(\rho_1). \tag{14}
$$

After combining the relations (9) , (12) and (14) we obtain that

m_n(\rho_2) \asymp \left(\frac{\rho_2}{\rho_1}\right)^n m_n(\rho_1) \quad \text{and} \quad M_{n,1}(\rho_2) \asymp \left(\frac{\rho_2}{\rho_1}\right)^n M_{n,1}(\rho_1). \tag{15}
$$

Let $Q_n(z) = z^{k_n} + \cdots$, $k_n = \deg Q_n \leq n$. Again Bernstein–Walsh theorem gives us the inequality:

|Q_n(z)| \leqslant e^{k_n g_{\Gamma_{\rho_1}}(z,\infty)} m_n(\rho_1), \quad z \in \Gamma_{\rho_2}, \quad \rho_2 > \rho_1. \tag{16}
$$

From this relation it follows that

m_n(\rho_2) \leqslant \left(\frac{\rho_2}{\rho_1}\right)^{k_n} m_n(\rho_1). \tag{17}
$$

But in accordance with [\(15\)](#page-3-5) $m_n(\rho_2) \approx (\rho_2/\rho_1)^n m_n(\rho_1)$. From here and [\(17\)](#page-3-6) we obtain the inequality

\left(\frac{\rho_2}{\rho_1}\right)^n \leqslant C \left(\frac{\rho_2}{\rho_1}\right)^{k_n},\tag{18}

where $C = C(\rho_1, \rho_2)$, $k_n \leq n, 1 < \rho_1 < \rho_2$. It directly follows from [\(18\)](#page-3-7) that

2.3. Let $D_{\rho} := \{z \in \widehat{\mathbb{C}} : g_S(z) > \log \rho\}, \ \rho > 1, \ g_{\Gamma_{\rho}}(z,\infty)$ be the Green function for D_{ρ} . Then $g_{\Gamma_{\rho}}(z,\infty) = g_S(z,\infty) - \log \rho = \log |z| + \gamma_{\rho} + o(1) =$ $\log|z| + \gamma_S - \log \rho + o(1)$. Thus $\gamma_\rho = \gamma_S - \log \rho$. **Set**

$$
\mathbf{t} =
$$

$$
u_n(z) := \frac{1}{k_n} \log |Q_n(z)| - g_{\Gamma_\rho}(z, \infty) - \frac{1}{k_n} \log m_n(\rho).
$$
 (20)

Since function u_n is subharmonic in the domain D_ρ and $u_n \leq 0$ on Γ_ρ , then $u_n \leq 0$ in D_ρ and $u_n(\infty) \leq 0$. Thus we have that $\log \rho - \gamma_S \leqslant \log m_n(\rho)^{1/k_n}$ and finally obtain

m_n(\rho)^{1/k_n} \geqslant \rho e^{-\gamma_S} = \rho \operatorname{cap}(S). \tag{21}
$$

For $z \in K \Subset D\rho$ and $\zeta \in \Gamma_\rho$ we have by definition $g_{\Gamma_\rho}(z,\zeta) = 0$. Let now extend the function $g_{\Gamma_{\rho}}(z,\zeta)$ inside Γ_{ρ} by identity $g_{\Gamma_{\rho}}(z,\zeta) \equiv 0$ when $z \in D_{\rho}$, $\zeta \in \mathrm{int}\,\Gamma_{\rho}$.

Let

Q_n(z) = \prod_{j=1}^{k_n} (z - \zeta_j),
$$

$$
v_n(z) := \frac{1}{k_n} \log |Q_n(z)| - g_{\Gamma_\rho}(z, \infty) + \frac{1}{k_n} \sum_{j=1}^{k_n} g_{\Gamma_\rho}(z, \zeta_j) - \frac{1}{k_n} \log m_n(\rho), \quad (22)
$$

 $z \in D_\rho$. Then v_n is a harmonic function in D_ρ and $v_n \leq 0$ on Γ_ρ . From this it follows that for $z \in \Gamma_{\rho_2}$, $\rho < \rho_2 < R$, we have

|Q_n(z)| \exp\left\{\sum_{j=1}^{k_n} g_{\Gamma_\rho}(z,\zeta_j)\right\} \leq m_n(\rho) \exp\left\{k_n g_{\Gamma_\rho}(z,\infty)\right\}.
$$

Let $z_n^* \in \Gamma_{\rho_2}$ is such that $|Q_n(z_n^*)| = m_n(\rho_2)$. Then from [\(23\)](#page-4-0) we obtain that

m_n(\rho_2) \exp\left\{ \sum_{j=1}^{k_n} g_{\Gamma_\rho}(z_n^*, \zeta_j) \right\} \leqslant m_n(\rho) \left(\frac{\rho_2}{\rho}\right)^{k_n}.

Ultimately from (24) and (15) we obtain that

\exp\left\{\frac{1}{k_n}\sum_{j=1}^{k_n}g_{\Gamma_\rho}(z_n^*,\zeta_j)\right\}\leqslant C(\rho,\rho_2)^{1/k_n},\quad\varepsilon_n\to 0.
$$

Let now $\Lambda \subset \mathbb{N}$ is a subsequence such that $z_n^* \to z^* \in \Gamma_{\rho_2}$ and $\frac{1}{k_n}\chi(Q_n) \to \mu$ as $n \to \infty$, $n \in \Lambda$, $\mu(1) = 1$. Then according to the descendence principle (see [\[5,](#page-6-3) Chapter I, $\S 3$, Theorem 1.3, [\[10\]](#page-7-6), [\[2\]](#page-6-4) and [\[3\]](#page-6-5)), we have that

\int g_{\Gamma_{\rho}}(z^*, \zeta) d\mu(\zeta) \leq 0, \quad z^* \in \Gamma_{\rho_2}, \quad \rho_2 > \rho. \tag{26}
$$

It directly follows from [\(26\)](#page-4-2) that $\text{supp }\mu \subset \widehat{\mathbb{C}} \setminus D_{\rho}$. Since it is true for every $\rho > 1$ than we have that $\text{supp}\,\mu\subset S$.

2.4. So we have got that $k_n/n \to 1$ and each limit point μ of the sequence $\{\frac{1}{k}\}$ $\frac{1}{k_n}\chi(Q_n)$ satisfies the condition supp $\mu \subset S$.

Since supp $\mu \subset S$ we have that

\overline{\lim}_{\substack{n \to \infty \\ n \in \Lambda}} m_n(\rho)^{1/k_n} \leqslant C_2 < \infty.
$$

Also from [\(21\)](#page-4-3) it follows that

\lim_{\substack{n \to \infty \\ n \in \Lambda}} m_n(\rho)^{1/k_n} \geqslant C_1 > 0.
$$

Set

u_n(z) := \frac{1}{k_n} \log \frac{1}{|Q_n(z)|} - \frac{1}{k_n} \sum_{j=1}^{k_n} g_{\Gamma_\rho}(z, \zeta_j) + g_{\Gamma_\rho}(z, \infty), \quad z \in D_\rho.
$$

Then $\{u_n\}$ is a sequence of harmonic functions in D_ρ . Let $u(z) = \lim_{n \to \infty} u_n(z)$. Then u is a harmonic function with the following properties (see (15)):

From this it follows that $u(z) = \text{const}$ and thus $V^{\mu}(z) = V^{\lambda_S}(z)$ for $z \in D_{\rho}$. Since supp $\mu \subset S$, then $V^{\mu}(z) = V^{\lambda_S}$ for $z \in D$. Finally $\mu = \lambda_S$ because S has no inner points.

Eventually we have that for each $\rho > 1$ there exist the limits

From the above it easy to prove that

|R_n(z)|^{1/n} \xrightarrow{\text{cap}} \text{cap}(S)e^{-g_S(z,\infty)}, \quad n \to \infty.

Indeed, let

v_n(z) := \frac{1}{n - m + 1} \log |q_m(z)R_n(z)| + g_S(z, \infty) + \gamma_S. \tag{30}
$$

Then for each $\rho > 1$ function v_n is a subharmonic function in D_ρ and from [\(28\)](#page-5-0) it follows that for $z \in \Gamma_\rho$ we have

v_n(z) \leqslant C_n,\tag{31}
$$

where $C_n \to 0$ as $n \to \infty$. From [\(31\)](#page-5-1) we obtain that for $z \in D_\rho$

|q_m(z)R_m(z)|^{1/(n-m+1)} \leqslant \text{cap}(S)e^{-g_S(z,\infty)}e^{C_n}.

Thus

\overline{\lim}_{n \to \infty} |R_n(z)|^{1/n} \leqslant \text{cap}(S)e^{-g_S(z,\infty)}.

Relation [\(29\)](#page-5-2) follows from [\(28\)](#page-5-0) and [\(33\)](#page-5-3) by two-constants theorem (cf. $[4, 8, 3, 3]$ subsection 8, (31)–(36)]).

Since $\frac{1}{n}\chi(Q_n) \to \lambda_S$, then inside D

|Q_n(z)|^{1/n} \xrightarrow{\text{cap}} e^{-V^{\lambda_S}(z)}, \quad n \to \infty. \tag{34}
$$

From (29) and (34) the relation (5) follows.

Theorem [1](#page-1-0) is proven.

3. Appendix

In fact the admissible class of analytic functions is wider then it is described in the items $(1)-(2)$ of definition of $\mathscr F$. In particular our approach is valid for the class of multivalued functions generated by the inverse Zhoukovskii transform. More precisely, let $\varphi(z) := z + (z^2 - 1)^{1/2}$, where $z \in \widehat{\mathbb{C}} \setminus \Delta$, $\Delta = [-1, 1]$ and such branch of the function $(\cdot)^{1/2}$ is chosen that $\varphi(z)/z \to 2$ as $z \to \infty$. Let $1 < A < B < \infty$ and $a := (A + 1/A)/2$, $b := (B + 1/B)/2$. Then the function

$$
\mathfrak{f}_{\Delta}(z) := \left[\left(A - \frac{1}{\varphi(z)} \right) \left(B - \frac{1}{\varphi(z)} \right) \right]^{1/2} \tag{35}
$$

is an algebraic function of forth order with the set of square root singularities $\Sigma(f) = \{\pm 1, a, b\}$. Under the above conditions on $(\cdot)^{1/2}$ we have that $f \in \mathscr{H}(\widehat{\mathbb{C}} \setminus \Delta)$ and Stahl's compact set $S(f) = [-1, 1]$. Now let $\varphi_{\Delta_j}(z)$ be the inverse Zhoukovskii function for a segment $\Delta_j := [\alpha_j, \beta_j], j = 1, \ldots, m, \Delta_j \cap \Delta_k = \emptyset, j \neq k$. Set

$$
f(z) := \prod_{j=1}^{m} f_{\Delta_j}(z),
$$
\n(36)

where each $f_{\Delta_j}(z)$ is defined by [\(35\)](#page-6-7) with some suitable A_j and B_j .

When all $\Delta_j \subset \mathbb{R}$, $j = 1, ..., m$, then $S(\mathfrak{f}) = \bigsqcup_{j=1}^{m}$ $j=1$ Δ_j , Since $\mathbb{C}(z,\mathfrak{f}) \subset \mathscr{F}$, our

approach is valid for each $f \in \mathbb{C}(z, \mathfrak{f}).$

Another admissible and non-trivial subclass of $\mathscr F$ is obtained when at least one of the branch points $\alpha_j, \beta_j, j = 1, \ldots, m$, of f does not belong to the real line.

We can generalize [\(35\)](#page-6-7) in the following way. Set

$$
\mathfrak{f}_{\Delta}(z) := \prod \left(A - \frac{1}{\varphi(z)} \right)^{\alpha} \left(B - \frac{1}{\varphi(z)} \right)^{\beta} \cdot \ldots \cdot \left(C - \frac{1}{\varphi(z)} \right)^{\gamma}, \qquad (37)
$$

where $\alpha, \beta, \ldots, \gamma \in \mathbb{C} \setminus \mathbb{Z}, \alpha + \beta + \cdots + \gamma \in \mathbb{Z}$, to obtain functions which are not from $\mathscr F$ but for which the proof from Section 2 is also valid.
