# A heat flow for the mean field equation on a finite graph

## Abstract

Inspired by works of Castéras (Pacific J. Math., 2015), Li-Zhu (Calc. Var., 2019) and Sun-Zhu (Calc. Var., 2020), we propose a heat flow for the mean field equation on a connected finite graph  $G = (V, E)$ . Namely

$$
\begin{cases} \partial_t \phi(u) = \Delta u - Q + \rho \frac{e^u}{\int_V e^u d\mu} \\ u(\cdot, 0) = u_0, \end{cases}
$$

where  $\Delta$  is the standard graph Laplacian,  $\rho$  is a real number,  $Q: V \to \mathbb{R}$  is a function satisfying  $\int_V Q d\mu = \rho$ , and  $\phi : \mathbb{R} \to \mathbb{R}$  is one of certain smooth functions including  $\phi(s) = e^s$ . We prove that for any initial data  $u_0$  and any  $\rho \in \mathbb{R}$ , there exists a unique solution  $u : V \times [0, +\infty) \to \mathbb{R}$ of the above heat flow; moreover,  $u(x, t)$  converges to some function  $u_{\infty}: V \to \mathbb{R}$  uniformly in  $x \in V$  as  $t \to +\infty$ , and  $u_{\infty}$  is a solution of the mean field equation

$$
\Delta u_{\infty} - Q + \rho \frac{e^{u_{\infty}}}{\int_{V} e^{u_{\infty}} d\mu} = 0.
$$

Though *G* is a finite graph, this result is still unexpected, even in the special case  $O \equiv 0$ . Our approach reads as follows: the short time existence of the heat flow follows from the ODE theory; various integral estimates give its long time existence; moreover we establish a Lojasiewicz-Simon type inequality and use it to conclude the convergence of the heat flow.

*Key words:* Heat flow on graph, the Lojasiewicz-Simon inequality, mean field equation *2010 MSC:* 35R02, 34B45

#### 1. Introduction

Let us start with the mean field equation on a closed Riemann surface  $(\Sigma, g)$ , which says

$$
-\Delta_g u + Q = \rho \frac{e^u}{\int_{\Sigma} e^u dv_g},\tag{1}
$$

where  $\rho \in \mathbb{R}$  is a number,  $Q : \Sigma \to \mathbb{R}$  is a smooth function with  $\int_{\Sigma} Q dv_g = \rho$ , and  $\Delta_g$  is the Laplacian operator with respect to the metric *g*. This equation arises in various topics such as conformal geometry [\[21](#page-13-0)], statistical mechanics [\[2\]](#page-13-1), and the abelian Chen-Simons-Higgs model [\[35,](#page-14-0) [3](#page-13-2), [9\]](#page-13-3). The existence of solutions of [\(1\)](#page-0-0) has been extensively investigated for several decades. Landmark achievements have been obtained for the case  $\rho \neq 8k\pi$ ,  $k \in \mathbb{N}$ , [\[1](#page-13-4), [7,](#page-13-5) [10](#page-13-6), [24,](#page-13-7) [25,](#page-13-8) [29,](#page-13-9) [32](#page-13-10), [11](#page-13-11)], and for the case  $\rho = 8\pi$  [\[8\]](#page-13-12).

In 2015, Castéras [\[4,](#page-13-13) [5\]](#page-13-14) proposed and studied the following parabolic equation

$$
\begin{cases} \frac{\partial}{\partial t} e^{u} = \Delta_{g} u - Q + \rho \frac{e^{u}}{\int_{\Sigma} e^{u} dv_{g}} \\ u(x, 0) = u_{0}(x), \end{cases}
$$
 (2)

where  $u_0 \in C^{2,\alpha}(\Sigma)$ ,  $0 < \alpha < 1$ , is the initial data,  $\Delta_g$ ,  $Q$  and  $\rho$  are described as in [\(1\)](#page-0-0). It is a gradient flow for the energy functional  $J_\rho : W^{1,2}(\Sigma, g) \to \mathbb{R}$  defined by

$$
J_{\rho}(u) = \frac{1}{2} \int_{\Sigma} |\nabla_g u|^2 dv_g + \int_{\Sigma} Q u dv_g - \rho \log \int_{\Sigma} e^u dv_g,
$$

where  $\nabla_g$  is the gradient operator with respect to the metric *g*. It was proved by Castéras that for any  $\rho \neq 8k\pi$ ,  $k = 1, 2, \dots$ , there exists some initial data  $u_0$  such that  $u(\cdot, t)$  converges to a function  $u_{\infty}$  in  $W^{2,2}(\Sigma)$ , where  $u_{\infty}$  is a solution of the mean field equation [\(1\)](#page-0-0); For  $\rho = 8\pi$ , a sufficient condition for convergence of the flow [\(2\)](#page-1-0) was given by Li-Zhu [\[23\]](#page-13-15). This gives a new proof of the result of Ding-Jost-Li-Wang [\[8](#page-13-12)], which was extended by Chen-Lin [\[6](#page-13-16)] to a general critical case, and generalized by Yang-Zhu [\[37\]](#page-14-1) to a non-negative prescribed function case. Recently, using a more refined analysis, Sun-Zhu [\[34\]](#page-14-2) studied a modified version of [\(2\)](#page-1-0), i.e. the parabolic equation

$$
\begin{cases} \frac{\partial}{\partial t} e^{u} = \Delta_{g} u - \frac{8\pi}{\text{Area}(\Sigma)} + 8\pi \frac{he^{u}}{\int_{\Sigma} he^{u} dv_{g}} \\ u(x,0) = u_{0}(x), \end{cases}
$$
 (3)

where  $h(x) \ge 0$ ,  $h \ne 0$  on  $\Sigma$ , and Area( $\Sigma$ ) =  $\int_{\Sigma} dv_g$  denotes the area of  $\Sigma$ . Clearly this is another method of proving the result in [\[37\]](#page-14-1).

In this paper, we are concerned with the mean field equation on a finite graph. Let us fix some notations. Assume  $G = (V, E)$  is a finite graph, where V denotes the vertex set and E denotes the edge set. For any edge  $xy \in E$ , we assume that its weight  $w_{xy} > 0$  and that  $w_{xy} = w_{yx}$ . Let  $\mu: V \to \mathbb{R}^+$  be a finite measure. For any function  $u: V \to \mathbb{R}$ , the Laplacian of *u* is defined as

$$
\Delta u(x) = \frac{1}{\mu(x)} \sum_{y \sim x} w_{xy}(u(y) - u(x)),
$$
 (4)

where *y* ∼ *x* means  $xy \in E$ , or *y* and *x* are adjacent. The associated gradient form reads

$$
\Gamma(u, v)(x) = \frac{1}{2\mu(x)} \sum_{y \sim x} w_{xy}(u(y) - u(x))(v(y) - v(x)).
$$

Write  $\Gamma(u) = \Gamma(u, u)$ . We denote the length of its gradient by

$$
|\nabla u|(x) = \sqrt{\Gamma(u)(x)} = \left(\frac{1}{2\mu(x)} \sum_{y \sim x} w_{xy}(u(y) - u(x))^2\right)^{1/2}.
$$
 (5)

For any function  $g: V \to \mathbb{R}$ , an integral of *g* over *V* is defined by

<span id="page-2-1"></span>
$$
\int_{V} g d\mu = \sum_{x \in V} \mu(x) g(x). \tag{6}
$$

Let  $W^{1,2}(V)$  be a Sobolev space including all real functions *u* with the norm

$$
||u||_{W^{1,2}(V)} = \left(\int_V (|\nabla u|^2 + u^2) d\mu\right)^{1/2}.
$$

As an analog of [\(1\)](#page-0-0), the mean field equation on the finite graph *G* reads as

<span id="page-2-0"></span>
$$
-\Delta u + Q = \rho \frac{e^u}{\int_V e^u d\mu},\tag{7}
$$

where  $\rho$  is a real number,  $Q: V \to \mathbb{R}$  is a function with  $\int_V Q d\mu = \rho$ , and  $\Delta$  is the graph Laplacian with respect to the measure  $\mu$  as in [\(4\)](#page-1-1). The equation [\(7\)](#page-2-0) can be viewed as a discrete version of [\(1\)](#page-0-0). Let  $\phi : \mathbb{R} \to \mathbb{R}$  be a  $C^1$  function. We propose the following heat flow

<span id="page-2-2"></span>
$$
\begin{cases} \frac{\partial}{\partial t} \phi(u) = \Delta u - Q + \rho \frac{e^u}{\int_V e^u d\mu} \\ u(x, 0) = u_0(x), \quad x \in V. \end{cases}
$$
 (8)

This is an analog of [\(3\)](#page-1-2). Obviously it is a gradient flow for the functional  $J_\rho : W^{1,2}(V) \to \mathbb{R}$ , which is defined as

<span id="page-2-5"></span>
$$
J_{\rho}(u) = \frac{1}{2} \int_{V} |\nabla u|^2 d\mu + \int_{V} Q u d\mu - \rho \log \int_{V} e^u d\mu,
$$
 (9)

where the notations [\(5\)](#page-1-3) and [\(6\)](#page-2-1) are used. Our main result is stated as follows:

<span id="page-2-3"></span>**Theorem 1.** Let  $G = (V, E)$  be a connected finite graph. Suppose  $\phi : \mathbb{R} \to \mathbb{R}$  is a  $C^1$  function *satisfying*

<span id="page-2-6"></span>
$$
\lim_{s \to -\infty} \phi(s) = 0, \quad \phi'(s) > 0 \text{ for all } s \in \mathbb{R}, \quad \inf_{s \in [0, +\infty)} \phi'(s) > 0. \tag{10}
$$

Let  $\rho$  be any real number, and Q be any function with  $\int_V Q d\mu = \rho$ . Then for any initial function  $u_0: V \to \mathbb{R}$ *, we have the following assertions:* 

(*i*) *there exists a unique solution*  $u : V \times [0, \infty) \rightarrow \mathbb{R}$  *of the heat flow [\(8\)](#page-2-2);* 

(*ii*) *there exists some function*  $u_{\infty}: V \to \mathbb{R}$  *such that*  $u(\cdot, t)$  *converges to*  $u_{\infty}$  *uniformly in*  $x \in V$ *as t* → +∞*; moreover u*<sup>∞</sup> *is a solution of the mean field equation* [\(7\)](#page-2-0)*.* 

There are two interesting special cases of results in Theorem [1](#page-2-3) as follows:

<span id="page-2-4"></span>**Corollary 2.** Let  $G = (V, E)$  and  $\phi$  be as in Theorem [1.](#page-2-3) If  $\int_V f d\mu = 0$ , then for any initial *function*  $u_0: V \to \mathbb{R}$ *, the heat flow* 

$$
\begin{cases} \frac{\partial}{\partial t} \phi(u) = \Delta u - f \\ u(\cdot, 0) = u_0 \end{cases}
$$

*has a solution*  $u: V \times [0, +\infty) \to \mathbb{R}$ *. Moreover, there exists some function*  $u^*$  *such that*  $u(\cdot, t)$ *converges to*  $u^*$  *as t*  $\rightarrow +\infty$  *uniformly in*  $x \in V$ *, and that*  $u^*$  *satisfies* 

$$
\left\{ \begin{array}{l} \Delta u^*=f\\ \int_V \phi(u^*)d\mu=\int_V \phi(u_0)d\mu. \end{array} \right.
$$

<span id="page-3-0"></span>**Corollary 3.** Let  $G = (V, E)$  and  $\phi$  be as in Theorem [1.](#page-2-3) Then for any initial function  $u_0 : V \to \mathbb{R}$ , *the heat flow*

$$
\begin{cases} \frac{\partial}{\partial t} \phi(u) = \Delta u \\ u(\cdot, 0) = u_0 \end{cases}
$$

*has a solution u* :  $V \times [0, +\infty) \rightarrow \mathbb{R}$ *; moreover, as t*  $\rightarrow +\infty$ *, u*( $\cdot$ *,t*) *converges to a constant c uniformly in*  $x \in V$ *, in particular* 

$$
\phi(c) = \frac{1}{|V|} \int_V \phi(u_0) d\mu.
$$

Obviously there are infinitely many examples of  $\phi$  in Theorem [1.](#page-2-3) A typical example is

$$
\phi(s) = \begin{cases} e^{\alpha s} + \beta s^p & \text{when } s > 0\\ e^{\alpha s} & \text{when } s \le 0, \end{cases}
$$

where  $\alpha > 0$ ,  $\beta \ge 0$  and  $p > 1$  are constants. Another one says for any real number  $a > 1$ ,

$$
\phi(s) = \begin{cases} s^2 + (\log a)(s + \cos s - 1) + 1 & \text{when} \quad s > 0 \\ a^s & \text{when} \quad s \le 0. \end{cases}
$$

Though  $G = (V, E)$  is a finite graph, the results in Theorem [1](#page-2-3) are quite unexpected, even in special cases  $\rho = 0$  and  $Q \equiv 0$  (Corollaries [2](#page-2-4) and [3\)](#page-3-0). As for its proof, we find a way of thinking from Simon [\[31](#page-13-17)], Jendoubi [\[20\]](#page-13-18), Castéras [\[4](#page-13-13), [5](#page-13-14)], Li-Zhu [\[23\]](#page-13-15), and Sun-Zhu [\[34\]](#page-14-2). Firstly, we use the ODE theory to conclude the short time existence of the heat flow [\(8\)](#page-2-2). Secondly, we obtain the global existence of the flow through estimating the uniform bound of  $||u(\cdot,t)||_{W^{1,2}(V)}$  for all time *t*. This allows us to select a sequence of times  $(t_n) \rightarrow +\infty$  such that  $u(\cdot, t_n)$  converges to some function  $u_{\infty}$  uniformly in *V*, where  $u_{\infty}$  is a solution of the mean field equation [\(7\)](#page-2-0). Thirdly, we establish a Lojasiewicz-Simon type inequality along the heat flow by employing an estimate due to Lojasiewicz ([\[28\]](#page-13-19), Theorem 4, page 88), namely

<span id="page-3-2"></span>**Lemma 4.** (Lojasiewicz, 1963). *Let*  $\Gamma : \mathbb{R}^{\ell} \to \mathbb{R}$  *be an analytic function in a neighborhood of a point*  $\mathbf{a} \in \mathbb{R}^{\ell}$  *with*  $\nabla \Gamma(\mathbf{a}) = \mathbf{0} \in \mathbb{R}^{\ell}$ *. Then there exist*  $\sigma > 0$  *and*  $0 < \theta < 1/2$  *such that* 

$$
\|\nabla \Gamma(\mathbf{y})\| \geq |\Gamma(\mathbf{y}) - \Gamma(a)|^{1-\theta}, \quad \forall \mathbf{y} \in \mathbb{R}^{\ell}, \ \|\mathbf{y} - \mathbf{a}\| < \sigma,
$$

*where*  $\nabla \Gamma(\mathbf{y}) = (\partial_{y_1} \Gamma(\mathbf{y}), \cdots, \partial_{y_\ell} \Gamma(\mathbf{y})),$  and  $\|\cdot\|$  stands for the standard norm of  $\mathbb{R}^\ell$ .

Finally, we conclude the uniform convergence of  $u(\cdot, t)$  to  $u_{\infty}$  as  $t \to +\infty$  with the help of the above Lojasiewicz-Simon type inequality. Since the graph *G* is finite, this inequality seems much simpler than that of [\[31](#page-13-17), [20](#page-13-18), [4](#page-13-13), [5](#page-13-14), [23](#page-13-15), [34](#page-14-2)]. Moreover, in our case, all integral estimates look very concise and very easy to understand.

Note that if the mean field equation [\(7\)](#page-2-0) has a solution, so does the Kazdan-Warner equation [\[14\]](#page-13-20). For such kind of equations, see for examples [\[12](#page-13-21), [22,](#page-13-22) [19,](#page-13-23) [27](#page-13-24), [33,](#page-13-25) [39\]](#page-14-3). According to [\[14](#page-13-20)], its solvability needs some assumptions. While Theorem [1](#page-2-3) implies that for any real number  $\rho$ , [\(7\)](#page-2-0) is solvable. One may ask whether or not these two conclusions are consistent. Let us answer this question. Suppose that  $u_{\infty}$  is given as in Theorem [1](#page-2-3) and satisfies the mean field equation [\(7\)](#page-2-0). Clearly  $v = u_{\infty} - \log \int_V e^{u_{\infty}} d\mu$  is a solution of the Kazdan-Warner equation

<span id="page-3-1"></span>
$$
\Delta v = Q - \rho e^v. \tag{11}
$$

By the assumption in Theorem [1,](#page-2-3)  $\int_V Q d\mu = \rho$ . If we assume  $Q \equiv c$  for some constant *c*, then  $\rho = c|V|$ , where  $|V| = \sum_{x \in V} \mu(x)$  denotes the volume of the graph. It follows from ([\[14](#page-13-20)], Theorems 2-4) that if  $c > 0$  or  $c < 0$ , then [\(11\)](#page-3-1) has a solution. This implies that the results of Theorem [1](#page-2-3) and those of [\[14\]](#page-13-20) are consistent and do not contradict each other.

For flow on infinite graph, partial existence results for the mean field equation are obtained by Ge-Jiang [\[13\]](#page-13-26). Also there is a possibility of solving problems in [\[15,](#page-13-27) [16](#page-13-28), [17,](#page-13-29) [18,](#page-13-30) [26](#page-13-31), [30,](#page-13-32) [38\]](#page-14-4) by a method of heat flow. Throughout this paper, we often denote various constants by the same *C* from line to line, even in the same line. The remaining part of this paper is arranged as follows: In Section 2, we prove the short time existence of the heat flow; In Section 3, we show the heat flow exists for all time  $t \in [0, +\infty)$ ; In Section 4, we establish a Lojasiewicz-Simon type inequality and use it to prove the uniform convergence of the heat flow as  $t \to +\infty$ . As a consequence, the proof of Theorem [1](#page-2-3) is finished.

### <span id="page-4-2"></span>2. Short time existence

In this section, using the theory of ordinary differential equation, we shall prove that the solution of the heat flow [\(8\)](#page-2-2) exists on a short time interval. Also we shall give several properties of the heat flow.

Since  $G = (V, E)$  is a finite graph, we assume with no loss of generality that  $V = \{x_1, \dots, x_\ell\}$ for some integer  $\ell \ge 1$ . Then any function  $u: V \to \mathbb{R}$  can be represented by  $y = (y_1, \dots, y_\ell) \in \mathbb{R}^\ell$ with  $y_j = u(x_j)$  for  $1 \le j \le \ell$ ; moreover, we denote

<span id="page-4-3"></span>
$$
\mathcal{M}(u) = \Delta u - Q + \frac{\rho e^u}{\int_V e^u d\mu} \tag{12}
$$

and a map  $\mathcal{F}: \mathbb{R}^{\ell} \to \mathbb{R}^{\ell}$  by  $\mathcal{F}(\mathbf{y}) = (f_1(\mathbf{y}), \cdots, f_{\ell}(\mathbf{y})),$  where  $f_j(\mathbf{y}) = \mathcal{M}(u)(x_j)$  for  $1 \le j \le \ell$ . Then the equation [\(8\)](#page-2-2) is equivalent to the ordinary differential system

<span id="page-4-0"></span>
$$
\begin{cases}\n\frac{d}{dt}\phi(y_1) &= f_1(\mathbf{y}) \\
\vdots \\
\frac{d}{dt}\phi(y_\ell) &= f_\ell(\mathbf{y}) \\
\mathbf{y}(0) &= \mathbf{y}_0,\n\end{cases}
$$
\n(13)

where  $y_0 = (u_0(x_1), \dots, u_0(x_\ell))$  is the initial data. For the map  $\mathcal F$ , we have the following:

<span id="page-4-4"></span>**Lemma 5.** The map  $\mathcal{F} : \mathbb{R}^{\ell} \to \mathbb{R}^{\ell}$  is analytic.

*Proof.* At  $\mathbf{v} = (u(x_1), \dots, u(x_\ell))$ , we write

$$
f_j(\mathbf{y}) = \mathcal{M}(u)(x_j) = \frac{1}{\mu(x_j)} \sum_{z \sim x_j} w_{zx_j}(u(z) - u(x_j)) - Q(x_j) + \frac{\rho e^{u(x_j)}}{\sum_{i=1}^{\ell} \mu(x_i) e^{u(x_i)}}.
$$

Replacing  $(u(x_1), \dots, u(x_\ell))$  by y on the righthand side of the above equality, we have that  $f_j$  is analytic,  $j = 1, \dots, \ell$ .

On the short time existence of solutions of [\(8\)](#page-2-2), we obtain

<span id="page-4-1"></span>**Lemma 6.** *There exists some constant*  $T^* > 0$  *such that* [\(8\)](#page-2-2) *has a solution*  $u : V \times [0, T^*] \to \mathbb{R}$ *.* 

*Proof.* By the short time existence theorem of the ordinary differential equation ([\[36](#page-14-5)], page 250), there exist some  $T^* > 0$  and a  $C^1$  map  $y : [0, T^*] \to \mathbb{R}^{\ell}$  such that  $y(t)$  satisfies [\(13\)](#page-4-0). Define  $u(x_j, t) = y_j(t)$  for  $1 \le j \le \ell$ . Then  $u : V \times [0, T^*] \to \mathbb{R}$  is a solution of [\(8\)](#page-2-2).

For any  $\rho \in \mathbb{R}$ , let  $J_{\rho}: W^{1,2}(V) \to \mathbb{R}$  be a functional defined as in [\(9\)](#page-2-5). One can easily see that [\(8\)](#page-2-2) is a negative gradient flow of  $J<sub>o</sub>$ . In particular

<span id="page-5-3"></span>
$$
\langle dJ_{\rho}(u(\cdot,t)), \phi \rangle = -\int_{V} \mathcal{M}(u(\cdot,t)) \phi d\mu, \quad \forall \phi \in W^{1,2}(V). \tag{14}
$$

Along the heat flow [\(8\)](#page-2-2), there are two important quantities: one is invariant, the other is monotone, namely

<span id="page-5-1"></span>**Lemma 7.** (*i*) *For all*  $t \in [0, T^*]$ *, we have an invariant quantity* 

$$
\int_V \phi(u(\cdot,t))d\mu = \int_V \phi(u_0)d\mu.
$$

(*ii*)  $J_\rho(\cdot, t)$  *is monotone with respect to t, in particular, if*  $0 \le t_1 < t_2 \le T^*$ , then

$$
J_{\rho}(u(\cdot,t_2)) \leq J_{\rho}(u(\cdot,t_1)).
$$

*Proof.* Since  $u(x, t)$  is a solution of [\(8\)](#page-2-2), we have by calculating

$$
\frac{d}{dt} \int_{V} \phi(u(\cdot, t)) d\mu = \int_{V} \phi'(u) u_{t} d\mu
$$
\n
$$
= \int_{V} \left( \Delta u - Q + \frac{\rho e^{u}}{\int_{V} e^{u} d\mu} \right) d\mu
$$
\n
$$
= 0.
$$

This immediately implies the assertion (*i*).

By the integration by parts,

<span id="page-5-2"></span>
$$
\frac{d}{dt}J_{\rho}(u(\cdot,t)) = \int_{V} \nabla u \nabla u_{t} d\mu + \int_{V} Q u_{t} d\mu - \frac{\rho}{\int_{V} e^{u} d\mu} \int_{V} e^{u} u_{t} d\mu
$$
\n
$$
= -\int_{V} \mathcal{M}(u) u_{t} d\mu
$$
\n
$$
= -\int_{V} \phi'(u) u_{t}^{2} d\mu \leq 0,
$$
\n(15)

since  $\phi'(s) > 0$  for all  $s \in \mathbb{R}$ . Here we denote  $u_t = \partial u / \partial t$ . This concludes the assertion (*ii*).

## 3. Long time existence

In this section, we prove the long time existence of the heat flow [\(8\)](#page-2-2). By Lemma [6,](#page-4-1) there exists some  $T^* > 0$  such that [\(8\)](#page-2-2) has a solution  $u : V \times [0, T^*] \to \mathbb{R}$ . Let

<span id="page-5-0"></span>
$$
T = \sup \{ T^* > 0 : u : V \times [0, T^*] \to \mathbb{R} \text{ solves (8)} \}.
$$
 (16)

Clearly, [\(8\)](#page-2-2) has a solution  $u: V \times [0, T) \rightarrow \mathbb{R}$ .

<span id="page-6-2"></span>Proposition 8. *Let T be defined as in [\(16\)](#page-5-0). Then there exists some constant C independent of T such that*

$$
||u(\cdot,t)||_{W^{1,2}(V)} \leq C, \quad \forall t \in [0,T).
$$

*Proof.* We divide the proof into several steps.

**Step 1.** *There exists some constant C independent of T such that for all*  $x \in V$  *and*  $t \in [0, T)$ *,* 

$$
u(x,t)\leq C.
$$

By [\(10\)](#page-2-6),  $\phi'(s) > 0$  for all  $s \in \mathbb{R}$  and there exists some constant  $a > 0$  such that  $\phi'(s) \ge a > 0$ for all  $s \in [0, +\infty)$ . There would hold  $\phi(s) \geq as$  for all  $s \in \mathbb{R}$ . Indeed, the mean value theorem implies

$$
\phi(s) - \phi(0) = \phi'(\xi)s,
$$

where  $\xi$  lies between 0 and *s*. Hence  $\phi(s) \geq as$  for all  $s \geq 0$  since  $\phi(0) > 0$ . Obviously  $\phi(s) \geq as$ for all  $s < 0$  since  $\phi(s) > 0$  for all  $s \in \mathbb{R}$ . This together with (*i*) of Lemma [7](#page-5-1) leads to

$$
u(x,t) \leq \frac{1}{a} \phi(u(x,t))
$$
  
\n
$$
\leq \frac{1}{a \min_{x \in V} \mu(x)} \int_{V} \phi(u(\cdot,t)) d\mu
$$
  
\n
$$
= \frac{1}{a \min_{x \in V} \mu(x)} \int_{V} \phi(u_0) d\mu
$$

for all  $x \in V$ . This finishes the first step.

**Step 2.** *There exists a constant C independent of T such that for any*  $t \in [0, T)$ *, one finds a subset*  $A_t \subset V$  *satisfying*  $||u(\cdot, t)||_{L^\infty(A_t)} \leq C$  *and*  $|A_t| \geq C^{-1}$ *.* 

For any  $\epsilon > 0$  and  $t \in [0, T)$ , we define a set

$$
V_{\epsilon,t} = \{x \in V : \phi(u(x,t)) < \epsilon\}.
$$

This together with (*i*) of Lemma [7](#page-5-1) and Step 1 leads to

<span id="page-6-0"></span>
$$
\int_{V} \phi(u_{0}) d\mu = \int_{V} \phi(u(\cdot, t)) d\mu
$$
\n
$$
= \int_{V_{\epsilon_{d}}} \phi(u(\cdot, t)) d\mu + \int_{V \backslash V_{\epsilon_{d}}} \phi(u(\cdot, t)) d\mu
$$
\n
$$
\leq \epsilon |V| + \phi(C) |V \backslash V_{\epsilon_{d}}|.
$$
\n(17)

Taking  $\epsilon = \epsilon_0 = \frac{1}{2|V|} \int_V \phi(u_0) d\mu$ , we conclude from [\(17\)](#page-6-0) that

<span id="page-6-1"></span>
$$
|V \setminus V_{\epsilon_0, t}| \ge \frac{1}{2\phi(C)} \int_V \phi(u_0) d\mu.
$$
 (18)

Set  $A_t = V \setminus V_{\epsilon_0,t}$ . For any  $x \in A_t$ , there holds  $\phi(u(x,t)) \ge \epsilon_0$ . Since  $\phi(s) \to 0$  as  $s \to -\infty$ , we find some real number *b* such that  $\phi(b) = \epsilon_0$ . It follows that  $u(x, t) \ge b$  for all  $x \in A_t$ . This together with Step 1 leads to

$$
\|u(\cdot,t)\|_{L^{\infty}(A_t)} \leq C
$$

If *C* is chosen larger but independent of *T*, then we have by [\(18\)](#page-6-1) that  $|A_t| \ge C^{-1}$ .

**Step 3.** *There exists a positive constant C independent of T such that for all t*  $\in$  [0, *T*)*, there holds*

$$
\int_V u^2(\cdot,t)d\mu \leq C \int_V |\nabla u(\cdot,t)|^2 d\mu + C.
$$

Recalling the definition of the first eigenvalue of the negative Laplacian, namely

$$
\lambda_1 = \inf_{v \in W^{1,2}(V), \int_V v d\mu = 0, v \neq 0} \frac{\int_V |\nabla v|^2 d\mu}{\int_V v^2 d\mu} > 0,
$$

we obtain for any  $v \in W^{1,2}(V)$ ,

<span id="page-7-0"></span>
$$
\int_{V} v^{2} d\mu = \int_{V} (v - \overline{v})^{2} d\mu + \int_{V} \overline{v}^{2} d\mu
$$
\n
$$
\leq \frac{1}{\lambda_{1}} \int_{V} |\nabla v|^{2} d\mu + \frac{1}{|V|} \left( \int_{V} v d\mu \right)^{2}, \qquad (19)
$$

where  $\overline{v} = \frac{1}{|V|} \int_V v d\mu$ . By Step 2, one calculates along the heat flow [\(8\)](#page-2-2),

<span id="page-7-1"></span>
$$
\frac{1}{|V|} \left( \int_{V} u(\cdot, t) d\mu \right)^{2} = \frac{1}{|V|} \left( \int_{A_{t}} u(\cdot, t) d\mu + \int_{V \setminus A_{t}} u(\cdot, t) d\mu \right)^{2}
$$
\n
$$
= \frac{1}{|V|} \left( \int_{A_{t}} u(\cdot, t) d\mu \right)^{2} + \frac{1}{|V|} \left( \int_{V \setminus A_{t}} u(\cdot, t) d\mu \right)^{2}
$$
\n
$$
+ \frac{2}{|V|} \int_{A_{t}} u(\cdot, t) d\mu \int_{V \setminus A_{t}} u(\cdot, t) d\mu
$$
\n
$$
\leq \frac{C^{2} |A_{t}|^{2}}{|V|} + \frac{1}{|V|} \left( \int_{V \setminus A_{t}} u(\cdot, t) d\mu \right)^{2}
$$
\n
$$
+ \frac{C^{2} |A_{t}|^{2}}{\epsilon |V|} + \frac{\epsilon}{|V|} \left( \int_{V \setminus A_{t}} u(\cdot, t) d\mu \right)^{2}, \qquad (20)
$$

where  $\epsilon$  is a positive constant to be determined later. Using the Hölder inequality, one has

$$
\left(\int_{V\setminus A_t} u(\cdot,t)d\mu\right)^2 \leq |V\setminus A_t|\int_V u^2(\cdot,t)d\mu.
$$

This together with [\(19\)](#page-7-0) and [\(20\)](#page-7-1) implies

<span id="page-7-2"></span>
$$
\int_{V} u^{2}(\cdot,t)d\mu \leq \frac{1}{\lambda_{1}}\int_{V} |\nabla u(\cdot,t)|^{2} d\mu + \frac{(1+\epsilon)|V \setminus A_{t}|}{|V|} \int_{V} u^{2}(\cdot,t)d\mu + C^{2}|V| \left(1 + \frac{1}{\epsilon}\right). \tag{21}
$$

By Step 2, we have  $|A_t| \ge C^{-1}$  with  $0 < C^{-1} < |V|$ . Taking  $\epsilon = (2C)^{-1}/(|V| - C^{-1})$  in [\(21\)](#page-7-2), one gets  $(1 + \epsilon)|V \setminus A_t|/|V| \le 1 - (2C|V|)^{-1}$ , and thus

$$
(2C|V|)^{-1} \int_V u^2(\cdot,t)d\mu \leq \frac{1}{\lambda_1} \int_V |\nabla u(\cdot,t)|^2 d\mu + C.
$$

This completes the proof of Step 3.

**Step 4.** *There exists a constant C independent of T such that*  $||u(\cdot,t)||_{W^{1,2}(V)} \leq C$  for all  $t \in [0, T)$ .

It follows from the Poincaré inequality and the Young inequality that

<span id="page-8-0"></span>
$$
\int_{V} |u(\cdot,t) - \overline{u}(t)| d\mu \le \epsilon \int_{V} |\nabla u(\cdot,t)|^2 d\mu + C,\tag{22}
$$

where  $\epsilon > 0$  is chosen later, *C* is a constant depending on  $\epsilon$ , but independent of *T*. For any fixed  $\rho \in \mathbb{R}$ , in view of [\(9\)](#page-2-5), we have by using [\(22\)](#page-8-0),

<span id="page-8-3"></span>
$$
J_{\rho}(u(\cdot,t)) = J_{\rho}(u(\cdot,t) - \overline{u}(t))
$$
  
\n
$$
= \frac{1}{2} \int_{V} |\nabla u(\cdot,t)|^{2} d\mu + \int_{V} Q(u(\cdot,t) - \overline{u}(t)) d\mu
$$
  
\n
$$
- \rho \log \left( \int_{V} e^{u(\cdot,t) - \overline{u}(t)} d\mu \right)
$$
  
\n
$$
\geq \left( \frac{1}{2} - \epsilon \right) \int_{V} |\nabla u(\cdot,t)|^{2} d\mu - C - \rho \log \int_{V} e^{u(\cdot,t) - \overline{u}(t)} d\mu.
$$
 (23)

As in Section [2,](#page-4-2) we write  $V = \{x_1, \dots, x_\ell\}$ . Let  $\theta_i = \mu(x_i)/|V|$  and  $s_i = u(x_i, t), 1 \le i \le \ell$ . Obviously  $0 < \theta_i < 1$  for any *i* and  $\sum_{i=1}^{\ell} \theta_i = 1$ . Since  $e^s$  is convex in  $s \in \mathbb{R}$ , we have

$$
\frac{1}{|V|} \int_{V} e^{u(\cdot,t)} d\mu = \sum_{i=1}^{\ell} \frac{\mu(x_i)}{|V|} e^{u(x_i,t)}
$$

$$
= \sum_{i=1}^{\ell} \theta_i e^{s_i}
$$

$$
\geq e^{\sum_{i=1}^{\ell} \theta_i s_i}
$$

$$
= e^{\overline{u}(t)},
$$

where  $\overline{u}(t) = \frac{1}{|V|} \int_V u(\cdot, t) d\mu$ . This immediately gives for  $t \in [0, T)$ ,

<span id="page-8-1"></span>
$$
\log \int_{V} e^{u(\cdot,t) - \overline{u}(t)} d\mu \ge \log |V|. \tag{24}
$$

According to the Trudinger-Moser embedding ([\[14\]](#page-13-20), Lemma 6), for any real number  $\beta > 0$ , there exists some constant *C* depending only on  $\beta$  and the Graph *G* such that

$$
\int_V e^{\beta \frac{(u(\cdot,t)-\overline{u}(t))^2}{\|\nabla u(\cdot,t)\|_2^2}} d\mu \leq C.
$$

As a consequence,

<span id="page-8-2"></span>
$$
\log \int_{V} e^{u(\cdot,t) - \overline{u}(t)} d\mu \le \log \int_{V} e^{\frac{(u(\cdot,t) - \overline{u}(t))^2}{4\epsilon \|\nabla u(\cdot,t)\|_2^2} + \epsilon \|\nabla u(\cdot,t)\|^2} d\mu
$$
  

$$
\le \epsilon \int_{V} |\nabla u(\cdot,t)|^2 d\mu + C
$$
 (25)

for some constant *C* depending on  $\epsilon$  and the graph *G*. Combining [\(24\)](#page-8-1) and [\(25\)](#page-8-2), we have for any fixed real number  $\rho$ ,

<span id="page-9-0"></span>
$$
\rho \log \int_{V} e^{u(\cdot,t) - \overline{u}(t)} d\mu \le |\rho| \epsilon \int_{V} |\nabla u(\cdot,t)|^2 d\mu + C. \tag{26}
$$

Inserting [\(26\)](#page-9-0) into [\(23\)](#page-8-3) and taking  $\epsilon = 1/(4 + 4|\rho|)$ , we conclude

<span id="page-9-2"></span>
$$
J_{\rho}(u(\cdot,t)) \ge \frac{1}{4} \int_{V} |\nabla u(\cdot,t)|^2 d\mu - C.
$$
 (27)

This together with (*ii*) of Lemma [7](#page-5-1) implies

$$
\int_V |\nabla u(\cdot,t)|^2 d\mu \leq C, \quad \forall t \in [0,T).
$$

In view of Step 3, we complete the finial step and the proof of the lemma.

Now we are in a position to prove the long time existence of the heat flow [\(8\)](#page-2-2).

<span id="page-9-1"></span>**Proposition 9.** *Let T be given as in [\(16\)](#page-5-0). Then*  $T = +\infty$ *.* 

*Proof.* Suppose *T* < +∞. By Proposition [8](#page-6-2) and the short time existence theorem of the ordinary differential equation ([\[36\]](#page-14-5), page 250),  $u(\cdot, t)$  can be uniquely extended to a time interval [0, *T*<sub>2</sub>] for some  $T_2 > T$ . This contradicts the definition of *T*. Therefore  $T = +\infty$ for some  $T_2 > T$ . This contradicts the definition of *T*. Therefore  $T = +\infty$ .

*Completion of the proof of (i) of Theorem [1](#page-2-3).* An immediate consequence of Proposition [9.](#page-9-1)  $\Box$ 

# 4. Convergence of the heat flow

In this section, we shall prove (*ii*) of Theorem [1.](#page-2-3) Since *V* is finite, all norms of the function space  $W^{1,2}(V)$  are equivalent. Then it follows from Proposition [8](#page-6-2) that there exists a constant C such that for all  $t \in [0, +\infty)$ ,

<span id="page-9-3"></span>
$$
||u(\cdot,t)||_{L^{\infty}(V)} \leq C. \tag{28}
$$

In view of  $(15)$  and  $(27)$ , we have

$$
\int_0^{+\infty} \int_V \phi'(u)u_t^2 d\mu dt \le J_\rho(u_0) + C.
$$

This together with the finiteness of *V* and  $\phi'(s) > 0$  for all  $s \in \mathbb{R}$  implies that there exists an increasing sequence  $t_n \to +\infty$  such that for all  $x \in V$ ,

<span id="page-9-4"></span>
$$
\phi'(u(x,t))u_t^2(x,t)|_{t=t_n} \to 0 \quad \text{as} \quad n \to \infty.
$$
 (29)

By [\(28\)](#page-9-3), since  $\phi'(s) > 0$  for all  $s \in \mathbb{R}$ , we obtain

<span id="page-9-5"></span>
$$
0 < \min_{s \in [-C, C]} \phi'(s) \le \phi'(u(x, t_n)) \le \max_{s \in [-C, C]} \phi'(s), \quad \forall n \ge 1. \tag{30}
$$

Combining [\(29\)](#page-9-4) and [\(30\)](#page-9-5), we conclude that for all  $x \in V$ ,

<span id="page-9-6"></span>
$$
\left. \frac{\partial}{\partial t} \phi(u(x,t)) \right|_{t=t_n} \to 0 \quad \text{as} \quad n \to \infty. \tag{31}
$$

Moreover, up to a subsequence, we can find some function  $u_{\infty} : V \to \mathbb{R}$  such that  $u(x, t_n)$ converges to  $u_{\infty}(x)$  uniformly in  $x \in V$  as  $n \to \infty$ . This together with [\(8\)](#page-2-2) and [\(31\)](#page-9-6) leads to

<span id="page-10-0"></span>
$$
\mathcal{M}(u_{\infty}) = \Delta u_{\infty} - Q + \frac{\rho e^{u_{\infty}}}{\int_{V} e^{u_{\infty}} d\mu} = 0 \quad \text{on} \quad V.
$$
 (32)

In conclusion, we found an increasing sequence  $(t_n) \to +\infty$  such that  $u(x, t_n) \to u_\infty(x)$  uniformly in *x* ∈ *V* as *n* → ∞, where  $u_{\infty}$  is a solution of the mean field equation [\(32\)](#page-10-0). Hereafter we further prove that along the heat flow,  $u(\cdot, t)$  converges to  $u_\infty$  as  $t \to +\infty$  uniformly on *V*. For this purpose, we need an estimate due to Lojasiewicz, namely Lemma [4.](#page-3-2) The power of Lemma [4](#page-3-2) is shown in the following finite dimensional Lojasiewicz-Simon inequality.

<span id="page-10-3"></span>**Proposition 10.** *Let*  $\sigma > 0$  *and*  $0 < \theta < 1/2$  *be given as in Lemma [4,](#page-3-2)*  $\mathcal{M}(u)$  *be defined as in* [\(12\)](#page-4-3)*, and l be the number of points of V. Along the heat flow [\(8\)](#page-2-2), if*  $||u(\cdot,t) - u_{\infty}||_{L^{\infty}(V)} < \sigma/\sqrt{\ell}$  *for some fixed t, then there exists some constant C independent of t such that*

$$
|J_{\rho}(u(\cdot,t))-J_{\rho}(u_{\infty})|^{1-\theta}\leq C||\mathcal{M}(u)(\cdot,t)||_{L^{2}(V)}.
$$

*Proof.* Assume  $||u(\cdot, t) - u_\infty||_{L^\infty(V)} < \sigma/\sqrt{\ell}$  for some fixed *t*. For the sake of clarity, we denote  **and Γ(<b>a**) =  $J_{\rho}(u_{\infty})$ . Clearly the function  $\Gamma : \mathbb{R}^{\ell} \to \mathbb{R}$  is analytic due to Lemma [5,](#page-4-4) and

$$
\|\mathbf{y}-\mathbf{a}\| = \sqrt{\sum_{i=1}^{\ell} (y_i - a_i)^2} \leq \sqrt{\ell} \max_{1 \leq i \leq \ell} |y_i - a_i| < \sigma.
$$

For any  $1 \le i \le \ell$ , we define a function  $e_i : V \to \mathbb{R}$  by

$$
e_i(x) = \begin{cases} 1, & \text{if } x = x_i \\ 0, & \text{if } x \neq x_i. \end{cases}
$$

Let  $e_i$  be a unit vector in  $\mathbb{R}^{\ell}$ , whose *i*-th component is 1 and the rest are 0. In view of [\(14\)](#page-5-3), one calculates the partial derivative of the analytic function  $\Gamma(y)$  as follows. For any  $1 \le i \le \ell$ ,

<span id="page-10-1"></span>
$$
\partial_{y^i} \Gamma(\mathbf{y}) = \lim_{h \to 0} \frac{1}{h} \left( \Gamma(\mathbf{y} + h \mathbf{e}_i) - \Gamma(\mathbf{y}) \right)
$$
  
\n
$$
= \lim_{h \to 0} \frac{1}{h} \left( J_\rho(u(x, t) + h e_i(x)) - J_\rho(u(x, t)) \right)
$$
  
\n
$$
= dJ_\rho(u(x, t)) (e_i(x))
$$
  
\n
$$
= \int_V \mathcal{M}(u)(x, t) e_i(x) d\mu.
$$
 (33)

This together with the fact  $\sum_{i=1}^{\ell} \int_{V} e_i^2 d\mu = \sum_{i=1}^{\ell} \mu(x_i) = |V|$  leads to

<span id="page-10-2"></span>
$$
\|\nabla \Gamma(\mathbf{y})\| = \sqrt{\sum_{i=1}^{\ell} (\partial_{y_i} \Gamma(y))^2}
$$
  
\n
$$
\leq \sqrt{\left(\int_V \mathcal{M}(u)^2 d\mu\right) \sum_{i=1}^{\ell} \int_V e_i^2 d\mu}
$$
  
\n
$$
= \sqrt{|V|} \|\mathcal{M}(u)(\cdot, t)\|_{L^2(V)}.
$$
\n(34)

Similar to [\(33\)](#page-10-1), we have by [\(32\)](#page-10-0) that for all  $1 \le i \le \ell$ ,

<span id="page-11-0"></span>
$$
\partial_{y_i} \Gamma(\mathbf{a}) = \int_V \mathcal{M}(u_{\infty}(x)) e_i(x) d\mu = 0.
$$
 (35)

In view of the definition of  $\Gamma$ , [\(34\)](#page-10-2) and [\(35\)](#page-11-0), we obtain by applying Lemma [4](#page-3-2) that

$$
\begin{array}{rcl}\n|J_{\rho}(u(\cdot,t))-J_{\rho}(u_{\infty})|^{1-\theta} & = & \|\Gamma(\mathbf{y})-\Gamma(\mathbf{a})|^{1-\theta} \\
& \leq & \|\nabla\Gamma(\mathbf{y})\| \\
& \leq & \sqrt{|V|}\|M(u)(\cdot,t)\|_{L^{2}(V)}.\n\end{array}
$$

This ends the proof of the proposition.  $\Box$ 

Finally we prove the uniform convergence of the heat flow [\(8\)](#page-2-2), namely

<span id="page-11-5"></span>Proposition 11. *Along the heat flow [\(8\)](#page-2-2), there holds*

<span id="page-11-1"></span>
$$
\lim_{t \to +\infty} \int_{V} |u(\cdot, t) - u_{\infty}|^2 d\mu = 0.
$$
 (36)

*Proof.* For the proof of this proposition, we modify an argument of Sun-Zhu ([\[34\]](#page-14-2), Section 5). Suppose that [\(36\)](#page-11-1) does not hold. Then there exists some constant  $\epsilon_0 > 0$  and an increasing sequence of numbers  $(t_n^*)$  such that  $t_n^* > t_n$  and

<span id="page-11-2"></span>
$$
\int_{V} |u(\cdot, t_n^*) - u_{\infty}|^2 d\mu \ge 2\epsilon_0,
$$
\n(37)

where  $(t_n)$  is given by [\(29\)](#page-9-4) and satisfies  $u(\cdot, t_n) \to u_\infty$  uniformly on *V*. Obviously

$$
\lim_{n\to\infty}\int_V|u(\cdot,t_n)-u_\infty|^2d\mu=0.
$$

Thus there exists  $n_1 \in \mathbb{N}$  such that if  $n \geq n_1$ , then

<span id="page-11-3"></span>
$$
\int_{V} |u(\cdot, t_n) - u_{\infty}|^2 d\mu < \epsilon_0. \tag{38}
$$

We *claim* that  $J_\rho(u(\cdot,t)) > J_\rho(u_\infty)$  for all  $t \in [0,+\infty)$ . Indeed, we have by (*ii*) of Lemma [7](#page-5-1) that  $J_\rho(u(\cdot,t))$  is decreasing with respect to *t*, and in particular  $J_\rho(u(\cdot,t)) \geq J_\rho(u_\infty)$  for all  $t \geq 0$ . Suppose there exists some  $\tilde{t} > 0$  such that  $J_{\rho}(u(\cdot, \tilde{t})) = J_{\rho}(u_{\infty})$ . Then  $J_{\rho}(u(\cdot, t)) \equiv J_{\rho}(u_{\infty})$  and thus *u*<sub>t</sub> ≡ 0 on *V* for all *t* ∈ [ $\tilde{t}$ , +∞). Hence *u*(*x*, *t*) ≡ *u*<sub>∞</sub>(*x*) for all *x* ∈ *V* and all *t* ∈ [ $\tilde{t}$ , +∞), which contradicts [\(37\)](#page-11-2). This confirms our claim  $J_\rho(u(\cdot,t)) > J_\rho(u_\infty)$  for all  $t \ge 0$ .

For any  $n \geq n_1$ , we define

$$
s_n = \inf \left\{ t > t_n : ||u(\cdot, t) - u_{\infty}||_{L^2(V)}^2 \ge 2\epsilon_0 \right\}.
$$

It follows from [\(37\)](#page-11-2) that  $s_n < +\infty$ , and that for all  $t \in [t_n, s_n)$ ,

<span id="page-11-4"></span>
$$
\int_{V} |u(\cdot, t) - u_{\infty}|^{2} d\mu < 2\epsilon_{0} = \int_{V} |u(\cdot, s_{n}) - u_{\infty}|^{2} d\mu.
$$
 (39)

For *t* ∈ [ $t_n$ ,  $s_n$ ), we calculate by [\(15\)](#page-5-2), Proposition [10,](#page-10-3) the fact  $u_t = (\phi(u))^{-1} \mathcal{M}(u)$ , and [\(28\)](#page-9-3) that

$$
-\frac{d}{dt}(J_{\rho}(u(\cdot,t))-J_{\rho}(u_{\infty}))^{\theta} = -\theta(J_{\rho}(u(\cdot,t))-J_{\rho}(u_{\infty}))^{\theta-1}\frac{d}{dt}J_{\rho}(u(\cdot,t))
$$
  

$$
= \theta(J_{\rho}(u(\cdot,t))-J_{\rho}(u_{\infty}))^{\theta-1}\int_{V} \mathcal{M}(u)u_{t}d\mu
$$
  

$$
\geq C\frac{\int_{V}(\phi'(u))^{-1}\mathcal{M}^{2}(u)d\mu}{\|\mathcal{M}(u)\|_{L^{2}(V)}}
$$
  

$$
\geq C\|u_{t}\|_{L^{2}(V)}.
$$

Hence

<span id="page-12-0"></span>
$$
\int_{t_n}^{s_n} ||u_t||_{L^2(V)} dt \le C(J_\rho(u(\cdot,t_n)) - J_\rho(u_\infty))^\theta.
$$
\n(40)

By the Hölder inequality,

<span id="page-12-1"></span>
$$
\frac{d}{dt} \left( \int_{V} |u(\cdot, t) - u_{\infty}|^{2} d\mu \right)^{1/2} = \frac{1}{\|u(\cdot, t) - u_{\infty}\|_{L^{2}(V)}} \int_{V} (u - u_{\infty}) u_{t} d\mu \le \left( \int_{V} u_{t}^{2} d\mu \right)^{1/2}.
$$
 (41)

Combining [\(40\)](#page-12-0) and [\(41\)](#page-12-1), we have

$$
\|u(\cdot,s_n)-u_\infty\|_{L^2(V)}-\|u(\cdot,t_n)-u_\infty\|_{L^2(V)}\leq C(J_\rho(u(\cdot,t_n))-J_\rho(u_\infty))^\theta.
$$

This together with [\(38\)](#page-11-3) and [\(39\)](#page-11-4) leads to

$$
\epsilon_0 \leq C(J_\rho(u(\cdot,t_n)) - J_\rho(u_\infty))^\theta,
$$

which is impossible if *n* is chosen sufficiently large, since  $J_\rho(u(\cdot, t_n)) \to J_\rho(u_\infty)$  as  $n \to \infty$ . This confirms (36) confirms [\(36\)](#page-11-1).

*Completion of the proof of (ii) of Theorem [1](#page-2-3).* Recalling  $V = \{x_1, \dots, x_\ell\}$ , one concludes from Proposition [11](#page-11-5) that

$$
\lim_{t \to +\infty} \sum_{i=1}^{\ell} \mu(x_i) |u(x_i, t) - u_{\infty}(x_i)|^2 = 0.
$$

Since for all  $j \in \{1, \dots, \ell\}$ , there holds

$$
|u(x_j, t) - u_{\infty}(x_j)| \leq \frac{1}{\min_{x \in V} \mu(x)} \sum_{i=1}^{\ell} \mu(x_i) |u(x_i, t) - u_{\infty}(x_i)|^2,
$$

one comes to a conclusion that *u*(*x*, *t*) converges to *u*<sub>∞</sub>(*x*) uniformly in *x* ∈ *V* as *t* → +∞. By (32), *u*<sub>∞</sub> is a solution of (7). Thus the proof of Theorem 1 is completely finished. □ [\(32\)](#page-10-0),  $u_{\infty}$  is a solution of [\(7\)](#page-2-0). Thus the proof of Theorem [1](#page-2-3) is completely finished.
