Multiplicative deconvolution estimator based on a ridge approach

Abstract

We study the non-parametric estimation of an unknown density f with support on \mathbb{R}_+ based on an i.i.d. sample with multiplicative measurement errors. The proposed fully-data driven procedure consists of the estimation of the Mellin transform of the density *f* and a regularisation of the inverse of the Mellin transform by a ridge approach. The upcoming bias-variance trade-off is dealt with by a data-driven choice of the ridge parameter. In order to discuss the bias term, we consider the *Mellin-Sobolev spaces* which characterise the regularity of the unknown density *f* through the decay of its Mellin transform. Additionally, we show minimax-optimality over *Mellin-Sobolev spaces* of the ridge density estimator.

1. Introduction

In this paper we are interested in estimating the unknown density $f : \mathbb{R}_+ \to \mathbb{R}_+$ of a positive random variable X given independent and identically distributed (i.i.d.) copies of $Y = XU$, where X and U are independent of each other and *U* has a known density $g : \mathbb{R}_+ \to \mathbb{R}_+$. In this setting the density $f_Y : \mathbb{R}_+ \to \mathbb{R}_+$ of *Y* is given by

$$
f_Y(y) = (f * g)(y) := \int_{\mathbb{R}_+} f(x)g(y/x)x^{-1}dx \quad \forall y \in \mathbb{R}_+
$$

Here $*$ denotes multiplicative convolution. The estimation of *f* using an i.i.d. sample Y_1, \ldots, Y_n from f_Y is thus an inverse problem called multiplicative deconvolution.

This particular model was studied by [\[6\]](#page-14-0). Inspired by the work [\[4\]](#page-14-1), the authors of [\[6\]](#page-14-0) introduced an estimator based on the estimation of the Mellin transform of the unknown density *f* and a spectral cut-off regularisation of the inverse of the Mellin transform. In [\[4\]](#page-14-1) a pointwise kernel density estimator was proposed and investigated, while the authors of [\[6\]](#page-14-0) studied the global risk of the density estimation. For the model of multiplicative measurement, the multivariate case of global density estimaton, respectively the univariate case of global survival function estimation, was considered by [\[5\]](#page-14-2) , respectively [\[7\]](#page-14-3), based on a spectral cut-off approach.

In this work, we will borrow the ridge approach from the additive deconvolution literature, for instance used by [\[12\]](#page-14-4) and [\[14\]](#page-14-5), to build a new density estimator and compare it with the spectral cut-off estimator proposed by [\[6\]](#page-14-0). The contribution of this work to the existing literature is the inclusion of the ridge approach and the comparison to the spectral cut-off approach. We discuss in which situations the corresponding estimators are comparable, respectively when the ridge approach is favourable. Furthermore, the ridge approach can be used for furture works considering oscillatory error densities or unknown error densities, compare [\[12\]](#page-14-4) and [\[14\]](#page-14-5).

1.1. Related works

The model of multiplicative measurement errors was motivated in the work of [\[4\]](#page-14-1) as a generalisation of several models, for instance the multiplicative censoring model or the stochastic volatility model.

[\[17\]](#page-14-6) and [\[18\]](#page-14-7) introduce and analyse intensively *multiplicative censoring*, which corresponds to the particular multiplicative deconvolution problem with multiplicative error *^U* uniformly distributed on [0, 1]. This model is often applied in survival analysis as explained and motivated in [\[10\]](#page-14-8). The estimation of the cumulative distribution function of *X* is discussed in [\[18\]](#page-14-7) and [\[2\]](#page-14-9). Series expansion methods are studied in [\[1\]](#page-13-0) treating the model as an inverse problem. The density estimation in a multiplicative censoring model is considered in [\[8\]](#page-14-10) using a kernel estimator and a convolution power kernel estimator. Assuming an uniform error distribution on an interval $[1-\alpha, 1+\alpha]$ for $\alpha \in (0, 1)$, [\[9\]](#page-14-11) analyse a projection density estimator with respect to the Laguerre basis. [\[3\]](#page-14-12) investigate a beta-distributed error *U*. In the work of [\[4\]](#page-14-1), the authors used the Mellin transform to construct a kernel estimator for the pointwise density estimation. Moreover, they point out that the following widely used naive approach is a special case of their estimation strategy. Transforming the data by applying the logarithm to the model $Y = XU$ writes as $log(Y) = log(X) + log(U)$. In other words, multiplicative convolution becomes convolution for the log-transformed data. As a consequence, the density of log(*X*) is eventually estimated employing usual strategies for non-parametric deconvolution problems (see for example [\[14\]](#page-14-5)) and then transformed back to an estimator of f. However, it is difficult to interpret regularity conditions on the density of $log(X)$. Furthermore, the analysis of the global risk of an estimator using this naive approach is challenging as [\[9\]](#page-14-11) pointed out.

1.2. Organisation

The paper is organised as follows. In Section [1](#page-0-0) we recapitulate the definition of the Mellin transform and collect its frequently used properties. To be able to compare our estimator with the spectral cut-off estimator proposed by [\[6\]](#page-14-0), we will revisit its construction and state the necessary assumption for the estimator to be well-defined and present the ridge density estimator. In Section [2](#page-3-0) we will show that the ridge density estimator is minimax-optimal over the Mellin-Sobolev spaces, by stating an upper bound and using the lower bound result given in [\[5\]](#page-14-2). A data-driven procedure based on a Goldenshluger-Lepski method is described and analysed in Section [3.](#page-5-0) Finally, results of a simulation study are reported in section [4](#page-6-0) which visualize the reasonable finite sample performance of our estimators. The proofs of Section [2](#page-3-0) and Section [3](#page-5-0) are postponed to the Appendix.

*1.3. The spectral cut-o*ff *and ridge estimator*

We define for any weight function $\omega : \mathbb{R} \to \mathbb{R}_+$ the corresponding weighted norm by $||h||_{\omega}^2 := \int_0^{\infty} |h(x)|^2 \omega(x) dx$ for a measurable, complex-valued function *h*. Denote by $\mathbb{L}^2(\mathbb{R}_+, \omega)$ the set of all measurable, contain- (\mathbb{R}_+, ω) the set of all measurable, complex-valued functions
 $\omega(x)dx$ for $h, h \in \mathbb{R}^2(\mathbb{R}, \omega)$ the corresponding weighted with finite $\|\cdot\|_{\omega}$ -norm and by $\langle h_1, h_2 \rangle_{\omega} := \int_0^{\infty} h_1(x) h_2(x) \omega(x) dx$ for $h_1, h_2 \in \mathbb{L}^2(\mathbb{R}_+, \omega)$ the corresponding weighted scalar product. Similarly, define $\mathbb{L}^2(\mathbb{R}) := \{h : \mathbb{R} \to \mathbb{C} \text{ measurable } : ||h||^2_{\mathbb{R}} := \int_{-\infty}^{\infty} h(t) \overline{h(t)} dt < \infty\}$ and $\mathbb{L}^1(\Omega, \omega) :=$ $\{h : \Omega \to \mathbb{C} : ||h||_{\mathbb{L}^1(\Omega,\omega)} := \int_{\Omega} |h(x)|\omega(x)dx < \infty\}$. In the introduction we already mentioned that the density *f_{<i>Y*} of *Y*, can be written as the multiplicative convolution of the densities *f* and *g*. We will n *Y*¹ can be written as the multiplicative convolution of the densities *f* and *g*. We will now define this convolution in a more general setting. Let *c* ∈ ℝ. For two functions $h_1, h_2 \text{ ∈ } \mathbb{L}^1(\mathbb{R}_+, x^{c-1})$, where we use the notation x^{c-1} for the weight function $x \mapsto x^{c-1}$ we define the multiplicative convolution $h_1 * h_2$ of h weight function $x \mapsto x^{c-1}$, we define the multiplicative convolution $h_1 * h_2$ of h_1 and h_2 by

$$
(h_1 * h_2)(y) := \int_0^\infty h_1(y/x)h_2(x)x^{-1}dx, \quad y \in \mathbb{R}_+.

In fact, one can show that the function $h_1 * h_2$ is well-defined, $h_1 * h_2 = h_2 * h_1$ and $h_1 * h_2 \in \mathbb{L}^1(\mathbb{R}, x^{c-1})$, compare [\[5\]](#page-14-2). It is worth pointing out, that the definition of the multiplicative convolution in equation [1](#page-1-0) is independent of the model parameter *c* ∈ R. We also know for densities h_1, h_2 that $h_1, h_2 \in \mathbb{L}^1(\mathbb{R}_+, x^0)$. If additionally $h_1 \in \mathbb{L}^2(\mathbb{R}_+, x^{2c-1})$ then $h_1 * h_2 \in \mathbb{L}^2(\mathbb{R}_+, x^{2c-1})$ $h_1 * h_2 \in \mathbb{L}^2(\mathbb{R}_+, x^{2c-1}).$

Mellin transform. We will now define the Mellin transform for $\mathbb{L}^1(\mathbb{R}_+, x^{c-1})$ functions and present the convolution theorem. [Appendix A.](#page-8-0) Proof sketches of these properties can be found in [\[6\]](#page-14-0), respectively [\[5\]](#page-14-2). Let $h_1 \in \mathbb{L}^1(\mathbb{R}, x^{c-1})$. $$
\mathcal{M}_c[h_1](t) := \int_0^\infty x^{c-1+it} h_1(x) dx, \quad t \in \mathbb{R}.

The key property of the Mellin transform, which makes it so appealing for the use of multiplicative deconvolution, is the so-called convolution theorem, that is, for $h_1, h_2 \in \mathbb{L}^1(\mathbb{R}_+, x^{c-1})$,

$$
\mathcal{M}_c[h_1 * h_2](t) = \mathcal{M}_c[h_1](t)\mathcal{M}_c[h_2](t), \quad t \in \mathbb{R}.
$$

Let us now revisit the definition of the spectral cut-off estimator.

Spectral-cut off estimator. The family of spectral cut-off estimator $(f_k)_{k \in \mathbb{R}_+}$ proposed by [\[6\]](#page-14-0), respectively [\[5\]](#page-14-2), is based on the estimation of the Mellin transform of *f^Y* and a spectral cut-off regularisation of the inverse Mellin transform. Given the sample $(Y_j)_{j\in[n]}$, where $[a] := [1, a] \cap \mathbb{N}$ for any $a \in \mathbb{N}$, an unbiased estimator of $\mathcal{M}_c[f_Y](t)$, $t \in \mathbb{R}$, is given by the empirical Mellin transform

$$
\widehat{\mathcal{M}}_c(t) := n^{-1} \sum_{j \in [\![n]\!]} Y_j^{c-1+it}, \quad t \in \mathbb{R}
$$

if $\mathbb{E}_{f_Y}(Y_1^{c-1}) < \infty$ for *c* ∈ R. Exploiting the convolution theorem, eq. [\(3\)](#page-2-0), under the assumption that $M_c[g](t) \neq 0$ we can define the unbiased estimator $\widehat{M}_c(t)/M_c[g](t)$ of $M_c[f](t)$ for $t \in \mathbb{R}$. To construct an estimator of the unknown density *f*, the authors of [\[6\]](#page-14-0) used a spectral-cut off approach. That is, for $k \in \mathbb{R}_+$ we assume that $1_{[-k,k]} \mathcal{M}_c[g]^{-1} \in$ $\mathbb{L}^2(\mathbb{R})$, then we can ensure that $\mathbb{1}_{[-k,k]} \widehat{\mathcal{M}}_c/\mathcal{M}_c[g] \in \mathbb{L}^1(\mathbb{R}) \cap \mathbb{L}^2(\mathbb{R})$ since $|\widehat{\mathcal{M}}_c(t)| \leq \widehat{\mathcal{M}}_c(0) < \infty$ almost surely. Now, the spectral out off density estimator \widehat{f} c the spectral cut-off density estimator \widetilde{f}_k can be defined by

$$
\widetilde{f}_k(x) := \mathcal{M}_c^{-1} [\mathbb{1}_{[-k,k]} \widehat{\mathcal{M}}_c / \mathcal{M}_c[g]](x) = \frac{1}{2\pi} \int_{-k}^k x^{-c-it} \frac{\widehat{\mathcal{M}}_c(t)}{\mathcal{M}_c[g](t)} dt, \quad x \in \mathbb{R}_+.
$$
\n(4)

Here we used two minor assumptions on the error density *g*, that is,

$$
\forall t \in \mathbb{R} : \mathcal{M}_c[g](t) \neq 0 \quad \text{and} \quad \forall k \in \mathbb{R}_+ : \mathbb{1}_{[-k,k]} \mathcal{M}_c[g]^{-1} \in \mathbb{L}^2(\mathbb{R}). \tag{[G0]}
$$

This assumption implies that the Mellin transform of *g* does not approach zero too fast. Although this assumption is fulfilled for a large class of error densities, we will now show that one can define an estimator for an even weaker assumption on the error density. An intense study of this estimator, including the minimax optimality and data-driven choice of the parameter $k \in \mathbb{R}_+$, can be found in [\[6\]](#page-14-0).

Ridge estimator. Inspired by the work of [\[14\]](#page-14-5) and [\[12\]](#page-14-4), let $r, \xi \ge 0$ such that $t \mapsto \mathcal{M}_c[g](t)^{r+1}(1+|t|)^{-\xi(r+2)} \in \mathbb{L}^d(\mathbb{R}) \cap \mathbb{L}^d(\mathbb{R}) \cap \mathbb{L}^d(\mathbb{R})$. Then for any $k \in \mathbb{R}$, we define the function \mathbb $\mathbb{L}^1(\mathbb{R}) \cap \mathbb{L}^2(\mathbb{R})$. Then for any $k \in \mathbb{R}_+$ we define the function $R_{k,\xi,r} \in \mathbb{L}^1(\mathbb{R}) \cap \mathbb{L}^2(\mathbb{R})$ by

$$
\mathsf{R}_{k,\xi,r}(t) := \frac{\mathcal{M}_c[g](-t)|\mathcal{M}_c[g](t)|^r}{\max(|\mathcal{M}_c[g](t)|, k^{-1}(1+|t|)^{\xi})^{r+2}}, \quad t \in \mathbb{R},
$$

and the set $G_k := \{t \in \mathbb{R} : k^{-1}(1+|t|)^{\xi} > |\mathcal{M}_c[g](t)|\}$. Now for all $t \in G_n^c$ holds $R_{k,r}(t) = \mathcal{M}_c[g](t)^{-1}$. We define next the *ridge density estimator* $\widehat{f}_{k,r}$ by $\widehat{f}_{k,r} := \mathcal{M}_c^{-1}[\widehat{\mathcal{M}}_c \mathbb{R}_{k,r}]$. In fact, it can be written explicitly for $x \in \mathbb{R}_+$ as

$$
\widehat{f}_{k,\xi,r}(x) = \frac{1}{2\pi} \int_{-\infty}^{\infty} x^{-c-it} \widehat{\mathcal{M}}_c(t) \mathbf{R}_{k,\xi,r}(t) dt = \frac{1}{2\pi} \int_{G_k^c} x^{-c-it} \frac{\widehat{\mathcal{M}}_c(t)}{\mathcal{M}_c[g](t)} dt + \frac{1}{2\pi} \int_{G_k} x^{-c-it} \widehat{\mathcal{M}}_c(t) \mathbf{R}_{k,\xi,r}(t) dt.
$$

By the construction of G_k the quotient $\widehat{M}_c(t)/M_c[g](t)$ in the integrand in eq. [\(5\)](#page-2-1) is well-defined even without assumption [G0].

2. Minimax theory

In this section, we will see that an even milder assumption on the error density *g* than [G1] is sufficient to ensure that the presented ridge estimator is consistent. We finish this Section [2,](#page-3-0) by showing that the estimator is minimax optimal over the Mellin-Sobolev ellipsoids. We denote by $\mathbb{E}_{f_Y}^n$ the expectation corresponding to the distribution of $(Y_j)_{j \in \llbracket n \rrbracket}$. Respectively we define $\mathbb{E}_{f_Y} := \mathbb{E}_{f_Y}^1$ and \mathbb{E}_g , \mathbb{E}_f .

2.1. General consistency

Although the sequence $(G_k)_{k \in \mathbb{N}}$ is obviously nested, that is $G_{k+1} \subseteq G_k$ for all $k \in \mathbb{N}$, we want to stress out that the squared bias, $||f - \mathbb{E}_{f}^{n}(\widehat{f}_{k,\xi,r})||_{x^{2c-1}}^{2}$ of $\widehat{f}_{k,\xi,r}$, defined in eq. [\(5\)](#page-2-1), might not tend to zero for k going to infinity. For instance, one may consider the case where $M_c[g]$ vanishes on an open, nonempty set $A \subset \mathbb{R}$ and $M_c[f]$ does not vanish on *A*. A more sophisticated discussion about identifiability and consistency in the context of additive deconvolution problems can be found in the work of [\[14\]](#page-14-5). The discussion there can be directly transfered to the case of multiplicative deconvolution problems. Based on the discussion presented in [\[14\]](#page-14-5), we will give a minimal assumption to ensure that we can define a consistent estimator using the ridge approach. We will from now on assume, that the Mellin transform of *g* is almost nonzero everywhere, that is,

$$
\lambda({t \in \mathbb{R} : \mathcal{M}_c[g](t) = 0}) = 0. \tag{[G-1]}
$$

Under the asumption [G-1] we can use the dominated convergence theorem to show that the bias $||f - \mathbb{E}_f^n(\widehat{f}_{k,\xi,r})||_{\chi_{2c-1}}^2$
vanishes for *k* going to infinity. Eurthor it is worth streaming out that for $k \in \mathbb{N}$ vanishes for *k* going to infinity. Further, it is worth stressing out that for *k* ∈ N and *t* ∈ R we have $R_{k+1,\xi,r}(t) \ge R_{k,\xi,r}(t)$.

$$
\mathbb{E}_{f_Y}^n(||f - \widehat{f}_{k,\xi,r}||_{X^{2c-1}}^2) \le \frac{1}{2\pi} ||\mathbb{1}_{G_k} \mathcal{M}_c[f]||_{\mathbb{R}}^2 + \frac{\sigma_c}{2\pi n} ||R_{k,\xi,r}||_{\mathbb{R}}^2
$$

where $G_k := \{t \in \mathbb{R} : k^{-1}(1 + |t|)^{\xi} > |\mathcal{M}_c[g](t)|\}$ *and* $\widehat{f}_{k,\xi,r}$ *is defined in equation* [\(5\)](#page-2-1)*. If additionally* $\mathbb{G}-1\}$ *holds and* (k) *sy satisfies* $k \to \infty$ *and* $n^{-1} \mathbb{R}$, $\ldots \mathbb{R} \to 0$ for *If additionally* [G-1] *holds and* $(k_n)_{n\in\mathbb{N}}$ *satisfies* $k_n \to \infty$ *and* $n^{-1} ||R_{k_n,\xi,r}||^2_{\mathbb{R}} \to 0$ for $n \to \infty$ then

$$
\mathbb{E}_{f_Y}^n(||\widehat{f}_{k_n,\xi,r} - f||_{x^{2c-1}}^2) \to 0
$$

for $n \to \infty$.

Although the assumptions on ξ , k_n , $r \ge 0$ in Proposition [1](#page-3-1) seem to be rather technical, we will see that they are fulfilled when considering more precise classes of error densities, so-called *smooth error densities*. Before we define this family of error densities let us shorty comment on the consistency of the presented estimator.

Remark 1 (Strong consistency). In Proposition [1](#page-3-1) we have seen that we can determine a set of assumptions which ensures by application of the Markov inequality, that $\|\widehat{f}_{k_n,\xi,r}-f\|_{x^{2c-1}}^2 \to 0$ in probability. Here, we needed the additional assumption that $f \in L^2(\mathbb{R}, x^{2c-1})$ and $\sigma_c = \mathbb{E}_{f_f}(Y_1^{2(c-1)})$

holds. Further, the Mellin transform developed in $c = 1$ is well-defined for any d holds. Further, the Mellin transform developed in $c = 1$ is well-defined for any density f. In the book of [\[14\]](#page-14-5) they proposed an estimator \widehat{f}_V of the density $f_V : \mathbb{R} \to \mathbb{R}$ of a real random variable *V* given i.i.d. copies of $Z = V + \varepsilon$ where *V* and ε are stochastically independent. They were able to show that their estimator \widehat{f} is strongly consistent in the L¹(ℝ)-sense, that is, $\|\widehat{f}_V - f_V\|_{\mathbb{L}^1(\mathbb{R})} \to 0$ almost surely. Given the log transformed data, $\log(Y) = \log(X) + \log(\varepsilon)$, we can use the estimator \hat{f}_V for $V = \log(X)$ and deduce the estimator $\hat{f}_X(x) := \hat{f}_V(\log(x))x^{-1}$ for any $x \in \mathbb{R}_+$. Then $\|\hat{f}_V - f\|_{L^1(\mathbb{R})} = \hat{f}_V(\log(x))x^{-1}$ for any $x \in \mathbb{R}_+$. Then $\|\widehat{f}_X - f\|_{\mathbb{L}^1(\mathbb{R}_+,x^0)} = \|\widehat{f}_V - f_V\|_{\mathbb{L}^1(\mathbb{R})}$, implying that the estimator \widehat{f}_X is strongly consistent in the $\mathbb{L}^1(\mathbb{R}_+,x^0)$. Although it might be terming generalise this result for the \math it might be tempting generalise this result for the $\mathbb{L}^1(\mathbb{R}_+, x^{c-1})$ -distance for any *c* ∈ ℝ, it would need an additional moment assumption on *f* which contradicts the idea of considering the most general case. moment assumption on *f* which contradicts the idea of considering the most general case.

2.2. Noise assumption

Up to now, we have only assumed that the Mellin transform of the error density *g* does not vanish almost everywhere, i.e. [G-1]. To develop the minimax theory for the estimator $\hat{f}_{k,\xi,r}$ we will specify the class of considered error density *g* through an assumption on the decay of its corresponding Mellin transform M*c*[*g*]. This assumption will allow us to determine the growth of the variance term more precisely. In the context of additive deconvolution problems, compare [\[11\]](#page-14-13), densities whose Fourier transform decay polynomially are called *smooth error densities*. To stay in this way of speaking we say that an error density *g* is a *smooth error density* if there exists $c_g, C_g, \gamma \in \mathbb{R}_+$ such that

$$

This assumption on the error density was also considered in the works of [\[4\]](#page-14-1), [\[6\]](#page-14-0) and [\[5\]](#page-14-2). We focus on to the case where $\xi = 0$, and use the abreviation $f_k := f_{k,0,r}$, respectively $R_k := R_{k,0,r}$. Then under the asummption of Proposition 1 and assumption IG11 we can show that for each $r > 0 \vee (x^{-1} - 1)$ there exists a constant $C > 0$ su [1](#page-3-1) and assumption [G1] we can show that for each $r > 0 \vee (\gamma^{-1} - 1)$ there exists a constant $C_{g,r} > 0$ such that r^{-1} which had to the following constant values and some begins a properties. By Harally and the following $n^{-1} \|\mathbf{R}_k\|_{\mathbb{R}}^2 \leq C_{g,r} k^{2+\gamma-1} n^{-1}$, which leads to the following corollary whose proof can be found in [Appendix B.](#page-10-0) Here $a \vee b := \max(a, b)$ for $a, b \in \mathbb{R}$.

Corollary [1](#page-3-1). Let the assumptions of Proposition 1 and [G1] be fulfilled. Then for $r > 0 \vee (\gamma^{-1} - 1)$,

\mathbb{E}_{f_Y}^n(\|f-\widehat{f_k}\|_{x^{2c-1}}^2) \leq \frac{1}{2\pi} \|\mathbb{1}_{G_k} \mathcal{M}_c[f]\|_{\mathbb{R}}^2 + C_{g,r} \frac{\sigma_c k^{2+\gamma^{-1}}}{n}.
$$

If one chooses $(k_n)_{n\in\mathbb{N}}$ such that $k_n^{2+\gamma-1}n^{-1}\to 0$ and $k_n\to\infty$ then $\mathbb{E}_{f_Y}^n(\|f-\widehat{f}_{k_n}\|_{x^{2c-1}}^2)\to 0$ for $n\to\infty$.

Considering the bound of the variance term, a choice of $(k_n)_{n \in \mathbb{N}}$ increasing slowly in *n*, would imply a faster decay of the variance term. On the other hand, the opposite effect on the bias term can be observed. In fact, to balance both terms, an assumption on the decay of the Mellin transform of the unknown density *f* is needed. In the non-parametric Statistics and in the inverse problem community this is usually done by considering regularity spaces.

2.3. The Mellin-Sobolev space

We will now introduce the so-called *Mellin-Sobolev* spaces, which are, for instance, considered by [\[6\]](#page-14-0) for the case $c = 1$ and [\[5\]](#page-14-2) for the multivariate case. In the work of [\[6\]](#page-14-0) their connection to regularity properties, in terms of analytical properties, and their connection to the Fourier-Sobolev spaces are intensely studied. For $s, L \in \mathbb{R}_+$ and *c* ∈ R we define the *Mellin-Sobolev spaces* by

$$
\mathbb{W}_c^s(\mathbb{R}_+):=\{f\in \mathbb{L}^2(\mathbb{R}_+,x^{2c-1}):|f|_{s,c}^2:=||(1+t^2)^{s/2}\mathcal{M}_c[f]||_{\mathbb{R}}^2\leq \infty\}
$$

and their corresponding ellipsoids by $\mathbb{W}_{c}^{s}(L) := \{f \in \mathbb{W}_{c}^{s}(\mathbb{R}_{+}) : |f|_{s,c}^{2} \le L\}$. Then for $f \in \mathbb{W}_{c}^{s}(L)$ and under assumption \mathbb{R} . [G1] we can show that $||\mathbb{1}_{G_k} \mathcal{M}_c[f]||^2_2 \leq C(g, L, s)k^{-2s/\gamma}$. Since *f* is a density and to control the variance term, it is natural to consider the following subset of *W_s*(*I*). natural to consider the following subset of $\mathbb{W}_c^s(L)$,

$$
\mathbb{D}_{c}^{s}(L) := \{ f \in \mathbb{W}_{c}^{s}(L) : f \text{ is a density }, \mathbb{E}_{f}(X_{1}^{2(c-1)}) \leq L \}.
$$

Then we can state the following theorem whose proof is postponed to [Appendix B.](#page-10-0)

Theorem 1 (Upper bound over $\mathbb{D}_{c}^{s}(L)$). Let $c \in \mathbb{R}$, $s, L \in \mathbb{R}_{+}$ and $\mathbb{E}_{g}(U_{1}^{2(c-1)}, \ldots, U_{n}) \leq c \leq 1$ Then the choice $k := \frac{n^{s}}{2^{s+2}+1}$ leads to $\binom{2(c-1)}{1} < \infty$. Let further [**G1**] be fulfilled and $r > 0 \vee (\gamma^{-1} - 1)$ *. Then the choice* $k_o := n^{\gamma/(2s+2\gamma+1)}$ *leads to*

$$
\sup_{f\in\mathbb{D}_c^s(L)}\mathbb{E}_{f_Y}^n(\|f-\widehat{f}_{k_o}\|_{x^{2c-1}}^2)\leq C_{g,L,r}n^{-2s/(2s+2\gamma+1)}.
$$

A similar result was presented by the authors [\[6\]](#page-14-0) and [\[5\]](#page-14-2) showing that for the spectral cut-off estimator f_{k_o} the choice $k_o = n^{1/(2s+2\gamma+1)}$ leads to the same rate of $n^{-2s/(2s+\gamma+1)}$ uniformly over the classes $\mathbb{D}_c^s(L)$. For the case $c = 1$ the authors of [\[6\]](#page-14-0) presented a lower bound result, showing that in many cases the rate given in Theorem [1](#page-4-0) is the minimax rate for the density estimation *f* given the i.i.d. sample $(Y_i)_{i \in [n]}$. For the multivariate case, the author in [\[5\]](#page-14-2) has generalised the proof for all $c > 0$. The following Theorem follows as a special case of the lower bound presented in [\[5\]](#page-14-2) for the dimension $d = 1$ and its proof is thus omitted.

Theorem 2 (Lower bound over $\mathbb{D}_{c}^{s}(L)$). *Let* $s, \gamma \in \mathbb{N}$, $c > 0$ *and assume that* [**G1**] *holds.* Additionally, assume that $g(x) = 0$ for $x > 1$ and that there exists constants c, C such that $g(x) = 0$ *for* $x > 1$ *and that there exists constants* c_g , C_g *such that*

$$
c_g(1+t^2)^{-\gamma/2} \leq |\mathcal{M}_{\bar{c}}[g](t)| \leq C_g(1+t^2)^{-\gamma/2}, \quad t \in \mathbb{R},
$$

where $\widetilde{c} = 1/2$ *for* $c > 1/2$ *and* $\widetilde{c} = 0$ *for* $c \in (0, 1/2]$ *.*

Then there exist constants $C_{g,c}, L_{s,g,c} > 0$ such that for all $L \ge L_{s,g,c}, n \in \mathbb{N}$ and for any estimator \widehat{f} of f based on an *i.i.d.* sample $(Y_i)_{i \in \llbracket n \rrbracket}$,

$$
\sup_{f \in \mathbb{D}_c^s(L)} \mathbb{E}_{f_Y}^n(||\widehat{f} - f||_{x^{2c-1}}^2) \ge C_{g,c} n^{-2s/(2s+2\gamma+1)}
$$

We want to emphasize that the additional assumption on the error densities are for technical reasons. To ensure that $\mathcal{M}_{\overline{c}}[g]$ is well-defined, we need to addtionally assume that $\mathbb{E}_g(U_1^{-1/2}) < \infty$ for the case of *c* > 1/2. If *c* ∈ (0, 1/2], then $\mathbb{E}((U_1^{-1}) < \infty$ follows from $\mathbb{E}((U_1^{2c-2})$, compare Proposition then $\mathbb{E}_g(U_1^{-1}) < \infty$ follows from $\mathbb{E}_g(U_1^{2c-2})$, compare Proposition [1.](#page-3-1)

In the work of [\[6\]](#page-14-0) the authors showed that for the case of $c = 1$ the spectral cut-off estimator \widetilde{f}_k , defined in eq. [\(4\)](#page-2-2) is minimax optimal for some examples of error densities. In fact, they stressed out that for Beta-distributed *U*1, considered for instance by [\[3\]](#page-14-12), all assumption on *g* are fulfilled.

3. Data-driven method

In Section [2](#page-3-0) we determined a choice of the parameter $\xi, k, r \ge 0$ such that the resulting ridge estimator $f_{k,\xi,r}$ is
sistent, see Corollary 1. Setting $\xi = 0$ we additionally found a choice of the parameter $k \in \mathbb{R}$, consistent, see Corollary [1.](#page-4-1) Setting $\xi = 0$ we additionally found a choice of the parameter $k \in \mathbb{R}_+$ which makes the estimator minimax optimal over the Mellin-Sobolev ellipsoids $\mathbb{D}_{c}^{s}(L)$, compare Theorem [1.](#page-4-0) We want to emphasize that the latter choice of $k \in \mathbb{R}_+$ might not be explicitly dependent on the exact unknown density f but is still dependent on its regularity parameter $s \in \mathbb{R}_+$ which again is unknown.

We will now present a data-driven version of the estimator \widehat{f}_k , only dependent on the sample $(Y_j)_{j\in[\![n]\!]}$. For the datadriven choice of $k \in \mathbb{R}_+$ we will use a version of the Goldenshluger-Lepski method. That is, we will define the random functions $\widehat{A}, \widehat{V} : \mathbb{R}_+ \to \mathbb{R}_+$ for $k \in \mathbb{R}_+$ by

$$
\widehat{A}(k) := \sup_{k' \in \mathcal{K}_n} (\|\widehat{f}_{k'} - \widehat{f}_{k' \wedge k}\|_{x^{2c-1}}^2 - \chi_1 \widehat{V}(k))_+ \text{ and } \widehat{V}(k) := 2\widehat{\sigma}_c \|R_k\|_{\mathbb{R}}^2 n^{-1}
$$

for $\chi_1 \in \mathbb{R}_+$ and $\mathcal{K}_n := \{k \in \mathbb{N} : ||\mathbb{R}_k||^2_{\mathbb{R}} \le n\}$. Here $a \wedge b := \min(a, b)$ and $a_+ = \max(a, 0)$ for any real numbers $a, b \in \mathbb{R}$. Generally, the random function \widehat{V} is an empiricial version of $V(k) := \sigma_c ||\mathbf{R}_k||^2_{\mathbf{R}} n^{-1}$ which mimics the behaviour of the versions term connect Deposition 1. Analyzeurly, \widehat{A} is an empirical version of A variance term, compare Proposition [1.](#page-3-1) Analogously, \widehat{A} is an empirical version of $A(k) := \sup_{k \in \mathcal{K}_n} (\|\widehat{f}_{k'} - \widehat{f}_{k' \wedge k}\|_{x^{2c-1}}^2 \chi_1 V(k)$ ¹ which behaves like the bias term. For $\chi_2 \ge \chi_1$ we then set

$$
\widehat{k} := \underset{k \in \mathcal{K}_n}{\arg \min} \widehat{A}(k) + \chi_2 \widehat{V}(k). \tag{6}
$$

Then we can show the following result where we denote by $||h||_{\infty}$ the essential supremum of a measurable function *h* : ℝ → ℂ and $||h||_{\infty, x^{2c-1}}$ the essential supremum of $x \mapsto x^{2c-1}h(x)$.

Theorem 3. Let $c \in \mathbb{R}$ and $f \in \mathbb{L}^2(\mathbb{R}_+, x^{2c-1})$. Assume that $\mathbb{E}_{f_Y}(Y_1^{5(c-1)})$.
Then for $y_2 > y_1 > 72$ $\binom{1}{1}$ < ∞, $||g||_{\infty, x^{2c-1}}$ < ∞ *and* [**G1**] *is fulfilled. Then for* $\chi_2 \geq \chi_1 \geq 72$,

$$
\mathbb{E}_{f_Y}^n(||\widehat{f_k} - f||_{X^{2c-1}}^2) \le C_1 \inf_{k \in \mathcal{K}_n} (||1\!\!1_{G_k} \mathcal{M}_c[f]||_{\mathbb{R}}^2 + V(k)) + \frac{C_2}{n}
$$

where C_1 *is a positive constant depending on* χ_2, χ_1 *and* C_2 *is a positive constant depending on* $\mathbb{E}_{f_Y}(Y_1^{5(c-1)}$ $\lim_{1}^{5(c-1)}$, ||g||_{∞,*x*^{2*c*−1}}, *g and r.*

Assuming now that the density lies in a Mellin-Sobolev ellipsoid, we can deduce directly the following corollary whose proof is thus omitted.

Corollary 2. *Let* $c \in \mathbb{R}$, $s, L \in \mathbb{R}_+$ and $f \in \mathbb{D}_{c}^s(L)$. Assume further that $\mathbb{E}_{f_Y}(Y_1^{5(c-1)}$ $\binom{1}{1}$ < ∞, $||g||_{\infty, x^{2c-1}}$ < ∞ *and* [G1] *is fulfilled. Then for* $\chi_2 \geq \chi_1 \geq 72$,

$$
\mathbb{E}_{f_Y}^n(||\widehat{f_k} - f||_{x^{2c-1}}^2) \le C(L, s, r, g, \mathbb{E}_f(X_1^{5(c-1)})) n^{-2s/(2s+2\gamma+1)}
$$

where $C(L, s, r, g, \mathbb{E}_f(X_1^{5(c-1)})$ $\binom{5(c-1)}{1}$) *is a positive constant depending on L*, *s*, *r*, *g and* $\mathbb{E}_f(X_1^{5(c-1)})$ $\binom{5(c-1)}{1}$.

Conclusion

Let us summarise the presented results of the ridge estimator $f_{k,\xi,r}$ in comparison to the properties of the spectral cut-off estimator \hat{t}_k , considered by [\[6\]](#page-14-0) and [\[5\]](#page-14-2). For the definition of the estimator, the spectral cut-off estimator needs the assumption [G0]. This assumption already implies the existence of a consistent version of the spectral cut-off estimator. For the definition of the ridge estimator the assumption [G0] is not necessary. Nevertheless, in order to show that there exists a consistent version of the ridge estimator, we needed assumption [G-1], which is weaker than [G0]. In this scenario, the estimator $f_{k,\xi,r}$ seems to be favourable if one aims to consider minimal assumptions on the error density, for instance to construct a strong consistent estimator, compare Remark [1.](#page-3-2) As soon as we are interested in developing the minimax theory of the estimators, the assumption [G1] is natural to be considered. It is worth pointing out, that [G1] implies [G0] and therefore [G-1]. Here the assumptions of Proposition [1,](#page-3-1) which are needed for the minimax optimality of both estimators, are identical to the assumptions of [\[5\]](#page-14-2). Thus none of the estimators seem to be more favourable in terms of minimax-optimality. Again, for the data-driven estimators f_k and f_k , proposed by [\[6\]](#page-14-0), the assumptions on the error densities are identical. Here it should be mentioned that the authors [\[6\]](#page-14-0) have proven the case $c = 1$. The general case for $c \in \mathbb{R}$ can be easily shown using the same strategies as in the proof of Theorem [3.](#page-5-1) In total, we can say that for the construction of an estimator with minimal assumption on the error density *g*, the ridge estimator seems to be favourable, in the sense, that it requires weaker assumptions on *g*. As soon as we consider smooth error densities, that is under assumption [G1], neither the ridge estimator nor the spectral cut-off estimator seems to be more favourable in terms of minimax-optimality and data-driven estimation.

4. Numerical study

In this section, we illustrate the behaviour of the data-driven ridge estimator $f_k = f_{k,0,r}$ presented in eq. [\(5\)](#page-2-1) and [\(6\)](#page-5-2) and compare it with the spectral cut-off estimator $f_{\vec{k}}$, presented in [\[6\]](#page-14-0), where

$$
\widetilde{k} = \underset{k \in \widetilde{\mathcal{K}}_n}{\arg \min} - ||\widetilde{f_k}||_{x^{2c-1}}^2 + \widehat{\text{pen}}(k)
$$

with $\widehat{\text{pen}}(k) := 2\chi \widehat{\sigma}_c ||1_{[-k,k]}\mathcal{M}_c[g]^{-1}||^2_{\mathbb{R}}/(2\pi n)$ and $\widetilde{\mathcal{K}}_n := \{k \in \mathbb{N} : ||1_{[-k,k]}\mathcal{M}_c[g]^{-1}||^2_{\mathbb{R}} \leq 2\pi n\}$. To do so, we use the following examples for the unknown density f following examples for the unknown density *f* ,

- (*i*) *Beta Distribution:* $f(x) = B(2, 5)^{-1}x(1 x)^{4}1_{(0,1)}(x), x \in \mathbb{R}_{+}$,
 ii) *Log Camma Distribution:* $f(x) = 55\Gamma(5)^{-1}x^{-6} \log(x)^{4}1$
- (*ii*) $Log-Gamma Distribution: f(x) = 5⁵Γ(5)⁻¹ x⁻⁶ log(x)⁴ 1_(1,∞)(x), x ∈ ℝ₊,$
 iii) $Gamma$ Distribution: $f(x) = Γ(5)⁻¹ x⁴ exp(x)¹ 1⁻¹ cos(x) x ∈ ℝ₋₁ and$
- (*iii*) *Gamma Distribution:* $f(x) = \Gamma(5)^{-1}x^4 \exp(-x)1\!\!\mathbb{1}_{(0,\infty)}(x), x \in \mathbb{R}_+$, and
(*iii*) *Log Marmal Distribution:* $f(x) = (0.08\pi x^2)^{-1/2} \exp(-\log(x)^2/0.08)$
- (*iv*) *Log-Normal Distiribution:* $f(x) = (0.08\pi x^2)^{-1/2} \exp(-\log(x)^2/0.08) \mathbb{1}_{(0,\infty)}(x), x \in \mathbb{R}_+$.

A detailed discussion of these examples in terms of the decay of their Mellin transform can be found in [\[5\]](#page-14-2). To visualize the behaviour of the estimator, we use the following examples of error densities *g*,

- *a*) *Symmetric noise:* $g(x) = 1_{(0.5,1.5)}(x), x \in \mathbb{R}_+$, and
- *b*) *Beta Distribution:* $g(x) = 2x \mathbb{1}_{(0,1)}(x), x \in \mathbb{R}_+$.

Here it is worth pointing out that the example *a*) and *b*) fulfill [G1] with $\gamma = 1$ and $\gamma = 2$. By minimising an integrated weighted squared error over a family of histogram densities with randomly drawn partitions and weights we select for *a*) $\chi_1 = \chi_2 = 72$ for $f_{\vec{k}}$ and $\chi = 5$ for $f_{\vec{k}}$. For the case *b*) we choose $\chi_1 = \chi_2 = 6$ and $\chi = 3$. In both cases, we have set $r = 2.$

Fig. 1: The estimator f_k (top) and f_k (bottom) is depicted for 50 Monte-Carlo simulations with sample size $n = 2000$ in the case (*i*) under the error dependent of k (right) for $a = 1$. The true depending f is giv density *a*) (left) and *b*) (right) for $c = 1$. The true density *f* is given by the black curve while the red curve is the point-wise empirical median of the 50 estimates.

Figure [1](#page-7-0) shows that both estimators behave similarly. As suggested by the theory, the reconstruction of the density *f* from the observation $(Y_j)_{j \in \llbracket n \rrbracket}$ seems to be less difficult if the error variable is uniformly distibuted, case *a*), than if the error variable is Beta distributed, case *b*).

The true density *f* is given by the black curve while the red curve is the point-wise empirical median of the 50 estimates.

Again we see that both estimators react analogously to varying values of the model parameter $c \in \mathbb{R}$. Looking at the medians in Figure [2,](#page-8-1) for $c = 0$ the median seems to be closer to the true density for smaller values of $x \in \mathbb{R}_+$. For $c = 1$ the opposite effects seems to occur. For $c = 1/2$, the case of the unweighted \mathbb{L}^2 -distance, such effects cannot
be observed. Regarding the risk, this seems natural as the weight function for $c = 0$ is monton be observed. Regarding the risk, this seems natural as the weight function for $c = 0$ is montonically decreasing, while for $c = 1$ it is monotonically increasing.

\mathbb{E}_{f_Y}^n(\sup_{k \in \mathcal{K}_n} \left(\sup_{h \in \mathbb{U}} v_{k,1}(h)^2 - \frac{\chi_1}{12} V(k) \right)_+) \le \sum_{k=1}^{K_n} \frac{C_{f_Y}}{n} \left(||\mathbf{R}_k^2||_{\infty} \exp(-C_{f_Y} \frac{||\mathbf{R}_k||_{\mathbb{R}}^2}{||\mathbf{R}_k^2||_{\infty}}) + n^{-1} \right) \le \frac{C_{f_Y}}{n} (1 + \sum_{k=1}^{K_n} ||\mathbf{R}_k^2||_{\infty} \exp(-C_{f_Y} \frac{||\mathbf{R}_k||_{\mathbb{R}}^2}{||\mathbf{R}_k^2||_{\infty}})).
$$

Now it can easily be seen that there exists constants $c_{g,r}, C_{g,r} > 0$ such that $c_{g,r} k^{2+\gamma^{-1}} \le ||R_k||_{\mathbb{R}}^2 \le C_g k^{2+\gamma^{-1}}$ using [G1]. By simple calculus, one can show that $\|\mathbb{R}_k^2\|_{\infty} \leq C_{g,r}k^2$. Since $(k^2 \exp(-C_{f_Y}k^{\gamma-1}))_{k \in \mathbb{N}}$ is summable we can deduce that $\mathbb{E}_{I_Y}^n(\sup_{k \in \mathcal{K}_n} \left(\sup_{h \in \mathbb{U}} \nu_{k,1}(h)^2 - \frac{\chi_1}{12} V(k) \right)_+ \leq C_{f_Y} n^{-1}$ Let us now show part (*ii*) : For any $h \in \mathbb{U}$ and $k \in \mathcal{K}_n$ we get

$$
\nu_{k,2}(h)^2 \leq \frac{\|h\|_{x^{2c-1}}^2}{2\pi} \int_{-\infty}^{\infty} |\widehat{M}_{c,2}(t) - \mathbb{E}_{f_Y}^n(\widehat{M}_{c,2}(t)|^2 |R_k(t)|^2) dt \leq \frac{1}{2\pi} \int_{-\infty}^{\infty} |\widehat{M}_{c,2}(t) - \mathbb{E}_{f_Y}^n(\widehat{M}_{c,2}(t))|^2 |R_{K_n}(t)|^2 dt
$$

and thus, since $R_k(t) \ge R_\ell(t)$ for all $t \in \mathbb{R}$ and $k \ge \ell$,

$$
\mathbb{E}^n_{f_Y}(\sup_{k \in \mathcal{K}_n} \sup_{h \in \mathbb{U}} \nu_{k,2}(h)^2)) \leq \frac{1}{n} \|R_{K_n}\|_{\mathbb{R}}^2 \mathbb{E}_{f_Y}(Y_1^{2(c-1)} 1\!\!1_{[c_n,\infty)} (Y_1^{c-1})).
$$

Now by definition of \mathcal{K}_n we know that $||R_{K_n}||_{\mathbb{R}}^2 n^{-1} \le 1$. We deduce that for any $p > 0$

$$
\mathbb{E}_{f_Y}^n(\sup_{m\in\mathcal{K}_n} \sup_{h\in\mathbb{U}} \nu_{k,2}(h)^2)) \le c_n^{-p} \mathbb{E}_{f_Y}(Y_1^{(2+p)(c-1)}) \le \frac{C(\sigma_c, \mathbb{E}_{f_Y}(Y_1^{5(c-1)}))}{n}
$$

choosing $p = 3$ and by the definition of $(c_n)_{n \in \mathbb{N}}$. Part (iii): First we see that for any $k \in \mathcal{K}_n$, $(V(k) - \widehat{V}(k))_+ = ||R_k||_{\mathbb{R}}^2 n^{-1} (\sigma_c - 2\widehat{\sigma}_c)_+ \leq (\sigma_c - 2\widehat{\sigma}_c)_+$. On $\Omega = \{|\widehat{\sigma}_c - \sigma_c| \leq \frac{(\sigma_c - 2\widehat{\sigma}_c)^2}{\sigma_c^2} \}$ $\sigma_c/2$ } we have $\frac{\sigma_c}{2} \leq \hat{\sigma}_c \leq \frac{3}{2}\sigma_c$. This implies

$$
\mathbb{E}_{f_Y}^n(\sup_{k \in \mathcal{K}_n} (V(k) - \widehat{V}(k))_+) \leq \mathbb{E}_{f_Y}^n((\sigma_c - 2\widehat{\sigma}_c)_+) \leq 2\mathbb{E}_{f_Y}^n(|\sigma_c - \widehat{\sigma}_c| \mathbb{1}_{\Omega^c}) \leq 4\frac{\mathbb{V}\ar^n_{f_Y}(\widehat{\sigma}_c)}{\sigma_c}
$$

applying the Cauchy Schwartz inequality and the Markov inequality. Now the last inequality implies the claim. \Box
