## **A NOTE ON THE WEAK CONVERGENCE OF CONTINUOUSLY INTEGRABLE SEQUENCES**

Abstract. A uniformly continuously integrable sequence of real-valued measurable functions, defined on some probability space, is relatively compact in the  $\sigma(L^1, L^{\infty})$  topology. In this paper, we link such a result to weak convergence theory of bounded measures as exposed in Billingsley (1968) and in Lo(2021) to offer a detailed and new proof using the ideas beneath the proof of prohorov's theorem where the continuous integrability replaces the uniform or asymptotic tightness.

**Keywords**. weak convergence in the  $\sigma(L^1, L^{\infty})$  topology; weak convergence of bounded measure from a probabilistic point of view; relative compactness; tightness; continuous integrability.

## 1. Introduction

The following result is proved, for example in [Meyer](#page-7-0) [\(1966\)](#page-7-0).

<span id="page-0-0"></span>**Proposition 1.** *Let*  $(f_n)_{n\geq 1}$  *be a sequence of measurable mappings:* 

$$
f_n:\Omega\longrightarrow\mathbb{R},
$$

*where*  $(\Omega, \mathcal{A}, \mathbb{P})$  *is a probability space. Suppose that*  $(f_n)_{n\geq 0}$  *is uniformly continuously integrable (u.c.i), that is*

$$
\lim_{c \to +\infty} \overline{\phi}(c) := \lim_{c \to +\infty} \sup_{n \ge 1} \int_{(|f_n| > c)} |f_n| \ d\mathbb{P} = 0.
$$

*Then*  $(f_n)_{n\geq 1}$  *has a sub-sequence*  $(f_{n_k})_{k\geq 1}$  *converging to some*  $f \in L^1$  *in the*  $\sigma(L^1,L^\infty)$  topology, i.e.,

$$
\forall g \in L^{\infty}, \int g f_{n_k} d\mathbb{P} \to \int g f d\mathbb{P}.
$$

Let us make some remarks.

**Remark [1](#page-0-0).** Proposition 1 implies that: Any uniformly continuously integrable sequence possesses a subsequence such that the sequence of its mathematical expectations converges in R, since

$$
\mathbb{E}_{\mathbb{P}}(f_{n_k}) = \int 1_{\Omega} f_{n_k} d\mathbb{P} \to \int 1_{\Omega} f d\mathbb{P} = \mathbb{E}_{\mathbb{P}}(f)
$$

This fact is very important in some mathematical problems. For example, it is used in the extension of the Doob decomposition of super-martingales for discrete sequences to time-continuous versions.

**Remark 2.** Proposition [1](#page-0-0) is very important in some mathematical problems. For example, it used in the extension of the Doob decomposition of super-martingales for discrete sequences to time-continuous versions.

**Remark 3**. From the weak convergence theory in the sense of [Billinsgley](#page-7-1) [\(1968\)](#page-7-1), the problem posed here is very similar to prohorov's theorem except we do not have a topology on the domain  $\Omega$  of the  $f_n$ 's. The idea is that we might give a proof following the lines of that of Prohorov's theorem (see Theorem in Lo *[et al.](#page-7-2)* [\(2016](#page-7-2))) in which the tightness hypothesis will be replaced by the *u.c.i* condition. The proof given below realizes that idea. Let us proceed to the proof.

2. Proof

Let us divide the proof into two parts.

**Part 1.** Let us suppose that the  $f_n$ 's are non-negative. Let us set measures  $\nu_n$ :

$$
d\nu_n = f_n d\mathbb{P}, \ n \ge 1.
$$

Let

$$
\mathcal{C}_0 = \{ g \in L^{\infty}, \ \|g\| \le 1 \}.
$$

Since the  $f_n$ 's are *u.c.i*, we have for  $n \ge 1$ , for  $c > 0$ ,

$$
\int |f_n| d\mathbb{P} = \int_{(|f_n| \le c)} |f_n| d\mathbb{P} + \int_{(|f_n| > c)} |f_n| d\mathbb{P}
$$
  
\n
$$
\le c + \sup_{n \ge 1} \int_{(|f_n| > c)} |f_n| d\mathbb{P}
$$
  
\n
$$
= c + \overline{\phi}(c)
$$

and

$$
\overline{\phi}(c) \to 0, \text{ as } c \to +\infty.
$$

So, for some  $c_0 > 0$ , we have

$$
\sup_{n\geq 1} \int |f_n| \, d\mathbb{P} \leq c_0 + 1 =: C.
$$

Now, for  $g \in \mathcal{C}_0$ ,  $\forall n \geq 1$ ,

$$
\left| \int gf_n \ d\mathbb{P} \right| \leq \int |f_n| \ d\mathbb{P} \leq C.
$$

Hence

$$
\overline{\nu}_n = (\nu_n(g), \ g \in \mathcal{C}_0) \in [0, \ C]^{C_0}.
$$

Since  $[0, C]^{C_0}$  as an arbitrary product of the compact set  $[0, C]$ , by Tchychonov's theorem, we may extract a sub-sequence  $(\overline{\nu}_{n_k})_{k\geq 1}$  from  $(\overline{\nu}_{n})_{n\geq 1}$  converging to  $\overline{\nu} = (\nu(g), g \in \overline{\mathcal{C}}_0)$ , that is

$$
\forall g \in \mathcal{C}_0, \ \nu_{n_k}(g) \to \nu(g),
$$

with

$$
\forall g \in \mathcal{C}_0, \ \nu(g) \leq C.
$$

We have to show that  $\nu$  is still a measure on  $(\Omega, \mathcal{A}, \mathbb{P})$  for  $g = 1_A$ ,  $A \in \mathcal{A}$ . But in general, we have for  $(\alpha, \beta) \in \mathbb{R}^2$ :  $|\alpha| + |\beta| \le 1$ ,  $(g, h) \in C_0^2$ ,

$$
\nu_{n_k}(\alpha g + \beta h) = \alpha \nu_{n_k}(g) + \beta \nu_{n_k}(h)
$$
  
\n
$$
\rightarrow \alpha \nu(g) + \beta \nu(h) \text{ as } k \rightarrow +\infty
$$

and since  $\alpha g + \beta h \in \mathcal{C}_0$ , we have

$$
\nu_{n_k}(\alpha g + \beta h) \to \nu(\alpha g + \beta h) \text{ as } k \to +\infty
$$

and hence

$$
\nu(\alpha g + \beta h) = \alpha \nu(g) + \beta \nu(h).
$$

We prove similarly that for  $(g_1, \dots, g_p) \in C_0^p$ ,  $p \ge 2$ , for  $(\alpha_1, \dots, \alpha_p) \in \mathbb{R}^p$ :  $|\alpha_1| + \cdots + |\alpha_p| \leq 1,$ 

$$
\nu_{n_k}(\alpha_1g_1+\cdots+\alpha_pg_p)\to \alpha_1\nu(g_1)+\cdots+\alpha_p\nu(g_p).
$$

Now for any pair-wise disjoint measurable sets  $(A_j)_{1\leq j\leq p},~ 1_{\sum_{j=1}^pA_j}\in \mathcal{C}_0,$  and

$$
\nu_{n_k} \left( \sum_{j=1}^p A_j \right) =: \nu_{n_k} \left( 1_{\sum_{j=1}^p A_j} \right) \to \nu \left( 1_{\sum_{j=1}^p A_j} \right)
$$

and

$$
\nu_{n_k} \left( \sum_{j=1}^p A_j \right) = \sum_{j=1}^p \nu_{n_k} (1_{A_j}) \to \sum_{j=1}^p \nu (1_{A_j}).
$$

So,

$$
\nu\left(\sum_{j=1}^p A_j\right) = \sum_{j=1}^p \nu(A_j).
$$

Let us prove that  $\nu$  is a measure by extending the finite additivity to a  $\sigma$ additivity.

But since  $\nu$  is non-negative, finite and additive, so it is enough to show that  $\nu$  is continuous at  $\emptyset$ :

$$
\forall A_p \downarrow \emptyset, \ \nu(A_P) \downarrow 0 \ as \ p \uparrow +\infty.
$$

By Theorem [Lo](#page-7-3) [\(2018\)](#page-7-3), an *u.c.i* sequence is also uniformly absolutely:

$$
\forall \varepsilon > 0, \ \left( \exists \delta > 0, \ \forall A \in \mathcal{A} : \mathbb{P}(A) < \delta, \ \sup_{n \ge 1} \ \int_A |f_n| \ d\mathbb{P} < \varepsilon \right).
$$

Let  $A_p \downarrow \emptyset$ ,  $A_p \in \mathcal{A}$ . So there exists  $p_0 \in \mathbb{N}$ , such that for any  $p \geq p_0$ ,  $\mathbb{P}(A_p) < \epsilon$ and hence

$$
\sup_{k\geq 1} \int_{A_p} |f_{n_k}| \, d\mathbb{P} < \epsilon,
$$

that is,

$$
\forall p \ge p_0, \ \forall k \ge 1, \ |\nu_{n_k}(A_p)| \le \int_{A_p} |f_{n_k}| \ d\mathbb{P} < \varepsilon.
$$

By letting  $k \to +\infty$ , we get

$$
\forall p \ge p_0, \ \nu(A_p) < \epsilon.
$$

We proved that

$$
\nu(A_P) \to 0 \text{ as } p \to +\infty.
$$

 $\nu$  is non-decreasing as an additive and non-negative mapping on A. So  $\nu$ is a measure on  $(\Omega, \mathcal{A}, \mathbb{P})$ , Let us show that  $\nu$  is continuous with respect to P, that is

$$
d\nu = f \ d\mathbb{P}, \ f \in L^1.
$$

We have for  $A \in \mathcal{A}$  such that  $\mathbb{P}(A) = 0$ ,

$$
0 = \int_A f_{n_k} \, d\mathbb{P} = \nu_{n_k}(A) \to \nu(A)
$$

and then  $\nu(A) = 0$ . So  $\nu$  is continuous with respect to P. By Random Nikodym theorem, there exists  $f \in L^1$  (since  $\nu$  is finite) such that

<span id="page-5-0"></span> $d\nu = f \, d\mathbb{P}.$ 

So

(2.1) 
$$
\forall A \in \mathcal{A}, \int 1_A f_{n_k} d\mathbb{P} \to \int 1_A f d\mathbb{P}.
$$

Now,  $(2.1)$  is automatically holds if  $1_A$  is replaced by an elementary function on  $(\Omega, \mathcal{A}, \mathbb{P})$ . Next any element g of  $\tilde{\mathcal{C}}_0$  is limit of a sequence  $(g_p)$  of elementary functions with  $|g_p| \le |g| \le 1$ . So for  $p \ge 1$ ,  $k \ge 1$ ,  $\varepsilon > 0$ , we have

$$
\left| \int g f_{n_k} d\mathbb{P} - \int g f d\mathbb{P} \right|
$$
  
\n
$$
\leq \left| \int (g - g_p) f_{n_k} d\mathbb{P} \right| + \left| \int g_p f_{n_k} d\mathbb{P} - \int g f d\mathbb{P} \right|
$$
  
\n
$$
\leq \left| \int_{(|g - g_p| \leq \varepsilon)} (g - g_p) f_{n_k} d\mathbb{P} \right| + \left| \int_{(|g - g_p| > \varepsilon)} (g - g_p) f_{n_k} d\mathbb{P} \right| + \left| \int g_p f_{n_k} d\mathbb{P} - \int g f d\mathbb{P} \right|
$$
  
\n
$$
\leq \varepsilon \int f_{n_k} d\mathbb{P} + \int 1_{(|g - g_p| > \varepsilon)} f_{n_k} d\mathbb{P} + \left| \int g_p f_{n_k} d\mathbb{P} - \int g f d\mathbb{P} \right|.
$$

By letting  $p \ge 1$  and  $\varepsilon > 0$  fixed, and letting  $k \to +\infty$ , we get

$$
\limsup_{k\to+\infty}\left|\int g\ f_{n_k}\ d\mathbb{P}-\int g\ f\ d\mathbb{P}\right|\leq \varepsilon\int\ f\ d\mathbb{P}+\int 1_{(|g-g_p|>\varepsilon)}\ f\ d\mathbb{P}+\left|\int g_p\ f\ d\mathbb{P}-\int g\ f\ d\mathbb{P}\right|.
$$

Now, we let  $p \to +\infty$ , to get

$$
\left| \int g_p f \, d\mathbb{P} - \int g f \, d\mathbb{P} \right| \to 0,
$$

by the dominated convergence theorem applied to  $L^1 \ni (2f) \ge |g - g_p| \to 0$ and

$$
\int 1_{(|g-g_p|>\varepsilon)} f \, d\mathbb{P} \to 0,
$$

since  $g_p \to g$  and hence  $g_p \to_p g$  and next  $\mathbb{P}(|g - g_p| > \varepsilon) \to 0$  and finally the integrable function f is continuous. We get for any  $\varepsilon > 0$ 

$$
\limsup_{k \to +\infty} \left| \int g f_{n_k} d\mathbb{P} - \int g f d\mathbb{P} \right| \leq \varepsilon \int f d\mathbb{P}.
$$

We conclude by letting  $\varepsilon \downarrow 0$  and get

$$
\forall g \in \mathcal{C}_0, \int g \, f_{n_k} \, d\mathbb{P} \to \int g \, f \, d\mathbb{P}.
$$

Finally, for any  $g \in L^{\infty}$ ,  $||g||_{\infty} \geq 1$ ,

$$
\overline{g} = \frac{g}{\|g\|_\infty} \in \mathcal{C}_0
$$

and

$$
\int gf_{n_k} d\mathbb{P} = ||g||_{\infty} \int \overline{g} f_{n_k} d\mathbb{P} \to ||g||_{\infty} \int \overline{g} f d\mathbb{P} = \int gf d\mathbb{P}.
$$

The proof of **Part 1** is complete.

**Part 2**. Here the  $f_n$ s are not necessarily non-negative. We define for  $g \in C_0$ 

$$
\nu_n(g) = \int gf_n^+ d\mathbb{P} - \int gf_n^- d\mathbb{P}
$$
  
=  $\nu_n^+(g) - \nu_n^-(g)$ .

The sequences  $(f_n^+)_{n\geq 1}$  and  $(f_n^-)_{n\geq 1}$  are still *u.c.i* since for example

$$
\int_{(f_n^+>c)} f_n^+ d\mathbb{P} \le \int_{(|f_n|>c)} f_n^+ d\mathbb{P} \le \int_{(|f_n|>c)} |f_n| d\mathbb{P} \le \overline{\phi}(c).
$$

So for some constant  $C > 0$ , we have

$$
0\leq \nu_n^+\leq C \ and \ 0\leq \nu_n^-\leq C.
$$

By **Part 1**, we extract a subsequence  $(\nu^+_{n'})_{n'\geq 1}$  from  $(\nu^+_{n})_{n\geq 1}$  that weakly converges to  $\nu^+$  with  $d\nu^+ = f^+d\mathbb{P}$ ,  $\bar{f}^+ \in L^1$ . Next From  $(\nu_{n'}^-)_{n' \geq 1}$  we extract a subsequence  $(\nu_{n_k}^-)_{k\geq 1}$  and  $(\nu_{n_k}^-)_{k\geq 1}$  that weakly converges to  $\nu^-$  with  $d\nu^- = f^- d\mathbb{P}$ ,  $f^- \in L^1$ . Hence

$$
\nu_{n_k}^+\to_{\sigma(L^1,L^\infty)}\nu^+\ \ and\ \ \nu_{n_k}^-\to_{\sigma(L^1,L^\infty)}\nu^-,
$$

and

$$
\nu_{n_k} = \nu_{n_k}^+ - \nu_{n_k}^- \to_{\sigma(L^1, L^\infty)} \nu^+ - \nu^- = \nu,
$$

with  $d\nu = f d\mathbb{P}$ , with  $f = f^+ - f^- \in L^1$ .
