# Rigidity of the round cylinders in Ricci shrinkers

#### Abstract

In this paper, we prove that the round cylinders are rigid in the space of Ricci shrinkers. Namely, any Ricci shrinker that is sufficiently close to  $S^{n-1} \times \mathbb{R}$  in the pointed-Gromov-Hausdorff topology must itself be isometric to  $S^{n-1} \times \mathbb{R}$ .

# <span id="page-0-0"></span>1 Introduction

A Ricci shrinker is a triple  $(M^n, g, f)$  of smooth manifold  $M^n$ , Riemannian metric *g* and a smooth function *f* satisfying

$$
Rc + \text{Hess } f = \frac{1}{2}g,
$$

where the potential function *f* is normalized so that

$$
R + |\nabla f|^2 = f. \tag{1.1}
$$

The Ricci shrinkers play essential roles in studying the singularities of the Ricci flow. For example, it was proved by Enders-Müller-Topping [\[26\]](#page-73-0) that any proper blowup sequence from a type-I Ricci flow converges smoothly to a nontrivial Ricci shrinker.

Due to its importance, the classification of Ricci shrinkers has attracted extensive attentions. In dimension 2 or 3, we know that  $\mathbb{R}^2$ ,  $S^2$ ,  $\mathbb{R}^3$ ,  $S^3$ ,  $S^2 \times \mathbb{R}$ , and their quotients make the complete list of all Ricci shrinkers (e.g., [\[32\]](#page-74-0)[\[54\]](#page-75-0)[\[57\]](#page-75-1)[\[13\]](#page-73-1)). In higher dimensions, there exist many nontrivial, non-product Ricci shrinkers (e.g., [\[37\]](#page-74-1)[\[11\]](#page-73-2)[\[27\]](#page-73-3)), and the classification of Ricci shrinkers is only achieved when extra assumptions are assumed. Such assumptions include non-negativity of curvatures (e.g., [\[52\]](#page-75-2)[\[46\]](#page-75-3)[\[55\]](#page-75-4)[\[45\]](#page-75-5)[\[48\]](#page-75-6)), restriction of the Weyl curvatures (e.g., [\[59\]](#page-75-7)[\[50\]](#page-75-8)[\[12\]](#page-73-4)[\[23\]](#page-73-5)), restriction of asymptotic behavior at infinity (e.g., [\[40\]](#page-74-2)[\[41\]](#page-74-3)), Kähler conditions (e.g., [\[56\]](#page-75-9)[\[22\]](#page-73-6)[\[20\]](#page-73-7)), and others. In general, much less is known if no extra assumptions are assumed.

We can consider all Ricci shrinkers as one moduli space M equipped with pointed-Gromov-Hausdorff topology. On each Ricci shrinker, *f* always achieves its minimum value (cf. [\[14\]](#page-73-8)) at some point *p*, which can be assigned as a base point. A natural question is: which Ricci shrinker is rigid in  $M$ , in the sense that there is no nearby (in the pointed Gromov-Hausdorff distance) Ricci shrinker other than itself? For instance, it follows from [\[35\]](#page-74-4) and the weak-compactness theory developed in [\[44\]](#page-74-5) that the spherical space form *S n* /Γ is rigid since any Ricci shrinker is a self-similar Ricci flow solution. Other rigid examples include  $\mathbb{CP}^{2n}$  proved by Kröncke [\[42\]](#page-74-6) and  $S^2 \times S^2$  proved by Sun-Zhu [\[66\]](#page-76-0) very recently. Their proofs depend on a delicate local structure theory of M (cf. [\[62\]](#page-75-10)[\[36\]](#page-74-7)), which is not available for non-compact Ricci shrinkers. This makes the rigidity problem for non-compact Ricci shrinkers much more involved. Up to now, the only non-compact Ricci shrinkers known to be rigid are the Gaussian solitons  $(\mathbb{R}^n, g_E)$ , whose rigidity is proved through an entropy-gap argument (cf. [\[69\]](#page-76-1)[\[70\]](#page-76-2)[\[48\]](#page-75-6)).

Inspired by the fundamental work of Colding-Ilmanen-Minicozzi [\[21\]](#page-73-9) on mean curvature flow, and our earlier research on 4-dimensional Ricci shrinkers [\[47\]](#page-75-11), we are interested in figuring out whether the generalized cylinders  $S^k \times \mathbb{R}^{n-k}$ ,  $2 \le k \le n-1$  are rigid in the moduli space of Ricci shrinkers. In this article, we confirm the rigidity of the round cylinders  $S^{n-1} \times \mathbb{R}$ , i.e., the cases  $k = n - 1$ .

<span id="page-1-0"></span>**Theorem 1.1** (Main Theorem). *There exists a small constant*  $\hat{\epsilon} = \hat{\epsilon}(n) > 0$  *satisfying the following property.*

*Suppose* (*M<sup>n</sup>* , *p*, *g*, *f*) *is a Ricci shrinker such that*

$$
d_{PGH}\left\{(M^n, p, g), (S^{n-1} \times \mathbb{R}, p_c, g_c)\right\} < \hat{\epsilon},\tag{1.2}
$$

*then*  $(M, g)$  *is isometric to* ( $S^{n-1} \times \mathbb{R}$ ,  $g_c$ ). Here  $d_{PGH}$  means the pointed-Gromov-Hausdorff distance, *p is a minimum point of f and*  $p_c$  *<i>is a fixed point of*  $S^{n-1} \times \mathbb{R}$ *.* 

The proof of Theorem [1.1](#page-1-0) relies heavily on the symmetry improvement technique of S. Brendle et al. (cf. [\[3\]](#page-72-0)[\[5\]](#page-72-1)[\[6\]](#page-72-2)[\[7\]](#page-72-3)[\[9\]](#page-72-4)), the classification result of B. Kotschwar [\[38\]](#page-74-8) and the weak-compactness theory developed by H. Li, S. Huang and the authors ([\[44\]](#page-74-5) [\[34\]](#page-74-9) [\[48\]](#page-75-6)).

*Outline of the proof of Theorem [1.1.](#page-1-0)* The proof consists of four steps.

#### *Step 1. The base point p is in an*  $\epsilon$ *-neck.*

Condition [\(1.2\)](#page-1-1) means that the base point *p* has a neighborhood very close to the standard cylinder in the Gromov-Hausdorff topology, which is very rough. However, by the weak-compactness theory developed in [\[44\]](#page-74-5), we can improve the Gromov-Hausdorff topology to the *C* ∞-Cheeger-Gromov topology (cf. Proposition 7.4 of [\[44\]](#page-74-5)). Therefore, by choosing  $\hat{\epsilon}$  sufficiently small, we are able to show (cf. Proposition [2.6\)](#page-9-0) that *p* is actually in the center of an evolving normalized  $\epsilon$ -neck (cf. Definition [2.5\)](#page-9-1). We may understand that the point  $p$  has  $\epsilon$ -symmetry with respect to the model space  $S^{n-1} \times \mathbb{R}$ .

## *Step 2. Each point*  $x \in M$  *is in an*  $\epsilon$ *-neck or a region*  $\epsilon$ *-close to the Bryant soliton, after proper rescaling.*

This step is the technical core of this paper. We characterize the  $\epsilon$ -symmetry in terms of curvature and potential function estimates and show that these estimates are almost preserved along the flow line of ∇*f* . Roughly speaking, if the level set of *f* is uniformly away from being critical (i.e.,  $\nabla f = 0$ ), then each point locates in an  $\epsilon$ -neck. Moreover, the critical points are isolated, and the region is very close to the Bryant soliton near the critical point of f. Therefore, each point "far away" from the critical set is in an  $\epsilon$ -neck, and each point "near" critical set is in a region  $\epsilon$ -close to the Bryant soliton. These descriptions can be made precise, which is the key new ingredient of this argument.

#### *Step 3.* (*M*, *g*) *is rotationally symmetric.*

This step utilizes the celebrated symmetry improvement technique developed by S. Brendle et al. (cf. Appendix [B](#page-68-0) for details). Suppose  $\epsilon$  is sufficiently small and every point on  $(M, g)$  has  $\epsilon$ symmetry (with respect to either the cylinder or Bryant soliton), then every point has  $\frac{\epsilon}{2}$ -symmetry. Consequently, this process will run forever and yield that every point  $x \in M$  has  $2^{-k} \epsilon$ -symmetry for each positive integer  $k$ . Therefore,  $(M, g)$  is rotationally symmetric.

## *Step 4.*  $(M, g)$  *is isometric to*  $S^{n-1} \times \mathbb{R}$ *.*

Since (*M*, *g*) is rotationally symmetric already, the classification result of Kotschwar [\[38\]](#page-74-8) applies. We know that  $(M, g)$  is isometric to  $S^n$ ,  $S^{n-1} \times \mathbb{R}$  or  $\mathbb{R}^n$ . By condition [\(1.2\)](#page-1-1), we conclude that  $(M, g)$ must be isometric to  $S^{n-1} \times \mathbb{R}$ . *n*−1 × R.

From the discussion above, it is clear that the most difficult part of the proof is to analyze precisely the propagation of the  $\epsilon$ -symmetry along the flow line of  $\nabla f$ . Due to this propagation, if there is a neck region far away from the base point and close to the round cylinder, then the behavior of the far-end can be described precisely. Since  $f \sim \frac{d^2(p, \cdot)}{4}$ , the value of *f* indicates the distance to the base point. For each pair  $t \leq s$ , we define  $\Sigma(t, s)$  to be a connected component of the level set

$$
\{x \in M \mid t \le f(x) \le s\}.\tag{1.3}
$$

In the particular case  $t = s$ , we define

$$
\Sigma(t) := \Sigma(t, t) = \{x \in M \mid f(x) = t\}.
$$
\n(1.4)

If a point locates in a cylinder-like neighborhood, we say it is the center of  $\epsilon$ -neck. Alternatively, if a point locates in a neighborhood close to a steady soliton with mild singularities, we say it is the center of  $\epsilon$ -steady soliton conifold. Note that the conifold here is the one introduced by Chen-Wang (cf. Definition 1.2 of [\[24\]](#page-73-10)) to denote the Riemannian space with mild singularities. For the exact definitions of the aforementioned concepts, see Definition [2.5,](#page-9-1) Definition [4.3](#page-40-0) and Definition [A.1.](#page-60-1) With these terminologies, we can precisely describe the propagation of the  $\epsilon$ -symmetry in the following theorem.

<span id="page-3-1"></span>**Theorem 1.2** (Propagation of almost symmetry). *For any positive constants n, A, B,*  $\epsilon$  *and*  $\delta_0 \in$ (0, 1)*, there exist positive constants*  $\sigma = \sigma(n, \delta_0, A, B)$ ,  $L = L(n, \delta_0, A, B)$  and  $\eta = \eta(n, \delta_0, A, B, \epsilon)$ *satisfying the following property.*

*Let* (*M<sup>n</sup>* , *g*, *f*) *be a Ricci shrinker with*

*If*  $\epsilon_1 \leq \sigma$  and  $\epsilon'_1 \leq \eta$ , then one of the following statements holds.

- *(a). There exists an end E with*  $\partial E = \Sigma(t_0)$  *such that any point in*  $\Sigma(\eta^{-1}t_0, ∞) \subset E$  *is the center of an evolving normalized*  $ε$ -neck. Moreover, *E* is asymptotic to the round cylinder with rate *O*( $r^{-\tau(n)}$ ).
- *(b). There exists an end E with*  $\partial E = \Sigma(t_0)$  *such that any point in*  $\Sigma(\eta^{-1}t_0, \infty) \subset E$  *is the center of an evolving*  $\epsilon$ *-neck. Moreover, E is asymptotic to a regular cone with cross section di*ff*eomorphic to S <sup>n</sup>*−<sup>1</sup> *.*
- *(c). There exists a compact set E with* ∂*E* = Σ(*t*0)*, a number s* ≥ *s*<sup>0</sup> *and a point q* ∈ Σ(*s*) *such that*  $R(q) = \sigma s$ . Moreover, any point in  $\Sigma(\eta^{-1}t_0, s) \subset E$  is the center of an evolving  $\epsilon$ -neck and any *point in the cap D* :=  $E\setminus\Sigma(t_0, s)$  *is the center of an*  $\epsilon$ -steady soliton conifold. Furthermore,

\text{diam}_g D \le \frac{L}{\sqrt{s}}, \quad \sup_D |f - s| \le L \quad \text{and} \quad L^{-1} s \le \inf_D R \le \sup_D R \le s + L. \tag{1.6}

Note that [\(1.5\)](#page-3-0) on  $\Sigma(t_0, s_0)$  is satisfied if the region is very close to the cylinder, where the constant  $\epsilon'_1$  can be chosen as zero. Since the function *f* contains no critical point on the region  $\Sigma(t_0, s_0)$ , one can follow Munteanu-Wang [\[53\]](#page-75-12) to define the tangential curvature operator *Rm*<sub>Σ</sub> restricted on each level set of *f* and the term  $\mathbb{R}_{m_{\Sigma}}^{\circ}$  is the "traceless" part of  $\mathbb{R}_{m_{\Sigma}}$  (cf. [\(2.6\)](#page-7-0), [\(2.7\)](#page-7-1)). If  $\mathbb{R}/f$  is small, the value of  $|\overset{\circ}{Rm}_{\Sigma}|$  measures how close  $Rm_{\Sigma}$  resembles the curvature operator of the standard  $S^{n-1}$ . Theorem [1.2](#page-3-1) implies that if a Ricci shrinker has a neck region sufficiently close to the cylinder in some weak sense, one can move forward along the direction of ∇*f* to determine the future geometric property. If we regard a Ricci shrinker as a Ricci flow solution, the control of the geometric behavior at spatial infinity amounts to that near the singular time  $t = 1$ . Recall that the traditional pseudolocality on Ricci shrinkers (cf. [\[48,](#page-75-6) Corollary 10.6]) means that the almost Euclidean property is preserved by the flow until time  $t = 1$ . Theorem [1.2](#page-3-1) claims instead that the  $\epsilon$ -symmetric property is almost preserved by the flow until time  $t = 1$ . Therefore, Theorem [1.2](#page-3-1) can be understood as a generalized form of pseudolocality theorem on Ricci shrinkers. See Figure [1](#page-4-0) for rough intuition. We emphasize here that the global bound of the curvature is not needed. With some extra assumptions like the boundedness of the curvature, Munteanu-Wang [\[53,](#page-75-12) Theorem 1.6] has already obtained case (a) in Theorem [1.2.](#page-3-1)

We briefly discuss the proof of Theorem [1.2.](#page-3-1) We first show on the neck region satisfying  $(1.5)$ , the estimate  $|\stackrel{\circ}{Rm}_{\Sigma}| \leq \epsilon_0 R$  holds on  $\Sigma(t_0, s_0)$ , where  $\epsilon_0$  is a constant depending only on  $\epsilon_1$  and  $\epsilon'_1$ . Since  $f \ge t_0$  is large and  $R/f \le \epsilon_1$  is small, all normal directional part of *Rm* is small and insignificant. Moreover, we can show that the scalar curvature *R* is almost constant along any level set  $\Sigma$  of *f* contained in the neck region. From the elliptic equation of *R*, one obtains an ODE by examining the behavior of *R* along the gradient flow of *f* .

One can extend the neck region from  $\Sigma(t_0, s_0)$  to  $\Sigma(t_0, s)$  with *s* to be maximal so that [\(1.5\)](#page-3-0) still holds. Then we show that *s* is finite only if there exists a point  $q \in \Sigma(s)$  with  $R(q) = \epsilon_1 f(q)$ . Here, we need to use the pseudolocality for Ricci shrinkers proved in [\[48\]](#page-75-6) to show that any point  $x \in \Sigma(\eta^{-1}t_0, s)$  is the center of an evolving  $\epsilon$ -neck. Depending on the behavior of *R* along the gradient flow of *f* , only three cases can happen, as described in Theorem [1.2.](#page-3-1) If *R* stays close to  $\frac{n-1}{2}$ , then *s* = ∞ and we obtain the case (a). If at some point in the neck *R* is smaller than  $\frac{n-1}{2}$ by some detectable small number, then *R* will be quadratically decaying along the flow. In this case,  $s = \infty$  and we obtain the case (b). If at some point in the neck *R* is bigger than  $\frac{n-1}{2}$  by some detectable small number, then *R* will be increasing along the flow until it reaches the boundary  $\Sigma(s)$ . If this happens,  $s < \infty$  and we obtain case (c). In this case, it is important to show that there exists a compact cap *D* with  $\partial D = \Sigma(s)$ . The reason is that the behavior of the Ricci shrinker near the boundary  $\Sigma(s)$  is modeled on a Ricci steady soliton conifold (cf. Definition [A.1\)](#page-60-1) at a proper scale. This can be proved through a compactness argument (cf. [\[44\]](#page-74-5)[\[34\]](#page-74-9)). Since each model steady soliton

conifold has only one end (cf. Theorem [A.22\)](#page-66-0), the cap region *D* is compact. Further analysis implies the estimates in [\(1.6\)](#page-3-2).

Now we continue to discuss Step 2 in the outline proof of Theorem [1.1](#page-1-0) in more detail. First, one notices that any Ricci shrinker close to the cylinder satisfies the conditions of Theorem [1.2](#page-3-1) for two neck regions. By extending those two neck regions, there are three possibilities.

- (1). The Ricci shrinker has two ends so that each point is the center of an evolving  $\epsilon$ -neck.
- (2). The Ricci shrinker has exactly one end so that outside a compact cap *D*, any point is the center of an evolving  $\epsilon$ -neck.
- (3). The Ricci shrinker is compact and it consists of two caps  $D_1$  and  $D_2$  such that outside those two caps, any point is the center of an evolving  $\epsilon$ -neck.

In order to realize Step 2 in the proof of Theorem [1.1,](#page-1-0) the last key ingredient needed is the observation that the cap is modeled on the Bryant soliton in cases (2), (3) above. This fact follows from the classification result (cf. Theorem [4.7\)](#page-43-0) of any asymptotically cylindrical Ricci steady soliton conifold with the curvature condition PIC2, which is a generalization of the celebrated work of S. Brendle [\[3\]](#page-72-0). On the other hand, if one considers the Ricci flow associated with a Ricci shrinker close to the cylinder, we show that locally the Ricci flow almost preserves the nonnegativity of some curvature conditions (cf. Theorem [5.4\)](#page-48-0) defined by S. Brendle. By analyzing the geometry along the gradient flow of *f* , one can show that the blowup limit near the cap region must have the PIC2 condition. Consequently, the blowup limit must be a steady soliton conifold with PIC2 condition, which can be classified and can only be the Bryant soliton. Therefore, the cap regions are modeled on Bryant solitons. In conclusion, for a Ricci shrinker sufficiently close to a cylinder, each point lies in a region either  $\epsilon$ -close to the cylinder or the Bryant soliton. Roughly speaking, this means that the shrinker itself is  $\epsilon$ -symmetric (cf. Definition [B.1,](#page-68-1) Definition [B.3](#page-69-0) or Definition [B.4](#page-70-0) for precise definitions). Therefore, we have collected sufficient technical preparation to apply the symmetry improvement argument of S. Brendle et al.

This paper is organized as follows. In Section 2, we discuss some basic properties for Ricci shrinkers and the associated Ricci flows. In Section 3, we obtain all the necessary technical estimates on the neck region. Section 4 focuses on the cap region and shows that it can be modeled on a Ricci steady soliton conifold. As a conclusion of the estimates in Section 3 and Section 4, we prove Theorem [1.2](#page-3-1) at the end of Section 4. In Section 5, we prove Theorem [1.1.](#page-1-0) In the last section, we discuss possible generalizations of our theorems.

## <span id="page-6-0"></span>2 Preliminaries

For any Ricci shrinker  $(M^n, g, f)$ , the scalar curvature  $R \ge 0$  by [\[17,](#page-73-11) Corollary 2.5]. Moreover, it follows from the strong maximum principle that  $R > 0$  unless  $(M, g)$  is the Gaussian soliton.

We recall the following fundamental estimate of the potential function *f* .

**Lemma 2.1** ([\[14\]](#page-73-8) [\[33\]](#page-74-10)). *Let*  $(M^n, g, f)$  *be a Ricci shrinker. Then there exists a point*  $p \in M$  *where f attains its infimum and f satisfies the quadratic growth estimate*

$$
\frac{1}{4} (d(x, p) - 5n)^2 + \le f(x) \le \frac{1}{4} (d(x, p) + \sqrt{2n})^2
$$

*for all*  $x \in M$ *, where*  $a_+ := \max\{0, a\}$ *.* 

For any Ricci shrinker  $(M^n, g, f)$  with the normalization [\(1.1\)](#page-1-2), the entropy is defined as

$$
\mu = \mu(g) \coloneqq \log \int \frac{e^{-f}}{(4\pi)^{n/2}} \, dV.
$$

We remark that  $e^{\mu}$  is comparable to the volume of the unit ball  $B(p, 1)$ , see [\[44,](#page-74-5) Lemma 2.5].

Next we recall the following identities and elliptic equations on Ricci shrinkers (see [\[59\]](#page-75-7) [\[53\]](#page-75-12)):

Here, the weighted Laplacian  $\Delta_f := \Delta - \langle \nabla f, \nabla \cdot \rangle$ .

We will only consider the case that  $\Sigma(t) = \Sigma(t, s) \cap \{x \in M \mid f(x) = t\}$ . Notice that  $\Sigma(t, \infty)$  can be either compact or non-compact and it represents a cap or an end of the Ricci shrinker, respectively.

For the rest of the paper, we will mainly focus on  $\Sigma(t)$  when *t* is a noncritical value of *f*. Also, we omit *t* in  $\Sigma(t)$ , if there is no confusion.

On Σ, we denote the unit normal vector  $|\nabla f|^{-1} \nabla f$  by  $e_n$  and assume  $\{e_1, e_2, \dots, e_n\}$  is a local orthonormal frame such that  $\{e_1, \dots, e_{n-1}\}$  are tangent to  $\Sigma$ . By using the same convention as in [\[53\]](#page-75-12), we use subscript *n* to denote  $e_n$  and  $a, b, c, d, \cdots$  to denote all tangential directions.

We have the following estimates of the curvature along the normal direction. The proof follows from direct calculations based on [\(2.1\)](#page-6-1)-[\(2.4\)](#page-6-2).

<span id="page-6-5"></span>**Proposition 2.2.** *For any Ricci shrinker*  $(M^n, g, f)$  *such that*  $R \leq \frac{3}{4}$  $\frac{3}{4}f$  on a level set  $\Sigma$  of f, the *following estimates hold on* Σ*.*

$$
|R_{an}| \leq C f^{-\frac{1}{2}} |\nabla R|,

|R_{ancn}| \leq C f^{-1} (|Rc| + |\nabla^2 Rc| + |Rc| |Rm|),
$$

*where*  $C = C(n) > 0$ *.* 

*Proof.* From [\(1.1\)](#page-1-2) and our assumption on *R*, we have  $|\nabla f| \geq \frac{1}{2} \sqrt{f}$ . We compute on  $\Sigma$ ,

$$
|R_{an}| = \frac{|Rc(e_a, \nabla f)|}{|\nabla f|} \le C f^{-\frac{1}{2}} |\langle \nabla R, e_a \rangle| \le C f^{-\frac{1}{2}} |\nabla R|.
$$

from  $(2.1)$ . Moreover, it follows from  $(2.1)$  and  $(2.3)$  that

$$
|R_{nn}| = |\nabla f|^{-2} |Rc(\nabla f, \nabla f)|
$$
  
\n
$$
\leq C f^{-1} |\langle \nabla R, \nabla f \rangle|
$$
  
\n
$$
= C f^{-1} |\Delta R - R + 2|Rc|^2|
$$
  
\n
$$
\leq C f^{-1} (R + |Rc|^2 + |\nabla^2 R|).
$$

Similarly, we compute from [\(2.2\)](#page-6-4),

$$
|R_{abcn}| \le |\nabla f|^{-1} |R_{abcl}f_l| \le C f^{-\frac{1}{2}} |\nabla Rc|.
$$

For the last inequality, we have

$$
|R_{ancn}| \le |\nabla f|^{-2} |R_{akcl} f_k f_l|
$$
  
\n
$$
\le C f^{-1} |(\nabla_k R_{ac} - \nabla_a R_{kc}) f_k|
$$
  
\n
$$
= C f^{-1} |\nabla_k R_{ac} f_k - \nabla_a (R_{kc} f_k) + R_{kc} f_{ka}|
$$
  
\n
$$
= C f^{-1} |\Delta R_{ac} - R_{ac} + 2R_{akcl} R_{kl} - \nabla_{ac}^2 R/2 + R_{kc} (g_{ka}/2 - R_{ka})|
$$
  
\n
$$
= C f^{-1} |2R_{akcl} R_{kl} - R_{kc} R_{ka} - R_{ac}/2 + \Delta R_{ac} - \nabla_{ac}^2 R/2|
$$
  
\n
$$
\le C f^{-1} (|Rc| + |\nabla^2 Rc| + |Rc| |Rm|).
$$

In sum, the proof is complete.  $\Box$ 

As in [\[53\]](#page-75-12), we define the following tensors on  $\Sigma$ :

$$
\mathring{Rc}_{\Sigma} = \mathring{R}_{ab} := R_{ab} - \frac{1}{n-1} R g_{ab},\tag{2.5}
$$

$$
U = U_{abcd} := \frac{1}{(n-1)(n-2)} R(g_{ac}g_{bd} - g_{ad}g_{bc}),
$$
\n(2.6)

$$
\stackrel{\circ}{Rm}_{\Sigma} = \stackrel{\circ}{R}_{abcd} := R_{abcd} - U_{abcd},\tag{2.7}
$$

$$
V = V_{abcd} := \frac{1}{n-3} \left( \overset{\circ}{R}_{ac} g_{bd} + \overset{\circ}{R}_{bd} g_{ac} - \overset{\circ}{R}_{ad} g_{bc} - \overset{\circ}{R}_{bc} g_{ad} \right), \tag{2.8}
$$

$$
W = W_{abcd} := R_{abcd} - U_{abcd} - V_{abcd}.
$$
\n
$$
(2.9)
$$

Notice that all tensors  $\mathbb{R}_{C_{\Sigma}}^{\circ}$ , *U*,  $\mathbb{R}_{m_{\Sigma}}^{\circ}$ , *V* and *W* can be extended to tensors on Σ(*s*, *t*) by requiring they vanish on the normal direction  $e_n$ . By this convention, all tensors can be written in a coordinate-free form. For instance, we have

$$
\mathring{Rc}_{\Sigma} = Rc - \frac{R}{n-1}g - T
$$
\n(2.10)

where

$$
T := \frac{1}{2|\nabla f|^2} (dR \otimes df + df \otimes dR) - \left( \frac{R}{(n-1)|\nabla f|^2} + \frac{Rc(\nabla f, \nabla f)}{|\nabla f|^4} \right) df \otimes df.
$$
 (2.11)

Next, we have the following lower bound estimate of the scalar curvature, which essentially follows from [\[19,](#page-73-12) Theorem 1].

<span id="page-8-0"></span>**Proposition 2.3.** *For any Ricci shrinker*  $(M^n, g, f)$ *, suppose*  $\bar{t} \geq 2n$  *and* 

<span id="page-8-1"></span>
$$
\min_{\Sigma(\bar{t})} \frac{Rf}{1 + nf^{-1}} = \alpha > 0.
$$

*Then for any*  $x \in \Sigma(\overline{t}, \infty)$ *,* 

$$
R(x)f(x) \ge \frac{R(x)f(x)}{1 + nf^{-1}(x)} \ge \alpha.
$$

*Proof.* We define  $\phi = R - \alpha f^{-1} - \alpha n f^{-2}$ . Then it follows from direct computations, see [\[19,](#page-73-12) Equation (6)] for details, that on  $\Sigma(\bar{t}, \infty)$ 

$$
\Delta_f \phi \le \phi - \alpha n f^{-3} \left(\frac{f}{2} - n\right) - \alpha f^{-4} (2f + 6n) |\nabla f|^2 \le \phi
$$

since  $f \geq \overline{t} \geq 2n$ . By our assumption,  $\phi \geq 0$  on the boundary  $\Sigma(\overline{t})$ . If  $\Sigma(\overline{t}, \infty)$  is compact, then we conlude that  $\phi \ge 0$  on  $\Sigma(\bar{t}, \infty)$  from the maximum principle. If  $\Sigma(\bar{t}, \infty)$  is non-compact, the maximum principle also applies since  $\liminf_{x\to\infty} \phi(x) \ge 0$  from its definition.

In sum, we have proved that on  $\Sigma(\bar{t}, \infty)$ ,

$$
\frac{Rf}{1 + nf^{-1}} \geq \alpha
$$

and the proof is complete.  $\Box$ 

### Ricci flow associated with a Ricci shrinker

Recall that any Ricci shrinker  $(M^n, g, f)$  can be regarded as a self-similar solution of the Ricci flow. Let  $\psi^t : M \to M$  be a family of diffeomorphisms generated by  $X(t) = \frac{1}{1-t^2}$  $\frac{1}{1-t}\nabla f$ , and  $\psi^0 = \text{id}$ . In other words, we have

$$
\frac{\partial}{\partial t}\psi^t(x) = \frac{1}{1-t}\nabla f\left(\psi^t(x)\right). \tag{2.12}
$$

It is well known that the rescaled pull-back metric  $g(t) := (1 - t)(\psi^t)^* g$  satisfies the Ricci flow equation

$$
\partial_t g = -2Rc(g(t))
$$

for any −∞ < *t* < 1. In particular, *g*(0) = *g*. For any Ricci shrinker, the associated Ricci flow is implicitly understood.

**Example 2.4** (Round cylinder). *The round cylinder* ( $S^{n-1} \times \mathbb{R}$ ,  $g_c$ ) *is a Ricci shrinker where the scalar curvature is identically*  $\frac{n-1}{2}$  *and the potential function*  $f_c = \frac{z^2}{4}$  $\frac{z^2}{4} + \frac{n-1}{2}$  $\frac{1}{2}$ , where *z* is the *coordinate in the*  $\mathbb{R}$ -factor. The associated Ricci flow is  $\{(S^{n-1} \times \mathbb{R}, g_c(t)), -\infty < t < 1\}$ , where

$$
g_c(t) = 2(n-2)(1-t)g_{S^{n-1}} + dz \otimes dz, \quad g_c(0) = g_c.
$$

Next, we have the following definition, which measures how close a parabolic neighborhood of a point in a Ricci flow is to the round cylinder, see also [\[58,](#page-75-13) Section 11.8].

<span id="page-9-1"></span>**Definition 2.5** (Center of an evolving  $\epsilon$ -neck). Let  $(M^n, g(t))$  be a Ricci flow solution and let  $(\bar{x}, \bar{t})$ *be a point in space-time with*  $R(\bar{x}, \bar{t}) = \frac{n-1}{2}r^{-2}$ . We say that  $(\bar{x}, \bar{t})$  is the center of an **evolving**  $\epsilon$ -neck  $S^{n-1} \times \mathbb{R}$  if, after rescaling the metric by the factor  $r^{-2}$ , the parabolic neighborhood  $B_{g(\bar{t})}(\bar{x}, \epsilon^{-1}r) \times$  $[\bar{t}-\epsilon^{-1}r^2,\bar{t}]$  is  $\epsilon$ -close in  $C^{[\epsilon^{-1}]}$ -topology to  $(S^{n-1}\times\mathbb{R},g_c(t))$ . The evolving neck is called an **evolving**  $\boldsymbol{p}$  *normalized*  $\boldsymbol{\epsilon}$ -neck, if we further require that  $|r - 1| < \boldsymbol{\epsilon}$ . For any Ricci shrinker  $(M^n, g, f)$ , we  $say \ x \in M$  *is the center of an evolving (normalized)*  $\epsilon$ -neck *if*  $(x, 0)$  *is the center of an evolving*  $(normalized) \in neck$ .

From the weak-compactness theory developed in [\[44\]](#page-74-5), we prove the following result.

<span id="page-9-0"></span>**Proposition 2.6.** *For any n and*  $\epsilon > 0$ *, there exists a constant*  $\eta_1 = \eta_1(\epsilon, n) > 0$  *satisfying the following property.*

*Suppose* (*M<sup>n</sup>* , *p*, *g*, *f*) *is a Ricci shrinker such that*

$$
d_{PGH}\left\{ (M^n, p, g), \left(S^{n-1} \times \mathbb{R}, p_c, g_c\right)\right\} < \eta_1,
$$

*then p is the center of an evolving normalized*  $\epsilon$ -neck.

*Proof.* Suppose otherwise, there exists a number  $\bar{\epsilon}$  and a sequence of Ricci shrinkers ( $M_i^n$ ,  $p_i$ ,  $g_i$ ,  $f_i$ ) such that

$$
\lim_{i\to 0} d_{PGH}\big\{(M_i^n, p_i, g_i), \left(S^{n-1}\times \mathbb{R}, p_c, g_c\right)\big\} = 0
$$

and  $p_i$  is not the center of an  $\bar{\epsilon}$ -neck. By Proposition 5.8 of [\[44\]](#page-74-5), the entropy  $\mu(g_i)$  is uniformly bounded from below. Using Theorem 1.1 of [\[44\]](#page-74-5), the above convergence can be improved to be in the smooth topology

$$
(M_i, p_i, g_i) \xrightarrow{C^{\infty}-Cheeger-Gromov} \left( S^{n-1} \times \mathbb{R}, p_c, g_c \right).
$$

From the definition of the Ricci flow associated with a Ricci shrinker, it is clear that the corresponding sequence of Ricci flows  $(M_i, p_i, g_i(t))_{t \leq 0}$  converges smoothly to  $(S^{n-1} \times \mathbb{R}, g_c(t))_{t \leq 0}$ . Therefore, we obtain a contradiction.

## <span id="page-10-0"></span>3 Estimates on the neck region

Throughout this section, we consider a Ricci shrinker  $(M^n, p, g, f)$  such that the following assumptions as in Theorem [1.2](#page-3-1) are satisfied.

$$
\begin{cases}\n|\nabla^i Rm| \leq BR^{\frac{1}{2}+1}, & \forall 0 \leq i \leq 4 \quad \text{on} \quad \Sigma(t_0, s); \\
R \leq \epsilon_1 f & \text{on} \quad \Sigma(t_0, s); \\
|\mathcal{R}m_{\Sigma}| \leq \epsilon_1'R & \text{on} \quad \Sigma(t_0); \\
|R - \frac{n-1}{2}| \leq \epsilon_1' & \text{on} \quad \Sigma(t_0); \\
(1 - \delta_0)s \geq t_0 \geq n\epsilon_1^{-1}; \\
\mu(g) \geq -A; \\
\Sigma(t_0) \text{ is diffeomorphic to } S^{n-1}.\n\end{cases} \tag{\dagger}
$$

Moreover, we set

$$
\epsilon_0 := \max{\{\epsilon'_1, \epsilon_1^{\frac{1}{2}}\}}.
$$
\n
$$
(3.1)
$$

Here, we assume  $0 < \delta_0 < 1$  and  $A, B \ge 1$ . With fixed  $n, \delta_0, A$  and  $B$ , we regard  $\epsilon_1$  and  $\epsilon'_1$  as two small positive parameters. In addition, the constant *s* can be finite or ∞. Notice that for the round cylinder  $S^{n-1} \times \mathbb{R}$ , ([†](#page-10-0)) is satisfied for any  $\epsilon_1$  and  $\epsilon'_1$  provided that  $t_0$  is sufficiently large. In the following analysis, we set

$$
E := \Sigma(t_0, s) \tag{3.2}
$$

and use the notation  $\phi_1 = O(\phi_2)$  if  $|\phi_1| \le C |\phi_2|$  for some constant  $C = C(n, A, B) > 0$ .

One important consequence of  $\mu(g) \geq -A$  is the following no-local-collapsing result from [\[48\]](#page-75-6).

<span id="page-10-5"></span>**Theorem 3.1.** ([\[48,](#page-75-6) Theorem 22]) *For any Ricci shrinker*  $(M^n, g, f)$  *with*  $\mu(g) \geq -A$ *, there exists a*  $\kappa = \kappa(n, A) > 0$  *such that for any*  $B(q, r) \subset M$  *with*  $R \leq r^{-2}$ *, we have* 

$$
|B(q,r)| \ge \kappa r^n.
$$

We next prove

<span id="page-10-4"></span>Lemma 3.2. *On E, we have*

$$
Rf \ge t_0,\tag{3.3}
$$

$$
|R_{an}|, |R_{abcn}| = O(f^{-\frac{1}{2}}R^{\frac{3}{2}}), \tag{3.4}
$$

$$
|R_{nn}|, |R_{ancn}| = O(f^{-1}R(1+R)).
$$
\n(3.5)

*Proof.* The inequality [\(3.3\)](#page-10-1) follows immediately from Proposition [2.3,](#page-8-0) since by ([†](#page-10-0)),

$$
\inf_{\Sigma(t_0)} \frac{Rf}{1 + nf^{-1}} \ge \frac{(\frac{n-1}{2} - \epsilon_1')t_0}{1 + nt_0^{-1}} \ge t_0.
$$

The equations [\(3.4\)](#page-10-2) and [\(3.5\)](#page-10-3) follow from Proposition [2.2](#page-6-5) and ([†](#page-10-0)).

The next lemma follows from Lemma [3.2](#page-10-4) and direct calculations from the definition [\(2.5\)](#page-7-2).

|Rc|^2 = |Rc_{\Sigma}|^2 + \frac{R^2}{n-1} + O(f^{-1}R^2(1+R)),

\langle U, V \rangle, \langle V, W \rangle, \langle W, U \rangle = O(f^{-1}R^2(1+R)),
$$
  
\n
$$
|U|^2 = \frac{2}{(n-1)(n-2)}R^2,
$$
  
\n
$$
|V|^2 = \frac{4}{n-3}|Rc_{\Sigma}|^2 + O(f^{-1}R^2(1+R)),
$$
  
\n
$$
|Rm|^2 = |Rm_{\Sigma}|^2 + \frac{2}{(n-1)(n-2)}R^2 + O(f^{-1}R^2(1+R)),
$$
  
\n
$$
|Rm|^2 = |U|^2 + |V|^2 + |W|^2 + O(f^{-1}R^2(1+R)).
$$

<span id="page-11-3"></span>**Proposition 3.4.** *Under the assumption* ([†](#page-10-0))*, there exists*  $\sigma_1 = \sigma_1(n, B) > 0$  *such that* 

<span id="page-11-4"></span>
$$
|\stackrel{\circ}{Rm}_{\Sigma}| = O(\epsilon_0 R) \tag{3.6}
$$

*on E* if  $\epsilon_0 \leq \sigma_1$ *.* 

*Proof.* In the proof, all constants  $c_i$ ,  $i = 1, 2, \cdots$  are positive and depend only on *n* and *B*. We define  $s_0 \in [t_0, s]$  to be the largest number such that

$$
\frac{|Rm_{\Sigma}|^2}{R^2} \leq \tau \epsilon_0^2
$$

on  $\Sigma(t_0, s_0)$ , where  $\tau > 1$  is a large constant to be determined later. By the assumption ([†](#page-10-0)), we have

<span id="page-11-5"></span>
$$
|\overset{\circ}{Rm}_{\Sigma}|\leq \epsilon_1'R
$$

on  $\Sigma(t_0)$  and hence  $s_0 > t_0$  as  $\epsilon_0 \ge \epsilon'_1$ . If  $s_0 = s$ , then the conclusion follows. Otherwise, we assume  $s_0 < s$ .

Following [\[53\]](#page-75-12), we define

$$
G := \frac{|Rm|^2}{R^2} - \frac{2}{(n-1)(n-2)} = \frac{|\stackrel{\circ}{Rm}E|^2}{R^2} + O(f^{-1}(1+R))
$$
  

$$
= \frac{|\stackrel{\circ}{Rm}E|^2}{R^2} + O(t_0^{-1} + \epsilon_1) = \frac{|\stackrel{\circ}{Rm}E|^2}{R^2} + O(\epsilon_0^2).
$$
 (3.7)

where the equalities follow from Lemma [3.3](#page-11-0) and ([†](#page-10-0)). Therefore, there exists  $s_1 \in (t_0, s_0]$  such that

<span id="page-11-2"></span>
$$
\max_{\Sigma(t_0, s_0)} G = \max_{\Sigma(s_1)} G \in [\frac{\tau}{2} \epsilon_0^2, 2\tau \epsilon_0^2].
$$
\n(3.8)

It follows from a direct calculation, see [\[53,](#page-75-12) (4.10),(4.11)] for details, that

<span id="page-11-1"></span>
$$
\Delta_f G \ge -2\langle \nabla G, \nabla \log R \rangle + 4R^{-3}P,\tag{3.9}
$$

where

$$
P := -2RR_{ijkl}R_{piqk}R_{pjql} - \frac{1}{2}RR_{ijkl}R_{ijpq}R_{pqkl} + |Rm|^2|Rc|^2.
$$

By similar calculations as [\[53,](#page-75-12) (4.16)] and our assumptions, we obtain

$$
P \ge \frac{1}{n-1} R^2 |W|^2 + \frac{4}{(n-1)(n-2)(n-3)} R^2 |R_{C\Sigma}^{\circ}|^2 - \frac{5}{2} R |W|^3
$$
  
 
$$
-\frac{8}{(n-3)^2} R |R_{C\Sigma}^{\circ}|^3 - \frac{6}{n-3} R |W| |R_{C\Sigma}^{\circ}|^2 - c_1 f^{-1} R^4 (1+R). \tag{3.10}
$$

From Lemma [3.3,](#page-11-0) we obtain on  $\Sigma(t_0, s_0)$  that

$$
|W|^2 + \frac{4}{n-3}|R_{C\Sigma}^{\circ}|^2 = |R_{C\Sigma}^{\circ}|^2 + O(f^{-1}R^2(1+R)) \le \tau \epsilon_0^2 R^2 + O((t_0^{-1} + \epsilon_1)R^2) \le c_2 \epsilon_0^2 R^2. \tag{3.11}
$$

Now, it follows from [\(3.10\)](#page-12-0) and [\(3.11\)](#page-12-1) that

$$
P \ge \left(\frac{1}{n-1} - c_3 \epsilon_0\right) R^2 |W|^2 + \left(\frac{4}{(n-1)(n-2)(n-3)} - c_3 \epsilon_0\right) R^2 |Rc_2|^2 - c_3 f^{-1} R^4 (1+R). \tag{3.12}
$$

Therefore, if  $\epsilon_0$  is sufficiently small, we obtain

$$
P \ge c_4 R^2 |Rm_E|^2 - c_5 f^{-1} R^4 (1 + R).
$$

It follows from [\(3.9\)](#page-11-1) and [\(3.12\)](#page-12-2) that

$$
\Delta_f G \ge -2\langle \nabla G, \nabla \log R \rangle + 4c_4 RG - 4c_5 f^{-1}R(1+R). \tag{3.13}
$$

If we denote the Laplacian and inner product on the level set  $\Sigma$  by  $\Delta_{\Sigma}$  and  $\langle , \rangle_{\Sigma}$  respectively, then

$$
\Delta G = \Delta_{\Sigma} G + G_{nn} + H G_n,
$$

where  $H := \text{Tr}_{\Sigma} \frac{\nabla^2 f}{|\nabla f|}$  $\frac{\nabla^2 f}{|\nabla f|}$  is the mean curvature of the level set Σ. From the fact that  $|\nabla^i Rm| \leq BR^{\frac{1}{2}+1}$  for  $0 \le i \le 4$ , the term  $G_{nn}$  can be estimated as (see [\[53,](#page-75-12) (4.26)] for details)

$$
G_{nn} \le c_6 f^{-1} (1+R) |\langle \nabla G, \nabla f \rangle| + O(f^{-1}R(1+R)). \tag{3.14}
$$

Since

$$
H = \frac{\Delta f - f_{nn}}{|\nabla f|} = \frac{\frac{n-1}{2} - R + R_{nn}}{|\nabla f|} = \frac{\frac{n-1}{2} - R + O(f^{-1}R(1+R))}{|\nabla f|}
$$

we have

$$
HG_n = O(f^{-1}(1+R)|\langle \nabla G, \nabla f \rangle|). \tag{3.15}
$$

<span id="page-12-6"></span><span id="page-12-5"></span><span id="page-12-4"></span><span id="page-12-3"></span>,

Moreover,

$$
\langle \nabla G, \nabla \log R \rangle = \langle \nabla G, \nabla \log R \rangle_{\Sigma} + \frac{1}{|\nabla f|^2} \langle \nabla G, \nabla f \rangle \langle \nabla \log R, \nabla f \rangle
$$
  
=\langle \nabla G, \nabla \log R \rangle\_{\Sigma} + O(f^{-1}(1+R)) |\langle \nabla G, \nabla f \rangle| \t(3.16)

since  $\langle \nabla \log R, \nabla f \rangle = 2R^{-1}Rc(\nabla f, \nabla f) = O(R^{-1}fR_{nn}) = O(1 + R).$ 

Combining [\(3.13\)](#page-12-3), [\(3.14\)](#page-12-4), [\(3.15\)](#page-12-5) and [\(3.16\)](#page-12-6), we derive on  $\Sigma(t_0, s_0)$  that

$$
\Delta_{\Sigma} G \ge \langle \nabla G, \nabla f \rangle - c_7 f^{-1} (1+R) |\langle \nabla G, \nabla f \rangle| - 2 \langle \nabla G, \nabla \log R \rangle_{\Sigma} + c_8 RG - c_7 f^{-1} R (1+R). \tag{3.17}
$$

By our assumption, there exists a point  $z \in \Sigma(s_1)$  such that

$$
G(z) = \max_{\Sigma(s_1)} G = \max_{\Sigma(t_0, s_0)} G \in [\frac{\tau}{2} \epsilon_0^2, 2\tau \epsilon_0^2].
$$

From [\(3.17\)](#page-13-0) and the maximum principle, we conclude at *z* that

$$
0 \ge \langle \nabla G, \nabla f \rangle - c_7 f^{-1} (1 + R) |\langle \nabla G, \nabla f \rangle| + c_8 RG - c_7 f^{-1} R (1 + R).
$$

Since  $\langle \nabla G, \nabla f \rangle \ge 0$  at *z*, we have

<span id="page-13-0"></span>
$$
G \le c_9 f^{-1} (1+R)
$$

at *z*. Therefore, it follows from [\(3.8\)](#page-11-2) that

$$
\frac{\tau}{2}\epsilon_0^2 \le G(z) \le c_9 f^{-1}(1+R) \le c_{10}\epsilon_0^2,
$$

where for the last inequality we have used  $t_0 \ge n\epsilon_1^{-1}$  and hence  $t_0^{-1} = O(\epsilon_0^2)$ . However, it contradicts our assumption ([†](#page-10-0)) if  $\tau$  is sufficiently large.

Remark 3.5. *From the proof of Proposition [3.4,](#page-11-3) we have shown that on E*

$$
|Rm_{\Sigma}|\leq C\epsilon_0 R
$$

<span id="page-13-3"></span>◦

*for some constant C depending only on n and B.*

Next, we prove

<span id="page-13-2"></span>Lemma 3.6. *With the same assumptions above, we have on E,*

$$
\begin{cases}\n|\stackrel{\circ}{RC_{\Sigma}}| = O(\epsilon_0 R), \\
|\nabla \stackrel{\circ}{RC_{\Sigma}}| = O(\epsilon_0^{\frac{1}{2}} R^{\frac{3}{2}}), \\
|\nabla^2 \stackrel{\circ}{RC_{\Sigma}}| = O(\epsilon_0^{\frac{1}{3}} R^2).\n\end{cases} (3.18)
$$

*Proof.* In the proof, all constants  $C_i$ ,  $i = 1, 2, \cdots$  are positive and depend only on *n*, *A* and *B*.

From the definition of  $\mathring{R}_{c_{\Sigma}}$ , we obtain

$$
\overset{\circ}{R}_{ac} = \sum_{k=1}^{n-1} \overset{\circ}{R}_{akck} + R_{ancn}.
$$

Therefore, it follows from [\(3.5\)](#page-10-3) and [\(3.6\)](#page-11-4) that

$$
|\stackrel{\circ}{Rc_{\Sigma}}| = O(\epsilon_0 R) + O(f^{-1}R(1+R)) = O(\epsilon_0 R). \tag{3.19}
$$

In addition, we have

<span id="page-14-0"></span>
$$
\begin{cases}\n|\nabla \mathring{Rc}_{\Sigma}| = O(R^{\frac{3}{2}}),\\ \n|\nabla^2 \mathring{Rc}_{\Sigma}| = O(R^2),\\ \n|\nabla^3 \mathring{Rc}_{\Sigma}| = O(R^{\frac{5}{2}}).\n\end{cases}
$$
\n(3.20)

Indeed, it follows from  $(2.10)$  and  $(\dagger)$  that

$$
|\nabla \hat{Rc}_{\Sigma}| = O(|\nabla Rc|) + O(f^{-1}|\nabla R|(1+R)) + O(f^{-\frac{1}{2}}|\nabla^2 R|) + O(f^{-\frac{1}{2}}|Rc|(1+R))
$$
  
=  $O(R^{\frac{3}{2}}) + O(f^{-1}R^{\frac{3}{2}}(1+R)) + O(f^{-\frac{1}{2}}R^2) + O(f^{-\frac{1}{2}}R(1+R)) = O(R^{\frac{3}{2}}).$ 

Here, we have used [\(3.3\)](#page-10-1). The other two equalities in [\(3.20\)](#page-14-0) can be proved similarly by using  $|\nabla^i Rm| \leq BR^{\frac{i}{2}+1}$  for  $0 \leq i \leq 4$ .

For any  $q \in E$ , we set  $R(q) = r^{-2}$  and  $r_1 = C_1^{-1}r$  for a large constant  $C_1 > 1$  determined later. Case 1:  $B(q, 2r_1) \cap \Sigma(s) = \emptyset$ .

From the fact that  $|\nabla R|^2 = O(R^3)$ , we may assume that  $C_1$  is large enough so that

$$
C_1^{-1}r^{-2} \le R \le C_1r^{-2}
$$

on  $B(q, 2r_1)$ . It follows from Theorem [3.1](#page-10-5) and the Bishop-Gromov volume comparison that

$$
C_2^{-1} \le \frac{|B(q, r_1)|}{r_1^n} \le C_2
$$

for some  $C_2 > 1$ . By the standard interpolation inequality (see [\[30,](#page-74-11) Theorem 7.28]) that for any  $\epsilon > 0$ 

$$
\left(\int_{B(q,r_1)} |\nabla \overset{\circ}{R_{C_{\Sigma}}} |^{2} r_{1}^{6-n} dV\right)^{\frac{1}{2}} \n\leq \epsilon \left(\int_{B(q,r_1)} |\overset{\circ}{R_{C_{\Sigma}}} |^{2} r_{1}^{4-n} dV + \int_{B(q,r_1)} |\nabla \overset{\circ}{R_{C_{\Sigma}}} |^{2} r_{1}^{6-n} dV + \int_{B(q,r_1)} |\nabla^{2} \overset{\circ}{R_{C_{\Sigma}}} |^{2} r_{1}^{8-n} dV\right)^{\frac{1}{2}} \n+ C_{3} \epsilon^{-1} \left(\int_{B(q,r_1)} |\overset{\circ}{R_{C_{\Sigma}}} |^{2} r_{1}^{4-n} dV\right)^{\frac{1}{2}} \leq C_{4} \epsilon + C_{4} \epsilon^{-1} \epsilon_{0},
$$

where we have used [\(3.19\)](#page-13-1) and [\(3.20\)](#page-14-0). Plugging  $\epsilon = \epsilon_0^{\frac{1}{2}}$  into the above inequality, we obtain

$$
\int_{B(q,r_1)} |\nabla \stackrel{\circ}{R_{C\Sigma}}|^2 \, dV \le 2C_4 \epsilon_0 r_1^{n-6}.\tag{3.21}
$$

Since  $|\nabla^2 \hat{Rc}_\Sigma| \le C_5 r_1^{-4}$  by [\(3.20\)](#page-14-0), it follows from mean value formula and [\(3.21\)](#page-14-1) that

<span id="page-14-1"></span>
$$
|\nabla \overset{\circ}{Rc_{\Sigma}}| \leq C_6 \epsilon_0^{\frac{1}{2}} r_1^{-3}.
$$

In other words, we have proved that  $|\nabla \hat{Rc}_{\Sigma}| = O(\epsilon_0^{\frac{1}{2}} R^{\frac{3}{2}})$ . The estimate of  $|\nabla^2 \hat{Rc}_{\Sigma}|$  can be proved similarly.

Case 2:  $B(q, 2r_1) \cap \Sigma(s) \neq \emptyset$ .

In this case, there exists  $q' \in \Sigma(s)$  which can be connected by a shortest geodesic in *E* from *q* to  $q'$  such that its length is smaller than  $2r_1$ . From  $|\nabla R|^2 = O(R^3)$ ,  $R(q')$  is almost equal to  $r^{-2}$ , if  $C_1$  is sufficiently large.

Next, we denote the induced metric on  $\Sigma(s)$  by  $g_{\Sigma}$  and define  $\delta_1 > 0$  to be the largest number such that  $R \le 2r^{-2}$  on  $\Omega := B_{g_{\Sigma}}(q', \delta_1 r)$ . In addition, we define  $\rho = 2\sqrt{f}$  and  $\phi_t$  to be the family of diffeomorphisms generated by  $\nabla \rho / |\nabla \rho|^2$ .

Now we define a map

$$
\Phi : \Omega \times (-\delta_2 r, 0] \longrightarrow E
$$

by  $\Phi(z, t) = \phi_t(z)$ . We claim that there exists  $C_7 > 1$  such that  $\delta_2 \ge C_7^{-1}$  and  $\Phi^* g$  is close to  $\overline{g}$  :=  $g_{\Sigma}$  +  $dt^2$  in  $C^2$  sense. More precisely,

<span id="page-15-2"></span><span id="page-15-0"></span>
$$
|\Phi^* g - \bar{g}|_{C^k(\bar{g})} = O(\epsilon_1^{\frac{1}{2}} r^{-k})
$$
\n(3.22)

for  $k = 0, 1, 2$ . We only prove the case  $k = 0$ , and the other cases are similar. We first compute for any  $t \in (-\delta_2 r, 0]$ ,

$$
\Phi^* g(\partial_t, \partial_t) = \frac{1}{|\nabla \rho|^2} = \frac{f}{|\nabla f|^2} = 1 + \frac{R}{f - R} = 1 + O(\epsilon_1). \tag{3.23}
$$

Next, we set *g*(*t*) to be  $\Phi^* g$  restricted on  $\Omega \times \{t\}$ . From our definition of  $\phi_t$ , we compute

$$
\partial_t g(t) = \frac{2\sqrt{f}}{|\nabla f|^2} \nabla^2 f = \frac{2\sqrt{f}}{|\nabla f|^2} (g(t) - 2Rc) = O(f^{-\frac{1}{2}}R).
$$

By integration, we have for any  $t \in (-\delta_2 r, 0]$ ,

<span id="page-15-1"></span>
$$
|g(t) - g_{\Sigma}| = O(\delta_2 r f^{-\frac{1}{2}} R) = O(\epsilon_1^{\frac{1}{2}}),
$$
\n(3.24)

where for the last equality we have used  $|\nabla R|^2 = O(R^3)$  and [\(3.23\)](#page-15-0). Combining [\(3.23\)](#page-15-0) and [\(3.24\)](#page-15-1), [\(3.22\)](#page-15-2) is proved.

From [\(3.22\)](#page-15-2), it follows that *g* is almost a product metric on a neighborhood of  $\Sigma(s)$ . By  $|\nabla R|^2 =$  $O(R^3)$  again, there exists  $C_8 > 1$  such that  $\delta_1 \ge C_8^{-1}$ . Moreover, we can guarantee that  $B(q, 2r_1) \cap E \subset$  $\Phi(\Omega \times (-\delta_2 r, 0)).$ 

Therefore, the rest of the proof can be done similarly to Case 1 by considering a product neighborhood of *q* with size  $r_1$  instead.

Next, we prove that the scalar curvature is almost constant on any level set contained in *E*. We first prove

<span id="page-15-3"></span>**Lemma 3.7.** *With the same assumptions above, on any level set*  $\Sigma$  *of f contained in E, we have* 

$$
|\nabla_{\Sigma}R|=O(\epsilon_0^{\frac{1}{2}}R^{\frac{3}{2}}).
$$

*Proof.* Recall the decomposition of *Rc* from [\(2.10\)](#page-7-3). Direct calculation implies

$$
\frac{1}{2}\nabla_a R = \sum_{b=1}^{n-1} \nabla_b R_{ab} + \nabla_n R_{an}
$$
  
\n
$$
= \sum_{b=1}^{n-1} \nabla_b \left( \overset{\circ}{R}_{ab} + \frac{R}{n-1} g_{ab} + T_{ab} \right) + \nabla_n R_{an}
$$
  
\n
$$
= \sum_{b=1}^{n-1} \left( \nabla_b \overset{\circ}{R}_{ab} + \nabla_b T_{ab} \right) + \frac{\nabla_a R}{n-1} + \nabla_n R_{an}.
$$

Therefore, we obtain

$$
\frac{n-3}{2(n-1)}\nabla_a R = \sum_{b=1}^{n-1} \left( \nabla_b \overset{\circ}{R}_{ab} + \nabla_b T_{ab} \right) + \nabla_n R_{an}.
$$
 (3.25)

It is clear from the definition that

<span id="page-16-0"></span>
$$
\nabla_b T_{ab} = \frac{f_{ab} \nabla_b R}{|\nabla f|^2} = \frac{(g_{ab}/2 - R_{ab}) \nabla_b R}{|\nabla f|^2}.
$$

Since 
$$
R_{ab} = \overset{\circ}{R}_{ab} + \frac{R}{n-1}g_{ab} = \frac{R}{n-1}g_{ab} + O(\epsilon_0 R)
$$
, we have  
\n
$$
\sum_{b=1}^{n-1} \nabla_b T_{ab} = \frac{1}{|\nabla f|^2} \left( \frac{\nabla_a R}{2} - \frac{R \nabla_a R}{n-1} + O(\epsilon_0 R^{\frac{5}{2}}) \right)
$$
\n
$$
= O(f^{-1} R^{\frac{3}{2}} (1 + R)) + O(\epsilon_0 f^{-1} R^{\frac{5}{2}}) = O(\epsilon_0 R^{\frac{3}{2}}).
$$
\n(3.26)

Moreover, we compute

$$
\nabla_n R_{an} = \frac{\langle \nabla R_{an}, \nabla f \rangle}{|\nabla f|} = \frac{\Delta R_{an} - R_{an} + 2R_{aknl} R_{kl}}{|\nabla f|}
$$

$$
= O(f^{-\frac{1}{2}} R^2) + O(f^{-1} R^{\frac{3}{2}}) = O(\epsilon_0 R^{\frac{3}{2}}).
$$
(3.27)

Combining [\(3.25\)](#page-16-0),[\(3.26\)](#page-16-1), [\(3.27\)](#page-16-2) and Lemma [3.6,](#page-13-2) we immediately obtain

$$
|\nabla_a R| = O(\epsilon_0^{\frac{1}{2}} R^{\frac{3}{2}}).
$$

<span id="page-16-2"></span><span id="page-16-1"></span> $\Box$ 

<span id="page-16-3"></span>**Lemma 3.8.** With the same assumptions above, for any level set  $\Sigma$  contained in E and  $x, y \in \Sigma$ , we *have*

$$
\left|\frac{R(x)}{R(y)}-1\right|=O(\epsilon_0^{\frac{1}{2}}).
$$

*Moreover, the diameter of*  $\Sigma$  *is*  $O(R^{-\frac{1}{2}}(x))$ *.* 

*Proof.* For the second fundamental form *h* of Σ, we have

$$
h_{ab} = \frac{f_{ab}}{|\nabla f|} = \frac{\frac{g_{ab}}{2} - R_{ab}}{|\nabla f|} = O(f^{-\frac{1}{2}}(1+R))
$$

and hence the mean curvature

$$
H = \sum h_{aa} = O(f^{-\frac{1}{2}}(1 + R)).
$$

We denote the intrinsic Ricci curvature and scalar curvature of  $\Sigma$  by  $\tilde{R}_{ab}$  and  $\tilde{R}$ , respectively. It follows from the Gauss curvature equation that

$$
\tilde{R}_{ab} = R_{ab} - R_{anbn} + Hh_{ab} - h_{ac}h_{cb}
$$
  
=  $R_{ab} + O(f^{-1}R(1+R)) + O(f^{-1}(1+R)^2) = R_{ab} + O(\epsilon_0^2 R)$  (3.28)

where we have used  $(3.3)$  and  $(3.5)$ .

Similarly,

<span id="page-17-1"></span><span id="page-17-0"></span>
$$
\tilde{R} = R - R_{nn} + H^2 - |h|^2
$$
  
= R + O(\epsilon\_0^2 R). (3.29)

Combining [\(3.28\)](#page-17-0), [\(3.29\)](#page-17-1) and Lemma [3.6,](#page-13-2) we have

$$
\tilde{R}_{ab} = \frac{R}{n-1} g_{ab} + \stackrel{\circ}{R}_{ab} + O(\epsilon_0^2 R) \n= \frac{R}{n-1} g_{ab} + O(\epsilon_0 R) = \frac{\tilde{R}}{n-1} g_{ab} + O(\epsilon_0 \tilde{R}).
$$
\n(3.30)

Now we fix a point  $x \in \Sigma$  and set  $R(x) = r^{-2}$ . By Lemma [3.7,](#page-15-3) we have  $|\nabla_{\Sigma} R^{-\frac{1}{2}}| \le C_1 \epsilon_0^{\frac{1}{2}}$  and hence

$$
|R^{-\frac{1}{2}}(y) - r| \le C_1 L \epsilon_0^{\frac{1}{2}},\tag{3.31}
$$

provided that  $d_{\Sigma}(x, y) \le L$ . From [\(3.29\)](#page-17-1), [\(3.30\)](#page-17-2) and [\(3.31\)](#page-17-3), the proof of the Myers theorem indicates that

$$
\operatorname{diam}\Sigma=O(r)
$$

and hence by [\(3.31\)](#page-17-3),

$$
R(y) = \left(1 + O(\epsilon_0^{\frac{1}{2}})\right)r^{-2}.
$$

In sum, the proof is complete.

For later applications, we prove

<span id="page-17-4"></span>Lemma 3.9. *With the same assumptions above, we have on E,*

$$
|\Delta R| = O(\epsilon_0^{\frac{1}{3}} R^2).
$$

We shall estimate the different terms of the right-hand side of  $(3.32)$  separately.

Firstly, it is clear that

\nabla_{nn}^{2} R = \frac{\nabla^{2} R(\nabla f, \nabla f)}{|\nabla f|^{2}}
$$
\n
$$
= \frac{1}{|\nabla f|} \nabla_{n} \langle \nabla R, \nabla f \rangle - \frac{1}{|\nabla f|^{2}} \nabla^{2} f(\nabla R, \nabla f)
$$
\n
$$
= \frac{1}{|\nabla f|} \nabla_{n} \left( \Delta R - R + 2|Rc|^{2} \right) - \frac{1}{|\nabla f|^{2}} \left( \frac{\langle \nabla R, \nabla f \rangle}{2} - Rc(\nabla R, \nabla f) \right)
$$
\n
$$
= O(f^{-\frac{1}{2}} R^{\frac{3}{2}} (1 + R)) + O(f^{-1} R (1 + R)) = O(\epsilon_{0} R^{2}). \tag{3.33}
$$

Secondly, we move on to estimate  $\nabla_{aa}^2 R$ . It follows from [\(3.25\)](#page-16-0) that

$$
\frac{n-3}{2(n-1)}\nabla_{ca}^2 R = \sum_{b=1}^{n-1} \left( \nabla_c \nabla_b \overset{\circ}{R}_{ab} - \nabla_c \nabla_b T_{ab} \right) + \nabla_c \nabla_n R_{an}.
$$
 (3.34)

In light of [\(3.20\)](#page-14-0), we have

<span id="page-18-5"></span><span id="page-18-3"></span><span id="page-18-2"></span><span id="page-18-1"></span>
$$
|\nabla_c \nabla_b \overset{\circ}{R}_{ab}| = O(\epsilon_0^{\frac{1}{3}} R^2). \tag{3.35}
$$

Recall that *T* is defined in [\(2.11\)](#page-8-1). Direct calculation implies that

$$
|\nabla_c \nabla_b T_{ab}| = O(|\nabla f|^{-2} |\nabla R| |\nabla^3 f|) + O(|\nabla f|^{-2} |\nabla^2 R| |\nabla^2 f|) + O(|\nabla f|^{-2} |Rc| |\nabla^2 f|^2)
$$
  
=  $O(f^{-1} |\nabla R| |\nabla Rc|) + O(f^{-1} |\nabla^2 R|(1+R)) + O(f^{-1} |Rc|(1+R)^2)$   
=  $O(f^{-1}R^3) + O(f^{-1}R^2(1+R)) + O(f^{-1}R(1+R)^2) = O(\epsilon_0^2 R^2).$  (3.36)

Here, we have used the fact that some components of  $\nabla^2 T$  along the normal direction vanish. Furthermore, we compute

$$
\nabla_c \nabla_n R_{an} = \nabla_c \left( \frac{\langle \nabla R_{an}, \nabla f \rangle}{|\nabla f|} \right) = \nabla_c \left( \frac{\Delta R_{an} - R_{an} + 2R_{aknl} R_{kl}}{|\nabla f|} \right)
$$
  
=  $O(|\nabla f|^{-1} (|\nabla^3 Rc| + |\nabla Rc| + |\nabla Rm||Rm|) + O(|\nabla f|^{-2} |\nabla^2 f|(R + R^2))$   
=  $O(f^{-\frac{1}{2}} R^{\frac{3}{2}} (1 + R)) + O(f^{-1} R (1 + R)^2) = O(\epsilon_0 R^2).$  (3.37)

Combining [\(3.34\)](#page-18-1), [\(3.35\)](#page-18-2), [\(3.36\)](#page-18-3) and [\(3.37\)](#page-18-4), we obtain

<span id="page-18-6"></span><span id="page-18-4"></span>
$$
\nabla_{ca}^2 R = O(\epsilon_0^{\frac{1}{3}} R^2). \tag{3.38}
$$

Finally, it is clear that [\(3.32\)](#page-18-0) follows from the combination of [\(3.33\)](#page-18-5) and [\(3.38\)](#page-18-6). The proof of the lemma is complete. For later applications, we prove

Lemma 3.10. *With the same assumptions above, we have on E,*

|\Delta R_{ab}| = O(\epsilon_0^{\frac{1}{3}} R^2).
$$

*Proof.* By definition,

$$
\Delta R_{ab} = \Delta \left( \stackrel{\circ}{R}_{ab} + \frac{R}{n-1} g_{ab} - T_{ab} \right) \tag{3.39}
$$

It is clear from [\(3.18\)](#page-13-3) and Lemma [3.9](#page-17-4) that

$$
\Delta\left(\overset{\circ}{R}_{ab}+\frac{R}{n-1}g_{ab}\right)=O(\epsilon_0^{\frac{1}{3}}R^2).
$$

On the other hand, one can compute as [\(3.36\)](#page-18-3) that  $|\Delta T_{ab}| = O(\epsilon_0^2 R^2)$ . Now the conclusion follows from  $(3.39)$ .

Now we consider a family of diffeomorphisms  $\varphi_t$  defined by

\begin{cases}\n\frac{d\varphi_t}{dt} = \frac{\nabla f}{|\nabla f|^2}, \\
\varphi_{t_0} = \text{id} \quad \text{on} \quad \Sigma(t_0).\n\end{cases} (3.40)
$$

By abuse of notation, we set  $R = R(t) = R(\varphi_t(x))$  for  $x \in \Sigma(t_0)$ . Direct calculation yields that

$$
R_t = \frac{\langle \nabla R, \nabla f \rangle}{|\nabla f|^2} = \frac{\Delta R - R + 2|Rc|^2}{t - R}.
$$
\n(3.41)

On the one hand, we compute on *E*,

$$
|Rc|^2 = \sum_{a,b=1}^{n-1} R_{ab}^2 + 2 \sum_{a=1}^{n-1} R_{an}^2 + R_{nn}^2
$$
  
= 
$$
\sum_{a,b=1}^{n-1} \left( \overset{\circ}{R}_{ab} + \frac{R}{n-1} g_{ab} \right)^2 + 2 \sum_{a=1}^{n-1} R_{an}^2 + R_{nn}^2
$$
  
= 
$$
\frac{R^2}{n-1} + O(\epsilon_0 R^2) + O(f^{-1} R^3) + O(f^{-2} R^2 (1 + R)^2)
$$
  
= 
$$
\frac{R^2}{n-1} + O(\epsilon_0 R^2),
$$
 (3.42)

where we have used  $(3.4)$  and  $(3.5)$ .

On the other hand,  $\Delta R = O(\epsilon_0^{\frac{1}{3}} R^2)$  from Lemma [3.9.](#page-17-4) Combining this with [\(3.42\)](#page-19-1), we obtain from [\(3.41\)](#page-19-2) that

where *X* is a function such that

X = \frac{O(\epsilon_0^{\frac{1}{3}})t - 1 + \frac{2}{n-1}R}{t - R} = O(\epsilon_0^{\frac{1}{3}}).
$$
 (3.44)

Now we define

\epsilon_2 \coloneqq \epsilon_0^{\frac{1}{4}} \tag{3.45}
$$

and analyze different cases depending on whether *R* stays in the interval  $\left[\frac{n-1}{2} - \epsilon_2, \frac{n-1}{2} + \epsilon_2\right]$ . Notice that by the assumption ([†](#page-10-0)), on  $\Sigma(t_0)$ , *R* stays in this interval.

#### Cylindrical end

Without loss of generality, we assume that *s* is the largest number such that  $E = \Sigma(t_0, s)$  satisfies ([†](#page-10-0)). Throughout this subsection, we assume on *E*

\left| R - \frac{n-1}{2} \right| < \epsilon_2. \tag{3.46}
$$

<span id="page-20-2"></span>**Proposition 3.11.** *Under the assumption* [\(3.46\)](#page-20-0)*, there exists*  $\sigma_2 = \sigma_2(n, A, B, \delta_0) > 0$  *such that if*  $\epsilon_0 \leq \sigma_2$ , then  $s = \infty$ .

*Proof.* We assume  $s < \infty$  and derive a contradiction. By the definition of *s*, there exists a point  $q \in \Sigma(s)$  such that at *q* either

$$
R = \epsilon_1 f
$$
 or  $|\nabla^k Rm| = BR^{\frac{k}{2}+1}$ 

for some  $0 \le k \le 4$ . We claim that the first case cannot happen. Indeed, by [\(3.46\)](#page-20-0) that

$$
\frac{n-1}{2} + \epsilon_2 \ge R(q) = \epsilon_1 f(q) \ge \epsilon_1 t_0 \ge n
$$

which is impossible.

To exclude the second case, we assume there exists a sequence of Ricci shrinkers  $(M_i^n, g_i, f_i)$ with the end  $E_i = \Sigma(t_{0,i}, s_i)$  satisfying ([†](#page-10-0)) and  $\epsilon_{0,i} \to 0$ . Moreover, there exists a  $q_i \in \Sigma(s_i)$  at which

<span id="page-20-1"></span>
$$
|\nabla^k R m_i| = BR_i^{\frac{k}{2}+1}
$$
\n(3.47)

for a fixed  $0 \le k \le 4$ .

Now we fix a small number  $\delta < \delta_0/2$  to be determined later and define  $x_i$  to be a point such that  $\psi_i^{\delta}(x_i) = q_i$ , where  $\psi^t$  is a family of diffeomorphisms defined in [\(2.12\)](#page-8-2). We claim that such  $x_i$  must exist and lie in  $E_i$ . Indeed, from [\(2.12\)](#page-8-2) we have for any  $t \ge 0$  that

$$
\frac{df_i(\psi_i^t(x_i))}{dt} = \frac{|\nabla f_i|^2(\psi_i^t(x_i))}{1-t} = \frac{f_i(\psi_i^t(x_i)) - R_i(\psi_i^t(x_i))}{1-t} \le \frac{f_i(\psi_i^t(x_i))}{1-t}.
$$

Therefore,

<span id="page-21-1"></span><span id="page-21-0"></span>
$$
t_i := f_i(x_i) \ge s_i(1 - \delta). \tag{3.48}
$$

In particular,  $x_i \in E_i$  since  $(1 - \delta_0)s_i \ge t_{0,i}$  by our assumption ([†](#page-10-0)). On the other hand, by [\(3.46\)](#page-20-0) we have for any  $0 \le t \le \delta$ ,

$$
\frac{df_i(\psi_i^t(x_i))}{dt} = \frac{f_i(\psi_i^t(x_i)) - R_i(\psi_i^t(x_i))}{1 - t} \ge \frac{f_i(\psi_i^t(x_i)) - n}{1 - t}.
$$

By solving the above ODE, we obtain

$$
t_i \le (s_i - n)(1 - \delta) + n = s_i(1 - \delta) + n\delta. \tag{3.49}
$$

Claim.

$$
(M_i, x_i, g_i) \xrightarrow{C^{\infty}-Cheeger-Gromov} (S^{n-1} \times \mathbb{R}, p_c, g_c).
$$

*Proof of the Claim:* From [\(3.48\)](#page-21-0) and [\(3.49\)](#page-21-1), for any  $L > 1$  we have  $B_{g_i}(x_i, L) \subset E_i$ , if *i* is sufficiently large. Indeed, since  $2\sqrt{f_i}$  is 1-Lipschitz, we have for any  $y \in B_{g_i}(x_i, L)$ ,

$$
|2\sqrt{f_i(y)} - 2\sqrt{t_i}| = |2\sqrt{f_i(y)} - 2\sqrt{f_i(x_i)}| \le L.
$$
 (3.50)

Since  $\lim_{i\to\infty} t_i = +\infty$  by [\(3.48\)](#page-21-0), we obtain

<span id="page-21-5"></span><span id="page-21-3"></span><span id="page-21-2"></span>
$$
\lim_{i \to \infty} \frac{f_i(y)}{t_i} = 1 \tag{3.51}
$$

uniformly for  $y \in B_{g_i}(x_i, L)$ . By our assumptions ([†](#page-10-0)) and [\(3.46\)](#page-20-0), the Riemannian curvature  $|Rm_i|$  is uniformly bounded on  $E_i$ . Moreover, one can obtain the higher order estimates of  $Rm_i$  on  $B_{g_i}(x_i, L)$ . Indeed, we take  $\delta_1 := \delta_0/10$  and for any  $(y, t) \in B_{g_i}(x_i, L) \times [-\delta_1, 0]$ , we compute

$$
|Rm_i|(y,t) = \frac{1}{1-t}|Rm_i|(\psi_i^t(y), 0).
$$
\n(3.52)

Similar to [\(3.48\)](#page-21-0), if *i* is sufficiently large, we obtain

$$
f_i(y) \ge f_i(\psi_i^t(y)) \ge \frac{f_i(y)}{1+\delta_1} \ge t_{0,i}.
$$

In other words,  $\psi_i^t(y) \in E_i$ . Therefore, it is clear from [\(3.52\)](#page-21-2) that  $|Rm_i|$  is uniformly bounded on  $B_{g_i}(x_i, L) \times [-\delta_1, 0]$ . Now the higher order estimates of  $|Rm_i|$  follow from Shi's local estimates [\[63\]](#page-76-3).

From the above estimates of the curvature and Theorem [3.1,](#page-10-5) we conclude that

$$
(M_i^n, x_i, g_i) \xrightarrow{C^\infty - Cheeger-Gromov} (M_{\infty}^n, x_{\infty}, g_{\infty}),
$$

where the limit is a complete smooth Riemannian manifold with bounded curvature. On the other hand, if we define  $\tilde{f}_i := t_i^{-\frac{1}{2}}(f_i - t_i)$ , then

<span id="page-21-4"></span>
$$
|\nabla_{g_i}\tilde{f}_i|^2_{g_i} = \frac{|\nabla_{g_i}f_i|^2_{g_i}}{t_i} = \frac{f_i - R_i}{t_i}.
$$
\n(3.53)

In addition, we obtain

$$
\text{Hess}_{g_i} \tilde{f}_i = t_i^{-\frac{1}{2}} \text{Hess}_{g_i} f_i = \frac{1}{2} t_i^{-\frac{1}{2}} g_i - t_i^{-\frac{1}{2}} R c_i.
$$
 (3.54)

From the definition of  $\tilde{f}_i$  and [\(3.50\)](#page-21-3), we compute for any  $y \in B_{g_i}(x_i, L)$  that

$$
\tilde{f}_i(y) = t_i^{-\frac{1}{2}}(f_i(y) - t_i) = t_i^{-\frac{1}{2}}(\sqrt{f_i(y)} - \sqrt{t_i})(\sqrt{f_i(y)} + \sqrt{t_i}) \le \frac{3}{2}L.
$$
\n(3.55)

Therefore, it follows from [\(3.53\)](#page-21-4), [\(3.54\)](#page-22-0), [\(3.55\)](#page-22-1) and the standard regularity theorem for elliptic equations that  $\tilde{f}_i$  converges smoothly to a smooth function  $f_\infty$  on  $M_\infty$ . Moreover, we conclude from [\(3.54\)](#page-22-0) that

<span id="page-22-2"></span><span id="page-22-1"></span><span id="page-22-0"></span>
$$
\text{Hess}_{g_{\infty}} f_{\infty} = 0. \tag{3.56}
$$

In addition,  $f_{\infty}$  is not a constant since by [\(3.46\)](#page-20-0) and [\(3.53\)](#page-21-4),

$$
|\nabla_{g_{\infty}}f_{\infty}|^2=1.
$$

From [\(3.56\)](#page-22-2), we conclude that  $(M_{\infty}, g_{\infty})$  is isometric to  $(\Sigma_{\infty} \times \mathbb{R}, g'_{\infty} \times g_E)$ , where  $\Sigma_{\infty}$  is the level set of *f*∞. Since the second fundamental form of Σ<sup>∞</sup> vanishes, it follows from [\(3.6\)](#page-11-4) that the sectional curvature of  $g'_{\infty}$  on  $\Sigma_{\infty}$  is identically  $\frac{1}{2(n-2)}$ . Therefore, it is clear that  $(M_{\infty}, g_{\infty})$  is isometric to  $(S^{n-1} \times \mathbb{R}, g_c)$  and Claim is proved.

Now we fix the parameter  $\delta$  small enough such that the pseudolocality Theorem [\[48,](#page-75-6) Theorem 24] can be applied. Combining with [\[17,](#page-73-11) Theorem 3.1], we conclude that for any  $L > 0$ ,

$$
|Rm_i|\leq C(n)
$$

on  $B_{g_i}(x_i, L) \times [0, \delta]$ , if *i* is sufficiently large. Therefore, we conclude that

$$
(M_i, x_i, g_i(t))_{t \in [0,\delta]} \xrightarrow{C^{\infty}-Cheeger-Gromov} (M_{\infty}, x_{\infty}, g_{\infty}(t))_{t \in [0,\delta]}
$$

such that  $(M_{\infty}, g_{\infty}(t))$  has unifomrly bounded curvature. From the uniqueness of the Ricci flow with bounded curvature [\[25\]](#page-73-13) and the Claim, we have

$$
(M_{\infty}, x_{\infty}, g_{\infty}(t))_{t\in[0,\delta]}=(S^{n-1}\times\mathbb{R}, p_c, g_c(t))_{t\in[0,\delta]}.
$$

Therefore, for  $0 \leq k \leq 4$ ,

$$
\lim_{i \to \infty} \frac{|\nabla^k R m_i|}{R^{\frac{k}{2}+1}} (q_i, 0) = \lim_{i \to \infty} \frac{|\nabla^k R m_i|}{R^{\frac{k}{2}+1}} (x_i, \delta) = \frac{|\nabla^k R m_{g_c}|}{R^{\frac{k}{2}+1}_{g_c}} = \begin{cases} \sqrt{\frac{2}{(n-1)(n-2)}} & \text{if } k = 0, \\ 0 & \text{if } k > 0. \end{cases}
$$

However, this contradicts [\(3.47\)](#page-20-1) since  $B \ge 1$ . In sum, we obtain a contradiction, and the proof is complete. complete.

From Proposition [3.11,](#page-20-2) *E* is an end of the Ricci shrinker. Next, we show that any point in *E* far away from  $\Sigma(t_0)$  is the center of an evolving normalized  $\epsilon$ -neck.

<span id="page-23-2"></span>**Proposition 3.12.** With the above assumptions ([†](#page-10-0)) and [\(3.46\)](#page-20-0), for any  $\epsilon > 0$ , there exists a constant  $\eta_3 = \eta_3(\epsilon, n, \delta_0, A, B) > 0$  such that if  $\epsilon_0 \leq \eta_3$ , then any point  $x \in \Sigma(\eta_3^{-1}t_0, \infty) \subset E$  is the center of *an evolving normalized*  $ε$ *-neck.* 

*Proof.* We prove it by contradiction. Suppose for fixed  $\epsilon$  the conclusion does not hold. Then there exists a sequence of Ricci shrinkers  $(M_i^n, p_i, g_i, f_i)$  satisfying all the assumptions with  $\epsilon_{0,i} \to 0$  and  $x_i \in \Sigma(i^2 t_{0,i}, \infty)$  which is not the center of an evolving normalized  $\epsilon$ -neck. By the identical proof as that of Proposition [3.11,](#page-20-2) we conclude that

$$
(M_i, x_i, g_i) \xrightarrow{C^{\infty}-Cheeger-Gromov} (S^{n-1} \times \mathbb{R}, p_c, g_c).
$$

For a fixed number  $L > 0$ , we consider any spacetime point  $(y, \bar{t}) \in B_{g_i}(x_i, L) \times [-L, 0]$ . From

$$
0 \le \frac{df_i(\psi_i^t(y))}{dt} = \frac{f_i(\psi_i^t(y)) - R_i(\psi_i^t(y))}{1 - t} \le \frac{f_i(\psi_i^t(y))}{1 - t},
$$

we have

$$
f_i(y) \ge f_i(\psi_i^{\bar{t}}(y)) \ge \frac{f_i(y)}{1 - \bar{t}} \ge \frac{f_i(y)}{1 + L}.
$$
 (3.57)

On the other hand, if we set  $f_i(x_i) = t_i$ , then similar to [\(3.51\)](#page-21-5),

<span id="page-23-1"></span><span id="page-23-0"></span>
$$
\lim_{i \to \infty} \frac{f_i(y)}{t_i} = 1 \tag{3.58}
$$

for  $y \in B_{g_i}(x_i, L)$  uniformly. In particular, [\(3.57\)](#page-23-0) and [\(3.58\)](#page-23-1) imply  $\psi_i^{\bar{t}}(y) \in E_i$  since  $t_i \geq i^2 t_{0,i}$ . Now we compute

$$
|Rm_i|(y,\bar{t}) = \frac{|Rm_i|(\psi_i^{\bar{t}}(y),0)}{1-\bar{t}}
$$

which is uniformly bounded for  $(y, \bar{t}) \in B_{g_i}(x_i, L) \times [-L, 0]$ . Combining this fact with Theorem [3.1,](#page-10-5) we conclude that

$$
(M_i, x_i, g_i(t))_{t \leq 0} \xrightarrow{C^{\infty}-Cheeger-Gromov} (M_{\infty}^n, x_{\infty}, g_{\infty}(t))_{t \leq 0}
$$

such that  $(M^n_{\infty}, g_{\infty}(t))_{t\leq 0}$  has uniformly bounded curvature. By the same proof as in Proposition [3.11,](#page-20-2)  $(M^n_{\infty}, g_{\infty}(0)) = (S^{n-1} \times \mathbb{R}, g_c)$ . Therefore, it follows from the backward uniqueness of the Ricci flow [\[39,](#page-74-12) Theorem 1.1] that  $g_\infty(t) = g_c(t)$  for any  $t \le 0$ . However, this implies that  $x_i$  is the center of an evolving normalized  $\epsilon$ -neck for large *i*, which is a contradiction.

Next, we show that *E* is asymptotic to the cylinder at some fixed rate depending only on *n*. From Proposition [3.12,](#page-23-2) there exists a large number  $t' > t_0$  such that on  $E' := \Sigma(t', \infty)$  we have

$$
|\nabla^i Rm| \le C(n)R^{\frac{i}{2}+1}
$$

for any  $0 \le i \le 4$  and Theorem [3.1](#page-10-5) holds for some  $\kappa$  depending only on *n*. Therefore, it follows from  $(3.17)$  that on  $E'$  we have

$$
\Delta_{\Sigma}G \geq \langle \nabla G, \nabla f \rangle - c_2 f^{-1} (1+R) |\langle \nabla G, \nabla f \rangle| - 2 \langle \nabla G, \nabla \log R \rangle_{\Sigma} + c_1 RG - c_2 f^{-1} R (1+R),
$$

where  $G = \frac{|Rm|^2}{R^2} - \frac{2}{(n-1)(n-2)}$  and  $c_1, c_2$  depend only on *n*. If we set  $k(t) = \sup_{\Sigma(t)} G$ , then for any *t*  $\ge$  *t'*, there exists a maximum point  $z \in \Sigma(t)$  such that at *z*,

$$
0 \ge \langle \nabla G, \nabla f \rangle - c_4 t^{-1} |\langle \nabla G, \nabla f \rangle| + c_3 R k - c_4 R t^{-1}, \tag{3.59}
$$

for *c*<sup>3</sup> and *c*<sup>4</sup> depending on *n*, where we have used the fact that *R* is uniformly bounded on *E*.

If *k*(*t*) ≥ 2*c*<sub>4</sub> $c_3^{-1}$ *t*<sup>-1</sup>, then by [\(3.59\)](#page-24-0) we have

$$
0 \ge \langle \nabla G, \nabla f \rangle - c_3 t^{-1} |\langle \nabla G, \nabla f \rangle| + \frac{c_4}{2} Rk. \tag{3.60}
$$

It is clear from [\(3.60\)](#page-24-1) that  $\langle \nabla G, \nabla f \rangle \leq 0$  at *z*. Therefore, we obtain

$$
k'(t) \le \frac{\langle \nabla G, \nabla f \rangle}{|\nabla f|^2}(z) \le -\frac{c_4 R k(t)}{2|\nabla f|^2 (1 - c_3 t^{-1})}(z) \le -\tau_1 k(t) t^{-1}
$$
(3.61)

for  $\tau_1 = \tau_1(n) \in (0, 1)$ , where the last inequality follows from [\(3.46\)](#page-20-0). If we consider max{ $k(t)$ ,  $2c_4c_3^{-1}t^{-1}$ } and [\(3.61\)](#page-24-2), it is easy to see that for any  $t \ge t'$ ,

<span id="page-24-4"></span><span id="page-24-3"></span><span id="page-24-2"></span><span id="page-24-1"></span><span id="page-24-0"></span>
$$
k(t) = O(t^{-\tau_1}).
$$
\n(3.62)

Combining [\(3.62\)](#page-24-3) with [\(3.7\)](#page-11-5), we conclude that

$$
\frac{|\stackrel{\circ}{R}m_{\Sigma}|}{R} = O(t^{-\tau_2}),\tag{3.63}
$$

on  $\Sigma(t)$ , where  $\tau_2 = \tau_1/2$ .

Next, we prove

<span id="page-24-5"></span>**Proposition 3.13.** With the above assumptions, for any sequence  $x_i \in E$  with  $x_i \to \infty$ , we have

$$
(M, x_i, g) \xrightarrow{C^{\infty}-Cheeger-Gromov} \left( S^{n-1} \times \mathbb{R}, p_c, g_c \right).
$$

*Proof.* For any sequence  $x_i \rightarrow \infty$  with  $t_i = f(x_i)$ , we conclude that

$$
(M_i, x_i, g_i) \xrightarrow{C^{\infty}-Cheeger-Gromov} (M_{\infty}, x_{\infty}, g_{\infty}),
$$

where the limit is a complete smooth Riemannian manifold. Here, the smooth convergence follows from the same proof as that of the Claim in Proposition [3.11.](#page-20-2) Moreover, by considering  $f_i$  =  $t_i^{-\frac{1}{2}}(f_i - t_i)$ , we can show as in Proposition [3.11](#page-20-2) that the limit ( $M_{\infty}$ , *g*<sub>∞</sub>) splits isometrically as ( $\Sigma_{\infty}$  ×  $\mathbb{R}, g'_{\infty} \times g_E$ ). From [\(3.63\)](#page-24-4), it is clear that  $(\Sigma_{\infty}, g'_{\infty})$  is isometric to  $(S^{n-1}, g_S)$  up to scaling, where  $g_S$  is the standard metric on  $S^{n-1}$  such that the scalar curvature is  $\frac{n-1}{2}$ . In particular, if the limit ( $M_{\infty}, g_{\infty}$ ) is a Ricci shrinker, then  $(\Sigma_{\infty}, g'_{\infty})$  is exactly isometric to  $(S^{n-1}, g_S)$ .

Therefore, we conclude from [\[54,](#page-75-0) Proposition 5.2] that for any  $x_i \to \infty$ 

$$
(M_i, x_i, g_i) \xrightarrow{C^{\infty}-Cheeger-Gromov} (S^{n-1} \times \mathbb{R}, p_c, g_c)
$$

and the proof is complete.

If we denote the induced metric on  $\Sigma(t)$  by  $\tilde{g}(t)$ , then it follows from [\(3.63\)](#page-24-4), Proposition [3.13](#page-24-5) and the same proof as in [\[53,](#page-75-12) Theorem 4.1, Page 919-922] that

<span id="page-25-0"></span>
$$
\tilde{g}(t) = g_S + O(t^{-\tau}),\tag{3.64}
$$

where  $\tau = \tau(n) > 0$ . Similar estimates also hold for the higher derivatives of  $\tilde{g}(t)$ . Now we define a map

$$
\Psi: S^{n-1} \times [t_0, \infty) \longrightarrow E
$$

by  $\Psi(z, t) = \varphi_t(z)$ . Here  $\varphi_t$  is defined in [\(3.40\)](#page-19-3) and we have identified  $S^{n-1}$  with  $\Sigma(t_0)$  by a diffeomorphism.

Therefore, it follows from [\(3.64\)](#page-25-0) that on  $S^{n-1} \times \{t\}$ ,

$$
|\Psi^*g - g_c| = O(t^{-\tau}).
$$

If we consider the estimates of the second fundamental form, then the estimates for all higher derivatives can also be derived. More precisely, we have on  $S^{n-1} \times \{t\}$  that

$$
|\nabla^k_{g_c}(\Psi^*g)|=O(t^{-\tau_k})
$$

for some  $\tau_k = \tau_k(n) > 0$ . In other words, the end *E* is smoothly asymptotic to  $S^{n-1} \times \mathbb{R}$ .

Remark 3.14. *In* [\[53,](#page-75-12) Theorem 1.6]*, Munteanu and Wang have obtained a similar result with an extra assumption that the Ricci shrinker considered has uniformly bounded curvature. This assumption plays an important role in* [\[53,](#page-75-12) Theorem 3.1] *for getting the higher-order estimates*  $|\nabla^k Rm| \leq B_k R^{\frac{k}{2}+1}$  *for any*  $k \geq 0$ *. Notice that we drop the uniformly bounded curvature condition by applying the pseudolocality theorem (cf.* [\[48,](#page-75-6) Corollary 10.6], [\[58,](#page-75-13) Theorem 10.1], [\[67,](#page-76-4) Theorem 1.2 ]*).*

#### Conical end

In this subsection, we assume that [\(3.46\)](#page-20-0) is violated in one direction and hence there exists a  $t_1 \in$  $(t_0, \infty)$  such that

<span id="page-25-2"></span><span id="page-25-1"></span>
$$
\left| R - \frac{n-1}{2} \right| < \epsilon_2 \tag{3.65}
$$

on  $\Sigma(t_0, t_1)$  and

$$
\min_{\Sigma(t_1)} R = \frac{n-1}{2} - \epsilon_2.
$$
 (3.66)

We define

$$
E^1 \coloneqq \Sigma(t_1, s) \subset E. \tag{3.67}
$$

**Proposition 3.15.** With the assumptions above, there exist positive constants  $\hat{c}_1$  and  $\hat{c}_2$  depending *only on n, A and B such that if*  $\epsilon_0$  *is sufficiently small, then* 

$$
\frac{1}{\frac{2}{n-1} + \hat{c}_2 \epsilon_2 t_1^{-1} t} \le R(x) \le \frac{1}{\frac{2}{n-1} + \hat{c}_1 \epsilon_2 t_1^{-1} t}
$$
(3.68)

*for any*  $x \in E^1$ *, where*  $t = f(x)$ *.* 

*Proof.* In the proof, all constants  $c_i$ ,  $i = 1, 2, \cdots$  depend only on *n*, *A* and *B*.

By our assumption, there exists  $x \in \Sigma(t_1)$  such that

<span id="page-26-6"></span><span id="page-26-4"></span><span id="page-26-0"></span>
$$
R(x)=\frac{n-1}{2}-\epsilon_2.
$$

From Lemma [3.8,](#page-16-3) we may assume on  $\Sigma(t_1)$ ,

$$
\frac{n-1}{2} - \frac{3}{2}\epsilon_2 \le R \le \frac{n-1}{2} - \frac{1}{2}\epsilon_2.
$$
 (3.69)

In addition, it follows from [\(3.43\)](#page-19-4) and [\(3.44\)](#page-20-3) that

$$
\left(\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}}\right) R^2 - R \le tR_t \le \left(\frac{2}{n-1} + c_1 \epsilon_0^{\frac{1}{3}}\right) R^2 - R \tag{3.70}
$$

for some constant  $c_1 > 0$ . By considering the ODE with the given initial values in [\(3.69\)](#page-26-0), we obtain

$$
\frac{1}{\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}} + c_3 \epsilon_2 t_1^{-1} t} \le R(t) \le \frac{1}{\frac{2}{n-1} + c_1 \epsilon_0^{\frac{1}{3}} + c_2 \epsilon_2 t_1^{-1} t}
$$
(3.71)

for any  $t \geq t_1$ . Here, the constants  $c_2$  and  $c_3$  are determined by

<span id="page-26-2"></span><span id="page-26-1"></span>
$$
\frac{1}{\frac{2}{n-1} + c_1 \epsilon_0^{\frac{1}{3}} + c_2 \epsilon_2} = \frac{n-1}{2} - \frac{1}{2} \epsilon_2
$$
 (3.72)

and

<span id="page-26-3"></span>
$$
\frac{1}{\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}} + c_3 \epsilon_2} = \frac{n-1}{2} - \frac{3}{2} \epsilon_2.
$$
 (3.73)

It is clear from [\(3.71\)](#page-26-1), [\(3.72\)](#page-26-2), [\(3.73\)](#page-26-3) and the definition of  $\epsilon_2$  that [\(3.68\)](#page-26-4) holds if  $\epsilon_0$  is sufficiently  $small.$ 

Similar to Proposition [\(3.11\)](#page-20-2), we have the following result.

<span id="page-26-5"></span>**Proposition 3.16.** *Under the assumptions* ([†](#page-10-0)), [\(3.65\)](#page-25-1) *and* [\(3.66\)](#page-25-2)*, there exists*  $\sigma_3 = \sigma_3(n, \sigma_0, A, B)$  > 0 *such that if*  $\epsilon_0 \leq \sigma_3$ *, then*  $s = \infty$ *.* 

*Proof.* We prove it by contradiction. Similar to Proposition [\(3.11\)](#page-20-2), we assume there exists a sequence of Ricci shrinkers  $(M_i, g_i, f_i)$  with the end  $E_i = \Sigma(t_{0,i}, s_i)$  satisfying ([†](#page-10-0)), [\(3.65\)](#page-25-1) and [\(3.66\)](#page-25-2) with  $\epsilon_{0,i} \to 0$ . Moreover, there exists a point  $q_i \in \Sigma(s_i)$  at which

$$
|\nabla^k Rm_i|=BR_{g_i}^{\frac{k}{2}+1}
$$

for a fixed  $0 \le k \le 4$ .

Claim 1.

<span id="page-27-1"></span>lim inf *i*→∞  $\epsilon_{2,i} \frac{s_i}{s}$ *t*1,*i*  $(3.74)$ 

*Proof of Claim 1:* Otherwise, it follows from the assumption [\(3.65\)](#page-25-1) and [\(3.68\)](#page-26-4) that

$$
\limsup_{i\to\infty}\max_{\Sigma(t_{0,i},s_i)}\left|R_i-\frac{n-1}{2}\right|=0.
$$

Therefore, the same proof of Proposition [3.11](#page-20-2) yields a contradiction.

Now we set  $r_i^{-2} = \frac{2}{n-1} R_i(q_i)$ , then it follows from [\(3.68\)](#page-26-4) that

$$
r_i = \sqrt{1 + \frac{n-1}{2} \sigma_i s_i} \ge 1
$$

where

<span id="page-27-0"></span>
$$
\hat{c}_1 \epsilon_{2,i} t_{1,i}^{-1} \leq \sigma_i \leq \hat{c}_2 \epsilon_{2,i} t_{1,i}^{-1}.
$$

Next we fix a constant  $\delta = \delta(n) \in (0, 1/20)$  determined later and prove the following result.

**Claim 2.** There exists a constant  $c_1 = c_1(n) > 0$  such that for any  $t \in [-2\delta r_i^2, 0]$ ,

$$
\frac{s_i}{1+|t|} \le f_i(\psi_i^t(q_i)) \le \frac{s_i - c_1}{1+|t|} + c_1 \tag{3.75}
$$

*Proof of Claim 2:* For any  $t \in [-2\delta r_i^2, 0]$  we have

$$
\frac{df_i(\psi_i^t(q_i))}{dt} = \frac{|\nabla_{g_i} f_i|^2_{g_i}}{1-t}(\psi_i^t(q_i)) = \frac{f_i - R_i}{1-t}(\psi_i^t(q_i))
$$

Since  $0 \le R_i(\psi_i^t(q_i)) \le c_1$ , it is clear that

$$
\frac{f_i(\psi_i^t(q_i)) - c_1}{1 - t} \le \frac{df_i(\psi_i^t(q_i))}{dt} \le \frac{f_i(\psi_i^t(q_i))}{1 - t}.
$$

By solving the above ODE, we immediately obtain [\(3.75\)](#page-27-0).

Now we set  $q_i^t := \psi_i^t(q_i)$  and  $s_i^t := f_i(\psi_i^t(q_i))$ . Moreover, for any fixed number  $L > 1$  and *t* ∈  $[-2\delta r_i^2, 0]$ , we consider  $y \in B_{g_i}(q_i^t, L(1 + |t|)^{-\frac{1}{2}}r_i)$  and obtain

$$
|2\sqrt{f_i(y)} - 2\sqrt{s_i^t}| = |2\sqrt{f_i(y)} - 2\sqrt{f_i(q_i^t)}| \le \frac{Lr_i}{\sqrt{1+|t|}} = L\sqrt{\frac{1+\frac{n-1}{2}\sigma_i s_i}{1+|t|}}.
$$

From [\(3.75\)](#page-27-0) and the fact that  $\lim_{i\to\infty} \sigma_i = 0$ , we obtain

<span id="page-28-2"></span><span id="page-28-0"></span>
$$
\lim_{i \to \infty} \frac{f_i(y)}{s_i^t} = 1 \tag{3.76}
$$

uniformly for (*y*, *t*) ∈ *B*<sub>*gi*</sub> ( $q_i^t$ , *L*(1 + |*t*|)<sup>- $\frac{1}{2}$ *r<sub>i</sub>*) × [−2δ*r*<sub> $i^2$ </sub>, 0].</sup>

In particular, for  $(y, t) \in B_{g_i} (q_i^t, L(1 + |t|)^{-\frac{1}{2}} r_i) \times [-2\delta r_i^2, -L^{-1} r_i^2]$ , we obtain

$$
s_i^t \ge \frac{s_i}{1+|t|} \ge \frac{s_i}{1+2\delta r_i^2} \ge t_{1,i},\tag{3.77}
$$

<span id="page-28-1"></span>.

where we have used [\(3.74\)](#page-27-1) for the last inequality. Moreover, since  $r_i \geq 1$ , we have

$$
s_i^t \leq \frac{s_i - c_1}{1 + |t|} + c_1 \leq \frac{s_i - c_1}{1 + L^{-1}r_i^2} + c_1 \leq \frac{s_i - c_1}{1 + L^{-1}} + c_1.
$$

Therefore, it follows from [\(3.76\)](#page-28-0) that

$$
t_{1,i} \le f_i(y) \le s_i
$$

for sufficiently large *i*, which implies that  $y \in E_i^1$ .

**Claim 3.** If we set  $\tilde{g}_i(t) = r_i^{-2} g_i(r_i^2 t)$ , then

$$
(M_i, q_i, \tilde{g}_i(t))_{t \in [-\delta, 0)} \xrightarrow{C^{\infty}-Cheeger-Gromov} (M_{\infty}^n, q_{\infty}, g_{\infty}(t))_{t \in [-\delta, 0)}
$$

for a complete smooth Ricci flow  $(M^n_\infty, g_\infty(t))_{t \in [-\delta,0)}$  with uniformly bounded curvature.

*Proof of Claim 3:* For any  $L > 1$  and  $(y, t) \in B_{g_i}(q_i^t, L(1+|t|)^{-\frac{1}{2}}r_i) \times [-2\delta r_i^2, -L^{-1}r_i^2]$  it follows from [\(3.68\)](#page-26-4) and [\(3.76\)](#page-28-0) that

$$
R_i(y) \le \frac{1}{\frac{2}{n-1} + \hat{c}_1 \frac{\epsilon_{2,i}}{t_{1,i}} f_i(y)} \le \frac{2}{\frac{2}{n-1} + \hat{c}_1 \frac{\epsilon_{2,i}}{t_{1,i}} s_i^t}
$$

Therefore, we obtain

$$
\frac{1}{1+|t|}R_i(y) \le \frac{s_i^t}{s_i}R_i(y) \le \frac{2}{s_i} \frac{1}{\frac{2}{n-1}(s_i^t)^{-1} + \hat{c}_1 \frac{\epsilon_{2,i}}{t_{1,i}}} \le \frac{K}{\frac{2}{n-1} + \hat{c}_2 \frac{\epsilon_{2,i}}{t_{1,i}} s_i} \le KR_i(q_i) = \frac{n-1}{2}Kr_i^{-2}.
$$
 (3.78)

Here,  $K := 2(1 + \hat{c}_2/\hat{c}_1)$  and the third inequality follows from [\(3.74\)](#page-27-1).

From [\(3.78\)](#page-28-1), it is clear that  $R_{\tilde{g}_i}(y, t)$  is uniformly bounded for any  $t \in [-2\delta, -L^{-1}]$  and  $y \in$  $B_{\tilde{g}_i(t)}(q_i, L)$ . Since  $|Rm_{\tilde{g}_i}|$  is controlled by  $R_{\tilde{g}_i}$  by our assumption ([†](#page-10-0)), we immediately conclude from the Shi's local estimates and Theorem [3.1](#page-10-5) that

$$
(M_i, q_i, \tilde{g}_i(t))_{t \in [-\delta, 0)} \xrightarrow{C^{\infty}-Cheeger-Gromov} (M_{\infty}^n, q_{\infty}, g_{\infty}(t))_{t \in [-\delta, 0)}
$$

for a complete smooth Ricci flow  $(M^n_\infty, g_\infty(t))_{t \in [-\delta,0)}$  with uniformly bounded curvature.

We have

**Claim 4.** There exists a constant  $\lambda \geq K^{-1}$  such that

$$
(M_{\infty}, g_{\infty}(-\delta)) = (S^{n-1} \times \mathbb{R}, \lambda g_c),
$$

where  $K$  is the same constant in  $(3.78)$ .

*Proof of Claim 4:* We set

$$
\tilde{f}_i := r_i^{-1} t_i^{-\frac{1}{2}} (F_i(-\delta r_i^2) - t_i),
$$

where  $F_i(t) := (1 - t)f_i(t)$  and  $t_i := F_i(-\delta r_i^2)(q_i)$ . From a direct calculation,

$$
|\nabla_{\tilde{g}_i(-\delta)} \tilde{f}_i|^2_{\tilde{g}_i(-\delta)} = \frac{|\nabla_{g_i(-\delta r_i^2)} F_i(-\delta r_i^2)|^2_{g_i(-\delta r_i^2)}}{t_i} = \frac{F_i(-\delta r_i^2) - (1 + \delta r_i^2)^2 R_{g_i(-\delta r_i^2)}}{t_i},
$$
(3.79)

where we have used the identity  $(1 - t)^2 R_i + |\nabla F_i|^2 = F_i$ . From [\(3.78\)](#page-28-1), we obtain  $(1 + \delta r_i^2) R_{g_i(-\delta r_i^2)}$ | is uniformly bounded on  $B_{\tilde{g}_i(-\delta)}(q_i, L)$ . Moreover,

$$
t_i = (1 + \delta r_i^2) f_i(q_i^{-\delta r_i^2}) = (1 + \delta r_i^2) s_i^{-\delta r_i^2},
$$
\n(3.80)

Therefore, it follows from [\(3.77\)](#page-28-2) that

<span id="page-29-4"></span><span id="page-29-1"></span>
$$
\lim_{i \to \infty} \frac{(1 + \delta r_i^2)^2 R_{g_i(-\delta r_i^2)}}{t_i} = 0
$$
\n(3.81)

uniformly on  $B_{\tilde{g}_i(-\delta)}(q_i, L)$ . On the other hand, it follows from [\(3.79\)](#page-29-0) that  $F_i(-\delta r_i^2)$  is  $r_i/2$ -Lipschitz with respect to  $\tilde{g}_i(-\delta)$ . Therefore, for any  $y \in B_{\tilde{g}_i(-\delta)}(q_i, L)$ ,

$$
\tilde{f}_i(y) = r_i^{-1} t_i^{-\frac{1}{2}} (F_i(y, -\delta r_i^2) - t_i)
$$
\n
$$
= r_i^{-1} t_i^{-\frac{1}{2}} (\sqrt{F_i(y, -\delta r_i^2)} - \sqrt{t_i}) (\sqrt{F_i(y, -\delta r_i^2)} + \sqrt{t_i})
$$
\n
$$
\leq r_i^{-1} t_i^{-\frac{1}{2}} \frac{L}{2} r_i \cdot 3 \sqrt{t_i} \leq \frac{3}{2} L,
$$
\n(3.82)

where we have used the fact that  $\lim_{i\to\infty} t_i^{-1}r_i^2 = 0$  from [\(3.80\)](#page-29-1). Then it is clear that

<span id="page-29-2"></span>
$$
\lim_{i \to \infty} \frac{F_i(-\delta r_i^2)}{t_i} = \lim_{i \to \infty} \frac{\tilde{f}_i r_i t_i^{\frac{1}{2}} + t_i}{t_i} = 1
$$

uniformly on  $B_{\tilde{g}_i(-\delta)}(q_i, L)$ . In addition, we compute

<span id="page-29-3"></span>
$$
\begin{split}\n\text{Hess}_{\tilde{g}_i(-\delta)} \tilde{f}_i \\
&= r_i^{-1} t_i^{-\frac{1}{2}} \text{Hess}_{g_i(-\delta r_i^2)} F_i \\
&= \frac{1}{2} r_i^{-1} t_i^{-\frac{1}{2}} g_i(-\delta r_i^2) - (1 + \delta r_i^2) r_i^{-1} t_i^{-\frac{1}{2}} R c_{g_i(-\delta r_i^2)} \\
&= \frac{1}{2} r_i t_i^{-\frac{1}{2}} \tilde{g}_i(-\delta) - (1 + \delta r_i^2) r_i^{-1} t_i^{-\frac{1}{2}} R c_{\tilde{g}_i(-\delta)}.\n\end{split} \tag{3.83}
$$

Therefore, it follows from [\(3.82\)](#page-29-2), [\(3.83\)](#page-29-3) and the standard regularity theorem for elliptic equations that  $\tilde{f}_i$  converges smoothly to a smooth function  $f_\infty$  on  $M_\infty$  and

<span id="page-30-0"></span>
$$
\text{Hess}_{g_{\infty}} f_{\infty} = 0, \tag{3.84}
$$

since lim *i*→∞  $t_i^{-1} r_i^2 = 0$ . Furthermore, it follows from the combination of [\(3.79\)](#page-29-0), [\(3.80\)](#page-29-1) and [\(3.81\)](#page-29-4) that

<span id="page-30-1"></span>
$$
|\nabla_{g_{\infty}} f_{\infty}|^2 = 1. \tag{3.85}
$$

Therefore,  $f_{\infty}$  is not a constant. From [\(3.84\)](#page-30-0) and [\(3.85\)](#page-30-1), we conclude that ( $M_{\infty}$ ,  $g_{\infty}$ ) is isometric to  $(\Sigma_{\infty} \times \mathbb{R}, g'_{\infty} \times g_E)$ , where  $\Sigma_{\infty}$  is the level set of  $f_{\infty}$ . It follows immediately from Lemma [3.8](#page-16-3) that  $(M_{\infty}, g_{\infty}) = (S^{n-1} \times \mathbb{R}, \lambda g_c)$  for some constant  $\lambda > 0$ . Notice that  $(M_{\infty}, g_{\infty})$  cannot be flat  $\mathbb{R}^n$  since by [\(3.68\)](#page-26-4) and [\(3.75\)](#page-27-0) that  $R_i(q_i^{-\delta})/R_i(q_i) \ge C > 0$  uniformly. From the estimate [\(3.78\)](#page-28-1), it is clear that  $\lambda \geq K^{-1}$ .

Now we fix the parameter  $\delta = \delta(n) > 0$  small enough such that the pseudolocality Theorem [\[48,](#page-75-6) Theorem 24] can be applied. Combining with [\[17,](#page-73-11) Theorem 3.1], we conclude that for any  $L > 0$ ,

$$
|Rm_{\tilde{g}_i}|\leq C(n)
$$

on  $B_{\tilde{g}_i}(q_i, L) \times [-\delta, 0]$ , if *i* is sufficiently large. Therefore, we conclude that

$$
(M_i, q_i, \tilde{g}_i(t))_{t \in [-\delta, 0]} \xrightarrow{C^{\infty}-Cheeger-Gromov} (S^{n-1} \times \mathbb{R}, p_c, g_c(t))_{t \in [-\delta, 0]}
$$

since  $R_{\tilde{g}_i}(q_i, 0) = \frac{n-1}{2}$ . Therefore, we can derive the contradiction as in the proof of Proposition [3.11.](#page-20-2)  $\Box$ 

Proposition [3.16](#page-26-5) implies that *E* is an end of the Ricci shrinker. Moreover, it follows from [\(3.68\)](#page-26-4) and ([†](#page-10-0)) that  $|Rm|$  is quadratically decaying. It is well-known (e.g., [\[40\]](#page-74-2)) that the tangent cone at infinity concerning this end is a metric cone over a smooth cross-section.

Next, we show that any point in *E* far away from  $\Sigma(t_0)$  is the center of an evolving  $\epsilon$ -neck. We only sketch the proof as it is similar to the proofs of Proposition [3.12](#page-23-2) and Proposition [3.16.](#page-26-5)

<span id="page-30-3"></span>**Proposition 3.17.** *Under the assumptions* ([†](#page-10-0)), [\(3.65\)](#page-25-1) *and* [\(3.66\)](#page-25-2)*, for any*  $\epsilon > 0$ *, there exists a constant*  $\eta_4 = \eta_4(\epsilon, n, \delta_0, A, B) > 0$  *such that if*  $\epsilon_0 \leq \eta_4$ *, then any point*  $x \in \Sigma(\eta_4^{-1}t_0, \infty) \subset E^1$  *is the center of an evolving*  $\epsilon$ *-neck.* 

*Proof.* We prove it by contradiction. Suppose for fixed  $\epsilon$ , *n* and *A* the conclusion does not hold. Then there exists a sequence of Ricci shrinkers  $(M_i^n, p_i, g_i, f_i)$  satisfying all the assumptions and  $x_i \in \Sigma(i^2 t_{0,i}, \infty)$  which is not the center of an evolving  $\epsilon$ -neck. Now we set  $t_i = f_i(x_i)$ . We claim that

<span id="page-30-2"></span>
$$
\liminf_{i \to \infty} \epsilon_{2,i} \frac{t_i}{t_{1,i}} > 0. \tag{3.86}
$$

Otherwise, it follows from the assumption [\(3.65\)](#page-25-1) and [\(3.68\)](#page-26-4) that

$$
\limsup_{i\to\infty}\max_{\Sigma(t_{0,i},t_i)}\left|R_i-\frac{n-1}{2}\right|=0.
$$

Therefore, the same proof of Proposition  $(3.12)$  shows that  $x_i$  is the center of an evolving normalized  $\epsilon$ -neck for sufficiently large *i*.

By the same proof as in that of Proposition [3.16](#page-26-5) we have

$$
(M_i, x_i, \tilde{g}_i) \xrightarrow{C^{\infty}-Cheeger-Gromov} \left( S^{n-1} \times \mathbb{R}, p_c, g_c \right) \tag{3.87}
$$

where  $\tilde{g}_i = r_i^{-2} g_i$  and  $R_i(x_i) = \frac{n-1}{2} r_i^{-2}$ . For a fixed number  $L > 1$  and  $y \in B_{g_i}(x_i, Lr_i)$ , one can prove as [\(3.76\)](#page-28-0) that

<span id="page-31-1"></span><span id="page-31-0"></span>
$$
\lim_{i \to \infty} \frac{f_i(y)}{t_i} = 1
$$

uniformly for *y*, where  $t_i = f_i(x_i)$ . If we set  $\psi_i^t(y) = y^t$ , then we can prove as [\(3.75\)](#page-27-0) that

$$
\frac{9}{10} \frac{t_i}{1+|t|} \le f_i(y^t) \le \frac{11}{10} \frac{t_i}{1+|t|}
$$
\n(3.88)

for any  $(y, t) \in B_{g_i}(x_i, Lr_i^2) \times [-Lr_i^2, 0]$ . Since

$$
r_i = \sqrt{1 + \frac{n-1}{2} \sigma_i t_i}
$$

for some

$$
\hat{c}_1 \epsilon_{2,i} t_{1,i}^{-1} \le \sigma_i \le \hat{c}_2 \epsilon_{2,i} t_{1,i}^{-1},
$$

it is clear from [\(3.86\)](#page-30-2) and [\(3.88\)](#page-31-0) that

$$
f_i(y^t) \ge \frac{9}{10} \frac{t_i}{1 + L r_i^2} = \frac{9}{10} \frac{t_i}{1 + L(1 + \frac{n-2}{2}\sigma_i t_i)} \ge t_{1,i}.
$$

In particular,  $y^t \in E_i^1$ . Therefore, we can apply [\(3.68\)](#page-26-4) and prove exactly as [\(3.78\)](#page-28-1) that

$$
\frac{1}{1+|t|}R_i(y^t) \le \frac{f_i(y^t)}{f_i(y)}R_i(y^t) \le \frac{2}{t_i}\frac{1}{\frac{2}{n-1}u_i^{-1} + \hat{c}_1\frac{\epsilon_{2,i}}{t_{1,i}}} \le \frac{K}{\frac{2}{n-1} + \hat{c}_2\frac{\epsilon_{2,i}}{t_{1,i}}t_i} \le Kr_i^{-2}
$$

for  $(y, t) \in B_{g_i}(x_i, Lr_i^2) \times [-Lr_i^2, 0]$ , where  $u_i = f_i(y^t)$ . Therefore, we conclude that for  $\tilde{g}_i(t) :=$  $r_i^{-2}g_i(r_i^2t)$ ,  $R_{\tilde{g}_i}(y, t)$  is uniformly bounded on  $B_{\tilde{g}_i(0)}(y, L) \times [-L, 0]$  since

$$
R_{\tilde{g}_i}(y, t) = \frac{r_i^2}{1 + |t|} R_i(y^t) \le K.
$$

Then it is clear as before that

$$
(M_i, x_i, \tilde{g}_i(t))_{t \leq 0} \xrightarrow{C^{\infty}-Cheeger-Gromov} (M_{\infty}^n, x_{\infty}, g_{\infty}(t))_{t \leq 0}
$$

for a complete smooth Ricci flow solution  $(M_{\infty}, g_{\infty}(t))_{t\leq 0}$  with uniformly bounded curvature. From [\(3.87\)](#page-31-1) and the backward uniqueness of the Ricci flow [\[39,](#page-74-12) Theorem 1.1], we conclude that

$$
(M_{\infty}, g_{\infty}(t))_{t\leq 0}=(S^{n-1}\times \mathbb{R}, g_c(t))_{t\leq 0}.
$$

However, this implies that  $x_i$  is the center of an evolving  $\epsilon$ -neck for large *i*, which is a contradiction.

In this subsection, we assume that [\(3.46\)](#page-20-0) is violated in the other direction and hence there exists a  $t_2 \in (t_0, \infty)$  such that on  $\Sigma(t_0, t_2)$

and

$$
\max_{\Sigma(t_2)} R = \frac{n-1}{2} + \epsilon_2.

Now we set  $E^2 = \Sigma(t_2, s) \subset E$  and prove the following result.

<span id="page-32-7"></span>**Proposition 3.18.** With the assumptions above, there exists a positive constants  $\hat{c}_3$ ,  $\hat{c}_4$  depending *only on n*, *A and B such that*

$$
\frac{1}{\frac{2}{n-1} - \hat{c}_3 \epsilon_2 t_2^{-1} t} \le R(x) \le \frac{1}{\frac{2}{n-1} - \hat{c}_4 \epsilon_2 t_2^{-1} t}
$$
(3.91)

*for any*  $x \in E^2$ , where  $t = f(x)$ . Moreover,  $R(\psi^t(x))$  is increasing for  $t \ge 0$  as long as  $\psi^t(x)$  stays in *E* 2 *.*

*Proof.* By our assumption, there exists  $z \in \Sigma(t_2)$  such that

<span id="page-32-4"></span><span id="page-32-3"></span><span id="page-32-0"></span>
$$
R(z) = \frac{n-1}{2} + \epsilon_2.
$$

From Lemma [3.8,](#page-16-3) we may assume on  $\Sigma(t_2)$  that

$$
\frac{n-1}{2} + \frac{1}{2}\epsilon_2 \le R \le \frac{n-1}{2} + \frac{3}{2}\epsilon_2.
$$
 (3.92)

Recall from [\(3.70\)](#page-26-6) we have

$$
\left(\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}}\right) R^2 - R \le tR_t \le \left(\frac{2}{n-1} + c_1 \epsilon_0^{\frac{1}{3}}\right) R^2 - R \tag{3.93}
$$

for some constant  $c_1 = c_1(n) > 0$ . By considering the ODE with the given initial values in [\(3.92\)](#page-32-0), we obtain

$$
\frac{1}{\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}} - c_2 \epsilon_2 t_2^{-1} t} \le R(t) \le \frac{1}{\frac{2}{n-1} + c_1 \epsilon_0^{\frac{1}{3}} - c_3 \epsilon_2 t_2^{-1} t}
$$
(3.94)

for any  $t \ge t_2$ . Here, the constants  $c_2$  and  $c_3$  are determined by

$$
\frac{1}{\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}} - c_2 \epsilon_2} = \frac{n-1}{2} + \frac{1}{2} \epsilon_2.
$$
 (3.95)

and

<span id="page-33-0"></span>
$$
\frac{1}{\frac{2}{n-1} + c_1 \epsilon_0^{\frac{1}{3}} - c_3 \epsilon_2} = \frac{n-1}{2} + \frac{3}{2} \epsilon_2.
$$
 (3.96)

It is clear from [\(3.94\)](#page-32-1), [\(3.95\)](#page-32-2), [\(3.96\)](#page-33-0) and the definition of  $\epsilon_2$  that [\(3.91\)](#page-32-3) holds if  $\epsilon_0$  is sufficiently small. Now the last statement follows from  $(3.91)$  and  $(3.93)$  since on  $E^2$ ,

$$
\left(\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}}\right) R^2 - R > 0.
$$

Parallel to Proposition [\(3.11\)](#page-20-2) and Proposition [3.16,](#page-26-5) we have the following result.

<span id="page-33-3"></span>**Proposition 3.19.** *Under the assumptions* ([†](#page-10-0)), [\(3.89\)](#page-32-5) *and* [\(3.90\)](#page-32-6)*, there exists*  $\sigma_4 = \sigma_4(n, \delta_0, A, B)$ 0 *such that if*  $\epsilon_0 \leq \sigma_4$ , then  $s < \infty$  *and there exists a point*  $q \in \Sigma(s)$  *such that* 

<span id="page-33-1"></span>
$$
R(q) = \epsilon_1 f(q), \tag{3.97}
$$

*if*  $\epsilon_0$  *is sufficiently small.* 

*Proof.* By [\(3.91\)](#page-32-3), the scalar curvature blowup before the time  $t = \frac{2t_2}{(n-1)t_1}$  $\frac{2t_2}{(n-1)\epsilon_2\hat{c}_4}$ . Therefore, we must have  $s < \infty$ . We move on to show [\(3.97\)](#page-33-1).

From our definition of *E* in ([†](#page-10-0)), there exists a point  $q \in \Sigma(s)$  such that at *q* either

$$
R = \epsilon_1 f
$$
 or  $|\nabla^k Rm| = BR^{\frac{k}{2}+1}$ 

for some  $0 \le k \le 4$ . Notice that the second possibility can be excluded exactly as Proposition [3.16,](#page-26-5) if  $\epsilon_0$  is sufficiently small and we sketch the proof below.

Assume there exists a sequence of Ricci shrinkers  $(M_i, g_i, f_i)$  with the end  $E_i = \sum (t_{0,i}, s_i)$  satisfy-ing ([†](#page-10-0)), [\(3.89\)](#page-32-5) and [\(3.90\)](#page-32-6) with  $\epsilon_{0,i} \to 0$ . Moreover, there exists a  $q_i \in \Sigma(s_i)$  at which

$$
|\nabla^k Rm_i|=BR_i^{\frac{k}{2}+1}
$$

for a fixed  $0 \le k \le 4$ .

Claim 1.

<span id="page-33-2"></span>
$$
\liminf_{i \to \infty} \epsilon_{2,i} \frac{s_i}{t_{2,i}} > 0. \tag{3.98}
$$

*Proof of Claim 1:* Otherwise, it follows from the assumption  $(3.89)$  and  $(3.91)$  that

$$
\limsup_{i\to\infty}\max_{\Sigma(t_{0,i},s_i)}\left|R_i-\frac{n-1}{2}\right|=0.
$$

Therefore, the same proof of Proposition [\(3.11\)](#page-20-2) yields a contradiction.

Now we set  $r_i^{-2} = \frac{2}{n-1}R_i(q_i)$ . Then it is clear from [\(3.91\)](#page-32-3) that  $r_i \le 1$ . Moreover, we define  $q_i^t = \psi_i^t(q_i)$ ,  $s_i^t = f_i(q_i^t)$  and fix a constant  $\delta = \delta(n) \in (0, 1/20)$  determined later.

**Claim 2.** For any  $t \in [-2\delta r_i^2, 0]$ , we have

<span id="page-34-0"></span>
$$
\frac{s_i}{1+|t|} \le s_i^t \le \frac{s_i}{(1+|t|)^{1-\epsilon_{1,i}}}.\tag{3.99}
$$

*Proof of Claim 2:* For any  $t \in [-2\delta r_i^2, 0]$  we have

$$
\frac{df_i(q_i^t)}{dt} = \frac{|\nabla_{g_i} f_i|_{g_i}^2}{1-t}(q_i^t) = \frac{f_i - R_i}{1-t}(q_i^t).
$$

Since  $0 \le R_i(q_i^t) \le \epsilon_{1,i} f_i(q_i^t)$  by our assumptions, it is clear that

$$
(1 - \epsilon_{1,i}) \frac{f_i(q_i^t)}{1 - t} \le \frac{df_i(q_i^t)}{dt} \le \frac{f_i(q_i^t)}{1 - t}.
$$

By solving the above ODE, we immediately obtain [\(3.99\)](#page-34-0).

**Claim 3.** For any fixed number  $L > 1$ ,  $t \in [-2\delta r_i^2, -L^{-1}r_i^2]$  and  $y \in B_{g_i}(q_i^t, L(1+|t|)^{-\frac{1}{2}}r_i)$ , we have

<span id="page-34-3"></span><span id="page-34-2"></span><span id="page-34-1"></span>
$$
\frac{s_i}{1+2\delta} \le f_i(y) \le s_i \tag{3.100}
$$

for sufficiently large *i*.

*Proof of Claim 3:* We compute

$$
|2\sqrt{f_i(y)} - 2\sqrt{s_i^t}| = |2\sqrt{f_i(y)} - 2\sqrt{f_i(q_i^t)}| \le \frac{Lr_i}{\sqrt{1+|t|}}.
$$

Therefore, it follows from [\(3.99\)](#page-34-0) that

$$
2\sqrt{f_i(y)} \le 2\sqrt{s_i^t} + \frac{Lr_i}{\sqrt{1+|t|}} \le \frac{2\sqrt{s_i}}{(1+|t|)^{\frac{1-\epsilon_{1,i}}{2}}} + \frac{Lr_i}{\sqrt{1+|t|}}.
$$
(3.101)

Since  $L^{-1}r_i^2 \le |t| \le \delta r_i^2 \le \delta$ , there exists a universal constant  $c_1 > 0$  such that

$$
2\sqrt{s_i} - \frac{2\sqrt{s_i}}{(1+|t|)^{\frac{1-\epsilon_{1,i}}{2}}} \ge c_1|t|\sqrt{s_i} \ge c_1L^{-1}r_i^2\sqrt{s_i} \ge \frac{Lr_i}{\sqrt{1+|t|}}.\tag{3.102}
$$

Here, the last inequality follows from the fact that  $\limsup_{i\to\infty} s_i^{-1}r_i^{-2} = 0$  since  $R_i \leq \epsilon_{1,i}f_i$  on  $E_i$ . Therefore, the second inequality in Claim 3 follows from  $(3.101)$  and  $(3.102)$ . Similarly, we compute

$$
2\sqrt{f_i(y)} \ge 2\sqrt{s_i^t} - \frac{Lr_i}{\sqrt{1+|t|}} \ge \frac{2\sqrt{s_i} - L}{\sqrt{1+|t|}} \ge \frac{2\sqrt{s_i}}{\sqrt{1+2\delta}}
$$

since  $\lim_{i\to\infty} s_i = \infty$  and  $|t| \leq \delta$ . Therefore, the first inequality in Claim 3 follows.

Combining [\(3.98\)](#page-33-2) and [\(3.100\)](#page-34-3), we conclude that  $y \in E_i^2$ .

**Claim 4.** If we set  $\tilde{g}_i(t) = r_i^{-2} g_i(r_i^2 t)$ , then

$$
(M_i, q_i, \tilde{g}_i(t))_{t \in [-\delta, 0]} \xrightarrow{C^{\infty}-Cheeger-Gromov} (S^{n-1} \times \mathbb{R}, p_c, g_c(t))_{t \in [-\delta, 0]}
$$

for a complete smooth Ricci flow  $(M^n_\infty, g_\infty(t))_{t \in [-\delta,0)}$  with uniformly bounded curvature.

*Proof of Claim 4:* For any  $L > 1$  and  $(y, t) \in B_{g_i}(q_i^t, L(1+|t|)^{-\frac{1}{2}}r_i) \times [-2\delta r_i^2, -L^{-1}r_i^2]$ , it follows from Proposition [3.18](#page-32-7) that  $R_i(y)$  is bounded above by  $R_i(\phi^u(y))$ , where  $u = s - f(y)$ . Since the scalar curvature is almost constant on  $\Sigma(s)$  by Lemma [3.8,](#page-16-3) we have

$$
\frac{1}{1+|t|}R_i(y) \le (n-1)r_i^{-2}.
$$

The rest of the proof follows exactly like that of Proposition [3.16,](#page-26-5) and we can derive a contradiction as before.

In sum, the proof is complete.

**Corollary 3.20.** *Under the assumptions of Proposition* [3.19,](#page-33-3) *there exists*  $\hat{c}_5 = \hat{c}_5(n, A, B) > 0$  *such that*

$$
s \ge \frac{\hat{c}_5}{\epsilon_2} t_2 \quad and \quad R(q) \ge \frac{\hat{c}_5}{\epsilon_2}.
$$
 (3.103)

*Proof.* By our assumption ([†](#page-10-0)),  $R(q) = \epsilon_1 f(q) \ge n$ . Therefore, it follows from [\(3.91\)](#page-32-3) that

$$
s \ge \frac{n+1}{n(n-1)\hat{c}_4} \frac{t_2}{\epsilon_2}.
$$

Consequently,

$$
R(q) = \epsilon_1 s \ge \frac{n+1}{n(n-1)\hat{c}_4} \frac{\epsilon_1 t_2}{\epsilon_2} \ge \frac{n+1}{(n-1)\hat{c}_4} \frac{1}{\epsilon_2}.
$$

Next, we show that any point in *E* far away from  $\Sigma(t_0)$  is the center of an evolving  $\epsilon$ -neck. We omit the proof as it is similar to the proofs of Proposition [3.17](#page-30-3) and Proposition [3.19.](#page-33-3)

**Proposition 3.21.** *Under the assumptions* ([†](#page-10-0)), [\(3.65\)](#page-25-1) *and* [\(3.66\)](#page-25-2)*, for any*  $\epsilon > 0$ *, there exists*  $\eta_5 =$  $\eta_5(\epsilon, n, \delta_0, A, B) > 0$  such that if  $\epsilon_0 \leq \eta_5$ , then any point  $x \in \Sigma(\eta_5^{-1}t_0, s) \subset E^2$  is the center of an *evolving*  $∈$ *-neck.* 

For later applications, we show that any point in  $E<sup>2</sup>$  has a positive curvature operator.

**Proposition 3.22.** *Under the assumptions* ([†](#page-10-0)), [\(3.65\)](#page-25-1) *and* [\(3.66\)](#page-25-2)*, there exists*  $\sigma_5 = \sigma_5(n, A, B) > 0$ *such that if*  $\epsilon_0 \leq \sigma_5$ *, then* 

$$
Rm \ge \delta \epsilon_2 \frac{R^2}{f}
$$

*for*  $\delta = \delta(n) > 0$  *on*  $E^2$ *.*
*Proof.* From [\(3.6\)](#page-11-0), we have

$$
R_{abcd} = \frac{R}{(n-1)(n-2)}(g_{ac}g_{bd} - g_{ad}g_{bc}) + O(\epsilon_0 R).
$$

Moreover, it follows from [\(2.2\)](#page-6-0) that

$$
R_{abcn} = \frac{R_{abcl}f_l}{|\nabla f|} = \frac{\nabla_b R_{ac} - \nabla_a R_{bc}}{|\nabla f|} = \frac{\nabla_b \overset{\circ}{R}_{ac} - \nabla_a \overset{\circ}{R}_{bc} + \frac{\nabla_b R_{gac}}{n-1} - \frac{\nabla_a R_{gbc}}{n-1}}{|\nabla f|}.
$$

Therefore, it is clear from [\(3.18\)](#page-13-0) and Lemma [3.7](#page-15-0) that

<span id="page-36-2"></span>
$$
R_{abcn} = O(\epsilon_0^{\frac{1}{2}} f^{-\frac{1}{2}} R^{\frac{3}{2}}).
$$

In addition, from the computation in the proof of Proposition [2.2,](#page-6-1) we have

$$
R_{ancn} = \frac{2R_{akcl}R_{kl} - R_{kc}R_{ka} - R_{ac}/2 + \Delta R_{ac} - \nabla_{ac}^2 R/2}{|\nabla f|^2}.
$$
 (3.104)

From direct calculations,

$$
2R_{akcl}R_{kl} = 2R_{abcd}R_{bd} + 2R_{abcn}R_{bn} + 2R_{ancn}R_{nn}
$$
  
\n
$$
= 2R_{abcd}R_{bd} + O(f^{-1}R^{3}) + O(f^{-2}R^{4})
$$
  
\n
$$
= \frac{2R}{(n-1)(n-2)}(g_{ac}g_{bd} - g_{ad}g_{bc})R_{bd} + O(\epsilon_{0}R^{2}) + O(\epsilon_{1}R^{2})
$$
  
\n
$$
= \frac{2R^{2}g_{ac}}{(n-1)(n-2)} - \frac{2RR_{ac}}{(n-1)(n-2)} - \frac{2RR_{nn}}{(n-1)(n-2)} + O(\epsilon_{0}R^{2})
$$
  
\n
$$
= \frac{2R^{2}g_{ac}}{(n-1)^{2}} + O(\epsilon_{0}R^{2}),
$$
  
\n(3.105)

where we have used [\(3.4\)](#page-10-0) and [\(3.5\)](#page-10-1). In addition,

$$
R_{kc}R_{ka} = R_{bc}R_{ab} + R_{cn}R_{an} = \frac{R^2}{(n-1)^2} + O(\epsilon_0 R^2).
$$
 (3.106)

Combining [\(3.105\)](#page-36-0), [\(3.106\)](#page-36-1), [\(3.38\)](#page-18-0) and Lemma [3.10,](#page-19-0) it follows from [\(3.104\)](#page-36-2) that

$$
R_{ancn} = \frac{1}{|\nabla f|^2} \left( \frac{R^2}{(n-1)^2} - \frac{R}{2(n-1)} \right) g_{ac} + O(\epsilon_0^{\frac{1}{3}} f^{-1} R^2).
$$
 (3.107)

Since  $R \ge \frac{n-1}{2} + \frac{\epsilon_2}{2}$  on  $E^2$ , we obtain from [\(3.107\)](#page-36-3) that

<span id="page-36-3"></span><span id="page-36-1"></span><span id="page-36-0"></span>
$$
R_{\text{anan}} \ge c_1 \epsilon_2 \frac{R^2}{f}
$$

for some constant  $c_1 = c_1(n) > 0$ . For any two-form *w*, we decompose it as

$$
w = \tilde{w} + x_a e^a \wedge e^n,
$$

where  $\tilde{w}$  is the two-form on  $\Sigma$ . If we set  $|x| = \sqrt{\sum_{a=1}^{n-1} x_a^2}$ , then we compute

$$
Rm(w, w) = Rm(\tilde{w}, \tilde{w}) + 2x_a Rm(\tilde{w}, e^a \wedge e^n) + x_a x_b R_{anbn}
$$
  
\n
$$
\geq \frac{R}{(n-1)(n-2)} |\tilde{w}|^2 - c_2 \epsilon_0 R |\tilde{w}|^2 - c_2 |x| |\tilde{w}| \epsilon_0^{\frac{1}{2}} f^{-\frac{1}{2}} R^{\frac{3}{2}} + x_a x_b R_{anbn}
$$
  
\n
$$
\geq \frac{R}{(n-1)(n-2)} |\tilde{w}|^2 - c_2 \epsilon_0 R |\tilde{w}|^2 - c_2 |x| |\tilde{w}| \epsilon_0^{\frac{1}{2}} f^{-\frac{1}{2}} R^{\frac{3}{2}} + c_1 |x|^2 \epsilon_2 f^{-1} R^2 - c_3 |x|^2 \epsilon_0^{\frac{1}{3}} f^{-1} R^2
$$

for some constants  $c_2$  and  $c_3$  depending only on *n*, *A* and *B*. Since  $\epsilon_2 = \epsilon_0^{\frac{1}{4}}$ , it follows from the mean value inequality that

$$
Rm(w, w) \ge \frac{c_1}{2} \epsilon_2 f^{-1} R^2 (|x|^2 + |\tilde{w}|^2) = \frac{c_1}{2} \epsilon_2 f^{-1} R^2 |w|^2,
$$

if  $\epsilon_0$  is sufficiently small.

# 4 Estimates on the cap region

Throughout this section, we assume ([†](#page-10-2)), [\(3.89\)](#page-32-0), [\(3.90\)](#page-32-1) and  $\epsilon_0$  is small enough such that Proposition [3.19](#page-33-0) holds. We will fix  $\epsilon_1$  and choose  $\epsilon'_1$  to be a small parameter which may depend on  $\epsilon_1$ . In particular, we assume  $\epsilon'_1 \leq \epsilon_1^{\frac{1}{2}}$  and hence  $\epsilon_0 = \epsilon_1^{\frac{1}{2}}$  which is also fixed.

Define

$$
D := \text{the connected component of } M \setminus \text{Int } \Sigma(t_0, s) \text{ containing } \Sigma(s). \tag{4.1}
$$

From Proposition [3.18](#page-32-2) there exists a point  $q \in \Sigma(s)$  such that

$$
R(q) = \epsilon_1 f(q) = \epsilon_1 s.
$$

First we prove

<span id="page-37-2"></span>Proposition 4.1. *Under the above assumptions, there exist positive constants*  $m_1, m_2$  *depending only on n such that*

$$
\frac{0.9}{\epsilon_1^{-1} + m_2 L} \le \frac{R(y)}{s} \le \frac{1.1}{\epsilon_1^{-1} + m_1 L}
$$
(4.2)

*for any*  $L \in [0, s/2]$  *and*  $y \in \Sigma(s - L)$ *.* 

*Proof.* We first prove  $\Sigma(s/2, s) \subset E^2$ . Otherwise, there exist  $s_1 \in [s/2, s]$  and a point  $x \in \Sigma(s_1)$  such that  $\Sigma(s_1, s) \subset E^2$  and

<span id="page-37-1"></span><span id="page-37-0"></span>
$$
R(x) = \frac{n-1}{2} + \epsilon_2.
$$
 (4.3)

From [\(3.70\)](#page-26-0) we have on *E* that

$$
tR_t \ge \left(\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}}\right) R^2 - R.
$$

Consequently, solving the ODE yields that

<span id="page-38-0"></span>
$$
R(q^{t}) \ge \frac{1}{\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}} - \delta_1 t}
$$
\n(4.4)

for any  $t \in [s_1, s]$ , where  $q^t = \phi^{t-s}(q) \in \Sigma(t)$  and  $\delta_1$  is determined by

$$
\epsilon_1 s = R(q) = \frac{1}{\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}} - \delta_1 s}.
$$
\n(4.5)

Since  $R(q) \gg 1$  by [\(3.103\)](#page-35-0), it follows from [\(4.4\)](#page-38-0) and [\(4.5\)](#page-38-1) that

<span id="page-38-2"></span><span id="page-38-1"></span>
$$
R(q^{s_1}) \ge \frac{n}{2}.\tag{4.6}
$$

However, [\(4.6\)](#page-38-2) contradicts [\(4.3\)](#page-37-0) by Lemma [3.8.](#page-16-0)

Now it is clear that [\(4.4\)](#page-38-0) holds for any  $t \in [s/2, s]$ . Therefore, it follows from (4.4) and [\(4.5\)](#page-38-1) that for  $L \in [0, s/2]$ ,

$$
R(q^{s-L}) \ge \frac{1}{\frac{2}{n-1} - c_1 \epsilon_0^{\frac{1}{3}} - \delta_1(s-L)} = \frac{1}{\frac{1}{\epsilon_1 s} + \delta_1 s - \delta_1(s-L)} = \frac{1}{\frac{1}{\epsilon_1 s} + \delta_1 L}
$$

and hence

$$
\frac{R(q^{s-L})}{R(q)} \ge \frac{1}{1+\delta_1 s \epsilon_1 L}.\tag{4.7}
$$

From [\(4.5\)](#page-38-1) and the fact that  $R(q) \gg 1$ , we know that  $\delta_1 s \approx \frac{2}{n-1}$ <sup>2</sup>/<sub>*n*−1</sub>. Combining [\(4.7\)](#page-38-3) and Lemma [3.8,](#page-16-0) we conclude that

$$
\min_{\Sigma(s-L)} R \ge \frac{0.9R(q)}{1 + m_2 \epsilon_1 L}
$$

for some constant  $m_2 = m_2(n) \approx \frac{2}{n-1}$ . Therefore,

$$
\min_{\Sigma(s-L)} R \ge \frac{0.9s}{\epsilon_1^{-1} + m_2 L}.
$$

Now the other inequality in [\(4.2\)](#page-37-1) can be proved similarly by considering

$$
tR_t \leq \left(\frac{2}{n-1} + c_1 \epsilon_0^{\frac{1}{3}}\right) R^2 - R,
$$

which follows from  $(3.70)$ .

Next, we prove

<span id="page-39-6"></span>**Proposition 4.2.** *Under the above assumptions, for any small*  $\epsilon_1 > 0$ *, there exist*  $\tau_1 = \tau_1(\epsilon_1, n, \delta_0, A, B)$  $0$  *and*  $L_1 = L_1(\epsilon_1, n, \delta_0, A, B) > 0$  *such that if*  $\epsilon'_1 \leq \tau_1$ *, then* 

$$
diam_g D \le \frac{L_1}{\sqrt{s}} \quad and \quad \sup_D |f - s| \le L_1.
$$

*In particular, D is compact and*  $\partial D = \Sigma(s)$ *.* 

*Proof.* We prove it by contradiction. Suppose for fixed  $\epsilon_1$  the conclusion does not hold. Then there exists a sequence of Ricci shrinkers  $(M_i^n, g_i, f_i)$  satisfying all the assumptions with  $\epsilon'_{1,i} \to 0$  and

$$
\text{diam}_{g_i} D_i \ge \frac{i^2}{\sqrt{s_i}}, \quad \text{or} \quad \sup_{D_i} |f_i - s_i| \ge i^2. \tag{4.8}
$$

From Proposition [3.18,](#page-32-2) there exists a point  $q_i \in \Sigma(s_i)$  satisfying

<span id="page-39-5"></span><span id="page-39-0"></span>
$$
R_i(q_i) = \epsilon_1 f_i(q_i) = \epsilon_1 s_i.
$$

Now we define  $\tilde{f}_i := f_i - s_i$  and  $\tilde{g}_i := s_i g_i$ . From direct calculations, we have

$$
R_{\tilde{g}_i} + |\nabla_{\tilde{g}_i}\tilde{f}_i|^2_{\tilde{g}_i} = \frac{R_i + |\nabla_{g_i}f_i|^2_{g_i}}{s_i} = \frac{f_i}{s_i} = 1 + \frac{\tilde{f}_i}{s_i}
$$
(4.9)

and

$$
\text{Hess}_{\tilde{g}_i} \tilde{f}_i + R c_{\tilde{g}_i} = \text{Hess}_{g_i} f_i + R c_i = \frac{g_i}{2} = \frac{\tilde{g}_i}{2s_i}.
$$
\n(4.10)

For any  $L > 1$  and  $y \in B_{\tilde{g}_i}(q_i, L)$ , it follows from [\(4.9\)](#page-39-0) that

$$
|\tilde{f}_i(y)| \le 2L \quad \text{and} \quad R_{\tilde{g}_i}(y) \le 2 \tag{4.11}
$$

if *i* is sufficiently large. Therefore, it follows from [\(4.11\)](#page-39-1) and Theorem [3.1](#page-10-3) that

$$
|B_{\tilde{g}_i}(q_i, 1)|_{\mu_i} \ge v_0 \tag{4.12}
$$

for some  $v_0 = v_0(n, A) > 0$ , where  $\mu_i := e^{-\tilde{f}_i} dV_{\tilde{g}_i}$  is the weighted measure. Combining [\(4.9\)](#page-39-0)-[\(4.12\)](#page-39-2), it follows from the main result [\[44,](#page-74-0) Theorem 1.1] and its variant [\[44,](#page-74-0) Theorem 10.2] that by taking a subsequence if necessary,

$$
(M_i, q_i, \tilde{g}_i, \tilde{f}_i) \xrightarrow{\text{pointed-Gromov-Hausdorff}} (X_{\infty}, q_{\infty}, d_{\infty}, f_{\infty}), \tag{4.13}
$$

where  $(X_\infty, d_\infty)$  is a length space,  $f_\infty$  is a Lipschitz function on  $(X_\infty, d_\infty)$ . The space  $X_\infty$  has a natural regular-singular decomposition  $X_\infty = \mathcal{R} \cup \mathcal{S}$  satisfying

(a). The singular part  $S$  is a closed set of Minkowski codimension at least 4. Namely, we have

<span id="page-39-3"></span>
$$
\dim_{\mathcal{M}} S \le n - 4. \tag{4.14}
$$

(b). The regular part R is an open manifold with smooth metric *g*<sup>∞</sup> satisfying Ricci steady soliton equation

<span id="page-40-1"></span>
$$
Rc_{\infty} + \text{Hess}_{g_{\infty}} f_{\infty} = 0. \tag{4.15}
$$

(c). The convergence [\(4.13\)](#page-39-3) can be improved to

$$
(M_i, q_i, \tilde{g}_i, \tilde{f}_i) \xrightarrow{\text{pointed} - \hat{C}^{\infty} - \text{Cheeger} - \text{Gromov}} (X_{\infty}, q_{\infty}, g_{\infty}, f_{\infty}).
$$
\n
$$
(4.16)
$$

(d). On the regular part  $\mathcal{R}$ ,

<span id="page-40-2"></span><span id="page-40-0"></span>
$$
R_{\infty} + |\nabla f_{\infty}|^2 = 1. \tag{4.17}
$$

Note that  $(4.16)$  implies that away from S, the convergence is smooth. This follows from the bootstrapping argument based on [\(4.9\)](#page-39-0) and [\(4.10\)](#page-39-4), see [\[44\]](#page-74-0). Moreover, [\(4.15\)](#page-40-1) and [\(4.17\)](#page-40-2) follow from [\(4.10\)](#page-39-4) and [\(4.9\)](#page-39-0), respectively, by taking the limit.

In addition, it follows from [\[34,](#page-74-1) Theorem 4.10] that the regular part  $\mathcal R$  is geodesically convex. Therefore, the limit  $(X_\infty, q_\infty, d_\infty, f_\infty)$  is a Ricci steady soliton conifold in the sense of Definition [A.1.](#page-60-0)

By our assumptions, any point  $y \in B_{\tilde{g}_i}(q_i, L) \cap E_i^2$  satisfies ([†](#page-10-2)) and [\(4.2\)](#page-37-1). Furthermore, *y* is an evolving  $\epsilon$ -neck by Proposition [3.21.](#page-35-1) Therefore, the corresponding limit set  $E_{\infty}$  of  $E_i^2$  under the convergence [\(4.16\)](#page-40-0) is an end of  $(X_\infty, d_\infty)$ . On the other hand, it follows from Theorem [A.22](#page-66-0) that  $(X_\infty, d_\infty)$  has only one end. In other words,  $D_\infty := X_\infty \backslash E_\infty$  is a compact set, which fact in turn yields that  $\text{diam}_{d_{\infty}} D_{\infty} < \infty$ . Since  $f_{\infty}$  is 1-Lipschitz and  $f_{\infty}(q_{\infty}) = 0$ , it is clear that  $\sup_{\Omega} |f_{\infty}| < \infty$ . *D*<sup>∞</sup>

Therefore, for some  $L_1 > 0$  and sufficiently large *i*, we have

$$
\text{diam}_{\tilde{g}_i} D_i \le L_1, \quad \sup_{D_i} |f_i - s_i| \le L_1,
$$

which contradicts [\(4.8\)](#page-39-5). The proof is established by this contradiction.  $\Box$ 

We have the following definition, which measures how close the neighborhood of a point in a Ricci shrinker is to a Ricci steady soliton conifold.

**Definition 4.3** (Center of an  $\epsilon$ -steady soliton conifold). Let  $(M^n, g, f)$  be a Ricci shrinker and let  $\bar{x} \in M$  such that  $f(\bar{x}) = s$ . We say that  $\bar{x}$  is the center of an  $\epsilon$ -steady soliton conifold if, after *rescaling the metric by the factor s, the neighborhood*  $B_g(\bar{x}, \epsilon^{-1} s^{-\frac{1}{2}})$  *is*  $\epsilon$ *-close in the Gromov-Hausdorff sense to a nontrivial*  $(X, q, d, f) \in \mathfrak{S}(n)$ *.* 

From the proof of Proposition [4.2,](#page-39-6) we immediately have

<span id="page-40-3"></span>**Corollary 4.4.** *Under the above assumptions, for any*  $\epsilon$ ,  $\epsilon_1 > 0$ , *there exists*  $\tau_2 = \tau_2(\epsilon, \epsilon_1, n, \delta_0, A, B) >$ 0 such that if  $\epsilon'_1 \le \tau_2$ , then any point in D is the center of an  $\epsilon$ -steady soliton conifold.

Next, we estimate the scalar curvature on the cap region. Before that, we recall the following Sobolev inequality proved in [\[48\]](#page-75-0).

<span id="page-41-3"></span>**Theorem 4.5.** ([\[48,](#page-75-0) Theorem 1]) *For any Ricci shrinker*  $(M^n, g, f)$  *with*  $\mu(g) \geq -A$ *, there exists a*  $C = C(n, A) > 0$  *such that for any compactly supported locally Lipschitz function u, we have* 

$$
\left(\int u^{\frac{n}{n-2}}\,dV\right)^{\frac{n-2}{n}}\leq C\int 4|\nabla u|^2+Ru^2\,dV.
$$

Notice that the Sobolev inequality is scaling-invariant and also holds at different time slices of the Ricci flow associated with a Ricci shrinker. Now we have

<span id="page-41-6"></span>**Proposition 4.6.** *Under the above assumptions, for any small*  $\epsilon_1 > 0$ *, there exist positive numbers*  $\tau_3 = \tau_3(\epsilon_1, n, \delta_0, A, B)$  and  $L_2 = L_2(\epsilon_1, n, \delta_0, A, B)$  such that if  $\epsilon'_1 \leq \tau_3$ , then

<span id="page-41-5"></span>
$$
L_2^{-1} s \le R \le s + L_1 \tag{4.18}
$$

*on D, where L*<sup>1</sup> *is the same constant in Proposition [4.2.](#page-39-6)*

*Proof.* Without loss of generality, we assume  $\tau_3 \leq \tau_1$  and the conclusion of Proposition [4.2](#page-39-6) holds. In particular, we have

$$
R(y) \le f(y) \le s + L_1, \quad \forall y \in D. \tag{4.19}
$$

For the other direction, we assume the inequality does not hold. Then there exists a sequence of Ricci shrinkers  $(M_i^n, q_i, g_i, f_i)$  satisfying all the assumptions with  $\epsilon'_{1,i} \to 0$  such that

<span id="page-41-4"></span><span id="page-41-2"></span>
$$
R_i(x_i) < i^{-2} s_i \tag{4.20}
$$

for some  $x_i \in D_i$ . For  $t \leq 0$ , we define

$$
\tilde{g}_i(t) := s_i g_i(s_i^{-1}t), \quad \tilde{F}_i(t) := F_i(s_i^{-1}t) - s_i, \quad \tilde{\Box}_i := \partial_t - \Delta_{\tilde{g}_i(t)},
$$

where  $F_i(t) = (1 - t) f_i(t)$ . Direct calculation shows that

$$
|\nabla_{\tilde{g}_i(t)} \tilde{F}_i(t)|_{\tilde{g}_i(t)}^2 = s_i^{-1} |\nabla_{g_i(s_i^{-1}t)} F_i(s_i^{-1}t)|_{g_i(s_i^{-1}t)}^2 = \frac{F_i(s_i^{-1}t) - (1 - s_i^{-1}t)^2 R_{g_i(s_i^{-1}t)}}{s_i}.
$$

Thus we obtain

<span id="page-41-1"></span><span id="page-41-0"></span>
$$
|\nabla_{\tilde{g}_i(t)} \tilde{F}_i(t)|_{\tilde{g}_i(t)}^2 + (1 - s_i^{-1}t)^2 R_{\tilde{g}_i(t)} = 1 + \frac{\tilde{F}_i(t)}{s_i}.
$$

Moreover, we compute

$$
\partial_t \tilde{F}_i(t) = s_i^{-1} \partial_t F_i(s_i^{-1} t) = -s_i^{-1} (1 - s_i^{-1} t) R_{g_i(s_i^{-1} t)} = -(1 - s_i^{-1} t) R_{\tilde{g}_i(t)}
$$
(4.21)

and

$$
\Delta_{\tilde{g}_i(t)} \tilde{F}_i(t) = s_i^{-1} \Delta_{g_i(s_i^{-1}t)} F_i(s_i^{-1}t) = s_i^{-1} \left( \frac{n}{2} - (1 - s_i^{-1}t) R_{g_i(s_i^{-1}t)} \right) = \frac{n}{2s_i} - (1 - s_i^{-1}t) R_{\tilde{g}_i(t)}.
$$
 (4.22)

Combining [\(4.21\)](#page-41-0) and [\(4.22\)](#page-41-1), we obtain

<span id="page-42-1"></span>
$$
\tilde{\Box}_i \tilde{F}_i(t) = (\partial_t - \Delta_{\tilde{g}_i(t)}) \tilde{F}_i(t) = -\frac{n}{2s_i}.
$$
\n(4.23)

Now we define the following parabolic balls

$$
P_i^1 := \{(y, t) \mid |\tilde{F}_i(y, t)| \le 2L_1, -2L_1 \le t \le 0\},
$$
  

$$
P_i^2 := \{(y, t) \mid |\tilde{F}_i(y, t)| \le 4L_1, -4L_1 \le t \le 0\}.
$$

In the following proof, all positive constants  $C_i$  in the following proof depend only on  $n$ ,  $\delta_0$ ,  $A$ ,  $B$ and  $\epsilon_1$  and the corresponding inequalities hold for sufficiently large *i*. It follows from [\(4.2\)](#page-37-1) and [\(4.19\)](#page-41-2) that

<span id="page-42-0"></span>
$$
0 \le R_{\tilde{g}_i(t)} \le C_1 \tag{4.24}
$$

on  $P_i^2$ , since by the definition we know

$$
R_{\tilde{g}_i(t)}(z) = s_i^{-1} R_{g_i(s_i^{-1}t)}(z) = s_i^{-1} (1 - s_i^{-1}t)^{-1} R_{g_i(0)}(\psi_i^{s_i^{-1}t}(z))
$$

for any point *z*. Since  $\tilde{F}_i(q_i, 0) = 0$ , it follow from [\(4.21\)](#page-41-0) and [\(4.24\)](#page-42-0) that

$$
0 \leq \tilde{F}_i(q_i, t) \leq C_2
$$

for *t* ∈  $[-4L_1, 0]$ .

Claim 1. Suppose *u* is a nonnegative function such that

<span id="page-42-2"></span>
$$
\tilde{\Box}_i u \le 0, \quad \text{on } P_i^2.
$$

Then we have

$$
\max_{P_i^1} u^2 \le C_3 \iint_{P_i^2} u^2 \, dV_{\tilde{g}_i(t)} dt \tag{4.25}
$$

for some  $C_3 > 0$ .

*Proof of Claim 1:* The proof follows verbatim as [\[44,](#page-74-0) Lemma 9.7] by using the Moser iteration. Notice that the Sobolev inequality and the control of  $R_{\tilde{g}_i(t)}$  on  $P_i^2$  are guaranteed by Theorem [4.5](#page-41-3) and [\(4.24\)](#page-42-0) respectively. Moreover, the cutoff functions  $\eta_k$  in the proof of [\[44,](#page-74-0) Lemma 9.7] can be defined similarly by using  $\tilde{F}_i$  and  $\eta_k$  can be estimated similarly by using [\(4.23\)](#page-42-1). We omit the details.

Next we define for any  $\tau > 0$ ,

$$
P_i(\tau) = P_i^2 \cap \{(z, t) \mid R_{\tilde{g}_i(t)}(z) < \tau\}.
$$

**Claim 2.** There exists a constant  $C_4 > 0$  such that

<span id="page-42-3"></span>
$$
|P_i(2i^{-2})| \ge C_4. \tag{4.26}
$$

Here the volume is with respect to  $dV_{\tilde{g}_i(t)}dt$ .

*Proof of Claim 2:* It follows from [\(4.20\)](#page-41-4) that  $(x_i, 0) \in P_i^1$ . Then the proof follows exactly as that of [\[44,](#page-74-0) Lemma 9.8] by using [\(4.25\)](#page-42-2).

It is clear from [\(4.26\)](#page-42-3) that for any *i* sufficiently large, there exists  $t_i \in [-2L_1, 0]$  such that

$$
|\Sigma_i|_{dV_{\tilde{g}_i(t_i)}} \geq C_5,
$$

where  $\Sigma_i = M_i \times \{t_i\} \cap P_i(2i^{-2})$  and  $C_5 = \frac{C_4}{2L_1}$  $\frac{C_4}{2L_1}$ . Now, we define

<span id="page-43-0"></span>
$$
\Omega_i := \psi_i^{s_i^{-1}t_i} \left( \mathrm{pr}(\Sigma_i) \right)
$$

where pr is the projection onto  $M_i$ . Then we compute

$$
|\Omega_i|_{dV_{\bar{g}_i(0)}} \ge \frac{1}{2} (1 - s_i^{-1} t_i)^{\frac{n}{2}} |\Omega_i|_{dV_{\bar{g}_i(0)}} = \frac{1}{2} |\Sigma_i|_{dV_{\bar{g}_i(t_i)}} \ge C_6,
$$
\n(4.27)

where  $C_6 = C_5/2$ . On the other hand, for any  $(z, t_i) \in \Sigma_i$ , we have

$$
\tilde{F}_i(z, t_i) = F_i(z, t) - s_i = (1 - s_i^{-1} t_i) f_i(z', 0) - s_i
$$

where  $z' = \psi_i^{s_i^{-1}t_i}$  $i_i^{s_i \tcdot t_i}(z)$ . Therefore, it follows from the definition of  $P_i^2$  and [\(4.18\)](#page-41-5) that

$$
|\tilde{f}_i(z')| = |f_i(z', 0) - s_i| \le 4L_1 + 1. \tag{4.28}
$$

As in the proof of Proposition [4.2,](#page-39-6) by taking a subsequence if necessary, we have

$$
(M_i, q_i, \tilde{g}_i, \tilde{f}_i) \xrightarrow{\text{pointed} - \hat{C}^{\infty} - \text{Cheeger} - \text{Gromov}} (M_{\infty}, q_{\infty}, g_{\infty}, f_{\infty}),
$$

where  $(M_{\infty}, q_{\infty}, g_{\infty}, f_{\infty})$  is a steady soliton conifold. Notice that  $\lim_{z\to\infty} f_{\infty}(z) = -\infty$  by our as-sumptions. Combining [\(4.27\)](#page-43-0) and [\(4.28\)](#page-43-1), we conclude that there exists a point  $z \in \mathcal{R}$  such that

$$
R_{g_{\infty}}(z)=0.
$$

By applying the strong maximum principle for  $\Delta_{f_\infty} R_\infty = -2|Rc_\infty|^2 \le 0$ , we conclude that  $R_\infty \equiv 0$ on *R*. However, this contradicts the fact that  $R_{\infty}(q_{\infty}) = \epsilon_1$ .

In sum, the proof is complete.

As observed above, the cap region is modeled on a steady soliton conifold if  $\epsilon'_1$  is sufficiently small. In general, it is difficult to classify all steady soliton conifolds even though there are no singularities. However, under some special conditions, we can classify all such steady soliton conifolds. For the definition of PIC2, see [\[2,](#page-72-0) Section 7.5].

<span id="page-43-2"></span>**Theorem 4.7.** *Let*  $(X, p, d, f) \in \mathfrak{S}(n)$  *be non-compact such that*  $(\mathcal{R}, g)$  *has* PIC2*. Suppose there exists a compact set C satisfying*

*(a). The singular part*  $S \subset C$ .

<span id="page-43-1"></span>

- *(b). For any*  $x \in X \backslash C$ , the scalar curvature satisfies  $\frac{c_1}{d(p, x)} \le R(x) \le \frac{c_2}{d(p, x)}$  $\frac{c_2}{d(p,x)}$ , where  $c_1, c_2$  are *two positive constants.*
- *(c). For any sequence*  $q_i \to \infty$ ,  $q_i$  *is the center of an evolving*  $\epsilon_i$ *-neck with*  $\epsilon_i \to 0$ *.*

*Then* (*X*, *d*) *is isometric to the Bryant soliton up to scaling.*

*Proof.* Since  $(R, g)$  has PIC2 on R, it implies that  $sec \ge 0$  on R. Combined with the identity  $R + |\nabla f|^2 = 1$  as  $(X, d)$  is nontrivial, we conclude that  $|Rm|$  is uniformly bounded on R. For any *x* ∈ R, we define  $\lambda = \lambda(x)$  to be the largest constant such that *S* := *Rm* −  $\lambda$ *I* has weakly PIC2. By our assumption,  $\lambda > 0$  on  $\mathcal{R}$ .

**Claim 1.**  $\lambda$  satisfies the following inequality on  $\mathcal{R}$ .

<span id="page-44-1"></span><span id="page-44-0"></span> $\Delta_f \lambda$  ≤ 0

*Proof of the Claim 1:* By our definition, *S* is contained in the boundary of PIC2 cone. For fixed *x* ∈ R, there exists a four-frame { $e_1, e_2, e_3, e_4$ } ∈  $T_xM$  and constants  $u, v$  ∈ [0, 1] such that

$$
S_{1313} + u^2 S_{1414} + v^2 S_{2323} + u^2 v^2 S_{2424} - 2uv S_{1234} = 0.
$$

Therefore, it follows from [\[2,](#page-72-0) Proposition 7.21] that

$$
Q(S)_{1313} + u^2 Q(S)_{1414} + v^2 Q(S)_{2323} + u^2 v^2 Q(S)_{2424} - 2uvQ(S)_{1234} \ge 0,
$$
 (4.29)

where  $Q$  is a quadratic term of the curvature tensor, see [\[31\]](#page-74-2) for its precise definition.

In addition, we have

$$
Q(S) = Q(Rm) - 2\lambda Rc \otimes \text{id} + 2(n-1)\lambda^2 I,
$$
\n(4.30)

where  $\oslash$  is the Kulkarni-Nomizu product. Therefore, it follows from [\(4.29\)](#page-44-0) and [\(4.30\)](#page-44-1) that

$$
Q(Rm)_{1313} + u^2 Q(Rm)_{1414} + v^2 Q(Rm)_{2323} + u^2 v^2 Q(Rm)_{2424} - 2uvQ(Rm)_{1234}
$$
  
\n
$$
\geq 2\lambda \left(R_{11} + R_{33} + u^2(R_{11} + R_{44}) + v^2(R_{22} + R_{33}) + u^2 v^2(R_{22} + R_{44})\right)
$$
  
\n
$$
-2(n-1)\lambda^2 (1+u^2+v^2+u^2v^2) \geq 0,
$$

where for the last inequality, we have used  $R_{ii} \ge (n-1)\lambda$  since *S* has weakly PIC2. Therefore, we conclude that

$$
\Delta_f \lambda \le \frac{\Delta_f(Rm)_{1313} + u^2 \Delta_f(Rm)_{1414} + v^2 \Delta_f(Rm)_{2323} + u^2 v^2 \Delta_f(Rm)_{2424} - 2uv \Delta_f(Rm)_{1234}}{(1+u^2)(1+v^2)}
$$
  
= 
$$
-\frac{Q(Rm)_{1313} + u^2 Q(Rm)_{1414} + v^2 Q(Rm)_{2323} + u^2 v^2 Q(Rm)_{2424} - 2uv Q(Rm)_{1234}}{(1+u^2)(1+v^2)} \le 0
$$

at *x*, where we have used the equation  $\Delta_f Rm = -Q(Rm)$ .

Hence, we have on  $\mathcal{R}$ ,

 $\Delta_f \lambda$  ≤ 0.

Since  $\lambda$  is positive on  $\mathcal{R}$ , it follows from Proposition [A.10](#page-62-0) that

<span id="page-45-0"></span>
$$
\inf_{K \cap \mathcal{R}} \lambda > 0 \tag{4.31}
$$

for any compact set *K*. Since the regular part  $\mathcal R$  is geodesically convex and  $(X, d)$  is the completion of  $(R, g)$ , it follows from [\[61\]](#page-75-1) that  $(X, d)$  is an Alexandrov space with  $sec \geq 0$ .

**Claim 2.**  $f$  is a concave function on  $(X, d)$  with a unique critical point.

*Proof of the Claim 2:* Since Hess  $f = -Rc < 0$ , it is clear that f is concave on  $(\mathcal{R}, g)$  in the sense that for any geodesic  $\gamma(t)$  contained in R,  $f(\gamma(t))$  is concave. Now we fix a geodesic  $\gamma(t)_{t\in[0,L]}$  in X such that  $\gamma(0) = x$  and  $\gamma(L) = y$ . For any small number  $\epsilon > 0$ , we set  $x' = \gamma(\epsilon)$  and  $y' = \gamma(L - \epsilon)$ . Since R is dense, we can take two sequences  $x_n \to x'$  and  $y_n \to y'$  such that  $x_n$  and  $y_n$  are contained in R. From the geodesical convexity of R, there exists a geodesic  $\gamma_n \subset \mathcal{R}$  connecting  $x_n$  and  $y_n$ . Since the geodesic in an Alexandrov space is not branching,  $\gamma_n$  converges to  $\gamma(t)_{t \in [\epsilon, L-\epsilon]}$ . By taking the limit, we immediately conclude that  $f(\gamma(t))$  is concave for  $t \in [\epsilon, L - \epsilon]$ . Since  $\epsilon > 0$  is arbitrary,  $f(\gamma(t))$  is concave for any  $t \in [0, L]$ . Therefore, f is concave in the sense of [\[60,](#page-75-2) Definition 1.1].

We fix a point  $x \in X$ . Starting from *x*, we denote the gradient flow of *f* by  $\alpha(t)$  for  $t \ge 0$ , see [\[60,](#page-75-2) Section 2]. If  $\alpha(t)_{t\in[0,\infty)}$  is contained in a compact set *K* of *X*, then there exists a sequence  $t_i \to \infty$ such that  $|\nabla f|(\alpha(t_i)) \to 0$ , since f is bounded on K. By taking a subsequence, we may assume  $\alpha(t_i)$  converges to a point  $y \in K$ . By the lower semicontinuity of  $|\nabla f|$  [\[60,](#page-75-2) Corollary 1.3.5], *y* is a critical point of *f*. If  $\alpha(t)_{t \in [0,\infty)}$  is not contained in any compact set, there exists a sequence  $s_i$  such that  $\alpha(s_i) \to \infty$ . By our assumption (b),  $R(\alpha(s_i)) \to 0$ . However, this contradicts the fact that *R* is increasing along  $\alpha(t)$  as long as  $\alpha(t)$  is outside *C* since  $\langle \nabla R, \nabla f \rangle = 2Rc(\nabla f, \nabla f) \ge 0$ . In any case, *f* has a critical point. Without loss of generality, we set *p* to be a critical point of *f* .

It follows from [\(4.31\)](#page-45-0) that for any constant *c*, there exists a constant  $\delta > 0$  such that  $(X_c, d)$  is an Alexandrov space with  $sec \ge \delta$ , where  $X_c = \{x \in C \mid f(x) \ge c\}$ . By this reason, f is a strictly concave function on *X*. Therefore, it is a standard fact that  $p$  is the unique critical point which is also the maximum point.

#### Claim 3.  $X\setminus\{p\} \subset \mathcal{R}$ .

*Proof of the Claim 3:* Otherwise, we set  $q \in S$  and  $q \neq p$  such that  $f(q) = t$  is minimal. Notice that by our assumption (b), the choice of *t* is possible. By our assumption,  $|\nabla f|(q) > 0$  since *p* is the only critical point of *f* . From the lower semicontinuity of |∇*f* | [\[60,](#page-75-2) Corollary 1.3.5], we conclude that there exists a small  $\delta > 0$  such that

<span id="page-45-2"></span><span id="page-45-1"></span>
$$
|\nabla f| \ge \delta \tag{4.32}
$$

on  $B(q, \delta)$ . Now we take any positive sequence  $r_i \rightarrow 0$  and define  $d_i = r_i^{-1}d$ ,  $g_i = r_i^{-2}g$  and  $f_i = r_i^{-1}(f - f(q))$ . From the definition, it is clear that on R

$$
\text{Hess}_{g_i} f_i = -r_i^{-1} R c_i. \tag{4.33}
$$

Now we have

$$
(X, q, d_i, f_i) \xrightarrow{\text{pointed-Gromov-Hausdorff}} \left(K_q, 0, d_\infty, f_\infty\right),
$$

where ( $K_a$ ,  $d_\infty$ ) is the tangent cone at *q* and  $f_\infty$  is a locally Lipschitz function. In addition, it follows from [\(4.33\)](#page-45-1) and the same arguments in Claim 1 that  $f_{\infty}$  is both concave and convex on  $K_q$ .

For any  $s < t$ , it is clear from our choice of  $t$  that  $f^{-1}(s) \cap B(q, \delta) \subset \mathcal{R}$  on which the  $|Rm|$  is uniformly bounded. Moreover, for any  $x \in f^{-1}(s) \cap B(q, \delta)$ , it follows from [\(4.32\)](#page-45-2) that the second fundamental form at *x*, which is  $\frac{\text{Hess } f}{|\nabla f|}(x)$ , is uniformly bounded. Therefore, we conclude that

$$
\left(f_i^{-1}((-\infty,0)), q, g_i, f_i\right) \xrightarrow{C^{\infty}-Cheeger-Gromov} \left(f_{\infty}^{-1}((-\infty,0)), 0, d_{\infty}, f_{\infty}\right).
$$

Here, for the smooth convergence, we have used  $\Delta_f Rm = -Q(Rm)$  to obtain the higher order estimates of *Rm* on  $f^{-1}(s) \cap B(q, \delta)$ . Moreover, we have

$$
(f_\infty^{-1}((-\infty,0)),d_\infty)=(\mathbb{R}^n\cap\{x_n<0\},g_E).
$$

In particular, it follows from the smooth convergence of  $f_i$  to  $f_\infty$  on  $f_\infty^{-1}((-\infty, 0))$  and [\(4.32\)](#page-45-2) that *f*<sup>∞</sup> is not a constant. Since *f*<sup>∞</sup> is both convex and concave, it is clear (see [\[60,](#page-75-2) Lemma 2.1.4]) that  $(K_q, d_\infty)$  is isometric to  $(Y \times \mathbb{R}, d' \times g_E)$ , where *Y* is a metric cone isometric to any level set of  $f_\infty$ . Therefore, it is immediate from [\(4.33\)](#page-45-1) that *Y* is smooth and hence isometric to  $\mathbb{R}^{n-1}$ . From this, we conclude that  $(K_q, d_\infty)$  is isometric to  $(\mathbb{R}^n, g_E)$ . However, this implies that  $q \in \mathcal{R}$ , which contradicts our assumption.

#### Claim 4. *p* ∈ R.

*Proof of the Claim 4:* From Claim 2, any point in *X*\{*p*} is regular with uniformly bounded |*Rm*|. Therefore, for any sequence  $r_i \rightarrow 0$ , the convergence

$$
(X, p, r_i^{-1}d) \xrightarrow{pointed-Gromov-Hausdorff} (K_p, 0, d_\infty)
$$

is smooth away from the vertex. Moreover,

<span id="page-46-0"></span>
$$
(K_p, d) = (\mathbb{R}^n / \Gamma, g_E) \tag{4.34}
$$

where  $\Gamma \leq O(n)$  is a finite subgroup acting freely on  $S^{n-1}$ . If we set the nontrivial level set of *f* by Σ, then near *p* we have two foliations by Σ and  $S^{n-1}/\Gamma$  respectively. Then it is easy to see that Σ and  $S^{n-1}/\Gamma$  are *h*-cobordant. Indeed, by our assumption, there exist a region in *M* homeomorphic to  $\Sigma \times [0, 4]$  and an embedding of  $N \times [1, 3]$  into the interior of  $\Sigma \times [1, 4]$  such that  $N \times \{k\}$  separates  $\Sigma \times \{k\}$  and  $\Sigma \times \{k+1\}$  for  $1 \leq k \leq 3$ . By an easy topological argument, the compact manifold bounded by  $N \times \{1\}$  and  $\Sigma \times \{3\}$  is a cobordism such that the boundary inclusions are homotopy equivalences. In particular, Σ and *N* are homotopic and hence Γ must be trivial. From [\(4.34\)](#page-46-0), we have

$$
(K_p,d)=(\mathbb{R}^n,g_E)
$$

and hence  $p \in \mathcal{R}$ .

In sum, we have proved that  $S = \emptyset$  and hence  $(X, p, d, f)$  is a smooth steady soliton. The rest of the proof follows from the classification theorem of Brendle [\[3,](#page-72-1) Theorem 1.2].

Combining the results in Section 3 and Section 4, we are able to prove Theorem [1.2](#page-3-0) now. Let us first recall and fix notations.

For any constants  $n, \delta_0, A, B$  and  $\epsilon$ , we define the following constants:

- Let  $\bar{\sigma} := \min{\lbrace \sigma_1(n, B), \sigma_2(n, \delta_0, A, B), \sigma_3(n, \delta_0, A, B), \sigma_4(n, \delta_0, A, B), \sigma_5(n, A, B) \rbrace}$ , where  $\sigma_1$ ,  $\sigma_2$ ,  $\sigma_3$ ,  $\sigma_4$  and  $\sigma_5$  are functions in Proposition [3.4,](#page-11-1) Proposition [3.11,](#page-20-0) Proposition [3.16,](#page-26-1) Proposition [3.19](#page-33-0) and Proposition [3.22,](#page-35-2) respectively.
- Let  $\bar{\eta}$  := min{ $\eta_3(\epsilon, n, \delta_0, A, B)$ ,  $\eta_4(\epsilon, n, \delta_0, A, B)$ ,  $\eta_5(\epsilon, n, \delta_0, A, B)$ }, where  $\eta_3$ ,  $\eta_4$  and  $\eta_5$  are functions in Proposition [3.12,](#page-23-0) Proposition [3.17](#page-30-0) and Proposition [3.21,](#page-35-1) respectively.
- Let  $\sigma \coloneqq \min\{\bar{\sigma}^2, \bar{\eta}^2\}.$
- Let  $\eta := \min\{\sigma^{\frac{1}{2}}, \overline{\eta}, \tau_1(\sigma, n, \delta_0, A, B), \tau_2(\sigma, n, \delta_0, A, B), \tau_3(\sigma, n, \delta_0, A, B)\}\)$ , where  $\tau_1$ ,  $\tau_2$  and  $\tau_3$ are functions in Proposition [4.2,](#page-39-6) Corollary [4.4](#page-40-3) and Proposition [4.6,](#page-41-6) respectively.
- Let  $L := \max\{L_1(\sigma, n, \delta_0, A, B), L_2(\sigma, n, \delta_0, A, B)\}$ , where  $L_1$  and  $L_2$  are functions in Proposition [4.2](#page-39-6) and Proposition [4.6,](#page-41-6) respectively.

We close this section with the proof of Theorem [1.2.](#page-3-0)

*Proof of Theorem [1.2.](#page-3-0)* From our assumptions, the condition [\(1.5\)](#page-3-1) in particular holds for  $\epsilon_1 = \sigma$  and  $\epsilon'_1 = \eta$ . With our choice of  $\sigma$ ,  $\eta$  and *L*, it is clear from the results of Section 3 and Section 4 that the conclusion holds.

## 5 Proof of the main theorem

The purpose of this section is to prove Theorem [1.1.](#page-1-0) As we discussed in the introduction, the key ingredient is to show each point in the Ricci shrinker is either in a cylinder-like neighborhood or in a Bryant-soliton-like neighborhood, then we apply the symmetry improvement argument.

We recall the following definition of the curvature cone from [\[8\]](#page-72-2). Here  $\mathscr{C}_B(\mathbb{R}^n)$  denotes the vector space of algebraic curvature tensor.

**Definition 5.1.** A cone  $\hat{C}$  in  $\mathscr{C}_B(\mathbb{R}^n)$  has the property  $(*)$  if it satisfies the following conditions:

- $\hat{C}$  *is closed, convex, O(n)-invariant, and of full-dimension.*
- $\hat{C}$  *is transversally invariant under Hamilton's ODE:*  $\frac{dRm}{dt} = Q(Rm)$ .
- *Every algebraic curvature tensor Rm* <sup>∈</sup> *<sup>C</sup>*ˆ\{0} *has positive scalar curvature.*
- *The identity I lies in the interior of C.*ˆ

For later applications, we mainly consider the following example from [\[4,](#page-72-3) Definition 2.2].

<span id="page-47-0"></span>**Example 5.2.** *For any parameter*  $\sigma \in (0, 2)$  *and*  $\theta \ge 0$ *, we define the cone*  $C_{\sigma\theta}$  *as the set* 

 ${Rm = S + H \bigotimes id \mid S \in PIC2, Re_0(S) = 0, tr(H)id - (n - 2\sigma)H \geq 0, tr(H) - \theta \text{scal}(S) \geq 0}$ 

where *H* is a symmetric bilinear form,  $\oslash$  is the Kulkarni-Nomizu product, Rc<sub>0</sub> is the traceless Ricci, *and* PIC2 *denotes the cone consists of curvature tensor satisfying the weakly PIC2 condition. It* *follows from* [\[4,](#page-72-3) Theorem 2.5] *and the definition that*  $C_{\sigma\theta}$  *has the property* (\*) *if*  $\sigma \in (1,2)$  *and*  $\theta \in (0, \bar{\theta}(n))$  *for a constant*  $\bar{\theta}$  *depending only on n.* 

*We denote*  $C_{1+\theta\theta}$  *by*  $\hat{C}(\theta)$  *for*  $\theta \in (0, \min\{1/2, \bar{\theta}\})$ *. It is clear from the definition that* 

<span id="page-48-5"></span>
$$
Rc \ge -C(n)\theta R\tag{5.1}
$$

*for any Rm*  $\in \hat{C}(\theta)$ *. Furthermore, it is easy to see that the curvature tensor of*  $S^{n-1} \times \mathbb{R}$  *lies in*  $\hat{C}(\theta)$ *. Indeed, we can write the curvature tensor as Rm* = *H*  $\odot$  id, where  $H_{ij} = \delta_{ij}$  for *i*, *j*  $\geq 2$  *and*  $H_{1i} = -\delta_{1i}$  *and hence it is easy to check from the definition.* 

If a cone  $\hat{C}$  has the property (\*), we have the following result (see, e.g., [\[55,](#page-75-3) Lemma 4.2]).

<span id="page-48-0"></span>**Lemma 5.3.** Let  $\hat{C}$  in  $\mathscr{C}_B(\mathbb{R}^n)$  be a cone with property (\*). Then there exists two positive constants τ *and K depending only on the cone such that*

$$
Q(Rm) - \tau R^2 I \in T_{Rm}\hat{C} \quad and \quad |Rm| \le KR
$$

*for any Rm*  $\in \hat{C}$ *.* 

We prove the following theorem, which implies that locally the Ricci flow associated with a Ricci shrinker almost preserves the cone  $\hat{C}$ . Recall that on the Ricci flow associated with a Ricci shrinker,  $F(x, t) := (1 - t)f(x, t)$  for any  $t < 1$ . Moreover, the constant  $\tau$  and K are from Lemma [5.3](#page-48-0) which depends only on the cone  $\hat{C}$ .

<span id="page-48-4"></span>**Theorem 5.4.** *Let*  $\hat{C}$  *in*  $\mathcal{C}_B(\mathbb{R}^n)$  *be a cone with* (\*)*. There exist constants*  $\delta = \delta(n, \tau, K) > 0$  *and*  $C = C(n) > 0$  *satisfying the following property. For any Ricci flow*  $(M^n, g(t))_{t \leq 1}$  *associated with a Ricci shrinker, we define*  $\lambda(x, t)$  *be the minimal number such that*  $Rm(x, t) + \lambda(x, t)I \in \hat{C}$ *, for any*  $f(x, t)$  ∈ *M* ×  $(-\infty, 1)$ *. For any r* > 0,  $\epsilon$  > 0, if  $\epsilon$  +  $r^{-2}$  ≤  $\delta$ *R on*  $P_2$  := { $(x, t)$  |  $F(x, t)$  ≤  $2r$ ,  $0 \le t$  < 1} *and*  $\lambda \leq \epsilon$  *on*  $\{(x, 0) | F(x, 0) \leq 2r\}$ *, then* 

$$
\lambda \leq \epsilon + Cr^{-2}
$$

*on*  $P_1 := \{(x, t) | F(x, t) \le r, 0 \le t < 1\}.$ 

*Proof.* We fix a smooth function  $\eta$  on  $[0, \infty)$  such that  $0 \le \eta \le 1$ ,  $\eta = 1$  on  $[0, 1]$  and  $\eta = 0$  on  $[2, \infty)$ . Furthermore,  $|\eta'|^2 \le C\eta^{\frac{3}{2}}$  and  $|\eta''| \le C\eta^{\frac{1}{2}}$  for a universal constant *C*. If we set  $\phi = \phi_r = \eta\left(\frac{F}{r}\right)$ |  $(\frac{F}{r})$ , it follows from the identities of  $F$  (see [\[48,](#page-75-0) Section 3] for details) that

$$
|\nabla \phi|^2 \le C\phi^{\frac{3}{2}}r^{-1} \quad \text{and} \quad |\Box \phi| \le C\phi^{\frac{1}{2}}r^{-1} \tag{5.2}
$$

for some constant *C* depending only on *n*.

From our definition, the curvature operator

<span id="page-48-3"></span><span id="page-48-2"></span><span id="page-48-1"></span>
$$
S := Rm + \lambda I \tag{5.3}
$$

lies on the boundary of  $\hat{C}$ . Therefore, it follows from Lemma [5.3](#page-48-0) that

$$
Q(S) - \tau \text{scal}^2(S)I \in T_S \hat{C},\tag{5.4}
$$

where  $\text{scal}(S)$  is the scalar curvature of  $S$ . Direct calculation yields that

$$
Q(S) = Q(Rm) + 2\lambda Rc \otimes \text{id} + 2(n-1)\lambda^2 I,
$$
\n(5.5)

$$
scal(S) = R + n(n-1)\lambda.
$$
 (5.6)

Combining  $(5.4)$ ,  $(5.5)$  and  $(5.6)$ , we have

$$
Q(Rm) + 2\lambda Rc \otimes \mathrm{id} + 2(n-1)\lambda^2 I - \tau (R + n(n-1)\lambda)^2 I \in T_S \hat{C}.
$$
 (5.7)

Moreover, it follows from Lemma [5.3](#page-48-0) again that

$$
|S| \leq K \text{scal}(S) = K (R + n(n-1)\lambda),
$$

which implies that

<span id="page-49-5"></span><span id="page-49-3"></span><span id="page-49-2"></span><span id="page-49-1"></span><span id="page-49-0"></span>
$$
|Rm| \le C_1(R + |\lambda|) \tag{5.8}
$$

for some  $C_1 = C_1(n, K) > 0$ . In light of [\(5.3\)](#page-48-2), direct calculation(with Uhlenbeck's trick) yields that

$$
\Box S = (\partial_t - \Delta)S = Q(Rm) + (\Box \lambda)I = \left\{Q(Rm) - \lambda^2 I\right\} + (\Box \lambda + \lambda^2)I. \tag{5.9}
$$

Note that  $Q(Rm) - \lambda^2 I \in T_S \hat{C}$  if  $0 \le \lambda \le \delta_1 R$  for some small constant  $\delta_1 = \delta_1(n, K, \tau) > 0$ . Actually, under this condition, it follows from [\(5.8\)](#page-49-2) that

$$
2\lambda Rc \bigotimes id + 2(n-1)\lambda^2 I \leq C_2 \lambda(\lambda + R)I
$$

for some  $C_2 = C_2(n, K) > 0$ . Combining the above inequality with [\(5.7\)](#page-49-3), we have

$$
Q(Rm) + (C_2 \lambda(\lambda + R) - \tau(R + n(n-1)\lambda)^2) I \in T_S \hat{C}.
$$

If  $\delta_1$  is sufficiently small, then  $C_2\lambda(\lambda + R) - \tau(R + n(n-1)\lambda)^2 \leq -\lambda^2$ . Consequently, we have proved that

$$
Q(Rm) - \lambda^2 I \in T_S \hat{C}
$$
\n(5.10)

if  $0 \leq \lambda \leq \delta_1 R$ .

On the other hand, the choice of  $\lambda$  in [\(5.3\)](#page-48-2) implies that  $\Box S$  is not in the interior of  $T_S\hat{C}$ , see [\[18,](#page-73-0) Claim 3 on Page 11] for details. Therefore, it follows from [\(5.10\)](#page-49-4) and [\(5.9\)](#page-49-5) that

<span id="page-49-4"></span> $\Box \lambda \leq -\lambda^2$ 

wherever  $0 \le \lambda \le \delta_1 R$ . Thus we have

$$
\square(\phi\lambda)=(\square\phi)\lambda+\phi(\square\lambda)-2\langle\nabla\phi,\nabla\lambda\rangle\leq(\square\phi)\lambda-\phi\lambda^2-2\langle\nabla\log\phi,\nabla(\phi\lambda)\rangle+2\frac{|\nabla\phi|^2}{\phi}\lambda.
$$

Plugging [\(5.2\)](#page-48-3) into the above inequality, we obtain

$$
\Box(\phi\lambda) \le -\phi\lambda^2 + Cr^{-1}\sqrt{\phi}\lambda - 2\langle \nabla \log \phi, \nabla(\phi\lambda) \rangle \le Cr^{-2} - 2\langle \nabla \log \phi, \nabla(\phi\lambda) \rangle
$$
 (5.11)

for some  $C = C(n)$ . Applying the maximum principle to [\(5.11\)](#page-49-6), we obtain

<span id="page-49-6"></span>
$$
\phi\lambda \leq \epsilon + Cr^{-2}
$$

as long as  $\epsilon + Cr^{-2} \leq \delta_1 R$ . If we set  $\delta = \frac{\delta_1}{C}$  in our assumption, then the conclusion follows.  $\Box$ 

**Remark 5.5.** In the proof of Theorem [5.4,](#page-48-4) a key fact we use is that  $\hat{C}$  is transversally invariant *under Hamilton's ODE. This restriction excludes many well-known cones like*  ${Rm \geq 0}$ , *PIC1, and PIC2. Another critical fact we use is the existence of a good cuto*ff *function from* [\(5.2\)](#page-48-3)*, which is not available for general non-compact Ricci flows.*

The following lemma follows directly from Definition [2.5](#page-9-0) and Definition [B.1.](#page-68-0)

<span id="page-50-0"></span>**Lemma 5.6.** *For any n and*  $\epsilon > 0$ , *there exists a constant*  $\tau_4 = \tau_4(\epsilon, n) > 0$  *satisfying the following property.*

*Suppose*  $(M^n, g(t))$  *is an n-dimensional Ricci flow solution and*  $(\bar{x}, \bar{t})$  *is a spacetime point. Then*  $(\bar{x}, \bar{t})$  *is*  $\epsilon$ -symmetric in the sense of Definition [B.1](#page-68-0) if  $(\bar{x}, \bar{t})$  *is the center of an evolving*  $\tau_4$ -neck with *respect to*  $S^{n-1} \times \mathbb{R}$ *.* 

**Proposition 5.7.** *There exists a small constant*  $\hat{\epsilon} = \hat{\epsilon}(n) > 0$  *satisfying the following property.* 

*Suppose* (*M<sup>n</sup>* , *p*, *g*, *f*) *is a Ricci shrinker and* (*M<sup>n</sup>* , *g*(*t*))*t*≤<sup>0</sup> *is the associated ancient Ricci flow solution. If*

<span id="page-50-1"></span>
$$
d_{PGH}\left\{ (M^n, p, g), (S^{n-1} \times \mathbb{R}, p_c, g_c) \right\} < \hat{\epsilon},\tag{5.12}
$$

*then one of the following conclusions hold:*

- *(A). The flow is*  $\delta_1$ -symmetric of type A (cf. Definition [B.3](#page-69-0) and Theorem [B.2\)](#page-69-1).
- *(B). The flow is*  $\delta_2$ -symmetric of type B, and Assumption [1](#page-69-2) and Assumption [2](#page-70-0) are satisfied (cf. *Definition [B.4](#page-70-1) and Theorem [B.5\)](#page-71-0).*
- *(C). The flow is* δ4*-symmetric of type C, and Assumption [1](#page-69-2) and Assumption [3](#page-71-1) are satisfied (cf. Definition [B.6](#page-71-2) and Theorem [B.7\)](#page-72-4).*

*Proof.* First, we fix some constants and parameters as follows:

$$
A = -\mu(S^{n-1} \times \mathbb{R}, g_c) + 1, \quad B = 1, \quad \delta_0 = \frac{1}{2},
$$
  
\n
$$
\epsilon_1 = \sigma = \sigma(n, \delta_0, A, B), \quad \epsilon_0 = \epsilon_1^{\frac{1}{2}}, \quad \epsilon_2 = \epsilon_0^{\frac{1}{4}},
$$
  
\n
$$
L = L(n, \delta_0, A, B), \quad \epsilon_1' = \eta = \eta(n, \delta_0, A, B, \epsilon),
$$

where  $\sigma$ , *L* and  $\eta$  are functions defined in Theorem [1.2.](#page-3-0) Notice that  $\epsilon'_1$  and  $\eta$  depend on *n* and  $\epsilon$  and all other constants depend only on *n*.

We argue by contradiction.

If the Proposition were wrong, we could find a sequence of Ricci shrinkers  $(M_i^n, p_i, g_i, f_i)$  which does not satisfy any situation of (A), (B), or (C) and satisfy

$$
(M_i, p_i, g_i, f_i) \xrightarrow{\text{pointed-Gromov-Hausdorff}} (S^{n-1} \times \mathbb{R}, g_c, p_c).
$$

Note that the above convergence can be improved (cf. [\[44,](#page-74-0) Theorem 1.1]) as follows

$$
(M_i, p_i, g_i) \xrightarrow{C^{\infty}-Cheeger-Gromov} \left( S^{n-1} \times \mathbb{R}, p_c, g_c \right). \tag{5.13}
$$

Furthermore, by [\[44,](#page-74-0) Proposition 8.8], we know  $\mu(M_i, g_i) \to \mu(S^{n-1} \times \mathbb{R}, g_c)$ . Consequently, there exists a sequence  $r_i \rightarrow +\infty$  satisfying the following properties if *i* is sufficiently large.

- 1.  $\{x \in M_i \mid r_i \le f_i(x) \le 2r_i\}$  consists of two components, denoted by  $\Sigma_i^1(r_i, 2r_i)$  and  $\Sigma_i^2(r_i, 2r_i)$ , which satisfy the condition  $(1.5)$  of Theorem [1.2.](#page-3-0)
- 2. Each point in  $\{x \in M_i \mid f_i(x) \leq \eta^{-1} r_i\}$  is the center of an evolving normalized  $\epsilon$ -neck.

From Theorem [1.2,](#page-3-0) there exist sets  $E_i^1$  and  $E_i^2$  with  $\partial E_i^1 = \sum_i^1(r_i)$  and  $\partial E_i^2 = \sum_i^2(r_i)$  such that one of the following holds:

- (A). Both  $E_i^1$  and  $E_i^2$  are ends of  $M_i$ .
- (B).  $E_i^1$  is compact and  $E_i^2$  is an end of  $M_i$ .
- (C). Both  $E_i^1$  and  $E_i^2$  are compact.

We shall discuss the above situations case by case.

# *Case A: If (A) happens, then the flow*  $(M_i, g_i(t))_{t \leq 0}$  *is*  $\delta_1$ *-symmetric of type A.*

We take  $\epsilon \le \tau_4(\delta_1, n)$ , where  $\tau_4$  is from Lemma [5.6](#page-50-0) and  $\delta_1$  is the constant in Theorem [B.2.](#page-69-1) It follows from Theorem [1.2](#page-3-0) that any point in  $\Sigma_i^1(\eta^{-1}r_i,\infty)$  or  $\Sigma_i^2(\eta^{-1}r_i,\infty)$  is the center of an evolving normalized  $\tau_4$ -neck. Combining with property 2 above, we conclude from Lemma [5.6](#page-50-0) that each point  $(x, 0) \in M_i \times \{0\}$  is  $\delta_1$ -symmetric. Moreover, it is easy to see  $M_i$  is diffeomorphic to  $S^{n-1} \times \mathbb{R}$ . Therefore,  $(M_i, g_i)$  is  $\delta_1$ -symmetric of type-A at time 0, see Definition [B.3.](#page-69-0)

Since the associated Ricci flow  $g_i(t)$  of  $(M_i, g_i)$  is self-similar, we claim that each spacetime point  $(\bar{x}, \bar{t}) \in M_i \times (-\infty, 0]$  is also  $\delta_1$ -symmetric. Indeed, it follows from the definition of the diffeomorphisms  $\psi_i^t$  [\(2.12\)](#page-8-0) that

$$
\psi_i^{\theta(s)} \circ \psi_i^{\bar{t}} = \psi_i^s,
$$

where  $\theta(s) = \frac{s-\bar{t}}{1-\bar{t}}$  $\frac{s-\bar{t}}{1-\bar{t}}$ . Therefore, for any  $s \leq \bar{t}$ ,

$$
g_i(s) = (1-s)(\psi_i^s)^* g_i = (1-\bar{t})(1-\theta(s))(\psi_i^{\bar{t}})^*(\psi_i^{\theta(s)})^* g_i = (1-\bar{t})(\psi_i^{\bar{t}})^* g_i(\theta(s)).
$$

We set  $\psi_i^{\bar{i}}(\bar{x}) = x$ , then  $(x, 0)$  is  $\delta_1$ -symmetric. By comparing the similar parabolic neighborhoods in the Definition [B.1](#page-68-0) based at  $(x, 0)$  and  $(\bar{x}, \bar{t})$  respectively, it is easy to see  $(\bar{x}, \bar{t})$  is also  $\delta_1$ -symmetric, since the CMC foliation is unique, see [\[9,](#page-72-5) Proposition D.1]. In particular, if  $\mathcal{U} = \{U^{(a)} : 1 \le a \le \binom{n}{2}$  $\binom{n}{2}$ is the collection of vector fields in the Definition [B.1](#page-68-0) around  $(x, 0)$ , then  $\bar{U} = {\{\bar{U}^{(a)} = (\psi_i^{\bar{t}})_*^{-1}U^{(a)} : \phi_i^{\bar{t}}(\bar{t}) = (\bar{t})\}}$  $1 \le a \le {n \choose 2}$  $\{x^{n}\}\$ is the collection around  $(\bar{x}, \bar{t})$ . In summary, we know the flow  $(M_i, g_i(t))_{t\leq 0}$  is  $\delta_1$ symmetric of type-A .

*Case B: If (B) happens, then the flow*  $(M_i, g_i(t))_{t \leq 0}$  *is*  $\delta_2$ -symmetric of type *B, and Assumption* [1](#page-69-2) *and Assumption [2](#page-70-0) in Appendix [B](#page-68-1) are satisfied.*

In this case, it follows from Theorem [1.2](#page-3-0) that there exists  $s_i \geq 2r_i$  and a point  $q_i \in \Sigma(s_i)$  with  $f_i(q_i) = \epsilon_1 R_i(q_i)$ . By our choice of parameters, any point  $x \in M_i \setminus D_i$  is the center of an evolving normalized  $\epsilon$ -neck, where  $D_i = E_i^1 \setminus \Sigma_i^1(r_i, s_i)$ . Moreover, we fix a point  $z_i \in D_i$  to be a maximum point of *f<sup>i</sup>* .

**Claim 1:** On  $P_{2,i} = \{(x, t) | F_i(x, t) \le 2r_i, 0 \le t < 1\}$ , we have

<span id="page-52-0"></span>
$$
R_i \ge \frac{1}{2}.\tag{5.14}
$$

*Proof of Claim 1*: For any  $(x, t) \in M_i \times [0, 1)$  with  $F_i(x, t) \le 2r_i$ , we have  $(1 - t)f_i(\psi_i^t(x)) \le 2r_i$ by the definition of  $F_i$ . If  $f_i(\psi_i^t(x)) \le r_i$ , then  $\psi_i^t(x)$  is the center of an evolving normalized  $\epsilon$ -neck. In particular,  $R_i(\psi_i^t(x)) \ge 1$  and hence

$$
R_i(x, t) = \frac{1}{1 - t} R_i(\psi_i^t(x)) \ge 1.
$$

If  $f_i(\psi_i^t(x)) \ge r_i$ , then it follows from Lemma [3.2](#page-10-4) that

$$
R(\psi_i^t(x)) \ge \frac{r_i}{f_i(\psi_i^t(x))}
$$

and hence

$$
R_i(x,t) = \frac{1}{1-t}R_i(\psi_i^t(x)) \ge \frac{1}{1-t}\frac{r_i}{f_i(\psi_i^t(x))} \ge \frac{1}{2}.
$$

**Claim 2:** If we set  $\tilde{f}_i = f_i - s_i$  and  $\tilde{g}_i = s_i g_i$ , then  $(M_i, q_i, \tilde{g}_i, \tilde{f}_i)$  converges smoothly in the Cheeger-Gromov sense to the Bryant soliton.

*Proof of Claim 2*: We consider a continuous family of cones  $\hat{C}(\theta)$  from Example [5.2,](#page-47-0) for  $\theta$  a small positive number.

For any small  $\theta$ , since the curvature tensor of  $S^{n-1} \times \mathbb{R}$  is contained in  $\hat{C}(\theta)$ , then there exists a sequence  $v_i \rightarrow 0^+$  such that

<span id="page-52-1"></span>
$$
Rm_i + v_i I \in \hat{C}(\theta).
$$

on  ${(x, 0) \in M_i \times \{0\} \mid F_i(x, 0) \le 2r_i}$ . Therefore, it follows from [\(5.14\)](#page-52-0) and Theorem [5.4](#page-48-4) that

$$
Rm_i + (v_i + C_1 r_i^{-2})I \in \hat{C}(\theta)
$$
\n(5.15)

on  $P_{1,i} = \{(x, t) \mid F_i(x, t) \le r_i, 0 \le t < 1\}$ , for some constant  $C_1 = C_1(n) > 0$ , if *i* is sufficiently large. Now we define the set  $X_i := E_i^1 \setminus \sum_i^1 (r_i, 2r_i)$  and the following subsets

$$
\begin{cases}\nA_i &:= \{x \in X_i \mid \text{there exists a point } y \text{ with } f_i(y) \le r_i \text{ such that } \psi_i^t(y) = x \text{ for some } t \in (0, 1)\}, \\
B_i &:= \{x \in X_i \mid |\nabla f_i|(x) = 0\}, \\
C_i &:= X_i \setminus (A_i \cup B_i).\n\end{cases}
$$

It is clear that  $A_i$ ,  $B_i$  and  $C_i$  are disjoint and  $A_i$  is open. Moreover, from our construction  $B_i \cup C_i \subset D_i$ . For any  $x \in A_i$  with  $\psi_i^t(y) = x$  for some  $f_i(y) \le r_i$ , we compute

$$
F_i(y, t) = (1 - t)f_i(y, t) = (1 - t)f_i(\psi_i^t(y)) \le f_i(y) \le r_i,
$$

where we have used the ODE inequality

$$
\frac{df_i(\psi_i^t(y))}{dt} = \frac{|\nabla f_i|^2(\psi_i^t(y))}{1-t} \le \frac{f_i(\psi_i^t(y))}{1-t}.
$$

Therefore, it follows from [\(5.15\)](#page-52-1) that

$$
Rm_i(x) + (1-t)(v_i + C_1r_i^{-2})I \in \hat{C}(\theta).
$$

In particular, we have for any  $x \in A_i$ ,

<span id="page-53-0"></span>
$$
Rm_i(x) + (v_i + C_1r_i^{-2})I \in \hat{C}(\theta).
$$
 (5.16)

Next we define

$$
Y_i
$$
 := the closure of the interior part of  $B_i \cup C_i$ .  
\n $Z_i := (B_i \cup C_i) \setminus Y_i$ .

It is clear that  $Z_i$  has no interior point and  $Z_i \subset \partial A_i$ . From the continuity, we conclude from [\(5.16\)](#page-53-0) that on *Z<sup>i</sup>*

$$
Rm_i + (v_i + C_1 r_i^{-2})I \in \hat{C}(\theta).
$$
 (5.17)

Now we claim that there exists a constant  $C_2 = C_2(n) > 0$  such that

<span id="page-53-1"></span>
$$
R_i \geq (1 - C_2 \theta) s_i
$$

on  $\partial Y_i$  if *i* is sufficiently large.

Indeed, if  $x \in B_i$ , then  $R_i(x) = f_i(x)$  and hence by [\(1.6\)](#page-3-2) that

$$
\lim_{i \to \infty} \frac{R_i(x)}{s_i} = \lim_{i \to \infty} \frac{f_i(x)}{s_i} = 1
$$

uniformly since  $x \in D_i$ . If  $x \in C_i$ , we denote the gradient flow generated by  $\frac{\nabla f_i}{|\nabla f_i|^2}$  by  $\phi_i^t$  and there exist  $y \in B_i$  and  $t_i < 0$  such that

$$
\lim_{t\to t_i^+}\phi_i^t(x)=y.
$$

Moreover, it follows from [\(1.6\)](#page-3-2) again that  $t_i > -L$  since both  $x, y \in D_i$ . From the choice of  $x$ , there exists a sequence  $x_j \in A_i \to x$ . We define  $y_j = \phi_i^{t_i}$  $i_i^{t_i}(x_j)$ . Then it is clear that  $y_j \rightarrow y$ . Now we have the ODE:

$$
\frac{dR_i(\phi_i^t(x_j))}{dt} = \frac{\langle \nabla R_i, \nabla f_i \rangle}{|\nabla f_i|^2} (\phi_i^t(x_j)) = \frac{2Rc_i(\nabla f_i, \nabla f_i)}{|\nabla f_i|^2} (\phi_i^t(x_j)).
$$
\n(5.18)

From the definition of  $\hat{C}(\theta)$  and [\(5.1\)](#page-48-5), it is clear that  $Rc \ge -C\theta R$  for any  $Rm \in \hat{C}(\theta)$ . Combining this fact with  $(5.17)$ , we have on  $A_i$  that

<span id="page-53-3"></span><span id="page-53-2"></span>
$$
Rc_i \ge -C\theta R_i \tag{5.19}
$$

for some constant  $C = C(n) > 0$ , if *i* is sufficiently large. Hence, it follows from [\(5.18\)](#page-53-2) and [\(5.19\)](#page-53-3) that

$$
\frac{dR_i(\phi_i^t(x_j))}{dt} \ge -C\theta R_i(\phi_i^t(x_j))
$$

and hence

$$
R_i(x_j) \geq e^{-C\theta |t_i|} R_i(\phi_i^{t_i}(x_j)) = e^{-C\theta |t_i|} R_i(y_j) \geq e^{-C\theta} R_i(y_j).
$$

Notice that  $R_i(y) = f_i(y)$  since *y* is a critical point of  $f_i$ . By taking  $j \to \infty$ , we conclude

$$
R_i(x) \ge e^{-C\theta} R_i(y) = e^{-C\theta} f_i(y)
$$

and hence by [\(1.6\)](#page-3-2)

<span id="page-54-0"></span>
$$
R_i(x) \ge (1 - C_2 \theta) s_i \tag{5.20}
$$

if *i* is sufficiently large. Now we have the elliptic equation

$$
\Delta_{f_i} R_i = R_i - 2|Rc_i|^2 \le R_i - \frac{2}{n}R_i^2 \le 0
$$

on *Y<sub>i</sub>*, where for the last inequality we have used  $Y_i \subset D_i$  and [\(1.6\)](#page-3-2). From [\(5.20\)](#page-54-0) and the maximum principle, we have on *Y<sup>i</sup>* ,

<span id="page-54-1"></span>
$$
R_i \ge (1 - C_2 \theta) s_i. \tag{5.21}
$$

From Theorem [1.2](#page-3-0) (c), we have

$$
(M_i, q_i, \tilde{g}_i, \tilde{f}_i) \xrightarrow{\text{pointed} - \hat{C}^{\infty} - \text{Cheeger-Gromov}} (X_{\infty}, q_{\infty}, d_{\infty}, f_{\infty}),
$$

where  $(X_\infty, q_\infty, d_\infty, f_\infty) \in \mathfrak{S}(n)$  is a nontrivial steady soliton conifold. From [\(5.16\)](#page-53-0), [\(5.17\)](#page-53-1) and [\(5.21\)](#page-54-1), we have

$$
Rm_{\tilde{g}_i} + s_i^{-1} (v_i + C_1 r_i^{-2}) I \in \hat{C}(\theta)
$$
\n(5.22)

on  $A_i \cup Z_i$  and

<span id="page-54-3"></span><span id="page-54-2"></span>
$$
R_{\tilde{g}_i} \ge 1 - C_2 \theta \tag{5.23}
$$

on  $Z_i$ . Therefore, for any  $x \in \mathcal{R}$ , it follows from [\(5.22\)](#page-54-2), [\(5.23\)](#page-54-3) and the smooth convergence that

$$
Rm_{\infty}(x) \in \hat{C}(\theta)
$$
 or  $R_{\infty}(x) \ge 1 - C_2\theta$ .

Now we let  $\theta \rightarrow 0$  and conclude that

$$
Rm_{\infty}(x) \in \hat{C}(0)
$$
 or  $R_{\infty}(x) = 1$ .

Here, we have used the fact that  $|\nabla f_{\infty}|^2 + R_{\infty}(x) = 1$  on R. Notice that the set  $\{x \in \mathcal{R} \mid R_{\infty}(x) = 1\}$ has no interior point since otherwise from  $\Delta_{f_{\infty}} R_{\infty} = -2|Rc_{\infty}|^2$  and the analyticity that  $Rc_{\infty} \equiv 0$  on *R*, which contradites the fact that  $R_{\infty}(q_{\infty}) = \epsilon_1$ . By continuity, we have

$$
Rm_{\infty}(x) \in \hat{C}(0)
$$

for any  $x \in \mathcal{R}$ . In addition, it follows from [\[4,](#page-72-3) Proposition 2.3] that  $\hat{C}(0) \subset \text{PIC2}$ . Therefore, it implies that on  $\mathcal R$ 

$$
Rm_{\infty} \in \text{PIC2.}
$$

Now we claim that  $(R, g)$  has strictly PIC2. Indeed, it follows from Proposition [3.22,](#page-35-2) Proposition [4.1](#page-37-2) and the smooth convergence that

$$
Rm_{\infty}(x) > \frac{c(n)}{t}R_{\infty}(x) > 0
$$

if  $f_{\infty}(x) = -t < 0$ . Therefore, it follows from the geodesic convexity of R and the strong maximum principle (see [\[10,](#page-72-6) Proposition 9]) that  $(R, g)$  has strictly PIC2.

Moreover, one can show as [\[15,](#page-73-1) Lemma 6.1] that −*f*<sup>∞</sup> is comparable to the distance function *d*∞(*z*∞, ·) outside a compact set, where *z*<sup>∞</sup> is the limit point of *z<sup>i</sup>* . From Proposition [4.1](#page-37-2) we conclude

$$
\frac{c_1}{d_{\infty}(z_{\infty}, x)} \le R_{\infty}(x) \le \frac{c_2}{d_{\infty}(z_{\infty}, x)}
$$

for *x* outside a compact set, where  $c_1$ ,  $c_2$  are positive constants.

Combined with Proposition [3.21,](#page-35-1) it is clear that all assumptions of Theorem [4.7](#page-43-2) are satisfied. Therefore, we conclude that the limit steady soliton conifold  $(X_{\infty}, d_{\infty})$  must be isometric to the Bryant soliton. In particular, it implies that  $(M_i, q_i, \tilde{g}_i, \tilde{f}_i)$  converges smoothly in the Cheeger-Gromov sense to the Bryant soliton whose maximum of the scalar curvature is 1.

In addition, if we set  $\tilde{g}_i(t) = s_i g_i(s_i^{-1}t)$ , then the Ricci flow  $(M_i, q_i, \tilde{g}_i(t))_{t \leq 0}$  converges smoothly to the Ricci flow associated with the Bryant soliton.

**Claim 3:** There exists a constant  $\theta_0 = \theta_0(n) > 0$  such that for sufficiently large *i* if  $(x, t) \in$  $M_i \times (-\infty, 0]$  satisfies

$$
\lambda_i(x,t) \leq \theta_0 R_i(x,t),
$$

where  $\lambda_i$  is the minimal eigenvalue of  $Rc_i$ , then *x* is  $\delta_1$ -symmetric in the sense of Definition [B.1.](#page-68-0)

*Proof of Claim 3*: We may assume that the parameter  $\epsilon < \tau_4(\delta_1, n)$  so that any point  $x \in M_i \backslash D_i$ is  $\delta_1$ -symmetric. From Claim 2, it is clear that  $(D_i, s_i g_i)$  converges smoothly to a cap in the Bryant soliton. Therefore, there exists a constant  $\theta_0$  depending only on *n* that

$$
\lambda_i \geq \theta_0 R_i,
$$

on  $D_i$ , if *i* is sufficiently large. In other words, any point  $x \in M_i$  with  $\lambda_i(x) \leq \theta_0 R_i(x)$  is contained in  $M_i \backslash D_i$  and hence  $\delta_1$ -symmetric.

Since the Ricci flow  $(M_i, g_i(t))_{t \leq 0}$  associated with  $(M_i, g_i)$  is self-similar, it is clear that if a spacetime point  $(x, t)$  satisfies

$$
\lambda_i(x,t) \leq \theta_0 R_i(x,t),
$$

then  $(x, t)$  is  $\delta_1$ -symmetric.

**Claim 4:** There exist constants  $\epsilon' = \epsilon'(n) > 0$  and  $\Lambda_0 = \Lambda_0(n) > 0$  such that for  $\epsilon \leq \epsilon'$  and sufficiently large *i*, if  $(x, \bar{t}) \in M_i \times (-\infty, 0]$  and  $d_{g_i(\bar{t})}(z_i, x) \ge \Lambda_0 R_i(z_i, \bar{t})^{-\frac{1}{2}}$ , then

$$
\lambda_i(y,t) \leq \frac{\theta_0}{2} R_i(y,t),
$$

for any  $(y, t) \in B_{g_i(\bar{t})}(x, \bar{L}R_i(x, \bar{t})^{-\frac{1}{2}}) \times [-\bar{L}R_i(x, \bar{t})^{-1}, \bar{t}],$  where  $\bar{L}$  is the constant from Theorem [B.2.](#page-69-1)

*Proof of Claim 4:* We choose our parameter  $\epsilon$  small enough so that if a point  $x \in M_i$  is the center of an evolving normalized  $\epsilon$ -neck, then  $\lambda_i(x) \leq \frac{\theta_0}{2}$  $\frac{\partial}{\partial x}R_i(x)$  and  $R_i(u) \ge 0.9R_i(v)$  for any *u*, *v* ∈  $B_{g_i}(x, \bar{L}R_i(x)^{-\frac{1}{2}}).$ 

Assume  $y \in B_{g_i}(x, \overline{L}R_i(x)^{-\frac{1}{2}}) \cap D_i$ , then

$$
R_i(x) \ge \frac{9}{10}R_i(y) \ge \frac{9s}{10L},
$$

where the last inequality follows from [\(1.6\)](#page-3-2). Therefore,

$$
d_{g_i}(z_i, x) \leq d_{g_i}(z_i, y) + d_{g_i}(y, x) \leq \left(L + \bar{L}\left(\frac{10L}{9}\right)^{\frac{1}{2}}\right) s^{-\frac{1}{2}}.
$$

On the other hand, since  $z_i$  is a critical point of  $f_i$ , it follows from [\(1.6\)](#page-3-2) that

$$
\lim_{i \to \infty} \frac{R_i(z_i)}{s_i} = \lim_{i \to \infty} \frac{f_i(z_i)}{s_i} = 1.
$$

From [\(1.6\)](#page-3-2) again, if we take  $\Lambda_0 = 2L + 2\overline{L} \left( \frac{10L}{9} \right)$  $\left(\frac{0L}{9}\right)^{\frac{1}{2}}$ , then for any point *x* with  $d_i(x, z_i) \ge \Lambda_0 R_i(z_i)^{-\frac{1}{2}}$ ,  $B_{g_i}(x, \bar{L}R_i(x)^{-\frac{1}{2}})$  must be contained in  $M_i\backslash D_i$  and hence

$$
\lambda_i(y) \le \frac{\theta_0}{2} R_i(y)
$$

for any  $y \in B_{g_i}(x, \bar{L}R_i(x)^{-\frac{1}{2}})$ .

In addition, for any  $(y, t) \in B_{g_i}(x, \bar{L}R_i(x)^{-\frac{1}{2}}) \times [-\bar{L}R_i(x)^{-1}, 0], \psi_i^t(y) \notin D_i$  since  $f_i(\psi_i^t(y)) \le f_i(y)$ . Therefore, for the associated Ricci flow  $(M_i, g_i(t))_{t \leq 0}$ , if  $(x, 0) \in M_i \times (-\infty, 0]$  and  $d_{g_i(0)}(z_i, x) \geq$  $\Lambda_0 R_i(z_i, 0)^{-\frac{1}{2}}$ , then

$$
\lambda_i(y,t) \leq \frac{\theta_0}{2} R_i(y,t),
$$

for any  $(y, t) \in B_{g(0)}(x, \bar{L}R_i(x, 0)^{-\frac{1}{2}}) \times [-\bar{L}R_i(x, 0)^{-1}, 0]$ . Therefore, the Claim follows from the self-similarity of  $(M_i, g_i(t))_{t \leq 0}$ .

Now we fix  $\epsilon = \min{\tau_4(\delta_1, n), \tau_4(\delta_2, n), \epsilon'(n)}$ , where  $\delta_2$  is from Theorem [B.5.](#page-71-0) From Claim 2-Claim 4, it is clear that Assumption [1](#page-69-2) and Assumption [2](#page-70-0) in Appendix [B](#page-68-1) are satisfied. Moreover, if *i* is sufficiently large,  $(M_i, g_i(t))$  is  $\delta_2$ -symmetric of type-B at time 0 in the sense of Definition [B.4.](#page-70-1) From the self-similarity of  $(M_i, g_i(t))$  as in Case A, we immediately conclude that  $(M_i, g_i(t))$  is δ2-symmetric of type-B at time *t* for any *t* ≤ 0.

*Case C: If (C) happens, then the flow*  $(M_i, g_i(t))_{t \leq 0}$  *is*  $\delta_4$ -symmetric of type *C, and Assumption* [1](#page-69-2) *and Assumption [3](#page-71-1) in Appendix [B](#page-68-1) are satisfied.*

In this case, it follows from Theorem [1.2](#page-3-0) that there exist  $s_i^1, s_i^2 \ge 2r_i$  and points  $q_i^1 \in \Sigma_i^1(s_i^1)$ and  $q_i^2 \in \Sigma_i^2(s_i^2)$  with  $f_i(q_i^1) = \epsilon_1 R_i(q_i^1)$  and  $f_i(q_i^2) = \epsilon_1 R_i(q_i^2)$ . By our choice of parameters, any point  $x \in M_i \setminus D_i$  is the center of an evolving normalized  $\epsilon$ -neck, where  $D_i = D_i^1 \cup D_i^2 =$  $(E_i^1 \setminus \Sigma_i^1(r_i, s_i^1)) \cup (E_i^2 \setminus \Sigma_i^2(r_i, s_i^2))$ . Moreover, we fix points  $z_i^1 \in D_i^1$  and  $z_i^2 \in D_i^2$  to be a maximum point of  $f_i$  on  $D_i^1$  and  $D_i^2$ , respectively.

If we set  $\tilde{g}_i^1 = s_i^1 g_i$ ,  $\tilde{g}_i^2 = s_i^2 g_i$ ,  $\tilde{f}_i^1 = f_i - s_i^1$  and  $\tilde{f}_i^2 = f_i - s_i^2$ . Following the the discussion in case B, it is clear that both  $(M_i, q_i^1, \tilde{g}_i^1, \tilde{f}_i^1)$  and  $(M_i, q_i^2, \tilde{g}_i^2, \tilde{f}_i^2)$  converge smoothly in the Cheeger-Gromov sense to the Bryant soliton. Furthermore, there exist constants  $\epsilon'' = \epsilon''(n) > 0$  and  $\Lambda_1 = \Lambda_1(n) > 0$ such that for  $\epsilon \leq \epsilon''$  and sufficiently large *i*, if  $(x, \bar{t}) \in M_i \times (-\infty, 0], d_{g_i(\bar{t})}(z_i^1, x) \geq \Lambda_1 R_i(z_i, \bar{t})^{-\frac{1}{2}}$  and  $d_{g_i(\bar{t})}(z_i^2, x) \ge \Lambda_1 R_i(z_i, \bar{t})^{-\frac{1}{2}}$ , then

$$
\lambda_i(y,t) \leq \frac{\theta_0}{2} R_i(y,t),
$$

for any  $(y, t) \in B_{g_i(\bar{t})}(x, \bar{L}R_i(x, \bar{t})^{-\frac{1}{2}}) \times [-\bar{L}R_i(x, \bar{t})^{-1}, \bar{t}].$ 

Now we fix  $\epsilon = \min{\lbrace \tau_4(\delta_1, n), \tau_4(\delta_4, n), \epsilon''(n) \rbrace}$ , where  $\delta_4$  is from Theorem [B.7.](#page-72-4) From Claim 3, Claim 4 and the discussion above, it is clear that Assumption [1](#page-69-2) and Assumption [3](#page-71-1) in Appendix [B](#page-68-1) are satisfied. Moreover, if *i* is sufficiently large,  $(M_i, g_i(t))$  is  $\delta_4$ -symmetric of type-C at time 0 in the sense of Definition [B.6.](#page-71-2) Applying the self-similarity of  $(M_i, g_i(t))$  as in Case A, we immediately conclude that  $(M_i, g_i(t))$  is  $\delta_4$ -symmetric of type-C at time *t* for any  $t \le 0$ .

In conclusion, for each large *i*, the associated ancient Ricci flow  $(M_i, g_i(t))_{t \leq 0}$  must locate in one of the situations of  $(A)$ ,  $(B)$ , or  $(C)$ . However, this contradicts our assumption at the beginning. This contradiction establishes the proof of this Proposition.

Now we are able to finish the proof of Theorem [1.1.](#page-1-0)

*Proof of Theorem [1.1:](#page-1-0)* It follows from the combination of Theorem [B.2,](#page-69-1) Theorem [B.5](#page-71-0) and The-orem [B.7](#page-72-4) that each ancient Ricci flow solution  $(M^n, g(t))_{t \leq 0}$  satisfying one of (A), (B) or (C) in Proposition [5.7](#page-50-1) is rotationally symmetric. Then we can apply Kotschwar's classification [\[38\]](#page-74-3) to obtain that  $(M, g)$  must be isometric to  $S^n$ ,  $S^{n-1} \times \mathbb{R}$ , or  $\mathbb{R}^n$ . Applying [\(1.2\)](#page-1-1) again, we know that  $(M, g)$  can only be  $S^{n-1} \times \mathbb{R}$ . *n*−1 × R.

## 6 Further discussion

In this paper, we mainly focus on the model space ( $S^{n-1} \times \mathbb{R}$ ,  $g_c$ ). One can also consider the model space  $((S^{n-1}/\Gamma) \times \mathbb{R}, g_c)$ , where  $\Gamma \leq O(n)$  is a finite subgroup acting freely on  $S^{n-1}$ . Then we can also define a spacetime  $(x, t)$  in a Ricci flow  $(M, g(t))$  to be the center of an evolving (normalized)  $\epsilon$ -neck if the model space  $S^{n-1} \times \mathbb{R}$  is replaced by  $(S^{n-1}/\Gamma) \times \mathbb{R}$ .

The following theorem is another version of Theorem [1.2](#page-3-0) in this case, whose proof is almost identical and hence omitted.

<span id="page-58-0"></span>**Theorem 6.1.** *For any positive constants n, N, A, B,*  $\epsilon$  *and*  $\delta_0 \in (0, 1)$ *, there exist positive constants*  $\sigma = \sigma(n, N, \delta_0, A, B)$ ,  $L = L(n, N, \delta_0, A, B)$  and  $\eta = \eta(n, N, \delta_0, A, B, \epsilon)$  satisfying the following *property.*

*Let* (*M<sup>n</sup>* , *g*, *f*) *be a Ricci shrinker with*

$$
\begin{cases}\n|\nabla^i Rm| \leq BR^{\frac{i}{2}+1}, & \forall 0 \leq i \leq 4 & \text{on } \Sigma(t_0, s_0), \\
R \leq \epsilon_1 f & \text{on } \Sigma(t_0, s_0), \\
|\mathcal{R}m_{\Sigma}| \leq \epsilon_1'R & \text{on } \Sigma(t_0), \\
|R - \frac{n-1}{2}| \leq \epsilon_1' & \text{on } \Sigma(t_0), \\
(1 - \delta_0)s_0 \geq t_0 \geq n\epsilon_1^{-1}, \\
\mu(g) \geq -A, \\
\Sigma(t_0) \text{ is diffeomorphic to } S^{n-1}/\Gamma \text{ with } |\Gamma| \leq N.\n\end{cases}
$$

*If*  $\epsilon_1 \leq \sigma$  and  $\epsilon'_1 \leq \eta$ , then one of the following statements holds.

- *(a). There exists an end E with*  $\partial E = \Sigma(t_0)$  *such that any point in*  $\Sigma(\eta^{-1}t_0, ∞) \subset E$  *is the center of an evolving normalized*  $\epsilon$ -neck. Moreover, E is asymptotic to  $((S^{n-1}/\Gamma) \times \mathbb{R}, g_c)$  with rate *O*( $r^{-\tau(n)}$ ).
- *(b). There exists an end E with*  $\partial E = \Sigma(t_0)$  *such that any point in*  $\Sigma(\eta^{-1}t_0, \infty) \subset E$  *is the center of an evolving*  $\epsilon$ *-neck. Moreover, E is asymptotic to a regular cone with cross section di*ff*eomorphic to S <sup>n</sup>*−<sup>1</sup> /Γ*.*
- *(c). There exists a compact set E with*  $∂E = Σ(t<sub>0</sub>)$ *, a number s*  $≥ s<sub>0</sub>$  *and a point q*  $∈ Σ(s)$  *such that*  $R(q) = \sigma s$ . Moreover, any point in  $\Sigma(\eta^{-1}t_0, s) \subset E$  is the center of an evolving  $\epsilon$ -neck and any *point in the cap D* :=  $E\{\Sigma(t_0, s)$  *is the center of an e-steady soliton conifold. Furthermore,*

$$
\text{diam}_g D \le \frac{L}{\sqrt{s}}, \quad \sup_D |f - s| \le L \quad \text{and} \quad L^{-1} s \le \inf_D R \le \sup_D R \le s + L.
$$

However, the following conjecture originally proposed in [\[47\]](#page-75-4) is still open.

**Conjecture 6.2.** *For any n* > 0 *and*  $N$  > 0*, there exists a small constant*  $\epsilon = \epsilon(n, N)$  > 0 *with the following property.*

*Suppose* (*M<sup>n</sup>* , *p*, *g*, *f*) *is a Ricci shrinker such that*

$$
d_{PGH}\left\{(M^n, p, g), \left((S^{n-1}/\Gamma) \times \mathbb{R}, p_c, g_c\right)\right\} < \epsilon
$$

*with*  $|\Gamma| \leq N$ , *then*  $(M, g)$  *is isometric to*  $((S^{n-1}/\Gamma) \times \mathbb{R}, p_c, g_c)$ .

Notice that the same proof of Theorem [1.1](#page-1-0) does not go through. The key point is another version of Theorem [4.7](#page-43-2) corresponding to  $(S^{n-1}/\Gamma) \times \mathbb{R}$  does not hold. In fact, in this case one can show  $(X, d)$ in Theorem [4.7](#page-43-2) is isometric to  $(\mathbb{R}^n/\Gamma, g_{Br})$ , where  $g_{Br}$  is the quotient metric of the Bryant soliton. In other words, even though the cap region is modeled by (R *n* /Γ, *gBr*), the underlying topology of the cap is unclear. A deeper bubble may exist and converge to the singularity of (R *n* /Γ, *gBr*). For this reason, one cannot apply the theorems of symmetry as done in the proof of Theorem [1.1.](#page-1-0)

However, if we assume *f* has no critical point outside a compact set, we have the following weaker theorem.

**Theorem 6.3.** *There exists a small constant*  $\epsilon = \hat{\epsilon}(n, N) > 0$  *satisfying the following property.* 

*Suppose*  $(M^n, p, g, f)$  *is a Ricci shrinker such that*  $|\nabla f| > 0$  *on*  $\{x \in M \mid f(x) \ge n\}$  *and* 

 $d_{PGH}\left\{(M^n, p, g), \left((S^{n-1}/\Gamma) \times \mathbb{R}, p_c, g_c\right)\right\} < \hat{\epsilon}$ 

*with*  $|\Gamma| \leq N$ , *then*  $(M, g)$  *is isometric to*  $((S^{n-1}/\Gamma) \times \mathbb{R}, p_c, g_c)$ .

*Proof.* Suppose the conclusion does not hold, there exists a sequence of Ricci shrinkers  $(M_i^n, p_i, g_i, f_i)$ such that

$$
(M_i, p_i, g_i, f_i) \xrightarrow{pointed-Gromov-Hausdorff} ((S^{n-1}/\Gamma_i) \times \mathbb{R}, p_c, g_c, f_c)
$$

for  $|\Gamma_i| \leq N$ , but no  $(M_i, g_i)$  is isometric to  $((S^{n-1}/\Gamma_i) \times \mathbb{R}, g_c)$ . Since there are only finitely many conjugacy classes of subgroups of  $O(n)$  with order no larger than *N*, we may assume  $\Gamma_i = \Gamma$  for a fixed  $\Gamma \leq O(n)$  acting freely on  $S^{n-1}$ .

If *i* is large, the conclusion of Theorem [6.1](#page-58-0) holds. Since  $f_i$  is assumed to be regular on  $\{x \in M_i\}$ |  $f_i(x) \ge n$ , we conclude as in the proof of Theorem [1.1](#page-1-0) that each  $M_i$  is diffeomorphic to  $(S^{n-1}/\Gamma) \times \mathbb{R}$ and each point is the center of an evolving normalized  $\delta_1$ -neck. By considering the universal cover  $(\tilde{M}_i, \tilde{g}_i, \tilde{f}_i)$  of  $(M_i, g_i, f_i)$ . We can apply Theorem [B.2](#page-69-1) by iteration and conclude that  $(\tilde{M}_i, \tilde{g}_i, \tilde{f}_i)$  is rotationally symmetric. From [\[38,](#page-74-3) Theorem 1],  $(\tilde{M}_i, \tilde{g}_i)$  is isometric to  $(S^{n-1} \times \mathbb{R}, g_c)$ . This implies that  $(M_i, g_i)$  is isometric to  $((S^{n-1}/\Gamma) \times \mathbb{R}, g_c)$ , which is a contradiction.

On the other hand, inspired by the main theorem of [\[21\]](#page-73-2), it is natural to guess that all generalized round cylinders are also rigid in Ricci shrinkers.

**Conjecture 6.4.** *For any n and*  $2 \le k \le n - 2$ *, there exists a small constant*  $\epsilon = \epsilon(n) > 0$  *with the following property.*

*Suppose* (*M<sup>n</sup>* , *p*, *g*, *f*) *is a Ricci shrinker such that*

 $d_{PGH}\left\{ (M^n, p, g), (S^{n-k} \times \mathbb{R}^k, p_c, g_c) \right\} < \epsilon,$ 

*then*  $(M, g)$  *is isometric to*  $(S^{n-k} \times \mathbb{R}^k, g_c)$ *.* 

# Appendix

## A Steady soliton conifold

Following Chen-Wang [\[24\]](#page-73-3), we introduce the concept of the steady soliton conifold and prove many fundamental properties.

**Definition A.1.** Let  $\mathfrak{S}(n)$  be the collection of geodesic spaces  $(X^n, p, d, g, f)$  with the following *properties.*

- *1. f is a locally Lipschitz function defined on X and f*(*p*) = 0*.*
- *2. X has a disjoint regular-singular decomposition X* = R ∪ S*, where* R *is the regular part,* S *is the singular part. A point is called regular if it has a neighborhood that is isometric to a totally geodesic convex domain of some smooth Riemannian manifold. A point is called singular if it is not regular.*
- *3.* ( $\mathcal{R}, g$ ) is an open (possibly incomplete) Riemannian manifold of dimension n with  $R \geq 0$  and *satisfies the Ricci steady soliton equation*

$$
Rc_f := Rc + \text{Hess } f = 0. \tag{A.1}
$$

- *4.* R *is geodesically convex, i.e., for any pair of points*  $x, y \in \mathbb{R}$ *, there exists a shortest geodesic in* R *connecting x and y.*
- <span id="page-60-0"></span>*5.* dim<sub>M</sub>  $S$  ≤ *n* − 4*, where* dim<sub>M</sub> *means Minkowski dimension.*
- *6. Every tangent space of x* ∈ S *is a metric cone of Hausdor*ff *dimension n. Moreover, if Y is a tangent cone of x, then the unit ball*  $B(\hat{x}, 1)$  *centered at vertex*  $\hat{x}$  *must satisfy*

$$
|B(\hat{x}, 1)| \le (1 - \delta_0)\omega_n
$$

*for some uniform positive number*  $\delta_0 = \delta_0(n) > 0$ *. Here the volume is the n-dimensional Hausdorff measure and*  $\omega_n$  *is the volume of the unit ball in*  $\mathbb{R}^n$ *.* 

Note that  $(X, d)$  is called a (Riemannian) conifold if all the properties in the above definition except equation  $(A.1)$  are satisfied (cf. Definition 1.2 of [\[24\]](#page-73-3)). The geodesic space  $(X,d)$  is the completion of  $(R, g)$ . The equation [\(A.1\)](#page-60-1) justifies the "steady soliton" in the name. By taking the divergence of [\(A.1\)](#page-60-1), we obtain  $R + |\nabla f|^2 = \lambda$  on  $\mathcal R$  for a constant  $\lambda \ge 0$ . If  $\lambda = 0$ , then  $R \equiv 0$  and  $f$ is a constant. From the equation  $\Delta_f R = -2|Rc|^2$  on R, we conclude that  $Rc \equiv 0$  on R. In this case,  $(X, d)$  is a Ricci-flat Riemannian conifold and is called a **trivial** steady soliton conifold. If  $\lambda > 0$ , we rescale the metric such that  $\lambda = 1$  and hence

$$
R + |\nabla f|^2 = 1\tag{A.2}
$$

on R. In this case,  $(X, d)$  is called a **nontrivial** Ricci steady soliton. In the following, we derive some geometric and analytic properties of  $(X, d) \in \mathfrak{S}(n)$ . Most results are generalizations of the corresponding results in [\[34\]](#page-74-1) for smooth metric measure spaces and can be proved similarly as in [\[24\]](#page-73-3). Moreover, we define the weighted measure  $e^{-f} dV$  by  $\mu$ , where  $dV$  is the *n*-dimensional Hausdorff measure and denote the volume with respect to  $d\mu$  by  $|\cdot|_{\mu}$ .

<span id="page-61-1"></span>**Proposition A.2.** *(Volume comparison) Let*  $(X, p, d, f) \in \mathfrak{S}(n)$ *. For any*  $0 < r_1 < r_2$  *and*  $x \in X$ *, we have*

<span id="page-61-0"></span>
$$
\frac{|B(x,r_2)|_{\mu}}{r_2^n} \le e^{r_2} \frac{|B(x,r_1)|_{\mu}}{r_1^n}.
$$
\n(A.3)

*Proof.* If  $(X, d)$  is smooth, then  $(A.3)$  follows from [\[68,](#page-76-0) Theorem 1.2] since  $Rc_f \ge 0$  and  $|\nabla f| \le 1$ <br>by  $(A, 2)$  For the general case, we can derive the result as [24 Proposition 2.3] by [\(A.2\)](#page-60-2). For the general case, we can derive the result as [\[24,](#page-73-3) Proposition 2.3].

Next, we have the following segment inequality, which is a generalization of [\[34,](#page-74-1) Theorem 2.6] by following the argument of [\[24,](#page-73-3) Proposition 2.6]

<span id="page-61-2"></span>**Proposition A.3.** *(Segment inequality) Let*  $(X, p, d, f) \in \mathfrak{S}(n)$ *. For any L > 0, there exists a constant C*<sub>1</sub> = *C*<sub>1</sub>(*n*, *L*) > 0 *such that if*  $A_1$ ,  $A_2$  *are two subsets of*  $B(q, r)$  ⊂⊂  $B(p, L)$ *, we have* 

$$
\int_{A_1 \times A_2} \mathcal{F}_u(x, y) d\mu(x) d\mu(y) \le C_1 r(|A_1|_{\mu} + |A_2|_{\mu}) \int_{B(q, 3r)} u \, d\mu,
$$

*where u is a nonnegative continuous function on B*(*q*, 3*r*) *and*

$$
\mathcal{F}_u(x,y) := \inf_{\gamma} \int_0^{d(x,y)} u(\gamma(t)) dt
$$

*with infimum being taken over all geodesics connecting q*<sup>1</sup> *and y.*

**Definition A.4.** The Sobolev space  $N^{1,2}(X,\mu)$  is the subspace of  $L^2(X,\mu)$  consisting of functions u *for which the norm*

$$
||u||_{N^{1,2}}^2 = ||u||_{L^2}^2 + \inf_{u_i} \liminf_{i \to \infty} ||h_i||_{L^2}^2 < \infty,
$$

*where the limit infimum is taken over all upper gradients h<sub>i</sub> of the functions u<sub>i</sub> satisfying*  $||u_i - u||_{L^2}$  *→ O. Notice that for any domain* Ω ⊂ *X*, *one can define*  $N^{1,2}$ (Ω,  $\mu$ ) *similarly. Also,*  $N_c^{1,2}$ ,  $N_0^{1,2}$  *and*  $N_{loc}^{1,2}$ *can be defined as the usual Sobolev space.*

The definition of the upper gradient can be found in Cheeger [\[16,](#page-73-4) Definition 1.1]. Notice that the only difference between  $N^{1,2}(X,\mu)$  and the one defined in [\[24,](#page-73-3) Definition 2.10] is the former uses the measure  $d\mu$ . Similar to [\[24,](#page-73-3) Corollary 2.12] and [\[24,](#page-73-3) Proposition 2.12], we have

<span id="page-61-3"></span>**Proposition A.5.**  $C_c^{\infty}(\mathcal{R}) \cap N^{1,2}(X,\mu)$  is dense in  $N^{1,2}(X,\mu)$ . Moreover, for any open set  $\Omega \subset X$ , the *restriction map*  $N^{1,2}(\Omega, \mu) \to W^{1,2}(\mathcal{R} \cap \Omega, \mu)$  *is an isomorphic isometry.* 

Combining Proposition [A.2](#page-61-1) and Proposition [A.3,](#page-61-2) we obtain the following local  $L^2$ -Poincaré inequality and local *L* 2 -Sobolev inequalities as [\[34,](#page-74-1) Proposition 2.7, 2.9]

**Proposition A.6.** *(Local L*<sup>2</sup>-Poincaré inequality) Let  $(X, p, d, f) \in \mathfrak{S}(n)$ . For any  $L > 0$ , there exists *a constant*  $C_2 = C_2(n, L) > 0$  *such that for any*  $B(q, r) \subset B(p, L)$ *, we have* 

$$
\int_{B(q,r)} \left| u - \int_{B(q,r)} u \, d\mu \right|^2 \, d\mu \le C_2 r^2 \int_{B(q,r)} |\nabla u|^2 \, d\mu,
$$

*for any*  $u \in N_{loc}^{1,2}(X, \mu)$ *, where* 

$$
\int_{B(q,r)} u \, d\mu := \frac{1}{|B(q,r)|_{\mu}} \int_{B(q,r)} u \, d\mu.
$$

<span id="page-62-3"></span>**Proposition A.7.** *(Local L*<sup>2</sup>-Sobolev inequality) Let  $(X, p, d, f) \in \mathfrak{S}(n)$ *. For any L* > 0*, there exists a constant*  $C_3 = C_3(n, L) > 0$  *such that for any*  $B(q, r) \subset B(p, L)$ *, we have* 

$$
\left(\int_{B(q,r)} u^{\frac{n}{n-2}} \, d\mu\right)^{\frac{n-2}{n}} \le \frac{C_3 r^2}{|B(q,r)|_{\mu}^{\frac{2}{n}}} \int_{B(q,r)} |\nabla u|^2 + r^{-2} u^2 \, d\mu,\tag{A.4}
$$

*for any*  $u \in N^{1,2}_{loc}(X, \mu)$ .

**Definition A.8.** Suppose  $u \in N_{loc}^{1,2}(\Omega, \mu)$  and  $h \in L_{loc}^2(\Omega, \mu)$ . Then  $\Delta_f u \leq h$  in the weak sense if for *any nonnegative*  $v \in N_c^{1,2}(\Omega, \mu)$ *,* 

<span id="page-62-4"></span>
$$
-\int_{\Omega\cap\mathcal{R}}\langle\nabla u,\nabla v\rangle d\mu\leq \int_{\Omega}vh\,d\mu.
$$

*Moreover, we say u is a harmonic function if*  $\Delta_f u = 0$  *in the weak sense.* 

As the singular part  $S$  has high codimension, we can extend any bounded subharmonic function on the regular part globally. The following lemma can be proved similarly as [\[24,](#page-73-3) Proposition 2.19].

<span id="page-62-1"></span>**Lemma A.9.** *Let*  $(X, p, d, f) \in \mathfrak{S}(n)$  *and*  $\Omega$  *a bounded open domain. Suppose u is a bounded function on* R ∩ Ω *satisfying*

$$
\Delta_f u = h \ge 0.
$$

*Then*  $u \in N_{loc}^{1,2}(\Omega, \mu)$  *and*  $\Delta_f u = h$  *in the weak sense on*  $\Omega$ *.* 

Next, we prove a quantitative version of the strong maximum principle.

<span id="page-62-0"></span>**Proposition A.10.** *Let*  $(X, p, d, f) \in \mathfrak{S}(n)$ *. Given any L and*  $q \in B(p, L)$ *, suppose u is a bounded, nonnegative, continuous function on*  $B(q, 3) \cap \mathcal{R}$  *such that* 

<span id="page-62-2"></span>
$$
\Delta_f u \le 0 \tag{A.5}
$$

*in the weak sense on B*( $q$ , 2)  $\cap$  *R*. Then there exists a constant  $\delta_1 = \delta_1(n, L) > 0$  such that if  $u(y) = \tau$ *for some*  $y \in B(q, 1) \cap \mathcal{R}$ *, then* 

$$
|\{u \leq 2\tau\} \cap B(q,2)|_{\mu} \geq \delta_1 |B(q,2)|_{\mu}.
$$

*In particular, either*  $u \equiv 0$  *on*  $B(q, 2) \cap \mathcal{R}$  *or* 

$$
\inf_{B(q,1)\cap \mathcal{R}} u > 0.
$$

*Proof.* It follows from Lemma [A.9](#page-62-1) that  $u \in N^{1,2}(B(q, 2), \mu)$  and [\(A.5\)](#page-62-2) holds on  $B(q, 2)$ , by the same argument of [\[24,](#page-73-3) Proposition 2.19]. If  $u = 0$  at some point in  $B(q, 2) \cap \mathcal{R}$ , it follows from the classical strong maximum principle that  $u \equiv 0$  on  $B(q, 2) \cap \mathcal{R}$ . Therefore, we may assume  $u > 0$  on  $B(q, 2) \cap \mathcal{R}$ .

Since  $(2\tau - u)^+$  is a bounded subharmonic function (with respect to  $\Delta_f$ ) in  $N^{1,2}(B(q, 2), \mu)$ . We can apply [\(A.7\)](#page-62-3), [\(A.4\)](#page-62-4) and the standard Moser iteration to obtain

$$
\|(2\tau - u)^{+}\|_{L^{\infty}(B(q,1))} \le C \left(\frac{1}{|B(q,1)|_{\mu}} \int_{B(q,2)} |(2\tau - u)^{+}|^{2} d\mu\right)^{\frac{1}{2}} \le C \left(\int_{B(q,2)} |(2\tau - u)^{+}|^{2} d\mu\right)^{\frac{1}{2}} \tag{A.6}
$$

for some constant  $C = C(n, L) > 0$ , where we have used [\(A.3\)](#page-61-0) for the last inequality. Since *u* is continuous on  $B(q, 2) \cap \mathcal{R}$  and  $u(y) = \tau$  for some  $y \in B(q, 1) \cap \mathcal{R}$ , it follows from [\(A.6\)](#page-63-0) that

$$
\tau \leq C \left( \int_{B(q,2)} |(2\tau - u)^+|^2 \, d\mu \right)^{\frac{1}{2}} \leq 2C \tau \left( \frac{|\{u \leq 2\tau\} \cap B(q,2)|_{\mu}}{|B(q,2)|_{\mu}} \right)^{\frac{1}{2}}.
$$

Therefore, the proof of [\(A.5\)](#page-62-2) is complete. For the last conclusion, if  $\inf_{B(a,1)\cap \mathcal{R}} u = 0$ , then there exists a sequence  $y_i \in B(q, 1) \cap \mathcal{R}$  with  $u(y_i) = \tau_i \to 0$ . Applying [\(A.5\)](#page-62-2) for  $\tau = \tau_i$ , we conclude that there exists a point  $z \in \overline{B}(a, 1) \cap \mathcal{R}$  such that  $u(z) = 0$ , which is a contradiction.

As an application, we have

<span id="page-63-1"></span>**Proposition A.11.** *Let*  $(X, p, d, f) \in \mathfrak{S}(n)$  *be compact. Then*  $Rc \equiv 0$  *on*  $\mathcal{R}$ *.* 

*Proof.* Since *X* is compact and *f* is locally Lipschitz, there exists a point  $q \in X$  such that

<span id="page-63-0"></span>
$$
f(q) = \inf_X f.
$$

From the equation  $\Delta_f(f - f(q)) = -(|\nabla f|^2 + R) \leq 0$ , we conclude from Proposition [A.10](#page-62-0) that *f* ≡ *f*(*q*). In this case, it follows from the steady soliton equation that  $Rc \equiv 0$  on  $\Re$ .

Next, we have the following existence result and gradient estimates for harmonic functions. The proof follows verbatim from [\[24,](#page-73-3) Proposition 2.26].

**Proposition A.12.** Let  $\Omega \subset X$  be a bounded domain and v a continuous function in  $N^{1,2}(\Omega,\mu)$ . Then *there is a unique solution*  $u \in N^{1,2}(\Omega, \mu)$  *solving the Dirichlet problem* 

$$
\Delta_f u = 0 \text{ in } \Omega \text{ and } u - v \in N_0^{1,2}(\Omega, \mu).
$$

*Moreover, the weak maximum principle holds for u, that is,*

$$
\sup_{\Omega} u = \sup_{\partial \Omega} u, \quad \inf_{\Omega} u = \inf_{\partial \Omega} u.
$$

Next, we have the following splitting result.

<span id="page-64-0"></span>**Proposition A.13.** *Let*  $(X, p, d, f) \in \mathfrak{S}(n)$ *. Suppose there exists a smooth function b on* R *satisfying* 

$$
\Delta_f b = s \quad and \quad |\nabla b| = t
$$

*on* R, where *s* and *t* are constants with  $t > 0$ . Then  $(X, d)$  is isometric to  $(Y \times \mathbb{R}, d' \times d_{g_E})$ , where (*Y*, *d* ′ ) *is a Ricci steady soliton conifold.*

*Proof.* It follows from the Weitzenböck formula that on  $\mathcal{R}$ 

$$
0 = \frac{1}{2}\Delta_f |\nabla b|^2 = |\text{Hess } b|^2 + Rc_f(\nabla b, \nabla b) + \langle \nabla \Delta_f b, \nabla b \rangle = |\text{Hess } b|^2.
$$

Therefore, Hess *b* = 0 and one can prove as [\[24,](#page-73-3) Lemma 2.31] that the gradient flow of  $\nabla b$  preserves the regular point. Now the conclusion follows easily. the regular point. Now the conclusion follows easily.

For any  $u, v \in N^{1,2}(X, \mu)$ , we define a nonnegative symmetric bilinear from  $\mathscr{E}$  by

$$
\mathscr{E}(u,v) := \int_{\mathcal{R}} \langle \nabla u, \nabla v \rangle \, d\mu.
$$

It can be proved (see [\[24,](#page-73-3) Proposition 2.15]) that  $\mathscr E$  is an irreducible, strongly local and regular Dirichlet form. The associated semigroup  $(P_t)_{\geq 0}$  can be expressed as

$$
P_t(u)(y) = \int u(x)p(t, x, y) d\mu(x), \quad \forall u \in L^2(X, \mu), \ t > 0.
$$

Here,  $p(t, x, y)$  is called the heat kernel with respect to  $\mathcal{E}$ . Notice the  $\Delta_f$  can be regarded as the unique generator concerning  $\mathscr E$  and the domain of  $\Delta_f$ , denoted by  $\Sigma(\Delta_f)$ , is a subspace of  $L^2(X,\mu)$ .

We have the following estimates which follow from [\[64\]](#page-76-1) and [\[65\]](#page-76-2) as [\[24,](#page-73-3) Proposition 2.20], see also [\[34,](#page-74-1) Theorem 3.1].

**Theorem A.14.** *(Heat kernel estimates) There exists a unique heat kernel*  $p(t, x, y)$  *with respect to the Dirichlet form* E *.*

*1. p*(*t*, *x*, *y*) *is stochastically complete. That is,*

$$
\int p(t, x, y) d\mu(x) = 1.
$$

*2. For any L* > 0*, there exists a constant*  $C_5 = C_5(n, L) > 0$  *such that* 

$$
\frac{C_5^{-1}}{|B(x, \sqrt{t})|_{\mu}} \exp\left(-\frac{d^2(x, y)}{C_5^{-1}t}\right) \le p(t, x, y) \le \frac{C_5}{|B(x, \sqrt{t})|_{\mu}} \exp\left(-\frac{d^2(x, y)}{C_5t}\right)
$$

*for any*  $x, y \in B(p, L)$  *and*  $0 < t < L^2$ *.* 

Next, we have the following Bakry-Émery condition.

<span id="page-65-0"></span>**Proposition A.15.** *(Bakry-Émery condition) Let*  $(X, p, d, f) \in \mathfrak{S}(n)$ *. Then for any*  $u \in \Sigma(\Delta_f)$  *with*  $\Delta_f u \in N^{1,2}(X, \mu)$  *and*  $v \in L^{\infty} \cap \Sigma(\Delta_f)$  *with*  $v \ge 0$  *and*  $\Delta_f v \in L^{\infty}$ *,* 

$$
\frac{1}{2}\int |\nabla u|^2 \Delta_f v \, d\mu \ge \int v \langle \nabla u, \nabla \Delta_f u \rangle \, d\mu.
$$

*Proof.* If  $u \in C_c^{\infty}(\mathcal{R})$ , then it follows from the Weitzenböck formula that

$$
\frac{1}{2}\Delta_f|\nabla u|^2 = |\text{Hess }u|^2 + R c_f(\nabla u, \nabla u) + \langle \nabla u, \nabla \Delta_f u \rangle \ge \langle \nabla u, \nabla \Delta_f u \rangle.
$$

Then for any  $v \in L^{\infty} \cap \Sigma(\Delta_f)$  with  $v \ge 0$  and  $\Delta_f v \in L^{\infty}$ , it is clear from the integration by parts that

$$
\frac{1}{2}\int |\nabla u|^2 \Delta_f v \, d\mu \ge \int v \langle \nabla u, \nabla \Delta_f u \rangle \, d\mu.
$$

Now the general case follows by approximating *u* by functions in  $C_c^{\infty}(\mathcal{R})$  as Proposition [A.5.](#page-61-3)  $\Box$ 

Now we obtain the following result. For the definition of  $RCD(K, \infty)$  space, see [\[29,](#page-74-4) Definition 2.1].

**Theorem A.16.** *Let*  $(X, p, d, f) \in \mathfrak{S}(n)$ *. Then*  $(X, d, \mu)$  *is a* RCD $(0, \infty)$  *space.* 

*Proof.* (i), (ii) and (iv) in [\[29,](#page-74-4) Definition 2.1] follow from the definition of  $\mathscr E$ , Proposition [A.2](#page-61-1) and Proposition [A.15,](#page-65-0) respectively. (iii) in [\[29,](#page-74-4) Definition 2.1] follows from Proposition [A.5](#page-61-3) and the corresponding result on  $\mathcal{R}$ .

For applications, we have the following gradient estimate for the positive harmonic function, see also [\[51,](#page-75-5) Theorem 1.1].

<span id="page-65-1"></span>**Proposition A.17** (Cheng-Yau estimate). Let  $(X, p, d, f) \in \mathfrak{S}(n)$ . Suppose  $\Omega = B(x, 4r)$  and  $u \in$  $L^{\infty}(\Omega) \cap N^{1,2}(\Omega,\mu)$  *satisfies* 

$$
\Delta_f u = 0.
$$

*Then there exists a constant*  $C_4 = C_4(n) > 0$  *such that if*  $x \in \mathcal{R}$ ,

$$
|\nabla u|(x)\leq \frac{C_4}{r}||u||_{L^\infty(\Omega)}.
$$

*Proof.* The proof follows verbatim from [\[24,](#page-73-3) Proposition 2.24] by using the  $\delta$ -function property of the heat kernel and the weighted Sobolev inequality. The latter can be derived from [\[1,](#page-72-7) Proposition 2.1], since  $(X, d, \mu)$  is a RCD(0,  $\infty$ ) space.

From Proposition [A.17,](#page-65-1) we immediately obtain

<span id="page-65-2"></span>Corollary A.18 (Liouville theorem). *Suppose u is a harmonic function on* R *with sublinear growth, then*  $u \equiv C$  *on*  $\mathcal{R}$ *.* 

Now we recall

Definition A.19. *The first eigenvalue fo* ∆*<sup>f</sup> is defined by*

$$
\lambda := \inf_{u \in N^{1,2}(X,\mu)} \frac{\mathscr{E}(u,u)}{\int u^2 d\mu} = \inf_{u \in C_c^\infty(\mathcal{R})} \frac{\int |\nabla u|^2 d\mu}{\int u^2 d\mu}.
$$

Notice that the last equality holds from Proposition [A.5.](#page-61-3) For any non-compact Ricci steady soliton conifold, we have the following theorem, which is a generalization of [\[51,](#page-75-5) Proposition 2.1].

<span id="page-66-1"></span>**Theorem A.20.** *Let*  $(X, p, d, f) \in \mathfrak{S}(n)$  *be non-compact. Then*  $\lambda = \frac{1}{4}$  $\frac{1}{4}$ .

*Proof.* First we show that  $\lambda \leq 1/4$ . This can be done by considering the test function  $u(x)$  :=  $e^{-\frac{1}{4}(1+\epsilon)d(p,x)}\phi(x)$ , where  $\phi$  is a cutoff function with  $\phi = 1$  on  $B(p, L - 1)$  and  $\phi = 0$  outside  $B(p, L)$ . Since the volume  $|B(p, L)| \le L^n e^L |B(p, 1)|_\mu$  by [\(A.3\)](#page-61-0), one can compute directly that  $\lambda \le \frac{1}{4}$  $\frac{1}{4}(1+\epsilon)^2$ for any  $\epsilon > 0$ .

Next we compute on  $\mathcal{R}$ ,

$$
\Delta_f e^{\frac{f}{2}} = \left(-\frac{1}{2} + \frac{|\nabla f|^2}{4}\right) e^{\frac{f}{2}} \le -\frac{1}{4} e^{\frac{f}{2}}.
$$

Since *f* is locally bounded, the above equation also holds on *X* in the weak sense. Therefore, we have  $\lambda \ge 1/4$  by the same argument of [\[51,](#page-75-5) Lemma 2.2].

Theorem [A.20](#page-66-1) implies, in particular, that any non-compact  $(X, p, d, f) \in \mathfrak{S}(n)$  admits a positive Green's function (see, e.g. [\[28,](#page-74-5) Lemma 5.2]):

$$
G(x, y) = \int_0^\infty p(t, x, y) dt.
$$

Next, we recall the following definition.

**Definition A.21.** *Let*  $(X, p, d, f) \in \mathfrak{S}(n)$  *be non-compact and E an end of X. E is said to be parabolic if it does not admit a positive harmonic function h satisfying*

$$
h = 1
$$

*on* ∂*E and*

$$
\liminf_{x \to E(\infty)} h(x) < 1,
$$

*where*  $E(\infty)$  *denotes the infinity of E. Otherwise, E is said to be nonparabolic.* 

It is clear from the existence of a positive Green's function that *X* has at least one nonparabolic end.

Now we can follow the same proof as in [\[51,](#page-75-5) Theorem 4.1] to prove the following result.

<span id="page-66-0"></span>**Theorem A.22.** *Let*  $(X, p, d, f) \in \mathfrak{S}(n)$  *be non-compact and nontrivial. Then X* has only one end.

*Proof.* We assume *X* has at least two ends and derive a contradiction. We first show *X* has at most one nonparabolic end. Indeed, if *X* has two nonparabolic end, one can follow the arguments of [\[43,](#page-74-6) Theorem 21.1, 21.3] to construct a positive, bounded, nonconstant, harmonic function *u* satisfying

$$
\mathscr{E}(u,u)=\int |\nabla u|^2\,d\mu<\infty.
$$

However, this contradicts Corollary [A.18.](#page-65-2) Hence, *X* has exactly one nonparabolic end *E*. Suppose *X* has more than one end, then we can choose *F* as a parabolic end. For simplicity, we may assume that *X* has exactly two ends *E* and *F*.

**Claim 1:** *F* contains a geodesic ray  $\gamma \subset F \cap \mathcal{R}$ .

Actually, we fix a point  $q \in \mathcal{R} \cap F$  and a sequence of points  $y_i \in \mathcal{R} \cap F$ . Let  $\alpha_i \subset \mathcal{R}$  be a shortest geodesic connecting  $q$  and  $y_i$ , whose existence is guaranteed by item 4 of Definition A.1. Then  $\alpha_i$ converges to a geodesic  $\gamma \subset F$ , naturally parametrized by arc length, such that  $\gamma(0) = q$ . Since *q* is regular point, there exists a small constant  $\epsilon$  such that  $\gamma([0, \epsilon]) \subset \mathcal{R}$ . In particular, at each point  $y \in \gamma([0, \epsilon])$ , each tangent space at *y* is  $\mathbb{R}^n$ . By volume comparison and heat kernel estimate(cf. [\[34,](#page-74-1) Theorem 4.5]), for each sequence  $r_\alpha \to 0^+$ , the unit balls in tangent spaces associated to this sequence and points  $y = \gamma(t)$  varies continuously in Gromov-Hausdorff topology for  $t \in [0.5\epsilon, \infty)$ . In particular, the volume of unit balls in tangent spaces is then a continuous function of *t*. Thus, by the gap property(Item 6 of Definition A.1), it is a constant independent of *t*. This means that for each  $t \in [0.5\epsilon, \infty)$ , a tangent space of  $\gamma(t)$  is  $\mathbb{R}^n$ . Therefore, it follows from definition that  $\gamma(t)$  is a regular point, i.e.,  $\gamma(t) \in \mathcal{R}$  for any  $t \geq 0$ . We define the Busemann function

$$
\beta(x) = \lim_{t \to \infty} (t - d(x, \gamma(t))).
$$

It follows from the Laplacian comparison that

$$
\Delta_f \beta \ge -1, \quad |\nabla \beta| = 1,
$$

which in turn implies that

<span id="page-67-1"></span><span id="page-67-0"></span>
$$
\Delta_f e^{\beta} \ge 0. \tag{A.7}
$$

**Claim 2:** Fix  $p \in X$ , for all  $L > 0$  large enough, we have

$$
|B(p, L) \cap E|_{\mu} \le Ce^{L}.\tag{A.8}
$$

On the end *E*, the function  $d(p, \cdot) + \beta$  is uniformly bounded. Therefore, it suffices to show that for some large  $s > 0$ , we have

$$
|\{s < -\beta < t\} \cap E|_{\mu} \le Ce^t, \quad \forall \ t > s. \tag{A.9}
$$

Actually, by perturbing distance function and the high co-dimension assumption of  $S(\text{cf. } [24, \text{Corol-}])$  $S(\text{cf. } [24, \text{Corol-}])$  $S(\text{cf. } [24, \text{Corol-}])$ lary B.3]), for each small  $\delta > 0$ , we can find an almost "tubular neighborhood"  $T_{\delta}$  of S. The distance from any point in  $\partial T_{\delta}$  to S is comparable to  $\delta$ , and the  $(n-1)$ -dimensional Hausdorff measure of

 $\partial T_{\delta} \cap K$  is bounded by  $C(K)\delta^2$  for dimensional reason, where *K* is any compact set. Applying integration by parts away from  $T_\delta$ , we have

$$
0\leq \int_{\{s<-\beta
$$

where  $\vec{n}$  is the outward unit normal vector of  $\partial T_{\delta}$ . It follows that

$$
|\{\beta = -t\} \cap (E \setminus T_\delta)|_\mu \le e^{t-s} |\{\beta = -s\} \cap E|_\mu + C(E, s, t) \delta^2 e^t,
$$

where  $\mu$  is the induced measure on the hypersurfaces. Integrating the above inequality, we obtain

$$
|\{s<-\beta
$$

Letting  $\delta \to 0$ , we arrive at [\(A.9\)](#page-67-0). By choosing proper cutoff functions, integration by parts(cf. [\[24,](#page-73-3) Proposition 2.17], [\[49,](#page-75-6) Theorem 1.4]) then implies that

$$
|F \backslash B(p, L)|_{\mu} \le Ce^{-L}.\tag{A.10}
$$

Then we verbatim follow the proof in [\[51\]](#page-75-5). Define a cut-off function  $\phi$  with support in *B*(*p*, 2*L*) such that  $\phi = 1$  on  $B(p, L)$  and  $|\nabla \phi| \leq CL^{-1}$ . Using the fact  $\lambda_1(\Delta_f) = \frac{1}{4}$  $\frac{1}{4}$ , and the volume estimate [\(A.9\)](#page-67-0) and [\(A.10\)](#page-68-2), integration by parts implies that

$$
\frac{1}{2}\int_X \left\{\Delta_f e^{\beta}\right\} \phi^2 e^{-f} = \int_X e^{\frac{1}{2}\beta} \left(\Delta_f e^{\frac{1}{2}\beta} + \frac{1}{4}e^{\frac{1}{2}\beta}\right) \phi^2 e^{-f} \le \int_X |\nabla \phi|^2 e^{\beta} e^{-f} \le \frac{C}{L} \to 0.
$$

It then follows from the combination of  $(A.7)$  and the above inequality that on  $\mathcal{R}$ ,

$$
\Delta_f e^{\beta} = 0, \quad \Delta_f \beta = -1 \quad \text{and} \quad |\nabla \beta| = 1.
$$

It follows from Proposition [A.13](#page-64-0) that  $(X, d)$  is isometric to  $(Y \times \mathbb{R}, d' \times d_{g_E})$ , where  $(Y, d')$  is a Ricci steady soliton conifold. Since we assume *X* has at least two ends, *Y* must be compact. Therefore, it follows from Proposition [A.11](#page-63-1) that  $Rc<sub>Y</sub>$  and hence  $Rc<sub>X</sub>$  are identically 0 on  $R$ .

In sum, we obtain a contradiction, and the original conclusion holds.

### <span id="page-68-1"></span>B Improvement theorems of symmetry

We recall the following definition, see [\[9,](#page-72-5) Definition 4.2].

<span id="page-68-0"></span>Definition B.1 (Neck-symmetry). *Let* (*M<sup>n</sup>* , *g*(*t*)) *be an n-dimensional Ricci flow solution and let*  $(\bar{x}, \bar{t})$  *be a spacetime point with*  $R(\bar{x}, \bar{t}) = \frac{n-1}{2}r^{-2}$ . Assume that  $(\bar{x}, \bar{t})$  *is the center of an evolving*  $\bar{\epsilon}$ -neck for some small positive number  $\bar{\epsilon}$ . We say  $(\bar{x}, \bar{t})$  is  $\epsilon$ -symmetric if there exists a smooth, time*independent family of vector fields*  $\mathcal{U} = \{U^{(a)} : 1 \le a \le \binom{n}{2}\}$  $\left\{ \frac{n}{2} \right\}$  defined on the closed ball  $\bar{B}_{g(\bar{t})}(\bar{x}, 100r)$ *with the following properties:*

• *In B*<sub>*g*( $\bar{t}$ )( $\bar{x}$ , 100*r*) × [ $\bar{t}$  – 100*r*<sup>2</sup>,  $\bar{t}$ ]*, we have the estimate*</sub>

$$
\sum_{l=0}^2 \sum_{a=1}^{n \choose 2} r^{2l} |D^l(\mathcal{L}_{U^{(a)}}(g(t)))|^2 \leq \epsilon^2.
$$

• If  $t \in [\bar{t} - 100r^2, \bar{t}]$  *and*  $v$  *denotes the unit normal vector to Hamilton's CMC foliation of the*  $\bar{\epsilon}$ -neck at time t, then in  $B_{g(\bar{t})}(\bar{x}, 100r)$ *, we have the estimate* 

$$
\sum_{a=1}^{\binom{n}{2}} r^{-2} |\langle U^{(a)}, v \rangle|^2 \le \epsilon^2.
$$

 $\bullet$  *If*  $t \in [\bar{t} - 100r^2, \bar{t}]$  and  $\Sigma \subset B_{g(\bar{t})}(\bar{x}, 100r)$  *is a leaf of Hamilton's CMC foliation of the*  $\bar{\epsilon}$ -neck *at time t, then*

$$
\sum_{a,b=1}^{\binom{n}{2}}\left|\delta_{ab}-\mathrm{area}_{g(t)}(\Sigma)^{-\frac{n+1}{n-1}}\int_{\Sigma}\langle U^{(a)},U^{(b)}\rangle_{g(t)}\,d\mu_{g(t)}\right|^2\leq\epsilon^2.
$$

Now we state the Neck Improvement Theorem proved by Brendle [\[5,](#page-72-8) Theorem 8.6] in dimension 3 and Brendle-Naff [\[9,](#page-72-5) Theorem 4.8] in general dimension.

<span id="page-69-1"></span>Theorem B.2 (Improvement Theorem A). *There exists a large constant*  $\overline{L}$  (depending only upon n) *and a small constant*  $\delta_1$  (depending only upon  $\overline{L}$  and n) with the following property. Let  $(M^n, g(t))$ *be a Ricci flow solution, and let*  $(x_0, t_0)$  *be a spacetime point that is the center of an evolving*  $\delta_1$ -neck *and satisfies*  $R(x_0, t_0) = \frac{n-1}{2}r^{-2}$ . Moreover, suppose that every point in the parabolic neighborhood  $B_{g(t_0)}(x_0, \bar{L}r) \times [t_0 - \bar{L}r^2, t_0]$  *is*  $\epsilon$ -symmetric, where  $\epsilon \leq \delta_1$ . Then  $(x_0, t_0)$  *is*  $\frac{\epsilon}{2}$ -symmetric.

Next, we define the global symmetry of the Ricci flow. We have the following three types.

<span id="page-69-0"></span>**Definition B.3** ( $\epsilon$ -symmetry of type-A). *Let*  $(M^n, g(t))_{t \leq \overline{t}}$  *be an n-dimensional Ricci flow solution.*  $(M<sup>n</sup>, g(t))$  *is said to be*  $\epsilon$ *-symmetric of type-A at time*  $\bar{t}$  *if* 

- *M* is diffeomorphic to  $S^{n-1} \times \mathbb{R}$ .
- $(x, \bar{t})$  *is*  $\epsilon$ -symmetric in the sense of Definition [B.1](#page-68-0) for any  $x \in M$ .

Now we make the following assumptions for ancient solutions to the Ricci flow.

<span id="page-69-2"></span>**Assumption 1.** *There exists a constant*  $\theta_0 > 0$  *such that if spacetime point*  $(x, t)$  *of the Ricci flow* (*M<sup>n</sup>* , *g*(*t*))*t*≤<sup>0</sup> *satisfies*

$$
\lambda_1(x,t) \le \theta_0 R(x,t),
$$

*where*  $\lambda_1$  *to be the minimal eigenvalue of Rc, then*  $(x, t)$  *is*  $\delta_1$ -symmetric *in the sense of Definition [B.1,](#page-68-0) where*  $\delta_1$  *is the constant in Theorem [B.2.](#page-69-1)* 

<span id="page-70-0"></span>**Assumption 2.** *There exists a constant*  $\Lambda_0 > 0$  *such that for the Ricci flow solution*  $(M^n, g(t))_{t \leq 0}$ *with a marked point z, if*  $(\bar{x}, \bar{t}) \in M \times (-\infty, 0]$  *and*  $d_{g(\bar{t})}(z, \bar{x}) \ge \Lambda_0 R(z, \bar{t})^{-\frac{1}{2}}$ *, then* 

$$
\lambda_1(x,t) \le \frac{\theta_0}{2} R(x,t),
$$

for any  $(x, t) \in B_{g(\bar{t})}(\bar{x}, \bar{L}R(\bar{x}, \bar{t})^{-\frac{1}{2}}) \times [\bar{t} - \bar{L}R(\bar{x}, \bar{t})^{-1}, \bar{t}],$  where  $\bar{L}$  is the constant in Theorem [B.2.](#page-69-1)

The definition of the symmetry of type-B follows from [\[9,](#page-72-5) Definition 5.2]. In the following, we set  $r_{\text{max}}(t) = (\max_{M} R(t))^{-\frac{1}{2}}$ .

<span id="page-70-1"></span>**Definition B.4** ( $\epsilon$ -symmetry of type-B). *The Ricci flow*  $(M^n, g(t))_{t \leq \overline{t}}$  *with Assumption [1](#page-69-2) and Assumption* [2](#page-70-0) is called  $\epsilon$ -symmetric of type-B at time  $\bar{t}$  if M is diffeomorphic to  $\mathbb{R}^n$  and there exists a *compact domain*  $D \subset M$  and a family of time-independent vector fields  $\mathcal{U} = \{U^{(a)} : 1 \le a \le \binom{n}{2}$  $\binom{n}{2}$ *which are defined on an open subset containing D such that the following statements hold:*

- *There exists a point*  $x \in \partial D$  *such that*  $\lambda_1(x, \bar{t}) < \theta_0 R(x, \bar{t})$ *.*
- *For each*  $x \in D$ , we have  $\lambda_1(x, \overline{t}) > \frac{1}{2}$  $\frac{1}{2}\theta_0 R(x,\bar{t}).$
- *The boundary* <sup>∂</sup>*D is a leaf of Hamilton's CMC foliation at time t.*¯
- *For each*  $x \in M \setminus D$ , the point  $(x, \bar{t})$  is  $\epsilon$ -symmetric in the sense of Definition [B.1.](#page-68-0)
- *In*  $D \times [\bar{t} r_{\text{max}}(\bar{t})^2, \bar{t}]$ , we have the estimate

$$
\sum_{l=0}^{2}\sum_{a=1}^{\binom{n}{2}}r_{\max}(\bar{t})^{2l}|D^{l}(\mathcal{L}_{U^{(a)}}(g(t)))|^{2} \leq \epsilon^{2}.
$$

• *If*  $\Sigma \subset D$  is a leaf of Hamilton's CMC foliation of  $(M, g(\overline{t}))$  that has distance at most 50  $r_{\text{neck}}(\partial D)$ *from* ∂*D, then*

$$
\sup_{\Sigma}\sum_{a=1}^{{n\choose 2}}r_{\max}(\bar{t})^{-2}|\langle U^{(a)},\nu\rangle|^2\leq\epsilon^2,
$$

*where v is the unit normal vector to*  $\Sigma$  *in*  $(M, g(\overline{t}))$  *and*  $r_{\text{neck}}(\partial D)$  *is defined by the identity*  $area_{g(\bar{t})}(\partial D) = area_{g_{S^{n-1}}} (S^{n-1}) r_{\text{neck}}(\partial D)^{n-1}.$ 

• *If*  $\Sigma \subset D$  is a leaf of Hamilton's CMC foliation of  $(M, g(\bar{t}))$  that has distance at most 50  $r_{\text{neck}}(\partial D)$ *from* ∂*D, then*

$$
\sum_{a,b=1}^{\binom{n}{2}}\left|\delta_{ab}-\text{area}_{g(\bar{t})}(\Sigma)^{-\frac{n+1}{n-1}}\int_{\Sigma}\langle U^{(a)},U^{(b)}\rangle_{g(\bar{t})}\,d\mu_{g(\bar{t})}\right|^2\leq\epsilon^2,
$$

*where*  $r_{\text{neck}}(\partial D)$  *is defined by the identity* are  $a_{g(\bar{t})}(\partial D) = \text{area}_{g_{S^{n-1}}}(S^{n-1})r_{\text{neck}}(\partial D)^{n-1}$ .

Now we can state the improvement theorem for the second type. The proof follows verbatim from [\[5,](#page-72-8) Section 9] and [\[9,](#page-72-5) Section 5].

<span id="page-71-0"></span>**Theorem B.5** (Improvement Theorem B). *There exist positive constants*  $\delta_2$  *and*  $\delta_3$  *depending only*  $\theta_0$ ,  $\Lambda_0$  *and n with the following property. Let*  $(M^n, g(t))_{t \leq \overline{t}}$  *be a Ricci flow solution satisfying Assumption 1* and Assumption [2.](#page-70-0) Suppose  $(M^n, g(t))$  is  $\epsilon$ -symmetric of type-B at time t for any  $t \leq \bar{t}$ *with*  $\epsilon \leq \delta_2$  *and the marked point z in the Assumption* [2](#page-70-0) *belongs to D. Moreover, after rescaling the metric by r<sup>−2</sup>, the parabolic neighborhood*  $B_{g(\bar{t})}(z, \delta_3^{-1}r) \times [\bar{t} - \delta_3^{-1}r, \bar{t}]$  *is*  $\delta_3$ -close in the  $C^{[\delta_3^{-1}]}$ . *topology to the Bryant soliton based at the tip whose scalar curvature is* 1*, where R*(*z*, *t*̄) =  $r^{-2}$ *. Then*  $(M^n, g(t))$  *is*  $\frac{\epsilon}{2}$ -symmetric of type-B at  $\bar{t}$ .

<span id="page-71-1"></span>Assumption 3. *There exists a constant*  $\Lambda_1 > 0$  *such that for the Ricci flow solution*  $(M^n, g(t))_{t \leq 0}$ with two marked points  $z_1, z_2$ , if  $(\bar{x}, \bar{t}) \in M \times (-\infty, 0]$ ,  $d_{g(\bar{t})}(z_1, \bar{x}) \ge \Lambda_1 R(z_1, \bar{t})^{-\frac{1}{2}}$  and  $d_{g(\bar{t})}(z_2, \bar{x}) \ge$  $\Lambda_1 R(z_2, \bar{t})^{-\frac{1}{2}}$ , then

$$
\lambda_1(x,t) \le \frac{\theta_0}{2} R(x,t),
$$

for any  $(x, t) \in B_{g(\bar{t})}(\bar{x}, \bar{L}R(\bar{x}, \bar{t})^{-\frac{1}{2}}) \times [\bar{t} - \bar{L}R(\bar{x}, \bar{t})^{-1}, \bar{t}],$  where  $\bar{L}$  is the constant in Theorem [B.2.](#page-69-1)

Next, we have the following definition, see [\[6,](#page-72-9) Definition 3.1].

<span id="page-71-2"></span>**Definition B.6** ( $\epsilon$ -symmetry of type-C). *The Ricci flow*  $(M^n, g(t))_{t \leq \bar{t}}$  *with Assumption [1](#page-69-2) and Assumption* [3](#page-71-1) *is called*  $\epsilon$ -symmetric of type-C at time  $\bar{t}$  if M is diffeomorphic to S<sup>n</sup> and there exists a *compact domain*  $D \subset M$  and a family of time-independent vector fields  $\mathcal{U} = \{U^{(a)} : 1 \le a \le \binom{n}{2}$  $\binom{n}{2}$ *which are defined on an open subset containing D such that the following statements hold:*

- *The domain D is a disjoint union of two domains D*<sup>1</sup> *and D*2*, each of which is di*ff*eomorphic to B<sup>n</sup> .*
- $\lambda_1(x, \overline{t}) < \theta_0 R(\overline{x}, \overline{t})$  *for all points*  $x \in M \setminus D$ .
- $\lambda_1(x, \bar{t}) > \frac{1}{2}$  $\frac{1}{2}\theta_0 R(x, \bar{t})$  *for all points*  $x \in D$ .
- $\partial D_1$  *and*  $\partial D_2$  *are leaves of Hamilton's CMC foliation of*  $(M, g(\overline{t}))$ *.*
- *For each*  $x \in M \setminus D$ , the point  $(x, \overline{t})$  is  $\epsilon$ -symmetric in the sense of Definition [B.1.](#page-68-0)
- *The Lie derivative*  $\mathcal{L}_{U^{(a)}}(g(t))$  *satisfies for each*  $k \in \{1, 2\}$  *the estimate*

$$
\sup_{D_k \times [\bar{t} - \rho_k^2, \bar{t}]} \sum_{l=0}^2 \sum_{a=1}^{{n \choose 2}} \rho_k^{2l} |D^l(\mathcal{L}_{U^{(a)}}(g(t)))|^2 \le \epsilon^2,
$$

*where*  $\rho_k^{-2} := \sup_{x \in D_k} R(x, \bar{t}).$ 

• *For each*  $k \in \{1, 2\}$ , the following property holds. If  $\Sigma \subset D_k$  is a leaf of Hamilton's CMC *foliation of*  $(M, g(\bar{t}))$  *that has distance at most* 50  $r_{\text{neck}}(\partial D_k)$  *from*  $\partial D_k$ *, then* 

$$
\sup_{\Sigma}\sum_{a=1}^{{n\choose 2}}\rho_k^{-2}|\langle U^{(a)},\nu\rangle|^2\leq\epsilon^2,
$$

*where*  $\nu$  *is the unit normal vector to*  $\Sigma$  *in*  $(M, g(\overline{t}))$  *and*  $r_{\text{neck}}(\partial D_k)$  *is defined by the identity*  $area_{g(\bar{t})}(\partial D_k) = area_{g_{S^{n-1}}}(S^{n-1})r_{\text{neck}}(\partial D_k)^{n-1}.$
• *For each*  $k \in \{1, 2\}$ , the following property holds. If  $\Sigma \subset D_k$  is a leaf of Hamilton's CMC *foliation of*  $(M, g(\overline{t}))$  *that has distance at most* 50  $r_{\text{neck}}(\partial D_k)$  *from*  $\partial D_k$ *, then* 

$$
\sum_{a,b=1}^{{n \choose 2}} \left|\delta_{ab}-\text{area}_{g(\bar{t})}(\Sigma)^{-\frac{n+1}{n-1}}\int_{\Sigma}\langle U^{(a)},U^{(b)}\rangle_{g(\bar{t})}\,d\mu_{g(\bar{t})}\right|^2 \leq \epsilon^2.
$$

Following the same arguments of [\[7,](#page-72-0) Section 3] and [\[6,](#page-72-1) Section 3], we have the following theorem.

**Theorem B.7** (Improvement Theorem C). *There exist positive constants*  $\delta_4$  *and*  $\delta_5$  *depending only on*  $\theta_0$ ,  $\Lambda_1$  *and n with the following property. Let*  $(M^n, g(t))_{t \leq \overline{t}}$  *be a Ricci flow solution satisfying Assumption 1* and Assumption [3.](#page-71-0) Suppose  $(M^n, g(t))$  is  $\epsilon$ -symmetric of type-C at time t for any  $t \leq \bar{t}$ *with*  $\epsilon \leq \delta_4$  *and the marked points*  $z_1$  *and*  $z_2$  *in the Assumption* [3](#page-71-0) *belong to*  $D_1$  *and*  $D_2$  *respectively. Moreover, after rescaling the metric by*  $r_i^{-2}$ *, the parabolic neighborhood*  $B_{g(\bar{t})}(z_i,\delta_5^{-1}r_i)\times[\bar{t}-\delta_5^{-1}r_i,\bar{t}]$ *is*  $\delta$ <sub>5</sub>-close in the  $C^{[\delta_{5}^{-1}]}$ -topology to the Bryant soliton based at the tip whose scalar curvature is 1 *for i* = 1, 2, where  $R(z_i, \bar{t}) = r_i^{-2}$ . Then  $(M^n, g(t))$  is  $\frac{\epsilon}{2}$ -symmetric of type-C at  $\bar{t}$ .
