

Fractional weight multiplier systems on $SU(d, 1)$

Abstract

For a class of arithmetic subgroups $\Gamma \subset SU(d, 1)$ we prove that for every positive integer n there exists a subgroup Γ_n of finite index in Γ , which lifts to the n -fold connected cover of $SU(d, 1)$. Consequently Γ_n has a multiplier system of weight $\frac{1}{n}$.

1 Introduction

1.1 Some History

Let G be a connected, non-compact, semi-simple real Lie group, and $\Gamma \subset G$ an arithmetic subgroup. By an automorphic form on G with character $\chi : \Gamma \rightarrow \mathbb{C}$, one generally means a function $f : G \rightarrow \mathbb{C}$ satisfying (amongst several analytic properties) the transformation formula:

$$f(\gamma g) = \chi(\gamma) \cdot f(g), \quad \gamma \in \Gamma, g \in G.$$

Suppose also that the fundamental group of G is isomorphic to \mathbb{Z} , so that for each positive integer n there is a connected n -fold cover:

$$1 \rightarrow \mathbb{Z}/n \rightarrow \tilde{G}^{(n)} \rightarrow G \rightarrow 1.$$

Let $\tilde{\Gamma}^{(n)}$ denote the pre-image of Γ in $\tilde{G}^{(n)}$. By a *fractional weight form with denominator n* , one means a function $f : \tilde{G}^{(n)} \rightarrow \mathbb{C}$, satisfying the transformation formula

$$f(\gamma g) = \chi(\gamma) \cdot f(g), \quad \gamma \in \tilde{\Gamma}^{(n)}, g \in \tilde{G}^{(n)},$$

where the character $\chi : \tilde{\Gamma}^{(n)} \rightarrow \mathbb{C}^\times$ is injective on the subgroup \mathbb{Z}/n . The question of whether such forms exist is essentially equivalent to the question of whether the group $\tilde{\Gamma}^{(n)}$ splits as a direct sum of \mathbb{Z}/n and a lift of Γ to the n -fold cover of G . We shall answer this question in some new cases in this paper.

Main question. Given Γ and G as above, and a positive integer n , does there exist a subgroup $\Gamma_n \subset \Gamma$ of finite index, such that Γ_n lifts to the n -fold cover $\tilde{G}^{(n)}$?

The case of $\mathrm{SL}_2(\mathbb{R})$. The question above was considered first in the case $G = \mathrm{SL}_2(\mathbb{R})$ by Petersson [14], [15]. He showed that in this case, the answer is “yes”. More precisely, recall that there are two kinds of arithmetic subgroup Γ . If Γ has cusps, then some finite index subgroup Γ' is free. Hence Γ' lifts to the n -fold cover for every n . If on the other hand Γ is cocompact, then some finite index subgroup $\Gamma' \subset \Gamma$ is a surface group. In this case, it is sufficient to take Γ_n to be any subgroup of index n in Γ' .

The fractional weight forms found by Petersson have recently been studied by Ibukiyama and others (see for example [11]).

Metaplectic forms. Suppose that G is the group $\mathbb{G}(\mathbb{R})$ of real points of some algebraic group \mathbb{G} over \mathbb{Q} , and that Γ is a congruence subgroup of $\mathbb{G}(\mathbb{Q})$. It has been known for some time that any such Γ contains a congruence subgroup Γ_2 which has half-integral weight automorphic forms. Such forms are called *metaplectic forms*, and arise because of the splitting of the 2-fold metaplectic cover of $\mathbb{G}(\mathbb{A})$ over the subgroup $\mathbb{G}(\mathbb{Q})$ (here we are writing \mathbb{A} for the adèle ring of \mathbb{Q}). This result was proved in its most general form by Deligne [6]. Such metaplectic forms have been hugely studied. The basic examples are theta series.

There are also analogous “metaplectic forms” of other fractional weights (i.e. with $n > 2$). However, these forms do not arise from a connected cover of a real Lie group, but rather from an n -fold cover of the group $\mathbb{G}(\mathbb{A}_f)$ of finite-adèle points of \mathbb{G} . These metaplectic forms with $n > 2$ are not the subject of this paper.

The congruence subgroup problem. As far as the author knows, the next person to consider the question above was Deligne [5], who considered the case $G = \mathrm{Sp}_{2d}(\mathbb{R})$. Deligne proved that no arithmetic subgroup of $\mathrm{Sp}_{2d}(\mathbb{Z})$ for $d \geq 2$ can lift to the n -fold cover of $\mathrm{Sp}_{2d}(\mathbb{R})$ for $n > 2$. Deligne’s proof uses the congruence subgroup property, which had been established for such groups by Bass, Milnor and Serre [1]. Indeed, Deligne’s result applies to any case where the congruence subgroup property is known. Thus we have

If Γ has the congruence subgroup property and $n > 2$, then the answer to the main question above is “no”.

Recall that the congruence subgroup property is conjectured to hold for groups of real rank at least 2. Hence the question above remains most interesting for groups G of real rank 1. Up to an isometry, the only such group with fundamental group \mathbb{Z} is $\mathrm{SU}(d, 1)$. We focus on this case in this paper.

Recently Stover and Toledo [16], have proved for several arithmetic subgroups of $\mathrm{SU}(1, 2)$ that there do indeed exist subgroups Γ_n which lift to the n -fold cover. The main result of this paper generalizes theirs.

1.2 Statement of results

There are two kinds of arithmetic subgroup of $\mathrm{SU}(d, 1)$, which we shall call (following [2]) the “first kind” and the “second kind”. This paper is concerned with arithmetic groups of the first kind. We briefly review the construction.

Let F be a totally real number field and E/F a totally complex quadratic extension. We shall write $z \mapsto \bar{z}$ for the non-trivial Galois automorphism of E which fixes F . A matrix $J \in M_{d+1}(E)$ is called Hermitian if $\bar{J}^t = J$. We shall fix a Hermitian matrix $J \in M_{d+1}(E)$, which has signature $(d, 1)$ at one of the complex field embeddings of E , and signature either $(0, d + 1)$ or $(d + 1, 0)$ at all other complex field embeddings of F . Such a choice of J allows us to define a group scheme \mathbb{G} over \mathbb{Z} by

$$\mathbb{G}(A) = \{g \in \mathrm{SL}_{d+1}(\mathcal{O}_E \otimes_{\mathbb{Z}} A) : \bar{g}^t J g = J\}, \quad A \text{ a } \mathbb{Z}\text{-algebra.} \quad (1)$$

We have $\mathbb{G}(\mathbb{R}) = \mathrm{SU}(d, 1) \times \mathrm{SU}(d+1)^{[F:\mathbb{Q}]-1}$. The projection of $\mathbb{G}(\mathbb{Z})$ in $\mathrm{SU}(d, 1)$ is an arithmetic subgroup. More generally, we shall call any subgroup of $\mathrm{SU}(d, 1)$ commensurable with $\mathbb{G}(\mathbb{Z})$ an arithmetic group of the *first kind*. Such groups are cocompact if the Hermitian form defined by J is non-isotropic on E^{d+1} . This is always the case if $F \neq \mathbb{Q}$.

Theorem 1. *Let Γ be a cocompact arithmetic subgroup of $\mathrm{SU}(d, 1)$ of the first kind. Then for every positive integer n there exists a subgroup Γ_n of finite index in Γ which lifts to the connected n -fold cover of $\mathrm{SU}(d, 1)$.*

We recall in section 2 the notion of a fractional weight multiplier system. With this notation, Theorem 1 is equivalent to the following more classical looking statement:

Theorem 2. *Let Γ be a cocompact arithmetic subgroup of $\mathrm{SU}(d, 1)$ of the first kind. For every natural number $n > 0$ there exists a subgroup Γ_n of finite index in Γ and a weight $\frac{1}{n}$ multiplier system on Γ_n .*

In [section 3](#) we give an example of such a sequence of subgroups Γ_n together with the corresponding multiplier systems ([Theorem 5](#) and [Equation 9](#)). Actually, we expect [Theorem 1](#) to hold also in the case that Γ has cusps, and the group Γ in [Theorem 5](#) does indeed have cusps.

There is an equivalent purely group-theoretical restatement of [Theorem 1](#):

Theorem 3. *Let Γ be a cocompact arithmetic subgroup of $SU(d, 1)$ of the first kind and let $\tilde{\Gamma}$ be the preimage of Γ in the universal cover of $SU(d, 1)$. Then $\tilde{\Gamma}$ is residually finite*

There are also arithmetic subgroups of $SU(d, 1)$ of the “second kind” (see [\[2\]](#)), whose construction involves a non-commutative division algebra. It is not known whether arithmetic groups of the second kind have the congruence subgroup property or not. If they do have the congruence subgroup property, then the result of Deligne [\[5\]](#) implies that there are no fractional weight multiplier systems apart from those of half-integral weight. On the other hand, if there does exist a non-congruence subgroup Γ of the second kind, and if $H^1(\Gamma, \mathbb{C}) \neq 0$, then there would be no difficulty in extending [Theorem 1](#) to this case.

The theorems are easily deduced from the following result.

Lemma 1. *Let Γ be a cocompact arithmetic subgroup of $SU(d, 1)$ of the first kind. Let $\sigma \in H^2(\Gamma, \mathbb{C})$ be the image of the invariant Kähler form on the symmetric space for $SU(d, 1)$. Then there exists a congruence subgroup $\Gamma' \subset \Gamma$ and elements $\phi_1, \dots, \phi_r, \psi_1, \dots, \psi_r \in H^1(\Gamma', \mathbb{C})$ such that the following holds in $H^2(\Gamma', \mathbb{C})$:*

$$\sigma = \phi_1 \cup \psi_1 + \dots + \phi_r \cup \psi_r.$$

The theorems are proved in [section 4](#), assuming [Lemma 1](#), which is proved in [section 5](#). In the final section of the paper, we give an alternative and more constructive proof of [Lemma 1](#) in the special case that $H^2(\Gamma, \mathbb{C})$ is 1-dimensional. This proof leads to the following bound on the size of H^1 in this case:

Theorem 4. *Let Γ be a cocompact arithmetic subgroup of $SU(d, 1)$ of the first kind, such that $H^2(\Gamma, \mathbb{C})$ is 1-dimensional. If Γ' is any neat normal subgroup of Γ of finite index with $H^1(\Gamma', \mathbb{C}) \neq 0$, then we must have*

$$\dim H^1(\Gamma', \mathbb{C}) \geq 2d.$$

This bound is proved by analysing the rate of growth of the index $[\Gamma : \Gamma_n]$ for the subgroups constructed in [Theorem 1](#) as n tends to infinity.

Remarks

1. During the preparation of this paper, the author became aware of the work of Stover and Toledo [\[16\]](#), in which several special cases of [Theorem 1](#) are proved. In particular, they treat the case described in detail in [section 3](#).
2. In the case $d = 1$, the group $SU(1, 1)$ is isomorphic to $SL_2(\mathbb{R})$, and the theorems were proved by Petersson [\[14\]](#), [\[15\]](#), as described above. We shall always assume from now on that $d \geq 2$.

3. The results are also known in the case $n = 2$. An explicit multiplier systems of weight $\frac{1}{2}$ on $SU(2, 1)$ has been found by Jalal [12] using the metaplectic splitting.
4. The existence of a weight $\frac{1}{n}$ multiplier system on Γ_n implies the existence of automorphic forms of weight $\frac{k}{n}$ and level Γ_n for all sufficiently large integers k . For example, such forms may be constructed as Eisenstein or Poincaré series. We make no attempt to describe such forms here.

Some holomorphic forms of weight $\frac{1}{2}$ on $SU(d, 1)$ have already been found by Wang and Williams [17] using Borcherds products. In fact they construct forms on $SO(2d, 2)$. However, the restriction of a half-integral weight form from $SO(2d, 2)$ to $SU(d, 1)$ must also have half-integral weight.

5. The subgroups Γ_n constructed in Theorem 1 are non-congruence subgroups for n large enough, and are constructed using homomorphisms $\Gamma' \rightarrow \mathbb{Z}$ for certain congruence subgroups Γ' of Γ .

Based on very limited computational evidence (using the code at [9]), the author does not believe that Theorem 1 would hold for any congruence subgroups Γ_n apart from in the cases where the number field E contains a primitive n -th root of unity.

For arithmetic groups of the second kind in $SU(d, 1)$, one may prove that there is no congruence subgroup Γ_n satisfying the conditions of Theorem 1 for $n > 2$. The proof is essentially the same as Deligne’s proof in [5], but with the congruence subgroup property replaced by the “abelian congruence subgroup property” of P. Boyer [4]. In this context, the abelian congruence subgroup property states that if Γ is a congruence subgroup and $\phi : \Gamma \rightarrow \mathbb{Z}/n$ is a homomorphism then $\ker \phi$ is also a congruence subgroup.

2 Background on $SU(d, 1)$

We shall realise $SU(d, 1)$ as the group of matrices g in $SL_{d+1}(\mathbb{C})$ satisfying $\bar{g}^t J g = J$, where J is the following matrix:

$$J = \begin{pmatrix} 0 & 0 & 1 \\ 0 & I_{n-1} & 0 \\ 1 & 0 & 0 \end{pmatrix}.$$

(Here and later we write I_n for the $n \times n$ identity matrix). The group $SU(d, 1)$ is the group of isometries of the following Hermitian form on \mathbb{C}^{d+1} given by $\langle v, w \rangle = \bar{v}^t J w$. Let

$$\mathcal{H} = \left\{ \tau \in \mathbb{C}^d : \left\langle \begin{pmatrix} \tau \\ 1 \end{pmatrix}, \begin{pmatrix} \tau \\ 1 \end{pmatrix} \right\rangle < 0 \right\}.$$

The set \mathcal{H} is a homogeneous space for the group $SU(d, 1)$. Suppose $g \in SU(d, 1)$ is described as a block matrix $g = \begin{pmatrix} A & B \\ C & D \end{pmatrix}$, where A is a $d \times d$ matrix, D is a complex number, etc. Then the action of $SU(d, 1)$ on \mathcal{H} is given by

$$g * \tau = (C\tau + D)^{-1} \cdot (A\tau + B).$$

We also define

$$j(g, \tau) = C\tau + D. \quad (2)$$

The function $j(g, \tau)$ satisfies the usual condition of a multiplier system:

$$j(gh, \tau) = j(g, h\tau) \cdot j(h, \tau), \quad g, h \in \mathrm{SU}(d, 1). \quad (3)$$

One may use this multiplier system to define modular forms on $\mathrm{SU}(d, 1)$, and such objects have been extensively studied (see for example [10]).

Definition 1. Let Γ be an arithmetic subgroup of G . A function $\ell : \Gamma \times \mathcal{H} \rightarrow \mathbb{C}^\times$ is called a fractional weight multiplier system of weight $\frac{n}{m}$ if it satisfies the following conditions:

1. ℓ is a multiplier system, i.e. $\ell(gh, \tau) = \ell(g, h\tau) \cdot \ell(h, \tau)$ for all $g, h \in \Gamma$ and $\tau \in \mathcal{H}$;
2. there exists a character $\chi : \Gamma \rightarrow \mathbb{C}^\times$ such that

$$\ell(g, \tau)^m = \chi(g) \cdot j(g, \tau)^n$$

for all $g \in \Gamma$ and $\tau \in \mathcal{H}$;

3. For each $g \in \Gamma$ the function $\tau \mapsto \ell(g, \tau)$ is continuous (and hence holomorphic) on \mathcal{H} .

2.1 The universal cover and fractional weight multiplier systems

The Lie group $\mathrm{SU}(d, 1)$ has fundamental group \mathbb{Z} . We shall write $\widetilde{\mathrm{SU}(d, 1)}$ for its universal cover. We therefore have a central extension of groups

$$1 \rightarrow \mathbb{Z} \rightarrow \widetilde{\mathrm{SU}(d, 1)} \rightarrow \mathrm{SU}(d, 1) \rightarrow 1.$$

For the purposes of the calculations in section 3, it will be helpful to have a specific 2-cocycle σ representing this group extension. We describe such a cocycle now.

Define a function $X : \mathrm{SU}(d, 1) \rightarrow \mathbb{C}$ by

$$X(g) = \begin{cases} -g_{d+1,1} & \text{if } g_{d+1,1} \neq 0, \\ g_{d+1,d+1} & \text{if } g_{d+1,1} = 0. \end{cases}$$

Here we are writing $g_{i,j}$ for the complex number in the i -th row and the j -th column of the matrix g .

Lemma 2. Let $g \in \mathrm{SU}(d, 1)$ and $\tau \in \mathcal{H}$ we have $X(g) \neq 0$ and the complex number $\frac{j(g, \tau)}{X(g)}$ has positive real part, where $j(g, \tau)$ is defined in Equation 2.

Proof. Let $(a \ \underline{b} \ c)$ be the bottom row of the matrix g , where a and c are complex numbers and $\underline{b} \in \mathbb{C}^{d-1}$. In order that $g \in \mathrm{SU}(d, 1)$ we must have $a\bar{c} + \|\underline{b}\|^2 + c\bar{a} = 0$, where $\|\underline{b}\|$ denotes the standard (positive definite) norm on \mathbb{C}^{d-1} . If $a = 0$ then we must have $\underline{b} = 0$. In this case $X(g) = j(g, \tau) = c$ for all $\tau \in \mathcal{H}$ so the result is true in this case.

Suppose now that $a \neq 0$. In this case we have $X(g) = -a$, so in particular $X(g) \neq 0$. We may choose a diagonal matrix $t \in \mathrm{SU}(d, 1)$, such that $t_{d+1,d+1} = a^{-1}$. It is trivial to check that

$X(tg) = -1$ and $j(tg, \tau) = a^{-1}j(g, \tau)$. In view of this, it's sufficient to prove the lemma in the case $a = 1$, so that we have $2\Re(c) = -\|\underline{b}\|^2$. We must check in this case that $j(g, \tau)$ has negative real part.

Let $\tau = \begin{pmatrix} \tau_1 \\ \tau_2 \end{pmatrix}$ with $\tau_1 \in \mathbb{C}$ and $\tau_2 \in \mathbb{C}^{d-1}$. Since $\tau \in \mathcal{H}$ we must have $2\Re(\tau_1) + \|\tau_2\|^2 < 0$. We can finish the proof using the Cauchy–Schwarz inequality :

$$\Re(j(g, \tau)) = \Re(\tau_1 + b\tau_2 + c) < -\frac{\|\tau_2\|^2}{2} + \Re(b\tau_2) - \frac{\|\underline{b}\|^2}{2} \leq 0.$$

□

The lemma allows us to define, for each $g \in \text{SU}(d, 1)$ a branch $\tilde{j}(g, -)$ of the logarithm of $j(g, -)$ as follows:

$$\tilde{j}(g, \tau) = \log\left(\frac{j(g, \tau)}{X(g)}\right) + \log(X(g)), \quad (4)$$

where each logarithm in the right hand side is defined to be continuous away from the negative real axis and satisfy $-\pi < \Im(\log z) \leq \pi$. Note that by [Lemma 2](#), for each fixed $g \in \text{SU}(d, 1)$ the function $\tilde{j}(g, \tau)$ is continuous in τ .

Our multiplier system condition ([Equation 3](#)) on $j(g, \tau)$ implies the following formula for \tilde{j} :

$$\tilde{j}(gh, \tau) \equiv \tilde{j}(g, h\tau) + \tilde{j}(h, \tau) \pmod{2\pi i\mathbb{Z}}.$$

In particular, we may define an integer $\sigma(g, h)$ by

$$\sigma(g, h) = \frac{1}{2\pi i} \left(\tilde{j}(gh, \tau) - \tilde{j}(g, h\tau) - \tilde{j}(h, \tau) \right). \quad (5)$$

The right hand side of [Equation 5](#) is independent of τ , since it is a continuous \mathbb{Z} -valued function of τ .

Proposition 1. *The function σ defined in [Equation 5](#) is a measurable 2-cocycle, whose cohomology class in $H_{meas}^2(\text{SU}(d, 1), \mathbb{Z})$ corresponds to the universal cover of $\text{SU}(d, 1)$.*

Proof. It is an easy exercise to verify the 2-cocycle relation, and the function σ is evidently measurable. Hence by Calvin Moore's theory of measurable cohomology [\[13\]](#), there is a central extension of Lie groups corresponding to σ . It remains to show that this extension is the universal cover. For the moment, we'll write $\widetilde{\text{SU}(d, 1)}$ for the extension of $\text{SU}(d, 1)$ corresponding to σ . Explicitely, $\widetilde{\text{SU}(d, 1)}$ is the set $\text{SU}(d, 1) \times \mathbb{Z}$, with the group operation given by

$$(g, n) \cdot (g', n') = (gg', n + n' + \sigma(g, g')).$$

To prove that $\widetilde{\text{SU}(d, 1)}$ is the universal cover of $\text{SU}(d, 1)$, it's sufficient to prove that $\widetilde{\text{SU}(d, 1)}$ is connected. (Note that the topology on $\widetilde{\text{SU}(d, 1)}$ is not the product topology on $\text{SU}(d, 1) \times \mathbb{Z}$).

Let \tilde{T} be the pre-image in $\widetilde{\text{SU}(d, 1)}$ of the following torus in $\text{SU}(d, 1)$:

$$T = \{t_z : z \in \mathbb{C}, |z| = 1\}, \quad t_z = \begin{pmatrix} z & & & \\ & \bar{z}^2 & & \\ & & I_{d-2} & \\ & & & z \end{pmatrix}.$$

Note that on T , we have simply $\tilde{j}(t_z, \tau) = \log(z)$. An elementary calculation shows that there is an isomorphism $\Psi : \tilde{T} \rightarrow \mathbb{R}$ given by

$$\Psi(t_z, n) = \frac{1}{2\pi i} \log(z) - n.$$

Check:

$$\begin{aligned} \Psi((t_z, n)(t_{z'}, n')) &= \Psi((t_{zz'}, n + n' + \sigma(t_z, t_{z'}))) \\ &= \frac{1}{2\pi i} \log(zz') - \left(n + n' + \frac{1}{2\pi i} (\log(zz') - \log(z) - \log(z')) \right) \\ &= \frac{1}{2\pi i} \log(z) - n + \frac{1}{2\pi i} \log(z') - n'. \end{aligned}$$

The map Ψ and its inverse are measurable. Since measurable homomorphisms of Lie groups are continuous, it follows that Ψ is a homeomorphism. In particular \tilde{T} is connected. Hence all elements of the subgroup $\mathbb{Z} \subset \widetilde{\text{SU}(d, 1)}$ are connected by paths in \tilde{T} to the identity element. This implies that $\widetilde{\text{SU}(d, 1)}$ is connected. \square

We'll now describe the cohomological meaning of the fractional weight multiplier systems defined above. Recall that we have a cohomology class $\sigma \in H^2(\text{SU}(d, 1), \mathbb{Z})$. For any integer $n > 0$, we shall write σ_n for the image of σ in $H^2(\text{SU}(d, 1), \mathbb{Q}/n\mathbb{Z})$.

Proposition 2. *There exists a weight $\frac{1}{n}$ multiplier system on Γ if and only if the restriction of σ_n to Γ splits as an element of $H^2(\Gamma, \mathbb{Q}/n\mathbb{Z})$.*

Proof. Suppose σ_n splits on Γ . We have a long exact sequence

$$\rightarrow H^2(\Gamma, n\mathbb{Z}) \rightarrow H^2(\Gamma, \mathbb{Q}) \rightarrow H^2(\Gamma, \mathbb{Q}/n\mathbb{Z}) \rightarrow$$

It follows that σ is in the image of $H^2(\Gamma, n\mathbb{Z})$. Hence there is another cocycle $\sigma' \in Z^2(\Gamma, n\mathbb{Z})$ and a map $\kappa : \Gamma \rightarrow \mathbb{Q}$ such that

$$\sigma(g, h) = \sigma'(g, h) + \kappa(gh) - \kappa(g) - \kappa(h) \quad g, h \in \Gamma.$$

This implies

$$\exp\left(\frac{2\pi i \cdot \sigma(g, h)}{n}\right) = \exp\left(\frac{2\pi i}{n}(\kappa(gh) - \kappa(g) - \kappa(h))\right).$$

Equivalently, the function

$$\ell(g, \tau) = \exp\left(\frac{\tilde{j}(g, \tau) - 2\pi i \cdot \kappa(g)}{n}\right),$$

is a weight $\frac{1}{n}$ multiplier system on Γ , where $\tilde{j}(g, \tau)$ is defined in [Equation 4](#). This argument may be reversed to prove the converse. \square

2.2 Stable cohomology

Let Γ be a cocompact arithmetic subgroup of $SU(d, 1)$ of the first kind. Thus Γ is commensurable with some $\mathbb{G}(\mathbb{Z})$ with \mathbb{G} as defined in Equation 1.

We shall define the *stable cohomology* $H_{\text{stable}}^\bullet(\mathbb{C})$ by

$$H_{\text{stable}}^\bullet(\mathbb{C}) = \lim_{\rightarrow} H^\bullet(\Gamma', \mathbb{C}),$$

where the limit is taken over all congruence subgroups Γ' of Γ . The restriction maps $H^\bullet(\Gamma', \mathbb{C}) \rightarrow H^\bullet(\Gamma'', \mathbb{C})$ are all injective, so the direct limit may be thought of as a union. We have a cocycle $\sigma \in H^2(SU(d, 1), \mathbb{Z})$. We shall often abuse notation and write σ for the image of this cocycle in $H^2(\Gamma, \mathbb{Z})$, $H^2(\Gamma, \mathbb{Q})$, $H^2(\Gamma, \mathbb{C})$ or $H_{\text{stable}}^2(\mathbb{C})$. The meaning should be clear from the context.

Recall that the restriction maps $H^\bullet(\Gamma, \mathbb{C}) \rightarrow H^\bullet(\Gamma', \mathbb{C})$ are compatible with cup product. This implies that we have a cup product operation on the stable cohomology, which coincides with the usual cup product on each $H^\bullet(\Gamma, \mathbb{C})$.

We recall now some standard facts about stable cohomology, which may be found (in the current context) in [2] and more generally in [3]. There is an action of $\mathbb{G}(\mathbb{Q})$ on the stable cohomology, which extends to a smooth action of the totally disconnected group $\mathbb{G}(\mathbb{A}_f)$, where \mathbb{A}_f denotes the ring of finite adèles of \mathbb{Q} . By the Strong Approximation Theorem, there is a bijective correspondence between the congruence subgroups $\Gamma(K_f)$ of $\mathbb{G}(\mathbb{Q})$ and the compact open subgroups K_f of $\mathbb{G}(\mathbb{A}_f)$, where K_f is the closure of $\Gamma(K_f)$ in $\widehat{\mathbb{G}(\mathbb{A}_f)}$, or equivalently $\Gamma(K_f)$ is the intersection of K_f with $\mathbb{G}(\mathbb{Q})$. We may recover the cohomology of any congruence subgroup from the stable cohomology by

$$H^\bullet(\Gamma(K_f), \mathbb{C}) = (H_{\text{stable}}^\bullet(\mathbb{C}))^{K_f}.$$

The smooth representation $H_{\text{stable}}^\bullet(\mathbb{C})$ of $\mathbb{G}(\mathbb{A}_f)$ is semi-simple, and has a decomposition into irreducibles of the following form:

$$H_{\text{stable}}^\bullet(\mathbb{C}) = \bigoplus_{\pi} H^\bullet(\mathfrak{g}, K, \pi_\infty) \otimes \pi_f, \quad (6)$$

where π runs through certain automorphic representations of $\mathbb{G}(\mathbb{A})$ which arise in $L^2(\mathbb{G}(\mathbb{Q}) \backslash \mathbb{G}(\mathbb{A}))$. In the relative Lie algebra cohomology on the right hand side of Equation 6 we have $\mathfrak{g} = \mathfrak{su}(d, 1)$ and K is a maximal compact subgroup of $SU(d, 1)$. In this notation, we have $\pi = \pi_\infty \otimes \pi_f$, where π_∞ is an irreducible representation of $SU(d, 1)$ and π_f is an irreducible representation of $\mathbb{G}(\mathbb{A}_f)$.

One of the automorphic representations arising in the decomposition (Equation 6) is the one dimensional subspace $\pi = \mathbb{C}$ of constant functions. For this trivial representation we have $\pi_\infty = \mathbb{C}$ and $\pi_f = \mathbb{C}$. Thus the stable cohomology contains $H^\bullet(\mathfrak{g}, K, \mathbb{C})$ as a direct summand with the trivial action of $\mathbb{G}(\mathbb{A}_f)$. For any non-trivial automorphic representation π occurring in the decomposition, π_f is an infinite dimensional irreducible representation of $\mathbb{G}(\mathbb{A}_f)$. From this, it follows that

$$(H_{\text{stable}}^\bullet(\mathbb{C}))^{\mathbb{G}(\mathbb{A}_f)} = H^\bullet(\mathfrak{g}, K, \mathbb{C}).$$

The cohomology groups $H_{\text{cts}}^\bullet(\mathfrak{g}, K, \mathbb{C})$ are canonically isomorphic to the cohomology of the compact dual of the symmetric space \mathcal{H} . This compact dual is the complex projective space

$\mathbb{P}^d(\mathbb{C})$ and has the following cohomology groups

$$H_{\text{cts}}^r(\mathfrak{g}, K, \mathbb{C}) = H^r(\mathbb{P}^d(\mathbb{C}), \mathbb{C}) = \begin{cases} \mathbb{C} & r = 0, 2, 4, \dots, 2d, \\ 0 & \text{otherwise.} \end{cases}$$

A generator of $H_{\text{cts}}^2(\mathfrak{g}, K, \mathbb{C})$ is called an invariant Kähler class; such a generator is the de Rham cohomology class of the 2-form given by the imaginary part of the invariant Hermitian metric on \mathcal{H} . In fact, such a class is only determined up to constant multiple. The other non-zero cohomology groups $H^{2r}(\mathfrak{g}, K, \mathbb{C})$ for $r = 2, \dots, d$ are generated by the cup-powers of the Kähler class.

The natural map $H_{\text{cts}}^\bullet(\mathfrak{g}, K, \mathbb{C}) \cong H_{\text{cts}}^\bullet(\text{SU}(d, 1), \mathbb{C}) \rightarrow H_{\text{meas}}^\bullet(\text{SU}(d, 1), \mathbb{C})$ is an isomorphism. We have described in [Equation 5](#) a cocycle σ , whose cohomology class generates $H_{\text{meas}}^2(\text{SU}(d, 1), \mathbb{Z})$. Hence the image of σ in $H^2(\mathfrak{g}, K, \mathbb{C})$ is an invariant Kähler class. In summary, we have

$$(H_{\text{stable}}^r(\mathbb{C}))^{\mathbb{G}(\mathbb{A}_f)} = \begin{cases} \text{Span}\{\sigma^s\} & \text{if } r = 2s \text{ with } s = 0, \dots, d, \\ 0 & \text{otherwise.} \end{cases}$$

3 Example : $\text{SU}(2, 1)$ over the Eisenstein integers

This section concerns computer calculations. The code for these calculations runs on sage version 9.0, and is available at [\[9\]](#).

Let $\zeta = e^{2\pi i/3}$. In this section we shall consider arithmetic subgroups of the following group:

$$\Gamma = \{g \in \text{SL}_3(\mathbb{Z}[\zeta]) : \bar{g}^t J g = J\}, \quad J = \begin{pmatrix} 0 & 0 & 1 \\ 0 & 1 & 0 \\ 1 & 0 & 0 \end{pmatrix}.$$

The group Γ is an arithmetic subgroup of $\text{SU}(2, 1)$ of the first kind. The Hermitian form on $\mathbb{Q}(\zeta)^3$ defined by the matrix J is isotropic, so Γ has cusps.

Let $\Gamma(\sqrt{-3})$ denote the principal congruence subgroup in Γ of level $\sqrt{-3}$. The group $\Gamma(\sqrt{-3})$ decomposes as a direct sum:

$$\Gamma(\sqrt{-3}) = \Upsilon \oplus \mu_3,$$

where μ_3 is the centre of $\text{SU}(2, 1)$ generated by ζI_3 , and Υ is a subgroup of index 3 defined as follows:

$$\Upsilon = \{(g_{i,j}) \in \Gamma(\sqrt{-3}) : g_{1,1} \equiv 1 \pmod{3}\}.$$

It will be useful to have the following notation for upper-triangular elements of Υ :

$$n(z, x) = \begin{pmatrix} 1 & \sqrt{-3} \cdot z & \frac{-3\text{N}(z) + x\sqrt{-3}}{2} \\ 0 & 1 & \sqrt{-3} \cdot \bar{z} \\ 0 & 0 & 1 \end{pmatrix}, \quad z \in \mathbb{Z}[\zeta], \quad x \in \mathbb{Z}, \quad x \equiv \text{N}(z) \pmod{2}.$$

Here and later we write N and Tr for the norm and trace maps from $\mathbb{Q}(\zeta)$ to \mathbb{Q} .

Lemma 3. *The group Υ is generated by the following elements:*

$$n(z, x), \quad n(z, x)^t, \quad \text{where } z \in \mathbb{Z}[\zeta] \text{ and } x \in \mathbb{Z} \text{ satisfy } x \equiv N(z) \pmod{2}.$$

Proof. The proof mimics the use of the Euclidean algorithm to find generators of $\mathrm{SL}_2(\mathbb{Z})$; it will be given in a forthcoming paper. \square

For the calculations described below, it is convenient to have a fairly small finite presentation of Υ . To obtain such a presentation, one begins with the presentation of [7] for the group $\mathrm{PU}(2, 1)(\mathbb{Z}[\zeta])$, and then applies the Reidemeister–Schreier algorithm to the subgroup Υ . The resulting presentation of Υ is rather large (52 generators and 223 relations), and Lemma 3 shows that we only need a small number of generators. After rewriting the large presentation in terms of the small set of generators, and simplifying the resulting presentation using GAP, we obtain a presentation for Υ with the following five generators

$$n_1 = n(1, 1), \quad n_2 = n(\zeta, 1), \quad n_3 = n(0, 2), \quad n_4 = n_1^t, \quad n_5 = n_3^t.$$

and with the following thirteen relations.

$$\begin{aligned} & [n_1, n_3], \quad [n_2, n_3], \quad [n_4, n_5], \quad (n_3 n_5)^3, \\ & n_3 n_2 n_1 n_2^{-1} n_3 n_1^{-1} n_3, \quad (n_1^{-1} n_3 n_4^{-1})^3, \\ & n_5^{-1} n_2 n_5 n_4^{-1} n_1^{-1} n_2^{-1} n_3 n_4 n_3^{-1} n_1, \\ & n_4^{-1} n_1^{-1} n_3 n_5 n_2 n_1 n_5^{-1} n_4 n_2^{-1} n_3^{-1}, \\ & n_5^{-1} n_4 n_1 n_5 n_3^{-1} n_1^{-1} n_2^{-1} n_4^{-1} n_3^{-1} n_3^{-1} n_2, \\ & n_5^{-1} n_2 n_1 n_5^{-1} n_4 n_1 n_4 n_1 n_5^{-1} n_4 n_2^{-1}, \\ & n_3 n_5 n_1 n_4 n_5^{-1} n_2^{-1} n_4 n_3^{-1} n_1 n_4 n_2 n_1, \\ & n_3^{-1} n_1 n_4 n_2 n_3 n_1 n_5^{-1} n_1^{-1} n_4^{-1} n_5 n_1^{-1} n_2^{-1}, \\ & n_4^{-1} n_3^{-1} n_5 n_3 n_1^{-1} n_4^{-1} n_2 n_1 n_3^{-1} n_4 n_1 n_5^{-1} n_4 n_2^{-1} n_1^{-1} n_3. \end{aligned}$$

Using this presentation, we can easily calculate the abelianization $\Upsilon^{\mathrm{ab}} = \Upsilon/[\Upsilon, \Upsilon]$ of Υ . Each relation gives us a row vector in \mathbb{Z}^5 , whose entry in column r is the multiplicity of the generator n_r in the relation. These row vectors form an 13×5 matrix. If we row reduce the matrix over \mathbb{Z} , then we obtain the following matrix:

$$\begin{pmatrix} 3 & 0 & 0 & 3 & 0 \\ 0 & 0 & 3 & 0 & 0 \\ 0 & 0 & 0 & 0 & 3 \end{pmatrix}$$

This gives us the following relations in the abelianization:

$$(n_1 n_4)^3 = 1, \quad n_3^3 = 1, \quad n_5^3 = 1.$$

In particular Υ^{ab} is isomorphic to $\mathbb{Z}^2 \oplus (\mathbb{Z}/3)^3$.

Lemma 4. *There exists a surjective homomorphism $\phi : \Upsilon \rightarrow \mathbb{Z}[\zeta]$, defined on the generators of Lemma 3 by*

$$\phi(n(z, x)) = z, \quad \phi(n(z, x)^t) = -\bar{z}.$$

The vector space $H^1(\Upsilon, \mathbb{C})$ is 2-dimensional, and has $\{\phi, \bar{\phi}\}$ as a basis.

Proof. One sees from our presentation of the abelianization, that there is a homomorphism ϕ defined on generators by

$$\phi(n_1) = 1, \quad \phi(n_2) = \zeta, \quad \phi(n_3) = 0, \quad \phi(n_4) = -1, \quad \phi(n_5) = 0,$$

From this, it is trivial to check that $\phi(n(z, x)) = z$. To verify our formula for $\phi(n(z, x)^t)$, we need only check that $\phi(n(\zeta, 1)^t) = -\bar{\zeta}$. We have $n(\zeta, 1)^t = n_3^{-1}n_1n_4n_1n_3^{-2}n_2$, and therefore

$$\phi(n(\zeta, 1)) = 1 + \zeta = -\bar{\zeta}.$$

Our calculation of Υ^{ab} implies that $H^1(\Upsilon, \mathbb{C})$ is 2-dimensional. Clearly ϕ and $\bar{\phi}$ are linearly independent, so they form a basis for $H^1(\Upsilon, \mathbb{C})$. \square

The lemma allows us to define a tower of subgroups $\Upsilon_{\text{n.c.}}(I)$ indexed by non-zero ideals $I \subset \mathbb{Z}[\zeta]$ as follows:

$$\Upsilon_{\text{n.c.}}(I) = \phi^{-1}(I).$$

Theorem 5. *For each non-zero ideal $I \subset \mathbb{Z}[\zeta]$ there exists a multiplier system on $\Upsilon_{\text{n.c.}}(2 \cdot I)$ of weight $\frac{1}{N(I)}$.*

We give a formula for the multiplier system on in [Equation 9](#) below.

To prove the theorem, we first replace σ by a more convenient 2-cocycle on Υ . This is achieved by the following lemma.

Lemma 5. *Define a function $\Sigma : \Upsilon \times \Upsilon \rightarrow \frac{1}{4}\mathbb{Z}$ by*

$$\Sigma(g, h) = \frac{1}{4} \text{Tr} \left(\frac{\phi(g)\bar{\phi}(h)}{\sqrt{-3}} \right).$$

The function Σ is an inhomogeneous 2-cocycle on Υ with values in $\frac{1}{4}\mathbb{Z}$. Furthermore, the equation $\Sigma = \sigma$ holds in $H^2(\Upsilon, \frac{1}{12}\mathbb{Z})$, where σ is the cocycle defined in [Equation 5](#).

Proof. The 2-cocycle relation for Σ follows immediately from the fact that ϕ and $\bar{\phi}$ are homomorphisms. To show that $\sigma = \Sigma$, we form the central extension corresponding to the cocycle $\sigma - \Sigma$, regarded as having values in $\frac{1}{12}\mathbb{Z}$:

$$1 \rightarrow \frac{1}{12}\mathbb{Z} \rightarrow \tilde{\Upsilon} \rightarrow \Upsilon \rightarrow 1. \quad (7)$$

We must prove that this extension splits.

We shall realize the group $\tilde{\Upsilon}$ as the set $\Upsilon \times \frac{1}{12}\mathbb{Z}$, with the group operation defined by

$$(g, x)(g', x') = (gg', x + x' + (\sigma - \Sigma)(g, g')).$$

Our first aim is to find a presentation for $\tilde{\Upsilon}$. For each of our generators n_i above, we define a lift $\hat{n}_i = (n_i, 0)$. The group $\tilde{\Upsilon}$ is generated by the lifts \hat{n}_i together with one other element $z = (I_3, \frac{1}{12})$.

For each of the thirteen relations $g_1^{a_1} \cdots g_t^{a_t} = I_3$ in Υ , the corresponding element $\hat{g}_1^{a_1} \cdots \hat{g}_t^{a_t} \in \tilde{\Upsilon}$ is in the central subgroup $\frac{1}{12}\mathbb{Z}$, and may be calculated easily using a computer. This gives us a corresponding relation in $\tilde{\Upsilon}$ of the form

$$\hat{g}_1^{a_1} \cdots \hat{g}_t^{a_t} = z^c.$$

Of course, z is in the centre of $\tilde{\Upsilon}$, so we have an additional relation $[z, \hat{n}_i] = (I_3, 0)$ for each generator n_i . This gives us a presentation of $\tilde{\Upsilon}$ with six generators and eighteen relations. Just as before, we may use our presentation to calculate the abelianization $\tilde{\Upsilon}^{\text{ab}}$. The result is that $\tilde{\Upsilon}^{\text{ab}}$ is generated by $\hat{n}_1, \hat{n}_2, \hat{n}_3, \hat{n}_4, \hat{n}_5, z$ and has relations:

$$\hat{n}_1^3 \hat{n}_4^3 = z^6, \quad \hat{n}_3^3 = z^6, \quad \hat{n}_5^3 = z^{-30}.$$

In particular, there is a homomorphism $\Phi : \tilde{\Upsilon} \rightarrow \tilde{\Upsilon}^{\text{ab}} \rightarrow \frac{1}{12}\mathbb{Z}$, defined by

$$\Phi(\hat{n}_1) = \Phi(\hat{n}_4) = \Phi(z) = \frac{1}{12}, \quad \Phi(\hat{n}_2) = 0, \quad \Phi(\hat{n}_3) = \frac{2}{12}, \quad \Phi(\hat{n}_5) = \frac{-10}{12}.$$

The homomorphism Φ splits the extension in [Equation 7](#). □

Proof of [Theorem 5](#). Let I be a non-zero ideal of $\mathbb{Z}[\zeta]$. By [Proposition 2](#), we must show that the image of σ in $H^2(\Upsilon_{\text{n.c.}}(2 \cdot I), \mathbb{Q}/(\mathbb{N}(I) \cdot \mathbb{Z}))$ is a coboundary. In view of [Lemma 5](#), it is sufficient to prove this for the cocycle Σ . Let $g, h \in \Upsilon_{\text{n.c.}}(2 \cdot I)$. This means that $\phi(g)$ and $\phi(h)$ are in $2 \cdot I$. Therefore $\phi(g)\bar{\phi}(h)$ is a multiple of $4\mathbb{N}(I)$. Using this, one easily checks that $\Sigma(g, h)$ is an integer, and is a multiple of $\mathbb{N}(I)$. Therefore $\Sigma(g, h)$ is zero in $\mathbb{Q}/(\mathbb{N}(I) \cdot \mathbb{Z})$. □

The Multiplier System. We now describe the multiplier systems predicted in [Theorem 5](#). By [Lemma 5](#), there is a function $\kappa : \Upsilon \rightarrow \frac{1}{12}\mathbb{Z}$ such that

$$\sigma(g, h) = \Sigma(g, h) + \kappa(gh) - \kappa(g) - \kappa(h), \quad g, h \in \Upsilon. \quad (8)$$

Of course, κ is only defined up to addition of an element of $H^1(\Upsilon, \frac{1}{12}\mathbb{Z})$. This gives us the freedom to insist (for example) that κ is zero on the upper triangular generators n_1, n_2 . Once such a restriction is made, one can calculate the function κ using [Equation 8](#).

Choose any $g, h \in \Upsilon_{\text{n.c.}}(2I)$. The number $\Sigma(g, h)$ is an integer and is a multiple of $\mathbb{N}(I)$. This implies

$$\exp\left(2\pi i \frac{\sigma(g, h)}{\mathbb{N}(I)}\right) = \exp\left(2\pi i \frac{\kappa(gh) - \kappa(g) - \kappa(h)}{\mathbb{N}(I)}\right).$$

Substituting the definition of σ ([Equation 5](#)) we have for any τ in the symmetric space \mathcal{H} :

$$\exp\left(\frac{\tilde{j}(gh, \tau) - \tilde{j}(g, h\tau) - \tilde{j}(h, \tau)}{\mathbb{N}(I)}\right) = \exp\left(2\pi i \frac{\kappa(gh) - \kappa(g) - \kappa(h)}{\mathbb{N}(I)}\right).$$

Here $\tilde{j}(g, \tau)$ is the logarithm branch of the multiplier system $j(g, \tau)$ defined in [Equation 4](#). It follows that the function $\ell(g, \tau)$ is a multiplier system on $\Upsilon_{\text{n.c.}}(2 \cdot \mathbb{N}(I))$ of weight $\frac{1}{\mathbb{N}(I)}$, where $\ell(g, \tau)$ is defined by

$$\ell(g, \tau) = \exp\left(\frac{\tilde{j}(g, \tau) - 2\pi i \cdot \kappa(g)}{\mathbb{N}(I)}\right). \quad (9)$$

Note that we have $\ell(g, \tau)^{12 \cdot \mathbb{N}(I)} = j(g, \tau)^{12}$.

Remark. *By working a little harder, one can improve on [Theorem 5](#), and show that $\Upsilon_{\text{n.c.}}(I)$ has a multiplier system of weight $\frac{1}{\mathbb{N}(I)}$ if $\mathbb{N}(I)$ is odd, and $\frac{2}{\mathbb{N}(I)}$ if $\mathbb{N}(I)$ is even.*

4 Proof of Theorem 1

In this section, we shall assume [Lemma 1](#), and deduce [Theorem 1](#). As before, we let Γ be an arithmetic subgroup of $\mathrm{SU}(d, 1)$ of the first kind. Let $\sigma \in H^2(\Gamma, \mathbb{Z})$ be the cocycle described in [section 2](#). We shall prove that for every positive integer n there is a subgroup Γ_n of finite index in Γ , such that the image of the cocycle σ in $H^2(\Gamma_n, \mathbb{Z}/n)$ is a coboundary.

Proof of Theorem 1. According to [Lemma 1](#) there exists a congruence subgroup Γ' and elements $\phi_i, \psi_i \in H^1(\Gamma', \mathbb{C})$ such that

$$\sigma = \sum_{i=1}^r \phi_i \cup \psi_i, \quad \text{in } H^2(\Gamma', \mathbb{C}). \quad (10)$$

Since $\sigma \in H^2(\Gamma', \mathbb{Q})$, we may choose the elements ϕ_i, ψ_i to be in $H^1(\Gamma', \mathbb{Q})$. We shall think of ϕ_i, ψ_i as homomorphisms $\Gamma' \rightarrow \mathbb{Q}$. The images of these homomorphisms are finitely generated, since arithmetic groups are finitely generated. We may therefore define a subgroup Γ'' of finite index in Γ' by

$$\Gamma'' = \bigcap_i (\phi_i^{-1}(\mathbb{Z}) \cap \psi_i^{-1}(\mathbb{Z})).$$

From now on we shall regard ϕ_i, ψ_i as elements of $H^1(\Gamma'', \mathbb{Z})$. Note that [Equation 10](#) remains true in $H^2(\Gamma'', \mathbb{Q})$ but not necessarily in $H^2(\Gamma'', \mathbb{Z})$. We have a long exact sequence

$$\rightarrow H^1(\Gamma'', \mathbb{Q}/\mathbb{Z}) \xrightarrow{\partial} H^2(\Gamma'', \mathbb{Z}) \rightarrow H^2(\Gamma'', \mathbb{Q}) \rightarrow .$$

From [Equation 10](#), we have in $H^2(\Gamma'', \mathbb{Z})$:

$$\sigma = \sum_{i=1}^r (\phi_i \cup \psi_i) + \partial\gamma, \quad \text{for some } \gamma \in H^1(\Gamma'', \mathbb{Q}/\mathbb{Z}).$$

The subgroup $\Gamma_1 = \ker(\gamma : \Gamma'' \rightarrow \mathbb{Q}/\mathbb{Z})$ has finite index in Γ'' , and in $H^2(\Gamma_1, \mathbb{Z})$ we have

$$\sigma = \sum_{i=1}^r \phi_i \cup \psi_i. \quad (11)$$

Our tower of subgroups Γ_n is defined by

$$\Gamma_n = \{g \in \Gamma_1 : \phi_i(g) \equiv 0 \pmod{n} \text{ for } i = 1, \dots, r\} \quad (12)$$

The image of each ϕ_i in $H^1(\Gamma_n, \mathbb{Z}/n)$ is zero. Hence by [Equation 11](#) the image of σ in $H^2(\Gamma_n, \mathbb{Z}/n)$ is zero. \square

Before moving on, we investigate the index of the tower of subgroups Γ_n . It is clear from the definition [Equation 12](#) that we have $[\Gamma_1 : \Gamma_n] \leq n^r$, and this implies

$$[\Gamma : \Gamma_n] \ll n^r. \quad (13)$$

On the other hand we have $\sigma = n \cdot \tau$ for the element $\tau \in H^2(\Gamma_n, \mathbb{Z})$ given by $\tau = \sum (\frac{1}{n}\phi_i) \cup \psi_i$. Hence σ^d is a multiple of n^d in $H^{2d}(\Gamma_n, \mathbb{Z})$.

By Poincaré duality, we have a commutative diagram

$$\begin{array}{ccccc}
H^{2d}(\Gamma, \mathbb{Z}) & \cong & H_0(\Gamma, \mathbb{Z}) & \cong & \mathbb{Z} \\
\text{restriction } \downarrow & & \downarrow & & \downarrow \times [\Gamma : \Gamma_n] \\
H^{2d}(\Gamma_n, \mathbb{Z}) & \cong & H_0(\Gamma_n, \mathbb{Z}) & \cong & \mathbb{Z}
\end{array}$$

Since the restriction of σ^d to Γ_n is a multiple of n^d , we must have (as $n \rightarrow \infty$)

$$n^d \ll [\Gamma : \Gamma_n]. \quad (14)$$

Comparing the two bounds in [Equation 13](#) and [Equation 14](#), we deduce the following:

Corollary 1. *Let Γ be a cocompact arithmetic subgroup of $\mathrm{SU}(d, 1)$ of the first kind, and let $\sigma \in H^2(\Gamma, \mathbb{Q})$ be the cohomology class of the invariant Kähler form. If $\sigma = \sum_{i=1}^r \phi_i \cup \psi_i$ with $\phi_i, \psi_i \in H^1(\Gamma, \mathbb{Q})$. Then $r \geq d$.*

5 Proof of [Lemma 1](#)

Let Γ be a cocompact arithmetic subgroup of $\mathrm{SU}(d, 1)$ of the first kind. Let $\sigma \in H_{\mathrm{stable}}^2(\mathbb{C})$ denote the invariant Kähler class. Our aim is to prove that σ is in the subspace V of H_{stable}^2 spanned by cup products of $H_{\mathrm{stable}}^1(\mathbb{C}) \otimes H_{\mathrm{stable}}^1(\mathbb{C})$.

It is proved in [\[3\]](#) that $H^1(\Gamma', \mathbb{C}) \neq 0$ for some congruence subgroup Γ' of Γ . We shall choose such a subgroup Γ' now. Furthermore, by reducing the size of Γ' if necessary we may assume that Γ' is neat. The neatness condition implies that the quotient space $X = \Gamma' \backslash \mathcal{H}$ is a smooth compact d -dimensional projective complex variety. The cohomology of Γ' is isomorphic to that of X . We may therefore make use of Poincaré duality and the Hard Lefschetz Theorem (see for example [\[8\]](#)). In particular,

1. $H^{2d}(\Gamma', \mathbb{C})$ is a 1-dimensional vector space spanned by σ^d .
2. The cup product induces a perfect pairing $H^1(\Gamma', \mathbb{C}) \otimes H^{2d-1}(\Gamma', \mathbb{C}) \rightarrow H^{2d}(\Gamma', \mathbb{C})$.
3. Cup product with σ^{d-1} induces an isomorphism $H^1(\Gamma', \mathbb{C}) \rightarrow H^{2d-1}(\Gamma', \mathbb{C})$.

Choose a non-zero element $\phi \in H^1(\Gamma', \mathbb{C})$. By Poincaré duality, there exists $\phi^* \in H^{2d-1}(\Gamma', \mathbb{C})$, such that $\phi \cup \phi^* = \sigma^d$. By the Hard Lefschetz Theorem, $\phi^* = \psi \cup \sigma^{d-1}$ for some $\psi \in H^1(\Gamma', \mathbb{C})$. Thus the map

$$\Phi : V \rightarrow H_{\mathrm{stable}}^{2d}(\mathbb{C}), \quad \Sigma \mapsto \Sigma \cup \sigma^{d-1}$$

is surjective.

The element σ is $\mathbb{G}(\mathbb{A}_f)$ -invariant, so Φ is a morphism of $G(\mathbb{A}_f)$ -modules. The representation V of $G(\mathbb{A}_f)$ is contained in $H_{\mathrm{stable}}^2(\mathbb{C})$ and is therefore semi-simple. Therefore there exists a trivial 1-dimensional subrepresentation in V . This shows that $V^{G(\mathbb{A}_f)} \neq 0$. On the other hand, $(H_{\mathrm{stable}}^2(\mathbb{C}))^{G(\mathbb{A}_f)}$ is spanned by σ , so we must have $\sigma \in V$.

6 Explicit construction in the case $h^2 = 1$.

In this section, we prove [Theorem 6](#), which is a more precise version of [Lemma 1](#) in a special case. Our method leads to a bound on the cohomology of certain arithmetic groups ([Theorem 7](#)). We shall work throughout this section with rational cohomology groups $H^\bullet(\Gamma, \mathbb{Q})$ rather than complex cohomology groups. The reason for this change is because we will need to use [Corollary 1](#) in order to prove [Theorem 7](#).

As before we assume that Γ is a cocompact arithmetic subgroup of $\mathrm{SU}(d, 1)$ of the first kind, but now we make the additional assumption that $H^2(\Gamma, \mathbb{C})$ is 1-dimensional. Since the cocycle σ is a non-zero element of $H^2(\Gamma, \mathbb{Q})$, we have.

$$H^2(\Gamma, \mathbb{Q}) = \mathrm{Span}\{\sigma\}.$$

By results in [\[3\]](#) we may choose a normal subgroup $\Gamma' \trianglelefteq \Gamma$ of finite index, such that

1. Γ' is neat,
2. $H^1(\Gamma', \mathbb{Q}) \neq 0$.

We shall express σ as a specific sum of cup products of elements in $H^1(\Gamma', \mathbb{Q})$. As a consequence, we prove in [Theorem 7](#) the bound $\dim H^1(\Gamma', \mathbb{C}) \geq 2d$.

Let \mathcal{H} be the symmetric space corresponding to $\mathrm{SU}(d, 1)$. The quotient $X = \Gamma' \backslash \mathcal{H}$ is a compact complex manifold of dimension d over the complex numbers, and the cohomology of Γ' is canonically isomorphic to that of X .

Let r be the dimension of $H^1(\Gamma', \mathbb{Q})$ and choose a basis $\{\phi_1, \dots, \phi_r\}$ for $H^1(\Gamma', \mathbb{Q})$. By Poincaré duality, we may choose a dual basis $\phi_1^*, \dots, \phi_r^*$ of $H^{2d-1}(\Gamma', \mathbb{Q})$, i.e.

$$\phi_i \cup \phi_j^* = \delta_{ij} \cdot \sigma^d. \quad (15)$$

By the Hard Lefschetz Theorem, the cup product with σ^{d-1} gives an isomorphism $H^1(\Gamma', \mathbb{Q}) \rightarrow H^{2d}(\Gamma', \mathbb{Q})$. We may therefore define $\psi_1, \dots, \psi_r \in H^1(\Gamma', \mathbb{Q})$ by

$$\psi_i \cup \sigma^{d-1} = \phi_i^*.$$

Finally, we define an element $\Sigma \in H^2(\Gamma', \mathbb{Q})$ by

$$\Sigma = \frac{1}{r} \sum_{i=1}^r (\phi_i \cup \psi_i). \quad (16)$$

Note that we obviously have $\Sigma \cup \sigma^{d-1} = \sigma^d$, so Σ is certainly non-zero.

Theorem 6. *Let Γ be a cocompact subgroup of $\mathrm{SU}(d, 1)$ of the first kind, such that $H^2(\Gamma, \mathbb{Q})$ is 1-dimensional. Let Γ' be a neat normal subgroup satisfying $H^1(\Gamma', \mathbb{Q}) \neq 0$, and let $\Sigma \in H^2(\Gamma', \mathbb{Q})$ be as defined in [Equation 16](#). Then we have $\Sigma = \sigma$ in $H^2(\Gamma', \mathbb{Q})$.*

We prove the theorem in two lemmata.

Lemma 6. *The element $\Sigma \in H^2(X, \mathbb{Q})$ does not depend on the choice of basis $\{\phi_1, \dots, \phi_r\}$ of $H^1(X, \mathbb{Q})$.*

Proof. For any finite dimensional vector space V , we may identify $\text{Hom}(V, V)$ with $V \otimes V^*$. Under this identification, the identity element of $\text{Hom}(V, V)$ becomes $\sum \phi_i \otimes \phi_i^*$ for any basis ϕ_i . Hence this sum is independent of the basis. The element Σ is the image of such a sum under the following composition of maps:

$$H^1 \otimes (H^1)^* \xrightarrow{\text{Poincaré duality}} H^1 \otimes H^{2d-1} \xrightarrow{\text{Hard Lefschetz}} H^1 \otimes H^1 \xrightarrow{\text{cup product}} H^2.$$

□

We are assuming in this section that Γ' is normal in Γ . The finite group Γ/Γ' acts on the cohomology of Γ' . This is a tiny version of the action of $\mathbb{G}(\mathbb{A}_f)$ on the stable cohomology. The action is compatible with cup products, i.e. $g\phi \cup g\psi = g(\phi \cap \psi)$. Furthermore $g\sigma = \sigma$ for all $g \in \Gamma/\Gamma'$. The next lemma shows that the same is true of Σ .

Lemma 7. *For all $g \in \Gamma/\Gamma'$ we have $g(\Sigma) = \Sigma$.*

Proof. Let $v_i = g\phi_i$ for $i = 1, \dots, r$. Clearly $\{v_i\}$ is another basis of $H^1(\Gamma', \mathbb{Q})$, and we shall write $\{v_i^*\}$ for the dual basis in $H^{2d-1}(\Gamma', \mathbb{Q})$. Applying g to both sides of Equation 15, we get (since $g\sigma = \sigma$):

$$v_i \cup g\phi_j^* = \delta_{i,j} \cdot \sigma^d.$$

Hence $v_i^* = g\phi_i^*$ for $i = 1, \dots, r$. By the hard Lefschetz theorem, there are unique elements $w_i \in H^1(\Gamma', \mathbb{Q})$, such that $w_i \cup \sigma^{d-1} = v_i^*$. Since $g\sigma = \sigma$, we must have $w_i = g\psi_i$. Putting all of this together, we find

$$g\Sigma = \frac{1}{r} \sum (g\phi_i) \cup (g\psi_i) = \frac{1}{r} \sum v_i \cup w_i.$$

Lemma 6 implies that the right hand side is equal to Σ . □

Proof of Theorem 6. Recall that $H^2(\Gamma, \mathbb{Q})$ is generated by σ . The previous lemma shows that $\Sigma \in H^2(\Gamma, \mathbb{Q})^{\Gamma/\Gamma'}$. By the Hochschild–Serre spectral sequence, it follows that Σ is the restriction of an element of $H^2(\Gamma, \mathbb{Q})$. Therefore $\Sigma = c \cdot \sigma$ for some rational number c . The equation $\Sigma \cup \sigma^{d-1} = \sigma^d$ implies $c = 1$. □

Theorem 7. *Let Γ be a cocompact subgroup of $\text{SU}(d, 1)$ of the first kind, such that $H^{1,1}(\Gamma, \mathbb{C})$ is 1-dimensional. Let Γ' be a neat normal subgroup satisfying $H^1(\Gamma', \mathbb{C}) \neq 0$, Then*

$$\dim H^1(\Gamma', \mathbb{C}) \geq 2d.$$

Proof. Recall that according to Corollary 1, we cannot express σ as a sum of fewer than d cup products. It is tempting to apply this fact directly to the formula in Theorem 6. However, this gives only the bound $\dim H^1(\Gamma', \mathbb{C}) \geq d$, since the number of terms in the sum Σ is $\dim H^1(\Gamma, \mathbb{C})$. To obtain the stronger bound of the theorem, we shall simplify our formula for Σ a little further and remove half of the terms.

By Poincaré duality and the hard Lefschetz theorem, we have a non-degenerate alternating form

$$\bigwedge^2 H^1(\Gamma', \mathbb{Q}) \rightarrow H^{2d}(\Gamma', \mathbb{Q}), \quad \phi \wedge \psi \mapsto \phi \cup \psi \cup \sigma^{d-1}.$$

Therefore the dimension r of $H^1(\Gamma', \mathbb{Q})$ is even, and we let $r = 2s$. Furthermore we may choose our basis $\{\phi_1, \dots, \phi_{2s}\}$ to be a symplectic basis, i.e. one which satisfies

$$\phi_i \cup \phi_j \cup \sigma^{d-1} = \begin{cases} \sigma^d & \text{if } j = i + s, \\ -\sigma^d & \text{if } j = i - s, \\ 0 & \text{otherwise.} \end{cases}$$

With such a choice of basis $\{\phi_i\}$ we have $\psi_i = \phi_{i+s}$ if $i \leq s$ and $\psi_i = -\phi_{i-s}$ if $i > s$. This allows us to simplify our formula for Σ , so that we have

$$\Sigma = \frac{1}{s} \sum_{i=1}^s \phi_i \cup \phi_{i+r}.$$

The key point here is that we are now expressing Σ as a sum of s cup products, rather than a sum of r cup products, so we have only half the number of terms as before. The theorem now follows from [Corollary 1](#). \square
