On the pathwise uniqueness for a class of degenerate Itô-stochastic differential equations ¹

Abstract. We show pathwise uniqueness for a class of degenerate Itô-SDE among all of its weak solutions that spend zero time at the points of degeneracy of the dispersion matrix. Consequently, by the Yamada-Watanabe Theorem and a weak existence result, the pathwise unique solutions can be shown to be strong and to exist. The main tools to show pathwise uniqueness are inequalities associated with maximal functions and a Krylov type estimate derived from elliptic regularity and uniqueness in law.

Keywords: pathwise uniqueness, degenerate Itô-SDE, Krylov type estimate, uniqueness in law, maximal function

1 Introduction

An Itô-SDE whose diffusion coefficient is not locally uniformly elliptic is called a degenerate Itô-SDE and in this paper, we aim to show pathwise uniqueness for a class of such SDEs on \mathbb{R}^d with $d \geq 3$. In [13], a Krylov type estimate induced by a parabolic regularity result on \mathbb{R}^d is essentially used to show pathwise uniqueness for a class of non-degenerate Itô-SDEs with singular drift coefficients. However, it is not clear how such an estimate can be derived when the diffusion coefficient is not locally uniformly elliptic. Recently in [7], using elliptic and parabolic regularity results and generalized Dirichlet form theory, the existence and uniqueness in law of a quite large class of degenerate Itô-SDEs with fully discontinuous coefficients was shown (see Theorem 2.2). This leads us to explore a subclass of degenerate Itô-SDE for which a Krylov type estimate can be concluded from resolvent regularity.

Let us introduce our main results. For some $y \in \mathbb{R}^d$, we deal with the following time-homogeneous degenerate Itô-SDE

$$X_t = y + \int_0^t \sqrt{\frac{1}{\psi}} (X_s) \cdot \sigma(X_s) dW_s + \int_0^t \mathbf{G}(X_s) ds, \quad 0 \le t < \infty,$$
(1)

where $(W_t)_{t\geq 0}$ is a *d*-dimensional standard Brownian motion and the degeneracy stems from $\sqrt{\frac{1}{\psi}}$. Now consider

(H1): $d \geq 3$, $\mathbf{G} = (g_1, \ldots, g_d) \in L^{\infty}_{loc}(\mathbb{R}^d, \mathbb{R}^d)$ and $A = (a_{ij})_{1 \leq i,j \leq d}$ is a symmetric matrix of functions with $a_{ji} = a_{ij} \in H^{1,2d+2}_{loc}(\mathbb{R}^d) \cap C(\mathbb{R}^d)$ for all $1 \leq i,j \leq d$ such that for every open ball $B \subset \mathbb{R}^d$, there exist constants $\lambda_B, \Lambda_B > 0$ with

$$\lambda_B \|\xi\|^2 \le \langle A(x)\xi,\xi\rangle \le \Lambda_B \|\xi\|^2$$
, for all $\xi \in \mathbb{R}^d$, $x \in B$.

 $\sigma = (\sigma_{ij})_{1 \le i,j \le d} \text{ is a matrix of continuous functions with } \sigma\sigma^T = A. \ \psi \in L^q_{loc}(\mathbb{R}^d) \text{ for some} \\ q > 2d + 2 \text{ with } \psi > 0 \text{ a.e., } \frac{1}{\psi} \in L^\infty_{loc}(\mathbb{R}^d), \text{ and } \sqrt{\frac{1}{\psi}}(x) \in [0,\infty) \text{ for any } x \in \mathbb{R}^d.$

If (H1) holds and ψ , σ and G are as in (H1), then we will consider the following conditions.

(H2): There exist constants $N_0 \in \mathbb{N}$ and M > 0 such that for a.e. $x \in \mathbb{R}^d \setminus \overline{B}_{N_0}$

$$-\frac{\langle \frac{1}{\psi}(x)A(x)x,x\rangle}{\|x\|^2} + \frac{\operatorname{trace}(\frac{1}{\psi}(x)A(x))}{2} + \langle \mathbf{G}(x),x\rangle \le M\|x\|^2(\ln\|x\|+1).$$
(2)

(H3): There exists an open set E in \mathbb{R}^d such that for any open ball U with $\overline{U} \subset E$,

$$0 < \inf_{U} \psi \le \sup_{U} \psi < \infty$$

(H4): For some $\widetilde{q} \in (\frac{d}{2}, \infty)$, $\sqrt{\frac{1}{\psi}} \cdot \sigma_{ij} \in H^{1,2\widetilde{q}}_{loc}(\mathbb{R}^d)$ and $g_i \in H^{1,\widetilde{q}}_{loc}(\mathbb{R}^d)$ for all $1 \le i, j \le d$.

Then our main result is stated as follows.

Theorem 1.1 Assume (H1)–(H4) and let E be as in (H3). Then for $y \in E$, pathwise uniqueness holds for (1) in the following sense. If $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}}_y, (\widetilde{\mathcal{F}}_t)_{t\geq 0}, (\widetilde{X}_t^k)_{t\geq 0}, (\widetilde{W}_t)_{t\geq 0})$, $k \in \{1, 2\}$ are weak solutions to (1) satisfying both

$$\int_0^\infty \mathbf{1}_{\{\sqrt{\frac{1}{\psi}}=0\}}(\widetilde{X}_s^k)ds = 0, \quad \widetilde{\mathbb{P}}_y\text{-}a.s, \tag{3}$$

then

$$\widetilde{\mathbb{P}}_{y}(\widetilde{X}_{t}^{1} = \widetilde{X}_{t}^{2}, t \ge 0) = 1.$$

$$\tag{4}$$

Moreover, for $y \in E$ and a d-dimensional Brownian motion $(\widetilde{W}_t)_{t\geq 0}$ on a probability space $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$, there exists a strong solution $(Y_t^y)_{t\geq 0}$ to (1) satisfying

$$\int_0^\infty \mathbf{1}_{\{\sqrt{\frac{1}{\psi}}=0\}}(Y^y_s)ds = 0, \qquad \widetilde{\mathbb{P}}\text{-}a.s.$$

The main ingredient for the proof of Theorem 1.1 is a new Krylov type estimate (Corollary 3.2) which is derived from uniqueness in law (Theorem 2.2) and elliptic regularity results for the resolvent (see (9)). Additionally, we adapt a technique used in [13, Proof of Theorem 2.2] and well-known inequalities for the Hardy–Littlewood maximal function (Proposition 2.1). As a concrete application of Theorem 1.1, we obtain the following result.

Corollary 1.2 Let $d \geq 3$ and $\alpha \in [0, \frac{d}{2d+2})$ be a constant, $\mathbf{G} = (g_1, \ldots, g_d) \in L^{\infty}_{loc}(\mathbb{R}^d, \mathbb{R}^d)$ satisfying that for some constants $N_0 \in \mathbb{N}$ and M > 0,

$$\langle \mathbf{G}(x), x \rangle \le M \|x\|^2 (\ln \|x\| + 1), \quad \text{for a.e. } x \in \mathbb{R}^d \setminus \overline{B}_{N_0}$$

and that for some $\varepsilon > 0$ $g_i \in H^{1,\frac{d}{2}+\varepsilon}_{loc}(\mathbb{R}^d)$ for all $1 \leq i \leq d$. Then for $y \in \mathbb{R}^d \setminus \{0\}$, pathwise uniqueness holds for

$$X_{t} = y + \int_{0}^{t} \|X_{s}\|^{\frac{\alpha}{2}} \cdot id \ dW_{s} + \int_{0}^{t} \mathbf{G}(X_{s})ds, \quad 0 \le t < \infty$$
(5)

in the following sense. If $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}}_y, (\widetilde{\mathcal{F}}_t)_{t \geq 0}, (\widetilde{X}_t^k)_{t \geq 0}), k \in \{1, 2\}$ are weak solutions to (5) satisfying both

$$\int_0^\infty 1_{\{0\}}(\widetilde{X}^k_s)ds = 0, \quad \widetilde{\mathbb{P}}_y\text{-}a.s,$$

then (4) follows. Moreover, for $y \in \mathbb{R}^d \setminus \{0\}$ and a d-dimensional Brownian motion $(\widetilde{W}_t)_{t\geq 0}$ on a probability space $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ there exists a strong solution $(Y_t^y)_{t\geq 0}$ to (5) satisfying

$$\int_0^\infty \mathbb{1}_{\{0\}}(Y^y_s)ds = 0, \qquad \widetilde{\mathbb{P}}\text{-}a.s.$$

To the author's knowledge, Engelbert and Schmidt first showed in [3] the existence and uniqueness in law of one-dimensional SDEs without drift among the solutions that spend zero time at the zeros of dispersion coefficients. In subsequent studies, they presented in [4] and [5] a sufficient condition for the existence of a pathwise unique and strong solution for one-dimensional SDEs with general drift. As another related literature, we refer to [8] and [2] dealing with similar types of results above. Although here formally similar results are shown for $d \geq 3$, the used methods completely differ from [8], [2], [3], [4], [5] in that we ultimately develop a new Krylov type estimate by using elliptic regularity and uniqueness in law.

In Section 2, we introduce well-known results about the Hardy–Littlewood maximal function and briefely explain the results of [7], where the existence and uniqueness in law of weak solutions to (1) are shown. In Section 3, we prove the already mentioned a new Krylov type estimate for weak solutions to (1) satisfying (3). Finally, in Section 4 we present the proofs of Theorem 1.1 and Corollary 1.2 and some examples where Theorem 1.1 is applied.

2 Preliminaries

For basic notations which are not defined in this paper, we refer to [6, **Notations and Conventions**]. For r > 0 and $x \in \mathbb{R}^d$, denote by $B_r(x)$ the open ball with radius r with center 0 and let $B_r = B_r(0)$. Weak and strong solutions to Itô-SDEs are defined as in [6, Definition 3.50]. For a matrix of functions $B = (b_{ij})_{1 \le i,j \le d}$, we write $||B|| = \left(\sum_{i,j=1}^d |b_{ij}|^2\right)^{1/2}$. Denote the $d \times d$ identity matrix by *id*. \mathcal{M} denotes the Hardy–Littlewood maximal operator defined by

$$\mathcal{M}f(x) = \sup_{r>0} \frac{1}{dx(B_r(x))} \int_{B_r(x)} |f(y)| dy, \qquad f \in L^1_{loc}(\mathbb{R}^d), \ x \in \mathbb{R}^d.$$

The following well-known results are crucially used in the proof of Theorem 1.1.

Proposition 2.1 (i) If $f \in L^r(\mathbb{R}^d)$ with $r \in (1,\infty]$, then $\mathcal{M}f \in L^r(\mathbb{R}^d)$ and there exists a constant $c_{d,r} > 0$ which only depends on d and r such that

$$\|\mathcal{M}f\|_{L^r(\mathbb{R}^d)} \le c_{d,r} \|f\|_{L^r(\mathbb{R}^d)}.$$

(ii) There exists a constant $\tilde{c}_d > 0$ which only depends on d such that for any $f \in C_0^1(\mathbb{R}^d)$ and $x, y \in \mathbb{R}^d$ it holds

$$|f(x) - f(y)| \le \widetilde{c}_d ||x - y|| (\mathcal{M} ||\nabla f||(x) + \mathcal{M} ||\nabla f||(y)).$$

Proof. (i) directly follows from [11, Chapter 1, 1.3, Theorem 1 (c)]. For the proof of (ii), let us choose a measurable set $A \subset \mathbb{R}^d$ in [14, Lemma 3.5] such that dx(A) = 0 and that

$$|f(z) - f(w)| \le 2^d ||z - w|| \left(\mathcal{M} ||\nabla f||(z) + \mathcal{M} ||\nabla f||(w)\right), \quad \forall z, w \in \mathbb{R}^d \setminus A.$$
(6)

Since $\|\nabla f\| \in C(\mathbb{R}^d)$, it holds $\|\nabla f\|(x) \leq \mathcal{M}\|\nabla f\|(x)$ for all $x \in \mathbb{R}^d$. Thus, by [1, Lemma 3.4] we obtain $\mathcal{M}\|\nabla f\| \in C(\mathbb{R}^d)$, hence the assertion follows from (6) and the continuity of f.

Under the assumption **(H1)**, by [7, Theorem 4] there exists $\mu = \rho \psi dx$ with $\rho \in H^{1,2d+2}_{loc}(\mathbb{R}^d) \cap C(\mathbb{R}^d)$ and $\rho(x) > 0$ for all $x \in \mathbb{R}^d$ such that

$$\int_{\mathbb{R}^d} \langle \mathbf{G} - \frac{1}{2\psi} \nabla A - \frac{1}{2\rho\psi} A \nabla \rho, \nabla f \rangle d\mu = 0, \quad \forall f \in C_0^\infty(\mathbb{R}^d).$$

Moreover, by [7, Theorem 3] there exists a sub-Markovian C_0 -semigroup of contractions $(\overline{T}_t)_{t>0}$ on $L^1(\mathbb{R}^d, \mu)$ whose generator extends $(L, C_0^{\infty}(\mathbb{R}^d))$, where

$$Lf = \frac{1}{2} \operatorname{trace}(\frac{1}{\psi} A \nabla^2 f) + \langle \mathbf{G}, \nabla f \rangle, \quad f \in C_0^{\infty}(\mathbb{R}^d).$$

Through Riesz–Thorin interpolation, $(\overline{T}_t)_{t>0}$ restricted to $L^1(\mathbb{R}^d,\mu)_b$ can be extended to a sub-Markovian C_0 -semigroup of contractions on each $L^r(\mathbb{R}^d,\mu)$, $r \in [1,\infty)$ and to a sub-Markovian semigroup of contractions on $L^{\infty}(\mathbb{R}^d,\mu)$. We donote all these by $(T_t)_{t>0}$. Denote by $(G_{\alpha})_{\alpha>0}$ the sub-Markovian C_0 -resolvent of contractions on each $L^r(\mathbb{R}^d,\mu)$, $r \in [1,\infty)$ and the sub-Markovian resolvent of contractions on $L^{\infty}(\mathbb{R}^d,\mu)$ associated with $(T_t)_{t>0}$, i.e.

$$G_{\alpha}f := \int_0^\infty e^{-\alpha s} T_s f ds, \qquad f \in \bigcup_{r \in [1,\infty]} L^r(\mathbb{R}^d,\mu).$$

Then by [7, Theorems 5, 6], there exist $(R_{\alpha})_{\alpha>0}$ and $(P_t)_{t>0}$ such that for any $\alpha, t > 0$ and $f \in \mathcal{B}_b(\mathbb{R}^d)$

$$R_{\alpha}f \in C(\mathbb{R}^d), P_{\cdot}f \in C(\mathbb{R}^d \times (0,\infty)) \text{ and } R_{\alpha}f = G_{\alpha}f, P_tg = T_tg \ \mu\text{-a.e.}$$

Moreover, it follows from [7, Theorem 7] that there exists a Hunt process

$$\mathbb{M} = (\Omega, \mathcal{F}, (\mathcal{F}_t)_{t \ge 0}, (X_t)_{t \ge 0}, (\mathbb{P}_x)_{x \in \mathbb{R}^d})$$

with state space \mathbb{R}^d and life time $\zeta = \inf\{t \ge 0 : X_t = \Delta\}$ satisfying that

$$\mathbb{P}_x\left(\{\omega\in\Omega: X_{\cdot}(\omega)\in C([0,\infty),\mathbb{R}^d), \ X_t(\omega)=\Delta \text{ for all } t\geq\zeta\}\right)=1, \quad \forall x\in\mathbb{R}^d,$$

where Δ is a point at infinity and that for all $f \in \mathcal{B}_b(\mathbb{R}^d)$, $t, \alpha > 0$ and $x \in \mathbb{R}^d$,

$$P_t f(x) = \mathbb{E}_x[f(X_t)], \quad R_\alpha f(x) = \mathbb{E}_x\left[\int_0^\infty e^{-\alpha s} f(X_s) ds\right], \tag{7}$$

where \mathbb{E}_x is the expectation with respect to \mathbb{P}_x defined on (Ω, \mathcal{F}) . Under the assumptions **(H1)** and **(H2)**, using a similar method to [6, Lemma 3.26], we obtain that \mathbb{M} is non-explosive, i.e. $\mathbb{P}_x(\zeta = \infty) = 1$ for all $x \in \mathbb{R}^d$ (equivalently, $(T_t)_{t>0}$ is conservative, i.e. $T_t \mathbb{1}_{\mathbb{R}^d} = 1$, μ -a.e. for all t > 0). As a direct consequence of [7, Theorems 8, 12, Lemma 2 and Remark 2] and the above, we then obtain the following theorem.

Theorem 2.2 Assume (H1)–(H2) and let $\mathbb{M} = (\Omega, \mathcal{F}, (\mathcal{F}_t)_{t\geq 0}, (X_t)_{t\geq 0}, (\mathbb{P}_x)_{x\in\mathbb{R}^d})$ be the Hunt process defined above. Then there exists an $(\mathcal{F}_t)_{t\geq 0}$ -Brownian motion $(W_t)_{t\geq 0}$ such that for any $y \in \mathbb{R}^d$, $(\Omega, \mathcal{F}, \mathbb{P}_y, (\mathcal{F}_t)_{t\geq 0}, (X_t)_{t\geq 0}, (W_t)_{t\geq 0})$ is a weak solution to (1) satisfying

$$\int_0^\infty \mathbf{1}_{\{\sqrt{\frac{1}{\psi}}=0\}}(X_s)ds = 0, \quad \mathbb{P}_y\text{-}a.s.$$

Furthermore if for some $y \in \mathbb{R}^d$ there exists a weak solution $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}}_y, (\widetilde{\mathcal{F}}_t)_{t \geq 0}, (\widetilde{X}_t)_{t \geq 0}, (\widetilde{W}_t)_{t \geq 0})$ to (1) such that

$$\int_0^\infty \mathbf{1}_{\{\sqrt{\frac{1}{\psi}}=0\}}(\widetilde{X}_s)ds = 0, \quad \widetilde{\mathbb{P}}_y\text{-}a.s.,$$
(8)

then

$$\mathbb{P}_y \circ X^{-1} = \widetilde{\mathbb{P}}_y \circ \widetilde{X}^{-1}, \quad on \ \mathcal{B}(C([0,\infty), \mathbb{R}^d)).$$

Remark 2.3 In Theorem 2.2, the assumption $d \ge 3$ of (H1) can be replaced by d = 2. However, we point out that $d \ge 3$ of (H1) is needed for all other results of this paper. Moreover, in order to obtain Theorem 2.2, the condition in (H1) that σ_{ij} is continuous for all $1 \le i, j \le d$ can be replaced by the condition that σ_{ij} is locally bounded and measurable for all $1 \le i, j \le d$.

3 Krylov type estimates

Theorem 3.1 Assume (H1) and (H3) and let E be as in (H3). Let $\tilde{q} \in (\frac{d}{2}, \infty)$, $y \in E$, t > 0and B be an open ball in \mathbb{R}^d . Let $\mathbb{M} = (\Omega, \mathcal{F}, (\mathcal{F}_t)_{t \ge 0}, (X_t)_{t \ge 0}, (\mathbb{P}_x)_{x \in \mathbb{R}^d})$ be the Hunt process of Section 2. Then for any $f \in L^{\tilde{q}}(\mathbb{R}^d)_0$ with $supp(fdx) \subset B$, there exists a constant $C_{y,B,\tilde{q}} > 0$ which is independent of f and t > 0 such that

$$\mathbb{E}_{y}\left[\int_{0}^{t} f(X_{s})ds\right] \leq e^{t}C_{y,B,\widetilde{q}} \|f\|_{L^{\widetilde{q}}(\mathbb{R}^{d})}$$

Proof. Let $(G_{\alpha})_{\alpha>0}$ be the resolvent defined on $\bigcup_{r\in[1,\infty]}L^r(\mathbb{R}^d,\mu)$ as in Section 2. Since E is an open subset of \mathbb{R}^d and $y \in E$, there exist open balls U_1 and U_2 such that $y \in U_1 \subset \overline{U}_1 \subset U_2 \subset \overline{U}_2 \subset E$. First assume $f \in C_0^{\infty}(\mathbb{R}^d)$ with $\operatorname{supp}(f) \subset B$. Then by the proof of [7, Theorem 5] (cf. [7, Theorem 3 (c)]), $G_1 f \in H^{1,2}(U_2)$ and

$$\begin{split} \int_{U_2} \left\langle \frac{1}{2} \rho A \nabla G_1 f, \nabla \varphi \right\rangle dx &- \int_{U_2} \left\langle \rho \psi \mathbf{B}, \nabla G_1 f \right\rangle \varphi \, dx + \int_{U_2} (\alpha \rho \psi G_1 f) \, \varphi dx \\ &= \int_{U_2} (\rho \psi f) \, \varphi dx, \qquad \forall \varphi \in C_0^\infty(U_2), \end{split}$$

where $\mathbf{B} = \mathbf{G} - \frac{1}{2\psi} (\nabla A + \frac{1}{\rho} A \nabla \rho)$. Note that $d \geq 3$ implies $1 - \frac{1}{2d+2} > \frac{2}{d} > \frac{1}{\tilde{q}}$. By [7, Theorems 2, 5], **(H3)** and the $L^1(\mathbb{R}^d, \mu)$ -contraction property of $(\alpha G_\alpha)_{\alpha>0}$, there exists a constant $C_1 > 0$ which only depends on the coefficients A, \mathbf{G} , ψ and U_1 , U_2 , \tilde{q} , d such that

$$\begin{aligned} \|R_{1}f\|_{C(\overline{U}_{1})} &\leq C_{1}\left(\|G_{1}f\|_{L^{1}(U_{2})} + \|\rho\psi f\|_{L^{\widetilde{q}}(U_{2})}\right) \\ &\leq C_{1}\left((\inf_{U_{2}}\rho\psi)^{-1}\|G_{1}f\|_{L^{1}(\mathbb{R}^{d},\mu)} + (\sup_{U_{2}}\rho\psi)\|f\|_{L^{\widetilde{q}}(\mathbb{R}^{d})}\right) \\ &\leq C_{1}\left((\inf_{U_{2}}\rho\psi)^{-1}\|f\|_{L^{1}(\mathbb{R}^{d},\mu)} + (\sup_{U_{2}}\rho\psi)\|f\|_{L^{\widetilde{q}}(\mathbb{R}^{d})}\right) \\ &\leq C_{1}\left((\inf_{U_{2}}\rho\psi)^{-1}\|\rho\psi\|_{L^{2d+2}(B)}\|f\|_{L^{\frac{2d+2}{2d+1}}(B)} + (\sup_{U_{2}}\rho\psi)\|f\|_{L^{\widetilde{q}}(\mathbb{R}^{d})}\right) \\ &\leq C_{1}C_{2}\|f\|_{L^{\widetilde{q}}(\mathbb{R}^{d})}, \end{aligned}$$
(9)

where $C_2 := (\inf_{U_2} \rho \psi)^{-1} \|\rho \psi\|_{L^{2d+2}(B)} dx(B)^{\frac{2d+1}{2d+2}-\frac{1}{q}} + \sup_{U_2} \rho \psi$. Using the denseness of $C_0^{\infty}(B)$ in $L^{\widetilde{q}}(B)$, (9) extends to $f \in \mathcal{B}_b(\mathbb{R}^d)_0$ with $\operatorname{supp}(fdx) \subset B$. By (7) and (9), it holds for any $f \in \mathcal{B}_b(\mathbb{R}^d)_0$ with $\operatorname{supp}(fdx) \subset B$

$$\mathbb{E}_{y}\left[\int_{0}^{t} f(X_{s})ds\right] \leq e^{t} \mathbb{E}_{y}\left[\int_{0}^{\infty} e^{-s}|f|(X_{s})ds\right]$$

= $e^{t}R_{1}|f|(y) \leq e^{t}||R_{1}|f|||_{C(\overline{U}_{1})} \leq e^{t}C_{1}C_{2}||f||_{L^{\widetilde{q}}(\mathbb{R}^{d})}.$

Finally, using monotone approximation, the assertion follows.

As a direct consequence of Theorems 3.1, 2.2, we obtain the following.

Corollary 3.2 Assume (H1)-(H3) and let E be as in (H3). Let $\tilde{q} \in (\frac{d}{2}, \infty)$, $y \in E$, t > 0and B be an open ball in \mathbb{R}^d . Let $(\tilde{\Omega}, \tilde{\mathcal{F}}, \tilde{\mathbb{P}}_y, (\tilde{\mathcal{F}}_t)_{t\geq 0}, (\tilde{X}_t)_{t\geq 0}, (\tilde{W}_t)_{t\geq 0})$ be a weak solution to (1) satisfying (8). Then for any $f \in L^{\tilde{q}}(\mathbb{R}^d)_0$ with $supp(fdx) \subset B$, there exists a constant $C_{y,B,\tilde{q}} > 0$ which is independent of f and t > 0 such that

$$\widetilde{\mathbb{E}}_{y}\left[\int_{0}^{t} f(\widetilde{X}_{s}) ds\right] \leq e^{t} C_{y,B,\widetilde{q}} \|f\|_{L^{\widetilde{q}}(\mathbb{R}^{d})}$$

where $\widetilde{\mathbb{E}}_y$ is the expectation with respect to $\widetilde{\mathbb{P}}_y$ defined on $(\widetilde{\Omega}, \widetilde{\mathcal{F}})$.

4 Pathwise uniqueness

Proof of Theorem 1.1. Fix $y \in E$. For $k \in \{1,2\}$, let $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}}_y, (\widetilde{\mathcal{F}}_t)_{t \ge 0}, (\widetilde{X}_t^k)_{t \ge 0}, (\widetilde{W}_t)_{t \ge 0})$ be weak solutions to (1) satisfying (3) and let $\widetilde{Z}_t := \widetilde{X}_t^1 - \widetilde{X}_t^2, t \ge 0$. Given $n \in \mathbb{N}$ with $n \ge 2$ and $y \in B_{n-1}$, set $\widetilde{D}_n^k := \inf\{t \ge 0 : \widetilde{X}_t^k \in \mathbb{R}^d \setminus B_{n-1}\}$ and $\widetilde{D}_n := \widetilde{D}_n^1 \wedge \widetilde{D}_n^2$. Let $\widehat{\sigma} = (\widehat{\sigma}_{ij})_{1 \le i,j \le d}$ be defined by $\widehat{\sigma} = \sqrt{\frac{1}{\psi}} \cdot \sigma$. By Itô's formula, for any $t \ge 0$ it holds \mathbb{P}_y -a.s.

$$\begin{split} \|\widetilde{Z}_{t\wedge D_n}\|^2 &= 2\int_0^{t\wedge D_n} \widetilde{Z}_s \left(\widehat{\sigma}(\widetilde{X}_s^1) - \widehat{\sigma}(\widetilde{X}_s^2) d\widetilde{W}_s + \int_0^{t\wedge D_n} \|\widehat{\sigma}(\widetilde{X}_s^1) - \widehat{\sigma}(\widetilde{X}_s^2)\|^2 ds \\ &+ 2\int_0^{t\wedge D_n} \langle \widetilde{Z}_s, \mathbf{G}(\widetilde{X}_s^1) - \mathbf{G}(\widetilde{X}_s^2) \rangle ds. \end{split}$$

Let $\widehat{\sigma}_{ij}^n \in H^{1,2\widetilde{q}}(\mathbb{R}^d)_0$ be an extension of $1_{B_n}\widehat{\sigma}_{ij} \in H^{1,2\widetilde{q}}(B_n)$ satisfying $\operatorname{supp}(\widehat{\sigma}_{ij}^n dx) \subset B_{n+1}$ for each $i, j \in \{1, 2...d\}$. Likewise, let $g_i^n \in H^{1,\widetilde{q}}(\mathbb{R}^d)_0$ be an extension of $1_{B_n}g_i$ satisfying $\operatorname{supp}(g_i^n) \subset B_{n+1}$ for each $i \in \{1, 2...d\}$ and let $\mathbf{G}^n = (g_1^n, \ldots, g_d^n)$. Given $m \in \mathbb{N}$, let $\eta_m \in C_0^{\infty}(B_{1/m})$ be a standard mollifier on \mathbb{R}^d . Define

$$\widehat{\sigma}_{ij}^{n,m} := \widehat{\sigma}_{ij}^n * \eta_m, \quad g_i^{n,m} := g_i^n * \eta_m, \quad \text{ for } i, j \in \{1, 2, \dots, d\},$$

where f * g is the convolution of f and g. Let $\widehat{\sigma}^{n,m} = (\widehat{\sigma}^{n,m}_{ij})_{1 \le i,j \le d}$ and $\mathbf{G}^{n,m} = (g_1^{n,m}, \dots, g_d^{n,m})$. Set

$$N_t := M_t + A_t^{(1)} + A_t^{(2)}$$
 and $N_t^n := N_{t \wedge \widetilde{D}_n}$ for $t \ge 0$,

where

$$M_t := 2 \int_0^t \frac{\widetilde{Z}_s \left(\widehat{\sigma}(\widetilde{X}_s^1) - \widehat{\sigma}(\widetilde{X}_s^2)\right)}{\|\widetilde{Z}_s\|^2} d\widetilde{W}_s, \quad A_t^{(1)} := \int_0^t \frac{\|\widehat{\sigma}(X_s^1) - \widehat{\sigma}(\widetilde{X}_s^2)\|^2}{\|\widetilde{Z}_s\|^2} ds,$$
$$A_t^{(2)} := 2 \int_0^t \frac{\langle \widetilde{Z}_s, \mathbf{G}(\widetilde{X}_s^1) - \mathbf{G}(\widetilde{X}_s^2) \rangle}{\|\widetilde{Z}_s\|^2} ds, \quad t \ge 0,$$

where $\frac{0}{0} := 0$. Then for all $t \ge 0$ it holds

$$\|\widetilde{Z}_{t\wedge D_n}\|^2 = \int_0^t \|\widetilde{Z}_{s\wedge D_n}\|^2 dN_s^n, \qquad \widetilde{\mathbb{P}}_y\text{-a.s.}$$
(10)

Let $\widetilde{\mathbb{E}}_y$ be the expectation with respect to $\widetilde{\mathbb{P}}_y$ defined on $(\widetilde{\Omega}, \widetilde{\mathcal{F}})$. By Itô-isometry and Fatou's Lemma, it holds

$$\begin{split} \frac{1}{4} \widetilde{\mathbb{E}}_y \left[|M_{t \wedge \widetilde{D}_n}|^2 \right] &\leq \quad \widetilde{\mathbb{E}}_y \left[\int_0^{t \wedge \widetilde{D}_n} \frac{\|\widehat{\sigma}^n(\widetilde{X}_s^1) - \widehat{\sigma}^n(\widetilde{X}_s^2)\|^2}{\|\widetilde{Z}_s\|^2} ds \right] \\ &\leq \quad \liminf_{\delta \to 0+} \widetilde{\mathbb{E}}_y \left[\int_0^{t \wedge \widetilde{D}_n} \frac{\|\widehat{\sigma}^n(\widetilde{X}_s^1) - \widehat{\sigma}^n(\widetilde{X}_s^2)\|^2}{\|\widetilde{Z}_s\|^2} \mathbf{1}_{\{\|\widetilde{Z}_s\| > \delta\}} ds \right]. \end{split}$$

Using triangle inequality and Jensen's inequality, we get

$$\begin{split} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\widehat{\sigma}^{n}(\widetilde{X}_{s}^{1}) - \widehat{\sigma}^{n}(\widetilde{X}_{s}^{2})\|^{2}}{\|\widetilde{Z}_{s}\|^{2}} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right] \\ &\leq 3 \Biggl(\limsup_{m \to \infty} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\widehat{\sigma}^{n}(\widetilde{X}_{s}^{1}) - \widehat{\sigma}^{n,m}(\widetilde{X}_{s}^{1})\|^{2}}{\|\widetilde{Z}_{s}\|^{2}} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right] \\ &+ \sup_{m \in \mathbb{N}} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\widehat{\sigma}^{n,m}(\widetilde{X}_{s}^{1}) - \widehat{\sigma}^{n,m}(\widetilde{X}_{s}^{2})\|^{2}}{\|\widetilde{Z}_{s}\|^{2}} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right] \\ &+ \limsup_{m \to \infty} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\widehat{\sigma}^{n,m}(\widetilde{X}_{s}^{2}) - \widehat{\sigma}^{n}(\widetilde{X}_{s}^{2})\|^{2}}{\|\widetilde{Z}_{s}\|^{2}} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right] \Biggr). \end{split}$$

Using Corollary 3.2,

$$\begin{split} \limsup_{m \to \infty} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\widehat{\sigma}^{n}(\widetilde{X}_{s}^{1}) - \widehat{\sigma}^{n,m}(\widetilde{X}_{s}^{1})\|^{2}}{\|\widetilde{Z}_{s}\|^{2}} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right] \\ &\leq \limsup_{m \to \infty} \frac{1}{\delta^{2}} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t} \|\widehat{\sigma}^{n}(\widetilde{X}_{s}^{1}) - \widehat{\sigma}^{n,m}(\widetilde{X}_{s}^{1})\|^{2} ds \right] \\ &\leq \limsup_{m \to \infty} \frac{C_{y,B_{n+1},\widetilde{q}}}{\delta^{2}} \sum_{i,j=1}^{d} \|(\widehat{\sigma}_{ij}^{n} - \widehat{\sigma}_{ij}^{n,m})\|_{L^{2\widetilde{q}}(\mathbb{R}^{d})}^{2} = 0, \end{split}$$

where $C_{y,B_{n+1},\widetilde{q}} > 0$ is a constant as in Corollary 3.2. In the same way as above, we also get

$$\limsup_{m \to \infty} \widetilde{\mathbb{E}}_y \left[\int_0^{t \wedge \widetilde{D}_n} \frac{\|\widehat{\sigma}^{n,m}(\widetilde{X}_s^2) - \widehat{\sigma}^n(\widetilde{X}_s^2)\|^2}{\|\widetilde{Z}_s\|^2} 1_{\{\|\widetilde{Z}_s\| > \delta\}} ds \right] = 0.$$

By Proposition 2.1 and Corollary 3.2,

$$\sup_{m\in\mathbb{N}} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t\wedge\widetilde{D}_{n}} \frac{\|\widehat{\sigma}^{n,m}(\widetilde{X}_{s}^{1}) - \widehat{\sigma}^{n,m}(\widetilde{X}_{s}^{2})\|^{2}}{\|\widetilde{Z}_{s}\|^{2}} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right]$$

$$\leq \sup_{m\in\mathbb{N}} \sum_{i,j=1}^{d} \widetilde{c}_{d} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t} \left(\mathbf{1}_{B_{n}}(\widetilde{X}_{s}^{1})\mathcal{M}\|\nabla\widehat{\sigma}_{ij}^{n,m}\|(\widetilde{X}_{s}^{1}) + \mathbf{1}_{B_{n}}(\widetilde{X}_{s}^{2})\mathcal{M}\|\nabla\widehat{\sigma}_{ij}^{n,m}\|(\widetilde{X}_{s}^{2})\right)^{2} ds \right] \quad (11)$$

$$\leq \sup_{m\in\mathbb{N}} \sum_{i,j=1}^{d} 2e^{t} \widetilde{c}_{d} C_{y,B_{n+1},\widetilde{q}} \left(\left\| \mathbf{1}_{B_{n}}\mathcal{M}\|\nabla\widehat{\sigma}_{ij}^{n,m}\| \right\|_{L^{2}\widetilde{q}(\mathbb{R}^{d})}^{2} + \left\| \mathbf{1}_{B_{n}}\mathcal{M}\|\nabla\widehat{\sigma}_{ij}^{n,m}\| \right\|_{L^{2}\widetilde{q}(\mathbb{R}^{d})}^{2} \right)$$

$$\leq 4e^{t} c_{d,2\widetilde{q}}^{2} \widetilde{c}_{d} C_{y,B_{n+1},\widetilde{q}} \sup_{m\in\mathbb{N}} \sum_{i,j=1}^{d} \|\nabla\widehat{\sigma}_{ij}^{n,m}\|_{L^{2}\widetilde{q}(\mathbb{R}^{d})}^{2} \leq 4e^{t} c_{d,2\widetilde{q}}^{2} \widetilde{c}_{d} C_{y,B_{n+1},\widetilde{q}} \sum_{i,j=1}^{d} \|\nabla\widehat{\sigma}_{ij}^{n}\|_{L^{2}\widetilde{q}(\mathbb{R}^{d})}^{2},$$

where $c_{d,2\tilde{q}}, \tilde{c}_d > 0$ are constants as in Proposition 2.1. Therefore, $\widetilde{\mathbb{E}}_y \left[|M_{t \wedge D_n}|^2 \right] < \infty$. Analogously to the above,

$$\widetilde{\mathbb{E}}_{y}\left[|A_{t\wedge\widetilde{D}_{n}}^{(1)}|\right] \leq 4e^{t}c_{d,2\widetilde{q}}^{2}\widetilde{c}_{d}C_{y,B_{n+1},\widetilde{q}}\sum_{i,j=1}^{d}\|\nabla\widehat{\sigma}_{ij}^{n}\|_{L^{2\widetilde{q}}(\mathbb{R}^{d})}^{2} < \infty.$$

Using Fatou's Lemma,

$$\begin{split} \frac{1}{2} \widetilde{\mathbb{E}}_{y} \left[|A_{t \wedge \widetilde{D}_{n}}^{(2)}| \right] &\leq \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\mathbf{G}^{n}(\widetilde{X}_{s}^{1}) - \mathbf{G}^{n}(\widetilde{X}_{s}^{2})\|}{\|\widetilde{Z}_{s}\|} ds \right] \\ &\leq \liminf_{\delta \to 0+} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\mathbf{G}^{n}(\widetilde{X}_{s}^{1}) - \mathbf{G}^{n}(X_{s}^{2})\|}{\|\widetilde{Z}_{s}\|} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right], \end{split}$$

and again as above, we have

$$\begin{split} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge D_{n}} \frac{\|\mathbf{G}^{n}(\widetilde{X}_{s}^{1}) - \mathbf{G}^{n}(\widetilde{X}_{s}^{2})\|}{\|\widetilde{Z}_{s}\|} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right] \\ & \leq \left(\limsup_{m \to \infty} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\mathbf{G}^{n}(\widetilde{X}_{s}^{1}) - \mathbf{G}^{n,m}(\widetilde{X}_{s}^{1})\|}{\|\widetilde{Z}_{s}\|} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right] \\ & + \sup_{m \in \mathbb{N}} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\mathbf{G}^{n,m}(\widetilde{X}_{s}^{1}) - \mathbf{G}^{n,m}(\widetilde{X}_{s}^{2})\|}{\|\widetilde{Z}_{s}\|} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right] \\ & + \limsup_{m \to \infty} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\mathbf{G}^{n,m}(\widetilde{X}_{s}^{2}) - \mathbf{G}^{n}(\widetilde{X}_{s}^{2})\|}{\|\widetilde{Z}_{s}\|} \mathbf{1}_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right] \right). \end{split}$$

Using Corollary 3.2,

$$\begin{split} &\limsup_{m \to \infty} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t \wedge \widetilde{D}_{n}} \frac{\|\mathbf{G}^{n}(\widetilde{X}_{s}^{1}) - \mathbf{G}^{n,m}(\widetilde{X}_{s}^{1})\|}{\|\widetilde{Z}_{s}\|} 1_{\{\|\widetilde{Z}_{s}\| > \delta\}} ds \right] \\ &\leq \limsup_{m \to \infty} \frac{1}{\delta^{2}} \widetilde{\mathbb{E}}_{y} \left[\int_{0}^{t} \|\mathbf{G}^{n}(\widetilde{X}_{s}^{1}) - \mathbf{G}^{n,m}(\widetilde{X}_{s}^{1})\| ds \right] \leq \limsup_{m \to \infty} \frac{e^{t} C_{y,B_{n+1},\widetilde{q}}}{\delta^{2}} \|\mathbf{G}^{n} - \mathbf{G}^{n,m}\|_{L^{\widetilde{q}}(\mathbb{R}^{d})} = 0, \end{split}$$

and as before

$$\limsup_{m \to \infty} \widetilde{\mathbb{E}}_y \left[\int_0^{t \wedge \widetilde{D}_n} \frac{\|\mathbf{G}^n(\widetilde{X}_s^2) - \mathbf{G}^{n,m}(\widetilde{X}_s^2)\|}{\|\widetilde{Z}_s\|} 1_{\{\|\widetilde{Z}_s\| > \delta\}} ds \right] = 0.$$

Using an estimate as in (11), Proposition 2.1 and Corollary 3.2, we obtain

$$\sup_{m\in\mathbb{N}}\widetilde{\mathbb{E}}_{y}\left[\int_{0}^{t\wedge D_{n}}\frac{\|\mathbf{G}^{n,m}(\widetilde{X}_{s}^{1})-\mathbf{G}^{n,m}(\widetilde{X}_{s}^{2})\|}{\|\widetilde{Z}_{s}\|}\mathbf{1}_{\{\|\widetilde{Z}_{s}\|>\delta\}}ds\right] \leq 2e^{t}c_{d,2\widetilde{q}}\,\widetilde{c}_{d}\,C_{y,B_{n+1},\widetilde{q}}\sum_{i=1}^{d}\|\nabla g_{i}\|_{L^{\widetilde{q}}(\mathbb{R}^{d})}$$

Therefore, $\tilde{\mathbb{E}}_{y}\left[|A_{t\wedge D_{n}}^{(2)}|\right] < \infty$. Thus, applying [10, page 378, (2.3) Proposition] to (10), it follows that

$$\|\widetilde{Z}_{t\wedge\widetilde{D}_n}\|^2 = \|\widetilde{Z}_0\|^2 \exp\left(M_{t\wedge\widetilde{D}_n} + A_{t\wedge\widetilde{D}_n}^{(1)} + A_{t\wedge\widetilde{D}_n}^{(2)} - \frac{1}{2}\langle M \rangle_{t\wedge\widetilde{D}_n}\right) = 0, \quad \widetilde{\mathbb{P}}_y\text{-a.s.}$$

Since $\widetilde{D}_n \to \infty \ \widetilde{\mathbb{P}}_y$ -a.s. as $n \to \infty$, letting $n \to \infty$ we obtain $\widetilde{Z}_t = 0$, $\widetilde{\mathbb{P}}_y$ -a.s. so that pathwise uniqueness is shown. The existence of a strong solution $(Y_t^y)_{t\geq 0}$ to (1) follows from the Yamada-Watanabe Theorem ([12, Corollary 1]).

Proof of Corollary 1.2. Let $A = \sigma = id$, $\sqrt{\frac{1}{\psi}}(x) = ||x||^{\alpha/2}$, $x \in \mathbb{R}^d$ and $E = \mathbb{R}^d \setminus \{0\}$. Then **(H1)**–**(H4)** are satisfied and the SDE (1) becomes the SDE (5). Choose $q \in (2d + 2, \frac{d}{\alpha})$ and $\tilde{q} \in (\frac{d}{2}, \frac{d}{2-\alpha} \wedge \frac{d}{2} + \varepsilon)$. Then $\psi \in L^q_{loc}(\mathbb{R}^d) \sqrt{\frac{1}{\psi}} \in H^{1,2\tilde{q}}_{loc}(\mathbb{R}^d)$ and $g_i \in H^{1,\tilde{q}}_{loc}(\mathbb{R}^d)$ for all $1 \leq i \leq d$. Therefore, the assertion follows from Theorem 1.1.

Remark 4.1 In Theorems 1.1, 2.2 and Corollary 3.2, the condition (H2) can be replaced by any ohter condition that implies the non-explosion of \mathbb{M} defined in Section 2 (cf. [7]).

Example 4.2 Let $d \geq 3$ and for some $\varepsilon > 0$ let $\mathbf{G} = (g_1, \ldots, g_d) \in L^{\infty}_{loc}(\mathbb{R}^d, \mathbb{R}^d)$ with $g_i \in H^{1,\frac{d}{2}+\varepsilon}_{loc}(\mathbb{R}^d)$ for all $1 \leq i, j \leq d$. Consider the following Itô-SDE

$$X_t = y + \int_0^t \sqrt{\frac{1}{\psi}} \left(X_s\right) \cdot id \, dW_s + \int_0^t \mathbf{G}(X_s) ds, \qquad 0 \le t < \infty, \tag{12}$$

where y and $\sqrt{\frac{1}{\psi}}$ are specified below in three different cases.

(i) For $\alpha \in [0, \frac{d}{2d+2})$ and $\gamma \in (0, \infty)$, let

$$\sqrt{\frac{1}{\psi}}(x) := \|x\|^{\alpha/2} \mathbf{1}_{\{x \neq 0\}}(x) + \gamma \mathbf{1}_{\{x = 0\}}(x), \quad x \in \mathbb{R}^d.$$

Then $\left\{\sqrt{\frac{1}{\psi}}=0\right\}=\emptyset$. Thus by Theorem 1.1 (cf. proof of Corollary 1.2), for $y \in \mathbb{R}^d \setminus \{0\}$ pathwise uniqueness holds for (12) in the usual sense, i.e. if

$$(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}}_y, (\widetilde{\mathcal{F}}_t)_{t \ge 0}, (\widetilde{X}_t^k)_{t \ge 0}, (\widetilde{W}_t)_{t \ge 0}), \quad k \in \{1, 2\}$$

are weak solutions to (12), then

$$\widetilde{\mathbb{P}}_y(\widetilde{X}^1_t = \widetilde{X}^2_t, \ t \ge 0) = 1.$$

Moreover, by Theorem 1.1 and Corollary 3.2 for $y \in \mathbb{R}^d \setminus \{0\}$ and a d-dimensional Brownian motion $(\widetilde{W}_t)_{t\geq 0}$ on a probability space $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ there exists a strong solution $(Y_t^y)_{t\geq 0}$ to (12) satisfying

$$\int_0^\infty 1_{\{0\}}(Y_s^y)ds = 0, \qquad \widetilde{\mathbb{P}}\text{-}a.s.$$

(ii) Let $\alpha \in [0, \frac{d}{2d+2})$. For $i \in \mathbb{N} \cup \{0\}$, let

$$\phi_i(x) = \|x - 2i\mathbf{e}_1\|^{\frac{\alpha}{2}} \mathbf{1}_{B_1(2i\mathbf{e}_1)}(x), \quad x \in \mathbb{R}^d,$$

where $B_1(2i\mathbf{e}_1)$ denotes an open ball with center $2i\mathbf{e}_1$ and radius 1. Define

$$\sqrt{\frac{1}{\psi}}(x) := \mathbb{1}_{\mathbb{R}^d \setminus \bigcup_{i=0}^{\infty} B_1(2i\mathbf{e}_1)} + \sum_{i=0}^{\infty} \phi_i(x), \qquad x \in \mathbb{R}^d.$$

Note that $\left\{\sqrt{\frac{1}{\psi}}=0\right\} = \{2i\mathbf{e}_1 : i \in \mathbb{N} \cup \{0\}\}$. Thus by Theorem 1.1 (cf. proof of Corollary 1.2), for $y \in \mathbb{R}^d \setminus \{2i\mathbf{e}_1 : i \in \mathbb{N} \cup \{0\}\}$ pathwise uniqueness holds for (12) in the following sense, i.e. if

$$(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}}_y, (\widetilde{\mathcal{F}}_t)_{t \ge 0}, (\widetilde{X}_t^k)_{t \ge 0}, (\widetilde{W}_t)_{t \ge 0}), \ k \in \{1, 2\}$$

are weak solutions to (1) satisfying both

$$\int_0^\infty 1_{\bigcup_{i=0}^\infty \{2i\mathbf{e}_1\}}(\widetilde{X}_s^k)ds = 0, \quad \widetilde{\mathbb{P}}_y\text{-}a.s,$$

then

$$\widetilde{\mathbb{P}}_y(\widetilde{X}_t^1 = \widetilde{X}_t^2, \ t \ge 0) = 1.$$

Moreover, by Theorem 1.1 and Corollary 3.2 for $y \in \mathbb{R}^d \setminus \{2i\mathbf{e}_1 : i \in \mathbb{N} \cup \{0\}\}$ and a d-dimensional Brownian motion $(\widetilde{W}_t)_{t\geq 0}$ on a probability space $(\widetilde{\Omega}, \widetilde{\mathcal{F}}, \widetilde{\mathbb{P}})$ there exists a strong solution $(Y_t^y)_{t\geq 0}$ to (12) satisfying

$$\int_0^\infty \mathbf{1}_{\{2i\mathbf{e}_1:i\in\mathbb{N}\cup\{0\}\}}(Y_s^y)ds = 0, \quad \widetilde{\mathbb{P}}\text{-}a.s.$$

$$\tag{13}$$

(iii) Let $(\gamma_i)_{i\geq 0}$ be a sequence with $\gamma_i \in (0,\infty)$ for all $i \in \mathbb{N} \cup \{0\}$. For $\alpha \in [0, \frac{d}{2d+2})$ and $i \in \mathbb{N} \cup \{0\}$, let ϕ_i be defined as in (ii). Define

$$\sqrt{\frac{1}{\psi}}(x) := \mathbb{1}_{\mathbb{R}^d \setminus \bigcup_{i=0}^{\infty} B_1(2i\mathbf{e}_1)} + \sum_{i=0}^{\infty} \gamma_i \mathbb{1}_{\{2i\mathbf{e}_1\}} + \mathbb{1}_{\mathbb{R}^d \setminus \bigcup_{i=0}^{\infty} \{2i\mathbf{e}_1\}} \left(\sum_{i=0}^{\infty} \phi_i(x)\right), \quad x \in \mathbb{R}^d.$$

Then $\left\{\sqrt{\frac{1}{\psi}}=0\right\}=\emptyset$. Therefore, by Theorem 1.1 (cf. proof of Corollary 1.2), for $y \in \mathbb{R}^d \setminus \{2i\mathbf{e}_1 : i \in \mathbb{N} \cup \{0\}\}\$ pathwise uniqueness holds for (12) in the usual sense and by Corollary 3.2 there exists a strong solution $(Y_t^y)_{t\geq 0}$ to (12) satisfying (13).
