# FROM RIGHT (n+2)-ANGULATED CATEGORIES TO n-EXANGULATED CATEGORIES

ABSTRACT. The notion of right semi-equivalence in a right (n+2)-angulated category is defined in this article. Let  $\mathscr C$  be an n-exangulated category and  $\mathscr X$  is a strongly covariantly finite subcategory of  $\mathscr C$ . We prove that the standard right (n+2)-angulated category  $\mathscr C/\mathscr X$  is right semi-equivalence under a natural assumption. As an application, we show that a right (n+2)-angulated category has an n-exangulated structure if and only if the suspension functor is right semi-equivalence. Besides, we also prove that an n-exangulated category  $\mathscr C$  has the structure of a right (n+2)-angulated category with right semi-equivalence if and only if for any object  $X \in \mathscr C$ , the morphism  $X \to 0$  is a trivial inflation.

### 1. Introduction

Triangulated categories and exact categories are two fundamental structures in algebra, geometry and topology. They are also important tools in many mathematical branches. Nakaoka and Palu [NP] recently introduced the notion of extriangulated categories, whose extriangulated structures are given by E-triangles with some axioms. Triangulated categories and exact categories are extriangulated categories. There are a lot of examples of extriangulated categories which are neither triangulated categories nor exact categories, see [NP, ZZ, HZZ2, NP1, T]. Beligiannis and Marmaridis [BM] defined the notion of right triangulated category. Informally, a right triangulated category is a triangulated category whose suspension functor is not necessarily an equivalence. Subsequently, in order to research some homological properties, the notion of a right triangulated category with right semi-equivalence was introduced by Assem, Beligiannis and Marmaridis [ABM], these are the right triangulated category whose suspension functor is fully faithful and right dense. We need to pay attention to this relation: a triangulated category is a right triangulated category with right semi-equivalence, but the opposite is not necessarily true, see Example 3.5. Recently, Tattar [T] proved a right triangulated category with right semi-equivalence is an extriangulated category. More specifically, Tattar [T] gave a characterization of right triangulated categories which are extriangulated as follows.

**Theorem 1.1.** [T, Theorem A] Let  $(\mathscr{C}, \Sigma, \nabla)$  be a right triangulated category. Then  $\mathscr{C}$  has an extriangulated structure if and only if the suspension functor  $\Sigma$  is right semi-equivalence.

Moreover, Tattar also gave a characterization of extriangulated categories which are right triangulated with right semi-equivalences.

**Theorem 1.2.** [T, Theorem B] Let  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  be an extriangulated category. Then  $\mathscr{C}$  has a right triangulated structure and the suspension functor is right semi-equivalence if and only if for any object  $C \in \mathscr{C}$ , the morphism  $C \to 0$  is an inflation.

In [GKO], Geiss, Keller and Oppermann introduced a new type of categories, called (n+2)-angulated categories, which generalize triangulated categories: the classical triangulated categories are the special case n=1. Lin [L] introduced right (n+2)-angulated categories, the right triangulated categories are the special case n=1. Later, Jasso [J] introduced n-exact categories which are categories inhabited by certain exact sequences with n+2 terms terms, called n-exact sequences. The case n=1 corresponds to the usual concepts of exact categories. Recently, Herschend, Liu and Nakaoka [HLN] introduced the notion of n-exangulated categories. It should be noted that the case n=1 corresponds to extriangulated categories. As typical examples we have that n-exact and (n+2)-angulated categories are

n-exangulated, see [HLN, Proposition 4.5 and Proposition 4.34]. However, there are some other examples of n-exangulated categories which are neither (n + 2)-angulated nor n-exact, see [HLN, LZ1, HZZ1].

Motivated by the definition of a right triangulated category with right semi-equivalence and the Tattar's idea, we define right (n + 2)-angulated categories with right semi-equivalences (see Definition 3.1), and prove the following.

**Theorem 1.3.** (see Theorem 3.12 for details) Let  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  be an n-example action and  $\mathscr{X}$  be a strongly covariantly finite subcategory of  $\mathscr{C}$ . Then  $\mathscr{C}/\mathscr{X}$  is a right (n+2)-angulated category with right semi-equivalence under a reasonable assumption.

We also show that Tattar's result has a higher counterpart:

**Theorem 1.4.** (see Corollary 4.5 for details) Let  $(\mathcal{C}, \Sigma^n, \Theta)$  be a right (n+2)-angulated category. Then  $\mathcal{C}$  has the natural structure of an n-exangulated category if and only if the n-suspension functor  $\Sigma^n$  is right semi-equivalence.

Moreover, we also gives a way to characterize which n-exangulated categories induces right (n + 2)angulated categories with right semi-equivalences.

**Theorem 1.5.** (see Theorem 4.3 for details) Let  $(\mathcal{C}, \mathbb{E}, \mathfrak{s})$  be an n-exangulated category. Then  $\mathcal{C}$  induces an (n+2)-angulated structure with right semi-equivalence if and only if for any object  $C \in \mathcal{C}$ , the morphism  $C \to 0$  is a trivial inflation.

This article is organized as follows. In Section 2, we review some elementary definitions and facts on n-exangulated categories and right (n+2)-angulated categories. In Section 3, we define a notion of right semi-equivalences for right (n+2)-angulated categories, and we give the proof of Theorem 1.3. In Section 4, we prove Theorem 1.4 and Theorem 1.5.

## 2. Preliminaries

In this section, we briefly review basic concepts and results concerning n-exangulated categories and right (n+2)-angulated categories.

2.1. *n*-exangulated categories. For any pair of objects  $A, C \in \mathcal{C}$ , an element  $\delta \in \mathbb{E}(C, A)$  is called an  $\mathbb{E}$ -extension or simply an extension. We also write such  $\delta$  as  ${}_{A}\delta_{C}$  when we indicate A and C. The zero element  ${}_{A}0_{C} = 0 \in \mathbb{E}(C, A)$  is called the *split*  $\mathbb{E}$ -extension. For any pair of  $\mathbb{E}$ -extensions  ${}_{A}\delta_{C}$  and  ${}_{A'}\delta'_{C'}$ , let  $\delta \oplus \delta' \in \mathbb{E}(C \oplus C', A \oplus A')$  be the element corresponding to  $(\delta, 0, 0, \delta')$  through the natural isomorphism  $\mathbb{E}(C \oplus C', A \oplus A') \simeq \mathbb{E}(C, A) \oplus \mathbb{E}(C', A') \oplus \mathbb{E}(C', A) \oplus \mathbb{E}(C', A')$ .

For any  $a \in \mathcal{C}(A, A')$  and  $c \in \mathcal{C}(C', C)$ ,  $\mathbb{E}(C, a)(\delta) \in \mathbb{E}(C, A')$  and  $\mathbb{E}(c, A)(\delta) \in \mathbb{E}(C', A)$  are simply denoted by  $a_*\delta$  and  $c^*\delta$ , respectively.

Let  ${}_{A}\delta_{C}$  and  ${}_{A'}\delta'_{C'}$  be any pair of  $\mathbb{E}$ -extensions. A morphism (a,c):  $\delta \to \delta'$  of extensions is a pair of morphisms  $a \in \mathscr{C}(A,A')$  and  $c \in \mathscr{C}(C,C')$  in  $\mathscr{C}$ , satisfying the equality  $a_*\delta = c^*\delta'$ .

**Definition 2.1.** [HLN, Definition 2.7] Let  $\mathbf{C}_{\mathscr{C}}$  be the category of complexes in  $\mathscr{C}$ . As its full subcategory, define  $\mathbf{C}_{\mathscr{C}}^{n+2}$  to be the category of complexes in  $\mathscr{C}$  whose components are zero in the degrees outside of  $\{0,1,\ldots,n+1\}$ . Namely, an object in  $\mathbf{C}_{\mathscr{C}}^{n+2}$  is a complex  $X^{\:\raisebox{3.5pt}{\text{\circle*{1.5}}}} = \{X_i,d_i^X\}$  of the form

$$X_0 \xrightarrow{d_0^X} X_1 \xrightarrow{d_1^X} \cdots \xrightarrow{d_{n-1}^X} X_n \xrightarrow{d_n^X} X_{n+1}.$$

We write a morphism  $f^*: X^* \to Y^*$  simply  $f^* = (f^0, f^1, \dots, f^{n+1})$ , only indicating the terms of degrees  $0, \dots, n+1$ .

**Definition 2.2.** [HLN, Definition 2.11] By Yoneda lemma, any extension  $\delta \in \mathbb{E}(C, A)$  induces natural transformations

$$\delta_{\sharp} \colon \mathscr{C}(-,C) \Rightarrow \mathbb{E}(-,A) \text{ and } \delta^{\sharp} \colon \mathscr{C}(A,-) \Rightarrow \mathbb{E}(C,-).$$

For any  $X \in \mathscr{C}$ , these  $(\delta_{\sharp})_X$  and  $\delta_X^{\sharp}$  are given as follows.

- $(1) \ (\delta_{\sharp})_X \colon \mathscr{C}(X,C) \to \mathbb{E}(X,A) \ \colon \ f \mapsto f^*\delta.$
- (2)  $\delta_X^{\sharp} : \mathscr{C}(A, X) \to \mathbb{E}(C, X) : g \mapsto g_* \delta.$

We simply denote  $(\delta_{\sharp})_X(f)$  and  $\delta_X^{\sharp}(g)$  by  $\delta_{\sharp}(f)$  and  $\delta^{\sharp}(g)$ , respectively.

**Definition 2.3.** [HLN, Definition 2.9] Let  $\mathscr{C}, \mathbb{E}, n$  be as before. Define a category  $\mathbb{E} := \mathbb{E}^{n+2}_{(\mathscr{C},\mathbb{E})}$  as follows.

(1) A pair  $\langle X^{\bullet}, \delta \rangle$  is an object of the category  $\mathbb{E}$  with  $X^{\bullet} \in \mathbf{C}_{\mathscr{L}}^{n+2}$  and  $\delta \in \mathbb{E}(X_{n+1}, X_0)$ , called an  $\mathbb{E}$ -attached complex of length n+2, if it satisfies

$$(d_0^X)_*\delta = 0$$
 and  $(d_n^X)^*\delta = 0$ .

We also denote it by

$$X_0 \xrightarrow{d_0^X} X_1 \xrightarrow{d_1^X} \cdots \xrightarrow{d_{n-2}^X} X_{n-1} \xrightarrow{d_{n-1}^X} X_n \xrightarrow{d_n^X} X_{n+1} \xrightarrow{\delta} .$$

(2) For such pairs  $\langle X^{\bullet}, \delta \rangle$  and  $\langle Y^{\bullet}, \rho \rangle$ ,  $f^{\bullet} : \langle X^{\bullet}, \delta \rangle \to \langle Y^{\bullet}, \rho \rangle$  is defined to be a morphism in  $\mathbb{E}$  if it satisfies  $(f_0)_*\delta = (f_{n+1})^*\rho$ .

**Definition 2.4.** [HLN, Definition 2.13] An *n*-exangle is an object  $\langle X^{\bullet}, \delta \rangle$  in Æ that satisfies the listed conditions.

(1) The following sequence of functors  $\mathscr{C}^{op} \to \mathsf{Ab}$  is exact.

$$\mathscr{C}(-,X_0) \xrightarrow{\mathscr{C}(-,\ d_0^X)} \cdots \xrightarrow{\mathscr{C}(-,\ d_n^X)} \mathscr{C}(-,X_{n+1}) \xrightarrow{\delta_{\sharp}} \mathbb{E}(-,X_0)$$

(2) The following sequence of functors  $\mathscr{C} \to \mathsf{Ab}$  is exact.

$$\mathscr{C}(X_{n+1},-) \xrightarrow{\mathscr{C}(d_n^X,-)} \cdots \xrightarrow{\mathscr{C}(d_0^X,-)} \mathscr{C}(X_0,-) \xrightarrow{\delta^{\sharp}} \mathbb{E}(X_{n+1},-)$$

In particular any n-example is an object in  $\mathbb{E}$ . A morphism of n-examples simply means a morphism in  $\cancel{E}$ . Thus n-exangles form a full subcategory of  $\cancel{E}$ .

**Definition 2.5.** [HLN, Definition 2.22] Let \$\sigma\$ be a correspondence which associates a homotopic equivalence class  $\mathfrak{s}(\delta) = [{}_{A}X_{C}^{\bullet}]$  to each extension  $\delta = {}_{A}\delta_{C}$ . Such  $\mathfrak{s}$  is called a realization of  $\mathbb{E}$  if it satisfies the following condition for any  $\mathfrak{s}(\delta) = [X^*]$  and any  $\mathfrak{s}(\rho) = [Y^*]$ .

(R0) For any morphism of extensions (a,c):  $\delta \to \rho$ , there exists a morphism  $f^{\:\raisebox{3.5pt}{\text{\circle*{1.5}}}} \in \mathbf{C}^{n+2}_{\mathscr{C}}(X^{\:\raisebox{3.5pt}{\text{\circle*{1.5}}}},Y^{\:\raisebox{3.5pt}{\text{\circle*{1.5}}}})$  of the form  $f^{\bullet} = (a, f_1, \dots, f_n, c)$ . Such  $f^{\bullet}$  is called a *lift* of (a, c).

In such a case, we simple say that "X' realizes  $\delta$ " whenever they satisfy  $\mathfrak{s}(\delta) = [X']$ .

Moreover, a realization  $\mathfrak{s}$  of  $\mathbb{E}$  is said to be *exact* if it satisfies the following conditions.

- (R1) For any  $\mathfrak{s}(\delta) = [X^{\bullet}]$ , the pair  $\langle X^{\bullet}, \delta \rangle$  is an *n*-example.
- (R2) For any  $A \in \mathcal{C}$ , the zero element  $A_{00} = 0 \in \mathbb{E}(0, A)$  satisfies

$$\mathfrak{s}(A_0) = [A \xrightarrow{\mathrm{id}_A} A \to 0 \to \cdots \to 0 \to 0].$$

Dually,  $\mathfrak{s}({}_{0}0_{A}) = [0 \to 0 \to \cdots \to 0 \to A \xrightarrow{\mathrm{id}_{A}} A]$  holds for any  $A \in \mathscr{C}$ .

Note that the above condition (R1) does not depend on representatives of the class  $[X^*]$ .

**Definition 2.6.** [HLN, Definition 2.23] Let  $\mathfrak{s}$  be an exact realization of  $\mathbb{E}$ .

- (1) An n-exangle  $\langle X^*, \delta \rangle$  is called an  $\mathfrak{s}$ -distinguished n-exangle if it satisfies  $\mathfrak{s}(\delta) = [X^*]$ . We often simply say  $distinguished\ n\text{-}exangle\ \text{when}\ \mathfrak s$  is clear from the context.
- (2) An object  $X^{\bullet} \in \mathbb{C}^{n+2}_{\mathscr{C}}$  is called an  $\mathfrak{s}$ -conflation or simply a conflation if it realizes some extension  $\delta \in \mathbb{E}(X_{n+1}, X_0).$
- (3) A morphism f in  $\mathscr{C}$  is called an  $\mathfrak{s}$ -inflation or simply an inflation if it admits some conflation
- X ∈ C<sub>C</sub><sup>n+2</sup> satisfying d<sub>X</sub><sup>0</sup> = f.
  (4) A morphism g in C is called an \$\\$-deflation\$ or simply a deflation if it admits some conflation X ∈ C<sub>C</sub><sup>n+2</sup> satisfying d<sub>X</sub><sup>n</sup> = g.

**Definition 2.7.** [HLN, Definition 2.27] For a morphism  $f^{\bullet} \in \mathbf{C}^{n+2}_{\mathscr{C}}(X^{\bullet}, Y^{\bullet})$  satisfying  $f^{0} = \mathrm{id}_{A}$  for some  $A = X_{0} = Y_{0}$ , its mapping cone  $M_{f}^{\bullet} \in \mathbf{C}^{n+2}_{\mathscr{C}}$  is defined to be the complex

$$X_1 \xrightarrow{d_0^{M_f}} X_2 \oplus Y_1 \xrightarrow{d_1^{M_f}} X_3 \oplus Y_2 \xrightarrow{d_2^{M_f}} \cdots \xrightarrow{d_{n-1}^{M_f}} X_{n+1} \oplus Y_n \xrightarrow{d_n^{M_f}} Y_{n+1}$$

where 
$$d_0^{M_f} = \begin{bmatrix} -d_1^X \\ f_1 \end{bmatrix}$$
,  $d_i^{M_f} = \begin{bmatrix} -d_{i+1}^X & 0 \\ f_{i+1} & d_i^Y \end{bmatrix}$   $(1 \le i \le n-1)$ ,  $d_n^{M_f} = \begin{bmatrix} f_{n+1} & d_n^Y \end{bmatrix}$ .

The mapping cocone is defined dually, for morphisms  $h^{\bullet}$  in  $\mathbb{C}_{\mathscr{C}}^{n+2}$  satisfying  $h_{n+1} = \mathrm{id}$ .

**Definition 2.8.** [HLN, Definition 2.32] An *n-exangulated category* is a triplet  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  of additive category  $\mathscr{C}$ , additive bifunctor  $\mathbb{E} \colon \mathscr{C}^{\mathrm{op}} \times \mathscr{C} \to \mathsf{Ab}$ , and its exact realization  $\mathfrak{s}$ , satisfying the following conditions.

- (EA1) Let  $A \xrightarrow{f} B \xrightarrow{g} C$  be any sequence of morphisms in  $\mathscr{C}$ . If both f and g are inflations, then so is  $g \circ f$ . Dually, if f and g are deflations, then so is  $g \circ f$ .
- (EA2) For  $\rho \in \mathbb{E}(D, A)$  and  $c \in \mathscr{C}(C, D)$ , let  ${}_A\langle X^{\:\raisebox{3.5pt}{\text{\circle*{1.5}}}}, c^*\rho\rangle_C$  and  ${}_A\langle Y^{\:\raisebox{3.5pt}{\text{\circle*{1.5}}}}, \rho\rangle_D$  be distinguished n-exangles. Then  $(\mathrm{id}_A, c)$  has a  $good\ lift\ f^{\:\raisebox{3.5pt}{\text{\circle*{1.5}}}}$ , in the sense that its mapping cone gives a distinguished n-exangle  $\langle M_f^{\:\raisebox{3.5pt}{\text{\circle*{1.5}}}}, (d_0^X)_*\rho\rangle$ .

(EA2°) Dual of (EA2).

Note that the case n = 1, a triplet  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  is a 1-exangulated category if and only if it is an extriangulated category, see [HLN, Proposition 4.3].

**Example 2.9.** From [HLN, Proposition 4.34] and [HLN, Proposition 4.5], we know that n-exact categories and (n + 2)-angulated categories are n-exangulated categories. There are some other examples of n-exangulated categories which are neither n-exact nor (n + 2)-angulated, see [HLN, LZ1, HZZ1].

**Lemma 2.10.** [HLN, Proposition 3.6] Let  ${}_{A}\langle X^{\centerdot}, \delta \rangle_{C}$  and  ${}_{B}\langle Y^{\centerdot}, \rho \rangle_{D}$  be distinguished *n*-exangles. Suppose that we are given a commutative square

$$X^{0} \xrightarrow{d_{X}^{0}} X^{1}$$

$$\downarrow a \qquad \qquad \downarrow b$$

$$Y^{0} \xrightarrow{d_{X}^{0}} Y^{1}$$

in  $\mathscr{C}$ . Then there is a morphism  $f^*: \langle X^*, \delta \rangle \to \langle Y^*, \rho \rangle$  which satisfies  $f^0 = a$  and  $f^1 = b$ .

2.2. Right (n+2)-angulated categories. Let  $\mathcal{A}$  be an additive category with an endofunctor  $\Sigma^n$ :  $\mathcal{A} \to \mathcal{A}$ . An (n+2)- $\Sigma^n$ -sequence in  $\mathcal{A}$  is a sequence of morphisms

$$A_0 \xrightarrow{f_0} A_1 \xrightarrow{f_1} A_2 \xrightarrow{f_2} \cdots \xrightarrow{f_{n-1}} A_n \xrightarrow{f_n} A_{n+1} \xrightarrow{f_{n+1}} \Sigma^n A_0.$$

Its *left rotation* is the (n+2)- $\Sigma^n$ -sequence

$$A_1 \xrightarrow{f_1} A_2 \xrightarrow{f_2} A_3 \xrightarrow{f_3} \cdots \xrightarrow{f_n} A_{n+1} \xrightarrow{f_{n+1}} \Sigma^n A_0 \xrightarrow{(-1)^n \Sigma^n f_0} \Sigma^n A_1.$$

A morphism of (n+2)- $\Sigma^n$ -sequences is a sequence of morphisms  $\varphi = (\varphi_0, \varphi_1, \dots, \varphi_{n+1})$  such that the following diagram commutes

$$A_0 \xrightarrow{f_0} A_1 \xrightarrow{f_1} A_2 \xrightarrow{f_2} \cdots \xrightarrow{f_n} A_{n+1} \xrightarrow{f_{n+1}} \Sigma^n A_0$$

$$\downarrow \varphi_0 \qquad \qquad \downarrow \varphi_1 \qquad \qquad \downarrow \varphi_2 \qquad \qquad \downarrow \varphi_{n+1} \qquad \downarrow \Sigma^n \varphi_0$$

$$B_0 \xrightarrow{g_0} B_1 \xrightarrow{g_1} B_2 \xrightarrow{g_2} \cdots \xrightarrow{g_n} B_{n+1} \xrightarrow{g_{n+1}} \Sigma^n B_0$$

where each row is an (n+2)- $\Sigma^n$ -sequence. It is an *isomorphism* if  $\varphi_0, \varphi_1, \varphi_2, \cdots, \varphi_{n+1}$  are all isomorphisms in  $\mathcal{A}$ .

**Definition 2.11.** [L, Definition 2.1] A right (n+2)-angulated category is a triple  $(\mathcal{A}, \Sigma^n, \Theta)$ , where  $\mathcal{A}$  is an additive category,  $\Sigma^n$  is an endofunctor of  $\mathcal{A}$  (which is called the *n*-suspension functor), and  $\Theta$  is a class of (n+2)- $\Sigma^n$ -sequences (whose elements are called right (n+2)-angles), which satisfies the following axioms:

- (RN1) (a) The class  $\Theta$  is closed under isomorphisms, direct sums and direct summands.
  - (b) For each object  $A \in \mathcal{A}$  the trivial sequence

$$0 \to A \xrightarrow{1_A} A \to 0 \to \cdots \to 0 \to 0$$

belongs to  $\Theta$ .

(c) Each morphism  $f_0: A_0 \to A_1$  in  $\mathcal{A}$  can be extended to a right (n+2)-angle:

$$A_0 \xrightarrow{f_0} A_1 \xrightarrow{f_1} A_2 \xrightarrow{f_2} \cdots \xrightarrow{f_{n-1}} A_n \xrightarrow{f_n} A_{n+1} \xrightarrow{f_{n+1}} \Sigma^n A_0.$$

(RN2) If an (n+2)- $\Sigma^n$ -sequence belongs to  $\Theta$ , then its left rotation belongs to  $\Theta$ .


(RN3) Each solid commutative diagram

$$A_{0} \xrightarrow{f_{0}} A_{1} \xrightarrow{f_{1}} A_{2} \xrightarrow{f_{2}} \cdots \xrightarrow{f_{n}} A_{n+1} \xrightarrow{f_{n+1}} \sum^{n} A_{0}$$

$$\downarrow \varphi_{0} \qquad \downarrow \varphi_{1} \qquad \downarrow \varphi_{2} \qquad \qquad \downarrow \qquad \downarrow \varphi_{n+1} \qquad \downarrow \Sigma^{n} \varphi_{0}$$

$$B_{0} \xrightarrow{g_{0}} B_{1} \xrightarrow{g_{1}} B_{2} \xrightarrow{g_{2}} \cdots \xrightarrow{g_{n}} B_{n+1} \xrightarrow{g_{n+1}} \Sigma^{n} B_{0}$$

with rows in  $\Theta$  can be completed to a morphism of (n+2)- $\Sigma^n$ -sequences. (RN4) Given a commutative diagram



whose top rows and second column belong to  $\Theta$ . Then there exist morphisms  $\varphi_i \colon A_i \to B_i$  (i = $2, 3, \dots, n+1$ ),  $\psi_j : B_j \to C_j \ (j=2, 3, \dots, n+1)$  and  $\phi_k : A_k \to C_{k-1} \ (k=3, 4, \dots, n+1)$ with the following two properties:

- (I) The sequence  $(1_{A_1}, \varphi_1, \varphi_2, \cdots, \varphi_{n+1})$  is a morphism of (n+2)- $\Sigma^n$ -sequences.
- (II) The (n+2)- $\Sigma^n$ -sequence

$$A_{2} \xrightarrow{\begin{pmatrix} f_{2} \\ \varphi_{2} \end{pmatrix}} A_{3} \oplus B_{2} \xrightarrow{\begin{pmatrix} -f_{3} & 0 \\ \varphi_{3} & -g_{2} \\ \phi_{3} & \psi_{2} \end{pmatrix}} A_{4} \oplus B_{3} \oplus C_{2} \xrightarrow{\begin{pmatrix} -f_{4} & 0 & 0 \\ -\varphi_{4} & -g_{3} & 0 \\ \phi_{4} & \psi_{3} & h_{2} \end{pmatrix}} A_{5} \oplus B_{4} \oplus C_{3}$$

$$\xrightarrow{\begin{pmatrix} -f_{5} & 0 & 0 \\ \varphi_{5} & -g_{4} & 0 \\ \phi_{5} & \psi_{4} & h_{3} \end{pmatrix}} \cdots \xrightarrow{\begin{pmatrix} -f_{n}} & 0 & 0 \\ (-1)^{n+1}\varphi_{n} & -g_{n-1} & 0 \\ \phi_{n} & \psi_{n-1} & h_{n-2} \end{pmatrix}} A_{n+1} \oplus B_{n} \oplus C_{n-1}$$

$$\xrightarrow{\begin{pmatrix} (-1)^{n+1}\varphi_{n+1} & -g_{n} & 0 \\ \phi_{n+1} & \psi_{n} & h_{n-1} \end{pmatrix}} B_{n+1} \oplus C_{n} \xrightarrow{(\psi_{n+1}, h_{n})} C_{n+1} \xrightarrow{\sum^{n} f_{1} \circ h_{n+1}} \sum^{n} A_{2}$$

belongs to  $\Theta$ , and  $h_{n+1} \circ \psi_{n+1} = \Sigma^n f_0 \circ g_{n+1}$ 

The notion of a left (n+2)-angulated category is defined dually.

If  $\Sigma^n$  is an automorphism, it is easy to see that the converse of an axiom (RN2) also holds, thus the right (n+2)-angulated category  $(\mathcal{A}, \Sigma^n, \Theta)$  is an (n+2)-angulated category in the sense of Geiss-Keller-Oppermann [GKO, Definition 1.1] and in the sense of Bergh-Thaule [BT, Theorem 4.4]. If  $(\mathcal{A}, \Sigma^n, \Theta)$  is a right (n+2)-angulated category,  $(\mathcal{A}, \Omega^n, \Phi)$  is a left (n+2)-angulated category,  $\Omega^n$  is a quasi-inverse of  $\Sigma^n$  and  $\Theta = \Phi$ , then  $(\mathcal{A}, \Sigma^n, \Theta)$  is an (n+2)-angulated category.

3. Right (n+2)-angulated categories with right semi-equivalences

We first introduce the concept of right semi-equivalence in a right (n+2)-angulated category.

**Definition 3.1.** Let  $(C, \Sigma, \Theta)$  be a *right* (n+2)-angulated category. The endofunctor  $\Sigma$  is called a right semi-equivalence if it satisfies the following conditions:

- (1)  $\Sigma$  is full;
- (2)  $\Sigma$  is faithful;
- (3)  $\Sigma$  is right dense, that is, for any morphism  $u:U\to TV$ , there exists a right (n+2)-angle

$$V \to U_1 \to U_2 \to \cdots \to U_n \to U \xrightarrow{u} \Sigma V.$$

**Remark 3.2.** Let  $(\mathcal{C}, \Sigma, \Theta)$  be a right triangulated category. We recalled the notion of right semi-equivalence was introduced in [ABM]. The suspension functor  $\Sigma$  is called right dense if for any right triangle of the form  $A \xrightarrow{u} \Sigma B \xrightarrow{v} C' \xrightarrow{w} \Sigma A$ , there exists  $C \in \mathcal{C}$  such that  $C' \cong \Sigma C$ . The suspension functor  $\Sigma$  is called a right semi-equivalence if it is full, faithful and right dense. In fact, if n = 1, then Definition 3.1 coincides with the definition of right semi-equivalence of right triangulated category in [ABM].

*Proof.* Let  $(C, \Sigma, \Theta)$  be a right triangulated category and  $\Sigma$  be fully faithful. We only need to show that  $\Sigma$  is right semi-equivalence if and only if for any morphism  $u: U \to \Sigma V$ , there exists a right triangle  $V \xrightarrow{v} W \xrightarrow{w} U \xrightarrow{u} \Sigma V$ .

"⇒" See the proof of Corollary 1.7 in [ABM].

" $\Leftarrow$ " For any right triangle of the form  $U \xrightarrow{u} \Sigma V \xrightarrow{v'} W' \xrightarrow{w'} \Sigma U$ , there exists a right triangle  $V \xrightarrow{f} M \xrightarrow{g} U \xrightarrow{u} \Sigma V$  by assumption. By (RTR2), we have that  $U \xrightarrow{u} \Sigma V \xrightarrow{-\Sigma f} \Sigma M \xrightarrow{-\Sigma g} \Sigma U$  is a right triangle. By (RTR4), we have the following commutative diagram

$$U \xrightarrow{u} \Sigma V \xrightarrow{v'} W' \xrightarrow{w'} \Sigma U$$

$$\parallel \qquad \qquad \parallel \qquad \qquad \parallel \qquad \qquad \parallel \qquad \qquad \parallel$$

$$U \xrightarrow{u} \Sigma V \xrightarrow{-\Sigma f} \Sigma M \xrightarrow{-\Sigma g} \Sigma U$$

where the rows are right triangle in  $\mathcal{C}$ . By Corollary 1.5 in [ABM], we have that h is an isomorphism. This shows that  $\Sigma$  is right dense. Moreover,  $\Sigma$  is right semi-equivalence.

**Remark 3.3.** Similarly, for a *left* (n+2)-angulated category, we can define left semi-equivalence.

**Example 3.4.** A (n + 2)-angulated category is a right (n + 2)-angulated category with right semi-equivalence. But the opposite is not necessarily true. A non-trivial example of a right (n + 2)-angulated category with right semi-equivalence, see Theorem 3.12.

Now we give some examples of right triangulated categories with right semi-equivalences, These examples come from [ABM, Sections 3.1-3.4], one also can see [Z].

**Example 3.5.** (a) Let A be a finite dimensional k-algebra, where k is a commutative ring. We define

$$\Lambda = \begin{bmatrix} A_0 & & 0 & \\ Q_0 & A_1 & & \\ & Q_1 & A_1 & \\ 0 & & \ddots & \ddots \end{bmatrix},$$

where lower triangular matrices have only finitely many non-zero coefficients,  $A_i = A, Q_i = DA = \operatorname{Hom}_k(A,k)$  (with its canonical A-A-bimodule structure) for all  $i \geq 0$ , addition is the usual addition of matrices and multiplication is induced from the bimodule structure of DA and the zero morphism  $DA \otimes_A DA \to 0$ . Then the stable module category  $\overline{\operatorname{mod}}\Lambda$  is a right triangulated category, whose suspension functor is a right semi-equivalence. But the stable module category  $\overline{\operatorname{mod}}\Lambda$  is not a triangulated category.

(b) If A is an APR-iterated tilted algebra over an algebraically closed field, then the full subcategory  $\mathcal{H} = \mathcal{H}^{-1}(A)$  of  $K^b(\text{proj}A)$  consisting of the complexes having vanishing cohomology in the positive indices is a right triangulated category, whose suspension functor is a right semi-equivalence. But  $\mathcal{H} = \mathcal{H}^{-1}(A)$  is not a triangulated category.

- (c) Let  $\mathscr{C}$  be a k-abelian category, where k is a commutative ring, and  $\mathscr{Y}, \mathscr{X}$  be two k-linear subcategory of  $\mathscr{C}$ . Then  $\mathscr{Y}$  is said to be  $\mathscr{X}$ -coresolving [AS] if it satisfies:
  - (i)  $\mathscr{Y}$  contain  $\mathscr{X}$ ;
  - (ii) If  $0 \to A \to B \to C \to 0$  is  $\mathscr{X}$ -exact, with  $A, B \in \mathscr{Y}$ , then  $C \in \mathscr{Y}$ ;
  - (iii) If  $0 \to A \to B \to C \to 0$  is  $\mathscr{X}$ -exact, with  $A, C \in \mathscr{Y}$ , then  $B \in \mathscr{Y}$ .

Assume that A is  $\mathscr{X}$ -coresolving, each  $\mathscr{X}$ -monic in  $\mathscr{Y}$  is a monomorphism and every object in  $\mathscr X$  is  $\mathscr X$ -projective. Then the stable category  $\mathscr Y/\mathscr X$  is a right triangulated category, whose suspension functor is a right semi-equivalence. But  $\mathscr{Y}/\mathscr{X}$  is not a triangulated category.

Let  $\mathscr C$  be an additive category and  $\mathscr X$  a subcategory of  $\mathscr C$ . Recall that we say a morphism  $f\colon A\to B$ in  $\mathscr{C}$  is an  $\mathscr{X}$ -monic if

$$\mathscr{C}(f,X)\colon\mathscr{C}(B,X)\to\mathscr{C}(A,X)$$

is an epimorphism for all  $X \in \mathcal{X}$ . We say that f is an  $\mathcal{X}$ -epic if

$$\mathscr{C}(X, f) \colon \mathscr{C}(X, A) \to \mathscr{C}(X, B)$$

is an epimorphism for all  $X \in \mathcal{X}$ . Similarly, we say that f is a left  $\mathcal{X}$ -approximation of B if f is an  $\mathscr{X}$ -monic and  $A \in \mathscr{X}$ . We say that f is a right  $\mathscr{X}$ -approximation of A if f is an  $\mathscr{X}$ -epic and  $B \in \mathscr{X}$ .

We denote by  $\mathscr{C}/\mathscr{X}$  the category whose objects are objects of  $\mathscr{C}$  and whose morphisms are elements of  $\operatorname{Hom}_{\mathscr{C}}(A,B)/\mathscr{X}(A,B)$  for  $A,B\in\mathscr{C}$ , where  $\mathscr{X}(A,B)$  is the subgroup of  $\operatorname{Hom}_{\mathscr{C}}(A,B)$  consisting of morphisms which factor through an object in  $\mathscr{X}$ . Such category is called the (additive) quotient category of  $\mathscr C$  by  $\mathscr X$ . For any morphism  $f\colon A\to B$  in  $\mathscr C$ , we denote by  $\overline f$  the image of f under the natural quotient functor  $\mathscr{C} \to \mathscr{C}/\mathscr{X}$ .

**Definition 3.6.** [LZ1, Definition 3.1] Let  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  be an *n*-exangulated category. A subcategory  $\mathscr{X}$  of  $\mathscr{C}$  is called strongly contravariantly finite, if for any object  $C \in \mathscr{C}$ , there exists a distinguished n-exangle

$$B \to X_1 \to X_2 \to \cdots \to X_{n-1} \to X_n \xrightarrow{g} C \dashrightarrow$$

where g is a right  $\mathscr{X}$ -approximation of C and  $X_i \in \mathscr{X}$ . Dually we can define strongly covariantly finite subcategory.

A strongly contravariantly finite and strongly covariantly finite subcategory is called strongly functorially finite.

Construction 3.7. Assume that  $\mathscr{X}$  is a strongly covariantly finite subcategory of an n-exangulated category  $\mathscr{C}$ .

**Step 1:** For any object  $A \in \mathcal{C}$ , take a distinguished *n*-exangle

$$A \xrightarrow{f} X_1 \to X_2 \to \cdots \to X_n \to X_{n+1} \xrightarrow{\delta},$$

where f is a left  $\mathscr{X}$ -approximation of A and  $X_1, X_2, \cdots, X_{n-1}, X_n \in \mathscr{X}$ . Define  $\mathbb{G}(A) = \mathbb{G}A$  to be the image of  $X_{n+1}$  in  $\mathscr{C}/\mathscr{X}$ .

For any morphism  $a \in \mathscr{C}(A,A')$ , since f is a left  $\mathscr{X}$ -approximation of A and  $X'_1 \in \mathscr{X}$ , we can complete the following commutative diagram:

For any morphism  $\bar{a} \in (\mathscr{C}/\mathscr{X})(A, A')$ , define  $\mathbb{G}\bar{a}$  to be the image  $\bar{b}$  of b in  $\mathscr{C}/\mathscr{X}$ .

It is not difficult to see that the endofunctor  $\mathbb{G}: \mathscr{C}/\mathscr{X} \to \mathscr{C}/\mathscr{X}$  is well defined.

Step 2: Let

$$A_0 \xrightarrow{\alpha_0} A_1 \xrightarrow{\alpha_1} A_2 \to \cdots \to A_n \xrightarrow{\alpha_n} A_{n+1} \xrightarrow{\eta}$$

is a distinguished n-exangle in  $\mathscr{C}$ , where  $\alpha_0$  is  $\mathscr{X}$ -monomorphism. It follows that there exists the following commutative diagram of distinguished n-exangles

We define

$$A_0 \xrightarrow{\overline{\alpha_0}} A_1 \xrightarrow{\overline{\alpha_1}} A_2 \xrightarrow{\overline{\alpha_2}} \cdots \xrightarrow{\overline{\alpha_n}} A_{n+1} \xrightarrow{\overline{\alpha_{n+1}}} \mathbb{C} A_0$$

to be a standard right (n+2)-angle in  $\mathscr{C}/\mathscr{X}$ .

We define

$$\Theta = \{X^* | X^* \text{ is an } (n+2) - \mathbb{G} \text{-sequence with } X^* \oplus Y^* \cong Z^*, \text{ where } Y^* \text{ is an } X^* \oplus X^* \oplus X^* \cong Z^* \}$$

(n+2)- $\mathbb{G}$ -sequence and  $Z^*$  is a standard right (n+2)-angle $\}$ .

**Lemma 3.8.** Let  $\mathscr{C}$  be an n-exangulated category and  $\mathscr{X}$  is a strongly covariantly finite subcategory of  $\mathscr{C}$ . Then the quotient category  $\mathscr{C}/\mathscr{X}$  is a right (n+2)-angulated category with the endofunctor  $\mathbb{G}$  and right (n+2)-angles defined in Construction 3.7.

*Proof.* Since the proof is very similar to [ZW, Theorem 3.11], we omit it. Moreover, one also can see [LZ2, Lemma 3.2].  $\Box$ 

Lemma 3.9. [ZW, Lemma 3.3] Let

$$X_{0} \xrightarrow{f_{0}} X_{1} \xrightarrow{f_{1}} X_{2} \xrightarrow{f_{2}} \cdots \longrightarrow X_{n} \xrightarrow{f_{n}} X_{n+1} - \xrightarrow{\delta} >$$

$$\downarrow a_{0} \qquad \downarrow a_{1} \qquad \downarrow a_{2} \qquad \qquad \downarrow a_{n} \qquad \downarrow a_{n+1}$$

$$Y_{0} \xrightarrow{g_{0}} Y_{1} \xrightarrow{g_{1}} Y_{2} \xrightarrow{g_{2}} \cdots \longrightarrow Y_{n} \xrightarrow{g_{n}} Y_{n+1} - \xrightarrow{\eta} >$$

be any morphism of distinguished *n*-examples. Then  $a_0$  factors through  $f_0$  if and only if  $a_{n+1}$  factors through  $g_n$  if and only if  $(a_0)_*\delta = (a_{n+1})^*\eta = 0$ .

**Definition 3.10.** [ZW, Definition 3.14] Let  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  be an *n*-exangulated category.

(1) An object  $P \in \mathscr{C}$  is called *projective* if, for any distinguished n-exangle

$$A_0 \xrightarrow{\alpha_0} A_1 \xrightarrow{\alpha_1} A_2 \xrightarrow{\alpha_2} \cdots \xrightarrow{\alpha_{n-2}} A_{n-1} \xrightarrow{\alpha_{n-1}} A_n \xrightarrow{\alpha_n} A_{n+1} \xrightarrow{\delta}$$

and any morphism c in  $\mathscr{C}(P, A_{n+1})$ , there exists a morphism  $b \in \mathscr{C}(P, A_n)$  satisfying  $\alpha_n \circ b = c$ . We denote the full subcategory of projective objects in  $\mathscr{C}$  by  $\mathcal{P}$ . Dually, the full subcategory of injective objects in  $\mathscr{C}$  is denoted by  $\mathcal{I}$ .

(2) We say that  $\mathscr{C}$  has enough projectives if for any object  $C \in \mathscr{C}$ , there exists a distinguished n-exangle

$$B \xrightarrow{\alpha_0} P_1 \xrightarrow{\alpha_1} P_2 \xrightarrow{\alpha_2} \cdots \xrightarrow{\alpha_{n-2}} P_{n-1} \xrightarrow{\alpha_{n-1}} P_n \xrightarrow{\alpha_n} C \xrightarrow{\delta}$$

satisfying  $P_1, P_2, \dots, P_n \in \mathcal{P}$ . We can define the notion of having *enough injectives* dually.

**Lemma 3.11.** [LZ1, Lemma 4.3] Let  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  be an *n*-exangulated category and  $\mathscr{X}$  be a subcategory of  $\mathscr{C}$ . For each pair of objects A and C in  $\mathscr{C}$ , define

$$\mathbb{F}^{\mathscr{X}}(C,A) = \{A_0 \xrightarrow{f} A_1 \to A_2 \to \cdots \to A_{n-1} \to A_n \to A_{n+1} \xrightarrow{\delta} | f \text{ is an } \mathscr{X}\text{-monic}\}.$$

Then  $(\mathscr{C}, \mathbb{F}^{\mathscr{X}}, \mathfrak{s}_{\mathbb{F}^{\mathscr{X}}})$  is an *n*-exangulated category.

Dually, we define for each pair of objects A and C in  $\mathscr{C}$ 

$$\mathbb{F}_{\mathscr{X}}(C,A) = \{A_0 \to A_1 \to A_2 \to \cdots \to A_{n-1} \to A_n \xrightarrow{g} A_{n+1} \xrightarrow{\delta} | g \text{ is an } \mathscr{X}\text{-epic}\}.$$

Then  $(\mathscr{C}, \mathbb{F}_{\mathscr{X}}, \mathfrak{s}_{\mathbb{F}_{\mathscr{X}}})$  is an *n*-exangulated category.

We denote the full subcategory of projective objects in  $(\mathscr{C}, \mathbb{F}^{\mathscr{X}}, \mathfrak{s}_{\mathbb{F}^{\mathscr{X}}})$  by  $\operatorname{Proj}_{\mathbb{F}^{\mathscr{X}}}\mathscr{C}$ . Our first main result is the following.

**Theorem 3.12.** Let  $\mathscr C$  be an n-exangulated category and  $\mathscr X$  be a strongly covariantly finite subcategory of  $\mathscr C$ . Then

- (1) The quotient category  $\mathscr{C}/\mathscr{X}$  is a right (n+2)-angulated category whose suspension functor  $\mathbb{G}$  is right dense;
- (2) If  $\mathscr{X} \subset \operatorname{Proj}_{\mathbb{F}^{\mathscr{X}}}\mathscr{C}$ , then  $\mathbb{G}$  is right semi-equivalence.

*Proof.* (1) By Lemma 3.8, we know that  $\mathscr{C}/\mathscr{X}$  is a right (n+2)-angulated category. Now we show that  $\mathbb{G}$  is right semi-equivalence.

For any morphism  $\bar{u}: U \to \mathbb{G}V$  in  $\mathscr{C}/\mathscr{X}$ , since  $\mathscr{X}$  is a strongly covariantly finite subcategory of  $\mathscr{C}$ , there exists a distinguished n-example

$$V \xrightarrow{f_0} X_1 \xrightarrow{f_1} X_2 \to \cdots \to X_n \xrightarrow{f_n} \mathbb{G}V \xrightarrow{\eta}$$

where  $f_0$  is a left  $\mathscr{X}$ -approximation of V and  $X_1, X_2, \dots, X_n \in \mathscr{X}$ . By (EA2), we can observe that  $(\mathrm{id}_V, u)$  has a good lift  $f^{\bullet} = (\mathrm{id}_V, h_1, \dots, h_n, u)$ , that is, we have the commutative diagram

of distinguished n-exangles. We claim that  $g_0$  is an  $\mathscr{X}$ -monic. Indeed, let  $a:V\to X$  be any morphism with  $X\in\mathscr{X}$ . Since  $f_0$  is a left  $\mathscr{X}$ -approximation, there exists a morphism  $b:X_1\to X$  such that  $a=bf_0$  and then  $a=bh_1g_0$ . This shows that  $g_0$  is an  $\mathscr{X}$ -monic. Thus we have

$$V \xrightarrow{\overline{g_0}} A_1 \xrightarrow{\overline{g_1}} A_2 \xrightarrow{\overline{g_2}} \cdots \to A_n \xrightarrow{\overline{g_n}} U \xrightarrow{\overline{u}} \mathbb{G}V$$

is a right (n+2)-angle in  $\mathscr{C}/\mathscr{X}$  by Construction 3.7, hence  $\mathbb{G}$  is right dense.

(2) We only need to show that  $\mathbb{G}$  is fully faithful by (1).

Let  $\bar{u}: U \to V$  be a morphism in  $\mathscr{C}/\mathscr{X}$  with  $\mathbb{G}\bar{u} = 0$ . We have the commutative diagram of distinguished n-exangles

Where  $f_u$  and  $f_v$  are left  $\mathscr{X}$ -approximation,  $X_1, X_2, \dots, X_n$ ;  $X_1', X_2', \dots, X_n' \in \mathscr{X}$ . Since  $\bar{u'} = \mathbb{G}\bar{u} = 0$ , there exists  $v: X \to \mathbb{G}V$  and  $w: \mathbb{G}U \to X$  such that u' = vw with  $X \in \mathscr{X}$ . Since  $X \in \operatorname{Proj}_{\mathbb{F}\mathscr{X}}\mathscr{C}$ , there exists  $w': X \to X_n'$  such that  $v = g_v w'$ , that is, we have the commutative diagram

$$V \xrightarrow{f_{v}} X'_{1} \xrightarrow{g'_{1}} X'_{2} \xrightarrow{g'_{2}} \cdots \xrightarrow{g'_{n-1}} X'_{n} \xrightarrow{g_{v}} \mathbb{G}V - \xrightarrow{\delta'} > .$$

Therefore  $u' = vw = g_v w' w$  and u' factors through  $g_v$ . By Lemma 3.9, we get u factors through  $f_u$ , hence  $\bar{u} = 0$ . This shows that  $\mathbb{G}$  is faithful.

To prove that  $\mathbb{G}$  is full, let  $\bar{u}: \mathbb{G}U \to \mathbb{G}V$  be a morphism in  $\mathscr{C}/\mathscr{X}$ . Since  $\mathscr{X} \subset \operatorname{Proj}_{\mathbb{F}\mathscr{X}}\mathscr{C}$ , We have the commutative diagram of distinguished *n*-exangles by the dual of Lemma 2.10

Where  $f_u$  and  $f_v$  are left  $\mathscr{X}$ -approximation,  $X_1, X_2, \cdots, X_n$ ;  $X_1', X_2', \cdots, X_n' \in \mathscr{X}$ . Thus  $\bar{u} = \mathbb{G}\bar{u}'$  by Construction 3.7.

As a special case of Theorem 3.12 when n = 1, we have the following.

Corollary 3.13. [T, Lemma 3.3] Let  $\mathscr{C}$  be an extriangulated category and  $\mathscr{X}$  be a covariantly finite subcategory of  $\mathscr{C}$ . If  $\mathscr{X} \subset \operatorname{Proj}_{\mathbb{F}^{\mathscr{X}}}\mathscr{C}$ , then the quotient category  $\mathscr{C}/\mathscr{X}$  is a right triangulated category with right semi-equivalence.

4. On the relation n-exangulated category and right (n+2)-angulated category

**Definition 4.1.** Let  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  be an *n*-exangulated category and X be any object in  $\mathscr{C}$ . The morphism  $X \to 0$  is called *trivial inflation* if it can be embedded in a distinguished *n*-exangle

$$X \to 0 \to 0 \to \cdots \to 0 \to Y \dashrightarrow$$
.

Dually the morphism  $0 \to X$  is called trivial deflation if it can be embedded in a distinguished n-exangle

$$Z \to 0 \to 0 \to \cdots \to 0 \to X \dashrightarrow$$
.

**Remark 4.2.** In extriangulated categories, note that the inflation and the trivial inflation are the same, and the deflation and the trivial deflation are the same.

Our second main result is the following.

**Theorem 4.3.** Let  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  be an *n*-exangulated category. Then the following statements are equivalent.

- (1) There exists a fully faithful additive endofunctor  $\Sigma: \mathscr{C} \to \mathscr{C}$  such that for any morphism  $u: U \to \Sigma V$ , there exists a distinguished n-example  $V \to U_1 \to U_2 \to \cdots \to U_n \to U \dashrightarrow$ . Moreover,  $\mathbb{E}(-,-) \cong \mathscr{C}(-,\Sigma-)$ .
- (2) For any object  $C \in \mathcal{C}$ , the morphism  $C \to 0$  is a trivial inflation.
- (3) There is a right (n+2)-angulation of  $\mathscr C$  which induces the *n*-exangulated category structure  $(\mathscr C, \mathbb E, \mathfrak s)$ .

*Proof.* (1)  $\Rightarrow$  (2) We claim that for any  $C \in \mathscr{C}$ , the morphism  $1_{\Sigma C} \in \mathscr{C}(\Sigma C, \Sigma C) \cong \mathbb{E}(\Sigma C, C)$  is realised by the distinguished *n*-exangle

$$C \to 0 \to 0 \to \cdots \to 0 \to \Sigma C \dashrightarrow$$

Indeed, Let  $\mathfrak{s}(1_{\Sigma C}) = [C \to E_1 \to E_2 \to \cdots \to E_n \to \Sigma C]$ , then we have two exact sequence by Definition 2.4

$$\mathscr{C}(-,C) \to \mathscr{C}(-,E_1) \to \cdots \to \mathscr{C}(-,\Sigma C) \xrightarrow{(1_{\Sigma C})_{\sharp} = \mathrm{id}} \mathbb{E}(-,C) \cong \mathscr{C}(-,\Sigma C);$$

$$\mathscr{C}(\Sigma C, -) \to \mathscr{C}(E_n, -) \to \cdots \to \mathscr{C}(C, -) \xrightarrow{(1_{\Sigma C})^{\sharp} = \Sigma} \mathbb{E}(\Sigma C, -) \cong \mathscr{C}(\Sigma C, \Sigma -).$$

Since  $\Sigma$  is faithful, then  $(1_{\Sigma C})_{\sharp}$  and  $(1_{\Sigma C})^{\sharp}$  are monomorphic. That is to say  $C \to 0 \to 0 \to \cdots \to 0 \to \Sigma C \dashrightarrow$  is a n-example. Thus  $C \to E_1 \to E_2 \to \cdots \to E_n \to \Sigma C \dashrightarrow$  is homotopically equivalent to the object  $C \to 0 \to 0 \to \cdots \to 0 \to \Sigma C \dashrightarrow$  by [HLN, Proposition 3.1]. This shows  $C \to 0$  is a trivial inflation.

 $(2) \Rightarrow (1)$  For any object  $C \in \mathscr{C}$ , since the morphism  $C \to 0$  is a trivial inflation, then we have a distinguished n-exangle

$$C \to 0 \to 0 \to \cdots \to 0 \to Y \dashrightarrow$$
.

Notice that  $C \to 0$  is a left 0-approximation of C, then 0 is a strongly covariantly finite subcategory of an n-exangulated category  $\mathscr{C}$ . On the other hand,  $0 \subset \operatorname{Proj}_{\mathbb{F}^{\mathscr{X}}}\mathscr{C}$ . Then  $\mathscr{C} \cong \mathscr{C}/0$  has a right (n+2)-angulated structure  $(\mathscr{C}, \Sigma, \Theta)$  with  $\Sigma$  is right semi-equivalence by Construction 3.7, Lemma 3.8 and Theorem 3.12.

In order to show  $\mathbb{E}(-,-) \cong \mathscr{C}(-,\Sigma-)$ , we define

$$F:\mathscr{C}(C,\Sigma A)\to\mathbb{E}(C,A)$$

$$f \to f^* \delta$$

for any  $A, C \in \mathscr{C}$  and  $\delta_A \in \mathscr{C}(\Sigma A, A)$ . It is not difficult to see that the F is well defined and injective. We only show that F is surjective. Let  $\varepsilon \in \mathbb{E}(C, A)$  be realised by  $A \to A_1 \to A_2 \to \cdots \to A_n \to C$ , we have the commutative diagram

of distinguished n-exangles by Lemma 2.10 and assumption. Thus we have that  $\varepsilon = f^*\delta_A =: F(f)$ .

- $(2) \Rightarrow (3)$  Since  $\mathbb{E}(-,-) \cong \mathscr{C}(-,\Sigma-)$  by (2), then the right (n+2)-angulated structure on  $\mathscr{C}$  of Lemma 3.8 concides with the *n*-exangulated structure of  $\mathscr{C}$ . That is to say, the (n+2)-angulation of  $\mathscr{C}$  (with right semi-equivalence) induces an *n*-exangulation on  $\mathscr{C}$ .
- $(3) \Rightarrow (2)$  Let  $(\mathscr{C}, \Sigma, \Theta)$  be a right (n+2)-angulation of  $\mathscr{C}$ . Then for the morphism  $1_C \colon C \to C$  in  $\mathscr{C}$ , by axioms (RN1) and (RN2), there exists an right (n+2)-angle

$$C \to 0 \to \cdots \to 0 \to \Sigma C \to \Sigma C$$

in  $\Theta$ , we have that

$$C \to 0 \to \cdots \to 0 \to \Sigma C \xrightarrow{\delta}$$

is a distinguished n-exangle for some  $\delta \in \mathbb{E}(\Sigma C, C)$ . So the morphism  $C \to 0$  is a trivial inflation.

As a special case of Theorem 4.3 when n = 1, we have the following.

**Corollary 4.4.** [T, Theorem B] Let  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  be an extriangulated category. Then  $\mathscr{C}$  has a right triangulated structure  $(\mathscr{C}, \Sigma, \Theta)$  with  $\Sigma$  is right semi-equivalence if and only if for any object  $C \in \mathscr{C}$ , the morphism  $C \to 0$  is an inflation.

*Proof.* This follows from Theorem 4.3 and Remark 4.2.

In general, a right (n + 2)-angulated category do not have a natural n-exangulated structure. As a direct consequence of Theorem 4.3, we have the following.

**Corollary 4.5.** Let  $(\mathscr{C}, \Sigma^n, \Theta)$  be a right (n+2)-angulated category. Then  $\mathscr{C}$  has an n-exangulated structure  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  if and only if the suspension functor  $\Sigma^n$  is right semi-equivalence.

As a special case of Corollary 4.5 when n = 1, we have the following.

Corollary 4.6. [T, Theorem A] Let  $(\mathscr{C}, \Sigma, \Theta)$  be a right triangulated category. Then  $\mathscr{C}$  has an extriangulated structure  $(\mathscr{C}, \mathbb{E}, \mathfrak{s})$  if and only if the suspension functor  $\Sigma$  is right semi-equivalence.

**Remark 4.7.** (1) One can get that the Example 3.5 can induce extriangulated structures which are not triangulated by Corollary 4.6.

(2) Let  $\mathscr C$  be an n-exangulated category and  $\mathscr X$  is a strongly covariantly finite subcategory of  $\mathscr C$ . If  $\mathscr X \subset \operatorname{Proj}_{\mathbb F^{\mathscr X}}\mathscr C$ , then the standard right (n+2)-angulated category  $\mathscr C/\mathscr X$  has an n-exangulated structure by Theorem 3.12 and Corollary 4.5.
