ON SQUARES OF DEHN TWISTS ABOUT NON-SEPARATING CURVES OF A NON-ORIENTABLE CLOSED SURFACE

Abstract. The level 2 mapping class group of an orientable closed surface can be generated by squares of Dehn twists about non-separating curves (see [\[5\]](#page-15-0)). On the other hand, the level 2 mapping class group $\mathcal{M}_2(N)$ of a nonorientable closed surface N can not be generated by only Dehn twists, and so it can not be generated by squares of Dehn twists about non-separating curves. In this paper, we prove that the Dehn twist subgroup of $\mathcal{M}_2(N)$ can not be generated by squares of Dehn twists about non-separating curves either. As an application, we give a finite generating set for the subgroup of $\mathcal{M}_2(N)$ generated by Dehn twists about separating curves and squares of Dehn twists about non-separating curves. Moreover, we examine about actions on non-separating simple closed curves of N by $\mathcal{M}_2(N)$.

1. INTRODUCTION

We first explain about the case of orientable surfaces. For $g \geq 0$, let Σ_g denote an orientable closed surface of genus g, that is, Σ_g is a connected sum of g tori. The mapping class group $\mathcal{M}(\Sigma_g)$ of Σ_g is the group which consists of isotopy classes of all orientation preserving diffeomorphisms of Σ_g . The level 2 mapping class group $\mathcal{M}_2(\Sigma_g)$ of Σ_g is the subgroup of $\mathcal{M}(\Sigma_g)$ which acts on $H_1(\Sigma_g;\mathbb{Z}/2\mathbb{Z})$ trivially. Let $\mathcal{T}^2(\Sigma_g)$ denote the subgroup of $\mathcal{M}(\Sigma_g)$ generated by squares of Dehn twists about non-separating curves. It is known that $\mathcal{T}^2(\Sigma_g) = \mathcal{M}_2(\Sigma_g)$ (see [\[5\]](#page-15-0)). Let $\mathcal{I}(\Sigma_g)$ denote the subgroup of $\mathcal{M}(\Sigma_g)$ which acts on $H_1(\Sigma_g;\mathbb{Z})$ trivially, called the Torelli group of Σ_g . It is clear that $\mathcal{I}(\Sigma_g) \subset \mathcal{M}_2(\Sigma_g)$, and hence we have that $\mathcal{T}^2(\Sigma_g)\mathcal{I}(\Sigma_g) = \mathcal{M}_2(\Sigma_g).$

In this paper, we would like to consider the similar problem for the case of nonorientable surfaces, as follows. For $g \geq 1$, let N_g denote a non-orientable closed surface of genus g, that is, N_g is a connected sum of Σ_h and $g-2h$ real projective planes for $0 \leq h \leq \frac{g-1}{2}$ $\frac{1}{2}$. In this paper, we describe N_g as a surface obtained by attaching $g-2h$ Möbius bands to a surface obtained by removing disjoint $g-2h$ disks from Σ_h , as shown in Figure [1.](#page-1-0) We call these attached Möbius bands crosscaps. The mapping class group $\mathcal{M}(N_q)$ of N_q is the group which consists of isotopy classes of all diffeomorphisms of N_g . The level 2 mapping class group $\mathcal{M}_2(N_g)$ of N_g is the subgroup of $\mathcal{M}(N_g)$ which acts on $H_1(N_g; \mathbb{Z}/2\mathbb{Z})$ trivially. Let $\mathcal{T}^2(N_g)$ denote the subgroup of $\mathcal{M}(N_q)$ generated by squares of Dehn twists about non-separating

curves. Note that $\mathcal{T}^2(N_g) \subset \mathcal{M}_2(N_g)$. $\mathcal{M}_2(N_g)$ can be normally generated by one crosscap slide (see [\[13\]](#page-15-1)), and a crosscap slide can not be described as any product of Dehn twists (see [\[10\]](#page-15-2)). Hence $\mathcal{M}_2(N_q)$ can not be generated by only Dehn twists, and so $\mathcal{T}^2(N_g) \neq \mathcal{M}_2(N_g)$. We consider the subgroup $\mathcal{T}_2(N_g)$ of $\mathcal{M}_2(N_g)$ generated by all Dehn twists, called the *twist subgroup* of $\mathcal{M}_2(N_q)$. Note that a generating set for $\mathcal{T}_2(N_g)$ which does not consist of squares of Dehn twists about non-separating curves is known (see [\[9\]](#page-15-3)). In this paper, we prove that $\mathcal{T}_2(N_g) \neq \mathcal{T}^2(N_g)$ for $g \geq 4$ either.

More precisely, we prove the following, where $\mathcal{I}(N_q)$ is the subgroup of $\mathcal{M}(N_q)$ which acts on $H_1(N_q; \mathbb{Z})$ trivially, called the *Torelli group* of N_q .

Theorem 1.1. For $g \geq 3$, the quotient of $\mathcal{M}_2(N_g)$ by $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$ is isomorphic to $(\mathbb{Z}/2\mathbb{Z})^{{g-1 \choose 2}}$ if g is odd and to $(\mathbb{Z}/2\mathbb{Z})^{{g-1 \choose 2}+1}$ if g is even.

It is known that $\mathcal{T}_2(N_q)$ is an index 2 subgroup of $\mathcal{M}_2(N_q)$ (see [\[10,](#page-15-2) [9\]](#page-15-3)). Since $\mathcal{T}_2(N_g) \supset \mathcal{T}^2(N_g)\mathcal{I}(N_g)$, we have the following.

Corollary 1.2. For $g \geq 3$, the quotient of $\mathcal{T}_2(N_g)$ by $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$ is isomorphic to $(\mathbb{Z}/2\mathbb{Z})^{{g-1 \choose 2}-1}$ if g is odd and to $(\mathbb{Z}/2\mathbb{Z})^{{g-1 \choose 2}}$ if g is even.

By this corollary, we can conclude that $\mathcal{T}_2(N_g) \neq \mathcal{T}^2(N_g)$ for $g \geq 4$. We remark that $\mathcal{T}_2(N_3) = \mathcal{T}^2(N_3)$ since $\mathcal{I}(N_3)$ is trivial.

Here is an outline of the paper. In Section [2,](#page-1-1) we present the prior results necessary to prove Theorem [1.1.](#page-1-2) In Section [3,](#page-4-0) we examine about actions on nonseparating simple closed curves of N_q by $\mathcal{M}_2(N_q)$. In Section [4,](#page-6-0) we prove Theorem [1.1,](#page-1-2) using results of Sections [2](#page-1-1) and [3.](#page-4-0) In Section [5,](#page-10-0) we give a finite generating set for $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$, as an application of Theorem [1.1.](#page-1-2) In Appendix [A,](#page-13-0) we consider the case where g is odd of Theorem [1.1](#page-1-2) and Corollary [1.2.](#page-1-3)

Through this paper, the product gf of mapping classes f and g means that we apply f first and then g , and we do not distinguish a simple closed curve from its isotopy class. In addition, for simple closed curves α and β of N_q , we denote $\alpha = \beta$ if α and β are isotopic.

2. Preliminaries

2.1. On Dehn twist and crosscap slide.

First, we define a *Dehn twist* and a *crosscap slide* which are elements of $\mathcal{M}(N_q)$. For a simple closed curve α of N_g , its regular neighborhood is either an annulus or a Möbius band. We call α a two sided or a one sided simple closed curve respectively. For a two sided simple closed curve α , the *Dehn twist* t_{α} about α is the isotopy class of the map acting as shown in Figure [2](#page-2-0) (a). The direction of the twist is indicated by an arrow written beside α as shown in Figure [2](#page-2-0) (a). For a one sided simple closed curve μ of N_q and an oriented two sided simple closed curve α of N_q such that $N_g \setminus \alpha$ is non-orientable when $g \geq 3$ and that μ and α intersect transversely at only one point, the *crosscap slide* $Y_{\mu,\alpha}$ about μ and α is the isotopy class of the map described by pushing the crosscap which is a regular neighborhood of μ once along α , as shown in Figure [2](#page-2-0) (b).

Next, we explain about some relations on Dehn twists and crosscap slides. For details, for instance see [\[12\]](#page-15-4). For a simple closed curve α which bounds a disk or a crosscap, we have that

$$
t_{\alpha}=1.
$$

For any Dehn twist t_{α} , crosscap slide $Y_{\mu,\alpha}$ and $f \in \mathcal{M}(N_g)$, we have that

$$
ft_{\alpha}f^{-1} = t_{f(\alpha)}, \ fY_{\mu,\alpha}f^{-1} = Y_{f(\mu),f(\alpha)},
$$

where, the directions of the twist of $t_{f(\alpha)}$ and the pushing of $Y_{f(\mu),f(\alpha)}$ are induced from f and the directions of the twist of t_{α} and the pushing of the $Y_{\mu,\alpha}$. Let μ_1 , μ_2 and α be simple closed curves as shown in Figure [3](#page-3-0) (a). Then we have that

$$
Y_{\mu_2,\alpha}^{-1}Y_{\mu_1,\alpha} = Y_{\mu_2,\alpha}Y_{\mu_1,\alpha}^{-1} = t_\alpha^2.
$$

For two crosscap slides $Y_{\mu,\alpha}$ and $Y_{\mu,\beta}$ such that $\overline{\alpha\beta}$ is simple, where $\overline{\alpha}$ and $\overline{\beta}$ are oriented loops of N_{g-1} obtained by collapsing a regular neighborhood of μ and $\overline{\alpha\beta}$ is a composition loop of $\overline{\alpha}$ and $\overline{\beta}$ based at the collapsing point, let $\delta_1(\mu,\alpha,\beta)$ and $\delta_2(\mu, \alpha, \beta)$ be simple closed curves determined by μ , α and β as shown in Figure [3](#page-3-0) (b). Then we have that

$$
Y_{\mu,\beta}Y_{\mu,\alpha} = t_{\delta_1(\mu,\alpha,\beta)}t_{\delta_2(\mu,\alpha,\beta)}.
$$

In addition, for any crosscap slide $Y_{\mu,\alpha}$, we have that

$$
Y_{\mu,\alpha}^2 = t_{\delta(\mu,\alpha)}, \ Y_{\mu,\alpha} = Y_{\mu,\alpha^{-1}}^{-1},
$$

where $\delta(\mu, \alpha)$ is a simple closed curve determined by μ and α as shown in Figure [2](#page-2-0) (b).

2.2. On $\mathcal{M}_2(N_q)$ and $\mathcal{I}(N_q)$.

For $1 \leq i_1 < i_2 < \cdots < i_k \leq g$, let $\alpha_{i_1,i_2,\ldots,i_k}$ be a simple closed curve of N_g as shown in Figure [4.](#page-3-1) For $g \geq 4$, Szepietowski [\[13\]](#page-15-1) gave a finite generating set for $\mathcal{M}_2(N_q)$, and then Hirose-Sato [\[4\]](#page-15-5) gave a minimal generating set for $\mathcal{M}_2(N_q)$ as follows.

Theorem 2.1 ([\[4\]](#page-15-5)). For $g \geq 4$, $\mathcal{M}_2(N_q)$ is minimally generated by

- $Y_{\alpha_i,\alpha_{i,j}}$ for $1 \leq i < j \leq g$,
- $Y_{\alpha_j,\alpha_{i,j}}$ for $1 \leq i < j \leq g-1$,
- $t^{2}_{\alpha_{1,j,k,l}}$ for $1 < j < k < l \leq g$.

For $g \leq 3$, $\mathcal{I}(N_g)$ is trivial. For $g \geq 4$, a normal generating set for $\mathcal{I}(N_g)$ in $\mathcal{M}(N_q)$ is known as follows.

Theorem 2.2 ([\[3,](#page-15-6) [8\]](#page-15-7)). Let α , β_1 , β_2 and γ be simple closed curves as shown in Figure [5.](#page-3-2) For $g \geq 5$, $\mathcal{I}(N_g)$ is normally generated by t_{α} and $t_{\beta_1} t_{\beta_2}^{-1}$ in $\mathcal{M}(N_g)$. $\mathcal{I}(N_4)$ is normally generated by t_{α} , $t_{\beta_1}t_{\beta_2}^{-1}$ and t_{γ} in $\mathcal{M}(N_4)$.

For $n \geq 1$, let $\Gamma_2(n)$ denote the kernel of the natural homomorphism $GL(n, \mathbb{Z}) \rightarrow$ $GL(n,\mathbb{Z}/2\mathbb{Z})$. A finite presentation for $\Gamma_2(n)$ was given by Fullarton [\[1\]](#page-15-8) and the second author [\[7\]](#page-15-9) independently, and then Hirose and the second author [\[3\]](#page-15-6) gave another presentation as follows. Put $n = g - 1$. For $1 \le i, j \le g - 1$ with $i \ne j$, let $Y_{i,j}$ be the matrix whose (i, j) entry is 2, (i, i) entry is -1 , the other diagonal entries are 1 and the other entries are 0, and $Y_{i,g}$ the matrix whose (i, i) entry is −1, the other diagonal entries are 1 and the other entries are 0. $\Gamma_2(g-1)$ has the following presentation.

Proposition 2.3 ([\[3\]](#page-15-6)). For $g \geq 2$, $\Gamma_2(g-1)$ admits a presentation with generators $Y_{i,j}$ for $1 \leq i \leq g-1$ and $1 \leq j \leq g$ with $i \neq j$. The defining relators are

 (1) $Y_{i,j}^2$, (2) $(Y_{i,j}Y_{k,j})^2$, $(Y_{i,j}Y_{k,l})^2$, (3) $(Y_{i,j}Y_{i,k}Y_{j,k})^2$, $(Y_{i,j}Y_{i,k}Y_{i,l})^2$, (4) $(Y_{j,i}Y_{i,j}Y_{k,j}Y_{j,k}Y_{i,k}Y_{k,i})^2$,

where indices i, j, k and l are distinct.

We regard $\alpha_{i_1,i_2,...,i_k}$ as an element of $H_1(N_g;\mathbb{Z})$. Note that $\alpha_{i_1,i_2,...,i_k} = \alpha_{i_1} +$ $\alpha_{i_2} + \cdots + \alpha_{i_k}$. Then, as a Z-module, we have presentations

$$
H_1(N_g; \mathbb{Z})/\langle \alpha_{1,2,...,g} \rangle = \langle \alpha_1, \alpha_2,..., \alpha_g \mid \alpha_{1,2,...,g} = 0 \rangle
$$

= $\langle \alpha_1, \alpha_2,..., \alpha_{g-1} \rangle$.

It is known that any automorphism of $H_1(N_q; \mathbb{Z})$ preserves the homology class of $\alpha_{1,2,...,g}$ (see [\[11,](#page-15-10) [3\]](#page-15-6)). Hence $f \in \mathcal{M}(N_g)$ induces the automorphism f_* of $H_1(N_g;\mathbb{Z})/\langle \alpha_{1,2,...,g}\rangle$. More precisely, for $f \in \mathcal{M}(N_g)$, when $f(\alpha_j) = \sum_{i=1}^g c_{ij}\alpha_i$, we define $f_*(\alpha_j) = \sum_{i=1}^{g-1} (c_{ij} - c_{gj}) \alpha_i$. We can regard an automorphism of $H_1(N_g;\mathbb{Z})/\langle\alpha_{1,2,...,g}\rangle$ as a matrix in $GL(g-1,\mathbb{Z})$. Then we have that $(Y_{\alpha_i,\alpha_{i,j}})_*$ = $Y_{i,j}, (Y_{\alpha_j,\alpha_{i,j}})_* = Y_{j,i}$ and $(Y_{\alpha_i,\alpha_{i,j}})_* = Y_{i,g}$ for $1 \leq i < j \leq g-1$. It is known that the quotient $\mathcal{M}_2(N_g)/\mathcal{I}(N_g)$ of $\mathcal{M}_2(N_g)$ by $\mathcal{I}(N_g)$ is isomorphic to $\Gamma_2(g-1)$ for $g \geq 3$ (see [\[11,](#page-15-10) [3\]](#page-15-6)).

3. ACTION ON NON-SEPARATING SIMPLE CLOSED CURVES OF N_g by $\mathcal{M}_2(N_g)$

For a simple closed curve α of N_q , we denote by [α] its $\mathbb{Z}/2\mathbb{Z}$ coefficient first homology class. In this section, we prove the following.

Theorem 3.1. For any non-separating simple closed curves α and β of N_g , $[\alpha] =$ $[\beta] \in H_1(N_q;\mathbb{Z}/2\mathbb{Z})$ if and only if there is $\varphi \in \mathcal{M}_2(N_q)$ such that $\varphi(\alpha) = \beta$.

Proof. We note that $H_1(N_g; \mathbb{Z}/2\mathbb{Z})$ is isomorphic to $(\mathbb{Z}/2\mathbb{Z})^g$. Let $O_2(g)$ denote the orthogonal group on $\mathbb{Z}/2\mathbb{Z}$ of rank g. The natural action on $H_1(N_g;\mathbb{Z}/2\mathbb{Z})$ by $\mathcal{M}(N_q)$ induces the epimorphism $\mathcal{M}(N_q) \to O_2(q)$ (see [\[2\]](#page-15-11)). For $f \in \mathcal{M}(N_q)$, we denote by $f_{\star} \in O_2(g)$ the matrix corresponding to f. It is known that $O_2(g)$ is generated by $(t_{\alpha_{i_1,i_2,...,i_k}})$. Since α_i and $\alpha_{i_1,i_2,...,i_k}$ intersect transversally at only one point if $i \in \{i_1, i_2, \ldots, i_k\}$, and do not intersect if $i \notin \{i_1, i_2, \ldots, i_k\}$, we have that

$$
(t_{\alpha_{i_1,i_2,\ldots,i_k}})_{\star}([\alpha_i]) = \begin{cases} [\alpha_{i_1,i_2,\ldots,i_k}] + [\alpha_i] & (i \in \{i_1,i_2,\ldots,i_k\}), \\ [\alpha_i] & (i \notin \{i_1,i_2,\ldots,i_k\}). \end{cases}
$$

We note that the kernel of $\mathcal{M}(N_q) \to O_2(g)$ is $\mathcal{M}_2(N_q)$.

Let α and β be non-separating simple closed curves of N_q . If there is $\varphi \in \mathcal{M}_2(N_q)$ such that $\varphi(\alpha) = \beta$, since $\varphi_{\star} = 1$, we have that $[\alpha] = [\beta]$ clearly. Hence we show the converse. Suppose that $[\alpha] = [\beta]$. There is $h \in \mathcal{M}(N_g)$ such that $h(\beta)$ is isotopic to either $\alpha_1, \alpha_{1,2}$ or $\alpha_{1,2,\dots,g}$. We construct $f \in \mathcal{M}_2(N_g)$ satisfying $f(h(\alpha)) = h(\beta)$.

First, suppose that $h(\beta) = \alpha_1$. Note that $[h(\alpha)] = [h(\beta)] = [\alpha_1]$. For $f_1 \in \mathcal{M}(N_q)$ satisfying $f_1(h(\alpha)) = h(\beta)$, we see that $(f_1)_\star([\alpha_1]) = (f_1)_\star([h(\alpha)]) =$ $[f_1(h(\alpha))] = [h(\beta)] = [\alpha_1].$ On the other hand, for $2 \leq i \leq g$, since the mod 2 intersection number of $(f_1)_\star([\alpha_1])$ and $(f_1)_\star([\alpha_i])$ is 0, we can describe $(f_1)_*([\alpha_i]) = \sum^g$ $j=2$ $c_{ji}[\alpha_j]$, where $c_{ji} = 0$ or 1. Note that $(f_1)_*$ can be described

as a matrix

$$
\begin{pmatrix} 1 & 0 & \cdots & 0 \\ 0 & c_{22} & \cdots & c_{2g} \\ \vdots & \vdots & & \vdots \\ 0 & c_{g2} & \cdots & c_{gg} \end{pmatrix}.
$$

Then there is $f_2 \in \mathcal{M}(N_q)$ such that

- $(f_2)_* = (f_1)_*^{-1},$
- f_2 is a product of $t_{\alpha_{i_1,i_2,...,i_k}}$'s for some even indices $i_1, i_2, ..., i_k$ with $i_1 \geq 2$.

Let $f = f_2 f_1$. We note that $f_* = (f_2)_*(f_1)_* = 1$, that is, f is in $\mathcal{M}_2(N_g)$. Since $t_{\alpha_{i_1,i_2,\ldots,i_k}}(\alpha_1)=\alpha_1$ if $i_1\geq 2$, we have that

$$
f(h(\alpha)) = f_2(h(\beta)) = f_2(\alpha_1) = \alpha_1 = h(\beta).
$$

Next, suppose that $h(\beta) = \alpha_{1,2}$. Note that $[h(\alpha)] = [h(\beta)] = [\alpha_1] + [\alpha_2]$. For $f_1 \in$ $\mathcal{M}(N_g)$ satisfying $f_1(h(\alpha)) = h(\beta)$, we see that $(f_1)_\star([\alpha_1] + [\alpha_2]) = (f_1)_\star([h(\alpha)]) =$ $[f_1(h(\alpha))] = [h(\beta)] = [\alpha_1] + [\alpha_2]$. Put $(f_1)_*([\alpha_i]) = \sum_{i=1}^g$ $j=1$ $c_{ji}[\alpha_j]$ for $1 \leq i \leq g$, where $c_{ji} = 0$ or 1. By the definition of $O_2(g)$, we have that there are an odd number of c_{j1} 's (resp. c_{j2} 's) for which $c_{j1} = 1$ (resp. $c_{j2} = 1$), and that there are an even number of j's for which $c_{j1} = c_{j2} = 1$. In addition, we see that $(f_1)_\star([\alpha_1] + [\alpha_2]) =$ $\sum_{i=1}^{g}$ $j=1$ $(c_{j1} + c_{j2})[\alpha_j] = [\alpha_1] + [\alpha_2]$, and hence $c_{11} \neq c_{12}$, $c_{21} \neq c_{22}$ and $c_{j1} = c_{j2}$ for

 $j \geq 3$. Therefore, we have that $\begin{pmatrix} c_{11} & c_{12} \\ c_{21} & c_{22} \end{pmatrix} = \begin{pmatrix} 1 & 0 \\ 0 & 1 \end{pmatrix}$ or $\begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$. We can rewrite $(f_1)_\star([\alpha_1]) = [\alpha_i] + \sum$ l $s=1$ $[\alpha_{j_s}]$ for some even indices $3 \leq j_1 < j_2 < \cdots < j_l \leq g$, where $i = 1$ or 2. Then we calculate

$$
(t_{\alpha_{1,2,j_{1},...,j_{l}}})_{\star}(f_{1})_{\star}([\alpha_{1}]) = (t_{\alpha_{1,2,j_{1},...,j_{l}}})_{\star}([\alpha_{i}]) + \sum_{s=1}^{l} (t_{\alpha_{1,2,j_{1},...,j_{l}}})_{\star}([\alpha_{j_{s}}])
$$

= [\alpha_{1,2,j_{1},...,j_{l}}] + [\alpha_{i}] + \sum_{s=1}^{l} ([\alpha_{1,2,j_{1},...,j_{l}}] + [\alpha_{j_{s}}])

where $(i, j) = (1, 2)$ or $(2, 1)$. Similarly $(t_{\alpha_{1,2,j_1,\dots,j_l}})_{\star}(f_1)_{\star}([\alpha_2]) = [\alpha_i]$. Note that $(t_{\alpha_{1,2,j_1,\ldots,j_l}})_{\star}(f_1)_{\star}$ can be described as a matrix

Then there is $f_2 \in \mathcal{M}(N_g)$ such that

- $(f_2)_\star = \{(t_{\alpha_{1,2,j_1,\ldots,j_l}})_\star (f_1)_\star\}^{-1},$
- f_2 is a product of $t_{\alpha_{i_1,i_2,...,i_k}}$'s (and $t_{\alpha_{1,2}}$) for some even indices $i_1, i_2, ...,$ i_k with $i_1 \geq 3$.

Let $f = f_2 t_{\alpha_{1,2,j_1,...,j_l}} f_1$. We note that $f_{\star} = (f_2)_{\star} \{(t_{\alpha_{1,2,j_1,...,j_l}})_{\star}(f_1)_{\star}\} = 1$, that is, f is in $\mathcal{M}_2(N_g)$. Since $t_{\alpha_{1,2,j_1,...,j_l}}(\alpha_{1,2}) = \alpha_{1,2}, t_{\alpha_{1,2}}(\alpha_{1,2}) = \alpha_{1,2}$ and $t_{\alpha_{i_1,i_2,...,i_k}}(\alpha_{1,2}) = \alpha_{1,2}$ if $i_1 \geq 3$, we have that

$$
f(h(\alpha)) = f_2 t_{\alpha_{1,2,j_1,\ldots,j_l}}(h(\beta)) = f_2 t_{\alpha_{1,2,j_1,\ldots,j_l}}(\alpha_{1,2}) = f_2(\alpha_{1,2}) = \alpha_{1,2} = h(\beta).
$$

Finally, suppose that $h(\beta) = \alpha_{1,2,...,g}$. Note that $[h(\alpha)] = [h(\beta)] = [\alpha_1] + [\alpha_2] +$ $\cdots + [\alpha_g]$. For $f_1 \in \mathcal{M}(N_g)$ satisfying $f_1(h(\alpha)) = h(\beta)$, there is $f_2 \in \mathcal{M}(N_g)$ such that

- $(f_2)_* = (f_1)_*^{-1},$
- f_2 is a product of $t_{\alpha_{i_1,i_2,...,i_k}}$'s for some even indices i_1, i_2, \ldots, i_k .

Let $f = f_2 f_1$. We note that $f_* = (f_2)_*(f_1)_* = 1$, that is, f is in $\mathcal{M}_2(N_q)$. Since $t_{\alpha_{i_1,i_2,...,i_k}}(\alpha_{1,2,...,g}) = \alpha_{1,2,...,g}$, we have that

$$
f(h(\alpha)) = f_2(h(\beta)) = f_2(\alpha_{1,2,...,g}) = \alpha_{1,2,...,g} = h(\beta).
$$

Therefore $\varphi = h^{-1}fh$ is in $\mathcal{M}_2(N_g)$ and satisfies $\varphi(\alpha) = \beta$ if $[\alpha] = [\beta]$. Thus the proof is completed. \Box

4. Proof of Theorem [1.1](#page-1-2)

In this section, we prove Theorem [1.1.](#page-1-2) First we prepare some things.

For $1 \leq i \leq g-1$, let $Y_{g,i} = (Y_{\alpha_g, \alpha_{i,g}})_* \in \Gamma_2(g-1)$, and we can check that

$$
Y_{g,i} = (Y_{1,i}Y_{1,g})(Y_{2,i}Y_{2,g})\cdots(Y_{i-1,i}Y_{i-1,g})\cdot(Y_{i+1,i}Y_{i+1,g})\cdots(Y_{g-1,i}Y_{g-1,g})Y_{i,g}.
$$

Hence, from Proposition [2.3](#page-3-3) we have the following.

Corollary 4.1. For $q \geq 3$, $\Gamma_2(q-1)$ admits a presentation with generators $Y_{i,j}$ for $1 \leq i, j \leq g$ with $i \neq j$. The defining relators are (1)-(4) of Proposition [2.3](#page-3-3) and (5) $(Y_{1,i}Y_{1,g})(Y_{2,i}Y_{2,g})\cdots(Y_{i-1,i}Y_{i-1,g})\cdot(Y_{i+1,i}Y_{i+1,g})\cdots(Y_{g-1,i}Y_{g-1,g})Y_{i,g}Y_{g,i}^{-1}$ for $1 \leq i \leq g-1$.

Lemma 4.2. For $g \geq 3$, in $\Gamma_2(g-1)$, the relation $Y_{i,j}Y_{g,j} = Y_{g,j}Y_{i,j}$ holds for $1 \leq i \leq g-1$.

Proof. By relators of $\Gamma_2(g-1)$, we have relations

$$
Y_{i,j}(Y_{k,j}Y_{k,g}) = (Y_{k,j}Y_{k,g})Y_{i,j},
$$

\n

Y_{i,j}(Y_{i,j}Y_{i,g}) = (Y_{i,j}Y_{i,g})(Y_{i,g}Y_{i,j}Y_{i,g}),
$$

\n
$$
(Y_{i,g}Y_{i,j}Y_{i,g})(Y_{k,j}Y_{k,g}) = (Y_{k,j}Y_{k,g})(Y_{i,g}Y_{i,j}Y_{i,g})
$$

for $k \neq i$. Hence we calculate

$$
Y_{i,j}Y_{g,j} = Y_{i,j}(Y_{1,j}Y_{1,g})\cdots(Y_{j-1,j}Y_{j-1,g})\cdot(Y_{j+1,j}Y_{j+1,g})\cdots(Y_{g-1,j}Y_{g-1,g})Y_{j,g}
$$

= (Y_{1,j}Y_{1,g})\cdots(Y_{j-1,j}Y_{j-1,g})\cdot(Y_{j+1,j}Y_{j+1,g})\cdots(Y_{g-1,j}Y_{g-1,g})(Y_{i,g}Y_{i,j}Y_{i,g})Y_{j,g}
$$

= (Y_{1,j}Y_{1,g})\cdots(Y_{j-1,j}Y_{j-1,g})\cdot(Y_{j+1,j}Y_{j+1,g})\cdots(Y_{g-1,j}Y_{g-1,g})\frac{Y_{i,g}Y_{i,j}Y_{j,g}Y_{i,g}}{\binom{3}{3}}
$$

= (Y_{1,j}Y_{1,g})\cdots(Y_{j-1,j}Y_{j-1,g})\cdot(Y_{j+1,j}Y_{j+1,g})\cdots(Y_{g-1,j}Y_{g-1,g})Y_{j,g}Y_{i,j}\frac{Y_{i,g}Y_{i,g}}{\binom{3}{1}}
$$

= (Y_{1,j}Y_{1,g})\cdots(Y_{j-1,j}Y_{j-1,g})\cdot(Y_{j+1,j}Y_{j+1,g})\cdots(Y_{g-1,j}Y_{g-1,g})Y_{j,g}Y_{i,j}\frac{Y_{i,g}Y_{i,g}}{\binom{1}{1}}
$$

Thus we obtain the claim.

Let N be the normal subgroup of $\Gamma_2(g-1)$ normally generated by $Y_{j,i}^{-1}Y_{i,j}$ for $1 \leq i, j \leq g.$

Lemma 4.3. For $g \geq 3$, the quotient $\Gamma_2(g-1)/N$ of $\Gamma_2(g-1)$ by N admits a presentation with generators $Y_{i,j}$ for $1 \leq i < j \leq g$. The defining relators are

(1) Y 2 i,j , (2) (Yi,jYk,j) 2 , (Yi,jYi,l) 2 , (Yi,jYj,l) 2 , (Yi,jYk,l) 2 , (5) (Y1,iY1,g)· · ·(Yi−1,iYi−1,g) · (Yi,i+1Yⁱ+1,g)· · ·(Yi,g−1Yg−1,g) for 2 ≤ i ≤ g − 1, and Y1,gY2,g · · · Yg−1,g if g is odd.

Proof. Since we have that $Y_{j,i} = Y_{i,j}$ for $1 \leq i < j \leq g$ in $\Gamma_2(g-1)/N$, by the Tietze transformation, $\Gamma_2(g-1)/N$ is generated by $Y_{i,j}$ for $1 \leq i < j \leq g$.

By the relator (1) of $\Gamma_2(g-1)$, we have the relator $\overline{(1)}$. By the relator $(Y_{i,j}Y_{k,j})^2$ of $\Gamma_2(g-1)$, we have relators

- $(Y_{i,j}Y_{k,j})^2$ if $1 \leq i, k < j \leq g$,
- $(Y_{j,i}Y_{j,k})^2$ if $1 \leq j < i, k \leq g-1$,
- $(Y_{i,j}Y_{j,k})^2$ if $1 \leq i < j < k \leq g-1$.

In addition, by Lemma [4.2,](#page-6-1) we have relators

- $(Y_{j,i}Y_{j,g})^2$ if $i > j$,
- $(Y_{i,j}Y_{j,g})^2$ if $i < j$.

Moreover, by the relator $(Y_{i,j}Y_{k,l})^2$ of $\Gamma_2(g-1)$, we have the relator $(Y_{i,j}Y_{k,l})^2$. Hence we have the relator $\overline{(2)}$. By the relators $\overline{(1)}$ and $\overline{(2)}$, the relators (3) and (4) are trivial relators. By the relator (5) of $\Gamma_2(g-1)$, we have the relator

$$
(Y_{1,i}Y_{1,g})\cdots(Y_{i-1,i}Y_{i-1,g})\cdot(Y_{i,i+1}Y_{i+1,g})\cdots(Y_{i,g-1}Y_{g-1,g}),
$$

and hence by the relators $\overline{(1)}$ and $\overline{(2)}$,

Y_{1,i} = Y_{1,g}(Y_{2,i}Y_{2,g})\cdots(Y_{i-1,i}Y_{i-1,g})\cdot(Y_{i,i+1}Y_{i+1,g})\cdots(Y_{i,g-1}Y_{g-1,g})
$$

=
$$
(Y_{1,g}\cdots Y_{i-1,g}Y_{i+1,g}\cdots Y_{g-1,g})(Y_{2,i}\cdots Y_{i-1,i}Y_{i,i+1}\cdots Y_{i,g-1}).
$$

\Box
$$

for $2 \le i \le g-1$. By the relators $\overline{(1)}$ and $\overline{(2)}$, the relator (5) of $\Gamma_2(g-1)$ for $i=1$ can be transformed as

$$
(Y_{1,2}Y_{2,g})\cdots(Y_{1,g-1}Y_{g-1,g}) = (Y_{1,2}\cdots Y_{1,g-1})(Y_{2,g}\cdots Y_{g-1,g})
$$

\n

= (Y_{1,g} \cdot Y_{3,g} \cdots Y_{g-1,g})(Y_{2,3} \cdots Y_{2,g-1})
$$

\n

(Y_{1,g}Y_{2,g} \cdot Y_{4,g} \cdots Y_{g-1,g})(Y_{2,3} \cdot Y_{3,4} \cdots Y_{3,g-1})
$$

(Y_{1,g}Y_{2,g}Y_{3,g} \cdot Y_{5,g} \cdots Y_{g-1,g})(Y_{2,4}Y_{3,4} \cdot Y_{4,5} \cdots Y_{4,g-1})

= \begin{cases} Y_{1,g} \cdots Y_{g-1,g} & \text{if } g \text{ is odd,} \\ 1 & \text{if } g \text{ is even.} \end{cases}
$$

Hence we have the relator $\overline{(5)}$.

Thus we obtain the claim.

By the relators $\overline{(1)}$ and $\overline{(2)}$, it follows that $\Gamma_2(g-1)/N$ is a $\mathbb{Z}/2\mathbb{Z}$ -module. By the relator $\overline{(5)}$, generators $Y_{1,i}$ are not needed, for $2 \leq i \leq g$ if g is odd and for $2 \leq i \leq g-1$ if g is even. Therefore we have the following.

Corollary 4.4. For $g \geq 3$, the quotient $\Gamma_2(g-1)/N$ of $\Gamma_2(g-1)$ by N is isomorphic to $(\mathbb{Z}/2\mathbb{Z})^{{g-1 \choose 2}}$ if g is odd and to $(\mathbb{Z}/2\mathbb{Z})^{{g-1 \choose 2}+1}$ if g is even.

Lemma 4.5. In $M_2(N_g)$, $\mathcal{T}^2(N_g)$ is normally generated by $t^2_{\alpha_{i_1,i_2,...,i_k}}$ for even indices $1 \leq i_1 < i_2 < \cdots < i_k \leq g$.

Proof. For any non-separating simple closed curve α of N_g , there are indices $1 \leq$ $i_1 < i_2 < \cdots < i_k \leq g$ such that $[\alpha] = [\alpha_{i_1, i_2, \ldots, i_k}] \in H_2(N_g; \mathbb{Z}/2\mathbb{Z})$, and then there is $f \in \mathcal{M}_2(N_g)$ such that $f(\alpha_{i_1,i_2,...,i_k}) = \alpha$, by Theorem [3.1.](#page-4-1) Hence for any $t^2_{\alpha} \in \mathcal{T}^2(N_g)$, there is $f \in \mathcal{M}_2(N_g)$ such that $t^2_{\alpha} = t^2_{f(\alpha_{i_1, i_2, ..., i_k})} = ft^2_{\alpha_{i_1, i_2, ..., i_k}} f^{-1}$. Thus we obtain the claim. \Box

Lemma 4.6. Let d_1 , d_2 and d_3 be simple closed curves on a surface S as shown in Figure [6.](#page-9-0) Then $t_{d_1}t_{d_2}$ and t_{d_3} are in $\mathcal{T}^2(S)$.

Proof. Let c_i be a simple closed curve of S as shown in Figure [6,](#page-9-0) for $1 \leq i \leq k$. It is known that

- $t_{d_1}t_{d_2} = (t_{c_1}t_{c_2}\cdots t_{c_k})^{k+1},$
- $t_{d_3} = (t_{c_1} t_{c_2} \cdots t_{c_k})^{2(k+1)},$

called the k-chain relation. When $k = 1$, it is clear that $t_{d_1} t_{d_2}$ is in $\mathcal{T}^2(S)$. When $k \geq 2$, by the commutativity relation $t_{c_i} t_{c_j} = t_{c_j} t_{c_i}$ with $|i - j| \geq 2$ and the braid relation $t_{c_i} t_{c_{i+1}} t_{c_i} = t_{c_{i+1}} t_{c_i} t_{c_{i+1}}$, we calculate

$$
(t_{c_1}t_{c_2}\cdots t_{c_k})^{k+1} = (t_{c_1}t_{c_2}\cdots t_{c_{k-1}})^k t_{c_k}t_{c_{k-1}}\cdots t_{c_2}t_{c_1}^2 t_{c_2}\cdots t_{c_{k-1}}t_{c_k}
$$

$$
= (t_{c_1}t_{c_2}\cdots t_{c_{k-1}})^k
$$

$$
t_{c_k}^2 (t_{c_k}^{-1}t_{c_{k-1}}^2 t_{c_k})\cdots (t_{c_k}^{-1}t_{c_{k-1}}^{-1}\cdots t_{c_2}^{-1}t_{c_1}^2 t_{c_2}\cdots t_{c_{k-1}}t_{c_k}).
$$

FIGURE 6. Simple closed curves $c_1, c_2, \ldots, c_k, d_1, d_2$ and d_3 .

By induction on k, we have that $(t_{c_1}t_{c_2}\cdots t_{c_k})^{k+1}$ is in $\mathcal{T}^2(S)$, and so are $t_{d_1}t_{d_2}$ and t_{d_3} . Thus we obtain the claim.

We now prove Theorem [1.1.](#page-1-2)

Proof of Theorem [1.1.](#page-1-2) By Corollary [4.4,](#page-8-0) it suffices to show that the quotient of $\mathcal{M}_2(N_g)$ by $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$ is isomorphic to $\Gamma_2(g-1)/N$. Let ϕ : $\mathcal{M}_2(N_g) \to$ $\Gamma_2(g-1)$ be the homomorphism defined in Subsection [2.2,](#page-2-1) that is, $\phi(f) = f_*$. Since ker ϕ is $\mathcal{I}(N_g)$, we show that $\phi(\mathcal{T}^2(N_g))$ is N.

For $1 \leq i < j \leq g$, we have that $(Y_{\alpha_j,\alpha_{i,j}}^{-1})_*(Y_{\alpha_i,\alpha_{i,j}})_* = Y_{j,i}^{-1}Y_{i,j} \in N$. In addition, since the equality $t^2_{\alpha_{i,j}} = Y^{-1}_{\alpha_j,\alpha_{i,j}} Y_{\alpha_i,\alpha_{i,j}}$ holds, we have that $\phi(t^2_{\alpha_{i,j}}) =$ $Y_{j,i}^{-1}Y_{i,j}$. Therefore $\phi(\mathcal{T}^2(N_g)) \supset N$.

In order to prove $\phi(\mathcal{T}^2(N_g)) \subset N$, it suffices to show that $\phi(t^2_{\alpha_{i_1,i_2,...,i_k}})$ is in N, by Lemma [4.5.](#page-8-1) Let $\alpha'_{i_1,i_2,...,i_k}$ be a simple closed curve as shown in Figure [4.](#page-3-1) Since $t_{\alpha_{i_1,i_2,...,i_k}}^{-1} t_{\alpha'_{i_1,i_2,...,i_k}}^{-1}$ is in $\mathcal{I}(N_g)$ and hence its image by ϕ is 1, we have that

 $\phi(t^2_{\alpha_{i_1,i_2,...,i_k}}) = \phi(t^2_{\alpha_{i_1,i_2,...,i_k}} \cdot t^{-1}_{\alpha_{i_1,i_2,...,i_k}} t_{\alpha'_{i_1,i_2,...,i_k}}) = \phi(t_{\alpha_{i_1,i_2,...,i_k}} t_{\alpha'_{i_1,i_2,...,i_k}}).$

By the proof of Lemma [4.6,](#page-8-2) $t_{\alpha_{i_1,i_2,...,i_k}}t_{\alpha'_{i_1,i_2,...,i_k}}$ is a product of $T_{s,t}$ for $1 \leq s < t \leq$ k, where

$$
T_{s,t} = (t_{\alpha_{i_{s+1},i_{s+2}}} t_{\alpha_{i_{s+2},i_{s+3}}} \cdots t_{\alpha_{i_{t-1},i_t}})^{-1} t_{\alpha_{i_s,i_{s+1}}}^2 (t_{\alpha_{i_{s+1},i_{s+2}}} t_{\alpha_{i_{s+2},i_{s+3}}} \cdots t_{\alpha_{i_{t-1},i_t}}).
$$

Note that $T_{s,t}$ is the square of the Dehn twist about a simple closed curve as shown in Figure [7.](#page-9-1) Similar to the proof of Lemma [4.5,](#page-8-1) there is $f \in \mathcal{M}_2(N_g)$ such that $T_{s,t} =$ $ft_{\alpha_{i_s,i_t}}^2 f^{-1}$. Since $\phi(t_{\alpha_{i_s,i_t}}^2) = Y_{i_t,i_s}^{-1} Y_{i_s,i_t}$, it follows that $\phi(t_{\alpha_{i_1,i_2,...,i_k}} t_{\alpha'_{i_1,i_2,...,i_k}})$ is in N. Therefore $\phi(\mathcal{T}^2(N_g)) \subset N$.

Thus we complete the proof.

5. A FINITE GENERATING SET FOR $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$

By Theorem [1.1,](#page-1-2) $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$ is a finite index subgroup of $\mathcal{M}_2(N_g)$. In addi-tion, by Theorem [2.1,](#page-2-2) $\mathcal{M}_2(N_g)$ is finitely generated. Hence $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$ is also finitely generated. In this section, we give a finite generating set for $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$ by the Reidemeister-Schreier method.

For $1 \leq i < j \leq g$, let $\beta_{i,j}$ be a simple closed curve as shown in Figure [8.](#page-10-1) For (i, j) with $1 \leq i < j \leq g$, we consider the lexicographic order \lt , that is, $(i, j) < (k, l)$ if and only if $i < k$, or $i = k$ and $j < l$. Let Y be the set consisting of

Y_{\alpha_{i_1}, \alpha_{i_1, j_1}} Y_{\alpha_{i_2}, \alpha_{i_2, j_2}} \cdots Y_{\alpha_{i_m}, \alpha_{i_m, j_m}}
$$

for $2 \le i_s < j_s \le g$ if g is odd and $(i_s, j_s) = (1, g)$ or $2 \le i_s < j_s \le g$ if g is even, where $s \neq t \iff (i_s, j_s) \neq (i_t, j_t)$, and \mathcal{Y}_{LO} the subset of \mathcal{Y} consisting of

$$
Y_{\alpha_{i_1},\alpha_{i_1,j_1}} Y_{\alpha_{i_2},\alpha_{i_2,j_2}} \cdots Y_{\alpha_{i_m},\alpha_{i_m,j_m}} \in \mathcal{Y},
$$

where $s < t \iff (i_s, j_s) < (i_t, j_t)$.

FIGURE 8. A simple closed curve $\beta_{i,j}$ for $1 \leq i < j \leq g$.

The main result of this section is as follows.

Theorem 5.1. $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$ is generated by

- (1) $ft_{\alpha_{i,j}}^2 f^{-1}$ for $1 \leq i < j \leq g$ and $f \in \mathcal{Y}_{\text{LO}}$,
- (2) $ft_{\beta_{i,j}}f^{-1}$ for $1 \leq i < j \leq g$ and $f \in \mathcal{Y}_{\text{LO}}$,
- (3) $ft_{\alpha_{1,j,k,l}}^{2}f^{-1}$ for $1 < j < k < l \leq g$ and $f \in \mathcal{Y}_{\text{LO}}$.

In order to prove this theorem, we first show the following lemma.

Lemma 5.2. $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$ is generated by (1)-(3) of Theorem [5.1](#page-10-2) and

(4)
$$
f[Y_{\alpha_i,\alpha_{i,j}},Y_{\alpha_k,\alpha_{k,l}}]f^{-1}
$$
 for $1\leq i < j \leq g$, $1\leq k < l \leq g$ and $f \in \mathcal{Y}_{\text{LO}}$.

In addition, in order to prove this lemma, we use the following lemma.

Lemma 5.3. The following holds.

$$
\begin{array}{rcl}\n[a, b_1b_2 \cdots b_n] & = & [a, b_1] \left(b_1[a, b_2]b_1^{-1} \right) \left(b_1b_2[a, b_3]b_2^{-1}b_1^{-1} \right) \\
&\quad \cdots \left(b_1b_2 \cdots b_{n-1}[a, b_n]b_{n-1}^{-1} \cdots b_2^{-1}b_1^{-1} \right)\n\end{array}
$$

Proof. We calculate

$$
[a, b_1] (b_1[a, b_2]b_1^{-1})
$$

= $(ab_1a^{-1}b_1^{-1}) (b_1ab_2a^{-1}b_2^{-1}b_1^{-1})$
= $ab_1b_2a^{-1}b_2^{-1}b_1^{-1}$
= $[a, b_1b_2],$

$$
[a, b_1b_2 \cdots b_{n-1}] (b_1b_2 \cdots b_{n-1}[a, b_n]b_{n-1}^{-1} \cdots b_2^{-1}b_1^{-1})
$$

= $(ab_1b_2 \cdots b_{n-1}a^{-1}b_{n-1}^{-1} \cdots b_2^{-1}b_1^{-1}) (b_1b_2 \cdots b_{n-1}ab_na^{-1}b_{n-1}^{-1} \cdots b_2^{-1}b_1^{-1})$
= $ab_1b_2 \cdots b_na^{-1}b_n^{-1} \cdots b_2^{-1}b_1^{-1}$
= $[a, b_1b_2 \cdots b_n].$

By induction on n, we obtain the claim. \square

Proof of Lemma [5.2.](#page-10-3) By Theorem [1.1,](#page-1-2) we have the short exact sequence

$$
1 \to \mathcal{T}^2(N_g)\mathcal{I}(N_g) \to \mathcal{M}_2(N_g) \to (\mathbb{Z}/2\mathbb{Z})^{\binom{g-1}{2}+\epsilon} \to 1,
$$

where $\epsilon = 0$ if g is odd and $\epsilon = 1$ if g is even. In order to give a generating set for $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$, we use the Reidemeister-Schreier method (for details, for instance see [\[6\]](#page-15-12)).

By Lemma [4.3,](#page-7-0) it follows that $(\mathbb{Z}/2\mathbb{Z})^{\binom{g-1}{2}+\epsilon}$ is equal to \mathcal{Y}_{LO} as a set. We note that \mathcal{Y}_{LO} is a Schreier transversal for $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$ in $\mathcal{M}_2(N_g)$, that is, for any $Y_{\alpha_{i_1}, \alpha_{i_1, j_1}} Y_{\alpha_{i_2}, \alpha_{i_2, j_2}} \cdots Y_{\alpha_{i_m}, \alpha_{i_m, j_m}} \in \mathcal{Y}_{\text{LO}}$ with $m \geq 1$, $Y_{\alpha_{i_1},\alpha_{i_1,j_1}}Y_{\alpha_{i_2},\alpha_{i_2,j_2}}\cdots Y_{\alpha_{i_{m-1}},\alpha_{i_{m-1},j_{m-1}}}$ is in $\mathcal{Y}_{\mathrm{LO}}$. For any $x \in \mathcal{M}_2(N_g)$, let \overline{x} be the element of $\mathcal{Y}_{\text{LO}} = (\mathbb{Z}/2\mathbb{Z})^{\binom{g-1}{2}+\epsilon}$ which is sent from x by the natural projection. Then $\mathcal{T}^2(N_g)\mathcal{I}(N_g)$ is generated by

$$
G = \left\{ fx^{\pm 1} \overline{fx^{\pm 1}}^{-1} \middle| \ x \in X, f \in \mathcal{Y}_{\text{LO}}, fx^{\pm 1} \neq \overline{fx^{\pm 1}} \right\},\
$$

where X is the generating set for $\mathcal{M}_2(N_g)$ in Theorem [2.1.](#page-2-2) For any $fx^{\pm 1} \overline{fx^{\pm 1}}^{-1}$ G, we check that $fx^{\pm 1} \overline{fx^{\pm 1}}^{-1}$ is a product of elements in (1)-(4) of Lemma [5.2](#page-10-3) and their inverses. Note that $Y_{\alpha_j,\alpha_{i,j}}^{-1}Y_{\alpha_i,\alpha_{i,j}} = Y_{\alpha_j,\alpha_{i,j}}Y_{\alpha_i,\alpha_{i,j}}^{-1} = t_{\alpha_{i,j}}^2$ and $Y_{\alpha_i,\alpha_{i,j}}^2 =$ $Y_{\alpha_j,\alpha_{i,j}}^2 = t_{\beta_{i,j}}.$

Let $x = Y_{\alpha_i, \alpha_{i,j}}$. If f includes x, there are $f_1, f_2 \in \mathcal{Y}_{\text{LO}}$ such that $f = f_1 x f_2$. Then we see

$$
fx\overline{fx}^{-1} = f_1xf_2x\overline{f_1xf_2x}^{-1}
$$

\n
$$
= f_1xf_2x(f_1f_2)^{-1}
$$

\n
$$
= f_1[x, f_2]f_1^{-1} \cdot f_1f_2x^2f_2^{-1}f_1^{-1},
$$

\n
$$
fx^{-1}\overline{fx^{-1}}^{-1} = f_1xf_2x^{-1}\overline{f_1xf_2x^{-1}}^{-1}
$$

\n
$$
= f_1xf_2x^{-1}(f_1f_2)^{-1}
$$

\n
$$
= f_1[x, f_2]f_1^{-1}.
$$

If f does not include x, there are $f_1, f_2 \in \mathcal{Y}_{\text{LO}}$ such that $f = f_1 f_2$ and $f_1 x f_2 \in \mathcal{Y}_{\text{LO}}$. Then we see

$$
fx\overline{fx}^{-1} = f_1f_2x\overline{f_1f_2x}^{-1}
$$

\n
$$
= f_1f_2x(f_1xf_2)^{-1}
$$

\n
$$
= f_1[x, f_2]^{-1}f_1^{-1},
$$

\n
$$
fx^{-1}\overline{fx^{-1}}^{1} = f_1f_2x^{-1}\overline{f_1f_2x^{-1}}^{-1}
$$

\n
$$
= f_1f_2x^{-1}(f_1xf_2)^{-1}
$$

\n
$$
= fx^{-2}f^{-1} \cdot f_1[x, f_2]^{-1}f_1^{-1}.
$$

By Lemma [5.3,](#page-10-4) we have that $fx^{\pm 1} \overline{fx^{\pm 1}}^{-1}$ is a product of elements in (1)-(4) of Lemma [5.2](#page-10-3) and their inverses. In addition, let $x = Y_{\alpha_j, \alpha_{i,j}}$ and $x' = Y_{\alpha_i, \alpha_{i,j}}$. Then we see

$$
f x \overline{f x}^{-1} = f x \overline{f x'}^{-1} = f x (x')^{-1} f^{-1} \cdot f x' \overline{f x'}^{-1},
$$

$$
f x^{-1} \overline{f x^{-1}}^{-1} = f x^{-1} \overline{f x}^{-1} = f x^{-2} f^{-1} \cdot f x \overline{f x}^{-1}.
$$

Moreover, let $x = t^2_{\alpha_{1,j,k,l}}$. Then we see

$$
fx^{\pm 1}\overline{fx^{\pm 1}}^{-1} = fx^{\pm 1}f^{-1}.
$$

Therefore, for any $fx^{\pm 1} \overline{fx^{\pm 1}}^{-1} \in G$, we have that $fx^{\pm 1} \overline{fx^{\pm 1}}^{-1}$ is a product of elements in (1)-(4) of Lemma [5.2](#page-10-3) and their inverses.

Thus we finish the proof.

Remark 5.4. Put $f = Y_{\alpha_{i_1}, \alpha_{i_1, j_1}} Y_{\alpha_{i_2}, \alpha_{i_2, j_2}} \cdots Y_{\alpha_{i_m}, \alpha_{i_m, j_m}} \in \mathcal{Y}_{\text{LO}}$. We notice that the generator (4) in Lemma [5.2](#page-10-3) can be reduced a form satisfying $(i_m, j_m) < (i, j)$ (k, l) , since in the above proof $f_1[x, f_2]^{-1} f_1^{-1}$ is a product of these reduced generators.

Proof of Theorem [5.1.](#page-10-2) It is clear that the generators $(1), (2)$ and (3) in Lemma [5.2](#page-10-3) are equal to the generators (1) , (2) and (3) in Theorem [5.1](#page-10-2) respectively. We show that the reduced generator (4) in Remark [5.4](#page-12-0) is obtained from the generators (1) and (2) in Theorem [5.1.](#page-10-2)

For any reduced generator $f[Y_{\alpha_i,\alpha_{i,j}},Y_{\alpha_k,\alpha_{k,l}}]f^{-1}$, we see

$$
f[Y_{\alpha_i,\alpha_{i,j}},Y_{\alpha_k,\alpha_{k,l}}]f^{-1} = f(Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_k,\alpha_{k,l}})^2 Y_{\alpha_k,\alpha_{k,l}}^{-2} (Y_{\alpha_k,\alpha_{k,l}}Y_{\alpha_i,\alpha_{i,j}}^{-2}Y_{\alpha_k,\alpha_{k,l}}^{-1})f^{-1}
$$

= $f(Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_k,\alpha_{k,l}})^2 f^{-1} \cdot ft_{\beta_{k,l}}^{-1} f^{-1}$
 $f(Y_{\alpha_k,\alpha_{k,l}}t_{\beta_{i,j}}^{-1}Y_{\alpha_k,\alpha_{k,l}}^{-1})f^{-1}.$

Since f and $fY_{\alpha_k,\alpha_{k,l}}$ are in \mathcal{Y}_{LO} , $ft_{\beta_{k,l}}f^{-1}$ and $f(Y_{\alpha_k,\alpha_{k,l}}t_{\beta_{i,j}}Y_{\alpha_k,\alpha_{k,l}}^{-1})f^{-1}$ are both generators (2) in Theorem [5.1.](#page-10-2) Hence we check that either $f[Y_{\alpha_i,\alpha_{i,j}}, Y_{\alpha_k,\alpha_{k,l}}]f^{-1}$ or $f(Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_k,\alpha_{k,l}})^2f^{-1}$ is obtained from the generators (1) and (2) in Theorem [5.1.](#page-10-2) Let $i = k$. Then we calculate

$$
(Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_k,\alpha_{k,l}})^2 = \left(t_{\alpha_{j,l}}t_{Y_{\alpha_i,\alpha_{i,j}}^{-1}(\alpha_{j,l})}^{-1}\right)^2
$$

\n
$$
= t_{\alpha_{j,l}}^2(Y_{\alpha_i,\alpha_{i,j}}^{-1}t_{\alpha_{j,l}}^{-2}Y_{\alpha_i,\alpha_{i,j}})
$$

\n
$$
= t_{\alpha_{j,l}}^2Y_{\alpha_i,\alpha_{i,j}}^{-2}Y_{\alpha_i,\alpha_{i,j}}t_{\alpha_{j,l}}^{-2}Y_{\alpha_i,\alpha_{i,j}}^{-1}Y_{\alpha_i,\alpha_{i,j}}^2Y_{\alpha_i,\alpha_{i,j}}^2Y_{\alpha_i,\alpha_{i,j}}^{-1}
$$

\n
$$
= t_{\alpha_{j,l}}^2t_{\beta_{i,j}}^{-1}(Y_{\alpha_i,\alpha_{i,j}}t_{\alpha_{j,l}}^{-2}Y_{\alpha_i,\alpha_{i,j}}^{-1})t_{\beta_{i,j}}
$$

(see Figure [9](#page-14-0) (a)). Since f and $fY_{\alpha_i,\alpha_{i,j}}$ are in $\mathcal{Y}_{\text{LO}}, f(Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_k,\alpha_{k,l}})^2 f^{-1}$ is obtained from the generators (1) and (2) in Theorem [5.1.](#page-10-2) Let $j = l$. Then we calculate

$$
[Y_{\alpha_i,\alpha_{i,j}}, Y_{\alpha_k,\alpha_{k,l}}] = Y_{\alpha_i,\alpha_{i,j}} Y_{\alpha_k,\alpha_{k,j}} Y_{\alpha_i,\alpha_{i,j}}^{-1} Y_{\alpha_k,\alpha_{k,j}}^{-1}
$$

\n
$$
= Y_{Y_{\alpha_i,\alpha_{i,j}}(\alpha_k), Y_{\alpha_i,\alpha_{i,j}}(\alpha_{k,j})} Y_{\alpha_k,\alpha_{k,j}}^{-1}
$$

\n
$$
= Y_{\alpha_k,\alpha_{k,j}} Y_{\alpha_k,\alpha_{i,k}}^{-1} Y_{\alpha_k,\alpha_{k,j}}^{-1}
$$

\n
$$
= Y_{\alpha_k,\alpha_{k,j}} t_{\beta_{i,k}} Y_{\alpha_k,\alpha_{k,j}}^{-1}
$$

(see Figure [9](#page-14-0) (b)). Since $fY_{\alpha_k,\alpha_{k,j}}$ is in $\mathcal{Y}_{\text{LO}}, f[Y_{\alpha_i,\alpha_{i,j}}, Y_{\alpha_k,\alpha_{k,l}}]f^{-1}$ is obtained from the generators (1) and (2) in Theorem [5.1.](#page-10-2) Let $j = k$. Then we calculate

$$
(Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_k,\alpha_{k,l}})^2 = Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_j,\alpha_{j,l}}Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_j,\alpha_{i,j}}^{-1}Y_{\alpha_j,\alpha_{j,l}}^{-1}Y_{\alpha_i,\alpha_{i,j}}^{-1}
$$

\n
$$
Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_j,\alpha_{i,j}}^{-1}(Y_{\alpha_j,\alpha_{i,j}}Y_{\alpha_j,\alpha_{j,l}})^2
$$

\n
$$
= Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_j\alpha_{j,l}}t_{\alpha_{i,j}}^2Y_{\alpha_j\alpha_{j,l}}^{-1}Y_{\alpha_i,\alpha_{i,j}}^{-1}
$$

\n
$$
t_{\alpha_{i,j}}^2 \left(t_{Y_{\alpha_j,\alpha_{j,l}}^{-2}(\alpha_{i,l})}t_{Y_{\alpha_j,\alpha_{j,l}}^{-1}(\alpha_{i,l})}^{-1}\right)^2
$$

\n
$$
= Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_j\alpha_{j,l}}t_{\alpha_{i,j}}^2Y_{\alpha_j\alpha_{j,l}}^{-1}Y_{\alpha_i,\alpha_{i,j}}^{-1}
$$

\n
$$
t_{\alpha_{i,j}}^2(Y_{\alpha_j,\alpha_{j,l}}^{-2}t_{\alpha_{i,l}}^2Y_{\alpha_j,\alpha_{j,l}}^2 \cdot Y_{\alpha_j,\alpha_{j,l}}^{-1}t_{\alpha_{i,l}}^{-2}Y_{\alpha_j,\alpha_{j,l}})
$$

\n

= Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_j\alpha_{j,l}}t_{\alpha_{i,j}}^2Y_{\alpha_j\alpha_{j,l}}^{-1}Y_{\alpha_i,\alpha_{i,j}}^{-1}
$$

t_{\alpha_{i,j}}^2t_{\beta_{j,l}}^{-1}t_{\alpha_{i,l}}^2Y_{\alpha_{j,\alpha_{j,l}}^{-1}t_{\alpha_{i,j}}^{-1}t_{\alpha_{i,l}}^{-2}t_{\beta_{j,l}}Y_{\alpha_j,\alpha_{j,l}}^{-1}
$$

(see Figure [9](#page-14-0) (c)). Since f, $fY_{\alpha_j,\alpha_{j,l}}$ and $fY_{\alpha_i,\alpha_{i,j}}Y_{\alpha_j,\alpha_{j,l}}$ are in \mathcal{Y}_{LO} , $f(Y_{\alpha_i,\alpha_{i,j}}Y_{\alpha_k,\alpha_{k,l}})^2f^{-1}$ is obtained from the generators (1) and (2) in Theorem [5.1.](#page-10-2) Let $i < k < j < l$. Then we calculate

$$
[Y_{\alpha_i,\alpha_{i,j}}, Y_{\alpha_k,\alpha_{k,l}}] = Y_{\alpha_i,\alpha_{i,j}} Y_{\alpha_k,\alpha_{k,l}} Y_{\alpha_i,\alpha_{i,j}}^{-1} Y_{\alpha_k,\alpha_{k,l}}^{-1}
$$

\n
$$
= Y_{\alpha_i,\alpha_{i,j}} Y_{Y_{\alpha_k,\alpha_{k,l}}(\alpha_i), Y_{\alpha_k,\alpha_{k,l}}(\alpha_{i,j})}
$$

\n

= Y_{\alpha_i,\alpha_{i,j}} Y_{\alpha_i,\alpha_{i,l}}^{-1} Y_{\alpha_i,\alpha_{i,k}}^2 Y_{\alpha_i,\alpha_{i,l}} Y_{\alpha_i,\alpha_{i,k}}^2 Y_{\alpha_i,\alpha_{i,j}}
$$

Y_{\alpha_i,\alpha_{i,k}}^{-2} Y_{\alpha_i,\alpha_{i,l}}^{-1} Y_{\alpha_i,\alpha_{i,k}}^{-2} Y_{\alpha_i,\alpha_{i,l}}

= Y_{\alpha_i,\alpha_{i,j}} (t_{\beta_{i,l}}^{-1} Y_{\alpha_i,\alpha_{i,l}} t_{\beta_{i,k}} Y_{\alpha_i,\alpha_{i,l}} t_{\beta_{i,l}} t_{\beta_{i,k}}) Y_{\alpha_i,\alpha_{i,j}}
$$

\n
$$
t_{\beta_{i,k}}^{-1} t_{\beta_{i,l}}^{-1} \cdot Y_{\alpha_i,\alpha_{i,l}} t_{\beta_{i,k}}^{-1} Y_{\alpha_i,\alpha_{i,l}}^{-1} \cdot t_{\beta_{i,l}}
$$

(see Figure [9](#page-14-0) (d)). Since f, $fY_{\alpha_i,\alpha_{i,j}}$, $fY_{\alpha_i,\alpha_{i,l}}$ and $fY_{\alpha_i,\alpha_{i,j}}Y_{\alpha_i,\alpha_{i,l}}$ are in \mathcal{Y}_{LO} , $f[Y_{\alpha_i,\alpha_{i,j}},Y_{\alpha_k,\alpha_{k,l}}]f^{-1}$ is obtained from the generators (1) and (2) in Theorem [5.1.](#page-10-2) For the other cases, we have that $f[Y_{\alpha_i,\alpha_{i,j}}, Y_{\alpha_k,\alpha_{k,l}}]f^{-1} = 1$.

Thus we complete the proof.

APPENDIX A. THE CASE WHERE g is ODD

In this appendix, we prove the following.

Theorem A.1. $\mathcal{I}(N_g) \subset \mathcal{T}^2(N_g)$ if $g \geq 3$ is odd.

Proof. Recall Subsection [2.2,](#page-2-1) especially Theorem [2.2.](#page-3-4) Since $\mathcal{I}(N_3)$ is trivial, it is clear that $\mathcal{I}(N_3) \subset \mathcal{T}^2(N_3)$. Hence suppose that $g \geq 5$. By Lemma [4.6,](#page-8-2) it follows that $t_{\beta_1}t_{\beta_2}^{-1}(= t_{\beta_1}t_{\beta_2}\cdot t_{\beta_2}^{-2})$ is in $\mathcal{T}^2(N_g)$. Note that $N_g \setminus \alpha$ is a joint union of N_2

with a boundary and N_{g-2} with a boundary. Let δ be a simple closed curve such that $N_g \setminus (\alpha \cup \delta)$ is a joint union of a Möbius band, N_2 with a boundary and $\Sigma_{\frac{g-3}{2}}$ with two boundaries, as shown in Figure [10.](#page-15-13) By Lemma [4.6,](#page-8-2) it follows that $t_{\alpha}t_{\delta}^{-\frac{2}{2}}$ in $\mathcal{T}^2(N_g)$. Since $t_\delta = 1$, we have that t_α is in $\mathcal{T}^2(N_g)$. Therefore we conclude that $\mathcal{I}(N_g) \subset \mathcal{T}^2(N_g)$. Thus we finish the proof.

 \Box

By Theorems [1.1](#page-1-2) and [A.](#page-13-1)1, we have the following.

Corollary A.2. For odd $g \geq 3$, the quotient of $\mathcal{M}_2(N_g)$ by $\mathcal{T}^2(N_g)$ is isomorphic to $(\mathbb{Z}/2\mathbb{Z})^{\binom{g-1}{2}}$, and the quotient of $\mathcal{T}_2(N_g)$ by $\mathcal{T}^2(N_g)$ is isomorphic to $(\mathbb{Z}/2\mathbb{Z})^{\binom{g-1}{2}-1}.$

Remark A.3. Any Dehn twist about a separating simple closed curve is in $\mathcal{I}(N_q)$ for any genus g, and so in $\mathcal{T}^2(N_g)$ if g is odd.

Remark A.4. We do not know whether or not $\mathcal{I}(N_g) \subset \mathcal{T}^2(N_g)$ if g is even.
