SOME APPROXIMATE SOLUTIONS TO THE SPREAD OF INFLUENZA A VIRUS INFECTION

ABSTRACT. We study differential equations describing the spread of influenza A virus infection based on a mathematical model. We look for surface trajectories of the dynamical system in hand and their asymptotic behaviour.

1. Introduction

We consider the system of differential equations

where $i=2,\ldots,n_E$ and $j=2,\ldots,n_I$. We replace the value $\partial_{xx}V(x,t)$ in the model [BQRY20] by the constant a, so in this paper we deal with only the case of constant $\partial_{xx}V(x,t)$. The constants D_{PCF} and v_a correspond to the diffusion rate and to the upward transport in the periciliary fluid. In the equations c denotes the viral clearance rate, p denotes the virion producing rate and T denotes the fraction of uninfected target cells. We denote by n_I and n_E the numbers of age classes of infectious and eclipse phases, see [BQRY20].

In the present paper, in the case of a system of equations with $n_E = 0$, we propose a heuristic which shows that around $T(x,t) = \frac{c}{\tau_I p \beta}$ the system changes its behaviour. We obtain that if $\tau_I p \beta T > c$, then the trajectories tend to have asymptotic behaviour while for $\tau_I p \beta T < c$ they do not. Denote by c_E and c_I the values $\frac{n_E}{\tau_E}$ and $\frac{n_I}{\tau_I}$.

To solve the equations, we are looking for the smooth functions

$$T, E_i, I_j, V, W: \mathbb{R}^2 \to \mathbb{R}.$$

This means we are looking for a map

$$S \colon \begin{bmatrix} x \\ t \end{bmatrix} \mapsto \begin{bmatrix} T(x,t) \\ E_1(x,t) \\ \vdots \\ E_{n_E}(x,t) \\ I_1(x,t) \\ \vdots \\ I_{n_I}(x,t) \\ V(x,t) \\ W(x,t) \end{bmatrix}, \qquad S'(x,t) = \begin{bmatrix} \partial_x T(x,t) & \partial_t T(x,t) \\ \partial_x E_1(x,t) & \partial_t E_1(x,t) \\ \vdots & \vdots \\ \partial_x E_{n_E}(x,t) & \partial_t E_{n_E}(x,t) \\ \partial_x I_1(x,t) & \partial_t I_1(x,t) \\ \vdots & \vdots \\ \partial_x I_{n_I}(x,t) & \partial_t I_{n_I}(x,t) \\ \partial_x V(x,t) & \partial_t V(x,t) \\ \partial_x W(x,t) & \partial_t W(x,t) \end{bmatrix}$$

such that at every (x_0, t_0) the graph of the linear map $(x, t) \mapsto S'(x_0, t_0) \cdot \begin{bmatrix} x \\ t \end{bmatrix}$ is the same as the graph of the linear map

for all the points

$$(T, E_1, \dots, E_{n_E}, I_1, \dots, I_{n_I}, V, W) \in \mathbb{R}^{n_E + n_I + 3},$$

where

$$\alpha, \gamma_0, \gamma_1, \dots, \gamma_{n_E-1}, \delta_0, \dots, \delta_{n_I-1}, \psi \colon (T, E_1, \dots, E_{n_E}, I_1, \dots, I_{n_I}, V, W) \to \mathbb{R}$$

are some given smooth functions.

If the linear maps

$$\Phi_{T,E_1,...,E_{n_E},I_1,...,I_{n_I},V,W}$$

have rank two, then their graphs form a 2-distribution in $\mathbb{R}^{n_E+n_I+3}$ and we are looking for integral surfaces (graphs of the solutions S) of this distribution.

2. Preliminaries

Let us partition the space $\mathbb{R}^{n_E+n_I+3}$ according to different values of the first T coordinate into hyperplanes. Then for each $T \in \mathbb{R}$ consider the map

$$\varphi \colon \begin{bmatrix} E_1 \\ \vdots \\ E_{n_E} \\ I_1 \\ \vdots \\ I_{n_I} \\ V \\ W \end{bmatrix} \mapsto \begin{bmatrix} -c_E & 0 & \cdots & \cdots & 0 & 0 & 0 & \cdots & \cdots & 0 & \beta T & 0 \\ c_E & -c_E & 0 & \cdots & 0 & 0 & \cdots & \cdots & 0 & 0 & 0 \\ \vdots & & & & & & & \vdots \\ 0 & \cdots & 0 & c_E & -c_E & 0 & \cdots & \cdots & 0 & 0 \\ 0 & \cdots & 0 & 0 & c_E & -c_I & 0 & \cdots & \cdots & \cdots & 0 \\ 0 & \cdots & 0 & 0 & c_E & -c_I & 0 & \cdots & \cdots & \cdots & 0 \\ \vdots & & & & & \vdots & & & & \vdots \\ 0 & \cdots & \cdots & 0 & 0 & c_I & -c_I & 0 & \cdots & \cdots & 0 \\ \vdots & & & & & \vdots & & & & \vdots \\ 0 & \cdots & \cdots & \cdots & 0 & \cdots & 0 & c_I & -c_I & 0 & 0 \\ 0 & \cdots & 0 & 0 & \cdots & p & -c & v_a \\ 0 & \cdots \end{bmatrix} \cdot \begin{bmatrix} E_1 \\ \vdots \\ E_{n_E} \\ \hline I_1 \\ \vdots \\ \vdots \\ I_{n_I} \\ V \\ W \end{bmatrix}$$

defined by the multiplication with this coefficient matrix $A \in \mathbb{R}^{(n_E+n_I+2)\times(n_E+n_I+2)}$. Then the second column in $\mathbb{R}^{(n_E+n_I+3)}$ of the coefficient matrix of the linear map

$$\Phi_{T,E_1,...,E_{n_E},I_1,...,I_{n_I},V,W}$$

can be obtained by extending the vector

$$\varphi(E_1,\ldots,E_{n_E},I_1,\ldots,I_{n_I},V,W) + (0,\ldots,0,D_{PCF}a,\psi)$$

by the first coordinate $-\beta TV$.

For example, the first column of the matrix of the map $\Phi_{T,E_1,...,E_{n_E},I_1,...,I_{n_I},V,W}$ can be chosen to be

$$[-r_1W, r_2W, \dots, r_{n_E+n_I+2}W, a],$$

where $r_i > 0$ are constants and $r_{n_E+n_I+2} = 1$.

These two column vectors define two vector fields in $\mathbb{R}^{(n_E+n_I+3)}$. If these are linearly independent, then we have a 2-distribution and if this distribution is involutive, then there are integral surfaces for it. These surfaces are the trajectories of the differential equation.

Lemma 2.1. We have

$$(-1)^{n_E + n_I} \det(A - \lambda I) = (c_E + \lambda)^{n_E} (c_I + \lambda)^{n_I} (c + \lambda) \lambda + \beta T c_E^{n_E} p \left(c_I^{n_I} - (c_I + \lambda)^{n_I} \right)$$

for the characteristic polynomial of A.

Proof. We compute the determinant of

It is equal to

$$(-c_E - \lambda)^{n_E}(-c_I - \lambda)^{n_I}(-c - \lambda)(-\lambda) + (-1)^{n_E + n_I}\beta T c_E^{n_E} \det B,$$

where

$$B = \begin{bmatrix} c_I & -c_I - \lambda & 0 & \cdots & 0 \\ 0 & c_I & -c_I - \lambda & 0 & 0 \\ \vdots & & & \vdots \\ 0 & \cdots & c_I & -c_I - \lambda & 0 \\ p & \cdots & \cdots & p & v_a \\ 0 & \cdots & \cdots & 0 & -\lambda \end{bmatrix}$$

and

$$\det B = (-\lambda) \det B_{n_I}, \quad B_k = \begin{bmatrix} c_I & -c_I - \lambda & 0 & \cdots \\ 0 & c_I & -c_I - \lambda & 0 \\ \vdots & & & \\ 0 & \cdots & c_I & -c_I - \lambda \\ p & \cdots & \cdots & p \end{bmatrix}$$

where $3 \le k \le n_I$. We have

$$\det B_k = c_I \det B_{k-1} + (-1)^{k+1} p(-c_I - \lambda)^{k-1}$$

for $k \ge 3$ and

$$\det B_2 = \det \begin{bmatrix} c_I & -c_I - \lambda \\ p & p \end{bmatrix} = c_I p - p(-c_I - \lambda).$$

Hence

$$\det B = (-\lambda) \left(c_I \det B_{n_I-1} + (-1)^{n_I+1} p(-c_I - \lambda)^{n_I-1} \right) =$$

$$(-\lambda) \left(c_I \left(c_I \det B_{n_I-2} + (-1)^{n_I} p(-c_I - \lambda)^{n_I-2} \right) + (-1)^{n_I+1} p(-c_I - \lambda)^{n_I-1} \right) =$$

$$(-\lambda) \left(c_I^2 \det B_{n_I-2} + c_I (-1)^{n_I} p(-c_I - \lambda)^{n_I-2} + (-1)^{n_I+1} p(-c_I - \lambda)^{n_I-1} \right) =$$

$$(-\lambda) \left(c_I^3 \det B_{n_I-3} + c_I^2 (-1)^{n_I-1} p(-c_I - \lambda)^{n_I-3} + c_I (-1)^{n_I} p(-c_I - \lambda)^{n_I-2} +$$

$$(-1)^{n_I+1} p(-c_I - \lambda)^{n_I-1} \right) = \cdots =$$

$$(-\lambda) \left(c_I^{n_I-2} \det B_2 + c_I^{n_I-3} (-1)^4 p(-c_I - \lambda)^2 + \cdots + (-1)^{n_I+1} p(-c_I - \lambda)^{n_I-1} \right) =$$

$$(-\lambda) \left(c_I^{n_I-1} p + c_I^{n_I-2} p(c_I + \lambda) + c_I^{n_I-3} p(c_I + \lambda)^2 + \cdots + p(c_I + \lambda)^{n_I-1} \right).$$

This means that

$$(-1)^{n_{E}+n_{I}} \det(A - \lambda I) = (c_{E} + \lambda)^{n_{E}} (c_{I} + \lambda)^{n_{I}} (c + \lambda)\lambda + \beta T c_{E}^{n_{E}} p(-\lambda) (c_{I}^{n_{I}-1} + c_{I}^{n_{I}-2} (c_{I} + \lambda) + c_{I}^{n_{I}-3} (c_{I} + \lambda)^{2} + \cdots + (c_{I} + \lambda)^{n_{I}-1}) = (c_{E} + \lambda)^{n_{E}} (c_{I} + \lambda)^{n_{I}} (c + \lambda)\lambda + \beta T c_{E}^{n_{E}} p(-\lambda) \sum_{j=0}^{n_{I}-1} c_{I}^{j} (c_{I} + \lambda)^{n_{I}-1-j}.$$

Corollary 2.2. If $n_E = 0$, then

$$(-1)^{n_I} \det(A - \lambda I) = (c_I + \lambda)^{n_I} (c + \lambda) \lambda + \beta T p \left(c_I^{n_I} - (c_I + \lambda)^{n_I} \right).$$

3. Results

Recall that c denotes the viral clearance rate, p denotes the virion producing rate and T denotes the fraction of uninfected target cells. We denote by n_I and n_E the numbers of age classes of infectious and eclipse phases and we have $c_I = n_I/\tau_I$ and $c_E = n_E/\tau_E$. We want to determine the eigenvalues of the matrix A.

3.1. The case of $n_E = 0$. If we suppose that $n_E = 0$, then by Corollary 2.2 we have

$$(-1)^{n_I} \det(A - \lambda I) = (c_I + \lambda)^{n_I} (c + \lambda) \lambda + \beta T p \left(c_I^{n_I} - (c_I + \lambda)^{n_I} \right) =$$

$$(c_I + \lambda)^{n_I} \left((c + \lambda) \lambda - \beta T p \right) + \beta T p c_I^{n_I} = (c_I + \lambda)^{n_I} \left(\lambda^2 + c\lambda - \beta T p \right) + \beta T p c_I^{n_I},$$

denote $(c_I + \lambda)^{n_I} (\lambda^2 + c\lambda - \beta T p)$ by $F(\lambda)$. Of course F(0) < 0 so 0 is between the roots

$$\frac{-c \pm \sqrt{c^2 + 4\beta Tp}}{2}$$

of $\lambda^2 + c\lambda - \beta Tp$. This implies for example that

The derivative of $(-1)^{n_I} \det(A - \lambda I)$ is the same as the derivative of $F(\lambda)$, which is

$$n_{I}(c_{I} + \lambda)^{n_{I}-1}(c + \lambda)\lambda + (c_{I} + \lambda)^{n_{I}}\lambda + (c_{I} + \lambda)^{n_{I}}(c + \lambda) - \beta T p n_{I}(c_{I} + \lambda)^{n_{I}-1} = (c_{I} + \lambda)^{n_{I}-1} (n_{I}(c + \lambda)\lambda + (c_{I} + \lambda)(c + 2\lambda) - \beta T p n_{I}) = (c_{I} + \lambda)^{n_{I}-1} ((n_{I} + 2)\lambda^{2} + (cn_{I} + c + 2c_{I})\lambda + cc_{I} - \beta T p n_{I}).$$

Observe that

$$(-c + \sqrt{c^2 + 4\beta Tp})/2 \le -c_I$$

is impossible since

$$0 < c_I \le (c - \sqrt{c^2 + 4\beta T p})/2 < 0$$

is impossible.

3.1.1. The case of
$$-c_I \leq (-c - \sqrt{c^2 + 4\beta Tp})/2$$
. Suppose that $-c_I < (-c - \sqrt{c^2 + 4\beta Tp})/2$

so $F(\lambda)$ has two or three different roots, more simply

$$c_I \ge (c + \sqrt{c^2 + 4\beta T p})/2$$

 $2(c_I - c/2) > \sqrt{c^2 + 4\beta T p}$

which is equivalent to

$$4(c_I - c/2)^2 \ge c^2 + 4\beta T p$$

because $2(c_I - c/2) \le -\sqrt{c^2 + 4\beta Tp}$ is not possible, so

$$c_I^2 - cc_I \ge \beta T p,$$

and note that this also implies that

$$c_I > c$$
.

If n_I is even, then

$$(c_I + \lambda)^{n_I} ((c + \lambda)\lambda - \beta T p) + \beta T p c_I^{n_I}$$

has a horizontal tangency at

$$\lambda_a = -c_I$$

and a local minimum at

$$\lambda_b = \frac{-c(n_I + 1) - 2c_I + \sqrt{(c(n_I + 1) + 2c_I)^2 - 4(n_I + 2)(cc_I - \beta T p n_I)}}{2(n_I + 2)}$$

because

$$\lim_{+\infty} F = \infty.$$

Since $F(0) = -\beta T p c_I^{n_I}$, we have $F(\lambda_2) < 0$ so it also has at most one singular point between λ_a and λ_b . We have that

$$(-1)^{n_I} \det(A - \lambda I) = F(\lambda) + \beta T p c_I^{n_I}$$

is equal to 0 at $\lambda = 0$. These imply that if

$$cc_I = \beta T p n_I,$$

then the root of $det(A - \lambda I)$ is only $\lambda_0 = 0$, if

$$cc_I < \beta T p n_I$$
,

then the roots are $\lambda_0 = 0$ and some $\lambda_1 > 0$ and if

$$cc_I > \beta T p n_I$$

then the roots are $\lambda_0 = 0$ and some $-c_I < \lambda_1 < 0$.

If $n_I \geq 3$ is odd, then $\lambda = -c_I$ is just an inflection point and then we have the analogous result about the roots but in every case there is another root $\lambda_2 < -c_I$ as well.

3.1.2. The case of
$$(-c - \sqrt{c^2 + 4\beta Tp})/2 < -c_I < (-c + \sqrt{c^2 + 4\beta Tp})/2$$
. In the case of $(-c - \sqrt{c^2 + 4\beta Tp})/2 < -c_I < (-c + \sqrt{c^2 + 4\beta Tp})/2$

the function $F(\lambda)$ has again three different roots, more simply

$$(c + \sqrt{c^2 + 4\beta Tp})/2 > c_I > (c - \sqrt{c^2 + 4\beta Tp})/2$$

$$\sqrt{c^2 + 4\beta Tp} > 2c_I - c > -\sqrt{c^2 + 4\beta Tp}$$

$$|2c_I - c| < \sqrt{c^2 + 4\beta Tp}$$

$$4c_I^2 - 4cc_I < 4\beta Tp$$

$$c_I^2 - cc_I < \beta Tp.$$

If n_I is even, then $(c_I + \lambda)^{n_I} ((c + \lambda)\lambda - \beta T p) + \beta T p c_I^{n_I}$ has two local minima at

$$\lambda_{1,2} = \frac{-c(n_I + 1) - 2c_I \pm \sqrt{(c(n_I + 1) + 2c_I)^2 - 4(n_I + 2)(cc_I - \beta T p n_I)}}{2(n_I + 2)}$$

with $F(\lambda_{1,2}) < 0$ and a local maximum at $\lambda = -c_I$, where $\lambda_1 < -c_I < \lambda_2$. So $\det(A - \lambda I)$ has the roots $\lambda_0 = 0$ and $\lambda_1 > 0$ if $cc_I < \beta T p n_I$, $\lambda_0 = 0$ if $cc_I = \beta T p n_I$ and $\lambda_0 = 0$ and some $\lambda_1 < 0$ if $cc_I > \beta T p n_I$ and at most two other negative roots in each cases. If $n_I \geq 3$ is odd, then similarly to the case of $2|n_I|$ we have $\lambda_0 = 0$ and a positive or negative root depending on the same conditions and one other negative root.

This motivates the following definition.

Definition 3.1. If $c > \tau_I p \beta T$, then the system (1.1) is definite. If $c < \tau_I p \beta T$, then the system is indefinite.

If the system that we have studied is definite or indefinite, then 0 is an eigenvalue with multiplicity one. So we obtain the following.

Proposition 3.2. Let $n_E = 0$. If the system (1.1) is definite, then all the non-zero eigenvalues of the matrix of φ is negative. If the system is indefinite, then there is one positive eigenvalue and all the other non-zero eigenvalues are negative. In both cases 0 is an eigenvalue.

Proof. The statement follows from the previous arguments.

TABLE 2. The signs of the possible different eigenvalues of A in the case of odd n_I . The "-" signs in the first and second rows represent negative numbers which are smaller than $-c_I$ and in the third row the "-" signs represent a negative number which is smaller than $-c_I$ and a negative number which is bigger than $-c_I$.

Proposition 3.3. The algebraic multiplicity of all the real eigenvalues is one, except possibly for the negative eigenvalues in the brackets in the case of $2|n_I|$ and for the eigenvalue 0 in the case of $c = \beta T p \tau_I$.

Proof. The statement follows from the previous arguments.

Proposition 3.4. The geometric multiplicity of every real eigenvalue is one.

Proof. We have to solve the equation

$$(A - \lambda I)x = 0,$$

which is just

$$p \sum_{i=1}^{n_{I}} I_{i} + (-c - \lambda)V + v_{a}W = 0,$$

$$-\lambda W = 0.$$

This implies W=0 and since substituting the first n_I equations into

$$p \sum_{i=1}^{n_I} I_i + (-c - \lambda)V = 0$$

results $\det(A - \lambda I) = 0$, which can be seen after a short computation, the solution of $(A - \lambda I)x = 0$ is

$$W = 0, \quad V \in \mathbb{R}, \quad I_k = \frac{c_I^{k-1}}{(c_I + \lambda)^k} \beta T V,$$

which means that the geometric multiplicity is equal to 1 for $\lambda \neq 0$. If $\lambda = 0$, then the solution is

$$V \in \mathbb{R}, \quad I_1 = \beta T V / c_I, \quad I_k = I_{k-1}, \quad p \sum_{i=1}^{n_I} I_i - cV + v_a W = 0$$

so the geometric multiplicity is equal to 1.

Corollary 3.5. The eigenvectors for $\lambda \neq 0$ are

$$\left[\frac{1}{c_I+\lambda}\beta TV, \frac{c_I}{(c_I+\lambda)^2}\beta TV, \dots, \frac{c_I^{n_I-1}}{(c_I+\lambda)^{n_I}}\beta TV, V, 0\right],$$

where $V \in \mathbb{R}$ and for $\lambda = 0$ they are

$$\left[\frac{1}{c_I}\beta TV, \frac{1}{c_I}\beta TV, \dots, \frac{1}{c_I}\beta TV, V, \frac{\beta Tp\tau_I - c}{-v}V\right],$$

where $V \in \mathbb{R}$.

In the following, suppose that $n_E = 0$. According to the previous arguments by parametrizing everything by T let us write and denote the space \mathbb{R}^{n_I+3} as

$$\mathbb{R} \oplus \mathbb{R}^{n_I+2} = \mathbb{V} \oplus \mathbb{V}_T^- \oplus \mathbb{V}_T^+ \oplus \mathbb{V}_T^0,$$

where the first \mathbb{V} summand stands for the variable T, the summand \mathbb{V}_T^- is the eigenspace for the negative eigenvalues, the summand \mathbb{V}_T^+ is the eigenspace for the positive eigenvalues and the last \mathbb{V}_T^0 summand stands for the eigenvalue 0. Then we get the vector field

$$\Phi_{T,I_1,\dots,I_{n_I},V,W} \in \mathbb{R}^{n_I+3}$$

by computing at first the vector field

$$\varphi(I_1,\ldots,I_{n_I},V,W)\in\mathbb{V}_T^-\oplus\mathbb{V}_T^+\oplus\mathbb{V}_T^0$$

and then by taking the vector field

$$\varphi(I_1,\ldots,I_{n_I},V,W) + (0,\ldots,0,D_{PCF}a,0) + (0,\ldots,0,\psi).$$

This last addition modifies $\varphi(I_1, \ldots, I_{n_I}, V, W)$ only in its last two coordinates in \mathbb{R}^{n_I+2} . After this we add $-\beta TV$ in the first coordinate \mathbb{R} in $\mathbb{R} \oplus \mathbb{R}^{n_I+2}$.




FIGURE 1. The sketch of the vector fields for $T < \frac{c}{\tau_I p \beta}$, $T = \frac{c}{\tau_I p \beta}$ and $T > \frac{c}{\tau_I p \beta}$, respectively, from the left to the right hand side. The subspace $\mathbb{V}_T^{0'}$ is a component of \mathbb{V}_T^0 .

The map φ has negative eigenvalues in the direction \mathbb{V}_T^- , an eigenvalue 0 in the direction of \mathbb{V}_T^0 and a positive eigenvalue in the direction of \mathbb{V}_T^+ depending on whether the state of the system is definite or indefinite (the presence of the positive eigenvalue changes at $T = \frac{c}{\tau_{IP}\beta}$). The last coordinate of the vector field $\varphi(I_1, \ldots, I_{n_I}, V, W)$ is equal to 0. By omitting \mathbb{V}_T^0 it is easy to sketch this vector field depending on the value of T, see Figure 1.

When we add $(0, ..., 0, D_{PCF}a, 0)$, all the vector fields are modified by the constant $D_{PCF}a$ in one coordinate direction. Then in the space $\mathbb{V}^{n_I} \oplus \mathbb{V}^2 = \mathbb{R}^{n_I+2}$ we add $(0, ..., 0, \psi)$ to the previously constructed vector field. If the value of $|\psi| = |\partial_{xt}V(x, t)|$ is small, then adding it does not modify the picture too much.
