# Concurrent Realizability on Conjunctive Structures

## 1 Introduction

The point of this work is to explore axiomatisations of concurrent computation using the technology of proof theory and realizability.

Justifications for this work:

- Type systems for concurrent calculi are diverse and heterogeneous, there is no consensual common logical foundation.
- The situation is similar regarding semantics of processes.

Arguments for this approach:

- Realizability is a fruitful and flexible tool for relating intuitionistic and classical logics with computation models, including control, effects, etc.
- It does not assume a pre-existing logical structure but only a basic notion of composition.
- The framework of implicative structures and related systems unifies computational objects (programs) and types (behaviours) in a common structure.
- This is especially relevant when considering concurrent processes where it is customary to use process both as specifications and implementations.


## 2 Definitions

### 2.1 Processes and processes with fusions

We start by describing the language of processes which are the realizers of the concurrent realizability. We define the Processes With Fusions (PWF) which are pairs $(P, e)$ where $P$ is a $\pi$-term and $e$ is a fusion identifying channels. Those fusions are formalized as equivalence relations on $\mathbb{N}$ (i.e.: on the set of names) where each equivalence class is finite

Firstly we remember the definitions of $\pi$-calculus without additions and replication. We restrict to this calculus and the corresponding fragment of linear logic following the approach of Honda \& Yoshida on his article Combinatory Representation of Mobile Processes [5]. For the actions of emissions (resp. receptions) we choose to take actions which are binders for the names which are emitted (resp. received), following the symmetric approach given by Beffara on his PhD thesis [8] .

After that we define the (PWF)-processes and redefine the usual constructions of $\pi$-calculus for the processes with fusions.

Definition 2.1. The set $\Pi$ of $\pi$-processes is defined by the following grammar:

$$
P, Q::=\mathbb{1}|(P \mid Q)| u^{\varepsilon}(\vec{x}) \cdot P \mid(\nu x) P
$$

where $\vec{x}$ is a vector of names, $x$ and $u$ are names and $\varepsilon$ is a polarity. The expressions of the shape $u^{\varepsilon}(\vec{x})$ are called actions and whenever it is not necessary to specify $u, \varepsilon$ and $\vec{x}$, we write simply $\alpha, \beta, \gamma, \ldots$ to denote action.

The free names of a process $P$ is defined by induction:

- $F(\mathbb{1}):=\emptyset$.
- $\mathrm{F}(P \mid Q):=\mathrm{F}(P) \cup \mathrm{F}(Q)$.
- $\mathrm{F}\left(u^{\varepsilon}(\vec{x}) \cdot P\right):=(\mathrm{F}(P) \backslash\{\vec{x}\}) \cup\{u\}$.
- $\mathrm{F}((\nu x) P):=\mathrm{F}(P) \backslash\{x\}$.

As usual, processes are considered up to $\alpha$-conversion. The structural equivalence on processes is defined by the following rules:

- $(\Pi, \mid, \equiv)$ is an abelian monoid, i.e.: $\mathbb{1}|P \equiv P, P| Q \equiv Q \mid P$ and $(P \mid Q)|R \equiv P|(Q \mid R)$.
- $P \equiv(\nu x) P$ and $P \mid(\nu x) Q \equiv(\nu x)(P \mid Q)$ whenever $x \notin \mathrm{~F}(P)$. Moreover, $(\nu x)(\nu y) P \equiv(\nu y)(\nu x) P$ and we write $(\nu x y) P:=(\nu x)(\nu y) P$.
- $\equiv$ is a congruence, i.e.:

$$
\frac{P \equiv P^{\prime}}{\frac{u^{\varepsilon}(\vec{x}) \cdot P \equiv u^{\varepsilon}(\vec{x}) \cdot P^{\prime}}{P\left|Q \equiv P^{\prime}\right| Q}} \quad \frac{P \equiv P^{\prime}}{(\nu x) P \equiv(\nu x) P^{\prime}}
$$

Definition 2.2. A substitution is a function $\sigma \in \mathbb{N}^{\mathbb{N}}$. Given a substitution $\sigma$ and a set $X \subseteq \mathbb{N}$ we denote by $\sigma \backslash X$ the restriction $\sigma_{\mid X^{c}}: X^{c} \rightarrow \mathbb{N}$. We define the action of substitutions over $\pi$-processes by means of:

- $\mathbb{1}_{\sigma}:=\mathbb{1}$.
- $(P \mid Q)_{\sigma}:=P_{\sigma} \mid Q_{\sigma}$.
- $\left(u^{\varepsilon}(\vec{x}) \cdot P\right)_{\sigma}:=u_{\sigma}^{\varepsilon}(\vec{x}) \cdot P_{\sigma \backslash\{\vec{x}\}}$ possibly renaming the bound names $\vec{x}$ to prevent the capture of free names.
- $((\nu x) . P)_{\sigma}:=(\nu x) \cdot P_{\sigma \backslash\{x\}}$ possibly renaming the bound name $x$ to prevent the capture of free names.

Intuitively, fusions are connections between channels. The fundamental properties of connections are that every channel is de facto connected to itself and that if $a$ is connected to $b$ and $b$ is connected to $c$, then $a$ and $c$ are connected. Unlikely what happens on the Beffara's polarized $\pi$ calculus [8], we present connections that are not oriented. Then, the connection relationship is a symmetric relation. We conclude that the connection relationship are equivalence relations on names.

For technical reasons we ask that each name be fused with a finite number of names (i.e.: the equivalence classes are finite sets). On the other hand, we allow that infinitely many names are fused to another name (i.e.: there are infinitely many non trivial equivalence classes).

We observe that on the Beffara's polarized $\pi$-calculus [8], to give a process the type $\vdash A^{\perp}, A$, it is needed to assign to $A$ and $A^{\perp}$ an interface of polarized names, which determines the parallel composition of finite fusions that have type $\vdash A^{\perp}, A$. Because our fusions potentially involve infinitely many channels, we can give to a unique process (in fact a fusion) the type $\vdash A^{\perp}, A$.

Definition 2.3. The set of fusions is $\mathcal{E}:=\left\{e \subseteq \mathbb{N}^{2} \mid e\right.$ is an equivalence relation and $(\forall x \in \mathbb{N})[x]_{e}$ is finite $\}$. The minimum fusion is $\Delta_{\mathbb{N}}:=\{(x, x) \mid x \in \mathbb{N}\}$. Given $e, f \in \mathcal{E}, x \in \mathbb{N}$ and $\sigma \in \mathbb{N}^{\mathbb{N}}$ we define also:

- $[x]_{e}:=\{y \in \mathbb{N} \mid x \underset{e}{\sim} y\}$ (the equivalence class of $x$ ). Also define the domain of $e$ as $|e|:=\left\{x \in \mathbb{N} \mid[x]_{e} \neq\{x\}\right\}$.
- $e \vee f=e f=\operatorname{tcl}(e \cup f)$ where tcl is the transitive closure (since $e \cup f$ is simmetric and reflexive, $e \vee f \in \mathcal{E}$ ).
- Given $X \subseteq \mathbb{N}$, we define $e \cap X:=\left(e \cap X^{2}\right) \cup \Delta_{\mathbb{N}}$ and $e \backslash X:=e \cap X^{c}=\left(e \backslash\left(X^{c}\right)^{2}\right) \cup \Delta_{\mathbb{N}}$.


## Proposition 2.4.

1. Given fusions $e, f$ and sets $X, Y, e \vee f=e f, e \cap X$ and $e \backslash X$ are fusions.
2. $(e \cap X) \cap Y=e \cap(X \cup Y)$ and $(e \backslash X) \backslash Y=e \backslash(X \cup Y)$.
3. The set of fusions together with $\vee, \cap$ is a lattice $(\mathcal{E}, \vee, \cap)$ with the following properties:
(a) $\Delta_{\mathbb{N}}$ is the minimum element of $\mathcal{E}$. However, $\mathcal{E}$ has no maximum element.
(b) Given $e, f, g \in \mathcal{E},(e \cap g) \vee(f \cap g) \subseteq(e \vee f) \cap g$ and in general the converse inclusion is false.
(c) Given $e, f, g \in \mathcal{E}$, $(e \cap f) \vee g \subseteq(e \vee g) \cap(f \vee g)$ and in general the converse inclusion is false

Proof. 1,2 are straightforward.
3 The first sentence is a direct verification. For the second observe that since $(e \cap g) \cup(f \cap g)=(e \cup f) \cap g \subseteq(e \vee f) \cap g$, then $(e \cap g) \vee(f \cap g) \subseteq(e \vee f) \cap g$. The converse inclusion is in general false: consider the counterexample $e:=\left\{x_{0} \leftrightarrow x_{1}\right\}, f:=\left\{x_{1} \leftrightarrow x_{2}\right\}$ and $g:=\left\{x_{0} \leftrightarrow x_{2}\right\}$. Clairly $x_{1} \stackrel{(e \vee f) \cap g}{\longleftrightarrow} x_{2}$ but since $e \cap g=f \cap g=\Delta_{\mathbb{N}}$ then $(e \cap g) \vee(f \cap g)=\Delta_{\mathbb{N}}$ and hence $\left(x_{0}, x_{2}\right)$ are not related by $(e \cap g) \vee(f \cap g)$. For the third sentence the reasoning is similar, with the same relations $e, f, g$ and the couple $\left(x_{1}, x_{2}\right)$ as a counterexample for the converse inclusion.

## Definition 2.5.

- Given $e \in \mathcal{E}$ and $x \in \mathbb{N}$ we define $x_{e}^{\bullet}:=\min [x]_{e}$ and $x_{e}^{*}:= \begin{cases}x & \text { if }[x]_{e}=\{x\} \\ \min \left([x]_{e} \backslash\{x\}\right) & \text { if }[x]_{e} \neq\{x\}\end{cases}$ Define $\sigma_{e}: \mathbb{N} \rightarrow \mathbb{N}$ s.t. $\forall x \in \mathbb{N} \quad \sigma_{e}(x):=x_{e}^{\bullet}$.
- Given a substitution $\sigma \in \mathbb{N}^{\mathbb{N}}$ and a fusion $e \in \mathcal{E}$, we define $e_{\sigma}:=\operatorname{trcl}(\{(\sigma(x), \sigma(y)) \mid x \underset{e}{\sim} y\})$.

Lemma 2.6. Let us consider $e \in \mathcal{E}$ and $x \in \mathbb{N}$. Then $\sigma_{e \backslash\{x\}} \circ\left\{x:=x_{e}^{*}\right\}=\left\{x:=x_{e}^{*}\right\} \circ \sigma_{e}$
Proof. Observe that

$$
\sigma_{e \backslash\{x\}}(z)= \begin{cases}z_{e}^{\bullet} & \text { if } z \nsim x \\ x_{e}^{*} & \text { if } z \neq x \underset{e}{ } z \\ x & \text { if } z=x\end{cases}
$$

Let us denote by $\tau:=\sigma_{e \backslash\{x\}} \circ\left\{x:=x_{e}^{*}\right\}$ and $\rho:=\left\{x:=x_{e}^{*}\right\} \circ \sigma_{e}$. To prove that $\tau=\rho$ we have two cases:

- If $z \not \chi_{e} x$, then $\tau(z)=\sigma_{e \backslash\{x\}}(z)=z_{e}^{\bullet}$ and $\rho(z)=\left\{x:=x_{e}^{*}\right\}\left(z_{e}^{\bullet}\right)=z_{e}^{\bullet}$, thus proving the result.
- If $z \underset{e}{\sim} x$ then $\tau(z)=x_{e}^{*}$, whether $z=x$ or not. On the other hand, $\rho(z)=\left\{x:=x_{e}^{*}\right\}\left(z_{e}^{\bullet}\right)=\left\{x:=x_{e}^{*}\right\}\left(x_{e}^{\bullet}\right)$ and we have two cases of analysis:
- If $x \neq x_{e}^{\bullet}$, then $x_{e}^{\bullet}=x_{e}^{*}\left(\right.$ because $x_{e}^{\bullet}=x_{e}^{*}$ iff $\left.x \neq x_{e}^{\bullet}\right)$ and hence $\left\{x:=x_{e}^{*}\right\}\left(x_{e}^{\bullet}\right)=x_{e}^{\bullet}=x_{e}^{*}$.
- If $x=x_{e}^{\bullet}$, then $\left\{x:=x_{e}^{*}\right\}\left(x_{e}^{\bullet}\right)=x_{e}^{*}$.

Definition 2.7. Let us consider $\sigma, \tau: \mathbb{N} \rightarrow \mathbb{N}$. We say that $\sigma \sim \tau$ (we say they are equivalent) iff exists a finite permutation $\rho$ s.t. $\sigma=\rho^{-1} \circ \tau \circ \rho$.

Lemma 2.8. Let us consider $x, y \in \mathbb{N}, e \in \mathcal{E}$ and $\sigma:=\left\{y:=y_{e}^{*}\right\}, \tau:=\left\{x:=x_{e \backslash\{y\}}^{*}\right\}, \sigma^{\prime}:=\left\{x:=x_{e}^{*}\right\}$ and $\tau^{\prime}:=\left\{y:=y_{e \backslash\{x\}}^{*}\right\}$. Then:

1. If $[x]_{e}=[y]_{e}=\{x, y\}$, then $\tau \circ \sigma=\{y:=x\}$ and $\tau^{\prime} \circ \sigma^{\prime}=\{x:=y\}$.
2. If $x \not{\underset{e}{e}}_{\nsim y}$ or $[x]_{e}=[y]_{e} \subset\{x, y\}$, then $\tau \circ \sigma=\tau^{\prime} \circ \sigma^{\prime}$.

In both cases we conclude that $\tau \circ \sigma \sim \tau^{\prime} \circ \sigma^{\prime}$.
Proof. For $x=y$ is clear. If $x \neq y$ there are two cases:

1. $x \underset{e}{\sim} y$. This case splits into two subcases:
(a) $[x]_{e}=[y]_{e}=\{x, y\}$. Observe that $x_{e}^{*}=y, y_{e \backslash\{x\}}^{*}=y, y_{e}^{*}=x$ and $x_{e \backslash\{y\}}^{*}=x$ and then $\tau \circ \sigma=\sigma=\{y:=x\}$ and $\tau^{\prime} \circ \sigma^{\prime}=\sigma^{\prime}=\{x:=y\}$ which are equivalent by means of the permutation (in fact a transposition) (xy).
(b) $[x]_{e}=[y]_{e} \subset\{x, y\}$. Let us consider $z=\min \left([x]_{e} \backslash\{x, y\}\right)$. Without loss of generality we can suppose that $x<y$. Then we have three subcases:
i. $z<x<y$. In this case $x_{e}^{*}=z, y_{e \backslash\{x\}}^{*}=z$ and $y_{e}^{*}=z, x_{e \backslash\{y\}}^{*}=z$. Thus $\sigma=\tau^{\prime}=\{y:=z\}$, $\sigma^{\prime}=\tau=\{x:=z\}$ and hence $\tau \circ \sigma=\tau^{\prime} \circ \sigma^{\prime}$ (which are equivalent by means of the identity).
ii. $x<z<y$. In this case $x_{e}^{*}=z, y_{e \backslash\{x\}}^{*}=z$ and $y_{e}^{*}=x, x_{e \backslash\{y\}}^{*}=z$. Thus $\sigma=\{y:=x\}, \tau=\{x:=z\}$, $\sigma^{\prime}=\{x:=z\}$ and $\tau^{\prime}=\{y:=z\}$ from which we get $\tau \circ \sigma=\{y:=z, x:=z\}=\tau^{\prime} \circ \sigma^{\prime}$.
iii. $x<y<z$. In this case $x_{e}^{*}=y, y_{e \backslash\{x\}}^{*}=z$ and $y_{e}^{*}=x, x_{e \backslash\{y\}}^{*}=z$. Thus $\sigma=\{y:=x\}$, $\tau=\{x:=z\}, \sigma^{\prime}=\{x:=y\}$ and $\tau^{\prime}=\{y:=z\}$ from which we get $\tau \circ \sigma=\{y:=z, x:=z\}=\tau^{\prime} \circ \sigma^{\prime}$.
 $\sigma=\tau^{\prime}\left\{y:=y^{\prime}\right\}, \sigma^{\prime}=\tau=\left\{x:=x^{\prime}\right\}$ from which we get $\tau \circ \sigma=\left\{x:=x^{\prime}, y:=y^{\prime}\right\}=\tau^{\prime} \circ \sigma^{\prime}$.

Definition 2.9. The set of processes with fusions (PWF) is $\bar{\Pi}:=\Pi \times \mathcal{E}$. Given $(P, e),(Q, f) \in \bar{\Pi}$ we say that they are structurally equivalent iff $P_{\sigma_{e}} \equiv Q_{\sigma_{f}}$ and $e=f$ and we write $(P, e) \equiv(Q, f)$.

We define the free names of a (PWF) (P,e) by means of $\mathrm{F}(P, e):=N_{P} \cup|e|$ where $N_{P}:=\left\{x \in \mathbb{N} \mid[x]_{e} \cap \mathrm{~F}(P) \neq \emptyset\right\}$.
Thus the free names of $(P, e)$ are all the names which are equivalent to some free name of $P$ along with all the names which are on the domain of $e$. Observe that since $\mathrm{F}(P)$ is finite and the equivalence classes of $e$ are finite, then $N_{P}$ is finite.

Definition 2.10. Let us consider a $P W F(P, e)$ and a set $X \subseteq \mathbb{N}$. We denote by $(P, e) \backslash X$ the $P W F(P, e \backslash X)$.
Definition 2.11. We fix injections $\iota_{1}, \iota_{2}: \mathbb{N} \rightarrow \mathbb{N}$ such that $\iota_{1}(\mathbb{N}) \cap \iota_{2}(\mathbb{N})=\emptyset$ and $\iota_{1}(\mathbb{N}) \cup \iota_{2}(\mathbb{N})=\mathbb{N}$. For instance, we can take $\iota_{1}(n):=2 n+1$ and $\iota_{2}(n):=2 n$. We use the following notations: $\mathbb{N}^{i}:=\iota_{i}(\mathbb{N})$, n. $:=\iota_{i}(n)$ and the substitution $P^{i}:=P_{\iota_{i}}$ for $i=1,2$.

### 2.2 The $\nu$-binder

Following we define a $\nu$-binder for PWF. The result of $(\nu x)(P, e)$ must be $(Q, f)$ where $x \notin \mathrm{~F}(Q, f):=N_{Q} \cup|f|$. Let us consider $(\nu x)\left(x^{\dagger}(), x \leftrightarrow y\right)$. Even if $x$ must be bind on $(\nu x)\left(x^{\uparrow}(), x \leftrightarrow y\right)$, since $x$ is fused with $y$, the reasonable definition for $(\nu x)\left(x^{\uparrow}(), x \leftrightarrow y\right)$ is $\left(y^{\uparrow}(), \Delta_{\mathbb{N}}\right)$. On the other hand, if we have $(\nu x)\left(x^{\uparrow}(), \Delta_{\mathbb{N}}\right)$, what we expect is simply bind $x$ on the process side, i.e.: $(\nu x)\left(x^{\uparrow}(), \Delta_{\mathbb{N}}\right)=\left((\nu x) x^{\uparrow}(), \Delta_{\mathbb{N}}\right)$.

Both situations are covered by the following definition by cases:

$$
(\nu x)(P, e):= \begin{cases}\left(P\left\{x:=x_{e}^{*}\right\}, e \backslash\{x\}\right) & \text { if } x \in|e| \\ ((\nu x) P, e) & \text { otherwise }\end{cases}
$$

The following definition includes up to $\alpha$-equivalence both cases into a single sentence:
Definition 2.12. Let us consider $(P, e) \in \bar{\Pi}$ and $x \in \mathbb{N}$. We define $(\nu x)(P, e):=\left((\nu x) P\left\{x:=x_{e}^{*}\right\}, e \backslash\{x\}\right)$.
Remark 2.13. Observe that if $[x]_{e} \neq\{x\}$ then $\left((\nu x) P\left\{x:=x_{e}^{*}\right\}, e \backslash\{x\}\right) \equiv\left(P\left\{x:=x_{e}^{*}\right\}, e \backslash\{x\}\right)$. Indeed: since $[x]_{e} \neq\{x\}$ then $x \neq x_{e}^{*}$ which implies $x \notin \mathrm{~F}\left(P\left\{x:=x_{e}^{*}\right\}\right)$ and hence $(\nu x) P\left\{x:=x_{e}^{*}\right\} \equiv P\left\{x:=x_{e}^{*}\right\}$.

On the other hand, if $[x]_{e}=\{x\}$, then $x=x_{e}^{*}$ and then $(\nu x)(P, e)=((\nu x) P, e)$.
Corollary 2.14. Let us consider a (PWF)-process $(P, e)$ and names $x, y$. Then $(\nu x)(\nu y)(P, e) \equiv_{\alpha}(\nu y)(\nu x)(P, e)$. More generally, given a finite set $X=\left\{x_{1}, \ldots, x_{n}\right\} \subseteq \mathbb{N}$ and any permutation $\rho$ of $n$ elements, then

$$
\left(\nu x_{1}\right) \ldots\left(\nu x_{n}\right)(P, e) \equiv_{\alpha}\left(\nu x_{\rho(1)}\right) \ldots\left(\nu x_{\rho(n)}\right)(P, e)
$$

Proof. Observe that $(\nu x)(\nu y)(P, e)=(\nu x)\left((\nu y) P\left\{y:=y_{e}^{*}\right\}, e \backslash\{y\}\right)=\left((\nu x y) P\left\{y:=y_{e}^{*}\right\}\left\{x:=x_{e \backslash\{y\}}^{*}\right\}, e \backslash\{x, y\}\right)$. By Lemma 2.8 this is $\alpha$-equivalent to $\left((\nu y x) P\left\{x:=x_{e}^{*}\right\}\left\{y:=y_{e \backslash\{x\}}^{*}\right\}, e \backslash\{x, y\}\right)=$ $(\nu y)\left((\nu x) P\left\{x:=x_{e}^{*}\right\}, e \backslash\{x\}\right)=(\nu y)(\nu x)(P, e)$. The generalization to finite sets is straightforward.

Definition 2.15. Given a finite set of names $X:=\left\{x_{1}, \ldots, x_{k}\right\}$ s.t. $x_{1}<\cdots<x_{k}$ we define $(\nu X)(P, e):=$ $\left(\nu x_{k}\right) \ldots\left(\nu x_{1}\right)(P, e)$. If we consider processes up to $\alpha$-conversion the choice of an order on $X$ is unnecessary.

The latter gives -at least of $\alpha$-equivalence- a definition of the binder $(\nu X)$ for any finite set $X$. In order to define a binder $(\nu X)$ where $X$ is an infinite set, it is necessary at least to bind the names of $X_{P}:=\mathrm{F}(P) \cap X$, which is a finite set. However, it is possible that due to the substitutions defined by the $\nu$-operator, new names appear that must also be bind. For instance, let us consider the following case for $P=n .1^{\uparrow}()$ and try to intuitively compute

$$
\left(\nu_{1}\right)(P, n .1 \leftrightarrow m .1 ; k .1 \leftrightarrow k .2)=\left(\nu_{1}\right)\left(n .1^{\uparrow}(), n .1 \leftrightarrow m .1 ; k .1 \leftrightarrow k .2\right) \text { where } \nu_{1} \text { means } \nu \mathbb{N}^{1}
$$

The set $X_{P}=\{n .1\}$ and $(\nu n .1)\left(n .1^{\uparrow}(), n .1 \leftrightarrow m .1 ; k .1 \leftrightarrow k .2\right)=\left(m .1^{\uparrow}(), k .1 \leftrightarrow k .2\right)$. It is clear that a reasonable definition of $\left(\nu_{1}\right)(P, e)$ must give a process whose free names are not members of $\mathbb{N}^{1}$. Then we need to bind also m. 1 on the process side and $k .1$ on the fusion side.

The following does the job: $\left(\nu_{1}\right)\left(n .1^{\uparrow}(), n .1 \leftrightarrow m .1 ; k .1 \leftrightarrow k .2\right):=(\nu n .1, m .1)\left(n .1^{\uparrow}(), n .1 \leftrightarrow m .1 ; k .1 \leftrightarrow k .2\right) \backslash \mathbb{N}^{1}=$ $(\nu m .1)(\nu n .1)\left(n .1^{\uparrow}(), n .1 \leftrightarrow m .1 ; k .1 \leftrightarrow k .2\right) \backslash \mathbb{N}^{1}=(\nu m .1)\left(m .1^{\uparrow}(), k .1 \leftrightarrow k .2\right) \backslash \mathbb{N}^{1}=\left((\nu m .1) m .1^{\uparrow}(), k .1 \leftrightarrow k .2\right) \backslash \mathbb{N}^{1}=$ $\left((\nu m .1) m .1^{\uparrow}(), \Delta_{\mathrm{N}}\right)$.

It is clear that the fusion side should be uniformly bind over $\mathbb{N}^{1}$ at the end of the calculation. But the exact finite set of names to pass to the operator $\nu$ demands to treat the substitution hereditarily:

Definition 2.16. Let us consider a set of names $X$ and a finite subset $S$. We recursively define the following sequence $\left(S_{n}, \sigma_{n}\right) \in \mathcal{P}(X) \times \mathcal{E}:$

- $S_{0}:=S, \sigma_{0}:=\emptyset$.
- Suppose that $S_{n}=\left\{s_{1}, \ldots, s_{k}\right\}$ (in increasing order). Let us define $\sigma_{n+1}: S_{n} \rightarrow \mathbb{N}$ given by:

\end{aligned}

And define $S_{n+1}:=S_{n} \cup\left(\left\{t_{1}, \ldots, t_{k}\right\} \cap X\right)$.
Proposition 2.17. With the hypothesis and the notations of Definition 2.16 we have:

1. For all $n \in \mathbb{N}$ we have $S_{n} \subseteq[S]_{e}:=\{y \in \mathbb{N} \mid \exists x \in S \quad x \underset{e}{\sim} y\}$ and $S_{n} \subseteq S_{n+1}$
2. $[S]_{e}:=\bigcup_{x \in S}[x]_{e}$ is finite and hence there exists $m \in \mathbb{N}$ s.t. $\forall n>m \quad S_{n}=S_{m}$.
3. Let us define $m:=\min \left\{n \in \mathbb{N} \mid S_{n}=S_{n+1}\right\}$. Suppose that $S_{m}:=\left\{s_{1}, \ldots, s_{k}\right\}$. Then, for all $h \in\{1, \ldots, k\}$ we have one of the following:
(a) $t_{h} \in X$ and $s_{h}<t_{h}$.
(b) $t_{h} \notin X$ and $\forall j>h$ if $s_{j} \underset{e}{\sim} s_{h} \Longrightarrow t_{j}=t_{h}$.
4. Let us consider $m:=\min \left\{n \in \mathbb{N} \mid S_{n}=S_{n+1}\right\}$ and suppose that $[x]_{e} \cap X^{c} \neq \emptyset$ for all $x \in S_{m}$. Then $\sigma_{m+1}: S_{m} \rightarrow X^{c}$. In particular, if $X=\mathbb{N}^{1}$, then $\sigma_{m+1}: S_{m} \rightarrow \mathbb{N}^{2}$. Moreover $\sigma_{m+1}$ is constant over each equivalence class of $e \cap S_{m}$.
Proof.
5. By induction, since $S_{0} \subseteq[S]_{e}$ and $S_{n} \subseteq[S]_{e} \Longrightarrow S_{n+1} \subseteq[S]_{e}$. Also by definition $S_{n} \subseteq S_{n+1}$.
6. Since $e$ is a fusion, each equivalence class is finite and then $[S]_{e}$ is a finite union of finite sets. Then the increasing sequence $S_{n} \subseteq[S]_{e}$ must stabilize from some $n \in \mathbb{N}$, which ends the proof.
7. By hypothesis $S_{n+1}=S_{n}$, then $\left\{t_{1}, \ldots, t_{k}\right\} \cap X \subseteq S_{n}$.

If $t_{h} \in X$, then $t_{h} \in S_{n}$. Since $t_{h}=s_{h, e \backslash\left\{s_{1}, \ldots, s_{h-1}\right\}}^{*}$, then $t_{h} \neq s_{1}, \ldots, s_{h}$. Then we deduce that $t_{h}=s_{j}$ with $j>h$. Since $S_{n}$ is increasingly ordered we deduce that $s_{h}<t_{h}$.
If $t_{h} \notin X$ then for all $j>h t_{h} \in\left[s_{j}\right]_{e \backslash\left\{s_{1}, \ldots, s_{j}\right\}}$ and then $t_{j}=\min \left[s_{j}\right]_{e \backslash\left\{s_{1}, \ldots, s_{j}\right\}}=t_{h}$.
4. Let us consider $S_{m}=C_{1} \biguplus \cdots \biguplus C_{l}$ the decomposition of $S_{m}$ on $e \cap S_{m}$-equivalence classes. Let us consider $C_{i}=\left\{s_{i, 1}, \ldots, s_{i, r_{i}}\right\}$ where $s_{i, 1}<\cdots<s_{i, r_{i}}$. If we suppose that $t_{i, k} \in X$ for all $k \in\left\{1, \ldots, r_{i}\right\}$, by Proposition 2.17.3a we deduce $s_{i, r_{i}}<t_{i, r_{i}}$ which leads a contradiction because otherwise $t_{i, r_{i}} \in S_{m+1} \backslash S_{m}$ and then $S_{m} \neq S_{m+1}$. Then there exists a $k_{i}$ s.t. $t_{k_{i}} \notin X$ and by Proposition 2.17.3b we have that $\forall j>k_{i} t_{i, j}=t_{i, k_{i}}$. By definition, $\sigma_{m+1}$ on $C_{i}$ is the composition of the following substitutions:

which is the constant substitution $\sigma_{m+1}(x)=t_{i, k_{i}} \in X^{c}$ for all $x \in C_{i}$. Since this reasoning does not depends upon $C_{i}$, we get $\sigma_{m+1}: S_{m} \rightarrow X^{c}$ and $\sigma_{m+1}$ is constant over each equivalence class $C_{i}$.

Definition 2.18. Let us consider a set of names $X$ and a $P W F(P, e)$ and $S:=N_{P} \cap X \subseteq X$. By Definition 2.16 we have a sequence $\left(S_{n}, \sigma_{n}\right)_{n \in \mathbb{N}}$. Since $S$ is finite, by Proposition 2.17, we have a maximum set $S_{m}$ for the sequence $\left(S_{n}\right)_{n \in \mathbb{N}}$. We denote by $\left(X_{(P, e)}, \sigma_{(P, e)}\right)$ the couple $\left(S_{m}, \sigma_{m}\right)$.

Definition 2.19. Let us consider a set of names $X \subseteq \mathbb{N}$ and a $P W F(P, e)$ and consider $S:=\mathrm{F}(P) \cap X$. We define

$$
(\nu X)(P, e):=\left(\nu X_{(P, e)}\right)(P, e) \backslash X:=\left(\left(\nu X_{(P, e)}\right) P_{\sigma_{(P, e)}}, e \backslash X\right)
$$

Remark 2.20. The operator $(\nu X)$ for an infinite set is defined since $X_{\left(N_{P}, e\right)}$ is a finite set and $(Q, f) \backslash X$ is defined for any $P W F(Q, f)$ and any set $X$ (Definition 2.10).

Example 2.21. Suppose that $x<y<z$ are names. Consider: $X:=\{x, t\}, P:=x^{\uparrow}() \cdot y^{\downarrow}()$ and $e:=x \leftrightarrow y \leftrightarrow z ; t \leftrightarrow u$. We compute $\left((\nu X)(P, e)\right.$ and for that we compute $X_{(P, e)}=\{x, y, z\}$. Then:

& =(\nu z)(\nu y)\left(y^{\uparrow}() \cdot y^{\downarrow}(), y \leftrightarrow z ; t \leftrightarrow u\right) \backslash X & & =(\nu z)\left(z^{\uparrow}() \cdot z^{\downarrow}(), t \leftrightarrow u\right) \backslash X
\end{aligned}
$$

$$
=\left((\nu z) z^{\uparrow}() \cdot z^{\downarrow}, \Delta_{\mathbb{N}}\right)
$$

Lemma 2.22. Let us consider fusions e, $f$ where $|e| \subseteq \mathbb{N}^{1}$ and $|f| \subseteq \mathbb{N}^{2}$ and define $\sigma_{\tau}:=\prod_{x \in \mathbb{N}^{1}}(x \leftrightarrow \tau(x))$ for $\tau: \mathbb{N}^{1} \rightarrow \mathbb{N}^{2}$. Then:

1. ef $\sigma_{\tau} \backslash \mathbb{N}^{1}=\left\{(a, b) \in \mathbb{N}^{2} \times \mathbb{N}^{2} \mid \exists x_{0}, \ldots x_{4 k+1} \quad a=x_{0} f x_{1} \tau x_{2}\right.$ e $x_{3} \tau x_{4}, \ldots$,

$$
\left.\ldots, x_{4(k-1)} f x_{4(k-1)+1} \tau x_{4(k-1)+2} e x_{4(k-1)+3} \tau x_{4 k} f x_{4 k+1}\right\}
$$

2. $e f \sigma_{\tau} \backslash \mathbb{N}^{1}=e_{\tau} f$.

## Proof.

1. By definition of the transitive closure of $e \cup f \cup\left\{(x, \tau(x)) x \in \mathbb{N}^{1}\right\}$ we get the result. Observe that $a, b \in \mathbb{N}^{2}$ because of the restriction $\backslash \mathbb{N}^{1}$.
2. On the chain above observe that the blocks $x_{6 j+1} \tau x_{6 j+2}$ e $x_{6 j+3}$ can be replaced by $x_{6 j+1} e_{\tau} x_{6 j+3}$. This observation yields ef $\sigma_{\tau} \backslash \mathbb{N}^{1} \subseteq e_{\tau} f$. The converse inclusion is straightforward since $e_{\tau} \subseteq e f \sigma_{\tau} \backslash \mathbb{N}^{1}$.

Definition 2.23. We define the following fusions: $I:=\prod_{n \in \mathbb{N}}(n .1 \leftrightarrow n .2) ; \Psi:=\prod_{n \in \mathbb{N}}(n .1 \leftrightarrow n .1 .2)$ and $\Phi:=\Psi \quad I^{2}=$ $\prod_{n \in \mathbb{N}}(n .1 \leftrightarrow n .1 .2) \prod_{n \in \mathbb{N}}(n .1 .2 \leftrightarrow n .2 .2)$.
Corollary 2.24. Let us consider fusions e, $f$. Then:

1. $e^{1} f^{2} \Phi=\left\{(a, b) \mid \exists x_{0}, \ldots, x_{k}\right.$ s.t. $\left.a=x_{0} \Phi x_{1} e^{1} x_{2} \Phi x_{3} f^{2} x_{4} \Phi \ldots \Phi x_{k-2} e^{1} x_{k-1} \Phi x_{k}=b, k \in \mathbb{N}^{*}\right\}$.
2. $e^{1} f^{2} \Phi \backslash \mathbb{N}_{1}=e^{1.2} f^{2} \prod_{n \in \mathbb{N}}(n .1 .2 \leftrightarrow n .2 .2)=e^{1.2} f^{2} I^{2}$.
3. $e^{1} f^{2} I \backslash \mathbb{N}_{1}=e^{2} f^{2}$.

Proof.

1. By Lemma 2.22.1.
2. Applying Lemma 2.22.2: $e^{1} f^{2} \Phi \backslash \mathbb{N}^{1}=e^{1} f^{2} I^{2} \Psi \backslash \mathbb{N}^{1}=e^{1} f^{2} I^{2} \sigma_{\tau} \backslash \mathbb{N}^{1}=\left(e^{1}\right)_{\tau} f^{2} I^{2}=e^{1.2} f^{2} I^{2}$ where $\tau: \mathbb{N}^{1} \rightarrow \mathbb{N}^{1.2}, \tau(x .1):=x .1 .2$.
3. Applying Lemma 2.22.2: $e^{1} f^{2} I \backslash \mathbb{N}^{1}=e^{1} f^{2} \sigma_{\mu} \backslash \mathbb{N}^{1}=\left(e^{1}\right)_{\mu} f^{2}=e^{2} f^{2}$ where $\mu: \mathbb{N}^{1} \rightarrow \mathbb{N}^{2}, \mu(x .1):=x .2$.

Corollary 2.25. Let us consider a fusion e. Then:

1. $e^{1} \Phi=\left\{(a, b) \mid \exists x, y \quad(a, x),(y, b) \in \Phi\right.$ and $\left.(x, y) \in e^{1}\right\}$.
2. $e^{1} \Phi \backslash \mathbb{N}_{1}=e^{1.2} \prod_{n \in \mathbb{N}}(n .1 .2 \leftrightarrow n .2 .2)=e^{1.2} I^{2}$.
3. $e^{1} I \backslash \mathbb{N}_{1}=e^{1} \prod_{n \in \mathbb{N}}(n .1 \leftrightarrow n .2) \backslash \mathbb{N}_{1}=e^{2}$.

Proof. Apply the result above with $f:=\Delta_{\mathbb{N}}$.
Proposition 2.26. Let us consider $\tau: \mathbb{N}^{1} \rightarrow \mathbb{N}^{2}$ a substitution, ( $P W F$ ) processes $(P, e),(Q, f)$ s.t. $\mathrm{F}(P, e) \subseteq \mathbb{N}^{1}$ and $\mathrm{F}(Q, f) \subseteq \mathbb{N}^{2}$. Let us define $\sigma_{\tau}:=\prod_{x \in \mathbb{N}^{1}}(x \leftrightarrow \tau(x))$. Then $(\nu 1)\left(P \mid Q, e f \sigma_{\tau}\right) \equiv_{\alpha}\left(P_{\tau} \mid Q, e_{\tau} f\right)$.

Proof. By Definition $2.19(\nu 1)\left(P \mid Q, e f \sigma_{\tau}\right) \equiv{ }_{\alpha}\left(P_{\sigma} \mid Q, e f \sigma_{\tau} \backslash \mathbb{N}^{1}\right)$ for some $\sigma: S \subseteq \mathbb{N}^{1} \rightarrow \mathbb{N}^{2}$. By Lemma 2.22 $e f \sigma_{\tau} \backslash \mathbb{N}^{1}=e_{\tau} f$. It remains to proof that $\left(P_{\sigma} \mid Q, e_{\tau} f\right) \equiv_{\alpha}\left(P_{\tau} \mid Q, e_{\tau} f\right)$. For the latter, by definition of $\equiv_{\alpha}$ on (PWF), it suffices to prove that $\left(P_{\sigma} \mid Q\right)_{\rho}=\left(P_{\tau} \mid Q\right)_{\rho}$ for $\rho(x):=x_{e_{\tau} f}^{\bullet}:=\min [x]_{e_{\tau} f}$. Recall that $\sigma(x) \underset{\text { efor }}{\sim} x \underset{\text { efo }}{\sim} \tau(x)$ for all $x \in S$ and, since $\sigma(x), \tau(x) \in \mathbb{N}^{2}$, we have $\sigma(x) \underset{e f \sigma_{\tau} \backslash \mathbb{N}^{1}}{\sim} \tau(x)$, i.e. $\sigma(x) \underset{e_{\tau} f}{\sim} \tau(x)$ and then $\rho(\sigma(x))=\rho(\tau(x))$ for all $x \in S$, which ends the proof.
Definition 2.27. Given $(P, e),(Q, f)(P W F)$-processes, $u, \vec{x}$ names and $\varepsilon$ a polarity, we define:

- $(P, e) \mid(Q, f):=(P \mid Q, e f)$.
- $u^{\varepsilon}(\vec{x})(P, e):=\left(u^{\varepsilon}(\vec{x}) \cdot P, e\right)$ whenever $\forall x_{i} \in \vec{x} \quad\left[x_{i}\right]_{e}=\left\{x_{i}\right\}$ (otherwise this construction is not allowed).
- $\mathbb{1}:=\left(\mathbb{1}, \Delta_{\mathbb{N}}\right) \in \bar{\Pi}$.
- Given a set $X$ and a (PWF) $(P, e)$ we have yet defined $(\nu X)(P, e)$.

We get constructions as operators on (PWF), where those constructors are defined as follows:

## 2.3 (PWF) as a set generated by $\Pi$ and $\mathcal{E}$ under parallel composition

Now we observe that there are immersions from $\Pi$ and $\mathcal{E}$ to $\bar{\Pi}$ which preserve the constructions of $\Pi$ and the join of $\mathcal{E}$ :
Definition 2.28. Let us define $\gamma_{1}: \Pi \rightarrow \bar{\Pi}$ by means of $\gamma_{1}(P):=\left(P, \Delta_{\mathbb{N}}\right)$ and $\gamma_{2}: \mathcal{E} \rightarrow \bar{\Pi}$ by means of $\gamma_{2}(e):=(\mathbb{1}, e)$. Let us define $\bar{\Pi}_{0}:=\operatorname{Im}\left(\gamma_{1}\right)$ and $\mathcal{E}_{0}:=\operatorname{id}\left(\gamma_{2}\right)$.
Proposition 2.29. Given $P, Q \in \Pi, e, f \in \mathcal{E}$, u, x names, $\vec{x} \in \mathcal{E}_{\vec{x}}$ a vector of names and $\varepsilon$ a polarity.

1. $(P, e)=\gamma_{1}(P) \mid \gamma_{2}(e)$. Thus $\bar{\Pi}$ is generated from $\bar{\Pi}_{0} \cup \mathcal{E}_{0}$ by means of parallel composition.
2. $\gamma_{1}(\mathbb{1})=\left(\mathbb{1}, \Delta_{\mathrm{N}}\right)=\mathbb{1}$.
3. $\gamma_{1}(P)\left|\gamma_{1}(Q)=\left(P, \Delta_{\mathrm{N}}\right)\right|\left(Q, \Delta_{\mathrm{N}}\right)=\left(P \mid Q, \Delta_{\mathrm{N}}\right)=\gamma_{1}(P \mid Q)$.
4. $u^{\varepsilon}(\vec{x})\left(\gamma_{1}(P)\right)=u^{\varepsilon}(\vec{x}) \cdot\left(P, \Delta_{\mathrm{N}}\right)=\left(u^{\varepsilon}(\vec{x}) \cdot P, \Delta_{\mathrm{N}}\right)=\gamma_{1}\left(u^{\varepsilon}(\vec{x}) \cdot P\right)$.
5. $(\nu x)\left(\gamma_{1}(P)\right)=(\nu x)(P, e)=\left((\nu x) P, \Delta_{N}\right)=\gamma_{1}((\nu x) P)$.
6. $\gamma_{2}(e)\left|\gamma_{2}(f)=(\mathbb{1}, e)\right|(\mathbb{1}, f)=(\mathbb{1}, e f)=\gamma_{2}(e f)$.

Thus, identifying $P=\gamma_{1}(P)$ and $e=\gamma_{2}(e)$ we can write $(P, e)$ instead of $P \mid e$.
Proposition 2.30. We have the following properties:

1. $(\bar{\Pi}, \mid, \mathbb{1}, \equiv)$ is an abelian monoid.
2. The structural equivalence on (PWF) respects the operators $\nu, \mid,!$ and $u^{\varepsilon}$, i.e.:

\frac{(P, e) \equiv\left(P^{\prime}, e\right) \quad e \in \mathcal{E}_{\vec{x}}}{u^{\varepsilon}(\vec{x}) \cdot(P, e) \equiv u^{\varepsilon}(\vec{x}) \cdot\left(P^{\prime}, e\right)} \quad \frac{(P, e) \equiv\left(P^{\prime}, e\right)}{(P, e)\left|(Q, f) \equiv\left(P^{\prime}, e\right)\right|(Q, f)} \quad \frac{(P, e) \equiv\left(P^{\prime}, e\right)}{(\nu x)(P, e) \equiv(\nu x)\left(P^{\prime}, e\right)}
$$

Proof. The first statement is straightforward. For the second one:

- Suppose that $(P, e) \equiv\left(P^{\prime}, e\right)$, which implies that $P_{\sigma_{e}} \equiv P_{\sigma_{e}}^{\prime}$ and then $\left(\sigma_{e}(u)^{\varepsilon}(\vec{x})\right) \cdot P_{\sigma_{e}} \equiv\left(\sigma_{e}(u)^{\varepsilon}(\vec{x})\right) \cdot P_{\sigma_{e}}^{\prime}$ (observe that there is no capture of free names because $\sigma_{e}(z)=x_{i}$ iff $z=x_{i}$ for $\left.x_{i} \in \vec{x}\right)$. From that we get ( $\left.u^{\varepsilon}(\vec{x}) \cdot P, e\right) \equiv$ $\left(u^{\varepsilon}(\vec{x}) \cdot P^{\prime}, e\right)$.
- From $(P, e) \equiv\left(P^{\prime}, e\right)$, we get $(P \mid Q, e f) \equiv\left(P^{\prime} \mid Q^{\prime}, e f\right)$ because $P_{\sigma_{e}} \equiv P_{\sigma_{e}}^{\prime}$ implies that $P_{\sigma_{e f}} \equiv P_{\sigma_{e f}}^{\prime}$.
- Suppose that $(P, e) \equiv\left(P^{\prime}, e\right)$, which implies that $P_{\sigma_{e}} \equiv P_{\sigma_{e}}^{\prime}$ and let's try to prove that $(\nu x)(P, e) \equiv(\nu x)\left(P^{\prime}, e\right)$ which is equivalent to prove that $\left((\nu x) P\left\{x:=x_{e}^{*}\right\}\right)_{\sigma_{e \backslash\{x\}}} \equiv\left((\nu x) P^{\prime}\left\{x:=x_{e}^{*}\right\}\right)_{\sigma_{e \backslash\{x\}}}$. Since $\sigma_{e \backslash\{x\}}(x)=x$, equivalently we have to prove that $(\nu x) P \sigma_{e \backslash\{x\}} \circ\left\{x:=x_{e}^{*}\right\} \equiv(\nu x) P^{\prime} \sigma_{e \backslash\{x\}} \circ\left\{x:=x_{e}^{*}\right\}$. By Lemma 2.6 it is equivalent to prove that $(\nu x) P\left\{x:=x_{e}^{*}\right\} \circ \sigma_{e} \equiv(\nu x) P^{\prime}\left\{x:=x_{e}^{*}\right\} \circ \sigma_{e}$. We have two cases:

- If $x \neq x_{e}^{*}$, then $x=x_{e}^{\bullet}$ and $x \notin \operatorname{Im}\left(\left\{x:=x_{e}^{*}\right\} \circ \sigma_{e}\right)$ and we conclude that $x \notin \mathrm{~F}\left(P\left\{x:=x_{e}^{*}\right\} \circ \sigma_{e}\right)$ and $x \notin \mathrm{~F}\left(P^{\prime}\left\{x:=x_{e}^{*}\right\} \circ \sigma_{e}\right)$. ### 2.4 Parallel composition in terms of the left adjoint of implication

Remember Definition2.11, where we fix injections $\iota_{1}, \iota_{2}: \mathbb{N} \rightarrow \mathbb{N}$ such that $\iota_{1}(\mathbb{N}) \cap \iota_{2}(\mathbb{N})=\emptyset$ and $\iota_{1}(\mathbb{N}) \cup \iota_{2}(\mathbb{N})=\mathbb{N}$. More precisely we take $\iota_{1}(n):=2 n+1$ and $\iota_{2}(n):=2 n$. For $i=1,2$ we denote $(P, e)^{i}$ the process $(P, e)_{\iota_{1}}=\left(P_{\iota_{i}}, e_{\iota_{i}}\right)$, i.e. the result of applying $\iota_{i}$ to the whole names of the $\operatorname{PWF}(P, e)$. We also denote as $(P, e)^{-i}$ the process $(P, e)_{\iota_{i}^{-1}}$, which has meaning only if $\mathrm{F}(P, e) \subseteq \mathbb{N}^{i}$.

### 2.5 Poles, polarities, orthogonality and behaviours

The notion of poles is central in Classical Realizability [6], [7] and is maintained on the algebraic presentations [9], [10] and [11]. These poles are parameters for the Realizability definition and allow to give a non-trivial interpretation for negation, unlike what is done on Intuitionistic Realizability [1], [2]. The interpretation of formulæ is strongly inspired by the phase semantics [4].

We start by considering poles that are barely closed under $\alpha$-equivalence and doing the part of the theory that does not require any form of (anti)reduction closure. As is done in the semantics of phases, we interpret the language in the set of behaviors, which are the sets $X$ closed under double orthogonal (i.e.: $X=X^{\perp \perp}$ ). The fundamental connective that we will use is the multiplicative conjunction $\otimes$. Intuitively, $X \otimes Y$ corresponds to (by means of renaming) forcing processes of $X$ not to communicate with those of $Y$. As we need to get a behaviour, we close it by double orthogonal.

Using the orthogonality defined by the poles and the defined notion $\otimes$, we then introduce the connectives that correspond to the Multiplicative Linear Logic (MLL).

Definition 2.34. A pole is a set of closed processes $\Perp \subseteq \bar{\Pi}_{0}:=\{(P, e) \in \bar{\Pi} \mid \mathrm{F}(P, e)=\emptyset\}$ that is closed under $\equiv{ }_{\alpha}$, i.e.: if $(P, e) \equiv{ }_{\alpha}(Q, e) \in \Perp$ then $(P, e) \in \Perp$.

Given (PWF)-processes $(P, e),(Q, f)$ we say that they are orthogonal iff $(\bar{\nu})((P, e) \mid(Q, f)):=(\bar{\nu})(P \mid Q, e f) \in \Perp$. We write $(P, e) \perp(Q, f)$ to abbreviate that $(P, e)$ and $(Q, f)$ are orthogonal.

Given $\Perp$ we define an orthogonal operator ()$^{\perp}: \mathcal{P}(\bar{\Pi}) \rightarrow \mathcal{P}(\bar{\Pi})$ by $A^{\perp}:=\{(P, e) \in \bar{\Pi} \mid \forall(Q, f) \in A \quad(P, e) \perp(Q, f)\}$.

### 2.6 Adequacy Lemma

We define the Realizability relation on behaviours through:
Definition 2.41. Given a pole $\Perp$, a behaviour $A \in \mathbb{B}$ and a $(P W F) P$, e), we say that $(P, e)$ realizes $A$ iff $(P, e) \in A$. We will indistincly use the notations $(P, e) \Vdash A$ or $(P, e) \in A$.

As usually on Realizability, we will interpret the language of logic (in this case of MLL) as sets taken from some set whose elements have computational meaning. In our case we interpret the language on behaviours. Given a pole $\Perp$, the theory of the corresponding Realizability model is the set of formulæ whose interpretation is realized.

The result which establishes that Realizability is correctly defined is the Adequacy Lemma, which consists in proving that the rules of logic (in this case the rules of MLL) deduce true consequences from true premises. In the remainder of the section we prove all the technical lemmas to prove the Adequacy Lemma, which will be done on the next section.

Observe that the definition is correct since $\mathbb{N}^{1}=\mathbb{N}^{1.1} \biguplus \mathbb{N}^{1.2 .1} \biguplus \mathbb{N}^{2.2 .1}$ and that $\tau(x) \in \mathbb{N}^{2}$ for all $x \in \mathbb{N}^{1}$.
We have the following identities:

Definition 3．2．（Miquey［10］，［12］）A conjunctive Structure（CS）is $\mathcal{C}=\left(\mathbb{C}, \otimes,()^{\perp}, \preccurlyeq\right)$ s．t．：
1．$(\mathbb{C}, \curlyvee, \preccurlyeq)$ is a complete join semilattice（whose join is $\curlyvee$ ）．
2．$\otimes$ is a binary monotone operation of $\mathbb{C}$ and ()$^{\perp}$ is a unary antimonotone function on $\mathbb{C}$ ．
3．The join operation $\curlyvee$ is distributive w．r．t $\otimes$ ，i．e．：Given $a \in \mathbb{C}$ and $\mathfrak{B} \subseteq \mathbb{C}$ we have：
－$\Upsilon_{b \in \mathfrak{B}}(a \otimes b)=a \otimes\left(\Upsilon_{b \in \mathfrak{B}} b\right)$
－$\Upsilon_{b \in \mathfrak{B}}(b \otimes a)=\left(\Upsilon_{b \in \mathfrak{B}} b\right) \otimes a$

Remark 3．11．The definition of（CA）＇s we give here is mutatis mutandis the one given by É．Miquey on his PhD thesis［10］but adapted to the context of a linear calculus．The definition of conjunctive algebra（CA）given by Miquey is a couple $(\mathcal{A}, \mathcal{S})$ where $\mathcal{A}$ is a conjunctive structure， $\mathcal{S} \subseteq \mathbb{A}$ contains the（linear）combinators $S_{3}, S_{4}$ and $S_{5}$ ，satisfies the rules（upc）and（ mp ）（respectively：upper closure and modus ponens closure）and contains the（non－linear） combinators for weakening and contraction：

- $S_{1}:=人_{a \in \mathbb{A}} a \multimap(a \otimes a)$ ．
- $S_{2}:=人_{a, b \in \mathbb{A}}(a \otimes b) \multimap a$.

We do not use $S_{1}$ and $S_{2}$ in order to get a linear type system according to concurrency．In his thesis，Miquey also proves that combinators $S_{6}, S_{7}$ being to the separator，but his proof lies in the use of the combinators $S_{1}, S_{2}$ ．Similarly， the rules（ctx）and（ctr）are provable by by means of $S_{1}, S_{2}$ ．Here we explicitly add them to the separator．

### 3.3 The algebraic model induced by the (PWF)

Proposition 3.23. Let us consider $\mathcal{B}:=\left(\mathbb{B}, \otimes,()^{\perp}, \mathbf{1}, \subseteq\right)$ according with Definitions 2.34, 2.34, Proposition 2.35, Definition 2.37. Take $\mathcal{S}:=\mathbb{B} \backslash\{\emptyset\}$. Then $(\mathcal{B}, \mathcal{S})$ is a $(C A)$.

Proof. We have already proven all we need. Let us recap the proof, step by step:

- $(\mathbb{B}, \vee, \subseteq)$ is a complete join semilattice by Proposition 2.35.
- $\otimes$ is monotone on both arguments since $A \otimes B=(A \bullet B)^{\perp \perp}$, $\bullet$ is monotone by definition and ()$^{\perp}$ is anti-monotone by Proposition 2.36.1.
- $A \otimes \bigvee \mathfrak{B}=\bigvee_{B \in \mathfrak{B}}(A \otimes B)$ for all $\mathfrak{B} \subseteq \mathbb{B}$ and $A \in \mathbb{B}$ by Proposition 2.39.
- $(\bigvee \mathfrak{B})^{\perp}=\bigwedge_{B \in \mathfrak{B}} B^{\perp}$ for all $\mathfrak{B} \subseteq \mathbb{B}$ by Proposition 2.36 .3
- Since $\mathbb{B}$ are the subsets of (PWF) closed under ()$^{\perp \perp}$, we get by definition $A^{\perp \perp}=A$ for all $A \in \mathbb{B}$.

So far we have proven that $\mathcal{B}:=\left(\mathbb{B}, \otimes,()^{\perp}, \mathbf{1}, \subseteq\right)$ is a $(\mathrm{CS})$ with unit. To prove that $\mathcal{S}$ is a separator we use what we call the Adequation Lemma:

- All the combinators $S_{3}$ to $S_{7}$ are inhabited by Lemma 2.48 from item 2 to item 5 and then $S_{3}$ to $S_{7}$ belong $\mathcal{S}$. Then $\mathcal{S}$ satisfies the (ax)-rule on Definition 3.10. Similarly, since $\mathbb{1} \in \mathbf{1}$, then $\mathbf{1} \in \mathcal{S}$ and then $\mathcal{S}$ satisfies the (unit)-rule.
- $\mathcal{S}$ satisfies the (upc)-rule since $A \subseteq B$ where $A \neq \emptyset$ implies $B \neq \emptyset$.
- We observe that there is a general mechanism to prove that $\mathcal{S}$ satisfies a rule of the shape $\frac{G_{1} \in \mathcal{S} \quad \ldots \quad G_{k} \in \mathcal{S}}{D \in \mathcal{S}}$. Suppose we prove that $(P, e) \in G_{1} \multimap \cdots \multimap G_{k} \multimap D \in \mathcal{S}$ for some (PWF)-process ( $P, e$ ) and that there are $\left(Q_{1}, f_{1}\right) \in G_{1}, \ldots,\left(Q_{k}, f_{k}\right) \in G_{k}$.
On the other hand since $G_{1} \multimap \cdots \multimap G_{k} \multimap D \subseteq G_{1} \multimap \cdots \multimap G_{k} \multimap D$, by the adjoint $*_{1}$, we get

$$
\left(G_{1} \multimap \cdots \multimap G_{k} \multimap D\right) *_{1} G_{1} *_{1} \cdots *_{1} G_{k} \subseteq D
$$

By this remark, we have that $(P, e) *_{1}\left(Q_{1}, f_{1}\right) *_{1} \cdots *_{k}\left(Q_{k}, f_{k}\right) \in D$ and then $D \in \mathcal{S}$.
Applying this general mechanism we get:

- By Lemma 2.48.1, $I \in(A \multimap B) \multimap A \multimap B$ and then $\mathcal{S}$ satisfies the (mp)-rule.
- By Lemma 2.50 there is a $\sigma_{\tau} \in(A \multimap B) \multimap(A \otimes C) \multimap(B \multimap C)$ and then $\mathcal{S}$ satisfies the (ctx)-rule.
- By Lemma 2.49 there is a $\sigma_{\tau} \in(A \multimap B) \multimap B^{\perp} \multimap A^{\perp}$ and then $\mathcal{S}$ satisfies the (ctr)-rule.


### 3.4 Adding parallelism and combinators for pi-calculus

Definition 3.24. A Conjunctive Parallel Structure (CPS) is a Conjunctive Structure with unit $\left(\mathbb{C}, \otimes,()^{\perp}, \mathbf{1}, \preccurlyeq\right)$ together with a binary operation $(\mid): \mathbb{C} \times \mathbb{C} \rightarrow \mathbb{C}$ called parallel composition s.t. $(\mathbb{C}, \mid, \mathbf{1})$ is an abelian monoid, i.e.:

$$
\begin{aligned}
(p \mid q) \mid r & =p \mid(q \mid r) \\
p \mid \mathbf{1} & =\mathbf{1} \mid p \\
p \mid q & =q \mid p
\end{aligned}=p
$$

And the condition of compatibility between $\mid$ and $\curlyvee$ given by ${ }^{5}$ :

$$
(\bigvee \mathcal{B}) \mid a \preccurlyeq \bigvee\{b|a| b \in \mathcal{B}\}
$$

for all $\mathcal{B} \subseteq \mathbb{C}$.
$A(C P A)$ is a $(C P S) \mathcal{C}=\left(\mathbb{C}, \otimes,()^{\perp}, \mid, \mathbf{1},\right)$ together with a separator $\mathcal{S}$ s.t. $(\mathcal{C}, \mathcal{S})$ is a (CA).
Definition 3.25. Given a $(C P A) \mathcal{C}=\left(\mathbb{C}, \otimes, \mid,()^{\perp}, \mathbb{1}, \preccurlyeq\right)$ we define $\triangleright: \mathbb{C} \times \mathbb{C} \rightarrow \mathbb{C}$ by means of

$$
b \triangleright c:=\bigvee\{x \in \mathbb{C}|x| b \preccurlyeq c\}
$$

Proposition 3.26. Let us consider a (CPA) $\mathcal{C}=\left(\mathbb{C}, \otimes, \mid,()^{\perp}, \mathbf{1}, \preccurlyeq\right)$. Then for all $a, b, c \in \mathbb{C} \quad a \mid b \preccurlyeq c \Longleftrightarrow a \preccurlyeq b \triangleright c$. Proof.
$(\Longrightarrow) a \mid b \preccurlyeq c$ implies that $a \in\{x \in \mathbb{C}|x| b \preccurlyeq c\}$ and then $a \preccurlyeq b \triangleright c$.
$(\Longleftarrow)$ Since $\mid$ is monotone (because $*$ is monotone) we have $a|b \preccurlyeq(b \triangleright c)| b=(\curlyvee\{x \in \mathbb{C}|x| a \preccurlyeq c\}) \mid b \preccurlyeq$ $\curlyvee\{x|b| x \in \mathbb{C}, x \mid b \preccurlyeq c\} \preccurlyeq c$, this using the compatibility between | and $\curlyvee$.

Proposition 3.27. The $(C A)\left(\mathbb{B}, \otimes,()^{\perp}, \mathbf{1}, \subseteq\right)$ with separator $\mathcal{S}:=\mathbb{B} \backslash\{\emptyset\}$ (c.f.: Proposition 3.23) is a (CPA) with the operator || (c.f.: Definition 2.37).

Proof.

- Since $(\bar{\Pi}, \mid, \mathbb{1})$ is an abelian monoid, then $(\mathbb{B}, \|, \mathbf{1})$ is also.

[^2]－$(\bigvee \mathfrak{B}) \mid A \subseteq \bigvee\{B \| A \mid B \in \mathfrak{B}\}$ for all $\mathfrak{B} \subseteq \mathbb{B}$ and $A \in \mathbb{B}$ by Lemma 2.40 （observe that $B \mid A \subseteq B \| A$ ）．

Definition 3．28．A Combinatory Conjunctive Parallel Structure（CCPS）is a（CPS）with unit $\mathcal{C}=\left(\mathbb{C}, \otimes, \mid,()^{\perp}, \mathbf{1}, \preccurlyeq\right)$ together with an injective function $\mathbf{M}: \mathbb{N} \times \mathbb{N} \rightarrow \mathbb{C}$ ．

Definition 3．29．Given $a(C C P S) \mathcal{C}:=\left(\mathbb{C}, \otimes, \mid,()^{\perp}, \mathbf{1}, \mathbf{M}, \preccurlyeq\right)$ we define the Honda \＆Yoshida Combinators of $\mathcal{C}$ by means of：

$$
\begin{aligned}
K(a) & :=人_{x \in \mathbb{N}}(M(a, x) \triangleright \mathbf{1}) \\
F(a, b) & :=人_{x \in \mathbb{N}}(M(a, x) \triangleright M(b, x)) \\
B l(a, b) & :=人_{x \in \mathbb{N}}(M(a, x) \triangleright F(x, b)) \\
B r(a, b) & :=人_{x \in \mathbb{N}}(M(a, x) \triangleright F(b, x)) \\
D(a, b, c) & :=人_{x \in \mathbb{N}}(M(a, x) \triangleright M(b, x) \mid M(c, x)) \\

Proposition 3．30．Given a $(C C P S) \mathcal{C}=\left(\mathbb{C}, \otimes, \mid,()^{\perp}, \mathbf{1}, \mathbf{M}, \preccurlyeq\right)$ we have：

K(a) \mid M(a, x) & \preccurlyeq \mathbf{1} \\
F(a, b) \mid M(a, x) & \preccurlyeq M(b, x) \\
B l(a, b) \mid M(a, x) & \preccurlyeq F(x, b) \\
B r(a, b) \mid M(a, x) & \preccurlyeq F(b, x) \\
D(a, b, c) \mid M(a, x) & \preccurlyeq M(b, x) \mid M(c, x) \\
S(a, b, c) \mid M(a, x) & \preccurlyeq F(b, c)
\end{aligned}

Definition 3．31．A Combinatory Conjunctive Parallel Algebra is a $(C C P S) \mathcal{C}=\left(\mathbb{C}, \otimes, \mid,()^{\perp}, \mathbf{1}, \mathbf{M}, \preccurlyeq\right)$ together with a separator $\mathcal{S} \subseteq \mathbb{C}$ s．t．$((\mathbb{C}, \otimes, \mathbf{1}, \preccurlyeq), \mathcal{S})$ is a $(C P A)$ and all the Honda $\mathcal{E}$ Yoshida combinators belong to $\mathcal{S}$ ．

On secuential models of Classical Realizability，the set of realizers has associated an operational semantics given by reduction．This notion of reduction is correlated with the constructors／destructors for types：e．g．：the rules of introduction／elimination of implication corresponds respectively to abstraction and $\beta$－reduction on $\lambda$－calculus．In these models，to get the Adequation Lemma we need to close the the poles by anti－reduction．

So far we have not needed to introduce a notion of reduction because the constructors of Linear Logic here reflect the properties of connections and handling of names．However，to obtain a model of behaviours $\mathcal{B}$ where the Honda \＆Yoshida＇s combinators defined by adjunction（c．f．：Definition 3．31）are inhabited，we ask the poles to be closed by anti－reduction．This choice follows the Beffara＇s design when defining the regular poles［8］．

Definition 3．32．The reduction on $(P W F)$ is defined as the least binary relation $\longrightarrow$ s．t．：
－$\left(u^{\uparrow}(\vec{x}) \cdot P \mid v^{\downarrow}(\vec{x}) \cdot Q, e\right) \longrightarrow((\nu \vec{x})(P \mid Q), e)$ ，whenever $u \underset{e}{\sim} x$.
－Respects the constructions｜and $\nu$ of（PWF）（c．f．：Definition 2．27）．
－Is closed under $\equiv{ }_{\alpha}$ ．
Definition 3．33．Let us consider a pole $\Perp \subseteq \bar{\Pi}$ ．We say that $\Perp$ is regular iff for all $(P, e),(Q, f)$（ $P W F$ ）－processes， $\{(Q, f)\}^{\perp} \subseteq\{(P, e)\}^{\perp}$ whenever $(P, e) \longrightarrow(Q, f)$ ．

Proposition 3.34. Let us consider a $(C P A) \mathcal{B}:=\left(\mathbb{B}, \otimes, \|,()^{\perp}, \mathbf{1}, \preccurlyeq\right)$ whose pole $\Perp$ is regular. Then $\mathcal{B}$ is a (CCPA) with the definition $\mathbf{M}(a, b):=\left\{\left(a^{\uparrow}(b) . \mathbb{1}, \Delta_{\mathbb{N}}\right)\right\}^{\perp \perp}$.
Proof. By definition, $\mathbf{M}(a, b) \in \mathcal{S}$ because is not empty. The other combinators $\mathbf{K}(a), \mathbf{F}(a, b), \mathbf{B l}(a, b), \mathbf{B r}(a, b), \mathbf{D}(a, b, c)$ and $\mathbf{S}(a, b, c)$ are given by Definition 3.31 and they are inhabited by their respective encoding on (PWF).

## Remark 3.35.



This schemata shows the relation between the logical side (immanent for conjunctive algebras of Miquey) and the concurrent computational side: The relation between both sides is given by the fussion of names.

The right-hand side of the diagram corresponds to the logical connectives $\otimes, 8, \multimap$ of $M L L$ and the adjoint application of - , while - is an auxiliary definition. Operationally, the logical connectives corresponds to parallel composition without communication.

The left-hand side corresponds to the operational semantics of the the realizers. The parallel composition $\|$ corresponds to general parallelism, where communication is allowed. The operation $\triangleleft$ is the right adjoint of general parallelism while $\odot$ is an auxiliary definition.

The diagram explains that the link between the logical side and the operational side is given by global fusions.
