# SPECIAL SLANT SURFACES WITH NON-CONSTANT MEAN CURVATURE IN 2-DIMENSIONAL COMPLEX SPACE FORMS

#### Abstract

In the late 1990s, B. Y. Chen introduced the notion of special slant surfaces in Kähler surfaces and classified non-minimal proper special slant surfaces with constant mean curvature in 2-dimensional complex space forms. In this paper, we completely classify proper special slant surfaces with non-constant mean curvature in 2-dimensional complex space forms.


## 1. Introduction

A surface in a Kähler surface is called a slant surface if its Wirtinger angle is constant. Holomorphic curves and Lagrangian surfaces are slant surfaces with constant Wirtinger angle 0 and $\pi / 2$, respectively. A slant surface is said to be proper if it is neither a holomorphic curve nor a Lagrangian surface. There exist infinity many proper slant surfaces in 2-dimensional complex space forms (see for example [11, 12, 13).

In [6], Chen established a pointwise inequality between the squared mean curvature and the Gaussian curvature for proper slant surfaces in 2-dimensional complex space forms. A proper slant surface satisfies the equality case of the inequality identically if and only if the shape operator takes a special form. As a generalization of such a surface, Chen introduced a new class of slant surfaces in Kähler surfaces, named special slant surfaces. This class also includes all slant minimal surfaces and slant pseudo-umbilical surfaces. Moreover, he [5] classified non-minimal proper special slant surfaces with constant mean curvature in 2-dimensional complex space forms.

In this paper, we completely classify proper special slant surfaces with non-constant mean curvature in 2 -dimensional complex space forms.

## 2. Preliminaries

Let $M$ be a surface of a Kähler surface $\tilde{M}^{2}$ with complex structure $J$. We denote by $\nabla$ and $\tilde{\nabla}$ the Levi-Civita connections on $M$ and $\tilde{M}^{2}$, and by $h$ and $A_{\xi}$ the second fundamental form and the shape operator with respect to $\xi$, respectively. The formulas of Gauss and Weingarten are given respectively by

& \tilde{\nabla}_{X} \xi=-A_{\xi} X+D_{X} \xi
\end{aligned}
$$

for vector fields $X, Y$ tangent to $M$ and $\xi$ normal to $M$. The second fundamental form $h$ is related to the shape operator $A$ by $\left\langle A_{\xi} X, Y\right\rangle=\langle h(X, Y), \xi\rangle$. The mean curvature vector field $H$ is defined by $H=(1 / 2)$ trace $h$. The function $|H|$ is called the mean

[^0]curvature. If it vanishes identically, then $M$ is said to be minimal. In particular, if $h$ vanishes identically, then $M$ is said to be totally geodesic. A surface $M$ is said to be pseudo-umbilical if $|H| \neq 0$ and $A_{H}=\mu I$ for some function $\mu$ on $M$, where $I$ is the identify transformation.

We denote by $R$ and $\tilde{R}$ the Riemannian curvature tensors of $M$ and $\tilde{M}$, respectively, and by $R^{D}$ the curvature tensor of the normal connection $D$. We define the covariant derivative $\bar{\nabla} h$ of $h$ by

Then, the equations of Gauss, Codazzi and Ricci are given respectively by

\langle R(X, Y) Z, W\rangle & =\langle\tilde{R}(X, Y) Z, W\rangle+\langle h(X, W), h(Y, Z)\rangle \\
& -\langle h(X, Z), h(Y, W)\rangle  \tag{2.1}\\
(\tilde{R}(X, Y) Z)^{\perp} & =\left(\bar{\nabla}_{X} h\right)(Y, Z)-\left(\bar{\nabla}_{Y} h\right)(X, Z),  \tag{2.2}\\
\left\langle R^{D}(X, Y) \xi, \nu\right\rangle & =\langle\tilde{R}(X, Y) \xi, \nu\rangle+\left\langle\left[A_{\xi}, A_{\nu}\right](X), Y\right\rangle \tag{2.3}
\end{align*}
$$

for vectors $X, Y, Z, W$ tangent to $M$ and $\xi, \nu$ normal to $M$, where $(\tilde{R}(X, Y) Z)^{\perp}$ denotes the normal component of $\tilde{R}(X, Y) Z$.

At each point $p \in M$, the angle $\theta$ between $J X$ and $T_{p} M$, where $0 \leq \theta \leq \pi / 2$, is independent of the choice of non-zero vector $X \in T_{p} M$. The angle $\theta$ is called the Wirtinger angle. A surface is called a slant surface if its Wirtinger angle is constant on $M$ (see [2]). The Wirtinger angle $\theta$ of a slant surface is called the slant angle. A slant surface with slant angle $\theta$ is called $\theta$-slant. Holomorphic curves and Lagrangian surfaces are slant surfaces with slant angle 0 and $\pi / 2$, respectively. A slant surface is said to be proper if $\theta \neq 0, \pi / 2$.

For any vector $X$ tangent to $M$, we put $J X=P X+F X$, where $P X$ and $F X$ denote the tangential and normal components of $J X$, respectively. If $M$ is a proper slant surface, then for a given unit tangent vector field $e_{1}$, we choose a local orthonormal frame $\left\{e_{1}, e_{2}, e_{3}, e_{4}\right\}$ of $M$ in $\tilde{M}^{2}$ such that

e_{2}=(\sec \theta) P e_{1}, \quad e_{3}=(\csc \theta) F e_{1}, \quad e_{4}=(\csc \theta) F e_{2}
$$

In the case when $M$ is a Lagrangian surface, for a given local orthonormal frame $\left\{e_{1}, e_{2}\right\}$ on $M$, we choose a local orthonormal frame $\left\{e_{1}, e_{2}, e_{3}, e_{4}\right\}$ of $M$ in $\tilde{M}^{2}$ such that $e_{3}=J e_{1}$ and $e_{4}=J e_{2}$. We call such orthonormal frames adapted frames.

Remark 2.1. The equation (2.3) of Ricci is a consequence of the equations (2.1) and (2.2) of Gauss and Codazzi for any slant surface with slant angle $\theta \in(0, \pi / 2]$ in any Kähler surface (see [8], [11] and [12]).

Let $\tilde{M}^{2}(4 \epsilon)$ be a complex space form of complex dimension 2 and constant holomorphic sectional curvature $4 \epsilon$. The curvature tensor $\tilde{R}$ of $\tilde{M}^{2}(4 \epsilon)$ is given by

\begin{align*}
\tilde{R}(X, Y) Z= & \epsilon\{\langle Y, Z\rangle X-\langle X, Z\rangle Y+\langle Z, J Y\rangle J X \\
& -\langle Z, J X\rangle J Y+2\langle X, J Y\rangle J Z\} \tag{2.4}
\end{align*}
$$

for any tangent vector fields $X, Y$ and $Z$ of $\tilde{M}^{2}(4 \epsilon)$. It is well-known that any 2 dimensional complete and simply connected complex space form is holomorphically isometric to complex Euclidean plane $\mathbb{C}^{2}$, complex projective plane $\mathbb{C} P^{2}(4 \epsilon)$ or complex hyperbolic plane $\mathbb{C} H^{2}(4 \epsilon)$, according as $\epsilon=0, \epsilon>0$ or $\epsilon<0$.

In the next section, we recall the definition of special slant surfaces introduced by Chen [6] and some results on such slant surfaces in $\tilde{M}^{2}(4 \epsilon)$.

## 3. Special slant surfaces

In [6], Chen proved that the squared mean curvature $|H|^{2}$ and the Gaussian curvature $K$ of a proper $\theta$-slant surface in a complex space form $\tilde{M}^{2}(4 \epsilon)$ satisfy the following inequality:

|H|^{2}(p) \geq 2 K(p)-2\left(1+3 \cos ^{2} \theta\right) \epsilon \tag{3.1}
\end{equation*}
$$

at each point $p \in M$. The equality case holds at $p$ if and only if, with respect to some suitable adapted frame $\left\{e_{1}, e_{2}, e_{3}, e_{4}\right\}$ at $p$, the shape operator of $M$ at $p$ takes the following form:

$$
A_{e_{3}}=\left(\begin{array}{cc}
3 \lambda & 0 \\
0 & \lambda
\end{array}\right), \quad A_{e_{4}}=\left(\begin{array}{cc}
0 & \lambda \\
\lambda & 0
\end{array}\right)
$$

Moreover, he proved that a non-totally geodesic proper slant surface attaining equality of the equality (3.1) identically exists only in $\mathbb{C} H^{2}(4 \epsilon)$ and satisfies $K \equiv 2 \epsilon / 3$ and $\theta=\cos ^{-1}(1 / 3)$. In [9], the explicit representation of such a surface was given. This surface is named Chen's surface in [15]. A proper slant surface in $\tilde{M}^{2}(4 \epsilon)$ has non-zero parallel mean curvature and constant Gaussian curvature if and only if it is locally congruent to Chen's surface (see [14, 15, [16]).

Remark 3.1. Every Lagrangian surface in $\tilde{M}^{2}(4 \epsilon)$ satisfies the inequality (3.1) with $\theta=\pi / 2$ (see [3]). Chen and Vrancken [10] obtained the explicit representation of Lagrangian surfaces satisfying equality of the equality identically.

A slant surface with slant angle $\theta \in(0, \pi / 2]$ in a Kähler surface is called special slant if, with respect to some suitable adapted frame $\left\{e_{1}, e_{2}, e_{3}, e_{4}\right\}$, the shape operators of $M$ take the following special form:

A_{e_{3}}=\left(\begin{array}{cc}
c \lambda & 0  \tag{3.2}\\
0 & \lambda
\end{array}\right), \quad A_{e_{4}}=\left(\begin{array}{cc}
0 & \lambda \\
\lambda & 0
\end{array}\right)
$$

for some constant $c$ and some function $\lambda$ (see [5, 6]).
Every slant minimal surface with slant angle $\theta \in(0, \pi / 2]$ in a Kähler surface is a special slant surface satisfying (3.2) with $c=-1$ (see [4, Lemma 3.1] and [6, Proposition 3]).

Special slant surfaces satisfying (3.2) with $c=1$ are pseudo-umbilical, simply called slumbilical surfaces (see [7]). Slumbilical surfaces in $\tilde{M}^{2}(4 \epsilon)$ have been classified in [7]. In particular, we have

Theorem $3.1([7])$. Let $M$ be a proper $\theta$-slant surface in a complex space form $\tilde{M}^{2}(4 \epsilon)$ with non-vanishing mean curvature. If $M$ is a slumbilical surface, then $\epsilon=0$ and one of the following two cases occurs:
(1) $M$ is an open portion of the Euclidean 2-plane equipped with the flat metric

$$
g=e^{-2 y \cot \theta}\left\{d x^{2}+(a x+b)^{2} d y^{2}\right\}
$$

for some real numbers $a, b$ with $a \neq 0$. Moreover, up to rigid motions of $\mathbb{C}^{2}$, the immersion is given by

$$
\begin{aligned}
z(x, y)= & \frac{(a x+b)^{1+i a^{-1} \csc \theta}}{a+i \csc \theta} e^{-y \cot \theta}\left(\cos \left(\sqrt{1+a^{2}} y\right)\right. \\
& \left.+i \frac{a \cos \theta}{\sqrt{1+a^{2}}} \sin \left(\sqrt{1+a^{2}} y\right), \frac{a \sin \theta+i}{\sqrt{1+a^{2}}} \sin \left(\sqrt{1+a^{2}} y\right)\right)
\end{aligned}
$$

(2) $M$ is an open portion of the Euclidean 2-plane equipped with the flat metric

$$
g=e^{-2 y \cot \theta}\left(d x^{2}+b^{2} d y^{2}\right)
$$

for some positive number $b$. Moreover, up to rigid motions of $\mathbb{C}^{2}$, the immersion is given by

$$
z(x, y)=b \sin \theta \exp \left\{i b^{-1} x \csc \theta-y \cot \theta\right\}(\cos y, \sin y)
$$

Remark 3.2. Slumbilical surfaces described in (1) (resp. (2)) of Theorem 3.1 satisfy (3.2) with $c=1$ and $\lambda=e^{y \cot \theta} /(a x+b)$ (resp. $\lambda=e^{y \cot \theta} / b$ ) with respect to an adapted frame such that $e_{1}=e^{y \cot \theta} \partial / \partial x$ and $e_{2}=\lambda \partial / \partial y$ (cf. Case $(\beta-b)$ in the proof of Theorem 4.1 of 77 ). In particular, both families of surfaces have non-constant mean curvature.

For each $c \in(2,5)$, there exists a special slant immersion

$$
\phi_{c}: M\left(\frac{4(c-2)}{3(c-1)} \epsilon\right) \rightarrow \mathbb{C} H^{2}(4 \epsilon)
$$

of a simply-connected surface with constant Gaussian curvature $\frac{4(c-2)}{3(c-1)} \epsilon$ into $\mathbb{C} H^{2}(4 \epsilon)$ with slant angle $\theta=\cos ^{-1}\left(\frac{1}{3} \sqrt{\frac{(5-c)(c-2)}{c-1}}\right)$, which satisfies (3.2) with $\lambda=\sqrt{\frac{(c-5) \epsilon}{3(c-1)}}$, with respect to some adapted frame (see [5, Theorem1]). The explicit representation of $\phi_{c}$ was obtained in [9, Theorem 5.1]. A non-totally geodesic proper slant surface satisfies equality of the equality (3.1) identically if and only if it is locally congruent to $\phi_{3}$.

Let $U$ be a simply-connected open subset of $\mathbb{R}^{2}$ and $E=E(x, y)$ a positive function on $U$ satisfying the following conditions:

$$
\frac{\partial}{\partial x}\left(\frac{1}{E} \frac{\partial}{\partial x}\left(\frac{1}{E} \frac{\partial E}{\partial y}\right)\right)=0, \quad \frac{\partial E}{\partial y} \neq 0
$$

For a given $\theta \in(0, \pi / 2)$ and $\epsilon<0$, we put $G=(\sec \theta) E_{y} /(2 \sqrt{-\epsilon} E), E_{y}=\partial E / \partial y$. Denote by $M(\theta, \epsilon, E)$ the surface $U$ with metric tensor

$$
g=E^{2} d x^{2}+G^{2} d y^{2}
$$

Then, $M(\theta, \epsilon, E)$ has constant Gaussian curvature $K=4 \epsilon \cos ^{2} \theta$. There exists a special $\theta$-slant immersion

$$
\psi_{\theta, \epsilon, E}: M(\theta, \epsilon, E) \rightarrow \mathbb{C} H^{2}(4 \epsilon)
$$

which satisfies (3.2) with $c=2$ and $\lambda=-\sqrt{-\epsilon} \sin \theta$, with respect to the adapted frame with $e_{1}=E^{-1} \partial / \partial x, e_{2}=G^{-1} \partial / \partial y$ (see [5, Theorem 2]).

The explicit representation of $\psi_{\theta,-1, y}$ was given in Proposition 6.1 of 9]. Two slant immersions $\psi_{\theta,-1,(x+y)^{-2}}$ and $\psi_{\theta,-1, y}$ are not congruent to each other in $\mathbb{C} H^{2}(-4)$. Therefore, up to rigid motions of $\mathbb{C} H^{2}(-4)$, for each $\theta \in(0, \pi / 2)$ there exist more
than one special $\theta$-slant immersions of a surface with constant Gaussian curvature $-4 \cos ^{2} \theta$ into $\mathbb{C} H^{2}(-4)$ satisfying (3.2) (see Remark 6.1 and Corollary 6.2 in 9).

For special slant surfaces with satisfying (3.2) with $c=2$ in $\tilde{M}^{2}(4 \epsilon)$, we have
Theorem 3.2 (5). Let $M$ be a non-minimal proper $\theta$-slant surface in a complex space form $\tilde{M}^{2}(4 \epsilon)$. If $M$ is a special slant surface satisfying (3.2) with $c=2$, then $\epsilon<0$ and $M$ is isometric to $M(\theta, \epsilon, E)$. Moreover, up to rigid motions of $\mathbb{C} H^{2}(4 \epsilon)$, the immersion is given by $\psi_{\theta, \epsilon, E}$.

Chen [5] proved that $\phi_{c}$ and $\psi_{\theta, \epsilon, E}$ are the only non-minimal proper special slant surfaces in a complex space form $\tilde{M}^{2}(4 \epsilon)$ with constant mean curvature. The next section solves the classification problem for the case of non-constant mean curvature.

## 4. The main theorem

The main result of this paper is the following classification theorem.
Theorem 4.1. Let $M$ be a proper $\theta$-slant surface in a complex space form $\tilde{M}^{2}(4 \epsilon)$ with $\nabla|H|^{2} \neq 0$ everywhere. If $M$ is a special slant surface, then $M$ is a slumbilical surface in $\mathbb{C}^{2}$, which is locally congruent to one of the following:

$$
\begin{align*}
z(x, y)= & \frac{(a x+b)^{1+i a^{-1} \csc \theta}}{a+i \csc \theta} e^{-y \cot \theta}\left(\cos \left(\sqrt{1+a^{2}} y\right)\right.  \tag{1}\\
& \left.+i \frac{a \cos \theta}{\sqrt{1+a^{2}}} \sin \left(\sqrt{1+a^{2}} y\right), \frac{a \sin \theta+i}{\sqrt{1+a^{2}}} \sin \left(\sqrt{1+a^{2}} y\right)\right)
\end{align*}
$$

for some real numbers $a, b$ with $a \neq 0$;
(2)

$$
z(x, y)=b \sin \theta \exp \left\{i b^{-1} x \csc \theta-y \cot \theta\right\}(\cos y, \sin y)
$$

for some positive number $b$.
Proof. Let $M$ be a proper special slant surface in $\tilde{M}^{2}(4 \epsilon)$ satisfying (3.2) with respect to some suitable adapted frame $\left\{e_{1}, e_{2}, e_{3}, e_{4}\right\}$. Then, we have

$$
\begin{equation*}
h\left(e_{1}, e_{1}\right)=c \lambda e_{3}, \quad h\left(e_{1}, e_{2}\right)=\lambda e_{4}, \quad h\left(e_{2}, e_{2}\right)=\lambda e_{3} \tag{4.1}
\end{equation*}
$$

Assume that $\nabla|H|^{2} \neq 0$ everywhere. Then, $c \neq-1, \lambda$ is not constant and nowhere zero. Moreover, it follows from Theorem 3.2 that $c \neq-2$.

We put $p=\left\langle\nabla_{e_{1}} e_{1}, e_{2}\right\rangle$ and $q=\left\langle\nabla_{e_{2}} e_{1}, e_{2}\right\rangle$. Then, by Lemma 4 of [6], which is a consequence of the equation (2.2) of Codazzi and Lemma 4.1 of [2, p.29], we have

\begin{align*}
& e_{1} \lambda=(c-2) \lambda q  \tag{4.2}\\
& e_{2} \lambda=\lambda p+\frac{6 \epsilon}{c+1} \sin \theta \cos \theta  \tag{4.3}\\
& \lambda p=\frac{(c+1) \lambda^{2} \cot \theta}{2}-\frac{3(c-1)}{2(c+1)} \epsilon \sin \theta \cos \theta \tag{4.4}
\end{align*}
$$

It follows from (2.4), (4.1) and the equation (2.1) of Gauss for $\left\langle R\left(e_{1}, e_{2}\right) e_{2}, e_{1}\right\rangle$ that

$$
\begin{equation*}
-p^{2}-q^{2}-e_{1} q+e_{2} p=(c-1) \lambda^{2}+\left(1+3 \cos ^{2} \theta\right) \epsilon \tag{4.5}
\end{equation*}
$$

Differentiating (4.4) along $e_{i}(i=1,2)$ and using (4.2) and (4.3), we obtain

$$
\begin{align*}
& e_{1} p=(c-2)\{(c+1) \lambda \cot \theta-p\} q  \tag{4.6}\\
& e_{2} p=-p^{2}+(c+1) \lambda p \cot \theta-\frac{6 \epsilon p}{(c+1) \lambda} \sin \theta \cos \theta+6 \epsilon \cos ^{2} \theta \tag{4.7}
\end{align*}
$$

Substituting (4.7) into (4.5) yields

$$
\begin{equation*}
e_{1} q=-(c-1) \lambda^{2}-\epsilon-2 p^{2}-q^{2}+(c+1) \lambda p \cot \theta-\frac{6 \epsilon p}{(c+1) \lambda} \sin \theta \cos \theta+3 \epsilon \cos ^{2} \theta \tag{4.8}
\end{equation*}
$$

Every function $f$ satisfies the condition $\left[e_{1}, e_{2}\right] f-\left(\nabla_{e_{1}} e_{2}-\nabla_{e_{2}} e_{1}\right) f=0$, which can be written as

$$
\begin{equation*}
e_{1}\left(e_{2} f\right)-e_{2}\left(e_{1} f\right)+p e_{1} f+q e_{2} f=0 \tag{4.9}
\end{equation*}
$$

We apply (4.9) for $\lambda$. Using (4.2) and (4.3), we get

$$
\begin{equation*}
e_{1}\left(e_{2} \lambda\right)-e_{2}\left(e_{1} \lambda\right)=\left(e_{1} \lambda\right) p+\lambda e_{1} p-(c-2)\left\{\left(e_{2} \lambda\right) q+\lambda e_{2} q\right\} \tag{4.10}
\end{equation*}
$$

From (4.9) with $f=\lambda$ and (4.10), it follows that

$$
\begin{equation*}
2 p e_{1} \lambda+\lambda e_{1} p+(3-c) q e_{2} \lambda-(c-2) \lambda e_{2} q=0 \tag{4.11}
\end{equation*}
$$

Substituting (4.2), (4.3) and (4.6) into (4.11) gives

$$
\begin{equation*}
e_{2} q=q\left(\frac{p}{c-2}+(c+1) \lambda \cot \theta+\frac{6(3-c) \epsilon}{(c-2)(c+1) \lambda} \sin \theta \cos \theta\right) \tag{4.12}
\end{equation*}
$$

Case (I): $q=0$ on an open subset $\mathcal{U}$ of $M$. In this case, substituting (4.4) into (4.8), and multiplying the resulting equation by the least common denominator $2(c+1)^{2} \lambda^{2}$, we obtain the following polynomial equation in $\lambda$ :
$2(c-1)(c+1)^{2} \lambda^{4}-\epsilon(c+1)^{2}\left\{3(c-1) \cos ^{2} \theta-2\right\} \lambda^{2}+9 \epsilon^{2}(c-3)(c-1) \sin ^{2} \theta \cos ^{2} \theta=0$.
Since $\lambda$ is not constant, all coefficients must vanish. Therefore, taking into account $c \neq-1$, we must have $c=1$. Applying Theorem 3.1 shows $\epsilon=0$. It follows from $q=0$ and (4.2) that $e_{1} \lambda=0$. Thus, Remark 3.2 implies that $\mathcal{U}$ is locally congruent to (2).

Case (II): $q \neq 0$ on an open subset $\mathcal{W}$ of $M$. In this case, we compute (4.9) with $f=q$, that is,

\end{equation*}
$$

Differentiating (4.8) and (4.12) along $e_{2}$ and $e_{1}$ respectively, we obtain

\begin{align*}
e_{2}\left(e_{1} q\right)= & \left\{-2(c-1) \lambda+p(c+1) \cot \theta+\frac{6 \epsilon p}{(c+1) \lambda^{2}} \sin \theta \cos \theta\right\} e_{2} \lambda \\
& -\left\{4 p-(c+1) \lambda \cot \theta+\frac{6 \epsilon}{(c+1) \lambda} \sin \theta \cos \theta\right\} e_{2} p-2 q e_{2} q  \tag{4.14}\\
e_{1}\left(e_{2} q\right)= & \left\{\frac{p}{c-2}+(c+1) \lambda \cot \theta+\frac{6(3-c) \epsilon}{(c-2)(c+1) \lambda} \sin \theta \cos \theta\right\} e_{1} q \\
& +\frac{q}{c-2} e_{1} p+q\left\{(c+1) \cot \theta-\frac{6(3-c) \epsilon}{(c-2)(c+1) \lambda^{2}} \sin \theta \cos \theta\right\} e_{1} \lambda . \tag{4.15}
\end{align*}
$$

Substituting (4.14) and (4.15) into (4.13) shows

& \frac{q}{c-2} e_{1} p+\left\{4 p-(c+1) \lambda \cot \theta+\frac{6 \epsilon}{(c+1) \lambda} \sin \theta \cos \theta\right\} e_{2} p \\
& +\left\{\frac{(c-1) p}{c-2}+(c+1) \lambda \cot \theta+\frac{6(3-c) \epsilon}{(c-2)(c+1) \lambda} \sin \theta \cos \theta\right\} e_{1} q+3 q e_{2} q  \tag{4.16}\\
& +q\left\{(c+1) \cot \theta-\frac{6(3-c) \epsilon}{(c-2)(c+1) \lambda^{2}} \sin \theta \cos \theta\right\} e_{1} \lambda \\
& +\left\{2(c-1) \lambda-(c+1) p \cot \theta-\frac{6 \epsilon p}{(c+1) \lambda^{2}} \sin \theta \cos \theta\right\} e_{2} \lambda=0 .
\end{align*}
$$

Substituting (4.2), (4.3), (4.6), (4.7), (4.8) and (4.12) into (4.16) and multiplying the resulting equation by the least common denominator $(c-2)(c+1)^{2} \lambda^{2}$, we find

$$
\begin{equation*}
\alpha_{1}(\lambda) p^{3}+\alpha_{2}(\lambda) p^{2}+\alpha_{3}(\lambda) p+\alpha_{4}(\lambda)=0 \tag{4.17}
\end{equation*}
$$

where $\alpha_{i}(i=1,2,3,4)$ are polynomials in $\lambda$ given by

$$
\begin{aligned}
\alpha_{1}= & 2(c+1)^{2}(3 c-5) \lambda^{2}, \\
\alpha_{2}= & -(c+1)^{3}(3 c-5) \cot \theta \lambda^{3}+6 \epsilon(c+1)(5 c-7) \sin \theta \cos \theta \lambda, \\
\alpha_{3}= & -(c-3)(c-1)(c+1)^{2} \lambda^{4} \\
& +\left\{(c+1)^{2}\left[\epsilon(c-1)+2 q^{2}(c-3)\right]-3 \epsilon(c+1)^{2}(7 c-11) \cos ^{2} \theta\right\} \lambda^{2} \\
& +36 \epsilon^{2}(c-1) \sin ^{2} \theta \cos ^{2} \theta, \\
\alpha_{4}= & (c-2)(c-1)(c+1)^{3} \cot \theta \lambda^{5} \\
& +\left\{(c-2)(c+1)^{3}\left[\epsilon-q^{2}(c+1)\right] \cot \theta\right. \\
& \left.+3 \epsilon(c-2)(c+1)^{3} \cos ^{2} \theta \cot \theta-6 \epsilon(c-1)(c+1)(3 c-7) \sin \theta \cos \theta\right\} \lambda^{3} \\
& -\left\{6 \epsilon(c-3)(c+1)\left[\epsilon+q^{2}(c-4)\right] \sin \theta \cos \theta+18 \epsilon^{2}(c+1)(c-1) \sin \theta \cos ^{3} \theta\right\} \lambda,
\end{aligned}
$$

where all coefficients are expressed as

$$
\begin{equation*}
\sum_{m, n \geq 1} Q_{m, n}^{i}(c) \sin ^{m} \theta \cos ^{n} \theta+\sum_{m, n \geq 0} R_{m, n}^{i}(c) \cos ^{m} \theta \cot ^{n} \theta \tag{4.18}
\end{equation*}
$$

for some polynomials $Q_{m, n}^{i}(c)$ and $R_{m, n}^{i}(c)$ in $c$.
In the rest of this paper, we will express the coefficients of polynomials in $\lambda$ in the form (4.18).

Substituting (4.4) into (4.17) and multiplying the resulting equation by the least common denominator $4(c+1) \lambda$, we derive

$$
\begin{equation*}
\beta_{1}(\lambda) q^{2}+\beta_{2}(\lambda)=0 \tag{4.19}
\end{equation*}
$$

where $\beta_{i}(i=1,2)$ are polynomials in $\lambda$ given by

$$
\begin{aligned}
\beta_{1}= & 4(c-1)^{2}(c+1)^{4} \cot \theta \lambda^{4}+36 \epsilon(c-3)^{2}(c+1)^{2} \sin \theta \cos \theta \lambda^{2} \\
\beta_{2}= & -2(c-1)^{2}(c+1)^{4} \cot \theta \lambda^{6} \\
& -\left\{2 \epsilon(c+1)^{4}(3 c-5) \cot \theta-3 \epsilon(c-1)(c+1)^{4}(3 c-5) \cos ^{2} \theta \cot \theta\right. \\
& \left.+6 \epsilon(c-1)(c+1)^{2}\left(c^{2}-16 c+31\right) \sin \theta \cos \theta\right\} \lambda^{4} \\
& +\left\{6 \epsilon^{2}(c+1)^{2}\left(c^{2}+2 c-11\right) \sin \theta \cos \theta\right. \\
& \left.-18 \epsilon^{2}(c-1)^{2}(c+1)^{2}(3 c-8) \sin \theta \cos ^{3} \theta\right\} \lambda^{2} \\
& +81 \epsilon^{3}(c-3)^{2}(c-1)^{2} \sin ^{3} \theta \cos ^{3} \theta
\end{aligned}
$$

We differentiate (4.19) along $e_{1}$ and use (4.2) and (4.8). Then, dividing the left-hand side of the resulting equation by the greatest common factor $4(c+1) \lambda q$, we obtain

$$
\begin{equation*}
\kappa_{1}(\lambda) p^{2}+\kappa_{2}(\lambda) p+\kappa_{3}(\lambda)=0 \tag{4.20}
\end{equation*}
$$

where $\kappa_{i}(i=1,2,3)$ are polynomials in $\lambda$ given by

$$
\begin{aligned}
\kappa_{1}= & 4(c-1)^{2}(c+1)^{3} \cot \theta \lambda^{3}+36 \epsilon(c-3)^{2}(c+1) \sin \theta \cos \theta \lambda, \\
\kappa_{2}= & -2(c-1)^{2}(c+1)^{4} \cot ^{2} \theta \lambda^{4}-6 \epsilon(c+1)^{2}\left(c^{2}-14 c+25\right) \cos ^{2} \theta \lambda^{2} \\
& +108 \epsilon^{2}(c-3)^{2} \sin ^{2} \theta \cos ^{2} \theta, \\
\kappa_{3}= & (c-1)^{2}(c+1)^{3}(5 c-8) \cot \theta \lambda^{5} \\
& +\left\{2(c+1)^{3}\left[\epsilon\left(4 c^{2}-13 c+11\right)-q^{2}(c-1)^{2}(2 c-5)\right] \cot \theta\right. \\
& -3 \epsilon(c-1)(c+1)^{3}\left(3 c^{2}-7 c+6\right) \cos ^{2} \theta \cot \theta \\
& \left.+6 \epsilon(c-1)(c+1)\left(c^{3}-15 c^{2}+45 c-35\right) \sin \theta \cos \theta\right\} \lambda^{3} \\
& -\left\{3 \epsilon(c+1)\left[\epsilon\left(c^{3}-6 c^{2}+21 c-32\right)+6 q^{2}(c-3)^{3}\right] \sin \theta \cos \theta\right. \\
& \left.+9 \epsilon^{2}(c+1)\left(3 c^{4}-20 c^{3}+35 c^{2}+26 c-92\right) \sin \theta \cos ^{3} \theta\right\} \lambda .
\end{aligned}
$$

Substituting (4.4) into (4.20) and multiplying the resulting equation by the least common denominator $(c+1) \lambda$, we get

$$
\begin{equation*}
\tau_{1}(\lambda) q^{2}+\tau_{2}(\lambda)=0 \tag{4.21}
\end{equation*}
$$

where $\tau_{i}(i=1,2)$ are polynomials in $\lambda$ given by

$$
\begin{aligned}
\tau_{1}= & 2(c-1)^{2}(c+1)^{4}(2 c-5) \cot \theta \lambda^{4}+18 \epsilon(c-3)^{3}(c+1)^{2} \sin \theta \cos \theta \lambda^{2} \\
\tau_{2}= & -(c-1)^{2}(c+1)^{4}(5 c-8) \cot \theta \lambda^{6} \\
& -\left\{2 \epsilon(c+1)^{4}\left(4 c^{2}-13 c+11\right) \cot \theta-3 \epsilon(c-1)(c+1)^{4}\left(4 c^{2}-11 c+9\right) \cos ^{2} \theta \cot \theta\right. \\
& \left.+6 \epsilon(c-1)(c+1)^{2}\left(c^{3}-15 c^{2}+45 c-35\right) \sin \theta \cos \theta\right\} \lambda^{4} \\
& +\left\{3 \epsilon^{2}(c+1)^{2}\left(c^{3}-6 c^{2}+21 c-32\right) \sin \theta \cos \theta\right. \\
& \left.-9 \epsilon^{2}(c+1)^{2}\left(4 c^{4}-29 c^{3}+74 c^{2}-65 c-8\right) \sin \theta \cos ^{3} \theta\right\} \lambda^{2} \\
& -81 \epsilon^{3}(c-3)^{3}(c-1) \sin ^{3} \theta \cos ^{3} \theta
\end{aligned}
$$

Eliminating $q^{2}$ from (4.19) and (4.21) yields

$$
\beta_{1} \tau_{2}-\beta_{2} \tau_{1}=0
$$

which can be written as the following polynomial equation in $\lambda$ :

$$
12(c-1)^{5}(c+1)^{8} \cot ^{2} \theta \lambda^{10}+\epsilon \sum_{m=1}^{4} \psi_{m}(c) \lambda^{2 m}=0
$$

where each $\psi_{m}(c)$ is a polynomial in $c$. Since $\lambda$ is not constant, all coefficients must vanish. Hence, taking into account $c \neq-1$, we must have $c=1$. Applying Theorem 3.1, we get $\epsilon=0$. It follows from $q \neq 0, c \neq 2$ and (4.2) that $e_{1} \lambda \neq 0$. Therefore, from Remark 3.2 we deduce that $\mathcal{W}$ is locally congruent to (1).

Combining Theorem 4.1, Corollary 3.2 of [9] and Theorem 5 of [5], we have
Corollary 4.1. Let $M$ be a non-totally geodesic proper slant surface in a complex space form $\tilde{M}^{2}(4 \epsilon)$. If $M$ is a special slant surface satisfying (3.2), then either
(1) $\epsilon=0$ and $c \in\{-1,1\}$, or
(2) $\epsilon<0$ and $2 \leq c<5$.

## 5. Final REmarks

Remark 5.1. In contrast to Corollary 4.1, for any given constants $\epsilon$ and $c$, there exists a Lagrangian surface in $\tilde{M}^{2}(4 \epsilon)$ satisfying (3.2) for some non-zero function $\lambda$ with respect to some adapted frame (see Theorem 6.1 of [4).

Remark 5.2. Let $M$ be a surface in a Riemannian 4-manifold. We consider an arbitrary orthonormal basis $\left\{e_{1}, e_{2}\right\}$ of $T_{p} M$ and denote $h_{i j}=h\left(e_{i}, e_{j}\right)$. Then, for $X=\cos \theta e_{1}+$ $\sin \theta e_{2}$ we have

$$
h(X, X)=H+\cos 2 \theta \frac{h_{11}-h_{22}}{2}+\sin 2 \theta h_{12}
$$

This implies that when $X$ goes once around the unit tangent circle, $h(X, X)$ goes twice around the ellipse centered at $H$, which is called the curvature ellipse. The ellipse can degenerate into a line segment or a point.

For a non-minimal special slant surface satisfying (3.2) in a Kähler surface, we have (1) $c=3$ if and only if the curvature ellipse is a circle at any point (see [1] for Lagrangian surfaces in complex space forms).
(2) $c=1$ if and only if the curvature ellipse degenerates into a line segment at any point.
(3) If the ambient space is a complex space form and $c \neq 1$, then the semi-major axis and the semi-minor axis of the curvature ellipse are both positive constant.

Remark 5.3. Theorem 6 in [6] states that a proper slant surface in the complex Euclidean plane $\mathbb{C}^{2}$ is special slant if and only if it is a slant minimal surface. However, it is incorrect. In fact, special slant surfaces in $\mathbb{C}^{2}$ described in Theorem 4.1 are nonminimal surfaces. In the proof of Theorem 6 in [6], the case $c=1$ is missing. If $c=1$, then the solution $\lambda$ of (4.34) in [6] is given by

$$
\lambda=f(x) e^{\cot \theta \int \phi(y) d y}
$$

for some function $f(x)$. If $c \neq 1$, then $\lambda$ is given by (4.35) in [6], which leads to a contradiction. Hence, Theorem 6 in [6] should be corrected as follows:

A proper slant surface in the complex Euclidean plane $\mathbb{C}^{2}$ is special slant if and only if it is either a slant minimal surface or a slumbilical surface.

Remark 5.4. In the proof of Theorem4.1, the condition (4.13) for $q$ plays an important role. On the contrary, (4.9) for $f=p$ does not provide any new information. In fact, using (4.2), (4.3), (4.6) and (4.7), we can check that (4.9) for $f=p$ holds identically.
