Eternal vertex cover number of maximal outerplanar graphs

Abstract. Eternal vertex cover problem is a variant of the classical vertex cover problem modeled as a two player attacker-defender game. Computing eternal vertex cover number of graphs is known to be NP-hard in general and the complexity status of the problem for bipartite graphs is open. There is a quadratic complexity algorithm known for this problem for chordal graphs. Maximal outerplanar graphs forms a subclass of chordal graphs, for which no algorithm of sub-quadratic time complexity is known. In this paper, we obtain a recursive algorithm of linear time for computing eternal vertex cover number of maximal outerplanar graphs.

Keywords: Eternal Vertex Cover, Maximal Outerplanar Graph, Linear Time Algorithm

1 Introduction

A set S of vertices in a graph G forms a vertex cover of G if every edge in G has at least one end point in S. The size of a minimum vertex cover in G, called the vertex cover number of G, will be denoted by mvc(G). The eternal vertex cover problem of graphs is motivated by the following dynamic network security / fault-tolerance model. A network can be modeled by a graph G(V, E), where the nodes of the network are represented by the vertices of G and the links by the edges of G. The problem is to deploy a minimum set of guards at the nodes, so that if there is an attack (or fault) on a single link at any time, a guard is available at the end of the link, who can move across the link to defend (or repair) the attack (or fault). Simultaneously, the remaining guards need to reconfigure themselves, possibly by repositioning themselves to one of their adjacent nodes, so that any attack (or fault) on a single edge at any future instant of time can also be protected in the same manner. Thus, the model requires guaranteeing protection against single link attacks/failures ad-infinitum. It is immediate that lowest number of guards needed to achieve this goal in a graph G is at least mvc(G). If k guards are sufficient to achieve the goal, then we say that G is k-defendable.

Formally, guards are initially placed on a vertex cover C_0 of G, forming an initial configuration. Suppose at instant i, guards are placed in a configuration C_i and an attack occurs on an arbitrary edge $uv \in E(G)$, then a guard at either u or v (or both) must move across the edge. Other guards may or not move across one of their neighboring edges simultaneously. At the end of these movements, the next configuration C_{i+1} is reached. To ensure that all edges remain guarded at the instant i + 1, we require C_{i+1} to be a vertex cover of G. The minimum number of guards necessary for a graph G to be protected against any infinite sequence of single edge attacks is called the eternal vertex cover number of G, denoted by evc(G). The eternal vertex cover problem has two models. The first one allows only at most one guard on a vertex in any configuration, while in the second model this constraint is absent. The results in this paper work in both the models. Computing evc(G) for an arbitrary graph G is NP-hard, though in PSPACE [1], and is fixed parameter tractable with evc(G) as parameter[1]. The problem appears significantly harder than mvc computation. For instance, mvc computation is polynomial time for bipartite graphs, but the complexity status of the problem is open for bipartite graphs[1]. Consequent to the hardness results, work on solving the problem on various graph classes have been attempted in the literature. It is known that the problem is NP-complete even for biconnected internally triangulated planar graphs[2]. Polynomial time algorithms for computing evc(G) were known exactly only for very elementary graph classes such as an O(n) algorithm for trees [3], a polynomial time algorithm for a tree-like graph class [4] and a linear time algorithm for cactus graphs [5]. A recent structure theorem developed in [6] has resulted in a quadratic time algorithm for chordal graphs. Similar graph protection problems defined on parameters like dominating sets [7,8,9,10,11,12] and independent sets [13,14] are also studied in literature.

An outerplanar graph is a planar graph that admits a planar embedding with all its vertices lying on the exterior face and it is maximal outerplanar if addition of any more edges between existing vertices will make the graph not outerplanar. Since maximal outerplanar graphs are chordal, it follows from [6] that its evc number can be computed in quadratic time. We improve the complexity and show that the evc number of maximal outerplanar graphs can be computed in linear time.

Our algorithm takes a maximal outerplanar graph G on at least three vertices and an edge uv on the outer face of G and recursively computes evc(G), mvc(G) along with some related parameters. If both u and v are of degree greater than two, then the recursion is applied on the two induced subgraphs G_u and G_v of G as shown in Fig. 1. Otherwise, the recursion works on the graph obtained by deleting the degree two end point of the edge uv from G. Since evc(G) happens to be not merely a function of the eternal vertex cover number and vertex cover number of these associated subgraphs, the algorithm has to recursively compute this larger set of parameters. The linear time complexity of the algorithm is derived from Theorems 1 to 4, which assert that evc(G) can be determined in constant time from this larger set of parameters of the associated subgraphs. Apart from the algorithmic result, these theorems serve to demonstrate the structural connection between the MVCproblem and the EVC problem for maximal outerplanar graphs.

2 Preliminaries

Let G be a graph with $S \subseteq V$. The parameter $\operatorname{evc}_S(G)$ denotes the minimum number k such that G is k-defendable with all vertices of S occupied in all configurations. Similarly, $\operatorname{mvc}_S(G)$ denote the size of the smallest cardinality vertex cover of G containing all vertices of S. When $S = \{v_1 \cdots v_i\}$ for $1 \leq i \leq 3$, we shorten the notation $\operatorname{evc}_{\{v_1 \cdots v_i\}}(G)$ and $\operatorname{mvc}_{\{v_1 \cdots v_i\}}(G)$ as $\operatorname{evc}_{v_1 \cdots v_i}(G)$ and $\operatorname{mvc}_{v_1 \cdots v_i}(G)$ respectively.

Proposition 1 is an easy adaptation of a result from known literature.

Proposition 1. [2] Let G(V, E) be a maximal outerplanar graph with at least two vertices and $S \subseteq V$. If for every vertex $v \in V \setminus S$, $\operatorname{mvc}_{S \cup \{v\}}(G) = \operatorname{mvc}_{S}(G)$, then $\operatorname{evc}_{S}(G) = \operatorname{mvc}_{S}(G)$. Otherwise, $\operatorname{evc}_{S}(G) = \operatorname{mvc}_{S}(G) + 1$. Hence, $\operatorname{evc}_{S}(G) = \operatorname{mvc}_{S \cup \{v\}}(G)$.

Proposition 2. Let G be a maximal outerplanar graph with an edge uv. Then, $\operatorname{evc}_v(G) \leq \operatorname{evc}_{uv}(G) \leq \operatorname{evc}(G) + 1$.

Proof. Let evc(G) = k. The first part of the inequality is obvious. So, we prove the second part. By Proposition 1, for each vertex $x \in V(G)$, $mvc_x(G) \leq k$. Since $uv \in E(G)$, this implies that $\operatorname{mvc}_{xu}(G) \leq k$ or $\operatorname{mvc}_{xv}(G) \leq k$. Therefore, for any vertex $x \in V(G)$, we have $\operatorname{mvc}_{xuv}(G) \leq k+1$. Hence by Proposition 1, $\operatorname{evc}_{uv}(G) \leq k+1 = \operatorname{evc}(G) + 1$.

From now on, whenever we say a graph is maximal outerplanar, we assume a fixed outerplanar embedding of the graph.

For a maximal outerplanar graph G on at least three vertices and any edge uv on the outer face of G, we use the notation $\Delta(uv)$ to denote the unique common neighbor of u and v.

Definition 1 (uv-segments). Let G be a maximal outerplanar graph with at least three vertices. Let uv be an edge on the outer face of G. Let $w = \Delta(uv)$. We define the graph $G_u(uv)$ (respectively, $G_v(uv)$) to be the maximal biconnected outerplanar subgraph of G that satisfies the following two properties (see Fig. 1):

- 1. The edge uw (respectively, vw) is on the outer face of $G_u(uv)$ (respectively, $G_v(uv)$).
- 2. $G_u(uv)$ (respectively, $G_v(uv)$) does not contain the vertex v (respectively u).

 $G_u(uv)$ and $G_v(uv)$ will be called the uv segments of G.

Note 1. We will write G_u and G_v instead of $G_u(uv)$ and $G_v(uv)$ when there is no scope for confusion. Observe that G_u (respectively, G_v) will be a single edge, if $deg_G(u) = 2$ (respectively, $deg_G(v) = 2$).



Fig. 1. G_u is the uv segment of the graph that contains u and G_v is the uv segment that contains v. In (a), G_u is a single edge.

Definition 2 (mvc and evc parameters). For a maximal outerplanar graph G and an edge uv, the set of parameters $\mathscr{M}(G, uv) = \{mvc(G), mvc_u(G), mvc_v(G), mvc_{uv}(G)\}$ is called the (set of) mvc parameters of G with respect to uv and the set $\mathscr{E}(G, uv) = \{evc(G), evc_u(G), evc_v(G), evc_v(G), evc_u(G)\}$ is called the (set of) evc parameters of G with respect to uv.

The following observation, which gives the mvc and evc parameters of a triangle, is the base case of the recursive computation of these parameters for larger graphs described in subsequent sections.

Observation 1 Let G be a triangle uvw. Consider the edge uv. Then, (1) $\operatorname{mvc}(G) = \operatorname{mvc}_u(G) = \operatorname{mvc}_u(G) = 2$ (2) $\operatorname{evc}(G) = \operatorname{evc}_u(G) = \operatorname{evc}_v(G) = 2$ and $\operatorname{evc}_{uv}(G) = 3$.

3 Computation of the mvc parameters

Throughout this section, we assume that G is a maximal outerplanar graph of at least four vertices, uv is an edge on the outer face of G and $w = \Delta(uv)$. The results in this section show that the mvc parameters of G with respect to the edge uv - viz., $\mathcal{M}(G, uv)$, can be computed in constant time if the mvc parameters of G_u with respect to uw - viz., $\mathcal{M}(G_u, uw)$ and the mvc parameters of G_v with respect to vw - viz., $\mathcal{M}(G_v, vw)$ are given.

The following observation is easy to see.

Observation 2 If $deg_G(u) = 2$ and $deg_G(v) > 2$, then, (1) $mvc(G) = mvc_{vw}(G_v)$ (2) $mvc_u(G) = mvc(G_v) + 1$, (3) $mvc_v(G) = mvc(G)$ and (4) $mvc_{uv}(G) = mvc_v(G_v) + 1$.

The following theorem is a consequence of Observation 2.

Theorem 1. Let G be a maximal outerplanar graph and uv be an edge on the outer face of G such that $deg_G(u) = 2$. Let $w = \Delta(uv)$.

- 1. Given $\mathcal{M}(G_v, vw)$, it is possible to compute mvc(G) in constant time.
- 2. Given mvc(G) and $\mathcal{M}(G_v, vw)$, it is possible to compute the remaining mvc parameters of G with respect to uv in constant time.

Now, we look at the computation of $\mathcal{M}(G, uv)$ when $deg_G(u) > 2$ and $deg_G(v) > 2$. The following observation is easy to obtain.

Observation 3 If $deg_G(u) > 2$ and $deg_G(v) > 2$, then $mvc(G) \in \{mvc(G_u) + mvc(G_v) - 1, mvc(G_u) + mvc(G_v)\}.$

The next lemma gives a method to compute mvc(G) using $\mathcal{M}(G_u, uw)$ and $\mathcal{M}(G_v, vw)$.

Lemma 1. If $deg_G(u) > 2$ and $deg_G(v) > 2$, then $mvc(G) = min\{mvc_w(G_u) + mvc_{vw}(G_v) - 1, mvc_{uw}(G_u) + mvc_w(G_v) - 1, mvc(G_u) + mvc(G_v)\}.$

Proof. It can be easily seen that $\operatorname{mvc}(G) \leq \min\{\operatorname{mvc}_w(G_u) + \operatorname{mvc}_{vw}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{mvc}_w(G_v) - 1, \operatorname{mvc}(G_u) + \operatorname{mvc}(G_v)\}$. By Observation 3, we have the following two cases to consider.

If $\operatorname{mvc}(G) = \operatorname{mvc}(G_u) + \operatorname{mvc}(G_v) - 1$, then both G_u and G_v have a minimum vertex cover with w. Further, either $\operatorname{mvc}_{uw}(G_u) = \operatorname{mvc}(G_u)$ or $\operatorname{mvc}_{vw}(G_v) = \operatorname{mvc}(G_v)$. Hence, it is clear that $\operatorname{mvc}(G) = \operatorname{mvc}(G_u) + \operatorname{mvc}(G_v) - 1 = \min\{\operatorname{mvc}_w(G_u) + \operatorname{mvc}_{vw}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{mvc}_w(G_v) - 1\}$. From this, the result follows.

If $\operatorname{mvc}(G) = \operatorname{mvc}(G_u) + \operatorname{mvc}(G_v)$, then by the upper bound shown in the beginning of this proof, $\operatorname{mvc}(G_u) + \operatorname{mvc}(G_v) = \operatorname{mvc}(G) \leq \min\{\operatorname{mvc}_w(G_u) + \operatorname{mvc}_{vw}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{mvc}_w(G_v) - 1\}.$ From this, the result follows.

The next lemma shows that given mvc(G), $\mathcal{M}(G_u, uw)$ and $\mathcal{M}(G_v, vw)$, the values of $mvc_u(G)$, $mvc_v(G)$ and $mvc_{uv}(G)$ are computable in constant time.

Lemma 2. Let $deg_G(u) > 2$ and $deg_G(v) > 2$. If $mvc(G) = mvc(G_u) + mvc(G_v) - 1$, then $mvc_u(G) = mvc_{uw}(G_u) + mvc(G_v) - 1$, $mvc_v(G) = mvc(G_u) + mvc_{vw}(G_v) - 1$ and $mvc_{uv}(G) = mvc_{uw}(G_u) + mvc_{vw}(G_v) - 1$.

Proof. Let $\operatorname{mvc}(G_u) = k_u$ and $\operatorname{mvc}(G_v) = k_v$. Since $\operatorname{mvc}(G) = k_u + k_v - 1$, both G_u and G_v have a minimum vertex cover with w. Let $k = \operatorname{mvc}_u(G)$. Since $\operatorname{mvc}_w(G_v) = k_v$, we can observe that G has a vertex cover C of size k such that $u, w \in C$. Now, it can be easily seen that C is the union of a vertex cover of G_u containing both u and w and a minimum vertex cover of G_v with w. Therefore, $\operatorname{mvc}_u(G) = \operatorname{mvc}_{uw}(G_u) + \operatorname{mvc}(G_v) - 1$. Similarly, it is easy to see that $\operatorname{mvc}_v(G) = \operatorname{mvc}(G_u) + \operatorname{mvc}_{vw}(G_v) - 1$. \Box

Lemma 3. Let $deg_G(u) > 2$ and $deg_G(v) > 2$. If $mvc(G) = mvc(G_u) + mvc(G_v)$, then $mvc_u(G) = min\{mvc_u(G_u) + mvc(G_v), mvc(G_u) + mvc_w(G_v), mvc(G) + 1\}$, $mvc_v(G) = min\{mvc(G_u) + mvc_v(G_v), mvc_w(G_u) + mvc(G_v), mvc(G) + 1\}$ and $mvc_{uv}(G) = min\{mvc_u(G_u) + mvc_v(G_v), mvc(G) + 1\}$.

Proof. Let $mvc(G_u) = k_u$ and $mvc(G_v) = k_v$.

First we prove that $\operatorname{mvc}_u(G) = \min\{\operatorname{mvc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{mvc}(G_u) + \operatorname{mvc}_w(G_v), \operatorname{mvc}(G) + 1\}$. It can be easily seen that $\operatorname{mvc}_u(G) \leq \min\{\operatorname{mvc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{mvc}(G_u) + \operatorname{mvc}_w(G_v), \operatorname{mvc}(G)\}$

+ 1]. Now, we need to show that $\operatorname{mvc}_u(G) \ge \min\{\operatorname{mvc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{mvc}(G_u) + \operatorname{mvc}_w(G_v), \operatorname{mvc}(G) + 1\}$. We know that $\operatorname{mvc}_u(G) \in \{\operatorname{mvc}(G), \operatorname{mvc}(G) + 1\}$. If $\operatorname{mvc}_u(G) = \operatorname{mvc}(G) + 1$, then the proof is immediate, because $\operatorname{mvc}_u(G)$ is equal to one of the three quantities listed and so it is greater than or equal to their minimum. Otherwise, we have $\operatorname{mvc}_u(G) = \operatorname{mvc}(G) = \operatorname{mvc}(G_u) + \operatorname{mvc}(G_v)$. In this case, it is enough to show that among the three parameters, the first or the second will be equal to $\operatorname{mvc}(G_u) + \operatorname{mvc}(G_v)$. For contradiction, suppose this was not the case. Then, $\operatorname{mvc}_u(G_u) = k_u + 1$ and $\operatorname{mvc}_w(G_v) = k_v + 1$. Consider any minimum vertex cover S of G such that $u \in S$. If $w \in S$, then $|S| \ge \operatorname{mvc}_u(G_u) + \operatorname{mvc}(G_v) - 1 \ge k_u + k_v + 1$, a contradiction. If $w \notin S$, again $|S| \ge \operatorname{mvc}_u(G_u) + \operatorname{mvc}(G_v) \ge k_u + k_v + 1$, a contradiction. The proof for $\operatorname{mvc}_v(G)$ is symmetric to the previous case.

Now, we show that $\operatorname{mvc}_{uv}(G) = \min\{\operatorname{mvc}_u(G_u) + \operatorname{mvc}_v(G_v), \operatorname{mvc}(G) + 1\}$. It is easy to see that $\operatorname{mvc}_{uv}(G) \leq \min\{\operatorname{mvc}_u(G_u) + \operatorname{mvc}_v(G_v), \operatorname{mvc}(G) + 1\}$. We know that $\operatorname{mvc}_{uv}(G) \in \{\operatorname{mvc}(G), \operatorname{mvc}(G) + 1\}$. Suppose $\operatorname{mvc}_{uv}(G) = \operatorname{mvc}(G) = k_u + k_v$. In this case, it suffices to show that $\operatorname{mvc}_u(G_u) = k_u$ and $\operatorname{mvc}_v(G_v) = k_v$. For contradiction, assume $\operatorname{mvc}_u(G_u) = k_u + 1$. Then, $\operatorname{mvc}_w(G_u) = k_u$. Since, $\operatorname{mvc}_{uv}(G) = k_u + k_v$, $\operatorname{mvc}_{vw}(G_v) = k_v$. Then, $\operatorname{mvc}(G) = k_u + k_v - 1$, which is a contradiction. Hence, $\operatorname{mvc}_u(G_u) \leq k_u$. Similarly, $\operatorname{mvc}_v(G_v) \leq k_v$ as required. Now, suppose $\operatorname{mvc}_{uv}(G) = \operatorname{mvc}(G) + 1 = k_u + k_v + 1$. In this case, it suffices to show that $\operatorname{mvc}_u(G_u) + \operatorname{mvc}_v(G_v) \geq \operatorname{mvc}_{uv}(G) = \operatorname{mvc}(G) + 1$, which is straightforward to obtain. \Box

From Lemma 1, Lemma 2 and Lemma 3, the following theorem is immediate.

Theorem 2. Let G be a maximal outerplanar graph and uv be an edge on the outer face of G such that $deg_G(u) > 2$ and $deg_G(v) > 2$. Let $w = \Delta(uv)$.

- 1. Given $\mathcal{M}(G_u, uw)$ and $\mathcal{M}(G_v, vw)$, it is possible to compute mvc(G) in constant time.
- 2. Given mvc(G), $\mathcal{M}(G_u, uw)$ and $\mathcal{M}(G_v, vw)$, it is possible to compute the remaining mvc parameters of G with respect to uv in constant time.

4 Bounds on the evc parameters

In this section, we will derive some bounds on the evc parameters of a maximal outerplanar graph. These bounds will be used in the next section for the recursive computation of the evc parameters. Throughout this section, we consider G to be a maximal outerplanar graph on at least four vertices, uv an edge on its outer face and $w = \Delta(uv)$.

First, we derive some bounds for $\mathscr{E}(G, uv)$ when $deg_G(u) = 2$.

Lemma 4. If u is a degree-2 vertex in G, then:

1. $\operatorname{evc}(G) \leq \operatorname{evc}_u(G) = \operatorname{evc}(G_v) + 1$

- 2. $\operatorname{evc}_{uv}(G) = \operatorname{evc}_v(G_v) + 1$
- 3. $\operatorname{evc}(G) \ge \max\{\operatorname{mvc}(G_v) + 1, \operatorname{evc}_{vw}(G_v)\}\$
- 4. $\operatorname{evc}_{v}(G) = \max\{\operatorname{mvc}_{uv}(G), \operatorname{evc}(G)\}\$

Proof. Let evc(G) = k.

- 1. First inequality is straightforward. So, it suffices to show that $\operatorname{evc}_u(G) = \operatorname{evc}(G_v) + 1$. From Proposition 1, $\max_{x \in V(G_v)} \operatorname{mvc}_x(G_v) = \operatorname{evc}(G_v)$. Hence, $\max_{x \in V(G_v)} \operatorname{mvc}_x(G) = \operatorname{evc}(G_v) + 1$. Hence, by Proposition 1, we get $\operatorname{evc}_u(G) = \operatorname{evc}(G_v) + 1$.
- 2. Similar to the previous case, by Proposition 1, $\max_{x \in V(G_v)} \operatorname{mvc}_x(G_v) = \operatorname{evc}(G_v)$. Hence, $\max_{x \in V(G_v)} \operatorname{mvc}_{xuv}(G) \leq \operatorname{evc}(G_v) + 1$. Hence, by Proposition 1, we get $\operatorname{evc}_{uv}(G) \leq \operatorname{evc}(G_v) + 1$. By Proposition 2 and Part 1 of this lemma, $\operatorname{evc}_{uv}(G) \geq \operatorname{evc}_u(G) = \operatorname{evc}_v(G_v) + 1$. Therefore, $\operatorname{evc}_{uv}(G) = \operatorname{evc}_v(G_v) + 1$.
- 3. By Observation 2, we get $\operatorname{mvc}_u(G) = \operatorname{mvc}(G_v) + 1$. By Proposition 1, since $\operatorname{evc}(G) \ge \operatorname{mvc}_u(G)$, we have $\operatorname{evc}(G) \ge \operatorname{mvc}(G_v) + 1$.

By Proposition 1, for any vertex $x \in V(G)$, $\operatorname{mvc}_x(G) \leq k$. Further, any vertex cover of G contain at least two vertices among u, v and w. Let x be an arbitrary vertex in G_v and C be a vertex cover of G of size k containing x. If C contains both v and w, the vertex cover obtained by restricting C to $V(G_v)$ gives a vertex cover of G_v of size at most k. If G does not contain v(respectively, w), then $C' = C \setminus \{u\} \cup \{v\}$ (respectively, $C' = C \setminus \{u\} \cup \{w\}$) is a vertex cover of G_v of size k that contains x, v and w. Therefore, for any vertex $x \in V(G_v)$, $\operatorname{mvc}_{xvw}(G_v) \leq k$ containing x along with both v and w. By Proposition 1, $\operatorname{evc}_{vw}(G_v) \leq k = \operatorname{evc}(G)$.

4. By Proposition 1, $\operatorname{evc}_v(G) \geq \operatorname{mvc}_{uv}(G)$ and it is easy to see that $\operatorname{evc}_v(G) \geq \operatorname{evc}(G)$. Hence, $\operatorname{evc}_v(G) \geq \max\{\operatorname{mvc}_{uv}(G), \operatorname{evc}(G)\}$. Now, we need to show that $\operatorname{evc}_v(G) \leq \max\{\operatorname{mvc}_{uv}(G), \operatorname{evc}(G)\}$. By Proposition 2, $\operatorname{evc}_v(G) \leq \operatorname{evc}(G) + 1$. If $\operatorname{evc}_v(G) = \operatorname{evc}(G)$, then we are done. Hence, suppose $\operatorname{evc}_v(G) = \operatorname{evc}(G) + 1$. In this case, it is enough to show that $\operatorname{mvc}_{uv}(G) \geq \operatorname{evc}(G) + 1$. By Proposition 1, we know that $\operatorname{evc}(G) = \max_{x \in V(G)} \operatorname{mvc}_x(G)$. Since degree of u is 2, this implies that for any vertex $x \in V(G) \setminus \{u\}$, $\operatorname{mvc}_{xv}(G) \leq \operatorname{evc}(G)$. If $\operatorname{mvc}_{uv}(G) \leq \operatorname{evc}(G)$, then by Proposition 1, $\operatorname{evc}_v(G) = \operatorname{evc}(G)$ which is a contradiction. Hence, $\operatorname{mvc}_{uv}(G) \geq \operatorname{evc}(G) + 1$ as required. \Box

Now, we derive some upper bounds for $\mathscr{E}(G, uv)$ when $deg_G(u) > 2$ and $deg_G(v) > 2$.

- **Proposition 3.** 1. $\max_{x \in V(G_v)} \operatorname{mvc}_x(G) \le \min\{\operatorname{mvc}_w(G_u) + \operatorname{evc}_{vw}(G_v) 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_w(G_v) 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_w(G_v)\}$
- 2. $\max_{x \in V(G_u)} \operatorname{mvc}_x(G) \le \min\{\operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_w(G_v) 1, \operatorname{evc}_w(G_u) + \operatorname{mvc}_{vw}(G_v) 1, \operatorname{evc}(G_u) + \operatorname{mvc}(G_v)\}.$

Proof. Since Parts 1 and 2 are symmetric, we only prove Part 1. Consider a vertex $x \in V(G_v)$. It can be easily seen that $\operatorname{mvc}_x(G) \leq \min\{\operatorname{mvc}_w(G_u) + \operatorname{mvc}_{xvw}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{mvc}_{xw}(G_v) - 1\}$. By Proposition 1, we get $\operatorname{mvc}_x(G) \leq \min\{\operatorname{mvc}_w(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_w(G_v) - 1\}$. Now, it remains to prove that $\operatorname{mvc}_x(G) \leq \operatorname{mvc}(G_u) + \operatorname{evc}(G_v)$. If $\operatorname{mvc}_x(G_v) = \operatorname{mvc}_x(G_v)$, then $\operatorname{mvc}_x(G) \leq \operatorname{mvc}(G_u) + \operatorname{mvc}_x(G_v) = \operatorname{mvc}_x(G_v)$, then $\operatorname{mvc}_x(G) \leq \operatorname{mvc}(G_u) + \operatorname{mvc}_x(G_v) \leq \operatorname{mvc}(G_v) + \operatorname{evc}(G_v)$ by Proposition 1. Otherwise, it

is the case that $\operatorname{mvc}_x(G_v) = \operatorname{mvc}_{xw}(G_v)$. This implies $\operatorname{mvc}_x(G) \leq \operatorname{mvc}_{uw}(G_u) + \operatorname{mvc}_{xw}(G_v) - 1$. Since, $\operatorname{mvc}_{uw}(G) \leq \operatorname{mvc}(G_u) + 1$, we get $\operatorname{mvc}_x(G) \leq \operatorname{mvc}(G_u) + \operatorname{mvc}_{xw}(G_v) = \operatorname{mvc}(G_u) + \operatorname{mvc}_x(G_v) \leq \operatorname{mvc}(G_u) + \operatorname{evc}(G_v)$ by Proposition 1. \Box

Lemma 5 gives an upper bound for evc(G) when $deg_G(u) > 2$ and $deg_G(v) > 2$.

Lemma 5. If $deg_G(u) > 2$ and $deg_G(v) > 2$, then:

- 1. $\operatorname{evc}(G) \leq \min\{\operatorname{mvc}(G) + 1, \operatorname{evc}_w(G_u) + \operatorname{evc}_w(G_v) 1\}$
- 2. $\operatorname{evc}(G) \leq \max\{U, V\}$ where $U = \min\{\operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_w(G_v) - 1, \operatorname{evc}_w(G_u) + \operatorname{mvc}_{vw}(G_v) - 1, \operatorname{evc}(G_u) + \operatorname{mvc}(G_v)\}\)$ and $V = \min\{\operatorname{mvc}_w(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_w(G_v) - 1, \operatorname{mvc}(G_u) + \operatorname{evc}(G_v)\}\)$
- *Proof.* 1. By Proposition 1, it is easy to see that $evc(G) \le \min\{mvc(G) + 1, evc_w(G_u) + evc_w(G_v) 1\}$.
- 2. By Proposition 3, we have $\max_{x \in V(G)} \operatorname{mvc}_x(G) \leq \max(U, V)$. Hence, by Proposition 1, we get $\operatorname{evc}(G) \leq \max(U, V)$.

Proposition 4. 1. $\max_{x \in V(G_v)} \operatorname{mvc}_{xv}(G) \leq \min\{\operatorname{mvc}(G_u) + \operatorname{evc}_v(G_v), \operatorname{mvc}_w(G_u) + \operatorname{evc}_{vw}(G_v) - 1\}$ 2. $\max_{x \in V(G_u)} \operatorname{mvc}_{xv}(G) \leq \min\{\operatorname{evc}(G_u) + \operatorname{mvc}_v(G_v), \operatorname{evc}_w(G_u) + \operatorname{mvc}_{vw}(G_v) - 1\}$

- *Proof.* 1. It is easy to see that for any vertex $x \in V(G_v)$, $\operatorname{mvc}_{xv}(G) \leq \operatorname{mvc}_w(G_u) + \operatorname{mvc}_{xvw}(G_v) 1$ and $\operatorname{mvc}_{xv}(G) \leq \operatorname{mvc}(G_u) + \operatorname{mvc}_{xv}(G_v)$. By Proposition 1, we get the result.
- 2. It is easy to see that for any vertex $x \in V(G_u)$, $\operatorname{mvc}_{xv}(G) \leq \operatorname{mvc}_x(G_u) + \operatorname{mvc}_v(G_v)$ and $\operatorname{mvc}_{xv}(G) \leq \operatorname{mvc}_{xw}(G_u) + \operatorname{mvc}_{vw}(G_v) 1$. By Proposition 1, we get the result. \Box

Lemma 6 gives an upper bound for $evc_v(G)$ when $deg_G(u) > 2$ and $deg_G(v) > 2$.

Lemma 6. If $deg_G(u) > 2$ and $deg_G(v) > 2$, then:

- 1. $\operatorname{evc}_{v}(G) \leq \min\{\operatorname{evc}(G) + 1, \operatorname{mvc}_{v}(G) + 1, \operatorname{evc}_{w}(G_{u}) + \operatorname{evc}_{vw}(G_{v}) 1\}$
- 2. $\operatorname{evc}_{v}(G) \leq \max\{U, V\}$, where $U = \min\{\operatorname{evc}(G_{u}) + \operatorname{mvc}_{v}(G_{v}), \operatorname{evc}_{w}(G_{u}) + \operatorname{mvc}_{vw}(G_{v}) 1\}$ and $V = \min\{\operatorname{mvc}(G_{u}) + \operatorname{evc}_{v}(G_{v}), \operatorname{mvc}_{w}(G_{u}) + \operatorname{evc}_{vw}(G_{v}) 1\}$
- *Proof.* 1. By Proposition 2, we know that $\operatorname{evc}_v(G) \leq \operatorname{evc}(G) + 1$. By Proposition 4, $\max_{x \in V(G_u)} \operatorname{mvc}_{xv}(G) \leq \operatorname{evc}_w(G_u) + \operatorname{mvc}_{vw}(G_v) 1 \leq \operatorname{evc}_w(G_u) + \operatorname{evc}_{vw}(G_v) 1$ and $\max_{x \in V(G_v)} \operatorname{mvc}_{xv}(G) \leq \operatorname{mvc}_w(G_u) + \operatorname{evc}_{vw}(G_v) 1 \leq \operatorname{evc}_w(G_u) + \operatorname{evc}_{vw}(G_v) 1$. By Proposition 1, we get $\operatorname{evc}_v(G) \leq \operatorname{evc}_w(G_u) + \operatorname{evc}_{vw}(G_v) 1$. By Proposition 1, we also get $\operatorname{evc}_v(G) \leq \operatorname{mvc}_v(G) + 1$. Hence, we are done.
- 2. By Proposition 4, we have $\max_{x \in V(G_u)} \operatorname{mvc}_{vx}(G) \leq U$ and $\max_{y \in V(G_v)} \operatorname{mvc}_{vy}(G) \leq V$. Therefore, by Proposition 1, we get $\operatorname{evc}_v(G) = \max_{x \in V(G)} \operatorname{mvc}_{vx}(G) \leq \max\{U, V\}$.

Proposition 5 and Lemma 7 are symmetric to Proposition 4 and Lemma 6 respectively.

Proposition 5. 1. $\max_{x \in V(G_u)} \operatorname{mvc}_{xu}(G) \le \min\{\operatorname{evc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_w(G_v) - 1\}$

2.
$$\max_{x \in V(G_v)} \operatorname{mvc}_{xu}(G) \le \min\{\operatorname{mvc}_u(G_u) + \operatorname{evc}(G_v), \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_w(G_v) - 1\}$$

Lemma 7. If $deg_G(u) > 2$ and $deg_G(v) > 2$, then:

1. $\operatorname{evc}_u(G) \le \min\{\operatorname{evc}(G) + 1, \operatorname{mvc}_u(G) + 1, \operatorname{evc}_{uw}(G_u) + \operatorname{evc}_w(G_v) - 1\}$

2. $\operatorname{evc}_u(G) \leq \max\{U, V\}$, where $U = \min\{\operatorname{evc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_w(G_v) - 1\}$ and $V = \min\{\operatorname{mvc}_u(G_u) + \operatorname{evc}(G_v), \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_w(G_v) - 1\}$

Proposition 6. 1. $\max_{x \in V(G_u)} \operatorname{mvc}_{xuv}(G) \le \min\{\operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_{vw}(G_v) - 1, \operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v)\}$ 2. $\max_{x \in V(G_v)} \operatorname{mvc}_{xuv}(G) \le \min\{\operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{mvc}_u(G_u) + \operatorname{evc}_v(G_v)\}$

- *Proof.* 1. Consider any vertex $x \in V(G_u)$. By Proposition 1, we have $mvc_{xuw}(G_u) \leq evc_{uw}(G_u)$. This implies $\operatorname{mvc}_{uv}(G) \leq \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_{vw}(G_v) - 1$. Similarly, by Proposition 1, we have $\operatorname{mvc}_{xu}(G_u) \leq \operatorname{evc}_u(G_u)$. This implies $\operatorname{mvc}_{xuv}(G) \leq \operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v)$. Thus, for any $x \in$ $V(G_u)$, we have $\operatorname{mvc}_{xuv}(G) \leq \min\{\operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_{vw}(G_v) - 1, \operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v)\}$. 2. This case is symmetric to the previous one.

Lemma 8 gives an upper bound for $evc_{uv}(G)$ when $deg_G(u) > 2$ and $deg_G(v) > 2$.

Lemma 8. If $deg_G(u) > 2$ and $deg_G(v) > 2$, then:

- 1. $\operatorname{evc}_{uv}(G) \leq \min\{\operatorname{evc}(G) + 1, \operatorname{mvc}_{uv}(G) + 1, \max\{P_1, P_2\}\}, where$ $P_1 = \min\{\operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_{vw}(G_v) - 1, \operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v)\} \text{ and }$ $P_2 = \min\{\operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{mvc}_u(G_u) + \operatorname{evc}_v(G_v)\}$
- 2. $\operatorname{evc}_{uv}(G) \leq \min\{Q, \operatorname{evc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) 1, \operatorname{evc}_u(G_u) + \operatorname{evc}(G_v), \operatorname{evc}_v(G_v) + \operatorname{evc}(G_u)\}, where$ $Q = \max\{\operatorname{evc}_u(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v)\}$
- *Proof.* 1. By Proposition 2, we know that $evc_{uv}(G) \leq evc(G) + 1$. By Proposition 1, we know that $\operatorname{evc}_{uv}(G) \leq \operatorname{mvc}(G) + 1$. By Proposition 1 and Proposition 6, we get $\operatorname{evc}_{uv}(G) = \max_{x \in V(G)} \operatorname{mvc}(G)$ $\operatorname{mvc}_{xuv}(G) \leq \max(P_1, P_2).$
- 2. It can be easily seen that $\operatorname{evc}_{uv}(G) \leq \operatorname{evc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) 1$. Now, we show that $\operatorname{evc}_{uv}(G) \leq Q$. By Proposition 6, we get $\max_{x \in V(G)} \operatorname{mvc}_{xuv}(G) \leq \max\{\operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) - \operatorname{mvc}_{uw}(G_u)\}$ 1, $\operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v)$ }. Hence, by Proposition 1, we get $\operatorname{evc}_{uv}(G) \leq Q$. Next, we show that $evc_{uv}(G) \leq evc_u(G_u) + evc(G_v)$. By Proposition 1 and Proposition 6, we get $\max_{x \in V(G_u)} \operatorname{mvc}_{xuv}(G) \leq \operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v) \leq \operatorname{evc}_u(G_u) + \operatorname{evc}(G_v)$. Since $\operatorname{mvc}_{uw}(G_u) \leq \operatorname{mvc}_u(G_u) < \operatorname{mvc}_u(G_u) <$ $\operatorname{evc}_u(G_u)$ by Proposition 1 and $\operatorname{evc}_{uw}(G_v) \leq \operatorname{evc}(G_v) + 1$ by Proposition 2, using Proposition 6, we get $\max_{x \in V(G_v)} \operatorname{mvc}_{xuv}(G) \leq \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) - 1 \leq \operatorname{evc}_u(G_u) + \operatorname{evc}(G_v)$. Hence, by Proposition 1, we get $\operatorname{evc}_{uv}(G) \leq \operatorname{evc}_u(G_u) + \operatorname{evc}(G_v)$. Symmetrically, we can prove that $\operatorname{evc}_{uv}(G) \leq \operatorname{evc}(G_u) + \operatorname{evc}_v(G_v).$

The following lemma gives some lower bounds for $\mathscr{E}(G, uv)$ when $deg_G(u) > 2$ and $deg_G(v) > 2$.

Lemma 9. If $deg_G(u) > 2$ and $deg_G(v) > 2$, then:

- 1. $\operatorname{evc}(G) \ge \max\{\operatorname{evc}_w(G_u) + \operatorname{mvc}(G_v) 1, \operatorname{mvc}(G_u) + \operatorname{evc}_w(G_v) 1\}$
- 2. $\operatorname{evc}_u(G) \ge \max\{\operatorname{evc}(G), \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}(G_v) 1, \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}(G_v) 1, \operatorname{evc}_{uw}(G_v) + \operatorname{mvc}(G_v) + \operatorname{mvc}(G_v) 1, \operatorname{evc}_{uw}(G_v) + \operatorname{mvc}(G_v) + \operatorname{mvc}(G_v) 1, \operatorname{evc}_{uw}(G_v) + \operatorname{mvc}(G_v) + \operatorname{mvc}(G_v)$ $\operatorname{evc}_u(G_u) + \operatorname{mvc}_w(G_v) - 1$
- $evc_u(G_u) + mvc_{vw}(G_v) - 1, evc_{uw}(G_u) + mvc_v(G_v) - 1, mvc_u(G_u) + evc_{vw}(G_v) - 1$
- *Proof.* 1. For any vertex $x \in V(G_u)$, consider a minimum vertex cover S_x of G of size $mvc_x(G)$ containing x. It is easy to see that $|S_x \cap V(G_v)| \ge \operatorname{mvc}(G_v)$. If $w \in S_x$, then $|S_x \cap V(G_u)| \ge$ $\operatorname{mvc}_{wx}(G_u)$ and hence, $\operatorname{mvc}_{x}(G) \geq \operatorname{mvc}_{wx}(G_u) + \operatorname{mvc}(G_v) - 1$. If $w \notin S_x$, then $|S_x \cap V(G_u)| \geq$ $\operatorname{mvc}_{x}(G_{u})$. Therefore, $\operatorname{mvc}_{x}(G) \geq \operatorname{mvc}_{x}(G_{u}) + \operatorname{mvc}(G_{v})$. Since $\operatorname{mvc}_{wx}(G_{u}) \leq \operatorname{mvc}_{x}(G_{u}) + 1$, in this case also we get $mvc_x(G) \ge mvc_{wx}(G_u) + mvc(G_v) - 1$. By Proposition 1, we get $\operatorname{evc}(G) \geq \max_{x \in V(G_n)} \operatorname{mvc}_x(G)$

 $\geq \max_{x \in V(G_u)} \operatorname{mvc}_{wx}(G_u) + \operatorname{mvc}(G_v) - 1 \geq \operatorname{evc}_w(G_u) + \operatorname{mvc}(G_v) - 1$. Symmetrically, we get $\operatorname{evc}(G) \geq \operatorname{mvc}(G_u) + \operatorname{evc}_w(G_v) - 1$. From this, the result follows.

- 2. By Proposition 1, it can be easily seen that $\operatorname{evc}_u(G) \geq \operatorname{evc}(G)$. By Proposition 1, there exists a vertex $x \in V(G_v)$ such that $\operatorname{mvc}_x(G_v) = \operatorname{evc}(G_v)$. Let S_{xu} be a vertex cover of G of size $\operatorname{mvc}_{xu}(G)$ containing x and u. If $w \in S_{xu}$, then it can be seen that $|S_{xu}| \geq \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}(G_v) = 1$. Otherwise, we get $|S_{xu}| \geq \operatorname{mvc}_u(G_u) + \operatorname{evc}(G_v) \geq \operatorname{mvc}_{uw}(G_u) - 1 + \operatorname{evc}(G_v)$. Hence, by Proposition 1, we get $\operatorname{evc}_u(G) \geq \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}(G_v) - 1$. Next, we to show that $\operatorname{evc}_u(G) \geq \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}(G_v) - 1$. For every vertex $x \in V(G_u)$, $\operatorname{mvc}_{xu}(G) \geq \operatorname{mvc}_{xuw}(G_u) + \operatorname{mvc}(G_v) - 1$. By Proposition 1, it can be seen that $\operatorname{evc}_u(G) \geq \operatorname{max}_{x \in V(G_u)} \operatorname{mvc}_{xu}(G) \geq \operatorname{mvc}_{xu}(G) \geq \operatorname{mvc}_{xu}(G_u) + \operatorname{mvc}(G_v) - 1$. Now, it remains to show that $\operatorname{evc}_u(G) \geq \operatorname{evc}_u(G_u) + \operatorname{mvc}_w(G_v) - 1$. By Proposition 1, there exists a vertex $x \in V(G_u)$ such that $\operatorname{mvc}_{xu}(G_u) = \operatorname{evc}(G_u)$. Let S_{xu} be a vertex cover of G of size $\operatorname{mvc}_{xu}(G)$ containing x and u. If $w \in S_{xu}$, then it can be seen that $|S_{xu}| \geq \operatorname{mvc}_{xuw}(G_u) + \operatorname{mvc}_w(G_v) - 1 = \operatorname{evc}_u(G_u) + \operatorname{mvc}_w(G_v) - 1$. Otherwise, we get $|S_{xu}| \geq \operatorname{evc}_u(G_u) + \operatorname{mvc}(G_v) \geq \operatorname{evc}_u(G_u) + \operatorname{mvc}_w(G_v) - 1$. Hence, by Proposition 1, we get $\operatorname{evc}_u(G) \geq \operatorname{evc}_u(G_u) + \operatorname{mvc}_w(G_v) - 1$.
- 3. By Proposition 1, it can be easily seen that $\operatorname{evc}_{uv}(G) \ge \max\{\operatorname{evc}(G), \operatorname{evc}_u(G), \operatorname{evc}_v(G)\}$. Similar to the proof of $\operatorname{evc}_u(G) \ge \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_u(G_v)$ in the previous case, we get $\operatorname{evc}_{uv}(G) \ge \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_v(G_v) 1$ and $\operatorname{evc}_{uv}(G) \ge \operatorname{evc}_u(G_u) + \operatorname{mvc}_{vw}(G_v) 1$. Similar to the proof of $\operatorname{evc}_u(G) \ge \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}(G_v) 1$ in the previous case, we get $\operatorname{evc}_{uv}(G) \ge \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_v(G_v) 1$ and $\operatorname{evc}_{uv}(G) \ge \operatorname{mvc}_u(G_u) + \operatorname{mvc}_v(G_v) 1$. \Box

5 Computation of the evc parameters

Let G be a maximal outerplanar graph with at least four vertices, uv be an edge on its outer face and $w = \Delta(uv)$. In this section, we describe the method of computing $\mathscr{E}(G, uv)$ using the bounds obtained in Section 4.

5.1 Computing $\mathscr{E}(G, uv)$ when $deg_G(u) = 2$

In this subsection, we consider the case when u is a degree-2 vertex in G.

Lemma 10. Let $\operatorname{mvc}(G_v) \neq \operatorname{evc}(G_v)$. Then, $\operatorname{evc}(G) = \operatorname{evc}(G_v)$ if and only if $\operatorname{evc}_{vw}(G_v) = \operatorname{evc}(G_v)$.

Proof. Let $\operatorname{mvc}(G_v) < \operatorname{evc}(G_v) \le \operatorname{evc}_{vw}(G_v)$. Then, by Proposition 1, $\operatorname{evc}(G_v) = \operatorname{mvc}(G_v) + 1$. Lemma 4 Part 3, $\operatorname{evc}(G) \ge \operatorname{evc}_{vw}(G_v)$.

To prove the forward direction, assume $\operatorname{evc}(G) = \operatorname{evc}(G_v)$. This gives $\operatorname{evc}(G_v) = \operatorname{evc}(G) \geq \operatorname{evc}_{vw}(G_v)$. This implies $\operatorname{evc}(G_v) = \operatorname{evc}_{vw}(G_v)$. Now, to prove the reverse direction, assume $\operatorname{evc}_{vw}(G_v) = \operatorname{evc}(G_v)$. It is enough to show that $\operatorname{evc}(G) \leq \operatorname{evc}_{vw}(G_v)$. By Proposition 1, for any vertex $x \in V(G_v)$, we get $\operatorname{mvc}_{xvw}(G_v) \leq \operatorname{evc}(G_v)$ which implies $\operatorname{mvc}_x(G) \leq \operatorname{evc}(G_v)$. Moreover, since $\operatorname{mvc}_u(G) \leq \operatorname{mvc}(G_v) + 1 = \operatorname{evc}(G_v)$, by Proposition 1, $\operatorname{evc}(G) \leq \operatorname{evc}(G_v) = \operatorname{evc}_{vw}(G_v)$. \Box

Lemma 11. $evc(G) = max\{mvc(G_v) + 1, evc_{vw}(G_v)\}.$

Proof. We prove this lemma by splitting into following two cases.

1. Suppose $\operatorname{mvc}(G_v) = \operatorname{evc}(G_v)$. In this case, by Lemma 4, Part 1 and Part 3, we have $\operatorname{evc}(G) = \operatorname{evc}(G_v) + 1 = \operatorname{mvc}(G_v) + 1$. Further by Part 3 of Lemma 4, $\operatorname{evc}_{vw}(G_v) \leq \operatorname{evc}(G)$. Thus, we have $\operatorname{evc}(G) = \max\{\operatorname{mvc}(G_v) + 1, \operatorname{evc}_{vw}(G_v)\}.$

2. Suppose $\operatorname{mvc}(G_v) < \operatorname{evc}(G_v)$. If $\operatorname{evc}_{vw}(G_v) = \operatorname{evc}(G_v)$, then by Lemma 10, we have $\operatorname{evc}(G) = \operatorname{evc}(G_v) = \operatorname{evc}(G_v) = \operatorname{mvc}(G_v) + 1$. Else if $\operatorname{evc}_{vw}(G_v) \neq \operatorname{evc}(G_v)$, then by Lemma 10 and Proposition 2, we get $\operatorname{evc}(G) = \operatorname{evc}(G_v) + 1 = \operatorname{evc}_{vw}(G_v)$. In both the cases, we can observe that $\operatorname{evc}(G) = \operatorname{max}\{\operatorname{mvc}(G_v) + 1, \operatorname{evc}_{vw}(G_v)\}$.

From Lemma 4 and Lemma 11, the following theorem is immediate.

Theorem 3. Let G be a maximal outerplanar graph and u be a degree-2 vertex in G with neighbors v and w.

- 1. Given $mvc(G_v)$ and $\mathscr{E}(G_v, vw)$, it is possible to compute evc(G) in constant time.
- 2. Given evc(G), $\mathscr{M}(G, uv)$ and $\mathscr{E}(G_v, vw)$, it is possible to compute the remaining evc parameters of G with respect to uv in constant time.

5.2 Computing $\mathscr{E}(G, uv)$ when $deg_G(u) > 2$ and $deg_G(v) > 2$

Now, we will see how $\mathscr{E}(G, uv)$ can be computed when $deg_G(u) > 2$ and $deg_G(v) > 2$ using mvc(G), $\mathscr{M}(G_u, uw)$, $\mathscr{M}(G_v, vw)$, $\mathscr{E}(G_u, uw)$ and $\mathscr{E}(G_v, vw)$. For this subsection, we will assume that $deg_G(u) > 2$ and $deg_G(v) > 2$. We will also assume that $mvc(G_u) = k_u$ and $mvc(G_v) = k_v$.

Lemmas 12-14 handle the computation of evc(G).

Lemma 12. If $\operatorname{evc}(G_u) = k_u$ and $\operatorname{evc}(G_v) = k_v$, then $\operatorname{evc}(G) = \max\{\operatorname{evc}_w(G_u) + \operatorname{mvc}(G_v) - 1, \operatorname{mvc}(G_u) + \operatorname{evc}_w(G_v) - 1\}.$

Proof. First, suppose $\operatorname{evc}_w(G_u) = k_u$ and $\operatorname{evc}_w(G_v) = k_v$. By Lemma 5 Part 1, we have $\operatorname{evc}(G) \leq k_u + k_v - 1$. By Observation 3 and Proposition 1, we get $\operatorname{evc}(G) = k_u + k_v - 1$. Note that in this case $\max\{\operatorname{evc}_w(G_u) + \operatorname{mvc}(G_v) - 1, \operatorname{mvc}(G_u) + \operatorname{evc}_w(G_v) - 1\} = k_u + k_v - 1$ as well.

Now, by Proposition 2, it remains to consider the case when $\operatorname{evc}_w(G_u) = k_u + 1$ or $\operatorname{evc}_w(G_v) = k_v + 1$. In this case, $\max\{\operatorname{evc}_w(G_u) + \operatorname{mvc}(G_v) - 1, \operatorname{mvc}(G_u) + \operatorname{evc}_w(G_v) - 1\} = k_u + k_v$. We will show that $\operatorname{evc}(G) = k_u + k_v$. From Lemma 5 Part 2, we get $\operatorname{evc}(G) \leq \max\{\operatorname{evc}(G_u) + \operatorname{mvc}(G_v), \operatorname{mvc}(G_u) + \operatorname{evc}(G_v)\} = k_u + k_v$. By Lemma 9 Part 1, we get $\operatorname{evc}(G) \geq \max\{\operatorname{evc}_w(G_u) + \operatorname{mvc}(G_v) - 1, \operatorname{mvc}(G_u) + \operatorname{evc}_w(G_v) - 1\}$. Hence, we are done. \Box

Lemma 13. If $evc(G_u) = k_u$ and $evc(G_v) = k_v + 1$, then $evc(G) = min\{mvc(G) + 1, evc(G_u) + evc_{vw}(G_v) - 1, mvc_{uw}(G_u) + evc_w(G_v) - 1\}$.

Proof. Since $\operatorname{evc}(G_v) = k_v + 1$, by Lemma 9 Part 1, we get $\operatorname{evc}(G) \ge k_u + k_v$. By Observation 3 and Proposition 1, we get $\operatorname{evc}(G) \in \{k_u + k_v, k_u + k_v + 1\}$. By Proposition 2, it is easy to see that $\min\{\operatorname{mvc}(G) + 1, \operatorname{evc}(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_w(G_v) - 1\} \in \{k_u + k_v, k_u + k_v + 1\}$.

Let U and V be as defined in Lemma 5 Part 2. From our assumptions, it follows that $U \leq k_u + k_v$ and $V \geq k_u + k_v$. Hence by Lemma 5 Part 2, we get $\operatorname{evc}(G) \leq V \leq \min\{\operatorname{evc}(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_{w}(G_v) - 1\}$. From this, using Proposition 1, we get $\operatorname{evc}(G) \leq \min\{\operatorname{mvc}(G) + 1, \operatorname{evc}(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) - 1\}$.

Hence, it suffices to show that when $\operatorname{evc}(G) = k_u + k_v$, then $\min\{\operatorname{mvc}(G) + 1, \operatorname{evc}(G_u) + \operatorname{evc}_{w}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_w(G_v) - 1\} = k_u + k_v$. For this, suppose $\operatorname{evc}(G) = k_u + k_v$. By Lemma 9 Part 1, we have $\operatorname{evc}_w(G_u) \leq k_u + 1$ and $\operatorname{evc}_w(G_v) \leq k_v + 1$. If $\operatorname{mvc}_{uw}(G_u) = k_u$, we get $\min\{\operatorname{evc}(G_u) + \operatorname{evc}_{w}(G_v) - 1, \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_w(G_v) - 1\} \leq k_u + k_v = \operatorname{evc}(G)$ as required. Therefore, let us assume that $\operatorname{mvc}_{uw}(G_u) = k_u + 1$. In this case, it is enough to show that $\operatorname{evc}_{vw}(G_v) = k_v + 1$. By Proposition 1, there exists a vertex $x \in V(G_v)$ such that $\operatorname{mvc}_x(G_v) = k_v + 1$. Consider such

a vertex x. By Proposition 1, we know there exits a vertex cover S_x of G such that $x \in S_x$ and $|S_x| = \text{evc}(G) = k_u + k_v$. Since $\text{mvc}_{uw}(G_u) = k_u + 1$ and $\text{mvc}_x(G_v) = k_v + 1$, it is easy to see that $u \notin S_x$ and hence $v, w \in S_x$. Further, $|S_x \cap V(G_v)| = k_v + 1$ and hence $\text{mvc}_{xvw}(G_v) = k_v + 1$. By Proposition 1, this implies that $\text{evc}_{vw}(G_v) = k_v + 1$, as required.

Lemma 14. If $evc(G_u) = k_u + 1$ and $evc(G_v) = k_v + 1$, then $evc(G) = min\{mvc(G) + 1, max\{evc_{uw}(G_u) + mvc_w(G_v) - 1, mvc_w(G_u) + evc_{vw}(G_v) - 1\}\}.$

Proof. Since $\operatorname{evc}(G_v) = k_v + 1$, by Lemma 9 Part 1, we get $\operatorname{evc}(G) \ge k_u + k_v$. By Observation 3 and Proposition 1, we get $\operatorname{evc}(G) \in \{k_u + k_v, k_u + k_v + 1\}$. By Proposition 2, it is easy to see that $\min\{\operatorname{mvc}(G)+1, \max\{\operatorname{evc}_{uw}(G_u)+\operatorname{mvc}_w(G_v)-1, \operatorname{mvc}_w(G_u)+\operatorname{evc}_{vw}(G_v)-1\}\} \in \{k_u+k_v, k_u+k_v+1\}$.

By Lemma 5, we get $\operatorname{evc}(G) \leq \min\{\operatorname{mvc}(G) + 1, \max\{\operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_w(G_v) - 1, \operatorname{evc}_{vw}(G_v) + \operatorname{mvc}_w(G_u) - 1\}\}$. Hence, it is enough to show that if $\operatorname{evc}(G) = k_u + k_v$, then $\min\{\operatorname{mvc}(G) + 1, \max\{\operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_w(G_v) - 1, \operatorname{evc}_{vw}(G_v) + \operatorname{mvc}_w(G_u) - 1\}\} = k_u + k_v$.

For this, suppose $\operatorname{evc}(G) = k_u + k_v$. Since $\operatorname{evc}(G) = k_u + k_v$, $\operatorname{evc}(G_u) = k_u + 1$ and $\operatorname{evc}(G_v) = k_v + 1$, by Lemma 9 Part 1, we get $\operatorname{evc}_w(G_u) = k_u + 1$ and $\operatorname{evc}_w(G_v) = k_v + 1$. Now, it is enough to show that $\operatorname{mvc}_w(G_u) = k_u$ and $\operatorname{mvc}_w(G_v) = k_v$. Since $\operatorname{evc}_w(G_u) = k_u + 1$, by Proposition 1, there exists a vertex $x \in V(G_u)$ such that $\operatorname{mvc}_{xw}(G_u) = k_u + 1$. By Proposition 1, we know $k_u + k_v = \operatorname{evc}(G) \ge \operatorname{mvc}_w(G)$. Therefore, it has to be the case that $\operatorname{mvc}_w(G_v) = k_v$. Symmetrically, we get $\operatorname{mvc}_w(G_u) = k_u$. \Box

Lemmas 15- 21 deal with the computation of the remaining parameters in $\mathscr{E}(G, uv)$ using evc(G), $\mathscr{M}(G, uv)$, $\mathscr{M}(G_u, uw)$, $\mathscr{M}(G_v, vw)$, $\mathscr{E}(G_u, uw)$ and $\mathscr{E}(G_v, vw)$.

Lemma 15. If $\operatorname{evc}(G_u) = k_u$, $\operatorname{evc}(G_v) = k_v$ and $\operatorname{evc}(G) = k_u + k_v - 1$, then $\operatorname{evc}_u(G) = \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}(G_v) - 1$, $\operatorname{evc}_v(G) = \operatorname{evc}_{vw}(G_v) + \operatorname{mvc}(G_u) - 1$ and $\operatorname{evc}_{uv}(G) = \min\{\operatorname{mvc}_{uv}(G) + 1, \operatorname{evc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) - 1\}.$

Proof. By Lemma 9 Part 1, we know $\operatorname{evc}(G) \ge \max\{\operatorname{evc}_w(G_u) + \operatorname{mvc}(G_v) - 1, \operatorname{mvc}(G_u) + \operatorname{evc}_w(G_v) - 1\}$. Therefore, we get $\operatorname{evc}_w(G_u) = k_u$ and $\operatorname{evc}_w(G_v) = k_v$. By Proposition 1, we know $\operatorname{mvc}_{uw}(G_u) = k_u$ and $\operatorname{mvc}_{vw}(G_v) = k_v$. Hence, we get $\operatorname{mvc}_{uv}(G) = k_u + k_v - 1$.

First, we will prove the expression for $\operatorname{evc}_u(G)$. By Lemma 7, $\operatorname{evc}_u(G) \leq \operatorname{evc}_{uw}(G_u) + \operatorname{evc}_w(G_v) - 1 = \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}(G_v) - 1$. By Lemma 9 Part 2, we get $\operatorname{evc}_u(G) \geq \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}(G_v) - 1$. Hence, $\operatorname{evc}_u(G) = \operatorname{evc}_{uw}(G_u) + \operatorname{mvc}(G_v) - 1$. Similarly, we get $\operatorname{evc}_v(G) = \operatorname{evc}_{vw}(G_v) + \operatorname{mvc}(G_u) - 1$. Now, we show that $\operatorname{evc}_{uv}(G) = \min\{\operatorname{mvc}_{uv}(G) + 1, \operatorname{evc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) - 1\}$. By Lemma 8, we have $\operatorname{evc}_{uv}(G) \leq \min\{\operatorname{mvc}_{uv}(G) + 1, \operatorname{evc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) - 1\}$. By Proposition 1, we know that $\operatorname{evc}_{uv}(G) \in \{\operatorname{mvc}_{uv}(G), \operatorname{mvc}_{uv}(G) + 1\}$. Now, it is enough to show that if $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G)$, then $\operatorname{evc}_{uw}(G_u) + \operatorname{evc}_{vw}(G)$ Recall that $\operatorname{mvc}_{uv}(G) = k_u + k_v - 1$. Suppose $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G) = k_u + k_v - 1$. Then, by Lemma 9 Part 3, we get $\operatorname{evc}_{uw}(G_u) = k_u$ and $\operatorname{evc}_{vw}(G_v) = k_v$. Therefore, $\operatorname{evc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) - 1 = k_u + k_v - 1$. \Box

Lemma 16. If $\operatorname{evc}(G_u) = k_u$, $\operatorname{evc}(G_v) = k_v$ and $\operatorname{evc}(G) = k_u + k_v$, then $\operatorname{evc}_u(G) = \operatorname{evc}_v(G) = \operatorname{evc}(G)$ and $\operatorname{evc}_{uv}(G) = \min\{\operatorname{evc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{evc}_v(G_v) + \operatorname{mvc}(G_u), \operatorname{mvc}_{uv}(G) + 1\}.$

Proof. Since $\operatorname{evc}_{uw}(G_u) \leq k_u + 1$ by Proposition 2 and $\operatorname{mvc}_w(G_v) = k_v$ by Proposition 1, it follows by Lemma 7 that $\operatorname{evc}_u(G) \leq \max\{\operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_w(G_v) - 1, \operatorname{mvc}_u(G_u) + \operatorname{evc}(G_v)\} = k_u + k_v = \operatorname{evc}(G)$ and by Lemma 9 Part 2, we get $\operatorname{evc}_u(G) \geq \operatorname{evc}(G) = k_u + k_v$, Hence, we get $\operatorname{evc}_u(G) = \operatorname{evc}(G)$. Similarly, we get $\operatorname{evc}_v(G) = \operatorname{evc}(G)$. Now, we show that $\operatorname{evc}_{uv}(G) = \min\{\operatorname{evc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{mvc}(G_u) + \operatorname{evc}_v(G_v), \operatorname{mvc}_{uv}(G) + 1\}$. Since by Proposition 1, $\operatorname{mvc}_u(G_u) = k_u$ and $\operatorname{mvc}_v(G_v) = k_v$, by Lemma 8 Part 1, we have $\operatorname{evc}_{uv}(G) \leq \min\{\operatorname{evc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{mvc}(G_u) + \operatorname{evc}_v(G_v), \operatorname{mvc}_{uv}(G) + 1\}$. We know that $\operatorname{evc}_{uv}(G) \in \{\operatorname{mvc}_{uv}(G), \operatorname{mvc}_{uv}(G) + 1\}$. So, it is now enough to show that when $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G)$, then $\min\{\operatorname{evc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{mvc}(G_u) + \operatorname{evc}_v(G_v)\} = \operatorname{evc}_{uv}(G)$.

Consider the case when $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G)$. In this case, we will show that $\operatorname{mvc}_{uv}(G) = k_u + k_v$. Since we have already proved that $\operatorname{evc}_u(G) = \operatorname{evc}(G) = k_u + k_v$, by Proposition 1, we know that $\operatorname{mvc}_{uv}(G) \leq k_u + k_v$. Moreover, since $\operatorname{evc}_{uv}(G) \geq \operatorname{evc}(G) = k_u + k_v$, we get $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G) = k_u + k_v$. It remains to show that $\min\{\operatorname{evc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{mvc}(G_u) + \operatorname{evc}_v(G_v)\} = k_u + k_v$. Since $\operatorname{mvc}_{uv}(G) = k_u + k_v$, it can be easily seen that either $\operatorname{mvc}_{uw}(G_u) = k_u + 1$ or $\operatorname{mvc}_{vw}(G_v) = k_v + 1$. Without loss of generality, assume that $\operatorname{mvc}_{uw}(G_u) = k_u + 1$. In this case, since $\operatorname{evc}_{uv}(G) = k_u + k_v$, by Lemma 9 Part 3, we get $\operatorname{evc}_v(G_v) = k_v$. Hence, we get $\min\{\operatorname{evc}_u(G_u) + \operatorname{mvc}(G_v), \operatorname{mvc}(G_u) + \operatorname{evc}_v(G_v)\} = k_u + k_v$.

Lemma 17. If $\operatorname{evc}(G_u) = k_u$, $\operatorname{evc}(G_v) = k_v + 1$ and $\operatorname{mvc}(G) = k_u + k_v - 1$, then: $\operatorname{evc}_u(G) = \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}(G_v) - 1$, $\operatorname{evc}_v(G) = \min\{\operatorname{mvc}_v(G) + 1, \operatorname{evc}_w(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{mvc}_v(G_u) + \operatorname{mvc}_v(G_v) + 1, \operatorname{evc}_{vw}(G_v) - 1, \operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v)\}\}$ $\operatorname{evc}_{uv}(G) = \min\{\operatorname{mvc}_{uv}(G) + 1, \operatorname{evc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{evc}_u(G_u) + \operatorname{max}\{\operatorname{evc}_{vw}(G_v) - 1, \operatorname{mvc}_v(G_v)\}\}$

Proof. Since $evc(G_v) = k_v + 1$, by Lemma 13, it can be seen that $evc(G) = k_u + k_v$.

First, we will look at $\operatorname{evc}_u(G)$. By Lemma 9 Part 2, we get $\operatorname{evc}_u(G) \geq \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}(G_v) - 1$. Now, it is enough to show that $\operatorname{evc}_u(G) \leq \operatorname{mvc}_{uw}(G_u) + \operatorname{evc}(G_v) - 1$. We know that $\operatorname{mvc}_u(G) \in \{\operatorname{mvc}(G), \operatorname{mvc}(G) + 1\}$. First, suppose $\operatorname{mvc}_u(G) = \operatorname{mvc}(G)$. In this case, it can be seen that $\operatorname{mvc}_{uw}(G_u) = k_u$ and hence, $\operatorname{mvc}_{uw}(G_u) + \operatorname{evc}(G_v) - 1 = k_u + k_v$. Moreover, by Proposition 1, we know $\operatorname{evc}_u(G) \leq \operatorname{mvc}_u(G) + 1 = k_u + k_v$. Hence, we are done. Next, suppose $\operatorname{mvc}_u(G) = \operatorname{mvc}(G) + 1$. In this case, by Lemma 2, we get $\operatorname{mvc}_{uw}(G_u) = k_u + 1$. Hence, we get $\operatorname{mvc}_{uw}(G_u) + \operatorname{evc}(G_v) - 1 = k_u + k_v + 1$. By Lemma 7, we have $\operatorname{evc}_u(G) \leq \operatorname{evc}(G) + 1 = k_u + k_v + 1$. Hence, we are done.

Now we will look at $\operatorname{evc}_v(G)$. Let $Q = \min\{\operatorname{mvc}_v(G)+1, \operatorname{evc}_w(G_u)+\operatorname{evc}_{vw}(G_v)-1, \max\{\operatorname{mvc}_w(G_u)+\operatorname{evc}_{vw}(G_v)-1, \operatorname{evc}(G_u)+\operatorname{mvc}_v(G_v)\}\}$, the expression for $\operatorname{evc}_v(G)$ to be proved. By Lemma 6, we have $\operatorname{evc}_v(G) \leq Q$. Since $\operatorname{evc}_v(G) \in \{\operatorname{mvc}_v(G), \operatorname{mvc}_v(G)+1\}$ by Proposition 1, it is enough to show that if $\operatorname{evc}_v(G) = \operatorname{mvc}_v(G)$, then $Q \leq \operatorname{mvc}_v(G)$. Assume $\operatorname{evc}_v(G) = \operatorname{mvc}_v(G)$. Since $\operatorname{evc}_v(G) \geq \operatorname{evc}(G) = k_u + k_v$ and $\operatorname{mvc}_v(G) \leq \operatorname{evc}(G) = k_u + k_v$, we have $\operatorname{evc}_v(G) = \operatorname{mvc}_v(G) = k_u + k_v$. By Lemma 9 Part 2, we get $\operatorname{evc}_v(G_v) \leq k_v + 1$. If $\operatorname{evc}_w(G_u) = k_u$, then we get $Q \leq k_u + k_v$, as required. If this was not the case, then there exists a vertex $x \in V(G_u)$ with $\operatorname{mvc}_{xw}(G_u) = k_u + 1$. If $\operatorname{mvc}_v(G_v) = k_v$, then we get $Q \leq k_u + k_v$ immediately. Hence, we assume $\operatorname{mvc}_v(G) = k_v + 1$. Then, for the vertex $x \in V(G_u)$ for which $\operatorname{mvc}_{xw}(G_u) = k_u + 1$, we get $\operatorname{mvc}_{xv}(G) > k_u + k_v$. Since $\operatorname{evc}_v(G) \geq \operatorname{mvc}_{xv}(G)$ by Proposition 1, this is a contradiction. Thus, $Q \leq k_u + k_v$.

Now, we will consider $\operatorname{evc}_{uv}(G)$. Let $P = \min\{\operatorname{mvc}_{uv}(G)+1, \operatorname{evc}_{uw}(G_u)+\operatorname{evc}_{vw}(G_v)-1, \operatorname{evc}_u(G_u)+\max\{\operatorname{evc}_{vw}(G_v)-1, \operatorname{mvc}_v(G_v)\}\}$, the expression for $\operatorname{evc}_{uv}(G)$ to be proved. By Lemma 8, we get $\operatorname{evc}_{uv}(G) \leq P$. Now, we will show that $\operatorname{evc}_{uv}(G) \geq P$. Since $\operatorname{evc}_{uv}(G) \in \{\operatorname{mvc}_{uv}(G), \operatorname{mvc}_{uv}(G)+1\}$ by Proposition 1, it is enough to show that if $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G)$, then $P \leq \operatorname{mvc}_{uv}(G)$. Assume $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G)$. Since $\operatorname{evc}_{uv}(G) \geq \operatorname{evc}(G) = k_u + k_v$ and $\operatorname{mvc}_{uv}(G) \leq k_u + k_v$, we know that $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G) = k_u + k_v$. By Lemma 9 Part 3, we get $\operatorname{evc}_{uv}(G_v) = k_v + 1$. If $\operatorname{evc}_{uw}(G_u) = k_u$, then it can be seen that $P \leq k_u + k_v$. Hence, assume $\operatorname{evc}_{uw}(G_u) = k_u + 1$. Then, by Lemma 9 Part 3, we get $\operatorname{mvc}_v(G_v) = k_v$. Further, by Lemma 9 Part 3, it can be seen that $\operatorname{mvc}_{uw}(G_u) = k_u$. This

implies $\operatorname{mvc}_{vw}(G_v) = k_v + 1$ by Lemma 2. Hence, by Lemma 9, we get $\operatorname{evc}_u(G_u) = k_u$. Therefore, we get $P \leq k_u + k_v = \operatorname{evc}_{uv}(G)$.

Lemma 18. If $\operatorname{evc}(G_u) = k_u$, $\operatorname{evc}(G_v) = k_v + 1$ and $\operatorname{mvc}(G) = \operatorname{evc}(G) = k_u + k_v$, then: $\operatorname{evc}_u(G) = \operatorname{evc}_u(G_u) + \operatorname{evc}_w(G_v) - 1$, $\operatorname{evc}_v(G) = \min\{\operatorname{mvc}_v(G) + 1, \operatorname{evc}_w(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{max}\{\operatorname{mvc}_w(G_u) + \operatorname{evc}_{vw}(G_v) - 1, \operatorname{evc}(G_u) + \operatorname{mvc}_v(G_v)\}\}$ $\operatorname{evc}_{uv}(G) = \min\{\operatorname{evc}(G) + 1, \operatorname{max}\{\operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v), \operatorname{evc}_u(G_u) + \operatorname{evc}_{vw}(G_v) - 1\}\}.$

Proof. First, we will show that $\operatorname{evc}_u(G) = \operatorname{evc}_u(G_u) + \operatorname{evc}_w(G_v) - 1$. Since $\operatorname{evc}(G) = k_u + k_v$, by Lemma 9 Part 1, $\operatorname{evc}_w(G_v) \leq k_v + 1$, which implies $\operatorname{evc}_w(G_v) = k_v + 1$. Further, by Proposition 2, $\operatorname{evc}_u(G) \in \{k_u + k_v, k_u + k_v + 1\}$. Now, it is enough to show that if $\operatorname{evc}_u(G) = \operatorname{evc}(G) = k_u + k_v$, then $\operatorname{evc}_u(G_u) = k_u$ and if $\operatorname{evc}_u(G) = \operatorname{evc}(G) + 1 = k_u + k_v + 1$, then $\operatorname{evc}_u(G_u) = k_u + 1$. First, suppose $\operatorname{evc}_u(G) = k_u + k_v$. By Lemma 9 Part 2, we get $\operatorname{mvc}_u(G_u) = k_u$ and by Lemma 1, we get $\operatorname{mvc}_w(G_v) \neq k_v$. Hence, we have $\operatorname{mvc}_v(G_v) = k_v$. For contradiction, suppose $\operatorname{evc}_u(G_u) = k_u + 1$. Since $\operatorname{mvc}_w(G_v) = k_v + 1$, this implies $\operatorname{mvc}_u(G) \geq k_u + k_v + 1$. By Proposition 1, this contradicts the value of $\operatorname{evc}_u(G)$. Hence, we get $\operatorname{evc}_u(G_u) = k_u$ as required. Next, suppose $\operatorname{evc}_u(G) = k_u + k_v + 1$. For contradiction, suppose $\operatorname{evc}_u(G_u) = k_u$. By Lemma 7, we have $\operatorname{evc}_u(G_u) = k_u$. Then, by Proposition 1, we get $\operatorname{mvc}_u(G_u) = k_u$. By Lemma 7, we have $\operatorname{evc}_u(G_u) = k_u + 1$ and we are done.

The proof of the expression for $\operatorname{evc}_v(G)$ is exactly the same as that in the proof of Lemma 17. Now we will look at $\operatorname{evc}_{uv}(G)$. Let $P = \max\{\operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v), \operatorname{evc}_u(G_u) + \operatorname{evc}_{vw}(G_v) - 1\}$. We need to show that $\operatorname{evc}_{uv}(G) = \min\{\operatorname{evc}(G) + 1, P\}$. By Lemma 8, we get $\operatorname{evc}_{uv}(G) \leq \min\{\operatorname{evc}(G) + 1, P\}$. Now, we will show that $\operatorname{evc}_{uv}(G) \geq \min\{\operatorname{evc}(G) + 1, P\}$. If $\operatorname{evc}_{uv}(G) = \operatorname{evc}(G) + 1$, we are done. Therefore, consider the case when $\operatorname{evc}_{uv}(G) = \operatorname{evc}(G) = k_u + k_v$. In this case, we show that $P \leq k_u + k_v$. Since $\operatorname{mvc}(G) = k_u + k_v$ and $\operatorname{mvc}_w(G_u) = k_u$ by Proposition 1, we get $\operatorname{mvc}_{vw}(G_v) = k_v + 1$ by Lemma 1. Hence, by Lemma 9 Part 3, we get $\operatorname{evc}_u(G_u) = k_u$. Moreover, we also get $\operatorname{evc}_{vw}(G_v) = k_v + 1$ and $\operatorname{mvc}_{uw}(G_u) = k_u$ by Lemma 9 Part 3. Therefore, since $\operatorname{mvc}(G) = k_u + k_v$, we know $\operatorname{mvc}_w(G_v) \neq k_v$. This implies $\operatorname{mvc}_v(G_v) = k_v$. Thus, we get $P \leq k_u + k_v$.

Lemma 19. If $\operatorname{evc}(G_u) = k_u$, $\operatorname{evc}(G_v) = k_v + 1$ and $\operatorname{evc}(G) = k_u + k_v + 1$, then $\operatorname{evc}_u(G) = \operatorname{evc}_v(G) = \operatorname{evc}(G)$ and $\operatorname{evc}_{uv}(G) = \min\{\operatorname{mvc}_{uv}(G) + 1, \operatorname{evc}(G_u) + \operatorname{evc}_v(G_v)\}$.

Proof. First, we will show that $\operatorname{evc}_u(G) = \operatorname{evc}(G)$. Since we know that $\operatorname{evc}_u(G) \ge \operatorname{evc}(G)$ by Lemma 9 Part 2, it is enough to show that $\operatorname{evc}_u(G) \le \operatorname{evc}(G)$. For any vertex $x \in V(G_u)$, we have $\operatorname{mvc}_x(G_u) = k_u$ by Proposition 1 and hence $\operatorname{mvc}_{xu}(G_u) \le k_u + 1$. This implies $\operatorname{mvc}_{xu}(G) \le k_u + k_v + 1 = \operatorname{evc}(G)$. Similarly, for any vertex $y \in V(G_v)$, we have $\operatorname{mvc}_y(G_v) \le k_v + 1$. Hence, $\operatorname{mvc}_{yu}(G) \le k_u + k_v + 1$. Therefore, by Proposition 1, $\operatorname{evc}_u(G) \le k_u + k_v + 1$. Hence, $\operatorname{evc}_u(G) = \operatorname{evc}(G)$.

Next, we will show that $\operatorname{evc}_v(G) = \operatorname{evc}(G)$. Since we know that $\operatorname{evc}_v(G) \ge \operatorname{evc}(G)$ by Lemma 9 Part 2, it is enough to show that $\operatorname{evc}_v(G) \le \operatorname{evc}(G)$. For any vertex $x \in V(G_u)$, we have $\operatorname{mvc}_x(G_u) = k_u$ by Proposition 1 and hence $\operatorname{mvc}_{xv}(G) \le k_u + k_v + 1 = \operatorname{evc}(G)$. Similarly, for any vertex $y \in V(G_v)$, $\operatorname{mvc}_{yvw}(G_v) \le k_v + 2$. Since $\operatorname{mvc}_w(G_u) = k_u$, this gives $\operatorname{mvc}_{yv}(G) \le k_u + k_v + 1$. Therefore, by Proposition 1, $\operatorname{evc}_v(G) \le k_u + k_v + 1$. Hence, $\operatorname{evc}_v(G) = \operatorname{evc}(G)$.

Now, we will show that $\operatorname{evc}_{uv}(G) = \min\{\operatorname{mvc}_{uv}(G) + 1, \operatorname{evc}(G_u) + \operatorname{evc}_v(G_v)\}$. By Lemma 8, we get $\operatorname{evc}_{uv}(G) \leq \min\{\operatorname{mvc}_{uv}(G) + 1, \operatorname{evc}(G_u) + \operatorname{evc}_v(G_v)\}$. Next, we show that $\operatorname{evc}_{uv}(G) \geq \min\{\operatorname{mvc}_{uv}(G) + 1, \operatorname{evc}(G_u) + \operatorname{evc}_v(G_v)\}$. If $\operatorname{mvc}_{uv}(G) = k_u + k_v$ or $\operatorname{evc}_v(G_v) = k_v + 1$, this is trivial. So, we are left with the case when $\operatorname{mvc}_{uv}(G) = k_u + k_v + 1$ and $\operatorname{evc}_v(G_v) = k_v + 2$. For contradiction, suppose $\operatorname{evc}_{uv}(G) \leq k_u + k_v + 1$. By Proposition 1, there exists a vertex $x \in V(G_v)$ such that $\operatorname{mvc}_{xv}(G_v) = k_v + 2$ and this implies $\operatorname{mvc}_{xuv}(G) \geq k_u + k_v + 1$ and $\operatorname{mvc}_{uw}(G_u) = k_u$. Since $\operatorname{mvc}_{uv}(G) = k_u + k_v + 1$, we get $\operatorname{mvc}_v(G_v) = k_v + 1$ and $\operatorname{mvc}_w(G_v) = k_v$. This implies $\operatorname{mvc}(G) = k_u + k_v - 1$ and $\operatorname{mvc}_{uv}(G) \leq k_u + k_v$, a contradiction. Therefore, $\operatorname{evc}_{uv}(G) \geq k_u + k_v + 2$, as required. Hence, $\operatorname{evc}_{uv}(G) = \min\{\operatorname{mvc}_{uv}(G) + 1, \operatorname{evc}(G_u) + \operatorname{evc}_v(G_v)\}$.

Lemma 20. If $evc(G_u) = k_u + 1$ and $evc(G_v) = k_v + 1$, then $evc_u(G) = \min\{mvc_u(G) + 1, evc_u(G_u) + evc_w(G_v) - 1\}$ and $evc_v(G) = \min\{mvc_v(G) + 1, evc_v(G_v) + evc_w(G_u) - 1\}.$

Proof. Since the statement of the lemma is symmetric with respect to u and v, we will only prove the expression for $\operatorname{evc}_u(G)$. We first show that $\operatorname{evc}_u(G) \leq \min\{\operatorname{mvc}_u(G) + 1, \operatorname{evc}_u(G_u) + \operatorname{evc}_w(G_v) - 1\}$. Since $\operatorname{evc}_u(G) \leq \operatorname{mvc}_u(G) + 1$ by Proposition 1, it is enough to show that $\operatorname{evc}_u(G) \leq \operatorname{evc}_u(G_u) + \operatorname{evc}_w(G_v) - 1$. By Proposition 5, we get $\max_{x \in V(G_u)} \operatorname{mvc}_{ux}(G) \leq \operatorname{evc}_u(G_u) + \operatorname{mvc}(G_v) \leq \operatorname{evc}_u(G_u) + \operatorname{evc}_w(G_v) - 1$ and $\max_{x \in V(G_v)} \operatorname{mvc}_{ux}(G) \leq \operatorname{mvc}_u(G_u) + \operatorname{evc}_w(G_v) - 1 \leq \operatorname{evc}_u(G_u) + \operatorname{evc}_w(G_v) - 1$. Hence, by Proposition 1, we get $\operatorname{evc}_u(G) \leq \operatorname{evc}_u(G_u) + \operatorname{evc}_w(G_v) - 1$.

Next, we need to show that $\operatorname{evc}_u(G) \geq \min\{\operatorname{mvc}_u(G) + 1, \operatorname{evc}_u(G_u) + \operatorname{evc}_w(G_v) - 1\}$. By Proposition 1, it is enough to show that when $\operatorname{evc}_u(G_u) = \operatorname{mvc}_u(G)$, then $\operatorname{evc}_u(G) \geq \operatorname{evc}_u(G_u) + \operatorname{evc}_w(G_v) - 1$. Suppose $\operatorname{evc}_u(G) = \operatorname{mvc}_u(G)$. Since $\operatorname{mvc}_u(G) \leq \operatorname{evc}_u(G)$, we have $\operatorname{mvc}_u(G) = \operatorname{evc}_u(G) = \operatorname{evc}_u(G)$. By Observation 3 and Lemma 14, we have $\operatorname{evc}(G) \in \{k_u + k_v, k_u + k_v + 1\}$. First, suppose $\operatorname{evc}_u(G) = k_u + k_v$. We will show a contradiction in this case. By Lemma 9 Part 2, we get $\operatorname{mvc}_w(G_v) = k_v$ and $\operatorname{mvc}_{uw}(G_u) = k_u$. This implies $\operatorname{mvc}_u(G) = k_u + k_v - 1$, which is a contradiction.

Next, suppose $\operatorname{evc}_u(G) = k_u + k_v + 1$. In this case, it is enough to show that $\operatorname{evc}_u(G_u) = k_u + 1$ and $\operatorname{evc}_w(G_v) = k_v + 1$. We have $\operatorname{mvc}_{uw}(G_u) \leq k_u + 1$. If $\operatorname{mvc}_w(G_v) = k_v$, we get $\operatorname{mvc}_u(G) = k_u + k_v$, a contradiction. Therefore, $\operatorname{mvc}_w(G_v) = k_v + 1$. By Lemma 9 Part 2, we get $\operatorname{evc}_u(G_u) = k_u + 1$. If $\operatorname{mvc}_u(G_u) = k_u$, we get $\operatorname{mvc}_u(G) = k_u + k_v$, a contradiction. Therefore, $\operatorname{mvc}_u(G_u) = k_u + 1$. Consider any vertex $x \in V(G_v)$. By Proposition 1, we have $\operatorname{mvc}_{xu}(G) \leq k_u + k_v + 1$. Since, $\operatorname{mvc}_u(G_u) = k_u + 1$, it can be verified that $\operatorname{mvc}_{xw}(G_v) \leq k_v + 1$. Hence, by Proposition 1, $\operatorname{evc}_w(G_v) = k_v + 1$, as required.

Lemma 21. If $evc(G_u) = k_u + 1$ and $evc(G_v) = k_v + 1$, then:

- 1. If $\operatorname{mvc}_{uv}(G) \le k_u + k_v$ then $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G) + 1$.
- 2. Otherwise, $\operatorname{evc}_{uv}(G) = \min\{\operatorname{mvc}_{uv}(G) + 1, \max\{P_1, P_2\}\}, where P_1 = \min\{\operatorname{evc}_{uw}(G_u) + \operatorname{mvc}_{vw}(G_v) 1, \operatorname{evc}_u(G_u) + \operatorname{mvc}_v(G_v)\} and P_2 = \min\{\operatorname{mvc}_{uw}(G_u) + \operatorname{evc}_{vw}(G_v) 1, \operatorname{mvc}_u(G_u) + \operatorname{evc}_v(G_v)\}.$
- *Proof.* 1. Suppose $\operatorname{mvc}_{uv}(G) \leq k_u + k_v$. By Proposition 1, $\operatorname{evc}_{uv}(G) \in \{\operatorname{mvc}_{uv}(G), \operatorname{mvc}_{uv}(G) + 1\}$. Therefore it is enough to show that $\operatorname{evc}_{uv}(G) \neq \operatorname{mvc}_{uv}(G)$. For contradiction, suppose this was not true. By Lemma 9 Part 1, we get $\operatorname{evc}(G) \geq k_u + k_v$. Therefore, $\operatorname{evc}_{uv}(G) \geq k_u + k_v$. Hence, we may assume that $\operatorname{mvc}_{uv}(G) = \operatorname{evc}_{uv}(G) = k_u + k_v$. By Lemma 9 Part 3, we get $\operatorname{mvc}_{uw}(G_u) = k_u$ and $\operatorname{mvc}_{vw}(G_v) = k_v$. This gives $\operatorname{mvc}_{uv}(G) = k_u + k_v - 1$, a contradiction. Hence, $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G) + 1$.
- 2. Suppose $\operatorname{mvc}_{uv}(G) = k_u + k_v + 1$. By Lemma 8, we know $\operatorname{evc}_{uv}(G) \leq \min\{\operatorname{mvc}_{uv}(G) + 1, \max(P_1, P_2)\}$. Now, we will show that $\operatorname{evc}_{uv}(G) \geq \min(\operatorname{mvc}_{uv}(G) + 1, \max(P_1, P_2))$. Recall that we are in a case when $\operatorname{mvc}_{uv}(G) = k_u + k_v + 1$ and by Proposition 1 $\operatorname{evc}_{uv}(G) \in \{\operatorname{mvc}_{uv}(G), \operatorname{mvc}_{uv}(G) + 1\}$. If $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G) + 1$, we are done. Therefore we are left with the case where $\operatorname{evc}_{uv}(G) = \operatorname{mvc}_{uv}(G) = k_u + k_v + 1$. In this case $\operatorname{mvc}_{uw}(G_u) = k_u + 1$ and

 $\operatorname{mvc}_{vw}(G_v) = k_v + 1$. It is enough to show that $\operatorname{max}(P_1, P_2) \leq k_u + k_v + 1$. For contradiction, suppose $P_1 > k_u + k_v + 1$. This implies $\operatorname{evc}_{uw}(G_u) = k_u + 2$. By Lemma 9 Part 3, we get $\operatorname{mvc}_v(G_v) = k_v$, $\operatorname{evc}_v(G_v) = k_v + 1$ and $\operatorname{evc}_u(G_u) = k_u + 1$. From this, we get $P_1 \leq k_u + k_v + 1$, a contradiction.

Symmetrically, we get contradiction when $P_2 > k_u + k_v + 1$. Therefore, $\max(P_1, P_2) \le k_u + k_v + 1$.

П

From Lemma 12-21, the following theorem is immediate.

Theorem 4. Let G be a maximal outerplanar graph and uv be an edge on the outer face of G such that $deg_G(u) > 2$ and $deg_G(v) > 2$. Let $w = \Delta(uv)$.

- 1. Given $\mathscr{M}(G_u, uw)$, $\mathscr{E}(G_u, uw)$, $\mathscr{M}(G_v, vw)$ and $\mathscr{E}(G_v, vw)$, it is possible to compute evc(G) in constant time.
- 2. Given evc(G), $\mathcal{M}(G, uv)$, $\mathcal{M}(G_u, uw)$, $\mathcal{E}(G_u, uw)$, $\mathcal{M}(G_v, vw)$ and $\mathcal{E}(G_v, vw)$, it is possible to compute the remaining evc parameters of G with respect to uv in constant time.

6 A linear time algorithm to compute evc number

In this section, we formulate a divide and conquer algorithm that takes a pair (G, uv) as input where G is a maximal outerplanar graph and uv is an edge on its outer face and recursively computes $\mathscr{M}(G, uv)$ and $\mathscr{E}(G, uv)$. The case when G is a triangle forms the base case of the recursion and it is handled using Observation 1. Let $w = \Delta(uv)$. If $deg_G(u) > 2$ and $deg_G(v) > 2$, then the recursion works on (G_u, uw) and (G_v, vw) using Theorem 2 and Theorem 4. Otherwise, suppose u' is the degree-2 vertex among u and v and v' is the other one. In this case, the recursion works on $(G_{v'}, v'w)$ using Theorem 3.

A high level overview of our method is given in Algorithm 1. To obtain the linear time guarantee, we need to ensure that the time spent in steps other than the recursive calls is O(1). Theorems 1-4 guarantee that lines 8 - 11 and lines 17 - 20 work in constant time, forming the most crucial part of our algorithm. However, we will have to avoid the explicit computation of the subgraphs and passing them as explicit parameters in the recursive calls using a refinement of Algorithm 1. For this refinement, we maintain a Vertex Edge Face Adjacency List data structure using which the following are possible:

- 1. For any edge e, we can traverse through the internal faces on which the edge lies in O(1) time.
- 2. For any internal face f, we can traverse through the edges on the boundary of f in O(1) time.

The details of the data structure is given in Fig. 2 in the appendix. An example for Vertex Edge Face Adjacency List of a maximal outerplanar graph on four vertices is given in Fig. 3 in the appendix. Vertex Edge Face Adjacency List of an outerplanar graph can be produced by modifying the algorithm suggested by N. Chiba and T. Nishizeki [15] for listing all the triangles of a planar graph in linear time. An algorithm for producing the Vertex Edge Face Adjacency List is given in Algorithm 3 in the appendix.

By using the *visit* field of faces in the Vertex Edge Face Adjacency List data structure, we avoid passing the subgraph as an explicit parameter in recursive calls, maintaining the following invariants:

1. The edge e passed as parameter to the recursion is present in exactly one unvisited face f.

2. The e-segment of G that contains the unvisited face f is precisely the subgraph on which the recursive call in Algorithm 1 would have been made.

Further, line numbers 2, 3, 5 and 6 of Algorithm 1 can also be implemented in linear time using the new data structure.

Algorithm 1 To compute $\mathscr{M}(G, uv)$ and $\mathscr{E}(G, uv)$ of a maximal outerplanar graph G with uv an edge on its outer face.

Algorithm 2 (in the appendix) gives a linear time refinement of Algorithm 1. The details of the correspondence between the two algorithms are given in the appendix.

7 Conclusion

This paper presents a linear time algorithm for computing the eternal vertex cover number of maximal outerplanar graphs, lowering the best known upper bound to the complexity of the problem from quadratic [6] time to linear. The techniques presented in the paper make crucial use of the planarity of the underlying graph to yield a divide and conquer algorithm for computing the evc number of a maximal outerplanar graph. Attempts to generalize the techniques to maximal planar graphs may not be successful due to the known NP hardness result on the evc computation of biconnected internally triangulated planar graphs [2]. However, the complexity status of the problem

of computing the evc number of outerplanar graphs is open and may be attempted using the techniques developed in this work.

8 Appendix - Refinement of Algorithm 1 to Work in Linear Time

8.1 Vertex Edge Face Adjacency List

To make Algorithm 1 work in linear time, we should avoid the explicit passing of the subgraphs G_u and G_v as parameters for the recursive calls. Instead, we do the following.

Using an algorithm suggested by N. Chiba and T. Nishizeki [15], in linear time all the triangles of a planar graph can be listed/ printed. Let G be a maximal outerplanar graph with a fixed outerplanar embedding. When G is given as input to the algorithm of Chiba and Nishizeki, it will precisely list all the internal faces of the graph. By modifying the algorithm proposed in [15], we produce a global data structure named **Vertex Edge Face Adjacency List**. The details of the data structure is given in Fig. 2. The algorithm for producing this data structure is given in Algorithm 3 and will be discussed later.

In a Vertex Edge Face Adjacency List data structure, for any edge $v_i v_j$, there are links between the edge node $v_i v_j$ and the edge node $v_j v_i$. For each face node representing a face f in G, there are links to the edge nodes corresponding to the bounding edges of f and vice versa. Remember that each edge of G has 2 edge nodes corresponding to it. Hence, for each face node f, there are 6 pointers to edge nodes. For each face node, there is a visit field which is initialized to *unvisited*. Each vertex node has a mark field, which is initialized to *unmarked*, the cur-edge field which is initialized to *null* and a pointer to the beginning of the adjacency list of that vertex.

The Vertex Edge Face Adjacency List of a maximal outerplanar graph on four vertices is given in Fig. 3.

8.2 Refined algorithm and its correspondence with Algorithm 1

We will first assume that Vertex Edge Face Adjacency List of the graph has been already produced and give the remaining details of the linear time implementation. Algorithm 2 gives a linear time version of Algorithm 1. To compute the evc number of a maximal outerplanar graph, we pass an edge uv on the outer face of the graph as input to the algorithm. Initially, the visit field of all faces are set to *unvisited*. Note that, the edge uv is present in exactly one unvisited face uvw initially. On entering the algorithm, the face uvw is marked as *visited*. Once this marking is done, the edges uw and vw can be in at most one unvisited face each. Note that if uw is not in any unvisited face, then $deg_G(u) = 2$. Otherwise $deg_G(u) > 2$. Similarly we can check if $deg_G(v) = 2$ or not from the number of unvisited faces containing the edge vw.

In subsequent recursive calls, the following invariants will be maintained:

(1) the edge e passed as parameter to the recursion is present in exactly one unvisited face f.

(2) The *e*-segment of G that contains the unvisited face f is precisely the subgraph on which the recursive call in Algorithm 1 would have been made.

By maintaining the visit field of faces, we avoid passing the subgraph as an explicit parameter in recursive calls in Algorithm 2.

From these observations, we show that Algorithm 2 is a linear time implementation of Algorithm 1. The inputs of the function EVC_Parameters of Algorithm 1 are a maximal outerplanar graph G and an edge uv on the outer face. The algorithm is divided into following three cases:

1. The input graph is a triangle (degrees of both the end vertices of the edge uv are 2). Refer to line number 3 of Algorithm 1.

- 2. The input graph is not a triangle and exactly one end vertex of the input edge uv is of degree 2. Refer to line number 5 of Algorithm 1.
- 3. The input graph is not a triangle and both the end vertices of the input edge uv has degree greater than 2. Refer to line number 12 of Algorithm 1..

The input to the function EVC_Parameters of Algorithm 2 is an edge uv on the outer face of the input graph. For the input edge uv, let uvw be the unvisited face in which uv lies. The three cases of Algorithm 2 corresponding to the three cases of Algorithm 1 are as follows:

- 1. Both edges uw and vw lie in no unvisited face and thereby uvw is a triangle. Refer to line number 5 of Algorithm 2.
- 2. Exactly one among the edges uw and vw lie in an unvisited face. Refer to line number 8 of Algorithm 2.
- 3. Both uw and vw lie in one unvisited face each. Refer to line number 16 of Algorithm 2.

In line number 2 of Algorithm 1, we find the unique common neighbor w of u and v in the input graph. Instead of this step, line number 2 of Algorithm 2, identifies w as the third vertex in the unique unvisited face containing the edge uv. After this the face uvw is marked as visited in line number 4 of Algorithm 2 and subsequently the edges uw and vw are in at most one unvisited face each.

Now, we show that line number 3 of Algorithm 1 is equivalent to line number 5 of Algorithm 2. In line number 3 of Algorithm 1, we check whether the input graph is a triangle, which is the base case. Equivalently, by the invariants stated above, in Algorithm 2, it is enough to check if the uv-segment of G containing the face uvw is a triangle. In line 5 of Algorithm 2, we do the following in constant time using vertex edge face adjacency list: We check if uw or vw lie in any unvisited face. If neither uw nor vw lie in an unvisited face, then we can infer that uv-segment of G containing the face uvwis a triangle.

In line 5 of Algorithm 1, we check whether exactly one end vertex of the edge uv is of degree 2. In line number 8 of Algorithm 2, if uw (respectively, vw) is in any univisited face, then we can infer that the degree of the vertex u (respectively, v) is greater than 2 in the uv-segment of G that contains the face uvw. Otherwise, the degree of u (respectively, v) in the uv-segment of G that contains the face uvw is equal to 2.

In line number 7 of Algorithm 1, we recursively call the function EVC_Parameters with two input parameters: (1) the graph obtained by deleting the degree-2 endpoint u' of the edge uv from the input graph and (2) the edge v'w bounding the face uvw, where degree of v' is greater than 2 in the input graph. Since in Algorithm 2, uvw is already marked as visited in line number 4, it is enough to invoke the recursive call with the edge e as parameter, where e is the bounding edge of the face uvw with one unvisited face adjacent to it. This is achieved in line number 12 of Algorithm 2, in which we recursively call the function EVC_Parameters with the edge e as input, where e is that edge among the edges uw and vw which lies in an unvisited face. Note that the invariants of the Algorithm 2 are maintained.

The equivalence between line number 12 of Algorithm 1 and line number 16 of Algorithm 2 follows from our arguments so far. In line number 15 (respectively, 16) of Algorithm 1, a recursive call to the algorithm is made with input parameters: (1) G_u (respectively, G_v), the *uw*-segment (respectively, *vw*-segment) of G that does not contain the edge vw (respectively, uw) and (2) the edge uw (respectively, vw). Note that the edges bounding the face uvw, other than uv, are used as parameters in these two calls. Equivalently, in line number 17 and 18 of Algorithm 2, recursive calls

are made respectively with the edges uw and vw as input parameters. Since the face uvw is marked as visited already, the invariants of the algorithm are maintained here as well.

Thus, we can see that Algorithm 2 is linear time implementation of Algorithm 1.

8.3 Building the Vertex Edge Face Adjacency List

We can use the algorithm given below to populate the Vertex Edge Face Adjacency List of a maximal outerplanar graph.

We assume a bare Vertex Edge Face Adjacency List L as the input graph representation in which the face nodes and the links to and from face nodes are absent. The Algorithm 2, begins by creating a copy L' of the bare Vertex Edge Face Adjacency List L and links from an edge node in L' to its copy in L. (For simplicity, in the data structure given in Fig. 2, we have avoided a field for this link.) During the running of Algorithm 2, we traverse through L' and each time a new face node is created corresponding to a face f_i in G, we assign links from the newly created face node to the edge nodes (bounding edges of f_i) in L and also the reverse links. This step can be done in constant time by utilizing the links from each edge nodes of L' to its copy in L. During the running of Algorithm 2, some edge nodes of L' gets deleted while their copies in L are retained. Note that, this way of deletion of edge nodes of L' is necessary to obtain linear time complexity, as it was done in [15]. Hence, the linear time complexity of the construction follows from the analysis in [15].
