# The gauge invariant cosmological Jacobi map from weak lensing at leading order

**Abstract.** We compute the weak lensing Jacobi map at first order in perturbation theory and show that it is both, gauge invariant and symmetric. Linear perturbations therefore do not induce any rotation. However, vector and tensor perturbations do induce B-modes in the shear. We show that contrary to what is often claimed in the literature, the shear B-mode power spectrum is not fully determined by the rotation power spectrum. Also the E-mode shear power spectrum is not determined by the convergence power spectrum. While this difference is small for scalar perturbations, it becomes very relevant for tensor perturbations, i.e. gravitational waves.

#### 1 Introduction

In this paper we show that the treatment of weak lensing typically found in the cosmology literature is not complete and actually not gauge invariant, since often one part of the Jacobi map is neglected. This is unproblematic in a nearly Newtonian situation but becomes relevant on very large scales and, especially, when we include vector and tensor modes. In particular, working at first order in cosmological perturbation theory, we obtain the following results when we correctly consider the Jacobi map for lensing:

- The Jacobi map is gauge invariant when expressed in terms of z and  $\mathbf{n}$ . Here z is the observed redshift and  $\mathbf{n}$  is the observation direction.
- The Jacobi map is symmetric, hence there is no rotation at first order. We have  $\omega \equiv 0$  for scalar, vector and tensor perturbations.
- The *B*-mode of the shear does not vanish for vector and tensor perturbations and, especially, its angular power spectrum is not given by the one of the rotation,  $\omega$ , as claimed in the literature, see e.g. [1–3].

• The power spectrum of the convergence  $\kappa$  and the *E*-mode of the shear are not simply related as claimed in the literature, see e.g. [1–3]. We find that while for scalar perturbations this difference is relevant only at large scales,  $\ell \lesssim 20$ , for tensor perturbations it is significant on all scales.

The fact that, at first order in perturbation theory, weak lensing does not induce rotation is already clear by deriving an evolution equation for rotation e.g. from Eq. (27) in [4]. This equation is solved fully non-perturbatively by relativistic numerical N-body simulations in [5]. Also in the comprehensive work [6] and in the pioneering paper [7] it is found that rotation vanishes at first order in the observable Jacobi map. The 'simplification' made in the references [1–3] is that they write the two dimensional Jacobi map as

$$D_{ab} = \delta_{ab} + \delta\theta_{a,b} \,,$$

where  $\delta\theta_a$  is the (2d) deflection angle on the sphere and hence this matrix has only two degrees of freedom which are cast either in the power spectra of the convergence  $\kappa$  and the rotation  $\omega$  or in the *E*- and *B*-modes of the shear.

However, in the observable Jacobi map, the deflection angle cannot be expressed in some arbitrary coordinates but it must be defined with respect to a parallel transported Sachs basis of the 'screen'. In Ref. [8] it is shown explicitly that at first order the rotation of this Sachs basis exactly cancels the antisymmetric contribution to  $D_{ab}$ , rendering it symmetric also in the presence of vector and tensor perturbations. This is no longer the case at second order, where the Jacobi map, in general, has four non-vanishing degrees of freedom. But already at the linear level, the spectra of the convergence  $\kappa$ , the rotation  $\omega$  and the E- and B-modes of the shear are unrelated.

In the next section we define the Jacobi map non-perturbatively in the geodesic light-cone gauge [9-11] and derive an expression at first order in a generic gauge. We then show that, when expressed as function of the observed redshift and direction, this map is gauge invariant and find that at first order in perturbation theory its rotation vanishes. In Sections 3 and 4 we derive expressions for the shear E- and B-mode spectra as well as for the convergence, and we compare them with the results in the literature. In Section 5 we evaluate the power spectra numerically and in Section 6 we conclude. The details of some lengthy calculations are deferred to several appendices.

#### **Notation:**

We consider a perturbed spatially flat Friedmann-Lemaître-Robertson-Walker (FLRW) universe and write the perturbed metric as

$$ds^{2} = a^{2}(t) \left[ -(1+2\phi)dt^{2} - 2B_{i}dx^{i}dt + (\delta_{ij} + 2H_{ij})dx^{i}dx^{j} \right], \qquad (1.1)$$

where a is the scale factor and t denotes conformal time. The speed of light is c = 1. The perturbations are split into scalar, vector and tensor parts as follows

$$B_i = B_i^{(v)} + B_{,i}^{(s)} (1.2)$$

with  $\partial^i B_i^{(v)} = 0$ , and

$$H_{ij} = -\psi \delta_{ij} + \left( E_{,ij} - \frac{1}{3} \delta_{ij} \Delta E \right) + H_{i,j}^{(v)} + H_{j,i}^{(v)} + H_{ij}^{(t)}$$

with  $\partial^i H_i^{(v)} = 0$  and  $\partial^i H_{ij}^{(t)} = H_i^{(t)\,i} = 0.$ 

#### 2 Weak lensing and the Jacobi map

In the Geodesic Light-Cone (GLC) gauge the Jacobi map can be determined exactly, as shown in [10, 12]. To recall this derivation, let us introduce the GLC gauge coordinates which are the proper time in synchronous gauge  $\tau$ , a null coordinate w, and two angular coordinates  $\tilde{\theta}^a$  (a=1,2) which specify the negative of the arrival direction of the light ray at the observer. The GLC metric is then given by six arbitrary functions  $(\Upsilon, U^a, \gamma_{ab} = \gamma_{ba})$ ,

$$ds^{2} = \Upsilon^{2}dw^{2} - 2\Upsilon dw d\tau + \gamma_{ab}(d\tilde{\theta}^{a} - U^{a}dw)(d\tilde{\theta}^{b} - U^{b}dw) \qquad , \qquad a, b = 1, 2$$
 (2.1)

where  $\gamma_{ab}$  and its inverse  $\gamma^{ab}$  lower and raise two-dimensional indices. In GLC coordinates the past light-cone of a given observer is defined by  $w = w_o = \text{constant}$ , and null geodesics stay at fixed values of the angular coordinates  $\tilde{\theta}^a = \tilde{\theta}^a_o = \text{constant}$  (with  $\tilde{\theta}^a_o$  specifying the direction of observation).

To clarify the geometric meaning of these variables, let us consider the limiting case of vanishing perturbations, a spatially flat FLRW universe with scale factor a(t) and the observer at the coordinate position r = 0. In this case the geodesic light-cone variables are

$$w = r + t, d\tau = a(t)dt, \Upsilon = a(t), U^a = 0,$$
  

$$\gamma_{ab} d\tilde{\theta}^a d\tilde{\theta}^b = a^2(t) r^2 (d\theta^2 + \sin^2 \theta d\phi^2). (2.2)$$

Let us also introduce the so-called Sachs basis  $(s_A^{\mu})$  with A = 1, 2 [13, 14]. For this we consider a light ray with 4-velocity  $k^{\mu}$  in a matter fluid with 4-velocity  $u^{\mu}$ . The Sachs basis of the 'screen' normal to both  $u^{\mu}$  and  $k^{\mu}$  is defined by the conditions [15, 16]:

$$g_{\mu\nu}s^{\mu}_{A}s^{\nu}_{B} = \delta_{AB}, \qquad s^{\mu}_{A}u_{\mu} = 0, \qquad s^{\mu}_{A}k_{\mu} = 0.$$
 (2.3)

Its evolution equation is

$$\Pi^{\mu}_{\nu}k^{\lambda}\nabla_{\lambda}s^{\nu}_{A} = 0 \quad \text{with} \quad \Pi^{\mu}_{\nu} = \delta^{\mu}_{\nu} - \frac{k^{\mu}k_{\nu}}{(u^{\alpha}k_{\alpha})^{2}} - \frac{k^{\mu}u_{\nu} + u^{\mu}k_{\nu}}{u^{\alpha}k_{\alpha}},$$
(2.4)

where  $\Pi^{\mu}_{\nu}$  is a projector on the two-dimensional space orthogonal to  $u_{\mu}$  and to  $n_{\mu} = u_{\mu} + (u^{\alpha}k_{\alpha})^{-1}k_{\mu}$  with  $n^{\alpha}n_{\alpha} = 1$  and  $n^{\alpha}u_{\alpha} = 0$ .

Following [10], it can be shown that in GLC coordinates the screen space, normal to incoming photon geodesics and the observers worldline, is simply given by the 2-dimensional subspace spanned by the angles  $\tilde{\theta}^a$ . In GLC gauge, the angular part of the Sachs basis, which is fixed up to a global rotation, satisfies [10]

$$\gamma_{ab} s_A^a s_B^b = \delta_{AB} \qquad , \qquad \nabla_\tau s_A^a = 0 \,, \tag{2.5}$$

and the exact Jacobi map is simply given by [10, 12]

$$J_B^A = s_a^A \left( \Delta^{ab} s_{bB} \right)_0 \,, \tag{2.6}$$

where  $\Delta^{ab}$  is defined by  $(\Delta^{ab}) = -2(\partial_{\tau}\gamma_{ab})^{-1}$  and  $s_a^A$  are the angular component of the Sachs basis. The GLC line element in Eq. (2.1) still admits a residual gauge freedom for the metric entries allowing for a coordinate transformation which depends only of certain combinations of the coordinates [10, 17]. This gauge freedom can be fixed to the so-called *observational gauge*. Within this gauge, [18] in the vicinity of the observer geodesic,  $\gamma_{ab}$  can be expanded

as  $\gamma_{ab} = \hat{\gamma}_{ab}(w-\tau)^2 + \mathcal{O}\left((w-\tau)^3\right)$ , where  $\hat{\gamma}_{ab} = \operatorname{diag}\left(1,\sin\tilde{\theta}^1\right)$  is the unperturbed metric of the 2-sphere. With this we obtain

$$\partial_{\tau}\gamma_{ab} = -2\hat{\gamma}_{ab}\left(w - \tau\right) + \mathcal{O}\left((w - \tau)^{2}\right) \tag{2.7}$$

and

$$\Delta^{ab} \approx \hat{\gamma}^{ab} \left( w - \tau \right)^{-1} + \mathcal{O} \left( 1 \right) \,. \tag{2.8}$$

We introduce also the Sachs basis of the FLRW metric which is given by  $\bar{s}_{a\,A} = \bar{d}\,\hat{s}_{a\,A}$ , where  $\hat{s}_{a\,A}$  are 2d angular directions normal to  $u^{\mu}$  and  $k^{\mu}$  such that  $\hat{s}_{a\,A}\hat{s}_{b\,A} = \hat{\gamma}_{ab}$  and  $\bar{d}$  is the (unperturbed) area (or angular diameter) distance in a FLRW universe. Using also that in the vicinity of the observer worldline the Sachs basis is given by  $s_{b\,B} = \hat{s}_{b\,B}\,(w-\tau) + \mathcal{O}\left((w-\tau)^2\right)$  we obtain at the observer position

$$\left(\Delta^{ab}s_{b\,B}\right)_{\alpha} = \hat{s}_{B}^{a} \quad \text{so that} \tag{2.9}$$

$$J_B^A = s_a^A \hat{s}_B^a \,. \tag{2.10}$$

Until this point, our expressions are exact. We now continue to first order in perturbation theory where we have<sup>1</sup>

$$s_{aA} = \bar{s}_{aA} + \frac{1}{2}\delta\gamma_{ab}\bar{s}_A^b \quad \text{hence}$$
 (2.11)

$$J_B^A = \bar{d} \left( \delta_B^A + \frac{1}{2} \delta \hat{\gamma}_{ab} \hat{s}^{bA} \hat{s}_B^a \right) . \tag{2.12}$$

Here  $\delta \gamma_{ab} \equiv \gamma_{ab} - \bar{\gamma}_{ab}$  is the linear perturbation of  $\gamma_{ab}$  and  $\delta \hat{\gamma}_{ab} \equiv \bar{d}^{-2} \delta \gamma_{ab}$ . Already from this expression it is clear that the Jacobi map is symmetric at first order in perturbation theory. (Note, however that even for a symmetric Jacobi matrix shear can change the direction of the principal axes of an elliptical source, if the principal axes of the source and the Jacobi map are misaligned, see [20] for a detailed study of this effect.)

To complete our calculation we now have to express the first order perturbation of the angular metric in GLC gauge in terms of the general perturbed metric defined in Eqs. (1.1) to (1.3). This is a lengthy calculation which we perform in Appendix A.1. The result is as follows

$$\delta \gamma^{ab}(t,x) = \delta \gamma_{GI}^{ab} + \delta^{kj} \partial_k \bar{\gamma}^{ab} \chi_j - 2 \mathcal{H} \bar{\gamma}^{ab} \left( B + E' \right) , \qquad (2.13)$$

where

$$\chi_j = H_j^{(v)} + E_{,j} \quad \text{and}$$
(2.14)

$$\delta \gamma_{GI}^{ab} = \bar{\gamma}^{ac} \partial_c \delta \theta_{GI}^b + \bar{\gamma}^{bc} \partial_c \delta \theta_{GI}^a - 2 a^2 r^2 \bar{\gamma}^{ac} H_{cd}^{(t)} \bar{\gamma}^{db} + 2 \bar{\gamma}^{ab} \Psi , \qquad (2.15)$$

$$\delta\theta_{GI}^{a} = -\int_{0}^{r_{s}} dr \, \frac{\hat{\gamma}^{ac}}{r^{2}} \left( \delta w_{GI,c} - r \, \sigma_{c}^{(v)} - 2 \, r H_{rc}^{(t)} \right) \,, \tag{2.16}$$

$$\delta w_{GI} = -\int_0^{r_s} dr \left( \Phi + \Psi - \sigma_r^{(v)} - H_{rr}^{(t)} \right) . \tag{2.17}$$

Here  $\Phi$  and  $\Psi$  are the Bardeen potentials and  $\sigma_i^{(v)} = B_i^{(v)} + H_i^{(v)}$  is a gauge invariant vector perturbation (see e.g. [21] for an introduction to gauge invariant cosmological perturbation

theory). The prime indicates the derivative wrt conformal time t. The quantities indexed by 'GI' are gauge invariant. Interestingly  $\delta \gamma^{ab}(t,x^i)$  is not. The reason for this is that we calculate it at fixed coordinate position and time  $(t,x^i)$  which depend on the coordinate system chosen. To convert it to an observable we have to compute it at an observed redshift z in some fixed observed direction  $\mathbf{n}$ . The details of this conversion are also given in Appendix A.2. The result is

$$\delta \gamma^{ab}(z, \mathbf{n}) = \bar{\gamma}^{ac} \nabla_c \delta \theta_{GI}^b + \bar{\gamma}^{bc} \nabla_c \delta \theta_{GI}^a - 2 a^2 r^2 \bar{\gamma}^{ac} H_{cd}^{(t)} \bar{\gamma}^{db} + 2 \bar{\gamma}^{ab} \Psi$$
$$+ 2 \bar{\gamma}^{ab} \left( \frac{\delta z_{GI}}{\mathcal{H}r} - \delta z_{GI} + \frac{\delta w_{GI}}{r} \right), \qquad (2.18)$$

where

$$\delta z_{GI} = -\Phi + \sigma_r^{(v)} + \delta w_{GI}' - \frac{1}{a} \partial_r \int_0^{t_s} dt \, a \, \Phi.$$
 (2.19)

The first line is simply  $\delta \gamma_{GI}^{ab}$ , but in the second line the gauge dependent terms of (2.13) have been converted into gauge invariant terms. This expression is now explicitly gauge invariant and, thanks to Eq. (2.12), leads to one of the main result of this work: the Jacobi map at linear order in perturbation theory is

$$J_B^A(z, \mathbf{n}) = \bar{d}(z, \mathbf{n}) \left\{ \delta_{AB} \left[ 1 - \Psi + \left( 1 - \frac{1}{\mathcal{H}r} \right) \delta z_{GI} - \frac{\delta w_{GI}}{r} \right] - \frac{1}{2} \hat{\gamma}_{ac} \nabla_b \delta \theta_{GI}^c \hat{s}_A^a \hat{s}_B^b - \frac{1}{2} \hat{\gamma}_{bc} \nabla_a \delta \theta_{GI}^c \hat{s}_A^a \hat{s}_B^b + H_{ab}^{(t)} \hat{s}_A^a \hat{s}_B^b \right\}.$$
 (2.20)

This expression also shows that the Jacobi map is gauge invariant as it is expected for an observable. Furthermore it is symmetric which shows that at first order lensing does not induce rotation. The trace of  $J_B^A$  gives rise to the convergence  $\kappa$ , while its traceless part defines the shear.

#### 3 Shear E and B modes

We follow the standard approach in the literature, for the decomposition of lensing shear into its E- and B- modes. It relies on the definition of an appropriate 2-screen orthogonal to the line-of-sight. We consider the generic line-of-sight

$$n^{i} = (\sin\theta\cos\phi, \sin\theta\sin\phi, \cos\theta) \tag{3.1}$$

and define the basis  $(e_A^i)$  in the 2d plane orthogonal to  $n^i$  through the following conditions

$$e_A^i e_{iB} = \delta_{AB}$$
 and  $e_A^i n_i = 0$ . (3.2)

The  $e_A^i$  can be explicitly given by

$$e_1^i = (\cos\theta\cos\phi, \cos\theta\sin\phi, -\sin\theta)$$
 and  $e_2^i = (-\sin\phi, \cos\phi, 0)$ , (3.3)

which are simply  $\hat{e}^i_{\theta}$  and  $\hat{e}^i_{\phi}$  used in Appendix B of [3]. Hence, standard approach to lensing theory projects  $D_{ab}$  as given in the Introduction on the angular part of the basis  $e^i_A$ . Once this projection is done, the decomposition in E- and B- modes takes place on the 2d screen defined

by  $e_A^i$ . We are going to show here that this procedure is automatically taken into account in Eq. (2.20) and hence no further projection is needed to extract the shear components.

To this aim, we first recall that

$$\frac{\partial n^i}{\partial \theta^a} \frac{\partial \theta^a}{\partial n^j} = \delta^i_j - n^i n_j \,. \tag{3.4}$$

Moreover

$$\hat{s}_A^a = \frac{\partial \theta^a}{\partial n^i} e_A^i \quad \text{and} \quad e_A^i = \frac{\partial n^i}{\partial \theta^a} \hat{s}_A^a \,.$$
 (3.5)

Hence, for a generic spatial tensor T we obtain

$$\hat{s}_{A}^{a}\hat{s}_{B}^{b}T_{ab} = \frac{\partial\theta^{a}}{\partial n^{i}}\frac{\partial\theta^{b}}{\partial n^{j}}\frac{\partial n^{k}}{\partial\theta^{a}}\frac{\partial n^{l}}{\partial\theta^{b}}e_{A}^{i}e_{B}^{j}T_{kl}$$

$$= \left(\delta_{i}^{k} - n^{k}n_{i}\right)\left(\delta_{j}^{l} - n^{l}n_{j}\right)e_{A}^{i}e_{B}^{j}T_{kl} = e_{A}^{i}e_{B}^{j}T_{ij}.$$
(3.6)

This proves that Eq. (2.20) is automatically ready to be used as a projected quantity on the 2d screen for the study of the shear. Here we remark an important point. As already mentioned above, standard approaches to lensing theory [1–3] start from the amplification matrix  $A_{ij} = \partial_i \delta x_j$  and project it on the basis  $e_A^i$  afterwards. Following our derivation, this procedure is not well-posed from the mathematical point of view, since  $A_{ij}$  does not necessarily transform as a tensor<sup>2</sup> as required instead by Eq. (3.6). Moreover, in the treatment of weak lensing theory with the Jacobi map the projection on the  $e_A^i$  basis naturally emerges.

We now decompose the lensing shear in E- and B- modes defined through the circular basis

$$e_{\pm}^{j} \equiv \frac{1}{\sqrt{2}} \left( e_1^{j} \pm i e_2^{j} \right) , \qquad (3.7)$$

where the subscripts +/- respectively refer to anti-clockwise and clockwise circular basis. According to Eqs. (3.5),

$$e_{\pm}^{i} = \frac{\partial n^{i}}{\partial \theta^{a}} \hat{s}_{\pm}^{a} \tag{3.8}$$

where we have defined  $\hat{s}^a_{\pm} \equiv \frac{1}{\sqrt{2}} (\hat{s}^a_1 \pm i \hat{s}^a_2)$ . Let us underline for later use that under a rotation by an angle  $\beta$  of the basis in the 2d screen, both  $e^j_{\pm}$  and  $\hat{s}^a_{\pm}$  change by an overall factor  $\exp(\pm i\beta)$ .

Hence, we first decompose  $J_{AB}(z, \mathbf{n})$  into

$$\kappa(z, \mathbf{n}) \equiv 1 - \frac{1}{2 \, \bar{d}} \, \delta^{AB} J_{AB} \qquad \text{convergence,} 
\omega(z, \mathbf{n}) \equiv \frac{i}{2 \, \bar{d}} \, \sigma_2^{AB} J_{AB} \equiv 0 \qquad \text{rotation,} 
\text{and shear} 
\gamma_1(z, \mathbf{n}) \equiv \frac{1}{2 \, \bar{d}} \, \sigma_3^{AB} J_{AB} \qquad , \qquad \gamma_2(z, \mathbf{n}) \equiv \frac{1}{2 \, \bar{d}} \, \sigma_1^{AB} J_{AB} \,.$$
(3.9)

Here  $(\sigma_i^{AB})$  are the Pauli matrices. We also introduce

$$\gamma_{\pm}(z, \mathbf{n}) \equiv \gamma_1 \pm i\gamma_2 \,, \tag{3.10}$$

which are the  $e_+$  and  $e_-$  components of  $\gamma$ .

For scalar perturbations, the fully relativistic and gauge invariant shear agrees with the standard result. Vector perturbations are less interesting as they are not generated in inflationary models. The vector shear from a cosmic string network is estimated in [7].

From (3.9), inserting  $J_{AB}$  from (2.20) we find

$$\gamma_{\pm}(z, \mathbf{n}) = -\hat{\gamma}_{ac} \nabla_b \delta \theta_{GI}^c \hat{s}_{\pm}^a \hat{s}_{\pm}^b + H_{ab}^{(t)} \hat{s}_{\pm}^a \hat{s}_{\pm}^b.$$
 (3.11)

In this derivation,  $\gamma_{\pm}$  naturally emerge as projected onto the circular polarization basis. Inserting also (2.16) for  $\delta\theta_{GI}^c$  and making use of Eq. (E.7) we obtain

$$\gamma_{+} = \int_{0}^{r_{s}} \frac{dr}{r^{2}} \left( \partial_{+}^{2} \delta w_{GI} - r \, \partial_{+} \, \sigma_{+}^{(v)} - 2 \, r \partial_{+} \, H_{r+}^{(t)} \right) + H_{++}^{(t)} ,$$

$$\gamma_{-} = \int_{0}^{r_{s}} \frac{dr}{r^{2}} \left( \partial_{-}^{2} \delta w_{GI} - r \, \partial_{-} \, \sigma_{-}^{(v)} 2 \, r \partial_{-} \, H_{r-}^{(t)} \right) + H_{-}^{(t)} . \tag{3.12}$$

This result is in agreement with [22] where  $\partial_{\pm}$  are written as the more familiar spin raising and spin lowering operators,  $\partial_{+} \equiv -\partial / \sqrt{2}$  and  $\partial_{-} \equiv -\overline{\partial} / \sqrt{2}$ , where (see also Appendix E for details) the helicity components of  $\sigma_{a}^{(v)}$ ,  $H_{ra}$  and  $H_{ab}$  are defined by

$$\sigma_{\pm}^{(v)} \equiv \hat{s}_{\pm}^a \sigma_a^{(v)}$$
 ,  $H_{r\pm}^{(t)} \equiv \hat{s}_{\pm}^a H_{ra}^{(t)}$  and  $H_{\pm\pm}^{(t)} \equiv \hat{s}_{\pm}^a \hat{s}_{\pm}^b H_{ab}^{(t)}$ . (3.13)

Eqs. (3.12) and (3.13) make evident that  $\gamma_{\pm}$  are respectively helicity  $\pm 2$  objects. They then can be decomposed in terms of the spin-weighted spherical harmonics  $_{\pm 2}Y_{\ell m}(\mathbf{n})$  (see Appendix E for details) as

$$\gamma_{\pm}(z, \mathbf{n}) = \sum_{\ell m} a_{\ell m}^{\pm}(z)_{\pm 2} Y_{\ell m}(\mathbf{n}).$$
(3.14)

The coefficients  $a_{\ell m}^{\pm}$  are in general complex. They can be further decomposed as

$$a_{\ell m}^{E}(z) \equiv \frac{1}{2} \left( a_{\ell m}^{+} + a_{\ell m}^{-} \right) \quad \text{and} \quad a_{\ell m}^{B}(z) \equiv \frac{i}{2} \left( a_{\ell m}^{+} - a_{\ell m}^{-} \right) .$$

These are the coefficients of the E- and B- mode spectra of the shear,

$$C_{\ell}^{E}(z_{1}, z_{2}) = \langle a_{\ell m}^{E}(z_{1}) a_{\ell m}^{E}^{*}(z_{2}) \rangle$$
 and  $C_{\ell}^{B}(z_{1}, z_{2}) = \langle a_{\ell m}^{B}(z_{1}) a_{\ell m}^{B}^{*}(z_{2}) \rangle$ . (3.16)

Here  $\langle \dots \rangle$  stands for an *ensemble average* over all the possible realizations of the perturbations. Contrary to  $\gamma_{\pm}$  the shear E- and B-mode spectra are independent of the chosen coordinate system. Since they have opposite helicity, E- and B-modes are uncorrelated.

# 3.1 Power spectra

In this section we present the power spectrum for  $\gamma_{\pm}(z, \mathbf{n})$ . Inserting (2.17) in (3.12) we obtain

$$\gamma_{\pm}(z, \mathbf{n}) = \partial_{\pm}^{2} \int_{0}^{r_{s}} dr \frac{r_{s} - r}{r r_{s}} \left( \sigma_{r}^{(v)} + H_{rr}^{(t)} - \Phi - \Psi \right) - \partial_{\pm} \int_{0}^{r_{s}} \frac{dr}{r} \left( \sigma_{\pm}^{(v)} + 2H_{r+}^{(t)} \right) + H_{\pm\pm}^{(t)}.$$
(3.17)

We focus our investigation to tensor perturbations. The scalar part is simple and leads to the well known standard result, see, e.g. [1–3], and as said vector perturbations are absent in simple inflationary models.

In Appendix B.1 we give the detailed derivation of the shear tensor power spectrum using the total angular momentum method. Here we just report the results for the E- and B-mode spectra. We can decompose each of them in the form

where 0, 1, 2 respectively label helicity 0, helicity 1 and helicity 2 projections of the tensor modes onto the screen. A single subscript stands for auto-correlation of helicity projections whereas double subscripts indicate cross-correlations between different helicity projections. We obtain the following non-vanishing contributions for the auto-correlations

Here  $P_T(k, z_1, z_2)$  is the unequal redshift tensor power spectrum. It is obtained from the inital power spectrum  $P_T(k)$  and the tensor transfer function  $T_T(k, z)$  by  $P_T(k, z_1, z_2) = P_T(k)T_T(k, z_1)T_T(k, z_2)$ . The relations between the comoving distance and redshift are obvious,  $r_1 = r(z_1)$ ,  $r_2 = r(z_2)$ , z = z(r) and z' = z(r').

In Section 5, we will present numerical results of our helicity decomposition for a tensor power spectrum from inflation.

#### 4 Convergence

As stressed already previously, our results show that in general  $\kappa$  and  $\gamma_E$  are different. In this section, we explicitly evaluate the angular power spectrum of the convergence in order to quantify this difference for scalar and tensor perturbations. To this aim, we start from the Jacobi map given in Eq. (2.20) and evaluate the convergence according to Eq. (3.9). We find

$$\kappa(z, \mathbf{n}) = \Psi - \left(1 - \frac{1}{\mathcal{H}r}\right) \delta z_{GI} + \frac{\delta w_{GI}}{r} + \frac{1}{2} \nabla_a \delta \theta_{GI}^a - \frac{1}{2} H_{ab}^{(t)} \hat{\gamma}^{ab}, \qquad (4.1)$$

$$\kappa^{(T)}(z, \mathbf{n}) = -\left(1 - \frac{1}{\mathcal{H}r}\right) \delta w_{GI}' + \frac{\delta w_{GI}}{r}$$

$$-\frac{1}{2} \int_0^{r_s} \frac{dr}{r^2} \left(\Delta_2 \delta w_{GI} - 2r \hat{\gamma}^{ab} \nabla_a H_{rb}^{(t)}\right) - \frac{1}{2} H_{ab}^{(t)} \hat{\gamma}^{ab}. \qquad (4.2)$$

While the first line is the full  $\kappa$ , the second relation is valid only for tensor perturbations.

For comparison with the literature we also evaluate (2.13) for scalar perturbations at fixed time, t, in longitudinal gauge. After some integration by part we find

$$\kappa^{(S)}(t,\mathbf{n}) = \psi + \int_0^{r_z} \frac{dr}{r_z} \left[ \frac{r_z - r}{r} \Delta_2(\Phi + \Psi) - (\Phi + \Psi) \right], \qquad (4.3)$$

where  $r_z$  is the comoving distance out to redshift z(t). This result agrees with Ref. [22], but note that it is not gauge invariant. Nevertheless, in addition to the traditional integral of  $\Delta_2(\Phi+\Psi)$  which comes from  $\nabla_a\delta\theta^a_{GI}$  and is also there in the scalar shear, there are additional relativistic terms. The observable  $\kappa(z,\mathbf{n})$  contains additional corrections of similar amplitude as the relativistic terms. For scalar perturbations (4.1) becomes

$$\kappa^{(S)}(z, \mathbf{n}) = \Psi - \left(1 - \frac{1}{\mathcal{H}r}\right)\delta z_{GI} + \frac{\delta w_{GI}}{r} + \frac{1}{2}\nabla_a \delta \theta_{GI}^a, \tag{4.4}$$

where for scalar perturbations we have

$$\delta w_{GI} = -\int_0^r dr' \left(\Phi + \Psi\right) ,$$

$$\nabla_a \delta \theta_{GI}^a = \int_0^r dr' \frac{r - r'}{rr'} \Delta_2 \left(\Phi + \Psi\right) ,$$

$$\delta z_{GI} = -\Phi - \int_0^r dr' \left(\Phi' + \Psi'\right) - \partial_r \int_0^{t_s} dt \, \frac{a(t')}{a(t)} \, \Phi(t', r) ,$$

$$(4.5)$$

so that finally

$$\kappa^{(S)}(z, \mathbf{n}) = \Psi + \Phi + \int_0^{r_z} \frac{dr}{r_z} \left[ \frac{r_z - r}{r} \Delta_2(\Phi + \Psi) - (\Phi + \Psi) \right] + \left( 1 - \frac{1}{\mathcal{H}r} \right) \left[ \int_0^r dr' \left( \Phi' + \Psi' \right) + \partial_r \int_0^{r_s} dr' \frac{a(t')}{a(t_s)} \Phi(t', r') \right] - \frac{1}{\mathcal{H}r} \Phi.$$
 (4.6)

In  $\Lambda$ CDM cosmology the term  $\partial_r \int_0^{r_s} dr' \frac{a(t')}{a(t_s)} \Phi(t', r')$  can be replaced by the radial velocity,  $V_r$ . We have assumed that our sources and the observer move on geodesics which is not necessarily true for the velocity field of the cosmic fluid which obeys the Euler equation. However, for pressureless matter in  $\Lambda$ CDM the fluid velocity is geodesic. Comparing (4.6) with (4.3), we notice that several additional terms of the order of the gravitational potentials  $\Psi$  appear as well as one term proportional to the velocity,  $\partial_r \Psi$  which is parametrically a factor  $k/\mathcal{H}$  larger than potential terms. Our result actually agrees up to the sign with the perturbation of the area distance which can be found e.g. in Refs. [21, 23, 24]. The expression for its power spectrum, the  $C_\ell^{(s)\kappa}(z_1, z_2)$  is somewhat cumbersome and not very illuminating. It is given explicitly in the Appendix, Eq. (C.9) and plotted in the figures of Section 5.

Let us now concentrate on tensor perturbations. We recall that for tensor perturbations

At this point, we make use of the fact that  $H_{ij}^{(t)}$  is transverse and traceless, so that we can

$$\kappa(z, \mathbf{n}) = -\left(1 - \frac{1}{\mathcal{H}r}\right) \int_{0}^{r_{z}} dr \, \partial_{t}H_{rr}^{(t)} + \frac{1}{r_{z}} \int_{0}^{r_{z}} dr \, H_{rr}^{(t)}$$

$$-\frac{1}{2} \int_{0}^{r_{z}} dr \left(\frac{r_{z} - r}{r_{z}r} \Delta_{2} H_{rr}^{(t)} + 2 \, \partial_{r}H_{rr}^{(t)} + 6 \, \frac{H_{rr}^{(t)}}{r}\right) + \frac{1}{2} H_{rr}^{(t)}$$

$$= \int_{0}^{r_{z}} dr \left[\frac{H_{rr}^{(t)}}{r_{z}} - 3 \frac{H_{rr}^{(t)}}{r} - \left(2 - \frac{1}{\mathcal{H}r_{z}}\right) \partial_{r}H_{rr}^{(t)} - \frac{1}{2} \frac{r_{z} - r}{r_{z}r} \Delta_{2} H_{rr}^{(t)}\right]$$

$$+ \left(\frac{3}{2} - \frac{1}{\mathcal{H}r}\right) H_{rr}^{(t)}. \tag{4.8}$$

Eq. (4.8) has been further manipulated in order to write all the integrated terms without time derivative. To this aim, we made use of the fact that all the integrals in Eq. (4.8) are done along the past light-cone, where  $\frac{d}{dr} = -\partial_t + \partial_r$ . This result agrees (up to a sign) with the perturbation of the area distance from tensor perturbations, see [25]. In Appendix B.3 we calculate the convergence power spectrum from (4.8). Here we just report the final result.

Introducing the kernels

$$\mathcal{I}_{\ell}(k,r,r') = \left(2 - \frac{1}{\mathcal{H}r}\right) \frac{j_{\ell+1}(kr')}{kr'} \\

the convergence power spectrum from tensor perturbations is given by

The corresponding kernels  $\mathcal{I}_{\ell}^{E}$  and  $\mathcal{L}_{\ell}^{E}$  for the shear E-modes are

$$\mathcal{I}_{\ell}^{E}(k,r,r') = \left[\frac{\ell(\ell+1)}{2} \frac{r-r'}{r} - (\ell-2) - 3\right] \frac{j_{\ell}(kr')}{(kr')^{2}} + \frac{j_{\ell+1}(kr')}{kr'} 
\mathcal{L}_{\ell}^{E}(k,r) = \frac{1}{2} \frac{j_{\ell}(kr)}{(kr)^{2}},$$


which are clearly different. They are the kernels one obtains when considering only the term  $\Delta_2 \delta w_{GI}$  in (4.1).

While the difference between  $\kappa$  and E-mode shear power spectra for scalar modes are terms which are parametrically smaller, by at least one factor  $(k/\mathcal{H})$  than the equal term which dominates on small scales,  $k \gg \mathcal{H}$ , for tensor perturbations the terms are all of the same order and we can at best say that  $\kappa$  and E-shear power spectra are of the same order of magnitude.

#### 5 Numerical results

In this section we present the numerical evaluation of the convergence and the shear (E- and B- modes). We consider the Planck best fit cosmology [26], as well as some simple analytical approximations.

We first plot the scalar  $\kappa$  and  $\gamma_E$  power spectra where the latter is rescaled by a factor  $[\ell(\ell+1)]^2/[(\ell+2)!/(\ell-2)!]$ , so that it should agree with the  $\kappa$  power spectrum according to standard lensing calculations, see [1–3]. While this is an excellent approximation for  $\ell \gtrsim 20$ , it fails by up to 20% at very low  $\ell$ 's. It is an interesting open question whether this difference can be measured with future weak lensing and galaxy number count surveys.

We now concentrate on tensor perturbations. The linear gravitational waves Fourier power spectrum is determined by

$$P_T(k, t_1, t_2) = T_h(k, t_1) T_h(k, t_2) P_{T0}(k) , \qquad (5.1)$$

with


$$P_{T0}(k) = 2\pi^2 \frac{rA_s}{k^3} \left(\frac{k}{k_0}\right)^{n_T}, \qquad (5.2)$$

where r denotes the scalar-to-tensor ratio at  $k_0 = 0.002 \text{ Mpc}^{-1}$  and we chose  $n_T = -r/8$  given by the consistency relation. We have to evaluate the tensor transfer function

$$T_h'' + 2\mathcal{H}T_h' + k^2T_h = 0, (5.3)$$

with the initial conditions  $T_h(0) = 1$  and  $T'_h(0) = 0$ . In a matter-dominated universe the growing mode of (5.3) is given by

$$T_h^{\mathcal{M}} = 3 \frac{j_1(kt)}{kt}. \tag{5.4}$$






Figure 2. We plot the shear E (left) and B (right) modes for tensor perturbations. We indicate the different contributions to Eqs. (B.25) with different colors: blue for the terms involving  $\hat{Q}_1$ , green for  $\hat{Q}_2$  and magenta for  $\hat{Q}_3$ . The different styles refer to the different approximations: dot-dashed for matter-dominated universe, dotted for radiation and matter, dashed for CDM and solid for  $\Lambda$ CDM. To compare with Ref. [3] we use r = 0.2.

This is the approximation adopted in Ref. [3]. However, this approximation neglects the phase of radiation domination which changes the initial conditions for the matter-dominated epoch. A more accurate approximation consists in considering first an era of radiation domination and matching the initial conditions for the subsequent matter-dominated epoch. Following Refs. [27–29] we obtain

$$D = \frac{1}{3kt_*} + \frac{kt_*}{3} + \frac{\cos(2kt_*)}{3kt_*} + \frac{\sin(2kt_*)}{6}, \qquad (5.7)$$

$$t_* = \frac{4\sqrt{\Omega_{\rm rel}}}{H_0\Omega_M} \simeq 540 \text{Mpc} \,.$$


Here  $t_*$  is the conformal time at equal matter and radiation.

In addition to these two approximations we also consider a universe without dark energy,  $\Omega_{\Lambda}=0,$  where

$$\mathcal{H}^{\text{CDM}} = \frac{1}{t} + \frac{1}{t+t} \tag{5.9}$$

and the complete solution in  $\Lambda$ CDM, where the Hubble parameter is computed with CLASS [30], with Planck best-fit cosmology [26].

In Fig. 2 we compare the contributions from  $\hat{Q}_1$ ,  $\hat{Q}_2$  and  $\hat{Q}_3$  to the shear E- and Bmode power spectra. These quantities are introduced in appendix B.2, see [3, 31] for details.

We plot these quantities for easy comparison with Ref. [3]. All our plots start at  $\ell=3$  since our expressions formally diverge at  $\ell=2$ . This is due to the fact that we have neglected the term at the observer which regularizes this unphysical divergence, see [3] for a discussion. We see that except at the largest scales,  $\ell \lesssim 10$ , the two approximations (5.4)-(dot-dashed lines used in Ref. [3]) and (5.5) (dotted lines) fail to describe correctly scales that enter the horizon during the radiation era. The simplest approximation, Eq. (5.4), agrees well with the results presented in Ref. [3]. The more accurate approximation provided by Eq. (5.5) is quite good at smaller scales, failing therefore only on the scales comparable with the transition between the two regimes. Instead the impact of  $\Omega_{\Lambda}$  on the Hubble parameter does not lead to any sizable effect and the pure CDM spectra cannot be distinguished from the  $\Lambda$ CDM ones. Of course at z=2 the universe is matter dominated and  $\Lambda$  is subdominant. But since lensing is an integrated quantity, also low redshifts contribute to it. Nevertheless, these contributions cannot alter the signal appreciably. We have also computed the lensing signal at low redshift, z=0.3 where  $\Lambda$  is still dominant. But also there the difference between the CDM transfer function and the correct  $\Lambda$ CDM one changes the (much smaller) result only by about 20%. Hence tensor-shear is not a useful observable to measure  $\Lambda$ .

In fig. 3 we show the E- and B- modes with the absolute value of the individual contributions as defined in Eqs. (3.19, 3.20). We see that all the terms contribute with similar amplitudes and shapes to the total power spectrum. Note also that on large scales, the negative cross correlations of the different helicities lead to significant cancellation, while on smaller scales,  $\ell > 10$  their contribution is less relevant. Both the E-mode and B-mode power spectra have the same amplitudes for  $\ell > 6$ . We have checked numerically that this equality persists also for higher  $\ell$ . In Appendix D we show that the evolution equation for the E- and B-modes of the shear is governed by the E and B parts of the Weyl tensor. We also show that for statistically isotropic, free gravitational waves inside the horizon,  $k > \mathcal{H}$ , the E and B part of the Weyl tensor have the same power spectrum.

In Ref. [3] it has been shown that this tensor auto-correlation spectrum is much smaller




Figure 4. We plot the shear E (top-left) and B (top-right) modes and  $\kappa$  (bottom-left). Different colors refer to absolute value of different redshift cross-correlation. In the bottom-right plot we compare the power spectra for  $z_1 = z_2 = 2$ . The E- and B-spectra agree for  $\ell > 6$  and the convergence spectrum is about a factor 50 lower than the shear. We use the scalar-to-tensor ration r = 0.1.

than intrinsic alignment and will therefore be very hard to measure. For this reason we also show the cross-correlations which are not plagued by intrinsic alignment.

In fig. 4 we consider the correlations between different redshifts. The coefficients of the expansion in spherical harmonics of the E- and B- modes oscillate with a frequency determined by the comoving distance to the source. By correlating different redshifts we therefore multiply spherical Bessel functions with different phases which leads to oscillations in the cross power spectrum. Moreover, the conversion from the angular multipole  $\ell$  to the physical separation between the two sources is redshift dependent. In particular, a given multipole  $\ell$  corresponds to a larger physical distance when increasing the redshift difference  $\Delta z = |z_1 - z_2|$ , leading to a suppression of the angular power spectrum. For the biggest redshift difference,  $z_2 = 1.25$  (orange lines) the rapid oscillations of the spherical Bessel functions are challenging our accuracy. The wiggles at  $\ell > 60$  are not physical but an





Figure 5. On the left panel we plot the ratio between shear E and B modes (solid lines) and between shear E modes and the convergence  $\kappa$  (dashed lines) at different redshifts. On the right panel we show the redshift evolution of  $\kappa$  for different multipoles. We remark that its behaviour is not monotonic with the redshift z. We remark that this in line with the maximum of the angular diameter distance  $z_* \simeq 1.59$ , as already pointed out in Ref. [25]

accuracy problem.

In fig. 4, lower panel, we also show the tensor spectrum of the convergence  $\kappa$ . While the standard treatment of lensing predicts that this should agree with the shear E-mode spectrum (up to an  $\ell$ -factor which rapidly converges to 1 for increasing  $\ell$ ), we see a very different behavior. At equal redshift (blue line) the  $\kappa$  power spectrum is by more than an order of magnitude smaller than the shear E-mode power spectrum. This remains roughly true for the unequal redshift spectra even though the shapes, e.g., the number and positions of the zero-crossings, are similar.

Contrary to that, the E- and B-mode shear spectra are identical for  $\ell > 6$  within numerical accuracy both for equal and unequal redshift spectra. This equality comes from

the fact that they are generated respectively by the E- and B-part of the Weyl tensor of the gravitational waves. In Appendix D we show this and we also show that the E- and B-parts of the Weyl tensor for free gravitational waves inside the horizon have identical spectra.

In Fig. 5 we show the ratio between the shear E- and B-modes which is always very close to one and the ratio between the convergence and the shear E-mode which has a minimum of about  $10^{-3}$  for  $\ell \sim 20$  at  $z=z_* \simeq 1.6$  where the angular diameter distance is maximal. At higher redshifts  $\kappa$  increases again and approaches the shear spectra for  $z \gtrsim 4$ , see Fig. 6.

To summarize our results, for linear tensor perturbations, the E- and B-mode spectra of the shear are identical, the  $\kappa$ -spectrum is more than an order of magnitude smaller for  $z \leq 3$  and the rotation vanishes. This is in contrast to scalar perturbations where at sufficiently high  $\ell$  the shear E-mode and the  $\kappa$  spectra agree while the shear B-mode and the rotation vanish.

#### 6 Conclusions

In this paper we have computed the Jacobi map to first order in cosmological perturbation theory. This is the correct gauge invariant and fully relativistic lensing map. We have shown that contrary to the often used 'amplification matrix'  $\partial_a \theta_b$ , the Jacobi matrix has in general four degrees of freedom and is symmetric at first order in perturbation theory also when vector and tensor perturbations are included. Therefore lensing rotation vanishes at first order also for vector and tensor perturbations. Furthermore, the simple relations between the convergence  $\kappa$  and the shear E-mode  $\gamma_E$  are not valid. While for scalar perturbations the difference is relatively small (up to 20%) and only relevant on large scales,  $\ell \lesssim 20$ , it is very significant for tensor perturbations, for which the corresponding power spectra differ by more than an order of magnitude. More precisely, the tensor convergence power spectrum is on average a factor 10 to 50 times smaller then the tensor shear E-mode power spectrum. This factor depends on the redshift and is largest at  $z_* \simeq 1.6$  which maximizes the angular diameter distance. Even though, at first, this is surprising, it is certainly not inconceivable. While for scalar perturbations there is a hierarchy between time derivatives,  $\propto \mathcal{H}$  and spatial derivatives  $\propto k$ , this is no longer the case for tensor perturbations which oscillate with frequency k. Therefore, the additional terms which appear in our relativistic treatment, which contain radial derivatives that can be converted into time derivatives on the lightcone, are expected to be of the same order of magnitude as the original terms, and therefore they can change the result very substantially.

This equivalence of spatial and temporal derivatives for free, subhorizon tensor perturbations also explains the fact that the E- and B-mode shear power spectra are identical well inside the horizon, for z=2 this is above  $\ell \sim 6$ .

Furthermore, the simple relation between the  $\gamma_B$  and rotation power spectrum is not valid as the latter vanishes at first order in perturbation theory while the former is equal to the E-mode spectrum for tensor perturbations.

While lensing shear spectra at equal redshift are plagued by intrinsic alignment and therefore difficult to measure, cross spectra at different redshift might be a way out of this systematic problem.

# A The perturbed angular metric in GLC gauge

#### A.1 Coordinate transformation from GLC gauge to standard linear theory

In this appendix we derive the expression for the GLC  $\delta\gamma_{ab}$  in terms of general metric perturbations as defined in Eqs. (1.1) to (1.3). A coordinate transformation between GLC metric  $g_{\mu\nu}^{GLC}$  (2.1) and the a metric  $g_{\alpha\beta}$  in Eq. (1.1) is given by

$$g_{GLC}^{\mu\nu} = \frac{\partial x^{\mu}}{\partial y^{\alpha}} \frac{\partial x^{\nu}}{\partial y^{\beta}} g^{\alpha\beta} \,. \tag{A.1}$$

Here  $x^{\mu}=(\tau+\delta\tau,w+\delta w,\theta^a+\delta\theta^a),\ y^{\alpha}=(t,x^i)$  and  $g^{\mu\nu}_{GLC}$  and  $g^{\alpha\beta}$  are respectively the linearized inverse of  $g^{GLC}_{\mu\nu}=\bar{g}_{\mu\nu}+\delta g_{\mu\nu}$  and  $g_{\alpha\beta}=\bar{g}_{\alpha\beta}+\delta g_{\alpha\beta}$ . Eq. (A.1) then returns, respectively for the  $\tau\tau$ , ww and wa components,

$$\delta \tau' = a \phi$$

$$\frac{d\delta w}{d\lambda} = \phi - n^i n^j H_{ij} - n^i B_i$$

$$\frac{d\delta \theta^a}{d\lambda} = \delta^{ij} \partial_i \theta^a \left( \partial_j \delta w - B_j - 2 n^k H_{kj} \right),$$
(A.2)

where  $'\equiv\partial_t,\,\frac{d}{d\lambda}\equiv\partial_t-n^i\partial_i$  and we have defined  $r=\sqrt{\delta_{ij}x^ix^j},\,n^i\equiv x^i/r$  as well as  $\theta^a\equiv\left(\arccos\left(\frac{x^2}{x^1}\right),\arctan\left(\frac{x^3}{r}\right)\right)$ . It is important to note that  $\frac{d}{d\lambda}$  is the total derivative along the background light cone, i.e. in direction of the null-vector  $(k^\mu)=(1,n^i)$ , whereas a prime ' is the partial derivative wrt conformal time at fixed space coordinates. By applying the SVT decomposition in Eqs. (1.2) and (1.3) and defining the Bardeen potentials  $\Phi$  and  $\Psi$  as

$$\Phi = \phi - (B + E')' - \mathcal{H}(B + E') \quad \text{and} \quad \Psi = \psi + \mathcal{H}(B + E') + \frac{1}{3}\Delta E, \quad (A.3)$$

we obtain

$$\delta \tau' = a \Phi + \left[ a \left( B + E' \right) \right]', \tag{A.4}$$

which is solved by

$$\delta \tau = \int_0^{t_s} dt \, a \, \Phi + a \left( B + E' \right) = \delta \tau_{GI} + a \left( B + E' \right) \,, \tag{A.5}$$

where we have introduced

$$\delta \tau_{GI} \equiv \int_0^{t_s} dt \, a \, \Phi \,. \tag{A.6}$$

From now on, the subscript s refers to a quantity evaluated at the source position. In this way, the second of Eqs. (A.2) can be written as

$$\frac{d\delta w}{d\lambda} = \frac{d\left(n^{i}H_{i}^{(v)} + B + n^{j}E_{,j} + E'\right)}{d\lambda} + \Phi + \Psi - n^{i}\sigma_{i}^{(v)} - n^{i}n^{j}H_{ij}^{(t)}, \tag{A.7}$$

where  $\sigma_i^{(v)} = B_i^{(v)} + H_i^{(v)'}$  is a gauge invariant vector perturbation. This leads to

$$\delta w = -\int_0^{r_s} dr \left( \Phi + \Psi - n^i \sigma_i^{(v)} - n^i n^j H_{ij}^{(t)} \right) + n^i H_i^{(v)} + B + n^j E_{,j} + E'$$

$$= \delta w_{GI} + n^i \chi_i + B + E', \qquad (A.8)$$

where we have defined  $\chi_j \equiv H_j^{(v)} + E_{,j}$  and

$$\delta w_{GI} \equiv -\int_{0}^{r_{s}} dr \left( \Phi + \Psi - n^{i} \sigma_{i}^{(v)} - n^{i} n^{j} H_{ij}^{(t)} \right) (t_{o} - r, r, \theta^{a}). \tag{A.9}$$

Here  $t_o$  denotes present time. Finally, the last of Eqs. (A.2) gives

$$\frac{d\delta\theta^{a}}{d\lambda} = \delta^{ij}\partial_{i}\theta^{a} \left(\partial_{j}\delta w_{GI} + \partial_{j}n^{k}H_{k}^{(v)} - B_{j}^{(v)} - H_{j}^{(v)'} + \frac{dH_{j}^{(v)}}{d\lambda} - 2n^{k}H_{kj}^{(t)} + \partial_{j}n^{k}E_{,k} + \frac{dE_{,j}}{d\lambda}\right) 
= \frac{d\delta\theta_{GI}^{a}}{d\lambda} + \delta^{ij}\partial_{i}\theta^{a} \left(\partial_{j}n^{k}\chi_{k} + \frac{d\chi_{j}}{d\lambda}\right),$$
(A.10)

where we have introduced

$$\delta\theta_{GI}^{a} \equiv \int_{0}^{\lambda_{s}} d\lambda \delta^{ij} \partial_{i} \theta^{a} \left( \delta w_{GI,j} - \sigma_{j}^{(v)} - 2n^{k} H_{kj}^{(t)} \right)$$

$$= -\int_{0}^{r_{s}} dr \delta^{ij} \partial_{i} \theta^{a} \left( \delta w_{GI,j} - \sigma_{j}^{(v)} - 2n^{k} H_{kj}^{(t)} \right) (t_{o} - r, r, \theta^{a}), \qquad (A.11)$$

and we have used the geometrical identity  $n^i \partial_i \theta^a = \partial_r \theta^a = 0$ . In order to simplify the gauge dependent term in Eq. (A.10), let us note that

$$\delta^{ij}\partial_{i}\theta^{a}\frac{d\chi_{j}}{d\lambda} = \frac{d\left(\delta^{ij}\partial_{i}\theta^{a}\chi_{j}\right)}{d\lambda} - \delta^{ij}\frac{d\partial_{i}\theta^{a}}{d\lambda}\chi_{j} = \frac{d\left(\delta^{ij}\partial_{i}\theta^{a}\chi_{j}\right)}{d\lambda} + \delta^{ij}n^{k}\partial_{k}\left(\partial_{i}\theta^{a}\right)\chi_{j}, \quad (A.12)$$

since  $\partial_i \theta^a$  explicitly does not depend on t. Now we have that the combination

$$\delta^{kj} \left( \partial_i \theta^a \partial_j n^i + n^i \partial_{ij} \theta^a \right) = \delta^{kj} \partial_j \left( n^i \partial_i \theta^a \right) = 0, \tag{A.13}$$

since  $n^i \partial_i \theta^a = \partial_r \theta^a = 0$ . With this the deflection angle can finally be written as

$$\delta\theta^a = \delta\theta^a_{GI} + \delta^{ij}\partial_i\theta^a \chi_i. \tag{A.14}$$

The above Eqs. (A.5), (A.8) and (A.14) share the following property: the integrated terms are gauge invariant, as expected, whereas the gauge dependent part can be entirely taken out of the integral and can be written as a boundary term. This is a consequence of the fact that gauge transformation can be written as a Lie derivative, acting as a differential operator rather than an integral one. Let us also remark that  $\partial_i \theta^a$  is precisely the angular

part of the Jacobian needed to transform car thesian coordinates into polar ones. Since this transformation preserves the SO(3) background symmetry and both  $H_j^{(v)}$  and  $E_{,j}$  are vectors under the transformation of this symmetry group, we can immediately write

$$\delta w = \delta w_{GI} + \chi_r + B + E'$$
 and  $\delta \theta^a = \delta \theta_{GI}^a + \chi^a$ . (A.15)

Finally, let us compute the perturbation of the inverse  $\gamma^{ab} = \bar{\gamma}^{ab} + \delta \gamma^{ab}$  to first order, needed for the expression of the Jacobi map. To this aim, we make use of the ab component of Eq. (A.1). The background term is given by

$$\bar{\gamma}^{ab} = a^{-2} \delta^{ij} \partial_i \theta^a \partial_j \theta^b \,. \tag{A.16}$$

After some straightforward manipulations, also the linear term can be written as

$$\delta \gamma^{ab} = a^{-2} \left( \partial_i \delta \theta^a_{GI} \partial_j \theta^b \delta^{ij} + \partial_i \theta^a \partial_j \delta \theta^b_{GI} \delta^{ij} - 2 \partial_i \theta^a \partial_j \theta^b \delta^{ik} \delta^{jl} H_{kl}^{(t)} \right)$$

$$+ \delta^{kl} \partial_k \bar{\gamma}^{ab} \chi_l + 2 \bar{\gamma}^{ab} \left( \psi + \frac{1}{3} \Delta E \right)$$

$$= \delta \gamma^{ab}_{GI} + \delta^{kl} \partial_k \bar{\gamma}^{ab} \chi_l - 2 \mathcal{H} \bar{\gamma}^{ab} \left( B + E' \right)$$
(A.17)

where we have defined

$$\delta \gamma_{GI}^{ab} \equiv a^{-2} \left( \partial_i \delta \theta_{GI}^a \partial_j \theta^b \delta^{ij} + \partial_i \theta^a \partial_j \delta \theta_{GI}^b \delta^{ij} - 2 \partial_i \theta^a \partial_j \theta^b \delta^{ik} \delta^{jl} H_{kl}^{(t)} \right) + 2 \bar{\gamma}^{ab} \Psi . \tag{A.18}$$

We therefore find that also  $\delta \gamma^{ab}$  is not gauge invariant. This is in agreement with what has been found when a perturbation theory is applied directly in the light-cone coordinates [32–34]. This seems to suggest that not even the Jacobi map at linear order is gauge invariant. However, we show in the following part of this Appendix that this gauge dependence is just an artifact due to the fact that background coordinates are left unspecified. Gauge invariance will be indeed restored once the background coordinates are labelled with observable quantities like the redshift on the observer's past light-cone and the incoming directions of photons.

# A.2 Observed redshift and incoming photon directions on the past light-cone

We want to express the perturbed Jacobi map in terms of the fiducial model background coordinates where the time coordinate is replaced by the observed redshift and the observed position of source is given by the observer direction of the incoming photons and their redshift. This provides background coordinates on the past lightcone. Let us first determine the perturbed redshift of the source. With the normalization  $(k_{\mu}u^{\mu})_{o} = -a_{o} = -1$  we have

$$1 + z = -(k^{\mu}u_{\mu})_{s} = a^{-1} - \delta (g^{\mu\nu}\partial_{\mu}\tau\partial_{\nu}w)$$

$$= a^{-1} \left[ 1 - \Phi + n^{j}\sigma_{j}^{(v)} + \delta w'_{GI} - a^{-1}n^{i}\partial_{i}\delta\tau_{GI} - \mathcal{H}(B + E') \right]$$

$$= a^{-1} \left[ 1 + \delta z_{GI} - \mathcal{H}(B + E') \right], \tag{A.19}$$

where we have introduced

$$\delta z_{GI} \equiv -\Phi + n^j \sigma_i^{(v)} + \delta w'_{GI} - a^{-1} n^i \partial_i \delta \tau_{GI}. \tag{A.20}$$

Since 
$$a^{-1} = 1 + \bar{z}$$
,

$$\frac{\delta z}{1+\bar{z}} = \delta z_{GI} - \mathcal{H} \left( B + E' \right) . \tag{A.21}$$

We are now in the position to fix the gauge dependence of  $\delta \gamma^{ab}$  by expressing it in terms of the observed redshift and incoming directions on the past light-cone. Clearly, observable quantities expressed in terms of other observables cannot depend on the coordinate system. Indeed, Eqs. (A.15) and (A.21) are gauge dependent quantities representing the perturbations of redshift, incoming directions and the signal being on the past light-cone in a generic gauge. We can fix their gauge dependence by requiring that  $\delta z$ ,  $\delta w$  and  $\delta \theta^a$  are null (i.e. these assume their measured values and are not perturbed). This gives

$$B + E' = \frac{\delta z_{GI}}{\mathcal{H}}$$
 ,  $\chi_r = -\delta w_{GI} - \frac{\delta z_{GI}}{\mathcal{H}}$  and  $\chi^a = -\delta \theta_{GI}^a$ . (A.22)

Eqs. (A.22) then correspond to identify the gauge invariant variables as the ones where redshift, light-cone and deflection angles are not perturbed. At this point, it is straightforward to express  $\delta \gamma^{ab}$  in terms of the choices (A.22) and we obtain from Eq. (A.17)

$$\delta \gamma^{ab}(z, \mathbf{n}) = \delta \gamma_{GI}^{ab} - 2 \bar{\gamma}^{ab} \delta z_{GI} - \partial_r \bar{\gamma}^{ab} \delta w_{GI} - \partial_r \bar{\gamma}^{ab} \frac{\delta z_{GI}}{\mathcal{H}} - \delta \theta_{GI}^c \partial_c \bar{\gamma}^{ab}$$

$$= \delta \gamma_{GI}^{ab} + 2 \bar{\gamma}^{ab} \left( \frac{\delta z_{GI}}{\mathcal{H}r} - \delta z_{GI} + \frac{\delta w_{GI}}{r} \right) - \delta \theta_{GI}^c \partial_c \bar{\gamma}^{ab}, \qquad (A.23)$$

where we explicitly note that Eq. (A.23) is the gauge invariant variable built in the gauge where redshift and light-cone perturbations are vanishing by construction<sup>3</sup>.

Finally, thanks to the transformation properties of the Jacobian under coordinate transformation from carthesian to polar coordinates and the fact that  $H_{ij}^{(t)}$  is a tensor under SO(3), it can be shown that

$$\delta \gamma_{GI}^{ab} = \bar{\gamma}^{ac} \partial_c \delta \theta_{GI}^b + \bar{\gamma}^{bc} \partial_c \delta \theta_{GI}^a - 2 a^2 \bar{r}^2 \bar{\gamma}^{ac} H_{cd}^{(t)} \bar{\gamma}^{db} + 2 \bar{\gamma}^{ab} \Psi , \qquad (A.24)$$

where we defined  $H_{ab}^{(t)} = \partial_a n^i \partial_b n^j H_{ij}^{(t)}$ . The final expression is then

$$\delta \gamma^{ab}(z, \mathbf{n}) = \bar{\gamma}^{ac} \nabla_c \delta \theta_{GI}^b + \bar{\gamma}^{bc} \nabla_c \delta \theta_{GI}^a - 2 a^2 \bar{r}^2 \bar{\gamma}^{ac} H_{cd}^{(t)} \bar{\gamma}^{db}$$

$$+ 2 \bar{\gamma}^{ab} \left( \Psi - \delta z_{GI} + \frac{\delta z_{GI}}{\mathcal{H}r} + \frac{\delta w_{GI}}{r} \right).$$
(A.25)

Hence, the Jacobi map on the past light-cone in terms of the observed redshift and the direction of observation is

$$J_B^A(z, \mathbf{n}) = \bar{d}(z, \mathbf{n}) \left( \delta_B^A + \frac{1}{2} \delta \hat{\gamma}_{ab} \hat{s}_A^b \hat{s}_B^a \right) , \qquad (A.26)$$

where  $\delta \gamma_{ab} = \bar{d}^2 \delta \hat{\gamma}_{ab}$ . Finally, combining Eqs. (A.25) and (A.26) and recalling that in linear theory  $\delta \gamma_{ab} = -\bar{\gamma}_{ac} \delta \gamma^{cd} \bar{\gamma}_{db}$ , we find

#### B Tensor power Spectra

#### B.1 Shear

In this appendix we outline the procedure to compute the angular power spectrum of the shear from tensor perturbations given in (3.17). As the shear from scalar perturbations has been calculated in the literature before, we do not repeat it here. We use the total angular momentum method and follow the method introduced, e.g., in Chapter 5 of Ref. [21]. In order to Fourier transform the terms appearing in (3.17), we first notice that  $H_{rr}^{(t)}$ ,  $H_{r\pm}^{(t)}$  and  $H_{\pm\pm}^{(t)}$  are projection respectively of helicity 0,  $\pm 1$  and  $\pm 2$  of the tensor perturbations on the basis  $\{\mathbf{e}_{\pm}\}$  normal to the radial direction. Note that even though a gravitational wave has helicity 2 in the plane normal to its direction of propagation, it can carry helicities 0 and 1 in our direction of observation  $\mathbf{n}$ . In total generality, the components  $H_{ij}$  can then be decomposed as

Here  ${}_sY_{\ell m}(\mathbf{n}, \hat{\mathbf{k}})$  is the spherical harmonic  ${}_sY_{\ell m}(\mathbf{n})$  where  $\mathbf{k}$  is identified as the  $\mathbf{e}_z$  direction, i.e., the angles of  $\mathbf{n}$  evaluated wrt the direction of  $\mathbf{k}$ , see [21] for details. The exponential  $e^{i\mathbf{k}\cdot\mathbf{n}}$  can be further expanded into spherical Bessel functions and spherical harmonics so that the total angular momentum decomposition leads to [21]

Here  $j_L(x)$  is the spherical Bessel function of L-th order and  $\langle \ell_1, \ell_2; m_1, m_2 | \ell_3, m_3 \rangle$  are the Clebsch-Gordan coefficients. All these functions are used with the conventions reported in [21].

The coefficients in front of the integrals in Eqs. (B.1) are needed in order to obtain the correct limit case when  $\mathbf{k} \parallel \hat{\mathbf{z}}$  where the polarization tensors are

where  $e_{ij}^p(\hat{\mathbf{k}})$  is the transverse, traceless polarization tensor and  $p=\pm 1$  accounts for the two polarization states of the tensor perturbations. Before continuing, a comment about the orientation of the basis is in order. Indeed, given the tensor nature of  $H_{ij}^{(t)}$ , we need to care about the orientation of the basis and, in particular, we must ensure that the final result is independent of this choice. Given that, the choice of  $\mathbf{k}$  as a reference basis might look peculiar and it is certainly not well suited in light of the  $\int d^3\mathbf{k}$  integrals in Eqs. (B.1). To overcome this issue, we need to refer to an generic basis  $\mathbf{E}$  and decompose our perturbations in terms of this reference basis. This change of reference frame leads to (see [21])

where F and G are two unspecified functions depending only on the modulus of the wave vector, we have used the orthonormality of the  ${}_sY_{\ell m}(\hat{\bf k};{\bf E})$  in Eq. (E.3) and defined  $N_{\alpha\beta}\equiv\sum_{p=\pm1}p^{\alpha+\beta}$ , where  $\alpha$ ,  $\beta=0$  for E-modes and 1 for B-modes. From Eqs. (B.15) we notice that the sum  $\alpha+\beta$  is 0 or 2 respectively for EE and BB correlations, whereas it is 1 for EB correlations. This implies that  $N_{\alpha\beta}=2$  for both EE and BB modes whereas we get  $N_{\alpha\beta}=0$  for EB modes. This is a clear consequence of the fact that E- and B- modes have opposite parity and then their correlation vanishes.

We can now write down the non-vanishing terms appearing in the  $C_{\ell}$ 's of the shear Eand B- modes. In particular, we split

#### B.2 Comparison with Schmidt and Jeong

The total results derived in this work nicely agree with the evaluation of the E- and B- modes for the shear lensing. However, our classification of the involved terms is different. Indeed, in [3, 31] the  $a_{\ell m}^{\pm}$  coefficients have been split in the following way

where  $\widehat{Q}_1$ ,  $\widehat{Q}_2$  and  $\widehat{Q}_3$  are complex operators acting on  $j_\ell(x)/x^2$  function. The explicit definition of these operators can be found in the appendix B of [3] and the total sums in the combinations of  $a_{\ell m}^{\pm}$  agree with our results. However, the direct comparison between Eq. (B.25) and (B.12) yields the relations

The helicity-2 projections are decoupled from the others in both ways of splitting  $\gamma_{\pm}$ . However, in Eq. (B.25) the helicity-0 and helicity-1 projections of tensor perturbations are not well-decoupled. In particular, helicity-0 projection sources both  $\hat{Q}_2$  and  $\hat{Q}_3$ . For the *B*-mode, where  $\mathcal{S}^B=0$ , both the procedures lead to a proper decoupling between helicity-1 and helicity-2 projections. On the contrary, for the *E*- mode the helicity-0 projection sources both  $\hat{Q}_2$  and  $\hat{Q}_3$ .

#### B.3 Convergence

To compute the convergence power spectrum from tensor perturbations we apply the same decomposition as in Eq. (B.8), we have

The underbraced terms in Eq. (C.9) are directly sourced by the action of the angular Laplacian on the lensing potential in the convergence, as one can realize by noticing the factor  $\ell(\ell+1)$ . From a direct comparison between Eq. (C.8) and (C.9), we see that only these terms agree with the standard relation

$$C_{\ell}^{(s)E}(z_1, z_2) = \frac{(\ell+2)!}{(\ell-2)!} \frac{C_{\ell}^{(s)\kappa}(z_1, z_2)}{\ell^2(\ell+1)^2} = \frac{(\ell+2)(\ell-1)}{\ell(\ell+1)} C_{\ell}^{(s)\kappa}(z_1, z_2).$$
 (C.10)

For large  $\ell$ , one can simplify (C.9). But since here we are interested in the difference between the  $\kappa$  and  $\gamma_E$  power spectra which are most relevant at low  $\ell$ , we do not use the Limber approximation here.

Let us finally remark that the structure of Eq. (C.9) agrees with the one found in [40], where the  $C_{\ell}$ 's of the distance-redshift relation for scalar perturbations have been studied. At linear level, indeed, they are supposed to be equal to the ones of the convergence. As already pointed out there, the monopole of the convergence is not affected at all by lensing corrections. Let us also mention that making use of momentum conservation (the relativistic Euler equation for pressure-less matter yields  $a(t_1)V(t_1) = \int_0^{t_1} dt a\Psi$ ), the time integrals in (C.9) can actually be replaced by the matter velocity field. We have used this for the numerical evaluation of the  $\kappa$ -spectrum in Section 5.

#### D Evolution of shear E and B modes

Let us start from the evolution equation for the Jacobi map (see [10, 15] for details)

$$\frac{d^2 J_{AB}}{d\lambda^2} = R_{AC} J_{CB} \,, \tag{D.1}$$

where  $R_{AC} \equiv R_{\alpha\beta\nu\mu}k^{\alpha}k^{\nu}s_A^{\beta}s_C^{\mu}$  is a projection of the Riemann tensor on the Sachs basis and  $k^{\mu}$ . We want to derive the evolution equation for the lensing shear. To this end, we project Eq. (D.1) on the Pauli matrices  $\sigma_{3/1}$ . Thanks to the definition in Eqs. (3.9), we have for the lhs of Eq. (D.1)

$$\frac{d^2 \left(J_{AB} \sigma_3^{AB}\right)}{d\lambda^2} = 2 \frac{d^2 \left(\bar{d}\gamma_1\right)}{d\lambda^2} = 2\bar{d} \frac{d^2 \gamma_1}{d\lambda^2} + 2 \frac{d\bar{d} d\gamma_1}{d\lambda} + 2 \frac{d^2 \bar{d}}{d\lambda^2} \gamma_1, \tag{D.2}$$

and the same for  $\gamma_2$ . On the other hand  $R_{AC}$  can be decomposed in terms of the Ricci focusing  $\Phi_{00}$  and the Weyl projection  $\Psi_0$  (see [12]) as

$$R_{AC} = \Phi_{00} \, \delta_{AC} + \text{Re} \Psi_0 \, (\sigma_3)_{AC} + \text{Im} \Psi_0 \, (\sigma_1)_{AC} \,, \tag{D.3}$$

where  $\Phi_{00} \equiv -\frac{1}{2}R_{\mu\nu}k^{\mu}k^{\nu}$  and  $\Psi_0 \equiv \frac{1}{2}C_{\alpha\beta\mu\nu}k^{\alpha}k^{\mu}\Sigma^{\beta}\Sigma^{\nu}$  are respectively sourced by Ricci tensor  $R_{\mu\nu}$  and the Weyl one  $C_{\alpha\beta\mu\nu}$ , being  $\Sigma^{\mu} \equiv s_1^{\mu} + is_2^{\mu}$ . In this way, once projected on the Pauli matrices and assuming that  $\omega = 0$ , the rhs of Eq. (D.1) becomes

$$R_{AC}J_{CB}\sigma_3^{AB} = 2\bar{d} [(1 - \kappa)\text{Re}\Psi_0 + \gamma_1 \Phi_{00}] ,$$
  

$$R_{AC}J_{CB}\sigma_1^{AB} = 2\bar{d} [(1 - \kappa)\text{Im}\Psi_0 + \gamma_2 \Phi_{00}] .$$
 (D.4)

In this way, if we define  $\dot{} \equiv d/d\lambda$ , we get that the evolution equations for the shear components become

$$\ddot{\gamma}_{1} + \frac{\dot{d}}{\bar{d}}\dot{\gamma}_{1} + \frac{\ddot{d}}{\bar{d}}\gamma_{1} = (1 - \kappa)\operatorname{Re}\Psi_{0} + \gamma_{1}\Phi_{00},$$

$$\ddot{\gamma}_{2} + \frac{\dot{d}}{\bar{d}}\dot{\gamma}_{2} + \frac{\ddot{d}}{\bar{d}}\gamma_{2} = (1 - \kappa)\operatorname{Im}\Psi_{0} + \gamma_{2}\Phi_{00},$$
(D.5)

leading to

$$\ddot{\gamma}_{+} + \frac{\dot{\bar{d}}}{\bar{d}}\dot{\gamma}_{+} + \frac{\ddot{\bar{d}}}{\bar{d}}\gamma_{+} = (1 - \kappa)\Psi_{0} + \gamma_{+} \Phi_{00},$$

$$\ddot{\gamma}_{-} + \frac{\dot{\bar{d}}}{\bar{d}}\dot{\gamma}_{-} + \frac{\ddot{\bar{d}}}{\bar{d}}\gamma_{-} = (1 - \kappa)\overline{\Psi}_{0} + \gamma_{-} \Phi_{00}.$$
(D.6)

So far these equations are exact, modulo the absence of rotation. At linear order, we have that  $\gamma_{\pm}$  is a purely linear quantity, so  $\Phi_{00}$  can be taken as the background one, which is independent of the angles. On the other hand,  $\Psi_0$  is null on the background, hence  $\kappa$  must be taken as the background value which is 0. Finally, at linear order  $d/d\lambda$  involves only time and radial derivatives, hence Eqs. (D.6) can be readily converted to equations for the  $a_{\ell m}^{\pm}$ 's as

$$\ddot{a}_{\ell m}^{\pm} + \frac{\dot{\bar{d}}}{\bar{d}} \dot{a}_{\ell m}^{\pm} + \frac{\ddot{\bar{d}}}{\bar{d}} a_{\ell m}^{\pm} = a_{\ell m}^{\Psi_0 \pm} + \Phi_{00} a_{\ell m}^{\pm}, \tag{D.7}$$

where we have decomposed also  $\Psi_0$  in terms of the  $\pm 2Y_{\ell m}$ . We then obtain

$$\ddot{a}_{\ell m}^{E/B} + \frac{\dot{\bar{d}}}{\bar{d}} \dot{a}_{\ell m}^{E/B} + \frac{\ddot{\bar{d}}}{\bar{d}} a_{\ell m}^{E/B} = a_{\ell m}^{\Psi_0 E/B} + \Phi_{00} a_{\ell m}^{E/B}. \tag{D.8}$$

But  $a_{\ell m}^{\Psi_0 E/B}$  are nothing else than the harmonic coefficients of the Weyl tensor E- and B-modes. The E- and B-part of the Weyl tensor from gravitational waves is, see [21], Appendix A3.3.4,

$$E_{ij} = \frac{1}{2} \left( \partial_t^2 + \Delta \right) H_{ij} \simeq -k^2 H_{ij} \tag{D.9}$$

$$B_{ij} = -\frac{1}{2} \epsilon_{nmi} \partial_t \left( \partial_m H_{jn} - \partial_n H_{jm} \right) \simeq -k k_m H_{jn} \epsilon_{nmi} \,. \tag{D.10}$$

Here the  $\simeq$  sign is valid for a fixed k-mode inside the horizon when  $\partial_t H \simeq ikH$  and  $\partial_m H \simeq ik_m H$ . For this it is also important that the gravitational wave obeys the free wave equation and is not sourced by some tensor anisotropic stress. Such a source term would modify the relation. Let us consider the concrete example of an orthonormal system  $\hat{\mathbf{k}}, \mathbf{e}^{(1)}, \mathbf{e}^{(2)}$ , where  $\mathbf{k}$  is the wave vector of our gravitational wave, and  $\mathbf{e}^{(2)} = \hat{\mathbf{k}} \times \mathbf{e}^{(1)}$ . We can orient this basis such that in Fourier space

$$H_{ij} = H(\mathbf{k}, t) \begin{pmatrix} 0 & 1 & 0 \\ 1 & 0 & 0 \\ 0 & 0 & 0 \end{pmatrix} = H(\mathbf{k}, t) \left( \mathbf{e}_i^{(1)} \mathbf{e}_j^{(2)} + \mathbf{e}_i^{(2)} \mathbf{e}_j^{(1)} \right).$$

Inserting this above we obtain

$$E_{ij} \simeq k^2 H(\mathbf{k}, t) \left( \mathbf{e}_i^{(1)} \mathbf{e}_j^{(2)} + \mathbf{e}_i^{(2)} \mathbf{e}_j^{(1)} \right),$$
 (D.11)

$$B_{ij} \simeq k^2 H(\mathbf{k}, t) \left( \mathbf{e}_i^{(1)} \mathbf{e}_j^{(1)} - \mathbf{e}_i^{(2)} \mathbf{e}_j^{(2)} \right).$$
 (D.12)

While these components are uncorrelated, they have both the same power spectrum given by  $2k^4P_T(k)$ . Therefore free gravitational waves generate shear E- and B-modes with the same power spectra on subhorizon scales, i.e., for  $k > \mathcal{H}(z)$ .

### E Spin-weighted spherical harmonics

In order for the paper to be as self-contained as possible, we provide here some useful relations of spin-weighted spherical harmonics and the spin raising and lowering operators which are extensively used in this work. This appendix is not meant to give a exhaustive discussion of the subject. It rather provides the reader with the basic useful formulas needed to obtain our results. Anyone interested in a more detailed discussion about the topic can refer to [22, 31, 41, 42].

Let us start by considering a function  $f(\mathbf{n})$  with spin s. We define the spin raising and lowering operators respectively as

$$\partial f(\mathbf{n}) \equiv -\sin^{s}\theta \left[ \partial_{\theta} + \frac{i}{\sin\theta} \partial_{\phi} \right] \left[ \sin^{-s}\theta f(\mathbf{n}) \right] = -\left( \partial_{\theta} + \frac{i}{\sin\theta} \partial_{\phi} \right) f(\mathbf{n}) + s \cot\theta f(\mathbf{n})$$

$$\overline{\partial} f(\mathbf{n}) \equiv -\sin^{-s}\theta \left[ \partial_{\theta} - \frac{i}{\sin\theta} \partial_{\phi} \right] \left[ \sin^{s}\theta f(\mathbf{n}) \right] = -\left( \partial_{\theta} - \frac{i}{\sin\theta} \partial_{\phi} \right) f(\mathbf{n}) - s \cot\theta f(\mathbf{n}).$$
(E.1)

Here  $(\theta, \phi)$  are the usual polar angles of the direction **n**. The effect of the operator  $\partial (\overline{\partial})$  on the function f is to raise (lower) its spin, such that  $\partial f(\overline{\partial}f)$  has spin s+1 (s-1). For a spin zero function  $\overline{\partial}f=0$ . In this way, the spin-weighted spherical harmonics  ${}_sY_{\ell m}$  are obtained from the spin zero spherical harmonics  $Y_{\ell m}$  by acting with  $\partial$  and  $\overline{\partial}$  respectively

$${}_{s}Y_{\ell m}(\mathbf{n}; \mathbf{E}) = \sqrt{\frac{(\ell - |s|)!}{(\ell + |s|)!}} \begin{cases} \partial^{s}Y_{\ell m}(\mathbf{n}; \mathbf{E}) &, \quad s \ge 0 \\ (-1)^{s} \overline{\partial}^{|s|} Y_{\ell m}(\mathbf{n}; \mathbf{E}) &, \quad s < 0. \end{cases}$$
(E.2)

The prefactor is needed to ensure that they remain normalized, i.e.

$$\int d\Omega_{\mathbf{n}} \, {}_{s}Y_{\ell m}(\mathbf{n}; \mathbf{E}) \, {}_{s}Y_{\ell'm'}^{*}(\mathbf{n}; \mathbf{E}) = \delta_{\ell\ell'}\delta_{mm'} \,. \tag{E.3}$$

Our notation is such that the pair  $(\mathbf{n}; \mathbf{E})$  indicates that the angles of the direction  $\mathbf{n}$  are taken with respect to the reference frame where  $\mathbf{E}$  is the z-direction. Hence, the angular derivatives in the definition of the spin operators and the dependence on  $\mathbf{n}$  in Eq.  $(\mathbf{E}.1)$  are referring to the same basis.

With the use of Eq. (3.8), we can write Eqs. (E.1) as

$$\partial f(\mathbf{n}) = \left(-\sqrt{2}\,\hat{s}_{+}^{a}\partial_{a} + s\cot\theta\right)f(\mathbf{n}) = -\sqrt{2}\,\partial_{+}f(\mathbf{n})\,,$$

$$\overline{\partial} f(\mathbf{n}) = \left(-\sqrt{2}\,\hat{s}_{-}^{a}\partial_{a} - s\cot\theta\right)f(\mathbf{n}) = -\sqrt{2}\,\partial_{-}f(\mathbf{n})\,,$$
(E.4)

where  $\partial_{\pm} \equiv \hat{s}_{\pm}^a \partial_a \mp s \frac{\cot \theta}{\sqrt{2}}$ . A useful relation for us, concerning the derivatives of basis, is (see [22])

$$\sqrt{2} r e_+^i \partial_i e_+^j = \cot \theta e_+^j. \tag{E.5}$$

This relation can be rewritten in terms of our basis  $\hat{s}_{\pm}^{a}$ , again by making use of Eq. (3.8), as follows

$$\hat{s}_{\pm}^a \nabla_a \hat{s}_{\pm}^c = \frac{\cot \theta}{\sqrt{2}} \, \hat{s}_{\pm}^c \,. \tag{E.6}$$

As a final remark, we note that Eq. (E.6) allows us to explicitly deal with double projections on  $\hat{s}^a_{\pm}$  in Eq. (3.11). Indeed, for a generic scalar field  $A(\mathbf{n})$ , we have that

$$\hat{s}_{+}^{a} \hat{s}_{+}^{b} \nabla_{a} \partial_{b} A(\mathbf{n}) = \hat{s}_{+}^{a} \partial_{a} \left( \hat{s}_{+}^{b} \partial_{b} A(\mathbf{n}) \right) - \hat{s}_{+}^{a} \nabla_{a} \left( \hat{s}_{+}^{b} \right) \partial_{b} A(\mathbf{n}) 
= -\frac{1}{\sqrt{2}} \hat{s}_{+}^{a} \partial_{a} \partial A(\mathbf{n}) - \frac{\cot \theta}{\sqrt{2}} \hat{s}_{+}^{c} \partial_{c} A(\mathbf{n}) 
= -\frac{1}{\sqrt{2}} \hat{s}_{+}^{a} \partial_{a} \partial A(\mathbf{n}) + \frac{\cot \theta}{2} \partial A(\mathbf{n}) = \frac{1}{2} \partial^{2} A(\mathbf{n}), \qquad (E.7)$$

and the same derivation holds also for  $\hat{s}_{-}^{a}\hat{s}_{-}^{b}\nabla_{a}\partial_{b}A(\mathbf{n}) = \frac{1}{2}\overline{\partial}^{2}A(\mathbf{n})$ .
