## A Reply to "On Salum's Algorithm for X3SAT"

## Abstract

This paper gives a reply to "On Salum's Algorithm for X3SAT" [1].

The authors confuse the definition of the scope  $\psi(r_i)$ , beyond the scope  $\phi'(r_i)$ , and the formula  $\varphi = \psi \land \phi$ . Also, they claim that "it is easy to see that X3SAT formulas with empty minterms are equivalent to 3CNF formulas (by simply replacing the  $\odot$  notational element with  $\lor$ )". I did not understand what the authors meant here. The formula  $(a \odot b \odot c) \land (b \odot x \odot y) \land (c \odot x \odot \overline{y})$  is totally different from the formula  $(a \lor b \lor c) \land (b \lor x \lor y) \land (c \lor x \lor \overline{y})$ .

In particular, the authors find  $\phi = (a \wedge b \wedge \overline{c}) \wedge (x \odot y) \wedge (x \odot \overline{y})$ , after Scope  $(a, \phi)$  runs. They next run Scope  $(\overline{a}, \phi)$  over  $\phi$ , and detect the conflict with a already in the minterm. The authors also run Scope  $(x, \phi)$  over  $\phi$ , and find  $\phi = (a \wedge \overline{b} \wedge \overline{c} \wedge x \wedge \overline{y} \wedge y)$ . These are totally wrong.

The correct way of the executions is as follows.

 $\varphi = \psi \land \phi$ .  $\psi$  is empty and  $\phi = (a \odot b \odot c) \land (b \odot x \odot y) \land (c \odot x \odot \overline{y})$ .

Scope  $(a, \phi)$ :  $\phi(a) := a \land \phi$ . Then,  $\phi(a) = \psi(a) \land \phi'(a)$ , as Scope  $(a, \phi)$  terminates.  $\psi(a) = a \land \overline{b} \land \overline{c}$  and  $\phi'(a) = (x \odot y) \land (x \odot \overline{y})$ .

Scope  $(\overline{a}, \phi)$ :  $\phi(\overline{a}) := \overline{a} \land \phi$ .  $\phi(\overline{a}) = \psi(\overline{a}) \land \phi'(\overline{a})$ .  $\psi(\overline{a}) = \overline{a}$  and  $\phi'(\overline{a}) = (b \odot c) \land (b \odot x \odot y) \land (c \odot x \odot \overline{y})$ .

Scope  $(x, \phi)$ :  $\phi(x) := x \land \phi$ .  $\psi(x) \Rightarrow \overline{b} \land x \land \overline{y} \land \overline{c} \land y$ . Thus, x is incompatible, because  $\psi(x) \Rightarrow \overline{y} \land y$ . As a result,  $\overline{x}$  is necessary. That is,  $\varphi \leftarrow \overline{x} \land \phi$ .

 $\varphi = \psi \land \phi$ , where  $\psi = \overline{x}$  and  $\phi = (a \odot b \odot c) \land (b \odot y) \land (c \odot \overline{y})$ .

Scope  $(a, \phi)$ :  $\phi(a) := a \land \phi$ .  $\psi(a) \Rightarrow a \land \overline{b} \land \overline{c} \land y \land \overline{y}$ . Thus,  $\overline{a}$  is necessary.  $\varphi \leftarrow \psi \land \phi$ , where  $\psi = \overline{x} \land \overline{a}$  and  $\phi = (b \odot c) \land (b \odot y) \land (c \odot \overline{y})$ .

Scope  $(\underline{b}, \phi)$ :  $\phi(\underline{b}) := \underline{b} \land \phi$ .  $\psi(\underline{b}) = \underline{b} \land \overline{c} \land \overline{y}$  and  $\phi'(\underline{b})$  is empty.

Scope  $(b, \phi)$ :  $\phi(b) := b \land \phi$ .  $\psi(b) = b \land c \land y$  and  $\phi'(b)$  is empty.

Likewise,  $c, \overline{c}, y, \overline{y}$  are decided to be compatible. Then, the current formula becomes  $\varphi = \overline{x} \wedge \overline{a} \wedge (b \odot c) \wedge (b \odot y) \wedge (c \odot \overline{y})$ , which is satisfiable. Note that  $\overline{x} \wedge \overline{a}$  is fixed in any satisfying assignment. Next, a satisfying assignment is constructed over  $\phi = (b \odot c) \wedge (b \odot y) \wedge (c \odot \overline{y})$ . See also the final version [2].
