Asymptotic normality in linear regression with approximately sparse structure

Abstract

In this paper we study the asymptotic normality in high-dimensional linear regression. We focus on the case where the covariance matrix of the regression variables has a KMS structure, in asymptotic settings where the number of predictors, p, is proportional to the number of observations, n. The main result of the paper is the derivation of the exact asymptotic distribution for the suitably centered and normalized squared norm of the product between predictor matrix, \mathbb{X} , and outcome variable, Y, i.e. the statistic $\|\mathbb{X}'Y\|_2^2$. Additionally, we consider a specific case of approximate sparsity of the model parameter vector β and perform a Monte-Carlo simulation study. The simulation results suggest that the statistic approaches the limiting distribution fairly quickly even under high variable multi-correlation and relatively small number of observations, suggesting possible applications to the construction of statistical testing procedures for the real-world data and related problems.

1 Introduction

Consider a linear regression model

$$Y = \mathbb{X}\beta + \varepsilon, \tag{1.1}$$

where $Y := (y_1, \ldots, y_n)' \in \mathbb{R}^{n \times 1}$ are *n* observations of outcome and $\mathbb{X} = (X_1, \ldots, X_n)' \in \mathbb{R}^{n \times p}$ are *p*dimensional predictors with X_1, \ldots, X_n being i.i.d. $p \times 1$ random vectors $X_i = (X_{1,i}, \ldots, X_{p,i})'$, which are normally distributed with zero mean and covariance matrix Σ , denoted $X_i \stackrel{d}{=} \mathcal{N}_p(0, \Sigma)$. We assume that the covariance matrix Σ has a form

$$\Sigma = (\rho^{|i-j|})_{i,j=1}^{p} = \begin{bmatrix} 1 & \rho & \dots & \rho^{p-1} \\ \rho & 1 & \dots & \rho^{p-2} \\ \vdots & \vdots & \ddots & \vdots \\ \rho^{p-1} & \rho^{p-2} & \dots & 1 \end{bmatrix},$$
(1.2)

if $0 < |\rho| < 1$, and $\Sigma = I_p$ if $\rho = 0$ (here and below I_p denotes the $p \times p$ identity matrix). This matrix is often called the Kac–Murdock–Szegö (KMS) matrix, originally introduced in Kac et al. (1953). As the

autocorrelation matrix of corresponding causal AR(1) processes, KMS matrix is positive definite and is considered due to the wide array of applications in the literature and its' well known spectral properties (see, e.g., Fikioris (2018) for a thorough literature review). Further, $\varepsilon := (\varepsilon_1, \ldots, \varepsilon_n)' \in \mathbb{R}^{n \times 1} \stackrel{d}{=} \mathcal{N}(0, \sigma_{\varepsilon}^2 I_n)$ are unobserved i.i.d. errors with $\mathbb{E}\varepsilon_i = 0$, $\operatorname{Var}(\varepsilon_i) = \sigma_{\varepsilon}^2 > 0$, and $\beta := (\beta_1, \ldots, \beta_p)' \in \mathbb{R}^{p \times 1}$ is an unknown *p*-dimensional parameter. In practice, the assumption that $\mathbb{E}X_i = 0$ can be untenable and it may be appropriate to add an intercept to the linear model (1.1), however, for simplicity, throughout this paper we will assume that the intercept is known and the variables are centered.

This paper is concerned with the derivation of the exact asymptotic distribution for the suitably centered and normalized squared norm $\|\mathbb{X}'Y\|_2^2$ under the assumption of the KMS type covariance structure in (1.2), where p and n are assumed large. Throughout the paper we assume that $p, n \to \infty$ and $p/n \to c \in (0, \infty)$. We are particularly interested in cases where p > n. Statistics of such form arise in various applications in the context of high-dimensional linear regression, and under normality assumptions, general results can be derived using random matrix theory through Wishart distributions (see, e.g., Dicker (2014)). In our paper we approach the problem following an observation by Gaunt (2013), that the distribution of product of Gaussian random variables admits a variance-gamma distribution, resulting in a set of attractive properties. In addition to the ℓ_2 -norm statistic, we find that the obtained results can be easily extended towards alternative forms of the statistic, e.g., by using a different norm, which would reduce the problem to manipulating variancegamma distribution, thus suggesting possible further research cases and useful extensions.

Additionally, we examine a specific case of parameter β by considering $\beta_j = j^{-1}, j \ge 1$. Similar structures of the vector β are often found in the literature when approximate sparsity of the coefficients in the linear regression model (1.1) is assumed. See, e.g., Ing (2020) and Cha et al. (2021) for a broader view towards sparsity requirements and its' implications to specific high-dimensional algorithms; Shibata (1980) and Ing (2007) for model selection problems in autoregressive time series models; or Belloni et al. (2012), Javanmard and Montanari (2014), Zhang and Zhang (2014), Caner and Kock (2018), Belloni et al. (2018), Gold et al. (2020), Ning et al. (2020), Guo et al. (2021) for applications on inference of high-dimensional models and high-dimensional instrumental variable (IV) regression models. Performing Monte Carlo simulations, we find that the empirical distributions of the corresponding statistic approach the limiting distribution reasonably quickly even for large values of ρ and c, suggesting that the assumption of sparse structure can be included in the applications and statistical tests.

In this paper, $\stackrel{d}{\rightarrow}$, $\stackrel{d}{\rightarrow}$ and $\stackrel{P}{\rightarrow}$ denote the equality of distributions, convergence of distributions and convergence in probability, respectively. C stands for a generic positive constant which may assume different values at various locations. $\mathbf{1}_A$ denotes the indicator function of a set A.

The structure of the paper is as follows. In Section 2 we present the main results of the paper. In Section 3 we present useful properties of variance-gamma distribution, which are used in Section 4 in order to prove some auxiliary results. In Section 5 we present the proof of the main result. Finally, in Section 6 we provide an example of the main result under imposed approximate sparsity assumption for the parameter β of the model (1.1). Technical results are presented in Appendix A, while, for brevity, some straightforward yet tedious proofs are presented in the Supplementary material.

2 Main results

In this section we formulate the main results on the normality of statistic $\|X'Y\|_2^2$. Introduce the notations:

$$\kappa_{1,p} := \sum_{k=1}^{p} \sum_{l=1}^{p} \beta_k \beta_l \rho^{|k-l|}, \qquad (2.1)$$

$$\kappa_{2,p} := \sum_{k=1}^{p} \left(\sum_{l=1}^{p} \beta_{l} \rho^{|k-l|} \right)^{2}, \qquad (2.2)$$

$$\kappa_{3,p} := \sum_{k,l,j,j'=1}^{p} \beta_j \beta_{j'} \rho^{|k-j|} \rho^{|l-j'|} \rho^{|k-l|}.$$
(2.3)

It is easy to see that, under $\sum_{j=1}^{\infty} \beta_j^2 < \infty$, there exist limits

$$\kappa_i = \lim_{p \to \infty} \kappa_{i,p}, \ i = 1, 2, 3.$$

Obviously, $\kappa_{2,p} \geq 0$. Moreover, since $(\rho^{|i-j|})_{i,j=1}^p$ is positive semi-definite, $\kappa_{i,p} \geq 0$, i = 1, 3. Indeed, $\sum_{k,l=1}^p \rho^{|k-l|} a_k a_l \geq 0$, thus it suffices to take $a_k = \beta_k$ for i = 1 and $a_k = \sum_{j=1}^p \beta_j \rho^{|k-j|}$ for i = 3. Our first main result is the following theorem.

Theorem 2.1. Assume the model in (1.1) with covariance structure in (1.2). Let $n \to \infty$ and let $p = p_n$ satisfy

$$p \to \infty, \qquad \frac{p}{n} \to c \in (0, \infty).$$
 (2.4)

Let also the β_j satisfy

$$\sum_{j=1}^{\infty} \beta_j^2 < \infty.$$
(2.5)

Then

$$\frac{\|\mathbb{X}'Y\|_2^2 - n^2\kappa_{2,p} - pn(\kappa_{1,p} + \sigma_{\varepsilon}^2)}{n^{3/2}} \quad \stackrel{d}{\to} \quad \mathcal{N}(0,s^2), \tag{2.6}$$

where variance s^2 has the structure

$$s^{2} = 4\kappa_{2}^{2} + 4(\kappa_{1} + \sigma_{\varepsilon}^{2})(2\kappa_{2}c + \kappa_{3}) + 2c(\kappa_{1} + \sigma_{\varepsilon}^{2})^{2}\left(c + \frac{1+\rho^{2}}{1-\rho^{2}}\right).$$
(2.7)

Our second main result deals with the case where the centering sequence in (2.6) is modified to include the limiting values of $\kappa_{i,p}$, i = 1, 2.

Theorem 2.2. Let the assumptions of Theorem 2.1 hold. In addition, assume that $\sum_{j=p+1}^{\infty} \beta_j^2 = o(p^{-1/2})$ and $\sup_{j\geq 1} |\beta_j| j^{\alpha} < \infty$ with $\alpha > 1/2$. Then,

$$\frac{\|\mathbb{X}'Y\|_2^2 - n^2 \left(\kappa_2 + c(\kappa_1 + \sigma_{\varepsilon}^2)\right)}{n^{3/2}} \stackrel{d}{\to} \mathcal{N}(0, s^2).$$
(2.8)

The proofs of these theorems are given in Section 5.

REMARK 2.1. For alternative expressions of κ_1 , κ_2 and κ_3 , see Lemma 5.2 below.

Define

$$\beta(x) \quad := \quad \sum_{j=1}^{\infty} \beta_j^2 x^j, \quad |x| \le 1.$$

The following corollary deals with the case when $\rho = 0$, i.e., $\Sigma = I_p$. The result easily follows from Theorem 2.2, noting that in this case $\kappa_i = \beta(1), i = 1, 2, 3$.

Corollary 2.1. Assume a model (1.1) with covariance structure $\Sigma = I_p$. Let assumptions (2.4) and (2.5) be satisfied. In addition, assume that $\sum_{j=p+1}^{\infty} \beta_j^2 = o(p^{-1/2})$ and $\sup_{j\geq 1} |\beta_j| j^{\alpha} < \infty$ with $\alpha > 1/2$. Then,

$$\frac{\|\mathbb{X}'Y\|_2^2 - n^2(\beta(1)(1+c) + c\sigma_{\varepsilon}^2)}{n^{3/2}} \stackrel{d}{\to} \mathcal{N}(0, s^2), \tag{2.9}$$

where

$$s^{2} = 2\beta(1)^{2} (4 + 5c + c^{2}) + 4\beta(1)\sigma_{\varepsilon}^{2} (1 + 3c + c^{2}) + 2\sigma_{\varepsilon}^{4} (c + c^{2}).$$
(2.10)

3 Properties of the variance-gamma distribution

In this section we provide some properties of the variance-gamma distribution, which will be used in the following proofs.

Recall that the variance-gamma distribution with parameters $r > 0, \theta \in \mathbb{R}, \sigma > 0$ and $\mu \in \mathbb{R}$ has density

$$f^{\rm VG}(x) = \frac{1}{\sigma\sqrt{\pi}\Gamma(r/2)} e^{\theta(x-\mu)/\sigma^2} \left(\frac{|x-\mu|}{2\sqrt{\theta^2 + \sigma^2}}\right)^{(r-1)/2} K_{(r-1)/2} \left(\frac{\sqrt{\theta^2 + \sigma^2}}{\sigma^2} |x-\mu|\right),\tag{3.1}$$

where $x \in \mathbb{R}$, $K_{\nu}(x)$ is the modified Bessel function of the second kind. For a random variable Q with density (3.1) we write $Q \stackrel{d}{=} \mathrm{VG}(r, \theta, \sigma, \mu)$. Let $\Gamma(a, b), a > 0, b > 0$, denote the gamma distribution with density

$$f^{\rm G}(x) = \frac{b^a}{\Gamma(a)} x^{a-1} e^{-bx}, \ x > 0.$$

It holds that

$$Q \stackrel{d}{=} \mu + \theta W_r + \sigma \sqrt{W_r} U, \tag{3.2}$$

where $W_r \stackrel{d}{=} \Gamma(r/2, 1/2)$, $U \stackrel{d}{=} \mathcal{N}(0, 1)$, W_r and U are independent. The characteristic function of $Q \stackrel{d}{=} VG(r, \theta, \sigma, \mu)$ has a form (see, e.g., Madan et al. (1998), Kotz et al. (2001))

$$\varphi_Q(t) = \frac{\mathrm{e}^{\mathrm{i}\mu t}}{(1 + \sigma^2 t - 2\mathrm{i}\theta t)^{r/2}}, \quad t \in \mathbb{R}.$$
(3.3)

We note the following properties of the variance-gamma distribution.

(i) If $Q_1 \stackrel{d}{=} \text{VG}(r_1, \theta, \sigma, \mu_1)$ and $Q_2 \stackrel{d}{=} \text{VG}(r_2, \theta, \sigma, \mu_2)$ are independent random variables then

 $Q_1 + Q_2 \stackrel{d}{=} \operatorname{VG}(r_1 + r_2, \theta, \sigma, \mu_1 + \mu_2).$

(ii) If $Q \stackrel{d}{=} VG(r, \theta, \sigma, \mu)$, then for any a > 0

$$aQ \stackrel{a}{=} \operatorname{VG}(r, a\theta, a\sigma, a\mu).$$

The following proposition is crucial for our purposes.

Proposition 3.1. (i) If $(\xi_1, \xi_2)' \stackrel{d}{=} \mathcal{N}(0, \Sigma)$, where $\Sigma = \begin{pmatrix} \sigma_1^2 & \rho \sigma_1 \sigma_2 \\ \rho \sigma_1 \sigma_2 & \sigma_2^2 \end{pmatrix}$, then

 $\xi_1 \xi_2 \stackrel{d}{=} \operatorname{VG}(1, \rho \sigma_1 \sigma_2, \sqrt{1 - \rho^2} \sigma_1 \sigma_2, 0).$

(ii) If $(\xi_{1j}, \xi_{2j})'$, j = 1, ..., n are *i.i.d.* random vectors with common distribution $\mathcal{N}(0, \Sigma)$, then

$$\sum_{j=1}^{n} \xi_{1j} \xi_{2j} \stackrel{d}{=} \operatorname{VG}(n, \rho \sigma_1 \sigma_2, \sqrt{1 - \rho^2} \sigma_1 \sigma_2, 0)$$

and

$$\sum_{j=1}^n \xi_{1j}\xi_{2j} \stackrel{d}{=} \sigma_1\sigma_2(\rho W_n + \sqrt{1-\rho^2}\sqrt{W_n}U),$$

where $W_n \stackrel{d}{=} \Gamma(n/2, 1/2)$ and $U \stackrel{d}{=} \mathcal{N}(0, 1)$ are independent random variables. (iii) Assume that $(\xi_{1j}^{(1)}, \dots, \xi_{1j}^{(p)}, \xi_{2j})'$, $j = 1, \dots, n$, are *i.i.d.* copies of $(\xi_1^{(1)}, \dots, \xi_1^{(p)}, \xi_2)' \stackrel{d}{=} \mathcal{N}(0, \Sigma^{(p)})$ and let $\rho^{(kl)} := \operatorname{Corr}(\xi_1^{(k)}, \xi_1^{(l)})$, $\rho^{(k)} := \operatorname{Corr}(\xi_1^{(k)}, \xi_2)$, $(\sigma_1^{(k)})^2 := \operatorname{Var}(\xi_1^{(k)})$, $\sigma_2^2 := \operatorname{Var}(\xi_2)$, $k, l = 1, \dots, p$. Then

$$\begin{pmatrix} \sum_{j=1}^{n} \xi_{1j}^{(1)} \xi_{2j} \\ \vdots \\ \sum_{j=1}^{n} \xi_{1j}^{(p)} \xi_{2j} \end{pmatrix} \stackrel{d}{=} \begin{pmatrix} \sigma_{1}^{(1)} \sigma_{2} (\rho^{(1)} W_{n} + \sqrt{1 - (\rho^{(1)})^{2}} \sqrt{W_{n}} U_{1}) \\ \vdots \\ \sigma_{1}^{(p)} \sigma_{2} (\rho^{(p)} W_{n} + \sqrt{1 - (\rho^{(p)})^{2}} \sqrt{W_{n}} U_{p}) \end{pmatrix}$$

where $(U_1, \ldots, U_p)' \stackrel{d}{=} \mathcal{N}(0, \Sigma_U), \ \Sigma_U = (\sigma_U^{(kl)})$ with

$$\sigma_U^{(k,l)} = \mathbb{E}U_k U_l = \frac{\rho^{(kl)} - \rho^{(k)} \rho^{(l)}}{\sqrt{1 - (\rho^{(k)})^2} \sqrt{1 - (\rho^{(l)})^2}}, \quad k, l = 1, \dots, p.$$
(3.4)

Proof. The statements in (i), (ii) are well-known, see e.g. Gaunt (2019). The proof of part (iii) follows from Lemma 3.1. $\hfill \Box$

Lemma 3.1. Assume that $(\xi_1^{(1)}, \ldots, \xi_1^{(p)}, \xi_2)'$ has distribution $\mathcal{N}(0, \Sigma^{(p)})$ and let $\rho^{(kl)} := \operatorname{Corr}(\xi_1^{(k)}, \xi_1^{(l)}), \rho^{(k)} := \operatorname{Corr}(\xi_1^{(k)}, \xi_2), (\sigma_1^{(k)})^2 := \operatorname{Var}(\xi_1^{(k)}), \sigma_2^2 := \operatorname{Var}(\xi_2), k, l = 1, \ldots, p.$ Then

$$\begin{pmatrix} \xi_1^{(1)}\xi_2 \\ \vdots \\ \xi_1^{(p)}\xi_2 \end{pmatrix} \stackrel{d}{=} \begin{pmatrix} \sigma_1^{(1)}\sigma_2(\rho^{(1)}W_1 + \sqrt{1 - (\rho^{(1)})^2}\sqrt{W_1}U_1) \\ \vdots \\ \sigma_1^{(p)}\sigma_2(\rho^{(p)}W_1 + \sqrt{1 - (\rho^{(p)})^2}\sqrt{W_1}U_p) \end{pmatrix},$$

where $W_1 \stackrel{d}{=} \Gamma(1/2, 1/2)$, $(U_1, \ldots, U_p)'$ is, independent of W_1 , zero mean normal vector with covariances in (3.4).

PROOF. It suffices to prove that for any $(t_1, \ldots, t_p) \in \mathbb{R}^p$ it holds

$$\left(\sum_{k=1}^{p} t_k \xi_1^{(k)}\right) \xi_2 \stackrel{d}{=} \sigma_2 \sum_{k=1}^{p} t_k \sigma_1^{(k)} \left(\rho^{(k)} W_1 + \sqrt{1 - (\rho^{(k)})^2} \sqrt{W_1} U_k\right).$$

Since

$$\sum_{k=1}^{p} t_k \xi_1^{(k)} \stackrel{d}{=} \mathcal{N}\Big(0, \sum_{k,l=1}^{p} t_k t_l \rho^{(kl)} \sigma_1^{(k)} \sigma_1^{(l)}\Big), \quad \xi_2 \stackrel{d}{=} \mathcal{N}(0, \sigma_2^2),$$

by Proposition 3.1(i) we obtain that

$$\left(\sum_{k=1}^{p} t_k \xi_1^{(k)}\right) \xi_2 \stackrel{d}{=} \operatorname{VG}\left(1, \sigma_2 \sum_{k=1}^{p} t_k \rho^{(k)} \sigma_1^{(k)}, \sigma_2 \sqrt{\sum_{k,l=1}^{p} t_k t_l \sigma_1^{(k)} \sigma_1^{(l)} (\rho^{(kl)} - \rho^{(k)} \rho^{(l)})}, 0\right).$$
(3.6)

For the right-hand side of (3.5) write

$$\sigma_{2} \sum_{k=1}^{p} t_{k} \sigma_{1}^{(k)} \left(\rho^{(k)} W_{1} + \sqrt{1 - (\rho^{(k)})^{2}} \sqrt{W_{1}} U_{k} \right)$$

= $\left(\sigma_{2} \sum_{k=1}^{p} t_{k} \sigma_{1}^{(k)} \rho^{(k)} \right) W_{1} + \left(\sigma_{2} \sum_{k=1}^{p} t_{k} \sigma_{1}^{(k)} \sqrt{1 - (\rho^{(k)})^{2}} U_{k} \right) \sqrt{W_{1}}$

Here, by (3.4),

$$\begin{aligned} \sigma_2 \sum_{k=1}^p t_k \sigma_1^{(k)} \sqrt{1 - (\rho^{(k)})^2} U_k & \stackrel{d}{=} & \sigma_2 \bigg(\sum_{k,l=1}^p t_k t_l \sigma_1^{(k)} \sigma_1^{(l)} \sqrt{1 - (\rho^{(k)})^2} \sqrt{1 - (\rho^{(l)})^2} \mathbb{E}(U_k U_l) \bigg)^{1/2} U_1 \\ & = & \sigma_2 \bigg(\sum_{k,l=1}^p t_k t_l \sigma_1^{(k)} \sigma_1^{(l)} (\rho^{(kl)} - \rho^{(k)} \rho^{(l)}) \bigg)^{1/2} U_1. \end{aligned}$$

Note that $U_1 \stackrel{d}{=} \mathcal{N}(0, 1)$. So that,

$$\sigma_{2} \sum_{k=1}^{p} t_{k} \sigma_{1}^{(k)} \left(\rho^{(k)} W_{1} + \sqrt{1 - (\rho^{(k)})^{2}} \sqrt{W_{1}} U_{k} \right)$$

$$\stackrel{d}{=} \left(\sigma_{2} \sum_{k=1}^{p} t_{k} \sigma_{1}^{(k)} \rho^{(k)} \right) W_{1} + \sigma_{2} \left(\sum_{k,l=1}^{p} t_{k} t_{l} \sigma_{1}^{(k)} \sigma_{1}^{(l)} \left(\rho^{(kl)} - \rho^{(k)} \rho^{(l)} \right) \right)^{1/2} \sqrt{W_{1}} U_{1},$$

which, by representation (3.2), has the same VG distribution as that in (3.6). This proves (3.5).

4 Some auxiliary lemmas

In this section we establish some auxiliary results that will be used in the proofs of Theorems 2.1 and 2.2. Here and throughout the paper we remove the upper indices when working with triangular schemes of random variables, e.g., $(V_1, \ldots, V_p) \equiv (V_1^{(p)}, \ldots, V_p^{(p)})$, whenever it is clear from the context.

Lemma 4.1. Let $V = (V_1, \ldots, V_p)' \stackrel{d}{=} \mathcal{N}_p(0, \Sigma_V^{(p)})$, where $\Sigma_V^{(p)}$ is positive definite covariance matrix and $\operatorname{tr}((\Sigma_V^{(p)})^2) = o(p^2), p \to \infty$. Then

$$\frac{1}{p}\sum_{k=1}^{p} \left(V_k^2 - \mathbb{E}V_k^2\right) \xrightarrow{P} 0 \quad as \quad p \to \infty.$$

$$\tag{4.1}$$

If, in addition, $p^{-1}\operatorname{tr}(\Sigma_V^{(p)}) \to 1$, then

$$\frac{1}{p} \sum_{k=1}^{p} V_k^2 \xrightarrow{P} 1 \quad as \quad p \to \infty.$$

$$(4.2)$$

Proof. Due to the Spectral Theorem, we have

$$V'V = \sum_{k=1}^{p} V_k^2 \stackrel{d}{=} \sum_{j=1}^{p} \lambda_j^{(p)} \tilde{Z}_j^2, \qquad (4.3)$$

where \tilde{Z}_j are i.i.d. standard normal variables and $\lambda_1^{(p)}, \ldots, \lambda_p^{(p)}$ are the eigenvalues of $\Sigma_V^{(p)}$. Observe from (4.3) that

$$\mathbb{E}V'V = \sum_{j=1}^{p} \lambda_{j}^{(p)} = \operatorname{tr}(\Sigma_{V}^{(p)}), \qquad (4.4)$$

$$\operatorname{Var}(V'V) = \operatorname{Var}\left(\sum_{j=1}^{p} \lambda_{j}^{(p)} \tilde{Z}_{j}^{2}\right) = 2\sum_{j=1}^{p} (\lambda_{j}^{(p)})^{2} = 2\operatorname{tr}((\Sigma_{V}^{(p)})^{2}).$$
(4.5)

Thus, by (4.4)–(4.5), for any $\epsilon > 0$

$$\mathbb{P}\Big(\Big|\frac{1}{p}\big(V'V - \mathbb{E}V'V\big)\Big| > \epsilon\Big) \quad \leq \quad \frac{\operatorname{Var}(V'V)}{p^2\epsilon^2} \ \to \ 0, \ \ p \to \infty,$$

and the relation in (4.1) follows due to assumption $\operatorname{tr}((\Sigma_V^{(p)})^2) = o(p^2)$. Finally, if $p^{-1}\operatorname{tr}(\Sigma_V^{(p)}) \to 1$, by (4.4), the result (4.1) leads to (4.2).

REMARK 4.1. The assumption on matrix $\Sigma_V = \Sigma_V^{(p)}$ in Lemma 4.1, requiring that $\operatorname{tr}(\Sigma_V^2) = o(p^2)$, is not overly restrictive: assume, for example, that $\Sigma_V = (\sigma^{(i,j)})$ is any KMS type covariance matrix, as in (1.2). Then it is straightforward to see that

$$\operatorname{tr}(\Sigma_V^2) = \sum_{i,j=1}^p (\sigma^{(i,j)})^2 = \sum_{i,j=1}^p \rho^{2|i-j|}$$
$$= \sum_{|m| < p} (p - |m|) \rho^{2|m|} \le p \sum_{|m| < p} |m| \rho^{2|m|} = \mathcal{O}(p)$$

Lemma 4.2. Assume that $\tilde{Z}_1, \tilde{Z}_2, \ldots$ are *i.i.d.* $\mathcal{N}(0, 1)$ random variables. For any $p \in \mathbb{N}$ define

$$\zeta_j^{(p)} := \nu_j^{(p)}(\tilde{Z}_j^2 - 1) + \gamma_j^{(p)}\sqrt{p}\tilde{Z}_j, \quad j = 1, \dots, p,$$
(4.6)

where $\nu_j^{(p)}$, j = 1, ..., p, are positive scalars, and $\gamma_j^{(p)}$, j = 1, ..., p, are real scalars, such that

$$\sum_{j=1}^{p} (\nu_j^{(p)})^3 = o\left(\left(\sum_{j=1}^{p} \operatorname{Var}(\zeta_j^{(p)})\right)^{3/2}\right), \tag{4.7}$$

$$p\sum_{j=1}^{p} (\gamma_j^{(p)})^2 \nu_j^{(p)} = o\left(\left(\sum_{j=1}^{p} \operatorname{Var}(\zeta_j^{(p)})\right)^{3/2}\right)$$
(4.8)

with $\operatorname{Var}(\zeta_j^{(p)}) = 2(\nu_j^{(p)})^2 + p(\gamma_j^{(p)})^2$. Then, as $p \to \infty$,

$$\frac{\sum_{j=1}^{p} \zeta_{j}^{(p)}}{\sqrt{\sum_{j=1}^{p} \operatorname{Var}(\zeta_{j}^{(p)})}} \stackrel{d}{\to} \mathcal{N}(0,1).$$

$$(4.9)$$

Proof. The proof uses the method of cumulants and is structured as follows:

(i) we establish the moment-generating function of $\zeta_j^{(p)}$, $M_{\zeta_j^{(p)}}(t) := \mathbb{E}e^{t\zeta_j^{(p)}}$, and $\log\left(M_{\zeta_j^{(p)}}(t)\right)$;

- (ii) we find G(t;p) which corresponds to the cumulant generating function of the sum $\sum_{j=1}^{p} \zeta_{j}^{(p)}$;
- (iii) we find $K(t;p) := G\left(\frac{t}{\sqrt{\sum_{j=1}^{p} (2(\nu_{j}^{(p)})^{2} + p(\gamma_{j}^{(p)})^{2})}}; p\right)$, which corresponds to the cumulant generating function of the left hand side of (4.9);
- (iv) finally, in order to prove (4.9), we show that the cumulants $\varkappa_j^{(p)}$, generated by K(t;p), satisfy $\varkappa_1^{(p)} = 0$, $\varkappa_2^{(p)} = 1$ and $\varkappa_d^{(p)} \to 0$, $d = 3, 4, \ldots$, as $p \to \infty$.

Step 1. First, rewrite

$$\zeta_{j}^{(p)} = \nu_{j}^{(p)} \left(\tilde{Z}_{j} + \frac{\gamma_{j}^{(p)} \sqrt{p}}{2\nu_{j}^{(p)}} \right)^{2} - \nu_{j}^{(p)} - \frac{(\gamma_{j}^{(p)})^{2} p}{4\nu_{j}^{(p)}}.$$
(4.10)

Here, $\psi_j^{(p)} := \left(\tilde{Z}_j + \frac{\gamma_j^{(p)}\sqrt{p}}{2\nu_j^{(p)}}\right)^2$ has a noncentral chi-squared distribution with the following moment-generating function:

$$M_{\psi_j^{(p)}}(t) := \mathbb{E}e^{t\psi_j^{(p)}} = (1-2t)^{-1/2} \exp\left\{\left(\frac{\gamma_j^{(p)}}{2\nu_j^{(p)}}\right)^2 tp(1-2t)^{-1}\right\}, \quad |t| < \frac{1}{2}.$$
(4.11)

Therefore, by (4.10) and (4.11),

$$\begin{split} M_{\zeta_{j}^{(p)}}(t) &= M_{\psi_{j}^{(p)}}(\nu_{j}^{(p)}t) \exp\left\{-t\nu_{j}^{(p)}-tp\left(\frac{\gamma_{j}^{(p)}}{2\nu_{j}^{(p)}}\right)^{2}\right\} \\ &= \left(1-2\nu_{j}^{(p)}t\right)^{-\frac{1}{2}} \exp\left\{\frac{(\gamma_{j}^{(p)})^{2}}{4\nu_{j}^{(p)}}tp\left(1-2\nu_{j}^{(p)}t\right)^{-1}-t\left(\nu_{j}^{(p)}+\frac{(\gamma_{j}^{(p)})^{2}p}{4\nu_{j}^{(p)}}\right)\right\}, \end{split}$$

for $|t| < (2\nu_j^{(p)})^{-1}$, and

$$\begin{split} \log\left(M_{\zeta_{j}^{(p)}}(t)\right) &= \left(\frac{\gamma_{j}^{(p)}}{2\nu_{j}^{(p)}}\right)^{2} p t \nu_{j}^{(p)} \left(1 - 2\nu_{j}^{(p)}t\right)^{-1} - \frac{1}{2} \log\left(1 - 2\nu_{j}^{(p)}t\right) - t \left(\nu_{j}^{(p)} + \frac{(\gamma_{j}^{(p)})^{2}p}{4\nu_{j}^{(p)}}\right) \\ &= \frac{1}{2} \left((\gamma_{j}^{(p)})^{2}p + 2(\nu_{j}^{(p)})^{2}\right) t^{2} + \frac{(\gamma_{j}^{(p)})^{2}p}{2} \sum_{k=3}^{\infty} t^{k} 2^{k-2} (\nu_{j}^{(p)})^{k-2} + \frac{1}{2} \sum_{k=3}^{\infty} \frac{2^{k} (\nu_{j}^{(p)})^{k} t^{k}}{k} \end{split}$$

Step 2. Since $\zeta_1^{(p)}, \ldots, \zeta_j^{(p)}$ are independent, we have that

$$\begin{aligned} G(t;p) &= \sum_{j=1}^{p} \log M_{\zeta_{j}^{(p)}}(t) &= \frac{t^{2}}{2} \sum_{j=1}^{p} \left((\gamma_{j}^{(p)})^{2} p + 2(\nu_{j}^{(p)})^{2} \right) \\ &+ \frac{p}{2} \sum_{k=3}^{\infty} 2^{k-2} t^{k} \sum_{j=1}^{p} (\gamma_{j}^{(p)})^{2} (\nu_{j}^{(p)})^{k-2} &+ \frac{1}{2} \sum_{k=3}^{\infty} \frac{2^{k}}{k} t^{k} \sum_{j=1}^{p} (\nu_{j}^{(p)})^{k}. \end{aligned}$$

Step 3. It is straightforward to see that

$$\begin{split} K(t;p) &= G\left(\frac{t}{\sqrt{\sum_{j=1}^{p}\left(2(\nu_{j}^{(p)})^{2}+p(\gamma_{j}^{(p)})^{2}\right)}};p\right) \\ &= \frac{t^{2}}{2} + \frac{1}{2}\sum_{k=3}^{\infty}2^{k-2}t^{k}\frac{p\sum_{j=1}^{p}(\gamma_{j}^{(p)})^{2}(\nu_{j}^{(p)})^{k-2}}{\left(\sum_{j=1}^{p}(2(\nu_{j}^{(p)})^{2}+(\gamma_{j}^{(p)})^{2}p)\right)^{k/2}} \\ &+ \frac{1}{2}\sum_{k=3}^{\infty}\frac{2^{k}}{k}t^{k}\frac{\sum_{j=1}^{p}(\nu_{j}^{(p)})^{k}}{\left(\sum_{j=1}^{p}(2(\nu_{j}^{(p)})^{2}+(\gamma_{j}^{(p)})^{2}p)\right)^{k/2}} = \sum_{k=1}^{\infty}\varkappa_{k}^{(p)}\frac{t^{k}}{k!}, \end{split}$$

where $\varkappa_{1}^{(p)} = 0, \ \varkappa_{2}^{(p)} = 1$, and for $k \ge 3$,

$$\varkappa_{k}^{(p)} = \frac{k! 2^{k-3} p \sum_{j=1}^{p} (\gamma_{j}^{(p)})^{2} (\nu_{j}^{(p)})^{k-2} + (k-1)! 2^{k-1} \sum_{j=1}^{p} (\nu_{j}^{(p)})^{k}}{\left(\sum_{j=1}^{p} (2(\nu_{j}^{(p)})^{2} + (\gamma_{j}^{(p)})^{2} p)\right)^{k/2}}.$$
(4.12)

Step 4. In order to prove that (4.9) holds, it remains to show that, as $p \to \infty$, $\varkappa_d^{(p)} \to 0$ for all $d \ge 3$. By (4.12), it is equivalent to showing that for any fixed $k \ge 3$, as $p \to \infty$,

$$\frac{\sum_{j=1}^{p} (\nu_{j}^{(p)})^{k}}{\left(\sum_{j=1}^{p} \left(2(\nu_{j}^{(p)})^{2} + (\gamma_{j}^{(p)})^{2}p\right)\right)^{k/2}} \to 0,$$

$$(4.13)$$

$$\frac{p \sum_{j=1}^{p} (\gamma_{j}^{(p)})^{2} (\nu_{j}^{(p)})^{k-2}}{\left(\sum_{j=1}^{p} \left(2(\nu_{j}^{(p)})^{2} + (\gamma_{j}^{(p)})^{2}p\right)\right)^{k/2}} \to 0.$$
(4.14)

In order to prove (4.13) we use induction. The case for k = 3 holds by assumption. Assuming that (4.13) holds for fixed $k \geq 3$, we have

$$\frac{\sum_{j=1}^{p} (\nu_{j}^{(p)})^{k+1}}{\left(\sum_{j=1}^{p} \left(2(\nu_{j}^{(p)})^{2} + (\gamma_{j}^{(p)})^{2}p\right)\right)^{(k+1)/2}} \leq \frac{\left(\sum_{j=1}^{p} \left(2(\nu_{j}^{(p)})^{2} + (\gamma_{j}^{(p)})^{2}p\right)\right)^{(k+1)/2}}{\left(\sum_{j=1}^{p} \left(2(\nu_{j}^{(p)})^{2} + (\gamma_{j}^{(p)})^{2}p\right)\right)^{1/2} \sum_{j=1}^{p} (\nu_{j}^{(p)})^{k}}}{\left(\sum_{j=1}^{p} \left(2(\nu_{j}^{(p)})^{2} + (\gamma_{j}^{(p)})^{2}p\right)\right)^{(k+1)/2}}\right)} = \frac{\sum_{j=1}^{p} (\nu_{j}^{(p)})^{k}}{\left(\sum_{j=1}^{p} \left(2(\nu_{j}^{(p)})^{2} + (\gamma_{j}^{(p)})^{2}p\right)\right)^{(k+1)/2}} \to 0,$$

concluding that (4.13) holds for all $k \geq 3$. The proof for (4.14) is analogous: the case for k = 3 holds by assumption, thus, we repeat the same arguments as with (4.13) and conclude that (4.14) holds for all $k \geq 3$. This concludes the proof of the lemma.

5 Proof of the main results

In this section we give the proofs of theorems 2.1 and 2.2. Throughout the proofs, we express corresponding constants in terms of $\kappa_{i,p}$ and κ_i , i = 1, 2, 3, introduced in (2.1)–(2.3). Recall that $\kappa_{i,p} \geq 0$, and, by Remark 5.1, $\kappa_i < \infty$, for i = 1, 2, 3.

Proof of Theorem 2.1. Write

$$\|\mathbb{X}'Y\|_2^2 = H_1^2 + \dots + H_p^2 =: H,$$

where

$$H_k := \sum_{j=1}^n X_{k,j} \left(\sum_{l=1}^p \beta_l X_{l,j} + \varepsilon_j \right), \quad k = 1, \dots, p.$$

Denote $Z_j := \sum_{l=1}^p \beta_l X_{l,j} + \varepsilon_j$, $j = 1, \dots, n$. By covariance structure (1.2) and $X_{k,j} \stackrel{d}{=} \mathcal{N}(0,1)$, $\varepsilon_j \stackrel{d}{=} \mathcal{N}(0,\sigma_{\varepsilon}^2)$,

we have $Z_j \stackrel{d}{=} \mathcal{N}(0, \sigma_Z^2)$, where $\sigma_Z^2 = \sum_{l,l'=1}^p \beta_l \beta_{l'} \rho^{|l-l'|} + \sigma_{\varepsilon}^2$ and $\operatorname{Cov}(X_{k,j}, Z_j) = \sum_{l=1}^p \beta_l \rho^{|k-l|}$. Applying Proposition 3.1(iii) with $\xi_{1j}^{(k)} = X_{k,j}$, $\xi_{2j} = Z_j$, and $\sigma_1^{(k)} = 1$, $\sigma_{2,p} = \sigma_Z$, $\theta_k^{(p)} := \rho^{(k)} = \sigma_Z^{-1} \sum_{l=1}^p \beta_l \rho^{|k-l|}$, where $\rho^{(kl)} = \rho^{|k-l|}$, we obtain that

$$\|\mathbb{X}'Y\|_{2}^{2} \stackrel{d}{=} \sigma_{2,p}^{2} \sum_{k=1}^{p} \left(\theta_{k}^{(p)}W_{n} + \sqrt{1 - (\theta_{k}^{(p)})^{2}}\sqrt{W_{n}}U_{k}\right)^{2},$$

where $W_n \stackrel{d}{=} \Gamma(n/2, 1/2)$ and $(U_1, \dots, U_p)' \stackrel{d}{=} \mathcal{N}(0, \Sigma_U^{(p)})$ with $\Sigma_U^{(p)} = (\sigma_U^{(k,l)})$ defined as (see (3.4)):

$$\sigma_U^{(k,l)} = \frac{\rho^{|k-l|} - \theta_k^{(p)} \theta_l^{(p)}}{\sqrt{1 - (\theta_k^{(p)})^2} \sqrt{1 - (\theta_l^{(p)})^2}}, \quad k, l = 1, \dots, p.$$
(5.1)

By expanding the square we can write

$$\begin{aligned} \|\mathbb{X}'Y\|_{2}^{2} &\stackrel{d}{=} \sigma_{2,p}^{2} \left((W_{n} - \mathbb{E}W_{n} + \mathbb{E}W_{n})^{2} \sum_{k=1}^{p} (\theta_{k}^{(p)})^{2} + 2W_{n}^{3/2} \sum_{k=1}^{p} \theta_{k}^{(p)} \sqrt{1 - (\theta_{k}^{(p)})^{2}} U_{k} \right. \\ & + (W_{n} - \mathbb{E}W_{n}) \sum_{k=1}^{p} \left(1 - (\theta_{k}^{(p)})^{2} \right) U_{k}^{2} + \mathbb{E}W_{n} \sum_{k=1}^{p} \left(1 - (\theta_{k}^{(p)})^{2} \right) U_{k}^{2} \right). \end{aligned}$$

By further rearranging the right-hand side, we have

$$\frac{\|\mathbb{X}'Y\|_2^2}{n^{3/2}} \stackrel{d}{=} I_1 + I_2 + I_3 + I_4, \tag{5.2}$$

where

$$I_1 := \frac{\sigma_{2,p}^2}{n^{3/2}} (W_n - \mathbb{E}W_n)^2 \sum_{k=1}^p (\theta_k^{(p)})^2,$$
(5.3)

$$I_2 := \frac{\sigma_{2,p}^2}{n^{3/2}} (W_n - \mathbb{E}W_n) \Big(2\mathbb{E}W_n \sum_{k=1}^p (\theta_k^{(p)})^2 + \sum_{k=1}^p (1 - (\theta_k^{(p)})^2) U_k^2 \Big),$$
(5.4)

$$I_3 := \frac{\sigma_{2,p}^2}{n^{3/2}} 2W_n^{3/2} \sum_{k=1}^p \theta_k^{(p)} \sqrt{1 - (\theta_k^{(p)})^2} U_k + \frac{\sigma_{2,p}^2}{n^{3/2}} \mathbb{E}W_n \sum_{k=1}^p \left((1 - (\theta_k^{(p)})^2) U_k^2 - 1 \right), \tag{5.5}$$

$$I_4 := \frac{\sigma_{2,p}^2}{n^{3/2}} \Big(p \mathbb{E} W_n + (\mathbb{E} W_n)^2 \sum_{k=1}^p (\theta_k^{(p)})^2 \Big).$$
(5.6)

We will show that, as $p, n \to \infty$, $p/n \to c \in (0, \infty)$, the term $I_1 = o_P(1)$, while the terms I_2 and I_3 are asymptotically normal. More precisely, we will show that $I_2 \stackrel{d}{\to} \mathcal{N}(0, s_1^2)$ and $I_3 \stackrel{d}{\to} \mathcal{N}(0, s_2^2)$, where s_1^2 and s_2^2 are given by (5.12) and (5.30) below. Here, since W_n and $(U_1, \ldots, U_p)'$ are mutually independent for each n, it follows that $I_2 + I_3 \stackrel{d}{\to} \mathcal{N}(0, s_1^2 + s_2^2)$. Finally, the term I_4 defines the mean of the statistic, i.e.

$$\frac{\|\mathbb{X}'Y\|_2^2}{n^{3/2}} - I_4 \quad \stackrel{d}{\to} \quad \mathcal{N}(0, s_1^2 + s_2^2).$$
(5.7)

Thus, we will conclude by establishing that $I_4 = \sqrt{n}(\kappa_{2,p} + pn^{-1}(\kappa_{1,p} + \sigma_{\varepsilon}^2))$, while $s_1^2 + s_2^2 = s^2$, as in the statement of the theorem.

First, consider I_1 defined in (5.3). We will show that $I_1 = o_P(1)$. Denote

$$c_2 := \lim_{p \to \infty} \sum_{k=1}^p (\theta_k^{(p)})^2 = (\kappa_1 + \sigma_{\varepsilon}^2)^{-1} \kappa_2, \quad \sigma_2^2 := \lim_{p \to \infty} \sigma_{2,p}^2 = \kappa_1 + \sigma_{\varepsilon}^2.$$
(5.8)

It is clear that $c_2 < \infty$ and $\sigma_2^2 < \infty$. Recall that, by CLT,

$$\frac{W_n - \mathbb{E}W_n}{n^{1/2}} \stackrel{d}{\to} \mathcal{N}(0, 2).$$
(5.9)

Therefore,

$$I_1 = \mathcal{O}(1)n^{-1/2} \left(\frac{W_n - \mathbb{E}W_n}{n^{1/2}}\right)^2 = o(1)\mathcal{O}_P(1) = o_P(1).$$
(5.10)

Second, consider I_2 , defined in (5.4). We will show that

$$I_2 \stackrel{d}{\to} \mathcal{N}(0, s_1^2) \tag{5.11}$$

with s_1^2 given by

$$s_1^2 = 2\sigma_2^4 (2c_2 + c)^2 = 8\kappa_2^2 + 8c(\kappa_1 + \sigma_\varepsilon^2)\kappa_2 + 2c^2(\kappa_1 + \sigma_\varepsilon^2)^2.$$
(5.12)

Rewrite

$$I_2 = \sigma_{2,p}^2 \frac{W_n - \mathbb{E}W_n}{n^{1/2}} \Big(\frac{2\mathbb{E}W_n}{n} \sum_{k=1}^p (\theta_k^{(p)})^2 + \frac{1}{n} \sum_{k=1}^p (1 - (\theta_k^{(p)})^2) U_k^2 \Big).$$
(5.13)

Applying (5.8) and (5.9) for the outer term of (5.13), we obtain

$$\sigma_{2,p}^2 \frac{W_n - \mathbb{E}W_n}{n^{1/2}} \stackrel{d}{\to} \mathcal{N}(0, 2\sigma_2^4).$$

We will show that the inner term of (5.13) approaches $2c_2 + c$. Since $\mathbb{E}W_n = n$, by (5.8) and assumption $p/n \to c$ it suffices to prove the convergence

$$\frac{1}{p} \sum_{k=1}^{p} (1 - (\theta_k^{(p)})^2) U_k^2 \xrightarrow{P} 1.$$
(5.14)

Denote matrix

$$A := \operatorname{diag} \left(1 - (\theta_1^{(p)})^2, \dots, 1 - (\theta_p^{(p)})^2 \right).$$
(5.15)

To prove (5.14) we apply Lemma 4.1 with $V_j = \sqrt{1 - (\theta_j^{(p)})^2} U_j$, $j = 1, \ldots, p$, and $\Sigma_V^{(p)} = A^{1/2} \Sigma_U A^{1/2}$. Obviously, the conditions of Lemma 4.1 will hold if $\operatorname{tr}((A^{1/2} \Sigma_U A^{1/2})^2) = \mathcal{O}(p)$ and $p^{-1} \operatorname{tr}(A^{1/2} \Sigma_U A^{1/2}) \to 1$, as $p \to \infty$. Observe, that

$$\operatorname{tr}((A^{1/2}\Sigma_{U}A^{1/2})^{2}) = \operatorname{tr}((A\Sigma_{U})^{2})$$

$$= \sum_{k=1}^{p} \sum_{k'=1}^{p} (1 - (\theta_{k}^{(p)})^{2})(1 - (\theta_{k'}^{(p)})^{2})(\sigma_{U}^{(k,k')})^{2}$$

$$= \sum_{k=1}^{p} \sum_{k'=1}^{p} (\rho^{2|k-k'|} - 2\rho^{|k-k'|}\theta_{k}^{(p)}\theta_{k'}^{(p)} + (\theta_{k}^{(p)})^{2}(\theta_{k'}^{(p)})^{2})$$

$$= \sum_{k=1}^{p} \sum_{k'=1}^{p} \rho^{2|k-k'|} - 2(\kappa_{1,p} + \sigma_{\varepsilon}^{2})^{-1}\kappa_{3,p} + (\kappa_{1,p} + \sigma_{\varepsilon}^{2})^{-2}\kappa_{2,p}^{2}$$

$$= \sum_{k=1}^{p} \sum_{k'=1}^{p} \rho^{2|k-k'|} + o(p) \sim p \frac{1+\rho^{2}}{1-\rho^{2}}, \qquad (5.16)$$

since $\kappa_i < \infty$, i = 1, 2, 3 and $\kappa_{1,p} \ge 0$. Here we used (5.8) and the observation that

$$\sum_{k=1}^{p} \sum_{k'=1}^{p} \rho^{|k-k'|} \theta_{k}^{(p)} \theta_{k'}^{(p)} = \frac{\kappa_{3,p}}{\kappa_{1,p} + \sigma_{\varepsilon}^{2}} \to \frac{\kappa_{3}}{\kappa_{1} + \sigma_{\varepsilon}^{2}}, \quad \text{as } p \to \infty.$$
(5.17)

Similarly, we have

$$\frac{1}{p} \operatorname{tr}(A^{1/2} \Sigma_U A^{1/2}) = \frac{1}{p} \sum_{k=1}^p (1 - (\theta_k^{(p)})^2) = 1 - \frac{\kappa_{2,p}}{p(\kappa_{1,p} + \sigma_{\varepsilon}^2)} \to 1,$$

since, by Lemma A.4, $\kappa_{2,p} = o(p)$, while $\kappa_{1,p} \ge 0$, $\kappa_1 < \infty$. This concludes the proof of (5.14).

Next, consider I_3 , defined by (5.5). We will show that

$$I_3 \stackrel{d}{\to} \mathcal{N}(0, s_2^2),$$
 (5.18)

with s_2^2 defined in (5.30). Write

$$I_3 = \sigma_{2,p}^2 \left(2 \frac{W_n^{3/2}}{n^{3/2}} \mathbf{b}' U + n^{-1/2} (U'AU - p) \right),$$

where $U = (U_1, \ldots, U_p)'$, A is defined by (5.15), and

$$\mathbf{b} = \left(\theta_1^{(p)} \sqrt{1 - (\theta_1^{(p)})^2}, \dots, \theta_p^{(p)} \sqrt{1 - (\theta_p^{(p)})^2}\right)'.$$

Observe that $n^{-3/2}W_n^{3/2} \xrightarrow{P} 1$ due to the Law of Large Numbers. Thus, since W_n and U are independent for any n and $p/n \to c$, it follows that

$$I_3 = \sigma_{2,p}^2 \left(2\mathbf{b}'U + \sqrt{\frac{c}{p}} \left(U'AU - p \right) \right) + o_P(1).$$
(5.19)

First, we consider the inner term of (5.19) and show, that, as $p \rightarrow \infty$,

$$2\mathbf{b}'U + \sqrt{\frac{c}{p}}\left(UAU'-p\right) \stackrel{d}{\to} V_2,$$
 (5.20)

where $V_2 \stackrel{d}{=} \mathcal{N}(0, \sigma_2^{-4} s_2^2)$. Then, (5.18) readily follows from (5.19). Recall, that $U \stackrel{d}{=} \mathcal{N}_p(0, \Sigma_U), \Sigma_U > 0$. Further, let $\tilde{Z} \stackrel{d}{=} \mathcal{N}_p(0, I_p)$. Clearly, one has that $U \stackrel{d}{=} \Sigma_U^{1/2} \tilde{Z}$, where $\Sigma_U^{1/2}$ denotes the symmetric square root of Σ_U . By the Spectral Theorem, we construct $V := P'\tilde{Z}$, where $V \stackrel{d}{=} \mathcal{N}_p(0, I_p)$ and P is an orthogonal matrix that diagonalizes $\Sigma_U^{1/2} A \Sigma_U^{1/2}$, such, that $P' \Sigma_U^{1/2} A \Sigma_U^{1/2} P = \Lambda$, with $\Lambda = \operatorname{diag}(\lambda_1^{(p)}, \ldots, \lambda_p^{(p)})$ comprised of the eigenvalues of $\Sigma_U^{1/2} A \Sigma_U^{1/2}$. Then,

$$\frac{\sqrt{c}}{\sqrt{p}} \left(U'AU - p \right) + 2\mathbf{b}'U \stackrel{d}{=} \frac{\sqrt{c}}{\sqrt{p}} \left(V'\Lambda V - p \right) + 2\mathbf{b}'\Sigma_U^{1/2}PV \\
= \frac{\sqrt{c}}{\sqrt{p}} \left(\sum_{j=1}^p \left(\lambda_j^{(p)}(V_j^2 - 1) + g_j^{(p)}\sqrt{p}V_j \right) \right) \\
=: \frac{\sqrt{c}}{\sqrt{p}} \sum_{j=1}^p \widetilde{V}_j^{(p)},$$
(5.21)

where $(g_1^{(p)}, \ldots, g_p^{(p)}) = 2c^{-1/2}\mathbf{b}'\Sigma_U^{1/2}P$, and

$$\widetilde{V}_{j}^{(p)} := \lambda_{j}^{(p)}(V_{j}^{2} - 1) + g_{j}^{(p)}\sqrt{p}V_{j}, \quad j = 1, \dots, p.$$
(5.22)

Clearly, $\mathbb{E}\widetilde{V}_{j}^{(p)} = 0$ and $\mathbb{E}(\widetilde{V}_{j}^{(p)})^{2} = 2(\lambda_{j}^{(p)})^{2} + (g_{j}^{(p)})^{2}p$. Therefore, proving the result (5.20) is equivalent to showing:

$$\frac{\sqrt{c}}{\sqrt{p}} \sum_{j=1}^{p} \widetilde{V}_{j}^{(p)} \stackrel{d}{\to} \mathcal{N}(0, \sigma_{2}^{-4} s_{2}^{2}), \tag{5.23}$$

where

$$\sigma_2^{-4} s_2^2 = c \lim_{p \to \infty} p^{-1} \sum_{j=1}^p \mathbb{E}(\widetilde{V}_j^{(p)})^2 = 2c \lim_{p \to \infty} p^{-1} \sum_{j=1}^p (\lambda_j^{(p)})^2 + c \lim_{p \to \infty} \sum_{j=1}^p (g_j^{(p)})^2.$$
(5.24)

We prove (5.23) by applying Lemma 4.2 with $\nu_j^{(p)} = \lambda_j^{(p)}$ as the eigenvalues of $\Sigma_U^{1/2} A \Sigma_U^{1/2}$ and $\gamma_j^{(p)} = g_j^{(p)}$. By the conditions of Lemma 4.2, we need to show that the following holds

$$\sum_{i=1}^{p} (\lambda_{j}^{(p)})^{3} + p \sum_{j=1}^{p} (g_{j}^{(p)})^{2} \lambda_{j}^{(p)} = o\left(\left(\sum_{j=1}^{p} \left(2(\lambda_{j}^{(p)})^{2} + (g_{j}^{(p)})^{2}p\right)\right)^{3/2}\right).$$
(5.25)

First, observe that $p^{-1} \sum_{j=1}^{p} (2(\lambda_j^{(p)})^2 + (g_j^{(p)})^2 p) \to C \in (0,\infty)$. Indeed, we have that $\sum_{j=1}^{p} (g_j^{(p)})^2 \to C_g \in (0,\infty)$, since

$$\sum_{j=1}^{p} (g_{j}^{(p)})^{2} = 4c^{-1} (\mathbf{b}' \Sigma_{U}^{1/2} P) (\mathbf{b}' \Sigma_{U}^{1/2} P)' = 4c^{-1} \mathbf{b}' \Sigma_{U} \mathbf{b}$$

$$= 4c^{-1} \sum_{j=1}^{p} \sum_{j'=1}^{p} \theta_{j}^{(p)} \theta_{j'}^{(p)} \sqrt{1 - (\theta_{j}^{(p)})^{2}} \sqrt{1 - (\theta_{j'}^{(p)})^{2}} \sigma_{U}^{(j,j')}$$

$$= 4c^{-1} \sum_{j=1}^{p} \sum_{j'=1}^{p} \theta_{j}^{(p)} \theta_{j'}^{(p)} \left(\rho^{|j-j'|} - \theta_{j}^{(p)} \theta_{j'}^{(p)} \right)$$

$$\to 4c^{-1} \left(\kappa_{1} + \sigma_{\varepsilon}^{2} \right)^{-1} \kappa_{3} - 4c^{-1} \left(\kappa_{1} + \sigma_{\varepsilon}^{2} \right)^{-2} \kappa_{2}^{2} = C_{g}$$
(5.26)

by (5.8) and (5.17).

Next, by (5.16), we find that $p^{-1} \sum_{j=1}^{p} (\lambda_j^{(p)})^2 \to C_\lambda \in (0,\infty)$. Indeed, by (5.16), we have

$$\sum_{j=1}^{p} (\lambda_{j}^{(p)})^{2} = \operatorname{tr} \left((\Sigma_{U}^{1/2} A \Sigma_{U}^{1/2})^{2} \right) = \operatorname{tr} \left((\Sigma_{U} A)^{2} \right)$$
$$= \sum_{j=1}^{p} \sum_{j'=1}^{p} \rho^{2|j-j'|} + o(p) \sim p \frac{1+\rho^{2}}{1-\rho^{2}}.$$
(5.27)

Thus, by (5.26) and (5.27), it follows that $p^{-1} \sum_{j=1}^{p} (2c(\lambda_{j}^{(p)})^{2} + (g_{j}^{(p)})^{2}p) \rightarrow C \in (0, \infty)$ and condition (5.25) reduces to:

$$\sum_{j=1}^{p} (\lambda_j^{(p)})^3 + p \sum_{j=1}^{p} (g_j^{(p)})^2 \lambda_j^{(p)} = o(p^{3/2}).$$
(5.28)

We show that (5.28) holds. For the first term of (5.28), we have

$$\sum_{j=1}^{p} (\lambda_{j}^{(p)})^{3} = \operatorname{tr}((\Sigma_{U}^{1/2} A \Sigma_{U}^{1/2})^{3}) = \operatorname{tr}((\Sigma_{U} A)^{3})$$

$$= \sum_{i,j,k=1}^{p} (1 - (\theta_{i}^{(p)})^{2}) (1 - (\theta_{k}^{(p)})^{2}) (1 - (\theta_{j}^{(p)})^{2}) \sigma_{U}^{(i,j)} \sigma_{U}^{(i,k)} \sigma_{U}^{(k,j)}$$

$$= \sum_{i,j,k=1}^{p} (\rho^{|i-j|} + \theta_{i}^{(p)} \theta_{j}^{(p)}) (\rho^{|i-k|} + \theta_{i}^{(p)} \theta_{k}^{(p)}) (\rho^{|k-j|} + \theta_{k}^{(p)} \theta_{j}^{(p)})$$

$$= o(p^{3/2}), \qquad (5.29)$$

where the last equality follows from Lemma A.5. For the second term of (5.28), observe, that by Hölder's inequality and (5.29),

$$p\sum_{j=1}^{p} (g_{j}^{(p)})^{2} \lambda_{j}^{(p)} \leq p \left(\sum_{j=1}^{p} |g_{j}^{(p)}|^{3}\right)^{2/3} \left(\sum_{j=1}^{p} (\lambda_{j}^{(p)})^{3}\right)^{1/3}$$
$$= p^{3/2} \mathcal{O}(1) \left(\frac{\sum_{j=1}^{p} (\lambda_{j}^{(p)})^{3}}{p^{3/2}}\right)^{1/3} = o(p^{3/2}).$$

This concludes with (5.28), ensuring that the conditions of Lemma 4.2 hold.

Now we can establish the expression for s_2^2 . By (5.8), (5.24), (5.26) and (5.27),

$$= \sigma_{2}^{4} \lim_{p \to \infty} \frac{2c}{p} \left(\sum_{k=1}^{p} \sum_{k'=1}^{p} \rho^{2|k-k'|} + o(p) \right) + 4\sigma_{2}^{4} \left(\kappa_{1} + \sigma_{\varepsilon}^{2}\right)^{-1} \kappa_{3} - 4\sigma_{2}^{4} \left(\kappa_{1} + \sigma_{\varepsilon}^{2}\right)^{-2} \kappa_{2}^{2}$$

$$= 2c \frac{1+\rho^{2}}{1-\rho^{2}} \left(\kappa_{1} + \sigma_{\varepsilon}^{2}\right)^{2} + 4(\kappa_{1} + \sigma_{\varepsilon}^{2})\kappa_{3} - 4\kappa_{2}^{2}.$$
(5.30)

By (5.12) and (5.30), recalling that $s^2 = s_1^2 + s_2^2$, we have that

$$s^{2} = 4\kappa_{2}^{2} + 4(\kappa_{1} + \sigma_{\varepsilon}^{2})(2\kappa_{2}c + \kappa_{3}) + 2c(\kappa_{1} + \sigma_{\varepsilon}^{2})^{2}\left(c + \frac{1+\rho^{2}}{1-\rho^{2}}\right).$$
(5.31)

Finally, consider I_4 , defined by (5.6). Since $\mathbb{E}W_n = n$, we have that

$$I_4 = \frac{\kappa_{1,p} + \sigma_{\varepsilon}^2}{n^{3/2}} \left(n^2 \frac{\kappa_{2,p}}{\kappa_{1,p} + \sigma_{\varepsilon}^2} + pn \right) = \sqrt{n} \left(\kappa_{2,p} + \frac{p}{n} (\kappa_{1,p} + \sigma_{\varepsilon}^2) \right).$$
(5.32)

By (5.2), having established 4 parts by (5.3)–(5.6), we proved that (5.7) holds due to (5.10), (5.11), (5.18), (5.30), with terms (5.31) and (5.32), as in the statement of the theorem, thus concluding the proof. \Box

Before proceeding with the proof of Theorem 2.2, we establish the following lemma that ensures $\mathcal{O}(p^{-1/2})$ convergence rate for $\kappa_{1,p}$ and $\kappa_{2,p}$, appearing in Theorem 2.1, under additional restrictions for the parameters β_j .

Lemma 5.1. Assume that $\sum_{j=p+1}^{\infty} \beta_j^2 = o(p^{-1/2})$ and $\sup_{j\geq 1} |\beta_j| j^{\alpha} < \infty$, $\alpha > 1/2$, and $|\rho| < 1$. Then,

(i)
$$\kappa_1 = \kappa_{1,p} + o(p^{-1/2})$$
,

(ii)
$$\kappa_2 = \kappa_{2,p} + o(p^{-1/2})$$

Proof. For the proof see Appendix S1.

Proof of Theorem 2.2. Rewrite the left-hand side of (2.8) as follows:

$$\frac{\|\mathbb{X}'Y\|_2^2 - n^2(\kappa_2 + c(\kappa_1 + \sigma_{\varepsilon}^2))}{n^{3/2}} = \frac{\|\mathbb{X}'Y\|_2^2 - n^2\kappa_{2,p} - pn(\kappa_{1,p} + \sigma_{\varepsilon}^2)}{n^{3/2}} + \sqrt{n}(\kappa_{2,p} - \kappa_2) + \sqrt{n}c(\kappa_{1,p} - \kappa_1) + o(1).$$

It remains to apply Lemma 5.1 and Theorem 2.1 in order to conclude the proof of the theorem.

We end this section by deriving two supporting results that allows us to derive convenient alternative expressions for the terms κ_1, κ_2 and κ_3 . For this, we introduce functions $\beta(\cdot)$ and $b(\cdot)$ by Definition 5.1 below, which, under the assumptions of Theorem 2.1 and a given structure of β_j 's, requires only to evaluate the terms $\beta(1), \beta(\rho), \beta(\rho^2)$ and $b_1(\rho), b_2(\rho)$. Then, due to Lemma 5.2 below, the expressions for κ_1, κ_2 and κ_3 easily follow.

DEFINITION 5.1. Assume that $\sum_{j=1}^{\infty} \beta_j^2 < \infty$ and $|\rho| \le 1$. Define,

$$\beta(\rho) := \sum_{j=1}^{\infty} \beta_j^2 \rho^j, \qquad (5.33)$$

$$b_1(\rho) := \sum_{j'=2}^{\infty} \sum_{j=1}^{j'-1} \beta_j \beta_{j'} \rho^{j'-j}, \qquad (5.34)$$

$$b_2(\rho) := \sum_{j=2}^{\infty} \sum_{j'=1}^{j-1} \beta_j \beta_{j'} \rho^{j+j'}, \qquad (5.35)$$

and define the following quantities which involve derivatives of (5.33)-(5.35):

$$\beta^{(1)}(\rho) := \rho \frac{\mathrm{d}\beta(\rho)}{\mathrm{d}\rho} = \sum_{j=1}^{\infty} j\beta_j^2 \rho^j, \qquad (5.36)$$

$$b_1^{(1)}(\rho) := \rho \frac{\mathrm{d}b_1(\rho)}{\mathrm{d}\rho} = \sum_{j'=2}^{\infty} \sum_{j=1}^{j'-1} \beta_j \beta_{j'} \rho^{j'-j} (j'-j), \qquad (5.37)$$

$$b_{2}^{(1)}(\rho) := \rho \frac{\mathrm{d}b_{2}(\rho)}{\mathrm{d}\rho} = \sum_{j'=2}^{\infty} \sum_{j=1}^{j'-1} \beta_{j} \beta_{j'} \rho^{j'+j} (j'+j), \qquad (5.38)$$

$$b^{(2)}(\rho) := \rho^2 \frac{\mathrm{d}^2 b_1(\rho)}{\mathrm{d}\rho^2} + b_1^{(1)}(\rho) = \sum_{j'=2}^{\infty} \sum_{j=1}^{j'-1} \beta_j \beta_{j'} \rho^{j'-j} (j'-j)^2.$$
(5.39)

Note, that, by the rules of differentiation of power series, the functions (5.36)-(5.39) are well defined.

Lemma 5.2. Let the assumptions of Theorem 2.1 hold. Let κ_1 , κ_2 and κ_3 be given by (2.1), (2.2) and (2.3), respectively. Then, under notation in Definition 5.1, the following identities hold:

(i)
$$\kappa_1 = \beta(1) + 2b_1(\rho),$$

(ii) $\kappa_2 = \beta(1)\frac{1+\rho^2}{1-\rho^2} - \beta(\rho^2)\frac{1}{1-\rho^2} + 2\left(b_1^{(1)}(\rho) + b_1(\rho)\frac{1+\rho^2}{1-\rho^2} - b_2(\rho)\frac{1}{1-\rho^2}\right),$
(iii) $\kappa_3 = \frac{1}{(1-\rho^2)^2}\left((1+4\rho^2+\rho^4)(\beta(1)+2b_1(\rho)) - (1+3\rho^2)(\beta(\rho^2)+2b_2(\rho))\right) + \frac{1}{1-\rho^2}\left(3b_1^{(1)}(\rho)(1+\rho^2) - 2\left(b_2^{(1)}(\rho) + \beta^{(1)}(\rho^2)\right)\right) + b^{(2)}(\rho).$
Proof. See the proof in Appendix A.2.

Proof. See the proof in Appendix A.2.

REMARK 5.1. From the assumptions of Definition 5.1 it follows that $\beta(1), |\beta(\rho)|, |b_1(\rho)|, |b_2(\rho)| < \infty$ for $|\rho| < 1$. Thus, it follows from Lemma 5.2 that $\kappa_i < \infty$, i = 1, 2, 3.

Proof of Remark 5.1. Cases for $\beta(1)$ and $\beta(\rho)$ follow straightforwardly from the assumptions. Consider $b_1(\rho)$. Note, that for any p,

$$\begin{aligned} |b_{1}(\rho)| &\leq \sum_{l_{1},l_{2}=1}^{\infty} |\beta_{l_{1}}||\beta_{l_{2}}||\rho|^{|l_{1}-l_{2}|} &= \sum_{l_{1},l_{2}=1}^{\infty} \left(|\beta_{l_{1}}||\rho|^{|l_{1}-l_{2}|/2}\right) \left(|\beta_{l_{2}}||\rho|^{|l_{1}-l_{2}|/2}\right) \\ &\leq (1/2) \sum_{l_{1},l_{2}=1}^{\infty} \left(\beta_{l_{1}}^{2}|\rho|^{|l_{1}-l_{2}|} + \beta_{l_{2}}^{2}|\rho|^{|l_{1}-l_{2}|}\right) \\ &= \sum_{l_{1}=1}^{\infty} \beta_{l_{1}}^{2} \sum_{l_{2}=1}^{\infty} |\rho|^{|l_{1}-l_{2}|} \leq \beta(1) \frac{1+|\rho|}{1-|\rho|} < \infty \end{aligned}$$

by (S9). In a similar manner, it is easy to see that $|b_2(\rho)| \leq \beta(1) \frac{|\rho|}{1-|\rho|}$.

6 Approximate sparsity: an example

In this section we study the case when coefficients β_j decay hyperbolically, i.e., $\beta_j = j^{-1}, j \ge 1$. This assumption is analogous to the assumption of approximate sparsity, as defined by Belloni et al. (2012). The authors of the aforementioned paper note, that for approximately sparse models the regression function can be well approximated by a linear combination of relatively few important regressors, which is one of the reasons of popularity of variable selection approaches such as LASSO (Tibshirani (1996)) and it's modifications (see, e.g., Zou (2006), Meinshausen (2007), Belloni et al. (2011)). At the same time, approximate sparsity allows all coefficients β_j to be nonzero, which is a more plausible assumption in many real world settings.

In order to derive the quantities in Theorem 2.2, we apply the results of Lemma 5.2. For this, we establish the expressions for the quantities in Definition 5.1.

Define the real dilogarithm function (see, e.g., Morris (1979)):

$$\text{Li}_{2}(x) = -\int_{0}^{x} \frac{\log(1-u)}{u} \, \mathrm{d}u, \quad x \le 1, \ x \in \mathbb{R}.$$
 (6.1)

(Here and below, $\int_0^x = -\int_x^0$ if $x \le 0$.) For $|x| \le 1$ the real dilogarithm has a series representation,

$$\text{Li}_2(x) = \sum_{k=1}^{\infty} \frac{x^k}{k^2}.$$
 (6.2)

Then,

$$\beta(1) = \sum_{j=1}^{\infty} \frac{1}{j^2} = \frac{\pi^2}{6}, \qquad \beta(\rho) = \sum_{j=1}^{\infty} \frac{\rho^j}{j^2} = \text{Li}_2(\rho)$$

Additionally, we have

$$\frac{\mathrm{d}}{\mathrm{d}\rho}\mathrm{Li}_2(\rho) = -\frac{\log(1-\rho)}{\rho}.$$
(6.3)

Thus, by (5.36) and (6.3), we establish

$$\beta^{(1)}(\rho) = \rho \frac{\mathrm{d}}{\mathrm{d}\rho} \beta(\rho) = \rho \frac{\mathrm{d}}{\mathrm{d}\rho} \operatorname{Li}_2(\rho) = -\log(1-\rho).$$

Next, note that

$$b_{1}(\rho) = \sum_{i=2}^{\infty} \sum_{j=1}^{i-1} \frac{\rho^{i-j}}{ij} = \sum_{i=2}^{\infty} \sum_{k=1}^{i-1} \frac{\rho^{k}}{i(i-k)}$$

$$= \sum_{k=1}^{\infty} \rho^{k} \sum_{i=k+1}^{\infty} \frac{1}{i(i-k)} = \sum_{k=1}^{\infty} \frac{\rho^{k}}{k} \sum_{l=1}^{k} \frac{1}{l}$$

$$= \sum_{l=1}^{\infty} \frac{1}{l} \sum_{k=l}^{\infty} \frac{\rho^{k}}{k} = \sum_{l=1}^{\infty} \frac{1}{l} \int_{0}^{\rho} \frac{x^{l-1}}{1-x} dx$$

$$= -\int_{0}^{\rho} \frac{\log(1-x)}{x(1-x)} dx = \frac{\log^{2}(1-\rho)}{2} + \text{Li}_{2}(\rho), \qquad (6.4)$$

where we have used identities

$$\sum_{k=l+1}^{\infty} \frac{1}{i(i-k)} = \frac{1}{k} \sum_{l=1}^{k} \frac{1}{l}, \ k \ge 1, \qquad \sum_{k=l}^{\infty} \frac{\rho^k}{k} = \int_0^{\rho} \frac{x^{l-1}}{1-x} \, \mathrm{d}x$$

and (6.1). Then, by (5.37), (6.3) and (6.4),

$$b_1^{(1)}(\rho) = \rho \frac{\mathrm{d}}{\mathrm{d}\rho} b_1(\rho) = -\frac{\log(1-\rho)}{1-\rho},$$

whereas by (5.39),

$$b^{(2)}(\rho) = \rho^2 \frac{\mathrm{d}^2 b_1(\rho)}{\mathrm{d}\rho^2} + b_1^{(1)}(\rho) = \frac{\rho - \rho \log(1 - \rho)}{(1 - \rho)^2}.$$

Further, note that

$$b_{2}(\rho) = \sum_{i=2}^{\infty} \sum_{j=1}^{i-1} \frac{\rho^{i+j}}{ij} = \sum_{i=2}^{\infty} \frac{\rho^{i}}{i} \sum_{j=1}^{i-1} \frac{\rho^{j}}{j} = \sum_{i=2}^{\infty} \frac{\rho^{i}}{i} \int_{0}^{\rho} \sum_{j=1}^{i-1} x^{j-1} dx$$

$$= \sum_{i=1}^{\infty} \frac{\rho^{i+1}}{i+1} \int_{0}^{\rho} \frac{1-x^{i}}{1-x} dx$$

$$= -\log(1-\rho) \left(\sum_{i=1}^{\infty} \frac{\rho^{i}}{i} - \rho\right) - \int_{0}^{\rho} \left(\sum_{i=1}^{\infty} \frac{\rho^{i}}{i} \frac{x^{i-1}}{1-x} - \rho \frac{1}{1-x}\right) dx$$

$$= -\log(1-\rho) \sum_{i=1}^{\infty} \frac{\rho^{i}}{i} - \int_{0}^{\rho} \sum_{i=1}^{\infty} \frac{(\rho x)^{i}}{i} \frac{1}{x(1-x)} dx$$

$$= \log^{2}(1-\rho) + \int_{0}^{\rho} \frac{\log(1-\rho x)}{x(1-x)} dx$$

$$= \frac{1}{2} \left(\log^{2}(1-\rho) - \operatorname{Li}_{2}(\rho^{2})\right), \qquad (6.5)$$

where the last equality follows from Lemma A.1. Next, by (5.37), (6.3) and (6.5) we have

$$b_2^{(1)}(\rho) = \log(1-\rho^2) - \frac{\rho\log(1-\rho)}{1-\rho}.$$

Thus, we can apply Lemma 5.2(i) and arrive at the following expression for κ_1 :

$$\kappa_1 = \frac{\pi^2}{6} + \log^2(1-\rho) + 2\mathrm{Li}_2(\rho).$$
(6.6)

Similarly, for κ_2 , by collecting and simplifying the terms, by Lemma 5.2(ii) and Lemma A.1, we have

$$\kappa_{2} = \frac{1+\rho^{2}}{1-\rho^{2}} \left(\frac{\pi^{2}}{6} + 2\mathrm{Li}_{2}(\rho)\right) - \frac{2\log(1-\rho)}{1-\rho} + \log^{2}(1-\rho)\frac{\rho^{2}}{1-\rho^{2}}$$
$$= \frac{1}{1-\rho^{2}} \left((1+\rho^{2})\kappa_{1} - \log^{2}(1-\rho) - 2(1+\rho)\log(1-\rho)\right).$$
(6.7)

Lastly, for κ_3 , by Lemma 5.2(iii), through simplification of terms, we get

$$\kappa_{3} = \frac{1}{(1-\rho^{2})^{2}} \Big((1+4\rho^{2}+\rho^{4}) \Big(\frac{\pi^{2}}{6} + 2\operatorname{Li}_{2}(\rho) \Big) + \log^{2}(1-\rho)\rho^{2}(1+\rho^{2}) \\ - (3-\rho+4\rho^{2})(1+\rho)\log(1-\rho) + \rho(1+\rho)^{2} \Big) \\ = \kappa_{2} \frac{1+3\rho^{2}}{1-\rho^{2}} + \frac{1}{(1-\rho^{2})^{2}} \Big((-1+\rho+2\rho^{2})(1+\rho)\log(1-\rho) + \rho(1+\rho)^{2} - 2\rho^{4}\kappa_{1} \Big).$$
(6.8)

This allows us to apply Theorem 2.2 under the considered specification of the parameter β , and conclude with the following corollary.

Corollary 6.1. Assume a model (1.1) with (1.2) covariance structure and consider $\beta_j := j^{-1}, j = 1, ..., p$. Let $p = p_n$ satisfies

$$p \to \infty, \qquad \frac{p}{n} \to c \in (0,\infty).$$

Then

$$\frac{\|\mathbb{X}'Y\|_2^2 - n^2 \left(\kappa_2 + c(\kappa_1 + \sigma_{\varepsilon}^2)\right)}{n^{3/2}} \xrightarrow{d} \mathcal{N}(0, s^2), \tag{6.9}$$

where

$$s^{2} = 4\kappa_{2}^{2} + 4(\kappa_{1} + \sigma_{\varepsilon}^{2})\left(2\kappa_{2}c + \kappa_{3}\right) + 2c(\kappa_{1} + \sigma_{\varepsilon}^{2})^{2}\left(c + \frac{1+\rho^{2}}{1-\rho^{2}}\right),$$
(6.10)

and κ_1 , κ_2 and κ_3 are defined by (6.6), (6.7) and (6.8), respectively.

In order to illustrate the results of Corollary 6.1, we end this section with a Monte Carlo simulation study, where we generate 1000 independent replications of the statistic $||X'Y||_2^2$. The data is generated following the assumptions of Corollary 6.1 for varying sets of parameters $(n, p, \rho, \sigma_{\varepsilon}^2)$. The results are presented in Figures 1–5. Figures show the empirical cumulative distribution function (CDF) and the empirical probability density function (PDF), together with the limiting CDF and PDF of $V \stackrel{d}{=} \mathcal{N}(0, s^2)$ for different parameter combinations. We notice that for relatively small values of ρ , the distribution is fairly close to the limiting distribution even for small values of (p, n). On the other hand, slightly slower convergence is evident for $\rho \approx 1$ (see Figure 1 for simulation results with $\rho = 0.95$). However, it can be noted that for large values of ρ the effect of c term is greatly reduced, resulting in very similar distributions when comparing, e.g., c = 1against c = 10.

A Appendix

Throughout the proofs we use the notation C to mark generic constants, the specific values of which can change from line to line.

A.1 Technical lemmas

Lemma A.1. Assume that $|\rho| < 1$. Then,

$$\int_0^{\rho} \frac{\log(1-\rho x)}{x(1-x)} \, \mathrm{d}x = -\frac{1}{2} \left(\operatorname{Li}_2(\rho^2) + \log^2(1-\rho) \right)$$

where Li₂ denotes the real dilogarithm function. (Recall, that for $\rho < 0$, by \int_0^{ρ} we denote $-\int_{\rho}^{0}$.) Proof. Write,

$$\int_0^{\rho} \frac{\log(1-\rho x)}{x(1-x)} \, \mathrm{d}x = \int_0^{\rho} \frac{\log(1-\rho x)}{x} \, \mathrm{d}x + \int_0^{\rho} \frac{\log(1-\rho x)}{1-x} \, \mathrm{d}x.$$

By (6.1), we have

$$\int_{0}^{\rho} \frac{\log(1-\rho x)}{x} \, \mathrm{d}x = -\operatorname{Li}_{2}(\rho^{2}). \tag{A.1}$$

It remains to show that

$$\int_{0}^{\rho} \frac{\log(1-\rho x)}{1-x} \, \mathrm{d}x = \frac{1}{2} \big(\operatorname{Li}_{2}(\rho^{2}) - \log^{2}(1-\rho) \big). \tag{A.2}$$

Indeed, by substitution $v = \rho - \rho x$, we have

$$\int_{0}^{\rho} \frac{\log(1-\rho x)}{1-x} dx = \int_{\rho-\rho^{2}}^{\rho} \frac{\log(1-\rho+v)}{v} dv$$
$$= \int_{\rho-\rho^{2}}^{\rho} \frac{\log(1+\frac{v}{1-\rho})}{v} dv - \log^{2}(1-\rho).$$
(A.3)

Further, by substitution $w = -\frac{v}{1-\rho}$, we have

$$\int_{\rho-\rho^{2}}^{\rho} \frac{\log(1+\frac{v}{1-\rho})}{v} \, \mathrm{d}v = -\int_{-\frac{\rho}{1-\rho}}^{-\rho} \frac{\log(1-w)}{w} \, \mathrm{d}w$$
$$= \operatorname{Li}_{2}(-\rho) - \operatorname{Li}_{2}\left(-\frac{\rho}{1-\rho}\right)$$
$$= \operatorname{Li}_{2}(-\rho) + \operatorname{Li}_{2}(\rho) + \frac{1}{2}\log^{2}(1-\rho)$$
(A.4)

$$= \frac{1}{2} \left(\operatorname{Li}_2(\rho^2) + \log^2(1-\rho) \right), \tag{A.5}$$

where for (A.4)–(A.5) we apply the easily verifiable identities (see, e.g., Maximon (2003)):

$$\operatorname{Li}_{2}\left(\frac{x}{x-1}\right) = -\operatorname{Li}_{2}(x) - \frac{1}{2}\log^{2}(1-x), \quad x < 1,$$

$$\operatorname{Li}_{2}(x) + \operatorname{Li}_{2}(-x) = \frac{1}{2}\operatorname{Li}_{2}(x^{2}), \quad |x| < 1.$$

Thus, (A.3) and (A.5) imply (A.2), which concludes the proof.

Lemma A.2. Assume that $\sum_{j=1}^{\infty} \beta_j^2 < \infty$ and $|\rho| < 1$. Then, the following inequalities hold:

(i)
$$\left|\sum_{l=p+1}^{\infty}\sum_{l'=l+1}^{\infty}\beta_{l}\beta_{l'}\rho^{l'-l}\right| \leq C\sum_{l=p+1}^{\infty}\beta_{l}^{2}.$$

(ii) $\left|\sum_{l=p+1}^{\infty}\sum_{l'=l+1}^{\infty}\beta_{l}\beta_{l'}\rho^{l'-l}(l'-l)\right| \leq C\sum_{l=p+1}^{\infty}\beta_{l}^{2}.$

(iii)
$$\left|\sum_{l=1}^{p}\sum_{l'=p+1}^{\infty}\beta_{l}\beta_{l'}\rho^{l'-l}\right| \leq C\sum_{l=p+1}^{\infty}\beta_{l}^{2}.$$

(iv)
$$\left|\sum_{l=1}^{p}\sum_{l'=p+1}^{\infty}\beta_{l}\beta_{l'}\rho^{l'+l}\right| \leq C\sum_{l=p+1}^{\infty}\beta_{l}^{2}.$$

Proof. See the proof in Supplementary material, Section S2.

Lemma A.3. Assume that $\sup_{j\geq 1} |\beta_j| j^{\alpha} < \infty$, $\alpha > 1/2$ and that $|\rho| < 1$. Then,

$$\left|\sum_{j=1}^p \beta_j \rho^{p-j}\right| = o(p^{-1/4}).$$

Proof. We have

$$\begin{split} \left| \sum_{j=1}^{p} \beta_{j} \rho^{p-j} \right| &\leq \sum_{j=1}^{\lfloor \sqrt{p} \rfloor} |\beta_{j}| |\rho|^{p-j} + \sum_{j=\lfloor \sqrt{p} \rfloor+1}^{p} |\beta_{j}| |\rho|^{p-j} \\ &\leq \sup_{j\geq 1} |\beta_{j}| \sum_{j=1}^{\lfloor \sqrt{p} \rfloor} |\rho|^{p-j} + p^{-\alpha/2} \sum_{j=\lfloor \sqrt{p} \rfloor+1}^{p} |\beta_{j}| p^{\alpha/2} |\rho|^{p-j} \\ &\leq \sup_{j\geq 1} |\beta_{j}| \sum_{j=1}^{\lfloor \sqrt{p} \rfloor} |\rho|^{p-j} + p^{-\alpha/2} \sup_{j\geq 1} |\beta_{j}| j^{\alpha} \sum_{j=\lfloor \sqrt{p} \rfloor+1}^{p} |\rho|^{p-j} \\ &\leq C \bigg(\sum_{j=1}^{\lfloor \sqrt{p} \rfloor} |\rho|^{p-j} + p^{-\alpha/2} \sum_{j=\lfloor \sqrt{p} \rfloor+1}^{p} |\rho|^{p-j} \bigg) \\ &\leq C \bigg(|\rho|^{p-\lfloor \sqrt{p} \rfloor} + p^{-\alpha/2} \bigg). \end{split}$$

Here we used the fact that $\sum_{j=\lfloor\sqrt{p}\rfloor+1}^p |\rho|^{p-j} \to (1-|\rho|)^{-1} < \infty$. Thus,

$$p^{1/4} \left| \sum_{j=1}^{p} \beta_j \rho^{p-j} \right| \le C \left(p^{1/4} |\rho|^{p - \lfloor \sqrt{p} \rfloor} + p^{\frac{1}{4} - \frac{\alpha}{2}} \right) \to 0.$$
 (A.6)

REMARK A.1. Obviously, the assumption $\sup_{j\geq 1} |\beta_j| j^{\alpha} < \infty$, for $\alpha > 1/2$, implies that $\sum_{j=1}^{\infty} \beta_j^2 < \infty$:

$$\sum_{j=1}^{\infty}\beta_j^2 = \sum_{j=1}^{\infty}\beta_j^2 j^{2\alpha} j^{-2\alpha} \leq \sup_{j\geq 1}\beta_j^2 j^{2\alpha} \sum_{k=1}^{\infty} k^{-2\alpha} < \infty.$$

Lemma A.4. Assume that the assumptions of Theorem 2.1 hold. Then,

$$\kappa_{2,p} = o(p).$$

Proof. Observe, that

$$\kappa_{2,p} = \sum_{k=1}^{p} \left(\sum_{l=1}^{p} \beta_{l} \rho^{|k-l|} \right)^{2} = \sum_{k=1}^{p} \sum_{l_{1}, l_{2}=1}^{p} \beta_{l_{1}} \beta_{l_{2}} \rho^{|k-l_{1}|+|k-l_{2}|}$$

$$\leq \sum_{l_{1}, l_{2}=1}^{p} |\beta_{l_{1}}| |\beta_{l_{2}}| \sum_{k=1}^{p} |\rho|^{|k-l_{1}|+|k-l_{2}|}$$

$$\leq C \left(\sum_{l=1}^{p} |\beta_{l_{1}}| \right)^{2}$$

$$= o(p)$$
(A.7)

where (A.7) follows from (S9). Meanwhile, $\sum_{l=1}^{p} |\beta_{l_1}| = o(p^{1/2})$, since

$$\sum_{l=1}^{p} |\beta_l| = \sum_{l=1}^{\lfloor p^{1/2} \rfloor} |\beta_l| + \sum_{l=\lfloor p^{1/2} \rfloor+1}^{p} |\beta_l|$$

$$\leq p^{1/4} \left(\sum_{l=1}^{\infty} \beta_l^2\right)^{1/2} + p^{1/2} \left(\sum_{l=\lfloor p^{1/2} \rfloor+1}^{\infty} \beta_l^2\right)^{1/2} = o(p^{1/2}).$$

Lemma A.5. Assume that $\sum_{j=1}^{\infty} \beta_j^2 < \infty$ and $|\rho| < 1$. Define $\theta_k^{(p)} = \sum_{j=1}^p \beta_j \rho^{|k-j|}$. Then,

$$\left|\sum_{i,j,k=1}^{p} \left(\rho^{|i-j|} + \theta_i^{(p)} \theta_j^{(p)}\right) \left(\rho^{|i-k|} + \theta_i^{(p)} \theta_k^{(p)}\right) \left(\rho^{|k-j|} + \theta_k^{(p)} \theta_j^{(p)}\right)\right| = o(p^{3/2}).$$
(A.8)

Proof. See the proof in Supplementary material, Section S3.

A.2 Proof of Lemma 5.2

Here and throughout the proof we employ the notation as in Definition 5.1. (i) Note that, by (5.33) and (5.35), we have

$$\kappa_{1,p} = \sum_{k=1}^{p} \beta_k^2 + 2 \sum_{k=2}^{p} \sum_{l=1}^{k-1} \beta_k \beta_l \rho^{k-l} \to \beta(1) + 2b_1(\rho) \text{ as } p \to \infty.$$

(ii) Write

$$\kappa_{2,p} = \sum_{l=1}^{p} \sum_{k=1}^{p} \beta_l^2 \rho^{2|k-l|} + 2 \sum_{l'>l} \sum_{k=1}^{p} \beta_l \beta_{l'} \rho^{|k-l|} \rho^{|k-l'|}.$$

From here, it is straightforward to see that

$$\kappa_{2,p} \rightarrow \beta(1)\frac{1+\rho^2}{1-\rho^2} - \beta(\rho^2)\frac{1}{1-\rho^2} + 2\Big(b_1^{(1)}(\rho) + b_1(\rho)\frac{1+\rho^2}{1-\rho^2} - b_2(\rho)\frac{1}{1-\rho^2}\Big).$$
(A.9)

Technical details of the proof of (A.9) are presented in Supplementary material, Section S4. (iii) Consider

$$\kappa_{3,p} = \sum_{l=1}^{p} \beta_l^2 J_1(l) + 2 \sum_{l < l'} \beta_l \beta_{l'} J_2(l, l'), \qquad (A.10)$$

where

$$J_1(l) := \sum_{k,k'=1}^p \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l|} \mathbf{1}_{\{l=l'\}},$$
(A.11)

$$J_2(l,l') := \sum_{k,k'=1}^p \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l'|} \mathbf{1}_{\{l < l'\}}.$$
 (A.12)

Then, it is straightforward to see that, as $p \to \infty$, using the notation in Definition 5.1, we have that

$$\sum_{l=1}^{p} \beta_l^2 J_1(l) \to \beta(1) \frac{1+4\rho^2+\rho^4}{(1-\rho^2)^2} - \beta(\rho^2) \frac{1+3\rho^2}{(1-\rho^2)^2} - \frac{2}{1-\rho^2} \beta^{(1)}(\rho^2), \tag{A.13}$$

and

$$\sum_{l'>l} \beta_l^2 J_2(l,l') \rightarrow \frac{1}{2(1-\rho^2)^2} (b^{(2)}(\rho)(1-\rho^2)^2 + 3b_1^{(1)}(\rho)(1-\rho^4) + 2b_1(\rho)(1+4\rho^2+\rho^4) - 2b_2^{(1)}(\rho)(1-\rho^2) - 2b_2(\rho)(1+3\rho^2)).$$
(A.14)

Technical details of the proof of (A.13)–(A.14) are omitted here and presented in the Supplementary material S5. This concludes the proof.

Supplementary material

S1 Proof of Lemma 5.1

Part (i). Write

$$\kappa_1 - \kappa_{1,p} = 2\sum_{l=1}^p \sum_{l'=p+1}^\infty \beta_l \beta_{l'} \rho^{l'-l} + \sum_{l=p+1}^\infty \sum_{l'=p+1}^\infty \beta_l \beta_{l'} \rho^{|l-l'|}.$$

Here,

$$\left|\sum_{l=1}^{p}\sum_{l'=p+1}^{\infty}\beta_{l}\beta_{l'}\rho^{l'-l}\right| = o(p^{-1/2})$$

by Lemma A.2(iii), while

$$\sum_{l=p+1}^{\infty} \sum_{l'=p+1}^{\infty} \beta_l \beta_{l'} \rho^{|l-l'|} = \sum_{l=p+1}^{\infty} \beta_l^2 + 2 \sum_{l=p+1}^{\infty} \sum_{l'=l+1}^{\infty} \beta_l \beta_{l'} \rho^{l'-l} \le C \sum_{l=p+1}^{\infty} \beta_l^2 = o(p^{-1/2})$$

by Lemma A.2(i), which concludes the proof.

Part (ii). Write

$$\kappa_{2} - \kappa_{2,p} = \left(2\sum_{k=1}^{p}\sum_{l=1}^{p}\sum_{l'=p+1}^{\infty} + 2\sum_{k=p+1}^{\infty}\sum_{l=1}^{p}\sum_{l'=p+1}^{\infty} + \sum_{k=1}^{p}\sum_{l=p+1}^{\infty}\sum_{l'=p+1}^{\infty} + \sum_{k=p+1}^{p}\sum_{l=1}^{p}\sum_{l'=1}^{p}\sum_{l'=p+1}^{\infty}\sum_{l'=p+1}^{p}\beta_{l}\beta_{l'}\rho^{|k-l|+|k-l'|} + \sum_{k=p+1}^{p}\sum_{l=1}^{p}\sum_{l'=p+1}^{p}\sum_{l'$$

We have

$$L_{1} = \sum_{l=1}^{p} \sum_{l'=p+1}^{\infty} \beta_{l} \beta_{l'} \sum_{k=1}^{p} \rho^{|k-l|+l'-k} = \sum_{l=1}^{p} \sum_{l'=p+1}^{\infty} \beta_{l} \beta_{l'} \left(\sum_{k=1}^{l} \rho^{l'+l-2k} + \sum_{k=l+1}^{p} \rho^{l'-l} \right)$$
$$= \sum_{l=1}^{p} \sum_{l'=p+1}^{\infty} \beta_{l} \beta_{l'} \left(\frac{\rho^{l'-l}}{1-\rho^{2}} - \frac{\rho^{l+l'}}{1-\rho^{2}} + (p-l)\rho^{l'-l} \right).$$

Thus,

$$|L_1| \leq \sum_{l=1}^p \sum_{l'=p+1}^\infty |\beta_l| |\beta_{l'}| \left(\frac{|\rho|^{l'-l}}{1-\rho^2} + \frac{|\rho|^{l+l'}}{1-\rho^2} + (l'-l)|\rho|^{l'-l} \right) \leq C \sum_{j=p+1}^\infty \beta_j^2 = o(p^{-1/2})$$

by Lemma A.2(ii)–(iv). For the term L_2 we have

$$L_{2} = \sum_{l=1}^{p} \sum_{l'=p+1}^{\infty} \beta_{l} \beta_{l'} \sum_{k=p+1}^{\infty} \rho^{k-l+|k-l'|} = \sum_{l=1}^{p} \sum_{l'=p+1}^{\infty} \beta_{l} \beta_{l'} \bigg(\sum_{k=p+1}^{l'} \rho^{l'-l} + \sum_{k=l'+1}^{\infty} \rho^{2k-l-l'} \bigg).$$

Thus, by Lemma A.2(ii)-(iii),

$$|L_2| \leq \sum_{l=1}^p \sum_{l'=p+1}^\infty |\beta_l| |\beta_{l'}| \Big((l'-l)|\rho|^{l'-l} + \frac{\rho^2}{1-\rho^2} |\rho|^{l'-l} \Big) = o(p^{-1/2}).$$

For the term L_3 we have

$$L_3 = \sum_{l=p+1}^{\infty} \sum_{l'=p+1}^{\infty} \beta_l \beta_{l'} \sum_{k=1}^p \rho^{l+l'-2k} = \sum_{l=p+1}^{\infty} \sum_{l'=p+1}^{\infty} \beta_l \beta_{l'} \left(\frac{\rho^{l'+l-2p}}{1-\rho^2} - \frac{\rho^{l+l'}}{1-\rho^2} \right).$$

Thus,

$$\begin{aligned} |L_3| &\leq \sum_{l=p+1}^{\infty} \sum_{l'=p+1}^{\infty} |\beta_l| |\beta_{l'}| \Big(\frac{|\rho|^{l'+l-2p}}{1-\rho^2} + \frac{|\rho|^{l+l'}}{1-\rho^2} \Big) \\ &\leq \frac{1}{1-\rho^2} \Big(\left(\sum_{l=p+1}^{\infty} |\beta_l| |\rho|^{l-p} \right)^2 + \left(\sum_{l=p+1}^{\infty} |\beta_l| |\rho|^l \right)^2 \Big) \\ &\leq C \sum_{l=p+1}^{\infty} \beta_l^2 + o(p^{-1/2}) = o(p^{-1/2}), \end{aligned}$$

since $\sum_{l=p+1}^{\infty} |\rho|^{2(l-p)} < \infty$ and due to Hölder's inequality. Further, for the term L_4 we have

$$= \frac{\rho^{2}}{1-\rho^{2}} \left(\sum_{l=1}^{p} \beta_{l} \rho^{p-l}\right)^{2} = o(p^{-1/2}),$$

by Lemma A.3. Finally, for L_5 write

$$L_5 = \sum_{k=p+1}^{\infty} \sum_{l=p+1}^{\infty} \beta_l^2 \rho^{2|k-l|} + 2 \sum_{k=p+1}^{\infty} \sum_{l,l'=p+1, l'>l}^{\infty} \beta_l \beta_{l'} \rho^{|k-l|+|k-l'|}.$$

For the first summand, we have

$$\sum_{k,l=p+1}^{\infty} \beta_l^2 \rho^{2|k-l|} = \sum_{l=p+1}^{\infty} \beta_l^2 \sum_{k=p+1}^{\infty} \rho^{2|k-l|} \mathbf{1}_{\{k \ge l\}} + \sum_{l=p+1}^{\infty} \beta_l^2 \sum_{k=p+1}^{\infty} \rho^{2|k-l|} \mathbf{1}_{\{k < l\}}$$

$$= \sum_{l=p+1}^{\infty} \beta_l^2 \sum_{k=l}^{\infty} \rho^{2k-2l} + \sum_{l=p+1}^{\infty} \beta_l^2 \sum_{k=p+1}^{l+1} \rho^{2l-2k}$$

$$= \sum_{l=p+1}^{\infty} \beta_l^2 \left(\left(\frac{1}{1-\rho^2} \right) + \left(-\frac{\rho^{2l-2p}}{1-\rho^2} + \frac{1}{\rho^2 (1-\rho^2)} \right) \right)$$

$$\leq C \sum_{l=p+1}^{\infty} \beta_l^2, \qquad (S2)$$

where $C < \infty$. Similarly,

$$\sum_{k=p+1}^{\infty} \sum_{l'>l}^{\infty} \beta_l \beta_{l'} \rho^{|k-l|+|k-l'|} = \sum_{l=p+1}^{\infty} \sum_{l'=l+1}^{\infty} \sum_{k=p+1}^{\infty} \beta_l \beta_{l'} \rho^{2k-l-l'} \mathbf{1}_{\{k \ge l'>l\}}$$

+
$$\sum_{l=p+1}^{\infty} \sum_{l'=l+1}^{\infty} \sum_{k=p+1}^{\infty} \beta_l \beta_{l'} \rho^{l'-l} \mathbf{1}_{\{l'>k\geq l\}}$$
 (S4)

+
$$\sum_{l=p+1}^{\infty} \sum_{l'=l+1}^{\infty} \sum_{k=p+1}^{\infty} \beta_l \beta_{l'} \rho^{l'+l-2k} \mathbf{1}_{\{l'>l>k\}}.$$
 (S5)

For (S3), write

$$\sum_{l=p+1}^{\infty} \sum_{l'=l+1}^{\infty} \sum_{k=p+1}^{\infty} \beta_l \beta_{l'} \rho^{2k-l-l'} \mathbf{1}_{\{k \ge l' > l\}} = \sum_{l=p+1}^{\infty} \sum_{l'=l+1}^{\infty} \beta_l \beta_{l'} \frac{\rho^{l'-l}}{1-\rho^2}.$$

Thus, by Lemma A.2(i), we have

(iv)
$$\sum_{i,j,k=1}^{p} (\theta_i^{(p)})^2 (\theta_j^{(p)})^2 (\theta_k^{(p)})^2 = o(p^{3/2}).$$

Case (i). We have

$$\sum_{i,j,k=1}^{p} \rho^{|i-j|+|i-k|+|k-j|} = \sum_{i=1}^{p} \sum_{k=1}^{p} \rho^{2|i-k|} + 2\sum_{i>j} \sum_{k=1}^{p} \rho^{|i-j|+|i-k|+|k-j|},$$

where

$$\sum_{i=1}^{p} \sum_{k=1}^{p} \rho^{2|i-k|} = \sum_{i=1}^{p} \left(\sum_{k=1}^{i} \rho^{2(i-k)} + \sum_{k=i+1}^{p} \rho^{2(k-i)} \right) = \mathcal{O}(p),$$
(S7)

and

$$\begin{split} \sum_{j=1}^{p} \sum_{i=j+1}^{p} \sum_{k=1}^{p} \rho^{|i-j|+|i-k|+|k-j|} &= \sum_{j=1}^{p} \sum_{i=j+1}^{p} \sum_{k=1}^{j} \rho^{2i-2k} + \sum_{j=1}^{p} \sum_{i=j+1}^{p} \sum_{k=i+1}^{p} \rho^{2i-2j} \\ &+ \sum_{j=1}^{p} \sum_{i=j+1}^{p} \sum_{k=i+1}^{p} \rho^{2k-2j} \\ &= \frac{\rho^2}{(1-\rho^2)^3} \Big(p(1-\rho^2)(3\rho^{2p}+\rho^2+2) - 2(1+2\rho^2)(1-\rho^{2p}) \Big) \end{split}$$

Observe, that by (S6), we have $p \sum_{i,k=1}^{p} (\theta_i^{(p)})^2 (\theta_k^{(p)})^2 = \mathcal{O}(p)$. Additionally,

$$\sum_{k=l+1}^{l'} \rho^{|k-l|+|k-l'|} = \sum_{k=l+1}^{l'} \rho^{k-l+l'-k} = (l'-l)\rho^{l'-l},$$
$$\sum_{k=l'+1}^{p} \rho^{|k-l|+|k-l'|} = \sum_{k=l'+1}^{p} \rho^{k-l+k-l'} = \frac{\rho^{-l-l'+2}(\rho^{2l'}-\rho^{2p})}{1-\rho^{2}}.$$

By simplifying, it follows that

$$K_{2}(l,l') = \frac{(l-l'-1)\rho^{l'-l} + \rho^{l+l'} + (-l+l'-1)\rho^{l'+2-l} + \rho^{2p+2-l-l'}}{\rho^{2}-1}$$

$$\rightarrow \frac{\rho^{l'-l}((l'-l)(\rho^{2}-1) - 1 - \rho^{2}) + \rho^{l+l'}}{\rho^{2}-1} \quad \text{as } p \to \infty,$$

therefore, using the notation of Definition 5.1, we rewrite

$$\sum_{l'=2}^{\infty} \sum_{l=1}^{l'-1} K_2(l,l') = \sum_{l'=2}^{\infty} \sum_{l=1}^{l'-1} \beta_l \beta_{l'} \left(\rho^{l'-l}(l'-l) + \rho^{l'-l} \frac{1+\rho^2}{1-\rho^2} - \rho^{l'+l} \frac{1}{1-\rho^2} \right)$$
$$= b_1^{(1)}(\rho) + b_1(\rho) \frac{1+\rho^2}{1-\rho^2} - b_2(\rho) \frac{1}{1-\rho^2},$$

which concludes the proof of (A.9).

S5 Proof of results (A.13)–(A.14) of Lemma 5.2(iii)

Proof. First, we establish the following observation:

$$\sum_{l_{2}=1}^{p} |\rho|^{|l_{1}-l_{2}|} = |\rho|^{l_{1}} \sum_{l_{2}=1}^{l_{1}} |\rho|^{-l_{2}} + |\rho|^{-l_{1}} \sum_{l_{2}=l_{1}+1}^{p} |\rho|^{l_{2}}$$

$$= |\rho|^{l_{1}} \frac{|\rho|^{-1}(|\rho|^{-l_{1}}-1)}{|\rho|^{-1}-1} + |\rho|^{-l_{1}} \frac{|\rho|^{l_{1}+1}(|\rho|^{p-l_{1}}-1)}{|\rho|-1}$$

$$= \frac{1+|\rho|-|\rho|^{l_{1}}-|\rho|^{p-l_{1}+1}}{1-|\rho|} \leq \frac{1+|\rho|}{1-|\rho|}.$$
(S9)

Consider $J_1(l)$ in (A.11). By (S9), write,

$$J_{1}(l) = \sum_{k,k'=1}^{p} \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l|} \mathbf{1}_{\{l=l'\}} = \sum_{k=1}^{p} \rho^{2|k-l|} + 2\sum_{k < k'} \rho^{|k'-k|+|k-l|+|k'-l|}$$
$$= \frac{1}{1-\rho^{2}} \left(1+\rho^{2}-\rho^{2l}-\rho^{2(p-l+1)}\right) + 2\sum_{k < k'} \rho^{|k'-k|+|k-l|+|k'-l|}.$$

Observe, that

$$\sum_{l=1}^{p} \beta_{l}^{2} \rho^{2(p-l+1)} = \sum_{l=1}^{\lfloor \sqrt{p} \rfloor} \beta_{l}^{2} \rho^{2(p-l+1)} + \sum_{l=\lfloor \sqrt{p} \rfloor+1}^{p} \beta_{l}^{2} \rho^{2(p-l+1)}$$

$$\leq \rho^{2(p-\lfloor \sqrt{p} \rfloor+1)} \sum_{l=1}^{\lfloor \sqrt{p} \rfloor} \beta_{l}^{2} + \rho^{2} \sum_{l=\lfloor \sqrt{p} \rfloor+1}^{p} \beta_{l}^{2} \to 0.$$
(S10)

Hence,

$$\sum_{l=1}^{p} \beta_l^2 \sum_{k=1}^{p} \rho^{2|k-l|} \rightarrow \frac{1+\rho^2}{1-\rho^2} \sum_{k=1}^{\infty} \beta_l^2 - \frac{1}{1-\rho^2} \sum_{k=1}^{\infty} \beta_l^2 \rho^{2l}$$
$$= \beta(1) \frac{1+\rho^2}{1-\rho^2} - \beta(\rho^2) \frac{1}{1-\rho^2}.$$
(S11)

Similarly,

$$\sum_{k < k'} \rho^{|k'-k|+|k-l|+|k'-l|} = \sum_{k < k'} \rho^{2l-2k} \mathbb{1}_{\{l \ge k\}} + \sum_{k < k'} \rho^{2k'-2k} \mathbb{1}_{\{k < l \le k'\}} + \sum_{k < k'} \rho^{2k'-2l} \mathbb{1}_{\{k' > l\}}.$$

The first term can be rewritten,

$$\sum_{k < k'} \rho^{2l-2k} \mathbb{1}_{\{l \ge k\}} = \sum_{k=1}^{l} \sum_{k'=k+1}^{l} \rho^{2l-2k} = \frac{\rho^{2l} \left(-l+l\rho^2-\rho^2\right)+\rho^2}{\left(1-\rho^2\right)^2}.$$

We get

$$\sum_{l=1}^{p} \beta_{l}^{2} \sum_{k < k'} \rho^{2l-2k} = \sum_{l=1}^{p} \beta_{l}^{2} \frac{\rho^{2l} \left(-l+l\rho^{2}-\rho^{2}\right)+\rho^{2}}{\left(1-\rho^{2}\right)^{2}} \\ \rightarrow \frac{\rho^{2}}{\left(1-\rho^{2}\right)^{2}} \beta(1) - \frac{1}{1-\rho^{2}} \beta^{(1)}(\rho^{2}) - \frac{\rho^{2}}{\left(1-\rho^{2}\right)^{2}} \beta(\rho^{2}).$$
(S12)

Similarly,

$$\begin{split} \sum_{k < k'} \rho^{2k' - 2k} \mathbb{1}_{\{k < l \le k'\}} &= \sum_{k=1}^{l} \sum_{k'=l+1}^{p} \rho^{2k' - 2k} \\ &= -\frac{\rho^{2(p-l+1)}}{(1-\rho^2)^2} - \frac{\rho^{2(l+1)}}{(1-\rho^2)^2} + \frac{\rho^{2(p+1)}}{(1-\rho^2)^2} + \frac{\rho^2}{(1-\rho^2)^2}, \end{split}$$

where due to (S10),

$$\sum_{l=1}^{p} \beta_{l}^{2} \sum_{k < k'} \rho^{2k'-2k} \mathbb{1}_{\{k < l \le k'\}} \rightarrow \sum_{l=1}^{\infty} \beta_{l}^{2} \left(\frac{\rho^{2}}{(1-\rho^{2})^{2}} - \frac{\rho^{2(l+1)}}{(1-\rho^{2})^{2}} \right)$$
$$= \frac{\rho^{2}}{(1-\rho^{2})^{2}} \beta(1) - \frac{\rho^{2}}{(1-\rho^{2})^{2}} \beta(\rho^{2}).$$
(S13)

Finally, observe that

$$\begin{split} \sum_{k < k'} \rho^{2k' - 2l} \mathbb{1}_{\{k' < l\}} &= \sum_{k=l+1}^{p-1} \sum_{k'=k+1}^{p} \rho^{2k' - 2l} \\ &= \frac{(p-l)\rho^{2(p-l+1)}}{(1-\rho^2)^2} - \frac{(p-l+1)\rho^{2(p-l+2)}}{(1-\rho^2)^2} + \frac{\rho^4}{(1-\rho^2)^2}, \end{split}$$

where due to (S10), it remains to see that, as $p \to \infty$,

$$\sum_{l=1}^{p} \beta_l^2 \sum_{k < k'} \rho^{2k'-2l} \mathbb{1}_{\{k' < l\}} \quad \to \quad \sum_{l=1}^{\infty} \beta_l^2 \frac{\rho^4}{(1-\rho^2)^2} = \frac{\rho^4}{(1-\rho^2)^2} \beta(1).$$
(S14)

Finally, by collecting the terms of (S12), (S13) and (S14) and simplifying, we get

$$\begin{split} \lim_{p \to \infty} \sum_{l=1}^{p} \beta_{l}^{2} \sum_{k < k'}^{p} \rho^{|k'-k|+|k-l|+|k'-l|} &= \frac{\rho^{4}}{(1-\rho^{2})^{2}} \beta(1) - \frac{\rho^{2}}{(1-\rho^{2})^{2}} \beta(\rho^{2}) + \frac{2\rho^{2}}{(1-\rho^{2})^{2}} \beta(1) \\ &- \frac{1}{1-\rho^{2}} \beta^{(1)}(\rho^{2}) - \frac{\rho^{2}}{(1-\rho^{2})^{2}} \beta(\rho^{2}) \\ &= \beta(1) \Big(\frac{\rho^{2}(\rho^{2}+2)}{(1-\rho^{2})^{2}} \Big) - \beta(\rho^{2}) \Big(\frac{2\rho^{2}}{(1-\rho^{2})^{2}} \Big) - \frac{\beta^{(1)}(\rho^{2})}{1-\rho^{2}} \Big) \end{split}$$

Therefore, from (S11), (S12), (S13) and (S14),

$$\begin{split} \sum_{l=1}^{p} \beta_{l}^{2} J_{1}(l) &\to \beta(1) \frac{1+\rho^{2}}{1-\rho^{2}} - \frac{1}{1-\rho^{2}} \beta(\rho^{2}) \\ &+ 2 \left(\beta(1) \frac{\rho^{2}(\rho^{2}+2)}{(1-\rho^{2})^{2}} - \beta(\rho^{2}) \frac{2\rho^{2}}{(1-\rho^{2})^{2}} - \frac{1}{1-\rho^{2}} \beta^{(1)}(\rho^{2}) \right) \\ &= \beta(1) \frac{\rho^{4}+4\rho^{2}+1}{(1-\rho^{2})^{2}} - \beta(\rho^{2}) \frac{3\rho^{2}+1}{(1-\rho^{2})^{2}} - \frac{2}{1-\rho^{2}} \beta^{(1)}(\rho^{2}), \end{split}$$

which concludes the proof of (A.13).

Next, consider $J_2(l, l')$ in (A.12). According to the arrangement of indices k, k, l, l', we have 9 cases:

 $\underline{\text{Case } 1}$:

$$\sum_{k,k'=1}^{p} \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l'|} \mathbf{1}_{\{k,k' \le l\}} = \rho^{l+l'} \sum_{k,k'=1}^{l} \rho^{|k-k'|-k-k'} \\ = \frac{(-(2l+1)\rho^{2l} + (2l-1)\rho^{2l+2} + \rho^2 + 1)\rho^{l'-l}}{(1-\rho^2)^2}.$$

 $\underline{\text{Case } 2}$:

$$\sum_{k,k'=1}^{p} \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l'|} \mathbf{1}_{\{k \le l, l < k' \le l'\}} = \rho^{l+l'} \sum_{k=1}^{l} \sum_{k'=l+1}^{l'} \rho^{-2k}$$
$$= \frac{(1-\rho^{2l})(l'-l)\rho^{l'-l}}{1-\rho^2}.$$

 $\underline{\text{Case } 3}$:

$$\begin{split} \sum_{k,k'=1}^{p} \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l'|} \mathbf{1}_{\{k \le l, l' < k' \le p\}} &= \rho^{l-l'} \sum_{k=1}^{l} \sum_{k'=l'+1}^{p} \rho^{-2k+2k'} \\ &= \frac{(1-\rho^{2l})\rho^{-l'-l+2}(\rho^{2l'}-\rho^{2p})}{(1-\rho^{2})^{2}}. \end{split}$$

 $\underline{\text{Case } 4}$:

$$\begin{split} \sum_{k,k'=1}^{p} \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l'|} \mathbf{1}_{\{l < k \le l', 1 \le k' \le l\}} &= \rho^{-l+l'} \sum_{k=l+1}^{l'} \sum_{k'=1}^{l} \rho^{2k-2k'} \\ &= \frac{(1-\rho^{2l})\rho^{l'-3l+2}(\rho^{2l}-\rho^{2l'})}{(1-\rho^{2})^2}. \end{split}$$

 $\underline{\text{Case } 5}$:

$$\begin{split} \sum_{k,k'=1}^{p} \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l'|} \mathbf{1}_{\{l < k,k' \le l'\}} &= \rho^{-l+l'} \sum_{k,k'=l+1}^{l'} \rho^{|k-k'|+k-k'} \\ &= \rho^{-l+l'} \bigg(\sum_{k=l+1}^{l'} \sum_{k':k' \ge k}^{l'} 1 + \sum_{k=l+1}^{l'} \sum_{k':k' \ge l+1}^{k-1} \rho^{2k-2k'} \bigg) \\ &= \frac{1}{2} \rho^{l'-3l} \bigg(\rho^{2l} (-l'+l-1)(l-l') \\ &+ \frac{2\rho^2 \big((1-\rho^2) \rho^{2l} l' + \rho^{2l'} - (l+1) \rho^{2l} + l \rho^{2l+2} \big)}{(1-\rho^2)^2} \bigg). \end{split}$$

 $\underline{\text{Case } 6}$:

$$\sum_{k,k'=1}^{p} \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l'|} \mathbf{1}_{\{l < k \le l', l' < k' \le p\}} = \rho^{-l-l'} \sum_{k=l+1}^{l'} \sum_{k'=l'+1}^{p} \rho^{2k'}$$
$$= \frac{(l'-l) \rho^{-l'-l+2} (\rho^{2l'} - \rho^{2p})}{1 - \rho^2}.$$

 $\underline{\text{Case } 7}$:

$$\sum_{k,k'=1}^{p} \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l'|} \mathbf{1}_{\{l' < k \le p, 1 \le k' \le l\}} = \rho^{-l+l'} \sum_{k=l'+1}^{p} \sum_{k'=1}^{l} \rho^{2k-2k'} = \frac{(1-\rho^{2l})\rho^{l'-3l+2}(\rho^{2l'}-\rho^{2p})}{(1-\rho^2)^2}.$$

<u>Case 8</u>: We have

$$\begin{split} \sum_{k,k'=1}^{p} \rho^{|k-k'|} \rho^{|k-l|} \rho^{|k'-l'|} \mathbf{1}_{\{l' < k \le p, l < k' \le l'\}} &= \rho^{-l+l'} \sum_{k=l'+1}^{p} \sum_{k'=l+1}^{l'} \rho^{2k-2k'} \\ &= \frac{\rho^{-3l-l'+2} (\rho^{2l} - \rho^{2l'}) (\rho^{2l'} - \rho^{2p})}{(1 - \rho^2)^2}. \end{split}$$

<u>Case 9</u>: We have

The two summands of (S15) are symmetric, therefore due to brevity we consider only the first term. The proof for the second term will be analogous. Note,

(S16)

where

$$\sum_{l=1}^{p-1} |\beta_l| |\rho|^{p-l} (p-l) \leq \left(\sum_{l=1}^{p-1} \beta_l^2\right)^{1/2} \left(\sum_{l=1}^{p-1} \rho^{2(p-l)} (p-l)^2\right)^{1/2} < \infty$$

holds due to $\sum_{j=1}^\infty \beta_j^2 < \infty.$ It remains to note that

$$\begin{split} \sum_{l'=2}^{p} |\beta_{l'}||\rho|^{p-l'} &= \sum_{l'=2}^{\lfloor\sqrt{p}\rfloor} |\beta_{l'}||\rho|^{p-l'} + \sum_{l'=\lfloor\sqrt{p}\rfloor+1}^{p} |\beta_{l'}||\rho|^{p-l'} \\ &\leq |\rho|^{p-\lfloor\sqrt{p}\rfloor} p^{1/4} \bigg(\sum_{l'=2}^{\lfloor\sqrt{p}\rfloor} \beta_{l'}^2 \bigg)^{1/2} + \bigg(\sum_{l'=\lfloor\sqrt{p}\rfloor+1}^{p} \beta_{l'}^2 \bigg)^{1/2} \bigg(\sum_{l'=\lfloor\sqrt{p}\rfloor+1}^{p} \rho^{2(p-l')} \bigg)^{1/2} \\ &\to 0, \end{split}$$

since $\sum_{l'=2}^{\lfloor\sqrt{p}\rfloor}\beta_{l'}^2 < \infty$ and $\sum_{l'=\lfloor\sqrt{p}\rfloor+1}^p |\rho|^{2(p-l')} < \infty$. Thus, by (S15) and (S16), it follows that

$$\begin{split} \sum_{l'>l} \beta_l \beta_{l'} J_2(l,l') &= \frac{1}{2(1-\rho^2)^2} \bigg(\sum_{l'>l} \beta_l \beta_{l'} \rho^{l'-l} \big((l'-l)^2 (1-\rho^2)^2 \\ &+ 3(1-\rho^4) (l'-l) + 2(1+4\rho^2+\rho^4) \big) \\ &+ \sum_{l'>l} \beta_l \beta_{l'} \rho^{l'+l} \big(-2(1-\rho^2) (l'+l) - 2 - 6\rho^2 \big) \\ &\to \frac{1}{2(1-\rho^2)^2} \big(b^{(2)}(\rho) (1-\rho^2)^2 + 3b_1^{(1)}(\rho) (1-\rho^4) \\ &+ 2b_1(\rho) (1+4\rho^2+\rho^4) - 2b_2^{(1)}(\rho) (1-\rho^2) - 2b_2(\rho) (1+3\rho^2) \big), \end{split}$$

which concludes the proof of (A.14).
