On the surplus management of funds with assets and liabilities in presence of solvency requirements

Abstract

In this paper we consider a company whose assets and liabilities evolve according to a correlated bivariate geometric Brownian motion, such as in Gerber and Shiu (2003). We determine what dividend strategy maximises the expected present value of dividends until ruin in two cases: (i) when shareholders won't cover surplus shortfalls and a solvency constraint (as in Paulsen, 2003) is consequently imposed, and (ii) when shareholders are always to fund any capital deficiency with capital (asset) injections. In the latter case, ruin will never occur and the objective is to maximise the difference between dividends and capital injections.

Developing and using appropriate verification lemmas, we show that the optimal dividend strategy is, in both cases, of barrier type. Both value functions are derived in closed form. Furthermore, the barrier is defined on the ratio of assets to liabilities, which mimics some of the dividend strategies that can be observed in practice by insurance companies. Existence and uniqueness of the optimal strategies are shown. Results are illustrated.

1. Introduction

1.1. Motivation and main contributions

The optimisation problem that is described in many modern definitions of *Enterprise Risk Management* ("ERM", see, e.g., Taylor, 2015) is one that is closely related to the so-called *stability problem* in actuarial risk theory (see, e.g., Bühlmann, 1970). How to distribute dividends is one consideration (see, e.g. Albrecher and Thonhauser, 2009; Avanzi, 2009, for reviews of the literature in actuarial risk theory). For instance, the Australian Actuaries Institute (2016) write:

An insurer's target capital policy is an integral part of its risk and capital management plans, and is likely to be used to inform dividend policy and to determine capital management triggers and mitigating actions required such as capital raising or distributions.

In this paper, we consider a risky company, whose assets and liabilities follow a bivariate geometric Brownian motion with dependence. Such a model was considered by Gerber and Shiu (2003), who conjectured that a barrier strategy formulated on the funding ratio of assets to liabilities was the optimal strategy. Sometimes, insurance companies use such a funding ratio based method to set their target capital;

see for example Australian Actuaries Institute (2016); International Actuarial Association (IAA) (2016). The conjecture of Gerber and Shiu (2003) was subsequently proven by Decamps, Schepper, and Goovaerts (2009). Other relevant references are Decamps, Schepper, and Goovaerts (2006, without optimality, but with finite horizon), Chen and Yang (2010, without optimality, but with regime-switching dynamics), and Avanzi, Henriksen, and Wong (2018, without optimality, but with recovery requirements).

In this paper the company is underfunded, and ruined, if its funding ratio decreases below a certain level α_0 . This level would typically be 1, but it only needs to be positive in this paper. For instance, a higher level than 1 could reflect the higher liquidation value of liabilities (as opposed to going-concern value).

In this paper, we are interested in determining the optimal dividend strategy in the presence of solvency considerations. Specifically, we consider two cases. In the first case, shareholders won't be held liable further than the value of the company. In this case, a solvency constraint $\alpha_1 > \alpha_0$ on the surplus level is introduced, below which no dividends are allowed to be paid. Note that our formulation differs from Decamps, Schepper, and Goovaerts (2009), where the authors also propose to model the assets and liabilities of a company by means of correlated geometric Brownian motion and where they also formulate an optimal control problem based on the funding ratio, but without a solvency constraint. In our paper, a dividend payment cannot bring the surplus level below a given solvency constraint. In the second case, shareholders will always inject capital if needed. Consequently, ruin does not occur, and shareholders will maximise the difference between dividends and capital injections. Lest the problem becomes trivial, capital injections attract transaction costs. With proportional transaction costs, it turns out (unsurprisingly) that if such measures are warranted (have positive expected value), these will be made only at level α_0 to avoid bankruptcy. A recent treatment of optimal dividends and capital injections with transaction costs is Lindensjö and Lindskog (2020), although they considered a pure diffusion rather than a ratio of two correlated geometric Brownian motions as in this paper.

Both cases described above make sense in a practical setting. Trigger points are routinely used to define different stress situations (e.g., exceeding target vs below target). Furthermore, resulting actions from management may include the injection of capital, or the reduction of dividends (see, e.g., Australian Actuaries Institute, 2016); see also Avanzi, Henriksen, and Wong (2018).

The paper is structured as follows. Section 2 establishes the optimal dividend strategy, if ruin occurs as soon as liabilities are worth less than α_0 assets and in presence of a solvency constraint $\alpha_1 > \alpha_0$. Section 3 considers the case where capital injections are always made at α_0 to prevent ruin. Numerical illustrations are presented in Section 4.

Remark 1.1. Note that we do not consider a solvency constraint α_1 when capital injections are forced. This is mainly because the shareholders bear the entire responsibility of a shortfall, and then there is no point in restricting the amount of dividends they can distribute from a regulatory point of view.

That being said, the company could decide to self-inflict this constraint, as it can significantly improve the stability of the outcomes for minor cost in expectation, as discussed in Section 4.1 (see also Avanzi and Wong, 2012; Avanzi, Henriksen, and Wong, 2018). One could even imagine optimising this parameter, subject to a maximum coefficient of variation of the present value of dividends (when considered as a random variable). We conjecture that the optimal dividend strategy would remain of barrier type.

1.2. The bivariate asset and liability process

Let $(\Omega, \{\mathcal{F}_t; t \ge 0\}, \mathbb{P})$ be a filtrated probability space as usually defined. We consider a risky company, whose assets $X_1 := \{X_1(t) : t \ge 0\}$ and liabilities $X_2 := \{X_2(t) : t \ge 0\}$, respectively, follow a bivariate geometric Brownian motion with correlation $\rho \in (-1, 1)$. That is, the uncontrolled processes (X_1, X_2) follow the dynamics

$$d\begin{pmatrix} X_1(t)\\ X_2(t) \end{pmatrix} = \begin{pmatrix} \mu_A & 0\\ 0 & \mu_L \end{pmatrix} \begin{pmatrix} X_1(t)\\ X_2(t) \end{pmatrix} dt + \begin{pmatrix} \sigma_A X_1(t) & 0\\ \rho \sigma_L X_2(t) & \sqrt{1 - \rho^2} \sigma_L X_2(t) \end{pmatrix} d\begin{pmatrix} W_1(t)\\ W_2(t) \end{pmatrix},$$
(1.1)

where $X_1(0) = A_0 > 0$, $X_2(0) = L_0 > 0$, $\sigma_A > 0$, $\sigma_L > 0$, and where $W_1 := \{W_1(t) : t \ge 0\}$ and $W_2 := \{W_2(t) : t \ge 0\}$ are standard Brownian motions. Furthermore, we define the funding ratio process

 $Y := \{Y(t) : t \ge 0\}$ with

$$Y(t) = \frac{X_1(t)}{X_2(t)}, \quad t \ge 0$$

This is the same model as in Gerber and Shiu (2003).

2. The optimal dividend strategy under a solvency constraint

2.1. Model formulation

In this section, we discuss the case where we are allowed to distribute assets according to a strategy π , i.e.

$$X_1^{\pi}(t) = X_1(t) - D^{\pi}(t), \qquad (2.1)$$

where $D^{\pi} := \{D^{\pi}(t) : t \ge 0\}$, the aggregate dividend process, is a càdlàg, non-decreasing process which is adapted to $\{\mathcal{F}_t; t \ge 0\}$, the filtration generated by the bivariate process (X_1, X_2) . The modified funding ratio (for a strategy π) is then defined as $Y^{\pi} := \{Y^{\pi}(t) : t \ge 0\}$ given by

$$Y^{\pi}(t) = \frac{X_1^{\pi}(t)}{X_2(t)}.$$
(2.2)

We now introduce the ruin level α_0 such that the company is ruined whenever its funding ratio (asset divided by liability) downcrosses α_0 . In this case, the time of ruin, $\tau^{\pi}_{\alpha_0}$, is defined as the first time the modified funding ratio Y^{π} reaches α_0 , i.e.

$$\tau_{\alpha_0}^{\pi} := \inf \left\{ t \ge 0 : Y^{\pi}(t) \le \alpha_0 \right\}$$
(2.3)

with the convention that $\inf\{\emptyset\} = \infty$. For convenience, we define (the funding ratio set) $L: 2^{\mathbb{R}_+} \to 2^{\mathbb{R}_+^2}$ with

$$L(B) = \left\{ (x, y) : \frac{x}{y} \in B \right\}.$$
(2.4)

For a set B, we use the notation 2^B for its power set (the set of all subsets of B), i.e. $2^B := \{X : X \subseteq B\}$). In this sense, we can see that ruin occurs at the first time the process (X_1^{π}, X_2) is outside $L((\alpha_0, \infty))$.

We require that

$$\frac{A_0}{L_0} \ge \alpha_0, \tag{2.5}$$

or equivalently $(X_1(0), X_2(0)) \in L([\alpha_0, \infty))$. While we need to consider $A_0/L_0 = \alpha_0$ as a boundary case, it would not make sense to start at a lower level.

In this sense, the bivariate process after payments of dividends is given by

$$d\begin{pmatrix} X_{1}^{\pi}(t) \\ X_{2}(t) \end{pmatrix} = \begin{pmatrix} \mu_{A} & 0 \\ 0 & \mu_{L} \end{pmatrix} \begin{pmatrix} X_{1}^{\pi}(t) \\ X_{2}(t) \end{pmatrix} dt + \begin{pmatrix} \sigma_{A}X_{1}^{\pi}(t) & 0 \\ \rho\sigma_{L}X_{2}(t) & \sqrt{1 - \rho^{2}}\sigma_{L}X_{2}(t) \end{pmatrix} d\begin{pmatrix} W_{1}(t) \\ W_{2}(t) \end{pmatrix} - d\begin{pmatrix} D^{\pi}(t) \\ 0 \end{pmatrix}.$$




Figure 1: Figures illustrating the model. The uncontrolled processes are in black and the controlled processes are in grey. The dotted lines depict the undiscounted, aggregate payment process.

A sample path of (X_1^{π}, X_2) is illustrated in Figure 1. Note that the subscript "*R*" indicates that we consider a model with solvency constraint where ruin is possible. Likewise, we will throughout the paper use the subscript "*CI*" in Section 3 where ruin is prevented by capital injections.

For a given (dividend) strategy π , we measure its performance by its expected present value. That is, if we denote the discount rate $\delta > 0$ and the shifted operator $\mathbb{E}^{x_1,x_2}[\cdot] := \mathbb{E}[\cdot|X_1(0) = x_1, X_2(0) = x_2]$, then the performance function is given by

$$J_R(x_1, x_2; \pi) = \mathbb{E}^{x_1, x_2} \left[\int_0^{\tau_{\alpha_0}^{\pi}} e^{-\delta s} dD^{\pi}(s) \right].$$
(2.6)

In this section we consider a solvency constraint level $\alpha_1 > \alpha_0$ such that after paying the dividend, the surplus level can never be less than α_1 . This is equivalent to the constraint introduced in Paulsen (2003, in a univariate, pure diffusion setting). In mathematical terms, this constraint translates into the condition

$$\int_{0}^{\tau_{\alpha_{0}}^{\pi}} \mathbf{1}_{\{Y^{\pi}(s) < \alpha_{1}\}} dD^{\pi}(s) = 0.$$
(2.7)

In this sense, a strategy π is said to be admissible if D^{π} is a non-decreasing, càdlàg, $\{\mathcal{F}_t; t \geq 0\}$ -adapted process with $D^{\pi}(0-) = 0$, and (2.7) satisfied. We denote Π_R as the set of admissible strategies.

Denote the optimal value function

$$J_R^*(x_1, x_2) := \sup_{\pi \in \Pi_R} J_R(x_1, x_2; \pi).$$
(2.8)

We are interested in finding an optimal strategy π^* such that

$$J_R(x_1, x_2; \pi^*) = J_R^*(x_1, x_2).$$
(2.9)

Finally, for the model to make sense, we impose the profitable condition

$$\mu_A > \mu_L \tag{2.10}$$

and require (as in Gerber and Shiu, 2003)

$$\delta > \mu_A \tag{2.11}$$

such that the optimal value function J_R^* is finite.

2.2. Verification lemma

We define the extended generator \mathscr{A} for the bivariate process (X_1, X_2) as

$$\mathscr{A}f(x_{1}, x_{2}) = \mu_{A}x_{1}\frac{\partial}{\partial x_{1}}f(x_{1}, x_{2}) + \mu_{L}x_{2}\frac{\partial}{\partial x_{2}}f(x_{1}, x_{2}) + \frac{1}{2}\sigma_{A}^{2}x_{1}^{2}\frac{\partial^{2}}{\partial x_{1}^{2}}f(x_{1}, x_{2}) + \frac{1}{2}\sigma_{L}^{2}x_{2}^{2}\frac{\partial^{2}}{\partial x_{2}^{2}}f(x_{1}, x_{2}) + \rho\sigma_{A}\sigma_{L}x_{1}x_{2}\frac{\partial^{2}}{\partial x_{1}\partial x_{2}}f(x_{1}, x_{2}),$$
(2.12)

for a function f and (x_1, x_2) such that the above is well-defined. Now, under the model described in Section 2.1, one sufficient condition for a strategy $\pi \in \Pi_R$ to be optimal is given by the following lemma.

Throughout the paper, we use \mathscr{C}^1 to denote the class of continuously differentiable functions, and \mathscr{C}^2 for the class with the first and second derivative of the function both existing and continuous.

Lemma 2.1. For a strategy $\tilde{\pi} \in \Pi_R$, denote its value function $H(x_1, x_2) := J_R(x_1, x_2; \tilde{\pi})$. Suppose H satisfies the following six conditions

- 1. $H(x_1, x_2) \ge 0$ on $L([\alpha_0, \infty))$,
- 2. $H(x_1, x_2) \in \mathscr{C}^1(L([\alpha_0, \infty)) \cap \mathscr{C}^2(L([\alpha_0, \infty) \setminus L(\{\alpha_1\}))),$ 3. For each $n \in \mathbb{N}$, the following holds: On $L([\alpha_0 + \frac{1}{n}, \alpha_0 + n))$, all partial derivatives of H are bounded, i.e. there is a positive number K such that

$$\max\left(\left|\frac{\partial}{\partial x_1}H(x_1,x_2)\right|, \left|\frac{\partial}{\partial x_2}H(x_1,x_2)\right|\right) \le K \text{ for all } (x_1,x_2) \in L([\alpha_0,\infty)),$$

 $(\mathscr{A} - \delta)H(x_1, x_2) = 0,$

4. On $L([\alpha_1, \infty))$, H satisfies

$$\frac{\partial}{\partial x_1} H(x_1, x_2) \ge 1, \tag{2.13}$$

(2.14)

- 5. On $L((\alpha_0, \alpha_1))$, H satisfies
- 6. On $L((\alpha_1, \infty))$, H satisfies

$$(\mathscr{A} - \delta)H(x_1, x_2) \le 0. \tag{2.15}$$

Then $\tilde{\pi}$ is optimal, that is, $\tilde{\pi} = \pi^*$, and $J_R(x_1, x_2; \pi^*) = J_R^*(x_1, x_2)$ for all $(x_1, x_2) \in L([\alpha_0, \infty))$.

Proof. According to the definition of optimal value function in (2.8), we have $H(x_1, x_2) \leq J_R^*(x_1, x_2)$. Then it suffices to show that

$$H(x_1, x_2) \ge J_R(x_1, x_2; \pi)$$

for any strategy $\pi \in \Pi_R$.

For any $\pi \in \Pi_R$, we denote the family of sequential stopping times $\{T_n, n \in \mathbb{N}\}$ when the funding ratio of the modified process is outside the interval $[\alpha_0 + \frac{1}{n}, \alpha_0 + n)$, i.e.

$$T_n := \inf\{t \ge 0 : Y^{\pi}(t) \notin [\alpha_0 + \frac{1}{n}, \alpha_0 + n)\}.$$

First, from (2.13), for any $(x_1, x_2) \in L([\alpha_1, \infty))$ and $d \ge 0$, we have

$$H(x_1 + d, x_2) - H(x_1, x_2) = \int_{x_1}^{x_1 + d} \frac{\partial}{\partial x} H(x, x_2) dx \ge \int_{x_1}^{x_1 + d} dx = d,$$

which gives

$$H(x_1 + d, x_2) \ge H(x_1, x_2) + d. \tag{2.16}$$

For $(x_1, x_2) \in L([\alpha_1, \infty))$, it is obvious to have $(x_1 + d, x_2) \in L([\alpha_1, \infty))$. For any dividend strategy π with $D^{\pi}(0) = d > 0$, we revise π by removing its dividend distribution at t = 0 without changing its distributions at other time points, then as revealed by (2.16), the resulting value function associated with $(x_1 + d, x_2)$ is non-decreasing. Or, equivalently, for any $(x_1 - d, x_2) \in L([\alpha_1, \infty))$, we obtain

$$H(x_1 - d, x_2) + d \le H(x_1, x_2).$$

Then it suffices to consider the case with the dividend distribution at time 0 is $D^{\pi}(0) = 0$. Now, we shall note that H is not \mathscr{C}^2 over the entire range $[\alpha_0, \infty)$ and therefore we shall use the generalization of Itô's formula, the so-called Meyer-Itô Formula (e.g. Theorem 70 in Chaper IV in Protter, 2005). As pointed out by Peskir (2005), $H(x_1, x_2) \in \mathscr{C}^1$ is enough to exclude the local time at $L(\{\alpha_1\})$ so that with Condition 2 in Lemma 2.1, we can proceed with the Itô's lemma in its standard form.

On the event $\{X_1(0) = x_1, X_2(0) = x_2\}$, by using Itô's lemma for the stopped jump diffusion processes $\{e^{-\delta(t\wedge T_n)}H(X_1^{\pi}(t\wedge T_n), X_2(t\wedge T_n))\}$, we get that

$$\begin{split} &e^{-\delta(t\wedge T_n)}H(X_1^{\pi}(t\wedge T_n), X_2(t\wedge T_n)) \\ &= H(x_1, x_2) - \int_{0-}^{t\wedge T_n} \delta e^{-\delta s} H(X_1^{\pi}(s-), X_2(s-)) ds \\ &+ \int_{0-}^{t\wedge T_n} e^{-\delta s} \frac{\partial}{\partial x_1} H(X_1^{\pi}(s-), X_2(s-)) dX_1^{\pi,c}(s) \\ &+ \int_{0-}^{t\wedge T_n} e^{-\delta s} \frac{\partial}{\partial x_2} H(X_1^{\pi}(s-), X_2(s-)) dX_2(s) \\ &+ \int_{0-}^{t\wedge T_n} e^{-\delta s} \frac{\sigma_A^2(X_1^{\pi}(s-))^2}{2} \frac{\partial^2}{\partial x_1^2} H(X_1^{\pi}(s-), X_2(s-)) \mathbf{1}_{\{(X_1^{\pi}(s-), X_2(s-))\notin L(\{\alpha_1\})\}} ds \\ &+ \int_{0-}^{t\wedge T_n} e^{-\delta s} \frac{\sigma_L^2(X_2(s-))^2}{2} \frac{\partial^2}{\partial x_2^2} H(X_1^{\pi}(s-), X_2(s-)) \mathbf{1}_{\{(X_1^{\pi}(s-), X_2(s-))\notin L(\{\alpha_1\})\}} ds \\ &+ \int_{0-}^{t\wedge T_n} e^{-\delta s} \rho \sigma_A \sigma_L X_1^{\pi}(s-) X_2(s-) \frac{\partial^2}{\partial x_1 \partial x_2} H(X_1^{\pi}(s-), X_2(s-)) \mathbf{1}_{\{(X_1^{\pi}(s-), X_2(s-))\notin L(\{\alpha_1\})\}} ds \\ &+ \sum_{s \leq t\wedge T_n} e^{-\delta s} \left[H(X_1^{\pi}(s), X_2(s)) - H(X_1^{\pi}(s-), X_2(s-)) \right], \end{split}$$

where $X_1^{\pi,c}$ is the continuous part of X_1^{π} and we have used the fact that the discontinuity comes from the dividends $(-\Delta X_1^{\pi})$.

Furthermore, using $dX_1^{\pi,c}(s) = \mu_A X_1^{\pi,c}(s) ds + \sigma_A X_1^{\pi,c}(s) dW_1(s) - dD^{\pi,c}(s)$ where $D^{\pi,c}$ is the continuous

part of D^{π} , and similarly for $X_2(s)$, by collecting terms, we have

$$\begin{split} e^{-\delta(t\wedge T_{n})}H(X_{1}^{\pi}(t\wedge T_{n}), X_{2}(t\wedge T_{n})) \\ &= H(x_{1}, x_{2}) + \int_{0-}^{t\wedge T_{n}} e^{-\delta s} (\mathscr{A} - \delta)H(X_{1}^{\pi}(s-), X_{2}(s-))\mathbf{1}_{\{(X_{1}^{\pi}(s-), X_{2}(s-))\notin L(\{\alpha_{1}\})\}} ds \\ &+ \int_{0-}^{t\wedge T_{n}} e^{-\delta s} \sigma_{A} X_{1}^{\pi}(s-) \frac{\partial}{\partial x_{1}} H(X_{1}^{\pi}(s-), X_{2}(s-)) dW_{1}(s) \\ &+ \int_{0-}^{t\wedge T_{n}} e^{-\delta s} \rho \sigma_{L} X_{2}(s-) \frac{\partial}{\partial x_{2}} H(X_{1}^{\pi}(s-), X_{2}(s-)) dW_{1}(s) \\ &+ \int_{0-}^{t\wedge T_{n}} e^{-\delta s} \sqrt{1-\rho^{2}} \sigma_{L} X_{2}(s-) \frac{\partial}{\partial x_{2}} H(X_{1}^{\pi}(s-), X_{2}(s-)) dW_{2}(s) \\ &- \int_{0-}^{t\wedge T_{n}} e^{-\delta s} \frac{\partial}{\partial x_{1}} H(X_{1}^{\pi}(s-), X_{2}(s-)) dD^{\pi,c}(s) \\ &+ \sum_{s \leq t\wedge T_{n}} e^{-\delta s} \left[H(X_{1}^{\pi}(s), X_{2}(s)) - H(X_{1}^{\pi}(s-), X_{2}(s-)) \right]. \end{split}$$

We denote the sum of the integrals in the second, the third and the fourth line of the right-hand side of (2.17) by $M(t \wedge T_n)$. After adding and subtracting some terms, we have that

$$\begin{split} &e^{-\delta(t\wedge T_n)}H(X_1^{\pi}(t\wedge T_n), X_2(t\wedge T_n)) \\ &= H(x_1, x_2) + \int_{0-}^{t\wedge T_n} e^{-\delta s} (\mathscr{A} - \delta) H(X_1^{\pi}(s-), X_2(s-)) \mathbf{1}_{\{(X_1^{\pi}(s-), X_2(s-))\notin L(\{\alpha_1\})\}} ds \\ &+ M(t\wedge T_n) \\ &- \int_{0-}^{t\wedge T_n} e^{-\delta s} \left[\frac{\partial}{\partial x_1} H(X_1^{\pi}(s), X_2(s)) - 1 \right] dD^{\pi, c}(s) \\ &+ \sum_{s \leq t\wedge T_n} e^{-\delta s} \left[H(X_1^{\pi}(s-) + \Delta X_1^{\pi}(s), X_2(s)) - H(X_1^{\pi}(s-), X_2(s-)) - \Delta X_1^{\pi}(s) \right] \\ &- \left[\int_{0-}^{t\wedge T_n} e^{-\delta s} dD^{\pi, c}(s) - \sum_{s \leq t\wedge T_n} e^{-\delta s} \Delta X_1^{\pi}(s) \right]. \end{split}$$

Using the fact that (X_1^{π}, X_2) are continuous except at time t when dividends is paid, which changes the X_1^{π} by the amount of $-\Delta X_1^{\pi}(t)$, we deduce that

$$\begin{split} &e^{-\delta(t\wedge T_n)}H(X_1^{\pi}(t\wedge T_n), X_2(t\wedge T_n)) \\ &= H(x_1, x_2) + \int_{0-}^{t\wedge T_n} e^{-\delta s} (\mathscr{A} - \delta) H(X_1^{\pi}(s-), X_2(s-)) \mathbf{1}_{\{(X_1^{\pi}(s-), X_2(s-))\notin L(\{\alpha_1\})\}} ds \\ &+ M(t\wedge T_n) \\ &- \int_{0-}^{t\wedge T_n} e^{-\delta s} \left[\frac{\partial}{\partial x_1} H(X_1^{\pi}(s), X_2(s)) - 1 \right] dD^{\pi, c}(s) \\ &+ \sum_{s \leq t\wedge T_n} e^{-\delta s} \left[H(X_1^{\pi}(s-) - \Delta D^{\pi}(s), X_2(s-)) - H(X_1^{\pi}(s-), X_2(s-)) + \Delta D^{\pi}(s) \right] \\ &- \left[\int_{0-}^{t\wedge T_n} e^{-\delta s} dD^{\pi, c}(s) + \sum_{s \leq t\wedge T_n} e^{-\delta s} \Delta D^{\pi}(s) \right]. \end{split}$$

By rearranging, we get

- \int_{0^{-}}^{t\wedge T_{n}} e^{-\delta s} \left[\frac{\partial}{\partial x_{1}} H(X_{1}^{\pi}(s), X_{2}(s)) - 1 \right] dD^{\pi,c}(s) \\
+ \sum_{s \leq t\wedge T_{n}} e^{-\delta s} \left[H(X_{1}^{\pi}(s-) - \Delta D^{\pi}(s), X_{2}(s-)) - H(X_{1}^{\pi}(s-), X_{2}(s-)) + \Delta D^{\pi}(s) \right].
\end{cases}$$
(2.18)

Now, by hypothesis (Conditions 1,4,5,6), (2.16) and recall the solvency constraint, we have

$$\left[\int_{0-}^{t\wedge T_n} e^{-\delta s} dD^{\pi,c}(s) + \sum_{s\leq t\wedge T_n} e^{-\delta s} \Delta D^{\pi}(s)\right] - M(t\wedge T_n) \leq H(x_1, x_2).$$

By taking expectation, we have

Note that $\{M(t \wedge T_n) : t \ge 0\}$ is a zero-mean martingale by Condition 3, we have

2.3. The value of dividends under a barrier strategy

In this section, we derive the value function of a barrier strategy with an arbitrary barrier level β (disregarding any solvency constraint). The corresponding value function is denoted by

$$G^{\beta}(x_1, x_2) = \mathbb{E}^{x_1, x_2} \left[\int_{0-}^{\tau_{\alpha_0}^{\pi^{\beta}}} e^{-\delta t} dD^{\pi^{\beta}}(t) \right],$$

where $\tau_{\alpha_0}^{\pi^{\beta}}$ is the time of run defined in the previous section, when a barrier strategy with barrier level β , π^{β} , is applied. Note that using a martingale argument, Gerber and Shiu (2003) deduced that the value function G^{β} satisfies the second condition in Lemma 2.1, i.e. $G^{\beta} \in \mathscr{C}^1(L([\alpha_0,\infty)) \cap \mathscr{C}^2(L([\alpha_0,\infty) \setminus L(\{\alpha_1\})))$.

Clearly, the value function of G^{β} is given by

$$G^{\beta}(x_1, x_2) = \begin{cases} G(x_1, x_2; \beta), & (x_1, x_2) \in L([\alpha_0, \beta]), \\ x_1 - \beta x_2 + G(\beta x_2, x_2; \beta), & (x_1, x_2) \in L((\beta, \infty)). \end{cases}$$
(2.19)

with $G(x_1, x_2; \beta)$ given by

$$(\mathscr{A} - \delta)G(x_1, x_2; \beta) = 0 \text{ for } (x_1, x_2) \in L([\alpha_0, \beta]), \quad G(\alpha_0 x_2, x_2; \beta) = 0.$$
 (2.20)

The differential equation (2.20) can be obtained by the following heuristic reasoning. Let $\frac{x_1}{x_2} < \beta \Leftrightarrow x_1 < \beta x_2$. Consider an infinitesimal time interval of length dt such that no dividend is paid during dt. We get that

$$G(x_1, x_2; \beta) = e^{-\delta dt} \mathbb{E} \Big[G \Big(x_1 + \mu_A x_1 dt + \sigma_A x_1 W_1(dt), \\ x_2 + \mu_L x_2 dt + \rho \sigma_L x_2 W_1(dt) + \sqrt{1 - \rho^2} \sigma_L x_2 W_2(dt); \beta \Big) \Big].$$
(2.21)

Developing the expectation using Taylor series, subtracting $G(x_1, x_2; \beta)$ and dividing by dt on both sides yields

$$G(x_1, x_2; \beta)\left(\frac{e^{\delta dt} - 1}{dt}\right) = \mathscr{A}G(x_1, x_2; \beta).$$

We let $dt \to 0$ and using l'Hôpital's rule we obtain (2.20).

The boundary conditions for the value function, which hold for all levels of barrier β , are given by

Condition (2.22) follows directly from the definition of ruin. Condition (2.23) is similar to Gerber and Shiu (2003, Equation (6.4)) which can be obtained using the same heuristic argument.

To find the solution to equation (2.20), we take advantage of the fact that G^{β} (and G) are homogeneous functions of degree 1, which follows since the dynamics of both assets and liabilities are progressing proportionally to the assets and liabilities, respectively. That is, for a given constant ϱ it holds that $G^{\beta}(\varrho x_1, \varrho x_2) = \varrho G^{\beta}(x_1, x_2)$ so that the important quantity (up to a scaling factor) is the ratio x_1/x_2 . The solution to the system of equations is given in the following lemma:

Lemma 2.2. The solution to differential equation (2.20) with boundary conditions (2.22) and (2.23) is given by

$$\zeta_{1} = \frac{\frac{1}{2}\tilde{\sigma}^{2} - (\mu_{A} - \mu_{L}) - \sqrt{\frac{1}{4}\tilde{\sigma}^{4} + (\mu_{A} - \mu_{L})^{2} - \tilde{\sigma}^{2}(\mu_{A} + \mu_{L} - 2\delta)}}{\tilde{\sigma}^{2}} < 0,$$

$$\zeta_{2} = \frac{\frac{1}{2}\tilde{\sigma}^{2} - (\mu_{A} - \mu_{L}) + \sqrt{\frac{1}{4}\tilde{\sigma}^{4} + (\mu_{A} - \mu_{L})^{2} - \tilde{\sigma}^{2}(\mu_{A} + \mu_{L} - 2\delta)}}{\tilde{\sigma}^{2}} > 1.$$
(2.25)

Proof: See Appendix A.

Remark 2.1. Note that for $x_2 = 1$ this result of Lemma 2.2 is also given by Gerber and Shiu (2003, Equation (9.6)).

2.4. The optimal barrier

We see from (2.24), that only the denominator depends on β and that both the numerator and the denominator are negative. Furthermore, it is interesting to note that, apart from a scaling factor of x_2 , the function is only expressed in terms of ratios of x_1 to x_2 . Hence, the shape of the value function is unaffected by the scale of the two processes.

Note that both numerator and denominator in (2.24) are negative. We now take the derivative of the denominator and set the derivative equal to 0 to find the maximum of the denominator (and hence the maximum of $G(\cdot; \beta)$). The resulting optimal barrier level is

$$\beta_0^* = \alpha_0 \left(\frac{\zeta_2(\zeta_2 - 1)}{\zeta_1(\zeta_1 - 1)} \right)^{\frac{1}{\zeta_1 - \zeta_2}} = \alpha_0 \left(\frac{\zeta_1(\zeta_1 - 1)}{\zeta_2(\zeta_2 - 1)} \right)^{\frac{1}{\zeta_2 - \zeta_1}}.$$

Because of the assumption that $\mu_A > \mu_L$, we have that $\beta_0^* > \alpha_0$. We obtain this result by using the representation given by (A.5) for both the numerator and the denominator of (2.26),

Hence, the optimal barrier level β_0^* exists and is unique. Let f denote the denominator of (2.24) as a function of β . Using the assumptions (2.11) and (2.10) and the result (2.27), we get that $f'(\alpha_0) > 0$. Then because $f(\infty) = -\infty$ we know that β_0^* maximises (2.24).

Also, note that for $\delta = \mu_A$ we get that $\zeta_2 = 1$ which implies that $\beta_0^* \to \infty$ for $\mu_A \to \delta$ (if we become very patient (δ is getting closer to μ_A) it is optimal to wait more before distributing profits) and for $\mu_A \leq \mu_L$ we get $\beta_0^* = \alpha_0$ (if the company is not profitable we should liquidate it immediately).

Remark 2.2. At the optimal barrier β_0^* , we have

(2.28)

Condition (2.28) is obtained by taking the derivative of (2.23) with respect to β . This gives us that (using the chain rule for partial derivatives)

The term $\frac{\partial^2}{\partial x_1 \partial \beta} G(x_1, x_2; \beta) |_{x_1 = \beta x_2 -}$ in (2.29) is claimed to be 0 at the optimal barrier. Specifically, we see from (2.24) that $G(x_1, x_2; \beta)$ and $\frac{\partial}{\partial x_1} G(x_1, x_2; \beta)$ share the same denominator with respect to β . Since the optimal barrier β_0^* is obtained by setting $\frac{\partial}{\partial \beta} G(x_1, x_2; \beta) = 0$, then $\frac{\partial^2}{\partial x_1 \beta} G(x_1, x_2; \beta)$ is also 0 at β_0^* . We get (2.28) by inserting β_0^* and dividing the equation by x_2 .

Finally, we denote the optimal barrier in the model with (simple) solvency constraint by β_1^* . We conjecture that the optimal barrier for the assets is given by β_1^* , where

$$\beta_1^* = \begin{cases} \beta_0^*, & \beta_0^* \ge \alpha_1, \\ \alpha_1, & \beta_0^* < \alpha_1. \end{cases}$$

With techniques similar to the ones in Decamps, Schepper, and Goovaerts (2009) (who also derived β_0^* but had no solvency constraint) we will show that β_1^* is the optimal barrier. To make the paper self contained, we also give a proof for the case $\beta_0^* \ge \alpha_1$.

2.5. Verification of all the conditions of verification lemma

Next, we show that the barrier strategy with level $\beta_1^* = \max \{\alpha_1, \beta_0^*\}$ satisfies all the conditions in the verification lemma. First, we need the following lemma.

Lemma 2.3. For $\alpha \geq \beta_0^*$, we have

where $G(x_1, x_2; \beta)$ is the value function of the barrier strategy of barrier level $\beta \ge \alpha_0$ (i.e. without solvency constrain) with initial asset and liability values x_1 and x_2 , respectively.

Therefore, using (2.24) we have that

$$G(\beta_0^* x_2, x_2; \beta_0^*) = \beta_0^* x_2 \frac{\left(\frac{\beta_0^*}{\alpha_0}\right)^{\zeta_1} - \left(\frac{\beta_0^*}{\alpha_0}\right)^{\zeta_2}}{\zeta_1 \left(\frac{\beta_0^*}{\alpha_0}\right)^{\zeta_2 - \zeta_1}} \\ = \beta_0^* x_2 \frac{1 - \left(\frac{\beta_0^*}{\alpha_0}\right)^{\zeta_2 - \zeta_1}}{\zeta_1 - \zeta_2 \left(\frac{\beta_0^*}{\alpha_0}\right)^{\zeta_2 - \zeta_1}} \\ = \beta_0^* x_2 \frac{\zeta_2(\zeta_2 - 1) - \zeta_1(\zeta_1 - 1)}{\zeta_1 \zeta_2 [(\zeta_2 - 1) - (\zeta_1 - 1)]} \\ = \beta_0^* x_2 \frac{\zeta_2^2 - \zeta_1^2 - (\zeta_2 - \zeta_1)}{\zeta_1 \zeta_2 (\zeta_2 - \zeta_1)} \\ = \beta_0^* x_2 \frac{\zeta_2 + \zeta_1 - 1}{\zeta_1 \zeta_2}.$$
(2.33)

Using the definition of ζ_1 and ζ_2 , we have $\zeta_1 + \zeta_2 - 1 = \frac{2(\mu_L - \mu_A)}{\tilde{\sigma}^2}$ and $\zeta_1 \zeta_2 = \frac{2(\mu_L - \delta)}{\tilde{\sigma}^2}$, we get (2.31). To complete the proof, we need to show that $G(\alpha x_2; x_2; \alpha) \ge \frac{\alpha}{\beta_0^*} G(\beta_0^* x_2, x_2; \beta_0^*)$ for $\alpha \ge \beta_0^*$. This can be done by direct computation with help from (2.31), that is

$$= \alpha x_2 \frac{\left(\frac{\alpha}{\alpha_0}\right)^{\zeta_2 - \zeta_1} - 1}{\zeta_2 \left(\frac{\alpha}{\alpha_0}\right)^{\zeta_2 - \zeta_1} - \zeta_1}$$
$$= \alpha x_2 \frac{\left(\frac{\alpha}{\beta_0^*}\right)^{\zeta_2 - \zeta_1} \left(\frac{\beta_0^*}{\alpha_0}\right)^{\zeta_2 - \zeta_1} - 1}{\left(\frac{\alpha}{\beta_0^*}\right)^{\zeta_2 - \zeta_1} \zeta_2 \left(\frac{\beta_0^*}{\alpha_0}\right)^{\zeta_2 - \zeta_1} - \zeta_1}.$$

By noticing that $f(x) = \frac{x-1}{x+d}$ is an increasing function for $x \ge 1$, we have

Next, we show that the value function of the barrier strategy with barrier level β_0^* is concave in the first argument, i.e.

by equation (2.32). That is, by (2.19) and (2.35), (2.34) holds.

Now we are ready to show that our candidate strategy, a barrier strategy with barrier level $\beta_1^* = \max{\{\beta_0^*, \alpha_1\}}$, is the optimal strategy. We proceed by showing that the value function associated to the barrier strategy satisfies all the conditions in the verification lemma. This is shown by the next lemma.

Lemma 2.4. The barrier strategy with barrier level β_1^* is admissible and its value function $G^{\beta_1^*}$ satisfies all the conditions in the verification lemma, Lemma 2.1.

Proof. The barrier strategy is admissible because it only brings down the asset level when the ratio is above $\beta_1^* = \max{\{\beta_0^*, \alpha_1\}} \ge \alpha_1$ and it does nothing when the ratio is below α_1 . By the definition of the strategy, there is never a negative contribution and therefore Condition 1 in Lemma 2.1 is automatically satisfied. For the other conditions, we separate the cases into $\beta_0^* \ge \alpha_1$ and $\beta_0^* < \alpha_1$.

Case 1: $\beta_0^* \ge \alpha_1$. The strategy is simply the barrier strategy with barrier level β_0^* . By (2.19) and (2.24), Condition 2 is obvious for $G^{\beta_1^*}$ except for the second order differentiability at the barrier point β_0^* . In view of this and by the definition of β_0^* , we have

$$\frac{\partial^2}{\partial x_1^2} G^{\beta_1^*}(x_1, x_2) \big|_{\frac{x_1}{x_2} \nearrow \beta_0^*} = \frac{\partial^2}{\partial x_1^2} G(x_1, x_2; \beta_0^*) \big|_{\frac{x_1}{x_2} \nearrow \beta_0^*} = 0.$$

Hence, we also have

$$\frac{\partial^2}{\partial x_2^2} G^{\beta_1^*}(x_1, x_2) \big|_{\frac{x_1}{x_2} \nearrow \beta_0^*} = \beta_0^{*2} \frac{\partial^2}{\partial x_1^2} G^{\beta_1^*}(x_1, x_2) \big|_{\frac{x_1}{x_2} \nearrow \beta_0^*} = 0,$$

and

$$\frac{\partial^2}{\partial x_1 \partial x_2} G^{\beta_1^*}(x_1, x_2) |_{\frac{x_1}{x_2} \nearrow \beta_0^*} = \beta_0^* \frac{\partial^2}{\partial x_1^2} G^{\beta_1^*}(x_1, x_2) |_{\frac{x_1}{x_2} \nearrow \beta_0^*} = 0$$

Therefore, $G^{\beta_1^*} \in \mathscr{C}^2(L((\alpha_0, \infty)))$ and Condition 2 is established. For $\frac{x_1}{x_2} \leq \beta_0^*$, by the definition of the strategy, we have $(\mathscr{A} - \delta)G^{\beta_1^*}(x_1, x_2) = 0$. For $\frac{x_1}{x_2} \geq \beta_0^*$,

$$(\mathscr{A} - \delta)G^{\beta_1^*}(x_1, x_2) = -\delta(x_1 - \beta_0^* x_2) + (\mathscr{A} - \delta)G^{\beta_0^*}(\beta_0^* x_2, x_2)$$

$$\leq 0.$$

This proves (2.14) and (2.15) (Conditions 5 and 6). By using (2.34), $\frac{\partial}{\partial x_1} G^{\beta_1^*}(x_1, x_2)|_{\frac{x_1}{x_2} \ge \beta_0^*} = 1$ and $G^{\beta_1^*} \in \mathscr{C}^2$, we have $\frac{\partial}{\partial x_1} G^{\beta_1^*}(x_1, x_2) \ge 1$, which leads to (2.13) (Condition 4). Since $G^{\beta_1^*}$ is concave in the first argument, we have $\frac{\partial}{\partial x_1}G^{\beta_1^*}(x_1,x_2) \leq \frac{\partial}{\partial x_1}G^{\beta_1^*}(x_1,x_2)|_{\frac{x_1}{x_2}=\alpha_0} = \frac{\beta_0^*}{\alpha_0} \frac{\zeta_1-\zeta_2}{\zeta_1\left(\frac{\beta_0^*}{\alpha_0}\right)^{\zeta_1}-\zeta_2\left(\frac{\beta_0^*}{\alpha_0}\right)^{\zeta_2}}$. Combining with $\frac{\partial}{\partial x_1}G^{\beta_1^*}(x_1,x_2) \geq 1$, we have shown that $\frac{\partial}{\partial x_1}G^{\beta_1^*}(x_1,x_2)$ is bounded.

Lastly, we show that $\frac{\partial}{\partial x_2} G^{\beta_1^*}(x_1, x_2)$ is bounded (and therefore establish Condition 3) by direct computation combining the two branches, i.e.

$$\begin{aligned} \left| \frac{\partial}{\partial x_2} G^{\beta_1^*}(x_1, x_2) \right| &\leq \max \left\{ |-\beta_0^*|, \left| (1-\zeta_1) K_1 \left(\frac{x_1}{x_2}\right)^{\zeta_1} + (1-\zeta_2) K_2 \left(\frac{x_1}{x_2}\right)^{\zeta_2} \right| \right\} \\ &\leq \max \left\{ \beta_0^*, |(1-\zeta_1) K_1| \left(\frac{x_1}{x_2}\right)^{\zeta_1} + |(1-\zeta_2) K_2| \left(\frac{x_1}{x_2}\right)^{\zeta_2} \right\} \\ &\leq \max \left\{ \beta_0^*, |(1-\zeta_1) K_1| \alpha_0^{\zeta_1} + |(1-\zeta_2) K_2| \beta_0^{*\zeta_2} \right\}, \end{aligned}$$

where the maximum is taken over the two branches and K_1 and K_2 are pre-determined constants given by (2.24). All conditions are established.

Case 2: $\alpha_1 > \beta_0^*$. Since the barrier level is α_1 , Conditions 2,4 and 5 are satisfied automatically. Using similar arguments as above, i.e. separating the value function into 2 branches and making use of the properties that the value function (and its derivatives) is continuous and therefore bounded on one branch, equal to a constant on the other branch, we can show that Condition 3 is satisfied. For Condition 6, with the help of the second branch of (2.19), (2.30) and (2.31), for $\frac{x_1}{x_2} \ge \alpha_1$, we have

$$\begin{aligned} (\mathscr{A} - \delta)G^{\beta_1^*}(x_1, x_2) &= \mu_A x_1 + \mu_L x_2(-\alpha_1 + \frac{\partial}{\partial x_2}G(\alpha_1 x_2, x_2; \alpha_1)) - \delta(x_1 - \alpha_1 x_2 + G(\alpha_1 x_2, x_2; \alpha_1)) \\ &= \mu_A x_1 + \mu_L x_2(-\alpha_1 + \frac{G(\alpha_1 x_2, x_2; \alpha_1)}{x_2}) - \delta(x_1 - \alpha_1 x_2 + G(\alpha_1 x_2, x_2; \alpha_1)) \\ &= (\mu_A - \delta) x_1 + (\delta - \mu_L)\alpha_1 x_2 + (\mu_L - \delta)G(\alpha_1 x_2, x_2; \alpha_1) \\ &\leq (\mu_A - \delta) \alpha_1 x_2 + (\delta - \mu_L)\alpha_1 x_2 + (\mu_L - \delta)\left(\frac{\alpha_1}{\beta_0^*}\right)G(\beta_0^* x_2, x_2; \beta_0^*) \\ &= (\mu_A - \mu_L) \alpha_1 x_2 + (\mu_L - \delta)\left(\frac{\alpha_1}{\beta_0^*}\right)\beta_0^* x_2\frac{\mu_L - \mu_A}{\mu_L - \delta} \\ &= (\mu_A - \mu_L) \alpha_1 x_2 + \alpha_1 x_2(\mu_L - \mu_A) \\ &= 0. \end{aligned}$$

All conditions are established.

As all conditions in the verification lemma (Lemma 2.1) are satisfied, we can conclude that $\pi^{\beta_1^*}$ is optimal in our formulation. This is restated in the following.

Theorem 2.5. With β_0^* defined by (2.25) and (2.26), the barrier strategy with barrier level $\beta_1^* = \max(\beta_0^*, \alpha_1)$ is optimal in the presence of solvency constraint at level $\alpha_1 > \alpha_0$.

Proof. The result follows from Lemmas 2.1 and 2.4.

3. When capital is injected to prevent ruin

3.1. The model with capital injections

In this section, we assume that capital injections are made in order to prevent ruin. In this case, a strategy π consists of two parts: (1) $D^{\pi}(t)$ to pay dividends to shareholders, and (2) $E^{\pi}(t)$ to rescue the

company when the asset is too low. In this sense, we have

$$X_1^{\pi}(t) = X_1(t) - D^{\pi}(t) + E^{\pi}(t), \qquad (3.1)$$

where both D^{π} and E^{π} are non-decreasing, càdlàg and $\{\mathcal{F}_t; t \geq 0\}$ -adapted processes such that

$$\frac{X_1^{\pi}(t)}{X_2(t)} \ge \alpha_0, \quad t \ge 0.$$
(3.2)

The set of admissible strategies is denoted as Π_{CI} . The dynamics of the bivariate process (X_1^{π}, X_2) become

Similar to the case in Section 2, the value function of a strategy $\pi \in \Pi_{CI}$ is given by

where κ is a constant strictly greater than 1 which recognises that there is a price of raising capital.

We also denote the optimal value function as

$$J_{CI}^*(x_1, x_2) = \sup_{\pi \in \Pi_{CI}} J_{CI}(x_1, x_2; \pi)$$

and we are interested in finding a strategy $\pi^* \in \Pi_{CI}$ such that

In addition to the above, because $\kappa > 1$ we restrict the set of admissible strategies so that

$$\Delta D^{\pi}(t)\Delta E^{\pi}(t) = 0, \qquad (3.6)$$

that is, the company does not raise money to pay dividends, which would not be optimal in view of (3.3). Conditions (2.10) and (2.11) are also assumed to be true here.




Figure 2: Simulation of the controlled funding ratio in the model where ruin must be prevented. The dotted lines are the net distributions.

The model is illustrated in Figure 2, where the funding ratios are depicted by solid lines and net distributions (distributions, minus rescue measures, in absence of transaction costs) by dotted lines for a given sample path of the two-dimensional Brownian motion. The plot also contains the optimal upper barrier, which we find in the following sections.

Remark 3.1. In this section, capital is always injected to prevent ruin. Such capital injections are not always desirable, in that the expected present value of future dividends gained from the rescue may not compensate for the cost of the capital injection. But in some cases it could indeed be profitable. This idea goes back to Borch (1974, Chapter 20) and Porteus (1977).

Determining the optimal unconstrained dividend and capital injection strategy in our context is outside the scope of this paper. It makes sense that capital injections would be warranted if, and only if, the associated value function $J_{CI}(\gamma x_2, x_2; \beta, \gamma)$ was greater than or equal to zero. This conjecture is supported by previous results in the literature (see, for instance Løkka and Zervos, 2008; Avanzi, Shen, and Wong, 2011). This is explored in Section 4.2.3.

3.2. Verification lemma

Under the model formulation described in Section 3.1, one sufficient condition for a strategy $\pi \in \Pi_{CI}$ to be optimal is given by the following lemma.

Lemma 3.1. For a strategy $\hat{\pi} \in \Pi_{CI}$, denote its value function $H(x_1, x_2) := J_{CI}(x_1, x_2; \hat{\pi})$. Suppose on $L(\alpha_0, \infty)$, H satisfies the following 5 conditions

$$H(x_1, x_2) \in \mathscr{C}^2(L(\alpha_0, \infty)), \tag{3.7}$$

$$H(x_1, x_2) \geq 0, \tag{3.8}$$

where K_0 is a positive number. Then $\hat{\pi}$ is optimal, that is, $\hat{\pi} = \pi^*$, and $J_{CI}(x_1, x_2; \pi^*) = J_{CI}^*(x_1, x_2)$ for all $(x_1, x_2) \in L([\alpha_0, \infty))$.

Proof. According to the definition of value function in (3.4), it is obvious to have $H(x_1, x_2) \leq J_{CI}^*(x_1, x_2)$. Then it is suffices to show that

Rearranging the terms in (3.14), using $dX_1^{\pi,c}(s) = \mu_A ds + \sigma_A dW(s) - D^{\pi,c}(s) + E^{\pi,c}(s)$ (and similarly for $dX_2(s)$, we obtain

Note the assumption that the strategy π is efficient implies that $\Delta X_1^{\pi}(t) < 0$ corresponds to a dividend payment at time t while $\Delta X_1^{\pi}(t) > 0$ corresponds to a capital injection, i.e.

3.3. The barrier strategy with capital injections

Gerber and Shiu (2003) match inflow and outflow in the situation where $\kappa = 1$. Here, we set $\kappa > 1$ and obtain the expected present value of outflow minus inflow if a barrier strategy is applied. The distribution barrier that maximizes this difference exists and is unique. The differential equation characterising the value function in this case has the following form:

We conjecture that an optimal strategy in this formulation is a strategy $\pi^{\beta,\gamma}$ with two reflecting barriers: a dividend barrier β and a capital injection barrier γ . Of course, for the strategy to make sense and admissible, we require $\alpha_0 \leq \gamma < \beta$. Under the reflecting barriers strategy, when the modified funding ratio is above β , the amount $x_1 - \beta x_2$ is paid as dividend, then the modified asset value is reduced to βx_2 ; when the modified funding ratio is below γ , the cost of capital injection is $\kappa(x_1 - \gamma x_2)$, then the modified asset value is increased to γx_2 . Therefore, the expected present value of dividends for a doubly-reflected barrier with barriers (β, γ) , denoted by $G^{\beta,\gamma}$, is given by

(3.20)

where $G(x_1, x_2; \beta, \gamma)$ is given by the differential equation

$$(\mathscr{A} - \delta)G(x_1, x_2; \beta, \gamma) = 0 \text{ for } \gamma \leq \frac{x_1}{x_2} \leq \beta.$$

Since we have forced capital injections we do not have a boundary condition at the ruin level as in (2.22). Instead, we have a boundary condition at the capital injection level which can be obtained in the same way as (2.23). In total, the boundary conditions are

For a heuristic derivation of conditions (3.21) and (3.22), see Avanzi, Shen, and Wong (2011, Section 3.1). Analogous to the solution for $(\mathscr{A} - \delta)G(x_1, x_2; \beta) = 0$ as given in (A.7), the solution of $(\mathscr{A} - \delta)G(x_1, x_2; \beta, \gamma) = 0$ is in the form

That is, in total we get that the value function for a strategy with dividend barrier β and capital injection barrier γ with $\beta > \gamma$ is

3.4. The optimal barriers

In this section, we propose the choice of the optimal barriers, denoted as (β_2^*, γ^*) . Because of transaction costs it makes sense that the optimal rescue level is the lowest possible (i.e. $\gamma^* = \alpha_0$), which is our choice of γ^* .

Remark 3.2. Note that this may not hold any more if transaction costs are not constant. Furthermore, we conjecture that the form of the optimal distribution strategy is as before, that is, of the barrier type.

For β_2^* , it makes sense to maximize (3.25) with respect to β , for $\frac{x_1}{x_2} \in [\gamma^*, \beta]$. By rearranging the terms, we see that

Setting this term equal to zero leads to the equation

We can rewrite this representation for the optimal upper barrier and obtain the following representation for κ :

Having chosen the optimal barriers (β_2^*, γ^*) , we are left to prove the optimality of the barrier strategy.

It remains to show that our candidate strategy $\pi^{\beta_2^*,\alpha_0}$ satisfies all the conditions purposed in the lemma. We start by showing concavity of the value function.

where we used the fact that $\frac{x_1}{\gamma^* x_2} \ge 1$ and the last inequality is always true since the right-hand side is an arithmetic sum (of two positive numbers) while the left-hand side is the geometric sum of them.

Remark 3.3. When $\frac{x_1}{x_2} = \beta_2^*$, the inequality in (3.33) becomes equality and therefore we have

$$\frac{\partial^2}{\partial x_1^2} G(x_1, x_2; \beta_2^*, \gamma^*) |_{\frac{x_1}{x_2} \nearrow \beta_2^*} = 0.$$
(3.35)

Lemma 3.4. The value function of a barrier strategy with barrier levels $\gamma^* = \alpha_0$ and β_2^* (defined as the solution to (3.28)) satisfies all the conditions in the verification Lemma 3.1.

Proof. For presentation purpose, we denote $G(x_1, x_2)$ for $G(x_1, x_2; \beta_2^*, \gamma^*)$. First, we need to show that $G^{\beta_2^*, \gamma^*}(x_1, x_2) \in \mathscr{C}^2$.

Since $\gamma^* = \alpha_0$, we have only 2 branches to work with, namely $\frac{x_1}{x_2} \in [\alpha_0, \beta_2^*)$ and $\frac{x_1}{x_2} \in [\beta_2^*, \infty)$. From Lemma 3.3, we have

$$\frac{\partial^2}{\partial x_1^2} G(x_1, x_2) \big|_{\frac{x_1}{x_2} \nearrow \beta_2^*} = 0.$$
(3.36)

By taking partial derivatives of G using (3.25), we are able to show that

$$\frac{\partial^2}{\partial x_2^2} G(x_1, x_2) \big|_{\frac{x_1}{x_2} \nearrow \beta_2^*} = \frac{\partial^2}{\partial x_1^2} G(x_1, x_2) \big|_{\frac{x_1}{x_2} \nearrow \beta_2^*} \times \beta_2^{*2} = 0$$
(3.37)

and

$$\frac{\partial^2}{\partial x_1 \partial x_2} G(x_1, x_2) |_{\frac{x_1}{x_2} \nearrow \beta_2^*} = \frac{\partial^2}{\partial x_1^2} G(x_1, x_2) |_{\frac{x_1}{x_2} \nearrow \beta_2^*} \times \beta_2^* = 0.$$
(3.38)

Equations (3.36), (3.37) and (3.38) prove that the second-order partial derivatives are continuous. Since the function $G^{\beta_2^*,\gamma^*}$ is first-order differentiable, we can conclude that $G^{\beta_2^*,\gamma^*}$ is second-order differentiable, i.e. $G^{\beta_2^*,\gamma^*} \in \mathscr{C}^2$.

Next, we show that $(\mathscr{A} - \delta)G^{\beta_2^*,\gamma^*}(x_1, x_2) \leq 0$. We need to show that $(\mathscr{A} - \delta)G^{\beta_2^*,\gamma^*}(x_1, x_2) \leq 0$ holds for the 2 branches $\frac{x_1}{x_2} \in [\alpha_0, \beta_2^*)$ and $\frac{x_1}{x_2} \in [\beta_2^*, \infty)$. For the first branch, by the form of the value function, we have $(\mathscr{A} - \delta)G^{\beta_2^*,\gamma^*}(x_1, x_2) = 0$. For the second branch, since $G^{\beta_2^*,\gamma^*} \in \mathscr{C}^2$ and $G^{\beta_2^*,\gamma^*}(x_1, x_2) = x_1 - \beta_2^* x_2 + G(\beta_2^* x_2, x_2)$, we have

$$(\mathscr{A} - \delta)G^{\beta_2^*, \gamma^*}(x_1, x_2) = -\delta(x_1 - \beta_2^* x_2) + (\mathscr{A} - \delta)G(\beta_2^* x_2, x_2)$$

= -\delta(x_1 - \beta_2^* x_2)
\le 0.

The condition $1 \leq \frac{\partial}{\partial x_1} G^{\beta_2^*,\gamma^*}(x_1,x_2) \leq \kappa$ is an automatic result from (3.21), (3.22) and Lemma 3.3. Lastly, we show $|\frac{\partial}{\partial x_2} G^{\beta_2^*,\gamma^*}(x_1,x_2)| < K$ for some positive constant K. For the first branch $\frac{x_1}{x_2} \in [\alpha_0, \beta_2^*)$, we have

$$\left| \frac{\partial}{\partial x_2} G^{\beta_2^*, \gamma^*}(x_1, x_2) \right| = \left| K_1 (1 - \zeta_1) \left(\frac{x_1}{x_2} \right)^{\zeta_1} + K_2 (1 - \zeta_2) \left(\frac{x_1}{x_2} \right)^{\zeta_2} \right|$$

$$\leq |K_1 (1 - \zeta_1)| \left(\frac{x_1}{x_2} \right)^{\zeta_1} + |K_2 (1 - \zeta_2)| \left(\frac{x_1}{x_2} \right)^{\zeta_2}$$

$$\leq |K_1 (1 - \zeta_1)| \left(\alpha_0 \right)^{\zeta_1} + |K_2 (1 - \zeta_2)| \left(\beta_2^* \right)^{\zeta_2},$$

which is bounded. For the second branch, we have

$$\left|\frac{\partial}{\partial x_2}G^{\beta_2^*,\gamma^*}(x_1,x_2)\right| = |-\beta_2^*|,$$

which is also bounded. Take $K = \max\left\{\beta_2^*, K_1(1-\zeta_1)|(\alpha_0)^{\zeta_1} + |K_2(1-\zeta_2)|(\beta_2^*)^{\zeta_2}\right\} + 1$, and by noticing that G is continuously differentiable, we arrive at $\left|\frac{\partial}{\partial x_2}G^{\beta_2^*,\gamma^*}(x_1,x_2)\right| < K$ for some positive constant K. \Box

Since the value function $G^{\beta_2^*,\gamma^*}$ satisfies all the conditions proposed in the verification Lemma 3.1, we conclude that the barrier strategy with level $\gamma = a_0$ and $\beta = \beta_2^*$ is optimal. This is restated in the following.

Theorem 3.5. Define $\gamma^* = \alpha_0$ and β_2^* as the solution to (3.28), the doubly-reflected barrier strategy with barriers (β_2^*, γ^*) is optimal.

4. Numerical illustrations




Figure 3: Scatter plots of 10,000 simulations in presence of solvency constraints (horizontal axis) or absence of solvency constraints (vertical axis).

The left figure shows pairs of outcomes for the present value of dividends until ruin for each simulation, whereas and the right figure shows pairs of outcomes of the time to ruin (censored at 15,000). The figures shown in-between squared brackets are the mean and variance of the present value of dividends on the left hand side, and time to ruin (censored at 15,000) on the right hand side.

4.1. The impact of the solvency constraint

In this section, we consider the impact of the solvency constraint on the stability of operations. In Figure 3, we compare outcomes of 10,000 simulations (according to an Euler scheme) for the aggregate distributed amount (left), as well as the associated time to bankruptcy (right), when a solvency constraint is applied (horizontal axis) or not (vertical axis). The simulations were censored at time T = 15,000 (unless declared bankrupt before). For parameters used, see Table A in Appendix B, set no. 1.

In all scatter plots, values in the top left triangle are those where the outcome in absence of constraints beats that in presence of a solvency constraint, whereas outcomes in the bottom right triangle are those where the constraints beats the base case.

In terms of dividends, we know that the absence of constraints will lead to a higher expected present value—on average (here 0.778 > 0.774). However, what the left hand side of Figure 3 teaches us is that, when there is a substantial difference, it is in favour of the solvency constraint (dots that are significantly away from the 45 degree line are in the bottom right triangle). Also, the coefficient of variation of the aggregate distribution amount is lower with the solvency constraint than without (0.214/0.774 < 0.217/0.778).

We now turn our attention to right hand side of Figure 3, which focuses on the the impact of the solvency constraint on the time to ruin. It illustrates that the time to ruin in the presence of a solvency constraint clearly dominates the time to ruin in the absence of solvency constraint. This is evidenced by (i) the outcomes are in the bottom triangle (away from the 45 degree line), and (ii) moreover, many trajectories are not ruined yet after T = 15,000 time units when a solvency constraint is applied, whereas the corresponding trajectories re-calculated in absence of solvency constraint were ruined (see the vertical accumulation of dots at T = 15,000).

Combining both results, one could argue that the solvency constraint in this case is really effective and comes at a relatively small cost. Note that while these results would be quantitatively different with other parameters, conclusions would be qualitatively similar.

4.2. The impact of of capital injections

In this section, we illustrate the impact of introducing capital injections on the dividend strategy and its outcomes.




Figure 4: The optimal barriers β_2^* as a function of κ . The higher the transaction costs, the higher the optimal dividend barrier level. For parameters used, see Table A in Appendix B, set no. 1.

4.2.1. The impact of transaction costs on the optimal distribution barrier

Whatever the level of transaction costs κ , the optimal capital injection level γ^* will always be α_0 . However, the optimal distribution barrier will be affected by different values of κ . This is illustrated in Figure 4. For $\kappa = 1$, the optimal distribution barrier is α_0 since there is no reason to hold an extra buffer when additional capital comes at no cost. It then increases as κ increases.

4.2.2. The impact of the capital injection and distribution barriers on the value function




Figure 5: Surface plots of the value functions as functions of γ and β with $\kappa = 1.05$. For parameters used, see Table A in Appendix B, set no. 1.

In Figure 5, we depict surface plots for γ and β of the value function for the model in the case where capital is injected to prevent ruin. The existence of an optimal level for β is obvious, as is the fact that the

optimal level for γ will always be the ruin level (here $\alpha_0 = 1$).

4.2.3. Should capital be injected to prevent ruin?

In this section, we explore the conjecture spelt out in Remark 3.1, which asserts that, in fact, the company should be rescued only if the value function at the capital injection barrier is nonnegative. Under which combination of parameters would rescue be optimal?




Figure 6: Illustration of which values of κ (black line) that makes the value functions equal to 0 at the funding ratio α_0 . The corresponding optimal values for β are in grey. Assuming the conjecture is correct, this means that if κ is higher than the plotted figure, then one should never rescue the company with capital injections (and vice versa). For parameters used, see Table A in Appendix B, set no. 2.

In Figure 6, we plot the values of κ which makes the value function exactly equal to 0 for the optimal choice of the upper barrier. This is because everything else being equal, the cost of injecting capital (κ) will be the main parameter determining whether capital injections are worthwhile or not.

Lower risk levels will allow for higher levels of transaction costs κ . In fact, very low risk will make it very attractive to rescue the company even though the cost of capital injection is high.

A. Proof of Lemma 2.2

Proof of Lemma 2.2. We introduce the notation $\tilde{G}(\cdot;\beta)$ by

$$G(x_1, x_2; \beta) = (x_1 + x_2)G\left(\frac{x_1}{x_1 + x_2}, \frac{x_2}{x_1 + x_2}; \beta\right) = (x_1 + x_2)G(y, 1 - y; \beta)$$
$$= (x_1 + x_2)\tilde{G}(y; \beta),$$

where $y = \frac{x_1}{x_1 + x_2}$. For reformulation of the HJB equation, we need the following derivatives

$$\frac{\partial}{\partial x_i}G(x_1, x_2; \beta) \text{ and } \frac{\partial^2}{\partial x_i \partial x_j}G(x_1, x_2; \beta), \quad i, j = 1, 2.$$

We get

$$\begin{split} \frac{\partial}{\partial x_1} G(x_1, x_2; \beta) &= \frac{\partial}{\partial x_1} \left((x_1 + x_2) \, \tilde{G}\left(\frac{x_1}{x_1 + x_2}; \beta\right) \right) \\ &= \tilde{G}\left(\frac{x_1}{x_1 + x_2}; \beta\right) + (x_1 + x_2) \, \tilde{G}'\left(\frac{x_1}{x_1 + x_2}; \beta\right) \left(\frac{1}{x_1 + x_2} - \frac{x_1}{(x_1 + x_2)^2}\right) \\ &= \tilde{G}(y; \beta) + \tilde{G}'(y; \beta)(1 - y), \\ \frac{\partial}{\partial x_2} G(x_1, x_2; \beta) &= \frac{\partial}{\partial x_2} \left((x_1 + x_2) \, \tilde{G}\left(\frac{x_1}{x_1 + x_2}; \beta\right) \right) \\ &= \tilde{G}\left(\frac{x_1}{x_1 + x_2}; \beta\right) + (x_1 + x_2) \, \tilde{G}'\left(\frac{x_1}{x_1 + x_2}; \beta\right) \left(-\frac{x_1}{(x_1 + x_2)^2}\right) \\ &= \tilde{G}(y; \beta) + \tilde{G}'(y; \beta)(-y), \end{split}$$

$$\begin{split} \frac{\partial^2}{\partial x_1^2} G(x_1, x_2; \beta) &= \frac{\partial^2}{\partial x_1^2} \left((x_1 + x_2) \,\tilde{G}\left(\frac{x_1}{x_1 + x_2}; \beta\right) \right) \\ &= \frac{\partial}{\partial x_1} \left(\tilde{G}\left(\frac{x_1}{x_1 + x_2}; \beta\right) + \frac{x_2}{x_1 + x_2} \tilde{G}'\left(\frac{x_1}{x_1 + x_2}; \beta\right) \right) \\ &= \tilde{G}'\left(\frac{x_1}{x_1 + x_2}; \beta\right) \left(\frac{1}{x_1 + x_2} - \frac{x_1}{(x_1 + x_2)^2} - \frac{x_2}{(x_1 + x_2)^2}\right) \\ &\quad + \frac{x_2}{x_1 + x_2} \tilde{G}''\left(\frac{x_1}{x_1 + x_2}; \beta\right) \frac{x_2}{(x_1 + x_2)^2} \\ &= \tilde{G}''(y; \beta) \frac{x_2^2}{(x_1 + x_2)^3}. \end{split}$$

Likewise,

$$\begin{aligned} \frac{\partial^2}{\partial x_2^2} G(x_1, x_2; \beta) = & \tilde{G}''(y; \beta) \frac{x_1^2}{(x_1 + x_2)^3}, \\ \frac{\partial^2}{\partial x_1 \partial x_2} G(x_1, x_2; \beta) = & - \tilde{G}''(y; \beta) \frac{x_1 x_2}{(x_1 + x_2)^3}. \end{aligned}$$

In total we get that

$$\frac{\mathscr{A}G(x_1, x_2; \beta) - \delta G(x_1, x_2; \beta)}{x_1 + x_2} = \frac{1}{2} \left(\sigma_A^2 + \sigma_L^2 - 2\rho\sigma_A\sigma_L \right) y^2 (1 - y)^2 \tilde{G}''(y; \beta) + (\mu_A - \mu_L) y(1 - y) \tilde{G}'(y; \beta) + (\mu_A y + \mu_L(1 - y) - \delta) \tilde{G}(y; \beta).$$
(A.1)

We guess that the solution to the right-hand side of equation (A.1) equal to 0 has a solution of the form:

$$\tilde{G}(y;\beta) = y^{\vartheta}(1-y)^{\varphi}.$$
(A.2)

Inserting this in (A.1) gives:

$$\frac{\mathscr{A}G(x_1, x_2; \beta) - \delta G(x_1, x_2; \beta)}{x_1 + x_2} = \frac{1}{2} \left(\sigma_A^2 + \sigma_L^2 - 2\rho\sigma_A\sigma_L \right) y^2 (1 - y)^2 \\
\times \left(y^{\vartheta - 2} \left(\vartheta^2 - \vartheta \right) (1 - y)^{\varphi} - 2 y^{\vartheta - 1} \vartheta \left(1 - y \right)^{\varphi - 1} \varphi + y^{\vartheta} \left(1 - y \right)^{\varphi - 2} \left(\varphi^2 - \varphi \right) \right) \\
+ \left(\mu_A - \mu_L \right) y (1 - y) \left(\vartheta y^{\vartheta - 1} (1 - y)^{\varphi} - \varphi y^{\vartheta} (1 - y)^{\varphi - 1} \right) + \left(\mu_A y + \mu_L (1 - y) - \delta \right) y^{\vartheta} (1 - y)^{\varphi}.$$

Dividing the above equation with $y^{\vartheta}(1-y)^{\varphi} = \tilde{G}(y)$ and setting

$$\tilde{\sigma}^2 = \sigma_A^2 + \sigma_L^2 - 2\rho\sigma_A\sigma_L \tag{A.3}$$

yields that the right-hand side is equal to

$$\frac{1}{2} \left(\vartheta^2 - \vartheta\right) \tilde{\sigma}^2 + \vartheta(\mu_A - \mu_L) + \mu_L - \delta + \left(\vartheta + \varphi - 1\right) \left(\left(-\vartheta \tilde{\sigma}^2 - \mu_A + \mu_L \right) y + \frac{1}{2} \tilde{\sigma}^2 (\vartheta + \varphi) y^2 \right).$$
(A.4)

Setting the part of (A.4) not depending on y equal to 0 gives us a quadratic equation for

$$\frac{1}{2}\tilde{\sigma}^2\vartheta^2 + \left(\mu_A - \mu_L - \frac{1}{2}\tilde{\sigma}^2\right)\vartheta + \mu_L - \delta = 0, \tag{A.5}$$

and setting the last term of (A.4) equal to 0 we get that $\varphi = 1 - \vartheta$. We denote by ζ_1 and ζ_2 the two solutions to the quadratic equation. The solutions are given by

$$\frac{-\left(\mu_{A}-\mu_{L}-\frac{1}{2}\tilde{\sigma}^{2}\right)\pm\sqrt{\left(\mu_{A}-\mu_{L}-\frac{1}{2}\tilde{\sigma}^{2}\right)^{2}-4\frac{1}{2}\tilde{\sigma}^{2}\left(\mu_{L}-\delta\right)}}{\tilde{\sigma}^{2}} = \frac{\frac{1}{2}\tilde{\sigma}^{2}-\left(\mu_{A}-\mu_{L}\right)\pm\sqrt{\frac{1}{4}\tilde{\sigma}^{4}+\left(\mu_{A}-\mu_{L}\right)^{2}-\left(\mu_{A}-\mu_{L}\right)\tilde{\sigma}^{2}-2\tilde{\sigma}^{2}\left(\mu_{L}-\delta\right)}}{\tilde{\sigma}^{2}} = \frac{\frac{1}{2}\tilde{\sigma}^{2}-\left(\mu_{A}-\mu_{L}\right)\pm\sqrt{\frac{1}{4}\tilde{\sigma}^{4}+\left(\mu_{A}-\mu_{L}\right)^{2}-\tilde{\sigma}^{2}\left(\mu_{A}+\mu_{L}-2\delta\right)}}{\tilde{\sigma}^{2}}.$$
(A.6)

Because the coefficient of the quadratic term of (A.5), $\frac{1}{2}\tilde{\sigma}^2$, is greater than 0 and because the left-hand side of (A.5) is negative for $\vartheta = 0$ by (2.11) and (2.10) the quadratic equation (A.5) has a positive solution, which we denote ζ_2 , and negative solution, which we denote ζ_1 . Because the left-hand side of (A.5) is equal to $\mu_A - \delta < 0$ for $\vartheta = 1$, we get that $\zeta_2 > 1$.

By using that $\tilde{G}(y;\beta) = G(y,1-y;\beta)$ we get that a general solution is given by

$$G(x_1, x_2; \beta) = \vartheta_1 x_1^{\zeta_1} x_2^{1-\zeta_1} + \vartheta_2 x_1^{\zeta_2} x_2^{1-\zeta_2},$$
(A.7)

which is equivalent to $x_2 \left(\vartheta_1 \left(\frac{x_1}{x_2} \right)^{\zeta_1} + \vartheta_2 \left(\frac{x_1}{x_2} \right)^{\zeta_2} \right)$. Solving ϑ_1 and ϑ_2 using (2.22) and (2.23), we obtain (2.24).

Note the solution to $(\mathscr{A} - \delta)\tilde{G}(y;\beta) = 0$ is unique, given the 2 boundary conditions (2.22) and (2.23). This shows that our guess (A.2) is correct.
