# Magic angles in twisted bilayer graphene near commensuration: Towards a hypermagic regime

#### Abstract

The Bistritzer-MacDonald continuum model (BM model) describes the low-energy moiré bands for twisted bilayer graphene (TBG) at small twist angles. We derive a generalized continuum model for TBG near any commensurate twist angle, which is characterized by complex interlayer hoppings at commensurate $A A$ stackings (rather than the real hoppings in the BM model), a real interlayer hopping at commensurate $A B / B A$ stackings, and a global energy shift. The complex phases of the $A A$ stacking hoppings and the twist angle together define a single angle parameter $\phi_{0}$. We compute the model parameters for the first six distinct commensurate TBG configurations, among which the $38.2^{\circ}$ configuration may be within experimentally observable energy scales. We identify the first magic angle for any $\phi_{0}$ at a condition similar to that of the BM model. At this angle, the lowest two moiré bands at charge neutrality become flat except near the $\boldsymbol{\Gamma}_{M}$ point and retain fragile topology but lose particle-hole symmetry. We further identify a hypermagic parameter regime centered at $\phi_{0}= \pm \pi / 2$ where many moiré bands around charge neutrality (often 8 or more) become flat simultaneously. Many of these flat bands resemble those in the kagome lattice and $p_{x}, p_{y}$ 2-orbital honeycomb lattice tight-binding models.


## I. Introduction

At certain discrete commensurate twist angles $\theta_{0}$, the honeycomb lattices of two graphene layers align to form a perfectly periodic superlattice $[1,2]$. The simplest such commensurate configuration is $\theta_{0}=0$ in which two layers of graphene are aligned with no twist. Bistritzer and MacDonald demonstrated that if two layers of graphene are twisted by a small angle relative to this $\theta_{0}=0$ configuration, forming twisted bilayer graphene (TBG), a moiré superlattice emerges, and the low energy single particle physics can be described by a continuum model [3]. Furthermore, at the so called magic angle, $\theta \approx 1.05^{\circ}$, this model predicts that the lowest two moiré bands (i.e. the first conduction and valence bands) at charge neutrality become approximately flat. Moreover, it has been shown that the two flat bands carry a fragile topology [4-8], obstructing the construction of maximally localized symmetric Wannier orbitals [9-14]. In this flat band regime, the physics is dominated by interactions. Interacting electronic states such as correlated insulators, superconductors, and Chern insulators have been observed [15-33], the mechanisms of which have been studied extensively [34-59]. Flat bands and interacting electronic states are also present in other two dimensional moiré materials such as twisted double bilayer graphene [60-63], twisted trilayer and multilayer graphene [64-69], ABC trilayer graphene [70-73], and twisted transition metal dichalcogenides [74-76]. For the purpose of exploring interacting states, the search for more flat band moiré platforms is important.

In this paper, we search for flat moiré bands in TBG twisted by a small angle relative to an arbitrary commensurate configuration. That is to say, we consider a twist angle $\theta=\theta_{0}+\delta \theta$ where $\theta_{0}$ is a commensurate angle and $\delta \theta$ is small. Without loss of generality, we can
choose $0 \leq \theta_{0}<\pi / 3$ because of the crystalline symmetries of TBG. When $\theta_{0}=0$, the interlayer hopping couples states near the top and bottom layer $\mathbf{K}$ points only among themselves. This allows one to explicitly derive the form of the Bistritzer-MacDonald continuum model (BM model) by computing the interlayer hopping in reciprocal space and making a few well-justified approximations [3]. However, for all other commensurate configurations, the calculations are more complicated since states near the top and bottom $\mathbf{K}$ points are coupled to many other states. The origin of this complication is the fact that the commensurate unit cell contains $4 N$ atoms, where the integer $N$ is 1 when $\theta_{0}=0$ but is 7 or greater for all other commensurate configurations [2].

Assuming that the interlayer hopping is not too strong, the states far from the top and bottom $\mathbf{K}$ points influence the low energy physics perturbatively. Rather than explicitly applying perturbation theory, we take an approach based on symmetry and parameter determination from a microscopic tight-binding model. We first show, based on an analysis of the magnitudes of the hopping terms, that the system is approximated by a continuum model of a certain general form. We then use the exact unitary and anti-unitary crystalline symmetries of TBG to constrain the coefficients of this general model. Near a commensurate twist angle $\theta_{0}$, we arrive at a TBG continuum model containing four real parameters $\chi_{0}, w_{0}, w_{1}$, and $w_{2}$, which are ultimately determined by the microscopic hopping parameters. We show that $w_{1}$ controls the interlayer hopping at the commensurate $A B$ and $B A$ stacking configurations while $w_{0} e^{i \chi_{0}}$ and $w_{0} e^{-i \chi_{0}}$ control the interlayer hoppings at the commensurate $A A$ stacking configuration. $w_{2}$ is simply a global energy shift. When $\theta_{0}=0$, the value of $\chi_{0}$ is negligible because of an approximate mirror symmetry, and we recover the BM model.

In order to determine the model parameters near gen-
eral commensurate configurations, we consider the geometry of TBG in real space. The key observation is that a small relative rotation $\delta \theta$ of the two graphene layers can be locally approximated by an interlayer translation [77]. By carefully taking the limit $\delta \theta \rightarrow 0$, we derive the model for commensurate twist angle $\theta_{0}$ and interlayer displacement $\mathbf{d}$ from the model for twist angle $\theta=\theta_{0}+\delta \theta$. We then determine the continuum model parameters from a numerical computation of the microscopic tight-binding model (without lattice relaxation or corrugation [78]) at commensurate angle $\theta_{0}$ with two values of $\mathbf{d}$ corresponding to $A A$ and $A B$ stacking configurations. For the case $\theta_{0}=0$, we recover $w_{0} \approx w_{1} \approx 110 \mathrm{meV}, \chi_{0}=0, w_{2}=0$ in agreement with the BM model. We additionally provide numerical values of the model parameters for the next five commensurate configurations in order of the number of atoms per commensurate unit cell. When determining the continuum model parameters, we only use numerical tight-binding results at a single crystal momentum (the commensurate $\mathbf{K}$ point) and two $\mathbf{d}$ vectors. However, we find that the continuum model matches the tight-binding model with high accuracy for all crystal momenta in the commensurate $\mathbf{K}$ valley and all $\mathbf{d}$ vectors. It is worth noting that in the first five non-trivial (i.e. $\left.\theta_{0} \neq 0\right)$ commensurate configurations, the new parameters $\chi_{0}$ and $w_{2}$ are non-negligible. Although we do not consider lattice relaxation or corrugation, we note that these effects can alter the values of the model parameters, but not the general form of the continuum model (assuming these effects preserve the moiré lattice symmetries) [10, 78, 79]. We note also the possibility that the model parameters can be altered by the effects of higher graphene bands which we do not consider.

Next, we compute the moiré band structures of TBG with twist angle near the first six commensurate configurations. By both the "tripod model" approximation $[3,80]$ and accurate numerical computations, we identify the condition for the first magic angle in any nearly commensurate TBG system (Eqs. (66) and (67)). This condition is similar to that of the original BM model. A further simplification of the generic TBG continuum model indicates that the moiré band structure only depends on a single angle variable $\phi_{0}=\chi_{0}+\theta_{0} / 2$. At the first magic angle, the lowest two bands at charge neutrality in the nearly commensurate TBG model with $\phi_{0} \neq 0$ are flat in most of the moiré Brillouin zone except in the vicinity of the $\boldsymbol{\Gamma}_{M}$ point. These bands are no longer particle-hole symmetric, though they do retain fragile topology. According to our model, the first magic angle near any nonzero commensurate twist angle $\theta_{0}$ (e.g. the magic angle $0.004^{\circ}$ near $\theta_{0} \approx 38.2^{\circ}$ ) may be too small to be realized experimentally. However, it is possible that spontaneous commensurate atomic structural reconstructions (e.g. charge density wave orders), lattice relaxation or corrugation, or effective couplings mediated by higher graphene bands may enhance the moiré potential and enlarge the magic angles.

Finally, we reveal the existence of a hypermagic regime

centered at $\phi_{0}= \pm \pi / 2$ where several moiré bands (often 8 or more) near charge neutrality become extremely flat simultaneously. The second and third magic angles in the chiral limit [12] are contained in the hypermagic regime, and for these parameters the lowest two bands at charge neutrality have fragile topology $[4-8]$. On the other hand, for many parameters in the hypermagic regime the lowest bands at charge neutrality have trivial topology. In such cases, we expect that the strongly interacting physics may be similar to that of the Hubbard model with trivial bands and may host anti-ferromagnetic states. Interestingly, many of the flat bands in the hypermagic regime resemble those of the kagome lattice and $p_{x}, p_{y}$ 2 -orbital honeycomb lattice tight-binding models, which are known to exhibit flat bands [81, 82].

The rest of this paper is organized as follows. Sec. II derives the generic form of the low energy TBG continuum model near commensuration from a microscopic graphene Hamiltonian. Sec. III further restricts the form of the TBG continuum model using crystalline symmetries, and gives the model parameters for the first six commensurate configurations. In Sec. IV, we discuss the low energy bands (namely the first two conduction and valence bands) of commensurate TBG. Then in Sec. V, we compute the moiré band structure near several commensurate configurations with the actual model parameters and give the condition for the first magic angle. In Sec. VI, we further explore the parameter space of the nearly commensurate TBG continuum model, reveal the hypermagic regime, and investigate the topology of the moiré bands. Finally, we give a high level discussion in Sec. VII.

## II. Derivation of the generic continuum model

## A. Microscopic Hamiltonian

The honeycomb lattice of monolayer graphene consists of two sublattices $A$ and $B$. We will often make the identifications $A=1$ and $B=-1$ when using $A$ and $B$ in
equations. As shown in Fig. 1(a), the positions of the carbon atoms in sublattice $\alpha$ are given by $\mathbf{r}+\boldsymbol{\tau}_{\alpha}$ for $\alpha \in\{A, B\}, \mathbf{r}$ in a triangular Bravais lattice $L$, and constant vectors $\boldsymbol{\tau}_{\alpha}$. It is convenient to choose the primitive vectors $\left(\mathbf{a}_{1}, \mathbf{a}_{2}\right)$ for $L$ where $\mathbf{a}_{1}=a_{0} \sqrt{3} \hat{\mathbf{x}}, \mathbf{a}_{2}=R_{-\pi / 3} \mathbf{a}_{1}$, $a_{0} \approx 0.142 \mathrm{~nm}$ is the interatomic distance, and $R_{\phi}$ denotes rotation by angle $\phi$ about the $\hat{\mathbf{z}}$ axis. Additionally, we choose $\boldsymbol{\tau}_{A}=a_{0} \hat{\mathbf{y}}$ and $\boldsymbol{\tau}_{B}=R_{-\pi / 3} \boldsymbol{\tau}_{A}$ so that the origin $\mathbf{0}$ is in the center of a hexagon. We define $\Omega$ to be the primitive unit cell of $L$ and $|\Omega|$ to be its area.

The Bravais lattice $P$ that is reciprocal to $L$ has primitive vectors ( $\mathbf{b}_{1}, \mathbf{b}_{2}$ ) with $\mathbf{b}_{1}=R_{2 \pi / 3} \mathbf{b}_{2}$ and $\mathbf{b}_{2}=$ $-4 \pi \hat{\mathbf{y}} /\left(3 a_{0}\right)$ so that $\mathbf{b}_{j} \cdot \mathbf{a}_{k}=2 \pi \delta_{j, k}$. Explicitly, the lattices $L$ and $P$ are given by

We define the Brillouin zone BZ to be the Wigner-Seitz unit cell of $P$ and $|\mathrm{BZ}|$ to be its area. Note that $|\Omega||\mathrm{BZ}|=$ $(2 \pi)^{2}$. We additionally define the high-symmetry crystal momenta

which are shown in Fig. 1(b).
We consider a system consisting of two stacked graphene layers denoted by $l \in\{+,-\}$. We rotate layer $l$ by the angle $-l \theta / 2$ about the origin $\mathbf{0}$ and then translate it by an in-plane vector $-l \mathbf{d} / 2$, so that $\theta$ and $\mathbf{d}$ are the relative rotation and translation of the two layers. We show in App. C that when $\theta$ is not a commensurate angle, a change in the translation vector $\mathbf{d}$ is equivalent to a unitary change of basis, but this is not generally the case when $\theta$ is a commensurate angle.

Let $L_{l}, P_{l}$, and $\mathrm{BZ}_{l}$ be the real space lattice, reciprocal lattice, and graphene Brillouin zone of layer $l$. Explicitly, $L_{l}=R_{-l \theta / 2} L, P_{l}=R_{-l \theta / 2} P$, and $\mathrm{BZ}_{l}=R_{-l \theta / 2} \mathrm{BZ}$ where we use the notation $R S=\{R s \mid s \in S\}$ for a set $S$ of vectors and an operator or number $R$. We will additionally use the notations $S_{1} \cap S_{2}$ and $S_{1} \cup S_{2}$ for the intersection and union of sets $S_{1}, S_{2}$, as well as the notations $S_{1}+S_{2}=\left\{s_{1}+s_{2} \mid s_{1} \in S_{1}, s_{2} \in S_{2}\right\}$ and $s_{1}+S_{2}=\left\{s_{1}+s_{2} \mid s_{2} \in S_{2}\right\}$ where $s_{1}$ is a vector and $S_{1}$, $S_{2}$ are sets of vectors.

We neglect electron spin when describing the singleparticle model because of the weak spin-orbit coupling in graphene [83]. The spinless $p_{z}$ orbitals $|\mathbf{r}, l, \alpha\rangle$ for $\mathbf{r} \in L_{l}$, $l \in\{+,-\}$, and $\alpha \in\{A, B\}$ form an orthonormal basis for the Hilbert space. The orbital $|\mathbf{r}, l, \alpha\rangle$ is localized at position $\mathbf{r}+\boldsymbol{\tau}_{\alpha}^{l}$ where $\boldsymbol{\tau}_{\alpha}^{l}=R_{-l \theta / 2} \boldsymbol{\tau}_{\alpha}-l \mathbf{d} / 2$. Note that $\mathbf{d}$ enters the formalism only through the definition of $\boldsymbol{\tau}_{\alpha}^{l}$.

The Bloch states are defined by

for crystal momentum vectors $\mathbf{k} \in \mathbb{R}^{2}$, and satisfy the normalization condition

Note that the origin for crystal momenta is $\boldsymbol{\Gamma}$, defined in Eq. (2) and shown in Fig. 1. The Bloch states $|\mathbf{k}, l, \alpha\rangle$ with $\mathbf{k} \in \mathrm{BZ}_{l}$ form a continuous basis for the Hilbert space. However, for convenience we will sometimes use the overcomplete set formed by all Bloch states $|\mathbf{k}, l, \alpha\rangle$ for $\mathbf{k} \in \mathbb{R}^{2}$.

We consider a microscopic single-particle Hamiltonian $H$ with matrix elements

where $\mu$ is a chemical potential and $t_{ \pm}: \mathbb{R}^{2} \rightarrow \mathbb{R}$ are rotationally symmetric functions (i.e. $t_{ \pm}(\mathbf{r})$ depends only on $|\mathbf{r}|)$ determining the intra- and interlayer hoppings. We allow the functions $t_{ \pm}(\mathbf{r})$ to remain unspecified for now. The intra-layer matrix elements are given by

(see App. A). If the value of $\mu$ is chosen appropriately, then for crystal momenta near $\mathbf{K}_{l}=R_{-l \theta / 2} \mathbf{K}$, this matrix element can be approximated by a Dirac cone

Here, $\boldsymbol{\sigma}_{\phi}=e^{-i(\phi / 2) \sigma_{z}}\left(\sigma_{x} \hat{\mathbf{x}}+\sigma_{y} \hat{\mathbf{y}}\right) e^{i(\phi / 2) \sigma_{z}}$ is a vector of rotated Pauli matrices satisfying

and $v_{F}$ is the Fermi velocity, which depends on the function $t_{+}(\mathbf{r})$. We make the assumption throughout the paper that $v_{F}>0$. See App. B for a derivation of Eq. (7) based on symmetry. The matrix elements for crystal momenta near the other Brillouin zone corners $R_{n \pi / 3} \mathbf{K}_{l}$ for $1 \leq n \leq 5$ are given by similar Dirac cone Hamiltonians.

The interlayer matrix elements are given by

where the hatted functions $\hat{t}_{ \pm}(\mathbf{k})$ are the two dimensional Fourier transforms of $t_{ \pm}(\mathbf{r})$ (see App. A). We see that $H$ is block diagonal: the Bloch states $\left|\mathbf{k}^{\prime}, l^{\prime}, \alpha^{\prime}\right\rangle$ and $|\mathbf{k}, l, \alpha\rangle$ are in the same Hamiltonian block if and only if

## B. Commensurate configurations

Since layer $l$ is invariant under translation by elements of the graphene Bravais lattice $L_{l}$, the bilayer system is invariant under translations by elements of $L_{-} \cap L_{+}$. Commensurate configurations are those for which $L_{-} \cap$ $L_{+} \neq\{\mathbf{0}\}$, in which case $L_{-} \cap L_{+}$forms a Bravais lattice called the commensuration superlattice. Let $\theta=\theta_{0}$ be a commensurate angle, by which we mean the twist angle for a commensurate configuration.

We show in App. C that the crystalline symmetries of TBG allow us to restrict our attention to configurations with $\theta_{0} \in[0, \pi / 3)$. These configurations can be enumerated by a pair of relatively prime integers $m>n \geq 0$ with

(see App. D 1). The commensurate configuration corresponding to the pair $(m, n)$ has $4 N$ atoms per unit cell where the integer $N \geq 1$ is given in Eq. (D12) as a function of $m$ and $n$.

As shown in App. D 3, if $3 \mid n$ (i.e. 3 divides $n$ ) we have

\begin{equation*}
\mathbf{K}_{+}-\mathbf{K}_{-}^{\prime}, \mathbf{K}_{+}^{\prime}-\mathbf{K}_{-} \in P_{-}+P_{+} \tag{13}
\end{equation*}
$$

where $\mathbf{K}_{l}=R_{-l \theta / 2} \mathbf{K}$ and $\mathbf{K}_{l}^{\prime}=R_{-l \theta / 2} \mathbf{K}^{\prime}$. Additionally, in either case we have

$$
\begin{equation*}
\mathbf{K}_{+}-\mathbf{K}_{+}^{\prime}, \mathbf{K}_{-}-\mathbf{K}_{-}^{\prime} \notin P_{-}+P_{+} \tag{14}
\end{equation*}
$$

If $\theta_{0}$ is a commensurate angle then so is $\pi / 3-\theta_{0}$, and the Hamiltonians for these two configurations are unitarily equivalent (see App. C). Furthermore, we show in App. D 4 that among the two configurations corresponding to $\theta_{0}$ and $\pi / 3-\theta_{0}$, one must satisfy $3 \mid n$ while the other does not. As a result, we assume without loss of generality that $3 \mid n$ and Eq. (12) holds. From here on, we will always assume $3 \mid n$ unless we explicitly state otherwise. Tab. I lists properties of the first six commensurate configurations in increasing order of $N$. Fig. 2 illustrates the locations of the atoms in real space for a particular commensurate configuration.

We saw in Eq. (10) that the microscopic Hamiltonian is block diagonal in accordance with the lattice $P_{-}+P_{+}$. We show in App. D 2 that when the system is commensurate, $P_{-}+P_{+}$is the reciprocal lattice of the commensuration superlattice $L_{-} \cap L_{+}$. We see that the block diagonality can be attributed in this case to translation symmetry with respect to the commensuration superlattice. Each Hamiltonian block has a basis consisting of Bloch states with $N$ non-equivalent crystal momenta in each layer, for a total dimension of $4 N$. As an example, Fig. 3(a) illustrates the crystal momenta involved in the Hamiltonian block containing $\mathbf{K}_{+}$and $\mathbf{K}_{-}$for a particular commensurate configuration. We show in App. D 5 that $L_{-} \cap L_{+}=\sqrt{N} L$ and $P_{-}+P_{+}=P / \sqrt{N}$ so that the Brillouin zone $\mathrm{BZ}_{0}$ corresponding to the commensuration superlattice is a regular hexagon.

## C. Incommensurate configurations

We now consider an incommensurate twist angle $\theta$. We show in App. E that in this case $P_{-}+P_{+}$is a dense subset of $\mathbb{R}^{2}$. As a result, the block diagonality of $H$ given by Eq. (10) cannot be directly used to define a band structure. In this section, we will construct a notion of distance between Bloch states that can be used in place of block diagonality to analyze $H$.

We show in App. D 1 that since $\theta$ is incommensurate, we have $P_{-} \cap P_{+}=\{\mathbf{0}\}$. It follows that for any $l \in\{+,-\}$ and crystal momentum vectors $\mathbf{k}, \mathbf{k}^{\prime}$ with $\mathbf{k}^{\prime}-\mathbf{k} \in P_{-}+$ $P_{+}$there are unique vectors $\mathbf{G}_{-} \in P_{-}, \mathbf{G}_{+} \in P_{+}$such that

\mathbf{k}+\mathbf{G}_{l}=\mathbf{k}^{\prime}+\mathbf{G}_{-l} \tag{15}
\end{equation*}
$$

This pair of vectors $\mathbf{G}_{-}, \mathbf{G}_{+}$determines the interlayer matrix element in Eq. (9). Since $\hat{t}_{-}(\mathbf{k})$ depends only on $|\mathbf{k}|$, the magnitude of $\left\langle\mathbf{k}^{\prime},-l, \alpha^{\prime}\right| H|\mathbf{k}, l, \alpha\rangle$ depends only

on $\left|\mathbf{k}+\mathbf{G}_{l}\right|$. We assume that $\hat{t}_{-}(\mathbf{k})$ monotonically decreases with $|\mathbf{k}|$, so that interlayer matrix elements with large magnitude correspond to small values of $\left|\mathbf{k}+\mathbf{G}_{l}\right|$. Similarly, the intralayer matrix element in Eq. (6) is zero unless $\mathbf{k}^{\prime}-\mathbf{k} \in P_{l}$. As a result, $\left\langle\mathbf{k}^{\prime}, l, \alpha^{\prime}\right| H|\mathbf{k}, l, \alpha\rangle$ is only nonzero when $\mathbf{k}$ and $\mathbf{k}^{\prime}$ are related as in Eq. (15) with $\left|\mathbf{G}_{-l}\right|=0$.

With this motivation, we define a function $d$ that quantifies the magnitude of the matrix elements of $H$

d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)= \begin{cases}\infty & \text { if } \mathbf{k}^{\prime}-\mathbf{k} \notin P_{-}+P_{+}  \tag{16}\\ \left|\mathbf{k}+\mathbf{G}_{l}\right| & \text { if } l^{\prime}=-l \text { and Eq. (15) } \\ \left|\mathbf{G}_{-l}\right| & \text { if } l^{\prime}=l \text { and Eq. (15) }\end{cases}
$$

We show in App. F that $d$ satisfies

1. $d(\mathbf{k}, l, \mathbf{k}, l)=0$
2. $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}, l\right)$

$$
\text { 3. } d\left(\mathbf{k}, l, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right) \leq d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)+d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right)
$$

so that $d$ defines a notion of distance on the set $\mathbb{R}^{2} \times$ $\{+,-\}[84]$. Suppose we define the distance between Bloch states $|\mathbf{k}, l, \alpha\rangle,\left|\mathbf{k}^{\prime}, l^{\prime}, \alpha^{\prime}\right\rangle$ to be $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)$. Then by construction, the microscopic Hamiltonian $H$ described by Eqs. (6) and (9) is local with respect to this notion of distance.

## D. Continuum model for incommensurate configurations

We now take

$$
\begin{equation*}
\theta=\theta_{0}+\delta \theta \tag{17}
\end{equation*}
$$

where $\theta_{0}$ is a commensurate angle as in Eq. (11) and $\delta \theta$ is small. We assume that $\theta$ is an incommensurate angle so that the distance function $d$ from Sec. II C is defined. We are interested in the single particle physics of $H$ near the Fermi level at charge neutrality, as this determines the low energy excitations of the many-body Hamiltonian. In this section, we will derive a continuum model that approximates the relevant energies and eigenvectors of $H$.

We will make use of the following characterization of the distance function $d$ that applies when $\theta=\theta_{0}+\delta \theta$. Let $L_{l}^{0}=R_{-l \theta_{0} / 2} L, P_{l}^{0}=R_{-l \theta_{0} / 2} P$, and recall from Sec. II B that $L_{-}^{0} \cap L_{+}^{0}$ is the commensuration superlattice corresponding to twist angle $\theta_{0}$ and $P_{-}^{0}+P_{+}^{0}$ is its reciprocal lattice. Define the set

\mathcal{Q}\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=-\delta_{l^{\prime}, l} \mathbf{k}^{\prime}+\left(\mathbf{k}+P_{l}^{0}\right) \cap\left(\mathbf{k}^{\prime}+P_{-l}^{0}\right) \tag{18}
\end{equation*}
$$

and the operator

$$
\begin{equation*}
D(\delta \theta)=R_{\delta \theta / 2}-R_{-\delta \theta / 2}=2 \sin (\delta \theta / 2) R_{\pi / 2} \tag{19}
\end{equation*}
$$

Let $\mathbf{k} \in \mathbb{R}^{2}, l \in\{+,-\}$, and define $\mathbf{k}_{0}=R_{l \delta \theta / 2} \mathbf{k}$. Then for any pair ( $\mathbf{k}^{\prime}, l^{\prime}$ ) with $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)<\infty$, there are unique vectors $\mathbf{k}_{0}^{\prime} \in \mathbf{k}_{0}+P_{-}^{0}+P_{+}^{0}$ and $\mathbf{Q} \in \mathcal{Q}\left(\mathbf{k}_{0}, l, \mathbf{k}_{0}^{\prime}, l^{\prime}\right)$ such that

$$
\begin{equation*}
\mathbf{k}^{\prime}=R_{-l^{\prime} \delta \theta / 2} \mathbf{k}_{0}^{\prime}-l D(\delta \theta) \mathbf{Q} \tag{20}
\end{equation*}
$$

Additionally, we have $|\mathbf{Q}|=d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)$ so that

$$
\begin{equation*}
\left|R_{l^{\prime} \delta \theta / 2} \mathbf{k}^{\prime}-\mathbf{k}_{0}^{\prime}\right|=2|\sin (\delta \theta / 2)| d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right) \tag{21}
\end{equation*}
$$

Conversely, if $\mathbf{k}^{\prime}$ is given by Eq. (20) for some $\mathbf{k}_{0}^{\prime} \in \mathbf{k}_{0}+$ $P_{-}^{0}+P_{+}^{0}$ and $\mathbf{Q} \in \mathcal{Q}\left(\mathbf{k}_{0}, l, \mathbf{k}_{0}^{\prime}, l^{\prime}\right)$ then $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=|\mathbf{Q}|$. These claims are proved in App. G.

Since monolayer graphene has Dirac cones at the K and $\mathbf{K}^{\prime}$ points (i.e. graphene has two valleys), the single particle physics of $H$ near the Fermi level at charge neutrality is dominated by Bloch states with crystal momenta near $\mathbf{K}_{ \pm}$or $\mathbf{K}_{ \pm}^{\prime}$. Consider two momenta $\mathbf{k}=\mathbf{K}_{l}$, $\mathbf{k}^{\prime}=\mathbf{K}_{l^{\prime}}^{\prime}$ from opposite graphene valleys. Then $\mathbf{k}_{0}=\mathbf{K}_{l}^{0}$ and $R_{l^{\prime} \delta \theta / 2} \mathbf{k}^{\prime}=\mathbf{K}_{l^{\prime}}^{\prime 0}$ where $\mathbf{K}_{ \pm}^{0}=R_{\mp \theta_{0} / 2} \mathbf{K}$ and $\mathbf{K}_{ \pm}^{\prime 0}=$ $R_{\mp \theta_{0} / 2} \mathbf{K}^{\prime}$. By Eqs. (12) and (14), $\mathbf{K}_{l^{\prime}}^{\prime 0} \notin \mathbf{K}_{l}^{0}+P_{-}^{0}+P_{+}^{0}$ so there is some minimal value $\kappa>0$ taken by the quantity $\left|\mathbf{K}_{l^{\prime}}^{\prime 0}-\mathbf{k}_{0}^{\prime}\right|$ for $\mathbf{k}_{0}^{\prime} \in \mathbf{k}_{0}+P_{-}^{0}+P_{+}^{0}$. By Eq. (21),

$$
\begin{equation*}
d\left(\mathbf{K}_{l}, l, \mathbf{K}_{l^{\prime}}^{\prime}, l^{\prime}\right) \geq \frac{\kappa}{2|\sin (\delta \theta / 2)|} \tag{22}
\end{equation*}
$$

which diverges as $\delta \theta \rightarrow 0$. This implies that for small $\delta \theta$, the spectrum of $H$ splits into two nearly uncoupled valleys corresponding to $\mathbf{K}$ and $\mathbf{K}^{\prime}$. We will neglect intervalley coupling and focus on the $\mathbf{K}$ valley, noting that timereversal symmetry interchanges the valleys (see App. I).

For any $q>0$, define $U(\mathbf{k}, l, q)$ to be the subspace generated by all Bloch states $\left|\mathbf{k}^{\prime}, l^{\prime}, \alpha^{\prime}\right\rangle$ with $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)<q$, and note that $U(\mathbf{k}, l, q)$ is finite dimensional. To compute the eigenstates and energies of $H$ in the $\mathbf{K}$ valley, we consider the projection of $H$ into $U\left(\mathbf{K}_{l}+\mathbf{p}, l, q\right)$ for a small vector $\mathbf{p}$ and a large value $q$. Let $B_{l, q}$ be the set of pairs $\left(\mathbf{k}^{\prime}, l^{\prime}\right)$ such that $\mathbf{k}^{\prime}$ is given by Eq. (20) with $\mathbf{k}=\mathbf{K}_{l}$, $\mathbf{k}_{0}^{\prime} \in \mathrm{BZ}_{l^{\prime}}^{0}=R_{-l^{\prime} \theta_{0} / 2} \mathrm{BZ}$, and $|\mathbf{Q}|<q$. Then for all vectors $\mathbf{p}$ small enough, the set of Bloch states $\left|\mathbf{k}^{\prime}+\mathbf{p}, l^{\prime}, \alpha^{\prime}\right\rangle$ with $\left(\mathbf{k}^{\prime}, l^{\prime}\right) \in B_{l, q}$ forms a basis for $U\left(\mathbf{K}_{l}+\mathbf{p}, l, q\right)$. The set $B_{l, q}$ is illustrated in Fig. 3(b).

Recall from Sec. IIB that we can write $L_{-}^{0} \cap L_{+}^{0}=$ $\sqrt{N} L$ and $P_{-}^{0}+P_{+}^{0}=P / \sqrt{N}$ where $4 N$ is the number of atoms in the primitive unit cell of $L_{-}^{0} \cap L_{+}^{0}$. When $N>1$ and $q$ is large enough, there are elements $\left(\mathbf{k}^{\prime}, l^{\prime}\right) \in B_{l, q}$ for which the value of $\mathbf{k}_{0}^{\prime}$ is not $\mathbf{K}_{l^{\prime}}^{0}$ (e.g. the points shown in Fig. 3(b)). The corresponding Bloch states in $U\left(\mathbf{K}_{l}+\mathbf{p}, l, q\right)$ have expected energies with respect to the intralayer Hamiltonian that are far from the Fermi level at charge neutrality. Assuming that $\left|\hat{t}_{-}(\mathbf{K})\right|$ is not too large, these Bloch states can be treated perturbatively. There is then some effective Hamiltonian supported only on the subspace generated by Bloch states $\left|\mathbf{k}^{\prime}+\mathbf{p}, l^{\prime}, \alpha^{\prime}\right\rangle$ such that $\left(\mathbf{k}^{\prime}, l^{\prime}\right) \in B_{l, q}$ and the value of $\mathbf{k}_{0}^{\prime}$ is $\mathbf{K}_{l^{\prime}}^{0}$. Note that these conditions are equivalent to $\mathbf{k}^{\prime}+\mathbf{p}=\mathbf{K}_{l^{\prime}}+\mathbf{p}^{\prime}$ where

$$
\begin{equation*}
\mathbf{p}^{\prime}=\mathbf{p}-l D(\delta \theta) \mathbf{Q} \tag{23}
\end{equation*}
$$

and $\mathbf{Q} \in \mathcal{Q}\left(\mathbf{K}_{l}^{0}, l, \mathbf{K}_{l^{\prime}}^{0}, l^{\prime}\right)$ with $|\mathbf{Q}|<q$. For convenience, we define

$$
\begin{align*}
\mathcal{Q}_{+} & =\mathcal{Q}\left(\mathbf{K}_{+}^{0},+, \mathbf{K}_{-}^{0},-\right) \\
& =\mathcal{Q}\left(\mathbf{K}_{-}^{0},-, \mathbf{K}_{+}^{0},+\right)  \tag{24}\\
& =\left(\mathbf{K}_{-}^{0}+P_{-}^{0}\right) \cap\left(\mathbf{K}_{+}^{0}+P_{+}^{0}\right) \\
\mathcal{Q}_{-} & =-\mathcal{Q}_{+}  \tag{25}\\
\mathcal{Q}_{0} & =\mathcal{Q}\left(\mathbf{K}_{+}^{0},+, \mathbf{K}_{+}^{0},+\right) \\
& =\mathcal{Q}\left(\mathbf{K}_{-}^{0},-, \mathbf{K}_{-}^{0},-\right)  \tag{26}\\
& =P_{-}^{0} \cap P_{+}^{0} .
\end{align*}
$$

We will now describe a class of continuum models that approximate these effective Hamiltonians. We introduce continuum states $|\mathbf{p}, l, \alpha\rangle_{c}$ for $\mathbf{p} \in \mathbb{R}^{2}, l \in\{+,-\}$, $\alpha \in\{A, B\}$ in a new Hilbert space, satisfying the normalization condition

$$
\begin{equation*}
\left\langle\mathbf{p}^{\prime}, l^{\prime},\left.\alpha^{\prime}\right|_{c} \mathbf{p}, l, \alpha\right\rangle_{c}=\delta_{l^{\prime}, l} \delta_{\alpha^{\prime}, \alpha} \delta^{2}\left(\mathbf{p}^{\prime}-\mathbf{p}\right) \tag{27}
\end{equation*}
$$

Although $\mathbf{p}$ is allowed to range over all of $\mathbb{R}^{2},|\mathbf{p}, l, \alpha\rangle_{c}$ represents the Bloch state $\left|\mathbf{K}_{l}+\mathbf{p}, l, \alpha\right\rangle$ when $\mathbf{p}$ is small. When $\mathbf{p}$ is large, these states cannot be identified because they satisfy different normalization conditions, namely Eqs. (4) and (27). Because of Eq. (7), we take the part of the continuum Hamiltonian due to intralayer coupling to be $\tilde{H}_{\text {intra }}=\int d^{2} \mathbf{p}|\mathbf{p}\rangle_{c} \mathcal{H}_{\text {intra }}(\mathbf{p})\left\langle\left.\mathbf{p}\right|_{\boldsymbol{c}}\right.$ where

$$
\mathcal{H}_{\mathrm{intra}}(\mathbf{p})=\hbar v_{F}\left(\begin{array}{cc}
\boldsymbol{\sigma}_{\theta / 2} \cdot \mathbf{p} & 0  \tag{28}\\
0 & \boldsymbol{\sigma}_{-\theta / 2} \cdot \mathbf{p}
\end{array}\right)
$$

and

$$
\begin{equation*}
|\mathbf{p}\rangle_{c}=\left(|\mathbf{p},+, A\rangle_{c}|\mathbf{p},+, B\rangle_{c}|\mathbf{p},-, A\rangle_{c}|\mathbf{p},-, B\rangle_{c}\right) \tag{29}
\end{equation*}
$$

is a row vector of states. Because of Eq. (23), we take the part of the continuum Hamiltonian due to interlayer coupling to be $\tilde{H}_{\text {inter }}=\int d^{2} \mathbf{p}^{\prime} d^{2} \mathbf{p}\left|\mathbf{p}^{\prime}\right\rangle_{c} \mathcal{H}_{\text {inter }}\left(\mathbf{p}^{\prime}, \mathbf{p}\right)\left\langle\left.\mathbf{p}\right|_{c}\right.$ where

$$
\begin{align*}
& \mathcal{H}_{\text {inter }}\left(\mathbf{p}^{\prime}, \mathbf{p}\right)= \\
& \sum_{\mathbf{Q} \in \mathcal{Q}_{0}}\left(\begin{array}{cc}
S_{\mathbf{Q}}^{+} & 0 \\
0 & S_{\mathbf{Q}}^{-}
\end{array}\right) \delta^{2}\left(\mathbf{p}^{\prime}-\mathbf{p}-D(\delta \theta) \mathbf{Q}\right) \\
& +\sum_{\mathbf{Q} \in \mathcal{Q}_{+}}\left(\begin{array}{cc}
0 & T_{\mathbf{Q}} \\
0 & 0
\end{array}\right) \delta^{2}\left(\mathbf{p}^{\prime}-\mathbf{p}-D(\delta \theta) \mathbf{Q}\right)  \tag{30}\\
& +\sum_{\mathbf{Q} \in \mathcal{Q}_{-}}\left(\begin{array}{cc}
0 & 0 \\
T_{\mathbf{Q}} & 0
\end{array}\right) \delta^{2}\left(\mathbf{p}^{\prime}-\mathbf{p}-D(\delta \theta) \mathbf{Q}\right)
\end{align*}
$$

Here, $T_{\mathbf{Q}}$ and $S_{\mathbf{Q}}^{l}$ denote complex $2 \times 2$ matrices which are functions of $\delta \theta$ and the translation parameter $\mathbf{d}$. Note that since $\tilde{H}_{\text {inter }}$ is Hermitian, we have

The full continuum Hamiltonian is given by $\tilde{H}=\tilde{H}_{\text {intra }}+$ $\tilde{H}_{\text {inter }}$.

We show in App. D 5 that

where $s= \pm 1$ is given by Eq. (D43). Furthermore, the elements of $\mathcal{Q}_{+}$with minimal norm are

The lattices $\mathcal{Q}_{+}$and $\mathcal{Q}_{0}$ and the vectors $\mathbf{Q}_{1}, \mathbf{Q}_{2}$, and $\mathbf{Q}_{3}$ are shown in Fig. 4.

We now observe that $\tilde{H}$ is block diagonal: the states $\left|\mathbf{p}^{\prime}, l^{\prime}, \alpha^{\prime}\right\rangle_{c}$ and $|\mathbf{p}, l, \alpha\rangle_{c}$ are in the same Hamiltonian block if and only if

More explicitly, we have

We refer to $D(\delta \theta) \mathcal{Q}_{0}$ as the moiré reciprocal lattice and $\mathbf{p}+l \mathbf{q}_{1}$ as the moiré quasi-momentum for $|\mathbf{p}, l, \alpha\rangle_{c}$. The Wigner-Seitz unit cell of the moiré reciprocal lattice is $\mathrm{BZ}_{M}=D(\delta \theta) \sqrt{N} \mathrm{BZ}$ and it is called the moiré Brillouin
zone. Additionally, we define the high-symmetry moiré quasi-momenta

We interpret $\tilde{H}$ as the Hamiltonian for a system of Dirac electrons moving through the spatially varying potentials $T(\mathbf{r}), S^{+}(\mathbf{r})$, and $S^{-}(\mathbf{r})$. Note that these potentials are periodic (up to a phase) with respect to the moiré superlattice $D(\delta \theta)^{-1} L / \sqrt{N}$ which is reciprocal to $D(\delta \theta) \mathcal{Q}_{0}$.

## E. Continuum model for commensurate configurations

As in Sec. IID we take $\theta=\theta_{0}+\delta \theta$ where $\theta_{0}$ is a commensurate twist angle, $\delta \theta$ is small, and $\theta$ is an incommensurate angle. Since the microscopic Hamiltonian is continuous with respect to twist angle, we can take the limit $\delta \theta \rightarrow 0$ to derive a continuum model for the commensurate configuration with twist angle $\theta_{0}$.

In this section, we use $T_{\mathbf{Q}}(\delta \theta, \mathbf{d}), \quad S_{\mathbf{Q}}^{l}(\delta \theta, \mathbf{d})$, $T(\mathbf{r}, \delta \theta, \mathbf{d})$, and $S^{l}(\mathbf{r}, \delta \theta, \mathbf{d})$, to denote the $T_{\mathbf{Q}}$ and $S_{\mathbf{Q}}^{l}$ matrices and the $T(\mathbf{r})$ and $S^{l}(\mathbf{r})$ potentials with twist angle $\theta=\theta_{0}+\delta \theta$ and translation vector $\mathbf{d}$. To determine the correct definition of $T_{\mathbf{Q}}(0, \mathbf{d})$, note that

This implies that the pattern of atoms near position $\mathbf{r}$ with $\theta=\theta_{0}+\delta \theta$ and $\mathbf{d}=\mathbf{0}$ is the same to first order in $\delta \theta$ as the pattern with $\theta=\theta_{0}$ and

We see that in the commensurate case, the continuum Hamiltonian describes four energy bands, approximating the bands nearest the Fermi level at charge neutrality.

Note that $T_{0}(\mathbf{d})$ and $S_{0}^{l}(\mathbf{d})$ are periodic (up to a phase) with respect to the lattice $L_{-}^{0}+L_{+}^{0}=L / \sqrt{N}$ which is reciprocal to $\mathcal{Q}_{0}$ (see Apps. D 2 and D5). As a result, for $\theta=\theta_{0}$ the continuum Hamiltonian $\tilde{H}$ is periodic in $\mathbf{d}$ (up to unitary equivalence) with respect to $L_{-}^{0}+L_{+}^{0}$. It is worthwhile to note that the microscopic Hamiltonian $H$ has the exact same periodicity in $\mathbf{d}$ (see App. C).

## III. Symmetry constraints and model parameters

We now consider the constraints that can be put on the TBG continuum model at twist angle $\theta=\theta_{0}+\delta \theta$ based on the symmetries of TBG, and explicitly determine the parameters of the TBG continuum model near various commensurate angles.

Note that the continuum model is fully determined by the $T_{\mathbf{Q}}$ and $S_{\mathbf{Q}}^{l}$ matrices with $\mathbf{d}=\mathbf{0}$ in both the commensurate $(\delta \theta=0)$ and incommensurate $(\delta \theta \neq 0)$ cases. We therefore make the assumption that $\mathbf{d}=\mathbf{0}$ throughout this section. For $\theta \neq 0$, the valley preserving symmetries of the microscopic Hamiltonian $H$ are generated by the unitary operators $C_{3 z}$ (rotation by $2 \pi / 3$ about $\hat{\mathbf{z}}$ ), $C_{2 x}$ (rotation by $\pi$ about $\hat{\mathbf{x}}$ ), and the anti-unitary operator $C_{2 z} \mathcal{T}$ (time-reversal followed by rotation by $\pi$ about $\hat{\mathbf{z}}$ ). The representations of these symmetry operators on the $|\mathbf{k}, l, \alpha\rangle$ and $|\mathbf{p}, l, \alpha\rangle_{c}$ states are given in App. I.

We require that $\tilde{H}$ commutes with these symmetry operators. $\tilde{H}_{\text {intra }}$ commutes with the symmetry operators identically so we need only consider $\tilde{H}_{\text {inter }}$. Assuming $\delta \theta \neq 0$, the symmetry constraint $\left[C_{2 z} \mathcal{T}, \tilde{H}_{\text {inter }}\right]=0$ is equivalent to

where we use the notation $\bar{M}$ for the complex conjugate of a matrix $M$. By continuity, these equations also hold for $\delta \theta=0$.

Since $\hat{t}_{-}(\mathbf{k})$ monotonically decreases with $|\mathbf{k}|$, we expect that the magnitudes of $T_{\mathbf{Q}}$ and $S_{\mathbf{Q}}^{l}$ decay rapidly with $|\mathbf{Q}|$. We therefore neglect $T_{\mathbf{Q}}$ and $S_{\mathbf{Q}}^{l}$ for all $\mathbf{Q}$ with non-minimal norm. Recall that the elements of $\mathcal{Q}_{+}$of minimal norm are $\mathbf{Q}_{1}, \mathbf{Q}_{2}$, and $\mathbf{Q}_{3}$ which are given in Eq. (33). The elements of $\mathcal{Q}_{-}$with minimal norm are $-\mathbf{Q}_{1},-\mathbf{Q}_{2}$, and $-\mathbf{Q}_{3}$, and the only element of $\mathcal{Q}_{0}$ of minimal norm is $\mathbf{0}$. See Fig. 4 for an illustration of the $\mathbf{Q}_{1}, \mathbf{Q}_{2}$, and $\mathbf{Q}_{3}$ vectors.

By Eq. (31), it suffices to determine the matrices $T_{\mathbf{Q}_{1}}$, $T_{\mathbf{Q}_{2}}, T_{\mathbf{Q}_{3}}, S_{\mathbf{0}}^{+}, S_{\mathbf{0}}^{-}$which correspond to minimal norm momenta. By expanding these matrices in the Pauli basis and applying Eqs. (54) to (56) we find

for real model parameters $\chi_{0}, w_{0}, w_{1}$, and $w_{2}$ with $w_{0} \geq 0$ and $\chi_{0} \in[0,2 \pi)$. Here, we have used $\zeta_{j}=\frac{2 \pi(j-1)}{3}$ for $j \in\{1,2,3\}$ and $\sigma_{0}$ for the $2 \times 2$ identity matrix. Note that the model parameters $\chi_{0}, w_{0}, w_{1}$, and $w_{2}$ depend on $\theta_{0}$ and $\delta \theta$ but not on $\mathbf{d}$.

In the special case $\theta=0$ (i.e. no twist) there is an additional valley preserving unitary mirror symmetry $M_{y}$ (reflection across the $x z$ plane). The symmetry constraint $\left[M_{y}, \tilde{H}_{\text {inter }}\right]=0$ is equivalent to

(see App. I). When $\theta=0$, Eq. (58) implies $\chi_{0}=0$. Therefore, if the twist angle is near 0 (i.e. $\theta_{0}=0$, $\theta=\delta \theta \approx 0$ ) one will find $\chi_{0} \approx 0$ because of the approximate $M_{y}$ symmetry. This agrees with the BistritzerMacDonald model for small angle TBG [3].

In App. J, we show that when $\delta \theta=0$, the model parameters can be determined from numerical computations of the Hamiltonian block containing $\mathbf{K}_{ \pm}$using

Eqs. (6) and (9). Additionally, Apps. D 6 and J show that the $\chi_{0}, w_{0}$, and $w_{2}$ parameters determine the band structure of $A A$ stacked commensurate configurations, while the $w_{1}$ and $w_{2}$ parameters determine the band structures of $A B$ and $B A$ stacked commensurate configurations. For numerical computations, we choose the $t_{ \pm}(\mathbf{r})$ functions in Eq. (5) to be those used in Refs. [77, 78, 85] and described in App. K. Tab. I shows approximate values of the model parameters derived from these functions for the first six commensurate configurations in order of the number of atoms per unit cell. Appendix Tab. II lists these parameters with more significant figures. Appendix Fig. 15 shows that the continuum models with parameters in Appendix Tab. II are accurate low energy approximations of the microscopic Hamiltonian for all $\mathbf{d}$ vectors. Additionally, Appendix Fig. 16 compares the band structures for each commensurate configuration in Tab. I with the band structure derived from the microscopic Hamiltonian, and we see very good agreement. We note that we do not include any lattice relaxation or corrugation effects here in the microscopic model, nor do we include coupling mediated by higher graphene bands. Such effects may alter the true model parameters.

## IV. Commensurate models: band structures

By Eqs. (28), (52) and (53), the continuum model corresponding to commensurate twist angle $\theta_{0}$ and translation vector $\mathbf{d}$ is $\tilde{H}=\int d^{2} \mathbf{p}|\mathbf{p}\rangle_{\boldsymbol{c}} \mathcal{H}_{0}(\mathbf{p})\left\langle\left.\mathbf{p}\right|_{\boldsymbol{c}}\right.$, where the explicit Hamiltonian matrix is

The matrices $T_{\mathbf{Q}_{j}}$ are given in Eq. (57) and $I$ is the $4 \times 4$ identity matrix. Recall that $\boldsymbol{\sigma}_{\phi}$ is the Pauli matrix vector defined in Eq. (8), $\mathbf{Q}_{j}$ is defined in Eq. (33), and the momentum space basis $|\mathbf{p}\rangle_{\boldsymbol{c}}$ is defined in Eq. (29). Using Eqs. (43) and (44) we can also describe this model in real space as $\tilde{H}=\int d^{2} \mathbf{r}|\mathbf{r}\rangle_{c} \mathcal{H}_{0}(\mathbf{r})\left\langle\left.\mathbf{r}\right|_{c}\right.$, where the Hamiltonian

matrix takes the form

and the real space basis $|\mathbf{r}\rangle_{\boldsymbol{c}}$ is defined in Eq. (42).
Fig. 5 shows the low energy band structures of the model in Eqs. (59) and (60) for the first two commensurate configurations in Tab. I, namely $(m, n)=(1,0)$ (the untwisted configuration with $\left.\theta_{0}=0\right)$ and $(m, n)=(5,3)$ $\left(\theta_{0} \approx 38.2^{\circ}\right)$. For both configurations, we show three translation vectors $\mathbf{d}$, and use the parameters in Appendix Tab. II. Similar band structures for the other commensurate configurations in Tab. I are shown in Appendix Fig. 16. We compare the band structures of untwisted bilayer graphene and commensurate TBG in the following cases:

1. At $A A$ stacking where $\mathbf{d}=\mathbf{0}$. In this case, untwisted bilayer graphene is gapless at momentum
$|\mathbf{p}|=\left|\mathbf{p}_{0}\right|=3\left|w_{0}\right| /\left(\hbar v_{F}\right)$ at charge neutrality as in Fig. 5(a). In contrast, commensurate TBG develops a gap at $|\mathbf{p}|=\left|\mathbf{p}_{0}\right|$ at charge neutrality as in Fig. 5(b), due to the relative rotation angle between the Dirac fermions in different layers and the nonzero value of $\chi_{0}$. Specifically, the gap at $|\mathbf{p}|=\left|\mathbf{p}_{0}\right|$ is given in general by

where $\phi_{0}=\chi_{0}+\theta_{0} / 2$. In the $\theta_{0} \approx 38.2^{\circ}$ commensurate configuration, the charge neutrality gap in Fig. 5(b) is approximately 1.6 meV , which should be experimentally measurable.
2. At $A B$ stacking where $\mathbf{d}=\frac{s}{\sqrt{N}} a_{0} \hat{\mathbf{y}}$ (recall that $s= \pm 1$ was introduced in Eq. (32)). In this case, both untwisted (Bernal) bilayer graphene, shown in Fig. 5(c), and commensurate TBG, shown in Fig. 5(d), have gapless quadratic Dirac band touchings [86] at charge neutrality.
3. At generic asymmetric stackings such as $\mathbf{d}=$ $\frac{s}{\sqrt{N}} a_{0} \hat{\mathbf{x}}$. Untwisted bilayer graphene remains gapless as in Fig. 5(e). In contrast, commensurate TBG has a tilted band gap at charge neutrality as in Fig. $5(\mathbf{f})$, but there may not be an indirect gap.

Although the above observations are made at exactly commensurate angles, they may also hold for local measurements (e.g. scanning tunneling microscopy experiments) near the corresponding stackings if the angle $\theta$ is close enough to a commensurate angle $\theta_{0}$. In particular, when $\theta_{0}$ is significantly far from zero, one expects to observe a local charge neutrality gap at $A A$ stacking positions (e.g. a 1.6 meV gap at $\theta_{0} \approx 38.2^{\circ}$ ). However, we note that the local charge neutrality at $A A$ stacking is generically different from the global charge neutrality of an incommensurate angle, due to local charge transfers between $A A$ stacking regions and $A B$ stacking regions. This can be seen in Fig. 7(c), by noting that the moiré bands at global charge neutrality are close to the conduction band energy at $A A$ stacking in Fig. 5(b).

## V. Continuum models near commensuration: moiré band structures and magic angles

The continuum model corresponding to twist angle $\theta=\theta_{0}+\delta \theta$ and translation vector $\mathbf{d}=\mathbf{0}$ is described by Eqs. (28), (30) and (57). Note that when $\delta \theta \neq 0$, the microscopic Hamiltonians for different choices of translation vector $\mathbf{d}$ differ only by a unitary transformation (see App. C) so it is sufficient to consider the case $\mathbf{d}=\mathbf{0}$. In this section, we further develop the continuum model Hamiltonian and investigate its moiré band structures and magic angles using the parameters determined in Sec. III.

Since $\delta \theta$ is small, we approximate the rotation angles $\pm \theta / 2$ of the Dirac cones in Eq. (28) by $\pm \theta_{0} / 2$. This

is a common approximation in the literature [3]. Additionally, we approximate the $\chi_{0}, w_{0}, w_{1}$, and $w_{2}$ parameters by their values at angle $\theta_{0}$ (i.e. with $\delta \theta=0$ ), which can be determined using the method described in Sec. III. The continuum model then becomes $\tilde{H}=$ $\int d^{2} \mathbf{p}^{\prime} d^{2} \mathbf{p}\left|\mathbf{p}^{\prime}\right\rangle_{c} \mathcal{H}\left(\mathbf{p}^{\prime}, \mathbf{p}\right)\left\langle\left.\mathbf{p}\right|_{c}\right.$, where the Hamiltonian ma-

and the matrices $T_{\mathbf{Q}_{j}}$ are defined in Eq. (57). Recall that $\boldsymbol{\sigma}_{\phi}$ is the Pauli matrix vector defined in Eq. (8), $\mathbf{q}_{j}$ is defined in Eq. (35), and the momentum space basis $|\mathbf{p}\rangle_{\boldsymbol{c}}$ is defined in Eq. (29). Note that $w_{2}$ only provides a constant energy shift.

Using Eqs. (43) and (44) we can also describe this model in real space by $\tilde{H}=\int d^{2} \mathbf{r}|\mathbf{r}\rangle_{c} \mathcal{H}(\mathbf{r})\left\langle\left.\mathbf{r}\right|_{c}\right.$, where

and the real space basis $|\mathbf{r}\rangle_{c}$ is defined in Eq. (42).

Following Refs. [3, 12], we introduce the dimensionless parameter

Recall that $4 N$ is the number of atoms in each commensurate unit cell at twist angle $\theta_{0}$. Note that $\alpha^{-1} \propto|\delta \theta|$ when $\delta \theta$ is small.

As a first step in the search for magic angles, we cut off the continuum model in Eq. (63) to a subspace of four quasi-momenta, namely $\mathbf{p}$ and $\mathbf{p}-\mathbf{q}_{j}$ for $j \in\{1,2,3\}$. This truncation is known as the tripod model approximation $[3,80]$ and it yields an approximate $\mathbf{k} \cdot \mathbf{p}$ model at the $\mathbf{K}_{M}$ point at charge neutrality. Generically, the lowest bands of this model have a Dirac fermion spectrum with Fermi velocity $v_{M}$. In this tripod model approximation, it can be shown (see App. O) that the velocity $v_{M}$ reaches its minimum (which is generically nonzero unless $\theta_{0}=0$ ) near

given that the energy $E$ at the $\mathbf{K}_{M}$ point satisfies $\frac{\left|E-w_{2}\right|}{\hbar v_{F}\left|\mathbf{K}_{M}\right|} \ll 1$. Note that the energy $E-w_{2}$ at the $\mathbf{K}_{M}$ point is generically nonzero when $\theta_{0}$ is nonzero. It is also known that the magic angle condition in Eq. (66) generically requires $w_{0} \leq\left|w_{1}\right|$ to avoid hybridization with the remote bands [80], and this is also true here (see Fig. 19
for examples illustrating this point). By Eq. (65), we conclude that the first magic angle occurs at

The tripod model approximation, however, does not give the higher (i.e. second, third, etc.) magic angles.

Fig. 6(a) and (b) show numerical results for Dirac velocities $v_{M}$ and the bandwidth of the lowest two moiré bands at charge neutrality, near the commensurate configurations with $(m, n)=(1,0)\left(\theta_{0}=0^{\circ}\right)$ and $(m, n)=$ $(5,3)\left(\theta_{0} \approx 38.2^{\circ}\right)$, respectively. The blue curves show $v_{M} / v_{F}$ values computed from the tripod model, and have a minimum around the angle in Eq. (67). The red curves show the accurate $v_{M} / v_{F}$ values computed using 768 moiré bands (see App. M and Fig. 17). In both cases, the value of $v_{M} / v_{F}$ is computed by numerical differentiation in the $\mathbf{q}_{1}$ direction at $\mathbf{K}_{M}$. Intriguingly, at $\theta_{0} \approx 38.2^{\circ}$, the accurate Fermi velocity $v_{M}$ at the first magic angle $\delta \theta_{\text {magic }}$ is almost zero and much smaller than that found in the tripod model. The black curves show the total bandwidth (in units of $\hbar v_{F}\left|\mathbf{K}_{M}\right|$ ) of the lowest two bands at charge neutrality using 768 moiré bands. From the accurate $v_{M} / v_{F}$ (red) and bandwidth (black) curves, we clearly see the first magic angle around the value in Eq. (67). There are higher (i.e. smaller) magic angles near $\theta_{0} \approx 38.2^{\circ}$ as well, where the lowest two bands become flat.

Fig. 7(a) and (c) show the moiré band structures at the first magic angle $\delta \theta=\delta \theta_{\text {magic }}$ the commensurate configurations with $(m, n)=(1,0)\left(\theta_{0}=0^{\circ}\right)$ and $(m, n)=(5,3)\left(\theta_{0} \approx 38.2^{\circ}\right)$, respectively. The band structure with $\theta_{0}=0^{\circ}$ shows the usual magic angle moiré bands of small angle TBG studied in [3]. At $\theta_{0} \approx 38.2^{\circ}$, the band structure is clearly not symmetric across the Fermi level, indicating the absence of both particle-hole symmetry $P[5,45,87]$ and chiral symmetry $C[12]$ (see definitions in App. L). The lowest two moiré bands at charge neutrality are still approximately flat near the $\mathbf{K}_{M}$ and $-\mathbf{K}_{M}$ points, and are energetically shifted close to a remote conduction band. The two bands are however not quite flat near the $\boldsymbol{\Gamma}_{M}$ point.

It is known that in small angle TBG, lattice relaxation has the effect of slightly reducing the value of $w_{0}$ $[10,78,79]$. Although we do not here consider relaxation from first principles, it is nonetheless worthwhile to consider the effect of a reduction in $w_{0}$ on the moiré band structure. Fig. 7(b) and (d) show moiré band structures using the same parameters as in Fig. 7(a) and (c), but with $w_{0}$ reduced by $20 \%$. In both cases, we see that the two lowest bands at charge neutrality develop a gap from the higher bands, but are otherwise qualitatively similar. Moiré band structures at the first magic angle in Eq. (67) near the other commensurate configurations listed in Tab. I are shown in Appendix Fig. 18. Additionally, other example moiré band structures near the first magic angle can be found in Figs. 10 and 19.

Appendix Tab. II shows the values of $\delta \theta_{\text {magic }}$ for the first six commensurate configurations. Due to the small magnitude of $w_{0}$ and $w_{1}$ for nonzero commensurate angles, the corresponding values of $\delta \theta_{\text {magic }}$ are so small that they likely cannot be achieved experimentally. However, we note the possibility that atomic structural reconstructions (e.g. charge density wave orders) may occur in large twist angle TBG and enhance the effective interlayer hoppings $w_{0}$ and $w_{1}$. Additionally, lattice relaxation or corrugation or couplings mediated by higher graphene bands could also change these parameters. Provided these perturbations do not break the symmetries of the moiré superlattice (translation, $C_{3 z}, C_{2 z} \mathcal{T}$, and $C_{2 x}$ ), the form of effective continuum model will not change, and we may arrive at larger first magic angles in nearly commensurate TBG.

## VI. Flat bands in the continuum model parameter space: the hypermagic regime

Regarding the possibility that the actual model parameters may change due to atomic structural reconstruction, lattice relaxation or corrugation, or couplings mediated by higher graphene bands, we now investigate the band structure of the TBG continuum model near commensuration in Eq. (63) with arbitrary parameters. We reveal the existence of a remarkable hypermagic regime centered at $\phi_{0}= \pm \pi / 2$ where many moiré bands (often 8 or more) become extremely flat simultaneously.

## A. Model simplification

We first simplify the continuum model in Eq. (63) by applying a unitary transformation of the basis from $|\mathbf{p}\rangle_{c}$ to $|\mathbf{p}\rangle_{\boldsymbol{c}}^{\prime}=|\mathbf{p}\rangle_{c} U_{\theta_{0}}$, where

Such a transformation removes the rotation angles $\pm \theta_{0} / 2$ for the Dirac cones, and transforms the Hamiltonian into $\tilde{H}=\int d^{2} \mathbf{p}^{\prime} d^{2} \mathbf{p}\left|\mathbf{p}^{\prime}\right\rangle_{c}^{\prime} \mathcal{H}^{\prime}\left(\mathbf{p}^{\prime}, \mathbf{p}\right)\left\langle\left.\mathbf{p}\right|_{c} ^{\prime}\right.$, where the Hamiltonian matrix is given by

Here, $\boldsymbol{\sigma}=\sigma_{x} \hat{\mathbf{x}}+\sigma_{y} \hat{\mathbf{y}}$ is a vector of Pauli matrices, and

where $\zeta_{j}=\frac{2 \pi(j-1)}{3}$ for $j \in\{1,2,3\}$, and we have defined

This implies that the angles $\chi_{0}$ and $\theta_{0}$ do not have fully independent effects on the band structure. We are left with a single angle variable $\phi_{0}$ in the continuum model of Eq. (69), occurring in the matrices $T_{\mathbf{Q}_{j}}^{\prime}$ in Eq. (71). We note that the angle $\phi_{0}$ in Eq. (72) also occurs in the expression for the energy gap in the commensurate $A A$ stacking configuration in Eq. (62). This can also be understood via the transformation in Eq. (68).

The model can similarly be written in the transformed real space basis

The Hamiltonian then becomes $\tilde{H}=\int d^{2} \mathbf{r}|\mathbf{r}\rangle_{c}^{\prime} \mathcal{H}^{\prime}(\mathbf{r})\left\langle\left.\mathbf{r}\right|_{c} ^{\prime}\right.$, where the Hamiltonian matrix is given by

and where we have defined

\end{equation*}

in terms of the matrices $T_{\mathbf{Q}_{j}}^{\prime}$ in Eq. (71).
By the results of App. L, we can assume without loss of generality that $s=1$ (recall that $s$ affects the direction of $\mathbf{q}_{j}$, see Eqs. (33) and (35)), and

In addition, since $w_{2}$ simply shifts the energy bands globally, we assume $w_{2}=0$ hereafter. As shown in App. L, the moiré band structures at angle $\phi_{0}$ and angle $-\phi_{0}$ are particle-hole transformations of each other, while the moiré band structures at angle $\phi_{0}$ and angle $\pi-\phi_{0}$ are equivalent.

We note that in the chiral limit $w_{0}=0$ [12], the continuum model in Eq. (69) is independent of the angle $\phi_{0}$. This is revealed as a symmetry of the TBG continuum model in the chiral limit in Ref. [14].

## B. Changing $\phi_{0}$ in the first magic manifold

We first describe the evolution of the flat bands with respect to the angle variable $\phi_{0}$ defined in Eq. (72) with the magic angle criteria $\alpha^{-1} \approx \sqrt{3}$ and $0 \leq w_{0} / w_{1} \leq 1$ (see Eq. (66)). Following Ref. [80], we refer to the parameter space satisfying these conditions and minimizing the

bandwidth of the lowest two bands at charge neutrality as the first magic manifold.

Fig. 8 contains three heatmaps showing the base 10 logarithm of the bandwidth (in units of $\hbar v_{F}\left|\mathbf{K}_{M}\right|$ ) of the two lowest bands at charge neutrality. The first magic manifold appears in Fig. 8(b) (where $\phi_{0}=0$ ) as a dark nearly horizontal curve on the left of the plot. In the first magic manifold with $\phi_{0}=0$, the lowest two flat bands at charge neutrality are symmetric about zero energy due to an anti-commuting particle-hole symmetry $P$ defined in App. L [5]. Band structures for parameters in the first magic manifold with $\phi_{0}=0$ can be found in Fig. 7(a), (b) and Fig. 10(a).

For a fixed $w_{0} / w_{1}$ and with $\alpha^{-1} \approx \sqrt{3}$, tuning $\phi_{0}$ away from 0 shifts the two flat bands at charge neutrality away from zero energy (breaking the particle-hole symmetry $P)$, and gradually increases the bandwidth of the flat bands. As shown in Fig. 8(a), the bandwidth around $\alpha^{-1}=\sqrt{3}$ increases as $\phi_{0}$ increases from 0 to $\pi / 2$, but still shows a local minimum near $\alpha^{-1}=\sqrt{3}$. The precise value of $\alpha^{-1}$ that minimizes the bandwidth decreases as $\phi_{0}$ increases. The increase of the bandwidth is mostly due to band curvature at the $\boldsymbol{\Gamma}_{M}$ point. This can be seen in Fig. 7(c), (d) and Fig. 10(b)-(d). In particular, the lowest two bands at charge neutrality remain quite flat near the $\mathbf{K}_{M}$ and $-\mathbf{K}_{M}$ points in the first magic manifold for small $\phi_{0}$. See Appendix Figs. 18 and 19 for additional band structures in the first magic manifold.

Fig. 11(a) and (b) show the real space wavefunctions at $\boldsymbol{\Gamma}_{M}$ corresponding to the flat bands in Fig. 10(a) and (b). We see that when $\phi_{0}$ is increased from 0 in the first magic manifold, the annular shape of the real space wavefunctions remains unchanged.

## C. The hypermagic regime

One may have noticed that in the bandwidth plot of Fig. 8(a) (where $w_{0} / w_{1}=0.8$ ) there are three dark spots at $\phi_{0}=\pi / 2$ near $\alpha^{-1}=0.7,0.4$, and 0.3 , indicating parameters with very small bandwidths for the lowest two bands at charge neutrality. The situation is identical at $\phi_{0}=-\pi / 2$, which is related to $\phi_{0}=\pi / 2$ by a particlehole transformation $P$ (see App. L).

To investigate what happens to the flat bands at $\phi_{0}= \pm \pi / 2$, we compute the bandwidth of the lowest two bands at charge neutrality at angle $\phi_{0}=\pi / 2$, as a function of $\alpha^{-1}$ and $w_{0} / w_{1}$. The result is given in Fig. 8(c), where we find a small bandwidth region containing three curves with $\alpha^{-1}$ values around $0.7,0.4$, and 0.3 when $0 \leq w_{0} / w_{1} \lesssim 3$. These curves start at $w_{0} / w_{1}=0$ and extend to at least $w_{0} / w_{1}=5$. The upper two curves merge around $w_{0} / w_{1}=0.2, \alpha^{-1}=0.45$ and contain the so-called second magic angle in the chiral limit at $w_{0} / w_{1}=0, \alpha^{-1}=0.45$ [12]. The third magic angle in the chiral limit at $w_{0} / w_{1}=0, \alpha^{-1}=0.267$ lies on the lowest curve.

Fig. 10(e) and (f) show example moiré band structures at points on each of the upper two dark curves in Fig. 8(c). Surprisingly, in both cases, we find several extremely flat bands in addition to the lowest two bands at charge neutrality. In total, there are at least 7 flat bands in Fig. 10(e) and 9 flat bands in Fig. 10(f)! Additional moiré band structures with parameters lying on the curves in Fig. 8(c) are given in Fig. 21. All of the plots show multiple flat bands, including those in Fig. 21(i) and (j) which correspond to the second and third magic angles in the chiral limit.

To further investigate this multiple flat band phenomenon, we plot in Fig. 9 the bandwidth of the third and eighth narrowest bands among the first 20 conduction bands and the first 20 valence bands at charge neutrality for $\phi_{0}=\pi / 2$ and $\pi / 4$. In Fig. 9(a), we see that for $\phi_{0}=\pi / 2$ there is a large region (the dark diagonal band rising from the bottom left of the plot) in which there are 3 or more flat bands. Additionally, Fig. 9(b) shows that the region in which there are 8 or more flat bands is nearly as large as the region in which there are 3 or more flat bands. Fig. 9(c) and (d) show that when $\phi_{0}$ is decreased to $\pi / 4$ the flat bands are often still present though less narrow. Appendix Fig. 20 shows similar heatmaps for the angles $\phi_{0}=0, \pi / 8$, and $3 \pi / 8$. At $\phi_{0}=0$, there are very few parameters for which there are more than two flat bands. We call the parameter region centered at $\phi_{0}= \pm \pi / 2$ in which there are many simultaneous flat bands the hypermagic regime.

Taking a closer look at the moiré bands around charge
neutrality in Fig. 10(e) and (f), we see groups of three connected bands in which one band is very flat, there are Dirac cones at $\mathbf{K}_{M}$ and $-\mathbf{K}_{M}$ between the other two bands, and there is a quadratic band touching at $\boldsymbol{\Gamma}_{M}$ between the flat band and one of the other bands. The second to fourth valence bands at charge neutrality in Fig. 10(e) and (f) are examples of this pattern. Each such group of three connected bands resembles those of a tight-binding model on the kagome lattice [82, 88, 89]. Furthermore, the corresponding real space wavefunctions at $\boldsymbol{\Gamma}_{M}$ in Fig. 11(e) and (f) show a kagome lattice pattern and the Wilson loop bands in Fig. 13(f) are consistent with exponentially localizable Wannier functions [90, 91]. Intriguingly, there is a band inversion transition along the lowest dark curve in Fig. 8(c) around $w_{0} / w_{1}=0.86, \alpha^{-1}=0.3$. For $w_{0} / w_{1}$ slightly below 0.86 , the lowest two moiré bands at charge neutrality are part of a group of three kagome-like bands while for $w_{0} / w_{1}$ just above 0.86 , they form a pair of two isolated bands. This transition is illustrated in Fig. 12(a)-(c).

In addition to the groups of three connected bands, we also see groups of four connected bands in which the top and bottom bands are very flat, there are Dirac cones at $\mathbf{K}_{M}$ and $-\mathbf{K}_{M}$ between the middle two bands, and there are two quadratic band touchings at $\boldsymbol{\Gamma}_{M}$, each involving one flat band. The second to fifth conduction bands at charge neutrality in Fig. 10(e) and (f) are examples of this pattern. These groups of four bands resemble those of the $p_{x}, p_{y} 2$-orbital honeycomb lattice tight-binding model [81, 82]. Furthermore, the corre-

sponding real space wavefunctions at $\boldsymbol{\Gamma}_{M}$ in Fig. 11(c) show a honeycomb lattice pattern and the Wilson loop bands in Fig. 13(d) are consistent with exponentially localizable Wannier functions [90, 91]. We note that similar groups of three or four bands were also observed in a recent study of twisted Kitaev bilayers in Ref. [92]. Additional moiré band structures with parameters in the hypermagic regime including some with $\phi_{0}<\pi / 2$ can be found in Appendix Fig. 22.

The continuum model in Eq. (69) (with $w_{2}=0$ ) at $\phi_{0}= \pm \pi / 2$ clearly has neither the particle-hole symmetry $P$ nor the chiral symmetry $C$ (see App. L for the
definitions of these operators), due to the asymmetry between conduction bands and valence bands, for example in Fig. 10(e) and (f). As shown in App. L, conjugation by $P$ maps the Hamiltonian $\tilde{H}$ at angle $\phi_{0}$ to $-\tilde{H}$ at angle $-\phi_{0}$, while keeping the other parameters invariant. In contrast, conjugation by $C$ maps $\tilde{H}$ at angle $\phi_{0}$ to $-\tilde{H}$ at angle $\phi_{0}-\pi$, while keeping the other parameters invariant. Therefore, the continuum model at angle $\phi_{0}= \pm \pi / 2$ has a combined $C P$ symmetry:

$$
\begin{equation*}
[C P, \tilde{H}]=0 \quad \text { when } \quad \phi_{0}= \pm \frac{\pi}{2} \tag{77}
\end{equation*}
$$

No other values of $\phi_{0}$ possess this symmetry unless $w_{0}=$ 0 .

## D. Band topology

Lastly, we discuss the band topology of the lowest two moiré bands at charge neutrality. It is known that in the BM model for small angle TBG [3], which corresponds to $\phi_{0}=0$ here (see Eq. (72)), the lowest two moiré bands carry a fragile topology protected by $C_{2 z} \mathcal{T}$ symmetry, provided the two bands are disconnected from all other bands [4-8, 93-95]. It was further shown in Ref. [87] that in the presence of both $C_{2 z} \mathcal{T}$ symmetry and the anticommuting particle-hole symmetry $P$, the fragile topology becomes stable. See App. L for the definition of the $P$ operator and recall that particle-hole symmetry is present only when $\phi_{0}=0$.

The fragile topology in the lowest two moiré bands at charge neutrality can be detected by computing their Wilson loop winding number modulo 2 [5, 87, 90, 91]. See App. M for an explanation of the Wilson loop matrix and its band structure. Fig. 13(a) shows the Wilson loop bands of the lowest two moiré bands using parameters corresponding to small angle TBG at the first magic angle. We find a winding number of 1 , indicating nontrivial fragile topology. Away from $\phi_{0}=0$, the system no longer has particle-hole symmetry $P$, so the fragile topology of the lowest two moiré bands can potentially be lost.

We find that the fragile topology of the lowest two moiré flat bands at charge neutrality remains robust for any $\phi_{0} \in[0, \pi / 2]$ in the first magic manifold (see Sec. VIB) as long as they are gapped from the remote bands. Two examples of Wilson loop bands in the first magic manifold (with $w_{0} / w_{1}=0.8$ ) are given in Fig. 13(b) and (c) and both have a winding number of 1.

Computing Wilson loop bands in the hypermagic regime, we find that among parameters for which the lowest two bands are gapped from the higher bands, it is possible for the lowest two bands to have either trivial topology or nontrivial fragile topology. In order to transition from one of these possibilities to the other, there must be a gap closing between the lowest two bands and the higher bands. We illustrate one such gap closing

in Fig. 12(d)-(f). The gap closing occurs in Fig. 12(e) near the crossing between the upper two dark curves in Fig. 8(c). The parameters in Fig. 12(d) are near the second magic angle in the chiral limit and as a result the lowest two bands at charge neutrality have fragile topology [4-8]. In contrast, the bands in Fig. 12(f) are topologically trivial and resemble those of a honeycomb lattice tight-binding model. The Wilson loop bands corresponding to Fig. 12(d) and (f) are given in Fig. 13(g) and (h) and have Wilson loop winding numbers of 1 and 0 , respectively. Fig. 13(e) shows the Wilson bands cor-
responding to the lowest two bands at charge neutrality in Fig. 10(e) which are topologically trivial.

## VII. Discussion

We have derived an effective low energy continuum model for TBG at angle $\theta=\theta_{0}+\delta \theta$ near generic commensurate angles $\theta_{0}$. The model is characterized by complex interlayer hopping amplitudes $w_{0} e^{i \chi_{0}}$ and $w_{0} e^{-i \chi_{0}}$ at commensurate $A A$ stackings, a real interlayer hopping

amplitude $w_{1}$ at commensurate $A B / B A$ stackings, and a global energy shift $w_{2}$. The twist angle $\theta_{0}$ and the phase $\chi_{0}$ combine into a single angle parameter $\phi_{0}=\chi_{0}+\theta_{0} / 2$ which affects the band structure of the effective continuum model in Eq. (69). Unless $\theta_{0}=0$, as in small angle TBG, $\phi_{0}$ is generically nonzero. Taking the $\delta \theta \rightarrow 0$ limit yields a low-energy model for commensurate TBG, which gives a nonzero charge neutrality gap in the $A A$ stacking case if $\phi_{0} \neq 0(\bmod \pi)$, and gapless quadratic band touching in the $A B / B A$ stacking cases. For commensurate angle $\theta_{0} \approx 38.2^{\circ}$, the gap in the $A A$ stacking case is around 1.6 meV and is therefore experimentally detectable. Away from commensurate angles, we find the first magic angle $\delta \theta_{\text {magic }}$ near a generic commensurate angle $\theta_{0}$ is still approximately given by $\alpha^{-1}=\sqrt{3}$ with $\alpha$ defined in Eq. (65). When $\phi_{0} \neq 0$ at the first magic angle, the lowest two moiré bands at charge neutrality are generically flat except in the vicinity of the $\boldsymbol{\Gamma}_{M}$ point.

We have also revealed a hypermagic parameter regime centered at $\phi_{0}= \pm \pi / 2$, in which several moiré bands (often 8 or more) become flat simultaneously. The hypermagic regime includes the second and third magic angles in the chiral limit as well as parameters with large $w_{0} / w_{1}$. We have identified a gap closing transition in the hypermagic regime between the lowest two bands at charge neutrality and the higher bands, across which the topology of the lowest two bands changes from fragile topological to trivial.

Many of the flat bands in the hypermagic regime belong to disconnected groups of bands which may be understood in terms of effective tight-binding models. Some groups of three bands resemble the kagome lattice tightbinding model which contains a flat band [82, 88, 89]. Other groups of four bands resemble the $p_{x}, p_{y} 2$-orbital honeycomb lattice tight-binding model which contains two flat bands [81, 82].

The lowest two bands at charge neutrality often resemble the honeycomb lattice tight-binding model which can be used to describe monolayer graphene. If such hypermagic parameters can be achieved experimentally, one may expect the strongly interacting physics in the flat bands to be analogous to that in the conventional Hubbard model with trivial single-particle bands. This may allow the occurrence of anti-ferromagnetic states, in contrast to the spin-valley ferromagnetic states in interacting magic angle TBG with $\phi_{0}=0[44,45,57-59]$.

A practical future concern is how to achieve a continuum model with $\phi_{0}$ near $\pm \pi / 2$ and a sufficiently large energy scale for the parameters $w_{0}$ and $w_{1}$ to observe the hypermagic regime in experiment. The effective hopping parameters $w_{0}$ and $w_{1}$ at nonzero commensurate angles $\theta_{0}$ (without lattice relaxation or other effects not considered here) are generically small. For example, $w_{0}$ and $w_{1}$ at $\theta_{0} \approx 38.2^{\circ}$ are about 1 percent of those at $\theta_{0}=0^{\circ}$. One idea to enhance $w_{0}$ and $w_{1}$ is to explore the possibility of atomic interaction induced structural reconstruction (e.g. charge density waves) or lattice relaxation, which may enhance the moiré potential modula-
tion between commensurate $A A$ and $A B / B A$ stackings. In addition, for small twist angles near the untwisted configuration $\theta_{0}=0$, breaking the mirror symmetry $M_{y}$ (while preserving the other symmetries) would allow $\chi_{0}$ to be nonzero, and therefore also $\phi_{0}$ to be nonzero. Thus, strong $M_{y}$ breaking perturbations could transform small angle TBG into a large $\phi_{0}$ model realization. Another interesting question is whether or not there exist other moiré models (e.g. involving twisted graphene multilayers or other twisted materials) for which there is a similar hypermagic regime where many bands become simultaneously flat. If other such models exist, it would be interesting to consider their common features and the underlying reasons for the existence of these hypermagic regimes. We leave these ideas and questions for future study.

## Appendices

## A. Microscopic Hamiltonian matrix elements

In this appendix, we derive Eqs. (6) and (9) for the intra- and interlayer microscopic Hamiltonian matrix elements. Recall that $L$ is the Bravais lattice of monolayer graphene, $P$ is its reciprocal lattice, BZ is the Brillouin zone, $L_{l}=$ $R_{-l \theta / 2} L$, and $P_{l}=R_{-l \theta / 2} P$. The Bloch states $|\mathbf{k}, l, \alpha\rangle$ are defined by Eq. (3) and satisfy the normalization condition Eq. (4). We first derive Eq. (6) under the simplifying assumption $\mu=0$ so that Eq. (5) becomes $\left\langle\mathbf{r}^{\prime}, l, \alpha^{\prime}\right| H|\mathbf{r}, l, \alpha\rangle=$ $t_{+}\left(\mathbf{r}^{\prime}+\boldsymbol{\tau}_{\alpha^{\prime}}^{l^{\prime}}-\mathbf{r}-\boldsymbol{\tau}_{\alpha}^{l}\right)$. Using the identity

where $|B Z|$ is the area of $B Z$, we compute

\left\langle\mathbf{k}^{\prime}, l, \alpha^{\prime}\right| H|\mathbf{k}, l, \alpha\rangle & =\frac{1}{|\mathrm{BZ}|} \sum_{\mathbf{r}, \mathbf{r}^{\prime} \in L_{l}} e^{-i \mathbf{k}^{\prime} \cdot\left(\mathbf{r}^{\prime}+\boldsymbol{\tau}_{\alpha^{\prime}}^{l}\right)} e^{i \mathbf{k} \cdot\left(\mathbf{r}+\boldsymbol{\tau}_{\alpha}^{l}\right)} t_{+}\left(\mathbf{r}^{\prime}+\boldsymbol{\tau}_{\alpha^{\prime}}^{l}-\mathbf{r}-\boldsymbol{\tau}_{\alpha}^{l}\right) \\
& =\frac{1}{|\mathrm{BZ}|} \sum_{\mathbf{r}^{\prime} \in L_{l}} e^{-i \mathbf{r}^{\prime} \cdot\left(\mathbf{k}^{\prime}-\mathbf{k}\right)} \sum_{\mathbf{r} \in L_{l}} e^{-i \mathbf{k}^{\prime} \cdot \boldsymbol{\tau}_{\alpha^{\prime}}^{l}} e^{i \mathbf{k} \cdot\left(\mathbf{r}-\mathbf{r}^{\prime}+\boldsymbol{\tau}_{\alpha}^{l}\right)} t_{+}\left(\mathbf{r}^{\prime}-\mathbf{r}+\boldsymbol{\tau}_{\alpha^{\prime}}^{l}-\boldsymbol{\tau}_{\alpha}^{l}\right) \\
& =\sum_{\mathbf{G}_{l} \in P_{l}} \delta^{2}\left(\mathbf{k}^{\prime}-\mathbf{k}-\mathbf{G}_{l}\right) \sum_{\mathbf{r} \in L_{l}} e^{-i \mathbf{k}^{\prime} \cdot \boldsymbol{\tau}_{\alpha^{\prime}}^{l}} e^{i \mathbf{k} \cdot\left(-\mathbf{r}+\boldsymbol{\tau}_{\alpha}^{l}\right)} t_{+}\left(\mathbf{r}+\boldsymbol{\tau}_{\alpha^{\prime}}^{l}-\boldsymbol{\tau}_{\alpha}^{l}\right)  \tag{A2}\\
& =\sum_{\mathbf{G}_{l} \in P_{l}} \delta^{2}\left(\mathbf{k}^{\prime}-\mathbf{k}-\mathbf{G}_{l}\right) e^{-i \mathbf{G}_{l} \cdot \boldsymbol{\tau}_{\alpha^{\prime}}^{l}} \sum_{\mathbf{r} \in L_{l}} e^{-i \mathbf{k} \cdot\left(\mathbf{r}+\boldsymbol{\tau}_{\alpha^{\prime}}^{l}-\boldsymbol{\tau}_{\alpha}^{l}\right)} t_{+}\left(\mathbf{r}+\boldsymbol{\tau}_{\alpha^{\prime}}^{l}-\boldsymbol{\tau}_{\alpha}^{l}\right) \\
& =\left\langle\mathbf{k}^{\prime}, l, \alpha^{\prime} \mid \mathbf{k}, l, \alpha^{\prime}\right\rangle \sum_{\mathbf{r} \in L+\boldsymbol{\tau}_{\alpha^{\prime}}-\boldsymbol{\tau}_{\alpha}} e^{-i\left(R_{l \theta / 2} \mathbf{k}\right) \cdot \mathbf{r}} t_{+}(\mathbf{r})
\end{align*}
$$

Note that we have used the rotational symmetry of the $t_{+}(\mathbf{r})$ function in the last step. When $\mu \neq 0$, the Hamiltonian is modified by subtraction of $\mu$ times the identity. As a result, the general form of the matrix element is

\end{equation*}

which is Eq. (6).
Next, we derive Eq. (9). Using Eq. (A1) and the identities

where $|\Omega|$ is the area of the primitive unit cell $\Omega$ of $L$, we compute

\left\langle\mathbf{k}^{\prime},-l, \alpha^{\prime}\right| H|\mathbf{k}, l, \alpha\rangle & =\frac{1}{|\mathrm{BZ}|} \sum_{\mathbf{r}^{\prime} \in L_{-l}} \sum_{\mathbf{r} \in L_{l}} e^{-i \mathbf{k}^{\prime} \cdot\left(\mathbf{r}^{\prime}+\boldsymbol{\tau}_{\alpha^{\prime}}^{-l}\right)} e^{i \mathbf{k} \cdot\left(\mathbf{r}+\boldsymbol{\tau}_{\alpha}^{l}\right)} t_{-}\left(\mathbf{r}^{\prime}+\boldsymbol{\tau}_{\alpha^{\prime}}^{-l}-\mathbf{r}-\boldsymbol{\tau}_{\alpha}^{l}\right) \\
& =\frac{1}{|\mathrm{BZ}|} \sum_{\mathbf{r}^{\prime} \in L_{-l}} \sum_{\mathbf{r} \in L_{l}} \int \frac{d^{2} \mathbf{q}}{(2 \pi)^{2}} \hat{t}_{-}(\mathbf{q}) e^{-i \mathbf{k}^{\prime} \cdot\left(\mathbf{r}^{\prime}+\boldsymbol{\tau}_{\alpha^{\prime}}^{-l}\right)} e^{i \mathbf{k} \cdot\left(\mathbf{r}+\boldsymbol{\tau}_{\alpha}^{l}\right)} e^{i \mathbf{q} \cdot\left(\mathbf{r}^{\prime}+\boldsymbol{\tau}_{\alpha^{\prime}}^{-l}-\mathbf{r}-\boldsymbol{\tau}_{\alpha}^{l}\right)} \\
& =|\mathrm{BZ}| \int \frac{d^{2} \mathbf{q}}{(2 \pi)^{2}} \hat{t}_{-}(\mathbf{q}) e^{i \boldsymbol{\tau}_{\alpha^{\prime}}^{-l} \cdot\left(\mathbf{q}-\mathbf{k}^{\prime}\right)} e^{i \boldsymbol{\tau}_{\alpha}^{l} \cdot(\mathbf{k}-\mathbf{q})} \sum_{\mathbf{G}_{-l} \in P_{-l}} \delta^{2}\left(\mathbf{q}-\mathbf{k}^{\prime}-\mathbf{G}_{-l}\right) \sum_{\mathbf{G}_{l} \in P_{l}} \delta^{2}\left(\mathbf{k}-\mathbf{q}+\mathbf{G}_{l}\right)  \tag{A5}\\
& =\sum_{\mathbf{G}_{-} \in P_{-}} \sum_{\mathbf{G}_{+} \in P_{+}} \frac{\hat{t}_{-}\left(\mathbf{k}+\mathbf{G}_{l}\right)}{|\Omega|} e^{i \boldsymbol{\tau}_{\alpha^{\prime}}^{-l} \cdot \mathbf{G}_{-l}} e^{-i \boldsymbol{\tau}_{\alpha}^{l} \cdot \mathbf{G}_{l}} \delta^{2}\left(\mathbf{k}+\mathbf{G}_{l}-\mathbf{k}^{\prime}-\mathbf{G}_{-l}\right)

which is Eq. (9).

## B. Dirac cones

In this appendix, we derive Eq. (7). Since this equation is an approximation of Eq. (6) and both equations depend on the crystal momentum $\mathbf{k}$ only through $R_{l \theta / 2} \mathbf{k}$, it suffices to consider the case $\theta=0$. That is, we need to show that the single particle Hamiltonian for monolayer graphene at $\mathbf{K}+\mathbf{p}$ takes the form

when the chemical potential is chosen appropriately. Although this is well known, the most common derivation employs a model of graphene that has only first or second order hopping (for example, see Refs. [96, 97]). We will now give an argument based on symmetry to show that Eq. (B1) holds with arbitrary order hopping. This is similar to the symmetry argument given in Sec. III in the case of twisted bilayer graphene near commensuration.

For monolayer graphene, we consider an orthonormal basis of spinless $p_{z}$ orbitals $|\mathbf{r}, \alpha\rangle$ for $\mathbf{r} \in L$ and $\alpha \in\{A, B\}$ localized at $\mathbf{r}+\boldsymbol{\tau}_{\alpha}$. We ignore the electron spin because of the weak spin-orbit coupling in graphene [83]. The Bloch states are defined by

for crystal momentum vectors $\mathbf{k}$, and satisfy the normalization condition

\left\langle\mathbf{k}^{\prime}, \alpha^{\prime} \mid \mathbf{k}, \alpha\right\rangle=\delta_{\alpha^{\prime}, \alpha} \sum_{\mathbf{G} \in P} \delta^{2}\left(\mathbf{k}^{\prime}-\mathbf{k}-\mathbf{G}\right) e^{-i \boldsymbol{\tau}_{\alpha} \cdot \mathbf{G}} \tag{B3}
\end{equation*}
$$

We consider a microscopic Hamiltonian $H_{\text {mono }}$ with matrix elements

where $\mu$ is a chemical potential and $t_{+}: \mathbb{R}^{2} \rightarrow \mathbb{R}$ is a rotationally symmetric function (i.e. $t_{+}(\mathbf{r})$ depends only on $|\mathbf{r}|)$. The symmetries of $H_{\text {mono }}$ are generated by the unitary operators $C_{6 z}$ (rotation by $\pi / 3$ about $\hat{\mathbf{z}}$ ), $M_{y}$ (reflection across the $x z$ plane), and the anti-unitary operator $\mathcal{T}$ (time-reversal). These operators take the form

where $R^{x}$ denotes reflection across the $x$ axis. The symmetry subgroup that preserves the high-symmetry crystal momentum K is generated by $C_{2 z} \mathcal{T}, C_{3 z}$, and $M_{y}$, where $C_{2 z}=C_{6 z}^{3}$ and $C_{3 z}=C_{6 z}^{2}$. Using Eq. (B3) we find

If we expand the matrix elements of $H_{\text {mono }}$ to second order around $\mathbf{K}$, we find

\end{equation*}

where $\mathcal{H}_{\text {mono }}(\mathbf{p})$ is a Hermitian $2 \times 2$ matrix that is linear in $\mathbf{p}$. Requiring

& =e^{-i(2 \pi / 3) \sigma_{z}} \mathcal{H}_{\mathrm{mono}}\left(R_{2 \pi / 3} \mathbf{p}\right) e^{i(2 \pi / 3) \sigma_{z}}  \tag{B12}\\
& =\sigma_{x} \mathcal{H}_{\mathrm{mono}}\left(R^{x} \mathbf{p}\right) \sigma_{x} \tag{B13}
\end{align*}
$$

where we use the notation $\bar{M}$ for the complex conjugate of a matrix $M$. We now expand $\mathcal{H}_{\text {mono }}$ in Pauli matrices as

where the $h$ coefficients are real. First, we choose the value of $\mu$ so that $h_{0}^{0}=0$. Next, Eq. (B11) implies $h_{0}^{z}=h_{x}^{z}=$ $h_{y}^{z}=0$ and Eq. (B12) implies $h_{0}^{x}=h_{0}^{y}=h_{x}^{0}=h_{y}^{0}=0$ and $h_{y}^{x}+i h_{y}^{y}=i\left(h_{x}^{x}+i h_{x}^{y}\right)$. If we define $v_{F}$ and $\phi_{F}$ by $\hbar v_{F} e^{i \phi_{F}}=h_{x}^{x}+i h_{x}^{y}$ we have

Finally, Eq. (B13) implies $\phi_{F}=0$ so the Hamiltonian is described by Eq. (B1). We conclude that the $C_{2 z} \mathcal{T}$ and $C_{3 z}$ symmetries imply that $\mathcal{H}_{\text {mono }}$ takes the form of a Dirac cone and $M_{y}$ symmetry determines the rotation angle of the Dirac cone.

## C. Equivalent configurations

Note that the microscopic Hamiltonian in Eq. (5) is uniquely determined up to unitary equivalence by the relative positions of the carbon atoms in the $x y$ plane and their partitioning into two layers. We will therefore consider systems differing only by an isometry of the $x y$ plane and a relabeling of the basis states to be equivalent. This leads to significant redundancy in the specification of bilayer configurations, as we will now show.

With angle and translation parameters $(\theta, \mathbf{d})$, the atoms are located at sites

\end{equation*}
$$

where the two terms indicate the top and bottom layers. Since this set and partitioning is invariant under the mapping $\theta \mapsto-\theta, \mathbf{d} \mapsto-\mathbf{d}$ (with an interchange of the two layers) the configurations with parameters $(\theta, \mathbf{d})$ and $(-\theta,-\mathbf{d})$ are equivalent.

Next, consider the configuration with parameters $\left(\theta+\pi / 3, R_{-\pi / 6} \mathbf{d}\right)$. If we rotate the whole system by the angle $\pi / 6$, the bottom layer atoms are located at

and the top layer atoms are located at

Since $R_{\pi / 3} L=L$ and $R_{\pi / 3} \boldsymbol{\tau}_{\alpha}-\boldsymbol{\tau}_{-\alpha} \in L$, the bottom layer atoms are equivalently located at

Since these locations now match Eq. (C1), we see that the configurations with parameters $(\theta, \mathbf{d})$ and $\left(\theta+\pi / 3, R_{-\pi / 6} \mathbf{d}\right)$ are equivalent. As a result of these equivalences, we can restrict $\theta$ to the interval $[0, \pi / 3)$ and note that the configurations $(\theta, \mathbf{d})$ and $\left(\pi / 3-\theta,-R_{-\pi / 6} \mathbf{d}\right)$ are equivalent.

Next, consider the configuration with parameters $(\theta, \mathbf{d}+\mathbf{X})$ for a vector $\mathbf{X} \in \mathbb{R}^{2}$. If we translate the whole system by $\mathbf{X} / 2$, the atoms are located at sites

$$
\begin{equation*}
\left\{R_{-\theta / 2}\left(\mathbf{r}+\boldsymbol{\tau}_{\alpha}\right)-\mathbf{d} / 2 \mid \mathbf{r} \in L, \alpha \in\{A, B\}\right\} \cup\left\{R_{\theta / 2}\left(\mathbf{r}+\boldsymbol{\tau}_{\alpha}\right)+\mathbf{d} / 2+\mathbf{X} \mid \mathbf{r} \in L, \alpha \in\{A, B\}\right\} \tag{C5}
\end{equation*}
$$

If $\mathbf{X} \in L_{-}$then this matches Eq. (C1) so the configurations with parameters $(\theta, \mathbf{d})$ and $(\theta, \mathbf{d}+\mathbf{X})$ are equivalent. Similarly, if we translate the whole system by $-\mathbf{X} / 2$, we see that when $\mathbf{X} \in L_{+}$the configurations with parameters $(\theta, \mathbf{d})$ and $(\theta, \mathbf{d}+\mathbf{X})$ are equivalent. Putting these results together, we see that whenever $\mathbf{X} \in L_{-}+L_{+}$, the configurations with parameters $(\theta, \mathbf{d})$ and $(\theta, \mathbf{d}+\mathbf{X})$ are equivalent.

We show in App. D 2 that when $\theta$ is a commensurate angle, $L_{-}+L_{+}$is a Bravais lattice whose reciprocal lattice is $P_{-} \cap P_{+}$. Furthermore, it follows from the results of App. D 6 that for commensurate $\theta$, no set $S$ larger than $L_{-}+L_{+}$ has the property that the configurations with parameters $(\theta, \mathbf{d})$ and $(\theta, \mathbf{d}+\mathbf{X})$ are equivalent for all $\mathbf{d} \in \mathbb{R}^{2}$ and all $\mathbf{X} \in S$. On the other hand, we show in App. E that when $\theta$ is not a commensurate angle, $L_{-}+L_{+}$is a dense subset of $\mathbb{R}^{2}$. Since the Hamiltonian depends continuously on $\mathbf{d}$, it follows that for incommensurate $\theta$ the configurations with parameters $(\theta, \mathbf{0})$ and $(\theta, \mathbf{d})$ are equivalent for all $\mathbf{d} \in \mathbb{R}^{2}$.

## D. Properties of commensurate configurations

Using a combination of elementary number theory and symmetry arguments, these appendices enumerate and characterize the commensurate configurations of TBG. The approach taken in Apps. D 1 and D 2 is similar to that in Ref. [2], but we include detailed derivations for completeness. We follow the notations of Secs. II A and II B.

## 1. Enumeration of commensurate configurations

We first seek to enumerate the commensurate configurations. Recall that $\mathbf{a}_{1}, \mathbf{a}_{2}$ are primitive vectors for $L$ and $\mathbf{b}_{1}, \mathbf{b}_{2}$ are primitive vectors for $P$, as illustrated in Fig. 1. Let $a$ and $b$ denote matrices with columns $\left(\mathbf{a}_{1}, \mathbf{a}_{2}\right)$ and $\left(\mathbf{b}_{1}, \mathbf{b}_{2}\right)$ respectively. Explicitly, we have

$$
\begin{align*}
a & =a_{0}\left(\begin{array}{cc}
\sqrt{3} & \sqrt{3} / 2 \\
0 & -3 / 2
\end{array}\right) \\
b & =\frac{2 \pi}{a_{0}}\left(\begin{array}{cc}
\sqrt{3} / 3 & 0 \\
1 / 3 & -2 / 3
\end{array}\right) . \tag{D1}
\end{align*}
$$

Recall from Sec. II B that the bilayer system is commensurate when $L_{-} \cap L_{+} \neq\{\boldsymbol{0}\}$, and in this case $L_{-} \cap L_{+}$is the commensuration superlattice. $L_{-} \cap L_{+} \neq\{\mathbf{0}\}$ is equivalent to the existence of nonzero integer vectors $\mathbf{u}_{+}$and $\mathbf{u}_{-}$ such that

$$
\begin{equation*}
\mathbf{u}_{+}=a^{-1} R_{\theta} a \mathbf{u}_{-} \tag{D2}
\end{equation*}
$$

Similarly, $P_{-} \cap P_{+} \neq\{\mathbf{0}\}$ is equivalent to the existence of nonzero integer vectors $\mathbf{v}_{+}$and $\mathbf{v}_{-}$such that

$$
\begin{equation*}
\mathbf{v}_{+}=b^{-1} R_{\theta} b \mathbf{v}_{-} \tag{D3}
\end{equation*}
$$

Note that

$$
\begin{align*}
a^{-1} R_{\theta} a & =\left(\begin{array}{cc}
x_{0}+y_{0} & 2 y_{0} \\
-2 y_{0} & x_{0}-y_{0}
\end{array}\right)  \tag{D4}\\
b^{-1} R_{\theta} b & =\left(\begin{array}{cc}
x_{0}-y_{0} & 2 y_{0} \\
-2 y_{0} & x_{0}+y_{0}
\end{array}\right) \tag{D5}
\end{align*}
$$

where $x_{0}=\cos \theta, y_{0}=\frac{1}{\sqrt{3}} \sin \theta$. It follows that the bilayer system is commensurate if and only if $x_{0}$ and $y_{0}$ are both rational, which is equivalent to the $L_{-} \cap L_{+} \neq\{\mathbf{0}\}$ and $P_{-} \cap P_{+} \neq\{\mathbf{0}\}$.

From here on, we will use $\theta_{0}$ in place of $\theta$ when we assume the system is commensurate in order to match the notation of Sec. II B. If the system is commensurate, then $\left(x_{0}, y_{0}\right)$ is a rational point on the ellipse $x^{2}+3 y^{2}=1$. Unless $\left(x_{0}, y_{0}\right)=(1,0)$, the line through $\left(x_{0}, y_{0}\right)$ and $(1,0)$ intersects the $y$ axis at a rational point $(0, m / n)$ where $m, n$ are relatively prime integers with $n>0$. Solving $x^{2}+3 y^{2}=1$ simultaneously with $x=-\frac{n}{m} y+1$ yields

$$
\begin{align*}
x_{0} & =\frac{3 m^{2}-n^{2}}{3 m^{2}+n^{2}}  \tag{D6}\\
y_{0} & =\frac{2 m n}{3 m^{2}+n^{2}}
\end{align*}
$$

The special case $\left(x_{0}, y_{0}\right)=(1,0)$ corresponds to $(m, n)=(1,0)$. By the results of App. C, we can restrict $\theta_{0} \in[0, \pi / 3)$ so that $m>n \geq 0$ and $\theta_{0}=\cos ^{-1}\left(x_{0}\right)$.

## 2. Commensuration lattices

We now determine the primitive vectors and reciprocal lattices of $L_{-} \cap L_{+}$and $P_{-} \cap P_{+}$assuming $\theta_{0}$ is a commensurate angle. We have

$$
\begin{align*}
a^{-1} R_{\theta_{0}} a & =\frac{1}{N}\left(\begin{array}{cc}
\alpha & \beta \\
-\beta & \gamma
\end{array}\right)  \tag{D7}\\
b^{-1} R_{\theta_{0}} b & =\frac{1}{N}\left(\begin{array}{cc}
\gamma & \beta \\
-\beta & \alpha
\end{array}\right)  \tag{D8}\\
\alpha & =(m+n)(3 m-n) / d_{0}  \tag{D9}\\
\beta & =4 m n / d_{0}=\alpha-\gamma  \tag{D10}\\
\gamma & =(m-n)(3 m+n) / d_{0}  \tag{D11}\\
N & =\left(3 m^{2}+n^{2}\right) / d_{0} \tag{D12}
\end{align*}
$$

where $d_{0}$ is the greatest common divisor of the numerators of $\alpha, \beta, \gamma, N$. Note that $\alpha$ should not be confused with the model parameter defined in Eq. (65) and used in the main text. If $3 \nmid n$ (i.e. 3 does not divide $n$ ) then the numerator of $N$ is $1(\bmod 3)$ so $3 \nmid d_{0}$. On the other hand, if $3 \mid n$ then $3 \mid d_{0}$ but $9 \nmid d_{0}$ since $3 \nmid m$. In either case $3 \nmid N$. If one of $m$ and $n$ is even, then the numerator of $N$ is odd so $d_{0}$ is odd. On the other hand, if $m$ and $n$ are both odd then $4 \mid d_{0}$, but considering the numerator of $\beta$ we see that $8 \nmid d_{0}$. If $p$ is a prime divisor of $d_{0}$ other than 2 then considering the numerator of $\beta$, we see that $p \mid m$ or $p \mid n$ but not both. Considering the numerator of $N$, we see that $p=3$. We conclude

$$
d_{0}=\operatorname{gcd}\left(4 m n, 3 m^{2}+n^{2}\right)= \begin{cases}1 & \text { if }(2 \mid n \text { or } 2 \mid m) \text { and } 3 \nmid n  \tag{D13}\\ 3 & \text { if }(2 \mid n \text { or } 2 \mid m) \text { and } 3 \mid n \\ 4 & \text { if } 2 \nmid n \text { and } 2 \nmid m \text { and } 3 \nmid n \\ 12 & \text { if } 2 \nmid n \text { and } 2 \nmid m \text { and } 3 \mid n\end{cases}
$$

so that $\operatorname{gcd}(\beta, N)=1$. Also, since $\operatorname{det}\left(a^{-1} R_{\theta_{0}} a\right)=1$ we have $\alpha \gamma+\beta^{2}=N^{2}$.
Assume for now that $(m, n) \neq(1,0)$ so that $\beta \neq 0$. Writing $\mathbf{u}_{-}$in components as $\mathbf{u}_{-}=x \hat{\mathbf{x}}+y \hat{\mathbf{y}}$ for integers $x, y$, Eq. (D2) becomes

$$
\frac{1}{N}\left(\begin{array}{cc}
\alpha & \beta  \tag{D14}\\
-\beta & \gamma
\end{array}\right)\binom{x}{y} \in \mathbb{Z}^{2}
$$

which is in turn equivalent to the pair of congruences

$$
\begin{align*}
\alpha x+\beta y & \equiv 0  \tag{D15}\\
-\beta x+\gamma y & (\bmod N)  \tag{D16}\\
\equiv 0 & (\bmod N)
\end{align*}
$$

Since $\beta \neq 0$ and $\operatorname{gcd}(\beta, N)=1$, we can multiply Eq. (D16) through by $\beta$. However since $-\beta^{2} \equiv \alpha \gamma(\bmod N)$, we see that this equation is implied Eq. (D15). Furthermore, Eq. (D15) can be solved as

$$
\begin{align*}
& x=n_{1} \\
& y=n_{1}\left(-\beta^{-1} \alpha\right)+n_{2} N \tag{D17}
\end{align*}
$$

for integers $n_{1}, n_{2}$, where $\beta^{-1}$ is the smallest non-negative integer such that $\beta^{-1} \beta=1\left(\bmod N^{2}\right)$. As a result, the set of integer vectors $\mathbf{u}$ such that $a^{-1} R_{\theta_{0}} a \mathbf{u}$ is an integer vector forms a Bravais lattice with primitive vectors

$$
\begin{align*}
& \mathbf{u}_{1}^{-}=\hat{\mathbf{x}}-\beta^{-1} \alpha \hat{\mathbf{y}}  \tag{D18}\\
& \mathbf{u}_{2}^{-}=N \hat{\mathbf{y}}
\end{align*}
$$

In the case $(m, n)=(1,0), a^{-1} R_{\theta_{0}} a=I, N=1$, and $\beta^{-1}=0$ so this result still holds. The image of this lattice under $a^{-1} R_{\theta_{0}} a$ is also a Bravais lattice with corresponding primitive vectors

$$
\begin{align*}
\mathbf{u}_{1}^{+} & =a^{-1} R_{\theta_{0}} a \mathbf{u}_{1}^{-}=-\alpha \rho \hat{\mathbf{x}}+\left(\beta \rho-\beta^{-1} N\right) \hat{\mathbf{y}} \\
\mathbf{u}_{2}^{+} & =a^{-1} R_{\theta_{0}} a \mathbf{u}_{2}^{-}=\beta \hat{\mathbf{x}}+\gamma \hat{\mathbf{y}}  \tag{D19}\\
\rho & =\left(\beta^{-1} \beta-1\right) / N \in N \mathbb{Z} .
\end{align*}
$$

We conclude that the commensuration superlattice takes the form

$$
\begin{equation*}
L_{-} \cap L_{+}=\left\{R_{-\theta_{0} / 2} a\left(n_{1} \mathbf{u}_{1}^{+}+n_{2} \mathbf{u}_{2}^{+}\right) \mid n_{1}, n_{2} \in \mathbb{Z}\right\}=\left\{R_{\theta_{0} / 2} a\left(n_{1} \mathbf{u}_{1}^{-}+n_{2} \mathbf{u}_{2}^{-}\right) \mid n_{1}, n_{2} \in \mathbb{Z}\right\} \tag{D20}
\end{equation*}
$$

Note that the unit cell of $L_{-} \cap L_{+}$has area $N|\Omega|$.
We can use this result to compute the reciprocal lattice of $L_{-} \cap L_{+}$. Let this reciprocal lattice be called $\tilde{P}$ and note that primitive vectors for $\tilde{P}$ can be given by

$$
\begin{align*}
& \tilde{\mathbf{u}}_{1}=\frac{1}{N} R_{-\theta_{0} / 2} b(\gamma \hat{\mathbf{x}}-\beta \hat{\mathbf{y}})=R_{\theta_{0} / 2} b \hat{\mathbf{x}}  \tag{D21}\\
& \tilde{\mathbf{u}}_{2}=R_{-\theta_{0} / 2} b\left[\left(-\beta \rho / N+\beta^{-1}\right) \hat{\mathbf{x}}-(\alpha \rho / N) \hat{\mathbf{y}}\right]=\frac{1}{N} R_{\theta_{0} / 2} b\left(\beta^{-1} \alpha \hat{\mathbf{x}}+\hat{\mathbf{y}}\right)
\end{align*}
$$

Since $\rho / N$ is an integer, $\tilde{\mathbf{u}}_{1} \in P_{-}, \tilde{\mathbf{u}}_{2} \in P_{+}$so $\tilde{P} \subset P_{-}+P_{+}$. However, by the definition of the reciprocal lattice $P_{-}+P_{+} \subset \tilde{P}$ so that $\tilde{P}=P_{-}+P_{+}$. Note that the unit cell for $\tilde{P}$ has area $|\mathrm{BZ}| / N$.

Since Eqs. (D7) and (D8) are related by the interchange of $\alpha$ and $\gamma$, corresponding results for the reciprocal lattices can be obtained by interchanging $\alpha$ and $\gamma$. The set of integer vectors $\mathbf{v}$ such that $b^{-1} R_{\theta_{0}} b \mathbf{v}$ is an integer vector forms a Bravais lattice with primitive vectors

$$
\begin{align*}
& \mathbf{v}_{1}^{-}=\hat{\mathbf{x}}-\beta^{-1} \gamma \hat{\mathbf{y}} \\
& \mathbf{v}_{2}^{-}=N \hat{\mathbf{y}} \tag{D22}
\end{align*}
$$

and the image of this lattice under $b^{-1} R_{\theta_{0}} b$ is also a Bravais lattice with corresponding primitive vectors

$$
\begin{align*}
& \mathbf{v}_{1}^{+}=b^{-1} R_{\theta_{0}} b \mathbf{v}_{1}^{-}=-\gamma \rho \hat{\mathbf{x}}+\left(\beta \rho-\beta^{-1} N\right) \hat{\mathbf{y}}  \tag{D23}\\
& \mathbf{v}_{2}^{+}=b^{-1} R_{\theta_{0}} b \mathbf{v}_{2}^{-}=\beta \hat{\mathbf{y}}+\alpha \hat{\mathbf{y}}
\end{align*}
$$

We conclude

$$
\begin{equation*}
P_{-} \cap P_{+}=\left\{R_{-\theta_{0} / 2} b\left(n_{1} \mathbf{v}_{1}^{+}+n_{2} \mathbf{v}_{2}^{+}\right) \mid n_{1}, n_{2} \in \mathbb{Z}\right\}=\left\{R_{\theta_{0} / 2} b\left(n_{1} \mathbf{v}_{1}^{-}+n_{2} \mathbf{v}_{2}^{-}\right) \mid n_{1}, n_{2} \in \mathbb{Z}\right\} \tag{D24}
\end{equation*}
$$

the reciprocal lattice of $P_{-} \cap P_{+}$is $L_{-}+L_{+}$, and the unit cell of $P_{-} \cap P_{+}$has area $N|\mathrm{BZ}|$.

## 3. Equivalences between top and bottom $K$ and $K^{\prime}$ points

We will now derive Eqs. (12) to (14) starting with Eq. (14). By Eq. (2),

$$
\begin{align*}
\mathbf{K}_{l} & =R_{-l \theta_{0} / 2} \mathbf{K} \\
& =R_{-l \theta_{0} / 2}\left(2 \mathbf{b}_{1}+\mathbf{b}_{2}\right) / 3  \tag{D25}\\
& =R_{-l \theta_{0} / 2} b(2 \hat{\mathbf{x}}+\hat{\mathbf{y}}) / 3
\end{align*}
$$

and similarly $\mathbf{K}_{l}^{\prime}=R_{-l \theta_{0} / 2} b(\hat{\mathbf{x}}+2 \hat{\mathbf{y}})$, so that $\mathbf{K}_{l}-\mathbf{K}_{l}^{\prime}=R_{-l \theta_{0} / 2}(\hat{\mathbf{x}}-\hat{\mathbf{y}}) / 3$. Examining the primitive vectors $\tilde{\mathbf{u}}_{1}$ and $\tilde{\mathbf{u}}_{2}$ for $P_{-}+P_{+}$in Eq. (D21), we see that if $R_{-l \theta_{0} / 2} b \mathbf{v} \in P_{-}+P_{+}$where $\mathbf{v}$ is a rational vector then the denominators of $\mathbf{v} \cdot \hat{\mathbf{x}}$ and $\mathbf{v} \cdot \hat{\mathbf{y}}$ must divide $N$. Since $3 \nmid N$, it follows that $\mathbf{K}_{l}-\mathbf{K}_{l}^{\prime} \notin P_{-}+P_{+}$, which is Eq. (14).

Next, since $3 \nmid N$ there is an integer $k \in\{0,1,2\}$ such that

$$
\begin{equation*}
k N=2+\beta^{-1} \gamma \quad(\bmod 3) \tag{D26}
\end{equation*}
$$

so that by Eq. (D22) we have

$$
\begin{equation*}
\mathbf{v}_{1}^{-}+k \mathbf{v}_{2}^{-}=\hat{\mathbf{x}}+2 \hat{\mathbf{y}} \quad(\bmod 3) \tag{D27}
\end{equation*}
$$

Recalling that $\mathbf{v}_{j}^{+}=b^{-1} R_{\theta_{0}} b \mathbf{v}_{j}^{-}$for $j=1,2$ we then have

$$
\begin{align*}
\mathbf{K}_{-} & =-R_{\theta_{0} / 2} b\left(\mathbf{v}_{1}^{-}+k \mathbf{v}_{2}^{-}\right) / 3+\mathbf{G}_{-} \\
& =-R_{-\theta_{0} / 2} b\left(\mathbf{v}_{1}^{+}+k \mathbf{v}_{2}^{+}\right) / 3+\mathbf{G}_{-} \\
\mathbf{K}_{-}^{\prime} & =R_{\theta_{0} / 2} b\left(\mathbf{v}_{1}^{-}+k \mathbf{v}_{2}^{-}\right) / 3+\mathbf{G}_{-}^{\prime}  \tag{D28}\\
& =R_{-\theta_{0} / 2} b\left(\mathbf{v}_{1}^{+}+k \mathbf{v}_{2}^{+}\right) / 3+\mathbf{G}_{-}^{\prime}
\end{align*}
$$

for some $\mathbf{G}_{-}, \mathbf{G}_{-}^{\prime} \in P_{-}$. Multiplying these equations by $R_{-\theta_{0}}$, we find

$$
\begin{align*}
& \mathbf{K}_{+}=-R_{-\theta_{0} / 2} b\left(\mathbf{v}_{1}^{-}+k \mathbf{v}_{2}^{-}\right) / 3+\mathbf{G}_{+} \\
& \mathbf{K}_{+}^{\prime}=R_{-\theta_{0} / 2} b\left(\mathbf{v}_{1}^{-}+k \mathbf{v}_{2}^{-}\right) / 3+\mathbf{G}_{+}^{\prime} \tag{D29}
\end{align*}
$$

where $\mathbf{G}_{+}=R_{-\theta_{0}} \mathbf{G}_{-} \in P_{+}$and $\mathbf{G}_{+}^{\prime}=R_{-\theta_{0}} \mathbf{G}_{+}^{\prime} \in P_{+}$. Note that

$$
\begin{equation*}
\mathbf{K}_{+}-\mathbf{K}_{-}=R_{-\theta_{0} / 2} b\left(\mathbf{v}_{1}^{+}-\mathbf{v}_{1}^{-}+k\left(\mathbf{v}_{2}^{+}-\mathbf{v}_{2}^{-}\right)\right) / 3+\mathbf{G}_{+}-\mathbf{G}_{-} \tag{D30}
\end{equation*}
$$

so $\mathbf{K}_{+}-\mathbf{K}_{-} \in P_{-}+P_{+}$if and only if $R_{-\theta_{0} / 2} b\left(\mathbf{v}_{1}^{+}-\mathbf{v}_{1}^{-}+k\left(\mathbf{v}_{2}^{+}-\mathbf{v}_{2}^{-}\right)\right) / 3 \in P_{-}+P_{+}$. By the same argument as before, we see that $\mathbf{K}_{+}-\mathbf{K}_{-} \in P_{-}+P_{+}$if and only if

$$
\begin{equation*}
\mathbf{v}_{1}^{+}+k \mathbf{v}_{2}^{+}=\hat{\mathbf{x}}+2 \hat{\mathbf{y}} \quad(\bmod 3) \tag{D31}
\end{equation*}
$$

in which case we also have $\mathbf{K}_{+}^{\prime}-\mathbf{K}_{-}^{\prime} \in P_{-}+P_{+}$. Similarly, $\mathbf{K}_{+}-\mathbf{K}_{-}^{\prime} \in P_{-}+P_{+}$if and only if

$$
\begin{equation*}
\mathbf{v}_{1}^{+}+k \mathbf{v}_{2}^{+}=2 \hat{\mathbf{x}}+\hat{\mathbf{y}} \quad(\bmod 3) \tag{D32}
\end{equation*}
$$

in which case we also have $\mathbf{K}_{+}^{\prime}-\mathbf{K}_{-} \in P_{-}+P_{+}$.
Using Eqs. (D23) and (D26), $\alpha \gamma+\beta^{2}=N^{2}=1(\bmod 3)$, and $\beta=\alpha-\gamma$, one can show

$$
\begin{equation*}
\mathbf{v}_{1}^{+}+k \mathbf{v}_{2}^{+}=N(\alpha+\gamma)(2 \hat{\mathbf{x}}+\hat{\mathbf{y}}) \quad(\bmod 3) \tag{D33}
\end{equation*}
$$

Additionally, using Eq. (D13) we find

$$
\begin{align*}
N(\alpha+\gamma) & =2\left(9 m^{4}-n^{4}\right) / d_{0}^{2} \\
& =\left\{\begin{array}{lll}
1 & (\bmod 3) & \text { if } 3 \nmid n \\
2 & (\bmod 3) & \text { if } 3 \mid n .
\end{array}\right. \tag{D34}
\end{align*}
$$

Let $\left(\mathbf{J}_{-}, \mathbf{J}_{-}^{\prime}\right)$ denote $\left(\mathbf{K}_{-}, \mathbf{K}_{-}^{\prime}\right)$ when $3 \mid n$ and $\left(\mathbf{K}_{-}^{\prime}, \mathbf{K}_{-}\right)$when $3 \nmid n$. We then conclude $\mathbf{K}_{+}-\mathbf{J}_{-}, \mathbf{K}_{+}^{\prime}-\mathbf{J}_{-}^{\prime} \in P_{-}+P_{+}$, which is equivalent to Eqs. (12) and (13).

## 4. Pairs of complementary commensurate configurations

It follows from App. C that when $\theta_{0}$ is a commensurate angle, $\pi / 3-\theta_{0}$ is also a commensurate angle. We will now prove this statement another way and consider an important relationship between the two configurations that is used in Sec. II B.

Returning to the notation of App. D 1, let

$$
\begin{align*}
& x_{1}=\cos \left(\pi / 3-\theta_{0}\right)=\frac{1}{2}\left(x_{0}+3 y_{0}\right) \\
& y_{1}=\frac{1}{\sqrt{3}} \sin \left(\pi / 3-\theta_{0}\right)=\frac{1}{2}\left(x_{0}-y_{0}\right) . \tag{D35}
\end{align*}
$$

Since $\theta_{0}$ is a commensurate angle, $x_{0}$ and $y_{0}$ are rational, and therefore $x_{1}$ and $y_{1}$ are rational. It follows that $\pi / 3-\theta_{0}$ is also commensurate. If $\left(x_{0}, y_{0}\right)$ corresponds to the integer pair $\left(m_{0}, n_{0}\right)$ and $\left(x_{1}, y_{1}\right)$ corresponds to the integer pair $\left(m_{1}, n_{1}\right)$ then

$$
\begin{equation*}
\frac{m_{1}}{n_{1}}=\frac{y_{1}}{1-x_{1}}=\frac{3 m_{0}^{2}-2 m_{0} n_{0}-n_{0}^{2}}{3\left(m_{0}-n_{0}\right)^{2}} \tag{D36}
\end{equation*}
$$

If $3 \mid n_{0}$ then $3 \nmid m_{0}$ so the denominator of this fraction is divisible by 3 exactly once. However, the numerator is also divisible by 3 so we conclude $3 \not X n_{1}$. On the other hand, suppose $3 \not X n_{0}$. It is straightforward to see that the largest power of 3 dividing the numerator is the same as the largest power of 3 dividing $m_{0}-n_{0}$, so we conclude $3 \mid n_{1}$. As a result, in one of the commensurate configurations corresponding to $\theta_{0}$ and $\pi / 3-\theta_{0}$ we have $\left(\mathbf{J}_{-}, \mathbf{J}_{-}^{\prime}\right)=\left(\mathbf{K}_{-}, \mathbf{K}_{-}^{\prime}\right)$, and in the other we have $\left(\mathbf{J}_{-}, \mathbf{J}_{-}^{\prime}\right)=\left(\mathbf{K}_{-}^{\prime}, \mathbf{K}_{-}\right)$.

## 5. The lattices $\mathcal{Q}_{+}$and $\mathcal{Q}_{0}$

In this section, we prove Eq. (32), find the minimal norm elements of $\left(\mathbf{K}_{-}+P_{-}\right) \cap\left(\mathbf{K}_{+}+P_{+}\right)$, and derive the forms of $L_{-} \cap L_{+}, P_{-} \cap P_{+}, L_{-}+L_{+}$, and $P_{-}+P_{+}$. As explained in Sec. II B, we assume $3 \mid n$ so that $\mathbf{J}_{-}=\mathbf{K}_{-}$. Since $\left(\mathbf{K}_{-}+P_{-}\right) \cap\left(\mathbf{K}_{+}+P_{+}\right)$is closed under addition by elements of $P_{-} \cap P_{+}$and has the property that the difference of any two elements is in $P_{-} \cap P_{+}$, we must have

$$
\begin{equation*}
\left(\mathbf{K}_{-}+P_{-}\right) \cap\left(\mathbf{K}_{+}+P_{+}\right)=\mathbf{k}_{0}+P_{-} \cap P_{+} \tag{D37}
\end{equation*}
$$

for some vector $\mathbf{k}_{0}$. Since $P_{-} \cap P_{+}$is a triangular lattice, $\mathbf{k}_{0}+P_{-} \cap P_{+}$has at most three elements of minimal norm. However, since $\left(\mathbf{K}_{-}+P_{-}\right) \cap\left(\mathbf{K}_{+}+P_{+}\right)$has 3 -fold rotational symmetry and does not contain 0 , it must have exactly three elements of minimal norm. Since $\left(\mathbf{K}_{-}+P_{-}\right) \cap\left(\mathbf{K}_{+}+P_{+}\right)$additionally has symmetry under reflection across the vector K, one of the elements of minimal norm must be proportional to $\mathbf{K}$. Since the unit cell of $P_{-} \cap P_{+}$has area $N|\mathrm{BZ}|$, we conclude $P_{-} \cap P_{+}=\sqrt{N} P$ and the element of minimal norm proportional to $\mathbf{K}$ must be $\mathbf{Q}_{1}=s \sqrt{N} \mathbf{K}$ where $s$ is 1 or -1 . The other two elements of minimal norm are $\mathbf{Q}_{2}=R_{2 \pi / 3} \mathbf{Q}_{1}$ and $\mathbf{Q}_{3}=R_{4 \pi / 3} \mathbf{Q}_{1}$, and we can write

$$
\begin{equation*}
\left(\mathbf{K}_{-}+P_{-}\right) \cap\left(\mathbf{K}_{+}+P_{+}\right)=s \sqrt{N} \mathbf{K}+P_{-} \cap P_{+} \tag{D38}
\end{equation*}
$$

Recalling from App. D 2 that the reciprocal lattice of $P_{-} \cap P_{+}$is $L_{-}+L_{+}$, it follows that $L_{-}+L_{+}=L / \sqrt{N}$. Applying the same argument to the real space lattices, we see that $L_{-} \cap L_{+}=\sqrt{N} L$ so that $P_{-}+P_{+}=P / \sqrt{N}$.

We will now determine the sign $s$. We have $s \sqrt{N} \mathbf{K}-\mathbf{K}_{l} \in P_{l}$ or equivalently $\left(s \sqrt{N} R_{l \theta_{0} / 2}-I\right) \mathbf{K} \in P$. Using the half-angle formulas and the results of Apps. D 1 and D 2 we find

$$
\begin{align*}
\cos \left(\theta_{0} / 2\right) & =\frac{m \sqrt{3}}{\sqrt{d_{0} N}}  \tag{D39}\\
\sin \left(\theta_{0} / 2\right) & =\frac{n}{\sqrt{d_{0} N}}  \tag{D40}\\
\left(s \sqrt{N} R_{l \theta_{0} / 2}-I\right) \mathbf{K} & =\frac{4 \pi \sqrt{3}}{9 a_{0}}\left(\left(\operatorname{sm} \sqrt{3 / d_{0}}-1\right) \hat{\mathbf{x}}+\left(\operatorname{sln} / \sqrt{d_{0}}\right) \hat{\mathbf{y}}\right) \tag{D41}
\end{align*}
$$

For comparison,

$$
\begin{equation*}
n_{1} \mathbf{b}_{1}+n_{2} \mathbf{b}_{2}=\frac{4 \pi \sqrt{3}}{9 a_{0}}\left(\left(3 n_{1} / 2\right) \hat{\mathbf{x}}+\left(n_{1} / 2-n_{2}\right) \sqrt{3} \hat{\mathbf{y}}\right) \tag{D42}
\end{equation*}
$$

By Eq. (D13), when $m \pm n$ is odd, we have $d_{0}=3$ so the equation $\left(s \sqrt{N} R_{l \theta_{0} / 2}-I\right) \mathbf{K}=n_{1} \mathbf{b}_{1}+n_{2} \mathbf{b}_{2}$ has a solution if and only if $s m=1(\bmod 3)$. When $m \pm n$ is even, we have $d_{0}=12$ so the same equation now has a solution if and only if $s m=2(\bmod 3)$. We summarize both cases by saying

$$
\begin{equation*}
s=\frac{m \pm n}{\sqrt{d_{0} / 3}} \quad(\bmod 3) \text { and } s= \pm 1 \tag{D43}
\end{equation*}
$$

## 6. $A A, A B, B A$ stacking commensurate configurations

We say that a commensurate configuration has $A A$ stacking if there is an $A$ sublattice atom on the top layer that is directly above some $A$ sublattice atom on the bottom layer. Similarly we say that a commensurate configuration has $A B(B A)$ stacking if there is a $B(A)$ sublattice atom on the top layer that is directly above some $A(B)$ sublattice atom on the bottom layer. For the commensurate configuration with $\theta_{0}=0$, it is clear that $\mathbf{d}=\mathbf{0}$ (i.e. no interlayer translation) corresponds to $A A$ stacking, $\mathbf{d}=a_{0} \hat{\mathbf{y}}$ corresponds to $A B$ stacking, and $\mathbf{d}=-a_{0} \hat{\mathbf{y}}$ corresponds to $B A$ stacking. We will now derive a generalization of this correspondence for commensurate configurations with $3 \mid n$.

We first consider $A A$ stacking. In this case, there is a pair of vectors $\mathbf{r}_{+} \in L_{+}$and $\mathbf{r}_{-} \in L_{-}$such that $\mathbf{r}_{+}+\boldsymbol{\tau}_{A}^{+}=$

$\mathbf{r}_{-}+\boldsymbol{\tau}_{A}^{-}$. Equivalently, we have $\boldsymbol{\tau}_{A}^{+}-\boldsymbol{\tau}_{A}^{-} \in L_{-}+L_{+}$. Using Eq. (D40), we have

$$
\begin{align*}
\boldsymbol{\tau}_{A}^{+}-\boldsymbol{\tau}_{A}^{-} & =\left(R_{-\theta_{0} / 2} \boldsymbol{\tau}_{A}-\mathbf{d} / 2\right)-\left(R_{\theta_{0} / 2} \boldsymbol{\tau}_{A}+\mathbf{d} / 2\right) \\
& =-\left(R_{\theta_{0} / 2}-R_{-\theta_{0} / 2}\right)\left(a_{0} \hat{\mathbf{y}}\right)-\mathbf{d} \\
& =2 \sin \left(\theta_{0} / 2\right)\left(a_{0} \hat{\mathbf{x}}\right)-\mathbf{d}  \tag{D44}\\
& =\frac{2 n}{\sqrt{d_{0} N}} a_{0} \hat{\mathbf{x}}-\mathbf{d} \\
& =n^{\prime} \mathbf{a}_{1} / \sqrt{N}-\mathbf{d}
\end{align*}
$$

where $n^{\prime}=2 n / \sqrt{3 d_{0}}$ is an integer since $3 \mid n$ and $d_{0} \in\{3,12\}$ by Eq. (D13). Since we found in App. D 5 that $L_{-}+L_{+}=L / \sqrt{N}$ we see that $\boldsymbol{\tau}_{A}^{+}-\boldsymbol{\tau}_{A}^{-} \in L_{-}+L_{+}$if and only if $\mathbf{d} \in L_{-}+L_{+}$. We conclude that $A A$ stacking corresponds to $\mathbf{d} \in L_{-}+L_{+}$. Since $\boldsymbol{\tau}_{B}=R_{-\pi / 3} \boldsymbol{\tau}_{A}$ and $\mathbf{a}_{2}=R_{-\pi / 3} \mathbf{a}_{1}$ we have

$$
\begin{equation*}
\boldsymbol{\tau}_{B}^{+}-\boldsymbol{\tau}_{B}^{-}=n^{\prime} \mathbf{a}_{2} / \sqrt{N}-\mathbf{d} \tag{D45}
\end{equation*}
$$

so that $\boldsymbol{\tau}_{B}^{+}-\boldsymbol{\tau}_{B}^{-} \in L_{-}+L_{+}$if and only if $\mathbf{d} \in L_{-}+L_{+}$. It follows that $A A$ stacking can equivalently be defined by saying that there is a $B$ sublattice atom on the top layer that is directly above some $B$ sublattice atom on the bottom layer. A commensurate configuration with $A A$ stacking is shown in Fig. 2.

Next, we consider $A B$ and $B A$ stacking. In $A B$ stacking, there are vectors $\mathbf{r}_{l} \in L_{l}$ such that $\mathbf{r}_{+}+\boldsymbol{\tau}_{B}^{+}=\mathbf{r}_{-}+\boldsymbol{\tau}_{A}^{-}$, or equivalently $\boldsymbol{\tau}_{B}^{+}-\boldsymbol{\tau}_{A}^{-} \in L_{-}+L_{+}$. Similarly, $B A$ stacking is equivalent to $\boldsymbol{\tau}_{A}^{+}-\boldsymbol{\tau}_{B}^{-} \in L_{-}+L_{+}$. Using Eqs. (D39) and (D40), we have

$$
\begin{align*}
\boldsymbol{\tau}_{A}^{l}-\boldsymbol{\tau}_{B}^{-l} & =-\left(R_{l \theta_{0} / 2} \boldsymbol{\tau}_{B}-R_{-l \theta_{0} / 2} \boldsymbol{\tau}_{A}\right)-l \mathbf{d} \\
& =-R_{-\pi / 6}\left(R_{\left(l \theta_{0}-\pi / 3\right) / 2}-R_{-\left(l \theta_{0}-\pi / 3\right) / 2}\right) \boldsymbol{\tau}_{A}-l \mathbf{d} \\
& =2 \sin \left(\left(l \theta_{0}-\pi / 3\right) / 2\right) R_{-\pi / 6}\left(a_{0} \hat{\mathbf{x}}\right)-l \mathbf{d}  \tag{D46}\\
& =\left(l \sin \left(\theta_{0} / 2\right) \sqrt{3}-\cos \left(\theta_{0} / 2\right)\right)\left(\boldsymbol{\tau}_{B}-\boldsymbol{\tau}_{A}\right)-l \mathbf{d} \\
& =-m^{\prime}\left(\boldsymbol{\tau}_{B}-\boldsymbol{\tau}_{A}\right) / \sqrt{N}-l \mathbf{d}
\end{align*}
$$

where $m^{\prime}=(m-l n) / \sqrt{d_{0} / 3}$ is an integer with $m^{\prime}=s(\bmod 3)$ by Eq. (D43). It follows that $\boldsymbol{\tau}_{A}^{l}-\boldsymbol{\tau}_{B}^{-l} \in L_{-}+L_{+}$ if and only if $\mathbf{d} \in-\frac{l s a_{0}}{\sqrt{N}} \hat{\mathbf{y}}+L_{-}+L_{+}$so that $A B$ stacking corresponds to $\mathbf{d} \in \frac{s}{\sqrt{N}} a_{0} \hat{\mathbf{y}}+L_{-}+L_{+}$and $B A$ stacking corresponds to $\mathbf{d} \in-\frac{s}{\sqrt{N}} a_{0} \hat{\mathbf{y}}+L_{-}+L_{+}$. Commensurate configurations with $A B$ and $B A$ stacking are shown in Fig. 14.

## E. $\quad L_{-}+L_{+}$and $P_{-}+P_{+}$are dense for incommensurate $\theta$

Suppose $\theta$ is an incommensurate angle. Recall from App. D 1 that this implies $x_{0}$ and $y_{0}$ are not both rational. It follows from Eq. (D4) that both columns and both rows of the matrix $a^{-1} R_{\theta} a$ contain an irrational value. It is well known that for any irrational number $z$, the set of fractional parts of integer multiples of $z$ is dense in the interval $[0,1)$. Equivalently, the set of integer linear combinations of 1 and $z$ is dense in $\mathbb{R}$. It follows that the set of integer linear combinations of $a^{-1} R_{\theta} a \hat{\mathbf{x}}, a^{-1} R_{\theta} a \hat{\mathbf{y}}, \hat{\mathbf{x}}, \hat{\mathbf{y}}$ is dense in $\mathbb{R}^{2}$. Since the linear map $R_{-\theta / 2} a$ is continuous and density is preserved under continuous maps, we conclude that $L_{-}+L_{+}$is dense in $\mathbb{R}^{2}$. A similar argument using Eq. (D5) shows that $P_{-}+P_{+}$is dense in $\mathbb{R}^{2}$ as well.

## F. Properties of the distance function $d$

1. We consider item 1 in Sec. II C which claims $d(\mathbf{k}, l, \mathbf{k}, l)=0$. If we write $\mathbf{k}+\mathbf{G}_{l}=\mathbf{k}+\mathbf{G}_{-l}$ where $\mathbf{G}_{l}=\mathbf{G}_{-l}=\mathbf{0}$, we then have $d(\mathbf{k}, l, \mathbf{k}, l)=\left|\mathbf{G}_{-l}\right|=0$.
2. We consider item 2 in Sec. II C which claims $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}, l\right)$. If $\mathbf{k}^{\prime}-\mathbf{k} \notin P_{-}+P_{+}$then $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=$ $\infty=d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}, l\right)$. Otherwise, suppose $\mathbf{k}+\mathbf{G}_{l}=\mathbf{k}^{\prime}+\mathbf{G}_{-l}$ for some $\mathbf{G}_{-} \in P_{-}, \mathbf{G}_{+} \in P_{+}$. There are two cases to consider:

- If $l^{\prime}=-l$ then $\mathbf{k}^{\prime}+\mathbf{G}_{l^{\prime}}=\mathbf{k}+\mathbf{G}_{-l^{\prime}}$ so that

$$
\begin{equation*}
d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=\left|\mathbf{k}+\mathbf{G}_{l}\right|=\left|\mathbf{k}^{\prime}+\mathbf{G}_{l^{\prime}}\right|=d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}, l\right) \tag{F1}
\end{equation*}
$$

- If $l^{\prime}=l$ then $\mathbf{k}^{\prime}-\mathbf{G}_{l^{\prime}}=\mathbf{k}-\mathbf{G}_{-l^{\prime}}$ so that

$$
\begin{equation*}
d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=\left|\mathbf{G}_{-l}\right|=\left|-\mathbf{G}_{-l^{\prime}}\right|=d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}, l\right) . \tag{F2}
\end{equation*}
$$

3. We consider item 3 in Sec. II C which claims

$$
\begin{equation*}
d\left(\mathbf{k}, l, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right) \leq d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)+d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right) \tag{F3}
\end{equation*}
$$

When either term on the right hand side is $\infty$, the inequality is trivially satisfied. If the left hand side is $\infty$ then $\mathbf{k}^{\prime \prime}-\mathbf{k} \notin P_{-}+P_{+}$. This implies that at least one of the terms on the right hand side must be $\infty$ as well, so the inequality is satisfied.

Otherwise, suppose

$$
\begin{align*}
\mathbf{k}+\mathbf{G}_{l} & =\mathbf{k}^{\prime}+\mathbf{G}_{-l} \\
\mathbf{k}^{\prime}+\mathbf{G}_{l^{\prime}}^{\prime} & =\mathbf{k}^{\prime \prime}+\mathbf{G}_{-l^{\prime}}^{\prime} \tag{F4}
\end{align*}
$$

for some $\mathbf{G}_{-}, \mathbf{G}_{-}^{\prime} \in P_{-}$and $\mathbf{G}_{+}, \mathbf{G}_{+}^{\prime} \in P_{+}$. It follows that

$$
\begin{equation*}
\mathbf{k}+\mathbf{G}_{l}+\mathbf{G}_{l^{\prime}}^{\prime}=\mathbf{k}^{\prime \prime}+\mathbf{G}_{-l}+\mathbf{G}_{-l^{\prime}}^{\prime} \tag{F5}
\end{equation*}
$$

We now consider three cases:
(a) Suppose $l=l^{\prime}=l^{\prime \prime}$ and without loss of generality we take $l=l^{\prime}=l^{\prime \prime}=+$. Then $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=\left|\mathbf{G}_{-}\right|$, $d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right)=\left|\mathbf{G}_{-}^{\prime}\right|$ and $\mathbf{k}+\mathbf{G}_{l}^{\prime \prime}=\mathbf{k}^{\prime \prime}+\mathbf{G}_{-l}^{\prime \prime}$ where

$$
\begin{align*}
& \mathbf{G}_{-}^{\prime \prime}=\mathbf{G}_{-}+\mathbf{G}_{-}^{\prime} \\
& \mathbf{G}_{+}^{\prime \prime}=\mathbf{G}_{+}+\mathbf{G}_{+}^{\prime} \tag{F6}
\end{align*}
$$

We then have

$$
\begin{align*}
d\left(\mathbf{k}, l, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right) & =\left|\mathbf{G}_{-}^{\prime \prime}\right| \\
& =\left|\mathbf{G}_{-}+\mathbf{G}_{-}^{\prime}\right|  \tag{F7}\\
& \leq d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)+d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right)
\end{align*}
$$

(b) Suppose $l=l^{\prime} \neq l^{\prime \prime}$ and without loss of generality we take $l=l^{\prime}=+, l^{\prime \prime}=-$. Then $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=\left|\mathbf{G}_{-}\right|$, $d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right)=\left|\mathbf{k}^{\prime \prime}+\mathbf{G}_{-}^{\prime}\right|$ and $\mathbf{k}+\mathbf{G}_{l}^{\prime \prime}=\mathbf{k}^{\prime \prime}+\mathbf{G}_{-l}^{\prime \prime}$ where

$$
\begin{align*}
& \mathbf{G}_{-}^{\prime \prime}=\mathbf{G}_{-}+\mathbf{G}_{-}^{\prime} \\
& \mathbf{G}_{+}^{\prime \prime}=\mathbf{G}_{+}+\mathbf{G}_{+}^{\prime} \tag{F8}
\end{align*}
$$

We then have

$$
\begin{align*}
d\left(\mathbf{k}, l, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right) & =\left|\mathbf{k}^{\prime \prime}+\mathbf{G}_{-}^{\prime \prime}\right| \\
& =\left|\mathbf{G}_{-}+\left(\mathbf{k}^{\prime \prime}+\mathbf{G}_{-}^{\prime}\right)\right|  \tag{F9}\\
& \leq d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)+d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right)
\end{align*}
$$

(c) Suppose $l=l^{\prime \prime} \neq l^{\prime}$ and without loss of generality we take $l=l^{\prime \prime}=+, l^{\prime}=-$. Then $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=\left|\mathbf{k}^{\prime}+\mathbf{G}_{-}\right|$, $d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right)=\left|\mathbf{k}^{\prime}+\mathbf{G}_{-}^{\prime}\right|$ and $\mathbf{k}+\mathbf{G}_{l}^{\prime \prime}=\mathbf{k}^{\prime \prime}+\mathbf{G}_{-l}^{\prime \prime}$ where

$$
\begin{align*}
& \mathbf{G}_{-}^{\prime \prime}=\mathbf{G}_{-}-\mathbf{G}_{-}^{\prime} \\
& \mathbf{G}_{+}^{\prime \prime}=\mathbf{G}_{+}-\mathbf{G}_{+}^{\prime} \tag{F10}
\end{align*}
$$

We then have

$$
\begin{align*}
d\left(\mathbf{k}, l, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right) & =\left|\mathbf{G}_{-}^{\prime \prime}\right| \\
& =\left|\mathbf{G}_{-}-\mathbf{G}_{-}^{\prime}\right| \\
& =\left|\left(\mathbf{k}^{\prime}+\mathbf{G}_{-}\right)-\left(\mathbf{k}^{\prime}+\mathbf{G}_{-}^{\prime}\right)\right|  \tag{F11}\\
& \leq d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)+d\left(\mathbf{k}^{\prime}, l^{\prime}, \mathbf{k}^{\prime \prime}, l^{\prime \prime}\right)
\end{align*}
$$

The last case in which $l \neq l^{\prime}=l^{\prime \prime}$ follows from the symmetry of $d$ and the case $l=l^{\prime} \neq l^{\prime \prime}$.

## G. Level sets of $d$

In this section we prove the characterization of $d$ described in Sec. IID. Recall that $P_{ \pm}^{0}=R_{-l \theta_{0} / 2} P$ and that $\theta=\theta_{0}+\delta \theta$ is an incommensurate angle, where $\theta_{0}$ is a commensurate angle and $\delta \theta$ is small. Let $\mathbf{k} \in \mathbb{R}^{2}, l \in\{+,-\}$, and let $\mathbf{k}_{0}=R_{l \delta \theta / 2} \mathbf{k}$. Suppose that $\mathbf{k}^{\prime}, l^{\prime}$ satisfy $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)<\infty$ so that we can write $\mathbf{k}+\mathbf{G}_{l}=\mathbf{k}^{\prime}+\mathbf{G}_{-l}$ for unique vectors $\mathbf{G}_{-} \in P_{-}, \mathbf{G}_{+} \in P_{+}$. Define $\mathbf{G}_{ \pm}^{0}=R_{ \pm \delta \theta / 2} \mathbf{G}_{ \pm} \in P_{ \pm}^{0}$ and $\mathbf{k}_{0}^{\prime}=\mathbf{k}_{0}+\mathbf{G}_{l}^{0}-\mathbf{G}_{-l}^{0} \in \mathbf{k}_{0}+P_{-}^{0}+P_{+}^{0}$. We then have

$$
\begin{align*}
\mathbf{k}^{\prime}-R_{l \delta \theta / 2} \mathbf{k}_{0}^{\prime} & =\left(\mathbf{k}+\mathbf{G}_{l}-\mathbf{G}_{-l}\right)-R_{l \delta \theta / 2}\left(\mathbf{k}_{0}+\mathbf{G}_{l}^{0}-\mathbf{G}_{-l}^{0}\right) \\
& =R_{-l \delta \theta / 2}\left(\mathbf{k}_{0}+\mathbf{G}_{l}^{0}\right)-R_{l \delta \theta / 2}\left(\mathbf{k}_{0}+\mathbf{G}_{l}^{0}\right)  \tag{G1}\\

where $D(\delta \theta)$ is defined by Eq. (19) and

where $\mathbf{Q}_{l^{\prime}} \in \mathcal{Q}\left(\mathbf{k}_{0}, l, \mathbf{k}_{0}^{\prime}, l^{\prime}\right)$. Furthermore, the vectors $\mathbf{k}_{0}^{\prime}$ and $\mathbf{Q}_{l^{\prime}}$ are uniquely determined because the vectors $\mathbf{G}_{-}$ and $\mathbf{G}_{+}$are uniquely determined. Additionally, since $\left|\mathbf{Q}_{-l}\right|=\left|\mathbf{k}_{0}+\mathbf{G}_{l}^{0}\right|=\left|\mathbf{k}+\mathbf{G}_{l}\right|$ and $\left|\mathbf{Q}_{l}\right|=\left|\mathbf{G}_{l}^{0}\right|=\left|\mathbf{G}_{l}\right|$ we have $d\left(\mathbf{k}, l, \mathbf{k}^{\prime}, l^{\prime}\right)=\left|\mathbf{Q}_{l^{\prime}}\right|$. The converse statement can be proved simply by tracing the above argument backwards.

## H. Equivalence of small rotations and spatially varying translations

We now derive Eqs. (47) and (48) which relate the $T$ and $S^{l}$ potentials in commensurate and incommensurate configurations. In this section, we denote continuum states $|\mathbf{p}, l, \alpha\rangle_{c}$ and $|\mathbf{r}, l, \alpha\rangle_{c}$ with twist angle $\theta=\theta_{0}+\delta \theta$ and translation vector $\mathbf{d}$ by $|\mathbf{p}, l, \alpha, \delta \theta, \mathbf{d}\rangle_{c}$ and $|\mathbf{r}, l, \alpha, \delta \theta, \mathbf{d}\rangle_{c}$, respectively. Since $|\mathbf{p}, l, \alpha, 0, \mathbf{d}\rangle_{c}$ is a state with crystal momentum $\mathbf{K}_{l}+\mathbf{p}$ which has been shifted by $-l \mathbf{d} / 2$ we must have

Next, let the continuum Hamiltonian $\tilde{H}$ with twist angle $\theta=\theta_{0}+\delta \theta$ and translation vector d be denoted $\tilde{H}(\delta \theta, \mathbf{d})$. Since the pattern of atoms near position $\mathbf{r}$ with $\theta=\theta_{0}+\delta \theta$ and $\mathbf{d}=\mathbf{0}$ is the same to first order in $\delta \theta$ as the pattern with $\theta=\theta_{0}$ and $\mathbf{d}=D(\delta \theta) \mathbf{r}$, we must have

& =e^{-i\left(\mathbf{K}_{-}+\mathbf{K}_{+}\right) \cdot D(\delta \theta) \mathbf{r} / 2}\left(\left\langle\mathbf{r},+, A, 0,\left.D(\delta \theta) \mathbf{r}\right|_{c}\left\langle\mathbf{r},+, B, 0,\left.D(\delta \theta) \mathbf{r}\right|_{c}\right) \tilde{H}(0, D(\delta \theta) \mathbf{r})\binom{|\mathbf{r},-, A, 0, D(\delta \theta) \mathbf{r}\rangle_{c}}{|\mathbf{r},-, B, 0, D(\delta \theta) \mathbf{r}\rangle_{c}}\right.\right. \\
& +O\left(\delta \theta^{2}\right) \\
& =e^{-i \cos (\theta / 2) \mathbf{K} \cdot D(\delta \theta) \mathbf{r}} T(\mathbf{r}, 0, D(\delta \theta) \mathbf{r})+O\left(\delta \theta^{2}\right) \tag{H6}
\end{align*}

which is equivalent to Eq. (47). Eq. (48) follows from a similar calculation.

## I. Symmetry representations

In this section, we give the representations of the unitary and anti-unitary symmetries of twisted bilayer graphene referred to in Sec. III. For $\theta \neq 0$, the spinless symmetries of the full Hamiltonian are generated by the unitary operators $C_{6 z}$ (rotation by $\pi / 3$ about $\hat{\mathbf{z}}$ ), $C_{2 x}$ (rotation by $\pi$ about $\hat{\mathbf{x}}$ ), and the anti-unitary operator $\mathcal{T}$ (time-reversal). These operators take the form

where $R^{x}$ denotes reflection across the $x$ axis. The minus sign for $C_{2 x}$ reflects the fact that $|\mathbf{r}, l, \alpha\rangle$ are $p_{z}$ orbitals. The symmetry subgroup preserving valley is generated by $C_{2 z} \mathcal{T}, C_{3 z}$, and $C_{2 x}$, where $C_{2 z}=C_{6 z}^{3}$ and $C_{3 z}=C_{6 z}^{2}$. Using Eq. (4), we find

In the case $\theta=0$ there is an additional valley preserving unitary symmetry $M_{y}$ (reflection across the $x z$ plane). This operator has representations

For $\theta$ near $0, M_{y}$ can be considered an approximate symmetry.

## J. Determining the model parameters when $\delta \theta=0$

Recall from Sec. IIE that in the commensurate case, the continuum Hamiltonian approximates the four bands of $H$ nearest the Fermi level at charge neutrality. Explicitly, this model takes the form of a $\mathbf{p}$ dependent $4 \times 4$ matrix as shown in Eq. (59). In order to determine the parameters for this model, we will now describe a method to determine an effective Hamiltonian for these four bands directly from the microscopic Hamiltonian $H$.

Recall from Sec. II B that for commensurate configurations, $H$ is block diagonal with blocks of dimension $4 N$. Let $H(\mathbf{p})$ be the Hamiltonian block containing Bloch states $\left|\mathbf{K}_{l}+\mathbf{p}, l, \alpha\right\rangle$ for $l \in\{+,-\}, \alpha \in\{A, B\}$. In practice, the $4 N \times 4 N$ matrix representation for $H(\mathbf{p})$ can be computed accurately from Eqs. (6) and (9) with finitely many terms for each sum as long as the hopping functions $t_{+}(\mathbf{r})$ and $\hat{t}_{-}(\mathbf{k})$ decay rapidly enough. We diagonalize $H(\mathbf{p})$ as

for real eigenvalues $E_{1}(\mathbf{p}) \leq E_{2}(\mathbf{p}) \leq \cdots \leq E_{4 N}(\mathbf{p})$ and orthonormal eigenvectors $|\mathbf{p}, j\rangle$. The indices $j$ from $2 N-1$ to $2 N+2$ correspond to the four bands described by the continuum Hamiltonian.

Define the projection operators

Since the states $|\mathbf{p}, j\rangle$ are almost completely supported on the states $\left|\mathbf{K}_{l}+\mathbf{p}, l, \alpha\right\rangle$, the operators $P_{0}(\mathbf{p})$ and $P_{1}(\mathbf{p})$ are nearly the same. It follows that there is a canonical unitary operator $U(\mathbf{p})$ called the direct rotation that satisfies

and minimizes the Frobenius norm of $U(\mathbf{p})-I$ over all unitary operators satisfying Eq. (J3) [98]. The only condition upon which this theorem is dependent is $\left\|P_{0}(\mathbf{p})-P_{1}(\mathbf{p})\right\|_{o p}<1$, which is satisfied in practice. Here, we use the notation $\|M\|_{o p}$ to denote the operator norm of $M$. The direct rotation is given explicitly by

where $\sqrt{M}$ denotes the operator square root of $M$ and is defined using a branch cut of the function $z \mapsto \sqrt{z}$ along the negative real axis in the complex plane, with $\sqrt{1}=1$. The operator

is the result of projecting $H(\mathbf{p})$ onto the four bands of interest and then applying the direct rotation into the subspace spanned by the Bloch states $\left|\mathbf{K}_{l}+\mathbf{p}, l, \alpha\right\rangle$. Under the mapping $\left|\mathbf{K}_{l}+\mathbf{p}, l, \alpha\right\rangle \mapsto|\mathbf{p}, l, \alpha\rangle_{c}, H_{\text {eff }}(\mathbf{p})$ maps to an operator that should be considered the correct continuum Hamiltonian.

Let $\mathcal{H}_{\text {eff }}(\mathbf{p})$ be the $4 \times 4$ matrix representation of $H_{\text {eff }}(\mathbf{p})$ with respect to the basis $\left|\mathbf{K}_{l}+\mathbf{p}, l, \alpha\right\rangle$ so that $\mathcal{H}_{\text {eff }}(\mathbf{p})$ is directly comparable to the matrix $\mathcal{H}_{0}(\mathbf{p})$ defined in Eq. (59). These two matrices are explicitly dependent on $\mathbf{p}$, but also implicitly dependent on the translation vector $\mathbf{d}$. Recall from App. D 6 that $\mathbf{d}=\mathbf{0}$ corresponds to $A A$ stacking, $\mathbf{d}=\frac{s}{\sqrt{N}} a_{0} \hat{\mathbf{y}}$ corresponds to $A B$ stacking, and $\mathbf{d}=-\frac{s}{\sqrt{N}} a_{0} \hat{\mathbf{y}}$ corresponds to $B A$ stacking. By Eqs. (57) and (60), we have

where $\mathbf{d}_{A B}=\frac{s}{\sqrt{N}} a_{0} \hat{\mathbf{y}}$ so that $w_{0}, \chi_{0}, w_{2}$ determine $\mathcal{H}_{0}(\mathbf{p})$ for $A A$ stacking configurations, while $w_{1}$, $w_{2}$ determine $\mathcal{H}_{0}(\mathbf{p})$ for $A B$ and $B A$ stacking configurations. Furthermore, to determine the model parameters, it suffices to compare $\mathcal{H}_{\text {eff }}(\mathbf{p})$ and $\mathcal{H}_{0}(\mathbf{p})$ at $\mathbf{p}=\mathbf{0}$ and a single generic $\mathbf{d}$ value. For simplicity, we instead use $\mathbf{p}=\mathbf{0}$ and both $\mathbf{d}=\mathbf{0}$ and $\mathbf{d}=\mathbf{d}_{A B}$ to determine the model parameters shown in Tabs. I and II. These computations are performed using the hopping functions $t_{ \pm}(\mathbf{r})$ given in App. K.

To validate the accuracy of these results, we compute the relative error

using the parameters in Tab. II, where $\|M\|$ denotes the Frobenius norm of $M$. We compute this relative error as a function of $\mathbf{d}$ and $\mathbf{p}$, where $\mathbf{d}$ varies over a unit cell of $2 L / \sqrt{N}$ (recalling from Sec. IIE that both $H$ and $\tilde{H}$ are periodic up to unitary equivalence with respect to $L / \sqrt{N}$ ), and $|\mathbf{p}|$ varies from 0 to $3\left|\mathbf{p}_{0}\right| / 2$ where $\hbar v_{F}\left|\mathbf{p}_{0}\right|=3\left|w_{0}\right|$ (see Fig. 5). Specifically, for each value of $|\mathbf{p}|$, we compute the maximal relative error for $\mathbf{d}$ in a $10 \times 10$ discretization of a unit cell of $2 L / \sqrt{N}$ and for five values of $\mathbf{p}$ with the given magnitude. The results are shown in Fig. 15 for the first 6 commensurate configurations. The relative errors for all configurations other than $(m, n)=(1,0)$ (and $\left.\theta_{0}=0^{\circ}\right)$ are less than $10^{-2}$ for all $|\mathbf{p}|$ values considered and are less than $10^{-3.5}$ for $\mathbf{p}=\mathbf{0}$. The relative errors for $(m, n)=(1,0)$ are larger but still bounded by $10^{-1}$ for all $|\mathbf{p}|$ values considered, and the relative error at $\mathbf{p}=\mathbf{0}$ is less than 0.03 . We conclude that $\tilde{H}$ is an accurate model for the four bands of $H$ nearest the Fermi level at charge neutrality for all $\mathbf{d}$ and small $\mathbf{p}$. Fig. 16 compares the eigenvalues of $\mathcal{H}_{\mathrm{eff}}(\mathbf{p})$ and $\mathcal{H}_{0}(\mathbf{p})$ for each commensurate configuration in Tab. II as a function of $\mathbf{p}$ for three values of $\mathbf{d}$.

where $A_{0}=-2.7 \mathrm{eV}$ and $B_{0}=0.48 \mathrm{eV}$ are transfer integrals, $r_{z}=2.36 a_{0}$ is the interlayer spacing, and $\delta_{0}=0.318 a_{0}$ is chosen so that $t_{+}\left(\mathbf{a}_{1}\right) \approx t_{+}\left(\boldsymbol{\tau}_{B}-\boldsymbol{\tau}_{A}\right) / 10$. Using Eqs. (6) and (7) we find

We now consider the continuum Hamiltonian $\tilde{H}$ in Eq. (69) as a function $\tilde{H}\left(\phi_{0}, w_{0}, w_{1}, w_{2}, \delta \theta, s\right)$ of the shown parameters. By Eq. (36), we have

These operators act within the $\mathbf{K}$ valley and the origin of quasi-momentum $\mathbf{p}$ is the $\boldsymbol{\Gamma}_{M}$ point of the moiré Brillouin zone. These operators are unitary and satisfy

It follows that $\tilde{H}$ is always equivalent up to a sign and a unitary change of basis from the case in which $s=1$, $0 \leq \phi_{0} \leq \pi / 2$, and $w_{0}, w_{1}, \delta \theta \geq 0$, so it is sufficient to restrict the parameters in these ranges in calculations.

In particular, we have

Therefore, when $\phi_{0}=\pi / 2$, the system has a combined $C P$ symmetry, although neither $C$ nor $P$ is a symmetry. Moreover, noting that the $C P$ operator map momentum $\mathbf{p}$ to $-\mathbf{p}, C P$ symmetry implies that the energy spectrum at $\phi_{0}=\pi / 2$ is symmetric between $\mathbf{p}$ and $-\mathbf{p}$, as can be seen in Fig. 10(d)-(f)).

## M. Wilson loops and quasi-momentum truncation

In order to make the moiré translation symmetry of the Hamiltonian in Eq. (69) more explicit, we now reparametrize the states $|\mathbf{p}\rangle_{c}^{\prime}$ defined in Eq. (68), following the approach of [80]. Note that we can write the moiré quasi-momentum $\mathbf{p}+l \mathbf{q}_{1}$ uniquely in the form $\mathbf{q}+\mathbf{g}_{0}$ where $\mathbf{q} \in \mathrm{BZ}_{M}$ and $\mathbf{g}_{0} \in D(\delta \theta) \mathcal{Q}_{0}$. We then have $\mathbf{p}=\mathbf{q}-\mathbf{g}$ where $\mathbf{g}=l \mathbf{q}_{1}-\mathbf{g}_{0} \in$ $D(\delta \theta) \mathcal{Q}_{l}$. With this motivation, for $\mathbf{q} \in \mathbb{R}^{2}, \mathbf{g} \in D(\delta \theta) \mathcal{Q}_{l}, l \in\{+,-\}$, and $\alpha \in\{A, B\}$ we define

Although the states $|\mathbf{q}, \mathbf{g}, \alpha\rangle_{M}$ for $\mathbf{q} \in \mathrm{BZ}_{M}$ form a continuous basis for the Hilbert space, it is useful to define the overcomplete set of states $|\mathbf{q}, \mathbf{g}, \alpha\rangle_{M}$ for $\mathbf{q} \in \mathbb{R}^{2}$.

Using this notation, the continuum Hamiltonian can be written

where the infinite dimensional Hamiltonian matrix $\mathcal{H}(\mathbf{q})$ has elements

Consider some set of $N_{b} \geq 1$ bands of $\mathcal{H}(\mathbf{q})$ that are disconnected from all other bands throughout $\mathrm{BZ}_{M}$. Let $U(\mathbf{q})$ be a matrix whose columns form an orthonormal basis for this set of bands. Importantly, we require

for $\mathbf{g}_{0} \in D(\delta \theta) \mathcal{Q}_{0}$. As a result, $\mathcal{A}$ is a well defined $U\left(N_{b}\right)$ gauge connection on the torus $\mathbb{T}=\mathbb{R}^{2} / D(\delta \theta) \mathcal{Q}_{0}$.
For any closed loop $\boldsymbol{\Gamma}$ in $\mathbb{T}$, we define the gauge covariant Wilson loop unitary

where $\mathcal{P}$ indicates path ordering. For each $0 \leq x<1$, we define the loop $\boldsymbol{\Gamma}_{x}(t)=x\left(\mathbf{q}_{3}-\mathbf{q}_{2}\right)+t\left(\mathbf{q}_{1}-\mathbf{q}_{2}\right)$ for $0 \leq t \leq 1$. Following [99], we compute

& =\lim _{N_{q} \rightarrow \infty} \prod_{j=N_{q}-1}^{0} I-\mathcal{A}\left(\boldsymbol{\Gamma}_{x}\left(t_{j+1}\right)\right) \cdot\left(\boldsymbol{\Gamma}_{x}\left(t_{j+1}\right)-\boldsymbol{\Gamma}_{x}\left(t_{j}\right)\right)  \tag{M12}\\
& =\lim _{N_{q} \rightarrow \infty} \prod_{j=N_{q}-1}^{0} I-U^{\dagger}\left(\boldsymbol{\Gamma}_{x}\left(t_{j+1}\right)\right)\left(U\left(\boldsymbol{\Gamma}_{x}\left(t_{j+1}\right)\right)-U\left(\boldsymbol{\Gamma}_{x}\left(t_{j}\right)\right)\right) \\
& =\lim _{N_{q} \rightarrow \infty} \prod_{j=N_{q}-1}^{0} U^{\dagger}\left(\boldsymbol{\Gamma}_{x}\left(t_{j+1}\right)\right) U\left(\boldsymbol{\Gamma}_{x}\left(t_{j}\right)\right)
\end{align*}

where $I$ is the identity matrix and $t_{j}=j / N_{q}$. Since $W\left(\boldsymbol{\Gamma}_{x}\right)$ is gauge covariant, its spectrum is gauge invariant. We will refer to the spectrum of $-i \ln \left(W\left(\boldsymbol{\Gamma}_{x}\right)\right)$ as a function of $x$ as the Wilson loop band structure.

When we numerically compute the energy or Wilson loop band structure of $\tilde{H}$, we must truncate the infinite dimensional matrices $\mathcal{H}(\mathbf{q}), V\left(\mathbf{g}_{0}\right)$, and $U(\mathbf{q})$ to a finite number of dimensions. Since the infinite dimensional nature of $\mathcal{H}(\mathbf{q})$ comes from the infinite size of $\mathcal{Q}_{l}$, we equivalently need to choose a truncation of the lattices $\mathcal{Q}_{l}$. In order to make the symmetry operators $C_{3 z}, C_{2 x}$, and $P$ well defined (see Apps. I and L), we need a truncation $\tilde{\mathcal{Q}}_{l}$ of $\mathcal{Q}_{l}$ satisfying

One such truncation is given explicitly by

for some $M \geq 1$. See Fig. 17 for an illustration of $D(\delta \theta) \tilde{\mathcal{Q}}_{l}$ as defined by Eq. (M14) with $M=15$. This truncation is equivalent to the " $\boldsymbol{\Gamma}_{M}$-centered model" in Ref. [80]. As long as Eq. (M13) is satisfied, the finite dimensional truncated Hamiltonian retains exact $C_{2 z} \mathcal{T}, C_{3 z}$, and $C_{2 x}$ symmetries, and Eqs. (L1), (L2), (L4) and (L5) hold as well. However, it should be noted that the moiré translation symmetry in Eq. (M6) is exact only when $M=\infty$.

## N. Real space wavefunctions

In this section, we derive the form of the real space wavefunctions shown in Fig. 11. Suppose $v$ is an eigenvector of $\mathcal{H}(\mathbf{q})$ where $\mathcal{H}$ is given in Eq. (M4). In that case,

Using Eq. (M1), we have

summed over one or more eigenvectors $v$ with $\mathbf{q}=\boldsymbol{\Gamma}_{M}$. Importantly, this quantity is invariant under unitary mixing of the eigenvectors involved.

## O. Tripod model approximation for magic angle conditions

In this section, we use Eqs. (M3) and (M4) to approximate the condition under which the bands of the continuum Hamiltonian nearest the Fermi level at charge neutrality become flat near the $\mathbf{K}_{M}$ point in the moiré Brillouin zone. In order to make the model analytically tractable, we use the truncation

which produces a model called the "tripod Hamiltonian" [3, 80]. Although this truncation does not satisfy Eq. (M13), it nonetheless enables a simple calculation of the magic angle in small angle TBG.

We now consider the eigenvalue problem for the tripod Hamiltonian near the $\mathbf{K}_{M}$ point. We decompose the eigenvector $\psi$ in the form

where $\psi_{0}, \psi_{1}, \psi_{2}, \psi_{3}$ are two dimensional complex column vectors, $\mathbf{p}$ is a small vector, and the states $|\mathbf{q}, \mathbf{g}, \alpha\rangle_{M}$ are defined in Eq. (M1). The eigenvalue problem then takes the form

It is easy to see that this equation has real solutions for $\lambda$ if and only if $\left|w_{0}\right|<\left|w_{1}\right|$.
We conclude that the magic angle conditions for the tripod Hamiltonian are Eq. (O20) when either $w_{0}=0$ or $\phi_{0}=0$, and Eq. (O24) when $\phi_{0}= \pm \pi / 2$ and $\left|w_{0}\right|<\left|w_{1}\right|$.
