# <span id="page-0-1"></span>**Sobolev algebras on Lie groups and noncommutative geometry**

#### **Abstract**

We show that there exists a quantum compact metric space which underlies the setting of each Sobolev algebra associated to a subelliptic Laplacian  $\Delta = -(X_1^2 + \cdots + X_m^2)$  on a compact connected Lie group *G* if *p* is large enough, more precisely under the (sharp) condition  $p > \frac{d}{\alpha}$  where *d* is the local dimension of  $(G, X)$  and where  $0 < \alpha \leq 1$ . We also provide locally compact variants of this result and generalizations for real second order subelliptic operators. We also introduce a compact spectral triple (=noncommutative manifold) canonically associated to each subelliptic Laplacian on a compact group. In addition, we show that its spectral dimension is equal to the local dimension of (*G, X*). Finally, we prove that the Connes spectral pseudo-metric allows us to recover the Carnot-Carathéodory distance.

# <span id="page-0-0"></span>**1 Introduction**

Suppose  $1 < p < \infty$ . If  $\Delta_p$ : dom  $\Delta_p \subset L^p(\mathbb{R}^n) \to L^p(\mathbb{R}^n)$  is the (positive) Laplacian and if  $\alpha \in \mathbb{R}$ , we can consider the fractional powers  $\Delta_p^{\frac{\alpha}{2}}$  and  $(\text{Id} + \Delta_p)^{\frac{\alpha}{2}}$ . If  $\alpha < 0$ , these operators are the Riesz potential and the Bessel potential of order  $-\alpha$ . The last one was independently introduced by Aronszajn and Smith  $[8]$  and Calderón  $[16]$ , which is nowadays a classical notion in harmonic analysis, see  $[78, p. 131]$  and  $[44, Definition 1.2.4 p. 13]$ .

Strichartz proved in [\[79,](#page-38-1) Theorem 2.1, Chap. 2] that the Bessel potential space  $L^p_\alpha(\mathbb{R}^n) \stackrel{\text{def}}{=}$ <br> $\{f \in L^p(\mathbb{R}^n) : \text{ there exists } g \in L^p(\mathbb{R}^n) \text{ such that } f = (\text{Id} + \Delta_p)^{-\frac{\alpha}{2}}g\}$  is an algebra for the  $f \in L^p(\mathbb{R}^n)$ : there exists  $g \in L^p(\mathbb{R}^n)$  such that  $f = (\text{Id} + \Delta_p)^{-\frac{\alpha}{2}}g$  is an algebra for the

<span id="page-1-4"></span>pointwise product for any  $1 < p < \infty$  and any  $\alpha > 0$  such that  $\alpha p > n$ . Note that by [\[64,](#page-38-2) Theorem 12.3.4 p. 301], we have

$$
\mathcal{L}_{\alpha}^{p}(\mathbb{R}^{n})=\operatorname{dom}\Delta_{p}^{\frac{\alpha}{2}}.
$$

Indeed, for any  $1 < p < \infty$  and any  $\alpha > 0$ , Kato and Ponce showed in their work [\[54,](#page-37-1) Lemma X.4 p. 906] on Navier-Stokes equations, that  $L^p_\alpha(\mathbb{R}^n) \cap L^\infty(\mathbb{R}^n)$  is an algebra for the pointwise product (see also [\[47,](#page-37-2) Theorem 2.2.12 p. 81]). This is a stronger result since by the Sobolev embedding theorem  $[2,$  Theorem 1.2.4 (c) p. 14 we have a continuous inclusion  $L^p_\alpha(\mathbb{R}^n) \subset L^\infty(\mathbb{R}^n)$  if  $\alpha p > n$ . The proof is a simple consequence of the inequality

$$
(1.1) \t\t\t||fg||_{L^{p}_{\alpha}(\mathbb{R}^{n})} \lesssim_{\alpha,p} ||f||_{L^{p}_{\alpha}(\mathbb{R}^{n})} ||g||_{L^{\infty}(\mathbb{R}^{n})} + ||f||_{L^{\infty}(\mathbb{R}^{n})} ||g||_{L^{p}_{\alpha}(\mathbb{R}^{n})}
$$

for any  $f, g \in L^p_\alpha(\mathbb{R}^n) \cap L^\infty(\mathbb{R}^n)$ , where we use the graph norm of the closed operator  $\Delta_p^{\frac{\alpha}{2}}$

||f||_{L^p_{\alpha}(\mathbb{R}^n)} \stackrel{\text{def}}{=} ||f||_{L^p(\mathbb{R}^n)} + ||\Delta_p^{\frac{\alpha}{2}}(f)||_{L^p(\mathbb{R}^n)} \approx ||(\mathrm{Id} + \Delta_p)^{\frac{\alpha}{2}}(f)||_{L^p(\mathbb{R}^n)}.
$$

The motivation of this result was the estimate of  $\|(Id + \Delta_p)^{\frac{\alpha}{2}}(fg) - f(\mathrm{Id} + \Delta_p)^{\frac{\alpha}{2}}(g)\|_{L^p(\mathbb{R}^n)}$ for any Schwartz functions  $f$  and  $g$ . This commutator estimate is needed in the study of some nonlinear partial differential equations. We refer to [\[61\]](#page-38-3) and references therein for a comprehensive view of the state of the art in this kind of inequalities and to [\[64,](#page-38-2) Section 12.3] for several equivalent definitions of the Banach space  $L^p_\alpha(\mathbb{R}^n)$ .

In 1996, in their study of Schrödinger semigroups, Gulisashvili and Kon considered in [\[46\]](#page-37-3) the homogeneous Sobolev space  $\dot{L}^p_\alpha(\mathbb{R}^n)$  which is the completion of the space dom  $\Delta_p^{\frac{\alpha}{2}}$  with respect to the norm

(1.2) 
$$
||f||_{\dot{L}^p_{\alpha}(\mathbb{R}^n)} \stackrel{\text{def}}{=} ||\Delta_p^{\frac{\alpha}{2}}(f)||_{L^p(\mathbb{R}^n)}.
$$

Note that there exist several definitions of this abstract space. We refer to [\[66\]](#page-38-4) for more information. In this paper, we only use functions of this space belonging to dom  $\Delta_p^{\frac{\alpha^2}{2}}$ . If  $\alpha > 0$ , Gulisashvili and Kon observed that  $\dot{L}^p_\alpha(\mathbb{R}^n) \cap L^\infty(\mathbb{R}^n)$  is also an algebra for the pointwise product. This result is again a consequence of the Leibniz's rule [\[46,](#page-37-3) Theorem 1.4]

(1.3) \t\t\t ||f g||_{\dot{L}^p_\alpha(\mathbb{R}^n)} \lesssim_{\alpha,p} ||f||_{\dot{L}^p_\alpha(\mathbb{R}^n)} ||g||_{L^\infty(\mathbb{R}^n)} + ||f||_{L^\infty(\mathbb{R}^n)} ||g||_{\dot{L}^p_\alpha(\mathbb{R}^n)}.
$$

Coulhon, Russ and Tardivel-Nachef [\[25\]](#page-36-1) extended this result to the case of a unimodular connected Lie group *G* with polynomial volume growth by replacing the Laplacian by a subelliptic Laplacian  $-X_1^2 - \cdots - X_m^2$  where  $X \stackrel{\text{def}}{=} (X_1, \ldots, X_m)$  is a family of left-invariant Hörmander vector fields. Replacing  $\mathbb{R}^n$  by *G*, they obtain generalizations

$$

for any  $f, g \in L^p_\alpha(G) \cap L^\infty(G)$  and

$$
||fg||_{\dot{L}^p_\alpha(G)} \lesssim_{\alpha,p} ||f||_{\dot{L}^p_\alpha(G)} ||g||_{L^\infty(G)} + ||f||_{L^\infty(G)} ||g||_{\dot{L}^p_\alpha(G)}, \quad 0 < \alpha \leq 1
$$

 $(\alpha > 0$  if *G* is nilpotent) of the Leibniz's rules [\(1.1\)](#page-1-0) and [\(1.3\)](#page-1-1). Furthermore, they obtained algebras  $L^p_\alpha(G) \cap L^\infty(G)$  and  $L^p_\alpha(G) \cap L^\infty(G)$  called Sobolev algebras. Note that Bohnke has previously proved in [\[12,](#page-36-2) Théorème 1] that  $L^p_\alpha(G)$  is an algebra for the pointwise product if *G* is a stratified Lie group and if *αp > d* where *d* is the local dimension of the group. With the help of Sobolev embedding theorem  $L^p_\alpha(G) \subset L^\infty(G)$  under the condition  $\alpha p > d$ , we can see

<span id="page-2-1"></span>that this is a particular case of the results of  $[25]$ . See  $[15]$  and  $[72]$  for the more complicated case of non-unimodular Lie groups.

The concept of quantum compact metric space has its origins in Connes' paper [\[20\]](#page-36-4) of 1989, in which he shows that we can recover the geodesic distance dist of a compact oriented Riemannian spin manifold  $M$  using the Dirac operator  $\mathscr{D}$ , by the formula

\text{dist}(x, y) = \sup_{f \in \mathcal{C}(M), ||[\mathcal{D}, f]|| \leq 1} |f(x) - f(y)|, \quad x, y \in M
$$

where the supremum is taken on all the continuous functions such that the commutator  $[\mathscr{D}, f] \stackrel{\text{def}}{=}$  $\mathscr{D}f - f\mathscr{D}$  extends to a contractive operator. Recall that  $\mathscr{D}$  is an unbounded operator acting on the Hilbert space of  $L^2$ -spinors and that the functions of  $C(M)$  act on the same Hilbert space by multiplication operators. Indeed, it is well-known that the commutator  $[\mathscr{D}, f]$  induces a bounded operator if and only if *f* is a Lipschitz function and in this case the Lipschitz constant of f is equal to the norm  $\|\mathscr{D}, f\|$ . Moreover, this space of functions is norm dense in the space  $C(M)$  of continuous functions. See [\[21,](#page-36-5) Chapter 6] for more information and we refer to [\[85\]](#page-39-0) for a complete proof. If we identify the points  $x, y$  as pure states  $\omega_x$  and  $\omega_y$  on the unital  $C^*$ -algebra  $C(M)$ , we can see this formula as

$$
dist(\omega_x, \omega_y) = \sup_{f \in \mathcal{C}(M), ||[\mathscr{D}, f]|| \leq 1} |\omega_x(f) - \omega_y(f)|, \quad x, y \in M.
$$

After many years, Rieffel [\[75\]](#page-38-6) axiomatized this formula replacing the algebra C(*M*) by a unital C<sup>∗</sup>-algebra *A*,  $f \mapsto ||[{\mathscr{D}}, f]||$  by a seminorm  $|| \cdot ||$  defined on a dense subspace of *A* and  $\omega_x, \omega_y$  by arbitrary states of *A* obtaining essentially the formula [\(4.2\)](#page-11-0) below and giving rise to a theory of *quantum* compact metric spaces. With this notion, Rieffel was able to define a quantum analogue of Gromov-Hausdorff distance and to give a meaning to many approximations found in the physics literature, as the case of matrix algebras converging to a sphere. Moreover, as research in noncommutative metric geometry progressed, some additional conditions are often added as Leibniz's rules

$$
\|ab\| \lesssim \|a\| \|b\|_A + \|a\|_A \|b\|_B, \quad a, b \in \text{dom}\, \|\cdot\|
$$

which reminds  $(1.1)$  and  $(1.3)$ .

If *G* is a compact connected Lie group *G* and if  $\alpha p > d$ , we show that  $(C(G), \lVert \cdot \rVert_{\dot{L}^p_\alpha(G)})$ is a quantum compact metric space which underlies the setting of each Leibniz's rule [\(1.5\)](#page-1-2) associated to a subelliptic Laplacian  $\Delta$  on a compact connected Lie group *G*. Here C(*G*) is the algebra of continuous function on *G*. We also provide locally compact variants for non-compact groups in Section [5](#page-15-0) with the help of seminorms  $\|\cdot\|_{L^p_\alpha(G)}$ . Finally, our approach is flexible and should be adaptable to different contexts. The present work gets its inspiration from the papers [\[74\]](#page-38-7), [\[50\]](#page-37-4) and [\[7\]](#page-35-3).

Spectral triples are generalizations of the setting of Hodge-Dirac operators and Dirac operators on compact oriented Riemannian (spin) manifolds. This notion has emerged as a mean to encode geometric information of spaces in operator and spectral theory. It is at the heart of noncommutative geometry and used to describe quantum spaces providing efficient tools for such an analysis. Remarkably, this notion also provide a framework for the study of classical spaces as fractals (e.g. [\[19\]](#page-36-6)) or orbifolds. We refer to [\[22\]](#page-36-7) for an extensive list of examples.

We introduce a spectral triple associated to each subelliptic Laplacian on a compact connected Lie group *G* and we show that the spectral dimension is equal to the local dimension of  $(G, X)$  where  $X \stackrel{\text{def}}{=} (X_1, \ldots, X_m)$  is the family of left-invariant Hörmander vector fields which

<span id="page-3-4"></span>defines the subelliptic Laplacian [\(3.9\)](#page-8-0). In retrospect, our proof of this computation is quite simple. However, a variant shows a link between what we call the *local Coulhon-Varopoulos dimension* of a suitable (symmetric) markovian semigroup  $(T_t)_{t\geq0}$  acting on  $L^{\infty}(\Omega)$  where  $\Omega$  is a finite measure space and the spectral dimension of the spectral triple defined by an associated canonical Hodge-Dirac operator. We will investigate this more general setting in a future publication [\[Arh22\]](#page-35-4), also providing generalizations to suitable markovian semigroups acting on von Neumann algebras.

<span id="page-3-1"></span>Recall that this dimension is defined as the infimum of positive real numbers *d* such that

||T_t||_{L^1(\Omega) \to L^\infty(\Omega)} \lesssim \frac{1}{t^{\frac{d}{2}}}, \quad 0 < t \leq 1,
$$

see [\[23\]](#page-36-8) and [\[24,](#page-36-9) p. 187] (see also [\[17\]](#page-36-10) for a related work). Note that the terminology *ultracontractivity* is equally used in [\[6,](#page-35-5) Section 7.3.2] and in [\[5\]](#page-35-6). This notion is also referred in [\[87\]](#page-39-1) under the more suitable term *local ultracontractivity*. We warn the reader that really different defini-tions of ultracontractivity coexist in the literature, e.g. see [\[28\]](#page-36-11), [\[26\]](#page-36-12), [\[30,](#page-36-13) p. 89] and [\[45\]](#page-37-5). In the case of a connected Lie group  $G$  equipped with a family  $X$  of left-invariant Hörmander vector fields, the inequality [\(1.7\)](#page-3-1) is satisfied for the heat semigroup whose generator is the opposite −∆ of the subelliptic Laplacian and the local dimension *d* of (*G, X*).

**Structure of the paper** The paper is organized as follows. Section [2](#page-3-0) gives background on operator theory. The aim of Section [3](#page-5-0) is to describe our setting related to Lie groups and to prove some preliminary useful results. In Section [4,](#page-10-0) we show the existence of our quantum compact metric spaces. Section [5](#page-15-0) is devoted to give *locally* compact variants of these quantum compact metric spaces. In Section [6,](#page-20-0) we introduce new compact spectral triples and we describe some properties. In particular we compute the spectral dimension. In Section [7,](#page-28-0) we investigate the links between the Connes spectral pseudo-distance and the Carnot-Caratheodory distance but also with the intrinsic pseudo-distance associated to some Dirichlet form. We prove an analogue of formula [\(1.6\)](#page-2-0) for the Carnot-Caratheodory distance. Finally, we state in Section [8](#page-34-0) two natural conjectures on the functional calculus of subelliptic Laplacians and their associated Hodge-Dirac operators.

#### <span id="page-3-0"></span>**2 Preliminaries on operator theory**

**Minkowski's inequality** Suppose that  $(\Omega_1, \mu_1)$  and  $(\Omega_2, \mu_2)$  are two *σ*-finite measure spaces and consider a measurable function  $f: \Omega_1 \times \Omega_2 \to \mathbb{C}$ . We will use the following classical inequality [\[78,](#page-38-0) A.1 p. 271]

(2.1) \qquad \left[\int_{\Omega_2} \left| \int_{\Omega_1} f(x, y) \, \mathrm{d}\mu_1(x) \right|^p \mathrm{d}\mu_2(y) \right]^{\frac{1}{p}} \leqslant \int_{\Omega_1} \left( \int_{\Omega_2} |f(x, y)|^p \, \mathrm{d}\mu_2(y) \right)^{\frac{1}{p}} \mathrm{d}\mu_1(x).
$$

**Dunford-Pettis theorem** Let  $\Omega$  be a  $\sigma$ -finite measure space such that  $L^1(\Omega)$  is separable. A particular case of Dunford-Pettis theorem, e.g. [\[76,](#page-38-8) p. 528] [\[45,](#page-37-5) Section 3], says that if  $T: L^1(\Omega) \to L^{\infty}(\Omega)$  is a bounded operator then there exists a function  $K \in L^{\infty}(\Omega \times \Omega)$  such that for any  $f \in L^1(\Omega)$  we have  $(Tf)(x) = \int_{\Omega} K(x, y) f(y) dy$  for almost all  $x \in \Omega$ . Moreover, we have

(2.2) \t\t\t\t\t||T||_{L^1(\Omega) \to L^\infty(\Omega)} = ||K||_{L^\infty(\Omega \times \Omega)}.
$$

<span id="page-4-8"></span>Conversely, such a function *K* defines a bounded operator  $T: L^1(\Omega) \to L^{\infty}(\Omega)$ . We also have a similar result for a bounded operator  $T: L^2(\Omega) \to L^{\infty}(\Omega)$ . In this case, the equality [\(2.2\)](#page-3-2) is replaced by

||T||_{L^{2}(\Omega)\to L^{\infty}(\Omega)} = ||K||_{L^{\infty}(\Omega,L^{2}(\Omega))}.
$$

**Operator theory** Recall the characterization of the domain of the closure  $\overline{T}$  of a closable unbounded operator *T*: dom  $T \subset Y \to Z$  between Banach spaces *Y* and *Z*. We have

<span id="page-4-1"></span>(2.4)  $x \in \text{dom } \overline{T}$  iff there exists  $(x_n) \subset \text{dom } T$  such that  $x_n \to x$  and  $T(x_n) \to y$  for some *y*.

<span id="page-4-5"></span>The following is [\[83,](#page-39-2) Corollary 5.6 p. 144].

**Theorem 2.1** *Let T be a closed densely defined operator on a Hilbert space H. Then the operator*  $T^*T$  *on*  $(Ker T)^{\perp}$  *is unitarily equivalent to the operator*  $TT^*$  *on*  $(Ker T^*)^{\perp}$ *.* 

If *T* is densely defined, by [\[53,](#page-37-6) Problem 5.27 p. 168], we have

<span id="page-4-4"></span>(2.5) Ker *T* <sup>∗</sup> = (Ran *T* ) ⊥*.*

We will also use the following classical equalities [\[51,](#page-37-7) 2.8.45 p. 171]

$$
\operatorname{Ran} T^*T = \operatorname{Ran} T^* \quad \text{and} \quad \operatorname{Ker} T^*T = \operatorname{Ker} T.
$$

If *A* is sectorial operator on a *reflexive* Banach space *Y* , we have by [\[48,](#page-37-8) Proposition 2.1.1 (h)] a decomposition

$$
(2.7) \t\t Y = \text{Ker } A \oplus \overline{\text{Ran } A}.
$$

**Fractional powers** See [\[48\]](#page-37-8) and [\[56\]](#page-37-9) for more information on fractional powers. Let *A* be a sectorial operator on a Banach space *Y*. If *A* is densely defined and if  $\alpha$  is a complex number with  $0 < \text{Re } \alpha < n$ , where *n* is an integer, then the space dom  $A^n$  is a core of  $A^\alpha$  by [\[48,](#page-37-8) p. 62], i.e. dom  $A^n$  is dense in dom  $A^\alpha$  for the graph norm of  $A^\alpha$ , and we have

$$
A^{\alpha}(x) = \frac{\Gamma(n)}{\Gamma(\alpha)\Gamma(n-\alpha)} \int_0^{\infty} t^{\alpha-1} (A(t+A)^{-1})^n x \, dt, \quad x \in \text{dom } A^n.
$$

For any complex numbers  $\alpha, \beta$  with Re  $\alpha, \text{Re }\beta > 0$  we have  $A^{\alpha}A^{\beta} = A^{\alpha+\beta}$ . By [\[48,](#page-37-8) p. 62] and [\[48,](#page-37-8) Corollary 3.1.11], for any  $\alpha \in \mathbb{C}$  with  $\text{Re } \alpha > 0$  we have

$$
\operatorname{Ran} A^{\alpha} \subset \overline{\operatorname{Ran} A} \quad \text{and} \quad \operatorname{Ker} A^{\alpha} = \operatorname{Ker} A.
$$

If *A* is a sectorial operator on a Banach space *Y* and if Re  $\alpha > 0$ , then by [\[36,](#page-37-10) p. 137] the graph norms of the operators  $A^{\alpha}$  and  $(\mathrm{Id} + A)^{\alpha}$  are equivalent, i.e.

$$
||A^{\alpha}x||_Y + ||x||_Y \approx ||(\mathrm{Id} + A)^{\alpha}x||_Y, \quad x \in \mathrm{dom}\, A^{\alpha}.
$$

The proof uses [\[68,](#page-38-9) p. 28], the equality dom(Id + *A*)<sup> $\alpha$ </sup> = dom  $A^{\alpha}$  of [\[48,](#page-37-8) Proposition 3.1.9 p. 65] and the boundedness of the operator  $(\text{Id} + A)^{-\alpha}$ . See [\[56,](#page-37-9) Lemma 15.22 p. 294] and [\[48,](#page-37-8) Lemma 6.3.2 p. 148] for the particular case where *A* is injective.

<span id="page-5-5"></span>**Compactness of fractional powers** Let  $\Omega$  be a finite measure space. Consider a weak\* continuous semigroup  $(T_t)_{t\geq0}$  of selfadjoint positive unital contractions on  $L^{\infty}(\Omega)$  with weak<sup>\*</sup> (negative) generator  $A_{\infty}$ . A classical argument shows that each operator  $T_t$  is integral preserving. Such a semigroup induces a strongly continuous semigroup  $(T_{t,p})_{t\geqslant0}$  on  $L^p(\Omega)$  and its generator  $A_p$  is sectorial if  $1 < p < \infty$ .

There exists a weak\* continuous conditional expectation  $\mathbb{E}: L^{\infty}(\Omega) \to L^{\infty}(\Omega)$  on the fixed subalgebra  ${f \in L^{\infty}(\Omega) : T_t(f) = f \text{ for all } t \geq 0}$ . This subset is equal to Ker  $A_{\infty}$ . We sketch the argument. By [\[39,](#page-37-11) Proposition 3.1.4 p. 120], the induced semigroup  $(T_{t,1})_{t\geq0}$  on the space  $L^1(\Omega)$  is mean ergodic. In particular, we have a bounded projection  $Q: L^1(\Omega) \to L^1(\Omega)$  onto Ker  $A_1$  along Ran  $A_1$  which is clearly contractive, satisfying  $Q(1) = 1$ . By [\[1,](#page-35-7) Corollary 5.52] p. 222], *Q* is a conditional expectation. We conclude by duality that the suitable conditional expectation  $\mathbb E$  exists, see [\[37,](#page-37-12) Exercise 9 p. 159].

If  ${f \in L^{\infty}(\Omega) : T_t(f) = f \text{ for all } t \geq 0} = \mathbb{C}1$ , the condition expectation is given by  $\mathbb{E}(f) = (\int_{\Omega} f) 1$ . We use the notation  $L_0^p(\Omega)$  for the subspace Ker $\mathbb{E}_p$  of  $L^p(\Omega)$ . It is the space of functions with mean 0. We have  $L_0^p(\Omega) = \overline{\text{Ran }A_p}$ . Finally, for  $1 \leqslant p \leqslant q \leqslant \infty$ , consider the property

(2.11) 
$$
||T_t||_{L_0^p(\Omega) \to L_0^q(\Omega)} \lesssim \frac{1}{t^{\frac{n}{2}(\frac{1}{p} - \frac{1}{q})}}, \quad 0 < t \leq 1,
$$

which is a *local* version of the property  $[50, (R_n^{pq})]$  p. 619]

<span id="page-5-4"></span>
$$
||T_t||_{\mathrm{L}_0^p(\Omega)\to \mathrm{L}_0^q(\Omega)}\lesssim \frac{1}{t^{\frac{n}{2}(\frac{1}{p}-\frac{1}{q})}},\quad t>0.
$$

By an interpolation argument similar to the one of [\[50,](#page-37-4) Lemma 1.1.2], each of these properties holds for one pair  $1 \leqslant p < q \leqslant \infty$  if and only if it holds for all  $1 \leqslant p \leqslant q \leqslant \infty$ . See also [\[6,](#page-35-5) Section 7.3.2 p. 65] for a variant.

<span id="page-5-1"></span>Recall the following result  $[29,$  Theorem 9 (see also  $[52,$  Theorem 5.5) which allows to obtain compactness via complex interpolation.

**Theorem 2.2** *Suppose that*  $(X_0, X_1)$  *and*  $(Y_0, Y_1)$  *are Banach couples and that*  $X_0$  *is a* UMD*space. Let*  $T: X_0 + X_1 \rightarrow Y_0 + Y_1$  *such that its restriction*  $T_0: X_0 \rightarrow Y_0$  *is compact and such that*  $T_1: X_1 \to Y_1$  *is bounded. Then for any*  $0 < \theta < 1$  *the map*  $T: (X_0, X_1)_{\theta} \to (Y_0, Y_1)_{\theta}$  *is compact.*

The following is  $[50,$  Theorem 1.1.7. Note that the proof of this result uses  $[50,$  Lemma 1.1.6] whose proof unfortunately seems false in light of the classical problem [\[52,](#page-37-13) Problem 5.4]. However, [\[50,](#page-37-4) Lemma 1.1.6] can be replaced by Theorem [2.2.](#page-5-1)

<span id="page-5-3"></span>**Proposition 2.3** *Let*  $\Omega$  *be a finite measure space. Let*  $(T_t)_{t\geq0}$  *be a weak\* continuous semigroup of selfadjoint positive contractions on*  $L^{\infty}(\Omega)$  *with*  $\{x \in L^{\infty}(\Omega) : T_t(x) = x \text{ for all } t \geq 0\} = \mathbb{C}1$ *satisfying*  $||T_t||_{L_0^1(\Omega) \to L^\infty(\Omega)} \lesssim \frac{1}{t^{\frac{n}{2}}}$  $\frac{1}{t^{\frac{n}{2}}}$  for some *n* and such that  $A^{-1}$  is compact on  $L_0^2(\Omega)$ . Then for  $all \ 1 \leqslant p < q \leqslant \infty$  such that  $\frac{2 \text{Re } z}{n} > \frac{1}{p} - \frac{1}{q}$  the operator  $A^{-z} \colon L_0^p(\Omega) \to L_0^q(\Omega)$  is compact.

### <span id="page-5-0"></span>**3 Background and preliminaries results on Lie groups**

**Convolution** If *G* is a unimodular locally compact group equipped with a Haar measure  $\mu$ <sup>*G*</sup>. recall that the convolution product of two functions *f* and *g* is given, when it exists, by

$$
(f * g)(s) \stackrel{\text{def}}{=} \int_G f(r)g(r^{-1}s) d\mu_G(r) = \int_G f(sr^{-1})g(r) d\mu_G(r).
$$

<span id="page-6-5"></span>**Carnot-Carathéodory distances on connected Lie groups** Let *G* be a connected Lie group with neutral element *e*. We consider a finite sequence  $X \stackrel{\text{def}}{=} (X_1, \ldots, X_m)$  of left invariant vector fields which generate the Lie algebra  $\mathfrak g$  of the group  $\tilde G$  such that the vectors  $X_1(e), \ldots, X_m(e)$  are linearly independent. We say that it is a family of left-invariant Hörmander vector fields.

Let  $\gamma: [c, d] \to G$  be an absolutely continuous path such that  $\dot{\gamma}(t)$  belongs to the subspace  $\text{span}\{X_1|_{\gamma(t)},\ldots,X_m|_{\gamma(t)}\}\$  for almost all  $t\in[c,d]$ . If  $\dot{\gamma}(t)=\sum_{k=1}^m\dot{\gamma}_k(t)X_k|_{\gamma(t)}$  for almost all  $t \in [c, d]$ , where  $\dot{\gamma}_k(t) \in \mathbb{R}$  and where each  $\dot{\gamma}_k$  is measurable, we can define the *p*-length of  $\gamma$  by

<span id="page-6-4"></span>(3.2) 
$$
\ell_p(\gamma) \stackrel{\text{def}}{=} \int_c^d \left(\sum_{k=1}^m |\dot{\gamma}_k(t)|^p\right)^{\frac{1}{p}} dt
$$

which belongs to  $[0, \infty]$ . For any  $s, s' \in G$  there exists such a path  $\gamma : [0, 1] \to G$  with finite length with  $\gamma(0) = s$  and  $\gamma(1) = s'$ . If  $s, s' \in G$  and  $1 < p < \infty$  then we define the real number dist $_{\text{CC}}^{p}(s, s')$  between *s* and *s'* to be the infimum of the length of all such paths with  $\gamma(0) = s$ and  $\gamma(1) = s'$ :

<span id="page-6-2"></span>(3.3) 
$$
\text{dist}_{\text{CC}}^p(s, s') \stackrel{\text{def}}{=} \inf_{\gamma(0) = s, \gamma(1) = s'} \ell_p(\gamma).
$$

See  $[84, p. 39]$  and  $[33, p. 22]$  if  $p = 2$ . In this case, we recover the Carnot-Carathéodory distance dist<sub>CC</sub> $(s, s')$ . We refer also to [\[67\]](#page-38-10).

If  $f: G \to \mathbb{C}$  is a smooth function and if  $\gamma: [0, 1] \to G$  is an absolutely continuous path with tangents in the subspace spanned by  $X_1, \ldots, X_m$  then by [\[38,](#page-37-14) p. 64] we have

(3.4) 
$$
\frac{d}{dt} f(\gamma(t)) = \sum_{k=1}^{m} \dot{\gamma}_k(t) (X_k f)(\gamma(t)) \text{ a.e. } t \in [0, 1]
$$

i.e.

<span id="page-6-0"></span>
$$
\frac{\mathrm{d}}{\mathrm{d}t}f(\gamma(t)) = \langle \dot{\gamma}(t), (Xf)(\gamma(t)) \rangle \quad \text{a.e. } t \in [0, 1].
$$

We will need the following elementary inequality. In the following statement, each dom  $X_{k,p}$ is the domain of  $X_k$  on  $L^p(G)$ , i.e.  $X_{k,p}$ : dom  $X_{k,p} \subset L^p(G) \to L^p(G)$ . Recall that connected Lie groups are  $\sigma$ -finite under Haar measure. Let  $\lambda: G \to B(L^p(G)), s \mapsto (f \mapsto f(s^{-1} \cdot))$  be the left regular representation of *G*.

<span id="page-6-3"></span>The following result is a variant of [\[84,](#page-39-3) Lemma VIII.1.1 p. 106].

**Lemma 3.1** *Suppose*  $1 < p < \infty$  *and*  $\frac{1}{p} + \frac{1}{p^*} = 1$ *. Then for any*  $s \in G$  *and any*  $f$  *belonging to* dom  $X_{1,p} \cap \cdots \cap \text{dom } X_{m,p}$ *, we have* 

(3.5) 
$$
\| (\mathrm{Id} - \lambda_s) f \|_{\mathrm{L}^p(G)} \leqslant \mathrm{dist}_{\mathrm{CC}}^{p^*}(s, e) \bigg( \sum_{k=1}^m \| X_{k,p} f \|_{\mathrm{L}^p(G)}^p \bigg)^{\frac{1}{p}}.
$$

*Proof* : Let  $f \in C_c^{\infty}(G)$ . Let  $s \in G$  and let  $\gamma: [0,1] \mapsto G$  be an absolutely continuous path from *e* to  $s^{-1}$ . For any  $s' \in G$ , we have

$$
((\mathrm{Id} - \lambda_s)f)(s') = f(s') - (\lambda_s f)(s') = f(s') - f(s^{-1}s')
$$
  
= 
$$
-\int_0^1 \frac{d}{dt} f(\gamma(t)s') dt \stackrel{(3.4)}{=} -\int_0^1 \sum_{k=1}^m \dot{\gamma}_k(t) (X_k f)(\gamma(t)s') dt.
$$

<span id="page-7-4"></span>Consequently, using Hölder's inequality, we obtain

<span id="page-7-0"></span>(3.6) 
$$
\left| ((\mathrm{Id}-\lambda_s)f)(s') \right| \leqslant \int_0^1 \left( \sum_{k=1}^m \dot{\gamma}_k(t)^p \right)^{\frac{1}{p}} \left( \sum_{k=1}^m \left[ (X_k f)(\gamma(t) s') \right]^{p^*} \right)^{\frac{1}{p^*}} \mathrm{d}t.
$$

Using Minkowski's inequality [\(2.1\)](#page-3-3) and left invariance in the last equality, we deduce that

$$
\begin{split}\n\|(\mathrm{Id}-\lambda_{s})f\|_{p^{*}} &= \left[\int_{G} \left|\left((\mathrm{Id}-\lambda_{s})f\right)(s')\right|^{p^{*}} \mathrm{d}\mu_{G}(s')\right]^{\frac{1}{p^{*}}} \\
&\leqslant \left[\int_{G} \left(\int_{0}^{1} \left(\sum_{k=1}^{m} \dot{\gamma}_{k}(t)^{p}\right)^{\frac{1}{p}} \left(\sum_{k=1}^{m} \left[\left(X_{k}f\right)(\gamma(t)s')\right]^{p^{*}}\right)^{\frac{1}{p^{*}}} \mathrm{d}t\right)^{p^{*}} \mathrm{d}\mu_{G}(s')\right]^{\frac{1}{p^{*}}} \\
&\leqslant \int_{0}^{1} \left[\int_{G} \left(\sum_{k=1}^{m} \dot{\gamma}_{k}(t)^{p}\right)^{\frac{p^{*}}{p}} \left(\sum_{k=1}^{m} \left[\left(X_{k}f\right)(\gamma(t)s')\right]^{p^{*}}\right) \mathrm{d}\mu_{G}(s')\right]^{\frac{1}{p^{*}}} \mathrm{d}t \\
&= \int_{0}^{1} \left(\sum_{k=1}^{m} \dot{\gamma}_{k}(t)^{p}\right)^{\frac{1}{p}} \left[\sum_{k=1}^{m} \int_{G} \left[\left(X_{k}f\right)(\gamma(t)s')\right]^{p^{*}} \mathrm{d}\mu_{G}(s')\right]^{\frac{1}{p^{*}}} \mathrm{d}t \\
&= \int_{0}^{1} \left(\sum_{k=1}^{m} \dot{\gamma}_{k}(t)^{p}\right)^{\frac{1}{p^{*}}} \left[\sum_{k=1}^{m} \|X_{k}f\|_{\mathrm{L}^{p^{*}}(G)}^{p^{*}}\right]^{\frac{1}{p^{*}}} \mathrm{d}t.\n\end{split}
$$

Hence by taking the infimum over all possible paths, and observing that  $dist_{CC}^{p^*}(e, s^{-1})$ dist $p^*_{\text{CC}}(s, e)$  we obtain [\(3.5\)](#page-6-1) with [\(3.3\)](#page-6-2). We conclude by using an approximation argument as in the proof of the next Proposition [3.4](#page-8-1) for a general *f*.

**Growth of volume and dimensions** Let *G* be a connected Lie group equipped with a family  $X \stackrel{\text{def}}{=} (X_1, \ldots, X_m)$  of left-invariant Hörmander vector fields and a left Haar measure  $\mu_G$ . For any  $r > 0$  and any  $x \in G$ , we denote by  $B(x,r)$  the open ball with respect to the Carnot-Carathéodory metric centered at *x* and of radius *r*, and by  $V(r) \stackrel{\text{def}}{=} \mu_G(B(x,r))$  the Haar measure of any ball of radius *r*. It is well-known, e.g. [\[84,](#page-39-3) p. 124] that there exist  $d \in \mathbb{N}^*$ ,  $c, C > 0$  such that

(3.7) 
$$
cr^d \leqslant V(r) \leqslant Cr^d, \quad r \in ]0,1[.
$$

The integer *d* is called the local dimension of (*G, X*).

When  $r \geq 1$ , only two situations may occur, independently of the choice of X (see e.g. [\[33,](#page-36-15) p. 26]): either *G* has polynomial volume growth, which means that there exist  $D \in \mathbb{N}$  and  $c'$ ,  $C' > 0$  such that

$$
(3.8) \t\t c'r^D \leqslant V(r) \leqslant C'r^D, \quad r \geqslant 1
$$

or *G* has exponential volume growth, which means that there exist  $c_1, C_1, c_2, C_2 > 0$  such that

<span id="page-7-2"></span><span id="page-7-1"></span>
$$
c_1 e^{c_2 r} \leqslant V(r) \leqslant C_1 e^{C_2 r}, \quad r \geqslant 1.
$$

When *G* has polynomial volume growth, the integer *D* in [\(3.8\)](#page-7-1) is called the dimension at infinity of *G*. Note that, contrary to *d*, it only depends on *G* and not on *X*, see [\[84,](#page-39-3) Chapter 4].

<span id="page-7-3"></span>By [\[33,](#page-36-15) II.4.5 p. 26] or [\[76,](#page-38-8) p. 381], each connected Lie group of polynomial growth is unimodular. By  $[76, pp. 256-257]$  and  $[33, p. 26]$ , a connected compact Lie group has polynomial volume growth with  $D = 0$ . Recall finally that connected nilpotent Lie groups have polynomial volume growth by [\[33,](#page-36-15) p. 28].

<span id="page-8-3"></span>**Example 3.2** The local dimension of the abelian compact Lie group  $\mathbb{T}^n$  is *n* by [\[76,](#page-38-8) p. 274] and its dimension at infinity is of 0 since  $\mathbb{T}^n$  is compact.

**Example 3.3** The local dimension and the dimension at infinity of a stratified Lie group are equal by  $[33, \text{II}.4.15]$ . The three-dimensional Heisenberg group  $\mathbb{H}_3$  (equipped with its canonical stratification) is a stratified group and its dimensions are equal to 4 by [\[33,](#page-36-15) Example II.4.16].

Let *G* be a unimodular connected Lie group endowed with a family  $(X_1, \ldots, X_m)$  of leftinvariant Hörmander vector fields and let  $\mu$ <sup>*G*</sup> be a Haar measure. We consider the subelliptic Laplacian  $\Delta$  on *G* defined by

<span id="page-8-0"></span>
$$
\Delta \stackrel{\text{def}}{=} -\sum_{k=1}^{m} X_k^2.
$$

For  $1 \leqslant p < \infty$ , let  $\Delta_p$ : dom  $\Delta_p \subset L^p(G) \to L^p(G)$  be the smallest closed extension of the closable unbounded operator  $\Delta |C^{\infty}_{c}(G)|$  to  $L^p(G)$ . Note that the domain dom  $\Delta_p^{\frac{\alpha}{2}}$  is closed under the adjoint operation  $f \mapsto f$ .

We denote by  $(T_t)_{t\geq0}$  the associated weak\* continuous semigroup of selfadjoint unital (i.e.  $T_t(1) = 1$ ) positive contractive operators on L∞(*G*), see [\[84,](#page-39-3) pp. 20-21], [\[33,](#page-36-15) p. 21] and [\[76,](#page-38-8) p. 301]. By [\[76,](#page-38-8) Proposition 4.13 p. 323] and [\[33,](#page-36-15) Proposition 11.3.1 p. 20], for any *t >* 0, the operator  $T_t: L^p(G) \to L^p(G)$  is a convolution operator by a positive function  $K_t$  of  $L^1(G)$ .

Suppose  $1 < p < \infty$  and that the Lie group G has polynomial volume growth. By [\[3,](#page-35-8) Theorem 2] and [\[25,](#page-36-1) p. 339], for any  $f \in C_c^{\infty}(G)$  we have

*.*

<span id="page-8-2"></span>(3.10) 
$$
\left\|\Delta_p^{\frac{1}{2}}(f)\right\|_{\mathcal{L}^p(G)} \approx_p \sum_{k=1}^m \left\|X_k(f)\right\|_{\mathcal{L}^p(G)}
$$

Since dom  $\Delta_p$  is a core of  $\Delta_p^{\frac{1}{2}}$ , a classical argument [\[68,](#page-38-9) p. 29] reveals that the subspace  $C_c^{\infty}(G)$ is a core of the operator  $\Delta_p^{\frac{1}{2}}$ .

The following observation is a natural complement of the equivalences [\(3.10\)](#page-8-2). Since it is always written in the literature without proof, we give an argument. Note that the subspace dom  $X_{1,p} \cap \cdots \cap$  dom  $X_{m,p}$  is considered in the paper [\[9,](#page-36-16) p. 194] and in the book [\[33,](#page-36-15) p. 15] and respectively denoted by  $W'_{1,2}(G)$  and  $L'_{2,1}(G)$ .

<span id="page-8-1"></span>**Proposition 3.4** *Let G be a unimodular connected Lie group with polynomial volume growth.*  $Suppose 1 \leq p \leq \infty$ . We have  $dom \Delta_p^{\frac{1}{2}} = dom X_{1,p} \cap \cdots \cap dom X_{m,p}$ . Moreover, for any  $f \in \text{dom } \Delta_p^{\frac{1}{2}}, \text{ we have } (3.10).$  $f \in \text{dom } \Delta_p^{\frac{1}{2}}, \text{ we have } (3.10).$  $f \in \text{dom } \Delta_p^{\frac{1}{2}}, \text{ we have } (3.10).$ 

*Proof* : Let  $f \in \text{dom } \Delta_p^{\frac{1}{2}}$ . The subspace  $C_c^{\infty}(G)$  is dense in dom  $\Delta_p^{\frac{1}{2}}$  equipped with the graph norm. Hence we can find a sequence  $(f_n)$  of  $C_c^{\infty}(G)$  such that  $f_n \to f$  and  $\Delta_p^{\frac{1}{2}}(f_n) \to \Delta_p^{\frac{1}{2}}(f)$ in  $L^p(G)$ . For any integers *n*, *l* and any  $1 \leq k \leq m$ , we obtain

$$
||f_n - f_l||_{\mathcal{L}^p(G)} + ||X_k(f_n) - X_k(f_l)||_{\mathcal{L}^p(G)}
$$
  
\n
$$
\lesssim_p ||f_n - f_l||_{\mathcal{L}^p(G)} + ||\Delta_p^{\frac{1}{2}}(f_n) - \Delta_p^{\frac{1}{2}}(f_l)||_{\mathcal{L}^p(G)}
$$

which shows that  $(f_n)$  is a Cauchy sequence in dom  $X_{k,p}$ . By the closedness of  $X_{k,p}$  we infer that this sequence converges to some  $g \in \text{dom } X_{k,p}$  equipped with the graph norm. Since dom  $X_{k,p}$ 

<span id="page-9-3"></span>equipped with the graph norm is continuously embedded into  $L^p(G)$ , we have  $f_n \to g$  in  $L^p(G)$ , and therefore  $f = g$  since  $f_n \to f$ . It follows that  $f \in \text{dom } X_{k,p}$ . This proves the inclusion dom  $\Delta_p^{\frac{1}{2}} \subset \text{dom } X_{k,p}$ . Moreover, for any integer *n*, we have

$$
||X_{k}(f_{n})||_{\mathcal{L}^{p}(G)} \lesssim_{p}^{(3.10)} ||\Delta_{p}^{\frac{1}{2}}(f_{n})||_{\mathcal{L}^{p}(G)}.
$$

Since  $f_n \to f$  in dom  $X_{k,p}$  and in dom  $\Delta_p^{\frac{1}{2}}$  both equipped with the graph norm, we conclude that 1

<span id="page-9-1"></span>
$$
\left\|X_k(f)\right\|_{\mathrm{L}^p(G)} \lesssim_p \left\|\Delta_p^{\frac{1}{2}}(f)\right\|_{\mathrm{L}^p(G)}.
$$

П

The proof of the reverse inclusion and estimate are similar.

Suppose  $1 \leqslant p < \infty$  and  $\alpha > 0$ . When  $f \in \text{dom } \Delta_p^{\frac{\alpha}{2}}$ , we let

(3.11) 
$$
||f||_{\dot{L}^p_{\alpha}(G)} \stackrel{\text{def}}{=} ||\Delta_p^{\frac{\alpha}{2}}(f)||_{L^p(G)}.
$$

It is related to Sobolev towers, see [\[40,](#page-37-15) Section II.5] and [\[56,](#page-37-9) Section 15.E]. Note that  $\|\cdot\|_{\dot{\mathcal{L}}^p_\alpha(G)}$ is a seminorm on the subspace  $\dot{L}^p_\alpha(G)$  of  $L^p(G)$  (and even a norm if *G* is not compact). In this paper, we have no intention to define and to use a Banach space  $\dot{L}^p_\alpha(G)$ .

Assume that the unimodular connected Lie group *G* has *polynomial volume growth*. For any  $\alpha \in [0,1]$  and any  $p \in ]1, +\infty[$ , by [\[25,](#page-36-1) Theorem 3] the space  $\mathcal{L}^p_\alpha(G) \cap \mathcal{L}^\infty(G)$  is an algebra under pointwise product. In [\[25,](#page-36-1) pp. 289-290], the authors give a simple proof of the case  $\alpha = 1$ . More precisely for all  $f, g \in L^p_\alpha(G) \cap L^\infty(G)$  we have  $fg \in L^p_\alpha(G) \cap L^\infty(G)$  and [\(1.5\)](#page-1-2). If *G* is in addition nilpotent, the conclusion holds for all  $\alpha \geq 0$ . See also [\[46,](#page-37-3) Theorem 1.4] for the particular case  $G = \mathbb{R}^n$  with some generalizations.

<span id="page-9-0"></span>In the following statement, the seminorm  $\lVert \cdot \rVert_{\mathrm{L}^{p}_{\alpha}(G)}$  is defined on

(3.12) 
$$
\text{dom }\|\cdot\|_{\dot{L}^p_\alpha(G)} \stackrel{\text{def}}{=} C_0(G) \cap \text{dom }\Delta_p^{\frac{\alpha}{2}}
$$

where  $C_0(G)$  is the Banach space of complex-valued continuous functions on G that vanish at infinity. Recall that  $C_0(G)$  is equipped with the restriction of the norm  $\lVert \cdot \rVert_{L^{\infty}(G)}$ . If the group *G* is compact, we have of course the equality  $C_0(G) = C(G)$  where  $C(G)$  is the Banach space of complex-valued continuous functions on *G*.

<span id="page-9-2"></span>**Lemma 3.5** *Let G be a connected unimodular Lie group. Suppose*  $1 < p < \infty$  *and*  $\alpha > 0$ *.* 

- *1. The*  $\mathbb{C}\text{-subspace}$  dom  $\lVert \cdot \rVert_{\dot{L}^p_\alpha(G)}$  is dense in the Banach space  $C_0(G)$ *.*
- 2. The subspace  $\text{dom}\left\|\cdot\right\|_{\mathbb{L}^p_\alpha(G)}$  is closed under the adjoint operation  $f \mapsto f$ .
- *3. If G is compact, we have*

(3.13) 
$$
\left\{ f \in \text{dom } || \cdot ||_{\dot{L}^p_\alpha(G)} : || f ||_{\dot{L}^p_\alpha(G)} = 0 \right\} = \mathbb{C} 1_{C(G)}.
$$

*If G has polynomial volume growth and is non-compact, we have*

(3.14) 
$$
\left\{ f \in \text{dom } \| \cdot \|_{\dot{L}^p_\alpha(G)} : \| f \|_{\dot{L}^p_\alpha(G)} = 0 \right\} = \{0\}.
$$

4. If *G* is compact, the seminorm  $\lVert \cdot \rVert_{\dot{L}^p_\alpha(G)}$  is lower semicontinuous.

<span id="page-10-1"></span>*Proof* : 1. Recall that the space dom  $\Delta_p^n$  is a core of the operator  $\Delta_p^{\frac{\alpha}{2}}$  if  $\frac{\alpha}{2} < n$ . Consequently the domain dom  $\lVert \cdot \rVert_{\dot{L}^p_\alpha(G)}$  $\sum_{n=0}^{(3.12)}$  $\sum_{n=0}^{(3.12)}$  $\sum_{n=0}^{(3.12)}$  C<sub>0</sub>(*G*) ∩ dom  $\Delta_p^{\frac{\alpha}{2}}$  contains the subspace C<sub>c</sub><sup>∞</sup>(*G*) of C<sub>0</sub>(*G*). Note that this subspace is dense in  $C_0(G)$  by regularization by [\[63,](#page-38-11) Theorem 2.11]. We infer that the  $\mathbb{C}$ -subspace dom  $\lVert \cdot \rVert_{\mathrm{L}^p_\alpha(G)}$  is dense in the Banach space  $\mathrm{C}_0(G)$ .

2. Note that the space  $C_0(G)$  is obviously closed under the adjoint operation  $f \mapsto \overline{f}$ . We will show that dom  $\lVert \cdot \rVert_{\dot{L}^p_\alpha(G)}$  is equally closed under the same operation.

Let  $f \in \text{dom } \Delta_p^{\frac{\alpha}{2}}$ . We know that the subspace dom  $\Delta_p^n$  is core of  $\Delta_p^{\frac{\alpha}{2}}$ . Hence there exists a sequence  $(f_j)$  of dom  $\Delta_p^n$  such that  $f_j \to f$  and  $\Delta_p^{\frac{\alpha}{2}}(f_j) \to \Delta_p^{\frac{\alpha}{2}}(f)$ . We have  $\overline{f_j} \to \overline{f}$  and  $\Delta_p^{\frac{\alpha}{2}}(\overline{f_j}) = \overline{\Delta_p^{\frac{\alpha}{2}}(f_j)} \rightarrow \overline{\Delta_p^{\frac{\alpha}{2}}(f)}$  where the equality can be seen with [\(2.8\)](#page-4-0). By [\(2.4\)](#page-4-1), we conclude that  $\overline{f} \in \text{dom } \Delta_p^{\frac{\alpha}{2}}$  and that  $\Delta_p^{\frac{\alpha}{2}}(\overline{f}) = \overline{\Delta_p^{\frac{\alpha}{2}}(f)}$ . We conclude that dom  $\|\cdot\|_{L^p_\alpha(G)}$  is closed under the adjoint operation  $f \mapsto \overline{f}$ .

3. We have  $\Delta_p(1) \stackrel{(3.9)}{=} -\sum_{k=1}^m X_k^2(1) = 0$  $\Delta_p(1) \stackrel{(3.9)}{=} -\sum_{k=1}^m X_k^2(1) = 0$  $\Delta_p(1) \stackrel{(3.9)}{=} -\sum_{k=1}^m X_k^2(1) = 0$ . Hence the constant function 1 belongs to Ker  $\Delta_p \stackrel{(2.9)}{=} \text{Ker } \Delta_p^{\frac{\alpha}{2}}$  $\Delta_p \stackrel{(2.9)}{=} \text{Ker } \Delta_p^{\frac{\alpha}{2}}$  $\Delta_p \stackrel{(2.9)}{=} \text{Ker } \Delta_p^{\frac{\alpha}{2}}$ . We conclude that  $||1||_{\dot{L}^p_{\alpha}(G)} = ||\Delta_p^{\frac{\alpha}{2}}(1)||_p = 0$ .

In the other direction, if  $||f||_{\mathring{L}^p_\alpha(G)} = 0$ , we have  $||\Delta_p^{\frac{\alpha}{2}}(f)||_p = 0$ . Hence *f* belongs to Ker  $\Delta_p^{\frac{\alpha}{2}}$ . By [\(2.9\)](#page-4-2), we deduce that  $\left\|\Delta_p^{\frac{1}{2}}(f)\right\|_p = 0$ . Then according to Proposition [3.4](#page-8-1) and [\(3.10\)](#page-8-2), we have  $||X_k(f)||_p = 0$  for any *k*. By Lemma [3.1,](#page-6-3) we infer that  $\lambda_s(f) = f$  for any  $s \in G$ . If *G* is compact, we conclude that the function *f* is constant, that is  $f \in \mathbb{C}1$  and that  $f = 0$  if *G* is not compact.

4. Let  $f \in C(G)$  and  $(f_n)$  be a sequence of elements of  $C(G) \cap \text{dom } \Delta_p^{\frac{\alpha}{2}}$  such that  $(f_n)$  converges to *f* for the norm topology of C(*G*) and  $||f_n||_{\dot{L}^p_\alpha(G)} \leq 1$  for any *n*, that is  $\left\|\Delta_p^{\frac{\alpha}{2}}(f_n)\right\|_{\mathbb{L}^p(G)} \leq 1$  by [\(3.11\)](#page-9-1). We have to prove that *f* belongs to dom  $\Delta_p^{\frac{\alpha}{2}}$  and that  $||f||_{\dot{L}^p_\alpha(G)} \leq 1.$ 

Since  $\|\cdot\|_{\mathcal{L}^p(G)} \leq \|\cdot\|_{\mathcal{C}(G)}$ , the sequence  $(f_n)$  converges to  $f$  for the norm topology of  $\mathcal{L}^p(G)$ , hence for the weak topology of  $L^p(G)$ . Note that the sequence  $\Delta_p^{\frac{\alpha}{2}}(f_n)$  is bounded in the Banach space  $L^p(G)$ . Since bounded sets are weakly relatively compact by [\[65,](#page-38-12) Theorem 2.8.2], there exists a weakly convergent subnet  $(\Delta_p^{\frac{\alpha}{2}} f_{n_j})$ . Then  $(f_{n_j}, \Delta_p^{\frac{\alpha}{2}} f_{n_j})$  is a weakly convergent net in the graph of the closed operator  $\Delta_p^{\frac{\alpha}{2}}$ . Note that this graph is closed and convex, hence weakly closed by [\[65,](#page-38-12) Theorem 2.5.16]. Thus the limit of  $(f_{n_j}, \Delta_p^{\frac{\alpha}{2}} f_{n_j})$  belongs again to the graph and is of the form  $(g, \Delta_p^{\frac{\alpha}{2}}g)$  for some  $g \in \text{dom }\Delta_p^{\frac{\alpha}{2}}$ . In particular,  $(f_{n_j})$  converges weakly to *g* and  $\Delta_p^{\frac{\alpha}{2}}(f_{n_j})$  converges weakly to  $\Delta_p^{\frac{\alpha}{2}}(g)$ . We infer that  $f = g$ . We conclude that *f* belongs to  $\Delta_p^{\frac{\alpha}{2}}$ . Moreover, using the weakly lower semicontinuity of the norm [\[65,](#page-38-12) Theorem 2.5.21], we obtain

$$
||f||_{\dot{L}^p_{\alpha}(G)} \stackrel{(3.11)}{=} ||\Delta_p^{\frac{\alpha}{2}}(f)||_{L^p(G)} \leqslant \liminf_j ||\Delta_p^{\frac{\alpha}{2}}(f_{n_j})||_{L^p(G)} \leqslant 1.
$$

<span id="page-10-0"></span>**4 Quantum compact metric spaces**

**Lipschitz pairs and quantum compact metric spaces** Following [\[58,](#page-38-13) Definition 2.3], a Lipschitz pair  $(A, \|\cdot\|)$  is a C<sup>∗</sup>-algebra *A* equipped with a seminorm  $\|\cdot\|$  defined on a dense <span id="page-11-4"></span>subspace dom  $\lVert \cdot \rVert$  of the selfadjoint part  $(u)$ <sub>sa</sub> such that

<span id="page-11-1"></span>(4.1) 
$$
\{a \in \text{dom} \, ||\cdot|| : ||a|| = 0\} = \mathbb{R}1_{uA}
$$

where *uA* is the unitization of the algebra *A*. If *A* is in addition unital, we say that  $(A, \|\cdot\|)$  is a unital Lipschitz pair.

Recall that a state of a C<sup>\*</sup>-algebra *A* is a positive linear form  $\varphi$  on *A* with  $\|\varphi\| = 1$ . If *X* is a compact topological space and if  $A = C(X)$ , a state is the integral associated to a regular Borel measure of probability on *X*.

A pair  $(A, \|\cdot\|)$  is a quantum compact metric space when:

def

- 1.  $(A, \|\cdot\|)$  is a unital Lipschitz pair.
- 2. The Monge-Kantorovich metric on the set S(*A*) of the states of *A*, defined for any two states  $\varphi, \psi \in S(A)$  by:

<span id="page-11-0"></span>(4.2) 
$$
\text{dist}_{\text{MK}}(\varphi, \psi) \stackrel{\text{def}}{=} \sup \left\{ |\varphi(a) - \psi(a)| : a \in \text{dom} \, || \cdot || \text{ and } ||a|| \leq 1 \right\},
$$

induces the weak<sup>\*</sup> topology on  $S(A)$ .

<span id="page-11-3"></span>In this case, we say that  $\|\cdot\|$  is a Lip-norm. We refer to the nice surveys [\[58\]](#page-38-13) and [\[75\]](#page-38-6) and references therein for more information.

**Example 4.1** If  $(X, \text{dist})$  is a compact metric space, a fundamental example  $[58, \text{Example 4.1}]$ 2.6], [\[59,](#page-38-14) Example 2.9] is given by  $(C(X), Lip)$  where  $C(X)$  is the commutative C<sup>\*</sup>-algebra of continuous functions on *X* and where Lip is the Lipschitz seminorm, defined for any Lipschitz function  $f: X \to \mathbb{C}$  by

(4.3) 
$$
\text{Lip}(f) \stackrel{\text{def}}{=} \sup \left\{ \frac{|f(x) - f(y)|}{\text{dist}(x, y)} : x, y \in X, x \neq y \right\}.
$$

The set of real Lipschitz functions is norm-dense in  $C(X)_{sa}$  by the Stone-Weierstrass theorem. Indeed,  $\text{Lip}(X)$  contains the constant functions. Moreover,  $\text{Lip}(X)$  separates points in *X*. If  $x_0, y_0 \in X$  with  $x_0 \neq y_0$ , we can use the lipschitz function  $f: X \to \mathbb{R}, x \mapsto \text{dist}(x, y_0)$  since we have  $f(x_0) > 0 = f(y_0)$ . Moreover, it is immediate that a function f has zero Lipschitz constant if and only if it is constant on *X*, i.e. [\(4.1\)](#page-11-1) is satisfied.

In the case of  $(C(X), Lip)$ , the equality  $(4.2)$  gives the dual formulation of the classical Kantorovich-Rubinstein metric [\[86,](#page-39-4) Remark 6.5] for Borel probability measures  $\mu$  and  $\nu$  on X

<span id="page-11-2"></span>(4.4) 
$$
\operatorname{dist}(\mu, \nu) \stackrel{\text{def}}{=} \sup \left\{ \left| \int_X f \, \mathrm{d}\mu - \int_X f \, \mathrm{d}\nu \right| : f \in \mathrm{C}(X)_{\mathrm{sa}}, \operatorname{Lip}(f) \leq 1 \right\}.
$$

which is a basic concept in optimal transport theory [\[86\]](#page-39-4). Considering the Dirac measures  $\delta_x$ and  $\delta_y$  at points  $x, y \in X$  instead of  $\mu$  and  $\nu$ , we recover the distance dist $(x, y)$  with the formula  $(4.4).$  $(4.4).$ 

**Characterizations of quantum compact metric spaces** The compatibility of Monge-Kantorovich metric with the weak\* topology is hard to check directly in general. Fortunately, there exists a condition which is more practical. This condition is inspired by the fact that Arzéla-Ascoli's theorem shows that for any  $x \in X$  the set

$$
\{f \in \mathcal{C}(X)_{\text{sa}} : \text{Lip}(f) \leqslant 1, f(x) = 0\}
$$

<span id="page-12-5"></span>is norm relatively compact and it is known that this property implies that  $(4.4)$  metrizes the weak\* topology on the space of Borel probability measures on *X*. Now, we give sufficient conditions in order to obtain quantum compact metric spaces,  $[58,$  Theorem 2.43]. See also  $[69,$ Proposition 1.3].

<span id="page-12-1"></span>**Proposition 4.2** *Let*  $(A, \|\cdot\|)$  *be a unital Lipschitz pair. The following assertions are equivalent:*

- *(a)*  $(A, \|\cdot\|)$  *is a quantum compact metric space,*
- *(b) there exists a state*  $\mu \in S(A)$  *such that the set*  $\{a \in A_{sa} : ||a|| \leq 1, \mu(a) = 0\}$  *is relatively compact in A for the topology of the norm of A,*
- *(c) for all states*  $\mu \in S(A)$ *, the set*  $\{a \in A_{sa} : ||a|| \leq 1, \mu(a) = 0\}$  *is relatively compact in A for the topology of the norm of A.*

**Quasi-Leibniz quantum compact metric space** The Lipschitz seminorm Lip of Example [4.1](#page-11-3) associated to a compact metric space (*X,* dist) enjoys a natural property with respect to the multiplication of functions in  $C(X)$ , called the Leibniz property for any Lipschitz functions  $f, g: X \to \mathbb{C}$ 

<span id="page-12-0"></span>(4.5) 
$$
\text{Lip}(fg) \leq \|f\|_{C(X)} \text{Lip}(g) + \text{Lip}(f) \|g\|_{C(X)}.
$$

Moreover, the Lipschitz seminorm is lower-semicontinuous with respect to the norm of the algebra  $C(X)$ , i.e. the uniform convergence norm on X.

We want to have these additional properties for a quantum compact metric space  $(A, \|\cdot\|)$ . Unfortunately, because of difficulties with Lipschitz seminorms, Latrémolière has not chosen a direct generalization of [\(4.5\)](#page-12-0) in this work on quantum compact metric spaces. He introduced the following definition by considering the Jordan-Lie-algebra of selfadjoint elements. We say that a quantum compact metric space  $(A, \|\cdot\|)$  is a  $(C, 0)$ -quasi-Leibniz quantum compact metric space if  $\|\cdot\|$  is Jordan-Lie subalgebra of *A* and if for any  $a, b \in \text{dom}\|\cdot\|$  we have

$$
||a \circ b|| \leq C[||a|| ||b||]_A + ||a||]_A ||b||
$$
 and  $||\{a, b\}|| \leq C[||a|| ||b||]_A + ||a||]_A ||b||$ 

for some constant  $C > 0$ , where we use the Jordan product  $a \circ b \stackrel{\text{def}}{=} \frac{1}{2}(ab + ba)$  and the Lie product  $\{a, b\} \stackrel{\text{def}}{=} \frac{1}{2i}(ab - ba)$  and if  $\|\cdot\|$  is lower semicontinuous, i.e.

<span id="page-12-4"></span>
$$
\{x \in \text{dom}\, \|\cdot\| : \|x\| \leq 1\}
$$

is closed for the topology of the norm of *A*.

<span id="page-12-2"></span>The following is essentially [\[59,](#page-38-14) Proposition 2.17] and Proposition [4.2.](#page-12-1) It is our main tool for checking the definition of quasi-Leibniz quantum compact metric spaces.

**Proposition 4.3** *Let A be a unital*  $C^*$ -algebra and  $\|\cdot\|$  *be a seminorm defined on a dense*  $C$  $-subspace$  dom  $\lVert \cdot \rVert$  *of A, such that* 

- *1.* dom  $\|\cdot\|$  *is closed under the adjoint operation,*
- *2.*  ${a \in \text{dom} ||\cdot|| : ||a|| = 0} = \mathbb{C}1_A$
- *3. there exists a constant*  $C > 0$  *such that for all*  $a, b \in \text{dom} \lVert \cdot \rVert$ *, we have*

(4.8) 
$$
\|ab\| \leqslant C \big[ \|a\|_A \|b\| + \|a\| \|b\|_A \big],
$$

<span id="page-13-5"></span>*4. there exists a state*  $\mu \in S(A)$  *such that the set*  $\{a \in \text{dom} \|\cdot\| : \|a\| \leq 1, \mu(a) = 0\}$  *is relatively compact in A for the topology of the norm of A.*

*5.*  $\|\cdot\|$  *is lower semicontinuous.* 

*If*  $\|\cdot\|$ <sub>sa</sub> *is the restriction of*  $\|\cdot\|$  *to*  $A_{sa} \cap \text{dom}\|\cdot\|$ *, then*  $(A_{sa}, \|\cdot\|_{sa})$  *is a*  $(C, 0)$ *-quasi-Leibniz quantum compact metric space.*

**New quantum compact metric spaces** Let *G* be a connected Lie group equipped with a family  $X = (X_1, \ldots, X_m)$  of left-invariant Hörmander vector fields and a left Haar measure  $\mu_G$ . In this section, we suppose that *G* is *compact*. For the introduction of new quantum compact metric spaces, we need some preliminary results related to some estimates of the heat kernel. For any  $s \in G$ , a particular case of [\[84,](#page-39-3) Theorem V.4.3] gives

<span id="page-13-0"></span>(4.9) 
$$
0 \leqslant K_t(s) \lesssim \frac{1}{t^{\frac{d}{2}}}, \quad 0 < t \leqslant 1
$$

where the local dimension *d* is defined in  $(3.7)$ .

<span id="page-13-2"></span>The following is essentially  $[76, pp. 339-341]$ . Since a point of  $[76, pp. 339-341]$  is misleading and since it is fundamental for us, we give an argument relying on the same nice ideas.

**Lemma 4.4** *The operator*  $\Delta_2$ :  $\text{dom}(\Delta_2) \subset L^2(G) \to L^2(G)$  *has compact resolvent and we have the estimate*

<span id="page-13-3"></span>(4.10) 
$$
||T_t||_{L^1(G) \to L^{\infty}(G)} \lesssim \frac{1}{t^{\frac{d}{2}}}, \quad 0 < t \leq 1.
$$

*Proof* : Note that for any  $0 < t \leq 1$ , we have

(4.11) 
$$
\|K_t\|_{\mathcal{L}^2(G)} \lesssim \|K_t\|_{\mathcal{L}^\infty(G)} \lesssim \frac{(4.9)}{\xi} \frac{1}{t^{\frac{d}{2}}}.
$$

By translation invariance of the normalized Haar measure of *G*, we deduce that (4.12)

$$
\int_{G \times G} |K_t(sr^{-1})|^2 \, ds \, dr = \int_G \left( \int_G |K_t(sr^{-1})|^2 \, ds \right) dr = \int_G \left( \int_G |K_t(s)|^2 \, ds \right) dr \stackrel{(4.11)}{\leq} \frac{1}{t^d}.
$$

For any  $t > 0$ , we deduce by [\[51,](#page-37-7) Exercise 2.8.38 p. 170] and [\(3.1\)](#page-5-2) that  $T_t: L^2(G) \to L^2(G)$  is a Hilbert-Schmidt operator. By [\[40,](#page-37-15) Theorem 4.29 p. 119], we conclude that the operator  $\Delta_2$ has compact resolvent. Finally, for any  $t > 0$ , we have

<span id="page-13-1"></span>
$$
||T_t||_{\mathcal{L}^1(G)\to\mathcal{L}^\infty(G)} \stackrel{(2.2)}{=} \mathop{\rm esssup}_{s,r\in G} |K_t(sr^{-1})| \stackrel{(4.9)}{\lesssim} \frac{1}{t^{\frac{d}{2}}}.
$$

П

<span id="page-13-4"></span>**Lemma 4.5** *The operator*  $\Delta_2^{-1}$ :  $L_0^2(G) \rightarrow L_0^2(G)$  *is compact.* 

*Proof* : By Lemma [4.4,](#page-13-2) the operator  $\Delta_2$ : dom  $\Delta_2 \subset L^2(G) \to L^2(G)$  has compact resolvent. Note that  $\text{Ker }\Delta_2$  is an eigenspace, hence a reducing subspace for the selfadjoint operator  $\Delta_2$ . So for any  $\lambda$  in the resolvent subset  $\rho(\Delta_2)$ , we have a well-defined operator  $(\lambda - \Delta_2)^{-1}$ : (Ker  $\Delta_2$ )<sup>⊥</sup> → (Ker  $\Delta_2$ )<sup>⊥</sup> which is compact by composition. By the resolvent iden-tity [\[48,](#page-37-8) p. 273], we deduce that  $\Delta_2^{-1}$ :  $(\text{Ker }\Delta_2)^{\perp} \to (\text{Ker }\Delta_2)^{\perp}$  is also compact by [\[35,](#page-37-16) p. 3]. Recall that  $(\text{Ker }\Delta_2)^\perp = L_0^2(G)$ . We conclude that  $\Delta_2^{-1}: L_0^2(G) \to L_0^2(G)$  is compact.

For the next statement, the domain of  $\lVert \cdot \rVert_{\dot{L}^p_\alpha(G)}$  is defined as in [\(3.12\)](#page-9-0).

<span id="page-14-2"></span>**Theorem 4.6** Let G be a compact connected Lie group equipped with a family  $(X_1, \ldots, X_m)$ *of left-invariant Hörmander vector fields. Suppose*  $0 < \alpha \leq 1$  *(or*  $0 < \alpha$  *if G is nilpotent) and*  $\frac{d}{d}$   $\lt p \lt \infty$  where *d* is the local dimension defined in [\(3.7\)](#page-7-2). Then  $(C(G), \lVert \cdot \rVert_{\dot{L}^p_\alpha(G)})$  defines a  $(C_{\alpha,p},0)$ -quasi-Leibniz quantum compact metric space for some constant  $C_{\alpha,p} > 0$ .

*Proof* : We will prove the assumptions of Proposition [4.3.](#page-12-2) The third point of Proposition [4.3](#page-12-2) is satisfied by  $(1.5)$  and the first two points by Lemma [3.5.](#page-9-2)

Since the normalized integral  $\int_G : C(G) \to \mathbb{C}$  is a state of the unital C<sup>\*</sup>-algebra C(*G*), it suffices to show that

(4.13) 
$$
\left\{ f \in \text{dom } || \cdot ||_{\dot{L}^p_\alpha(G)} : || f ||_{\dot{L}^p_\alpha(G)} \leq 1, \int_G f = 0 \right\}
$$

is relatively compact in  $C(G)$ .

<span id="page-14-0"></span>Note that [\[33,](#page-36-15) p. 38] contains a proof of the existence of  $\omega > 0$  such that

(4.14) 
$$
||T_t||_{L_0^1(G)\to L^\infty(G)} \lesssim e^{-\omega t} \quad t \ge 1.
$$

Combined with  $(4.10)$ , we deduce the estimate

<span id="page-14-1"></span>
$$
\|T_t\|_{\mathrm{L}_0^1(G)\to \mathrm{L}^\infty(G)}\lesssim \frac{1}{t^{\frac{d}{2}}}\quad t>0.
$$

With Lemma [4.5,](#page-13-4) we conclude that the assumptions of Proposition [2.3](#page-5-3) are satisfied. Using this result with  $z = \frac{\alpha}{2}$  and  $q = \infty$ , the operator  $\Delta^{-\frac{\alpha}{2}}: L^p_0(G) \to L^\infty_0(G)$  is compact if  $p > \frac{d}{\alpha}$ . So the image  $\mathcal{I}$  by  $\Delta^{-\frac{\alpha}{2}}$  of the closed unit ball  $\{g \in \overline{\text{Ran}\Delta_p} : \|g\|_{\text{L}^p(G)} \leq 1\}$  of  $\text{L}_0^p(G) = \overline{\text{Ran}\Delta_p}$ is relatively compact. Note that  $\text{Ran}\,\Delta_p^{\frac{\alpha}{2}} \subset \overline{\text{Ran}\,\Delta_p}$  by [\(2.9\)](#page-4-2). Hence the subset (write  $f =$  $\Delta^{-\frac{\alpha}{2}}\Delta_p^{\frac{\alpha}{2}}f$ 

$$
\left\{f \in \mathrm{C}(G)_0 \cap \mathrm{dom}\, \Delta_p^{\frac{\alpha}{2}} : \left\|\Delta_p^{\frac{\alpha}{2}}(f)\right\|_{\mathrm{L}^p(G)} \leqslant 1\right\}
$$

of I is relatively compact in  $C(G)$  where  $C(G)_0$  is the subspace of continuous functions with null integral. Since we have

$$
\label{eq:2.1} \begin{split} \left\{f\in\mathcal{C}(G)_0\cap\operatorname{dom}\Delta_p^{\frac{\alpha}{2}}:\left\|\Delta_p^{\frac{\alpha}{2}}(f)\right\|_{\mathcal{L}^p(G)}\leqslant 1\right\}\\ \stackrel{(3.11)(3.12)}{=} \left\{f\in\operatorname{dom}\left\|\cdot\right\|_{\dot{\mathcal{L}}^p_\alpha(G)}:\|f\|_{\dot{\mathcal{L}}^p_\alpha(G)}\leqslant 1,\ \int_Gf=0\right\} \end{split}
$$

we deduce that the subset [\(4.13\)](#page-14-0) is also relatively compact in  $C(G)$ . The proof is complete.

**Remark 4.7** The result is sharp. Consider the abelian compact group  $G = \mathbb{T}^2$  and the Laplacian  $\Delta_2$ : dom  $\Delta_2 \subset L^2(\mathbb{T}^2) \to L^2(\mathbb{T}^2)$ , e<sup>ni</sup>· ⊗ e<sup>mi</sup>·  $\mapsto -(n^2 + m^2)e^{n\mathbf{i} \cdot \mathbf{r}} \otimes e^{m\mathbf{i} \cdot \mathbf{r}}$  and  $\alpha = 1$ . By Example [3.2,](#page-7-3) the local dimension *d* of  $\mathbb{T}^2$  is 2. In [\[7,](#page-35-3) Remark 5.3] and its proof, it is showed that the set

$$
\left\{ f \in \mathrm{C}(\mathbb{T}^2)_0 \cap \mathrm{dom} \, \Delta_2^{\frac{1}{2}} : \, \left\| \Delta_2^{\frac{1}{2}}(f) \right\|_{\mathrm{L}^2(\mathbb{T}^2)} \leqslant 1 \right\}
$$

is not bounded, in particular, not relatively compact. With the notation  $(3.11)$ , this set can be written

(4.15) 
$$
\left\{ f \in \text{dom } \| \cdot \|_{\dot{L}_1^2(\mathbb{T}^2)} : \| f \|_{\dot{L}_1^2(\mathbb{T}^2)} \leq 1, \int_{\mathbb{T}^2} f = 0 \right\}.
$$

By Proposition [4.2,](#page-12-1) we conclude that we does not have in general a quantum compact metric space under the critical condition  $p = \frac{d}{\alpha}$ .

<span id="page-15-1"></span>**Remark 4.8** The inequality [\(1.5\)](#page-1-2) is open if  $\alpha > 1$ . It would be interesting to find a counterexample.

**Remark 4.9** We can replace the subelliptic Laplacian  $\Delta$  of [\(3.9\)](#page-8-0) by a real second order subelliptic operator  $H \stackrel{\text{def}}{=} -\sum_{i,j=1}^{m} c_{ij} X_i X_j$  where  $c_{ij} \in \mathbb{R}$ , satisfying the condition  $\frac{1}{2}(C + C^T) \geq \mu$ . for some  $\mu > 0$  and  $C = [c_{ij}]$ . The L<sup>*p*</sup>-realization  $H_p$  of this operator is a closed operator with domain dom  $H_p = L'_{p,2}$ . See [\[33,](#page-36-15) Chapter II] for more information. In the case of a compact connected Lie group  $G$ , the boundedness of Riesz transforms is proved in  $[33, p. 39]$ . Moreover, for any  $f \in L'_{2,1}$  we have by [\[33,](#page-36-15) pp. 16-17]

$$
\mathrm{Re}\,\langle f,H_2f\rangle_{\mathrm{L}^2(G)}\geqslant\mu\sum_{k=1}^m\left\|X_kf\right\|_{\mathrm{L}^2(G)}^2.
$$

In particular,  $H_2 f = 0$  if and only if for any  $k \in \{1, \ldots, m\}$  we have  $X_k f = 0$ . This observation is useful for obtaining a suitable generalization of the third point of Lemma [3.5](#page-9-2) (unfortunately, this argument only works in the case  $p \geq 2$ .

The generalization of the Leibniz's rule [\(1.5\)](#page-1-2) for these operators for  $\alpha \in ]0,1[$  is an open question.

**Remark 4.10** It may be worthy to study the family of the quantum compact metric spaces  $(C(G), \lVert \cdot \rVert_{\dot{L}^p_\alpha(G)})$  when  $p \to \frac{d}{\alpha}$  from the perspective of the quantum Gromov-Haudorff distance. What can be said about the "limit" ?

**Remark 4.11** It is unclear if there exists a formula for the restriction of the Monge-Kantorovich metric  $(4.2)$  on the subset of pure states of  $C(G)$ , i.e. the map

$$
(s,s')\mapsto \sup\big\{|f(s)-f(s')|:f\in \mathrm{C}(G,\mathbb{R}), \|f\|_{\dot{\mathrm{L}}^p_\alpha(G)}\leqslant 1\big\}.
$$

on  $G \times G$ . It would be interesting to understand this quantity to equivalence with respect to a constant. The question is natural when we compare to the next situation of Theorem [7.4.](#page-31-0)

### <span id="page-15-0"></span>**5 Quantum locally compact metric spaces**

**Quantum locally compact metric spaces** The basic reference is [\[57\]](#page-37-17). A topography on a C\*-algebra *A* is an abelian C\*-subalgebra M of *A* containing an approximate identity for *A*. A topographic quantum space (*A,*M) is an ordered pair of a C\*-algebra *A* and a topography M on *A*. Let  $(A, \mathfrak{M})$  be a topographic quantum space. A state  $\varphi \in S(A)$  is local when there exists a compact *K* of the Gelfand spectrum of  $\mathfrak{M}$  such that  $\varphi(1_K) = 1$ . A Lipschitz triple  $(A, \|\cdot\|, \mathfrak{M})$  is a triple where  $(A, \|\cdot\|)$  is a Lipschitz pair and  $\mathfrak{M}$  is a topography on A.

Let  $(A, \|\cdot\|, \mathfrak{M})$  be a Lipschitz triple. The definition of quantum locally compact quantum metric spaces of [\[57\]](#page-37-17) is equivalent to say that  $(A, \|\cdot\|, \mathfrak{M})$  is a quantum locally compact quantum metric space if and only if for any compactly supported element  $g, h \in \mathfrak{M}$  and for some local state  $\mu$  of  $\tilde{A}$ , the set:

$$
\{ ga h : a \in (uA)_{sa}, ||a|| \leq 1, \mu(a) = 0 \}
$$

is relatively compact for the topology associated to  $\|\cdot\|_A$ . Here we identify  $\mu$  with its unique extension  $a + \lambda 1 \mapsto \mu(a) + \lambda$  as a state of the unital  $C^*$ -algebra  $uA$ .

<span id="page-16-5"></span>**Quasi-Leibniz quantum locally compact metric space** Unfortunately, Latrémolière did not generalize the notion of definition of quasi-Leibniz quantum compact metric spaces of Section [4](#page-10-0) to the locally compact case. We make an attempt by saying that a quantum locally compact quantum metric space  $(A, \|\cdot\|, \mathfrak{M})$  is a quasi-Leibniz quantum locally compact metric space if the restriction of  $\|\cdot\|$  on  $A_{sa}$  satisfies the points [\(4.6\)](#page-12-3) and [\(4.7\)](#page-12-4) which is slightly less general than  $[7, Section 5.5]$ .

**Criterion of relative compactness** The following is a locally compact group generalization  $[14, \text{ Exercise 26 VIII}.72]$  $[14, \text{ Exercise 26 VIII}.72]$   $[32, \text{Problem 4 p. 283}]$  (see also  $[33, \text{Theorem A.4.1}]$  for a particular case) of the classical Fréchet-Kolmogorov theorem on relative compactness.

<span id="page-16-3"></span>**Theorem 5.1** *Let G be a locally compact group equipped with a left Haar measure. Suppose*  $1 \leq p \leq \infty$ . Let F be a subset of the Banach space  $L^p(G)$ . Then F is relatively compact if and *only if there exists M >* 0 *such that*

(5.1) 
$$
\lim_{s \to e} \sup_{f \in \mathcal{F}} \|\lambda_s f - f\|_{\mathcal{L}^p(G)} = 0,
$$

(5.2) 
$$
\sup_{f \in \mathcal{F}} ||f||_{\mathcal{L}^p(G)} \leqslant M \quad \text{and} \quad \lim_{r \to \infty} \sup_{f \in \mathcal{F}} \int_{G - B(e,r)} |f(s)|^p \, \mathrm{d}\mu_G(s) = 0.
$$

Now, consider a connected Lie group  $G$  equipped with a family  $X$  of left-invariant Hörmander vector fields with polynomial volume growth and local dimension *d*. We suppose that *G* is *not* compact. Let K be a compact subset of *G*. We denote by  $C_K(G)$  the space of continuous functions on *G* with support in *K*.

Suppose  $1 < p < \infty$  and  $\alpha \geqslant 0$ . Following essentially [\[25,](#page-36-1) p. 287] we define the subspace

(5.3) 
$$
L^p_\alpha(G) \stackrel{\text{def}}{=} \text{dom } \Delta_p^{\frac{\alpha}{2}}
$$

of  $L^p(G)$ . If  $f \in L^p_\alpha(G)$ , we will use the notation

<span id="page-16-2"></span>(5.4) 
$$
||f||_{L^p(\mathcal{G})} \stackrel{\text{def}}{=} ||\Delta_p^{\frac{\alpha}{2}}(f)||_{L^p(\mathcal{G})} + ||f||_{L^p(\mathcal{G})} \stackrel{(2.10)}{\approx} ||(\mathrm{Id} + \Delta_p)^{\frac{\alpha}{2}}(f)||_{L^p(\mathcal{G})}.
$$

We refer to [\[40,](#page-37-15) Section II.5] and [\[56,](#page-37-9) Section 15.E] for the link with Sobolev towers. If  $\alpha p > d$ , we have by [\[25,](#page-36-1) p. 287] [\[15,](#page-36-3) Theorem 4.4 (c)] a Sobolev embedding  $L^p_\alpha(G) \subset L^\infty(G)$ :

<span id="page-16-1"></span>(5.5) 
$$
||f||_{L^{\infty}(G)} \lesssim ||f||_{L^{p}_{\alpha}(G)}, \quad f \in \text{dom}\,\Delta_{p}^{\frac{\alpha}{2}}.
$$

Note that by [\[48,](#page-37-8) Proposition 3.2.3] the Bessel potential  $(\text{Id} + \Delta)^{-\alpha}$  is a *bounded* operator on the Banach space  $L^p(G)$  for any  $\alpha \in \mathbb{C}$  with  $\text{Re }\alpha > 0$ . Consequently if  $0 < \alpha \leq \beta$  it is obvious to check with [\(2.10\)](#page-4-3) that

<span id="page-16-0"></span>(5.6) 
$$
||f||_{L^p_{\alpha}(G)} \lesssim ||f||_{L^p_{\beta}(G)}.
$$

<span id="page-16-4"></span>A contractive inclusion for the case  $G = \mathbb{R}^n$  is proved in [\[78,](#page-38-0) p. 135] with a different argument. A *contractive* version of [\(5.6\)](#page-16-0) is stated without proof in the inequality following [\[15,](#page-36-3) (3.1)] but it is a mistake confirmed by the authors of this paper.

<span id="page-17-2"></span>**Proposition 5.2** *Let G be a non-compact connected Lie group equipped with a family*  $(X_1, \ldots, X_m)$ *of left-invariant H¨ormander vector fields. Suppose that G has polynomial volume growth. Let*  $\alpha \geq 1$  *and*  $\max\{1, \frac{d}{\alpha}\} < p < \infty$ *. If*  $g: G \to \mathbb{C}$  *is a compactly supported continuous function then the subset*

<span id="page-17-1"></span>(5.7) 
$$
g\{f \in C_0(G) \cap \text{dom}\,\Delta_p^{\frac{\alpha}{2}} : ||f||_{L^p_{\alpha}(G)} \leq 1, f(e) = 0\}
$$

*is relatively compact in*  $L^{\infty}(G)$ *.* 

*Proof* : Let *K* be a compact subset of *G*. For any  $M \geq 0$ , consider the subset

(5.8) 
$$
E_{K,p,M} \stackrel{\text{def}}{=} \left\{ f \in \mathcal{C}_K(G) \cap \text{dom}\, \Delta_p^{\frac{\alpha}{2}} : \|f\|_{\mathcal{L}^p_\alpha(G)} \leqslant M \right\}
$$

of the Banach space  $L^p(G)$ . If  $f \in E_{K,p,M}$ , using the Sobolev embedding  $L^p_\alpha(G) \subset L^\infty(G)$  we obtain

<span id="page-17-0"></span>
$$
||f||_{\mathcal{L}^p(G)} \lesssim_{K,p} ||f||_{\mathcal{L}^{\infty}(G)} \stackrel{(5.5)}{\lesssim} ||f||_{\mathcal{L}^p_{\alpha}(G)} \leqslant M.
$$

Consequently, the subset  $E_{K,p,M}$  is bounded in  $L^p(G)$ . Moreover, using Lemma [3.1,](#page-6-3) we have for any function  $f \in E_{K,p,M}$  and any  $s \in G$ 

$$
\begin{split}\n\| (\mathrm{Id} - \lambda_s) f \|_{\mathrm{L}^p(G)} &\stackrel{(3.5)}{\leq} \mathrm{dist}_{\mathrm{CC}}^{p^*}(s, e) \bigg( \sum_{k=1}^m \| X_{k, p}(f) \|_{\mathrm{L}^p(G)}^p \bigg)^{\frac{1}{p}} \approx_p \mathrm{dist}_{\mathrm{CC}}^{p^*}(s, e) \sum_{k=1}^m \| X_{k, p}(f) \|_{\mathrm{L}^p(G)} \\
&\stackrel{(3.10)}{\leq_p} \mathrm{dist}_{\mathrm{CC}}^{p^*}(s, e) \| \Delta_p^{\frac{1}{2}}(f) \|_{\mathrm{L}^p(G)} &\stackrel{(5.4)}{\leq} \mathrm{dist}_{\mathrm{CC}}^{p^*}(s, e) \| f \|_{\mathrm{L}^p(G)} \\
&\stackrel{(5.8)}{\leq} \mathrm{dist}_{\mathrm{CC}}^{p^*}(s, e) \| f \|_{\mathrm{L}^p(\mathrm{G})} &\stackrel{(5.8)}{\leq} M \mathrm{dist}_{\mathrm{CC}}^{p^*}(s, e).\n\end{split}
$$

With Theorem [5.1,](#page-16-3) we obtain the relative compactness of the subset  $E_{K,p,M}$  in  $L^p(G)$  and of its subset

$$
F_{K,p,M} \stackrel{\text{def}}{=} \Big\{ f \in \mathrm{C}_K(G) \cap \mathrm{dom}\, \Delta_p^{\frac{\alpha}{2}} : \|f\|_{\mathrm{L}^p_\alpha(G)} \leqslant M, f(e) = 0 \Big\}.
$$

The operator  $(\text{Id} + \Delta)^{-\frac{\alpha}{2}}$ :  $L^p(G) \to \overline{\text{Ran} \Delta_{\infty}}$  is bounded by [\(5.5\)](#page-16-1) and [\(5.4\)](#page-16-2) (hence uniformly continuous). Applying this operator to the previous subset by writing  $f = (\text{Id} + \Delta)^{-\frac{\alpha}{2}}(\text{Id} +$  $\Delta_p$ )<sup> $\frac{\alpha}{2}$ </sup>*f*, we obtain that the set  $F_{K,p,M}$  is relatively compact in  $L^{\infty}(G)$ , hence in C<sub>0</sub>(*G*). Note that if *f* belongs to  $C_0(G) \cap \text{dom } \Delta_p^{\frac{\alpha}{2}}$  and satisfies  $||f||_{L^p_\alpha(G)} \leq 1$  and if  $g \in C_c(G)$ , we have

$$
||gf||_{L^p_{\alpha}(G)} \lesssim_p ||g||_{L^p_{\alpha}(G)} ||f||_{L^{\infty}(G)} + ||g||_{L^{\infty}(G)} ||f||_{L^p_{\alpha}(G)}
$$
  

$$
\lesssim ||f||_{L^p_{\alpha}(G)} \Big[ ||g||_{L^{\infty}(G)} + ||g||_{L^p_{\alpha}(G)} \Big] \le ||g||_{L^{\infty}(G)} + ||g||_{L^p_{\alpha}(G)}.
$$

Consequently, if supp  $g \subset K$ , we obtain that the subset [\(5.7\)](#page-17-1) is included in some subset  $F_{K,p,M}$ with  $M \stackrel{\text{def}}{=} \|g\|_{L^{\infty}(G)} + \|g\|_{L^{p}_{\alpha}(G)}.$ г

**Remark 5.3** In [\[78,](#page-38-0) Proposition 3 p. 138], it is proved that a measurable function *f* belongs to the space  $L_1^p(\mathbb{R}^n)$  if and only if  $\|(\mathrm{Id} - \lambda_s)f\|_{L^p(\mathbb{R}^n)} = O(|s|)$ . So, we are not confident in a possible generalization of Proposition [5.2](#page-16-4) to the case  $0 < \alpha < 1$ . Note also that in [\[78,](#page-38-0) Ex 6.1] p. 159], it is stated that a measurable function *f* belongs to the space  $L_1^p(\mathbb{R}^n)$  if and only if *f* belongs to  $L^p(\mathbb{R}^n)$ , *f* is absolutely continuous and the partial derivatives  $\frac{\partial f}{\partial x_1}, \ldots, \frac{\partial f}{\partial x_n}$  belong to  $\mathcal{L}^p(\mathbb{R}^n)$ .

<span id="page-18-2"></span>**Remark 5.4** It is transparent for the author that some form of local ultracontractivity [\[45,](#page-37-5) Definition 2.11] can be used to give some variants or generalizations of the previous proof to other contexts.

We also define the seminorm  $\lVert \cdot \rVert_{L^p_\alpha(G)}$  on the space  $(C_0(G) \cap \text{dom } \Delta_p^{\frac{\alpha}{2}}) \oplus \mathbb{C}1$  by letting  $||f||_{L^p_\alpha(G)} \stackrel{\text{def}}{=} ||f_0||_{L^p_\alpha(G)}$  for any element  $f = f_0 + \lambda 1$  of the space  $(C_0(G) \cap \text{dom } \Delta_p^{\frac{\alpha}{2}}) \oplus \mathbb{C}1$ . Note that the latter space is a subspace of the unitization  $C_0(G) \oplus \mathbb{C}1$  of the non-unital algebra  $C_0(G)$ .

<span id="page-18-0"></span>**Lemma 5.5** *The restriction of the seminorm*  $\lVert \cdot \rVert_{L^p_\alpha(G)}$  *on the subspace*  $(C_0(G) \cap \text{dom } \Delta_p^{\frac{\alpha}{2}})$  *is lower semicontinuous.*

*Proof* : Let  $f \in C_0(G)$  and  $(f_n)$  be a sequence of elements of  $C_0(G) \cap \text{dom } \Delta_p^{\frac{\alpha}{2}}$  such that  $(f_n)$  converges to *f* for the norm topology of  $C_0(G)$  and  $||f_n||_{L^p_\alpha(G)} \leq 1$  for any *n*, that is  $\left\|\Delta_{p}^{\frac{\alpha}{2}}(f_{n})\right\|_{\mathbb{L}^{p}(G)} + \|f_{n}\|_{\mathbb{L}^{p}(G)} \leq 1$  by [\(5.4\)](#page-16-2). Note that in particular that the sequences  $(f_{n})$  and  $(\Delta_p^{\frac{\alpha}{2}}(f_n))$  are bounded in the Banach space  $L^p(G)$ . We have to prove that the function *f* belongs to dom  $\Delta_p^{\frac{\alpha}{2}}$  and that  $||f||_{L^p_\alpha(G)} \leq 1$ .

First, we show that the sequence  $(f_n)$  converges to f for the weak topology of the Banach space  $L^p(G)$ . Indeed, for any function  $g \in C_c(G)$ , we have

$$
\left| \int_G (f_n - f) g \, \mathrm{d}\mu_G \right| \leq \|f_n - f\|_{\mathrm{L}^\infty(G)} \int_G |g| \, \mathrm{d}\mu_G \xrightarrow[n \to +\infty]{} 0.
$$

Using the boundedness of the sequence  $(f_n)$  in  $L^p(G)$ , we obtain the claim with [\[65,](#page-38-12) 2.71 p. 234] since we have the convergence with any function *g* of the dense subspace  $C_c(G)$  of the Banach space  $L^{p^*}(G)$ .

Since the sequence  $(\Delta_p^{\frac{\alpha}{2}} f_n)$  is bounded in the Banach space  $L^p(G)$  and since bounded sets are weakly relatively compact by  $[65,$  Theorem 2.8.2], there exists a weakly convergent subnet  $(\Delta_p^{\frac{\alpha}{2}} f_{n_j})$ . Then  $(f_{n_j}, \Delta_p^{\frac{\alpha}{2}} f_{n_j})$  is a weakly convergent net in the graph of the closed operator  $\Delta_p^{\frac{\alpha}{2}}$ . Note that this graph is closed and convex, hence weakly closed by [\[65,](#page-38-12) Theorem 2.5.16]. Thus the limit of  $(f_{n_j}, \Delta_p^{\frac{\alpha}{2}} f_{n_j})$  belongs again to the graph and is of the form  $(g, \Delta_p^{\frac{\alpha}{2}} g)$  for some  $g \in \text{dom }\Delta_p^{\frac{\alpha}{2}}$ . In particular, the net  $(f_{n_j})$  converges weakly to *g* and  $\Delta_p^{\frac{\alpha}{2}}(f_{n_j})$  converges weakly to  $\Delta_p^{\frac{\alpha}{2}}(g)$ . We infer that  $f = g$ . We conclude that *f* belongs to dom  $\Delta_p^{\frac{\alpha}{2}}$ . Moreover, using the weakly lower semicontinuity of the norm [\[65,](#page-38-12) Theorem 2.5.21], we obtain

$$
||f||_{\mathcal{L}^p_{\alpha}(G)} \stackrel{(5.4)}{=} ||\Delta_p^{\frac{\alpha}{2}}(f)||_{\mathcal{L}^p(G)} + ||f||_{\mathcal{L}^p(G)} \leq \liminf_j \left[ ||\Delta_p^{\frac{\alpha}{2}}(f_{n_j})||_{\mathcal{L}^p(G)} + \liminf_j ||f_{n_j}||_{\mathcal{L}^p(G)} \right] \leq 1.
$$

<span id="page-18-1"></span>**Corollary 5.6** Let *G* be a non-compact connected Lie group equipped with a family  $(X_1, \ldots, X_m)$ *of left-invariant H¨ormander vector fields. Suppose that G has polynomial volume growth. Let*  $\alpha \geq 1$  *and*  $\max\{1, \frac{d}{\alpha}\}$   $\leq p \leq \infty$  *where d is the local dimension defined in* [\(3.7\)](#page-7-2)*.* Then  $(C_0(G), \lVert \cdot \rVert_{L^p_\alpha(G)}, C_0(G))$  defines a  $(C_{\alpha,p}, 0)$ -quasi-Leibniz quantum locally compact metric space *for some constant*  $C_{\alpha,p} > 0$ *.* 

*Proof* : Parts 1 and 2 of Lemma [3.5](#page-9-2) say that dom  $\lVert \cdot \rVert_{\mathring{L}^p_\alpha(G)}$  $\sum_{n=0}^{(3.12)}$  $\sum_{n=0}^{(3.12)}$  $\sum_{n=0}^{(3.12)}$  C<sub>0</sub>(*G*)∩dom  $\Delta_p^{\frac{\alpha}{2}}$  is closed under the adjoint operation and dense in the space  $C_0(G)$ . Consequently  $(C_0(G) \cap \text{dom }\Delta_p^{\frac{\alpha}{2}}) \oplus \mathbb{C}1$  is also closed under the adjoint operation of the algebra  $C_0(G) \oplus \mathbb{C}1$  and dense in  $C_0(G) \oplus \mathbb{C}1$ .

<span id="page-19-4"></span>Let  $f = f_0 + \lambda 1$  be an element of  $(C_0(G) \cap \text{dom }\Delta_p^{\frac{\alpha}{2}}) \oplus \mathbb{C}1$ . Suppose that  $||f||_{L^p_\alpha(G)} = 0$ . Then by definition

$$
\left\|\Delta_p^{\frac{\alpha}{2}}(f_0)\right\|_{\mathrm{L}^p(G)} + \left\|f_0\right\|_{\mathrm{L}^p(G)} \stackrel{(5.4)}{=} \left\|f_0\right\|_{\mathrm{L}^p_\alpha(G)} = 0.
$$

Hence  $||f_0||_{L^p(G)} = 0$  and finally  $f_0 = 0$ . We conclude that  $f = \lambda 1$ . So [\(4.1\)](#page-11-1) is satisfied. So we have a Lipschitz pair  $(C_0(G), \lVert \cdot \rVert_{L^p_\alpha(G)})$ .

This Dirac measure  $\delta_e$  is clearly a local state since it is supported by the compact  $\{e\}$ . The Leibniz rule is given by  $(1.4)$ . The lower semicontinuity is given by Lemma [5.5.](#page-18-0) We conclude with Proposition [5.2.](#page-16-4) П

In the end of this section, we will investigate what happens when we replace the operator Id +  $\Delta_p$  by the subelliptic Laplacian  $\Delta_p$  in one case. The obtained result of Proposition [5.7](#page-19-0) is a bit different. Indeed, it is obvious that the addition of the identity to the operator  $\Delta$  removes global phenomenons.

Suppose that the connected Lie group *G* is equipped with a family  $(X_1, \ldots, X_m)$  of leftinvariant Hörmander vector fields and has polynomial growth with  $d < D$ . Such group is not compact. For example by [\[76,](#page-38-8) p. 273], this condition is satisfied if *G* is simply connected, nilpotent with  $G \not\approx \mathbb{R}^d$ . Consider some  $1 < p < \infty$  and some  $\alpha > 0$ . If  $d < \alpha p < D$ , it is stated in [\[25,](#page-36-1) p. 288] and [\[24,](#page-36-9) p. 197] that

||f||_{L^{\infty}(G)} \lesssim ||f||_{\dot{L}^{p}_{\alpha}(G)}, \quad f \in C^{\infty}_{c}(G).
$$

<span id="page-19-0"></span>Now, we prove an analogue of Proposition [5.2.](#page-16-4)

**Proposition 5.7** *Let G be a connected Lie group equipped with a family*  $(X_1, \ldots, X_m)$  of left*invariant Hörmander vector fields. Suppose that*  $G$  *has polynomial growth with*  $d < D$ *. Assume that*  $d < p < D$ . If  $q: G \to \mathbb{C}$  *is a compactly supported continuous function then the subset*

g\{f \in C_0(G) \cap \text{dom}\,\Delta_p^{\frac{1}{2}} : ||f||_{\mathring{L}_1^p(G)} \leq 1, f(e) = 0\}
$$

*is relatively compact in*  $L^{\infty}(G)$ *.* 

*Proof* : Let K be a compact subset of G. For any  $M \geq 0$ , consider the subset

(5.11) 
$$
E_{K,p,M} \stackrel{\text{def}}{=} \left\{ f \in C_K(G) \cap \text{dom } \Delta_p^{\frac{1}{2}} : \|f\|_{\dot{L}_1^p(G)} \leqslant M \right\}
$$

of the space  $L^p(G)$ . If  $f \in E_{K,p,M}$ , using the Sobolev embedding  $\dot{L}^p_1(G) \subset L^{\infty}(G)$  of [\(5.9\)](#page-19-1), we obtain  $(5.9)$ 

<span id="page-19-2"></span>
$$
||f||_{\mathcal{L}^p(G)} \lesssim_{K,p} ||f||_{\mathcal{L}^{\infty}(G)} \lesssim ||f||_{\dot{\mathcal{L}}^p_1(G)} \leq M.
$$

We infer that the subset  $E_{K,p,M}$  is bounded in  $L^p(G)$ . Furthermore, using Lemma [3.1,](#page-6-3) we have for any function  $f \in E_{K,p,M}$ 

$$
\|(\mathrm{Id} - \lambda_s)f\|_{\mathrm{L}^p(G)} \stackrel{(3.5)}{\leq} \mathrm{dist}_{\mathrm{CC}}^{p^*}(s,e) \bigg(\sum_{k=1}^m \|X_{k,p}(f)\|_{\mathrm{L}^p(G)}^p\bigg)^{\frac{1}{p}} \approx_p \mathrm{dist}_{\mathrm{CC}}^{p^*}(s,e) \sum_{k=1}^m \|X_{k,p}(f)\|_{\mathrm{L}^p(G)} \tag{5.11}
$$
  

$$
\lesssim_p \mathrm{dist}_{\mathrm{CC}}^{p^*}(s,e) \|\Delta_p^{\frac{1}{2}}(f)\|_{\mathrm{L}^p(G)} \stackrel{(3.11)}{=} \mathrm{dist}_{\mathrm{CC}}^{p^*}(s,e) \|f\|_{\mathrm{L}_1^p(G)} \stackrel{(5.11)}{\leq} M \mathrm{dist}_{\mathrm{CC}}^{p^*}(s,e).
$$

By Theorem [5.1,](#page-16-3) the subset  $E_{K,p,M}$  is relatively compact in  $L^p(G)$ . Hence, its subset

$$
F_{K,p,M} \stackrel{\text{def}}{=} \left\{ f \in \mathcal{C}_K(G) \cap \text{dom}\, \Delta_p^{\frac{1}{2}} : ||f||_{\dot{\mathcal{L}}_1^p(G)} \leqslant M, f(e) = 0 \right\}
$$

<span id="page-20-2"></span>is also relatively compact in  $L^p(G)$ . The operator  $\Delta^{-\frac{1}{2}}: L^p(G) \to \overline{\text{Ran}\Delta_{\infty}}$  is bounded by [\(5.9\)](#page-19-1), hence uniformly continuous. Applying this operator to the previous subset by writing  $f = \Delta^{-\frac{1}{2}} \Delta_p^{\frac{1}{2}} f$  we obtain that the set  $F_{K,p,M}$  is relatively compact in  $L^{\infty}(G)$ , hence in the space  $C_0(G)$ . Note that we have

$$
||gf||_{\dot{L}_1^p(G)} \overset{(1.5)}{\lesssim_p} ||g||_{\dot{L}_1^p(G)} ||f||_{L^{\infty}(G)} + ||g||_{L^{\infty}(G)} ||f||_{\dot{L}_1^p(G)}
$$
  

$$
\overset{(5.9)}{\lesssim} ||f||_{L_1^p(G)} \left[ ||g||_{L^{\infty}(G)} + ||g||_{\dot{L}_1^p(G)} \right] \overset{(5.11)}{\lesssim} ||g||_{L^{\infty}(G)} + ||g||_{\dot{L}_1^p(G)}.
$$

Consequently, if supp  $g \subset K$ , we obtain that the subset  $(5.10)$  is included in some subset  $F_{K,p,M}$ with  $M \stackrel{\text{def}}{=} \|g\|_{L^{\infty}(G)} + \|g\|_{\dot{L}^p_1(G)}.$ 

Similarly to Corollary [5.6,](#page-18-1) we obtain the following result where the seminorm  $\lVert \cdot \rVert_{\mathcal{L}_{\alpha}^{p}(G)}$  is defined on dom  $\lVert \cdot \rVert_{\dot{L}_1^p(G)}$  $\sum_{n=0}^{(3.12)}$  $\sum_{n=0}^{(3.12)}$  $\sum_{n=0}^{(3.12)}$  C<sub>0</sub>(*G*) ∩ dom  $\Delta_p^{\frac{1}{2}}$ . Unfortunately, we are not able to prove the lower semicontinuity of the seminorm  $\lVert \cdot \rVert_{\dot{L}^p_1(G)}$ . So we cannot make the statement that we have a *quasi-Leibniz* quantum locally compact metric space.

**Corollary 5.8** Let G be a connected Lie group equipped with a family  $(X_1, \ldots, X_m)$  of left*invariant Hörmander vector fields. Suppose that*  $G$  *has polynomial growth with*  $d < D$ *. Then the triple*  $(C_0(G), \lVert \cdot \rVert_{\dot{L}^p_1(G)}, C_0(G))$  *defines a quantum locally compact metric space.* 

### <span id="page-20-0"></span>**6 Compact spectral triples and spectral dimension**

**Possibly kernel-degenerate compact spectral triples** Consider a triple  $(A, Y, \emptyset)$  constituted of the following data: a Banach space Y, a closed unbounded operator  $\mathbb{D}$  on Y with dense domain dom  $\bar{p} \subset Y$ , an algebra *A* equipped with a homomorphism  $\pi: A \to B(Y)$ . In this case, we define the Lipschitz algebra

$$
\text{Lip}_{\not{D}}(A) \stackrel{\text{def}}{=} \{a \in A : \pi(a) \cdot \text{dom } D \subset \text{dom } D \text{ and the unbounded operator} \quad [\not{D}, \pi(a)] : \text{dom } D \subset Y \to Y \text{ extends to an element of } B(Y) \}.
$$

We say that  $(A, Y, B)$  is a (possibly kernel-degenerate) compact spectral triple if in addition *Y* is a Hilbert space  $H$ ,  $A$  is a  $C^*$ -algebra,  $D$  is a selfadjoint operator on  $Y$  and if we have

- 1.  $\overline{p}^{-1}$  is a compact operator on  $\overline{\text{Ran }\mathcal{D}} \stackrel{(2.5)}{=} (\text{Ker }\mathcal{D})^{\perp}$  $\overline{\text{Ran }\mathcal{D}} \stackrel{(2.5)}{=} (\text{Ker }\mathcal{D})^{\perp}$  $\overline{\text{Ran }\mathcal{D}} \stackrel{(2.5)}{=} (\text{Ker }\mathcal{D})^{\perp}$ ,
- 2. the subset  $\text{Lip}_{\phi}(A)$  is dense in A.

We essentially follow [\[19,](#page-36-6) Definition 2.1] and [\[7,](#page-35-3) Definition 5.10]. Note that there exists different variations of this definition in the literature, see e.g. [\[35,](#page-37-16) Definition 1.1]. Moreover, we can replace  $\mathbf{D}^{-1}$  by  $|\mathbf{D}|^{-1}$  in the first point by an elementary functional calculus argument.

We equally refer to  $[7,$  Definition 5.10 for the notion of compact Banach spectral triple which is a generalization for the case of an operator  $\vec{\psi}$  acting on a Banach space Y instead of a Hilbert space *H*.

**Example 6.1** If *M* is a compact oriented Riemannian manifold *M*, we can associate the spectral triple  $(C(M), L^2(\wedge T^*M), D)$  where  $L^2(\wedge T^*M)$  is the Hilbert space of square-integrable <span id="page-21-4"></span>complex-valued forms on *M* and where *D* is the Hodge-Dirac operator (also called Hodgede Rham operator). If *M* is in addition a spin manifold, we can also consider the spectral triple  $(C(M), L<sup>2</sup>(M, S), \mathscr{D})$  obtained by using the Hilbert space  $L<sup>2</sup>(M, S)$  the space of squareintegrable spinors on M, and the Dirac operator  $\mathscr{D}$ . In both cases, the functions of  $C(M)$  act on the Hilbert space by multiplication operators.

**Spectral dimension** Let  $(A, H, \mathcal{D})$  be a compact spectral triple. By [\[71,](#page-38-16) Proposition 5.3.38], we have Ker  $|\not\!\!D| = \text{Ker }\nolimits \not\!\!D$ . Moreover, the operator  $|\not\!\!D|^{-1}$  is well-defined on  $\overline{\text{Ran }\nabla}^{(2.5)} \equiv (\text{Ker }\nabla)^{\perp}$  $\overline{\text{Ran }\nabla}^{(2.5)} \equiv (\text{Ker }\nabla)^{\perp}$  $\overline{\text{Ran }\nabla}^{(2.5)} \equiv (\text{Ker }\nabla)^{\perp}$ . Furthermore, we can extend it by letting  $|\not\!\!D|^{-1} = 0$  on Ker  $\not\!\!D$ . Following [\[35,](#page-37-16) p. 4], we say that a compact spectral triple  $(A, H, \emptyset)$  is  $\alpha$ -summable for some  $\alpha > 0$  if Tr $|\emptyset|^{-\alpha} < \infty$ , that is if the operator  $|\psi|^{-1}$  belongs to the Schatten class  $S^{\alpha}(H)$ . In this case, the spectral dimension of the spectral triple is defined by

<span id="page-21-2"></span>(6.2) 
$$
\dim(A, H, \mathcal{D}) \stackrel{\text{def}}{=} \inf \{ \alpha > 0 : \text{Tr} |\mathcal{D}|^{-\alpha} < \infty \}.
$$

<span id="page-21-3"></span>See also  $\left[43, p. 450\right]$  and  $\left[27, p. 38 \right]$  and Definition 6.2 p. 47 for a variation of this definition. We will use the following lemma which is a slight variation of [\[43,](#page-37-18) Lemma 10.8 p. 450].

**Lemma 6.2** *If*  $|\n\mathcal{D}|^{-\alpha}$  *is trace-class then for any*  $t > 0$  *the operator*  $e^{-t\mathcal{D}^2}$  *is trace-class and we have*

(6.3) 
$$
\operatorname{Tr} e^{-t\vec{\mathcal{P}}^2} \lesssim \frac{1}{t^{\frac{\alpha}{2}}}, \quad t > 0.
$$

*Proof* : Note that here the operator  $|\mathcal{D}|^{-\alpha}$  is defined and bounded on Ran  $\mathcal{D}$ . However, we can extend it by letting  $|\not\!\!D|^{-\alpha} = 0$  on Ker  $\vec{p}$ . For any  $t > 0$ , we have  $e^{-t\vec{p}^2} = |\not\!\!D|^\alpha e^{-t\vec{p}^2} |\not\!\!D|^{-\alpha}$ . An elementary study of the function  $f: \lambda \mapsto \lambda^{\alpha} e^{-t\lambda^2}$  on  $\mathbb{R}^+$  shows that  $f'(\lambda) = \lambda^{\alpha-1} e^{-t\lambda^2} (\alpha-2\lambda^2 t)$ for any  $\lambda \geqslant 0$  and consequently that *f* is bounded and that its maximum is  $\left(\frac{\alpha}{2t}\right)^{\frac{\alpha}{2}}e^{-\frac{\alpha}{2}}$  in 2*t*  $\lambda = \sqrt{\frac{\alpha}{2t}}$ . We conclude by functional calculus that the operator  $|\mathcal{D}|^{\alpha}e^{-t\mathcal{D}^2}$  is bounded and that

$$
\text{Tr} \, \mathrm{e}^{-t\vec{p}^2} = \left\| \mathrm{e}^{-t\vec{p}^2} \right\|_{S^1(H)} \leqslant \left\| |\vec{p}|^{\alpha} \mathrm{e}^{-t\vec{p}^2} \right\|_{\mathcal{B}(H)} \left\| |\vec{p}|^{-\alpha} \right\|_{S^1(H)} \lesssim \frac{1}{t^{\frac{\alpha}{2}}}.
$$

П

**Hodge-Dirac operator** Let *G* be a unimodular connected Lie group equipped with a family  $(X_1, \ldots, X_m)$  of left-invariant Hörmander vector fields and consider a Haar measure  $\mu_G$  on *G*. Suppose  $1 \leqslant p \leqslant \infty$ . Recall that we have a canonical isometry  $\ell_m^p(\mathcal{L}^p(G)) = \mathcal{L}^p(G, \ell_m^p)$ . We define the unbounded closed operator  $\nabla_p$  from  $L^p(G)$  into the space  $L^p(G, \ell_m^p)$  by dom  $\nabla_p =$ dom  $X_{1,p} \cap \cdots \cap$  dom  $X_{m,p}$  and

<span id="page-21-0"></span>(6.4) 
$$
\nabla_p f \stackrel{\text{def}}{=} (X_{1,p}f, \dots, X_{m,p}f), \quad f \in \text{dom}\, \nabla_p.
$$

If  $1 \leq p \leq \infty$ , note that  $\text{dom } \nabla_p = \text{dom } \Delta_p^{\frac{1}{2}}$  by Proposition [3.4.](#page-8-1) For any functions  $f, g$  of  $\text{dom }\nabla_p \cap \text{L}^{\infty}(G)$  then *fg* belongs to  $\text{dom }\nabla_p \cap \text{L}^{\infty}(G)$  and we have

$$
\nabla_p(fg) = g \cdot \nabla_p(f) + f \cdot \nabla_p(g)
$$

where  $f \cdot (h_1, \ldots, h_m) \stackrel{\text{def}}{=} (fh_1, \ldots, fh_m)$ . See [\[25,](#page-36-1) p. 289] for a generalization.

<span id="page-22-6"></span><span id="page-22-0"></span>If  $1 < p < \infty$ , we introduce the unbounded closed operator

(6.6) 
$$
\psi_p \stackrel{\text{def}}{=} \begin{bmatrix} 0 & (\nabla_{p^*})^* \\ \nabla_p & 0 \end{bmatrix}.
$$

on the Banach space  $L^p(G) \oplus_p L^p(G, \ell_m^p)$  defined by

$$
\mathcal{D}_p(f,g) \stackrel{\text{def}}{=} ((\nabla_{p^*})^*(g), \nabla_p(f)), \quad f \in \text{dom}\, \nabla_p, \ g \in \text{dom}(\nabla_{p^*})^*.
$$

We call it the Hodge-Dirac operator of the subelliptic Laplacian  $\Delta = -(X_1^2 + \cdots + X_m^2)$ . These operators are related by the computation

$$
\mathcal{D}_p^2 \stackrel{(6.6)}{=} \begin{bmatrix} 0 & (\nabla_{p^*})^* \\ \nabla_p & 0 \end{bmatrix}^2 = \begin{bmatrix} (\nabla_{p^*})^* \nabla_p & 0 \\ 0 & \nabla_p (\nabla_{p^*})^* \end{bmatrix} = \begin{bmatrix} \Delta_p & 0 \\ 0 & \nabla_p (\nabla_{p^*})^* \end{bmatrix}.
$$

The operator  $\mathcal{D}_2$  is identical to the operator  $\Pi$  of [\[9,](#page-36-16) proof of Theorem 1.2] with  $b = \text{Id}$ .

We will use just the following lemma which describes a tractable subspace for the adjoint operator  $(\nabla_{p^*})^*$ . If  $(\varphi_j)$  is a Dirac net of functions of  $C_c^{\infty}(G)$  and if  $h = (h_1, \ldots, h_m)$ , we will use the notation  $\text{Reg}_j h \stackrel{\text{def}}{=} (h_1 * \varphi_j, \dots, h_m * \varphi_j)$  as soon as it makes sense.

<span id="page-22-4"></span>**Lemma 6.3** *Suppose*  $1 < p < \infty$ . The subspace  $C_c^{\infty}(G) \otimes \ell_m^p$  is a core of the unbounded *operator*  $(\nabla_{p^*})^*$ *.* 

*Proof* : Is is easy to check (use [\[53,](#page-37-6) Problem 5.24 p. 168]) that  $C_c^{\infty}(G) \otimes \ell_m^p$  is a subset of dom $(\nabla_{p^*})^*$ . We consider a Dirac net  $(\varphi_j)$  of functions of  $C_c^{\infty}(G)$ . Let  $h = (h_1, \ldots, h_m)$  be an element of dom $(\nabla_{p^*})^*$ . Then  $\text{Reg}_j h = (h_1 * \varphi_j, \dots, h_m * \varphi_j)$  belongs to  $C_c^{\infty}(G) \otimes \ell_m^p$ . It remains to show that  $(\text{Reg}_j h)$  converges to *h* in the graph norm of  $(\nabla_{p^*})^*$ . By [\[14,](#page-36-17) Proposition 20 VIII.44], the net  $(\text{Reg}_j h)$  converges to *h* in  $L^p(G, \ell_m^p)$ . For any  $1 \leq k \leq m$ , we put  $a_k \stackrel{\text{def}}{=} X_k(e)$ . If  $f \in C_c^{\infty}(G)$ , using [\[77,](#page-38-17) (9.19)] and the equalities  $X_k = d\lambda(a_k)$  [\[33,](#page-36-15) p. 14] in the second equality and [\[63,](#page-38-11) Proposition 3.14] in the third equality, we have

\nabla \text{Reg}_j f \stackrel{(6.4)}{=} (X_1(f * \varphi_j), \dots, X_m(f * \varphi_j)) = (\text{d}\lambda(a_1)(\lambda_f(\varphi_j)), \dots, \text{d}\lambda(a_m)(\lambda_f(\varphi_j)))
$$

$$
= (\lambda_{X_1f}(\varphi_j), \dots, \lambda_{X_mf}(\varphi_j)) = ((X_1f) * \varphi_j, \dots, (X_mf) * \varphi_j)
$$

$$
= \text{Reg}_j(X_1f, \dots, X_mf) = \text{Reg}_j(\nabla f)
$$

where  $\lambda_f(g) \stackrel{\text{def}}{=} f * g$  and where  $d\lambda$  is the derived representation [\[63,](#page-38-11) Definition 3.12] of the left regular representation  $\lambda$ . Moreover, for any  $g \in C_c^{\infty}(G)$ , we have using [\[32,](#page-36-18) (14.10.9)] in the second and the last inequalities

$$
\langle (\nabla_{p^*})^* \text{Reg}_j h, g \rangle_{\text{L}^p(G),\text{L}^{p^*}(G)} = \langle \text{Reg}_j h, \nabla_{p^*} g \rangle_{\text{L}^p(G, \ell^p_m),\text{L}^{p^*}(G, \ell^{p^*}_m)} = \langle h, \text{Reg}_j(\nabla_{p^*} g) \rangle
$$
  
\n
$$
\stackrel{(6.9)}{=} \langle h, \nabla_{p^*}(\text{Reg}_j g) \rangle = \langle (\nabla_{p^*})^*(h), \text{Reg}_j g \rangle = \langle \text{Reg}_j(\nabla_{p^*})^*(h), g \rangle_{\text{L}^p(G),\text{L}^{p^*}(G)}
$$

where here we use the bracket  $\langle f, g \rangle_{\mathsf{L}^p(G),\mathsf{L}^{p^*}(G)} = \int_G f(s)g(s^{-1}) ds$ . Note that the use of the inversion map  $G \to G$ ,  $s \mapsto s^{-1}$  in the bracket simplifies [\[32,](#page-36-18) (14.10.9)]. By density and duality, we infer that  $(\nabla_{p^*})^* \text{Reg}_j h = \text{Reg}_j((\nabla_{p^*})^* h)$  which converges to  $(\nabla_{p^*})^*(h)$  in  $\mathcal{L}^p(G)$ .

If  $f \in L^{\infty}(G)$ , we define the bounded operator  $\pi(f)$ :  $L^p(G) \oplus_p L^p(G, \ell_m^p) \to L^p(G) \oplus_p$  $L^p(G, \ell_m^p)$  by

\pi(f) \stackrel{\text{def}}{=} \begin{bmatrix} M_f & 0 \\ 0 & \tilde{M}_f \end{bmatrix}, \quad f \in L^{\infty}(G)
$$

<span id="page-23-3"></span>where the linear map  $M_f: L^p(G) \to L^p(G)$ ,  $g \mapsto fg$  is the multiplication operator by the function *f* and where

$$
\widetilde{\mathcal{M}}_f \stackrel{\text{def}}{=} \mathrm{Id}_{\ell_m^p} \otimes \mathcal{M}_f: \ell_m^p(\mathcal{L}^p(G)) \to \ell_m^p(\mathcal{L}^p(G)), (h_1, \ldots, h_m) \mapsto (fh_1, \ldots, fh_m)
$$

is also a multiplication operator (by the function  $(f, \ldots, f)$  of  $\ell_m^{\infty}(\mathcal{L}^{\infty}(G))$ ). Using [\[40,](#page-37-15) Proposition 4.10 p. 31], it is (really) easy to check that  $\pi: L^{\infty}(G) \to B(L^p(G) \oplus_p L^p(G, \ell^p_m))$  is an isometric homomorphism. Moreover, it is obviously continuous when the algebra  $L^{\infty}(G)$  is equipped with the weak\* topology and when the space  $B(L^p(G)) \oplus_p L^p(G, \ell^p_m)$  is equipped with the weak operator topology. Note  $B(L^p(G) \oplus_p L^p(G, \ell^p_m))$  is a dual Banach space whose predual is the projective tensor product  $L^p(G) \oplus_p L^p(G, \ell_m^p) \hat{\otimes} (L^{p^*}(G) \oplus_{p^*} L^{p^*}(G, \ell_m^{p^*}))$ . Using [\[11,](#page-36-20) Theorem A.2.5 (2)], it is not difficult to prove that  $\pi$  is *even* weak\* continuous when we equip the space  $B(L^p(G) \oplus_p L^p(G, \ell^p_m))$  with the weak\* topology.

**Proposition 6.4** *Let G be a unimodular connected Lie group equipped with a family X of leftinvariant Hörmander vector fields. Consider a Haar measure*  $\mu_G$  on G. Suppose  $1 < p < \infty$ .

- *1.* We have  $(\mathbf{D}_p)^* = \mathbf{D}_{p^*}$ . In particular, the unbounded operator  $\mathbf{D}_2$  is selfadjoint.
- *2. We have*

(6.11) 
$$
\operatorname{dom} \nabla_{\infty} \subset \operatorname{Lip}_{\not{D}_p}(\operatorname{L}^{\infty}(G)).
$$

*3. For any*  $f \in \text{dom } ∇_{∞}$ *, we have*

$$
\| \big[\not{D}_p, \pi(f)\big] \|_{\mathrm{L}^p(G)\oplus_p \mathrm{L}^p(G,\ell_m^p)\to \mathrm{L}^p(G)\oplus_p \mathrm{L}^p(G,\ell_m^p)} = \|\nabla_\infty(f)\|_{\mathrm{L}^\infty(G,\ell_m^p)}.
$$

*Proof* : 1. By definition, an element  $(z, t)$  of the Banach space  $L^{p^*}(G) \oplus_{p^*} L^{p^*}(G, \ell_m^{p^*})$  belongs to dom $(\mathcal{D}_p)^*$  if and only if there exists  $(h, k) \in L^{p^*}(G) \oplus_{p^*} L^{p^*}(G, \ell^p_m)$  such that for any  $(f, g) \in \text{dom}\, \nabla_p \oplus \text{dom}(\nabla_{p^*})^*$  we have

$$
\left\langle \begin{bmatrix} 0 & (\nabla_{p^*})^* \\ \nabla_p & 0 \end{bmatrix} \begin{bmatrix} f \\ g \end{bmatrix}, \begin{bmatrix} z \\ t \end{bmatrix} \right\rangle = \left\langle \begin{bmatrix} f \\ g \end{bmatrix}, \begin{bmatrix} h \\ k \end{bmatrix} \right\rangle,
$$

that is

(6.13) 
$$
\langle (\nabla_{p^*})^*(g), z \rangle + \langle \nabla_p(f), t \rangle = \langle g, k \rangle + \langle f, h \rangle.
$$

If  $z \in \text{dom}\,\nabla_{p^*}$  and if  $t \in \text{dom}(\nabla_p)^*$  the latter holds with  $k = \nabla_{p^*}(z)$  and  $h = (\nabla_p)^*(t)$ . This proves that  $\text{dom}(\nabla_p)^* \subset \text{dom}(\mathcal{D}_p)^*$  and that

$$
(\not{D}_p)^*(z,t) = ((\nabla_p)^*(t), \nabla_{p^*}(z)) = \begin{bmatrix} 0 & (\nabla_p)^* \\ \nabla_{p^*} & 0 \end{bmatrix} \begin{bmatrix} z \\ t \end{bmatrix} \stackrel{(6.7)}{=} \not{D}_{p^*}(z,t).
$$

Conversely, if  $(z, t) \in \text{dom}(\mathcal{D}_p)^*$ , choosing  $g = 0$  in [\(6.13\)](#page-23-0) we obtain  $t \in \text{dom}(\nabla_p)^*$  and taking  $f = 0$  we obtain  $z \in \text{dom}\,\nabla_{p^*}.$ 

2. Let  $f \in C_c^{\infty}(G)$ . A standard calculation shows that

$$
\begin{split}\n\left[\mathcal{D}_{p},\pi(f)\right] &\stackrel{(6.6)}{=} \begin{bmatrix} 0 & \left(\nabla_{p^{*}}\right)^{*} \\ \nabla_{p} & 0 \end{bmatrix} \begin{bmatrix} \mathbf{M}_{f} & 0 \\ 0 & \tilde{\mathbf{M}}_{f} \end{bmatrix} - \begin{bmatrix} \mathbf{M}_{f} & 0 \\ 0 & \tilde{\mathbf{M}}_{f} \end{bmatrix} \begin{bmatrix} 0 & \left(\nabla_{p^{*}}\right)^{*} \\ \nabla_{p} & 0 \end{bmatrix} \\
&= \begin{bmatrix} 0 & \left(\nabla_{p^{*}}\right)^{*} \tilde{\mathbf{M}}_{f} \\ \nabla_{p} \mathbf{M}_{f} & 0 \end{bmatrix} - \begin{bmatrix} 0 & \mathbf{M}_{f}(\nabla_{p^{*}})^{*} \\ \nabla_{f}\nabla_{p} & 0 \end{bmatrix} \\
&= \begin{bmatrix} 0 & \left(\nabla_{p^{*}}\right)^{*} \tilde{\mathbf{M}}_{f} - \mathbf{M}_{f}(\nabla_{p^{*}})^{*} \\ \nabla_{p} \mathbf{M}_{f} - \tilde{\mathbf{M}}_{f} \nabla_{p} & 0 \end{bmatrix}.\n\end{split}
$$

<span id="page-24-0"></span>We calculate the two non-zero entries of the commutator. For the lower left corner, if  $g \in C_c^{\infty}(G)$ we have

(6.14) 
$$
(\nabla_p \mathbf{M}_f - \tilde{\mathbf{M}}_f \nabla_p)(g) = \nabla_p \mathbf{M}_f(g) - \tilde{\mathbf{M}}_f \nabla_p(g) = \nabla_p(fg) - f \cdot \nabla_p(g)
$$

$$
\stackrel{(6.5)}{=} g \cdot \nabla_p(f) = (gX_{1,m}(f), \dots, gX_{m,p}(f)) = \mathbf{M}_{\nabla f}J(g)
$$

where  $J: L^p(G) \to \ell^p_m(L^p(G)), g \mapsto (g, \ldots, g)$  and where  $M_{\nabla(f)}$  is the multiplication operator on the L<sup>p</sup>-space  $\ell_m^p(\mathcal{L}^p(G))$  by  $\nabla(f)$ . For the upper right corner, note that for any  $h \in C_c^{\infty}(G) \otimes \ell_m^p$ <br>and any  $g \in C_c^{\infty}(G)$  we have

$$
\langle ((\nabla_{p^*})^*\tilde{M}_f - M_f(\nabla_{p^*})^*)(h), g \rangle = \langle (\nabla_{p^*})^*\tilde{M}_f(h), g \rangle - \langle M_f(\nabla_{p^*})^*(h), g \rangle
$$
  
\n
$$
= \langle \tilde{M}_f(h), \nabla_{p^*}(g) \rangle - \langle (\nabla_{p^*})^*(h), M_f(g) \rangle = \langle h, \tilde{M}_f \nabla_{p^*}(g) \rangle - \langle h, \nabla_{p^*} M_f(g) \rangle
$$
  
\n
$$
= \langle h, \tilde{M}_f \nabla_{p^*}(g) - \nabla_{p^*} M_f(g) \rangle = \langle h, f \cdot \nabla_{p^*}(g) - \nabla_{p^*}(fg) \rangle
$$
  
\n
$$
\stackrel{(6.5)}{=} -\langle h, g \cdot \nabla(f) \rangle = \langle h, -M_{\nabla f} J(g) \rangle = \langle h, M_{\nabla f} J(g) \rangle
$$
  
\n
$$
= \langle M_{\nabla f}(h), J(g) \rangle = \langle J^* M_{\nabla f}(h), g \rangle_{\mathcal{L}^p(G), \mathcal{L}^{p^*}(G)}.
$$

We conclude that

(6.15) 
$$
((\nabla_{p^*})^*\tilde{M}_f - M_f(\nabla_{p^*})^*)(h) = J^*M_{\nabla f}(h), \quad h \in C_c^{\infty}(G) \otimes \ell_m^p.
$$

The two non-zero components of the commutator are bounded linear operators on  $C_c^{\infty}(G)$  and on  $C_c^{\infty}(G) \otimes \ell_m^p$ . We deduce that  $[\psi_p, \pi(f)]$  is bounded on the core  $(C_c^{\infty}(G) \oplus \ell_m^p) \otimes C_c^{\infty}(G)$  of the unbounded operator  $\mathcal{D}_p$  (here we use Lemma [6.3\)](#page-22-4). By [\[7,](#page-35-3) Proposition 26.5], this operator extends to a bounded operator on the Banach space  $L^p(G) \oplus_p L^p(G, \ell_m^p)$ . Hence  $C_c^{\infty}(G)$  is a subset of  $\mathrm{Lip}_{\not{D}_p}(\mathrm{L}^{\infty}(G)).$ 

If  $(g, h) \in \text{dom } \mathcal{D}_p$  and  $f \in C_c^{\infty}(G)$ , we have in addition

$$
\|M_{\nabla f}J\|_{L^{p}(G)\to\ell_{m}^{p}(L^{p}(G))} = \sup_{\|g\|_{L^{p}(G)}=1} \|M_{\nabla(f)}J(g)\|_{\ell_{m}^{p}(L^{p}(G))}
$$
\n
$$
= \sup_{\|g\|_{L^{p}(G)}=1} \| (X_{1,p}(f)g,\ldots,X_{m,p}(f)g)\|_{\ell_{m}^{p}(L^{p}(G))}
$$
\n
$$
= \sup_{\|g\|_{L^{p}(G)}=1} \| (X_{1,p}(f)g,\ldots,X_{m,p}(f)g)\|_{L^{p}(G,\ell_{m}^{p})}
$$
\n
$$
= \sup_{\|g\|_{L^{p}(G)}=1} \left( \int_{G} |(X_{1,p}f)(s)g(s)|^{p}+\cdots+|(X_{m,p}f)(s)g(s)|^{p}d\mu_{G}(s) \right)^{\frac{1}{p}}
$$
\n
$$
= \sup_{\|g\|_{L^{p}(G)}=1} \left( \int_{G} |[(X_{1,p}f)(s)|^{p}+\cdots+|(X_{m,p}f)(s)|^{p}]g(s)|^{p}d\mu_{G}(s) \right)^{\frac{1}{p}}
$$
\n
$$
= \sup_{\|h\|_{L^{1}(G)}=1, h\geq 0} \left( \int_{G} |[(X_{1,p}f)(s)|^{p}+\cdots+|(X_{m,p}f)(s)|^{p}]h(s)d\mu_{G}(s) \right)^{\frac{1}{p}}
$$
\n
$$
= \left( \sup_{\|h\|_{L^{1}(G)}=1, h\geq 0} \left\langle ||\nabla f||_{\ell_{m}^{p}}^{p}, h \right\rangle_{L^{\infty}(G), L^{1}(G)} \right)^{\frac{1}{p}}
$$
\n
$$
= \left( ||\nabla f||_{\ell_{m}^{p}}^{p} \right|_{L^{\infty}(G)}^{\frac{1}{p}} = ||\nabla f||_{L^{\infty}(G,\ell_{m}^{p})}.
$$

<span id="page-25-2"></span>By duality, the second non-null entry of the commutator has the same norm. So we have proved [\(6.12\)](#page-23-1) in the case where  $f \in C_c^{\infty}(G)$ .

Let  $f \in \text{dom}\,\nabla_{\infty}$ . Since  $C_c^{\infty}(G)$  is a weak<sup>\*</sup> core of the operator  $\nabla_{\infty}$ , we can consider a net  $(f_j)$  in  $C_c^{\infty}(G)$  such that  $f_j \to f$  and  $\nabla_{\infty}(f_j) \to \nabla_{\infty}(f)$  both for the weak\* topology of L<sup>∞</sup>(*G*). By [\[7,](#page-35-3) Lemma 1.6], we can suppose that the nets  $(f_j)$  and  $(\nabla_\infty(f_j))$  are bounded. By [\[7,](#page-35-3) Proposition 5.11 4.], we deduce that  $f \in \text{Lip}_{\mathcal{P}_p}(\text{L}^{\infty}(G))$ . By continuity of  $\pi$ , note that  $\pi(f_j) \to \pi(f)$  for the weak operator topology. For any  $\xi \in \text{dom }\mathcal{D}_p$  and any  $\zeta \in \text{dom}(\mathcal{D}_p)^*$ , we have

$$
\langle [\vec{p}_p, \pi(f_j)]\xi, \zeta \rangle_{\mathcal{L}^p(G)\oplus_p \mathcal{L}^p(G,\ell^p_m), \mathcal{L}^{p^*}(G)\oplus_{p^*} \mathcal{L}^{p^*}(G,\ell^p_m)} = \langle (\vec{p}_p \pi(f_j) - \pi(f_j)\vec{p}_p)\xi, \zeta \rangle
$$
  
\n
$$
= \langle \vec{p}_p \pi(f_j)\xi, \zeta \rangle - \langle \pi(f_j)\vec{p}_p \xi, \zeta \rangle = \langle \pi(f_j)\xi, (\vec{p}_p)^*\zeta \rangle - \langle \pi(f_j)\vec{p}_p \xi, \zeta \rangle
$$
  
\n
$$
\rightarrow \langle \pi(f)\xi, (\vec{p}_p)^*\zeta \rangle - \langle \pi(f)\vec{p}_p \xi, \zeta \rangle = \langle [\vec{p}_p, \pi(f)]\xi, \zeta \rangle.
$$

The net  $([\mathcal{D}_p, \pi(f_j)])$  is bounded since

$$
\left\| \left[ \not{\! \! D}_p, \pi(f_j) \right] \right\|_{p \to p} \stackrel{(6.12)}{=} \left\| \nabla_\infty(f_j) \right\|_{\mathcal{L}^\infty(G, \ell^p_m)} \lesssim_{m,p} \left\| \nabla_\infty(f_j) \right\|_{\mathcal{L}^\infty(G, \ell^\infty_m)} \lesssim 1.
$$

We deduce that the net  $([\mathcal{D}_p, \pi(f_i)])$  converges to  $[\mathcal{D}_p, \pi(f)]$  for the weak operator topology by a "net version" of [\[53,](#page-37-6) Lemma 3.6 p. 151]. Furthermore, it is (really) easy to checkthat  $M_{\nabla_{\infty}(f_i)}J \to M_{\nabla_{\infty}(f)}J$  and  $-\mathbb{E} M_{\nabla_{\infty}(f_i)} \to -\mathbb{E} M_{\nabla_{\infty}(f)}$  both for the weak operator topology. Indeed, recall that the composition of operators is separately continuous for the weak operator topology. By uniqueness of the limit, we deduce that the commutator is given by the same formula that in the case of elements of  $C_c^{\infty}(G)$ . From here, we obtain [\(6.12\)](#page-23-1) as before.

<span id="page-25-1"></span>**Remark 6.5** The inclusion  $(6.11)$  is probably an equality. We leave this intriguing question open. We sketch an incomplete proof. Let *f* an element of  $\mathrm{Lip}_{p_p}(\mathrm{L}^{\infty}(G))$ . We consider a Dirac

net  $(\varphi_j)$  of functions of  $C^{\infty}(G)$ . For any *j*, we let  $f_j \stackrel{\text{def}}{=} \text{Reg}_j f$ . By an obvious "net version" of [\[32,](#page-36-18) 14.11.1], the net  $(f_j)$  converges to  $f$  in  $L^\infty(G)$  for the weak\* topology. The point is to prove that  $(\nabla_{\infty} f_j)$  is a bounded net. If it is true, using Banach-Alaoglu theorem, we can suppose that  $\nabla_{\infty}(f_i) \to g$  for the weak\* topology for some function  $g \in L^{\infty}(G)$ . Since the graph of the unbounded operator  $\nabla_{\infty}$  is weak\* closed, we would conclude that f belongs to the subspace dom  $\nabla_{\infty}$ .

For the proof of the boundedness of the net, the writing

$$
\|\nabla_{\infty} f_j\|_{\mathcal{L}^{\infty}(G,\ell_{m}^{\infty})} \approx_{m,p} \|\nabla_{\infty} f_j\|_{\mathcal{L}^{\infty}(G,\ell_{m}^p)} \stackrel{(6.12)}{=} \sup_{\|\xi\| \leqslant 1, \|\eta\| \leqslant 1} |\langle [\not\!{D}_p, \pi(f_j)]\xi, \eta \rangle|
$$

and maybe  $[32, (14.10.9)]$  could be useful.

<span id="page-25-0"></span>**Theorem 6.6** Let G be a compact connected Lie group equipped with a family  $(X_1, \ldots, X_m)$ *of left-invariant Hörmander vector fields and consider the normalized Haar measure*  $\mu_G$  *on*  $G$ *. The triple*  $(C(G), L^2(G) \oplus_2 L^2(G, \ell_m^2), \emptyset_2)$  *is a compact spectral triple.* 

*Proof* : Here, we use the notation  $\nabla \stackrel{\text{def}}{=} \nabla_2$ . On the Hilbert space  $(\text{Ker } \nabla^* \nabla)^{\perp} \oplus_2 (\text{Ker } \nabla \nabla^*)^{\perp}$ we have

(6.16) 
$$
|\psi_2|^{-1} = (\psi_2^2)^{-\frac{1}{2}} \stackrel{(6.8)}{=} \begin{bmatrix} \nabla^* \nabla & 0 \\ 0 & \nabla \nabla^* \end{bmatrix}^{-\frac{1}{2}} = \begin{bmatrix} (\nabla^* \nabla)^{-\frac{1}{2}} & 0 \\ 0 & (\nabla \nabla^*)^{-\frac{1}{2}} \end{bmatrix}.
$$

<span id="page-26-2"></span>By Theorem [2.1,](#page-4-5) we know that the operators  $\nabla^* \nabla |_{(\text{Ker }\nabla)^{\perp}}$  and  $\nabla \nabla^* |_{(\text{Ker }\nabla^*)^{\perp}}$  are unitarily equivalent. Moreover, we have

$$
(\text{Ker}\,\nabla)^{\perp} \stackrel{(2.5)}{=} \overline{\text{Ran}\,\nabla^*} \stackrel{(2.6)}{=} \overline{\text{Ran}\,\nabla^* \nabla} \stackrel{(2.5)}{=} (\text{Ker}\,\nabla^* \nabla)^{\perp}
$$

and

$$
(\operatorname{Ker} \nabla \nabla^*)^{\perp} \stackrel{(2.6)}{=} (\operatorname{Ker} \nabla^*)^{\perp}.
$$

Consequently  $(\nabla^*\nabla)^{-\frac{1}{2}}|_{(\text{Ker}\nabla^*\nabla)^{\perp}}$  and  $(\nabla\nabla^*)^{-\frac{1}{2}}|_{(\text{Ker}\nabla\nabla^*)^{\perp}}$  are also unitarily equivalent. By Proposition [4.5,](#page-13-4) the operator  $(\nabla^*\nabla)^{-\frac{1}{2}} = \Delta_2^{-\frac{1}{2}}$ :  $\overline{\text{Ran}\Delta_2} \to \overline{\text{Ran}\Delta_2}$  is compact (the square root does not change the compactness by [\[Nee22,](#page-38-18) Lemma 9.3]) on  $\overline{\text{Ran}\Delta_2} \stackrel{(2.5)}{=} (\text{Ker}\,\nabla^*\nabla)^\perp$  $\overline{\text{Ran}\Delta_2} \stackrel{(2.5)}{=} (\text{Ker}\,\nabla^*\nabla)^\perp$  $\overline{\text{Ran}\Delta_2} \stackrel{(2.5)}{=} (\text{Ker}\,\nabla^*\nabla)^\perp$ . Hence the operator  $(\nabla \nabla^*)^{-\frac{1}{2}}|_{(\text{Ker } \nabla \nabla^*)^{\perp}}$  is also compact. We conclude that the operator  $|\psi_2|^{-1}$  is compact.

**Remark 6.7** Recall that a compact spectral triple  $(A, H, \mathcal{D})$  is even if there exists a selfadjoint unitary operator  $\gamma: H \to H$  such that  $\gamma \not\!\! D = -\not\!\! D\gamma$  and  $\gamma \pi(a) = \pi(a)\gamma$  for any  $a \in A$ . Note that the spectral triple  $(C(G), L^2(G) \oplus_2 L^2(G, \ell_m^2), \emptyset)$  is even. Indeed, the Hodge-Dirac operator  $\not\!\!D_p$ anti-commutes with the involution

$$
\gamma_p \stackrel{\text{def}}{=} \begin{bmatrix} -\text{Id}_{\text{L}^p(G)} & 0\\ 0 & \text{Id}_{\text{L}^p(G,\ell_m^p)} \end{bmatrix} : \text{L}^p(G) \oplus_p \text{L}^p(G,\ell_m^p) \to \text{L}^p(G) \oplus_p \text{L}^p(G,\ell_m^p)
$$

(which is selfadjoint if  $p = 2$ ), since

$$
\begin{split} \n\mathcal{D}_{p}\gamma_{p} + \gamma_{p}\mathcal{D}_{p} & \stackrel{(6.6)}{=} \begin{bmatrix} 0 & (\nabla_{p^{*}})^{*} \\ \nabla_{p} & 0 \end{bmatrix} \begin{bmatrix} -\mathrm{Id} & 0 \\ 0 & \mathrm{Id} \end{bmatrix} + \begin{bmatrix} -\mathrm{Id} & 0 \\ 0 & \mathrm{Id} \end{bmatrix} \begin{bmatrix} 0 & (\nabla_{p^{*}})^{*} \\ \nabla_{p} & 0 \end{bmatrix} \\ \n& = \begin{bmatrix} 0 & (\nabla_{p^{*}})^{*} \\ -\nabla_{p} & 0 \end{bmatrix} + \begin{bmatrix} 0 & -(\nabla_{p^{*}})^{*} \\ \nabla_{p} & 0 \end{bmatrix} = 0. \n\end{split}
$$

Moreover, for any  $f \in L^{\infty}(G)$ , we have

$$
\gamma_p \pi(f) \stackrel{(6.10)}{=} \begin{bmatrix} -\mathrm{Id} & 0 \\ 0 & \mathrm{Id} \end{bmatrix} \begin{bmatrix} M_f & 0 \\ 0 & \tilde{M}_f \end{bmatrix} = \begin{bmatrix} -M_f & 0 \\ 0 & \tilde{M}_f \end{bmatrix} = \begin{bmatrix} M_f & 0 \\ 0 & \tilde{M}_f \end{bmatrix} \begin{bmatrix} -\mathrm{Id} & 0 \\ 0 & \mathrm{Id} \end{bmatrix} \stackrel{(6.10)}{=} \pi(f)\gamma_p.
$$

In the sequel, if  $1 \leq p < \infty$  and if *H* is a Hilbert space, we use the notation  $S^p(H)$  for the space of the compact operators  $T: H \to H$  such that  $||T||_{S^p(H)} \stackrel{\text{def}}{=} (\text{Tr}|T|^p)^{\frac{1}{p}} < \infty$ . Moreover, recall that the local dimension  $d$  of  $(G, X)$  is defined in  $(3.7)$ .

<span id="page-26-1"></span>**Proposition 6.8** *Assume that G is compact.* If  $\alpha > d$ *, the operator*  $|\n\psi|^{-\alpha}$  *is trace-class.* 

*Proof* : We consider the canonical projection  $Q: L^2(G) \to L^2(G)$  on  $L^2_0(G)$ . We have  $Q = \text{Id} - \mathbb{E}$ where the conditional expectation  $\mathbb E$  is defined in Section [2](#page-3-0) by  $\mathbb E(f) = (\int_G f) 1$ . For any  $t > 0$ and any function  $f \in L^2(G)$ , we have

$$
T_t Q f = T_t (\text{Id} - \mathbb{E}) f = T_t f - T_t \mathbb{E} f = K_t * f - \int_G f.
$$

For almost all  $s \in G$ , we infer that using the translation invariance of the Haar measure

$$
T_t Q f(s) \stackrel{(6.17)}{=} (K_t * f)(s) - \int_G f \stackrel{(3.1)}{=} \int_G K_t(r) f(r^{-1} s) d\mu_G(r) - \int_G f(r) d\mu_G(r)
$$
  
= 
$$
\int_G [K_t(r) - 1] f(r^{-1} s) d\mu_G(r).
$$

<span id="page-27-3"></span>We conclude that  $T_tQ: L^2(G) \to L^2(G)$  is a convolution operator by the function  $K_t - 1$ . For any  $t > 0$ , we have using [\[51,](#page-37-7) Exercise 2.8.38 (ii) p. 170]

$$
||T_t||_{S^1(L_0^2(G))} = ||T_{\frac{t}{2}}^2||_{S^1(L_0^2(G))} = ||T_{\frac{t}{2}}||_{S^2(L_0^2(G))}^2 = ||T_{\frac{t}{2}}Q||_{S^2(L^2(G))}^2
$$

$$
= ||K_{\frac{t}{2}} - 1||_{L^2(G)}^2 = \int_G |(K_{\frac{t}{2}} - 1)(r)|^2 d\mu_G(r)
$$

(for the third equality, consider an orthonormal basis  $(e_i)_{i \in I}$  of the Hilbert space  $L^2(G)$  adapted to the closed subspace  $\mathrm{L}^2_0(G)$  and use the equality  $||T||_{S^2(\mathrm{L}^2(G))} = \left(\sum_{i\in I} ||T(e_i)||^2_{\mathrm{L}^2(G)}\right)^{\frac{1}{2}}$ . Now, by translation invariance of the Haar measure and Dunford-Pettis theorem, we obtain

$$
||T_t||_{S^1(L^2_0(G))} = \underset{s \in G}{\text{esssup}} \int_G |(K_{\frac{t}{2}} - 1)(sr^{-1})|^2 d\mu_G(r)
$$
  

$$
\stackrel{(2.3)}{=} ||T_{\frac{t}{2}}Q||^2_{L^2(G) \to L^\infty(G)} = ||T_{\frac{t}{2}}||^2_{L^2(G) \to L^\infty(G)}.
$$

By interpolation, we have by  $(2.11)$  combinated with  $(4.10)$  the estimate

$$
||T_{\frac{t}{2}}||_{\mathcal{L}^2_0(G)\to \mathcal{L}^\infty(G)} \lesssim \frac{1}{t^{\frac{d}{4}}}, \quad 0 < t \leqslant 1.
$$

We infer that

(6.19) 
$$
||T_t||_{S^1(L_0^2(G))} \lesssim \frac{1}{t^{\frac{d}{2}}}, \quad 0 < t \leq 1.
$$

Now, if  $t \geq 1$ , we have since G is compact

<span id="page-27-2"></span>
$$
||T_t||_{S^1(L^2_0(G))} \stackrel{(6.18)}{=} ||K_{\frac{t}{2}} - 1||^2_{L^2(G)} \le ||K_{\frac{t}{2}} - 1||^2_{L^{\infty}(G)}
$$
  

$$
\stackrel{(2.2)}{=} ||T_{\frac{t}{2}}Q||^2_{L^1(G) \to L^{\infty}(G)} = ||T_{\frac{t}{2}}||^2_{L^1_0(G) \to L^{\infty}(G)}.
$$

With the estimate [\(4.14\)](#page-14-1), we conclude that

(6.20) 
$$
||T_t||_{S^1(L^2_0(G))} \lesssim e^{-2\omega t}, \quad t \ge 1.
$$

Observe that the map is  $\mathbb{R}^+ \mapsto B(L^2(G))$ ,  $t \mapsto T_t$  is strong operator continuous hence weak operator continuous. Moreover, if  $\alpha > d$ , we have

$$
\int_0^\infty t^{\frac{\alpha}{2}-1} \|T_t\|_{S^1(L_0^2(G))} dt = \int_0^1 t^{\frac{\alpha}{2}-1} \|T_t\|_{S^1(L_0^2(G))} dt + \int_1^\infty t^{\frac{\alpha}{2}-1} \|T_t\|_{S^1(L_0^2(G))} dt
$$
  
\n
$$
\stackrel{(6.19)}{=} \int_0^1 t^{\frac{\alpha}{2}-1-\frac{d}{2}} dt + \int_1^\infty t^{\frac{\alpha}{2}-1} e^{-2\omega t} dt < \infty.
$$

By [\[82,](#page-38-19) Lemma 2.3.2], we deduce that the operator  $\int_0^\infty t^{\frac{\alpha}{2}-1} T_t dt$  acting on the Hilbert space  $L_0^2(G)$  is well-defined and trace-class. Furthermore, we have  $||T_t||_{L_0^2(G) \to L_0^2(G)}$  $\lesssim$ <sup>6.20</sup>)<sup></sup> e<sup>-2ωt</sup> if  $t \geq 1$ , that means that  $(T_t)_{t \geq 0}$  is an exponentially stable semigroup on  $L_0^2(G)$ . Consequently, we know by  $[48, Corollary 3.3.6]$  that

$$
\Delta^{-\frac{\alpha}{2}} = \frac{1}{\Gamma(\frac{\alpha}{2})} \int_0^{\infty} t^{\frac{\alpha}{2} - 1} T_t dt.
$$

<span id="page-28-3"></span>We obtain that if  $\alpha > d$  then the operator  $\Delta^{-\frac{\alpha}{2}}$  is trace-class. The operator  $(\nabla \nabla^*)^{-\alpha}$  is also trace-class since unitarily equivalent to  $\Delta^{-\frac{\alpha}{2}}$  as observed in the proof of Theorem [6.6.](#page-25-0) Finally, note that

(6.21) 
$$
|\psi_2|^{-\alpha} \stackrel{(6.8)}{=} \begin{bmatrix} \Delta_2^{-\frac{\alpha}{2}} & 0\\ 0 & (\nabla \nabla^*)^{-\frac{\alpha}{2}} \end{bmatrix}.
$$

We conclude that the operator  $|\psi_2|^{-\alpha}$  is trace-class if  $\alpha > d$ .

**Theorem 6.9** *Assume that G is compact. The spectral dimension* [\(6.2\)](#page-21-2) *of the spectral triple*  $(C(G), L^2(G) \oplus_2 L^2(G, \ell_m^2), \emptyset_2)$  *is equal to the local dimension d of*  $(G, X)$ *.* 

П

 $\Box$ 

*Proof* : Note Proposition [6.8.](#page-26-1) Now, suppose that the operator  $|\mathcal{D}|^{-\alpha}$  is trace-class. By Lemma [6.2,](#page-21-3) we have Tr e<sup> $-t\psi^2 \leq \frac{1}{\sqrt{2}}$ </sup>  $\frac{1}{t^{\frac{\alpha}{2}}}$  for any  $t > 0$ . Using [\[33,](#page-36-15) Proposition II.3.1 p. 20], the relation  $K_t = \check{K}_t$  in the second equality, [\[51,](#page-37-7) Exercise 2.8.38 (ii) p. 170] in the fourth equality, the selfadjointness of  $T_t$  and finally  $(6.8)$  in the last inequality, we deduce that

$$
K_t(e) = \int_G K_{\frac{t}{2}}(r) K_{\frac{t}{2}}(r^{-1}) d\mu_G(r) = \int_G K_{\frac{t}{2}}^2 = ||K_{\frac{t}{2}}||_{\mathcal{L}^2(G)}^2 = ||T_{\frac{t}{2}}||_{S^2(\mathcal{L}^2(G))}^2
$$
  
=  $||T_{\frac{t}{2}}^2||_{S^1(\mathcal{L}^2(G))} = ||T_t||_{S^1(\mathcal{L}^2(G))} = \text{Tr } T_t = \text{Tr } e^{-t\Delta_2} \leq \frac{1}{t^{\frac{N}{2}}}.$ 

By  $[84, (3)$  p. 113] (see also  $[33, p. 174]$  for a more general statement for selfadjoint subelliptic operators), we have

$$
\frac{1}{t^{\frac{d}{2}}} \stackrel{(3.7)}{\approx} \frac{1}{V(\sqrt{t})} \lesssim K_t(e), \quad 0 < t \leq 1.
$$

We conclude that  $\frac{1}{t^{\frac{d}{2}}} \lesssim \frac{1}{t^{\frac{\alpha}{2}}}$  for any  $0 < t \leq 1$  and consequently  $\alpha \geq d$ .

# <span id="page-28-0"></span>**7** Some remarks on Carnot-Carathéodory distances

Let *G* be a connected unimodular Lie group equipped with a family  $(X_1, \ldots, X_m)$  of left-invariant Hörmander vector fields. In this section, we will show in Theorem [7.4](#page-31-0) that the Connes spectral pseudo-distance associated to our Hodge-Dirac operator allows us to recover the Carnot-Carathéodory distance. If  $(A, Y, \mathcal{D})$  is a triple as that precedes [\(6.1\)](#page-20-1), recall that it is defined by

<span id="page-28-1"></span>(7.1) 
$$
\operatorname{dist}_{\not{D}}(\varphi, \psi) \stackrel{\text{def}}{=} \sup \left\{ |\varphi(a) - \psi(a)| : a \in \operatorname{Lip}_{\not{D}}(A) \text{ and } \left\| [\not{D}, \pi(a)] \right\| \leq 1 \right\}
$$

where  $\varphi$  and  $\psi$  are two states of the algebra *A* and where  $\text{Lip}_{p}(A)$  is defined in [\(6.1\)](#page-20-1). The term pseudo-metric is used since  $dist(\varphi, \psi)$  is not necessarily finite. In general,  $Lip_{\mathcal{D}}(A)$  is unknown and we replace this space by a dense subset of  $A$  (or a weak<sup>\*</sup> dense subset if  $\overline{A}$  is a dual space) which is contained in  $\text{Lip}_{\phi}(A)$ . See the papers [\[60\]](#page-38-20), [\[70\]](#page-38-21) and [\[73\]](#page-38-22) for more information.

In [\[76,](#page-38-8) Lemma 2.3 p. 265] and [\[33,](#page-36-15) p. 24], the following formula is stated for the Carnot-Carathéodory distance, i.e. the case  $p = 2$  of [\(3.3\)](#page-6-2). For any  $s, s' \in G$ , it is written that

<span id="page-28-2"></span>(7.2) 
$$
\text{dist}_{\text{CC}}(s,s') \stackrel{\text{def}}{=} \sup \left\{ |f(s) - f(s')| : f \in \text{C}_c^{\infty}(G), \|\nabla f\|_{\text{L}^{\infty}(G,\ell_m^2)} \leq 1 \right\}.
$$

We will see that this formula is strongly related to the distance  $(7.1)$  in our setting. Unfortunately, we are unable to understand the sketched proof. The writings "Therefore" and "by <span id="page-29-2"></span>a slight modification of the  $\psi_n$  one can arrange" of [\[76,](#page-38-8) Lemma 2.3 p. 265] are obscure for us. Moreover, the same reference [\[33,](#page-36-15) p. 24] says without proof that we can replace the space  $C_c^{\infty}(G)$  by the subspace  $C_c^{\infty}(G,\mathbb{R})$  of real-valued compactly supported continuous functions in this formula.

Indeed, we can use the following elementary argument. We fix  $s, s' \in G$ . We write  $f(s)$  −  $f(s') = |f(s) - f(s')|e^{i\theta}$  for some  $\theta \in \mathbb{R}$ . We consider the real-valued function  $\tilde{f} \stackrel{\text{def}}{=} \frac{1}{2}[f e^{-i\theta} +$  $\overline{f}e^{i\theta}$ . We have

$$
\left\|\nabla \tilde{f}\right\|_{\mathcal{L}^{\infty}\left(G,\ell_{m}^{2}\right)}=\frac{1}{2}\left\|e^{-i\theta}\nabla(f)+e^{-i\theta}\nabla(f)\right\|_{\mathcal{L}^{\infty}\left(G,\ell_{m}^{2}\right)}\leqslant\left\|\nabla f\right\|_{\mathcal{L}^{\infty}\left(G,\ell_{m}^{2}\right)}
$$

and

$$
|\tilde{f}(s) - \tilde{f}(s')| = \frac{1}{2} |f(s)e^{-i\theta} + \overline{f}(s)e^{i\theta} - f(s')e^{-i\theta} - \overline{f}(s')e^{i\theta}|
$$
  
= 
$$
\frac{1}{2} |e^{-i\theta}[f(s) - f(s')] + e^{i\theta}[\overline{f}(s) - \overline{f}(s')]|
$$
  
= 
$$
\frac{1}{2} ||f(s) - f(s')| + |\overline{f(s) - f(s')}| = |f(s) - f(s')|.
$$

<span id="page-29-0"></span>Now, we introduce the following definition.

**Definition 7.1** *Suppose*  $1 < p < \infty$ *. Let*  $f: G \to \mathbb{C}$  *be a function. The number* 

(7.3) 
$$
\operatorname{Lip}_{\mathrm{CC}}^p(f) \stackrel{\text{def}}{=} \sup \left\{ \frac{|f(s) - f(s')|}{\operatorname{dist}_{\mathrm{CC}}^p(s, s')} : s, s' \in G, s \neq s' \right\}
$$

 $of [0, \infty]$  *is called the p-Carnot-Carathéodory-Lipschitz constant of*  $f$ *. If*  $Lip_{CC}^p(f)$  *is finite, we call f a p-Carnot-Carath´eodory-Lipschitz function.*

In [\[9,](#page-36-16) Proposition 2.5 (i)], it is stated that the domain dom  $\nabla_{\infty}$  is the space of the equivalence classes of *bounded* 2-Carnot-Carath´eodory-Lipschitz function on *G*. Here, we complete this fact and we give a variant of [\[9,](#page-36-16) Proposition 2.5].

<span id="page-29-1"></span>**Lemma 7.2** *Suppose*  $1 < p < \infty$ *. Then an essentially bounded function*  $f: G \to \mathbb{C}$  *is a p*-*Carnot-Carath´eodory-Lipschitz function if and only if its equivalence class belongs to the space* dom ∇∞*. In this case, we have*

$$
\operatorname{Lip}^p_{\mathcal{CC}}(f) = \|\nabla f\|_{\mathcal{L}^\infty(G, \ell^{p^*})}.
$$

*Proof* : Suppose that  $f \in C_c^{\infty}(G)$ . Let  $s, s' \in G$  and let  $\gamma: [0,1] \mapsto G$  be an absolutely continuous path from *s* to *s* ′ . We have

$$
f(s) - f(s') = f(\gamma(0)) - f(\gamma(1)) = -\int_0^1 \frac{d}{dt} f(\gamma(t)) dt \stackrel{(3.4)}{=} -\int_0^1 \sum_{k=1}^m \dot{\gamma}_k(t) (X_k f)(\gamma(t)) dt.
$$

Consequently, using Hölder's inequality, we obtain

$$
\begin{aligned} \left| f(s) - f(s') \right| &\leq \int_0^1 \left| \sum_{k=1}^m \dot{\gamma}_k(t) (X_k f)(\gamma(t)) \right| \mathrm{d}t \\ &\leq \int_0^1 \left( \sum_{k=1}^m |\dot{\gamma}_k(t)|^p \right)^{\frac{1}{p}} \left( \sum_{k=1}^m \left| (X_k f)(\gamma(t)) \right|^{p^*} \right)^{\frac{1}{p^*}} \mathrm{d}t. \end{aligned}
$$

<span id="page-30-3"></span>We deduce that

$$
\left|f(s) - f(s')\right| \leq \int_0^1 \left(\sum_{k=1}^m |\dot{\gamma}_k(t)|^p\right)^{\frac{1}{p}} dt \left\| (X_1 f, \dots, X_m f)\right\|_{\mathcal{L}^\infty(G, \ell_m^{p^*})} \stackrel{(3.2)}{=} \left\| \nabla f \right\|_{\mathcal{L}^\infty(G, \ell_m^{p^*})} \ell_p(\gamma).
$$

Passing to the infimum, we obtain  $|f(s) - f(s')| \leq ||\nabla f||_{L^{\infty}(G, \ell_{m}^{p^*})} \operatorname{dist}_{CC}^p(s, s')$  by [\(3.3\)](#page-6-2). Consequently, we have the inequality  $\text{Lip}_{\text{CC}}^p(f) \leq \|\nabla f\|_{\text{L}^\infty(G,\ell_n^{p^*})}$ . We conclude with a regularization argument for the general case of a function *f* of dom  $\widetilde{\nabla}_{\infty}$ .

Now, we prove the reverse inequality. Suppose that  $f: G \to \mathbb{C}$  is a *p*-Carnot-Carathéodory-Lipschitz function. Let  $\xi \in \ell_m^p$  with  $\|\xi\|_{\ell_m^p} = 1$ . For any  $1 \leq k \leq m$ , we put  $a_k \stackrel{\text{def}}{=} X_k(e)$ . Consider some  $s_0 \in G$  and the path

(7.4) 
$$
\gamma(t) \stackrel{\text{def}}{=} s_0 \exp\left(t \sum_{k=1}^m \xi_k a_k\right), \quad t \in \mathbb{R}.
$$

By [\[31,](#page-36-21) (19.8.11)], for any  $t \in \mathbb{R}$  we have

<span id="page-30-0"></span>(7.5) 
$$
\dot{\gamma}(t) = \sum_{k=1}^{m} \xi_k X_k(\gamma(t)).
$$

We infer that  $\dot{\gamma}(t)$  belongs to the subspace span $\{X_1|_{\gamma(t)},\ldots,X_m|_{\gamma(t)}\}$  for all  $t \in \mathbb{R}$ . Moreover, the *p*-length of the restriction  $\gamma$ [*c, d*] is given by

<span id="page-30-1"></span>
$$
\ell_p(\gamma|[c,d]) \stackrel{(3.2)}{=} \int_c^d \left(\sum_{k=1}^m |\dot{\gamma}_k(t)|^p\right)^{\frac{1}{p}} dt \stackrel{(7.5)}{=} \int_c^d ||\xi||_{\ell_m^p} dt = |c-d| ||\xi||_{\ell_m^p} = |c-d|.
$$

By [\(3.3\)](#page-6-2), we deduce that

(7.6) 
$$
\text{dist}_{\text{CC}}^p(\gamma(c), \gamma(d)) \leq |d - c|.
$$

We consider the function  $g: \mathbb{R} \to \mathbb{R}$ ,  $t \mapsto f(\gamma(t))$ . Since f is a *p*-Carnot-Carathéodory-Lipschitz function, we have

$$
|g(c) - g(d)| = |f(\gamma(c)) - f(\gamma(d))| \le \mathrm{Lip}_{\mathrm{CC}}^p(f) \mathrm{dist}_{\mathrm{CC}}^p(\gamma(c), \gamma(d)) \stackrel{(7.6)}{\le} \mathrm{Lip}_{\mathrm{CC}}^p(f)|d - c|.
$$

Hence the function  $q$  is a Lipschitz function on  $\mathbb{R}$ , hence differentiable almost everywhere. It is left to the reader to show that  $X_j f$  exists almost everywhere on  $G$ .

If  $t > 0$ , using the notation  $s_t \stackrel{\text{def}}{=} \exp(t \sum_{k=1}^m \xi_k a_k)$  we deduce that

<span id="page-30-2"></span>
$$
\text{Lip}_{\text{CC}}^p(f) \stackrel{(7.3)}{\geq} \frac{|f(\gamma(t)) - f(s_0)|}{\text{dist}_{\text{CC}}^p(\gamma(t), s_0)} \stackrel{(7.6)}{\geq} \frac{|f(\gamma(t)) - f(s_0)|}{t} = \left| \frac{1}{t} \left( (\rho_{s_t} - \text{Id})f \right)(s_0) \right|
$$

where  $\rho$  is the right regular representation of *G*. Consequently, for any  $t > 0$  we obtain

(7.7) 
$$
\left\| \frac{1}{t} (\rho_{s_t} - \mathrm{Id}) f \right\|_{\mathrm{L}^{\infty}(G)} \leqslant \mathrm{Lip}_{\mathrm{CC}}^p(f).
$$

Now,  $\left| \frac{1}{t} \left( (\rho_{s_t} - \text{Id}) f \right) (s_0) \right| = \frac{|f(\gamma(t)) - f(s_0)|}{t}$  converges almost everywhere when  $t \to 0$ . Using dominated convergence theorem, we conclude that  $\frac{1}{t}(\rho_{s_t} - \text{Id})f$  converges in  $L^{\infty}(G)$  for the weak\* topology.

<span id="page-31-2"></span>Using [\[33,](#page-36-15) p. 14], we infer that the class of *f* belongs to dom  $\nabla_{\infty}$  and that  $\frac{1}{t}((\rho_{s_t} - \text{Id})f \rightarrow$ <br> *m*  $\in$  *Y*  $f$  when  $t \rightarrow 0$  for the weals\* topology of  $I \propto (C)$  where *Y* is the wight invertion  $\sum_{k=1}^{m} \xi_k Y_{k,\infty} f$  when  $t \to 0$  for the weak\* topology of  $L^{\infty}(G)$  where  $Y_k$  is the right invariant vector field associated to the element  $a_k$ . Passing to the limit in [\(7.7\)](#page-30-2) when  $t \to 0$ , using the weak\* lower semicontinuity of the norm  $[65, Th 2.6.14 p. 227]$ , we obtain

$$
\left\| \sum_{k=1}^m \xi_k Y_{k,\infty} f \right\|_{\mathcal{L}^\infty(G)} \leqslant \mathrm{Lip}_{\mathrm{CC}}^p(f).
$$

Since G is unimodular, we have  $\|\sum_{k=1}^m \xi_k X_{k,\infty} f\|_{L^\infty(G)} = \|\sum_{k=1}^m \xi_k Y_{k,\infty} f\|_{L^\infty(G)}$  (if  $I: G \to G$ ,  $s \mapsto s^{-1}$  is the inversion map and  $I_*$  its associated push-forward map on vector fields, we have  $I_* X_k = -Y_k$ . We conclude by duality that

$$
\|\nabla f\|_{\mathcal{L}^{\infty}(G,\ell_{m}^{p^*})} = \|(X_1f,\ldots,X_mf)\|_{\mathcal{L}^{\infty}(G,\ell_{m}^{p^*})} \leqslant \mathrm{Lip}_{\mathrm{CC}}^p(f).
$$

<span id="page-31-1"></span>**Lemma 7.3** *Suppose*  $1 < p < \infty$ *. For any*  $s, s' \in G$ *, we have* 

$$
\text{dist}_{\text{CC}}^p(s, s') = \sup \big\{ |f(s) - f(s')| : f \in \text{dom}\,\nabla_\infty, \text{Lip}_{\text{CC}}^p(f) \leq 1 \big\}.
$$

*Moreover, we can replace by* dom  $\nabla_{\infty}$  *by the space*  $C_c^{\infty}(G)$ *.* 

*Proof* : Let  $f \in \text{dom } \nabla_{\infty}$  with  $\text{Lip}_{\text{CC}}^p(f) \leq 1$ . For any  $s, s' \in G$ , we have by definition

$$
|f(s) - f(s')| \leqslant \mathrm{Lip}_{\mathrm{CC}}^p(f) \cdot \mathrm{dist}_{\mathrm{CC}}^p(s, s') \leqslant \mathrm{dist}_{\mathrm{CC}}^p(s, s').
$$

We deduce that  $\sup\{|f(s) - f(s')| : f \in \text{dom}\,\nabla_{\infty}, \text{Lip}_{CC}^p(f) \leq 1\} \leq \text{dist}_{CC}^p(s, s').$  Now, we prove the reverse inequality. We fix  $s \in G$ . We consider the function  $h: G \to \mathbb{R}$ ,  $s' \mapsto$  $dist_{\text{CC}}^p(s, s')$ . Since  $dist_{\text{CC}}^p$  is a distance on *G* we have for any  $s'' \in G$ 

$$
|h(s')-h(s'')| = |{\rm dist}_{\rm CC}^p(s,s')-{\rm dist}_{\rm CC}^p(s,s'')|\leqslant {\rm dist}_{\rm CC}^p(s',s'').
$$

We infer that that  $h$  is  $p$ -Carnot-Carath $\acute{e}$ odory-Lipschitz function (hence its class belongs to dom  $\nabla_{\infty}$  by Lemma [7.2\)](#page-29-1) with  $\text{Lip}_{\text{CC}}^p(h) \leq 1$ . Since  $|h(s) - h(s')| = \text{dist}_{\text{CC}}^p(s, s')$  we obtain

$$
\text{dist}_{\text{CC}}^p(s, s') \leqslant \sup \left\{ |f(s) - f(s')| : f \in \text{dom}\,\nabla_\infty, \text{Lip}_{\text{CC}}^p(f) \leqslant 1 \right\}.
$$

For the last assertion, we use a regularization argument. We consider a Dirac net  $(\varphi_i)$  of functions of  $C^{\infty}(G)$  satisfying in particular  $\int_G \varphi_j d\mu_G = 1$ . For any *j* we let  $f_j \stackrel{\text{def}}{=} \varphi_j * f$ . Using the left-invariance of the distance  $dist_{CC}^p$  in the third equality, we have

$$
\begin{split} \operatorname{Lip}^p_{\mathrm{CC}}(f_j) & \stackrel{(7.3)}{=} \sup_{s \neq s'} \left| \frac{f_j(s) - f_j(s')}{\operatorname{dist}^p_{\mathrm{CC}}(s, s')} \right| \stackrel{(3.1)}{=} \sup_{s \neq s'} \left| \int_G \frac{f(t^{-1}s)\varphi_j(t) - f(t^{-1}s')\varphi_j(t)}{\operatorname{dist}^p_{\mathrm{CC}}(s, s')} \, \mathrm{d}\mu_G(t) \right| \\ &= \sup_{s \neq s'} \left| \int_G \frac{f(t^{-1}s) - f(t^{-1}s')}{\operatorname{dist}^p_{\mathrm{CC}}(t^{-1}s, t^{-1}s')} \varphi_j(t) \, \mathrm{d}\mu_G(t) \right| \leq \int_G \operatorname{Lip}^p_{\mathrm{CC}}(f) \varphi_j(t) \, \mathrm{d}\mu_G(t) \\ &= \operatorname{Lip}^p_{\mathrm{CC}}(f) \int_G \varphi_j(t) \, \mathrm{d}\mu_G(t) \leqslant \operatorname{Lip}^p_{\mathrm{CC}}(f). \end{split}
$$

Since f is left uniformly continuous, the net  $(f_i)$  converges uniformly by [\[41,](#page-37-19) Proposition 2.44 p. 58] to *f*. The conclusion is obvious.

<span id="page-31-0"></span>With the terminology of [\[60,](#page-38-20) Definition 1.8], we can interpret the end of the following result by saying that  $(C(G), L^2(G) \oplus_2 L^2(G, \ell_m^2), \mathcal{D}_2)$  is a metric spectral triple.

<span id="page-32-1"></span>**Theorem 7.4** Let G be a connected unimodular Lie group equipped with a family  $(X_1, \ldots, X_m)$ *of left-invariant Hörmander vector fields. Suppose*  $1 < p < \infty$ *. For any*  $s, s' \in G$ *, we have* 

<span id="page-32-0"></span>
$$
\text{dist}_{\text{CC}}^p(s, s') = \sup \left\{ |f(s) - f(s')| : f \in \text{dom}\,\nabla_{\infty}, \|\nabla f\|_{\text{L}^{\infty}(G, \ell_m^{p^*})} \leq 1 \right\}
$$
\n
$$
(7.8) \qquad = \sup \left\{ |f(s) - f(s')| : f \in \text{dom}\,\nabla_{\infty}, \left\| \left[ \not{D}_{p^*}, \pi(f) \right] \right\|_{p^* \to p^*} \leq 1 \right\}.
$$

*Moreover, we can replace by* dom  $\nabla_{\infty}$  *by the space*  $C_c^{\infty}(G)$ *. c*

*Finally, if G is in addition compact, letting*  $||f||_{p_p} \stackrel{\text{def}}{=} ||[D_p, \pi(f)]||_{p \to p}$  *for any*  $f \in \text{dom } \nabla_{\infty}$ *, then the pair*  $(C(G), \|\cdot\|_{\mathcal{D}_p})$  *is a Leibniz quantum compact metric space.* 

*Proof* : Combining Lemma [7.2](#page-29-1) and Lemma [7.3,](#page-31-1) we obtain the first equality. The second equality is a consequence of  $(6.12)$ .

Now, we prove the last sentence. By [\[7,](#page-35-3) Proposition 5.11 2.], note that  $\|\cdot\|_{\not\!\!D_p}$  is a seminorm on  $\text{Lip}_{\not{D}_p}(L^{\infty}(G))$ , hence on the subspace dom  $\nabla_{\infty}$ . We put dom  $\lVert \cdot \rVert_{\not{D}_p} \stackrel{\text{def}}{=} \text{dom}\,\nabla_{\infty}$  and  $A \stackrel{\text{def}}{=} C(G)$ . We check the properties of Proposition [4.3.](#page-12-2) Note that with a positive answer to the question raised in Remark [6.5,](#page-25-1) we could use [\[7,](#page-35-3) Proposition 5.11 3. and Remark 5.7] for some assertions.

1. The domain dom  $\|\cdot\|_{\not{D}_p} = \text{dom } \nabla_{\infty}$  is clearly closed under  $f \mapsto f$ .

2. Let  $f \in \text{dom } \nabla_{\infty}$  with  $\nabla_{\infty} f = 0$ . For any  $s \in G$ , we have

$$
\begin{aligned} \left\| (\mathrm{Id} - \lambda_s) f \right\|_{\mathrm{L}^p(G)} &\stackrel{(3.5)}{\leq} \mathrm{dist}_{\mathrm{CC}}^{p^*}(s, e) \bigg( \sum_{k=1}^m \|X_k f\|_{\mathrm{L}^p(G)}^p \bigg)^{\frac{1}{p}} \\ &\lesssim_{m, p} \mathrm{dist}_{\mathrm{CC}}^{p^*}(s, e) \left\| \nabla_\infty f \right\|_{\mathrm{L}^\infty(G, \ell_m^p)} = 0. \end{aligned}
$$

We deduce that the function f is constant on G. The converse is obvious. Hence we have the equality  $\{ f \in \text{dom } || \cdot ||_{\mathcal{D}_{p}} : ||f||_{\mathcal{D}_{p}} = 0 \} = \mathbb{C}1_{\mathcal{C}(G)}$ .

3. By [\[7,](#page-35-3) Proposition 5.11 1.], for any  $f, g \in \text{Lip}_{\mathcal{D}_p}(\text{L}^{\infty}(G))$  we have  $fg \in \text{Lip}_{\mathcal{D}_p}(\text{L}^{\infty}(G))$ and

$$
||fg||_{\mathcal{D}_p} \leq ||f||_{\mathcal{C}(G)} ||g||_{\mathcal{D}_p} + ||f||_{\mathcal{D}_p} ||g||_{\mathcal{C}(G)}.
$$

4. Let  $s_0 \in G$  be any point. The Dirac probability measure  $\delta_{s_0}$  is supported on the compact {*s*<sub>0</sub>}. So it is a local state. We consider the subset  $\{f \in \text{dom } \lVert \cdot \rVert_{\mathcal{D}_p} : \lVert f \rVert_{\mathcal{D}_p} \leq 1, f(s_0) = 0\}.$ By [\(7.8\)](#page-32-0) and Lemma [7.2,](#page-29-1) this subset is equicontinuous. Furthermore, it is pointwise bounded since ∗

$$
|f(s)| = |f(s) - f(s_0)| \leq \text{dist}_{\text{CC}}^{p^*}(s_0, s) \lesssim 1, \quad s \in G
$$

by continuity of the function  $s \mapsto \text{dist}_{CC}^{p^*}(s_0, s)$  on the compact *G*. By Arzèla-Ascoli theorem, we conclude that it is relatively compact in the space  $C(G)$ .

5. Suppose that the net  $(f_j)$  converges to  $f$  in the space  $L^{\infty}(G)$  and that  $||f_j||_{\mathcal{D}_p} \leq 1$ , that is  $\|\nabla f_j\|_{L^{\infty}(G,\ell_m^{p^*})} \leq 1$ . It converges for the weak\* topology. Consequently  $(\nabla_{\infty} f_j)$  is a bounded net of  $L^{\infty}(G,\ell_{m}^{p^*})$ . Using Banach-Alaoglu theorem, we can suppose that  $\nabla_{\infty} f_j \to g$  for the weak\* topology for some function  $g \in L^{\infty}(G, \ell_m^{p^*})$ . Since the graph of the unbounded operator  $\nabla_{\infty}$  is weak\* closed, we conclude that *f* belongs to the subspace dom  $\nabla_{\infty}$  and that  $g = \nabla_{\infty} f$ . The weak\* lower semicontinuity of the norm  $[65, Th 2.6.14 p. 227]$  reveals that

$$
\|\nabla_{\infty} f\|_{\mathcal{L}^{\infty}(G,\ell_m^{p^*})} \leq \liminf_j \|\nabla_{\infty} f_j\|_{\mathcal{L}^{\infty}(G,\ell_m^{p^*})} \leq 1.
$$

 $\blacksquare$ 

<span id="page-33-3"></span>**Remark 7.5** if *G* is a unimodular Lie group, it seems apparent that the seminorm  $\|\cdot\|_{\mathcal{D}_p}$  can be used to define quantum *locally* compact metric spaces in the spirit of the ones of Section [5.](#page-15-0) The proof is left to the reader as an exercise.

We finish the paper by connecting our setting to the vast topic of Dirichlet forms. We refer to the books  $[13]$ ,  $[42]$  and  $[62]$  for more information on Dirichlet forms and also to the papers [\[10\]](#page-36-23), [\[18\]](#page-36-24), [\[55\]](#page-37-21), [\[80\]](#page-38-24) and [\[81\]](#page-38-25) which are connected to our setting. Let  $\Omega$  be a connected second countable Hausdorff locally compact space and  $\mu$  be a positive Radon measure with support  $\Omega$ . We denote by  $\mathcal{M}(\Omega)$  the collection of all signed Radon measures on  $\Omega$ .

Recall that a Dirichlet form  $\mathcal{E}$  on  $L^2(\Omega)$  is a closed positive definite symmetric bilinear form defined on dom  $\mathcal{E} \times$  dom  $\mathcal{E}$  where dom  $\mathcal{E}$  is a dense linear subspace of the Hilbert space  $L^2(\Omega)$ .

Beurling and Deny showed that if  $\mathcal E$  has no killing measure and no jumping measure, it can be written as

<span id="page-33-1"></span>
$$
\mathcal{E}(f,g) = \int_{\Omega} d\Gamma(f,g), \quad f, g \in \text{dom}\,\mathcal{E}
$$

for a  $\mathcal{M}(\Omega)$ -valued positive definite symmetric bilinear form Γ defined by the formula

(7.9) 
$$
\int_{\Omega} h \, d\Gamma(f,g) \stackrel{\text{def}}{=} \frac{1}{2} \big[ \mathcal{E}(f,hg) + \mathcal{E}(g,hf) - \mathcal{E}(fg,h) \big]
$$

for all  $f, g \in \text{dom }\mathcal{E} \cap L^{\infty}(\Omega)$  and  $h \in \text{dom }\mathcal{E} \cap C_c(\Omega)$ . The form  $\Gamma$  is called the carré du champ associated to  $\mathcal{E}$ . The Radon-Nikodym derivative  $\frac{d\Gamma(f,f)}{d\mu}(x)$  plays (if it exists) the role of the square of the length of the gradient of  $f \in \text{dom } \mathcal{E}$  at  $x \in \Omega$ .

<span id="page-33-2"></span>An intrinsic pseudo-distance on *X* associated to  $\mathcal{E}$  is defined in [\[80,](#page-38-24) (4.1)] by

(7.10) 
$$
\text{dist}_{\mathcal{E}}(x, y) \stackrel{\text{def}}{=} \sup \left\{ |f(x) - f(y)| : f \in \text{dom}\,\mathcal{E} \cap C_c(\Omega), \frac{\text{d}\Gamma(f, f)}{\text{d}\mu} \leq 1 \right\}.
$$

Here  $\frac{d\Gamma(f,f)}{d\mu} \leq 1$  means that  $\Gamma(f,f)$  is absolutely continuous with respect to  $\mu$  and that  $\frac{d\Gamma(f,f)}{d\mu} \leq$ 1 almost everywhere. We warn the reader that there exist several variants of this distance, see [\[80\]](#page-38-24) and [\[81,](#page-38-25) p. 236].

<span id="page-33-0"></span>Returning to the setting of Lie groups, we can consider the symmetric bilinear form

(7.11) 
$$
\mathcal{E}(f,g) = \int_G \left\langle \nabla f(s), \nabla g(s) \right\rangle_{\ell_m^2} d\mu_G(s)
$$

whose domain is the subspace dom  $\mathcal{E} = \text{dom } X_{1,2} \cap \cdots \cap \text{dom } X_{m,2} = \text{dom } \nabla_2$  of the Hilbert space  $L^2(G)$ . This subspace is considered in the paper [\[9\]](#page-36-16) and the book [\[33\]](#page-36-15) and denoted respectively  $W'_{1,2}(G)$  and  $L'_{2,1}(G)$  (and equipped with a suitable norm). A simple computation for any  $f, g \in \text{dom } \mathcal{E} \cap L^{\infty}(G)$  and any  $h \in \text{dom } \mathcal{E} \cap C_c(G)$  gives

$$
\frac{1}{2} \left[ \mathcal{E}(f, hg) + \mathcal{E}(g, hf) - \mathcal{E}(uv, h) \right]
$$
\n
$$
\stackrel{(7.11)}{=} \frac{1}{2} \int_G \left[ \langle \nabla f(s), \nabla (hg)(s) \rangle + \langle \nabla g(s), \nabla (hf)(s) \rangle - \langle \nabla (fg)(s), \nabla h(s) \rangle \right] d\mu_G(s)
$$
\n
$$
\stackrel{(6.5)}{=} \frac{1}{2} \int_G \left[ h(s) \langle \nabla f(s), \nabla g(s) \rangle + g(s) \langle \nabla f(s), \nabla h(s) \rangle + h(s) \langle \nabla g(s), \nabla f(s) \rangle \right]
$$
\n
$$
+ f(s) \langle \nabla g(s), \nabla h(s) \rangle - f(s) \langle \nabla g(s), \nabla h(s) \rangle - g(s) \langle \nabla f(s), \nabla h(s) \rangle \right] d\mu_G(s)
$$
\n
$$
= \int_G h(s) \langle \nabla f(s), \nabla g(s) \rangle d\mu_G(s).
$$

<span id="page-34-3"></span>By [\(7.9\)](#page-33-1), we conclude (with no surpise) that  $\frac{d\Gamma(f,g)}{d\mu_G}(s) = \langle \nabla f(s), \nabla g(s) \rangle$  almost everywhere on *G*. In particular, we have the equality  $\frac{d\Gamma(f,f)}{d\mu_G}(s) = ||\nabla f(s)||_e^2$  $\ell_m^2$  almost everywhere. In this case, the intrinsic pseudo-distance  $(7.10)$  is given by

$$
\text{dist}_{\mathcal{E}}(s, s') \stackrel{(7.10)}{=} \sup \left\{ |f(s) - f(s')| : f \in W'_{1,2}(G) \cap C_c(G), \|\nabla f(s)\|_{\ell_m^2} \leq 1 \text{ a.e.} \right\}
$$
\n
$$
= \sup \left\{ |f(s) - f(s')| : f \in W'_{1,2}(G) \cap C_c(G), \|\nabla f\|_{\mathcal{L}^\infty(G, \ell_m^2)} \leq 1 \right\}
$$

where  $s, s' \in G$ . Using an approximation procedure similar to the one of the proof of Lemma [7.3](#page-31-1) left to the reader, we could conclude that

$$
\operatorname{dist}_{\mathcal{E}}(s, s') = \sup \left\{ |f(s) - f(s')| : f \in \mathrm{C}_c^{\infty}(G), \|\nabla f\|_{\mathrm{L}^{\infty}(G, \ell_m^2)} \leq 1 \right\} \stackrel{(7.2)}{=} \operatorname{dist}_{\mathrm{CC}}(s, s'),
$$

i.e. we obtain the Carnot-Carathéodory distance.

**Remark 7.6** It is possible that the result [\[55,](#page-37-21) Corollay 2.1] can be used to recover a part of the case  $p = 2$  of Lemma [7.2](#page-29-1) with a very different argument.

## <span id="page-34-0"></span>**8 Some open problems on functional calculus**

Let *G* be a connected Lie group of polynomial growth (hence unimodular) equipped with a family  $(X_1, \ldots, X_m)$  of left-invariant Hörmander vector fields and consider a Haar measure  $\mu_G$ on *G*. We refer to [\[48\]](#page-37-8) and [\[49\]](#page-37-22) for more information on functional calculus. Here we use the bisector  $\Sigma_{\theta}^{\pm} \stackrel{\text{def}}{=} \Sigma_{\theta} \cup (-\Sigma_{\theta})$  where  $\Sigma_{\theta}^{+} \stackrel{\text{def}}{=} \{z \in \mathbb{C} \setminus \{0\} : | \arg z | < \theta \}$  for any angle  $\theta \in (0, \frac{\pi}{2})$ . We will explain why the following conjecture is very natural.

<span id="page-34-2"></span>**Conjecture 8.1** *Suppose*  $1 < p < \infty$  *with*  $p \neq 2$ *. The unbounded operator*  $\overline{\psi}_p$  *is bisectorial and admits a bounded*  $H^{\infty}(\Sigma_{\theta}^{\pm})$  *functional calculus on a bisector*  $\Sigma_{\theta}^{\pm}$  *for some*  $0 < \theta < \frac{\pi}{2}$  *on the Banach space*  $L^p(G) \oplus_p L^p(G, \ell_m^p)$ *.* 

The case  $p = 2$  is of course obvious since  $\mathcal{D}_2$  is selfadjoint. The boundedness of the  $H^{\infty}(\Sigma_{\theta}^{\pm})$ functional calculus of the unbounded operator  $\mathcal{D}_p$  implies the boundedness of the Riesz transforms and this result may be thought of as a strengthening of the equivalence [\(3.10\)](#page-8-2). Indeed, consider the function sgn  $\in$   $H^{\infty}(\Sigma_{\theta}^{\pm})$  defined by sgn(*z*)  $\stackrel{\text{def}}{=} 1_{\Sigma_{\theta}^{+}}(z) - 1_{\Sigma_{\theta}^{-}}(z)$ . If the operator  $\mathcal{D}_p$  has a bounded  $H^{\infty}(\Sigma_{\theta}^{\pm})$  functional calculus on  $L^p(G) \oplus_p L^p(G, \ell_m^p)$ , the operator sgn $(\mathcal{D}_p)$ is bounded. Moreover, we have

<span id="page-34-1"></span>(8.1) 
$$
|\psi_p| = \text{sgn}(\psi_p)\psi_p \text{ and } \psi_p = \text{sgn}(\psi_p)|\psi_p|.
$$

For any element  $\xi$  of the space dom  $D\!\!\!\!/_{p} = \text{dom} |D\!\!\!\!/_{p}|$ , we deduce that

$$
\|\psi_p(\xi)\|_{\mathrm{L}^p(G)\oplus_p\mathrm{L}^p(G,\ell_m^p)} \stackrel{(8.1)}{=} \|\operatorname{sgn}(\not\!{D}_p)|\not\!{D}_p|(\xi)\|_{\mathrm{L}^p(G)\oplus_p\mathrm{L}^p(G,\ell_m^p)} \lesssim_p \|\|\not\!{D}_p|(\xi)\|_{\mathrm{L}^p(G)\oplus_p\mathrm{L}^p(G,\ell_m^p)}
$$

and similarly

$$
\left\||\psi_p(\xi)\right\|_{\mathrm{L}^p(G)\oplus_p\mathrm{L}^p(G,\ell_m^p)} \stackrel{(8.1)}{=} \left\| \mathrm{sgn}(\psi_p)\psi_p(\xi) \right\|_{\mathrm{L}^p(G)\oplus_p\mathrm{L}^p(G,\ell_m^p)} \lesssim_p \left\|\psi_p(\xi)\right\|_{\mathrm{L}^p(G)\oplus_p\mathrm{L}^p(G,\ell_m^p)}.
$$

<span id="page-35-10"></span>Recall that on  $L^p(G) \oplus_p L^p(G, \ell_m^p)$ , we have

$$
|\psi_p| \stackrel{(6.8)}{=} \begin{bmatrix} \Delta_p^{\frac{1}{2}} & 0 \\ 0 & * \end{bmatrix}.
$$

Using [\(6.6\)](#page-22-0) and by restricting to elements  $\xi$  of the form  $(f, 0)$  with  $f \in \text{dom } \Delta_p^{\frac{1}{2}}$ , we obtain the desired equivalence [\(3.10\)](#page-8-2).

**Remark 8.2** With a positive answer to Conjecture [8.1,](#page-34-2) it is not difficult to show in the case where *G* is compact that the triples  $(C(G), L^p(G) \oplus_p L^p(G, \ell^p_m), \mathcal{D}_p)$  gives new examples of compact Banach spectral triples in the sense of [\[7,](#page-35-3) Definition 5.10].

We finish with an other related conjecture.

**Conjecture 8.3** *Suppose*  $1 < p < \infty$ *. If Y is a* UMD *Banach space, the unbounded operator*  $\Delta_p \otimes \text{Id}_Y$  *is sectorial and admits a bounded*  $H^{\infty}(\Sigma_{\theta})$  *functional calculus with*  $0 < \theta < \frac{\pi}{2}$  *on the Bochner space*  $L^p(G, Y)$ *.* 

This is true for the classical Laplacian on  $\mathbb{R}^d$  by [\[49,](#page-37-22) Theorem 10.2.25 p. 391]. The scalar case  $Y = \mathbb{C}$  seems true by [\[34,](#page-37-23) Theorem 3.4]. The very interesting case where  $Y = S^p$  is a Schatten class could have applications in quantum information theory. It is apparent that [\[4\]](#page-35-9) is related to this problem.
