# Mass formulas and stringy point-count for semi-direct products of tame abelian groups and wild symmetric or cyclic groups in characteristic three

#### Abstract

In positive characteristic, there exist counterexamples to the statement corresponding to Batyrev's theorem concerning the McKay correspondence. In this paper, we give another computation of the counterexamples by using stringy-point count for some sequences of quotient varieties. There is a proof of the Serre-Bhagava's mass formula, which is important formula in the number theory, from the computation of stringy-point count of a quotient variety associated to a representation of symmetric group. Our computation of the stringy-point count in this paper is regarded as a variation of this proof to give different versions of mass formula.

## 1 Introduction

Our study begins with the following theorem, which is a version of the McKay correspondence.

Theorem 1.1 ([1]). Let $G \subset \mathrm{SL}_{d}(\mathbb{C})$ be a finite subgroup. Suppose there exists a crepant resolution $Y \rightarrow X$ of a quotient variety $X=\mathbb{A}_{\mathbb{C}}^{d} / G$. Then the topological Euler characteristic e $(Y)$ of $Y$ and the number of conjugacy classes of $G$ is equal:

$$
e(Y)=\sharp \operatorname{Conj}(G)
$$

It is natural to ask if the same equality holds in positive characteristic when replacing the topological Euler characteristic by the l-adic Euler characteristic. The $l$-adic Euler characteristic is defined by the alternating sum of the dimensions of the $l$-adic étale cohomology with compact support for a prime $l$ different from the characteristic of the base field. Because the $l$-adic Euler characteristic is equal to the topological Euler characteristic in characteristic zero, we get a natural extension of the assertion of Batyrev's theorem to arbitrary characteristic.

In positive characteristic, it is known that the equation of Batyrev's theorem holds for the quotient variety of the $2 n$-dimensional representation defined as a direct sum of two standard representations of the $n$-th symmetric group. This follows from Kedlaya's formula [6, Theorem 1.1], see [9, Theorem 5.21]. In [12], Yasuda studies quotient varieties for $p$-cyclic groups in characteristic $p$. Especially, he proves that a quotient variety $\mathbb{A}^{3} / C_{p}$ has a crepant resolution if $p=3$, and the equation of Batyrev's theorem holds. If $p \geq 5$, the quotient variety does not have crepant resolutions. ([12, Theorem 1.1, Corollary 6.25])

In the paper [10, we get examples of quotient varieties which have crepant resolutions and the Euler characteristic of the resolutions are not equal to the number of conjugacy classes in characteristic three. The example is given by concrete computation of crepant resolutions and its Euler characteristics. In this paper, we give another computation of the Euler characteristic of the crepant resolutions for some cases treated in [10] using stringy-point count invariant.

The stringy-point count equals a weighted count of $G$-étale algebras over a local field. In [10, we studied quotient varieties associated to representations of semi-direct products of tame abelian group and wild symmetric or cyclic group. For some of these cases, we compute the weighted count as follows.

Theorem 1.2 (Main theorem). Let $k$ be a finite field of order $q$ and characteristic three. Let $G \subset \mathrm{SL}_{3}(k)$ be a finite group without pseudo-reflections, that are $M \in \mathrm{SL}_{d}(k)$ such that $\operatorname{dim}_{k}\left(k^{d}\right)^{M}=d-1$, and let $V$ be the associated 3-dimensional representation of $G$ over $k$. Let $l \neq 3$ be a prime.

Suppose that l satisfies $q-1 \in l \mathbb{Z}$. Then we get the following formulas:
$\sum_{A \in G-E t(K)} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{C_{G}\left(H_{A}\right)}=\left\{\begin{array}{cc}q^{3}+\left(2+\frac{l-1}{6}\right) q^{2}+\frac{l-1}{6} q & \left(G \cong C_{l} \rtimes C_{3}\right) \\ q^{3}+\left(2+\frac{(l-1)(l+4)}{6}\right) q^{2}+\frac{(l-1)(l-2)}{6} q & \left(G \cong C_{l}^{2} \rtimes C_{3}\right)\end{array}\right.$,
where $G$-Ét $(K)$ is the set of $G$-étale $K$-algebras, $\boldsymbol{v}_{V}$ is the $v$-function associated $V, H_{A}$ is a stable subgroup of a summand of $A$, and $C_{G}\left(H_{A}\right)$ is the centralized group of $H_{A}$ in $G$. For more detail, see section three.

On the other hand, when we suppose that l satisfies $q-1 \in 2 l \mathbb{Z}$, we get the following formulas:
$\sum_{A \in G-E ́ t(K)} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{C_{G}\left(H_{A}\right)}=\left\{\begin{array}{cc}q^{3}+6 q^{2}+q & \left(G \cong C_{2}^{2} \rtimes \mathfrak{S}_{3}\right) \\ q^{2}+\frac{(l+5)(l+7)}{12} q^{2}+\frac{(l+1)(l+5)}{12} q & \left(l \neq 2, G \cong C_{l}^{2} \rtimes \mathfrak{S}_{3}\right)\end{array}\right.$
The Serre-Bhargava mass formula is represented as

$$
\sum_{A \in S_{n}-\hat{E} t(K)} q^{-\boldsymbol{a}(A)}=\sum_{m=0}^{n-1} P(n, n-m) q^{-m},
$$

where $\boldsymbol{a}$ is the Artin conductor of induced representation $\rho: G_{K} \rightarrow \mathrm{GL}_{n}(\mathbb{C})$ and $P(n, j)$ is the number of partitions of $n$ into $j$ positive integers (see [2]). In [9], another proof of the formula was given, which uses the stringy-point count of a quotient variety by a symmetric group. The left-hand-side of the mass formula is a weighted count of Galois extensions. Thus the formulas in the main theorem can be regarded as new versions of mass formula.

We prove this theorem by concrete computation. Firstly, we classify the $G$ étale algebras by the corresponding field extension $L / k((t))$. For each classes, we compute the value of $v$-function $\boldsymbol{v}_{V}$ by compute a basis of the tuning module. We compute the number of $G$-étale algebras with a prescribed value of $\boldsymbol{v}_{V}$. Then we can compute the sum in the left-hand-side in the formulas.

An important point of the proof is the computation of $v$-functions. The $v$ function corresponds to a local hight of some stack, for instance see 4. Section 3.1]. The module resolvent defined by Fröhlich in [3] also coincides with $v$ function. The $v$-function coincides with age of an element of group if the order of the group is not divided by the characteristic of base field. But, if the order of the group is divided by the characteristic, computing the $v$-function is difficult. The $v$-function is computed in the following cases.

- In [9, Theorem 4.8], the $v$-function is computed for permutation representations.
- In [13, Corollary 11.4], the $v$-function is computed for the stable hyperplane in permutation representations.
- The $v$-function is computed for the representation of $p$-cyclic group in [12, Proposition 6.9], and for the representation of $p^{r}$-cyclic group in 8, Theorem 3.11] as generalization.
- In [11, Theorem 5.3], the $v$-function is computed for the 2-dimensional representation of the group $(\mathbb{Z} / p \mathbb{Z})^{2}$. This is the first case that $v$-function is not determined by ramification filtration.

In the proof of the main theorem of this paper, we compute the $v$-function for the representation of symmetric group of degree three in characteristic three.

The stringy-point count gives the number of $k$-point of a crepant resolution. By using the Weil conjecture for $l$-adic cohomology, we can get the Euler characteristic of crepant resolution from the stringy-point count. Thus we get the following corollary from the main theorem.

Corollary 1.3. Let $G$ be a finite subgroup of $\mathrm{SL}_{3}(k)$ without pseudo-reflections. For a crepant resolution $Y \rightarrow \mathbb{A}_{k}^{3} / G$, we have

$$
\chi(Y)= \begin{cases}3+\frac{l-1}{3} & (G \cong \mathbb{Z} / l \mathbb{Z} \rtimes \mathbb{Z} / 3 \mathbb{Z}) \\ 3+\frac{l^{2}-1}{3} & \left(G \cong(\mathbb{Z} / l \mathbb{Z})^{2} \rtimes \mathbb{Z} / 3 \mathbb{Z}\right) \\ \frac{(l-1)(l-2)}{6}+2 l+4 & \left(G \cong(\mathbb{Z} / l \mathbb{Z})^{2} \rtimes \mathfrak{S}_{3}\right)\end{cases}
$$

The corollary supports the result of [10] for the Euler characteristic.
The outline of the paper is as follows. In section two, we explain notations and conventions of this paper. In section two, we give a some notations and conventions used through this paper. In section three, we give several facts for the stringy-point count or the stringy-motive, which is an invariant regarded as a generalization of the stringy-point count. In section four, we prove the main theorem by a case-by-case analysis. The key of the proof is the computation of $v$-function especially for symmetric extension. The computation of $v$-function is generally difficult, but we can in this cases.

## 2 Notation and Convention

Throughout this paper, $k$ denotes the finite field of order $q$, where $q$ is a power of a prime $p$, and $K$ denotes the Laurent power series field $k((t))$. The valuation ring of $K$ with respect to the normalized valuation $v_{K}$ is denoted by $\mathcal{O}_{K}$. Note that $\mathcal{O}_{K}$ is the ring $k[[t]]$ of formal power series. For any field $F$ of characteristic $p$, we define

$$
\wp: F \ni x \mapsto x^{p}-x \in F
$$

Note that $\wp$ is additive because the characteristic of $F$ is $p$.
The cyclic group $\mathbb{Z} / n \mathbb{Z}$ of order $n$ is denoted by $C_{n}$ for simplicity. The symmetric group of degree three is denoted by $\mathfrak{S}_{3}$. A tame group means a finite group whose order is not divided by the characteristic of the base field. Finite groups which are not tame are called wild groups.

For a subgroup $G$ of $\mathrm{SL}_{d}(k)$, we say $G$ is small if $G$ has no pseudo-reflections, equivalently any element $g$ of $G$ satysfies $\operatorname{dim}_{k}\left(k^{d}\right)^{g} \neq 1$. We say $G$ is of cyclic
type if $G$ isomorphic to a semidirect product $H \rtimes C_{3}$ where $H$ is a tame abelian group. If $G$ isomorphic to a semidirect product $G \cong H \rtimes \mathfrak{S}_{3}$ where $H$ is a tame abelian group, we say $G$ is of symmetric type.

## 3 Stringy motive and stringy-point count

In this section, we give some facts of the stringy-point count. For an $\mathcal{O}_{K^{-}}$-variety $X$, that means $X$ is a reduced $\mathbb{Q}$-Gorenstein quasi-projective $\mathcal{O}_{K}$-scheme such that flat, of finite type, equi-dimensional over $\mathcal{O}_{K}$, and the structure morphism $X \rightarrow \operatorname{Spec} \mathcal{O}_{K}$ is smooth on an open dence subscheme of $X$, we denote its stringy point-count by $\sharp_{s t} X$, which is an invariant defined as the volume of $X$ with respect to a certain $p$-adic measure. For more detail see 14. A crepant resolution means a proper birational morphism $Y \rightarrow X$ such that $Y$ is smooth over $\mathcal{O}_{K}$ and the relative canonical divisor $K_{Y / X}$ is zero. For a crepant resolution $Y \rightarrow X$, we have

$$
\sharp Y(k)=\sharp_{s t} X .
$$

Thus we can use the stringy point-count for counting the $k$-points on a crepant resolution.

For a finite group $G$, a finite étale $K$-algebras $A$ of degree $\sharp G$ endowed with a $G$-action and satisfying $A^{G}=K$ is called a $G$-étale $K$-algebra. An isomorphism of $G$-étale $K$-algebras is a $G$-equivaliant isomorphisms of $K$-algebras. We denote the set of the isomorphic classes of $G$-étale $K$-algebras by $G$-Ét $(K)$. Note that each $A \in G$-Ét $(K)$ is written as

$$
A=L_{1} \oplus L_{2} \oplus \cdots \oplus L_{m}
$$

where $\left\{L_{i}\right\}_{i=1}^{m}$ are copies of a Galois extension $L / K$. Let $H_{A} \subset G$ be the stabilizer of $L_{1}$. Then $H_{A}$ is isomorphic to the Galois group of $L / K$.

Let $V=\mathbb{A}_{\mathcal{O}_{K}}^{n}$ be an $n$-dimensional linear representation of $G$ and let $\mathcal{O}_{K}\left[x_{1}, \ldots, x_{n}\right]$ be the coordinate ring of $V$. Then the linear part $M=\sum_{i=1}^{n} \mathcal{O}_{K} x_{i}$ of $\mathcal{O}_{K}\left[x_{1}, \ldots, x_{n}\right]$ is the free $\mathcal{O}_{K}$-module of degree $n$ endowed with $G$-action.

For $A \in G$-Et $(K)$, we define the tuning module $\Xi_{A / K}^{V}$ of $A$ by

$$
\Xi_{A / K}^{V}=\operatorname{Hom}_{\mathcal{O}_{K}}^{G}\left(M, \mathcal{O}_{A}\right),
$$

where $\mathcal{O}_{A}$ is the integer ring of $A$ over $\mathcal{O}_{K}$ and $\operatorname{Hom}_{\mathcal{O}_{K}}^{G}\left(M, \mathcal{O}_{A}\right)$ is the set of all the $G$-equivariant $\mathcal{O}_{K}$-linear morphisms $M \rightarrow \mathcal{O}_{A}$. Then the $v$-function $\boldsymbol{v}_{V}$ on $G$-Ét $(K)$ is defined by

$$
\boldsymbol{v}_{V}(A)=\frac{1}{\sharp G} \operatorname{length}_{\mathcal{O}_{K}} \frac{\operatorname{Hom}_{\mathcal{O}_{K}}\left(M, \mathcal{O}_{A}\right)}{\mathcal{O}_{A} \cdot \Xi_{A / K}^{V}} .
$$

The $v$-function satisfies that

$$
\boldsymbol{v}_{V}(A)=\boldsymbol{v}_{\left.V\right|_{H_{A}}}(L)
$$

where $\left.V\right|_{H_{A}}$ is a representation given by regarding $V$ as a representation of $H_{A}$.
Note that, the $v$-function corresponds to the age of an element of $H_{A}$ when $H_{A}$ is tame. For $h \in \mathrm{GL}_{d}(K)$ of order $l$ which is not divided by $p$, the eigenvalues of $h$ is written as $\zeta^{a_{1}}, \zeta^{a_{2}}, \ldots, \zeta^{a_{d}}$, where $\zeta \in K$ is the primitive $l$-th root of unity and $0 \leq a_{i}<l$ for any $i$. Then the age of $h$ is defined by

$$
\operatorname{age}(h)=\frac{1}{l} \sum_{i=1}^{d} a_{i}
$$

Lemma 3.1 (9, Lemma 4.3). Take a $G$-étale $K$-algebra $A=L^{\oplus n}$. Suppose that $H_{A}$ is tame and the ramification index of $L / K$ is e. Let $\zeta \in K$ be a primitive e-th root of unity. Let $g \in H_{A}$ be an element which acts on $L$ by

$$
g(\pi)=\zeta \pi
$$

for a uniformizer $\pi$ of $L$. Then

$$
\boldsymbol{v}_{V}(A)=\operatorname{age}(g)
$$

The stringy-point count is equal to a weighted sum of $G$-étale $K$-algebras.
Theorem 3.2 ([14, Theorem 7.4, Proposition 8.5]). Let $\sharp k=q$. If $V=\mathbb{A}_{\mathcal{O}_{K}}^{n}$ is a linear representation of a finite group $G$. If $V / G$ is étale in codimension one, then we have

$$
\sharp_{s t}(V / G)=\sum_{A \in G-\dot{E} t(K)} \frac{q^{n-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)} .
$$

This is one of realizations of the following equation called the wild McKay correspondence. The wild McKay correspondence is a equation between stringy motive and an integration on a moduli space of $G$-torsors over $\operatorname{Spec} k((t))$, denoted by $\Delta_{G}$. The stringy motive is defined as a motivic integration on arc space. For a variety $X$, we denote the stringy motive of $X$ by $M_{s t}(X)$.

Theorem 3.3 ([15, Corollary 14.4]). Let $V, G$ be same as in Theorem 3.2. Let $X$ be a quotient variety $X=V / G$. Then we have

$$
M_{s t}(X)=\int_{\Delta_{G}} \mathbb{L}^{d-\boldsymbol{v}_{V}}
$$

This is generalization of the motivic McKay correspondence in characteristic zero proved by Batyref [1] and Denef-Loeser [5].

## 4 Main theorem

In this section, we set $p=3$. Namely, the base field $k$ is a finite field of order $q=3^{r}$. We give a proof of the following theorem.

Theorem 4.1 (Main theorem). Let $G \subset \mathrm{SL}_{3}(k)$ be a small finite group and let $V$ be the natural representation of $G$. Let $l \neq 3$ be a prime.

Suppose that l satisfies $q-1 \in l \mathbb{Z}$. Then we get the following formulas for the case that $G$ is of cyclic type:
$\sum_{A \in G-E ́ t(K)} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)}=\left\{\begin{array}{cl}q^{3}+\left(2+\frac{l-1}{6}\right) q^{2}+\frac{l-1}{6} q & \left(G \cong C_{l} \rtimes C_{3}\right) \\ q^{3}+\left(2+\frac{(l-1)(l+4)}{6}\right) q^{2}+\frac{(l-1)(l-2)}{6} q & \left(G \cong C_{l}^{2} \rtimes C_{3}\right)\end{array}\right.$
On the other hand, when we suppose that $l$ satisfies $q-1 \in 2 l \mathbb{Z}$, we get the following formulas for the case that $G$ is of symmetric type:

$$
\sum_{A \in G-\dot{E} t(K)} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)}=\left\{\begin{array}{cc}
q^{3}+6 q^{2}+q & \left(G \cong C_{2}^{2} \rtimes \mathfrak{S}_{3}\right) \\
q^{2}+\frac{(l+5)(l+7)}{12} q^{2}+\frac{(l+1)(l+5)}{12} q & \left(l \neq 2, G \cong C_{l}^{2} \rtimes \mathfrak{S}_{3}\right)
\end{array}\right.
$$

### 4.1 The case that $G$ is cyclic type

Firstly, we consider the case that $G$ is a small subgroup of $\mathrm{SL}_{3}(k)$ isomorphic to $C_{l} \rtimes C_{3}$ where $l$ is a prime different from three. From [10, Lemma 3.1], we may assume that any elements of $C_{l} \subset G$ are diagonalized and $C_{3} \subset G$ is generated by

$$
\boldsymbol{S}=\left[\begin{array}{lll}
0 & 1 & 0 \\
0 & 0 & 1 \\
1 & 0 & 0
\end{array}\right]
$$

In this case, the set $G$-Ét $(K)$ is divided into three parts:

$$
\begin{gathered}
S_{1}=\left\{A \in G \text {-Ét }(K) \mid H_{A} \text { is trivial }\right\} \\
S_{2}=\left\{A \in G \text {-Ét }(K) \mid H_{A} \cong C_{3}\right\} \\
S_{3}=\left\{A \in G \text {-Ét }(K) \mid H_{A} \cong C_{l}\right\}
\end{gathered}
$$

where $H_{A}$ denotes the stable subset of a connected component of $A$ as in previous section.

If $A \in S_{1}$, then $A=K^{\oplus 3 l}$. As $A$ is unramified, we have $\boldsymbol{v}_{V}(A)=0$ from 9, Lemma 3.4]. Obviously, $C_{G}\left(H_{A}\right)=G$. Thus we get

$$
\begin{equation*}
\sum_{A \in S_{1}} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)}=\frac{1}{3 l} q^{3} . \tag{4.1.1}
\end{equation*}
$$

If $A \in S_{2}$, then $A=L^{\oplus l}$ where $L$ is a $C_{3}$-extension over $K$. By the ArtinSchreier theory, there exist $a \in K / \wp(K)$ such that $K[x] /\left(x^{3}-x-a\right) \cong L$. This implies that there exists $\alpha \in L$ uniquely such that $\alpha$ generates $L$ as $K$-algebra, $\alpha$ satisfies

$$
\alpha^{3}-\alpha \in k / \wp(k) \oplus \bigoplus_{3 \nmid j>0} k t^{-j}
$$

and $C_{3}$ acts on $L$ by $\alpha \cdot \boldsymbol{S}=\alpha+1$. Here, we fix a representative for each element of the quotient $k / \wp(k)$, and we denote the set of the representatives
also by $k / \wp(k)$. Hence the set $k / \wp(k) \oplus \bigoplus_{3 \nmid j>0} k t^{-j}$ is a set of representatives of $K / \wp(K)$. We set $a=\alpha^{3}-\alpha$. Let $j=-v_{K}(a)$. If $j=0$ then $A$ is unramified and we get $\boldsymbol{v}_{V}(A)=0$ from [9, Lemma 3.4]. When $j>0$, from [13, Lemma 11.1] and [7, Proposition 7 in page 50], we get

$$
\boldsymbol{v}_{V}(A)=\frac{d_{L / K}}{2}=j+1
$$

We set

$$
S_{2, m}=\left\{A \in S_{2} \mid \boldsymbol{v}_{V}(A)=m\right\} .
$$

If $3 \nmid(m-1)>0$, then we have

$$
\sharp S_{2,0}=\sharp((k / \wp(k)) \backslash\{0\})=2,
$$

and

$$
\begin{aligned}
\sharp S_{2, m} & =\sharp\left(k / \wp(k) \oplus \bigoplus_{0<j<m-1,3 \nmid j} k t^{-j} \oplus k^{\times} t^{-m}\right) \\
& =3 q^{m-\left\lfloor\frac{m-1}{3}\right\rfloor-2}(q-1) .
\end{aligned}
$$

As $l$ is not divided by three, $C_{G}\left(C_{3}\right)=C_{3}$. Therefore, we get

$$
\begin{align*}
\sum_{A \in S_{2}} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)} & =\sum_{m=0}^{\infty} \sum_{A \in S_{2, m}} \frac{q^{3-m}}{3} \\
& =\frac{2}{3} q^{3}+\frac{q^{3}}{3} \sum_{3 \nmid m-1>0} \sharp S_{2, m} q^{-m} \\
& =\frac{2}{3} q^{3}+q(q-1) \sum_{3 \nmid m-1>0} q^{-\left\lfloor\frac{m-1}{3}\right\rfloor} \\
& =\frac{2}{3} q^{3}+q(q-1) \sum_{r=0}^{\infty}\left(q^{-\left\lfloor\frac{3 r}{3}\right\rfloor}+q^{-\left\lfloor\frac{3 r+1}{3}\right\rfloor}\right) \\
& =\frac{2}{3} q^{3}+2 q(q-1) \sum_{r=0}^{\infty} q^{-r} \\
& =\frac{2}{3} q^{3}+2 q(q-1) \frac{q}{q-1} \\
& =\frac{2}{3} q^{3}+2 q^{2} \tag{4.1.2}
\end{align*}
$$

If $A \in S_{3}, A=L^{\oplus 3}$ where $L$ is a $C_{l}$-extension of $K$. From the assumption $l \mid(q-1), K$ has all the $l$-th roots of unity. A quotient group $K^{\times} /\left(K^{\times}\right)^{l}$ is isomorphic to a bicyclic group $C_{l}^{2}$. We fix a generator $\mu$ of $k^{\times}$. Then $K^{\times} /\left(K^{\times}\right)^{l}$
is generated by classes of $\mu$ and $t$. By the Kummer theory, there exists $\alpha \in L$ such that $L$ is generated by $\alpha$ as $K$-algebra and

$$
\alpha^{l}=\mu \text { or } \mu^{i} t \quad(0 \leq i \leq l-1)
$$

If $\alpha^{l}=\mu$ then $A$ is unramified. Thus $\boldsymbol{v}_{V}(A)=0$ from [9, Lemma 3.4]. We suppose that $\alpha^{l}=\mu^{i} t$. Let $\zeta_{l} \in k$ is a primitive $l$-th root of unitiy. We choose a generator $h$ of $C_{l}$ such that $\alpha \cdot h=\zeta_{l} \alpha$. From Lamma 3.1, we get

Theorem 4.2. Let $G$ be a small subgroup of $\mathrm{SL}_{3}(k)$ isomorphic to $C_{l} \rtimes C_{3}$ where $l$ is a prime different from three. Suppose that $q-1 \in l \mathbb{Z}$. For the natural representation $V$ of $G$, we get

If $A \in S_{1}, A$ is unramified. Therefore we get $\boldsymbol{v}_{V}(A)=0$ from (9, Lemma 3.4]. As $C_{G}\left(H_{A}\right)=G$, we get

If $A \in S_{3}, A=L^{\oplus 3}$ where $L$ is a $C_{l}$-extension of $K$. Similarly as in the case $A \in S_{3}$ when $G \cong C_{l} \rtimes C_{3}$, we can choose a generator $\alpha \in L$ over $K$ satisfying

& \sharp\left\{h \in C_{l}^{2} \mid \operatorname{age}(h)=2\right\}=\frac{(l-1)(l-2)}{2} .
\end{aligned}

As the action on $A$ is defined by choice of a conjugate class represented by $h$,

In this case, $C_{G}\left(H_{A}\right)=C_{l}^{2}$. Therefore, we get

& =\frac{l^{2}-1}{3 l^{2}} q^{3}+\frac{(l-1)(l+4)}{6 l} q^{2}+\frac{(l-1)(l-2)}{6 l} q \tag{4.1.6}
\end{align*}

If $A \in S_{4}, A=L^{\oplus 3}$ where $L$ is $C_{l}^{2}$-extension of $K$. As $K^{\times} /\left(K^{\times}\right)^{l}$ is isomorphic to $C_{l}^{2}$ and it is generated by $\mu, t$, there are generators $\alpha, \beta \in L$ such that

Note that $\beta$ is an uniformizer of $L$. We choose $h_{1}, h_{2} \in C_{l}^{2}$ satisfying

& \sharp\left\{\left(h_{1}, h_{2}\right) \mid h_{1}, h_{2} \text { generate } C_{l}^{2}, \operatorname{age}\left(h_{2}\right)=2\right\}=\frac{(l-1)(l-2)}{2}\left(l^{2}-l\right) .
\end{aligned}
$$

Hence, for

Theorem 4.3. Let $G$ be a small subgroup of $\mathrm{SL}_{3}(k)$ isomorphic to $C_{l}^{2} \rtimes C_{3}$ where $l$ is a prime different from three. Suppose that $q-1 \in l \mathbb{Z}$. For the natural representation $V$ of $G$, we get

\sum_{A \in G-E \in t(K)} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)}=q^{3}+\left(2+\frac{(l-1)(l+4)}{6}\right) q^{2}+\frac{(l-1)(l-2)}{6} q
$$

Proof. By the formulas (4.1.4), (4.1.5), (4.1.6), and (4.1.7), we get

= & \frac{q^{3}}{3 l^{2}}+\left(\frac{2}{3} q^{3}+2 q^{2}\right) \\
& +\left(\frac{\left(l^{2}-1\right)}{3 l^{2}} q^{3}+\frac{(l-1)(l+4)}{6 l} q^{2}+\frac{(l-1)(l-2)}{6 l} q\right)
\end{aligned}
$$

$$
\begin{aligned}
& +\left(\frac{(l-1)^{2}(l+4)}{6 l} q^{2}+\frac{(l-1)^{2}(l-2)}{6 l} q\right) \\
= & q^{3}+\left(2+\frac{(l-1)(l+4)}{6}\right) q^{2}+\frac{(l-1)(l-2)}{6} q .
\end{aligned}
$$

### 4.2 The case that $G$ is symmetric type

In this section, we consider the case that $G$ is a small subgroup of $\mathrm{SL}_{3}(k)$ isomorphic to $C_{l}^{2} \rtimes \mathfrak{S}_{3}$ where $l$ is a prime different from three. From [10, Lemma 3.2], we may assume that any elements of $C_{l}^{2}$ are diagonalized and $\mathfrak{S}_{3} \subset G$ is generated by

\boldsymbol{S}=\left[\begin{array}{lll}
0 & 1 & 0 \\
0 & 0 & 1 \\
1 & 0 & 0
\end{array}\right], \boldsymbol{T}=\left[\begin{array}{ccc}
0 & 0 & -1 \\
0 & -1 & 0 \\
-1 & 0 & 0
\end{array}\right]
$$

Firstly, we consider the case that $l \neq 2$. In this case, the set $G$-Ét $(K)$ is divided into seven parts:

S_{2}=\left\{A \mid H_{A} \cong C_{3}\right\} \\

S_{5}=\left\{A \mid H_{A} \cong C_{2}\right\} \\
S_{6}=\left\{A \mid H_{A} \cong C_{2 l}\right\} \\
S_{7}=\left\{A \mid H_{A} \cong \mathfrak{S}_{3}\right\}
\end{gathered}
$$

If $A \in S_{1}$ then $A$ is unramified and $C_{G}\left(H_{A}\right)=G$. Thus we get $\boldsymbol{v}_{V}(A)=0$ from [9, Lemma 3.4] and

\sum_{A \in S_{1}} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)}=\frac{1}{6 l^{2}} q^{3} . \tag{4.2.1}

If $A \in S_{2}$, then $A=L^{\oplus 2 l^{2}}$ where $L$ is a $C_{3}$-extension over $K$. Then we discuss as in the case $A \in S_{2}$ when $G \cong C_{l} \rtimes C_{3}$. We let $\alpha, a, j$ as in the case. Then we have

$$

We put

S_{2, m}=\left\{A \in S_{2} \mid \boldsymbol{v}_{V}(A)=m\right\}

As $\boldsymbol{S}$ and $\boldsymbol{S}^{2}$ are conjugate in $G$, we have

1 & (m=0) \\
\frac{3}{2} q^{m-\left\lfloor\frac{m-1}{3}\right\rfloor-2}(q-1) & (3 \nmid(m-1)>0) . \\
0 & (\text { otherwise })
\end{array} .\right.
$$

As $C_{G}\left(H_{A}\right)=C_{3}$, we get

\sum_{A \in S_{2}} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)} & =\sum_{m=0}^{\infty} \sum_{A \in S_{2}} \frac{q^{3-m}}{3} \\
& =\frac{1}{3} q^{3}+\frac{1}{2} q(q-1) \sum_{3 \nmid(m-1)>0} q^{-\left\lfloor\frac{m-1}{3}\right\rfloor} \\
& =\frac{1}{3} q^{3}+q^{2} . \tag{4.2.2}
\end{align*}
$$

If $A \in S_{3}, A=L^{\oplus 3}$ where $L$ is a $C_{l}$-extension of $K$. Similarly as in the case $A \in S_{3}$ when $G \cong C_{l} \rtimes C_{3}$, we can choose a generator $\alpha \in L$ over $K$ satisfying

\alpha^{l}=\mu \text { or } \mu^{i} t \quad(0 \leq i \leq l-1)
$$

and $h \in H_{A}$ such that $\alpha \cdot h=\zeta_{l} \alpha$.
If $\alpha^{l}=\mu$ then $A$ is unramified. Thus $\boldsymbol{v}_{V}(A)=0$ from [9, Lemma 3.4]. We suppose that $\alpha^{l}=\mu^{i} t$. By Lemma 3.1 we get

We divide the set $S_{3, m}$ into two parts:

& S_{3, m}^{\prime}=\left\{A \in S_{3, m} \mid \sharp C_{G}\left(H_{A}\right)=2 l^{2}\right\} .

Now the elements of $S_{3, m}^{\prime}$ corresponds to the conjugate class in $C_{l}^{2}$, which is represented by $\operatorname{diag}\left(\zeta_{l}^{a}, \zeta_{l}^{2 l-2 a}, \zeta_{l}^{a}\right)$, and choice of exponent $i$ in $\alpha^{l}=\mu^{i} t$ from $0 \leq i \leq l-1$. Moreover, we have

= & \left(\frac{(l-1)(l-2)}{6 l^{2}}+\frac{l-1}{2 l^{2}}\right) q^{3} \\
& +\left(\frac{1}{6 l}\left(\frac{(l-1)(l+4)}{2}-3\left\lfloor\frac{l}{2}\right\rfloor\right)+\frac{1}{2 l}\left\lfloor\frac{l}{2}\right\rfloor\right) q^{2} \\
& +\left(\frac{1}{6 l}\left(\frac{(l-1)(l-2)}{2}-3\left(l-1-\left\lfloor\frac{l}{2}\right\rfloor\right)\right)+\frac{1}{2 l}\left(l-1-\left\lfloor\frac{l}{2}\right\rfloor\right)\right) q \\
= & \frac{l^{2}-1}{6 l^{2}} q^{3}+\frac{(l-1)(l+4)}{12 l} q^{2}+\frac{(l-1)(l-2)}{12 l} q . \tag{4.2.3}

If $A \in S_{4}, A=L^{\oplus 6}$ where $L$ is $C_{l}^{2}$-extension of $K$. As $K^{\times} /\left(K^{\times}\right)^{l}$ is isomorphic to $C_{l}^{2}$ and it is generated by $\mu, t$, there are generators $\alpha, \beta \in L$ such that

$$

We choose $h_{1}, h_{2} \in C_{l}^{2}$ satisfying

\alpha \cdot h_{1}=\zeta_{l} \alpha, & \beta \cdot h_{1}=\beta \\
\alpha \cdot h_{2}=\alpha, & \beta \cdot h_{2}=\zeta_{l} \beta
\end{array}

By Lemma 3.1, we have

because $\beta$ is an uniformizer of $L$.
For pairs of generators $\left(h_{1}, h_{2}\right),\left(h_{1}^{\prime}, h_{2}^{\prime}\right)$ of $H_{A}$, we define a equivalence relation $\sim$ by

\left(h_{1}, h_{2}\right) \sim\left(h_{1}^{\prime}, h_{2}^{\prime}\right) \Leftrightarrow \exists g \in G, h_{1}=g h_{1}^{\prime} g^{-1}, h_{2}=g h_{2}^{\prime} g^{-1}

Then a $G$-action on $A$ is defined by the equivalent class of the pair of generators $\left(h_{1}, h_{2}\right)$ of $C_{l}^{2}$. We have

& 2 q^{2}+q
\end{align*}
$$

Theorem 4.6. Let $G$ be a small subgroup isomorphic to $C_{l}^{2} \rtimes \mathfrak{S}_{3}$ where $l$ is a prime. Suppose that $l \neq 2,3$ and $q-1 \in 2 l \mathbb{Z}$. For the natural representation $V$ of $G$, we get

$$
\sum_{A \in G-E t(K)} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)}=q^{3}+\frac{(l+5)(l+7)}{12} q^{2}+\frac{(l+1)(l+5)}{12} q .
$$

Proof. From the formulas (4.2.1), (4.2.2), (4.2.3), (4.2.4), (4.2.5), (4.2.6), and (4.2.7), we get

$$
\left.\begin{array}{rl}
\sum_{A \in G \text {-Ét }(K)} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)}= & \sum_{i=1}^{7} \sum_{A \in S_{i}} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)} \\
= & \frac{1}{6 l^{2}} q^{3}+\left(\frac{1}{3} q^{3}+q^{2}\right) \\
& +\left(\frac{l^{2}-1}{6 l^{2}} q^{3}+\frac{(l-1)(l+4)}{12 l} q^{2}+\frac{(l-1)(l-2)}{12 l} q\right) \\
& +\left(\frac{(l-1)^{2}(l+4)}{12 l} q^{2}+\frac{(l-1)^{2}(l-2)}{12 l} q\right) \\
& +\left(\frac{1}{2 l} q^{3}+\frac{1}{l} q^{2}\right) \\
& +\left(\frac{l-1}{2 l} q^{3}+\frac{(l-1)(3 l+4)}{4 l} q^{2}+\frac{3(l-1)}{4} q\right) \\
& +\left(2 q^{2}+q\right) \\
= & q^{3}
\end{array}\right) \frac{(l+5)(l+7)}{12} q^{2}+\frac{(l+1)(l+5)}{12} q .
$$

If $l=2$, the set $G$-Ét $(K)$ is divided into eight part which are $S_{1}, S_{2}, \ldots, S_{7}$ defining in the case of $l \neq 2$ and

$$
S_{8}=\left\{A \in G \text {-Ét }(K) \mid H_{A} \text { generated by } \boldsymbol{T} \text { and } \operatorname{diag}(-1,0,-1)\right\}
$$

For the sums $\sum_{A \in S_{i}} \frac{q^{3-v_{V}(A)} \sharp \sharp C_{G}\left(H_{A}\right)}{}(i=1,2,3,4,5,7)$, we can use the formulas (4.2.1), (4.2.2), (4.2.3), (4.2.4), (4.2.5), and (4.2.7).

If $A \in S_{6}$, then $A$ corresponds to a cyclic subgroup of $K^{\times} /\left(K^{\times}\right)^{4}$ by the Kummer theory. All the cyclic subgroup is generated by $\mu, \mu^{i} t(0 \leq i \leq 3)$, or $\mu t^{2}$. From Lemma 4.4, we have $\boldsymbol{v}_{V}(A)=1$ for any $A \in S_{6}$ not corresponding to the subgroup generated by $\mu$. Hence we have

$$
\begin{align*}
\sum_{A \in S_{6}} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)} & =\frac{1}{4} q^{3}+\frac{\sharp S_{6}-1}{4} q^{2} \\
& =\frac{1}{4} q^{3}+\frac{5}{4} q^{2} . \tag{4.2.8}
\end{align*}
$$

If $A \in S_{8}$, then $A=L^{\oplus 6}$ where $L$ is a $C_{2}^{2}$-extension of $K$. From the Kummer theory, $L$ is generated by $\alpha, \beta$ satisfying

$$
\alpha^{2}=\mu, \beta^{2}=t
$$

over $K$. Applying Lemma 3.1, we get $\boldsymbol{v}_{V}(A)=1$ because $\beta$ is a uniformizer of $L$, the ramification index of $L / K$ is two, and the age of matrices in $\mathrm{SL}_{3}(K)$ of order two are one. Giving an action of $G$ on $A$ corresponds to choosing generators $h_{1}, h_{2}$ of $H_{A}$ such that

$$
\begin{array}{ll}
\alpha \cdot h_{1}=-\alpha, & \alpha \cdot h_{2}=\alpha \\
\beta \cdot h_{1}=\beta, & \beta \cdot h_{2}=-\beta .
\end{array}
$$

up to conjugate. Then the choices are

$$
\left(h_{1}, h_{2}\right)=(\boldsymbol{T}, \operatorname{diag}(-1,1,-1)),(\operatorname{diag}(-1,1,-1), \boldsymbol{T}), \text { or }(\boldsymbol{T}, \operatorname{diag}(-1,1,-1) \boldsymbol{T})
$$

Hence

$$
\sharp S_{8}=3 .
$$

As $C_{G}\left(H_{A}\right)=H_{A}$, we get

$$
\begin{equation*}
\sum_{A \in S_{8}} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)}=\frac{3}{4} q^{2} . \tag{4.2.9}
\end{equation*}
$$

Theorem 4.7. Let $G$ be a small subgroup isomorphic to $C_{2}^{2} \rtimes \mathfrak{S}_{3}$. Suppose that $q-1 \in 4 \mathbb{Z}$. For the natural representation $V$ of $G$, we get

$$
\sum_{A \in G-E t(K)} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)}=q^{3}+6 q^{2}+q
$$

Proof. By using the formulas the formulas (4.2.1), (4.2.2), (4.2.3), (4.2.4), (4.2.5), (4.2.7), 4.2.8), and (4.2.9), we get

$$
\begin{aligned}
\sum_{A \in G \text {-Ét }(K)} \frac{q^{3-\boldsymbol{v}_{V}(A)}}{\sharp C_{G}\left(H_{A}\right)}= & \frac{1}{24} q^{3}+\left(\frac{1}{3} q^{3}+q^{2}\right)+\left(\frac{3}{24} q^{3}+\frac{1}{4} q^{2}\right)+\frac{1}{4} q^{2} \\
& +\left(\frac{1}{4} q^{3}+\frac{1}{2} q^{2}\right)+\left(2 q^{2}+q\right)+\left(\frac{1}{4} q^{3}+\frac{5}{4} q^{2}\right)+\frac{3}{4} q^{2} \\
= & q^{3}+6 q^{2}+q
\end{aligned}
$$

## 5 Euler characteristic

In this section, we compute the Euler characteristic, which defined from the $l$-adic cohomology, of a crepant resolution $Y$ of $V / G$ for a representation $V$ of a cyclic or symmetric type subgroup $G \subset \mathrm{SL}_{3}(k)$.

To compute the Euler characteristic, we use the following well-known formula.
Proposition 5.1. For a smooth variety $Y$ over $\mathbb{F}_{q}$. Suppose that

$$
\sharp Y\left(\mathbb{F}_{q^{m}}\right)=\sum_{i=1}^{n} a_{i} q^{i m}
$$

where $a_{i} \in \mathbb{Z}$. Then

$$
\chi(Y)=\sum_{i=1}^{n} a_{i}
$$

Proof. Let $Z(t) \in \mathbb{Q}[[t]]$ be the zeta function of $Y$, which is defined as

$$
Z(t)=\exp \left(\sum_{m=1}^{\infty} \sharp Y\left(\mathbb{F}_{q^{m}}\right) \frac{t^{m}}{m}\right),
$$

or equivalently

$$
\frac{d}{d t} \log Z(t)=\sum_{m=1}^{\infty} \sharp Y\left(\mathbb{F}_{q^{m}}\right) t^{m-1} .
$$

From the assumption, we have

$$
\begin{aligned}
\sum_{m=1}^{\infty} \sharp Y\left(\mathbb{F}_{q^{m}}\right) t^{m-1} & =\sum_{m=1}^{\infty} \sum_{i=1}^{n} a_{i} q^{i m} t^{m-1} \\
& =\sum_{i=1}^{n} a_{i} q^{i} \sum_{m=1}^{\infty}\left(q^{i} t\right)^{m-1} \\
& =\sum_{i=1}^{n} \frac{a_{i} q^{i}}{1-q^{i} t}
\end{aligned}
$$

Thus

$$
\log Z(t)=\int \sum_{i=1}^{n} \frac{a_{i} q^{i}}{1-q^{i} t} d t=\sum_{i=1}^{n}-a_{i} \log \left(1-q^{i} t\right)
$$

and hence

$$
Z(t)=\exp \left(\sum_{i=1}^{n}-a_{i} \log \left(1-q^{i} t\right)\right)=\prod_{i=1}^{n} \frac{1}{\left(1-q^{i} t\right)^{a_{i}}}
$$

From the Weil conjecture we get

$$
\chi(Y)=\operatorname{deg}\left(\prod_{i=1}^{n}\left(1-q^{i} t\right)^{a_{i}}\right)=\sum_{i=1}^{n} a_{i}
$$

Corollary 5.2. Let $G$ be a cyclic type or symmetric type subgroup of $\mathrm{SL}_{3}(k)$. For a crepant resolution $Y \rightarrow V / G$ of a quotient of a canonical representation $V$ of $G$, we have

$$
\chi(Y)= \begin{cases}3+\frac{l-1}{3} & \left(G \cong C_{l} \rtimes \mathbb{Z} / 3 \mathbb{Z}\right) \\ 3+\frac{l^{2}-1}{3} & \left(G \cong\left(C_{l}\right)^{2} \rtimes \mathbb{Z} / 3 \mathbb{Z}\right) \\ \frac{(l-1)(l-2)}{6}+2 l+4 & (G: \text { symmetric type })\end{cases}
$$

Proof. By the property of the stringy-point count, we have

$$
\sharp Y\left(\mathbb{F}_{q}\right)=\sharp_{s t} V / G .
$$

Hence the assertion follows from the previous proposition and Theorem4.1.
Remark 5.3. From [10, Theorem 1.2], the quotient varieties $V / G$ have crepant resolutions.
