# THE MINIMAL DIMENSION OF A SPHERE WITH AN EQUIVARIANT EMBEDDING OF THE BOUQUET OF $g$ CIRCLES IS $2 g-1$

#### Abstract

To embed the bouquet of $g$ circles $B_{g}$ into the $n$-sphere $S^{n}$ so that its full symmetry group action extends to an orthogonal actions on $S^{n}$, the minimal $n$ is $2 g-1$. This answers a question raised by B. Zimmermann.


In this note graphs are finite and connected and group actions are faithful. Denote the $n$-dimensional Euclidean space and orthogonal group by $\mathbb{R}^{n}$ and $O(n)$, and the unit sphere in $\mathbb{R}^{n+1}$ by $S^{n}$.

Graphs belong to a most familiar geometric subject to us and the symmetries of graphs is a big and active research area.

For a given graph $\Gamma$ with an action of a finite group $G$, an embedding $e: \Gamma \rightarrow S^{n}$ is $G$-equivariant, if there is a subgroup $G \subset O(n+1)$ so that $G$ acts on the pair $\left(S^{n}, e(\Gamma)\right)$ satisfying $g(e(x))=e(g(x))$ for any $x \in \Gamma$ and $g \in G$. In the definition of $G$-equivariant embedding, one may replace $\left(S^{n}, O(n+1)\right)$ by $\left(\mathbb{R}^{n}, O(n)\right)$. See Remark 0.5 for relations between the two definitions.

The existence of $G$-equivariant embedding for any pair $(G, \Gamma)$ is known, see Mos and $[\mathrm{Pa}$. On the other hand, for given $\Gamma$ and $G$, usually it is difficult to find the minimal $n$ so that there is an $G$-equivariant embedding $\Gamma \rightarrow \mathbb{R}^{n}$.

The most significant finite group associated to a graph $\Gamma$ is its full symmetry group $\operatorname{Sym}(\Gamma)$. The simplest and also most symmetric graph is the bouquet of $g$ circles (the graph with one vertex and $g$ closed edges, see Figure 1), denoted as $B_{g} . B_{g}$ is the simplest in the sense that $B_{g}$ has only one vertex. $B_{g}$ is the most symmetric in the sense that: for $g \geq 3$, the maximum order of finite group action on a hyperbolic graph of rank $g$ (defined as its fundamental group rank) is $2^{g} g$ !, which is realized uniquely by the action of $\operatorname{Sym}\left(B_{g}\right)$ on $B_{g}$ [WZ]. A graph $\Gamma$ is

hyperbolic if it has rank $>1$ and has no free edge. See Example 0.6 for the rank 2 case.

We will simply use equivariant embedding of $\Gamma$ for $\operatorname{Sym}(\Gamma)$-equivariant embedding of $\Gamma$.

Recently B. Zimmermann asked a very interesting question (as commented by the Math. Review of the paper).
Question 0.1. (Zi]) What is the minimal $n$ so that there is an equivariant embedding $B_{g} \rightarrow S^{n}$ ?

Zimmermann has pointed that $n \geq g-1$ from a group theoretical reason. He also described an equivariant embedding of $B_{g}$ into $S^{2 g}$. So he concluded the minimal $n$ is between $g-1$ and $2 g[\mathrm{Zi}]$. We will answer this question.

Theorem 0.2. The minimal $n$ so that there is an equivariant embedding $B_{g} \rightarrow S^{n}$ is $2 g-1$.

Theorem 0.2 follows from the next two propositions.
Proposition 0.3. Suppose there is an equivariant embedding of $B_{g}$ into $S^{n}$, then $n \geq 2 g-1$.
Proposition 0.4. There are equivariant embeddings of $B_{g}$ into $S^{2 g-1}$ for each $g>1$.

Proof of Proposition 0.3. We need first recall a careful description of the action of $\operatorname{Sym}\left(B_{g}\right)$ on $B_{g}$. Denote the vertex of $B_{g}$ by $v$ and the $g$ circles by $C_{1}, \ldots, C_{g}$, see Figure 2. From now on we consider that each circle $C_{i}$ is oriented. It is known that $\operatorname{Sym}\left(B_{g}\right)$ is the semi-direct product $\left(\mathbb{Z}_{2}\right)^{g} \ltimes S_{g}$, where $S_{g}$ is the permutation group of $g$ elements, which permutes those $g$ oriented circles, and the normal subgroup $\left(\mathbb{Z}_{2}\right)^{g}$ acts by orientation reversing involutions of those $g$ oriented circles.

More precisely, for each $\sigma \in S_{g}$, denote the corresponding action on $B_{g}$ by $\tau_{\sigma}$, which sends $C_{i}$ to $C_{\sigma(i)}$ and preserves the orientations. Denote the element $\rho_{i}$ to be the element in $\left(\mathbb{Z}_{2}\right)^{g} \subset \operatorname{Sym}\left(B_{g}\right)$, which

is the orientation reversing involution on $C_{i}$ and is the identity on the remaining $C_{j}$, for $j \neq i$. Now $\rho_{i}$ has two fixed points, one is $v$, another we denote as $p_{i}$. It is clear that

$$
\begin{equation*}
\tau_{\sigma} \rho_{i} \tau_{\sigma^{-1}}=\rho_{\sigma(i)} \tag{1}
\end{equation*}
$$

By (1) we have

$$
\rho_{\sigma(i)} \tau_{\sigma}\left(p_{i}\right)=\tau_{\sigma} \rho_{i} \tau_{\sigma}^{-1} \tau_{\sigma}\left(p_{i}\right)=\tau_{\sigma} \rho_{i}\left(p_{i}\right)=\tau_{\sigma}\left(p_{i}\right)
$$

So we have

$$
\rho_{\sigma(i)} \tau_{\sigma}\left(p_{i}\right)=\tau_{\sigma}\left(p_{i}\right)
$$

That is, $\tau_{\sigma}\left(p_{i}\right)$ is the fixed point of $\rho_{\sigma(i)}$ on $C_{\sigma(i)}-\{v\}$. Since the fixed point of $\rho_{\sigma(i)}$ on $C_{\sigma(i)}-v$ is unique, we have

$$
\begin{equation*}
\tau_{\sigma}\left(p_{i}\right)=p_{\sigma(i)} \tag{2}
\end{equation*}
$$

Suppose now we have an equivariant embedding $B_{g} \subset S^{n}$. That is to say we have embedded $\operatorname{Sym}\left(B_{g}\right)$ into $O(n+1)$ which acts on the pair $\left(S^{n}, B_{g}\right)$ and the restriction on $B_{g}$ is the action of $\operatorname{Sym}\left(B_{g}\right)$ described as above. Since $S^{n}$ is the unit sphere of $\mathbb{R}^{n+1}$ and $O(n+1)$ is the orthogonal transformation group of $\mathbb{R}^{n+1}$, the action of $\operatorname{Sym}\left(B_{g}\right)$ on $S^{n}$ extends to a $\operatorname{Sym}\left(B_{g}\right)$-action on $\mathbb{R}^{n+1}$ as an orthogonal transformation group.

Consider each point in $\mathbb{R}^{n+1}$ as a vector in $\mathbb{R}^{n+1}$. Since $v, p_{1}, p_{2}, \ldots, p_{g}$ are in the unit sphere, each of them is a non-zero vector. Let

$$
V=\left\langle v, p_{1}, p_{2}, \ldots, p_{g}\right\rangle
$$

be the subspace of $\mathbb{R}^{n+1}$ spanned by the vectors $v, p_{1}, p_{2}, \ldots, p_{g}$.
By (2), the $S_{g}$-action on $B_{g}$ permutes those vectors $p_{1}, p_{2}, \ldots, p_{g}$ and fixes $v$. Hence $S_{g}$ acts faithfully on $V$, that is $\left.\tau_{\sigma}\right|_{V}=\left.\mathrm{id}\right|_{V}$ if and only if $\sigma$ is the identity in $S_{g}$.

Now we show that the vectors $v, p_{1}, \ldots, p_{g-1}$ are linearly independent:
Suppose $a, a_{1}, \ldots, a_{g-1}$ are real numbers such that

$$
\begin{equation*}
a v+\sum_{i=1}^{g-1} a_{i} p_{i}=0 \tag{3}
\end{equation*}
$$

For each $j \in\{1,2, \ldots, g-1\}$, recall that $(j, g) \in S_{g}$ exchanges $j$ and $g$, and fixes all the remaining $i$, and $\tau_{(j, g)}$ corresponds to the element $(j, g) \in S_{g}$. Since $\tau_{(j, g)}$ is an orthogonal transformation, $\tau_{(j, g)}$ is linear. Applying $\tau_{(j, g)}$ to (3), we have

$$
\begin{equation*}
0=\tau_{(j, g)}\left(a v+\sum_{i=1}^{g-1} a_{i} p_{i}\right)=a \tau_{(j, g)}(v)+\sum_{i=1}^{g-1} a_{i} \tau_{(j, g)}\left(p_{i}\right) \tag{4}
\end{equation*}
$$

Since $v$ is the common fixed point of $S_{g}$ and $\tau_{(j, g)}\left(p_{i}\right)=p_{i}$ if $j \neq i$ and $\tau_{(j, g)}\left(p_{j}\right)=p_{g}$, we have further

$$
\begin{equation*}
a v+\sum_{i=1, i \neq j}^{g-1} a_{i} p_{i}+a_{j} p_{g}=0 \tag{5}
\end{equation*}
$$

On the other hand by (3) and some elementary transformations we have

$$
\begin{equation*}
a v+\sum_{i=1, i \neq j}^{g-1} a_{i} p_{i}+a_{j} p_{g}=a v+\sum_{i=1}^{g-1} a_{i} p_{i}-a_{j} p_{j}+a_{j} p_{g}=a_{j}\left(p_{g}-p_{j}\right) \tag{6}
\end{equation*}
$$

Combine (5) and (6), we have

$$
a_{j}\left(p_{g}-p_{j}\right)=0
$$

Since $B_{g} \subset \mathbb{R}^{n+1}$ is an embedding, and $j \neq g$, we have

$$
p_{g}-p_{j} \neq 0
$$

Hence $a_{j}=0$. Since $j$ can be any element in $\{1,2, \ldots, g-1\}$. Hence $a_{j}=0$ for each $j \in\{1,2, \ldots, g-1\}$. By (3) we have

$$
a v=0 .
$$

Since $v \in S^{n}, v \neq 0$, we have $a=0$. That is (3) implies that

$$
\begin{equation*}
a=a_{1}=a_{2}=\ldots=a_{g-1}=0 \tag{7}
\end{equation*}
$$

that is $v, p_{1}, \ldots, p_{g-1}$ are linearly independent. As a conclusion we have

$$
\begin{equation*}
\operatorname{dim} V \geq g \tag{8}
\end{equation*}
$$

Let $V^{\perp}$ be orthogonal complement of $V$ in $\mathbb{R}^{n+1}$. We have

$$
\begin{equation*}
\mathbb{R}^{n+1}=V \oplus V^{\perp} \tag{9}
\end{equation*}
$$

For any $i \in\{1,2, \ldots, g\}, \rho_{i}$ is orthogonal, so is linear. Moreover each point in $\left\{v, p_{1}, p_{2}, \ldots, p_{g}\right\}$ is a fixed point of $\rho_{i}$. Therefore $\rho_{i}$ is the identity on $V$, the subspace spanned by $\left\{v, p_{1}, p_{2}, \ldots, p_{g}\right\}$. Further more we conclude that the action of the subgroup $\left(\mathbb{Z}_{2}\right)^{g}$ on $V$ is trivial. In particular $V$ is an invariant subspace of the $\left(\mathbb{Z}_{2}\right)^{g}$-action.

Since the $\left(\mathbb{Z}_{2}\right)^{g}$-action on $\mathbb{R}^{n+1}$ is orthogonal and $V$ is invariant under the $\left(\mathbb{Z}_{2}\right)^{g}$-action, $\left(\mathbb{Z}_{2}\right)^{g}$ acts orthogonally on the orthogonal complement $V^{\perp}$ of $V$. Since the $\left(\mathbb{Z}_{2}\right)^{g}$-action is trivial on $V$ and is faithful on $\mathbb{R}^{n+1}$, the $\left(\mathbb{Z}_{2}\right)^{g}$-action must be faithful on $V^{\perp}$ by (9).

Let $q$ be the dimension of $V^{\perp}$, and consider $O(q)$ as $q$ by $q$ orthogonal matrix group. Then $\left(\mathbb{Z}_{2}\right)^{g}$-action on $V^{\perp}$ is by a matrix group in $O(q)$. Let $\Omega_{q}$ be the set of all $q$ by $q$ diagonal matrices whose entries on the diagonal of the matrices are either 1 or -1 . Then there are exactly $2^{q}$ matrices in $\Omega_{q}$.

Each element in $\left(\mathbb{Z}_{2}\right)^{g}$ is of order 1 or 2 , therefore it can be diagonalized, indeed into $\Omega_{q}$. By linear algebra, a finite number of commuting diagonalizable matrices can be diagonalized simultaneously. Since $\left(\mathbb{Z}_{2}\right)^{g}$ is a finite abelian group, we may assume that under a basis of $V^{\perp}$, all matrices in $\left(\mathbb{Z}_{2}\right)^{g}$ are diagonalized, therefore are elements in $\Omega_{g}$. Since $\left(\mathbb{Z}_{2}\right)^{g}$ has $2^{g}$ elements, $\left(\mathbb{Z}_{2}\right)^{g}$ acts faithfully on $V^{\perp}$, the image of $\left(\mathbb{Z}_{2}\right)^{g}$ in $\Omega_{g}$ must be also $2^{g}$ pairwise different elements. Therefore $2^{g} \leq 2^{q}$, that is

$$
\begin{equation*}
g \leq q=\operatorname{dim} V^{\perp} \tag{10}
\end{equation*}
$$

By (8), (9) and (10) we have

$$
n+1=\operatorname{dim} V+\operatorname{dim} V^{\perp} \geq 2 g
$$

That is

$$
n \geq 2 g-1
$$

We finish the proof.
Proof of Proposition 0.4. We will contruct two different equivariant embeddings. The first one is an equivariant embedding $B_{g} \rightarrow \mathbb{R}^{2 g-1}$, then the required $G$-equivariant embedding $B_{g} \rightarrow S^{2 g-1}$ can be obtained by one point compactification via the inverse of stereographic projection $p: S^{2 g-1} \rightarrow \mathbb{R}^{2 g-1}$. The second one is an equivariant embedding of $B_{g} \rightarrow \mathbb{R}^{2 g}$, where $B_{g}$ stays equivariantly in the unit sphere $S^{2 g-1}$.

The first construction. Before we give a general construction, we like to provide a visible equivariant embedding of $B_{2} \subset \mathbb{R}^{3}$ in the familiar dimension in which we live.

Fix a standard $x y z$-coordinate system of $\mathbb{R}^{3}$. Let $C_{1}$ be the unit circle in the lower-half $z x$-plane which is tangent to the $x$-axis at the origin, and $C_{2}$ be the unit circle in the upper-half $y z$-plane which is tangent to
the $y$-axis at the origin, as shown in Figure 3. Then $C_{1} \bigcup C_{2}$ provides an embedding $B_{2} \subset \mathbb{R}^{3}$. The action of $\operatorname{Sym}\left(B_{2}\right)=\left(\mathbb{Z}_{2}\right)^{2} \ltimes S_{2}$ is also realized by a subgroup of $O(3)$ : where the inversion of $C_{1}$ is given by the reflection about the $y z$-plane, the inversion of $C_{2}$ is given by the reflection about the $z x$-plane, and the permutation of $C_{1}$ and $C_{2}$ is given by the $\pi$-rotation around a diagonal $L$ in the $x y$-plane. This provides an equivariant embedding.

Then we provide the equivariant embedding of $B_{g} \subset \mathbb{R}^{2 g-1}$ for $g>2$.
Let $V_{1}=\mathbb{R}^{g-1}$ and $v_{1}, v_{2}, \ldots, v_{g}$ be the vertices of a regular $(g-1)$ dimensional simplex $\Delta_{g-1}$ centered at the origin $O_{1}$ of $V_{1}$ with the length $\left|O_{1} v_{i}\right|=1$. Then $S_{g}$, the full symmetry group of $\Delta_{g-1}$, is a subgroup of $O(g-1)$. Let $V_{2}=\mathbb{R}^{g}$, and $e_{1}, e_{2}, \ldots, e_{g}$ be the standard orthogonal basis of $V_{2}$. Let $V=V_{1} \times V_{2}$, then $V=\mathbb{R}^{2 g-1}$, and $\left(v_{i}, e_{i}\right)$ is a standard orthogonal basis of the Euclidean plane $E_{i}$ spanned by $v_{i}$ and $e_{i}, i \in\{1, \ldots, g\}$.

Define the isometrical embedding $\iota_{i}: S^{1} \rightarrow V$ by

$$
\begin{equation*}
\iota_{i}(\cos \theta, \sin \theta)=(1+\cos \theta) v_{i}+\sin \theta e_{i} \tag{11}
\end{equation*}
$$

where $0 \leq \theta<2 \pi$ is the parameter on the unit circle.
Let $\iota_{i}\left(S^{1}\right)=C_{i}, i \in\{1, \ldots, g\}$. Clearly the origin $O$ of $V$ belongs to each $C_{i}$. Moreover $C_{i}$ belongs to $E_{i}$, and $E_{i} \cap E_{j}=O$ for $i \neq j$, so $C_{i} \cap C_{j}=O$ for $i \neq j$. Hence $\bigcup_{i=1}^{g} C_{i}$ is a bouquet of $g$ circles embedded in $V$ with the origin $O$ as the vertex, still denoted as $B_{g}$.

For each $i \in\{1,2, \ldots, g\}$ and each $\sigma \in S_{g}$, we define $\iota_{i}, \tau_{\sigma} \in O(2 g-1)$ as follows

$$
\begin{equation*}
\iota_{i}\left(v_{j}\right)=v_{j} \text { for all } j, \iota_{i}\left(e_{j}\right)=e_{j} \text { for } j \neq i ; \iota_{i}\left(e_{i}\right)=-e_{i} . \tag{12}
\end{equation*}
$$

THE MINIMAL $n$ FOR EQUIVARIANT EMBEDDINGS $B_{g} \rightarrow S^{n}$ IS $n=2 g-17$

$$
\begin{equation*}
\tau_{\sigma}\left(e_{i}\right)=e_{\sigma(i)}, \tau_{\sigma}\left(v_{i}\right)=v_{\sigma(i)} \tag{13}
\end{equation*}
$$

By $(11),(12)$ and $(13)$, one can check directly
(i) $\iota_{i}$ is the identity on $C_{j}$ for $j \neq i$ and is an orientation reversing involution on $C_{i}$.
(ii) $\tau_{\sigma}\left(C_{i}\right)=C_{\sigma(i)}$ and $\tau_{\sigma}^{-1}\left(C_{i}\right)=C_{\sigma^{-1}(i)}$.

Let

$$
H=\left\langle\iota_{i}, \tau_{\sigma}: 1 \leq i \leq g, \sigma \in S_{g}\right\rangle
$$

Then $H$ is a subgroup of $\operatorname{Sym}\left(B_{g}\right)$, and each $h \in H$ has the form

$$
h=\tau_{\sigma} \prod_{i=1}^{g} \iota_{i}^{\alpha_{i}}
$$

where $\alpha_{i}=0$ or 1 , since $\left\langle\iota_{i}, 1 \leq i \leq g\right\rangle$ is a normal subgroup of $H$. Clearly $H$ acts faithfully on $B_{g}$. Moreover if $h \in H$ is the identity on $B_{g}, h$ must fix all $v_{i}$ and $e_{i}$, which implies that $h$ is the identity on $V$. So $H$ also acts faithfully on $V$. The restriction of $H$ on $B_{g}$ is $\operatorname{Sym}\left(B_{g}\right)$, since it exhausts all symmetries of $\operatorname{Sym}\left(B_{g}\right)$.

Therefore we get an equivariant embedding $B_{g} \rightarrow \mathbb{R}^{2 g-1}$.
The second construction. View $\mathbb{R}^{2 g}$ as the product

$$
\mathbb{R}^{2 g}=\mathbb{R}_{1}^{2} \times \mathbb{R}_{2}^{2} \times \ldots \times \mathbb{R}_{g}^{2}
$$

where each $\mathbb{R}_{i}^{2}$ is an Euclidean plane with standard coordinate system $\left(x_{i}, y_{i}\right), i=1,2, \ldots, g$. Then $\left(x_{1}, y_{1}, x_{2}, y_{2}, \ldots, x_{g}, y_{g}\right)$ provides a standard coordinate system of the Euclidean space $\mathbb{R}^{2 g}$. Let $C_{i}$ be the circle in $\mathbb{R}_{i}^{2} \subset \mathbb{R}^{2 g}$ given by

$$
\begin{equation*}
C_{i}=\left\{x_{i}^{2}+y_{i}^{2}=\frac{1}{g}, x_{j}=\frac{1}{\sqrt{g}}, y_{j}=0 \text { for remaining } j \neq i .\right\} \tag{13}
\end{equation*}
$$

with anti-clockwise orientation in the $x_{i} y_{i}$-plane.
Now we make three observations:
(a) Clearly the point

$$
v=\left(\frac{1}{\sqrt{g}}, 0, \frac{1}{\sqrt{g}}, 0, \ldots, \frac{1}{\sqrt{g}}, 0\right) \in \mathbb{R}^{2 g}
$$

belongs to each $C_{i}$, and each pair $C_{i}$ and $C_{j}$ intersect only at $v$ for $i \neq j$. Therefore the union $\bigcup_{i=1}^{g} C_{i}$ provides an embedding of $B_{g} \rightarrow \mathbb{R}^{2 g}$.
(b) For each $i \in\{1,2, \ldots, g\}$ and each $\sigma \in S_{g}$, we define

$$
\iota_{i}, \tau_{\sigma}: \mathbb{R}^{2 g} \rightarrow \mathbb{R}^{2 g}
$$

as below:

$$
\iota_{i}\left(x_{1}, y_{1}, \ldots, x_{i-1}, y_{i-1}, x_{i}, y_{i}, x_{i+1}, y_{i+1}, \ldots, x_{g}, y_{g}\right)
$$

$$
\begin{gathered}
=\left(x_{1}, y_{1}, \ldots, x_{i-1}, y_{i-1}, x_{i},-y_{i}, x_{i+1}, y_{i+1}, \ldots, x_{g}, y_{g}\right) . \\
\tau_{\sigma}\left(x_{1}, y_{1}, \ldots, x_{i}, y_{i}, \ldots, x_{g}, y_{g}\right) \\
=\left(x_{\sigma(1)}, y_{\sigma(1)}, \ldots, x_{\sigma(i)}, y_{\sigma(i)}, \ldots, x_{\sigma(g)}, y_{\sigma(g)}\right)
\end{gathered}
$$

Clearly $\iota_{i}, \tau_{\sigma} \in O(2 g), \iota_{i}$ is the identity on $C_{j}$ for $j \neq i$ and is an orientation reversing involution on $C_{i}$. and $\tau_{\sigma}\left(C_{i}\right)=C_{\sigma(i)}$. Moreover the group

$$
H=<\iota_{i}, \tau_{\sigma}: 1 \leq i \leq g, \sigma \in S_{g}>
$$

is isomorphic to $\left(\mathbb{Z}_{2}\right)^{g} \rtimes S_{g} \cong \operatorname{Sym}\left(B_{g}\right)$ and acts faithfully on the pair $\left(\mathbb{R}^{2 g}, B_{g}\right)$.
(c) For each $w \in B_{g}, w \in C_{i}$ for some $i$. By (13) we have

$$
\begin{gathered}
|w|^{2}=\sum_{j=1}^{g}\left(x_{j}^{2}+y_{j}^{2}\right)=\sum_{j=1, j \neq i}^{g}\left(x_{j}^{2}+y_{j}^{2}\right)+\left(x_{i}^{2}+y_{i}^{2}\right) \\
=\sum_{j=1, j \neq i}^{g}\left(\left(\frac{1}{\sqrt{g}}\right)^{2}+0^{2}\right)+\frac{1}{g}=1 .
\end{gathered}
$$

That is to say $B_{g}$ stays in the unit sphere $S^{2 g-1} \subset \mathbb{R}^{2 g}$.
By the conclusion of (b), the given $B_{g} \subset S^{2 g-1}$ is an equivariant embedding.

Remark 0.5. For given pair $(G, \Gamma)$, as we explained in the proof of Proposition 0.4 , each $G$-equivariant embedding $\Gamma \rightarrow \mathbb{R}^{n}$ provides a $G$ equivariant embedding $\Gamma \rightarrow S^{n}$. However a $G$-equivariant embedding $\Gamma \rightarrow S^{n}$ does not guarantee a $G$-equivariant embedding $\Gamma \rightarrow R^{n}$, see the example below.

Example 0.6. The maximum order of finite group action on a hyperbolic graph of rank 2 is 12 , which is realized uniquely by the action of $\operatorname{Sym}\left(M_{3}\right)=S_{3} \ltimes \mathbb{Z}_{2}$ on $M_{3}$ [WZ], where $M_{3}$ is the graph with two vertices joined by three edges, $S_{3}$ permutes three edges and fixes each vertex, and $\mathbb{Z}_{2}$ is an orientation-reversing involution on each edge. There is an equivariant embedding $M_{3} \rightarrow S^{2}$, which is indicated by the left side of Figure 4.

There is no equivariant embedding $M_{3} \subset \mathbb{R}^{2}$. A quick proof uses Jordan curve theorem: For any embedding $M_{3} \rightarrow \mathbb{R}^{2}, M_{3}$ divides $\mathbb{R}^{2}$ into two bounded regions $R_{1}, R_{2}$, and one unbounded region $R_{3}$, see the right side of Figure 4. Then $C_{2}$, the unique edge neighboring two bounded regions, must be invariant under any $\tau \in O(2)$, therefore the embedding is not equivariant.

Remark 0.7. A related question is when a finite group action $G$ on a graph $\Gamma$ can be $G$-equivariantly embedded into $\mathbb{R}^{3}\left(S^{3}\right)$, see [FNPT], [WWZZ2]. Similar question for surfaces is also addressed, see [CC], [WWZZ1].
