INHOMOGENEOUS AND SIMULTANEOUS DIOPHANTINE APPROXIMATION IN BETA DYNAMICAL SYSTEMS

Abstract. In this paper, we investigate inhomogeneous and simultaneous Diophantine approximation in beta dynamical systems. For $\beta > 1$ let T_β be the β -transformation on [0, 1]. We determine the Lebesgue measure and Hausdorff dimension of the set

$$
\left\{(x,y)\in [0,1]^2:|T^n_\beta x-f(x,y)|<\varphi(n)\text{ for infinitely many }n\in\mathbb{N}\right\},
$$

where $f : [0,1]^2 \to [0,1]$ is a Lipschitz function and φ is a positive function on N. Let $\beta_2 \geq \beta_1 > 1$, $f_1, f_2 : [0,1] \rightarrow [0,1]$ be two Lipschitz functions, τ_1, τ_2 be two positive continuous functions on [0, 1]. We also determine the Hausdorff dimension of the set

$$
\left\{(x,y)\in [0,1]^2: \frac{|T_{\beta_1}^nx - f_1(x)| < \beta_1^{-n\tau_1(x)}}{|T_{\beta_2}^ny - f_2(y)| < \beta_2^{-n\tau_2(y)}} \text{ for infinitely many } n \in \mathbb{N}\right\}.
$$

Under certain additional assumptions, the Hausdorff dimension of the set

$$
\left\{(x,y)\in [0,1]^2: \frac{|T_{\beta_1}^nx - g_1(x,y)| < \beta_1^{-n\tau_1(x)}}{|T_{\beta_2}^ny - g_2(x,y)| < \beta_2^{-n\tau_2(y)}} \text{ for infinitely many } n \in \mathbb{N} \right\}
$$

is also determined, where $g_1, g_2 : [0, 1]^2 \to [0, 1]$ are two Lipschitz functions.

1. INTRODUCTION

Given a real number $\beta > 1$, the β -transformation $T_{\beta} : [0, 1] \rightarrow [0, 1]$ is define by

$$
T_{\beta}x = \beta x - \lfloor \beta x \rfloor \quad \text{ for } x \in [0, 1],
$$

where $|\cdot|$ denotes the integral part of a real number. In this paper, we study the metric properties of orbits in the beta dynamical system $([0, 1], T_\beta)$.

In 1957, Rényi [\[12\]](#page-17-0) initialed the study of the map T_β in his investigation of expansions of real numbers in non-integral bases. Parry [\[10\]](#page-17-1) proved that there is an invariant and ergodic measure for T_β , which is equivalent to the Lebesgue measure $\mathcal L$ on [0, 1]. Then Birkhoff's ergodic theorem implies that for any fixed $x_0 \in [0,1]$,

$$
\liminf_{n \to \infty} |T_{\beta}^n x - x_0| = 0 \tag{1.1}
$$

for L-almost all $x \in [0,1]$. On the other hand, the Poincaré Recurrence Theorem yields that for \mathcal{L} -almost all $x \in [0, 1]$,

$$
\liminf_{n \to \infty} |T_{\beta}^n x - x| = 0. \tag{1.2}
$$

Both [\(1.1\)](#page-0-0) and [\(1.2\)](#page-1-0) are qualitative in nature, and taking into account the speed of convergence in (1.1) and (1.2) leads to the study of the metric properties of the set

$$
D_{\beta}(\varphi, x_0) = \left\{ x \in [0, 1] : |T_{\beta}^n x - x_0| < \varphi(n) \text{ for infinitely many } n \in \mathbb{N} \right\} \tag{1.3}
$$

and the set

$$
R_{\beta}(\varphi) = \left\{ x \in [0, 1] : |T_{\beta}^n x - x| < \varphi(n) \text{ for infinitely many } n \in \mathbb{N} \right\},\tag{1.4}
$$

respectively, where $\varphi : \mathbb{N} \to (0,\infty)$ is a positive function. The study of $D_\beta(\varphi, x_0)$ is called the *shrinking target problem*, and the study of $R_\beta(\varphi)$ is called *quantitative recurrence* in beta dynamical systems. When $x_0 \neq 0$, the set $D_\beta(\varphi, x_0)$ can be also viewed as the *inhomogeneous Diophantine approximation* by orbits in $([0, 1], T_\beta)$. In the following, we introduce related works which motivated the present paper. In a general measure preserving dynamical system with compatible metric, the shrinking target problem was introduced by Hill and Velani [\[7\]](#page-16-0), and for a pioneering work on quantitative recurrence one refers to Boshernitzan [\[2\]](#page-16-1).

In 1967, Philipp [\[11\]](#page-17-2) proved that for any fixed $x_0 \in [0, 1]$,

$$
\mathcal{L}(D_{\beta}(\varphi, x_0)) = \begin{cases} 0 & \text{if } \sum_{n=1}^{\infty} \varphi(n) < \infty, \\ 1 & \text{if } \sum_{n=1}^{\infty} \varphi(n) = \infty. \end{cases}
$$
(1.5)

When $\sum_{n=1}^{\infty} \varphi(n) < \infty$, Shen and Wang [\[13\]](#page-17-3) obtained the Hausdorff dimension of $D_{\beta}(\varphi, x_0)$. They proved that

$$
\dim_{\mathrm{H}} D_{\beta}(\varphi, x_0) = \frac{1}{1+\alpha} \quad \text{with } \alpha = \liminf_{n \to \infty} \frac{\log_{\beta} \varphi(n)^{-1}}{n}, \tag{1.6}
$$

where \dim_H denotes the Hausdorff dimension.

Concerning the set $R_{\beta}(\varphi)$ in [\(1.4\)](#page-1-1), Tan and Wang [\[14\]](#page-17-4) obtained its Hausdorff dimension, which is also equal to $\frac{1}{1+\alpha}$ given in [\(1.6\)](#page-1-2). Wang [\[16\]](#page-17-5) considered the following extension of $R_\beta(\varphi)$:

$$
\{x \in [0,1] : |T_{\beta}^n x - f(x)| < \varphi(n) \text{ for infinitely many } n \in \mathbb{N}\},\qquad(1.7)
$$

where $f : [0, 1] \rightarrow [0, 1]$ is a Lipschitz function. He proved that this set has Hausdorff dimension $\frac{1}{1+\alpha}$ given in [\(1.6\)](#page-1-2) as well. The set [\(1.7\)](#page-1-3) can be viewed as the inhomogeneous Diophantine approximation by orbits in $([0, 1], T_\beta)$ in which the inhomogeneous part (i.e. the term $f(x)$) is allowed to vary. Very recently, Lü, Wang and Wu $[9]$ proved that the Lebesgue measure of the set (1.7) also satisfies (1.5) .

Another related set is the set of points $(x, y) \in [0, 1]^2$ such that the orbit of x under T_β approximates y with a given speed, which is studied by Ge and Lü [\[6\]](#page-16-2). More precisely, Ge and Lü proved that the two-dimensional Lebesgue measure \mathcal{L}^2 of the set

$$
\{(x,y)\in[0,1]^2:|T_{\beta}^nx-y|<\varphi(n)\text{ for infinitely many }n\in\mathbb{N}\}\qquad(1.8)
$$

satisfies [\(1.5\)](#page-1-4) and this set has Hausdorff dimension $1 + \frac{1}{1+\alpha}$ with α given in [\(1.6\)](#page-1-2). Coons, Hussain and Wang [\[4\]](#page-16-3) extended this result to the generalised Hausdorff measure.

In view of the sets (1.3) , (1.4) , (1.7) and (1.8) , and the corresponding results mentioned above, a natural question is what if we replace the inhomogeneous part y in (1.8) by a more general function, especially depending on both coordinates. Concerning this question, we have the following result.

Theorem 1.1. Let $\beta > 1$, $f : [0, 1]^2 \rightarrow [0, 1]$ be a Lipschitz function, and φ be a positive function on N. Set

$$
W_{\beta}(f,\varphi) = \left\{ (x,y) \in [0,1]^2 : |T_{\beta}^n x - f(x,y)| < \varphi(n) \text{ for infinitely many } n \in \mathbb{N} \right\}.
$$

Then

$$
\mathcal{L}^2(W_\beta(f,\varphi)) = \begin{cases} 0 & \text{if } \sum_{n=1}^\infty \varphi(n) < \infty, \\ 1 & \text{if } \sum_{n=1}^\infty \varphi(n) = \infty. \end{cases}
$$

Furthermore, if $\sum_{n=1}^{\infty} \varphi(n) < \infty$, then

$$
\dim_{\mathrm{H}} W_{\beta}(f,\varphi) = 1 + \frac{1}{1+\alpha},
$$

where $\alpha = \liminf_{n \to \infty} \frac{\log_{\beta} \varphi(n)^{-1}}{n}$ $\frac{\nu(n)}{n}$.

This paper was also motivated by a result of Wang and Li [\[17\]](#page-17-7) on *simultaneous* Diophantine approximation in beta dynamical systems. More precisely, let f, g : $[0, 1] \rightarrow [0, 1]$ be two Lipschitz functions, τ_1, τ_2 be two positive continuous functions on [0, 1] with $\tau_1(x) \leq \tau_2(y)$ for all $x, y \in [0, 1]$. Wang and Li [\[17\]](#page-17-7) proved that for any $\beta > 1$, the Hausdorff dimension of the set

$$
\left\{ (x,y) \in [0,1]^2 : \frac{|T_\beta^n x - f(x)| < \beta^{-n\tau_1(x)}}{|T_\beta^n y - g(y)| < \beta^{-n\tau_2(y)}} \text{ for infinitely many } n \in \mathbb{N} \right\}
$$

is equal to

$$
\min\left\{\frac{2}{1+\theta_1},\frac{2+\theta_2-\theta_1}{1+\theta_2}\right\},
$$

where $\theta_i = \min_{x \in [0,1]} \tau_i(x)$ for $i = 1,2$. This generalizes a result of Hussain and Wang [\[8\]](#page-17-8), in which they obtained the Hausdorff dimension of the above set when f, g, τ_1, τ_2 are all constants. It is natural to consider approximation by orbits under two (maybe different) transformations T_{β_1} and T_{β_2} in the x- and y-coordinate, respectively. Concerning this, we have the following result.

Theorem 1.2. Let $\beta_2 \geq \beta_1 > 1$, $f_1, f_2 : [0,1] \rightarrow [0,1]$ be two Lipschitz functions, and τ_1, τ_2 be two positive continuous functions on [0, 1]. Let F be the set

$$
\left\{ (x,y) \in [0,1]^2 : \frac{|T_{\beta_1}^n x - f_1(x)| < \beta_1^{-n\tau_1(x)}}{|T_{\beta_2}^n y - f_2(y)| < \beta_2^{-n\tau_2(y)}} \text{ for infinitely many } n \in \mathbb{N} \right\}
$$

.

Then the Hausdorff dimension of F is given by

$$
\dim_{\text{H}} F = \begin{cases} \min\left\{ \frac{2+\theta_1}{1+\theta_1}, \frac{2+\theta_2-\theta_1 \log_{\beta_2} \beta_1}{1+\theta_2} \right\} & \text{if } \beta_1^{1+\theta_1} < \beta_2, \\ \min\left\{ \frac{1+\log_{\beta_2} \beta_1}{(1+\theta_1)\log_{\beta_2} \beta_1}, \frac{2+\theta_2-\theta_1 \log_{\beta_2} \beta_1}{1+\theta_2} \right\} & \text{if } \beta_2 \le \beta_1^{1+\theta_1} \le \beta_2^{1+\theta_2}, \\ \min\left\{ \frac{1+\log_{\beta_2} \beta_1}{1+\theta_2}, \frac{(2+\theta_1)\log_{\beta_2} \beta_1-\theta_2}{(1+\theta_1)\log_{\beta_2} \beta_1} \right\} & \text{if } \beta_1^{1+\theta_1} > \beta_2^{1+\theta_2}, \\ \text{where for } i = 1, 2, \ \theta_i = \min_{x \in [0,1]} \tau_i(x). \end{cases} (1.9)
$$

Theorem [1.2](#page-2-0) generalizes the result of Wang and Li [\[17\]](#page-17-7) and is the main contribution of this paper. In view of Theorem [1.2](#page-2-0) and Theorem [1.1](#page-2-1) (and its motivation described above), it is natural to consider replacing the functions f_1, f_2 in Theorem [1.2](#page-2-0) by functions depending on both coordinates. For this, we have the following partial result.

Theorem 1.3. Let $\beta_2 \geq \beta_1 > 1$, $g_1, g_2 : [0, 1]^2 \rightarrow [0, 1]$ be two Lipschitz functions, and τ_1, τ_2 be two positive continuous functions on [0, 1]. Let G be the set

$$
\left\{(x,y)\in [0,1]^2: \frac{|T_{\beta_1}^nx - g_1(x,y)| < \beta_1^{-n\tau_1(x)}}{|T_{\beta_2}^ny - g_2(x,y)| < \beta_2^{-n\tau_2(y)}} \text{ for infinitely many } n \in \mathbb{N}\right\}.
$$

For $i = 1, 2$, set $\kappa_i = \max_{x \in [0,1]} \tau_i(x)$. If $\beta_2 > \beta_1^{\kappa_1}$ and $\beta_1 > \beta_2^{\kappa_2}$, then the Hausdorff dimension of G is given by (1.9) .

The paper is organized as follows. In Section [2,](#page-3-1) we give some preliminaries which include some elementary properties of beta transformations, and a special version of the mass transference principle from rectangles to rectangles recently proved by Wang and Wu $[15]$. In Section [3,](#page-6-0) we prove Theorem [1.1.](#page-2-1) In Section [4,](#page-9-0) we first give the proof of Theorem [1.2](#page-2-0) and then show how to modify it to prove Theorem [1.3.](#page-3-2)

2. Preliminaries

2.1. Properties of beta transformations. For $\beta > 1$, let T_{β} be the β -transformation on [0, 1] defined by

$$
T_{\beta}x = \beta x - \lfloor \beta x \rfloor,
$$

where $|\cdot|$ denotes the integral part of a real number. Then every $x \in [0,1]$ can be expressed uniquely as a finite or infinite series

$$
x = \frac{\epsilon_1(x,\beta)}{\beta} + \frac{\epsilon_2(x,\beta)}{\beta^2} + \dots + \frac{\epsilon_n(x,\beta)}{\beta^n} + \dots,
$$
 (2.1)

where for $n \geq 1$, $\epsilon_n(x,\beta) = \lfloor \beta T_{\beta}^{n-1} x \rfloor$. The expression [\(2.1\)](#page-3-3) or the sequence

 $(\epsilon_1(x, \beta), \epsilon_2(x, \beta), \ldots)$

is called the *β*-expansion of x, and for $n \geq 1$, $\epsilon_n(x, \beta)$ is called the *n*-th digit of x (with respect to base β).

Note that for every $x \in [0, 1]$, all its digits $\epsilon_n(x, \beta)$ are in $\{0, 1, \ldots, \lceil \beta - 1 \rceil\}$, where $\lceil \beta - 1 \rceil$ is the smallest integer not less than $\beta - 1$. However, not every sequence

over $\{0, 1, \ldots, \lceil \beta - 1 \rceil\}$ is the β -expansion for some $x \in [0, 1]$. We call a finite or an infinite sequence $(\epsilon_1, \epsilon_2, \ldots)$ admissible, if there exists an $x \in [0, 1]$ such that the β -expansion of x begins with $(\epsilon_1, \epsilon_2, \ldots)$.

For $n \geq 1$, let Σ_{β}^{n} be the set of all admissible sequences of length n. For the cardinality of Σ_{β}^n , one has the following well-known result due to Rényi.

Lemma 2.1. [\[12\]](#page-17-0) Let $\beta > 1$. Then for any $n \geq 1$,

$$
\beta^n \le \# \Sigma_{\beta}^n \le \frac{\beta^{n+1}}{\beta - 1},
$$

where $#$ denotes the cardinality of a finite set.

For any $n \geq 1$ and $w = (\epsilon_1, \ldots, \epsilon_n) \in \Sigma_{\beta}^n$, the set

$$
I_{n,\beta}(w) = \{x \in [0,1] : \epsilon_i(x,\beta) = \epsilon_i, 1 \le i \le n\}
$$

is called a cylinder of order n (with respect to base β), which is a left-closed and right-open interval of length at most β^{-n} with left endpoint

$$
\frac{\epsilon_1}{\beta} + \frac{\epsilon_2}{\beta^2} + \cdots + \frac{\epsilon_n}{\beta^n}.
$$

All cylinders of order n form a partition of the unit interval. That is,

$$
[0,1] = \bigcup_{w \in \Sigma_{\beta}^n} I_{n,\beta}(w) \tag{2.2}
$$

and a disjoint union.

The following notion plays an important role in the study of metric properties of β -expansions, which is also needed in this paper.

Definition 2.2 (Full word and full cylinder). A word $w = (\epsilon_1, \ldots, \epsilon_n) \in \Sigma_{\beta}^n$ is called a full word and $I_{n,\beta}(w)$ is called a full cylinder if

$$
|I_{n,\beta}(w)| = \frac{1}{\beta^n},
$$

where |A| denotes the diameter of a set A.

The following property of full cylinders is important in the proofs of Theorem [1.2.](#page-2-0)

Lemma 2.3. [\[3,](#page-16-4) Theorem 1.2] For each $n \geq 1$, there exists at least one full cylinder among every $n + 1$ consecutive cylinders of order n.

We will also need the following property of a Lipschitz function on full cylinders.

Lemma 2.4. [\[16,](#page-17-5) Lemma 3.1] Let $f : [0,1] \rightarrow [0,1]$ be a Lipschitz function. Then for any $n \geq 1$ and full word $w = (\epsilon_1, \ldots, \epsilon_n) \in \Sigma_{\beta}^n$, the following hold.

(i) There exists a point $x_{n,w}^*$ in the closure of $I_{n,\beta}(w)$ such that $T_{\beta}^n x_{n,w}^* = f(x_{n,w}^*)$ when $x_{n,w}^* \in I_{n,\beta}(w)$, and $f(x_{n,w}^*) = 1$ when

$$
x_{n,w}^* = \frac{\epsilon_1}{\beta} + \frac{\epsilon_2}{\beta^2} + \dots + \frac{\epsilon_n}{\beta^n} + \frac{1}{\beta^n}.
$$

(ii) For any $\epsilon > 0$ there exists a point $x_{n,w} \in I_{n,\beta}(w)$ such that

$$
|T_{\beta}^n x_{n,w} - f(x_{n,w})| < \epsilon.
$$

Proof. The part (i) was proved in $[16, \text{ Lemma } 3.1]$. Here we only show (ii) by using (i). Let $x_{n,w}^*$ be provided in (i). If $x_{n,w}^* \in I_{n,\beta}(w)$, then (ii) holds trivially by simply taking $x_{n,w} = x_{n,w}^*$. For the other case that

$$
x_{n,w}^* = \frac{\epsilon_1}{\beta} + \frac{\epsilon_2}{\beta^2} + \dots + \frac{\epsilon_n}{\beta^n} + \frac{1}{\beta^n},
$$

by the continuity of f on [0, 1] and T_{β}^n on $I_{n,\beta}(w)$, we can take $x_{n,w} \in I_{n,\beta}(w)$ to be a point which is sufficiently close to $x_{n,w}^*$ such that

$$
|f(x_{n,w}) - f(x_{n,w}^*)| = |f(x_{n,w}) - 1| < \epsilon/2,
$$
\n
$$
|T_{\beta}^n x_{n,w} - 1| = 1 - T_{\beta}^n x_{n,w} < \epsilon/2.
$$

Then it follows that

$$
|T_{\beta}^{n} x_{n,w} - f(x_{n,w})| \le |f(x_{n,w}) - 1| + |T_{\beta}^{n} x_{n,w} - 1| < \epsilon.
$$

2.2. Mass transference principle from rectangles to rectangles, a special version. Let \mathbb{R}^+ be the set of positive numbers. For $x = (x_1, \ldots, x_d) \in \mathbb{R}^d$, $\mathbf{a} =$ $(a_1, \ldots, a_d) \in (\mathbb{R}^+)^d$ and $r > 0$, let

$$
B(x,r^{\mathbf{a}})=\prod_{i=1}^d B(x_i,r^{a_i}).
$$

In the proofs of Theorem [1.2,](#page-2-0) we will make use of a recent result of Wang and Wu [\[15\]](#page-17-9), called the mass transference principle from rectangles to rectangles in Diophantine approximation. For our purpose, we only need the following special version of Wang and Wu's result.

Lemma 2.5. [\[15,](#page-17-9) Theorems 3.1-3.2] Let $\{J_n\}_{n\geq 1}$ be a sequence of finite index sets, ${x_{n,\alpha}: n \geq 1, \alpha \in J_n}$ be a sequence of points in $[0,1]^d$ and ${x_n}_{n \geq 1}$ be a nonincreasing sequence of positive numbers tending to 0. Let $\mathbf{a} = (a_1, \ldots, a_d), \mathbf{t} =$ $(t_1,\ldots,t_d)\in (\mathbb{R}^+)^d$. Set

 $W(\mathbf{t}) = \left\{ x \in [0,1]^d : x \in B(x_{n,\alpha}, r_n^{\mathbf{a}+\mathbf{t}}) \text{ for infinitely many } n \in \mathbb{N} \text{ and } \alpha \in J_n \right\}.$

If for all large n, the set

$$
\left\{ x \in [0,1]^d : x \in \bigcup_{\alpha \in J_n} B(x_{n,\alpha}, r_n^{\mathbf{a}}) \right\}
$$
 (2.3)

is of full Lebesgue measure, then for any ball $B \subset [0,1]^d$,

$$
\dim_{\mathrm{H}} B \cap W(\mathbf{t}) \ge \min_{A \in \mathcal{A}} \left\{ \# \mathcal{K}_1 + \# \mathcal{K}_2 + \frac{\sum_{k \in \mathcal{K}_3} a_k - \sum_{k \in \mathcal{K}_2} t_k}{A} \right\},\,
$$

where

$$
\mathcal{A} = \{a_i, a_i + t_i : 1 \leq i \leq d\},\
$$

and for each
$$
A \in \mathcal{A}
$$
, the sets $\mathcal{K}_1, \mathcal{K}_2, \mathcal{K}_3$ form a partition of $\{1, ..., d\}$ defined as

$$
\mathcal{K}_1 = \{k : a_k \ge A\}, \ \mathcal{K}_2 = \{k : a_k + t_k \le A\} \setminus \mathcal{K}_1, \ \mathcal{K}_3 = \{1, ..., d\} \setminus (\mathcal{K}_1 \cup \mathcal{K}_2).
$$

We remark that the condition [\(2.3\)](#page-5-0) above is to guarantee the local ubiquity for rectangles ([\[15,](#page-17-9) Definition 3.2]) needed in [\[15,](#page-17-9) Theorems 3.1-3.2].

3. Proof of Theorem [1.1](#page-2-1)

We first prove the Lebesgue measure part of the theorem. For $y \in [0,1]$, let

 $D_y = \left\{ x \in [0,1] : |T_\beta^n x - f(x,y)| < \varphi(n) \text{ for infinitely many } n \in \mathbb{N} \right\}.$

Since $f : [0, 1]^2 \to [0, 1]$ is a Lipschitz function, so is the function $x \mapsto f(x, y)$ for every $y \in [0, 1]$. Hence by [\[9,](#page-17-6) Theorem 1.6], for every $y \in [0, 1]$,

$$
\mathcal{L}(D_y) = \begin{cases} 0 & \text{if } \sum_{n=1}^{\infty} \varphi(n) < \infty, \\ 1 & \text{if } \sum_{n=1}^{\infty} \varphi(n) = \infty. \end{cases}
$$

Then by the Fubini's theorem,

$$
\mathcal{L}^2(W_\beta(f,\varphi)) = \int_0^1 \int_0^1 \mathbb{1}_{W_\beta(f,\varphi)}((x,y))dxdy = \int_0^1 \int_0^1 \mathbb{1}_{D_y}(x)dxdy = \int_0^1 \mathcal{L}(D_y)dy,
$$

where $\mathbb{1}_A$ denotes the characteristic function of a set A. Therefore, we have

$$
\mathcal{L}^2(W_\beta(f,\varphi)) = \begin{cases} 0 & \text{if } \sum_{n=1}^\infty \varphi(n) < \infty, \\ 1 & \text{if } \sum_{n=1}^\infty \varphi(n) = \infty. \end{cases}
$$

This proves the Lebesgue measure part of the theorem.

Next we prove the Hausdorff dimension part. Suppose that $\sum_{n=1}^{\infty} \varphi(n) < \infty$. Then without loss of generality we can assume that $\varphi(n) < 1$ for all $n \in \mathbb{N}$. Again since for every $y \in [0, 1]$, the function $x \mapsto f(x, y)$ is Lipschitz, it follows from [\[16,](#page-17-5) Theorem 1.1 that for any $y \in [0, 1]$,

$$
\dim_{\mathrm{H}} D_y = \frac{1}{1+\alpha} \quad \text{with } \alpha = \liminf_{n \to \infty} \frac{\log_{\beta} \varphi(n)^{-1}}{n}.
$$

Then by [\[5,](#page-16-5) Corollary 7.12],

$$
\dim_{\mathrm{H}} W_{\beta}(f,\varphi) \ge 1 + \frac{1}{1+\alpha}.
$$

In the following we prove the converse inequality.

For $n \in \mathbb{N}$, let

$$
W_n = \{(x, y) \in [0, 1]^2 : |T_{\beta}^n x - f(x, y)| < \varphi(n)\}.
$$

Then

$$
W_{\beta}(f,\varphi) = \bigcap_{\substack{N=1\\7}}^{\infty} \bigcup_{n=N}^{\infty} W_n.
$$
 (3.1)

Let

$$
J_{n,\beta}(k) = \left[\frac{k\varphi(n)}{\beta^n}, \frac{(k+1)\varphi(n)}{\beta^n}\right] \cap [0,1], \quad \text{for } k = 0, 1, \ldots, \left\lfloor \frac{\beta^n}{\varphi(n)} \right\rfloor.
$$

Then clearly

$$
[0,1] = \bigcup_{0 \leq k \leq \left\lfloor \frac{\beta^n}{\varphi(n)} \right\rfloor} J_{n,\beta}(k).
$$

Hence we have

$$
[0,1]^2 = \bigcup_{w \in \Sigma^n_\beta} \bigcup_{0 \leq k \leq \left\lfloor \frac{\beta^n}{\varphi(n)} \right\rfloor} I_{n,\beta}(w) \times J_{n,\beta}(k).
$$

Therefore,

$$
W_n = \bigcup_{w \in \Sigma^n_\beta} \bigcup_{0 \le k \le \left\lfloor \frac{\beta^n}{\varphi(n)} \right\rfloor} \left\{ (x, y) \in I_{n, \beta}(w) \times J_{n, \beta}(k) : |T^n_\beta x - f(x, y)| < \varphi(n) \right\}. \tag{3.2}
$$

Since $f : [0,1]^2 \rightarrow [0,1]$ is Lipschitz, there exists $L > 0$ such that for any $x, y, x', y' \in [0, 1],$

$$
|f(x,y) - f(x',y')| \le L ||(x - x', y - y')||,
$$
\n(3.3)

where $\|\cdot\|$ is the Euclidean norm. Let $w \in \Sigma_{\beta}^n$, $0 \leq k \leq \left|\frac{\beta^n}{\varphi(n)}\right|$ $\varphi(n)$ |, and $(x, y) \in$ $I_{n,\beta}(\omega) \times J_{n,\beta}(k)$. If $(x, y) \in W_n$, then by [\(3.3\)](#page-7-0) we see that for large n,

$$
|T_{\beta}^n x - f(x, k\varphi(n)/\beta^n)| \le |T_{\beta}^n x - f(x, y)| + |f(x, y) - f(x, k\varphi(n)/\beta^n)|
$$

$$
\le \varphi(n) + \frac{L\varphi(n)}{\beta^n}
$$

$$
< 2\varphi(n).
$$
 (3.4)

Therefore, for large n , we have

$$
\begin{aligned} \left\{ (x,y) \in I_{n,\beta}(w) \times J_{n,\beta}(k) : |T_{\beta}^n x - f(x,y)| < \varphi(n) \right\} \\ &\subset \left\{ x \in I_{n,\beta}(w) : |T_{\beta}^n x - f(x,k\varphi(n)/\beta^n)| < 2\varphi(n) \right\} \times J_{n,\beta}(k) \\ &:= \tilde{I}_{n,\beta}(w,k) \times J_{n,\beta}(k), \end{aligned}
$$

and thus by (3.2) ,

$$
W_n \subset \bigcup_{w \in \Sigma^n_\beta} \bigcup_{0 \le k \le \left\lfloor \frac{\beta^n}{\varphi(n)} \right\rfloor} \tilde{I}_{n,\beta}(w,k) \times J_{n,\beta}(k). \tag{3.5}
$$

Below we estimate the diameter of $\tilde{I}_{n,\beta}(w, k) \times J_{n,\beta}(k)$. To this end, let $x_1, x_2 \in$ $\tilde{I}_{n,\beta}(w, k)$. Then by [\(3.4\)](#page-7-2) and [\(3.3\)](#page-7-0), for large n,

$$
4\varphi(n) > |T_{\beta}^{n}x_{1} - f(x_{1}, k\varphi(n)/\beta^{n})| + |T_{\beta}^{n}x_{2} - f(x_{2}, k\varphi(n)/\beta^{n})|
$$

\n
$$
\geq |T_{\beta}^{n}x_{1} - T_{\beta}^{n}x_{2}| - |f(x_{1}, k\varphi(n)/\beta^{n}) - f(x_{2}, k\varphi(n)/\beta^{n})|
$$

\n
$$
\geq (\beta^{n} - L)|x_{1} - x_{2}|
$$

\n
$$
\geq \frac{\beta^{n}}{2}|x_{1} - x_{2}|.
$$

This implies that for all large n, the diameter of $\tilde{I}_{n,\beta}(w, k)$ satisfies that

$$
|\tilde{I}_{n,\beta}(w,k)| \le \frac{8\varphi(n)}{\beta^n}.
$$

As a consequence, for all large n ,

$$
|\tilde{I}_{n,\beta}(w,k)\times J_{n,\beta}(k)| \leq \frac{9\varphi(n)}{\beta^n}.
$$

By (3.1) and (3.5) , for every $N \in \mathbb{N}$, the family

$$
\left\{\tilde{I}_{n,\beta}(w,k)\times J_{n,\beta}(k):n\geq N,w\in\Sigma_{\beta}^{n},0\leq k\leq\left\lfloor\frac{\beta^{n}}{\varphi(n)}\right\rfloor\right\}
$$

is a covering of $W_\beta(f, \varphi)$. Recall that $\alpha = \liminf_{n \to \infty} \frac{\log_\beta \varphi(n)^{-1}}{n}$ $\frac{\rho(n)^{-1}}{n}$. Let $s > 1 + \frac{1}{1+\alpha}$. Then we have

$$
\mathcal{H}^{s}_{\infty}(W_{\beta}(f,\varphi)) \leq \liminf_{N \to \infty} \sum_{n \geq N} \sum_{w \in \Sigma_{\beta}^{n}} \sum_{0 \leq k \leq \lfloor \frac{\beta^{n}}{\varphi(n)} \rfloor} |\tilde{I}_{n,\beta}(w,k) \times J_{n,\beta}(k)|^{s}
$$

$$
\leq \liminf_{N \to \infty} \sum_{n \geq N} \sum_{w \in \Sigma_{\beta}^{n}} \sum_{0 \leq k \leq \lfloor \frac{\beta^{n}}{\varphi(n)} \rfloor} \left(\frac{9\varphi(n)}{\beta^{n}}\right)^{s}
$$

$$
\leq \liminf_{N \to \infty} \sum_{n \geq N} \frac{\beta^{n+1}}{\beta - 1} \cdot \frac{2\beta^{n}}{\varphi(n)} \cdot \left(\frac{9\varphi(n)}{\beta^{n}}\right)^{s} \quad \text{(by Lemma 2.1)}
$$

= 0,

here and afterwards \mathcal{H}_{∞}^{s} denotes the s-dimensional Hausdorff content [\[1\]](#page-16-6). Since $s > 1 + \frac{1}{1+\alpha}$ is arbitrary, it follows that

$$
\dim_{\mathrm{H}} W_{\beta}(f,\varphi) \leq 1 + \frac{1}{1+\alpha}.
$$

This proves the Hausdorff dimension part and completes the proof of Theorem [1.1.](#page-2-1)

4. Proofs of Theorems [1.2](#page-2-0)[-1.3](#page-3-2)

4.1. Proof of Theorem [1.2.](#page-2-0) The upper bounds part. Recall the formula (2.2) . So for every $n \in \mathbb{N}$,

$$
[0,1]^2 = \bigcup_{w \in \Sigma_{\beta_1}^n, v \in \Sigma_{\beta_2}^n} I_{n,\beta_1}(w) \times I_{n,\beta_2}(v).
$$

For $w \in \Sigma_{\beta_1}^n$ and $v \in \Sigma_{\beta_2}^n$, let

$$
J_{n,\beta_1}(w) = \left\{ x \in I_{n,\beta_1}(w) : |T_{\beta_1}^n x - f_1(x)| < \beta_1^{-n\tau_1(x)} \right\},\tag{4.1}
$$

$$
J_{n,\beta_2}(v) = \left\{ y \in I_{n,\beta_2}(v) : |T_{\beta_2}^n y - f_2(y)| < \beta_2^{-n\tau_2(y)} \right\}.
$$

Then we have

$$
F = \bigcap_{N=1}^{\infty} \bigcup_{n=N}^{\infty} \left\{ (x, y) \in [0, 1]^2 : \frac{|T_{\beta_1}^n x - f_1(x)| < \beta_1^{-n\tau_1(x)}}{|T_{\beta_2}^n y - f_2(y)| < \beta_2^{-n\tau_2(y)}} \right\}
$$
\n
$$
= \bigcap_{N=1}^{\infty} \bigcup_{n=N}^{\infty} \bigcup_{w \in \Sigma_{\beta_1}^n, v \in \Sigma_{\beta_2}^n} J_{n, \beta_1}(w) \times J_{n, \beta_2}(v). \tag{4.2}
$$

Fix $w \in \sum_{\beta_1}^n$ and $v \in \sum_{\beta_2}^n$. In the following we estimate the diameters of $J_{n,\beta_1}(w)$ and $J_{n,\beta_2}(v)$. For $i = 1, 2$, let $\theta_i = \min_{x \in [0,1]} \tau_i(x)$. Since $f_1 : [0,1] \to [0,1]$ is Lipschitz, there exists $L > 0$ such that

$$
|f_1(x) - f_1(x')| \le L|x - x'| \quad \text{for any } x, x' \in [0, 1]. \tag{4.3}
$$

Let $x, x' \in J_{n,\beta_1}(w)$. Then by (4.1) and (4.3) ,

$$
2\beta_1^{-n\theta_1} \ge |T_{\beta_1}^n x - f_1(x)| + |T_{\beta_1}^n x' - f_1(x')|
$$

\n
$$
\ge |T_{\beta_1}^n x - T_{\beta_1}^n x'| - |f_1(x) - f_1(x')|
$$

\n
$$
\ge (\beta_1^n - L)|x - x'|.
$$
 (4.4)

Since $\beta_1^n - L > \frac{\beta_1^n}{2}$ for large n, [\(4.4\)](#page-9-3) implies that for large n,

$$
|J_{n,\beta_1}(w)| \le 4\beta_1^{-n(1+\theta_1)}.\tag{4.5}
$$

Similarly, for large n we have

$$
|J_{n,\beta_2}(v)| \le 4\beta_2^{-n(1+\theta_2)}.\tag{4.6}
$$

From [\(4.2\)](#page-9-4) we see that for every $N \in \mathbb{N}$, the family

$$
\left\{J_{n,\beta_1}(w) \times J_{n,\beta_2}(v) : n \ge N, w \in \Sigma_{\beta_1}^n, v \in \Sigma_{\beta_2}^n\right\}
$$
\n(4.7)

is a covering of F . In the following, we obtain upper bounds for the Hausdorff dimension of F by considering three cases separately.

Case 1. $\beta_1^{1+\theta_1} < \beta_2$. Note that in this case,

$$
4\beta_2^{-n(1+\theta_2)} \le 4\beta_2^{-n} \le 4\beta_1^{-n(1+\theta_1)}, \quad \forall n \in \mathbb{N}.
$$

Hence each $J_{n,\beta_1}(w) \times J_{n,\beta_2}(v)$ in the family (4.7) can be covered by at most

$$
2 \times \frac{4\beta_1^{-n(1+\theta_1)}}{4\beta_2^{-n(1+\theta_2)}} = 2\beta_2^{n((1+\theta_2)-(1+\theta_1)\log_{\beta_2}\beta_1)}
$$

many squares of side length $4\beta_2^{-n(1+\theta_2)}$ $\frac{(-n(1+\theta_2))}{2}$. Thus for $s > \frac{2+\theta_2-\theta_1\log_{\beta_2}\beta_1}{1+\theta_2}$ $\frac{\frac{1}{\sigma_1} \log \frac{\beta_2}{\sigma_1}}{1+\theta_2}$, we have

$$
\mathcal{H}_{\infty}^{s}(F) \leq \liminf_{N \to \infty} \sum_{n=N}^{\infty} \sum_{w \in \Sigma_{\beta_1}^{n}, v \in \Sigma_{\beta_2}^{n}} 2\beta_2^{n((1+\theta_2)-(1+\theta_1)\log_{\beta_2}\beta_1)} \left(4\sqrt{2}\beta_2^{-n(1+\theta_2)}\right)^s
$$

$$
\ll \liminf_{N \to \infty} \sum_{n=N}^{\infty} \beta_1^{n} \beta_2^{n} \beta_2^{n((1+\theta_2)(1-s)-(1+\theta_1)\log_{\beta_2}\beta_1)} \qquad \text{(by Lemma 2.1)}
$$

$$
= \liminf_{N \to \infty} \sum_{n=N}^{\infty} \beta_2^{n(2+\theta_2-\theta_1\log_{\beta_2}\beta_1-(1+\theta_2)s)}
$$

$$
= 0.
$$

Hence

$$
\dim_{\mathrm{H}} F \le \frac{2 + \theta_2 - \theta_1 \log_{\beta_2} \beta_1}{1 + \theta_2}.
$$
\n(4.8)

On the other hand, since $4\beta_2^{-n(1+\theta_2)} \leq 4\beta_1^{-n(1+\theta_1)}$ $I_1^{-n(1+\theta_1)}, \text{ each } J_{n,\beta_1}(w) \times J_{n,\beta_2}(v) \text{ can}$ be covered by a single square of side length $4\beta_1^{-n(1+\theta_1)}$ $\frac{(-n(1+\theta_1))}{1}$. Moreover, since β_2^{-n} < $4\beta_1^{-n(1+\theta_1)}$ $\frac{1}{1}$, we see that each such square covers at least

$$
\frac{1}{2} \times \frac{4\beta_1^{-n(1+\theta_1)}}{\beta_2^{-n}} = 8\beta_2^{n(1-(1+\theta_1)\log_{\beta_2}\beta_1)} := k_n(w)
$$

many sets $J_{n,\beta_1}(w) \times J_{n,\beta_2}(v_i)$ $(i = 1, ..., k_n(w))$ such that $I_{n,\beta_2}(v_1), ..., I_{n,\beta_2}(v_{k_n(w)})$ are consecutive cylinders of order n . Therefore, the set

$$
\bigcup_{w \in \Sigma_{\beta_1}^n, v \in \Sigma_{\beta_2}^n} J_{n,\beta_1}(w) \times J_{n,\beta_2}(v)
$$

can be covered by

$$
\frac{\beta_1^n}{\beta_1 - 1} \cdot \frac{\beta_2^n}{\beta_2 - 1} \cdot \frac{1}{8\beta_2^{n(1 - (1+\theta_1)\log_{\beta_2}\beta_1)}}
$$

many squares of side length $4\beta_1^{-n(1+\theta_1)}$ $\frac{(-n(1+\theta_1))}{1}$. As a consequence, for $s > \frac{2+\theta_1}{1+\theta_1}$, we have

$$
\mathcal{H}_{\infty}^{s}(F) \ll \liminf_{N \to \infty} \sum_{n=N}^{\infty} \beta_1^n \beta_2^n \beta_2^{-n(1-(1+\theta_1)\log_{\beta_2} \beta_1)} \beta_1^{-n(1+\theta_1)s}
$$

$$
= \liminf_{N \to \infty} \sum_{n=N}^{\infty} \beta_2^{n(2+\theta_1-(1+\theta_1)s)\log_{\beta_2} \beta_1}
$$

$$
= 0.
$$

Hence

$$
\dim_{\mathrm{H}} F \le \frac{2 + \theta_1}{1 + \theta_1}.
$$

This combined with [\(4.8\)](#page-10-0) gives the desired upper bound for $\dim_{\text{H}} F$ when $\beta_1^{1+\theta_1} < \beta_2$.

Cases 2. $\beta_2 \leq \beta_1^{1+\theta_1} \leq \beta_2^{1+\theta_2}$. Since $4\beta_2^{-n(1+\theta_2)} \leq 4\beta_1^{-n(1+\theta_1)}$ $\frac{1}{1}$ ^{-n(1+ σ ¹)}, as in Case 1 we see that [\(4.8\)](#page-10-0) still holds. Again, each $J_{n,\beta_1}(w) \times J_{n,\beta_2}(v)$ in [\(4.7\)](#page-9-5) can be covered by a single square of side length $4\beta_1^{-(1+\theta_1)}$ $\frac{-n(1+\theta_1)}{1}$. Thus for $s > \frac{1+\log_{\beta_2} \beta_1}{(1+\theta_1)\log_{\beta_2} s_1}$ $\frac{1+\log_{\beta_2} \rho_1}{(1+\theta_1)\log_{\beta_2} \beta_1}$, we have

$$
\mathcal{H}_{\infty}^{s}(F) \leq \liminf_{N \to \infty} \sum_{n=N}^{\infty} \sum_{w \in \Sigma_{\beta_1}^n, v \in \Sigma_{\beta_2}^n} \left(4\sqrt{2}\beta_1^{-n(1+\theta_1)}\right)^s
$$

$$
\ll \liminf_{N \to \infty} \sum_{n=N}^{\infty} \beta_1^n \beta_2^n \beta_1^{-ns(1+\theta_1)}
$$

$$
= \liminf_{N \to \infty} \sum_{n=N}^{\infty} \beta_2^{n\left((1 + \log_{\beta_2} \beta_1) - s(1 + \theta_1) \log_{\beta_2} \beta_1\right)}
$$

$$
= 0,
$$

which implies that

$$
\dim_{\mathrm{H}} F \le \frac{1 + \log_{\beta_2} \beta_1}{(1 + \theta_1) \log_{\beta_2} \beta_1}.
$$

Combining this with (4.8) yields the desired upper bound for dim_H F in Case 2.

Case 3. $\beta_1^{1+\theta_1} > \beta_2^{1+\theta_2}$. In this case, we have

$$
4\beta_2^{-n(1+\theta_2)} > 4\beta_1^{-n(1+\theta_1)}, \quad \forall n \in \mathbb{N}.
$$

Then by a similar argument as in Case 2, it is easily seen that

$$
\dim_{\mathrm{H}} F \le \min \left\{ \frac{1 + \log_{\beta_2} \beta_1}{1 + \theta_2}, \frac{(2 + \theta_1) \log_{\beta_2} \beta_1 - \theta_2}{(1 + \theta_1) \log_{\beta_2} \beta_1} \right\}.
$$

The lower bounds part. Fix a full word $w \in \Sigma_{\beta_1}^n$. Then by Lemma [2.4\(](#page-4-2)ii), there exists a point $x_{n,w} \in I_{n,\beta_1}(w)$ such that

$$
|T_{\beta_1}^n x_{n,w} - f_1(x_{n,w})| < \frac{1}{2} \beta_1^{-n\kappa_1},
$$

where $\kappa_i := \max_{x \in [0,1]} \tau_i(x)$ for $i = 1, 2$. Thus for any $x \in I_{n,\beta_1}(w)$ and all large n,

$$
|T_{\beta_1}^n x - f_1(x)| - \frac{1}{2}\beta_1^{-n\kappa_1} \le |T_{\beta_1}^n x - f_1(x)| - |T_{\beta_1}^n x_{n,w} - f_1(x_{n,w})|
$$

\n
$$
\le |T_{\beta_1}^n x - T_{\beta_1}^n x_{n,w}| + |f_1(x) - f_1(x_{n,w})|
$$

\n
$$
\le (\beta_1^n + L)|x - x_{n,w}| \qquad \text{(by (4.3))}
$$

\n
$$
\le 2\beta_1^n |x - x_{n,w}|.
$$

Hence if $|x - x_{n,w}| < \frac{1}{4}$ $\frac{1}{4}\beta_1^{-n(1+\tau_1(x))}$ $t_1^{-(n+1+T_1(x))}$, then

$$
|T_{\beta_1}^n x - f_1(x)| < 2\beta_1^n \times \frac{1}{4}\beta_1^{-n(1+\tau_1(x))} + \frac{1}{2}\beta_1^{-n\kappa_1} \le \beta_1^{-n\tau_1(x)}.
$$

This implies that

$$
J_{n,\beta_1}(w) \supset \left\{ x \in I_{n,\beta_1}(w) : |x - x_{n,w}| < \frac{1}{4} \beta_1^{-n(1+\tau_1(x))} \right\} := \tilde{J}_{n,\beta_1}(w).
$$

Similarly, for any full word $v \in \sum_{\beta_2}^n$ and for all large n, there exists a point $y_{n,v} \in$ $I_{n,\beta_2}(v)$ such that

$$
J_{n,\beta_2}(v) \supset \left\{ y \in I_{n,\beta_2}(v) : |y - y_{n,v}| < \frac{1}{4} \beta_2^{-n(1+\tau_2(y))} \right\} := \tilde{J}_{n,\beta_2}(v).
$$

Therefore, by (4.2) we have

$$
F \supset \bigcap_{N=1}^{\infty} \bigcup_{n=N}^{\infty} \bigcup_{w \in \Sigma_{\beta_1}^n, v \in \Sigma_{\beta_2}^n} \tilde{J}_{n,\beta_1}(w) \times \tilde{J}_{n,\beta_2}(v) := \tilde{F}.
$$
 (4.9)

Fix $\epsilon > 0$. Since τ_1, τ_2 are continuous functions on [0, 1], there exists a ball $B \subset [0,1]^2$ such that for any $(x, y) \in B$,

$$
\tau_1(x) \le \theta_1 + \epsilon/2, \quad \tau_2(y) \le \theta_2 + \epsilon/2.
$$

Let $n \in \mathbb{N}$ be large so that

$$
\beta_1^{-n\epsilon/2} \le \frac{1}{8} \quad \text{and} \quad n+1 \le \beta_1^{n\epsilon}.\tag{4.10}
$$

Then for any full words $w \in \sum_{\beta_1}^n$ and $v \in \sum_{\beta_2}^n$, we have

$$
B \cap \left(\tilde{J}_{n,\beta_1}(w) \times \tilde{J}_{n,\beta_2}(v)\right) \supset B \cap \left(J_{n,\beta_1}^*(w) \times J_{n,\beta_2}^*(v)\right),\tag{4.11}
$$

where

$$
J_{n,\beta_1}^*(w) = \left\{ x \in I_{n,\beta_1}(w) : |x - x_{n,w}| < \frac{1}{4} \beta_1^{-n(1+\theta_1 + \epsilon/2)} \right\},
$$

$$
J_{n,\beta_2}^*(v) = \left\{ y \in I_{n,\beta_2}(v) : |y - y_{n,v}| < \frac{1}{4} \beta_2^{-n(1+\theta_2 + \epsilon/2)} \right\}.
$$

Note that $J^*_{n,\beta_1}(w)$ contains a ball centered in $I_{n,\beta_1}(w)$ of radius $\frac{1}{8}\beta_1^{-n(1+\theta_1+\epsilon/2)}$ $\int_1^{-n(1+\sigma_1+\epsilon/2)}$, and $J_{n,\beta_2}^*(v)$ contains a ball centered in $I_{n,\beta_2}(v)$ of radius $\frac{1}{8}\beta_2^{-n(1+\theta_2+\epsilon/2)}$ $\frac{2^{n(1+\sigma_2+\epsilon/2)}}{2}$. Hence we see from (4.10) and (4.11) that

$$
B \cap \left(\tilde{J}_{n,\beta_1}(w) \times \tilde{J}_{n,\beta_2}(v) \right) \supset B \cap \left(B \left(\overline{x}_{n,w}, \beta_1^{-n(1+\theta_1+\epsilon)} \right) \times B \left(\overline{y}_{n,v}, \beta_2^{-n(1+\theta_2+\epsilon)} \right) \right)
$$

for some $\overline{x}_{n,w} \in I_{n,\beta_1}(w)$ and $\overline{y}_{n,v} \in I_{n,\beta_2}(v)$. Therefore,

$$
B \cap \widetilde{F} \supseteq B \cap W(\mathbf{t}), \tag{4.12}
$$

where

$$
W(\mathbf{t}) = \bigcap_{N=1}^{\infty} \bigcup_{n=N}^{\infty} \bigcup_{w \in \Sigma_{\beta_1}^n, v \in \Sigma_{\beta_2}^n} B\left(\overline{x}_{n,w}, \beta_2^{-n(1+\theta_1+\epsilon)\log_{\beta_2}\beta_1}\right) \times B\left(\overline{y}_{n,v}, \beta_2^{-n(1+\theta_2+\epsilon)}\right),\tag{4.13}
$$

and

$$
\mathbf{t} = (t_1, t_2) = ((\theta_1 + 2\epsilon) \log_{\beta_2} \beta_1, \theta_2 + 2\epsilon).
$$

From Lemma [2.3](#page-4-3) we know that for every $x \in [0, 1]$, among any $n + 1$ consecutive cylinders of order n around x , there is at least one full cylinder. So, there exists a full word $w \in \sum_{\beta_1}^n$ such that

$$
|x - \overline{x}_{n,w}| \le (n+1)\beta_1^{-n} \le \beta_1^{-n(1-\epsilon)} = \beta_2^{-n(1-\epsilon)\log_{\beta_2} \beta_1}.
$$

Thus

$$
[0,1]\subset \bigcup_{w\in \Sigma^n_{\beta_1} \textrm{full}} B\left(\overline{x}_{n,w},\beta_2^{-n(1-\epsilon)\log_{\beta_2}\beta_1}\right).
$$

Similarly,

$$
[0,1] \subset \bigcup_{v \in \Sigma_{\beta_2}^n \text{ full}} B\left(\overline{y}_{n,v}, \beta_2^{-n(1-\epsilon)}\right).
$$

Therefore, for all large n , the set

$$
\left\{ z \in [0,1]^2 : z \in \bigcup_{w \in \Sigma_{\beta_1}^n, v \in \Sigma_{\beta_2}^n \text{ full}} B\left(\overline{x}_{n,w}, \beta_2^{-n(1-\epsilon)\log_{\beta_2} \beta_1}\right) \times B\left(\overline{y}_{n,v}, \beta_2^{-n(1-\epsilon)}\right) \right\}
$$
\n(4.14)

is of full Lebesgue measure (indeed it equals $[0, 1]^2$). Let

$$
\mathbf{a} = (a_1, a_2) = ((1 - \epsilon) \log_{\beta_2} \beta_1, 1 - \epsilon).
$$

Then

$$
\mathbf{a} + \mathbf{t} = (a_1 + t_1, a_2 + t_2) = ((1 + \theta_1 + \epsilon) \log_{\beta_2} \beta_1, 1 + \theta_2 + \epsilon).
$$

Now by (4.13) , (4.14) and Lemma [2.5,](#page-5-1) we have

$$
\dim_{\mathrm{H}} B \cap W(\mathbf{t}) \ge \min_{A \in \mathcal{A}} \left\{ \# \mathcal{K}_1 + \# \mathcal{K}_2 + \frac{\sum_{k \in \mathcal{K}_3} a_k - \sum_{k \in \mathcal{K}_2} t_k}{A} \right\} := s,\qquad(4.15)
$$

where

 $\mathcal{A} = \{a_k, a_k + t_k : k = 1, 2\} = \{(1 - \epsilon) \log_{\beta_2} \beta_1, (1 + \theta_1 + \epsilon) \log_{\beta_2} \beta_1, 1 - \epsilon, 1 + \theta_2 + \epsilon\},\$ and for each $A \in \mathcal{A}$ the sets $\mathcal{K}_1, \mathcal{K}_2, \mathcal{K}_3$ form a partition of $\{1, 2\}$ defined as

$$
\mathcal{K}_1 = \{k : a_k \ge A\}, \quad \mathcal{K}_2 = \{k : a_k + t_k \le A\} \setminus \mathcal{K}_1, \quad \mathcal{K}_3 = \{1, 2\} \setminus (\mathcal{K}_1 \cup \mathcal{K}_2).
$$

For convenience, write

$$
s_A = \# \mathcal{K}_1 + \# \mathcal{K}_2 + \frac{\sum_{k \in \mathcal{K}_3} a_k - \sum_{k \in \mathcal{K}_2} t_k}{A} \quad \text{for } A \in \mathcal{A}.
$$

In the following, we evaluate s in (4.15) . We consider three cases separately.

When $\beta_1^{1+\theta_1} < \beta_2$, we let $\epsilon > 0$ be small enough so that $(1+\theta_1+\epsilon) \log_{\beta_2} \beta_1 \leq 1-\epsilon$. Then by definition and a simple calculation, we see that

$$
s_A = \begin{cases} 2 & \text{if } A = (1-\epsilon)\log_{\beta_2}\beta_1, \\ \frac{2+\theta_1}{1+\theta_1+\epsilon} & \text{if } A = (1+\theta_1+\epsilon)\log_{\beta_2}\beta_1, \\ 2 - \frac{(\theta_1+2\epsilon)\log_{\beta_2}\beta_1}{1-\epsilon} & \text{if } A = 1-\epsilon, \\ \frac{2+\theta_2-(\theta_1+2\epsilon)\log_{\beta_2}\beta_1}{1+\theta_2+\epsilon} & \text{if } A = 1+\theta_2+\epsilon. \end{cases}
$$

Since $(1 + \theta_1 + \epsilon) \log_{\beta_2} \beta_1 \leq 1 - \epsilon$, we have

$$
2 - \frac{(\theta_1 + 2\epsilon) \log_{\beta_2} \beta_1}{1 - \epsilon} \ge 2 - \frac{\theta_1 + 2\epsilon}{1 + \theta_1 + \epsilon} = \frac{2 + \theta_1}{1 + \theta_1 + \epsilon}.
$$

Hence in this case,

$$
s = \min_{A \in \mathcal{A}} s_A = \min \left\{ \frac{2 + \theta_1}{1 + \theta_1 + \epsilon}, \frac{2 + \theta_2 - (\theta_1 + 2\epsilon) \log_{\beta_2} \beta_1}{1 + \theta_2 + \epsilon} \right\}.
$$

By this, [\(4.9\)](#page-12-2), [\(4.12\)](#page-12-3) and [\(4.15\)](#page-13-2) (and let $\epsilon \to 0$), we obtain the desired lower bound for dim_H F when $\beta_1^{1+\theta_1} < \beta_2$.

For the other two cases that $\beta_2 \leq \beta_1^{1+\theta_1} \leq \beta_2^{1+\theta_2}$ and $\beta_1^{1+\theta_1} > \beta_2^{1+\theta_2}$, we let $\epsilon > 0$ be small enough so that

$$
\begin{cases} 1-\epsilon < (1+\theta_1+\epsilon)\log_{\beta_2} \beta_1 < 1+\theta_2+\epsilon & \quad \text{if } \beta_2 \leq \beta_1^{1+\theta_1} \leq \beta_2^{1+\theta_2}, \\ (1+\theta_1+\epsilon)\log_{\beta_2} \beta_1 \geq 1+\theta_2+\epsilon & \quad \text{if } \beta_1^{1+\theta_1} > \beta_2^{1+\theta_2}. \end{cases}
$$

Then in each of these two cases, s_A for $A \in \mathcal{A}$ (and thus s) can be easily evaluated. Indeed, we have

$$
s = \begin{cases} \min\left\{ \frac{(1-\epsilon)(1+\log_{\beta_2}\beta_1)}{(1+\theta_1+\epsilon)\log_{\beta_2}\beta_1}, \frac{2+\theta_2-(\theta_1+2\epsilon)\log_{\beta_2}\beta_1}{1+\theta_2+\epsilon} \right\} & \text{if } \beta_2 \le \beta_1^{1+\theta_1} \le \beta_2^{1+\theta_2},\\ \min\left\{ \frac{(1-\epsilon)(1+\log_{\beta_2}\beta_1)}{1+\theta_2+\epsilon}, \frac{(2+\theta_1)\log_{\beta_2}\beta_1-(\theta_2+2\epsilon)}{(1+\theta_1+\epsilon)\log_{\beta_2}\beta_1} \right\} & \text{if } \beta_1^{1+\theta_1} > \beta_2^{1+\theta_2}. \end{cases}
$$

Then a similar argument as above yields the desired lower bounds for $\dim_\text{H} F$ in these two cases. This completes the proof of Theorem [1.2.](#page-2-0)

4.2. Proof of Theorem [1.3.](#page-3-2) Since the proof of Theorem [1.3](#page-3-2) is similar to that of Theorem [1.2,](#page-2-0) in this subsection we only point out the modifications of Subsection [4.1](#page-9-6) needed to prove Theorem [1.3.](#page-3-2)

The upper bounds part. We prove this part under the weaker assumption that $\beta_2 \geq \beta_1^{\theta_1}$ and $\beta_1 \geq \beta_2^{\theta_2}$. Since $g_1, g_2 : [0, 1]^2 \to [0, 1]$ are Lipschitz functions, there exists $L > 0$ such that for any $(x, y), (x', y') \in [0, 1]^2$,

$$
|g_i(x, y) - g_i(x', y')| \le L ||(x - x', y - y')||, \quad i = 1, 2.
$$
 (4.16)

For $w \in \Sigma_{\beta_1}^n$ and $v \in \Sigma_{\beta_2}^n$, let $a_{n,w}^1$, $a_{n,v}^2$ be the left endpoints of $I_{n,\beta_1}(w)$ and $I_{n,\beta_2}(v)$, respectively. Let $(x,y) \in I_{n,\beta_1}(w) \times I_{n,\beta_2}(v)$ such that

$$
|T_{\beta_1}^n x - g_1(x, y)| < \beta_1^{-n\tau_1(x)}, \quad |T_{\beta_2}^n y - g_2(x, y)| < \beta_2^{-n\tau_2(y)}.
$$

Then we have

$$
|T_{\beta_1}^n x - g_1(x, a_{n,v}^2)| \le |T_{\beta_1}^n x - g_1(x, y)| + |g_1(x, y) - g_1(x, a_{n,v}^2)|
$$

$$
< \beta_1^{-n\tau_1(x)} + L|y - a_{n,v}^2|
$$

$$
\le \beta_1^{-n\theta_1} + L\beta_2^{-n}
$$

$$
\le (L+1)\beta_1^{-n\theta_1},
$$

where the last inequality holds since $\beta_2 \geq \beta_1^{\theta_1}$. Similarly, we have

$$
|T_{\beta_2}^n y - g_2(a_{n,w}^1, y)| < \beta_2^{-n\theta_2} + L\beta_1^{-n} \le (L+1)\beta_2^{-n\theta_2},
$$

where in the second inequality we have used the assumption that $\beta_1 \geq \beta_2^{\theta_2}$. Let

$$
J_{n,1}(w,v) = \left\{ x \in I_{n,\beta_1}(w) : |T_{\beta_1}^n x - g_1(x, a_{n,v}^2)| < (L+1)\beta_1^{-n\theta_1} \right\},
$$

$$
J_{n,2}(w,v) = \left\{ y \in I_{n,\beta_2}(v) : |T_{\beta_2}^n y - g_2(a_{n,w}^1, y)| < (L+1)\beta_2^{-n\theta_2} \right\}.
$$

Then from the above we see that

$$
G = \bigcap_{N=1}^{\infty} \bigcup_{n=N}^{\infty} \bigcup_{w \in \Sigma_{\beta_1}^n, v \in \Sigma_{\beta_2}^n} \left\{ (x, y) \in I_{n, \beta_1}(w) \times I_{n, \beta_2}(v) : \frac{|T_{\beta_1}^n x - g_1(x, y)| < \beta_1^{-n\tau_1(x)}}{|T_{\beta_2}^n y - g_2(x, y)| < \beta_2^{-n\tau_2(y)} \right\}
$$
\n
$$
\subset \bigcap_{n=1}^{\infty} \bigcup_{w \in \Sigma_{\beta_1}^n} \bigcup_{w \in \Sigma_{\beta_2}^n} J_{n,1}(w, v) \times J_{n,2}(w, v).
$$
\n
$$
(4.17)
$$

$$
N=1\ n=N\ w\!\in\!\!\Sigma_{\beta_1}^n, v\!\!\in\!\!\Sigma_{\beta_2}^n
$$

Moreover, by the same argument as in (4.4) , we see that for all large n,

$$
|J_{n,1}(w,v)| \le 4(L+1)\beta_1^{-n(1+\theta_1)}, \quad |J_{n,2}(w,v)| \le 4(L+1)\beta_2^{-n(1+\theta_2)}.
$$

This is completely analogous to [\(4.5\)](#page-9-7) and [\(4.6\)](#page-9-8). Then the upper bounds part of Theorem [1.3](#page-3-2) follows from the same proof of that of Theorem [1.2.](#page-2-0)

The lower bounds part. Fix full words $w \in \sum_{\beta_1}^n$ and $v \in \sum_{\beta_2}^n$. Applying Lemma [2.4\(](#page-4-2)ii) to the function $x \mapsto g_1(x, a_{n,v}^2)$ (which is Lipschitz since $g_1 : [0, 1]^2 \to [0, 1]$ is Lipschitz), there exists a point $x_{n,w,v} \in I_{n,\beta_1}(w)$ such that

$$
|T_{\beta_1}^n x_{n,w,v} - g_1(x_{n,w,v}, a_{n,v}^2)| < \beta_2^{-n}.
$$

Thus for any $(x, y) \in I_{n, \beta_1}(w) \times I_{n, \beta_2}(v)$, we have by (4.16) that

$$
|T_{\beta_1}^n x - g_1(x, y)| - \beta_2^{-n} \le |T_{\beta_1}^n x - g_1(x, y)| - |T_{\beta_1}^n x_{n, w, v} - g_1(x_{n, w, v}, a_{n, v}^2)|
$$

\n
$$
\le |T_{\beta_1}^n x - T_{\beta_1}^n x_{n, w, v}| + |g_1(x, y) - g_1(x_{n, w, v}, a_{n, v}^2)|
$$

\n
$$
\le \beta_1^n |x - x_{n, w, v}| + L(|x - x_{n, w, v}| + |y - a_{n, v}^2|)
$$

\n
$$
\le (\beta_1^n + L)|x - x_{n, w, v}| + L\beta_2^{-n}.
$$

Since $\beta_2 > \beta_1^{\kappa_1}$ (recall that $\kappa_i = \max_{x \in [0,1]} \tau_i(x)$ for $i = 1, 2$), we see that if $|x |x_{n,w,v}| < \frac{1}{4}$ $\frac{1}{4}\beta_1^{-n(1+\tau_1(x))}$ $\binom{n-1+\tau_1(x)}{1}$, then there exists $n_0 \in \mathbb{N}$ (independent of (x, y)) such that for all $n \geq n_0$,

$$
|T_{\beta_1}^n x - g_1(x, y)| < 2\beta_1^n \cdot \frac{1}{4}\beta_1^{-n(1+\tau_1(x))} + (L+1)\beta_2^{-n} \le \beta_1^{-n\tau_1(x)}.
$$

Similarly, there is a point $y_{n,w,v} \in I_{n,\beta_2}(v)$ such that

$$
|T_{\beta_2}^n y_{n,w,v} - g_2(a_{n,w}^1, y_{n,w,v})| < \beta_1^{-n}.
$$

Thus by a similar argument as above, we have

$$
|T_{\beta_2}^n y - g_2(x, y)| - \beta_1^{-n} \le (\beta_2^n + L)|y - y_{n, w, v}| + L\beta_1^{-n}.
$$

Hence if $|y - y_{n,w,v}| < \frac{1}{4}$ $\frac{1}{4}\beta_2^{-n(1+\tau_2(y))}$ $\frac{1-n(1+72(y))}{2}$, then for large *n*,

$$
|T_{\beta_2}^n y - g_2(x, y)| < 2\beta_2^n \cdot \frac{1}{4}\beta_2^{-n(1+\tau_2(y))} + (L+1)\beta_1^{-n} \le \beta_2^{-n\tau_2(y)},
$$

where the second inequality holds for large *n* since $\beta_1 > \beta_2^{\kappa_2}$.

Let

$$
\tilde{J}_{n,1}(w,v) = \left\{ x \in I_{n,\beta_1}(w) : |x - x_{n,w,v}| < \frac{1}{4} \beta_1^{-n(1+\tau_1(x))} \right\},
$$

$$
\tilde{J}_{n,2}(w,v) = \left\{ y \in I_{n,\beta_2}(v) : |y - y_{n,w,v}| < \frac{1}{4} \beta_2^{-n(1+\tau_2(y))} \right\}.
$$

Then from the above (and recall (4.17)), we see that

$$
G \supset \bigcap_{N=1}^{\infty} \bigcup_{n=N}^{\infty} \bigcup_{w \in \Sigma_{\beta_1}^n, v \in \Sigma_{\beta_2}^n} \tilde{J}_{n,1}(w, v) \times \tilde{J}_{n,2}(w, v).
$$

This is in complete analogy to [\(4.9\)](#page-12-2). Then a proof similar to the second part of Subsection [4.1](#page-9-6) yields the lower bounds in Theorem [1.3.](#page-3-2)
