Two iterative formulas of largest and smallest singular value of nonsingular matrices

Abstract

We obtain an iterative formula that converges incrementally to the smallest singular value. Similarly, we obtain an iterative formula that converges decreasingly to the largest singular value.

Keywords: Singular values, Frobenius norm, Determinant.

1 Lower bound for the smallest singular value

Let $M_n(\mathbb{C})(n \geq 2)$ be the space of $n \times n$ complex matrices. Let σ_i $(i = 1, \dots, n)$ be the singular values of $A \in M_n(\mathbb{C})$ which is nonsingular and suppose that $\sigma_1 \geq \sigma_2 \geq \dots \geq \sigma_{n-1} \geq \sigma_n > 0$. For $A = [a_{ij}] \in M_n(\mathbb{C})$, the Frobenius norm of A is defined by

$$||A||_F = \left(\sum_{i,j=1}^n |a_{ij}|^2\right)^{1/2} = \operatorname{tr}\left(A^H A\right)^{\frac{1}{2}}$$

where A^H is the conjugate transpose of A. The relationship between the Frobenius norm and singular values is

$$||A||_F^2 = \sigma_1^2 + \sigma_2^2 + \dots + \sigma_n^2$$

It is well known that lower bounds for the smallest singular value σ_n of a nonsingular matrix $A \in M_n(\mathbb{C})$ have many potential theoretical and practical applications [1, 2]. Yu and Gu [5] obtained a lower bound for σ_n as follows:

$$\sigma_n \geqslant |\det A| \left(\frac{n-1}{\|A\|_F^2}\right)^{(n-1)/2} = l > 0$$

The above inequality is also shown in [4]. In [6], Zou improved the above inequality by showing that

$$\sigma_n \geqslant |\det A| \left(\frac{n-1}{\|A\|_F^2 - l^2}\right)^{(n-1)/2} = l_0$$

In [3], Lin and Xie improve a lower bound for smallest singular value of matrices by showing that a is the smallest positive solution to the equation

$$x^{2} (\|A\|_{F}^{2} - x^{2})^{n-1} = |\det A|^{2} (n-1)^{n-1}.$$

and $\sigma_n \geqslant a > l_0$. Under certain conditions, $\sigma_n = a$ will hold. However, in many cases, $\sigma_n = a$ is not true. We give necessary and sufficient conditions such that $\sigma_n = a$ in Proposition 1.

2 Main results

Let

$$l = |\det A| \left(\frac{n-1}{\|A\|_F^2}\right)^{(n-1)/2},$$

$$l_0 = |\det A| \left(\frac{n-1}{\|A\|_F^2 - l^2}\right)^{(n-1)/2}.$$

And a is the smallest positive solution to the equation

$$x^{2} (\|A\|_{F}^{2} - x^{2})^{n-1} = |\det A|^{2} (n-1)^{n-1}.$$

From [3], we have $\sigma_n \ge a > l_0 > l > 0$. Next, we give necessary and sufficient conditions such that $a = \sigma_n$.

Proposition 1. Let a be the smallest positive solution to the equation

$$x^{2} (\|A\|_{F}^{2} - x^{2})^{n-1} = |\det A|^{2} (n-1)^{n-1}.$$

then $a = \sigma_n$ if and only if

$$\sigma_1 = \sigma_2 = \cdots = \sigma_{n-1}$$

Proof. \Rightarrow : If $a = \sigma_n$, then

$$\sigma_n^2 (\|A\|_F^2 - \sigma_n^2)^{n-1} = |\det A|^2 (n-1)^{n-1}.$$

Since $||A||_F^2 = \sigma_1^2 + \sigma_2^2 + \cdots + \sigma_n^2$ and $|\det A|^2 = \sigma_1^2 \sigma_2^2 \cdots \sigma_n^2$, we have

$$\sigma_n^2 \left(\sigma_1^2 + \sigma_2^2 + \dots + \sigma_{n-1}^2\right)^{n-1} = \sigma_1^2 \sigma_2^2 \cdots \sigma_n^2 (n-1)^{n-1}$$
$$\left(\frac{\sigma_1^2 + \sigma_2^2 + \dots + \sigma_{n-1}^2}{n-1}\right)^{n-1} = \sigma_1^2 \sigma_2^2 \cdots \sigma_{n-1}^2$$

By the arithmetic-geometric mean inequality, the above equation holds if and only if

$$\sigma_1^2 = \sigma_2^2 = \dots = \sigma_{n-1}^2$$

if and only if

$$\sigma_1 = \sigma_2 = \cdots = \sigma_{n-1}$$

⇐: Let

$$\sigma_1^2 = \sigma_2^2 = \dots = \sigma_{n-1}^2 = c^2 (c > 0).$$

Then a is the smallest positive solution to the equation

$$x^{2} \left(c^{2} (n-1) + \sigma_{n}^{2} - x^{2}\right)^{n-1} = c^{2(n-1)} \sigma_{n}^{2} (n-1)^{n-1}$$

if and only if a is the smallest positive zero point of

$$f(x) = x^{2} \left(1 + \frac{\sigma_{n}^{2} - x^{2}}{c^{2}(n-1)} \right)^{n-1} - \sigma_{n}^{2}.$$

Next, we proof $a = \sigma_n$. Obviously, we can see that $f(\sigma_n) = 0$ and $f(0) = -\sigma_n^2 < 0$. Next, we prove that f(x) is an strictly increasing function on $[0, \sigma_n]$. Taking the derivative of f(x), we can get

$$f'(x) = \left(1 + \frac{\sigma_n^2 - x^2}{c^2(n-1)}\right)^{n-2} \frac{2x}{c^2(n-1)} \left(c^2(n-1) + \sigma_n^2 - nx^2\right).$$

 $\forall x_0 \in (0, \sigma_n)$, we have

$$c^{2}(n-1) + \sigma_{n}^{2} - nx_{0}^{2} \ge n\sigma_{n}^{2} - nx_{0}^{2} > 0.$$

We have $f'(x_0) > 0$. Therefore f(x) is an strictly increasing function on $[0, \sigma_n]$ and σ_n is the smallest positive zero point of

$$f(x) = x^{2} \left(1 + \frac{\sigma_{n}^{2} - x^{2}}{c^{2}(n-1)} \right)^{n-1} - \sigma_{n}^{2}$$

Therefore, σ_n is the smallest positive solution to the equation

$$x^{2} \left(c^{2}(n-1) + \sigma_{n}^{2} - x^{2}\right)^{n-1} = c^{2(n-1)} \sigma_{n}^{2}(n-1)^{n-1}.$$

We get $a = \sigma_n$.

In the above special condition, a can be equal to σ_n , which is not general. Next, we give our main theorem. We give an iterative formula for the smallest singular value, which converges incrementally to the smallest singular value.

Theorem 1. Let $A \in M_n(\mathbb{C})$ be nonsingular and $0 < a_1 \leqslant \sigma_n$ and

$$a_{k+1} = \left(a_k^2 + \left| \det \left(a_k^2 I_n - A^H A \right) \right| \left(\frac{n-1}{\|A\|_F^2 - (n-1)a_k^2} \right)^{n-1} \right)^{1/2}, k = 1, 2, \cdots$$

Then $\sigma_n \geqslant a_{k+1} \geqslant a_k > 0 (k = 1, 2, \cdots)$ and $\lim_{k \to +\infty} a_k = \sigma_n$.

Proof. Let $0 \leq \lambda < \sigma_n^2$, by the arithmetic-geometric mean inequality, we have

$$(\sigma_1^2 - \lambda) (\sigma_2^2 - \lambda) \cdots (\sigma_{n-1}^2 - \lambda) \leqslant \left(\frac{\sigma_1^2 + \cdots + \sigma_{n-1}^2 - (n-1)\lambda}{n-1}\right)^{n-1}$$

Since

$$(\sigma_1^2 - \lambda) (\sigma_2^2 - \lambda) \cdots (\sigma_{n-1}^2 - \lambda) = \frac{(\sigma_1^2 - \lambda) (\sigma_2^2 - \lambda) \cdots (\sigma_n^2 - \lambda)}{\sigma_n^2 - \lambda}$$
$$= \frac{\left| \det (\lambda I_n - A^H A) \right|}{\sigma_n^2 - \lambda}$$

we have

$$\frac{\left|\det\left(\lambda I_{n} - A^{H} A\right)\right|}{\sigma_{n}^{2} - \lambda} \leqslant \left(\frac{\sigma_{1}^{2} + \dots + \sigma_{n-1}^{2} - (n-1)\lambda}{n-1}\right)^{n-1}$$

$$\sigma_{n}^{2} \geqslant \lambda + \left|\det\left(\lambda I_{n} - A^{H} A\right)\right| \left(\frac{n-1}{\sigma_{1}^{2} + \dots + \sigma_{n-1}^{2} - (n-1)\lambda}\right)^{n-1}$$

$$\sigma_{n} \geqslant \left(\lambda + \left|\det\left(\lambda I_{n} - A^{H} A\right)\right| \left(\frac{n-1}{\sigma_{1}^{2} + \dots + \sigma_{n-1}^{2} + \sigma_{n}^{2} - (n-1)\lambda}\right)^{n-1}\right)^{1/2}$$

$$\sigma_{n} \geqslant \left(\lambda + \left|\det\left(\lambda I_{n} - A^{H} A\right)\right| \left(\frac{n-1}{\|A\|_{F}^{2} - (n-1)\lambda}\right)^{n-1}\right)^{1/2}$$

Let $\lambda \to \sigma_n^{2-}$ (λ tends to σ_n^2 from the left). We get that the above inequality is also true for $\lambda = \sigma_n^2$. Therefore, for $0 \le \lambda \le \sigma_n^2$, we have

$$\sigma_n \geqslant \left(\lambda + \left| \det \left(\lambda I_n - A^H A \right) \right| \left(\frac{n-1}{\|A\|_F^2 - (n-1)\lambda} \right)^{n-1} \right)^{1/2} \tag{1}$$

We show by induction on k that

$$\sigma_n \geqslant a_{k+1} \geqslant a_k > 0$$

We have $\sigma_n \geqslant a_1 > 0$. In equation 1, let $\lambda = a_1^2$, we have

$$\sigma_n \geqslant a_2 = \left(a_1^2 + \left| \det \left(a_1^2 I_n - A^H A \right) \right| \left(\frac{n-1}{\|A\|_F^2 - (n-1)a_1^2} \right)^{n-1} \right)^{1/2} \geqslant a_1 > 0$$

Assume that our claim is true for k=m, that is $\sigma_n \geqslant a_{m+1} \geqslant a_m > 0$. Now we consider the case when k=m+1. In equation 1, let $\lambda = a_{m+1}^2$, we have

$$\sigma_n \geqslant a_{m+2} = \left(a_{m+1}^2 + \left| \det \left(a_{m+1}^2 I_n - A^H A \right) \right| \left(\frac{n-1}{\|A\|_F^2 - (n-1)a_{m+1}^2} \right)^{n-1} \right)^{1/2} \geqslant a_{m+1} > 0$$

Hence $\sigma_n \geqslant a_{m+2} \geqslant a_{m+1} > 0$. This proves $\sigma_n \geqslant a_{k+1} \geqslant a_k > 0 (k = 1, 2, \cdots)$. By the well known monotone convergence theorem, $\lim_{k \to \infty} a_k$ exists. Let $\lim_{k \to \infty} a_k = \sigma$, then

$$\sigma = \left(\sigma^2 + \left| \det \left(\sigma^2 I_n - A^H A\right) \right| \left(\frac{n-1}{\|A\|_F^2 - (n-1)\sigma^2}\right)^{n-1}\right)^{1/2}, k = 1, 2, \cdots$$

We have

$$\left| \det \left(\sigma^2 I_n - A^H A \right) \right| \left(\frac{n-1}{\|A\|_F^2 - (n-1)\sigma^2} \right)^{n-1} = 0$$

Since

$$\frac{n-1}{\|A\|_F^2 - (n-1)\sigma^2} \neq 0$$

we have

$$\det\left(\sigma^2 I_n - A^H A\right) = 0.$$

We get that σ^2 is the eigenvalue of A^HA . Since σ_n^2 is the smallest eigenvalue of A^HA , we have $\sigma^2 \geqslant \sigma_n^2$. According to the definition of σ , we have $\sigma \leqslant \sigma_n$. Therefore, $\sigma^2 \leqslant \sigma_n^2$ and we get $\sigma = \sigma_n$. Hence $\lim_{k \to +\infty} a_k = \sigma_n$.

From Theorem 1, we can see that as long as there is a lower bound of σ_n (we set it to b) and let $a_1 = b$ in Theorem 1, we can get a better lower bound than b. For example, we bring the lower bound of Lin and Xie [3] into our Theorem 1 to obtain the following results.

Corollary 1. Let a be the smallest positive solution to the equation

$$x^{2} (\|A\|_{F}^{2} - x^{2})^{n-1} = |\det A|^{2} (n-1)^{n-1}.$$

Let $a_1 = a$ and

$$a_{k+1} = \left(a_k^2 + \left|\det\left(a_k^2 I_n - A^H A\right)\right| \left(\frac{n-1}{\|A\|_F^2 - (n-1)a_k^2}\right)^{n-1}\right)^{1/2}, k = 1, 2, \cdots$$

Then $\sigma_n \geqslant a_{k+1} \geqslant a_k \geqslant a > 0 (k = 1, 2, \cdots)$ and $\lim_{k \to +\infty} a_k = \sigma_n$.

Proof. From [3], we have $\sigma_n \geqslant a > 0$. We know Corollary 1 is a special case of Theorem 1.

We give the iterative formula for the smallest singular value:

$$a_{k+1} = \left(a_k^2 + |\det(a_k^2 I_n - A^H A)| \left(\frac{n-1}{\|A\|_F^2 - (n-1)a_k^2}\right)^{n-1}\right)^{1/2}, k = 1, 2, \cdots,$$

where $a_1 = a$, which converges incrementally to the smallest singular value. Similarly, we can give an iterative formula that converges decreasingly to the largest singular value.

Theorem 2. Let $A \in M_n(\mathbb{C})$ be nonsingular, $a_1 \geqslant \sigma_1$. Assume

$$a_{k+1} = \left(a_k^2 - |\det(a_k^2 I_n - A^H A)| \left(\frac{n-1}{(n+1)a_k^2 - ||A||_F^2}\right)^{n-1}\right)^{1/2}, k = 1, 2, \cdots.$$

Then $\sigma_1 \leqslant a_{k+1} \leqslant a_k (k=1,2,\cdots)$ and $\lim_{k\to+\infty} a_k = \sigma_1$.

Proof. Set $\lambda > \sigma_1^2$, according to the arithmetic geometric mean inequality, we can get

$$(\lambda - \sigma_2^2) (\lambda - \sigma_3^2) \cdots (\lambda - \sigma_n^2) \leqslant \left(\frac{(n-1)\lambda - (\sigma_2^2 + \cdots + \sigma_n^2)}{n-1}\right)^{n-1}$$
.

Since

$$(\lambda - \sigma_2^2) (\lambda - \sigma_3^2) \cdots (\lambda - \sigma_n^2) = \frac{(\lambda - \sigma_1^2) (\lambda - \sigma_2^2) \cdots (\lambda - \sigma_n^2)}{\lambda - \sigma_1^2},$$
$$= \frac{|\det(\lambda I_n - A^H A)|}{\lambda - \sigma_1^2},$$

we can get

$$\frac{|\det(\lambda I_n - A^H A)|}{\lambda - \sigma_1^2} \leqslant \left(\frac{(n-1)\lambda - (\sigma_2^2 + \dots + \sigma_n^2)}{n-1}\right)^{n-1}
\sigma_1^2 \leqslant \lambda - |\det(\lambda - A^H A)| \left(\frac{n-1}{(n-1)\lambda + \sigma_1^2 - \|A\|_F^2}\right)^{n-1}
\leqslant \lambda - |\det(\lambda - A^H A)| \left(\frac{n-1}{(n+1)\lambda - \|A\|_F^2}\right)^{n-1}
\sigma_1 \leqslant \left(\lambda - |\det(\lambda - A^H A)| \left(\frac{n-1}{(n+1)\lambda - \|A\|_F^2}\right)^{n-1}\right)^{1/2}$$

Let $\lambda \to {\sigma_1^2}^+(\lambda \text{ tend to } {\sigma_1^2} \text{ from the right})$. We get that the above equation is also true for $\lambda = {\sigma_1^2}$. So, for $\lambda \geqslant {\sigma_1^2}$, we have

$$\sigma_1 \leqslant \left(\lambda - \left|\det\left(\lambda - A^H A\right)\right| \left(\frac{n-1}{(n+1)\lambda - \|A\|_F^2}\right)^{n-1}\right)^{1/2} \tag{2}$$

We use induction on k to prove that:

$$\sigma_1 \leqslant a_{k+1} \leqslant a_k$$

For k = 1, $\sigma_1 \leqslant a_1$ can be obtained from the condition. In the equation (2), taking $\lambda = a_1^2$, we can get

$$\sigma_1 \leqslant a_2 = \left(a_1^2 - \left|\det\left(a_1^2 - A^H A\right)\right| \left(\frac{n-1}{(n+1)a_1^2 - \|A\|_F^2}\right)^{n-1}\right)^{1/2} \leqslant a_1$$

Suppose our conclusion holds for k = m, that is, $\sigma_1 \leq a_{m+1} \leq a_m$. Now let's consider the case of k = m + 1. In equation (2), let $\lambda = a_{m+1}^2$, we can get

$$\sigma_1 \leqslant a_{m+2} = \left(a_{m+1}^2 - \left| \det \left(a_{m+1}^2 - A^H A \right) \right| \left(\frac{n-1}{(n+1)a_{m+1}^2 - \|A\|_F^2} \right)^{n-1} \right)^{1/2} \leqslant a_{m+1}$$

So $\sigma_1 \leqslant a_{k+1} \leqslant a_k$. This proves that $\sigma_1 \leqslant a_{k+1} \leqslant a_k (k=1,2,\cdots)$. From the monotone convergence theorem, $\lim_{k\to\infty} a_k$ exists. Let $\lim_{k\to\infty} a_k = \sigma$, then

$$\sigma = \left(\sigma^2 - |\det(\sigma^2 I_n - A^H A)| \left(\frac{n-1}{(n+1)\sigma^2 - ||A||_F^2}\right)^{n-1}\right)^{1/2}$$

We have

$$|\det(\sigma^2 I_n - A^H A)| \left(\frac{n-1}{(n+1)\sigma^2 - ||A||_F^2}\right)^{n-1} = 0.$$

because

$$\frac{n-1}{(n+1)\sigma^2 - ||A||_F^2} \neq 0,$$

we can get

$$\det(\sigma^2 I_n - A^H A) = 0.$$

So σ^2 is the eigenvalue of A^HA . Because σ_1^2 is the largest eigenvalue of A^HA , there is $\sigma^2 \leqslant \sigma_1^2$. According to the definition of σ , we have $\sigma \geqslant \sigma_1$, so $\sigma^2 \geqslant \sigma_1^2$. We get $\sigma = \sigma_1$, so $\lim_{k \to +\infty} a_k = \sigma_1$.

The largest singular value has an obvious upper bound. Because $\sigma_1^2 \leq \sigma_1^2 + \cdots + \sigma_n^2 = ||A||_F^2$, so $\sigma_1 < ||A||_F$. We give an iterative formula for the largest singular value:

$$a_{k+1} = \left(a_k^2 - |\det(a_k^2 I_n - A^H A)| \left(\frac{n-1}{(n+1)a_k^2 - ||A||_F^2}\right)^{n-1}\right)^{1/2}, k = 1, 2, \cdots,$$

where $a_1 = ||A||_F$, which converges decreasingly to σ_1 .
