ON DECAY OF THE SOLUTIONS FOR THE DISPERSION GENERALIZED-BENJAMIN-ONO AND BENJAMIN-ONO EQUATIONS

ABSTRACT. We show that uniqueness results of the kind those obtained for KdV and Schrödinger equations ([\[7\]](#page-29-0), [\[28\]](#page-30-0)), are not valid for the dispersion generalized-Benjamin-Ono equation in the weighted Sobolev spaces

$$
H^s(\mathbb{R}) \cap L^2(x^{2r}dx),
$$

for appropriated s and r.

In particular, we obtain that the uniqueness result proved for the dispersion generalized-Benjamin-Ono equation ([\[13\]](#page-29-1)), is not true for all pairs of solutions $u_1 \neq 0$ and $u_2 \neq 0$. To achieve these results we employ the techniques present in our recent work [\[6\]](#page-29-2). We also improve some Theorems established for the dispersion generalized-Benjamin-Ono equation and for the Benjamin-Ono equation ([\[13\]](#page-29-1), [\[12\]](#page-29-3)).

1. Introduction

This paper is concerned with the initial-value problem (IVP) associated with the dispersion generalized-Benjamin-Ono (DGBO) equation,

$$
\begin{cases} u_t + D_x^{a+1} \partial_x u + u u_x = 0, & x, t \in \mathbb{R}, \quad a \in (0,1), \\ u(x,0) = \phi(x), \end{cases}
$$
 (1.1)

where D_x^{a+1} stands for the fractional derivative of order $a+1$ with respect to the variable x and is defined, via your Fourier transform, as $D_x^{a+1} f(x) = (|\xi|^{a+1} \hat{f})^{\vee}(x)$.

For $a = 1$, the IVP [\(1.1\)](#page-0-0) becomes the well-known IVP for the KdV equation, for which the local and global well-posedness (LWP and GWP, respectively) in Sobolev spaces already widely studied, see [\[19,](#page-29-4) [20,](#page-29-5) [2\]](#page-29-6), and references therein. About persistence in weighted Sobolev spaces, in [\[18\]](#page-29-7) it was proved that the Schwartz space is preserved by the flow of the KdV equation.

When $a = 0$ we obtain the IVP for the Benjamin-Ono equation (BO)

$$
\begin{cases} u_t + \mathcal{H}\partial_x^2 u + uu_x = 0, & x, t \in \mathbb{R}, \\ u(x,0) = \phi(x), \end{cases}
$$
 (1.2)

where H stands for the Hilbert transform.

With respect to the well-posedness in the Sobolev spaces, the IVP [\(1.2\)](#page-0-1) has been largely studied recently, see for example [\[1,](#page-29-8) [24,](#page-30-1) [23,](#page-29-9) [31,](#page-30-2) [25,](#page-30-3) [3,](#page-29-10) [29,](#page-30-4) [16\]](#page-29-11). Through the work of Iorio [\[17\]](#page-29-12), the flow of the BO equation, in general polynomial decay is not preserved in weighted Sobolev spaces. The extension for fractional weights can be found in the paper of Ponce and Fonseca [\[11\]](#page-29-13).

Lately, the idea of improving theorems in weighted Sobolev spaces for the Benjamin-Ono equation, by assuming a higher spacial decay on the initial data, can be found in [\[9\]](#page-29-14).

Recently Kenig, Ponce and Vega ([\[21\]](#page-29-15)) obtained uniqueness results of solutions of the IVP [\(1.2\)](#page-0-1). Roughly, they proved that for solutions u_1 and u_2 in a suitable class of functions, defined in $\mathbb{R} \times [0, T]$, which agree in an open set $\Omega \subset \mathbb{R} \times [0, T]$, we have $u_1 \equiv u_2$.

We recall that the solutions of the IVP (1.2) satisfy the following conservation laws (see [\[11\]](#page-29-13))

I_2(u) = \int_{\mathbb{R}} u^2(x, t) dx \tag{1.4}

and

$$
I_3(u) = \int_{\mathbb{R}} \left(|D^{1/2}u|^2 - \frac{u^3}{3} \right) (x, t) dx, \tag{1.5}
$$

where $D = \mathcal{H} \partial_x$.

The IVP [\(1.1\)](#page-0-0) has been extensively studied in the last years. In particular, for the local wellposedness in Sobolev spaces $H^s(\mathbb{R})$, see [\[14,](#page-29-16) [27,](#page-30-5) [15\]](#page-29-17) and references therein. In [\[26\]](#page-30-6) the authors proved that, as in the case of BO equation, the IVP associated to the DGBO equation the application data-solution from $H^s(\mathbb{R})$ to $C([0,T]; H^s(\mathbb{R}))$ fails to be locally C^2 at the origin for all $T > 0$ and all $s \in \mathbb{R}$. Hence, the IVP [\(1.1\)](#page-0-0) cannot be solved by an argument based only on the contraction principle.

For the DGBO equation, lately Kenig, Pilot, Ponce and Vega (see [\[22\]](#page-29-18)) proved uniqueness results, similarly to obtained by the authors in [\[21\]](#page-29-15).

Real solutions sufficiently smooth of the IVP (1.1) satisfies (see [\[13\]](#page-29-1))

\frac{d}{dt}\int u^2(x,t)dx = 0.
$$
\n(1.6)

Let us start by recalling the following well-posedness results about the IVP (1.1) . See the notation of function spaces in the Section [2.](#page-5-0)

Theorem A. Let $a \in (0,1)$.

- (a) If $\phi \in Z_{s,r}$ then the solution of [\(1.1\)](#page-0-0) satisfies $u \in C([-T,T]: Z_{s,r})$ if either
	- (i) $s \ge 1 + a$ and $r \in (0, 1]$, or
	- (ii) $s \ge 2(1+a)$ and $r \in (1,2]$, or
	- (iii) $s \geq [(r+1)^{-}](1+a)$ and $2 < r < 5/2+a$, with $\llbracket \cdot \rrbracket$ denoting the integer part function.
- (b) If $\phi \in \dot{Z}_{s,r}$ then the solution of [\(1.1\)](#page-0-0) satisfies $u \in C([-T,T]: \dot{Z}_{s,r})$ provided (iv) $s \geq [(r+1)^{-}](1+a)$ and $5/2 + a < r < 7/2 + a$.

The result in Theorem A is sharp in the sense that one cannot have solutions with additional decay in the spatial variable. More precisely,

Theorem B. Let $a \in (0,1)$ and assume $u \in C([-T,T]: Z_{s,(7/2+a)^{-}})$, with

$$
T > 0
$$
 and $s \ge (1+a)(7/2 + a) + \frac{1-a}{2}$,

is a solution of [\(1.1\)](#page-0-0). If there exist three different times $t_1, t_2, t_3 \in [-T, T]$ such that

$$
u(\cdot, t_j) \in \dot{Z}_{s,7/2+a}, \quad j = 1,2,3,
$$

then $u \equiv 0$.

Next theorem shows that the condition in Theorem B at two times is not sufficient to guarantee that $u \equiv 0$.

Theorem C. Let $a \in (0,1)$ and assume $u \in C([-T,T]: Z_{s,(7/2+a)^{-}})$, with

T > 0
$$
 and $s \ge (1 + a)(7/2 + [1 + 2a]/2) + \frac{1 - a}{2}$,

is a solution of [\(1.1\)](#page-0-0) such that

$$
\phi \in \dot{Z}_{s,7/2+\tilde{a}}, \quad \tilde{a} = [\![1+2a]\!]/2, \quad and \quad \int_{\mathbb{R}} x \phi(x) dx \neq 0.
$$

Then there exists $t^* \neq 0$ with

$$
t^* = \frac{-4}{\|\phi\|^2} \int_{-\infty}^{\infty} x\phi(x)dx
$$

such that $u(t^*) \in \dot{Z}_{7/2 + \tilde{a}}$.

and for any $T > 0$

The following theorem is about the IVP [\(1.2\)](#page-0-1). Such result shows that the uniqueness result obtained in [\[11,](#page-29-13) Theorem 3] cannot extend for all pairs $u_1 \neq 0$ and $u_2 \neq 0$ of solutions of the BO equation.

Theorem D. There exist $u_1, u_2 \in C(\mathbb{R}; Z_{4,2})$ solutions of the IVP [\(1.2\)](#page-0-1) such that

$$
u_1 - u_2 \in L^{\infty}([-T, T]; Z_{4,4}).
$$

 $u_1 \neq u_2$

The proof of Theorems A–C can be found in the work of Fonseca, Linares, and Ponce [\[13\]](#page-29-1). The proof of Theorem D is due to the same authors and can be seen in [\[12\]](#page-29-3).

The result in Theorem B may be seen as a uniqueness result. Here, we are mainly concerned with the question of when this uniqueness result can be extended to any pair of solutions u_1 and u_2 of [\(1.1\)](#page-0-0) with $u_1 \neq 0$ and $u_2 \neq 0$. More precisely, we are interested in the following question: assume

$$
u_1(\cdot, t_1) - u_2(\cdot, t_1), \ u_1(\cdot, t_2) - u_2(\cdot, t_2), \ u_1(\cdot, t_3) - u_2(\cdot, t_3) \in X,\tag{1.7}
$$

for three different times t_1, t_2, t_3 and some function space X; is it true that $u_1 \equiv u_2$? In our case we will take $X = Z_{s,r}$ for suitable s and r. For the KdV equation, this question (for two different times) was addressed in the paper of Escauriaza, Kenig, Ponce and Vega [\[7\]](#page-29-0). Indeed, the authors showed if u_1 and u_2 are two solutions of the KdV equation in $C([0, 1]; Z_{3,1})$ with

$$
u_1(\cdot,0) - u_2(\cdot,0), u_1(\cdot,1) - u_2(\cdot,1) \in H^1(e^{ax_+^{3/2}}dx)
$$

for some $a > 0$ then $u_1 \equiv u_2$. Here $x_+ = \max\{0, x\}$. For similar questions for the Schrödinger equation, see the work [\[8\]](#page-29-19), of the same authors above. For the BO equation, we recall that from the work of Fonseca and Ponce [\[11,](#page-29-13) Theorem 3] a similar uniqueness result as in Theorem B with $a = 0$ also holds. On the other hand, the Theorem D above shows that the result established in [\[11,](#page-29-13) Theorem 3] can not extend for two non-zero solutions. Hence, the question [\(1.7\)](#page-2-0) for the BO equation has a negative answer.

Now, consider the question [\(1.7\)](#page-2-0), for two different times. We recall that a similar result as in Theorem C with $a = 0$ can be found in [\[12,](#page-29-3) Theorem 2]. Hence, by this result and the Theorem C, follows that the Theorems B and [\[11,](#page-29-13) Theorem 3] are not valid for two different times. This shows us that the question [\(1.7\)](#page-2-0), for two different times, for the DGBO and BO equations has a negative answer.

Next we present our results. We start with results about the dispersion generalized Benjamin-Ono. The first one tells us that similar uniqueness properties of solutions as in the KdV and Schrödinger equations (see [\[7\]](#page-29-0) and [\[8\]](#page-29-19), resp.) are not true for the IVP (1.1) . By the other hand, this also shows that the uniqueness properties obtained in Theorem B can not be extended to all pair of non-zero solutions. To achieve such results we use some ideas developed in [\[6\]](#page-29-2)(see also [\[4\]](#page-29-20)).

Theorem 1.1. Assume $a \in (0,1)$ and let u_1 and u_2 be solutions of [\(1.1\)](#page-0-0) satisfying

$$
u_1(0) = \phi, u_2(0) = \varphi, \phi \neq \varphi,
$$
\n
$$
(1.8)
$$

$$
\|\phi\| = \|\varphi\|,\tag{1.9}
$$

$$
\int \phi(x)dx = \int \varphi(x)dx,\tag{1.10}
$$

$$
\int x\phi(x)dx = \int x\varphi(x)dx,
$$
\n(1.11)

and

$$
\phi, \varphi \in Z_{s,4},\tag{1.12}
$$

where $s \geq 4(1+a) + 1$.

Then $u_1 \neq u_2$ and for some $T > 0$

$$
u_1 - u_2 \in C([-T, T]; Z_{s,4}). \tag{1.13}
$$

The idea to prove Theorem [1.1](#page-2-1) is the following. Let u_1 and u_2 be solutions of the IVP [\(1.1\)](#page-0-0) with initial data ϕ and φ , respectively. Then $w := u_1 - u_2$ satisfies the following variable coefficients linear IVP

$$
\begin{cases} w_t + D_x^{a+1} \partial_x w + u_1 \partial_x w + w \partial_x u_2 = 0, & x \in \mathbb{R}, \ t > 0, \quad a \in (0, 1), \\ w(x, 0) = \phi(x) - \varphi(x). \end{cases}
$$
(1.14)

By setting $\sigma = \phi - \varphi$ and $z = \frac{1}{2}\partial_x(u_1^2 - u_2^2) = u_1 \partial_x w + w \partial_x u_2$, the integral equation associated with (1.14) is given by

$$
w(t) = U(t)\sigma - \int_0^t U(t-\tau)z(\tau)d\tau.
$$
\n(1.15)

Thus, using the Fourier transform, we manage to show that the right-hand side of [\(1.15\)](#page-3-1) belongs to $C([-T,T];Z_{s,4}).$

In the following, we improve the last theorem, by assuming additional decay on the initial data.

Theorem 1.2. Let $\theta \in [0,1)$ and $(r, a) \in \{4\} \times (0, 1/2] \cup \{5\} \times (1/2, 1)$ be the such that $r + \theta <$ $9/2 + a$. Assume u_1, u_2 solutions of the IVP [\(1.1\)](#page-0-0) with initial data ϕ and φ , respectively. Suppose that the hypothesis (1.8) – (1.11) are valid and

$$
\phi, \varphi \in Z_{s,r+\theta}, \text{ where } s \ge (r+\theta)(1+a)+1. \tag{1.16}
$$

Then $u_1 \neq u_2$ and for some $T > 0$

$$
u_1 - u_2 \in C([-T, T]; Z_{s, r + \theta}).
$$
\n(1.17)

Roughly speaking, Theorem [1.2](#page-3-3) reduces to Theorem [1.1](#page-2-1) when we set $\theta = 0$. The idea to prove Theorem [1.2](#page-3-3) is exactly the same of Theorem [1.1](#page-2-1) but now we need to handle with fractional derivatives.

The next theorem corresponds to an improvement of Theorem C, in which we assuming an additional decay on the initial data. Note that this result also allows us to conclude that Theorem B cannot be extended for two different times, even assuming a higher decay in the initial data.

Theorem 1.3. Let $\theta \in [0, 1)$ and $(r, a) \in \{4\} \times (0, 1/2] \cup \{5\} \times (1/2, 1)$ be the such that $r + \theta < 9/2 +$ a. Suppose that $u \in C([-T,T]; \mathcal{Z}_{s,(\frac{7}{2}+a)^{-}})$ is a solution of the IVP (1.1) , for $s \ge (r+\theta)(1+a)+1$. If $u(0) = \phi \in \dot{Z}_{s,r+\theta}$ and

$$
\int_{-\infty}^{\infty} x\phi(x)dx \neq 0,
$$

then

$$
u(t^*)\in Z_{s,r+\theta},
$$

where

$$
t^* = \frac{-4}{\|\phi\|^2} \int_{-\infty}^{\infty} x\phi(x)dx.
$$

The goal of the next result is to improve the Theorem A.

Theorem 1.4. Let $s > r(1+a) + 1$. Thus, the following statements are true

- 1) If $r \in (0, 5/2 + a)$, then the solution of IVP [\(1.1\)](#page-0-0) is such that $u \in C([-T, T]; Z_{s,r})$.
- 2) If $r \in [5/2 + a, 7/2 + a)$, then the solution of IVP [\(1.1\)](#page-0-0) is such that $u \in C([-T, T]; \dot{Z}_{s,r})$.
- 3) For $r(1 + a) > 1/2$ and $r \in (0, 5/2 + a)$, the IVP [\(1.1\)](#page-0-0) is LWP (GWP resp., if $a > 1/3$) in $Z_{s,r}.$
- 4) For $r(1 + a) > 1/2$ and $r \in [5/2 + a, 7/2 + a)$, the IVP [\(1.1\)](#page-0-0) is LWP (GWP resp., if $a > 1/3$) in $\dot{Z}_{s,r}$.

Now, we put in order some remarks about our results.

i) In the last Theorem we push down the index s given in Theorem A, in the sense that we will describe below. From the hypotheses of Theorem A, it is seen that

$$
[[(r+1)^-](1+a) = \begin{cases} 1+a, & \text{for } r \in (0,1] \\ 2(1+a), & \text{for } r \in (1,2]. \end{cases}
$$

Moreover, we see that

$$
r(1+a) + 1 < \llbracket (r+1)^{-} \rrbracket (1+a)
$$

is true, for $n - 1 < r < n - \frac{1}{1+a}$, where $n = 1, ..., 5$.

Hence, in such intervals of r , we obtain less regularity compared to what appears in Theorem A.

- ii) The techniques used to prove Theorem [1.4](#page-3-4) are different from those employed in [\[13\]](#page-29-1); here we use frequently the integral equation associated with the IVP [\(1.1\)](#page-0-0) together with weighted estimates for $U(t)\phi$ (see Lemma [2.8](#page-8-0) below).
- iii) Due the presence of the non linearity uu_x in integral equation associated with the IVP [\(1.1\)](#page-0-0) our Theorems [1.1–](#page-2-1)[1.4](#page-3-4) holds for $s \ge (1+a)r+1$. We believe that the regularity s can be pushed down to $s \geq (1+a)r$; however, the techniques employed do not allow us to achieve this index.

Now, we will describe our results about the Benjamin-Ono equation. The following theorem shows us that, assuming on initial data a decay of order five, it's possible to improve the Theorem D. This shows that the answer to the question [\(1.7\)](#page-2-0) is negative, even assuming more decay on initial data.

Theorem 1.5. Let u_1, u_2 solutions of the IVP [\(1.2\)](#page-0-1) with initial data ϕ and φ , respectively. Suppose that conditions $\phi \neq \varphi$ and [\(1.9\)](#page-2-3)–[\(1.11\)](#page-3-2) are satisfied. In addition, assume

$$
\int x^2 \phi(x) = \int x^2 \varphi(x) dx,
$$
\n(1.18)

$$
\int x \phi^2(x) = \int x \varphi^2(x) dx,
$$
\n(1.19)

$$
I_3(\phi) = I_3(\varphi) \tag{1.20}
$$

and

$$
\phi, \varphi \in Z_{s,5},\tag{1.21}
$$

where $s \geq 5$.

Then $u \neq v$ and for all $T > 0$

$$
u_1 - u_2 \in C([-T, T]; Z_{s,5}).
$$
\n
$$
(1.22)
$$

The following result improves the last Theorem. It also shows that, by assuming an additional decay on the initial data of order $3/2^-$, we can improve Theorem D.

Theorem 1.6. Let $\theta \in (0, 1/2)$ and u_1, u_2 solutions of the IVP [\(1.2\)](#page-0-1) with initial data ϕ and φ , respectively. Suppose that the hypothesis $\phi \neq \varphi$, [\(1.9\)](#page-2-3)–[\(1.11\)](#page-3-2) and [\(1.18\)](#page-4-0)–[\(1.20\)](#page-4-1) are valid. In addition, assume that

$$
\phi, \varphi \in Z_{s,5+\theta},\tag{1.23}
$$

where $s \geq 5 + \theta$.

Then $u \neq v$ and for all $T > 0$

$$
u_1 - u_2 \in C([-T, T]; Z_{s, 5+\theta}). \tag{1.24}
$$

The rest of this paper is organized as follows. In Section [2](#page-5-0) is give some notation and the auxiliary results. The Section [3](#page-9-0) is devoted to the proof of Theorems [1.1](#page-2-1) and [1.2;](#page-3-3) here we divide the proof of Theorem [1.2](#page-3-3) is given in two parts, first we aboard the case $r = 4$, and then the case $r = 5$. In Section [4](#page-19-0) we proof the Theorems [1.4](#page-3-4) and [1.3;](#page-3-5) here we used some similar estimates as in the proofs of Section [3,](#page-9-0) moreover the induction principle for the proof of Theorem [1.4.](#page-3-4) Finally, the Section [5](#page-25-0) is dedicated to the proof of Theorems [1.5](#page-4-2) and [1.6.](#page-4-3)

2. Notation and Preliminaries

In this section, we present some notation and auxiliary results used in our proofs. We use c to denote the various positive constants that may appear in our arguments; we use a subscript to indicate the dependence on parameters. For positive numbers a and b, we write $a \lesssim b$ if, there exists a constant c, such that $a \leq cb$. Let $\|\cdot\|_{L^2(\mathbb{R})}$ the usual $L^2(\mathbb{R})$ norm. In short, we denote the $L^2(\mathbb{R})$ norm only as $\|\cdot\|$. If $s \in \mathbb{R}$, we denote by $H^s := H^s(\mathbb{R})$ the L^2 -based Sobolev space, endowed with the norm $\|\cdot\|_{H^s}$. The Fourier transform of f is defined by

$$
\hat{f}(\xi) = \int_{\mathbb{R}} f(x)e^{-i\xi x} dx, \qquad \xi \in \mathbb{R}.
$$

For any complex number z and a real function f , the Bessel potential and Riesz potential are defined via their Fourier transforms, respectively as

$$
\widehat{J^z f}(\xi) = (1 + \xi^2)^{z/2} \widehat{f}(\xi) \quad \text{and} \quad \widehat{D^z f}(\xi) = |\xi|^z \widehat{f}(\xi).
$$

Let $r \in \mathbb{R}$. We define $L_r^2(\mathbb{R})$ as the space all functions $f = f(x)$ satisfying

$$
||f||_{L_r^2}^2 := \int_{\mathbb{R}} (1+x^{2r}) |f(x)|^2 dx < \infty.
$$

If $s, r \in \mathbb{R}$, the weighted Sobolev space is given by

$$
Z_{s,r}=H^s(\mathbb{R})\cap L^2_r(\mathbb{R}),
$$

endowed with the norm $\| \cdot \|_{Z_{s,r}}^2 = \| \cdot \|_{H^s}^2 + \| \cdot \|_{L^2_r}^2$. We also introduce the space of all zero mean value functions as

$$
\dot{Z}_{s,r} = \{ f \in Z_{s,r} : \hat{f}(0) = 0 \}.
$$

Throughout this work, δ_x will denote the Dirac delta function, centered at $x \in \mathbb{R}$.

In what follows, we describe some auxiliary results needed to obtain our main theorems.

Next, L_s^p denotes the Sobolev space defined as $L_s^p := (1 - \Delta)^{-s/2} L^p(\mathbb{R}^d)$. Such spaces can be characterized by the Stein derivative of order b as follows.

Theorem 2.1. Let $b \in (0,1)$ and $2d/(d+2b) < p < \infty$. Then $f \in L_b^p(\mathbb{R}^d)$ if and only if

a)
$$
f \in L^p(\mathbb{R}^d)
$$
,
\nb) $\mathcal{D}^b f(x) := \left(\int_{\mathbb{R}^d} \frac{|f(x) - f(y)|^2}{|x - y|^{d + 2b}} dy \right)^{1/2} \in L^p(\mathbb{R}^d)$, with
\n

||f||_{b,p} := ||J^b f||_p \simeq ||f||_p + ||D^b f||_p \simeq ||f||_p + ||\mathcal{D}^b f||_p.

Proof. See Theorem 1 in [\[30\]](#page-30-7).

The advantage in using \mathcal{D}^b is that it is suitable when dealing with pointwise estimates, as we will see below. In addition, from Fubini's theorem we have the product estimate (see [\[28,](#page-30-0) Proposition 1])

\|\mathcal{D}^b(fg)\|_{L^2(\mathbb{R}^d)} \le \|f\mathcal{D}^b g\|_{L^2(\mathbb{R}^d)} + \|g\mathcal{D}^b f\|_{L^2(\mathbb{R}^d)}.

\nWe also recall the following.

Lemma 2.2. Let $b \in (0,1)$ and h be a measurable function on R such that $h, h' \in L^{\infty}(\mathbb{R})$. Then, for all $x \in \mathbb{R}$

\mathcal{D}^b h(x) \lesssim \|h\|_{L^\infty(\mathbb{R})} + \|h'\|_{L^\infty(\mathbb{R})}.\tag{2.3}
$$

Moreover,

$$
\|\mathcal{D}^{b}(hf)\|_{L^{2}(\mathbb{R})} \leq \|\mathcal{D}^{b}h\|_{L^{\infty}(\mathbb{R})}\|f\|_{L^{2}(\mathbb{R})} + \|h\|_{L^{\infty}(\mathbb{R})}\|\mathcal{D}^{b}f\|_{L^{2}(\mathbb{R})}.
$$
\n(2.4)

Proof. Note that [\(2.3\)](#page-6-0) follows from Lemma 2.7 in [\[10\]](#page-29-21), while [\(2.4\)](#page-6-1) is a consequence of [\(2.2\)](#page-5-1). \square

In our proofs, we need to deal with several pointwise estimates in terms of the Stein derivative. To handly with this kind estimates, we start by introducing a cut-off function

 $\chi \in C_0^{\infty}(\mathbb{R})$ such that supp $\chi \subset [-2, 2]$ and $\chi \equiv 1$ in $(-1, 1)$. (2.5)

The next result will be needed in the proof of Lemma [2.9.](#page-8-1)

Proposition 2.3. For any $\theta \in (0,1)$ and $\alpha > 0$, the function $\mathcal{D}^{\theta}(|\xi|^{\alpha}\chi(\xi)|(\cdot))$ is continuous in $\eta \in \mathbb{R} - \{0\}$ with

Proof. See Lemma 4 in [\[28\]](#page-30-0).

The next result is useful to prove the Lemma [2.9](#page-8-1) below.

Proposition 2.7. Let $\varrho \in L^{\infty}(\mathbb{R})$, with $\partial_x^k \varrho \in L^2(\mathbb{R})$ for $k = 1, 2$. Then, for any $\theta \in (0, 1)$, there exists a constant $c > 0$, depending only on ϱ and θ , such that

Note that A_j and B_k depends on ξ , t and \hat{f} , that is, $A_j = A_j(\xi, t, \hat{f})$ and $B_k = B_k(\xi, t, \hat{f})$, where $j = 1, ..., 11$ and $k = 1, ..., 18$.

The next three results below are useful to prove the Theorems [1.2–](#page-3-3)[1.4.](#page-3-4)

where we also used the Sobolev embedding.

\lesssim ||J^{(a+\beta)(1+\mu)}f|| + |||x|^{1+\mu}f||,
$$

where we used Lemma [2.6.](#page-6-6)

For $j \in \{2, 3, 4\}$ the idea of the proof is the same above. This ends the proof. \Box

In what follows, we will give the auxiliary results necessary to obtain our results for the Benjamin-Ono equation. We start by recalling the definition of the truncated weights $\langle x \rangle_N$, $N \in \mathbb{Z}^+$, which are given by

Also, we assume that $\langle x \rangle_N$ is smooth and non-decreasing in |x| with $\langle x \rangle'_{N}(x) \leq 1$, for any $x \geq 0$, and there exists a constant c independent of N such that $|\langle x \rangle''_{N}(x)| \leq$ $c\partial_x^2\langle x\rangle.$

To obtain the proof of Theorem [1.5,](#page-4-2) we need of the following auxiliary result. The Proposition 1 in [\[9\]](#page-29-14) tells us that

where $u = u(x, t)$ is solution of the IVP [\(1.2\)](#page-0-1) and I_3 is given in [\(1.20\)](#page-4-1).

To obtain the proof of Theorem [1.6](#page-4-3) we need of the following.

Remark 2.11. Let u_1 and u_2 solutions of the IVP [\(1.2\)](#page-0-1), with initial data ϕ and φ , respectively. If $w = u_1 - u_2$, then

3. Proof of Theorems [1.1–](#page-2-1)[1.2](#page-3-3)

The results that we give in this section shows us that the kind of uniqueness properties for the KdV equation (7) and Schrödinger equation (8) doesn't valid for the DGBO equation. As we already mentioned in the introduction, the objective of the Theorems [1.1](#page-2-1) and [1.2](#page-3-3) is to get a negative answer to the question [\(1.7\)](#page-2-0).

Proof of Theorem [1.1.](#page-2-1) First we observe that since $5/2 + a^- < 4$ we have $\phi, \varphi \in Z_{s,5/2+a^-}$. Hence, from Theorem A (part (iii)) there exists $T > 0$ such that $u_1, u_2 \in C([-T, T]; Z_{s,5/2+a^{-}})$. Consequently, the constant

N := \sup_{[-T,T]} \{ ||u_1(t)||_{H^{4(1+a)+1}} + ||u_2(t)||_{H^{4(1+a)+1}} + ||x|^{\frac{5}{2}}u_1(t)|| + ||x|^{\frac{5}{2}}u_2(t)|| \},\
$$

is finite.

By multiplying (1.15) by x^4 and using the Fourier transform we obtain

The idea now is to show that the right-hand side of [\(3.1\)](#page-10-0) is finite. Using [\(2.16\)](#page-7-1) with σ instead of f , the first term on the right-hand side of (3.1) can be estimated as

Let us estimate some of the terms C_j above. Note that [\(1.10\)](#page-2-4) and [\(1.11\)](#page-3-2) are equivalent to $\hat{\sigma}(0) = 0$ and $\partial_{\xi}\hat{\sigma}(0) = 0$, respectively. So, from Taylor's expansion with integral remainder we may write

Note that in view of the support of χ , the quantities $\|\chi|\xi|^{a-2}\xi^2\|$ and $\|(1-\chi)|\xi|^{a-2}\|_{L^\infty}$ are finite. Also, the fundamental theorem of calculus and hypothesis [\(1.11\)](#page-3-2) implies that

$$
\lesssim ||\langle x \rangle^{5/2+a^{-}}\sigma|| + ||\partial_{\xi}\hat{\sigma}||
$$

\n
$$
\lesssim ||\langle x \rangle^{5/2+a^{-}}\sigma||.
$$
\n(3.6)

Using the inequality $|\langle \xi \rangle^r \partial_{\xi} \hat{\sigma} | \lesssim |\partial_{\xi} (\langle \xi \rangle^r \hat{\sigma})| + |\langle \xi \rangle^{r-1} \hat{\sigma}|$, an application of Lemma [2.6](#page-6-6) gives

4. Proof of Theorems [1.3](#page-3-5) and [1.4](#page-3-4)

In arguments of the next proof, we make use of the conservation quantity (1.6) , beyond the several auxiliary results established in the Section [2.](#page-5-0)

5. Proof of Theorems [1.5](#page-4-2) and [1.6](#page-4-3)

In the following we will stablish our decay results for the Benjamin-Ono equation. Here we use the truncated weights $\langle x \rangle_N$ defined in the Section [2.](#page-5-0)

\frac{1}{2} \|\langle x \rangle_N x^4 w\|^2 + \int \langle x \rangle_N x^4 \mathcal{H} \partial_x^2 w \langle x \rangle_N x^4 w + \int \langle x \rangle_N^2 x^8 (u_1 \partial_x w + w \partial_x u_2) = 0. \tag{5.7}
$$

Following, our goal is to estimate the second term on the identity above. The identities

$$
x\mathcal{H}\partial_x^2 w = \mathcal{H}\partial_x^2(xw) - 2\mathcal{H}\partial_x w,
$$

$$
x^2\mathcal{H}\partial_x^2 w = \mathcal{H}\partial_x^2(x^2w) - 4\mathcal{H}\partial_x(xw) + 2\mathcal{H}w,
$$

$$
x^3\mathcal{H}\partial_x^2 w = \mathcal{H}\partial_x^2(x^3w) - 6\mathcal{H}\partial_x(x^2w) - 2\mathcal{H}(xw)
$$

together with [\(5.6\)](#page-25-4) gives us

$$
x^4\mathcal{H}\partial_x^2 w = \mathcal{H}\partial_x^2(x^4w) - 8\mathcal{H}\partial_x(x^3w) + 4\mathcal{H}(x^2w).
$$

Thus,

$$
\langle x \rangle_N x^4 \mathcal{H} \partial_x^2 w = \langle x \rangle_N \mathcal{H} \partial_x^2 (x^4 w) - 8 \langle x \rangle_N \mathcal{H} \partial_x (x^3 w) + 4 \langle x \rangle_N \mathcal{H} (x^2 w)
$$

 := $\mathcal{A} + \mathcal{B} + \mathcal{C}.$ (5.8)

To estimate the first term in the last identity we can write

$$
\mathcal{A} = [\langle x \rangle_N; \mathcal{H}] \partial_x^2 (x^4 w) + \mathcal{H}(\langle x \rangle_N \partial_x^2 (x^4 w))
$$

= $\mathcal{A}_1 + \mathcal{H} \partial_x^2 (\langle x \rangle_N x^4 w) - 2\mathcal{H}(\partial_x \langle x \rangle_N \partial_x (x^4 w)) - \mathcal{H}(\partial_x^2 \langle x \rangle_N x^4 w)$
= $\mathcal{A}_1 + \dots + \mathcal{A}_4.$ (5.9)

Thus, by the Calderón commutator estimate (see Theorem 6 in [\[11\]](#page-29-13) and references therein) we get

$$
\|\mathcal{A}_1\| \lesssim \|\partial_x^2 \langle x \rangle_N \|_{L^\infty} \|x^4 w\| \lesssim P. \tag{5.10}
$$

Also,

$$
\|\mathcal{A}_4\| \lesssim \|\partial_x^2 \langle x \rangle_N x^4 w\| \lesssim \|\partial_x^2 \langle x \rangle_N \|_{L^\infty} \|x^4 w\| \lesssim P. \tag{5.11}
$$

By returning the term A_2 in [\(5.7\)](#page-25-5) we get

$$
\int \mathcal{H} \partial_x^2 (\langle x \rangle_N x^4 w) \langle x \rangle_N x^4 w = 0. \tag{5.12}
$$

To estimate \mathcal{A}_3 , the inequality $|x\partial_x\langle x\rangle_N|\lesssim \langle x\rangle_N$ yields us

$$
\|A_3\| \lesssim \|\partial_x \langle x \rangle_N x^3 w\| + \|\partial_x \langle x \rangle_N x^4 \partial_x w\|
$$

\n
$$
\lesssim \|\langle x \rangle_N x^2 w\| + \underbrace{\|\langle x \rangle_N x^3 \partial_x w\|}_{F}
$$

\n
$$
\lesssim P + \|J(\langle x \rangle^3 \langle x \rangle_N w)\|
$$

\n
$$
\lesssim P + \|J^4(\langle x \rangle_N w)\| + \|\langle x \rangle^4 \langle x \rangle_N w\|
$$

\n
$$
\lesssim P + \|J^5 w\| + \|\langle x \rangle^5_N w\| + \|\langle x \rangle^4 \langle x \rangle_N w\|
$$

\n
$$
\lesssim P + \|\langle x \rangle^4 \langle x \rangle_N w\|,
$$

\n
$$
\lesssim P + \|\langle x \rangle^4 \langle x \rangle_N w\|,
$$

where above we used Lemma [2.6](#page-6-6) (with $\alpha = b = 4$ and $\alpha = b = 5$). To estimate term $\mathcal B$ we can write

$$
\langle x \rangle_N \mathcal{H} \partial_x (x^3 w) = \left[\langle x \rangle_N; \mathcal{H} \right] \partial_x (x^3 w) + \mathcal{H} (\langle x \rangle_N \partial_x (x^3 w))
$$

 := $\mathcal{B}_1 + \mathcal{B}_2.$ (5.14)

Thus, by the Calderón commutator estimate

$$
\|\mathcal{B}_1\| \lesssim \|\partial_x \langle x \rangle_N \|_{L^\infty} \|x^3 w\| \lesssim P. \tag{5.15}
$$

Also, from [\(5.13\)](#page-26-0)

$$
\|\mathcal{B}_2\| \lesssim \|\langle x \rangle_N x^2 w\| + \|\langle x \rangle_N x^3 \partial_x w\| \lesssim P + \|\langle x \rangle^4 \langle x \rangle_N w\|.
$$
 (5.16)

hypotheses (1.18) – (1.20) and identity (2.24) imply that

$$
C \lesssim \|\mathcal{H}(x^2w)\| + \|x\mathcal{H}(x^2w)\| \lesssim \|x^2w\| + \|\mathcal{H}(x^3w)\| \lesssim \|x^2w\| + \|x^3w\| \lesssim P. \tag{5.17}
$$

Hence, by $(5.9)–(5.17)$ $(5.9)–(5.17)$

$$
\mathcal{A} \lesssim \|x^4 \langle x \rangle_N^{1+\theta} w \| + P. \tag{5.18}
$$

About the nonlinear term in [\(5.7\)](#page-25-5) we see that

$$
\int \langle x \rangle_N^2 x^8 w(u_1 \partial_x w + w \partial_x u_2) = -\frac{1}{2} \int \left(\partial_x (x^8 \langle x \rangle_N^2) u_1 + x^8 \langle x \rangle_N^2 \partial_x u_1 \right) w^2 +
$$

+
$$
\int x^8 \langle x \rangle_N^2 w^2 \partial_x u_2
$$

$$
\lesssim (\|u_1\|_{L^\infty} + \|\partial_x u_2\|_{L^\infty}) \|x^4 \langle x \rangle_N w\|^2 + P^2
$$

$$
\lesssim P(P + \|x^4 \langle x \rangle_N w\|^2),
$$
 (5.19)

where above we used integration by parts, Sobolev's embedding and the inequality

$$
|\partial_x(x^8 \langle x \rangle_N^2)| \lesssim (1+x^8) \langle x \rangle_N^2.
$$

By the above inequalities we conclude that

$$
\frac{d}{dt} \|\langle x \rangle_N x^4 w\|^2 \lesssim (1+P) \|\langle x \rangle_N x^4 w\|^2 + P^2.
$$

Thus, by Gronwall's Lemma

$$
\sup_{[-T,T]} \|\langle x \rangle_N x^4 w\| \le c(T).
$$

On the other hand, we obtain $w \in C([-T,T]; Z_{s,r})$ by similar ideas presented in [\[5\]](#page-29-22). This finishes the proof.

The following result allows us to extend the Theorem D, by assuming an additional decay on initial data of the order $3/2^-$.

Proof of Theorem [1.6.](#page-4-3) Suppose that $\theta \in (0, 1/2)$. Let u_1 and u_2 solutions of the IVP [\(1.1\)](#page-0-0) with initial data ϕ and φ , respectively. As before, let $\sigma = \phi - \varphi$ and $w = u_1 - u_2$. Thus, Theorems A and [1.5](#page-4-2) imply that, for all $T > 0$, the constant

$$
\tilde{P} = \sup_{[-T,T]} \{ \|u_1(t)\|_{H^s} + \|u_2(t)\|_{H^s} + \|w(t)\|_{Z_{s,5}} \} < \infty. \tag{5.20}
$$

In a similar way to the proof of the Theorem [1.5](#page-4-2) we obtain

$$
\frac{1}{2} \|\langle x \rangle_N^{1+\theta} x^4 w\|^2 + \int \langle x \rangle_N^{1+\theta} x^4 \mathcal{H} \partial_x^2 w \langle x \rangle_N^{1+\theta} x^4 w + \int \langle x \rangle_N^{2+2\theta} x^8 (u_1 \partial_x w + w \partial_x u_2) = 0, \qquad (5.21)
$$

where

$$
\langle x \rangle_N^{1+\theta} x^4 \mathcal{H} \partial_x^2 w = \langle x \rangle_N^{1+\theta} \mathcal{H} \partial_x^2 (x^4 w) - 8 \langle x \rangle_N^{1+\theta} \mathcal{H} \partial_x (x^3 w) + 4 \langle x \rangle_N^{1+\theta} \mathcal{H} (x^2 w)
$$

 := $\tilde{\mathcal{A}} + \tilde{\mathcal{B}} + \tilde{\mathcal{C}}.$ (5.22)

Next, we will deal with the terms above. Then

$$
\tilde{\mathcal{A}} = [\langle x \rangle_N^{1+\theta}; \mathcal{H}] \partial_x^2 (x^4 w) + \mathcal{H}(\langle x \rangle_N^{1+\theta} \partial_x^2 (x^4 w))
$$
\n
$$
= \tilde{\mathcal{A}}_1 + \mathcal{H} \partial_x^2 (\langle x \rangle_N^{1+\theta} x^4 w) - 2 \mathcal{H}(\partial_x \langle x \rangle_N^{1+\theta} \partial_x (x^4 w)) - \mathcal{H}(\partial_x^2 \langle x \rangle_N^{1+\theta} x^4 w)
$$
\n
$$
= \tilde{\mathcal{A}}_1 + \dots + \tilde{\mathcal{A}}_4.
$$
\n(5.23)

Thus, by the Calderón commutator estimate we conclude

$$
\|\tilde{\mathcal{A}}_1\| \lesssim \|\partial_x^2 \langle x \rangle_N^{1+\theta} \|_{L^\infty} \|x^4 w\| \lesssim \tilde{P}.\tag{5.24}
$$

Also,

$$
\|\tilde{\mathcal{A}}_4\| \lesssim \|\partial_x^2 \langle x \rangle_N^{1+\theta} x^4 w\| \lesssim \|\partial_x^2 \langle x \rangle_N^{1+\theta} \|_{L^\infty} \|x^4 w\| \lesssim \tilde{P}.
$$
 (5.25)

 $\hfill \square$

By returning the term \tilde{A}_2 in [\(5.7\)](#page-25-5) we obtain

$$
\int \mathcal{H} \partial_x^2 (\langle x \rangle_N^{1+\theta} x^4 w) \langle x \rangle_N^{1+\theta} x^4 w = 0.
$$
 (5.26)

To estimate \tilde{A}_3 , the inequality $|x\partial_x\langle x\rangle_N|\lesssim \langle x\rangle_N$ yields us

$$
\|\tilde{\mathcal{A}}_{3}\| \lesssim \| \langle x \rangle_{N}^{\theta} \partial_{x} \langle x \rangle_{N} x^{3} w \| + \| \langle x \rangle_{N}^{\theta} \partial_{x} \langle x \rangle_{N} x^{4} \partial_{x} w \|
$$

\n
$$
\lesssim \| \langle x \rangle_{N}^{1+\theta} x^{2} w \| + \| \langle x \rangle_{N}^{1+\theta} x^{3} \partial_{x} w \|
$$

\n
$$
\lesssim \tilde{P} + \tilde{F}.
$$
\n(5.27)

Using [\[11,](#page-29-13) Theorem 4] and identity $\widehat{\partial_x(x^3w)}(0,t) = 0$, the term $\tilde{\mathcal{B}}$ can be estimated as

$$
\tilde{\beta} \lesssim \| \langle x \rangle_N^{\theta} \mathcal{H} \partial_x (x^3 w) \| + \| \langle x \rangle_N^{\theta} x \mathcal{H} \partial_x (x^3 w) \| \n\lesssim \| \langle x \rangle_N^{\theta} \partial_x (x^3 w) \| + \| \langle x \rangle_N^{\theta} \mathcal{H} (x \partial_x (x^3 w)) \| \n\lesssim \| \langle x \rangle_N^{\theta} x^2 w \| + \| \langle x \rangle_N^{\theta} x^3 \partial_x w \| + \| \langle x \rangle_N^{\theta} x^3 w \| + \| \langle x \rangle_N^{\theta} x^4 \partial_x w \| \n\lesssim \tilde{P} + \underbrace{\| \langle x \rangle_N^{\theta} \langle x \rangle^4 \partial_x w}_{\tilde{F}} \bigg|.
$$
\n(5.28)

By Lemma [2.6](#page-6-6) (with $\alpha = 5(1 + \theta)$ and $b = 5$)

$$
\tilde{F} \lesssim ||J(\langle x \rangle_N^{\theta} \langle x \rangle^4 w)|| + ||x^4 w|| + ||\langle x \rangle_N^{\theta} \langle x \rangle^3 w||
$$
\n
$$
\lesssim ||J^{1+\theta}(\langle x \rangle^4 w)|| + ||\langle x \rangle_N^{1+\theta} \langle x \rangle^4 w||
$$
\n
$$
\lesssim ||J^{5(1+\theta)} w|| + ||\langle x \rangle_N^{5} w|| + ||\langle x \rangle_N^{1+\theta} \langle x \rangle^4 w||
$$
\n
$$
\lesssim \tilde{P} + ||\langle x \rangle_N^{1+\theta} x^4 w||.
$$
\n(5.29)

Also, the Theorem 4 in [\[11\]](#page-29-13), equality (2.24) and (1.18) – (1.20) yields us

\tilde{\mathcal{C}} \lesssim \| \langle x \rangle_N^{\theta} \mathcal{H}(x^2 w) \| + \| \langle x \rangle_N^{\theta} x \mathcal{H}(x^2 w) \| \n\lesssim \| \langle x \rangle_N^{\theta} x^2 w \| + \| \langle x \rangle_N^{\theta} \mathcal{H}(x^3 w) \| \n\lesssim \| \langle x \rangle_N^{\theta} x^2 w \| + \| \langle x \rangle_N^{\theta} x^3 w \| \n\lesssim \| \langle x \rangle_N^{1+\theta} \langle x \rangle^4 w \| \n\lesssim \tilde{P} + \| \langle x \rangle_N^{1+\theta} x^4 w \|.

Hence, by [\(5.23\)](#page-27-0)–[\(5.30\)](#page-28-0)

\tilde{\mathcal{A}} \lesssim \|x^4 \langle x \rangle_N^{1+\theta} w \| + \tilde{P}.\tag{5.31}

About the nonlinear term in [\(5.21\)](#page-27-1) we see that

\int \langle x \rangle_N^{2+2\theta} x^8 w(u_1 \partial_x w + w \partial_x u_2) = -\frac{1}{2} \int \left(\partial_x (x^8 \langle x \rangle_N^{2+2\theta}) u_1 + x^8 \langle x \rangle_N^{2+2\theta} \partial_x u_1 \right) w^2 + \n+ \int x^8 \langle x \rangle_N^{2+2\theta} w^2 \partial_x u_2 \n\lesssim (\|u_1\|_{L^\infty} + \|\partial_x u_2\|_{L^\infty}) \|x^4 \langle x \rangle_N^{1+\theta} w\|^2 + \tilde{P}^2 \n\lesssim \tilde{P}(\tilde{P} + \|x^4 \langle x \rangle_N^{1+\theta} w\|^2),
$$
\n(5.32)

where above we used integration by parts, Sobolev's embedding and the inequality

|\partial_x(x^8\langle x\rangle_N^{2+2\theta})| \lesssim (1+x^8)\langle x\rangle_N^{2+2\theta}.
$$

By the above inequalities we conclude that

\frac{d}{dt}\|\langle x \rangle_N^{1+\theta} x^4 w\|^2 \lesssim (1+\tilde{P})\|\langle x \rangle_N^{1+\theta} x^4 w\|^2 + \tilde{P}^2.
$$

Thus, Gronwall's Lemma yields us

\sup_{[-T,T]} \| \langle x \rangle_N^{1+\theta} x^4 w \| \le \tilde{c}(T).
$$
