ON IMPLICITLY OSCILLATORY QUADRILINEAR INTEGRALS

1. INTRODUCTION

1.1. Formulation of the main result. Let B be a nonempty open ball of finite radius in \mathbb{R}^2 , and let \tilde{B} be a connected open neighborhood of B. For $j \in \{1, 2, 3, 4\}$, let $\varphi_j : \tilde{B} \to \mathbb{R}$ be a C^{ω} submersion. Write $\underline{3} = \{1,2,3\}, \underline{4} = \{1,2,3,4\},\$ and $\mathbf{\Phi} = (\varphi_j : j \in \underline{4}).$

Consider quadrilinear functionals

(1.1)
$$
\mathcal{T}(\mathbf{f}) = \int_{\mathbb{R}^2} \prod_{j \in \underline{4}} (f_j \circ \varphi_j)(x) \, \eta(x) \, dx,
$$

acting on $f = (f_j : j \in \underline{4})$, with each $f_j : \mathbb{R}^1 \to \mathbb{C}$ Lebesgue measurable and belonging to an appropriate function space. Throughout the discussion, $\eta \in C^{\infty}(\mathbb{R}^2)$ is a smooth cutoff function supported in B .

We impose the following hypothesis, which is a necessary condition for the conclusion that we seek.

Hypothesis 1 (Main hypothesis). Let $\Omega \subset B$ be open and connected. Let $(F_j : j \in \underline{4})$ be a tuple of C^{ω} functions $F_j : \varphi_j(\Omega) \to \mathbb{R}$. If $\sum_{j=1}^4 F_j \circ \varphi_j \equiv 0$ in Ω then each F_j is constant.

For $\sigma \in \mathbb{R}$ and $p \in (1,\infty)$, denote by $W^{p,\sigma}$ the Sobolev space of functions having σ derivatives in $L^p(\mathbb{R})$. Our main result is the following theorem, whose other hypotheses are formulated below.

Theorem 1.1. Let Φ satisfy the main hypothesis [1,](#page-0-0) the transversality hypothesis [2,](#page-1-0) and the auxiliary hypotheses [3,](#page-1-1) [4,](#page-2-0) and [5.](#page-2-1) For any $p > 2$ and any $\eta \in C_0^{\infty}(B)$, there exist $\sigma < 0$ and $C < \infty$ such that for every four-tuple $\mathbf{f} = (f_1, \ldots, f_4)$ of functions in $L^p(\mathbb{R}^1),$

(1.2)
$$
|\mathcal{T}(\mathbf{f})| \leq C \prod_{j \in \underline{4}} ||f_j||_{W^{p,\sigma}}.
$$

A special case of the corresponding result with two factors f_j is a restatement of this well-known fact: Let $t \mapsto \gamma(t)$ be a real analytic mapping from \mathbb{R}^1 to \mathbb{R}^2 . Let $\eta \in C^{\infty}(\mathbb{R})$ be compactly supported. Define a measure μ in \mathbb{R}^2 by \int Let $\eta \in C^{\infty}(\mathbb{R})$ be compactly supported. Define a measure μ in \mathbb{R}^2 by $\int g d\mu = \int_{\mathbb{R}} g(\gamma(t)) \eta(t) dt$. If the range of γ is not contained in any affine subspace of \mathbb{R}^2 then there exists $\delta > 0$ such that the Fourier transform of μ satisfies $|\mu(\xi)| = O(|\xi|^{-\delta})$ as $|\xi| \to \infty$.

An immediate application is to weak continuity of mappings $f \mapsto \prod_{j\in \underline{4}} (f_j \circ \varphi_j)$. Joly, Métivier, and Rauch [\[8\]](#page-27-0) proved weak continuity with this application in mind, for threefold products, with weaker auxiliary hypotheses all around. Their proof was based on microlocal defect measures and an argument by contradiction, and yielded no quantitative upper bound corresponding to [\(1.2\)](#page-0-1). For threefold products, an inequality in terms of negative order Sobolev norms was proved by Bourgain [\[1\]](#page-27-1) in a particular case, and later by the author [\[2\]](#page-27-2) in a relatively general C^{ω} case. More recently, Evans [\[7\]](#page-27-3) has developed another proof for threefold products. A more streamlined version of the analysis in [\[2\]](#page-27-2), with certain supplementary hypotheses relaxed, is presented in [\[6\]](#page-27-4).

Fourfold products, with integration over two-dimensional domains, are more singular and apparently require significantly more intricate analysis. One indication of this is the failure of the inequality to hold for $p = 2$ with four factors, while it extends to all $p > 3/2$ for three factors, leading to a useful gain in certain Fourier coefficient-based estimates — the same phenomenon that arises in Roth's theorem concerning arithmetic progressions of length three [\[9\]](#page-27-5).

1.2. Hypotheses, and comments on them. Hypothesis [1](#page-0-0) is necessary for the conclusion [\(1.2\)](#page-0-1) to hold. Indeed, suppose $\sum_j (F_j \circ \varphi_j) \equiv 0$ in some open set. For large $\lambda \in \mathbb{R}^+$, define $f_j = \eta_j e^{i\lambda F_j}$ for suitable C_0^{∞} cutoff functions η_j . Then $\prod_j (f_j \circ \varphi_j)$ is independent of λ , and the cutoff functions can be chosen so that its integral does not vanish. On the other hand, if some real-valued function F_k is nonconstant, and if η_k is chosen to be supported in an open set in which ∇F_k vanishes nowhere, then for any strictly negative parameter σ , $\|\eta_k e^{i\lambda F_k}\|_{W^{p,\sigma}}$ tends to 0 as $\lambda \to \infty$. Thus [\(1.2\)](#page-0-1) cannot hold.

Throughout the paper, we impose a transversality hypothesis on Φ .

Hypothesis 2 (Transversality). For each pair of distinct indices $j \neq k \in \underline{4}$, $\nabla \varphi_j$, $\nabla \varphi_k$ are linearly independent at each point of B.

This transversality hypothesis guarantees that the integral defining $\mathcal{T}(\mathbf{f})$ converges absolutely when each $f_j \in L^2$, and that $|\mathcal{T}(\mathbf{f})| \leq C \prod_{j=1}^4 ||f_j||_{L^2}$. In this inequality, L^2 cannot be replaced by L^p for any $p < 2$. This can be seen by choosing any point x, setting f_i equal to the indicator function of an interval of length ε centered at $\varphi_i(x)$, and evaluating both sides of the inequality as $\varepsilon \to 0$.

We will impose three auxiliary hypotheses, each of which holds for generic data **Φ**. For each $j \in \underline{4}$, let V_j be a nowhere vanishing C^{ω} vector field in \tilde{B} that satisfies $V_i(\varphi_i) \equiv 0.$

Hypothesis 3. For any $k \in \underline{4}$, on any connected open set $\omega \subset \tilde{B} \subset \mathbb{R}^2$ with nonempty interior, any C^{ω} solution $(F_j : j \neq k)$ of the equation

(1.3)
$$
\sum_{j \neq k} (F_j \circ \varphi_j) V_k \varphi_j \nabla \varphi_j \equiv 0
$$

in ω satisfies $F_i \circ \varphi_i \equiv 0$ in ω for each $j \neq k$.

Equation [\(1.3\)](#page-1-2) is a system of two scalar equations in three scalar-valued unknown functions F_j .

Hypothesis 4. Endow $\mathbb{R}^3 = \mathbb{R}^2 \times \mathbb{R}^1$ with coordinates (x, s) . For each $k \in \underline{4}$ and each $j \neq k$, define

(1.4)
$$
\Phi_{j,k} = (\varphi_j(x), sV_k\varphi_j(x)).
$$

Define $W_{j,k}$ to be nowhere vanishing C^{ω} vector fields in $\tilde{B}\times\mathbb{R}^1$ that satisfy $W_{j,k}(\Phi_{j,k})\equiv$ 0. Then for each $k \in \underline{4}$, the three-tuple of vector fields $\{W_{j,k} : j \neq k\}$ is linearly independent at each point of $B \times (\mathbb{R} \setminus \{0\})$.

If $i, j, k \in \underline{4}$ are pairwise distinct then since $\nabla_x \varphi_i$, $\nabla \varphi_j$ are linearly independent at each point of \tilde{B} , then $\nabla_{x,s}\Phi_{i,k}$ and $\nabla_{x,s}\Phi_{j,k}$ are likewise linearly independent at each point of $B \times \mathbb{R}$.

Hypothesis 5. For each permutation (i, j, k, l) of $(1, 2, 3, 4)$, for each $\tau \in \mathbb{R}$, the function

(1.5)
$$
\frac{V_l \varphi_i \cdot |V_k \varphi|^{\tau}}{V_l \varphi_j \cdot |V_k \varphi_j|^{\tau}}
$$

cannot be expressed as a ratio $\frac{h_i \circ \varphi_i}{h_j \circ \varphi_j}$, with h_i, h_j real analytic, in any nonempty open subset of \mathbb{R}^2 .

It can be shown that generic tuples Φ do satisfy the main hypothesis [1,](#page-0-0) and more generally, generic *n*-tuples $\mathbf{\Phi} = (\varphi_1, \ldots, \varphi_n)$ of mappings satisfy the analogous condition for arbitrarily large n. More precisely, there exist $N < \infty$ and a nonempty Zariski open subset Ω of the Euclidean space of all N-jets of n-tuples of functions at $0 \in \mathbb{R}^2$ such that for any real analytic Φ whose N-jet at 0 belongs to Ω , there exists a ball B centered at 0 in which hypothesis [1](#page-0-0) is satisfied. Likewise, all of the auxiliary hypotheses also hold for generic Φ .

The main hypothesis implies a weak form of transversality: for any $j \neq k$, $V_k(\varphi_j)$ does not vanish identically.

The hypothesis of real analyticity of Φ represents a compromise that simplifies both the formulation of Theorem [1.1,](#page-0-2) and its proof. As is shown in [\[3\]](#page-27-6) and in $[6]$, it implies a formally stronger quantitative formulation: There exist C, N such that for all $f \in C^N$ and all $x \in B$,

$$
(1.6) \qquad \sum_{j=1}^4 \sum_{0 < n \le N} \left| \partial^n (f_j \circ \varphi_j)(x) \right| \le C \sum_{0 < |\alpha| \le N} \left| \partial^\alpha \sum_{k=1}^4 (f_k \circ \varphi_k)(x) \right|.
$$

Here $\partial^n = d^n/dy^n$ and $\partial^\alpha = \partial^\alpha/\partial x^\alpha$. The author believes that for any N, Theo-rem [1.1](#page-0-2) extends to C^{N+1} data Φ satisfying [\(1.6\)](#page-2-2), with the transversality and auxiliary hypotheses significantly relaxed. For real analytic Φ , we believe that the transversality hypothesis can be relaxed to the assumption that no two $\nabla\varphi_i$ are everywhere linearly dependent, and that the three auxiliary hypotheses can be omitted entirely. It is shown for threefold products in [\[6\]](#page-27-4) and for a related additive problem in [\[3\]](#page-27-6) how

results with relaxed auxiliary hypotheses can be obtained as consequences of results with strong auxiliary hypotheses, in closely related contexts.

Key ingredients in the proof of Theorem [1.1](#page-0-2) were developed in [\[2\]](#page-27-2), [\[4\]](#page-27-7), and [\[3\]](#page-27-6) in that order, with their eventual application to Theorem [1.1](#page-0-2) envisioned.

The author is indebted to Terence Tao and Craig Evans for calling to his attention the works of Bourgain $[1]$ and of Joly, Métivier, and Rauch $[8]$, respectively.

2. PARAMETERS

Certain positive parameters are to be chosen in the course of the proof. In order to avoid any appearance of circularity, we specify here the order in which these are to be chosen, which is not the order in which they will arise in the exposition. $\gamma \in (\frac{1}{2})$ $(\frac{1}{2}, 1)$ is to be chosen first, and is an arbitrary element of that interval. Each of the other parameters is chosen to be sufficiently small relative to parameters chosen earlier, and relative to other quantities that are determined, at least implicitly, by parameters chosen earlier. The next parameter chosen is τ_0 , then $\rho_0, \delta_0, \delta_1, \delta_3, \delta_4, \delta_1^*, \delta_2^*, \delta_3^*, \delta_4^*,$ and finally ρ , in that order. Thus at every step, we may assume that ρ is as small as may be desired, relative to all other positive parameters that arise. δ_2 and δ_5 are not chosen, but are determined by other parameters.

3. Decompositions

3.1. **Fourier decomposition.** Under the transversality hypothesis, one has for any permutation (i, j, k, l) of $(1, 2, 3, 4)$

$$
(3.1) \t\t |\mathcal{T}(\mathbf{f})| \leq C \|f_i\|_{L^1} \|f_j\|_{L^1} \|f_k\|_{L^\infty} \|f_l\|_{L^\infty}.
$$

Therefore by interpolation,

(3.2)
$$
|\mathcal{T}(\mathbf{f})| \leq C \prod_{j \in \underline{4}} ||f_j||_{L^2}.
$$

Therefore Theorem [1.1](#page-0-2) is an immediate consequence, by decomposition and interpolation, of the following proposition.

Proposition 3.1. Let Φ satisfy the hypotheses of Theorem [1.1.](#page-0-2) There exists $\delta > 0$ such that for any $\eta \in C_0^{\infty}(\mathbb{R}^2)$ supported in B, there exists $C < \infty$ with the following property. Let $\lambda \geq 1$. Let $f_j \in L^{\infty}(\mathbb{R})$. Assume that $\widehat{f_j(\xi)}$ is supported where $|\xi| \leq 2\lambda$ for each $j \in \underline{4}$, and that $\widehat{f_1(\xi)}$ is supported where $\frac{1}{2}\lambda \leq |\xi| \leq 2\lambda$. Then

(3.3)
$$
|\mathcal{T}(\mathbf{f})| \leq C\lambda^{-\delta} \prod_{j \in \underline{4}} ||f_j||_{L^{\infty}}.
$$

Throughout the analysis, we assume without loss of generality that λ is large. Thus if $c_1 < c_2$ are constants then λ^{c_1} is small relative to λ^{c_2} .

3.2. $\not\vdash/\nsharp$ decomposition. A basic strategy is to apply the Cauchy-Schwarz inequality to eliminate one of the four functions f_j . This transforms the remaining functions f_k to associated functions $\mathcal{D}_s f_k$, as follows.

Definition 6. For $x, s \in \mathbb{R}$ and $f : \mathbb{R} \to \mathbb{C}$,

(3.4)
$$
\mathcal{D}_s f(x) = f(x+s) f(x).
$$

If f is highly oscillatory, then $\mathcal{D}_s f$ need not be so; if for instance $f(x) = e^{i\lambda x}$ then $\mathcal{D}_s f$ is a constant function of x for each s. On the other hand, if $f(x) = e^{i\lambda x^2}$ with $\lambda \in \mathbb{R}$ and $|\lambda|$ large, then $\mathcal{D}_s f(x)$ takes the form $c(s)e^{i2s\lambda x}$ with $|c(s)| \equiv 1$. The next lemma is based on a simple characterization of those functions for which $\mathcal{D}_s f$ is not highly oscillatory.

Lemma 3.2. [\[4\]](#page-27-7) Let $\delta > 0$ and $R \geq 1$. For any $f \in L^2(\mathbb{R})$ there exists a decomposition $f = f_{\sharp} + f_{\flat}$ satisfying $||f_{\sharp}||_{L^2} + ||f_{\flat}||_{L^2} \lesssim ||f||_{L^2}$, with the following supplementary properties.

The summand f [#] admits a decomposition

(3.5)
$$
f_{\sharp}(x) = \sum_{n=1}^{M} h_n(x)e^{i\alpha_n x}
$$

with each $\alpha_n \in \mathbb{R}$, and with each h_n a smooth function satisfying

(3.6)
$$
\begin{cases} \|\partial^N h_n\|_{\infty} \leq C_N R^N \|f\|_{\infty} \forall N \geq 0, \\ \|h_n\|_{L^2} \lesssim \|f\|_{L^2}, \\ \widehat{h_n} \text{ is supported in } [-R, R], \\ M \lesssim R^{\delta}. \end{cases}
$$

Moreover, the support of f [#] is contained in a CR -neighborhood of the support of f. Finally, if $f \in L^{\infty}$ then

(3.7) kf♯k[∞] . M¹/² kfk∞.

The summand f_\flat satisfies

(3.8)
$$
\int_{\mathbb{R}} \int_{|\xi| \leq R} |\widehat{\mathcal{D}_s f_\flat}(\xi)|^2 d\xi ds \lesssim R^{-\delta} \|f\|_{L^2}^4.
$$

All implicit constants are independent of R, f.

Thus for most s, the function $x \mapsto \mathcal{D}_s f_\flat(x)$ either has small norm, or is highly oscillatory. The conclusion [\(3.7\)](#page-4-0) is not stated explicitly in [\[4\]](#page-27-7), but is an immediate consequence of the construction given there.

3.3. Local $\not\vdash \sharp$ decomposition. The proof of Theorem [1.1](#page-0-2) is structured around a local version of Lemma [3.2.](#page-4-1) Fix auxiliary parameters $\gamma \in (\frac{1}{2})$ $(\frac{1}{2}, 1)$ and $\tau_0 > 0$ satisfying

$$
\gamma + \tau_0 < 1.
$$

Let **f** be given, satisfying the hypotheses of Proposition [3.1](#page-3-0) with respect to a large parameter $\lambda \in \mathbb{R}^+$. We may assume henceforth, with no loss of generality, that $||f_j||_{\infty} = O(1)$ for each $j \in \underline{4}$.

For $m \in \mathbb{Z}$ let I_m, I_m^* be the intervals of lengths $\lambda^{-\gamma}$ and $3\lambda^{-\gamma}$, respectively, centered at $m\lambda^{-\gamma}$. Introduce a partition of unity $1 = \sum_m \eta_m^2$ in \mathbb{R}^1 , with each $\eta_m \in C_0^{\infty}$ supported in the interval concentric with I_m of sidelength $2\lambda^{-\gamma}$, and satisfying $\|\nabla^N \eta_m\|_{C^0} = O(\lambda^N)$ for every nonnegative integer N. Decompose

(3.10)
$$
f_j = \sum_{m \in \mathbb{Z}} \eta_m f_{j,m} \text{ with } f_{j,m} = \eta_m f_j.
$$

For each $j \in \underline{4}$ and $m \in \mathbb{Z}$, apply Lemma [3.2](#page-4-1) to the function $y \mapsto f_{j,m}(\lambda^{-\gamma}y)$, with the parameter R of that lemma defined to be $R = \lambda^{\tau_0}$, and with the parameter δ of that lemma chosen to be a small number $\delta_j^* > 0$ that depends on j. In the final step of the proof of Theorem [1.1,](#page-0-2) in §[10,](#page-26-0) the four values δ_j^* will be chosen, but for the present, each δ_j^* is small but otherwise arbitrary.

Reverse this linear change of variables for each m , to express

(3.11)
$$
f_j = f_{j,\sharp} + f_{j,\flat} \text{ with }\begin{cases} f_{j,\sharp} = \sum_{m \in \mathbb{Z}} \eta_m \cdot f_{j,m,\sharp} \\ f_{j,\flat} = \sum_{m \in \mathbb{Z}} \eta_m \cdot f_{j,m,\flat} \end{cases}
$$

where the terms $f_{j,m,\sharp}$ enjoy these properties:

(3.12)
$$
f_{j,m,\sharp}(x) = \sum_{n=1}^{M} h_{j,m,n}(x) e^{i\alpha_{j,m,n}x}
$$

with

(3.13)
$$
\begin{cases} |\alpha_{j,m,n}| = O(\lambda), \\ M = O(\lambda^{\delta_j^*\tau_0/2}), \\ ||\partial^N h_{j,m,n}||_{\infty} = O_N(\lambda^{(\tau_0+\gamma)N}) \text{ for every } N \in \mathbb{N}, \\ \widetilde{h_{j,m,n}}(\xi) \text{ is supported where } |\xi| \leq \lambda^{\tau_0+\gamma}. \end{cases}
$$

Moreover,

$$
(3.14) \t\t\t | \alpha_{1,m,n} | \gtrsim \lambda.
$$

This lower bound for $|\alpha_{1,m,n}|$ holds by the assertion concerning the support of f_{\sharp} in Lemma [3.2,](#page-4-1) since $f_1(\xi)$ is assumed to be supported where $|\xi| \gtrsim \lambda$ and $R = \lambda^{\tau_0}$ is chosen to be small relative to λ .

The summands $f_{j,m,b}$ satisfy

(3.15)
$$
\int_{\mathbb{R}} \int_{|\xi| \leq \lambda^{\tau_0 + \gamma}} |\widehat{\mathcal{D}_s f_{j,m,\flat}}(\xi)|^2 d\xi ds \lesssim \lambda^{-\delta_j^*} \lambda^{-2\gamma}.
$$

The factor of $\lambda^{-2\gamma}$ arises because $||f_{j,m}||_{L^2}^4 = O(\lambda^{-2\gamma})$, which is a consequence of the hypothesis that $||f_j||_{L^{\infty}} = O(1)$. The factor $\lambda^{-\delta_j^*}$ encodes an improvement over this trivial bound $O(\lambda^{-2\gamma})$.

4. CONTRIBUTION OF $(f_{1,\sharp}, f_{2,\sharp}, f_{3,\sharp}, f_{4,\sharp})$

In this section, we analyze $\mathcal{T}(\mathbf{g}) = \mathcal{T}(g_1, \ldots, g_4)$ with each g_j of the local exponential monomial form

(4.1)
$$
g_j(x) = \sum_{m \in \mathbb{Z}} \eta_m(x) h_{j,m}(x) e^{i\alpha_{j,m}x}
$$

and satisfying

(4.2)
$$
\begin{cases} \alpha_{j,m} \in \mathbb{R}, \\ |\alpha_{j,m}| = O(\lambda), \\ |\alpha_{1,m}| \asymp \lambda, \\ ||h_{j,m}||_{C^N} = O_N(\lambda^{(\gamma + \tau_0)N}) \text{ for every } N \ge 0. \end{cases}
$$

with the auxiliary functions η_m introduced in §[3.3.](#page-4-2) Thus g_j is of the form $f_{j,\sharp}$ in the local $\not\parallel \psi \parallel$ decomposition, but with a single summand for each index m; in this respect, the title of this section is a misnomer. Multilinearity of the form $\mathcal T$ will be used in §[10](#page-26-0) to reduce matters to this local monomial case.

Proposition 4.1. There exist $\kappa > 0$ and $C < \infty$ such that for any g of the form (4.1) satisfying (4.2) ,

$$
(4.3) \t\t |\mathcal{T}(\mathbf{g})| \le C\lambda^{-\kappa}.
$$

 $κ$ depends only on Φ and on the choices of $γ$ and of $τ_0$. The constant C also depends on the constants implicit in [\(4.2\)](#page-6-1). Neither κ nor C depends on λ , nor on other properties of g.

In proving Proposition [4.1,](#page-6-2) we may assume that for each j, the sum in (4.1) extends over values of $m \in \mathbb{Z}$ that all lie in a common congruence class modulo 3. We reduce to this situation by decomposing the sum over all $m \in \mathbb{Z}$ into 3 subsums and invoking the multilinearity of $\mathcal T$. Doing this for each index $j \in \underline{4}$ results in a decomposition of $\mathcal{T}(\mathbf{g})$ into 81 terms. It suffices to examine one such term. Thus we may assume henceforth that each g_j is a sum (4.1) over m lying in one such congruence class. The terms in such a sum have supports in pairwise disjoint intervals I_m^* .

Proof of Proposition [4.1.](#page-6-2) The multilinearity of $\mathcal T$ gives an expansion

(4.4)
$$
\mathcal{T}(\mathbf{g}) = \sum_{\mathbf{m}\in\mathbb{Z}^4} I_{\mathbf{m}}
$$

with

(4.5)
$$
I_{\mathbf{m}} = \int e^{i\Phi_{\mathbf{m}}(x)} \prod_{j=1}^{4} h_{j,m_j}(\varphi_j(x)) \eta_{m_j}(\varphi_j(x)) dx
$$

and

(4.6)
$$
\Phi_{\mathbf{m}}(x) = \sum_{j=1}^{4} \alpha_{j,m_j} \varphi_j(x).
$$

In the sum [\(4.4\)](#page-6-3), each $m_i \in \mathbb{Z}$ is implicitly restricted to some congruence class modulo 3, which depends on j. Terms with different indices m_j thus have disjoint supports.

We say that $\mathbf{m} = (m_1, \ldots, m_4) \in \mathbb{Z}^4$ is interacting if there exists $x \in B$ such that $\varphi_j(x) \in I^*_{m_j}$ for each $j \in \underline{4}$. If **m** is not interacting then the integrand in [\(4.5\)](#page-6-4) vanishes identically, so $|I_{\mathbf{m}}| = 0$. While the support of each f_j potentially brings $O(\lambda^{\gamma})$ indices m_j into play, for a total of $O(\lambda^{4\gamma})$ tuples **m** for which at least one factor $f_{j,m_j} \circ \varphi_j$ could be nonzero, only $O(\lambda^{2\gamma})$ tuples **m** actually interact. If **m** interacts, then any two of the four indices m_i determine the other two, up to uniformly bounded additive ambiguity.

Trivially

$$
|I_{\mathbf{m}}| = O(\lambda^{-2\gamma})
$$

uniformly in all parameters, since the integrand is $O(1)$ and is supported in a cube of sidelength $O(\lambda^{-\gamma})$ in \mathbb{R}^2 . Together with the bound $O(\lambda^{2\gamma})$ for the number of interacting tuples **m**, this gives $\mathcal{T}(\mathbf{g}) = O(1)$. We seek to improve upon this trivial bound by a factor $O(\lambda^{-\tilde{\delta}})$, for some $\tilde{\delta} > 0$, by exploiting the oscillation of $\Phi_{\bf m}$ to improve the upper bound (4.7) for most indices **. However, for any particular interacting m** there exists a choice of parameters α_{j,m_j} for which the phase $\Phi_{\mathbf{m}}$ is essentially stationary, whence there is no significant improvement. Thus we must show that no matter how the ensemble of parameters α_{j,m_j} is chosen, within the context of our hypotheses, there is sufficient oscillation to create significant cancellation for all but a relatively small minority of the interacting tuples m.

Let $\rho_0 > 0$ be a positive quantity, sufficiently small to satisfy

(4.8) τ⁰ + γ + ρ⁰ < 1.

Let $\rho > 0$ be a small parameter that belongs to $(0, \rho_0]$, sufficiently small to satisfy various constraints imposed in the course of the proof.

For each interacting $\mathbf{m} \in \mathbb{Z}^4$, choose $z_{\mathbf{m}} \in \mathbb{R}^2$ satisfying

(4.9)
$$
\varphi_j(z_{\mathbf{m}}) \in I^*_{m_j} \ \forall j \in \underline{4}.
$$

By repeatedly integrating by parts, exploiting the upper bounds [\(3.13\)](#page-5-0) for derivatives of $h_{j,m,n}$, we conclude that

(4.10)
$$
I_{\mathbf{m}} = O(\lambda^{-N}) \ \forall \ N < \infty
$$

unless $\Phi_{\mathbf{m}}$ is approximately stationary in the sense that

(4.11)
$$
|\nabla \Phi_{\mathbf{m}}(z_{\mathbf{m}})| \leq \lambda^{\gamma + \tau_0 + \rho},
$$

that is, unless

(4.12)
$$
\left|\sum_{j=1}^{4} \alpha_{j,m_j} \nabla \varphi_j(z_{\mathbf{m}})\right| \leq \lambda^{\gamma + \tau_0 + \rho}.
$$

Indeed, each integration by parts yields a factor $O(\lambda^{-\rho})$, so that N' integrations by parts gives a bound $O(\lambda^{-N'\rho})$.

(4.13)
$$
|\mathcal{T}(\mathbf{g})| \lesssim \lambda^{-N} + \lambda^{-2\gamma} \#(\mathcal{N}),
$$

with $\#(\mathcal{N})$ denoting the cardinality of N. Our goal is a bound of the form $\#(\mathcal{N}) =$ $O(\lambda^{2\gamma-\tilde{\delta}}).$

Define

(4.14)
$$
F_j(x) = \lambda^{-1} \alpha_{j,m} \text{ for each } x \in I_m^* = I_{m-1} \cup I_m \cup I_{m+1}
$$

for each $m \in \mathbb{Z}$ in the appropriate congruence class modulo 3. Define $\mathbf{F} = (F_1, F_2, F_3)$. The condition $|\alpha_{1,m}| \gtrsim \lambda$ for every m implies that $|F_1(y)| \gtrsim 1$ for every $y \in I_m^*$.

If the stationarity condition [\(4.12\)](#page-7-1) holds, and if $\mathbf{m} \in \mathbb{Z}^4$ varies only over a single congruence class as indicated above, then

(4.15)
$$
\left| \sum_{j=1}^{4} (F_j \circ \varphi_j)(x) \nabla \varphi_j(x) \right| = O\left(\lambda^{-1+\gamma+\tau_0+\rho} + \lambda^{-\gamma}\right).
$$

Indeed, for any x in the support of $\prod_j(\eta_{m_j}\circ\varphi_j)$,

(4.16)
$$
\left| \alpha_{j,m_j} \nabla \varphi_j(x) - \alpha_{j,m_j} \nabla \varphi_j(z_m) \right| = O(\lambda \cdot \lambda^{-\gamma})
$$

since $\nabla^2 \varphi_j = O(1)$ and $|\alpha_{j,m_j}| = O(\lambda)$. Invoking [\(4.12\)](#page-7-1) and taking into account the factor of λ^{-1} in the definition of F_j gives [\(4.15\)](#page-8-0).

Since $\gamma > \frac{1}{2}$ with strict inequality, $\lambda^{-\gamma} \ll \lambda^{-1+\gamma} \ll \lambda^{-1+\gamma+\tau_0+\rho}$ and therefore [\(4.15\)](#page-8-0) implies that

(4.17)
$$
\left| \sum_{j=1}^{4} (F_j \circ \varphi_j)(x) \nabla \varphi_j(x) \right| = O(\lambda^{-1+\gamma+\tau_0+\rho}).
$$

Defining the sublevel set

(4.18)
$$
S(\mathbf{F}, \varepsilon) = \{x \in \mathbb{R}^2 : \big| \sum_{j=1}^4 (F_j \circ \varphi_j)(x) \nabla \varphi_j(x) \big| < \varepsilon \},
$$

we have arranged that

(4.19)
$$
\lambda^{-2\gamma} \cdot \#(\mathcal{N}) \lesssim |S(\mathbf{F}, C\lambda^{-(1-\gamma-\tau_0-\rho)})|
$$

for a certain constant $C < \infty$, where $\#(\mathcal{N})$ denotes the cardinality of N. Thus an upper bound for $\lambda^{-2\gamma} \cdot \#(\mathcal{N})$ will be a consequence of an upper bound for $|S(\mathbf{F}, C\lambda^{-(1-\gamma-\tau_0-\rho)})|$. Since $\gamma+\tau_0+\rho < 1$ and $|F_1(\varphi_1(x))|\geq 1$, the inequality [\(4.17\)](#page-8-1) can hold only if there is significant cancellation in the sum $\sum_{j\in\mathcal{S}}(F_j\circ\varphi_j)(x)$.

By making a smooth change of variables, we may assume without loss of generality that

$$
(4.20) \qquad \qquad \varphi_4(x_1, x_2) \equiv x_1.
$$

Then writing $a_j = \partial \varphi_j / \partial x_2$,

(4.21)
$$
S(\mathbf{F}, \varepsilon) \subset S'(F_1, F_2, F_3, \varepsilon) = \left\{ x : \left| \sum_{j=1}^3 a_j(x) (F_j \circ \varphi_j)(x) \right| < \varepsilon \right\}
$$

for any $\varepsilon > 0$. Observe that the additive inequality defining $S(\mathbf{F}, \varepsilon)$ involves only three functions F_j , and has variable coefficients a_j .

Let $\Omega \subset \mathbb{R}^2$ be a closed bounded open ball or parallelepiped with nonempty interior. For each $j \in \underline{3}$ let $a_j : \overline{\Omega} \to \mathbb{R}$ be a C^{ω} function in a neighborhood of Ω . Likewise, let $\varphi_j : \Omega \to \mathbb{R}^1$ be \check{C}^ω submersions. To any three-tuple $\check{\mathbf{f}} = (f_j : j \in \underline{3})$ of Lebesgue measurable functions $f_j : \Omega \to \mathbb{R}$, and to any $\varepsilon > 0$, associate the sublevel set

(4.22)
$$
S'(\mathbf{f},\varepsilon) = \{x \in \Omega : \big|\sum_{j=1}^3 a_j(x)(f_j \circ \varphi_j)(x)\big| < \varepsilon\}.
$$

We are in a position to invoke the following result of the companion paper [\[3\]](#page-27-6). For each $j \in \underline{4}$, let V_j be a real analytic vector field in \hat{B} that vanishes nowhere and satisfies $V_j(\varphi_j) \equiv 0$.

Theorem 4.2. Let $a_j, \varphi_j \in C^{\omega}(\tilde{B})$. Assume that the coefficients a_j vanish nowhere in B, and that for each $i \neq j \in \{1, 2, 3\}$, $\nabla \varphi_i(x)$ and $\nabla \varphi_j(x)$ are linearly independent at each $x \in B$.

Assume that for any nonempty open set $U \subset \tilde{B}$, if $f_j : \varphi_j(U) \to \mathbb{R}$ are real analytic and $\sum_{j=1}^{3} a_j \cdot (f_j \circ \varphi_j) \equiv 0$ in U then each $f_j \equiv 0$ in $\varphi_j(U)$.

Assume that for each permutation (i, j, k) of $(1, 2, 3)$, for any $\tau \in \mathbb{R}$ and any nonempty open set $U \subset \tilde{B}$, the function $\frac{a_i|V_k\varphi_i|^{\tau}}{a_i|V_k\varphi_i|^{\tau}}$ $\frac{a_i |V_k\varphi_i|^{\tau}}{a_j |V_k\varphi_j|^{\tau}}$ cannot be expressed in U as $\frac{h_i\circ\varphi_i}{h_j\circ\varphi_j}$ $h_j\circ\varphi_j$ for any real analytic functions h_i, h_j .

There exist $C < \infty$ and $\tau > 0$ with the following property. Let $\varepsilon > 0$ be arbitrary. For any ordered triple f of Lebesgue measurable functions satisfying $|f_3(y)| \geq 1$ for every $y \in \varphi_3(B)$,

$$
(4.23) \t |S(\mathbf{f}, \varepsilon)| \le C\varepsilon^{\tau}.
$$

We wish to apply Theorem [4.2](#page-9-0) with $f_j = F_j$ and $a_j = \partial \varphi_j / \partial x_2$, so must verify that its hypotheses are satisfied. We have arranged that $|F_1| \gtrsim 1$ at every point of its domain. The transversality hypothesis that $\nabla \varphi_i$ and $\nabla \varphi_4$ are everywhere linearly independent for each $j \in \underline{3}$ implies that a_j vanishes nowhere.

We must verify that the main hypothesis of Theorem [4.2](#page-9-0) is satisfied. It states that any C^{ω} local solution $\mathbf{g} = (g_1, g_2, g_3)$ of the equation

(4.24)
$$
\sum_{j} (g_j \circ \varphi_j)(x) \cdot \frac{\partial \varphi_j}{\partial x_2}(x) \equiv 0
$$

in any open set must vanish identically. So let $g \in C^{\omega}$ satisfy this equation in a nonempty small open set. Choose an antiderivative G_j for each g_j . Then

(4.25)
$$
\frac{\partial}{\partial x_2} \left(\sum_{j=1}^3 G_j \circ \varphi_j \right) \equiv 0.
$$

Since $\varphi_4(x_1, x_2) \equiv x_1$, this means that $\sum_{j=1}^3 (G_j \circ \varphi_j)$ can be expressed as $-G_4 \circ \varphi_4$ for a certain function G_4 . Then $\sum_{j=1}^4 (G_j \circ \varphi_j)$ vanishes identically in an open set. By the main hypothesis of Theorem [1.1,](#page-0-2) this implies that each function G_j is locally constant. Therefore the derivatives g_j vanish identically. Finally, the hypothesis concerning $\frac{a_i|V_k\varphi_i|^{\tau}}{a_i|V_k|\varphi_i|^{\tau}}$ $\frac{a_{i}|V_{k}\varphi_{i}|}{a_{j}|V_{k}\varphi_{j}|^{\tau}}$, with $a_{i} = \partial\varphi_{i}/\partial x_{2} = V_{4}(\varphi_{i})$ is Hypothesis [5](#page-2-1) of Theorem [1.1.](#page-0-2)

Thus all hypotheses of Theorem [4.2](#page-9-0) are indeed satisfied. Since the parameters were chosen to satisfy $\tau_0 + \gamma + \rho \leq \tau_0 + \gamma + \rho_0 < 1$, we conclude that

(4.26)
$$
|S'(\mathbf{F}, \lambda^{-(1-\gamma-\tau_0-\rho)})| = O(\lambda^{-\tilde{\delta}})
$$

with $\tilde{\delta} = (1 - \gamma - \tau_0 - \rho_0)\varrho > 0$ for a certain exponent $\varrho > 0$. Combining this with (4.13) and (4.19) , we conclude that

(4.27)
$$
|\mathcal{T}(\mathbf{g})| \lesssim \lambda^{-\tilde{\delta}} + C_N \lambda^{-N}
$$

for every $N < \infty$. This completes the proof of Proposition [4.1.](#page-6-2)

5. CONTRIBUTIONS OF FUNCTIONS $f_{j,\flat}$

Proposition 5.1. For each $\delta > 0$ there exist $\tau, C \in (0,\infty)$ with the following property. Suppose that $||f_j||_{L^{\infty}} \leq 1$ for each $j \in \underline{4}$. Suppose that $f_1 = \sum_m \eta_m \cdot f_{1,m}$ where $f_{1,m}$ satisfies

(5.1)
$$
\int_{\mathbb{R}} \int_{|\xi| \leq \lambda^{\tau_0 + \gamma}} |\widehat{\mathcal{D}_s f_{1,m}}(\xi)|^2 d\xi ds \lesssim \lambda^{-\delta} \lambda^{-2\gamma}
$$

for each $m \in \mathbb{Z}$. Then

(5.2)
$$
|\mathcal{T}(\mathbf{f})| \leq C\lambda^{-\tau}.
$$

To begin the proof of Proposition [5.1,](#page-10-0) expand

(5.3)
$$
\mathcal{T}(\mathbf{f}) = \sum_{\mathbf{m}} \mathcal{T}(\eta_{m_j} f_j : j \in \underline{4})
$$

with the sum extending over all interacting $\mathbf{m} = (m_1, m_2, m_3, m_4)$. Change variables to $(x_1, x_2) \in \mathbb{R}^2$ so that $\varphi_4(x_1, x_2) \equiv x_1$, if necessary introducing a finite partition of unity independent of λ so that such a transformation is possible on the support of each summand.

By the Cauchy-Schwarz inequality,

$$
(5.4)
$$

$$
|\mathcal{T}(\mathbf{f})| \lesssim \lambda^{-\gamma/2} \sum_{\mathbf{m}} \Big(\iiint \prod_{j \in \underline{3}} f_j(\varphi_j(x_1, x_2')) \overline{f_j}(\varphi_j(x_1, x_2)) \zeta_{\mathbf{m}}(x_1, x_2, x_2') dx_1 dx_2 dx_2' \Big)^{1/2}
$$

with

(5.5)
$$
\zeta_{\mathbf{m}}(y, t, t') = \prod_{j=1}^{4} \eta_{m_j}(y, t) \eta_{m_j}(y, t'),
$$

assuming as we may that all η_m are real-valued.

Notation 7.

(5.6)
$$
f_j^s(x) = \mathcal{D}_s(f_j)(x) = f_j(x+s)\overline{f_j}(x).
$$

Notation 8. $Q_m \subset \mathbb{R}^2$ denotes a cube with sides parallel to the coordinate axes of sidelength $\lambda^{-\gamma}$ such that for any $x_2' \in \mathbb{R}$, the function $(x_1, x_2) \mapsto \zeta_m(x_1, x_2, x_2')$ is supported in the cube Q_{m}^* of sidelength $C\lambda^{-\gamma}$ concentric with Q_{m} , where $C < \infty$ depends only on Φ . \bar{z}_{m} denotes some fixed element of Q_{m} .

Substitute $x'_2 = x_2 + s$ in the triple integral in [\(5.4\)](#page-10-1), changing variables from (x_1, x_2, x_2') to (x_1, x_2, s) . Recalling that $\varphi_4(x_1, x_2) \equiv x_1$, write

$$
D\varphi_j(x) = \frac{\partial \varphi_j}{\partial x_2}(x) \neq 0.
$$

For $x \in Q_m^*$,

(5.7)
$$
f_j(\varphi_j(x_1, x_2)) \overline{f_j}(\varphi_j(x_1, x_2')) = f_j^{sD\varphi_j(\bar{z})}(\varphi_j(x)) + O(\lambda^{1-2\gamma})
$$

for each $j \in \underline{3}$. Indeed, as in [\[2\]](#page-27-2) and [\[4\]](#page-27-7), [\(5.7\)](#page-11-0) is a consequence of the assumption that $f_i(\xi)$ is supported where $|\xi| = O(\lambda)$; this restriction on the support of the Fourier transform implies that $\|\nabla f_j\|_{L^\infty} = O(\lambda \|f_j\|_{L^\infty}) = O(\lambda)$, and replacing φ_j by its first order Taylor polynomial results in a perturbation of the argument φ_j of f_j of size $O(\lambda^{-2\gamma}).$

Therefore $|\mathcal{T}(\mathbf{f})|$ is majorized by $C\lambda^{(1-2\gamma)/2}$ plus

(5.8)
$$
C\lambda^{-\gamma/2} \sum_{\mathbf{m}} \left(\int_{|s|=O(\lambda^{-\gamma})} \left| \int_{\mathbb{R}^2} \prod_{j\in \underline{3}} f_j^{sD\varphi_j(\bar{z})}(\varphi_j(x)) \zeta_{\mathbf{m}}(x,s) dx \right| ds \right)^{1/2}
$$

with ζ_m renamed but retaining its essential properties. Since $\gamma > \frac{1}{2}$, the exponent $(1-2\gamma)/2$ is negative.

By Cauchy-Schwarz, the preceding line is in turn majorized by

(5.9)
$$
C\lambda^{\gamma/2}\Big(\sum_{\mathbf{m}}\int_{|s|=O(\lambda^{-\gamma})}\Big|\int_{\mathbb{R}^2}\prod_{j\in\mathbb{Z}}f_j^{sD\varphi_j(\bar{z})}(\varphi_j(x))\zeta_{\mathbf{m}}(x,s)\,dx\Big|\,ds\Big)^{1/2}.
$$

The sum extends only over interacting indices **m**, and there are only $O(\lambda^{2\gamma})$ interacting indices, so this application of Cauchy-Schwarz incurs a factor $O(\lambda^{\gamma})$ which combines with the factor $O(\lambda^{-\gamma/2})$ in [\(5.8\)](#page-11-1) to give the initial factor of $\lambda^{\gamma/2}$.

Associate the factors η_{m_j} that were incorporated into the factors ζ_{m} with the functions f_j , and expand in local Fourier series

(5.10)
$$
\eta_m^2(x) f_{j,m}^s(x) = \eta_m(x) \sum_{k_j} a_{j,m,s,k_j} e^{i\pi \lambda^\gamma k_j x}.
$$

The coefficients satisfy

(5.11)
$$
\sum_{k_j \in \mathbb{Z}} |a_{j,m,s,k_j}|^2 = O(1)
$$

uniformly in all parameters j, m, s .

The property [\(5.1\)](#page-10-2) of f_1 now comes into play. By [\(3.15\)](#page-5-1), with $\lambda^{\gamma} k_1$ here playing the role there of the Fourier variable ξ ,

(5.12)
$$
\int_{|s|=O(\lambda^{-\gamma})} \sum_{|k_1| \leq \lambda^{\tau_0}} |a_{1,m_1,s,k_1}|^2 ds = O(\lambda^{-\gamma-\delta}).
$$

Decompose

(5.13)
$$
\eta_{m_1}^2(x)f_{1,m_1}^s(x) = \eta_{m_1}(x)f_{1,m_1}^{s,\star}(x) + \eta_{m_1}(x)f_{1,m_1}^{s,\dagger}(x)
$$

with

(5.14)
$$
f_{1,m_1}^{s,\star}(x) = \sum_{|k_1| > \lambda^{\tau_0}} a_{1,m_1,s,k_1} e^{i\pi\lambda^{\gamma}k_1x}
$$

and with $f_{1,n}^{s,\dagger}$ $t_{1,m_1}(x)$ equal to the sum over those k_1 satisfying $|k_1| \leq \lambda^{m_1}$.

The second summand satisfies

(5.15)
$$
\int_{|s|=O(\lambda^{-\gamma})} \|\eta_{m_1} f_{1,m_1}^{s,\dagger}\|_{L^2}^2 ds = O(\lambda^{-2\gamma-\delta}).
$$

It follows that for each **m**, the contribution of $\eta_{m_1} f_{1,n}^{s,\dagger}$ $t_{1,m_1}^{s,\intercal}$ to

$$
\int_{|s|=O(\lambda^{-\gamma})}\Big|\int_{\mathbb{R}^2}\prod_{j\in \underline{3}}f_j^{sD\varphi_j(\bar{z})}(\varphi_j(x))\,\,\zeta_{\mathbf{m}}(x,s)\,dx\Big|\,ds
$$

is $O(\lambda^{-3\gamma-\delta/2})$. Therefore if $f_1^{sD\varphi_j}$ $i_1^{sD\varphi_j}$ is replaced by $f_1^{sD\varphi_j, \dagger}$ $i_1^{s_D\varphi_{j,1}}$ in [\(5.8\)](#page-11-1), then upon summation over all interacting $\mathbf{m} \in \mathbb{Z}^4$, the resulting contribution to the upper bound for $|\mathcal{T}(\mathbf{f})|$ is $O(\lambda^{-\delta/4})$. Therefore we may henceforth assume that all indices k_1 appearing in the local Fourier expansion [\(5.10\)](#page-11-2) of f_1^s satisfy $|k_1| > \lambda^{\tau_0}$.

Consider any interacting m. Inserting the three local Fourier expansions into the inner integral in [\(5.9\)](#page-11-3), that is, into

(5.16)
$$
\int_{\mathbb{R}^2} \prod_{j \in \underline{3}} f_j^{sD\varphi_j(\bar{z})}(\varphi_j(x)) \zeta_m(x,s) dx,
$$

produces the sum of oscillatory integrals

(5.17)
$$
\sum_{\mathbf{k}} \prod_{j \in \underline{3}} a_{j,m_j,s} D\varphi_j(\bar{z}), k_j \int_{\mathbb{R}^2} e^{i\pi \lambda^{\gamma} \Psi_{\mathbf{k}}(x)} \zeta_{\mathbf{m}} dx,
$$

with phase functions

(5.18)
$$
\Psi_{\mathbf{k}}(x) = \sum_{j=1}^{3} k_j \varphi_j(x).
$$

The sum extends over those $\mathbf{k} = (k_1, k_2, k_3) \in \mathbb{Z}^3$ satisfying $|k_1| > \lambda^{\tau_0}$.

Let $\delta_1, \rho > 0$ be small quantities to be chosen below. δ_1 will depend on δ , and ρ will depend on δ_1 . The integral [\(5.17\)](#page-12-0) is $O(\lambda^{-N})$ for every $N < \infty$, as follows by repeated integrations by parts, unless $\Psi_{\mathbf{k}}$ satisfies the stationarity condition

(5.19)
$$
|\nabla \Psi_{\mathbf{k}}(\bar{z}_{\mathbf{m}})| = O(\lambda^{\rho}),
$$

that is, unless

(5.20)
$$
\left| \sum_{j=1}^{3} k_j \cdot \nabla \varphi_j(\bar{z}_{\mathbf{m}}) \right| = O(\lambda^{\rho}).
$$

When [\(5.20\)](#page-13-0) holds, each k_i determines the other two quantities k_j up to additive ambiguity $O(\lambda^{\rho})$. That is, if [\(5.20\)](#page-13-0) holds for $\mathbf{k} = (k_1, k_2, k_3)$ and for (k'_1, k'_2, k'_3) , and if $k_i = k'_i + O(\lambda^{\rho})$, then $|k_j - k'_j| = O(\lambda^{\rho})$ for each $j \in \underline{3}$. This is a consequence of the transversality hypothesis, which guarantees that any 2×2 submatrix of the 3×2 matrix

$$
\begin{pmatrix} \nabla \varphi_1(x) \\ \nabla \varphi_2(x) \\ \nabla \varphi_3(x) \end{pmatrix}
$$

is nonsingular for every $x \in B$.

The parameter $\delta_1 > 0$ now comes into play. Decompose

(5.21)
$$
f_{j,m_j}^s = g_{j,m_j}^s + h_{j,m_j}^s
$$

where h_{j,m_j}^s is the sum of those terms in [\(5.10\)](#page-11-2) satisfying

$$
(5.22) \t\t |a_{j,m_j,s,k_j}| \leq \lambda^{-\delta_1}
$$

and if $j = 1$, also satisfying $|k_1| > \lambda^{\tau_0}$.

As in [\[2\]](#page-27-2), it is a consequence of the transversality hypothesis, [\(5.19\)](#page-12-1), and the local Fourier coefficient bound [\(5.11\)](#page-11-4) that [\(5.16\)](#page-12-2) equals

(5.23)
$$
O(\lambda^{-2\gamma-\delta_1+C\rho})+\int_{\mathbb{R}^2}\prod_{j\in\underline{3}}g_j^{sD\varphi_j(\bar{z})}(\varphi_j(x))\zeta_{\mathbf{m}}(x)\,dx.
$$

For each (j, m_j) , the number of frequencies k_{j,m_j} for which [\(5.22\)](#page-13-1) fails to hold, is $O(\lambda^{2\delta_1})$ by Bessel's inequality [\(5.11\)](#page-11-4). Consequently, for each index j, the function $\sum_{m_j} g_{j,m_j}^s$ is a sum of $O(\lambda^{2\delta_1})$ functions of the form

(5.24)
$$
\tilde{g}_j(x,s) = \sum_{m \in \mathbb{Z}} \eta_m(x) a_{j,m,s} e^{i\pi \lambda^\gamma k_j(m,s)x},
$$

with complex scalar coefficients $a_{j,m,s} = O(1)$, and with real frequency functions that satisfy the supplementary condition $|k_1(m, s)| > \lambda^{r_0}$ for every m for $j = 1$. We refer to such a function \tilde{g}_j^s as being of local exponential monomial form. Altogether, we have a sum of the contributions of $O(\lambda^{6\delta_1})$ such functions. As above, we ensure that the terms in this sum are disjointly supported, by partitioning those $m \in \mathbb{Z}$ according to their congruence classes modulo 3 for each index j.

The functions $(m, s) \mapsto k_i (m, s)$ now take on the leading role in the analysis. If we can show that there exists $\tilde{\delta} > 0$, independent of ρ , such that

(5.25)
$$
\sum_{\mathbf{m}} \int_{|s|=O(\lambda^{-\gamma})} \Big| \int_{\mathbb{R}^2} \prod_{j\in\mathcal{Z}} \tilde{g}_j(\varphi_j(x), sD\varphi_j(\bar{z}_{\mathbf{m}})) \zeta_{\mathbf{m}}(x, s) dx \Big| ds = O(\lambda^{-\gamma-\tilde{\delta}})
$$

uniformly for any three functions \tilde{g}_j of monomial form with $|k_1(m, s)| \geq \lambda^{m}$ for all (m, s) , then we may conclude that

(5.26)
$$
\sum_{\mathbf{m}} \int_{|s|=O(\lambda^{-\gamma})} \Big| \int_{\mathbb{R}^2} \prod_{j\in \underline{3}} g_j^{sD\varphi_j(\bar{z}_{\mathbf{m}})} \zeta_{\mathbf{m}}(x,s) dx \Big| ds = O(\lambda^{-\gamma-\tilde{\delta}+6\delta_1}).
$$

The exponent δ_1 is at our disposal, but is not permitted to depend on ρ . Since $\tilde{\delta}$ is independent of ρ , we may choose $\delta_1 < \frac{1}{6}$ $\frac{1}{6}\tilde{\delta}$ to obtain a favorable upper bound for this term. Henceforth we write g_j^s rather than $\tilde{g}_{j,m_j}(\cdot, s)$ to indicate functions with these properties.

Definition 9. Let $(g_j^s : j \in \underline{3})$ be an ordered triple of functions of local exponential monomial form satisfying $|k_1(m, s)| \geq \lambda^{r_0}$. Let f_1 satisfy $||f||_{L^{\infty}} = O(1)$. The associated set $\mathcal{M} = \mathcal{M}(g_1, g_2, g_3, f_1)$ is the set of all (\mathbf{m}, s) such that $\mathbf{m} \in \mathbb{Z}^4$ is interacting, $s \in \mathbb{R}$ satisfies $|s| = O(\lambda^{-\gamma})$, (\mathbf{m}, s) satisfies the stationarity condition

(5.27)
$$
\left| \sum_{j=1}^{3} k_j(\mathbf{m}, s) \nabla \varphi_j(\bar{z}_{\mathbf{m}}) \right| = O(\lambda^{\rho}),
$$

and

(5.28)
$$
\left| \int \eta_{m_1}(y) f_1(y+s) \overline{f_1(y)} e^{-i\pi \lambda^\gamma k_1(m_1,s) y} dy \right| \gtrsim \lambda^{-\gamma-\delta_1}.
$$

Denote by $|M|$ the measure of M, with respect to counting measure on m , as **varies over all interacting elements of** \mathbb{Z}^4 **, and with respect to Lebesgue measure** on $s \in \mathbb{R}$. Since there are $O(\lambda^{2\gamma})$ interacting indices **m**, The trivial bound for the measure of M is $|M| = O(\lambda^{2\gamma}\lambda^{-\gamma}) = O(\lambda^{\gamma})$, with a factor $O(\lambda^{2\gamma})$ reflecting the number of interacting indices **m**, and a factor $O(\lambda^{-\gamma})$ reflecting the restriction $|s| = O(\lambda^{-\gamma}).$

Denote by $|M|^*$ the supremum of $|M|$, taken over the set of all possible tuples $(\tilde{g}_j : j \in \underline{3})$ of local exponential monomials enjoying the properties indicated above and all f_1 . In these terms, we have shown that

(5.29)
$$
\sum_{\mathbf{m}} \int_{|s|=O(\lambda^{-\gamma})} \Big| \int_{\mathbb{R}^2} \prod_{j\in \underline{3}} \tilde{g}_j(\varphi_j(x), s D\varphi_j(\bar{z}_{\mathbf{m}})) \zeta_{\mathbf{m}}(x, s) dx \Big| ds
$$

= $O(\lambda^{-N}) + O(\lambda^{-2\gamma} |\mathcal{M}|^{\star}).$

We note that the coefficient implicit in the notation $O(\lambda^{-N})$ does depend on ρ , but this dependence is harmless since the exponent N is independent of ρ , indeed, is arbitrarily large. Therefore the quantity [\(5.9\)](#page-11-3) associated to the ordered triple $(f_j^s : j \in \underline{3})$ with which we began §[5](#page-10-3) is majorized by

(5.30)
$$
O(\lambda^{(1-2\gamma)/2} + \lambda^{-\delta/4} + \lambda^{-\delta_1/2}\lambda^{C\rho} + \lambda^{-N}) + O(\lambda^{\gamma/2}\lambda^{6\delta_1}(\lambda^{-2\gamma}|\mathcal{M}|^{\star})^{1/2})
$$

for any $N < \infty$. The first term is favorable since $\gamma > \frac{1}{2}$, and the second since $\delta > 0$. The third term is favorable provided that ρ is chosen to be sufficiently small relative to δ_1 .

To complete the proof of Proposition [5.1,](#page-10-0) it suffices to establish the following upper bound for $|\mathcal{M}|^*$.

Lemma 5.2. There exists $\delta_0 > 0$ such that whenever $0 < \delta_1 \leq \delta_0$, and whenever $\rho > 0$ is sufficiently small, there exists $\rho > 0$ such that for any $\mathcal{M}, \mathbf{g}, f_1, \delta_1, \rho$ as in Definition [9,](#page-14-0)

(5.31)
$$
|\mathcal{M}| = O(\lambda^{\gamma - \varrho}).
$$

If δ_1 is chosen to be $\leq \min(\delta_0, \frac{1}{24}\varrho)$ then the last term in [\(5.30\)](#page-14-1) is $O(\lambda^{-\varrho/4})$, and thus Lemma [5.2](#page-15-0) yields the required upper bound for [\(5.9\)](#page-11-3).

Lemma [5.2](#page-15-0) will be applied with the parameter ρ in the discussion above satisfying $\rho \leq \rho_0$. The upper bound for $|\mathcal{S}|$ will provide an upper bound for $|\mathcal{M}|^*$ by the stationarity condition [\(5.19\)](#page-12-1), since $\lambda^{\rho} \leq \lambda^{\rho_0}$ for large λ . The formulation emphasizes that ρ is then independent of ρ , allowing us to choose ρ to be arbitrarily small and hence sufficiently small relative to δ, δ_1 .

The trivial bound in Lemma [5.2](#page-15-0) is $|S| = O(\lambda^{\gamma})$. As in the proof of Proposition [4.1,](#page-6-2) we have reduced matters to an upper bound for the measure of a sublevel set; Lemma [5.2](#page-15-0) plays the same role in the proof of Proposition [5.1](#page-10-0) that Theorem [4.2](#page-9-0) plays in the proof of Proposition [4.1.](#page-6-2)

Remark. The assumption [\(5.28\)](#page-14-2) in Definition [9](#page-14-0) would be unnecessary for Lemma [5.2,](#page-15-0) and §[8](#page-21-0) and §[9](#page-23-0) below would likewise be superfluous, if auxiliary hypothesis [3](#page-1-1) were strengthened to exclude nonzero real analytic solutions of $\sum_{j\neq k} (F_j \circ \varphi_j) (V_k \varphi)^\sigma \nabla \varphi_j =$ 0 for all $\sigma \in \mathbb{R}$, rather than merely for $\sigma = 1$.

Let $\mathcal{M}, \mathbf{g}, f_1, \delta_1, \rho$ be as in Lemma [5.2.](#page-15-0) For each interacting **m**, define $\mathcal{S}^*(\mathbf{m}) \subset \mathbb{R}$ to be the set of $s \in \mathbb{R}$ that satisfy $|s| = O(\lambda^{-\gamma})$, [\(5.28\)](#page-14-2), and

(5.32)
$$
\left| \sum_{j=1}^{3} k_j(m_j, s) \nabla_x \varphi_j(x) \right| = O(\lambda^{\rho}) \ \forall \, x \in Q_{\mathbf{m}}^*.
$$

Since $\rho < \gamma$, the last inequality is equivalent to the stationarity condition [\(5.27\)](#page-14-3) in the definition of \mathcal{M} , after appropriate adjustment of the constant factors implicit in the notations $O(\lambda^{\rho})$. Thus the conclusion [\(5.31\)](#page-15-1) of Lemma [5.2](#page-15-0) can be restated as

(5.33)
$$
\sum_{\mathbf{m}} |\mathcal{S}^*(\mathbf{m})| = O(\lambda^{\gamma - \varrho}),
$$

where the summation extends over all interacting indices $\mathbf{m} \in \mathbb{Z}^4$. To complete the proof of Proposition [5.1,](#page-10-0) it suffices to prove [\(5.33\)](#page-15-2). Our next four sections are devoted to this task.

6. A functional (approximate) equation

To φ_j are associated mappings $\Phi_j : B \times \mathbb{R} \to \mathbb{R}^2$ defined by

(6.1)
$$
\Phi_j(x,s) = (\varphi_j(x), sD\varphi_j(x))
$$

where $D = \partial/\partial x_2$. We next study solutions of the functional equation

(6.2)
$$
\sum_{j=1}^{3} (f_j \circ \Phi_j)(x, s) \nabla \varphi_j(x) = 0,
$$

in which the unknown is an ordered triple $f = (f_j : j \in \underline{3})$ of functions defined on some open subset of $\mathbb{R}^2 \times \mathbb{R}^1$. A solution **f** is said to be trivial if it vanishes identically.

We also study associated sublevel set inequalities, which quantify the nonexistence of nontrivial solutions. The results that we develop will be applied to functions f_i defined by $f_j(y, s) = k_j(m, s)$ when $y \in I_m^*$, and k_j are the functions in the hypothesis of Lemma [5.2.](#page-15-0) Throughout this section, all hypotheses of Theorem [1.1](#page-0-2) are implicitly assumed, although certain lemmas rely on only some of those hypotheses.

Here $(x, s) = ((x_1, x_2), s)$ belongs to some open subset of $\mathbb{R}^2 \times \mathbb{R}^1$, φ_j are C^{ω} submersions mapping an open subset of \mathbb{R}^2 to \mathbb{R}^1 , and f_j is defined on an open subset of \mathbb{R}^2 . $\nabla = \nabla_x$ denotes the gradient with respect to x alone, and $D\varphi_j = \frac{\partial \varphi_j}{\partial x_2}$. Thus each term $f_j(\varphi_j(x), sD\varphi_j(x)) \cdot \nabla \varphi_j(x)$ is \mathbb{R}^2 -valued.

For each $j \in \underline{3}$, $D\varphi_j$ vanishes nowhere. This is a consequence of the transver-sality hypothesis [\(2\)](#page-1-0) and the choice of coordinates, in which $\varphi_4(x_1, x_2) \equiv x_1$, and consequently $D = \partial/\partial x_2$ annihilates φ_4 .

6.1. **Exact solutions.** The equation [\(6.2\)](#page-16-0) for an ordered triple **f** of functions f_j is homogeneous with respect to s; if $f(x, s)$ is a solution then so is $f(x, rs)$ for any $r \in \mathbb{R} \setminus \{0\}.$

The differential of each Φ_j with respect to $(x, s) \in \mathbb{R}^3$ has rank 2 at each point of its domain, since $D\varphi_i \neq 0$. Thus each of the three relations

(6.3)
$$
\Phi_j(x,s) = \text{ constant } \in \mathbb{R}^2
$$

defines a foliation in \mathbb{R}^3 with one-dimensional leaves indexed by the constants on the right-hand side of [\(6.3\)](#page-16-1). We refer to these leaves in \mathbb{R}^3 as level curves of Φ_j . For each index i , the vector field

(6.4)
$$
V_j^{\dagger} = \left(-\partial_2 \varphi_j, \ \partial_1 \varphi_j, \ s(D\varphi_j)^{-1} \left(\partial_2 \varphi_j \cdot \partial_{1,2}^2 \varphi_j - \partial_1 \varphi_j \cdot \partial_{2,2}^2 \varphi_j \right) \right)
$$

vanishes nowhere and annihilates Φ_j ; V_j^{\dagger} j_j^{\dagger} is tangent to the leaves of the associated foliation. Since $\nabla \varphi_j$ are pairwise transverse in \mathbb{R}^2 , it follows from an examination of the vector fields in \mathbb{R}^2 defined by their first two components that V_i^{\dagger} V_i^{\dagger} , V_j^{\dagger} are everywhere linearly independent whenever $i \neq j$. Therefore the transversality hypothesis [\(2\)](#page-1-0) ensures that these foliations are everywhere pairwise transverse. However, the hyperplane defined by $s = 0$ is degenerate in the sense that all three tangent vectors V_i^\dagger j^{\dagger} are tangent to this hyperplane at each of its points.

Write

(6.5)
$$
\mathbb{R}^3_{\neq 0} = \{(x, s) \in \mathbb{R}^2 \times \mathbb{R} : s \neq 0\}.
$$

Lemma 6.1. Let Φ satisfy the transversality hypothesis [2.](#page-1-0) Let **f** be any ordered triple of Lebesgue measurable functions that satisfies the functional equation [\(6.2\)](#page-16-0) almost

everywhere in some open subset Ω of $\mathbb{R}^3_{\neq 0}$. Then each function $f_j \circ \Phi_j$ agrees almost everywhere with a C^{ω} function in Ω .

Proof. We work in a small neighborhood of an arbitrary point of Ω , and all assertions in this proof are concerned with appropriately defined but unspecified such neighborhoods. Thus " $x \in \mathbb{R}^{2n}$ means that $x \in \mathbb{R}^2$ belongs to such a neighborhood. We initially simplify matters by assuming that each f_j is continuous.

Any two gradients $\nabla \varphi_j(x)$ are transverse at every $x \in \mathbb{R}^2$, and consequently the system [\(6.2\)](#page-16-0) of two scalar linear equations in three unknown quantities f_k can be solved locally to express

(6.6)
$$
(f_1 \circ \Phi_1)(x, s) = h_j(x) \cdot (f_j \circ \Phi_j)(x, s)
$$

with $h_j \in C^{\omega}$ independent of s, both for $j = 2$ and for $j = 3$. The functions h_j are entirely specified by the datum $(\varphi_j : j \in \underline{4})$.

If Γ is any leaf of the foliation in $\mathbb{R}^3_{\neq 0}$ defined by level curves of Φ_2 , then its image $\Phi_1(\Gamma)$ is a C^{ω} curve in the two-dimensional domain of f_1 . This is a direct consequence of the transversality of the two vectors $\nabla\varphi_1, \nabla\varphi_2$. The family of all such $\Phi_1(\Gamma)$ is a two parameter family of curves in this domain, rather than a foliation.

In the same way, there is a corresponding family of curves $\Phi_1(\Gamma')$, with $\Gamma' \subset \mathbb{R}^3_{\neq 0}$ denoting level curves of Φ_3 . The auxiliary hypothesis [4](#page-2-0) of Theorem [1.1](#page-0-2) now enters the discussion for the first time. It ensures that if Γ, Γ' are level curves of Φ_2, Φ_3 respectively that meet at a point $(x, s) \in \mathbb{R}^3_{\neq 0}$ then their images $\Phi_1(\Gamma)$ and $\Phi_1(\Gamma')$ intersect transversely in \mathbb{R}^2 at $\Phi_1(x, s)$.

Consider any point $(\bar{x}, \bar{s}) \in \mathbb{R}^3_{\neq 0} = \mathbb{R}^2 \times \mathbb{R}^1_{\neq 0}$. Set $a = f_2(\Phi_2(\bar{x}, \bar{s}))$. Denote by $\bar{\Gamma}$ the level curve of Φ_2 that passes through (\bar{x}, \bar{s}) . The relation [\(6.6\)](#page-17-0) expresses the restriction of f_1 to $\Phi_1(\Gamma)$ as the constant a multiplied by a real analytic function, which depends only on the datum $(\varphi_k : k \in \underline{4})$.

Consider those leaves Γ' that intersect $\overline{\Gamma}$. The restriction of f_1 to each leaf $\Phi_1(\Gamma')$ is likewise expressed by (6.6) as a given C^{ω} function, specified by the geometric data, multiplied by the value of f_1 at the unique point at which $\Phi_1(\Gamma')$ intersects $\Phi_1(\bar{\Gamma})$. The latter value of f_1 was expressed in the preceding paragraph as the product of the scalar a with a specified C^{ω} function. Therefore in a neighborhood of any point of the domain of f_1 at which the curves $\Phi_1(\bar{\Gamma})$ and $\Phi_1(\Gamma')$ are transverse to one another, f_1 is C^{ω} .

The assumptions are invariant under permutation of the indices in 3 , so corresponding conclusions hold for f_2 and for f_3 .

The case of Lebesgue measurable f is treated by applying the same reasoning to almost every (\bar{x}, \bar{s}) .

The proof of Lemma [6.1](#page-16-2) has implicitly shown that the space of local solutions has dimension less than or equal to 1:

Lemma 6.2. In any connected open subset of $\mathbb{R}^2 \times \mathbb{R}_{\neq 0}$, equivalence classes of Lebesque measurable solutions f of (6.2) are unique up to multiplication by constant scalars.

Lemma 6.3. There exists a unique exponent $\sigma \in \mathbb{R}$ with the following property. Let f be any Lebesgue measurable solution of [\(6.2\)](#page-16-0) in some connected open subset S of $\mathbb{R}^2\times\mathbb{R}^+$ that does not vanish identically. Then f_j takes the form

(6.7)
$$
f_j(x, s) = s^{\sigma} F_j(x) \text{ almost everywhere in } \varphi_j(S) \ \forall j \in \underline{3}
$$

for some $F_j \in C^{\omega}$.

This lemma can be applied equally well to solutions in $\mathbb{R}^2 \times \mathbb{R}^-$, with s^{σ} replaced by $|s|^{\sigma}$ in [\(6.7\)](#page-18-0) since whenever $f(x, s)$ is a solution, so is $f(x, -s)$. Thus the exponent σ is the same for $s < 0$ as for $s > 0$.

Proof. If $f(x, s)$ is a solution then so is $f(x, rs)$ for any $0 \neq r \in \mathbb{R}$. Therefore by the uniqueness established in Lemma [6.2,](#page-17-1) $f(x, rs) = h(r)f(x, s)$ for some function h. Since f does not vanish identically, this relation implies that $h(r_1r_2) \equiv h(r_1)h(r_2)$ for r_1, r_2 in appropriate intervals. This forces h to take the form $c|r|^{\sigma}$ in any interval in which it is defined. \Box

Recalling that $D\varphi_i = V_4\varphi_i$ vanishes nowhere by the transversality hypothesis, we may assume that $D\varphi_j(x) > 0$ for every x for each index j, by replacing φ_j by $-\varphi_j$ if necessary. Working in the region in which $s > 0$, and writing $F_j(x)s^{\sigma}$ in place of $f_i(x, s)$, the functional equation [\(6.2\)](#page-16-0) can now be rewritten as

(6.8)
$$
\sum_{j=1}^{3} (D\varphi_j)^{\sigma} \cdot (F_j \circ \varphi_j) \cdot \nabla \varphi_j = 0.
$$

Here the first and second factors are real-valued, while the third is \mathbb{R}^2 -valued, and the symbol · denotes multiplication of scalars with scalars, or with vectors.

Lemma 6.4. If there exists a solution (F_1, F_2, F_3) of [\(6.8\)](#page-18-1) that does not vanish identically in some nonempty open set in \mathbb{R}^2 , then the exponent σ cannot equal 0.

Proof. Let (F_1, F_2, F_3) be a solution. Choose G_j to be an antiderivative of F_j for each $j \in \underline{3}$. If $\sigma = 0$ then each factor $(D\varphi_j)^\sigma$ is constant, so [\(6.8\)](#page-18-1) can be written as $\nabla \big(\sum_{j=1}^3 (G_j \circ \varphi_j)\big) \equiv 0$ in a nonempty open subset of \mathbb{R}^2 . Thus $\sum_{j=1}^3 (G_j \circ \varphi_j)$ is locally constant.

Choosing G_4 to be an appropriate constant, $\sum_{j=1}^4 (G_j \circ \varphi_j)$ vanishes identically. By the main hypothesis, all G_j must then be locally constant. Therefore their derivatives F_j vanish identically.

The discussion so far leaves open the question of whether there exists any solution besides the trivial solution $f \equiv 0$. The auxiliary hypothesis [3](#page-1-1) of Theorem [1.1](#page-0-2) excludes nonzero solutions with $\sigma = 1$, but not with other exponents.

6.2. Approximate solutions.

Lemma 6.5. Suppose that there is no nonzero C^{ω} solution of [\(6.2\)](#page-16-0) in any nonempty open subset of \mathbb{R}^3 . Then there exists $\kappa > 0$ with the following property. Let $I \subset \mathbb{R} \setminus \{0\}$ be a compact interval. Let $B \subset \mathbb{R}^2$ be a ball. Let $\varepsilon \in (0,1]$. Let $\mathbf{f} = (f_j(x,s) : j \in \mathcal{I})$

be an ordered triple of Lebesgue measurable functions. Suppose that there exists $i \in \underline{3}$ for which $|f_i(x, s)| \geq 1$ for every $(x, s) \in B \times I$. Then

(6.9)
$$
\left| \{(x,s) \in B \times I : \left| \sum_{j=1}^{3} (f_j \circ \Phi_j)(x,s) \nabla \varphi_j(x) \right| \leq \varepsilon \} \right| \leq C \varepsilon^{\kappa}.
$$

Proof. Let **f** satisfy the hypotheses. It suffices to prove the conclusion in the special case in which $|f_i(x, s)| \leq 2$ for every $j \in \underline{3}$ and every $(x, s) \in B \times I$. Indeed, partition the domain into sets $\mathcal{A}_{l,k}$ in which there exists l such that $|f_l(x,s)| \in [2^k, 2^{k+1})$ and $|f_i(x, s)| \leq |f_i(x, s)|$ for every $j \neq l$. Apply the special case to $2^{-k}f_i(x, s)$ with ε replaced by $2^{-k} \varepsilon$ to conclude that $|\mathcal{A}_{l,k}| = O(2^{-k} \varepsilon)^{\kappa}$. Sum these bounds over all nonnegative integers k and over $l \in \{3\}$ to complete the proof.

Since the hypotheses are invariant under permutation of the indices in 3 , we may assume that the index i in the hypotheses is 1. Let

(6.10)
$$
\mathcal{E} = \{(x, s) \in B \times I : \left| \sum_{j=1}^{3} (f_j \circ \Phi_j)(x, s) \nabla \varphi_j(x) \right| \leq \varepsilon \}.
$$

The proof of Lemmas [6.1](#page-16-2) and [6.2](#page-17-1) above, in combination with reasoning in [\[2\]](#page-27-2), [\[3\]](#page-27-6), and [\[4\]](#page-27-7), demonstrates that there exist C^{ω} functions g_j that are independent of **f**, a set $\tilde{\mathcal{E}} \subset \mathcal{E}$ satisfying $|\tilde{\mathcal{E}}| \gtrsim |\mathcal{E}|^C$, and scalars $a_j \in [-3, 3]$ that may depend on f, satisfying

(6.11)
$$
\left|f_j(\Phi_j(x,s)) - a_j g_j(\Phi_j(x,s))\right| = O(\varepsilon) \quad \forall j \in \underline{3}, \ \forall (x,s) \in \tilde{\mathcal{E}}.
$$

See for instance the derivation of relation (6.20) of [\[3\]](#page-27-6) and the discussion in §4 of [\[3\]](#page-27-6) on which that derivation is based.

The family of tuples $G_{\mathbf{a}} = (a_j g_j : j \in \underline{3})$ parametrized by $\mathbf{a} = (a_1, a_2, a_3) \in [-3, 3]^3$ is a compact C^{ω} family of C^{ω} functions in the sense hypothesized in Lemma 11.2 of [\[2\]](#page-27-2). That is, a varies over a compact subset of a Euclidean space, $y = (x, s)$ varies over a compact convex subset of a Euclidean space, $G_{\mathbf{a}}(y)$ is \mathbb{C}^n -valued for some n, and the mapping $(y, \mathbf{a}) \mapsto G_{\mathbf{a}}(y)$ is defined and real analytic in a neighborhood of this domain. Lemma [1](#page-19-0)1.2 of $[2]$ states¹ that if such a family contains no exact solution to a system such as $\sum_j a_j (g_j \circ \Phi_j) \nabla \varphi_j \equiv 0$ in any nonempty open set, then [\(6.9\)](#page-19-1) holds for some exponent κ for all $G_{\mathbf{a}}$ in the family, uniformly in \mathbf{a} . Since $\tilde{\mathcal{E}} \subset \mathcal{E}$, and since the inequality in question holds on \mathcal{E} , the inequality [\(6.11\)](#page-19-2) implies that

(6.12)
$$
\left| \sum_{j=1}^{3} a_j (g_j \circ \Phi_j)(x, s) \nabla \varphi_j(x) \right| = O(\varepsilon) \ \forall (x, s) \in \tilde{\mathcal{E}}.
$$

Therefore $|\tilde{\mathcal{E}}| = O(\varepsilon^{\gamma})$ for some exponent $\gamma > 0$ that depends only on Φ . Therefore $|\mathcal{E}| = O(\varepsilon^{\gamma/C}).$ \Box \Box

¹The result in [\[2\]](#page-27-2) is stated and proved for scalar linear equations, but the same reasoning applies to finite-dimensional linear systems.

Lemma 6.6. Under the hypotheses of Lemma [6.5,](#page-18-2) there exists $\kappa > 0$ such that for any $r > 0$,

(6.13)
$$
\left| \left\{ (x,s) \in \mathbb{R}^2 \times [-r,r] : \left| \sum_{j=1}^3 (f_j \circ \Phi_j)(x,s) \nabla \varphi_j(x) \right| \leq \varepsilon \right\} \right| \leq C \varepsilon^{\kappa} r.
$$

Proof. To obtain this upper bound for the set of all (x, s) satisfying $\frac{1}{2}r \leq |s| \leq r$, apply Lemma [6.5](#page-18-2) to the functions $(x, s) \mapsto f_j(x, rs)$. Then apply this partial result with r replaced by $2^{-n}r$ for each $n \in \mathbb{N}$, and sum over n.

The next lemma is a variant of Lemma [6.6,](#page-20-0) concerning the case in which [\(6.2\)](#page-16-0) does admit a nontrivial solution. Let B be as above.

Lemma 6.7. Suppose that there exist $\mathbf{F} = (F_j : j \in \underline{3})$, defined in $B \times \mathbb{R}^1_{\neq 0}$ and not vanishing identically in any nonempty open set, and an exponent $\sigma \in \mathbb{R}$, such that every \mathbb{R}^3 -valued exact solution f of (6.2) in any nonempty connected open subset of $B \times \mathbb{R}^{\pm}$ takes the form $f_j(y, s) = b|s|^{\sigma} F_j(y)$ for some coefficient $b \in \mathbb{R}$ that depends on f. Then there exist $\kappa, c > 0$ and $C_0 < \infty$ with the following property.

Let $f = (f_j : j \in \underline{3})$ be an ordered triple of Lebesgue measurable functions. Let $\varepsilon \in (0,1]$. Let $S(f,\varepsilon)$ be the sublevel set

$$
S(\mathbf{f}, \varepsilon) = \left\{ (x, s) \in B \times (0, 1] : \left| \sum_{j=1}^{3} (f_j \circ \Phi_j)(x, s) \nabla \varphi_j(x) \right| \le \varepsilon \right\}.
$$

Let $\mathcal{S} \subset S(\mathbf{f}, \varepsilon)$ be measurable. Then either

$$
(6.14) \t\t |S| \le \varepsilon^c
$$

or there exist $\mathbb{S}' \subset \mathbb{S}$ and $b \in \mathbb{R}$ such that for each $j \in \mathcal{S}$,

(6.15)
$$
\left| \{ (y,s) \in \psi_j(\mathbb{S}') : \left| f_j(y,s) - b \right| s \right|^{\sigma} F_j(y) \right| \leq C_0 \varepsilon \} \geq |S(\mathbf{f}, \varepsilon)|^{\kappa} \ \forall \varepsilon > 0.
$$

In the case in which no nontrivial solutions of [\(6.2\)](#page-16-0) exist, the hypotheses of Lemma [6.7](#page-20-1) are satisfied with $\mathbf{F} \equiv 0$, but the conclusion is weaker than that of Lemma [6.6.](#page-20-0) Lemma [6.7](#page-20-1) is proved by excerpting portions of the proofs of Lemmas [6.5](#page-18-2) and [6.6.](#page-20-0)

7. The case in which equation [\(6.2\)](#page-16-0) has only the trivial solution

We prove Lemma [5.2](#page-15-0) in the case in which every solution of [\(6.2\)](#page-16-0) in any nonempty open set vanishes identically. Let k_j be the functions given in the statement of Lemma [5.2,](#page-15-0) and let $\mathcal{S}^*(\mathbf{m})$ be as defined at the end of §[5.](#page-10-3) For each $j \in \underline{3}$ define

(7.1)
$$
f_j(y,s) = \lambda^{-\tau_0} k_j(m,s) \ \forall \, y \in I_m^*.
$$

Then whenever $x \in Q_m^*$ and $s \in \mathcal{S}^*(m)$,

(7.2)
$$
\sum_{j\in\mathcal{J}}(f_j\circ\Phi_j)(x,s)\nabla_x\varphi_j(x)=\lambda^{-\tau_0}\sum_{j\in\mathcal{J}}k_j(m_j,s)\nabla_x\varphi_j(x)=O(\lambda^{\rho_0-\tau_0}).
$$

Moreover, since $|k_1(m, s)| \geq \lambda^{r_0}$, $|f_1(y, s)| \geq 1$ whenever $y \in \varphi_1(Q_m^*)$ and $s \in \mathcal{S}^*(m)$.

Define

(7.3)
$$
\mathcal{A} = \{(x, s) : \left| \sum_{j \in \underline{3}} (f_j \circ \Phi_j)(x, s) \nabla_x \varphi_j(x) \right| = O(\lambda^{\rho_0 - \tau_0}) \}.
$$

For any **m** and any $s = O(\lambda^{-\gamma})$, if $s \in S^*(\mathbf{m})$ then for any $x \in Q^*_{\mathbf{m}}$,

(7.4)
$$
\left| \sum_{j \in \underline{3}} (f_j \circ \Phi_j)(x, s) \nabla_x \varphi_j(x) \right| = O(\lambda^{\rho_0 - \tau_0}).
$$

This is simply the defining property of $S^*(m)$, rewritten in terms of the functions f_j . Thus

(7.5)
$$
\bigcup_{\mathbf{m}} (Q_{\mathbf{m}} \times \mathcal{S}^*(\mathbf{m})) \subset \mathcal{A}.
$$

According to Lemma [6.6,](#page-20-0) since s varies over $[-r, r]$ for $r = C\lambda^{-\gamma}$,

(7.6)
$$
|\mathcal{A}| = O(\lambda^{-(\tau_0 - \rho_0)\kappa} \cdot \lambda^{-\gamma})
$$

where $\kappa > 0$ depends only on Φ . Now

$$
(7.7) \qquad |\mathcal{S}| = \sum_{\mathbf{m}} |\mathcal{S}^*(\mathbf{m})| \asymp \lambda^{2\gamma} \Big| \bigcup_{\mathbf{m}} (Q_{\mathbf{m}} \times \mathcal{S}^*(\mathbf{m})) \Big| \leq \lambda^{2\gamma} |\mathcal{A}| = O(\lambda^{\gamma - (\tau_0 - \rho_0)\kappa}).
$$

Since $(\tau_0 - \rho_0)\kappa > 0$, this completes the proof of Lemma [5.2](#page-15-0) for this case.

8. 0 AND 1 ARE THE ONLY RELEVANT VALUES OF σ

The analysis developed thus far does not lead to the desired conclusion if there are many m such that $f_{j,m}$ has the property that $f_{j,m,s}(x) = f_{j,m}(x+s)\overline{f_{j,m}}(x)$ has the property that $|f_{j,m,s}(\xi(s))|$ is relatively large for many s, for a function ξ that is well approximated by $c(j, m) s^{\sigma}$ for many m. The exponents $\sigma = 0, 1$ are excluded by hypotheses of Theorem [1.1.](#page-0-2) In this section we develop a lemma which will subsequently be used to show that for $\sigma \notin \{0, 1\}$, $|f_{j,m,s}(\xi(s))|$ cannot be large for many s for such a function ξ . This result will be used in §[9](#page-23-0) to complete the proof of Lemma [5.2.](#page-15-0)

Lemma 8.1. For each $\sigma \in \mathbb{R} \setminus \{0,1\}$ there exists $\delta_2 > 0$ with the following property. Let $\mu \in (0,1)$ and $B \in [0,\infty)$. Let $r \in [1,\infty)$ be arbitrary, and let $\xi : \mathbb{R} \to \mathbb{R}$ be Lebesgue measurable and satisfy

(8.1)
$$
|\xi(s) - rs^{\sigma}| \leq Br^{\mu} \quad \forall s > 0.
$$

For any $f, g \in L^{\infty}(\mathbb{R})$ supported on some common interval of length 1,

(8.2)
$$
\int_{s>0} \left| \int_{\mathbb{R}} f(x+s) g(x) e^{i\xi(s)x} dx \right| ds \leq C r^{-\delta_2} ||f||_{\infty} ||g||_{\infty}.
$$

The constant C depends only on σ, μ, B .

The same conclusion holds for the corresponding integral over $s \in \mathbb{R}^-$.

The conclusion is false for $\sigma = 0$ (consider $f_j(y) = \overline{g_j}(y) = e^{i\xi y}$) and also false for $\sigma = 1$ (consider $f_j(y) = \overline{g_j}(y) = e^{i\xi y^2}$).

Proof. The conclusion can be equivalently stated in terms of a trilinear expression

(8.3)
$$
I = \iint f(x+s) g(x) h(s) e^{i\xi(s)x} \mathbf{1}_{\Omega}(x,s) dx ds,
$$

where Ω is the set of all (x, s) such that $x \in J$, $x + s \in J$, and $s \in \mathbb{R}^+$ for a certain interval $J \subset \mathbb{R}$ of length 1. This set Ω is convex. The conclusion is then that

(8.4)
$$
|I| \leq C r^{-\delta_2} ||f||_{\infty} ||g||_{\infty} ||h||_{\infty}
$$

for any three functions f, g, h .

Assume that $||f||_{\infty} \leq 1$ and likewise for g, h. By Cauchy-Schwarz, $|I|^2$ is majorized by

$$
C \iiint f(x+s')\bar{f}(x+s)h(s')\bar{h}(s) e^{i[\xi(s')-\xi(s)]x} \mathbf{1}_{\Omega}(x,s) \mathbf{1}_{\Omega}(x,s') dx ds ds'
$$

=
$$
C \iiint f(x+s+t)\bar{f}(x+s)h(s+t)\bar{h}(s) e^{i[\xi(s+t)-\xi(s)]x} \mathbf{1}_{\Omega}(x,s) \mathbf{1}_{\Omega}(x,s+t) dx ds dt
$$

=
$$
C \iiint F_t(x+s)H_t(s) e^{i[\xi(s+t)-\xi(s)]x} \mathbf{1}_{\Omega}(x,s) \mathbf{1}_{\Omega}(x,s+t) dx ds dt
$$

=
$$
C \iiint F_t(y) \tilde{H}_t(s) e^{i[\xi(s+t)-\xi(s)]y} \mathbf{1}_{\Omega}(y-s,s) \mathbf{1}_{\Omega}(y-s,s+t) dy ds dt
$$

with $F_t(x) = f(x+t)\bar{f}(x)$, $H_t(s) = h(s+t)\bar{h}(s)$, and $\tilde{H}_t(s) = H_t(s)e^{-i[\xi(s+t)-\xi(s)]s}$. The outer integral extends only over some interval of length 2.

A second application of Cauchy-Schwarz results in majorization of the square of the absolute value of the inner integral by

(8.5)
$$
C \iint \tilde{H}_t(u) \overline{\tilde{H}_t(v)} \Big(\int e^{i[\xi(u+t) - \xi(u) - \xi(v+t) + \xi(v)]y} \mathbf{1}_{\Omega'}(y, u, v, t) dy \Big) du dv
$$

for each t , with

$$
\mathbf{1}_{\Omega'}(y, u, v, t) = \mathbf{1}_{\Omega}(y - u, u)\mathbf{1}_{\Omega}(y - u, u + t)\mathbf{1}_{\Omega}(y - v, v)\mathbf{1}_{\Omega}(y - v, v + t).
$$

The set $\Omega' \subset \mathbb{R}^4$, whose indicator function is denoted here by $\mathbf{1}_{\Omega'}$, is convex.

Define Ω'' to be the set of all (u, v, t) for which there exists y such that $(y, u, v, t) \in$ Ω' . Ω'' is convex, and is contained in a ball of radius $O(1)$, centered at the origin, in \mathbb{R}^3 . Replacing the inner integral by its absolute value and invoking the hypothesis $||h||_{L^{\infty}} \leq 1$, we conclude that $|I|^4$ is majorized by

$$
(8.6) \quad C \iiint \left| \int e^{i[\xi(u+t) - \xi(u) - \xi(v+t) + \xi(v)]y} \mathbf{1}_{\Omega'}(y, u, v, t) \, dy \right| dt \, du \, dv
$$

$$
\lesssim \iiint_{\Omega''} \left(1 + |\xi(u+t) - \xi(u) - \xi(v+t) + \xi(v)| \right)^{-1} dt \, du \, dv.
$$

The inequality holds because for each $(u, v, t) \in \Omega'', y \mapsto \mathbf{1}_{\Omega''}(y, u, v, t)$ is the indicator function of an interval of length $O(1)$.

Each quantity t, u, v is confined to an interval of length $O(1)$ centered at the origin in R, and there is an implicit restriction to the region in which $u, v, u + t, v + t$ are all positive.

The structural hypothesis $\xi(s) = rs^{\sigma} + O(r^{\mu})$ and the restriction $|s| = O(1)$ implicit in the hypotheses give

$$
(8.7) \ \ r^{-1} \big| \xi(u+t) - \xi(u) - \xi(v+t) + \xi(v) \big| = \big| (u+t)^{\sigma} - (u)^{\sigma} - (v+t)^{\sigma} + v^{\sigma} \big| + O(r^{\mu-1}).
$$

For any $\sigma \notin \{0, 1\}$ there exists $\kappa > 0$ such that for any $\varepsilon > 0$,

(8.8)
$$
\left| \left\{ (u, v, t) \in \Omega'': \left| (u + t)^{\sigma} - u^{\sigma} - (v + t)^{\sigma} + v^{\sigma} \right| < \varepsilon \right\} \right| = O(\varepsilon^{\kappa}).
$$

This can be shown by fixing (v, t) and allowing u to vary over the interval $\{u :$ $(u, v, t) \in \Omega''$. Details of the elementary proof are left to the reader.

Choose $\varepsilon = r^{\mu-1}$. Then for any (u, v, t) satisfying $r^{-1}|\xi(u+t) - \xi(u) - \xi(v+t)$ + $|\xi(v)| < \varepsilon$, one also has $|(u+t)^{\sigma} - u^{\sigma} - (v+t)^{\sigma} + v^{\sigma}| \leq C\varepsilon$. Therefore

$$
(8.9) \quad \left| \left\{ (u, v, t) \in \Omega'': \left| \xi(u + t) - \xi(u) - \xi(v + t) + \xi(v) \right| \le r^{\mu} \right\} \right| = O(r^{-(1 - \mu)\kappa}),
$$

and consequently

$$
(8.10) \iiint (1+|\xi(u+t)-\xi(u)-\xi(v+t)+\xi(v)|)^{-1} dt du dv = O(r^{-(1-\mu)\kappa}+r^{-\mu}).
$$

9. Conclusion of proof of Lemma [5.2](#page-15-0)

We now complete the proof of Lemma [5.2,](#page-15-0) by proving the upper bound [\(5.33\)](#page-15-2), that is, $\sum_{\mathbf{m}} |\mathcal{S}^*(\mathbf{m})| = O(\lambda^{\gamma-\varrho})$, in the case in which there does exist a real analytic solution \bf{F} , not identically zero, of (6.2) in some nonempty open set. The case in which every real analytic exact solution vanishes identically, has already been treated in §[7.](#page-20-2)

We have shown that the exact solutions in any connected open set form a onedimensional vector space, and take the form $s^{\sigma} \mathbf{F}(y)$, with $\mathbf{F} \in C^{\omega}$; $\sigma \in \mathbb{R}$ is uniquely determined by $(\varphi_j : j \in \underline{4})$. Choose and fix such a function **F** that does not vanish identically. By auxiliary hypothesis [3,](#page-1-1) $\sigma \neq 1$. By Lemma [6.4,](#page-18-3) $\sigma \neq 0$.

For $j \in \underline{3}$ define K_i by

(9.1)
$$
K_j(y,s) = \lambda^{-\tau_0} k_j(m,s) \text{ for } y \in I_m^*
$$

and for $s = O(\lambda^{-\gamma})$, where m is chosen to have the appropriate residue modulo 3 for the index *j*. Then $|K_1(y, s)| \geq 1$ for every (y, s) .

Define $S(K)$ to be the set of all $(x, s) \in B \times [-C\lambda^{-\gamma}, C\lambda^{-\gamma}]$ such that there exists **m** with x in the support of ζ_m satisfying $s \in S^*(m)$. The desired bound $\sum_{m} |\mathcal{S}^*(m)| = O(\lambda^{\gamma-\varrho})$ is equivalent to $_{\mathbf{m}}|\mathcal{S}^*(\mathbf{m})|=O(\lambda^{\gamma-\varrho})$ is equivalent to

(9.2)
$$
\lambda^{\gamma} |S(\mathbf{K})| = O(\lambda^{-\varrho}).
$$

By Lemma [6.7,](#page-20-1) either $\lambda^{\gamma} |S(K)| \leq \lambda^{-c}$ for a certain constant $c > 0$ — in which case the proof of Lemma [5.2](#page-15-0) is complete — or there exist a measurable set $S \subset S(K)$ and a scalar $b \in \mathbb{R}$ that satisfy

(9.3)
$$
|K_1(y,s) - b|s|^{\sigma} F_1(y)| \lesssim \lambda^{\rho - \tau_0} \text{ for all } (y,s) \in S
$$

and

(9.4)
$$
\lambda^{\gamma} |S| \gtrsim (\lambda^{\gamma} |S(\mathbf{K})|^C.
$$

Thus in order to complete the proof of Lemma [5.2,](#page-15-0) it suffices to show that in this second case,

(9.5)
$$
\lambda^{\gamma} |S| = O(\lambda^{-\varrho}) \text{ for some } \varrho > 0.
$$

Let $\delta_3 > 0$ be another small parameter satisfying requirements to be specified below. We may assume that $|s| \geq \lambda^{-\gamma-\delta_3}$ for every $(y, s) \in S$. Indeed, if the set S' of all $(y, s) \in S$ satisfying this inequality had Lebesgue measure $\leq \frac{1}{2}|S|$, then $|S| \leq 2|S \setminus S'| \lesssim \lambda^{-\gamma-\delta_3}$, and the proof would be complete. Thus we may assume that $|S'| \geq \frac{1}{2}|S|$.

We may assume that $|S'| > 0$, and in particular, that S' is nonempty. Choose an arbitrary point $(\bar{y}, \bar{s}) \in S'$. Since $|K_1(\bar{y}, \bar{s})| \geq 1$, $|b| \bar{s} |^{\sigma} F_1(\bar{y})| \geq 1 - O(\lambda^{\rho-\tau_0}) \geq \frac{1}{2}$ $\frac{1}{2}$, since $\tau_0 > \rho$ and we may assume λ to be large. The function **F** is fixed, and is bounded above. Since $\lambda^{-\gamma-\delta_3} \leq |\bar{s}| \leq \lambda^{-\gamma}$ it follows that

(9.6)
$$
\begin{cases} |b|\lambda^{-\gamma\sigma} \gtrsim 1 & \text{if } \sigma > 0, \\ |b|\lambda^{-(\gamma+\delta_3)\sigma} \gtrsim 1 & \text{if } \sigma < 0. \end{cases}
$$

Thus

$$
(9.7) \t\t\t |b|\lambda^{-\sigma\gamma} \gtrsim \lambda^{-|\sigma|\delta_3}.
$$

The function F_1 is real analytic and does not vanish identically, for if $F_1 \equiv 0$ then $|K_1(y, s) - 0| = O(\lambda^{\rho - \tau_0})$ for all $(y, s) \in S$, contradicting the condition $|K_1(y, s)| \geq 1$ unless $S = \emptyset$. Therefore there exist $c > 0$ and $C < \infty$ such that

(9.8)
$$
\left| \left\{ y \in \varphi_1(B) : |F_1(y)| \le \varepsilon \right\} \right| \le C\varepsilon^c \ \forall \varepsilon > 0.
$$

These quantities c, C depend only on Φ . Therefore

$$
(9.9) \qquad \left| \left\{ (x,s) \in B \times [-C\lambda^{-\gamma}, C\lambda^{-\gamma}] : |F_1(\varphi_1(x))| \le \lambda^{-\delta_4} \right\} \right| = O(\lambda^{-c\delta_4} \lambda^{-\gamma}).
$$

Thus it suffices to establish an upper bound of the same type for the measure of the set of all $(x, s) \in S'$ that satisfy the supplementary inequality $|F_1(\varphi_1)(x)| > \lambda^{-\delta_4}$.

For any such x, and any interacting **m** for which x belongs to the support of ζ_m , for any other x' in the support of ζ_m ,

$$
|F_1(\varphi_1)(x')| \ge |F_1(\varphi_1)(x)| - C\lambda^{-\gamma} \ge \lambda^{-\delta_4} - \lambda^{-\gamma} \gtrsim \lambda^{-\delta_4}
$$

since $|x - x'| = O(\lambda^{-\gamma})$ and $\delta_4 < \gamma$.

Thus it suffices to show that for any interacting **m** with the supplementary property that $|F_1(\varphi_1(x'))| \gtrsim \lambda^{-\delta_4}$ for every x' in the support of **m**, the following holds: For any x that is in the support of **m**, $S'(x) = \{s \in \mathbb{R} : (x, s) \in S'\}$ satisfies $|S'(x)| =$ $O(\lambda^{-\gamma-\varrho}).$

Consider any such x. The coefficients in the local Fourier series (5.10) are by definition

$$
a_{j,m,s,k_j(m,s)} = \frac{1}{2}\lambda^{\gamma} \int \eta_m(y) f_j(y+s) \overline{f_j(y)} e^{-i\pi\lambda^{\gamma} k_j(m,s)y} dy.
$$

By the inequality [\(5.28\)](#page-14-2), which is one of the hypotheses of Lemma [5.2,](#page-15-0) these satisfy

$$
|a_{1,m_1,s,k_1(m_1,s)}| \gtrsim \lambda^{-\delta_1}.
$$

This lower bound can be exploited to obtain an upper bound for $|S'(x)|$. To begin,

$$
(9.10) \quad \int_{S'(x)} \left| \int \eta_{m_1}(y) f_1(y+s) \overline{f_1(y)} e^{-i\pi \lambda^\gamma k_1(m_1,s)y} \, dy \right| ds
$$

$$
\gtrsim \int_{S'(x)} \lambda^{-\gamma} |a_{1,m_1,s,k_1(m_1,s)}| \, ds \gtrsim \lambda^{-\gamma-\delta_1} |S'(x)|.
$$

To continue, an upper bound for the left-hand side of [\(9.10\)](#page-25-0) can be derived from Lemma [8.1](#page-21-1) after a change of variables. Indeed, set $\tilde{s} = \lambda^{\gamma} s$ and $\tilde{x} = \lambda^{\gamma} x$. By [\(9.3\)](#page-23-1), the phase $\pi \lambda^{\gamma} k_1(m_1, s)$ y is equal to $\xi(\tilde{s}) \tilde{y}$ with

(9.11)
$$
\xi(t) = \pi \lambda^{\tau_0} K_1(m_1, \lambda^{-\gamma} t) = \pi \lambda^{\tau_0} b \lambda^{-\gamma \sigma} |t|^{\sigma} F_1(\varphi_1(x)) + O(\lambda^{\rho}).
$$

In these coordinates, we aim to apply Lemma [8.1](#page-21-1) with the parameter

(9.12)
$$
r = \pi \lambda^{\tau_0} |b| \lambda^{-\gamma \sigma} F_1(\varphi_1(x)).
$$

The lemma is applicable provided that $r \geq 1$ and $\lambda^{\rho} \leq r^{\mu}$ for some $\mu < 1$; we next verify that these inequalities are satisfied.

Since $|b\lambda^{-\gamma\sigma}| \gtrsim \lambda^{-|\sigma|\delta_3}$ by (9.7) ,

$$
(9.13) \t\t\t r \gtrsim \lambda^{\tau_0 - C\delta_3 - \delta_4}
$$

and it follows that both $r \geq 1$ and $\lambda^{\rho} \leq r^{1/2}$ for all sufficiently large λ , provided that ρ, δ_3, δ_4 are chosen to be sufficiently small relative to τ_0 . We require that the parameters be chosen so that

(9.14)
$$
C\delta_3 + \delta_4 < \frac{1}{2}\tau_0 \text{ and } \rho < \frac{1}{4}\tau_0.
$$

Then Lemma [8.1](#page-21-1) applies, and yields the upper bound

$$
\int_{S'(x)} \left| \int \eta_{\mathbf{m}}(y) f_1(y+s) \overline{f_1(y)} e^{i\pi \lambda^\gamma k_1(m_1,s)y} dy \right| ds
$$
\n
$$
\leq \int_{|s|=O(\lambda^{-\gamma})} \left| \int \eta_{\mathbf{m}}(y) f_1(y+s) \overline{f_1(y)} e^{i\pi \lambda^\gamma k_1(m_1,s)y} dy \right| ds
$$
\n
$$
\lesssim \lambda^{-2\gamma} \cdot (\lambda^{\tau_0-C\delta_3-\delta_4})^{-\delta_2}.
$$

Together with (9.10) , (9.15) yields a lower bound for $|S'(x)|$:

 (9.16) $\mathcal{U}(x)| \lesssim \lambda^{-\gamma+\delta_1} \lambda^{-\tau_0\delta_2/4}.$

We require that

(9.17)
$$
\delta_3 < \delta_1 < \frac{1}{8}\tau_0 \delta_2.
$$

Recall that σ is uniquely determined by $(\varphi_j : j \in \underline{4})$, while δ_2 , which arose in Lemma [8.1,](#page-21-1) depends only on σ , and δ_1 is assumed to be less than or equal to δ_0 , which has not yet been specified. Therefore these requirements can be satisfied by first choosing $\delta_0 < \frac{1}{8}$ $\frac{1}{8}\tau_0\delta_2$, then choosing δ_3 , δ_4 sufficiently small relative to δ_0 , δ_2 . Thus we have shown that if the parameters δ_0 , δ_3 , δ_4 , ρ are chosen to satisfy the indicated constraints then uniformly for all $x \in B$ under consideration,

$$
(9.18)\qquad \qquad |S'(x)| = O(\lambda^{-\gamma - \delta_5})
$$

for a certain exponent $\delta_5 > 0$. This completes the proof of Lemma [5.2.](#page-15-0)

10. Conclusion of proof

Assume that $\|\mathbf{f}\|_{L^{\infty}} = O(1)$. Let $\delta_1^*, \delta_2^*, \delta_3^*, \delta_4^* \in (0, \delta_0]$ be small positive quantities, to be chosen below. For each index j, decompose $f_j = f_{j,\sharp} + f_{j,\flat}$ by applying Lemma [3.2](#page-4-1) in the manner indicated in the discussion following its statement, with parameter $\delta = \delta_j^*$.

The summands $f_{j,sharp}$ satisfy

$$
(10.1) \t\t\t\t\t||f_{j,\sharp}||_{L^{\infty}} = O(\lambda^{a_j})
$$

where $a_j = \delta_j^* \tau_0 / 2$ tends to 0 as $\delta_j^* \to 0$. Express

(10.2)
$$
\mathcal{T}(\mathbf{f}) = \mathcal{T}(f_1, f_2, f_3, f_{4,\sharp}) + \mathcal{T}(f_1, f_2, f_3, f_{4,\flat}).
$$

By Proposition [5.1,](#page-10-0)

(10.3)
$$
|\mathcal{T}(f_1, f_2, f_3, f_{4,\flat})| = O(\lambda^{-\tau_4})
$$

for a certain positive constant $\tau_4 > 0$ that depends on the choice of δ_4^* . Express

(10.4)
$$
\mathcal{T}(f_1, f_2, f_3, f_{4,\sharp}) = \mathcal{T}(f_1, f_2, f_{3,\sharp}, f_{4,\sharp}) + \mathcal{T}(f_1, f_2, f_{3,\flat}, f_{4,\sharp}).
$$

By Proposition [5.1,](#page-10-0)

(10.5)
$$
|\mathcal{T}(f_1, f_2, f_{3,\flat}, f_{4,\sharp})| = O(\lambda^{-\tau_3} || f_{4,\sharp} ||_{L^{\infty}}) = O(\lambda^{-\tau_3 + a_4}),
$$

for a certain $\tau_3 > 0$ that depends on δ_3^* . Continuing in this way gives

$$
(10.6) \quad |\mathcal{T}(\mathbf{f})| = O(\lambda^{-\tau_4}) + O(\lambda^{-\tau_3 + a_4}) + O(\lambda^{-\tau_2 + a_3 + a_4}) + O(\lambda^{-\tau_1 + a_2 + a_3 + a_4}) + |\mathcal{T}(f_{1, \sharp}, f_{2, \sharp}, f_{3, \sharp}, f_{4, \sharp})|,
$$

with each τ_j being positive, and depending on δ_j^* . Finally, since each function $f_{j,\sharp}$ is a sum of $O(\lambda^{a_j})$ functions g_j of the type that appears in Proposition [4.1,](#page-6-2) that Proposition provides a majorization

(10.7)
$$
\mathcal{T}(f_{1,\sharp}, f_{2,\sharp}, f_{3,\sharp}, f_{4,\sharp}) = O\left(\lambda^{-\tau} \prod_{j=1}^4 \|f_{j,\sharp}\|_{L^{\infty}}\right) = O\left(\lambda^{-\tau+a_1+a_2+a_3+a_4}\right)
$$

for a certain exponent $\tau > 0$ that does not depend on the quantities δ_j^* .

Choose the parameters δ_j^* to be sufficiently small to ensure that $a_j \leq \tau/8$ for each j, and choose them by ascending induction on j so that each δ_n^* is sufficiently small as a function of δ_{n-1}^* to ensure that each term on the right-hand side of [\(10.6\)](#page-26-1) is of the form $O(\lambda^{-c})$ for some $c > 0$. This completes the proof of Theorem [1.1.](#page-0-2)

11. A sublevel set inequality

For any four-tuple **f** of measurable functions $f_j : \varphi_j(B) \to \mathbb{C}$ define

(11.1)
$$
S(\mathbf{f}, \varepsilon) = \left\{ x \in B : \left| \sum_{j=1}^{4} (f_j \circ \varphi_j)(x) \right| < \varepsilon \right\}
$$

and

(11.2)
$$
|(\mathbf{f} \circ \mathbf{\Phi})(x)| = \sum_{j=1}^{4} |(f_j \circ \varphi_j)(x)|.
$$

Corollary 11.1. Let (a, Φ) satisfy the hypotheses of Theorem [1.1.](#page-0-2) There exist $C <$ ∞ and $\tau > 0$ such that for any Lebesgue measurable f and any $\varepsilon > 0$,

(11.3)
$$
\left| \left\{ x \in S(\mathbf{f}, \varepsilon) : |(\mathbf{f} \circ \mathbf{\Phi})(x)| \ge 1 \right\} \right| \le C \varepsilon^{\tau}.
$$

This follows from Theorem [1.1](#page-0-2) by the same reasoning as developed for the case of three summands in §18 of [\[2\]](#page-27-2).
