Concave and other generalizations of stochastic Gronwall inequalities

Abstract

We provide nonlinear generalizations of a class of stochastic Gronwall inequalities that have been studied by von Renesse and Scheutzow (2010), Scheutzow (2013), Xie and Zhang (2020) and Mehri and Scheutzow (2021). This class of stochastic Gronwall inequalities is a useful tool for SDEs.

More precisely, we study generalizations of the Bihari-LaSalle type. Whilst in a closely connected article by the author convex generalizations are studied, we investigate here concave and other generalizations. These types of estimates are useful to obtain existence and uniqueness of global solutions of path-dependent SDEs driven by Lévy processes under one-sided non-Lipschitz monotonicity and coercivity assumptions.

Keywords: stochastic Gronwall inequality, stochastic Bihari-LaSalle inequality, Lenglart's domination inequality, sharp constants, existence and uniqueness of path-dependent SDEs with jumps, Osgood condition

1 Introduction

In this article we provide generalizations of two types of stochastic Gronwall inequalities. Whereas in the closely related article [12] convex generalizations are studied, we focus here on concave and more general generalizations. The estimates we obtain seem necessary to show existence, uniqueness and non-explosion of solutions to path-dependent SDEs under one-sided non-Lipschitz conditions. This section is structured as follows: First, we provide two simple examples which demonstrate where the generalizations we study can arise. Subsequently, we provide a short overview on the existing results in the literature and on the extensions we study in this paper.

Path-dependent SDEs as motivation for stochastic Gronwall inequalities: The stochastic Gronwall inequalities we generalize in this article were originally developed to study path-dependent SDEs [38]: Consider the following path-dependent SDE driven by a Brownian motion B,

$$dY_t = f(Y_{[-r,t]}, t)dt + g(X_{[-r,t]}, t)dB_t, \qquad Y_{[-r,0]} = y \in C([-r,0], \mathbb{R}^d),$$

where $X_{[-r,t]}$ denotes the path segment $\{X(u), u \in [-r,t]\}$ and r > 0 is a constant. Uniqueness of global solutions is known under a one-sided Lipschitz condition

$$2\langle y(t) - z(t), f(y_{[-r,t]}, t) - f(z_{[-r,t]}, t) \rangle + |g(y_{[-r,t]}, t) - g(z_{[-r,t]}, t)|_F^2 \le K \sup_{s \in [-r,t]} |y(s) - z(s)|^2$$
(1)

for all $y, z \in C([-r, \infty), \mathbb{R}^d)$, where K > 0 is a constant. Here $|\cdot|_F$ denotes the Frobenius norm. For stronger and more general results see von Renesse and Scheutzow [38, Theorem 2.2] and Mehri and Scheutzow [30, Theorem 3.3]. Note that (1) is weaker than assuming

$$2\langle y(t) - z(t), f(y_{[-r,t]}, t) - f(z_{[-r,t]}, t) \rangle \le K \sup_{s \in [-r,t]} |y(s) - z(s)|^2$$

and $|g(y_{[-r,t]}, t) - g(z_{[-r,t]}, t)|_F^2 \le K \sup_{s \in [-r,t]} |y(s) - z(s)|^2$

as the scalar product term might be negative. We sketch the proof ansatz for the uniqueness of global solutions: For two global solutions Y and Z with the same initial condition y define the process $X_t := |Y_t - Z_t|^2$. It suffices to show $\sup_{t \in [0,T]} X_t = 0$ a.s. for any T > 0. By Itô's formula and (1) we have

$$\begin{split} X_t &= \int_0^t 2\langle Y_s - Z_s, f(Y_{[0,s]},s) - f(Z_{[0,s],s}) \rangle + |g(Y_{[0,s]},s) - g(Z_{[0,s]},s)|_F^2 \mathrm{d}s \\ &+ \int_0^t 2\langle Y_s - Z_s, g(Y_{[0,s]},s) - g(Z_{[0,s]},s) \mathrm{d}B_s \rangle \\ &\leq \int_0^t K X_s^* \mathrm{d}s + M_t \qquad \forall t \geq 0, \end{split}$$

where X_s^* denotes the running supremum $\sup_{u \in [0,s]} X_u$ and M is a continuous local martingale starting in 0. Obtaining upper bounds for X_t^* (i.e. showing it is 0) using the BDG inequality and the Young inequality does not seem to be possible because then we would obtain the term $|g(y_{[0,t]},t) - g(z_{[0,t]},t)|_F^2$ due to the quadratic variation. Also taking expectations and then applying the deterministic Gronwall inequality to $t \mapsto \mathbb{E}[X_t]$ does not work, due to the running supremum X_s^* in the integral. In [38] bounds for X are obtained instead by proving a stochastic Gronwall inequality: To this end it is exploited that X is non-negative and M is a continuous local martingale starting in 0. In [30] these results are extended to càdlàg local martingales.

Consider now a one-sided non-Lipschitzian monotonicity assumption: Replace in (1) $K \sup_{s \in [0,t]} |y(s) - z(s)|^2$ by $K\eta(\sup_{s \in [0,t]} |y(s) - z(s)|^2)$, where $\eta : [0,\infty) \to [0,\infty)$ is a non-decreasing function satisfying $\int_0^{\varepsilon} \frac{du}{\eta(u)} = \infty$ for all $\varepsilon > 0$ (Osgood condition). To prove that uniqueness of global solutions also holds in this case, consider as before $X_t = |Y_t - Z_t|^2$. It would satisfy the following type of inequality

$$X_t \leq \int_0^t K\eta(X_s^*) \mathrm{d}s + M_t \qquad \forall t \geq 0.$$

This is a special case of the inequalities (and applications) we study in this article.

Application of stochastic Gronwall inequalities to other types of SDEs: Deterministic Gronwall inequalities are widely used to study SDEs. We provide a typical example when the deterministic Gronwall inequality is not applicable and instead stochastic generalizations of Gronwall inequalities appear useful to shorten calculations. Consider a non-path-dependent SDE driven by a Brownian motion B

$$dY_t = b(Y_t, t) dt + \sigma(Y_t, t) dB_t, \quad Y_0 = y_0 \in \mathbb{R}^d$$

with random coefficients b and σ . Assume the following one-sided condition

$$2\langle y-z, b(y,t) - b(z,t) \rangle + |\sigma(y,t) - \sigma(z,t)|_F^2 \le K_t \eta(|y-z|^2) \qquad \forall y, z \in \mathbb{R}^d, \forall t \ge 0,$$
(2)

where $\eta : [0, \infty) \to [0, \infty)$ is a non-decreasing function satisfying $\int_0^{\varepsilon} \frac{du}{\eta(u)} = \infty$ for all $\varepsilon > 0$, and $(K_t)_{t\geq 0}$ is an adapted non-negative stochastic process with suitable integrability assumptions. It is known that under additional assumptions this implies the uniqueness of global solutions. For more details in a more general setting see e.g. Lan and Wu [20, Theorem 1.1] and the references therein. Let Y and Z be global solutions of this SDE and set $X_t := |Y_t - Z_t|^2$. Similarly as in the path-dependent case above, using Itô's formula to compute X_t and applying assumption (2) gives

$$X_t \le \int_0^t \eta(X_s) K_s \mathrm{d}s + M_t \qquad \forall t \ge 0$$

for the local martingale $M_t := \int_0^t 2\langle Y_s - Z_s, \sigma(Y_s, s) - \sigma(Z_s, s) \rangle ds$. Hence, to prove uniqueness of solutions in this case, the typical argument to take expectations and then apply the deterministic Gronwall inequality to $t \mapsto \mathbb{E}[X_t]$ fails already in the linear case $\eta(x) = x$ if $(K_t)_{t \ge 0}$ is random. Using different techniques, uniqueness of solutions and further properties have been shown in Lan and Wu [20, Theorem 1.1]. Here, alternatively, generalizations of stochastic Gronwall inequalities could be applied and would shorten computations.

Results in the literature on stochastic Gronwall inequalities: Now we summarize the existing literature on the two stochastic Gronwall inequalities we will generalize. The following *stochastic Gronwall inequality with supremum* is due to von Renesse and Scheutzow [38, Lemma 5.4] and was generalized by Mehri and Scheutzow [30, Theorem 2.1]: Let $(X_t)_{t\geq 0}$ be a non-negative stochastic process, that satisfies

$$X_t \le \int_{(0,t]} X_{s^-}^* dA_s + M_t + H_t \quad \text{for all } t \ge 0,$$
 (3)

where $X_s^* = \sup_{u \in [0,s]} X_u$ denotes the running supremum. Here, M is a càdlàg local martingale that starts in 0, and H and A are suitable non-decreasing stochastic processes. Then, for all T > 0 and $p \in (0,1)$ there exists an explicit upper bound for $\mathbb{E}[\sup_{t \in [0,T]} X_t^p]$ which does not depend on the local martingale M.

There is also a *stochastic Gronwall inequality without supremum* which is closely connected to the previous inequality with supremum. This result is due to Scheutzow [35, Theorem 4] and was generalized by Xie and Zhang [40, Lemma 3.7] to càdlàg local martingales: If we assume instead of (3) the slightly stronger assumption that

$$X_t \le \int_{(0,t]} X_{s-} \mathrm{d}A_s + M_t + H_t \quad \text{for all } t \ge 0, \tag{4}$$

sharper bounds can be obtained.

Both previously mentioned inequalities are useful tools for SDEs. The stochastic Gronwall inequality with supremum is applied to study SDEs with memory, see for example [4], [5], [6], [7], [19], [30], [36] and [38]. The stochastic Gronwall inequality without supremum is applied to study various SDEs without memory, see e.g. [11], [16], [17], [21], [24], [29], [33], [34], [37], [39] and [41].

Further stochastic Gronwall inequalities with a somewhat different setting have been studied by Glatt-Holtz and Ziane [14, Lemma 5.3] and Agresti and Veraar [1, Lemma A.1].

Results of this article on generalizations of stochastic Gronwall inequalities: In this paper, we study the following nonlinear generalization of the above mentioned stochastic Gronwall inequalities: We replace the assumptions (3) and (4) by

$$X_t \le \int_{(0,t]} \eta(X_{s^-}^*) dA_s + M_t + H_t \quad \text{for all } t \ge 0,$$
(5)

and

$$X_t \le \int_{(0,t]} \eta(X_{s^-}) dA_s + M_t + H_t \quad \text{for all } t \ge 0,$$
 (6)

respectively, where $\eta : [0, \infty) \to [0, \infty)$ is a non-decreasing function. For continuous martingales and η that satisfy $\int_1^\infty \frac{\mathrm{d}u}{\eta(u)} = +\infty$ inequality (5) has been studied by von Renesse and Scheutzow [38, Lemma 5.1] in the context of global solutions of stochastic functional differential equations, but no explicit upper bounds for $\mathbb{E}[\sup_{t \in [0,T]} X_t^p]$ were derived. For convex η these inequalities are studied in [12]. Also other types of nonlinear extensions of the stochastic Gronwall inequalities have been studied, see Section 2.3 for more details.

For the deterministic case (i.e. $M \equiv 0$) the Bihari-LaSalle inequality provides an upper bound for X_t , see [8], [22]. In [8] and [22] the integrator is of the form $A(t) = \int_0^t \varphi(s) ds$, but we will need a version where the integrator A is only càdlàg. As this version is difficult to find in the literature, we provide a short proof in the appendix, which goes along the lines of the standard proof.

Lemma 1.1 (Deterministic Bihari-LaSalle inequality). Let H > 0 be a constant and let $x : [0, \infty) \rightarrow [0, \infty)$ be a càdlàg function and $A : [0, \infty) \rightarrow [0, \infty)$ a non-decreasing càdlàg function with A(0) = 0. Let $\eta : [0, \infty) \rightarrow [0, \infty)$ be a left-continuous non-decreasing function satisfying $\eta(u) > 0$ for u > 0. Define $G(v) := \int_c^v \frac{\mathrm{d}u}{\eta(u)}$ for some constant c > 0. Assume that the function x satisfies

$$x(t) \le \int_{(0,t]} \eta(x(s^{-})) \mathrm{d}A(s) + H \qquad \forall t \in [0,T]$$
 (7)

for some T > 0. If $G(H) + A(T) \in domain(G^{-1})$, then the following inequality holds true:

$$x(t) \le G^{-1}(G(H) + A(t)) \qquad \forall t \in [0, T].$$

Note that the upper bound on x does not depend on the choice of the constant c > 0 used in the definition of G. We obtain the well-known Gronwall inequality by choosing c = 1 and $\eta(u) \equiv u$ in Lemma 1.1 so that $G(u) \equiv \log(u)$, which implies the upper bound

$$x(t) \le H \exp(A(t)).$$

In the present article we show for concave η a stochastic version of the Bihari-LaSalle inequality which provides upper bounds similar to that of the deterministic Bihari-LaSalle inequality. Let $(\Omega, \mathcal{F}, \mathbb{P}, (\mathcal{F}_t)_{t\geq 0})$ an underlying filtered probability space satisfying the usual conditions. The following theorem is a part of Theorem 3.1 (noting that $x \mapsto G^{-1}(G(x^{1/p}) + \beta a)^p$ is concave under the assumptions of the theorem, i.e. $\mathbb{E}[\cdot | \mathcal{F}_0]$ may be replaced by $\mathbb{E}[\cdot]$ by Jensen's inequality).

Theorem 1.2 (Concave stochastic Bihari-LaSalle inequality with supremum). Let $p \in (0, 1)$ and assume that

- ▶ $(X_t)_{t\geq 0}$ is an adapted non-negative right-continuous process,
- ▶ $(A_t)_{t\geq 0}$ is a deterministic non-decreasing càdlàg function with $A_0 = 0$,
- ▶ $(H_t)_{t\geq 0}$ is an predictable non-negative non-decreasing càdlàg process,
- $(M_t)_{t>0}$ is a càdlàg local martingale with $M_0 = 0$,
- $\eta: [0,\infty) \to [0,\infty)$ is a continuous non-decreasing function with $\eta(x) > 0$ for all x > 0 such that $\eta_p: (0,\infty) \mapsto [0,\infty), \ x \mapsto \frac{p}{1-p}\eta(x^{1/p})x^{1-1/p}$ is concave and non-decreasing.

Moreover, assume that

$$X_t \le \int_{(0,t]} \eta(X_{s^-}^*) \mathrm{d}A_s + M_t + H_t \qquad \mathbb{P}\text{-}a.s.$$

holds true for all $t \ge 0$. Then, for all T > 0 such that $\mathbb{E}[H_T^p] < \infty$ the following inequality holds

$$\mathbb{E}\left[\sup_{t\in[0,T]}X_t^p\right]^{1/p} \le G^{-1}\big(G(\alpha_1\alpha_2\mathbb{E}[H_T^p]^{1/p}) + \beta A_T\big),$$

where we use the notation $G(v) := \int_1^v \frac{\mathrm{d}u}{\eta(u)}$. The constants $\beta = (1-p)^{-1}$ and $\alpha_1 \alpha_2 = (1-p)^{-1/p} p^{-1}$ are sharp.

The assumption that η_p is concave is slightly stronger than the assumption that η is concave. By a time change argument this theorem also implies estimates for random integrators A, see Corollary 3.8.

Under the stronger assumption (6) we obtain for concave η and random A also the following weak L^1 estimate: For all $t \ge 0$, R > 0, w > 0, u > 0 we have

$$\mathbb{P}[X_t^* > u] \le \frac{G^{-1}(G(\mathbb{E}[H_t \land w]) + R)}{u} + \mathbb{P}[H_t \ge w] + \mathbb{P}[A_t > R],\tag{8}$$

see Corollary 3.9. The benefit of this estimate is that it does not require integrability assumptions on H and A. It can be shown that under the weaker assumption (5) the weak L^1 norm is in general not finite, in particular (8) fails to hold true in this case. Note that in the special case $\eta(x) = x$ the estimate (8) simplifies to

$$\mathbb{P}[X_t^* > u] \le \frac{\mathrm{e}^R}{u} \mathbb{E}[H_t \wedge w] + \mathbb{P}[H_t \ge w] + \mathbb{P}[A_t > R], \tag{9}$$

for more details on the estimate (9) and the linear case $\eta(x) = x$ see [12, Section 5]. The inequality (9) is applied by Agresti and Veraar [2, Lemma 5.3, Lemma 6.7] to prove global well-posedness for reaction-diffusion systems with transport noise.

For the application by stems with transport noise. For the application to path-dependent SDEs the cases $\int_0^1 \frac{du}{\eta(u)} = +\infty$ and $\int_1^\infty \frac{du}{\eta(u)} = +\infty$ (without necessarily imposing concavity or convexity assumptions on η) are especially useful. Whilst we do not obtain explicit upper bounds for the quantity $\mathbb{E}[\sup_{t \in [0,T]} X_t^p]$ without concavity or convexity assumptions, we do observe that $(X_t)_{t \in [0,T]}$ still behaves similarly w.r.t the process $(H_t)_{t \geq 0}$ as the function $x(t), t \in [0,T]$ w.r.t. the constant H in the deterministic Bihari-LaSalle inequality, for details see Theorem 3.11. These properties are sufficient for our applications: We apply these results to prove existence and uniqueness of global solutions to path-dependent SDEs driven by Lévy processes under one-sided non-Lipschitzian monotonicity and coercivity assumptions.

2 Notation, assumptions and overview

We assume that all processes are defined on an underlying filtered probability space $(\Omega, \mathcal{F}, \mathbb{P}, (\mathcal{F}_t)_{t\geq 0})$ satisfying the usual conditions.

2.1 Notation and constants

Constants: For $p \in (0, 1)$ define the following constants:

$$\beta = (1-p)^{-1}, \quad \alpha_1 = (1-p)^{-1/p}, \quad \alpha_2 = p^{-1}.$$
 (10)

Quasinorms: We denote by $|\cdot|$ the Euclidean norm and $|\cdot|_F$ the Frobenius norm. Let Y be a random variable. We use for $p \in (0, 1]$ the notation (if well-defined)

$$\mathbb{E}_{\mathcal{F}_0}[Y] := \mathbb{E}[Y \mid \mathcal{F}_0], \qquad \qquad \|Y\|_p := \mathbb{E}[|Y|^p]^{1/p}, \qquad \qquad \|Y\|_{p,\mathcal{F}_0} := \mathbb{E}[|Y|^p \mid \mathcal{F}_0]^{1/p}.$$

Running supremum: Let X be a non-negative stochastic process with right-continuous paths. We use the following notation for the running supremum and its left limits:

$$X_t^* := \sup_{0 \le s \le t} X_s \quad \forall t \ge 0,$$

$$X_{t^-}^* := \lim_{s \nearrow t} X_s^* = \sup_{s \le t} X_s \quad \forall t > 0.$$

As usual, we set $X_{0^-}^* := X_0$. If X is càdlàg, then also $X_{t^-}^* = \sup_{s \le t} X_{s^-}$ holds true. If X is only right-continuous then X_t^* and $X_{t^-}^*$ take values in $[0, +\infty]$.

Functions: Let $\eta : [0, \infty) \to [0, \infty)$ be a non-decreasing function with $\eta(u) > 0$ for u > 0. Define the following functions for $p \in (0, 1)$.

$$G(x) := \int_{c}^{x} \frac{\mathrm{d}u}{\eta(u)} \qquad \qquad \forall x \in [0, \infty), \tag{11}$$

$$\eta_p(x) := \frac{p}{1-p} \eta(x^{1/p}) x^{1-1/p} \qquad \forall x \in (0,\infty),$$
(12)

$$\tilde{G}_p(x) := \int_{c^p}^x \frac{\mathrm{d}u}{\eta_p(u)} \qquad \qquad \forall x \in (0,\infty).$$
(13)

The functions have the following properties:

- ▶ The function G satisfies $G(0) \in [-\infty, 0)$. Moreover, G is increasing and concave. In particular, it has a well-defined increasing inverse G^{-1} : range $(G) \cap (-\infty, \infty) \mapsto [0, \infty)$. If $G(0) = -\infty$, then we set $G^{-1}(G(0) + a) := 0$ for $a \in (-\infty, \infty)$. If η is continuous, then G is continuously differentiable on $(0, \infty)$.
- ▶ The functions G and \tilde{G}_p satisfy for all $x \in (0, \infty)$

$$\tilde{G}_p(x) = \frac{1-p}{p} \int_{c^p}^x \frac{\mathrm{d}u}{\eta(u^{1/p})u^{1-1/p}} = (1-p) \int_c^{x^{1/p}} \frac{\mathrm{d}v}{\eta(v)} = (1-p)G(x^{1/p})$$
(14)

and for all $x \in \text{domain}(\tilde{G}_p^{-1})$

$$\tilde{G}_p^{-1}(x) = \left(G^{-1}\left(\frac{x}{1-p}\right)\right)^p.$$
(15)

2.2 Assumptions

We study the following two cases:

Definition 2.1 (Assumption \mathcal{A}_{sup}). Let

- \blacktriangleright $(X_t)_{t>0}$ be an adapted non-negative right-continuous process,
- ▶ $(A_t)_{t>0}$ be a predictable non-decreasing càdlàg process with $A_0 = 0$,
- \blacktriangleright $(H_t)_{t>0}$ be an adapted non-negative non-decreasing càdlàg process,
- $(M_t)_{t\geq 0}$ be a càdlàg local martingale with $M_0 = 0$,
- ▶ $\eta: [0,\infty) \to [0,\infty)$ be a continuous non-decreasing function with $\eta(x) > 0$ for all x > 0.

We say the processes X, A, H, M satisfy \mathcal{A}_{sup} if they satisfy the inequality below for all $t \geq 0$:

$$X_t \le \int_{(0,t]} \eta(X_{s-}^*) \mathrm{d}A_s + M_t + H_t \qquad \mathbb{P}\text{-}a.s.$$
 (16)

The following assumption is slightly stronger:

Definition 2.2 (Assumption $\mathcal{A}_{no \sup}$). Under the same assumptions on the processes as in the previous definition, we say that the processes satisfy $\mathcal{A}_{no \sup}$ if in addition X has left limits and the processes satisfy the following inequality for all $t \geq 0$:

$$X_t \le \int_{(0,t]} \eta(X_{s^-}) \mathrm{d}A_s + M_t + H_t \qquad \mathbb{P}\text{-}a.s.$$
(17)

We also use the two definitions above for processes defined on a finite time interval [0, T] and correspondingly adapt the definition in this case.

2.3 Overview of the results

Table 1 summarizes the results obtained by von Renesse and Scheutzow [38, Lemma 5.4], Scheutzow [35, Theorem 4], Xie and Zhang [40, Lemma 3.7], Mehri and Scheutzow [30, Theorem 2.1] and the author [12, Corollary 5.2, Corollary 5.4] on stochastic Gronwall inequalities. For a detailed overview on these results, see e.g. [12, Section 5]. Table 2 summarizes the stochastic Bihari-LaSalle inequalities obtained in this article, and for the convenience of the reader, also the results obtained in [12].

The constant $\alpha_1 \alpha_2$ is the sharp constant from Lenglart's inequality, α_2 is the sharp constant from a monotone version of Lenglart's inequality [13]. The constants α_1 , $\alpha_1 \alpha_2$ and β appearing in the stochastic Gronwall inequalities are sharp, see [12, Theorem 3.5, Theorem 3.7].

Also other nonlinear extensions of the stochastic Gronwall inequalities have been studied. Makasu [28, Theorem 2.2] and Le and Ling [26, Lemma 3.8] studied a non-linear generalization where in the assumption the term $\int_{(0,t]} X_{s^-} dA_s$ is replaced by $\left(\int_{(0,t]} (X_s)^{\theta} dA_s\right)^{1/\theta}$ for $\theta > 0$ and obtained estimates for $\mathbb{E}[\sup_{t \in [0,T]} X_t^p]$.

A further nonlinear extension of the stochastic Gronwall inequalities has been studied by Mekki, Nieto and Ouahab [31, Theorem 2.4]: For continuous local martingales a stochastic Henry Gronwall's inequality with upper bounds that do not depend on the local martingale M can be proven.

In addition, also extensions of the stochastic Gronwall inequalities have been studied, where the upper bounds depend on the quadratic variation of the martingale M, see e.g. Makasu [28], Makasu [27] and Mekki, Nieto and Ouahab [31]. In the present paper, we focus on bounds which do not depend on the local martingale M. Furthermore, Hudde, Hutzenthaler and Mazzonetto [18] have extended the stochastic Gronwall inequality without supremum to the setting of Itô processes which satisfy a suitable one-sided affine-linear growth condition.

3 Main results: Stochastic Bihari-LaSalle inequalities

In this section we provide nonlinear generalizations of the stochastic Gronwall inequalities mentioned in the introduction and Table 1. For the definition of the constants see (10).

3.1 Estimates for concave η and deterministic A

Theorem 3.1 (A sharp stochastic Bihari-LaSalle inequality for concave η). Let (X, A, H, M) and η satisfy Assumption \mathcal{A}_{sup} or Assumption $\mathcal{A}_{no sup}$. Moreover, assume that A is deterministic and $p \in (0, 1)$. For η we use the notation

$$\eta_p: (0,\infty) \mapsto [0,\infty), \qquad x \mapsto \frac{p}{1-p}\eta(x^{1/p})x^{1-1/p}.$$

a) Let Assumption \mathcal{A}_{sup} hold and assume that η_p is concave and non-decreasing. Then, the following assertions hold for all $t \ge 0$:

$$\|X_t^*\|_{p,\mathcal{F}_0} \leq \begin{cases} G^{-1} \Big(G\big(\alpha_1 \alpha_2 \|H_t\|_{p,\mathcal{F}_0} \big) + \beta A_t \Big) & \text{if } \mathbb{E}[H_t^p] < \infty \text{ and } H \text{ is predictable,} \\ \\ G^{-1} \Big(G\big(\alpha_1 \alpha_2 \|H_t\|_{p,\mathcal{F}_0} \big) + \beta A_t \Big) & \text{if } \mathbb{E}[H_t^p] < \infty \text{ and } \Delta M \ge 0, \\ \\ G^{-1} \Big(G\big(\alpha_1 \|H_t\|_{1,\mathcal{F}_0} \big) + \beta A_t \Big) & \text{if } \mathbb{E}[H_t] < \infty, \end{cases}$$

where $\beta := (1-p)^{-1}$, $\alpha_1 := (1-p)^{-1/p}$ and $\alpha_2 := p^{-1}$. We use the notation $(\Delta M_t)_{t\geq 0} := (M_t - M_{t^-})_{t\geq 0}$ and $\|Y\|_{p,\mathcal{F}_0} := \mathbb{E}[|Y|^p | \mathcal{F}_0]^{1/p}$ for random variables Y.

The constants α_1 , $\alpha_1\alpha_2$ and β are sharp, they are already sharp when $\eta(x) \equiv x$.

b) If Assumption $\mathcal{A}_{no \sup}$ holds, the following assertions are true for all $t \geq 0$:

$$\begin{cases} \alpha_1 G^{-1} \Big(G \big(\alpha_2 \| H_t \|_{p, \mathcal{F}_0} \big) + A_t \Big) & \text{ if } \mathbb{E}[H_t^p] < \infty, \ H \ is \ predictable, \\ & \text{ and } \eta_p \ is \ concave \ and \ non-decreasing} \end{cases}$$

$$\|X_t^*\|_{p,\mathcal{F}_0} \leq \begin{cases} \alpha_1 G^{-1} \left(G\left(\alpha_2 \|H_t\|_{p,\mathcal{F}_0}\right) + A_t \right) & \text{if } \mathbb{E}[H_t^p] < \infty, \ \Delta M \ge 0, \\ \text{and } \eta_p \text{ is concave and non-decreasing,} \end{cases}$$

$$\leq \alpha_1 G^{-1} \left(G\left(\|H_t\|_{1,\mathcal{F}_0}\right) + A_t \right) & \text{if } \mathbb{E}[H_t] < \infty \text{ and } \eta \text{ is concave.} \end{cases}$$

$$(18)$$

The constant α_1 is sharp. If $\eta(x) \equiv x$, then $\alpha_1 \alpha_2$ appears in the estimates for $\mathbb{E}[H_t^p] < \infty$ and the constant is sharp.

Under Assumption $\mathcal{A}_{no \sup}$ also the following weak L^1 estimates are true for all $t \ge 0, u > 0, w > 0$:

$$\mathbb{P}_{\mathcal{F}_0}[X_t^* > u] \leq \begin{cases} \frac{G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_t \wedge w]) + A_t)}{u} + \mathbb{P}_{\mathcal{F}_0}[H_t \ge w] & \text{if } H \text{ is predictable and } \eta \text{ is concave,} \\ \frac{G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_t]) + A_t)}{u} & \text{if } \mathbb{E}[H_t] < \infty \text{ and } \eta \text{ is concave.} \end{cases}$$

$$(19)$$

Remark 3.2. Assume that (X, A, H, M) and η satisfy Assumption $\mathcal{A}_{no \sup}$ and let η be concave. Then, also for the case $\Delta M \ge 0$ it can be shown that $t \ge 0, u > 0, w > 0$ we have

$$\mathbb{P}_{\mathcal{F}_0}[X_t^* > u] \le \frac{G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_t \land w]) + A_t)}{u} + \mathbb{P}_{\mathcal{F}_0}[H_t \ge w].$$

We prefer not to prove it to keep the manuscript at a reasonable length.

Remark 3.3. If we assume that (X, A, H, M) and η satisfy Assumption \mathcal{A}_{sup} (which is a weaker assumption than Assumption $\mathcal{A}_{no sup}$), (19) does not hold in general. See [12, Theorem 3.8] for a counterexample and further details.

Remark 3.4. The function $\eta_p(x) \equiv \frac{p}{1-p}\eta(x^{1/p})x^{1-1/p}$ defined in (12) appears (upto the factor 1-p) naturally in connection with the deterministic Bihari-LaSalle equality: Let x be as in Lemma 1.1 and assume that x is non-decreasing. Then, x^p (for some $p \in (0, 1)$) satisfies:

$$x(t)^{p} \leq (1-p) \int_{0}^{t} \eta_{p}(x(s^{-})^{p}) \mathrm{d}A(s) + H^{p} \quad \text{for all } t \in [0,T].$$
⁽²⁰⁾

This can be seen using the same formulas we will use in the stochastic case, see Remark 5.2.

Moreover, for any continuous η such that $x(t) := G^{-1}(G(H) + t)$ is well-defined for $t \in [0, T]$, we have that x satisfies

$$x(t) = \int_0^t \eta(x(s)) \mathrm{d}s + H$$

and x^p satisfies

$$x^{p}(t) = (1-p) \int_{0}^{t} \eta_{p}(x^{p}(s)) \mathrm{d}s + H^{p}.$$

Remark 3.5 (On the relation between the concavity of η_p and η). Assume that $\eta_p(0) = 0$. Then, concavity of η_p implies that η is concave: If η_p is concave, then it is almost everywhere differentiable. For any x > 0 in which η_p is differentiable, we have for $y = x^{1/p}$

$$\eta(y) = \frac{1-p}{p} \eta_p(y^p) y^{1-p} \text{ and } \eta'(y) = \frac{1-p}{p} \left(p \eta'_p(y^p) + (1-p) \eta_p(y^p) y^{-p} \right).$$

Due to η_p being concave and $\eta_p(0) = 0$, we have that $z \mapsto \frac{\eta_p(z)}{z}$ is non-increasing. In particular, η is almost everywhere differentiable and η' is non-increasing (on its domain). As concavity of η_p implies, that η_p (and hence also η) is locally Lipschitz continuous, we have that η is absolutely continuous. Together, this implies that η is concave.

However, concavity of η does not imply that η_p is concave: For example $\eta(x) = x \arctan(1/x)$ is concave (due to $\eta''(x) = -2(x^2+1)^{-2} < 0$) and $\eta_{1/2}(x) = x \arctan(1/x^2)$ is not concave (as $\eta''_{1/2}(x) = 2x(x^4-3)(x^4+1)^{-2}$).

Remark 3.6 (Well-definedness of the upper bounds). In the deterministic Bihari-LaSalle inequality Lemma 1.1 the assumption $G(H) + A(t) \in \text{domain}(G^{-1})$ is needed. In Theorem 3.1 we do not need a corresponding assumption, because this is automatically satisfied if η or η_p is concave: We have $\text{domain}(G^{-1}) = \text{range}(G) = (\lim_{\varepsilon \to 0} G(\varepsilon), \lim_{x \to \infty} G(x))$. Hence, it suffices to show $\lim_{x \to \infty} G(x) = \infty$. Concavity of η implies that there exists some K > 0 such that $\eta(u) \leq Ku$ for all $u \in [c, \infty)$, and hence

$$\lim_{x \to \infty} G(x) = \int_c^\infty \frac{\mathrm{d}u}{\eta(u)} \ge \int_c^\infty \frac{\mathrm{d}u}{Ku} = +\infty.$$

Due to (14) a similar argument implies $\lim_{x\to\infty} G(x) = \infty$ if η_p is concave.

Remark 3.7 (Comparison of bounds in the cases $\mathcal{A}_{no \sup}$ and \mathcal{A}_{\sup}). Recall that Assumption $\mathcal{A}_{no \sup}$ is a special case of Assumption \mathcal{A}_{\sup} . The bound given by Theorem 3.1 b) is indeed better than the bound of Theorem 3.1 a). This can be seen as follows: Under the assumptions of Theorem 3.1 a) we show for all $h > 0, x \ge 0$

$$\alpha_1 G^{-1}(G(h) + x) \le G^{-1}(G(\alpha_1 h) + \beta x)$$
(21)

holds true. Fix some h > 0. Define for all $x \ge 0$:

$$f(x) := \alpha_1^p \big(G^{-1}(G(h) + x) \big)^p = \alpha_1^p (\tilde{G}_p^{-1}(\tilde{G}_p(h^p) + (1 - p)x)),$$

$$g(x) := \big(G^{-1}(G(\alpha_1 h) + \beta x) \big)^p = \tilde{G}_p^{-1} (\tilde{G}_p(\alpha_1^p h^p) + (1 - p)\beta x).$$

Here, we used (14) and (15). Note that $f(0) = \alpha_1^p h^p = g(0)$. Furthermore, we have $\alpha_1^p = \beta = (1-p)^{-1}$, $\alpha_1^{-p} \in (0,1)$ and

$$f'(x) = (1-p)\alpha_1^p \frac{1}{\tilde{G}'_p(\alpha_1^{-p}f(x))} = \eta_p(\alpha_1^{-p}f(x))$$
$$g'(x) = (1-p)\beta \frac{1}{\tilde{G}'_p(g(x))} = \eta_p(g(x)).$$

For concave η_p the ODEs $y' = \eta_p(\alpha_1^{-p}y)$ and $y' = \eta_p(y)$ have unique solutions for y(0) > 0. Therefore, the assumption that η_p is non-decreasing implies that $f(x) \leq g(x)$ for all $x \geq 0$. Taking the *p*-th root implies the claim.

3.2 Estimates for concave η and random A

In this section we extend the results of the previous subsection to predictable integrators A. Note that we may not expect in general estimates of the type

$$||X_T^*||_p \le c_1 ||G^{-1} (G(c_2 H_T) + A_T)||_p$$

to hold, where c_1 and c_2 are constants that only depend on $p \in (0, 1)$. This type of estimate fails to hold true even for constant H, $\eta(x) \equiv x$ and assumption $\mathcal{A}_{no \text{ sup}}$, see Example 6.1 in the appendix. Due to the estimates known for the linear case $\eta(x) \equiv x$ (see e.g. [12, Corollary 5.4.] and the references therein), we conjecture that estimates of the form

$$\|X_t^* (G^{-1}(G(c_3 H) + A_T))^{-1}\|_p \le c_4,$$
(22)

(where G^{-1} denotes the inverse of G and $(...)^{-1}$ the reciprocal) for some constants c_3 and c_4 that only depend on $p \in (0, 1)$, might hold true for constant $H_t \equiv H$ and Assumption $\mathcal{A}_{no \sup}$ (and similarly for Assumption \mathcal{A}_{\sup}).

Using Theorem 3.1 we prove a slightly weaker estimate which is presumably not sharp.

Corollary 3.8 (A stochastic Bihari-LaSalle inequality for concave η and random A). Let (X, A, H, M)and η satisfy Assumption \mathcal{A}_{sup} (see Definition 2.1) assume that $\eta_p(x) := \frac{p}{1-p}\eta(x^{1/p})x^{1-1/p}$ is concave and non-decreasing. Let t > 0.

a) If $\mathbb{E}[H_t^p] < \infty$ and either H is predictable or M has no negative jumps, then

$$\mathbb{E}_{\mathcal{F}_0}[\left(G^{-1}(G(\alpha_1\alpha_2 \| H_t \|_{p,\mathcal{F}_0}) + \beta A_t)\right)^{-q} (X_t^*)^p] \le \frac{q}{q-p} (\alpha_1\alpha_2 \| H_t \|_{p,\mathcal{F}_0})^{p-q}$$

holds for all $p \in (0,1)$, and q > p. In particular, by an application of Hölder's inequality we also have

$$\|X_t^*\|_{p/2,\mathcal{F}_0} \le \left(\frac{q}{q-p}(\alpha_1\alpha_2\|H_t\|_{p,\mathcal{F}_0})^{p-q}\right)^{1/p} \mathbb{E}_{\mathcal{F}_0}[\left(G^{-1}(G(\alpha_1\alpha_2\|H_t\|_{p,\mathcal{F}_0}) + \beta A_t)\right)^q]^{1/p}.$$

b) If $\mathbb{E}[H_t] < \infty$ then

$$\mathbb{E}_{\mathcal{F}_0}[\left(G^{-1}(G(\alpha_1 \| H_t \|_{1,\mathcal{F}_0}) + \beta A_t)\right)^{-q} (X_t^*)^p] \le \frac{q}{q-p} (\alpha_1 \| H_t \|_{1,\mathcal{F}_0})^{p-q}$$

holds for all $p \in (0,1)$, and q > p. In particular, we also have

$$\|X_t^*\|_{p/2,\mathcal{F}_0} \le \left(\frac{q}{q-p}(\alpha_1 \|H_t\|_{1,\mathcal{F}_0})^{p-q}\right)^{1/p} \mathbb{E}_{\mathcal{F}_0}[\left(G^{-1}(G(\alpha_1 \|H_t\|_{1,\mathcal{F}_0}) + \beta A_t)\right)^q]^{1/p}.$$

If we assume the stronger assumption \mathcal{A}_{nosup} then we may replace β by 1 in the estimates above.

Moreover, under the stronger assumption $\mathcal{A}_{no \sup}$ we obtain:

Corollary 3.9 (A stochastic Bihari-LaSalle inequality for concave η and random A for $\mathcal{A}_{no \sup}$). Let (X, A, H, M) satisfy Assumption $\mathcal{A}_{no \sup}$ (see Definition 2.2) and assume that η is concave. Then, for all $t \geq 0, R > 0, w > 0, u > 0$ we have

$$\mathbb{P}_{\mathcal{F}_0}[X_t^* > u] \leq \begin{cases} \frac{G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_t \wedge w]) + R)}{u} + \mathbb{P}_{\mathcal{F}_0}[H_t \ge w] + \mathbb{P}_{\mathcal{F}_0}[A_t > R] & \text{if } H \text{ is predictable and } \eta \text{ is concave} \\ \frac{G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_t]) + R)}{u} + \mathbb{P}_{\mathcal{F}_0}[A_t > R] & \text{if } \mathbb{E}[H_t] < \infty \text{ and } \eta \text{ is concave.} \end{cases}$$

Corollary 3.9 does not hold under the weaker assumption \mathcal{A}_{sup} , see Remark 3.3.

3.3 Estimates for general η and random A

Now we study upper bounds of X without imposing concavity or convexity assumptions on η . Whilst we do not obtain bounds for $||X_T^*||_p$ in this case, we do observe the same qualitative behavior as in the deterministic case.

Remark 3.10 (Qualitative behavior of the deterministic Bihari-LaSalle inequality). Let x, H, A, η and G be as in Lemma 1.1.

- a) Assume $\int_0^{\varepsilon} \frac{du}{\eta(u)} = +\infty$ for all $\varepsilon > 0$ (Osgood condition) and assume that (7) already holds when H is replaced by 0. The assumption on η implies $\lim_{\varepsilon \to 0} G(\varepsilon) = -\infty$, and hence for small enough $\varepsilon > 0$, we have that $G(\varepsilon) + A(t) \in \text{domain}(G^{-1})$. Hence, for any $\varepsilon > 0$ we may apply Lemma 1.1 to x, ε (instead of H), A and η and obtain $x(t) \leq \lim_{\varepsilon \to 0} G^{-1}(G(\varepsilon) + A(t)) = 0$.
- b) If $\int_1^\infty \frac{\mathrm{d}u}{\eta(u)} = +\infty$, then $[G(H), \infty) \subseteq \operatorname{range}(G) = \operatorname{domain}(G^{-1})$. This implies that $G(H) + A(t) \in \operatorname{domain}(G^{-1})$, so we may apply Lemma 1.1 to obtain the upper bound $x(t) \leq G^{-1}(G(H) + A(t))$.

Theorem 3.11 provides a stochastic version of Remark 3.10. Assertion d) can be seen as an extension of [38, Lemma 5.1] from continuous to càdlàg local martingales M.

Theorem 3.11 (Stochastic Bihari-LaSalle type estimates for \mathcal{A}_{sup}). Let (X, A, H, M) and η satisfy assumption \mathcal{A}_{sup} and assume $\lim_{x\to\infty} \eta(x) = +\infty$. Then the following assertions hold.

a) We have for all stopping times τ and all deterministic times $T \geq 0$

$$\mathbb{E}[G(X_{\tau \wedge T})] \le \mathbb{E}[A_{\tau \wedge T}] + G(\mathbb{E}[H_{\tau \wedge T}]),$$

where the terms take values in $[0, +\infty]$. For the definition of G see (11).

- b) If $\int_0^{\varepsilon} \frac{\mathrm{d}u}{n(u)} = +\infty$ for all $\varepsilon > 0$ and $H_T = 0$ then $X_T^* = 0$ \mathbb{P} -almost surely.
- c) Let $(X^{(n)}, A, H^{(n)}, M^{(n)})$ satisfy \mathcal{A}_{\sup} for each $n \in \mathbb{N}$ for some η which does not depend on n. If $\int_0^{\varepsilon} \frac{\mathrm{d}u}{\eta(u)} = +\infty$ for all $\varepsilon > 0$ and $\lim_{n \to \infty} \mathbb{E}[H_T^{(n)}] = 0$, then

$$\lim_{n \to \infty} \mathbb{P}[\sup_{t \in [0,T]} X_t^{(n)} > \delta] = 0 \quad for \ each \ \delta > 0.$$

d) If $X_t \ge c$ for all $t \in [0,T]$ for some T > 0 where c is the constant from the definition of G, then for any $p \in (0,1)$

$$\|G(X_T^*)\|_p \le \alpha_1 \alpha_2 \|A_T + G(\mathbb{E}[H_T])\|_p$$

where α_1, α_2 are constants that only depend on p (see (10)). If we assume in addition that $\int_1^\infty \frac{\mathrm{d}u}{\eta(u)} = +\infty, \mathbb{E}[A_T^p] < \infty$ and $\mathbb{E}[H_T] < \infty$ this guarantees that X_T^* is almost surely finite.

Theorem 3.11 can be applied to study existence and uniqueness of global solutions to path-dependent SDEs: In Section 4 we will use Theorem 3.11b) to prove the uniqueness of the solutions, Theorem 3.11c) will be applied to prove that the Euler approximates are indeed a Cauchy sequence. Moreover, Theorem 3.11d) is useful to prove the non-explosion of the solution.

4 Application: Existence and uniqueness of solutions to a Lévy driven path-dependent SDE

The first stochastic Gronwall inequality [38] (of the class of stochastic Gronwall inequalities related to the results of this paper) was developed to study stochastic functional differential equations: Stochastic Gronwall inequalities seem necessary to obtain the existence and uniqueness of local and global solutions under a one-sided Lipschitz condition. The results of [38] were extended to path-dependent SDEs driven by a more general integrator in [30]. In this section, using the stochastic Bihari-LaSalle inequality Theorem 3.11, we obtain existence and uniqueness of global solutions to path-dependent SDEs under a one-sided *non-Lipschitz* condition.

Assume an underlying filtered probability space $(\Omega, \mathcal{F}, \mathbb{P}, (\mathcal{F}_t)_{t\geq 0})$ satisfying the usual conditions. Let L be a \mathbb{R}^d -valued càdlàg Lévy process with bounded jumps and its Lévy-Itô decomposition given by

$$L_t = bt + \sigma B_t + \int_{|\xi| \le c} \xi \tilde{N}(t, \mathrm{d}\xi) \qquad \forall t \ge 0$$

where $b \in \mathbb{R}^d$, $\sigma \in \mathbb{R}^{d \times m}$, B an m-dimensional Brownian motion, N an independent Poisson random measure on $\mathbb{R}^+ \times (\mathbb{R}^d - \{0\})$ with Lévy measure ν and c > 0 some constant. We denote by \tilde{N} the corresponding compensated Poisson random measure. For details, see for example [3, p. 126]. Let $|\cdot|_F$ denote the Frobenius norm on $\mathbb{R}^{d \times m}$. Define $U := \{\xi \in \mathbb{R}^d \mid 0 < |\xi| \le c\}$ and set $\mathcal{U} := \mathcal{B}(U)$, where $\mathcal{B}(U)$ denotes the Borel σ -algebra on U.

We study the path-dependent SDE with random coefficients driven by L:

$$\begin{cases} dX_t = f(t, X) dt + \int_{|\xi| \le c} g(t, X, \xi) \tilde{N}(dt, d\xi) + h(t, X) dB_t \\ X_t = z_t, \quad t \in [-r, 0], \end{cases}$$

$$(23)$$

where r > 0 is some constant and the initial condition $(z_t)_{t \in [-r,0]}$ has càdlàg paths and is \mathcal{F}_0 measurable. Denote by \mathcal{P} the predictable σ -algebra on $[0,\infty) \times \Omega$. Recall that the Borel σ -field on the space Càdlàg $([-r,\infty); \mathbb{R}^d)$ induced by the Skorohod metric J_1 is strictly contained in the Borel σ -field generated by the uniform norm, see e.g. [9, Section 6, Setion 12] for more details. Whilst we work on the space Càdlàg $([-r,\infty); \mathbb{R}^d)$ predominantly with uniform convergence, we need the coefficients f, g, h to be measurable w.r.t. the Borel σ -field induced by convergence in Skorohod metric J_1 on compacts sets, which we denote by $\tilde{\mathcal{B}}(Càdlàg([-r,\infty); \mathbb{R}^d)))$. We need this stronger measurability assumption to ensure the measurability of the coefficients in (23).

Assume that the coefficients

$$f:([0,\infty)\times\Omega\times\operatorname{Càdlàg}([-r,\infty);\mathbb{R}^d), \mathcal{P}\otimes\mathcal{B}(\operatorname{Càdlàg}([-r,\infty);\mathbb{R}^d))) \to (\mathbb{R}^d,\mathcal{B}(\mathbb{R}^d)),$$

$$g:([0,\infty)\times\Omega\times\operatorname{Càdlàg}([-r,\infty);\mathbb{R}^d)\times U, \mathcal{P}\otimes\tilde{\mathcal{B}}(\operatorname{Càdlàg}([-r,\infty);\mathbb{R}^d)))\otimes\mathcal{U} \to (\mathbb{R}^d,\mathcal{B}(\mathbb{R}^d)),$$

$$h:([0,\infty)\times\Omega\times\operatorname{Càdlàg}([-r,\infty);\mathbb{R}^d), \mathcal{P}\otimes\tilde{\mathcal{B}}(\operatorname{Càdlàg}([-r,\infty);\mathbb{R}^d))) \to (\mathbb{R}^{d\times m},\mathcal{B}(\mathbb{R}^{d\times m}))$$

are measurable mappings. For every $t \in [0, \infty)$, $\omega \in \Omega$, $\xi \in U$ assume that $f(t, \omega, x)$, $g(t, \omega, x, \xi)$ and $h(t, \omega, x)$ only depend on the path segment $x(s), s \in [-r, t)$. We denote by f(t, x), $g(t, x, \xi)$ and h(t, x) the corresponding random variables.

Assumption 4.1. Let $(L_t^R)_{t\geq 0}$ and $(\tilde{K}_t^R)_{t\geq 0}$ for all R > 0 and $(K_t)_{t\geq 0}$ be non-negative, jointly measurable and adapted stochastic processes, such that for all $t\geq 0$ the quantities $\mathbb{E}[\int_0^t L_s^R ds]$, $\mathbb{E}[\int_0^t \tilde{K}_s^R ds]$ and $\mathbb{E}[\int_0^t K_s ds]$ are finite. Assume that for all $\omega \in \Omega$, for all $x, y \in \text{Càdlàg}([-r, \infty); \mathbb{R}^d)$ and for all $t \geq 0$:

(C1) for $\sup_{s \in [-r,t]} |x(s)|, \sup_{s \in [-r,t]} |y(s)| \le R$

(C2)

$$2\langle x(t^{-}) - y(t^{-}), f(t, \omega, x) - f(t, \omega, y) \rangle + \int_{U} |g(t, \omega, x, \xi) - g(t, \omega, y, \xi)|^{2} \nu(d\xi) + |h(t, \omega, x) - h(t, \omega, y)|_{F}^{2} \leq L_{t}^{R}(\omega)\eta_{1}(\sup_{s \in [-r, t]} |x(s) - y(s)|^{2}),$$

$$2\langle x(t^{-}), f(t, \omega, x) \rangle + \int_{U} |g(t, \omega, x, \xi)|^{2} \nu(d\xi) + |h(t, \omega, x)|_{F}^{2} \leq K_{t}(\omega)\eta_{2}(1 + \sup_{s \in [-r, t]} |x(s)|^{2}),$$

- (C3) $x \mapsto f(t, \omega, x)$ as a function from Càdlàg $([-r, \infty); \mathbb{R}^d)$ (endowed with the topology induced by uniform convergence on compact sets) to \mathbb{R}^d is continuous,
- (C4) for $\sup_{s \in [-r,t]} |x(s)| \le R$

$$|f(t,\omega,x)| + \int_U |g(t,\omega,x,\xi)|^2 \nu(\mathrm{d}\xi) + |h(t,\omega,x)|_F^2 \leq \tilde{K}_t^R(\omega)$$

(C5) $\mathbb{E}[\sup_{s\in[-r,0]}|z_s|^2]<\infty,$

where $\eta_1, \eta_2 : [0, \infty) \to [0, \infty)$ are non-decreasing continuous functions with $\eta_i(x) > 0$ for all x > 0, i = 1, 2. Define

$$G_i(x) := \int_1^x \frac{\mathrm{d}u}{\eta_i(u)}, \qquad \forall x > 0, i = 1, 2.$$

Assume:

$$\int_0^\varepsilon \frac{\mathrm{d}u}{\eta_1(u)} = +\infty \quad \forall \varepsilon > 0 \qquad \text{i.e. } \lim_{\varepsilon \searrow 0} G_1(\varepsilon) = -\infty,$$
$$\int_1^\infty \frac{\mathrm{d}u}{\eta_2(u)} = +\infty \qquad \qquad \text{i.e. } \lim_{x \to \infty} G_2(x) = +\infty.$$

Remark 4.2. The assumption $\lim_{\varepsilon \searrow 0} G_1(\varepsilon) = -\infty$ implies that $\lim_{\varepsilon \searrow 0} \eta_1(\varepsilon) = 0$. Hence, (C1) and (C3) imply that for any fixed $\omega \in \Omega$ and $t \ge 0$ we have that the mappings

$$\begin{aligned} \text{Càdlàg}([-r,\infty);\mathbb{R}^d) &\to L^2(U,\mathcal{U},\nu), \qquad x \mapsto g(t,\omega,x,\xi), \\ \text{Càdlàg}([-r,\infty);\mathbb{R}^d) &\to \mathbb{R}^{d \times m}, \qquad x \mapsto h(t,\omega,x) \end{aligned}$$

are continuous (with respect to topology induced by uniform convergence on compact sets).

The following theorem is a nonlinear extension of [30, Theorem 3.3]: We study an SDE driven by a less general integrator than [30], but we have weaker assumptions on the coefficients, as we allow in (C1) and (C2) of Assumption 4.1 nonlinear upper bounds η_1 and η_2 . We also impose slightly weaker integrability assumptions on the coefficients. Our proof of existence and uniqueness of global solutions is similar to that of [30] except that we use a stochastic Bihari-LaSalle inequality (Theorem 3.11) instead of a stochastic Gronwall inequality. In contrast to [38] our SDE has càdlàg paths and we have a nonlinear monotonicity condition (C1).

Corollary 4.3 (Existence and uniqueness of global of solutions). Assume Assumption 4.1 holds. Then the SDE (23) has a unique strong global solution.

The following example satisfies the assumptions of Corollary 4.3 but does not seem to be covered by the results in the existing literature. It is similar to [30, Example 4.1].

Example 4.4. Consider the following 1-dimensional path-dependent (or functional) SDE

$$dX_t = \left[-2\text{sgn}(X_{t^-})|X_{t^-}|^{1/2} + \sup_{t-1 \le s < t} |X_s|\right] dt + \left[|X_{t^-}|^{3/4} + \sup_{t-1 \le s < t} |X_s| + \left(|X_{t^-}| \wedge \frac{1}{e}\right)\log\left(\frac{1}{|X_{t^-}| \wedge \frac{1}{e}}\right)\right] dW_t + dN_t.$$

where B is a standard Brownian motion and N a compensated standard Poisson process.

Due to the term $-(|X_{t-}| \wedge \frac{1}{e}) \log (|X_{t-}| \wedge \frac{1}{e})$ the diffusion coefficient does not satisfy a one-sided Lipschitz assumption, hence the results of [38] and [30] cannot be applied. Moreover, due to the pathdependence or the jump term dN_t the results of [20] cannot be applied.

As mentioned in the introduction, existence and uniqueness results could be proven without stochastic Bihari-LaSalle inequalities (using the BDG inequality instead) if the inequality of (C1) is replaced by the stronger assumption

$$2\langle x(t^{-}) - y(t^{-}), f(t,\omega,x) - f(t,\omega,y) \rangle \leq L_{t}^{R}(\omega)\eta_{1}(\sup_{s\in[-r,t]}|x(s) - y(s)|^{2}) \text{ and } \int_{U}|g(t,\omega,x,\xi) - g(t,\omega,y,\xi)|^{2}\nu(\mathrm{d}\xi) + |h(t,\omega,x) - h(t,\omega,y)|_{F}^{2} \leq L_{t}^{R}(\omega)\eta_{1}(\sup_{s\in[-r,t]}|x(s) - y(s)|^{2}).$$

Due to the term $|X_{t-}|^{3/4}$ in the diffusion coefficient, this strengthened assumption is not satisfied by the diffusion coefficient g for suitable η_1 .

It is easily seen that the coefficients satisfy assumptions (C2), (C3) and (C4) of Assumption 4.1. We show that also (C1) is satisfied: We have for 0 < x < y:

$$|y^{3/4} - x^{3/4}|^2 = (3/4)^2 \left(\int_x^y s^{-1/4} \mathrm{d}x\right)^2 \le (y-x) \int_x^y s^{-2/4} \mathrm{d}s \le 2(y-x)(y^{1/2} - x^{1/2})$$

This implies for all $x, y \in Càdlàg([-r, \infty); \mathbb{R}^d)$ that

$$2\langle y(t^{-}) - x(t^{-}), -2\mathrm{sgn}(y(t^{-}))|y(t^{-})|^{1/2} + 2\mathrm{sgn}(x(t^{-}))|x(t^{-})|^{1/2} \rangle + 2||y(t^{-})|^{3/4} - |x(t^{-})|^{3/4}|^{2} \le 0.$$

Define $\varphi(x) := y \log(1/y) - x \log(1/x) - (y-x) \log(1/(y-x))$ for $x \in [0, y]$. Noting that φ is convex and $\varphi(0) = \varphi(y) = 0$, implies $g \leq 0$ and in particular for all $0 \leq x \leq y \leq 1/e$

$$|y\log(1/y) - x\log(1/x)| \le |y - x|\log(1/|y - x|).$$

Hence, choosing $\eta_1(x) = K(x + (x \wedge e^{-1}) \log \left(\frac{1}{x \wedge e^{-1}}\right))$ for some K > 0 large enough implies that the coefficients indeed satisfy (C1).

5 Proofs

5.1 A Lenglart type estimate

We will prove the stochastic Bihari-LaSalle inequalities using the following lemma which is [12, Lemma 4.5]. It is an extension of an inequality Lenglart inequality, see [23, Théorème I] or [30, Lemma 2.2 (ii)]:

Lemma 5.1 (Lenglart type estimates). Fix some T > 0 and $p \in (0,1)$ and let (X, A, H, M) satisfy Assumption \mathcal{A}_{sup} or Assumption $\mathcal{A}_{no sup}$. We consider the following 6 cases, which arise from combining \mathcal{A}_{sup} or $\mathcal{A}_{no sup}$ with one of the following three assumptions:

- a) H is predictable and $\mathbb{E}[H_T^p] < \infty$,
- b) M has no negative jumps and $\mathbb{E}[H^p_T] < \infty$,

c)
$$\mathbb{E}[H_T] < \infty$$
.

Fix arbitrary $u, \lambda > 0$ and set:

$$\tau_u := \tau := \inf\{s \ge 0 \mid H_s \ge \lambda u\}, \qquad \sigma_u := \sigma := \inf\{s \ge 0 \mid X_s > u\},$$

where $\inf \emptyset := +\infty$. Then, the following estimate holds true for all $t \in [0, T]$:

$$\mathbb{1}_{\{X_t^* > u\}} u \le X_{t \land \sigma_u} \land u \le I_t^{L,u} + M_t^{L,u} + H_t^{L,u}.$$
(24)

Here $(I_t^{L,u})_{t\geq 0}$ is a non-decreasing process containing the integral term from (16) and (17) respectively with an additional indicator function

$$I_t^L := I_t^{L,u} := \begin{cases} \int_{(0,t]} \eta(X_{s^-}^*) \mathbb{1}_{\{X_{s^-}^* \le u\}} \mathrm{d}A_s & \text{for } \mathcal{A}_{\mathrm{sup}}, \\\\ \int_{(0,t]} \eta(X_{s^-}) \mathbb{1}_{\{X_{s^-}^* \le u\}} \mathrm{d}A_s & \text{for } \mathcal{A}_{no \, \mathrm{sup}}, \end{cases}$$

the process $(M_t^{L,u})_{t>0}$ is a local martingale with càdlàg paths starting in 0 defined by

$$M_t^L := M_t^{L,u} := \begin{cases} \lim_{n \to \infty} M_{t \wedge \tau^{(n)} \wedge \sigma} & \text{if } H \text{ is predictable and } \mathbb{E}[H_T^p] < \infty, \\ M_{t \wedge \tau \wedge \sigma} & \text{if } M \text{ has no negative jumps and } \mathbb{E}[H_T^p] < \infty, \\ \tilde{M}_{t \wedge \sigma} \mathbbm{1}_{\{\mathbb{E}_{\mathcal{F}_0}[H_T] \le u\}} & \text{if } \mathbb{E}[H_T] < \infty, \end{cases}$$

(where $\tau^{(n)}$ denotes an announcing sequence of τ and $\tilde{M}_t := M_t + \mathbb{E}[H_T \mid F_t] - \mathbb{E}_{\mathcal{F}_0}[H_T]$ for $t \in [0,T]$), and $(H_t^{L,u})_{t\geq 0}$ is a non-decreasing process depending on H:

$$H_t^L := H_t^{L,u} := \begin{cases} H_t \wedge (\lambda u) + u \mathbb{1}_{\{H_t \ge \lambda u\}} & \text{if } H \text{ is predictable and } \mathbb{E}[H_T^p] < \infty, \\ H_t \wedge (\lambda u) + u \mathbb{1}_{\{H_t \ge \lambda u\}} & \text{if } M \text{ has no negative jumps and } \mathbb{E}[H_T^p] < \infty, \\ \mathbb{E}_{\mathcal{F}_0}[H_T] \wedge u & \text{if } \mathbb{E}[H_T] < \infty. \end{cases}$$

We will frequently use the formulas of the subsequent remark.

Remark 5.2 (Calculation of Z^p , $p \in (0,1)$). Let Z be a non-negative random variable and $p \in (0,1)$. Then Z^p can be calculated using the three formulas below.

$$Z^{p} = p \int_{0}^{\infty} \mathbb{1}_{\{Z \ge u\}} u^{p-1} du$$

$$Z^{p} = (1-p) \int_{0}^{\infty} Z \mathbb{1}_{\{Z \le u\}} u^{p-2} du$$

$$Z^{p} = p(1-p) \int_{0}^{\infty} (Z \wedge u) u^{p-2} du$$
(25)

The third equality follows e.g. by using the first and second equality. In particular, we also have $Z^{p-1} = (1-p) \int_0^\infty \mathbb{1}_{\{Z \le u\}} u^{p-2} du$ for Z > 0.

The third equality of (25) holds true for general concave functions, which is due to Burkholder [10, Theorem 20.1, p.38-39], see also Pratelli [32, p. 403]:

Remark 5.3. [Calculation of F(Z) for concave F] Let $F \colon \mathbb{R} \to \mathbb{R}$ be a concave function and let F' its left-hand derivative. Then, for any non-negative random variable Z we have

$$F(Z) = F(0) + ZF'(\infty) - \int_{[0,\infty)} (Z \wedge u) \mathrm{d}F'(u).$$

For the convenience of the reader we provide the proof: Recall that left-hand derivative F' of a concave function is non-increasing and left-continuous. By integration by parts (see e.g. [15, Theorem 21.67 (iv), p. 419]) we have

$$\int_{[0,\infty)} (Z \wedge u) dF'(u) = \int_{[0,Z]} u dF'(u) + Z \int_{[Z,\infty)} dF'(u)$$
$$= ZF'(Z+) - \int_{[0,Z]} F'(u) du + ZF'(\infty) - ZF'(Z+)$$
$$= -F(Z) + F(0) + ZF'(\infty).$$

The last equality can be seen by e.g. using that concave functions are absolutely continuous and almost everywhere differentiable.

Remark 5.4. In the proofs of the stochastic Bihari-LaSalle inequalities, we will assume $X \ge \varepsilon$ and $H \ge \varepsilon$ for some $\varepsilon > 0$ instead of $X \ge 0$ and $H \ge 0$. We do this to ensure that terms like $G(X_t)$ or $G(H_t)$ are well-defined and to ensure that we may apply the deterministic Bihari-LaSalle inequality, see Lemma 1.1. We may do this without loss of generality because we can add an arbitrary $\varepsilon > 0$ to (16) (or similarly (17)) and slightly weaken (16) (using that η is non-decreasing) to obtain for all $t \in [0, T]$:

$$(X_t + \varepsilon) \le \int_{(0,t]} \eta(X_{s^-}^* + \varepsilon) \mathrm{d}A_s + M_t + (H_t + \varepsilon) \qquad \mathbb{P}\text{-a.s.}$$

Proving the assertions of the theorems for the processes $(X_t + \varepsilon)_{t \ge 0}$, $(A_t)_{t \ge 0}$, $(M_t)_{t \ge 0}$ and $(H_t + \varepsilon)_{t \ge 0}$ and then taking the limit $\varepsilon \to 0$ will imply the assertions for the general case $X \ge 0$, $H \ge 0$.

5.2 Proofs for concave η (Theorem 3.1)

Proof of Theorem 3.1, a). The sharpness of the constants follows from [12, Theorem 3.5 and Theorem 3.7]. Assume w.l.o.g. that $X \ge \varepsilon$ and $H \ge \varepsilon$ for some $\varepsilon > 0$ (see Remark 5.4). Furthermore, we assume w.l.o.g. that M is a martingale. This implies, that $(M_t^{L,u})_{t\in[0,T]}$ from Lemma 5.1 is a martingale for any u > 0.

Fix some $t \in [0, T]$. Lemma 5.1 implies (under the assumption \mathcal{A}_{sup}) for all $u > 0, \lambda > 0$:

$$\mathbb{1}_{\{X_t^* > u\}} u \le \int_{(0,t]} \eta(X_{s^-}^*) \mathbb{1}_{\{X_{s^-}^* \le u\}} dA_s + M_t^{L,u} + H_t^{L,u}$$

using the notation $M^{L,u}$ and $H^{L,u}$ from Lemma 5.1. Fix some $\hat{u} > 0$. We multiply the equation above with $pu^{p-2}\mathbb{1}_{\{u < \hat{u}\}}$, take the conditional expectation given \mathcal{F}_0 and integrate over u. This implies (using Fubini and $\{X_t^* > u\} \cap \{\hat{u} > u\} = \{X_t^* \land \hat{u} > u\}$):

$$\int_{0}^{\infty} \mathbb{P}_{\mathcal{F}_{0}}[X_{t}^{*} \wedge \hat{u} > u] p u^{p-1} \mathrm{d}u \leq \mathbb{E}_{\mathcal{F}_{0}} \left[\int_{(0,t]} \eta(X_{s^{-}}^{*}) \int_{0}^{\hat{u}} \mathbb{1}_{\{X_{s^{-}}^{*} \leq u\}} p u^{p-2} \mathrm{d}u \mathrm{d}A_{s} \right] \\
+ \int_{0}^{\hat{u}} \mathbb{E}_{\mathcal{F}_{0}}[H_{t}^{L,u}] p u^{p-2} \mathrm{d}u.$$
(26)

Hence, by Remark 5.2 inequality (26) can be slightly weakened to

$$\mathbb{E}_{\mathcal{F}_{0}}[(X_{t}^{*} \wedge \hat{u})^{p}] = \int_{0}^{\infty} \mathbb{P}_{\mathcal{F}_{0}}[X_{t}^{*} \wedge \hat{u} > u]pu^{p-1} du
\leq \mathbb{E}_{\mathcal{F}_{0}}\left[\int_{(0,t]} \eta(X_{s^{-}}^{*} \wedge \hat{u}) \frac{p}{1-p} ((X_{s^{-}}^{*} \wedge \hat{u})^{p-1} - \hat{u}^{p-1}) dA_{s}\right]
+ \int_{0}^{\hat{u}} \mathbb{E}_{\mathcal{F}_{0}}[H_{t}^{L,u}]pu^{p-2} du
\leq \frac{p}{1-p} \mathbb{E}_{\mathcal{F}_{0}}\left[\int_{(0,t]} \eta(X_{s^{-}}^{*} \wedge \hat{u})(X_{s^{-}}^{*} \wedge \hat{u})^{p-1} dA_{s}\right] + \int_{0}^{\infty} \mathbb{E}_{\mathcal{F}_{0}}[H_{t}^{L,u}]pu^{p-2} du.$$
(27)

If $\mathbb{E}[H_T^p] < \infty$ and either H is predictable or $\Delta M \ge 0$, we have (choosing $\lambda = p$ and applying Remark 5.2 and recalling $\alpha_1 = (1-p)^{-1/p}$, $\alpha_2 = p^{-1}$):

$$\int_{0}^{\infty} H_{t}^{L,u} p u^{p-2} du = \int_{0}^{\infty} \left(H_{t} \wedge (\lambda u) + u \mathbb{1}_{\{H_{t}\lambda^{-1} \ge u\}} \right) p u^{p-2} du$$

$$= \lambda \int_{0}^{\infty} \left((H_{t}\lambda^{-1}) \wedge u \right) p u^{p-2} du + \int_{0}^{\infty} \mathbb{1}_{\{H_{t}\lambda^{-1} \ge u\}} p u^{p-1} du$$

$$= \lambda (1-p)^{-1} (H_{t}\lambda^{-1})^{p} + (H_{t}\lambda^{-1})^{p}$$

$$= (p(1-p)^{-1} + 1) p^{-p} H_{t}^{p}$$

$$= \alpha_{1}^{p} \alpha_{2}^{p} H_{t}^{p}.$$
(28)

If $\mathbb{E}[H_T] < \infty$, we have:

$$\int_{0}^{\infty} H_{t}^{L,u} p u^{p-2} \mathrm{d}u = \int_{0}^{\infty} \left(\mathbb{E}_{\mathcal{F}_{0}}[H_{T}] \wedge u \right) p u^{p-2} \mathrm{d}u = (1-p)^{-1} \mathbb{E}_{\mathcal{F}_{0}}[H_{T}]^{p} = \alpha_{1}^{p} \mathbb{E}_{\mathcal{F}_{0}}[H_{T}]^{p}.$$
(29)

Furthermore, by assumption, $\eta_p(x) \equiv \frac{p}{1-p}\eta(x^{1/p})x^{1-1/p}$ is concave and A is deterministic. Therefore, (27) implies by Jensen's inequality for all $t \in [0, T]$:

$$\mathbb{E}_{\mathcal{F}_{0}}[(X_{t}^{*} \wedge \hat{u})^{p}] \leq \mathbb{E}_{\mathcal{F}_{0}}\left[\int_{(0,t]} \eta_{p}\left((X_{s^{-}}^{*} \wedge \hat{u})^{p}\right) \mathrm{d}A_{s}\right] + \int_{0}^{\infty} \mathbb{E}_{\mathcal{F}_{0}}[H_{t}^{L,u}]pu^{p-2}\mathrm{d}u$$

$$\leq \int_{(0,t]} \eta_{p}(\mathbb{E}_{\mathcal{F}_{0}}[(X_{s^{-}}^{*} \wedge \hat{u})^{p}])\mathrm{d}A_{s}$$

$$+ \begin{cases} \alpha_{1}^{p}\alpha_{2}^{p}\mathbb{E}_{\mathcal{F}_{0}}[H_{T}^{p}] & \text{if } H \text{ is predictable or } \Delta M \geq 0, \\ \alpha_{1}^{p}\mathbb{E}_{\mathcal{F}_{0}}[H_{T}]^{p} & \text{if } \mathbb{E}[H_{T}] < \infty. \end{cases}$$
(30)

Since $H \ge \varepsilon$, η_p is non-decreasing and $s \mapsto \mathbb{E}_{\mathcal{F}_0}[(X_s^* \land \hat{u})^p]$ is càdlàg and takes values in $[0, \infty)$, we may apply the deterministic Bihari-LaSalle inequality (see Lemma 1.1) to the previous inequality. Recall the following definition and its properties (see (13) and (14)):

$$\tilde{G}_p(x) := \int_{c^p}^x \frac{\mathrm{d}u}{\eta_p(u)}, \quad \text{satisfying } \tilde{G}_p(x) = (1-p)G(x^{1/p}), \quad \tilde{G}_p^{-1}(x) = \left(G^{-1}\left(\frac{x}{1-p}\right)\right)^p.$$

For e.g. the case that H is predictable or M has non-negative jumps the deterministic Bihari-LaSalle inequality implies for all $\hat{u}>0$

$$\begin{split} \|X_T^* \wedge \hat{u}\|_{p,\mathcal{F}_0} &\leq \left\{ \tilde{G}_p^{-1} \left(\tilde{G}_p \left(\alpha_1^p \alpha_2^p \mathbb{E}_{\mathcal{F}_0} [H_T^p] \right) + A_T \right) \right\}^{1/p} \\ &= \left\{ \tilde{G}_p^{-1} \left((1-p) G \left(\alpha_1 \alpha_2 \|H_T\|_{p,\mathcal{F}_0} \right) + A_T \right) \right\}^{1/p} \\ &= G^{-1} \left(G \left(\alpha_1 \alpha_2 \|H_T\|_{p,\mathcal{F}_0} \right) + \beta A_T \right). \end{split}$$

Taking the limit $\hat{u} \to \infty$ implies the claim. A nearly identical argument implies the claim for also for the case $\mathbb{E}[H_T] < \infty$.

Proof of Theorem 3.1, b). The sharpness of the constants follows from [12, Theorem 3.7]. We assume w.l.o.g. that $X \ge \varepsilon$ and $H \ge \varepsilon$ for some $\varepsilon > 0$ (see Remark 5.4) and that M is a martingale. As before, we define the following stopping times for some fixed $u, \lambda > 0$:

$$\tau_u := \inf\{s \ge 0 \mid H_s \ge \lambda u\}, \qquad \sigma_u := \inf\{s \ge 0 \mid X_s > u\}.$$

We first prove the assertion for the case $\mathbb{E}[H_T] < \infty$, which is related to the proof of [40, Lemma 3.7]. **Proof for** $\mathbb{E}[H_T] < \infty$: As η is concave and H is non-decreasing, we have for all $t \in [0, T]$:

$$\mathbb{E}_{\mathcal{F}_{0}}[X_{t \wedge \sigma_{u}} \wedge u] \leq \mathbb{E}_{\mathcal{F}_{0}}[\int_{(0, t \wedge \sigma_{u}]} \eta(X_{s^{-}}) \mathrm{d}A_{s}] + \mathbb{E}_{\mathcal{F}_{0}}[H_{T}]$$
$$\leq \mathbb{E}_{\mathcal{F}_{0}}[\int_{(0, t]} \eta(X_{s^{-} \wedge \sigma_{u}} \wedge u) \mathrm{d}A_{s}] + \mathbb{E}_{\mathcal{F}_{0}}[H_{T}]$$
$$\leq \int_{(0, t]} \eta(\mathbb{E}_{\mathcal{F}_{0}}[X_{s^{-} \wedge \sigma_{u}} \wedge u]) \mathrm{d}A_{s} + \mathbb{E}_{\mathcal{F}_{0}}[H_{T}]$$

Recall that X is a non-negative process. Therefore, dominated convergence implies that $t \mapsto \mathbb{E}[X(t \wedge \sigma_u) \wedge u]$ is càdlàg. Thus, we may apply the deterministic Bihari-LaSalle inequality Lemma 1.1, which gives:

$$\mathbb{P}_{\mathcal{F}_0}[X_T^* > u] u \le \mathbb{E}_{\mathcal{F}_0}[X_{T \wedge \sigma_u} \wedge u] \le G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_T]) + A_T) =: \delta.$$

This implies the assertion (19). In particular, we have $\mathbb{P}_{\mathcal{F}_0}[X_T^* > u]u \leq \delta \wedge u$, and hence by Remark 5.2

$$\begin{split} \|X_T^*\|_{p,\mathcal{F}_0}^p &= p \int_0^\infty \mathbb{P}[X_T^* > u] u^{p-1} \mathrm{d}u \le p \int_0^\infty (\delta \wedge u) u^{p-2} \mathrm{d}u \\ &= \frac{1}{1-p} \delta^p = \frac{1}{1-p} G^{-1} (G(\mathbb{E}_{\mathcal{F}_0}[H_T]) + A_T)^p, \end{split}$$

which implies the claim (18) (recalling $\alpha_1 = (1-p)^{-1/p}$).

Proof for predictable H and $\Delta M \ge 0$: Assume that $\mathbb{E}[H_T^p] < \infty$ and that either H is predictable or $\Delta M \ge 0$. As we assumed w.l.o.g. that M is a martingale, also $(M_t^{L,u})_{t\in[0,T]}$ from Lemma 5.1 is a martingale for any u > 0. By Lemma 5.1 (using the case \mathcal{A}_{nosup}) we have for all $t \in [0,T]$

$$\mathbb{E}_{\mathcal{F}_0}[X_{t \wedge \sigma_u} \wedge u] \leq \mathbb{E}_{\mathcal{F}_0}[\int_{(0,t]} \eta(X_{s^-}) \mathbb{1}_{\{X_{s^-}^* \leq u\}} \mathrm{d}A_s] \\ + \lambda \mathbb{E}_{\mathcal{F}_0}[H_t \lambda^{-1} \wedge u] + u \mathbb{P}_{\mathcal{F}_0}[H_t \lambda^{-1} \geq u]$$

Integrating w.r.t to $p(1-p)u^{p-2}du$, using Remark 5.2 and choosing $\lambda = p$ (see also (28)) gives:

$$y(t) := p(1-p) \int_0^\infty \mathbb{E}_{\mathcal{F}_0} [X_{t \wedge \sigma_u} \wedge u] u^{p-2} \mathrm{d}u$$
$$\leq p \mathbb{E}_{\mathcal{F}_0} [\int_{(0,t]} \eta(X_{s^-}) (X_{s^-}^*)^{p-1} \mathrm{d}A_s] + p^{-p} \mathbb{E}_{\mathcal{F}_0} [H_t^p].$$

Using $p \in (0, 1)$, we have $(X_{s^-}^*)^{p-1} \leq X_{s^-}^{p-1}$. This implies (using the definitions $\eta_p(x) = \frac{p}{1-p}\eta(x^{1/p})x^{1-1/p}$, $\alpha_2 = p^{-1}$) for all $t \in [0, T]$

$$y(t) \le (1-p) \int_{(0,t]} \mathbb{E}_{\mathcal{F}_0}[\eta_p(X_{s^-}^p)] \mathrm{d}A_s + \alpha_2^p \mathbb{E}_{\mathcal{F}_0}[H_t^p].$$

Note, that we have by Remark 5.2 $\mathbb{E}[X_t^p] = p(1-p) \int_0^\infty \mathbb{E}[X_t \wedge u] u^{p-2} du \le y(t) \le \mathbb{E}[(X_t^*)^p]$. In particular, $y(t) < \infty$ for all $t \in [0, T]$ due to Theorem 3.1a). Hence, due to η_p being concave and non-decreasing and $\mathbb{E}[X_t^p] \le y(t)$, we obtain:

$$y(t) \le (1-p) \int_{(0,t]} \eta_p(\mathbb{E}[X_{s^-}^p]) dA_s + \alpha_2^p \mathbb{E}_{\mathcal{F}_0}[H_t^p],$$

$$\le (1-p) \int_{(0,t]} \eta_p(y(s^-)) dA_s + \alpha_2^p \mathbb{E}_{\mathcal{F}_0}[H_t^p],$$

which implies by Lemma 1.1, $\tilde{G}_p(x) = (1-p)G(x^{1/p})$ and $\tilde{G}_p^{-1}(x) = (G^{-1}(\frac{x}{1-p}))^p$ (see (14)):

$$y(T) \le \tilde{G}_p^{-1}(\tilde{G}_p(\alpha_2^p \mathbb{E}_{\mathcal{F}_0}[H_T^p]) + (1-p)A_T) = G^{-1}(G(\alpha_2 ||H_T||_{p,\mathcal{F}_0}) + A_T)^p$$

which implies by $\mathbb{P}_{\mathcal{F}_0}[X_T^* > u] \leq \mathbb{E}_{\mathcal{F}_0}[X_{T \wedge \sigma_u} \wedge u]u^{-1}$

$$\|X_{T}^{*}\|_{p,\mathcal{F}_{0}}^{p} = \int_{0}^{\infty} p\mathbb{P}[X_{T}^{*} > u]u^{p-1} du$$

$$\leq p \int_{0}^{\infty} \mathbb{E}_{\mathcal{F}_{0}}[X_{T \wedge \sigma_{u}} \wedge u]u^{p-2} du$$

$$= \frac{1}{1-p}y(T)$$

$$\leq \frac{1}{1-p}G^{-1}(G(\alpha_{2}\|H_{T}\|_{p,\mathcal{F}_{0}}) + A_{T}))^{p}$$
(31)

which implies the assertion (18).

Now we prove (19) for predictable H. Fix some u > 0, w > 0 and t > 0 and choose $\lambda > 0$ s.t. $\lambda u = w$. Due to predictability of H there exists a localizing sequence $\tau_u^{(n)}$ for the stopping time $\tau_u := \inf\{s \ge 0 \mid H_s \ge \lambda u\}$. Define $B := \{H_0 < \lambda u\}$ and note that $\mathbb{E}_{\mathcal{F}_0}[H_{\tau_u^{(n)} \wedge t} \mathbb{1}_B] < \infty$. We will now use that we have shown (19) already for the case that $\mathbb{E}[H_t] < \infty$: This gives that (19) holds for $(X^{\tau_u^{(n)}} \mathbb{1}_B, A, H^{\tau_u^{(n)}} \mathbb{1}_B, M^{\tau_u^{(n)}} \mathbb{1}_B)$ and η , i.e.

$$\mathbb{P}_{\mathcal{F}_0}[X_{t \wedge \tau_u^{(n)}}^* > u, H_0 < \lambda u] \le \frac{1}{u} G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_{t \wedge \tau_u^{(n)}}]\mathbb{1}_B) + A_t) \le \frac{1}{u} G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_t \wedge (\lambda u)]) + A_t).$$

Noting that $\{H_t < \lambda u\} \subseteq \{H_0 < \lambda u\}$ and that on $\{H_t < \lambda u\}$ we have $\lim_{n \to \infty} \tau_u^{(n)} = \tau_u > t$ gives:

$$\mathbb{P}_{\mathcal{F}_0}[X_t^* > u] \leq \sup_{n \in \mathbb{N}} \mathbb{P}_{\mathcal{F}_0}[X_{t \wedge \tau_u^{(n)}}^* > u, H_t < \lambda u] + \mathbb{P}_{\mathcal{F}_0}[H_t \ge \lambda u]$$
$$\leq \frac{1}{u} G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_t \wedge (\lambda u)]) + A_t) + \mathbb{P}_{\mathcal{F}_0}[H_t \ge \lambda u].$$

5.3 Proof for concave η and random A (Corollary 3.8, Corollary 3.9)

Proof of Corollary 3.8. We prove the claim for the case of Assumption \mathcal{A}_{sup} and predictable H. The other cases follow by the same argument. We prove the assertion by a time change [12, Lemma 4.8]. Fix some T > 0. We may assume w.l.o.g. that the continuous part of A is strictly increasing and $A_{\infty}^c = \infty$, for details see [12, Remark 4.10]. Let $(\tilde{X}, \tilde{A}, \tilde{H}, \tilde{M})$ denote the family of processes we obtain by applying [12, Lemma 6.8] to $((X_{t\wedge T})_{t\geq 0}, A, (H_{t\wedge T})_{t\geq 0}, (M_{t\wedge T})_{t\geq 0})$. Due to $\tilde{A}_t = t$ being deterministic, we may apply Theorem 3.1, yielding

$$\mathbb{E}_{\mathcal{F}_0}[(\tilde{X}_t^*)^p] \le G^{-1}(G(\alpha_1\alpha_2 \|\tilde{H}_t\|_{p,\mathcal{F}_0}) + \beta t)^p \qquad \forall t \ge 0.$$

Note that for any $t \ge 0$ we have

$$\mathbb{E}_{\mathcal{F}_0}[\mathbb{1}_{\{A_T \le t\}}(X_T^*)^p] \le \mathbb{E}_{\mathcal{F}_0}[\sup_{r:A_r \le t} (X_{r \wedge T})^p] = \mathbb{E}_{\mathcal{F}_0}[\sup_{r:A_r \le t} (\tilde{X}_{A_r})^p] \le \mathbb{E}_{\mathcal{F}_0}[\sup_{s \le t} (\tilde{X}_s)^p] = \mathbb{E}_{\mathcal{F}_0}[(\tilde{X}_t^*)^p].$$

To simplify the notation in the following calculations, define

$$f: [0,\infty) \to [\alpha_1 \alpha_2 \| H_T \|_{p,\mathcal{F}_0}, \infty), \qquad x \mapsto G^{-1}(G(\alpha_1 \alpha_2 \| H_T \|_{p,\mathcal{F}_0}) + \beta x)$$

noting that concavity of η implies that $[G(\alpha_1 \alpha_2 || H_T ||_{p, \mathcal{F}_0}), \infty) \subseteq \text{domain}(G^{-1})$, hence implying that the map is well-defined. Moreover, f is strictly increasing and bijective. The two inequalities above yield together

$$\mathbb{E}_{\mathcal{F}_0}[\mathbb{1}_{\{A_T \le t\}}(X_T^*)^p] \le G^{-1}(G(\alpha_1 \alpha_2 \|H_T\|_{p,\mathcal{F}_0}) + \beta t)^p = f(t)^p$$
(32)

We have for 0 , <math>p < 1:

$$\mathbb{E}_{\mathcal{F}_{0}}[f(A_{T})^{-q}(X_{T}^{*})^{p}] = \mathbb{E}_{\mathcal{F}_{0}}[q\int_{f(A_{T})}^{\infty} x^{-q-1}dx(X_{T}^{*})^{p}]$$

$$= q\int_{\alpha_{1}\alpha_{2}}^{\infty} \mathbb{E}_{\mathcal{F}_{0}}[\mathbb{1}_{\{f(A_{T})\leq x\}}(X_{T}^{*})^{p}]x^{-q-1}dx$$

$$\stackrel{(32)}{\leq} q\int_{\alpha_{1}\alpha_{2}}^{\infty} f(f^{-1}(x))^{p}x^{-q-1}dx$$

$$= q\int_{\alpha_{1}\alpha_{2}}^{\infty} \mathbb{E}_{\mathcal{F}_{0}}[\mathbb{1}_{\{f(A_{T})\leq x\}}(X_{T}^{*})^{p}]x^{-q-1}dx$$

$$\leq \frac{q}{q-p}(\alpha_{1}\alpha_{2}||H_{T}||_{p,\mathcal{F}_{0}})^{p-q}.$$

This implies the first assertion. We obtain the upper bound for $||X_t^*||_{p/2,\mathcal{F}_0}$ by rewriting

$$\mathbb{E}_{\mathcal{F}_0}[(X_t^*)^{p/2}] = \mathbb{E}_{\mathcal{F}_0}\left[(X_t^*)^{p/2} \left(G^{-1} (G(\alpha_1 \alpha_2 \| H_t \|_{p, \mathcal{F}_0}) + \beta A_t) \right)^{-q/2} \cdot \left(G^{-1} (G(\alpha_1 \alpha_2 \| H_t \|_{p, \mathcal{F}_0}) + \beta A_t) \right)^{q/2} \right].$$

and then applying Hölder's inequality.

and then applying Hölder's inequality.

Proof of Corollary 3.9. We prove the claim for the case of $\mathbb{E}[H_T] < \infty$, the assertion can be shown by the same argument for predictable H. As in the proof of Corollary 3.8 we prove the assertion by a time change [12, Lemma 4.8]. Fix some T > 0. We may assume w.l.o.g. that the continuous part of A is strictly increasing and $A_{\infty}^{c} = \infty$, for details see [12, Remark 4.10]. Let $(\tilde{X}, \tilde{A}, \tilde{H}, \tilde{M})$ denote the family of processes we obtain by applying [12, Lemma 6.8] to $((X_{t\wedge T})_{t\geq 0}, A, (H_{t\wedge T})_{t\geq 0}, (M_{t\wedge T})_{t\geq 0})$. Due to $\hat{A}_t = t$ being deterministic, we may apply Theorem 3.1 $(\hat{X}, \hat{A}, \hat{H}, \hat{M})$, yielding for all R > 0, u > 0

$$\mathbb{P}_{\mathcal{F}_0}[\tilde{X}_R^* > u] \le \frac{G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[\tilde{H}_R]) + \tilde{A}_R)}{u} \le \frac{G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_T]) + R)}{u}$$

This implies using $\{X_T^* > u, A_T \leq R\} \subseteq \{\tilde{X}_{A_T}^* > u, A_T \leq R\} \subseteq \{\tilde{X}_R^* > u\}$

$$\mathbb{P}_{\mathcal{F}_0}[X_T^* > u] \le \mathbb{P}_{\mathcal{F}_0}[X_T^* > u, A_T \le R] + \mathbb{P}_{\mathcal{F}_0}[A_T > R] \le \frac{G^{-1}(G(\mathbb{E}_{\mathcal{F}_0}[H_T]) + R)}{u} + \mathbb{P}_{\mathcal{F}_0}[A_T > R].$$

Proof for general η (Theorem 3.11) 5.4

We prove Theorem 3.11a) by combining Lemma 5.1 with Remark 5.3, assertions b), c) and d) follow from a).

Proof of Theorem 3.11. **Proof of a):** Since for any stopping time τ the family of processes $(X_{\cdot\wedge\tau}, A_{\cdot\wedge\tau}, H_{\cdot\wedge\tau}, M_{\cdot\wedge\tau})$ also satisfies assumption \mathcal{A}_{sup} , it suffices to prove the claim for $\tau = T$. We may assume that $\mathbb{E}[H_T] < \infty$ and $\mathbb{E}[A_T] < \infty$ since otherwise the assertion is trivial. Lemma 5.1 (using Assumption \mathcal{A}_{sup} and $E[H_T] < \infty$ implies for any $t \in [0, T]$

$$\mathbb{E}[X_t \wedge u] \le \mathbb{E}[X_{t \wedge \sigma_u} \wedge u] \le \mathbb{E}[\int_{(0,t]} \eta(X_{s^-}^*) \mathbb{1}_{\{X_{s^-}^* \le u\}} \mathrm{d}A_s] + \mathbb{E}[H_T] \wedge u.$$
(33)

Here, we used that by Fatou's lemma $\mathbb{E}[M_T^{L,u}] \leq 0$. Set $F(x) := G(x + \varepsilon) - G(\varepsilon)$ which is concave and satisfies F(0) = 0 and $F'(\infty) = 0$. Combining Remark 5.3 with (33) implies by Fubini's theorem:

$$\mathbb{E}[F(X_T)] = -\mathbb{E}\left[\int_{[0,\infty)} X_T \wedge u \mathrm{d}F'(u)\right] \le -\mathbb{E}\left[\int_{(0,T]} \eta(X_{s^-}^*) \int_{X_{s^-}^*}^\infty \mathrm{d}F'(u) \mathrm{d}A_s\right] + F(\mathbb{E}[H_T])$$
$$\le \mathbb{E}[A_T] + F(\mathbb{E}[H_T]).$$

Hence, this implies for all $\varepsilon > 0$

$$\mathbb{E}[G(X_T + \varepsilon)] \le \mathbb{E}[A_T] + G(\mathbb{E}[H_T] + \varepsilon).$$
(34)

Letting $\varepsilon \to 0$ gives by monotone convergence

$$\mathbb{E}[G(X_T)] \le \mathbb{E}[A_T] + G(\mathbb{E}[H_T])$$

Proof of c): Let $\delta > 0$ be arbitrary. Set $\tau^{(n)} := \inf\{t \ge 0 \mid X_t^{(n)} > \delta\} \wedge T$ using the definition $\inf \emptyset := \infty$. Moreover, set $P_{\delta}^{(n)} := \mathbb{P}[\sup_{t \in [0,T]} X_t^{(n)} > \delta]$. Recall that X is right-continuous and G is non-decreasing. Furthermore, in the proof of a) (see (34)) we also proved $\mathbb{E}[G(X_{\tau \wedge T} + \varepsilon)] \le \mathbb{E}[A_{\tau \wedge T}] + G(\mathbb{E}[H_{\tau \wedge T}] + \varepsilon)$ for all stopping times τ and all $\varepsilon > 0$. Combining this yields:

$$P_{\delta}^{(n)}G(\varepsilon+\delta) + (1-P_{\delta}^{(n)})G(\varepsilon) \leq \mathbb{E}[G(X_{\tau^{(n)}\wedge T}^{(n)}+\varepsilon)] \leq \mathbb{E}[A_T] + G(E[H_T^{(n)}]+\varepsilon).$$

Rearranging the terms implies by continuity of G for any $\varepsilon > 0$

$$\limsup_{n \to \infty} P(n)_{\delta} \le \limsup_{n \to \infty} \frac{\mathbb{E}[A_T] + G(E[H_T^{(n)}] + \varepsilon) - G(\varepsilon)}{G(\varepsilon + \delta) - G(\varepsilon)} = \frac{\mathbb{E}[A_T]}{G(\varepsilon + \delta) - G(\varepsilon)}$$

Taking the limit $\varepsilon \to 0$ and using the assumption $\lim_{\varepsilon \to 0} G(\varepsilon) = -\infty$ implies the claim $\lim_{\varepsilon \to \infty} P_{\delta}^{(n)} = 0$.

Proof of b): This follows immediately from c) by choosing $(X^{(n)}, A, H^{(n)}, M^{(n)}) := (X, A, H, M)$ for all n.

Proof of d): By assumption we have $X_t \ge c$ and $G(x) = \int_c^x \frac{\mathrm{d}u}{\eta(u)}$ for all x > 0, which implies that $G(X_t) \ge 0$ for all t. Hence, applying Lenglart's inequality (see e.g. [23, Corollaire II] or [30, Lemma 2.2 (ii)]) to assertion a) yields $\|\sup_{t \in [0,T]} G(X_t)\|_p \le \alpha_1 \alpha_2 \|A_T + G(\mathbb{E}[H_T])\|_p$.

5.5 Proof of the application (Corollary 4.3)

Proof of Corollary 4.3. We may assume w.l.o.g. that $\lim_{x\to\infty} \eta_1(x) = +\infty$ and $\lim_{x\to\infty} \eta_2(x) = +\infty$. **Proof of uniqueness of global solutions:** Let $(X_t)_{t\in[0,T]}$ and $(Y_t)_{t\in[0,T]}$ be two strong solutions of (23) up to some deterministic time T > 0 with the same initial condition $(z_t)_{t\in[-r,0]}$. For the uniqueness of global strong solutions it suffices to prove $\mathbb{P}[\sup_{t\in[0,T]} |X_t - Y_t|^2 = 0] = 1$.

Define

$$\tau(R) := \inf\{t \in [0, T] \mid |X_t| > R \text{ or } |Y_t| > R\}$$

where we set $\inf \emptyset := T$. Then, by Itô's formula we have for $t \in [0, T]$:

$$|X_{t\wedge\tau(R)} - Y_{t\wedge\tau(R)}|^{2} = \int_{0}^{t\wedge\tau(R)} 2\langle X_{s^{-}} - Y_{s^{-}}, f(s, X) - f(s, Y) \rangle ds + \int_{0}^{t\wedge\tau(R)} |h(s, X) - h(s, Y)|_{F}^{2} ds + \int_{(0, t\wedge\tau(R)]} \int_{U} |g(s, X, \xi) - g(s, Y, \xi)|^{2} \nu(d\xi) ds + M_{t\wedge\tau(R)}$$
(35)
$$\stackrel{(C1)}{\leq} \int_{0}^{t\wedge\tau(R)} L_{s}^{R} \eta_{1}(\sup_{u\in[0,s]} |X_{u} - Y_{u}|^{2}) ds + M_{t\wedge\tau(R)} \leq \int_{0}^{t} L_{s}^{R} \eta_{1}(\sup_{u\in[0,s]} |X_{u\wedge\tau(R)} - Y_{u\wedge\tau(R)}|^{2}) ds + M_{t\wedge\tau(R)},$$

where the local martingale M is given by

$$\begin{split} M_t &:= \int_0^t 2\langle X_{s^-} - Y_{s^-}, (h(s,X) - h(s,Y)) \mathrm{d}B_s \rangle \\ &+ \int_{(0,t]} \int_U 2\langle X_{s^-} - Y_{s^-}, g(s,X,\xi) - g(s,Y,\xi) \rangle \tilde{N}(\mathrm{d}s,\mathrm{d}\xi) \\ &+ \int_{(0,t]} \int_U |g(s,X,\xi) - g(s,Y,\xi)|^2 \tilde{N}(\mathrm{d}s,\mathrm{d}\xi). \end{split}$$

Applying Theorem 3.11b) to $(|X_{.\wedge\tau(R)} - Y_{.\wedge\tau(R)}|^2, \int_0^{\cdot} L_s^R ds, 0, M)$ and η_1 implies $\mathbb{P}[\sup_{t \in [0,T]} |X_{t\wedge\tau(R)} - Y_{t\wedge\tau(R)}|^2 = 0] = 1$ for all T > 0, R > 0 which yields the claim.

Proof of the existence of strong global solutions: We show the existence of a solution using the Euler method, see e.g. [25], [38], [30]. We define for $n \in \mathbb{N}$ the Euler approximates as

$$\begin{aligned} X_{t}^{(n)} &:= z_{t} & \text{for } t \in [-r, 0] \\ X_{t}^{(n)} &:= X_{\frac{k}{n}}^{(n)} + \int_{(\frac{k}{n}, t]} f(s, X_{\cdot \wedge \frac{k}{n}}^{(n)}) \mathrm{d}s + \int_{(\frac{k}{n}, t]} \int_{U} g(s, X_{\cdot \wedge \frac{k}{n}}^{(n)}, \xi) \tilde{N}(\mathrm{d}s, \mathrm{d}\xi) \\ &+ \int_{(\frac{k}{n}, t]} h(s, X_{\cdot \wedge \frac{k}{n}}^{(n)}) \mathrm{d}B_{s} & \text{for } t \in (\frac{k}{n}, \frac{k+1}{n}], k \in \mathbb{N}_{0} \end{aligned}$$
(36)

The Euler approximate $X^{(n)}$ has càdlàg paths and is adapted. In particular, the stochastic integrals are well-defined. Define $k(n,t) := \frac{k}{n}$ for $t \in (\frac{k}{n}, \frac{k+1}{n}]$, $k \in \mathbb{N}_0$ and k(n,t) := t for $t \in [-r, 0]$. With the

notation k(n,t) (36) can be rewritten as

$$X_{t}^{(n)} = z_{0} + \int_{0}^{t} f(s, X_{\cdot \wedge k(n,s)}^{(n)}) ds + \int_{(0,t]} \int_{U} g(s, X_{\cdot \wedge k(n,s)}^{(n)}, \xi) \tilde{N}(ds, d\xi) + \int_{0}^{t} h(s, X_{\cdot \wedge k(n,s)}^{(n)}) dB_{s} \quad \text{for all } t \ge 0.$$
(37)

Define the remainder

$$p_t^{(n)} := X_{k(n,t)}^{(n)} - X_t^{(n)}, \qquad t \in [-r,\infty).$$

The stochastic process $p^{(n)}$ is adapted and $p_{k/n^+}^{(n)} = 0$ for every $k \in \mathbb{N}_0$. Note that $t \mapsto X_{k(n,t)}^{(n)}$, $t \ge 0$ is càglàd and $X_t^{(n)}$ is càdlàg. Therefore, $p_t^{(n)}$ is neither càglàd nor càdlàg. Fix $T \ge 0$ and define for R > 0 the stopping times

$$\tau_R^{(n)} := \left(\inf\left\{t \ge 0 \mid |X_t^{(n)}| > \frac{R}{3}\right\} \land T\right) \mathbb{1}_{\{R > 3\sup_{s \in [-r,0]} |z_s|\}}.$$

Then

$$|p_t^{(n)}| \le \frac{2R}{3}, \quad |X_t^{(n)}| \le \frac{R}{3}, \quad t \in (0, \tau_R^{(n)}).$$
 (38)

On $\{R > 3 \sup_{s \in [-r,0]} |z_s|\}$ the inequalities extend to $[-r, \tau_R^{(n)})$ and we have $\tau_R^{(n)} > 0$ (due to the right-continuity of $X^{(n)}$).

As T was arbitrary, it suffices to prove the existence of a strong solution on [0, T]. The existence proof is done in the following steps:

- a) For every $t \ge 0$, we have $\mathbb{1}_{(0,\tau_R^{(n)})}(t) \sup_{u \in (k(n,t),t]} |p_u^{(n)}| \to 0$ in probability as $n \to \infty$.
- b)
 $$\begin{split} \left\|G_2(1+\sup_{u\in[0,T]}|X_{u\wedge\tau_R^{(n)}}^{(n)}|^2)\right\|_{1/2} &\leq C(T,R,n) \text{ for some } C(T,R,n) \text{ satisfying}\\ &\lim_{n\to\infty}C(T,R,n)=\tilde{C}(T) \text{ for all } R>0. \end{split}$$
- c) $\lim_{R \to \infty} \limsup_{n \to \infty} \mathbb{P}[\tau_R^{(n)} < T] = 0.$
- d) $\lim_{n,m\to\infty} \mathbb{P}\left[\sup_{t\in[0,T]} |X_t^{(n)} X_t^{(m)}| > \varepsilon\right] = 0$ for all $\varepsilon > 0$.
- e) There exists a càdlàg adapted process $(X_t)_{t\geq 0}$ such that $\lim_{n\to\infty} \mathbb{P}[\sup_{t\in[0,T]} |X_t^{(n)} X_t| > \varepsilon] = 0$ for all $\varepsilon > 0$ and X is a strong solution of equation (23) on [0,T].

We only prove the steps b), c), d): The remaining steps are proven as in [30, Theorem 3.3]. **Proof of b):** Using Itô's formula, we have for $t \in [0, T]$:

$$\begin{split} |X_t^{(n)}|^2 &= |z_0|^2 + \int_0^t 2\langle X_{s^-}^{(n)}, f(s, X_{\cdot \wedge k(n,s)}^{(n)}) \rangle \mathrm{d}s + \int_{(0,t]} \int_U |g(s, X_{\cdot \wedge k(n,s)}^{(n)}, \xi)|^2 \nu(\mathrm{d}\xi) \mathrm{d}s \\ &+ \int_0^t |h(s, X_{\cdot \wedge k(n,s)}^{(n)})|_F^2 \mathrm{d}s + M_t^{(n)}, \end{split}$$

where $M^{(n)}$ is a local martingale defined by

$$\begin{split} M_t^{(n)} &:= \int_{(0,t]} \int_U 2\langle X_{s^-}^{(n)}, g(s, X_{\cdot \wedge k(n,s)}^{(n)}, \xi) \rangle \tilde{N}(\mathrm{d}s, \mathrm{d}\xi) \\ &+ \int_{(0,t]} \int_U |g(s, X_{\cdot \wedge k(n,s)}^{(n)}, \xi)|^2 \tilde{N}(\mathrm{d}s, \mathrm{d}\xi) \\ &+ \int_0^t 2\langle X_{s^-}^{(n)}, h(s, X_{\cdot \wedge k(n,s)}^{(n)}) \mathrm{d}B_s \rangle. \end{split}$$

Using (C2) and (C4), we have (using $\lim_{r \nearrow s} X_{r \land k(n,s)}^{(n)} = X_{k(n,s)}^{(n)} = \lim_{r \nearrow s} X_{k(n,r)}^{(n)}$ for s > 0):

$$|X_{t\wedge\tau_{R}^{(n)}}^{(n)}|^{2} \stackrel{(C2)}{\leq} |z_{0}|^{2} + \int_{0}^{t\wedge\tau_{R}^{(n)}} 2\langle X_{s^{-}}^{(n)} - \lim_{r \neq s} X_{r\wedge k(n,s)}^{(n)}, f(s, X_{\cdot\wedge k(n,s)}^{(n)}) \rangle ds + \int_{0}^{t\wedge\tau_{R}^{(n)}} K_{s} \eta_{2} (1 + \sup_{u \in [-r,s]} |X_{u\wedge k(n,s)}^{(n)}|) ds + M_{t}^{(n)} \stackrel{(C4)}{\leq} |z_{0}|^{2} + \int_{0}^{t\wedge\tau_{R}^{(n)}} 2|p_{s^{-}}^{(n)}| \tilde{K}_{s}^{R} ds + \int_{0}^{t} K_{s} \eta_{2} (1 + \sup_{u \in [-r,0]} |z_{u}|^{2} + \sup_{u \in [0,s]} |X_{u\wedge\tau_{R}^{(n)}}^{(n)}|^{2}) ds + M_{t\wedge\tau_{R}^{(n)}}^{(n)}$$
(39)

Set

$$H_t^{n,R} := 1 + \sup_{u \in [-r,0]} |z_u|^2 + |z_0|^2 + \int_0^{t \wedge \tau_R^{(n)}} 2|p_{s^-}^{(n)}|\tilde{K}_R(s) \mathrm{d}s$$

For almost every $s \in [0, T]$ we have (38), a) and dominated convergence

$$0 \le \limsup_{n \to \infty} \mathbb{E}[|p_{s^{-}}^{(n)}| \mathbbm{1}_{\{s < t \land \tau_{R}^{(n)}\}} \tilde{K}_{s}^{R}] \le \limsup_{n \to \infty} \mathbb{E}[\sup_{u \in (k(n,s),s]} |p_{u}^{(n)}| \mathbbm{1}_{\{s < t \land \tau_{R}^{(n)}\}} \tilde{K}_{s}^{R}] \stackrel{a)}{=} 0.$$

Therefore, by dominated convergence, we have for all $t \in [0, T]$:

$$\lim_{n \to \infty} \mathbb{E} \left[\int_0^{t \wedge \tau_R^{(n)}} 2|p_{s^-}^{(n)}| \tilde{K}_s^R \mathrm{d}s \right] = \lim_{n \to \infty} \int_0^t 2\mathbb{E} [|p_{s^-}^{(n)}| \mathbbm{1}_{\{s < t \wedge \tau_R^{(n)}\}} \tilde{K}_s^R] \mathrm{d}s = 0.$$

In particular, by (C5) this implies

$$\lim_{n \to \infty} \mathbb{E}[H_T^{n,R}] = 1 + \mathbb{E}[\sup_{u \in [-r,0]} |z_u|^2] + \mathbb{E}[|z_0|^2] < \infty.$$
(40)

We apply Theorem 3.11d) to $Y_t := 1 + \sup_{u \in [-r,0]} |z_u|^2 + |X_{t \wedge \tau_R^{(n)} \wedge T}^{(n)}|^2$, $t \ge 0$, which satisfies due to (39) $Y_t \le \int_0^t K_s \eta_2(Y_{s^-}^*) ds + M_{t \wedge \tau_R^{(n)} \wedge T}^{(n)} + H_{t \wedge \tau_R^{(n)} \wedge T}^{n,R}$. This yields (noting that $\alpha_1 \alpha_2 = 8$ for p = 1/2):

$$\left\| G_{2}(1 + \sup_{t \in [0,T]} |X_{t \wedge \tau_{R}^{(n)}}^{(n)}|^{2}) \right\|_{1/2} \leq \left\| G_{2}(Y_{T}^{*}) \right\|_{1/2}$$

$$\leq 8 \left\| \int_{0}^{T} K_{t} dt + G_{2}(\mathbb{E}[H_{T}^{n,R}]) \right\|_{1/2} =: C(T, R, n).$$

$$(41)$$

Combining (40) with (41) implies by continuity of G_2 for

$$\tilde{C}(T) := 8 \left\| \int_0^T K_t dt + G_2 (1 + \mathbb{E}[\sup_{u \in [-r,0]} |z_u|^2] + \mathbb{E}[|z_0|^2]) \right\|_{1/2}$$

the assertion.

Proof of c): We have due to G_2 being non-decreasing, $G_2(x) \ge 0$ for $x \ge 1$ and $\lim_{x\to\infty} G_2(x) = +\infty$:

$$\begin{split} \limsup_{R \to \infty} \limsup_{n \to \infty} \mathbb{P}[\tau_R^{(n)} < T] &\leq \limsup_{R \to \infty} \limsup_{n \to \infty} \mathbb{P}[\sup_{t \in [0, \tau_R^{(n)} \wedge T]} |X_t^{(n)}| \geq R/3] + \lim_{R \to \infty} \mathbb{P}[\sup_{s \in [-r, 0]} |z_s| \geq R/3] \\ &\stackrel{(C5)}{\leq} \limsup_{R \to \infty} \limsup_{n \to \infty} \frac{\mathbb{E}[G_2(1 + \sup_{t \in [0, \tau_R^{(n)} \wedge T]} |X_t^{(n)}|^2)^{1/2}]}{G_2(1 + (R/3)^2)^{1/2}} \\ &\stackrel{b)}{\leq} \limsup_{R \to \infty} \limsup_{n \to \infty} \frac{C(T, R, n)^{1/2}}{G_2(1 + (R/3)^2)^{1/2}} \\ &\stackrel{b)}{\leq} \limsup_{R \to \infty} \frac{\tilde{C}(T)^{1/2}}{G_2(1 + (R/3)^2)^{1/2}} \\ &= 0. \end{split}$$

Proof of d): Set $\tau_R^{n,m} := \tau_R^{(n)} \wedge \tau_R^{(m)}$. Itô's formula gives for $t \in [0,T]$:

$$\begin{split} |X_t^{(n)} - X_t^{(m)}|^2 &= \int_0^t 2\langle X_{s^-}^{(n)} - X_{s^-}^{(m)}, f(s, X_{\cdot \wedge k(n,s)}^{(n)}) - f(s, X_{\cdot \wedge k(m,s)}^{(m)}) \rangle \mathrm{d}s \\ &+ \int_{(0,t]} \int_U |g(s, X_{\cdot \wedge k(n,s)}^{(n)}, \xi) - g(s, X_{\cdot \wedge k(m,s)}^{(m)}, \xi)|^2 \nu(\mathrm{d}\xi) \mathrm{d}s \\ &+ \int_0^t |h(s, X_{\cdot \wedge k(n,s)}^{(n)}) - h(s, X_{\cdot \wedge k(m,s)}^{(m)})|_F^2 \mathrm{d}s + M_t^{n,m} \end{split}$$

where $(M_t^{n,m})_{t\geq 0}$ is a local martingale starting in 0. Using (C1) we obtain:

$$\begin{aligned} |X_{t\wedge\tau_{R}^{n,m}}^{(n)} - X_{t\wedge\tau_{R}^{n,m}}^{(m)}|^{2} &\stackrel{(C1)}{\leq} \int_{0}^{t\wedge\tau_{R}^{n,m}} L_{s}^{R} \eta_{1} \bigg(\sup_{u\in[-r,s]} |X_{u\wedge k(n,s)}^{(n)} - X_{u\wedge k(m,s)}^{(m)}|^{2} \bigg) \mathrm{d}s \\ &-2 \int_{0}^{t\wedge\tau_{R}^{n,m}} \langle p_{s^{-}}^{(n)} - p_{s^{-}}^{(m)}, f(s, X_{\cdot\wedge k(n,s)}^{(n)}) - f(s, X_{\cdot\wedge k(m,s)}^{(m)}) \rangle \mathrm{d}s + M_{t\wedge\tau_{R}^{n,m}}^{n,m}. \end{aligned}$$
(42)

To be able to apply Theorem 3.11, we need to compute $\sup_{u \in [-r,s]} |X_{u \wedge k(n,s)}^{(n)} - X_{u \wedge k(m,s)}^{(m)}|^2$. We have for $u \in (0,s]$:

$$X_{u \wedge k(n,s)} = \begin{cases} X_u^{(n)} & \text{for } u \in [0, k(n,s)] \\ X_{k(n,s)}^{(n)} = X_{k(n,u)}^{(n)} = p_u^{(n)} + X_u^{(n)} & \text{for } u \in (k(n,s),s] \\ = X_u^{(n)} + p_u^{(n)} \mathbb{1}_{\{u \in (k(n,s),s]\}}, \end{cases}$$

which yields

$$|X_{u\wedge k(n,s)}^{(n)} - X_{u\wedge k(m,s)}^{(m)}|^2 \le 2|X_u^{(n)} - X_u^{(m)}|^2 + 4|p_u^{(n)}|^2 \mathbb{1}_{\{u \in (k(n,s),s]\}} + 4|p_u^{(m)}|^2 \mathbb{1}_{\{u \in (k(m,s),s]\}}.$$

Using the notation

$$\begin{split} p_s^{n,m,R} &:= 4 \mathbbm{1}_{(0,\tau_R^{(n)})}(s) \sup_{u \in (k(n,s),s]} |p_u^{(n)}|^2 + 4 \mathbbm{1}_{(0,\tau_R^{(m)})}(s) \sup_{u \in (k(m,s),s]} |p_u^{(m)}|^2, \\ H_t^{n,m,R} &:= \int_0^t \mathbbm{1}_{(0,\tau_R^{n,m})}(s) 4(|p_{s^-}^{(n)}| + |p_{s^-}^{(m)}|) \tilde{K}_s^R \mathrm{d}s \\ &\quad + \int_0^{t \wedge \tau_R^{n,m}} L_s^R \eta_1 \bigg(2 \sup_{u \in [-r,s]} |X_{u \wedge \tau_R^{n,m}}^{(n)} - X_{u \wedge \tau_R^{n,m}}^{(m)}|^2 + p_s^{n,m,R} \bigg) \\ &\quad - L_s^R \eta_1 \bigg(2 \sup_{u \in [-r,s]} |X_{u \wedge \tau_R^{n,m}}^{(n)} - X_{u \wedge \tau_R^{n,m}}^{(m)}|^2 \bigg) \mathrm{d}s, \end{split}$$

we obtain from (42) using (C4)

$$|X_{t\wedge\tau_{R}^{n,m}}^{(n)} - X_{t\wedge\tau_{R}^{n,m}}^{(m)}|^{2} \stackrel{(C4)}{\leq} \int_{0}^{t} L_{s}^{R} \eta_{1} \left(2 \sup_{u \in [-r,s]} |X_{u\wedge\tau_{R}^{n,m}}^{(n)} - X_{u\wedge\tau_{R}^{n,m}}^{(m)}|^{2} \right) \mathrm{d}s + M_{t\wedge\tau_{R}^{n,m}}^{n,m} + H_{t}^{n,m,R}.$$

$$(43)$$

Note that due to (38) there exists a constant $\hat{C}(R) > 0$ that only depends on R such that

$$2\sup_{u\in[-r,s]}|X_{u\wedge\tau_R^{n,m}}^{(n)}-X_{u\wedge\tau_R^{n,m}}^{(m)}|^2\mathbb{1}_{\{s<\tau_R^{n,m}\}} \leq \hat{C}(R), \qquad p_s^{n,m,R} \leq \hat{C}(R).$$

Hence, by uniform continuity of η_1 on $[0, 2\hat{C}(R)]$ and a), for any fixed $s \in [0, t]$, we have

$$\eta_1 \left(2 \sup_{u \in [-r,s]} |X_{u \wedge \tau_R^{n,m}}^{(n)} - X_{u \wedge \tau_R^{n,m}}^{(m)}|^2 + p_s^{n,m,R} \right) - \eta_1 \left(2 \sup_{u \in [-r,s]} |X_{u \wedge \tau_R^{n,m}}^{(n)} - X_{u \wedge \tau_R^{n,m}}^{(m)}|^2 \right) \to 0$$

in probability for $m, n \to \infty$. Hence, the integrand of $H_t^{n,m,R}$ converges to 0 in probability for almost every $s \in [0, t]$. Therefore, by dominated convergence we have:

$$\limsup_{n,m\to\infty} \mathbb{E}[H_T^{n,m,R}] = 0$$

We multiply (43) by 2 and apply Theorem 3.11c) to

$$(2\sup_{s\in[0,t]}|X_{s\wedge\tau_R^{n,m}}^{(n)} - X_{s\wedge\tau_R^{n,m}}^{(m)}|^2, \ 2\int_0^t L_s^R \mathrm{d}s, \ 2H_t^{n,m,R}, \ 2M_{t\wedge\tau_R^{n,m}}^{n,m})$$

(This can be done by using that $\lim_{n,m\to\infty} a_{n,m} = a$ if and only if for all $(n_k)_k$, $(m_k)_k \subseteq \mathbb{N}$ with $\lim_{k\to\infty} n_k = \lim_{k\to\infty} m_k = \infty$ we have $\lim_{k\to\infty} a_{n_k,m_k} = a$.) We obtain that $\lim_{n,m\to\infty} \mathbb{P}[\sup_{t\in[0,\tau_R^{n,m}\wedge T]} |X_t^{(n)} - X_t^{(m)}| > a] = 0$ for any a > 0.

By c) we have:

$$\begin{split} &\limsup_{n,m\to\infty} \mathbb{P}[\sup_{t\in[0,T]} |X_t^{(n)} - X_t^{(m)}| > a] \\ &\leq \limsup_{R\to\infty} \limsup_{n,m\to\infty} \left(\mathbb{P}[T > \tau_R^{(n)}] + \mathbb{P}[T > \tau_R^{(m)}] + \mathbb{P}[\sup_{t\in[0,\tau_R^{n,m}\wedge T]} |X_t^{(n)} - X_t^{(m)}| > a] \right) \\ &= 0, \end{split}$$

which implies the claim.

6 Appendix

6.1 Proof of the (deterministic) Bihari-LaSalle inequality

Proof of Lemma 1.1. Denote by y(t) the right-hand side of (7), which is a non-decreasing right-continuous function. Define $t_{k,n} := kt2^{-n}$ for $k, n \in \mathbb{N}$. We obtain, using that η is non-decreasing

$$G(y(t)) - G(y(0)) = \lim_{n \to \infty} \sum_{k=1}^{2^n} \left[G(y(t_{k,n})) - G(y(t_{k-1,n})) \right]$$

$$= \lim_{n \to \infty} \sum_{k=1}^{2^n} \int_{y(t_{k-1,n})}^{y(t_{k,n})} \frac{\mathrm{d}u}{\eta(u)}$$

$$\leq \lim_{n \to \infty} \sum_{k=1}^{2^n} \frac{1}{\eta(y(t_{k-1,n}))} \left[(y(t_{k,n}) - y(t_{k-1,n})) \right]$$

$$\stackrel{*}{=} \int_{(0,t]} \frac{\mathrm{d}y(s)}{\eta(y(s^{-}))} \leq \int_{(0,t]} \frac{\mathrm{d}y(s)}{\eta(x(s^{-}))} = A(t).$$

We use the left-continuity of η in the equality (*). Rearranging the terms, noting that y(0) = H and applying G^{-1} (if possible) implies the assertion.

6.2 Counterexample: Random integrators A in Theorem 3.1

Let (X, A, H, M) and η satisfy Assumption $\mathcal{A}_{no \sup}$. The following counterexample shows: For random integrators A we may not expect in general estimates of the type

$$||X_T^*||_p \le c_1 ||G^{-1}(G(c_2H_T) + A_T)||_p$$

г		

to hold, where c_1 and c_2 are constants that only depend on $p \in (0, 1)$. This type of estimate fails to hold true even for constant H and $\eta(x) \equiv x$.

Example 6.1. For some fixed $p \in (0, 1)$ we will construct stochastic processes $X_{\gamma} = (X_{t,\gamma})_{t\geq 0}$, $A_{\gamma} = (A_{t,\gamma})_{t\geq 0}$ and $M_{\gamma} = (M_{t,\gamma})_{t\geq 0}$ depending on a parameter $\gamma \in [0, \infty)$, such that $(X_{\gamma}, A_{\gamma}, 1, M_{\gamma})$ satisfy $\mathcal{A}_{no \sup}$, the equality

$$X_{t,\gamma} = \int_0^t X_{s^-,\gamma} dA_{s,\gamma} + M_{t,\gamma} + 1, \qquad t \ge 0,$$
(44)

and

$$\lim_{n \to \infty} \frac{\|X_{T_n, \gamma_n}^*\|_p}{\|\mathrm{e}^{A_{T_n, \gamma_n}}\|_p} = \infty$$

for suitably chosen sequences $(\gamma_n)_{n \in \mathbb{N}}, (T_n)_{n \in \mathbb{N}} \subset (0, \infty).$

Choose $(\Omega, \mathcal{F}, \mathbb{P}) := ([0, 1], \mathcal{L}[0, 1], ds)$, $\mathcal{F}_t := \mathcal{N}$ for $t \in [0, 1)$ and $\mathcal{F}_t := \mathcal{F}$ for $t \ge 1$, where $\mathcal{L}[0, 1]$ denotes the Lebesgue σ -field on [0, 1] and \mathcal{N} denotes the σ -field generated by the Lebesgue null sets. We define the martingale by

$$\begin{split} M_{t,\gamma}(\omega) &:= \mathbb{1}_{[1,\infty)}(t)(\gamma \mathbb{1}_{[0,\frac{e}{e+\gamma}]}(\omega) - e\mathbb{1}_{(\frac{e}{e+\gamma},1]}(\omega)) \qquad \forall t \ge 0, \omega \in \Omega, \\ \tau_{\gamma}(\omega) &:= \infty \mathbb{1}_{[0,\frac{e}{e+\gamma}]}(\omega) + \mathbb{1}_{(\frac{e}{e+\gamma},1]}(\omega), \\ A_{t,\gamma} &:= t \wedge \tau_{\gamma}. \end{split}$$

It can be easily verified, that

$$X_{t,\gamma}(\omega) := \begin{cases} e^t & \forall t \in [0,1), \, \omega \in \Omega\\ e^{t-1}(e^1 + \gamma) & \forall t \in [1,\infty), \, \omega \in [0, \frac{e}{e+\gamma}]\\ 0 & \forall t \in [1,\infty), \, \omega \in (\frac{e}{e+\gamma}, 1]. \end{cases}$$

satisfies (44). This implies for $T \ge 1$:

$$\frac{\|X_{T,\gamma}^*\|_p^p}{\|\exp(A_{T,\gamma})\|_p^p} = \frac{e^{p(T-1)}(e+\gamma)^p \mathbb{P}\{[0,\frac{e}{e+\gamma}]\} + e^p \mathbb{P}\{(\frac{e}{e+\gamma},1]\}}{e^{pT} \mathbb{P}\{[0,\frac{e}{e+\gamma}]\} + e^p \mathbb{P}\{(\frac{e}{e+\gamma},1]\}}$$
$$= \frac{e^{-p}(e+\gamma)^p + e^p \mathbb{P}\{(\frac{e}{e+\gamma},1]\} \mathbb{P}\{[0,\frac{e}{e+\gamma}]\}^{-1}e^{-pT}}{1 + e^p \mathbb{P}\{(\frac{e}{e+\gamma},1]\} \mathbb{P}\{[0,\frac{e}{e+\gamma}]\}^{-1}e^{-pT}}$$

Set $\gamma_n := n$ for all $n \in \mathbb{N}$. For each γ_n we can find a T_n such that

$$\frac{\|X_{T_n,\gamma_n}^*\|_p^p}{\|e^{A_{T_n,\gamma_n}}\|_p^p} \ge e^{-p}(e+n)^p - 1,$$

which implies the claim.
