# **GAUSSIAN FLUCTUATIONS OF A NONLINEAR STOCHASTIC HEAT EQUATION IN DIMENSION TWO**

#### RAN TAO

ABSTRACT. We study the Gaussian fluctuations of a nonlinear stochastic heat equation in spatial dimension two. The equation is driven by a Gaussian multiplicative noise. The noise is white in time, smoothed in space at scale  $\varepsilon$ , and tuned logarithmically by a factor  $\frac{1}{\sqrt{\log \varepsilon^{-1}}}$  in its strength. We prove that, after centering and rescaling, the solution random field converges in distribution to an Edwards-Wilkinson limit as *ε* ↓ 0. The tool we used here is the Malliavin-Stein's method. We also give a functional version of this result.

KEYWORDS: Stochastic heat equation, Gaussian fluctuations, Malliavin calculus, Stein's method.

### 1. INTRODUCTION

1.1. **Main result.** Consider the following parameterized two-dimensional nonlinear stochastic heat equation (SHE) with constant initial data on  $(t, x) \in [0, +\infty) \times \mathbb{R}^2$ :

(1.1) \qquad \partial_t u^{\varepsilon}(t,x) = \frac{1}{2} \Delta u^{\varepsilon}(t,x) + \frac{\beta}{\sqrt{\log \varepsilon^{-1}}} \sigma(u^{\varepsilon}(t,x)) \mathrm{d}W_{\phi^{\varepsilon}}(t,x);
$$

$$
(1.2) \t u^{\varepsilon}(0,x) = 1.
$$

Here  $\beta > 0$  is a constant;  $\sigma : [0, \infty) \to [0, \infty)$  is a globally Lipschitz function satisfying  $\sigma(0) = 0$ ,  $\sigma(1) \neq 0$ , and  $|\sigma(x) - \sigma(y)| \leq \sigma_{\text{Lip}}|x - y|$  for all  $x, y \in \mathbb{R}^2$ with  $\sigma_{\text{Lip}} > 0$  fixed. We define

\mathrm{d}W_{\phi^{\varepsilon}}(t,x)=\phi^{\varepsilon}\ast\mathrm{d}W(t,x),
$$

where  $dW(t, x)$  is a space-time white noise on  $[0, +\infty) \times \mathbb{R}^2$ ,  $\phi \in C_c^{\infty}(\mathbb{R}^2)$  is a non-negative mollifier with  $\int \phi \, dx = 1$  and  $\phi^{\varepsilon}(x) = \frac{1}{\varepsilon^2}$  $\frac{1}{ε^2}$  $\phi$ ( $\frac{x}{ε}$  $(\frac{x}{\varepsilon})$ , and \* denotes convolution in space.

The noise  $dW_{\phi^{\varepsilon}}(t,x)$  is a centered Gaussian noise, white in time and homogeneously colored in space. The spatial correlation length is at scale *ε*. Formally, the covariance operator of  $dW^{\varepsilon}_{\phi}$  is given by

\mathbb{E}\left[\mathrm{d}W^{\varepsilon}_{\phi}(t,x)\mathrm{d}W^{\varepsilon}_{\phi}(t',x')\right] = \delta_0\big(t-t'\big)\tfrac{1}{\varepsilon^2}R\big(\tfrac{x-x'}{\varepsilon}\big).
$$

<span id="page-1-5"></span>Here  $\delta_0$  is the Dirac delta measure with unit mass at zero.  $R(x)$  is nonnegative and non-negative definite, given by

$$
R(x) = \int_{\mathbb{R}^2} \phi(x+y)\phi(y) \mathrm{d}y \in C_c^{\infty}(\mathbb{R}^2).
$$

For  $\varepsilon > 0$ , it is well-known that the initial value problem  $(1.1)$ – $(1.2)$  is well-posed and has a mild formulation

$$
(1.4) \t u^{\varepsilon}(t,x) = 1 + \frac{\beta}{\sqrt{\log \varepsilon^{-1}}} \int_0^t \int_{\mathbb{R}^2} G_{t-s}(x-y) \sigma(u^{\varepsilon}(s,y)) dW_{\phi^{\varepsilon}}(s,y).
$$

Here  $G_t(x) := \frac{1}{2\pi t} e^{-|x|^2/(2t)}$  denotes the two-dimensional heat kernel. The stochastic integral in [\(1.4\)](#page-0-2) is interpreted in the Itô-Walsh sense.

Our main result is the following central limit theorem (CLT):

<span id="page-1-3"></span>**Theorem 1.1.** *There exists some*  $\beta_0 \in (0, 0)$ √ 2*π*  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}$ ) *such that if*  $\beta < \beta_0$ *, for any fixed*  $T > 0$  *and any fixed Schwartz function*  $g \in C_c^{\infty}(\mathbb{R}^2)$ *, the random variable* 

(1.5) 
$$
X^{\varepsilon,T}(g) \coloneqq \sqrt{\log \varepsilon^{-1}} \int_{\mathbb{R}^2} \left[ u^{\varepsilon}(T,x) - 1 \right] g(x) dx
$$

*converges in law to a Gaussian distribution*

$$
\mathbf{X}^T(g) \coloneqq \int_{\mathbb{R}^2} U(T, x) g(x) \mathrm{d}x
$$

 $as \varepsilon \to 0$ . Here *U* is the random distribution that solves the Edwards-Wilkinson *equation in dimension two:*

$$
\partial_t U = \frac{1}{2} \Delta U + \beta \sqrt{\mathbb{E} \sigma \left( \Xi_{1,2}(2) \right)^2} \, \mathrm{d}W(t,x), \qquad U(0,x) = 0.
$$

 $\Xi_{1,2}(\cdot)$  *is a random process defined by the following as in* [\[11,](#page-24-0) p.3]*:* Let  ${B(q)}_{q\geq0}$  *be a 1D standard Brownian motion with the natural filtration*  $\{\mathcal{G}_q\}_{q\geq0}$ . Then  $\Xi_{1,2}(\cdot)$  *is the (unique) solution to a forward-backward stochastic differential equation (FBSDE):*

d\Xi_{1,2}(q) = \frac{\beta}{2\sqrt{\pi}} \big( \mathbb{E} [\sigma^2(\Xi_{1,2}(2)) | \mathcal{G}_q] \big)^{1/2} dB(q), \qquad q \in (0,2];
$$

$$
(1.9) \t\t \Xi_{1,2}(0) = 1.
$$

The existence and uniqueness of solutions to  $(1.8)$ – $(1.9)$  are given in [\[11,](#page-24-0) Theorem 1.1.<sup>2</sup>. To keep the consistency of notations, the subscript <sub>1,2</sub> denotes that the initial data equals to 1 constantly and the terminal time is at  $q = 2$ .

From  $[11,$  Theorem 1.1, we have that the coefficient in  $(1.7)$  satisfies

$$
\beta\sqrt{\mathbb{E}\sigma\left(\Xi_{1,2}(2)\right)^2}=2\sqrt{\pi}J(2,1),
$$

<span id="page-2-4"></span>where  $J^2(q, a)$  is a viscosity solution to the quasilinear heat equation

$$
\partial_q J^2 = \frac{1}{2} J^2 \partial_{aa} J^2;
$$
  

$$
J^2(0, a) = \frac{\beta^2}{4\pi} \sigma^2(a).
$$

We also prove the following functional version of the CLT:

<span id="page-2-2"></span>**Theorem 1.2.** *Let*  $\beta < \beta_0$ *. For any*  $T > 0$  *and*  $g \in C_c^{\infty}(\mathbb{R}^2)$ *. We have convergence in law in the space of continuous functions*  $C([0,T])$ *,*

\left(\mathbf{X}^{\varepsilon,t}(g)\right)_{t\in[0,T]} \to \left(\beta\sqrt{\mathbb{E}\sigma\left(\Xi_{1,2}(2)\right)^2}\int_0^t\int_{\mathbb{R}^2}G_{t-s}\ast g(x)\mathrm{d}W(s,x)\right)_{t\in[0,T]},
$$

 $as \varepsilon \to 0$ . As above, dW *is a space-time white noise on*  $[0, +\infty) \times \mathbb{R}^2$ .

1.2. **Context.** The Gaussian fluctuations of many SHE and KPZ equations have been widely studied.

If  $\sigma(x) = x$ , our SHE [\(1.1\)](#page-0-0)–[\(1.2\)](#page-0-1) becomes a linear one:

(1.10) 
$$
\partial_t v^{\varepsilon}(t,x) = \frac{1}{2} \Delta v^{\varepsilon}(t,x) + \frac{\beta}{\sqrt{\log \varepsilon^{-1}}} v^{\varepsilon}(t,x) dW_{\phi^{\varepsilon}}(t,x);
$$

$$
(1.11) \t v^{\varepsilon}(0,x) = 1.
$$

It is known that there is a phase transition at  $\beta = \sqrt{2\pi}$  for this multiplicative<br>SUE in dimension two Jp [9] Consumers, Sup and Zyganuas showed that for SHE in dimension two. In [\[2\]](#page-24-1), Caravenna, Sun, and Zygouras showed that for any fixed  $T > 0$  and  $x \in \mathbb{R}^2$ , if  $\beta \ge \sqrt{2\pi}$ ,  $v^{\varepsilon}(T, x)$  converges to 0 in probability as  $\varepsilon \to 0$ ; if  $\beta < \sqrt{2\pi}$  (known as  $\beta$  in the "subcritical" regime),  $v^{\varepsilon}(T, x)$ converges in law to a log-normal random variable as  $\varepsilon \to 0$ . They also proved that (see [\[2,](#page-24-1) Theorem 2.17]) if  $\beta < \sqrt{2\pi}$ , for any fixed time  $T > 0$  and any fixed Schwartz function  $g \in C_c^{\infty}(\mathbb{R}^2)$ , the random variable

\sqrt{\log \varepsilon^{-1}} \int_{\mathbb{R}^2} \left[ v^{\varepsilon}(T, x) - 1 \right] g(x) \mathrm{d}x
$$

converges in law to a Gaussian distribution. In other words, the solution random field to  $(1.10)$ – $(1.11)$ , after centering and rescaling, converges (in distribution) to the solution to an Edwards-Wilkinson equation.

We are interested in obtaining an analog result for our nonlinear SHE  $(1.1)$ – $(1.2)$ . In [\[2\]](#page-24-1), the authors used the Feynman–Kac formula, which is not available for nonlinear case. Therefore, new methods should be used for this problem. In [\[11\]](#page-24-0), Dunlap and Gu characterized the local statistics for the limiting solution field to nonlinear SHE  $(1.1)$ – $(1.2)$  when  $\beta \sigma_{\text{Lip}} < \sqrt{2\pi}$ . (See Proposition [2.10](#page-12-0) below or [\[11,](#page-24-0) Theorem 1.2].) They showed that  $u^{\varepsilon}(T,x)$ converges in law to a specific random variable  $\Xi_{1,2}(2)$  as  $\varepsilon \to 0$ . They also gave the multipoint statistics in their work.

Based on their findings, we want to study the asymptotics of the (centered and rescaled) solution field to the nonlinear SHE as  $\varepsilon \to 0$ . One may

conjecture an Edwards-Wilkinson limit as in the linear case. In Theorem [1.1,](#page-1-3) we gave a proof to this limit for a regime  $\beta < \beta_0$ √ 2*π*  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}.$  Whether or not this result can be extended to the entire "subcritical" regime  $\beta \in (0,$ √ 2*π*  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}\text{)}$  remains unknown. We will discuss it in more detail below.

We proved Theorem [1.1](#page-1-3) by using the mild formulation [\(1.4\)](#page-0-2) and the Malliavin-Stein's method. The use of the Malliavin-Stein's method in proving the Gaussian fluctuations for SHE is inspired by works [\[7,](#page-24-2) [14,](#page-24-3) [17,](#page-24-4) [18,](#page-24-5) [26\]](#page-25-0). We also use a multivariate version to prove a functional CLT in Theorem [1.2.](#page-2-2)

Through a Hopf-Cole transformation  $h = \log u$ , the linear SHE  $(1.10)$ –  $(1.11)$  is related to a KPZ-type equation in  $d = 2$ . The Gaussian fluctuations of the KPZ equation in  $d = 2$  in the subcritical regime is proved in [\[4\]](#page-24-6) and [\[13\]](#page-24-7). In [\[23\]](#page-25-1), the authors proved the Gaussian fluctuations of the linear SHE and KPZ equations in dimension two with general initial conditions. One of the reasons why we are interested in the nonlinear SHE is that we hope it will shed lights on the study of more general Hamilton–Jacobi SPDEs:

(1.12) 
$$
\partial_t h(t,x) = \frac{1}{2} \Delta h(t,x) + H(\nabla h(t,x)) + \beta \mathrm{d}W_{\phi}(t,x),
$$

where the Hamiltonian  $H$  is not necessarily quadratic. The only result in this direction that we are aware of is the study of a two-dimensional anisotropic KPZ equation in [\[1\]](#page-24-8). While the nonlinear SHE  $(1.1)$ – $(1.2)$  is more complicated than the linear one, it is still much more approachable than  $(1.12)$  because we can make use of the mild formulation  $(1.4)$ .

[\[14\]](#page-24-3) presents analog Gaussian fluctuations of the nonlinear SHE in  $d \geq 3$ . Gaussian fluctuations of the linear SHE and KPZ equations in  $d \geq 3$  are studied in [\[9,](#page-24-9) [10,](#page-24-10) [12,](#page-24-11) [16\]](#page-24-12) and [\[21\]](#page-25-2).

There are a few other things we would like to remark before we proceed.

1.2.1. *β-region.* In general, for SHE with multiplicative noise and KPZ equations in  $d \geq 2$ , the noise-strength parameter  $\beta$  plays a noticeable role.

For linear SHE  $(1.10)$ – $(1.11)$ , if  $v^{\varepsilon}(t, x)$  converges to 0 in probability as  $\varepsilon \to 0$  for any  $t > 0$ ,  $x \in \mathbb{R}^2$ , we say that the system is in the *strong disorder* regime. If  $v^{\varepsilon}(t, x)$  converges in distribution to a non-degenerate random variable as  $\varepsilon \to 0$  for any  $t > 0, x \in \mathbb{R}^2$ , we say that the system is in the *weak disorder* or *subcritical* regime.

As stated above, in [\[2\]](#page-24-1), the authors proved that  $\beta_c = \sqrt{2\pi}$  is the exact timel threshold where the departure from weak disorder to strong disorder critical threshold where the departure from weak disorder to strong disorder takes place. They also proved the Edwards-Wilkinson limit for linear SHE in the entire subcritical regime  $\beta \in (0, \sqrt{2\pi})$ . (Work [\[13\]](#page-24-7) gives an alternative proof to this limiting result for a smaller regime  $\beta < \beta_0$ , where  $\beta_0 < \sqrt{2\pi}$ .) When  $\beta \approx \sqrt{2\pi}$ , the solution random field  $v^{\varepsilon}(t,x)$  no longer needs any contains and recessling to obtain a portrivial limiting structure. We refer to centering and rescaling to obtain a nontrivial limiting structure. We refer to [\[5,](#page-24-13) [15,](#page-24-14) [3\]](#page-24-15) for the study in this direction.

<span id="page-4-1"></span>Here we are to prove the Edwards-Wilkinson limit (Theorem [1.1\)](#page-1-3) for nonlinear SHE  $(1.1)$ – $(1.2)$  in a regime  $\beta < \beta_0$ √ 2*π*  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}$  smaller than the entire subcritical regime  $\beta \in (0, \frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}})$ √  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}\$ . In fact, our proof below ensures that The-orem [1.1](#page-1-3) would hold for  $\beta_0 = \frac{1}{2\sqrt{3}}$  $\frac{1}{2\sqrt{6}}$ √ 2*π*  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}$  (see Remark [2.6](#page-12-1) for detail). While we don't believe that this is an optimal *β*-region, whether or not (and how) Theorem [1.1](#page-1-3) can be extended to the entire subcritical regime remains open.

For SHE in  $d \geq 3$ , the readers may refer to [\[22\]](#page-25-3) and [\[10\]](#page-24-10) on the weak/strong disorder regions of *β*. In particular, [\[10\]](#page-24-10) proved the Edwards-Wilkinson limit for linear SHE in  $d \geq 3$  in the entire subcritical regime. For nonlinear SHE in  $d \geq 3$ , [\[14\]](#page-24-3) also restricted  $\beta$  in a smaller region.

1.2.2. *General initial condition.* Following the same methods as in [\[11\]](#page-24-0), we can generate the results from  $[11,$  Theorem 1.2 to nonlinear SHE  $(1.1)$  with general initial condition

(1.13) 
$$
u^{\varepsilon}(0,x) = u_0(x), \qquad x \in \mathbb{R}^2,
$$

if we assume  $u_0$  satisfies

$$
0 < \inf_{x \in \mathbb{R}^2} u_0(x) \le \sup_{x \in \mathbb{R}^2} u_0(x) < +\infty.
$$

In fact, it can be shown that  $u^{\varepsilon}(T,x) \to \bar{u}(T,x)\Xi_{1,2}(2)$  in law as  $\varepsilon \to 0$  where  $\bar{u}(T, x) = G_T * u_0(x)$  is a deterministic function. One can now go through the exactly same arguments as in the proof of Theorem [1.1](#page-1-3) here to obtain the Gaussian fluctuations of the SHE  $(1.1)$  with initial condition  $(1.13)$  as  $\varepsilon \to 0$ . We claim, without proof, that Theorem [1.1](#page-1-3) still holds, except that the Edwards-Wilkinson equation [\(1.7\)](#page-1-2) should be replaced by a new SPDE:

$$
\partial_t U = \frac{1}{2} \Delta U + \beta \sqrt{\mathbb{E}\sigma \left(\Xi_{1,2}(2)\right)^2} \bar{u}(t,x) dW(t,x), \qquad U(0,x) = 0.
$$

This result aligns with the one in [\[23,](#page-25-1) Theorem 1.3, Remark 1.4] for linear SHE in dimension two with general initial condition.

1.3. **Organization of the paper.** In Section [2,](#page-5-0) we first scale our SHE  $(1.1)$ – $(1.2)$  to microscopic variables. Then we introduce the basics of the Malliavin-Stein's method and prove some uniform moment bounds to use in the sequel. We will also state [\[11,](#page-24-0) Theorem 1.2] in Proposition [2.10](#page-12-0) for convenience. In Section [3](#page-13-0) and [4,](#page-20-0) we prove Theorem [1.1](#page-1-3) and [1.2](#page-2-2) respectively.

### 2. Preliminaries

2.1. **Scaling.** We are going to use the Malliavin calculus for Gaussian spaces. In order to simplify the calculation, we want to fix a specific Gaussian space. For this purpose, we introduce another representation of the SHE  $(1.1)$ – $(1.2)$ .

We study the following equation in microscopic variables on  $(t, x) \in$  $[0, +\infty) \times \mathbb{R}^2$ :

$$
\partial_t \mathcal{V}^\varepsilon(t,x) = \frac{1}{2} \Delta \mathcal{V}^\varepsilon(t,x) + \frac{\beta}{\sqrt{\log \varepsilon^{-1}}} \sigma \left( \mathcal{V}^\varepsilon(t,x) \right) dW_\phi(t,x);
$$

<span id="page-5-2"></span>
$$
(2.2) \t\t\t V^{\varepsilon}(0,x) = 1.
$$

Here  $W_{\phi}(t, x) \coloneqq W_{\phi^1}(t, x) = \int_{\mathbb{R}^2} \phi(x - y) W(t, y) dy$  is defined as in [\(1.3\)](#page-0-3) with  $\varepsilon$  = 1. By the scaling property of the space-time white noise, we have

$$
u^{\varepsilon}(\cdot,\cdot) = \mathcal{V}^{\varepsilon}(\frac{\cdot}{\varepsilon^2},\frac{\cdot}{\varepsilon})
$$
 jointly in law.

Since we are only interested in proving convergence in law, it is sufficient to prove Theorem [1.1](#page-1-3) with  $u^{\varepsilon}(T,x)$  substituted by  $\mathcal{V}^{\varepsilon}(\frac{T}{\varepsilon^2})$  $\frac{T}{\varepsilon^2}$ ,  $\frac{x}{\varepsilon}$  $(\frac{x}{\varepsilon})$ . In fact, as the mild formulation of  $\mathcal{V}^{\varepsilon}(t,x)$  is

$$
(2.3) \qquad \mathcal{V}^{\varepsilon}(t,x) = 1 + \frac{\beta}{\sqrt{\log \varepsilon^{-1}}} \int_0^t \int_{\mathbb{R}^2} G_{t-s}(x-y) \sigma\left(\mathcal{V}^{\varepsilon}(s,y)\right) \mathrm{d}W_{\phi}(s,y),
$$

we have

$$
X^{\varepsilon,T}(g) \stackrel{\text{law}}{=} Y^{\varepsilon,T}(g) := \sqrt{\log \varepsilon^{-1}} \int_{\mathbb{R}^2} \left[ \mathcal{V}^{\varepsilon}(\frac{T}{\varepsilon^2}, \frac{x}{\varepsilon}) - 1 \right] g(x) dx
$$
\n
$$
= \beta \int_{\mathbb{R}^2} \int_0^{\frac{T}{\varepsilon^2}} \int_{\mathbb{R}^2} G_{\frac{T}{\varepsilon^2} - s}(\frac{x}{\varepsilon} - y) \sigma \left( \mathcal{V}^{\varepsilon}(s, y) \right) dW_{\phi}(s, y) g(x) dx.
$$

For  $0 \le t_1 < \cdots < t_m \le T$ , we have

$$
(X^{\varepsilon,t_1}(g),\ldots,X^{\varepsilon,t_m}(g))\stackrel{\mathrm{law}}{=} (Y^{\varepsilon,t_1}(g),\ldots,Y^{\varepsilon,t_m}(g)).
$$

From now on, we will study  $Y^{\varepsilon,T}(g)$  instead of  $X^{\varepsilon,T}(g)$ , etc.

*Remark* 2.1*.* As discussed in [\[11,](#page-24-0) Section 1.1], in the subcritical regime  $\beta \sigma_{\rm Lip} < \sqrt{2\pi}$ , the 2-dimensional stochastic heat equation [\(2.1\)](#page-5-1)–[\(2.2\)](#page-5-2) evolves on an exponential time scale with respect to the strength of the random noise. The exponential time scale explains why we need the tuning  $\frac{1}{\sqrt{2}}$  $\log \varepsilon^{-1}$ before the noise term in our SHE  $(1.1)$ – $(1.2)$ .

This scaling is different from the  $d \geq 3$  cases. When  $d \geq 3$ , if the strength of the noise is small enough so that the system is in the weak disorder regime, the SHE  $(2.1)$ – $(2.2)$  evolves in an 'arbitrarily long' diffusion scale  $(\frac{t}{\lambda})$  $\frac{t}{\lambda}$ <sup>*,*</sup> $\frac{x}{\lambda^2}$ </sup>) where  $\lambda$  is independent of the strength of the noise. See e.g. [\[22\]](#page-25-3).

<span id="page-6-1"></span>2.2. **The Malliavin calculus.** Now we state the Gaussian space in which we will be working with and give some elementary results from the Malliavin calculus theory. A detailed discussion should be referred to the monograph [\[25\]](#page-25-4).

Consider a complete probability space  $(\Omega, \mathscr{F}, \mathbb{P})$  generated by the Gaussian noise  $dW_{\phi}$  as defined above. Let  $\mathcal{H}$  be the Hilbert space given by the closure of  $C_c^{\infty}(\mathbb{R}_{\geq 0} \times \mathbb{R}^2)$  with respect to the inner product

Define an operator  $W: \mathcal{H} \to L^2(\Omega)$  as

$$
W(h) = \int_0^{+\infty} \int_{\mathbb{R}^2} h(t, x) \mathrm{d}W_{\phi}(t, x).
$$

Then *W* is a linear isometry and the Gaussian space  $\{W(h): h \in \mathcal{H}\}\$ is an isonormal Gaussian process over H.

Following the conventional notations, we denote the Malliavin derivative operator for the isonormal Guassian process  $\{W(h): h \in \mathcal{H}\}\$  by *D*. Let  $\mathbb{D}^{k,p}, k, p \in \mathbb{Z}^+$  denote the associated Gaussian Sobolev spaces.

For any  $t \geq 0$ , let  $\mathscr{F}_t$  be the *σ*-algebra generated by  $\{W_\phi([0, s] \times A) : 0 \leq$  $s \leq t, A \in \mathscr{B}_b(\mathbb{R}^2)$  and the null sets of  $\mathscr{F}$ . Here  $\mathscr{B}_b(\mathbb{R}^2)$  denotes the bounded<br>Papel subsets of  $\mathbb{R}^2$ , A mandam field  $y$ ,  $\{y(t,x), t > 0, x \in \mathbb{R}^2\}$  is adopted if Borel subsets of  $\mathbb{R}^2$ . A random field  $v = \{v(t, x), t \ge 0, x \in \mathbb{R}^2\}$  is adapted if it is  $\mathscr{F}_t$ -measurable for each  $t \geq 0$  and  $x \in \mathbb{R}^2$ .

Let  $\delta$  denote the divergence operator.  $\delta$  is the adjoint operator of *D*. If  $v(t, x)$  is an adapted and measurable random field on  $[0, +\infty) \times \mathbb{R}^2$  such that

$$
\int_0^{+\infty}\int_{\mathbb{R}^2}\int_{\mathbb{R}^2}\mathbb{E}\left(v(t,x)v(t,y)\right)R(x-y)\mathrm{d}x\mathrm{d}y\mathrm{d}t<+\infty,
$$

then  $v \in \text{Dom}(\delta)$  and

$$
\delta(v) = \int_0^{+\infty} \int_{\mathbb{R}^2} v(t, x) \mathrm{d}W_{\phi}(t, x),
$$

where the last integral is well-defined in the Itô-Walsh sense with the isometry

$$
\mathbb{E}(\delta(v))^2 = \int_0^{+\infty} \int_{\mathbb{R}^2} \int_{\mathbb{R}^2} \mathbb{E}(v(t,x)v(t,y)) R(x-y) \mathrm{d}x \mathrm{d}y \mathrm{d}t
$$

By [\[25,](#page-25-4) Proposition 1.3.8], if  $v \in \text{Dom}(\delta)$  and is an adapted process in  $\mathbb{D}^{1,2}$ , then

$$
D_{r,z}\delta(v)=v(r,z)+\int_0^{+\infty}\int_{\mathbb{R}^2}D_{r,z}v(s,y)\mathrm{d}W_{\phi}(s,y).
$$

A standard Picard's iteration scheme shows that for all  $\varepsilon > 0$  and  $(t, x) \in$  $[0, +\infty) \times \mathbb{R}^2$ ,  $\mathcal{V}^{\varepsilon}(t, x) \in \mathbb{D}^{1, p}$  for all  $p \ge 1$ . Since  $\mathcal{V}^{\varepsilon}(t, x)$  has the mild

<span id="page-7-2"></span>formulation [\(2.3\)](#page-5-3), the Malliavin derivative  $D_{r,z} \mathcal{V}^{\varepsilon}(t,x)$  satisfies the equation

\frac{\beta}{\sqrt{\log \varepsilon^{-1}}} \int_{r}^{t} \int_{\mathbb{R}^{2}} G_{t-s}(x-y)D_{r,z}\sigma(\mathcal{V}^{\varepsilon}(s,y))\mathrm{d}W_{\phi}(s,y)
$$
  
= 
$$
\frac{\beta}{\sqrt{\log \varepsilon^{-1}}} \mathbb{1}_{[0,t]}(r)G_{t-r}(x-z)\sigma(\mathcal{V}^{\varepsilon}(r,z))
$$

$$
+ \frac{\beta}{\sqrt{\log \varepsilon^{-1}}} \int_{r}^{t} \int_{\mathbb{R}^{2}} G_{t-s}(x-y)\Sigma(s,y)D_{r,z}\mathcal{V}^{\varepsilon}(s,y)\mathrm{d}W_{\phi}(s,y).
$$

Here  $\Sigma$  is an adapted process bounded by the Lipschitz constant  $\sigma_{\text{Lip}}.$  If we further assume that  $\sigma \in C^1([0, +\infty))$ , then  $\Sigma(s, y) = \sigma'(\mathcal{V}^{\varepsilon}(s, y))$ .

In addition, we will need the following version of the Clark-Ocone formula in the proof of Theorem [1.1.](#page-1-3)

**Proposition 2.2** (Clark-Ocone Formula). *For*  $X \in \mathbb{D}^{1,2}$ ,

X = \mathbb{E}X + \int_0^{+\infty} \int_{\mathbb{R}^2} \mathbb{E}(D_{r,z}X|\mathscr{F}_r) dW_{\phi}(r,z) \qquad \mathbb{P}-almost \ surely.

*Proof.* See [\[8,](#page-24-16) Proposition 6.3]. □

2.3. **Moment bounds.** We will use the following two uniform moment bounds in the proof of Theorem [1.1.](#page-1-3)

Note that in both lemmas we are not able to cover the entire subcritical regime  $0 < \beta < \frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}$  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}.$  In fact, the extension of Lemma [2.3](#page-7-0) to the entire subcritical regime should be true and its counterpart in the 2D directed polymer environment is proved in [\[20\]](#page-25-5). However, it remains unknown whether Lemma [2.5](#page-10-0) can be extended to the entire subcritical regime.

We first give a uniform moment bound on the mild solution to the SHE.

<span id="page-7-0"></span>**Lemma 2.3.** *For all*  $p \ge 2$ *, there exists*  $0 < \beta_0(p) \le$ √ 2*π*  $\frac{\sqrt{2\pi}}{\sigma_{\rm Lip}}$  depending only on *p, such that for all*  $T > 0$  *and*  $\beta < \beta_0(p)$ *, there exists*  $\varepsilon_0 > 0$  *(depending on φ, T, βσ*Lip *and <sup>p</sup>) and <sup>C</sup>* <sup>&</sup>gt; <sup>0</sup> *(depending on βσ*Lip *and <sup>p</sup>) such that*

\sup_{t\in[0,T],x\in\mathbb{R}^2}\mathbb{E}|u^{\varepsilon}(t,x)|^p\leq C^p,
$$

*for all*  $\varepsilon < \varepsilon_0$ *.* 

*Proof.* First we notice that, for any  $\varepsilon, t > 0$ ,  $u^{\varepsilon}(t, \cdot)$  is stationary in the *x*-variable, so we only need to prove for  $u^{\varepsilon}(t,0)$ .

By the mild formulation  $(1.4)$ , the triangle inequality and the inequality  $2ab \leq (ca)^2 + (\frac{b}{c})$  $\frac{b}{c}$ )<sup>2</sup> for all *c* > 1, we have that for any arbitrary *α* > 1,

$$
\begin{aligned} & \left( \mathbb{E} \left| u^{\varepsilon}(t,0) \right|^{p} \right)^{\frac{2}{p}} \\ & \leq \frac{\alpha}{\alpha - 1} + \frac{\alpha \beta^{2}}{\log \varepsilon^{-1}} \left( \mathbb{E} \left( \int_{0}^{t} \int_{\mathbb{R}^{2}} G_{t-s}(y) \sigma \left( u^{\varepsilon}(s,y) \right) \mathrm{d}W_{\phi^{\varepsilon}}(s,y) \right)^{p} \right)^{\frac{2}{p}} \end{aligned}
$$

Apply the Burkholder-Davis-Gundy inequality, we have that with  $c_p = \frac{p(p-1)}{2}$  $\frac{1}{2}$ ,

$$
\begin{aligned} & \left( \mathbb{E} \left| u^{\varepsilon}(t,0) \right|^{p} \right)^{\frac{2}{p}} \\ &\leq \frac{\alpha}{\alpha - 1} + c_{p} \frac{\alpha \beta^{2}}{\log \varepsilon^{-1}} \\ &\cdot \int_{0}^{t} \left( \mathbb{E} \left( \int_{\mathbb{R}^{2}} \int_{\mathbb{R}^{2}} \left| \prod_{i=1}^{2} G_{t-s}(y_{i}) \sigma(u^{\varepsilon}(s,y_{i})) \right| \frac{1}{\varepsilon^{2}} R(\frac{y_{1} - y_{2}}{\varepsilon}) dy_{1} dy_{2} \right)^{\frac{p}{2}} \right)^{\frac{2}{p}} ds \end{aligned}
$$

The Hölder's inequality gives that

= \left(\mathbb{E}|\sigma(u^{\varepsilon}(t,x))|^p\right)^{\frac{2}{p}} \leq \sigma_{\mathrm{Lip}}^2 \left(\mathbb{E}|u^{\varepsilon}(t,0)|^p\right)^{\frac{2}{p}}
$$

Combined the above results. Use the Minkowski inequality and a change of variable  $y_1 - y_2 \mapsto y$ , we obtain

\begin{split}\n&\left(\mathbb{E}\left|u^{\varepsilon}(t,0)\right|^{p}\right)^{\frac{2}{p}} \\
&\leq \frac{\alpha}{\alpha-1} + c_{p} \frac{\alpha \beta^{2}}{\log \varepsilon^{-1}} \int_{0}^{t} \int_{\mathbb{R}^{2}} \int_{\mathbb{R}^{2}} \left(\mathbb{E}\left|\prod_{i=1}^{2} G_{t-s}(y_{i}) \sigma\left(u^{\varepsilon}(s,y_{i})\right)\right|^{p}\right)^{\frac{2}{p}} \int_{\varepsilon^{2}}^{\frac{2}{p}} \frac{1}{\varepsilon^{2}} R\left(\frac{y_{1}-y_{2}}{\varepsilon}\right) \mathrm{d}y_{1} \mathrm{d}y_{2} \mathrm{d}s \\
&\leq \frac{\alpha}{\alpha-1} + c_{p} \frac{\alpha \beta^{2} \sigma_{\mathrm{Lip}}^{2}}{\log \varepsilon^{-1}} \int_{0}^{t} \int_{\mathbb{R}^{2}} \int_{\mathbb{R}^{2}} G_{t-s}(y_{1}) G_{t-s}(y_{2}) \left(\mathbb{E}\left|u^{\varepsilon}(t,0)\right|^{p}\right)^{\frac{2}{p}} \frac{1}{\varepsilon^{2}} R\left(\frac{y_{1}-y_{2}}{\varepsilon}\right) \mathrm{d}y_{1} \mathrm{d}y_{2} \mathrm{d}s \\
&=\frac{\alpha}{\alpha-1} + c_{p} \frac{\alpha \beta^{2} \sigma_{\mathrm{Lip}}^{2}}{\log \varepsilon^{-1}} \int_{0}^{t} \int_{\mathbb{R}^{2}} G_{2(t-s)}(y) \left(\mathbb{E}\left|u^{\varepsilon}(s,0)\right|^{p}\right)^{\frac{2}{p}} \frac{1}{\varepsilon^{2}} R\left(\frac{y}{\varepsilon}\right) \mathrm{d}y \mathrm{d}s.\n\end{split}
$$

It is easy to see that with  $R(\cdot) \leq ||\phi||_{\infty}$  and  $\int_{\mathbb{R}^2} \frac{1}{\varepsilon^2}$  $\frac{1}{ε^2}R(\frac{y}{ε}$  $(\frac{y}{\varepsilon})dy = 1$ , we have the elementary inequality

Since  $\alpha > 1$  is arbitrary, condition [\(2.8\)](#page-8-0) is valid if and only if

$$
\beta < \beta_0(p) = \frac{\sqrt{2\pi}}{\sqrt{c_p} \sigma_{\text{Lip}}}.
$$

In particular,  $\beta_0(2)$  = √ 2*π*  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}$  and  $\beta_0(4) = \frac{1}{\sqrt{2\pi}}$ 6 √ 2*π*  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}.$  We can choose an appropriate *α* according to *p* and  $βσ$ <sub>Lip</sub>. □

As an immediate corollary, we have that under the same condition as in Lemma [2.3,](#page-7-0)

= a \sum_{j=0}^{\infty} \frac{b^{2j}}{(4\pi \log \varepsilon^{-1})^j} \left[ \int_0^t \left( \frac{1}{s} \wedge \frac{4\pi c}{\varepsilon^2} \right) ds \right]^j
$$

<span id="page-9-1"></span>Notice that when  $t > 0$ ,

<span id="page-10-1"></span>Therefore, if  $b < \sqrt{2\pi}$ , there exists an  $\varepsilon_0 > 0$  depending on *b*, *c* and *T*, such that for all a  $\varepsilon$  (0,  $\varepsilon$ ), the sum of the same in (9,11) converges for all t  $\varepsilon$  [0, *T*] that for all  $\varepsilon \in (0, \varepsilon_0)$ , the sum of the series in  $(2.11)$  converges for all  $t \in [0, T]$ and is uniformly bounded by some constant  $C$  depending only on  $b$ .  $\Box$ 

Next we give the uniform moment bounds for the Malliavin derivatives.

<span id="page-10-0"></span>**Lemma 2.5.** *For all*  $p \ge 2$ *, there exists*  $0 < \beta_0(p) \le$ √ 2*π*  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}$  depending only on *p*, such that for all  $T > 0$  and  $\beta < \beta_0(p)$ , there exists  $0 < \varepsilon'_0 \leq \varepsilon_0$  (depending *on*  $\phi$ ,  $T$ ,  $\beta \sigma_{\text{Lip}}$  *and*  $p$ *) and*  $C' > 0$  *(depending on*  $\beta \sigma_{\text{Lip}}$  *and*  $p$ *) such that for all*  $(t, x) \in (0, \frac{T}{\varepsilon^2})$  $\left[\frac{T}{\varepsilon^2}\right] \times \mathbb{R}^2$  *and all*  $(r, z) \in [0, t) \times \mathbb{R}^2$ ,

\left(\mathbb{E}\left|D_{r,z}\mathcal{V}^{\varepsilon}(t,x)\right|^{p}\right)^{\frac{1}{p}} \leq \frac{C'}{\sqrt{\log\varepsilon^{-1}}}G_{t-r}(x-z), \quad \text{ for all } \varepsilon < \varepsilon'_{0}.

*Proof.* We follow the idea from [\[14,](#page-24-3) Lemma 2.2].

&\leq \frac{\alpha}{\alpha-1} \frac{\beta^{2}}{\log \varepsilon^{-1}} G_{t-r}(x-z)^{2} \left(\mathbb{E}|\sigma(\mathcal{V}^{\varepsilon}(r,z))|^{p}\right)^{\frac{2}{p}} \\
&+ \frac{\alpha\beta^{2}}{\log \varepsilon^{-1}} \left(\mathbb{E}\left|\int_{r}^{t} \int_{\mathbb{R}^{2}} G_{t-s}(x-y) \Sigma(s,y) D_{r,z} \mathcal{V}^{\varepsilon}(s,y) \mathrm{d}W_{\phi}(s,y)\right|^{p}\right)^{\frac{2}{p}}\n\end{split}
$$

Applying the Burkholder-Davis-Gundy inequality with  $c_p = \frac{p(p-1)}{2}$  $\frac{p-1}{2}$ , we have

\begin{aligned}\n&\left(\mathbb{E}\left|D_{r,z}\mathcal{V}^{\varepsilon}(t,x)\right|^{p}\right)^{\frac{2}{p}} \leq \frac{\alpha}{\alpha-1} \frac{\beta^{2}\sigma_{\mathrm{Lip}}^{2}}{\log \varepsilon^{-1}} G_{t-r}(x-z)^{2} \left(\mathbb{E}|\mathcal{V}^{\varepsilon}(r,z)|^{p}\right)^{\frac{2}{p}} \\
&+ c_{p} \frac{\alpha\beta^{2}}{\log \varepsilon^{-1}} \int_{r}^{t} \left[\mathbb{E}\left(\int_{\mathbb{R}^{2}} \int_{\mathbb{R}^{2}} G_{t-s}(x-y_{1}) G_{t-s}(x-y_{2}) \Sigma(s,y_{1}) \Sigma(s,y_{2})\right. \right. \\
&\left. \cdot D_{r,z} \mathcal{V}^{\varepsilon}(s,y_{1}) D_{r,z} \mathcal{V}^{\varepsilon}(s,y_{2}) R(y_{1}-y_{2}) \mathrm{d}y_{1} \mathrm{d}y_{2}\right)^{\frac{p}{2}}\right]^{\frac{2}{p}} \mathrm{d}s\n\end{aligned}
$$

Using the Minkowski inequality,  $(2.9)$  and the boundness of  $\Sigma$ , we further obtain

\begin{aligned} &\left(\mathbb{E}\left|D_{r,z}\mathcal{V}^{\varepsilon}(t,x)\right|^{p}\right)^{\frac{2}{p}}\\ &\leq \frac{\alpha}{\alpha-1} \frac{\beta^{2}\sigma_{\mathrm{Lip}}^{2}C^{2}}{\log\varepsilon^{-1}}G_{t-r}(x-z)^{2} + c_{p}\frac{\alpha\beta^{2}\sigma_{\mathrm{Lip}}^{2}}{\log\varepsilon^{-1}}\int_{r}^{t}\int_{\mathbb{R}^{4}}R(y_{1}-y_{2})\\ &\cdot G_{t-s}(x-y_{1})G_{t-s}(x-y_{2})\left[\mathbb{E}\left|D_{r,z}\mathcal{V}^{\varepsilon}(s,y_{1})\right|^{p}\right]^{\frac{1}{p}}\left[\mathbb{E}\left|D_{r,z}\mathcal{V}^{\varepsilon}(s,y_{2})\right|^{p}\right]^{\frac{1}{p}}\mathrm{d}y_{1}\mathrm{d}y_{2}\mathrm{d}s. \end{aligned}
$$
\nIf we set  $t = \theta + r$  and  $x = \eta + z$ , let

 $\mathcal{K}(\theta, \eta) \coloneqq (\mathbb{E} |D_{r,z}\mathcal{V}^{\varepsilon}(\theta+r, \eta+z)|^p)$  $\frac{1}{p}$  =  $(\mathbb{E}|D_{r,z}\mathcal{V}^{\varepsilon}(t,x)|^{p})$  $\frac{1}{p}$ , <span id="page-11-1"></span>then we can rewrite the above inequality as

$$

= \int_0^T \left( \frac{1}{2\pi s} \wedge \frac{\|\phi\|_{\infty}}{\varepsilon^2} \right) ds = \int_0^{\frac{\varepsilon^2}{2\pi \|\phi\|_{\infty}}} \frac{\|\phi\|_{\infty}}{\varepsilon^2} ds + \int_{\frac{\varepsilon^2}{2\pi \|\phi\|_{\infty}}}^T \frac{1}{2\pi s} ds

= \frac{1}{2\pi} + \frac{1}{2\pi} \log \frac{2\pi \|\phi\|_{\infty} T}{\varepsilon^2}.

Thus for all  $n \geq 1$ ,

<span id="page-12-1"></span>*Remark* 2.6*.* In Section [3](#page-13-0) below, we only need the results of Lemma [2.3](#page-7-0) and Lemma [2.5](#page-10-0) for  $p = 2, 4$ . As a result, we can let  $\beta_0 = \frac{1}{2} \sqrt{\frac{p(1-p)}{n}}$  $\frac{1}{2\sqrt{6}}$  $\frac{0}{\sqrt{2\pi}}$  $\frac{\sqrt{2\pi}}{\sigma_{\text{Lip}}}$  in Theorem [1.1.](#page-1-3) Compared with the linear SHE case, we don't believe that it is an optimal value. The main difficulty of extension came from the restriction of  $\beta$  in Lemma [2.5.](#page-10-0) The coefficient  $\frac{1}{\sqrt{2}}$  $\frac{1}{6}$  came from the BDG-inequality and  $\frac{1}{2}$  came from [\(2.12\)](#page-9-3). One may find elementary ways to improve the BDG-inequality here, but while we believe that  $(2.12)$  is not sharp, it remains unclear how we can improve it.

2.4. **Stein's method.** The following propositions are key ingredients in our proof of the central limit theorems Theorem [1.1](#page-1-3) and Theorem [1.2.](#page-2-2) They are derived from the Stein's method for normal approximations and are also used in [\[14\]](#page-24-3) and [\[17\]](#page-24-4). A more detailed discussion on the Stein's method with Malliavin calculus should be referred to the monograph [\[24\]](#page-25-6).

**Proposition 2.7.** Let *X* be a random variable such that  $X = \delta(v)$  for  $v \in \overline{\text{Dom }\delta}$ . Assume  $X \in \mathbb{D}^{1,2}$ . Let  $Z$  be a centered Gaussian random variable *with variance*  $\Sigma$ *. For any*  $C^2$ -function  $h : \mathbb{R} \to \mathbb{R}$  *with a bounded second order derivative,*

$$
|\mathbb{E} h(X)-\mathbb{E} h(Z)|\leq \frac{1}{2}\|h''\|_{\infty}\sqrt{\mathbb{E}\left|\Sigma-\langle DX,v\rangle_{\mathcal{H}}\right|^{2}}.
$$

*Proof.* This is a special case of the Proposition [2.9](#page-12-0) below with  $m = 1$ .  $\Box$ 

*Remark* 2.8*.* The class of *C* 2 functions with bounded second order derivatives is a sufficient class of test functions  $h(\cdot)$  to show convergence in law. With Proposition [2.7,](#page-12-0) if we can prove that  $\mathbb{E}|\Sigma - \langle DX_n, v_n \rangle_{\mathcal{H}}|^2 \to 0$  as  $n \to \infty$  for a series of random variables  $X_n \in \mathbb{D}^{1,2}$  with  $X_n = \delta(v_n)$ , then we have  $X_n \Rightarrow Z$ in law.

\|h''\|_{\infty} = \max_{1 \le i,j \le m} \sup_{x \in \mathbb{R}^m} \left| \frac{\partial^2 h}{\partial x_i \partial x_j}(x) \right|.

*Proof. See* [\[17,](#page-24-4) Proposition 2.3]*.* ◻

2.5. **Local statistics of the limit.** We need the following local statistics of the limiting random field  $u^{\varepsilon}(t,x)$  as  $\varepsilon \to 0$ .

**Proposition 2.10.** *If*  $\beta \sigma_{\text{Lip}} < \sqrt{2\pi}$ , for any  $t > 0$  and  $x \in \mathbb{R}^2$ , we have

u^{\varepsilon}(t,x) \stackrel{law}{\rightarrow} \Xi_{1,2}(2)
$$
 as  $\varepsilon \to 0$ .

*The random process*  $\Xi_{1,2}(\cdot)$  *is defined as in* [\(1.8\)](#page-1-0)–[\(1.9\)](#page-1-1)*.* 

*Proof.* See [\[11,](#page-24-0) Theorem 1.2]. □

We also need the following spatial regularity statement for  $u^{\varepsilon}(t,\cdot)$ .

Here  $\Sigma(r, z)$  is the same random process as in [\(2.5\)](#page-6-0).

Our goal is to prove that  $Y^{\varepsilon,T}(g)$  converges in law to  $X^T(g)$  as defined in  $(1.6)$  when  $\varepsilon \to 0$ . \mathbb{E}\left(\sigma\left(\mathcal{V}^{\varepsilon}\left(\frac{s}{\varepsilon^2},\frac{y_1}{\varepsilon}\right)\right)\sigma\left(\mathcal{V}^{\varepsilon}\left(\frac{s}{\varepsilon^2},\frac{y_1}{\varepsilon}+y_2\right)\right)\right)\to \mathbb{E}\sigma(\Xi_{1,2}(2))^2, \quad \text{as } \varepsilon \to 0.

The Lipschitz condition and Lemma [2.3](#page-7-0) gives the uniform integrability to pass to the limit in [\(3.11\)](#page-16-0) and conclude that

**Proposition 4.1.** *For*  $p \ge 2$ ,  $T > 0$ ,  $g \in C_c^{\infty}(\mathbb{R}^2)$ , let  $\beta_0(p)$  and  $\varepsilon_0$  be defined *as in Lemma [2.3.](#page-7-0) If*  $\beta < \beta_0(p)$ , there exists a uniform constant  $C > 0$  $(depending only on  $\beta \sigma_{\text{Lip}}$ , *p* and *g*), such that for any  $0 \le s < t \le T$  and  $\varepsilon < \varepsilon_0$ ,$  $\mathbb{E}\left|X^{\varepsilon,t}(g) - X^{\varepsilon,s}(g)\right|^p \leq C(t-s)^{\frac{p}{2}}.$ 

*Proof.* By the mild formulation of  $u^{\varepsilon}$  in [\(1.4\)](#page-0-2) and the Burkholder-Davis-Gundy inequality, let  $c_p = \frac{p(p-1)}{2}$  $\frac{2^{D-1}}{2}$ , we have

$$

&=\left(\mathbb{E}\left|\beta\int_{\mathbb{R}^2}\left[\int_0^t\int_{\mathbb{R}^2}G_{t-r}(x-y)\sigma(u^{\varepsilon}(r,y))\mathrm{d}W_{\phi^{\varepsilon}}(r,y)\right.\right. \\
&\left.\left.-\int_0^s\int_{\mathbb{R}^2}G_{s-r}(x-y)\sigma(u^{\varepsilon}(r,y))\mathrm{d}W_{\phi^{\varepsilon}}(r,y)\right]g(x)\mathrm{d}x\right|^p\right)^{\frac{2}{p}} \\
&=\beta^2\left(\mathbb{E}\left|\int_0^T\int_{\mathbb{R}^2}\left(G_{t-r}\ast g(y)\mathbb{1}_{[0,t]}(r)-G_{s-r}\ast g(y)\mathbb{1}_{[0,s]}(r)\right)\sigma(u^{\varepsilon}(r,y))\mathrm{d}W_{\phi^{\varepsilon}}(r,y)\right|^p\right)^{\frac{2}{p}} \\
&\le c_p\beta^2\int_0^T\left(\mathbb{E}\left(\int_{\mathbb{R}^2}\int_{\mathbb{R}^2}\left(G_{t-r}\ast g(y_1)\mathbb{1}_{[0,t]}(r)-G_{s-r}\ast g(y_1)\mathbb{1}_{[0,s]}(r)\right)\right. \\
&\left.\left.\left(G_{t-r}\ast g(y_2)\mathbb{1}_{[0,t]}(r)-G_{s-r}\ast g(y_2)\mathbb{1}_{[0,s]}(r)\right)\right.\right. \\
&\left.\left.\left.\left(\sigma(u^{\varepsilon}(r,y_1))\sigma(u^{\varepsilon}(r,y_2))\right)\right.^{\frac{1}{\varepsilon^2}}R\left(\frac{y_1-y_2}{\varepsilon}\right)\mathrm{d}y_1\mathrm{d}y_2\right)^{\frac{p}{2}}\right)^{\frac{2}{p}}\mathrm{d}r.\n\end{split}
$$

Apply the Minkowski inequality, inequality [\(2.7\)](#page-8-1) and Lemma [2.3,](#page-7-0) the above is bounded by

$$
c_{p}\beta^{2}\sigma_{\mathrm{Lip}}^{2}\int_{0}^{T}\int_{\mathbb{R}^{2}}\int_{\mathbb{R}^{2}}\left(G_{t-r}\ast g(y_{1})\mathbb{1}_{[0,t]}(r)-G_{s-r}\ast g(y_{1})\mathbb{1}_{[0,s]}(r)\right) \cdot\left(G_{t-r}\ast g(y_{2})\mathbb{1}_{[0,t]}(r)-G_{s-r}\ast g(y_{2})\mathbb{1}_{[0,s]}(r)\right)\left(\mathbb{E}|u^{\varepsilon}(r,0)|^{p}\right)^{\frac{2}{p}}\frac{1}{\varepsilon^{2}}R\left(\frac{y_{1}-y_{2}}{\varepsilon}\right)\mathrm{d}y_{1}\mathrm{d}y_{2}\mathrm{d}r
$$

$$
\leq C\beta^{2}\sigma_{\mathrm{Lip}}^{2}\int_{0}^{T}\int_{\mathbb{R}^{2}}\int_{\mathbb{R}^{2}}\left(G_{t-r}\ast g(y_{1})\mathbb{1}_{[0,t]}(r)-G_{s-r}\ast g(y_{1})\mathbb{1}_{[0,s]}(r)\right)
$$
\n
$$
\cdot\left(G_{t-r}\ast g(y_{2})\mathbb{1}_{[0,t]}(r)-G_{s-r}\ast g(y_{2})\mathbb{1}_{[0,s]}(r)\right)\frac{1}{\varepsilon^{2}}R\left(\frac{y_{1}-y_{2}}{\varepsilon}\right)\mathrm{d}y_{1}\mathrm{d}y_{2}\mathrm{d}r

\leq C\beta^{2}\sigma_{\mathrm{Lip}}^{2}\int_{0}^{T}\left(\int_{\mathbb{R}^{2}}\int_{\mathbb{R}^{2}}\left(G_{t-r}\ast g(y_{1})\mathbb{1}_{[0,t]}(r)-G_{s-r}\ast g(y_{1})\mathbb{1}_{[0,s]}(r)\right)^{2}\frac{1}{\varepsilon^{2}}R\left(\frac{y_{1}-y_{2}}{\varepsilon}\right)\mathrm{d}y_{1}\mathrm{d}y_{2}\right)^{\frac{1}{2}}
$$

\cdot\left(\int_{\mathbb{R}^{2}}\int_{\mathbb{R}^{2}}\left(G_{t-r}\ast g(y_{2})\mathbb{1}_{[0,t]}(r)-G_{s-r}\ast g(y_{2})\mathbb{1}_{[0,s]}(r)\right)\frac{1}{\varepsilon^{2}}R\left(\frac{y_{1}-y_{2}}{\varepsilon}\right)\mathrm

In the last steps, we applied inequalities  $|1 - e^{-a}| \le \sqrt{a}$  and  $(1 - e^{-a}) \le a$  for all  $a \geq 0$ . The constant *C* may vary at each occurrence.

In the proof, the conditions  $\beta < \beta_0$  and  $\varepsilon < \varepsilon_0$  are given only to validate the use of Lemma [2.3.](#page-7-0) Therefore, we can choose  $\beta_0(p)$  and  $\varepsilon_0$  to be the same value as in Lemma  $2.3.$   $\Box$ 

Choose  $p = 4$ . By [\[19,](#page-24-18) Problem 4.11], the measure induced by  $X^{\varepsilon}(g) =$ <br>  $Z^{\varepsilon}(f \circ \lambda) Q \neq f \circ T$  on  $(G([0, T]) \mathcal{B}(G([0, T]))$  is tight. By [10, Theorem  ${X^{\varepsilon,t}(g); 0 \le t \le T}$  on  $(C([0,T]), \mathscr{B}(C([0,T]))$ ) is tight. By [\[19,](#page-24-18) Theorem 4.15], to prove Theorem [1.2,](#page-2-2) we only need to show the convergence of the finite-dimensional distribution.

**Lemma 4.2.** *Fix*  $0 \le t_1 < \cdots < t_m \le T$ . *As*  $\varepsilon \to 0$ *, the sequence of random vectors*  $(X^{\varepsilon,t_1}(g),...,X^{\varepsilon,t_m}(g))$  *converges in law to the m-dimensional Gaussian centered vector*  $Z = (Z^1, \ldots, Z^m)$  *with covariance* 

$$
C_{i,j} \coloneqq \mathbb{E}(Z^i Z^j) = \beta^2 \mathbb{E}\sigma\left(\Xi_{1,2}(2)\right)^2 \int_0^{t_i \wedge t_j} \int_{\mathbb{R}^2} G_{t_i-s} * g(y) G_{t_j-s} * g(y) \mathrm{d}y \mathrm{d}s.
$$

*Proof.* Recall that we have shown

$$
\left(X^{\varepsilon,t_1}(g),\ldots,X^{\varepsilon,t_m}(g)\right)\stackrel{\text{law}}{=}\left(Y^{\varepsilon,t_1}(g),\ldots,Y^{\varepsilon,t_m}(g)\right),
$$

\mathrm{Y}^{\varepsilon,t_i}(g) = \delta(v_{\varepsilon,t_i}(g)) \in \mathbb{D}^{1,2}
$$

By Proposition [2.9,](#page-12-0) it suffices to show that for each *i, j*,

$$
\mathbb{E}|C_{i,j} - \langle DY^{\varepsilon,t_i}(g), v_{\varepsilon,t_j}(g) \rangle_{\mathcal{H}}|^2 \to 0.
$$

Use  $(3.1)$ , we have

\langle DY^{\varepsilon,t_i}(g), v_{\varepsilon,t_j}(g) \rangle_{\mathcal{H}} = A_{1,\varepsilon}^{i,j} + A_{2,\varepsilon}^{i,j},

= \beta^2 \int_0^{\frac{t_i \wedge t_j}{\varepsilon^2}} \int_{\mathbb{R}^{2 \times 2}} \sigma(\mathcal{V}^{\varepsilon}(s, y_1)) \left( \int_{\mathbb{R}^2} G_{\frac{t_j}{\varepsilon^2} - s}(\frac{x_1}{\varepsilon} - y_1) g(x_1) dx_1 \right)

Following the same arugments as in Section [3,](#page-13-0) we can show

\mathbb{E}\left|A_{2,\varepsilon}^{i,j}\right|^2 \to 0 \quad \text{as } \varepsilon \to 0.
