# Precise Laplace approximation for mixed rough differential equation

#### Abstract

This work focuses on the Laplace approximation for the rough differential equation (RDE) driven by mixed rough path $\left(B^{H}, W\right)$ with $H \in(1 / 3,1 / 2)$ as $\varepsilon \rightarrow 0$. Firstly, based on geometric rough path lifted from mixed fractional Brownian motion ( fBm ), the Schilder-type large deviation principle (LDP) for the law of the first level path of the solution to the RDE is given. Due to the particularity of mixed rough path, the main difficulty in carrying out the Laplace approximation is to prove the Hilbert-Schmidt property for the Hessian matrix of the Itô map restricted on the Cameron-Martin space of the mixed fBm. To this end, we imbed the Cameron-Martin space into a larger Hilbert space, then the Hessian is computable. Subsequently, the probability representation for the Hessian is shown. Finally, the Laplace approximation is constructed, which asserts the more precise asymptotics in the exponential scale.

## 1. Introduction

In this paper, we consider the rough differential equation (RDE) driven by mixed rough paths as follows,

d Y_{t}^{\varepsilon}=\left[\sigma\left(Y_{t}^{\varepsilon}\right) \mid \hat{\sigma}\left(Y_{t}^{\varepsilon}\right)\right] \varepsilon d\left(B^{H}, W\right)_{t}+\beta\left(\varepsilon, Y_{t}^{\varepsilon}\right) d t, \quad Y_{0}^{\varepsilon}=0 \tag{1.1}
\end{equation*}
$$

where $\varepsilon>0$ is a small parameter. And $[\sigma \mid \hat{\sigma}]$ denotes the block matrix with $\sigma \in C_{b}^{\infty}\left(\mathbb{R}^{n}, \operatorname{Mat}\left(n, d_{1}\right)\right)$ and $\hat{\sigma} \in C_{b}^{\infty}\left(\mathbb{R}^{n}, \operatorname{Mat}\left(n, d_{2}\right)\right)$, and $\beta \in C_{b}^{\infty}\left([0,1] \times \mathbb{R}^{n}, \mathbb{R}^{n}\right)$ with $C_{b}^{\infty}$ being the set of bounded smooth functions with bounded derivatives. $\left(B^{H}, W\right)_{t} \in G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$, where $G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$ is the geometric rough path space, represents the mixed geometric rough path, which will be introduced in Section 2. Let $\left(\Omega, \mathcal{F},\left\{\mathcal{F}_{t}\right\}_{t \geq 0}, \mathbb{P}\right)$ be a completely probability space, $\left(b_{t}^{H}\right)_{t \geq 0}$ is $\mathbb{R}^{d_{1}}$-valued fractional Brownian motion (fBm) with Hurst index $H \in(1 / 3,1 / 2),\left(w_{t}\right)_{t \geq 0}$ is $\mathbb{R}^{d_{2}}$-valued Brownian motion $(\mathrm{Bm})$. For each time $t$, we denote by $\mathcal{F}_{t}$ the $\sigma$-field generated by the random variables $\left\{\left(b_{s}^{H}, w_{s}\right), 0 \leq s \leq t\right\}$ and all $\mathbb{P}$-null sets. The expectation with respect to $\mathbb{P}$ is denoted by $\mathbb{E}$. More details about fBm could see [5, 26].

Let $Y^{\varepsilon}=\hat{\Phi}_{\varepsilon}\left(\varepsilon\left(B^{H}, W\right), \lambda\right): G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}+1}\right) \mapsto G \Omega_{p}\left(\mathbb{R}^{n}\right)$ denote the Itô map corresponding to (1.1) with $\lambda_{t}=t$. The purpose of this paper is to prove the Laplace approximation for $Y^{\varepsilon, 1}$ under natural assumptions, the first level path of the solution map,

J(\varepsilon):=\mathbb{E}\left[\exp \left(-\frac{F\left(Y_{t}^{\varepsilon, 1}\right)}{\varepsilon^{2}}\right)\right] \tag{1.2}
\end{equation*}

where $F$ is a suitable real-valued bounded continuous function. See Section 2 for precise assumptions.
Laplace approximation is devised by Pierre-Simon Laplace in 1977. For SDE theory, the origins can be traced back to the Azencott's work on stochastic Taylor expansion [2]. Based on this, Ben Arous gave

[^0]some Laplace short time expansion for Wiener functional [4]. Since then, Laplace approximation has been a central topic in the probability field. Watanabe studied the precise asymptotics of the Schilder-type for some classes of generalized Wiener functionals by Malliavin calculus [30, 29]. Besides, Kusuoka and Stroock presented the asymptotic expansion of certain Wiener functionals as the variance of the Wiener goes to 0 20]. Osajima focused on the asymptotic expansion of the density function of Wiener functionals [21]. For stochastic partial differential equations (SPDEs), it could refer to 28, 9, 13].

However, the abovementioned references focused on the Bm . Different from $\mathrm{Bm}, \mathrm{fBm}$ is self-similar and possesses long-range dependence, which has been applied in some complex systems [5]. Since the fBm is neither a semi-martingale nor a Markov process, it can not be solved by conventional stochastic analysis [26]. Rough path, proposed by Terry Lyons in 1998, considers the path itself and the iterated integral together [23]. It does not need martingale integration theory, Markov property, and filtration theory, but focuses on the real analysis. Hence, it is effective to analyze fBm . More importantly, the central result in rough path theory, Lyons' universal limit theorem, states that the solution map is continuous (and locally Lipschitz) with respect to the topology of geometric rough path space [24]. Up to now, there exist three main formulations to rough path theory, Lyons' original formulation [24], Gubinelli's controlled path theory [10], and Davie's formulation [12, 6]. With the aid of rough path theory, Gaussian processes, including Bm and fBm, can be lifted to geometric rough paths. Therefore, it has been applied to analyze the LDP for Gaussian rough paths, including the Brownian rough path and fBm [22, 25, 11,14 . Further, starting with Aida 3], Inahama and Kawabi studied the Taylor expansion and Laplace approximation for Gaussian rough paths, where the fractional rough paths can be covered [15, 16, 17].

Therefore, we wish to investigate the precise Laplace asymptotics for the first level path of $Y_{t}^{\varepsilon}$. Firstly, we prove that the mixed fBm can be lifted to the mixed geometric rough path. Then, we give the Schilder-type LDP for the laws of the first level path of the solution to the above RDE (1.1), which provides the asymptotics of $J(\varepsilon)$ with $\varepsilon \rightarrow 0$ on logarithmic scale. Furthermore, it proceeds to show the Laplace approximation, providing more precise asymptotics in the exponential scale. Due to the particularty of mixed rough path, the main difficulty in carrying out the Laplace asymptotics is to analyze Hilbert-Schmidt property for the Hessian matrix of the Itô map restricted on the Cameron-Martin space. To this end, we imbed the CameronMartin space into a larger Hilbert space. We prove the Hilbert-Schmidt property with an orthonormal basis in this Hilbert space. Then, the probability representation for the Hessian is analyzed. Finally, the precise Laplace asymptotics for RDE driven by mixed rough path is constructed.

The plan of this paper is as follows. In the next section, we establish notation, give some precise conditions and main result. In Section 3, we state and prove the Schilder-type LDP for the laws of the first level path of the solution to the RDE (1.1). We prove the Hilbert-Schmidt property and probability representation of the Hessian matrix in Section 4 . Finally, Section 5 states the main proof. Throughout this paper, $c, C, C_{\star}$ denote certain positive constants that may vary from line to line. Throughout this paper, we take $t \in[0,1]$. Analogous results hold for any finite time interval.

## 2. Preliminaries and main results

Before introducing the fBm and rough path, we illustrate some information for spaces. Let $B$ be a Banach space with $\operatorname{dim} B<\infty$, such as $B=\mathbb{R}^{d_{1}+d_{2}}$ or $B=\operatorname{Mat}\left(n, d_{1}+d_{2}\right)$. Denote that

C=C([0,1], B)=\{k:[0,1] \rightarrow B \mid \text { continuous }\},
$$

the space of $B$-valued continuous functions with the usual sup-norm. For $p \geq 1, C^{p-v a r}$ is the set of $k \in C$ such that

where $\mathcal{P}$ runs over all the finite partition of $[0,1]$.
Denote $W^{\delta, p}$ with $p>1,0<\delta<1$ the Besov space, for a measurable function $k:[0,1] \rightarrow B$,

Refer to [1], we can see that $W^{\delta, p}$ is given by the interpolation of $W^{1, p}$ and $W^{0, p}=L^{p}$. When $p=2$, $W_{0}^{\delta, 2} \cong L_{0}^{\delta, 2}=\left[W^{1,2}, L^{2}\right]_{1-\delta}$, which can be defined as follows,

then $W_{0}^{\delta, 2}$ and $L_{0, \text { real }}^{\delta, 2}=\left[W^{1,2}, L^{2}\right]_{1-\delta}$ are equivalent Hilbert spaces.

## 2.1. $F B m$ and $B m$

Consider the $\mathbb{R}^{d_{1}}$-valued $\mathrm{fBm}\left(b_{t}^{H}\right)_{t \geq 0}$ with Hurst parameter $H \in(1 / 3,1 / 2)$,

b_{t}^{H}=\left(b_{t}^{H, 1}, b_{t}^{H, 2}, \cdots, b_{t}^{H, d_{1}}\right)
$$

where $\left(b_{t}^{H, i}\right)_{t \geq 0}, i \in\left\{1, \cdots, d_{1}\right\}$ are independent one-dimensional fBms. The above $\mathbb{R}^{d_{1}}$-valued $\mathrm{fBm}\left(b_{t}^{H}\right)_{t \geq 0}$ is a centred Gaussian process, satisfying that

\mathbb{E}\left[b_{t}^{H} b_{s}^{H}\right]=\frac{1}{2}\left[t^{2 H}+s^{2 H}-|t-s|^{2 H}\right] \times I_{d_{1}}, \quad(s, t \geq 0)
$$

and

\mathbb{E}\left[\left(b_{t}^{H}-b_{s}^{H}\right)^{2}\right]=|t-s|^{2 H} \times I_{d_{1}}, \quad(s, t \geq 0)
$$

where $I_{d_{1}}$ is the identity matrix in $\mathbb{R}^{d_{1} \times d_{1}}$. When $H=1 / 2$, it is a standard Bm in $\mathbb{R}^{d_{1}}$. The reproducing kernel Hilbert space for the $\operatorname{fBm}\left(b_{t}^{H}\right)_{t \geq 0}$ denoted by $\mathcal{H}^{H, d_{1}}$.

Then, consider the $\mathbb{R}^{d_{2}}$-valued $\operatorname{Bm}\left(w_{t}\right)_{t \geq 0}$,

where $\left(w_{t}^{i}\right)_{t \geq 0}, i \in\left\{1, \cdots, d_{2}\right\}$ are independent one-dimensional Bms. The reproducing kernel Hilbert space for $\left(w_{t}\right)_{t \geq 0}$, denoted by $\mathcal{H}^{\frac{1}{2}, d_{2}}$, which is defined as follows,

\mathcal{H}^{\frac{1}{2}, d_{2}}:=\left\{\hat{k} \in P\left(\mathbb{R}^{d_{2}}\right) \mid \hat{k}_{t}=\int_{0}^{t} \hat{k}_{s}^{\prime} d s \text { for all } t \text { with }\|\hat{k}\|_{\mathcal{H}^{\frac{1}{2}, d_{2}}}^{2}:=\int_{0}^{1}\left|\hat{k}_{t}^{\prime}\right|_{\mathbb{R}^{d_{2}}}^{2} d t<\infty\right\}
$$

where $P\left(\mathbb{R}^{d_{2}}\right):=\left\{\hat{k} \in C\left([0,1], \mathbb{R}^{d_{2}}\right) \mid \hat{k}_{0}=0\right\}$. Due to [ 17$]$, Proposition 3.4], it has $\mathcal{H}^{H, d_{1}} \hookrightarrow W_{0}^{\delta, 2} \cong L_{0, \text { real }}^{\delta, 2}$.
Let $\mathcal{H}:=\mathcal{H}^{H, d_{1}} \oplus \mathcal{H}^{\frac{1}{2}, d_{2}}$ be the Cameron-Martin subspace of the mixed $\mathrm{fBm}\left(b_{t}^{H}, w_{t}\right)_{0 \leq t \leq 1}$. Hence, $(k, \hat{k}) \in \mathcal{H}$ is of finite $q$-variation with $(H+1 / 2)^{-1}<q<2$.

### 2.2. Rough path

Next, we introduce the geometric rough path. Set $2<p<3$, and $\Delta=\{(s, t) \mid 0 \leq s \leq t \leq 1\}$, for the continuous map $A$ from $\Delta$ to the Banach space $B$, define that

\|A\|_{p-\mathrm{var}}=\left(\sup _{\mathcal{P}} \sum_{i=1}^{n}\left|A_{t_{i-1}, t_{i}}\right|_{B}^{p}\right)^{1 / p}
$$

where $\mathcal{P}$ stands for the finite partition of $[s, t]$.
Denote $B$ be the Banach space, a continuous map

X=\left(1, X^{1}, X^{2}\right): \Delta \rightarrow T^{2}(B)=\mathbb{R} \oplus B \oplus B^{\otimes 2}
$$

is said to be a $B$-valued rough path of roughness 2 if it satisfies the following conditions,
(Condition A): For any $s \leq u \leq t, X_{s, t}=X_{s, u} \otimes X_{u, t}$ where $\otimes$ stands for the tensor product.
(Condition B) For all $1 \leq j \leq[p],\left\|X^{j}\right\|_{p / j-\mathrm{var}}<\infty$.
The 0 -th component 1 is omitted. Therefore, we denote the rough path by $X=\left(X^{1}, X^{2}\right)$. The set of all the $B$-valued rough paths of roughness $2<p<3$ is denoted by $\Omega_{p}(B)$. With the distance $d_{p}(X, Y)=$ $\sum_{i=1}^{\lfloor p\rfloor}\left\|X^{j}-Y^{j}\right\|_{p / j-\mathrm{var}}$, it is a complete space.

For rough path $X$, denote that

\|X\|_{p-\mathrm{var}}=\left\|X^{1}\right\|_{p-\mathrm{var}}+\left\|X^{2}\right\|_{p / 2-\mathrm{var}}^{1 / 2}
$$

Next, for rough paths $X, Y$, for $\kappa>p-1$, define that

d_{p}(X, Y) \leq C \max \left(D_{1, p}(X, Y), D_{1, p}(X, Y)\left(D_{1, p}(X)+D_{1, p}(Y)\right), D_{2, p}(X, Y)\right) \tag{2.2}

Then, from [[24], Section 4.1], it has

\leq c_{1}\left[D_{2, p}(X, Y)^{p / 2}+D_{1, p}(X, Y)^{p / 2}\left(D_{1, p}(X)^{p}+D_{1, p}(Y)^{p}\right)^{1 / 2}\right]
\end{gathered}

where $c_{1}$ is a constant.
And $B$-valued continuous path $x$ with finite variation can be lifted to the rough path $X$, where the $j$-th level path is defined in the following way,

X_{s, t}^{j}=\int_{s \leq t_{1} \leq \cdots \leq t_{j} \leq t} d x_{t_{1}} \otimes d x_{t_{2}} \otimes \cdots \otimes d x_{t_{j}}
$$

The rough path obtained in above way is called smooth rough path. A rough path constructed as the $d_{p}$-limit of a sequence of smooth rough path is called a geometric rough path. The set of all the geometric rough paths is denoted by $G \Omega_{p}(B)$, and it is a complete separable metric space [24].

For any $m \in \mathbb{N}$, consider the $m$-dyadic grid that $t_{l}^{m}=\frac{l}{2^{m}}$ and set $\Delta_{l}^{m}\left(b^{H}, w\right)^{\mathrm{T}}=\left(b^{H}, w\right)_{t_{l}^{m}}^{\mathrm{T}}-\left(b^{H}, w\right)_{t_{l-1}^{m}}^{\mathrm{T}}$ for $0 \leq l \leq 2^{m}$. Then denote by $\left(b^{H}(m), w(m)\right)_{t}$ the process obtained by linear interpolation of $\left(b^{H}, w\right)_{t}^{\mathrm{T}}$ on the $m$ th dyadic grid. So $\left(b^{H}(m), w(m)\right)_{0}=0$ and for $t \in\left[t_{l-1}^{m}, t_{l}^{m}\right]$,

$$

The corresponding smooth rough path $\left(B^{H}(m), W(m)\right)_{s, t}=\left(1,\left(B^{H}(m), W(m)\right)_{s, t}^{1},\left(B^{H}(m), W(m)\right)_{s, t}^{2}\right)$ is built by taking its iterated path integrals, that is

\left(B^{H}(m), W(m)\right)_{s, t}^{j}=\int_{s \leq t_{1} \leq \cdots \leq t_{j} \leq t} d\left(b^{H}(m), w(m)\right)_{t_{1}}^{\mathrm{T}} \otimes d\left(b^{H}(m), w(m)\right)_{t_{2}}^{\mathrm{T}} \otimes \cdots \otimes d\left(b^{H}(m), w(m)\right)_{t_{j}}^{\mathrm{T}} .
$$

For $n \leq m, l=1, \ldots, 2^{n}$

\left(B^{H}(m), W(m)\right)_{t_{l-1}^{n}, t_{l}^{n}}^{1}=\Delta_{l}^{n}\left(b^{H}, w\right)^{\mathrm{T}} \quad \text { for } n \leq m
$$

and when $n \geq m$

\left(B^{H}(m), W(m)\right)_{t_{l-1}^{n}, t_{l}^{n}}^{1}=2^{m-n} \Delta_{\tilde{l}}^{m}\left(b^{H}, w\right)^{\mathrm{T}} \quad \text { for } n \geq m

where $\tilde{l}$ is the unique integer $\tilde{l}$ among $1, \cdots, 2^{m}$.
The second level path $\left(B^{H}(m), W(m)\right)_{s, t}^{2}$ could be defined as follows, when $n \leq m$,
$\left(B^{H}(m), W(m)\right)_{t_{l-1}^{n}, t_{l}^{n}}^{2}=\frac{1}{2} \Delta_{l}^{n}\left(b^{H}, w\right)^{\mathrm{T}} \otimes \Delta_{l}^{n}\left(b^{H}, w\right)^{\mathrm{T}}$

$$
+\frac{1}{2} \sum_{r, s=2^{m-n}(l-1)+1}^{2^{m-n} l}\left(\Delta_{r}^{m}\left(b^{H}, w\right)^{\mathrm{T}} \otimes \Delta_{s}^{m}\left(b^{H}, w\right)^{\mathrm{T}}-\Delta_{s}^{m}\left(b^{H}, w\right)^{\mathrm{T}} \otimes \Delta_{r}^{m}\left(b^{H}, w\right)^{\mathrm{T}}\right)
$$

While for the case of $n \geq m$,

\left(B^{H}(m), W(m)\right)_{t_{l-1}^{n}, t_{l}^{n}}^{2}=2^{2(m-n)-1}\left(\Delta_{\tilde{l}}^{m}\left(b^{H}, w\right)^{\mathrm{T}} \otimes \Delta_{\tilde{l}}^{m}\left(b^{H}, w\right)^{\mathrm{T}}\right)
$$

The smooth rough path $\left(B^{H}(m), W(m)\right)_{s, t}=\left(1,\left(B^{H}(m), W(m)\right)_{s, t}^{1},\left(B^{H}(m), W(m)\right)_{s, t}^{2}\right)$ with order 2 is constructed.

In this paper, the mixed $\operatorname{fBm}\left(b^{H}, w\right)^{\mathrm{T}} \in \mathbb{R}^{d_{1}+d_{2}}$ can be lifted to a geometric rough path $\left(B^{H}, W\right) \in$ $G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$ with roughness $2<p<3$.

Proposition 2.1. Let $\left(b_{t}^{H}, w_{t}\right)_{t \geq 0}^{\mathrm{T}} \in \mathbb{R}^{d_{1}+d_{2}}$ be the mixed fBm with Hurst parameter $1 / 3<H<1 / 2$. Then, for any $2<p<3$ such that $h p>1$, the sequence of its dyadic polygonal approximations $\left(B^{H}(m), W(m)\right)=$ $\left(1,\left(B^{H}(m), W(m)\right)^{1},\left(B^{H}(m), W(m)\right)^{2}\right)$ converges to a unique geometric rough path $\left(B^{H}, W\right)=\left(1,\left(B^{H}, W\right)^{1},\left(B^{H}, W\right)^{2}\right)$ almost surely according to the p-variation.

Proof. For $i=1,2$ and $0 \leq s \leq t \leq 1$, we proceed to prove that

\mathbb{E}\left[\left\|\left(B^{H}(m), W(m)\right)^{j}-\left(B^{H}, W\right)^{j}\right\|_{p / j-\mathrm{var}}^{p / j}\right] \leq C\left(\frac{1}{2^{m}}\right)^{h p / 2-1 / 2} \tag{2.3}

for some constant $C$. Since $p>2$, this implies that

\sum_{m=1}^{\infty}\left\|\left(B^{H}(m), W(m)\right)^{1}-\left(B^{H}, W\right)^{1}\right\|_{p-\mathrm{var}}<\infty, \quad \text { a.s.. } \tag{2.4}

In particular, the sequence of its dyadic polygonal approximations $\left(B^{H}(m), W(m)\right)$ converges to a unique geometric rough path $\left(B^{H}, W\right)$ almost surely according to the $p$-variation.

The subsequent proof consists of two steps.
Step 1. Prove that (2.3) and (2.4) hold for $i=1$. In particular, $\left(B^{H}(m), W(m)\right)^{1}$ converges to $\left(B^{H}, W\right)^{1}$ in $p$-variation almost surely.

### 2.3. Assumptions and main results

Denote $C_{0}^{p-\mathrm{var}}\left(\mathbb{R}^{n}\right)$ the space of continuous paths in $\mathbb{R}^{n}$ with $p$-variation $(2<p<3)$ starting at 0 . Let $Y^{\varepsilon}=\hat{\Phi}_{\varepsilon}\left(\varepsilon\left(B^{H}, W\right), \lambda\right): G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}+1}\right) \mapsto G \Omega_{p}\left(\mathbb{R}^{n}\right)$ denote the Itô map corresponding to (1.1) with $\lambda_{t}=t$. Denote the $Y^{\varepsilon, 1}$ is the first level path of the solution map. Consider the solution map $\hat{\Phi}_{\varepsilon}\left(\varepsilon\left(B^{H}, W\right)+(\gamma, \eta), \lambda\right)$,

A2. The function $F_{\Lambda}:=F \circ \Phi+\|(\cdot, \cdot)\|_{\mathcal{H}}^{2} / 2$ attains its minimum at a unique point $(\gamma, \eta)^{\mathrm{T}} \in \mathcal{H}$, with $\Phi(\gamma, \eta)=\phi^{0}$.

A3. The function $F$ is $m+3$ times Fréchet differentiable on a neighborhood $U\left(\phi^{0}\right)$ with $\phi^{0} \in C_{0}^{p^{\prime}-v a r}\left(\mathbb{R}^{n}\right)$. Furthermore, there exist positive constants $M_{1}, M_{2}, \cdots$ such that

Then, here follows our main result.
Theorem 2.3. Under Assumptions (A1)-(A4), we have the following asymptotic expansion with $\varepsilon \rightarrow 0$. There exist constants $c, \alpha_{0}, \alpha_{1}, \cdots$ s.t.

Remark 2.4. Denote $\tau_{p, p^{\prime}}$ the injection from $C^{p-v a r}\left(\mathbb{R}^{n}\right)$ to $C^{p^{\prime}-v a r}\left(\mathbb{R}^{n}\right)$. Then, we focus on the Laplace approximation for the first level path to the solution map, that is $F\left(\tau_{p, p^{\prime}}\left(Y_{t}^{\varepsilon, 1}\right)\right)$. But for simplicity, we write in the sense that $F\left(Y_{t}^{\varepsilon, 1}\right)$. The another way of saying that one views $F$ as a function on $C^{p-v a r}\left(\mathbb{R}^{n}\right)$, even if it can be done and assumptions (A1)-(A4) remains equivalent.

## 3. Schilder-type large deviation principle

In this section, we prove the Schilder-type LDP for the law of the first leve path of the solution map to the RDE (1.1) with $\varepsilon \rightarrow 0$.

Proposition 3.1. With $\varepsilon \rightarrow 0$, the law of $\varepsilon\left(B^{H}, W\right),\left\{\mathbb{P}_{\varepsilon}^{H}\right\}_{\varepsilon>0}$ satisfies the LDP with the good rate function $I$, which is defined as follows,

Choose $A(m, \varrho)=\left(\sum_{n=m+1}^{\infty} 2^{n}\left(n^{\kappa} / a_{n}\right)^{\frac{\varrho}{\varrho-p}}\right)^{\frac{\varrho-p}{p}}, a_{n}=$ $2^{n p\left(H-\frac{1}{\varrho}-\beta_{1}\right)}$ and $n^{\kappa} \leq C 2^{n p \beta_{2}}$ with $\beta_{2}>0$ and $\beta_{1}+\beta_{2} \in(0,(H-1 / p) / 2)$, we get

(ii) For any $r_{2}, r_{3}>0$, there exists $C_{2}>0$ depending on $r_{2}$ and $r_{3}$ such that if $\|(\gamma, \eta)\|_{q-v a r} \leq r_{2}$ and $\left\|\left\|\varepsilon\left(B^{H}, W\right) \mid\right\|_{p-\mathrm{var}} \leq r_{3}\right.$, then $\| R_{\varepsilon}^{m+1} \|_{p-\mathrm{var}} \leq C_{2}\left(\varepsilon+\| \|\left(B^{H}, W\right)\| \|_{p-\mathrm{var}}\right)^{m+1}$.

Proof. This lemma could be covered by reference 18].
Now, we give the Cameron-Martin theorem for mixed geometric rough path.
Theorem 3.6. (Cameron-Martin theorem for mixed rough path) For any $(k, \hat{k})^{\mathrm{T}} \in \mathcal{H}$, the law of $\left(B^{H}, W\right)$, $\left\{\mathbb{P}_{\varepsilon}^{H}\right\}$ and $\left\{\mathbb{P}_{\varepsilon}^{H}((\cdot, \cdot)+(K, \hat{K}))\right\}$ are mutually absolutely continuous, moreover, for any bounded Borel function $f$ on $G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$,

Proof. $\quad\left(B^{H}(m), W(m)\right)+(K(m), \hat{K}(m))$ is the smooth rough path constructed by $\left(b^{H}(m), w(m)\right)+$ $(k(m), \hat{k}(m))$. Meanwhile, as $m \rightarrow \infty,\left(B^{H}(m), W(m)\right) \rightarrow\left(B^{H}, W\right)$ in $G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$ and $(k(m), \hat{k}(m)) \rightarrow$ $(k, \hat{k})$ with $q$-norm, it is easy to see that (3.41) holds based on the Cameron-Martin theorem for fBm and $\operatorname{Bm}\left(b_{t}^{H}, w_{t}\right)_{t \geq 0}$.

The proof is completed.
Next, we give the Fernique type theorem for the mixed geometric rough path for later use.

## 4. Computation of Hessian

In this section, we set conditions for parameters. Firstly, for the fBm , the Hurst parameter $H \in(1 / 3,1 / 2)$. Then, choose $p$ and $q$ such that

### 4.1. Hilbert-Schmidt property of Hessian

In this subsection, we show the Hilbert-Schmidt property for the Hessian matrix of the Itô map restricted on the Cameron-Martin space $\mathcal{H}$. Throught this section, set $\beta_{0}(y)=\beta(0, y)$.

For fixed $(\gamma, \eta)^{\mathrm{T}} \in C_{0}^{p-\mathrm{var}}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$, set

We have divided the proof for Theorem4.1 into a sequence of lemmas.

Lemma 4.2. Choose appropriate $p$ and $q$. Then, if $p^{\prime} \geq p, \nabla F\left(\phi^{0}\right) \circ V_{2}$ is of trace class for a Fréchet differentiable function $F$. A similar fact holds for $\nabla^{2} F\left(\phi^{0}\right)\left\langle\chi(k, \hat{k})_{t}, \chi(k, \hat{k})_{t}\right\rangle$.

Moreover, $\left((f, \hat{f})^{\mathrm{T}},(k, \hat{k})^{\mathrm{T}}\right) \in C_{0}^{p-\mathrm{var}}\left(\mathbb{R}^{d_{1}+d_{2}}\right) \times C_{0}^{p-\mathrm{var}}\left(\mathbb{R}^{d_{1}+d_{2}}\right) \longmapsto V_{2} \in C_{0}^{p-\mathrm{var}}\left(\mathbb{R}^{n}\right)$ is a bounded bilinear map. Due to the fact that the space $C_{0}^{p-\mathrm{var}}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$ is not separable, consider the abstract Wiener space $\left(\mathcal{X}, \mathcal{H}, \mu^{H}\right)$. The Goodman's theorem (Theorem 4.6, [[19]]]) shows that, its restriction on the CameronMartin space $\mathcal{H}$ is of trace class. The same reasoning applies to the case of $\nabla^{2} F\left(\phi^{0}\right)\left\langle\chi(k, \hat{k})_{t}, \chi(k, \hat{k})_{t}\right\rangle$.

The proof is completed.
Our next concern will be $V_{1}\langle(f, \hat{f}),(k, \hat{k})\rangle$, and it can be rewritten as follows,

Since $\mathcal{H}^{H, d_{1}} \hookrightarrow W_{0}^{\delta, 2} \cong L_{0, \text { real }}^{\delta, 2}$ [17], Proposition 3.4], it has $\mathcal{H} \hookrightarrow L_{0, \text { real }}^{\delta, 2}\left(\mathbb{R}^{d_{1}}\right) \oplus \mathcal{H}^{\frac{1}{2}, d_{2}}$. \left\langle\left(A-A_{1}\right)\left(B^{H}, W\right),\left(B^{H}, W\right)\right\rangle:=\nabla F\left(\phi^{0}\right)\left\langle V_{2}\left(\left(B^{H}, W\right),\left(B^{H}, W\right)\right)\right\rangle
$$

$$
+\nabla^{2} F\left(\phi^{0}\right)\left\langle\chi\left(B^{H}, W\right), \chi\left(B^{H}, W\right)\right\rangle
$$

then by Lemma 4.7 and Lemma 4.6 it follows that $\left\langle\left(A-A_{1}\right)\left(B^{H}, W\right),\left(B^{H}, W\right)\right\rangle$ is the sum of $\operatorname{Tr}(A-$ $\left.A_{1}\right)$ and the second Wiener chaos corresponding to $A-A_{1}$ which is denoted by $\hat{K}_{A-A_{1}}\left(\left(B^{H}, W\right)^{1}\right)$, and $\nabla F\left(\phi^{0}\right)\langle\Theta\rangle \in \mathcal{C}_{2}\left(\mu^{H}\right)$. Hence, define that $\left\{\lambda_{j}\right\}$ and $\left\{\varkappa_{j}\right\}$ are eigenvalues and corresponding (orthonormal) eigenvectors of $A-A_{1}$, and $\left\{\hat{\lambda}_{j}\right\}$ and $\left\{\hat{\varkappa}_{j}\right\}$ are eigenvalues and corresponding (orthonormal) eigenvectors of $A$, we have

& \nabla F(\phi)\left\langle V_{1}\left(B^{H}, W\right)\right\rangle+\left\langle\left(A-A_{1}\right)\left(B^{H}, W\right),\left(B^{H}, W\right)\right\rangle \\
& =\nabla F(\phi)\left\langle V_{1}\left(B^{H}, W\right)\right\rangle+\sum_{j} \lambda_{j}\left\langle e_{j},\left(B^{H}, W\right)_{1}\right\rangle^{2} \\
& =\nabla F(\phi)\left\langle V_{1}\left(B^{H}, W\right)\right\rangle+\hat{K}_{A-A_{1}}\left(\left(B^{H}, W\right)^{1}\right)+\operatorname{Tr}\left(A-A_{1}\right) \\
& =\sum \hat{\lambda}_{j}\left(\left\langle\hat{\varkappa}_{j},\left(B^{H}, W\right)^{1}\right\rangle^{2}-1\right)+\operatorname{Tr}\left(A-A_{1}\right)+\nabla F\left(\phi^{0}\right)\langle\Lambda\rangle
\end{aligned}
$$

where $\left\{\hat{\varkappa}_{j}\right\}_{j=1,2, \ldots}$ are ONB of Cameron-Martin space $\mathcal{H}$, and $\Lambda$ defined in Lemma 4.5 is of finite $p$-variation. Take the above proof into consideration, (4.25) is obtained.

The proof is completed.

## 5. Main proof

Now, we give the proof of our main result.
Proof of Theorem 2.3. By Assumption (A2), $F_{\Lambda}:=F \circ \Phi+\|(\cdot, \cdot)\|_{\mathcal{H}}^{2} / 2$ attains its minimum at a unique point $(\gamma, \eta)^{\mathrm{T}} \in \mathcal{H}$. In the nerghborhood $O \subset G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$ of $(\gamma, \eta)$, there exists a constant $C$ such that

\end{equation*}

for $\varepsilon \in(0,1]$. The above term (5.1) converges to zero as $\varepsilon \rightarrow 0$.
According to the Lemma3.6 set $O=\gamma+U_{\rho}$ where $U_{\rho}=\left\{\left(B^{H}, W\right) \in G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)\left|\left\|\mid\left(B^{H}, W\right)\right\| \|_{p-\mathrm{var}}<\rho\right\}\right.$ for $\rho>0$,

& \int_{\gamma+U_{\rho}} \exp \left(-F\left(\hat{\Phi}_{\varepsilon}\left(\left(B^{H}, W\right), \lambda\right)^{1}\right) / \varepsilon^{2}\right) \mathbb{P}_{\varepsilon}^{H}\left(d\left(B^{H}, W\right)\right) \\
= & \int_{U_{\rho}} \exp \left(-F\left(\hat{\Phi}_{\varepsilon}\left(\left(B^{H}, W\right)+(\gamma, \eta)^{\mathrm{T}}, \lambda\right)^{1}\right) / \varepsilon^{2}\right) \\
& \times \exp \left(-\frac{1}{\varepsilon^{2}}\left\langle(\gamma, \eta)^{\mathrm{T}},\left(B^{H}, W\right)^{1}\right\rangle-\frac{1}{2 \varepsilon^{2}}\|(\gamma, \eta)\|_{\mathcal{H}}^{2}\right) \mathbb{P}_{\varepsilon}^{H}\left(d\left(B^{H}, W\right)\right) \\
= & \int_{\left\{\left\|\left(B^{H}, W\right)\right\|_{p-\operatorname{var}}<\rho\right\}} \exp \left(-\frac{F\left(\phi^{(\varepsilon)}\right)}{\varepsilon^{2}}-\frac{1}{\varepsilon}\left\langle(\gamma, \eta)^{\mathrm{T}},\left(B^{H}, W\right)^{1}\right\rangle\right. \\
& \left.-\frac{1}{2 \varepsilon^{2}}\|(\gamma, \eta)\|_{\mathcal{H}}^{2}\right) \mathbb{P}^{H}\left(d\left(B^{H}, W\right)\right) . \tag{5.2}
\end{align*}
$$

Take the stochastic Taylor expansion for $\phi^{(\varepsilon)}$ in the neighbourhood of $\phi^{(0)}$, one can get

F\left(\phi^{(\varepsilon)}\right)= & F\left(\phi^{0}\right)+\nabla F\left(\phi^{0}\right)\left\langle\phi^{(\varepsilon)}-\phi^{0}\right\rangle+\frac{1}{2} \nabla^{2} F\left(\phi^{0}\right)\left\langle\phi^{(\varepsilon)}-\phi^{0}, \phi^{(\varepsilon)}-\phi^{0}\right\rangle \\
& +\frac{1}{6} \int_{0}^{1} d \theta \nabla^{3} F\left(\theta \phi^{(\varepsilon)}+(1-\theta) \phi^{0}\right)\left\langle\phi^{(\varepsilon)}-\phi^{0}, \phi^{(\varepsilon)}-\phi^{0}, \phi^{(\varepsilon)}-\phi^{0}\right\rangle \\
= & F\left(\phi^{0}\right)+\nabla F\left(\phi^{0}\right)\left\langle\varepsilon \phi^{1}+\varepsilon^{2} \phi^{2}\right\rangle+\frac{1}{2} \nabla^{2} F\left(\phi^{0}\right)\left\langle\varepsilon \phi^{1}, \varepsilon \phi^{1}\right\rangle+Q_{\varepsilon}^{3} . \tag{5.3}
\end{align*}
$$

Due to the result in Lemma 3.5, there exists some constanct $C>0$ such that $\left|Q_{\varepsilon}^{3}\right| \leq C\left(\varepsilon+\left|\left\|\varepsilon\left(B^{H}, W\right) \mid\right\|_{p-\mathrm{var}}\right)^{3}\right.$ on the set $\left\{\left\|\left\|\varepsilon\left(B^{H}, W\right)\right\|\right\|_{p-\mathrm{var}}<\rho_{0}\right\}$.

Consider the term with order -2 in (5.2), due to the Assumption (A2)

-\frac{1}{\varepsilon^{2}}\left(F\left(\phi^{0}\right)+\frac{1}{2}\|(\gamma, \eta)\|_{\mathcal{H}}^{2}\right)=-\frac{a}{\varepsilon^{2}}
$$

For the term of order -1 in (5.2), we have $\phi^{1}: G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right) \mapsto C_{0}^{p-\operatorname{var}}\left(\mathbb{R}^{n}\right)$, and it satisfies the following differential equation,

= & {\left[\sigma\left(\phi_{t}^{0}\right) \mid \hat{\sigma}\left(\phi_{t}^{0}\right)\right] d\left(k_{t}, \hat{k}_{t}\right)^{\mathrm{T}}+\nabla_{\varepsilon} \beta\left(0, \phi_{t}^{0}\right) d t, \quad \phi_{0}^{1}=0 } \tag{5.4}
\end{align*}

Then, set $\theta^{1}(k, \hat{k})_{t}=\phi^{1}(k, \hat{k})_{t}-\chi(k, \hat{k})_{t}$, where

\end{equation*}

By the Assumption (A2), we conclude that

\langle(k, \hat{k}),(\gamma, \eta)\rangle_{\mathcal{H}}+\nabla F\left(\phi^{0}\right)\langle\chi(k, \hat{k})\rangle=0 \tag{5.6}
\end{equation*}
$$

Then, $\theta^{1}(k, \hat{k})_{t}$ satisfies the following differential equation,

& d \theta_{t}^{1}-\left[\nabla \sigma\left(\phi_{s}^{0}\right) \mid \nabla \hat{\sigma}\left(\phi_{s}^{0}\right)\right]\left\langle\theta_{t}^{1}, d\left(\gamma_{t}, \eta_{t}\right)^{\mathrm{T}}\right\rangle-\nabla_{y} \beta\left(0, \phi_{t}^{0}\right)\left\langle\theta_{t}^{1}, 1\right\rangle d t \\
= & \nabla_{\varepsilon} \beta\left(0, \phi_{t}^{0}\right) d t, \quad \theta_{0}^{1}=0, \tag{5.7}
\end{align*}
$$

its solution can be rewritten as $\theta_{t}^{1}=M_{t} \int_{0}^{t} M_{s}^{-1} \nabla_{\varepsilon} \beta\left(0, \phi_{s}^{0}\right) d s$, then, $\theta^{1}\left(B^{H}, W\right)_{t}$ is independent of $\left(B^{H}, W\right)$ and of finite $q$-variation.

Hence, with (5.6) and straightforward computation, it deduces that

Next, we focus on the term of order 0 in (5.2), it has

& d \phi_{t}^{2}-\left[\nabla \sigma\left(\phi_{s}^{0}\right) \mid \nabla \hat{\sigma}\left(\phi_{s}^{0}\right)\right]\left\langle\phi_{t}^{2}, d\left(\gamma_{t}, \eta_{t}\right)^{\mathrm{T}}\right\rangle-\nabla_{y} \beta\left(0, \phi_{t}^{0}\right)\left\langle\phi_{t}^{2}, 1\right\rangle d t \\
= & {\left[\nabla \sigma\left(\phi_{s}^{0}\right) \mid \nabla \hat{\sigma}\left(\phi_{s}^{0}\right)\right]\left\langle\phi_{t}^{1}, d\left(k_{t}, \hat{k}_{t}\right)^{\mathrm{T}}\right\rangle+\frac{1}{2}\left[\nabla^{2} \sigma\left(\phi_{t}^{0}\right) \mid \nabla^{2} \hat{\sigma}\left(\phi_{t}^{0}\right)\right]\left\langle\phi_{t}^{1}, \phi_{t}^{1}, d\left(\gamma_{t}, \eta_{t}\right)^{\mathrm{T}}\right\rangle } \\
& +\frac{1}{2} \nabla_{y}^{2} \beta\left(0, \phi_{t}^{0}\right)\left\langle\phi_{t}^{1}, \phi_{t}^{1}\right\rangle d t+\nabla_{y} \nabla_{\varepsilon} \beta\left(0, \phi_{t}^{0}\right)\left\langle\phi_{t}^{1}, 1\right\rangle d t \\
& +\frac{1}{2} \nabla_{\varepsilon}^{2} \beta\left(0, \phi_{t}^{0}\right) d t, \quad \phi_{0}^{2}=0 . \tag{5.8}
\end{align*}

Then, $\chi$ and $\psi$ extend to continuous maps from $G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$, and rewrite that $\chi\left(B^{H}, W\right)$ and $\psi\left(\left(B^{H}, W\right),\left(B^{H}, W\right)\right)$.
Consequently, we set $\theta^{2}(k, \hat{k})_{t}=\phi^{2}(k, \hat{k})_{t}-\psi^{2}((k, \hat{k}),(k, \hat{k}))_{t} / 2$, where

& d \psi_{t}-\left[\nabla \sigma\left(\phi_{t}^{0}\right) \mid \nabla \hat{\sigma}\left(\phi_{t}^{0}\right)\right]\left\langle\psi_{t}, d\left(\gamma_{t}, \eta_{t}\right)^{\mathrm{T}}\right\rangle-\nabla_{y} \beta\left(0, \phi_{t}^{0}\right)\left\langle\psi_{t}, 1\right\rangle d t \\
= & 2\left[\nabla \sigma\left(\phi_{t}^{0}\right) \mid \nabla \hat{\sigma}\left(\phi_{t}^{0}\right)\right]\left\langle\chi(k, \hat{k})_{t}, d\left(k_{t}, \hat{k}_{t} \mathrm{~T}^{\mathrm{T}}\right\rangle\right. \\
& +\left[\nabla^{2} \sigma\left(\phi_{t}^{0}\right) \mid \nabla^{2} \hat{\sigma}\left(\phi_{t}^{0}\right)\right]\left\langle\chi(k, \hat{k})_{t}, \chi(k, \hat{k})_{t}, d\left(\gamma_{t}, \eta_{t}\right)^{\mathrm{T}}\right\rangle \\
& +\nabla^{2} \beta_{0}\left(\phi_{t}^{0}\right)\left\langle\chi(k, \hat{k})_{t}, \chi(k, \hat{k})_{t}\right\rangle d t, \quad \psi_{0}=0 . \tag{5.9}
\end{align*}
$$

And $\theta^{2}(k, \hat{k})_{t}$ statifies the differential equation as follows,

= & {\left[\nabla \sigma\left(\phi_{t}^{0}\right) \mid \nabla \hat{\sigma}\left(\phi_{t}^{0}\right)\right]\left\langle\theta_{t}^{1}, d\left(k_{t}, \hat{k}_{t}\right)^{\mathrm{T}}\right\rangle+\frac{1}{2}\left[\nabla^{2} \sigma\left(\phi_{t}^{0}\right) \mid \nabla^{2} \hat{\sigma}\left(\phi_{t}^{0}\right)\right]\left\langle\theta_{t}^{1}, \theta_{t}^{1}, d\left(\gamma_{t}, \eta_{t}\right)^{\mathrm{T}}\right\rangle } \\
& +\left[\nabla^{2} \sigma\left(\phi_{t}^{0}\right) \mid \nabla^{2} \hat{\sigma}\left(\phi_{t}^{0}\right)\right]\left\langle\theta_{t}^{1}, \chi_{t}, d\left(\gamma_{t}, \eta_{t}\right)^{\mathrm{T}}\right\rangle \\
& +\frac{1}{2} \nabla_{y}^{2} \beta\left(\phi_{t}^{0}\right)\left\langle\theta_{t}^{1}, \theta_{t}^{1}\right\rangle d t+\nabla_{y}^{2} \beta\left(\phi_{t}^{0}\right)\left\langle\theta_{t}^{1}, \chi_{t}\right\rangle d t \\
& +\nabla_{y} \nabla_{\varepsilon} \beta\left(\phi_{t}^{0}\right)\left\langle\theta_{t}^{1}+\chi_{t}\right\rangle d t+\frac{1}{2} \nabla_{\varepsilon}^{2} \beta\left(0, \phi_{t}^{0}\right) d t, \quad \theta_{0}^{2}=0 . \tag{5.10}

Equivalently, its solution can be rewritten as

& +\frac{1}{2} \nabla_{y}^{2} \beta\left(\phi_{s}^{0}\right)\left\langle\theta_{s}^{1}, \theta_{s}^{1}\right\rangle d s+\nabla_{y}^{2} \beta\left(\phi_{s}^{0}\right)\left\langle\theta_{s}^{1}, \chi_{s}\right\rangle d s \\
& \left.+\nabla_{y} \nabla_{\varepsilon} \beta\left(\phi_{s}^{0}\right)\left\langle\theta_{s}^{1}+\chi_{s}\right\rangle d s+\frac{1}{2} \nabla_{\varepsilon}^{2} \beta\left(0, \phi_{s}^{0}\right) d s\right] \tag{5.11}

So, $\theta^{2}((k, \hat{k}),(k, \hat{k}))$ extends a map from $G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$ to $C_{0}^{p-v a r}\left(\mathbb{R}^{n}\right)$. Moreover, from Lemma 3.5, for some constant $C>0$, it has $\left\|\theta^{2}\left(B^{H}, W\right)\right\|_{p-\mathrm{var}} \leq C\left(1+\| \|\left(B^{H}, W\right)\| \|_{p-\mathrm{var}}\right)$ with $\left(B^{H}, W\right) \in G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)$. By the Lemma 3.2, it follows that $\theta^{2}\left(B^{H}, W\right)$ is exponential integrable.

By Lemma 3.5, Lemma 3.2 and Theorem 4.1, it deduces that

\exp \left(-\nabla F\left(\phi^{0}\right)\left\langle\phi^{2}\right\rangle-\frac{1}{2} \nabla^{2} F\left(\phi^{0}\right)\left\langle\phi^{1}, \phi^{1}\right\rangle\right) \in L^{r}\left(G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right), \mathbb{P}^{H}\right), \quad r>1
$$

When $\varepsilon \leq \rho$, it has

& \mathbf{1}_{\left\{\left\|\varepsilon\left(B^{H}, W\right)\right\|_{p-\mathrm{var}}<\rho\right\}} \exp \left(-\nabla F\left(\phi^{0}\right)\left\langle\phi^{2}\right\rangle-\frac{1}{2} \nabla^{2} F\left(\phi^{0}\right)\left\langle\phi^{1}, \phi^{1}\right\rangle\right) \exp \left(-\varepsilon^{-2} Q_{\varepsilon}^{3}\right) \\
\leq & \exp \left(-\nabla F\left(\phi^{0}\right)\left\langle\phi^{2}\right\rangle-\frac{1}{2} \nabla^{2} F\left(\phi^{0}\right)\left\langle\phi^{1}, \phi^{1}\right\rangle\right) \exp \left[2 C \rho\left(1+\| \|\left(B^{H}, W\right)\| \|_{p-\mathrm{var}}\right)^{2}\right] . \tag{5.12}
\end{align*}
$$

The dominated convergence theorem yields that

\lim _{\varepsilon \rightarrow 0} \int_{\left\{\left\|\varepsilon\left(B^{H}, W\right)\right\|_{p-\mathrm{var}}<\rho\right\}} \exp \left(-\nabla F\left(\phi^{0}\right)\left\langle\phi^{2}\right\rangle-\frac{1}{2} \nabla^{2} F\left(\phi^{0}\right)\left\langle\phi^{1}, \phi^{1}\right\rangle-\frac{1}{\varepsilon^{2}} Q_{\varepsilon}^{3}\right) \mathbb{P}^{H}\left(d\left(B^{H}, W\right)\right) \\
=\int_{G \Omega_{p}\left(\mathbb{R}^{d_{1}+d_{2}}\right)} \exp \left(-\nabla F\left(\phi^{0}\right)\left\langle\phi^{2}\right\rangle-\frac{1}{2} \nabla^{2} F\left(\phi^{0}\right)\left\langle\phi^{1}, \phi^{1}\right\rangle\right) \mathbb{P}^{H}\left(d\left(B^{H}, W\right)\right) \tag{5.13}
\end{array}
$$

By Lemma 4.8, the right-hand side of (5.13) exists, then the coefficient $\alpha_{0}$ can be defined in the following sense,

\alpha_{0}=\exp \left[-\frac{1}{2}\left(\operatorname{Tr}\left(A-A_{1}\right)+\nabla F\left(\phi^{0}\right)\langle\Lambda\rangle\right)\right] \cdot \operatorname{det}\left(\operatorname{Id}_{\mathcal{H}}+A\right)^{-1 / 2} \tag{5.14}
\end{equation*}
$$

where $\Lambda$ is of finite $p$-variation.
The proof is completed.
