## <span id="page-0-4"></span>BEHAVIOR OF KREISS BOUNDED  $C_0$ -SEMIGROUPS ON A HILBERT SPACE

## L. ARNOLD

ABSTRACT. Let  $0 < \alpha \leq 1$ . We prove that a  $\alpha$ -Kreiss bounded  $C_0$  semigroup  $(T_t)_{t>0}$ on a Hilbert space has asymptotics  $||T_t|| = O(t^{\alpha}/\sqrt{log(t)})$ . Then, we give an application to perturbed wave equation.

Let  $-A$  be the generator of a  $C_0$ -semigroup  $(T_t)_{t>0}$  on a complex Banach space X. For  $\alpha > 0$ , we say that  $(T_t)_{t\geq 0}$  is  $\alpha$ -Kreiss bounded (or simply Kreiss bounded when  $\alpha = 1$ ) if  $\sigma(A) \subset \overline{\mathbb{C}_+} = {\lambda \in \mathbb{C} : \text{Re}(\lambda) \geq 0}$  and

$$
||R(\lambda, A)|| \leq \frac{C}{(-\text{Re}(\lambda))^{\alpha}}, \quad \forall \text{Re}(\lambda) < 0.
$$

According to [\[5,](#page-4-0) (2.6)] (see also [\[8,](#page-4-1) Theorem 1.1.(1)]), if  $(T_t)_{t>0}$  is an  $\alpha$ -Kreiss bounded C<sub>0</sub>-semigroup on a Hilbert space for  $\alpha > 0$ , then  $||T_t|| = O(\overline{t}^{\alpha})$ . Let us fix  $\gamma \in (0, 1)$ . In [\[3\]](#page-4-2), the authors give an example (see [\[3,](#page-4-2) Example 4.4.]) of Kreiss bounded  $C_0$ semigroup for which there exists a constant  $C > 0$  such that  $||T_t|| \geq Ct^{\gamma}$  for  $t \geq 1$ . A natural question (listed as an open question in [\[7,](#page-4-3) Appendix B]) is whether the estimate  $||T_t|| = O(t^{\alpha})$ , for  $\alpha$ -Kreiss bounded  $C_0$ -semigroup  $(T_t)_{t\geq0}$  on a Hilbert space, is sharp. In the following we answer this question for  $\alpha \in (0,1]$ .

<span id="page-0-0"></span>**Theorem 1.** Let  $0 < \alpha \leq 1$  and let  $-A$  be the generator of  $\alpha$ -Kreiss bounded  $C_0$ semigroup  $(T_t)_{t\geq0}$  on a Hilbert space. Then

(2) 
$$
||T_t|| = \mathop{\mathcal{O}}_{t\to\infty} \left( t^{\alpha} / \sqrt{\log(t)} \right).
$$

The proof of the Theorem [1](#page-0-0) is based on techniques given in [\[2\]](#page-4-4). We first state and prove two lemmas. It is known (see [\[4\]](#page-4-5) or [\[9\]](#page-4-6)) that a  $C_0$ -semigroup  $(T_t)_{t\geq0}$  on a Hilbert space, with negative generator A, is bounded if and only if

$$
||R(-r+i \cdot, A)x||_{L^{2}(\mathbb{R}, H)}^{2} \leq \frac{C}{r} ||x||^{2}, \quad r > 0
$$

and

$$
||R(-r+i \cdot, A^*)x^*||_{L^2(\mathbb{R}, H)}^2 \leq \frac{C}{r} ||x^*||^2, \quad r > 0.
$$

The following lemma gives an analogous necessary condition for a  $C_0$ -semigroup to be  $\alpha$ -Kreiss bounded, for  $\alpha > 0$ .

<span id="page-0-3"></span>**Lemma 2.** Let  $\alpha > 0$  and  $(T_t)_{t>0}$  be a  $C_0$ -semigroup on a Hilbert space whose negative generator A. Assume  $(T_t)_{t>0}$  is  $\alpha$ -Kreiss bounded then

(3) 
$$
||R(-r+i \cdot, A)x||_{L^{2}(\mathbb{R}, H)}^{2} \leq \frac{C(1+r^{\alpha})^{2}}{r^{2\alpha}} ||x||^{2}, \quad r > 0
$$

and

(4) 
$$
||R(-r+i \cdot, A^*)x^*||_{L^2(\mathbb{R},H)}^2 \leq \frac{C(1+r^{\alpha})^2}{r^{2\alpha}} ||x^*||, \quad r > 0.
$$

*Proof.* Let  $x \in H$ . First, we by [\[6,](#page-4-7) formula (7.1) section 1.7], we have

$$
R(-r+i\beta, A)x = -\int_0^\infty e^{i\beta s} e^{-rs} T_s x ds, \quad r > 0, \beta \in \mathbb{R}.
$$

This means that for  $r > 0$ ,

(5) 
$$
R(-r+i\beta, A)x = -\mathcal{F}^{-1}(s \mapsto e^{-rs}T_sx)(\beta),
$$

where  $\mathcal{F}: L^2(\mathbb{R}, H) \mapsto L^2(\mathbb{R}, H)$  is the Fourier-Plancherel operator. By Fourier-Plancherel Theorem

<span id="page-1-3"></span>(6) 
$$
\left\|\mathcal{F}^{-1}(s \mapsto e^{-rs}T_s x)(\cdot)\right\|_{L^2(\mathbb{R},H)} = \frac{1}{\sqrt{2\pi}} \left\|e^{-r \cdot T}T_{(\cdot)}x\right\|_{L^2(\mathbb{R}_+,H)}.
$$

The Gearhart-Prüss Theorem (see [\[1,](#page-4-8) Theorem 5.2.1.]) says that for each  $r > 0$ ,  $\sup \|e^{-rt}T_t\| < \infty$ . This implies that there exists  $K > 0$  such that  $t>0$ 

<span id="page-1-0"></span>
$$
\sup_{a>1} ||e^{-a}T_{(\cdot)}x||_{L^2(\mathbb{R}_+,H)} \le K ||x||
$$

and then

(7) 
$$
\sup_{a>1} \|R(-a+i\beta,A)x\|_{L^2(\mathbb{R}_+,H)} \leq \frac{K}{\sqrt{2\pi}} \|x\|.
$$

Now, let  $r > 0$  and  $a = r + 1 > 1$ . By the resolvent identity, we have, for  $\beta \in \mathbb{R}$ ,

$$
R(-r+i\beta, A)x = (I + (r-a)R(-r+i\beta, A))R(-a+i\beta, A)x
$$
  
=  $(I - R(-r+i\beta, A))R(-a+i\beta, A)x.$ 

Using  $(1)$  and  $(7)$ :

$$
||R(-r+i \cdot, A)x||_{L^{2}(\mathbb{R}, H)}^{2} \leq (1 + \sup_{\beta \in \mathbb{R}} ||R(-r+i\beta, A)||)^{2} \sup_{a' < -1} ||R(-a'+i \cdot, A)x||_{L^{2}(\mathbb{R}_{+}, H)}^{2}
$$
  

$$
\leq 2\pi K^{2} \Big(1 + \frac{C}{r^{\alpha}}\Big)^{2} ||x||^{2}
$$
  

$$
\leq C' \frac{(1+r^{\alpha})^{2}}{r^{2\alpha}} ||x||^{2}.
$$

In the same way we obtain  $(4)$ .

The next lemma says that if  $(T_t)_{t\geq 0}$  and  $(T_t^*)_{t\geq 0}$  satisfy a kind of Cesàro condition then  $||T_t||$  satisfy [\(2\)](#page-0-2).

<span id="page-1-4"></span>**Lemma 3.** Let  $\alpha \in (0,1)$  and  $(T_t)_{t\geq 0}$  be a  $C_0$ -semigroup on a Banach space X. Assume that there exists  $C > 0$  such that for each  $t > 1$ ,

$$
\int_0^t \|T_s x\|^2 \, ds \le C t^{2\alpha} \|x\|^2 \,, \quad x \in X,
$$

and

$$
\int_0^t \|T_s^* x^*\|^2 ds \le C t^{2\alpha} \|x^*\|^2, \quad x^* \in X^*.
$$
  
  $T_s \mathbb{I} = \mathcal{O}(t^{\alpha/2}) \sqrt{\log(t)}$ 

Then,  $||T_t|| = O(t^{\alpha}/\sqrt{\log(t)})$ .

 $\Box$ 

*Proof.* Let  $t > 2$  and  $1 < P < Q < t$ . We have

$$
(Q - P)^{2} |\langle T_{t}x, x^{*} \rangle|^{2} = \Big| \int_{P}^{Q} \langle T_{t-s}x, T_{s}^{*}x^{*} \rangle ds \Big|^{2}
$$
  
\n
$$
\leq \Big( \int_{P}^{Q} \|T_{t-s}x\|^{2} ds \Big) \Big( \int_{P}^{Q} \|T_{s}^{*}x^{*}\|^{2} ds \Big)
$$
  
\n
$$
\leq \Big( \int_{P}^{Q} \|T_{t-s}x\|^{2} ds \Big) \Big( \int_{0}^{Q} \|T_{s}^{*}x^{*}\|^{2} ds \Big)
$$
  
\n
$$
\leq CQ^{2\alpha} \|x^{*}\|^{2} \Big( \int_{t-Q}^{t-P} \|T_{s}x\|^{2} ds \Big)
$$

Finally taking the supremum over  $\{|x^*\|=1\}$  one obtains, since  $\alpha \in (0,1],$ 

<span id="page-2-0"></span>(8) 
$$
\frac{(Q-P)^2}{Q^2} ||T_t x||^2 \le C Q^{2(\alpha-1)} \int_{t-Q}^{t-P} ||T_s x||^2 ds
$$

$$
\le C \int_{t-Q}^{t-P} ||T_s x||^2 ds
$$

Now we set  $L := |log(t)/log(2)|$ . For  $0 \le l \le L - 1$ ,  $Q = 2^{l+1}$  and  $P = 2^l$  we have

$$
||T_t x||^2 \le 4C \int_{t-2^{l+1}}^{t-2^l} ||T_s x||^2 ds
$$

Therefore

$$
L \|T_t x\|^2 = \sum_{l=0}^{L-1} \|T_t x\|^2 \le \sum_{l=0}^{L-1} 4C \int_{t-2^{l+1}}^{t-2^l} \|T_s x\|^p ds \le 4C \int_0^t \|T_s x\|^2 ds \le 4C^2 t^{2\alpha}
$$

Hence for  $t > 2$ ,

$$
||T_tx|| \leq \frac{2Ct^{\alpha}}{\sqrt{L}} ||x|| \leq \frac{C't^{\alpha}}{\sqrt{log(t)}} ||x||.
$$



We are now ready to prove Theorem [1.](#page-0-0)

*Proof of Theorem [1.](#page-0-0)* Let  $x \in H$  and  $r > 0$ . By [\(5\)](#page-1-2), [\(6\)](#page-1-3) and Lemma [2,](#page-0-3)

$$
\left\|e^{-r\cdot}T_{(\cdot)}x\right\|_{L^2(\mathbb{R}_+,H)}^2 = \|R(-r+i\cdot,A)x\|_{L^2(\mathbb{R},H)}^2 \leq \frac{C(1+r^{\alpha})^2}{r^{2\alpha}}\left\|x\right\|^2.
$$

Furthermore

$$
\left\|e^{-r\cdot}T_{(\cdot)}x\right\|_{L^2(\mathbb{R}_+,H)}^2 = \int_{\mathbb{R}} e^{-2rs} \left\|T_s x\right\|^2 ds \ge e^{-2rt} \int_0^t \left\|T_s x\right\|^2 ds.
$$

Taking  $t = \frac{1}{r}$  we obtain

$$
\int_0^t \|T_s x\|^2 ds \le Ce^2 t^{2\alpha} \left(1 + \frac{1}{t^{\alpha}}\right)^2 \|x\|^2.
$$

Hence, for  $t > 1$ ,

$$
\int_0^t \|T_s x\|^2 ds \le C' t^{2\alpha} \|x\|^2,
$$

where  $C' = 4e^2C$ . Similarly, since  $(T_t^*)_{t \geq 0}$  is Kreiss bounded  $C_0$ -semigroup on a Hilbert space, for  $t > 1$  and  $x^* \in H$ , we have

$$
\int_0^t \|T_s^*x^*\|^2 ds \le C't^{2\alpha} \|x^*\|^2.
$$

Finally, Lemma [3](#page-1-4) allows us to conclude that  $||T_t|| = \mathcal{O}(t^{\alpha}/\sqrt{\log(t)})$ .

## **Remark 4.** (1) When  $\alpha > 1$ , [\(8\)](#page-2-0) with  $Q = 2$  and  $P = 1$  gives  $||T_t x||^2 \leq C 2^{\alpha} \int_{t-1}^{t-1}$  $t-2$  $||T_s x||^2 ds \leq C' \int_0^t$ 0  $||T_s x||^2 ds \leq C'' t^{2\alpha} ||x||^2.$

Then  $||T_t|| = O(t^{\alpha})$ , which gives another proof of [\[8,](#page-4-1) Theorem 1.1.(1) with  $g(s) =$  $s^{\alpha}$  for  $\alpha > 1$ .

(2) Let us notice that if  $(T_t)_{t>0}$  satisfies the  $\alpha$ -Kreiss bounded condition only for  $\text{Re}(\lambda) \in (0,1)$  that is

$$
||R(\lambda, A)|| \le \frac{C}{-\text{Re}(\lambda)^{\alpha}}, \quad \forall \,\text{Re}(\lambda) \in (-1, 0),
$$

then the conclusion  $||T_t|| = O(t^{\alpha}/\sqrt{log(t)})$  remains true.

Let give an application of the Theorem [1.](#page-0-0) Let  $W^{2,s}(\mathbb{T}^2)$  be the second order Sobolev space equipped with the standard norm. Let A be the operator with domain  $D(A)$  $W^{2,2}(\mathbb{T}^2) \times W^{2,1}(\mathbb{T}^2)$  defined by

$$
A = \begin{pmatrix} 0 & -1 \\ -\Delta - M \frac{\partial}{\partial x} & 0 \end{pmatrix},
$$

where  $\Delta$  is the Laplacian with  $D(\Delta) = W^{2,2}(\mathbb{T}^2)$  and  $M : L^2(\mathbb{T}^2) \to L^2(\mathbb{T}^2)$  is the multiplication operator given by  $M(h)(x, y) = e^{iy}h(x, y)$ . Then, it is known (see [\[8,](#page-4-1) section 4] for details) that  $-A$  generates a  $C_0$ -group  $(T_t)_{t\in\mathbb{R}}$  on the Hilbert space  $H =$  $W^{1,2}(\mathbb{T}^2) \times L^2(\mathbb{T}^2)$  $W^{1,2}(\mathbb{T}^2) \times L^2(\mathbb{T}^2)$  $W^{1,2}(\mathbb{T}^2) \times L^2(\mathbb{T}^2)$ , satisfying  $||T_t|| = \mathcal{O}_{\mathbb{Z}^2}(|t|e^{|t|/2})$ . With Theorem 1, we are able to improve this estimate:

**Proposition 5.** Let  $(T_t)_{t \in \mathbb{R}}$  be the  $C_0$ -group on H generated by  $-A$ . Then

(9) 
$$
||T_t|| = \mathop{\mathcal{O}}_{t \to \pm \infty} \left( \frac{|t|}{\sqrt{\log(|t|)}} e^{|t|/2} \right)
$$

*Proof.* According to [\[8,](#page-4-1) Lemma 4.4.], for  $\lambda \in \mathbb{C}_+$ , with  $\text{Re}(\lambda) \in (0,1)$ ,

<span id="page-3-0"></span>
$$
\left\| R\left(\lambda, A + \frac{1}{2}\right) \right\| \le \frac{C}{-\text{Re}(\lambda)} \quad \text{and} \quad \left\| R\left(\lambda, -A + \frac{1}{2}\right) \right\| \le \frac{C}{-\text{Re}(\lambda)}.
$$

.

Then, according to Remark [4](#page-0-4) (2), the semigroup  $(e^{-1/2t}T_t)_{t\geq 0}$  (resp.  $(e^{-1/2t}T_{-t})_{t\geq 0}$ ) which is generated by  $-(A + \frac{1}{2})$  $(\frac{1}{2})$  (resp.  $A + \frac{1}{2}$ )  $\frac{1}{2}$ , satisfies  $||e^{-1/2t}T_t|| = \mathcal{O}(t/\sqrt{\log(t)})$ (resp.  $||e^{-1/2t}T_{-t}|| = \mathcal{O}(t/\sqrt{\log(t)}))$ . This yields the estimate [\(9\)](#page-3-0).  $\Box$
