# A Simple and Tighter Derivation of Achievability for Classical Communication over Quantum Channels

ABSTRACT. Achievability in information theory refers to demonstrating a coding strategy that accomplishes a prescribed performance benchmark for the underlying task. In quantum information theory, the crafted Hayashi–Nagaoka operator inequality is an essential technique in proving a wealth of one-shot achievability bounds since it effectively resembles a union bound in various problems. In this work, we show that the so-called pretty-good measurement naturally plays a role as the union bound as well. A judicious application of it considerably simplifies the derivation of one-shot achievability for classical-quantum channel coding via an elegant three-line proof.

The proposed analysis enjoys the following favorable features: (i) The established one-shot bound admits a closed-form expression as in the celebrated Holevo–Helstrom Theorem. Namely, the average error probability of sending M messages through a classical-quantum channel is upper bounded by the error of distinguishing the joint state between channel input and output against (M-1)-many products of its marginals. (ii) Our bound directly yields asymptotic achievability results in the large deviation, small deviation, and moderate deviation regimes in a unified manner. (iii) The coefficients incurred in applying the Hayashi–Nagaoka operator inequality or the quantum union bound are no longer needed. Hence, the derived one-shot bound sharpens existing results that rely on the Hayashi–Nagaoka operator inequality. In particular, we obtain the tightest achievable  $\varepsilon$ -one-shot capacity for classical-quantum channel heretofore, and it improves the third-order coding rate in the asymptotic scenario. (iv) Our result holds for infinite-dimensional Hilbert space. (v) The proposed method applies to deriving one-shot achievability for classical data compression with quantum side information, entanglement-assisted classical communication over quantum channels, and various quantum network information-processing protocols.

#### 1. Introduction

One-shot quantum information theory concerns the scenario that no structural assumptions are imposed on the underlying state or channel. For instance, without independent and identical (i.i.d.) repetitions of the channel, conventional methods based on typical projections used in the Holevo–Schumacher–Westmoreland Theorem [1–6] may not be applicable. Hence more refined and sophisticated techniques are requisite for one-shot analysis. To the best of our knowledge, the first<sup>1</sup> one-shot achievability analysis in quantum information theory was made by Burnashev and Holevo [33] in studying pure-state classical-quantum (c-q) channels (based on a Gram matrix technique), and a one-shot strong converse for c-q channel coding was proved by Ogawa and Nagaoka [34] via extending Arimoto's approach [35] to the non-commutative scenario. A one-shot achievability analysis for general c-q channels (without the memoryless condition) was proposed by Hayashi and Nagaoka, in which, a powerful operator inequality [36, Lemma 2] was proved for any positive semi-definite operators  $0 \le A \le 1$  and  $B \ge 0$ :

$$1 - \frac{A}{A+B} \le (1+c)(I-A) + (2+c+c^{-1})B, \quad \forall c > 0,$$
 (1)

where we denote a noncommutative quotient by

$$\frac{A}{B} := B^{-\frac{1}{2}} A B^{-\frac{1}{2}} \tag{2}$$

(here, the inverse is defined only on the support of the denominator operator). At the first glimpse of (1), it is not obvious how it is applied in analyzing the error probability in channel coding; nonetheless, an ingenious application of it by Hayashi and Nagaoka [36] yields a Feinstein's type bound for achieving the c-q channel capacity [37], [38, Theorem 1]. Later, Oskouei, Mancini and Wilde interpreted that Hayashi and Nagaoka's operator inequality resembles a union bound, and therefore a quantum union bound with similar coefficients as in (1) was proved [39]. Subsequently, Hayashi and Nagaoka's analysis based on (1) lays a technical cornerstone in a wealth of one-shot and asymptotic achievability results in quantum information theory wherein a quantum measurement for extracting classical information from a quantum system is needed. For examples, letting the coefficient c in (1) be a fixed constant along with a quantum Chernoff bound [42–45] delivers a large-deviation bound for c-q channel coding [44]. Letting  $c = O(1/\sqrt{n})$  for an n-fold i.i.d. repetition of a c-q channel, (1) achieves the second-order coding rate [46–50] in the small deviation regime. Later, both results were extended to the moderate deviation regime [51,52] accordingly. In addition, Anshu, Jain, and Warsi proposed a position-based coding for achieving entanglement-assisted classical communication over quantum channels [16], which also relies on the Hayashi–Nagaoka operator inequality (1).

Apart from the success and the significance of Hayashi and Nagaoka's approach, it is technically non-trivial to prove the operator inequality (1). On top of that, is it possible to tighten the one-shot achievability bound for quantum information-theoretic tasks by eliminating the incurred coefficients in terms of c?<sup>3,4</sup> In this paper, we show that the so-called *pretty good measurement* (PGM) [55,56] naturally

<sup>&</sup>lt;sup>1</sup>Technically speaking, the quantum dense coding [7] and teleportation [8] are both one-shot protocols. However, the original references only concerned noiseless channels. Further, the early work of quantum state discrimination [9, 10] also considered the one-shot setting. In this paper, we will focus on the *packing-type problems* in one-shot quantum information theory with general (noisy) quantum channels without specific constraints. We skip the *covering-type problems* such as quantum covering [11–18], privacy amplification [12, 18–25], decoupling [26–28], and simulation [29–32] since their achievability techniques are different from that of the packing problems.

<sup>&</sup>lt;sup>2</sup>We refer the readers to Ref. [39, Theorem 2.1] for the precise statement of the quantum union bound. An application of it with the sequential decoding strategy [40] leads to the same achievability bound as in [36,41] (for infinite-dimensional Hilbert space as well) [39, Theorem 5.1].

<sup>&</sup>lt;sup>3</sup>It is generally believed that the coefficients in (1) or in the quantum union bound cannot be removed [39]. However, achieving a tighter one-shot bound in quantum information theory without such coefficients are possible. That is the keynote of the present paper.

 $<sup>^4</sup>$ A one-shot achievability bound without the coefficients in terms of c was actually proved by Beigi and Gohari [53] which is based on a technique introduced by Yassaee  $et\ al.$  [54] (but the comparison to Hayashi and Nagaoka's bound [36, Lemma 3], [41, Theorem 1] was missing). We will compare Beigi and Gohari's result [53, Corollary 1] with ours (Theorem 1) in Section 3.1.

plays a role as the union bound. Together with the random coding technique, it yields a one-shot achievability bound via a much simpler proof which only bases on previously known facts. The above-mentioned coefficients in terms of c are not required anymore and hence the established one-shot bound is tighter. Furthermore, the proof itself provides a more transparent connection between c-q channel coding and binary quantum hypothesis testing.

To elaborate on our proposed simple derivation, we introduce a  $noncommutative \ minimal$  between two positive semi-definite operators A and B as:

$$A \wedge B := \frac{A + B - |A - B|}{2}.\tag{3}$$

This quantity is prominent in quantum state discrimination because the celebrated *Holevo–Helstrom Theorem* [9, 57, 58] endowed it with an operational meaning:

"Tr  $[A \wedge B]$  determines the minimum 'error' of discrimination between operators A and B."

In other words,

$$\inf_{0 \le T \le \mathbb{1}} \operatorname{Tr} \left[ A \left( \mathbb{1} - T \right) \right] + \operatorname{Tr} \left[ BT \right] = \operatorname{Tr} \left[ A \wedge B \right]. \tag{4}$$

Then, the achievability proof for a c-q channel  $x \mapsto \rho_B^x$  (which maps every classical symbol x to a density operator  $\rho_B^x$ ) proceeds as follows. Given a random codebook  $\mathcal{C}$  in which each codeword is drawn pairwise-independently according to an arbitrary probability distribution  $p_X$ , we calculate the average error probability for sending M messages using a pretty-good measurement as follows:

$$\mathbb{E}_{\mathcal{C}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \frac{\sum_{\bar{x} \neq x} \rho_{\mathsf{B}}^{\bar{x}}}{\rho_{\mathsf{B}}^{x} + \sum_{\bar{x} \neq x} \rho_{\mathsf{B}}^{\bar{x}}} \right]^{(a)} \leq \mathbb{E}_{\mathcal{C}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \wedge \left( \sum_{\bar{x} \neq x} \rho_{\mathsf{B}}^{\bar{x}} \right) \right]$$
 (5)

$$\stackrel{\text{(b)}}{\leq} \mathbb{E}_{x \sim p_{\mathsf{X}}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \wedge \left( \mathbb{E}_{\bar{x} \sim p_{\mathsf{X}}} \left[ \sum_{\bar{x} \neq x} \rho_{\mathsf{B}}^{\bar{x}} \right] \right) \right] \tag{6}$$

$$\stackrel{\text{(c)}}{=} \mathbb{E}_{x \sim p_{\mathsf{X}}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \wedge (M-1) \rho_{\mathsf{B}} \right] \tag{7}$$

$$= \operatorname{Tr} \left[ \rho_{\mathsf{XB}} \wedge (M-1)\rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}} \right], \tag{8}$$

where  $\rho_{XB} = \sum_{x \in X} p_X(x)|x\rangle\langle x| \otimes \rho_B^x$  is the resulting joint bipartite state between the channel input and output. The first inequality (a) is an adaptation of the Barnum–Knill Theorem [59], [60, Theorem 3.10] that relates the error probability using a PGM to that of using an optimal measurement (the formal statement of the trace inequality is deferred to Fact (vii) of Section 2 and the detailed proof is given in Theorem 1 of Section 3); (b) follows from the triangle inequality of trace-norm and the formula given in (3); and (c) follows from the pairwise-independence of  $\mathcal C$  and the fact that  $\rho_B = \mathbb E_{\bar x \sim p_X}[\rho_B^{\bar x}]$ . The last line (8) follows from the direct sum structure of trace-norm. Hence, the established bound in (8) provides us the following interpretation for sending M messages over a c-q channel:

"The error probability is upper bounded by the error of discriminating  $\rho_{XB}$  and (M-1)-many  $\rho_{X}\otimes\rho_{B}$ ."

The proposed simple derivation enjoys the following favorable features.

- (I) The one-shot achievability bound in (8) admits a closed-form expression as the Holevo-Helstrom Theorem. Computing such a closed-form expression is more time efficient than the previous results in terms of entropic quantities involving optimizations (see Remark 4 in Section 3).
- (II) The proof is self-explainable and it signifies a more lucid connection between c-q channel coding and hypothesis testing. Namely, in (5), the PGM translates the conditional error probability of c-q channel coding to the error of a binary state discrimination between a randomly-chosen state  $\rho_{\rm B}^x$  against the rest  $\sum_{\bar{x}\neq x}\rho_{\rm B}^{\bar{x}}$ . This also manifests that the PGM effectively works as an one-vs-rest (or it is also referred to as one-vs-all) classification strategy; see Figure 1(A). Then, the conditional expectation  $\mathbb{E}_{\bar{x}|x}$  averages the rest of the states to (M-1)-many marginal states  $\rho_{\rm B}$ ; see (7) and Figure 1(B). The discrimination immediately follows from taking expectation  $\mathbb{E}_{x\sim p_{\rm X}}$  on the randomly-drawn state  $\rho_{\rm B}^x$  and the direct-sum structure of trace-norm.

(III) The proposed bound (8) is free of the parameters c as in (1). This then shows that (8) is a tighter one-shot achievability bound than previous results based on the Hayashi–Nagaoka operator inequality (1); see Section 3.1 and Table 2 for the comparison with existing results. Accordingly, it unifies asymptotic derivations in the large, small, and moderate derivation regimes. To be more specific, directly applying the quantum Chernoff bound [42–45], (8) gives an one-shot exponential bound in the large deviation regime (Propositions 2). Using the infimum representation of the noncommutative minimal given in (4), the derived achievability bound (8) provides the tightest characterization of the  $\varepsilon$ -one-shot capacity heretofore (Propositions 3):




FIGURE 2. Flow chart of the implications of the established one-shot achievability bound in the large deviation, small deviation, and the moderate deviation regimes. Here,  $R := \frac{1}{n} \log n$  denotes the coding rate for blocklength  $n \in \mathbb{N}$ . The precise notation is referred to Section 3.

$$\log M \ge D_{\rm h}^{\varepsilon - \delta}(\rho_{\mathsf{XB}} \, \| \, \rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}) - \log \frac{1}{\delta}, \quad \forall \, 0 < \delta < \varepsilon < 1, \tag{9}$$

where  $D_{\rm h}^{\varepsilon}$  is the  $\varepsilon$ -quantum hypothesis-testing divergence [41, 48, 49] (see Proposition 3 for the precise definition). With the second-order expansion of  $D_{\rm h}^{\varepsilon}$  [48, 49, 61, 62], (9) improves the third-order coding rate for c-q channel coding in the small deviation regime since the cost  $c^{-1} = O(\sqrt{n})$  incurred in applying (1) is no longer needed. Removing the coefficients in terms of c may seem superficial; however, we remark that in the one-shot setting, every bit of an analytical bound counts. Straightforwardly, the moderate deviation expansion [51, 63] follows from the proposed one-shot bound. We refer the readers to Figure 2 below for a schematic flow chart.

- (IV) The proposed analysis applies to infinite-dimensional quantum systems [64] as well, e.g. communication over infinite-dimensional channels with energy constraints or cost constraints [65, 66].
- (V) The proposed methods via pretty-good measurement naturally extends to various quantum information-theoretic tasks including:
  - (i) binary quantum hypothesis testing (Section 4.1),
  - (ii) entanglement-assisted classical communication over point-to-point quantum channels (Section 4.2),
  - (iii) classical data compression with quantum side information (Section 4.3),
  - (iv) entanglement-assisted/unassisted classical communication over quantum multiple-access channels (Section 4.4),
  - (v) entanglement-assisted/unassisted classical communication over quantum broadcast channels (Section 4.5),
  - (vi) and entanglement-assisted/unassisted classical communication over quantum channels with casual state information available at encoder (Section 4.6).

We refer the readers to the summary given in Table 1 below.

Lastly, the established simple analysis sharpens the *proposition-based decoding*, a pivotal technique in one-shot quantum information theory (see e.g. [15,16,16,67,68]), proposed by Anshu, Jain, and Warsi [16, Lemma 4], which again employs the Hayashi–Nagaoka operator inequality (1). We state our result as follows. For a set of M density operators of the form


$$\tau^m_{\mathsf{AB}_1\dots\mathsf{B}_M} := \rho_{\mathsf{AB}_m} \otimes \sigma_{\mathsf{B}_1} \otimes \sigma_{\mathsf{B}_2} \otimes \dots \otimes \sigma_{\mathsf{B}_{m-1}} \otimes \sigma_{\mathsf{B}_{m+1}} \otimes \dots \otimes \sigma_{\mathsf{B}_M}, \quad m \in \mathsf{M}, \tag{10}$$

where  $\rho_{\mathsf{AB}_m} = \rho_{\mathsf{AB}}$  and  $\sigma_{B_m} = \sigma_{\mathsf{B}}$ , and  $\rho_{\mathsf{AB}}, \sigma_{\mathsf{B}}$  are arbitrary density operators. Then, we show that the associated pretty-good measurement guarantees an upper bound on the error probability for decoding every message  $m \in \mathsf{M}$  (Theorem 5):

$$\operatorname{Tr}\left[\tau_{\mathsf{AB}_{1}\dots\mathsf{B}_{M}}^{m}\left(\mathbb{1}-\Pi_{\mathsf{AB}_{1}\dots\mathsf{B}_{M}}^{m}\right)\right] \leq \operatorname{Tr}\left[\rho_{\mathsf{AB}}\wedge(M-1)\rho_{\mathsf{A}}\otimes\sigma_{\mathsf{B}}\right]. \tag{11}$$

The above bound (11) constitutes the main technique to derive numerous one-shot achievability bounds in Section 4. Hence, we may term is as a *one-shot quantum packing lemma*, and it might lead to more fruitful applications elsewhere.

This paper is organized as follows. Section 2 formally introduces the noncommutative minimal and its properties. Section 3 establishes our main result of the one-shot achievability for c-q channel coding; we compare it with existing results in Section 3.1. Section 4 entails its applications in one-shot quantum information theory. We conclude the paper and discuss possible open problems in Section 5. Appendix A proves a useful trace inequality regarding the noncommutative minimal.



- (A) Given a realization of a codebook  $\mathcal{C}=\{x(1),\dots,x(M)\}$ , the error probability of sending message m=1 using pretty-good measurement (PGM) is upper bounded by the error of distinguishing  $\rho_{\rm B}^{x(1)}$  against  $\sum_{\bar{m}=2}^M \rho_{\rm B}^{x(\bar{m})}$ ; see (5). The sum of the rest of channel output states in the above line is because the PGM effectively works as an one-vs-rest (or also referred to as one-vs-all) classification strategy.
- (B) Taking conditional expectation over the random codebook  $\mathcal{C}$  conditioned on codeword x(1), the error probability of sending message m=1 is upper bounded by the error of distinguishing  $\rho_{\rm B}^{x(1)}$  against  $(M-1)\rho_{\rm B}$ ; see (7). Namely, randomly drawing a codeword  $x(1) \sim p_{\rm X}$ , we are distinguishing the associated channel output state against (M-1)-many average channel output states.
- (C) Taking expectation over the transmitted codeword  $x(1) \sim p_X$ , Figure 1(B) is equivalent to distinguishing the joint state  $\rho_{XB}$  between channel input and output against (M-1)-many product of its marginal states  $\rho_X \otimes \rho_B$ ; see (8). This may be viewed as a one-shot packing lemma for classical-quantum channel coding.

FIGURE 1. Schematic illustration of the proposed achievability analysis for classical-quantum channel  $(x \mapsto \rho_B^x)$  coding. Similar reasoning applies to various quantum information-theoretic tasks. The readers can refer to Table 1 and Section 4 for instances.

## 2. The Noncommutative Minimal and Its Properties

We first recall the basic concepts of (binary) quantum state discrimination, which constitutes the central tool for the proposed achievability analysis in the following Section 3. Given arbitrary positive semi-definite operators A and B, we define the  $minimum\ error^5$  using two-outcome positive operator-valued measures (POVM) for distinguishing them as

$$\inf_{0 \le T \le \mathbb{1}} \operatorname{Tr} \left[ A \left( \mathbb{1} - T \right) \right] + \operatorname{Tr} \left[ BT \right]. \tag{12}$$

The well-known  $Holevo-Helstrom\ Theorem\ [9,57,58,69]$  show that the infimum can be attained by a Neyman-Pearson test  $T=\{A>B\}$  that projects onto the positive part of A-B, and the minimization is given by its dual formulation of a semi-definite program [71], [60, §1.2.3]:

$$\inf_{0 \le T \le \mathbb{1}} \operatorname{Tr} \left[ A \left( \mathbb{1} - T \right) \right] + \operatorname{Tr} \left[ BT \right] = \sup_{M = M^{\dagger}} \left\{ \operatorname{Tr} \left[ M \right] : M \le A, \ M \le B \right\}$$

$$= \operatorname{Tr} \left[ A \wedge B \right],$$
(13)

where the supremum is attained by the so-called *noncommutative minimal* (i.e. the operator with the greatest trace among the lower bound in terms of the Loewner partial ordering) [9, 57, 58, 69] of positive

<sup>&</sup>lt;sup>5</sup>The quantum state discrimination problems usually concern distinguishing an ensemble of quantum states where each of the state (i.e. a density operator with unit trace) in the ensemble is endowed with a prior probability. For example, the *minimum error* defined above coincides with the error probability in conventional quantum state discrimination when assuming Tr[A + B] = 1. We note that in Holevo's early works [57, 69], [58, §II], the scenario of distinguishing positive semi-definite operators (even on infinite-dimensional Hilbert space) was studied (see also [70] and [60, §3]).

semi-definite  $^{6}$  A and B, i.e.

$$A \wedge B := \underset{M - M^{\dagger}}{\operatorname{arg\,max}} \left\{ \operatorname{Tr} \left[ M \right] : M \le A, \ M \le B \right\}. \tag{14}$$

In other words, the Holevo–Helstrom Theorem [9, 57, 58] provides an operational meaning to the non-commutative minimal ' $\land$ ' for characterizing the minimum  $error^7$  of distinguishing positive semi-definite operators A and B. We will adopt such an interpretation subsequently.

The main goal of this paper is to characterize the average error probability in quantum information-theoretic tasks in terms of the noncommutative minimal ' $\land$ '. To that end, we first review its important properties that will be used in the proposed analysis. We note that the following properties can be found in existing works.

Fact (Properties of noncommutative minimal<sup>8</sup>). Considering arbitrary self-adjoint operators A and B, the following hold:

- (i) (Closed-form expression)  $A \wedge B = \frac{1}{2} (A + B |A B|)$ .
- (ii) (Monotone increase in the Loewner ordering)  $\operatorname{Tr}[A \wedge B] \leq \operatorname{Tr}[A' \wedge B']$  for  $A \leq A'$  and  $B \leq B'$ .

<sup>&</sup>lt;sup>6</sup>One can also define the noncommutative minimal among multiple self-adjoint operators. Throughout this paper, we will only consider the case of binary positive semi-definite operators.

<sup>&</sup>lt;sup>7</sup>In quantum state discrimination, one sometimes studies the maximum success probability [9,57,58] and express it via a semi-definite programming formulation as the trace of the so-called *noncommutative maximal* [10,60,70], i.e. the least (in trace ordering) of the upper bound (in Loewner ordering). Since the present paper aims to relate the *error* of a quantum information-theoretic task to that of quantum state discrimination, we will only focus on the error. Note also that for distinguishing multiple operators, say  $\{A_i\}_i$ , the error of the discrimination is given by the noncommutative minimal among the set of operators  $\{\sum_{j\neq i} A_j\}_i$  [10, §II].

<sup>&</sup>lt;sup>8</sup>Some of the properties can be proved by using the quantum Hockey–Stick divergence [72–74] as well. In this paper, we will just stick to the notation of the noncommutative minimal.

- (iii) (Monotone increase under trace-preserving maps)  $\operatorname{Tr}[A \wedge B] \leq \operatorname{Tr}[\mathcal{N}(A) \wedge \mathcal{N}(B)]$  for any trace-preserving map  $\mathcal{N}$ .
- (iv) (Concavity) The map  $(A, B) \mapsto \text{Tr}[A \wedge B]$  is jointly concave.
- (v) (Direct sum)  $(A \oplus A') \wedge (B \oplus B') = (A \wedge B) \oplus (A' \wedge B')$  for any self-adjoint A' and B'.
- (vi) (Upper bound)  $\operatorname{Tr}[A \wedge B] \leq \operatorname{Tr}[A^{1-s}B^s]$  for any  $A, B \geq 0$  and  $s \in (0,1)$ .
- (vii) (Lower bound)  $\operatorname{Tr}[A \wedge B] \ge \operatorname{Tr}\left[A \frac{B}{A+B}\right]$  for any  $A, B \ge 0$ .

*Proof.* Item (i) is a consequence of the Holevo–Helstrom Theorem [9, 57, 58] (or see [70, Lemma A.7]). Item (ii) directly follows from the definition given in (14) (or see [70, Lemma A.8]).

Items (iii) and (iv) follow from the fact that the trace-norm (i.e.  $||M||_1 := \text{Tr}[|M|])$ ) is contractive under trace-preserving maps and the triangle inequality (see e.g. [75, Theorems 9.2 & 9.3] of  $||\cdot||_1$ .

Item (v) with trace is due to the direct-sum structure of the trace-norm; the case without trace was proved in [70, Lemma A.9].

Item (vi) is the celebrated Audenaert et al.'s inequality [42, 43, 76] used in proving the quantum Chernoff bound; later, it was generalized to infinite-dimensional Hilbert space [45].

Item (vii) in a special case of Tr[A+B]=1 is an immediate consequence of the Barnum–Knill Theorem [59], [60, Theorem 3.10]. That is, the error probability using the pretty good measurement (PGM) [55,56] is no larger than twice of that using the optimal measurement. The proof for the general case of  $A, B \geq 0$  can be found in the author's previous work [25, Lemma 3]. For the completeness, we provide an alternative proof to Item (vii) (and a strengthened result of it) in Appendix A.

3. Main Result: A One-Shot Achievability for Classical-Quantum Channel Coding

In this section, we prove our main result of establishing a one-shot achievability bound for classicalquantum channel coding via a direct application of the pretty-good measurement.

**Definition 1** (Classical-quantum channel coding). Let  $\mathcal{N}_{\mathsf{X}\to\mathsf{B}}: x \mapsto \rho_\mathsf{B}^x$  be a classical-quantum channel where each  $\rho_\mathsf{B}^x$  is a density operator (i.e. a positive semi-definite operator with unit trace).

- 1. Classical registers M and X at Alice and a quantum register B at Bob.
- 2. An encoding  $m \mapsto x(m)$  which maps equiprobable messages in M to a codeword in X.
- 3. The classical-quantum channel  $\mathcal{N}_{\mathsf{X}\to\mathsf{B}}$  is applied on Alice's register  $\mathsf{X}$  and outputs a state on  $\mathsf{B}$  at  $\mathsf{Bob}$ .
- 4. A decoding measurement described by a positive operator-valued measure (POVM)  $\{\Pi_{\mathsf{B}}^m\}_{m\in\mathsf{M}}$  is performed on B to extract the sent message.

An  $(M, \varepsilon)$ -code for  $\mathcal{N}_{X\to B}$  is a protocol such that  $|\mathsf{M}|=M$  and the average error probability satisfies

$$\frac{1}{M} \sum_{m \in M} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x(m)} \left( \mathbb{1}_{\mathsf{B}} - \Pi_{\mathsf{B}}^{m} \right) \right] \le \varepsilon. \tag{15}$$

We adopt the standard random coding strategy.

- Encoding: Consider a random codebook  $\mathcal{C}$  where each of its codeword is pairwise-independently drawn from a probability distribution  $p_{\mathbf{X}}$ . Alice sends codewords according to the codebook  $\mathcal{C}$ .
- **Decoding:** At receiver, given an realization of the random codebook  $\mathcal{C}$ , Bob performs the pretty-good measurement (PGM) [55, 56] to decode each codeword in  $\mathcal{C}$  (which in turn decodes each message  $m \in M$  given  $\mathcal{C}$ ):

$$\Pi_{\mathsf{B}}^{x} := \frac{\rho_{\mathsf{B}}^{x}}{\sum_{\bar{x} \in \mathcal{C}, \, \bar{x} \neq x} \rho_{\mathsf{B}}^{\bar{x}}}, \quad \forall x \in \mathcal{C}.$$

$$(16)$$

Then, we main result is the following.

**Theorem 1** (A one-shot achievability bound classical-quantum channel coding). Consider an arbitrary classical-quantum channel  $\mathcal{N}_{\mathsf{X}\to\mathsf{B}}: x\mapsto \rho_{\mathsf{B}}^x$ . Then, there exists an  $(M,\varepsilon)$ -code for  $\mathcal{N}_{\mathsf{X}\to\mathsf{B}}$  such that for any probability distribution  $p_{\mathsf{X}}$ ,

$$\varepsilon \le \operatorname{Tr}\left[\rho_{\mathsf{X}\mathsf{B}} \wedge (M-1)\rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}\right]. \tag{17}$$

Here,  $\rho_{\mathsf{XB}} := \sum_{x \in \mathsf{X}} p_{\mathsf{X}}(x) |x\rangle \langle x| \otimes \rho_{\mathsf{B}}^x$  and the noncommutative minimal is  $A \wedge B = \frac{1}{2}(A + B - |A - B|)$ .

*Proof.* The claim follows from the lower bound of the noncommutative minimal ' $\wedge$ ' given in Fact (vii) for relating the pretty good measurement to the optimal measurement, and the concavity of ' $\wedge$ ', i.e. Fact (iv). Precisely, we calculate the (expected) probability of erroneous decoding for sending every codeword  $x \in \mathcal{C}$  through the channel (it is also called the random-coding error probability) using the PGM given in (16) as follows

$$\mathbb{E}_{\mathcal{C}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \frac{\sum_{\bar{x} \neq x} \rho_{\mathsf{B}}^{\bar{x}}}{\rho_{\mathsf{B}}^{x} + \sum_{\bar{x} \neq x} \rho_{\mathsf{B}}^{\bar{x}}} \right] \stackrel{\text{(a)}}{\leq} \mathbb{E}_{\mathcal{C}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \wedge \left( \sum_{\bar{x} \neq x} \rho_{\mathsf{B}}^{\bar{x}} \right) \right]$$

$$(18)$$

$$\stackrel{\text{(b)}}{\leq} \mathbb{E}_{x \sim p_{\mathsf{X}}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \wedge \left( \mathbb{E}_{\bar{x} \sim p_{\mathsf{X}}} \left[ \sum_{\bar{x} \neq x} \rho_{\mathsf{B}}^{\bar{x}} \right] \right) \right]$$
 (19)

$$\stackrel{\text{(c)}}{=} \mathbb{E}_{x \sim p_{\mathsf{Y}}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \wedge (M-1) \rho_{\mathsf{B}} \right], \tag{20}$$

where in (a) we applied Fact (vii) to relate expression with PGM to the noncommutative minimal; in (b) we used the concavity given in Fact (iv); in (c) we recalled the pairwise independence of the random codebook. Invoking the direct sum formula given in Fact (v), we arrive at the claimed inequality at the right-hand side of (17). Lastly, since the random-coding error probability using any  $p_X$  is larger than the error probability of the optimal code, the proof is completed.

Remark 1. In the classical case where  $\{\rho_{\mathsf{B}}^x\}_{x\in\mathsf{X}}$  mutually commute, Theorem 1 reduces to a result by Polyanskiy [77, (2.121)], which is only 1-bit weaker than the dependence testing bound by Polyanskiy, Poor, and Verdú [46, Theorem 17].

Remark 2. As will we show shortly in Sections 3.1 and 4, the one-shot bound established in Theorem 1 already implies (and sharpens) various existing known achievability results in the so-called achievable rate region. One may ask if the bound in Theorem 1 tight outside the achievable rate region? Taking c-q channel coding as an example, when the message size is too large or the coding rate (i.e.  $R := \frac{1}{n} \log M$ ) is way above the mutual information with respect to  $\rho_{XB}$ , the one-shot bound in Theorem 1 might not be very tight. If  $\log(M-1) \geq D_{\infty}^*(\rho_{XB} \| \rho_X \otimes \rho_B)$  where  $D_{\infty}^*(A \| B) := \inf\{\gamma \in \mathbb{R} : A \leq e^{\gamma}B\}$  is the max-relative entropy [19,78,79], then (17) yields a trivial bound:  $\varepsilon \leq 1$ .

In view of this, Theorem 1 can be strengthened to the following more involved form:

$$\varepsilon \le \left(1 - \frac{1}{M} \operatorname{Tr} \left[\rho_{\mathsf{X}\mathsf{B}} \wedge (M - 1)\rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}\right]\right) \operatorname{Tr} \left[\rho_{\mathsf{X}\mathsf{B}} \wedge (M - 1)\rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}\right]. \tag{21}$$

The bound (21) follows from a tighter inequality (98) given in Lemma 17 of Appendix A, instead of from Fact (vii). Now if  $\log(M-1) \ge D_{\infty}^*(\rho_{\mathsf{XB}} \| \rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}})$ , then the random coding error reaches that of randomly guessing equiprobable messages, i.e.  $\varepsilon \le 1 - 1/M$ . Regardless of the size of messages, (21) is technically a tighter one-shot bound. This naturally raises another question: can (21) lead to a simple proof of the upper bound on the strong converse exponent of c-q channel coding; see [80, Section 5.4], [81, Proposition IV.5], and [82, Proposition VI.2.]. We left it as a future work.

The interpretation of (17) in Theorem 1 is as lucid as the simple proof itself. Namely, we first relate the conditional error probability (of sending codeword x) using the PGM to the minimum error probability of discriminating the output state  $\rho_{\rm B}^x$  against all of the other possible channel output states,  $\sum_{\bar{x}\neq x}\rho_{\rm B}^{\bar{x}}$ . Here, discrimination against the sum of the rest of the states resulted from the nature of the union bound inherited in the PGM; note that this is similar to the concept of the one-vs-rest or the one-vs-all strategy in multiclass classification. Next, taking expectation on the rest of the states ensures that we are discriminating  $\rho_{\rm B}^x$  against (M-1) many marginal state  $\rho_{\rm B}$ . Lastly, the above is equivalent to the discrimination of the joint state  $\rho_{\rm XB}$  against (M-1) many decoupled product states  $\rho_{\rm X}\otimes\rho_{\rm B}$ . We hope that this simple proof provides a conceptually clear elucidation on the intimate relation between classical-quantum channel coding and quantum hypothesis testing in a pedagogical way.

The established one-shot achievability in Theorem 1 immediately covers (and sharpens) various known results of deriving the minimal error given a fixed message/coding size M or deriving the maximal message size given a fixed error  $\varepsilon$ . Let us define the following two important operational quantities for c-q channel coding:

$$\varepsilon^{\star}(\mathcal{N}_{X\to B}, M) := \inf\left\{\varepsilon \in \mathbb{R} : \exists \text{ an } (M, \varepsilon)\text{-code for } \mathcal{N}_{X\to B}\right\}; \tag{22}$$

$$M^{\star}(\mathcal{N}_{X\to B},\varepsilon):=\sup\left\{M\in\mathbb{N}:\exists \text{ an }(M,\varepsilon)\text{-code for }\mathcal{N}_{X\to B}\right\}. \tag{23}$$

We note that although  $\varepsilon^*(\mathcal{N}, M)$  and  $M^*(\mathcal{N}, \varepsilon)$  are inverse functions to each other in the one-shot setting, they lead to different asymptotic expansions in the large deviation and small deviation regimes, respectively.

**Proposition 2** (Bounding coding error given fixed coding rate). Consider an arbitrary classical-quantum channel  $\mathcal{N}_{\mathsf{X}\to\mathsf{B}}: x \mapsto \rho_{\mathsf{B}}^x$ . Then, for any  $n \in \mathbb{N}$  and R > 0, there exists an  $(\mathrm{e}^{nR}, \varepsilon)$ -code for  $\mathcal{N}_{\mathsf{X}\to\mathsf{B}}^{\otimes n}$  such that for any probability distribution  $p_{\mathsf{X}}$ ,

$$\varepsilon \le e^{-n\frac{1-\alpha}{\alpha}\left(I_{2^{-1/\alpha}}^{\downarrow}(\mathsf{X}:\mathsf{B})_{\rho}-R\right)}, \quad \forall \alpha \in (1/2,1).$$
 (24)

Here,  $I_{\alpha}^{\downarrow}(\mathsf{X}:\mathsf{B})_{\rho} := D_{\alpha}(\rho_{\mathsf{XB}} \parallel \rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}})$  and the state is evaluated on  $\rho_{\mathsf{XB}} := \sum_{x \in \mathsf{X}} p_{\mathsf{X}}(x) |x\rangle \langle x| \otimes \rho_{\mathsf{B}}^{x}$ , and the quantum Petz-Rényi divergence [83] is  $D_{\alpha}(\rho \parallel \sigma) := \frac{1}{\alpha - 1} \log \operatorname{Tr}\left[\rho^{\alpha} \sigma^{1 - \alpha}\right]$ .

 $\text{The exponent sup}_{\alpha \in (^{1}\!/2,1)} \xrightarrow{1-\alpha}_{\alpha} (I_{2-^{1}\!/\alpha}^{\downarrow}(\mathsf{X} : \mathsf{B})_{\rho} - R) \text{ is positive if and only if } R > I(\mathsf{X} : \mathsf{B})_{\rho} := D(\rho_{\mathsf{XB}} \parallel \rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}).$ 

*Proof.* For the one-shot case n=1, we apply Audenaert *et al.*'s inequality, i.e. Fact (vi) on the one-shot bound given in Theorem 1 with  $A=\rho_{\mathsf{XB}},\,B=(M-1)\rho_{\mathsf{X}}\otimes\rho_{\mathsf{B}},\,$  and  $s=\frac{1-\alpha}{\alpha}$  to obtain the large deviation

type bound. When considering product channels in the n-shot scenario, the exponential decays follows from the fact that  $\rho \mapsto I_{2-1/\alpha}^{\downarrow}(\mathsf{X} : \mathsf{B})_{\rho}$  is additive for any n-fold product state. The positivity holds by noting that the map  $\alpha \mapsto I_{2-1/\alpha}^{\downarrow}(\mathsf{X} : \mathsf{B})_{\rho}$  is non-decreasing on [1/2, 1] [80, Lemma 3.12].

**Proposition 3** (Bounding coding rate given fixed coding error). Consider an arbitrary classical-quantum channel  $\mathcal{N}_{\mathsf{X}\to\mathsf{B}}: x \mapsto \rho_\mathsf{B}^x$ . Then, for any  $\varepsilon \in (0,1)$  there exists an  $(M,\varepsilon)$ -code for  $\mathcal{N}_{\mathsf{X}\to\mathsf{B}}$  such that for any probability distribution  $p_\mathsf{X}$  and any  $\delta \in (0,\varepsilon)$ ,

$$\log M \ge D_{\rm h}^{\varepsilon - \delta}(\rho_{\mathsf{XB}} \| \rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}) - \log \frac{1}{\delta}. \tag{25}$$

Here,  $D_{\mathbf{h}}^{\varepsilon}(\rho \| \sigma) := \sup_{0 \le T \le 1} \{-\log \operatorname{Tr}[\sigma T] : \operatorname{Tr}[\rho T] \ge 1 - \varepsilon\}$  is the  $\varepsilon$ -hypothesis testing divergence [41, 48, 49].

Moreover, for any  $\varepsilon \in (0,1)$  and for sufficiently large  $n \in \mathbb{N}$ , there exists an  $(M,\varepsilon)$ -code for  $\mathcal{N}_{\mathsf{X}\to\mathsf{B}}^{\otimes n}$  such that for any probability distribution  $p_{\mathsf{X}}$ :

$$\log M \ge nI(\mathsf{X} : \mathsf{B})_{\rho} + \sqrt{nV(\mathsf{X} : \mathsf{B})_{\rho}} \,\Phi^{-1}(\varepsilon) - \tfrac{1}{2}\log n - O(1). \tag{26}$$

 $\label{eq:where V(X:B)} \begin{aligned} \text{where } V(\mathsf{X}:\mathsf{B})_{\rho} &:= V(\rho_{\mathsf{XB}} \, \| \, \rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}), \, V(\rho \, \| \, \sigma) := \mathrm{Tr} \left[ \rho (\log \rho - \log \sigma)^2 \right] - D(\rho \, \| \, \sigma)^2, \, \text{and } \Phi^{-1}(\varepsilon) := \sup \{ u : \int_{-\infty}^{u} \frac{1}{\sqrt{2\pi}} \, \mathrm{e}^{-\frac{1}{2}t^2} \, \mathrm{d}t \leq \varepsilon \} \ \text{is the inverse of the cumulative distribution of the standard normal distribution.} \end{aligned}$ 

*Proof.* By recalling the definition of the noncommutative minimal given in (13) and applying on Theorem 1, one has for any test  $0 \le T_{XB} \le \mathbb{1}_{XB}$  satisfying  $\text{Tr}[\rho_{XB}(\mathbb{1} - T_{XB})] \le \varepsilon - \delta$  such that,

$$\varepsilon \le \operatorname{Tr}[\rho_{\mathsf{X}\mathsf{B}}(\mathbb{1} - T_{\mathsf{X}\mathsf{B}})] + (M - 1)\operatorname{Tr}[\rho_{\mathsf{X}} \otimes \rho_{\mathsf{X}} T_{\mathsf{X}\mathsf{B}}] \tag{27}$$

$$\leq \varepsilon - \delta + (M - 1) e^{-D_{\rm h}^{\varepsilon - \delta}(\rho_{XB} \| \rho_{X} \otimes \rho_{B})}, \tag{28}$$

completing the proof.

The second-order achievability then follows from the expansion of the quantum hypothesis-testing divergence [39, 48, 49, 61, 62] by choosing  $\delta = 1/\sqrt{n}$ :  $D_{\rm h}^{\varepsilon \pm \delta} \left( \rho^{\otimes n} \parallel \sigma^{\otimes n} \right) \geq n D \left( \rho \parallel \sigma \right) + \sqrt{n V \left( \rho \parallel \sigma \right)} \Phi^{-1}(\varepsilon) - O(1)$ .

We remark that both Propositions 2 and 3 extends to the moderate deviation regime by directly following the approaches from [51,52]. The reader may refer to Figure 2 for the corresponding expressions.

Remark 3. Given that Theorem 1 already provides an one-shot bound on the average error probability, one may wonder why to weaken (17) in Theorem 1 to obtain another one-shot bound in Proposition 2 (note that they both have closed-form expressions). The reason is that the minimum error in terms of the noncommutative minimal in the right-hand side of (17) is not multiplicative under product states. Nevertheless, it can be further upper bounded by certain multiplicative Rényi-type quantities. That is exactly the spirit of the quantum Chernoff bound [42, 43, 45, 76], and hence we term the the result in Proposition 2 a kind of large deviation type bound accordingly.

On the other hand, Theorem 1 also gives a one-shot and asymptotic expansions in the small deviation regime (Proposition 3). Hence, to some extent Theorem 1 may be viewed as a "meta" achievability for classical communication over quantum channels (see also Lemma 5 later in Section 4.2).

Remark 4. Most existing one-shot achievability bounds to date (e.g. [16,36,41,67]) are expressed in terms of the quantum hypothesis testing divergence  $D_{\rm h}^{\varepsilon}$  as in (25) of Proposition 3, for the reason that they directly provide a one-shot characterization (lower bound) for the message/coding size M (i.e. the  $\varepsilon$ -one-shot capacity). To numerically compute  $D_{\rm h}^{\varepsilon}$ , one can formulate it into the standard form of a semi-definite program (SDP); namely, it is an optimization over a  $d_{\rm B} \times d_{\rm B}$  matrix-valued variable with  $m := d_{\rm B}^2 + 1$  linear (scalar) constraints, where we use  $d_{\rm B}$  to denote the dimension of the underlying Hilbert space representing

 $<sup>^{10}</sup>$ By large deviations, we meant the scenario where the coding rate  $R=\frac{1}{n}\log M$  deviates from the fundamental threshold (i.e. the quantum mutual information or the Holevo quantity when optimizing the input distributions) by a large amount; i.e. namely, it is constant O(1) away from the fundamental limit. In the small deviation regime, the optimal rate R for some fixed error  $\varepsilon \in (0,1)$  converges to the fundamental limit at a speed of  $O(1/\sqrt{n})$ , meaning that R deviates by a small amount. In between, we refer to the moderate deviation regime, where R deviates by the order  $\omega(1/\sqrt{n}) \cap o(1)$  [51,52]. In this case, the optimal error vanishes at a sub-exponential speed.

the quantum register B. (Here we only consider the computation on the quantum part of register B for simplicity without involving computation on the classical register X.) Using the state-of-the-art (classical) SDP solver [84], the running time<sup>11</sup> is  $O^*(m^{\omega}) = O^*(d_{\mathsf{B}}^{2\omega}) = O^*(d_{\mathsf{B}}^{4.746})$ , where  $\omega \leq 2.373$  is the exponent of matrix multiplication [85].

On the other hand, the one-shot bound provided in Theorem 1 admits a closed-form expression in terms of the trace-norm. Using the state-of-the-art algorithm for approximating singular values [86], it requires running time  $O^*(d_{\mathsf{B}}^\omega\log^2d_{\mathsf{B}}) = O^*(d_{\mathsf{B}}^{2.373}\log^2d_{\mathsf{B}})$ . This then shows that the computation of the proposed one-shot achievability bound in terms of the noncommutative minimal in Theorem 1 is nearly quadratically efficient than that of computing the one-shot bounds in terms of the quantum hypothesistesting divergence.

3.1. Comparison to Existing Results. In the following, we compare the established one-shot achievability bounds, i.e. Propositions 2 and 3 with existing results. The readers can refer to Table 2 below for a summary.

The exponential decaying rate of error probability given in Proposition 2 matches the one proved by Hayashi [44, (9)]. However, in the one-shot case, the large-deviation-type bound in Proposition 2 is tighter than [44, (9)] (without the factor 4). If further the  $\mathcal{N}_{\mathsf{X}\to\mathsf{B}}$  is a pure-state channel, one has  $I_{2^{-1}/\alpha}^{\downarrow}(\mathsf{X}:\mathsf{B})_{\rho} = I_{\alpha}(\mathsf{X}:\mathsf{B})_{\rho} := \inf_{\sigma_B \in \mathcal{S}(\mathcal{H}_\mathsf{B})} D_{\alpha}(\rho_{\mathsf{X}\mathsf{B}} \| \rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}) = \frac{\alpha}{\alpha-1} \log \mathrm{Tr}[(\sum_{x \in \mathsf{X}} (\rho_{\mathsf{B}}^x)^{\alpha})^{1/\alpha}]$  (where the minimization is over the set of density operators on Hilbert space  $\mathcal{H}_\mathsf{B}$ , i.e.  $\mathcal{S}(\mathcal{H}_\mathsf{B})$ ). Hence, the bound in Proposition 2 is tighter than the bound proved by Burnashev and Holevo [33, Proposition 1] (without the factor 2).

Hayashi–Nagaoka [36, Lemma 3], and Wang–Renner [41, Theorem 1] employed the Hayashi–Nagaoka inequality (1) to obtain an one-shot achievability bound on the message/coding size M: for any  $0 < \delta < \varepsilon < 1$  with choosing  $c = \frac{\delta}{2\varepsilon - \delta}$  in (1),

$$\log M \ge D_{\rm h}^{\varepsilon - \delta}(\rho_{\mathsf{XB}} \| \rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}) - \log \frac{4}{\delta^2}$$
 (29)

in terms of the hypothesis-testing divergence  $D_h^{\varepsilon}$  introduced in Proposition 3. The term  $-\log \frac{4}{\delta^2}$  results from optimizing the coefficient c when applying the Hayashi–Nagaoka inequality. Compared with (29), Proposition 3 in Section 3 does not have to choose the appropriate coefficient c and hence it gives a tighter one-shot achievability bound on M (especially when  $\delta$  is small):

$$\log M \ge D_{\rm h}^{\varepsilon - \delta}(\rho_{\mathsf{XB}} \| \rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}) - \log \frac{1}{\delta}. \tag{30}$$

Specialized to the i.i.d. asymptotic scenario of *n*-fold product channel, by choosing  $\delta = 1/\sqrt{n}$ , then (30) yields an improved third-order coding rate by a factor  $\frac{1}{2} \log n$  compared to that of using (29).

Beigi and Gohari [53] generalized a superb classical achievability method by Yassaee *et al.* [54] to also establish a one-shot achievability bound on M [53, Corollary 1]:

$$\log M \ge D_{\rm s}^{\varepsilon - \delta}(\rho_{\mathsf{XB}} \| \rho_{\mathsf{X}} \otimes \rho_{\mathsf{B}}) - \log \frac{1 - \varepsilon}{\delta},\tag{31}$$

where  $D_{\mathrm{s}}^{\varepsilon}(\rho \| \sigma) := \sup \{ \gamma \in \mathbb{R} : \operatorname{Tr} \left[ \rho \left\{ \rho \leq \mathrm{e}^{\gamma} \sigma \right\} \leq \varepsilon \right] \}$  is the information-spectrum divergence [36, 38, 48, 87,88]. Comparing (30) to (31), we recall the relation between quantum hypothesis-testing divergence  $D_{\mathrm{h}}^{\varepsilon}$ 

 $<sup>\</sup>overline{^{11}}$ We use notation  $O^*$  to hide  $m^{o(1)}$  and  $\log \frac{1}{\epsilon}$  factors, where  $\epsilon$  is accuracy parameter.

<sup>&</sup>lt;sup>12</sup>More precisely, Hayashi and Nagaoka obtained the first one-shot achievability bound (for general c-q channels) as in (29) but in terms of the *information-spectrum divergence*  $D_{\rm s}^{\varepsilon}$  [36, 38, 48, 87, 88] instead of the hypothesis-testing divergence  $D_{\rm h}^{\varepsilon}$  defined in Proposition 3. On the other hand, it is known that  $D_{\rm h}^{\varepsilon}(\cdot||\cdot) \geq D_{\rm s}^{\varepsilon}(\cdot||\cdot)$  [48, Lemma 12], and hence the one-shot achievability bound in terms of  $D_{\rm h}^{\varepsilon}$  is tighter than that in terms of  $D_{\rm s}^{\varepsilon}$ . Here, we remark that the approach proposed by Hayashi and Nagaoka [36] allows for choosing any measurement along with applying the Hayashi–Nagaoka inequality (1) in establishing achievability. Namely, the analysis in [36] with (1) can already lead to (29). Though the terminology and concept of the hypothesis-testing divergence  $D_{\rm h}^{\varepsilon}$  might appear in the contexts of statistical hypothesis testing by Stein–Chernoff [89], Strassen [90], Csiszár–Longo [91], Polyanskiy–Poor–Verdú [46], and by Wang–Renner [41] in the quantum setting.

and quantum information-spectrum divergence  $D_{\rm s}^{\varepsilon}$  [48, Lemma 12]:

$$D_{\mathrm{h}}^{\varepsilon}(\rho \| \sigma) \ge D_{\mathrm{s}}^{\varepsilon}(\rho \| \sigma) \ge D_{\mathrm{h}}^{\varepsilon - \delta'}(\rho \| \sigma) - \log \frac{1}{\delta'}, \quad \forall \, 0 < \delta' < \varepsilon. \tag{32}$$

This then indicates that the proposed one-shot bound (30) has a stronger leading term<sup>13</sup>  $D_{\rm h}^{\varepsilon-\delta}$  instead of  $D_{\rm s}^{\varepsilon-\delta}$ .

When considering the asymptotic expansion of the coding rate in the i.i.d. scenario, one has to translate  $D_s^{\varepsilon}$  in (31) back to  $D_h^{\varepsilon}$  using (32) and to employ the second-order achievability<sup>14</sup> of the quantum hypothesistesting divergence [48, 49, 61, 62]:

$$D_{\mathrm{h}}^{\varepsilon\pm\delta}\left(\rho^{\otimes n}\parallel\sigma^{\otimes n}\right)\geq nD\left(\rho\parallel\sigma\right)+\sqrt{nV\left(\rho\parallel\sigma\right)}\Phi^{-1}(\varepsilon)-O(1). \tag{33}$$

Then, Beigi and Gohari's result (31) leads to

$$\log M \geq nI(\mathsf{X} : \mathsf{B})_{\rho} + \sqrt{nV(\mathsf{X} : \mathsf{B})_{\rho}} \, \Phi^{-1}(\varepsilon) - \log n - O(1). \tag{34}$$

This achieves the same third-order term as the asymptotic expansion using (29) and (33). On the other hand, the proposed (30) with (33) gives a tighter third-order term:

$$\log M \geq nI(\mathsf{X} : \mathsf{B})_{\rho} + \sqrt{nV(\mathsf{X} : \mathsf{B})_{\rho}} \, \Phi^{-1}(\varepsilon) - \frac{1}{2} \log n - O(1). \tag{35}$$

Inspired from the third-order asymptotics of the classical hypothesis-testing divergence proved by Strassen [90, Theorem 3.1] (see also [46, Lemma 46] and [47, Proposition 2.3]), we conjecture the following third-order achievability of the quantum hypothesis-testing divergence:

$$D_{\mathbf{h}}^{\varepsilon \pm \delta} \left( \rho^{\otimes n} \parallel \sigma^{\otimes n} \right) \ge nD \left( \rho \parallel \sigma \right) + \sqrt{nV \left( \rho \parallel \sigma \right)} \Phi^{-1}(\varepsilon) + \frac{1}{2} \log n - O(1). \tag{36}$$

If (36) was true, then the established (30) will imply

$$\log M \ge nI(\mathsf{X} : \mathsf{B})_{\rho} + \sqrt{nV(\mathsf{X} : \mathsf{B})_{\rho}} \,\Phi^{-1}(\varepsilon) - O(1). \tag{37}$$

We remark that (37) will give the best possible third-order expansion of the achievable coding rate for c-q channel coding without further assumptions on the channel 15.

Remark 5. At the writing of this paper, a very recent work by Renes establishes the optimal error exponent for symmetric classical-quantum channels [93]. The result is asymptotic but it matches the quantum sphere-packing bound [94–96] for the high achievable rate region, and hence it is asymptotically optimal and tighter than the error exponent obtained in Proposition 2 in the i.i.d. asymptotic setting for symmetric classical-quantum channels. A one-shot bound for that is still missing. We leave it as a future work.

<sup>&</sup>lt;sup>13</sup>In the i.i.d. asymptotic setting, the leading term (i.e. either  $D_{\rm h}^{\varepsilon-\delta}$  or  $D_{\rm s}^{\varepsilon-\delta}$ ) dominates both the first-order and the second-order coding rates. On the other hand, (31) does have a better constant  $-\log(1-\varepsilon)$ , which corresponds to the *fourth-order term* in the small deviation regime. Such a term is negligible for small error (say e.g.  $\varepsilon \leq 10^{-3}$ ). For large error, one can invoke the strengthened one-shot bound in (21) (though the formula is more involved).

<sup>&</sup>lt;sup>14</sup>The second-order expansion of the quantum hypothesis-testing divergence was concurrently proposed by Tomamichel–Hayashi [48] and Ke Li [49]. Here in (33), we cite Li's result [49, Theorem 5] since it has a better third-order term -O(1) than that of Tomamichel–Hayashi [48, (28) & (33)], in which the third-order term is  $-(\frac{1}{2} + \min(\lambda(\sigma), \nu(\sigma)) \log n - O(1))$  for  $\lambda(\sigma)$  being the logarithmic condition number of  $\sigma$  and  $\nu(\sigma)$  being the number of distinct eigenvalues of  $\sigma$ .

We also remark that Li's result (33) was later generalized to infinite-dimensional separable Hilbert space by Datta-Pautrat-Rouzé [61, Proposition 1] and Oskouei-Mancini-Wilde [39, Lemma A.1]. The same result for general von Neumann algebras was proved by Pautrat and Wang [62, Theorem 1].

<sup>&</sup>lt;sup>15</sup>We note that Altuğ and Wagner proved that the third-order coding rate O(1) is optimal for classical symmetric and singular channels [92, Proposition 1] (see also [47, Theorem 4.3]). In other words, if the non-singularity condition is not imposed, larger third-order coding rate than O(1) is not achievable.

## 4. Applications in Quantum Information Theory

The analysis proposed in Section 3 naturally extends to classical communication over quantum channels, network information theory [97], and beyond; see Table 1 in Section 1. We apply our analysis using the pretty-good measurement to binary quantum hypothesis testing in Section 4.1. We present entanglement-assisted classical communication over quantum channels in Section 4.2. Section 4.3 is for classical data compression with quantum side information. Section 4.4 studies entanglement-assisted/unassisted classical communication over quantum multiple-access channels. Section 4.5 considers entanglement-assisted/unassisted classical communication over quantum broadcast channels. And Section 4.6 is devoted to entanglement-assisted classical communication over quantum channels with casual state information available at encoder.

4.1. **Binary Quantum Hypothesis Testing.** Binary quantum hypothesis testing and its optimal measurement is a relatively well-studied topic in quantum information theory due to its simpler structure [9, 10, 42–45, 48, 49, 51, 52, 57, 58, 98–108]. The goal of this section is not to re-do the analysis via optimal measurements, but to show how the sup-optimal pretty-good measurement along with the properties of the noncommutative minimal given in Section 2 can recover the existing results with only a slightly sub-optimal coefficients. Specifically, we will show that pretty-good measurement can also achieve the quantum Hoeffding bound [43, §5.5]. This indicates that the proposed analysis should not be too loose in terms of the one-shot exponential bounds (at least for binary quantum hypothesis testing).

Symmetric scenario. We first consider the symmetric scenario, where the two quantum hypotheses are described by density operators  $\rho$  and  $\sigma$  with prior probability  $p \in (0,1)$  and 1-p, respectively. Note that the one-shot quantum hypothesis testing is also known as the quantum state discrimination, and the relation between the optimal measurement and the pretty-good measurement was proved by Barnum and Knill [59], [60, Theorem 3.10]. Here, we demonstrate that the lower bound on the noncommutative minimal (Fact (vii)) can be interpreted as an adaptation of the Barnum-Knill Theorem. On one hand, the Holevo-Helstrom Theorem [9,57,58] shows that the minimal error for distinguishing  $\rho$  and  $\sigma$  in the symmetric scenario is given by  $\text{Tr}[p\rho \wedge (1-p)\sigma]$ . On the other hand, using pretty-good measurement with respect to the weighted states  $(p\rho, (1-p)\sigma)$  and applying the lower bound of the noncommutative

minimal, Fact (vii), the corresponding error probability is given by

$$p\operatorname{Tr}\left[\rho\frac{(1-p)\sigma}{p\rho+(1-p)\sigma}\right]+(1-p)\operatorname{Tr}\left[\sigma\frac{p\rho}{p\rho+(1-p)\sigma}\right]\leq 2\operatorname{Tr}\left[p\rho\wedge(1-q)\sigma\right],\tag{38}$$

which is twice of the error probability via the optimal measurement. This coincides with the claim made by Barnum and Knill on the relation between the error probability using the optimal measurement and that using the pretty-good measurement.

Remark 6. As mentioned in Remark 2 of Section 3, the upper bound in (38) can be strengthened to:

$$2\left(1 - \operatorname{Tr}\left[p\rho \wedge (1 - q)\sigma\right]\right) \operatorname{Tr}\left[p\rho \wedge (1 - q)\sigma\right],\tag{39}$$

by using (98) of Lemma 17 in Appendix A instead of Fact (vii).

On the other hand, one can use pretty-good measurement of the form  $\left\{\frac{\rho}{\rho+\sigma}, \frac{\sigma}{\rho+\sigma}\right\}$  and get an achievable error probability  $(1 - \text{Tr}\left[\rho \wedge \sigma\right]) \text{Tr}\left[\rho \wedge \sigma\right]$  or simply  $\text{Tr}\left[\rho \wedge \sigma\right]$ .

Asymmetric scenario. We move on to consider the asymmetric scenario, namely, the tradeoff between the type-I error and the type-II error without knowing the prior distribution. We use pretty-good measurement  $\left\{\frac{\rho}{\rho+\mu\sigma},\frac{\mu\sigma}{\rho+\mu\sigma}\right\}$  with a constant  $\mu$  that will be specified later and apply Fact (vii) to bound the type-I error  $\alpha$  and the type-II error  $\beta$ :

$$\begin{cases}
\alpha = \operatorname{Tr}\left[\rho \frac{\mu \sigma}{\rho + \mu \sigma}\right] \leq \operatorname{Tr}\left[\rho \wedge \mu \sigma\right]; \\
\beta = \operatorname{Tr}\left[\sigma \frac{\rho}{\rho + \mu \sigma}\right] \leq \mu^{-1} \operatorname{Tr}\left[\rho \wedge \mu \sigma\right].
\end{cases}$$
(40)

Next, we will show how (40) imply both the small-deviation-type bound and the large-deviation-type bound. As in the proof of Proposition 3, we invoke the definition of ' $\wedge$ ' in (13) with a test T satisfying  $\text{Tr}\left[\rho(\mathbb{1}-T)\right] \leq \varepsilon - \delta$ , i.e.

$$\operatorname{Tr}\left[\rho \wedge \mu\sigma\right] = \inf_{0 < T < 1} \operatorname{Tr}\left[\rho(1 - T)\right] + \operatorname{Tr}\left[\mu\sigma T\right] \tag{41}$$

$$\leq \varepsilon - \delta + \mu e^{-D_{\rm h}^{\varepsilon - \delta}(\rho \| \sigma)}. \tag{42}$$

Choosing a  $\mu$  such that the right-hand side of (42) equals  $\varepsilon$  and recalling the upper bound on ' $\wedge$ ' (Fact (vi) with taking  $s \to 0$ ) to obtain an upper bound on the type-II error:

$$\beta \le \mu^{-1} \operatorname{Tr} \left[ \rho \wedge \mu \sigma \right] \le \mu^{-1} = e^{-D_{h}^{\varepsilon - \delta}(\rho \| \sigma) - \log \delta}, \quad \forall \, 0 < \delta < \varepsilon < 1.$$

$$(43)$$

We remark that (43) is stronger than the analysis provided Beigi and Gohari [53, Theorem 6] in view of the relation between the quantum hypothesis-testing divergence and the quantum information-spectrum divergence, (32). This again magnifies the fact that the pretty-good measurement will give a one-shot achievability bound on the *Stein exponent* (i.e. the maximal exponent of the type-II error provided that the type-I error is at most  $\varepsilon \in (0,1)$ ) and it can achieve the second-order asymptotics in the i.i.d setting. Note since the pretty-good measurement is sub-optimal, it incurs a cost  $-\log \frac{1}{\delta}$  on the Stein exponent in the one-shot setting and a third-order term  $-\frac{1}{2}\log n$  in the *n*-fold i.i.d. scenario. Yet, it is still sufficient to achieve the moderate deviation asymptotics [52] (i.e. the inferior third-order term  $-\frac{1}{2}\log n$  does not affect the moderate deviation expansion).

Next, we show that the pretty-good measurement can recover the quantum Hoeffding bound [43, §5.5]. Applying the upper bound on ' $\wedge$ ' (Fact (vi) with  $\alpha = 1 - s \in (0, 1)$ ) on (40), we obtain:

$$\begin{cases} \alpha \leq \operatorname{Tr}\left[\rho \wedge \mu\sigma\right] \leq \mu^{1-\alpha} \operatorname{Tr}\left[\rho^{\alpha}\sigma^{1-\alpha}\right]; \\ \beta \leq \mu^{-1} \operatorname{Tr}\left[\rho \wedge \mu\sigma\right] \leq \mu^{-\alpha} \operatorname{Tr}\left[\rho^{\alpha}\sigma^{1-\alpha}\right]. \end{cases}$$
(44)

Choosing  $\mu = e^{\frac{\alpha-1}{\alpha}D_{\alpha}(\rho \| \sigma) + \frac{r}{\alpha}}$  with the quantum Petz–Rényi divergence  $D_{\alpha}$  introduced in Proposition 2, we arrive at the one-shot quantum Hoeffding bound: for all r > 0 and  $\alpha \in (0,1)$ ,

$$\begin{cases} \alpha \le e^{-\frac{1-\alpha}{\alpha}(D_{\alpha}(\rho \| \sigma) - r)}, \\ \beta \le e^{-r}. \end{cases}$$
(45)

To our best knowledge, this is the first time that the quantum Hoeffding bound is achieved by using the pretty-good measurement.

4.2. Entanglement-Assisted Classical Communication Over Quantum Channels. In this section, we elaborate how entanglement-assisted (EA) classical communication [26,65,109–112] follows from the proposed simple derivation in Section 3 in the same fashion.

**Definition 2** (Entanglement-assisted (EA) classical communication over quantum channels). Let  $\mathcal{N}_{A\to B}$ be a quantum channel.

- 1. A classical registers M, quantum registers A and A' at Alice and quantum registers B and R' at
- 2. A resource of an arbitrary state  $\theta_{R'A'}$  shared between Bob and Alice beforehand.
- 3. An encoding  $\mathcal{E}^m_{\mathsf{A}'\to\mathsf{A}}$  applied on  $\theta_{\mathsf{R}'\mathsf{A}'}$  for any equiprobable message  $m\in\mathsf{M}$  Alice wants to send. 4. The quantum channel  $\mathcal{N}_{\mathsf{A}\to\mathsf{B}}$  is applied on Alice's register A and outputs a state on B at Bob.
- 5. A decoding measurement  $\{\Pi^m_{\mathsf{R'B}}\}_{m\in\mathsf{M}}$  on registers  $\mathsf{R'B}$  to extract the sent message.

An  $(M, \varepsilon)$ -EA-code for  $\mathcal{N}_{\mathsf{A} \to \mathsf{B}}$  is a protocol such that  $|\mathsf{M}| = M$  and the average error probability satisfies

$$\frac{1}{M} \sum_{m \in M} \operatorname{Tr} \left[ \left( \mathbb{1} - \Pi_{\mathsf{R'B}}^{m} \right) \mathcal{N}_{\mathsf{A} \to \mathsf{B}} \circ \mathcal{E}_{\mathsf{A'} \to \mathsf{A}}^{m} \left( \theta_{\mathsf{R'A'}} \right) \right] \le \varepsilon. \tag{46}$$

We adopt the position-based encoding [16] but with the pretty-good measurement for the protocol.

- Preparations: Alice and Bob pre-share an M-fold product state  $\theta_{\mathsf{R}'\mathsf{A}'} := \theta_{\mathsf{R}\mathsf{A}}^{\otimes M} = \theta_{\mathsf{R}_1\mathsf{A}_1} \otimes \cdots \otimes \theta_{\mathsf{R}_n\mathsf{A}_n}$  $\begin{array}{l} \theta_{\mathsf{R}_M\mathsf{A}_M}.\\ \bullet \ \mathbf{Encoding:} \ \mathrm{Alice's\ encoding\ is\ sending\ her\ system}\ \mathsf{A}_m, \ \mathrm{i.e.}\ \mathcal{E}^m_{\mathsf{A}^M\to\mathsf{A}} = \mathrm{Tr}_{\mathsf{A}^{\mathsf{M}\backslash\{m\}}}, \ \mathrm{for\ each}\ m\in\mathsf{M}. \end{array}$
- **Decoding:** At receiver, the channel output states are

$$\rho_{\mathsf{R}^M\mathsf{B}}^m := \theta_\mathsf{R}^{\otimes (m-1)} \otimes \mathcal{N}_{\mathsf{A} \to \mathsf{B}}(\theta_{\mathsf{R}_m\mathsf{A}_m}) \otimes \theta_\mathsf{R}^{\otimes (M-m)}, \forall m \in \mathsf{M}. \tag{47}$$

Then, Bob performs the pretty-good measurement with respect to the channel output states:

$$\Pi_{\mathsf{R}^{M}\mathsf{B}}^{m} := \frac{\rho_{\mathsf{R}^{M}\mathsf{B}}^{m}}{\sum_{\bar{m}\in\mathsf{M}}\rho_{\mathsf{R}^{M}\mathsf{B}}^{\bar{m}}}, \quad \forall m \in \mathsf{M}. \tag{48}$$

Note that the decoding part constitutes the main difference from the previous results 16 such as the position-based decoding [16,68] with the Hayashi-Nagaoka operator inequality [36, Lemma 2], and the sequential decoding strategy [40] with an auxiliary probe system and a quantum union bound [39, Theorem 2.1].

Before analyzing the conditional error probability for sending each message  $m \in M$ , we denote  $\mathbb{E}_{|m|}$  as a conditional expectation [115–118] (which is a completely positive and trace-preserving map) from the operator algebra of bounded operators on  $\mathsf{R}^M\mathsf{B}$ , i.e.  $\mathcal{B}(\mathsf{R}^M\mathsf{B})$ , to its subalgebra  $\mathbb{B}(\mathsf{R}^{m-1}\otimes\mathcal{B}(\mathsf{R}_m\mathsf{B})\otimes\mathbb{1}_{\mathsf{R}^{M-m}})$ . The readers may view  $\mathbb{E}_{|m}$  as a partial trace  $\mathrm{Tr}_{\mathsf{R}^{\mathsf{M}\backslash\{m\}}}$  (which traces out systems other than  $\mathsf{R}_m$ ), and hence  $\mathbb{E}_{|m}$  preserves the sub-system  $\mathsf{R}_m\mathsf{B}$  of  $\rho_{\mathsf{R}^M\mathsf{B}}^m$ . Namely, we have

$$\begin{cases} \mathbb{E}_{|m}[\rho_{\mathsf{R}^{M}\mathsf{B}}^{m}] = \mathcal{N}_{\mathsf{A}\to\mathsf{B}}(\theta_{\mathsf{R}_{m}\mathsf{A}_{m}}) = \mathcal{N}_{\mathsf{A}\to\mathsf{B}}(\theta_{\mathsf{R}\mathsf{A}}); \\ \mathbb{E}_{|m}[\rho_{\mathsf{R}^{M}\mathsf{B}}^{\bar{m}}] = \theta_{\mathsf{R}_{m}} \otimes \mathcal{N}_{\mathsf{A}\to\mathsf{B}}(\theta_{\mathsf{A}_{m}}) = \theta_{\mathsf{R}} \otimes \mathcal{N}_{\mathsf{A}\to\mathsf{B}}(\theta_{\mathsf{A}}), \quad \forall \bar{m} \neq m. \end{cases}$$
(49)

<sup>&</sup>lt;sup>17</sup>Namely, the subalgebra consists of all operators in  $\mathcal{B}(\mathsf{R}^M\mathsf{B})$  of the form  $\mathsf{R}^{m-1}\otimes\Upsilon_{\mathsf{R}\dots\mathsf{B}}\otimes\mathsf{R}^{M-m}$  for all  $\Upsilon_{\mathsf{R}\dots\mathsf{B}}\in\mathcal{B}(\mathsf{R}_m\mathsf{B})$ .

Armed with these facts, we are now ready to calculate the average error probability. The error probability conditioned on sending each message  $m \in M$  is

$$\operatorname{Tr}\left[\rho_{\mathsf{R}^{M}\mathsf{B}}^{m}\frac{\sum_{\bar{m}\neq m}\rho_{\mathsf{R}^{M}\mathsf{B}}^{\bar{m}}}{\rho_{\mathsf{R}^{M}\mathsf{B}}^{m}+\sum_{\bar{m}\neq m}\rho_{\mathsf{R}^{M}\mathsf{B}}^{\bar{m}}}\right] \stackrel{\text{(a)}}{\leq} \operatorname{Tr}\left[\rho_{\mathsf{R}^{M}B}^{m} \wedge \left(\sum_{\bar{m}\neq m}\rho_{\mathsf{R}^{M}\mathsf{B}}^{\bar{m}}\right)\right]$$
(50)

$$= \operatorname{Tr}\left[\mathbb{E}_{|m}\left[\rho_{\mathsf{R}^{M}\mathsf{B}}^{m} \wedge \left(\sum_{\bar{m}\neq m} \rho_{\mathsf{R}^{M}\mathsf{B}}^{\bar{m}}\right)\right]\right] \tag{51}$$

$$= \operatorname{Tr}\left[\mathbb{E}_{|m}\left[\rho_{\mathsf{R}^{M}\mathsf{B}}^{m} \wedge \left(\sum_{\bar{m}\neq m} \rho_{\mathsf{R}^{M}\mathsf{B}}^{\bar{m}}\right)\right]\right]$$

$$\stackrel{\text{(b)}}{\leq} \operatorname{Tr}\left[\mathbb{E}_{|m}\left[\rho_{\mathsf{R}^{M}\mathsf{B}}^{m}\right] \wedge \left(\sum_{\bar{m}\neq m} \mathbb{E}_{|m}\left[\rho_{\mathsf{R}^{M}\mathsf{B}}^{\bar{m}}\right)\right]\right]$$

$$(51)$$

$$=\operatorname{Tr}\left[\mathcal{N}_{\mathsf{A}\to\mathsf{B}}(\theta_{\mathsf{R}\mathsf{A}})\wedge\left(M-1\right)\theta_{\mathsf{R}}\otimes\mathcal{N}_{\mathsf{A}\to\mathsf{B}}(\theta_{\mathsf{A}})\right],\tag{53}$$

where, likewise in the proof of Theorem 1, (a) follows from the lower bound of the noncommutative minimal, Fact (vii): (b) is due to the monotonicity of the noncommutative minimal, Fact (iii). Hence, we establish the following one-shot achievability for entanglement-assisted classical communication over quantum channels.

**Theorem 4** (A one-shot achievability bound for EA classical communication over quantum channels).  $\textit{Consider an arbitrary quantum channel $\mathcal{N}_{\mathsf{A}\to\mathsf{B}}$. Then, there exists an $(M,\varepsilon)$-EA-code for $\mathcal{N}_{\mathsf{A}\to\mathsf{B}}$ such that $\mathcal{N}_{\mathsf{A}\to\mathsf{B}}$ is the exists and $(M,\varepsilon)$-EA-code for $\mathcal{N}_{\mathsf{A}\to\mathsf{B}}$ is the exist and $(M,\varepsilon)$-EA-code for $\mathcal{N}_{\mathsf{A}\to\mathsf{B}$ is the exist and $(M,\varepsilon)$-EA-code for $(M,\varepsilon)$ that for any  $\theta_{RA}$ ,

$$\varepsilon \leq \operatorname{Tr} \left[ \mathcal{N}_{\mathsf{A} \to \mathsf{B}}(\theta_{\mathsf{R} \mathsf{A}}) \wedge (M-1) \, \theta_{\mathsf{R}} \otimes \mathcal{N}_{\mathsf{A} \to \mathsf{B}}(\theta_{\mathsf{A}}) \right]. \tag{54}$$

Remark 7. The above derivations re-emphasizes the central idea of the position-based encoding proposed by Anshu, Jain, and Warsi [16]. Namely, the pre-shared entanglement  $\theta_{\mathsf{R}^M\mathsf{A}^M} = \theta_{\mathsf{R}^A}^{\otimes M}$  along with the encoding  $m \mapsto \rho_{\mathsf{R}^M\mathsf{B}}^m = \mathcal{N}_{\mathsf{A}\to\mathsf{B}}(\theta_{\mathsf{R}^M\mathsf{A}_m})$  ensure the mutual independence between each subsystem  $\mathsf{R}_m\mathsf{A}_m$ ,  $m \in M$ , and accordingly  $\mathbb{E}_{|m}[\rho_{\mathsf{R}^M\mathsf{B}}^{\bar{m}}] = \theta_{\mathsf{R}} \otimes \mathcal{N}_{\mathsf{A}\to\mathsf{B}}(\theta_{\mathsf{A}})$  for all  $\bar{m} \neq m$ . Such an independence between the register  $R_m$  of each channel output states hence plays the same role as the independent random codebook used in classical-quantum channel coding (Theorem 1). On the other hand, we would like to point out that normally a communication system operates on a message set that is exponentially large, i.e.  $M \ge e^{nI(R:B)_{\mathcal{N}(\theta)}-O(n)}$ . Preparing exponentially-many copies of pre-shared state  $\theta_{\mathsf{RA}}^{\otimes M}$  might be practically challenging. (Note that even in the classical case, resources required to generate mutual independence among an exponentially large set could not be considered as non-expensive [119, Corollary 3.34). Nevertheless, Anshu, Jain, and Warsi [16, \$IV] adapted an entanglement recycling technique by Strelchuk, Horodecki, and Oppenheim [120] to reduce the required amount of entanglement resource.

From our analysis given above, only pairwise independence among each subsystem  $R_m A_m$  is needed. That is, we only requires  $\operatorname{Tr}_{\mathsf{R}^{\mathsf{M}\backslash\{m,\bar{m}\}}\mathsf{A}^{\mathsf{M}\backslash\{m,\bar{m}\}}}[\theta_{\mathsf{R}^{M}\mathsf{A}^{M}}] = \theta_{\mathsf{R}_{m}\mathsf{A}_{m}} \otimes \theta_{\mathsf{R}_{\bar{m}}\mathsf{A}_{\bar{m}}}$  for all  $m \neq \bar{m}$ . This point of view may provide another angle to reduce the required entanglement resource. Though, to the best of our knowledge, its explicit construction is not clear in a noncommutative probability space. We leave it as a future work.

Directly applying the pretty-good measurement as above allows us to obtain a tighter and cleaner one-shot achievability bound. This then revisits the position-based decoding proposed by Anshu, Jain, and Warsi [16, Lemma 4]. We summarize it as the following one-shot quantum packing lemma that is not only prominent to Theorems 1, 4 and all the forthcoming results in this section, but we believe it is applicable elsewhere in quantum information theory.

**Theorem 5** (A one-shot quantum packing lemma). Let  $\rho_{AB}$  and  $\sigma_{B}$  be arbitrary density operators and let M be an integer. For every  $m \in M := \{1, ..., M\}$ , define

$$\tau^m_{\mathsf{AB}_1 \dots \mathsf{B}_M} := \rho_{\mathsf{AB}_m} \otimes \sigma_{\mathsf{B}_1} \otimes \sigma_{\mathsf{B}_2} \otimes \dots \otimes \sigma_{\mathsf{B}_{m-1}} \otimes \sigma_{\mathsf{B}_{m+1}} \otimes \dots \otimes \sigma_{\mathsf{B}_M}, \tag{55}$$

where  $\rho_{AB_m} = \rho_{AB}$  and  $\sigma_{B_m} = \sigma_B$  for every  $m \in M$ . Then, there exists a measurement

$$\Pi_{\mathsf{AB}_{1}\dots\mathsf{B}_{M}}^{m} := \frac{\tau_{\mathsf{AB}_{1}\dots\mathsf{B}_{M}}^{m}}{\sum_{\bar{m}\in\mathsf{M}}\tau_{\mathsf{AB}_{1}\dots\mathsf{B}_{M}}^{\bar{m}}}, \quad \forall m \in \mathsf{M},$$

$$(56)$$

satisfying, for every  $m \in M$ ,

$$\operatorname{Tr}\left[\tau_{\mathsf{AB}_{1}\ldots\mathsf{B}_{M}}^{m}\left(\mathbb{1}-\Pi_{\mathsf{AB}_{1}\ldots\mathsf{B}_{M}}^{m}\right)\right]\leq\operatorname{Tr}\left[\rho_{\mathsf{AB}}\wedge(M-1)\rho_{\mathsf{A}}\otimes\sigma_{\mathsf{B}}\right].\tag{57}$$

Following the same reasoning as in Proposition 2, Theorem 4 (or Theorem 5) leads to a large deviation type bound, which is tighter than [68, Theorem 6] without a prefactor 4; following the same reasoning as in Proposition 3, Theorem 4 provides a tighter lower bound on the  $\varepsilon$ -one-shot entanglement-assisted capacity for  $\mathcal{N}_{\mathsf{A}\to\mathsf{B}}$  (i.e. the maximal logarithmic size of messages with average error probability below  $\varepsilon$ ) than [16, Theorem 1], [68, Theorem 8], and [39, Theorem 5.1] (with the same improvements as compared in Section 3.1).

**Proposition 6** (Bounding coding error given fixed coding rate). Consider an arbitrary quantum channel  $\mathcal{N}_{A\to B}$ . Then, for any R>0, there exists an  $(e^R,\varepsilon)$ -EA-code for  $\mathcal{N}_{A\to B}$  such that for any  $\theta_{RA}$ ,

$$\varepsilon \le e^{-\frac{1-\alpha}{\alpha} \left( I_{2^{-1/\alpha}}^{\downarrow}(\mathsf{A} : \mathsf{B})_{\mathcal{N}(\theta)} - R \right)}, \quad \forall \alpha \in (1/2, 1). \tag{58}$$

Here, we follow the notation given in Proposition 2.

**Proposition 7** (Bounding coding rate given fixed coding error). Consider an arbitrary quantum channel  $\mathcal{N}_{\mathsf{A}\to\mathsf{B}}$ . Then, for any  $\varepsilon\in(0,1)$  there exists an  $(M,\varepsilon)$ -EA-code for  $\mathcal{N}_{\mathsf{A}\to\mathsf{B}}$  such that for any  $\theta_{\mathsf{R}\mathsf{A}}$  and any  $\delta\in(0,\varepsilon)$ ,

$$\log M \ge D_{\rm h}^{\varepsilon - \delta}(\mathcal{N}_{\mathsf{A} \to \mathsf{B}}(\theta_{\mathsf{R} \mathsf{A}}) \, \| \, \theta_{\mathsf{R}} \otimes \mathcal{N}_{\mathsf{A} \to \mathsf{B}}(\theta_{\mathsf{A}})) - \log \frac{1}{\delta}. \tag{59}$$

Here, we follow the notation given in Proposition 3.

4.3. Classical Data Compression with Quantum Side Information. In this section, we show that how the proposed method in Section 3 can be applied to classical data compression with quantum side information [82, 107, 121–123]. Subsequently, we will simply term such an protocol as CQSW.

**Definition 3** (Classical-quantum channel coding). Let  $\rho_{XB} = \sum_{x \in X} p_{X}(x)|x\rangle\langle x| \otimes \rho_{B}^{x}$  be a classical-quantum state.

- 1. Classical registers X and M and at Alice and a quantum register B at Bob.
- 2. An encoding  $\mathcal{E}: X \to M$  which compresses the source in X to an index in M.
- 3. A decoding measurement described by a family of POVMs indexed by  $m \in M$ , i.e.  $\{\Pi_{\mathsf{B}}^{x,m}\}_{x \in \mathsf{X}}$  on Bob's register B, to recover the source  $x \in \mathsf{X}$ .

An  $(M, \varepsilon)$ -CQSW-code for  $\rho_{XB}$  is a protocol such that |M| = M and the error probability satisfies

$$\sum_{x \in \mathsf{X}} p_{\mathsf{X}}(x) \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \left( \mathbb{1}_{\mathsf{B}} - \Pi_{\mathsf{B}}^{x, \mathcal{E}(x)} \right) \right] \le \varepsilon. \tag{60}$$

Without loss of generality, we assume that the prior distribution of the source,  $p_X$ , has full support for brevity. We also adopt the standard random coding strategy as in Section 3.

- Encoding: The encoder maps each  $x \in X$  pairwise-independently to equiprobable indexes  $m \in M$ .
- **Decoding:** We use the following pretty-good measurement (again given the realization of the above encoding):

$$\Pi_{\mathsf{B}}^{x,m} := \frac{p_{\mathsf{X}}(x)\rho_{\mathsf{B}}^{x}}{\sum_{\bar{x}:\mathcal{E}(\bar{x})=m} p_{\mathsf{X}}(\bar{x})\rho_{\mathsf{B}}^{\bar{x}}}, \quad \forall x \in \mathsf{X}, \, m \in \mathsf{M}.$$

$$(61)$$

**Theorem 8** (A one-shot achievability bound for classical data compression with quantum side information). Consider an arbitrary classical-quantum state  $\rho_{XB} = \sum_{x \in X} p_X(x)|x\rangle\langle x| \otimes \rho_B^x$ . Then, there exists an  $(M,\varepsilon)$ -CQSW-code for  $\rho_{XB}$  such that

$$\varepsilon \le \operatorname{Tr}\left[\rho_{\mathsf{X}\mathsf{B}} \wedge \frac{1}{M} \mathbb{1}_{\mathsf{X}} \otimes \rho_{\mathsf{B}}\right]. \tag{62}$$

*Proof.* We use the pretty-good measurement given in (61) to calculate the expected error probability (over the random encoding) as follows:

$$\mathbb{E}_{x \sim p_{\mathsf{X}}} \mathbb{E}_{m \sim \frac{1}{M}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \frac{\sum_{\bar{x} \neq x, \mathcal{E}(\bar{x}) = m} p_{\mathsf{X}}(\bar{x}) \rho_{\mathsf{B}}^{\bar{x}}}{\sum_{\bar{x} : \mathcal{E}(\bar{x}) = m} p_{\mathsf{X}}(\bar{x}) \rho_{\mathsf{B}}^{\bar{x}}} \right] \overset{\text{(a)}}{\leq} \mathbb{E}_{x \sim p_{\mathsf{X}}} \mathbb{E}_{m \sim \frac{1}{M}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \bigwedge \left( \sum_{\bar{x} \neq x, \mathcal{E}(\bar{x}) = m} \frac{p_{\mathsf{X}}(\bar{x})}{p_{\mathsf{X}}(x)} \rho_{\mathsf{B}}^{\bar{x}} \right) \right] \tag{63}$$

$$\stackrel{\text{(b)}}{\leq} \mathbb{E}_{x \sim p_{\mathsf{X}}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \bigwedge \mathbb{E}_{m \sim \frac{1}{M}} \left( \sum_{\bar{x} \neq x} \mathbf{1}_{\{\mathcal{E}(\bar{x}) = m\}} \frac{p_{\mathsf{X}}(\bar{x})}{p_{\mathsf{X}}(x)} \rho_{\mathsf{B}}^{\bar{x}} \right) \right]$$
(64)

$$\stackrel{\text{(c)}}{\leq} \mathbb{E}_{x \sim p_{\mathsf{X}}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \bigwedge \left( \frac{1}{M} \sum_{\bar{x} \neq x} \frac{p_{\mathsf{X}}(\bar{x})}{p_{\mathsf{X}}(x)} \rho_{\mathsf{B}}^{\bar{x}} \right) \right]$$
 (65)

$$\stackrel{\text{(d)}}{\leq} \mathbb{E}_{x \sim p_{\mathsf{X}}} \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x} \bigwedge \left( \frac{1}{M p_{\mathsf{X}}(x)} \rho_{\mathsf{B}} \right) \right] \tag{66}$$

$$\stackrel{\text{(e)}}{\leq} \operatorname{Tr} \left[ \rho_{\mathsf{XB}} \wedge \left( \frac{1}{M} \mathbb{1}_{\mathsf{X}} \otimes \rho_{\mathsf{B}} \right) \right], \tag{67}$$

where (a) uses the lower bound of the noncommutative minimal given in Fact (vii); (b) follows from the concavity given in Fact (iv); (c) follows from the pairwise-independent and uniform random encoding; (d) follows from the monotone increase in the Loewner ordering and  $\sum_{\bar{x}\neq x} p_{\mathsf{X}}(\bar{x}) \rho_{\mathsf{B}}^{\bar{x}} \leq \sum_{\bar{x}} p_{\mathsf{X}}(\bar{x}) \rho_{\mathsf{B}}^{\bar{x}} = \rho_{\mathsf{B}}$ ; and lastly, (e) follows from the direct sum formula given in Fact (v).

Using the same reasoning as in Propositions 2 and 3 of Section 3, we have the following one-shot bounds for CQSW.

**Proposition 9** (Bounding coding error given fixed coding rate). Consider an arbitrary classical-quantum state  $\rho_{XB} = \sum_{x \in X} p_X(x)|x\rangle\langle x| \otimes \rho_B^x$ . Then, for any R > 0, there exists an  $(e^R, \varepsilon)$ -CQSW-code for  $\rho_{XB}$  such that

$$\varepsilon \le e^{-\frac{1-\alpha}{\alpha} \left( R - H_{2^{-1/\alpha}}^{\downarrow}(\mathsf{X} \mid \mathsf{B})_{\rho} - R \right)}, \quad \forall \alpha \in (1/2, 1), \tag{68}$$

 $where \ H_{\alpha}^{\downarrow}(\mathsf{X}\,|\,\mathsf{B})_{\rho} := -D_{\alpha}(\rho_{\mathsf{XB}}\,\|\,\mathbb{1}_{\mathsf{X}}\otimes\rho_{\mathsf{B}}).$ 

**Proposition 10** (Bounding coding rate given fixed coding error). Consider an arbitrary classical-quantum state  $\rho_{XB} = \sum_{x \in X} p_{X}(x)|x\rangle\langle x| \otimes \rho_{B}^{x}$ . Then, for any  $\varepsilon \in (0,1)$  there exists an  $(M,\varepsilon)$ -CQSW-code for  $\rho_{XB}$  such that for any  $\delta \in (0,\varepsilon)$ ,

$$\log M \le H_{\rm h}^{\varepsilon - \delta} \left( \mathsf{X} \, | \, \mathsf{B} \right)_{o} + \log \frac{1}{\delta},\tag{69}$$

 $where \,\, H_{\mathrm{h}}^{\varepsilon-\delta}\left(\mathsf{X}\,|\,\mathsf{B}\right)_{\varrho} := -D_{\mathrm{h}}^{\varepsilon-\delta}(\rho_{\mathsf{XB}}\,\|\,\mathbb{1}_{\mathsf{X}}\otimes\rho_{\mathsf{B}}).$ 

4.4. Multiple-Access Channel Coding. In this section, we show one-shot achievability bounds for classical-quantum multiple-access channel (MAC) coding and entanglement-assisted classical communication over quantum MACs [68, 124–126]. Note that the former naturally extends to (unassisted) classical communication over quantum MACs. We will present the scenario for only two senders with one receives; the result applies to multiple senders in the same fashion.

**Definition 4** (Classical-quantum multiple-access channel coding). Let  $\mathcal{N}_{\mathsf{XY} \to \mathsf{C}}: (x,y) \mapsto \rho_{\mathsf{C}}^{x,y}$  be a classical-quantum multiple-access channel.

1. Classical registers  $M_A$ , X at Alice and  $M_B$ , Y at Bob; quantum register C at Charlie.

- 2. An encoding at Alice  $m_{\mathsf{A}} \to x(m_{\mathsf{A}}) \in \mathsf{X}$  for any equiprobable message  $m_{\mathsf{A}} \in \mathsf{M}_{\mathsf{A}}$  she wants to send; an encoding at Bob  $m_{\mathsf{B}} \to y(m_{\mathsf{B}}) \in \mathsf{Y}$  for any equiprobable message  $m_{\mathsf{B}} \in \mathsf{M}_{\mathsf{B}}$  he wants to send
- 3. The channel  $\mathcal{N}_{XY\to C}$  is applied on Alice and Bob's registers X and Y, and outputs a state on C at Charlie.
- 4. A decoding measurement  $\{\Pi_{\mathsf{C}}^{m_{\mathsf{A}},m_{\mathsf{B}}}\}_{(m_{\mathsf{A}},m_{\mathsf{B}})\in\mathsf{M}_{\mathsf{A}}\times\mathsf{M}_{\mathsf{B}}}$  on registers  $\mathsf{C}$  to extract the sent message  $(m_{\mathsf{A}},m_{\mathsf{B}})$ .

An  $(M_A, M_B, \varepsilon)$ -code for  $\mathcal{N}_{XY\to C}$  is a protocol such that  $|\mathsf{M}_A| = M_A$ ,  $|\mathsf{M}_B| = M_B$ , and the average error probability satisfies

$$\frac{1}{M_{\mathsf{A}}M_{\mathsf{B}}} \sum_{(m_{\mathsf{A}}, m_{\mathsf{B}}) \in \mathsf{M}_{\mathsf{A}} \times \mathsf{M}_{\mathsf{B}}} \operatorname{Tr} \left[ \left( \mathbb{1} - \Pi_{\mathsf{C}}^{m_{\mathsf{A}}, m_{\mathsf{B}}} \right) \rho_{\mathsf{C}}^{x(m_{\mathsf{A}}), y(m_{\mathsf{B}})} \right] \leq \varepsilon. \tag{70}$$

We follow the strategy presented in Section 3.

- Encoding: Each pair of messages  $(m_A, m_B) \in M_A \times M_B$  is mapped to a codeword  $(x(m_A), y(m_B)) \in X \times Y$  pairwise-independently according to some probability distribution  $p_X \otimes p_Y$ .
- **Decoding:** Pretty-good measurement with respect to the corresponding channel output states (given the realization of the random codebook):

$$\Pi_{\mathsf{C}}^{m_{\mathsf{A}},m_{\mathsf{B}}} = \frac{\rho_{\mathsf{C}}^{x(m_{\mathsf{A}}),y(m_{\mathsf{B}})}}{\sum_{(\bar{m}_{\mathsf{A}},\bar{m}_{\mathsf{B}})} \rho_{\mathsf{C}}^{x(\bar{m}_{\mathsf{A}}),y(\bar{m}_{\mathsf{B}})}}, \quad (m_{\mathsf{A}},m_{\mathsf{B}}) \in \mathsf{M}_{\mathsf{A}} \times \mathsf{M}_{\mathsf{B}}. \tag{71}$$

Then, we obtain the following result (without duplicating the proof).

**Theorem 11** (A one-shot achievability bound for classical-quantum MAC coding). Consider an arbitrary classical-quantum multiple-access channel  $\mathcal{N}_{\mathsf{XY}\to\mathsf{C}}:(x,y)\mapsto\rho_{\mathsf{C}}^{x,y}$ . Then, there exists an  $(M_\mathsf{A},M_\mathsf{B},\varepsilon)$ -code for  $\mathcal{N}_{\mathsf{XY}\to\mathsf{C}}$  such that for any probability distributions  $p_\mathsf{X}$  and  $p_\mathsf{Y}$ ,

$$\varepsilon \leq \operatorname{Tr}\left[\rho_{\mathsf{XYC}} \bigwedge \left((M_{\mathsf{A}} - 1)\rho_{\mathsf{X}} \otimes \rho_{\mathsf{YC}} + (M_{\mathsf{B}} - 1)\rho_{\mathsf{Y}} \otimes \rho_{\mathsf{XC}} + (M_{\mathsf{A}} - 1)(M_{\mathsf{B}} - 1)\rho_{\mathsf{X}} \otimes \rho_{\mathsf{Y}} \otimes \rho_{\mathsf{C}}\right)\right], \tag{72}$$
 where 
$$\rho_{\mathsf{XYC}} := \sum_{(x,y) \in \mathsf{X} \times \mathsf{Y}} p_{\mathsf{X}}(x) |x\rangle \langle x|_{\mathsf{X}} \otimes p_{\mathsf{Y}}(y) |y\rangle \langle y|_{\mathsf{Y}} \otimes \rho_{\mathsf{C}}^{x,y}.$$

Next, we consider the entanglement-assisted setting.

**Definition 5** (Entanglement-assisted classical communication over quantum multiple-access channels). Let  $\mathcal{N}_{\mathsf{AB}\to\mathsf{C}}$  be a quantum multiple-access channel.

- 1. Classical registers  $M_A$  at Alice and  $M_B$  at Bob; quantum registers A and A' at Alice and quantum register B and B' at Bob, and quantum registers C,  $R_A'$  and  $R_B'$  at Charlie.
- 2. Resources of arbitrary state  $\theta_{R'_AA'}$  shared between Charlie and Alice, and state  $\theta_{R'_BB'}$  shared between Charlie and Bob.
- 3. An encoding at Alice  $\mathcal{E}_{\mathsf{A}'\to\mathsf{A}}^{m_\mathsf{A}}$  on  $\theta_{\mathsf{R}'_\mathsf{A}\mathsf{A}'}$  for any equiprobable message  $m_\mathsf{A}\in\mathsf{M}_\mathsf{A}$  she wants to send; an encoding at Bob  $\mathcal{E}_{\mathsf{B}'\to\mathsf{B}}^{m_\mathsf{B}}$  on  $\theta_{\mathsf{R}'_\mathsf{B}\mathsf{B}'}$  for any equiprobable message  $m_\mathsf{B}\in\mathsf{M}_\mathsf{B}$  he wants to send.
- 4. The channel  $\mathcal{N}_{AB\to C}$  is applied on Alice and Bob's registers A and B, and outputs a state on C at Charlie.
- 5. A decoding measurement  $\{\Pi_{\mathsf{R}_{\mathsf{A}}'\mathsf{R}_{\mathsf{B}}'\mathsf{C}}^{m_{\mathsf{A}},m_{\mathsf{B}}}\}_{(m_{\mathsf{A}},m_{\mathsf{B}})\in\mathsf{M}_{\mathsf{A}}\times\mathsf{M}_{\mathsf{B}}}$  on registers  $\mathsf{R}_{\mathsf{A}}\mathsf{R}_{\mathsf{B}}\mathsf{C}$  to extract the sent message  $(m_{\mathsf{A}},m_{\mathsf{B}})$ .

An  $(M_{\mathsf{A}}, M_{\mathsf{B}}, \varepsilon)$ -EA-code for  $\mathcal{N}_{\mathsf{AB}\to\mathsf{C}}$  is a protocol such that  $|\mathsf{M}_{\mathsf{A}}| = M_{\mathsf{A}}$ ,  $|\mathsf{M}_{\mathsf{B}}| = M_{\mathsf{B}}$ , and the average error probability satisfies

$$\frac{1}{M_{\mathsf{A}}M_{\mathsf{B}}}\sum_{(m_{\mathsf{A}},m_{\mathsf{B}})\in\mathsf{M}_{\mathsf{A}}\times\mathsf{M}_{\mathsf{B}}}\mathrm{Tr}\left[\left(\mathbb{1}-\Pi_{\mathsf{R}_{\mathsf{A}}^{\prime}\mathsf{R}_{\mathsf{B}}^{\prime}}^{m_{\mathsf{A}},m_{\mathsf{B}}}\right)\mathcal{N}_{\mathsf{AB}\to\mathsf{C}}\left(\mathcal{E}_{\mathsf{A}^{\prime}\to\mathsf{A}}^{m_{\mathsf{A}}}\left(\theta_{\mathsf{R}_{\mathsf{A}}^{\prime}\mathsf{A}^{\prime}}\right)\otimes\mathcal{E}_{\mathsf{B}^{\prime}\to\mathsf{B}}^{m_{\mathsf{B}}}\left(\theta_{\mathsf{R}_{\mathsf{B}}^{\prime}\mathsf{B}^{\prime}}\right)\right)\right]\leq\varepsilon.\tag{73}$$

As in Section 4.2, we use the position-based encoding (see also [68]) and the pretty-good measurement as decoding.

• **Preparation:**  $M_{\mathsf{A}}$ -fold product state  $\theta_{\mathsf{R}'_{\mathsf{A}}\mathsf{A}'} := \theta_{\mathsf{R}_{\mathsf{A}}\mathsf{A}}^{\otimes M_{\mathsf{A}}}$  shared at Charlie and Alice, and  $M_{\mathsf{B}}$ -fold product state  $\theta_{\mathsf{R}'_{\mathsf{B}}\mathsf{B}'} := \theta_{\mathsf{R}_{\mathsf{B}}\mathsf{B}}^{\otimes M_{\mathsf{B}}}$  shared at Charlie and Bob.

- Encoding:  $\mathcal{E}_{\mathsf{A}^{M_\mathsf{A}}\to\mathsf{A}}^{m_\mathsf{A}} = \mathrm{Tr}_{\mathsf{A}^{\mathsf{M}_\mathsf{A}\setminus\{m_\mathsf{A}\}}}$  for each  $m_\mathsf{A}\in\mathsf{M}_\mathsf{A}$  at Alice, and  $\mathcal{E}_{\mathsf{B}^{M_\mathsf{B}}\to\mathsf{B}}^{m_\mathsf{B}} = \mathrm{Tr}_{\mathsf{B}^{\mathsf{M}_\mathsf{B}\setminus\{m_\mathsf{B}\}}}$  for each  $m_\mathsf{B}\in\mathsf{M}_\mathsf{B}$ .
- **Decoding:** Denote the corresponding channel output state for sending message  $(m_A, m_B) \in M_A \times M_B$  by

$$\rho_{\mathsf{R}_{\mathsf{A}}^{M_{\mathsf{A}}}\mathsf{R}_{\mathsf{R}}^{M_{\mathsf{B}}}\mathsf{C}}^{m_{\mathsf{A}},m_{\mathsf{B}}} := \theta_{\mathsf{R}_{\mathsf{A}}}^{\otimes (m_{\mathsf{A}}-1)} \otimes \theta_{\mathsf{R}_{\mathsf{B}}}^{\otimes (m_{\mathsf{B}}-1)} \otimes \mathcal{N}_{\mathsf{A}\mathsf{B}\to\mathsf{C}} \left(\theta_{\mathsf{R}_{\mathsf{A}}} \otimes \theta_{\mathsf{R}_{\mathsf{B}}}\right) \otimes \theta_{\mathsf{R}_{\mathsf{A}}}^{\otimes (M_{\mathsf{A}}-m_{\mathsf{A}})} \otimes \theta_{\mathsf{R}_{\mathsf{B}}}^{\otimes (M_{\mathsf{B}}-m_{\mathsf{B}})}. \tag{74}$$

Then, we use the associated pretty-good measurement:

$$\Pi_{\mathsf{R}_{\mathsf{A}}\mathsf{R}_{\mathsf{B}}\mathsf{C}}^{m_{\mathsf{A}},m_{\mathsf{B}}} = \frac{\rho_{\mathsf{R}_{\mathsf{A}}^{M_{\mathsf{A}}}\mathsf{R}_{\mathsf{B}}^{M_{\mathsf{B}}}\mathsf{C}}^{m_{\mathsf{A}},m_{\mathsf{B}}}}{\sum_{(\bar{m}_{\mathsf{A}},\bar{m}_{\mathsf{B}})} \rho_{\mathsf{R}_{\mathsf{A}}^{M_{\mathsf{A}}}\mathsf{R}_{\mathsf{B}}^{M_{\mathsf{B}}}\mathsf{C}}^{\bar{m}_{\mathsf{A}},\bar{m}_{\mathsf{B}}}}, \quad (m_{\mathsf{A}},m_{\mathsf{B}}) \in \mathsf{M}_{\mathsf{A}} \times \mathsf{M}_{\mathsf{B}}. \tag{75}$$

Following the analysis presented in Section 4.2, we immediately obtain the following result (without duplicating the proof).

**Theorem 12** (A one-shot achievability bound for EA classical communication over quantum MAC). Consider an arbitrary quantum multiple-access channel  $\mathcal{N}_{\mathsf{AB}\to\mathsf{C}}$ . Then, there exists an  $(M_\mathsf{A},M_\mathsf{B},\varepsilon)$ -EA-code for  $\mathcal{N}_{\mathsf{AB}\to\mathsf{C}}$  such that for any  $\theta_{\mathsf{R}_\mathsf{A}}$  and  $\theta_{\mathsf{R}_\mathsf{R}}$ ,

$$\varepsilon \leq \operatorname{Tr}\left[\rho_{\mathsf{R}_{\mathsf{A}}\mathsf{R}_{\mathsf{B}}\mathsf{C}} \bigwedge \left((M_{\mathsf{A}}-1)\rho_{\mathsf{R}_{\mathsf{A}}} \otimes \rho_{\mathsf{R}_{\mathsf{B}}\mathsf{C}} + (M_{\mathsf{B}}-1)\rho_{\mathsf{R}_{\mathsf{B}}} \otimes \rho_{\mathsf{R}_{\mathsf{A}}\mathsf{C}} + (M_{\mathsf{A}}-1)(M_{\mathsf{B}}-1)\rho_{\mathsf{R}_{\mathsf{A}}} \otimes \rho_{\mathsf{R}_{\mathsf{B}}} \otimes \rho_{\mathsf{C}}\right)\right],$$

$$(76)$$

$$where \ \rho_{\mathsf{R}_{\mathsf{A}}\mathsf{R}_{\mathsf{B}}\mathsf{C}} := \mathcal{N}_{\mathsf{A}\mathsf{B}\to\mathsf{C}}\left(\theta_{\mathsf{R}_{\mathsf{A}}}\mathsf{A} \otimes \theta_{\mathsf{R}_{\mathsf{B}}}\mathsf{B}\right).$$

4.5. **Broadcast Channel Coding.** In this section, we study entanglement-assisted/unassisted classical communication over quantum broadcast channels [16, 26, 127–133].

**Definition 6** (Classical-quantum broadcast channel coding). Let  $\mathcal{N}_{X\to BC}: x\mapsto \rho_{BC}^x$  be a classical-quantum broadcast channel.

- 1. Classical registers  $M_B$ ,  $M_C$  at Alice; quantum registers B and C at Bob and Charlie, respectively.
- 2. An encoding at Alice  $(m_{\mathsf{B}}, m_{\mathsf{C}}) \to x(m_{\mathsf{B}}, m_{\mathsf{C}}) \in \mathsf{X}$  for any equiprobable message  $(m_{\mathsf{B}}, m_{\mathsf{C}}) \in \mathsf{M}_{\mathsf{B}} \times \mathsf{M}_{\mathsf{C}}$  she wants to send to Bob and Charlie, respectively.
- 3. The channel  $\mathcal{N}_{\mathsf{X}\to\mathsf{BC}}$  is applied on Alice's registers  $\mathsf{X}$ , and outputs a marginal state on  $\mathsf{B}$  at Bob and a marginal state on  $\mathsf{C}$  at Charlie.
- 4. Bob performs a decoding measurement  $\{\Pi_{\mathsf{B}}^{m_{\mathsf{B}}}\}_{m_{\mathsf{B}}\in\mathsf{M}_{\mathsf{B}}}$  on register B to extract the sent message  $m_{\mathsf{B}}$ , and Charlie performs a decoding measurement  $\{\Pi_{\mathsf{C}}^{m_{\mathsf{C}}}\}_{m_{\mathsf{C}}\in\mathsf{M}_{\mathsf{C}}}$  on register C to extract the sent message  $m_{\mathsf{C}}$ .

An  $(M_{\mathsf{B}}, M_{\mathsf{C}}, \varepsilon_{\mathsf{B}}, \varepsilon_{\mathsf{C}})$ -code for  $\mathcal{N}_{\mathsf{X}\to\mathsf{BC}}: x\mapsto \rho_{\mathsf{BC}}^x$  is a protocol such that  $|\mathsf{M}_{\mathsf{B}}|=M_{\mathsf{B}}, \, |\mathsf{M}_{\mathsf{C}}|=M_{\mathsf{C}}$ , and the average error probabilities satisfy

$$\begin{cases}
\frac{1}{M_{\mathsf{B}}M_{\mathsf{C}}} \sum_{(m_{\mathsf{B}},m_{\mathsf{C}})\in\mathsf{M}_{\mathsf{B}}\times\mathsf{M}_{\mathsf{C}}} \operatorname{Tr}\left[\left(\mathbb{1}-\Pi_{\mathsf{B}}^{m_{\mathsf{B}}}\right)\rho_{\mathsf{B}}^{x(m_{\mathsf{B}},m_{\mathsf{C}})}\right] \leq \varepsilon_{\mathsf{B}}; \\
\frac{1}{M_{\mathsf{B}}M_{\mathsf{C}}} \sum_{(m_{\mathsf{B}},m_{\mathsf{C}})\in\mathsf{M}_{\mathsf{B}}\times\mathsf{M}_{\mathsf{C}}} \operatorname{Tr}\left[\left(\mathbb{1}-\Pi_{\mathsf{C}}^{m_{\mathsf{C}}}\right)\rho_{\mathsf{C}}^{x(m_{\mathsf{B}},m_{\mathsf{C}})}\right] \leq \varepsilon_{\mathsf{C}}.
\end{cases} (77)$$

We follow the analysis proposed in Section 3 by considering communication from Alice to Bob and from Alice to Charlie, separately.

• Encoding: We introduce two auxiliary classical registers U and V for precoding. Message  $m_{\mathsf{B}} \in \mathsf{M}_{\mathsf{B}}$  for Bob is encoded to a pre-codeword  $u(m_{\mathsf{B}})$  pairwise-independently according to some probability distribution  $p_{\mathsf{U}}$ , and message  $m_{\mathsf{C}} \in \mathsf{M}_{\mathsf{C}}$  for Charlie is encoded to a pre-codeword  $v(m_{\mathsf{C}})$  pairwise-independently according to some probability distribution  $p_{\mathsf{V}}$ . Then, Alice picks a (deterministic) encoding  $(u(m_{\mathsf{B}}), v(m_{\mathsf{C}})) \mapsto x(u(m_{\mathsf{B}}), v(m_{\mathsf{C}})) \in \mathsf{X}$ .

• **Decoding:** Denoting (with a slight abuse of notation) the marginal channel output states at Bob by  $\rho_{\mathsf{B}}^{m_{\mathsf{B}}} := \frac{1}{M_{\mathsf{C}}} \sum_{m_{\mathsf{C}} \in \mathsf{M}_{\mathsf{C}}} \rho_{\mathsf{B}}^{x(u(m_{\mathsf{B}}),v(m_{\mathsf{C}}))}$ ,  $m_{\mathsf{B}} \in \mathsf{M}_{\mathsf{B}}$ , Bob performs the corresponding pretty-good measurement:

$$\Pi_{\mathsf{B}}^{m_{\mathsf{B}}} := \frac{\rho_{\mathsf{B}}^{m_{\mathsf{B}}}}{\sum_{\bar{m}_{\mathsf{B}} \in \mathsf{M}_{\mathsf{B}}} \rho_{\mathsf{B}}^{\bar{m}_{\mathsf{B}}}}, \quad m_{\mathsf{B}} \in \mathsf{M}_{\mathsf{B}}.$$
(78)

Similarly, denoting (with a slight abuse of notation again) the marginal channel output states at Charlie by  $\rho_{\mathsf{C}}^{m_{\mathsf{C}}} := \frac{1}{M_{\mathsf{B}}} \sum_{m_{\mathsf{B}} \in \mathsf{M}_{\mathsf{B}}} \rho_{\mathsf{C}}^{x(u(m_{\mathsf{B}}),v(m_{\mathsf{C}}))}$ ,  $m_{\mathsf{C}} \in \mathsf{M}_{\mathsf{C}}$ , Charlie performs the corresponding pretty-good measurement:

$$\Pi_{\mathsf{C}}^{m_{\mathsf{C}}} := \frac{\rho_{\mathsf{C}}^{m_{\mathsf{C}}}}{\sum_{\bar{m}_{\mathsf{C}} \in \mathsf{M}_{\mathsf{C}}} \rho_{\mathsf{C}}^{\bar{m}_{\mathsf{C}}}}, \quad m_{\mathsf{C}} \in \mathsf{M}_{\mathsf{C}}.$$

$$(79)$$

Then, we obtain the following result (without duplicating the proof).

**Theorem 13** (A one-shot achievability bound for classical-quantum broadcast channel coding). Consider an arbitrary classical-quantum broadcast channel  $\mathcal{N}_{\mathsf{X}\to\mathsf{BC}}: x\mapsto \rho_{\mathsf{BC}}^x$ . Then, there exists an  $(M_\mathsf{B},M_\mathsf{C},\varepsilon_\mathsf{B},\varepsilon_\mathsf{C})$ -code for  $\mathcal{N}_{\mathsf{X}\to\mathsf{BC}}$  such that for any probability distributions  $p_\mathsf{U}$  and  $p_\mathsf{V}$ , and (deterministic) encoding  $(u,v)\mapsto x(u,v)$ ,

$$\varepsilon_{\mathsf{B}} \le \operatorname{Tr}\left[\rho_{\mathsf{U}\mathsf{B}} \wedge (M_{\mathsf{B}} - 1)\rho_{\mathsf{U}} \otimes \rho_{\mathsf{B}}\right];$$
(80)

$$\varepsilon_{\mathsf{C}} \le \operatorname{Tr} \left[ \rho_{\mathsf{UC}} \wedge (M_{\mathsf{C}} - 1) \rho_{\mathsf{V}} \otimes \rho_{\mathsf{C}} \right],$$
 (81)

where  $\rho_{\mathsf{UVBC}} := \sum_{(u,v) \in \mathsf{U} \times \mathsf{V}} p_{\mathsf{U}}(u) |u\rangle \langle u|_{\mathsf{U}} \otimes p_{\mathsf{V}}(v) |v\rangle \langle v|_{\mathsf{V}} \otimes \rho_{\mathsf{BC}}^{x(u,v)}.$ 

Note that Theorem 13 extends to classical communication over quantum broadcast channels straightforwardly (see Table 1).

Remark 8. Theorem 13 employs independent pre-coding  $p_{\mathsf{U}} \otimes p_{\mathsf{V}}$  and hence it provides a simple and clean one-shot achievability bound. We note that such a scenario was considered by Anshu, Jain, and Warsi [132]. Hence, Theorem 13 improves on the achievability in [132, Theorem 13].

Generally, Alice can adopt a joint pre-coding  $p_{UV}$ , which is called *Marton's inner bound* in the classical setting [134,135] (see also the studies in the quantum setting [16,26,127–130]); however, it would require additional covering techniques. We leave it as a future work [136].

Next, we present entanglement-assisted classical communication over quantum broadcast channels.

**Definition 7** (Entanglement-assisted classical communication over quantum broadcast channels). Let  $\mathcal{N}_{A\to BC}$  be a quantum broadcast channel.

- 1. Classical registers  $M_B$ ,  $M_C$  at Alice; quantum registers A,  $A_B'$ , and  $A_C'$  at Alice, quantum registers B and  $R_B'$  at Bob and quantum registers C and  $R_C'$  at Charlie, respectively.
- 2. Resources of arbitrary state  $\theta_{R'_BA'_B}$  shared between Bob and Alice, and state  $\theta_{R'_CA'_C}$  shared between Charlie and Alice.
- 3. An encoding  $\mathcal{E}_{\mathsf{A}'_{\mathsf{B}}\mathsf{A}'_{\mathsf{C}}\to\mathsf{A}}^{m_{\mathsf{B}},m_{\mathsf{C}}}$  performed on  $\theta_{\mathsf{R}'_{\mathsf{B}}\mathsf{A}'_{\mathsf{C}}}\otimes\theta_{\mathsf{R}'_{\mathsf{C}}\mathsf{A}'_{\mathsf{C}}}$  by Alice for any equiprobable message  $(m_{\mathsf{B}},m_{\mathsf{C}})\in\mathsf{M}_{\mathsf{B}}\times\mathsf{M}_{\mathsf{C}}$  she wants to send to Bob and Charlie, respectively.
- 4. The channel  $\mathcal{N}_{\mathsf{A}\to\mathsf{BC}}$  is applied on Alice's registers A, and outputs a marginal state on B at Bob and a marginal state on C at Charlie.
- 5. Bob performs a decoding measurement  $\{\Pi_{\mathsf{R}_\mathsf{b}'\mathsf{B}}^{m_\mathsf{B}}\}_{m_\mathsf{B}\in\mathsf{M}_\mathsf{B}}$  on registers B to extract the sent message  $m_\mathsf{B}$ , and Charlie performs a decoding measurement  $\{\Pi_{\mathsf{R}_\mathsf{C}'\mathsf{C}}^{m_\mathsf{C}}\}_{m_\mathsf{C}\in\mathsf{M}_\mathsf{C}}$  on registers C to extract the sent message  $m_\mathsf{C}$ .

An  $(M_{\mathsf{B}}, M_{\mathsf{C}}, \varepsilon_{\mathsf{B}}, \varepsilon_{\mathsf{C}})$ -EA-code for  $\mathcal{N}_{\mathsf{A}\to\mathsf{BC}}$  is a protocol such that  $|\mathsf{M}_{\mathsf{B}}| = M_{\mathsf{B}}$ ,  $|\mathsf{M}_{\mathsf{C}}| = M_{\mathsf{C}}$  and the average error probabilities satisfy

$$\begin{cases}
\frac{1}{M_{\mathsf{B}}M_{\mathsf{C}}} \sum_{(m_{\mathsf{B}},m_{\mathsf{C}})\in\mathsf{M}_{\mathsf{B}}\times\mathsf{M}_{\mathsf{C}}} \operatorname{Tr}\left[\left(\mathbb{1}-\Pi_{\mathsf{R}_{\mathsf{B}}'\mathsf{B}}^{m_{\mathsf{B}}}\right) \mathcal{N}_{\mathsf{A}\to\mathsf{BC}} \circ \mathcal{E}_{\mathsf{A}_{\mathsf{B}}'\mathsf{A}_{\mathsf{C}}'\to\mathsf{A}}^{m_{\mathsf{B}},m_{\mathsf{C}}} \left(\theta_{\mathsf{R}_{\mathsf{B}}'\mathsf{A}_{\mathsf{B}}'} \otimes \theta_{\mathsf{R}_{\mathsf{C}}'\mathsf{A}_{\mathsf{C}}'}\right)\right] \leq \varepsilon_{\mathsf{B}}; \\
\frac{1}{M_{\mathsf{B}}M_{\mathsf{C}}} \sum_{(m_{\mathsf{B}},m_{\mathsf{C}})\in\mathsf{M}_{\mathsf{B}}\times\mathsf{M}_{\mathsf{C}}} \operatorname{Tr}\left[\left(\mathbb{1}-\Pi_{\mathsf{R}_{\mathsf{C}}'\mathsf{C}}^{m_{\mathsf{C}}}\right) \mathcal{N}_{\mathsf{A}\to\mathsf{BC}} \circ \mathcal{E}_{\mathsf{A}_{\mathsf{B}}'\mathsf{A}_{\mathsf{C}}'\to\mathsf{A}}^{m_{\mathsf{B}},m_{\mathsf{C}}} \left(\theta_{\mathsf{R}_{\mathsf{B}}'\mathsf{A}_{\mathsf{B}}'} \otimes \theta_{\mathsf{R}_{\mathsf{C}}'\mathsf{A}_{\mathsf{C}}'}\right)\right] \leq \varepsilon_{\mathsf{C}}.
\end{cases} (82)$$

We follow the similar analysis as above by considering communication from Alice to Bob and from Alice to Charlie, separately. Again, we also employ the position-based encoding as in [16, Theorem 6] and [132, Theorem 6], and apply the pretty-good measurement.

- **Preparation:** Consider an arbitrary state  $\theta_{\mathsf{R}_\mathsf{B}\mathsf{R}_\mathsf{C}\mathsf{A}}$  satisfying  $\theta_{\mathsf{R}_\mathsf{B}\mathsf{R}_\mathsf{C}} = \theta_{\mathsf{R}_\mathsf{B}} \otimes \theta_{\mathsf{R}_\mathsf{C}}$ . Let  $\theta_{\mathsf{R}_\mathsf{B}\mathsf{A}_\mathsf{B}}$  be a purified state of  $\theta_{\mathsf{R}_\mathsf{C}}$  and let  $\theta_{\mathsf{R}_\mathsf{C}\mathsf{A}_\mathsf{C}}$  be a purified state of  $\theta_{\mathsf{R}_\mathsf{C}}$ . Then, Alice and Bob share an  $M_\mathsf{B}$ -fold product state  $\theta_{\mathsf{R}_\mathsf{C}'\mathsf{A}_\mathsf{C}'} := \theta_{\mathsf{R}_\mathsf{B}}^{M_\mathsf{B}}$ , and Alice and Charlie share an  $M_\mathsf{C}$ -fold product state  $\theta_{\mathsf{R}_\mathsf{C}'\mathsf{A}_\mathsf{C}'} := \theta_{\mathsf{R}_\mathsf{C}}^{M_\mathsf{C}}$ .
- product state  $\theta_{\mathsf{R}'_\mathsf{B}\mathsf{A}'_\mathsf{B}} := \theta_{\mathsf{R}_\mathsf{B}\mathsf{A}_\mathsf{B}}^{M_\mathsf{B}}$ , and Alice and Charlie share an  $M_\mathsf{C}$ -fold product state  $\theta_{\mathsf{R}'_\mathsf{C}\mathsf{A}'_\mathsf{C}} := \theta_{\mathsf{R}_\mathsf{C}\mathsf{A}_\mathsf{C}}^{M_\mathsf{C}}$ .

   **Encoding:** For each  $(m_\mathsf{B}, m_\mathsf{C}) \in \mathsf{M}_\mathsf{B} \times \mathsf{M}_\mathsf{C}$ , Alice sends the  $(m_\mathsf{B}, m_\mathsf{C})$ -th registers  $\mathsf{A}_\mathsf{B}\mathsf{A}_\mathsf{C}$  and then applies an isometry, i.e.  $\mathcal{E}_{\mathsf{A}_\mathsf{B}^\mathsf{M}\mathsf{A}_\mathsf{C}^\mathsf{C}\to\mathsf{A}}^{m_\mathsf{B},m_\mathsf{C}} = \mathrm{Tr}_\mathsf{E} \circ \mathcal{V}_{\mathsf{A}_\mathsf{B}\mathsf{A}_\mathsf{C}\to\mathsf{E}\mathsf{A}} \circ \mathrm{Tr}_{\mathsf{A}_\mathsf{B}^\mathsf{M}\mathsf{B}\backslash\mathsf{A}_\mathsf{C}^{M_\mathsf{C}}\setminus\mathsf{A}_\mathsf{C}}$ , where  $\mathcal{V}_{\mathsf{A}_\mathsf{B}\mathsf{A}_\mathsf{C}\to\mathsf{E}\mathsf{A}}$  is an isometry transformation such that  $\mathcal{V}_{\mathsf{A}_\mathsf{B}\mathsf{A}_\mathsf{C}\to\mathsf{E}\mathsf{A}} \left(\theta_{\mathsf{R}_\mathsf{B}\mathsf{A}_\mathsf{B}} \otimes \theta_{\mathsf{R}_\mathsf{C}\mathsf{A}_\mathsf{C}}\right)$  equals a purified state  $\theta_{\mathsf{E}\mathsf{R}_\mathsf{B}\mathsf{R}_\mathsf{C}\mathsf{A}}$  of  $\theta_{\mathsf{R}_\mathsf{B}\mathsf{R}_\mathsf{C}\mathsf{A}}$  with an additional purifying register  $\mathsf{E}$ .
- **Decoding:** Denoting (with a slight abuse of notation) the marginal channel output states at Bob by

$$\rho_{\mathsf{R}_{\mathtt{B}}^{M_{\mathsf{B}}}\mathsf{B}}^{m_{\mathsf{B}}} := \theta_{\mathsf{R}_{\mathsf{B}}}^{m_{\mathsf{B}}-1} \otimes \mathrm{Tr}_{\mathsf{CER}_{\mathsf{C}}} \circ \mathcal{N}_{\mathsf{A} \to \mathsf{BC}} \circ \mathcal{V}_{\mathsf{A}_{\mathsf{B}}\mathsf{A}_{\mathsf{C}} \to \mathsf{EA}} \left( \theta_{\mathsf{R}_{\mathsf{B}}\mathsf{A}_{\mathsf{B}}} \otimes \theta_{\mathsf{R}_{\mathsf{C}}\mathsf{A}_{\mathsf{C}}} \right) \otimes \theta_{\mathsf{R}_{\mathsf{B}}}^{M_{\mathsf{B}}-m_{\mathsf{B}}}, \quad m_{\mathsf{B}} \in \mathsf{M}_{\mathsf{B}}. \tag{83}$$

Bob performs the corresponding pretty-good measurement:

$$\Pi_{\mathsf{R}_{\mathsf{B}}^{M_{\mathsf{B}}}\mathsf{B}}^{m_{\mathsf{B}}} := \frac{\rho_{\mathsf{R}_{\mathsf{B}}^{M_{\mathsf{B}}}\mathsf{B}}^{m_{\mathsf{B}}}}{\sum_{\bar{m}_{\mathsf{B}}\in\mathsf{M}_{\mathsf{B}}} \rho_{\mathsf{R}_{\mathsf{P}}^{M_{\mathsf{B}}}\mathsf{B}}^{\bar{m}_{\mathsf{B}}}}, \quad m_{\mathsf{B}} \in \mathsf{M}_{\mathsf{B}}.$$
(84)

Similarly, denoting (with a slight abuse of notation again) the marginal channel output states at Charlie by

$$\rho_{\mathsf{R}_\mathsf{C}^{M_\mathsf{C}}}^{m_\mathsf{C}} := \theta_{\mathsf{R}_\mathsf{C}}^{m_\mathsf{C}-1} \otimes \mathrm{Tr}_{\mathsf{BER}_\mathsf{B}} \circ \mathcal{N}_{\mathsf{A} \to \mathsf{BC}} \circ \mathcal{V}_{\mathsf{A}_\mathsf{B}\mathsf{A}_\mathsf{C} \to \mathsf{EA}} \left( \theta_{\mathsf{R}_\mathsf{B}} \mathsf{A}_\mathsf{B}} \otimes \theta_{\mathsf{R}_\mathsf{C}} \right) \otimes \theta_{\mathsf{R}_\mathsf{C}}^{M_\mathsf{C} - m_\mathsf{C}}, \quad m_\mathsf{C} \in \mathsf{M}_\mathsf{C}. \tag{85}$$

Charlie performs the corresponding pretty-good measurement:

$$\Pi_{\mathsf{R}_{\mathsf{C}}^{M_{\mathsf{C}}}\mathsf{C}}^{m_{\mathsf{C}}} := \frac{\rho_{\mathsf{R}_{\mathsf{C}}^{M_{\mathsf{C}}}\mathsf{C}}^{m_{\mathsf{C}}}}{\sum_{\bar{m}_{\mathsf{C}}\in\mathsf{M}_{\mathsf{C}}} \rho_{\mathsf{R}_{\mathsf{C}}^{M_{\mathsf{C}}}\mathsf{C}}^{\bar{m}_{\mathsf{C}}}}, \quad m_{\mathsf{C}}\in\mathsf{M}_{\mathsf{C}}.$$
(86)

Then, we obtain the following result (without duplicating the proof).

**Theorem 14** (A one-shot achievability bound for EA classical communication over quantum broadcast channels). Consider an arbitrary quantum broadcast channel  $\mathcal{N}_{\mathsf{A}\to\mathsf{BC}}$ . Then, there exists an  $(M_\mathsf{B},M_\mathsf{C},\varepsilon_\mathsf{B},\varepsilon_\mathsf{C})$ -EA-code for  $\mathcal{N}_{\mathsf{A}\to\mathsf{BC}}$  such that for any  $\theta_{\mathsf{R}_\mathsf{B}\mathsf{R}_\mathsf{C}}$  satisfying  $\theta_{\mathsf{R}_\mathsf{B}\mathsf{R}_\mathsf{C}} = \theta_{\mathsf{R}_\mathsf{B}} \otimes \theta_{\mathsf{R}_\mathsf{C}}$ ,

$$\varepsilon_{\mathsf{B}} \le \operatorname{Tr} \left[ \rho_{\mathsf{R}_{\mathsf{B}} \mathsf{B}} \wedge (M_{\mathsf{B}} - 1) \rho_{\mathsf{R}_{\mathsf{B}}} \otimes \rho_{\mathsf{B}} \right];$$
 (87)

$$\varepsilon_{\mathsf{C}} \le \operatorname{Tr}\left[\rho_{\mathsf{R}_{\mathsf{C}}} \wedge (M_{\mathsf{C}} - 1)\rho_{\mathsf{R}_{\mathsf{C}}} \otimes \rho_{\mathsf{C}}\right],$$
(88)

where  $\rho_{\mathsf{R}_{\mathsf{B}}\mathsf{R}_{\mathsf{C}}\mathsf{BC}} := \mathcal{N}_{\mathsf{A}\to\mathsf{BC}}\left(\theta_{\mathsf{R}_{\mathsf{B}}\mathsf{R}_{\mathsf{C}}\mathsf{A}}\right)$ .

4.6. Communication with Casual State Information at Encoder. In this section, we consider entanglement-assisted/unassisted classical communication over quantum channels with causal channel state information available at encoder [16, 26, 132], which is the quantum generalization of the classical Gel'fand-Pinsker channel [137], [97, §7].

**Definition 8** (Classical-quantum channel coding with causal state information). Let  $\mathcal{N}_{\mathsf{XS}\to\mathsf{B}}:(x,s)\mapsto \rho_\mathsf{B}^{x,s}$  be a classical-quantum channel parameterized by  $s\in\mathsf{S}$  and a channel state  $p_\mathsf{S}$  is available at encoder.

- 1. A classical register S at Channel, classical registers M, S' (an identical copy of S), and X at Alice, and a quantum register B at Bob.
- 2. An encoding  $(m, s) \mapsto x(m, s)$  which maps an equiprobable message  $m \in M$  given a realization of the channel state  $s \in S'$  to a codeword in X.
- 3. The classical-quantum channel  $\mathcal{N}_{\mathsf{XS}\to\mathsf{B}}$  is applied on Alice's register X given the realization of the channel state  $s \in \mathsf{S}$ , and outputs a state on B at Bob. (The realization  $s \in \mathsf{S}'$  at Alice and  $s \in \mathsf{S}$  at Channel is identical.)
- 4. A decoding measurement described by a measurement  $\{\Pi_{\mathsf{B}}^m\}_{m\in\mathsf{M}}$  on B to extract the sent message  $m\in\mathsf{M}$ . (Note that the receiver is aware of the mathematical description of the probability distribution  $p_{\mathsf{S}}$  but not of the realizations of which  $s\in\mathsf{S}$ .)

An  $(M, \varepsilon)$ -code for  $\mathcal{N}_{\mathsf{XS}\to\mathsf{B}}$  with state information  $p_{\mathsf{S}}$  is a protocol such that  $|\mathsf{M}|=M$  and the average error probability satisfies

$$\frac{1}{M} \sum_{(m,s) \in \mathsf{M} \times \mathsf{S}} p_{\mathsf{S}}(s) \operatorname{Tr} \left[ \rho_{\mathsf{B}}^{x(m,s),s} \left( \mathbb{1}_{\mathsf{B}} - \Pi_{\mathsf{B}}^{m} \right) \right] \le \varepsilon. \tag{89}$$

We adopt the standard random coding strategy as follows.

- **Encoding:** We introduce an auxiliary classical register U for precoding. The message  $m \in M$  is mapped to a pre-codeword  $u \in U$  pairwise-independently according to  $p_U$ . With the realization of the channel state  $s \in S'$ , Alice picks a (deterministic) encoding  $(u(m), s) \mapsto x(u(m), s) \in X$ .
- **Decoding:** At receiver, denoting (with a slight abuse of notation) the channel output state by  $\rho_{\mathsf{B}}^m := \sum_{s \in \mathsf{S}} p_{\mathsf{S}}(s) \rho_{\mathsf{B}}^{x(u(m),s),s}$  for each  $m \in \mathsf{M}$ , Bob performs the pretty-good measurement:

$$\Pi_{\mathsf{B}}^{m} := \frac{\rho_{\mathsf{B}}^{m}}{\sum_{\bar{m} \in \mathsf{M}} \rho_{\mathsf{B}}^{\bar{m}}}, \quad \forall m \in \mathsf{M}.$$

$$(90)$$

Then, following the analysis in Section 3, we obtain an one-shot achievability bound (without duplicating the proof).

**Theorem 15** (A one-shot achievability bound classical-quantum channel coding with casual state information). Consider an arbitrary classical-quantum channel  $\mathcal{N}_{\mathsf{XS}\to\mathsf{B}}:(x,s)\mapsto \rho_{\mathsf{B}}^{x,s}$  with state information  $p_{\mathsf{S}}$ . Then, there exists an  $(M,\varepsilon)$ -code for  $\mathcal{N}_{\mathsf{XS}\to\mathsf{B}}$  with state information  $p_{\mathsf{S}}$  such that for any probability distribution  $p_{\mathsf{U}}$  and (deterministic) map  $(u,s)\mapsto x(u,s)$ ,

$$\varepsilon \le \operatorname{Tr}\left[\rho_{\mathsf{UB}} \wedge (M-1)\rho_{\mathsf{U}} \otimes \rho_{\mathsf{B}}\right].$$
 (91)

Here, 
$$\rho_{\mathsf{UB}} := \sum_{(u,s) \in \mathsf{U} \times \mathsf{S}} p_{\mathsf{U}}(u) |u\rangle \langle u| \otimes p_{\mathsf{S}}(s) \rho_{\mathsf{B}}^{x(u,s),s}.$$

The result extends to classical communication over quantum channels  $\mathcal{N}_{\mathsf{AS}\to\mathsf{B}}$  with quantum state information  $\vartheta_\mathsf{S}$  (see also the definition below in the entanglement-assisted setting). We refer the readers to Table 1 for the corresponding results.

Remark 9. In the precoding phase of Theorem 15, the chosen probability distribution  $p_{\rm U}$  is independent of the channel state  $p_{\rm S}$ . This coding strategy is called casual state information at encoder [97, §7.5] and it was also studied in the quantum setting [132, Theorem 12]. (Hence, Theorem 15 improves on [132, Theorem 12].)

For the scenario of non-casual state information at encoder, the pre-coding probability distribution on U may be correlated with the channel state  $p_{S}$  [26, §4], [16, §V]. This would require additional techniques. We leave it as a future work [136].

Next, we move on to the entanglement-assisted setting.

**Definition 9** (Entanglement-assisted classical communication over quantum channels with causal state information). Let  $\mathcal{N}_{AS\to B}$  be a quantum channel with a channel state  $\vartheta_S$ .

- 1. A classical register M at Alice, and quantum registers A' and S' at Alice, quantum registers R' and B at Bob, and a quantum register S at Channel.
- 2. A resource of arbitrary state  $\theta_{\mathsf{R}'\mathsf{A}'}$  shared between Bob and Alice. Moreover, let  $\vartheta_{\mathsf{S}'\mathsf{S}}$  be a purified state of  $\vartheta_{\mathsf{S}}$  shared between Alice and Channel.
- 3. An encoding  $\mathcal{E}^m_{\mathsf{A}'\mathsf{S}'\to\mathsf{A}}$  performed on registers  $\mathsf{A}'$  and  $\mathsf{S}'$  of  $\theta_{\mathsf{R}'\mathsf{A}'}\otimes \vartheta_{\mathsf{S}'\mathsf{S}}$  by Alice for any equiprobable message  $m\in\mathsf{M}$ .
- 4. The quantum channel  $\mathcal{N}_{\mathsf{AS}\to\mathsf{B}}$  is applied on Alice's register A and the register S of the channel state, and outputs a state on B at Bob.
- 5. A decoding measurement  $\{\Pi_{\mathsf{R'B}}^m\}_{m\in\mathsf{M}}$  is performed on  $\mathsf{R'B}$  to extract the sent message m. (Note that the receiver is aware of the mathematical description of the channel state  $\vartheta_{\mathsf{S}}$  but Bob cannot access to the Channel register  $\S$  nor operate on such a channel state.)

An  $(M, \varepsilon)$ -EA-code for  $\mathcal{N}_{\mathsf{AS}\to\mathsf{B}}$  with state information  $\vartheta_{\mathsf{S}}$  is a protocol such that  $|\mathsf{M}|=M$  and the average error probability satisfies

$$\frac{1}{M} \sum_{m \in M} \operatorname{Tr} \left[ \left( \mathbb{1} - \Pi_{\mathsf{R'B}}^{m} \right) \mathcal{N}_{\mathsf{AS} \to \mathsf{B}} \circ \mathcal{E}_{\mathsf{A'S'} \to \mathsf{A}}^{m} \left( \theta_{\mathsf{R'A'}} \otimes \vartheta_{\mathsf{S'S}} \right) \right] \le \varepsilon. \tag{92}$$

We also use the position-based encoding as in [16, Theorem 5], [132, Theorem 4], and the pretty-good measurement.

- **Preparation:** Consider an arbitrary state  $\theta_{\mathsf{RAS}}$  satisfying  $\theta_{\mathsf{RS}} = \theta_{\mathsf{R}} \otimes \vartheta_{\mathsf{S}}$ . Let  $\theta_{\mathsf{RU}}$  be a purified state of  $\theta_{\mathsf{R}}$  with an additional quantum register U at Alice. Then, Alice and Bob share an M-fold product state  $\theta_{\mathsf{R'A'}} := \theta_{\mathsf{RU}}^M$ .
- Encoding: For each  $m \in M$ , Alice sends the m-th register of U and applies an isometry, i.e.  $\mathcal{E}^m_{\mathsf{U}^M \to \mathsf{A}} = \mathrm{Tr}_{\mathsf{E}} \circ \mathcal{V}_{\mathsf{S}'\mathsf{U} \to \mathsf{EA}} \circ \mathrm{Tr}_{\mathsf{U}^{M\backslash \{m\}}}$ , where  $\mathcal{V}_{\mathsf{S}'\mathsf{U} \to \mathsf{EA}}$  is an isometry transformation such that  $\mathcal{V}_{\mathsf{S}'\mathsf{U} \to \mathsf{EA}} (\theta_{\mathsf{R}\mathsf{U}} \otimes \theta_{\mathsf{S}'\mathsf{S}})$  equals a purified state  $\theta_{\mathsf{ERAS}}$  of  $\theta_{\mathsf{RAS}}$  with an additional purifying register  $\mathsf{E}$ .
- **Decoding:** Denoting (with a slight abuse of notation again) the marginal channel output states at Bob by

$$\rho_{\mathsf{R}^{M}\mathsf{B}}^{m} := \theta_{\mathsf{R}}^{m-1} \otimes \mathcal{N}_{\mathsf{AS} \to \mathsf{B}} \circ \mathrm{Tr}_{\mathsf{E}} \circ \mathcal{V}_{\mathsf{S}'\mathsf{U} \to \mathsf{EA}} \left( \theta_{\mathsf{RU}} \otimes \vartheta_{\mathsf{S}'\mathsf{S}} \right) \otimes \theta_{\mathsf{R}}^{M-m}, \quad m \in \mathsf{M}. \tag{93}$$

Bob performs the corresponding pretty-good measurement:

$$\Pi_{\mathsf{R}^{M}\mathsf{B}}^{m} := \frac{\rho_{\mathsf{R}^{M}\mathsf{B}}^{m}}{\sum_{\bar{m}\in\mathsf{M}} \rho_{\mathsf{R}^{M}\mathsf{B}}^{\bar{m}}}, \quad m \in \mathsf{M}.$$

$$(94)$$

Then, applying the analysis in Section 4.2, we obtain the following result (without duplicating the proof).

**Theorem 16** (A one-shot achievability bound for EA classical communication over quantum channels with casual state information). Consider an arbitrary quantum channel  $\mathcal{N}_{\mathsf{AS}\to\mathsf{B}}$  with state information  $\vartheta_{\mathsf{S}}$ . Then, there exists an  $(M,\varepsilon)$ -EA-code for  $\mathcal{N}_{\mathsf{AS}\to\mathsf{B}}$  with state information  $\vartheta_{\mathsf{S}}$  such that for any  $\theta_{\mathsf{RAS}}$  satisfying  $\theta_{\mathsf{RS}} = \theta_{\mathsf{R}} \otimes \vartheta_{\mathsf{S}}$ ,

$$\varepsilon \le \operatorname{Tr}\left[\rho_{\mathsf{R}\mathsf{B}} \wedge (M-1)\rho_{\mathsf{R}} \otimes \rho_{\mathsf{B}}\right].$$
 (95)

 $\mathit{Here},\ \rho_{\mathsf{RB}} := \mathcal{N}_{\mathsf{AS} \to \mathsf{B}} \, (\theta_{\mathsf{RAS}}).$ 

## 5. Conclusions

We propose a simple analysis of achievability for processing classical information in a quantum system. Our key point is to demonstrate that the pretty-good measurement directly translates the conditional error probability to the error of discriminating a state against the rest of the states. We obtain an elegant closed-form expression of the average error probability for classical communication over quantum channels with standard random coding and basic properties of the noncommutative minimal. The proposed method is tight in the sense that it gives tighter one-shot achievability bounds for channels without further constraints such as symmetry (see Section 3.1), and it unifies the asymptotic derivations in the large, small, and moderate deviation regimes (Table 2). Moreover, the analysis naturally applies to various quantum information-theoretic tasks (see Section 4 and Table 1). This manifests the fact that the proposed method

may be considered as a fundamental achievability approach. Hence we may term it as a *one-shot quantum* packing lemma (Theorem 5). Essentially, the proposed analysis can be applied to and can sharpen almost all existing results that rely on the Hayashi–Nagaoka operator inequality [36, Lemma 2]. We expect more application of the proposed analysis elsewhere. Last but not least, the proposed achievability analysis also applies to the converse analysis for the covering-type problems [17, 18, 25, 136].

We list some open problems along this research directions.

• Standard second-order analysis of the achievable coding rate consists of two steps: (i) reduction from the underlying task to quantum hypothesis testing, and (ii) an asymptotic expansion of the quantum hypothesis-testing divergence [39, 48, 49, 61, 62]. The proposed approach simplifies step (i), and hence now the bottleneck lies in step (ii). Specifically, we conjecture a third-order achievable expansion of the quantum hypothesis-testing divergence in (36). If (36) was true, then Proposition 3 will lead to the best possible third-order coding rate for classical-quantum (c-q) channels without further conditions, i.e.

$$\log M \ge nI(\mathsf{X} : \mathsf{B})_{\rho} + \sqrt{nV(\mathsf{X} : \mathsf{B})_{\rho}} \,\Phi^{-1}(\varepsilon) - O(1). \tag{96}$$

For non-singular c-q channels, it is unknown if the one-shot bound derived in Theorem 1 is sufficient or not. (Or one might resort to a strengthened result given in (21).)

- To the best of our knowledge, a conjecture made by Mosonyi and Audenaert [70, Conjectrue 4.2], and Qi, Wang, and Wilde [68, Conjecture 18] are still open. If they were true, then the established one-shot achievability bound for c-q multiple-access channels (Theorem 11) will imply an upper bound on the error probability by a sum of exponential decays.
- Can the established strengthened one-shot bound in (21) provide a simple proof for the upper bound on the strong converse exponent of c-q channel coding (see [80, Section 5.4], [81, Proposition IV.5], and [82, Proposition VI.2.])?
- In the classical setting (where all the channel output states {ρ<sub>B</sub><sup>x</sup>}<sub>x∈X</sub> mutually commute), the derived bound in Theorem 1 is still weaker than the random-coding union bound proved by Polyanskiy, Poor, and Verdú [46, Theorem 16], i.e. the latter implies Theorem 1 in the commuting case. Nevertheless, we remark that (5) can already yield Gallager's random-coding bound in the commuting case. Hence, there are technical noncommutativity difficulties that remain to be solved.
- It is not clear whether the derived bound in Theorem 1 can lead to Gallager's random-coding exponent [138, 139] for general c-q channels. It is interesting to see if the recent techniques proposed by Dupuis [23] (see also [17]) and Renes [93] can improve the proposed analysis in that regard.

## APPENDIX A. A TRACE INEQUALITY

This section is devoted to proving the trace inequality in Fact (vii):

$$\operatorname{Tr}[A \wedge B] \ge \operatorname{Tr}\left[A\frac{B}{A+B}\right].$$
 (97)

Note that a special case of (97) for Tr[A] = Tr[B] = 1 is a consequence of Barnum and Knill's theorem [59] (see also [60, Theorem 3.10]). Then, the result has been extended to the case of general positive semi-definite A and B in the author's previous work [25, Lemma 3]. For completeness, we provide a strengthened proof in the following Lemma 17 that implies the desired (97) by extending Sason–Verdú [140] and Renes' idea [141].

**Lemma 17** (A trace inequality for noncommutative parallel sum). Let A and B be arbitrary positive semi-definite operators such that (A + B) is invertible. Then, the following holds,

$$\operatorname{Tr}\left[A\frac{B}{A+B}\right] \le \frac{\operatorname{Tr}\left[A \lor B\right] \cdot \operatorname{Tr}\left[A \land B\right]}{\operatorname{Tr}\left[A+B\right]} \tag{98}$$

$$\leq \operatorname{Tr}\left[A \wedge B\right]. \tag{99}$$

Here,  $A \vee B := \frac{A+B+|A-B|}{2}$  and  $A \wedge B := \frac{A+B-|A-B|}{2}$ .

Remark 10. In the scalar case of positive a and b, the inequality  $\frac{ab}{a+b} \leq a \wedge b$  is obvious, and the term  $\frac{ab}{a+b} = (a^{-1} + b^{-1})^{-1}$  is called the parallel sum of a, b. Hence, Lemma 17 may be viewed as a noncommutative generalization of it. We note that an operator parallel sum  $(A^{-1} + B^{-1})^{-1}$  has been studied before (e.g. [142, §3], [143, §5]), and it is related to the Kubo–Ando operator (Harmonic) mean [144, 145]. Further, it can be shown that  $\text{Tr}[(A^{-1} + B^{-1})^{-1}] \leq \text{Tr}[A\frac{B}{A+B}]$ , and hence Lemma 17 also provides an upper bound (in trace) to the operator parallel sum.

*Proof.* We define a collision divergence [19] for  $A, B \ge 0$  as

$$D_2^*(A \parallel B) := \log \operatorname{Tr} \left[ \left( B^{-\frac{1}{4}} A B^{-\frac{1}{4}} \right)^2 \right]. \tag{100}$$

Let  $\{\Pi_A, \Pi_B\}$  be the optimal measurement for distinguishing positive semi-definite A and B, i.e. by recalling the Holevo–Helstrom Theorem [9, 57, 58],

$$\sup_{0 < T < \mathbb{I}} \operatorname{Tr}[AT] + \operatorname{Tr}[B(\mathbb{I} - T)] = \operatorname{Tr}[A\Pi_A] + \operatorname{Tr}[B\Pi_B] = \operatorname{Tr}[A \vee B]. \tag{101}$$

Denote by ' $\oplus$ ' the direct sum operation. We introduce a measure-and-prepare operation  $\Lambda$ , which is a completely positive and trace-preserving (CPTP) map:

$$\Lambda: (\,\cdot\,) \mapsto \operatorname{Tr}\left[(\,\cdot\,)\Pi_A \oplus \Pi_B\right] \oplus \operatorname{Tr}\left[(\,\cdot\,)(\mathbb{1} - \Pi_A \oplus \Pi_B)\right]. \tag{102}$$

We calculate the following:

$$\Lambda(A \oplus B) = \operatorname{Tr}[A \vee B] \oplus \operatorname{Tr}[A \wedge B]; \qquad (103)$$

$$\Lambda\left((A+B)^{\oplus 2}\right) = \operatorname{Tr}\left[A+B\right] \oplus \operatorname{Tr}\left[A+B\right]. \tag{104}$$

Then, since the map  $\exp D_2^*(\cdot \| \cdot)$  is monotonically decreasing under CPTP maps [146–148], we obtain

$$\operatorname{Tr}\left[A\frac{A}{A+B}\right] + \operatorname{Tr}\left[B\frac{B}{A+B}\right] = e^{D_2^*(A \oplus B \parallel (A+B)^{\oplus 2})}$$
(105)

$$\ge e^{D_2^* (\Lambda(A \oplus B) \, \| \, \Lambda((A+B)^{\oplus 2}))} \tag{106}$$

$$= \frac{\left(\operatorname{Tr}\left[A \vee B\right]\right)^{2}}{\operatorname{Tr}\left[A + B\right]} + \frac{\left(\operatorname{Tr}\left[A \wedge B\right]\right)^{2}}{\operatorname{Tr}\left[A + B\right]}.$$
(107)

Noting that  $A + B = A \vee B + A \wedge B$  and  $A \vee B \leq A + B$ , the above inequality translates to the desired inequalities in this lemma.
