On parametric resonance in the laser action

Abstract

We consider the selfconsistent semiclassical Maxwell–Schrödinger system for the solid state laser. The system consists of the Maxwell equations coupled to $N \sim 10^{20}$ Schrödinger equations for active molecules. The system includes time-periodic pumping and a weak dissipation. We introduce the corresponding Poincaré map \mathscr{P} and consider the differential $D\mathscr{P}(Y^0)$ at suitable ground state Y^0 .

We conjecture that the *stable laser action* is due to the *parametric resonance* (PR) which means that the maximal absolute value of the corresponding multipliers is sufficiently large. The multipliers are defined as eigenvalues of $D\mathscr{P}(Y^0)$. The PR makes the stationary state Y^0 highly unstable, and we suppose that this instability maintains the *coherent laser radiation*. We prove that the spectrum Spec $D\mathscr{P}(Y^0)$ is approximately symmetric with respect to the unit circle $|\mu| = 1$ if the dissipation is sufficiently small.

More detailed results are obtained for the Maxwell–Bloch system which is a finite-dimensional approximation of the Maxwell–Schrödinger system. The approximation consists of one-mode Maxwell field coupled to *N* two-level molecules. We calculate the corresponding Poincaré map *P* by successive approximations. The key role in calculation of the multipliers is played by the sum of *N* positive terms arising in the second-order approximation for the total current. This fact can be interpreted as the *synchronization of molecular currents* in all active molecules, which is provisionally in line with the role of *stimulated emission* in the laser action. The calculation of the sum relies on probabilistic arguments. The differential *DP* is calculated of in the "Hopf representation" which corresponds to the factorization of the dynamics by the action of the symmetry gauge group. The differential admits the block structure which allows us to reduce the eigenvalue problem to the polynomial of degree six.

1 Introduction

The article addresses the problems of laser and maser radiation. In the existing approaches, time-periodic pumping is not included in the dynamical equations, so the corresponding resonance features are absent. This fact was one of our main motivations.

We consider the selfconsistent semiclassical Maxwell–Schrödinger system for the solid state laser. The system consists of the Maxwell equations coupled to $N \sim 10^{20}$ Schrödinger equations for active molecules with one active electron. The system includes time-periodic pumping and a weak dissipation. We introduce the corresponding Poincaré map \mathcal{P} and consider its differential $D\mathcal{P}(Y^0)$ at suitable ground state Y^0 . Let μ denote the multipliers which are eigenvalues of the differential $D\mathcal{P}(Y^0)$. We conjecture that the laser action is due to the parametric resonance, when

$$\max_{\mu \in \operatorname{Spec} D\mathscr{P}(Y^0)} |\mu| > \rho \tag{1.1}$$

with sufficiently large $\rho > 1$. For solutions to the linearized dynamical equation with the spectrum satisfying (1.1), the components with $|\mu| \le 1$ are bounded, while the ones with $|\mu| > 1$ grow exponentially for large times. As a result, *almost all* solutions grow exponentially. This is why we expect that under the condition (1.1), similar growth takes place in the case of sufficiently small nonlinear coupling (the growth only occurs for limited time because of nonlinear effects and dissipation). Thus, our point of view is in line with the conventional interpretation of the laser action as the appearance of exponentially growing solutions of the corresponding linearized dynamics, see ([27, (6.5.12) and (6.6.23)]).

Remark 1.1. i) We suggest that the overwhelming predominance of a single mode, corresponding to the maximal value of $|\mu|$, can be responsible for the *coherent monochromatic* laser radiation.

ii) We suppose that the parametric resonance is also relevant to the gas- and free-electron lasers. However, at the moment, a mathematical formulation of the corresponding dynamics is problematic.

The main goal of the present article is an analysis of properties of the multipliers and development of methods for their calculation. Our main results are as follows.

I. We develop the Hamiltonian formalism for the ideal case of the Maxwell–Schrödinger system without dissipation. Using this formalism and the Lyapunov–Poincaré theorem [42, (3.28)], we establish the approximate symmetry of the spectrum Spec $D\mathscr{P}(Y^0)$ with respect to the unit circle $|\mu| = 1$ when the dissipation is sufficiently small (Lemma 4.1 and (4.6)).

More detailed results (II and III below) are obtained for the Maxwell–Bloch system which is a finitedimensional approximation of the Maxwell–Schrödinger system. The approximation consists of one-mode Maxwell field coupled to N two-level molecules. The system is time-periodic in the case of periodic pumping.

II. We calculate the corresponding Poincaré map P by successive approximations. The key role in calculation of the multipliers is played by the sum of N positive terms (16.2) arising in the second-order approximation for the total current. This fact can be interpreted as the *synchronization of molecular currents* in all active molecules, which is provisionally in line with the role of *stimulated emission* in the laser action.

III. We calculate suitable approximation for the matrix $DP(Y^0)$ corresponding to material parameters of the ruby laser. The calculation relies on the Hopf representation of the dynamics. The main peculiarity of the corresponding eigenvalue problem is that $DP(Y^0)$ is a matrix of size $\sim N \times N$ which depends on a random distribution of active molecules in the resonance cavity. Using the block structure of this matrix and probabilistic arguments, we reduce the eigenvalue problem to polynomial equation of degree six.

Our main novelties are as follows: i) the approximate symmetry of the spectrum in the nonlinear context, ii) the calculation of the differential $DP(Y^0)$ in the Hopf representation, iii) the block structure of the differential (20.8), iv) calculation of the sum (16.5) and the reduction to polynomial equation of degree six relying on Shnirelman's Quantum Ergodic Theorem [33, 37, 38] and probabilistic arguments (21.10)–(21.16), and v) the justification of the "rotating wave approximation" by a new estimate for averaging of slow rotations (Lemma A.1).

Remark 1.2. i) The conjecture on appropriate kind of synchronisation in the laser action has been put forward repeatedly, see, e.g., [29]. However, a dynamical formulation of the synchronization in the context of the laser action is still missing. In the present article, for the first time we will concretise this formulation in the framework of the nonlinear damped Maxwell-Schrödinger equations with time-periodic pumping.

ii) The condition (1.1) alone is not sufficient for the stable laser/maser action: to be sure that the energy of the Maxwell field increases indeed, we check that the projections of the corresponding eigenvectors onto the Maxwell field do not vanish, see (13.8) and Remark 21.3.

Let us comment on previous theories of laser radiation. The today laser/maser theory exists on the following three levels.

Rate equations. This approach is based on balance equations for the numbers of emitted and absorbed photons [1, 14, 27, 32, 40]. This theory comes back to famous Einstein's article [11] developing the theory of *stimulated* and *spontaneous emission and absorption*.

Semiclassical theory. This theory is based on finite-dimensional approximations of the Schrödinger equations for each active molecule coupled to the classical Maxwell equations [1, 3, 14, 27, 32, 35, 40]. This semiclassical approach uses method of slowly varying amplitudes [27, Sections 6.2 and 6.3]. The formation of the coherent monochromatic radiation is explained by an instability in the equation for amplitude of the Maxwell mode under various hypothesis on the density of population of active molecules [27, Sections 6.5 and 6.6]. The criterion of the instability is formulated in terms of presence of an unstable (nonnegative) root of the corresponding characteristic equation ([27, (6.5.12) and (6.6.23)]).

Quantum theory. This approach is based on quantized Maxwell equations in the Dicke–Haken–Lax model [9, 14, 27, 32, 40] and [15]–[19]. The theory resulted in successful explanation of many laser phenomena: superradiance, photon echoes, self-induced transparency and others [12, 14, 27, 32, 35, 40]. The results by K. Hepp and E. Lieb [19] establish the phase transitions which occur in the thermodynamical limit as $N \rightarrow \infty$ if the coupling constant is sufficiently large.

Remark 1.3. i) The time-periodic pumping with a resonant frequency plays the crucial role sustaining the population inversion. At the same time, the existing theories [1, 14, 26, 27, 32, 35, 40] simulate the maintenance of the inversion by *phenomenological constant terms* in dynamical equations; see [27, (6.4.11), (6.4.12)] for semiclassical model and the beginning of Section 7.3 in [27] for quantum model. So, the resonance features are not considered. This fact was our main motivation for the parametric resonance.

ii) The existing theories do not take into account different phases of the Maxwell field at different points of the

cavity (in particular, spatial variation of the Maxwell mode is neglected in the quantum case [27, (7.1.2)]). The *synchronization of molecular currents* established in present artcile, means that contribution of a molecule to the amplification of the Maxwell field does not depend on the phase of the Maxwell field at the location of the molecule, see Remark 16.1.

Remark 1.4. As far as I know, laser dynamics with time-periodic pumping and the corresponding parametric resonance were not considered previously.

In concluzion, the case of quantum Maxwell field will be considered elsewhere.

2 Laser equations

We use the Heaviside–Lorentz units (*unrationalized Gaussian units*), in which the main physical constants (electron charge and mass, Planck's constant, and the speed of light in vacuum) read [41, p. 221]

$$e = -4.8 \times 10^{-10} \text{esu}, \quad m = 9.1 \times 10^{-28} \text{g}, \quad \hbar = 1.055 \times 10^{-27} \text{erg} \cdot \text{s}, \qquad c = 3.0 \times 10^{10} \text{cm/s}.$$
 (2.1)

Laser cavity and medium. We consider solid state lasers. The laser resonator is a (usually cylindrical) cavity $V \subset \mathbb{R}^3$ with metallic walls (ideal conductor) connected with the output waveguide. Typical industrial laser consists of two cylindrical lamps of identical size with glass walls placed at the foci of a metallic cavity V with an elliptic cross-section. The *active lamp* V_a is filled with a dielectric medium doped with identical active molecules. The other *pumping lamp* is the discharge light source which produces the pumping field. In particular, for the typical cylindrical lamp of length 12 *cm* and diameter 0.6 *cm* we have

$$|V_a| = \frac{12\pi 0.36}{4} \approx 3.4 \, cm^3. \tag{2.2}$$

The dielectric medium of the active region V_a has an electrical conductivity σ . For example, the ruby laser is filled with corundum of electrical conductivity

$$\sigma = 10^{-14} Om^{-1} \cdot cm^{-1} = 10^{-2} s^{-1}.$$
(2.3)

The active molecules are located at the points $x_n \in V_a$ with numbers $n = 1, ..., N \sim 10^{20}$. We suppose that in each active molecule only one electron is involved in this interaction, and it is subject to an effective static molecular potential

$$\Phi_n(x) = \Phi(R_n(x - x_n)), \qquad R_n \in SO(3).$$
(2.4)

Here Φ is the potential of the ion (or nucleus) with the total charge |e| > 0. Further we consider two different hypothesis on the distribution of x_n and R_n with $n \in \overline{N} := \{1, ..., N\}$.

H1. Polycrystalline medium (or "glass medium" [39]). The values $x_n \in V$ and $R_n \in SO(3)$ are "almost uniformly distributed" and "almost independent".

H2. Crystalline medium. Rotations R_n do not depend on $n \in \overline{N}$.

Maxwell–Schrödinger equations. Each active molecule is described by the corresponding wave function $\psi_n(x,t)$, and in Heaviside–Lorentz units, the corresponding Maxwell–Schrödinger system reads (see [4, 5, 7, 13, 21, 22, 23, 24, 28, 31, 36] for the equations without dissipation)

$$\begin{cases} \frac{1}{c^2}\ddot{\mathbf{A}}(x,t) = \Delta \mathbf{A}(x,t) - \frac{\sigma}{c^2}\dot{\mathbf{A}}(x,t) + \frac{1}{c}P_s\mathbf{j}(\cdot,t), \ x \in V\\ i\hbar\psi_n(t) = H_n(t)\psi_n(t), \ n \in \overline{N} \end{cases}$$
(2.5)

where $\sigma > 0$ is electrical conductivity of the cavity medium. We assume the Coulomb gauge [20]

$$\operatorname{div} \mathbf{A}(x,t) \equiv 0, \tag{2.6}$$

and we denote by P_s the orthogonal projection onto divergent-free vector fields in the Hilbert space $L^2(V) \otimes \mathbb{R}^3$. Further, the Schrödinger operators read

$$H_n(t) := \frac{1}{2m} D^2(t) + e \Phi_n(x), \qquad D(t) = -i\hbar \nabla - \frac{e}{c} [\mathbf{A}(x,t) + \mathbf{A}_p(x,t)].$$
(2.7)

Here $\mathbf{A}_p(x,t)$ is an external pumping potential, also in the Coulomb gauge and time-periodic:

div
$$\mathbf{A}_{p}(x,t) \equiv 0;$$
 $\mathbf{A}_{p}(x,t+T) = \mathbf{A}_{p}(x,t), t > 0,$ (2.8)

where T > 0. The current density is defined by

$$\mathbf{j}(x,t) = \frac{e}{m} \sum_{n} \operatorname{Re}\left[\overline{\psi}_{n}(x,t)D(t)\psi_{n}(x,t)\right].$$
(2.9)

This formula neglects overlapping of the supports of the wave functions since the distance between active molecules is sufficiently large: it is of order 10 molecular diameters when the density of active molecules is of order 10^{20} .

Note that the pumping field is a solution to the Maxwell equations in the cavity V excited by the discharge currents in the pumping lamp.

Boundary conditions. We choose the boundary conditions modelling ideally conducting diamagnetic materials (like cooper, silver, gold, etc). More precisely, we assume that

$$\mathbf{n}(x) \times \dot{\mathbf{A}}(x,t) = 0, \quad \mathbf{n}(x) \cdot \operatorname{rot} \mathbf{A}(x,t) = 0; \quad \psi_n(x,t) = 0, \quad n \in \overline{N}; \qquad x \in \Gamma,$$
(2.10)

where $\mathbf{n}(x)$ is the outward normal to Γ at a point $x \in \Gamma$.

Remark 2.1. i) The boundary conditions (2.10) must to be valid for the total Maxwell field $\mathbf{A}(x,t) + \mathbf{A}_p(x,t)$. We require the same boundary conditions for $\mathbf{A}(x,t)$ to separate the *own field* $\mathbf{A}(x,t)$ from the pumping field $\mathbf{A}_p(x,t)$. In this case the pumping field $\mathbf{A}_p(x,t)$ satisfies the same boundary conditions as $\mathbf{A}(x,t)$.

ii) Under the Dirichlet boundary conditions for the wave functions, the total charge of each active molecule is constant, i.e.,

$$\int_{V} |\Psi_n(x,t)| dx = 1, \qquad t > 0; \qquad n \in \overline{N}.$$
(2.11)

Hamiltonian structure. In the *ideal case*, when $\sigma = 0$, the system (2.5), under the boundary conditions (2.10), is formally Hamiltonian, with the Hamiltonian functional (which is the energy up to a factor)

$$\mathscr{H}(\mathbf{A}, \mathbf{\Pi}, \boldsymbol{\psi}, t) = \frac{1}{2} [\|\frac{1}{c} \mathbf{\Pi}\|^2 + \|\operatorname{rot} \mathbf{A}\|^2] + \frac{1}{2} \sum_n \langle \boldsymbol{\psi}_n, H_n(\mathbf{A}, t) \boldsymbol{\psi}_n \rangle,$$
(2.12)

where $\psi := (\psi_1, \dots, \psi_N)$, $\|\cdot\|$ stands for the norm in the real Hilbert space $L^2(\mathbb{R}^3) \otimes \mathbb{R}^3$, and the brackets $\langle \cdot, \cdot \rangle$ stand for the inner product in $L^2(\mathbb{R}^3) \otimes \mathbb{C}$. The Schrödinger operators are defined by (2.7):

$$H_n(\mathbf{A},t) := \frac{1}{2m} [-i\hbar \nabla - \frac{e}{c} (\mathbf{A}(x) + \mathbf{A}_p(x,t))]^2 + e\Phi_n(x).$$
(2.13)

The system (2.5) with $\sigma \ge 0$ can be written in the Hamiltonian form with variational derivatives,

$$\begin{cases} \frac{1}{c^2}\dot{\mathbf{A}}(t) = D_{\mathbf{\Pi}}\mathscr{H}(\mathbf{A}(t),\mathbf{\Pi}(t),\boldsymbol{\psi}(t),t), \quad \frac{1}{c^2}\dot{\mathbf{\Pi}}(t) = -D_{\mathbf{A}}\mathscr{H}(\mathbf{A}(t),\mathbf{\Pi}(t),\boldsymbol{\psi}(t),t) - \frac{\sigma}{c^2}\dot{\mathbf{A}}(x,t) \\ i\hbar\psi_n(t) = D_{\psi_n}\mathscr{H}(\mathbf{A}(t),\mathbf{\Pi}(t),\boldsymbol{\psi}(t),t) = H_n(\mathbf{A}(t),\boldsymbol{\psi}(t),t)\psi_n(t), \end{cases}$$
(2.14)

Symmetry group. For any $\theta_n \in \mathbb{R}$, the functions $\mathbf{A}(x,t)$, $e^{i\theta_n}\psi_n(x,t)$ are solutions of the system (2.5) if $\mathbf{A}(x,t)$, $\psi_n(x,t)$ is a solution. In other words, the dynamics (2.5) under the boundary conditions (2.10) commutes with the action of the *symmetry group* $G := [U(1)]^N$ with the action

$$(e^{i\theta_1},\ldots,e^{i\theta_N})(\mathbf{A},\boldsymbol{\psi}_1,\ldots,\boldsymbol{\psi}_N) = (\mathbf{A},e^{i\theta_1}\boldsymbol{\psi}_1,\ldots,e^{i\theta_N}\boldsymbol{\psi}_N).$$
(2.15)

3 Parametric resonance

Let $L^2 = L^2(V)$ denote the Hilbert space of real-valued functions. The system (2.14) can be written as the dynamical equation on the Hilbert phase space $\mathbb{Y} = [L^2 \otimes \mathbb{R}^3]^2 \oplus [L^2]^{2N}$:

$$\dot{Y}(t) = \mathscr{F}(Y(t), t), \qquad Y(t) := (\mathbf{A}(t), \mathbf{\Pi}(t), \boldsymbol{\psi}(t)).$$
(3.1)

This system is T-periodic by (2.8), i.e.,

$$\mathscr{F}(Y,t+T) \equiv \mathscr{F}(Y,t). \tag{3.2}$$

The corresponding Poincaré map is defined by

$$\mathscr{P}: Y(0) \mapsto Y(T). \tag{3.3}$$

Let $Y^0(t)$ be a "stationary state" of the system (3.1) with the zero pumping $A_p(x,t) = 0$, i.e., a solution of type

$$Y^{0}(t) = (0, 0, (e^{-i\omega_{n}t}\psi_{n}(x) : n \in \overline{N})),$$
(3.4)

where $\omega_n \in \mathbb{R}$. The solutions correspond to the absence of the Maxwell field and to stationary states of all active molecules. The following definition is relevant for the system (3.1) with sufficiently small pumping.

Definition 3.1. The parametric resonance occurs for $Y^0 := Y^0(0)$ when the condition (1.1) holds with a sufficiently large $\rho > 1$.

Remark 3.2. The parametric resonance means an exponential divergence of trajectories close to Y^0 .

4 Symmetry of spectrum

In the *ideal case*, when $\sigma = 0$, the dissipation is absent, and the system (3.1) is Hamiltonian by (2.14), so it can be written as

$$\dot{Y}(t) = JD_Y \mathscr{H}(Y(t)), t), \tag{4.1}$$

where J is a skewadjoint operator, and J^2 is proportional to the identity operator.

Lemma 4.1. (Lyapunov–Poincaré theorem) In the case $\sigma = 0$, the symmetry holds

$$\operatorname{Spec} D\mathscr{P}(Y^0) = R[\operatorname{Spec} D\mathscr{P}(Y^0)], \qquad (4.2)$$

where $R\mu = \overline{\mu}^{-1}$ is the inversion, which is the reflection in the unit circle $|\mu| = 1$.

Proof. The differential $D\mathscr{P}(Y^0)$ admits the representation

$$D\mathscr{P}(Y^0)\mathbf{Y}(0) = \mathbf{Y}(T), \tag{4.3}$$

where $\mathbf{Y}(t)$ is the solution to the linearized equation

$$\dot{\mathbf{Y}}(t) = K(t)\mathbf{Y}(t), \qquad K(t) = D_Y \mathscr{F}(Y^0(t), t).$$
(4.4)

However, (4.1) implies that

$$\mathscr{F}(Y,t) = JD_Y \mathscr{H}(Y,t),$$

and therefore,

$$K(t) = JD_Y^2 \mathscr{H}(Y^0(t), t) = J\mathscr{A}(t),$$
(4.5)

where $\mathscr{A}(t)$ is the selfadjoint operator. Denote the map $U(t) : \mathbf{Y}(0) \to \mathbf{Y}(t)$, so $D\mathscr{P}(Y^0) = U(2\pi)$ by (4.3). Finally, the Lyapunov–Poincaré theorem [42, (3.28)] implies that $\operatorname{Spec} U^* = \operatorname{Spec} U^{-1}$, where $U = U(2\pi)$. Hence, the symmetry (4.2) is proved.

Remark 4.2. The symmetry (4.2) can be considered as a nonlinear version of the Lyapunov–Poincaré theorem, which plays the key role in M.G. Krein's theory of parametric resonance [8, 42]. The ground for this extension is the Hamiltonian structure of the dynamics (4.1).

Thus, in the ideal case, the set of multipliers is symmetric with respect to the unit circle. In general case, when the dissipation is included, the symmetry (4.2) is broken, though it holds approximately for sufficiently small $\sigma > 0$:

$$\operatorname{Spec} D\mathscr{P}(Y^0) \approx R[\operatorname{Spec} D\mathscr{P}(Y^0)].$$
(4.6)

Recall the proof of the Lyapunov–Poincaré theorem [42, (3.28)]. We have $\dot{U}(t) = J\mathscr{A}(t)U(t)$. Hence, differentiating $W(t) := U^*(t)JU(t)$, we obtain

$$\dot{W} = \dot{U}^* J U + U^* J \dot{U} = U^* \mathscr{A} (-J^2) U + U^* J^2 \mathscr{A} U = 0$$
(4.7)

since J^2 commutes with \mathscr{A} . Therefore, $U^*(t)JU(t) = J$, and hence $U^*(t) = JU^{-1}(t)J^{-1}$. This similarity implies that the spectra of $U^*(t)$ and $U^{-1}(t)$ coincide.

We consider the Maxwell–Schrödinger system (2.5) with the pumping $A_p(x,t)$, which is monochromatic, i.e.,

$$\mathbf{A}_{p}(x,t) = \mathbf{a}_{p}(x)\sin\Omega_{p}t,\tag{5.1}$$

where Ω_p is the pumping frequency. For example, for the ruby laser the resonant pumping wavelength and frequency are

$$\lambda = 694.3nm = 694.3 \times 10^{-9}m \approx 7 \times 10^{-5} \, cm, \qquad \Omega_p = \frac{2\pi c}{\lambda} = \frac{19 \times 10^{10}}{7 \times 10^{-5}} \approx 3 \times 10^{15} \, s^{-1}. \tag{5.2}$$

H3. The dipole radiation condition. We will assume that

$$\lambda \gg D,\tag{5.3}$$

where D is the diameter of active molecules.

Example 5.1. This condition holds for the ruby laser since the wavelength $\lambda \approx 7 \times 10^{-5} cm$ while the size of the chromium molecule is

$$D \approx 2.5 \, pm = 2.5 \times 10^{-10} \, cm. \tag{5.4}$$

8 **Resonance condition**

The resonance condition means that

The perturbation theory allows us to calculate solutions to the coupled system (2.5) with initial states close to (8.3). We expect that these solutions are rapidly growing due to the resonance condition (8.1) and the parametric resonance (1.1).

9 The magnitude of pumping

The pumping field (5.1) in a neighborhood of any active molecule is approximately a plane wave

The side surface S of the cavity is about $12\pi 0.6 cm^2 \approx 23 cm^2$. The intensity I of the plane wave (9.1) is $\frac{ck^2 |\mathbf{a}_p|^2}{2} \frac{erg/s}{cm^2}$, so

Substituting $|k| = |\Omega_p|/c$, we find

10 The Maxwell–Bloch equations

$$= \frac{e}{\hbar c} [\dot{a}_{1}(t)\mathbf{X}(\boldsymbol{x}_{n}) + \mathbf{a}_{p}(\boldsymbol{x}_{n})\Omega_{p}\cos\Omega_{p}t] \mathbf{P}_{n}^{ll'}$$

$$= \frac{\mathbf{P}_{n}^{ll'}}{\hbar c} [\dot{a}_{1}(t)\mathbf{X}(\boldsymbol{x}_{n}) + \mathbf{a}_{p}(\boldsymbol{x}_{n})\Omega_{p}\cos\Omega_{p}t], \qquad l, l' = 1, 2, \qquad (11.1)$$

These momenta are real vectors since we have chosen real eigenfunctions $\varphi_{n,l}(x)$.

Remark 11.1. In the case of the ruby laser, the matrix of type (11.2) corresponds to the dipole momenta of chromium ions Cr^{3+} . For definiteness of calculations, we accept

Remark 12.1. By our hypothesa H1–H4, the parameters α_n , β_n , γ_n and $\alpha_{n'}$, $\beta_{n'}$, $\gamma_{n'}$ are almost independent for sufficiently large distances $|x_{n'} - x_n|$.

All coefficients α_n , β_n and γ_n are small. In particular, for the ruby laser with the chromium dipole moment (11.3), and the pumping frequency (5.2), we have

Now (7.8) and (9.6) imply that

In all calculations below we will consider these values.

13 Parametric resonance for the Maxwell–Bloch equations

Let us reformulate the concept of parametric resonance (1.1) for the system (12.9). In the case of zero pumping $\mathbf{a}_p = 0$, this system admits "ground states", which are solutions corresponding to (8.2):

The system (13.3) can be written as

$$\dot{X}(\tau) = F(X(\tau), \tau), \qquad X(\tau) := (a(\tau), b(\tau), (c_n(\tau) : n \in \overline{N})).$$
(13.5)

This system (13.5) is 2π -periodic, i.e.,

$$F(X,\tau+2\pi) \equiv F(X,\tau). \tag{13.6}$$

The corresponding Poincaré map is defined by

$$P: X(0) \mapsto X(2\pi). \tag{13.7}$$

The following definition is relevant for the system (13.5) in the case of sufficiently small pumping.

Definition 13.1. The parametric resonance occurs for the ground state (13.1) when the condition (1.1) (with $DP(X^0)$ instead of $D\mathcal{P}(Y^0)$) holds with a sufficiently large $\rho > 0$.

We also need to check the additional condition for all the corresponding eigenvectors $\mathbf{X} := (\mathbf{a}, \mathbf{b}, (\mathbf{c}_n : n \in \overline{N}))$:

$$(\mathbf{a}, \mathbf{b}) \neq \mathbf{0},\tag{13.8}$$

which guarantees an exponential increment of the Maxwell field. We have verified this condition in the case of ruby laser; see Remark 21.3.

Symmetry group. Let us denote by $G = [U(1)]^N$ the symmetry gauge group of the system (13.3). The group acts on the phase space $\mathbb{X} = \mathbb{R}^2 \oplus [\mathbb{C}^2]^N$ by the formula

This action commutes with the dynamics (13.3), hence the differentials $DP(X^0)$ are similar for ground states (13.1) with arbitrary θ_n . So, it suffices to check the condition (1.1) only for the ground state with all $\theta_n = 0$:

14 Successive approximations

We will construct the Poincaré map (13.7) calculating successive approximations for the equations (13.3) on the interval $[0, 2\pi]$ with initial data

which are close to the stationary state (13.10), i.e.,

where $\varepsilon > 0$ is sufficiently small. As the *zero-order approximation*, we choose the stationary solution (13.10):

since we plan to study instability of solutions which are close to these stationary solutions. The higher-order approximations are defined as follows.

The Schrödinger amplitudes. We define the approximations $c_n^{(k)}$ with k = 1, ... as solutions of equations

To solve the Schrödinger equations (14.4), we will replace them by the corresponding averaged equations

The matrix functions $\Omega_n^{(k-1)}(\tau)$ are sufficiently small by (12.13), so the replacement is justified by Lemma A.1. All the matrices (14.6) and (14.8) are skewsymmetric, and hence,

Hence, the matrix in the formula (14.9) with n = 1 reads

$$U_n^{(1)}(\tau) = \begin{pmatrix} \cos\frac{\gamma_n\tau}{2} & -i\sin\frac{\gamma_n\tau}{2} \\ -i\sin\frac{\gamma_n\tau}{2} & \cos\frac{\gamma_n\tau}{2} \end{pmatrix} + O(\gamma_n^2)$$

by Lemma A.1.

The current. Substituting (14.20) and (14.21) in the second formula of (14.10) with k = 1, we obtain

$$= \sum_{n} \alpha_{n} \operatorname{Im} \left\{ [\overline{d}_{n,1}^{(1)} \cos \frac{\gamma_{n} \tau}{2} + \overline{d}_{n,2}^{(1)} \sin \frac{\gamma_{n} \tau}{2}] [-id_{n,1}^{(1)} \sin \frac{\gamma_{n} \tau}{2} + id_{n,2}^{(1)} \cos \frac{\gamma_{n} \tau}{2}] e^{-i\tau} \right\}$$

$$= \sum_{n} \alpha_{n} \operatorname{Im} \left\{ [i\overline{d}_{n,1}^{(1)} d_{n,2}^{(1)} - i|d_{n,1}^{(1)}|^{2} \sin \frac{\gamma_{n} \tau}{2} + i|d_{n,2}^{(1)}|^{2} \sin \frac{\gamma_{n} \tau}{2}] e^{-i\tau} \right\} + O(\sum_{n} \alpha_{n} \gamma_{n}^{2})$$

$$= \sum_{n} \alpha_{n} \operatorname{Re} \left\{ [\overline{d}_{n,1}^{(1)} d_{n,2}^{(1)} - |d_{n,1}^{(1)}|^{2} \sin \frac{\gamma_{n} \tau}{2} + |d_{n,2}^{(1)}|^{2} \sin \frac{\gamma_{n} \tau}{2}] e^{-i\tau} \right\} + O(\sum_{n} \alpha_{n} \gamma_{n}^{2})$$

$$= \sum_{n} \alpha_{n} \left[\operatorname{Im} \left\{ \overline{c}_{n,1}(0) c_{n,2}(0) e^{-i\tau} \right\} + [|c_{n,2}(0)|^{2} - |c_{n,1}(0)|^{2}] \frac{\gamma_{n} \tau}{2} \cos \tau \right] + O(10^{-17}), \tau \in [0, 2\pi], (14.23)$$

since $\sum_{n} \alpha_{n} \gamma_{n}^{2} \sim 10^{-17}$ by (12.13).

Notation. For each number $\varepsilon > 0$, the equality $r = O(\varepsilon)$ means that $|r| \le 10\varepsilon$. The Maxwell amplitude. Now (14.12) with k = 1 becomes

The current. Expanding (14.37) into the Taylor series, we obtain

Here the error $O(|\tilde{\omega}_n^{(1)}|^2) \sim 10^{-14}$ uniformly in $\tau \in [0, 2\pi]$. Indeed, $\tilde{\omega}_n^{(1)} = \beta_n \nu + \frac{\gamma_n}{2}$, where ν is expressed by (14.27) and (14.30)–(14.32):

Remark 15.1. i) The Poincaré map P is given by formulas (15.6) and (14.39).

ii) The second-order approximations (15.6) are obtained solving the equation (14.10) with k = 2, initial data (14.1), and the current (15.4). At the "ground state" (13.10), the current (15.4) takes the form

16 Synchronisation of molecular currents

The key peculiarity of the perturbative calculations is the appearance of the summation

$$\mathbf{S} = \sum_{n} \alpha_{n} \beta_{n} \tag{16.1}$$

in the second-order approximation of the total molecular current (15.7). This appearance is due to the Taylor approximation (14.39). Also note that the same summation reappears in (21.5) and (21.8).

Remark 16.1. The parameters (12.13) demonstrate that all terms in the summations (15.6) and (15.7) are very small. It is of crucial importance that all terms of the sum **S** *are nonnegative* since

$$\alpha_n \beta_n = \frac{2c}{\Omega_p} \mathbf{P}_n \mathbf{X}(x_n) \frac{\mathbf{P}_n \mathbf{X}(x_n)}{\hbar c} \ge 0, \tag{16.2}$$

and the sum is a non-negligible positive number, see (16.5) and (16.7) below. This means the synchronisation of all molecular currents in the total current (15.7) *independently* of the phase of the Maxwell field at the location of the molecules.

We must to know *the value of the summation* S for the calculation of the Poincaré map, although the summands are random values. We will calculate the summation S in both cases of polycrystalline- and monocrystalline medium.

I. Polycrystalline medium. By our assumption H1, $|\mathbf{P}_n| = |\mathbf{P}|$ does not depend on *n*, so

By Remark 12.1, we can apply the *law of large numbers* (recall that $N \sim 10^{20}$), and obtain that $\mathbf{S} \approx \overline{N} \mathbb{E} \alpha_n \beta_n$. Moreover, \mathbf{P}_n and $\mathbf{X}(x_n)$ are independent. Hence, using (5.3), we obtain that

$$= \frac{2}{\Omega_p \hbar} \frac{|\mathbf{P}|^2}{3} \sum_n \mathbf{X}^2(x_n) \approx \frac{2|\mathbf{P}|^2}{3\Omega_p \hbar} \frac{N}{|V_a|} \int_{V_a} \mathbf{X}^2(x) dx = \frac{2|\mathbf{P}|^2}{3\Omega_p \hbar} d\frac{|V_a|}{|V|}, \quad d := \frac{N}{|V_a|}$$
(16.5)

by the normalization of **X**. Here the value $|V_a|/|V|$ for the integral follows from Shnirelman's *Quantum Ergodic theorem* [33, 37, 38]. Note that this value obviously holds for the eigenmodes (7.6) with sufficiently large eigenvalues. For the case of ruby laser (12.13), we obtain $d \approx 3 \times 10^{19}$ and

which is much larger than the terns in the summations (15.6) and (15.7). Moreover, **S** is a Gaussian random value since $\alpha_n \beta_n$ are independent and identically distributed.

II. Crystalline medium. In this case the polarizations $\mathbf{P}_n = \mathbf{P}$ do not depend on *n*. We assume additionally that the mode $\mathbf{X}(x)$ is linearly polarised. Now (16.5) changes to

where φ is the angle between **P** and **X**(*x*).

17 Factordynamics and the Hopf fibration

The action (13.9) commutes with the dynamics (13.3), hence the latter induces the corresponding dynamics on the factorspace $\mathbb{X}_* = \mathbb{X}/G$. This factorspace is the base of the fibration $\mathbb{X} \to \mathbb{X}/G$. Also the Poincaré map *P* commutes with the action (13.9). Moreover, this action does not change the Maxwell field. Accordingly, the instability and the parametric resonance (1.1) must be checked for the induced factordynamics only. More accurate justification is given in the next section: we reduce the problem to calculation of the differential $DP_*(X^0_*)$, where P_* denotes the action of *P* on the factorspace \mathbb{X}/G , and the point X^0_* corresponds to X^0 in this factorization (see (13.10)). We show that the eigenvalues of $DP(X^0)$ and $DP_*(X^0_*)$ coincide up to $\mu = 1$, corresponding to the action (13.9).

To calculate $DP_*(X^0_*)$, we need suitable local coordinates on the factorspace. The charge conservation (12.11) means that

$$c_n(\tau) = \begin{pmatrix} c_{n,1}(\tau) \\ c_{n,2}(\tau) \end{pmatrix} \in S^3, \tag{17.1}$$

where S^3 is the unit sphere in \mathbb{C}^2 . The sphere is the Hopf fibration with fibers

and the base diffeomorphic to the unit sphere S^2 . We choose the following invariant coordinate on the base:

In particular, the *population inversion* $|c_2|^2 - |c_1|^2$ is the smooth function on the disk $D := |z| < \frac{1}{2}$, and

The coordinate z maps S^3 onto the closed disk \overline{D} , and it is a local coordinate on the region of S^3 outside the set $|c_1|^2 = |c_2|^2 = 1/2$. However, the inverse map $D \to S^2$ is two-valued. Indeed, denote by $\binom{c_1}{c_2}_* \in S^2$ the Hopf projection of a point $\binom{c_1}{c_2} \in S^3$. One branch of the inverse map is a diffeomorphism of D onto the neighborhood $S^2_+ \subset S^2$ of the point $\binom{1}{0}_*$ (where z = 0), and another branch is a diffeomorphism of D onto the neighborhood $S^2_- \subset S^2$ of the point $\binom{0}{1}_*$ (where also z = 0):

The base S^2 is the gluing of S^2_{\pm} along their boundaries, where $|z| = \frac{1}{2}$ and $|c_1|^2 = |c_2|^2 = \frac{1}{2}$.

18 Reduction of spectral problem by the symmetry group

We choose coordinates (17.3) on the bases of the Hopf fibration for each active molecule, and denote

Then the differential $DP_*(X^0_*)$ of the Poincaré map P_* on the factorspace \mathbb{X}/G is represented by the matrix

The following lemma justifies the reduction to the eigenvalue problem for the factordynamics.

Lemma 18.1. The eigenvalues of $DP(X^0)$ and $DP_*(X^0_*)$ coincide up to $\mu = 1$.

Proof. The variables a^0, b^0, \mathbb{Z}^0 are local coordinates on the factorspace $\mathbb{X}_* = \mathbb{X}/G$. this factorspace is the base of the fiberspace \mathbb{X} with the fibers, isomorphic to S^N , where *S* is the unit circle $|\theta| = 1$. It remains to calculate the differential (18.4) at the ground state (13.10) which correspond to the single point

Remark 21.1. According to Berry's conjecture, in the case of ergodic geodesic flow, the distribution of values of Laplacian eigenfunctions with sufficiently large eigenvalues can be Gaussian [6, 25], thus different from the "sinusoidal distribution" of eigenmodes (7.6).

Remark 21.2. The summation S reappears in the calculations (21.5) and (21.8).

Remark 21.3. i) For every nonzero eigenvector (21.1), its component \mathbf{x}_0 , representing the Maxwell field, does not vanish. Hence, if (1.1) holds, then the magnitude of the Maxwell field provisionally increases exponentially for large (but bounded) times.

ii) The degree six of the polynomial can be reduced to three using the symmetry (4.6).

Remark 21.4. We expect that

i) all the multipliers $|\mu|$ are simple with probability one;

ii) the multipliers are close to the corresponding roots of the polynomial $p(\mu)$;

iii) the condition (1.1) holds for the roots of the polynomial $p(\mu)$ when

where $d(\sigma_1)$ is the corresponding threshold, which is an increasing function of σ_1 . Physically, the condition (21.18) means that the amplitude of the pumping exceeds the damping losses.

A On averaging of slow rotations

where $\tilde{\Omega}_1(\tau) := \frac{1}{T} \int_0^T \Omega_1(\tau) d\tau$. It suffices to prove that

$$|c_{\varepsilon}(T) - \hat{c}_{\varepsilon}(T)| = O(\varepsilon^2), \qquad \varepsilon \to 0.$$
 (A.8)

The Taylor formula gives

$$c_{\varepsilon}(\tau) = c_0 + \varepsilon [\partial_{\varepsilon} c_{\varepsilon}(\tau)]|_{\varepsilon=0} + O(\varepsilon^2), \qquad \hat{c}_{\varepsilon}(\tau) = c_0 + \varepsilon [\partial_{\varepsilon} \hat{c}_{\varepsilon}(\tau)]|_{\varepsilon=0} + O(\varepsilon^2).$$
(A.9)

Therefore, (A.8) will follow from the identity

$$[\partial_{\varepsilon}c_{\varepsilon}(T)]|_{\varepsilon=0} = [\partial_{\varepsilon}\hat{c}_{\varepsilon}(T)]|_{\varepsilon=0}.$$
(A.10)

Indeed, $\hat{c}_{\varepsilon}(T) = e^{-i\varepsilon\tilde{\Omega}T}c_0$, so the right-hand side of (A.10) is equal to

$$[\partial_{\varepsilon}\hat{c}_{\varepsilon}(T)]|_{\varepsilon=0} = -i\tilde{\Omega}_{1}Tc_{0} = -i\int_{0}^{T}\Omega_{1}(\tau)c_{0}d\tau.$$
(A.11)

It remains to calculate the left-hand side. Denote

$$b_{\varepsilon}(\tau) := \partial_{\varepsilon} c_{\varepsilon}(\tau). \tag{A.12}$$

Differentiating equation (A.6) in ε , we obtain

$$\dot{b}_{\varepsilon}(\tau) = -i\Omega_1(\tau)c_{\varepsilon}(\tau) - i\varepsilon\Omega_1(\tau)b_{\varepsilon}(\tau), \qquad \tau \in [0,T]; \qquad b_{\varepsilon}(0) = 0.$$
(A.13)

In particular, for $\varepsilon = 0$ we have

$$\dot{b}_0(\tau) = -i\Omega_1(\tau)c_0, \qquad \tau \in [0,T]; \qquad b_0(0) = 0.$$
 (A.14)

Hence,

$$b_0(T) = -i \int_0^T \Omega_1(\tau) c_0 d\tau.$$
 (A.15)

Now (A.10) is proved.

Remark A.2. Equation (A.6) can be rewritten for $\tilde{c}_{\varepsilon}(s) := c_{\varepsilon}(\frac{s}{\varepsilon})$ as

$$\partial_s \tilde{c}_{\varepsilon}(s) = -i\Omega_1(\frac{s}{\varepsilon})\tilde{c}_{\varepsilon}(s), \qquad s \in [0, \varepsilon T], \tag{A.16}$$

where $s = \varepsilon \tau$ is the 'slow time'. Thus, Lemma A.1 is a specific version of averaging principle.

B Some integrals

2.1 Integrals (14.26)

First, (14.17) implies that

$$I_{1}(\tau) := \int_{0}^{\tau} e^{-i\tau'} e^{-\varkappa(\tau-\tau')} \sin(\tau-\tau') d\tau' = \int_{0}^{\tau} e^{-i\tau'} [e^{(-\varkappa+i)(\tau-\tau')} - e^{(-\varkappa-i)(\tau-\tau')}] d\tau'$$

$$= \frac{1}{2i} e^{(-\varkappa+i)\tau} \int_{0}^{\tau} e^{(\varkappa-2i)\tau'} d\tau' - \frac{1}{2i} e^{(-\varkappa-i)\tau} \int_{0}^{\tau} e^{\varkappa\tau'} d\tau'$$

$$= \frac{1}{2i} e^{(-\varkappa+i)\tau} \frac{e^{(\varkappa-2i)\tau} - 1}{\varkappa - 2i} - \frac{1}{2i} e^{(-\varkappa-i)\tau} \frac{e^{\varkappa\tau} - 1}{\varkappa}$$

$$= \frac{e^{-i\tau} - e^{(-\varkappa+i)\tau}}{2i\varkappa + 4} - \frac{e^{-i\tau} - e^{(-\varkappa-i)\tau}}{2i\varkappa}$$

$$\approx -\frac{i}{2} \sin\tau - \frac{\tau}{2i} e^{-i\tau} + \varkappa \Big[\frac{-\sin\tau + \tau e^{i\tau}}{4} + \frac{\tau^{2} e^{-i\tau}}{4i} \Big], \qquad (B.1)$$

where we have neglected errors $O(\varkappa^2) = O(10^{-14})$. Similarly,

$$\begin{split} I_{2}(\tau) &:= \frac{1}{2} \int_{0}^{\tau} \tau' \cos \tau' e^{-\varkappa(\tau-\tau')} \sin(\tau-\tau') d\tau' = \frac{1}{4} \int_{0}^{\tau} \tau' e^{-\varkappa(\tau-\tau')} \left[\sin \tau + \sin(\tau-2\tau') \right] d\tau' \\ &= \frac{1}{4} e^{-\varkappa\tau} \left[\sin \tau \int_{0}^{\tau} \tau' e^{\varkappa\tau'} d\tau' + \operatorname{Im} \int_{0}^{\tau} \tau' e^{\varkappa\tau'} e^{i(\tau-2\tau')} d\tau' \right] \\ &= \frac{1}{4} e^{-\varkappa\tau} \left[\sin \tau \left(\tau \frac{e^{\varkappa\tau}}{\varkappa} - \int_{0}^{\tau} \frac{e^{\varkappa\tau'}}{\varkappa} d\tau' \right) + \operatorname{Im} \left(e^{i\tau} \tau \frac{e^{(\varkappa-2t)\tau}}{\varkappa-2t} - e^{i\tau} \int_{0}^{\tau} \frac{e^{(\varkappa-2t)\tau'}}{\varkappa-2t} d\tau' \right) \right] \\ &= \frac{1}{4} e^{-\varkappa\tau} \left[\sin \tau \left(\tau \frac{e^{\varkappa\tau}}{\varkappa} - \frac{e^{\varkappa\tau}}{\varkappa^{2}} \right) + \operatorname{Im} \left(e^{i\tau} \tau \frac{e^{(\varkappa-2t)\tau}}{\varkappa-2t} - e^{i\tau} \frac{e^{(\varkappa-2t)\tau}}{(\varkappa-2t)^{2}} \right) \right] \\ &= \frac{1}{4} e^{-\varkappa\tau} \left[\sin \tau \left(\frac{\tau e^{\varkappa\tau}}{\varkappa} - \frac{e^{\varkappa\tau}}{\varkappa^{2}} \right) + \operatorname{Im} \left(\tau \frac{e^{(\varkappa-2t)\tau}}{\varkappa^{2}+4} - \frac{e^{(\varkappa-2t)\tau}}{(\varkappa^{2}+4)^{2}} \right) \right] \\ &\approx \frac{1}{4} e^{-\varkappa\tau} \left[\sin \tau \left(\frac{\tau^{2}}{2} + \frac{\varkappa^{3}}{2} \right) + \tau \frac{e^{\varkappa\tau}}{4} \operatorname{Im} \left(e^{-i\tau} (\varkappa+2t) \right) - \frac{1}{16} \operatorname{Im} \left[\left(e^{(\varkappa-t)\tau} - e^{i\tau} \right) (\varkappa+2t)^{2} \right] \right] \\ &\approx \frac{1}{4} e^{-\varkappa\tau} \left[\sin \tau \left(\frac{\tau^{2}}{2} + \frac{\varkappa^{3}}{2} \right) + \tau \frac{e^{\varkappa\tau}}{4} \operatorname{Im} \left(e^{-i\tau} (\varkappa+2t) \right) - \frac{1}{16} \operatorname{Im} \left[\left(e^{(\varkappa-t)\tau} - e^{i\tau} \right) (\varkappa+2t)^{2} \right] \right] \\ &\approx \frac{1}{4} e^{-\varkappa\tau} \left[\sin \tau \left(\frac{\tau^{2}}{2} + \frac{\varkappa^{3}}{2} \right) + \tau \frac{e^{\varkappa\tau}}{4} \operatorname{Iccos \tau - \varkappa sin \tau} \right] \\ &- \frac{1}{16} \left[\left(e^{\varkappa\tau} \cos \tau - \cos \tau \right) 4\varkappa - 4 \left(- e^{\varkappa\tau} \sin \tau - \sin \tau \right) \right] \right] \\ &\approx \frac{1}{4} \left[\sin \tau \frac{\tau^{2}}{2} + \frac{\pi}{4} \left[2\cos \tau - \varkappa \sin \tau \right] - \frac{1}{4} \left(1 + e^{-\varkappa\tau} \right) \sin \tau \right] \\ &\approx \frac{1}{4} \left[\sin \tau \frac{\tau^{2}}{2} + \frac{\pi}{4} \left[2\cos \tau - \varkappa \sin \tau \right] - \frac{1}{4} \left(2 - \varkappa \tau \right) \sin \tau \right] \\ &\approx \frac{1}{8} \left[\tau^{2} \sin \tau + \tau \cos \tau - \sin \tau \right] - \frac{1}{4} \left(2 - \varkappa \tau \right) \sin \tau \right] \end{aligned}$$

2.2 Integrals (14.32)

Calculate integrals

$$\begin{split} \int_{0}^{2\pi} \tau e^{i\tau} d\tau &= -2\pi i \approx -6.28i, \qquad \int_{0}^{2\pi} \tau \cos \tau d\tau = 0, \qquad \int_{0}^{2\pi} \tau e^{2i\tau} d\tau = -\pi i, \\ \int_{0}^{2\pi} \tau^{2} e^{i\tau} d\tau &= -4\pi^{2}i + i \int_{0}^{2\pi} 2\tau e^{i\tau} d\tau = -4\pi^{2}i + 4\pi, \\ \int_{0}^{2\pi} \tau^{2} e^{2i\tau} d\tau &= -2\pi^{2}i + i \int_{0}^{2\pi} \tau e^{2i\tau} d\tau = -2\pi^{2}i + \pi, \\ \int_{0}^{2\pi} \tau^{2} \sin \tau d\tau &= -4\pi^{2}i. \end{split}$$

Then neglecting errors $O(\varkappa^2) = O(10^{-14})$, we can rewrite (14.32) as

$$\begin{aligned} J_{1} &:= \frac{1}{2\pi} \int_{0}^{2\pi} I_{1}^{\prime}(\tau) e^{-i\tau} d\tau \approx \frac{1}{2\pi} \int_{0}^{2\pi} \left[-\frac{i}{2} \sin \tau - \frac{\tau}{2i} e^{-i\tau} + \varkappa \left[\frac{-\sin \tau + \tau e^{i\tau}}{4} + \frac{\tau^{2} e^{-i\tau}}{4i} \right] \right]^{\prime} e^{-i\tau} d\tau \\ &= \frac{1}{2\pi} \int_{0}^{2\pi} \left[-\frac{i}{2} \cos \tau - \frac{e^{-i\tau} - i\tau e^{-i\tau}}{2i} + \varkappa \left[\frac{-\cos \tau + e^{i\tau} + i\tau e^{i\tau}}{4} + \frac{2\tau e^{-i\tau} - i\tau^{2} e^{-i\tau}}{4i} \right] \right] e^{-i\tau} d\tau \\ &= \frac{1}{2\pi} \int_{0}^{2\pi} \left[-\frac{i}{2} \cos \tau e^{-i\tau} - \frac{e^{-i2\tau} - i\tau e^{-2i\tau}}{2i} + \varkappa \left[\frac{-\cos \tau e^{-i\tau} + i\tau}{4} + \frac{2\tau e^{-2i\tau} - i\tau^{2} e^{-2i\tau}}{4i} \right] \right] d\tau \\ &= \frac{1}{2\pi} \int_{0}^{2\pi} \left[-\frac{i}{4} + \frac{\tau e^{-2i\tau}}{2} + \varkappa \left[\frac{-\frac{1}{2} + i\tau}{4} + \frac{2\tau e^{-2i\tau} - i\tau^{2} e^{-2i\tau}}{4i} \right] \right] d\tau \\ &= -\frac{i}{4} + \frac{\pi i}{4\pi} + \varkappa \left[\frac{-\frac{1}{2} + i\pi}{4} + \frac{2\pi i - i(2\pi^{2}i + \pi)}{8\pi i} \right] = 0, \\ J_{2} &:= \frac{1}{2\pi} \int_{0}^{2\pi} I_{2}^{\prime}(\tau) e^{-i\tau} d\tau \approx \frac{1}{16\pi} \int_{0}^{2\pi} \left[\tau^{2} \sin \tau + \tau \cos \tau - \sin \tau \right]^{\prime} e^{-i\tau} d\tau \\ &= \frac{1}{16\pi} \int_{0}^{2\pi} \left[\tau \sin \tau + \tau^{2} \cos \tau \right] e^{-i\tau} d\tau = \frac{1}{32\pi} \int_{0}^{2\pi} \left[-i\tau(1 - e^{-2i\tau}) + \tau^{2}(1 + e^{-2i\tau}) \right] d\tau \end{aligned}$$

2.3 Integrals (15.5)

Neglecting errors $O(\varkappa^2) = O(10^{-14})$, we obtain

$$A_{1} \approx -\int_{0}^{2\pi} e^{-i\tau'} e^{-\varkappa(2\pi-\tau')} \sin\tau' d\tau' = -\frac{e^{-2\pi\varkappa}}{2i} \int_{0}^{2\pi} e^{-i\tau'} e^{\varkappa\tau'} [e^{i\tau'} - e^{-i\tau'}] d\tau'$$

$$= -\frac{e^{-2\pi\varkappa}}{2i} \int_{0}^{2\pi} [e^{\varkappa\tau'} - e^{(\varkappa-2i)\tau'}] d\tau' = -\frac{e^{-2\pi\varkappa}}{2i} \left[\frac{e^{2\pi\varkappa} - 1}{\varkappa} - \frac{e^{2\pi\varkappa} - 1}{\varkappa - 2i}\right]$$

$$\approx -\frac{e^{-2\pi\varkappa}}{2i} \left[\frac{2\pi\varkappa + \frac{1}{2}(2\pi\varkappa)^{2}}{\varkappa} - \frac{2\pi\varkappa}{4}(\varkappa+2i)\right] \approx -\frac{e^{-2\pi\varkappa}}{2i} \left[2\pi + 2\varkappa\pi^{2} - \varkappa\pi i\right]$$

$$\approx (1 - 2\pi\varkappa) \left[\pi i + \varkappa\pi^{2}i + \frac{\varkappa\pi}{2}\right] \approx \pi i + \varkappa\pi^{2}i + \frac{\varkappa\pi}{2} - \pi^{2}2\varkappa i$$

$$= \pi i + \varkappa \left[-\pi^{2}i + \frac{\pi}{2}\right] = A_{11} + iA_{12}, \qquad A_{11} = \varkappa\frac{\pi}{2}, \quad A_{12} = \pi - \varkappa\pi^{2}. \quad (B.4)$$

Similarly,

$$\begin{split} A_{2} \approx &-\frac{e^{-\pi\sigma_{1}}}{2i} \int_{0}^{2\pi} \tau' [e^{\varkappa\tau'} - e^{(\varkappa-2i)\tau'}] d\tau' \\ = &-\frac{e^{-\pi\sigma_{1}}}{2i} \Big[\tau \frac{e^{\varkappa\tau}}{\varkappa} - \frac{e^{\varkappa\tau}}{\varkappa^{2}} - \tau \frac{e^{\varkappa\tau}}{\varkappa-2i} + \frac{e^{\varkappa\tau}}{(\varkappa-2i)^{2}} \Big] \Big|_{0}^{2\pi} = -\frac{e^{-\pi\sigma_{1}}}{2i} \Big[\frac{\tau \varkappa-1}{\varkappa^{2}} e^{\varkappa\tau} - \frac{\tau(\varkappa-2i)-1}{(\varkappa-2i)^{2}} e^{\varkappa\tau} \Big] \Big|_{0}^{2\pi} \\ \approx &-\frac{e^{-\pi\sigma_{1}}}{2i} \Big[\frac{\tau \varkappa-1}{\varkappa^{2}} e^{\varkappa\tau} - \frac{\tau(\varkappa-2i)-1}{16} (\varkappa+2i)^{2} e^{\varkappa\tau} \Big] \Big|_{0}^{2\pi} \\ = &-\frac{e^{-\pi\sigma_{1}}}{2i} \Big[\frac{(\pi\sigma_{1}-1)e^{\pi\sigma_{1}}+1}{\varkappa^{2}} - \frac{(\varkappa+2i)^{2}}{16} [(\pi\sigma_{1}-4\pi i-1)e^{\pi\sigma_{1}}+1] \Big] \\ \approx &-\frac{e^{-\pi\sigma_{1}}}{2i} \Big[\frac{(\pi\sigma_{1}-1)(1+\pi\sigma_{1}+\frac{1}{2}(\pi\sigma_{1})^{2}+\frac{1}{6}(\pi\sigma_{1})^{3})+1}{(\varkappa)^{2}} - \pi i - \frac{\pi\sigma_{1}}{2} + \frac{1}{4} [\pi\sigma_{1} + (-4\pi i-1)\pi\sigma_{1}] \Big] \\ \approx &-\frac{e^{-\pi\sigma_{1}}}{2i} \Big[\frac{(\pi\sigma_{1})^{2} + (\pi\sigma_{1}-1)(\frac{1}{2}(\pi\sigma_{1})^{2}+\frac{1}{6}(\pi\sigma_{1})^{3})}{\varkappa^{2}} - \pi i - \frac{\pi\sigma_{1}}{2} + \frac{1}{4} [\pi\sigma_{1} + (-4\pi i-1)\pi\sigma_{1}] \Big] \\ \approx &-\frac{e^{-\pi\sigma_{1}}}{2i} \Big[(4\pi^{2} + (\pi\sigma_{1}-1)(2\pi^{2}+\frac{2}{3}\pi^{3}\sigma_{1}) - \pi i - \frac{\pi\sigma_{1}}{2} - \pi^{2}\sigma_{1}i] \Big] \\ \approx &-\frac{e^{-\pi\sigma_{1}}}{2i} \Big[2\pi^{2} - \pi i + \sigma_{1}[\frac{4}{3}\pi^{3} - \frac{\pi}{2} - \pi^{2}i] \Big] = e^{-\pi\sigma_{1}} \Big[\pi^{2}i + \frac{\pi}{2} + \sigma_{1}[\frac{2}{3}\pi^{3}i - \frac{\pi}{4}i + \frac{\pi^{2}}{2}] \Big] \\ = &\pi^{2}i + \frac{\pi}{2} - \sigma_{1}i[\frac{\pi^{3}}{3} + \frac{\pi}{4}] = A_{21} + iA_{22}, A_{21} = \frac{\pi}{2}, A_{22} = \pi^{2} - \sigma_{1}[\frac{\pi^{3}}{3} + \frac{\pi}{4}]. \end{split}$$
(B.5)

Hence,

$$A_3 = \operatorname{Re}A_2 \approx \pi^2 - \sigma_1 [\frac{\pi^3}{3} + \frac{\pi}{4}].$$
 (B.6)

Finally,

$$\begin{cases} B_{1} = -i \int_{0}^{2\pi} e^{-i\tau'} E(2\pi - \tau') d\tau' = -iA_{1}. \\ B_{2} = \int_{0}^{2\pi} [e^{-i\tau'} - i\tau' e^{-i\tau'}] E(2\pi - \tau') d\tau' = A_{1} - iA_{2} \\ B_{3} = \operatorname{Re} B_{2} = A_{11} + A_{22} \end{cases}$$
