Hagen-Hurley equations and the W boson

Abstract

We proceed with our study of the Hagen-Hurley equations describing spin one bosons. In this work, we describe a general decay of the Hagen-Hurley boson. It is important that the transformation conserves spin s = 1of the decaying boson and provides information about the kinematics of the decay. We explain the high instability of the Hagen-Hurley particle and identify it as the W boson.

1 Introduction

The intermediate vector bosons, W^{\pm} as well as Z^0 , are extremely short-lived particles with a half-life of about 3×10^{-25} s [1]. Very recently, an analysis of high-precision measurement of the W boson mass suggests that the mass is slightly higher than the Standard Model predicts [2]. This result hints at the need for reconsideration of the Standard Model.

This work aims to propose a relativistic equation that could effectively describe the W boson.

We base our approach on spin one Hagen-Hurley equation [3–7]. In Section 2, for the sake of completeness, we rewrite the Hagen-Hurley equations as two coupled Dirac equations involving higher-order spinors as in [8].

Then, in Section 3, we describe decays of *real* W bosons, such as appearing in the top quark decay or produced in collisions of protons and antiprotons. More precisely, we transform two coupled Dirac equations involving non-standard spinors, obtained in Section 2, into two Dirac equations for two fermions, generalizing our earlier work [9]. It is important that this transformation conserves spin s = 1 of the decaying boson and provides information about the kinematics of the decay, as described in Section 4.

In what follows, we are using definitions and conventions of Ref. [8].

2 Rearrangement of the Hagen-Hurley equations as two coupled Dirac equations

We start with the spinor formulation of the Hagen-Hurley equations, cf. [10] or Subsection 6 ii) in [11] or Eqs. (18), (19) in [8], see also Eqs. (2.1), (2.24) in [6] for the 7×7 form. These equations violate parity P [11], where $P: x^0 \rightarrow x^0, x^i \rightarrow -x^i$ (i = 1, 2, 3). Since parity is violated in weak interactions [12, 13], these equations can describe weakly interacting particles.

We write one of these equations (Eq. (19) of Ref. [8]), in the form:

$$\left. \begin{array}{c} p^{A}{}_{\dot{B}} \zeta_{A\dot{D}} = m\chi_{\dot{B}\dot{D}} \\ p_{A}{}^{\dot{D}} \chi_{\dot{B}\dot{D}} = -m\zeta_{A\dot{B}} \end{array} \right\}$$

$$\chi_{\dot{B}\dot{D}} = \chi_{\dot{D}\dot{B}} \tag{1b}$$

where Eq. (1b) is the spin-1 constraint [11]. In Eqs. (1a) we have $p^{A\dot{B}} = (\sigma^0 p^0 + \vec{\sigma} \cdot \vec{p})^{A\dot{B}}$, $p^{\mu} = i \frac{\partial}{\partial x_{\mu}}$, where σ^k (k = 1, 2, 3) are the Pauli matrices, and σ^0 is the 2 × 2 unit matrix. Equations (1), which were first proposed by Dirac [10], can be written in the 7 × 7 Hagen-Hurley form:

$$\beta^{\mu}p_{\mu}\Psi = m\Psi, \qquad (2)$$

the β^{μ} matrices given in [6], with $\Psi = (\chi_{11}, \chi, \chi_{22}, \zeta_{11}, \zeta_{12}, \zeta_{21}, \zeta_{22})^T$, where $\chi \stackrel{df}{=} \chi_{12} = \chi_{21}$ and T stands for transposition of a matrix.

Equations (1a) in explicit form read:

\left(p^{0}+p^{3}\right)\zeta_{11}+\left(p^{1}+ip^{2}\right)\zeta_{21} &=& m\chi_{21}
\end{array}\right\}$$

$$\left. \begin{array}{ccc} -\left(p^{1}+ip^{2}\right)\chi_{1\dot{2}}-\left(p^{0}-p^{3}\right)\chi_{2\dot{2}} &=& -m\zeta_{1\dot{2}}\\ \left(p^{0}+p^{3}\right)\chi_{1\dot{2}}+\left(p^{1}-ip^{2}\right)\chi_{2\dot{2}} &=& -m\zeta_{2\dot{2}}\\ -\left(p^{1}-ip^{2}\right)\zeta_{1\dot{2}}-\left(p^{0}-p^{3}\right)\zeta_{2\dot{2}} &=& m\chi_{1\dot{2}}\\ \left(p^{0}+p^{3}\right)\zeta_{1\dot{2}}+\left(p^{1}+ip^{2}\right)\zeta_{2\dot{2}} &=& m\chi_{\dot{2}\dot{2}} \end{array} \right\}$$

These equations are coupled due to the condition $\chi_{\dot{1}\dot{2}} = \chi_{\dot{2}\dot{1}}$ which ensures that s = 1.

3 Decays of real spin-1 Hagen-Hurley bosons

We realize that solutions of two Dirac equations (3) are non-standard since they involve higher-order spinors rather than spinors ξ_A , $\eta_{\dot{B}}$. There are several possibilities to reduce these higher-order spinors via the de Broglie method of fusion [14, 15]. Attempting to describe leptonic decays of the W boson, $W^- \to l + \bar{\nu}_l$, we made the following substitution [9]:

$$\chi_{\dot{B}\dot{D}}(x) = \eta_{\dot{B}}(x)\alpha_{\dot{D}}(x), \qquad (4a)$$

$$\zeta_{A\dot{B}}(x) = \xi_A(x) \alpha_{\dot{B}}(x), \qquad (4b)$$

where $\alpha_{\dot{A}}(x)$ is the Weyl spinor, describing massless neutrinos, while $\eta_{\dot{B}}(x)$, and $\xi_A(x)$ are the Dirac spinors. Since $\chi_{\dot{B}\dot{D}}(x) \neq \chi_{\dot{D}\dot{B}}(x)$ we had to assume that the spin of the decaying boson belonged to $0 \oplus 1$ space. We suggested that our formalism can describe a decay of a *virtual* W^- boson into a lepton and antineutrino in the mixed beta decay [9].

On the other hand, to describe the decay of a real W boson, we carry out another, conserving spin, substitution:

$$\chi_{\dot{B}\dot{D}}(x) = \eta_{\dot{B}}(x) \alpha_{\dot{D}}(x) + \alpha_{\dot{B}}(x) \eta_{\dot{D}}(x), \qquad (5a)$$

$$\zeta_{A\dot{B}}(x) = \xi_A(x) \alpha_{\dot{B}}(x) + \lambda_A(x) \eta_{\dot{B}}(x).$$
(5b)

Note that in this case $\chi_{\dot{1}\dot{2}} = \chi_{\dot{2}\dot{1}}$ and thus s = 1. Both terms in $\chi_{\dot{B}\dot{D}}(x)$ are necessary to ensure s = 1 condition.

Substituting (5) into Eqs. (3) and rearranging terms we obtain:

$$\left. \begin{array}{ccc} -\left(p^{1}+ip^{2}\right)\eta_{i}\alpha_{\dot{A}}-\left(p^{0}-p^{3}\right)\eta_{\dot{2}}\alpha_{\dot{A}} &=& -m\xi_{1}\alpha_{\dot{A}}\\ \left(p^{0}+p^{3}\right)\eta_{i}\alpha_{\dot{A}}+\left(p^{1}-ip^{2}\right)\eta_{\dot{2}}\alpha_{\dot{A}} &=& -m\xi_{2}\alpha_{\dot{A}}\\ -\left(p^{1}-ip^{2}\right)\xi_{1}\alpha_{\dot{A}}-\left(p^{0}-p^{3}\right)\xi_{2}\alpha_{\dot{A}} &=& m\eta_{i}\alpha_{\dot{A}}\\ \left(p^{0}+p^{3}\right)\xi_{1}\alpha_{\dot{A}}+\left(p^{1}+ip^{2}\right)\xi_{2}\alpha_{\dot{A}} &=& m\eta_{2}\alpha_{\dot{A}} \end{array} \right\} ,$$

where \dot{A} , $\dot{B} = \dot{1}$, $\dot{2}$.

Assuming solutions as:

$$\alpha_{\dot{B}}(x) = \hat{\alpha}_{\dot{B}}e^{-ik\cdot x}, \ \lambda_A(x) = \hat{\lambda}_A e^{-ik\cdot x}, \ k^{\mu}k_{\mu} = m_1^2, \tag{8}$$

$$\eta_{\dot{B}}(x) = \hat{\eta}_{\dot{B}} e^{-iq \cdot x}, \ \xi_A(x) = \hat{\xi}_A e^{-iq \cdot x}, \ q^{\mu} q_{\mu} = m_2^2, \tag{9}$$

we get two Dirac equations for spinors $(\xi_A, \eta_{\dot{B}})^T$ and $(\lambda_C, \alpha_{\dot{D}})^T$:

with rescaled momentum operators:

$$\tilde{p}^{\mu} = i\frac{\partial}{\partial x_{\mu}} + k^{\mu}, \ \bar{p}^{\mu} = i\frac{\partial}{\partial x_{\mu}} + q^{\mu}.$$

4 Kinematics of decay of the real spin-1 Hagen-Hurley bosons

The forms (8), and (9) solve equations (10), and (11) provided that:

$$(k^{\mu} + q^{\mu}) (k_{\mu} + q_{\mu}) = m^2.$$
(13)

We thus define a new four-vector:

$$p^{\mu} \stackrel{df}{=} k^{\mu} + q^{\mu}, \tag{14}$$

and we have $p^{\mu}p_{\mu} = m^2$ where m is the decaying boson mass.

Taking into account Eqs. (8), (9), and (13) we obtain two-body decay kinematic equality:

$$\left. \begin{array}{l} m_1^2 + m_2^2 + 2\left(k^0 q^0 - \overrightarrow{k} \cdot \overrightarrow{q}\right) = m^2, \\ k^0 = +\sqrt{\left|\overrightarrow{k}\right|^2 + m_1^2}, \ q^0 = +\sqrt{\left|\overrightarrow{q}\right|^2 + m_2^2}. \end{array} \right\}$$
(15)

It follows that transition from Eqs. (3) to (10), (11), via the substitution (5), can be interpreted as the decay of a real (not virtual) spin one boson with mass m into two spin one-half fermions with four-momenta k^{μ} , q^{μ} , and masses m_1 , m_2 because the inequality:

$$m^2 - m_1^2 - m_2^2 = 2\left(k^0 q^0 - \vec{k} \cdot \vec{q}\right) > 0,$$
 (16a)

is fulfilled.

Indeed, we have

$$k^{0}q^{0} - \overrightarrow{k} \cdot \overrightarrow{q} = \sqrt{\left|\overrightarrow{k}\right|^{2} + m_{1}^{2}} \sqrt{\left|\overrightarrow{q}\right|^{2} + m_{2}^{2}} - \left|\overrightarrow{k}\right| \left|\overrightarrow{q}\right| \cos\varphi > 0, \quad (16b)$$

where we have used the definition of the scalar product $\overrightarrow{k} \cdot \overrightarrow{q}$ and φ is an angle between vectors \overrightarrow{k} and \overrightarrow{q} .

Let us reconsider Eq. (15). For small m_1 , m_2 we have:

$$m^{2} = 2\left|\overrightarrow{k}\right|\left|\overrightarrow{q}\right|\left(1 - \cos\varphi\right).$$
(17)

Imposing the transverse momentum conservation as in [16] or, for negligible k_3 , q_3 , we get the expression for the classical transverse mass:

$$m_{\perp}^{2} = 2 \left| \overrightarrow{k}_{\perp} \right| \left| \overrightarrow{q_{\perp}} \right| \left(1 - \cos \varphi \right), \tag{18}$$

and this is exactly the equation 1 proposed in Ref. [16] to determine the mass of the W boson from the kinematic distribution of the decay leptons [2, 16] (note that the neutrino from the W boson is not directly detectable and longitudinal momentum balance cannot be imposed because of the geometry of the experiment [2], therefore the Eq. (18) is needed).

In conclusion, we identify the Hagen-Hurley spin one particle as the ${\cal W}$ boson.

5 Summary

We have demonstrated that the Hagen-Hurley equations describe the decay of a spin-1 boson into two massive spin- $\frac{1}{2}$ fermions. The Hagen-Hurley boson is unstable, as manifested by inequalities (16). Instability of the boson is enhanced by the presence in the coupled Dirac equations (3) of non-standard higher-order spinors $\zeta_{A\dot{B}}$, $\chi_{\dot{C}\dot{D}}$, rather than Dirac bispinors (ξ_A , $\eta_{\dot{B}}$)^T. Moreover, in our formalism, the classical kinematic condition for the transverse mass (18) appears naturally.

Summing up, we think that the Hagen-Hurley equations in spinor form (1) [11] or in alternative 7 × 7 matrix formulation [6] can describe the extremely unstable intermediate vector W boson. Moreover, the decay of W^+ into two massive spin $-\frac{1}{2}$ fermions ($W^+ \longrightarrow l^+\nu$, $W^+ \longrightarrow$ hadrons) as can be described by our formalism (with massive neutrinos), amounts to almost 100% of all decay modes of the W boson [1]. It is interesting, that our approach, based on the de Broglie method of fusion [14, 15], also describes the kinematics of the decay.
