# <span id="page-0-1"></span>ON G-BIRATIONAL RIGIDITY OF DEL PEZZO SURFACES

ABSTRACT. Let G be a finite group and  $H \subseteq G$  be its subgroup. We prove that if a smooth del Pezzo surface over an algebraically closed field is  $H$ -birationally rigid then it is also  $G$ -birationally rigid, answering a geometric version of Kollár's question in dimension 2 by positive. On our way, we also investigate  $G$ -birational rigidity of two-dimensional quadrics and del Pezzo surfaces of degree 6.

#### 1. Birational rigidity

The present note is motivated by J. Kollár's paper [\[Kol09\]](#page-25-0) which studies the behavior of birational rigidity of Fano varieties under extensions of algebraically closed fields. Let k be a field. Recall that a *Mori fiber space* is a projective morphism  $\pi : X \longrightarrow Y$  of algebraic varieties over k, such that X is Q-factorial with terminal singularities, rk Pic( $X/Y$ ) = 1 and  $-K_X$  is  $\pi$ -ample. Once  $Y = \text{Spec } \mathbf{k}$ , the variety X is simply a Q-factorial terminal Fano variety of Picard rank 1. Roughly speaking, it is called *birationally rigid* if  $X$  is not birational to the total space of any other Mori fiber space; see Definition [1.3](#page-1-0) below for the details. In [\[Kol09\]](#page-25-0) the following question was raised:

Question (Kollár). Let  $X$  be a Fano variety over a field **k** such that  $X$  is birationally rigid over the algebraic closure  $\overline{k}$ . Is X birationally rigid over  $k$ ?

From the modern point of view, one can naturally formulate the Minimal Model Program in equivariant setting. We refer to [\[Pro21\]](#page-25-1) for an overview and basic definitions used in this note. Let X be an algebraic variety over a field **k** and  $G$  be a group. Following Yu. Manin [\[Man66\]](#page-25-2), one calls X a geometric G-variety if  $\mathbf{k} = \overline{\mathbf{k}}$  and there is an injective homomorphism  $G \hookrightarrow \text{Aut}(X)$ . Another instance of this concept is an *arithmetic G-variety*, for which  $\mathbf{k} \neq \overline{\mathbf{k}}$ and G is the Galois group of the extension  $\overline{k}/k$  acting on  $X \times_{\text{Spec } k} \text{Spec } \overline{k}$  through the second factor. In both cases, we refer to X as to  $G\text{-}variety$ , if no confusion arises.

Furthermore, one can consider the "mixed" case, when k is not assumed to be algebraically closed and  $G$  acts by biregular automorphisms of  $X$ , i.e. one considers the action of Gal( $\mathbf{k}/\mathbf{k}$ ) × G. For some results in this setting see [\[DI09b,](#page-25-3) [Tre16,](#page-25-4) [Tre18,](#page-25-5) [Tre19,](#page-26-0) [RZ18,](#page-25-6) [Yas22,](#page-26-1) [CMYZ22,](#page-24-0) [Avi20\]](#page-24-1) and Remark [2.15](#page-7-0) below.

<span id="page-1-1"></span>Now, let us give some precise definitions.

**Definition 1.2.** A *G*-*Mori fiber space* is a projective morphism  $\pi: X \rightarrow Y$  of *G*-varieties, such that X has terminal singularities, all G-invariant Weil divisors on  $X$  are Q-Cartier divisors,  $\text{rk Pic}(X)^G - \text{rk Pic}(Y)^G = 1$  and  $-K_X$  is  $\pi$ -ample. If Y is a point, we say that X is a  $G$ -Fano variety.

<span id="page-1-0"></span>**Definition 1.3** (see e.g. [\[CS16,](#page-24-2) Definition 3.1.1]). A  $G$ -Fano variety is called  $G$ -birationally rigid if the following two conditions are satisfied:

(1) there is no G-birational map  $X \rightarrow X'$  such that X' is a G-Mori fiber space over a positive dimensional variety;

(2) if there is a G-birational map  $\varphi: X \dashrightarrow X'$  such that X' is a G-Fano variety, then  $X \simeq X'$  and there is a G-birational self-map  $\tau \in Bir(X)$  such that  $\varphi \circ \tau$  is a biregular -morphism.

Assume, moreover, that the following holds:

(3) Every G-birational self-map  $X \rightarrow X$  is actually G-biregular.

Then  $X$  is called  $G$ -birationally superrigid.

One can then generalize the initial question as follows:

**Question** (Cheltsov-Kollár). Let G be a group and  $H \subseteq G$  be its subgroup. Assume that X is an H-birationally rigid H-Fano variety. Further, assume that  $X$  is  $G$ -Fano. Is  $X$  then -birationally rigid?

Informally speaking, the non-triviality of this question lies e.g. in the fact, that a priori X may admit only H-birational maps to Fano varieties X' with  $\text{rk Pic}(X')^H > 1$ , while enlarging the group to G forces  $Pic(X')^G$  to be of rank 1. The original Kollár's question addresses arithmetic  $G$ -varieties. The goal of this note is to answer its *geometric* counterpart in dimension 2 by positive:

**Theorem.** Let  $\bf{k}$  be an algebraically closed field of characteristic zero and  $\bf{G}$  be a finite group. Let  $S$  be a two-dimensional geometric  $G$ -Fano variety over  $k$ , i.e. a smooth del Pezzo surface on which G acts faithfully by automorphisms, so that  $Pic(S)^G \simeq \mathbb{Z}$ . Assume that  $H \subseteq G$  is a subgroup and S is an H-birationally rigid. Then S is G-birationally rigid.

At the moment, there are no known counter-examples to the Cheltsov-Kollár's question, neither in geometric nor in arithmetic setting, although it is highly possible such counterexample exists. On the other hand, the results [\[CS19\]](#page-24-3) of I. Cheltsov and C. Shramov imply that the answer to the Question is positive when  $X = \mathbb{P}_{\mathbb{C}}^3$ , see Section [2.D](#page-5-0) below. Note that an analogous question with rigidity replaced by *superrigidity* is easy to answer positively, i.e. one has the following

<span id="page-2-1"></span><span id="page-2-0"></span>**Proposition 1.4.** If X is H-birationally superrigid then X is G-birationally superrigid.

*Proof.* Recall [\[CS16,](#page-24-2) 3.3] that X is G-birationally superrigid if and only if for every  $G$ invariant mobile linear system  $\mathscr{M}_X$  on X the pair  $(X, \lambda \mathscr{M}_X)$  is canonical for  $\lambda \in \mathbb{Q}_{>0}$  such that

$$
\lambda \mathscr{M}_X \sim_{\mathbb{Q}} -K_X.
$$

Since a G-invariant linear system  $\mathcal{M}_X$  is also H-invariant, the result follows.  $\Box$ 

Remark 1.5. The analogue of Proposition [1.4](#page-2-0) holds when the notion of superrigidity is replaced with the one of *solidity*. Recall  $[AO18]$  that a G-Fano variety X is called G-solid if  $X$  is not G-birational to a G-Mori fibre space with positive dimensional base, i.e. only condition (1) of Definition [1.3](#page-1-0) is required, see [\[Cor00,](#page-24-5) [CS16,](#page-24-2) [CS19,](#page-24-3) [CS22\]](#page-24-6).

**Notation.** We denote by  $S_n$  the symmetric group on *n* letters and by  $A_n$  its alternating subgroup. Further,  $D_n$  denotes the dihedral group of order  $2n$  with presentation

$$
D_n = \langle r, s \colon r^n = s^2 = (sr)^2 = id \rangle,
$$

and  $C_n$  denotes the cyclic group of order n. We denote by  $V_4$  the Klein four-group, isomorphic to  $C_2 \times C_2$ . Finally,  $A_{\bullet}B$  denotes an extension of B by A, not necessarily split.

### 2. Sarkisov links on del Pezzo surfaces

2.A. **Geometric**  $G$ -surfaces. In what follows, all surfaces are assumed smooth, projective and defined over an algebraically closed field **k** of characteristic zero. Given a finite group  $G$ , a (geometric) G-surface is a triple  $(S, G, \iota)$ , where S is a surface over **k** and  $\iota : G \hookrightarrow \text{Aut}(S)$ is a faithful G-action. A G-morphism of G-surfaces  $(S_1, G, \iota_1) \rightarrow (S_2, G, \iota_2)$  is a morphism  $f: S_1 \longrightarrow S_2$  such that for each  $g \in G$  the following diagram commutes:

Similarly, one defines  $G$ -rational maps and  $G$ -birational maps. In what follows, we consider only rational  $G$ -surfaces equipped with a structure of  $G$ -Mori fiber space, i.e.  $G$ -del Pezzo surfaces and  $G$ -conic bundles, whose  $G$ -invariant Picard rank is 1 and 2, respectively.

<span id="page-3-1"></span>2.B. Sarkisov program. The proof of the main theorem will be based on explicit geometry of del Pezzo surfaces (for which we refer to [\[Dol12,](#page-25-7) Chapter 8]) and, most importantly, the Sarkisov program in dimension 2. We work in the category of (geometric)  $G$ -surfaces over k. Any  $G$ -birational map between two  $G$ -surfaces can be decomposed into a sequence of birational G-morphisms and their inverses. A birational G-morphism  $S \rightarrow T$  is a blow-up of a closed G-invariant 0-dimensional subscheme  $\mathfrak p$  of T. Recall that  $\deg(\mathfrak p) = h^0(\mathcal{O}_{\mathfrak p})$ . If  $\mathfrak p$  is reduced and consists of closed points  $y_1, \ldots, y_n$  with residue fields  $\kappa(y_i),$  then  $\deg \mathfrak{p} = \sum \deg y_i$ where deg  $y_i = [\kappa(y_i) : \mathbf{k}]$ . If **p** is G-invariant, then it is a union of G-orbits. A G-birational map  $\varphi$  between G-Mori fiber spaces  $\pi: S \longrightarrow B$  and  $\pi': S' \longrightarrow B'$  is a diagram of G-equivariant maps



Recall that in dimension 2, a rational G-Mori fiber space  $\pi: S \longrightarrow B$  is either a G-del Pezzo surface (if B is a point), or a G-conic bundle (if  $B = \mathbb{P}^1$ ). According to the equivariant version of Sarkisov program, every G-birational map  $\varphi: S \dashrightarrow S'$  of G-Mori fiber spaces is factorized into a composition of *elementary Sarkisov G-links* of four types. Their complete description was given by Iskovskikh in [\[Isk96,](#page-25-8) Theorem 2.6] in the arithmetic case (also see a recent exposition [\[LS21\]](#page-25-9) by Lamy and Schneider) and restated in [\[DI09a,](#page-25-10) Section 7] in the geometric case. The following claim will be used systematically throughout the paper and is an immediate consequence of the Sarkisov program:

**Proposition 2.1.** A del Pezzo surface  $S$  is  $G$ -birationally rigid if and only if for every Sarkisov G-link  $S \rightarrow S'$  the surfaces S and S' are G-equivariantly isomorphic.

2.C. Del Pezzo surfaces of degree less than eight. In what follows,  $S$  denotes a smooth del Pezzo surface over an algebraically closed field k of characteristic zero. Recall that  $K_S^2 \in \{1, 2, ..., 9\}$ . Let  $G \subseteq Aut(S)$  be a finite group and  $H \subsetneq G$  be its subgroup (we always stick to this notation in what follows). Assume that  $Pic(S)^H \simeq \mathbb{Z}$ , so in particular  $Pic(S)^G \simeq \mathbb{Z}$ . Note that the condition  $Pic(S)^H \simeq \mathbb{Z}$  immediately excludes two cases: first, when  $K_S^2 = 7$ , and second, when  $K_S^2 = 8$  and S is a blow up of  $\mathbb{P}^2$  in one point. Indeed, in both cases, there exists an  $H$ -invariant (−1)-curve on  $S$  which can be  $H$ -equivariantly contracted, so  $\text{rk Pic}(S)^{H} > 1$ .

<span id="page-3-0"></span>**Proposition 2.2.** Assume that  $K_S^2 \in \{1, 2, 3\}$  and  $Pic(S)^G \simeq \mathbb{Z}$ . Then S is G-birationally rigid.

Proof. This is essentially the content of the so-called Segre-Manin theorem (which follows from classification of Sarkisov links nowadays). If  $S \rightarrow S'$  is a G-birational map to another <span id="page-4-2"></span> $G$ -Mori fibre space  $S'$ , then it decomposes into  $G$ -equivariant Sarkisov links of type II and isomorphisms, and for any such link  $\chi: S \rightarrow S'$ , there exists a commutative diagram

where  $\eta$ ,  $\eta'$  are birational morphisms and S', T are del Pezzo surfaces as well. This immediately implies that S is even G-superrigid when  $K_S^2 = 1$ . If  $K_S^2 \in \{2,3\}$ , then up to automorphisms of  $S$ , any such link is a birational Bertini or Geiser involution, i.e. there exists a biregular involution  $\sigma \in Aut(T)$  and an automorphism  $\delta \in Aut(S)$  such that  $\chi = \eta' \circ \sigma \circ \eta^{-1} \circ \delta$ . Thus, in particular, we have  $S' \simeq S$ . Since  $\sigma$  centralizes G, we conclude that  $S'$  is  $G$ -equivariantly isomorphic to  $S$ .

Remark 2.4. In [\[dDM19\]](#page-24-7) M. Mauri and L. das Dores classify completely those del Pezzo surfaces of degree 2 and 3 which are  $G$ -birationally superrigid.

**Proposition 2.5.** Let  $K_S^2 = 4$ . Then S is G-birationally rigid if and only if there is no G-fixed points on S. In particular, if S is H-birationally rigid then it is G-birationally rigid as well.

*Proof.* By [\[DI09a,](#page-25-10) Propositions 7.12, 7.13], every Sarkisov G-link  $\chi$  starting from S is either of type I and leads to a cubic surface equipped with a structure of  $G$ -conic bundle, or is of type II. In the former case,  $\chi$  is centred at a G-point of degree 1, i.e. a G-fixed point on S. So, if such point exists,  $S$  is  $G$ -birational to a  $G$ -Mori fiber space over a curve and hence is not G-birationally rigid. Suppose there are no G-fixed points on  $S$ . Then by loc. cit., any Sarkisov G-link of type II starting from  $S$  is either a birational Bertini involution (centred at a point of degree 3), or a birational Geiser involution (centred at a point of degree 2). In both cases, it leads to a G-isomorphic surface  $S' \simeq S$ , as in the proof of Proposition [2.2.](#page-3-0) Thus, S is G-birationally rigid.  $\Box$ 

Before going to the next case, let us recall the following useful statement:

<span id="page-4-1"></span>**Lemma 2.6** ([\[BB73,](#page-24-8) Lemma 2.4]). Let X be an irreducible algebraic variety and  $G \subset$ Aut(X) be a finite group. If G fixes a point  $p \in X$  then there is a faithful linear representation  $G \hookrightarrow GL(T_pX).$ 

<span id="page-5-3"></span><span id="page-5-2"></span>Remark 2.7. Note that a cyclic group always has a fixed point on a rational variety over an algebraically closed field of characteristic zero. This follows from the holomorphic Lefschetz fixed-point formula.

We now proceed with del Pezzo surfaces of degree 5.

<span id="page-5-1"></span>**Lemma 2.8** ( $\overline{D109a}$ , Theorem 6.4). Let S be a del Pezzo surface of degree 5 and  $G \subset \text{Aut}(S)$ be a group such that  $Pic(S)^G \simeq \mathbb{Z}$ . Then G is isomorphic to one of the following five groups:

$$
S_5, A_5, AGL_1(\mathbb{F}_5), D_5, C_5.
$$

Here,  $AGL_1(\mathbb{F}_5)$  denotes the general affine group of degree one over  $\mathbb{F}_5$ , defined by the presentation  $\langle a, b \mid a^5 = b^4 = \text{id}, bab^{-1} = a^3 \rangle$ ; it has a structure of a semidirect product  $C_5 \rtimes C_4$ .

**Proposition 2.9.** Let  $K_S^2 = 5$ . If S is H-birationally rigid then it is G-birationally rigid.

*Proof.* We use Lemma [2.8.](#page-5-1) By  $[D109a,$  Propositions 7.12, 7.13], every Sarkisov G-link starting from S is of type II, i.e. it is a diagram [\(2.3\)](#page-4-0) where  $\eta$  blows up a G-point of degree d, and one of the following holds:

- (1)  $S \simeq S'$ ,  $d = 4$ ,  $\chi$  is a birational Bertini involution;
- (2)  $S \simeq S'$ ,  $d = 3$ ,  $\chi$  is a birational Geiser involution;
- (3)  $S' \simeq \mathbb{P}^1 \times \mathbb{P}^1, d = 2;$

(4) 
$$
S' \simeq \mathbb{P}^2, d = 1.
$$

Recall that  $A_5$  (and hence  $S_5$ ) has no faithful representations of degree 2. Therefore, neither  $A_5$  nor  $S_5$  can have an orbit of size 1 or 2 on S by Lemma [2.6.](#page-4-1) Further,  $S_5$  and  $A_5$  have no subgroups of index 3 or 4, hence there are no equivariant birational Bertini or Geiser involutions for these groups. We conclude that S is G-birationally superrigid for  $G \in \{A_5, S_5\}.$ 

So, it remains to verify the statement for the following pairs  $(G, H)$ :

$$
(C_5 \rtimes C_4, D_5), (C_5 \rtimes C_4, C_5), (D_5, C_5).
$$

Note that S is never H-birationally rigid for  $H \in \{C_5, D_5\}$ . Indeed, it is easy to show (using a holomorphic Lefschetz fixed point formula, as was mentioned in Remark [2.7\)](#page-5-2), that  $C_5$  has exactly two fixed points on S and these points do not lie on  $(-1)$ -curves, see e.g. [\[Yas16,](#page-26-2) Lemma 4.16]. Therefore, there is a Sarkisov link (4) from above, which leads to  $\mathbb{P}^2$ . Furthermore, these two fixed points form an orbit under the action of the dihedral group  $D_5$ , containing  $C_5$ . So, there is an equivariant link (3) leading to  $\mathbb{P}^1 \times \mathbb{P}^1$ . □

<span id="page-5-0"></span>2.D. The projective plane, the projective space of dimension 3, and the "mixed" arithmetico-geometric case. Let us treat the del Pezzo surface of degree 9, i.e. the

<span id="page-6-2"></span>projective plane  $S = \mathbb{P}^2$ . We stick to the following classical (although perhaps outdated) terminology:

<span id="page-6-0"></span>**Definition 2.10** ([\[Bli17\]](#page-24-9)). We call a subgroup  $\iota : G \hookrightarrow GL_n(\mathbb{C})$  intransitive if the representation  $\iota$  is reducible, and *transitive* otherwise. Further, a transitive group  $G$  is called *imprimitive* if there is a decomposition  $\mathbb{C}^n = \bigoplus_{i=1}^m V_i$  into a direct sum of subspaces and G transitively acts on the set  ${V_i}$ . A transitive group G is called *primitive* if there is no such decomposition. Finally, we say that  $G \subset \text{PGL}_n(\mathbb{C})$  is (in)transitive or (im)primitive if its lift to  $GL_n(\mathbb{C})$  is such a group.

The following is due to D. Sakovics:

<span id="page-6-1"></span>**Theorem 2.11** ([\[Sak19,](#page-25-11) Theorem 1.3]). The projective plane  $\mathbb{P}^2$  is G-birationally rigid if and only if  $G$  is transitive and  $G$  is not isomorphic to  $A_4$  or  $S_4$ .

Corollary 2.12. If  $\mathbb{P}^2$  is H-birationally rigid then it is G-birationally rigid as well.

*Proof.* Indeed, G is transitive, since H is. Assume that  $G \simeq A_4$  or  $G \simeq S_4$ . If  $H \neq A_4$  then it must be one of the following groups:  $C_2$ ,  $C_3$ ,  $C_4$ ,  $C_2 \times C_2$ ,  $S_3$ ,  $D_4$ . But the irreducible representaions of these groups are of degrees 1 or 2, hence they fix a point on  $\mathbb{P}^2$  and are not transitive, a contradiction. □

Inspired by Blichfeldt's classification [\[Bli17\]](#page-24-9) of finite subgroups of  $PGL_4(\mathbb{C})$ , I. Cheltsov and C. Shramov managed to describe all the cases, in which  $\mathbb{P}_{\mathbb{C}}^3$  is G-birationally rigid:

**Theorem 2.13** ([\[CS19,](#page-24-3) Theorem 1.1]). The 3-dimensional complex projective space  $\mathbb{P}^3$  is  $G$ -birationally rigid if and only if  $G$  is primitive and not isomorphic to  $A_5$  and  $S_5$ .

This immediately implies a positive answer to Cheltsov-Kollár's question for  $X = \mathbb{P}^3$ :

**Corollary 2.14.** Let G be a finite group and  $H \subset G$  be its subgroup. If  $\mathbb{P}^3$  is H-birationally rigid then  $\mathbb{P}^3$  is *G*-birationally rigid.

*Proof.* Recall (see Definition [2.10\)](#page-6-0) that finite subgroups of  $Aut(\mathbb{P}^3) \simeq \text{PGL}_4(\mathbb{C})$  are either transitive (i.e. do not fix any point and do not leave any line invariant) or intransitive. Transitive groups are either imprimitive (i.e. leave a union of two skew lines invariant or have an orbit of length 4), or primitive.

Now, if  $\mathbb{P}^3$  is *H*-birationally rigid then *H* is transitive, and hence *G* is transitive as well. Clearly, if G leaves a union of two skew lines invariant, then the same is true for  $H$ . If G has an orbit of length 4 and  $H$  has no orbit of length 4, then  $H$  either fixes a point, or permutes two points in  $\mathbb{P}^3$  and hence has an invariant line. Both cases are not possible, as H is transitive. So, G is primitive. It remains to notice that G is not isomorphic to  $A_5$  or  $S_5$ , as all proper subgroups of  $S_5$ , not isomorphic to  $A_5$ , are not primitive, see e.g. [\[CS19,](#page-24-3) Appendix].  $\square$  <span id="page-7-4"></span><span id="page-7-0"></span>**Remark 2.15.** Suppose we are in the "mixed" setting of Remark [1.1.](#page-0-0) Let  $p \equiv 1 \pmod{1}$ 3) be a prime number, fix a non-trivial homomorphism  $C_3 \longrightarrow Aut(C_p)$  and consider the corresponding semidirect product  $G = C_p \rtimes C_3$ . By the result of C. Shramov [\[Shr21,](#page-25-12) Theorem 1.3(ii)], there exists a field  $\bf{k}$  (of characteristic zero) and a non-trivial Severi-Brauer surface S over k, such that  $G \hookrightarrow \text{Aut}(S)$ . Any Sarkisov G-link  $\chi: S \dashrightarrow S'$  centred at a point of degree 3 leads to the *opposite* Severi-Brauer surface  $S' = S^{op}$ ; if S corresponds to a central simple **k**-algebra A then, by definition,  $S^{\text{op}}$  is the unique Severi-Brauer surface corresponding to  $A^{\text{op}}$ , the inverse of A in the Brauer group  $Br(k)$ . Since  $S^{op}$  is never isomorphic to S, we conclude that  $S$  is not G-birationally rigid. However, passing to the algebraic closure of  $k$ , one has  $S_{\overline{k}} \simeq {\mathbb P}^2_{\overline{k}}$  $\frac{2}{k}$  which is *G*-birationally rigid by Sakovics' theorem [2.11.](#page-6-1) For more recent results on birational and biregualr self-maps of Severi-Brauer surfaces see [\[Shr20,](#page-25-13) [Tre21,](#page-25-14) [BSY22\]](#page-24-10).

### 3. Del Pezzo surfaces of degree 6

<span id="page-7-3"></span>Let S be a del Pezzo surface of degree  $K_S^2 = 6$ . Recall that S is a blow up of  $\mathbb{P}^2$  in three noncollinear points  $p_1, p_2, p_3$ , which we may assume to be  $[1:0:0]$ ,  $[0:1:0]$  and  $[0:0:1]$ , respectively. The set of  $(-1)$ -curves on S consists of six curves: the exceptional divisors of blow-up  $e_i = \pi^{-1}(p_i)$  and the strict transforms of the lines  $d_{ij}$  passing through  $p_i$ ,  $p_j$ . In the anticanonical embedding  $S \hookrightarrow \mathbb{P}^6$  these exceptional curves form a "regular hexagon"  $\Sigma$ . This yields a homomomorphism to the symmetry group of this hexagon

$$
\rho: \text{Aut}(S) \longrightarrow \text{Aut}(\Sigma) \simeq D_6 = \langle r, s : r^6 = s^2 = 1, srs^{-1} = r^{-1} \rangle,
$$

where r is a counter clockwise rotation by  $\pi/3$  and s is a reflection, shown on Figure [1.](#page-8-0) The surface  $S$  can be given as

$$
\{([x_0:x_1:x_2],[y_0:y_1:y_2]) \in \mathbb{P}^2 \times \mathbb{P}^2 : x_0y_0 = x_1y_1 = x_2y_2\},\tag{3.1}
$$

The projection to the first factor  $\mathbb{P}^2$  is the blow down of three lines  $\{x_1 = x_2 = 0\}$ ,  $\{x_0 =$  $x_2 = 0$ } and  $\{x_0 = x_1 = 0\}$  onto  $p_1, p_2$  and  $p_3$ , respectively, while the projection to the second factor is the blow down of  $\{y_1 = y_2 = 0\}$ ,  $\{y_0 = y_2 = 0\}$  and  $\{y_0 = y_1 = 0\}$ .

The kernel of  $\rho$  is the maximal torus T of PGL<sub>3</sub>(**k**), isomorphic to  $(\mathbf{k}^*)^3/\mathbf{k}^* \simeq (\mathbf{k}^*)^2$  and acting on  $S$  by

$$
(\lambda_0, \lambda_1, \lambda_2) \cdot ([x_0 : x_1 : x_2], [y_0 : y_1 : y_2]) = ([\lambda_0 x_0 : \lambda_1 x_1 : \lambda_2 x_2], [\lambda_0^{-1} y_0 : \lambda_1^{-1} y_1 : \lambda_2^{-1} y_2]) \tag{3.2}
$$

Moreover, the action of T on  $S \setminus \Sigma$  is faithful and transitive. The automorphism group of  $Aut(S)$  fits into the short exact sequence

$$
1 \longrightarrow (\mathbf{k}^*)^2 \longrightarrow \text{Aut}(S) \stackrel{\rho}{\longrightarrow} D_6 \longrightarrow 1.
$$

with  $\rho(\text{Aut}(S)) \simeq D_6 \simeq S_3 \times C_2$ , where  $C_2$  acts by

([x_0:x_1:x_2],[y_0:y_1:y_2])\mapsto ([y_0:y_1:y_2],[x_0:x_1:x_2])
$$
\n(3.3)

and S<sub>3</sub> acts naturally by permutations on each of the two triples  $x_0, x_1, x_2$  and  $y_0, y_1, y_2$ . In what follows, we will denote

$$
\theta \colon ([x_0 : x_1 : x_2], [y_0 : y_1 : y_2]) \mapsto ([x_1 : x_2 : x_0], [y_1 : y_2 : y_0]). \tag{3.4}
$$

<span id="page-8-2"></span>**Lemma 3.5.** Let S be a del Pezzo surface of degree 6 and  $G \subset Aut(S)$  be a finite group such that  $Pic(S)^G \simeq \mathbb{Z}$ . If G fixes a point on S then  $G \cap T = id$ .

*Proof.* Assume  $G \cap T \neq id$ . Note that T can be identified with a subgroup of  $PGL_3(k)$ which fixes 3 points  $p_1$ ,  $p_2$  and  $p_3$ . In particular, an element  $t \in T$  fixing a point on  $S \setminus \Sigma$ is necessarily trivial (of course, one can also deduce that from the explicit action of  $T$  given above). Therefore, a fixed point  $p \in S$  of G lies on  $\Sigma$ . Note that it must be the intersection of two sides of  $\Sigma$ , as otherwise we have a G-invariant (-1)-curve contradicting the minimality condition  $Pic(S)^G \simeq \mathbb{Z}$ . Similarly, if  $p = \ell_1 \cap \ell_2$ , where  $\ell_1$ ,  $\ell_2$  are some sides of  $\Sigma$ , then either G preserves both  $\ell_i$  and hence  $\text{rk Pic}(S)^G > 1$ , or G switches  $\ell_1$  and  $\ell_2$ . Denoting  $\ell'_1$  and  $\ell'_2$ the other two sides which intersect  $\ell_1$  and  $\ell_2$ , respectively, we easily see that  $\ell'_1$  and  $\ell'_2$  form a G-orbit of non-intersecting  $(-1)$ -curves, hence rk Pic $(S)^G > 1$ .

The following elementary group-theoretic fact will be used several times below, we state it only for the reader's convenience.

<span id="page-8-1"></span>**Lemma 3.6.** Subgroups of the dihedral group  $D_n = \langle r, s : r^n = s^2 = (sr)^2 = id \rangle$  are the following:

Cyclic:  $\langle r^d \rangle \simeq C_{n/d}$ , and  $\langle r^k s \rangle$ , where d divides n and  $0 \leq k \leq n-1$ .

<span id="page-9-2"></span>Dihedral:  $\langle r^d, r^k s \rangle \simeq D_{n/d}$ , where  $d < n$  divides n, and  $0 \leq k \leq d - 1$ .

Moreover, all cyclic subgroups  $\langle r^d \rangle$  are normal, one has  $D_n/\langle r^d \rangle \simeq D_d$ , and these are all normal subgroups when  $n$  is odd. When  $n$  is even, there are two more normal dihedral subgroups of index 2, namely  $\langle r^2, s \rangle$  and  $\langle r^2, rs \rangle$ .

<span id="page-9-1"></span>**Lemma 3.7.** Let S be a del Pezzo surface of degree 6. If  $Pic(S)^G \simeq \mathbb{Z}$  then G is of the form

$$
N_{\bullet}\langle r\rangle \simeq N_{\bullet}C_6
$$
,  $N_{\bullet}\langle r^2, s\rangle \simeq N_{\bullet}S_3$ , or  $N_{\bullet}\langle r, s\rangle \simeq N_{\bullet}D_6$ ,

where  $N \simeq C_n \times C_m$  is a subgroup of Ker  $\rho \simeq (\mathbf{k}^*)^2$ . In particular, if G fixes a point on S then it is one of the following subgroups of  $\text{Im}\rho = \text{Aut}(\Sigma)$ : C<sub>6</sub>, S<sub>3</sub> or D<sub>6</sub>.

*Proof.* Let  $G \subset \text{Aut}(S)$  be a finite group. Assume that  $\rho(G)$  is cyclic. In all the cases, described in Lemma [3.6,](#page-8-1) except  $\rho(G) = \langle r \rangle$ , we clearly have a G-orbit of pairwise nonintersecting sides of the hexagon, which correspond to  $(-1)$ -curves. Hence rk Pic $(S)^G > 1$ .

Let  $\rho(G)$  be dihedral, i.e.  $\langle r, s \rangle$ ,  $\langle r^2, s \rangle$ ,  $\langle r^2, rs \rangle$ ,  $\langle r^3, s \rangle$ ,  $\langle r^3, rs \rangle$ ,  $\langle r^3, r^2s \rangle$ . In the last three cases, one can always find a  $G$ -orbit of 2 disjoint  $(-1)$ -curves (a pair of opposite sides of the hexagon). Similarly, if  $\rho(G) = \langle r^2, rs \rangle$  then we have a G-orbit consisting of pairwise non-intersecting three  $(-1)$ -curves. In the first two cases, one has Pic $(S)^G \simeq \mathbb{Z}$ . Finally, the claim about fixed points follows from Lemma [3.5.](#page-8-2)  $\Box$ 

**Remark 3.8.** Note that, although  $D_6 = \langle r, s \rangle$  contains two groups isomorphic to  $S_3$ , only one of them gives *G*-equivariant Picard number 1, namely  $\langle r^2, s \rangle$ , which we denote  $S_3^{\min}$ . The group  $\langle r^2, rs \rangle$  will be denoted  $S_3^{\text{min}}$ .

By  $[Isk96, Theorem 2.6]$  every Sarkisov link starting from S is of type II and is repre-sented by the diagram [\(2.3\)](#page-4-0), where  $\eta$  blows up a point of degree d and one of the following holds:

- (1)  $S \simeq S'$ ,  $d = 5$ ,  $\chi$  is a birational Bertini involution;
- (2)  $S \simeq S'$ ,  $d = 4$ ,  $\chi$  is a birational Geiser involution;
- (3)  $d = 3, K_{S'}^2 = 6;$
- (4)  $d = 2, K_{S'}^2 = 6;$
- (5)  $d = 1, S' \simeq \mathbb{P}^1 \times \mathbb{P}^1$ .

Let us emphasize that in the cases (3) and (4) the surfaces  $S'$  does not have to be  $G$ -isomorphic<sup>[1](#page-9-0)</sup> to  $S$ , as the following example shows. I am grateful to Andrey Trepalin for pointing this out.

<span id="page-9-0"></span><sup>&</sup>lt;sup>1</sup>Therefore, the user should be careful when using the statement of  $[DI09a,$  Proposition 7.13], which is a bit misleading, in our opinion. For example, in the case of del Pezzo surfaces of degree 6 and links at points of degrees 3 and 2, the authors write  $S' \simeq S$ , which might create an impression that this is an isomorphism in the category of  $G$ -surfaces; compare with the case of del Pezzo surfaces of degree  $8$  and points of degree  $4$ , where it is not written that  $S' \simeq S$ .

<span id="page-10-0"></span>**Example 3.9.** Let  $\omega$  be a primitive 3rd root of unity and consider the finite subgroup  $G \subset Bir(\mathbb{P}^2_{\mathbf{k}})$  generated by the following 3 elements:

$$
\alpha\colon [x:y:z]\longmapsto [x:\omega y:\omega^2 z], \quad \beta\colon [x:y:z]\longmapsto [y:z:x], \quad \gamma\colon [x:y:z]\longmapsto [yz:xz:xy].
$$

One has

$$
G = \langle \alpha, \beta, \gamma \mid \alpha^3 = \beta^3 = \gamma^2 = id, \ \alpha\beta = \beta\alpha, \ \beta\gamma = \gamma\beta, \ \gamma\alpha\gamma = \alpha^{-1}\rangle \simeq (C_3 \times C_3) \rtimes C_2,
$$

where the copies of  $C_3$  are generated by  $\alpha$  and  $\beta$ , and  $C_2$  is generated by the Cremona involution  $\gamma$  and acts on  $C_3 \times C_3$  by coordinate exchange (wreath product). The group G is regularized on a del Pezzo surface S of degree 6 given by the equation  $(3.1)$ , which we identify with the blow-up of  $\mathbb{P}^2$  in  $p_1 = [1 : 0 : 0], p_2 = [0 : 1 : 0]$  and  $p_3 = [0 : 0 : 1].$  The homomorphism  $\rho: \text{Aut}(S) \longrightarrow D_6$  induces a short exact sequence

$$
1 \longrightarrow \langle \alpha \rangle \longrightarrow G \longrightarrow \langle \beta, \gamma \rangle \longrightarrow 1, \tag{3.10}
$$

where  $\beta$  acts by permutation of coordinates in each pair  $x_0, x_1, x_2$  and  $y_0, y_1, y_2$ , the involution  $\gamma$  acts as in [\(3.3\)](#page-8-3) and  $\alpha$  acts as in [\(3.2\)](#page-7-2). In particular,  $\rho(G) \simeq C_6$ . Consider the lift of the three points  $p_4 = [1 : 1 : 1], p_5 = [1 : \omega : \omega^2]$  and  $p_6 = [1 : \omega^2 : \omega]$  on S. They form a G-orbit in general position on S. A Sarkisov link  $(2.3)$  centred at these points leads to a del Pezzo surface S' of degree 6. Let us denote by  $L_{ij}$  the strict transforms on the cubic surface T of the lines on  $\mathbb{P}^2$  passing through  $p_i$  and  $p_j$ . Similarly,  $Q_{ijklr}$  will denote the strict transform of the conic passing through  $p_i, p_j, p_k, p_l, p_r$ . Then the morphism  $\eta'$  blows down  $Q_{12456}$ ,  $Q_{23456}$  and  $Q_{13456}$ . The hexagon of (-1)-curves on S' consists of the  $\eta'$ -images of  $L_{45}$ ,  $L_{46}$ ,  $L_{56}$ ,  $Q_{12346}$ ,  $Q_{12345}$  and  $Q_{12356}$ . Hence the homomorphism  $\rho'$ : Aut $(S') \rightarrow D_6$  induces a short exact sequence

$$
1 \longrightarrow \langle \beta \rangle \longrightarrow G \longrightarrow \langle \alpha, \gamma \rangle \longrightarrow 1. \tag{3.11}
$$

In particular,  $\rho'(G) \simeq S_3$ . But this clearly implies that S and S' cannot be G-isomorphic.

So, one has to pay a special attention to Sarkisov links centred at points of degree 3 and 2. The next proposition shows that an extra-condition of being  $H$ -isomorphic eliminates the phenomena described in Example [3.9.](#page-10-0)

<span id="page-10-1"></span>**Proposition 3.12.** Let  $S_1$  be a del Pezzo surface of degree 6 and  $\chi: S_1 \rightarrow S_2$  be a Sarkisov H-link of type II, centred at an H-point of degree d, where  $d \in \{2,3\}$ . Let  $G \supset H$  be another group and assume there is a G-link at the same point. If  $S_2$  is H-isomorphic to  $S_1$ , then it is also  $G$ -isomorphic to  $S_1$ .

*Proof.* We denote by  $G_1 = \iota_1(G)$  and  $H_1 = \iota_1(H)$  the embeddings of G and H into Aut $(S_1)$ , and by  $G_2 = \iota_2(G)$  and  $H_2 = \iota_2(H)$  the embeddings of G and H into Aut(S<sub>2</sub>) induced by the map  $\chi$ . For each  $i \in \{1,2\}$ , we denote by  $\rho_i$ :  $\mathrm{Aut}(S_i) \to \mathrm{Aut}(\Sigma_i) \simeq \mathrm{D}_6$  the homomorphisms

described above with  $T_i = \ker \rho_i$ ; further, set  $G_{i,T} = G_i \cap T_i$ ,  $H_{i,T} = H_i \cap T_i$ ,  $G_i = \rho_i(G_i)$  and  $H_i = \rho_i(H_i)$ . We have  $H_{i,T} \subset G_{i,T}$ ,  $H_i \subset G_i$  for each  $i \in \{1,2\}$ . Since each  $S_i$  is H-del Pezzo, by Lemma [3.7](#page-9-1) the pair  $(H_i, G_i)$  must be one of the following:  $(C_6, C_6)$ ,  $(S_3, S_3)$ ,  $(D_6, D_6)$ ,  $(C_6, D_6)$ ,  $(S_3, D_6)$ . Furthermore, since  $S_i$  admits an  $H_i$ -orbit of degree d (which is also a  $G_i$ -orbit), both  $H_i$  and  $G_i$  have index d subgroups which fix a point in general position on  $S_i$ , and thus do not intersect  $H_{i,T}$  and  $G_{i,T}$ , respectively. Therefore,  $H_{i,T}$  and  $G_{i,T}$  are either trivial or of order  $d$ , i.e. for each  $i$  we have the following possibilities:

- (1)  $H_i \, T = G_i \, T = id;$
- (2)  $H_{iT} = \mathrm{id} \subset G_{iT} \simeq C_d$ .
- (3)  $H_{iT} = G_{iT} \simeq C_d$ .

Suppose we are in case (1), then  $(H_1, G_1) = (\widehat{H}_1, \widehat{G}_1)$  and the statement is tautological when  $\hat{H}_1 = \hat{G}_1$ . If  $\hat{H}_1 \neq \hat{G}_1$  then  $G_1 = \hat{G}_1 = \rho_1(\text{Aut}(S_1)) = D_6$ . Since  $G_1 \simeq G_2$ , we must have  $G_2 = \rho_2(\text{Aut}(S_2)) = D_6$ . Indeed, otherwise  $G_{2,T} = G_2 \cap T_2 \neq \text{id}$  and thus  $G_{2,T} \simeq C_d$ . But then  $\hat{G}_2 \simeq C_2 \times C_2$  (if  $d = 3$ ) or  $\hat{G}_2 \simeq S_3$  (if  $d = 2$ ). In the former case  $S_2$  is not G-del Pezzo, while in the latter  $G_{2,T} \simeq C_2$  is necessarily the centre of  $G_2 \simeq C_2 \times S_3$ , which is not possible, as an involution from  $T_2$  cannot commute with the automorphism  $\theta$ , given by [\(3.4\)](#page-8-4). Now, having  $G_1 = \rho_1(\text{Aut}(S_1))$  and  $G_2 = \rho_2(\text{Aut}(S_2))$ , any isomorphism  $S_1 \stackrel{\sim}{\to} S_2$  (recall that there is single isomorphism class of del Pezzo surfaces of degree 6), possibly composed with an automorphism of  $S_2$ , is G-equivariant.

So, in what follows we assume  $G_{1,T} \simeq C_d$ . This implies  $G_{2,T} \simeq C_d$ . Indeed, otherwise  $G_{2,T} = id$ , hence  $G_1 \simeq G_2 = \hat{G}_2 \in \{C_6, S_3, D_6\}$ . If  $d = 3$ , then  $\hat{G}_1 \in \{C_2, C_2^2\}$  and thus  $S_1$  is not G-del Pezzo. If  $d = 2$ , then  $\hat{G}_1 \simeq C_3$  or  $G_{1,T} \simeq C_2$  is the centre of  $G_1 \simeq C_2 \times S_3$ ; in the first case,  $S_1$  is not G-del Pezzo, while the second case is impossible, as was noticed before.

Let  $\alpha: S_1 \longrightarrow S_2$  be an H-isomorphism from the statement; it maps  $T_1 = S_1 \setminus \Sigma_1$ isomorphically onto  $T_2 = S_2 \setminus \Sigma_2$  and induces isomorphisms  $H_{1,T} \simeq H_{2,T}$  and  $\widehat{H}_1 \simeq \widehat{H}_2$ . Define  $G_2' = \alpha \circ G_1 \circ \alpha^{-1} \subset \text{Aut}(S_2)$ . We claim that  $G_2' = \gamma^{-1} \circ G_2 \circ \gamma$  for some  $\gamma \in \text{Aut}(S_2)$ . This will finish the proof, as the surfaces  $S_1$  and  $S_2$  are then G-isomorphic via the map  $\gamma \circ \alpha$ .

Set  $\hat{G}'_2 = \rho_2(G'_2)$ ,  $G'_{2,T} = G'_2 \cap T_2$ . Firstly, note that  $\hat{G}_2 = \hat{G}'_2$ . Since  $\hat{G}'_2 \simeq \hat{G}_1$  and there is only one subgroup of  $D_6$ , in each isomorphism class, for which  $S_2$  is G-del Pezzo, it is enough to show that  $\hat{G}_2 \simeq \hat{G}_1$ . Both are subgroups of D<sub>6</sub> of same order, as  $G_1 \simeq G_2$  and  $G_{1,T} \simeq G_{2,T}$ , hence it remains to see that one cannot have  $\hat{G}_1 \simeq C_6$  and  $\hat{G}_2 \simeq S_3$  (or vice versa); but this is implied by  $H_1 \simeq H_2$ .

Secondly, we claim that  $G_{2,T} = G'_{2,T}$ . As always, we assume that  $S_2$  is given by the equation [\(3.1\)](#page-7-1), the group  $\rho_2(Aut(S_2))$  is isomorphic to  $S_3 \times C_2$ , where  $S_3$  acts by permutations in each triple of coordinates  $x_0, x_1, x_2$  and  $y_0, y_1, y_2$  (so there is an element  $\theta$  of the form [\(3.4\)](#page-8-4)) and C<sub>2</sub> acts as in [\(3.3\)](#page-8-3). Further, S<sub>3</sub> acts on the torus  $T_2 \simeq (\mathbf{k}^*)^3/\mathbf{k}^*$  by permuting the coordinates, and the action of  $C_2$  is the inversion; we denote this action of  $D_6$  on  $T_2$  by  $\varphi$ . The groups  $\widehat{G}'_2$  and  $\widehat{G}_2$ , being both  $S_3^{\min}$ ,  $C_6$  or  $D_6$ , contain  $\theta$ . Let  $\tau = (t, id) \in T_2 \rtimes \rho_2(\text{Aut}(S_2))$ be an element of order  $d \in \{2,3\}$  which generates  $G_{2,T}$  (or  $G'_{2,T}$ ), and  $(u, \theta)$  be an element of  $G_2$  (respectively, of  $G'_2$ ) which is mapped to (id,  $\theta$ ) by  $\rho_2$ . Then  $(u, \theta)^{-1} = (\varphi_{\theta^{-1}}(u^{-1}), \theta^{-1})$ . Therefore,  $(\varphi_{\theta^{-1}}(u^{-1}), \theta^{-1})(t, id)(u, \theta) = (\varphi_{\theta^{-1}}(u^{-1}tu), 1) = (\varphi_{\theta^{-1}}(t), 1)$  is a power of  $\tau =$  $(t, id)$ . If  $t = [(1, a, b)] \in T_2 \simeq (\mathbf{k}^*)^3 / \mathbf{k}^*$ , we must have  $[(a, b, 1)] = [(1, a, b)]$  or  $[(a, b, 1)] =$  $[(1, a^2, b^2)]$ , where a and b are primitive d-th roots of unity. This implies that  $d = 3$  and  $\tau = ([(1, \omega, \omega^2)],$  id) or  $\tau = ([(1, \omega^2, \omega)],$  id), which both generate the same subgroup of  $T_2$ .

Finally, let us show that  $G'_2$  is conjugate to  $G_2$ . Let  $\varrho = \iota \circ \theta$  be a generator of the cyclic subgroup of order 6 in  $\rho_2(\text{Aut}(S_2)) \simeq D_6$ , where  $\iota$  is the lift of the standard Cremona involution [\(3.3\)](#page-8-3). Further, let  $\sigma$  be the reflection

$$
\sigma \colon ([x_0:x_1:x_2],[y_0:y_1:y_2]) \longmapsto ([y_0:y_2:y_1],[x_0:x_2:x_1]),
$$

shown on Figure [1,](#page-8-0) so that  $\sigma$  and  $\varrho$  generate  $D_6$ ; note that  $\theta$  and  $\sigma$  generate  $S_3^{\text{min}}$ . We claim that every subgroup  $\Gamma \subset \text{Aut}(S_2)$  which fits into the short exact sequence

$$
1 \longrightarrow \langle \tau \rangle \longrightarrow \Gamma \longrightarrow \rho_2(\mathrm{Aut}(S_2)) = \langle \varrho, \sigma \rangle \longrightarrow 1
$$

is actually conjugate in Aut( $S_2$ ) to the subgroup  $\Gamma_0 \subset \text{Aut}(S_2)$  generated by  $\tau$ ,  $\rho$  and  $\sigma$ .

Indeed, let  $\overline{\varrho} \in \Gamma$  and  $\overline{\sigma} \in \Gamma$  be such that  $\rho_2(\overline{\varrho}) = \varrho$  and  $\rho_2(\overline{\sigma}) = \sigma$ . Then  $\Gamma$  is generated by  $\tau$ ,  $\overline{\varrho}$  and  $\overline{\sigma}$ . The map  $\overline{\varrho}$  is given by

$$
\overline{\varrho} \colon ([x_0 : x_1 : x_2], [y_0 : y_1 : y_2]) \mapsto ([ay_1 : by_2 : y_0], [a^{-1}x_1 : b^{-1}x_2 : x_0]) \tag{3.13}
$$

for some  $a, b \in \mathbf{k}^*$ . The map

$$
\beta \colon ([x_0:x_1:x_2],[y_0:y_1:y_2]) \mapsto ([x_0:b^{-1}x_1:ab^{-1}x_2],[y_0:by_1,ba^{-1}y_2])
$$

commutes with  $\tau = (t, id)$  and satisfies  $\beta \circ \overline{\varrho} \circ \beta^{-1} = \varrho$ . Let  $\widetilde{\varrho} = \beta \circ \overline{\varrho} \circ \beta^{-1} = \varrho$ ,  $\widetilde{\sigma} = \beta \circ \overline{\sigma} \circ \beta^{-1}$ . Then  $\tau$ ,  $\tilde{\varrho}$ ,  $\tilde{\sigma}$  generate the group  $\beta \circ \Gamma \circ \beta^{-1}$ . Since  $\beta \in \ker \rho_2 = T_2$ , we have  $\rho_2(\tilde{\sigma}) = \sigma$  and thus

$$
\widetilde{\sigma} = \sigma \circ \mu : ([x_0 : x_1 : x_2], [y_0 : y_1 : y_2]) \mapsto ([y_0 : b^{-1}y_2 : a^{-1}y_1], [x_0 : bx_2 : ax_1]) \tag{3.14}
$$

for some  $\mu = [(1, a, b)] \in T_2$ . Therefore

$$
\widetilde{\sigma}^2 \colon ([x_0:x_1:x_2],[y_0:y_1:y_2]) \mapsto ([x_0:ab^{-1}x_1:a^{-1}bx_2],[y_0:a^{-1}by_1:ab^{-1}y_2])
$$

is a power of  $([ (1, \omega, \omega^2) ], id);$  hence  $a = b\omega^i$ ,  $i \in \{0, 1, 2\}$ . Since  $(\sigma \circ \varrho)^2 = id$ , we have that

$$
(\widetilde{\sigma} \circ \widetilde{\varrho})^2 \colon ([x_0 : x_1 : x_2], [y_0 : y_1 : y_2]) \mapsto ([b^{-1}x_0 : b^{-1}x_1 : a^{-2}x_2], [by_0 : by_1 : a^2y_2])
$$

is a power of  $\tau = ([(1, \omega, \omega^2)], \mathrm{id})$ , hence  $b = a^2$ . Since  $a = b\omega^i$ , we conclude that  $\mu = \tau^k$ for some  $k \in \{0, 1, 2\}$ , i.e.  $\tilde{\sigma} = \sigma \circ \tau^k$ . Therefore,  $\beta \circ \Gamma \circ \beta^{-1} = \langle \tau, \varrho, \sigma \circ \tau^k \rangle = \Gamma_0$ , as was

<span id="page-13-0"></span>claimed. This shows that  $G_2$  and  $G'_2$  are conjugate (to  $\Gamma_0$ ) when  $\hat{G}_2 = \hat{G}'_2 = D_6$ . It remains to consider index 2 subgroups of  $\Gamma_0$ .

Note that  $\sigma^2 = \tau^3 = \varrho^6 = id$ ,  $\sigma \circ \varrho \circ \sigma = \varrho^{-1}$ ,  $\tau \circ \varrho \circ \tau = \varrho$ ,  $\sigma \circ \tau = \tau \circ \sigma$ , hence  $\Gamma_0 \simeq \langle \tau \rangle \rtimes_{\psi} \langle \varrho, \sigma \rangle$ , where  $\psi : \langle \varrho, \sigma \rangle \longrightarrow \text{Aut}(\langle \tau \rangle)$  is trivial on the subgroup  $\langle \varrho^2, \sigma \rangle \simeq S_3^{\text{min}}$  and  $\psi(\varrho)$  sends  $\tau$  to  $\tau^{-1}$ . Furthermore,  $\Gamma_0 \simeq \langle \theta, \sigma \rangle \times \langle \tau, \iota \rangle \simeq S_3^{\min} \times S_3$ . Let  $\Delta_0 \subset \Gamma_0$  be a subgroup of index 2. Then  $\Delta_0$  contains  $\langle \theta \rangle \times \langle \tau \rangle$  as a Hall subgroup and by the Schur–Zassenhaus theorem  $\Delta_0 = (\langle \theta \rangle \times \langle \tau \rangle) \rtimes_{\varphi} \langle \delta \rangle$ , where  $\delta = {\iota, \sigma, \iota \circ \sigma}$ . In the first two cases,  $\Delta_0$  is either  $\Delta'_0 = \langle \theta \rangle \times \langle \tau, \iota \rangle$  or  $\Delta''_0 = \langle \tau \rangle \times \langle \theta, \sigma \rangle$ , respectively, and in both cases the action  $\varphi: C_2 \longrightarrow \text{Aut}(C_3 \times C_3)$  is the coordinate exchange (i.e.  $\Delta_0$  is the wreath product  $C_3 \wr C_2$ ). In the third case  $\delta = \iota \circ \sigma$ , the action of  $\varphi$  is by inversion; we denote this group by  $\Delta_0''$ . Note that  $\rho_2(\Delta'_0) = \langle \theta \circ \iota \rangle \simeq C_6$ ,  $\rho_2(\Delta''_0) = S_3^{\min}$ , while  $\rho_2(\Delta'''_0) = \langle \theta, \iota \circ \sigma \rangle = S_3^{\min}$ . This shows that groups  $G_2$  and  $G'_2$  are either both conjugate to  $\Delta'_0$  or to  $\Delta''_0$ .

**Proposition 3.15.** If a del Pezzo surface of degree 6 is  $H$ -birationally rigid then it is also -birationally rigid.

*Proof.* By Lemma [3.7,](#page-9-1) we have to examine the following possibilities:

(a) 
$$
H = N_{\bullet}C_6
$$
 and  $G = M_{\bullet}D_6$ , or

(b) 
$$
H = N_{\bullet}S_3
$$
 and  $G = M_{\bullet}D_6$ , or

(c)  $H = N_{\bullet}B$  and  $G = M_{\bullet}B$ , with  $B \in \{C_6, S_3, D_6\}$ ,

where  $N \subseteq M$ . Possible Sarkisov G-links were described before Example [3.9;](#page-10-0) recall that  $G$ -birational Bertini or Geiser involutions always lead to a  $G$ -isomorphic surface. Therefore, taking into consideration Proposition [3.12,](#page-10-1) it remains to investigate the links centred at a G-fixed point; they lead to  $S' \simeq \mathbb{P}^1 \times \mathbb{P}^1$ .

If  $N \neq id$  then  $M \neq id$  and thus G has no fixed points on S by Lemma [3.5.](#page-8-2) Therefore, S is G-birationally rigid. Suppose that  $N = id$ , so  $H \in \{C_6, S_3, D_6\}$ . In all cases, H fixes the point  $([1 : 1 : 1], [1 : 1 : 1]) \in S$  which does not lie on the  $(-1)$ -curves. Making a Sarkisov link centred at this point, we arrive to the quadric surface  $S' = \mathbb{P}^1 \times \mathbb{P}^1$  acted by H. Explicitly, one blows up the fixed point, and then blows down the preimages of the curves  $d_{i,j}$ , see [\[Isk08\]](#page-25-15) for more details and related discussion. Thus, S is not H-birationally rigid.  $\Box$ 

## 4. G-BIRATIONAL RIGIDITY OF QUADRIC SURFACES

In this section, we investigate carefully the case of  $S = \mathbb{P}^1 \times \mathbb{P}^1$ . This will finish the proof of the main result. By  $[DIO9a,$  Propositions 7.12, 7.13, every Sarkisov G-link starting

□

<span id="page-14-3"></span>from  $S$  is either of type I and of the form

<span id="page-14-1"></span>

where  $\eta$  is a blow up of a degree 2 point,  $\pi: T \longrightarrow \mathbb{P}^1$  is a G-conic bundle with two singular fibers (in fact, it is necessarily a del Pezzo surface of degree 6, see [\[Isk80,](#page-25-16) Theorem 5]), or is of type II and is represented by the diagram  $(2.3)$ , where  $\eta$  blows up a point of degree d,  $\eta'$ blows up a point of degree  $d'$ , and one of the following holds:

- (1)  $S \simeq S'$ ,  $d = d' = 7$ ,  $\chi$  is a birational Bertini involution;
- (2)  $S \simeq S'$ ,  $d = d' = 6$ ,  $\chi$  is a birational Geiser involution;
- (3) S' is a del Pezzo surface of degree 5,  $d = 5$ ,  $d' = 2$ ;
- (4)  $S' \simeq \mathbb{P}^1 \times \mathbb{P}^1$ ,  $d = d' = 4$ ;
- (5) S' is a del Pezzo surface of degree 6,  $d = 3$ ,  $d' = 1$ ;
- (6)  $S' \simeq \mathbb{P}^2$ ,  $d = 1$ ,  $d' = 2$ .

In particular, if  $G$  does not fix a point on  $S$  and is not isomorphic to any of the groups

<span id="page-14-2"></span> $C_5$ ,  $C_6$ ,  $S_3$ ,  $D_5$ ,  $D_6$ ,  $AGL_1(\mathbb{F}_5)$ ,  $A_5$ ,  $S_5$ , (4.2)

then all G-links of type II from S lead to a quadric surface  $S' \simeq \mathbb{P}^1 \times \mathbb{P}^1$  (recall Lemma [3.5\)](#page-8-2). A priori, the surface  $S'$  does not have to be G-isomorphic to  $S$  (we saw such phenomena in Section [3\)](#page-7-3), unless we deal with  $G$ -birational Bertini and Geiser involutions. It turns out that  $G$ -links centred at a point of degree 4 also lead to a  $G$ -isomorphic del Pezzo surface  $S' \simeq \mathbb{P}^1 \times \mathbb{P}^1$ . As was pointed out to me by Andrey Trepalin, this holds in the arithmetic [\[Tre23,](#page-26-3) Lemma 4.3] and even mixed settings; we limit ourselves to the geometric situation:

<span id="page-14-0"></span>**Proposition 4.3.** Let  $\chi: S \rightarrow S'$  be a Sarkisov G-link of type II centred at a point of degree 4. Then  $S'$  is G-isomorphic to  $S$ .

*Proof.* Assume that  $\chi = \eta' \circ \eta^{-1}$ :  $S \rightarrow S'$  is given by the diagram [\(2.3\)](#page-4-0), then T is a del Pezzo surface of degree 4. It is a blow-up of  $\mathbb{P}^2_{\mathbf{k}}$  in 5 points  $p_1, \ldots, p_5$  in general position (recall that we assume  $\overline{\mathbf{k}} = \mathbf{k}$ ). Denote by  $E_1, \ldots, E_5$  the exceptional divisors of this blow-up,  $L_{ij}$ ,  $i, j \in \{1, \ldots, 5\}, i < j$ , the strict transforms of the lines through  $p_i$  and  $p_j$ , and by Q the strict transform of the conic through  $p_1, \ldots, p_5$ . These are sixteen (−1)-curves on T. Their intersection graph is the Clebsch strongly regular quintic graph on 16 vertices, shown on Fig-ure [2.](#page-15-0) Up to renumbering the points, we may assume that the curves  $\Sigma = \{E_1, E_2, E_3, L_{45}\}\$ 

(4.1)

<span id="page-15-1"></span>are the exceptional divisors of the blow-up  $\eta$ , while the curves  $\Sigma' = \{L_{12}, L_{13}, L_{23}, Q\}$  are the exceptional divisors of  $\eta'$ . Recall [\[Dol12,](#page-25-7) 8.2.40] that  $Aut(T)$  injects into the Weyl group  $W(D_5) \simeq C_2^4 \rtimes S_5$ , the automorphism group of the Clebsch graph. The quartic del Pezzo surface  $T$  is isomorphic to an intersection of two quadrics

$$
\sum_{i=1}^{5} x_i^2 = \sum_{i=1}^{5} \lambda_i x_i^2 = 0
$$

in  $\mathbb{P}^4_{\mathbf{k}}$ . The group  $S_5$  acts by permutation of coordinates (and naturally acts on the indexes of  $E_i$  and  $L_{jk}$ ), while  $C_2^4$  acts as a diagonal subgroup of PGL<sub>5</sub>(**k**). There are two types of involutions in this group,  $\iota_{ij}$  and  $\iota_{ijkl}$ , which switch the signs of  $x_i, x_j$  and  $x_i, x_j, x_k, x_l$ , respectively. Equivalently,  $\iota_{ijkl}$  coincides with the automorphism  $j_t, t \in \{1, 2, 3, 4, 5\} \setminus \{i, j, k, l\}$ , switching the sign of  $x_t$ . As explained in [\[DD16,](#page-25-17) 7],  $y_t$  are given by de Jonquières involutions of the plane model centred at  $p_t$  and interchange  $E_i$  with  $L_{it}$  and  $E_t$  with  $Q$ . To recover the action of  $j_t$ on the curves  $L_{ij}$ ,  $i, j \neq t$ , we notice that 2 disjoint curves  $E_i$  and  $E_j$  are both intersected by exactly two others,  $L_{ij}$  and  $Q$  (in other words, every two non-adjacent vertices of the Clebsch graph [2](#page-15-0) have 2 common neighbours). Therefore,  $\chi_t(L_{ij})$  is the curve, which intersects  $L_{it}$  and  $L_{jt}$ , and is different from  $\jmath_t(Q) = E_t$ ; hence, it is  $L_{sr}$ , where  $s, r \in \{1, 2, 3, 4, 5\} \setminus \{i, j, t\}.$

Now, one easily checks that involutions  $\iota_{*5} = \iota_{*} \circ \iota_{5}$  and  $\iota_{*4} = \iota_{*} \circ \iota_{4}$  do not preserve the set Σ. Hence, the subgroup of  $W(D_5)$  which preserves Σ is generated by  $(12)$ ,  $(123)$ ,  $\iota_{12}$  and (45), and is isomorphic to  $S_4 \times C_2$ . The involution  $\iota_{45}$  commutes with this group and maps Σ onto Σ'. Since  $\iota_{45}$  actually corresponds to an automorphism of T, we conclude that the blow down  $\eta'$  yields a G-isomorphic del Pezzo surface  $S'$ . □

**Corollary 4.4.** The surface  $\mathbb{P}^1 \times \mathbb{P}^1$  is G-birationally rigid if and only if the size of every G-orbit in general position is 4 or  $\geq 6$ .

<span id="page-16-1"></span><span id="page-16-0"></span>**Remark 4.5.** At the same time, it will be often possible to exclude the possibility of  $G$ -links  $\chi: S \dashrightarrow \mathbb{P}^1 \times \mathbb{P}^1$  centred at a point of degree 4. If such link exists and is represented by the diagram  $(2.3)$  then T is a del Pezzo surface of degree 4, so a natural obstruction to existence of  $\chi$  is the impossibility of embedding  $G \hookrightarrow \text{Aut}(T)$ . Luckily, all possible automorphism groups Aut $(T)$  of smooth del Pezzo surfaces of degree 4 are classified [\[Hos96,](#page-25-18) [Dol12\]](#page-25-7) and they are the following (see the proof of Proposition [4.3](#page-14-0) for the description of these semidirect products):

$$
C_2^4
$$
,  $C_2^4 \rtimes C_2$ ,  $C_2^4 \rtimes C_4$ ,  $C_2^4 \rtimes S_3$ ,  $C_2^4 \rtimes D_5$ .

Recall that

$$
Aut(S) \simeq (PGL_2(\mathbf{k}) \times PGL_2(\mathbf{k})) \rtimes C_2,
$$

where the action of  $C_2$  is given by exchanging the factors. Finite subgroups of the direct product can be determined using so-called Goursat's lemma. Recall that the fibred product of two groups  $G_1$  and  $G_2$  over a group D is

$$
G_1 \times_D G_2 = \{ (g_1, g_2) \in G_1 \times G_2 \colon \alpha(g_1) = \beta(g_2) \},
$$

where  $\alpha: G_1 \longrightarrow D$  and  $\beta: G_2 \longrightarrow D$  are some surjective homomorphisms. Although the notation does not reflect it, the data defining  $G_1 \times_D G_2$  is not only the groups  $G_1$ ,  $G_2$  and D but also the homomorphisms  $\alpha$ ,  $\beta$ .

**Lemma 4.6** (Goursat's lemma, [\[Gou89,](#page-25-19) p. 47]). Let A and B be two groups. There is a bijective correspondence between subgroups  $G \subset A \times B$  and 5-tuples  $\{G_A, G_B, K_A, K_B, \varphi\},\$ where  $G_A$  is a subgroup of A,  $K_A$  is a normal subgroup of  $G_A$ ,  $G_B$  is a subgroup of B,  $K_B$ is a normal subgroup of  $G_B$ , and  $\varphi: G_A/K_A \overset{\sim}{\longrightarrow} G_B/K_B$  is an isomorphism. More precisely, the group corresponding to this 5-tuple is

$$
G = \{(a, b) \in G_A \times G_B \colon \varphi(aK_A) = bK_B\}.
$$

Conversely, let G be a subgroup of  $A \times B$ . Denote by  $p_A: A \times B \longrightarrow A$  and  $p_B: A \times B \longrightarrow B$ the natural projections, and set  $G_A = p_A(G)$ ,  $G_B = p_B(G)$ . Further, let

$$
K_A = \ker p_B|_G = \{(a, id) \in G, a \in A\}, K_B = \ker p_A|_G = \{(id, b) \in G, b \in B\},\
$$

whose images by  $p_A$  and  $p_B$  define normal subgroups of  $G_A$  and  $G_B$ , respectively (denoted the same). Let  $\pi_A: G_A \longrightarrow G_A/K_A$  and  $\pi_B: G_B \longrightarrow G_B/K_B$  be the canonical projections. The map  $\varphi: G_A/K_A \to G_B/K_B$ ,  $\varphi(aK_A) = bK_B$ , where  $b \in B$  is any element such that  $(a, b) \in G$ , is an isomorphism. Furthermore,  $G = G_A \times_D G_B$ , where  $D = G_A/K_A$ ,  $\alpha = \pi_A$ , and  $\beta = \varphi^{-1} \circ \pi_B$ .

<span id="page-17-7"></span><span id="page-17-2"></span>**Corollary 4.7.** In the notation from Goursat's lemma, the subgroup  $G \subset A \times B$  fits into the short exact sequence

$$
1 \longrightarrow K_A \times K_B \longrightarrow G \longrightarrow D \longrightarrow 1.
$$

*Proof.* Indeed, the restriction of the homomorphism  $\alpha \times \beta$ :  $G_A \times G_B \longrightarrow D \times D$  to G has the kernel  $K_A \times K_B$  and the image isomorphic to  $\Delta = \{(t, t) \in D \times D\} \simeq D$ .

Using Goursat's lemma, one can get the description of finite subgroups  $G \subset Aut(\mathbb{P}^1 \times \mathbb{P}^1)$ for which  $Pic(\mathbb{P}^1 \times \mathbb{P}^1)^G \simeq \mathbb{Z}$ . Before doing that, let us recall the following classical result due to Felix Klein:

<span id="page-17-0"></span>**Proposition 4.8** ( $\overline{Kle19}$ ). If **k** is an algebraically closed field of characteristic zero, then every finite subgroup of  $PGL_2(k)$  is isomorphic to  $C_n$ ,  $D_n$  (where  $n \geq 1$ ),  $A_4$ ,  $S_4$  or  $A_5$ . Moreover, there is only one conjugacy class for each of these groups.

Every group  $G \subset \text{Aut}(\mathbb{P}^1 \times \mathbb{P}^1)$  fits into the short exact sequence

$$
1 \longrightarrow G_{\circ} \longrightarrow G \longrightarrow \widehat{G} \longrightarrow 1,
$$

where  $G_{\circ} = G \cap (\text{PGL}_2(\mathbf{k}) \times \text{PGL}_2(\mathbf{k}))$  and  $\widehat{G} \subseteq C_2$ .

<span id="page-17-1"></span>**Proposition 4.9** (cf. [\[Tre18,](#page-25-5) Lemma 3.2]). Let  $G \subset Aut(S)$  be a finite subgroup such that  $Pic(S)^G \simeq \mathbb{Z}$ . Then  $G \simeq (F \times_D F)_{\bullet}C_2$ , where F is cyclic, dihedral, or one of the groups  $A_4$ , S<sub>4</sub>, A<sub>5</sub>. Moreover, for every such group G we have  $Pic(S)^G \simeq \mathbb{Z}$ .

*Proof.* Since  $G_{\circ}$  preserves the factors of  $\mathbb{P}^1 \times \mathbb{P}^1$ , the condition  $Pic(S)^G \simeq \mathbb{Z}$  forces  $\widehat{G} = C_2$ . If  $G_1$  and  $G_2$  are the images of  $G_0$  under the projections of  $PGL_2(k) \times PGL_2(k)$  onto its factors, the Goursat's lemma implies that  $G_{\circ} = G_1 \times_D G_2$  for some D. Since  $\hat{G} \neq id$ , we must have  $G_1 \simeq G_2$ . Combining this with Proposition 4.8, we get the result. must have  $G_1 \simeq G_2$ . Combining this with Proposition [4.8,](#page-17-0) we get the result.

<span id="page-17-5"></span>**Corollary 4.10.** In the notation of Proposition [4.9,](#page-17-1) for every finite subgroup  $G \subset Aut(S)$ satisfying  $Pic(S)^G \simeq \mathbb{Z}$  one has the following short exact sequence

$$
1 \longrightarrow K \times K \longrightarrow G_{\circ} \longrightarrow D \longrightarrow 1 \tag{4.11}
$$

where K is a normal subgroup of F and  $F/K \simeq D$ .

*Proof.* We apply Corollary [4.7](#page-17-2) and note that the action of  $C_2$  in the semi-direct product  $(PGL_2(\mathbf{k}) \times PGL_2(\mathbf{k})) \rtimes C_2$  $(PGL_2(\mathbf{k}) \times PGL_2(\mathbf{k})) \rtimes C_2$  $(PGL_2(\mathbf{k}) \times PGL_2(\mathbf{k})) \rtimes C_2$  induces an isomorphism<sup>2</sup> of the kernels  $K_A \xrightarrow{\sim} K_B$ .

<span id="page-17-6"></span>**Lemma 4.12.** Let  $G \subset Aut(\mathbb{P}^1 \times \mathbb{P}^1)$  be a finite subgroup. Then, the following holds:

<span id="page-17-4"></span>(1) Assume there is a Sarkisov G-link  $\chi: S \dashrightarrow T$  of type I as in [\(4.1\)](#page-14-1). Then  $G_0$  has a subgroup of the form  $C_n \times C_m$  which is of index at most 2 in  $G_0$ .

<span id="page-17-3"></span><sup>&</sup>lt;sup>2</sup>In fact, for finite subgroups  $A, K_1, K_2$  of PGL<sub>2</sub>(k) an isomorphism  $A/K_1 \simeq A/K_2$  always implies  $K_1 \simeq K_2$ , unless  $A = D_{2n}$ ; see Lemma [3.6.](#page-8-1)

<span id="page-18-0"></span>(2) Assume there exists a Sarkisov G-link  $S \dashrightarrow \mathbb{P}^2$  of type II. Then  $G_{\circ}$  is isomorphic to a direct product of at most two cyclic groups. In particular, the abelian group  $G_0$  is generated by at most 2 elements.

*Proof.* [\(1\)](#page-17-4) Recall that the centre of  $\chi$  is a G-point  $\{p, q\}$  of degree 2. Therefore, the stabilizer  $G' \subset G$  of p is a normal subgroup of index 2 and  $G'' = G_{\circ} \cap G'$  is of index at most 2 in  $G_{\circ}$ . Since  $G''$  acts on S fiberwisely, the faithful representation  $G'' \longrightarrow GL(T_pS)$  is reducible, i.e. it is a direct sum of two 1-dimensional representations. Hence  $G'' \simeq C_n \times C_m$ . In the case [\(2\)](#page-18-0) the group G fixes a point on S and the result follows similarly.  $\Box$ 

We now proceed with determining for which groups  $G \simeq (F \times_D F)_{{\bullet}} C_2$  of Proposition [4.9](#page-17-1) the surface  $S = \mathbb{P}^1 \times \mathbb{P}^1$  is actually G-birationally rigid. In our analysis, we will often use Corollary [4.10](#page-17-5) (including its notation), without explicitly mentioning it.

<span id="page-18-1"></span>4.A. Case  $F = C_n$ . Denote  $S = F_1 \times F_2$ , where  $F_1 \simeq F_2 \simeq \mathbb{P}^1$ . Then  $G_0 \subseteq H_1 \times H_2$ ,  $H_1 \simeq H_2 \simeq \mathbb{C}_n$  are cyclic groups of order *n*, and  $H_i$  faithfully acts on  $F_i$ . Recall that each  $H_i$  fixes exactly two points on  $F_i$ . Hence, the group  $G_o$  fixes 4 points on S. Let  $p \in S$  be one of these fixed points. The group G is a disjoint union of  $G_0$  and  $gG_0$ , where  $g \notin G_0$ . Consider the set  $\Omega = \{p, g(p)\}\.$  Since  $g^2 \in G_{\circ}$ , this set is g-invariant. Furthermore, since  $g^{-1}G_{\circ}g = G_{\circ}$ , the point  $g(p)$  is fixed by  $G_{\circ}$ . Therefore,  $\Omega$  is G-invariant. If  $|\Omega| = 1$  (i.e.  $g(p) = p$ , then the stereographic projection from p conjugates G to a group acting on  $\mathbb{P}^2$ , hence S is not G-birationally rigid. Assume that  $g(p) \neq p$ . We claim that  $g(p)$  and p are in general position on S. Indeed, the coordinates  $[x : y]$  on  $F_1$  and  $[z : t]$  on  $F_2$  can be chosen so that the fixed points of  $G_0$  are

$$
([1:0],[1:0]), ([1:0],[0:1]), ([0:1],[1:0]), ([0:1],[0:1]).
$$

The automorphism g is of the the form  $([x : y], [z : t]) \mapsto (A[z : t], B[x : y])$ , where  $A, B \in$ PGL<sub>2</sub>(k). Assume that g sends  $([1:0], [1:0])$  onto  $([1:0], [0:1])$ , i.e.  $A[1:0] = [1:0]$  and  $B[1:0] = [0:1]$ . Then, as discussed above,  $g^2: ([x:y],[z:t]) \mapsto (AB[x:y], BA[z:t])$  fixes  $([1 : 0], [1 : 0])$ , which is impossible, as  $BA[1 : 0] = B[1 : 0] = [0 : 1]$ . Similarly, g cannot send  $([1:0], [1:0])$  onto  $([0:1], [1:0])$ . We conclude that p and  $q(p)$  are the points on the diagonal of S. Their blow up gives a conic bundle  $S' \to \mathbb{P}^1$  with two singular fibers, hence S is not  $G$ -birationally rigid.

<span id="page-18-3"></span>Remark 4.13. As we already noticed in Remark [2.7,](#page-5-2) a cyclic group always has a fixed point on a quadric. Blowing this point up and contracting the strict transforms of the lines passing through it, we arrive to  $\mathbb{P}^2$  (one often says that the group is *linearizable* in this case).

<span id="page-18-2"></span>4.B. Case  $F = D_n$ . Recall that  $D_2 \simeq V_4 \simeq C_2^2$  and set  $D_1 = C_2$ . Assume  $n \geq 3$ . Recall from Lemma [3.6](#page-8-1) that proper normal subgroups of  $D_n$  are cyclic groups of order  $n/d$  for each

<span id="page-19-7"></span>d dividing n (of index 2d) and, if n is even, dihedral of index 2. Therefore, we have the following two possibilities:

<span id="page-19-0"></span>4.B.1. The group  $G_{\circ}$  fits into the short exact sequence

<span id="page-19-4"></span>
$$
1 \longrightarrow D_m \times D_m \longrightarrow G_\circ \longrightarrow C_2^i \longrightarrow 1,
$$
\n(4.14)

where either  $i = 1$  and  $n = 2m$ ,  $m \ge 2$ , or  $i = 0$ ,  $D = id$ ,  $m = n \ge 3$ .

<span id="page-19-1"></span>4.B.2. The group  $G_{\circ}$  fits into the short exact sequence

<span id="page-19-6"></span>
$$
1 \longrightarrow C_m \times C_m \longrightarrow G_\circ \longrightarrow D_d \longrightarrow 1,
$$
\n(4.15)

where  $n = md, m \ge 1$ . Note that this covers the extremal case  $m = 1, G_{\circ} = D_n, n \ge 3$ .

<span id="page-19-5"></span><span id="page-19-2"></span>Proposition 4.16. In the notation from above, one has the following:

(1) S is G-birationally rigid in the case  $4.B.1$ .

<span id="page-19-3"></span>(2) S may fail to be G-birationally rigid in the case [4.B.2.](#page-19-1) If  $\chi: S \rightarrow S'$  is a Sarkisov G-link to a different G-Mori fiber space, then  $S' = \mathbb{P}^2$ ; or S' is a G-del Pezzo surface of degree 6 and  $G \simeq D_6$ ; or S' is a G-del Pezzo surface of degree 5 and  $G \simeq \text{AGL}_1(\mathbb{F}_5)$ ; or S' admits the structure of a  $G$ -conic bundle with 2 singular fibers.

*Proof.* [\(1\)](#page-19-2) First, there are no Sarkisov G-links of type I from S. Indeed, otherwise  $G_0$  has a subgroup  $N_0 \simeq C_k \times C_l$  of index at most 2 by Lemma [4.12.](#page-17-6) But then  $N_0 \cap (D_m \times D_m)$ must be an abelian group which can be generated by at most 2 elements and has index at most 2 in  $D_m \times D_m$ , which is not possible. Furthermore,  $G_{\circ}$  obviously does not embed into the groups from  $(4.2)$ , so it remains to show that there are no Sarkisov G-links of type II centred at a point of degree 4. Assume that it exists and is given by the diagram [\(2.3\)](#page-4-0). Then T is a del Pezzo surface of degree 4 in  $\mathbb{P}^4$ . Note that  $|G| = 4n^2$  if  $i = 1$ , and  $|G| = 2n^2$ if  $i = 0$ . From Remark [4.5](#page-16-0) we see that G does not embed into Aut(T), unless  $m = 2$ ; in particular, G must contain a subgroup of the form  $\Delta = \mathbb{C}_2^4$ . It is easy to prove [\[Bea07,](#page-24-11) Lemma 3.1, Proposition 3.11] that such  $\Delta$  is conjugate in PGL<sub>5</sub>(k) to a subgroup of the diagonal torus; it acts on T (which is an intersection of two quadrics in  $\mathbb{P}^4$ ) by changing the signs of the ambient coordinates  $x_k$  and consists of the projective transformations id,  $y_i$ ,  $i = 1, \ldots, 5, \, j_i \circ j_j, \, 1 \leq i < j \leq 5$ , where  $j_k \colon x_k \mapsto -x_k$ . The fixed point locus of each  $j_k$ is an elliptic curve cut out on T by the hyperplane  ${x_k = 0}$ , while the fixed point loci of other non-trivial involutions in  $\Delta$  consist of exactly 4 points. If  $tr(\delta)$  denotes the trace of the action of  $\delta$  on Pic(T)  $\otimes \mathbb{C}$  and Eu(·) denotes the topological Euler characteristic, then  $Eu(T^{\delta}) = \text{tr}(\delta) + 2$  by the Lefschetz fixed point formula (here  $T^{\delta}$  denotes the fixed locus of  $\delta$ ). Since Eu( $T^{j_k}$ ) = 0 and Eu( $T^{j_k \circ j_l}$ ) = 4, we get  $tr(j_k)$  = -2 and  $tr(j_k \circ j_l)$  = 2. Therefore, rank  $Pic(T)^{\Delta} = \frac{1}{\Delta}$  $\frac{1}{|\Delta|}\sum_{\delta\in\Delta}tr(\delta) = 1$ , which contradicts to existence of Sarkisov link; see

<span id="page-20-1"></span> $[D109a, 6.1]$  or  $[Yas22, 2.1]$  for more details. We conclude that S admits only G-birational Bertini and Geiser involutions, and hence is  $G$ -birationally rigid.

[\(2\)](#page-19-3) All possible Sarkisov G-links from  $S$  were described in the beginning of the Section; as we know, those centred at points of degrees  $7, 6$  and  $4$  lead to a  $G$ -isomorphic del Pezzo surface. Suppose that S' is a del Pezzo surface of degree 6. As  $\chi^{-1}$  starts with blowing up a G-fixed point on S', the group G must be isomorphic to  $C_6$ ,  $S_3$  or  $D_6$  and hence  $G_6$  is  $C_3$  or S<sub>3</sub>. As we are in the setting of the exact sequence [\(4.14\)](#page-19-4), we must have  $G \simeq D_6$ . Next, if S' is a del Pezzo surface of degree 5, then Lemma [2.8](#page-5-1) and the exact sequence [\(4.14\)](#page-19-4) show that we must have  $m = 1, G_{\circ} \simeq D_5$  and hence  $G \simeq \text{AGL}_1(\mathbb{F}_5)$ .

In fact, all possibilities described in Proposition [4.16](#page-19-5)[\(2\)](#page-19-3) do occur. For  $D_6$ -links to del Pezzo surface of degree 6, this was already mentioned in the end of Section [3,](#page-7-3) see also [\[Isk08\]](#page-25-15). To construct  $\text{AGL}_1(\mathbb{F}_5)$ -links to del Pezzo surface of degree 5, recall that  $\text{AGL}_1(\mathbb{F}_5)$  has presentation  $\langle \alpha, \beta | \alpha^5 = \beta^4 = id, \beta \alpha \beta^{-1} = \alpha^3 \rangle$ . Let  $\alpha \in Aut(S') \simeq S_5$  be an automorphism of order 5. It is easy to show [\[Yas16,](#page-26-2) Lemma 4.16], using the Lefschetz fixed point formula, that  $\alpha$  has exactly 2 fixed points, say p and q, in general position on S'. Then  $\alpha\beta \cdot p =$  $\alpha^{-2}\beta\alpha \cdot p = \alpha^{-2}\beta \cdot p$ , so  $\beta \cdot p$  is a fixed point of  $\alpha^3$  and hence of  $\alpha$ , i.e.  $\beta \cdot p \in \{p,q\}$ . We conclude that  $\{p, q\}$  is an orbit of G and hence one can associate a link to it.

Next, let us provide an example of a link to a conic bundle and to  $\mathbb{P}^2$ .

<span id="page-20-0"></span>**Example 4.17.** Assume that  $m = 1$  and that  $G_{\circ} = D_n$  acts on  $S = \mathbb{P}^1 \times \mathbb{P}^1$  "diagoanlly", i.e. by  $([x : y], [z : t]) \mapsto (A[x : y], A[z : t])$ , where  $A \in \text{PGL}_2(\mathbf{k})$  are elements of  $D_n$ . Let us choose the coordinates so that the action of  $D_n = \langle r, s : r^n = s^2 = id, srs = r^{-1} \rangle$  on each factor is given by  $r: [x : y] \mapsto [x : \omega y], s: [x : y] \mapsto [y : x]$ , where  $\omega$  denotes a primitive *n*-th root of unity. Consider two automorphisms of S

$$
\tau_1: ([x:y], [z:t]) \rightarrow ([z:t], [x:y]),
$$
  

$$
\tau_2: ([x:y], [z:t]) \rightarrow ([t:z], [y:x]).
$$

Then  $\tau_1$  commutes with  $G_{\circ}$ , while  $\tau_2$  defines a semidirect product  $G_{\circ} \rtimes \langle \tau_2 \rangle$ , where  $\tau_2$  acts by the inversion of r and preserves s. Note that r has exactly two fixed points  $[1:0]$  and  $[0:1]$ , which are permuted by s. Let

$$
p_1 = ([1:0], [1:0]), p_2 = ([1:0], [0:1]), p_3 = ([0:1], [1:0]), p_4 = ([0:1], [0:1]).
$$

The sets  $\Omega_1 = \{p_1, p_4\}$  and  $\Omega_2 = \{p_2, p_3\}$  are invariant with respect to  $G_{\circ}$ ,  $\tau_1$  and  $\tau_2$ . Therefore, the groups  $G_1 = G_0 \times \langle \tau_1 \rangle$  and  $G_2 = G_0 \times \langle \tau_2 \rangle$  admit an orbit in general position whose blow up gives a conic bundle  $S' \to \mathbb{P}^1$  with two singular fibers (in fact, this is a del Pezzo surface of degree 6, see [\[Isk80,](#page-25-16) Theorem 5]).

<span id="page-21-1"></span>Similarly, one can construct examples of links to  $\mathbb{P}^2$ . Note that, if such link exists, Lemma [2.6](#page-4-1) implies that  $G_0$  is an abelian group generated by at most 2 elements. In particular,  $d \leq 2$  in [\(4.15\)](#page-19-6). If  $d = 1$  then  $|G_{\circ}| = 2m^2$  and hence  $G_{\circ}$  is an index 2 subgroup of  $D_m \times D_m$ , which is impossible. If  $d = 2$  then  $G_0$  is an index 4 subgroup and hence it coincides with  $C_{2m} \times C_{2m} \subset D_{2m} \times D_{2m}$ . Making this group act on  $\mathbb{P}^1 \times \mathbb{P}^1$  diagonally, as above, and taking a direct product with  $\tau_1$ , we get a linearizable action.

Finally, if  $n = 2$  then  $G_{\circ} = V_4 \times_D V_4 \subset V_4 \times V_4 \simeq C_2^4$  and hence one has the following possibilities for  $G_{\circ}$ :

$$
V_4 \times V_4 \ (D = id), \quad (C_2 \times C_2) \times C_2 \simeq C_2^3 \ (D = C_2), \quad V_4 \ (D = V_4).
$$

When  $G_0 \simeq V_4 \times V_4 \simeq C_2^4$ , the same arguments as in the proof of Proposition [4.16](#page-19-5)[\(1\)](#page-19-2) show that S is G-birationally rigid. In the remaining two cases  $D \simeq C_2$  and  $D \simeq V_4$ , one easily constructs the examples similar to Example [4.17.](#page-20-0)

4.C. Case  $F = A_4$ . If  $K = A_4$  then  $G_0 = A_4 \times A_4$ . If  $K = V_4$  then we have a short exact sequence

$$
1 \longrightarrow V_4 \times V_4 \longrightarrow G_{\circ} \longrightarrow C_3 \longrightarrow 1,
$$
\n
$$
(4.18)
$$

while for  $K = id$  we simply get  $G_0 = A_4$ . Therefore, G is of the form

<span id="page-21-0"></span>
$$
(A_4 \times A_4) \bullet C_2
$$
,  $((V_4 \times V_4) \bullet C_3) \bullet C_2$ , or  $A_4 \bullet C_2$ . (4.19)

Note that none of the groups  $G_0$  admits a subgroup  $C_n \times C_m$  of index at most 2, hence there are no Sarkisov G-links of type I on S and no G-links leading to  $\mathbb{P}^2$  by Lemma [4.12.](#page-17-6) Clearly, none of the extensions  $(4.19)$  is isomorphic to a group from the list  $(4.2)$ .

It remains to investigate the links of type II centred at a point of degree 4. If  $G \simeq$  $(A_4 \times A_4)$ •C<sub>2</sub> then there are no such G-links, as |G| is divisible by 9 and hence G does not embed into automorphism groups of del Pezzo surfaces of degree 4. If such  $G$ -link existed for  $G \simeq ((C_2^4)_{\bullet}C_3)_{\bullet}C_2$ , then G would embed into  $Aut(T)$ , where T is a quartic del Pezzo surface, and moreover  $G = \text{Aut}(T) \simeq \mathbb{C}_2^4 \rtimes \mathbb{S}_3$ . However, one has  $\text{Pic}(T)^G \simeq \mathbb{Z}$  in this case [\[DI09a,](#page-25-10) Theorem 6.9], which is a contradiction.

Finally, if  $K = id$ , the group  $G_{\circ} = A_4 \times_{A_4} A_4 \simeq A_4$  acts on S by

$$
([x:y],[z:t]) \mapsto (g[x:y],\varphi(g)[z:t]), \quad g \in A_4,
$$

where  $\varphi \in Aut(A_4)$  is a fixed automorphism. The extension  $A_4_{\bullet}C_2$  always splits and one has  $G \simeq A_4 \rtimes_{\psi} \langle \tau \rangle$ , where  $\tau \notin G_{\circ}$ . The latter automorphism is of the form

$$
\tau \colon ([x:y],[z:t]) \mapsto (A[z:t],B[x:y]),
$$

where  $A, B \in \text{PGL}_2(\mathbf{k})$ . Since  $\tau^2 = id$ , we find that  $B = A^{-1}$ . Let us choose the coordinates on the first factor of  $\mathbb{P}^1 \times \mathbb{P}^1$  so that the derived subgroup  $V_4$  of  $A_4$  is generated by [x :  $[y] \mapsto [x:-y], [x:y] \mapsto [y:x].$  A direct computation then shows that an element of order 3 is represented by one of the following matrices

$$
\begin{pmatrix} i & i \\ 1 & -1 \end{pmatrix}, \quad \begin{pmatrix} i & -i \\ 1 & 1 \end{pmatrix}, \quad \begin{pmatrix} -i & i \\ 1 & 1 \end{pmatrix}, \quad \begin{pmatrix} -i & -i \\ 1 & -1 \end{pmatrix}.
$$
 (4.20)

Suppose that  $\psi = id$ , so  $G \simeq A_4 \times \langle \tau \rangle$ . Below we give two examples which show that the existence of the Sarkisov G-link depends on the embedding of  $G$  into  $Aut(S)$ .

**Example 4.21.** Assume that  $\varphi = id$ , so the group  $G_{\circ}$  acts on  $\mathbb{P}^{1} \times \mathbb{P}^{1}$  "diagonally" by  $([x : y], [z : t]) \mapsto (g \cdot [x : y], g \cdot [z : t])$ , where  $g \in \text{PGL}_2(\mathbf{k})$ . Further, assume that  $\tau$  is given by

$$
([x:y],[z:t]) \mapsto ([z:t],[x:y]).
$$

Obviously, it commutes with  $G_{\circ}$ . If  $\Omega = G \cdot p$  is an orbit of cardinality 4 on S, then the stabilizer of p is a cyclic group  $\langle \tau \rangle \times \langle \delta \rangle \simeq C_6$ , where  $\delta \in G_0$  is an element of order 3. As the fixed locus of  $\tau$  is the diagonal  $\Delta \subset \mathbb{P}^1 \times \mathbb{P}^1$ , we have  $p \in \Delta$ . But  $G_o$  preserves  $\Delta$ , hence  $\Omega \subset \Delta$ . As  $\Delta^2 = 2$ , the orbit  $\Omega$  is not in general position on S and hence there is no Sarkisov  $G$ -link starting from  $\Omega$ .

**Example 4.22.** Now let us assume that  $\varphi \in Aut(A_4)$  permutes the elements of  $V_4 \subset A_4$ such that  $V_4 = \langle \alpha \rangle \times \langle \beta \rangle$  acts by

$$
\alpha: ([x:y],[z:t]) \mapsto ([x:-y],[t:z]), \quad \beta: ([x:y],[z:t]) \mapsto ([y:x],[t:-z]).
$$

Set 
$$
M = \begin{pmatrix} 1 & 0 \ 1 & -1 \end{pmatrix}
$$
 and suppose that the element of order 3 of A<sub>4</sub> and  $\tau$  are  
\n
$$
\gamma: \left( \begin{bmatrix} x \\ y \end{bmatrix}, \begin{bmatrix} z \\ t \end{bmatrix} \right) \mapsto \left( M \begin{bmatrix} x \\ y \end{bmatrix}, M \begin{bmatrix} z \\ t \end{bmatrix} \right), \quad \tau: \left( \begin{bmatrix} x \\ y \end{bmatrix}, \begin{bmatrix} z \\ t \end{bmatrix} \right) \mapsto \left( M \begin{bmatrix} z \\ t \end{bmatrix}, M^{-1} \begin{bmatrix} x \\ y \end{bmatrix} \right),
$$

respectively. One easily checks that  $\alpha, \beta, \gamma$  generate the group  $\langle \alpha, \beta, \gamma : \alpha^2 = \beta^2 = \gamma^3 =$ id,  $\gamma \alpha \gamma^{-1} = \alpha \beta = \beta \alpha$ ,  $\gamma \beta \gamma^{-1} = \alpha$   $\sim \Delta_4$ , and  $\tau$  commutes with this group. If  $(1, a)^t$  is the eigenvector of M, then  $\gamma$  and  $\tau$  both fix the point ([1 : a], [1 : a]). Its G-orbit consists of 4 points

 $([1 : a], [1 : a]), ([1 : -a], [1 : a^{-1}]), ([1 : a^{-1}], [1 : -a^{-1}]), ([1 : -a^{-1}], [1 : -a]),$ 

which are in general position on  $S$ .

To sum up, when  $G_0 \simeq A_4$ , the surface S may admit a Sarkisov G-link centred at a point of degree 4. Note, however, that this link yields a G-isomorphic surface  $S' \simeq \mathbb{P}^1 \times \mathbb{P}^1$ by Proposition [4.3.](#page-14-0) Therefore,  $S$  is  $G$ -birationally rigid in any case.

<span id="page-23-3"></span>4.D. Case  $F = S_4$ . If  $K = S_4$  then  $G_{\circ} = S_4 \times S_4$ . If  $K = id$  then  $G_{\circ} = S_4$ . In the remaining two cases  $K = A_4$  and  $K = V_4$ , the group  $G_0$  fits into the short exact sequence

$$
1 \longrightarrow A_4 \times A_4 \longrightarrow G_\circ \longrightarrow C_2 \longrightarrow 1 \tag{4.23}
$$

or into the short exact sequence

$$
1 \longrightarrow V_4 \times V_4 \longrightarrow G_\circ \longrightarrow S_3 \longrightarrow 1 \tag{4.24}
$$

By Lemma [4.12,](#page-17-6) there are no Sarkisov G-links to  $\mathbb{P}^2$  and no Sarkisov G-links of type I starting from  $S$ . Furthermore, none of the extensions

$$
(S_4 \times S_4)_\bullet C_2, \quad ((A_4 \times A_4)_\bullet C_2)_\bullet C_2, \quad ((V_4 \times V_4)_\bullet S_3)_\bullet C_2, \quad S_{4\bullet}C_2 \tag{4.25}
$$

of  $C_2$  by  $G_0$  is isomorphic to a group from the list  $(4.2)$ . Finally, there are no Sarkisov  $G$ -links of type II, starting at a point of degree 4. Indeed, otherwise  $G$  has a subgroup of index 4 which fixes a point on S and hence  $G_0$  has an abelian subgroup of the form  $C_n \times C_m$ and of index 2 or 4, which is clearly not the case (alternatively, one can again argue using Remark [4.5\)](#page-16-0). We conclude that  $S$  can admit only  $G$ -equivariant birational Bertini and Geiser involutions<sup>[3](#page-23-0)</sup>, hence it is  $G$ -birationally rigid.

<span id="page-23-2"></span>4.E. Case  $F = A_5$ . Since  $A_5$  is simple, one has  $K = id$  or  $K = A_5$ , so either  $G \simeq (A_5 \times_{A_5} I_5)$  $A_5)$ •C<sub>2</sub>  $\simeq A_{5}$ •C<sub>2</sub> or  $G \simeq (A_5 \times A_5)$ •C<sub>2</sub>. Clearly, none of these groups is isomorphic to a group from [\(4.2\)](#page-14-2), unless in the first extension we get  $G \simeq S_5$ . However, by Lemma [2.6,](#page-4-1) there exists<sup>[4](#page-23-1)</sup> no Sarkisov S<sub>5</sub>-link  $\chi: S \dashrightarrow S'$  to a del Pezzo surface S' of degree 5, as the centre of  $(\eta')^{-1}$ in [\(2.3\)](#page-4-0) would be a point of degree 2. Further, none of the groups  $G_0 = A_5$  or  $G_0 = A_5 \times A_5$ has a subgroup of the form  $C_n \times C_m$  of index at most 2 in  $G_0$ , so there are no G-links of type I and no G-links to  $\mathbb{P}^2$  by Lemma [4.12.](#page-17-6) By Remark [4.5,](#page-16-0) S does not admit G-links centred at a point of degree 4. Similarly, G does not embed into automorphism group of del Pezzo surfaces of degree 1 or 2 [\[Dol12,](#page-25-7) 8.7, 8.8]. We conclude that  $S$  is  $G$ -birationally superrigid.

End of the proof. The results of previous sections tell us that  $S$  may fail to be  $G$ birationally rigid exactly in the following cases:

- (a)  $G = (\mathbb{C}_n \times_D \mathbb{C}_n)$ .  $\mathbb{C}_2$  is a group from Section [4.A,](#page-18-1)  $G_\circ = \mathbb{C}_n \times_D \mathbb{C}_n$ .
- (b)  $G = (D_n \times_D D_n) \bullet C_2$  is a group from Section [4.B,](#page-18-2) where  $G_0$  satisfies [4.B.2.](#page-19-1)
- (c)  $G = (C_2^3)_\bullet C_2$  or  $G = V_{4\bullet}C_2$  are groups from Section [4.B.](#page-18-2)

<span id="page-23-0"></span><sup>&</sup>lt;sup>3</sup>In fact, classification of the automorphism groups of del Pezzo surfaces of degree 1 and 2 [\[Dol12,](#page-25-7) [DI09a\]](#page-25-10) shows that there are no such links for most of  $G$ .

<span id="page-23-1"></span><sup>&</sup>lt;sup>4</sup>Alternatively, if such link existed, then the surface T in the diagram [\(2.3\)](#page-4-0) is a cubic surface acted by S<sub>5</sub>. It is well known that T must be the Clebsch diagonal cubic; one always has  $Pic(T)^{S_5} \simeq \mathbb{Z}$ , see [\[DI09a,](#page-25-10) Theorem 6.14].

The groups  $G_{\circ}$  from (a) are abelian and generated by at most 2 elements, hence cannot contain any of the groups  $G_{\circ}$  of sections [4.B-](#page-18-2)[4.E,](#page-23-2) unless  $G_{\circ} = V_4$  is as in (c). However, in the latter case, S is not G-birationally rigid. The groups  $G_0$  from sections [4.B](#page-18-2)[-4.E](#page-23-2) cannot embed into the groups  $G_{\circ}$  from (c) by the order reasons.

Suppose that  $G_0$  is a group from (b). Then there exists a Sarkisov G-link  $\chi: S \dashrightarrow S'$ leading to a different G-Mori fiber space  $S' \to Z$ , where  $Z =$  pt or  $Z = \mathbb{P}^1$ ; all possibilities are given by Proposition [4.16.](#page-19-5) If  $S' = \mathbb{P}^2$  then G fixes a point on S and hence the same is true for any subgroup  $H \subset G$ , showing that H is linearizable as well (see Remark [4.13\)](#page-18-3). If  $S' \to \mathbb{P}^1$ is a  $G$ -conic bundle then  $G$  has an orbit of size 2 on  $S$  and hence  $H$  has an orbit of size 1 or 2; the result follows. If S' is a G-del Pezzo surface of degree 6 then  $G \simeq G_{\circ} \times C_2 \simeq D_6$ , where  $G_0 \simeq D_3$ . Then  $H_0 \in \{\text{id}, \text{C}_2, \text{C}_3\}$  and  $H \in \{\text{C}_2, \text{C}_2^2, \text{C}_6\}$ , so S is not H-birationally rigid. Finally, if S' is a del Pezzo surface of degree 5 then  $G \simeq \text{AGL}_1(\mathbb{F}_5)$  and  $G_{\circ} \simeq D_5$ ; hence,  $H_0 \in \{\text{id}, \text{C}_2, \text{C}_5\}$  and then  $H \in \{\text{C}_2, \text{C}_2^2, \text{C}_4, \text{C}_{10}, \text{D}_5\}$ . But once again, such groups admit either an H-link to an H-conic bundle, or an H-link to  $\mathbb{P}^2$ .

The Theorem is proven.
