Locally uniform random permutations with large increasing subsequences

Victor Dubach

Abstract

We investigate the maximal size of an increasing subset among points randomly sampled from certain probability densities. Kerov and Vershik's celebrated result states that the largest increasing subset among N uniformly random densities. points on [0, 1]² has size asymptotically $2\sqrt{N}$. More generally, the order $\Theta(\sqrt{N})$ still holds i is continuous. In this paper we exhibit two sufficient conditions on the density to obtain a growth rate equivalent to any given power of N greater than \sqrt{N} , up to logarithmic factors. Our proofs use methods of slicin into appropriate grids, and investigating sampled points appearing in each box.

1 Introduction

1.1 Random permutations sampled from a pre-permuton

We start by defining the model of random permutations studied in this paper. Consider points X_1, \ldots, X_N in the unit square $[0, 1]^2$ whose x-coordinates and y-coordinates are all distinct. One can then naturally define a permutation σ of size N the following way: for any $i, j \in [1, N]$, let $\sigma(i) = j$ whenever the point with i-th lowest x-coordinate has j-th lowest y-coordinate. We denote by $\text{Perm}(X_1, \ldots, X_N)$ $\text{Perm}(X_1, \ldots, X_N)$ $\text{Perm}(X_1, \ldots, X_N)$ this permutation; see fig. 1 for an example. Now suppose μ is a probability measure on $[0,1]^2$ and that X_1,\ldots,X_N are random i.i.d. points distributed under μ : the random permutation $\text{Perm}(X_1, \ldots, X_N)$ is then denoted by $\text{Sample}_N(\mu)$. To ensure this permutation is well defined, we suppose that the marginals of μ have no atom so that X_1, \ldots, X_N have almost surely distinct x-coordinates and y-coordinates. We call such a measure a *pre-permuton*; see Section [2.4](#page-5-0) for discussion around this name.

Notice that permutations sampled from the uniform measure on $[0, 1]^2$ are uniformly random. The model of random permutations previously defined thus generalizes the uniform case while allowing for new tools in a geometric framework, as illustrated in [\[AD95\]](#page-16-0) (see also [\[Kiw06\]](#page-16-1) for a variant with uniform involutions). This observation motivates the study of such models, as done for example in [\[AD95\]](#page-16-0) or [\[Sjö22\]](#page-17-0).

In the present paper we are interested in pre-permutons that are absolutely continuous with respect to Lebesgue measure on $[0,1]^2$, and denote by μ_ρ the pre-permuton having density ρ . Following [\[Sjö22\]](#page-17-0) we call sampled permutations under μ_ρ locally uniform. This name is easily understood when ρ is continuous, since the measure μ_ρ can then locally be approximated by a uniform measure.

1.2 Growth speed of the longest increasing subsequence

Let σ be a permutation of size N. An increasing subsequence of σ is a sequence of indices $i_1 < \cdots < i_k$ such that $\sigma(i_1) < \cdots < \sigma(i_k)$. The maximal length of such a sequence is called (length of the) longest increasing subsequence of σ and denoted by $\text{LIS}(\sigma)$. Ulam formulated in the 60's the following question: let us write (here and throughout this paper) for all $N \in \mathbb{N}^*$

 $\ell_N := \mathbb{E} [\text{LIS}(\sigma_N)]$ where σ_N is a uniformly random permutation of size N,

then what can we say about the asymptotic behaviour of ℓ_N as $N \to \infty$? The study of longest increasing subsequences has since then been a surprisingly fertile research subject with unexpected links to diverse areas of mathematics [\[Rom15\]](#page-17-1). A solution to Ulam's problem was found by Kerov and Vershik; using objects called Young diagrams through Robinson-Schensted's correspondance, they obtained the following:

Figure 1: A family of points and its associated permutation, written in one-line notation $\sigma = \sigma(1)\sigma(2) \dots \sigma(N)$. Here we have $\sigma(1) = 2$ because the leftmost point is second from the bottom; and so on.

Theorem 1.1 ([\[VK77\]](#page-17-2)).

$$
\ell_{N} \underset{n \to \infty}{\sim} 2\sqrt{N}.
$$

The asymptotic behaviour of the longest increasing subsequence in the uniform case is now well understood with concentration inequalities [\[Fri98,](#page-16-2) [Tal95\]](#page-17-3) and an elegant asymptotic development [\[BDJ99\]](#page-16-3). It is then natural to try and generalize Theorem [1.1](#page-0-0) to $\text{LIS}(\text{Sample}_N(\mu))$ for appropriate pre-permutons μ . One of the first advances on this question was obtained by Deuschel and Zeitouni who proved:

Theorem 1.2 ([\[DZ95\]](#page-16-4)). If ρ is a C_b^1 , bounded below probability density on $[0, 1]^2$ then:

$$
\frac{1}{\sqrt{N}}\text{LIS}\big(\text{Sample}_N(\mu_\rho)\big) \underset{N \to \infty}{\longrightarrow} K_\rho
$$

in probability, for some positive constant K_{ρ} *defined by a variational problem.*

This \sqrt{N} behaviour holds more generally when the sampling density is continuous; see Corollary [3.3.](#page-6-0) These results, as well as most of the litterature on the subject, are restricted to the case of a pre-permuton with "regular", bounded density. The goal of this paper is to investigate the asymptotic behaviour of $\text{LIS}(\text{Sample}_N(\mu_\rho))$ when ρ is a probability density on $[0, 1]^2$ satisfying certain types of divergence. We state in Section [2.2](#page-2-0) sufficient conditions on ρ for the quantity $\mathbb{E} [\text{LIS}(\text{Sample}_N(\mu_{\rho}))]$ to be equivalent to any given power of N (between $N^{1/2}$ and N), up to logarithmic factors. We then present in Section [2.3](#page-4-0) a few concentration inequalities for LIS $(\mathrm{Sample}_N(\mu_\rho)).$

Lastly, it might be worth pointing out that growth rates found in this paper can be seen as "intermediate" in the Lastly, it might be worth pointing out that growth rates round in this paper can be seen as 'intermediate' in the theory of pre-permutons. Indeed, we previously explained how the \sqrt{N} behaviour corresponds to a "regula In a forthcoming paper we study under which condition the sampled permutation's longest increasing subsequence behaves linearly in N:

Proposition 1.3 ([\[Dub23\]](#page-16-5)). *Let* µ *be a pre-permuton and define*

$$
LIS(\mu) := \max_{A} \mu(A)
$$

where the maximum is taken over all increasing subsets of [0, 1]² *, in the sense that any pair of its points is* ≺*-increasing with the notation of Section* [2.1.](#page-1-1) Then the function LIS is upper semi-continuous on pre-permutons and satisfies

$$
\frac{1}{N} \text{LIS}\big(\text{Sample}_N(\mu)\big) \xrightarrow[N \to \infty]{} \widetilde{\text{LIS}}(\mu) \quad \text{almost surely}.
$$

2 Our results

2.1 Some notation

Throughout the paper, the only order on the plane we consider is the partial order \prec defined by:

for all $(x_1, y_1), (x_2, y_2) \in \mathbb{R}^2$, $(x_1, y_1) \prec (x_2, y_2)$ if and only if $x_1 < x_2$ and $y_1 < y_2$.

We also write dist for the L^1 -distance in the plane, namely:

for all
$$
(x_1, y_1), (x_2, y_2) \in \mathbb{R}^2
$$
, $dist((x_1, y_1), (x_2, y_2)) := |x_1 - x_2| + |y_1 - y_2|$,

and denote by Δ the diagonal of the unit square $[0, 1]^2$. We use the symbol N for the set of non-negative integers and N ∗ for the set of positive integers.

Consider points X_1, \ldots, X_N in the unit square $[0, 1]^2$ whose x-coordinates and y-coordinates are all distinct. Then the quantity $\text{LIS}(\text{Perm}(X_1, \ldots, X_N))$ is easily read on the visual representation: it is the maximal size of an increasing subset of these points, *i.e.* the maximal number of points forming an up-right path. For this reason and to simplify notation, we write $LIS(X_1, \ldots, X_N)$ for this quantity.

Finally, we use the symbols $\tilde{O}, \tilde{\Theta}, \tilde{\Omega}$ for asymptotic comparisons up to logarithmic factors: if $(a_n), (b_n)$ be two sequences of positive real numbers, we write $a_n = \widetilde{O}(b_n)$ as $n \to \infty$ when there exist constants $c_1 > 0$ and $c_2 \in \mathbb{R}$ such that for some integer n_0 :

for all
$$
n \ge n_0
$$
, $a_n \le c_1 \log(n)^{c_2} b_n$.

We also write $a_n = \tilde{\Omega}(b_n)$ when $b_n = \tilde{O}(a_n)$, and $a_n = \tilde{\Theta}(b_n)$ when simultaneously $a_n = \tilde{O}(b_n)$ and $a_n = \tilde{\Omega}(b_n)$.

2.2 First moment asymptotics of the longest increasing subsequence

Our main results are two conditions on the divergence of the pre-permuton density that imply a large growth rate for the longest increasing subsequences in the sampled permutations. First we study densities diverging at a single point (see the left hand side of fig. [2\)](#page-2-1) and then we study densities diverging along the diagonal (see the right hand side of fig. [2\)](#page-2-1).

Suppose we have a divergence at the north-east corner, in a radial way around this point. We show in this case that longest increasing subsequences behave similarly to the continuous density case, up to a logarithmic term.

Theorem 2.1. *Suppose the density* ρ *is continuous on* $[0, 1]^2 \setminus \{(1, 1)\}$ *and satisfies*

$$
\rho(x, y) = \Theta(d^{\alpha}) \quad \text{as} \quad (x, y) \to (1, 1)
$$

where $d := dist((x, y), (1, 1))$ *, for some* $\alpha > -2$ *. Then:*

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_\rho)\right)\right] = \underset{N \to \infty}{\widetilde{\Theta}} \left(\sqrt{N}\right).
$$

Figure 3: A representation of the permuton $\mu_{\beta,\gamma}^{\gamma}$. Here, dark blue indicates a high value while light blue indicates a low value of the density.

Note that the condition $\alpha > -2$ is necessary for integrability. In order to see long increasing subsequences appear in the sampled permutations, we will "pinch" the density along the diagonal when approaching the north-east corner. This will force sampled points to concentrate along the diagonal, thus likely forming increasing subsequences, and allow for sharper divergence exponents.

Theorem 2.2. *Suppose the density* ρ *is continuous on* $[0, 1]^2 \setminus \{(1, 1)\}$ *and satisfies*

$$
\rho(x,y) = \Theta\left(d^{\frac{\beta}{1-\beta}}\exp\left(-c|x-y|d^{\frac{\beta}{1-\beta}}\right)\right) \quad \text{as} \quad (x,y) \to (1,1)
$$

where $d := dist((x, y), (1, 1))$ *, for some* $\beta \in]1, 2[$ *and* $c > 0$ *. Then:*

$$
\mathbb{E}\left[\text{LIS}\big(\text{Sample}_N(\mu_\rho)\big)\right] = \bigoplus_{N \to \infty} \left(N^{1/\beta}\right).
$$

Note that when β varies between 1 and 2, the exponent $\frac{\beta}{1-\beta}$ varies between $-\infty$ and -2 . Note also that such densities exist by integrability of the estimate.

These previous results rely on a family of "reference" pre-permutons (*permutons* actually, see Section [2.4\)](#page-5-0) that we now introduce. Fix two parameters $\beta > 1$ and $\gamma \in \mathbb{R}$. Define for all positive integer $k \geq 1$

$$
u_k := \frac{1}{Z_{\beta,\gamma}} k^{-\beta} \log(k+1)^{\gamma}
$$

where

$$
Z_{\beta,\gamma} := \sum_{k\geq 1} k^{-\beta} \log(k+1)^{\gamma}
$$

,

and then for all non-negative integer $n \geq 0$:

$$
S_n := \sum_{k=1}^n u_k \quad \text{and} \quad R_n := \sum_{k>n} u_k.
$$

Consider the sequence of disjoint boxes

for all
$$
n \in \mathbb{N}^*
$$
, $C_n := [S_{n-1}, S_n]^2$,

covering the diagonal in an increasing manner. We can then define a probability density on the unit square by

$$
\rho_{\beta,\gamma}^{\gamma} := \sum_{k \ge 1} u_k^{-1} \mathbf{1}_{C_k}
$$

and we write $\mu_{\beta,\gamma}^{\gamma}$ for the (pre-)permuton having density $\rho_{\beta,\gamma}^{\gamma}$ with respect to Lebesgue measure on $[0,1]^2$. See fig. [3](#page-3-1) for a representation. When $\gamma = 0$, we drop the subscript γ .

Proposition 2.3. *If* $\beta \in]1,2[$ *and* $\gamma \ge 0$ *then:*

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N\left(\mu_{\beta,\gamma}^{\nearrow}\right)\right)\right] = \underset{N\to\infty}{\widetilde{\Theta}}\left(N^{1/\beta}\right).
$$

If $\beta \geq 2$ *then:*

$$
\mathbb{E}\left[\mathrm{LIS}\left(\mathrm{Sample}_N\left(\mu_{\beta,\gamma}^{\times}\right)\right)\right] = \underset{N\to\infty}{\widetilde{\Theta}}\left(\sqrt{N}\right).
$$

Lastly we state a result concerning densities diverging along the whole diagonal. This provides a different condition than Theorem [2.2](#page-3-0) to obtain a behaviour equivalent to any given power of N (between $N^{1/2}$ and N), up to a logarithmic term.

Theorem 2.4. *Suppose the density* ρ *is continuous on* $[0, 1]^2 \setminus \Delta$ *and satisfies*

$$
\rho(x, y) = \Theta(|x - y|^{\alpha}) \quad \text{as} \quad |x - y| \to 0
$$

for some $\alpha \in]-1,0[$ *. Then:*

$$
\mathbb{E}\left[\text{LIS}\big(\text{Sample}_N(\mu_\rho)\big)\right] = \bigoplus_{N \to \infty} \left(N^{1/(\alpha+2)}\right).
$$

2.3 Concentration around the mean

In this paper we only investigate the mean of $LIS(Sample_N(\mu))$. The reason is that we can easily deduce asymptotic knowledge of the random variable itself from well known concentration inequalities. In our case it is sufficient to use what's usually refered to as Azuma's or McDiarmid's inequality, found in [\[McD89\]](#page-17-4) and whose origin goes back to [\[Azu67\]](#page-16-6). One of its most common use is for the chromatic number of random graphs, but it is also well adapted to the study of longest increasing subsequences as illustrated in [\[Fri98\]](#page-16-2).

Theorem 2.5 (McDiarmid's inequality). Let $N \in \mathbb{N}^*$, X_1, \ldots, X_N be independent random variables with values in *a common space* $\mathcal X$ and $f: \mathcal X^N \to \mathbb R$ *be a function satisfying the bounded differences property:*

for all
$$
i \in [1, N]
$$
 and $x_1, \ldots, x_N, y_i \in \mathcal{X}$, $|f(x_1, \ldots, x_i, \ldots, x_N) - f(x_1, \ldots, y_i, \ldots, x_N)| \leq c$

for some constant $c > 0$ *. Then for any positive number* $\lambda > 0$ *:*

$$
\mathbf{P}\left(\left|f(X_1,\ldots,X_N)-\mathbb{E}\left[f(X_1,\ldots,X_N)\right]\right|>\lambda\right)\leq 2\exp\left(\frac{-2\lambda^2}{Nc^2}\right).
$$

We can apply this to $LIS(X_1, \ldots, X_N)$ where X_1, \ldots, X_N are i.i.d. points distributed under μ , noticing that changing the value of a single point changes the size of the largest increasing subset by at most 1:

Corollary 2.6. *Let* μ *be a pre-permuton. Then for any* $N \in \mathbb{N}^*$ *and* $\lambda > 0$ *:*

$$
\mathbf{P}\left(\left|\mathrm{LIS}\left(\mathrm{Sample}_{N}(\mu)\right)-\mathbb{E}\left[\mathrm{LIS}\left(\mathrm{Sample}_{N}(\mu)\right)\right]\right|>\lambda\right)\leq 2\exp\left(\frac{-2\lambda^{2}}{N}\right).
$$

This concentration inequality is especially useful when $\mathbb{E}\left[\mathrm{LIS}\big(\mathrm{Sample}_N(\mu)\big)\right]$ is of order greater than $\sqrt{N},$ which is for example the case in Theorem [2.2](#page-3-0) when $\beta \in]1,2[$. Corollary [2.6](#page-4-2) then implies that the variable is concentrated around its mean in the sense that

$$
\frac{\text{LIS}(\text{Sample}_N(\mu))}{\mathbb{E}\left[\text{LIS}(\text{Sample}_N(\mu))\right]} \underset{N \to \infty}{\longrightarrow} 1
$$

in probability. Moreover LIS (Sample_N (μ)) admits a median of order $\Theta(N^{1/\beta})$, and an analogous remark holds for Theorem [2.4.](#page-4-1) One could then apply the following sharper concentration inequality:

Theorem 2.7 (Talagrand's inequality for longest increasing subsequences). Let μ be a pre-permuton. For any $N \in \mathbb{N}^*$, *denote by* M_N *a median of* $L_N := \text{LIS}\big(\text{Sample}_N(\mu)\big)$. Then for all $\lambda > 0$:

$$
\mathbf{P}\left(L_N \ge M_N + \lambda\right) \le 2\exp\left(\frac{-\lambda^2}{4(M_N + \lambda)}\right) \quad \text{and} \quad \mathbf{P}\left(L_N \le M_N - \lambda\right) \le 2\exp\left(\frac{-\lambda^2}{4M_N}\right).
$$

See Theorem 7.1.2 in [\[Tal95\]](#page-17-3) for the original reference in the case of uniform permutations. The proof works the same for random permutations sampled from pre-permutons. See also [\[Kiw06\]](#page-16-1) for a nice application to longest increasing subsequences in random involutions.

2.4 Discussion

Improvements.

Several hypotheses made in the theorems simplify the calculations but are not crucial to the results. For instance Theorems [2.1](#page-2-2) and [2.2](#page-3-0) could be generalized by replacing the north-east corner with any point in the unit square and the diagonal with any local increasing curve passing through that point, under appropriate hypotheses. A similar remark holds for Theorem [2.4.](#page-4-1) We could also state Proposition [2.3](#page-3-2) for general $\gamma \in \mathbb{R}$, but prefer restricting ourselves to the case $\gamma > 0$ since this is all we need for the proofs of Theorems [2.1](#page-2-2) and [2.2](#page-3-0) and it requires a bit less work.

The necessity of logarithmic terms in our estimates remains an open question. We believe our results could be sharpened in this direction, but our techniques do not seem sufficient to this aim.

Links to permuton and graphon theory.

When μ is a probability measure on $[0, 1]^2$ whose marginals are uniform, we call it a *permuton* [\[GGKK15\]](#page-16-7). The theory of permutons was introduced in $[HKM^+13]$ $[HKM^+13]$ and is now widely studied $[KP13,Muk15,BBF^+22]$ $[KP13,Muk15,BBF^+22]$ $[KP13,Muk15,BBF^+22]$ $[KP13,Muk15,BBF^+22]$. It serves as a scaling limit model for random permutations and is especially useful when investigating models with restriction on the number of occurences of certain patterns $[BBF+18, BBF+20]$ $[BBF+18, BBF+20]$ $[BBF+18, BBF+20]$ $[BBF+18, BBF+20]$. One of its fundamental results is that for any permuton μ , the sequence $(\mathrm{Sample}_N(\mu))_{N \in \mathbb{N}^*}$ almost surely converges in some sense to μ .

Reading this paper does not require any prior knowledge about the litterature on permutons : it is merely part of our motivation for the study of models $\text{Sample}_N(\mu)$. Notice however that considering pre-permutons instead of permutons is nothing but a slight generalization. Indeed, one can associate to any pre-permuton μ a unique permuton $\tilde{\mu}$ such that random permutations sampled from μ or $\tilde{\mu}$ have same law [\[BDMW22\]](#page-16-13).

This paper was partly motivated by [\[McK19\]](#page-17-6), where an analogous problem is tackled for graphons. The theory of graphons for the study of dense graph sequences is arguably the main inspiration at the origin of permuton theory, and there exist numerous bridges between them $[GGKK15,BBD⁺22]$ $[GGKK15,BBD⁺22]$ $[GGKK15,BBD⁺22]$. For example the longest increasing subsequence of permutations corresponds to the clique number of graphs. In [\[DHM15\]](#page-16-15) the authors exhibit a wide family of graphons bounded away from 0 and 1 whose sampled graphs have logarithmic clique numbers, thus generalizing this property of Erdős-Rényi random graphs. In some sense this is analogous to Deuschel and Zeitouni's result on pemutations (Theorem [1.2](#page-1-2) here). In [\[McK19\]](#page-17-6) the author studies graphons allowed to approach the value 1, and proves in several cases that clique numbers behave as a power of N ; the results of the present paper are counterparts for permutations.

2.5 Proof method and organization of the paper

The proofs of Theorems [2.1](#page-2-2) and [2.2](#page-3-0) rely on bounding the density of interest on certain appropriate areas with other densities which are easier to study. This general technique is developped in Section [3](#page-5-1) where we prove two lemmas of possible independent interest.

Section [4](#page-7-0) is devoted to our reference permutons, which are the main ingredient when bounding general densities. The idea for the proof of Proposition [2.3](#page-3-2) is that points sampled from $\mu_{\beta,\gamma}^{\gamma}$ are uniformly sampled on each box C_n . We can thus use Theorem [1.1](#page-0-0) on each box containing enough points, the latter property being studied through appropriate concentration inequalities on binomial variables.

We then prove Theorems [2.1](#page-2-2) and [2.2](#page-3-0) in Section [5,](#page-11-0) using all the previously developped tools.

Finally, we prove Theorem [2.4](#page-4-1) in Section [6.](#page-14-0) This proof does not use the previous techniques and rather uses a grid on the unit square that gets thinner as $N \to \infty$. The main idea is to bound the number of points appearing in any increasing sequence of boxes. The sizes of the boxes are chosen so that a bounded number of points appear in each box, and concentration inequalities are used to make sure such approximations hold simultaneously on every box.

3 Bounds on LIS from bounds on the density

One of the main ideas for the proofs of Theorems [2.1](#page-2-2) and [2.2](#page-3-0) is to deduce bounds on the order of LIS from bounds on the sampling density. We state here two useful lemmas to this aim.

Lemma 3.1. *Suppose* f, g *are two probability densities on* $[0, 1]^2$ *such that* $f \geq \varepsilon g$ *for some* $\varepsilon > 0$ *. Then:*

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_f)\right)\right] = \underset{N \to \infty}{\Omega} \left(\mathbb{E}\left[\text{LIS}\left(\text{Sample}_{\lfloor \varepsilon N\rfloor}(\mu_g)\right)\right]\right).
$$

Likewise, if $f \leq Mg$ *for some* $M > 0$ *then*

$$
\mathbb{E}\left[\text{LIS}\big(\text{Sample}_N(\mu_f)\big)\right] = \underset{N\to\infty}{O} \left(\mathbb{E}\left[\text{LIS}\big(\text{Sample}_{\lceil MN\rceil}(\mu_g)\big)\right]\right).
$$

Proof. Let us deal with the first assertion of the lemma. We can write

$$
f = \varepsilon g + (1 - \varepsilon)h
$$

for some other probability density h on the unit square. The idea is to use a coupling between those densities. Let $N \in \mathbb{N}^*$ and B_1, \ldots, B_N be i.i.d. Bernoulli variables of parameter $\varepsilon, Y_1, \ldots, Y_N$ be i.i.d. random points distributed under density g, and Z_1, \ldots, Z_N be i.i.d. random points distributed under density h, all independent. Then define for all i between 1 and N :

$$
X_i := Y_i B_i + Z_i (1 - B_i).
$$

It is clear that X_1, \ldots, X_N are distributed as N i.i.d. points under density f. Let I be the set of indices i for which $B_i = 1$. Then

$$
LIS(X_1, \ldots, X_N) \geq LIS(Y_i, i \in I).
$$

Hence, if S_N denotes an independent binomial variable of parameter (N, ε) :

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_f)\right)\right] \geq \mathbb{E}\left[\text{LIS}\left(\text{Sample}_{S_N}(\mu_g)\right)\right] \geq \mathbb{E}\left[\text{LIS}\left(\text{Sample}_{\lfloor \epsilon N \rfloor}(\mu_g)\right)\right] \mathbf{P}(S_N \geq \epsilon N)
$$

where that last probability is bounded away from 0. This concludes the proof of the first assertion. The second one is a simple rewriting of it. \Box

Lemma 3.2. Suppose f, g, h are probability densities on $[0, 1]^2$ such that $f \leq c_1g + c_2h$ for some $c_1, c_2 > 0$. Then

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_f)\right)\right] = \bigcap_{N \to \infty} \left(\mathbb{E}\left[\text{LIS}\left(\text{Sample}_{\lceil MN \rceil}(\mu_g)\right)\right] + \mathbb{E}\left[\text{LIS}\left(\text{Sample}_{\lceil MN \rceil}(\mu_h)\right)\right]\right)
$$

for some constant $M > 0$ *.*

Proof. First write $c_1g+c_2h = M(\lambda g+(1-\lambda)h)$ with appropriate $M > 0$ and $\lambda \in]0,1[$. Applying lemma Lemma [3.1](#page-5-2) gives us:

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_f)\right)\right] = \bigcap_{N\to\infty} \left(\mathbb{E}\left[\text{LIS}\left(\text{Sample}_{\lceil MN\rceil}\left(\mu_{\lambda g + (1-\lambda)h}\right)\right)\right]\right).
$$

We once again use a coupling argument. Let $N \in \mathbb{N}^*$ and $B_1, \ldots, B_{\lceil MN \rceil}$ be i.i.d. Bernoulli variables of parameter λ , $Y_1, \ldots, Y_{\lceil MN \rceil}$ be i.i.d. random points distributed under density g, and $Z_1, \ldots, Z_{\lceil MN \rceil}$ be i.i.d. random points distributed under density h, all independent. Then define for all integer i between 1 and $\lfloor MN \rfloor$:

$$
X_i := Y_i B_i + Z_i (1 - B_i).
$$

It is clear that $X_1, \ldots, X_{\lfloor MN \rfloor}$ are distributed as $\lfloor MN \rfloor$ i.i.d. points under density $\lambda g + (1 - \lambda)h$. Moreover

$$
LIS(X_1, \ldots, X_{\lceil MN \rceil}) \leq LIS(Y_1, \ldots, Y_{\lceil MN \rceil}) + LIS(Z_1, \ldots, Z_{\lceil MN \rceil})
$$

whence

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_{\lceil MN\rceil}\left(\mu_{\lambda g + (1-\lambda)h}\right)\right)\right] \leq \mathbb{E}\left[\text{LIS}\left(\text{Sample}_{\lceil MN\rceil}\left(\mu_g\right)\right)\right] + \mathbb{E}\left[\text{LIS}\left(\text{Sample}_{\lceil MN\rceil}\left(\mu_h\right)\right)\right].
$$

This concludes the proof.

Before moving on, we state a direct consequence of Lemma [3.1.](#page-5-2)

Corollary 3.3. Let f be a continuous probability density on $[0, 1]^2$. Then:

$$
\mathbb{E}\left[\mathrm{LIS}\big(\mathrm{Sample}_N(\mu_f)\big)\right] = \mathop{\Theta}_{N \to \infty} \left(\sqrt{N}\right).
$$

 \Box

Proof. Since f is continuous on $[0, 1]^2$, there exists $M > 0$ satisfying $f \leq M$. Using Theorem [1.1](#page-0-0) and Lemma [3.1](#page-5-2) we get:

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_f)\right)\right] = O\left(\ell_{\lceil M N \rceil}\right) = O\left(\sqrt{N}\right)
$$

as $N \to \infty$. Then, f also being non-zero, there exists $\varepsilon > 0$ and a square box C contained in $[0,1]^2$ such that $f \ge \varepsilon$ on C. Since random points uniformly sampled in C yield uniformly random permutations, Theorem [1.1](#page-0-0) and Lemma [3.1](#page-5-2) imply:

$$
\mathbb{E}\left[\mathrm{LIS}\big(\mathrm{Sample}_N(\mu_f)\big)\right] = \Omega\left(\mathbb{E}\left[\mathrm{LIS}\big(\mathrm{Sample}_{\lfloor\varepsilon \mathrm{Leb}(C)N\rfloor}(\mathrm{Leb}_C)\big)\right]\right) = \Omega\left(\ell_{\lfloor\varepsilon \mathrm{Leb}(C)N\rfloor}\right) = \Omega\left(\sqrt{N}\right)
$$

as $N \to \infty$, where Leb_C denotes the uniform probability measure on C. We have thus proved the desired estimate. \square

4 Study of reference permutons

4.1 Preliminaries

The proof of Proposition [2.3](#page-3-2) hinges on the estimation of binomial variables. We thus state a concentration inequality usually referred to as Bernstein's inequality. If S_n denotes a binomial variable of parameter (n, p) , then:

Lemma 4.1.

for all
$$
t > 0
$$
, $\mathbf{P}(|\mathcal{S}_n - np| \ge t) \le 2 \exp\left(-\frac{-t^2/2}{np(1-p)+t/3}\right)$.

See [\[Ben62,](#page-16-16)[Hoe63\]](#page-16-17) for easy-to-find references and discussion on improvements, and [\[Ber27\]](#page-16-18) for the original one.

Now let us remind some asymptotics related to the quantities S_n and R_n introduced in Section [2.2.](#page-2-0) A short proof is included for completeness.

Lemma 4.2. *For any* $\beta > 1$ *and* $\gamma \in \mathbb{R}$ *we have*

$$
\sum_{k\geq n} k^{-\beta} \log(k+1)^{\gamma} \underset{n\to\infty}{\sim} \frac{n^{1-\beta}}{\beta-1} \log(n)^{\gamma}.
$$

Moreover for any $\beta' < 1$ *:*

$$
\sum_{k=1}^{n} k^{-\beta'} \log(k+1)^{\gamma} \underset{n \to \infty}{\sim} \frac{n^{1-\beta'}}{1-\beta'} \log(n)^{\gamma}.
$$

Proof. First use the integral comparison:

$$
\sum_{k\geq n} k^{-\beta} \log(k+1)^{\gamma} \underset{n\to\infty}{\sim} \int_{n}^{+\infty} x^{-\beta} \log(x+1)^{\gamma} dx
$$

and then an elementary integration by parts

$$
\int_{n}^{+\infty} x^{-\beta} \log(x+1)^{\gamma} dx = \frac{n^{1-\beta}}{\beta-1} \log(n+1)^{\gamma} - \int_{n}^{+\infty} \frac{x^{1-\beta}}{1-\beta} \gamma \frac{1}{x} \log(x+1)^{\gamma-1} dx
$$

$$
= \frac{n^{1-\beta}}{\beta-1} \log(n+1)^{\gamma} + \frac{\gamma}{\beta-1} \int_{n}^{+\infty} x^{-\beta} \log(x+1)^{\gamma-1} dx.
$$

However, the following holds:

$$
\int_{n}^{+\infty} x^{-\beta} \log(x+1)^{\gamma-1} dx = o\left(\int_{n}^{+\infty} x^{-\beta} \log(x+1)^{\gamma} dx\right) \quad \text{as } n \to \infty.
$$

This concludes the proof of the first assertion. The second one is completely similar.

4.2 Proof of Proposition [2.3](#page-3-2)

In this section we fix $\beta > 1$ and $\gamma \ge 0$ and prove Proposition [2.3.](#page-3-2) Consider $N \in \mathbb{N}^*$ and write

$$
L_N := \mathrm{LIS}\left(\mathrm{Sample}_N\left(\mu_{\beta,\gamma}^{\nearrow}\right)\right).
$$

Let X_1, \ldots, X_N be i.i.d. random variables distributed under $\mu_{\beta,\gamma}^{\gamma}$. For each $k \in \mathbb{N}^*$, define

$$
\mathcal{X}_{N,k} := \{X_1, \ldots, X_N\} \cap C_k
$$

and let N_k be the cardinal of $\mathcal{X}_{N,k}$, *i.e.* the number of points appearing in box C_k . Each N_k is a binomial variable of parameter (N, u_k) , and

$$
\sum_{k\geq 1} N_k = N.
$$

Conditionally on N_k , the set $\mathcal{X}_{N,k}$ consists of N_k uniformly random points in C_k . Moreover

$$
LIS(X_1, \ldots, X_N) = \sum_{k \ge 1} LIS(X_{N,k})
$$

thanks to the boxes being placed in an increasing fashion. Hence by taking expectation in the previous line, one obtains

$$
\mathbb{E}\left[L_N\right] = \sum_{k \ge 1} \mathbb{E}\left[\ell_{N_k}\right]
$$

with the notation of Theorem [1.1.](#page-0-0) For some integer k_N to be determined, we will use the following bounds:

$$
\sum_{k=1}^{k_N} \mathbb{E}\left[\ell_{N_k}\right] \le \mathbb{E}\left[L_N\right] \le \sum_{k=1}^{k_N} \mathbb{E}\left[\ell_{N_k}\right] + N \sum_{k>k_N} u_k \tag{1}
$$

where the right hand side was obtained by simply bounding each ℓ_{N_k} for $k > k_N$ with N_k . Using Theorem [1.1,](#page-0-0) fix an integer n_0 such that √ √

for all
$$
n \ge n_0
$$
, $\sqrt{n} \le \ell_n \le 3\sqrt{n}$. (2)

The number k_N appearing in eq. [\(1\)](#page-8-0) must be chosen big enough for the bounds to be tight, but also small enough for eq. [\(2\)](#page-8-1) to be used. By applying Bernstein's inequality (Lemma [4.1\)](#page-7-1) here with an appropriate choice of parameter, we obtain for any $N, k \in \mathbb{N}^*$:

$$
\mathbf{P}\left(|N_k - Nu_k| \ge \log(N)^2 \sqrt{Nu_k}\right) \le 2 \exp\left(-\psi_{N,k}\right) \text{ where } \psi_{N,k} := \frac{\log(N)^4 Nu_k/2}{Nu_k(1 - u_k) + \log(N)^2 \sqrt{Nu_k}/3}. \tag{3}
$$

We are thus looking, for each positive integer N , for k_N satisfying

for any
$$
k \in [1, k_N]
$$
, $N u_k - \log(N)^2 \sqrt{N u_k} \ge n_0$. (4)

Lemma [4.3,](#page-10-0) which we postpone to the end of this section, tells us we can choose k_N satisfying eq. [\(4\)](#page-8-2) and of the order

$$
k_N = \bigoplus_{N \to \infty} \left(\log(N)^{-4/\beta} N^{1/\beta} \right). \tag{5}
$$

Note that k_N may be zero for small values of N. One last step before proceeding with exploiting eq. [\(1\)](#page-8-0) is the study of the probability error term in eq. [\(3\)](#page-8-3). For any positive integer k lower than or equal to k_N , one of the following holds:

• If $Nu_k(1-u_k) \ge \log(N)^2 \sqrt{Nu_k}/3$ then

$$
\psi_{N,k} \ge \frac{\log(N)^4 N u_k/2}{2 N u_k (1 - u_k)} \ge \frac{\log(N)^4}{4}.
$$

• Otherwise

$$
\psi_{N,k} \geq \frac{\log(N)^4 Nu_k/2}{2\log(N)^2 \sqrt{Nu_k}/3} = \frac{3}{4} \log(N)^2 \sqrt{Nu_k} \geq \frac{3}{4} \log(N)^2 \sqrt{n_0}
$$

where we used eq. [\(4\)](#page-8-2) in the last inequality.

Hence there exists a constant $\delta > 0$ such that, for all $N \in \mathbb{N}^*$:

$$
\sup_{1 \le k \le k_N} \exp(-\psi_{N,k}) \le \exp(-\delta \log(N)^2). \tag{6}
$$

We now distinguish between the cases $\beta \in]1,2[$ and $\beta \ge 2$.

First suppose $\beta \in]1,2[$. Let us begin with the upper bound of eq. [\(1\)](#page-8-0). On the one hand:

$$
N\sum_{k>k_N} u_k = \Theta\left(Nk_N^{1-\beta} \log(k_N)^{\gamma}\right) = \Theta\left(\log(N)^{4-4/\beta+\gamma} N^{1/\beta}\right)
$$
\n(7)

as $N \to +\infty$, using Lemma [4.2](#page-7-2) and eq. [\(5\)](#page-8-4). On the other hand for each $k \in [1, k_N]$:

$$
\mathbb{E} [\ell_{N_k}] = \mathbb{E} \left[\ell_{N_k} \mathbf{1}_{|N_k - N u_k| < \log(N)^2 \sqrt{Nu_k}} \right] + \mathbb{E} \left[\ell_{N_k} \mathbf{1}_{|N_k - N u_k| \ge \log(N)^2 \sqrt{Nu_k}} \right]
$$
\n
$$
\le 3\sqrt{Nu_k + \log(N)^2 \sqrt{Nu_k}} + N \mathbf{P} \left(|N_k - Nu_k| \ge \log(N)^2 \sqrt{Nu_k} \right)
$$
\n
$$
\le 3\sqrt{Nu_k} + 3\log(N)(Nu_k)^{1/4} + 2N \exp(-\delta \log(N)^2)
$$

where we used eqs. [\(2\)](#page-8-1) to [\(4\)](#page-8-2) and [\(6\)](#page-9-0), and the inequality $\sqrt{a+b} \le \sqrt{a}$ + √ b for any $a, b \geq 0$. Summing and using Lemma [4.2](#page-7-2) and eq. [\(5\)](#page-8-4), we get

$$
\sum_{k=1}^{k_N} \mathbb{E} \left[\ell_{N_k} \right] \leq 3\sqrt{N} \sum_{k=1}^{k_N} \sqrt{u_k} + 3\log(N) N^{1/4} \sum_{k=1}^{k_N} u_k^{1/4} + 2Nk_N \exp\left(-\delta \log(N)^2 \right) \n= 3\sqrt{N} \Theta \left(k_N^{1-\beta/2} \log(k_N)^{\gamma/2} \right) + 3\log(N) N^{1/4} \Theta \left(k_N^{1-\beta/4} \log(k_N)^{\gamma/4} \right) + o(1) \n= \Theta \left(\log(N)^{2-4/\beta+\gamma/2} N^{1/\beta} \right).
$$
\n(8)

as $N \to +\infty$. This last upper bound along with eq. [\(7\)](#page-9-1) yields, in eq. [\(1\)](#page-8-0):

$$
\mathbb{E}\left[L_N\right] = O\left(\log(N)^{4-4/\beta+\gamma} N^{1/\beta}\right) \quad \text{as } N \to \infty. \tag{9}
$$

Now let's turn to the lower bound of eq. [\(1\)](#page-8-0), for which the calculations are simpler. For any $k \in [1, k_N]$:

$$
\mathbb{E}[\ell_{N_k}] \ge \mathbb{E}\left[\ell_{N_k} \mathbf{1}_{|N_k - N u_k| < \log(N)^2 \sqrt{N u_k}}\right] \ge \sqrt{n_0} \left(1 - 2\exp(-\psi_{N,k})\right)
$$

using eqs. (2) to (4) . Then by summing and using eqs. (5) and (6) :

$$
\mathbb{E}[L_N] \ge k_N \sqrt{n_0} \left(1 - 2 \exp\left(-\delta \log(N)^2\right)\right) = \Omega\left(\log(N)^{-4/\beta} N^{1/\beta}\right)
$$

as $N \to +\infty$. This lower bound, along with eq. [\(9\)](#page-9-2), concludes the proof of Proposition [2.3](#page-3-2) when $\beta \in]1,2[$.

Now suppose $\beta \ge 2$. The upper bound is very similar to the case $\beta \in]1,2[$, but with the appropriate asymptotics. Namely for any $\beta' \geq 1$ and $\gamma' \geq 0$ one has:

$$
\sum_{k=1}^{n} k^{-\beta'} \log(k+1)^{\gamma'} = O\left(\log(n)^{1+\gamma'}\right) \quad \text{as } n \to \infty.
$$
 (10)

On the one hand eq. [\(7\)](#page-9-1) still holds and we can thus write

$$
N\sum_{k>k_N} u_k = \widetilde{O}\left(\sqrt{N}\right) \quad \text{as } N \to \infty. \tag{11}
$$

On the other hand the first line of eq. [\(8\)](#page-9-3) is still valid and we obtain, as $N \to \infty$:

$$
\sum_{k=1}^{k_N} \mathbb{E} \left[\ell_{N_k} \right] \leq 3\sqrt{N} \sum_{k=1}^{k_N} \sqrt{u_k} + 3 \log(N) N^{1/4} \sum_{k=1}^{k_N} u_k^{1/4} + 2Nk_N \exp\left(-\delta \log(N)^2 \right)
$$

\n
$$
\leq \sqrt{N} O\left(\log(N)^{1+\gamma/2} \right) + \log(N) N^{1/4} \max\left(O\left(\log(N)^{1+\gamma/4} \right), \Theta\left(k_N^{1-\beta/4} \log(k_N)^{\gamma/4} \right) \right) + o(1)
$$

\n
$$
= O\left(\log(N)^{1+\gamma/2} \sqrt{N} \right) + \max\left(O\left(\log(N)^{2+\gamma/4} N^{1/4} \right), \Theta\left(\log(N)^{2-4/\beta+\gamma/4} N^{1/\beta} \right) \right)
$$

\n
$$
= \widetilde{O}\left(\sqrt{N}\right)
$$

using eqs. [\(5\)](#page-8-4) and [\(10\)](#page-9-4) and distinguishing between the cases $\beta \ge 4$ and $\beta < 4$ on the second line. Along with [\(11\)](#page-10-1), this yields the desired upper bound when injected in [\(1\)](#page-8-0).

The lower bound, on the contrary, requires no calculation. Indeed, bound below $\rho_{\beta,\gamma}^{\gamma}$ by u_1f where f denotes the uniform density on the square C_1 . Since sampled permutations from density f are uniform, we deduce from Theorem [1.1](#page-0-0) and Lemma [3.1](#page-5-2) that

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N\left(\mu_{\beta,\gamma}^{\chi}\right)\right)\right] = \Pr_{N\to\infty}\left(\ell_{\lfloor u_1N\rfloor}\right) = \Pr_{N\to\infty}\left(\sqrt{N}\right).
$$

All that is left for the proof of Proposition [2.3](#page-3-2) to be complete is the previously announced lemma about k_N .

Lemma 4.3. *Condition [\(4\)](#page-8-2) holds true for some* $k_N = \bigoplus_{N \to +\infty} \left(\log(N)^{-4/\beta} N^{1/\beta} \right)$.

Proof. Let $N \in \mathbb{N}^*$. For each integer k:

$$
Nu_k - \log(N)^2 \sqrt{Nu_k} \ge n_0 \Leftrightarrow \begin{cases} Nu_k \ge n_0; \\ Nu_k - n_0 \ge \log(N)^2 \sqrt{Nu_k}; \end{cases}
$$

$$
\Leftrightarrow \begin{cases} Nu_k \ge n_0; \\ N^2 u_k^2 + n_0^2 - 2Nu_k n_0 \ge \log(N)^4 Nu_k; \end{cases}
$$

$$
\Leftrightarrow \begin{cases} u_k \ge n_0/N; \\ N^2 u_k^2 - N (2n_0 + \log(N)^4) u_k + n_0^2 \ge 0. \end{cases}
$$

This last polynomial in the variable u_k has discriminant $\Delta_N = N^2 (\log(N)^8 + 4n_0 \log(N)^4) \ge 0$. Let x_N be its greatest root. Then √

$$
x_N = \frac{N\left(2n_0 + \log(N)^4\right) + \sqrt{\Delta_N}}{2N^2} \sum_{N \to \infty} \frac{\log(N)^4}{N}.
$$

A sufficient condition for $Nu_k - \log(N)^2 \sqrt{Nu_k} \ge n_0$ to hold is $u_k \ge \max(n_0/N, x_N)$. However

$$
u_k = \frac{1}{Z_{\beta,\gamma}} k^{-\beta} \log(k+1)^{\gamma} \ge c_0 k^{-\beta}
$$

for $c_0 := \log(2)^\gamma / Z_{\beta,\gamma}$, so a sufficient condition is

$$
k \leq c_0^{1/\beta} \max (n_0/N, x_N)^{-1/\beta}
$$

.

Hence the announced estimate for k_N .

 \Box

5 Study of densities diverging at a single point

5.1 Lower bound of Theorem [2.2](#page-3-0)

This bound is quite direct thanks to Lemma [3.1](#page-5-2) and the previous study of μ_β^{γ} . We will use the notation of Section [2.2](#page-2-0) with the same β as in Theorem [2.2](#page-3-0) and $\gamma = 0$. Studying ρ on the boxes $(C_n)_{n \in \mathbb{N}^*}$ will be enough to obtain the desired lower bound. Fix $\varepsilon > 0$ and some rank $m_0 \in \mathbb{N}^*$ such that

for all
$$
n \ge m_0
$$
 and $(x, y) \in C_n$, $\rho(x, y) \ge \varepsilon d^{\frac{\beta}{1-\beta}} \exp\left(-c|x-y|d^{\frac{\beta}{1-\beta}}\right)$.

Recall the notation $d := \text{dist}((x, y), (1, 1))$ for $(x, y) \in [0, 1]^2$. Note that, for $(x, y) \in C_n$:

$$
2R_n \le d \le 2R_{n-1} \quad \text{where} \quad R_{n-1}, R_n = \bigoplus_{n \to \infty} \left(n^{1-\beta} \right)
$$

by Lemma [4.2,](#page-7-2) and

$$
|x - y| \le u_n = \bigoplus_{n \to \infty} (n^{-\beta}).
$$

As a consequence, for potentially different values of $\varepsilon > 0$ and $m_0 \in \mathbb{N}^*$ we get

$$
\text{ for all } n \geq m_0 \text{ and } (x, y) \in C_n, \quad \rho(x, y) \geq \varepsilon \rho_{\beta}^{\nearrow}(x, y).
$$

Write g for the probability density on $\cup_{n \geq m_0} C_n$ proportional to ρ_{β}^{\nearrow} . Then by Lemma [3.1:](#page-5-2)

$$
\mathbb{E}\left[\text{LIS}\big(\text{Sample}_N(\mu_\rho)\big)\right] = \bigcap_{N \to \infty} \left(\mathbb{E}\left[\text{LIS}\left(\text{Sample}_{\lfloor \varepsilon N\rfloor}(\mu_g)\right)\right]\right).
$$

Moreover we can obtain

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_g)\right)\right] = \bigoplus_{N \to \infty} \left(N^{1/\beta}\right)
$$

with the same proof as for the reference permuton μ_{β}^{γ} (just start every index at m_0 instead of 1). Finally:

$$
\mathbb{E}\left[\text{LIS}\big(\text{Sample}_N(\mu_\rho)\big)\right] = \underset{N \to \infty}{\widetilde{\Omega}} \left(N^{1/\beta}\right).
$$

5.2 Upper bound of Theorem [2.2](#page-3-0)

This bound is more subtle than the previous one. Indeed, long increasing subsequences could appear outside of the boxes used in Section [5.1.](#page-11-1) Our solution comes in two steps: first consider slightly bigger boxes, and then add an overlapping second sequence of boxes to make sure a whole neighborhood of the diagonal is covered.

We will mainly use the notation of Section [2.2](#page-3-0) with the number β considered in Theorem 2.2 and any negative number $\gamma < 1 - \beta$. In addition to the boxes $(C_n)_{n \in \mathbb{N}^*}$, define sequences

for all
$$
n \in \mathbb{N}^*
$$
, $D_{n+1} := \left[S_n \pm \frac{u_{n+1}}{2}\right]^2$ and $E_n := [S_{n-1}, 1]^2 \setminus \left([S_n, 1]^2 \cup C_n \cup D_{n+1}\right)$.

and their unions

$$
E := \bigcup_{n \ge 1} E_n \quad , \quad C := \bigcup_{n \ge 1} C_n \quad , \quad D := \bigcup_{n \ge 1} D_{n+1}.
$$

See fig. [4](#page-12-0) for a visual representation. Notice how these three areas cover the whole unit square. Let us check that ρ is small outside the diagonal neighborhood $C \cup D$:

for all
$$
n \in \mathbb{N}^*
$$
 and $(x, y) \in E_n$, $|x - y| \ge u_{n+1}/2$ and $R_n \le \text{dist}((x, y), (1, 1)) \le 2R_{n-1}$.

Then using Lemma [4.2,](#page-7-2) we get as $n \to \infty$ uniformly in $(x, y) \in E_n$:

$$
|x - y| = \Omega \left(n^{-\beta} \log(n)^{\gamma} \right)
$$
 and $\text{dist}((x, y), (1, 1)) = \Theta \left(n^{1-\beta} \log(n)^{\gamma} \right)$.

Figure 4: The several areas used to study density ρ in the upper bound of Theorem [2.2.](#page-3-0)

Our hypothesis on ρ now rewrites

$$
\rho(x,y) = O\left(\left(n^{1-\beta}\log(n)^{\gamma}\right)^{\frac{\beta}{1-\beta}}\exp\left(-\Omega\left(n^{-\beta}\log(n)^{\gamma}\left(n^{1-\beta}\log(n)^{\gamma}\right)^{\frac{\beta}{1-\beta}}\right)\right)\right)
$$

$$
= O\left(n^{\beta}\log(n)^{\frac{\gamma\beta}{1-\beta}}\exp\left(-\Omega\left(\log(n)^{\frac{\gamma}{1-\beta}}\right)\right)\right)
$$

$$
= o(1)
$$

since $\frac{\gamma}{1-\beta} > 1$ by choice of γ . In particular ρ is bounded on E, and it reminds to study it on areas C and D. Using Lemma [4.2](#page-7-2) and bounding the exponential term by 1, we get as $n \to \infty$ uniformly in $(x, y) \in C_n \cup D_{n+1}$:

$$
\rho(x,y) = O\left(n^{\beta} \log(n)^{\frac{\gamma \beta}{1-\beta}}\right).
$$

Consequently

$$
\int_{C_n} \rho(x, y) dx dy = O\left(n^{-2\beta} \log(n)^{2\gamma} n^{\beta} \log(n)^{\frac{\gamma \beta}{1-\beta}}\right) = O\left(n^{-\beta} \log(n)^{\gamma \left(2 - \frac{\beta}{\beta - 1}\right)}\right) \quad \text{as } n \to \infty
$$

and likewise

$$
\int_{D_{n+1}} \rho(x, y) dx dy = O\left(n^{-\beta} \log(n)^{\gamma \left(2 - \frac{\beta}{\beta - 1}\right)}\right) \quad \text{as } n \to \infty.
$$

Define $\gamma' := \gamma \left(2 - \frac{\beta}{\beta - 1}\right) > 0$. The previous calculations show that we can find a bound

$$
\rho \le M(f+g+h)
$$

for some $M > 0$, f the uniform density on $[0, 1]^2$, g a probability density on C attributing uniform mass proportionnal to $n^{-\beta} \log(n+1)^{\gamma'}$ to each C_n , and h a probability density on D attributing uniform mass proportionnal to $n^{-\beta} \log(n+1)^{\gamma}$ to each D_{n+1} . Thus by Lemma [3.2](#page-6-1) it suffices to bound the quantities

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_f)\right)\right], \quad \mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_g)\right)\right], \quad \mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_h)\right)\right].
$$

The first term is nothing but the uniform case, so behaves as $\Theta\left(\sqrt{N}\right)$. Let us turn to the second term. Since the sampled permutations of our reference permutons only depend on the masses attributed to each box and not the sizes of these boxes, sampled permutations from μ_g have the same law as sampled permutations from $\mu_{\beta,\gamma'}^{\gamma}$ (see Section [2.4;](#page-5-0) $\mu_{\beta,\gamma'}^{\lambda}$ is the permuton associated to the pre-permuton μ_g). Hence by Proposition [2.3,](#page-3-2) this term behaves as $\tilde{\Theta}(N^{1/\beta})$. The third term is handled the same way. Finally:

$$
\mathbb{E}\left[\text{LIS}\big(\text{Sample}_N(\mu_\rho)\big)\right] = \bigcup_{N\to\infty} \left(N^{1/\beta}\right).
$$

5.3 Proof of Theorem [2.1](#page-2-2)

This section is devoted to the proof of Theorem [2.1.](#page-2-2) We thus consider $\alpha > -2$ and suppose ρ is as in the theorem. Since we want an upper bound on the longest increasing subsequences, we need to find appropriate areas to bound ρ on. For this define $\beta > 1$ by

$$
-\alpha = 2 - \frac{1}{\beta - 1} \quad i.e. \quad \alpha(1 - \beta) + 1 - 2\beta = -2. \tag{12}
$$

We use the notation of Section [2.2](#page-2-0) for this value of β and $\gamma = 0$. We shall bound ρ on the boxes $(C_n)_{n \in \mathbb{N}^*}$ as well as on the adjacent rectangles:

for all
$$
n \in \mathbb{N}^*
$$
, $D_n^{(1)} := [S_{n-1}, S_n] \times [S_n, 1]$ and $D_n^{(2)} := [S_n, 1] \times [S_{n-1}, S_n]$.

The sequences $(C_n)_{n \in \mathbb{N}^*}$, $(D_n^{(1)})_{n \in \mathbb{N}^*}$, $(D_n^{(2)})_{n \in \mathbb{N}^*}$ form a partition of the unit square. As in the upper bound of Theorem [2.2,](#page-3-0) we need to compute the masses attributed by ρ to each of these boxes. For this notice that

for all
$$
n \in \mathbb{N}^*
$$
 and $(x, y) \in C_n \cup D_n^{(1)} \cup D_n^{(2)}$, $R_n \leq \text{dist}((x, y), (1, 1)) \leq 2R_{n-1}$.

Hence

$$
\int_{C_n} \rho(x, y) dx dy = \Theta\left(n^{\alpha(1-\beta)} n^{-2\beta}\right) = \Theta\left(n^{-3}\right) \quad \text{as } n \to \infty
$$

and

for
$$
i = 1, 2
$$
,
$$
\int_{D_n^{(i)}} \rho(x, y) dx dy = \Theta\left(n^{\alpha(1-\beta)} n^{-\beta} n^{1-\beta}\right) = \Theta\left(n^{-2}\right) \text{ as } n \to \infty
$$

by eq. [\(12\)](#page-13-0). Using Lemma [3.2,](#page-6-1) it suffices to bound the quantities

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_f)\right)\right], \quad \mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_g)\right)\right], \quad \mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_h)\right)\right]
$$

where f is the probability density on C attributing uniform mass proportional to n^{-3} to each C_n and g (resp. h) is the probability density on $D^{(1)}$ (resp. $D^{(2)}$) attributing uniform mass proportional to n^{-2} to each $D_n^{(1)}$ (resp. $D_n^{(2)}$). Considering the reference permuton μ_3^{λ} of parameter (3,0), Proposition [2.3](#page-3-2) tells us

$$
\mathbb{E}\left[\mathrm{LIS}\left(\mathrm{Sample}_N(\mu_3^{\nearrow})\right)\right] = \underset{N \to \infty}{\widetilde{\Theta}}\left(\sqrt{N}\right).
$$

Since μ_3^{γ} attributes the same masses to the boxes of its support as density f attributes to its own, sampled permutations from both pre-permutons have same law (the same remark as in the upper bound of Theorem [2.2](#page-3-0) holds; μ_3^{γ} is the permuton associated to the pre-permuton μ_f). Consequently:

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_f^{\nearrow})\right)\right] = \underset{N \to \infty}{\widetilde{\Theta}} \left(\sqrt{N}\right).
$$

The case of density g is similar but with a slight alteration. Indeed, considering the reference permuton μ_2^{γ} of parameter (2, 0), Proposition [2.3](#page-3-2) tells us

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_2^{\lambda})\right)\right] = \underset{N \to \infty}{\widetilde{\Theta}}\left(\sqrt{N}\right). \tag{13}
$$

Note that μ_2^{γ} attributes the same masses to the boxes of its support as density g attributes to its own. A key difference here is that the rectangle boxes $D_n^{(1)}$ are not placed increasingly inside the unit square, so sampled permutations from permuton μ_2^{γ} and density g do not have the same law. To work around this problem, we can use an appropriate coupling. Take random i.i.d. points X_1, \ldots, X_N distributed under density g. Consider, for each $n \in \mathbb{N}^*$, the affine transformation a_n mapping D_n^1 to C_n and assemble them into a function a from $\cup_{n\geq 1} D_n^1$ to $\cup_{n\geq 1} C_n$. Then the image points $a(X_1), \ldots, a(X_N)$ are i.i.d. under the measure μ_2^{\nearrow} . Moreover, each increasing subset of $\{X_1, \ldots, X_N\}$ is mapped to an increasing subset of $\{a(X_1), \ldots, a(X_N)\}\$. This coupling argument shows that $\text{LIS}(\text{Sample}_N(\mu_g))$ is stochastically dominated by $\text{LIS}(\text{Sample}_N(\mu_2^{\lambda}))$, and eq. [\(13\)](#page-13-1) then implies:

$$
\mathbb{E}\left[\text{LIS}\big(\text{Sample}_N(\mu_g)\big)\right] = \underset{N \to \infty}{\widetilde{O}}\left(\sqrt{N}\right).
$$

Density h is handled the same way. Hence:

$$
\mathbb{E}\left[\mathrm{LIS}\big(\mathrm{Sample}_N(\mu_\rho)\big)\right] = \mathop{\textstyle \int}\limits_{N\to\infty} \left(\sqrt{N}\right).
$$

To conclude the proof of Theorem [2.1,](#page-2-2) the lower bound is obtained as a direct consequence of Lemma [3.1](#page-5-2) using the uniform case (see the proof of Corollary [3.3\)](#page-6-0).

6 Study of densities diverging along the diagonal

6.1 Lower bound of Theorem [2.4](#page-4-1)

From now on we consider a density ρ satisfying the hypothesis of Theorem [2.4](#page-4-1) for some exponent $\alpha \in]-1,0[$. As explained in Section [2.5,](#page-5-3) the idea is to slice the unit square into small boxes and investigate the number of sampled points appearing in appropriate increasing sequences of boxes. Let $N \in \mathbb{N}^*$ and take random i.i.d. points X_1, \ldots, X_N distributed under density ρ . Set

$$
b_N := \left\lfloor N^{1/(\alpha+2)} \right\rfloor,
$$

and define a family of b_N^2 identical boxes by

$$
\text{for all } (i,j) \in [\![1,b_N]\!]^2, \quad C_{i,j} := \left[\frac{(i-1)}{b_N}, \frac{i}{b_N}\right] \times \left[\frac{(j-1)}{b_N}, \frac{j}{b_N}\right].
$$

This covering of the unit square will be useful for the upper bound, while the lower bound aimed for in this section only requires using the increasing sequence of boxes $(C_{k,k})_{k\in[1,b_N]}$. More precisely, we make use of the inequality

$$
LIS(X_1, ..., X_N) \ge \sum_{k=1}^{b_N} \mathbf{1}_{N_k \ge 1}
$$
\n(14)

where each N_k denotes the number of points among X_1, \ldots, X_N in $C_{k,k}$. Thanks to the hypothesis made on ρ , we can fix δ , $\varepsilon > 0$ such that

$$
\text{ for all } (x,y) \in [0,1]^2 \text{ satisfying } |x-y| < \delta, \quad \rho(x,y) \geq \varepsilon |x-y|^\alpha.
$$

Now suppose N is big enough to have $b_N^{-1} < \delta$ and compute, for any $k \in [1, b_N]$:

$$
m_k := \iint_{C_{k,k}} \rho(x,y) dx dy \ge \iint_{C_{k,k}} \varepsilon |x-y|^\alpha dx dy = \varepsilon \int_0^{b_N^{-1}} dx \int_{-x}^{b_N^{-1}-x} dz |z|^\alpha
$$

= $\varepsilon \int_0^{b_N^{-1}} dx \left(\frac{x^{\alpha+1}}{\alpha+1} + \frac{(b_N^{-1}-x)^{\alpha+1}}{\alpha+1} \right) = \frac{2\varepsilon}{(\alpha+1)(\alpha+2)} b_N^{-(\alpha+2)} = \frac{\Omega}{N \to \infty} \left(\frac{1}{N} \right).$

Hence there exists $\eta > 0$ satisfying:

$$
\text{ for all } N \in \mathbb{N}^* \text{ and } k \in [\![1,b_N]\!], \quad m_k \geq \frac{\eta}{N}.
$$

Since N_k follows a binomial law of parameter (N, m_k) , we thus have :

$$
\mathbf{P}(N_k = 0) = (1 - m_k)^N \le (1 - \eta/N)^N \xrightarrow[N \to \infty]{} e^{-\eta} < 1.
$$

Consequently there exists a constant $p_0 > 0$ such that

for any big enough
$$
N \in \mathbb{N}^*
$$
 and all $k \in [1, b_N]$, $\mathbf{P}(N_k \ge 1) \ge p_0$.

Hence for big enough N , using eq. [\(14\)](#page-14-1):

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_{\rho})\right)\right] \geq \mathbb{E}\left[\sum_{k=1}^{b_N} \mathbf{1}_{N_k \geq 1}\right] \geq \sum_{k=1}^{b_N} p_0 = p_0 b_N = \Omega_{N \to \infty}\left(N^{1/(\alpha+2)}\right).
$$

6.2 Upper bound of Theorem [2.4](#page-4-1)

We use the same notation as in last section, but this time we investigate the whole grid $(C_{i,j})_{i,j\in[\![1,b_N]\!]}$. Say a sequence of distinct boxes

$$
\mathcal{C} = (C_{i_1,j_1},\ldots,C_{i_n,j_n})
$$

is increasing whenever

for all
$$
k \in [1, n-1]
$$
, $i_k \le i_{k+1}$ and $j_k \le j_{k+1}$.

When this happens, one has $n < 2b_N$. Indeed, when browsing the sequence, each coordinate increases at most $b_N - 1$ times. Write

$$
\mathcal{X} := \{X_1, \ldots, X_N\}.
$$

Then, for any box C, denote by \mathcal{X}_C the set of points in X appearing in C and, for any increasing sequence of boxes C, denote by $\mathcal{X}_{\mathcal{C}}$ the set of points in \mathcal{X} appearing in some box of \mathcal{C} . We aim to make use of the inequality

$$
LIS(\mathcal{X}) \le \sup_{\mathcal{C} \text{ increasing sequence of boxes}} |\mathcal{X}_{\mathcal{C}}| \tag{15}
$$

since the family of boxes occupied by an increasing subset of points necessarily rearranges as an increasing sequence of boxes. Now, thanks to the hypothesis made on ρ , let $M > 0$ be such that

for all
$$
(x, y) \in [0, 1]^2
$$
, $\rho(x, y) \le M|x - y|^{\alpha}$.

Since this latter function puts more mass on the diagonal boxes than the outside ones, we have:

for any
$$
(i, j) \in [\![1, b_N]\!]^2
$$
, $\iint_{C_{i,j}} \rho(x, y) dx dy \le \iint_{C_{i,j}} M |x - y|^\alpha dx dy$
 $\le M \int_0^{b_N^{-1}} \int_0^{b_N^{-1}} |x - y|^\alpha dx dy = \frac{2M}{(\alpha + 1)(\alpha + 2)} b_N^{-(\alpha + 2)} = \int_0^{\infty} (1/N).$

Thus there exists $M' > 0$ such that, for big enough N, each variable $|\mathcal{X}_{C_{i,j}}|$ is stochastically dominated by the law $Bin(N, M'/N)$. Additionally Lemma [4.1](#page-7-1) gives, denoting by S_N a random variable of law $Bin(N, M'/N)$:

$$
\mathbf{P}\left(|\mathcal{S}_N - M'| \ge \log(N)^2 \sqrt{M'}\right) \le 2 \exp\left(-\psi_N\right)
$$

where
$$
\psi_N = \frac{\log(N)^4 M'/2}{M'(1 - M'/N) + \log(N)^2 \sqrt{M'}/3} = \mathop{\Theta}_{N \to \infty} (\log(N)^2).
$$

This inequality, along with the aforementioned stochastic domination, implies that for big enoug N :

$$
\mathbf{P}\left(\forall (i,j),\ |\mathcal{X}_{C_{i,j}}| \leq M' + \log(N)^2\sqrt{M'}\right) \geq 1 - 2b_N^2 \exp(-\psi_N).
$$

Hence, using the fact that an increasing sequence of boxes contains at most $2b_N$ boxes:

P (for any increasing sequence of boxes C, $|\mathcal{X}_c| \le 2b_N \left(M' + \log(N)^2\right)$) $\left(\overline{M'}\right)\Bigr)\geq 1-2b_N^2\exp(-\psi_N)$

and then, by eq. [\(15\)](#page-15-0):

$$
\mathbf{P}\left(\text{LIS}(\mathcal{X}) \leq 2b_N\left(M' + \log(N)^2\sqrt{M'}\right)\right) \geq 1 - 2b_N^2\exp(-\psi_N).
$$

To conclude the proof of Theorem [2.4,](#page-4-1) it suffices to write:

$$
\mathbb{E}\left[\text{LIS}\left(\text{Sample}_N(\mu_{\rho})\right)\right] \leq 2b_N\left(M' + \log(N)^2\sqrt{M'}\right) + 2b_N^2N\exp(-\psi_N) = \widetilde{O}\left(N^{1/(\alpha+2)}\right).
$$
