# GENERATING FUNCTIONS OF DUAL K-THEORETIC P- AND Q-FUNCTIONS AND BOSON-FERMION CORRESPONDENCE

ABSTRACT. We present a new algebraic description of the dual K-theoretic P-function  $gq_\lambda$  and the dual K-theoretic Q-function  $gp_\lambda$ . Using a "β-deformed version" of the boson-fermion correspondence, these functions are realized as the bosonic counterparts to certain bases of the neutral fermion Fock space. This result generalizes Date-Jimbo-Miwa's neutral-fermionic presentation of the Schur P-function and the Q-function, developed in their study of the BKP-equation. As a corollary, we derive a generating function of  $gq<sub>\lambda</sub>$ , which was previously conjectured by Nakagawa-Naruse. Additionally, we provide a generating function of  $gp_\lambda$ .

### 1. INTRODUCTION

This paper is a continuation of the author's previous work [\[8\]](#page-14-0), in which he provided a fermionic description of the K-Q-function  $GQ_\lambda$  (see §[1.1\)](#page-0-0). In [\[8\]](#page-14-0), the author also attempted to give a similar description of the dual function  $gp_\lambda$ , but he only obtained some implicit formulas. In this paper, we address the issue and give a new fermionic description of  $gp_\lambda$ . We also apply our method to the K-P-function  $GP_{\lambda}$  and its dual  $qq_{\lambda}$ .

<span id="page-0-0"></span>1.1. Overview. The factorial  $K-P$ -function and the factorial  $K-Q$ -function [\[5\]](#page-14-1) are a distinguished family of symmetric functions that represent a Schubert class in the torus equivariant K-theory of the maximal isotropic symplectic and orthogonal Grassmanianns. In a special case where the torus equivariant K-theory reduces to the (non-equivariant) K-theory, these functions reduce to their non-factorial versions.

The non-factorial K-P-function  $GP_{\lambda}(x)$  and the K-Q-function  $GQ_{\lambda}(x)$  are families of symmetric functions in the variables  $x = (x_1, x_2, \ldots)$ , parametrized by a strict partition  $\lambda = (\lambda_1 > \cdots > \lambda_r >$ 0). Their coefficients are in  $\mathbb{Z}[\beta]$ , where  $\beta$  is a formal parameter. (They are also refereed to as shifted stable Grothendieck polynomials [\[12\]](#page-15-0).) At  $\beta = 0$  limit,  $GP_{\lambda}$  and  $GQ_{\lambda}$  reduce to the Schur P-function and the Q-function [\[13,](#page-15-1) §III.8] respectively.

Both of  $GP_{\lambda}$  and  $GQ_{\lambda}$  are elements of  $GT$ , the  $\mathbb{Z}[\beta]$ -algebra characterized by the K-Q-cancellation property [\[5,](#page-14-1) Definition 1.1]. Any element of GΓ is expressed as an infinite  $\mathbb{Z}[\beta]$ -linear combination of  $GP_\lambda$ . On the other hand, all infinite  $\mathbb{Z}[\beta]$ -linear combinations of  $GQ_\lambda$  form a proper subalgebra  $GT_+ \subsetneq GT$ . It was shown in [\[5\]](#page-14-1) that, at  $\beta = -1$  limit,  $GT$  (resp.  $GT_+$ ) is isomorphic to the K-theory of the Grassmannian of type B and D (resp. type C). Under these isomorphisms,  $GP_\lambda$  and  $GQ_\lambda$ represent the Schubert class  $[\mathcal{O}_{\Omega_{\lambda}}]$ .

In the previous paper [\[8\]](#page-14-0), the author of the paper presented an algebraic characterization of  $GQ<sub>\lambda</sub>$ in terms of the boson-fermion correspondence [\[3,](#page-14-2) [11\]](#page-15-2). The main idea of the construction was the

use of "β-deformed neutral fermions"  $\phi_n^{(\beta)}, \phi_n^{[\beta]}$  (Definition [3.1\)](#page-3-0) and β-deformed operators listed in Figure [1.](#page-1-0)

Our aim is to extend the result in  $[8]$  to the K-P-function, the dual K-P-function, and the dual K-Q-function. The dual K-P-function  $qq_\lambda$  and the dual K-Q-function  $gp_\lambda$  are unique symmetric polynomials which satisfy the Cauchy identity [\[14,](#page-15-3) Definition 5.3] (see also [\[12,](#page-15-0) Definition 1.2])

\sum_{\lambda:\text{strict}}GQ_{\lambda}(x)gp_{\lambda}(y) = \sum_{\lambda:\text{strict}}GP_{\lambda}(x)gq_{\lambda}(y) = \prod_{i,j} \frac{1 - \overline{x_i}y_j}{1 - x_iy_j}, \quad \text{where} \quad \overline{x_i} = \frac{-x_i}{1 + \beta x_i}.

Our main results, Theorems [5.2,](#page-9-0) [6.1,](#page-10-0) and [6.4,](#page-12-0) are the construction of the three types of vectors  $|\lambda\rangle_P$ ,  $|\lambda\rangle_q$ , and  $|\lambda\rangle_p$  satisfying

GP_{\lambda} = \Omega(|\lambda\rangle_P), \quad gq_{\lambda} = \chi(|\lambda\rangle_q), \quad gp_{\lambda} = \chi(|\lambda\rangle_p),
$$

where  $\Omega$  and  $\chi$  are the  $\beta$ -deformed boson-fermion correspondences (see §[3.6\)](#page-6-0). When  $\beta \to 0$ , [\(2\)](#page-1-1) reduces to Date-Jimbo-Miwa's neutral-fermionic presentation of the Schur P-function and the Qfunction [\[3,](#page-14-2) [11\]](#page-15-2).

1.2. Outline of the paper. In Section [2,](#page-2-0) we briefly review fundamental facts regarding the neutral fermion Fock space. In Section [3,](#page-3-1) we introduce and define the  $\beta$ -deformed operators listed in Figure [1.](#page-1-0) Each of  $\phi_n^{(\beta)}$ ,  $\phi_n^{[\beta]}$ ,  $\Phi_n^{(\beta)}$ ,  $\Phi_n^{[\beta]}$  (§[3.1](#page-3-2)[–3.2\)](#page-4-0) can be written as an infinite Q[ $\beta$ ]-linear combination of the neutral fermions  $\phi_n$  (§[2.1\)](#page-2-1). They satisfy the anti-commutation relation  $[(\Phi_m^{(\beta)})^*,\phi_n^{[\beta]}]_+$  $[(\Phi_m^{[\beta]})^*,\phi_n^{(\beta)}]_+ = \delta_{m,n}$  (Lemma [3.4\)](#page-4-1), which is a  $\beta$ -deformed variant of the basic anti-commutation relation  $[(\frac{1}{2}\phi_m)^*, \phi_n]_+ = \delta_{m,n}$ . We also define the β-deformed power sums  $p_n^{(\beta)}, p_n^{[\beta]}$  (§[3.4\)](#page-5-0), which satisfy the Cauchy identity (Lemma [3.6\)](#page-6-1):

\sum_{\lambda:\text{odd}} 2^{\ell(\lambda)} z_{\lambda}^{-1} p_{\lambda}^{(\beta)}(x) p_{\mu}^{[\beta]}(y) = \prod_{i,j} \frac{1 - \overline{x_i} y_j}{1 - x_i y_j}, \qquad z_{\lambda} = \prod_{i \ge 1} i^{m_i} \cdot m_i!,
$$

where  $m_i(\lambda) = \frac{d}{d} \{k \mid \lambda_k = i\}$ . Comparing [\(1\)](#page-1-2) with [\(3\)](#page-1-3), we show the existence of the non-degenerate inner product  $\langle \cdot, \cdot \rangle$  satisfying  $\langle p_{\lambda}^{(\beta)} \rangle$  $_{\lambda}^{(\beta)},p_{\lambda}^{[\beta]}$  $\langle \lambda^{|\beta|} \rangle = 2^{\ell(\lambda)} z_{\lambda} \delta_{\lambda,\mu}$  for odd paritions  $\lambda, \mu$ , and  $\langle GQ_{\lambda}, gp_{\mu} \rangle =$  $\langle GP_{\lambda}, gq_{\mu} \rangle = \delta_{\lambda,\mu}$  for strict partitions  $\lambda, \mu$  (Eq. [\(15\)](#page-5-1)). By virtue of these relations, the  $\beta$ -deformed boson-fermion correspondences  $\Omega$ ,  $\chi$  preserve the inner product (Eq. [\(17\)](#page-6-2)). We show commutation relations between these β-deformed operators in Section [4.](#page-7-0)

In Section [6,](#page-10-1) we present a neutral-fermionic presentation of the dual functions. We show  $q\ddot{q}$  =  $\chi(|\lambda\rangle_q)$  (Theorem [6.1\)](#page-10-0) and  $gp_\lambda = \chi(|\lambda\rangle_p)$  (Theorem [6.4\)](#page-12-0) by proving the orthonormality  $_Q \langle \mu | \lambda \rangle_p =$  $_P \langle \mu | \lambda \rangle_q = \delta_{\lambda,\mu}$ . Additionally, we present a generating function of  $g q_\lambda$  (Eq. [\(28\)](#page-12-1)) and  $g p_\lambda$  (Eq. [\(34\)](#page-14-3)).

1.3. Related works. A Pfaffian formula of  $GP_{\lambda}$  and  $GQ_{\lambda}$  was first given in [\[4\]](#page-14-4) in the context of the connective K-theory of Grassmann bundles. Nakagawa-Naruse [\[14,](#page-15-3) [15,](#page-15-5) [16\]](#page-15-4) introduced universal cohomology versions of these functions. The generating function of  $g_{\lambda}$  [\(28\)](#page-12-1) was first conjectured in [\[15\]](#page-15-5). In [\[16\]](#page-15-4), they conjectured a combinatorial description of  $gq_\lambda$  and  $qp_\lambda$  in terms of shifted plane partitions, which was proved by Lewis-Marberg [\[12\]](#page-15-0). In [\[2\]](#page-14-5), Chiu-Marberg showed that  $\bigoplus_{\lambda} \mathbb{Z}[\beta]$ .  $GP_{\lambda} \subsetneq GT$ , the subspace of *finite* linear combinations of  $GP_{\lambda}$ , is closed under the multiplication. The same property for  $GQ_\lambda$  was proved by Lewis-Marberg [\[12\]](#page-15-0).

Our results can be regarded as a variant of the free-fermionic description of  $K$ -theoretic functions of type A, such as the stable Grothendieck polynomials  $[6, 7]$  $[6, 7]$ , the multi-Schur functions  $[9]$ , and the canonical Grothendieck functions [\[10\]](#page-15-6).

### 2. Preliminaries: Neutral fermion Fock space

<span id="page-2-0"></span>This section provides a brief review of the neutral fermion Fock space. For readers who are interested in this topic, we recommend Baker's paper [\[1\]](#page-14-9) and Jimbo-Miwa's paper [\[11\]](#page-15-2). Let  $[A, B] =$  $AB - BA$  be the commutator and  $[A, B]_+ = AB + BA$  be the anti-commutator.

<span id="page-2-1"></span>2.1. **Fock space.** Let A be the  $\mathbb{Q}(\beta)$ -algebra of *neutral fermions* generated by  $\{\phi_n\}_{n\in\mathbb{Z}}$  satisfying the anti-commutation relation  $[\phi_m, \phi_n]_+ = 2(-1)^m \delta_{m+n,0}$ . In particular, we have  $\phi_0^2 = 1$  and  $\phi_n^2 = 0$ for  $n \neq 0$ .

Let  $|0\rangle$  and  $\langle 0|$  denote the *vacuum vectors*:

$$
\phi_{-n}|0\rangle = 0, \quad \langle 0|\phi_n = 0, \qquad (n > 0).
$$

The Fock space  $\mathcal{F} := \mathcal{A} \cdot |0\rangle$  is the left A-module generated by  $|0\rangle$ , and the *dual Fock space*  $\mathcal{F}^* := \langle 0 | \cdot \mathcal{A} \rangle$ is the right  $A$ -module generated by  $\langle 0|$ . The vacuum expectation value is the unique bilinear form

\mathcal{F}^* \otimes_{\mathbb{Q}(\beta)} \mathcal{F} \to \mathbb{Q}(\beta); \qquad \langle u | \otimes | v \rangle \mapsto \langle u | v \rangle
$$

that satisfies (i)  $\langle 0|0\rangle = 1$ , (ii)  $\langle 0|\phi_0|0\rangle = 0$ , and (iii)  $(\langle u|\phi_n|v\rangle) = \langle u|(\phi_n|v\rangle)$ . We often use the abbreviations  $\langle u|X|v \rangle := (\langle u|X|v \rangle) = \langle u|(X|v \rangle)$  and  $\langle X \rangle := \langle 0|X|0 \rangle$  for any  $X \in \mathcal{A}$ .

The Fock space F is split into two subspaces as  $\mathcal{F} = \mathcal{F}_{odd} \oplus \mathcal{F}_{even}$ , where  $\mathcal{F}_{odd}$  (resp.  $\mathcal{F}_{even}$ ) is the subspace generated by all vectors obtained from  $|0\rangle$  by applying odd (*resp.* even) numbers of  $\phi_n$  $(n \ge 0)$ . The dual Fock space is also split as  $\mathcal{F}^* = \mathcal{F}_{odd}^* \oplus \mathcal{F}_{even}^*$ . If  $\langle u | \otimes | v \rangle$  is in  $\mathcal{F}_{even}^* \otimes \mathcal{F}_{odd}$  or in  $\mathcal{F}_{odd}^* \otimes \mathcal{F}_{even}$ , the vacuum expectation value  $\langle v|u\rangle$  annihilates automatically. By restriction, we obtain the nondegenerate bilinear form

(4) 
$$
\mathcal{F}_{even}^* \otimes_{\mathbb{Q}(\beta)} \mathcal{F}_{even} \to \mathbb{Q}(\beta).
$$

There exists an anti-algebra isomorphism  $A \leftrightarrow A$ ;  $x \leftrightarrow x^*$  defined by  $\phi_n^* = (-1)^n \phi_{-n}$  and  $(xy)^* = y^*x^*$ . It induces the involution  $\mathcal{F} \leftrightarrow \mathcal{F}^*$ ;  $v \leftrightarrow v^*$  with  $|0\rangle^* = \langle 0|$ .

2.2. Wick's theorem. For a  $2r \times 2r$  matrix X, Pf(X) denotes the Pfaffian

$$
\text{Pf}(X) = \sum_{\substack{\sigma(1) < \sigma(3) < \cdots < \sigma(2r-1) \\ \sigma(1) < \sigma(2), \sigma(3) < \sigma(4), \ldots, \sigma(2r-1) < \sigma(2r)}} \text{sgn}(\sigma) a_{\sigma(1), \sigma(2)} a_{\sigma(3), \sigma(4)} \ldots a_{\sigma(2r-1), \sigma(2r)}.
$$

For  $n_1, \ldots, n_{2r} \in \mathbb{Z}$ , we have Wick's theorem

(5) 
$$
\langle \phi_{n_1} \phi_{n_2} \dots \phi_{n_{2r}} \rangle = \text{Pf}\left( \langle \phi_{n_i} \phi_{n_j} \rangle \right)_{1 \leq i < j \leq 2r}
$$

For a strict partition  $\lambda = (\lambda_1 > \lambda_2 > \cdots > \lambda_r > 0)$  of length r, we define  $|\lambda\rangle \in \mathcal{F}_{even}$  as

|\lambda\rangle = \begin{cases} \phi_{\lambda_1}\phi_{\lambda_2}\dots\phi_{\lambda_r}|0\rangle & (r:\text{even})\\ \phi_{\lambda_1}\phi_{\lambda_2}\dots\phi_{\lambda_r}\phi_0|0\rangle & (r:\text{odd}) \end{cases}.
$$

<span id="page-3-1"></span>The orthogonality  $\langle \mu | \lambda \rangle = \delta_{\lambda,\mu}$  is derived directly from Wick's theorem [\(5\)](#page-3-3).

# 3. β-deformed operators

<span id="page-3-2"></span> $\sum_{n\in\mathbb{Z}}\phi_nz^n$ , which determines a  $\mathbb{Q}(\beta)$ -linear map  $\mathcal{F}\to\mathcal{F}((z))$  by left multiplication, and a  $\mathbb{Q}(\beta)$ -3.1. β-deformed fermion fields I. The neutral fermion field  $\phi(z)$  is the formal series  $\phi(z)$  = linear map  $\mathcal{F}^* \to \mathcal{F}^*((z^{-1}))$  by right multiplication.

<span id="page-3-0"></span>**Definition 3.1.** We define the  $\beta$ -deformed fermion fields  $\phi^{(\beta)}(z) = \sum_{n \in \mathbb{Z}} \phi_n^{(\beta)} z^n$  and  $\phi^{[\beta]}(z) =$  $\sum_{n\in\mathbb{Z}}\phi_n^{[\beta]}z^n$  by

$$
\sum_{n=0}^{\infty} \phi_n^{(\beta)} z^n = \sum_{n=0}^{\infty} \phi_n (z + \frac{\beta}{2})^n, \quad \sum_{n=1}^{\infty} \phi_{-n}^{(\beta)} z^{-n} = \sum_{n=1}^{\infty} \phi_{-n} \left( \frac{z^{-1}}{1 + \frac{\beta}{2} z^{-1}} \right)^n,
$$

$$
\sum_{n=1}^{\infty} \phi_n^{[\beta]} z^n = \sum_{n=1}^{\infty} \phi_n \left( \frac{z}{1 + \frac{\beta}{2} z} \right)^n, \quad \sum_{n=0}^{\infty} \phi_{-n}^{[\beta]} z^{-n} = \sum_{n=0}^{\infty} \phi_{-n} (z^{-1} + \frac{\beta}{2})^n.
$$

 $\phi^{(\beta)}(z)$  determines a Q( $\beta$ )-linear map  $\mathcal{F}^* \to \mathcal{F}^*((z^{-1}))$  by right multiplication, and  $\phi^{[\beta]}(z)$  determines a  $\mathbb{Q}(\beta)$ -linear map  $\mathcal{F} \to \mathcal{F}((z))$  by left multiplication.

The following informal expressions are helpful in understanding what Definition [3.1](#page-3-0) describes:

(6) 
$$
\phi^{(\beta)}(z) = \phi(z + \frac{\beta}{2}), \qquad \phi^{[\beta]}(z) = \phi(\frac{z}{1 + \frac{\beta}{2}z}).
$$

For a positive integer n,  $\phi_n^{(\beta)}$  and  $\phi_n^{[\beta]}$  are infinite  $\frac{\mathbb{Z}}{2}[\beta]$ -linear combinations of  $\phi_1, \phi_2, \phi_3, \ldots$  For example, we have  $\phi_1^{(\beta)} = \phi_1 + \beta \phi_2 + \frac{3\beta^2}{4}$  $\frac{\beta^2}{4}\phi_3+\cdots$ . On the other hand,  $\phi_{-n}^{(\beta)}$  and  $\phi_{-n}^{[\beta]}$  are infinite  $\frac{\mathbb{Z}}{2}[\beta]$ linear combinations of  $\phi_{-1}, \phi_{-2}, \phi_{-3}, \ldots$  Hence, the β-deformed fermions satisfy the annihilation rule

(7) 
$$
\langle 0 | \phi_n^{(\beta)} = \langle 0 | \phi_n^{[\beta]} = 0, \phi_{-n}^{(\beta)} | 0 \rangle = \phi_{-n}^{[\beta]} | 0 \rangle = 0, \quad (n > 0).
$$

<span id="page-3-6"></span><span id="page-3-4"></span>The actions of the zero-th fermions  $\phi_0^{(\beta)}$  and  $\phi_0^{[\beta]}$  on the vacuum vectors are simple:

(8) 
$$
\langle 0 | \phi_0^{(\beta)} \rangle = \langle 0 | \phi_0, \quad \langle 0 | \phi_0 \phi_0^{(\beta)} \rangle = \langle 0 |, \quad \phi_0^{[\beta]} | 0 \rangle = \phi_0 | 0 \rangle, \quad \phi_0^{[\beta]} \phi_0 | 0 \rangle = | 0 \rangle.
$$

<span id="page-3-5"></span>**Lemma 3.2** ([\[8,](#page-14-0)  $\S9.1$ ]). We have the anti-commutation relation:

$$
[(\phi_m^{(\beta)})^*, \phi_n^{[\beta]}]_+ = \begin{cases} 2 & (m = n) \\ \beta & (m = n - 1) \\ 0 & (otherwise) \end{cases}.
$$

*Proof.* This lemma is derived directly from  $[(\phi_m)^*, \phi_n]_+ = 2\delta_{m,n}$  and Definition [3.1.](#page-3-0) For details of the proof, see [\[8,](#page-14-0)  $\S9.1$ ].

<span id="page-4-0"></span>3.2. β-deformed fermion fields II. We next define another two β-deformed fermion fields  $\Phi^{(\beta)}(z)$  =  $\sum_{n\in\mathbb{Z}}\Phi_n^{(\beta)}z^n$  and  $\Phi^{[\beta]}(z)=\sum_{n\in\mathbb{Z}}\Phi_n^{[\beta]}z^n$ .

<span id="page-4-3"></span>**Definition 3.3.** We define the fields  $\Phi^{(\beta)}(z)$  and  $\Phi^{[\beta]}(z)$  by

$$
\Phi^{(\beta)}(z) := \frac{1}{2 + \beta z^{-1}} \phi^{(\beta)}(z), \qquad \Phi^{[\beta]}(z) := \frac{1}{2 + \beta z} \phi^{[\beta]}(z).
$$

 $\Phi^{(\beta)}(z)$  determines a  $\mathbb{Q}(\beta)$ -linear map  $\mathcal{F}^* \to \mathcal{F}^*((z^{-1}))$  by right multiplication, and  $\Phi^{[\beta]}(z)$  determines a  $\mathbb{Q}(\beta)$ -linear map  $\mathcal{F} \to \mathcal{F}((z))$  by left multiplication.

For any  $n \in \mathbb{Z}$ , these new  $\beta$ -deformed fermions can expand as

(9) 
$$
\Phi_n^{(\beta)} = \frac{1}{2} \phi_n^{(\beta)} - \frac{\beta}{4} \phi_{n+1}^{(\beta)} + \frac{\beta^2}{8} \phi_{n+2}^{(\beta)} - \cdots,
$$

$$
\Phi_n^{[\beta]} = \frac{1}{2} \phi_n^{[\beta]} - \frac{\beta}{4} \phi_{n-1}^{[\beta]} + \frac{\beta^2}{8} \phi_{n-2}^{[\beta]} - \cdots.
$$

From [\(9\)](#page-4-2), we obtain the annihilation rule

(10) 
$$
\langle 0|\Phi_n^{(\beta)}=0, \quad \Phi_{-n}^{[\beta]}|0\rangle = 0, \quad (n>0).
$$

However, this is not the case for  $\langle 0 | \Phi_n^{[\beta]} \rangle$  and  $\Phi_{-n}^{(\beta)} |0\rangle$ . In fact, using

<span id="page-4-5"></span>
$$
\phi_0 = \phi_0^{(\beta)} - \frac{\beta}{2}\phi_1^{(\beta)} + \frac{\beta^2}{4}\phi_2^{(\beta)} - \dots = \phi_0^{[\beta]} - \frac{\beta}{2}\phi_{-1}^{[\beta]} + \frac{\beta^2}{4}\phi_{-2}^{[\beta]} - \dots,
$$

we can rewrite [\(9\)](#page-4-2) as

(11) 
$$
\Phi_{-n}^{(\beta)} = \frac{1}{2}\phi_{-n}^{(\beta)} - \frac{\beta}{4}\phi_{-n+1}^{(\beta)} + \frac{\beta^2}{8}\phi_{-n+2}^{(\beta)} - \dots + \frac{(-\beta)^n}{2^{n+1}}\phi_0, \n\Phi_n^{[\beta]} = \frac{1}{2}\phi_n^{(\beta)} - \frac{\beta}{4}\phi_{n-1}^{(\beta)} + \frac{\beta^2}{8}\phi_{n-2}^{(\beta)} - \dots + \frac{(-\beta)^n}{2^{n+1}}\phi_0
$$

for non-negative  $n \geq 0$ . From [\(7\)](#page-3-4), we obtain

(12) 
$$
\langle 0|\Phi_n^{[\beta]} = \frac{(-\beta)^n}{2^{n+1}} \cdot \langle 0|\phi_0 \neq 0, \qquad \Phi_{-n}^{(\beta)}|0\rangle = \frac{(-\beta)^n}{2^{n+1}} \cdot \phi_0|0\rangle \neq 0,
$$

which implies that the operators  $\Phi_n^{[\beta]}, \Phi_{-n}^{(\beta)}$  fail to annihilate the vacuum vectors.

<span id="page-4-1"></span>Lemma 3.4. We have the following commutation relation:

<span id="page-4-4"></span>
$$
[(\Phi_m^{(\beta)})^*,\phi_n^{[\beta]}]_+ = [(\Phi_m^{[\beta]})^*,\phi_n^{(\beta)}]_+ = \delta_{m,n}.
$$

*Proof.* It is obtained from Lemma [3.2](#page-3-5) and [\(9\)](#page-4-2) by straightforward calculations.

3.3. β-deformed current and Hamiltonian operators. For an odd integer  $m$ , we define the current operator  $b_m$  as  $b_m = \frac{1}{4} \sum_{i \in \mathbb{Z}} (-1)^i \phi_{-i-m} \phi_i$ .

**Definition 3.5.** For any non-zero integer m (possibly even), we define the  $\beta$ -deformed current operators  $b_m^{(\beta)}, b_m^{[\beta]}$  by

$$
b_m^{(\beta)}=\frac{(X-\frac{\beta}{2})^m-(-X-\frac{\beta}{2})^m}{2}\Bigg|_{X^k\mapsto b_k}\qquad and\qquad b_m^{[\beta]}=(b_{-m}^{(\beta)})^*,
$$

where  $\frac{(X-\frac{\beta}{2})^m-(-X-\frac{\beta}{2})^m}{2}$  $\frac{1}{2}$  is expanded as a polynomial in X if  $m > 0$ , and as a power series of  $X^{-1}$ if  $m < 0$ . For example, we have  $b_1^{(\beta)} = b_1$ ,  $b_2^{(\beta)} = -\beta b_1$ ,  $b_3^{(\beta)} = b_3 + \frac{3\beta^2}{4}$  $\frac{\beta^2}{4}b_1, b_{-1}^{(\beta)} = b_{-1} + \frac{\beta^2}{4}$  $\frac{b-3}{4}$  $\frac{\beta^4}{16}b_{-5} + \cdots$ .

Let  $p_n(x) = x_1^n + x_2^n + \cdots$  denote the *n*-th power sum in  $x = (x_1, x_2, \ldots)$ . The *Hamiltonian operator*  $\mathcal{H}(x)$  is defined as

$$
\mathcal{H}(x) = 2 \sum_{n=1,3,5,...} \frac{p_n(x)}{n} b_n.
$$

Deforming the currents as  $b_n \mapsto b_n^{(\beta)}$  (resp.  $b_n \mapsto b_n^{[\beta]}$ ), we have the *β*-deformed Hamiltonian operator  $\mathcal{H}^{(\beta)}(x)$  (resp.  $\mathcal{H}^{[\beta]}(x)$ ) by

$$
\mathcal{H}^{(\beta)}(x) = 2 \sum_{n=1,3,5,...} \frac{p_n(x)}{n} b_n^{(\beta)}, \qquad \mathcal{H}^{[\beta]}(x) = 2 \sum_{n=1,3,5,...} \frac{p_n(x)}{n} b_n^{[\beta]}.
$$

For brevity, we often use the abbreviations  $\mathcal{H}^{(\beta)} = \mathcal{H}^{(\beta)}(x)$  and  $\mathcal{H}^{[\beta]} = \mathcal{H}^{[\beta]}(x)$ .

<span id="page-5-0"></span>3.4. β-deformed power sums. The *β-deformed power sums*  $p_n^{(\beta)}(x), p_n^{[\beta]}(x)$  are defined by

(13) 
$$
p_n^{(\beta)}(x) := \sum_{i=0}^{\infty} {\binom{-n}{i}} \left(\frac{\beta}{2}\right)^i p_{n+i}(x), \qquad p_n^{[\beta]}(x) := \sum_{i=1}^n {\binom{n}{i}} \left(\frac{\beta}{2}\right)^i p_i(x).
$$

The following informal expressions are helpful in understanding [\(13\)](#page-5-2):

<span id="page-5-2"></span>
$$
p_n^{(\beta)}(x) = p_n(\frac{x}{1 + \frac{\beta}{2}x})
$$
 and  $p_n^{[\beta]}(x) = p_n(x + \frac{\beta}{2}) - p_n(\frac{\beta}{2}).$ 

For any partition  $\lambda = (\lambda_1 \geq \lambda_2 \geq \dots)$ , we put  $p_{\lambda}^{(\beta)}$  $p_{\lambda_1}^{(\beta)} := p_{\lambda_1}^{(\beta)}$  $\lambda_1^{(\beta)} p_{\lambda_2}^{(\beta)}$  $\chi_2^{(\beta)} \cdots$  and  $p_{\lambda}^{[\beta]}$  $\lambda^{[\beta]}:=p_{\lambda_1}^{[\beta]}$  ${}^{[\beta]}_{\lambda_1}p^{[\beta]}_{\lambda_2}$  $\frac{1}{\lambda_2}$ .... Let

$$
\widehat{G\Gamma} = \mathbb{Q}(\beta)[[p_1^{(\beta)}, p_3^{(\beta)}, p_5^{(\beta)}, \dots]],
$$
  

$$
g\Gamma = \mathbb{Q}(\beta)[p_1^{[\beta]}, p_3^{[\beta]}, p_5^{[\beta]}, \dots].
$$

Any element of  $\widehat{G\Gamma}$  is expressed as a (possibly infinite)  $\mathbb{Q}(\beta)$ -linear combination of  $p_{\lambda}^{(\beta)}$  $\lambda^{(\rho)}$ , where  $\lambda$ runs over all odd partitions. There exist two natural isomorphisms

<span id="page-5-3"></span>
$$
\iota^{(\beta)} : \widehat{\Gamma} \to \widehat{G\Gamma}; \quad p_n \mapsto p_n^{(\beta)}, \qquad \iota^{[\beta]} : \Gamma \to g\Gamma; \quad p_n \mapsto p_n^{[\beta]},
$$

where  $\Gamma = \mathbb{Q}(\beta)[p_1, p_3, \dots]$  and  $\widehat{\Gamma} = \mathbb{Q}(\beta)[[p_1, p_3, \dots]]$ . The map  $\iota^{(\beta)}$  is nothing but the substitution  $x_i \mapsto \frac{x_i}{1 + \frac{\beta}{2}x_i}$ .

Let  $\hat{Q}_{\lambda} \in \Gamma$  be the *Schur Q-function* [\[13,](#page-15-1) §III.8], where  $\lambda$  is a strict partition. The  $\beta$ -deformed Hamiltonians satisfy the equations

(14) 
$$
\iota^{(\beta)}(Q_{\lambda}) = \langle 0 | e^{\mathcal{H}^{(\beta)}} | \lambda \rangle, \qquad \iota^{[\beta]}(Q_{\lambda}) = \langle 0 | e^{\mathcal{H}^{[\beta]}} | \lambda \rangle.
$$

Set  $Q_{\lambda}^{(\beta)}$  $\chi^{(\beta)} := \iota^{(\beta)}(Q_{\lambda})$  and  $Q_{\lambda}^{[\beta]}$  $\lambda^{[\beta]} := \iota^{[\beta]}(Q_{\lambda}).$ 

3.5.  $\beta$ -deformed bilinear form. We define the bilinear form

<span id="page-5-1"></span>(15) 
$$
\widehat{G\Gamma} \otimes_{\mathbb{Q}(\beta)} g\Gamma \to \mathbb{Q}(\beta); \qquad f \otimes g \mapsto \langle f, g \rangle
$$

by  $\langle p_{\lambda}^{(\beta)} \rangle$  $\langle \begin{array}{c} (\beta) \\ \lambda \end{array}, p_{\mu}^{[\beta]} \rangle = 2^{-\ell(\lambda)} z_{\lambda} \delta_{\lambda,\mu}$  for any odd partitions  $\lambda, \mu$ . <span id="page-6-1"></span>**Lemma 3.6** ([\[8,](#page-14-0) §8]). We have the  $\beta$ -deformed Cauchy identity

$$
\sum_{\lambda:\text{odd}} 2^{\ell(\lambda)} z_{\lambda}^{-1} p_{\lambda}^{(\beta)}(x) p_{\mu}^{[\beta]}(y) = \prod_{i,j} \frac{1 - \overline{x_i} y_j}{1 - x_i y_j}, \quad where \quad \overline{x} = -\frac{x}{1 + \beta x}.
$$

Proof. This lemma is obtained from the equation

$$
\sum_{\lambda:\text{odd}} 2^{\ell(\lambda)} z_{\lambda}^{-1} p_{\lambda}(x) p_{\mu}(y) = \prod_{i,j} \frac{1 + x_i y_j}{1 - x_i y_j}
$$

by substituting  $x_i \mapsto \frac{x_i}{1 + \frac{\beta}{2} x_i}$  and  $p_n(y) \mapsto p_n(y + \frac{\beta}{2})$  $\frac{\beta}{2})-p_n(\frac{\beta}{2})$  $\frac{\beta}{2}$ ). For details, see [\[8,](#page-14-0) §8].

<span id="page-6-3"></span>**Lemma 3.7.** For any strict partitions  $\lambda, \mu$ , we have  $\langle Q_{\lambda}^{(\beta)} \rangle$  $\langle \begin{smallmatrix} (\beta) \ \lambda \end{smallmatrix}, Q^{[\beta]}_{\mu} \rangle = 2^{\ell(\lambda)} \delta_{\lambda, \mu}.$ 

Proof. Let  $\langle f, g \rangle' := \langle \iota^{(\beta)}(f), \iota^{[\beta]}(g) \rangle$  for  $f, g \in \Gamma$ . Then, the bilinear form  $\langle \cdot, \cdot \rangle'$  coincides with the Hall inner product on  $\Gamma$  [\[13,](#page-15-1) §III.8]. The lemma follows from the orthogonality  $\langle Q_{\lambda}, Q_{\mu} \rangle' =$  $2^{\ell(\lambda)}$  $\delta_{\lambda,\mu}$ .

Through the non-degenerate bilinear form [\(15\)](#page-5-1), we regard  $\widehat{G\Gamma}$  as a subspace of  $\text{Hom}_{\mathbb{O}(\beta)}(g\Gamma,\mathbb{Q}(\beta)).$ Since any element of  $\widehat{G\Gamma}$  is a expressed as an infinite  $\mathbb{Q}(\beta)$ -linear combination of  $p_{\lambda}^{(\beta)}$  $\lambda^{(\rho)}$ , they are in fact isomorphic:

(16) 
$$
\widehat{G}\Gamma \simeq \text{Hom}_{\mathbb{Q}(\beta)}(g\Gamma,\mathbb{Q}(\beta)).
$$

<span id="page-6-0"></span>3.6. β-deformed boson-fermion correspondence. Let  $\Omega_0, \chi$  be the  $\mathbb{Q}(\beta)$ -linear maps defined by

$$
\Omega_0: \mathcal{F}_{even} \to \widehat{G}\Gamma; \quad |v\rangle \mapsto \langle 0|e^{\mathcal{H}^{(\beta)}}|v\rangle,
$$
  

$$
\chi: \mathcal{F}_{even} \to g\Gamma; \quad |v\rangle \mapsto \langle 0|e^{\mathcal{H}^{[\beta]}}|v\rangle.
$$

From [\(14\)](#page-5-3) and Lemma [3.7,](#page-6-3) we show that they preserve the inner products:  $\langle u^* | v \rangle = \langle \Omega_0(|u\rangle), \chi(|v\rangle) \rangle$ , where  $\langle u^* | = |u \rangle^*$ .

Through the inner product [\(4\)](#page-2-2),  $\mathcal{F}_{even}$  is regarded as a subspace of  $\widehat{\mathcal{F}}_{even} := \text{Hom}_{\mathbb{Q}(\beta)}(\mathcal{F}_{even}^*, \mathbb{Q}(\beta)).$ For any  $\varphi \in \widehat{\mathcal{F}}_{even}$ , we let  $[\varphi]$  denote the unique element of  $\widehat{G\Gamma}$  that satisfies

$$
\langle [\varphi], \chi(|v\rangle) \rangle = \varphi(\langle v^*|), \qquad \forall |v\rangle \in \mathcal{F}_{even}.
$$

Then, the linear map  $\Omega_0$  naturally extends to

<span id="page-6-2"></span>
$$
\Omega: \widehat{\mathcal{F}}_{even} \to \widehat{G\Gamma}; \quad \varphi \mapsto [\varphi],
$$

which satisfies

(17) 
$$
\langle u^* | v \rangle = \langle \Omega(|u\rangle), \chi(|v\rangle) \rangle
$$

for any  $|u\rangle \in \hat{\mathcal{F}}_{even}$  and  $|v\rangle \in \mathcal{F}_{even}$ . One can easily check that  $\Omega$  and  $\chi$  are bijective. We call these linear isomorphisms  $\Omega$ ,  $\chi$  the  $\beta$ -deformed boson-fermion correspondences.

### 4. Commutation relations involving β-deformed operators

<span id="page-7-0"></span>In this section, we provide a list of useful commutation relations involving  $\beta$ -deformed operators. Most of the proofs are given in the author's earlier paper [\[8\]](#page-14-0).

Define the binary operators  $\oplus$  and  $\ominus$  by

$$
x \oplus y = x + y + \beta xy
$$
,  $x \ominus y = \frac{x - y}{1 + \beta y}$ .

Let  $\overline{x} = 0 \ominus x = \frac{-x}{1+\beta x}$  denote the additive inverse of x. Put

$$
\Theta = 2 \sum_{n=1,3,5,...} \left(\frac{\beta}{2}\right)^n \frac{b_{-n}}{n}, \qquad \theta = \Theta^* = 2 \sum_{n=1,3,5,...} \left(\frac{\beta}{2}\right)^n \frac{b_n}{n}.
$$

<span id="page-7-12"></span><span id="page-7-2"></span>Lemma 4.1. We have the following commutation relations:

(3)  $e^{-\Theta}e^{\mathcal{H}^{(\beta)}}e^{\Theta} = \prod_i (1 + \beta x_i) \cdot e^{\mathcal{H}^{(\beta)}}.$ (4)  $e^{\mathcal{H}^{(\beta)}}\phi^{(\beta)}(z)e^{-\overline{\mathcal{H}^{(\beta)}}}= \prod_{i} \frac{z^{-1} \oplus x_i}{z^{-1}-x_i} \cdot \phi^{(\beta)}(z).$ (5)  $\langle \phi^{(\beta)}(z) \phi^{(\beta)}(w) \rangle = \frac{w^{-1} - z^{-1}}{w^{-1} \oplus z^{-1}}$ , where  $\frac{w^{-1} - z^{-1}}{w^{-1} \oplus z^{-1}}$  expands as  $\frac{1-wz^{-1}}{1+wz^{-1}+\beta z^{-1}} = 1 - (2w+\beta)z^{-1} + (2w^2+3\beta w+\beta^2)z^{-2} - \cdots$ in the field  $\mathbb{Q}(\beta)((w^{-1}))((z^{-1}))$  $\mathbb{Q}(\beta)((w^{-1}))((z^{-1}))$  $\mathbb{Q}(\beta)((w^{-1}))((z^{-1}))$  of formal Laurent series<sup>1</sup>.

$$
\begin{array}{ccccccccc}\n\bullet & & & & & & \\

*Proof.* [\(1\)](#page-7-2) follows from  $\langle 0|b_{-n} = 0$  for  $n > 0$ . [\(2\)](#page-7-3) and [\(3\)](#page-7-4) are shown in [\[8,](#page-14-0) §4.3]. [\(4\)](#page-7-5) follows from

$$
e^{\mathcal{H}^{(\beta)}}\phi^{(\beta)}(z)e^{\mathcal{H}^{-(\beta)}} = \exp\left(\sum_{n=1}^{\infty} \frac{p_n(x)}{n}(z^n - (-z - \beta)^n)\right)\phi^{(\beta)}(z),
$$

which is given in [\[8,](#page-14-0) §4.2], and  $\exp\left(\sum_{n=1}^{\infty} \frac{p_n(x)}{n} A^n\right) = \prod_{i} \frac{1}{1-x_iA}$ . [\(5\)](#page-7-6) is shown in [8, §3.2].

<span id="page-7-7"></span>Lemma 4.2. We have the following commutation relations:

\n(3)  $e^{\theta}$  and  $e^{\mathcal{H}^{[\beta]}}$  commute with each other.  
\n(4)  $e^{\mathcal{H}^{[\beta]}\phi^{[\beta]}(z)e^{-\mathcal{H}^{[\beta]}} = \prod_{i} \frac{1-x_{i}\overline{z}}{1-x_{i}z} \cdot \phi^{[\beta]}(z)$ .  
\n(5)  $\langle \phi^{[\beta]}(z)\phi^{[\beta]}(w) \rangle = \frac{z-w}{z \oplus w}$ , where  $\frac{z-w}{z \oplus w}$  expands as  
\n
$$
\frac{1-wz^{-1}}{1+wz^{-1}+\beta w} = 1 - (2z^{-1} + \beta)w + (2z^{-2} + 3\beta z^{-1} + \beta^{2})w^{2} - \cdots
$$
  
\nin  $\mathbb{Q}(\beta)((z))((w))$ .

*Proof.* [\(1\)](#page-7-7) follows from  $b_n|0\rangle = 0$  for  $n > 0$ . [\(2\)](#page-7-8) and [\(5\)](#page-7-9) are shown in [\[8,](#page-14-0) §10.1]. [\(3\)](#page-7-10) follows from  $[b_m, b_n] = 0$  for  $m, n > 0$ . [\(4\)](#page-7-11) is shown in [\[8,](#page-14-0) §9.1].

$$
e^{\theta} \phi_n^{[\beta]} e^{-\theta} = \phi_n^{[\beta]} + \beta \phi_{n-1}^{[\beta]},

\n(2)  $e^{-\theta} \phi_n^{[\beta]} e^{\theta} = \phi_n^{[\beta]} - \beta \phi_{n-1}^{[\beta]} + \beta^2 \phi_{n-2}^{[\beta]} - \cdots,$

5.  $GP_{\lambda}$  and  $GQ_{\lambda}$ 

## 5.1. Fermionic presentation of  $GQ_\lambda$ . Define the vector  $|\lambda\rangle_Q$  by

(18) 
$$
|\lambda\rangle_{Q} = \begin{cases} \phi_{\lambda_1}^{(\beta)} e^{\Theta} \phi_{\lambda_2}^{(\beta)} e^{\Theta} \cdots \phi_{\lambda_r}^{(\beta)} e^{\Theta} |0\rangle & (r:\text{even})\\ \phi_{\lambda_1}^{(\beta)} e^{\Theta} \phi_{\lambda_2}^{(\beta)} e^{\Theta} \cdots \phi_{\lambda_r}^{(\beta)} e^{\Theta} \phi_0^{(\beta)} e^{\Theta} |0\rangle & (r:\text{odd}) \end{cases}.
$$

Note that  $|\lambda\rangle_Q$  is an element of  $\hat{\mathcal{F}}_{even}$ , but not an element of  $\mathcal{F}_{even}$ . In terms of the β-deformed boson-fermion correspondence, the main theorem of the previous paper [\[8\]](#page-14-0) can be described as follows:

<span id="page-8-1"></span>**Theorem 5.1** ([\[8,](#page-14-0) §7]). The K-theoretic Q-function  $GQ_\lambda(x)$  is expressed as

$$
GQ_{\lambda}(x) = \langle 0|e^{\mathcal{H}^{(\beta)}}|\lambda\rangle_{Q} = \Omega(|\lambda\rangle_{Q}).
$$

In [\[8\]](#page-14-0), the author proved Theorem [5.1](#page-8-1) by comparing the vacuum expectation value  $\langle 0 | e^{\mathcal{H}^{(\beta)}} |\lambda\rangle_Q$ with Hudson-Ikeda-Matsumura-Naruse's Pfaffian formula [\[4\]](#page-14-4). For later use, we give another proof using the generating function

<span id="page-8-2"></span>(19) 
$$
GQ_{\lambda}(x) = [u_1^{-\lambda_1} \dots u_r^{-\lambda_r}] \prod_{i=1}^r \frac{1}{1 + \beta u_i} \prod_{i,j} \frac{u_i \oplus x_j}{u_i \ominus x_j} \prod_{1 \leq i < j \leq r} \frac{u_j \ominus u_i}{u_j \oplus u_i},
$$

which was introduced by Nakagawa-Naruse [\[16,](#page-15-4) §5.2]. Here, the right hand side of [\(19\)](#page-8-2) expands in the field

and  $[u_1^{n_1} \dots u_r^{n_r}]F(u_1, \dots, u_r)$  denotes the coefficient of the monomial  $u_1^{n_1} \dots u_r^{n_r}$  in F.

These expansions in the field [\(20\)](#page-8-3) coincide with the Laurent expansions on the domain  $D_{(r)}$ :  ${|x_j| < |u_1| < |u_2| < \cdots < |u_r| < |\beta^{-1}|$ ;  $\forall j$ . When substituting  $\lambda_{r+1} = 0$  to [\(19\)](#page-8-2) formally, we have

Since the residue in the last expression equals to 1, we have  $GQ_{(\lambda,0)} = GQ_\lambda$ .

*Proof of Theorem [5.1.](#page-8-1)* We can assume r to be even without the loss of generality by adding  $\lambda_{r+1} = 0$ to the end of a strict partition if needed. The generating function of  $\langle 0 | e^{\mathcal{H}^{(\beta)}} |\lambda\rangle_Q$  expands as

For the equality (∗), we use the following formula by Ikeda-Naruse [\[5,](#page-14-1) Lemma 2.4]:

5.2. Fermionic presentation of  $GP_{\lambda}$ . Define  $|\lambda\rangle_P \in \widehat{\mathcal{F}}_{even}$  by

*Proof.* This theorem is given by comparing the definition of  $\Phi^{(\beta)}(z)$  (Definition [3.3\)](#page-4-3) and the generating function

For the K-theory setting, we substitute  $HP_\lambda(x) \mapsto GP_\lambda(x)$ ,  $x +_{\mathbb{L}} y \mapsto x \oplus y$ ,  $\mathcal{I}^{\mathbb{L}}(u) \mapsto 1 + \beta u$ ,  $[t]\overline{u} \mapsto u$  to obtain [\(23\)](#page-9-2).

<span id="page-10-1"></span>In this section, we present a fermionic description of the dual functions  $q p_{\lambda}, q q_{\lambda}$ . Comparing [\(1\)](#page-1-2) with Lemma [3.6,](#page-6-1) we find that  $q\bar{p}_{\lambda}$  and  $q\bar{q}_{\lambda}$  are unique elements of  $q\Gamma$  satisfying the duality

$$
\langle GQ_{\lambda}, gp_{\mu} \rangle = \langle GP_{\lambda}, gq_{\mu} \rangle = \delta_{\lambda, \mu}.
$$

# 6.1. **Fermionic presentation of**  $gq_{\lambda}$ . Define  $|\lambda\rangle_q \in \mathcal{F}_{even}$  by

$$
|\lambda\rangle_q:=\begin{cases} \phi_{\lambda_1}^{[\beta]}e^{-\theta}\phi_{\lambda_2}^{[\beta]}e^{-\theta}\ldots \phi_{\lambda_r}^{[\beta]}e^{-\theta}|0\rangle & (r:\text{even})\\ \phi_{\lambda_1}^{[\beta]}e^{-\theta}\phi_{\lambda_2}^{[\beta]}e^{-\theta}\ldots \phi_{\lambda_r}^{[\beta]}e^{-\theta}\phi_0^{[\beta]}e^{-\theta}|0\rangle & (r:\text{odd}) \end{cases}.
$$

<span id="page-10-0"></span>**Theorem 6.1.** The dual K-theoretic Q-function  $g q_\lambda(x)$  is expressed as

$$
gq_{\lambda}(x) = \langle 0|e^{\mathcal{H}^{[\beta]}}|\lambda\rangle_q = \chi(|\lambda\rangle_q).
$$

Let  $P(\mu) := (|\mu\rangle_P)^*$  for a strict partition  $\mu$ . We prove Theorem [6.1](#page-10-0) by showing the orthonormality  $_P \langle \mu | \lambda \rangle_q = \delta_{\lambda,\mu}$  (see [\(17\)](#page-6-2)). For strictly decreasing sequences  $\lambda = (\lambda_1 > \lambda_2 > \cdots > \lambda_r \geq 0)$  and  $\mu = (\mu_1 > \mu_2 > \cdots > \mu_s \ge 0)$ , define the two vectors  $(\mu \in \mathcal{F}^*$  and  $|\lambda) \in \mathcal{F}$  by

$$
(\mu| = \begin{cases} \langle 0|e^{\theta}(\Phi_{\mu_r}^{(\beta)})^* \dots e^{\theta}(\Phi_{\mu_2}^{(\beta)})^* e^{\theta}(\Phi_{\mu_1}^{(\beta)})^* & (\mu_r > 0) \\ \langle 0|e^{\theta}(\phi_0^{(\beta)})^* e^{\theta}(\Phi_{\mu_{r-1}}^{(\beta)})^* \dots e^{\theta}(\Phi_{\mu_2}^{(\beta)})^* e^{\theta}(\Phi_{\mu_1}^{(\beta)})^* & (\mu_r = 0) \end{cases},
$$

$$
|\lambda) = \phi_{\lambda_1}^{[\beta]} e^{-\theta} \phi_{\lambda_2}^{[\beta]} e^{-\theta} \dots \phi_{\lambda_r}^{[\beta]} e^{-\theta} |0\rangle.

The desired equation is now equivalent to

where  $\lambda, \mu$  are strictly decreasing sequences of non-negative integers.

## <span id="page-10-2"></span>Lemma 6.2. We have the following:

- (A) If  $n > 0$ , then  $\langle 0 | e^{\theta} (\phi_0^{(\beta)})^* \cdot \phi_n^{[\beta]} = 0$ . (B) If  $\mu \neq \emptyset$  and  $n > \mu_1$ , then  $(\mu | \phi_n^{[\beta]} = 0$ .
- (C) If  $\lambda \neq \emptyset$  and  $m > \lambda_1$ , then  $(\Phi_m^{(\beta)})^*|\lambda) = 0$ .
- *Proof.* (A): If  $n = 1$ , we have

For  $n > 1$  case, (A) follows immediately from  $[(\phi_0^{(\beta)})^*, \phi_n^{[\beta]}]_+ = 0$  and the annihilation rule [\(7\)](#page-3-4).

(B): We prove (B) by induction on  $s \ge 1$ . For  $s = 1$  and  $\mu_1 = 0$  case, (B) is nothing but (A). For  $s = 1$  and  $\mu_1 > 0$  case, (B) follows from

$$
(\mu|\phi_n^{[\beta]} = \langle 0 | e^{\theta} (\Phi_{\mu_1}^{(\beta)})^* \phi_n^{[\beta]} \stackrel{\text{Lemma }3.4}{=} - \langle 0 | e^{\theta} \phi_n^{[\beta]} (\Phi_{\mu_1}^{(\beta)})^* \stackrel{\text{Cor }4.3}{=} - \langle 0 | (\phi_n^{[\beta]} + \beta \phi_{n-1}^{[\beta]}) e^{\theta} (\Phi_{\mu_1}^{(\beta)})^* = 0,
$$

where the last equality follows from [\(7\)](#page-3-4). For general  $s > 1$ , let  $\mu' = (\mu_2 > \cdots > \mu_s \ge 0)$ . Then, we have

$$
(\mu|\phi_n^{[\beta]} = (\mu'|e^{\theta}(\Phi_{\mu_1}^{(\beta)})^*\phi_n^{[\beta]} = -(\mu'|e^{\theta}\phi_n^{[\beta]}(\Phi_{\mu_1}^{(\beta)})^* = -(\mu'|(\phi_n^{[\beta]} + \beta\phi_{n-1}^{[\beta]})e^{\theta}(\Phi_{\mu_1}^{(\beta)})^* = 0,

where the last equality follows from the induction hypothesis.

(C): (C) follows from the fact that  $|\lambda\rangle$  is a  $\mathbb{Q}(\beta)$ -linear combination of elements of the form  $\phi_{n_1}^{[\beta]} \phi_{n_2}^{[\beta]} \dots \phi_{n_r}^{[\beta]} |0\rangle$  with  $m > n_1 > n_2 > \dots > n_r \ge 0$  (see Corollary [4.3](#page-7-13) (2)).

*Proof of Theorem [6.1.](#page-10-0)* Let  $E = (\mu|\lambda)$ . Note that E is automatically 0 when  $r + s$  is odd.

(i) Assume  $s = 0$ . We have  $E = \langle 0|0\rangle = 1$  if  $r = 0$ . We have  $E = 0$  if  $r = 1$  since  $r + s$  is odd. If  $r \geq 2$ , since  $\lambda_1$  must be positive, we have  $E = (\emptyset|\lambda) = 0$  by the annihilation rule [\(7\)](#page-3-4).

(ii) When  $s > 0$  and  $r = 0$ , we can show  $E = 0$  in a similar manner to (i).

(iii) For general  $r, s \geq 0$ , we prove the theorem by induction on  $s \geq 0$ . If  $\mu_1 < \lambda_1$ ,  $E = 0$ follows from Lemma [6.2](#page-10-2) (B). If  $\mu_1 > \lambda_1$ ,  $E = 0$  follows from Lemma 6.2 (C). Assume  $\mu_1 = \lambda_1$ . If  $\mu_1 = \lambda_1 = 0$ , we have

$$
E = \langle 0 | e^{\theta} (\phi_0^{(\beta)})^* \phi_0^{[\beta]} e^{-\theta} | 0 \rangle
$$

{}^{Cor}_{=} 4.3 \langle (\phi_0^{(\beta)} - \beta \phi_1^{(\beta)} + \beta^2 \phi_2^{(\beta)} - \cdots)^* (\phi_0^{[\beta]} + \beta \phi_1^{[\beta]} ) \rangle \stackrel{(7)}{=} \langle (\phi_0^{(\beta)})^* \phi_0^{[\beta]} \rangle = 1.

If  $\mu_1 = \lambda_1 > 0$ , letting  $\lambda' = (\lambda_2 > \cdots > \lambda_r \ge 0)$  and  $\mu' = (\mu_2 > \cdots > \mu_s \ge 0)$ , we have

$$
E = (\mu|\lambda) = (\mu'|e^{\theta}(\Phi_{\mu_1}^{(\beta)})^* \phi_{\lambda_1}^{[\beta]} e^{-\theta}|\lambda')
$$

= (\mu'|e^{\theta} \{1 - \phi_{\lambda_1}^{[\beta]}(\Phi_{\mu_1}^{(\beta)})^* \} e^{-\theta}|\lambda')

 (Lemma 3.4)

= (\mu'|\lambda') - (\mu'|e^{\theta} \phi_{\lambda_1}^{[\beta]}(\Phi_{\mu_1}^{(\beta)})^* e^{-\theta}|\lambda')

 (Cor. 4.3).

By Lemma [6.2](#page-10-2) (C), the second term of the last expression is 0. Therefore,  $E = (\mu'|\lambda')$ . By induction hypothesis, we conclude  $E = \delta_{\mu,\lambda}$ .

**Corollary 6.3.** Let  $gq_n(x) = gq_{(n)}(x)$  and  $gq(z) = \sum_{n=0}^{\infty} gq_n(x)z^n$ . Then, we have

(25) 
$$
gq(z) = \left\langle e^{\mathcal{H}^{[\beta]}} \phi^{[\beta]}(z) \phi_0 \right\rangle = \prod_i \frac{1 - x_i \overline{z}}{1 - x_i z}.
$$

Equivalently, we have

e^{\mathcal{H}^{[\beta]}}\phi^{[\beta]}(z)e^{-\mathcal{H}^{[\beta]}} = gq(z)\cdot \phi^{[\beta]}(z).

6.2. Generating function of  $q\bar{q}\lambda$ . We can derive a generating function of  $q\bar{q}\lambda(x)$  from Theorem [6.1.](#page-10-0) Assume  $r$  to be even. From Theorem [6.1,](#page-10-0) we have

By Wick's theorem [\(5\)](#page-3-3), the expectation value on the right hand side is calculated as

= \prod_{i=1}^{r} \frac{1}{(1+\beta z_i)^{i-1}} \cdot \text{Pf}\left( \langle e^{\mathcal{H}^{[\beta]}} \phi^{[\beta]}(z_i) \phi^{[\beta]}(z_j) \rangle \right)_{1 \leq i < j \leq r}

\n

= \prod_{i=1}^{r} \frac{1}{(1+\beta z_i)^{i-1}} \cdot \text{Pf}\left( gq(z_i)gq(z_j) \langle \phi^{[\beta]}(z_i) \phi^{[\beta]}(z_j) \rangle \right)_{1 \leq i < j \leq r} \qquad \text{(Eq. (26))}

By using Ikeda-Naruse's formula [\(21\)](#page-9-3), we find that the Pfaffian [\(27\)](#page-12-2) equals to

\prod_{i=1}^r \frac{gq(z_i)}{(1+\beta z_i)^{i-1}} \cdot \prod_{1 \leq i < j \leq r} \frac{z_i - z_j}{z_i \oplus z_j} = \prod_{i=1}^r gq(z_i) \cdot \prod_{1 \leq i < j \leq r} \frac{z_i \ominus z_j}{z_i \oplus z_j}.

Finally, we obtain the desired generating function

where the rational function on the right hand side expands in the field

The generating function [\(28\)](#page-12-1) was firstly conjectured in [\[15,](#page-15-5) Conjecture 5.3]. Since the right hand side of [\(28\)](#page-12-1) admits the substitution  $\lambda_r = 0$ , we obtain  $g q_{(\lambda,0)} = g q_\lambda$ .

6.3. Fermionic description of  $qp_{\lambda}$ . We now proceed to the dual K-Q-function  $qp_{\lambda}$ . Unexpectedly, a fermionic description of  $gp_\lambda$  is significantly different from that of  $gq_\lambda$ . By analogy, one may expect the symmetric function

gp'_{\lambda}(x) = \begin{cases} \langle e^{\mathcal{H}^{[\beta]}} \Phi_{\lambda_1}^{[\beta]} e^{-\theta} \Phi_{\lambda_2}^{[\beta]} e^{-\theta} \dots \Phi_{\lambda_r}^{[\beta]} e^{-\theta} \\ \langle e^{\mathcal{H}^{[\beta]}} \Phi_{\lambda_1}^{[\beta]} e^{-\theta} \Phi_{\lambda_2}^{[\beta]} e^{-\theta} \dots \Phi_{\lambda_r}^{[\beta]} e^{-\theta} \phi_0^{[\beta]} e^{-\theta} \rangle & (r: \text{odd}) \end{cases}
$$

to be a possible candidate for  $qp_\lambda(x)$ . However, we have

(30) 
$$
\langle GQ_{\lambda}, gp_{\mu}' \rangle \neq \delta_{\lambda, \mu},
$$

which contradicts the expectation. This difference is due to the fact that the operators  $\Phi_n^{[\beta]}, \Phi_{-n}^{(\beta)}$  $(n > 0)$  do not annihilate the vacuum vectors (see [\(12\)](#page-4-4)). For instance, we have the inequality

$$
\langle GQ_{\emptyset},gp_n'\rangle = \langle e^{\theta}(\phi_0^{(\beta)})^* \Phi_n^{[\beta]} e^{-\theta}\rangle = \frac{(-\beta)^n}{2^{n+1}} \langle e^{\theta}(\phi_0^{(\beta)})^* \phi_0^{[\beta]} e^{-\theta}\rangle = \frac{(-\beta)^n}{2^{n+1}} \neq 0.
$$

To address the issue, we introduce the new vector  $|\lambda\rangle_p \in \mathcal{F}$  by

<span id="page-12-3"></span>
$$
|\lambda\rangle_p = (\Phi_{\lambda_1}^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2})^{\lambda_1})e^{-\theta}(\Phi_{\lambda_2}^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2})^{\lambda_2})e^{-\theta} \cdots e^{-\theta}(\Phi_{\lambda_r}^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2})^{\lambda_r})(\phi_0 + 1)|0\rangle
$$

for a strict partition  $\lambda = (\lambda_1 > \cdots > \lambda_r > 0)$ . We should note that  $|\lambda\rangle_p$  is not an element of  $\mathcal{F}_{even}$ .

<span id="page-12-0"></span>**Theorem 6.4.** For a strict partition  $\lambda = (\lambda_1 > \cdots > \lambda_r > 0)$ , we have

(31) 
$$
gp_{\lambda}(x) = \langle 0|e^{\mathcal{H}^{[\beta]}}|\lambda\rangle_p.
$$

Recall that, if  $\langle v | \in \mathcal{F}_{even}^*$  and  $|w\rangle \in \mathcal{F}_{odd}$ , the expectation value  $\langle v | w \rangle$  vanishes automatically. Let  $|\lambda\rangle_p = |\lambda_{even}\rangle_p + |\lambda_{odd}\rangle_p$  be the unique decomposition satisfying  $|\lambda_{even}\rangle_p \in \mathcal{F}_{even}$  and  $|\lambda_{odd}\rangle_p \in \mathcal{F}_{odd}$ . As  $\langle 0 | e^{\mathcal{H}^{[\beta]}} | \lambda_{odd} \rangle_p = 0$ , [\(31\)](#page-12-3) is equivalent to  $gp_\lambda(x) = \langle 0 | e^{\mathcal{H}^{[\beta]}} | \lambda_{even} \rangle_p$ . On the other hand, we have  $Q\langle\mu|\lambda\rangle_p = Q\langle\mu|\lambda_{even}\rangle_p$  by the same reason. Henceforth, Theorem [6.4](#page-12-0) is equivalent to

(32) 
$$
Q \langle \mu | \lambda \rangle_p = \delta_{\lambda, \mu}, \qquad (\forall \mu).
$$

For a decreasing sequence  $\mu = (\mu_1 > \cdots > \mu_s \geq 0)$ , let

<span id="page-12-4"></span>
$$
\langle \mu | := \langle 0 | (\phi_0 + 1) e^{\theta} (\phi_{\mu_s}^{(\beta)})^* \dots e^{\theta} (\phi_{\mu_2}^{(\beta)})^* e^{\theta} (\phi_{\mu_1}^{(\beta)})^*,
$$
  

$$
|\lambda \rangle \rangle := (\Phi_{\lambda_1}^{[\beta]} - \frac{1}{2} (-\frac{\beta}{2})^{\lambda_1}) e^{-\theta} (\Phi_{\lambda_2}^{[\beta]} - \frac{1}{2} (-\frac{\beta}{2})^{\lambda_2}) e^{-\theta} \dots (\Phi_{\lambda_r}^{[\beta]} - \frac{1}{2} (-\frac{\beta}{2})^{\lambda_r}) |0\rangle.
$$

Since  $\langle (\phi_0 + 1)X \rangle = \langle X(\phi_0 + 1) \rangle$  for any  $X \in \mathcal{A}$ , [\(32\)](#page-12-4) is equivalent to

$$
\langle \langle \mu | \lambda \rangle \rangle = \delta_{\lambda, \mu}.
$$

<span id="page-13-0"></span>Lemma 6.5. We have the following:

- <span id="page-13-1"></span>(A). If  $\mu = \emptyset$  and  $n \geq 0$ , then  $\langle \emptyset | (\Phi_n^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2}))$  $\frac{\beta}{2})^n$  = 0.
- (B). If  $\mu \neq \emptyset$  and  $n > \mu_1$ , then  $\langle \mu | (\Phi_n^{[\beta]} \frac{1}{2}(-\frac{\beta}{2}))$  $(\frac{\beta}{2})^n) = 0.$
- (C). If  $\lambda \neq \emptyset$  and  $m > \lambda_1$ , then  $(\phi_m^{(\beta)})^* |\lambda \rangle = 0$ .

Proof. (A): It is straightforward to derive

$$
\langle\!\langle \emptyset | (\Phi_n^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2})^n) = \langle 0 | (\phi_0 + 1)(\Phi_n^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2})^n) = \frac{1}{2}(-\frac{\beta}{2})^n \langle 0 | (\phi_0 + 1)(\phi_0 - 1) \rangle
$$
\n
$$
= \frac{1}{2}(-\frac{\beta}{2})^n \langle 0 | (\phi_0^2 - 1) = 0.
$$
\n(Eq. (11))

(B): For any  $s \geq 1$ , we have

$$
\langle \mu | (\Phi_n^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2})^n) = \langle \mu' | e^{\theta}(\phi_{\mu_1}^{(\beta)})^* (\Phi_n^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2})^n) = \langle \mu' | e^{\theta}(-\Phi_n^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2})^n)(\phi_{\mu_1}^{(\beta)})^* \rangle
$$
  
= 
$$
\langle \mu' | (-\Phi_n^{[\beta]} - \beta \Phi_{n-1}^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2})^n) e^{\theta}(\phi_{\mu_1}^{(\beta)})^* \qquad \text{(Cor. 4.3 (1))}.
$$

Since

$$
-\Phi_n^{[\beta]} - \beta \Phi_{n-1}^{[\beta]} - \frac{1}{2} \left(-\frac{\beta}{2}\right)^n = -\left(\Phi_n^{[\beta]} - \frac{1}{2} \left(-\frac{\beta}{2}\right)^n\right) - \beta \left(\Phi_{n-1}^{[\beta]} - \frac{1}{2} \left(-\frac{\beta}{2}\right)^{n-1}\right),
$$

we know that  $\langle \mu | (\Phi_n^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2}))$  $(\frac{\beta}{2})^n)$  is a linear combination of  $\langle\!\langle \mu' | (\Phi_n^{[\beta]} - \frac{1}{2}(-\frac{\beta}{2})^n \rangle \rangle$  $(\frac{\beta}{2})^n)$  and  $\langle\!\langle \mu' | (\Phi_{n-1}^{[\beta]}$  $rac{1}{2}(-\frac{\beta}{2})$  $\frac{\beta}{2}$ )<sup>n-1</sup>). We now prove (B) by induction on  $s \ge 1$ . For  $s = 1$ , the desired equation reduces to  $(A)$ . For general  $s > 1$ , (B) immediately follows from the above fact and the induction hypothesis. (C): This claim is proved in a similar way to the proof of Lemma [6.2](#page-10-2) (C).  $\Box$ 

*Proof of Theorem [6.4.](#page-12-0)* Let  $E = \langle \mu | \lambda \rangle$ .

(i) Assume  $s = 0$ . If  $r = 0$ , we have  $E = \langle 0|(\phi_0 + 1)|0\rangle = 1$ . If  $r > 0$ , we have  $E = 0$  from Lemma [6.5](#page-13-0) (A).

(ii) When  $r = 0$  and  $s > 0$ , we have  $E = 0$  from Lemma [6.5](#page-13-0) (C).

(iii) For general  $s, r > 0$ , we prove [\(33\)](#page-13-1) by induction on s. If  $\mu_1 < \lambda_1$ , then  $E = 0$  by Lemma [6.5](#page-13-0) (B). If  $\mu_1 > \lambda_1$ , then  $E = 0$  by Lemma [6.5](#page-13-0) (C). For the case when  $\mu_1 = \lambda_1(> 0)$ , we have

$$
E = \langle \mu' | e^{\theta} (\phi_{\mu_1}^{(\beta)})^* (\Phi_{\lambda_1}^{[\beta]} - \frac{1}{2} (-\frac{\beta}{2})^{\lambda_1}) e^{-\theta} | \lambda' \rangle \rangle
$$
  
\n
$$
= \langle \mu' | e^{\theta} [(\phi_{\mu_1}^{(\beta)})^*, \Phi_{\lambda_1}^{[\beta]}]_{+} e^{-\theta} | \lambda' \rangle \rangle - \langle \mu' | e^{\theta} \Phi_{\lambda_1}^{[\beta]} (\phi_{\mu_1}^{(\beta)})^* e^{-\theta} | \lambda' \rangle \rangle - \frac{1}{2} (-\frac{\beta}{2})^{\lambda_1} \langle \langle \mu' | e^{\theta} (\phi_{\mu_1}^{(\beta)})^* e^{-\theta} | \lambda' \rangle \rangle
$$
  
\n
$$
= \langle \langle \mu' | \lambda' \rangle \rangle - \langle \langle \mu' | e^{\theta} \Phi_{\lambda_1}^{[\beta]} (\phi_{\mu_1}^{(\beta)})^* e^{-\theta} | \lambda' \rangle \rangle - \frac{1}{2} (-\frac{\beta}{2})^{\lambda_1} \langle \langle \mu' | e^{\theta} (\phi_{\mu_1}^{(\beta)})^* e^{-\theta} | \lambda' \rangle \rangle \qquad \text{(Lemma 3.4)},
$$

in which the last two terms equal to 0 because

$$
(\phi_{\mu_1}^{(\beta)})^* e^{-\theta} |\lambda' \rangle = e^{-\theta} (\phi_{\mu_1}^{(\beta)} - \beta \phi_{\mu_1+1}^{(\beta)} + \cdots)^* |\lambda' \rangle \stackrel{\text{Lemma 6.5 (C)}}{=} 0.
$$

Then, we have  $E = \langle \langle \mu' | \lambda' \rangle \rangle = \delta_{\lambda,\mu}$  by induction hypothesis.

6.4. Generating function of  $gp_\lambda$ . From Theorem [6.4,](#page-12-0) we have

$$
gp_{\lambda} = [z_1^{\lambda_1} \dots z_r^{\lambda_r}] \left\langle e^{\mathcal{H}^{[\beta]}} \left( \Phi^{[\beta]}(z_1) - \frac{1}{2 + \beta z_1} \right) e^{-\theta} \cdots e^{-\theta} \left( \Phi^{[\beta]}(z_r) - \frac{1}{2 + \beta z_r} \right) (\phi_0 + 1) \right\rangle.
$$

By Wick's theorem [\(5\)](#page-3-3), the expectation value on the right hand side is calculated as

$$
\prod_{i=1}^{r} \frac{1}{2 + \beta z_i} \left\langle e^{\mathcal{H}^{[\beta]}} \left( \phi^{[\beta]}(z_1) - 1 \right) e^{-\theta} \cdots e^{-\theta} \left( \phi^{[\beta]}(z_r) - 1 \right) (\phi_0 + 1) \right\rangle
$$
\n
$$
= \prod_{i=1}^{r} \frac{1}{2 + \beta z_i} \sum_{\substack{0 \leq a \leq r \\ i_1 < i_2 < \cdots < i_a}} (-1)^{r-a} \left\langle e^{\mathcal{H}^{[\beta]}} e^{-(i_1 - 1)\theta} \phi^{[\beta]}(z_{i_1}) e^{-(i_2 - i_1)\theta} \phi^{[\beta]}(z_{i_2}) \right.
$$
\n
$$
\cdots e^{-(i_a - i_{a-1})\theta} \phi^{[\beta]}(z_{i_a}) (\phi_0 + 1) \right\rangle
$$
\n
$$
= \prod_{i=1}^{r} \frac{1}{2 + \beta z_i} \sum_{\substack{0 \leq a \leq r \\ i_1 < i_2 < \cdots < i_a}} (-1)^{r-a} \prod_{\kappa=1}^{a} \frac{1}{(1 + \beta z_{i_\kappa})^{i_\kappa - 1}} \left\langle e^{\mathcal{H}^{[\beta]}} \phi^{[\beta]}(z_{i_1}) \cdots \phi^{[\beta]}(z_{i_a}) (\phi_0 + 1) \right\rangle
$$
\n
$$
= \prod_{i=1}^{r} \frac{1}{2 + \beta z_i} \sum_{\substack{0 \leq a \leq r \\ i_1 < i_2 < \cdots < i_a}} (-1)^{r-a} \prod_{\kappa=1}^{a} \frac{g q(z_{i_\kappa})}{(1 + \beta z_{i_\kappa})^{i_\kappa - 1}} \prod_{i_\kappa < i_\theta} \frac{z_{i_\kappa} - z_{i_\theta}}{z_{i_\kappa} \oplus z_{i_\theta}}
$$
\n
$$
= \prod_{i=1}^{r} \frac{1}{2 + \beta z_i} \sum_{\substack{0 \leq a \leq r \\ i_1 < i_2 < \cdots < i_a}} (-1)^{r-a} \prod_{\kappa=1}^{a} \frac{g q(z_{i_\kappa})}{(1 + \beta z_{i_\kappa
$$

Finally, we obtain the desired generating function

<span id="page-14-3"></span>
$$
(34) \qquad gp_{\lambda} = [z_1^{\lambda_1} \dots z_r^{\lambda_r}] \prod_{i=1}^r \frac{1}{2 + \beta z_i} \sum_{\substack{0 \le a \le r \\ i_1 < i_2 < \dots < i_a}} (-1)^{r-a} \prod_{\kappa=1}^a \frac{gq(z_{i_{\kappa}})}{(1 + \beta z_{i_{\kappa}})^{i_{\kappa} - \kappa}} \prod_{1 \le \kappa < \theta \le a} \frac{z_{i_{\kappa}} \ominus z_{i_{\theta}}}{z_{i_{\kappa}} \oplus z_{i_{\theta}}}.
$$

If we substitute  $\lambda_{r+1} = 0$  on the right hand side of [\(34\)](#page-14-3), we obtain  $gp_{(\lambda,0)} = 0$ .

**Example 6.6.** Let  $gp_n = gp_{(n)}$  for the one-row partition  $\lambda = (n)$ . From [\(34\)](#page-14-3), the generating function of  $gp_n$  is

(35) 
$$
\sum_{n=1}^{\infty} g p_n z^n = \frac{1}{2 + \beta z} (g q(z) - 1).
$$

## APPENDIX A. EXAMPLES OF DUAL  $K-P$ -functions and dual  $K-Q$ -functions

In this appendix, we demonstrate how to obtain  $q\bar{q}\lambda$  and  $q\bar{p}\lambda$  from our generating functions [\(28\)](#page-12-1) and [\(34\)](#page-14-3) for simplest cases. For  $N > 0$ , denote  $\mathbf{x}_N = (x_1, x_2, ..., x_N, 0, 0, ...)$ .

A.1.  $gq_n$ . For the single variable case  $x = (x, 0, 0, \ldots),$  [\(25\)](#page-11-1) implies

(36) 
$$
g q_n(x) = 2x^n - \beta x^{n-1} + \beta^2 x^{n-2} - \dots + (-\beta)^{n-1} x, \qquad g q_0(x) = 1.
$$

For general  $\mathbf{x}_N = (x_1, x_2, \dots, x_N, 0, 0, \dots), g q_n(\mathbf{x}_N)$  is obtained by the branching rule

<span id="page-15-8"></span>
$$
g q_n(\mathbf{x}_N) = \sum_{i_1 + \dots + i_N = n} g q_{i_1}(x_1) \cdots g q_{i_N}(x_N),
$$

which follows from [\(25\)](#page-11-1). For example, when  $N = 2$ , we have

<span id="page-15-9"></span>(37) 
$$
g_{q1}(x, y) = 2x + 2y,
$$

$$
g_{q2}(x, y) = 2x^{2} + 4xy + 2y^{2} - \beta x - \beta y,
$$

$$
g_{q3}(x, y) = 2x^{3} + 4x^{2}y + 4xy^{2} + 2y^{2} - \beta x^{2} - 4\beta xy - \beta y^{2} + \beta^{2} x + \beta^{2} y.
$$

A.2.  $g q_\lambda$  for  $\ell(\lambda) \leq 3$ . In the field  $\mathbb{Q}(\beta)((z))((w))((t))$ , the rational function  $\frac{z \ominus w}{z \oplus v} \frac{z \ominus t}{z \oplus t} \frac{w \ominus t}{w \oplus t}$  expands as

<span id="page-15-7"></span>(38) 
$$
1 - (2z^{-1} + 2\beta)w + (2z^{-2} + 5\beta z^{-1} + 3\beta^2)w^2 + \cdots - \{2w^{-1} - 2z^{-1} - (2\beta z^{-1} + 2\beta^2)w + (4\beta z^{-2} + 8\beta^2 z^{-1} + 4\beta^3)w^2 + \cdots\}t + \cdots
$$

Let  $[l, m, n] = gq_l(\mathbf{x}_N)g q_m(\mathbf{x}_N)g q_n(\mathbf{x}_N)$ . From [\(28\)](#page-12-1) and [\(38\)](#page-15-7), we obtain

$$
g_{(l,m,n)}(\mathbf{x}_N) = [l, m, n] - 2[l + 1, m - 1, n] - 2\beta[l, m - 1, n] + 2[l + 2, m - 2, n] + 5\beta[l + 1, m - 2, n] + 3\beta^2[l, m - 2, n] - 2[l, m + 1, n - 1] + 2[l + 1, m, n - 1] + 2\beta[l + 1, m - 1, n - 1] + 2\beta^2[l, m - 1, n - 1] - 4\beta[l + 2, m - 2, n - 1] - 8\beta^2[l + 1, m - 2, n - 1] - 4\beta^3[l, m - 2, n - 1] + \cdots
$$

By substituting [\(36\)](#page-15-8) to this equation, we have

$$
g_{(2,1)}(x,y) = 4x^2y + 4xy^2 - 4\beta x^2 - 4\beta xy - 4\beta y^2,
$$
  
\n
$$
g_{(3,1)}(x,y) = 4x^3y + 8x^2y^2 + 4xy^3 - 4\beta x^3 - 10\beta x^2y - 10\beta xy^2
$$
  
\n
$$
-4\beta y^3 + 2\beta^2 x^2 + 2\beta^2 xy + 2\beta^2 y^2,
$$
  
\n
$$
g_{(3,2)}(x,y) = 4x^2y^3 + 4x^3y^2 - 10\beta x^3y - 16\beta x^2y^2 - 10\beta xy^3 + 6\beta^2 x^2y + 9\beta^2 xy^2
$$
  
\n
$$
+6\beta^2 x^3 - \beta^3 x^2 - \beta^3 xy - \beta^3 y^2,
$$
  
\n
$$
g_{(3,2,1)}(x,y) = -16\beta x^2y^3 - 16\beta x^3y^2 + 16\beta^2 x^3y + 16\beta^2 x^2y^2 + 16\beta^2 xy^3
$$
  
\n
$$
-8\beta^3 x^3 - 8\beta^3 x^2y - 8\beta^3 xy^2 - 8\beta^3 y^3.
$$

**Remark A.1.** Even when  $\lambda$  is not strict,  $g q_\lambda(x, y)$  can be non-trivial. For example, we have

$$
gq_{(-1,1)}(x,y) = -2,
$$
  $gq_{(0,1)}(x,y) = -2x - 2y - 2\beta,$   $gq_{(1,1)}(x,y) = -2\beta x - 2\beta y.$ 

By degree counting, we can prove  $gq_{(l,m,n)} = 0$  unless  $l + m + n \geq 0$ .

A.3.  $gp_n$  for  $n \leq 3$ . From [\(35\)](#page-14-10), we obtain

$$
gp_n(\mathbf{x}_N)=\frac{1}{2}gq_n(\mathbf{x}_N)-\frac{\beta^2}{4}gq_{n-1}(\mathbf{x}_N)+\cdots+\left(-\frac{\beta}{2}\right)^n gq_1(\mathbf{x}_N).
$$

For  $N = 1, 2$ , we have

gp_n(x) = x^n - \beta x^{n-1} + \beta^2 x^{n-2} - \dots + (-\beta)^{n-1} x,

gp_1(x, y) = x + y,

gp_2(x, y) = x^2 + 2xy + y^2 - \beta x - \beta y,

gp_3(x, y) = x^3 + 2x^2y + 2xy^2 + y^3 - \beta x^2 - 3\beta xy - \beta y^2 + \beta^2 x + \beta^2 y.
$$

A.4.  $gp_{(m,n)}$  for  $\ell(\lambda) \leq 2$ . From the generating function [\(34\)](#page-14-3) for  $r = 2$ , we have

$$
gp_{(m,n)}(\mathbf{x}_N) = \frac{1}{4} \sum_{i,j=0}^{\infty} \left( -\frac{\beta}{2} \right)^{i+j} g q_{(m-i,n-j)}(\mathbf{x}_N) - \frac{1}{4} \sum_{i=0}^{\infty} \left( -\frac{\beta}{2} \right)^{n+i} g q_{m-i}(\mathbf{x}_N) - \frac{1}{2} \left( -\frac{\beta}{2} \right)^m \sum_{j=0}^{\infty} (-\beta)^j \left( 1 - \frac{1}{2^{j+1}} \right) g q_{n-j}(\mathbf{x}_N) + \frac{1}{4} \left( -\frac{\beta}{2} \right)^{m+n}.
$$

By substituting [\(39\)](#page-16-0) to this equation, we obtain

gp_{(3,2)}(x,y) = x^3y^2 + x^2y^3 - 3\beta x^3y - 5\beta x^2y^2 - 3\beta xy^3

+ 2\beta^2x^3 + 4\beta^2x^2y + 4\beta^2xy^2 + 2\beta^2y^3 - \beta^3x^2 - \beta^3xy - \beta^3y^2.

A.5.  $gp_{(3,2,1)}(x,y)$ . From the generating function [\(34\)](#page-14-3) for  $r=3$ , we have

$$
gp_{(l,m,n)}(\mathbf{x}_{N}) = \frac{1}{8} \sum_{i,j,k=0}^{\infty} \left( -\frac{\beta}{2} \right)^{i+j+k} g q_{(l-i,m-j,n-k)}(\mathbf{x}_{N}) - \frac{1}{8} \sum_{i,j=0}^{\infty} \left( -\frac{\beta}{2} \right)^{n+i+j} g q_{(l-i,m-j)}(\mathbf{x}_{N}) - \frac{1}{4} \sum_{i,k=0}^{\infty} \left( -\frac{\beta}{2} \right)^{m+i} (-\beta)^{k} \left( 1 - \frac{1}{2^{k+1}} \right) g q_{(l-i,n-k)}(\mathbf{x}_{N}) - \frac{1}{2} \left( -\frac{\beta}{2} \right)^{l} \sum_{j,k=0}^{\infty} (-\beta)^{j+k} \left( 1 - \frac{1}{2^{j+1}} \right) \left( 1 - \frac{1}{2^{k+1}} \right) g q_{(m-j,n-k)}(\mathbf{x}_{N}) + \frac{1}{8} \sum_{i=0}^{\infty} \left( -\frac{\beta}{2} \right)^{m+n+i} g q_{l-i}(\mathbf{x}_{N}) + \frac{1}{4} \left( -\frac{\beta}{2} \right)^{l+n} \sum_{j=0}^{\infty} (-\beta)^{j} \left( 1 - \frac{1}{2^{j+1}} \right) g q_{m-j}(\mathbf{x}_{N}) + \frac{1}{4} \left( -\frac{\beta}{2} \right)^{l+m} \sum_{k=0}^{\infty} (-\beta)^{k} \left( k + \frac{1}{2^{k+1}} \right) g q_{n-k}(\mathbf{x}_{N}) - \frac{1}{8} \left( -\frac{\beta}{2} \right)^{l+m+n}.
$$

By substituting [\(39\)](#page-16-0), we obtain

<span id="page-17-0"></span> $gp_{(3,2,1)}(x,y)=-2\beta x^{3}y^{2}-2\beta x^{2}y^{3}+2\beta^{2}x^{3}y+2\beta^{2}x^{2}y^{2}+2\beta^{2}xy^{3}-\beta^{3}x^{3}-\beta^{3}x^{2}y-\beta^{3}xy^{2}-\beta^{3}y^{3}.$ (41)

**Remark A.2.** In the paper [\[12\]](#page-15-0), Lewis-Marberg provided a combinatorial description of  $qp_{\lambda}$  and  $gq<sub>\lambda</sub>$  using shifted set-valued tableaux. We can verify that the expressions [\(37\)](#page-15-9), [\(39\)](#page-16-0), [\(40\)](#page-16-1), and [\(41\)](#page-17-0) consistent with their combinatorial description.
