# STRONG EDGE-COLORING OF 2-DEGENERATE GRAPHS

#### Abstract

A strong edge-coloring of a graph $G$ is an edge-coloring in which every color class is an induced matching, and the strong chromatic index $\chi_{s}^{\prime}(G)$ is the minimum number of colors needed in strong edge-colorings of $G$. A graph is 2-degenerate if every subgraph has minimum degree at most 2. Choi, Kim, Kostochka, and Raspaud (2016) showed $\chi_{s}^{\prime}(G) \leq 5 \Delta+1$ if $G$ is a 2-degenerate graph with maximum degree $\Delta$. In this article, we improve it to $\chi_{s}^{\prime}(G) \leq 5 \Delta-\Delta^{1 / 2-\epsilon}+2$ when $\Delta \geq 4^{1 /(2 \epsilon)}$ for any $0<\epsilon \leq 1 / 2$.


## 1. Introduction

A strong edge-coloring of a graph $G$ is an edge-coloring in which every color class is an induced matching; that is, there are no 2-edge-colored triangles or paths of three edges. The strong chromatic index $\chi_{s}^{\prime}(G)$ is the minimum number of colors in a strong edge-coloring of $G$. This notion was introduced by Fouquet and Jolivet [9] and one of the main open problems was proposed by Erdős and Nešetřil [8] during a seminar in Prague:

Conjecture 1 (Erdős and Nešetřil, 1985). If $G$ is a simple graph with maximum degree $\Delta$, then $\chi_{s}^{\prime}(G) \leq 5 \Delta^{2} / 4$ if $\Delta$ is even, and $\chi_{s}^{\prime}(G) \leq\left(5 \Delta^{2}-2 \Delta+1\right) / 4$ if $\Delta$ is odd.

This conjecture is true for $\Delta \leq 3$, see [1, 10. For $\Delta=4$, Huang, Santana and Yu 11 showed that $\chi_{s}^{\prime}(G) \leq 21$, one more than the conjectured upper bound 20 . Chung, Gyárfás, Trotter, and Tuza (1990, [6]) confirmed the conjecture for $2 K_{2}$-free graphs. Using probabilistic methods, Molloy and Reed [14], Bruhn and Joos [3], Bonamy, Perrett, and Postle [2], and recently Hurley, Verclos, and Kang [12] showed that $\chi_{s}^{\prime}(G) \leq 1.772 \Delta^{2}$ for sufficiently large $\Delta$.

Sparse graphs have also attracted a lot of attention. Interested readers may see the survey paper [7] for more details. In this article, we are interested in $k$-degenerate graphs when $k=2$. A graph is $k$-degenerate if every subgraph has minimum degree at most $k$.

Let $G$ be a 2-degenerate graph with maximum degree $\Delta \geq 2$. Chang and Narayanan [4] proved that $\chi_{s}^{\prime}(G) \leq 10 \Delta-10$. Luo and Yu [13] improved it to $\chi_{s}^{\prime}(G) \leq 8 \Delta-4$. For arbitrary values of $k$, Wang [15] improved the result of Yu [16] and showed the following result.
Theorem 2. If $G$ is a $k$-degenerate graph with maximum degree $\Delta \geq k$, then $\chi_{s}^{\prime}(G) \leq(4 k-2) \Delta-$ $2 k^{2}+1$.

This implies that $\chi_{s}^{\prime}(G) \leq 6 \Delta-7$ for 2-degenerate graph $G$. Choi, Kim, Kostochka, and Raspaud (5) further improved it to $\chi_{s}^{\prime}(G) \leq 5 \Delta+1$ in 2016. Many believe that the optimal bound should be $4 \Delta+C$ for some constant $C$, but no progress has yet been made.

In this article, we show that for any $0<\epsilon \leq 1 / 2$, and $\Delta \geq 4^{1 /(2 \epsilon)}, \chi_{s}^{\prime}(G) \leq 5 \Delta-\Delta^{1 / 2-\epsilon}+2$ for 2-degenerate graph $G$ with maximum degree $\Delta$.

## 2. Main result and its proof

A special vertex is a vertex with at most two neighbors of degree more than two. Every 2degenerate graph contains special vertices, which are the new $2^{-}$-vertices after we remove all vertices of degree at most two. Let $G$ be a 2 -degenerate graph and $S$ be the set of special vertices of $G$. For each $u \in S$, there exists a set $W_{u}$ of vertices such that each $w \in W_{u}$ shares some 2-neighbors with $u$. The capacity of special vertices of $G$ is the maximum number of common 2-neighbors that are shared by a vertex in $S$ and other vertices in $G$. A pendant edge is an edge incident with a leaf (a vertex of degree one). Below is the main result of this article.
Theorem 3. For any $0<\epsilon \leq 1 / 2$, let $D$ be a positive integer when $D \geq 4^{1 /(2 \epsilon)}$, for any 2degenerate graph $G$ with maximum degree $\Delta$, if a vertex $u$ is adjacent to at least $d(u)-D$ leaves when it has $d(u)>D$, and

- $\Delta \leq D+2$ when the capacity of special vertices is at least $D^{1 / 2-\epsilon}$, and
- $\Delta \leq D+D^{1 / 2-\epsilon}$ when the capacity of special vertices is less than $D^{1 / 2-\epsilon}$,
then $\chi_{s}^{\prime}(G) \leq 5 D-D^{1 / 2-\epsilon}+2$.
Proof. Let $G$ be a counterexample with the fewest number of vertices of degree at least two.
Since $G$ is 2-degenerate, $G$ must have a set $S$ of special vertices. Let $u \in S$ and $W_{u}$ be the set whose vertices share 2 -neighbors with $u$ such that the maximum number of common 2 -neighbors of $u$ and vertices of $W_{u}$ is the capacity of special vertices of $G$. Let $W_{u}=\left\{w_{1}, \ldots, w_{s}\right\}$ and $u_{1}, u_{2}$ be the two neighbors of $u$ with degree more than 2 . For each $w_{i} \in W_{u}$, let $W_{i}=\left\{v_{i, 1}, \ldots, v_{i, t_{i}}\right\}$ be the common 2-neighbors of $w_{i}$ and $u$. Then $N(u)=\left\{u_{1}, u_{2}\right\} \cup \bigcup_{i=1}^{s}\left\{v_{i, 1}, \ldots, v_{i, t_{i}}\right\}$. We assume that $t_{1} \geq t_{2} \geq \ldots \geq t_{s} \geq 1$. Then $t_{1}$ is the capacity of special vertices of $G$. It is not hard to see that $u$ has no neighbors of degree one and $w_{i}$ has degree at least two for each $i$.

For edge $u v$, let $N_{2}(u v)$ be the set of edges $x y$ such that $x$ or $y$ is adjacent to $u$ or $v$. By definition, $u v$ should have a color different from the colors on edges in $N_{2}(u v)$ in a valid strong edge-coloring.

Case 1. $t_{1}<D^{1 / 2-\epsilon}$. In this case, we have $\Delta \leq D+D^{1 / 2-\epsilon}$.
Let $G^{\prime}$ be the graph obtained from $G-\left\{u v_{1,1}, \ldots, u v_{s, t_{s}}\right\}$ by adding up to $D^{\frac{1}{2}-\epsilon}$ pendant neighbors to each of $\left\{w_{1}, \ldots, w_{s}\right\}$ so that $w_{i}$ has degree at most $D+D^{1 / 2-\epsilon}$ and $w_{i}$ has at least $D^{\frac{1}{2}-\epsilon}$ pendant neighbors. Then the graph $G^{\prime}$ has fewer vertices of degree at least 2 and can be colored with $5 D-D^{1 / 2-\epsilon}+2$ colors. We modify the coloring of $G^{\prime}$ to obtain a coloring of $G$ according to the following algorithm.
(1) Keep the colors of edges that appear in both $G$ and $G^{\prime}$, but if $w_{i} v_{i, j}$ for some $i, j$ in $G$ has the same color as $u u_{1}$ or $u u_{2}$, then we switch color of $w_{i} v_{i, j}$ with a color on other pendant edges incident to $w_{i}$ in $G^{\prime}$.
(2) For each $i$, if a color $c$ appears on both a pendant edge incident to $w_{i}$ in $G^{\prime}$ and an edge incident to $u_{1}$ or $u_{2}$ (not including $u u_{1}$ and $u u_{2}$ ), then we switch the color of $w_{i} v_{i, j}$ for some $j$ with the color $c$.
(3) After (2), if a color $c$ appears on pendant edges of two or more vertices in $W_{u}$ in $G^{\prime}$, then we switch the color of $w_{i} v_{i, j}$ for some $j$ with $c$ for each such vertex $w_{i} \in W_{u}$.
(4) After (2) and (3), we color the edges $u v_{1,1}, \ldots, u v_{s, t_{s}}$ in reverse order with colors available to them.

Now we show that the above algorithm gives a valid strong edge-coloring of $G$. To do that, we only need to show that each of the edges in $\left\{u v_{1,1}, \ldots, u v_{s, t_{s}}\right\}$ can be colored. Consider $u v_{i, j}$ for $1 \leq i \leq s$ and $1 \leq j \leq t_{i}$. It needs to get a color not on edges in $N_{2}\left(u v_{i, j}\right)$. Note that $N_{2}\left(u v_{i, j}\right)$ contains the edges incident to $u_{1}, u_{2}, w_{i}$ and the edges incident to the 2-neighbors of $u$; So the number of colored edges in $N_{2}\left(u v_{i, j}\right)$, denoted as $n_{2}\left(u v_{i, j}\right)$, is at most

$$
d\left(u_{1}\right)+d\left(u_{2}\right)+d\left(w_{i}\right)+d(u)-3+d(u)-2-t_{i}-\sum_{p=1}^{i-1} t_{p}-(j-1) .
$$

We assume that $n_{2}\left(u v_{i, j}\right) \geq 5 D-D^{1 / 2-\epsilon}+2$, for otherwise, $u v_{i, j}$ can be colored. Because of the way the edges being colored, we have some repeated colors on edges incident to the 2-neighbors of $u$, namely $v_{1,1} w_{1}, v_{1,2} w_{1}, \ldots, v_{s, t_{s}} w_{s}$. The number of colors on $N_{2}\left(u v_{i, j}\right)$ and edges incident to $w_{i}$ for $i \in[s]$ (with repetition) is $n_{2}\left(u v_{i, j}\right)+D^{1 / 2-\epsilon} \cdot(s-1)$. Thus $n_{2}\left(u v_{i, j}\right)+D^{\frac{1}{2}-\epsilon}(s-1)-\left(5 D-D^{\frac{1}{2}-\epsilon}+2\right)$ colors are repeated. As each $w_{i}$ may allow only one edge (for example, $t_{i}=1$ ) whose color is the same as other edges in $N_{2}\left(u v_{i, j}\right)$, at least $\frac{n_{2}\left(u v_{i, j}\right)+D^{\frac{1}{2}-\epsilon}(s-1)-\left(5 D-D^{\frac{1}{2}-\epsilon}+2\right)}{D^{\frac{1}{2}-\epsilon}}$ edges have the same colors as others. Since $t_{1}<D^{1 / 2-\epsilon}$ and $s \geq \frac{d(u)-2}{t_{1}} \geq \frac{d(u)-2}{D^{1 / 2-\epsilon}}$, the number of different colors in $N_{2}\left(u v_{i, j}\right)$ is at most

$$
\begin{aligned}
& n_{2}\left(u v_{i, j}\right)-\frac{n_{2}\left(u v_{i, j}\right)+D^{\frac{1}{2}-\epsilon}(s-1)-\left(5 D-D^{\frac{1}{2}-\epsilon}+2\right)}{D^{\frac{1}{2}-\epsilon}} \\
& \leq n_{2}\left(u v_{i, j}\right)\left(1-\frac{1}{D^{\frac{1}{2}-\epsilon}}\right)-(s-1)+5 D^{1 / 2+\epsilon}-1+\frac{2}{D^{\frac{1}{2}-\epsilon}} \\
& \leq\left(d\left(u_{1}\right)+d\left(u_{2}\right)+2 d(u)-5+d\left(w_{i}\right)-t_{1}\right)\left(1-\frac{1}{D^{\frac{1}{2}-\epsilon}}\right)-\frac{d(u)-2}{D^{1 / 2-\epsilon}}+5 D^{1 / 2+\epsilon}+\frac{2}{D^{\frac{1}{2}-\epsilon}} \\
& \leq 3 \Delta\left(1-\frac{1}{D^{\frac{1}{2}-\epsilon}}\right)+d(u)\left(2-\frac{3}{D^{\frac{1}{2}-\epsilon}}\right)+5 D^{1 / 2+\epsilon}-5+\frac{9}{D^{\frac{1}{2}-\epsilon}} \\
& \leq 3\left(D+D^{\frac{1}{2}-\epsilon}\right)\left(1-\frac{1}{D^{\frac{1}{2}-\epsilon}}\right)+D\left(2-\frac{3}{D^{\frac{1}{2}-\epsilon}}\right)+5 D^{1 / 2+\epsilon}-5+\frac{9}{D^{\frac{1}{2}-\epsilon}} \\
& \leq 5 D+3 D^{\frac{1}{2}-\epsilon}-D^{1 / 2+\epsilon}-8+\frac{9}{D^{\frac{1}{2}-\epsilon}} \leq 5 D-D^{1 / 2-\epsilon}+1 .
\end{aligned}
$$

The last inequality holds because $D^{1 / 2+\epsilon} \geq 4 D^{1 / 2-\epsilon}$ and $\frac{9}{D^{\frac{1}{2}-\epsilon}} \leq 9$ when $D \geq 4^{\frac{1}{2 \epsilon}}$. Therefore, the edge $u v_{i, j}$ can be colored, which implies that we can color all the uncolored edges.

Case 2. $t_{1} \geq D^{1 / 2-\epsilon}$. In this case, $\Delta \leq D+2$.
Let $G^{\prime}$ be the graph obtained from $G$ by deleting the edge $u v_{1,1}$ and adding up to two pendant edges notated $\left\{w_{1} v^{\prime}, w_{1} v^{\prime \prime}\right\}$ so that $w_{1}$ has at least three pendant edges and continues to have maximum degree at most $D+2$.

Note that for $1 \leq i \leq s$ and $1 \leq j \leq t_{s}$,

$$
\begin{equation*}
\left|N_{2}\left(u v_{i, j}\right)\right| \leq d\left(u_{1}\right)+d\left(u_{2}\right)+d\left(w_{i}\right)+d(u)-3+d(u)-2-t_{i} \leq 3 \Delta+2 D-5-t_{i} \leq 5 D+1-t_{i} . \tag{1}
\end{equation*}
$$

We observe that $G^{\prime}$ is 2-degenerate, has fewer vertices of degree at least 2 , and contains at least $d(v)-D$ vertices of degree one if $d(v)>D$. So, $G^{\prime}$ can be colored with $5 D-D^{1 / 2-\epsilon}+2$ colors. Keep the colors of the edges in both $G$ and $G^{\prime}$, we try to get a valid coloring of $G$.

Case 2.1. the color of edge $v_{1,1} w_{1}$ is different from ones on $\left\{u u_{1}, u u_{2}, u v_{1,2}, \ldots, u v_{s, t_{s}}\right\}$. By (1), we have at most $5 D+1-D^{1 / 2-\epsilon}$ edges in $N_{2}\left(u v_{1,1}\right)$. Since there are $5 D-D^{1 / 2-\epsilon}+2$ different colors available, we can color $u v_{1,1}$ with a color not on the edges in $N_{2}\left(u v_{1,1}\right)$.

Case 2.2. the color of edge $v_{1,1} w_{1}$ is the same as the color of edge $u u_{1}$ (or edge $u u_{2}$ ). In this case, we swap the color of $v_{1,1} w_{1}$ with the color of $w_{1} v^{\prime}$ or $w_{1} v^{\prime \prime}$. By (11) again, $N_{2}\left(u v_{1,1}\right)$ has at most $5 D+1-D^{1 / 2-\epsilon}$ edges in $N_{2}\left(u v_{1,1}\right)$. Since there are $5 D-D^{1 / 2-\epsilon}+2$ different colors available, we can color $u v_{1,1}$ with a color not on the edges in $N_{2}\left(u v_{1,1}\right)$.

Case 2.3. the color of edge $v_{1,1} w_{1}$ is the same as the color of edge $u v_{i, j}$ for some $2 \leq i \leq s$. In this case, we uncolor the edges $u v_{i, j}, u v_{1,1}, \ldots, u v_{1, t_{1}}$, and recolor them in the order. By (1), there are at most $5 D+1-t_{i}-\left(t_{1}-1\right) \leq 5 D-D^{1 / 2-\epsilon}+1$ colors on edges in $N_{2}\left(u v_{i, j}\right)$, so $u v_{i, j}$ can be colored. Similarly, for each $j$, there are at most $5 D-D^{1 / 2-\epsilon}+1$ colors on edges in $N_{2}\left(u v_{1, j}\right)$, so $u v_{1, j}$ can be colored as well.

In any case, $G$ can be colored with $5 D-D^{1 / 2-\epsilon}+2$ colors. So $\chi_{s}^{\prime}(G) \leq 5 D-D^{1 / 2-\epsilon}+2$.
Observe that our main result follows from Theorem 3 with $\Delta=D$. Our proof does not work for corresponding result of list version.
