# ALGEBRAIC IDENTITIES ON Q-HARMONIC NUMBERS AND Q-BINOMIAL COEFFICIENTS

Abstract. The aim of this paper is to present a general algebraic identity. Applying this identity, we provide several formulas involving the q-binomial coefficients and the q-harmonic numbers. We also recover some known identities including an algebraic identity of D. Y. Zheng on q-Apéry numbers and we establish the q-analog of Euler's formula. The proposed results may have important applications in the theory of q-supercongruences.

### 1. Introduction

For an indeterminate  $x$  the q-shifted factorial is usually defined by

$$
(x; q)_0 = 1
$$
 and  $(x; q)_n = (1-x)(1-qx)\cdots(1-q^{n-1}x)$  for  $n = 1, 2, \ldots$ 

The Gaussian q-binomial coefficient is correspondingly given by

$$
\begin{bmatrix} n \\ j \end{bmatrix} = \frac{(q;q)_n}{(q;q)_j(q;q)_{n-j}} \text{ for } j = 0, 1, 2, \dots, n,
$$

The q-harmonic numbers are defined by

$$
\mathcal{H}_n(q) = \sum_{k=1}^n \frac{1}{[k]_q} \text{ for } n = 1, 2, \dots,
$$

where the q-numbers are given by

[k] or 
$$
[k]_q := \frac{1-q^k}{1-q} = 1+q+\cdots+q^{k-1}
$$

Following Comtet [\[7\]](#page-6-0), the complete Bell polynomials can be explicitly expressed as

$$
\mathbf{B}_{n}(x_{1}, x_{2}, \cdots, x_{n}) = \sum_{m_{1}+2m_{2}+\cdots+m_{n}=n} \frac{n!}{m_{1}!m_{2}!\cdots m_{n}!} \left(\frac{x_{1}}{1!}\right)^{m_{1}} \left(\frac{x_{2}}{2!}\right)^{m_{2}} \cdots \left(\frac{x_{n}}{n!}\right)^{m_{n}}
$$

During the last two decades, there has been an increasing interest in studying binomial sums and their q-analogues, one can consult recent papers, for example [\[6,](#page-6-1) [18,](#page-6-2) [19\]](#page-6-3). For a comprehensive account of the q-series and its applications to numbers theory, combinatorics and special functions, we refer the reader to the excellent monograph by G. Gasper and M. Rahman [\[8\]](#page-6-4). Recently, the study of the q-harmonic congruences turned into a very active research area (see e.g., [\[17\]](#page-6-5) and the references therein).

There exist numerous combinatorial identities involving q-binomial coefficients in the mathematical literature (see e.g., [\[6,](#page-6-1) [12,](#page-6-6) [16,](#page-6-7) [18,](#page-6-2) [19\]](#page-6-3)). Nowadays, there has been growing interest in deriving q-analogues of several combinatorial identities. This includes, for example, q-generalizations of some well known identities involving harmonic numbers.

The Apéry numbers are defined by the following binomial sum

$$
A(n) = \sum_{k=0}^{n} {n \choose k}^2 {n+k \choose k}^2
$$

These numbers have many interesting properties that make them extremely useful in the proof of the irrationality of  $\zeta(3)$  (see [\[3\]](#page-6-8) for further details). Also the Apéry numbers have remarkable arithmetic properties [\[9\]](#page-6-9). F. Beukers conjectured [\[4\]](#page-6-10) that

$$
A\left(\frac{p-1}{2}\right) \equiv a(p) \ (mod p^2)
$$

where  $p$  is an odd prime and  $a(n)$  is determined by

$$
\sum_{k=1}^{\infty} a(k)q^k := q \prod_{k=1}^{\infty} (1 - q^{2k})^4 (1 - q^{4k})^4 = q - 4q^3 - 2q^5 + 24q^7 + \cdots
$$

Beukers' conjecture was later showed by S. Ahlgren, K. Ono [\[1\]](#page-6-11), who reduce this statement in terms of the harmonic numbers  $H_n$  to the identity

$$
\sum_{k=1}^{n} {n \choose k}^{2} {n+k \choose k}^{2} \left(1 + 2kH_{n+k} + 2kH_{n-k} - 4kH_{k}\right) = 0
$$

In order to give a classical proof of the last identity, Chu [\[5\]](#page-6-12) presented the following algebraic identity

$$
\sum_{j=0}^{n} {n \choose j}^2 {n+j \choose j}^2 \left(\frac{-j}{(x+j)^2} + \frac{1+2j(H_{n+j}-H_j)+2j(H_{n-j}-H_j)}{x+j}\right) = \frac{x(1-x)_n^2}{(x)_{n+1}^2}
$$

which gives the desired formula in the limit.

In order to prove irrationality results on the q-analog of  $\zeta(3)$ :

$$
\zeta_q(3) = \sum_{k=1}^{+\infty} \frac{q^k (1 + q^k)}{(1 - q^k)^3}
$$

The authors of [\[13\]](#page-6-13) introduced implicitly a q-analog of the Apéry numbers  $A_q^{KRS}(n)$  and they showed that

$$
A_q^{KRZ}(n) = \sum_{k=0}^n \frac{a_q(n,k)}{q^k}
$$

where  $a_q(n, k)$  can be defined via the following q-partial fraction decomposition

$$
\frac{(xq^{-n};q)_n^2}{(x;q)_{n+1}^2} = \sum_{k=0}^n \left( \frac{a_q(n,k)}{(1-q^kx)^2} + \frac{b_q(n,k)}{1-q^kx} \right)
$$

A. Straub [\[17\]](#page-6-5) showed via the partial fraction decomposition technique that  $A_q^{KRS}(n)$  have the following explicit q-binomial representation

$$
q^{n(2n+1)}A_q^{K R Z}(n) = \sum_{k=0}^n q^{(n-k)^2} \binom{n}{k}^2 \binom{n+k}{k}^2
$$

which reduces to Apéry numbers when  $q \to 1$ .

D. Y. Zheng [\[20\]](#page-7-0) has recently introduced the q-Apéry numbers

$$
q^{n(n+1)}A_q^{KRZ}(n) = \sum_{k=0}^{n} q^{k(k-2n)} \binom{n}{k}^{2} \binom{n+k}{k}^{2}
$$

then he established an interesting algebraic identity

$$
\frac{x^{2n}(q/x;q)_n^2}{(1-x)(xq;q)_n^2} = \frac{1}{1-x} + \sum_{j=1}^n \begin{bmatrix} n \\ j \end{bmatrix}^2 q^{j(j-2n)} \left( \frac{q^j - 1}{(1-xq^j)^2} + \frac{1-4[j]\mathcal{H}_j(q) + 2[j]\mathcal{H}_{n+j}(q) + 2q[j]\mathcal{H}_{n-j}(q^{-1})}{1-xq^j} \right)
$$
\n(1.2)

which is a q-extension of the Chu's identity, and obtained the identity

$$
\sum_{k=0}^{n} q^{k(k-2n)} \binom{n}{k}^{2} \binom{n+k}{k}^{2} \left( 2\mathcal{H}_{k}(q) - \mathcal{H}_{n+k}(q) - q\mathcal{H}_{n-k}(q^{-1}) \right) = 0
$$

The purpose of this paper is to establish and develop important algebraic identities involving q-harmonic numbers and q-binomial coefficients, which may have important applications in the theory of q-supercongruences.

### 2. Some identities of q-binomial coefficients

We now state and prove one of the main results of this paper.

<span id="page-2-0"></span>**Theorem 2.1.** Let  $\alpha_1, \alpha_2, \ldots, \alpha_s$  be distinct elements of  $\mathbb{C}$ . For a positive integer m let  $P(x)$  $(x - \alpha_1)^m (x - \alpha_2)^m \cdots (x - \alpha_s)^m$ . For any polynomial  $Q(x)$  such that  $\deg(Q) < \deg(P)$ , we have

$$
\frac{Q(x)}{P(x)} = \sum_{j=1}^{s} \sum_{i=0}^{m-1} \sum_{k=0}^{m-1-i} \frac{(-1)^k g_j(\alpha_j) \mathbf{B}_k(x_1, \cdots, x_k) Q^{(i)}(\alpha_j)}{i! k! (x - \alpha_j)^{m-i-k}}.
$$
\n(2.1)

where

$$
x_l = m(l-1)!\sum_{i=1, i \neq j}^{s} \frac{1}{(\alpha_j - \alpha_i)^l}
$$
 and  $g_j(x) = \prod_{i=1, i \neq j}^{s} (x - \alpha_i)^{-m}$ .

Proof. Following [\[14,](#page-6-14) Eq.4], we can write

$$
Q(x) = \sum_{j=1}^{s} \sum_{i=0}^{m-1} \frac{1}{i!} Q^{(i)}(\alpha_j) L_{ji}(x)[P].
$$

By virtue of Equation (2) of [\[14\]](#page-6-14), it is clear that

$$
L_{ji}(x)[P] = P(x) \sum_{k=0}^{m-1-i} \frac{g_j^{(k)}(\alpha_j)}{k!(x-\alpha_j)^{m-i-k}}
$$

If we combine the two previous identities, we get

$$
\frac{Q(x)}{P(x)} = \sum_{j=1}^{s} \sum_{i=0}^{m-1} \sum_{k=0}^{m-1-i} \frac{g_j^{(k)}(\alpha_j) Q^{(i)}(\alpha_j)}{i! k! (x - \alpha_j)^{m-i-k}}.
$$

Since

$$
g_j(x) = \phi(x) \circ f_j(x)
$$

where  $\phi(x) = \exp(mx)$  and  $f_j(x) = \ln(\prod_{i=1, i\neq j}^{s}(x-\alpha_i)^{-1})$ . Then  $\phi^{(k)}(x) = m^k \exp(mx)$  and  $f_j^{(k)}(x) = (-1)^k (k-1)! \mathcal{H}_{k,\alpha_s[j]}(x)$ , where  $\mathcal{H}_{l,\alpha_s[j]}(x) = \sum_{i=1, i \neq j}^s \frac{1}{(x-\alpha_i)^l}$ . By using the Faà di Bruno formula, we can easily prove that

$$
g_j^{(k)}(x) = (-1)^k g_j(x) \sum_{m_1+2m_2+\cdots+m_k=k} \frac{k!}{m_1! m_2! \cdots m_k!} \prod_{l=1}^k \left(\frac{m(l-1)! \mathcal{H}_{l,\alpha_s[j]}(x)}{l!}\right)^{m_l}
$$

In particular

$$
g_j^{(k)}(\alpha_j) = (-1)^k g_j(\alpha_j) \mathbf{B}_k(x_1, \cdots, x_k)
$$

This gives the required result.

Taking  $\alpha_i = q^{-i}$  in Theorem [\(2.1\)](#page-2-0), we obtain after some minor manipulations the following theorem.

<span id="page-2-1"></span>**Theorem 2.2.** Let m and n positive integers and let  $Q(x)$  be a polynomial such that  $\deg(Q)$  $(n+1)m$ , we have

$$
\frac{(q;q)_n^m Q(x)}{(x;q)_{n+1}^m} = \sum_{j=0}^n {n \brack j}^m q^{m {j+1 \choose 2}} \sum_{i=0}^{m-1} \sum_{k=0}^{m-1-i} \frac{(-1)^{mj+i} \mathbf{B}_k(x_1, x_2, \dots, x_k) Q^{(i)}(q^{-j})}{i! k! q^{j(i+k)} (1-xq^j)^{m-i-k}}.
$$

where

$$
x_1 = \frac{q^j m}{1-q} \bigg(\mathcal{H}_j(q) - q \mathcal{H}_{n-j}(q^{-1})\bigg)
$$

and

$$
x_l = m(l-1)!\sum_{i=0, i \neq j}^{n} \frac{q^{jl}}{(1-q^{j-i})^l}
$$
 for  $l = 1, 2, ..., m-1$ ,

In view of Theorem [\(2.2\)](#page-2-1), we establish interesting corollaries

<span id="page-3-0"></span>**Corollary 2.3.** Let n be a positive integer and let  $Q(x)$  be a polynomial such that  $deg(Q)$  $2(n+1)$ . We have

$$
\frac{(q;q)_n^2 Q(x)}{(x;q)_{n+1}^2} = \sum_{j=0}^n \begin{bmatrix} n \\ j \end{bmatrix}^2 q^{j(j+1)} \left( \frac{Q(q^{-j})}{(1-xq^j)^2} - \frac{q^{-j}Q'(q^{-j})}{(1-xq^j)} + \frac{2Q(q^{-j})}{(1-xq^j)} \left( \frac{\mathcal{H}_j(q) - q\mathcal{H}_{n-j}(q^{-1})}{1-q} \right) \right)
$$

**Identity 2.4.** Setting  $Q(x) = 1$  in the last corollary, we obtain

$$
\frac{(q;q)_n^2}{(x;q)_{n+1}^2} = \sum_{j=0}^n \binom{n}{j}^2 q^{j(j+1)} \left( \frac{1}{(1-xq^j)^2} + \frac{2}{1-xq^j} \left( \frac{\mathcal{H}_j(q) - q\mathcal{H}_{n-j}(q^{-1})}{1-q} \right) \right)
$$

In particular

$$
(q;q)_n^2 = \sum_{j=0}^n {n \choose j}^2 q^{j(j+1)} \left( 1 + 2 \left( \frac{\mathcal{H}_j(q) - q\mathcal{H}_{n-j}(q^{-1})}{1-q} \right) \right)
$$

Identity 2.5.

$$
\frac{x^{2n}(q/x;q)_n^2}{(1-x)(xq;q)_n^2} = \frac{1}{1-x} + \sum_{j=1}^n \begin{bmatrix} n \\ j \end{bmatrix}^2 q^{j(j-2n)} \left( \frac{q^j-1}{(1-xq^j)^2} + \frac{1-4[j]\mathcal{H}_j(q) + 2[j]\mathcal{H}_{n+j}(q) + 2q[j]\mathcal{H}_{n-j}(q^{-1})}{1-xq^j} \right)
$$

This identity recovers Zheng identity [\(1.2\)](#page-1-0).

Proof. Let

$$
Q(x) = (1 - x)(x - q)^2 \cdots (x - q^n)^2 = (1 - x)x^{2n} (q/x;q)_n^2
$$
  
Q  
s verify that

It is not difficult to verify that

$$
\frac{Q(x)}{(x;q)_{n+1}^2} = \frac{x^{2n}(q/x;q)_n^2}{(1-x)(xq;q)_n^2} , \quad Q(q^{-j}) = q^{-j(2n+1)}(q^j-1)(q;q)_n^2 \begin{bmatrix} n+j\\j \end{bmatrix}^2
$$

and

$$
Q'(q^{-j}) = q^{-2nj}(q;q)_n^2 \binom{n+j}{j}^2 \left( -1 - 2[j] \left( \mathcal{H}_{n+j}(q) - \mathcal{H}_j(q) \right) \right)
$$

Applying Corollary  $(2.3)$ , we get after some simplifications the desired identity.  $\Box$ 

## Identity 2.6.

$$
\frac{(xq^{-n};q)_n^2}{(x;q)_{n+1}^2} = \sum_{j=0}^n \begin{bmatrix} n \\ j \end{bmatrix}^2 \begin{bmatrix} n+j \\ j \end{bmatrix}^2 q^{j(j+1)-n(n+2j+1)} \left( \frac{1}{(1-xq^j)^2} + \frac{4\mathcal{H}_j(q) - 2q\mathcal{H}_{n-j}(q^{-1}) - 2\mathcal{H}_{n+j}(q)}{(1-q)(1-xq^j)} \right)
$$

This identity gives the explicit representation of [\(1.1\)](#page-1-1).

*Proof.* Let 
$$
Q(x) = (xq^{-n}; q)_n^2
$$
. We have  $Q(q^{-j}) = q^{-n(n+2j+1)} {n+j \choose j}^2$  and  
\n
$$
Q^{'}(q^{-j}) = 2q^{-n(n+2j+1)+j} {n+j \choose j}^2 \left(\frac{\mathcal{H}_{n+j}(q) - \mathcal{H}_j(q)}{1-q}\right)
$$

Using Corollary  $(2.3)$ , the identity follows.

**Identity 2.7.** Letting  $x = 0$  in the last identity, we obtain

$$
\sum_{j=0}^{n} \binom{n}{j}^{2} \binom{n+j}{j}^{2} q^{j(j+1)-2nj} \left(1-q+4\mathcal{H}_{j}(q)-2q\mathcal{H}_{n-j}(q^{-1})-2\mathcal{H}_{n+j}(q)\right) = q^{n(n+1)}(1-q)
$$

$$
\frac{(q;q)_n^m x^l}{(x;q)_{n+1}^m} = \sum_{j=0}^n {n \brack j}^m q^{m\binom{j+1}{2}} \sum_{i=0}^{m-1} \sum_{k=0}^{m-1-i} {l \choose i} \frac{(-1)^{mj+i} B_k(x_1, x_2, \cdots, x_k)}{k! q^{j(k+l)} (1-xq^j)^{m-i-k}}.
$$

where

$$
x_l = m(l-1)!\sum_{i=0, i \neq j}^{n} \frac{q^{jl}}{(1-q^{j-i})^l}
$$

Corollary 2.9. Let m and n be positive integers. We have

$$
\frac{(q;q)_n^m}{(x;q)_{n+1}^m} = \sum_{j=0}^n \begin{bmatrix} n \\ j \end{bmatrix}^m q^{m\binom{j+1}{2}} \sum_{k=0}^{m-1} \frac{(-1)^{mj} \mathbf{B}_k(x_1, x_2, \cdots, x_k)}{k! q^{jk} (1 - xq^j)^{m-k}}
$$

where

$$
x_l = m(l-1)!\sum_{i=0, i \neq j}^{n} \frac{q^{jl}}{(1-q^{j-i})^l}
$$

<span id="page-4-1"></span>**Corollary 2.10.** Let  $Q(x)$  be a polynomial such that  $deg(Q) < n+1$ . Then we have

$$
\frac{(q;q)_n Q(x)}{(x;q)_{n+1}} = \sum_{j=0}^n (-1)^j \begin{bmatrix} n \\ j \end{bmatrix} q^{\binom{j+1}{2}} \frac{Q(q^{-j})}{(1-xq^j)}.
$$

The limiting case of Theorem [\(2.2\)](#page-2-1), is the following

<span id="page-4-0"></span>**Theorem 2.11.** Let m and n be two positive integers. Let  $Q(x)$  be a polynomial of degree l with leading coefficient  $a_l$ . Then we have the following curious identity:

$$
\sum_{j=0}^{n} {n \choose j}^{m} q^{m {j \choose 2}} \sum_{i=0}^{m-1} \frac{(-1)^{mj+i+1} \mathbf{B}_{m-1-i}(x_1, x_2, \cdots, x_{m-1-i}) Q^{(i)}(q^{-j})}{i!(m-1-i)!} =
$$
  

$$
\begin{cases} 0 & \text{if } 0 \le l < m(n+1)-1, \\ (-1)^{m(n+1)} (q;q)_n^m q^{-m {n+1 \choose 2}} a_l & \text{if } l = m(n+1)-1. \end{cases}
$$

where

$$
x_l = m(l-1)!\sum_{i=0, i \neq j}^{n} \frac{q^{jl}}{(1-q^{j-i})^l}
$$

When  $m = 1$ , the formula of Theorem  $(2.11)$  reads explicitly as

Corollary 2.12. Let n be a positive integer and  $Q(x)$  be a polynomial of degree l with leading coefficient  $a_l$ . Then we have the following identity:

$$
\sum_{j=0}^{n} \begin{bmatrix} n \\ j \end{bmatrix} q^{\binom{j}{2}} (-1)^{j} Q(q^{-j}) = \begin{cases} 0 & \text{if } 0 \le l < n, \\ (-1)^{n} (q;q)_{n} q^{-\binom{n+1}{2}} a_{l} & \text{if } l = n. \end{cases}
$$

**Identity 2.13.** Letting  $Q(x) = (x - 1)^l$  in the last corollary, we obtain, after some simple calculations, that

$$
\sum_{j=0}^{n} \begin{bmatrix} n \\ j \end{bmatrix} q^{\binom{j}{2}-jl} (-1)^{j} [j]^{l} = \begin{cases} 0 & \text{if } 0 \le l < n, \\ (-1)^{n} \frac{(q;q)_{n}}{(1-q)^{n}} q^{-\binom{n+1}{2}} & \text{if } l = n. \end{cases}
$$

We remark that in the limiting case  $q \to 1$  of this identity, we obtain the famous Euler's formula[\[2,](#page-6-15) [10,](#page-6-16) [11,](#page-6-17) [15\]](#page-6-18). Therefore, this identity is the q-analog of Euler's formula:

$$
\sum_{j=0}^{n} {n \choose j} (-1)^j j^l = \begin{cases} 0 & \text{if } 0 \le l < n, \\ (-1)^n n! & \text{if } l = n. \end{cases}
$$

Opting  $m = 2$  in Theorem [\(2.11\)](#page-4-0), we gain the following important result

<span id="page-5-0"></span>**Corollary 2.14.** Let n be a positive integer and  $Q(x)$  be a polynomial of degree l with leading coefficient  $a_l$ . Then the following identity holds:

$$
\sum_{j=0}^{n} \begin{bmatrix} n \\ j \end{bmatrix}^2 q^{j(j-1)} \left( Q^{'}(q^{-j}) - \frac{2q^{j}Q(q^{-j})}{1-q} \left( \mathcal{H}_j(q) - q \mathcal{H}_{n-j}(q^{-1}) \right) \right) = \begin{cases} 0 & \text{if } 0 \le l < 2n+1, \\ (q;q)_n^2 q^{-n(n+1)} a_l & \text{if } l = 2n+1. \end{cases}
$$

**Identity 2.15.** If  $Q(x) = 1$ , then the formula of Corollary [\(2.14\)](#page-5-0) gives

$$
\sum_{j=0}^{n} \binom{n}{j}^{2} q^{j^{2}} \left( \mathcal{H}_{j}(q) - q \mathcal{H}_{n-j}(q^{-1}) \right) = 0
$$

**Identity 2.16.** Choosing  $Q(x) = (1-x)(x-q)^2 \cdots (x-q^n)^2$  in Corollary [\(2.14\)](#page-5-0), we obtain

$$
\sum_{j=0}^{n} \binom{n}{j}^{2} \binom{n+j}{j}^{2} q^{j(j-1)-2nj} \left(1 + 2[j] \mathcal{H}_{n+j}(q) - 4[j] \mathcal{H}_{j}(q) + 2q \mathcal{H}_{n-j}(q^{-1})\right)\right) = q^{-n(n+1)}
$$

It would be interesting to establish some identities by means of Corollary [\(2.10\)](#page-4-1).

**Theorem 2.17.** Let n be a positive integer and y any complex number. Then the following identity holds true:

$$
\sum_{j=0}^{n} (-1)^{j} \begin{bmatrix} n \\ j \end{bmatrix} q^{\binom{j+1}{2} - jn} \frac{(y;q)_{n+j}}{(y;q)_{j}(1-xq^{j})} = \frac{(q;q)_{n}(y/x;q)_{n}x^{n}}{(x;q)_{n+1}}
$$

*Proof.* Let  $Q(x)$  be the polynomial

$$
Q(x) = (x - y)(x - qy) \cdots (x - yq^{n-1}) = (y/x; q)_n x^n
$$

Since

$$
Q(q^{-j}) = (yq^{j}; q)_n q^{-jn}
$$
 and  $(yq^{j}; q)_n = \frac{(y; q)_{n+j}}{(y; q)_j}$ 

we get form Corollary  $(2.10)$  the desired formula.

Letting  $y = q$  in the last theorem, we obtain the following result

<span id="page-5-1"></span>**Theorem 2.18.** Let  $n$  be a positive integer, the following identities hold true (1)

$$
\sum_{j=0}^{n}(-1)^{j}\begin{bmatrix}n\\j\end{bmatrix}\begin{bmatrix}n+j\\j\end{bmatrix}\frac{q^{\binom{j+1}{2}-jn}}{(1-xq^{j})}=\frac{x^{n}(q/x;q)_{n}}{(x;q)_{n+1}}.
$$

(2)

$$
\sum_{j=0}^{n} (-1)^{j} \binom{n}{j} \binom{n+j}{j} \frac{q^{\binom{j+1}{2} - jn}}{(1 - q^{j+l})} = 0.
$$

for  $l = 1, 2, ..., n$ . (3)

$$
\sum_{j=0}^{n-1} (-1)^{n+1+j} \begin{bmatrix} n \\ j \end{bmatrix} \begin{bmatrix} n+j \\ j \end{bmatrix} \frac{(1-q^{n+l})}{(1-q^{j+l})} q^{\binom{j+1}{2}+n^2-jn} = \begin{bmatrix} 2n \\ n \end{bmatrix} q^{\binom{n+1}{2}}.

for  $l = 1, 2, ..., n$ .

Setting  $x = a$  in the first statement of Theorem [\(2.18\)](#page-5-1), we recover Theorem 2 of [\[12\]](#page-6-6). The follwoing result is an extension of Theorem 5 of [\[19\]](#page-6-3).

**Theorem 2.19.** Let n be a positive integer. For  $m = 1, 2, \ldots, n$ , we have

\sum_{j=0}^{n}(-1)^{j}\begin{bmatrix} n \\ j \end{bmatrix} \begin{bmatrix} n+j \\ j \end{bmatrix} q^{\binom{j}{2}-jn} (\mathcal{H}_{m+j,q}(x)-\mathcal{H}_{j,q}(x))=(-1)^{n} q^{\binom{n+1}{2}} \sum_{i=1}^{m} q^{i} \frac{(xq^{i-n};q)_{n}}{(xq^{i};q)_{n+1}}.
$$

where

$$
\mathcal{H}_{n,q}(x) = \sum_{i=1}^{n} \frac{q^i}{1 - xq^i}
$$

Proof. By the first identity of Theorem [\(2.18\)](#page-5-1), it is easy to check

$$
\sum_{j=0}^n (-1)^j \begin{bmatrix} n \\ j \end{bmatrix} \begin{bmatrix} n+j \\ j \end{bmatrix} q^{\binom{j}{2} - jn} (\mathcal{H}_{m+j,q}(x) - \mathcal{H}_{j,q}(x)) = \sum_{i=1}^m q^i \frac{(xq^i)^n (q/xq^i;q)_n}{(xq^i;q)_{n+1}}.
$$

By means of

$$
(q/xq^{i};q)_{n} = (-1)^{n} q^{n-in} x^{-n} q^{\binom{n}{2}} (xq^{i-n};q)_{n}
$$

we deduce the result.  $\Box$
