Charged Gauss-Bonnet black holes supporting non-minimally coupled scalar clouds: Analytic treatment in the near-critical regime

Recent numerical studies have revealed the physically intriguing fact that charged black holes whose charge-to-mass ratios are larger than the critical value $(Q/M)_{\text{crit}} = \sqrt{2(9 + \sqrt{6})}/5$ can support hairy matter configurations which are made of scalar fields with a non-minimal negative coupling to the Gauss-Bonnet invariant of the curved spacetime. Using analytical techniques, we explore the physical and mathematical properties of the composed charged-black-hole-nonminimallycoupled-linearized-massless-scalar-field configurations in the near-critical $Q/M \gtrsim (Q/M)_{\text{crit}}$ regime. In particular, we derive an analytical resonance formula that describes the charge-dependence of the dimensionless coupling parameter $\bar{\eta}_{\rm crit} = \bar{\eta}_{\rm crit}(Q/M)$ of the composed Einstein-Maxwellnonminimally-coupled-scalar-field system along the *existence-line* of the theory, a critical border that separates bald Reissner-Nordström black holes from hairy charged-black-hole-scalar-field configurations. In addition, it is explicitly shown that the large-coupling $-\bar{\eta}_{\rm crit}(Q/M) \gg 1$ analytical results derived in the present paper for the composed Einstein-Maxwell-scalar theory agree remarkably well with direct numerical computations of the corresponding black-hole-field resonance spectrum.

I. INTRODUCTION

Early no-hair theorems [\[1](#page-6-0)[–6\]](#page-6-1), which were mainly motivated by Wheeler's no-hair conjecture for black holes [\[7](#page-6-2), [8\]](#page-6-3), have revealed the physically interesting fact that black holes with spatially regular horizons cannot support static matter configurations which are made of scalar fields.

However, recent studies [\[9](#page-6-4)[–12](#page-6-5)] (see also [\[13](#page-6-6)[–16\]](#page-6-7)) have explicitly demonstrated that the no-hair conjecture can be violated in generalized Einstein-scalar field theories whose actions are characterized by a direct non-trivial coupling $f(\phi)\mathcal{G}$ between the scalar field ϕ and the Gauss-Bonnet invariant \mathcal{G} of the curved spacetime. In particular, it has been revealed in the physically important works [\[9](#page-6-4)[–12](#page-6-5)] that spatially regular matter configurations which are made of non-minimally coupled scalar fields can be supported in asymptotically flat black-hole spacetimes [\[17](#page-6-8)[–24\]](#page-7-0).

The physically intriguing phenomenon of spontaneous scalarization of black holes in generalized Einstein-Gauss-Bonnet-scalar field theories [\[9](#page-6-4)[–16](#page-6-7)] owe its existence to the presence of an effective spatially-dependent mass term of the linearized form $-\bar{\eta}\mathcal{G}$, which reflects the direct non-trivial coupling between the scalar field and the Gauss-Bonnet curvature invariant, in the Klein-Gordon wave equation of the supported scalar configurations [see Eq. [\(10\)](#page-2-0) below]. The dimensionless physical parameter $\bar{\eta}$ of the composed field theory controls the strength of the direct non-minimal interaction between the scalar field and the spatially-dependent Gauss-Bonnet invariant of the curved spacetime.

The spontaneous scalarization phenomenon of charged black holes in composed Einstein-Maxwell-Gauss-Bonnetscalar-field theories has been explored, using numerical techniques, in the physically interesting works [\[25](#page-7-1), [26\]](#page-7-2) (see [\[13,](#page-6-6) [14](#page-6-9), [27–](#page-7-3)[32\]](#page-7-4) for recent studies of the spontaneous scalarization phenomenon of asymptotically flat spinning black holes). Intriguingly, it has been revealed in [\[25](#page-7-1), [26](#page-7-2)] that the composed charged-black-hole-nonminimally-coupledscalar-field system is characterized by a charge-dependent existence-line $\bar{\eta} = \bar{\eta}(Q)$ [\[33](#page-7-5)] which marks the onset of the spontaneous scalarization phenomenon in the generalized Einstein-Maxwell-scalar field theory. In particular, for a given value of the black-hole electric charge \bar{Q} , the critical existence line marks the boundary between bald Reissner-Nordström black holes and composed charged-black-hole-nonminimally-coupled-scalar-field hairy configurations.

The charge-dependent critical existence-line $\bar{\eta} = \bar{\eta}(Q)$ of the generalized Einstein-Maxwell-scalar theory is composed of charged Reissner-Nordström black holes that support scalar 'clouds' [\[34,](#page-7-6) [35](#page-7-7)], spatially regular matter configurations which are made of the non-trivially coupled linearized scalar fields. The characteristic existence-line of the physical system is universal in the sense that different non-trivially coupled Einstein-Maxwell-scalar field theories that share the same weak-field functional behavior $f(\phi) = 1 + \bar{\eta}\phi^2/2 + O(\phi^4)$ [\[25](#page-7-1), [26](#page-7-2)] of the coupling function are characterized by the same critical boundary between bald and hairy black-hole spacetimes.

Interestingly, the numerical results presented in [\[25,](#page-7-1) [26](#page-7-2)] have revealed that the spontaneous scalarization phenomenon of black holes in composed Einstein-Maxwell-scalar field theories with *negative* values of the non-minimal coupling parameter $\bar{\eta}$ may be induced by the electric charge of the supporting black hole. In particular, one finds that, in the $\bar{\eta}$ < 0 regime, the onset of the spontaneous scalarization phenomenon is marked by the dimensionless black-hole electric charge [\[25,](#page-7-1) [26\]](#page-7-2)

$$
\bar{Q}_{\rm crit} = \frac{\sqrt{2(9+\sqrt{6})}}{5} \ . \tag{1}
$$

Only charged black holes with $\overline{Q} \geq \overline{Q}_c$ can support non-minimally coupled spatially regular scalar clouds in the negative coupling $\bar{\eta}$ < 0 regime. Intriguingly, it has been demonstrated numerically in [\[25,](#page-7-1) [26\]](#page-7-2) that, in the nearcritical regime $\bar{Q}/\bar{Q}_{\text{crit}} \to 1^+$, the hairy charged black holes are characterized by the large-coupling asymptotic relation

$$
-\bar{\eta} \to \infty \quad \text{for} \quad \bar{Q}/\bar{Q}_{\text{crit}} \to 1^+ \ . \tag{2}
$$

The main goal of the present paper is to study, using *analytical* techniques, the physical and mathematical properties of the composed charged-Reissner-Nordström-black-hole-nonminimally-coupled-scalar-field cloudy configurations in the near-critical regime $\overline{Q} \gtrsim \overline{Q}_{\text{crit}}$. In particular, a remarkably compact WKB resonance formula, which describes the charge dependence $\overline{P} = \overline{P}(\overline{Q})$ of the charged victime direction of the composed Fin the charge-dependence $\bar{\eta} = \bar{\eta}(\bar{Q})$ of the characteristic critical existence-line of the composed Einstein-Maxwell-Gauss-Bonnet-nonminimally-coupled-massless-scalar-field theory in the dimensionless large-coupling $-\bar{\eta} \gg 1$ regime, will be derived.

Interestingly, we shall explicitly show below that the analytically derived near-critical resonance formula of the present paper [see Eq. [\(40\)](#page-6-10) below] provides a simple analytical explanation for the numerically observed [\[25](#page-7-1), [26](#page-7-2)] monotonically decreasing functional behavior $|\bar{\eta}| = |\bar{\eta}(\bar{Q})|$ of the critical existence-line that characterizes, in the $\bar{\eta} < 0$ regime, the composed charged-Reissner-Nordström-black-hole-nonminimally-coupled-linearized-scalar-field configurations.

II. DESCRIPTION OF THE SYSTEM

We explore the physical and mathematical properties of spatially regular scalar 'clouds' (linearized scalar field configurations) which are supported by charged Reissner-Nordström black holes. The supported massless scalar fields are characterized by a direct non-trivial (non-minimal) coupling to the Gauss-Bonnet invariant of the curved charged spacetime. The action of the composed Einstein-Maxwell-Gauss-Bonnet-nonminimally-coupled-massless-scalar-field system is given by the expression [\[26,](#page-7-2) [36\]](#page-7-8)

$$
S = \int d^4x \sqrt{-g} \Big[\frac{1}{4} R - \frac{1}{4} F_{\alpha\beta} F^{\alpha\beta} - \frac{1}{2} \nabla_\alpha \phi \nabla^\alpha \phi + f(\phi) \mathcal{G} \Big] , \qquad (3)
$$

where

$$
\mathcal{G} \equiv R_{\mu\nu\rho\sigma} R^{\mu\nu\rho\sigma} - 4R_{\mu\nu} R^{\mu\nu} + R^2 \tag{4}
$$

is the Gauss-Bonnet curvature invariant.

Following [\[11](#page-6-11), [12,](#page-6-5) [18](#page-6-12)], we assume that the scalar function $f(\phi)$, which controls the non-trivial direct coupling of the scalar field to the Gauss-Bonnet curvature invariant, is characterized by the leading order universal functional behavior

$$
f(\phi) = \frac{1}{2}\eta\phi^2\tag{5}
$$

in the weak-field regime. As discussed in [\[11,](#page-6-11) [12,](#page-6-5) [18](#page-6-12)], the functional behavior [\(5\)](#page-1-0) of the scalar coupling function in the weak scalar field regime guarantees that the Einstein-matter field equations are satisfied by the familiar scalarless black-hole solutions of general relativity (in our case, the Reissner-Nordström black-hole spacetime) in the $\phi \to 0$ limit. The physical parameter η [\[37](#page-7-9)], which may take either positive or negative values [\[25,](#page-7-1) [26](#page-7-2)], determines the strength of the direct (non-minimal) interaction between the spatially regular massless scalar field configurations and the Gauss-Bonnet invariant [\(4\)](#page-1-1) of the charged curved spacetime.

The supporting charged Reissner-Nordström black-hole spacetime is characterized by the line element [\[38](#page-7-10)[–40](#page-7-11)]

$$
ds^{2} = -\frac{\Delta}{r^{2}}dt^{2} + \frac{r^{2}}{\Delta}dr^{2} + r^{2}d\theta^{2} + r^{2}\sin^{2}\theta d\phi^{2} , \qquad (6)
$$

where the metric function Δ is given by the functional expression

$$
\Delta \equiv r^2 - 2Mr + Q^2 \tag{7}
$$

The physical parameters $\{M, Q\}$ are respectively the mass and electric charge of the central supporting Reissner-Nordström black hole. The horizon radii of the curved black-hole spacetime [\(6\)](#page-1-2) are determined by the zeros of the metric function ∆:

r_{\pm} = M \pm (M^2 - Q^2)^{1/2} . \tag{8}
$$

The radially-dependent Gauss-Bonnet invariant, which characterizes the curved Reissner-Nordström black-hole spacetime [\(6\)](#page-1-2), is given by the expression [\[26](#page-7-2)]

$$
\mathcal{G}_{\rm RN}(r; M, Q) = \frac{8}{r^8} \left(6M^2 r^2 - 12MQ^2 r + 5Q^4 \right) \,. \tag{9}
$$

A variation of the action [\(3\)](#page-1-3) with respect to the scalar field yields the generalized Klein-Gordon equation [\[26\]](#page-7-2)

$$
\nabla^{\nu}\nabla_{\nu}\phi = \mu_{\text{eff}}^2\phi\tag{10}
$$

for the non-minimally coupled scalar field with the radially-dependent effective mass term

$$
\mu_{\text{eff}}^2(r;M,Q) = -\eta \mathcal{G} \tag{11}
$$

This effective mass term reflects the direct (non-minimal) coupling of the scalar field ϕ to the Gauss-Bonnet invariant G [see Eq. [\(9\)](#page-2-1)] of the charged curved spacetime.

Interestingly, one finds that, in the regime [\[26,](#page-7-2) [41\]](#page-7-12)

$$
Q \ge Q_{\rm crit} = M \cdot \frac{\sqrt{2(9+\sqrt{6})}}{5} \,,\tag{12}
$$

the charged-dependent Gauss-Bonnet curvature invariant becomes negative in the exterior region

$$
r_{+} \le r \le \left(1 + \frac{1}{\sqrt{6}}\right) \cdot \frac{Q^2}{M} \tag{13}
$$

of the charged black-hole spacetime. Thus, the spatially-dependent effective mass term [\(11\)](#page-2-2) with $\eta < 0$ may become negative in the interval [\(13\)](#page-2-3). As we shall explicitly prove below, this intriguing property of the coupled Einstein-Maxwell-nonminimally-coupled-scalar-field system (3) allows the central charged Reissner-Nordström black hole (6) to support bound-state linearized cloudy configurations of the non-minimally coupled scalar field.

Using the functional field decomposition [\[42\]](#page-7-13)

$$
\phi(r,\theta,\varphi) = \sum_{lm} R_{lm}(r) Y_{lm}(\theta,\varphi) , \qquad (14)
$$

one obtains from Eq. [\(10\)](#page-2-0) the differential equation [\[26](#page-7-2), [43,](#page-7-14) [44\]](#page-7-15)

$$
\frac{d}{dr}\left(\Delta \frac{dR}{dr}\right) - l(l+1)R + \eta \left(\frac{48M^2}{r^4} - \frac{96MQ^2}{r^5} + \frac{40Q^4}{r^6}\right)R = 0\tag{15}
$$

for the radial part of the linearized non-minimally coupled scalar field in the supporting curved black-hole spacetime [\(6\)](#page-1-2).

The ordinary differential equation [\(15\)](#page-2-4) determines the spatial behavior of the static non-minimally coupled linearized massless scalar field configurations in the supporting charged Reissner-Nordström black-hole spacetime (6) . Following [\[25,](#page-7-1) [26\]](#page-7-2), we shall assume that the scalar eigenfunction $\psi(r)$ of the bound-state field configurations is spatially well behaved with the physically motivated boundary conditions [\[25,](#page-7-1) [26\]](#page-7-2)

$$
\psi(r = r_{\rm H}) < \infty \quad ; \quad \psi(r \to \infty) \to 0 \tag{16}
$$

at the black-hole horizon and at spatial infinity.

In the next section we shall study, using analytical techniques, the physical and mathematical properties of the negatively coupled charged-black-hole-nonminimally-coupled-linearized-massless-scalar-field configurations that characterize the composed Einstein-Maxwell-scalar field theory [\(3\)](#page-1-3). In particular, we shall explicitly prove that the composed Reissner-Nordström-black-hole-scalar-field cloudy configurations in the $Q > Q_{\text{crit}}$ regime [see Eq. [\(12\)](#page-2-5)] with $\eta < 0$ owe their existence to the presence of an effective near-horizon binding potential well [see Eq. [\(31\)](#page-4-0) below].

III. COMPOSED REISSNER-NORDSTROM-BLACK-HOLE-NONMINIMALLY-COUPLED-SCALAR-FIELD ¨ CONFIGURATIONS: A WKB ANALYSIS

In the present section we shall determine the charge-dependent functional behavior $\eta = \eta(Q/M)$ of the critical existence-line, which characterizes the composed charged-black-hole-nonminimally-coupled-scalar-field cloudy configurations, in the dimensionless large-coupling regime

$$
-\bar{\eta} \equiv -\frac{\eta}{M^2} \gg 1 \tag{17}
$$

Defining the new radial eigenfunction

$$
\psi \equiv rR\tag{18}
$$

and using the coordinate $y(r)$, which is defined by the radial differential relation [\[45\]](#page-7-16)

$$
dy = \frac{r^2}{\Delta} \cdot dr \tag{19}
$$

one obtains from equation (15) the Schrödinger-like radial equation

$$
\frac{d^2\psi}{dy^2} - V\psi = 0 \tag{20}
$$

where the radially-dependent potential $V[r(y)]$ of the composed charged-Reissner-Nordström-black-holenonminimally-coupled-scalar-field system is given by the functional expression

$$
V(r; M, Q, l, \bar{\eta}) = h(r) \left[\frac{l(l+1)}{r^2} + \frac{2M}{r^3} - \frac{2Q^2}{r^4} \right] + V_{GB}(r)
$$
\n(21)

with [see Eq. (7)]

$$
h(r) \equiv \frac{\Delta}{r^2} = 1 - \frac{2M}{r} + \frac{Q^2}{r^2} \,. \tag{22}
$$

The presence of the non-trivial term

$$
V_{GB}(r;M,Q) = -\bar{\eta} \cdot \frac{h(r)}{r^2} \left(\frac{48M^4}{r^4} - \frac{96M^3Q^2}{r^5} + \frac{40M^2Q^4}{r^6}\right)
$$
(23)

in the effective interaction potential [\(21\)](#page-3-0) is a direct consequence of the non-trivial (non-minimal) coupling between the Gauss-Bonnet curvature invariant [\(9\)](#page-2-1) of the charged spacetime [\(6\)](#page-1-2) and the supported scalar field.

We shall now prove that, in the dimensionless large-coupling regime [\(17\)](#page-3-1), the ordinary differential equation [\(20\)](#page-3-2), which characterizes the composed Einstein-Maxwell-scalar field theory (3) , is amenable to an analytical treatment. In particular, a standard second-order WKB analysis of the Schrödinger-like ordinary differential equation [\(20\)](#page-3-2) yields the familiar quantization condition [\[46](#page-7-17)[–48\]](#page-7-18)

$$
\int_{y_{t-}}^{y_{t+}} dy \sqrt{-V(y; M, Q, \bar{\eta})} = (n + \frac{1}{2}) \cdot \pi \quad ; \quad n = 0, 1, 2, ... \tag{24}
$$

for the discrete spectrum $\{\bar{\eta}(M, Q; n)\}_{n=0}^{n=\infty}$ of the dimensionless coupling parameter which characterizes the composed charged-Reissner-Nordström-black-hole-nonminimally-coupled-scalar-field cloudy configurations. Here $n \in \{0, 1, 2, ...\}$ is the discrete resonant parameter of the physical system. The critical existence-line of the field theory is determined by the fundamental $n = 0$ mode. The integration limits $\{y_{t-}, y_{t+}\}\$ in the WKB integral relation [\(24\)](#page-3-3) are the classical turning points of the effective binding potential [\(21\)](#page-3-0). Using Eq. [\(19\)](#page-3-4), one finds that the WKB relation [\(24\)](#page-3-3) can be expressed in the integral form

Q \equiv Q_{\rm crit} \cdot (1 + \epsilon) \quad ; \quad \epsilon \ge 0 \tag{26}
$$

and

$$
r \equiv r_+ \cdot (1+x) \quad ; \quad x \ge 0 \;, \tag{27}
$$

one obtains the near-critical ($\epsilon \ll 1$) near-horizon ($x \ll 1$) relations [see Eqs. [\(8\)](#page-2-6), [\(12\)](#page-2-5), and [\(22\)](#page-3-5)]

\frac{r_+}{M} = \frac{4 + \sqrt{6}}{5} \cdot \left(1 - \sqrt{6} \cdot \epsilon\right) + O(\epsilon^2) \tag{28}
$$

$$
\frac{r}{M} = \frac{r_{+} \cdot (1+x)}{M} = \frac{4+\sqrt{6}}{5} \cdot (1+x-\sqrt{6} \cdot \epsilon) + O(x^{2}, \epsilon^{2}, x\epsilon) ,
$$
\n(29)

and

$$
h(r) = (\sqrt{6} - 2) \cdot x + O(x^2, \epsilon^2, x\epsilon) \tag{30}
$$

Substituting the relations [\(28\)](#page-4-1), [\(29\)](#page-4-2), and [\(30\)](#page-4-3) into Eqs. [\(21\)](#page-3-0) and [\(23\)](#page-3-6), one finds the (rather cumbersome) nearcritical near-horizon expression

$$
M^{2}\frac{V(r)}{h(r)} = \left\{ \frac{11 - 4\sqrt{6}}{2} \cdot l(l+1) + \frac{19\sqrt{6} - 46}{2} - \bar{\eta} \left[\left(15204\sqrt{6} - 37236 \right) \cdot x - \left(16752 - 6828\sqrt{6} \right) \cdot \epsilon \right] \right\} \cdot \left[1 + O(x, \epsilon) \right] (31)
$$

for the effective interaction potential of the composed black-hole-massless-scalar-field cloudy configurations.

We shall henceforth consider composed charged-Reissner-Nordström-black-hole-massless-scalar-field cloudy configurations in the dimensionless large-coupling regime [see Eqs. [\(17\)](#page-3-1), [\(26\)](#page-4-4), and Eq. [\(38\)](#page-4-5) below]

$$
-\bar{\eta}\epsilon \gg 1\ ,\tag{32}
$$

in which case one finds from Eqs. [\(30\)](#page-4-3) and [\(31\)](#page-4-0) the remarkably compact leading order functional expression

$$
M^2 \frac{V(r)}{[h(r)]^2} = \bar{\eta} \cdot 6(1396 - 569\sqrt{6}) \cdot \left[(2 + \sqrt{6}) \cdot \frac{\epsilon}{x} - 1 \right]
$$
 (33)

for the effective binding potential of the composed charged-black-hole-scalar-field system.

Taking cognizance of Eqs. [\(25\)](#page-3-7), [\(27\)](#page-4-6), and [\(33\)](#page-4-7), one finds the resonance condition

$$
\frac{r_+}{M} \cdot \int_0^{(2+\sqrt{6})\cdot \epsilon} dx \sqrt{-\bar{\eta} \cdot 6(1396 - 569\sqrt{6}) \cdot \left[(2+\sqrt{6}) \cdot \frac{\epsilon}{x} - 1 \right]} = (n + \frac{1}{2}) \cdot \pi \quad ; \quad n = 0, 1, 2, \dots \tag{34}
$$

for the composed black-hole-field system. The WKB integral relation [\(34\)](#page-4-8) can be expressed in the compact mathematical form

\epsilon \sqrt{-\bar{\eta}} \cdot 2\sqrt{6} \sqrt{16 + \sqrt{6}} \int_0^1 dz \sqrt{\frac{1}{z} - 1} = (n + \frac{1}{2}) \cdot \pi \quad ; \quad n = 0, 1, 2, \dots, \tag{35}
$$

where

$$
z \equiv \frac{1}{2 + \sqrt{6}} \cdot \frac{x}{\epsilon} \tag{36}
$$

Using the integral relation

$$
\int_0^1 dz \sqrt{\frac{1}{z} - 1} = \frac{\pi}{2} \tag{37}
$$

one finds from [\(35\)](#page-4-9) the remarkably simple discrete resonance formula [\[49](#page-7-19)]

$$
\bar{\eta}(\epsilon; n) = -\frac{1}{\epsilon^2} \cdot \frac{1}{96 + 6\sqrt{6}} \cdot (n + \frac{1}{2})^2 \quad ; \quad n = 0, 1, 2, \dots, \tag{38}
$$

which characterizes the composed charged-Reissner-Nordström-black-hole-nonminimally-coupled-linearized-masslessscalar-field cloudy configurations in the dimensionless large-coupling $-\bar{\eta} \gg 1$ regime (or equivalently, in the nearcritical $\epsilon \ll 1$ regime).

The discrete resonance spectrum [\(38\)](#page-4-5) of the composed Einstein-Maxwell-Gauss-Bonnet-nonminimally-coupledscalar-field system [\(3\)](#page-1-3) can be expressed in the dimensionless form [see Eqs. [\(1\)](#page-1-5) and [\(26\)](#page-4-4)]

$$
\bar{Q}(\bar{\eta};n) = \frac{\sqrt{2(9+\sqrt{6})}}{5} + \frac{1}{\sqrt{-\bar{\eta}}} \cdot \frac{1}{\sqrt{138 - 7\sqrt{6}}} \cdot (n + \frac{1}{2}) \quad ; \quad n = 0, 1, 2, \dots, \tag{39}
$$

where $\overline{Q} \equiv Q/M$.

IV. NUMERICAL CONFIRMATION

In the present section we shall test the accuracy of the analytically derived large-coupling resonance spectrum [\(38\)](#page-4-5), which characterizes the composed charged-Reissner-Nordström-black-hole-nonminimally-coupled-linearized-scalarfield cloudy configurations. The charge-dependent resonance spectrum of the black-hole-field system has recently been computed numerically in [\[26\]](#page-7-2).

In Table [I](#page-5-0) we present, for various values of the dimensionless coupling parameter $\lambda = 2\sqrt{|\eta|}$ [\[44](#page-7-15)] used in [\[26\]](#page-7-2), the charge-dependent ratio $\mathcal{R}(\lambda) \equiv \epsilon^{analytical}/\epsilon^{numerical}$ between the analytically calculated value of the dimensionless critical parameter ϵ [as calculated directly from the analytically derived large-coupling resonance formula [\(38\)](#page-4-5)] and the corresponding exact (numerically computed [\[26](#page-7-2)]) values of the critical parameter. The data presented in Table [I](#page-5-0) for the cloudy Reissner-Nordström-black-hole-scalar-field configurations reveals the fact that the agreement between the *analytically* derived resonance formula [\(38\)](#page-4-5) and the corresponding *numerically* computed resonance spectrum of [\[26\]](#page-7-2) is remarkably good in the large-coupling $\lambda \gg 1$ regime [\[50\]](#page-7-20) of the Einstein-Maxwell-scalar field theory [\(3\)](#page-1-3).

TABLE I: Composed charged-Reissner-Nordström-black-hole-nonminimally-coupled-linearized-massless-scalar-field cloudy configurations. We present, for various values of the coupling parameter $\lambda \equiv 2\sqrt{|\bar{\eta}|}$ [\[26,](#page-7-2) [44](#page-7-15)] of the theory, the dimensionless ratio $\mathcal{R}(\lambda) \equiv \epsilon^{analytical}/\epsilon^{numerical}$ between the analytically calculated value of the dimensionless critical parameter ϵ [as calculated directly from the resonance formula [\(38\)](#page-4-5) for the fundamental $n = 0$ mode] and the corresponding exact values of the critical parameter as computed numerically in [\[26\]](#page-7-2). One finds that, in the large-coupling $\lambda \gg 1$ regime of the composed Reissner-Nordström-black-hole-scalar-field cloudy configurations, the agreement between the analytically derived resonance formula [\(38\)](#page-4-5) and the corresponding numerically computed resonance spectrum of [\[26\]](#page-7-2) is remarkably good [\[50](#page-7-20)].

V. SUMMARY AND DISCUSSION

Asymptotically flat black holes with spatially regular horizons can support bound-state matter configurations which are made of scalar fields with a direct (non-minimal) coupling to the Gauss-Bonnet invariant of the curved spacetime $[9-16]$ $[9-16]$.

The spontaneous scalarization phenomenon of charged black holes in composed Einstein-Maxwell-Gauss-Bonnetscalar field theories has recently been studied numerically in the physically important works [\[25,](#page-7-1) [26\]](#page-7-2). In particular, it has been revealed in [\[25,](#page-7-1) [26\]](#page-7-2) that a charge-dependent critical existence-line $\bar{\eta}_{\rm crit} = \bar{\eta}_{\rm crit}(Q/M)$ separates bald Reissner-Nordström black-hole spacetimes from the composed charged-black-hole-nonminimally-coupled-massless-scalar-field hairy configurations of the Einstein-Maxwell-scalar theory [\(3\)](#page-1-3) [\[51](#page-7-21)], where the dimensionless physical parameter $\bar{\eta}$ quantifies the strength of the direct non-trivial interaction between the supported scalar field and the Gauss-Bonnet curvature invariant.

Interestingly, it has been demonstrated [\[25](#page-7-1), [26\]](#page-7-2) that, in the negative coupling $\bar{\eta}$ < 0 regime, the composed chargedblack-hole-linearized-scalar-field cloudy configurations that sit on the critical existence-line of the Einstein-Maxwell-scalar field theory [\(3\)](#page-1-3) are restricted to the dimensionless charge regime $\bar{Q} > \bar{Q}_{\rm crit} = \sqrt{2(9 + \sqrt{6})}/5$ [see Eq. [\(1\)](#page-1-5)]. In particular, the numerical results presented in [\[25](#page-7-1), [26\]](#page-7-2) provide important evidence for an intriguing divergent functional behavior $-\bar{\eta}(Q) \to \infty$ of the non-minimal coupling parameter of the theory along the existence-line of the system in the near-critical limit $\bar{Q}/\bar{Q}_{\text{crit}} \to 1^+$.

In the present paper we have used *analytical* techniques in order to explore the physical and mathematical properties of the composed charged-Reissner-Nordström-black-hole-nonminimally-coupled-massless-scalar-field hairy configura-tions of the Einstein-Maxwell-scalar theory [\(3\)](#page-1-3) in the large-coupling $-\bar{\eta}(\bar{Q}) \gg 1$ regime. In particular, using a WKB procedure we have derived the analytical formula [\(38\)](#page-4-5) for the discrete resonant spectrum of the dimensionless coupling parameter $\bar{\eta}(Q)$ which characterizes the composed charged-black-hole-scalar-field cloudy configurations in the near-critical $Q \gtrsim Q_{\text{crit}}$ regime.

The analytically derived discrete WKB resonance formula [\(38\)](#page-4-5) yields the remarkably compact charge-dependent functional relation [\[52\]](#page-7-22)

$$
\bar{\eta}(\epsilon) = -\frac{1}{\epsilon^2} \cdot \frac{1}{4(96 + 6\sqrt{6})} \tag{40}
$$

for the critical existence-line of the composed Einstein-Maxwell-Gauss-Bonnet-nonminimally-coupled-massless-scalar field theory [\(3\)](#page-1-3), where $0 \leq \epsilon = (\bar{Q} - \bar{Q}_{\text{crit}})/\bar{Q}_{\text{crit}} \ll 1$ [see Eqs. [\(1\)](#page-1-5) and [\(26\)](#page-4-4)] is the dimensionless distance of the system from the exact critical ($-\bar{\eta} \to \infty$) configuration.

It is worth stressing the fact that the physical significance of the critical existence-line [\(40\)](#page-6-10) in the Einstein-Maxwell-scalar field theory [\(3\)](#page-1-3) stems from the fact that it separates, in the large-coupling $-\bar{\eta} \gg 1$ regime, bald Reissner-Nordström black holes from hairy charged-black-hole-nonminimally-coupled-massless-scalar-field configurations. From the analytically derived resonance formula [\(40\)](#page-6-10) one finds, in accord with the physically interesting numerical results presented in [\[25](#page-7-1), [26\]](#page-7-2), that the dimensionless coupling parameter $|\bar{\eta}(\bar{Q})|$ of the theory [\(3\)](#page-1-3) is a monotonically decreasing function of the black-hole electric charge \overline{Q} in the negative coupling $\overline{\eta}$ < 0 regime.

Finally, it is interesting to point out that our results provide a simple *analytical* explanation for the physically intriguing numerical observation originally made in [\[25,](#page-7-1) [26\]](#page-7-2), according to which the charge-dependent coupling parameter $\bar{\eta}(\bar{Q})$ of the Einstein-Maxwell-scalar field theory [\(3\)](#page-1-3) diverges along the critical existence line of the system in the $\bar{Q} \rightarrow \bar{Q}_{\text{crit}}$ limit. In particular, the analytically derived resonance formula [\(40\)](#page-6-10) reveals the fact that the coupling parameter $\bar{\eta}(Q)$, which characterizes the cloudy black-hole-field configurations, diverges quadratically in the near-critical $\epsilon \to 0$ limit.
