Abstract

We define and study a notion of G-dimension for DG-modules over a non-positively graded commutative noetherian DG-ring A. Some criteria for the finiteness of the G-dimension of a DG-module are given by applying a DG-version of projective resolution introduced by Minamoto [Israel J. Math. 245 (2021) 409-454]. Moreover, it is proved that the finiteness of G-dimension characterizes the local Gorenstein property of A. Applications go in three directions. The first is to establish the connection between G-dimensions and the little finitistic dimensions of A. The second is to characterize Cohen-Macaulay and Gorenstein DG-rings by the relations between the class of maximal local-Cohen-Macaulay DG-modules and a special G-class of DG-modules. The third is to extend the classical Buchwtweiz-Happel Theorem and its inverse from commutative noetherian local rings to the setting of commutative noetherian local DG-rings.

Keywords: G-dimension; Gorenstein DG-algebra; maximal local-Cohen-Macaulay DG-module; little finitistic dimension; Buchwtweiz-Happel Theory.

1. INTRODUCTION

The Gorenstein dimension, or G-dimension, for finitely generated modules over a commutative noetherian ring was introduced by Auslander [1] and was developed deeply by Auslander and Bridger [2]. The reason for the name is that G-dimension characterizes Gorenstein local rings exactly as projective dimension characterizes regular local rings. With that as a start, G-dimension has played an important role in singularity theory [10, 34], cohomology theory of commutative rings [5, 11] and representation theory of Artin algebras [3, 26]. Over a general ring, Enochs and Jenda [13] defined Gorenstein projective dimension for arbitrary modules. For finitely generated modules over commutative noetherian rings it coincides with the Auslander

and Bridger's G-dimension. For left modules over arbitrary associative rings, Holm [18] proved that the new concept has the desired properties.

In a different direction, Yassemi [31] studied G-dimension for complexes over a commutative noetherian local ring through a consistent use of the RHom-functor of complexes and the related category of reflexive complexes, while Christensen [11] went straight for the throat and gave the definition in terms of resolutions. Thus, the two definitions are equivalent, and they are both rooted in a result — due to Foxby — saying that a finitely generated module has finite G-dimension if and only if it is reflexive as a complex in the sense defined in [31, Definition 2.4] (see also [11, Definition 2.1.6]).

The aim of this paper is to introduce and study G-dimensions in derived commutative algebra. More specifically, we work with non-positively graded commutative DG-rings $A = \bigoplus_{n=-\infty}^{0} A^{i}$ with a differential of degree +1. These include the normalizations of simplicial commutative rings, so this setup includes the affine theory of derived algebraic geometry.

Given a commutative DG-ring A, the derived category of DG-modules over A will be denoted by D(A). Its full subcategory consisting of DG-modules with bounded cohomology will be denoted by D^b(A). We denote by D^b_f(A) the full triangulated subcategory of D^b(A) consisting of DG-modules with finitely generated cohomology. For a DG-module M, we set $\inf M = \inf \{n \mid$ $\operatorname{H}^{n}(M) \neq 0\}$, $\sup M = \sup \{n \mid \operatorname{H}^{n}(M) \neq 0\}$, and $\operatorname{amp} M = \sup M - \inf M$.

Motivated by the G-dimension for complexes over a commutative noetherian ring defined in [11, 31], we introduce the definition of G-dimension for DG-modules.

Definition 1.1. Let A be a noetherian DG-ring with $ampA < \infty$.

- (1) A DG-module $X \in D^{b}_{f}(A)$ is said to be reflexive if $\operatorname{RHom}_{A}(X, A) \in D^{b}_{f}(A)$ and the canonical homomorphism $X \to \operatorname{RHom}_{A}(\operatorname{RHom}_{A}(X, A), A)$ is isomorphic in $D^{b}_{f}(A)$.
- (2) For a reflexive DG-module X, we define the G-dimension of A, denoted by $G-\dim_A X$, by the formula

$$\operatorname{G-dim}_A X = \operatorname{supRHom}_A(X, A).$$

If X is not reflexive, we say that it has infinite G-dimension and write $G-\dim_A X = \infty$.

(3) The number $\sup\{G\operatorname{-dim}_A X + \inf X | X \in D^b_f(A)\}$ is called the global G-dimension of A and is denoted by G-gldimA.

Let A be an ordinary ring. If X is an A-module, then one can show that this definition coincides with the usual definition of the G-dimension of X defined by Auslander in [1]; moreover, if X is an A-complex, then the G-dimension of X defined here is just the definition defined by Yassemi in [31, Definition 2.8] or by Christensen in [11, Definition 2.3.3 and Theorem 2.3.7].

We denote by $\mathcal{R}(A)$ for the full subcategory of D(A) consisting of reflexive DG-modules. A DG-module $X \in \mathcal{R}(A)$ is said to be in the *G*-class \mathcal{G} if either $\operatorname{G-dim}_A X = -\sup X$, or X = 0, and denote by \mathcal{G}_0 the full subcategory of \mathcal{G} consisting of objects G such that either $\operatorname{G-dim}_A G = -\sup G = 0$, or G = 0 (see Definition 3.5). If we write $\mathcal{P} \subseteq D(A)$ for the full subcategory of direct summands of a finite direct sums of A, i.e. $\mathcal{P} = \operatorname{add} A$, then it is easy to check $\mathcal{P} \subseteq \mathcal{G}_0$. If A is an ordinary ring and X an A-module, then $\mathcal{G} = \mathcal{G}_0$ is exactly the class of modules of G-dimension zero.

Following [23], for any $0 \not\simeq X \in D^+(A)$, a *sppj morphism* $f: P \to X$ is a morphism in D(A)such that $P \in AddA[-\sup X]$ and the morphism $H^{\sup X}(f)$ is surjective, where AddA is the full subcategory of direct summands of a direct sum of A. Moreover, a *sppj resolution* P_{\bullet} of X is a sequence of exact triangles $X_{i+1} \xrightarrow{g_{i+1}} P_i \xrightarrow{f_i} X_i \to \text{such that } f_i$ is a sppj morphism for $i \ge 0$ with $X_0 := X$. If A is noetherian and $X \in D_f^b(A)$ then we can choose P_i in \mathcal{P} by [23, Proposition 2.26].

We set $\operatorname{injdim}_A A := \inf\{n \in \mathbb{Z} | \operatorname{Ext}_A^i(N, A) = 0 \text{ for any } N \in D^{\mathrm{b}}(A) \text{ and } i > n - \inf N\}$. Following [14, 15], recall that a commutative noetherian local DG-ring $(A, \overline{\mathfrak{m}}, \overline{k})$ is called *Gorenstein* if $\operatorname{amp} A < \infty$.

Recall that for full subcategories $\mathcal{X}, \mathcal{Y} \subseteq D(A)$, we define $\mathcal{X} * \mathcal{Y}$ to be the full subcategory consisting $Z \in D(A)$ which fits into an exact triangle $X \to Z \to Y \rightsquigarrow$ with $X \in \mathcal{X}$ and $Y \in \mathcal{Y}$.

Now, our main result can be stated as follows.

Theorem 1.2. Let $(A, \overline{\mathfrak{m}}, \overline{k})$ be a commutative noetherian local DG-ring with $\operatorname{amp} A < \infty$.

- (1) If $0 \not\simeq X \in D^{b}_{f}(A)$ with $\operatorname{amp} X \ge \operatorname{amp} A$ and n is a natural number, then the following are equivalent:
 - (i) $\operatorname{G-dim}_A X \leq n \sup X$;
 - (ii) For any sppj resolution P_{\bullet} of X with each $P_i \in \mathcal{P}$, one has $X_n \in \mathcal{G}_0[-\sup X]$;
 - (iii) X belongs to $\mathcal{P}[-\sup X] * \cdots * \mathcal{P}[-\sup X + n 1] * \mathcal{G}_0[-\sup X + n];$
 - (iv) X belongs to $\mathcal{G}_0[-\sup X] * \mathcal{P}[-\sup X+1] * \cdots * \mathcal{P}[-\sup X+n].$
- (2) If $0 \not\simeq X \in D^{b}_{f}(A)$ with $\operatorname{amp} X < \operatorname{amp} A$ and n is a natural number, then the following are equivalent:
 - (i) $\operatorname{G-dim}_A X \le n + \inf A \inf X;$
 - (*ii*) $X \oplus X[\operatorname{amp} A \operatorname{amp} X]$ belongs to $\mathcal{P}[-\sup X] * \cdots * \mathcal{P}[-\sup X + n 1] * \mathcal{G}_0[-\sup X + n].$
- (3) The following conditions are equivalent:
 - (i) A is local Gorenstein;
 - (*ii*) G-dim_A $k < \infty$;
 - (iii) G-gldim $A < \infty$.

Theorem 1.2 provides criteria for a natural number to be an upper bound of the G-dimension of a DG-module and the global G-dimension of a commutative noetherian local DG-ring. Moreover, it should be pointed out the inequality ampX < ampA in Theorem 1.2(2) is very often met. For instance, let $(A, \bar{\mathfrak{m}}, \bar{k})$ be a commutative noetherian local DG-ring with $0 < \text{amp}A < \infty$, then $\text{amp}\bar{k} = 0$. In addition, if A is local Gorenstein, then \bar{k} has finite G-dimension by Theorem 1.2(3), but Lemma 3.3 yields that \bar{k} never has finite projective dimension introduced by Bird, Shaul, Sridhar and Williamson in [9]. In combination with Proposition 4.1, we conclude that G-dimension is a finer invariant than projective dimension for DG-modules.

Let A be an Artin algebra. The *little finitistic dimension* of A, fpdA, is the supremum of projective dimensions of finitely generated A-modules of finite projective dimension. It is conjectured that $fpdA < \infty$ holds for Artin algebras A; see Bass [6] and [4, Conjectures]. This is the Finitistic Dimension Conjecture. Recently, this invariant has been generalized by Bird, Shaul, Sridhar and Williamson in [9] to the setting of non-positive commutative noetherian DG-rings with bounded cohomology. More precisely, they considered the number

 $\operatorname{fpd} A = \sup \{\operatorname{projdim}_A X + \inf X | X \in D^{\mathrm{b}}_{\mathrm{f}}(A) \text{ with } \operatorname{projdim}_A X < \infty \}.$

It should be noted that the little finitistic dimensions of an algebra can alternatively be computed by G-dimension; see for instance [29, Lemma 4.4]. As the first application of Theorem 1.2, we have the following corollary which shows that the little finitistic dimension fpd(A) over a DG-ring A can be computed by G-dimension defined in Definition 1.1 above.

Corollary 1.3. If A is a commutative noetherian local DG-ring with $ampA < \infty$, then we have

 $\operatorname{fpd} A = \sup \{ \operatorname{G-dim}_A X + \inf X | X \in \operatorname{D}_{\mathrm{f}}^{\mathrm{b}}(A) \text{ with } \operatorname{amp} X \ge \operatorname{amp} A, \ \operatorname{G-dim}_A X < \infty \}.$

As a direct consequence of Theorem 1.2(3) and Corollary 1.3, it follows that a local Gorenstein DG-ring A has finite little finitistic dimension.

Let A be a commutative noetherian local ring (not a DG-ring). A close relation between the class of maximal Cohen-Macaulay modules and the class of modules of G-dimension zero over A can be shown in the following fact; see for instance [12, 3.3].

Fact 1.4. Let A be a commutative noetherian local ring. Denote by \mathcal{M} the class of maximal Cohen-Macaulay modules over A. Then the following hold:

- (1) A is Cohen-Macaulay if and only if $\mathcal{G} \subseteq \mathcal{M}$.
- (2) A is Gorenstein if and only if $\mathcal{G} = \mathcal{M}$.

Recently, the theory of Cohen-Macaulay rings and Cohen-Macaulay modules has been extended by Shaul [28] to the setting of commutative noetherian DG-rings. There are many examples of local Cohen-Macaulay DG-rings, in particular local Gorenstein DG-rings are Cohen-Macaulay. As the second application of Theorem 1.2, we can generalize the above fact to the setting of commutative noetherian local DG-rings.

Corollary 1.5. Let $(A, \bar{\mathfrak{m}})$ be a commutative noetherian local DG-ring with $\operatorname{amp} A < \infty$. Denote by \mathcal{M} the class of maximal local-Cohen-Macaulay DG-modules over A. Set

 $\mathcal{H} = \{ X \in \mathcal{G} | \operatorname{ampR}\Gamma_{\bar{\mathfrak{m}}} X \ge \operatorname{amp} X = \operatorname{amp} A \}.$

Then the following hold:

- (1) A is local-Cohen-Macaulay if and only if $\mathcal{H} \subseteq \mathcal{M}$.
- (2) A is Gorentein if and only $\mathcal{H} = \mathcal{M}$.

In the study of stable homological algebra and Tate cohomology for two sided noetherian rings A, Buchweitz [10] introduced the Verdier quotient $D_{sg}(A) := D^{b}(A)/K^{b}(A)$, where $K^{b}(A)$ is the bounded homotopy category of finitely generated projective left A-modules. Later on, this category was reconsidered by Orlov [25]. Since it measures the homological singularity of the category of finitely generated left A-modules in sense that $D_{sg}(A) = 0$ if and only if the global dimension of A is finite, we call it the *singularity category*. Buchweitz-Happel Theorem ([10, Theorem 4.4.1], see also [17, Theorem 4.6]) says that there is a fully faithful triangle functor $F : \underline{\mathcal{G}} \to D_{sg}(A)$ provided that A is a commutative local Gorenstein ring. Also, it was shown in [7] that the inverse of this theorem holds true (see also [8, 22]). Recently, Buchweitz-Happel Theorem has been generalized by Jin to a proper noncommutative Gorenstein DG-algebra over a field k (see [20, Theorem 0.3 and Assumption 0.1]).

As the third application of Theorem 1.2, we extend the classical Buchwtweiz-Happel Theorem and its inverse from commutative noetherian local rings to the setting of commutative noetherian local DG-rings. For notation and notions, we refer the reader to Section 4.3.

Corollary 1.6. Assume that A is a commutative noetherian local DG-ring with $\operatorname{amp} A < \infty$. Let $\mathcal{A} = \{X \in \mathcal{R}(A) | \sup X \leq 0 \text{ and } G\operatorname{-dim}_A X \leq 0\}$, and let $D_{sg}(A) := D_f^b(A)/\langle \mathcal{P} \rangle$ be the singularity category over A. Then the functor

$$F: \underline{\mathcal{A}} \to \mathcal{D}_{sg}(\mathcal{A})$$

is a triangle equivalence if and only if A is a local Gorenstein DG-ring.

Remark that if A is a commutative noetherian local DG-algebra over a field k, a Gorenstein ring in our setting is a proper Gorenstein DG-algebra defined by Jin in [20, Assumption 0.1]. Therefore, over a commutative local noetherian non-positive DG algebra over a field k, Corollary 1.6 conveys that the inverse of Buchwtweiz-Happel Theorem obtained by Jin [20, Theorem 0.3] is also true.

The article is organized as follows. In Section 2, we introduce notation, definitions and basic facts needed for proofs. Section 3 is devoted to give the proof of Theorem 1.2. In Section 4, we apply Theorem 1.2 to establish the connection between G-dimensions and the little finitistic dimensions of A, to obtain a DG version of Fact 1.4, and to show a DG-version of Buchwtweiz-Happel Theorem and its inverse over A, and therefore prove the three corollaries.

2. Preliminaries

An associative DG-ring A is a \mathbb{Z} -graded ring $A = \bigoplus_{i \in \mathbb{Z}} A^i$ equipped with a \mathbb{Z} -linear map $d: A \to A$ of degree +1 such that $d \circ d = 0$, and such that

(2.1)
$$d(a \cdot b) = d(a) \cdot b + (-1)^{\imath} a \cdot d(b)$$

for all $a \in A^i$ and $b \in A^j$. A DG-ring A is called *commutative* if for all $a \in A^i$ and $b \in A^j$, one has $b \cdot a = (-1)^{i \cdot j} a \cdot b$, and $a^2 = 0$ if i is odd. A DG-ring A is called *non-positive* if $A^i = 0$ for all i > 0. A non-positive DG-ring A is called *noetherian* if the ring $H^0(A)$ is noetherian and the $H^0(A)$ -modules $H^i(A)$ are finitely generated for all i < 0. All DG-rings in this paper will be assumed to be commutative and non-positive.

A DG-module M over A is a graded A-module together with a differential of degree +1 satisfying the Leibniz rule similar to (2.1). The DG-A-modules form an abelian category, and by inverting the quasi-isomorphisms we obtain the derived category D(A) which is triangulated. We refer the reader to [33] for more details about DG-rings and their derived categories.

If A is a noetherian DG-ring, we say that $M \in D(A)$ has finitely generated cohomology if for all $n \in \mathbb{Z}$, the H⁰(A)-modules Hⁿ(M) are finitely generated. We denote by D_f(A) the full triangulated subcategory of D(A) consisting of DG-modules with finitely generated cohomology. We also set D⁻_f(A) = D_f(A) \cap D⁻(A). Similarly we will consider D⁺_f(A) and D^b_f(A). All these are full triangulated subcategories of D(A). If A is a noetherian DG-ring, and if the noetherian ring $\mathrm{H}^{0}(A)$ is local with maximal ideal $\bar{\mathfrak{m}}$ and residue field \bar{k} , we will say that $(A, \bar{\mathfrak{m}})$ (or $(A, \bar{\mathfrak{m}}, \bar{k})$) is a noetherian local DG-ring.

We recall the definition of the projective and injective dimensions of DG-modules introduced by Bird, Shaul, Sridhar and Williamson.

Definition 2.1. ([9, Definition 1.3]) Let A be a DG-ring and $M \in D(A)$.

(1) The projective dimension of M is defined by

 $\operatorname{projdim}_{A} M = \inf\{n \in \mathbb{Z} | \operatorname{Ext}_{A}^{i}(M, N) = 0 \text{ for any } N \in \operatorname{D^{b}}(A) \text{ and any } i > n + \sup N\}.$

(2) The injective dimension of M is defined by

 $\operatorname{injdim}_A M = \inf\{n \in \mathbb{Z} | \operatorname{Ext}^i_A(N, M) = 0 \text{ for any } N \in D^{\mathrm{b}}(A) \text{ and any } i > n - \inf N\}.$

Let A be a DG-ring, and let $\bar{\mathfrak{a}} \subseteq \mathrm{H}^{0}(A)$ be a finitely generated ideal. The category of derived $\bar{\mathfrak{a}}$ -torsion DG-modules over A, denoted by $\mathrm{D}_{\bar{\mathfrak{a}}-\mathrm{tor}}(A)$, is the full triangulated subcategory of $\mathrm{D}(A)$ consisting of DG-modules M such that the $\mathrm{H}^{0}(A)$ -modules $\mathrm{H}^{n}(M)$ are $\bar{\mathfrak{a}}$ -torsion for all $n \in \mathbb{Z}$. One can show that the inclusion functor $F : \mathrm{D}_{\bar{\mathfrak{a}}-\mathrm{tor}}(A) \to \mathrm{D}(A)$ has a right adjoint $G : \mathrm{D}(A) \to \mathrm{D}_{\bar{\mathfrak{a}}-\mathrm{tor}}(A)$, and composing this right adjoint with the inclusion, one obtains a triangulated functor

$$\mathrm{R}\Gamma_{\bar{\mathfrak{a}}}: \mathrm{D}(A) \to \mathrm{D}(A)$$

which we call the *derived torsion* or *local cohomology functor* of A with respect to \bar{a} . The functor $R\Gamma_{\bar{a}}$ has a right adjoint which is denoted by

$$\mathrm{L}\Lambda_{\bar{\mathfrak{a}}}:\mathrm{D}(A)\to\mathrm{D}(A),$$

This functor is called the *local homology* or *derived completion functor* with respect to \bar{a} . We recall the following definitions introduced by Shaul [28].

Definition 2.2. Let $(A, \overline{\mathfrak{m}})$ be a noetherian local DG-ring.

(1) We define the local cohomology Krull dimension of $M \in D^{-}(A)$ to be

$$\operatorname{lc.dim}_A M := \sup_{l \in \mathbb{Z}} \{ \operatorname{dim}(\operatorname{H}^l(M)) + l \}.$$

(2) We define the depth of $N \in D^+(A)$ to be the number

$$\operatorname{depth}_A N := \inf \operatorname{RHom}_A(\bar{k}, N).$$

Definition 2.3. Let $(A, \overline{\mathfrak{m}})$ be a noetherian local DG-ring with $\operatorname{amp} A < \infty$.

- (1) A is called local Cohen-Macaulay if $\operatorname{amp} R\Gamma_{\overline{\mathfrak{m}}}(A) = \operatorname{amp} A$.
- (2) We say that $M \in D^{b}_{f}(A)$ is a local-Cohen-Macaulay DG-module if there are equalities

$$\operatorname{amp} M = \operatorname{amp} A = \operatorname{amp} \operatorname{R} \Gamma_{\bar{\mathfrak{m}}}(M).$$

(3) A local-Cohen-Macaulay DG-module M is maximal local-Cohen-Macaulay if

 $\operatorname{lc.dim}_A M = \sup M + \operatorname{dim} \mathrm{H}^0(A).$

We denote by \mathcal{M} the full subcategory of maximal local-Cohen-Macaulay DG-modules.

From now until the end of the paper, we always assume that $(A, \overline{\mathfrak{m}}, \overline{k})$ is a commutative noetherian local DG-ring with $\operatorname{amp} A < \infty$.

3. Proof of Theorem 1.2

This section is devoted to a proof of the statements of Theorem 1.2. We start with the following proposition.

Proposition 3.1. Let $X' \to X \to X'' \to X'[1]$ be an exact triangle in $D^{b}_{f}(A)$. If two of the DG-modules belong to $\mathcal{R}(A)$, then so is the third.

Proof. If two of $\operatorname{RHom}_A(X', A)$, $\operatorname{RHom}_A(X, A)$ and $\operatorname{RHom}_A(X'', A)$ are in $\operatorname{D}_{\mathrm{f}}^{\mathrm{b}}(A)$, then so is the third. Using the abbreviated notation $((-, A), A) := \operatorname{RHom}_A(\operatorname{RHom}_A(-, A), A)$, we have the following commutative diagram in $\operatorname{D}_{\mathrm{f}}^{\mathrm{b}}(A)$:

$$\begin{array}{c|c} X' & \longrightarrow & X & \longrightarrow & X'' & \longrightarrow & X'[1] \\ \delta^{X'} & & \delta^{X} & & \delta^{X''} & & \delta^{X'}[1] \\ ((X', A), A) & \longrightarrow & ((X, A), A) & \longrightarrow & ((X'', A), A) & \longrightarrow & ((X', A), A)[1]. \end{array}$$

Therefore, if two of the morphisms $\delta^{X'}, \delta^X$ and $\delta^{X''}$ are isomorphisms, then so is the third. The rest follows by the fact that $D_f^b(A)$ is the full triangulated subcategory of D(A).

Following [14], a dualizing DG-module R over A is a DG-module $R \in D_{\rm f}^+(A)$ such that $\operatorname{injdim}_A R < \infty$ and the natural map $A \to \operatorname{RHom}_A(R, R)$ is an isomorphism in D(A). It follows by [14, Theorem 3.2] that $R \in D_{\rm f}^{\rm b}(A)$. If A is local then dualizing DG-module over A is unique up to shift. We say that R is normalized if $\inf R = -\dim \operatorname{H}^0(A)$.

Lemma 3.2. Let R be a normalized dualizing DG-module over A. For $X \in D^{b}_{f}(A)$, one has $\inf RHom_{A}(X, R) = -lc.dim_{A}X$, $depth_{A}RHom_{A}(X, R) = -supX$, $supRHom_{A}(X, R) = -depth_{A}X$, $lc.dim_{A}RHom_{A}(X, R) = -infX$.

Proof. By [27, Theorem 7.26] and [28, Theorem 2.15], one has

 $\inf \operatorname{RHom}_A(X, R) = -\sup \operatorname{R}\Gamma_{\tilde{\mathfrak{m}}}(X) = -\operatorname{lc.dim}_A X.$

Applying to [27, Theorem 7.26] and [28, Proposition 3.3], we obtain

 $\operatorname{supRHom}_A(X, R) = -\operatorname{inf} R\Gamma_{\overline{\mathfrak{m}}}(X) = -\operatorname{depth}_A X.$

Since $X \simeq \operatorname{RHom}_A(\operatorname{RHom}_A(X, R), R)$, it follows that $\operatorname{lc.dim}_A\operatorname{RHom}_A(X, R) = -\operatorname{inf} X$ and $\operatorname{depth}_A\operatorname{RHom}_A(X, R) = -\operatorname{sup} X$.

Lemma 3.3. Let $0 \not\simeq X \in D^{b}_{f}(A)$ with $\operatorname{projdim}_{A} X < \infty$. Then $\operatorname{amp} X \ge \operatorname{amp} A$.

Proof. Let $B = L\Lambda_{\bar{\mathfrak{m}}}(A)$. Then $X \otimes_A^L B \in D_{\mathrm{f}}^{\mathrm{b}}(B)$ with $\operatorname{projdim}_B(X \otimes_A^L B) < \infty$ by [9, Proposition 3.7] and $\operatorname{amp} X = \operatorname{amp}(X \otimes_A^L B)$, $\operatorname{amp} B = \operatorname{amp} A$. Thus we may assume that A is derived $\bar{\mathfrak{m}}$ -adic complete, and A has a normalized dualizing DG-module R by [27, Proposition 7.21]. As $\operatorname{RHom}_A(X, R) \simeq \operatorname{RHom}_A(X, A) \otimes_A^L R$ by [9, Proposition 1.16], one has

$$\begin{split} \mathrm{lc.dim}_{A}\mathrm{R}\mathrm{Hom}_{A}(X,R) &= \mathrm{lc.dim}_{A}(\mathrm{R}\mathrm{Hom}_{A}(X,A) \otimes_{A}^{\mathrm{L}} R) \\ &= \sup\{\mathrm{dim}\mathrm{H}^{0}(A)/\bar{\mathfrak{p}} + \mathrm{sup}\mathrm{R}\mathrm{Hom}_{A}(X,A)_{\bar{\mathfrak{p}}} + \mathrm{sup}R_{\bar{\mathfrak{p}}}|\bar{\mathfrak{p}} \in \mathrm{SpecH}^{0}(A)\} \\ &= \mathrm{lc.dim}_{A}R + \mathrm{sup}\mathrm{R}\mathrm{Hom}_{A}(X,A) \\ &= \mathrm{lc.dim}_{A}R + \mathrm{projdim}_{A}X, \end{split}$$

where the last equality is by [30, Proposition 4.4(3)]. Hence we have the next (in)equalities

$$ampX = \text{lc.dim}_A \text{RHom}_A(X, R) - \text{depth}_A \text{RHom}_A(X, R)$$
$$= \text{lc.dim}_A R + \text{projdim}_A X + \text{sup}X - \text{depth}_A R$$
$$\geq \text{ampR}\Gamma_{\tilde{\mathfrak{m}}}(R)$$
$$= \text{amp}A,$$

where the first equality is by Lemma 3.2, the second one is by [30, Proposition 4.9] and Nakayama's lemma and the last one is by [27, Theorem 7.26]. The inequality is by the fact that $\operatorname{projdim}_A X \geq -\sup X$.

Corollary 3.4. If $X \in \mathcal{R}(A)$ with $\operatorname{amp} X \ge \operatorname{amp} A$, then $\operatorname{G-dim}_A X \ge -\operatorname{sup} X$.

Proof. Let $B = L\Lambda_{\bar{\mathfrak{m}}}(A)$. Then $X \otimes_A^L B \in \mathcal{R}(B)$ with $\operatorname{amp}(X \otimes_A^L B) \ge \operatorname{amp}B$ and $\operatorname{G-dim}_B(X \otimes_A^L B) = \operatorname{G-dim}_A X$, $\operatorname{sup}(X \otimes_A^L B) = \operatorname{sup} X$. We may assume that A is derived $\bar{\mathfrak{m}}$ -adic complete, and A has a normalized dualizing DG-module R. Hence by Lemma 3.2 and [27, Theorem 7.26], one has the next (in)equalities

$$\begin{split} \operatorname{amp} X &= \operatorname{lc.dim}_{A} \operatorname{RHom}_{A}(X, R) - \operatorname{depth}_{A} \operatorname{RHom}_{A}(X, R) \\ &= \operatorname{lc.dim}_{A} R + \operatorname{sup} \operatorname{RHom}_{A}(X, A) + \operatorname{sup} X - \operatorname{depth}_{A} R \\ &= \operatorname{amp} \operatorname{RF}_{\bar{\mathfrak{m}}}(R) + \operatorname{sup} \operatorname{RHom}_{A}(X, A) + \operatorname{sup} X \\ &= \operatorname{amp} A + \operatorname{sup} \operatorname{RHom}_{A}(X, A) + \operatorname{sup} X \\ &\geq \operatorname{amp} A, \end{split}$$

which implies that $\operatorname{G-dim}_A X = \operatorname{supRHom}_A(X, A) \ge -\operatorname{sup} X$.

Definition 3.5. A DG-module $X \in \mathcal{R}(A)$ is said to be in the G-class \mathcal{G} if either $\operatorname{G-dim}_A X = -\sup X$, or X = 0, and we denote by \mathcal{G}_0 the full subcategory of \mathcal{G} consisting of objects G such that either $\operatorname{G-dim}_A G = -\sup G = 0$, or G = 0.

Remark 3.6. (1) Let $X \to Y \to Z \rightsquigarrow$ be an exact triangle in $\mathcal{R}(A)$. The exact triangle $\operatorname{RHom}_A(Z, A) \to \operatorname{RHom}_A(Y, A) \to \operatorname{RHom}_A(X, A) \rightsquigarrow$ yields that

 $\operatorname{G-dim}_A Y \leq \max{\operatorname{G-dim}_A X, \operatorname{G-dim}_A Z}.$

(2) For $0 \not\simeq X \in \mathcal{R}(A)$ with $\operatorname{amp} X \ge \operatorname{amp} A$, it follows from Corollary 3.4 that $\operatorname{G-dim}_A X = -\sup X$ if and only if $X \in \mathcal{G}$ if and only if $X \in \mathcal{G}_0[-\sup X]$.

(3) For any $i \in \mathbb{Z}$, one has $\mathcal{P}[i] \subseteq \mathcal{G}_0[i]$ by [23, Lemma 2.14].

(4) For any $X \in \mathcal{R}(A)$ and $n \in \mathbb{Z}$, one has $\operatorname{G-dim}_A X[n] = \operatorname{G-dim}_A X + n$.

We give several useful properties about sppj morphisms.

Lemma 3.7. Let $0 \neq X \in \mathcal{R}(A)$ with $\operatorname{amp} X \ge \operatorname{amp} A$ and $f : P \to X$ a sppj morphism with $Y = \operatorname{cn}(f)[-1]$. If $\operatorname{G-dim}_A X + \operatorname{sup} X \ge 1$, then $\operatorname{G-dim}_A Y = \operatorname{G-dim}_A X - 1$.

Proof. By Proposition 3.1, $Y \in \mathcal{R}(A)$. Set $n = \text{G-dim}_A X + \sup X$ and $g : Y \to P$ be the canonical morphism. We may assume that $\sup X = 0$ by shifting the degree. Then $n \ge 1$.

Firstly, we need to prove $\mathrm{H}^{i}(\mathrm{RHom}_{A}(Y, A) = 0$ for all i > n - 1. By assumption, we have $\mathrm{H}^{i}(\mathrm{RHom}_{A}(X, A)) = 0$ for all i > n and $\mathrm{H}^{i}(\mathrm{RHom}_{A}(P, A)) = 0$ for all i > 0. Then the following exact sequence

$$\mathrm{H}^{i}(\mathrm{RHom}_{A}(P,A)) \to \mathrm{H}^{i}(\mathrm{RHom}_{A}(Y,A)) \to \mathrm{H}^{i+1}(\mathrm{RHom}_{A}(X,A)) \to \mathrm{H}^{i+1}(\mathrm{RHom}_{A}(P,A))$$

yields that $\operatorname{H}^{i}(\operatorname{RHom}_{A}(Y, A)) = 0$ for all i > n-1. Next, since $\operatorname{H}^{n}(\operatorname{RHom}_{A}(X, A)) \neq 0$, the exact sequence $\operatorname{H}^{n-1}(\operatorname{RHom}_{A}(Y, A)) \to \operatorname{H}^{n}(\operatorname{RHom}_{A}(X, A)) \to 0$ implies that $\operatorname{H}^{n-1}(\operatorname{RHom}_{A}(Y, A)) \neq 0$. Thus $\operatorname{G-dim}_{A}Y = n-1$.

Lemma 3.8. Let $0 \not\simeq X \in \mathcal{G}$ with $\operatorname{amp} X \ge \operatorname{amp} A$. Then there exists a sppj morphism $f : P \to X$ such that the cocone $Y = \operatorname{cn}(f)[-1]$ is in $\mathcal{G}_0[-\operatorname{sup} X]$.

Proof. Let $f: P \to X$ be a sppj morphism with $P \in \mathcal{P}[-\sup X]$. One has an exact triangle $Y \to P \to X \rightsquigarrow$. By [23, Lemma 2.14] and [30, Proposition 4.4(3)], we have $\operatorname{G-dim}_A P = -\sup X$. If $\operatorname{amp} Y \geq \operatorname{amp} A$, then $Y \in \mathcal{G}_0[-\sup X]$ since $\sup Y \leq \sup X$ by Remark 3.6(2). If $\operatorname{amp} Y < \operatorname{amp} A$, then $Y \oplus P \to P \oplus P \to X \rightsquigarrow$ is an exact triangle with $(f, 0): P \oplus P \to X$ a sppj morphism and $\operatorname{amp}(Y \oplus P) \geq \operatorname{amp} A$ by Lemma 3.3, as required. \Box

Lemma 3.9. Let $0 \not\simeq X \in \mathcal{G}$ with $\operatorname{amp} X \ge \operatorname{amp} A$. Then there exists a morphism $f : X \to P$ such that $Y = \operatorname{cn}(f) \in \mathcal{G}_0[-\operatorname{sup} X]$.

Proof. By Lemma 3.8, there exists a sppj morphism $g : P \to \operatorname{RHom}_A(X, A)$ such that $P \in \mathcal{P}[-\operatorname{supRHom}_A(X, A)]$ and $\operatorname{amp}(\operatorname{cn}(g)[-1]) \ge \operatorname{amp} A$, so we have a morphism

$$g^*: X \simeq \operatorname{RHom}_A(\operatorname{RHom}_A(X, A), A) \to \operatorname{RHom}_A(P, A)$$

and an exact triangle $X \to \operatorname{RHom}_A(P, A) \to Y \rightsquigarrow$. As $\operatorname{RHom}_A(P, A) \in \mathcal{P}[-\operatorname{sup} X]$, it follows from Corollary 3.4 that $Y \in \mathcal{R}(A)$ and $\operatorname{amp} Y \ge \operatorname{amp} A$. We need to show that $Y \in \mathcal{G}_0[-\operatorname{sup} X]$. Since $\operatorname{H}^{-\operatorname{sup} X}(g)$ is surjective, $\operatorname{G-dim}_A Y = \operatorname{sup} \operatorname{RHom}_A(Y, A) \le \operatorname{sup} \operatorname{RHom}_A(X, A) =$ $\operatorname{G-dim}_A X = -\operatorname{sup} X$. If $\operatorname{G-dim}_A Y + \operatorname{sup} Y \ge 1$, then $\operatorname{sup} X \le \operatorname{sup} Y - 1$, and so $\operatorname{H}^{\operatorname{sup} Y}(Y) = 0$, this is a contradiction. Therefore, $Y \in \mathcal{G}_0[-\operatorname{sup} X]$. \Box

With the above preparations, now we prove Theorem 1.2.

Proof of Theorem 1.2. (1) Let X be a DG-module in $D_{f}^{b}(A)$ with $\operatorname{amp} X \ge \operatorname{amp} A$ and n a natural number. Then $(ii) \Longrightarrow (iii)$ is clear and $(iii) \Longrightarrow (i)$ holds by the definition.

To show $(i) \Longrightarrow (ii)$, we assume that P_{\bullet} is a sppj resolution of X and $X_{i+1} \stackrel{g_{i+1}}{\to} P_i \stackrel{f_i}{\to} X_i \rightsquigarrow$ are the corresponding exact triangles such that f_i is a sppj morphism and $\operatorname{amp} X_i \ge \operatorname{amp} A$ for $i \ge 0$ with $X_0 := X$. If $\operatorname{G-dim}_A X_{i-1} + \sup X_{i-1} > 0$ for all $i \ge 1$, then $\operatorname{G-dim}_A X_{j-1} + \sup X_{j-1} > 0$ and $\operatorname{G-dim}_A X_j = \operatorname{G-dim}_A X_{j-1} - 1$ for $j \le i$ by Lemma 3.7, which implies

$\operatorname{G-dim}_A X_i + i = \operatorname{G-dim}_A X.$

Since $\sup X_i \leq \sup X$, it follows that the set $\{i \geq 1 | \operatorname{G-dim}_A X_{i-1} + \sup X_{i-1} > 0\}$ is finite. Set $e := \max\{i \geq 1 | \operatorname{G-dim}_A X_{i-1} + \sup X_{i-1} > 0\}$. Then $e \leq n$ and $X_e \in \mathcal{G}_0[-\sup X]$, it follows from Lemma 3.8 that $X_n \in \mathcal{G}_0[-\sup X]$.

To verify the equivalence of (i) and (iv), it suffices to show

(3.1) G-dim_AX = min{
$$n | X \in \mathcal{G}_0[-\sup X] * \mathcal{P}[-\sup X+1] * \cdots * \mathcal{P}[-\sup X+n]$$
} - supX.

If $\operatorname{G-dim}_A X = -\sup X$, then the formula (3.1) holds by Lemma 3.9. We only need to prove the formula (3.1) provided that $\operatorname{G-dim}_A X > -\sup X$.

By Lemma 3.8, there is a sppj morphism $f : P \to \operatorname{RHom}_A(X, A)$ so that $\operatorname{amp}(\operatorname{cn}(f)[-1]) \ge \operatorname{amp} A$ and $P \in \mathcal{P}[-\operatorname{sup} \operatorname{RHom}_A(X, A)]$, so we have a morphism

$$f^*: X \simeq \operatorname{RHom}_A(\operatorname{RHom}_A(X, A), A) \to \operatorname{RHom}_A(P, A)$$

with $P^* := \operatorname{RHom}_A(P, A) \in \mathcal{P}[\operatorname{sup} \operatorname{RHom}_A(X, A)]$. Consider the exact triangle $Y \to X \to P^* \rightsquigarrow$, which induces the exact triangle

(3.2)
$$\operatorname{RHom}_A(Y, A)[-1] \to P \to \operatorname{RHom}_A(X, A) \to \operatorname{RHom}_A(Y, A)$$

and $Y \in \mathcal{R}(A)$ with $\operatorname{amp} Y \geq \operatorname{amp} A$ by Corollary 3.4. As $\operatorname{sup} P^* = -\operatorname{sup} \operatorname{RHom}_A(X, A) = \operatorname{sup} X - n < \operatorname{sup} X$, one has $\operatorname{sup} Y = \operatorname{sup} X$. Since $\operatorname{H^{sup} RHom}_A(X, A)(f)$ is surjective, it follows by the triangle (3.2) that

 $\operatorname{G-dim}_A Y = \operatorname{supRHom}_A(Y, A) \le \operatorname{supRHom}_A(X, A) - 1 = \operatorname{G-dim}_A X - 1 = n - 1 - \operatorname{sup} Y.$

Now by induction and Lemma 3.9, one can obtain the desired formula.

(2) Set $\overline{X} = X \oplus X[\operatorname{amp} A - \operatorname{amp} X]$. Then $\overline{X} \in D^{\mathrm{b}}_{\mathrm{f}}(A)$ with $\operatorname{amp} \overline{X} = \operatorname{amp} A$ and $\operatorname{sup} \overline{X} = \operatorname{sup} X$. As $\operatorname{G-dim}_A X + (\operatorname{amp} A - \operatorname{amp} X) = \operatorname{G-dim}_A \overline{X}$, the statement follows from (1).

(3) Evidently, (iii) is stronger than (ii), so it is sufficient to prove that (i) implies (iii) and (ii) implies (i).

 $(i) \Rightarrow (iii)$ As A is local Gorenstein, $\operatorname{injdim}_A A < \infty$ and $\operatorname{supRHom}_A(X, A) \leq \operatorname{injdim}_A A - \operatorname{inf} X$, it follows that $\operatorname{RHom}_A(X, A) \in \operatorname{D}_{\mathrm{f}}^{\mathrm{b}}(A)$ and $X \in \mathcal{R}(A)$ for any $X \in \operatorname{D}_{\mathrm{f}}^{\mathrm{b}}(A)$. Consequently, for any $X \in \operatorname{D}_{\mathrm{f}}^{\mathrm{b}}(A)$, we have $\operatorname{G-dim}_A X + \operatorname{inf} X \leq \operatorname{injdim}_A A$, as desired.

 $(ii) \Rightarrow (i)$ Assume that $\operatorname{G-dim}_A \overline{k} < \infty$. Then $\operatorname{supRHom}_A(\overline{k}, A) < \infty$. Hence [30, Proposition 4.2 and Theorem 4.7] implies that $\operatorname{injdim}_A A < \infty$ and A is local Gorenstein.

4. Applications

In this section, we will apply Theorem 1.2 to establish the connection between G-dimensions and the little finitistic dimensions of A, to examine the DG version of the Fact 1.4, and to establish a DG-version of Buchwtweiz-Happel Theorem and its inverse.

4.1. Relations between G-dimensions and the little finitistic dimensions. In this subsection we will apply Theorem 1.2 to show that the little finitistic dimension fpd(A) can be computed by G-dimension of DG-modules in $D_f^b(A)$.

Yekutieli [32] introduced a DG-version of projective dimension, pdM, for a DG-module M over a DG-algebra which are different from the definition $projdim_A M$ in Definition 2.1. By [23, Theorems 2.22 and 3.21], one has $projdim_A M = pdM - supM$.

Proposition 4.1. Let $0 \not\simeq X \in D^{b}_{f}(A)$. One has

 $\operatorname{G-dim}_A X \leq \operatorname{projdim}_A X,$

and equality holds if $\operatorname{projdim}_A X < \infty$.

Proof. The inequality is trivial if X is of infinite projective dimension. Next, assume that $n = \operatorname{projdim}_A X + \sup X < \infty$. It follows from [23, Proposition 2.26] that $X \in \mathcal{P}[-\sup X] * \mathcal{P}[-\sup X + 1] * \cdots * \mathcal{P}[-\sup X + n]$. Hence $\operatorname{G-dim}_A X \leq n - \sup X$ by Theorem 1.2(1) and

Lemma 3.3. This yields that $\operatorname{G-dim}_A X \leq \operatorname{projdim}_A X$. For the last part, we can choose a finitely generated $\operatorname{H}^0(A)$ -module T such that $\operatorname{projdim}_A X = \operatorname{supRHom}_A(X, T)$ by [23, Theorem 2.22]. The desired equality now follows from the next calculation,

$$\operatorname{projdim}_{A} X = \operatorname{supRHom}_{A}(X, T)$$
$$= \operatorname{sup}(\operatorname{RHom}_{A}(X, A) \otimes_{A}^{\operatorname{L}} T)$$
$$= \operatorname{supRHom}_{A}(X, A)$$
$$= \operatorname{G-dim}_{A} X.$$

where the second equality is by [9, Proposition 1.16], the third one is by Nakayama's lemma. \Box

The next lemma is an immediate consequence of Theorem 1.2(1).

Lemma 4.2. Let X be in $D_{f}^{b}(A)$ with $\operatorname{amp} X \ge \operatorname{amp} A$. If $\operatorname{G-dim}_{A} X = n$, then there exists an exact triangle

$$G \to X \to K \rightsquigarrow,$$


such that $G \in \mathcal{G}_0[-\sup X]$ and $\operatorname{projdim}_A K = n-1$. For $n = -\sup X$, we understand that K = 0.

The next result conveys that G-dimensions and the little finitistic dimensions are closely related to each other, which contains Corollary 1.3 in the introduction.

Theorem 4.3. Let X be an object in $D_{f}^{b}(A)$ with $\operatorname{amp} X \ge \operatorname{amp} A$. If $\operatorname{G-dim}_{A} X = n < \infty$, then there is a DG-module $Y \in D_{f}^{b}(A)$ with $\operatorname{projdim}_{A} Y = n$. In particular, one has

 $\operatorname{fpd} A = \sup \{ \operatorname{G-dim}_A X + \inf X | X \in D^{\mathrm{b}}_{\mathrm{f}}(A) \text{ with } \operatorname{amp} X \ge \operatorname{amp} A, \ \operatorname{G-dim}_A X < \infty \}.$

Proof. We may assume that $n > -\sup X$. By Lemma 4.2, there exists an exact triangle $G \to X \to K \to$ with $\operatorname{projdim}_A K = n - 1$ and $G \in \mathcal{G}_0[-\sup X]$, and there is an exact triangle $G \to P \to G' \to$ with $P \in \mathcal{P}[-\sup G]$ and $G' \in \mathcal{G}_0[-\sup G]$ by Lemma 3.9. Thus we get a commutative diagram of exact triangles:



The exact triangle $\operatorname{RHom}_A(G', A) \to \operatorname{RHom}_A(Y, A) \to \operatorname{RHom}_A(X, A) \rightsquigarrow \text{ yields that } \operatorname{G-dim}_A Y = n$. Note that $\sup X = \sup Y$, so $Y \notin \mathcal{G}_0[-\sup X]$. As $\sup K \leq \sup X - 1$, $P \to Y$ is a sppj morphism, it follows by the exact triangle $P \to Y \to K \rightsquigarrow$ and Proposition 4.1 that $\operatorname{projdim}_A Y = n$. Hence we have shown the first statement. This yields that $\operatorname{fpd}(A) \geq \sup\{\operatorname{G-dim}_A X + \inf X \mid X \in D^b_f(A) \text{ with } \operatorname{amp} X \geq \operatorname{amp} A$, $\operatorname{G-dim}_A X < \infty\}$. Also for any $Z \in D^b_f(A)$ with $\operatorname{projdim}_A Z < \infty$, one has $\operatorname{G-dim}_A Z \geq \operatorname{projdim}_A Z$. Thus the last statement follows. 4.2. Comparison to maximal local-Cohen-Macaulay DG-modules. The task of this subsection is to examine the DG version of Fact 1.4. We begin with the following AB formula for G-dimension of DG-modules.

Theorem 4.4. (AB Formula) Let X be a DG-module of finite G-dimension. One has an equality G-dim_AX = depth_A - depth_AX.

Proof. Since $G\text{-dim}_A X < \infty$, we have the following equalities

$$depth_A X = depthRHom_A(RHom_A(X, A), A)$$
$$= -supRHom_A(X, A) + depthA$$
$$= -G-dim_A X + depthA,$$

where the second equality is by [30, Proposition 4.9] and Nakayama's lemma, as required. \Box

Following [28], if $X \in D^{\mathrm{b}}_{\mathrm{f}}(A)$ then we set

$$\operatorname{seq.depth}_A X = \operatorname{depth}_A X - \operatorname{inf} X,$$

and call it the sequential depth of X.

Corollary 4.5. Let X be a DG-module of finite G-dimension with $\operatorname{amp} X = \operatorname{amp} A$. One has $\operatorname{G-dim}_A X + \sup X = \operatorname{seq.depth}_A A - \operatorname{seq.depth}_A X$.

Proof. One has the following equalities

$$\begin{aligned} \operatorname{G-dim}_A X + \sup X &= \operatorname{depth}_A - \operatorname{depth}_A X + \sup X \\ &= \operatorname{depth}_A - \operatorname{inf}_A - (\operatorname{depth}_A X - \operatorname{inf}_X) \\ &= \operatorname{seq.depth}_A - \operatorname{seq.depth}_A X, \end{aligned}$$

where the first one is by Theorem 4.4 and the second one is by ampX = ampA.

We are now ready to prove Corollary 1.5.

Proof of Corollary 1.5. (1) The "only if" part holds by noting that $A \in \mathcal{H}$ by [28, Theorem 4.1]. For the "if" part, we assume that X is an object in \mathcal{H} . It follows that lc. dim_A $A \geq$ lc.dim_A $X - \sup X \geq$ depth_A $X - \inf X$. Since A is local Cohen-Macaulay, we have the following (in)equalities

$$seq.depth_A X \le lc.dim_A X - sup X$$
$$\le lc.dim A$$
$$= seq.depth A$$
$$= seq.depth_A X,$$

where the second equality follows from Corollary 4.5, which implies that $\operatorname{ampR}_{\overline{\mathfrak{m}}}X = \operatorname{amp}A = \operatorname{amp}X$ and $\operatorname{lc.dim}_A X = \operatorname{dim} \operatorname{H}^0(A) + \operatorname{sup}X$. Thus $X \in \mathcal{M}$.

(2) For the "only if" part, since A is local Gorentein, it follows from [27, Theorem 7.26] that $X \simeq \operatorname{RHom}_A(\operatorname{RHom}_A(X, A), A)$ and $\operatorname{ampR}_{\overline{\mathfrak{m}}} X = \operatorname{ampRHom}_A(X, A)$ for any $X \in D^{\mathrm{b}}_{\mathrm{f}}(A)$. Let $X \in \mathcal{M}$. Then $\operatorname{ampRHom}_A(X, A) = \operatorname{amp} A$, it follows by Corollary 4.5 that

 $G-\dim_A X + \sup X = \text{seq.depth}A - \text{seq.depth}_A X = 0.$

Thus $X \in \mathcal{H}$ and $\mathcal{H} = \mathcal{M}$ by (1).

For the "if" part, we assume that $\mathcal{H} = \mathcal{M}$. Then A is local-Cohen-Macaulay by (1). Consider the sppj resolution P^{\bullet} of $k := \bar{k} \oplus \bar{k}[-\inf A]$

$$k_d \to P_{d-1} \to \cdots \to P_1 \to P_0 \to k$$

By the construction of the sppj resolution, we have $\sup k_d \leq 0$ and $\inf k_d \geq \inf A + \sup k_d$. We also have $\operatorname{lc.dim}_A k_d \leq d + \sup k_d$ and

$$\begin{aligned} \operatorname{epth}_A k_d &\geq \min\{\operatorname{depth}_A P_{d-1}[-\operatorname{sup} k_{d-1}], \operatorname{depth}_A k_{d-1} + 1\} \\ &\geq \min\{\operatorname{depth}_A P_{d-1}[-\operatorname{sup} k_{d-1}], \cdots, \operatorname{depth}_A P_0 + d - 1, d + \inf A\} \\ &\geq d + \inf A + \operatorname{sup} k_d. \end{aligned}$$

Set $G = A[-\sup k_d] \oplus k_d$. Then $\operatorname{lc.dim}_A G = d + \sup k_d$ and $\operatorname{depth}_A G = d + \inf A + \sup k_d$, that is to say, $G \in \mathcal{M} = \mathcal{H}$ and k han an sppj resolution

 $G \to A[-\sup k_d] \oplus P_{d-1} \to \cdots \to P_1 \to P_0 \to k.$

Thus, $\operatorname{G-dim}_A k < \infty$ by Theorem 1.2(1) and hence A is Gorenstein.

4.3. Buchwtweiz-Happel Theory and its inverse. In this subsection we will employ Theorem 1.2 to prove Corollary 1.6 in the introduction.

Let \mathcal{T} be a triangulated category and $\mathcal{D} \subseteq \mathcal{C}$ be subcategories in \mathcal{T} . As usual, we denote by $\langle \mathcal{D} \rangle$ the smallest thick triangulated subcategory containing \mathcal{D} , and denote by $\mathcal{C}/\langle \mathcal{D} \rangle$ the Verdier's quotient triangulated category. In fact, $\langle \mathcal{P} \rangle$ is the thick subcategory of the derived category $D^{b}(A)$ generated by A. We call the Verdier quotient $D_{sg}(A) := D_{f}^{b}(A)/\langle \mathcal{P} \rangle$ the singularity category of A. Each morphism $f : X \to Y$ in $D_{sg}(A)$ is given by an equivalence class of left fractions $s \setminus f$ as presented by $s \setminus f : X \xrightarrow{f} Z \xleftarrow{s} Y$, where the doubled arrow means s lies in the compatible saturated multiplicative system corresponding to $\langle \mathcal{P} \rangle$.

In the following, we set

$$A[<0]^{\perp_f} = \{ X \in \mathcal{R}(A) | \operatorname{Hom}_{\mathcal{D}(A)}(A[<0], X) = 0 \};$$

 ${}^{\perp_f} A[>0] = \{ X \in \mathcal{R}(A) | \operatorname{Hom}_{\mathcal{D}(A)}(X, A[>0]) = 0 \}.$

Recall from Corollary 1.5 that

$$\mathcal{H} = \{ X \in \mathcal{G} | \operatorname{ampR}\Gamma_{\bar{\mathfrak{m}}} X \ge \operatorname{amp} X = \operatorname{amp} A \}.$$

Lemma 4.6. Let $X \in \mathcal{R}(A)$. Assume that

$$\operatorname{amp} \operatorname{R} \Gamma_{\overline{\mathfrak{m}}} X \ge \operatorname{amp} X \ge \operatorname{amp} A.$$

Then $X \in \mathcal{H}$ if and only if $\sup X[\sup X] \leq 0$ and $\operatorname{G-dim}_A X[\sup X] \leq 0$, if and only if $X[\sup X] \in {}^{\perp_f} A[>0] \cap A[<0]^{\perp_f}$.

Proof. We will start by proving the first equivalence. Let $X \in \mathcal{H}$. Since $X \in \mathcal{G}$, $\operatorname{G-dim}_A X = -\sup X$. Therefore $\operatorname{G-dim}_A X[\sup X] = \operatorname{G-dim}_A X + \sup X = 0$. $\sup X[\sup X] \leq 0$ is obvious. Conversely, suppose $\sup X[\sup X] \leq 0$ and $\operatorname{G-dim}_A X[\sup X] \leq 0$. Then $\operatorname{G-dim}_A X \leq -\sup X$ as $\operatorname{G-dim}_A X[\sup X] = \operatorname{G-dim}_A X + \sup X$. By Corollary 3.4, we have $\operatorname{G-dim}_A X \geq -\sup X$.

It follows that $X \in \mathcal{G}$. In order to show $X \in \mathcal{H}$, it suffices to show $\operatorname{amp} X \leq \operatorname{amp} A$. Since $X[\sup X] \in \mathcal{R}(A)$, by [9, Proposition 1.2], we have

 $\inf(X[\sup X]) = \inf \operatorname{RHom}_A(\operatorname{RHom}_A(X[\sup X], A), A) \ge -\sup \operatorname{RHom}_A(X[\sup X], A) + \inf(A).$

Then

$$0 \ge \operatorname{G-dim}_A X[\sup X] = \sup(\operatorname{RHom}_A(X[\sup X], A)) \ge \inf(A) - \inf(X[\sup X])$$

It follows that $-\inf(A) \ge -\inf(X[\sup X])$. On the other hand, since $\sup A = 0$ and $0 \ge \sup X[\sup X]$, we have $\operatorname{amp} A = -\inf(A) \ge \sup X[\sup X] - \inf(X[\sup X]) = \operatorname{amp} X[\sup X] = \operatorname{amp} X$, as desired.

The second equivalence follows by the equalities ${}^{\perp_f}A[>0] = \{X \in \mathcal{R}(A) | \mathrm{H}^i(\mathrm{RHom}_A(X,A)) = 0 \text{ for } i > 0\}$ and $A[<0]^{\perp_f} = \{X \in \mathcal{R}(A) | \mathrm{H}^i(\mathrm{RHom}_A(A,X)) = 0 \text{ for } i > 0\} = \{X \in \mathcal{R}(A) | \mathrm{H}^i(X) = 0 \text{ for } i > 0\}.$

In the following, we set $\mathcal{A} = {}^{\perp_f} A[>0] \cap A[<0]^{\perp_f}$.

Remark 4.7. Let A be a non-positive DG-algebra over a field k satisfying the following conditions:

- (i) A is proper, i.e., $\dim_k \bigoplus_{i \in \mathbb{Z}} H^i(A) < \infty$;
- (ii) A is Gorenstein, i.e., the thick subcategory per A of the derived category D(A) generated by A coincides with the thick subcategory generated by DA, where $D = \text{Hom}_k(-,k)$ is the k-dual.

Assume that A is a proper Gorenstein DG-algebra. Recently, Jin defined that a DG-A-module $X \in D^{b}(A)$ is called *Cohen-Macaulay* if $\sup M \leq 0$ and $\operatorname{Hom}_{D^{b}(A)}(M, A[i]) = 0$ for all i > 0 (see [20, Definition 2.1]). If A is an ordinary Gorenstein algebra, then Cohen-Macaulay DG-modules defined by Jin is canonically equivalent to the usual (maximal) Cohen-Macaulay modules. Note that if a DG-module X belongs to $\mathcal{R}(A)$, then $X \in \mathcal{A}$ if and only if it is Cohen-Macaulay defined by Jin in the sense of [20].

On the other hand, from Corollary 1.5 we know that \mathcal{H} is equal to the class of maximal local-Cohen-Macaulay DG-modules defined by Shaul [28] over local Gorenstein DG-rings, see Definition 2.3. These two definitions are completely different at first glance. For example, one can see that the class of maximal local-Cohen-Macaulay DG-modules defined by Shaul is closed under suspensions, but the class of Cohen-Macaulay DG-modules defined by Jin is not. Fortunately, by Lemma 4.6, these two definitions are the same over commutative local Gorenstein DG-algebra over a field k under the condition that $\operatorname{ampR}\Gamma_{\overline{\mathfrak{m}}}X \ge \operatorname{amp}X \ge \operatorname{amp}A$ for all $X \in \mathcal{R}(A)$. This condition, are natural and very often met. For example, this holds for any module X over a commutative noetherian local ring A.

Lemma 4.8. The subcategory $\mathcal{R}(A)$ is thick and it is the smallest triangulated subcategory of $D_{f}^{b}(A)$ that contains the objects from \mathcal{A} .

Proof. Obviously, $\mathcal{R}(A)$ is closed under shifts and isomorphisms. Assume that $X \in \mathcal{R}(A)$ and X' is a direct summand of X. There exits two split triangles $X' \xrightarrow{u} X \xrightarrow{v} X'' \xrightarrow{0} X'[1]$ and $X'' \xrightarrow{p}$

 $X \xrightarrow{q} X' \xrightarrow{0} X''[1]$ in $D^{b}_{f}(A)$. For simplicity, we write ((-, A), A) for $\operatorname{RHom}_{A}(\operatorname{RHom}_{A}(-, A), A)$. Then we have the following commutative diagrams:

$$(4.1) \qquad \begin{array}{c} X' \xrightarrow{u} X \xrightarrow{v} X'' \xrightarrow{0} X'' \xrightarrow{0} X'[1] \\ \delta^{X'} \downarrow & \delta^{X} \downarrow & \delta^{X''} \downarrow & \delta^{X''} \downarrow \\ ((X', A), A) \longrightarrow ((X, A), A) \longrightarrow ((X'', A), A) \xrightarrow{0} ((X', A), A)[1], \\ (4.2) \qquad \begin{array}{c} X'' \xrightarrow{p} X \xrightarrow{q} X \xrightarrow{q} X' \xrightarrow{0} X''[1] \\ \delta^{X''} \downarrow & \delta^{X} \downarrow & \delta^{X'} \downarrow \\ ((X'', A), A) \longrightarrow ((X, A), A) \longrightarrow ((X', A), A) \xrightarrow{0} ((X'', A), A)[1]. \end{array}$$

Since u is a split monomorphism and δ^X is an isomorphism, it is straightforward to check that $\delta^{X'}$ is a split monomorphism by the commutative diagram (4.1). On the other hand, it follows from the commutativity of the diagram (4.2) that $\delta^{X'}q$ is an epimorphism, which implies that $\delta^{X'}$ is also an epimorphism. Thus, $\delta^{X'}$ is an isomorphism and X' belongs to $\mathcal{R}(A)$, and therefore $\mathcal{R}(A)$ is a thick subcategory of $D_{f}^{b}(A)$ by Proposition 3.1.

Recall that $\langle \mathcal{A} \rangle$ is the smallest thick triangulated subcategory of $D_{f}^{b}(A)$ that contains the objects from \mathcal{A} . Since $\mathcal{A} \subseteq \mathcal{R}(A)$, it follows that $\langle \mathcal{A} \rangle \subseteq \mathcal{R}(A)$. For the reverse containment, we assume that X is a non-zero object in $\mathcal{R}(A)$. Note that $\mathcal{R}(A)$ is precisely the subcategory of DG-modules with finite G-dimension. If $\operatorname{amp} X \geq \operatorname{amp} A$, applying Theorem 1.2(1), there exists a natural number n such that X belongs to $\mathcal{G}_{0}[-\operatorname{sup} X]*\mathcal{P}[-\operatorname{sup} X+1]*\cdots*\mathcal{P}[-\operatorname{sup} X+n]$. By the fact that $\mathcal{P} \subseteq \mathcal{G}_{0} \subseteq \mathcal{A}$, we deduce that X belongs to $\langle \mathcal{A} \rangle$. If $\operatorname{amp} X < \operatorname{amp} A$, applying Theorem 1.2(2), then $X \oplus X[\operatorname{amp} A - \operatorname{amp} X]$ belongs to $\mathcal{P}[-\operatorname{sup} X]*\cdots*\mathcal{P}[-\operatorname{sup} X+n-1]*\mathcal{G}_{0}[-\operatorname{sup} X+n]$ for some n. Similarly, since $\langle \mathcal{A} \rangle$ is thick, one has $X \in \langle \mathcal{A} \rangle$. Altogether, we have $\mathcal{R}(A) = \langle \mathcal{A} \rangle$. \Box

Let \mathcal{T} be a triangulated category. Recall that a subcategory $\omega \subseteq \mathcal{T}$ is called *presilting* if Hom_{\mathcal{T}}(M, M'[i]) = 0 for all $M, M' \in \omega$ and i > 0. Let \mathcal{E} be an arbitrary category. A full additive subcategory $\mathcal{M} \subseteq \mathcal{E}$ is called *contravariantly finite*, if every object X in \mathcal{E} admits a right \mathcal{M} -approximation, i.e. there exists an object $M \in \mathcal{M}$ and a morphism $f: M \to X$, such that the induced map Hom_{\mathcal{E}} $(N, M) \to \text{Hom}_{\mathcal{E}}(N, X)$ is surjective for all $N \in \mathcal{M}$. Dually, we define the notion of a *covariantly finite* subcategory. We say that M is *functorially finite* if it is both covariantly and contravariantly finite.

Lemma 4.9. The following statement hold.

- (1) \mathcal{A} is closed under extensions and direct summands and finite direct sums in $\mathcal{R}(\mathcal{A})$.
- (2) The subcategory $\mathcal{P} = \operatorname{add} A$ is presilting and functorially finite in $\mathcal{R}(A)$.
- (3) For any $X \in \mathcal{R}(A)$, $\operatorname{Hom}_{D(A)}(X, N[i]) = 0 = \operatorname{Hom}_{D(A)}(N, X[i])$ for any $N \in \mathcal{P}$ and $i \gg 0$.

Proof. (1) Since $\mathcal{A} = A[<0]^{\perp_f} \cap {}^{\perp_f} A[>0]$, one can check that all objects in \mathcal{A} is closed under extensions and direct summands and finite direct sums in $\mathcal{R}(A)$.

(2) The subcategory \mathcal{P} is presilting follows from the fact that A is a non-positive DG-ring. Note that for any $N \in \mathcal{R}(A)$, the set of the generators of $\operatorname{Hom}_{D(A)}(A, N) \cong \operatorname{H}^{0}(N)$ is finite. If f_1, \dots, f_s are generators of $\operatorname{Hom}_{\mathcal{D}(A)}(A, N)$, then the canonical homomorphism $f: A^{(s)} \to N$ given by (f_1, \dots, f_s) is a right add *A*-approximation. On the other hand, since $\operatorname{RHom}_A(X, A) \in \mathcal{D}^{\mathrm{b}}_{\mathrm{f}}(A)$ for any $X \in \mathcal{R}(A)$, the set $\operatorname{Hom}_{\mathcal{D}(A)}(X, A)$ also has finite generators. So the left add *A*-approximation can be constructed by a similar way. Therefore, \mathcal{P} is functorially finite in $\mathcal{R}(A)$. (3) It is obvious.

Following [35], we denote by $[\mathcal{D}]$ the ideal of morphisms in \mathcal{C} which factor through objects in \mathcal{D} . The stable category of \mathcal{C} by \mathcal{D} is the quotient category $\mathcal{C}/[\mathcal{D}]$, for which objects are the same as \mathcal{C} , but morphisms are morphisms in \mathcal{C} modulo those in $[\mathcal{D}]$.

We have the following results, which are analogues of well-known properties of Cohen-Macaulay modules.

Theorem 4.10. (1) The stable category $\underline{A} := \mathcal{A}/[\mathcal{P}]$ is a triangulated category; (2) The composition $\mathcal{A} \hookrightarrow \mathcal{R}(A) \to \mathcal{R}(A)/\langle \mathcal{P} \rangle$ induces a triangle equivalence

$$H: \underline{\mathcal{A}} \simeq \mathcal{R}(\mathcal{A})/\langle \mathcal{P} \rangle.$$

(3) $\mathcal{R}(A) = D^{b}_{f}(A)$ if and only if A is a local Gorenstein DG-ring.

Proof. (1) By Lemma 4.9(2), we know that \mathcal{P} is presilting and functorially finite in $\mathcal{R}(A)$. Then the result follows from the proof of [35, Corollary 2.7] and [35, Proposition 2.4(3)].

(2) Since $\mathcal{P} \subseteq \mathcal{R}(A)$ and $\mathcal{R}(A)$ is a triangulated full subcategory of $D_{\mathrm{f}}^{\mathrm{b}}(A)$, we have $\langle \mathcal{P} \rangle \subseteq \mathcal{R}(A)$. Thanks to [35, Corollary 2.7] or [19, Theorem 1.1], by Lemma 4.9, there is a triangle equivalence between \underline{A} and the singularity category $D_{\mathrm{f}}^{\mathrm{b}}(A)/\langle \mathcal{P} \rangle$.

(3) This follows from Theorem 1.2(3).

Let G be the obvious composite functor $\mathcal{A} \to D^{\mathrm{b}}_{\mathrm{f}}(A) \to D^{\mathrm{b}}_{\mathrm{f}}(A)/\langle \mathcal{P} \rangle$. Since $G(\mathcal{P}) = 0$, there is a unique factorization of G through the canonical projection $S : \mathcal{A} \to \underline{\mathcal{A}}$. We denote by F the factorization from $\underline{\mathcal{A}}$ to $D^{\mathrm{b}}_{\mathrm{f}}(A)/\langle \mathcal{P} \rangle$. Then $G = F \circ S$. In fact, F is the composite functor $\underline{\mathcal{A}} \xrightarrow{H} \mathcal{R}(A)/\langle \mathcal{P} \rangle \hookrightarrow D^{\mathrm{b}}_{\mathrm{f}}(A)/\langle \mathcal{P} \rangle$. Let A be a local Gorenstein DG-ring. By Theorem 4.10(3), we obtain a triangle equivalence: $F : \underline{\mathcal{A}} \simeq D^{\mathrm{b}}_{\mathrm{f}}(A)/\langle \mathcal{P} \rangle$.

We are now ready to prove Corollary 1.6.

Proof of Corollary 1.6. By Theorem 4.10, it suffices to show that if the functor $F : \underline{A} \to D_{\mathrm{f}}^{\mathrm{b}}(A)/\langle \mathcal{P} \rangle$ is dense, then A is a local Gorenstein DG-ring. Assume that $F : \underline{A} \to D_{\mathrm{f}}^{\mathrm{b}}(A)/\langle \mathcal{P} \rangle$ is dense, and let M be any DG-module in $D_{\mathrm{f}}^{\mathrm{b}}(A)$. It follows that $M \cong F(G)$ in $D_{\mathrm{f}}^{\mathrm{b}}(A)$ for some $G \in \mathcal{A}$. Let $s \setminus f : M \xrightarrow{f} Z \rightleftharpoons G$ be an isomorphism in $D_{\mathrm{f}}^{\mathrm{b}}(A)$ with $\mathrm{cn}(s) \in \langle \mathcal{P} \rangle$, then $\mathrm{cn}(f) \in \langle \mathcal{P} \rangle$. Consider the triangle $G \stackrel{s}{\Longrightarrow} Z \longrightarrow \mathrm{cn}(s) \rightsquigarrow \mathrm{in} D_{\mathrm{f}}^{\mathrm{b}}(A)$. We see that G and $\mathrm{cn}(s)$ lie in $\mathcal{R}(A)$, so $Z \in \mathcal{R}(A)$. It follows from $Z \in \mathcal{R}(A)$ and $\mathrm{cn}(f) \in \mathcal{R}(A)$ that $M \in \mathcal{R}(A)$. Therefore the G-dimension of M is finite. Thus A is a local Gorenstein DG-ring by Theorem 1.2(3). \Box

Remark 4.11. If A is a local Gorenstein ring, then Corollary 1.6 gives the classical Buchweitz-Happle Theorem and its inverse. As we stated in the Introduction, Jin [20] proved that if A is a proper Gorenstein DG-algebra, then there is a triangle equivalence between the stable category of Cohen-Macaulay DG-modules (see Remark 4.7) and the singularity category $D^{b}(A)/\langle \mathcal{P} \rangle$. This generalizes Buchweitz-Happle Theorem to the setting of proper Gorenstein DG-algebras (see [20, Theorem 2.4]). In fact, over commutative local noetherian DG-algebras over a field k, condition (ii) of the proper Gorenstein DG-algebra is equivalent to $\operatorname{injdim}_A A < \infty$. In this case, a Gorenstein ring in our setting is a proper Gorenstein DG-algebra defined in [20]. Therefore, over a commutative local noetherian non-positive DG algebra over k, Corollary 1.6 shows that the inverse of Buchweitz-Happel Theorem is also true.
