### Abstract

We define and study a notion of G-dimension for DG-modules over a non-positively graded commutative noetherian DG-ring A. Some criteria for the finiteness of the G-dimension of a DG-module are given by applying a DG-version of projective resolution introduced by Minamoto [Israel J. Math. 245 (2021) 409-454]. Moreover, it is proved that the finiteness of G-dimension characterizes the local Gorenstein property of A. Applications go in three directions. The first is to establish the connection between G-dimensions and the little finitistic dimensions of A. The second is to characterize Cohen-Macaulay and Gorenstein DG-rings by the relations between the class of maximal local-Cohen-Macaulay DG-modules and a special G-class of DG-modules. The third is to extend the classical Buchwtweiz-Happel Theorem and its inverse from commutative noetherian local rings to the setting of commutative noetherian local DG-rings.

### 1. INTRODUCTION

<span id="page-0-0"></span>The Gorenstein dimension, or G-dimension, for finitely generated modules over a commutative noetherian ring was introduced by Auslander [\[1\]](#page-16-1) and was developed deeply by Auslander and Bridger [\[2\]](#page-16-2). The reason for the name is that G-dimension characterizes Gorenstein local rings exactly as projective dimension characterizes regular local rings. With that as a start, Gdimension has played an important role in singularity theory [\[10,](#page-16-3) [34\]](#page-17-0), cohomology theory of commutative rings [\[5,](#page-16-4) [11\]](#page-16-5) and representation theory of Artin algebras [\[3,](#page-16-6) [26\]](#page-17-1). Over a general ring, Enochs and Jenda [\[13\]](#page-16-7) defined Gorenstein projective dimension for arbitrary modules. For finitely generated modules over commutative noetherian rings it coincides with the Auslander

and Bridger's G-dimension. For left modules over arbitrary associative rings, Holm [\[18\]](#page-16-8) proved that the new concept has the desired properties.

In a different direction, Yassemi [\[31\]](#page-17-2) studied G-dimension for complexes over a commutative noetherian local ring through a consistent use of the RHom-functor of complexes and the related category of reflexive complexes, while Christensen [\[11\]](#page-16-5) went straight for the throat and gave the definition in terms of resolutions. Thus, the two definitions are equivalent, and they are both rooted in a result — due to Foxby — saying that a finitely generated module has finite  $G$ dimension if and only if it is reflexive as a complex in the sense defined in [\[31,](#page-17-2) Definition 2.4] (see also  $[11,$  Definition 2.1.6]).

The aim of this paper is to introduce and study G-dimensions in derived commutative algebra. More specifically, we work with non-positively graded commutative DG-rings  $A = \bigoplus_{n=-\infty}^{0} A^i$ with a differential of degree  $+1$ . These include the normalizations of simplicial commutative rings, so this setup includes the affine theory of derived algebraic geometry.

Given a commutative DG-ring  $A$ , the derived category of DG-modules over  $A$  will be denoted by  $D(A)$ . Its full subcategory consisting of DG-modules with bounded cohomology will be denoted by  $D^b(A)$ . We denote by  $D^b_f(A)$  the full triangulated subcategory of  $D^b(A)$  consisting of DG-modules with finitely generated cohomology. For a DG-module M, we set  $\inf M = \inf \{ n \mid$  $H^{n}(M) \neq 0$ , sup $M = \sup\{n \mid H^{n}(M) \neq 0\}$ , and amp $M = \sup M - \inf M$ .

<span id="page-1-0"></span>Motivated by the G-dimension for complexes over a commutative noetherian ring defined in [\[11,](#page-16-5) [31\]](#page-17-2), we introduce the definition of G-dimension for DG-modules.

**Definition 1.1.** Let A be a noetherian DG-ring with amp $A < \infty$ .

- (1) *A DG-module*  $X \in D_f^b(A)$  *is said to be* reflexive *if*  $RHom_A(X, A) \in D_f^b(A)$  *and the canonical homomorphism*  $X \to \mathrm{RHom}_A(\mathrm{RHom}_A(X, A), A)$  *is isomorphic in*  $D_f^b(A)$ *.*
- (2) For a reflexive DG-module X, we define the G-dimension of A, denoted by  $G$ -dim<sub>A</sub>X, *by the formula*

$$
G\text{-dim}_AX = \text{supRHom}_A(X, A).
$$

*If* X is not reflexive, we say that it has infinite G-dimension and write  $G$ -dim $_A X = \infty$ *.* 

(3) The number  $\sup\{G\text{-dim}_AX + \inf X | X \in D_f^b(A)\}\$ is called the global G-dimension of A *and is denoted by* G*-*gldimA*.*

Let  $A$  be an ordinary ring. If  $X$  is an  $A$ -module, then one can show that this definition coincides with the usual definition of the G-dimension of X defined by Auslander in  $[1]$ ; moreover, if X is an A-complex, then the G-dimension of X defined here is just the definition defined by Yassemi in [\[31,](#page-17-2) Definition 2.8] or by Christensen in [\[11,](#page-16-5) Definition 2.3.3 and Theorem 2.3.7].

We denote by  $\mathcal{R}(A)$  for the full subcategory of  $D(A)$  consisting of reflexive DG-modules. A DG-module  $X \in \mathcal{R}(A)$  is said to be in the *G-class* G if either G-dim<sub>A</sub> $X = -\sup X$ , or  $X = 0$ , and denote by  $\mathcal{G}_0$  the full subcategory of  $\mathcal G$  consisting of objects G such that either G-dim<sub>A</sub>G =  $-\sup G = 0$ , or  $G = 0$  (see Definition [3.5\)](#page-7-0). If we write  $\mathcal{P} \subseteq D(A)$  for the full subcategory of direct summands of a finite direct sums of A, i.e.  $\mathcal{P} = \text{add}A$ , then it is easy to check  $\mathcal{P} \subseteq \mathcal{G}_0$ . If A is an ordinary ring and X an A-module, then  $\mathcal{G} = \mathcal{G}_0$  is exactly the class of modules of G-dimension zero.

Following [\[23\]](#page-17-3), for any  $0 \not\cong X \in D^+(A)$ , a *sppj morphism*  $f: P \to X$  is a morphism in  $D(A)$ such that  $P \in \text{Add}A[-\text{sup}X]$  and the morphism  $H^{\text{sup}X}(f)$  is surjective, where AddA is the full subcategory of direct summands of a direct sum of A. Moreover, a *sppj resolution*  $P_{\bullet}$  of X is a sequence of exact triangles  $X_{i+1} \stackrel{g_{i+1}}{\to} P_i \stackrel{f_i}{\to} X_i \rightsquigarrow$  such that  $f_i$  is a sppj morphism for  $i \geq 0$  with  $X_0 := X$ . If A is noetherian and  $X \in D_f^b(A)$  then we can choose  $P_i$  in  $P$  by [\[23,](#page-17-3) Proposition 2.26].

We set  $\text{injdim}_A A := \inf \{ n \in \mathbb{Z} \mid \text{Ext}^i_A(N, A) = 0 \text{ for any } N \in D^b(A) \text{ and } i > n - \inf N \}.$  Fol-lowing [\[14,](#page-16-9) [15\]](#page-16-10), recall that a commutative noetherian local DG-ring  $(A, \bar{m}, \bar{k})$  is called *Gorenstein* if amp $A < \infty$  and injdim  $_A A < \infty$ .

Recall that for full subcategories  $\mathcal{X}, \mathcal{Y} \subseteq D(A)$ , we define  $\mathcal{X} * \mathcal{Y}$  to be the full subcategory consisting  $Z \in D(A)$  which fits into an exact triangle  $X \to Z \to Y \rightsquigarrow$  with  $X \in \mathcal{X}$  and  $Y \in \mathcal{Y}$ .

<span id="page-2-0"></span>Now, our main result can be stated as follows.

**Theorem 1.2.** Let  $(A, \overline{\mathfrak{m}}, \overline{k})$  be a commutative noetherian local DG-ring with  $\text{ampA} < \infty$ .

- (1) If  $0 \neq X \in D_f^b(A)$  *with* amp $X \geq \text{ampA}$  *and n is a natural number, then the following are equivalent:*
	- $(i)$  G-dim<sub>A</sub> $X \leq n \sup X$ ;
	- *(ii)* For any sppj resolution  $P_{\bullet}$  of X with each  $P_i \in \mathcal{P}$ , one has  $X_n \in \mathcal{G}_0[-\sup X]$ ;
	- *(iii)* X *belongs to*  $\mathcal{P}[-\sup X] * \cdots * \mathcal{P}[-\sup X + n 1] * \mathcal{G}_0[-\sup X + n];$
	- *(iv)* X *belongs to*  $\mathcal{G}_0[-\sup X] * \mathcal{P}[-\sup X + 1] * \cdots * \mathcal{P}[-\sup X + n].$
- (2) If  $0 \neq X \in D_f^b(A)$  *with* amp $X <$  ampA *and n is a natural number, then the following are equivalent:*
	- $(i)$  G-dim<sub>A</sub> $X \leq n + \inf A \inf X$ ;
	- *(ii)*  $X \oplus X$ [amp*A* − amp*X*] *belongs to*  $\mathcal{P}$ [-sup*X*]\*···\* $\mathcal{P}$ [-sup*X*+n−1]\* $\mathcal{G}_0$ [-sup*X*+n]*.*
- *(3) The following conditions are equivalent:*
	- *(i)* A *is local Gorenstein;*
	- $(ii)$  G-dim<sub>A</sub> $\bar{k} < \infty$ ;
	- $(iii)$  G-gldim $A < \infty$ .

Theorem [1.2](#page-2-0) provides criteria for a natural number to be an upper bound of the G-dimension of a DG-module and the global G-dimension of a commutative noetherian local DG-ring. Moreover, it should be pointed out the inequality  $\text{amp}X < \text{amp}A$  in Theorem [1.2\(](#page-2-0)2) is very often met. For instance, let  $(A, \bar{m}, \bar{k})$  be a commutative noetherian local DG-ring with  $0 < \text{ampA} < \infty$ , then amp $\bar{k} = 0$ . In addition, if A is local Gorenstein, then  $\bar{k}$  has finite G-dimension by Theorem [1.2\(](#page-2-0)3), but Lemma [3.3](#page-6-1) yields that  $\bar{k}$  never has finite projective dimension introduced by Bird, Shaul, Sridhar and Williamson in [\[9\]](#page-16-11). In combination with Proposition [4.1,](#page-9-2) we conclude that G-dmension is a finer invariant than projective dimension for DG-modules.

Let A be an Artin algebra. The *little finitistic dimension* of A, fpdA, is the supremum of projective dimensions of finitely generated A-modules of finite projective dimension. It is conjectured that  $fpdA < \infty$  holds for Artin algebras A; see Bass [\[6\]](#page-16-12) and [\[4,](#page-16-13) Conjectures]. This is the Finitistic Dimension Conjecture. Recently, this invariant has been generalized by Bird, Shaul, Sridhar and Williamson in [\[9\]](#page-16-11) to the setting of non-positive commutative noetherian

DG-rings with bounded cohomology. More precisely, they considered the number

 $\text{fpd}A = \sup\{\text{projdim}_A X + \inf X \mid X \in D_f^b(A) \text{ with } \text{projdim}_A X < \infty\}.$ 

It should be noted that the little finitistic dimensions of an algebra can alternatively be computed by G-dimension; see for instance [\[29,](#page-17-4) Lemma 4.4]. As the first application of Theorem [1.2,](#page-2-0) we have the following corollary which shows that the little finitistic dimension  $\text{fpd}(A)$  over a DG-ring A can be computed by G-dimension defined in Definition [1.1](#page-1-0) above.

<span id="page-3-0"></span>**Corollary 1.3.** If A is a commutative noetherian local DG-ring with ampA  $<\infty$ , then we have

 $\text{fpd}A = \sup\{G\text{-dim}_AX + \inf X \mid X \in D_f^b(A) \text{ with } \text{amp}X \ge \text{amp}A, G\text{-dim}_AX < \infty\}.$ 

As a direct consequence of Theorem [1.2\(](#page-2-0)3) and Corollary [1.3,](#page-3-0) it follows that a local Gorenstein DG-ring A has finite little finitistic dimension.

Let  $A$  be a commutative noetherian local ring (not a DG-ring). A close relation between the class of maximal Cohen-Macaulay modules and the class of modules of G-dimension zero over A can be shown in the following fact; see for instance [\[12,](#page-16-14) 3.3].

<span id="page-3-1"></span>Fact 1.4. *Let* A *be a commutative noetherian local ring. Denote by* M *the class of maximal Cohen-Macaulay modules over* A*. Then the following hold:*

- *(1)* A *is Cohen-Macaulay if and only if*  $G \subseteq M$ *.*
- (2) A *is Gorenstein if and only if*  $G = M$ .

Recently, the theory of Cohen-Macaulay rings and Cohen-Macaulay modules has been extended by Shaul [\[28\]](#page-17-5) to the setting of commutative noetherian DG-rings. There are many examples of local Cohen-Macaulay DG-rings, in particular local Gorenstein DG-rings are Cohen-Macaulay. As the second application of Theorem [1.2,](#page-2-0) we can generalize the above fact to the setting of commutative noetherian local DG-rings.

<span id="page-3-2"></span>Corollary 1.5. Let  $(A, \bar{m})$  be a commutative noetherian local DG-ring with  $\text{amp}A < \infty$ . Denote *by* M *the class of maximal local-Cohen-Macaulay DG-modules over* A*. Set*

 $\mathcal{H} = \{X \in \mathcal{G} | \text{ampR}\Gamma_{\bar{\mathfrak{m}}}X \geq \text{amp}X = \text{amp}A\}.$ 

*Then the following hold:*

- *(1)* A *is local-Cohen-Macaulay if and only if*  $H \subseteq M$ *.*
- *(2) A is Gorentein if and only*  $H = M$ *.*

In the study of stable homological algebra and Tate cohomology for two sided noetherian rings A, Buchweitz [\[10\]](#page-16-3) introduced the Verdier quotient  $D_{sg}(A) := D^{b}(A)/K^{b}(A)$ , where  $K^{b}(A)$ is the bounded homotopy category of finitely generated projective left A-modules. Later on, this category was reconsidered by Orlov [\[25\]](#page-17-6). Since it measures the homological singularity of the category of finitely generated left A-modules in sense that  $D_{sg}(A) = 0$  if and only if the global dimension of A is finite, we call it the *singularity category*. Buchweitz-Happel Theorem([\[10,](#page-16-3) Theorem 4.4.1], see also [\[17,](#page-16-15) Theorem 4.6]) says that there is a fully faithful triangle functor  $F: \mathcal{G} \to D_{sq}(A)$  provided that A is a commutative local Gorenstein ring. Also, it was shown in [\[7\]](#page-16-16) that the inverse of this theorem holds true (see also [\[8,](#page-16-17) [22\]](#page-17-7)). Recently, Buchweitz-Happel

Theorem has been generalized by Jin to a proper noncommutative Gorenstein DG-algebra over a field  $k$  (see [\[20,](#page-17-8) Theorem 0.3 and Assumption 0.1]).

As the third application of Theorem [1.2,](#page-2-0) we extend the classical Buchwtweiz-Happel Theorem and its inverse from commutative noetherian local rings to the setting of commutative noetherian local DG-rings. For notation and notions, we refer the reader to Section [4.3.](#page-12-0)

<span id="page-4-1"></span>Corollary 1.6. *Assume that* A *is a commutative noetherian local DG-ring with* ampA  $< \infty$ *.* Let  $\mathcal{A} = \{X \in \mathcal{R}(A) | \sup X \leq 0 \text{ and } G\text{-dim}_A X \leq 0\}$ , and let  $D_{sg}(A) := D_f^b(A)/\langle \mathcal{P} \rangle$  be the *singularity category over* A*. Then the functor*

$$
F: \underline{\mathcal{A}} \to D_{sg}(A)
$$

*is a triangle equivalence if and only if* A *is a local Gorenstein DG-ring.*

Remark that if A is a commutative noetherian local DG-algebra over a field  $k$ , a Gorenstein ring in our setting is a proper Gorenstein DG-algebra defined by Jin in [\[20,](#page-17-8) Assumption 0.1]. Therefore, over a commutative local noetherian non-positive DG algebra over a field  $k$ , Corollary [1.6](#page-4-1) conveys that the inverse of Buchwtweiz-Happel Theorem obtained by Jin [\[20,](#page-17-8) Theorem 0.3] is also true.

The article is organized as follows. In Section [2,](#page-4-0) we introduce notation, definitions and basic facts needed for proofs. Section [3](#page-6-0) is devoted to give the proof of Theorem [1.2.](#page-2-0) In Section 4, we apply Theorem [1.2](#page-2-0) to establish the connection between G-dimensions and the little finitistic dimensions of A, to obtain a DG version of Fact [1.4,](#page-3-1) and to show a DG-version of Buchwtweiz-Happel Theorem and its inverse over A, and therefore prove the three corollaries.

### <span id="page-4-2"></span>2. Preliminaries

<span id="page-4-0"></span>An *associative DG-ring* A is a Z-graded ring  $A = \bigoplus_{i \in \mathbb{Z}} A^i$  equipped with a Z-linear map  $d: A \rightarrow A$  of degree +1 such that  $d \circ d = 0$ , and such that

(2.1) 
$$
d(a \cdot b) = d(a) \cdot b + (-1)^i a \cdot d(b)
$$

for all  $a \in A^i$  and  $b \in A^j$ . A DG-ring A is called *commutative* if for all  $a \in A^i$  and  $b \in A^j$ , one has  $b \cdot a = (-1)^{i \cdot j} a \cdot b$ , and  $a^2 = 0$  if i is odd. A DG-ring A is called *non-positive* if  $A^i = 0$  for all  $i > 0$ . A non-positive DG-ring A is called *noetherian* if the ring  $H^0(A)$  is noetherian and the  $H^0(A)$ -modules  $H^i(A)$  are finitely generated for all  $i < 0$ . All DG-rings in this paper will be assumed to be commutative and non-positive.

A DG-module M over A is a graded A-module together with a differential of degree  $+1$ satisfying the Leibniz rule similar to [\(2.1\)](#page-4-2). The DG-A-modules form an abelian category, and by inverting the quasi-isomorphisms we obtain the derived category  $D(A)$  which is triangulated. We refer the reader to [\[33\]](#page-17-9) for more details about DG-rings and their derived categories.

If A is a noetherian DG-ring, we say that  $M \in D(A)$  has finitely generated cohomology if for all  $n \in \mathbb{Z}$ , the H<sup>0</sup>(A)-modules H<sup>n</sup>(M) are finitely generated. We denote by D<sub>f</sub>(A) the full triangulated subcategory of  $D(A)$  consisting of DG-modules with finitely generated cohomology. We also set  $D_f^-(A) = D_f(A) \cap D^-(A)$ . Similarly we will consider  $D_f^+(A)$  and  $D_f^b(A)$ . All these are full triangulated subcategories of  $D(A)$ . If A is a noetherian DG-ring, and if the noetherian ring

 $H^0(A)$  is local with maximal ideal  $\bar{\mathfrak{m}}$  and residue field  $\bar{k}$ , we will say that  $(A, \bar{\mathfrak{m}})$  (or  $(A, \bar{\mathfrak{m}}, \bar{k})$ ) is a noetherian local DG-ring.

<span id="page-5-0"></span>We recall the definition of the projective and injective dimensions of DG-modules introduced by Bird, Shaul, Sridhar and Williamson.

**Definition 2.1.** ([\[9,](#page-16-11) Definition 1.3]) *Let* A *be a DG-ring and*  $M \in D(A)$ *.* 

*(1) The* projective dimension *of* M *is defined by*

projdim<sub>A</sub> $M = \inf\{n \in \mathbb{Z} | \text{Ext}^i_A(M, N) = 0 \text{ for any } N \in D^b(A) \text{ and any } i > n + \text{sup}N \}.$ 

*(2) The* injective dimension *of* M *is defined by*

 $\text{injdim}_A M = \text{inf}\{n \in \mathbb{Z} | \text{Ext}^i_A(N, M) = 0 \text{ for any } N \in D^b(A) \text{ and any } i > n - \text{inf}N\}.$ 

Let A be a DG-ring, and let  $\bar{\mathfrak{a}} \subseteq \mathrm{H}^0(A)$  be a finitely generated ideal. The category of derived  $\bar{\mathfrak{a}}$ -torsion DG-modules over A, denoted by  $D_{\bar{\mathfrak{a}}\text{-tor}}(A)$ , is the full triangulated subcategory of  $D(A)$  consisting of DG-modules M such that the  $H^0(A)$ -modules  $H^n(M)$  are  $\bar{\mathfrak{a}}$ -torsion for all  $n \in \mathbb{Z}$ . One can show that the inclusion functor  $F : D_{\bar{a}$ -tor $(A) \to D(A)$  has a right adjoint  $G : D(A) \to D_{\bar{a} \text{-tor}}(A)$ , and composing this right adjoint with the inclusion, one obtains a triangulated functor

$$
R\Gamma_{\bar{\mathfrak{a}}}:D(A)\to D(A),
$$

which we call the *derived torsion* or *local cohomology functor* of A with respect to  $\bar{a}$ . The functor  $R\Gamma_{\bar{a}}$  has a right adjoint which is denoted by

$$
L\Lambda_{\bar{\mathfrak{a}}}:D(A)\to D(A),
$$

This functor is called the *local homology* or *derived completion functor* with respect to  $\bar{a}$ . We recall the following definitions introduced by Shaul [\[28\]](#page-17-5).

**Definition 2.2.** Let  $(A, \bar{m})$  be a noetherian local DG-ring.

*(1)* We define the local cohomology Krull dimension of  $M ∈ D<sup>−</sup>(A)$  to be

$$
lc.dim_A M := \sup_{l \in \mathbb{Z}} \{ \dim(\mathrm{H}^l(M)) + l \}.
$$

*(2)* We define the depth of  $N \in D^+(A)$  to be the number

$$
depth_A N := \inf \text{RHom}_A(\bar{k}, N).
$$

<span id="page-5-1"></span>**Definition 2.3.** Let  $(A, \bar{m})$  be a noetherian local DG-ring with amp $A < \infty$ .

- *(1)* A *is called* local Cohen-Macaulay *if*  $amp{\text{ampR}}\Gamma_{\bar{\mathfrak{m}}}(A) =amp{ampA}$ .
- (2) We say that  $M \in D_f^b(A)$  *is a* local-Cohen-Macaulay DG-module *if there are equalities*

$$
\mathrm{amp}M=\mathrm{amp}A=\mathrm{ampR}\Gamma_{\bar{\mathfrak{m}}}(M).
$$

*(3) A local-Cohen-Macaulay DG-module* M *is* maximal local-Cohen-Macaulay *if*

 $\operatorname{lc.dim}_AM = \sup M + \dim \operatorname{H}^0(A).$ 

*We denote by* M *the full subcategory of maximal local-Cohen-Macaulay DG-modules.*

From now until the end of the paper, we always assume that  $(A, \bar{\mathfrak{m}}, \bar{k})$  is a commutative noetherian local DG-ring with  $\text{amp}A < \infty$ .

## 3. Proof of Theorem [1.2](#page-2-0)

<span id="page-6-3"></span><span id="page-6-0"></span>This section is devoted to a proof of the statements of Theorem [1.2.](#page-2-0) We start with the following proposition.

**Proposition 3.1.** Let  $X' \to X \to X'' \to X'[1]$  be an exact triangle in  $D_f^b(A)$ . If two of the *DG-modules belong to* R(A)*, then so is the third.*

*Proof.* If two of  $\text{RHom}_A(X', A)$ ,  $\text{RHom}_A(X, A)$  and  $\text{RHom}_A(X'', A)$  are in  $D_f^{\text{b}}(A)$ , then so is the third. Using the abbreviated notation  $((-, A), A) := \text{RHom}_{A}(\text{RHom}_{A}(-, A), A)$ , we have the following commutative diagram in  $D_f^b(A)$ :

$$
X' \longrightarrow X \longrightarrow X'' \longrightarrow X''

((X', A), A) \longrightarrow ((X, A), A) \longrightarrow ((X'', A), A) \longrightarrow ((X', A), A)[1].

Therefore, if two of the morphisms  $\delta^{X'}$ ,  $\delta^X$  and  $\delta^{X''}$  are isomorphisms, then so is the third. The rest follows by the fact that  $D_f^b(A)$  is the full triangulated subcategory of  $D(A)$ .

Following [\[14\]](#page-16-9), a dualizing DG-module R over A is a DG-module  $R \in D_f^+$  $f<sub>f</sub><sup>+</sup>(A)$  such that injdim<sub>A</sub>R <  $\infty$  and the natural map A  $\rightarrow$  RHom<sub>A</sub>(R, R) is an isomorphism in D(A). It follows by [\[14,](#page-16-9) Theorem 3.2] that  $R \in D_f^b(A)$ . If A is local then dualizing DG-module over A is unique up to shift. We say that R is normalized if  $\inf R = -\dim H^0(A)$ .

<span id="page-6-2"></span>**Lemma 3.2.** Let R be a normalized dualizing DG-module over A. For  $X \in D_f^b(A)$ , one has  $\inf \text{RHom}_A(X, R) = -\text{lcdim}_A X$ ,  $\operatorname{depth}_A \text{RHom}_A(X, R) = -\text{sup}X$  $\sup{\text{RHom}_A(X,R)} = -\text{depth}_A X, \text{lc.dim}_A \text{RHom}_A(X,R) = -\inf X.$ 

*Proof.* By [\[27,](#page-17-10) Theorem 7.26] and [\[28,](#page-17-5) Theorem 2.15], one has

 $\inf$ RHom<sub>A</sub> $(X, R) = -\sup$ R $\Gamma_{\overline{\mathfrak{m}}}(X) = -\text{lclim}_A X$ .

Applying to [\[27,](#page-17-10) Theorem 7.26] and [\[28,](#page-17-5) Proposition 3.3], we obtain

 $\text{supRHom}_{A}(X, R) = -\text{infR}\Gamma_{\overline{\mathfrak{m}}}(X) = -\text{depth}_{A}X.$ 

<span id="page-6-1"></span>Since  $X \simeq \text{RHom}_{A}(\text{RHom}_{A}(X, R), R)$ , it follows that lc.dim<sub>A</sub>RHom<sub>A</sub> $(X, R) = -\text{inf}X$  and  $\text{depth}_A \text{RHom}_A(X, R) = -\text{sup}X.$ 

**Lemma 3.3.** *Let*  $0 \neq X \in D_f^b(A)$  *with*  $projdim_A X < \infty$ *. Then*  $ampX \geq ampA$ *.* 

*Proof.* Let  $B = L\Lambda_{\bar{\mathfrak{m}}}(A)$ . Then  $X \otimes_A^L B \in D_f^b(B)$  with  $\text{projdim}_B(X \otimes_A^L B) < \infty$  by [\[9,](#page-16-11) Proposition 3.7] and  $\operatorname{amp} X = \operatorname{amp}(X \otimes_A^{\mathbf{L}} B)$ ,  $\operatorname{amp} B = \operatorname{amp} A$ . Thus we may assume that A is derived  $\overline{\mathfrak{m}}$ adic complete, and A has a normalized dualizing DG-module  $R$  by [\[27,](#page-17-10) Proposition 7.21]. As  $\text{RHom}_A(X, R) \simeq \text{RHom}_A(X, A) \otimes_A^{\mathbf{L}} R$  by [\[9,](#page-16-11) Proposition 1.16], one has

$$
\otimes_A^{\mathcal{L}} R
$$
)  
\n= sup{dim<sup>0</sup>(A)/ $\bar{\mathfrak{p}}$  + supRHom<sub>A</sub>(X, A) $\bar{\mathfrak{p}}$  + sup $R_{\bar{\mathfrak{p}}}$ | $\bar{\mathfrak{p}}$   $\in$  SpecH<sup>0</sup>(A)}  
\n= lc.dim<sub>A</sub>R + supRHom<sub>A</sub>(X, A)  
\n= lc.dim<sub>A</sub>R + projdim<sub>A</sub>X,

where the last equality is by  $[30,$  Proposition 4.4(3). Hence we have the next (in)equalities

$$
ampX = lc.dim_A\text{RHom}_A(X, R) - depth_A\text{RHom}_A(X, R)
$$
  
= lc.dim<sub>A</sub>R + projdim<sub>A</sub>X + supX - depth<sub>A</sub>R  

$$
\ge \text{ampR}\Gamma_{\overline{\mathfrak{m}}}(R)
$$
  
= ampA,

where the first equality is by Lemma [3.2,](#page-6-2) the second one is by [\[30,](#page-17-11) Proposition 4.9] and Nakayama's lemma and the last one is by [\[27,](#page-17-10) Theorem 7.26]. The inequality is by the fact that  $\operatorname{projdim}_A X \ge -\operatorname{sup} X$ .

<span id="page-7-1"></span>Corollary 3.4. *If*  $X \in \mathcal{R}(A)$  *with* amp $X \ge \text{amp}A$ , *then* G-dim<sub>A</sub> $X \ge -\text{sup}X$ .

*Proof.* Let  $B = L\Lambda_{\bar{m}}(A)$ . Then  $X \otimes_A^L B \in \mathcal{R}(B)$  with  $\text{amp}(X \otimes_A^L B) \ge \text{amp}B$  and  $G\text{-dim}_B(X \otimes_A^L B)$  $B) = G$ -dim<sub>A</sub>X, sup( $X \otimes_A^{\mathbb{L}} B$ ) = supX. We may assume that A is derived  $\bar{\mathfrak{m}}$ -adic complete, and A has a normalized dualizing DG-module R. Hence by Lemma [3.2](#page-6-2) and  $[27,$  Theorem 7.26], one has the next (in)equalities

$$
ampX = lc.dim_A\text{H}om_A(X, R) - depth_A\text{H}om_A(X, R)
$$
  
= lc.dim<sub>A</sub>R + sup\text{H}om<sub>A</sub>(X, A) + supX - depth<sub>A</sub>R  
= ampR $\Gamma_{\overline{m}}(R)$  + supRHom<sub>A</sub>(X, A) + supX  
= ampA + supRHom<sub>A</sub>(X, A) + supX  
 $\ge$  ampA,

<span id="page-7-0"></span>which implies that G-dim<sub>A</sub> $X = \sup \text{RHom}_A(X, A) \geq -\sup X$ .

**Definition 3.5.** *A DG-module*  $X \in \mathcal{R}(A)$  *is said to be in the G-class G if either* G-dim<sub>A</sub> $X =$  $-\sup X$ , or  $X = 0$ , and we denote by  $\mathcal{G}_0$  the full subcategory of  $\mathcal G$  consisting of objects  $G$  such *that either* G-dim<sub>A</sub> $G = -\sup G = 0$ *, or*  $G = 0$ *.* 

<span id="page-7-2"></span>**Remark 3.6.** (1) Let  $X \to Y \to Z \rightsquigarrow$  be an exact triangle in  $\mathcal{R}(A)$ . The exact triangle  $RHom_A(Z, A) \to RHom_A(Y, A) \to RHom_A(X, A) \rightsquigarrow$  yields that

 $G\text{-dim}_A Y \leq \max\{G\text{-dim}_A X, G\text{-dim}_A Z\}.$ 

(2) For  $0 \not\cong X \in \mathcal{R}(A)$  with amp $X \ge \text{amp}A$ , it follows from Corollary [3.4](#page-7-1) that G-dim<sub>A</sub>X =  $-\sup X$  if and only if  $X \in \mathcal{G}$  if and only if  $X \in \mathcal{G}_0[-\sup X]$ .

(3) For any  $i \in \mathbb{Z}$ , one has  $\mathcal{P}[i] \subseteq \mathcal{G}_0[i]$  by [\[23,](#page-17-3) Lemma 2.14].

(4) For any  $X \in \mathcal{R}(A)$  and  $n \in \mathbb{Z}$ , one has  $G\text{-dim}_AX[n] = G\text{-dim}_AX + n$ .

<span id="page-7-3"></span>We give several useful properties about sppj morphisms.

**Lemma 3.7.** *Let*  $0 \not\cong X \in \mathcal{R}(A)$  *with* amp  $X \geq \text{amp } A$  *and*  $f : P \rightarrow X$  *a sppj morphism with*  $Y = \text{cn}(f)[-1]$ *.* If G-dim<sub>A</sub>X + sup $X \geq 1$ *, then* G-dim<sub>A</sub>Y = G-dim<sub>A</sub>X - 1*.* 

*Proof.* By Proposition [3.1,](#page-6-3)  $Y \in \mathcal{R}(A)$ . Set  $n = G\text{-dim}_A X + \text{sup}X$  and  $g: Y \to P$  be the canonical morphism. We may assume that  $\sup X = 0$  by shifting the degree. Then  $n \geq 1$ .

Firstly, we need to prove  $\mathrm{H}^i(\mathrm{RHom}_A(Y,A) = 0$  for all  $i > n - 1$ . By assumption, we have  $H^{i}(\text{RHom}_{A}(X, A)) = 0$  for all  $i > n$  and  $H^{i}(\text{RHom}_{A}(P, A)) = 0$  for all  $i > 0$ . Then the following exact sequence

$$
H^{i}(\mathrm{RHom}_{A}(P,A)) \to H^{i}(\mathrm{RHom}_{A}(Y,A)) \to H^{i+1}(\mathrm{RHom}_{A}(X,A)) \to H^{i+1}(\mathrm{RHom}_{A}(P,A))
$$

yields that  $\mathrm{H}^i(\mathrm{RHom}_A(Y,A))=0$  for all  $i>n-1$ . Next, since  $\mathrm{H}^n(\mathrm{RHom}_A(X,A))\neq 0$ , the exact sequence  $H^{n-1}(\mathrm{RHom}_A(Y,A)) \to H^n(\mathrm{RHom}_A(X,A)) \to 0$  implies that  $H^{n-1}(\mathrm{RHom}_A(Y,A)) \neq$ 0. Thus G-dim<sub>A</sub> $Y = n - 1$ .

<span id="page-8-0"></span>**Lemma 3.8.** *Let*  $0 \neq X \in \mathcal{G}$  *with* amp $X \geq \text{ampA}$ *. Then there exists a sppj morphism*  $f : P \rightarrow$ X such that the cocone  $Y = \text{cn}(f)[-1]$  *is in*  $\mathcal{G}_0[-\text{sup}X]$ .

*Proof.* Let  $f: P \to X$  be a sppj morphism with  $P \in \mathcal{P}[-\text{sup}X]$ . One has an exact triangle  $Y \to Y$  $P \to X \rightsquigarrow$ . By [\[23,](#page-17-3) Lemma 2.14] and [\[30,](#page-17-11) Proposition 4.4(3)], we have G-dim<sub>A</sub> $P = -\sup X$ . If  $\text{ampY} \ge \text{ampA}, \text{then } Y \in \mathcal{G}_0[-\text{sup}X] \text{ since } \text{sup}Y \le \text{sup}X \text{ by Remark 3.6(2). If } \text{ampY} < \text{ampA},$  $\text{ampY} \ge \text{ampA}, \text{then } Y \in \mathcal{G}_0[-\text{sup}X] \text{ since } \text{sup}Y \le \text{sup}X \text{ by Remark 3.6(2). If } \text{ampY} < \text{ampA},$  $\text{ampY} \ge \text{ampA}, \text{then } Y \in \mathcal{G}_0[-\text{sup}X] \text{ since } \text{sup}Y \le \text{sup}X \text{ by Remark 3.6(2). If } \text{ampY} < \text{ampA},$ then  $Y \oplus P \to P \oplus P \to X \rightsquigarrow$  is an exact triangle with  $(f, 0) : P \oplus P \to X$  a sppj morphism and  $\text{amp}(Y \oplus P) \ge \text{amp}A$  by Lemma [3.3,](#page-6-1) as required.

<span id="page-8-2"></span>**Lemma 3.9.** *Let*  $0 \not\cong X \in \mathcal{G}$  *with* amp $X \ge \text{amp}A$ *. Then there exists a morphism*  $f : X \to P$ *such that*  $Y = cn(f) \in \mathcal{G}_0[-sup X]$ .

*Proof.* By Lemma [3.8,](#page-8-0) there exists a sppj morphism  $g : P \to \mathrm{RHom}_A(X, A)$  such that  $P \in$  $\mathcal{P}[-\text{supRHom}_{A}(X, A)]$  and  $\text{amp}(\text{cn}(g)[-1]) \ge \text{amp}A$ , so we have a morphism

$$
g^*: X \simeq \text{RHom}_A(\text{RHom}_A(X, A), A) \to \text{RHom}_A(P, A)
$$

and an exact triangle  $X \to \mathrm{RHom}_A(P, A) \to Y \to$ . As  $\mathrm{RHom}_A(P, A) \in \mathcal{P}[-\mathrm{sup}X]$ , it fol-lows from Corollary [3.4](#page-7-1) that  $Y \in \mathcal{R}(A)$  and amp $Y \ge \text{amp}A$ . We need to show that  $Y \in$  $\mathcal{G}_0[-\text{sup}X]$ . Since  $H^{-\text{sup}X}(g)$  is surjective,  $G\text{-dim}_AY = \text{supRHom}_A(Y, A) \leq \text{supRHom}_A(X, A) =$ G-dim<sub>A</sub>X =  $-\sup X$ . If G-dim<sub>A</sub>Y + supY ≥ 1, then supX  $\leq \sup Y - 1$ , and so H<sup>supY</sup>(Y) = 0, this is a contradiction. Therefore,  $Y \in \mathcal{G}_0[-\text{sup}X]$ .

With the above preparations, now we prove Theorem [1.2.](#page-2-0)

**Proof of Theorem [1.2.](#page-2-0)** (1) Let X be a DG-module in  $D_f^b(A)$  with amp $X \ge \text{ampA}$  and n a natural number. Then  $(ii) \implies (iii)$  is clear and  $(iii) \implies (i)$  holds by the definition.

To show  $(i) \Longrightarrow (ii)$ , we assume that  $P_{\bullet}$  is a sppj resolution of X and  $X_{i+1} \stackrel{g_{i+1}}{\to} P_i \stackrel{f_i}{\to} X_i \leadsto$  are the corresponding exact triangles such that  $f_i$  is a sppj morphism and  $\text{amp}X_i \ge \text{amp}A$  for  $i \ge 0$ with  $X_0 := X$ . If G-dim<sub>A</sub> $X_{i-1}$  + sup $X_{i-1} > 0$  for all  $i \ge 1$ , then G-dim<sub>A</sub> $X_{j-1}$  + sup $X_{j-1} > 0$ and G-dim<sub>A</sub> $X_j = G$ -dim<sub>A</sub> $X_{j-1} - 1$  for  $j \leq i$  by Lemma [3.7,](#page-7-3) which implies

## $G\text{-dim}_AX_i + i = G\text{-dim}_AX.$

Since sup  $X_i \le \sup X$ , it follows that the set  $\{i \ge 1 | G\text{-dim}_A X_{i-1} + \sup X_{i-1} > 0\}$  is finite. Set  $e := \max\{i \geq 1 | G - \dim_A X_{i-1} + \sup X_{i-1} > 0\}.$  Then  $e \leq n$  and  $X_e \in \mathcal{G}_0[-\sup X]$ , it follows from Lemma [3.8](#page-8-0) that  $X_n \in \mathcal{G}_0[-\text{sup}X]$ .

<span id="page-8-1"></span>To verify the equivalence of  $(i)$  and  $(iv)$ , it suffices to show

$$
(3.1) \quad \text{G-dim}_A X = \min\{n | X \in \mathcal{G}_0[-\text{sup}X] * \mathcal{P}[-\text{sup}X + 1] * \cdots * \mathcal{P}[-\text{sup}X + n]\} - \text{sup}X.
$$

If G-dim<sub>A</sub>X =  $-\sup X$ , then the formula [\(3.1\)](#page-8-1) holds by Lemma [3.9.](#page-8-2) We only need to prove the formula [\(3.1\)](#page-8-1) provided that G-dim<sub>A</sub> $X > -\text{sup}X$ .

By Lemma [3.8,](#page-8-0) there is a sppj morphism  $f : P \to \mathrm{RHom}_A(X, A)$  so that  $\mathrm{amp}(\mathrm{cn}(f)[-1]) \ge$ ampA and  $P \in \mathcal{P}[-\text{supRHom}_{A}(X, A)]$ , so we have a morphism

$$
f^*: X \simeq \text{RHom}_A(\text{RHom}_A(X, A), A) \to \text{RHom}_A(P, A)
$$

with  $P^* := \text{RHom}_A(P, A) \in \mathcal{P}[\text{supRHom}_A(X, A)].$  Consider the exact triangle  $Y \to X \to P^* \rightsquigarrow$ , which induces the exact triangle

(3.2) 
$$
\text{RHom}_A(Y, A)[-1] \to P \to \text{RHom}_A(X, A) \to \text{RHom}_A(Y, A)
$$

and  $Y \in \mathcal{R}(A)$  with amp $Y \ge \text{ampA}$  by Corollary [3.4.](#page-7-1) As  $\text{sup}P^* = -\text{supRHom}_A(X, A) =$  $\sup X - n < \sup X$ , one has  $\sup Y = \sup X$ . Since  $H^{\sup RHom_A(X,A)}(f)$  is surjective, it follows by the triangle [\(3.2\)](#page-9-3) that

 $G\text{-dim}_A Y = \text{supRHom}_A(Y, A) \leq \text{supRHom}_A(X, A) - 1 = G\text{-dim}_A X - 1 = n - 1 - \text{sup} Y.$ 

Now by induction and Lemma [3.9,](#page-8-2) one can obtain the desired formula.

(2) Set  $\bar{X} = X \oplus X$  [ampA-ampX]. Then  $\bar{X} \in D_f^b(A)$  with amp $\bar{X} = \text{amp}A$  and sup  $\bar{X} = \text{sup}X$ . As  $\text{G-dim}_AX + (\text{amp}A - \text{amp}X) = \text{G-dim}_A\overline{X}$ , the statement follows from (1).

(3) Evidently, *(iii)* is stronger than *(ii)*, so it is sufficient to prove that *(i)* implies *(iii)* and  $(ii)$  implies  $(i)$ .

 $(i) \Rightarrow (iii)$  As A is local Gorenstein, injdim<sub>A</sub>A <  $\infty$  and supRHom<sub>A</sub> $(X, A) \leq$  injdim<sub>A</sub>A – infX, it follows that  $\text{RHom}_A(X, A) \in D_f^b(A)$  and  $X \in \mathcal{R}(A)$  for any  $X \in D_f^b(A)$ . Consequently, for any  $X \in D_f^b(A)$ , we have G-dim<sub>A</sub>X + inf $X \leq \text{injdim}_A A$ , as desired.

<span id="page-9-0"></span> $(ii) \Rightarrow (i)$  Assume that G-dim<sub>A</sub> $\bar{k} < \infty$ . Then supRHom<sub>A</sub> $(\bar{k}, A) < \infty$ . Hence [\[30,](#page-17-11) Proposition 4.2 and Theorem 4.7 implies that  $\text{injdim}_A A < \infty$  and A is local Gorenstein.

## 4. Applications

In this section, we will apply Theorem [1.2](#page-2-0) to establish the connection between G-dimensions and the little finitistic dimensions of  $A$ , to examine the DG version of the Fact [1.4,](#page-3-1) and to establish a DG-version of Buchwtweiz-Happel Theorem and its inverse.

<span id="page-9-1"></span>4.1. Relations between G-dimensions and the little finitistic dimensions. In this sub-section we will apply Theorem [1.2](#page-2-0) to show that the little finitistic dimension  $fpd(A)$  can be computed by G-dimension of DG-modules in  $D_f^b(A)$ .

Yekutieli [\[32\]](#page-17-12) introduced a DG-version of projective dimension,  $pdM$ , for a DG-module M over a DG-algebra which are different from the definition projdim<sub>A</sub>M in Definition [2.1.](#page-5-0) By [\[23,](#page-17-3) Theorems 2.22 and 3.21], one has  $projdim_A M = pdM - supM$ .

<span id="page-9-2"></span>**Proposition 4.1.** *Let*  $0 \not\cong X \in D_f^b(A)$ *. One has* 

 $G$ -dim<sub>A</sub> $X \le$  projdim<sub>A</sub> $X$ ,

*and equality holds if*  $projdim_A X < \infty$ *.* 

*Proof.* The inequality is trivial if X is of infinite projective dimension. Next, assume that  $n = \text{projdim}_A X + \text{sup} X < \infty$ . It follows from [\[23,](#page-17-3) Proposition 2.26] that  $X \in \mathcal{P}[-\text{sup} X]$  \*  $\mathcal{P}[-\text{sup}X + 1] * \cdots * \mathcal{P}[-\text{sup}X + n]$ . Hence G-dim<sub>A</sub> $X \leq n - \text{sup}X$  by Theorem [1.2\(](#page-2-0)1) and Lemma [3.3.](#page-6-1) This yields that  $G\text{-dim}_AX \leq \text{projdim}_AX$ . For the last part, we can choose a finitely generated  $H^0(A)$ -module T such that  $projdim_A X = supRHom_A(X,T)$  by [\[23,](#page-17-3) Theorem 2.22]. The desired equality now follows from the next calculation,

$$
\begin{aligned} \text{projdim}_{A} X &= \text{supRHom}_{A}(X, T) \\ &= \text{sup}(\text{RHom}_{A}(X, A) \otimes_{A}^{\mathbf{L}} T) \\ &= \text{supRHom}_{A}(X, A) \\ &= \text{G-dim}_{A} X. \end{aligned}
$$

where the second equality is by [\[9,](#page-16-11) Proposition 1.16], the third one is by Nakayama's lemma.  $\square$ 

<span id="page-10-0"></span>The next lemma is an immediate consequence of Theorem [1.2\(](#page-2-0)1).

**Lemma 4.2.** Let X be in  $D_f^b(A)$  with  $\text{amp}X \ge \text{amp}A$ . If  $G$ - $\dim_A X = n$ , then there exists an *exact triangle*

$$
G \to X \to K \leadsto,
$$

*such that*  $G \in \mathcal{G}_0[-\sup X]$  *and*  $\operatorname{projdim}_A K = n-1$ *. For*  $n = -\sup X$ *, we understand that*  $K = 0$ *.* 

The next result conveys that G-dimensions and the little finitistic dimensions are closely related to each other, which contains Corollary [1.3](#page-3-0) in the introduction.

**Theorem 4.3.** Let X be an object in  $D_f^b(A)$  with  $\text{amp}X \ge \text{amp}A$ . If  $G\text{-dim}_AX = n < \infty$ , then *there is a DG-module*  $Y \in D_f^b(A)$  *with*  $projdim_A Y = n$ *. In particular, one has* 

 $\text{fpd}A = \sup\{G\text{-dim}_AX + \text{inf}X \mid X \in D_f^b(A) \text{ with } \text{amp}X \ge \text{amp}A, G\text{-dim}_AX < \infty\}.$ 

*Proof.* We may assume that  $n > -\sup X$ . By Lemma [4.2,](#page-10-0) there exists an exact triangle  $G \rightarrow$  $X \to K \rightsquigarrow$  with projdim<sub>A</sub> $K = n - 1$  and  $G \in \mathcal{G}_0[-\text{sup}X]$ , and there is an exact triangle  $G \to P \to G' \rightsquigarrow$  with  $P \in \mathcal{P}[-\text{sup}G]$  and  $G' \in \mathcal{G}_0[-\text{sup}G]$  by Lemma [3.9.](#page-8-2) Thus we get a commutative diagram of exact triangles:



The exact triangle  $\text{RHom}_A(G', A) \to \text{RHom}_A(Y, A) \to \text{RHom}_A(X, A) \rightsquigarrow$  yields that  $G$ -dim<sub>A</sub>Y = n. Note that sup  $X = \sup Y$ , so  $Y \notin \mathcal{G}_0[-\sup X]$ . As  $\sup K \leq \sup X - 1$ ,  $P \to Y$  is a sppj morphism, it follows by the exact triangle  $P \to Y \to K \rightsquigarrow$  and Proposition [4.1](#page-9-2) that  $\text{projdim}_A Y = n$ . Hence we have shown the first statement. This yields that  $fpd(A) > \sup\{G\text{-dim}_AX + \inf X | X \in$  $D_f^b(A)$  with  $\text{amp}X \ge \text{amp}A$ , G-dim<sub>A</sub>X <  $\infty$ . Also for any  $Z \in D_f^b(A)$  with  $\text{projdim}_A Z < \infty$ , one has  $G\text{-dim}_A Z \ge \text{projdim}_A Z$ . Thus the last statement follows.

<span id="page-11-0"></span>4.2. Comparison to maximal local-Cohen-Macaulay DG-modules. The task of this subsection is to examine the DG version of Fact [1.4.](#page-3-1) We begin with the following AB formula for G-dimension of DG-modules.

<span id="page-11-1"></span>Theorem 4.4. (AB Formula) *Let* X *be a DG-module of finite G-dimension. One has an equality*  $G$ -dim<sub>A</sub>X = depthA – depth<sub>A</sub>X.

*Proof.* Since G-dim<sub>A</sub> $X < \infty$ , we have the following equalities

$$
depth_A X = depthRHom_A(RHom_A(X, A), A)
$$
  
= 
$$
-supRHom_A(X, A) + depthA
$$
  
= 
$$
-G\text{-dim}_A X + depthA,
$$

where the second equality is by [\[30,](#page-17-11) Proposition 4.9] and Nakayama's lemma, as required.  $\square$ 

Following [\[28\]](#page-17-5), if  $X \in D_f^b(A)$  then we set

$$
\mathrm{seq}.depth_A X = \mathrm{depth}_A X - \mathrm{inf} X,
$$

<span id="page-11-2"></span>and call it the *sequential depth* of X.

Corollary 4.5. *Let* X *be a DG-module of finite G-dimension with* ampX = ampA*. One has*  $G$ -dim<sub>A</sub>X + supX = seq.depthA – seq.depth<sub>A</sub>X.

*Proof.* One has the following equalities

$$
G\text{-dim}_{A}X + \sup X = \text{depth}A - \text{depth}_{A}X + \sup X
$$

$$
= \text{depth}A - \inf A - (\text{depth}_{A}X - \inf X)
$$

$$
= \text{seq}.\text{depth}A - \text{seq}.\text{depth}_{A}X,
$$

where the first one is by Theorem [4.4](#page-11-1) and the second one is by  $\text{amp}X = \text{amp}A$ .

We are now ready to prove Corollary [1.5.](#page-3-2)

**Proof of Corollary [1.5.](#page-3-2)** (1) The "only if" part holds by noting that  $A \in \mathcal{H}$  by [\[28,](#page-17-5) Theorem 4.1. For the "if" part, we assume that X is an object in H. It follows that lc.  $\dim_A A \geq$ lc.dim<sub>A</sub>X – sup $X \geq$  depth<sub>A</sub>X – infX. Since A is local Cohen-Macaulay, we have the following (in)equalities

$$
seq.depthAX \leq lc.dimAX - supX
$$

$$
\leq lc.dimA
$$

$$
= seq.depthA
$$

$$
= seq.depthAX,
$$

where the second equality follows from Corollary [4.5,](#page-11-2) which implies that  $\mathrm{ampR} \Gamma_{\bar{m}} X = \mathrm{amp} A =$ ampX and  $\text{lc.dim}_AX = \text{dimH}^0(A) + \text{sup}X$ . Thus  $X \in \mathcal{M}$ .

(2) For the "only if" part, since A is local Gorentein, it follows from [\[27,](#page-17-10) Theorem 7.26] that  $X \simeq \text{RHom}_A(\text{RHom}_A(X, A), A)$  and  $\text{ampR}\Gamma_{\bar{\mathfrak{m}}}X = \text{ampRHom}_A(X, A)$  for any  $X \in D_f^b(A)$ . Let  $X \in \mathcal{M}$ . Then ampRHom<sub>A</sub> $(X, A) = \text{amp}A$ , it follows by Corollary [4.5](#page-11-2) that

$$
G\text{-dim}_AX + \sup X = \text{seq.depth}A - \text{seq.depth}_AX = 0.
$$

Thus  $X \in \mathcal{H}$  and  $\mathcal{H} = \mathcal{M}$  by (1).

For the "if" part, we assume that  $\mathcal{H} = \mathcal{M}$ . Then A is local-Cohen-Macaulay by (1). Consider the sppj resolution  $P^{\bullet}$  of  $k := \bar{k} \oplus \bar{k}[-\text{inf}A]$ 

$$
k_d \to P_{d-1} \to \cdots P_1 \to P_0 \to k.
$$

By the construction of the sppj resolution, we have  $\sup k_d \leq 0$  and  $\inf k_d \geq \inf A + \sup k_d$ . We also have lc.dim<sub>A</sub> $k_d \leq d + \sup k_d$  and

$$
\begin{aligned} \n\text{depth}_A k_d &\ge \min\{\text{depth}_A P_{d-1}[-\text{sup}k_{d-1}], \text{depth}_A k_{d-1} + 1\} \\ \n&\ge \min\{\text{depth}_A P_{d-1}[-\text{sup}k_{d-1}], \cdots, \text{depth}_A P_0 + d - 1, d + \inf A\} \\ \n&\ge d + \inf A + \text{sup}k_d. \n\end{aligned}
$$

Set  $G = A[-\text{sup }k_d] \oplus k_d$ . Then  $\text{lc.dim}_A G = d + \text{sup }k_d$  and  $\text{depth}_A G = d + \text{inf }A + \text{sup }k_d$ , that is to say,  $G \in \mathcal{M} = \mathcal{H}$  and k han an sppj resolution

$$
G \to A[-\mathrm{sup}k_d] \oplus P_{d-1} \to \cdots P_1 \to P_0 \to k.
$$

<span id="page-12-0"></span>Thus, G-dim<sub>A</sub> $k < \infty$  by Theorem [1.2\(](#page-2-0)1) and hence A is Gorenstein.

4.3. Buchwtweiz-Happel Theory and its inverse. In this subsection we will employ Theorem [1.2](#page-2-0) to prove Corollary [1.6](#page-4-1) in the introduction.

Let T be a triangulated category and  $\mathcal{D} \subset \mathcal{C}$  be subcategories in T. As usual, we denote by  $\langle \mathcal{D} \rangle$ the smallest thick triangulated subcategory containing  $\mathcal{D}$ , and denote by  $\mathcal{C}/\langle \mathcal{D} \rangle$  the Verdier's quotient triangulated category. In fact,  $\langle \mathcal{P} \rangle$  is the thick subcategory of the derived category  $D^b(A)$  generated by A. We call the Verdier quotient  $D_{sg}(A) := D_f^b(A)/\langle P \rangle$  the *singularity category* of A. Each morphism  $f: X \to Y$  in  $D_{sg}(A)$  is given by an equivalence class of left fractions  $s \setminus f$  as presented by  $s \setminus f : X \longrightarrow Z \iff Y$ , where the doubled arrow means s lies in the compatible saturated multiplicative system corresponding to  $\langle \mathcal{P} \rangle$ .

In the following, we set

$$
A[<0]^{\perp_f} = \{ X \in \mathcal{R}(A) | \text{Hom}_{D(A)}(A[<0], X) = 0 \};
$$
  

$$
\perp_f A[>0] = \{ X \in \mathcal{R}(A) | \text{Hom}_{D(A)}(X, A[>0]) = 0 \}.
$$

Recall from Corollary [1.5](#page-3-2) that

$$
\mathcal{H} = \{ X \in \mathcal{G} | \text{ampRT}_{\bar{\mathfrak{m}}} X \ge \text{amp} X = \text{amp} A \}.
$$

<span id="page-12-1"></span>**Lemma 4.6.** *Let*  $X \in \mathcal{R}(A)$ *. Assume that* 

$$
\mathrm{ampR}\Gamma_{\bar{\mathfrak{m}}}X \ge \mathrm{amp}X \ge \mathrm{amp}A.
$$

*Then*  $X \in \mathcal{H}$  *if and only if* sup  $X$ [sup  $X$ ]  $\leq 0$  *and* G-dim<sub>A</sub>X[sup  $X$ ]  $\leq 0$ *, if and only if*  $X$ [sup  $X$ ]  $\in$  $\perp f A[> 0] \cap A[< 0]^{\perp f}.$ 

*Proof.* We will start by proving the first equivalence. Let  $X \in \mathcal{H}$ . Since  $X \in \mathcal{G}$ , G-dim<sub>A</sub>X =  $-\sup X$ . Therefore G-dim<sub>A</sub>X[sup X] = G-dim<sub>A</sub>X + sup X = 0. sup X[sup X]  $\leq 0$  is obvious. Conversely, suppose sup  $X[\sup X] \leq 0$  and  $G\text{-dim}_AX[\sup X] \leq 0$ . Then  $G\text{-dim}_AX \leq -\sup X$ as G-dim<sub>A</sub>X[sup X] = G-dim<sub>A</sub>X + sup X. By Corollary [3.4,](#page-7-1) we have G-dim<sub>A</sub>X  $\geq$  - sup X.

It follows that  $X \in \mathcal{G}$ . In order to show  $X \in \mathcal{H}$ , it suffices to show amp  $X \le \text{amp}A$ . Since  $X[\sup X] \in \mathcal{R}(A)$ , by [\[9,](#page-16-11) Proposition 1.2], we have

 $\inf(X[\sup X]) = \inf \text{RHom}_A(\text{RHom}_A(X[\sup X], A), A) \ge -\sup \text{RHom}_A(X[\sup X], A) + \inf(A).$ 

Then

$$
0 \geq G \cdot \dim_A X[\sup X] = \sup(\text{RHom}_A(X[\sup X], A)) \geq \inf(A) - \inf(X[\sup X]).
$$

It follows that  $-\inf(A) \ge -\inf(X[\sup X])$ . On the other hand, since sup  $A = 0$  and  $0 \ge$  $\sup X[\sup X]$ , we have  $\sup A = -\inf(A) > \sup X[\sup X] - \inf(X[\sup X]) = \sup X[\sup X] =$  $ampX$ , as desired.

The second equivalence follows by the equalities  $\perp f A$   $[>0] = \{X \in \mathcal{R}(A) | H^i(RHom_A(X, A)) =$ 0 for  $i > 0$ } and  $A[ \leq 0]^{\perp_f} = \{ X \in \mathcal{R}(A) | H^i(RHom_A(A, X)) = 0$  for  $i > 0 \} = \{ X \in$  $\mathcal{R}(A)|\mathrm{H}^{i}(X)=0$  for  $i>0$ .

<span id="page-13-0"></span>In the following, we set  $\mathcal{A} = {}^{\perp_f}A[>0] \cap A[<0]^{\perp_f}$ .

**Remark 4.7.** Let A be a non-positive DG-algebra over a field k satisfying the following conditions:

- (i) A is proper, i.e.,  $\dim_k \bigoplus_{i \in \mathbb{Z}} H^i(A) < \infty;$
- (ii) A is Gorenstein, i.e., the thick subcategory per A of the derived category  $D(A)$  generated by A coincides with the thick subcategory generated by DA, where  $D = \text{Hom}_k(-, k)$  is the k-dual.

Assume that A is a proper Gorenstein DG-algebra. Recently, Jin defined that a DG-A-module  $X \in D^b(A)$  is called *Cohen-Macaulay* if sup  $M \leq 0$  and  $\text{Hom}_{D^b(A)}(M, A[i]) = 0$  for all  $i > 0$  (see [\[20,](#page-17-8) Definition 2.1]). If A is an ordinary Gorenstein algebra, then Cohen-Macaulay DG-modules defined by Jin is canonically equivalent to the usual (maximal) Cohen-Macaulay modules. Note that if a DG-module X belongs to  $\mathcal{R}(A)$ , then  $X \in \mathcal{A}$  if and only if it is Cohen-Macaulay defined by Jin in the sense of [\[20\]](#page-17-8).

On the other hand, from Corollary [1.5](#page-3-2) we know that  $H$  is equal to the class of maximal local-Cohen-Macaulay DG-modules defined by Shaul [\[28\]](#page-17-5) over local Gorenstein DG-rings, see Definition [2.3.](#page-5-1) These two definitions are completely different at first glance. For example, one can see that the class of maximal local-Cohen-Macaulay DG-modules defined by Shaul is closed under suspensions, but the class of Cohen-Macaulay DG-modules defined by Jin is not. Fortunately, by Lemma [4.6,](#page-12-1) these two definitions are the same over commutative local Gorenstein DG-algebra over a field k under the condition that  $\text{ampR}\Gamma_{\bar{\mathfrak{m}}}X \ge \text{amp}X \ge \text{amp}A$  for all  $X \in \mathcal{R}(A)$ . This condition, are natural and very often met. For example, this holds for any module X over a commutative noetherian local ring  $A$ .

Lemma 4.8. *The subcategory* R(A) *is thick and it is the smallest triangulated subcategory of*  $D_f^b(A)$  *that contains the objects from* A.

*Proof.* Obviously,  $\mathcal{R}(A)$  is closed under shifts and isomorphisms. Assume that  $X \in \mathcal{R}(A)$  and X' is a direct summand of X. There exits two split triangles  $X' \stackrel{u}{\to} X \stackrel{v}{\to} X'' \stackrel{0}{\to} X'[1]$  and  $X'' \stackrel{p}{\to} X''$   $X \stackrel{q}{\rightarrow} X' \stackrel{0}{\rightarrow} X''[1]$  in  $D_f^b(A)$ . For simplicity, we write  $((-, A), A)$  for RHom<sub>A</sub>(RHom<sub>A</sub> $(-, A), A$ ). Then we have the following commutative diagrams:

$$
(4.1)
$$
\n
$$
X' \xrightarrow{\begin{array}{c}\n u \longrightarrow X \longrightarrow Y'' \longrightarrow X'' \longrightarrow X'[1] \\
\delta^{X'} \downarrow \qquad \delta^{X'} \downarrow \qquad \delta^{X''} \downarrow \qquad \delta^{X'}[1] \downarrow \qquad \delta^{X''} \downarrow \qquad \delta^{X''}[1] \down
$$

<span id="page-14-1"></span>Since u is a split monomorphism and  $\delta^X$  is an isomorphism, it is straightforward to check that  $\delta^{X'}$  is a split monomorphism by the commutative diagram [\(4.1\)](#page-14-0). On the other hand, it follows from the commutativity of the diagram [\(4.2\)](#page-14-1) that  $\delta^{X'}q$  is an epimorphism, which implies that  $\delta^{X'}$  is also an epimorphism. Thus,  $\delta^{X'}$  is an isomorphism and X' belongs to  $\mathcal{R}(A)$ , and therefore  $\mathcal{R}(A)$  is a thick subcategory of  $D_f^b(A)$  by Proposition [3.1.](#page-6-3)

Recall that  $\langle A \rangle$  is the smallest thick triangulated subcategory of  $D_f^b(A)$  that contains the objects from A. Since  $A \subseteq \mathcal{R}(A)$ , it follows that  $\langle A \rangle \subseteq \mathcal{R}(A)$ . For the reverse containment, we assume that X is a non-zero object in  $\mathcal{R}(A)$ . Note that  $\mathcal{R}(A)$  is precisely the subcategory of DGmodules with finite G-dimension. If amp  $X \ge \text{ampA}$ , applying Theorem [1.2\(](#page-2-0)1), there exists a natural number n such that X belongs to  $\mathcal{G}_0[-\sup X]*\mathcal{P}[-\sup X+1]*\cdots *\mathcal{P}[-\sup X+n]$ . By the fact that  $P \subseteq \mathcal{G}_0 \subseteq \mathcal{A}$ , we deduce that X belongs to  $\langle \mathcal{A} \rangle$ . If ampX  $\langle \mathcal{A} \rangle$  applying Theorem [1.2\(](#page-2-0)2), then  $X \oplus X$ [amp $A-\text{amp}X$ ] belongs to  $\mathcal{P}[-\text{sup}X]*\cdots *\mathcal{P}[-\text{sup}X+n-1]*\mathcal{G}_0[-\text{sup}X+n]$ for some n. Similarly, since  $\langle A \rangle$  is thick, one has  $X \in \langle A \rangle$ . Altogether, we have  $\mathcal{R}(A) = \langle A \rangle$ .  $\Box$ 

Let T be a triangulated category. Recall that a subcategory  $\omega \subseteq \mathcal{T}$  is called *presilting* if  $\text{Hom}_{\mathcal{T}}(M, M'[i]) = 0$  for all  $M, M' \in \omega$  and  $i > 0$ . Let  $\mathcal E$  be an arbitrary category. A full additive subcategory  $M \subseteq \mathcal{E}$  is called *contravariantly finite*, if every object X in  $\mathcal{E}$  admits a right M-approximation, i.e. there exists an object  $M \in \mathcal{M}$  and a morphism  $f : M \to X$ , such that the induced map  $\text{Hom}_{\mathcal{E}}(N, M) \to \text{Hom}_{\mathcal{E}}(N, X)$  is surjective for all  $N \in \mathcal{M}$ . Dually, we define the notion of a *covariantly finite* subcategory. We say that M is *functorially finite* if it is both covariantly and contravariantly finite.

<span id="page-14-2"></span>Lemma 4.9. *The following statement hold.*

- (1) A is closed under extensions and direct summands and finite direct sums in  $\mathcal{R}(A)$ .
- (2) The subcategory  $\mathcal{P} =$  add A *is presilting and functorially finite in*  $\mathcal{R}(A)$ *.*
- (3) For any  $X \in \mathcal{R}(A)$ ,  $\text{Hom}_{D(A)}(X, N[i]) = 0 = \text{Hom}_{D(A)}(N, X[i])$  for any  $N \in \mathcal{P}$  and  $i \gg 0$ .

*Proof.* (1) Since  $A = A \leq 0$ <sup> $\perp$ f</sup>  $\cap \perp$ <sup>f</sup> $A$ [> 0], one can check that all objects in A is closed under extensions and direct summands and finite direct sums in  $\mathcal{R}(A)$ .

(2) The subcategory  $\mathcal P$  is presilting follows from the fact that A is a non-positive DG-ring. Note that for any  $N \in \mathcal{R}(A)$ , the set of the generators of  $\text{Hom}_{D(A)}(A, N) \cong H^0(N)$  is finite. If

 $f_1, \dots, f_s$  are generators of  $\text{Hom}_{D(A)}(A, N)$ , then the canonical homomorphism  $f: A^{(s)} \to N$ given by  $(f_1, \dots, f_s)$  is a right addA-approximation. On the other hand, since RHom<sub>A</sub> $(X, A) \in$  $D_f^b(A)$  for any  $X \in \mathcal{R}(A)$ , the set  $Hom_{D(A)}(X, A)$  also has finite generators. So the left add Aapproximation can be constructed by a similar way. Therefore,  $\mathcal P$  is functorially finite in  $\mathcal R(A)$ . (3) It is obvious.  $\square$ 

Following  $[35]$ , we denote by  $[\mathcal{D}]$  the ideal of morphisms in C which factor through objects in D. The stable category of C by D is the quotient category  $\mathcal{C}/[\mathcal{D}]$ , for which objects are the same as  $\mathcal{C}$ , but morphisms are morphisms in  $\mathcal{C}$  modulo those in  $[\mathcal{D}].$ 

We have the following results, which are analogues of well-known properties of Cohen-Macaulay modules.

<span id="page-15-0"></span>**Theorem 4.10.** *(1) The stable category*  $\underline{A} := \mathcal{A}/|\mathcal{P}|$  *is a triangulated category*; *(2) The composition*  $A \hookrightarrow \mathcal{R}(A) \rightarrow \mathcal{R}(A)/\langle \mathcal{P} \rangle$  *induces a triangle equivalence* 

$$
H: \underline{\mathcal{A}} \simeq \mathcal{R}(A)/\langle \mathcal{P} \rangle.
$$

(3)  $\mathcal{R}(A) = D_f^b(A)$  *if and only if* A *is a local Gorenstein DG-ring.* 

*Proof.* (1) By Lemma [4.9\(](#page-14-2)2), we know that  $P$  is presilting and functorially finite in  $\mathcal{R}(A)$ . Then the result follows from the proof of [\[35,](#page-17-13) Corollary 2.7] and [\[35,](#page-17-13) Proposition 2.4(3)].

(2) Since  $\mathcal{P} \subseteq \mathcal{R}(A)$  and  $\mathcal{R}(A)$  is a triangulated full subcategory of  $D_f^b(A)$ , we have  $\langle \mathcal{P} \rangle \subseteq$  $\mathcal{R}(A)$ . Thanks to [\[35,](#page-17-13) Corollary 2.7] or [\[19,](#page-16-18) Theorem 1.1], by Lemma [4.9,](#page-14-2) there is a triangle equivalence between  $\underline{\mathcal{A}}$  and the singularity category  $D_f^b(A)/\langle \mathcal{P} \rangle$ .

(3) This follows from Theorem [1.2\(](#page-2-0)3).

Let G be the obvious composite functor  $\mathcal{A} \to D_f^b(A) \to D_f^b(A)/\langle \mathcal{P} \rangle$ . Since  $G(\mathcal{P}) = 0$ , there is a unique factorization of G through the canonical projection  $S : A \rightarrow \underline{A}$ . We denote by F the factorization from  $\underline{A}$  to  $D_f^b(A)/\langle \mathcal{P} \rangle$ . Then  $G = F \circ S$ . In fact, F is the composite functor  $\underline{A} \stackrel{H}{\to} \mathcal{R}(A)/\langle \mathcal{P} \rangle \hookrightarrow D_f^{\rm b}(A)/\langle \mathcal{P} \rangle$ . Let A be a local Gorenstein DG-ring. By Theorem [4.10\(](#page-15-0)3), we obtain a triangle equivalence:  $F: \underline{\mathcal{A}} \simeq D_f^b(A)/\langle \mathcal{P} \rangle$ .

We are now ready to prove Corollary [1.6.](#page-4-1)

**Proof of Corollary [1.6.](#page-4-1)** By Theorem [4.10,](#page-15-0) it suffices to show that if the functor  $F : \underline{\mathcal{A}} \to$  $D_f^b(A)/\langle P \rangle$  is dense, then A is a local Gorenstein DG-ring. Assume that  $F: \underline{\mathcal{A}} \to D_f^b(A)/\langle P \rangle$ is dense, and let M be any DG-module in  $D_f^b(A)$ . It follows that  $M \cong F(G)$  in  $D_f^b(A)$  for some  $G \in \mathcal{A}$ . Let  $s \setminus f : M \longrightarrow Z \stackrel{s}{\iff} G$  be an isomorphism in  $D_f^b(A)$  with  $cn(s) \in \langle \mathcal{P} \rangle$ , then cn(f)  $\in \langle \mathcal{P} \rangle$ . Consider the triangle  $G \stackrel{s}{\Longrightarrow} Z \longrightarrow$  cn(s)  $\leadsto$  in  $D_f^b(A)$ . We see that G and cn(s) lie in  $\mathcal{R}(A)$ , so  $Z \in \mathcal{R}(A)$ . It follows from  $Z \in \mathcal{R}(A)$  and  $cn(f) \in \mathcal{R}(A)$  that  $M \in \mathcal{R}(A)$ . Therefore the G-dimension of M is finite. Thus A is a local Gorenstein DG-ring by Theorem [1.2\(](#page-2-0)3).  $\Box$ 

Remark 4.11. If A is a local Gorenstein ring, then Corollary [1.6](#page-4-1) gives the classical Buchweitz-Happle Theorem and its inverse. As we stated in the Introduction, Jin [\[20\]](#page-17-8) proved that if A is a proper Gorenstein DG-algebra, then there is a triangle equivalence between the stable category of Cohen-Macaulay DG-modules (see Remark [4.7\)](#page-13-0) and the singularity category  $D^b(A)/\langle \mathcal{P} \rangle$ . This generalizes Buchweitz-Happle Theorem to the setting of proper Gorenstein DG-algebras

(see [\[20,](#page-17-8) Theorem 2.4]). In fact, over commutative local noetherian DG-algebras over a field k, condition (ii) of the proper Gorenstein DG-algebra is equivalent to injdim<sub>A</sub> $A < \infty$ . In this case, a Gorenstein ring in our setting is a proper Gorenstein DG-algebra defined in [\[20\]](#page-17-8). Therefore, over a commutative local noetherian non-positive DG algebra over  $k$ , Corollary [1.6](#page-4-1) shows that the inverse of Buchweitz-Happel Theorem is also true.
