THE DEGREE-THREE BOUNDED COHOMOLOGY OF COMPLEX LIE GROUPS OF CLASSICAL TYPE

ABSTRACT. We establish Monod's isomorphism conjecture in degree-three bounded cohomology for every complex simple Lie group of classical type. Our main ingredient is a bounded-cohomological stability theorem with an optimal range in degree three that we bootstrap from previous stability results by the author and Hartnick. The bootstrapping procedure relies on the occurrence in our setting of a variant of the recently observed phenomenon of secondary stability in the sense of Galatius–Kupers–Randal-Williams.

1. INTRODUCTION

1.1. **Statement of main result.** This article is the third one in a series concerned with the explicit computation of the continuous bounded cohomology of Lie groups via stabilization techniques (see prequels [11, 12]). The theory of continuous bounded cohomology was developed in the early 2000s by Burger and Monod [6, 28] as a topological refinement of the celebrated notion for discrete groups (conceived by Johnson, Trauber, and Gromov [19] independently), with powerful applications in geometry, dynamics and rigidity theory [8, 14, 28].

Despite its power, the computation of continuous bounded cohomology remains a notorious challenge. In the setting of Lie groups, the problem can be reduced to the connected semisimple case, whose behavior is predicted by the prominent

Isomorphism Conjecture. For any connected semisimple Lie group G with finite center, the comparison map c^* : $H^*_{h}(G) \to H^*(G)$ is an isomorphism in every degree.

Here we denote by $H^*(G)$ the continuous group cohomology of G with coefficients on the trivial G-module \mathbb{R} , and by $H^*_b(G)$ the corresponding continuous bounded cohomology. The comparison map c^* is defined by forgetting the boundedness of a class. The isomorphism conjecture was formulated in this form by Monod in his ICM address [27] in 2006. The surjectivity question, posed earlier by Dupont [9], has been answered affirmatively in a variety of contexts, e.g. [21, 25]. We emphasize that the continuous cohomology of Lie groups is well understood in virtue of the van Est isomorphism (see e.g. [2, Cor. XI.5.6] or [33]) and classical results on the cohomology of compact symmetric spaces (see e.g. [18, 26]).

Beyond the trivial degrees zero and one, the isomorphism conjecture has been established fully in degree two by Burger and Monod [5]. However, in degrees \geq 3, the conjecture has seen scarce progress in the last two decades. In degree three, it has been verified for the groups

 $SL_n(\mathbb{R})$ [7, 30] and $SL_n(\mathbb{C})$ [1, 30, 17, 3]. In higher degrees, our lack of understanding of the conjecture is remarkable, only known to hold in degree four for $SL_2(\mathbb{R})$ [20].

The goal of this paper is to expose further evidence in favor of the isomorphism conjecture.

Theorem 1. The isomorphism conjecture holds in degree three for every connected simple complex Lie group G of classical type. In particular, we have $H^3_b(G) \cong H^3(G) \cong \mathbb{R}$.

This statement encompasses the four classical complex families \mathbf{A}_r , \mathbf{B}_r , \mathbf{C}_r , \mathbf{D}_r , which consist of the connected Lie groups locally isomorphic to

(1.1)
$$\operatorname{SL}_{r+1}(\mathbb{C}), \quad \operatorname{SO}_{2r+1}(\mathbb{C}), \quad \operatorname{Sp}_{2r}(\mathbb{C}), \quad \operatorname{SO}_{2r}(\mathbb{C}).$$

respectively. In each case, *r* is the rank of the group, and all are simple Lie groups whenever $r \ge 1$, except for SO₂(\mathbb{C}) and SO₄(\mathbb{C}) (abelian and with two simple factors, respectively).

Non-vanishing results for the continuous bounded cohomology of Lie groups find important applications in the study of representations of fundamental groups of manifolds, and in particular, of their moduli spaces and deformations. The case of surface group representations with Hermitian targets, studied extensively in existing literature, serves as the most prominent example of this claim (see, e.g., [4]). The relevant cohomological input in this setting is the non-vanishing of H_h^2 for non-compact Lie groups of Hermitian type.

A bounded-cohomological approach has been also applied successfully in the study of 3manifold group representations into $PSL_n(\mathbb{C})$ —a group with non-vanishing H_b^3 —and has been instrumental in proofs of interesting rigidity phenomena (see, e.g., [3, 13]). It is our hope that Theorem 1 be the foundation of future investigations of representation varieties of 3-manifold groups into more general complex Lie groups.

1.2. The role of bounded-cohomological stability. Each of the four sequences of groups indexed by r and listed in (1.1) can be organized as increasing chains of inclusions

$$S_0 \stackrel{l_0}{\hookrightarrow} S_1 \stackrel{l_1}{\hookrightarrow} S_2 \stackrel{l_2}{\hookrightarrow} \cdots \hookrightarrow S_r \stackrel{l_r}{\hookrightarrow} S_{r+1} \hookrightarrow \cdots$$

where S_r is the group of rank r and the inclusions ι_r are block embeddings in appropriate bases. The following theorem concerning the degree-three continuous bounded cohomology of the groups in these families plays a key role in the proof of Theorem 1.

Theorem 2. The embeddings ι_r in each of the classical families induce the isomorphisms

The property that the embeddings i_r in a chain of inclusions as (1.2) induce isomorphisms

(1.3)
$$H^{q}_{b}(S_{r_{0}}) \xleftarrow{\cong} H^{q}_{b}(S_{r_{0}+1}) \xleftarrow{\cong} H^{q}_{b}(S_{r_{0}+2}) \xleftarrow{\cong} \cdots$$

for every degree $q \in \mathbb{N}$, starting from an index $r_0 = r_0(q)$, is known as *bounded-cohomological* stability (abbrv. *bc-stability*). An assignment $q \mapsto r_0(q)$ as above is called *bc-stability range*.

Theorem 2 settles the *optimal* (i.e. lowest possible) bc-stability range $r_0(3)$ in degree q = 3 for the four complex classical families. In the case of the A_r family, Theorem 2 was proved by Bucher, Burger, and Iozzi [3, Thm. 2], relying on work by Monod [30]. Establishing the statement for the remaining three families is the crux of this article.

The isomorphism conjecture, if true, would imply bc-stability for all classical families of Lie groups—for which continuous cohomology is known to stabilize. Our derivation of Theorem 1 from Theorem 2 is a sort of converse of this implication, based on the following principle. If a classical family $(S_r)_{r \in \mathbb{N}}$ is bc-stable with range $r_0(q)$, then proving the degree-qisomorphism conjecture for all the groups $(S_r | r \ge r_0(q))$ within the range of bc-stability is reduced to verifying it only for $S_{r_0(q)}$. The specific feature that favors the application of this principle in our setting is that the range $r_0(3)$ established by Theorem 2 is low enough to reach groups whose H_b^3 is well understood. Indeed, all the groups at the base of the respective isomorphism chains for the families \mathbf{B}_r , \mathbf{C}_r , \mathbf{D}_r are of type \mathbf{A}_r in disguise.

1.3. A secondary stability phenomenon. To explain the structure of our proof of Theorem 2 for the families \mathbf{B}_r , \mathbf{C}_r , \mathbf{D}_r , we revisit the argument in Bucher–Burger–Iozzi [3] for the \mathbf{A}_r case. In [30], Monod proved the bc-stability of the family \mathbf{A}_r , with an addition that ensures a few extra injections—instead of isomorphisms—beyond the regime of bc-stability. In degree three:

$$\mathrm{H}^{3}_{\mathrm{b}}(\mathrm{SL}_{2}(\mathbb{C})) \nleftrightarrow \mathrm{H}^{3}_{\mathrm{b}}(\mathrm{SL}_{3}(\mathbb{C})) \nleftrightarrow \mathrm{H}^{3}_{\mathrm{b}}(\mathrm{SL}_{4}(\mathbb{C})) \cong \mathrm{H}^{3}_{\mathrm{b}}(\mathrm{SL}_{5}(\mathbb{C})) \cong \cdots \cong \mathrm{H}^{3}_{\mathrm{b}}(\mathrm{SL}_{r+1}(\mathbb{C})) \cong \cdots$$

Since $H_b^3(SL_2(\mathbb{C})) \cong \mathbb{R}$ (see [1, 7]), one deduces that $H_b^3(SL_n(\mathbb{C}))$ must have *at most* dimension one for $n \ge 3$. That the dimension is *at least* one is the content of [3], which exhibits a non-zero class in $H_b^3(SL_n(\mathbb{C}))$ based on a construction by Goncharov [17].

In analogy to (1.3), we call *weak* bc-stability the property that the embeddings ι_r in (1.2) induce injections starting from an index $r_1 = r_1(q)$ for every degree $q \in \mathbb{N}$. The (weak) bc-stability of the complex \mathbf{B}_r , \mathbf{C}_r , \mathbf{D}_r —among other classical families—was first proved by Hartnick and the author in [12, Thm. A, Cor. B]. In recent work, Kastenholz and Sroka [22] improved the range of weak bc-stability given in [12] for those families to $r_1(q) = 2q + 2$.

As opposed to Monod's weak bc-stability result [30] for \mathbf{A}_r , the ranges established in the references [12, 22] for the complex families \mathbf{B}_r , \mathbf{C}_r , \mathbf{D}_r do not yield a reduction to a group whose \mathbf{H}_b^3 is understood. Thus, our first step towards Theorem 2 is the following range improvement in degree three. Key Lemma. The block embeddings *i*, induce injections

$$\begin{split} H^3_b(O_3(\mathbb{C})) & \nleftrightarrow & H^3_b(O_5(\mathbb{C})) & \nleftrightarrow & \cdots & \nleftrightarrow & H^3_b(O_{2r+1}(\mathbb{C})) & \nleftrightarrow & \cdots \\ & H^3_b(\operatorname{Sp}_2(\mathbb{C})) & \nleftrightarrow & H^3_b(\operatorname{Sp}_4(\mathbb{C})) & \nleftrightarrow & \cdots & \nleftrightarrow & H^3_b(\operatorname{Sp}_{2r}(\mathbb{C})) & \nleftrightarrow & \cdots \\ & H^3_b(O_4(\mathbb{C})) & \nleftrightarrow & H^3_b(O_6(\mathbb{C})) & \nleftrightarrow & H^3_b(O_8(\mathbb{C})) & \nleftrightarrow & \cdots & \nleftrightarrow & H^3_b(O_{2r}(\mathbb{C})) & \nleftrightarrow & \cdots \\ \end{split}$$

Remark 1.1. The omission of the determinant-one condition in the orthogonal groups in the Key Lemma is on purpose. Upgrading it to determinant-one groups is a technical point that we will treat later. We ask from the reader to ignore that at this stage, and assume for the sake of the introduction that the Key Lemma has been proven for the special orthogonal groups.

A remarkable aspect of the Key Lemma is the next fact that lies at the heart of its proof, given in Section 4. We will prove that if *any* of the block embeddings ι_r for the families \mathbf{B}_r , \mathbf{C}_r , \mathbf{D}_r induces an injection at the level of \mathbf{H}_b^3 , then necessarily *all* the ι_r 's up to the ranges produced by the Key Lemma must induce injections. In this sense, any arbitrary range (e.g., [12, 22]) is as good as any other, for either of them will allow us to bootstrap the optimal range *a posteriori*.

The proof of this intriguing fact relies on a principle reminiscent of *secondary stability* in the sense of Galatius–Kupers–Randal-Williams [15]. A subject of ongoing research in the realm of ordinary homology, secondary stability is the event in which "the failure of stability is itself stable". In our case, failure of weak bc-stability is measured by the kernels of the maps induced by the embeddings ι_r . We prove the stability of those kernels based on a parametrization via cross-ratios of configuration spaces of isotropic projective points, exposed in Section 3.

1.4. Non-triviality of H_b^3 and Gromov norms. In analogy with the argument for A_r given above, it remains to show the non-triviality of H_b^3 for the relevant groups. We will prove:

Theorem 3. For any $r \in \mathbb{N}$, let S_r be either $SO_{2r+1}(\mathbb{C})$, $Sp_{2r}(\mathbb{C})$, or $SO_{2r}(\mathbb{C})$, and let n = n(r) be the dimension of the standard S_r -representation, so that $S_r < SL_n(\mathbb{C})$. Then, the restriction

(1.4)
$$\operatorname{res}_{r}: \operatorname{H}^{3}_{b}(\operatorname{SL}_{n}(\mathbb{C})) \to \operatorname{H}^{3}_{b}(S_{r})$$

is an isomorphism, except if $S_r = SO_{2r}(\mathbb{C})$ and $r \in \{1, 2\}$.

Since $H_b^3(SL_n(\mathbb{C}))$ is 1-dimensional for every $n \ge 2$, the injectivity of the map (1.4) implies the desired non-triviality statement. For groups of types \mathbf{B}_r and \mathbf{C}_r , this follows from the next proposition, which is of independent interest, for it also elucidates the norm structure of H_b^3 .

Proposition 4. For $r \in \mathbb{N}$, if S_r in Theorem 3 is $SO_{2r+1}(\mathbb{C})$ or $Sp_{2r}(\mathbb{C})$, then res_r is isometric.

The proofs of Proposition 4 and Theorems 2 and 3 for the families \mathbf{B}_r and \mathbf{C}_r , are given in Section 5. On the other hand, Proposition 4 does not hold in the \mathbf{D}_r case (see Proposition 6.12). Thus, we give a separate argument for Theorems 2 and 3 for that family in Section 6.

1.5. **Outlook.** In Section 8, we discuss the norm structure of H_b^3 for the classical complex Lie groups, and provide a conjecture in the D_r case, which remains open.

With little extra bookkeeping of the various types of Levi factors of parabolic subgroups, it should be possible to apply our ideas to prove the degree-three isomorphism conjecture for the real split Lie groups $SO_+(r+1, r)$, $Sp_{2r}(\mathbb{R})$, and $SO_+(r, r)$. In general, we expect the situation in degree three for classical groups to be fully determined by what occurs in rank one.

Finally, an exciting and potentially fruitful research avenue is the further usage of secondary stability techniques in bounded cohomology. This could serve for optimizing existing stability ranges, and, eventually, lead to new computations of bounded cohomology in higher degrees.

2. NOTATION AND STANDING ASSUMPTIONS

2.1. Notation on formed spaces. In the rest of this article, we will adhere to the notation from [12, §2], which we summarize below. The notation will be slightly simplified, as we only consider symmetric or antisymmetric formed spaces over \mathbb{C} .

Let $\varepsilon \in \{\pm 1\}$. An ε -symmetric formed space is a pair (V, ω) of a finite-dimensional \mathbb{C} -vector space V and an ε -symmetric bilinear form $\omega : V \times V \to \mathbb{C}$. We write $q(v) := \omega(v, v)$ for the quadratic form. The rank of (V, ω) is the maximal dimension of a totally isotropic subspace of V. Any non-degenerate ε -symmetric space (V, ω) of dimension n splits as the direct sum of formed spaces

(2.1)
$$V \cong \mathcal{H}_{c}^{\oplus r} \oplus \mathcal{E}^{\oplus d},$$

where *r* is the rank of (V, ω) , $\mathcal{H}_{\varepsilon}$ is the ε -hyperbolic plane, \mathcal{E} is the Euclidean line, and $d = n - 2r \in \{0, 1\}$. Furthermore, if $\varepsilon = -1$, then d = 0. We denote by $(V_r^{\varepsilon,d}, \omega_r^{\varepsilon,d})$ the formed space on the right-hand side of (2.1). An ordered basis $\mathscr{B}_r^{\varepsilon,d} = \{e_r, \dots, e_1, dh, f_1, \dots, f_r\}$ of

 $V_r^{\epsilon,d}$ is an adapted basis of $(V_r^{\epsilon,d}, \omega_r^{\epsilon,d})$ if $\langle h \rangle \cong \mathcal{E}$ and $\langle e_i, f_i \rangle \cong \mathcal{H}$ for every *i*. The matrix

$$J_r^{\varepsilon,d} := \begin{pmatrix} 0 & 0 & \varepsilon Q_r \\ 0 & 1_d & 0 \\ Q_r & 0 & 0 \end{pmatrix} \in \mathbf{M}_n(\mathbb{C}),$$

represents the form $\omega_r^{\epsilon,d}$ in the basis $\mathscr{B}_r^{\epsilon,d}$, where $Q_r \in M_r(\mathbb{C})$ is the matrix with 1's on its antidiagonal and zero elsewhere (the middle row and column are omitted if d = 0).

Let $G_r^{\varepsilon,d}$ be the automorphism group of $(V_r^{\varepsilon,d}, \omega_r^{\varepsilon,d})$ and $S_r^{\varepsilon,d} < G_r^{\varepsilon,d}$ its determinant-one subgroup. Both $G_r^{\varepsilon,d}$ and $S_r^{\varepsilon,d}$ are complex Lie subgroups of $GL(V_r^{\varepsilon,d})$. Concretely,

$$G_r^{\varepsilon,d} = \begin{cases} \mathcal{O}_{2r+1}(\mathbb{C}), & (\varepsilon,d) = (+1,1) \\ \mathrm{Sp}_{2r}(\mathbb{C}), & (\varepsilon,d) = (-1,0) \\ \mathcal{O}_{2r}(\mathbb{C}), & (\varepsilon,d) = (+1,0) \end{cases}$$

Observe that

(2.2)
$$G_r^{(+1,1)} \cong \{\pm I\} \times S_r^{(+1,1)} \text{ and } G_r^{(-1,0)} = S_r^{(-1,0)}.$$

For fixed d, the inclusions $\mathscr{B}_{r}^{\varepsilon,d} \hookrightarrow \mathscr{B}_{r+1}^{\varepsilon,d}$ of adapted bases gives rise to the embeddings

(2.3)
$$G_0^{\varepsilon,d} \stackrel{\iota_0}{\hookrightarrow} G_1^{\varepsilon,d} \stackrel{\iota_1}{\hookrightarrow} G_2^{\varepsilon,d} \hookrightarrow \cdots \hookrightarrow G_r^{\varepsilon,d} \stackrel{\iota_r}{\hookrightarrow} G_{r+1}^{\varepsilon,d} \hookrightarrow \cdots$$

of automorphism groups and of their corresponding determinant-one subgroups $S_r^{\epsilon,d}$. We abuse notation and denote by ι_r also the embedding $S_r^{\epsilon,d} \hookrightarrow S_{r+1}^{\epsilon,d}$ (see also (1.2)).

2.2. Standing assumptions. Throughout the article, we will keep a fixed choice of a pair

(2.4)
$$(\varepsilon, d) \in \{(+1, 1), (-1, 0), (+1, 0)\},\$$

which is equivalent to the choice of the classical family \mathbf{B}_r , \mathbf{C}_r , \mathbf{D}_r , respectively. We omit the indices ε , d whenever possible and write V_r , G_r , S_r , etc. instead of $V_r^{\varepsilon,d}$, $G_r^{\varepsilon,d}$, $S_r^{\varepsilon,d}$, etc. Finally, we set $n(r) := \dim(V_r)$, and

$$r_0 := \begin{cases} 3, & \text{if } (\varepsilon, d) = (+1, 0), \\ 1, & \text{otherwise,} \end{cases} \quad r_1 := \begin{cases} 2, & \text{if } (\varepsilon, d) = (+1, 0), \\ 1, & \text{otherwise.} \end{cases}$$

2.3. Re-statement of main results. In the notation fixed in this section, our main results admit the following compact re-statements (omitting the A_r case from Theorems 1 and 2):

Key Lemma bis. For $r \ge r_1$, the induced map $\iota_r^* : H^3_b(G_{r+1}) \to H^3_b(G_r)$ is injective.

Theorem 1 bis. For $r \ge r_0$, the comparison map $c^3 : H^3_b(S_r) \to H^3(S_r)$ is an isomorphism.

Theorem 2 bis. For $r \ge r_0$, the induced map $\iota_r^* : H^3_b(S_{r+1}) \to H^3_b(S_r)$ is an isomorphism.

Theorem 3 bis. For $r \ge r_0$, the restriction $\operatorname{res}_r : \operatorname{H}^3_{\operatorname{b}}(\operatorname{SL}_{n(r)}(\mathbb{C})) \to \operatorname{H}^3_{\operatorname{b}}(S_r)$ is an isomorphism.

3. CONFIGURATION SPACES OF ISOTROPIC POINTS

3.1. The variety of isotropic points. We will consider the following generalized flag variety.

Definition 3.1. For any $r \ge r_1$, we call the irreducible complex projective variety

$$\mathcal{P}_r = \mathcal{P}_r^{\varepsilon, d} := \{ [v] \in \mathbb{P}(V_r) \mid q(v) = 0 \}$$

the variety of isotropic points of V_r . By Witt's lemma [35, Thm. 7.4], it is a compact homogeneous G_r -space when endowed with the Hausdorff topology of its set of \mathbb{C} -points, and the Lebesgue class is its unique G_r -invariant measure class. The assumption $r \ge r_1$ excludes two pathological cases: the set \mathcal{P}_0 is empty, and $\mathcal{P}_1^{(+1,0)}$ is not irreducible as an algebraic set.

Let Q_r be the stabilizer of $[e_r] \in \mathcal{P}_r$, a maximal parabolic subgroup of G_r with Levi decomposition $Q_r = U_r \rtimes R_r$, where U_r is unipotent and R_r reductive. Represented in the basis \mathscr{B}_r , the reductive factor $R_r \cong \mathbb{C}^{\times} \times G_{r-1}$ consists of the block-diagonal matrices

$$\begin{pmatrix} \lambda & 0 & 0 \\ 0 & g & 0 \\ 0 & 0 & \lambda^{-1} \end{pmatrix}$$

with $\lambda \in \mathbb{C}^{\times}$ and $g \in G_{r-1}$. If Q_r^- denotes the stabilizer of $[f_r] \in \mathcal{P}_r$, then $Q_r \cap Q_r^- = R_r$. We are interested in parametrizing generic orbits of the diagonal G_r -action on product spaces \mathcal{P}_r^k , for $k \in \{3, 4, 5\}$. Genericity is understood in the measure-theoretical sense, and therefore, the products \mathcal{P}_r^k will be regarded as objects in the category of *Lebesgue G_r-spaces*.

Definition 3.2. We call *Lebesgue space* a standard Borel space X endowed with the measure class of a Borel probability measure. If X admits a Borel action of a lcsc group G, and the measure class is G-invariant, we call X a *Lebesgue G-space*. Morphisms of Lebesgue (G-) spaces are equivalence classes (up to null sets) of measure-class preserving Borel (G-)maps.

Example 3.3. An algebraic \mathbb{C} -variety X with the regular action of an algebraic group G is a Lebesgue G-space if we endow X with its Lebesgue measure class. The Borel σ -algebra of the set of orbits $G \setminus X$ with respect to the Hausdorff topology on X is standard (see [38, Thm. 3.1.3]), and hence $G \setminus X$ is a Lebesgue space.

If v_0, \ldots, v_k are all non-zero vectors in V_r , we will write $[v_0, \ldots, v_k]$ as a shorthand for the tuple $([v_0], \ldots, [v_k])$ of points in $\mathbb{P}(V_r)$. We will say the tuple is in general position if so are the vectors v_0, \ldots, v_k (or any choices of lifts). We define the subsets

(3.1)
$$\mathcal{P}_{r}^{(k+1)} := \left\{ [v_{0}, \dots, v_{k}] \in \mathcal{P}_{r}^{k+1} \mid \omega(v_{i}, v_{j}) \neq 0 \ \forall i \neq j \right\},$$

(3.2)
$$\mathcal{P}_r^{\{k+1\}} := \left\{ \vec{v} \in \mathcal{P}_r^{(k+1)} \mid \vec{v} \text{ is in general position} \right\}$$

Both are G_r -invariant, \mathfrak{S}_k -invariant¹, Zariski-open subsets of \mathcal{P}_r^{k+1} . In particular, they are also Hausdorff-open and co-null. Moreover, if $\partial_i : \mathcal{P}_r^{k+1} \to \mathcal{P}_r^k$ are the (G_r -equivariant) face maps that forget the *i*-th entry for $i \in \{0, ..., k\}$, then $\partial_i(\mathcal{P}_r^{(k+1)}) = \mathcal{P}_r^{(k)}$ and $\partial_i(\mathcal{P}_r^{(k+1)}) = \mathcal{P}_r^{\{k\}}$.

Our first observation is that there is only one generic G_r -orbit of triples of points in \mathcal{P}_r .

Lemma 3.4. The group G_r acts transitively on $\mathcal{P}_r^{\{3\}}$ for any $r \geq r_1$. Moreover, the point stabilizer $M_r < G_r$ admits a continuous surjection $M_r \twoheadrightarrow M'_r$ with solvable kernel, where

$$M'_{r} = \begin{cases} G_{r-1}^{(+1,0)} & \text{if } (\varepsilon, d) = (+1,1), \\ G_{r-2} & \text{if } (\varepsilon, d) = (-1,0), \\ G_{r-2}^{(+1,1)} & \text{if } (\varepsilon, d) = (+1,0). \end{cases}$$

Proof. For $r \ge r_1$, we set

(3.3)
$$\phi_2 := e_r + f_r + x_0 \in \mathcal{P}_r \text{ where}$$
$$x_0 := \begin{cases} 0 & \text{if } (\varepsilon, d) = (-1, 0) \text{ and } r = 1, \\ \sqrt{-2} h & \text{if } (\varepsilon, d) = (+1, 1) \text{ and } r = 1, \\ e_{r-1} - f_{r-1} & \text{otherwise,} \end{cases}$$

We show that for any $\mathbf{p} = [v_0, v_1, v_2] \in \mathcal{P}_r^{\{3\}}$, there exists $g \in G_r$ such that $g \mathbf{p} = [e_r, f_r, \phi_2]$. Indeed, since $\langle v_0, v_1 \rangle < V_r$ is hyperbolic and $(\mathbb{C}^{\times})^2 = \mathbb{C}^{\times}$, there exists $g_1 \in G_r$ such that

$$g_1[v_0, v_1, v_2] = [e_r, f_r, e_r + f_r + x]$$

for some $x \in V_{r-1} < V_r$. Here x = 0 if and only if n(r) = 2, which holds only when $(\varepsilon, d) = (-1, 0)$ and r = 1. If n(r) > 2, then $q(x) = -(1 + \varepsilon) = q(x_0)$. Now, by Witt's lemma, we find $g_2 \in G_{r-1} < G_r$ such that $g_2 x = x_0$, proving the claim.

Up to index two, the stabilizer M_r is isomorphic to the point stabilizer of the G_{r-1} -action on

$$\mathcal{Q} = \{ x \in V_{r-1} \mid q(x) = -(1+\varepsilon) \}$$

If $\varepsilon = -1$, then $e_{r-1} \in Q$ and, hence, M_r projects onto G_{r-2} with solvable kernel. If $\varepsilon = +1$ and $x \in Q$ is arbitrary, the orthogonal decomposition $V_{r-1} = \langle x \rangle \oplus \langle x \rangle^{\perp}$ implies that M_r is isomorphic to $\operatorname{Aut}(\langle x \rangle^{\perp}, \omega|_{\langle x \rangle^{\perp}})$ up to index two. This yields the claim, since $\langle x \rangle^{\top}$ is nondegenerate and of codimension one in V_{r-1} .

3.2. Cross-ratio coordinates on configurations of 4- and 5-tuples. We will describe the quotients $G_r \setminus \mathcal{P}_r^4$ and $G_r \setminus \mathcal{P}_r^5$ as Lebesgue spaces in terms of the ω -cross-ratios, introduced by Korányi and Reimann [23] in the realm of complex hyperbolic geometry; see e.g. [16].

¹As customary in homological algebra, we adopt the convention that $0 \in \mathbb{N}$. The symmetric group of the set $\{0, \dots, k\} \subset \mathbb{N}$ will be denoted by \mathfrak{S}_k .

Definition 3.5. For any $\mathbf{p} = (p_0, p_1, p_2, p_3) \in \mathcal{P}_r^{(4)}$ with $p_i = [v_i]$, the ratios

$$cr_{0}(\mathbf{p}) := \frac{\omega(v_{0}, v_{2}) \cdot \omega(v_{1}, v_{3})}{\omega(v_{0}, v_{3}) \cdot \omega(v_{1}, v_{2})},$$

$$cr_{1}(\mathbf{p}) := cr_{0}(p_{1}, p_{2}, p_{0}, p_{3})^{-1},$$

$$cr_{2}(\mathbf{p}) := cr_{0}(p_{2}, p_{0}, p_{1}, p_{3}),$$

are independent of the choices of line representatives v_i , thus giving rise to the G_r -invariant, holomorphic functions $\operatorname{cr}_j : \mathcal{P}_r^{(4)} \to \mathbb{C}^{\times}$, called ω -cross-ratios. We will regard them as G_r invariant morphisms $\operatorname{cr}_j : \mathcal{P}_r^4 \to \hat{\mathbb{C}}$ of Lebesgue spaces. We also write $\operatorname{cr}_i^{-1} := 1/\operatorname{cr}_j$.

The next lemma explains dependencies between ω -cross-ratios, including the effect of the permutation of their arguments. It shows that the only ω -cross-ratios associated to any generic choice of four points in \mathcal{P}_r are cr₀, cr₁, cr₂, and that any two of them determine the third one. Its proof is a verification left as an exercise to the reader.

Lemma 3.6. The following identities hold everywhere in $\mathcal{P}_{r}^{(4)}$:

(i) $\operatorname{cr}_{0} \circ (01) = \operatorname{cr}_{0} \circ (23) = \operatorname{cr}_{1}^{-1} \circ (02) = \operatorname{cr}_{1}^{-1} \circ (13) = \operatorname{cr}_{2} \circ (12) = \operatorname{cr}_{2} \circ (03) = \operatorname{cr}_{0}^{-1}$. (ii) $\operatorname{cr}_{1} \circ (12) = \operatorname{cr}_{1} \circ (03) = \operatorname{cr}_{2}^{-1} \circ (01) = \operatorname{cr}_{2}^{-1} \circ (23) = \operatorname{cr}_{1}^{-1}$. (iii) $\operatorname{cr}_{2} \circ (02) = \operatorname{cr}_{2} \circ (13) = \operatorname{cr}_{2}^{-1}$. (iv) $\operatorname{cr}_{0} \cdot \operatorname{cr}_{1}^{-1} \cdot \operatorname{cr}_{2} = \varepsilon$.

Remark 3.7. Let us consider the rank-one examples (i.e. r = 1) among the families treated in Theorem 2. If $(\varepsilon, d) = (-1, 0)$, then the ω -cross-ratios coincide with the classical cross-ratios on the complex projective line, since $G_1 = \text{Sp}_2(\mathbb{C}) = \text{SL}_2(\mathbb{C})$ and $\mathcal{P}_1 = \mathbb{P}(\mathbb{C}^2)$. We will continue to refer to this as the *classical setting*. Lemma 3.4 recovers the well-known fact that any triple in $\mathcal{P}_1^{\{3\}}$ is in the orbit of $(\infty, 0, 1) \in \hat{\mathbb{C}}^3$. As usual, we identify $\mathbb{P}(\mathbb{C}^2)$ with $\hat{\mathbb{C}}$ by

(3.4) $[f_1] \equiv \infty$, and $[e_1 + z \cdot f_1] \equiv z$ for any $z \in \mathbb{C}$.

Recall that for every $\mathbf{p} \in \mathcal{P}_1^{\{4\}}$, the cross-ratio $\operatorname{cr}_0(\mathbf{p})$ is the only number $a \in \mathbb{C} \setminus \{0, 1\}$ such that $G_1 \cdot \mathbf{p} = G_1 \cdot (\infty, 0, 1, a)$. In the language of Lebesgue spaces, this means that the map cr_0 descends to a isomorphism $G_1 \setminus \mathcal{P}_1^4 \cong \hat{\mathbb{C}}$. In fact, due to the low dimension of V_1 in the classical setting, just one of the ω -cross-ratios determines the value of the remaining two.

The only other rank-one example appears for $(\varepsilon, d) = (+1, 1)$, which gives $G_1 = O_3(\mathbb{C})$. As in the classical setting, we have an isomorphism $G_1 \setminus \mathcal{P}_1^4 \cong \hat{\mathbb{C}}$.

In contrast to the rank-one situation, one single ω -cross-ratio does not suffice to parametrize generic 4-tuples in higher-rank. However, two of them are enough.

Proposition 3.8. For any $r \ge 2$, the G_r -invariant morphism $\pi_3 : \mathcal{P}_r^4 \to \hat{\mathbb{C}}^2$ of Lebesgue spaces defined as $\pi_3 := (\operatorname{cr}_1, \operatorname{cr}_2)$ descends to an isomorphism $G_r \setminus \mathcal{P}_r^4 \cong \hat{\mathbb{C}}^2$.

We explain now how the ω -cross-ratios parametrize generic orbits of 5-tuples of points in \mathcal{P}_r .

Definition 3.9. For $j \in \{0, 1, 2\}$, we define morphisms $\alpha_j, \beta_j, \gamma_j : \mathcal{P}_r^5 \to \hat{\mathbb{C}}$

$$\begin{aligned} \alpha_j(\mathbf{p}) &:= \operatorname{cr}_j \circ \partial_4(\mathbf{p}) = \operatorname{cr}_j(p_0, p_1, p_2, p_3), \\ \beta_j(\mathbf{p}) &:= \operatorname{cr}_j \circ \partial_3(\mathbf{p}) = \operatorname{cr}_j(p_0, p_1, p_2, p_4), \\ \gamma_j(\mathbf{p}) &:= \operatorname{cr}_j \circ \partial_2(\mathbf{p}) = \operatorname{cr}_j(p_0, p_1, p_3, p_4), \end{aligned}$$

for $\mathbf{p} = (p_0, p_1, p_2, p_3, p_4) \in \mathcal{P}_r^{(5)}$, where $\partial_i : \mathcal{P}_r^5 \to \mathcal{P}_r^4$ denote the usual face operators. As in Definition 3.5, we set $\alpha_i^{-1} := 1/\alpha_i$ and define similarly $\beta_i^{-1}, \gamma_i^{-1}$.

We can express in terms of the ω -cross-ratios from Definition 3.9 all the remaining cross-ratios associated to a 5-tuple. This fact, recorded in the next lemma, is readily verified.

Lemma 3.10. The following identities hold everywhere in $\mathcal{P}_{r}^{(5)}$:

(i)
$$\operatorname{cr}_{0} \circ \partial_{1} = \alpha_{2}\beta_{2}^{-1}$$
 (iv) $\operatorname{cr}_{0} \circ \partial_{0} = \alpha_{1}\beta_{1}^{-1}$ (vii) $\alpha_{0}\gamma_{0} = \beta_{0}$
(ii) $\operatorname{cr}_{1} \circ \partial_{1} = \beta_{1}^{-1}\gamma_{1}$ (v) $\operatorname{cr}_{1} \circ \partial_{0} = \varepsilon(\alpha_{1}\alpha_{2}^{-1}\beta_{1}^{-1}\gamma_{1})$
(iii) $\operatorname{cr}_{2} \circ \partial_{1} = \varepsilon(\alpha_{2}^{-1}\beta_{1}^{-1}\beta_{2}\gamma_{1})$ (vi) $\operatorname{cr}_{2} \circ \partial_{0} = \alpha_{2}^{-1}\gamma_{1}$

We conclude from Lemmas 3.6 and 3.10 that at most five cross-ratios suffice to describe generic orbits of 5-tuples. The next theorem states that five are also necessary as long as $\dim(V_r)$ is large. Recall that r_1 was defined as a function of (ε, d) at the end of Subsection 2.1.

Proposition 3.11. For any $r \ge r_1 + 1$, the G_r -invariant morphism $\pi_4 : \mathcal{P}_r^5 \to \hat{\mathbb{C}}^5$ of Lebesgue spaces defined as $\pi_4 := (\alpha_1, \alpha_2, \beta_1, \beta_2, \gamma_1)$ descends to an isomorphism $G_r \setminus \mathcal{P}_r^5 \cong \hat{\mathbb{C}}^5$.

Remark 3.12. In rank one, the isomorphism $G_1 \setminus \mathcal{P}_1^5 \cong \hat{\mathbb{C}}^2$ holds for $(\varepsilon, d) \in \{(+1, 1), (-1, 0)\}$. For instance, in the classical setting (see Remark 3.7), any $\mathbf{p} \in \mathcal{P}_1^{\{5\}}$ is in the G_1 -orbit of the tuple $(\infty, 0, 1, a, b) \in \hat{\mathbb{C}}^5$ with $a = \alpha_0(\mathbf{p})$ and $b = \beta_0(\mathbf{p})$. In rank two for $(\varepsilon, d) = (+1, 0)$, the low dimension of V_2 yields one extra relation, which forces the isomorphism $G_2 \setminus \mathcal{P}_2^5 \cong \hat{\mathbb{C}}^4$.

Both Propositions 3.8 and 3.11 will be essential in our proof of Key Lemma. Their proof, in turn, consist of elementary, yet fairly lengthy and technical computations. For the sake of readibility, we have opted to present them in Appendix A.

4. PROOF OF KEY LEMMA

4.1. Cohomological characterization of ker i_r^* . For any $r \ge 1$, we consider the complex

(4.1)
$$0 \to L^{\infty}(\mathcal{P}_r) \xrightarrow{d_r^0} L^{\infty}(\mathcal{P}_r^2) \xrightarrow{d_r^1} L^{\infty}(\mathcal{P}_r^3) \to \cdots$$

of dual Banach G_r -modules, with G_r -equivariant coboundary maps defined by the alternating sum $d_r^k := \sum_{i=0}^{k+1} (-1)^i \cdot \partial^i$. Here ∂^i is the operator induced by the face maps $\partial_i : \mathcal{P}_r^{k+1} \to \mathcal{P}_r^k$. The complex (4.1) is *acyclic* in the sense that the homology of its augmented complex

(4.2)
$$0 \to \mathbb{R} \xrightarrow{d_r^{-1}} L^{\infty}(\mathcal{P}_r) \xrightarrow{d_r^0} L^{\infty}(\mathcal{P}_r^2) \xrightarrow{d_r^1} L^{\infty}(\mathcal{P}_r^3) \to \cdots$$

vanishes in every degree. This follows from the observation that integration over the first variable of $L^{\infty}(\mathcal{P}_{r}^{k+1})$ with respect to a quasi-invariant probability measure on \mathcal{P}_{r} is a contracting homotopy of (4.2). We denote by $\mathrm{H}_{\mathrm{b}}^{q}(G_{r} \curvearrowright \mathcal{P}_{r})$ the *q*-th homology of the complex $L^{\infty}(\mathcal{P}_{r}^{\bullet+1})^{G_{r}}$ of G_{r} -invariants of (4.1), and call it the *bounded cohomology of the action* $G_{r} \curvearrowright \mathcal{P}_{r}$.

In the rank-one cases, the action $G_1 \curvearrowright \mathcal{P}_1$ is amenable, and hence, there exists a canonical isomorphism $\mathrm{H}^*_{\mathrm{b}}(G_1) \cong \mathrm{H}^*_{\mathrm{b}}(G_1 \curvearrowright \mathcal{P}_1)$; see [28, Thm. 7.5.3]. Beyond rank one, the isomorphism needs not hold since the action is no longer amenable. However, the bounded cohomology of that action—or any other G_r -action on an acyclic complex—may still contain interesting information about $\mathrm{H}^*_{\mathrm{b}}(G_r)$. The precise relationship between $\mathrm{H}^*_{\mathrm{b}}(G_r)$ and $\mathrm{H}^*_{\mathrm{b}}(G_r \curvearrowright \mathcal{P}_r)$ is given by a spectral sequence [11, Prop. 2.15], with which we prove the following

Lemma 4.1. For any $r \in \mathbb{N}$, there exists a linear isomorphism ker $\iota_r^* \cong \mathrm{H}^3_{\mathrm{b}}(G_{r+1} \curvearrowright \mathcal{P}_{r+1})$.

Proof. There exists a spectral sequence $E_{\bullet}^{\bullet,\bullet}$ that abuts to zero, with first-page terms

$$\mathbf{E}_{1}^{p,q} = \mathbf{H}_{\mathbf{b}}^{q}(G_{r+1}; L^{\infty}(\mathcal{P}_{r+1}^{p}))$$

and differentials $d_1^{p,q} : E_1^{p,q} \to E_1^{p+1,q}$ induced by the operators d_{r+1}^{p-1} [11, Prop. 2.15]. Note first that $E_2^{p,0} \cong H_b^{p-1}(G_{r+1} \curvearrowright \mathcal{P}_{r+1})$ for all $p \ge 1$. Furthermore, as a consequence of the Eckmann–Shapiro lemma [28, Prop. 10.1.3], Lemma 3.4, and [28, Corollary 8.5.2], we have:

$$\begin{split} & \mathrm{E}_{1}^{0,q} &= \mathrm{H}_{\mathrm{b}}^{q}(G_{r+1}), \\ & \mathrm{E}_{1}^{1,q} &\cong \mathrm{H}_{\mathrm{b}}^{q}(Q_{r+1}) \cong \mathrm{H}_{\mathrm{b}}^{q}(G_{r}), \\ & \mathrm{E}_{1}^{2,q} &\cong \mathrm{H}_{\mathrm{b}}^{q}(R_{r+1}) \cong \mathrm{H}_{\mathrm{b}}^{q}(G_{r}), \end{split} \\ & \mathrm{E}_{1}^{2,q} &\cong \mathrm{H}_{\mathrm{b}}^{q}(R_{r+1}) \cong \mathrm{H}_{\mathrm{b}}^{q}(G_{r}), \end{aligned} \\ & \mathrm{E}_{1}^{2,q} &\cong \mathrm{H}_{\mathrm{b}}^{q}(R_{r+1}) \cong \mathrm{H}_{\mathrm{b}}^{q}(G_{r}), \end{aligned} \\ & \mathrm{E}_{1}^{2,q} &\cong \mathrm{H}_{\mathrm{b}}^{q}(R_{r+1}) \cong \mathrm{H}_{\mathrm{b}}^{q}(G_{r}), \end{aligned}$$

Here, Q_{r+1} , R_{r+1} , M_{r+1} are as defined in Subsection 3.1. For $p \leq 3$, we have $E_2^{p,1} = E_1^{p,1} = 0$ and $E_2^{p,2} = E_1^{p,2} = 0$. The latter equality holds from the isomorphism conjecture in degree two [5, Lem. 6.1]. In fact, for any (ϵ, d) as in (2.4) and any r, the group $G_r^{\epsilon,d}$ is of non-Hermitian type, and therefore $H_b^2(G_r^{\epsilon,d}) \cong H^2(G_r^{\epsilon,d}) = 0$. Finally, the map $d_1^{0,3}$ is conjugated by the isomorphisms above to the map ι_r^* (e.g. by [11, Lem. 3.7]), and hence, $E_2^{0,3} \cong \ker \iota_r^*$. Summarizing, we have showed that the second page $E_2^{\bullet,\bullet}$ has terms as displayed below.

Blank spaces indicate that the terms are not relevant to our computation. Observe that all the displayed terms will remain unchanged until the fourth page $E_4^{\bullet,\bullet}$. Then, the arrow

$$\mathbf{d}_{4}^{0,3}: \ker \iota_{r}^{*} \to \mathbf{H}_{\mathbf{b}}^{3}(G_{r+1} \curvearrowright \mathcal{P}_{r+1})$$

must be an isomorphism, for otherwise the limits $E_{\infty}^3 \neq 0$ or $E_{\infty}^4 \neq 0$ would be non-zero.

4.2. Secondary stability argument. Propositions 3.8 and 3.11 enter the proof of the Key Lemma bis in the form of the next statement, reminiscent of secondary stability in the sense of Galatius-Kupers–Randal-Williams [15].

Lemma 4.2. For every $r \ge r_1$, the linear isomorphism ker $\iota_r^* \cong \ker \iota_{r_1}^*$ holds.

Proof. In virtue of Lemma 4.1, we must prove the isomorphism

$$\mathrm{H}^{3}_{\mathrm{b}}(G_{r+1} \curvearrowright \mathcal{P}_{r+1}) \cong \mathrm{H}^{3}_{\mathrm{b}}(G_{r_{1}+1} \curvearrowright \mathcal{P}_{r_{1}+1}).$$

By Lemma 3.4, the space of invariants $L^{\infty}(\mathcal{P}^3_{r+1})^{G_{r+1}}$ consists solely of constants, and hence, there are no coboundaries in $H^3_b(G_{r+1} \curvearrowright \mathcal{P}_{r+1})$. Let now D^3_{r+1} be the bounded operator defined by the commutative diagram

$$L^{\infty}(\mathcal{P}_{r+1}^{4})^{G_{r+1}} \xrightarrow{d_{r+1}^{3}} L^{\infty}(\mathcal{P}_{r+1}^{5})^{G_{r+1}}$$
$$\pi_{3}^{*} \stackrel{\cong}{\uparrow} \cong \qquad \cong \stackrel{D_{r+1}^{3}}{=} L^{\infty}(\hat{\mathbb{C}}^{2}) - - - \stackrel{D_{r+1}^{3}}{=} - > L^{\infty}(\hat{\mathbb{C}}^{5})$$

Here, π_3^* and π_4^* are the isomorphisms induced by the morphisms of Lebesgue spaces from Propositions 3.8 and 3.11, respectively. Observe that ker $d_{r+1}^3 \cong \ker D_{r+1}^3$.

The proof is completed upon showing that D_{r+1}^3 is independent of $r \ge r_1$. In fact, after applying Lemma 3.10, the map D_{r+1}^3 can be expressed as

(4.3)
$$D_{r+1}^3 f(\mathbf{x}) = f\left(\varepsilon \frac{a_1c_1}{a_2b_1}, \frac{c_1}{a_2}\right) - f\left(\frac{c_1}{b_1}, \varepsilon \frac{b_2c_1}{a_2b_1}\right) + f\left(c_1, \varepsilon \frac{a_1b_2c_1}{a_2b_1}\right) - f(b_1, b_2) + f(a_1, a_2)$$

for any $f \in L^{\infty}(\hat{\mathbb{C}}^2)$ and a.e. $\mathbf{x} = (a_1, a_2, b_1, b_2, c_1) \in \hat{\mathbb{C}}^5$.

for any $f \in L^{\infty}(\mathbb{C}^2)$ and a.e. $\mathbf{x} = (a_1, a_2, b_1, b_2, c_1) \in \mathbb{C}^5$.

Proof of Key Lemma bis. The (weak) bc-stability of the complex classical families—proved in [12, Thm. A]—implies that ker $i_r^* = 0$ for large enough r. This fact combined with Lemma 4.2 finishes the proof.

In the classical setting (see Remark 3.7), the coboundary d_1^3 is conjugated to an operator D_1^3 : $L^{\infty}(\hat{\mathbb{C}}) \to L^{\infty}(\hat{\mathbb{C}}^2)$ in virtue of the isomorphisms discussed in Remarks 3.7 and 3.12. The functional equation $D_1^3 f = 0$ for $f \in L^{\infty}(\mathbb{C})$ is known as the Spence-Abel functional equation. Under a specific parametrization, it is given by

(4.4)
$$f\left(\frac{a(1-b)}{b(1-a)}\right) - f\left(\frac{1-b}{1-a}\right) + f\left(\frac{b}{a}\right) - f(b) + f(a) = 0$$
 for a.e. $(a,b) \in \mathbb{C}^2$,

and its only solution up to a constant factor is the *Bloch–Wigner dilogarithm* D (see e.g. [37, §3]). The expression of $D_{\infty}^3 := D_r^3$ given by (4.3) for any $r \ge r_1 + 1$ produces a higher-rank analogue of the Spence–Abel equation. A byproduct of the proof of the Key Lemma is the inexistence of non-trivial solutions for this equation.

Corollary 4.3. Let $\varepsilon \in \{\pm 1\}$. If $f \in L^{\infty}(\hat{\mathbb{C}}^2)$ satisfies the functional equation $D^3_{\infty}f = 0$ a.e., then f is a.e. the identically zero function.

5. PROOF OF THEOREMS 2 AND 3 FOR THE COMPLEX FAMILIES \mathbf{B}_r and \mathbf{C}_r

In Subsection 2.2, we fixed a pair $(\varepsilon, d) \in \{(+1, 1), (-1, 0), (+1, 0)\}$ as a standing assumption. In this section, we will only consider the cases (+1, 1) and (-1, 0), which correspond to the two complex classical families \mathbf{B}_r and \mathbf{C}_r , respectively. In both cases, we have $r_0 = r_1 = 1$. We first prove that res_r : $\mathrm{H}^3_{\mathrm{b}}(\mathrm{SL}_{n(r)}(\mathbb{C})) \to \mathrm{H}^3_{\mathrm{b}}(S_r)$ is isometric for any $r \in \mathbb{N}$, which is the statement of Proposition 4. We rely on the following result from [3]. Below, we denote by Π_n : $\mathrm{SL}_2(\mathbb{C}) \to \mathrm{SL}_n(\mathbb{C})$ the irreducible *n*-dimensional $\mathrm{SL}_2(\mathbb{C})$ -representation, and by b_n the *bounded Borel class*, defined in [3], which generates $\mathrm{H}^3_{\mathrm{b}}(\mathrm{SL}_n(\mathbb{C}))$ as a vector space.

Theorem 5.1 (see [3, Thm. 2]). For any $n \ge 2$, the map $\Pi_n^* : H^3_b(SL_n(\mathbb{C})) \to H^3_b(SL_2(\mathbb{C}))$ induced by Π_n is an isometric isomorphism that maps the bounded Borel class b_n to

$$\Pi_n^*(b_n) = \frac{n(n^2 - 1)}{6} \cdot b_2.$$

In particular, the Gromov norm of b_n is $||b_n|| = n(n^2 - 1)/6 \cdot v_3$, where $v_{\mathbb{H}^3} \approx 1.0149...$ is the maximal volume of an ideal tetrahedron in \mathbb{H}^3 .

Consider now the irreducible representation $\Pi_{n(r)}$: $SL_2(\mathbb{C}) \to SL(V_r) \cong SL_{n(r)}(\mathbb{C})$ for $r \ge 1$. The parity of n(r) depends on the choice of $(\varepsilon, d) \in \{(+1, 1), (-1, 0)\}$. It is important to note that (up to conjugation) $\Pi_{n(r)}$ preserves the form ω_r on V_r , which implies that its image is contained in S_r . We will use the notation $\overline{\Pi}_r$: $SL_2(\mathbb{C}) \to S_r$ for the co-restriction of $\Pi_{n(r)}$.

Proof of Proposition 4. Note that $\Pi_{n(r)}^* = \bar{\Pi}_r^* \circ \operatorname{res}_r$. Since $\operatorname{H}^3_{\operatorname{b}}(\operatorname{SL}_{n(r)}(\mathbb{C}))$ is generated by the bounded Borel class $b_{n(r)}$, it suffices to show the equality $\|\operatorname{res}_r(b_{n(r)})\| = \|b_{n(r)}\|$. Indeed, in virtue of Theorem 5.1 and the fact that both res_r and $\bar{\Pi}_r^*$ are norm non-increasing, we have

$$\|b_{n(r)}\| = \|\Pi_{n(r)}^{*}(b_{n(r)})\| = \|\bar{\Pi}_{r}^{*}(\operatorname{res}_{r}(b_{n(r)}))\| \le \|\operatorname{res}_{r}(b_{n(r)})\| \le \|b_{n(r)}\|$$

completing the proof.

For (ε, d) as in this section, the restriction map $H_b^*(G_r) \to H_b^*(S_r)$ is an isomorphism as a result of (2.2) and [28, Cor. 8.5.2]. This implies immediately that Key Lemma *bis* holds *verbatim* for S_r instead of G_r in these two cases:

Lemma 5.2. For
$$r \ge r_1 = 1$$
, the induced map $\iota_r^* : H^3_b(S_{r+1}) \to H^3_b(S_r)$ is injective.

Recall also that, depending on (ε, d) , the group S_1 equals $Sp_2(\mathbb{C})$ or $SO_3(\mathbb{C})$. The former group equals $SL_2(\mathbb{C})$ and the latter admits an isogeny $SL_2(\mathbb{C}) \twoheadrightarrow SO_3(\mathbb{C})$, as seen in, e.g., [36, 34]. Thus, S_1 is of type \mathbf{A}_1 , and, in particular, dim $H^3_b(S_1) = 1$.

Proof of Theorem 3 bis for \mathbf{B}_r , \mathbf{C}_r . If $r \ge r_0 = 1$, then $n(r) \ge 2$, so that $||b_{n(r)}|| > 0$. Together with Proposition 4, this establishes the injectivity of res_r. Surjectivity follows then from the fact that dim $\mathrm{H}^3_\mathrm{b}(S_r) \le 1$ for all $r \ge 1$. This, in turn, is a consequence of Lemma 5.2 and the equality dim $\mathrm{H}^3_\mathrm{b}(S_1) = 1$.

Proof of Theorem 2 bis for $\mathbf{B}_r, \mathbf{C}_r$. Theorem 3 bis implies that dim $\mathrm{H}^3_{\mathrm{b}}(S_r) = 1$ for all $r \ge 1$. Thus, the induced maps ι^*_r : $\mathrm{H}^3_{\mathrm{b}}(S_{r+1}) \to \mathrm{H}^3_{\mathrm{b}}(S_r)$ —injective by Lemma 5.2—are isomorphisms.

6. Proof of Theorems 2 and 3 for the complex family \mathbf{D}_r

In this section, we consider the case $(\varepsilon, d) = (+1, 0)$, which corresponds to the \mathbf{D}_r family, and recall that n(r) = 2r, $r_0 = 3$, and $r_1 = 2$. Note that the images of the irreducible representations Π_{2r} : $\mathrm{SL}_2(\mathbb{C}) \to \mathrm{SL}_{2r}(\mathbb{C})$ are not contained in $S_r = \mathrm{SO}_{2r}(\mathbb{C})$ for any r. This limitation prevents the adaptation of the argument in Section 5 to the \mathbf{D}_r family.

We will establish Theorem 3 *bis* by induction on the rank r without relying on norm considerations. The induction will be based on the following statement.

Lemma 6.1. The restriction map res_2 : $\operatorname{H}^3_b(\operatorname{SL}_4(\mathbb{C})) \to \operatorname{H}^3_b(\operatorname{SO}_4(\mathbb{C}))$ is injective.

To prove Lemma 6.1, we will realize res_2 over the Furstenberg boundaries of the involved groups. Subsection 6.1 collects relevant background on the Goncharov–Bucher–Burger–Iozzi *volume cocycle* of $\operatorname{SL}_n(\mathbb{C})$, which represents the bounded Borel class $b_n \in \operatorname{H}^3_b(\operatorname{SL}_n(\mathbb{C}))$. Then, in Subsection 6.2, we will discuss the Furstenberg boundary of $\operatorname{SO}_4(\mathbb{C})$.

6.1. The Goncharov–Bucher–Burger–Iozzi volume cocycle. The content of this subsection is extracted entirely from the references [17, 3]. We abbreviate by \mathbb{P} the complex projective line $\mathbb{P}(\mathbb{C}^2)$, isomorphic to the boundary of the hyperbolic 3-space \mathbb{H}^3 . We let $\operatorname{Vol}_{\mathbb{P}}$: $\mathbb{P}^4 \to \mathbb{R}$ be the function that assigns to a 4-tuple $(p_0, p_1, p_2, p_3) \in \mathbb{P}^4$ the oriented volume of the ideal tetrahedron in \mathbb{H}^3 with vertices p_i . Up to rescaling, $\operatorname{Vol}_{\mathbb{P}}$ is the unique alternating, $\operatorname{GL}_2(\mathbb{C})$ -invariant, continuous bounded cocycle $\mathbb{P}^4 \to \mathbb{R}$; see [1, 7].

We may write $\operatorname{Vol}_{\mathbb{P}}$ in terms of the Bloch–Wigner dilogarithm $\mathcal{D} : \mathbb{C} \to \mathbb{R}$ (see [37, §3]) as

(6.1)
$$\operatorname{Vol}_{\mathbb{P}} = \mathcal{D} \circ \operatorname{cr}_{0}$$

where cr_0 is the classical cross-ratio on \mathbb{P} (see Definition 3.5 and Remark 3.7). Under the identification $\mathbb{P} \cong \hat{\mathbb{C}}$ from (3.4), the equality (6.1) corresponds to $Vol_{\mathbb{P}}(\infty, 0, 1, z) = \mathcal{D}(z)$. Thus, the cocycle equation for $Vol_{\mathbb{P}}$ implies that \mathcal{D} satisfies Spence–Abel functional equation (4.4), and the alternation of $Vol_{\mathbb{P}}$ translates into the symmetries

(6.2)
$$\mathcal{D}(z) = \mathcal{D}\left(1 - \frac{1}{z}\right) = \mathcal{D}\left(\frac{1}{1-z}\right) = -\mathcal{D}\left(\frac{1}{z}\right) = -\mathcal{D}(1-z) = -\mathcal{D}\left(\frac{-z}{1-z}\right).$$

A complete flag in \mathbb{C}^n is a sequence $F^0 \subset F^1 \subset \cdots \subset F^{n-1} \subset F^n$ of subspaces $F^j \subset \mathbb{C}^n$ such that dim $(F^j) = j$. The group $\operatorname{SL}_n(\mathbb{C})$ acts transitively on the variety \mathbb{F}_n of complete flags in \mathbb{C}^n , and the stabilizer of the standard flag $\{0\} \subset \langle e_1 \rangle \subset \cdots \subset \langle e_1, \ldots, e_{n-1} \rangle \subset \mathbb{C}^n$ is the upper-triangular subgroup $P_n < \operatorname{SL}_n(\mathbb{C})$, a minimal parabolic subgroup. This identifies \mathbb{F}_n with the Furstenberg boundary of $\operatorname{SL}_n(\mathbb{C})$. Now, a complete *affine* flag (F, \vec{v}) is a pair that consists of a complete flag F, and a tuple of spanning vectors $\vec{v} = (v^1, \ldots, v^n)$ in the sense that

$$F^{j} = F^{j-1} \oplus \langle v^{j} \rangle$$
 for $j = 1, \dots, n$.

We write $\mathbb{F}_{n,aff}$ for the set of affine flags, which comes equipped with a projection $\mathbb{F}_{n,aff} \twoheadrightarrow \mathbb{F}_n$.

Definition 6.2. Let σ_3 denote the collection of equivalence classes $[V; (v^0, ..., v^3)]$, where V is a \mathbb{C} -vector space, $v^0, ..., v^3 \in V$ are vectors that span V. The equivalence $[V, (v^j)] \sim [W, (w^j)]$ holds if there exists a linear isomorphism

$$\phi: V \xrightarrow{-} W$$
 with $\phi(v^j) = w^j$ for all $j \in \{0, 1, 2, 3\}$.

Note that σ_3 is a set since every class $[V; (v^j)]$ admits a representative $[\mathbb{C}^m; (\bar{v}^j)]$ for $0 \le m \le 4$. Now, for any $J = (j_0, \dots, j_3) \in \{0, \dots, n-1\}^4$, we set $T_J : \mathbb{F}_{aff}(\mathbb{C}^n)^4 \to \sigma_3$ as

(6.3)
$$T_J((F_0, \vec{v}_0), \dots, (F_3, \vec{v}_3)) := \left[\frac{\langle F_0^{j_0+1}, \dots, F_3^{j_3+1} \rangle}{\langle F_0^{j_0}, \dots, F_3^{j_3} \rangle}; \left(v_0^{j_0+1}, \dots, v_3^{j_3+1}\right)\right],$$

where each $(F_i, \vec{v}_i) \in \mathbb{F}_{n, \text{aff}}$ is such that $F_i = (F_i^0 \subset \cdots \subset F_i^n)$ and $\vec{v}_i = (v_i^1, \dots, v_i^n)$, and the vectors in the right-hand side of (6.3) are regarded as classes modulo $\langle F_0^{j_0}, \dots, F_3^{j_3} \rangle$.

Definition 6.3. Let $n \ge 2$, and let Vol : $\sigma_3 \rightarrow \mathbb{R}$ be the map defined as

$$\operatorname{Vol}\left[\mathbb{C}^{m}; (v^{0}, \dots, v^{3})\right] := \begin{cases} \operatorname{Vol}_{\mathbb{P}}[v^{0}, \dots, v^{3}] & \text{if } m = 2 \text{ and all } v^{i} \neq 0, \\ 0 & \text{otherwise.} \end{cases}$$

We let $\tilde{B}_n^J : \mathbb{F}_{n,\text{aff}}^4 \to \mathbb{R}$ be the composition $\text{Vol} \circ T_J$ for any $J \in \{0, \dots, n-1\}^4$. This function is independent of the choices of spanning vectors, and thus, descends to a bounded Borel function $B_n^J : \mathbb{F}_n^4 \to \mathbb{R}$. Moreover, the sum

$$B_n := \sum_J B_n^J$$

descends to an alternating, $\operatorname{GL}_n(\mathbb{C})$ -invariant, bounded strict Borel cocycle $B_n : \mathbb{F}_n^4 \to \mathbb{R}$ (see [3, Cor. 13]). Observe that $B_2 = \operatorname{Vol}_{\mathbb{P}}$, so by analogy, we will call B_n the (Goncharov–Bucher–Burger–Iozzi) volume cocycle. The bounded Borel class $b_n \in \operatorname{H}_b^3(\operatorname{SL}_n(\mathbb{C})) \cong \operatorname{H}_b^3(\operatorname{GL}_n(\mathbb{C}))$, mentioned in Theorem 5.1 above, is defined as $b_n := [B_n]$.

Whilst B_n is not everywhere continuous, it is so in the following generic locus.

Definition 6.4. We say that a 4-tuple $(F_0, F_1, F_2, F_3) \in \mathbb{F}_n^4$ is in general position if $\dim \langle F_0^{j_0}, \dots, F_3^{j_3} \rangle = j_0 + \dots + j_3$

as long as the right-hand side is at most *n*. We will denote by $\mathbb{F}_n^{\{4\}}$ the Zariski-open (hence Hausdorff-open and co-null) subset of \mathbb{F}_n^4 of 4-tuples in general position.

Lemma 6.5. For any $n \ge 2$ and $J = (j_0, ..., j_3) \in \{0, ..., n-1\}^4$, the restriction of B_n^J to the open subset $\mathbb{F}_n^{\{4\}}$ is continuous, and vanishes identically unless the equality

(6.4) $\|J\|_1 = j_0 + \ldots + j_3 = n - 2$

holds. In particular, the volume cocycle $B_n : \mathbb{F}_n^4 \to \mathbb{R}$ is continuous on $\mathbb{F}_n^{\{4\}}$.

Proof. See discussion preceding [3, Lem. 16]. The restriction $B_n^J|_{\mathbb{F}_n^{\{4\}}}$ reduces to a hyperbolic volume function $\operatorname{Vol}_{\mathbb{P}}$ when (6.4) holds, and vanishes otherwise. This implies the continuity statement. Note that there are precisely $n(n^2 - 1)/6$ tuples *J* that fulfill (6.4).

6.2. The Furstenberg boundary of $SO_4(\mathbb{C})$. The content of this subsection is classical, and can be found e.g. in [36, §I.7]. We continue to abbreviate $\mathbb{P} := \mathbb{P}(\mathbb{C}^2)$. Observe first that $SO_4(\mathbb{C})$ acts on the variety of totally isotropic *projective lines* in $\mathbb{P}(\mathbb{C}^4)$ (i.e. 2-dimensional linear subspaces of \mathbb{C}^4) with two orbits, O^+ and O^- . Respectively, these consist of elements

$$\begin{split} l_a^+ &:= \left\{ [1, -t, a, at]^\top \in \mathbb{P}(\mathbb{C}^4) \mid t \in \hat{\mathbb{C}} \right\} \in O^+, \\ l_a^- &:= \left\{ [1, a, -t, at]^\top \in \mathbb{P}(\mathbb{C}^4) \mid t \in \hat{\mathbb{C}} \right\} \in O^-, \end{split}$$

with $a \in \hat{\mathbb{C}} \cong \mathbb{P}$, given in coordinates with respect to the basis $\mathscr{B}_2^{(+1,0)} = \{e_1, e_2, f_2, e_1\}$. These lines satisfy the properties

$$\begin{cases} l_a^+ \cap l_b^+ = l_a^- \cap l_b^- = \emptyset & \text{for } a \neq b, \\ l_a^+ \cap l_b^- = [1, b, -a, ab]^\top. \end{cases}$$

The SO₄(\mathbb{C})-action on the product $\mathcal{F} := O^+ \times O^-$ is transitive, and the stabilizer of the pair $(l_0^+, l_0^-) \in \mathcal{F}$ equals the subgroup of upper-triangular orthogonal matrices. Thus, we identify the Furstenberg boundary of SO₄(\mathbb{C}) with \mathcal{F} .

There exists an exceptional isogeny θ : $SL_2(\mathbb{C}) \times SL_2(\mathbb{C}) \twoheadrightarrow SO_4(\mathbb{C})$ that descends to an isomorphism of Lebesgue $SL_2(\mathbb{C}) \times SL_2(\mathbb{C})$ -spaces,

(6.5)
$$\partial \theta : \mathbb{P} \times \mathbb{P} \to \mathcal{F}, \quad \partial \theta(a,b) := (l_a^+, l_b^-), \ a, b \in \hat{\mathbb{C}}.$$

The following embedding of the Furstenberg boundary \mathcal{F} into the full flag variety of \mathbb{C}^4 plays a key role in our proof of Lemma 6.1.

Definition 6.6. Let $\rho : \mathcal{F} \to \mathbb{F}_4$ be the SO₄(\mathbb{C})-equivariant embedding defined as

$$\rho(l^+, l^-) := (\{0\} \subset l^+ \cap l^- \subset l^+ \subset l^+ + l^- \subset \mathbb{C}^4).$$

An analogous map can be obtained if we choose l^- instead of l^+ as the 2-dimensional subspace.

Remark 6.7. The image of ρ is a null set. In particular, ρ does not preserve measure classes.

6.3. Generic values of the volume cocycle of $SO_4(\mathbb{C})$. We introduce a notion of genericity for tuples of points in the Furstenberg boundary \mathcal{F} .

Definition 6.8. For any $k \in \mathbb{N}$, we set

$$\mathcal{F}^{\{k+1\}} := \partial \theta^{\times (k+1)} \big(\mathbb{P}^{\{k+1\}} \times \mathbb{P}^{\{k+1\}} \big) \subset \mathcal{F}^{k+1},$$

where the brackets in the upper index of \mathbb{P} refer to the generic subsets (3.2) in the classical setting. The product $\mathbb{P}^{\{k+1\}} \times \mathbb{P}^{\{k+1\}}$ is regarded as a subset of $(\mathbb{P} \times \mathbb{P})^{k+1}$ in the obvious way.

Lemma 6.9. The following statements hold:

- (i) The set $\mathcal{F}^{\{k+1\}}$ is an SO₄(\mathbb{C})-invariant, co-null Borel subset of \mathcal{F}^{k+1} , and the equality $\partial_i(\mathcal{F}^{\{k+1\}}) = \mathcal{F}^{\{k\}}$ holds for every $i \in \{0, ..., k+1\}$.
- (ii) The action $SO_4(\mathbb{C}) \curvearrowright \mathcal{F}^{\{3\}}$ is transitive.
- (iii) The image $\rho^{\times 4}(\mathcal{F}^{\{4\}})$ is contained in the set $\mathbb{F}_{4}^{\{4\}}$ of 4-tuples in general position.

Proof. Item (i) follows from the fact that $\partial \theta$ is an isomorphism of Lebesgue $SL_2(\mathbb{C}) \times SL_2(\mathbb{C})$ -spaces, and $\mathbb{P}^{\{k+1\}} \times \mathbb{P}^{\{k+1\}}$ is invariant, Borel and co-null in $(\mathbb{P} \times \mathbb{P})^{k+1}$. Item (ii) is a consequence of the transitivity of the action $SL_2(\mathbb{C}) \curvearrowright \mathbb{P}^{\{3\}}$. For (iii), we let $\mathbf{a} = (a_0, \dots, a_3)$ and $\mathbf{b} = (b_0, \dots, b_3) \in \mathbb{P}^{\{4\}}$. The genericity of these tuples means that their entries are pairwise distinct when regarded under the identification $\mathbb{P} \cong \hat{\mathbb{C}}$. Set $l_i^+ := l_{a_i}^+$ and $l_i^- := l_{b_i}^-$, so that

$$((l_0^+, l_0^-), \dots, (l_3^+, l_3^-)) = (\partial \theta_0)^4 (\mathbf{a}, \mathbf{b}) \in \mathcal{F}^4.$$

We claim that the image under $\rho^{\times 4}$ of the tuple $((l_0^+, l_0^-), \dots, (l_3^+, l_3^-))$ is in general position. Indeed, if we set $p_i := l_i^+ \cap l_i^- \in \mathcal{P}_2$, then, for instance, for distinct $i, j \in \{0, 1, 2, 3\}$, we have

$$\dim(p_i + p_j) = 1 + 1 - \dim(l_i^+ \cap l_i^- \cap l_j^+ \cap l_j^-) = 2,$$

$$\dim(p_i + l_i^+) = 1 + 2 - \dim(l_i^+ \cap l_i^- \cap l_j^+) = 3,$$

$$\dim(p_i + (l_j^+ + l_j^-)) = 1 + 3 - \dim(l_i^+ \cap l_i^- \cap (l_j^+ + l_j^-)) = 4,$$

where we used that $l_i^+ \cap l_j^+ = l_i^- \cap l_j^- = \{0\}$ and

$$l_i^+ \cap l_i^- \cap (l_j^+ + l_j^-) \subset (l_i^+ \cap l_i^- \cap l_j^+) + (l_i^+ \cap l_i^- \cap l_j^-) = \{0\}.$$

The remaining verifications are completely analogous to the three given above.

In the following lemma, we examine the values of the volume cocycle B_n over the image of the generic set $\mathcal{F}^{\{4\}}$ via the inclusion $\rho^{\times 4} : \mathcal{F}^4 \to \mathbb{F}_4^4$. For simplicity, in its proof we will write 4-tuples of indices (j_0, \ldots, j_3) as $j_0 \cdots j_3$, omitting parentheses and commas.

Lemma 6.10. For any $(a, b) \in \hat{\mathbb{C}}^2$, let $F_{(a,b)} := \rho(\partial \theta(a, b))$ and $F_a := F_{(a,a)}$. Then for all $(a, b) \in (\mathbb{C} \setminus \{0, 1\})^2$, the equality

$$B_4(F_{\infty}, F_0, F_1, F_{(a,b)}) = 2(\mathcal{D}(a) + \mathcal{D}(b))$$

holds. In particular, the map $B_4 \circ \rho^{\times 4}|_{\mathcal{F}^{\{4\}}} : \mathcal{F}^{\{4\}} \to \mathbb{R}$ is non-zero.

Proof. We claim the following values for the non-vanishing summands B_4^J of B_4 (see Lemma 6.5):

(6.6)
$$B_{4}^{J}(F_{\infty}, F_{0}, F_{1}, F_{(a,b)}) = \begin{cases} D(b) & \text{if } J \in \{2000, 0200, 0020, 0002\}, \\ -D(b/a) & \text{if } J \in \{1100, 0011\}, \\ D\left(\frac{1-b}{1-a}\right) & \text{if } J \in \{1010, 0101\}, \\ -D\left(\frac{a(1-b)}{b(1-a)}\right) & \text{if } J \in \{1001, 0110\}. \end{cases}$$

First, if we let $\phi_{ab} := e_1 + b e_2 - a f_2 + ab f_1$ for any $a, b \in \hat{\mathbb{C}}$, then

$$l_a^+ = \langle e_1 - a f_2, e_2 + a f_1 \rangle, \quad l_b^- = \langle e_1 + b e_2, b f_1 - f_2 \rangle, \quad \text{and} \quad l_a^+ \cap l_b^- = \langle \phi_{ab} \rangle,$$

and therefore, for $a, b \in \mathbb{C} \setminus \{0, 1\},$

$$\begin{split} F_{\infty} &= \left(\{0\} \subset \langle f_1 \rangle \subset \langle f_1, f_2 \rangle \subset \langle f_1, f_2, e_2 \rangle \subset \mathbb{C}^4\right), \\ F_0 &= \left(\{0\} \subset \langle e_1 \rangle \subset \langle e_1, e_2 \rangle \subset \langle e_1, e_2, f_2 \rangle \subset \mathbb{C}^4\right), \\ F_{(a,b)} &= \left(\{0\} \subset \langle \phi_{ab} \rangle \subset \langle \phi_{ab}, e_1 - a f_2 \rangle \subset \langle \phi_{ab}, e_1 - a f_2, e_1 + b e_2 \rangle \subset \mathbb{C}^4\right). \end{split}$$

Now, we have:

$$\begin{split} B_4^{2000}(F_{\infty}, F_0, F_1, F_{(a,b)}) &= \operatorname{Vol} \left[\frac{\langle f_1, f_2, e_2 \rangle + \langle e_1 \rangle + \langle \phi_{11} \rangle + \langle \phi_{ab} \rangle}{\langle f_1, f_2 \rangle + \{0\} + \{0\} + \{0\}}; (e_2, e_1, \phi_{11}, \phi_{ab}) \right] \\ &= \operatorname{Vol} \left[V_2^{(+1,0)} / \langle f_1, f_2 \rangle; (e_2, e_1, \phi_{11}, \phi_{ab}) \right] \\ &\stackrel{(*)}{=} \operatorname{Vol} \left[\mathbb{C}^2; \begin{pmatrix} 0 & 1 & 1 & 1 \\ 1 & 0 & 1 & b \end{pmatrix} \right] \\ &= \operatorname{Vol}_{\mathbb{P}}(\infty, 0, 1, b) = \mathcal{D}(b), \quad \text{and} \end{split}$$

$$\begin{split} B_4^{0011}(F_{\infty},F_0,F_1,F_{(a,b)}) &= \\ &= \operatorname{Vol}\left[\frac{\langle f_1 \rangle + \langle e_1 \rangle + \langle \phi_{11},e_1 - f_2 \rangle + \langle \phi_{ab},e_1 - af_2 \rangle}{\{0\} + \{0\} + \langle \phi_{11} \rangle + \langle \phi_{ab} \rangle}; \left(f_1,e_1,e_1 - f_2,e_1 - af_2\right)\right] \\ &= \operatorname{Vol}\left[V_2/\langle \phi_{11},\phi_{ab} \rangle; \left(f_1,e_1,e_1 - f_2,e_1 - af_2\right)\right] \\ \stackrel{(**)}{=} \operatorname{Vol}\left[\mathbb{C}^2; \left(\begin{array}{cc} 0 & \frac{a-b}{a-1} & 1 & b\\ -b^{-1} & 0 & 1 & a \end{array}\right)\right] \\ &= \operatorname{Vol}_{\mathbb{P}}(\infty,0,1,a/b) = \mathcal{D}(a/b) = -\mathcal{D}(b/a). \end{split}$$

The last equality in the case J = 0011 follows from one of the symmetries in (6.2). The equalities (*) and (**) follow from the notion of equivalence in σ_3 , implemented respectively by the epimorphisms $T_1, T_2 : V_2 \twoheadrightarrow \mathbb{C}^2$ defined as:

$$T_{1} : e_{1} \mapsto (1,0)^{\mathsf{T}}, \qquad e_{2} \mapsto (0,1)^{\mathsf{T}}, \qquad f_{2} \mapsto (0,0)^{\mathsf{T}}, \qquad f_{1} \mapsto (0,0)^{\mathsf{T}}; T_{2} : e_{1} \mapsto \left(\frac{a-b}{a-1},0\right)^{\mathsf{T}}, \qquad e_{2} \mapsto \left(-1,\frac{1-b}{b}\right)^{\mathsf{T}}, \qquad f_{2} \mapsto \left(\frac{1-b}{a-1},-1\right)^{\mathsf{T}}, \qquad f_{1} \mapsto (0,-b^{-1})^{\mathsf{T}}.$$

Note that ker $T_1 = \langle f_1, f_2 \rangle$ and ker $T_2 = \langle \phi_{11}, \phi_{ab} \rangle$. To conclude, we add the terms in (6.6) and use the fact that D satisfies the Spence–Abel equation (4.4):

$$B_4(F_{\infty}, F_0, F_1, F_{(a,b)}) = 4 \mathcal{D}(b) + 2 \left(-\mathcal{D}\left(\frac{a(1-b)}{b(1-a)}\right) + \mathcal{D}\left(\frac{1-b}{1-a}\right) - \mathcal{D}\left(\frac{b}{a}\right) \right)$$
$$= 4 \mathcal{D}(b) + 2 \left(\mathcal{D}(a) - \mathcal{D}(b) \right) = 2 \left(\mathcal{D}(a) + \mathcal{D}(b) \right).$$

6.4. **Proof of Lemma 6.1.** If $\rho : \mathcal{F} \to \mathbb{F}_4$ induced a morphism of L^{∞} -complexes, then it would, by virtue of functoriality [28, Prop. 8.4.2], implement the map res₂ from Lemma 6.1 at the cocycle level, and the injectivity of res₂ would be a consequence of Lemma 6.10. However, since ρ does not preserve measure classes, it cannot possibly induce a map of L^{∞} -spaces. To circumvent this measure theoretical difficulty we will consider the commutative diagram

(6.7)

where the upper indices $(-)^{\delta}$ on groups indicate that they are being regarded as discrete. In words, the map res₂ "factors" over its discrete analogue res₂^{δ}. This observation proves advantageous for us, as the latter map is more tractable than the former at the level of cocycles. As actions of discrete groups, $SL_4(\mathbb{C})^{\delta} \curvearrowright \mathbb{F}_4$ and $SO_4(\mathbb{C})^{\delta} \curvearrowright \mathcal{F}$ are amenable. In fact, their point-stabilizers are isomorphic to upper-triangular subgroups, and hence abstractly solvable. Thus, we have canonical isomorphisms

$$\mathrm{H}^{*}_{\mathrm{b}}(\mathrm{SL}_{4}(\mathbb{C})^{\delta}) \cong \mathrm{H}^{*}(\mathscr{C}^{\infty}(\mathbb{F}^{\bullet+1}_{n})^{\mathrm{SL}_{4}(\mathbb{C})}) \quad \text{and} \quad \mathrm{H}^{*}_{\mathrm{b}}(\mathrm{SO}_{4}(\mathbb{C})^{\delta}) \cong \mathrm{H}^{*}(\mathscr{C}^{\infty}(\mathscr{F}^{\bullet+1})^{\mathrm{SO}_{4}(\mathbb{C})}).$$

Moreover, the now well-defined morphism of complexes

(6.8) $\rho^* : \mathscr{C}^{\infty}(\mathbb{F}_4^{\bullet+1}) \to \mathscr{C}^{\infty}(\mathcal{F}^{\bullet+1})$

implements the restriction $\operatorname{res}_2^{\delta}$: $\operatorname{H}_b^*(\operatorname{SL}_4(\mathbb{C})^{\delta}) \to \operatorname{H}_b^*(\operatorname{SO}_4(\mathbb{C})^{\delta})$ (see [14, Thms. 4.23, 4.15]). Our last ingredient in the proof of Lemma 6.1 is an "equivariant lifting" theorem, due to Monod [29], that will enable the realization at the level of cocycles of the maps id* in the diagram (6.7). For any measure space X, we denote the Banach space of bounded measurable functions $X \to \mathbb{R}$ (without identification modulo null sets) by $\mathscr{L}^{\infty}(X)$. If $\varphi \in \mathscr{L}^{\infty}(X)$, we write $[\varphi]$ for its equivalence class in $L^{\infty}(X)$.

Theorem 6.11 (see [29]). Let G be a locally compact group with an amenable C^1 -action on a differentiable manifold X. Then for every $k \in \mathbb{N}$, there exists a G-equivariant lifting

$$s^k : L^{\infty}(X^{k+1}) \to \mathcal{L}^{\infty}(X^{k+1})$$

of the canonical projection $\mathscr{L}^{\infty}(X^{k+1}) \twoheadrightarrow L^{\infty}(X^{k+1})$ such that:

- (i) s[•] is a morphism of complexes, and
- (ii) if $x \in X^{k+1}$ is a continuity point of a function $\varphi \in \mathscr{L}^{\infty}(X^{k+1})$, then $(s[\varphi])(x) = \varphi(x)$.

About the proof. The existence of the s^k is [29, Thm. A]. For (i), see [29, Rem. 1]. For (ii), see the comment at the end of the proof of [29, Thm. B].

Let us fix a morphism of complexes *s* that results from the composition of an equivariant lifting as in Theorem 6.11 and the surjection $\mathscr{L}^{\infty} \twoheadrightarrow \mathscr{E}^{\infty}$:

(6.9)
$$L^{\infty}(\mathbb{F}_{4}^{\bullet+1}) \xrightarrow{\mathcal{S}} \mathscr{L}^{\infty}(\mathbb{F}_{4}^{\bullet+1}) \xrightarrow{\mathcal{S}} \mathscr{\ell}^{\infty}(\mathbb{F}_{4}^{\bullet+1})$$

Again by functoriality, the morphism *s* implements id^{*} : $H_b^*(SL_4(\mathbb{C})) \to H_b^*(SL_4(\mathbb{C})^{\delta})$ at the level of cocycles. Observe that $s[B_4] = B_4$ on $\mathbb{F}_4^{\{4\}}$ by Lemma 6.5.

Proof of Lemma 6.1. Since $H^3_b(SL_4(\mathbb{C})) \cong \mathbb{R}$, it suffices to prove that the composition res^{δ} \circ id^{*} in the diagram (6.7) is not the zero map. This will follow from exhibiting a non-trivial 3-cocycle in the image of $\rho^* \circ s$, for ρ^* and s as introduced in (6.8) and (6.9), respectively.

Let $[B_4]$ be the class up to null sets of the volume cocycle $B_4 \in \mathscr{L}^{\infty}(\mathbb{F}_4^4)$, and set $\mathcal{B}_2 := (\rho^* \circ s)[B_4] \in \mathscr{L}^{\infty}(\mathcal{F}^4)$. Observe that \mathcal{B}_2 is an SO₄(\mathbb{C})-invariant bounded 3-cocycle. Moreover,

$$\mathcal{B}_{2}(x) = s[B_{4}](\rho^{\times 4}(x)) = B_{4}(\rho^{\times 4}(x)) \text{ for all } x \in \mathcal{F}^{\{4\}},$$

in virtue of Lemma 6.5 and Lemma 6.9 (iii). Thus, we deduce from Lemma 6.10 that \mathcal{B}_2 does not vanish identically on $\mathcal{F}^{\{4\}}$, and this implies that \mathcal{B}_2 is not a coboundary. Indeed, by Lemma 6.9 (ii), any SO₄(\mathbb{C})-invariant function $\varphi \in \ell^{\infty}(\mathcal{F}^3)$ must take a constant value *c* on $\mathcal{F}^{\{3\}}$, and therefore, for every $x \in \mathcal{F}^{\{4\}}$, any coboundary d φ must satisfy the equality

$$d\varphi(x) = \sum_{i=0}^{3} (-1)^{i} \varphi(\partial_{i}(x)) = c - c + c - c = 0.$$

We finish this subsection by computing the norm of the restricted class $res_2(b_4) \in H^3_b(SO_4(\mathbb{C}))$. In particular, this proves that the restrictions res_r need not be isometric in the \mathbf{D}_r case.

Proposition 6.12. The restricted class $\operatorname{res}_2(b_4) \in \operatorname{H}^3_b(\operatorname{SO}_4(\mathbb{C}))$ has Gromov norm equal to $4 v_{\mathbb{H}^3}$, and the map $\operatorname{res}_2 : \operatorname{H}^3_b(\operatorname{SL}_4(\mathbb{C})) \hookrightarrow \operatorname{H}^3_b(\operatorname{SO}_4(\mathbb{C}))$ has operator norm equal to 2/5.

Proof. Let $\mathcal{B}_2 \in \ell^{\infty}(\mathcal{F}^4)$ be the cocycle defined in the proof of Lemma 6.1. Since \mathcal{B}_2 is the restriction of a Borel cocycle, its class $[\mathcal{B}_2] \in L^{\infty}(\mathcal{F}^4)$ is well-defined. Now, as in (6.9), let

$$s': L^{\infty}(\mathcal{F}^{\bullet+1}) \to \ell^{\infty}(\mathcal{F}^{\bullet+1})$$

be the SO₄(\mathbb{C})-equivariant morphism of complexes defined by the composition of a lifting as in Theorem 6.11 and the surjection $\mathscr{L}^{\infty} \twoheadrightarrow \mathscr{\ell}^{\infty}$. Moreover, the equality $s'[\mathcal{B}_2] = \mathcal{B}_2$ holds since \mathcal{B}_2 is continuous on the co-null set $\mathcal{F}^{\{4\}} \subset \mathcal{F}^4$. By [28, Thm. 7.5.3] and the commutativity of the diagram (6.7), we deduce that the norm of res₂(b_4) must equal the norm of the cohomology class defined by $[\mathcal{B}_2]$.

Now, by the essential transitivity of the action $SO_4(\mathbb{C}) \curvearrowright \mathcal{F}^3$ (see Lemma 6.9 (ii)), there are no non-trivial invariant 3-coboundaries in $L^{\infty}(\mathcal{F}^{\bullet+1})$. Hence, $\|\operatorname{res}_2(b_4)\| = \|[\mathcal{B}_2]\|_{\infty} = 4 \cdot v_3$ by Lemma 6.10. For the operator norm of res_2 , note simply that $\|b_4\| = 10 \cdot v_3$.

6.5. End of proof of Theorems 2 and 3. For any $r \ge r_1 = 2$, consider the commutative cube

(6.10)

$$\begin{array}{c}
H_{b}^{3}(G_{r+1}) & \xrightarrow{\cong} H_{b}^{3}(GL_{n(r+1)}(\mathbb{C})) \\
H_{b}^{3}(S_{r+1}) & \xrightarrow{\uparrow} H_{b}^{3}(SL_{n(r+1)}(\mathbb{C})) & \cong \downarrow \\
& \downarrow & \downarrow \\
H_{b}^{3}(G_{r}) & \xrightarrow{\cong} \downarrow \\
& \downarrow & \stackrel{\cong}{\longrightarrow} H_{b}^{3}(GL_{n(r)}(\mathbb{C})) \\
& H_{b}^{3}(S_{r}) & \xrightarrow{res_{r}} H_{b}^{3}(SL_{n(r)}(\mathbb{C}))
\end{array}$$

where the horizontal arrows correspond to the restriction maps

$$\operatorname{res}_{s}: \operatorname{H}^{3}_{b}(\operatorname{SL}_{n(s)}(\mathbb{C})) \to \operatorname{H}^{3}_{b}(S_{s}) \quad \text{and} \quad \operatorname{H}^{3}_{b}(\operatorname{GL}_{n(s)}(\mathbb{C})) \to \operatorname{H}^{3}_{b}(G_{s}),$$

the arrows pointing frontwards to the restriction maps

 $\sigma_{n(s)}: \operatorname{H}^3_{\operatorname{b}}(\operatorname{GL}_{n(s)}(\operatorname{\mathbb{C}})) \to \operatorname{H}^3_{\operatorname{b}}(\operatorname{SL}_{n(s)}(\operatorname{\mathbb{C}})) \quad \text{and} \quad \tau_s: \operatorname{H}^3_{\operatorname{b}}(G_s) \to \operatorname{H}^3_{\operatorname{b}}(S_s)$

for $s \in \{r, r+1\}$, and the vertical arrows to the maps induced by the block inclusions

$$\begin{split} \iota_r &: S_r \hookrightarrow S_{r+1}, \qquad j_r : \operatorname{SL}_{n(r)}(\mathbb{C}) \hookrightarrow \operatorname{SL}_{n(r+1)}(\mathbb{C}), \\ \iota_r &: G_r \hookrightarrow G_{r+1}, \qquad j_r : \operatorname{GL}_{n(r)}(\mathbb{C}) \hookrightarrow \operatorname{GL}_{n(r+1)}(\mathbb{C}), \end{split}$$

Observe that $\sigma_{n(s)}$ is an isomorphism by [28, Cor. 8.5.5] and that τ_s is an injection by [28, Prop. 8.6.2] for both $s \in \{r, r+1\}$, since $S_s < G_s$ is a finite-index normal subgroup. Moreover, the maps j_r^* induced in degree three by j_r , both for GL and SL, are isomorphisms due to Theorem 2 for the \mathbf{A}_r case. By Key Lemma *bis*, the map $\iota_r^* : \mathrm{H}^3_\mathrm{b}(G_{r+1}) \to \mathrm{H}^3_\mathrm{b}(G_r)$ is an injection.

The next lemma will serve as the induction step in the proofs of Theorems 2 bis and 3 bis.

Lemma 6.13. If, for any $r \ge 1$, the map $\operatorname{res}_r : \operatorname{H}^3_b(\operatorname{SL}_{n(r)}(\mathbb{C})) \to \operatorname{H}^3_b(S_r)$ is an isomorphism, then all the arrows in the diagram (6.10) are isomorphisms.

Proof. Note, by examining the bottom face of the cube, that if res_r is an isomorphism, then τ_r is surjective. This, in turn, implies that all the arrows in the bottom face are isomorphisms. Relying on these isomorphisms, a similar analysis of, first, the back face; then, the left face; and finally, the front face of (6.10), complete the proof of the lemma.

Proof of Theorem 3 bis for \mathbf{D}_r . We prove by induction that $\operatorname{res}_r : \operatorname{H}^3_b(\operatorname{SL}_{n(r)}(\mathbb{C})) \to \operatorname{H}^3_b(S_r)$ is an isomorphism for every $r \ge r_0 = 3$. By Lemma 6.13, if res_r is an isomorphism for any $r \ge 3$, then so is res_{r+1} . Thus, the claim follows once we establish that

$$\operatorname{res}_{r_0} = \operatorname{res}_3 : \operatorname{H}^3_{\mathrm{b}}(\operatorname{SL}_6(\mathbb{C})) \to \operatorname{H}^3_{\mathrm{b}}(\operatorname{SO}_6(\mathbb{C}))$$

is an isomorphism. The group $SO_6(\mathbb{C})$ admits an exceptional isogeny $SL_4(\mathbb{C}) \twoheadrightarrow SO_6(\mathbb{C})$, as in e.g. [36, 34], which induces an isomorphism in bounded cohomology [28, Cor. 8.5.2]. After applying Theorem 2 for \mathbf{A}_r , we deduce the chain of isomorphisms

$$\mathrm{H}^{3}_{\mathrm{b}}(\mathrm{SO}_{6}(\mathbb{C})) \cong \mathrm{H}^{3}_{\mathrm{b}}(\mathrm{SL}_{4}(\mathbb{C})) \cong \mathrm{H}^{3}_{\mathrm{b}}(\mathrm{SL}_{6}(\mathbb{C})) \cong \mathbb{R}.$$

Thus, it suffices to prove that res₃ is not identically zero. For this purpose, consider the front face of the commutative cube (6.10), with r = 2. Since the bottom arrow res₂ is injective by Lemma 6.1, we deduce our claim.

Proof of Theorem 2 bis *for* \mathbf{D}_r . By Lemma 6.13, if res_{*r*} is an isomorphism for any $r \ge r_0 = 3$, then so is the map $\iota_r^* : \mathrm{H}^3_{\mathrm{b}}(S_{r+1}) \to \mathrm{H}^3_{\mathrm{b}}(S_r)$. Theorem 3 *bis* finishes the proof.

Remark 6.14. We note that res_2 : $\operatorname{H}^3_b(\operatorname{SL}_4(\mathbb{C})) \hookrightarrow \operatorname{H}^3_b(\operatorname{SO}_4(\mathbb{C}))$ is not an isomorphism, since $\operatorname{H}^3_b(\operatorname{SL}_4(\mathbb{C})) \cong \mathbb{R}$, and $\operatorname{SO}_4(\mathbb{C})$ is isogenous to $\operatorname{SL}_2(\mathbb{C}) \times \operatorname{SL}_2(\mathbb{C})$, which has 2-dimensional H^3_b .

7. PROOF OF THEOREM 1

Let $(\varepsilon, d) \in \{(+1, 1), (-1, 0), (+1, 0)\}$. We will prove Theorem 1 *bis*, that is, that the comparison map $c^3 : H^3_b(S_r) \to H^3(S_r)$ is an isomorphism for all $r \ge r_0$, by induction on *r*.

The base case $r = r_0$ holds due to the exceptional Lie algebra isomorphisms in low rank, which place S_{r_0} inside the \mathbf{A}_r family. For the induction step, consider the commutative diagram

$$\begin{array}{ccc} \mathrm{H}^{3}_{\mathrm{b}}(S_{r+1}) & & \stackrel{c^{3}}{\longrightarrow} \mathrm{H}^{3}(S_{r+1}) \\ & & \stackrel{\iota^{*}_{r}}{\downarrow} \cong & & \cong \downarrow \iota^{*}_{r} \\ \mathrm{H}^{3}_{\mathrm{b}}(S_{r}) & & \stackrel{\cong}{\longrightarrow} \mathrm{H}^{3}(S_{r}) \end{array}$$

The induction hypothesis is the fact that the bottom arrow an isomorphism. That the left arrow is an isomorphism is Theorem 2. That the right one is an isomorphism is the stability of classical families in continuous cohomology, for which we argue as follows. For any non-compact semisimple Lie group G, the continuous cohomology $H^*(G)$ is isomorphic to the cohomology of its compact symmetric space (see e.g. [33, §5]). In the cases covered by Theorem 1, such compact symmetric spaces are diffeomorphic to compact classical groups. The stability of the (space) cohomology of those groups is recorded in [26, Thm. III.6.5]. \Box

8. About the Gromov norm on H^3_b of complex classical groups

For the purpose of this final section, let us adapt the notation introduced in Section 2 to cover also the complex family \mathbf{A}_r , as follows. For $\mathcal{F} \in \{\mathbf{A}, \mathbf{B}, \mathbf{C}, \mathbf{D}\}$, let $S_{\mathcal{F}_r}$ denote, respectively, the group

 $SL_{r+1}(\mathbb{C})$, $SO_{2r+1}(\mathbb{C})$, $Sp_{2r}(\mathbb{C})$, $SO_{2r}(\mathbb{C})$,

in the complex family \mathscr{F}_r . As explained in Subsection 2.2, the choice of $\mathscr{F} \in \{\mathbf{B}, \mathbf{C}, \mathbf{D}\}$ corresponds, respectively, to choosing $(\varepsilon, d) \in \{(+1, 1), (-1, 0), (+1, 0)\}$, and we will assume the notation introduced in Section 2 for those cases.

Let $b_{\mathcal{F}_r} \in \mathrm{H}^3_{\mathrm{b}}(S_{\mathcal{F}_r})$ be the continuous bounded cohomology class defined as

$$b_{\mathcal{F}_r} := \begin{cases} b_{r+1} & \text{if } \mathcal{F} = \mathbf{A}, \\ \frac{1}{2} \operatorname{res}_r(b_{2r+1}) & \text{if } \mathcal{F} = \mathbf{B}, \\ \operatorname{res}_r(b_{2r}) & \text{if } \mathcal{F} = \mathbf{C}, \\ \frac{1}{2} \operatorname{res}_r(b_{2r}) & \text{if } \mathcal{F} = \mathbf{D}, \end{cases}$$

where $b_n \in H^3_b(SL_n(\mathbb{C}))$ is the bounded Borel class, and $\operatorname{res}_r : H^3_b(SL_{n(r)}(\mathbb{C})) \to H^3_b(S_{\mathscr{F}_r})$ is the restriction map.

The next statement is an immediate corollary of Bucher–Burger–Iozzi [3, Thm. 2] (see Theorem 5.1), which gives the computation of the Gromov norm of the bounded Borel class, and of Proposition 4.

Corollary 8.1. For $\mathcal{F} \in \{\mathbf{A}, \mathbf{B}, \mathbf{C}\}$ and $r \geq 1$, the Gromov norm of $b_{\mathcal{F}_r} \in \mathrm{H}^3_{\mathrm{b}}(S_{\mathcal{F}_r})$ is

$$\|b_{\mathscr{F}_r}\| = \mathcal{I}(\mathscr{F}_r) \cdot v_{\mathbb{H}^3},$$

where $v_{\mathbb{H}^3}$ is the maximal volume of an ideal tetrahedron in \mathbb{H}^3 , and the number $\mathcal{I}(\mathcal{F}_r) \in \mathbb{Z}$ is given in the table

\mathscr{F}_r	\mathbf{A}_r	\mathbf{B}_r	\mathbf{C}_r
$\mathcal{I}(\mathcal{F}_r)$	$\frac{r(r+1)(r+2)}{6}$	$\frac{r(r+1)(2r+1)}{3}$	$\frac{r(4r^2-1)}{3}$

It was indicated to us by Marc Burger that the number $\mathcal{I}(\mathscr{F}_r)$ equals the Dynkin index of the principal $SL_2(\mathbb{C})$ -homomorphism $SL_2(\mathbb{C}) \to S_{\mathcal{F}_r}$. We refer the reader to [31] for the definition of Dynkin index, and [24] for the theory of principal $SL_2(\mathbb{C})$ -homomorphisms. The Dynkin index of the principal $SL_2(\mathbb{C})$ -homomorphisms has been computed for all complex simple Lie groups [32], including exceptional ones. For $\mathcal{F} = \mathbf{D}$, it is given by the formula

$$\mathcal{I}(\mathbf{D}_r) = \frac{r(r-1)(2r-1)}{3}.$$

Relying on the equality $||b_{\mathbf{D}_2}|| = 2 v_{\mathbb{H}^3} = \mathcal{I}(\mathbf{D}_2) v_{\mathbb{H}^3}$ established in Proposition 6.12, we conjecture that Corollary 8.1 holds also for $\mathcal{F} = \mathbf{D}$.

APPENDIX A. PROOFS OF CROSS-RATIO PARAMETRIZATION STATEMENTS

This appendix is devoted to the proof of the parametrizations via ω -cross-ratios of the configuration spaces of four and five points in the variety \mathcal{P}_r of isotropic points. These were stated in the main text as Proposition 3.8 and Proposition 3.11, respectively. We continue to adhere to the notation and standing assumptions in Subsections 2.1 and 2.2.

A.1. **Proof of Proposition 3.8.** Let us assume that $r \ge 2$. We consider the Borel functions Γ , Δ , $\Delta^{1/2}$, φ_- , φ_+ : $\mathbb{C}^2 \to \mathbb{C}$, defined as

(A.1)
$$\Gamma(z_1, z_2) := 1 - z_1 - z_2$$

(A.2)
$$\Delta(z_1, z_2) := \Gamma(z_1, z_2)^2 - 2(1 + \varepsilon) \cdot z_1 z_2$$

(A.3)
$$\Delta^{1/2}(z_1, z_2) := \begin{cases} \Gamma(z_1, z_2) & \text{if } \varepsilon = -1, \\ \sqrt{\Delta(z_1, z_2)} & \text{if } \varepsilon = +1, \end{cases}$$

(A.4)
$$\varphi_{\eta}(z_1, z_2) := \left(\frac{\Delta^{1/2} + \eta \Gamma}{2}\right)(z_1, z_2), \quad \eta \in \{\pm 1\},$$

where $\sqrt{-}$: $\mathbb{C} \to \mathbb{C}$ is a Borel choice of complex square root. Abusively, we will use the same symbols to denote the Borel functions $\mathcal{P}_r^4 \to \mathbb{C}$ defined a.e. by precomposing with $\pi_3 = (\mathrm{cr}_1, \mathrm{cr}_2)$.

Definition A.1. We let $\mathcal{P}_r^{\{\{4\}\}}$ be the subset of $\mathcal{P}_r^{\{4\}}$ consisting of tuples (p_0, p_1, p_2, p_3) such that the subspace $\langle p_0, p_1, p_2, p_3 \rangle < V_r$ is non-degenerate (see (3.2) for the definition of $\mathcal{P}_r^{\{4\}}$).

Lemma A.2. A tuple $[v_0, v_1, v_2, v_3] \in \mathcal{P}_r^{(4)}$ belongs to $\mathcal{P}_r^{\{\{4\}\}}$ if and only if the associated Gram matrix $(\omega(v_i, v_j))_{i,j}$ is non-singular. Moreover,

$$\mathcal{P}_{r}^{\{\{4\}\}} = \{(p_{0}, p_{1}, p_{2}, p_{3}) \in \mathcal{P}_{r}^{(4)} \mid \Delta(p_{0}, p_{1}, p_{2}, p_{3}) \neq 0\},\$$

and in particular, $\mathcal{P}_{r}^{\{\{4\}\}}$ is a G_{r} -invariant, co-null Borel subset of \mathcal{P}_{r}^{4} .

Proof. The matrix $(\omega(v_i, v_j))_{i,j}$ is singular if and only if there exists a non-trivial linear combination $v = \sum_i \alpha_i v_i$ such that $\omega(v_k, v) = 0$ for every $k \in \{0, ..., 3\}$. This means precisely that either v = 0 and the vectors $v_0, ..., v_3$ are linearly dependent, or $\langle v_0, ..., v_3 \rangle$ is degenerate. The second part of the lemma follows from the fact that the Gram determinant of $\{v_0, v_1, v_2, v_3\}$ equals the quotient $\Delta[v_0, v_1, v_2, v_3] / (\omega(v_0, v_1) \, \omega(v_2, v_3))^2$.

The subspace $L < V_r$ generated by any four lines $(p_0, p_1, p_2, p_3) \in \mathcal{P}_r^{\{\{4\}\}}$ is isomorphic to the sum $\mathcal{H} \oplus \mathcal{H}$. In Lemma A.5 below, we will construct an adapted basis of L in terms of any such points p_0, p_1, p_2, p_3 . For that purpose, we introduce perpendicular projections with respect to ω onto hyperbolic planes, and list relevant properties.

Definition A.3. Let $\mathcal{H}_0 < V_r$ be a hyperbolic plane and $\{v_0, v_1\}$ a basis of isotropic vectors of \mathcal{H}_0 . The *perpendicular projection* proj = $\operatorname{proj}_{\mathcal{H}_0}$: $V_r \twoheadrightarrow \mathcal{H}_0$ onto \mathcal{H}_0 is given by

$$\operatorname{proj}(v) := \frac{\omega(v_1, v)}{\omega(v_1, v_0)} v_0 + \frac{\omega(v_0, v)}{\omega(v_0, v_1)} v_1,$$

with kernel \mathcal{H}_0^{\perp} . We also let $\hat{\cdot} : V_r \to \mathcal{H}_0^{\perp}$ be the *complement map*, defined as $\hat{v} := v - \operatorname{proj}(v)$.

Lemma A.4. Let $[v_0, v_1, v_2, v_3] \in \mathcal{P}_r^{(4)}$, let $\hat{\cdot}$ denote the complement map to $\langle v_0, v_1 \rangle$, let $v, w \in V_r$ be any two vectors, and let $u \in V_r$ be isotropic. Then the following identities hold:

- (i) $\omega(\hat{v}, \hat{w}) = \omega(\hat{v}, w) = \omega(v, \hat{w}).$
- (ii) $q(\hat{u}) = -(1+\varepsilon) \left(\omega(v_1, u) \, \omega(u, v_0) / \omega(v_0, v_1) \right).$
- (iii) $\omega(\hat{v}_2, \hat{v}_3) = \omega(v_2, v_3) \cdot \Gamma[v_0, v_1, v_2, v_3].$
- (iv) $\omega(\hat{v}_2, \hat{v}_3)^2 q(\hat{v}_2) q(\hat{v}_3) = \omega(v_2, v_3)^2 \cdot \Delta[v_0, v_1, v_2, v_3].$

Proof. Since $\omega(\hat{v}, \operatorname{proj}(w)) = 0$, we have $\omega(\hat{v}, \hat{w}) = \omega(\hat{v}, w) - \omega(\hat{v}, \operatorname{proj}(w)) = \omega(\hat{v}, w)$, the first equality in (i). The second one is analogous. Items (ii) and (iii) follow immediately from

(i) and the definition of the complement map. For $\varepsilon = -1$, the identity (iv) holds since $\Delta = \Gamma^2$ and $q(\hat{v}_2) q(\hat{v}_3) = 0$. If $\varepsilon = +1$, then (iv) follows from (iii) and the next computation:

$$\begin{split} q(\hat{v}_{2}) q(\hat{v}_{3}) &= 4 \cdot \frac{\omega(v_{1}, v_{2}) \,\omega(v_{2}, v_{0})}{\omega(v_{0}, v_{1})} \cdot \frac{\omega(v_{1}, v_{3}) \,\omega(v_{3}, v_{0})}{\omega(v_{0}, v_{1})} \\ &= 4 \cdot \omega(v_{2}, v_{3})^{2} \cdot \frac{\omega(v_{1}, v_{3}) \,\omega(v_{2}, v_{0})}{\omega(v_{1}, v_{0}) \,\omega(v_{2}, v_{3})} \cdot \frac{\omega(v_{2}, v_{1}) \,\omega(v_{0}, v_{3})}{\omega(v_{2}, v_{3}) \,\omega(v_{0}, v_{1})} \\ &= 4 \cdot \omega(v_{2}, v_{3})^{2} \cdot (\operatorname{cr}_{1}^{-1} \cdot \operatorname{cr}_{2})[v_{0}, v_{1}, v_{2}, v_{3}]. \end{split}$$

The following technical lemma plays a key role in the proof of Proposition 3.8.

Lemma A.5. Let $\mathbf{p} = [v_0, v_1, v_2, v_3] \in \mathcal{P}_r^{\{\{4\}\}}$, let $\mathcal{H}_0 := \langle v_0, v_1 \rangle$ be the hyperbolic plane generated by the first two vectors, and let $\hat{\cdot}$ denote the complement map to \mathcal{H}_0 . We also let the quantities $\Pi = \Pi(v_0, v_1, v_2)$, $\lambda = \lambda(v_0, v_1, v_2)$, $\mu = \mu(v_0, v_1, v_2, v_3)$ be defined as

(A.5)
$$\Pi := \omega(v_0, v_1) \, \omega(v_1, v_2) \, \omega(v_2, v_0),$$

(A.6)
$$\lambda := \frac{\sqrt{\Pi}}{\omega(v_1, v_0)} = \frac{\omega(v_1, v_2)\,\omega(v_0, v_2)}{\sqrt{\Pi}}$$

(A.7)
$$\mu := \lambda^{-1} \cdot \omega(v_3, v_2).$$

Then $\mathcal{H}'_0 := \mathcal{H}^{\perp}_0 \cap \langle v_0, v_1, v_2, v_3 \rangle = \langle \hat{v}_2, \hat{v}_3 \rangle$ is a hyperbolic plane, and the unique solutions $e', f' \in \mathcal{H}'_0$ of the next linear systems form an adapted basis of \mathcal{H}'_0 :

(A.8)
$$\left\{\begin{array}{l} \omega(e', v_2) = \lambda \\ \omega(e', v_3) = \mu \varphi_{-}(\mathbf{p}) \end{array}\right\} \text{ and } \left\{\begin{array}{l} \omega(f', v_2) = -\lambda, \\ \omega(f', v_3) = \varepsilon \mu \varphi_{+}(\mathbf{p}), \end{array}\right\}$$

Proof. After writing e' and f' as linear combinations of the basis $\{\hat{v}_2, \hat{v}_3\}$ of \mathcal{H}' , one obtains that the coefficient matrix of both systems in (A.8) has determinant

$$q(\hat{v}_2) q(\hat{v}_3) - \omega(\hat{v}_2, \hat{v}_3)^2 = -\omega(v_2, v_3)^2 \cdot \Delta(\mathbf{p})$$

This quantity is non-zero in virtue of Lemma A.2. Their explicit solutions are:

(A.9) For
$$\varepsilon = -1$$
:
$$\begin{cases} e' = (\lambda/\omega(\hat{v}_3, \hat{v}_2)) \cdot \hat{v}_3, \\ f' = (-\mu/\omega(v_2, v_3)) \cdot \hat{v}_2 - (\lambda/\omega(\hat{v}_3, \hat{v}_2)) \cdot \hat{v}_3 \end{cases}$$
$$\begin{pmatrix} e' = \lambda/q(\hat{v}_2) \cdot (\hat{v}_2 - r) \end{pmatrix}$$

(A.10) For
$$\varepsilon = +1$$
:
$$\begin{cases} e' = \lambda/q(v_2) \cdot (v_2 - r), \\ f' = -\lambda/q(\hat{v_2}) \cdot (\hat{v_2} + r), \end{cases}$$

where

$$r := \frac{\omega(\hat{v}_2, \hat{v}_3) \cdot \hat{v}_2 - q(\hat{v}_2) \cdot \hat{v}_3}{\omega(v_2, v_3) \cdot \Delta^{1/2}(\mathbf{p})} \in \mathcal{H}'.$$

The next identities are consequences of Lemma A.4 and facilitate the computations that verify that e' and f' as above are actually solutions of (A.8) and an adapted basis of \mathcal{H}'_0 :

$$\begin{aligned} (\varepsilon = -1) \quad &\omega(\hat{v}_2, v_2) = q(\hat{v}_2) = 0, \quad &\omega(\hat{v}_3, v_3) = q(\hat{v}_3) = 0, \\ &\omega(\hat{v}_2, v_3) = \omega(v_2, \hat{v}_3) = \omega(\hat{v}_2, \hat{v}_3) = \omega(v_2, v_3) \cdot \Gamma(\mathbf{p}) \\ &= \omega(v_2, v_3) \cdot \Delta^{1/2}(\mathbf{p}) \neq 0. \end{aligned}$$
$$(\varepsilon = +1) \quad &\omega(r, v_2) = \omega(r, \hat{v}_2) = 0, \quad q(r) = -q(\hat{v}_2) = 2\lambda^2 \neq 0, \\ &\omega(r, v_3) = \omega(r, \hat{v}_3) = \omega(v_2, v_3) \cdot \Delta^{1/2}(\mathbf{p}) \neq 0. \end{aligned}$$

Proof of Proposition 3.8. Let $r \ge 2$. The theorem is proven once we establish the existence of a co-null subset $\Omega_3 \subset \mathbb{C}^2$ and a Borel map $\Phi_3 : \Omega_3 \to \mathcal{P}_r^4$ with the next three properties:

(i) $\pi_3(\mathcal{P}_r^{\{\{4\}\}}) \subset \Omega_3$. (ii) $\Phi_3(\Omega_3) \subset \mathcal{P}_r^{\{\{4\}\}}$ and $\pi_3 \circ \Phi_3 = \text{id}$. (iii) For all $\mathbf{p} \in \mathcal{P}_r^{\{\{4\}\}}$, there exists $g \in G_r$ such that $\Phi_3 \circ \pi_3(\mathbf{p}) = g \mathbf{p}$.

We proceed now to their construction. Let us define

(A.11)
$$\Omega_3 := \left\{ (a_1, a_2) \in (\mathbb{C}^{\times})^2 \mid \Delta(a_1, a_2) \neq 0 \right\}$$

Note that Ω_3 is a non-empty Zariski-open subset of \mathbb{C}^2 , hence co-null, and condition (i) follows immediately from Lemma A.2. We define the isotropic vector ϕ_2 and the Borel map $\phi_3: \Omega_3 \to \langle e_r, e_{r-1}, f_{r-1}, f_r \rangle$ by

$$\begin{split} \phi_2 &:= e_r + e_{r-1} - f_{r-1} + f_r, \\ \phi_3(a_1, a_2) &:= a_1 e_r + \varphi_-(a_1, a_2) e_{r-1} + \varepsilon \,\varphi_+(a_1, a_2) f_{r-1} + \varepsilon \,a_2 f_r. \end{split}$$

The vector $\phi_3(a_1, a_2)$ is isotropic for any $(a_1, a_2) \in \Omega_3$. We let now $\Phi_3 : \Omega_3 \to \mathcal{P}_r^4$ be the map

(A.12)
$$\Phi_3(a_1, a_2) := \left[e_r, f_r, \phi_2, \phi_3(a_1, a_2)\right]$$

The first three points in the triple are precisely the representative generic 3-tuple used in the proof of Lemma 3.4. After abbreviating $\phi_3 \equiv \phi_3(a_1, a_2)$, the identities given below hold true, implying that none of those quantities is zero and, hence, that Φ_3 ranges onto $\mathcal{P}_r^{(4)}$.

(A.13)
$$\begin{aligned} \omega(e_r, f_r) &= 1, \qquad \omega(e_r, \phi_2) = 1, \qquad \omega(e_r, \phi_3) = \varepsilon a_2, \\ \omega(f_r, \phi_2) &= \varepsilon, \qquad \omega(f_r, \phi_3) = \varepsilon a_1, \qquad \omega(\phi_2, \phi_3) = \varepsilon. \end{aligned}$$

From (A.13), we also derive that $\operatorname{cr}_i \left(\Phi_3(a_1, a_2) \right) = a_i$ for i = 1, 2. Together with Lemma A.2, this implies that $\Phi_3(a_1, a_2)$ is in $\mathcal{P}_r^{\{\{4\}\}}$ and that $\pi_4 \circ \Phi_3(a_1, a_2) = (a_1, a_2)$, establishing (ii).

For (iii), we fix an arbitrary $\mathbf{p} = [v_0, v_1, v_2, v_3] \in \mathcal{P}_r^{\{\{4\}\}}$. As in Lemma A.5, we let λ, Π, μ be the quantities defined in function of (v_0, v_1, v_2, v_3) from (A.5)–(A.7), and e', f' be the

solutions of the systems (A.8). Then we set

(A.14)
$$e'_r := \frac{\lambda v_1}{\omega(v_1, v_2)}, \quad e'_{r-1} := e', \quad f'_{r-1} := f', \quad f'_r := \frac{\omega(v_1, v_2) v_0}{\sqrt{\Pi}}.$$

Observe that $\{e'_r, f'_r\}$ is an adapted basis of the hyperbolic plane $\mathcal{H}_r := \langle v_0, v_1 \rangle < V_r$, and that $\{e'_{r-1}, f'_{r-1}\}$ is an adapted basis of $\mathcal{H}_{r-1} := \mathcal{H}_r^{\perp} \cap \langle v_0, v_1, v_2, v_3 \rangle$. By Witt's lemma, we extend $\{e'_r, e'_{r-1}, f'_{r-1}, f'_r\}$ to a full adapted basis \mathcal{B}'_r of V_r . The automorphism $T \in GL(V_r)$ that maps the standard adapted basis \mathcal{B}_r to \mathcal{B}'_r lies in G_r , and therefore, so does

(A.15)
$$g = g(v_0, v_1, v_2, v_3) := T^{\top} J_r$$

Note that for every $i \in \{0, ..., 3\}$, we have

$$g \cdot v_i = \omega(e'_r, v_i) e_r + \omega(e'_{r-1}, v_i) e_{r-1} + \omega(f'_{r-1}, v_i) f_{r-1} + \omega(f'_r, v_i) f_r$$

Writing in coordinates with respect to the standard adapted basis \mathscr{B}_r , we have the equalities below, where the second one follows after multiplying the fourth vector by μ^{-1} :

$$g \cdot \mathbf{p} = \begin{bmatrix} 1 & 0 & \lambda & \lambda \, \omega(v_1, v_3) / \omega(v_1, v_2) \\ 0 & 0 & \lambda & \mu \, \varphi_-(\mathbf{p}) \\ \mathbf{0} & \mathbf{0} & \mathbf{0} & \mathbf{0} \\ 0 & 0 & -\lambda & \varepsilon \, \mu \, \varphi_+(\mathbf{p}) \\ 0 & 1 & \lambda & \omega(v_1, v_2) \, \omega(v_0, v_3) / \sqrt{\Pi} \end{bmatrix} = \Phi_3 \circ \pi_3(\mathbf{p}).$$

A.2. **Proof of Proposition 3.11.** Recall the cross-ratios $\alpha_j, \beta_j, \gamma_j : \mathcal{P}_r^5 \to \mathbb{C}$ from Definition 3.9. With the notation established in (A.1)–(A.4), we set $\psi_-, \psi_+ : \mathbb{C}^6 \to \mathbb{C}$ to be a.e.

(A.16)
$$\psi_{\eta}(\mathbf{a}, \mathbf{b}, \mathbf{c}) := \eta \, \varphi_{\eta}(\mathbf{a}) \cdot \Gamma(\mathbf{b}) + a_2 b_1 c_1^{-1} \cdot \Gamma(\mathbf{c}), \quad \eta \in \{\pm 1\},$$

for $\mathbf{a} = (a_1, a_2)$, $\mathbf{b} = (b_1, b_2)$, $\mathbf{c} = (c_1, c_2)$. Let also Γ_{α} , Γ_{β} , $\Gamma_{\gamma} : \mathcal{P}_r^5 \to \mathbb{C}$ be the functions defined a.e. as

$$\Gamma_{\alpha} := \Gamma \circ (\alpha_1, \alpha_2), \quad \Gamma_{\beta} := \Gamma \circ (\beta_1, \beta_2), \quad \Gamma_{\gamma} := \Gamma \circ (\gamma_1, \gamma_2).$$

In this subsection, we will consider Δ , $\Delta^{1/2}$, φ_{η} , ψ_{η} a.e. defined functions $\mathcal{P}_{r}^{5} \rightarrow \mathbb{C}$ of 5-tuples after precomposing the expressions from (A.2)–(A.4) with the function (α_{1}, α_{2}), and the expression from (A.16) with ($\alpha_{1}, \alpha_{2}, \beta_{1}, \beta_{2}, \gamma_{1}, \gamma_{2}$).

The proof of Proposition 3.11 builds up on the computations of the previous subsection. The next lemma establishes the result of pairing the vectors e', f' obtained in Lemma A.5 from a tuple $[v_0, v_1, v_2, v_3] \in \mathcal{P}_r^{\{\{4\}\}}$ with a fifth vector v_4 . Its proof is a direct computation that we shall omit, relying on the explicit expressions of e' and f' given in (A.9) and (A.10).

Lemma A.6. Let $[v_0, v_1, v_2, v_3] \in \mathcal{P}_r^{\{\{4\}\}}$, let $\widehat{\cdot}$ be the complement map onto the hyperbolic plane $\langle v_0, v_1 \rangle$ spanned by the first two vectors, and let λ, μ, e', f' be as in Lemma A.5. If an isotropic vector $v_4 \in V_r \setminus \{0\}$ is such that $\mathbf{p} := [v_0, v_1, v_2, v_3, v_4]$ lies in $\mathcal{P}_r^{(5)}$, then

$$\omega(e', v_4) = \varepsilon \frac{\omega(v_2, v_4)}{\lambda} \cdot \frac{\psi_-(\mathbf{p})}{\Delta^{1/2}(\mathbf{p})} \quad \text{and} \quad \omega(f', v_4) = \frac{\omega(v_2, v_4)}{\lambda} \cdot \frac{\psi_+(\mathbf{p})}{\Delta^{1/2}(\mathbf{p})}$$

We give our definition of genericity for 5-tuples at this point, and then prove Proposition 3.11.

Definition A.7. We let $\mathcal{P}_r^{\{5\}\}}$ be the set of 5-tuples $(p_0, p_1, p_2, p_3, p_4) \in \mathcal{P}_r^{\{5\}}$ such that every 4-subtuple is in $\mathcal{P}_r^{\{\{4\}\}}$. In virtue of Lemma 3.10, such a tuple is in $\mathcal{P}_r^{\{\{5\}\}}$ if and only if

$$(p_0, p_1, p_i, p_j) \in \mathcal{P}_r^{\{\{4\}\}}$$
 for $i, j \in \{2, 3, 4\}$ with $i < j$

One verifies that $\mathcal{P}_5^{\{\{5\}\}}$ is a G_r -invariant, co-null subset of \mathcal{P}_r^5 .

Proof of Proposition 3.11. For every $r \ge r_1 + 1$, we must define a co-null subset $\Omega_4 \subset \mathbb{C}^5$ and a Borel map $\Phi_4 : \Omega_4 \to \mathcal{P}_r^5$ such that:

- (i) $\pi_4(\mathcal{P}_r^{\{\{5\}\}}) \subset \Omega_4$.
- (ii) $\Phi_4(\Omega_4) \subset \mathcal{P}_r^{\{\{5\}\}}$ and $\pi_4 \circ \Phi_4 = \text{id.}$
- (iii) For all $\mathbf{p} \in \mathcal{P}_r^{\{\{5\}\}}$, there exists $g \in G_r$ such that $\Phi_4 \circ \pi_4(\mathbf{p}) = g \mathbf{p}$.

We leave out the case $(\varepsilon, d) = (+1, 1)$, r = 2 for individual consideration, and assume that

$$r \ge \begin{cases} 3 & \text{if } \varepsilon = +1, \\ 2 & \text{if } \varepsilon = -1, \end{cases}$$

Similarly to the definition of Ω_3 in (A.11), we let

(A.17)
$$\Omega_4 := \left\{ (a_1, a_2, b_1, b_2, c_1) \in (\mathbb{C}^{\times})^5 \mid \Delta(a_1, a_2), \, \Delta(b_1, b_2), \, \Delta(c_1, c_2) \neq 0 \right\},$$

where $c_2 := \varepsilon(a_1b_2c_1)/(a_2b_1)$. Being an intersection of finitely many non-empty Zariskiopen subsets of \mathbb{C}^5 , the set Ω_4 is itself non-empty and Zariski-open, in particular co-null. Definition A.7 and Lemma A.2 imply that $\Delta(\alpha_1(\mathbf{p}), \alpha_2(\mathbf{p})), \Delta(\beta_1(\mathbf{p}), \beta_2(\mathbf{p})), \Delta(\gamma_1(\mathbf{p}), \gamma_2(\mathbf{p})) \neq 0$ for every $\mathbf{p} \in \mathcal{P}_r^{\{\{5\}\}}$, establishing (i).

We define the functions $\tilde{\phi}_4 : \Omega_4 \to \langle e_r, e_{r-1}, f_{r-1}, f_r \rangle$ and $\phi_4 : \Omega_4 \to V_r$ as

(A.18)
$$\begin{split} \tilde{\phi}_{4}(\mathbf{a},\mathbf{b},c_{1}) &:= b_{1} e_{r} + \frac{\psi_{-}(\mathbf{a},\mathbf{b},\mathbf{c})}{\Delta^{1/2}(\mathbf{a})} e_{r-1} + \varepsilon \frac{\psi_{+}(\mathbf{a},\mathbf{b},\mathbf{c})}{\Delta^{1/2}(\mathbf{a})} f_{r-1} + \varepsilon b_{2} f_{r}, \\ \phi_{4}(\mathbf{a},\mathbf{b},c_{1}) &:= \tilde{\phi}_{4}(\mathbf{a},\mathbf{b},c_{1}) + \left\{ e_{r-2} - \left(\frac{q(\tilde{\phi}_{4}(\mathbf{a},\mathbf{b},c_{1}))}{2}\right) \cdot f_{r-2} \right\}, \end{split}$$

with **a**, **b**, **c** as in (A.16) and $c_2 := \epsilon(a_1b_2c_1)/(a_2b_1)$. Observe that if $\epsilon = +1$, the vector $\tilde{\phi}_4(\mathbf{a}, \mathbf{b}, c_1)$ is not necessarily isotropic. In virtue of the assumption that $r \ge 3$ in that setting, we are able to incorporate in $\phi_4(\mathbf{a}, \mathbf{b}, c_1)$ a correction that makes it isotropic for any $(\mathbf{a}, \mathbf{b}, c_1)$.

We define $\Phi_4: \Omega_4 \to \mathcal{P}_r^5$,

$$\Phi_4(\mathbf{a},\mathbf{b},c_1) := \left[e_r, f_r, \phi_2, \phi_3(\mathbf{a}), \phi_4(\mathbf{a},\mathbf{b},c_1) \right].$$

Note that the first four lines in $\Phi_4(\mathbf{a}, \mathbf{b}, c_1)$ correspond to the tuple $\Phi_3(\mathbf{a})$ introduced in (A.12). Abbreviating $\phi_3 \equiv \phi_3(\mathbf{a})$ and $\phi_4 \equiv \phi_4(\mathbf{a}, \mathbf{b}, c_1)$, we obtain, in addition to (A.13), the identities

(A.19) $\omega(e_r,\phi_4) = \varepsilon b_2, \quad \omega(f_r,\phi_4) = \varepsilon b_1, \quad \omega(\phi_2,\phi_4) = \varepsilon, \quad \omega(\phi_3,\phi_4) = a_2 b_1 c_1^{-1}.$

In particular, this proves that Φ_4 ranges in $\mathcal{P}_r^{(5)}$. From (A.13) and (A.19), we derive

$$\begin{aligned} &\alpha_1 \left(\Phi_4(\mathbf{a}, \mathbf{b}, c_1) \right) = a_1, \qquad \beta_1 \left(\Phi_4(\mathbf{a}, \mathbf{b}, c_1) \right) = b_1, \qquad \gamma_1 \left(\Phi_4(\mathbf{a}, \mathbf{b}, c_1) \right) = c_1, \\ &\alpha_2 \left(\Phi_4(\mathbf{a}, \mathbf{b}, c_1) \right) = a_2, \qquad \beta_2 \left(\Phi_4(\mathbf{a}, \mathbf{b}, c_1) \right) = b_2. \end{aligned}$$

This implies that $\pi_4 \circ \Phi_4 = \text{id}$ and that every 4-subtuple of $\Phi_4(\mathbf{a}, \mathbf{b}, c_1)$ lies in $\mathcal{P}_r^{\{\{4\}\}}$. In order to conclude that $\Phi_4(\mathbf{a}, \mathbf{b}, c_1) \in \mathcal{P}_r^{\{\{5\}\}}$ holds, it suffices to observe that if dim $(V_r) = 2r + d \ge 5$, then necessarily r > 2, so that the correction term in (A.18) is non-zero, and hence, the lines in $\Phi_4(\mathbf{a}, \mathbf{b}, c_1)$ are linearly independent. This proves point (ii).

For (iii), fix an arbitrary $\mathbf{p} = [v_0, v_1, v_2, v_3, v_4] \in \mathcal{P}_r^{\{\{5\}\}}$ and let $\{e'_r, e'_{r-1}, f'_{r-1}, f'_r\}$ be the adapted basis of the subspace $\langle v_0, v_1, v_2, v_3 \rangle$,

$$e'_r := \frac{\lambda v_1}{\omega(v_1, v_2)}, \quad e'_{r-1} := e', \quad f'_{r-1} := f', \quad f'_r := \frac{\omega(v_1, v_2) v_0}{\sqrt{\Pi}},$$

defined as in (A.14), where Π , λ , μ , e', f' are functions of (v_0, v_1, v_2, v_3) as in Lemma A.5. Let also $g = g(v_0, v_1, v_2, v_3) \in G_r$ be the element from (A.15), so that

$$g \cdot [v_0, v_1, v_2, v_3] = \Phi_3(\pi_3(\mathbf{p})).$$

Let $x_0 \in \langle v_0, v_1, v_2, v_3 \rangle^{\perp}$ be the vector such that

$$g \cdot v_4 = x_0 + \omega(e'_r, v_4) e_r + \omega(e'_{r-1}, v_4) e_{r-1} + \omega(f'_{r-1}, v_4) f_{r-1} + \omega(f'_r, v_4) f_r.$$

Since the span of the lines in $g[v_0, v_1, v_2, v_3]$ equals $\langle e_r, e_{r-1}, f_{r-1}, f_r \rangle$, we have that $x_0 \neq 0$ whenever r > 2. In coordinates with respect to \mathscr{B}_r , we have

$$g \cdot [v_4] = \begin{bmatrix} \omega(e'_r, v_4) \\ \omega(e'_{r-1}, v_4) \\ x_0 \\ \omega(f'_{r-1}, v_4) \\ \omega(f'_{r-1}, v_4) \\ \omega(f'_r, v_4) \end{bmatrix} = \begin{bmatrix} \lambda \omega(v_1, v_4) / \omega(v_1, v_2) \\ \varepsilon \frac{\omega(v_2, v_4)}{\lambda} \cdot \frac{\psi_-(\mathbf{p})}{\Delta^{1/2}(\mathbf{p})} \\ \frac{\omega(v_2, v_4)}{\lambda} \cdot \frac{\psi_+(\mathbf{p})}{\Delta^{1/2}(\mathbf{p})} \\ \omega(v_1, v_2) \omega(v_0, v_4) / \sqrt{\Pi} \end{bmatrix} = \begin{bmatrix} \beta_1(\mathbf{p}) \\ \frac{\psi_-(\mathbf{p})}{\Delta^{1/2}(\mathbf{p})} \\ \varepsilon \frac{\psi_+(\mathbf{p})}{\Delta^{1/2}(\mathbf{p})} \\ \varepsilon \beta_2(\mathbf{p}) \end{bmatrix}$$

where $x'_0 := \epsilon \lambda / \omega(v_2, v_4) \cdot x_0 \neq 0$. Indeed, the last equality holds by Lemma 3.10, which implies that $\gamma_2(\mathbf{p}) = \epsilon(\alpha_1 \alpha_2^{-1} \beta_1^{-1} \beta_2 \gamma_1)(\mathbf{p})$.

Note that there exists an element $g' \in G_{r-2} < G_r$ such that $g'x_0 = e_{r-2} + (q(x'_0)/2) f_{r-2}$, and that

$$q(\mathbf{x}_0') = -q\big(\tilde{\phi}_4\left(\pi_4(\mathbf{p})\right).$$

Therefore, $(g'g) \cdot \mathbf{p} = \Phi_4 \circ \pi_4(\mathbf{p})$, completing the proof of (iii).

The proof for the case $(\varepsilon, d) = (+1, 1), r = 2$ is analogous, but requires a few modifications. We must replace everywhere in the argument above the set Ω_4 as in (A.17) by its co-null subset $\Omega'_4 \subset \Omega_4$ defined below, and the map ϕ_4 from (A.18) by $\phi'_4 : \Omega'_4 \to V_r$:

$$\Omega_4' := \left\{ (\mathbf{a}, \mathbf{b}, c_1) \in \Omega_4 \mid q(\tilde{\phi}_4(\mathbf{a}, \mathbf{b}, c_1)) \neq 0 \right\},$$

$$\phi_4'(\mathbf{a}, \mathbf{b}, c_1) := \tilde{\phi}_4(\mathbf{a}, \mathbf{b}, c_1) + \sqrt{-q(\tilde{\phi}_4(\mathbf{a}, \mathbf{b}, c_1))} \cdot h.$$

Remark A.8. The isomorphism $G_1 \setminus \mathcal{P}_1^5 \cong \mathbb{C}^2$ of Lebesgue spaces holds for the parameters $(\varepsilon, d) \in \{(+1, 1), (-1, 0)\}$. Indeed, in the classical setting (see Remark 3.7), any 5-tuple $\mathbf{p} \in \mathcal{P}_1^{\{\{5\}\}}$ is in the G_1 -orbit of the tuple $(\infty, 0, 1, a, b) \in \widehat{\mathbb{C}}^5$ with $a = \alpha_0(\mathbf{p})$ and $b = \beta_0(\mathbf{p})$.

In the other case that is not covered by Proposition 3.11, namely $(\varepsilon, d) = (+1, 0)$ and r = 2, low dimensionality forces the extra relation $q(\tilde{\phi}_4(\pi_4(\mathbf{p}))) = 0$, which causes that $G_2 \setminus \mathcal{P}_2^5 \cong \mathbb{C}^4$.
