# LIMITING CONFIGURATIONS FOR THE SU(1,2) HITCHIN EQUATION

#### Abstract

We study the limiting behavior of the solutions $h_{t}$ of the Hitchin's equation associated with a family of stable $\mathrm{SU}(1,2)$ Higgs bundles $(L, F, t \beta, t \gamma)$ on a compact connected Riemann surface $X$ as $t \rightarrow \infty$ under the assumption that the quadratic differential $q=\beta \cdot \gamma$ have simple zeros at $D$. The spectral data of the $\mathrm{SU}(1,2)$ Higgs bundle $(L, F, \beta, \gamma)$ can be represented by a Hecke modification of $V=L^{-2} K_{X} \oplus L K_{X}$. We show by a gluing construction that after appropriate rescaling, the limit is given by a metric on $V$ singular at $D$, induced by harmonic metrics adapted to parabolic structures on $L$ and on $K_{X}$ at $D$. We give rules to determine the parabolic weights of the limit.


## 1. Introduction

Let $X$ be a compact connected Riemann surface of genus $g \geq 2$ with a Kähler form $\omega$ with $\int_{X} \omega=2 \pi$. Let $\left(E, h_{0}\right)$ be a rank $r$ holomorphic Hermitian vector bundle and $\Phi \in \Omega^{1,0}(\operatorname{End}(E))$. The Hitchin's self-duality equation is an equation of the pair $(A, \Phi)$ :

$$
i \Lambda_{\omega}\left(F_{A}+\left[\Phi \wedge \Phi^{*}\right]\right)=\mu, \bar{\partial}_{A} \Phi=0
$$

with $\mu=\operatorname{deg}(E) / r, A$ an $h_{0}$-unitary connection, $\Phi^{*}$ the $h_{0}$-adjoint of $\Phi$. This is equivalent to the Hermitian-Yang-Mills equation

$$
i \Lambda_{\omega}\left(F_{\nabla_{h}}+\left[\Phi \wedge \Phi^{*_{h}}\right]\right)=\mu
$$

with $\nabla_{h}$ Chern connection of $h$. It was studied by Hitchin [Hit87] as dimension reduction of the self-dual Yang-Mills equation. Together with the work Simpson [Sim88], the gauge-theoretic moduli space of its irreducible solutions $\mathcal{M}$, called Hitchin moduli space, is identified with the moduli space of stable Higgs bundles $(E, \Phi)$. The rich structures on $\mathcal{M}$ build bridges between the fields of algebraic geometry, symplectic geometry and topology.

An important feature of $\mathcal{M}$ is the Hitchin map Hit : $\mathcal{M} \rightarrow \mathcal{B}$ given by taking the characteristic polynomial of $\Phi$. The space of coefficients $\mathcal{B}=\bigoplus_{j} H^{0}\left(X, K_{X}^{j}\right)$ is a finite dimensional vector space. Equivalently $\mathcal{B}$ parametrizes the space of spectral curves: for $b \in \mathcal{B}$, the curve $\Sigma_{b} \subset\left|K_{X}\right|$ may be viewed as marking eigenvalues of $\Phi$. It is given by divisor $\operatorname{det}\left(\lambda-p^{*} \Phi\right)$ of $p^{*} K_{X}^{r}$ where $p:\left|K_{X}\right| \rightarrow X$ is the projection and $\lambda \in p^{*} K_{X}$ is the tautological section. For generic choice of $b \in \mathcal{B}, \Sigma_{b}$ is smooth.

The Hitchin moduli space $\mathcal{M}$ is not compact. As a consequence of Uhlenbeck's weak compactness, both $\|\Phi\|_{L^{2}}$ and the Hitchin map are proper (see proofs in [Wen16]).

[^0]A sequence $\left(E_{j}, \Phi_{j}\right)$ on $\mathcal{M}$ escapes to infinity only if $\left\|\Phi_{j}\right\|_{L^{2}} \rightarrow \infty$ and $\operatorname{Hit}\left(\Phi_{j}\right) \rightarrow \infty$ on $\mathcal{B}$. It is an interesting problem to study the limiting behavior of the family of stable Higgs bundles $(E, t \Phi)$ as $t \rightarrow \infty$. Gaiotto-Moore-Netizkhe [GMN10] conjectured that as radial variable $t \rightarrow \infty$ on the Hitchin base, the natural hyperkähler metric the Hitchin metric on $\mathcal{M}$ is asymptotic to a semi-flat metric, constructed from the special Kähler structure on $\mathcal{B}$. Inspired by this work, Mazzeo-Swoboda-Weiß-Witt [MSWW16] studied the above family for rank-two Higgs bundles where the quadratic differential det $\Phi$ has simple zeros. This condition is equivalent to the spectral curve being smooth. In particular they constructed solutions $h_{\infty}$ called limiting configurations which solve the decoupled version of the Hitchin's equation

$$
F_{\nabla_{h_{\infty}}}^{\perp}=0,\left[\Phi \wedge \Phi^{*_{h_{\infty}}}\right]=0
$$

where $\perp$ it the trace-free part. They then showed that for each $h_{\infty}$ there is a family $(E, t \Phi)$ whose Hermitian-Yang-Mills metric $h_{t}$ converge in $C^{\infty}$ sense to it, away from the zeros of $\operatorname{det} \Phi$. Fredrickson [Fre18] extended the convergence result to arbitrary rank with smooth spectral curve. Mochizuki [Moc16] obtained similar convergence (after appropriate rescaling) more generally for any rank-two Higgs bundle with generically semisimple Higgs field.

The situation of limiting behaviors in higher rank with a singular spectral curve is more complicated and largely unexplored. The choice of the real form $\operatorname{SU}(1,2)$ of the complex Lie group $\operatorname{SL}(3, \mathbb{C})$ thus provides a natural next step in this direction. In generic case, its spectral curve is reduced with two irreducible components meeting at nodal singularities and the form of the Higgs field is more restrained than the general $\operatorname{SL}(3, \mathbb{C})$-Higgs bundle with same spectral curve.

An $\operatorname{SU}(1,2)$ Higgs bundle is given by a triple $(F, \beta, \gamma)$, or equivalently an $\operatorname{SL}(3, \mathbb{C})$ Higgs bundle of the form

$$
\left(E=L \oplus F, \Phi=\left(\begin{array}{ll}
0 & \beta  \tag{1}\\
\gamma & 0
\end{array}\right)\right)
$$

where $L=\operatorname{det} F^{*}, q=\gamma \circ \beta \in H^{0}\left(X, K_{X}^{2}\right)$ is a quadratic differential and the spectral curve $\Sigma$ is given by the divisor $Z\left(\lambda\left(\lambda^{2}-q\right)\right)$ on $\left|K_{X}\right|$. We assume all zeros of $q$ are simple and let $D=p_{1}+\ldots+p_{4 g-4}$ be the zero divisor. Therefore $\Sigma$ has $4 g-4$ simple nodes. The goal of this article is to study the limiting behavior of the Hermitian-Yang-Mills metric $h_{t}$ for such a family $(F, t \beta, t \gamma)$ of stable $\mathrm{SU}(1,2)$ Higgs bundle as $t \rightarrow \infty$.

In order to describe the $\mathrm{SU}(1,2)$ limiting configuration, we need a good description of the Hitchin fiber of the Hitchin map $\mathcal{M}_{\mathrm{SU}(1,2)} \rightarrow \mathcal{B}_{\mathrm{SU}(1,2)}=H^{0}\left(X, K_{X}^{2}\right)$. This is provided by the author in [Na2]: with $L$ and $q$ fixed, the data in $(F, \beta, \gamma)$ is equivalent to a holomorphic Hecke modification of $L^{-2} K_{X} \oplus L K_{X}$ at $D$ : an injective map of $O_{X^{-}}$ modules $\iota: F \rightarrow L^{-2} K_{X} \oplus K_{X}$ isomorphic over $X-D$. Solutions $h_{\infty}$ of the decoupled equation has the form

$$
h_{\infty}=\iota^{*}\left(h_{L}^{-2} h_{K} \oplus h_{L} h_{K}\right)
$$

with $h_{K}$ resp. $h_{L}$ metrics on $K_{X}$ resp. $L$ such that induced metric on $K_{X}^{2}$ satsifies $|q| \equiv 1$ and $h_{L}$ is a harmonic metric adapted to filtered line bundle $(L, \lambda)$ for some weights with $\sum_{j} \lambda_{j}=-\operatorname{deg} L$. The difference between two Hermitian metrics is an automorphism. We write $h^{\prime}=h \cdot g$ if $h^{\prime}(\sigma, \mu)=h(g \sigma, \mu)$ and we say that $h_{t} \rightarrow h_{\infty}$ in
$C^{\infty}$ if $h_{t}=h_{\infty} \cdot g_{t}$ and $g_{t} \rightarrow 1$ in $C^{\infty}$ under some fixed background metric. The main result of this article is the following

Theorem 1.1. Fix $x_{0} \in X-D,\left.v_{0} \in L\right|_{x_{0}}$ and $X_{0} \subset X-D$ a compact set. Let $h_{t}$ be Hermitian-Yang-Mills metric of $(F, t \beta, t \gamma)$ and $\iota: F \rightarrow L^{-2} K_{X} \oplus L K_{X}$ the Hecke modification corresponding to ( $F, \beta, \gamma$ ). Identify the two bundles by ı over $X-D$ and let $\widetilde{h}_{t}$ the normalization of $h_{t}$ (by a diagonal automorphism) such that

$$
\left|\left(v_{0}^{-2} \sqrt{q\left(x_{0}\right)}, 0\right)\right|=\left|\left(0, v_{0} \sqrt{q\left(x_{0}\right)}\right)\right|=1
$$

Let $h_{\infty}=h_{L, \infty}^{-2} h_{K} \oplus h_{L, \infty} h_{K}$ where $h_{L, \infty}$ is adapted to the filtered bundle $\left(L, \lambda_{\infty}\right)$ over $(X, D)$ such that

- $\lambda_{\infty, j}=1 / 4($ resp. $-1 / 4)$ for $\beta\left(p_{j}\right)=0\left(\operatorname{resp} . \gamma\left(p_{j}\right)=0\right)$, and
- $\lambda_{\infty, j}$ is a constant independent of $j$ for $\beta\left(p_{j}\right), \gamma\left(p_{j}\right) \neq 0$
- $\sum_{j} \lambda_{\infty, j}=-\operatorname{deg} L$

Then we have

$$
\widetilde{h}_{t} \xrightarrow{i n C^{\infty}} h_{\infty} \text { as } t \rightarrow \infty
$$

The method of proof is a combination of that in MSWW16] and [Moc16]. In [MSWW16], the authors constructed an approximate solution $h_{t}^{\text {app }}$ by gluing local model solutions on small disks around points in $D$ to a limiting configuration. The local model solution has an explicit form in terms of solutions of an ODE of Painlevé III type, asymptotic to the limiting configuration outside the disk when $t \gg 1$. They then showed by contraction mapping principle that for $t \gg 1$ there is a Hermitian-YangMills metric $h_{t}$ close to $h_{t}^{\text {app }}$. Let $\mathcal{H}_{t}(u)=F_{\nabla_{h^{\prime}}}+\left[\Phi \wedge \Phi^{* h^{\prime}}\right]$ where $h^{\prime}=h_{t}^{\text {app }} \cdot e^{u}$. The key estimates are certain lower bounds of the operator $L_{t}$ given by linearizing $\mathcal{H}_{t}$ at $u=0$. In [Moc16] an explicit local model is not readily available, the author instead relied on existence theorem of Hermitian-Yang-Mills metric for wild harmonic bundle by Biquard-Boalch $[\overline{\mathbf{B B 0 4}]}$ and convergence is not proven through contraction mapping principle. As a consequence, the rate of convergence to limiting configuration is not given in [Moc16].

The local model solution needed to prove Theorem 1.1 is constructed as follows. Note first there are three types of simple zeros of $q=\gamma \circ \beta$. It can either be a zero of $\beta$, a zero of $\gamma$ or neither. The Hecke modification map $\iota: F \rightarrow L^{-2} K_{X} \oplus L K_{X}$ provides a choice of local frames in which the Higgs field has a certain standard local form near each type of zero. For the first two types, we use an explicit local model solution in terms of Painlevé transcendentals. Near the boundary of the disk for $t \gg 1$, these local models are asymptotic to the decoupled solution with parabolic weight on $L$ given by $\lambda= \pm 1 / 4$. For the last type, we apply Biquard-Boalch theorem and construct it from a wild harmonic bundle over $\mathbb{P}^{1}$ with $\operatorname{SU}(1,2)$ symmetry. These local models are asymptotic to decoupled solution with parabolic weight $-1 / 4<\lambda<1 / 4$. The stability condition restricts possible numbers of zeros of each type. As a result, the space of admissible tuple of weights $\lambda$ is contained in a convex polytope inside a hyperplane in $\mathbb{R}^{4 g-4}$. The set of partitions of zeros in $D$ satisfying stability condition is in one-to-one correspondence with the faces of the polytope.

For a fixed $t \geq 1$, the parabolic weight $\lambda$ determines leading order terms $\sim \lambda \log |z|$ for the harmonic metrics on $L$ as a part of local model solution. However by the
uniqueness in Biquard-Boalch theorem, the next-to-leading order is also determined by the weight. In order to construct a good approximate solution $h_{t}^{\text {app }}$ by gluing the local model to decoupled solution given by a tuple of weights $\lambda=\left(\lambda_{1}, \ldots, \lambda_{4 g-4}\right)$, it will be necessary to match the next-to-leading order as well. In fact, this issue is also discussed in [Moc16] and we adapt the proof to show that the next-to-leading order constant $c_{\lambda}$ depends continuously on $\lambda$ and use it to show that for a partition of zeros corresponding to a certain face of the polytope of admissible weights, for $t \gg 1$ there exists a family $\lambda(t)$ matching the next-to-leading order. Furthermore we show that as $t \rightarrow \infty$, the matching weight $\lambda(t) \rightarrow \lambda_{\infty}$ given in Theorem 1.1 which is also characterized by being the centers of the corresponding face in the polyhedron of admissible weights.

The approximate solution $h_{t}^{\text {app }}$ is then constructed by gluing local model solutions to decoupled solution outside of the disks, for the carefuly chosen tuple of weights $\lambda(t)$. Due to this $t$-dependency of weight, the ensuing analysis including the key estimates of $L_{t}$ are significantly more complicated than that of [MSWW16]. This and other complications (e.g. a $t$-independent $L^{2}$-lower bound of operator $L_{t}$ does not exist, see $\$ 4.2$ partily explains the length of the article.

There are a multitude of potential avenues to continue and extend the present work. Limiting configurations serves as natural class of objects to compactify the Hitchin moduli space. A clear picture of the interplay between spectral data for more general singular spectral curves and the limiting behavior of solutions is an important topic for this program. Another potential direction is the asymptotic geometry on the moduli space of $G$-Higgs bundles. Furthermore, there has recently been some important progress (see [OSWW20]) connecting the $\mathrm{SL}(2, \mathbb{C})$-limiting configurations via non-abelian Hodge correspondence to equivariant pleated surfaces in $\mathbb{H}^{3}$. It will be interesting to apply and extend the present work to explore limiting objects on the other side of non-abelian Hodge correspondence for both $\operatorname{SU}(1,2)$ and perhaps other rank-one Lie groups such as $\mathrm{SU}(1, n)$ for $n \geq 3$ and $\mathrm{SO}_{0}(1, n)$.

Lastly we comment on a recent work of Mochizuki [MS23]. It contains two results related to the limiting behavior of $h_{t}$ for families of $\mathrm{SL}(r, \mathbb{C})$-Higgs bundles. The first result is the independence of limit $h_{\infty}$ on choice of subsequences when the spectral curve is irreducible. The second is the exponential convergence of $h_{t}$ under the condition that the corresponding spectral data is given by a line bundle $L$ on the normalized spectral curve. Let $n: \widetilde{\Sigma} \rightarrow \Sigma$ be the normalization $\lambda^{\prime}$ the pullback of $\lambda \in p^{*} K_{X}$ on $\widetilde{\Sigma}$. This condition applies when the Higgs bundle is given by $(E, \Phi)=\left((p \circ n)_{*} L,(p \circ n)_{*} \lambda^{\prime}\right)$ for a line bundle $L$ on $\widetilde{\Sigma}$. Both results go beyond the restriction of smoothness of the spectral curve. However, neither conditions apply to the present work. For the first condition, the spectral curve $\Sigma$ of an $\operatorname{SU}(1,2)$-Higgs bundles discussed in this work is always reducible; for the second result with spectral curve $\Sigma$, the only $\mathrm{SU}(1,2)$-Higgs bundles induced by a line bundle $L$ on the normalization $\widetilde{\Sigma}$ are the strictly polystable ones. In that case, the question of limiting behavior is reduced to that of $\operatorname{SU}(1,1) \cong \operatorname{SL}(2, \mathbb{R})$.

The rest of the article is organized as follows. In $\$ 2$ we introduce some notations and conventions, and review the notion of filtered bundle as well as the description of spectral data of $S U(1,2)$ Higgs bundles using Hecke modification. In §3, we construct
local model and approximate solution. In $\S 4$, we study linearization of the equation and prove the main theorem.

## 2. Preliminaries

2.1. $\mathbf{S U}(1,2)$ Higgs bundle and stability conditions. We review the definitions of a $(G$-)Higgs bundle, in particular an $\mathrm{SU}(1,2)$ Higgs bundle, the stability conditions, as well as the notion of a filtered bundle following notations in $\S 3$ of [Moc16]. We will also review the description of spectral data for $\mathrm{SU}(1,2)$ Higgs bundles from [ $\mathbf{N a 2 1 ]}$. Throughout this work $X$ is a fixed closed Riemann surface of genus $g(X) \geq 2$. All vector bundles are holomorphic.

Let $G^{c}$ be a complex reductive Lie group. A $G^{c}$-Higgs bundle is a pair $(P, \Phi)$ with $P$ a holomorphic principal $G^{c}$-bundle over $X$ and $\Phi \in H^{0}\left(X, P \times_{\text {Ad }} \mathfrak{g}^{c} \otimes K_{X}\right)$. For $G^{c} \subset \mathrm{GL}(r, \mathbb{C})$, a $G^{c}$-Higgs bundle can also be viewed as a rank- $r$ Higgs bundle. The celebrated non-abelian Hodge correspondence [Don87, Cor88, Hit87, Sim88] established a homeomorphism between the moduli of polystable $G^{c}$-Higgs bundles and the moduli space of reductive representations $\operatorname{Hom}^{+}\left(\pi_{1}(X), G^{c}\right) / / G^{c}$. Hitchin [Hit92] exploited this correspondence to study the topology of character variety of real representations $\operatorname{Hom}^{+}\left(\pi_{1}(X), \operatorname{PSL}(n, \mathbb{R})\right) / / \operatorname{PSL}(n, \mathbb{R})$ and constructed the Hitchin component. Along this line, the notion of $G$-Higgs bundle is developed in [BGG06]. Let $G$ be a connected reductive real Lie group, $H \subset G$ a maximal compact subgroup, and $\mathfrak{g}=\mathfrak{h} \oplus \mathfrak{m}$ a Cartan decomposition. Let $H^{c}$ and $\mathfrak{m}^{c}$ be the respective complexifications and $\iota: H^{c} \rightarrow G L\left(\mathfrak{m}^{c}\right)$ the isotropy representation.

Definition 2.1. A G-Higgs bundle over $X$ is a pair $(P, \varphi)$ where $P$ is a holomorphic principal $H^{c}$-bundle over $X, \varphi \in H^{0}\left(X, P \times_{\iota} \mathfrak{m}^{c} \otimes K_{X}\right)$.

The Hitchin map for $G$-Higgs bundle is given by (see, e.g. [GPR18])

$$
\text { Hit }: \mathcal{M}_{G} \rightarrow \mathcal{B}_{G}=\bigoplus_{i=1}^{a} H^{0}\left(X, K_{X}^{m_{i}}\right)
$$

where $m_{i}$ 's are the exponents of $G$ and $a$ is the real rank of $G$.
For $G^{c}=\operatorname{SL}(3, \mathbb{C})$, there are up to conjugation three real forms: $\mathrm{SU}(3), \mathrm{SU}(1,2)$ and $\operatorname{SL}(3, \mathbb{R})$. Higgs bundle corresponding to compact real form $\operatorname{SU}(3)$ has vanishing Higgs field. On the other hand, the real form $\operatorname{SL}(3, \mathbb{R})$ gives no restriction to the spectral curve. We will therefore focus on the real form $G=\mathrm{SU}(1,2)$. The Lie algebra

$$
\mathfrak{g}=\mathfrak{s u}(1,2)=\left\{X \in \operatorname{Mat}_{3}(\mathbb{C}) \mid X^{*} J+J X=0, \operatorname{tr} X=0\right\}
$$

where $J=\operatorname{diag}(-1,1,1)$ and $X^{*}$ is the conjugate transpose of $X . \theta: X \mapsto-X^{*}=J X J$ is the Cartan involution on $\mathfrak{g}$. The Cartan decomposition $\mathfrak{g}=\mathfrak{h} \oplus \mathfrak{m}$ is the eigendecomposition for $\theta$ with eigenvalues 1 and -1 . We have

$$
\mathfrak{h}=\left\{\left.\left(\begin{array}{cc}
-\operatorname{tr} Y & 0 \\
0 & Y
\end{array}\right) \right\rvert\, Y \in \mathfrak{u}(2)\right\}, \mathfrak{m}=\left\{\left(\begin{array}{cc}
0 & Z \\
Z^{*} & 0
\end{array}\right)\right\}
$$

Definition 2.2. An $S U(1,2)$ Higgs bundle is a triple $(F, \beta, \gamma): F$ is a rank-two bundle, $\gamma \in H^{0}\left(X, \operatorname{Hom}(L, F) \otimes K_{X}\right), \beta \in H^{0}\left(X, \operatorname{Hom}(F, L) \otimes K_{X}\right)$ where $L=\operatorname{det} F^{*}$.

Equivalently $\gamma: L K_{X}^{-1} \rightarrow F, \beta: F \rightarrow L K_{X}$ are holomorphic bundle maps. The composition $q=\beta \circ \gamma: L K_{X}^{-1} \rightarrow L K_{X}$ is a holomorphic quadratic differential. We say that $(F, \beta, \gamma)$ is an $S U(1,2)$ Higgs bundle associated to $q$ and $L$.

Via $G \rightarrow G^{c}=\operatorname{SL}(3, \mathbb{C})$, an $\operatorname{SU}(1,2)$ Higgs bundle is also an $\operatorname{SL}(3, \mathbb{C})$ Higgs bundle

$$
E=L \oplus F, \Phi=\left(\begin{array}{ll}
0 & \beta \\
\gamma & 0
\end{array}\right)
$$

The corresponding notions of (poly)stability are equivalent (see [BGG03] for a more general statement).

Proposition 2.3 (Lemma 2.2, Got01]). Let ( $E$, $\Phi$ ) as above, $E^{\prime} \subset E$ a $\Phi$-invariant subbundle. There are subbundles $L^{\prime} \subset L$ and $F^{\prime} \subset F$ such that $\mu\left(E^{\prime}\right) \leq \mu\left(L^{\prime} \oplus F^{\prime}\right)$.

As a result, we need only test slope stability on nonzero proper subbundles of the form $L^{\prime} \oplus F^{\prime}$. Since $\operatorname{deg} E=0$, and the only subbundles of a line bundle $L$ are 0 and $L$ itself, we have

Proposition 2.4. $(F, \beta, \gamma)$ is stable iff

- for a subbundle $0 \neq F^{\prime} \subsetneq F,\left.\beta\right|_{F^{\prime}}=0$ we have $\operatorname{deg}\left(F^{\prime}\right)<0$, and
- for a subbundle $F^{\prime \prime} \subsetneq F$ with $\gamma(L) \subset F^{\prime \prime} \otimes K_{X}$ has $\operatorname{deg}\left(L \oplus F^{\prime \prime}\right)<0$

We make the following assumption throughout this work: $q=\beta \circ \gamma$ has simple zeros. Let $D=p_{1}+\ldots+p_{4 g(X)-4}$ be the zero divisor.

Definition 2.5. A zero of $q$ has three types: $\beta(p)=0, \gamma(p)=0$, or neither vanishes. This gives a partition $D=D_{\beta}+D_{\gamma}+D_{r}$. Let $d_{\beta}=\operatorname{deg} D_{\beta}, d_{\gamma}=\operatorname{deg} D_{\gamma}, d_{r}=\operatorname{deg} D_{r}=$ $4 g(X)-4-d_{\beta}-d_{\gamma}$. Denote $\underline{D}=\left(D_{\beta}, D_{\gamma}, D_{r}\right)$ to denote a partition of $D$ into three effective divisors.

The Toledo invariant $\tau=2 \operatorname{deg} L$ labels the connected components of the moduli space. We have the Milnor-Wood type inequality $|\tau|<2(g-1)$. With $d_{\beta}, d_{\gamma}$ we have the following refinement.

Proposition 2.6. $(F, \beta, \gamma)$ is stable iff

$$
\begin{equation*}
-(g-1)+\frac{1}{2} d_{\beta}<d<(g-1)-\frac{1}{2} d_{\gamma} \tag{2}
\end{equation*}
$$

equivalently

$$
\begin{align*}
& d_{\beta}<2(g-1+d) \text { and }  \tag{3}\\
& d_{\gamma}<2(g-1-d) \tag{4}
\end{align*}
$$

In particular if $(F, \beta, \gamma)$ stable then $d_{r}>0$. Furthermore, $(F, \beta, \gamma)$ is strictly polystable iff $<$ in above inequalities are replaced with equality, in which case $F \cong L^{-2} K_{X}^{-1}\left(D_{\beta}\right) \oplus$ $L K_{X}^{-1}\left(D_{\gamma}\right)$.

In the following we will say $\underline{D}$ is stable (resp. strictly polystable) if (3), (4) (resp. their equality versions) hold.

Proof. The saturation of $\operatorname{img}(\gamma)$ gives a subbundle $F^{\prime \prime} \cong L K_{X}^{-1}\left(D_{\gamma}\right)$. This is the unique proper subbundle of $F$ such that $\gamma\left(L K_{X}^{-1}\right) \subset F^{\prime \prime}$. We have $\operatorname{deg} F^{\prime \prime}=-d-2(g-$ 1) $+d_{\gamma}$.

On the other hand, $\beta: F \rightarrow L K_{X}$ factors through the surjective sheaf map $\widetilde{\beta}$ : $F \rightarrow L K_{X}\left(-D_{\beta}\right)$. We have that $\operatorname{ker}(\beta)=\operatorname{ker}(\widetilde{\beta})$ giving a line subbundle $F^{\prime} \subset F$. This is the unique nonzero proper subbundle of $F$ such that $\beta_{F^{\prime}}=0$. We have $\operatorname{deg} F^{\prime}=\operatorname{deg} F-\operatorname{deg} L K_{X}\left(-D_{\beta}\right)=-2 d-2(g-1)+d_{\beta}$. The statements about stability now follow from Prop 2.4

The spectral curve of $(E, \Phi)$ (corresponding to $(F, \beta, \gamma)$ as above) is given by zero divisor of the section $\lambda\left(\lambda^{2}-q\right) \in \pi^{*} K_{X}^{3}$ where $\pi:\left|K_{X}\right| \rightarrow X$ is the projection. This has two irreducible components (one of which is the zero section in $\mid K_{X}$ ) corresponding to the two $\Phi$-invariant subbundles (one of which is $\operatorname{ker}(\beta) \cong L^{-2} K_{X}^{-1}\left(D_{\beta}\right)$ ). $(F, \beta, \gamma)$ is polystable iff $E$ is a direct sum of these two subbundles, i.e. $F \cong L^{\prime} \oplus L^{-2} K_{X}^{-1}\left(D_{\beta}\right)$, each of which a stable Higgs bundle of slope 0 . Under this identification $E \cong$ $\left(L \oplus L^{\prime}\right) \oplus L^{-2} K_{X}^{-1}\left(D_{\beta}\right), \Phi=\Phi^{\prime} \oplus 0$ where

$$
\Phi=\left(\begin{array}{cc}
0 & \beta^{\prime} \\
\gamma^{\prime} & 0
\end{array}\right)
$$

We have $D_{\beta}=Z\left(\beta^{\prime}\right), D_{\gamma}=Z\left(\gamma^{\prime}\right), D=D_{\beta}+D_{\gamma}$ and $\operatorname{deg} L^{\prime}=d-2(g-1)+d_{\gamma}=-d$ and $\operatorname{deg} L^{-2} K_{X}^{-1}\left(D_{\beta}\right)=-2 d-2(g-1)+d_{\beta}=0$. These implies the equalities instead of $<$ in (3), (4). Conversely if equalities instead of $<$ holds in (3), (4), $D=D_{\beta}+D_{\gamma}$. We have that $\gamma$ factors through $s_{\gamma}: L K_{X}^{-1} \rightarrow F^{\prime \prime}$ with simple zeros at $D_{\gamma}, \beta=s_{\beta} \circ \widetilde{\beta}$ where $s_{\beta}: L K_{X}\left(-D_{\beta}\right) \rightarrow L K_{X}$ with simple zeros at $D_{\beta}$. Since $\beta \circ \gamma=q: L K_{X}^{-1} \rightarrow L K_{X}$ with simple zeros at $D=D_{\beta}+D_{\gamma}$, the composition $F^{\prime \prime} \rightarrow F \xrightarrow{\widetilde{\beta}} L K_{X}\left(-D_{\beta}\right)$ is an isomorphism. Since $O_{X}(D) \cong K_{X}^{2}$ and $D=D_{\beta}+D_{\gamma}$, we have $F^{\prime \prime} \cong L K_{X}^{-1}\left(D_{\gamma}\right) \cong$ $L K_{X}\left(-D_{\beta}\right)$. Therefore $F \cong F^{\prime \prime} \oplus L^{-1} K_{X}\left(D_{\beta}\right)$, where the latter summand is $\operatorname{ker}(\beta)$. It follows that $(E, \Phi)$ is a direct sum of $\Phi$-invariant stable Higgs bundles of slope 0 . q.e.d.
2.2. $\mathbf{S U}(\mathbf{1 , 2})$ Hitchin equation. In this part we write down the Hitchin's equation for an $\operatorname{SU}(1,2)$ Higgs bundle in global and local form. We also fix some convention and notations about local form of a Hermitian metric and some other related objects.

Theorem 2.1. For $(F, \beta, \gamma)$ stable, there is a unique metric $h$ on $F$ such that

$$
\begin{equation*}
F_{\nabla_{h}}+\gamma^{*_{h}} \wedge \gamma+\beta \wedge \beta^{*_{h}}=0 \tag{5}
\end{equation*}
$$

In more generality the above is a consequence of Theorem 3.21 of [GGM12]. By viewing $\operatorname{SU}(1,2)$ Higgs bundle as $\operatorname{SL}(3, \mathbb{C})$-Higgs bundle, there is also a more straightforward proof:

Proof. By the existence and uniqueness theorem of Hitchin and Simpson [Hit87, Sim88], there is a unique Hermitian metric $H$ on $E=L \oplus F$ solving Hitchin equation $F_{\nabla_{H}}+\left[\Phi \wedge \Phi^{* H}\right]=0$ inducing the standard metric on $\operatorname{det} E=O_{X}$. Let $\alpha=1_{L} \oplus\left(-1_{F}\right)$, we have $\alpha^{-1} \Phi \alpha=-\Phi$. By uniqueness, $\alpha^{*} H=H$. Thus $H=\operatorname{diag}\left(\operatorname{det} h^{-1}, h\right)$ with $h$ a Hermitian metric on $F$. The form (5) follows by a direct calculation. q.e.d.

For $\boldsymbol{s}=\left(s_{1}, \ldots, s_{r}\right)$ be a local frame, the matrix $h_{s}$ is defined by $\left(h_{s}\right)_{i j}=h\left(s_{j}, s_{i}\right)$. For $\psi \in \operatorname{Hom}\left(E, E^{\prime}\right)$ with local frames $\boldsymbol{s}, \boldsymbol{u}$, we define the matrix $\psi_{s, u}$ by $\psi s_{j}=$ $\sum_{j}\left(\psi_{s, u}\right)_{i j} u_{j}$. We write $\psi_{s}$ if $E^{\prime}=E, \boldsymbol{u}=\boldsymbol{s}$. Let $\left(E_{i}, h_{i}\right), i=1,2$ be Hermitian vector bundles. Let $s_{i}$ be local frames of $E_{i}$ and $H_{i}=\left(h_{i}\right)_{s_{i}}$. Let $\phi \in \operatorname{Hom}\left(E_{1}, E_{2}\right)$ with $M=\phi_{s_{1}, s_{2}}$. Then under induced metric we have $|\phi|_{h_{1}, h_{2}}^{2}=\operatorname{tr}\left(\phi \phi^{*}\right)=\operatorname{tr}\left(M H_{1}^{-1} M^{*} H_{2}\right)$. Let $A, H \in \operatorname{Mat}_{n}(\mathbb{C})$ where $H \geq 0$ is Hermitian, we denote

$$
\begin{equation*}
|A|_{H}^{2}=\operatorname{tr}\left(A H^{-1} A^{*} H\right) \tag{6}
\end{equation*}
$$

Let $(F, \beta, \gamma)$ be an $\mathrm{SU}(1,2)$ Higgs bundle and $\left\{s_{1}, s_{2}\right\}$ local frame of $F$ over $(U ; z)$, $\left\{\left(s_{1} \wedge s_{2}\right)^{-1}\right\}$ the induced frame on $L=\operatorname{det} F^{*}$. Let $\beta_{s}=\beta_{0} d z, \gamma_{s}=\gamma_{0} d z, H=h_{s}$, then (5) is given by the following equation

$$
\begin{equation*}
\partial_{\bar{z}}\left(H^{-1} \partial_{z} H\right)=\gamma_{0} \gamma_{0}^{*} H(\operatorname{det} H)-(\operatorname{det} H)^{-1} H^{-1} \beta_{0}^{*} \beta_{0} \tag{7}
\end{equation*}
$$

2.3. Filtered bundle. In the following, we review the notion of filtered bundle following $\S 3$ of [Moc16]. Let $D \subset X$ be a finite set of $N$ points and $O=O_{X}, O^{\prime}=$ $O_{X}(* D)$ sheaf of meromorphic functions with poles in $D$. Let $\mathcal{E}$ be a locally free $O^{\prime}$-module. A metric on $\mathcal{E}$ will mean a metric on $\left.\mathcal{E}\right|_{X-D}$.

Definition 2.7. A filtered bundle structure on $\mathcal{E}$ over $(X, D)$ is a family of coherent O-submodules $\mathcal{P}_{*} \mathcal{E}$ labeled by a tuple $\boldsymbol{a}=\left(a_{P}\right)_{P \in D}, a_{P} \in \mathbb{R}$ such that

- $\mathcal{P}_{a} \mathcal{E} \otimes_{O} O^{\prime}=\mathcal{E}$,
- the stalk of $\mathcal{P}_{a} \mathcal{E}$ at $p \in D$ depends only on $a_{P} \in \mathbb{R}$, denoted by $\mathcal{P}_{a_{P}} \mathcal{E}_{P}$,
- $\mathcal{P}_{a} \mathcal{E}_{P} \subset \mathcal{P}_{b} \mathcal{E}_{P}$ for $a \leq b$ and there is $\epsilon>0$ such that $\mathcal{P}_{a} \mathcal{E}_{P}=\mathcal{P}_{a+\epsilon} \mathcal{E}_{P}$,
- $\mathcal{P}_{a} \mathcal{E}_{P} \otimes_{O_{X, P}} O(n P)_{P}=\mathcal{P}_{a+n} \mathcal{E}_{P}$ for $n \in \mathbb{Z}$.

A filtered Higgs bundle is a pair $\left(\mathcal{P}_{*} \mathcal{E}, \theta\right)$ where $\theta \in H^{0}\left(X, \operatorname{End}(\mathcal{E}) \otimes \Omega_{X}^{1}\right) .\left(\mathcal{P}_{*} \mathcal{E}, \theta\right)$ is an unramifiedly good filtered Higgs bundle if at each $P$ there is a finite subset of germs of meromorphic functions, $I(P) \subset O_{P}^{\prime}$ with $I(P) \rightarrow O_{X}(* D)_{P} / O_{X, P}$ injective, and a decomposition $\mathcal{P}_{a} \mathcal{E}_{P}=\bigoplus_{f \in I(P)} \mathcal{P}_{a} \mathcal{E}_{P, f}$ such that

$$
(\theta-(d f) I d) \mathcal{P}_{a} \mathcal{E}_{P, f} \subset \mathcal{P}_{a} \mathcal{E}_{P, f} \otimes \Omega_{X}^{1}(\log D)_{P}
$$

For each $a \in \mathbb{R}$, let $\delta \mathcal{P}_{a} \mathcal{E}_{P}=\mathcal{P}_{a} \mathcal{E}_{P} / \mathcal{P}_{<a} \mathcal{E}_{P}$.
Note that by the last property in the above definition, $\mathcal{P}_{a_{P}}^{P} \mathcal{E}_{P} / \mathcal{P}_{a_{P}-1}^{P} \mathcal{E}_{P}$ is the fiber of the vector bundle $\mathcal{P}_{a} \mathcal{E}$ at $P$. For $-1<\alpha \leq 0$, we have filtration $F_{\alpha}^{P}=\mathcal{P}_{a_{P}-1+\alpha}^{P} \mathcal{E}_{P} / \mathcal{P}_{a_{P}-1}^{P} \mathcal{E}_{P}$ of the fiber. In this way for any $\boldsymbol{a}$, a filtered bundle structure $\mathcal{P}_{*} \mathcal{E}$ is equivalent to a parabolic structure on holomorphic vector bundle $\mathcal{P}_{a} \mathcal{E}$.

Definition 2.8. A metric $h$ on $E$ is called adapted to $\mathcal{P}_{*} \mathcal{E}$ on $(X, D)$ if

- $\mathcal{P}_{a} \mathcal{E} \cong \mathcal{E}$ as $O$-module on $X-D$ for all $a$, and
- $s \in \mathcal{P}_{a} \mathcal{E}$ iff

$$
\begin{equation*}
|s|_{h}=O\left(\left|z_{P}\right|^{-a_{P}-\epsilon}\right), \quad \forall \epsilon>0 \tag{8}
\end{equation*}
$$

where $z_{P}$ is a holomorphic coordinate centered at $P$. Given a metric $h$ on $\mathcal{E}$, the second condition defines a filtered bundle structure $\mathcal{P}_{*}^{h} \mathcal{E}$.

For a tuple $\boldsymbol{b}$, define

$$
\operatorname{deg} \mathcal{P}_{*} \mathcal{E}=\operatorname{deg} \mathcal{P}_{b} \mathcal{E}-\sum_{P \in D} \sum_{b_{P}-1<a \leq b_{P}} a \cdot \operatorname{dim}_{\mathbb{C}}\left(\mathcal{P}_{a} \mathcal{E}_{P} / \mathcal{P}_{<a} \mathcal{E}_{P}\right)
$$

where $\mathcal{P}_{<a} \mathcal{E}_{P}=\bigcup_{c<a} \mathcal{P}_{c} \mathcal{E}_{P}$. This is independent of the choice of $\boldsymbol{b}$. For $\mathcal{G} \subset \mathcal{E}$ locally free $O^{\prime}$-submodules, let $\mathcal{P}_{a} \mathcal{G}=\mathcal{P}_{a} \mathcal{E} \cap \mathcal{G}$. This gives a filtered bundle structure on $\mathcal{G}$. Let $\mu\left(\mathcal{P}_{*} \mathcal{E}\right):=\operatorname{deg} \mathcal{P}_{*} \mathcal{E} / \operatorname{rank} \mathcal{E}$. A filtered $\operatorname{Higgs}$ bundle $\left(\mathcal{P}_{*} \mathcal{E}, \theta\right)$ is stable if any nonzero proper $\theta$-invariant locally free $O^{\prime}$-submodule $\mathcal{G}$ satisfies $\mu\left(\mathcal{P}_{*} \mathcal{G}\right)<\mu\left(\mathcal{P}_{*} \mathcal{E}\right)$. The following theorem from [BB04] is a generalization of [Hit87, Sim88] on closed Riemann surfaces and of [Sim90] on punctured Riemann surface for 'tame' case and of [Biq91] for parabolic vector bundles.

Theorem 2.2. Let $\left(\mathcal{P}_{*} \mathcal{E}, \theta\right)$ be a stable unramifiedly good filtered Higgs bundle with $\operatorname{deg} \mathcal{P}_{*} \mathcal{E}=0$. Then there exists $h$ (unique up to $\mathbb{R}_{+}$) adapted to $\left(\mathcal{P}_{*} \mathcal{E}, \theta\right)$ with $F_{\nabla_{h}}+\left[\theta \wedge \theta^{* h}\right]=0$ on $X-D$.

Theorem 2.3. Let $\mathcal{L}$ be a line bundle and $\lambda=\left(\lambda_{1}, \ldots, \lambda_{N}\right)$ a tuple of real numbers satisfying

$$
\begin{equation*}
\operatorname{deg} \mathcal{L}+\sum_{j=1}^{N} \lambda_{j}=0 \tag{9}
\end{equation*}
$$

Let $\left(U_{j} ; z_{j}\right)$ be disjoint local charts centered at $p_{j} \in D$ and $s_{j}$ a nowhere vanishing section over $U_{j}$. Then there is a metric $h$ on $\mathcal{L}$, unique up to positive constant, such that $F_{\nabla_{h}}=0$ on $X-D$ and

$$
\begin{equation*}
\log \left|s_{j} h_{h}=\lambda_{j} \log \right| z_{j} \mid+O(1) \text { as } \quad\left|z_{j}\right| \rightarrow 0 \tag{10}
\end{equation*}
$$

We call $h$ a harmonic metric adapted to filtered line bundle $(\mathcal{L}, \lambda)$.
Proof. Let $\widetilde{\mathcal{L}}=\mathcal{L} \otimes_{O} O^{\prime}$ and $\mathcal{L}_{\boldsymbol{m}}$ the $O$-submodule generated by $z_{j}^{-m_{j}} s_{j}$ over $U_{j}$. We have $\mathcal{L}_{\boldsymbol{m}}=\mathcal{L}\left(\sum_{j} m_{j}\left[p_{j}\right]\right)$. Let $\mathcal{P}_{\boldsymbol{b}} \widetilde{\mathcal{L}}=\mathcal{L}_{\left\lfloor b_{1}+\lambda_{1}\right\rfloor, \ldots,\left\lfloor b_{N}+\lambda_{N}\right\rfloor}$. We have $\operatorname{deg} \mathcal{P}_{*} \widetilde{\mathcal{L}}=$ $\operatorname{deg} \mathcal{L}+\sum_{j} \lambda_{j}=0$. By Theorem 2.2, there is a harmonic metric $h$ on $\widetilde{\mathcal{L}}$ adapted to $\mathcal{P}_{*} \widetilde{\mathcal{L}}$ unique up to positive constant.

Note that $u_{j}:=\log \left|s_{j}\right|_{h}$ is a harmonic function on $U_{j}-\left\{p_{j}\right\}$. Take $\xi<\lambda_{j}$. Since $s_{j} \in$ $\mathcal{P}_{-\lambda}$ we have by (8) that there is some constant $C$ such that $-u_{j}+\xi \log \left|z_{j}\right|+C \geq 0$ for $\left|z_{j}\right|$ small enough. By Bôcher's Theorem (see, e.g. Axl01] Theorem 3.9) characterizing positive harmonic functions on a punctured disk, we have $u_{j}=\mu \log \left|z_{j}\right|+\operatorname{Re}(f)$ with some $\mu \in \mathbb{R}$ and $f \in O\left(U_{j}\right)$. By (8) $\mu \geq \lambda_{j}$. If $\mu>\lambda_{j}$ we have some $\boldsymbol{b}$ with $b_{j}=-\mu<-\lambda_{j}$ such that $s_{j} \in \mathcal{P}_{\boldsymbol{b}}$, a contradiction. Therefore $\mu=\lambda_{j}$. q.e.d.

In the following we give a second proof in terms of solution to Poisson equations with prescribed logarithmic poles.

Lemma 2.9. Let $\boldsymbol{a}=\left(a_{1}, \ldots, a_{N}\right), n=-\sum_{j} a_{j}$ and $D=\left\{p_{1}, \ldots, p_{N}\right\}$ finite set on $X$. Then there is $\varphi: X-D \rightarrow \mathbb{R}$, unique up to a constant on $X$, satisfying $\Delta_{\partial} \varphi=n$ where $\Delta_{\partial}=\partial^{*} \partial+\partial \partial^{*}=i \Lambda \bar{\partial} \partial$ on functions and $\varphi+2 a_{j} \log \left|z_{j}\right|$ are bounded near $p_{j}$.

Proof. Suppose $n=0, N=2$ and $\boldsymbol{a}=(1 / 2,-1 / 2)$. Let $D=\{p, q\}$ with $p \neq q$. Consider the divisor $p-q$ and denote by $\mathcal{L}$ the associated line bundle. Let $s \in \mathcal{L} \otimes_{O} \mathscr{M}^{*}$ be the defining meromorphic section with a zero at $p$, a pole at $q$ and holomorphic on $X-D$. Let $h$ be a Hermitian-Einstein metric on $\mathcal{L}$, i.e. $i \Lambda F_{\nabla_{h}}=0$ on $X-D$. Set $\varphi=\log |s|_{h}$. For a chart $(U ; z)($ resp. $(V ; w))$ centered at $p($ resp. $q), \varphi-\log |z|$ (resp. $\varphi+\log |w|)$ is bounded and we have $\Delta_{\partial} \varphi=0$ on $X-D$.

For $n=1, N=1$ and $\boldsymbol{a}=(1)$. Let $D=\{p\}, \mathcal{L}$ a line bundle of degree $1, h$ (resp. $h_{0}$ ) a Hermitian-Einstein metric on $\mathcal{L}($ resp. $\mathcal{L}(-p))$ and $s: \mathcal{L}(-p) \rightarrow \mathcal{L}$ the inclusion induced by $O(-p) \subset O$. As bundle map $s$ has a simple zero at $p$ and is isomorphic away from $p$. By this inclusion we view $h$ as a metric on $\left.\mathcal{L}(-p)\right|_{X-D}$ and write $h=h_{0} e^{\varphi}$. We have $F_{\nabla_{h_{0}}}=0$ away from $p$ and $\Delta_{\partial} \varphi=i \Lambda \bar{\partial} \partial \varphi=i \Lambda F_{\nabla_{h}}=1$ on $X-D$.

Let $\sigma_{0}$ (resp. $\sigma$ ) be a trivializing section for $\mathcal{L}(-p)$ (resp. $\mathcal{L}$ ) on a chart $(U ; z)$ centered at $p$, we have $e^{\varphi / 2}\left|\sigma_{0}\right|_{h_{0}}=\left|\sigma_{0}\right|_{h}=|f||\sigma|_{h}$ with $f$ holomorphic with simple zero at $p$. Therefore $\varphi=2 \log |z|+O(1)$ as $z \rightarrow 0$

In general the solution is a linear combination of the above cases. Uniqueness follows from the fact that a harmonic funtion on $X$ is a constant.
q.e.d.

We now give a second proof of Theorem 2.3.
Proof. Let $h$ be a solution of the Hermitian-Einstein equation for $\mathcal{L}$, i.e. $i \Lambda F_{\nabla_{h}}=$ $\operatorname{deg} \mathcal{L i d}_{\mathcal{L}}$. By the above lemma, there is $\varphi$ on $X-D$ such that $\Delta_{\partial} \varphi=-\operatorname{deg} \mathcal{L}$ and $\varphi=2 \lambda_{j} \log \left|z_{j}\right|+O(1)$ at $p_{j}$. It is now easy to verify that $h e^{\varphi}$ is a harmonic metric adapted to filtered line bundle $(\mathcal{L}, \boldsymbol{\lambda})$.
q.e.d.

We first fix some local charts around zeros of $q$.
Definition 2.10. Let $(F, \beta, \gamma)$ be a stable $S U(1,2)$ Higgs bundle and $q=\beta \circ \gamma$, $D=Z(q)=D_{\beta}+D_{\gamma}+D_{r}$ as in Def[2.5] Let $\left(\mathbb{D}_{j} ; \zeta_{j}\right)$ be disjoint charts centered at $p_{j} \in D$ such that $q=\zeta_{j}\left(d \zeta_{j}\right)^{2}$ and $\mathbb{D}_{j}=\left\{\left|\zeta_{j}\right|<R\right\}$ for some $R>0$. Denote by $\mathbb{D}_{j}^{\times}=\mathbb{D}_{j}-\left\{p_{j}\right\}$. Let

$$
\begin{equation*}

The construction in the above proof allows us to get rid of the ambiguity of positive constant and give a $\boldsymbol{\lambda}$-family of harmonic metric adapted to $(L, \lambda)$. This will be useful in constructing the approximate solution later.

Definition 2.11. Fix $h_{L, H E}$ a solution to the Hermitian-Einstein equation for the line bundle L, i.e. $i \Lambda F_{\nabla_{h_{L, H E}}}=\operatorname{degLid}_{L}$. Fix $G_{j}$ for $1 \leq j \leq N$ (existence follows by Lemma 2.9), such that

Note that the for filtered line bundles, the estimate in (8) sharpens to () thanks to Bôcher's Theorem. We will need a similar sharpening for higher rank case. Let $\mathcal{E}$ be a locally free sheaf of $O^{\prime}$-modules and $h$ a metric on $\mathcal{E}$ as a vector bundle on $X-D$. Fix $P \in D$ and $(U ; z)$ a chart centered at $P$.

Let $h^{*}$ be the induced metric on $\mathcal{E}^{*}$. By Prop 3.1 of $[\mathbf{S i m 9 0}], \mathcal{P}_{a}^{\vee} \mathcal{E}_{P}^{*}=\mathcal{P}_{a}^{h^{*}} \mathcal{E}_{P}^{*}$ for all $a \in \mathbb{R}$. It is also straightforward to see that for nonzero representative $e \in \delta \mathcal{P}_{a}^{h} \mathcal{E}_{P}$, there is $s \in \mathcal{P}_{-a}^{\vee} \mathcal{E}_{P}^{*}$ such taht $s(e)=1$. The following result is a consequence of the proof of Lemma 6.2 in [Sim90].

Proposition 2.12. Let $\mathcal{E}, h$ and $(U ; z)$ as above and suppose that near $P \in D$ we have

Proof. We view $e \in \delta \mathcal{P}_{a}^{h} \mathcal{E}_{P}$ as a nonzero section defined in some open subset of $U$ containing $P$. For all $\epsilon>0$ there is $C_{\epsilon}$ with $\log \left(|z|^{-a}|e|_{h}\right) \leq \epsilon|\log | z| |+C_{\epsilon}$. Let $s \in \mathcal{P}_{-a}^{\vee} \mathcal{E}_{P}^{*}=\mathcal{P}_{-a}^{h^{*}} \mathcal{E}_{P}^{*}$ be such that $s(e)=1$. By Cauchy-Schwarz we have $1=|s(e)| \leq$ $|s|_{h^{*}}|e|_{h}$. For all $\epsilon>0$ there is $C_{\epsilon}^{\prime}$ such that

Let $\mathbb{D}$ be a sufficiently small disk centered at $P$. The fact that curvature decreases in holomorphic subbundle (spanned by $e \in \mathcal{E}$ ) implies that we have $-\Delta g \leq h$ away from $x$ for some $h \in L^{p}$. Let $u \in L_{2}^{p}(\mathbb{D}) \subset C^{0}(\mathbb{D})$ be some bounded function such that $\Delta u=h$ and $g<u$ on $\partial \mathbb{D}$. We have $-\Delta(g-u) \leq 0$ on $\mathbb{D}-\{P\}$. We have that $|(g-u) / \log | z \mid \rightarrow 0$ as $|z| \rightarrow 0$. By [Sim90] Lemma 2.2], $-\Delta(g-u) \leq 0$ weakly on all of $\mathbb{D}$. By the maximum principle, $g \leq u$, i.e. $g$ is bounded from above. Replace $g$ with $-g$, consider holomorphic subbundle spanned by $s \in \mathcal{E}^{*}$, note that the induced metric has $F_{\bar{V}_{h}}=-F_{\nabla_{h}}^{t}$ (see e.g. Prop 4.3 .7 (iii) [Huy05]). Repeating the above argument shows that $g$ is bounded from below as well. The conclusion then follows. q.e.d.
2.4. $\mathbf{S U}(\mathbf{1 , 2})$ Higgs bundle as Hecke modification. We next review from [Na21] the construction an stable $\operatorname{SU}(1,2)$ Higgs bundle $(F, \beta, \gamma)$ associated to a $q \in H^{0}\left(X, K_{X}^{2}\right)$ and a line bundle $L$ via holomorphic Hecke modifications of

A Hecke modification of a holomorphic vector bundle $E$ at $D=\left\{x_{1}, \ldots, x_{N}\right\}$ is a pair $(\hat{E}, s)$ where $\hat{E}$ is a holomorphic vector bundle and $s:\left.\left.\hat{E}\right|_{X-D} \rightarrow E\right|_{X-D}$ is an isomorphism which induces isomorphism $\hat{\mathcal{E}} \xrightarrow{\sim} \mathcal{E}$ where $\hat{\mathcal{E}}=\hat{E} \otimes_{O} O(* D), \mathcal{E}=E \otimes_{O}$ $O(* D)$. This is related to the Hecke operator and the Hecke eigensheaves, which play central roles in the geometric Langlands program (see, e.g. [Fre07]). [Hor22] used the Hecke modification to parametrize the non-abelian part of the singular Hitchin fiber for $\operatorname{SL}(2, \mathbb{C})$-Higgs bundles. ( $\hat{E}, s$ ) is called a holomorphic Hecke modification if $s$ is a holomorphic bundle map $\hat{E} \rightarrow E$. The data in a holomorphic Hecke modification of $E$ at $D$ is equivalent to specifying a locally free subsheaf of $O_{X}$-modules of the same rank that is isomorphic on $X-D$ to $E$. We introduce three sets equipped with some equivalence relations.

Definition 2.13. Let $\underline{D}=\left(D_{\beta}, D_{\gamma}, D_{r}\right)$ be a partition of the finite set $D$ and set

with $\left(F, \beta_{1}, \gamma_{1}\right) \sim\left(F^{\prime}, \beta_{2}, \gamma_{2}\right)$ if there is an isomorphism $\psi: F \rightarrow F^{\prime}, \Lambda^{2} \psi=i d_{L^{*}}$ with $\beta_{1}=\beta_{2} \circ \psi$, and $\gamma_{2}=\psi \circ \gamma_{1}$. Let

with $(F, \iota) \sim\left(F^{\prime}, \iota^{\prime}\right)$ if there is an isomorphism $\psi: F \xrightarrow{\sim} F^{\prime}, \Lambda^{2} \psi=i d_{L^{*}}$ and $\lambda \in \mathbb{C}^{\times}$ such that

For a finite set $\delta \subset X$ and a line bundle $L$ on $X$, set

with $\boldsymbol{b} \sim \boldsymbol{b}^{\prime}$ if there is $\tau \in \mathbb{C}^{\times}$such that $b_{p}^{\prime}=\tau b_{p}$ for all $p \in \delta$. For $\delta=D_{r}, \boldsymbol{b} \in \mathcal{F}_{L, D_{r}}$ is called an admissible Hecke parameter with respect to $\underline{D}$.

Note that the equivalence classes in $\mathcal{M}_{L, q, \underline{D}}$ are the isomorphism classes of stable $\mathrm{SU}(1,2)$ Higgs bundles associated to $q$ and $L$. The following gives a correspondence between the three sets, see $[\mathbf{N a 2 1 ]}$ for more details of the corresponding moduli problem.

Theorem 2.4. There are bijections

respecting the equivalence relations. For each $\boldsymbol{b} \in \mathcal{F}_{L, D_{r}}$ and $p_{j} \in D_{r}$, there are frame $s_{0, j}$ of $L,\left\{s_{1, j}, s_{2, j}\right\}$ of $F$, and $\sigma_{1, j}=\left(\left(s_{0, j}\right)^{-2} d \zeta_{j}, 0\right), \sigma_{2, j}=\left(0, s_{0, j} d \zeta_{j}\right)$ of $V$ over $\mathbb{D}_{j}$ with

- $s_{0, j}^{\otimes 3}=b_{p_{j}}$ for each $p_{j} \in D_{r}$,
- local form of $\iota: F \rightarrow V$ is given by $\frac{1}{\sqrt{2}}\left(\begin{array}{cc}\zeta_{j} & -1 \\ \zeta_{j} & 1\end{array}\right)$,
- $s_{1, j} \wedge s_{2, j}=s_{0, j}^{-1}$, and
- $\beta$, $\gamma$ have local forms over $\mathbb{D}_{j}$ with $p_{j} \in D_{r}$ given by

We say $\boldsymbol{\sigma}_{j}=\left(\sigma_{1, j}, \sigma_{2, j}\right)$, $\boldsymbol{s}_{j}=\left(s_{1, j}, s_{2, j}\right)$ are induced by $\left\{s_{0, j}\right\}$ of $\left.L\right|_{\mathbb{D}_{j}}$.
Proof. For a rank-two vector bundle $\mathcal{E}$, denote $\phi_{\mathcal{E}}: \mathcal{E}^{*} \otimes \operatorname{det} \mathcal{E} \xrightarrow{\sim} \mathcal{E}$ with $\ell \otimes s_{1} \wedge$ $s_{2} \mapsto \ell\left(s_{2}\right) s_{1}-\ell\left(s_{1}\right) s_{2}$. This is an isomorphism that induces identity on $\operatorname{det} \mathcal{E}$.

Given $(F, \beta, \gamma) \in \mathcal{M}_{L, q, \underline{D}}$, set $\iota_{2}=\beta$, and let $\iota_{1}$ be the composition

The induced local frame of $L$ consists of a nowhere vanishing holomorphic section $\left(s_{1} \wedge s_{2}\right)^{-1}$. Under these frames there are $\beta_{1}, \beta_{2}, \gamma_{1}, \gamma_{2} \in O(U)$ such that

It follows that $\iota\left(\left.F\right|_{p_{j}}\right)$ lies in fiber of first (resp. second) summand iff $\beta\left(p_{j}\right)=0$ (resp. $\gamma\left(p_{j}\right)=0$ ), therefore we get a map $\mathcal{M}_{L, q, \underline{D}} \rightarrow \mathcal{H}_{L, q, \underline{D}}$. From the above local form, it is also clear that the map is a bijection preserving respective equivalent relations.

Given $(F, \iota) \in \mathcal{H}_{L, q, \underline{D}}$, we have an exact sequence of $O$-modules

where $O_{D}$ is a direct sum of skyscraper sheaves with stalks $\mathbb{C}$ at points in $D$, and $\pi$ is unique up to $\operatorname{Aut}_{O} O_{D} \cong\left(\mathbb{C}^{\times}\right)^{4 g-4}$. For each $p \in D_{r}, \iota\left(\left.F\right|_{p}\right)=$ ker $\pi$ for $\pi \neq 0$ lying in a line $\ell \in \mathbb{P}\left(\left(\left.\left.L^{-2} K_{X}\right|_{p} \oplus L K_{X}\right|_{p}\right)^{*}\right)$, corresponding to $\left.b_{p} \in L^{\otimes 3}\right|_{p}$ which gives the slope. This gives the map (dependent on $\underline{D}$ ) from $\mathcal{H}_{L, q, \underline{D}}$ to $\mathcal{F}_{L, D_{r}}$. Again it is easy to verify that this is a bijection preserving respective equivalences.

Let $s_{1}^{\prime}$, $s_{2}^{\prime}$ be a local frame of $F$ over $(U ; \zeta)$ around $p \in D_{r}$. Without loss of generality, suppose $s_{1}^{\prime}$ generates the subbundle $\operatorname{ker} \beta$ over $U$. Under local frames $\left(s_{1}^{\prime} \wedge s_{2}^{\prime}\right)^{-1}$ of $L$ and $d \zeta$ of $K_{X}$, we have

We may assume $\beta_{2}$ is nowhere vanishing on $U$. Therefore $\beta_{2}^{-1} \in O(U)$ and $\gamma_{2}=\zeta \beta_{2}^{-1}$. Let $c$ be a cube root of the nonzero complex number $\beta_{2}^{2} \gamma_{1}(\zeta=0)$ and set

\end{aligned}

Under this local frame for $F,\left(s_{1} \wedge s_{2}\right)^{-1}$ for $L$ and $d \zeta$ for $K_{X}$, we have

Under $s_{1}, s_{2}$ for $F, s_{0}=\left(s_{1} \wedge s_{2}\right)^{-1}$ for $L$ and $\sigma_{1}=\left(s_{0}^{-2} d \zeta, 0\right), \sigma_{2}=\left(0, s_{0} d \zeta\right)$ for $V$, by (16) $\iota$ takes the form in the statement. $\iota\left(\left.F\right|_{p}\right)$ is the line spanned by $(-1,1)^{T}$ in $\left.V\right|_{p}=\left.\left.L^{-2} K_{X}\right|_{p} \oplus L K_{X}\right|_{p}$ under $\sigma_{1}, \sigma_{2}$. It follows straightforwardly that $b_{p}=1$ under the frame $s_{0}^{3}$, therefore the rest of the statement follows. q.e.d

It is worth mentioning that there is an equivalent interpretation of the Hecke parameters which is in a sense dual to the above construction. Given $(F, \beta, \gamma) \in \mathcal{M}_{L, q, \underline{D}}$, $F$ may be viewed as extension of line bundles in two different ways

where (1) (resp. (2)) are induced by $\gamma$ (resp. $\beta$ ) and $s$ have simple zeros at $D_{r}$. The line bundles $L K^{-1}\left(D_{\gamma}\right)$ (resp. $\operatorname{ker} \beta \cong L^{-2} K^{-1}\left(D_{\beta}\right)$ ) are realized as subbundles img $\gamma$ (resp. $\operatorname{ker} \beta$ ) inside $F$. Their fibers meet precisely at $D_{r}$. Up to a global constant, the tuple $\boldsymbol{b}$ provides a recipe to match their fibers at $D_{r}$ inside of $F$. This picture of extensions is similar to the reconstruction of an $\mathrm{SO}(2 m+1)$ bundle from an $\mathrm{Sp}(2 m)$ bundle in §4.2 of [Hit07] which inspired our description of $\mathrm{SU}(1,2)$ spectral data.

We consider an example of $\mathrm{SU}(1,2)$ Higgs bundle with $q \in H^{0}\left(X, K_{X}^{2}\right)$ having simple zeros:

For an $\mathrm{SU}(1,2)$ Higgs bundle $(F, \beta, \gamma)$ and $p \in D_{r}$, Theorem 2.4 provides local frames under which Higgs field takes a standard form. We give below similar frames at points in $D_{\beta}$ and $D_{\gamma}$. We view the sections of $F$ as sections of $V$ via $\iota$ from the correspondence in Theorem 2.4

Definition 2.14. For $p_{j} \in D_{\beta}$, given frame $\left\{s_{0, j}\right\}$ of $L_{\mathbb{D}_{j}}$ define a local frame of $V$ by $\sigma_{1, j}=\left(s_{0, j}^{-2} d \zeta_{j}, 0\right), \sigma_{2, j}=\left(0, s_{0, j} d \zeta_{j}\right)$ and set $s_{1, j}=\zeta_{j} \sigma_{2, j}, s_{2, j}=-\sigma_{1, j}$. These form a frame of $F$ over $\mathbb{D}_{j}$. Under these frames,

For $p_{j} \in D_{\gamma}$, given frame $\left\{s_{0, j}\right\}$ of $L_{\mathbb{D}_{j}}$ define a local frame $\sigma_{1, j}, \sigma_{2, j}$ of $V$ as above and set $s_{1, j}=\sigma_{2, j}, s_{2, j}=-\zeta_{j} \sigma_{1, j}$. These form a frame of $F$ over $\mathbb{D}_{j}$. Under these frames,

We will say that frames $\boldsymbol{\sigma}_{j}=\left\{\sigma_{1, j}, \sigma_{2, j}\right\}$ and $\boldsymbol{s}_{j}=\left\{s_{1, j}, s_{2, j}\right\}$ are induced by $\left\{s_{0, j}\right\}$.
It will be useful to note that if $s_{0, j}$ induces frame $s_{1, j}, s_{2, j}$, then for $f$ a nowhere vanishing holomorphic function on $\mathbb{D}_{j}, f s_{0, j}$ induces frame $f s_{1, j}, f^{-2} s_{2, j}$. Furthermore, note that under $\sigma_{1, j}, \sigma_{2, j}$ on $\mathbb{D}_{j}^{\times}$we have

## 3. Construction of approximate solution

Let $(F, \beta, \gamma)$ be a stable $\mathrm{SU}(1,2)$ Higgs bundle, $t \geq 1$ and recall notations in Def 2.10 In this part we construct an approximate solution to the Hitchin equation for $(F, t \beta, t \gamma)$ for $t \gg 1$ by gluing an decoupled solution on $X-\coprod_{j} \mathbb{D}_{j}$ to local model solutions on $\mathbb{D}_{j}^{\prime \prime}$. In $\S 3.1$ we characterize solutions to decoupled equation. In $\S 3.2$, we describe a family of local model solutions parametrized by $\lambda \in(-1 / 4,1 / 4)$ as well as two other local model solutions which may be viewed as the cases $\lambda= \pm 1 / 4$. In $\$ 3.3$ we apply estimates from [Moc16] to study asymptotic properties of these local model solutions. In particular in $\S 3.3 .4$, we show that the next-to-leading order coefficients of the $\lambda$-family of local solutions depends continuously on $\lambda \in(-1 / 4,1 / 4)$.

In $\S 3.4$, we show that for $t \gg 1$, there is a family $\boldsymbol{\lambda}(t)$ for which we can glue the local model solutions to a decoupled solution. A family of approximate solution $h_{t}^{\text {app }}$ is constructed using this $t$-dependent tuple of parabolic weights $\boldsymbol{\lambda}(t)$ and we show that it is very close to solving the Hitchin equation.
3.1. Decoupled solution. A metric $h$ on $\left.F\right|_{X-D}$ solving the decoupled form of (5)

F_{\nabla_{h}}=0, \quad \gamma \wedge \gamma^{\dagger_{h}}+\beta^{\dagger_{h}} \wedge \beta=0 \text { on } X-D \tag{19}
\end{equation*}
$$

will be refered to as a decoupled solution. Let $\iota: F \rightarrow V=L^{-2} K \oplus L K$ be the Hecke modification associated to $(F, \beta, \gamma)$ as in Theorem 2.4.

Lemma 3.1. $h_{\infty}$ on $\left.F\right|_{X-D}$ is a decoupled solution iff it has the form

\end{equation*}
$$

where $h_{K}$ is the unique metric on $K$ such that $|q| \equiv 1$ under induced metric on $K^{2}$ and $h_{L}$ is a harmonic metric adapted to a filtered line bundle $(L, \lambda)$ with $\operatorname{deg} L+\sum_{j} \lambda_{j}=0$.

Proof. Over $X-D$ we use $\iota$ (resp. det $\iota$ ) to identify $F$ (resp. $\operatorname{det} F=L^{-1}$ ) with $V=L^{-2} K \oplus L K\left(\right.$ resp. $\left.\operatorname{det} V=L^{-1} K\right)$ and write $h_{\infty}$ as $\iota^{*} h$ for some metric $h$ on $\left.V\right|_{X-D}$. On $X-D$ we have $(F, \beta, \gamma) \cong\left(V, b=\left(\begin{array}{ll}0 & q^{-1}\end{array}\right), c=\left(\begin{array}{ll}0 & q^{2}\end{array}\right)^{T}\right)$. Locally let $\sigma$ (resp. $\theta$ ) be nowhere vanishing holomorphic section of $L$ (resp. $K$ ) such that $\theta^{2}=q$. The sections $\sigma_{1}=\left(\sigma^{-2} \otimes \theta, 0\right), \sigma_{2}=(0, \sigma \otimes \theta)$ (resp. $\left\{\sigma \otimes \theta^{-2}\right\}$ ) form a frame of $V$ (resp. $\left.\operatorname{det} V^{*}\right)$. With respect to these, the Higgs field is given by $b=(0,1), c=(0,1)^{T}$. Let $H=h_{\sigma}$. The second equation in (19) implies $c c^{*} H(\operatorname{det} H)=(\operatorname{det} H)^{-1} H^{-1} b^{*} b$. We have by a direct calculation

Therefore the holomorphic direct sum $V=L^{-2} K \oplus L K$ is also $h$-orthogonal. We have $h=h_{1} \oplus h_{2}$ where $h_{1}, h_{2}$ are metrics on the two summands on $X-D$. Equivalently, these are induced by metrics $h_{L}$ (resp. $h_{K}$ ) on $L$ (resp. $K$ ). By flatness of $\nabla_{h}, \nabla_{h_{L}}$, $\nabla_{h_{K}}$ are both flat on $X-D$. We have $H_{11}=|\sigma|_{h_{L}}^{-4}|\theta|_{h_{K}}=|\sigma|_{h_{L}}^{-4}|q|_{h_{K}^{2}}^{1 / 2}$, $H_{22}=|\sigma|_{h_{L}}^{2}|q|_{h_{K}}^{1 / 2}$.
Therefore, $|q|_{h_{K}^{2}}=\left(H_{11} H_{22}^{2}\right)^{2 / 3} \equiv 1$.
Let $f=\log |\sigma|_{h_{L}}$. Since $F_{\nabla_{h_{L}}}=0$ on $\mathbb{D}_{j}^{\times}, f$ is a positive harmonic function on $\mathbb{D}_{j}^{\times}$. By Bôcher's theorem (see Theorem $3.9[\mathbf{A x l 0 1}]$ ), it has the form $\lambda_{j} \log \left|\zeta_{j}\right|+f_{0}$ with $f_{0}$ harmonic on $\mathbb{D}_{j}$. The condition on the sum of $\lambda_{j}$ now follows from Theorem 2.3. q.e.d.

Given $s_{0}$ a nowhere vanishing section of $L$ over $(\mathbb{D}, \zeta)$ centered at $p \in D$ and let $\sigma_{1}$, $\sigma_{2}$ be the induced frame as in the statement of Theorem 2.4. A decoupled solution $h_{\infty}=\iota^{*}\left(h_{L}^{-2} h_{K} \oplus h_{L} h_{K}\right)$ under these frames are given by

where $f=\left|s_{0}\right|_{h_{L}}^{2}$ and $\rho=|\zeta|$.
3.2. Local model. In this part, we construct a family of local model solutions in $\mathbb{D}_{j}$ depending on a real parameter $\lambda$ asymptotic to $h_{\infty}$ defined in Lemma 3.1 outside $\mathbb{D}_{j}$ with $\lambda=\lambda_{j}$. It will be defined by harmonic metric adapted to an unramifiedly good filtered Higgs bundle over $\left(\mathbb{P}^{1},[1: 0]\right)$ for $p_{j} \in D_{r}$ and by an explicit formula using solution to a Painlevé III type equation for $p_{j} \in D_{\beta}, D_{\gamma}$. It will be shown below that the stability condition of these filtered Higgs bundles are equivalent to

\begin{cases}\lambda_{j}=-1 / 4 & p_{j} \in D_{\beta} \\ \lambda_{j}=1 / 4 & p_{j} \in D_{\gamma} \\ \left|\lambda_{j}\right|<1 / 4 & p_{j} \in D_{r}\end{cases}
$$

A tuple $\lambda$ satisfying these conditions will be called admissible with respect to a partition $\underline{D}$ of $D$. We will first describe the set of these admissible weights. Let

We have the following simple fact
Lemma 3.2. Let $C$ be the cube in $\mathbb{R}^{4 n}$ with vertices $V=\{( \pm 1 / 4, \ldots, \pm 1 / 4)\}$ (i.e. $C$ is the convex hull of $V$ ), $m$ an integer with $|m|<n . ~ f\left(x_{1}, \ldots, x_{4 n}\right)=\sum_{j} x_{j}$ and $H=f^{-1}(m)$. For $\boldsymbol{x} \in C \cap H$, let $d_{1}(\boldsymbol{x})=\#\left\{j \mid x_{j}=1 / 4\right\}, d_{2}(\boldsymbol{x})=\#\left\{j \mid x_{j}=-1 / 4\right\}$. Then we have that either (i) $d_{1}<2(n+m), d_{2}<2(n-m)$ or (ii) $d_{1}=2(n+m), d_{2}=2(n-m)$. The latter case corresponds to $x$ being one of the vertices.

With $n=g-1, m=-\operatorname{deg} L$ and $d_{1}=d_{\gamma}, d_{2}=d_{\beta}$, it follows from Prop 2.6 and the above lemma that the closure $\overline{\mathscr{P}}_{d, g}$ is the intersection $C \cap H$. It is easy to show that no edges of the cube $C$ passes through $H$, therefore $V \cap H$ is the extremal set of $C \cap H$. This is a compact convex polytope whose vertices $V \cap H=\overline{\mathscr{P}_{d, g}}-\mathscr{P}_{d, g}$ consists of $\mathscr{P}_{\underline{D}}$ with $\underline{D}$ strictly polystable. The interior $\left(\mathscr{P}_{d, g}\right)^{\circ}=\mathscr{P}_{\underline{D}}$ with $d_{\beta}=d_{\gamma}=0$, whereas $\mathscr{P}_{\underline{D}}$ for $\underline{D}$ stable and $d_{\beta}$ or $d_{\gamma}>0$ are the interiors of the positive-dimensional faces of $\overline{\mathscr{P}_{d, g}}$.

Note that the face $\mathscr{P}_{\underline{D}}$ has vertices consisting of tuples $\lambda$ such that $\lambda_{j}=1 / 4$ for $p_{j} \in D_{\beta}, \lambda_{j}=-1 / 4$ for $p_{j} \in D_{\gamma}$ and $\#\left\{j \mid \lambda_{j}=1 / 4, p_{j} \in D_{r}\right\}=2(g-1-d)-d_{\beta}$, $\#\left\{j \mid \lambda_{j}=-1 / 4, p_{j} \in D_{r}\right\}=2(g-1+d)-d_{\gamma}$. It follows easily that the barycenter is characterized by the conditions listed in Theorem 1.1

We begin by constructing the local model for points in $D_{r}$. Let $\left[x_{0}: x_{1}\right]$ be the homogeneous coordinate on $\mathbb{P}^{1}$ and $U_{1}=\left\{x_{1} \neq 0\right\}$ (resp. $U_{0}=\left\{x_{0} \neq 0\right\}$ ) the affine chart with coordinate $z=x_{0} / x_{1}$ (resp. $w=x_{1} / x_{0}$ ). Set

p: \mathbb{P}^{1} \rightarrow \mathbb{P}^{1},\left[x_{0}: x_{1}\right] \longmapsto\left[x_{0}^{2}: x_{1}^{2}\right] \tag{24}
\end{equation*}

and $\zeta=z^{2}$ coordinate on affine chart $p\left(U_{1}\right)$ and let $\rho=|\zeta|$. Denote $O^{\prime}=O(*[1: 0])$ and $O=O_{\mathbb{P}^{1}}$. Let $\mathcal{E}=\left(O^{\prime}\right)^{\oplus 3}$ with free generators $\left\{e_{0}, e_{1}, e_{2}\right\}$. Note $z \in O^{\prime}$ whereas $w \notin O^{\prime}$, and $d z \in O^{\prime} \otimes_{O} \Omega_{\mathbb{P}^{1}}^{1}$ as in $\$ 2.3$ Define

$$
\theta: \mathcal{E} \rightarrow \mathcal{E} \otimes \Omega_{\mathbb{P}^{1}}^{1}, \quad \theta=\sqrt{2} z\left(\begin{array}{ccc} 
& z^{2} & 1  \tag{25}\\
1 & & \\
z^{2} & &
\end{array}\right) d z
$$

Define $v_{j}=T_{k+1, j+1} e_{k} \in \mathcal{E}$ for $j=0,1,2$ where

T=\left(\begin{array}{ccc}

These generate $\mathcal{E}$ over $U_{0}$, and $\theta v_{0}=2 z^{2} v_{0} \otimes d z, \theta v_{1}=-2 z^{2} v_{1} \otimes d z$, and $\theta v_{2}=0$.
Let $m_{0}, m_{1}, m_{2} \in \mathbb{Z}$ and

\mathcal{F}_{m_{0}, m_{1}, m_{2}}=\left\{\sum_{j=0}^{2} f_{j} v_{j} \mid \operatorname{ord}_{[1: 0]} f_{j} \geq-m_{j}\right\}
$$

It is a locally free $O$-submodule of $\mathcal{E}$. Sections $e_{0}, e_{1}, e_{2}$ (resp. $w^{-m_{0}} v_{0}, w^{-m_{1}} v_{1}$, $w^{-m_{2}} v_{2}$ ) trivialize $\mathcal{F}_{m_{0}, m_{1}, m_{2}}$ over $U_{1}$ (resp. $U_{0}$ ). The corresponding transition matrix is $G_{01}=T \cdot \operatorname{diag}\left(z^{m_{1}}, z^{m_{2}}, z^{m_{3}}\right)$. We have $\operatorname{det} G_{01}=($ const $) z^{m_{1}+m_{2}+m_{3}+3}$ is the transition function of the line bundle $\operatorname{det} \mathcal{F}_{m_{0}, m_{1}, m_{2}}$. Therefore, $\operatorname{deg} \mathcal{F}_{m_{0}, m_{1}, m_{2}}=3+m_{1}+m_{2}+m_{3}$. For $\boldsymbol{c}=\left(c_{0}, c_{1}, c_{2}\right)$, the $b$-family of $O$-submodules

$$

\mathcal{P}_{b}^{c} \mathcal{E}=\mathcal{F}_{\left\lfloor b-c_{0}\right\rfloor,\left\lfloor b-c_{1}\right\rfloor,\left\lfloor b-c_{2}\right\rfloor} \tag{27}
\end{equation*}
$$

defines a filtered bundle structure on $\mathcal{E}$ with $\operatorname{deg}\left(\mathcal{P}_{*}^{c} \mathcal{E}\right)=3-c_{0}-c_{1}-c_{2}$. By Def 2.7 $\left(\mathcal{P}_{b}^{c} \mathcal{E}, \theta\right)$ is an unramifiedly good filtered Higgs bundle.

For $0 \leq i<j \leq 2$, let $\mathcal{L}_{j}=O^{\prime} v_{j}$ and

\mathcal{S}_{i j}=\left\{\left.\left(\frac{a_{-1}}{z}+g_{1}\right) v_{i}+\left(-\frac{a_{-1}}{z}+g_{2}\right) v_{j} \right\rvert\, g_{1}, g_{2} \in O^{\prime}, a_{-1} \in \mathbb{C}\right\}
$$

with induced filtered bundle structure $\mathcal{P}_{b} \mathcal{L}_{j}=\mathcal{L}_{j} \cap \mathcal{P}_{b}^{c} \mathcal{E}, \mathcal{P}_{b} \mathcal{S}_{i j}=\mathcal{S}_{i j} \cap \mathcal{P}_{b}^{c} \mathcal{E}$. We have

\operatorname{deg} \mathcal{P}_{*} \mathcal{L}_{j}=-c_{j}, \operatorname{deg} \mathcal{P}_{*} \mathcal{S}_{i j}=1-c_{i}-c_{j}
$$

These are the only nonzero proper $\theta$-invariant $O^{\prime}$-submodules. Let

We have that for all $t \in \mathbb{R}_{+},\left(\mathcal{P}_{b}^{c} \mathcal{E}, t \theta\right)$ is a stable with $\operatorname{deg} \mathcal{P}_{*}^{c} \mathcal{E}=0$ iff $\boldsymbol{c} \in S$.
Lemma 3.3. For $t>0,-1 / 4<\lambda<1 / 4$, there is a unique smooth function $K=K_{t, \lambda}: \mathbb{C}_{z} \rightarrow i \mathfrak{u}(2)$, positive definite, satisfying

The metric defined by $h\left(e_{i}, e_{j}\right)=\left(\widetilde{K}_{t, \lambda}\right)_{j+1, i+1}$ for $i, j=0,1,2$ is adapted to filtered bundle $\mathcal{P}_{*}^{c} \mathcal{E}$ with $\boldsymbol{c}=(1+2 \lambda, 1+2 \lambda, 1-4 \lambda)$.

Let $\zeta=z^{2}$. We have at $z \neq 0$,

\partial_{\bar{\zeta}}\left(K^{-1} \partial_{\zeta} K\right)=\left(4|z|^{2}\right)^{-1} \partial_{\bar{z}}\left(K^{-1} \partial_{z} K\right)=t^{2}\left(\gamma_{1} \gamma_{1}^{*} K \operatorname{det} K-(\operatorname{det} K)^{-1} K^{-1} \beta_{1}^{*} \beta_{1}\right) .
$$

Proof. We have $\boldsymbol{c}=(1+2 \lambda, 1+2 \lambda, 1-4 \lambda) \in S$ iff $-1 / 4<\lambda<1 / 4$, in which case $\left(\mathcal{P}_{*}^{c} \mathcal{E}, t \theta\right)$ is a stable unramifiedly good filtered Higgs bundle. By Theorem 2.2, there is a harmonic metric $h=h_{t, \lambda}$ on $\mathcal{E}$ adapted to it, unique up to $\mathbb{R}_{+}$.

Let $g: \mathcal{E} \rightarrow \mathcal{E}$ be given by $e_{0} \mapsto-e_{0}, e_{j} \mapsto e_{j}$ for $j=1,2$. We have $g\left(v_{0}\right)=v_{1}$, $g\left(v_{1}\right)=v_{0}$, and $g\left(v_{2}\right)=v_{2}$. For any $v \in \mathcal{E}, b \in \mathbb{R}$, we have that $v \in \mathcal{P}_{b}^{c} \mathcal{E}$ iff $g(v) \in \mathcal{P}_{b}^{c} \mathcal{E}$. Therefore, $g^{*} h$ is also adapted to filtered bundle $\mathcal{P}_{*}^{c} \mathcal{E}$.

We have $g^{-1} \cdot F_{\nabla_{h}} \cdot g=F_{\nabla_{g^{*} h}}, g^{-1}\left[\theta \wedge \theta^{* h}\right] g=\left[\theta^{g} \wedge\left(\theta^{g}\right)^{*\left(g^{* h}\right)}\right]$ and $\theta^{g}=g^{-1} \theta g=-\theta$. Therefore

F_{\nabla_{g^{*} h}}+t^{2}\left[(-\theta) \wedge(-\theta)^{*\left(g^{*} h\right)}\right]=0
$$

It follows that $g^{*} h$ is a harmonic metric adapted to $\left(\mathcal{P}_{*}^{c} \mathcal{E}, t \theta\right)$. Thus there is $c>0$ such that $g^{*} h=c h$. For $j=1,2$, we have $-h\left(e_{0}, e_{j}\right)=h\left(g e_{0}, g e_{j}\right)=g^{*} h\left(e_{0}, e_{j}\right)=\operatorname{ch}\left(e_{0}, e_{j}\right)$. Therefore, $h\left(e_{0}, e_{j}\right)=0$, and $h=h_{t, \lambda}$ has block diagonal form which we may write as

where $K_{t, \lambda}$ is $2 \times 2$ Hermitian matrix-valued function of $z \in \mathbb{C}$ and $\delta_{t, \lambda}>0$. Note that $v_{0} \wedge v_{1} \wedge v_{2}=-4 \sqrt{2} z^{3} e_{0} \wedge e_{1} \wedge e_{2}$ and $c_{0}+c_{1}+c_{2}=3$. We have that $\left|e_{0} \wedge e_{1} \wedge e_{2}\right|_{\operatorname{det} h}^{2}$ is harmonic on $U_{0}$ and bounded near [1:0] $\in \mathbb{P}^{1}$. Therefore, $\delta_{t, \lambda}^{-1} \operatorname{det} K_{t, \lambda}$ is a constant. We may normalize this to 1 and the resulting $K_{t, \lambda}, \delta_{t, \lambda}$ is uniquely determined. We have $\delta_{t, \lambda}=\operatorname{det} K_{t, \lambda}$. (29) follows from (7) and (25).
q.e.d.

Let $B, C$ (resp. $K$ ) be function of $z \in \mathbb{C}$ valued in $3 \times 3$ matrices (resp. $3 \times 3$ positive-definite Hermitian matrices). Define

It follows that $S(K, B, C)=$ $\rho_{\phi}^{*} g_{\phi} S\left(g_{\phi}^{*}\left(\rho_{-\phi}^{*} K\right) g_{\phi}, B, C\right) g_{\phi}^{-1}$. Thus we have

under $\left\{v_{0}, v_{1}, v_{2}\right\}$. Note that $\operatorname{ord}_{[1: 0]} f=\operatorname{ord}_{[1: 0]} \rho_{\phi}^{*} f$ and $\phi \in \mathbb{R}$. It follows that $v \in \mathcal{P}_{b}^{c} \mathcal{E}$ iff $\rho_{\phi}^{*} v \in \mathcal{P}_{b}^{c} \mathcal{E}$. Therefore, $z \mapsto g_{\phi}^{*} K_{t, \lambda}\left(z e^{-i \phi}\right) g_{\phi}$ is a smooth function $\mathbb{C} \rightarrow i \mathfrak{u}(2)$ satisfying properties in Lemma3.3 It follows from the uniqueness that

For $f_{j} \in O^{\prime}$, we have that $\sum_{j} f_{j} v_{j} \in \mathcal{P}_{b}^{c} \mathcal{E}$ iff $\sum_{j} t^{2 / 3} \eta_{-t}^{*} f_{j} v_{j} \in \mathcal{P}_{b}^{c} \mathcal{E}$. Therefore, $z \mapsto$ $\Gamma_{t}^{*} K_{t, \lambda}\left(t^{-1 / 3} z\right) \Gamma_{t}$ gives a harmonic metric adapted to $\mathcal{P}_{*}^{c} \mathcal{E}$. By the uniqueness in Lemma 3.3. we have

By the continuity and positive-definiteness of $K_{t, \lambda}$, in a bounded neighborhood of the origin, det $H_{t, \lambda}$ is bounded away from zero. Furthermore, it is not hard to see that we have $f_{j} \in C^{\infty}([0, \infty))$ with $f_{j}^{\prime}(0)=0$ and $f_{3}(0)=0$. A direct calculation shows $\partial_{z} F, \partial_{\bar{z}} F=O(|z|)$ as $z \rightarrow 0$. As $\zeta=z^{2}$ we have $\partial_{\zeta}=(2 z)^{-1} \partial_{z}$ and
$\partial_{\bar{\zeta}}=(2 \bar{z})^{-1} \partial_{\bar{z}}$. The entries of $\partial_{\zeta} H_{t, \lambda}, \partial_{\overline{\mathcal{L}}} H_{t, \lambda}$ are bounded at the origin. Thus the same is true for $\partial_{\zeta}\left(\operatorname{det} H_{t, \lambda}^{-1}\right)$ and $\partial_{\bar{\zeta}}\left(\operatorname{det} H_{t, \lambda}^{-1}\right)$. Let

A bootstrap argument can be used to improve our knowledge on the regularity of $M$ at 0 . Consider two intermediate open neighborhoods: $0 \in \Omega^{\prime \prime} \Subset \Omega^{\prime} \Subset \Omega$. By elliptic regularity estimate (see, e.g. [DK90] Appendix III), there is some $C>0$ such that

Using the elliptic regularity of the Cauchy-Riemann operator $\partial_{\bar{\zeta}}$, we have $C^{\prime}>0$ such that

From the above $M^{ \pm 1}$ is bounded at 0 and $\left\|\partial_{\zeta} M\right\|_{L^{2}(\Omega)}<\infty$. By the Sobolev embedding $L_{1}^{2} \subset L^{4},\left\|\partial_{\zeta} M\right\|_{L^{4}\left(\Omega^{\prime}\right)}$ is bounded. This implies the same bound on $\left\|\partial_{\bar{\zeta}} M\right\|_{L^{4}\left(\Omega^{\prime}\right)}$ since $\partial_{\bar{\zeta}} M=\left(\partial_{\zeta} M^{*}\right)^{*}=\left(\partial_{\zeta} M\right)^{*}$. Thus there is $C^{\prime \prime}>0$ such that

Suppose $M \in L_{k+1}^{2}\left(\Omega_{k}\right)$ for some $k \geq 1$ and $0 \in \Omega_{k}^{\prime} \Subset \Omega_{k}$. By elliptic estimate, there is $C>0$ such that

Use $\nabla$ to denote either $\partial_{\zeta}$ or $\partial_{\bar{\zeta}}$, and $\nabla^{\ell}$ will denote $\partial_{\zeta}^{\ell_{1}} \partial_{\bar{\zeta}}^{\ell_{2}}$ with $\ell_{1}+\ell_{2}=\ell$. Then $\nabla^{k} \mathcal{T}_{1}(M)$ is a sum of terms of the form

where $n_{j} \in \mathbb{Z}$ and $\ell_{j} \geq 0, \sum_{j=1}^{m} \ell_{j}=k+2$, and for at least two indices $j$, we have $\ell_{j} \geq 1$. For the terms with $\ell_{j} \leq k$ for all $j$, take $p_{1}, \ldots, p_{m}>2$ with $1 / 2=\sum_{j} p_{j}^{-1}$ we have:

Therefore, by Sobolev embedding theorems (e.g. [DK90] Appendix IV), there is $C^{\prime}>0$ such that $\|M\|_{L_{\ell_{j}}^{p_{j}}} \leq C^{\prime}\|M\|_{L_{k+1}^{2}\left(\Omega_{k}\right)}<\infty$. The only terms left are of the form $\left(\nabla^{k+1} M\right) M^{-1}(\nabla M)$ or $(\nabla M) M^{-1}\left(\nabla^{k+1} M\right)$. These have finite $L^{2}\left(\Omega_{k}\right)$-norms since both $M^{-1}$ and $\nabla M$ have bounded entries at 0 and $M \in L_{k+1}^{2}\left(\Omega_{k}\right)$ by assumption. It follows by induction on $k$ and Sobolev embedding theorems that $M \in C^{\infty}$.

Summarize the above discussion, we have proven the following.
Proposition 3.4. For $-1 / 4<\lambda<1 / 4$, there is a smooth function $H_{t, \lambda}: \mathbb{C} \rightarrow i u(2)$ scuh that $K_{t, \lambda}(z)=H_{t, \lambda}\left(z^{2}\right)$ where $K_{t, \lambda}$ is the function in Lemma 3.3. In particular,

Let $(F, \beta, \gamma)$ be a stable $\mathrm{SU}(1,2)$ Higgs bundle. Recall notations in Def 2.10 and $s_{0}$ be a trivializing section of $L$ over the coordinate disk $(\mathbb{D} ; \zeta)$ centered at $p \in D_{r}$ and let $\boldsymbol{s}=\left\{s_{1}, s_{2}\right\}\left(\right.$ resp. $\left.\boldsymbol{\sigma}=\left\{\sigma_{1}, \sigma_{2}\right\}\right)$ be frames of $F$ (resp. $V$ ) over $D$ induced by $s_{0}$ as in the statement of Theorem 2.4. We fix notation for Hermitian metrics corresponding to the Hermitian-matrix valued functions above.

Definition 3.5. Denote by $h_{t, \lambda}$ the metric on $F$ over $D$ with $h_{t, \lambda}=\left(H_{t, \lambda}\right)_{s}$ where $H_{t, \lambda}$ is as in Prop 3.4 Denote by $\widetilde{h}_{t, \lambda}$ the metric on $\mathcal{E}$ given by $\widetilde{h}_{t, \lambda}\left(e_{i+1}, e_{k+1}\right)=\left(\widetilde{K}_{t, \lambda}\right)_{k i}$ where $i, k=0,1,2$ and $\widetilde{K}_{t, \lambda}$ is as in Lemma 3.3

We have by a direct calculation

Alternatively, $M_{\lambda}$ is a submatrix of $\left(\widetilde{h}_{1, \lambda}\right)_{\widetilde{\sigma}}$ where the frame on $\mathcal{E}$ is given by $\widetilde{\sigma}_{j}$ for $j=0,1,2$ where $\widetilde{\sigma}_{j}=\sum_{\ell=0}^{2}\left(T_{e \sigma}\right)_{\ell+1, j+1} e_{\ell}$ where

Note that $\lambda$ in $H_{t, \lambda}$ is characterized by $\operatorname{det} H_{t, \lambda}(\zeta)=O\left(|\zeta|^{c}\right)$ as $\zeta \rightarrow 0$ for $c<-2 \lambda$ and $\operatorname{det} H_{t, \lambda}(\zeta) \neq O\left(|\zeta|^{c}\right)$ as $\zeta \rightarrow 0$ for $c>-2 \lambda$.

For local model around points in $D_{\beta}, D_{\gamma}$, replace $\theta$ in (25) by

Same procedures as above defines an unramifiedly good filtered Higgs bundle $\left(\mathcal{P}_{*}^{c} \mathcal{E}, \theta\right)=\left(\mathcal{P}_{*}^{\left(c_{0}, c_{1}\right)} \mathcal{E}^{\prime}, \theta_{1}\right) \oplus\left(O^{\prime} e_{2}, 0\right)$ where $\mathcal{E}^{\prime}=O^{\prime} e_{0} \oplus O^{\prime} e_{1}$. By a similar discussion the rank-two summand is stable if $c_{0}, c_{1}>0$ and $c_{0}+c_{1}=1$. By arguments similar to the proof of Lemma 3.3, the corresponding metric has a local form (31) iff $c_{0}=c_{1}=1 / 2$. In fact in these cases, there is a more explicit formula similar to the local fiducial solution of [MSWW16] the local model, in terms of the a smooth solution of an ODE of Painlevé type III:

The result below therefore follows by a direct calculation verifying that $H_{t}$ indeed satisfies (38) with respective $\beta_{0}, \gamma_{0}$ and that $\psi_{P}$ defined below is smooth at the origin.

Furthermore, the solution satisfying the above asymptotic estimate is unique up to the choice of $c \in \mathbb{C}^{\times}$.

In the following we will refer to $\psi_{P}$ as the Painlevé function. The estimate below follows easily from (46) and will be useful later.

In order for the gluing construction to work well it will be necessary to know the behavior of function $M_{\lambda}$ at large radius with bounds uniform in $\lambda$ in some interval. We fix a small enough $\delta>0$ and let $I=(-1 / 4+$ $\delta, 1 / 4-\delta)$. Constants in an inequality will be said to be independent of $\lambda$ if it holds for all $\lambda \in I$. (These could still depend on choise of $\delta$.) In particular, we will show:

Proposition 3.8. There are $\rho_{0}>1$ and $C_{1}, C_{2}>0$ such that for all $\lambda \in I$ and $\rho \geq \rho_{0}$, we have

The coefficient $c_{\lambda}$ will play a central role in the gluing construction. Constants in the estimates below which does depend on $\lambda \in I$ will often depend on it through a continuous function of $c_{\lambda}$. Furthermore, the above gives asymptotics of the metric $\widetilde{h}_{1, \lambda}$ defined in $\operatorname{Def} 3.5$ Therefore by (48), we have $c_{0}=4$.

The estimates will build upon relevant results in [Moc16]. We first review these results. Then we use the local form of $\widetilde{h}_{1, \lambda}$ under $\widetilde{\boldsymbol{\sigma}}$ as well as Prop 2.12 to get the estimates in value. The gradient estimate relies on results similar to Lemma 3.12 and 3.13 in Moc16]. The continuity of $c$ and uniformity of constants $C_{1}, C_{2}$ on $I$ are similar to Prop 3.15 [Moc16] using an identity from [Sim88].
3.3.1. Asymptotic estimates of Mochizuki. $\left(E, \bar{\partial}_{E}, \theta, h\right)$ is called a harmonic bundle if $\bar{\partial}_{E} \theta=0$ and $h$ solves the Hitchin equation $F_{\nabla_{h}}+\left[\theta \wedge \theta^{*}\right]=0$. The following combines Propositions 2.1, 2.3, 2.10, 2.12 and Cor 2.6 of [Moc16].

Theorem 3.1. Let $\left(E, \bar{\partial}_{E}, \theta, h\right)$ be a harmonic bundle of rank $N$ with holomorphic decomposition $\left(E, \bar{\partial}_{E}, \theta\right)=\bigoplus_{j=1}^{N}\left(E_{j}, \bar{\partial}_{E_{j}}, \theta_{j}\right)$ over a chart $(\mathbb{D} ; z) \subset X$ with $\mathbb{D}=\{|z|<R\}$ where $E_{j}$ is a line bundle over $\mathbb{D}$. Let $\theta_{j}=f_{j} d z$ and $M>0$ such that $\left|f_{j}\right|<M$ on $\mathbb{D}$. Suppose $d=\min \left\{\left|f_{i}-f_{j}\right|: i \neq j\right\} \geq 1$. Then for any $0<r<R$ let $\mathbb{D}^{\prime}=\{|z|<r\}$, there are $C, c>0$ depending only on $R, r, M / d, N$ such that

The following bounds the covariant derivative by the gradient of the norm. It is a slight generalization of Lemma 3.12 in [Moc16].

In the following we denote $\widetilde{h}_{1, \lambda}$ by $\widetilde{h}$. An estimate is said to hold for $\rho \gg 1$ if there is $\rho_{0}>1$ such that it holds for $\rho \geq \rho_{0}$. In order to bound the first derivatives of off-diagonal elements, we apply Lemma 3.10 to $\left|v_{j}\right|_{\breve{h}}$, and given that $|\lambda|<1 / 4$, we have for $|\zeta| \gg 1$ there is $C_{7}>0$ independent of $\lambda \in I$ with $\left|\partial_{\zeta} \log \right| v_{j}\left|\frac{2}{\hbar}\right| \leq C_{7}|\zeta|^{-1}$. This provides a bound for the first term on the right-hand side of the inequality in the statement of Lemma 3.9. The other term is bounded by $e^{-(\text {const) } \rho}$ and is certainly bounded by the first term for $\rho \gg 1$. It follows that for $\rho \gg 1$, there is $C_{8}>0$ independent of $\lambda \in I$ with

3.3.4. Uniform boundedness of family of Hermitian-Yang-Mills metrics. In this part we finish proof of Prop 3.8, which follows from Prop 3.13 and:

Proposition 3.14. The function $\lambda \mapsto c_{\lambda}$ is continuous.
This is the continuity of the next-to-leading order in $\lambda \mapsto \widetilde{h}_{1, \lambda}$. We build on the proof of Prop 3.15 in [Moc16] for the rank-two case. Note that the conclusion will follow once we can show that for any $\lambda_{0} \in(-1 / 4,1 / 4)$ on $\{\rho \geq 1\}, \rho^{2\left(\lambda_{0}-\lambda\right) m_{\lambda_{0}} m_{\lambda}^{-1}-1} \rightarrow 1$ uniformly as $\lambda \rightarrow \lambda_{0}$. By Prop 3.13, there are $C_{\mathrm{I}}(\lambda), c_{\mathrm{I}}(\lambda), C_{\mathrm{II}}, C_{\mathrm{III}}$, $c_{\mathrm{III}}>0$ such that $\mathrm{I} \leq C_{\mathrm{I}}(\lambda) e^{-c_{\mathrm{I}} \rho}, \mathrm{III} \leq C_{\mathrm{III}} e^{-c_{\mathrm{III}} \rho}$ and that $\left|\rho^{2} \mu_{\lambda_{0}}^{2} m_{\lambda_{0}}\right| \leq C_{\mathrm{II}}$. Therefore by first taking $\rho \rightarrow \infty$, we have that $c_{\lambda} \rightarrow c_{\lambda_{0}}$ as $\lambda \rightarrow \lambda_{0}$.

Let $I_{0} \Subset(-1 / 4,1 / 4)$ containing $\lambda_{0}$. All constants in inequalities below will depend only on $I_{0}$ unless stated otherwise. Consider an auxiliary family $\widetilde{h}_{\lambda}^{0}$ for $\lambda \in I_{0}$ such that (1) $\widetilde{h}_{\lambda_{0}}^{0}=\widetilde{h}_{1, \lambda_{0}}$, (2) $\operatorname{det} \widetilde{h}_{\lambda}^{0}=\operatorname{det} \widetilde{h}_{1, \lambda} \equiv 1$ the standard metric on trivial bundle, (3) $\widetilde{h}_{\lambda}^{0} \rightarrow \widetilde{h}_{1, \lambda_{0}}$ uniformly on any $K \Subset \mathbb{P}^{1}-\{[1: 0]\}$ in $C^{\infty}$ sense as $\lambda \rightarrow \lambda_{0}$, and (4) on $\{|z| \geq 1\}$

Let $k_{\lambda}$ be given by $\widetilde{h}_{1, \lambda}=\widetilde{h}_{\lambda}^{0} k_{\lambda}$. We have that $k_{\lambda}$ is self-adjoint (with respect to both metrics) and positive-definite. It follows that $\left|k_{\lambda}\right| \leq C \operatorname{tr} k_{\lambda}^{2 / 2} \leq C \operatorname{tr}\left(k_{\lambda}\right)$ for some constant $C>0$. Since $\operatorname{det} k_{\lambda}=1, \operatorname{tr} k_{\lambda} \geq 3$ where equality happens iff $k_{\lambda}=$ Id. \sup _{\mathbb{P}^{1}}\left|s_{\lambda}\right| \leq C_{8}^{\prime}\left|s_{\lambda}\right|_{L^{1}, \widetilde{h}_{\lambda}^{0}, g_{\mathbb{P}^{1}}} \leq C_{8} .
$$

We have that $\mathbb{F}_{\lambda} \rightarrow 0$ uniformly on compact sets as $\lambda \rightarrow \lambda_{0}$. By (66), (67), and the uniform boundedness of sup $\left|s_{\lambda}\right|$ we have as $\lambda \rightarrow \lambda_{0}$

It follows that $\left\|\bar{\partial} s_{\lambda}\right\|_{L^{2}}=\left\|\partial_{h} s_{\lambda}\right\|_{L^{2}} \rightarrow 0$ where $h=\widetilde{h}_{\lambda}^{0}$. Therefore $\left\|s_{\lambda}\right\|_{L_{1}^{2}}$ is bounded uniformly in $\lambda$. Choose $s_{\lambda_{n}} \rightharpoonup s_{\infty}$ weakly in $L_{1}^{2}$. We have $\left\|s_{\infty}\right\|_{L^{p}}=1>0, s_{\infty}$ is a nonzero holomorphic endomorphism commuting with $\theta$. By stability of $\left(\mathcal{P}_{*}^{c} \widetilde{\mathcal{E}}, \theta\right), s_{\infty}$ must be a nonzero multiple of the identity. Since $\operatorname{det} k_{\lambda}=1$, we have $\lim _{n \rightarrow \infty} \operatorname{det} s_{\lambda_{n}}=$ $\lim _{n \rightarrow \infty}\left\|k_{\lambda_{n}}\right\|^{-3}=\operatorname{det} s_{\infty} \neq 0$.

Suppose $\left\|k_{\lambda}\right\|$ is not uniformly bounded below near $\lambda_{0}$. There is a sequence $\left\|k_{\lambda_{n}}\right\|^{-3} \rightarrow$ 0 as $n \rightarrow \infty$, which also holds for any further subsequence, leading to a contradiction. Therefore, $\left\|k_{\lambda}\right\|$ is bounded uniformly in $\lambda$. It follows that $k_{\lambda}=\left\|k_{\lambda}\right\| s_{\lambda}$ is uniformly bounded in $L_{1}^{2}$. For a sequence $\lambda_{n} \rightarrow \lambda_{0}$ as $n \rightarrow \infty$, there is a weakly $L_{1}^{2}$-convergent subsequence $k_{\lambda_{n_{\ell}}} \rightarrow k_{\infty}$ as $\ell \rightarrow \infty$. By the same argument, $k_{\infty}$ is a nonzero multiple of the identity. Furthermore, $k_{\infty}=\mathrm{Id}$ since $\operatorname{det} k_{\lambda} \equiv 1$. It follows that $k_{\lambda} \rightarrow$ Id weakly in $L_{1}^{2}$.

We have

which is bounded in $L^{p}$ uniformly in $\lambda$. By Lemma 3.16, there is $C_{10}>0$ such that $\sup \left(\operatorname{tr} k_{\lambda}-3\right) \leq C_{10}\left\|\operatorname{tr} k_{\lambda}-3\right\|_{L^{1}}$. For any sequence $k_{\lambda_{n}}$ with $\lambda_{n} \rightarrow \lambda_{0}$ as $n \rightarrow \infty$, we may take subsequence $k_{\lambda_{n_{k}}}$ as above such that $\operatorname{tr} k_{\lambda_{n_{k}}} \rightarrow 3$ in $L^{2}$ hence $L^{1}$. The above
inequality implies that $k_{\lambda_{n_{k}}} \rightarrow 3$ uniformly, hence $k_{\lambda_{n_{k}}} \rightarrow$ Id uniformly. Therefore, we have that $k_{\lambda} \rightarrow$ Id as $\lambda \rightarrow \lambda_{0}$ uniformly on $\mathbb{P}^{1}$.
q.e.d.

Corollary 3.18. The $\lambda$-family of matrix-valued function $H_{1, \lambda}$ defined in Prop 3.4 is continuous with respect to $\lambda$ in $C^{0}(\Omega)$ for any $\Omega \subset \mathbb{C}$ bounded. Furthermore, for $I_{0} \Subset(-1 / 4,1 / 4)$ we have $C=C\left(k, I_{0}, \Omega\right)>0$ such that

- $\widetilde{h}_{\lambda}^{0} \rightarrow \widetilde{h}_{1, \lambda_{0}}$ as $\lambda \rightarrow \lambda_{0}$ uniformly, in $C^{\infty}$ sense, on $\Omega \Subset \mathbb{P}^{1}-\{[1: 0]\}$,
- $k_{\lambda} \rightarrow \operatorname{Id}$ as $\lambda \rightarrow \lambda_{0}$ uniformly on $\mathbb{P}^{1}$.

It follows that $\widetilde{h}_{1, \lambda}=\widetilde{h}_{\lambda}^{0} k_{\lambda} \rightarrow \widetilde{h}_{1, \lambda_{0}}$ uniformly as $\lambda \rightarrow \lambda_{0}$. Since $H_{1, \lambda}\left(z^{2}\right)=K_{1, \lambda}(z)$, we have that the map $(-1 / 4,1 / 4) \rightarrow C^{0}(\Omega, i u(2))$ given by $\lambda \mapsto H_{1, \lambda}$ is continuous.

Recall from Lemma 3.3, $\widetilde{K}_{1, \lambda}=\left(\widetilde{h}_{1, \lambda}\right)_{e}$ satisfies the local form of Hitchin equation

We have that on a bounded domain $\Omega \subset \mathbb{P}^{1}-\{[1: 0]\}, \widetilde{h}_{1, \lambda}$ is uniformly bounded in $L_{1}^{2}$ and $C^{0}$. Therefore, $\left\|\widetilde{K}_{1, \lambda}^{ \pm 1}\right\|_{L^{\infty}(\Omega)}$ and $\left\|\nabla \widetilde{K}_{1, \lambda}\right\|_{L^{2}(\Omega)}$ are uniformly bounded. By interior elliptic estimate of the Cauchy-Riemann operator, on $\Omega^{\prime} \Subset \Omega$ there is $C>0$ such that

By Sobolev embedding $L_{1}^{2} \subset L^{4}$, we have that $\left\|\nabla \widetilde{K}_{1, \lambda}\right\|_{L^{4}\left(\Omega^{\prime}\right)}$ is uniformly bounded. On $\Omega^{\prime \prime} \Subset \Omega$ by interior elliptic estimate of Laplacian and

& \left\|\widetilde{K}_{1, \lambda}\right\|_{L_{2}^{2}\left(\Omega^{\prime \prime}\right)} \leq C^{\prime}\left(\left\|\left(\partial_{\bar{z}} \widetilde{K}_{1, \lambda}\right) \widetilde{K}_{1, \lambda}^{-1}\left(\partial_{z} \widetilde{K}_{1, \lambda}\right)\right\|_{L^{2}\left(\Omega^{\prime}\right)}+\left\|\widetilde{K}_{1, \lambda}\right\|_{L^{2}\left(\Omega^{\prime \prime}\right)}\right) \\
& \leq C^{\prime \prime}\left(\left\|\widetilde{K}_{1, \lambda}\right\|_{L^{4}\left(\Omega^{\prime}\right)}^{2}+\left\|\widetilde{K}_{1, \lambda}\right\|_{L^{2}\left(\Omega^{\prime \prime}\right)}\right)
\end{aligned}
$$

uniformly bounded on $\lambda \in I_{0}$. Then arguments similar to the proof of Prop 3.4 take over, and the second statement follows from Sobolev embedding theorems. q.e.d.
3.4. Gluing. In this part, we construct a $t$-family of approximate solutions to the Hitchin equation for the familly of stable $\mathrm{SU}(1,2)$ Higgs bundle $(F, t \beta, t \gamma)$. We will use the notations in Def 2.10 as well as (11) and let $\boldsymbol{b}=\left(b_{p}\right)_{p \in D_{r}}$ be the corresponding Hecke parameter as in $\operatorname{Def}\left[2.13\right.$, Let $g_{X}$ be a metric on $X$ which restricts to Euclidean metric on $\left(\mathbb{D}_{j} ; \zeta_{j}\right)$ with Kähler form $\omega=\frac{i}{2} d \zeta_{j} \wedge d \bar{\zeta}_{j}$.
3.4.1. Gluing in disks. We will define a metric on $\left.F\right|_{\mathbb{D}_{j}}$ for each $j$ which interpolates smoothly between local model solutions and a decoupled solution. This will be done on disk $\mathbb{D}_{j}^{\prime}$ by pulling back the function $M_{\lambda}$ via a diffeomorphism

which restricts to identity on $\mathbb{D}_{j}^{\prime \prime}$. This metric will be singular at $\partial \mathbb{D}_{j}^{\prime}$, which is then compensated by a gauge transformation connecting it continuously to a decoupled solution on $\mathbb{D}_{j}-\mathbb{D}_{j}^{\prime}$.

Let $\lambda$ be an admissible weight with respect to $\underline{D}$ (see $\$ 3.2$. As in previous sections, we fix $I \Subset(-1 / 4,1 / 4)$ and constants will be independent of $\lambda \in I$ unless otherwise stated. We say an inequality holds for $t \gg 1$ if there is $t_{0} \geq 1$ such that it holds for all $t \geq t_{0}$. Recall we defined for matrices $|M|=\max _{i, j}\left|M_{i j}\right|$. We have $|A B| \leq n|A||B|$ for $A, B n \times n$.

Define on $\mathbb{D}_{j}$

\end{align*}

where $M_{\infty, \lambda}$ is as in Prop 3.8 with $\lambda=\lambda_{j}$,

Note that there are $C_{1}, C_{2}>0$ with $\left|\partial_{\rho} \chi\right|<C_{1} R^{-1}$ and $\left|\partial_{\rho}^{2} \chi\right|<C_{2} R^{-2}$. Let

\end{aligned}

Note that $\chi^{-1} \geq 1$. By Prop 3.8, on a compact set in $\mathbb{D}_{j}^{\prime}-\left\{p_{j}\right\}$, there are $C, c>0$, such that for $t \gg 1$,

& \left|\partial_{\zeta} \partial_{\bar{\zeta}}\left(\widetilde{H}_{t, \lambda}^{\mathrm{int}}(\zeta)-\widetilde{H}_{t, \lambda}^{\mathrm{ext}}(\zeta)\right)\right| \leq C e^{-c t^{2 / 3}} \tag{72}

Similarly on a compact set in $\mathbb{D}_{j}^{\prime}-\left\{p_{j}\right\}$ there are $C^{\prime}, c^{\prime}>0$ such that for $t \gg 1$,

By regularities of $M_{\infty, \lambda}$ and (73), $\widetilde{H}_{t, \lambda}^{\text {app }} \in C^{0}\left(\mathbb{D}_{j}\right) \cap C^{2}\left(\mathbb{D}_{j}^{\times}\right)$. (It will be singular at $p_{j}$ since the frame $\sigma$ is singular there.) We will need the following elementary estimate of matrix norms.

$\mathcal{H}_{t, \beta_{0}, \gamma_{0}}(H)=0$ gives the local form of the Hitchin equation with $\beta=\beta_{0} d \zeta, \gamma=\gamma_{0} d \zeta$.
Lemma 3.20. For $p_{j} \in D_{r}$, there are $C, c>0$ such that on $\mathbb{D}_{j}^{\prime}-\mathbb{D}_{j}^{\prime \prime}$ for $t \gg 1$,

where $\beta_{0}=\left(\begin{array}{ll}0 & \zeta_{j}^{-1}\end{array}\right) \gamma_{0}=\left(\begin{array}{ll}0 & \zeta_{j}^{2}\end{array}\right)^{T}$ are the local forms under $\sigma$ on $\mathbb{D}_{j}^{\times}$in (18).
Proof. Write $\mathcal{H}_{t}=\mathcal{H}_{t, \beta_{0}, \gamma_{0}}, H_{1}:=\widetilde{H}_{t, \lambda}^{\text {int }}, H_{2}:=\widetilde{H}_{t, \lambda}^{\text {ext }}$. Note that $H_{2}$ as well as its extension solves the local form of Hitchin equation, i.e. $\mathcal{H}_{t}\left(H_{2}\right)=0$. We have $C_{0}$, $c_{0}>0$ such that for $t \gg 1$,

On the other hand there is $C_{1}>0$ such that for $t \gg 1,\left|H_{2}\right|,\left|\partial_{\bar{\zeta}} H_{2}\right|=\left|\partial_{\zeta} H_{2}\right|$, $\left|\partial_{\bar{\zeta}} \partial_{\zeta} H_{2}\right| \leq C_{1} t^{2 a_{\lambda}^{\prime} / 3}$ where $a_{\lambda}^{\prime}=\max (-2 \lambda, \lambda) \geq 0$. By Lemma 3.19 for $t>1$, $\left|\partial_{\bar{\zeta}} H_{1}\right| \leq 2\left|\partial_{\bar{\zeta}} H_{2}\right|$ and $\left|H_{1}^{-1}\right| \leq 2\left|H_{2}^{-1}\right|$. Note also that

For $n \geq 0$ and $x \gg 1$ we have $x^{n} e^{-a x} \leq e^{-a^{\prime} x}$ for some $a^{\prime}<a$. By (72) there are $C_{2}$, $c_{2}>0$ such that for $t \gg 1$,

We have that there is $C_{3}>0$ such that for $t \gg 1$, $\left|\operatorname{det} H_{2}\right| \geq C_{3} t^{-4 \lambda / 3}$. By Lemma 3.19 there are $C_{4}, c_{4}>0$ such that on $\mathbb{D}_{j}^{\prime}-\mathbb{D}_{j}^{\prime \prime}$ with $t \gg 1$,

$$

where $\rho=\left|\zeta_{j}\right|$ and $\psi_{P}$ is the Painlevé function. Note that for any $\ell$ we have for $\zeta_{0} \in \partial \mathbb{D}_{j}^{\prime}, \lim _{\zeta \rightarrow \zeta_{0}} \partial^{\ell} \chi=0$ where $\left|\zeta_{0}\right|=2 R / 3, \partial=\partial_{\zeta}$ or $\partial_{\bar{\zeta}}$.

\end{array}\right)^{T}

Proof. For $p_{j} \in D_{\gamma}$, define $H^{\text {ext }, \gamma}=\operatorname{diag}\left(\rho^{-1 / 2}, 1\right)$ on $\mathbb{D}_{j}^{\prime \prime}-\mathbb{D}_{j}^{\prime}$ with $\rho=\left|\zeta_{j}\right|$ solving the local form of decoupled equation with $\beta=\beta_{0}^{\prime} d \zeta_{j}, \gamma=\gamma_{0}^{\prime} d \zeta_{j}$. By properties of $\psi=\psi_{P}$ in Lemma3.7there are $C_{3}, C_{4}>0$ such that for $t \gg 1$,

We will focus on the annulus $\Omega=\mathbb{D}_{j}^{\prime}-\mathbb{D}_{j}^{\prime \prime}$.

Let $D_{\lambda}=\operatorname{diag}\left(4 c_{\lambda}^{-1}, c_{\lambda}^{1 / 2} / 2\right)$. We have $M_{\infty, \lambda}(\rho)=\left(D_{\lambda} G_{\lambda}(\rho)\right)^{*}\left(D_{\lambda} G_{\lambda}(\rho)\right)$ with $G_{\lambda}$ as in (70). Let

whose entries are bounded on $\Omega$. Furthermore, note that $G_{\lambda}(\rho)^{-1} D_{\lambda}^{-1}$ is continuous with respect to $\lambda \in I$ in $C^{0}(\Omega)$. Therefore, the conclusion follows if $\zeta \mapsto F_{\lambda}(|\zeta|)$ is continuous on $C^{0}\left(\mathbb{R}^{2}-B(0, R / 3)\right)$.

For $\epsilon>0$, by Prop 3.8, there is $\rho_{1}=\rho_{1}(\epsilon) \geq \max \left(\rho_{0}, R / 3\right)$ such that for $\rho \geq \rho_{1}$ and all $\lambda, \lambda_{0} \in I,\left|F_{\lambda}(\rho)-F_{\lambda_{0}}(\rho)\right| \leq \epsilon$. On the other hand, by Cor 3.18, there is $\delta=\delta\left(\rho_{1}\right)>0$ such that for $\left|\lambda-\lambda_{0}\right|<\delta$ and $R / 3 \leq \rho \leq \rho_{1},\left|F_{\lambda}(\rho)-F_{\lambda_{0}}(\rho)\right| \leq \epsilon$. Note that $\delta$ depends only on $\epsilon>0$. Therefore we have that $F_{\lambda} \rightarrow F_{\lambda_{0}}$ in $C^{0}\left(\mathbb{R}^{2}-B(0, R / 3)\right)$.
3.4.2. Global construction. In this part, we will assemble a metric $h_{t, \lambda}^{\text {app }}$ on $F$ for a choice of weight $\lambda$ by gluing metric defined on $\left.F\right|_{D_{j}}$ in $\$ 3.4 .1$ and a decoupled solution on $X-\coprod_{j} \mathbb{D}_{j}$. It is no surprise that for continuity at $\partial \mathbb{D}_{j}$ we need to choose the decoupled solution, i.e. the weight $\lambda$ carefully. We will be using notations $\varphi_{\lambda}$, $h_{L, \lambda}^{0}, h_{L, \mathrm{HE}}$ and $g_{\ell j}$ in $\operatorname{Def} 2.11$

For a stable $\mathrm{SU}(1,2)$ Higgs bundle $(F, \beta, \gamma)$ let $\boldsymbol{b}$ be corresponding Hecke parameters as in $\operatorname{Def} 2.13$ For each $p_{j} \in D$ we fix once and for all a trivializing section $\left\{s_{0, j}^{(0)}\right\}$ of $L_{\mathbb{D}_{j}}$ with $\left(s_{0, j}^{(0)}(0)\right)^{\otimes 3}=b_{p_{j}}$ if $p_{j} \in D_{r}$. Let $\lambda$ be an admissible weight with respect to $\underline{D}$ (see $\$ 3.2$ ).

Definition 3.23. For $t \geq 1, \lambda$ is called $t$-compatible with $\boldsymbol{b}$ if there is a trivializing $s_{0, j}$ of $L_{\mathbb{D}_{j}}$ for each $p_{j} \in D_{r}$ such that

- (1) $s_{0, j}^{\otimes 3}(0)=b_{p_{j}}$,
- (2) there is a harmonic metric $h_{L}$ adapted to $(L, \lambda)$ such that on $\mathbb{D}_{j}$,

where $\rho=\left|\zeta_{j}\right|$ and $\sigma$ is induced by $s_{0, j}$ as in Theorem 2.4
Note that (81) is exactly $\widetilde{H}_{t, \lambda_{j}}^{\text {ext }}$ in (69). Furthermore, the condition (2) is equivalent to

- (3) given any choice of $\left\{s_{0, j}\right\}_{p_{j} \in D_{r}}$ with $\left.s_{0, j} \in L\right|_{\mathbb{D}_{j}}$ and $s_{0, j}(0)^{3}=b_{p_{j}}$, there is a harmonic metric $h_{L}$ adapted to $(L, \lambda)$,

Note that $(2) \Rightarrow(3)$ by a direct calculation. We next show $(3) \Rightarrow(2)$ and introduce some notations.

Let $\boldsymbol{\sigma}_{j}^{(0)}=\left\{\sigma_{1, j}^{(0)}, \sigma_{2, j}^{(0)}\right\}$ and $s_{j}^{(0)}=\left\{s_{1, j}^{(0)}, s_{2, j}^{(0)}\right\}$ for all $j\left(\right.$ resp. $\sigma_{j}^{\lambda}=\left\{\sigma_{1, j}^{\lambda}, \sigma_{2, j}^{\lambda}\right\}$ and $s_{j}^{\lambda}=\left\{s_{1, j}^{\lambda}, s_{2, j}^{\lambda}\right\}$ for $p_{j} \in D_{r}$ ) be the frames induced by the frame $\left\{s_{0, j}^{(0)}\right\}$ (resp. the frame $\left\{s_{0, j}^{\lambda}\right\}$ ) as in Theorem 2.4. Note that the frame $\sigma=\sigma_{j}^{\lambda}$ satisfies (81).

From the above, condition (3) is also equivalent to

- (4) There is $\eta \in \mathbb{R}$ such that for all $p_{j} \in D_{r}$, we have

For the example in (17), $L \cong O_{X}, \boldsymbol{b}=(1, \ldots, 1)$ and $h_{L, \mathrm{HE}}$ may be taken to be the trivial metric on $O_{X}$. Recall that $c_{\lambda=0}=4$. It follows that $\lambda=(0, \ldots, 0)$ is $t$-compatible with $\boldsymbol{b}$ for all $t$. Note also that $c_{0, t}$ in (86) is independent of $t$ in this case.

By Prop 2.6, $\mathbf{0}=$ $(0, \ldots, 0) \in \widetilde{\mathscr{P}}_{\underline{D}}$. Let $\pi: \mathbb{R}^{d_{r}} \rightarrow H, \mu \mapsto\left(\mu_{k}-d_{r}^{-1} \sum_{\ell} \mu_{\ell}\right)_{k=1}^{d_{r}}$. We have that $\pi\left(\boldsymbol{\mu}-\boldsymbol{\mu}^{\prime}\right)=0$ iff there is a constant $c$ such that $\mu_{k}=\mu_{k}^{\prime}+c$ for all $k$.

Set

$$

where $1 \leq i_{1}<\ldots<i_{d_{r}} \leq 4 g-4$ are the indices such that $p_{i_{j}} \in D_{r}$ and $\lambda$ is the tuple with $\lambda_{i_{k}}=\lambda_{c}+\mu_{k}$ and set $F_{t}=\pi \circ G_{t}$. We can rewrite (90) as

The conclusion follows then from Brouwer's fixed point theorem. q.e.d.

with $\iota: F \rightarrow V=L^{-2} K_{X} \oplus L K_{X}$ the Hecke modification corresponding to $(F, \beta, \gamma)$ as in $\$ 2$ and $\widetilde{H}_{t, \lambda}^{\text {app }}$ (resp. $H_{t}^{\text {int }, \beta}, H_{t}^{\text {int, } \gamma}$ ) is defined in (71) (resp. (80)) and

By a direct calculation for $\underline{D}$-admissible weight $\lambda$,

By the definitions of $H_{t}^{\mathrm{int}, \beta}$ and $H_{t}^{\mathrm{int}, \gamma}$ in (80) as well as the asymptotic properties $\psi_{P}$ in Prop 3.6, we have that $h_{t}^{\text {app }}$ is $C^{2}$ at $\partial \mathbb{D}_{j}$ for $p_{j} \in D_{\beta}$ and $D_{\gamma}$. On the other hand, we saw that $\widetilde{H}_{t, \lambda_{j}(t)}^{\text {app }}$ is in $C^{2}\left(\mathbb{D}_{j}^{\times}\right)$in $\S 3.4 .1$. By condition (2) in $\operatorname{Def} 3.23$, we see that $h_{t}^{\text {app }}$ on $\mathbb{D}_{j}-\mathbb{D}_{j}^{\prime}$ is identical to $h_{\infty, t}$. Therefore it is also $C^{2}$ at $\partial \mathbb{D}_{j}$ for $p_{j} \in D_{r}$. This proves the first statement in the following proposition.

Proposition 3.27. $h=h_{t}^{\text {app }}$ as above is a $C^{2}$ metric on $F$ over $X$. There are $C$, $c>0$ such that for $t \gg 1$,

Proof. By definition, $h$ solves the Hitchin equation everywhere except on $\mathbb{D}_{j}^{\prime}-\mathbb{D}_{j}^{\prime \prime}$. Note that $\xi, f_{\ell j}$ in (87) are independent of $t$ and $\lambda$. There is $C_{0}>0$ such that for all $\lambda \in \mathcal{I},\left|F_{\lambda, j}\right| \leq C_{0}$ on $\mathbb{D}_{j}$ for $p_{j} \in D_{r}$. Therefore, there is $C_{1}>0$ such that $\left|T_{\lambda, j}\right|$, $\left|T_{\lambda, j}^{-1}\right|<C_{1}$. We have $C_{2}>0$ such that for all $\lambda \in \mathcal{I}$,

\left|\mathcal{H}_{t, \beta_{0}, \gamma_{0}}\left(T_{\lambda, j}^{*} \widetilde{H}_{t, \lambda_{j}}^{\mathrm{app}} T_{\lambda, j}\right)\right|=\left|T_{\lambda, j}^{-1} \mathcal{H}_{t, \beta_{0}, \gamma_{0}}\left(\widetilde{H}_{t, \lambda_{j}}^{\mathrm{app}}\right) T_{\lambda, j}\right| \leq C_{2}\left|\mathcal{H}_{t, \beta_{0}, \gamma_{0}}\left(\widetilde{H}_{t, \lambda_{j}}^{\mathrm{app}}\right)\right|,
$$

with $\beta_{0}=\frac{1}{\sqrt{2}}\left(\begin{array}{ll}\zeta_{j} & 1\end{array}\right), \gamma_{0}=\frac{1}{\sqrt{2}}\left(\begin{array}{ll}1 & \zeta_{j}\end{array}\right)^{T}$. On the other hand since $T_{\lambda, j, t}^{\prime}, \mathcal{H}_{t, \beta_{0}^{\prime}, \gamma_{0}^{\prime}}$, and $\mathcal{H}_{t, \beta_{0}^{\prime \prime}, \gamma_{0}^{\prime \prime}}\left(\right.$ with $\beta_{0}^{\prime}=\left(\begin{array}{ll}1 & 0\end{array}\right), \beta_{0}^{\prime \prime}=\left(\begin{array}{ll}\zeta_{j} & 0\end{array}\right), \gamma_{0}^{\prime}=\left(\begin{array}{ll}\zeta_{j} & 0\end{array}\right)^{T}$, and $\left.\gamma_{0}^{\prime \prime}=\left(\begin{array}{ll}1 & 0\end{array}\right)^{T}\right)$ are all diagonal we have

\mathcal{H}_{t, \beta, \gamma}\left(\left(T_{\lambda, j, t}^{\prime}\right)^{*} \widetilde{H}_{t, \lambda_{j}}^{\mathrm{app}} T_{\lambda, j, t}^{\prime}\right)=\left(T_{\lambda, j, t}^{\prime}\right)^{-1} \mathcal{H}_{t, \beta, \gamma}\left(\widetilde{H}_{t, \lambda_{j}}^{\mathrm{app}}\right) T_{\lambda, j, t}^{\prime}=\mathcal{H}_{t, \beta, \gamma}\left(\widetilde{H}_{t, \lambda_{j}}^{\mathrm{app}}\right)
$$

for $\beta=\beta_{0}^{\prime}$ (resp. $\beta_{0}^{\prime \prime}$ ) and $\gamma=\gamma_{0}^{\prime}$ (resp. $\gamma_{0}^{\prime \prime}$ ). The conclusion follows by combining Lemmas 3.20, 3.21, and the fact that $h_{t_{0}}^{\text {app }}$ is independent of $t$.
q.e.d.

The following will be a consequence of (72) and Lemma4.19 in the next section.
Proposition 3.28. On $X_{0} \subset X-D$ compact, there are $C, c>0$ such that for all $t \gg 1$,

## 4. Proof of the main theorem

4.1. Linearization. In this part, we linearize the operator assocated to the Hitchin's equation at $h_{t, \lambda}^{\text {app }}$ and use contraction mapping principle to find a solution near it. We begin by defining various norms that will be used later. Let $g_{X}$ be the Kähler metric defined in $\S 3.4$. For a matrix-valued $L^{2}$ function $M$ and an open subset $\Omega \subset X$, we use two equivalent definitions of $L^{2}$-norms interchangably when no ambiguity arises:

When $\Omega=X$, we write $\|\ldots\|_{L^{2}}$. Let $F$ be the rank-two bundle in a stable $\operatorname{SU}(1,2)$ Higgs bundle $(F, \beta, \gamma)$. Fix on $X$ a finite atlas $\left(U_{\alpha} ; z_{\alpha}\right)_{\alpha \in \mathcal{A}}$ over which $F$ is trivialized by holomorphic frames $\boldsymbol{s}_{\alpha}$. Fix a smooth partition of unity $0 \leq \rho_{\alpha} \leq 1$, with supp $\rho_{\alpha} \subset U_{\alpha}$ and $\sum_{\alpha} \rho_{\alpha}=1$. The difference in metrics on $F$ will be measured by an automorphism of the form $g=e^{u}$ with $u \in \operatorname{End}(F)$. For $u$ with local forms $u_{s_{\alpha}} \in C^{k}\left(U_{\alpha}\right)$, define

\|u\|_{C^{k}}=\sum_{j=0}^{k} \max _{\alpha} \sup _{U_{\alpha}} \max _{i_{1}, \ldots, i_{k}=z_{\alpha}, \bar{z}_{\alpha}}\left|\partial_{i_{1}} \ldots \partial_{i_{k}} u_{s_{\alpha}}\right| \tag{98}
\end{equation*}
$$

and for $u_{s_{\alpha}} \in L^{2}\left(U_{\alpha}\right), h$ a metric on $F$, define

\|u\|_{L^{2}, h}=\left(\int_{X}|u|_{h}^{2} \operatorname{dvol}_{g_{X}}\right)^{1 / 2}=\left(\int_{X} \operatorname{tr}\left(u u^{* h}\right) \operatorname{dvol}_{g_{X}}\right)^{1 / 2} \tag{99}
\end{equation*}

We note that for a fixed $h$, the norm

is equivalent to $\|\cdot\|_{L^{2}, h}$. Define inductively two equivalent norms,

& \|u\|_{L_{k}^{2}}^{2}=\sum_{\alpha} \int_{U_{\alpha}} \rho_{\alpha} \sum_{\ell+m=k}\left|\partial_{\bar{z}_{\alpha}}^{\ell} \partial_{z_{\alpha}}^{m} u_{s_{\alpha}}\right|^{2} \operatorname{dvol}_{g_{X}}+\|u\|_{L_{k-1}^{2}}^{2} . \tag{101}
\end{align*}

Given a metric $h$ on $F$ and $u \in \operatorname{End}(F)$, define

\end{align*}

where $g=e^{u}$. Note that by Sobolev embedding, if $u \in L_{2}^{2}(\Omega)$, then $g=e^{u} \in L_{2}^{2}$ as well. We have

This has a Fréchet derivative at $u=0$ given by

where $\hat{u}=u+(\operatorname{tr} u) \mathrm{Id}$. Note that $\mathcal{H}_{t, h}(u)$ is Hermitian with respect to $h \cdot e^{u}$ instead of $h$. We instead consider $u \mapsto g^{1 / 2} \mathcal{H}_{t, h}(u) g^{-1 / 2}$ where $g^{1 / 2}=e^{u / 2}$.

Definition 4.1. For $h$ a $L_{2}^{2}$ metric on $F$ and $t \geq 1$, let

It follows from direct calculations that $L_{t}(u)$ is Fréchet derivative of

We have a more convenient form of $L_{t}$ which follows from the Kähler identities $\left[i \Lambda, \partial_{h}\right]=-(\bar{\partial})^{*},[i \Lambda, \bar{\partial}]=\left(\partial_{h}\right)^{*}$ and the Kodaira-Nakano identity $\Delta^{\prime \prime}-\Delta^{\prime}=$ $\left[i F_{\nabla_{h}}, \Lambda\right]$ (see e.g. [Dem86])

Proposition 4.2. We have

The following lemma is easy to verify by a direct calculation.
Lemma 4.4. We have for $u \in L_{2}^{2}(\operatorname{Herm}(F, h))$,

As a consequence of the above lemma ker $L_{t}=0$. To see this suppose $L_{t}^{(h)} u=0$, then $Q_{t}^{(h)}(u)=0$. As a result $\operatorname{tr} u=c$ a constant. As noted in the proof of Lemma3.1, we have on $X-D,(F, \beta, \gamma) \cong\left(V,\left(\begin{array}{ll}0 & q^{-1}\end{array}\right),\left(\begin{array}{ll}0 & q^{2}\end{array}\right)^{T}\right)$ under Hecke modification $\iota$ of Theorem 2.4. Since $\hat{u} \gamma, \beta \hat{u}=0$ we have $u=\operatorname{diag}(2 c,-c)$. By stability of $(F, \beta, \gamma)$ from Prop 2.6, $d_{r}>0$. A calculation using local forms from e.g. (15), 16) over $\mathbb{D}_{j}$ with $p_{j} \in D_{r}$ shows that $c=0$. Note that this last step is crucial. In fact when restricted to $X-D$, the operator $L_{t}$ does have a nontrivial kernel spanned by $\operatorname{diag}(2 c,-c)$.

Let $h=h_{t}^{\text {app }}$ be the approximate solution as in $\operatorname{Def}$ 3.26. In the following we will denote $L_{t}=L_{t}^{(h)}$ and omit the subscripts to write $\langle\langle u, v\rangle\rangle,((u, v))$.

The proof of the main theorem will proceed as follows. First, we prove a $t$ dependent bound for $L_{t}$ from below for $t \gg 1$. In particular, we show there are $C, p>0$ such that $\left\|L_{t} u\right\|_{L^{2}} \geq C t^{p}\|u\|_{L_{2}^{2}}$. Write $h=h_{t}^{\text {app }}$ and $g=e^{u}$ and define the remainder term $R_{t}$ by

2 i \Lambda g^{1 / 2} \mathcal{H}_{t, h}(u) g^{-1 / 2}=2 i \Lambda g^{1 / 2} \mathcal{H}_{t, h}(0) g^{-1 / 2}+L_{t}(u)+R_{t}(u) \tag{106}
\end{equation*}
$$

A fixed point of

$$
u \longmapsto-L_{t}^{-1}\left(2 i \Lambda g^{1 / 2} \mathcal{H}_{t, h}(0) g^{-1 / 2}+R_{t}(u)\right)
$$

is a solution of the Hitchin equation. We prove relevant upper bounds for $R_{t}$ and use the contraction mapping principle to show convergence of the corresponding iteration sequence to a fixed point.

It is worth remarking that even though the outline the proof resembles the work in [MSWW16], there are some significant differences. For instance, the global estimates for the analogous operator $L_{t}$ in MSWW16] are by a combination of local estimates and the domain monotonicity principle. As we saw above this no longer works for our context since on $X-\coprod_{j} \mathbb{D}_{j}$ the operator $L_{t}$ has a nontrivial kernel. Furthermore in contrast to Prop 5.2 (i) and Lemma 6.3 of [MSWW16], there is no $t$-independent $L^{2} \rightarrow L^{2}$ lower bound of $L_{t}$. We are able to give a $t$-dependent lower bound in Prop 4.9 which $\rightarrow 0$ as $t \rightarrow \infty$. The analysis is further complicated by $t$-dependency of the weight $\lambda(t)$ in $h_{t}^{\text {app }}$.
4.2. $L^{2}$ lower bound for $L_{t}$. We will need the following technical lemma. Let $\mathbb{D}$ be the unit disk and define on $L_{1}^{2}(\mathbb{D})$,

where $F_{t}(\zeta)=t^{2} F(t \zeta)$, and $F \in L^{\infty}\left(\mathbb{R}^{2}\right)$ is a non-negative function such that there are $A>0$ and $0<\delta<1$ such that $F \geq A>0$ on $B(0, \delta)$. An ineqaulity is said to hold for $t \gg 1$ if there is $t_{0} \geq 1$ such that it holds for $t \geq t_{0}$.

Lemma 4.5. There are $C>0$ and for all $u \in L_{1}^{2}(\mathbb{D})$ and $t \gg 1$, we have

We have $F_{t} \geq G_{t}$, therefore $Q_{t}^{(0)}(u) \geq P_{t}(u)$, and it suffices to bound $P_{t}$ from below. By Rayleigh's theorem,

\end{equation*}

is the first eigenvalue of the self-adjoint operator $u \longmapsto-\Delta u+G_{t} u$ on $L^{2}(\mathbb{D})$ with the Neumann boundary condition $\partial_{r} u=0$ on $\partial \mathbb{D}$.

For $t>0$, we have $\lambda_{1}(t)>0$. To see this, suppose there is a sequence $u_{n} \in L_{1}^{2}(\mathbb{D})$ with $\left\|u_{n}\right\|_{L^{2}(\mathbb{D})}=1$ and $P_{t}\left(u_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$. It follows that $d u_{n} \rightarrow 0$ in $L^{2}(\mathbb{D})$ as $n \rightarrow \infty$. Thus $u_{n}$ is bounded in $L_{1}^{2}(\mathbb{D})$-norm. Denote again by $u_{n}$ a subsequence such that $u_{n} \rightarrow u_{\infty}$ weakly in $L_{1}^{2}(\mathbb{D})$ and strongly in $L^{2}(\mathbb{D})$. We have $\left\|u_{\infty}\right\|_{L^{2}(\mathbb{D})}=1$ and

therefore $d u_{\infty}=0$, and $u_{\infty}$ is a nonzero constant. We would have $0<P_{t}\left(u_{\infty}\right) \leq$ $\lim \inf _{n \rightarrow \infty} P_{t}\left(u_{n}\right)=0$ which leads to contradiction.

Next note that $\lambda_{1}(t) \rightarrow 0$ as $t \rightarrow \infty$. This is a consequence of the existence of an $L_{1}^{2}(\mathbb{D})$ function which is unbounded at the origin, e.g. $\zeta \mapsto \log \log (2+1 /|\zeta|)$. In fact there is $C>0$ such that

By the elliptic estimate for $-\Delta+G_{t}$ (see e.g. [GT83, Theorem 9.11]) and the Sobolev inequalities, we have that for any $\Omega \in \mathbb{D}$, there are $C$ and $C^{\prime}>0$ such that

We have that $u \in L_{2}^{4}(\Omega) \subset C^{1}(\Omega)$ by Sobolev embedding theorem (see [DK90, (A.9) Appendix IV]). By repeated application of the interior elliptic regularity estimates in $D-\partial B(0, \delta)$ where $G_{t}$ is smooth, we have that $u \in C^{1}(\mathbb{D}) \cap C^{\infty}(\mathbb{D}-\partial B(0, \delta))$.

For some $t \geq 1$, suppose $u \in C^{1}(\mathbb{D}) \cap C^{\infty}(\mathbb{D}-\partial B(0, \delta))$ is a real-valued eigenfunction of the first eigenvalue for the self-adjoint operator $-\Delta+G_{t}$ with Neumann boundary condition. By Courant's nodal domain theorem (see [CH53, §VI.6]), $u$ has no node in $\mathbb{D}$, i.e., we may assume that $u>0$. It is easy to see that any function orthogonal to $u$ in $L^{2}(\mathbb{D})$ cannot have a definite sign. Therefore the eigenspace of $\lambda_{1}$ is one-dimensional. As a consequence, it follows from the rotational symmetry of $G_{t}$ that $u$ is a radial function. Let $v$ be given by

where $J_{n}$ and $Y_{n}$ are Bessel functions of the first and second kind, and $I_{n}$ is the modified Bessel function of the first kind. We refer to [AS72, Chapter 9] for their definition and properties. Note that $I_{0}$ and $K_{0}$ form a basis of the space of solutions on $\left(0, t^{-1}\right.$ ], and $K_{0}$ is unbounded at the origin. The continuity of $v, v^{\prime}$ at $\rho=1 / t$, as well as the boundary condition $v^{\prime}(1)=0$, implies

The coefficient matrix for $c_{0}, c_{1}, c_{2}$ is singular iff $\lambda$ is an eigenvalue. Thus the eigenvalues of (109) are precisely the zeros of

& =\sqrt{\lambda} I_{0}\left(\sqrt{A-\lambda t^{-2}}\right) g_{t}(\lambda)+t \sqrt{A-\lambda t^{-2}} I_{1}\left(\sqrt{A-\lambda t^{-2}}\right) f_{t}(\lambda)
\end{aligned}

Using asymptotics of the relevant Bessel functions (see AS72, Chapter 9, (9.1.7), (9.1.8) and (9.1.9)])

where $f_{1}(x) \sim f_{2}(x)$ if $f_{1} / f_{2} \rightarrow 1$ as $x \rightarrow 0$. We have that for $\lambda>0$ small enough and $t \geq 1$,

-J_{0}\left(\sqrt{\lambda} t^{-1}\right) Y_{1}(\sqrt{\lambda}) \geq \frac{1}{2} \cdot 1 \cdot\left(\frac{2}{\pi} \frac{1}{\sqrt{\lambda}}\right)=\frac{1}{\pi \sqrt{\lambda}} \\
J_{1}(\sqrt{\lambda}) Y_{1}\left(\sqrt{\lambda} t^{-1}\right) \geq-2\left(\frac{\sqrt{\lambda}}{2}\right)\left(\frac{2}{\pi} \frac{1}{\sqrt{\lambda} t^{-1}}\right)=-\frac{2 t}{\pi} \\

It is also easy to see that for $\lambda>0$ small enough, and $t \geq 1$ we have some $C, C^{\prime}>0$ with

Recall that for $A$ positive-definite Hermitian, we denote by $A^{1 / 2}$ the unique positivedefinite Hermitian square root. We have:

Proposition 4.9. There is $C>0$ such that for $u \in L_{1}^{2}, t \gg 1$

Proof. Recall the $t$-family of tuple of weights $\lambda=\lambda(t) \in I$ in Def 3.26 defined for $t$ large enough with $\lambda \in I$ and $\lambda_{j}(t) \in I_{j}$. We say a constant in an inequality is uniform in $\lambda$ if the inequality holds for all $\lambda \in \cup_{j} I_{j}$.

We first focus on the terms of $Q_{t}(u)$ related to the Higgs field. Set

Consider first $\mathbb{D}_{j}^{\prime}$ for $p_{j} \in D_{r}$. We construct an $h_{t}^{\text {app }}$-unitary frame and decompose $u$ with respect to it. We then bound $Q_{t, \mathbb{D}_{j}^{\prime}}^{\text {Higgs }}(u)$ from below by terms of the form $\left\|f_{\ell} u_{\ell}\right\|_{L^{2}}^{2}$ with $u_{\ell}$ components in the decomposition. For $t \gg 1$, the lower bound for $f_{\ell}$ will be $t$-independent for all but one term. Similarly, $t$-independent lower bounds will be obtained for $Q_{t, \mathbb{D}_{j}^{\prime}}^{\mathrm{Higgs}}(u)$ with $p_{j} \in D_{\beta}, D_{\gamma}$ as well as $Q_{t, X-\amalg_{j} \mathbb{D}_{j}^{\prime}}^{\mathrm{Higgs}}(u)$ for all but one
term. The lower bounds for the remaining terms and the $L^{2}$-norm of its derivative will follow from Lemma 4.5

Let $p_{j} \in D_{r}$ and set $\zeta=\zeta_{j}, \lambda=\lambda_{j}$. Let $N_{\lambda}$ (resp. $N_{\infty, \lambda}$ ) be the unique positive definite Hermitian matrix satisfying

Recall that we have $g_{X}=d \zeta_{j} \cdot d \bar{\zeta}_{j}$ on $\mathbb{D}_{j}$, therefore $|d \zeta|^{2}=2$. Thus $\|\beta \hat{u}\|_{h_{t}^{\text {app }}}^{2}=$ $2\left\|\beta_{0} \hat{u}\right\|_{h_{t}^{\text {app }}}^{2}$ and $\|\hat{u} \gamma\|_{h_{t}^{\text {app }}}^{2}=2\left\|\hat{u} \gamma_{0}\right\|_{h_{t}^{\text {app }}}^{2}$. By (80) and (95), the frame $\boldsymbol{e}_{j, t}=\left\{e_{1, j, t}, e_{2, j, t}\right\}$ is $h_{t}^{\text {app }}$-unitary and $\left(\beta_{0}\right)_{\boldsymbol{e}_{t}}=\left(\begin{array}{ll}0 & a^{2}\end{array}\right),\left(\gamma_{0}\right)_{\boldsymbol{e}_{t}}=\left(\begin{array}{ll}0 & a^{-2} \zeta\end{array}\right)^{T}$. On this region, $h_{t}^{\text {app }}=\iota^{*}\left(h_{L}^{-2} h_{K}\right) \oplus\left(h_{L} h_{K}\right)$ where $h_{L}=h_{L, \lambda(t), t}$ and $h_{K}$ both have flat Chern connections. It is easy to see that there is $\sigma \in O_{W_{\alpha}}$ such that $|\sigma|_{h_{L}} \equiv 1$. Let $e_{1}=\left(\sigma^{-2} d w_{\alpha}, 0\right), e_{2}=\left(0, \sigma d w_{\alpha}\right)$. The frame $\boldsymbol{e}=\left\{e_{1}, e_{2}\right\}$ is both holomorphic and $h_{t}^{\text {app }}$-unitary. We write $u_{e}=u_{0} \sigma_{0}+u_{1} \sigma_{1}+u_{2} \sigma_{2}+u_{3} \sigma_{3}$ as in (116). From a direct calculation,

such that over $X-\mathbb{D}_{j}^{\prime}, L_{1}$ (resp. $L_{2}$ ) coincides with $L^{-2} K$ (resp. $L K$ ) summand of $V$ under the identification $\iota$ as in Theorem 2.4, Let $\sigma_{0}=\operatorname{diag}(2,-1)$ corresponding to (130). There is an induced decomposition

For $u \in \operatorname{Herm}\left(F, h_{t}^{\text {app }}\right)$, we write

with $\operatorname{tr} v=0$ which is compatible with (116) and similar decompositions on each region. By the estimates in (126), (127), (128), and (129), there is $C_{7}>0$ such that for all $t \gg 1$,

where $y_{j, t}$ is defined below (126). Recall from Prop 2.6 that the stability of $(F, \beta, \gamma)$ implies that $D_{r}>0$. Fix an index $j_{0}$ with $p_{j_{0}} \in D_{r}$. For $t \gg 1$ there is $C_{8}>0$ such that

By the uniformization theorem, $X=\Gamma \backslash \mathbb{H}$ for $\Gamma$ a Fuchsian group, denote the quotient map by $p: \mathbb{H} \rightarrow X$. Furthermore, there exists a fundamental polygon $\Pi \in \mathbb{H}$ for the action of $\Gamma$ on $\mathbb{H}$ with finitely many edges and positive angles at vertices (see e.g. [Sti92]). We can arrange so that a lift of $p_{j_{0}}$ is in the interior of $\Pi$. As a result there are finitely many $g \in \Gamma$ such that $g(\Pi)$ is adjacent to $\Pi$, denote the union of these with $\Pi$ by $\widetilde{\Pi}$. Consider $\Omega$ with $\partial \Omega$ smooth and $\Pi \Subset \Omega \Subset \widetilde{\Pi}$. By the Riemann mapping theorem, there is biholomorphism $r: \mathbb{D} \xrightarrow{\sim} \Omega$ mapping the origin to the unique point corresponding to $p_{j_{0}}$ under quotient in $\Pi$. By a result of Painlevé (see [Bell90]), $r$ extends smoothly to $\partial \mathbb{D}$. The above identification corresponds to a constant curvature metric $g_{X}^{\prime}$ on $X$. Note that both $g_{X}$ and $g_{X}^{\prime}$ are independent of $t$, we will use them interchangeably to define norms. We use $\gtrsim$ (resp. $\sim$ ) to denote (in)equalities up to constants independent of $t$ and $\lambda$ omitted. Let $\widetilde{F}_{t}:=(p \circ r)^{*} y_{t}$ and let

There is a non-negative function $F \in L^{\infty}(\Omega)$ such that $\widetilde{F}_{t} \geq F_{t}$ with $F_{t}(\zeta)=t^{2} F(t \zeta)$. By Lemma 4.5 for $t \gg 1$

& \gtrsim\left\|d\left(p^{*} f\right)\right\|_{L^{2}(\Omega)}^{2}+\left(\left(p^{*} y_{t} f\right), p^{*} f\right)_{L^{2}(\Omega)} \gtrsim Q_{t}^{(0)}(\phi) \\
& \gtrsim(\log t)^{-1}\|\phi\|_{L^{2}(\mathbb{D})}^{2} \gtrsim(\log t)^{-1}\left\|p^{*} f\right\|_{L^{2}(\Omega)}^{2} \\
& \gtrsim(\log t)^{-1}\|f\|_{L^{2}}^{2}
\end{aligned}
$$

where $\phi=(p \circ r)^{*} f$. Let $\zeta$ (resp. $z$ ) be a coordinate on $\mathbb{H}$ as the upper half-plane (resp. $\mathbb{D}$ as the unit disk) we have also used above the fact that for the map $r^{-1}: \zeta \mapsto z$, $\left|\partial_{\zeta} z\right|^{2}$ is bounded above and below on $\overline{\mathbb{D}}$.

Combining (131) we have for $t \gg 1$,

Note that the pointwise norm associated given by $\langle\langle\cdot, \cdot\rangle\rangle$ and $\langle\cdot, \cdot\rangle$ are mutually bounded. We have the following.

Corollary 4.10. There is $C>0$ such that for $u \in L_{2}^{2}\left(\operatorname{Herm}\left(F, h_{t}^{a p p}\right)\right)$ and $t \gg 1$

4.3. $L_{2}^{2}$ lower bound for $L_{t}$. Building on the inequality in Cor 4.10, we will prove the following $t$-dependent elliptic estimate for $L_{t}$.

Proposition 4.11. Fix $t_{0} \geq 1$. There are $C>0$ such that for $u \in L_{2}^{2}\left(\operatorname{Herm}\left(F, h_{t}^{a p p}\right)\right)$ and $t \gg 1$,

The proof combines elliptic estimate of $\Delta_{h_{t_{0}}^{\text {app }}}$ and bounds on $\left\|\Delta_{h_{t}^{\text {app }}}-\Delta_{h_{t_{0}}^{\text {app }}}\right\|$ and $\|\{\psi, \hat{u}\}\|$. Note that in contrast to Cor 4.10, the norms in the above inequality are given by fixed metric $h_{t_{0}}^{\text {app }}$. We begin by proving a comparison result (Lemma4.15) between the norms induced by $\|\cdot\|_{h_{0}^{\text {app }}}$ and $\|\cdot\|_{h_{t}^{\text {app }}}$. For an $r \times r$ matrix $M$ and positive-definite Hermitian matrix $H$ of the same dimension, recall the norm $|M|_{H}^{2}=\operatorname{tr}\left(M H^{-1} M^{*} H\right)$ defined in (6). We will need the following three comparison lemmas of matrix norms associated to different Hermitian matrices.

Lemma 4.12. Let $H>0$ be a $2 \times 2$ Hermitian matrix with eigenvalues $0<\alpha_{1} \leq \alpha_{2}$, then for $L>0$ the following are equivalent

- For any $A, L^{-1}|A|_{I}^{2} \leq|A|_{H}^{2} \leq L|A|_{I}^{2}$
- $\alpha_{2} / \alpha_{1} \leq L$

Lemma 4.13. There is $\epsilon_{0}>0$ and $C \geq 1$ such that for $2 \times 2$ Hermitian matrices $H_{0}, H_{1}>0$ with

There are $\epsilon_{0}, C_{0}>0$ such that for any $2 \times 2$ matrix $X$ with $|X-I|<\epsilon_{0}$ we have $\left|X^{-1}-I\right|<C_{0} \epsilon_{0}$. Suppose $|M-I|<\epsilon_{0}$ and without loss of generality that $|B|_{I}^{2}=1$. There is $C_{1}>0$ such that

Thus there is $C_{2}>0$ such that $|B|_{M}^{2} \leq C_{2}$.
q.e.d.

Lemma 4.14. Let $H>0$ be a $2 \times 2$ Hermitian matrix and $0<\alpha_{1} \leq \alpha_{2}$ its two eigenvalues. There is $C \geq 1$ such that for all $A$ and $T, 2 \times 2$ matrices with $T$ non-singular, we have

Proof. We have with $B=H^{1 / 2} A H^{-1 / 2}$,

Note that $\left|H^{1 / 2}\right|_{I}^{2}=\operatorname{tr} H=\alpha_{1}+\alpha_{2} \leq 2 \alpha_{2}$ and $\left|H^{-1 / 2}\right|_{I}^{2}=\operatorname{tr} H^{-1}=\alpha_{1}^{-1}+\alpha_{2}^{-1} \leq 2 \alpha_{1}^{-1}$. The conclusion follows from similar argument as in Lemma4.13
q.e.d.

Lemma 4.15. There is $C \geq 1$ such that for $u \in \operatorname{End}(F)$ and $t \gg 1$,

Proof. We consider four types of regions covering $X$ together with local frames of $F$ and prove the claim by studying local form of $h_{t}^{\text {app. }}$

- (1) for $p_{j} \in D_{r}, \widetilde{\mathbb{D}}_{j, t}=\left\{\rho<\rho_{0} t^{-2 / 3}\right\}$ with $\rho_{0}$ as in Prop 3.8,
- (2) for $p_{j} \in D_{r}, \mathbb{D}_{j}^{\prime}-\widetilde{\mathbb{D}}_{j, t}$,
- (3) $\mathbb{D}_{j}^{\prime}$ for $p_{j} \in D_{\beta}$ or $D_{\gamma}$, and
- (4) $X-\coprod_{j} \mathbb{D}_{j}^{\prime}$.

On (1), (2), (3), we use holomorphic frame $s_{j}^{(0)}$ defined in $\$ 3.4 .2$ We cover (4) by a finite atlas over which $L$ and $K$ are trivialized and take a unitary frame with respect to the metric $\iota^{*}\left(h_{L}^{-2} h_{K} \oplus h_{L} h_{K}\right)$ where $h_{L}=h_{L, \lambda\left(t_{0}\right)}^{0}$. By Lemma4.12, it suffices bound the ratio $\alpha_{2}(H) / \alpha_{1}(H)$ where $0<\alpha_{1}(H) \leq \alpha_{2}(H)$ are the eigenvalues of $H$ the local form of $h_{t}^{\text {app }}$.

Region (1): Note that for $t \gg 1, \rho_{0} t^{-2 / 3}<R / 3$ and $\widetilde{\mathbb{D}}_{j, t} \subset \mathbb{D}_{j}^{\prime \prime}$. From (36) and Def 3.5) we have

The matrix-valued function $\left(h_{t}^{\text {app }}\right)_{s_{j}^{(t)}}$ on $\widetilde{\mathbb{D}}_{j, t}$ (where the frame $s_{j}^{\lambda(t)}$ is defined in Def 3.24) is therefore given by $H_{t, \lambda_{j}(t)}\left(t^{-2 / 3} \zeta^{\prime}\right)=\left(\Gamma_{t}^{*}\right)^{-1} H_{1, \lambda_{j}(t)}\left(\zeta^{\prime}\right) \Gamma_{t}^{-1}$,
where $\zeta^{\prime}=t^{2 / 3} \zeta \in K=\overline{B\left(0, \rho_{0}\right)}$ is a fixed compact set. The eigenvalues are roots $0<\alpha_{1, \lambda} \leq \alpha_{2, \lambda}$ of

Region (2): let $H_{0}=\widetilde{H}_{t, \lambda_{j}(t)}^{\mathrm{int}}$ and $H_{1}=\widetilde{H}_{t, \lambda_{j}(t)}^{\text {ext }}$. We have by (72) there are $C_{2}, c_{2}>0$ such that $\left|H_{0}-H_{1}\right| \leq C_{2} e^{-c_{2} t^{2 / 3}}$. By the definition of $\widetilde{H}_{t, \lambda}^{\text {ext }}$ in (69) and Prop 3.14, there is $C_{3}>0$ such that $\left|H_{1}\right| \leq C_{3} t^{4 a_{\lambda}^{\prime} / 3}$ where $a_{\lambda}^{\prime}=\max (-2 \lambda, \lambda)$ and $\lambda=\lambda_{j}(t)$. For $t \gg 1$, we have $\left|H_{0}\right| \leq 2 C_{3} t^{4 a_{\lambda}^{\prime} / 3}$. Therefore if $\epsilon_{0}$ is as in Lemma4.13 for $t \gg 1$,

and there is $C_{4} \geq 1$ such that $C_{4}^{-1}|A|_{H_{1}}^{2} \leq|A|_{H_{0}}^{2} \leq C_{4}|A|_{H_{1}}^{2}$. By Prop 3.14, there is $C_{5}>0$ such that $\alpha_{2}\left(H_{1}\right) / \alpha_{1}\left(H_{1}\right) \leq C_{5} t^{4\left|\lambda_{j}(t)\right|} \leq C_{5} t$. Combining the above, by Lemma 4.12, there is $C_{6}>1$ such that on $\mathbb{D}_{j}^{\prime}-\widetilde{\mathbb{D}}_{j, t}$ for $t \gg 1, C_{6}^{-1} t^{-1}|A|_{I}^{2} \leq|A|_{H_{0}}^{2} \leq C_{6} t|A|_{I}^{2}$ for all $A$.

By (68) and Def 3.26, 3.24, we have

\zeta_{j} & 1
\end{array}\right)
$$

We have $C_{7}>0$ such that on $\mathbb{D}_{j}^{\prime}-\widetilde{\mathbb{D}}_{j, t},|S| \leq C_{7}$, and $\left|S^{-1}\right|<C_{7} t^{2 / 3}$. Therefore by Lemma 4.14, there is $C_{8}>1$ such that

C_{8}^{-1} t^{-10 / 3}|A|_{H_{0}}^{2} \leq|A|_{S^{*} H_{0} S}^{2}=|A|_{\left(h_{t}^{\mathrm{app}}\right)_{s_{j}^{(0)}}^{2}} \leq C_{8} t^{10 / 3}|A|_{H_{0}}^{2}
$$

Combining results on regions (1) and (2): on $\mathbb{D}_{j}^{\prime}$, there is $C_{9}>1$ such that for all A,

Note that by $\operatorname{Def} 3.26\left(h_{t}^{\mathrm{app}}\right)_{s_{j}^{(0)}}=\left(S^{-1} T_{\lambda, j} S\right)^{*}\left(h_{t}^{\mathrm{app}}\right)_{s_{j}^{\lambda}}\left(S^{-1} T_{\lambda, j} S\right)$. By direct calculation, we have

where $F=F_{\lambda(t), j}$ defined in (88) is a linear combination of fixed holomorphic functions $\xi_{j}$ and $f_{\ell j}$ with coefficients linear in $\lambda \in \mathcal{I}$. In particular, $\xi_{j}(0)=f_{\ell j}(0)=0$. Thus there is $C_{10}>0$ such that for $\lambda \in \mathcal{I}$,

Region (4): from Def 3.23, 2.11 we have $h_{L, \lambda, t}=h_{L, \lambda}^{0} e^{\eta_{\lambda, t}}$ and $h_{L, \lambda}^{0}=h_{L, \mathrm{HE}} e^{\varphi_{\lambda}}$ where $\varphi_{\lambda}$ is a linear combination of fixed functions $G_{j}$ bounded on $X-\coprod_{j} \mathbb{D}_{j}^{\prime}$ with coefficients linear in $\lambda$. By Prop 3.14, there are $C_{15}$ and $C_{15}^{\prime}>0$ such that for all $t \gg 1$,

Therefore there is $C_{16}>1$ such that on $X-\coprod_{j} \mathbb{D}_{j}^{\prime}$ with $t \gg 1$,

Proof. Let $H$ (resp. $U$ ) be the local form of a metric $h$ (resp. an endomorphism $u$ ) with respect to a holomorphic frame over a chart $(V ; z)$. Up to a positive scalar independent of $h$, the local form of $\Delta_{h} u=i \Lambda_{\omega}\left(\bar{\partial} \partial_{h} u-\partial_{h} \bar{\partial} u\right)$ is

Since the first term $-4 \partial_{\bar{z}} \partial_{z} U$ is independent of $H$, it suffices to bound the differences in $H^{-1} \partial_{\zeta} H, \partial_{\bar{\zeta}}\left(H^{-1} \partial_{\zeta} H\right)$ for $H$ given by $h_{t}^{\text {app }}$ (resp. $h_{t_{0}}^{\text {app }}$ ) over the four types of regions listed at the beginning of the proof of Lemma 4.15. Note that the second term is proportional to the curvature $F_{\nabla_{h}}$, which vanishes for both $h_{t}^{\text {app }}$ and $h_{t_{0}}^{\text {app }}$ outside $\mathbb{D}_{j}^{\prime}$.

Note that $\partial_{\bar{\zeta}} T_{\ell}=0$, we have by a direct calculation,

where $\Gamma_{t}=\operatorname{diag}\left(t^{1 / 3}, t^{-1 / 3}\right)$. We have $\left|\Gamma_{t} A \Gamma_{t}^{-1}\right| \lesssim t^{2 / 3}|A|$. On $\widetilde{\mathbb{D}}_{j, t}$, we have $|\zeta| \leq$ $\rho_{0} t^{-2 / 3}$, thus $t^{2 / 3} \zeta \in \overline{B\left(0, \rho_{0}\right)}$ a compact set independent of $t$. By Cor 3.18, there are $C_{0}, C_{0}^{\prime}, C_{1}, C_{1}^{\prime}>0$ such that for $t \gg 1$,

Let $H_{0}=\widetilde{H}_{t_{0}, \lambda_{j}\left(t_{0}\right)}^{\text {int }}, H_{1}=\widetilde{H}_{t, \lambda_{j}(t)}^{\text {int }}, T_{0}=T_{\lambda\left(t_{0}\right), j} S, T_{1}=T_{\lambda(t), j} S$, and let $H_{\ell}^{\prime}=T_{\ell}^{*} H_{\ell} T_{\ell}$. The calculations in (140) still apply. Let $H_{\infty, 1}=\widetilde{H}_{t, \lambda_{j}(t)}^{\mathrm{ext}}$. Note that $H_{0}^{\prime}$ is independent of $t$. By (140), there are $C_{10}, C_{10}^{\prime}>0$ such that on $\mathbb{D}_{j}^{\prime}-\widetilde{\mathbb{D}}_{j, t}$,

Let $H_{\ell}^{\prime}=T_{\ell}^{*} H_{\ell} T_{\ell}$ with $\ell=0,1$. We have $H_{0}^{\prime}=\left(h_{t_{0}}^{\text {app }}\right)_{s_{j}^{(0)}}$ and $H_{1}^{\prime}=\left(h_{t}^{\text {app }}\right)_{s_{j}^{(0)}}$. Let $s_{\alpha}$ be a holomorphic frame of $\left.V\right|_{U_{\alpha}}$ induced by that of $\left.L\right|_{U_{\alpha}}$ and $d z_{\alpha}$ and identify $F$ with $V$ via $\iota$ over each $U_{\alpha}$. Let $H_{0}$ (resp. $H_{1}$ ) be the local form of $h_{t_{0}}^{\text {app }}$ (resp. $h_{t}^{\text {app }}$ ) with respect to this frame over $U_{\alpha}$. From $\operatorname{Def} 2.11$ and $\$ 3.4 .2$ we have $h_{L, \lambda(t), t}=$ $h_{L, \lambda(t)}^{0} e^{\eta_{\lambda(l), t}}=h_{L, \mathrm{HE}} e^{\varphi_{\lambda(t)}+\eta_{\lambda(t), t}}$. where $z=z_{\alpha}$. Suppose for $0 \leq \ell \leq k+1$ there are $C_{\ell}^{\prime}, c_{\ell}^{\prime}>0$, and $t_{1, \ell+1} \geq t_{1,0}$ such that for all $\alpha \in \mathscr{A}, t \geq t_{1, \ell+1}, H_{t}=H_{t}^{(\alpha)}$ and $H_{t, \infty}=H_{t, \infty}^{(\alpha)}$ satisfies

$$
\begin{equation*}
\left\|H_{t}-H_{t, \infty}\right\|_{L_{\ell}^{2}\left(U_{\alpha, \ell}\right)} \leq C_{\ell}^{\prime} e^{-c_{t}^{\prime} t^{2 / 3}} \tag{164}
\end{equation*}
$$

Note the case $k=0$ follows from (163). By the local form of the Hitchin equation, we have with $z=z_{\alpha}$,

$$
\begin{aligned}
& \partial_{\bar{z}} \partial_{z}\left(H_{t}-H_{t, \infty}\right)=\partial_{\bar{z}}\left(H_{t}-H_{t, \infty}\right) H_{t}^{-1}\left(\partial_{z} H_{t}\right)+\left(\partial_{\bar{z}} H_{t, \infty}\right)\left(H_{t}^{-1}-H_{t, \infty}^{-1}\right)\left(\partial_{z} H_{t}\right) \\
& +\left(\partial_{\bar{z}} H_{t, \infty}\right) H_{t, \infty}^{-1} \partial_{z}\left(H_{t}-H_{t, \infty}\right) \\
& +t^{2}\left(H_{t}-H_{t, \infty}\right)\left[\varphi, H_{t}^{-1} \varphi^{*} H_{t}\right]+t^{2} H_{t, \infty}\left[\varphi,\left(H_{t}^{-1}-H_{t, \infty}^{-1}\right) \varphi^{*} H_{t}\right] \\
& +t^{2} H_{t, \infty}\left[\varphi, H_{t, \infty}^{-1} \varphi^{*}\left(H_{t}-H_{t, \infty}\right)\right]
\end{aligned}
$$

By the interior elliptic regularity estimate, there is $C>0$ such that for all $\alpha$,

$$
\left\|H_{t}-H_{t, \infty}\right\|_{L_{k+2}^{2}\left(U_{\alpha, k+2}\right)} \leq C\left(\left\|\partial_{\bar{z}} \partial_{z}\left(H_{t}-H_{t, \infty}\right)\right\|_{L_{k}^{2}\left(U_{\alpha, k+1}\right)}+\left\|H_{t}-H_{t, \infty}\right\|_{L^{2}\left(U_{\alpha, k+2}\right)}\right) .
$$

In (165), we expand higher derivatives of each term to get a sum of terms of the form

$$
\nabla^{m}\left(\partial_{\bar{z}}\left(H_{t}-H_{t, \infty}\right) H_{t}^{-1}\left(\partial_{z} H_{t}\right)\right), \ldots, \nabla^{m}\left(t^{2} H_{t, \infty}\left[\varphi, H_{t, \infty}^{-1} \varphi^{*}\left(H_{t}-H_{t, \infty}\right)\right]\right),
$$

with $0 \leq m \leq k$. Following inductive arguments as in the proof of Prop 3.4 and note that $t^{2} e^{-c t^{2 / 3}} \rightarrow 0$ as $t \rightarrow 0$ for $c>0$, we have (164) for all $\ell \geq 0$. The conclusion follows from the bounded inclusion $L_{\ell+2}^{2} \subset C^{\ell^{\prime}}$ for each $\ell^{\prime} \geq 0$.
q.e.d.

Theorem 1.1 will now follow by combining all the above analysis. We restate it in a more detailed form.

Theorem 4.2. Fix $x_{0} \in X-D, v_{0} \in L_{x_{0}}$ and $X_{0} \subset X-D$ a compact set. Let $h_{t}$ be Hermitian-Yang-Mills metric of $(F, t \beta, t \gamma)$ and $\iota: F \rightarrow V$ the Hecke modification corresponding to $(F, \beta, \gamma)$ as in Theorem 2.4 For $a \neq 0$ let $S_{a}=\iota^{-1} \circ \operatorname{diag}\left(a^{2}, a^{-1}\right) \circ \iota$, an endomorphism of $\left.F\right|_{X-D}$. Let $\widetilde{h}_{t}=S_{| |_{\left.0\right|_{k_{t}}}}^{*} h_{t}$ where $k_{t}$ is metric on $\left.L\right|_{X-D}=\left.\operatorname{det} F^{*}\right|_{X-D}$ induced from $h_{t}$. Let $X_{0} \Subset X-D$ be a compact set. Let $h_{\infty}=\iota^{*}\left(h_{L, \infty}^{-2} h_{K} \oplus h_{L, \infty} h_{K}\right)$ where $h_{L, \infty}$ is a harmonic metric adapted to the filtered bundle ( $L, \lambda_{\infty}$ ) over $(X, D)$ such that $\left|v_{0}\right|_{h_{L, \infty}}=1$ and

$$
\lambda_{\infty, j}=\left\{\begin{array}{ll}
1 / 4 & p_{j} \in D_{\beta}  \tag{166}\\
-1 / 4 & p_{j} \in D_{\gamma} \\
-d_{r}^{-1}\left(\operatorname{deg} L+\frac{1}{4}\left(d_{\beta}-d_{\gamma}\right)\right) & p_{j} \in D_{r}
\end{array} .\right.
$$

Let $\psi_{t}$ be given by $\widetilde{h}_{t}=h_{\infty} \cdot \psi_{t}$. Then for each $k \geq 0$, there is $C_{k}$ such

$$
\left\|\psi_{t}-I d\right\|_{C^{k}\left(X_{0}\right)} \leq \frac{C_{k}}{\log t}
$$

Proof. Let $h_{\infty, t}=\iota^{*}\left(h_{L, \lambda(t), t}^{-2} h_{K} \oplus h_{L, \lambda(t), t} h_{K}\right)$ and $g_{t}$ be as in Cor 4.22 We will first define several auxiliary metrics on $\left.F\right|_{X_{0}}$ and automorphisms relating them.

Let $k_{t}$ (resp. $k_{\infty, t}$ ) be the metric on $\left.L\right|_{X-D}$ induced from $h_{t}\left(\right.$ resp. $\left.h_{\infty, t}\right)$. Let $a_{t}=\left|v_{0}\right|_{k_{t}}$ and

$$
\begin{equation*}
a_{\infty, t}=\left|v_{0}\right|_{k_{\infty}, t}=\left|v_{0}\right|_{h_{L, \lambda}(t), t} \tag{167}
\end{equation*}
$$

Let $\widetilde{h}_{t}=S_{a_{t}}^{*} h_{t}, \widetilde{h}_{\infty, t}=S_{a_{t}}^{*} h_{\infty, t}$, and $h_{\infty, t}^{\prime}=S_{a_{\infty}, t}^{*} h_{\infty, t}$. Let $g_{t}^{\prime}\left(\right.$ resp. $\left.\widetilde{g}_{t}\right)$ be defined by $\widetilde{h}_{t}=\widetilde{h}_{\infty, t} \cdot g_{t}^{\prime}\left(\right.$ resp. $\left.\widetilde{h}_{\infty, t}=h_{\infty, t}^{\prime} \cdot \widetilde{g}_{t}\right)$. Let $g_{t}^{\prime \prime}$ be defined by $h_{\infty, t}^{\prime}=h_{\infty} \cdot g_{t}^{\prime \prime}$. The metrics and automorphism relating them are summarized in the following diagram. In particular, $\psi_{t}=g_{t}^{\prime \prime} \cdot \widetilde{g}_{t} \cdot g_{t}^{\prime}$.


Recall again by Prop 2.6 $d_{r}>0$. Let $j_{0}$ be a fixed index such that $p_{j_{0}} \in D_{r}$. By (167) and (84), we have that

$$
a_{\infty, t}=\left|v_{0}\right|_{h_{L, \text { HE }}} e^{\left(\varphi_{\lambda(t)}+\eta_{\lambda(t), t}\right) / 2}
$$

Without loss of generality we may assume $\left|v_{0}\right|_{h_{L, \mathrm{HE}}}=1$. By Props 3.14, 3.25 and 86) with $j=j_{0}$, there is $C_{0}>0$ such that for $t \gg 1$

$$
\left|\eta_{\lambda(t), t}-\frac{4}{3} \lambda_{j_{0}} \log t\right| \leq C_{0} .
$$

We have from $\operatorname{Def} 2.11$ that $\varphi_{\lambda}$ is a linear combination of fixed smooth functions $G_{j}$ on $X_{0}$ with coefficients linear in $\lambda(t)$. Note also that $\left|\lambda_{j_{0}}(t)\right|<1 / 4$ for all $t \geq 1$. Therefore there is $C_{1}>1$ such that for $t \gg 1, C_{1}^{-1} t^{-1 / 3} \leq e^{\varphi_{\lambda(t)}+\eta_{\lambda(t), t}} \leq C_{1} t^{1 / 3}$. Therefore there is $C_{2}>0$ such that for $t \gg 1, a_{\infty, t} \leq C_{2} t^{1 / 6}$. We have $a_{t}=a_{\infty, t}\left(\operatorname{det} g_{t}\left(p_{0}\right)\right)^{-1 / 2}$. By Cor 4.22 there is $C_{2}^{\prime}>0$ such that for $t \gg 1, a_{t} \leq C_{2}^{\prime} a_{\infty, t} \leq C_{2}^{\prime} C_{2} t^{1 / 6}$. Note that $g_{t}^{\prime}=S_{a_{t}}^{-1} \circ g_{t} \circ S_{a_{t}}$. It follows from Cor 4.22 that for $k \geq 0$, there are $C_{3, k}, c_{3, k}>0$ such that for $t \gg 1$

$$
\begin{equation*}
\left\|g_{t}^{\prime}-\mathrm{Id}\right\|_{C^{k}\left(X_{0}\right)} \leq C_{3, k} e^{-c_{3, k} t^{2 / 3}} \tag{168}
\end{equation*}
$$

We have

$$
\widetilde{g}_{t}=\iota^{-1} \circ \operatorname{diag}\left(\operatorname{det} g_{t}\left(p_{0}\right)^{-1},\left(\operatorname{det} g_{t}\left(p_{0}\right)\right)^{1 / 2}\right) \circ \iota
$$

Note that for any two choices of frame in (98) over $X_{0}$, the resulting norms are equivalent. Under a frame compatible with decomposition $V=L^{-2} K \oplus L K$, the local forms of $\widetilde{g}_{t}$ are constant. Therefore by Cor 4.22, there are $C_{4}, c_{4}>0$ such that for $t \gg 1$,

$$
\begin{equation*}
\left\|\widetilde{g}_{t}-\mathrm{Id}\right\|_{C^{k}\left(X_{0}\right)}=\left\|\widetilde{g}_{t}-\mathrm{Id}\right\|_{C^{0}\left(X_{0}\right)} \leq C_{4} e^{-c_{4} t^{2 / 3}} \tag{169}
\end{equation*}
$$

Let $h_{L, \infty, t}$ be the metric on $L$ with $h_{\infty, t}^{\prime}=\iota^{*}\left(h_{L, \infty, t}^{-2} h_{K} \oplus h_{L, \infty, t} h_{K}\right)$. We have that

$$
\begin{aligned}
& h_{L, \infty}=h_{L, \infty, t} \exp \left(\varphi_{\lambda_{\infty}}-\varphi_{\lambda(t)}+\varphi_{\lambda_{\infty}}\left(p_{0}\right)-\varphi_{\lambda(t)}\left(p_{0}\right)\right) \\
& =h_{L, \infty, t} \exp \left(\sum_{j=1}^{4 g-4} \sum_{\ell=1}^{j}\left(\lambda_{\infty, \ell}-\lambda_{\ell}(t)\right)\left(G_{j}-G_{j}\left(p_{0}\right)\right)\right) .
\end{aligned}
$$

For $k \geq 0$, there is $C_{5, k}>0$ such that $\left\|G_{j}-G_{j}\left(p_{0}\right)\right\|_{C^{k}\left(X_{0}\right)} \leq C_{5, k}$. By Prop 3.25 and the above, for $k \geq 0$, there is $C_{6, k}>0$ such that for $t$ large enough

$$
\begin{equation*}
\left\|g_{t}^{\prime \prime}-\mathrm{Id}\right\|_{C^{k}\left(X_{0}\right)} \leq \frac{C_{6, k}}{\log t} \tag{170}
\end{equation*}
$$

The conclusion follows from (168), (169) and $(170)$.
q.e.d.

Lastly, we comment on a special case of Thm 1.1 where the convergence rate is improved. For the $\mathrm{SU}(1,2)$ Higgs bundle $\left(F=K^{-1} \oplus K, t \beta, t \gamma\right)$ in (17), we have $\boldsymbol{b}=(1, \ldots, 1)$. By the discussion in Prop 3.25, $\lambda=(0, \ldots, 0)$ is $t$-compatible with $\boldsymbol{b}$ for all $t \geq 1$, and $\eta_{\lambda(t), t}$ (defined in (84)) is independent of $t$. It follows from the proof that $a_{t}$ is uniformly bounded in $t$ and that the convergence in $C^{k}\left(X_{0}\right)$ may be improved to be exponential in $t$.

In fact, this also follows directly from the $\operatorname{SL}(2, \mathbb{C})$-Hitchin equation case. The associated Hitchin equation reduces to a scalar PDE, and the solution is given by a metric $h_{t}^{-1} \oplus h_{t}$ on $F$ with $h_{t}^{1 / 2}$ the unique solution to the Hitchin's equation associated to $\operatorname{SL}(2, \mathbb{C})$ Higgs bundle

$$
\left(E=K_{X}^{1 / 2} \oplus K_{X}^{-1 / 2}, \Phi=t\left(\begin{array}{ll} 
& 1 \\
q &
\end{array}\right)\right)
$$

In this manner, the exponential in $t$ convergence $h_{t} \rightarrow h_{K}$ ( $h_{K}$ defined in Lemma3.1) is a direct consequence of the result in [MSWW16].
