Eigenvalues and threshold rezonances of a two-dimensional split-step quantum walk with strong shift

Abstract

In this paper, we derive sufficient conditions for the localization of two-dimensional split-step quantum walks with a strong shift. For this purpose, we analyze the zero points of the function f introduced by Fuda et.al. (Quantum Inf Process 16(8) 203, 2017) and make these zero points explicit. These zeros provide a concrete representation of the eigenvalues and eigenvectors of the evolution operator, and in particular, clarify where localization occurs. In addition, the eigenvalues obtained here asymptotically approach threshold resonance in special cases. We also describe the display of threshold resonances and generalized eigenfunctions.

1 Introduction

Quantum walks have been actively studied in recent years, being introduced to quantum information [\[16,](#page-12-0)[26\]](#page-13-0), quantum simulations [\[22,](#page-13-1)[25\]](#page-13-2), and topological phases [\[10,](#page-12-1)[11\]](#page-12-2). Split-step quantum walks (SSQWs), introduced by Kitagawa et.al. [\[11\]](#page-12-2) for the analysis of topological phases, have been studied in various fields including localized phenomena [\[4,](#page-12-3)[5,](#page-12-4)[7\]](#page-12-5), weakly convergent limit [\[6\]](#page-12-6), index theory $[18, 19, 27]$ $[18, 19, 27]$ $[18, 19, 27]$ and so on $[17, 21]$ $[17, 21]$. A necessary and sufficient condition for a quantum walk to induce localization is that the time evolution operator has eigenvalues [\[23\]](#page-13-8). In particular, non-zero components of eigenvectors are the points at which quantum walk localization occurs.

In the context of the discrete Schrödinger equation, a value called resonance is known $[1,8]$ $[1,8]$. If a Hamiltonian satisfies the eigenequations but its eigenfunctions are not square integrable, its eigenvalues are called resonances and its eigenfunctions are called the generalized eigenfunctions corresponding to the resonances. The same thing can happen when considering the eigenequations of the time evolution operator described by quantum walks. As mentioned above, it is equivalent for a quantum walk to cause localization and for the time evolution operator of a quantum walk to have eigenvalues, but the eigenfunctions corresponding to those eigenvalues may not be square integrable. Therefore, it is natural that the time evolution operator of this quantum walk has resonance. Prior work on quantum walk resonances and generalized eigenfunctions can be found in [\[14,](#page-12-8) [15,](#page-12-9) [20\]](#page-13-9).

Resonances for a quantum walk U also apply to stationary measures. If $\|(U^t\Psi_0)(x)\|^2$ is independent with respect to time $t \in \mathbb{Z}_{\geq 0}$, then the measure $\mu(x) := ||(U^t \Psi_0)(x)||^2$ is called a stationary measure [\[3,](#page-12-10) [9,](#page-12-11) [12,](#page-12-12) [13\]](#page-12-13), where Ψ_0 is the initial state. If the initial state Ψ_0 is a generalized eigenfunction of U, then $||(U^t\Psi_0)(x)||^2$ is time independent. Therefore, the research of resonances is linked to the stationary state.

In fact, generalized eigenfunctions have been used to derive the stationary measure of quantum walks $[3, 9, 12, 13]$ $[3, 9, 12, 13]$ $[3, 9, 12, 13]$ $[3, 9, 12, 13]$. In $[9]$, the stationary measures corresponding to the generalized eigenfunctions of one-dimensional space-inhomogeneous quantum walk with finite defects are presented. The stationary measures of a multi-dimensional space-homogeneous quantum walk with cycles can be found in [\[12\]](#page-12-12). The eigenvalues of the quantum walk can be divided into two essentially different parts [\[24\]](#page-13-10). That is, the part derived from birth and the part inherited from the discriminant operator T . A multi-dimensional quantum walk with cycles has an infinite number of eigenvectors with finite support, which corresponds to the birth eigenspace. In [\[12\]](#page-12-12), stationary measures are constructed by the superposition of an infinite number of eigenvectors in the birth eigenspace. On the other hand, in this paper, we derive the generalized eigenfunctions of the two-dimensional SSQWs not from the birth eigenspace, but from the inherited eigenspace. Thus, the eigenfunction in this paper differs from that in [\[12\]](#page-12-12) in its origins.

It was shown in [\[4\]](#page-12-3) that in d-dimensional SSQWs, if the effect of the shift is sufficiently weak, i.e., transition probability $|q_j|^2$ is sufficiently small, the time evolution operator has eigenvalues in the inherited eigenspace. We are interested in whether the time evolution operator has eigenvalues when $|q_j|^2$ is sufficiently large. Therefore, in this paper, a detailed analysis is performed under the condition that the shift is extremely strong, i.e, $q_1 = q_2 = 1$ in twodimensional SSQWs. In our model, eigenvalues and eigenvectors can be specifically displayed. In addition, we derive resonances and corresponding generalized eigenfunctions in a special case.

The remainder of this paper is organized as follows. Section $\sum_{k=1}^{\lfloor \log c \rfloor}$ introduces the general form of a two-dimensional SSQW with one defect and present prior work on localization [\[4\]](#page-12-3). While the previous study dealt only with the case where the effect of the shift is weak, this study deals with a model in which the effect of the shift is strong. We introduce conditions for this purpose. The main results are presented in Section [3.](#page-4-0) In Section [3,](#page-4-0) we give sufficient conditions for SSQWs to cause localization. If that sufficient condition is satisfied, we also show that the time evolution operator has at least four eigenvalues. It also showed where exactly localization is occurring. Furthermore, $|\phi_{2,2}| < |\omega_{2,2}|$ is a sufficient condition for localization to occur, but U have resonances when $|\phi_{2,2}| = |\omega_{2,2}|$. In particular, these resonances are boundary values of the essential spectrum of U and are called threshold resonances.

2 Model definition and related results

In this section, we first define a general two-dimensional split-step quantum walks (SSQWs) and briefly introduce related results. For detailed background and discussion, see [\[4\]](#page-12-3). Next, we define a more specific model of SSQWs that can be interpreted as an "extremely *strong* shift effect". The purpose of this paper is to shed light on a new aspect of SSQWs through the analysis of this specific model. Note that while [\[4\]](#page-12-3) provides sufficient conditions for the localization of SSQWs that can be interpreted as "very *weak* shift effects", the model presented in this paper deviates significantly from it.

2.1 Definition of two-dimensional split-step quantum walks

In what follows, we use H to denote $\ell^2(\mathbb{Z}^2;\mathbb{C}^4)$. Let $(\mathbf{p},\mathbf{q})=(p_1,p_2,q_1,q_2)\in\mathbb{R}^2\times\mathbb{C}^2$ satisfy $p_j^2 + |q_j|^2 = 1$ $(j = 1, 2)$ and use $\{e_j\}_{j=1}^2$ to denote the standard basis of \mathbb{Z}^2 . We set an operator S_j $(j = 1, 2)$ on $\ell^2(\mathbb{Z}^2; \mathbb{C}^2)$ as $S_j :=$ $\sqrt{ }$ $\overline{1}$ p_j q_jL_j $(q_jL_j)^*$ – p_j \setminus , where L_j is the e_j -shift on $\ell^2(\mathbb{Z}^2)$ defined by $(L_j f)(\boldsymbol{x}) = f(\boldsymbol{x} + \boldsymbol{e}_j)$ for all $f \in \ell^2(\mathbb{Z}^2)$, i.e.,

(S_j\psi)(\boldsymbol{x}) = \begin{pmatrix} p_j\psi_1(\boldsymbol{x}) + q_j\psi_2(\boldsymbol{x} + \boldsymbol{e}_j) \\ q_j^*\psi_1(\boldsymbol{x} - \boldsymbol{e}_j) - p_j\psi_2(\boldsymbol{x}) \end{pmatrix} \text{ for all } \boldsymbol{x} \in \mathbb{Z}^2, \ \psi = \begin{pmatrix} \psi_1 \\ \psi_2 \end{pmatrix} \in \ell^2(\mathbb{Z}^2; \mathbb{C}^2).
$$

Identifying H with $\ell^2(\mathbb{Z}^2;\mathbb{C}^2) \oplus \ell^2(\mathbb{Z}^2;\mathbb{C}^2)$, we define the shift operator S on H as $S = S_1 \oplus S_2$, i.e.,

(S\Psi)(\boldsymbol{x}) = \begin{pmatrix} (S_1\Psi_1)(\boldsymbol{x}) \\ (S_2\Psi_2)(\boldsymbol{x}) \end{pmatrix} \text{ for all } \boldsymbol{x} \in \mathbb{Z}^2, \ \Psi = \begin{pmatrix} \Psi_1 \\ \Psi_2 \end{pmatrix} \in \mathcal{H}, \ \Psi_j \in \ell^2(\mathbb{Z}^2; \mathbb{C}^2) \ (j = 1, 2).

Then S is self-adjoint and unitary on H and satisfies $S^2 = 1$. Next, we define the coin operator. Let $\Omega = {}^{t}(\omega_{1,1}, \omega_{1,2}, \omega_{2,1}, \omega_{2,2})$ and $\Phi = {}^{t}(\phi_{1,1}, \phi_{1,2}, \phi_{2,1}, \phi_{2,2})$ be normalized vectors on \mathbb{C}^{4} . We define the coin operator C on H as a multiplication operator by $C(\mathbf{x})$, i.e.,

(C\Psi)(\boldsymbol{x})=C(\boldsymbol{x})\Psi(\boldsymbol{x})\quad\text{for all }\boldsymbol{x}\in\mathbb{Z}^2,\ \Psi\in\mathcal{H}.

In our one-defect model, $C(\boldsymbol{x})$ is defined by

Then C is self-adjoint and unitary on H . We define a time evolution operator U on H as $U = SC$. Since both S and C are self-adjoint and unitary on H , the spectral mapping theorem (SMT) of quantum walks [\[24\]](#page-13-10) can be applied to U.

2.2 Related results for localization

To introduce the SMT results, we provide some definitions. The discriminant operator T on $\ell^2(\mathbb{Z}^2)$ with respect to U is defined as $T = dSd^*$, where $d : \mathcal{H} \to \ell^2(\mathbb{Z}^2)$ is a boundary operator, i.e.,

Furthermore, for a boundary operator d , the following holds:

Definition 2.1 (Localization). Let $\Psi_0 \in \mathcal{H}$ be an initial state with $\|\Psi_0\| = 1$. We say that a $pair (U, \Psi_0)$ *causes localization when there exists* $\boldsymbol{x} \in \mathbb{Z}^2$ *such that* $\limsup_{t\to\infty}||(U^t\Psi_0)(\boldsymbol{x})||^2 > 0$ *holds.*

In the following, sufficient conditions for localization are described. By [\[23,](#page-13-8) Proposition 2.4], (U, Ψ_0) causes localization if and only if the time evolution operator U has eigenvalue μ and Ψ_0 overlap with the eigenspace ker($U - \mu$). Therefore, for localization to occur, U must have an eigenvalue. We briefly present known results on the sufficient conditions for U to have eigenvalues. Among the results obtained by SMT, the following are of particular interest in this paper:

From this result, sufficient conditions for localization can be obtained by analyzing the eigenvalues of T . The following is a preparation for analyzing the eigenvalues of T . We define the bounded operator T_0 on $\ell^2(\mathbb{Z}^2)$ as follows:

By [\[4,](#page-12-3) Lemma 3.3], we find

Let 1_A be the characteristic function of a set A. Assuming $[-1, 1] \setminus \sigma(T_0) \neq \emptyset$, we can define the function f on $[-1, 1] \setminus \sigma(T_0)$ as

By the method of the paper [\[4\]](#page-12-3), we obtain the following facts for f and the eigenvalues of T, U :

Note that the eigenvalues $e^{\pm i \arccos \lambda}$ of U are discrete. The next theorem gives a sufficient condition for U to have eigenvalues.

FFS17main **Theorem 2.2** ([\[4\]](#page-12-3), $d = 2$). Assume the following conditions:

Then there exists $\delta > 0$ *such that if* (p, q) *satisfies* $p_l q_l \neq 0$ *and* $\|(p, q) - (p_0, 0)\|_{\mathbb{R}^2 \times \mathbb{C}^2} < \delta$, *then* f *have a zero, i.e., there exist eigenvalues of* U*.*

In the next subsection, we define SSQWs with a strong shift (i.e., $p=0$).

2.3 SSQWs with strong shift

We consider SSQWs in which the shift is so strong that Theorem [2.2](#page-3-0) cannot be applied. Therefore, we introduce the following conditions.

Remark 2.3. *Condition* ([C.1\)](#page-4-1) *is a special case of condition* ([2.6\)](#page-3-1) *in Theorem* [2.2.](#page-3-0) *Condition* $(\mathbb{C}.2)$ *is not essential, and the rest of the paper's argument can be developed similarly even if the parameters are not real values. Note that condition* $(\mathbb{C}.3)$ *is a "strong shift" condition, and the assumption of Theorem [2.2](#page-3-0) is not satisfied in the model with this condition imposed.*

Hereafter, conditions $(\check{\mathbb{C}}^1)$ – $(\check{\mathbb{C}}^2)$ is assumed unless otherwise noted. By conditions $(\check{\mathbb{C}}^1)$ – (c3), $a_{\Phi}(\mathbf{p}) = a_{\Omega}(\mathbf{p}) = 0$ holds and the previously defined T_0 and $\varphi_{\mathbf{q}}$ can be rewritten as

Defining $\Lambda := 2|\phi_{2,1}\phi_{2,2}|, [-1,1] \setminus \sigma(T_0) \neq \emptyset$ holds because $\sigma(T_0) = [-\Lambda, \Lambda]$ and

We set $\mathbb{T}_- := [-1, -\Lambda)$ and $\mathbb{T}_+ := (\Lambda, 1]$, then the domain of f is $\mathbb{T}_- \cup \mathbb{T}_+$.

3 Main result

In this section, we discuss the main results. The main results consist of two parts: one on localization and one on resonance. The models treated in this section are SSQWs with the strong shift defined in the previous section.

3.1 Sufficient conditions for localization of strong shift

In the next theorem, we present the necessary and sufficient conditions for f to have zero points.

 $\overline{\text{main1}}$ **Theorem 3.1.** *Under the conditions* $(\overline{\text{C}}.1)$ – $(\overline{\text{C}}.3)$ *, the following conditions* (1) and (2) are *equivalent.*

- *(1)* f has zero points on $\mathbb{T}_- \cup \mathbb{T}_+$.
- *(2)* $|\phi_{2,2}| < |\omega_{2,2}|$.

In particular, when either (i.e., both) of the above conditions holds, the zeros of f *consist of* λ_0^+ $and \ \lambda_0^-$ given by

$$
\lambda_0^{\pm} = \pm \frac{2\omega_{2,1}\omega_{2,2}}{\sqrt{2\omega_{2,2}^2/\phi_{2,2}^2 - 1}}.
$$

Note that $\lambda_0^+ \neq \lambda_0^-$ by condition $\begin{pmatrix} \epsilon_2^2 \\ \epsilon_1^2 \end{pmatrix}$. Furthermore, $\begin{pmatrix} \epsilon_1 & \epsilon_2 & \epsilon_1 \\ \epsilon_2^2 & \epsilon_3 & \epsilon_4 \\ \epsilon_4^+ & \epsilon_5^+ \end{pmatrix}$ *of the eigenvalue correspondence indicates that* U *has at least four eigenvalues* $e^{i \arccos \lambda_0^{\pm}}$ *and* $e^{-i \arccos \lambda_0^{\pm}}$.

Proof. First, we calculate $f(\lambda)$. By the Fourier transform from $\ell^2(\mathbb{Z}^2)$ to $L^2([0, 2\pi)^2, d\mathbf{k}/(2\pi)^2)$ and condition (\mathbb{C}^1) , we obtain $\hat{\varphi}_q(\mathbf{k}) = 2i\phi_{2,1}\omega_{2,2} \sin k_2$ and $\hat{T}_0(\mathbf{k}) = 2\phi_{2,1}\phi_{2,2} \cos k_2$ for $\mathbf{k} =$ $(k_1, k_2) \in [0, 2\pi)^2$. We set $a := \lambda/2\phi_{2,1}\phi_{2,2}$ for $\lambda \in \mathbb{T}_- \cup \mathbb{T}_+$. Note that $|a| > 1$. Then we have the following equation:

= a + \frac{1}{4\phi_{2,1}^2\phi_{2,2}^2} \int_{[0,2\pi)^2} \frac{d\mathbf{k}}{(2\pi)^2} \frac{4\phi_{2,1}^2 \omega_{2,2}^2 \sin^2 k_2}{\cos k_2 - a} \\
= a + \frac{\omega_{2,2}^2}{\phi_{2,2}^2} \int_{[0,2\pi)} \frac{dk_2}{(2\pi)} \frac{\sin^2 k_2}{\cos k_2 - a} \\
= a + \frac{\omega_{2,2}^2}{\phi_{2,2}^2} (-a + \text{sgn}(a)\sqrt{a^2 - 1}).

Thus, if there exist zero points $\lambda_0 \in \mathbb{T}_- \cup \mathbb{T}_+$ of f, i.e., $f(\lambda_0) = 0$, then

Note that condition $(\overline{3.1})$ and $(\overline{3.2})$ leads to conditions

Remark 3.3. *Theorem* [3.1](#page-4-4) *shows that SSQWs with the strong shift are localized as in [\[4\]](#page-12-3)*. *Moreover, we see that the localized location* $\boldsymbol{x} = (x_1, x_2)$ *always satisfies* $x_1 = 0$ *or* $x_1 = 1$ *by Theorem* [3.2.](#page-5-6) The cause is condition $\omega_{1,2} = \phi_{1,2} = 0$ in ([C.1\)](#page-4-1). If this condition is removed, *localization is expected to occur even for* $x_1 \neq 0$ *and* $x_1 \neq 1$ *.*

3.2 Threshold resonances and generalized eigenfunction

In this subsection, we consider the case of $|\phi_{2,2}| = |\omega_{2,2}|$. When $|\phi_{2,2}| = |\omega_{2,2}|$ holds, we obtain a quantity called the threshold resonance of U as the quantity corresponding to the eigenvalue μ_0 of U obtained in the case $|\phi_{2,2}| < |\omega_{2,2}|$ in Theorem [3.2.](#page-5-6) First, we define resonance and threshold resonance.

Definition 3.4 (Threshold resonances). We can naturally extend U to U_{∞} acting on \mathcal{H}_{∞} := $\ell^{\infty}(\mathbb{Z}^2;\mathbb{C}^4)$. Let $\Psi \in \mathcal{H}_{\infty}$ be a solution of $U_{\infty}\Psi = m\Psi$, where m is a complex number. If $\Psi \in \mathcal{H}_{\infty} \backslash \mathcal{H}$, then we say that m is a resonance of U and Ψ is a generalized eigenfunction of U corresponding to m. If m is a resonance of U and $m \in \partial \sigma_{\rm ess}(U)$ holds, then m is called a *threshold resonance.*

(T_0h_\lambda)(\boldsymbol{x}) = \phi_{2,1}\phi_{2,2}((L_2h_\lambda)(\boldsymbol{x}) + (L_2^*h_\lambda)(\boldsymbol{x})), (Th_\lambda)(\boldsymbol{x}) = \chi_{2,1}(\boldsymbol{x})\chi_{2,2}(\boldsymbol{x} + \boldsymbol{e}_2)(L_2h_\lambda)(\boldsymbol{x}) + \chi_{2,2}(\boldsymbol{x})\chi_{2,1}(\boldsymbol{x} - \boldsymbol{e}_2)(L_2^*h_\lambda)(\boldsymbol{x}).
$$

We define an operator W and a function β as $W := T - T_0$ and $\beta(\boldsymbol{x}) := \chi_{2,1}(\boldsymbol{x}) \chi_{2,2}(\boldsymbol{x}_{\text{min}} + \boldsymbol{e}_2)$ $\phi_{2,1}\phi_{2,2}$. Here, noting $\psi_{\lambda} \in \text{Ran}P$, we have $\psi_{\lambda}(0) = 0$. With this fact and Lemma [3.10,](#page-9-2) we obtain

$$
(Wh_{\lambda})(\boldsymbol{x}) = (\beta(\boldsymbol{0})\boldsymbol{1}_{\{\boldsymbol{0}\}}(\boldsymbol{x}) + \beta(-\boldsymbol{e}_{2})\boldsymbol{1}_{\{-\boldsymbol{e}_{2}\}}(\boldsymbol{x})) (L_{2}h_{\lambda})(\boldsymbol{x}) + (\beta(-\boldsymbol{e}_{2})\boldsymbol{1}_{\{\boldsymbol{0}\}}(\boldsymbol{x}) + \beta(\boldsymbol{0})\boldsymbol{1}_{\{\boldsymbol{e}_{2}\}}(\boldsymbol{x})) (L_{2}^{*}h_{\lambda})(\boldsymbol{x}) = \beta(\boldsymbol{0})\psi_{\lambda}(\boldsymbol{e}_{2})\boldsymbol{1}_{\{\boldsymbol{0}\}}(\boldsymbol{x}) - \varepsilon(\lambda)\beta(-\boldsymbol{e}_{2})\boldsymbol{1}_{\{-\boldsymbol{e}_{2}\}}(\boldsymbol{x}) + \beta(-\boldsymbol{e}_{2})\psi_{\lambda}(-\boldsymbol{e}_{2})\boldsymbol{1}_{\{\boldsymbol{0}\}}(\boldsymbol{x}) - \varepsilon(\lambda)\beta(\boldsymbol{0})\boldsymbol{1}_{\{\boldsymbol{e}_{2}\}}(\boldsymbol{x}). \qquad (3.15) \quad \boxed{\text{wh_la}}

On the other hand, we get the following equation by $\left(2.4\right)$ and Lemma $\overline{3.10}$:

(T_0 - \lambda)h_{\lambda} = \varphi_q - \varepsilon(\lambda)\phi_{2,1}\phi_{2,2}\left(\mathbf{1}_{\{-e_2\}} + \mathbf{1}_{\{e_2\}}\right) + \lambda\varepsilon(\lambda)\mathbf{1}_{\{0\}}.\tag{3.16}
$$

Combining $(\overline{3.15})$ and $(\overline{3.16})$, we have

= $\varphi_q + A_1 \mathbf{1}_{\{0\}} - \varepsilon(\lambda)A_2 \mathbf{1}_{\{-e_2\}} - \varepsilon(\lambda)A_3 \mathbf{1}_{\{e_2\}},$

where

A_1 := \beta(\mathbf{0})\psi_{\lambda}(\mathbf{e}_2) + \beta(-\mathbf{e}_2)\psi_{\lambda}(-\mathbf{e}_2) + \lambda\varepsilon(\lambda),
$$

A_2 := \beta(-\mathbf{e}_2) + \phi_{2,1}\phi_{2,2},
$$

\n
$$
A_3 := \beta(\mathbf{0}) + \phi_{2,1}\phi_{2,2}.
$$

By $\left(\stackrel{\text{leq};\text{phipsi}}{2.4}\right)$

-\lambda \varepsilon(\lambda) = \langle \omega_{2,1} \phi_{2,2} \mathbf{1}_{\{e_2\}} + \omega_{2,2} \phi_{2,1} \mathbf{1}_{\{-e_2\}}, \psi_{\lambda} \rangle \n= \omega_{2,1} \phi_{2,2} \psi_{\lambda}(e_2) + \omega_{2,2} \phi_{2,1} \psi_{\lambda}(-e_2) \n= \beta(\mathbf{0}) \psi_{\lambda}(e_2) + \beta(-e_2) \psi_{\lambda}(-e_2) + \phi_{2,1} \phi_{2,2} (\psi_{\lambda}(e_2) + \psi_{\lambda}(-e_2)).

Since $2 \cos k \cdot (-2i\omega_{2,1}\phi_{2,2} \sin k)/(2\phi_{2,1}\phi_{2,2} \cos k - \lambda)$ is an odd function, we obtain

\psi_{\lambda}(e_2) + \psi_{\lambda}(-e_2) = \int_{-\pi}^{\pi} 2 \cos k_2 \cdot \frac{-2i\omega_{2,1}\phi_{2,2}\sin k_2}{2\phi_{2,1}\phi_{2,2}\cos k_2 - \lambda} \frac{dk_2}{2\pi} = 0
$$

by (3.10) (3.10) . Thus we get $A_1 = \langle \varphi_q, \psi_\lambda \rangle + \lambda \varepsilon(\lambda) = 0$. On the other hand, we obtain $A_2 =$ $\omega_{2,2}\phi_{2,1}, A_3=\omega_{2,1}\phi_{2,2}$ by the definition of β . Hence, we have

= $(1 - 2\mu\lambda + \mu^{2})Sd^{*}h_{\lambda} + 2\mu(\varepsilon(\lambda) - 1)Sd^{*}\varphi_{q} + (\varepsilon(\lambda) - 1)(U - \mu)(1 - \mu S)d^{*}\mathbf{1}_{\{0\}}.$

The last equality in the above equation is due to the fact that $SCd^*\hbar_{\lambda} = Sd^*\hbar_{\lambda}$, $SCSd^* =$ $S(2d^*d-1)Sd^* = 2Sd^*T - d^*$ and Lemma [3.11.](#page-9-4) Also, the equation $1 - 2\mu\lambda + \mu^2 = 0$ holds, since $\lambda = \text{Re } \mu$ and $|\mu| = 1$. Thus

We are now ready to prove our main result on threshold resonances in this subsection, Theorem [3.6.](#page-7-5)

Proof of Theorem [3.6.](#page-7-5) In what follows, we show that m_+ is a threshold resonance of U. By the triangle inequality, for $\mu \in \Sigma_+$ and $\boldsymbol{x} \in \mathbb{Z}^2$, we obtain

\|(U_{\infty}\Psi_{m_+})(\boldsymbol{x})-m_+\Psi_{m_+}(\boldsymbol{x})\|_{\mathbb{C}^4}\leq \|(U_{\infty}\Psi_{m_+})(\boldsymbol{x})-(U_{\infty}\Psi_{\mu})(\boldsymbol{x})\|_{\mathbb{C}^4}\tag{3.17} \quad \text{eq:re}
$$

$$
+ \left\| (U_{\infty} \Psi_{\mu})(\boldsymbol{x}) - \mu \Psi_{\mu}(\boldsymbol{x}) \right\|_{\mathbb{C}^{4}} \tag{3.18} \quad \text{(9.18)}
$$

$$
+\|\mu\Psi_{\mu}(\boldsymbol{x})-m_{+}\Psi_{m_{+}}(\boldsymbol{x})\|_{\mathbb{C}^{4}}.\tag{3.19}\quad\text{eq:re}
$$

By the definition of Ψ_{m_+} , the term (3.19) (3.19) converges to 0 as $\mu \to m_+$. Noting Remark [3.5,](#page-6-2) the term (3.18) (3.18) can be evaluated from above as follows:

(U_{\infty}\Phi_{\mu})(\boldsymbol{x}) = \begin{pmatrix} (C_{\infty}\Phi_{\mu})_2(\boldsymbol{x} + \boldsymbol{e}_1) \\ (C_{\infty}\Phi_{\mu})_1(\boldsymbol{x} - \boldsymbol{e}_1) \\ (C_{\infty}\Phi_{\mu})_4(\boldsymbol{x} + \boldsymbol{e}_2) \\ (C_{\infty}\Phi_{\mu})_3(\boldsymbol{x} - \boldsymbol{e}_2) \end{pmatrix},
$$

here $(C_{\infty}\Phi_{\mu})_i(\boldsymbol{x})$ is the *i*-th component of $(C_{\infty}\Phi_{\mu})(\boldsymbol{x})$ for each $\boldsymbol{x} \in \mathbb{Z}^2$, $i = 1, 2, 3, 4$. Since C_{∞} is one-defect, there exists a constant $c > 0$ such that $|(C_{\infty}\Phi_{\mu})_i(\bm{x})| \leq c |(\Phi_{\mu})_i(\bm{x})|$ for $\boldsymbol{x} \in \mathbb{Z}^2$, $i = 1, 2, 3, 4$. Thus we obtain

$$
\| (U_{\infty} \Phi_{\mu})(x) \|_{\mathbb{C}^{4}}^{2} \leq c \{ |(\Phi_{\mu})_{1}(x - \boldsymbol{e}_{1})|^{2} + |(\Phi_{\mu})_{2}(x + \boldsymbol{e}_{1})|^{2} + |(\Phi_{\mu})_{3}(x - \boldsymbol{e}_{2})|^{2} + |(\Phi_{\mu})_{4}(x + \boldsymbol{e}_{2})|^{2} \} \rightarrow 0
$$

as $\mu \to m_+$. This means that the term (8.17) convergences to 0 as $\mu \to m_+$. Hence $\|(U_{\infty}\Psi_{m_+})(\bm{x})-\$ $m_+\Psi_{m_+}(\boldsymbol{x})\|_{\mathbb{C}^4} = 0$ holds for all $\boldsymbol{x} \in \mathbb{Z}^2$, i.e.,

$$
U_{\infty}\Psi_{m_+}=m_+\Psi_{m_+}.
$$

reso3 In addition to the above results, by Proposition $3.7, m₊$ $3.7, m₊$ is a threshold resonance of U. For other threshold resonances, the theorem can be proved in the same way as above. \Box
