Unbounded Hamiltonians generated by Parseval frames

Abstract

In [\[9\]](#page-22-0) Parseval frames were used to define bounded Hamiltonians, both in finite and in infinite dimesional Hilbert spaces. Here we continue this analysis, with a particular focus on the discrete spectrum of Hamiltonian operators defined as a weighted infinite sum of rank one operators defined by some Parseval frame living in an infinite dimensional Hilbert space. The main difference with [\[9\]](#page-22-0) is that, here, the operators we consider are mostly unbounded. This is an useful upgrade with respect to our previous results, since physically meaningful Hamiltonians are indeed often unbounded. However, due to the fact that frames (in general) are not bases, the definition of an Hamiltonian is not so easy, and part of our results goes in this direction. Also, we discuss the eigenvalues of the Hamiltonians, and we discuss some physical applications of our framework.

I Introduction

In quantum mechanics a central object is the Hamiltonian H of the physical system S one is interested in. H is, for closed and conservative systems, the energy of S . Quite often, the first step to analyze S consists in finding the eigenvectors of H, e_j : H $e_j = E_j e_j$, $j = 1, 2, 3, \ldots$ If H is self-adjoint, then each $E_j \in \mathbb{R}$ and eigenvectors related to different eigenvalues are orthogonal: $\langle e_j, e_k \rangle = 0$, if $E_j \neq E_k$. Most of the times $\mathcal{F}_e = \{e_j\}$ is an orthonormal basis (ONB) for H , the Hilbert space where S is defined, and the Hamiltonian is written

$$
H = \sum_{j} E_j \langle e_j, \cdot \rangle e_j = \sum_{j} E_j P_j,\tag{1.1}
$$

where we have introduced P_j acting on a generic vector f of H as follows: $P_j f = \langle e_j, f \rangle e_j$. Since $P_j = P_j^* = P_j^2$, H can be seen as a weighted sum of orthogonal projectors, with weights given by its eigenvalues E_j . If is clear that the domain of H , $\mathcal{D}(H)$, is not necessarily all of H. In fact we have $\mathcal{D}(H) = \{f \in \mathcal{H} : \sum_j E_j^2 |\langle e_j, f \rangle|^2 < \infty\}$, which is surely dense in H (it contains the linear span of the e_j 's), but not necessarily coincident with H .

In the past 30 years it has become clearer and clearer that the Hamiltonian of a system does not really have to be self-adjoint, [\[13\]](#page-22-1). Since this seminal paper, an always increasing number of physicists and mathematicians started to consider this possibility, where the reality of the eigenvalues of a manifestly non self-adjoint Hamiltonian H is due to some physical symmetry rather than on the mathematical requirement that $H = H^*$. However, even if the eigenvalues of H are real, the eigenvectors, φ_j are no longer mutually orthogonal, in general. Still, if the set $\mathcal{F}_{\varphi} = {\varphi_j}$ is a basis for \mathcal{H} , a second (uniquely determined) basis of the Hilbert space also exists, $\mathcal{F}_{\psi} = {\psi_j}$, such that $\langle \varphi_j, \psi_k \rangle = \delta_{j,k}$, and $H^* \psi_k = E_k \psi_k$. In this case we can write H and H^* as follows:

$$
H = \sum_j E_j \langle \psi_j, \cdot \rangle \varphi_j = \sum_j E_j Q_j, \qquad H^* = \sum_j \overline{E_j} \langle \varphi_j, \cdot \rangle \psi_j = \sum_j \overline{E_j} Q_j^*,
$$

where $Q_j f = \langle \psi_j, f \rangle \varphi_j$ is a projection operator, but it is not orthogonal if $\varphi_j \neq \psi_j$. Operators of this kind have been studied in the past, mainly from a mathematical point of view. We refer to [\[6\]](#page-22-2) for some results, mainly for the case in which \mathcal{F}_{φ} and \mathcal{F}_{ψ} are Riesz bases. Later, generalizations of this situation have been considered, [\[5,](#page-22-3) [18,](#page-23-0) [19\]](#page-23-1). In all these extensions, biorthogonality of the sets of vectors used to define some specific Hamiltonian was required. In [\[9\]](#page-22-0), this assumption was removed, in our knowledge, for the first time: we used frames, and in particular Parseval frames (PF), rather than bases. Hence the existence of a biorhogonal basis is not guaranteed. Our interest was mainly mathematical, but was also based on a very simple physical remark: in the analysis of a concrete physical situation

it may happen that *not all* vectors of H are relevant in the analysis of S . For instance, when the energy of S cannot *really* increase too much, or when S is localized in a bounded region, or still when the value of the momentum of S cannot be too large. In all these cases, but not only, it is reasonable to consider a *physical vector space*, \mathcal{H}_{ph} , as the subset of the mathematical Hilbert space H on which S is originally defined. \mathcal{H}_{ph} can be constructed as the projection of H, via some suitable orthogonal projector operator P i.e., $\mathcal{H}_{ph} = P\mathcal{H}$. The restriction of H defined by [\(1.1\)](#page-1-0) onto \mathcal{H}_{ph} gives rise to the new Hamiltonian $H_{ph} = PHP$ (physical part of H) acting in \mathcal{H}_{ph}

$$
H_{ph}f = \sum E_j \langle \varphi_j, f \rangle \varphi_j, \qquad (1.2)
$$

where, the set of vectors $\mathcal{F}_{\varphi} = {\varphi_j} = Pe_j$ loses the property of being an ONB of \mathcal{H}_{ph} and, instead, it turns out to be a Parseval frame of \mathcal{H}_{ph} .

In this paper we explore further this situation, extending what we have found in [\[9\]](#page-22-0) to unbounded operators, which are often more relevant in the analysis of concrete physical systems, [\[14,](#page-22-4) [22\]](#page-23-2).

The paper is divided in two parts: in Section [II](#page-3-0) we describe our mathematical results, while Section [III](#page-13-0) contains some detailed examples. More in details, after some preliminaries in Section [II.1,](#page-3-1) in Section [II.2](#page-4-0) we introduce the Hamiltonian $H_{\varphi,E} = \sum_{j\in J} E_j \langle \varphi_j, \cdot \rangle \varphi_j$, for a PF $\{\varphi_j\}$, and we study its domain, and we give conditions for $H_{\varphi,E}$ to be, or not, bounded and self-adjoint. Its spectrum is then analyzed in Section [II.3.](#page-8-0)

In Section [III.1](#page-13-1) we use a PF first introduced by Casazza and Christensen to define a particular $H_{\varphi,E}$, and in particular to study its eigenvalues and eigenvectors. We also show how to introduce two different sets of ladder operators, a_n and V_n . In particular, a_n and its adjoint a_n^* obey a truncated version of the canonical commutation relations which was first used, in our knowledge, in [\[11\]](#page-22-5), and later extended in [\[3\]](#page-22-6). These truncated bosonic operators allow to interpolate between fermions and bosons, going from $n = 2$ to $n \to \infty$. We will also comment that the operators V_n may have an interesting role in signal analysis.

Section [III.2](#page-17-0) contains a first part, where we propose a particular method to construct a PF out of an ONB, and then we apply this method to the Hamiltonian of a single electron in a strong magnetic field. Its eigenstates produce the so-called Landau levels, which have infinite degeneracy. This Hamiltonian is at the basis of the analysis of the quantum Hall effect. In particular, we will show that our approach could be seen as generating two different lattices in each Landau levels.

II Hamiltonians generated by Parseval frames

II.1 Parseval frames.

Here all necessary facts about Parseval frames are presented in a form convenient for our exposition. More details can be found in [\[17,](#page-23-3) [24\]](#page-23-4).

Let K be a complex infinite-dimensional separable Hilbert space with scalar product $\langle \cdot, \cdot \rangle$ linear in the second argument. Denote by $\mathbb J$ a generic countable index set such as $\mathbb Z$, N, $\mathbb{N} \cup \{0\}$, etc.

A Parseval frame (PF for short) is a family of vectors $\mathcal{F}_{\varphi} = {\varphi_j, j \in \mathbb{J}}$ in K which satisfies

$$
\sum_{j\in\mathbb{J}} |\langle \varphi_j, f \rangle|^2 = ||f||^2, \quad f \in \mathcal{K}.
$$
\n(2.1)

It follows from [\(2.1\)](#page-3-2) that $\|\varphi_j\| \leq 1$ for $j \in \mathbb{J}$.

According to the Naimark dilation theorem, each PF in K can be extended to an orthonormal basis of a wider subspace \mathcal{H} .

Theorem 1 ([\[23\]](#page-23-5)) Let $\mathcal{F}_{\varphi} = {\varphi_j, j \in \mathbb{J}}$ be a PF in a Hilbert space K. Then there exists a complementary Hilbert space M and a PF $\mathcal{F}_{\psi} = {\psi_j, j \in \mathbb{J}}$ in M such that

$$
\mathcal{F}_h = \{ h_j = \varphi_j \oplus \psi_j, \ j \in \mathbb{J} \}
$$
\n
$$
(2.2)
$$

is an ONB for $\mathcal{H} = \mathcal{K} \oplus \mathcal{M}$.

It is also easy to prove, with a direct computation, that taken an ONB $\{e_n\}$ of \mathcal{H} , and an orthogonal projector P, the set $\{Pe_n\}$ is a PF in $\mathcal{H}_{ph} = P\mathcal{H}$, as already claimed in the Introduction.

The excess $e[\mathcal{F}_{\varphi}]$ of a PF of $\mathcal{F}_{\varphi} = {\varphi_j, j \in \mathbb{J}}$ is the greatest integer n such that n elements can be deleted from the frame \mathcal{F}_{φ} and still leave a complete set, or ∞ if there is no upper bound to the number of elements that can be removed. It follows from [\[12,](#page-22-7) Lemma 4.1] and Theorem [1](#page-3-3) that $e[\mathcal{F}_{\varphi}]$ coincides with dim M, where M is the complementary Hilbert space in Theorem [1.](#page-3-3) The zero excess means that \mathcal{F}_{φ} is an ONB of K. The finite excess $e[\mathcal{F}_{\varphi}]$ means that the index set \mathbb{J} can be decomposed $\mathbb{J} = \mathbb{J}_0 \cup \mathbb{J}_1$ in such a way that $\mathcal{F}^0_{\varphi} = \{\varphi_j, j \in \mathbb{J}_0\}$ is a Riesz basis in K and \mathbb{J}_1 is a finite set [\[15\]](#page-22-8).

Each PF \mathcal{F}_{φ} determines an isometric operator $\theta_{\varphi} : \mathcal{K} \to \ell_2(\mathbb{J})$:

$$
\theta_{\varphi} f = \{ \langle \varphi_j, f \rangle \}_{j \in \mathbb{J}}, \qquad f \in \mathcal{K}, \tag{2.3}
$$

which is called an *analysis operator* associated with \mathcal{F}_{φ} .

The adjoint operator $\theta_{\varphi}^* : \ell_2(\mathbb{J}) \to \mathcal{K}$ of θ_{φ} is called a *synthesis operator* and it acts as follows

$$
\theta_{\varphi}^* \{c_j\} = \sum_{j \in \mathbb{J}} c_j \varphi_j, \qquad \{c_j\} \in \ell_2(\mathbb{J}). \tag{2.4}
$$

Let θ_{φ} and θ_{ψ} be analysis operators associated with PF's \mathcal{F}_{φ} and \mathcal{F}_{ψ} from Theorem [1.](#page-3-3) Then

$$
\ell_2(\mathbb{J}) = \mathcal{R}(\theta_{\varphi}) \oplus \mathcal{R}(\theta_{\psi}),\tag{2.5}
$$

where $\mathcal{R}(\theta_{\varphi})$ and $\mathcal{R}(\theta_{\psi})$ are the image sets of the operators θ_{φ} and θ_{ψ} , respectively.

By virtue of [\(2.4\)](#page-4-1) and [\(2.5\)](#page-4-2), for $\{c_j\} \in \ell_2(\mathbb{J})$, the following relation holds

$$
\sum_{j\in\mathbb{J}}c_j\varphi_j=0\qquad\Longleftrightarrow\qquad\{c_j\}\in\ker\theta_\varphi^*=\ell_2(\mathbb{J})\ominus\mathcal{R}(\theta_\varphi)=\mathcal{R}(\theta_\psi).
$$
\n(2.6)

 $\textbf{II.2} \quad \textbf{Operations} \ H^{min}_{\varphi \mathsf{E}} \ \textbf{and} \ H^{max}_{\varphi \mathsf{E}}.$

For a given PF $\mathcal{F}_{\varphi} = {\varphi_j, j \in \mathbb{J}}$ and a sequence of real quantities $\mathsf{E} = \{E_j, j \in \mathbb{J}\}\$, one can introduce a linear operator

$$
H_{\varphi,\mathbf{E}} = \sum_{j\in\mathbb{J}} E_j \langle \varphi_j, \cdot \rangle \varphi_j \tag{2.7}
$$

in a Hilbert space K. If $e[\mathcal{F}_{\varphi}] = 0$ (i.e., \mathcal{F}_{φ} is an ONB of K), the quantities E_j in [\(2.7\)](#page-4-3) turns out to be eigenvalues of $H_{\varphi \mathsf{E}}$. If \mathcal{F}_{φ} is a PF (but not an ONB), this fact does not hold in general (see Lemma [8](#page-8-1) below).

The operator $H_{\varphi \mathsf{E}}$ may be unbounded and its domain of definition should be specified. There are two natural domains for $H_{\varphi \mathsf{E}}$ typically used in the literature:

$$
\mathcal{D}_{min} = \{ f \in \mathcal{K} : \sum_{j \in \mathbb{J}} E_j^2 | \langle \varphi_j, f \rangle |^2 < \infty \},
$$
\n
$$
\mathcal{D}_{max} = \{ f \in \mathcal{K} : \sum_{j \in \mathbb{J}} E_j \langle \varphi_j, f \rangle \varphi_j \text{ converges unconditionally in } \mathcal{K} \}. \tag{2.8}
$$

It follows from [\[24,](#page-23-4) Theorem 7.2 (b)] that

$$
\mathcal{D}_{min} \subseteq \mathcal{D}_{max}.\tag{2.9}
$$

We observe that it may easily happen in [\(2.9\)](#page-4-4) that \mathcal{D}_{min} is indeed a proper subspaces of $\mathcal{D}_{max}.$

Example 2 Set $\mathbb{J} = \mathbb{Z} \setminus \{0\}$ and consider the quantities $E_n = n^2$, $E_{-n} = 0$ $(n \in \mathbb{N})$ and an ONB $\{e_n\}_{n\in\mathbb{N}}$ of K. In view of [\[24,](#page-23-4) Example 8.35], the set of vectors $\mathcal{F}_{\varphi} = {\varphi_j, j \in \mathbb{J}}$, where

$$
\varphi_n = \frac{1}{n} e_n, \qquad \varphi_{-n} = \sqrt{1 - \frac{1}{n^2}} e_n
$$

is a PF. In this case, the series

$$
\sum_{j\in\mathbb{J}}E_j\langle\varphi_j,f\rangle\varphi_j=\sum_{n\in\mathbb{N}}\langle e_n,f\rangle\,e_n
$$

converges unconditionally for all $f \in \mathcal{K}$. Hence, $\mathcal{D}_{max} = \mathcal{K}$. On the other hand, $\mathcal{D}_{min} =$ $\{f \in \mathcal{K} : \sum_{n \in \mathbb{N}} n^2 |\langle e_n, f \rangle|^2 < \infty\}$ is a subset of K. Therefore, $\mathcal{D}_{min} \subset \mathcal{D}_{max}$.

The specificity of frames gives rise to the following curious fact.

Proposition 3 For arbitrary unbounded set of quantities E there are uncountably many PF's \mathcal{F}_{φ} such that \mathcal{D}_{min} is trivial, i.e. $\mathcal{D}_{min} = \{0\}.$

Proof: Without loss of generality, one can assume that $\mathcal{H} = \ell^2(\mathbb{J})$, where \mathbb{J} is the countable set of indices. Let $\mathcal E$ be an operator of multiplication by the set $\mathsf E = \{E_j, j \in \mathbb J\}$ in $\ell^2(\mathbb J)$:

$$
\mathcal{E}\{c_j\} = \{E_j c_j\}, \qquad \mathcal{D}(\mathcal{E}) = \{\{c_j\} \in \ell^2(\mathbb{J}) : \{E_j c_j\} \in \ell^2(\mathbb{J})\}.
$$
 (2.10)

Since the set E is unbounded (i.e. $\sup_{j\in\mathbb{J}}\{|E_j|\}=\infty$) the self-adjoint operator $\mathcal E$ is unbounded in $\ell^2(\mathbb{J})$ and, by the extended version [\[1,](#page-21-0) Theorem 3.19] of the Schmüdgen theorem [\[31,](#page-23-6) Theorem 5.1, there are uncountably many infinite-dimensional subspaces \mathcal{K} of $\ell^2(\mathbb{J})$ such that

$$
\mathcal{D}(\mathcal{E}) \cap \mathcal{K} = \{0\}.\tag{2.11}
$$

For given K satisfying [\(2.11\)](#page-5-0) we denote by P the orthogonal projection operator in $\ell_2(\mathbb{J})$ on K and consider the canonical ONB $\{e_j, j \in \mathbb{J}\}\$ of $\ell_2(\mathbb{J})$. Then $\mathcal{F}_{\varphi} = \{\varphi_j = Pe_j, j \in \mathbb{J}\}\$ is a PF in K. The associated analysis operator θ_{φ} (see [\(2.3\)](#page-3-4)) maps K into $\ell^2(\mathbb{J})$ and

$$
\theta_{\varphi} f = \{ \langle \varphi_j, f \rangle \}_{j \in \mathbb{J}} = \{ \langle e_j, f \rangle \}_{j \in \mathbb{J}} = \{ c_j \} = f, \qquad f = \{ c_j \} \in \mathcal{K}.
$$

Therefore, $\mathcal{R}(\theta_{\varphi}) = \mathcal{K}$ and, in view of [\(2.10\)](#page-5-1), [\(2.11\)](#page-5-0), $\{E_j c_j\} \notin \ell^2(\mathbb{J})$ for non-zero $f = \{c_j\} \in$ K . This means that

$$
\sum_{j\in\mathbb{J}}E_j^2|\langle\varphi_j,f\rangle|^2=\sum_{j\in\mathbb{J}}E_j^2|\langle e_j,f\rangle|^2=\sum_{j\in\mathbb{J}}E_j^2|c_j|^2=\infty,\quad f\in\mathcal{K},\ f\neq 0
$$

and $\mathcal{D}_{min} = \{0\}.$

Of course, the choice of PF's \mathcal{F}_{φ} in Proposition [3](#page-5-2) should be very specific. Considering special classes of E and \mathcal{F}_{φ} one can guarantee that \mathcal{D}_{min} coincides with \mathcal{D}_{max} and is a dense set in K . Few simple sufficient conditions are given below.

Proposition 4 The following assertions are true:

- (i) if $\sup_{j\in\mathbb{J}}\{|E_j|\}<\infty$, then $\mathcal{D}_{min}=\mathcal{D}_{max}=\mathcal{K}$;
- (ii) if the index set \mathbb{J} of \mathcal{F}_{φ} can be decomposed $\mathbb{J} = \mathbb{J}_0 \cup \mathbb{J}_1$ in such a way that $\{\varphi_j, j \in \mathbb{J}_0\}$ is a Riesz basis in K and $\sup_{j\in\mathbb{J}_1}\{|E_j|\}<\infty$, then \mathcal{D}_{min} coincides with \mathcal{D}_{max} and is a dense set in K.

Proof: (*i*) Denote $\alpha = \sup_{j \in \mathbb{J}} \{ |E_j| \}$. Then

$$
\sum_{j\in\mathbb{J}} E_j^2 |\langle \varphi_j, f \rangle|^2 \le \alpha^2 \sum_{j\in\mathbb{J}} |\langle \varphi_j, f \rangle|^2 = \alpha^2 \|f\|^2, \qquad f \in \mathcal{K}.
$$
 (2.12)

Therefore, $\mathcal{D}_{min} = \mathcal{K}$. By virtue of [\(2.9\)](#page-4-4), $\mathcal{D}_{min} = \mathcal{D}_{max} = \mathcal{K}$.

(*ii*) Similarly to [\(2.12\)](#page-6-0), $\sum_{j\in\mathbb{J}_1} E_j^2 |\langle \varphi_j, f \rangle|^2 \leq \alpha^2 \sum_{j\in\mathbb{J}_1} |\langle \varphi_j, f \rangle|^2 \leq \alpha^2 ||f||^2$, where $\alpha =$ $\sup_{j\in\mathbb{J}_1}\{|E_j|\}$ and $f\in\mathcal{K}$. This means that the sets \mathcal{D}_{min} and \mathcal{D}_{max} defined by [\(2.8\)](#page-4-5) do not change if we consider the smaller set $\mathbb{J}_0 = \mathbb{J} \setminus \mathbb{J}_1$ instead of \mathbb{J} .

Each Riesz basis $\{\varphi_j, j \in \mathbb{J}_0\}$ is norm-bounded below (i.e., $\inf_{j\in\mathbb{J}} ||\varphi_j|| > 0$). By [\[24,](#page-23-4) Theorem 8.36] this means that $\mathcal{D}_{min} = \mathcal{D}_{max}$. Let $\{\psi_j, j \in \mathbb{J}_0\}$ be the biorthogonal Riesz basis for $\{\varphi_j, j \in \mathbb{J}_0\}$. By virtue of (2.8) , $\psi_j \in \mathcal{D}_{min}$ for all $j \in \mathbb{J}_0$. Hence, \mathcal{D}_{min} is a dense set in $\mathcal K$.

In what follows we consider a slightly more general case assuming that \mathcal{D}_{min} is dense in \mathcal{K} and $\mathcal{D}_{min} \subseteq \mathcal{D}_{max}$, so that \mathcal{D}_{max} is dense in \mathcal{K} a fortiori.

Equipping [\(2.7\)](#page-4-3) with domains \mathcal{D}_{min} and \mathcal{D}_{max} we define the following operators in K:

$$
H_{\varphi \mathsf{E}}^{\min} f = \sum_{j \in \mathbb{J}} E_j \langle \varphi_j, f \rangle \varphi_j, \qquad f \in \mathcal{D}(H_{\varphi \mathsf{E}}^{\min}) = \mathcal{D}_{\min},
$$

$$
H_{\varphi \mathsf{E}}^{\max} f = \sum_{j \in \mathbb{J}} E_j \langle \varphi_j, f \rangle \varphi_j, \qquad f \in \mathcal{D}(H_{\varphi \mathsf{E}}^{\max}) = \mathcal{D}_{\max}.
$$
 (2.13)

The operator $H_{\varphi E}^{min}$ admits a simple interpretation with the use of Naimark dilation theorem. Namely, in the Hilbert space $\mathcal{H} = \mathcal{K} \oplus \mathcal{M}$, we consider the ONB $\{h_j, j \in \mathbb{J}\}\$ defined by [\(2.2\)](#page-3-5) and define a self-adjoint Hamiltonian

$$
H_{h\mathsf{E}} = \sum_{j\in\mathbb{J}} E_j \langle h_j, \cdot \rangle h_j, \qquad \mathcal{D}(H_{h\mathsf{E}}) = \{ f \in \mathcal{H} \; : \; \sum_{j\in\mathbb{J}} E_j^2 |\langle h_j, f \rangle|^2 < \infty \}. \tag{2.14}
$$

By the construction, the set of eigenvalues of H_{hE} coincides with $E = \{E_i\}$ and the corresponding eigenfunctions are $\{h_j\}$. Comparing [\(2.13\)](#page-6-1) and [\(2.14\)](#page-6-2) we arrive at the conclusion that

$$
H_{\varphi \mathsf{E}}^{min} f = P_{\mathcal{K}} H_{h \mathsf{E}} f, \qquad f \in \mathcal{D}(H_{\varphi \mathsf{E}}^{min}) = \mathcal{D}_{min} = \mathcal{D}(H_{h \mathsf{E}}) \cap \mathcal{K}.
$$
 (2.15)

Therefore, the operator $H_{\varphi \in \mathcal{L}}^{min}$ may be interpreted as the restriction of the Hamiltonian $H_{h \in \mathcal{L}}$ acting in $\mathcal{H} = \mathcal{K} \oplus \mathcal{M}$ to the physical space $\mathcal{H}_{ph} = \mathcal{K}$, see [\(1.2\)](#page-2-0).

It follows from [\(2.9\)](#page-4-4) that

$$
H_{\varphi \mathsf{E}}^{\min} \subseteq H_{\varphi \mathsf{E}}^{\max}.\tag{2.16}
$$

The densely defined operator $H_{\varphi \mathsf{E}}^{max}$ is symmetric in K since

$$
\langle H_{\varphi \mathsf{E}}^{max} f, f \rangle = \sum_{j \in \mathbb{J}} E_j |\langle \varphi_j, f \rangle|^2, \qquad f \in \mathcal{D}(H_{\varphi \mathsf{E}}^{max})
$$

is real-valued. The same is true for $H_{\varphi \mathsf{E}}^{min}$ since [\(2.16\)](#page-7-0) holds.

Corollary 5 If $H_{\varphi \in}^{min}$ is self-adjoint in K, then $H_{\varphi \in}^{max}$ is also self-adjoint and $H_{\varphi \in}^{min} = H_{\varphi \in}^{max}$. Proof: It follows immediately from the relation

$$
H_{\varphi \mathsf{E}}^{min} \subseteq H_{\varphi \mathsf{E}}^{max} \subseteq (H_{\varphi \mathsf{E}}^{max})^* \subseteq (H_{\varphi \mathsf{E}}^{min})^* = H_{\varphi \mathsf{E}}^{min}.
$$

Using Proposition [4,](#page-5-3) it is easy to derive sufficient conditions for self-adjointness of $H_{\varphi \mathsf{E}}^{min}$.

Corollary 6 The following assertions are true:

- (i) if $\sup_{j\in\mathbb{J}}\{|E_j|\}<\infty$, then $H_{\varphi_{\mathsf{E}}}^{min}$ is a bounded self-adjoint operator in K;
- (ii) if $\sup_{j\in\mathbb{J}}\{|E_j|\}=\infty$ and the index set \mathbb{J} of \mathcal{F}_{φ} can be decomposed $\mathbb{J}=\mathbb{J}_0\cup\mathbb{J}_1$ in such a way that $\{\varphi_j, j \in \mathbb{J}_0\}$ is a Riesz basis in K and $\sup_{j \in \mathbb{J}_1} \{|E_j|\} < \infty$, then $H_{\varphi_{\mathsf{E}}}^{min}$ is an unbounded self-adjoint operator in K .

Proof: (i). By Proposition [4](#page-5-3) and [\(2.13\)](#page-6-1), the symmetric operator $H_{\varphi_{\mathsf{E}}}^{min}$ is defined on the whole space \mathcal{K} . Hence, $H_{\varphi_{\mathsf{E}}}^{min}$ is a bounded self-adjoint operator.

(*ii*). By employing Proposition [4](#page-5-3) once again, one gets that $H_{\varphi \mathsf{E}}^{min}$ is a densely defined operator in K. For $f \in \mathcal{D}(H_{\varphi \mathsf{E}})$ we decompose

$$
H_{\varphi} = \sum_{j \in \mathbb{J}_0} E_j \langle \varphi_j, f \rangle \varphi_j + \sum_{j \in \mathbb{J}_1} E_j \langle \varphi_j, f \rangle \varphi_j, \tag{2.17}
$$

where $\mathcal{F}_{\varphi}^0 = {\varphi_j, j \in \mathbb{J}_0}$ is a Riesz basis in K and $\sup_{j \in \mathbb{J}_1} { |E_j| } < \infty$.

Denote by $S_0 = \sum_{j\in\mathbb{J}_0} \langle \varphi_j, \cdot \rangle \varphi_j$ the frame operator of the Riesz basis \mathcal{F}^0_{φ} . Then [\[17,](#page-23-3) Theorem 6.1.1]

$$
\varphi_j = S_0^{1/2} e_j, \quad j \in \mathbb{J}_0,
$$

where $\{e_j, j \in \mathbb{J}_0\}$ is an ONB of K. Therefore, the first operator in [\(2.17\)](#page-7-1),

$$
A_0 = \sum_{j \in \mathbb{J}_0} E_j \langle \varphi_j, \cdot \rangle \varphi_j, \quad \mathcal{D}(A_0) = \{ f \in \mathcal{K} \; : \; \sum_{j \in \mathbb{J}_0} E_j^2 | \langle \varphi_j, f \rangle |^2 < \infty \}
$$

can be rewritten as follows

$$
A_0 = S_0^{1/2} H_{eE_0} S_0^{1/2}, \qquad H_{eE_0} = \sum_{j \in \mathbb{J}_0} E_j \langle e_j, \cdot \rangle e_j, \quad \mathsf{E}_0 = \{ E_j, j \in \mathbb{J}_0 \}. \tag{2.18}
$$

By the construction, the operator H_{eE_0} with the domain

$$
\mathcal{D}(H_{eE_0}) = \{f \in \mathcal{K} : \sum_{j \in \mathbb{J}_0} E_j^2 |\langle e_j, f \rangle|^2 < \infty \}
$$

is self-adjoint in K. In view of [\(2.18\)](#page-8-2), $\mathcal{D}(H_{eE_0}) = S_0^{1/2} \mathcal{D}(A_0)$ and

$$
\langle A_0 f, g \rangle = \langle H_{eE_0} S_0^{1/2} f, S_0^{1/2} g \rangle, \qquad f, g \in \mathcal{D}(A_0). \tag{2.19}
$$

Relation [\(2.19\)](#page-8-3) means that A_0 is self-adjoint. Moreover, as follows from the proof of Propo-sition [4,](#page-5-3) $\mathcal{D}(A_0) = \{f \in \mathcal{K} : \sum_{j \in \mathbb{J}_0} E_j^2 |\langle \varphi_j, f \rangle|^2 < \infty \} = \mathcal{D}_{min} = \mathcal{D}(H_{\varphi \mathsf{E}}^{min}).$

On the other hand,

$$
\sum_{j\in\mathbb{J}_1} E_j^2 |\langle \varphi_j, f \rangle|^2 \leq \alpha^2 \sum_{j\in\mathbb{J}_1} |\langle \varphi_j, f \rangle|^2 < \alpha^2 \|f\|^2, \quad f \in \mathcal{K}, \quad \alpha = \sup_{j\in\mathbb{J}_1} \{|E_j|\}.
$$

This means (see, e.g., [\[24,](#page-23-4) Theorem 7.2]) that the second operator in (2.17)

$$
A_1 = \sum_{j \in \mathbb{J}_1} E_j \langle \varphi_j, \cdot \rangle \varphi_j
$$

is defined on K and it is symmetric (since $\langle A_1 f, f \rangle = \sum_{j \in J_1} E_j |\langle \varphi_j, f \rangle|^2$ is real-valued for $f \in \mathcal{K}$). Hence, A_1 is a bounded self-adjoint operator in \mathcal{K} . This means that the operator $H_{\varphi \mathsf{E}} = A_0 + A_1$ with the domain $\mathcal{D}(A_0) = \mathcal{D}(H_{\varphi \mathsf{E}}^{min})$ is self-adjoint.

Remark 7 Similar results (in the case where \mathcal{F}_{φ} involves a Riesz basis) can be obtained by the perturbation theory methods if the operator A_1 is sufficiently small with respect to the self-adjoint operator A_0 (see, e.g., [\[29,](#page-23-7) X.2]).

II.3 Spectrum of $H_{\varphi E}$.

In what follows, we suppose that $H_{\varphi \in}^{min}$ is a self-adjoint operator in K. In this case, in view of Corollary [5,](#page-7-2) $H_{\varphi \mathsf{E}} := H_{\varphi \mathsf{E}}^{min} = H_{\varphi \mathsf{E}}^{max}$ is a self-adjoint operator.

We consider $H_{\varphi E}$ as a Hamiltonian generated by the pair $(\mathcal{F}_{\varphi}, E)$ of a PF \mathcal{F}_{φ} and a set of real numbers E. As was mentioned above, the Hamiltonian $H_{\varphi \mathsf{E}}$ is the restriction to the physical space K of the Hamiltonian $H_{h\text{E}}$ (see [\(2.14\)](#page-6-2)) acting in the wider Hilbert space $\mathcal{H} = \mathcal{K} \oplus \mathcal{M}$. By virtue of [\(2.14\)](#page-6-2), the point spectrum of H_{hE} coincides with the set E and $H_{h\mathsf{E}}h_n = E_n h_n \quad (n \in \mathbb{J})$. On the other hand:

Lemma 8 The following assertions are equivalent:

- (i) the relation $H_{\varphi \in \varphi_n} = E_n \varphi_n$ holds for some $E_n \in \mathsf{E}$;
- (ii) the vectors of the PF \mathcal{F}_{ψ} in Theorem [1](#page-3-3) satisfy the following conditions:

$$
\sum_{j\in\mathbb{J}} E_j^2 |\langle \psi_j, \psi_n \rangle|^2 < \infty, \qquad \sum_{j\in\mathbb{J}} E_j \langle \psi_j, \psi_n \rangle \varphi_j = 0 \tag{2.20}
$$

Proof: (i) \rightarrow (ii). If $H_{\varphi \in \varphi_n} = E_n \varphi_n$, then $\varphi_n \in \mathcal{D}(H_{\varphi \in}) \cap \mathcal{D}(H_{h \in})$ (see [\(2.15\)](#page-6-3)). This means that the vector ψ_n corresponding to φ_n in [\(2.2\)](#page-3-5) also belongs to $\mathcal{D}(H_{h\mathsf{E}})$. Therefore, $\sum_{j\in\mathbb{J}}E_j^2|\langle\psi_j,\psi_n\rangle|^2 = \sum_{j\in\mathbb{J}}E_j^2|\langle h_j,\psi_n\rangle|^2 < \infty$. Further, the relation $H_{h\mathsf{E}}h_n = E_nh_n$ means that $P_{\mathcal{K}}H_{h\mathsf{E}}h_n = E_j\varphi_n$. Taking [\(2.2\)](#page-3-5) and [\(2.14\)](#page-6-2) into account, one gets

$$
0 = P_K H_{hE} h_n - H_{\varphi E} \varphi_n = \sum_{j \in \mathbb{J}} E_j \langle h_j, h_n \rangle \varphi_j - \sum_{j \in \mathbb{J}} E_j \langle \varphi_j, \varphi_n \rangle \varphi_j = \sum_{j \in \mathbb{J}} E_j \langle \psi_j, \psi_n \rangle \varphi_j \quad (2.21)
$$

that establishes [\(2.20\)](#page-9-0).

 $(ii) \rightarrow (i)$. The first part in [\(2.20\)](#page-9-0) and [\(2.14\)](#page-6-2) mean that $\psi_n \in \mathcal{D}(H_{h\mathsf{E}})$. Hence, $\varphi_n =$ $h_n - \psi_n$ belongs to $\mathcal{D}(H_{\varphi \mathsf{E}}) \cap \mathcal{D}(H_{h\mathsf{E}})$. Reasoning similarly to [\(2.21\)](#page-9-1), we obtain

$$
0 = \sum_{j \in \mathbb{J}} E_j \langle \psi_j, \psi_n \rangle \varphi_j = P_K H_{h \mathsf{E}} h_n - H_{\varphi \mathsf{E}} \varphi_n = E_n P_K h_n - H_{\varphi \mathsf{E}} \varphi_n = E_n \varphi_n - H_{\varphi \mathsf{E}} \varphi_n
$$

that completes the proof. \Box

If $\|\varphi_n\|=1$, then $\psi_n=0$ and the conditions [\(2.20\)](#page-9-0) are clearly satisfied. In such case, E_n turns out to be an eigenvalue of $H_{\varphi E}$.

Lemma [8](#page-8-1) shows that the set E not always coincides with the point spectrum of $H_{\varphi E}$. For this reason, we will say that E is a set of *quasi-eigenvalues* of $H_{\varphi E}$.

Since $H_{\varphi \mathsf{E}}$ is assumed to be self-adjoint, one may believe that $H_{\varphi \mathsf{E}}$ can also be presented in a form similar to [\(2.14\)](#page-6-2):

$$
H_{\varphi \mathsf{E}} = \sum_{j \in \mathbb{J}} E'_j \langle e'_j, \cdot \rangle e'_j, \qquad \mathcal{D}(H_{\varphi \mathsf{E}}) = \{ f \in \mathcal{K} \; : \; \sum_{j \in \mathbb{J}} E'^2_j |\langle e'_j, f \rangle|^2 < \infty \},\tag{2.22}
$$

where $\mathcal{F}_{e'} = \{e'_j \in \mathcal{K}, j \in \mathbb{J}\}\$ is an ONB of \mathcal{K} and $\mathsf{E'} = \{E'_j, j \in \mathbb{J}\}\$ is a set of real numbers. The formula [\(2.22\)](#page-9-2) is more convenient for spectral analysis because it immediately gives the set E' of eigenvalues of $H_{\varphi E}$. This means, according what proposed in [\[9\]](#page-22-0) for bounded operators, that $(\mathcal{F}_{\varphi}, \mathsf{E})$ is E-connected to $\mathcal{F}_{e'}$. Indeed, under the assumptions here, $H_{\varphi \mathsf{E}} = \sum_{j\in \mathbb{J}} E_j \langle \varphi_j, \cdot \rangle \varphi_j = \sum_{j\in \mathbb{J}} E'_j \langle e'_j, \cdot \rangle e'_j.$

We recall before formulating the next statement that the PF \mathcal{F}_{φ} can be extended to an ONB \mathcal{F}_h in $\mathcal{H} = \mathcal{K} \oplus \mathcal{M}$ by adding a complementary PF \mathcal{F}_ψ of \mathcal{M} (as in Theorem [1\)](#page-3-3).

Theorem 9 Let $H_{\varphi \mathsf{E}}$ be a Hamiltonian generated by the pair $(\mathcal{F}_{\varphi}, \mathsf{E})$, where $\mathsf{E} = \{E_j, j \in \mathbb{J}\}\$ is a strictly increasing sequence $\ldots < E_j < E_{j+1} \ldots$ and let the operator

$$
B = \sum_{j \in \mathbb{J}} E_j \langle \varphi_j, \cdot \rangle \psi_j \; : \; \mathcal{K} \to \mathcal{M} \tag{2.23}
$$

be bounded. Then $H_{\varphi \mathsf{E}}$ has the form [\(2.22\)](#page-9-2) and its discrete spectrum $\sigma_{disc}(H_{\varphi \mathsf{E}})$ coincides with E' .

Proof: We can assume, without loss of generality, that $\mathbb{J} = \mathbb{N}$. Since $\mathsf{E} = \{E_j, j \in \mathbb{N}\}$ is strictly increasing, there exists $\lambda = \lim_{j \to \infty} E_j$. When λ is less than infinity, E is a bounded set, and the condition of boundedness of B in (2.23) is automatically fulfilled. Moreover the self-adjoint operator

$$
\lambda I - H_{hE} = \sum_{j \in \mathbb{N}} (\lambda - E_j) \langle h_j, \cdot \rangle h_j,
$$

where H_{hE} is defined by [\(2.14\)](#page-6-2), is positive, bounded and compact^{[1](#page-10-1)} in H . The same properties hold true for the operator $\lambda I - H_{\varphi E} = P_{\mathcal{K}}(\lambda I - H_{hE})P_{\mathcal{K}}$ acting in \mathcal{K} . Therefore, there exists an ONB $\{e'_j\}_{j\in\mathbb{N}}$ of K formed by eigenvectors e'_j :

$$
(\lambda I - H_{\varphi \mathsf{E}})e_j' = \mu_j e_j', \qquad j \in \mathbb{N}, \tag{2.24}
$$

corresponding to the decreasing sequence of eigenvalues μ_j . The set $\{\mu_j\}_{j\in\mathbb{N}}$ constitutes the discrete spectrum of $\lambda I - H_{\varphi E}$. It follows from [\(2.24\)](#page-10-2) that $H_{\varphi E}e'_{j} = (\lambda - \mu_{j})e'_{j}$. Therefore, the bounded operator $H_{\varphi \mathsf{E}}$ can be defined by [\(2.22\)](#page-9-2) with $E'_j = \lambda - \mu_j$ and its discrete spectrum $\sigma_{disc}(H_{\varphi \mathsf{E}})$ coincides with $\mathsf{E}' = \{E'_j = \lambda - \mu_j, \ j \in \mathbb{N}\}.$

Assume now that $\lambda = \lim_{j \to \infty} E_j = \infty$. Then the operators $H_{h\mathsf{E}}$ and $H_{\varphi\mathsf{E}}$ are both semi-bounded from below, and they are interconnected through the relation [\(2.15\)](#page-6-3). The operator H_{hE} has a compact resolvent (since its eigenvectors $\{h_j\}$ form an ONB of $\mathcal H$ and the corresponding eigenvalues ${E_j}$ are an increasing sequence tending to ∞). In this case, by means of [\[30,](#page-23-8) Theorem XIII.64], the set

$$
Y_{bH_{h\mathsf{E}}} = \{ f \in \mathcal{D}(H_{h\mathsf{E}}) : ||f|| \leq 1, ||H_{h\mathsf{E}}f|| \leq b \},
$$

is compact in H for every $b \geq 0$. Consider the similar set associated with $H_{\varphi E}$

$$
Y_{bH_{\varphi E}} = \{ f \in \mathcal{D}(H_{\varphi E}) : ||f|| \le 1, ||H_{\varphi E}f|| \le b \}.
$$

In view of [\(2.15\)](#page-6-3) and [\(2.23\)](#page-10-0), for all $f \in Y_{bH_{\varphi E}},$

$$
P_{\mathcal{M}}H_{h\mathsf{E}}f = P_{\mathcal{M}}\sum_{j\in\mathbb{N}}E_j\langle h_j, f\rangle h_j = \sum_{j\in\mathbb{N}}E_j\langle\varphi_j, f\rangle\psi_j = Bf,
$$

¹compactness follows from [\[21,](#page-23-9) problem 132] since $\lim_{j\to\infty} (\lambda - E_j) = 0$.

where P_M is the orthogonal projection operator on M in H. Furthermore,

$$
||H_{h\mathsf{E}}f||^2 = ||P_{\mathcal{K}}H_{h\mathsf{E}}f||^2 + ||P_{\mathcal{M}}H_{h\mathsf{E}}f||^2 = ||H_{\varphi\mathsf{E}}f||^2 + ||Bf||^2 \le b^2 + c^2, \quad f \in Y_{bH_{\varphi\mathsf{E}}}, \tag{2.25}
$$

where $c = \sup_{f \in Y_{bH_{\varphi E}}} ||Bf|| \le ||B|| < \infty$. Therefore,

$$
Y_{bH_{\varphi\mathsf{E}}} \subset Y_{\sqrt{b^2 + c^2}H_{h\mathsf{E}}}.\tag{2.26}
$$

Consider a convergent sequence $\{f_n\}$ in K, where $f_n \in Y_{bH_{\varphi_{\mathsf{E}}}}$ and denote $f = \lim f_n$. Obviously, $f \in \mathcal{K}$ and $||f|| \leq 1$. Moreover, $f \in Y_{\sqrt{b^2+c^2}H_{h\mathsf{E}}}$ by virtue of [\(2.26\)](#page-11-0) and the compactness of $Y_{\sqrt{b^2+c^2}H_{h\mathsf{E}}}\$. This means that $f \in \mathcal{D}(H_{h\mathsf{E}}) \cap \mathcal{K} = \mathcal{D}(H_{\varphi\mathsf{E}})$. Assume that $||H_{\varphi E}f|| > b$, i.e. $||H_{\varphi E}f||^2 = b^2 + \varepsilon \ (\varepsilon > 0)$. By virtue of (2.25) , $||Bf||^2 \leq c^2 - \varepsilon$ that contradicts to the definition of c. Hence, $||H_{\varphi E}f|| \leq b$ and $f \in Y_{bH_{\varphi E}}$. We verify that $Y_{bH_{\varphi E}}$ is a closed set in K. This fact, the compactness of $Y_{bH_{hE}}$, and [\(2.26\)](#page-11-0) mean that $Y_{bH_{\varphi E}}$ is a compact set in K for each $b \ge 0$. Applying again [\[30,](#page-23-8) Theorem XIII.64] we obtain that $H_{\varphi \in}$ has a compact resolvent in K. This means that formula [\(2.22\)](#page-9-2) holds, the spectrum of $H_{\varphi E}$ is discrete^{[2](#page-11-2)} and it coincides with E' . ✷

Remark 10 The statement in Theorem [9](#page-9-3) can be readily extended to cover the scenario of an increasing sequence $\ldots \leq E_j \leq E_{j+1} \leq \ldots$ provided that eigenvalues have finite multiplicities.

Theorem [9](#page-9-3) establishes a sufficient condition for the existence of the discrete spectrum of $H_{\varphi E}$ without the need for explicit construction. The Min-Max principle [\[32,](#page-23-10) p. 265] can be utilized to compute the eigenvalues. Additionally, an alternative method is presented below, which is specifically tailored to the properties of operators $H_{\varphi E}$.

Proposition 11 Let $H_{\varphi \in \mathcal{E}}$ be a Hamiltonian generated by the pair $(\mathcal{F}_{\varphi}, \mathsf{E})$ and let $\mathcal{R}(\theta_{\varphi})$ be the image set of the analysis operator θ_{φ} associated with \mathcal{F}_{φ} (see [\(2.3\)](#page-3-4)). Then $\mu \in \sigma_p(H_{\varphi \mathsf{E}})$ if and only if there exists a sequence ${c_i} \in \mathcal{R}(\theta_\varphi)$ such that

$$
\{(E_j - \mu)c_j\} \in \ell_2(\mathbb{J}) \ominus \mathcal{R}(\theta_\varphi) = \mathcal{R}(\theta_\psi). \tag{2.27}
$$

The corresponding eigenvector of $H_{\varphi \mathsf{E}}$ coincides with $f = \sum_{j\in \mathbb{J}} c_j \varphi_j$.

Proof: Assume that $H_{\varphi \in} f = \mu f$ for some $f \in \mathcal{D}(H_{\varphi \in})$. Since \mathcal{F}_{φ} is a PF, $f = \sum_{j \in \mathbb{J}} \langle \varphi_j, f \rangle \varphi_j$ and the relation $H_{\varphi \in \mathcal{F}} = \mu \mathcal{F}$ takes the form

$$
\sum_{j \in \mathbb{J}} (E_j - \mu) \langle \varphi_j, f \rangle \varphi_j = \sum_{j \in \mathbb{J}} (E_j - \mu) c_j \varphi_j = 0, \qquad c_j = \langle \varphi_j, f \rangle.
$$
 (2.28)

²The spectrum of $H_{\varphi \mathsf{E}}$ is discrete and coincides with E' for $\lambda = \infty$. However, for finite λ , the spectrum of $H_{\varphi \mathsf{E}}$ includes both its discrete spectrum part E' and the point of essential spectrum λ .

In view of (2.3) , $\theta_{\varphi}f = \{c_j\}$, i.e., the sequence $\{c_j\}$ belongs to $\mathcal{R}(\theta_{\varphi})$. Moreover, $\{E_j c_j\} \in$ $\ell_2(\mathbb{J})$ since $f \in \mathcal{D}(H_{\varphi \mathsf{E}})$. Combining [\(2.6\)](#page-4-6) with [\(2.28\)](#page-11-3) we obtain [\(2.27\)](#page-11-4).

Conversely, if [\(2.27\)](#page-11-4) holds, then $\{(E_j - \mu)c_j\} \in \ell_2(\mathbb{J})$ and $\sum_{j\in\mathbb{J}}(E_j - \mu)c_j\varphi_j = 0$, by virtue of [\(2.6\)](#page-4-6). The sequence $\{c_j\} \in \mathcal{R}(\theta_\varphi)$ determines a vector $f = \sum_{j\in\mathbb{J}} c_j \varphi_j \in \mathcal{K}$, where $c_j = \langle \varphi_j, f \rangle$. It follows from (2.27) that $\{E_j(\varphi_j, f) \} \in \ell_2(\mathbb{J})$. This means that $f \in \mathcal{D}(H_{\varphi E})$ and the relation $\sum_{j\in J} (E_j - \mu)c_j\varphi_j = \sum_{j\in J} (E_j - \mu)\langle \varphi_j, f \rangle \varphi_j = 0$ is equivalent to $H_{\varphi \in} f - \mu f = 0.$ \Box

Typically, a PF $\mathcal{F}_{\varphi} = \{\varphi_j, j \in \mathbb{J}\}\$ comprises a Riesz basis component $\mathcal{F}_{\varphi}^0 = \{\varphi_j, j \in \mathbb{J}_0\}\$ $(\mathbb{J}_0 \subset \mathbb{J})$. This is especially true when \mathcal{F}_{φ} has finite excess. In this case, the Hamiltonian $H_{\varphi \mathsf{E}}$ generated by the pair $(\mathcal{F}_{\varphi}, \mathsf{E})$ can be decomposed:

$$
H_{\varphi \mathsf{E}} = A_0 + A_1, \qquad A_i = \sum_{j \in \mathbb{J}_i} E_j \langle \varphi_j, \cdot \rangle \varphi_j. \tag{2.29}
$$

An additional analysis leads to the following:

Proposition 12 Assume that a PF $\mathcal{F}_{\varphi} = {\varphi_j, j \in \mathbb{J}}$ can be decomposed $\mathcal{F}_{\varphi} = \mathcal{F}_{\varphi}^0 \cup \mathcal{F}_{\varphi}^1$ in such a way that $\mathcal{F}_{\varphi}^0 = {\varphi_j, j \in \mathbb{J}_0}$ and $\mathcal{F}_{\varphi}^1 = {\varphi_j, j \in \mathbb{J}_1}$ are, respectively, a Riesz basis and a frame sequence in K. Denote by S_0 the frame operator for \mathcal{F}_{φ}^0 and suppose that $\sup_{j\in\mathbb{J}_1}\{|E_j|\}<\infty$. Then, for all $f\in\mathcal{D}(H_{\varphi\mathsf{E}})$,

$$
H_{\varphi E}f = S_0^{1/2} H_{eE_0} S_0^{1/2} f + (I - S_0)^{1/2} H_{eE_1} (I - S_0)^{1/2} f \tag{2.30}
$$

where the self-adjoint operator $H_{e_{\text{E}_0}}$ is defined by [\(2.18\)](#page-8-2), the set $\{e_j, j \in \mathbb{J}_1\}$ is a PF of the subspace $\mathcal{K}_1 = \overline{\text{span }\mathcal{F}^1_\varphi} = \mathcal{R}(I - S_0)$, and $H_{e_{\text{E}_1}} = \sum_{j \in \mathbb{J}_1} E_j \langle e_j, \cdot \rangle e_j$ is a bounded self-adjoint *operator in* K_1 .

Proof: It follows from the proof of Corollary [6](#page-7-3) that the operator A_0 in [\(2.29\)](#page-12-0) coincides with $S_0^{1/2} H_{e \mathsf{E}_0} S_0^{1/2}$ $_{0}^{1/2}$, where H_{eE0} is defined by [\(2.18\)](#page-8-2).

The operator $I - S_0$ is nonnegative in K since

$$
((I - S_0)f, f) = ||f||^2 - \sum_{j \in \mathbb{J}_0} |\langle \varphi_j, f \rangle|^2 = \sum_{j \in \mathbb{J}_1} |\langle \varphi_j, f \rangle|^2 \ge 0, \quad f \in \mathcal{K}.
$$
 (2.31)

This means that the square root $(I - S_0)^{1/2}$ exists. Further, the relation [\(2.31\)](#page-12-1) implies that

$$
\ker(I - S_0) = \mathcal{K} \ominus \mathcal{K}_1, \qquad \mathcal{K}_1 = \overline{\text{span }\mathcal{F}^1_{\varphi}}.
$$

Hence, \mathcal{K}_1 coincides with $\overline{\mathcal{R}(I-S_0)}$ and it is a reducing subspace for $I-S_0$. Denote by $(I - S_0)|_{\mathcal{K}_1}$ the restriction of $I - S_0$ onto \mathcal{K}_1 . The relation

$$
(I - S_0)f = \sum_{j \in \mathbb{J}} \langle \varphi_j, f \rangle \varphi_j - \sum_{j \in \mathbb{J}_0} \langle \varphi_j, f \rangle \varphi_j = \sum_{j \in \mathbb{J}_1} \langle \varphi_j, f \rangle \varphi_j, \quad f \in \mathcal{K}_1
$$

implies that $(I - S_0)|_{\mathcal{K}_1}$ is a frame operator of the frame \mathcal{F}^1_φ in the Hilbert space \mathcal{K}_1 . Hence, the inverse operator $((I - S_0)_{K_1})^{-1} : K_1 \to K_1$ is bounded and $\overline{\mathcal{R}(I - S_0)} = \mathcal{R}(I - S_0)$.

It follows from [\[17,](#page-23-3) Theorem 6.1.1] that the elements $\varphi_j \in \mathcal{F}^1_{\varphi}$ have the form

$$
\varphi_j = (I - S_0)^{1/2} e_j, \qquad j \in \mathbb{J}_1,
$$

where $\{e_j, j \in \mathbb{J}_1\}$ is a PF of \mathcal{K}_1 . Moreover, repeating the proof of the relation [\(2.18\)](#page-8-2) for the case of operator A_1 acting in \mathcal{K}_1 we get $A_1 = (I - S_0)^{1/2} H_{eE_1} (I - S_0)^{1/2}$. Here, the operator H_{eE_1} is bounded self-adjoint in \mathcal{K}_1 due to the part (i) of Corollary [6.](#page-7-3)

Considering $H_{\varphi \mathsf{E}}$ as a perturbation of A_0 by A_1 and supposing that A_1 is sufficiently small with respect to A_0 one can expect the coincidence of essential spectra of $H_{\varphi \mathsf{E}}$ and A_0 . For example, If \mathcal{F}_{φ} has a finite excess, then $I - S_0$ is a compact operator, and therefore the second operator in (2.30) is also compact. In such a case, the classical Weyl theorem [\[32,](#page-23-10) p. 182] implies that $\sigma_{ess}(H_{\varphi E}) = \sigma_{ess}(A_0 + A_1) = \sigma_{ess}(A_0)$.

III Examples

This section is devoted to a detailed analysis of two examples of our previous results, with some preliminary applications to quantum mechanics.

III.1 Hamiltonians generated by the Casazza-Christensen frame

In general, a PF with infinite excess may not contain a Riesz basis as a subset. If a subsequence of the frame elements is allowed to converge to 0 in norm, then it is easy to construct a frame that does not contain a Riesz basis. However, answering a similar question for frames that are norm-bounded below is much more complicated. An example of such a PF that is norm-bounded below, but does not contain a Schauder basis, was first constructed by Casazza and Christensen [\[15\]](#page-22-8). Our aim now is to investigate Hamiltonians generated by that PF and discuss their possible physical applications.

Let \mathcal{K}_n $(n \in \mathbb{N})$ be a *n*-dimensional Hilbert space with ONB $\{e_1^{(n)}\}$ $\binom{n}{1}, e_2^{(n)}$ ${n \choose 2}, \ldots e_n^{(n)}\}$. Then the set $\mathcal{F}_{\varphi}^{(n)} = {\{\varphi_j^{(n)}\}}$ $\{S_j^{(n)}, j \in \mathbb{J}_n\}$ where $\mathbb{J}_n = \{1, 2, ..., n, n + 1\}$ and

$$
\varphi_j^{(n)} = e_j^{(n)} - \frac{1}{n} \sum_{i=1}^n e_i^{(n)}, \quad 1 \le j \le n, \qquad \varphi_{n+1}^{(n)} = \frac{1}{\sqrt{n}} \sum_{i=1}^n e_i^{(n)}, \tag{3.1}
$$

is a PF for \mathcal{K}_n [\[17,](#page-23-3) Lemma 7.5.1]. The operator

$$
H_{\varphi_n \mathsf{E}_n} = \sum_{j \in \mathbb{J}_n} E_j^{(n)} \langle \varphi_j^{(n)}, \cdot \rangle \varphi_j^{(n)} = \sum_{j=1}^{n+1} E_j^{(n)} \langle \varphi_j^{(n)}, \cdot \rangle \varphi_j^{(n)}, \qquad \mathsf{E}_n = \{ E_j^{(n)}, j \in \mathbb{J}_n \}.
$$
 (3.2)

is a bounded self-adjoint operator in \mathcal{K}_n .

For the PF $\mathcal{F}_{\varphi}^{(n)}$, the complementary Hilbert space \mathcal{M}_n can be chosen as $\mathbb C$ and the complementary PF $\mathcal{F}_{\psi}^{(n)} = {\{\psi_j^{(n)}\}}$ ${j^{(n)}, j \in \mathbb{J}_n}$ in [\(2.2\)](#page-3-5) has the form [\[25\]](#page-23-11):

$$
\psi_j^{(n)} = \frac{1}{\sqrt{n}}, \quad j = 1, \dots n, \qquad \psi_{n+1}^{(n)} = 0.
$$
\n(3.3)

Consider the direct sum $\mathcal{K} = (\sum_{n=1}^{\infty} \oplus \mathcal{K}_n)_{\ell_2}$. The Hilbert space $\mathcal K$ consists of sequences $f = (f_1, f_2, \ldots)$ for which^{[3](#page-14-0)} $f_n \in \mathcal{K}_n$ and $\sum_{n=1}^{\infty} ||f_n||_{\mathcal{K}_n}^2 < \infty$. The scalar product in \mathcal{K} is defined as follows

$$
\langle f, g \rangle = \sum_{n=1}^{\infty} \langle f_n, g_n \rangle_{\mathcal{K}_n}, \qquad f, g \in \mathcal{K}.
$$

Since $\mathcal{K} = \left(\sum_{n=1}^{\infty} \oplus \mathcal{K}_n\right)_{\ell_2}$, the union of PF's $\mathcal{F}_{\varphi} = \bigcup_{n=1}^{\infty} \mathcal{F}_{\varphi}^{(n)}$ is a PF for \mathcal{K} [\[17,](#page-23-3) Theorem 7.5.2]. The complementary Hilbert space $\mathcal M$ in Theorem [1](#page-3-3) for the PF $\mathcal F_\varphi$ can be chosen as the direct sum

$$
\mathcal{M} = \left(\sum_{n=1}^{\infty} \oplus \mathcal{M}_n\right)_{\ell_2} = \left(\sum_{n=1}^{\infty} \oplus \mathbb{C}\right)_{\ell_2} = \ell_2(\mathbb{N}).
$$

The PF \mathcal{F}_{ψ} in M coincides with the union of PF's: $\mathcal{F}_{\psi} = \bigcup_{n=1}^{\infty} \mathcal{F}_{\psi}^{(n)}$ $\stackrel{\cdot(n)}{\psi}$.

Denote

$$
\mathsf{E} = \bigcup_{n=1}^{\infty} \mathsf{E}_n = \{ E_j^{(n)}, \ n \in \mathbb{N}, \ 1 \le j \le n+1 \}.
$$

For the PF \mathcal{F}_{φ} and **E** we consider the operator $H_{\varphi \mathsf{E}}^{min}: \mathcal{K} \to \mathcal{K}$ defined by [\(2.13\)](#page-6-1).

$$
H_{\varphi \mathsf{E}}^{\min} = \sum_{n=1}^{\infty} \sum_{j=1}^{n+1} E_j^{(n)} \langle \varphi_j^{(n)}, \cdot \rangle \varphi_j^{(n)}, \quad \mathcal{D}(H_{\varphi \mathsf{E}}^{\min}) = \{ f \in \mathcal{K} \; : \; \sum_{n=1}^{\infty} \sum_{j=1}^{n+1} (E_j^{(n)})^2 | \langle \varphi_j^{(n)}, f \rangle |^2 < \infty \}.
$$

Taking into account the decomposition $\mathcal{K} = (\sum_{n=1}^{\infty} \bigoplus \mathcal{K}_n)_{\ell_2}$ and (3.2) one can rewrite the last formulas as follows

$$
H_{\varphi \mathsf{E}}^{min} = \sum_{n=1}^{\infty} \oplus H_{\varphi_n \mathsf{E}_n}, \qquad \mathcal{D}(H_{\varphi_n \mathsf{E}_n}^{min}) = \{ f \in \mathcal{K} \; : \; \sum_{n=1}^{\infty} \| H_{\varphi_n \mathsf{E}_n} \|_{\mathcal{K}_n}^2 < \infty \}.
$$

The obtained formula means that $H_{\varphi \mathsf{E}}^{min}$ is self-adjoint in K (since $H_{\varphi_n \mathsf{E}_n}$ are bounded selfadjoint operators in \mathcal{K}_n for all $n \in \mathbb{N}$). By Corollary [5,](#page-7-2) $H_{\varphi \mathsf{E}} := H_{\varphi \mathsf{E}}^{min} = H_{\varphi \mathsf{E}}^{max}$ is a Hamiltonian generated by the pair $(\mathcal{F}_{\varphi}, \mathsf{E}).$

³we identify elements of \mathcal{K}_n with their counterpart in \mathcal{K} , i.e., we do not distinguish between $f \in \mathcal{K}_n$ and the sequence in K having f in the *n*-th entry and otherwise zero.

As the PF \mathcal{F}_{φ} does not contain a Riesz basis [\[15\]](#page-22-8), Proposition [12](#page-12-3) cannot be applied for the investigation of $H_{\varphi E}$. Nonetheless, one can attempt to use Theorem [9](#page-9-3) and Proposition [11.](#page-11-5)

Assume that $\{E_j^{(n)}\}$ $j^{(n)}$ is a strictly increasing sequence, i.e.

$$
E_1^{(1)} < E_2^{(1)} < E_1^{(2)} < E_2^{(2)} < E_3^{(2)} \dots < E_1^{(n)} < E_2^{(n)} \dots < E_n^{(n)} < E_{n+1}^{(n)} < \dots,
$$

where $E_j^{(n)} \to \infty$. Taking [\(3.3\)](#page-14-1) into account one gets that the operator $B : \mathcal{K} \to \ell_2(\mathbb{N})$ defined by [\(2.23\)](#page-10-0) has the form

$$
Bf = \left\{ \frac{1}{\sqrt{n}} \sum_{j=1}^{n} E_j^{(n)} \langle \varphi_j^{(n)}, f \rangle \right\}_{n=1}^{\infty}, \qquad f \in \mathcal{D}(B) \subseteq \mathcal{K}.
$$
 (3.4)

If

$$
\sup_{n \in \mathbb{N}, 1 \le j \le n} \frac{1}{\sqrt{n}} E_j^{(n)} < \infty,
$$

then the right-hand side of [\(3.4\)](#page-15-0) belongs to $\ell_2(\mathbb{N})$ for every $f \in \mathcal{K}$ and the operator B is bounded. In this case, applying Theorem [9](#page-9-3) we arrive at the conclusion that $H_{\varphi E}$ has a discrete spectrum. Explicit calculation of the discrete spectrum can be carried out using Proposition [11.](#page-11-5) Building on the argumentation presented in [\[9\]](#page-22-0), we conclude that the discrete spectrum of $H_{\varphi \mathsf{E}}$ consists of the original quantities^{[4](#page-15-1)} $\{E_{n+1}^{(n)}\}_{n=1}^{\infty}$ and the solutions μ_1, \ldots, μ_{n-1} of the equations

$$
\frac{1}{E_1^{(n)} - \mu} + \frac{1}{E_2^{(n)} - \mu} + \ldots + \frac{1}{E_n^{(n)} - \mu} = 0, \qquad n \ge 2.
$$

The corresponding eigenfunctions are

$$
\varphi_{n+1}^{(n)} = \frac{1}{n} \sum_{i=1}^{n} e_i^{(n)} \quad \text{(for the eigenvalues} \quad E_{n+1}^{(n)} \text{)} \quad \text{and} \quad f_j = \sum_{i=1}^{n} \frac{1}{E_i^{(n)} - \mu_j} e_i^{(n)},
$$

for the eigenvalues μ_j , $1 \le j \le n-1$ $(n \ge 2)$.

This example can be used to produce a natural settings in the realm of signal analysis. For that, we need first to introduce some ladder operators. In particular, we will now introduce the *horizontal* ladder operators a_n and a_n^* , acting on \mathcal{K}_n , and the *vertical* ladder operators V_n and V_n^* , mapping \mathcal{K}_{n+1} into \mathcal{K}_n and vice-versa.

First of all we define

$$
a_n e_j^{(n)} = \begin{cases} 0, & \text{if } j = 1\\ \sqrt{j-1} e_{j-1}^{(n)}, & \text{if } j = 2, 3, \dots, n, \end{cases}
$$

⁴this fact immediately follows from Corollary [8](#page-8-1) since $\psi_{n+1}^{(n)} = 0$, see [\(3.3\)](#page-14-1)

whose adjoint is

$$
a_n^* e_j^{(n)} = \begin{cases} \sqrt{j} e_{j+1}^{(n)}, & \text{if } j = 1, 2, \dots, n-1, \\ 0, & \text{if } j = n. \end{cases}
$$

These operators, already introduced in [\[7\]](#page-22-9) in connection with a biological system, satisfy the following commutation rule:

$$
[a_n, a_n^*] = I_{\mathcal{K}_n} - n P_n^{(n)},
$$

where $P_n^{(n)} f = \langle e_n^{(n)}, f \rangle_{\mathcal{K}_n} e_n^{(n)}$, for all $f \in \mathcal{K}_n$, and where $I_{\mathcal{K}_n}$ is the identity operator on \mathcal{K}_n . The action of a_n on the vectors $\varphi_j^{(n)}$ defined by [\(3.1\)](#page-13-3) is as follows:

$$
a_n \varphi_j^{(n)} = \begin{cases} -\tilde{e}^{(n)}, & \text{if } j = 1\\ \sqrt{j-1} \varphi_{j-1}^{(n)} + \frac{\sqrt{j-1}}{\sqrt{n}} \varphi_{n+1}^{(n)} - \tilde{e}^{(n)}, & \text{if } j = 2, 3, \dots, n, \\ \sqrt{n} \, \tilde{e}^{(n)}, & \text{if } j = n+1, \end{cases}
$$

where

$$
\tilde{e}^{(n)} = \frac{1}{n} \sum_{i=1}^{n} \sqrt{i} e_i^{(n)}
$$

.

It is easy (but not so relevant) to deduce also the action of a_n^* on $\varphi_j^{(n)}$ $\frac{(n)}{j}$.

We can further introduce the operator $V_{n+1} : \mathcal{K}_{n+1} \to \mathcal{K}_n$ as follows:

$$
V_{n+1}f = \sum_{j=1}^{n+1} \langle e_j^{(n+1)}, f \rangle_{\mathcal{K}_{n+1}} \varphi_j^{(n)}, \qquad f \in \mathcal{K}_{n+1}.
$$

In particular, we see that $V_{n+1}e_j^{(n+1)} = \varphi_j^{(n)}$ $j^{(n)}$. The adjoint of V_{n+1} can be easily deduced. It is an operator mapping \mathcal{K}_n into \mathcal{K}_{n+1} as follows:

$$
V_{n+1}^*g = \sum_{j=1}^{n+1} \langle \varphi_j^{(n)}, g \rangle_{\mathcal{K}_n} e_j^{(n+1)}, \qquad g \in \mathcal{K}_n.
$$

In this case, it is clear that $V_{n+1}^*\varphi_j^{(n)}$ $j^{(n)} \neq e_j^{(n+1)}$ $j^{(n+1)}$, in general. However, due to the fact that $\{\varphi_j^{(n)}\}$ ${j_n \choose j}^{n+1}_{j=1}$ is a PF in \mathcal{K}_n , it is possible to check that $V_{n+1}V_{n+1}^* = I_{\mathcal{K}_n}$, while $V_{n+1}^*V_{n+1} \neq I_{\mathcal{K}_{n+1}}$.

As for the possible interpretation of this example, and the ladder-like operators a_n , V_{n+1} and their adjoints, a natural look at this framework is in terms of signal analysis: \mathcal{K}_n is the set of signals with *n* bits. If a signal *f* is $f = e_1^{(n)}$ $1^{(n)}$, this means that only the first bit is "on", in a signal of *n* bits. Analogously, if $f = \alpha_1 e_1^{(n)} + \alpha_n e_n^{(n)}$, then the first and the last bits are "on", with two weights α_1 and α_n , with $|\alpha_1|^2 + |\alpha_n|^2 = 1$. The operators a_n and a_n^* switch on and off the various bits of a signal with *n* bits, while V_{n+1} and V_{n+1}^* add or remove bits

from the signal. Also, going from $\{e_j^{(e)}\}$ $_{j}^{\left(e\right) }\}$ to $\{\varphi_{j}^{\left(e\right) }$ $j^{(e)}$ } in this context is rather natural: a frame is what is often used in signal analysis to take into account possible loss of information during the transmission of the signal. The Hamiltonian can be seen as the energy of the signal, with various contributions arising from different possible lengths of the signals.

III.2 Relations with regular pseudo-bosons

This section is focused on a class of examples of PFs connected to the so-called regular pseudo-bosons [\[2,](#page-21-1) [4\]](#page-22-10), which are suitable deformations of the bosonic ladder operators $c = \frac{1}{\sqrt{2}}$ $\frac{1}{2}\left(x+\frac{d}{dx}\right)$ and $c^* = \frac{1}{\sqrt{2}}$ $\frac{1}{2}\left(x-\frac{d}{dx}\right).$

The starting point here is a bounded operator X with bounded inverse X^{-1} and an ONB $\mathcal{F}_e = \{e_n \in \mathcal{K}, n \in \mathbb{J} = \mathbb{N} \cup \{0\}\}\$ of a Hilbert space \mathcal{K} . Then we have

Proposition 13 If $||X^*X|| < 1$, then the sets

$$
\mathcal{F}_{\varphi} = \{ \varphi_n = X^* e_n, n \in \mathbb{J} \}, \qquad \mathcal{F}_{\tilde{\varphi}} = \{ \tilde{\varphi}_n = (I - X^* X)^{1/2} e_n, n \in \mathbb{J} \}
$$

are Riesz bases of K , with dual bases

$$
\mathcal{F}_{\psi} = \left\{ \psi_n = X^{-1} e_n, \, n \in \mathbb{J} \right\}, \qquad \mathcal{F}_{\tilde{\psi}} = \left\{ \tilde{\psi}_n = (I - X^* X)^{-1/2} e_n, \, n \in \mathbb{J} \right\}.
$$

Moreover, the set $\mathcal{F}_{ex}^{\varphi} = \mathcal{F}_{\varphi} \cup \mathcal{F}_{\tilde{\varphi}}$ is a PF of K. $\sqrt{ }$

If $\|X^*X\| > 1$ then the set $\mathcal{F}_{\widetilde{\widetilde{\psi}}} =$ $\tilde{\psi}_n = (I - (X^*X)^{-1})^{1/2} e_n, n \in \mathbb{J}$ \mathcal{L} is a Riesz basis with dual

$$
\mathcal{F}_{\widetilde{\widetilde{\varphi}}} = \left\{ \widetilde{\widetilde{\varphi}_n} = (I - (X^*X)^{-1})^{-1/2} e_n, n \in \mathbb{J} \right\}
$$

and the set $\mathcal{F}^{\psi}_{ex} = \mathcal{F}_{\psi} \cup \mathcal{F}_{\widetilde{\psi}}$ is a PF of K.

Proof: If $||X^*X|| < 1$, then $I - X^*X$ is a bounded positive operator on K, and there exist a positive square root $(I - X^*X)^{1/2}$ and its inverse $(I - X^*X)^{-1/2}$ that are bounded operators on K. Hence the Riesz basis nature of the pairs \mathcal{F}_{φ} , \mathcal{F}_{ψ} and $\mathcal{F}_{\tilde{\varphi}}$, $\mathcal{F}_{\tilde{\psi}}$ is clear. To prove that $\mathcal{F}_{ex}^{\varphi}$ is a PF, let us put $U = X^*X$, which is bounded with bounded inverse and self adjoint, and let us write a generic $f \in \mathcal{K}$ as $f = Uf + (I - U)f$. We have

$$
\langle Uf, f \rangle = \langle Xf, Xf \rangle = \sum_{n \in \mathbb{J}} |\langle Xf, e_n \rangle|^2 = \sum_{n \in \mathbb{J}} |\langle f, \varphi_n \rangle|^2.
$$

Moreover, since $I - U$ is a positive operator,

$$
(I - U)f = (I - U)^{1/2} ((I - U)^{1/2} f) = (I - U)^{1/2} \sum_{n \in \mathbb{J}} \langle e_n, (I - U)^{1/2} f \rangle e_n = \sum_{n \in \mathbb{J}} \langle \tilde{\varphi}_n, f \rangle \tilde{\varphi}_n,
$$

so that $\langle (I - U)f, f \rangle = \sum_{n \in \mathbb{J}} |\langle \tilde{\varphi}_n, f \rangle|^2$. Hence

$$
||f||^2 = \langle Uf, f \rangle + \langle (I - U)f, f \rangle = \sum_{n \in \mathbb{J}} |\langle f, \varphi_n \rangle|^2 + \sum_{n \in \mathbb{J}} |\langle \tilde{\varphi}_n, f \rangle|^2,
$$

which implies our claim: $\mathcal{F}_{ex}^{\varphi}$ is a PF.

The proof of the second part of the proposition is similar to this, and will not be repeated.

 \Box

Remarks:– (1) It is clear that if the sets $\mathcal{F}_{\tilde{\varphi}}$ and $\mathcal{F}_{\tilde{\psi}}$ are well defined, then the other sets, $\mathcal{F}_{\widetilde{\varphi}}$ and $\mathcal{F}_{\widetilde{\psi}}$, are not. The point is that only one between $I-U$ and $I-U^{-1}$ can be positive. This does not exclude the possibility to extend the above construction to consider both these possibilities. But we will not investigate further this point here.

III.2.1 An explicit construction

As it is discussed in [\[2,](#page-21-1) [4\]](#page-22-10), in particular, pseudo-bosons can be seen as suitable deformations of the ladder operators c and c^* we introduced before. It is well known that these operators can be used to diagonalize the Hamiltonian of a quantum harmonic oscillator $H_0 = \frac{1}{2}$ $\frac{1}{2}(p^2+x^2),$ where p and x are respectively the momentum and the position operators (both self-adjoint). In fact, after some algebra we can write $H_0 = c^*c + \frac{1}{2}$ $\frac{1}{2}I$, and its eigenstates e_n can be constructed by fixing first the vacuum e_0 , i.e. a vector in K such that $ce_0 = 0$, and then acting on it with powers of c^* : $e_n = \frac{(c^*)^n}{\sqrt{n!}}$ $\frac{c}{\sqrt{n!}} e_0$. Then, $\mathcal{F}_e = \{e_n, n \geq 0\}$ is an ONB of K. In particular, in the position representation, where c and c^* are the differential operators already introduced, we have $\mathcal{K} = \mathcal{L}^2(\mathbb{R})$ and

$$
e_n(x) = \frac{1}{\sqrt{2^n n! \sqrt{\pi}}} H_n(x) e^{-\frac{x^2}{2}},
$$

where $H_n(x)$ is the *n*-th Hermite polynomial.

Remark:– Despite the apparent simplicity of the system (the well known harmonic oscillator), it is maybe useful to stress that this is not necessarily trivial. Indeed, we could think of H_0 as the single electron Hamiltonian of a two-dimensional gas of electrons in a strong magnetic field, orthogonal to a fixed plane, when expressed in suitable variables. This is the physical system which is behind the Landau levels, and the fractional quantum Hall effect, see [\[16,](#page-22-11) [27\]](#page-23-12) for instance, and has attracted a lot of interest in the past years, [\[10,](#page-22-12) [20,](#page-23-13) [26,](#page-23-14) [28\]](#page-23-15) among the others. In most of these papers, the possibility of modifying a single wave function in the so-called *lowest Landau level* (LLL) is used to construct the wave function for the gas of electrons, localized at different lattice sites and minimizing the energy of the gas.

In what we will do now, we are inspired by the possibility of translating a wave function of the LLL while staying in the same energetic level. However, rather than using only translation operators, we will consider a combination of multiplication and translation operators. More explicitly, let K and T be the operators defined as follows:

$$
Kf(x) = m(x)f(x),
$$
 $Tf(x) = f(x - \alpha),$ $f \in \mathcal{L}^2(\mathbb{R}).$

Here $\alpha > 0$, fixed, and $m(x)$ is a complex-valued, smooth^{[5](#page-19-0)} function satisfying $0 < m \leq$ $|m(x)| \leq M < 1$ in R. These operators are bounded, with bounded inverse. In particular, T is unitary:

$$
K^{-1}f(x) = \frac{1}{m(x)} f(x), \qquad K^* f(x) = \overline{m(x)} f(x), \qquad T^* f(x) = T^{-1} f(x) = f(x + \alpha).
$$

Now, if we put $X^* = TK$, we get the following results:

$$
X^* f(x) = m(x - \alpha) f(x - \alpha), \qquad X f(x) = \overline{m(x)} f(x + \alpha),
$$

together with

$$
(X^{-1})^* f(x) = \frac{1}{m(x)} f(x + \alpha), \qquad X^{-1} f(x) = \frac{1}{m(x - \alpha)} f(x - \alpha).
$$

The operators X^*X and XX^* turn out to be both multiplication operators:

$$
X^* X f(x) = |m(x - \alpha)|^2 f(x), \qquad X X^* f(x) = |m(x)|^2 f(x).
$$

Because of our assumption on m, we have $|m(x - \alpha)|^2 \le M^2 < 1$, and therefore $||X^*X|| < 1$: we are in the first case of Proposition [13,](#page-17-1) so that the sets $\mathcal{F}_{\widetilde{\widetilde{\varphi}}}$ and $\mathcal{F}_{\widetilde{\widetilde{\psi}}}$ cannot be defined. Still we find

$$
\varphi_n(x) = m(x - \alpha)e_n(x - \alpha), \qquad \psi_n(x) = \frac{1}{m(x - \alpha)}e_n(x - \alpha)
$$

and

$$
\tilde{\varphi}_n(x) = \sqrt{1 - |m(x - \alpha)|^2} e_n(x), \qquad \tilde{\psi}_n(x) = \frac{1}{\sqrt{1 - |m(x - \alpha)|^2}} e_n(x).
$$

Biorthonormality (in pairs) of these functions is manifest, while the fact that $\mathcal{F}^\varphi_{ex} = \mathcal{F}_\varphi \cup \mathcal{F}_\varphi$ is a PF is not as clear, but it is a consequence of Proposition [13.](#page-17-1)

Following [\[4\]](#page-22-10) it is easy to find the ladder operators for \mathcal{F}_{φ} and $\mathcal{F}_{\tilde{\varphi}}$, and for their dual Riesz bases. We introduce the operators a_{φ} , b_{φ} , $a_{\tilde{\varphi}}$ and $b_{\tilde{\varphi}}$ as follows:

$$
a_{\varphi}f(x) = X^*c(X^*)^{-1}f(x), \qquad b_{\varphi}f(x) = X^*c^*(X^*)^{-1}f(x),
$$

⁵We could take, for instance, $m(x) \in C^{\infty}$.

and

$$
a_{\tilde{\varphi}}f(x) = (I - X^*X)^{1/2}c(I - X^*X)^{-1/2}f(x), \qquad b_{\tilde{\varphi}}f(x) = (I - X^*X)^{1/2}c^*(I - X^*X)^{-1/2}f(x),
$$

 $\forall f(x) \in \mathcal{S}(\mathbb{R})$, the set of the C^{∞} , fast decreasing, functions (the Schwartz space). Simple computations allow us to deduce the following expressions:

$$
a_{\varphi} = c - \frac{1}{\sqrt{2}} \left(\alpha + \frac{m'(x - \alpha)}{m(x - \alpha)} \right), \qquad b_{\varphi} = c^* - \frac{1}{\sqrt{2}} \left(\alpha - \frac{m'(x - \alpha)}{m(x - \alpha)} \right),
$$

while

$$
a_{\tilde{\varphi}} = c - \frac{1}{\sqrt{2}} \frac{q'(x)}{q(x)}, \qquad b_{\tilde{\varphi}} = c^* + \frac{1}{\sqrt{2}} \frac{q'(x)}{q(x)},
$$

where $q(x) = \sqrt{1 - |m(x - \alpha)|^2}$. Incidentally we observe that we can rewrite $\frac{q'(x)}{q(x)}$ = $\frac{d(\log(q(x)))}{dx}$.

Pseudo-bosonic operators are useful since they act as ladder operators on the families of function deduced before. In particular, we have

$$
a_{\varphi}\varphi_n(x) = \sqrt{n}\varphi_{n-1}(x), \qquad b_{\varphi}\varphi_n(x) = \sqrt{n+1}\varphi_{n+1}(x),
$$

and similarly

$$
a_{\tilde{\varphi}}\tilde{\varphi}_n(x) = \sqrt{n}\tilde{\varphi}_{n-1}(x), \qquad b_{\tilde{\varphi}}\tilde{\varphi}_n(x) = \sqrt{n+1}\tilde{\varphi}_{n+1}(x),
$$

with the understanding that $\varphi_{-1}(x) = \tilde{\varphi}_{-1}(x) = 0$. As a consequence, the various $\varphi_n(x)$ are eigenstates of $N_{\varphi} = b_{\varphi} a_{\varphi}$, while each $\tilde{\varphi}_n(x)$ is an eigenstate of $N_{\tilde{\varphi}} = b_{\tilde{\varphi}} a_{\tilde{\varphi}}$, both with eigenvalue n . If we further compute the adjoints of these operators, then we obtain ladder operators for the dual families, \mathcal{F}_{ψ} and $\mathcal{F}_{\tilde{\psi}}$, [\[2,](#page-21-1) [4\]](#page-22-10).

Defining now the vectors Φ_n as

$$
\Phi_n(x) = \begin{cases} \varphi_n(x), & n = 0, 1, 2, 3, \dots \\ \tilde{\varphi}_{-n-1}(x), & n = -1, -2, -3, \dots \end{cases}
$$

and the set $\mathcal{F}_{\Phi} = {\Phi_n(x), n \in \mathbb{Z}} = \mathcal{F}_{\varphi} \cup \mathcal{F}_{\tilde{\varphi}}$, it is easy to check that, taken any $f(x) \in \mathcal{L}^2(\mathbb{R})$,

$$
\sum_{n\in\mathbb{Z}}\langle\Phi_n,f\rangle\Phi_n(x)=\sum_{n=0}^{\infty}\langle\varphi_n,f\rangle\varphi_n(x)+\sum_{n=0}^{\infty}\langle\tilde{\varphi}_n,f\rangle\tilde{\varphi}_n(x)=X^*Xf(x)+(1-X^*X)f(x)=f(x),
$$

as it should (since $\mathcal{F}_{\varphi} \cup \mathcal{F}_{\tilde{\varphi}}$ is a PF in $\mathcal{K} = \mathcal{L}^2(\mathbb{R})$). Now, given a set of (real) numbers E_n , $n \in \mathbb{Z}$, we can consider an operator

$$
H = \sum_{n \in \mathbb{Z}} E_n \langle \Phi_n, \cdot \rangle \Phi_n(x) = H_1 + H_2,
$$

where

$$
H_1 = \sum_{n=0}^{\infty} E_n \langle \varphi_n, \cdot \rangle \varphi_n(x), \qquad H_2 = \sum_{n=0}^{\infty} E_{-(n+1)} \langle \tilde{\varphi}_n, \cdot \rangle \tilde{\varphi}_n(x).
$$

If we now fix $E_n = E_{-(n+1)} = n$, then

$$
H_1 = \sum_{n=0}^{\infty} n \langle \varphi_n, \cdot \rangle \varphi_n(x) = N_{\varphi} \sum_{n=0}^{\infty} \langle \varphi_n, \cdot \rangle \varphi_n(x),
$$

while $H_2 = \sum_{n=0}^{\infty} n \langle \tilde{\varphi}_n, \cdot \rangle \tilde{\varphi}_n(x) = N_{\tilde{\varphi}} \sum_{n=0}^{\infty} \langle \tilde{\varphi}_n, \cdot \rangle \tilde{\varphi}_n(x)$.

As for a possible interpretation of these two terms, we can go back to our previous remark, and to the explicit expressions of the functions $\varphi_n(x)$ and $\tilde{\varphi}_n(x)$. In particular, while these latter are proportional (via the weight function $\sqrt{1 - |m(x - \alpha)|^2}$) to the $e_n(x)$, the functions $\varphi_n(x)$ are again proportional (but via the other weight function $m(x - \alpha)$) to the translated version of the $e_n(x)$. Then, while H_2 can be seen as the single-electron deformed Hamiltonian for a particle in the lowest Landau level, H_1 can be seen as its shifted version (with a different weight function). This can be interesting in connection with the crystals constructed out of the single electron, as in [\[10,](#page-22-12) [20,](#page-23-13) [26,](#page-23-14) [28\]](#page-23-15), since it could produce two different lattices, one shifted with respect to the other. In condensed matter, lattices of this kind are useful, like the so-called reciprocal lattices.

These examples do not cover all possible applications of the general strategy proposed in this paper. More results, and more applications, are part of our future plans.
