A STUDY ON A_{α} -Spectrum and A_{α} -Energy of Unitary Addition Cayley Graphs

ABSTRACT

The unitary addition Cayley graph G_n , $n \in Z^+$ is the graph whose vertex set is Z_n , the ring of integers modulo n and two vertices u and v are adjacent if and only if $u + v \in \bigcup_n$ where \bigcup_n is the set of all units of the ring. The A_α -matrix of a graph G is defined as $A_\alpha(G) = \alpha D(G) + (1-\alpha)A(G)$, $\alpha \in [0, 1]$, where D(G) is the diagonal matrix of vertex degrees and A(G) is the adjacency matrix of G. In this paper, we investigate the A_α -eigenvalues for unitary addition Cayley graph and its complement. We determine bounds for A_α -eigenvalues of unitary addition Cayley graph when its order is odd. Consequently, we compute the A_α -energy of both G_n and its complement, $\overline{G_n}$, for $n = p^m$ where p is a prime number and n even. Moreover, we obtain some bounds for energies of G_n and \overline{G}_n when n is odd. We also define A_α -borderenergetic and A_α -hyperenergetic graphs and observe some classes for each.

1 Introduction

A graph G = (V, E) consists of finite nonempty set V of n vertices together with a set E of m edges. The degree of a vertex v is the number of edges incident with it and is denoted as deg(v). The complement \overline{G} of a graph G has V(G) as its vertex set, but two vertices are adjacent in \overline{G} if and only if they are not adjacent in G. Throughout the paper we consider only simple, undirected graphs.

Let \mathcal{G} be a group and let S be a subset of \mathcal{G} that is closed under taking inverses and does not contain the identity. Then the Cayley graph $X(\mathcal{G}, S)$ is the graph with vertex set \mathcal{G} and edge set $E = \{gh : hg^{-1} \in S\}$.

In [2] Dejter et al. introduced the concept of unitary Cayley graph. Later in [14] Deepa et al. introduced the unitary addition Cayley graphs(UACG). Naveen et al. in [10, 8] studied the structural properties, adjacency spectrum and energy of UACG.

For a simple graph G of order n, the adjacency matrix A(G) of order n is a symmetric matrix with

$$a_{ij} = \begin{cases} 1 & \text{if } v_i \sim v_j \\ 0 & \text{otherwise.} \end{cases}$$

In [17] Nikiforov introduced a convex linear combination of the adjacency matrix of G and degree matrix of G called the A_{α} -matrix. For $\alpha \in [0, 1]$, $A_{\alpha}(G) = \alpha D(G) + (1 - \alpha) A(G)$, where D(G) is the diagonal matrix with entries as corresponding vertex degrees. Clearly, $A_0(G) = A(G)$, $A_1(G) = D(G)$ and $Q(G) = 2A_{\frac{1}{2}}(G) = A(G) + D(G)$, where Q(G) is the signless Laplacian matrix. Also $A_{\alpha}(G) - A_{\beta}(G) = (\alpha - \beta)L(G) = (\alpha - \beta)(D(G) - A(G))$, where L(G) is the Laplacian matrix of G and $\beta \in [0, 1]$. A_{α} -matrix is a generalization of other matrices like A(G), Q(G), L(G) etc. Thus, it helps in studying spectral properties of those matrices as well as uncountable many convex combinations of D(G) and A(G).

The characteristic polynomial of a real symmetric matrix M of order n is defined as $|\lambda I - M|$ where I is the n order identity matrix. The eigenvalues of M, $\lambda_1 \ge \lambda_2 \ge \cdots \ge \lambda_n$, together with their multiplicities gives the spectrum of M. The spectrum of a graph is the spectrum of the matrix considered. We represent the M-spectrum of the graph

 $G \text{ as spec}_M(G) = \begin{pmatrix} \lambda_1 & \lambda_2 & \cdots & \lambda_t \\ m_1 & m_2 & \cdots & m_t \end{pmatrix} \text{ where } \lambda_i \text{'s are the } t \text{ distinct eigenvalues of the matrix } M \text{ considered}$ with multiplicity m_i . The roots of the characteristic polynomial of the adjacency matrix of a graph G are called the

with multiplicity m_i . The roots of the characteristic polynomial of the adjacency matrix of a graph G are called the adjacency eigenvalues of G. Similarly, the roots of A_{α} -matrix gives the A_{α} -spectrum of G. If G is an r-regular graph, then its A_{α} -eigenvalues are $\alpha r + (1 - \alpha) \lambda_i (A(G)), i = 1, 2, \dots, n$. The sum of absolute values of the adjacency eigenvalues of a graph gives the adjacency energy, $\varepsilon(G)$, of the graph. The A_{α} -energy of a graph G, for $\alpha \in [0, 1)$, is

defined as
$$\varepsilon_{\alpha}(G) = \sum_{i=1}^{n} \left| \lambda_i(A_{\alpha}(G)) - \frac{2\alpha m}{n} \right|, 1 \le i \le n$$
. If G is regular, then $\varepsilon_{\alpha}(G) = (1 - \alpha)\varepsilon(G)$.

If every vertex of a graph is connected to every other vertices, then it is called a complete graph. Initially researchers believed that complete graphs have the maximum energy among all the graphs on n vertices. That is, if $G \neq K_n$ is a graph on n vertices then $\varepsilon(G) < 2n-2$. But this was disproved by Gutman and gave rise to the question whether there exist graphs whose energy equals or exceeds the energy of complete graph. In [5], Gutman introduced about graphs whose energy exceeds the energy of complete graphs and called it hyperenergetic graphs. Later in 2015, Gong et al. in [4] introduced the notion of borderenergetic graphs, that is the graphs on n vertices having energy same as that of K_n . In 2017, Tura in [15] gave the Laplacian analogous of borderenergetic graphs. Several families of borderenergetic graphs can be found in [4, 7, 3, 16].

The tensor product $A \otimes B$ of two matrices A and B of order $m \times n$ and $p \times q$, respectively, is the $mp \times nq$ block matrix $[a_{ij}B]$. All one matrix, identity matrix and anti diagonal matrix, with non zero entries one, of order n are represented by J_n, I_n and \tilde{D}_n , respectively.

Consider a vector $s = (s_0, s_1, \dots, s_{n-1}) \in \mathbb{R}^n$. The left circulant matrix $C_L(s)$ associated with s is

$$C_L(s) = \begin{bmatrix} s_0 & s_1 & \cdots & s_{n-1} \\ s_1 & s_2 & \cdots & s_0 \\ \vdots & \vdots & \ddots & \vdots \\ s_{n-1} & s_0 & \cdots & s_{n-2} \end{bmatrix}$$

and the right circulant matrix $C_R(s)$ associated with s is

$$C_R(s) = \begin{bmatrix} s_0 & s_1 & \cdots & s_{n-1} \\ s_{n-1} & s_0 & \cdots & s_{n-2} \\ \vdots & \vdots & \ddots & \vdots \\ s_1 & s_2 & \cdots & s_0 \end{bmatrix}$$

From [8], the eigenvalues of right circulant matrix are $\lambda_j = s_0 + s_1 \omega^j + s_2 \omega^{2j} + \dots + s_{n-1} \omega^{(n-1)j}$, $j = 0, 1, \dots, n-1$, where ω is a complex primitive *n*-th root of unity.

The eigenvalues of left circulant matrix are $\lambda_0, \pm |\lambda_1|, \dots, \pm |\lambda_{(n-1)/2}|$ if *n* is odd and $\lambda_0, \lambda_{n/2}, \pm |\lambda_1|, \dots, \pm |\lambda_{(n-2)/2}|$ if *n* is even where λ_k are the eigenvalues of right circulant matrix. For a positive integer *n* the Möbius function $\mu(n)$ is defined as

$$\mu(n) = \begin{cases} 0, & \text{if } n \text{ has a squared prime factor} \\ (-1)^k, & \text{if } n \text{ is a product of } k \ge 0 \text{ distinct primes.} \end{cases}$$

For $0 \le k \le n-1$, the Ramanujan sum is $c(k,n) = \mu(t_k) \frac{\phi(n)}{\phi(t_k)}$, where $t_k = \frac{n}{\gcd(k,n)}$ and $\phi(n)$ is the Euler's phi function which is the number of positive integers $\le n$ which are relatively prime to n. Also, the eigenvalues of unitary Cayley graph X_n are $\lambda_i(X_n) = \sum_{\substack{1 \le j < n \\ \gcd(j,n) = 1}} \omega^{kj} = c(k,n)$, where ω is a complex primitive n-th root of unity.

Let $\mathbb{M}_{m \times n}(\mathbb{R})$ be the set of all $m \times n$ matrices with real entries. The Frobenius norm for $M \in \mathbb{M}_{m \times n}(\mathbb{R})$ is defined as

$$||M||_F = \sqrt{\sum_{i=1}^{m} \sum_{j=1}^{n} |m_{ij}|^2} = \sqrt{\operatorname{trace}(M^T M)},$$

where trace of a square matrix is defined as sum of the elements on the main diagonal. Let λ_i 's be the eigenvalues of the matrix M. If $MM^T = M^TM$, then $||M||_F^2 = \sum_{i=1}^n |\lambda_i(M)|^2$. The Zagreb index $\zeta(G)$ of a graph G is defined as the sum of the squares of the vertices degrees, that is, $\zeta(G) = \sum_{v \in V(G)} deg(v)^2$.

In real world, modelling a problem using graph gives a regular graph or a non-regular graph. In literature, there are more studies happened in regular graphs compared to the non-regular graph. The study of non-regular graph thus has an significant role in vast area of science and technologies. The UACG G_n is a non-regular graph for odd values of n. In this paper, the exact A_{α} -eigenvalues of UACG and its complement are found for the values $n = p^m$ and n even. For the case when n is odd, it's difficult to find an exact value, but we have found a bound for A_{α} -eigenvalues of G_n and its complement. From the A_{α} -eigenvalues, the A_{α} -energy for G_n and $\overline{G_n}$ are also computed for the values $n = p^m$ and n even. We also introduce the concept of A_{α} -borderenergetic and A_{α} -hyperenergetic graphs and found some graphs which are A_{α} -borderenergetic and A_{α} -hyperenergetic.

2 Preliminaries

Definition 2.1. [8] The unitary Cayley graph $X_n = \text{Cay}(Z_n, \cup_n)$ is the graph with vertex set Z_n , the integers modulo n and $u, v \in Z_n$ are adjacent if and only if $u - v \in \cup_n$, where \cup_n represents set of all units of the ring Z_n . The graph X_n is regular with degree $|\cup_n| = \phi(n)$.

Definition 2.2. [14] For a positive integer n > 1, the unitary addition Cayley graph(UACG) $G_n = Cay^+ (Z_n, \cup_n)$ is the graph whose vertex set is $Z_n = \{0, 1, 2, \dots, n-1\}$ and the edge set $E(G_n) = \{ab \mid a, b \in Z_n, a+b \in \cup_n\}$ where $\cup_n = \{a \in Z_n \mid \text{gcd}(a, n) = 1\}$.

If n is even, then G_n is regular and if n is odd, then G_n is semi regular.

Theorem 2.1. [14] The UACG G_n is isomorphic to X_n , the unitary Cayley graph, if and only if n is even. **Theorem 2.2.** [14] Let v_i , $i = 0, 1, 2, \dots, n-1$, be any vertex of the UACG G_n . Then

$$\deg (v_i) = \begin{cases} \phi(n) & \text{if } n \text{ is even} \\ \phi(n) & \text{if } n \text{ is odd and } \gcd(i, n) \neq 1 \\ \phi(n) - 1 & \text{if } n \text{ is odd and } \gcd(i, n) = 1 \end{cases}$$

Corollary 2.3. [14] The total number of edges in the UACG G_n is

$$|E(G_n)| = \begin{cases} \frac{1}{2}n\phi(n) & \text{if } n \text{ is even} \\ \frac{1}{2}(n-1)\phi(n) & \text{if } n \text{ is odd} \end{cases}$$

Theorem 2.4. [6] The energy of unitary Cayley graph X_n equals $2^l \phi(n)$, where l is the total number of unique prime factors that divides n.

Theorem 2.5. [6] The complement of unitary Cavley graph X_n has energy

$$\varepsilon(\overline{X_n}) = 2(n-1) + (2^k - 2)\phi(n) - \prod_{i=1}^k p_i + \prod_{i=1}^k (2-p_i),$$

where $\prod_{i=1}^{n} p_i$ is the largest divisor of n that is square-free.

Theorem 2.6. [9] Let M, M_1, M_2 be three real symmetric matrices of order n such that $M = M_1 + M_2$. Then the eigenvalues of these matrices satisfy the following inequalities: for $1 \le i \le n$ and $0 \le j \le \min\{i-1, n-i\}$,

$$\lambda_{i-j}(M_1) + \lambda_{1+j}(M_2) \ge \lambda_i(M) \ge \lambda_{i+j}(M_1) + \lambda_{n-j}(M_2)$$

Theorem 2.7. [11] Let G be a connected graph with $n \ge 3$ vertices, m edges, maximum degree Δ and Zagreb index $\zeta(G)$. Let $\alpha \in [0,1)$. Then

1.
$$\varepsilon_{\alpha}(G) \ge \sqrt{2\left(\alpha^{2}\zeta(G) + (1-\alpha)^{2} \|A(G)\|_{F}^{2} - \frac{2(\alpha m)^{2}}{n}\right)}.$$

- 2. $\varepsilon_{\alpha}(G) \ge 4(1-\alpha)\frac{m}{n}$. Equality occurs if and only if G is a regular graph with one positive and n-1 negative adjacency eigenvalues.

3. $\varepsilon_{\alpha}(G) \ge 2\sqrt{\frac{\zeta(G)}{n}} - \frac{4\alpha m}{n}$. Equality occurs if and only if G is a regular graph with one positive and n-1 negative adjacency eigenvalues.

4.
$$\varepsilon_{\alpha}(G) \ge \left(\alpha(\triangle + 1) + \sqrt{\alpha^2(\triangle + 1)^2 + 4\Delta(1 - 2\alpha)}\right) - \frac{4\alpha m}{n}$$

with equality if and only if $G \cong K_{1,\Delta}$.

Theorem 2.8. [13] Let G be a graph on n vertices, m edges and Zagreb index $\zeta(G)$. For $\alpha \in [0, 1)$, we have

$$\varepsilon_{\alpha}(G) \leq \sqrt{n(\alpha^2 \zeta(G) + (1-\alpha)^2 ||A(G)||_F^2) - 4\alpha^2 m^2}$$

Lemma 2.9. [19] Let M_1, M_2, M_3 and M_4 be matrices with M_1 invertible. Let

$$\widetilde{M} = \begin{pmatrix} M_1 & M_2 \\ M_3 & M_4 \end{pmatrix}.$$

Then det (\widetilde{M}) = det (M_1) det $(X - M_3 M_1^{-1} M_2)$.

If M_4 is invertible, then $\det\left(\widetilde{M}\right) = \det\left(M_4\right) \det\left(M_1 - M_2 M_4^{-1} M_3\right)$.

Definition 2.3. [1] The *M*-coronal $\Gamma_M(x)$ of a matrix *M* of order *n* is defined as the sum of the entries of the matrix $(xI_n - M)^{-1}$ (if it exists), that is,

$$\Gamma_M(x) = J_{n \times 1}^T \left(x I_n - M \right)^{-1} J_{n \times 1}$$

If each row sum of an $n \times n$ matrix M is constant, say t, then $\Gamma_M(x) = \frac{n}{x-t}$.

Lemma 2.10. [18] Let A be a real matrix of order n. Then

$$\det \left(yI_n - A - cJ_n\right) = \left(1 - c\Gamma_A\left(y\right)\right) \det \left(yI_n - A\right).$$

Lemma 2.11. [12] Let A and B be symmetric matrices of order n and m, respectively. If μ_1, \dots, μ_n and $\lambda_1, \dots, \lambda_m$ are the eigenvalues of A and B, respectively, then the eigenvalues of $A \otimes B$ are given by $\mu_i \lambda_i; j =$ $1, \cdots, n; i = 1, \cdots, m.$

A_{α} -spectrum and energy of unitary addition Cayley graphs 3

This section discusses the A_{α} -spectrum and A_{α} -energy of UACG for even n and $n = p^m$ where p is a prime number. Also, bound for A_{α} -eigenvalues and A_{α} -energy are found for odd n.

Proposition 3.1. Let $n = p^m$, $p \ge 3$, $m \ge 1$. Then the A_{α} -spectrum of UACG G_n is

$$\begin{pmatrix} p^{m-1} (p\alpha - 1) - 1 & \frac{x-y}{2} & p^{m-1} (p-1)\alpha - 1 & \alpha \left(p^m - p^{m-1}\right) & p^{m-1} \left((p-2)\alpha + 1\right) - 1 & \frac{x+y}{2} \\ \frac{p-3}{2} & 1 & (p-1) \left(p^{m-1} - 1\right) & p^{m-1} - 1 & \frac{p-1}{2} & 1 \end{pmatrix},$$

where $x = (1 + \alpha) p^m - 2p^{m-1} - 1$ and $y = \sqrt{(1 - p^m + \alpha p^m)^2 + (1 - \alpha) 4p^{m-1}}$.

Proof. The A_{α} -matrix of UACG of order p^{m} after proper labelling is $A_{\alpha}(G_{p^{m}}) = J_{p^{m-1}} \otimes C - I_{p^{m-1}} \otimes (C - B)$, where $B = \begin{bmatrix} \alpha \phi(p^{m}) & (1-\alpha) J_{1 \times p-1} \\ (1-\alpha) J_{p-1 \times 1} & (1-\alpha) (J - \widetilde{D}) - (1-\alpha \phi(p^{m})) I_{p-1} \end{bmatrix}$ and $C = (1-\alpha) \begin{bmatrix} 0 & J_{1 \times p-1} \\ J_{p-1 \times 1} & J_{p-1} - \widetilde{D} \end{bmatrix}$.

The matrix $A_{\alpha}(G_{p^m})$ is permutationally similar to

$$\hat{A}_{\alpha}\left(G_{p^{m}}\right) = \begin{bmatrix} \alpha\phi\left(p^{m}\right)I_{p^{m-1}} & (1-\alpha)J_{p^{m-1}\times\frac{p^{m}-p^{m-1}}{2}} & (1-\alpha)J_{p^{m-1}\times\frac{p^{m}-p^{m-1}}{2}} \\ (1-\alpha)J_{\frac{p^{m}-p^{m-1}}{2}\times p^{m-1}} & (1-\alpha)J + (\alpha\phi\left(p^{m}\right)-1)I & (1-\alpha)J - (1-\alpha)\widetilde{D}\otimes J \\ (1-\alpha)J_{\frac{p^{m}-p^{m-1}}{2}\times p^{m-1}} & (1-\alpha)J - (1-\alpha)\widetilde{D}\otimes J & (1-\alpha)J + (\alpha\phi\left(p^{m}\right)-1)I \end{bmatrix},$$

where \widetilde{D} is the anti-diagonal matrix with non-zero entries one of order $\frac{p-1}{2}$.

Then $A_{\alpha}(G_{p^m}) = P\hat{A}_{\alpha}(G_{p^m})P^{-1}$, where $P = \begin{bmatrix} A_{11}^T & A_{12}^T & \cdots & A_{1p^{m-2}}^T & A_{21}^T & A_{22}^T & \cdots & A_{2p^{m-2}}^T & \cdots & A_{p1}^T & A_{p2}^T & \cdots & A_{pp^{m-2}}^T \end{bmatrix}$ is a permutation matrix of order $p^m, m \ge 2$,

$$A_{ij} = [a_{st}], a_{st} = \begin{cases} 1 & \text{if } (s,t) \in H_{ij} \\ 0 & \text{otherwise} \end{cases}$$

$$\begin{split} s &= 1, 2, \cdots, p; t = 1, 2, \cdots, p^m \text{ and } \\ H_{ij} &= \{ (1, i + (j-1)p), (2, i + (j-1)p + p^{m-1}), \cdots, (p, i + (j-1)p + (p-1)p^{m-1}) \}, \\ i &= 1, 2, \cdots, p, j = 1, 2, \cdots, p^{m-2}. \\ P \text{ becomes the identity matrix when } m = 1. \end{split}$$

By Lemma 2.9,

$$\begin{split} |\lambda I - \hat{A}_{\alpha} (G_{p^{m}})| &= (\lambda - \alpha \phi (p^{m}))^{p^{m-1}} \left(1 - \left(1 - \alpha + \frac{p^{m-1} (1 - \alpha)^{2}}{\lambda - \alpha \phi (p^{m})} \right) \frac{p^{m} - p^{m-1}}{\lambda - \alpha \phi (p^{m}) + 1 + (1 - \alpha) p^{m-1}} \right) \\ &= (\lambda - \alpha \phi (p^{m}))^{p^{m-1}} \left(1 - \frac{\left((1 - \alpha) (\lambda - \alpha \phi (p^{m})) + p^{m-1} (1 - \alpha)^{2} \right) (p^{m} - p^{m-1})}{(\lambda - \alpha \phi (p^{m})) (\lambda - \alpha \phi (p^{m}) + 1 + (1 - \alpha) p^{m-1})} \right) \\ &= \prod_{i=1}^{\frac{p-1}{2}} \left((\lambda - \alpha \phi (p^{m}) + 1)^{2} - (1 - \alpha)^{2} (p^{m-1} \mu_{i})^{2} \right) (\lambda - \alpha \phi (p^{m}) + 1)^{p^{m} - p^{m-1} - p + 1}, \end{split}$$

where μ_i 's are the eigenvalues of \widetilde{D} and they are ± 1 .

$$\begin{aligned} |\lambda I - \hat{A}_{\alpha} (G_{p^{m}})| &= \left(\lambda - \alpha \phi (p^{m})\right)^{p^{m-1}} \left(1 - \frac{\left((1 - \alpha) (\lambda - \alpha \phi (p^{m})) + p^{m-1} (1 - \alpha)^{2}\right) \left(p^{m} - p^{m-1}\right)}{(\lambda - \alpha \phi (p^{m})) (\lambda - \alpha \phi (p^{m}) + 1 + (1 - \alpha) p^{m-1})}\right) \\ &\left((\lambda - \alpha \phi (p^{m}) + 1)^{2} - (1 - \alpha)^{2} \left(p^{m-1}\right)^{2}\right)^{\frac{p-1}{2}} (\lambda - \alpha \phi (p^{m}) + 1)^{p^{m} - p^{m-1} - p + 1} \end{aligned}$$

$$= (\lambda - \alpha \phi (p^m))^{p^{m-1}-1} (\lambda - \alpha \phi (p^m) + 1 + (1 - \alpha) p^{m-1})^{\frac{p-3}{2}} (\lambda - \alpha \phi (p^m) + 1 - (1 - \alpha) p^{m-1})^{\frac{p-1}{2}} ((\lambda - \alpha \phi (p^m)) (\lambda - \alpha \phi (p^m) + 1 + (1 - \alpha) p^{m-1}) - (1 - \alpha) ((\lambda - \alpha \phi (p^m)) + p^{m-1} (1 - \alpha)) (p^m - p^{m-1})) (\lambda - \alpha \phi (p^m) + 1)^{p^m - p^{m-1} - p + 1}.$$

Thus, the $A_{\alpha}\text{-spectrum of }G_{p^m}$ is $\operatorname{spec}_{A_{\alpha}}\left(G_{p^m}\right)=$

$$\begin{pmatrix} p^{m-1} \left(p\alpha - 1 \right) - 1 & \frac{x-y}{2} & p^{m-1} \left(p - 1 \right) \alpha - 1 & \alpha \left(p^m - p^{m-1} \right) & p^{m-1} \left(\left(p - 2 \right) \alpha + 1 \right) - 1 & \frac{x+y}{2} \\ \frac{p-3}{2} & 1 & \left(p - 1 \right) \left(p^{m-1} - 1 \right) & p^{m-1} - 1 & \frac{p-1}{2} & 1 \end{pmatrix},$$
where $x = (1 + \alpha) p^m - 2p^{m-1} - 1$ and $y = \sqrt{(1 - p^m + \alpha p^m)^2 + (1 - \alpha) 4p^{m-1}}.$

Next we calculate the A_{α} -energy of UACG G_n for $n = p^m$. Corollary 3.1. The A_{α} -energy of UACG G_{p^m} , $p \ge 3$ is

$$\begin{split} \varepsilon_{\alpha}\left(G_{p^{m}}\right) = & \frac{3p^{m} - 5p^{m-1} - p - 1}{2} + \frac{\alpha}{2p}\left(-3p^{m+1} + 9p^{m} - 4p^{m-1} + p^{2} - 2p + 1\right) + \\ & \frac{p - 1}{2p}\left|\left(p^{m} - p\right)\left(1 - \alpha\right) - \alpha\right| + \left|\frac{x - y}{2} - \frac{\alpha\left(p^{m} - 1\right)\left(p - 1\right)}{p}\right| + \left|\frac{x + y}{2} - \frac{\alpha\left(p^{m} - 1\right)\left(p - 1\right)}{p}\right|, \end{split}$$
where $x = (1 + \alpha) p^{m} - 2p^{m-1} - 1$ and $y = \sqrt{\left(1 - p^{m} + \alpha p^{m}\right)^{2} + \left(1 - \alpha\right)4p^{m-1}}.$

Proof. The number of vertices and edges of G_{p^m} is p^m and $\frac{(p^m-1)(p^m-p^{m-1})}{2}$ respectively. Thus,

$$\begin{split} \varepsilon_{\alpha}\left(G_{p^{m}}\right) = & \frac{p-3}{2} \left| p^{m-1}\left(p\alpha-1\right) - 1 - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| + \left| \frac{x-y}{2} - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| \\ & + \left(p-1\right)\left(p^{m-1}-1\right) \left| p^{m-1}\left(p-1\right)\alpha-1 - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| \\ & + \left(p^{m-1}-1\right) \left| \alpha\left(p^{m}-p^{m-1}\right) - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| \\ & + \frac{p-1}{2} \left| p^{m-1}\left(\left(p-2\right)\alpha+1\right) - 1 - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| \\ & + \left| \frac{x+y}{2} - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| \\ & + \left(p-1\right)\left(p^{m-1}-1\right) \left(-p^{m-1}\left(p-1\right)\alpha+1 + \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right) \\ & + \left(p^{m-1}-1\right) \left(\alpha\left(p^{m}-p^{m-1}\right) - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right) + \left| \frac{x-y}{2} - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| \\ & + \frac{p-1}{2} \left| p^{m-1}\left(\left(p-2\right)\alpha+1\right) - 1 - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| + \left| \frac{x+y}{2} - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| \\ & = \frac{3p^{m}-5p^{m-1}-p-1}{2} + \frac{\alpha}{2p} \left(-3p^{m+1}+9p^{m}-4p^{m-1}+p^{2}-2p+1 \right) \\ & + \left| \frac{p-1}{2p} \left| \left(p^{m}-p\right)\left(1-\alpha\right) - \alpha \right| + \left| \frac{x-y}{2} - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| \\ & + \left| \frac{x+y}{2} - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| \\ & + \left| \frac{x+y}{2} - \frac{\alpha\left(p^{m}-1\right)\left(p-1\right)}{p} \right| \\ \end{split}$$

Remark 3.1. If n is even, then G_n is regular and its A_α -spectrum will be $\alpha \phi(n) + (1 - \alpha) \lambda_i (A(G_n)), i = 1, 2, \dots, n$. Its A_α -energy will be $\varepsilon_\alpha(G_n) = 2^k (1 - \alpha) \phi(n)$, where k is the number of distinct prime factors dividing n and $\alpha \in [0, 1)$.

In general, computing exact eigenvalues of UACG for odd values of n is a tedious work. But, in the following proposition, we determine a bound for A_{α} -eigenvalues of UACG G_n when n is odd.

Proposition 3.2. For an odd integer n, the A_{α} -spectrum of the UACG G_n satisfy the following inequalities:

$$(1-\alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)} + \alpha\phi(n) - 1 \le \lambda_k \left(A_\alpha\left(G_n\right)\right) \le (1-\alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)} + \alpha\phi(n)$$

for $1 \leq k \leq \frac{(n+1)}{2}$ and

$$-(1-\alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)} + \alpha\phi(n) - 1 \le \lambda_k \left(A_\alpha\left(G_n\right)\right) \le -(1-\alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)} + \alpha\phi(n)$$

for $\frac{(n+3)}{2} \le k \le n$.

Proof. Let $A_{\alpha} = (a_{ij}), 0 \leq i, j \leq n-1$, be the A_{α} matrix of G_n , where

$$a_{ij} = \left\{ \begin{array}{ll} 1-\alpha & \quad \text{if } \gcd(n,i+j) = 1 \text{ and } i \neq j, \\ \alpha\phi(n) & \quad \text{if } \gcd(n,i+j) \neq 1 \text{ and } i=j, \\ \alpha(\phi(n)-1) & \quad \text{if } \gcd(n,i+j) = 1 \text{ and } i=j, \\ 0 & \quad \text{otherwise.} \end{array} \right.$$

Then $A_{\alpha} = B + C$, where $B = [b_{ij}], 0 \le i, j \le n - 1$,

$$b_{ij} = \begin{cases} 1 - \alpha & \text{if } \gcd(n, i+j) = 1, \\ 0 & \text{otherwise,} \end{cases}$$

and $C = [c_{ij}], 0 \le i, j \le n - 1$,

$$c_{ij} = \begin{cases} \alpha \phi(n) & \text{if } \gcd(n, i+j) \neq 1 \text{ and } i=j \\ \alpha \phi(n) - 1 & \text{if } \gcd(n, i+j) = 1 \text{ and } i=j \\ 0 & \text{otherwise.} \end{cases}$$

According to the definition of B, it is a left circulant matrix with initial row $(s_0, s_1, \dots, s_{n-1})$ where

$$s_j = \begin{cases} 1 - \alpha & \text{if } \gcd(j, n) = 1, \\ 0 & \text{otherwise.} \end{cases}$$

Thus eigenvalues of B are $(1 - \alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)}$, for $0 \le k \le \frac{(n-1)}{2}$ and $-(1 - \alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)}$ for $\frac{(n+1)}{2} \le k \le n-1$. Eigenvalues of C are $\alpha\phi(n)$ repeated $n - \phi(n)$ times and $\alpha\phi(n) - 1$ repeated $\phi(n)$ times. The required result is therefore obtained from the eigenvalues of B, C and Theorem 2.6.

In the following proposition, we estimate some bounds for A_{α} -energy of UACG G_n when n is odd. **Proposition 3.3.** For an odd integer $n \ge 3$ and $\alpha \in [0, 1)$,

$$\begin{aligned} \epsilon_{\alpha}(G_{n}) &\geq \sqrt{\frac{\phi(n)}{n}} \left[\alpha^{2} \left(\phi(n) \left(3n^{2} - 4n - 1\right) + 2n\right) + (1 - 2\alpha)(n - 1)2n\phi(n)\right]. \\ \epsilon_{\alpha}(G_{n}) &\geq \frac{2(1 - \alpha)(n - 1)\phi(n)}{n}. \\ \epsilon_{\alpha}(G_{n}) &\geq \sqrt{\frac{\phi(n)(\phi(n)(n - 2) + 1)}{n}} - \frac{4\alpha(n - 1)\phi(n)}{n}. \\ \epsilon_{\alpha}(G_{n}) &\geq \alpha(\phi(n) + 1) + \sqrt{\alpha^{2}(\phi(n) + 1)^{2} + 4\phi(n)(1 - \alpha)} - \frac{2\alpha(n - 1)\phi(n)}{n}. \\ \epsilon_{\alpha}(G_{n}) &\leq \sqrt{\phi(n)(n^{2}(1 - \alpha)^{2} - n + 2\alpha n - \alpha^{2}\phi(n)}. \end{aligned}$$

Proof. The Zagreb index of UACG is $\phi(n)^2(n-2) + \phi(n)$ and $||A(G_n)||_F^2 = (n-1)\phi(n)$. Then from Theorems 2.7 and 2.8 the result follows.

4 A_{α} -spectrum and energy of complement of unitary addition Cayley graphs

In this section, we compute the A_{α} -spectrum and A_{α} -energy of complement of UACG for even n and $n = p^m$. Also we find bounds for A_{α} -eigenvalues and A_{α} -energy for odd n.

Proposition 4.1. Let $n = p^m$, $p \ge 3$, $m \ge 1$. Then the A_{α} -spectrum of complement of UACG G_n is

$$\begin{pmatrix} -p^{m-1} & \alpha p^{m-1} - 1 & \alpha p^{m-1} & p^{m-1} - 1 & p^{m-1} \\ \frac{p-1}{2} & p^{m-1} - 1 & (p-1) \left(p^{m-1} - 1 \right) & 1 & \frac{p-1}{2} \end{pmatrix}.$$

Proof. The A_{α} -matrix of complement of UACG G_{p^m} after proper labelling is $A_{\alpha}(\overline{G_{p^m}}) = J_{p^{m-1}} \otimes C - I_{p^{m-1}} \otimes (C - B)$,

where
$$B = \begin{bmatrix} \alpha (1 - p^{m-1}) & 0_{1 \times p-1} \\ 0_{p-1 \times 1} & (1 - \alpha) \widetilde{D}_{p-1} - \alpha p^{m-1}I \end{bmatrix}$$
 and $C = (1 - \alpha) \begin{bmatrix} 1 & 0_{1 \times p-1} \\ 0_{p-1 \times 1} & \widetilde{D}_{p-1} \end{bmatrix}$.

The matrix $A_{\alpha}(\overline{G_{p^m}})$ is permutationally similar to

$$\hat{A}_{\alpha}\left(\overline{G_{p^{m}}}\right) = \begin{bmatrix} (1-\alpha)J_{p^{m-1}} - (1-\alpha p^{m-1})I_{p^{m-1}} & 0_{p^{m-1} \times \frac{p^{m}-p^{m-1}}{2}} & 0_{p^{m-1} \times \frac{p^{m}-p^{m-1}}{2}} \\ 0_{\frac{p^{m}-p^{m-1}}{2} \times p^{m-1}} & \alpha p^{m-1}I & (1-\alpha)\widetilde{D} \otimes J \\ 0_{\frac{p^{m}-p^{m-1}}{2} \times p^{m-1}} & (1-\alpha)\widetilde{D} \otimes J & \alpha p^{m-1}I \end{bmatrix},$$

ī

where \widetilde{D} is the anti-diagonal matrix of order $\frac{p-1}{2}$ with all non-zero entries one.

Then $A_{\alpha}(\overline{G_{p^m}}) = P\hat{A}_{\alpha}(\overline{G_{p^m}})P^{-1}$, where P is the same matrix as used in proof of Proposition 3.1.

$$|\lambda I - \hat{A}_{\alpha}(\overline{G_{p^{m}}})| = \begin{vmatrix} (\lambda + 1 - \alpha p^{m-1}) I_{p^{m-1}} - (1 - \alpha) J_{p^{m-1}} & 0_{p^{m-1} \times \frac{p^{m} - p^{m-1}}{2}} & 0_{p^{m-1} \times \frac{p^{m} - p^{m-1}}{2}} \\ 0_{\frac{p^{m} - p^{m-1}}{2} \times p^{m-1}} & (\lambda - \alpha p^{m-1}) I & -(1 - \alpha) \widetilde{D} \otimes J \\ 0_{\frac{p^{m} - p^{m-1}}{2} \times p^{m-1}} & -(1 - \alpha) \widetilde{D} \otimes J & (\lambda - \alpha p^{m-1}) I \end{vmatrix}.$$

By Lemma 2.9,

•

$$\begin{aligned} |\lambda I - \hat{A}_{\alpha} \left(\overline{G_{p^m}} \right)| &= \left| \left(\lambda + 1 - \alpha p^{m-1} \right) I - \left(1 - \alpha \right) J \right| \begin{vmatrix} \left(\lambda - \alpha p^{m-1} \right) I & - \left(1 - \alpha \right) \widetilde{D} \otimes J \\ - \left(1 - \alpha \right) \widetilde{D} \otimes J & \left(\lambda - \alpha p^{m-1} \right) I \end{vmatrix} \\ &= \left(\lambda + 1 - p^{m-1} \right) \left(\lambda + 1 - \alpha p^{m-1} \right)^{p^{m-1}-1} \left(\lambda - \alpha p^{m-1} \right)^{p^m - p^{m-1} - p + 1} \\ & \left(\left(\lambda - \alpha p^{m-1} \right)^2 - \left(1 - \alpha \right)^2 p^{2m-2} \right)^{\frac{p-1}{2}}. \end{aligned}$$

Thus, the A_{α} -spectrum of $\overline{G_{p^m}}$ is

$$\operatorname{spec}_{A_{\alpha}}\left(\overline{G_{p^{m}}}\right) = \begin{pmatrix} -p^{m-1} & \alpha p^{m-1} - 1 & \alpha p^{m-1} & p^{m-1} - 1 & p^{m-1} \\ \frac{p-1}{2} & p^{m-1} - 1 & (p-1)\left(p^{m-1} - 1\right) & 1 & \frac{p-1}{2} \end{pmatrix}.$$

Using Proposition 4.1 we now calculate the A_{α} -energy of complement of UACG G_n for $n = p^m$. Corollary 4.1. The A_{α} -energy of complement of UACG G_{p^m} , $p \ge 3$ is

$$\varepsilon_{\alpha}\left(\overline{G_{p^{m}}}\right) = \frac{p^{m+1} - p + \alpha\left(2 - p - 2p^{m-1} + p^{m}\right)}{p} + \left|\frac{p^{m} - p - \alpha p^{m} + \alpha}{p}\right|$$

Proof. The number of vertices and edges of $\overline{G_{p^m}}$ is p^m and $\frac{p^{m-1}(p^m-1)}{2}$ respectively. Thus,

$$\begin{split} \varepsilon_{\alpha}\left(\overline{G_{p^{m}}}\right) &= \left(\frac{p-1}{2}\right) \left| -p^{m-1} - \frac{\alpha\left(p^{m}-1\right)}{p} \right| + \left(p^{m-1}-1\right) \left| \alpha p^{m-1} - 1 - \frac{\alpha\left(p^{m}-1\right)}{p} \right| \\ &+ \left(p-1\right) \left(p^{m-1}-1\right) \left| \alpha p^{m-1} - \frac{\alpha\left(p^{m}-1\right)}{p} \right| + \left| p^{m-1} - 1 - \frac{\alpha\left(p^{m}-1\right)}{p} \right| \\ &+ \left(\frac{p-1}{2}\right) \left| p^{m-1} - \frac{\alpha\left(p^{m}-1\right)}{p} \right| \\ &= \left(\frac{p-1}{2}\right) \left(p^{m-1} + \frac{\alpha\left(p^{m}-1\right)}{p}\right) + \left(p^{m-1}-1\right) \left(-\alpha p^{m-1}+1 + \frac{\alpha\left(p^{m}-1\right)}{p}\right) \\ &+ \left(p-1\right) \left(p^{m-1}-1\right) \alpha + \left| p^{m-1} - 1 - \frac{\alpha\left(p^{m}-1\right)}{p} \right| + \left(\frac{p-1}{2}\right) \left(\frac{p^{m}-\alpha p^{m}+\alpha}{p}\right) \\ &= \frac{p^{m+1}-p+\alpha\left(2-p-2p^{m-1}+p^{m}\right)}{p} + \left| \frac{p^{m}-p-\alpha p^{m}+\alpha}{p} \right| \\ &= \left\{ \frac{\frac{p^{m+1}+p^{m}-2p+\alpha\left(3-p-2p^{m-1}\right)}{p} & \text{if } \alpha \leq \frac{p^{m}-p}{p^{m-1}} \\ &= \frac{p^{m+1}-p^{m}+\alpha\left(1-p-2p^{m-1}+2p^{m}\right)}{p} & \text{if } \alpha > \frac{p^{m}-p}{p^{m-1}} \\ \end{split}$$

Remark 4.1. If *n* is even, then $\overline{G_n}$ is regular and its A_{α} -spectrum will be $n - 1 - \phi(n)$ and $\alpha(n - \phi(n)) - (1 - \alpha)\lambda_i(A(G_n)) - 1, i = 2, 3, \dots, n$. Its A_{α} -energy will be $(1 - \alpha)\left(2n - 2 + (2^k - 2)\phi(n) - \prod_{i=1}^k p_i + \prod_{i=1}^k (2 - p_i)\right)$, where $p_1p_2 \cdots p_k$ is the largest square-free number that divides n.

In general, computing exact eigenvalues of complement of UACG for odd values of n is difficult. But, we estimate a bound for A_{α} -eigenvalues of complement of UACG G_n when n is odd in the following proposition.

Proposition 4.2. The A_{α} -spectrum of the complement of UACG G_n , for odd n, satisfy the ensuing inequalities:

$$(1-\alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)} + \alpha n - \alpha\phi(n) - 1 \le \lambda_k \left(A\left(\overline{G_n}\right)\right) \le (1-\alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)} + \alpha n - \alpha\phi(n)$$

for $2 \le k \le \frac{(n+1)}{2}$ and

$$-(1-\alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)} + \alpha n - \alpha\phi(n) - 1 \le \lambda_k \left(A\left(\overline{G_n}\right)\right) \le -(1-\alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)} + \alpha n - \alpha\phi(n)$$

for $\frac{(n+3)}{2} \leq k \leq n$ and

$$n - \phi(n) - 1 \le \lambda_1 \left(A\left(\overline{G_n}\right) \right) \le n - \phi(n).$$

Proof. Let $\bar{A}_{\alpha} = (\bar{a}_{ij}), 0 \leq i, j \leq n-1$, be the A_{α} matrix of $\overline{G_n}$, where

$$\bar{a}_{ij} = \begin{cases} 1 - \alpha & \text{if } \gcd(n, i+j) \neq 1 \text{ and } i \neq j, \\ \alpha(n-1-\phi(n)) & \text{if } \gcd(i+j, n \neq 1 \text{ and } i=j, \\ \alpha(n-\phi(n)) & \text{if } \gcd(n, i+j) = 1 \text{ and } i=j, \\ 0 & \text{otherwise.} \end{cases}$$

Then $\bar{A}_{\alpha} = \tilde{B} + \tilde{C}$, where $\tilde{B} = [b_{ij}], 0 \le i, j \le n-1$,

$$b_{ij} = \begin{cases} 1 - \alpha & \text{if } \gcd(n, i+j) \neq 1, \\ 0 & \text{otherwise,} \end{cases}$$

and $\tilde{C} = [c_{ij}], 0 \le i, j \le n - 1$,

$$c_{ij} = \begin{cases} \alpha n - \alpha \phi(n) - 1 & \text{if } \gcd(n, i+j) \neq 1 \text{ and } i = j, \\ \alpha(n - \phi(n)) & \text{if } \gcd(n, i+j) = 1 \text{ and } i = j, \\ 0 & \text{otherwise.} \end{cases}$$

According to the definition of \tilde{B} , it is a left circulant matrix with initial row $(s_0, s_1, \dots, s_{n-1})$ where

$$s_j = \begin{cases} 1 - \alpha & \text{if } \gcd(j, n) = 1\\ 0 & \text{otherwise.} \end{cases}$$

So eigenvalues of \tilde{B} are $(1-\alpha)(n-\phi(n)), (1-\alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)}$ for $1 \le k \le \frac{(n-1)}{2}$ and $-(1-\alpha)\mu(t_k)\frac{\phi(n)}{\phi(t_k)}$ for $\frac{(n+1)}{2} \le k \le n-1.$

Eigenvalues of \tilde{C} are $\alpha n - \alpha \phi(n) - 1$ repeated $n - \phi(n)$ times and $\alpha(n - \phi(n))$ repeated $\phi(n)$ times. Then from the eigenvalues of \tilde{B}, \tilde{C} and Theorem 2.6 we get the desired result.

In the following proposition, we estimate some bounds for A_{α} -energy of complement of UACG G_n when n is odd. **Proposition 4.3.** For an odd integer n > 3 and $\alpha \in [0, 1)$,

 $\epsilon_{\alpha}(\overline{G}_n) \geq$

$$\begin{split} &\sqrt{(n-\phi(n))\left(\alpha^{2}(n-\phi(n)(n^{2}+2n-2)+2n\alpha^{2}(2\phi(n)+n-1)+2n(n-1)(1-2\alpha)\right)+2n\alpha^{2}\phi(n)} \\ &\epsilon_{\alpha}(\overline{G}_{n}) \geq \frac{2(1-\alpha)(n-1)(n-\phi(n))}{n}. \\ &\epsilon_{\alpha}(\overline{G}_{n}) \geq 2\sqrt{(n-\phi(n))^{2}+\frac{\phi(n)(2(n-\phi(n))+1)}{n}} - \frac{2\alpha(n-1)(n-\phi(n))}{n}. \\ &\epsilon_{\alpha}(\overline{G}_{n}) \geq \alpha(\phi(n)+4) - n\alpha - \frac{2\alpha\phi(n)}{n} + \sqrt{(n-\phi(n)+2)(\alpha^{2}(n-\phi(n)+2)+4(1-2\alpha)}. \\ &\epsilon_{\alpha}(\overline{G}_{n}) \leq \sqrt{\alpha^{2}n^{4}+n^{3}(-\alpha-2\alpha+2\phi(n)+3) - n^{2}(1+p)(2\alpha^{2}+(1-\alpha)^{2}) + np(-2\alpha^{2}p-2\alpha+1)+p^{2}}. \end{split}$$

Proof. The Zagreb index of complement of UACG is $(n - \phi(n))^2 n + \phi(n)(2(n - \phi(n)) + 1)$ and $||A(\overline{G}_n)||_F^2 = (n - 1)(n - \phi(n))$. Then by using Theorems 2.7 and 2.8 we get the desired result.

5 A_{α} -borderenergetic and A_{α} -hyperenergetic graphs

In this section we define A_{α} analogous of borderenergetic and hyperenergetic graphs.

On studying about the A_{α} -energy we are interested to know whether there is a graph on n vertices whose A_{α} -energy equals the A_{α} -energy of complete graph on n vertices, that is $2(1 - \alpha)(n - 1)$. We refer them as A_{α} -borderenergetic graphs. Formally, a graph G is A_{α} -borderenergetic if $\varepsilon_{\alpha}(G) = \varepsilon_{\alpha}(K_n)$, for some $\alpha \in [0, 1)$. In general borderenergetic graphs are not A_{α} -borderenergetic, but regular borderenergetic graphs are A_{α} -borderenergetic for every value of α .

The graph whose A_{α} -energy exceeding the A_{α} -energy of complete graph is called A_{α} -hyperenergetic. That is, a graph G is A_{α} -hyperenergetic if $\varepsilon_{\alpha}(G) \ge \varepsilon_{\alpha}(K_n)$, for some $\alpha \in [0, 1)$.

In the following section we observed some graphs which are A_{α} -borderenergetic and A_{α} -hyperenergetic.

Observations

In this section with the help of Matlab software we study about A_{α} -energy of UACG and its complement as α varies.

Observation 1 : From Table 1 we observe the following:

- 1. A_{α} -energy of UACG G_n decreases as α increases for $n = p^m$.
- 2. G_{p^m} is A_{α} -hyperenergetic for $p \geq 5, m \geq 2$.
- 3. For all m, \overline{G}_{p^m} is A_{α} -hyperenergetic for some α greater than 0.4.

Eg: \overline{G}_9 is hyperenergetic for $\alpha > 0.428571428571$. \overline{G}_{25} is hyperenergetic for $\alpha > 0.438596491228$.

Observation 2 : From Table 1 we also observe the following:

1. For all m and some α , G_{3^m} is A_{α} -borderenergetic and as m increases, $\alpha \to 0$.

Eg: G_9 is borderenergetic for $\alpha = 0.375$, (see Table 2). However G_{p^m} is not A_{α} -borderenergetic for $p \ge 5$ and $m \ge 2$.

2. G_{p^m} is not adjacency borderenergetic for any p and m.

3. For all m and $p \ge 5$, \overline{G}_{p^m} is A_{α} -borderenergetic for some $\alpha \in (0.4, 0.5)$.

Eg: \overline{G}_5 is borderenergetic for $\alpha = 0.4545454545454545$. \overline{G}_{49} is borderenergetic for $\alpha = 0.449541284404$.

6 Conclusion

In this article the A_{α} -eigenvalues of unitary addition Cayley graph G_n when its order is p^m or even is calculated. When its order is odd, a bound for the A_{α} -eigenvalues is found. In addition, the A_{α} -energy of G_n when n is p^m or even is computed. For odd n, bounds for A_{α} -energy of G_n and \overline{G}_n are estimated. Also the concept of A_{α} -borderenergetic and A_{α} -hyperenergetic graphs is introduced and found some families of each.
