# HIGHER-ORDER GENERALIZATIONS OF THE $A_{6}^{(1)}$ - AND $A_{4}^{(1)}$-SURFACE TYPE $q$-PAINLEVÉ EQUATIONS

#### Abstract

In this paper, we construct higher-order generalizations of the $A_{6}^{(1)}$ - and $A_{4}^{(1)}$ surface type $q$-Painlevé equations from the system of partial difference equations with the consistency around a cube property by periodic reduction. Moreover, we also show their extended affine Weyl group symmetries and Lax pairs.


## 1. Introduction

Fix an integer $N>0$. This paper focuses on two $2 N$-order ordinary $q$-difference equations. One is the following:

where $t \in \mathbb{C}$ is an independent variable, $F_{i}=F_{i}(t) \in \mathbb{C}, i=1, \ldots, 2 N$, are dependent variables and $a_{1}, \ldots, a_{2 N-1} \in \mathbb{C}$ are parameters. The symbol ${ }^{-}$denotes the discrete time evolution and

where $p \in \mathbb{C}$ is a constant parameter. When $N=1$, the system (1.1) is equivalent to a $q$-Painlevé II equation of $A_{6}^{(1)}$-surface type [28, 49-51]:

Indeed, eliminating $F_{1}$ from the system (1.1) with $N=1$, we obtain Equation (1.3).
Remark 1.1. A different higher-order generalization of Equation (1.3) has been reported in [31 44], but the relationship between that system and the system (1.1) is unclear.

[^0]The other $2 N$-order ordinary $q$-difference equation is the following:

where $t$ is an independent variable, $G_{i}=G_{i}(t) \in \mathbb{C}, i=1, \ldots, 2 N$, are dependent variables and $a_{1}, \ldots, a_{2 N}, c \in \mathbb{C}$ are parameters. The symbol ${ }^{-}$denotes the discrete time evolution and

where $p \in \mathbb{C}$ is a constant parameter. When $N=1$, by using the shift operator ${ }^{\sim}$ and the variables $g_{1}=g_{1}(t)$ and $g_{2}=g_{2}(t)$ given by

the system (1.4) can be rewritten as

The system (1.7) is known as a $q$-Painlevé V equation of $A_{4}^{(1)}$-surface type [22, 23, 34, 57] and can be regarded as a Bäcklund transformation of the well-known Sakai's $q$-Painlevé V equation of $A_{4}^{(1)}$-surface type [51].
Remark 1.2. For a $q$-difference equation, it is common to use the symbol " $q$ " for its shift parameter. However, in this paper, the symbol " $q$ " is used in the later arguments, and the relations between the symbol " $p$ " in the systems (1.1) and (1.4) and the symbol " $q$ " in the later arguments will be given. Therefore, we use the symbol " $p$ " instead of the symbol " $q$ " for the systems (1.1) and (1.4) to avoid confusion.
1.1. Main results. In this subsection, we show four main results of this paper. The first two results are about symmetries, while the latter two are about Lax pairs, known as showing integrability.

Theorem 1.3. The system (1.1) can be derived from a birational representation of an extended affine Weyl group of $\left(A_{1} \times A_{1}\right)^{(1)}$-type when $N=1$ and that of $\left(A_{2 N-1} \rtimes A_{1}\right)^{(1)}$-type when $N \in \mathbb{Z}_{\geq 2}$.
Proof. This theorem is proven in $\$ 3.1$ when $N=1$ and in $\S 3.2$ when $N \in \mathbb{Z}_{\geq 2}$.
Theorem 1.4. The system (1.4) can be derived from a birational representation of an extended affine Weyl group of $\left(A_{2 N} \rtimes A_{1}\right)^{(1)}$-type.

Proof. This theorem is proven in $\$ 3.3$,

Remark 1.5. An affine Weyl group of $\left(A_{1} \times A_{1}\right)^{(1)}$-type means the direct product of two affine Weyl groups of $A_{1}^{(1)}$-type, while an affine Weyl group of $\left(A_{k} \rtimes A_{1}\right)^{(1)}$-type means the semi-direct product of an affine Weyl group of $A_{k}^{(1)}$-type and that of $A_{1}^{(1)}$-type. Moreover, the extended affine Weyl group of $\left(A_{1} \times A_{1}\right)^{(1)}$-type in Theorem 1.3 indicates an affine Weyl group of $\left(A_{1} \times A_{1}\right)^{(1)}$-type extended by an automorphism of Dynkin diagrams. On the other hand, the extended affine Weyl group of $\left(A_{k} \rtimes A_{1}\right)^{(1)}$-type in Theorems 1.3 and 1.4 indicates an affine Weyl group of $\left(A_{k} \rtimes A_{1}\right)^{(1)}$-type extended by an automorphism of Dynkin diagrams. (Further details can be found in Lemma 2.3.)

For details on the birational representations of the extended affine Weyl groups, see $\$ 3.1$ for the system (1.1) with $N=1$, 3.2 for the system (1.1) with $N \in \mathbb{Z}_{\geq 2}$, and $\$ 3.3$ for the system (1.4).

Theorem 1.6. The following pair of linear equations is a Lax pair of the system 1.1):

where $\Phi(x, t)$ is a column vector of length two and $L_{i}=L_{i}(x, t), i=1, \ldots, 2 N$, are $2 \times 2$ matrices given by

Proof. This theorem is proven in $\$ 4.1$ when $N=1$ and in $\$ 4.2$ when $N \in \mathbb{Z}_{\geq 2}$.

Theorem 1.7. The following pair of linear equations is a Lax pair of the system (1.4):

where $\Psi(x, t)$ is a column vector of length two and $M_{i}=M_{i}(x, t), i=1, \ldots, 2 N+1$, and $K_{j}=K_{j}(x, t), j=1, \ldots, 2 N$, are $2 \times 2$ matrices given by

Proof. This theorem is proven in $\$ 4.3$.
1.2. Background. In the early 20th century, to find a new class of special functions, Painlevé and Gambier classified all the ordinary differential equations of the type $y^{\prime \prime}=$ $F\left(y^{\prime}, y, t\right)$, where $y=y(t),^{\prime}=d / d t$ and $F$ is a function meromorphic in $t$ and rational in $y$ and $y^{\prime}$, with the Painlevé property (solutions do not have movable singularities other than poles) [1047]. As a result, they obtained six new equations, and the resulting equations are now collectively referred to as the Painlevé equations. Note that the Painlevé VI equation was found by Fuchs [9] before Painlevé and Gambier.

After the discovery, the Painlevé equations withdrew from the stage of "modern mathematics" for a while. The Painlevé equations regained attention after the 1970s because they appeared in mathematical physics research. For instance, solutions of the Painlevé equations (Painlevé transcendents) were rediscovered as scaling functions for the twodimensional Ising model on a square lattice [61] and as similarity solutions of the soliton equations describing specific shallow water waves (solitons) [1].
$q$-Painlevé equations are a family of second-order nonlinear ordinary $q$-difference equations. Historically, they have been obtained as $q$-discrete analogues of the Painlevé equations (see, for example, [12, 18]). Similar to the Painlevé equations, $q$-Painlevé equations are also known to describe special solutions of various discrete soliton equations [8, 13--15, 46]. Particularly famous is imposing periodic conditions on soliton equations, which are closely related to the result in this paper. It is also known that $q$-Painlevé equations have the same good properties as the Painlevé equations, such as having Lax pairs and (extended) affine Weyl group symmetries. (See for example [16, 27].)

Let us explain more about a Lax pair and an (extended) affine Weyl group symmetry relevant to this paper. A Lax pair of a $q$-Painlevé equation is given by a pair of two linear equations

such that their compatibility condition

gives the corresponding $q$-Painlevé equation. Here, $\phi(x, t)$ is a column vector, $A(x, t)$ and $B(x, t)$ are square matrices, $x \in \mathbb{C}$ is a parameter, and $t \in \mathbb{C}$ and $q \in \mathbb{C}$ are respectively the independent variable and the shift parameter of the $q$-Painlevé equation. Next, we explain an (extended) affine Weyl group symmetry of a $q$-Painlevé equation. A transformation from an integrable system to an integrable system is called a Bäcklund transformation. In the case of a $q$-Painlevé equation, there are self-Bäcklund transformations, that is, Bäcklund transformations to itself, which collectively form an (extended) affine Weyl group. In that case, the $q$-Painlevé equation is said to have an (extended) affine Weyl group symmetry. Note that an (extended) affine Weyl group symmetry of a $q$-Painlevé equation
does not always mean its Bäcklund transformations alone. It often means a large group of transformations, including its time evolution. For example, Theorem 1.3 asserts that the system (1.1) can be obtained from a birational action of an extended affine Weyl group of $\left(A_{2 N-1} \rtimes A_{1}\right)^{(1)}$-type. In this case, we say that the system (1.1) has an extended affine Weyl group symmetry of $\left(A_{2 N-1} \rtimes A_{1}\right)^{(1)}$-type.

There exist six Painlevé equations. However, by Okamoto's space of initial values [43], the Painlevé III equation can be classified into three types, and then the Painlevé equations can be considered as eight types [42]. On the other hand, an infinite number of $q$-Painlevé equations exist. By considering Sakai's space of initial values [51], which is an extension of Okamoto's space of initial values, $q$-Painlevé equations can be classified into nine surface types (see Figure 1.1).

Figure 1.1. Types of spaces of initial values for $q$-Painlevé equations. The surface degenerates in the direction of the arrow due to the specialization and confluence of the base points that characterize the surface types. On each surface, transformations collectively forming an (extended) affine Weyl group exist. A birational action of an element with infinite order of each transformation group gives rise to a $q$-Painlevé equation.

In [26], Kajiwara-Noumi-Yamada showed a birational representation of the extended affine Weyl group of $\left(A_{m-1} \times A_{n-1}\right)^{(1)}$-type (KNY's representation), where $m$ and $n$ are integers greater than or equal to 2 , except for $(m, n)=(2,2)$. Note that KNY's representation is essentially the same even if $m$ and $n$ are interchanged [33]. It was shown in [25] that KNY's representation gives the Painlevé type $q$-difference equations, including $q$-Painlevé equations as the second-order ordinary $q$-difference equations. Indeed, [25] showed that the case $(m, n)=(2,3)$ gives $q$-Painlevé equations of $A_{5}^{(1)}$-surface type, and [25,56] showed the case $(m, n)=(2,4)$ gives $q$-Painlevé equations of $A_{3}^{(1)}$-surface type.

Recently, it has been reported that KNY's representation can be extended to the birational representation of the extended affine Weyl group of $\left(A_{m-1} \times A_{n-1} \times A_{g-1}\right)^{(1)}$-type (extended KNY's representation), where $g$ is the common greatest divisor of $m$ and $n$ [30, 32]. The paper [45] presents the explicit forms of the Painlevé type $q$-difference equations obtained from the extended KNY's representation. It is also shown that these equations include Sakai's $q$-Garnier system [52], Tsuda's $q$-Painlevé system arising from the $q$-UC hierarchy [58] and Suzuki's $q$-Painlevé system arising from the $q$-DS hierarchy [53, 54]. Moreover, in [55], Suzuki claims that the case $(m, n, g)=(3,3,3)$ gives $q$-Painlevé equations of $A_{2}^{(1)}$-surface type.

As mentioned above, KNY's representation derived in 2002 is still being studied from various angles and is undergoing further development. The motivation for this study is to find research subjects that would be studied for a long time and used in a wide range of fields, as KNY's representation is.

We consider that the birational representation in this study and the extended KNY's representation are different for the following reasons:

- Different periodic conditions are imposed on the same system for their derivations.

In our previous works [20, 21], under a periodic condition, a system of partial difference equations having the consistency around a cube (CAC) property was found to give a birational representation of an extended affine Weyl group of type $\left(A_{2} \times A_{1}\right)^{(1)}$, which is KNY's representation with $(m, n)=(2,3)$. By comparing the
results in [20, 21] and those in [25, 26], it is expected that by imposing the periodic condition

on the system of partial difference equations given in $\$ 2$ KNY's representation with $m=2$ can be obtained.

On the other hand, by imposing the different periodic condition

on the same system, we can obtain a birational representation studied in this paper. The case $n=2$ is studied in [21], and its birational representation gives $q$-Painlevé equations of $A_{6}^{(1)}$-surface type. Moreover, the case $n=3$ is studied in [22], and its birational representation gives $q$-Painlevé equations of $A_{4}^{(1)}$-surface type. The case $n \geq 4$ is a new result of this paper.

- From the viewpoint of cluster algebra [31], the extended KNY's representation does not give $q$-Painlevé equations of $A_{7}^{(1)}$ - and $A_{6}^{(1)}$-surface type. However, the resulting birational representation in this study gives Equation (1.3), which is a $q$-Painlevé equation of $A_{6}^{(1)}$-surface type.

Remark 1.8. In [4], higher-order generalizations of the $A_{5}^{(1)}$ - and $A_{3}^{(1)}$-surface type $q$ Painlevé equations were derived by imposing the ( $n, 1$ )-type periodic condition:

on the multi-parametric version of the discrete modified KdV equation:

where $l_{1}, l_{2} \in \mathbb{Z}$ are lattice parameters and $\left\{\alpha^{(1)}(l), \alpha^{(2)}(l), \beta^{(1)}(l), \beta^{(2)}(l)\right\}_{l \in \mathbb{Z}}$ are complex parameters. From the following facts, the higher-order q-Painlevé equations in [4] are expected to be obtained from the (extended) KNY's representation.

- When

Equation (1.18) is called the lattice modified $K d V(\operatorname{lm} K d V)$ equation [38] 40].

- In [21], using the case $n=2$ as an example, it was shown that the ( $n, 1$ )-type periodically reduced $\operatorname{lm} K d V$ equation could be obtained from the $\omega$-lattice constructed from the $(1,1, \ldots, 1)$-type periodic reduction of the $(n+1)$-dimensional system of $l m K d V$ equations by considering its restricted lattice.
- The papers [20|21], together with the papers [25]26], indicate that the $(1,1, \ldots, 1)$ type periodic reduction of the system of lmKdV equations gives KNY's representation with $m=2$.
1.3. Notation and Terminology. This paper will use the following notations and terminologies for conciseness.
- For matrices $A$ and $B$, the symbol $A B$ means the matrix product $A . B$.
- For transformations $s$ and $r$, the symbol $s r$ means the composite transformation $s \circ r$.
- The " 1 " in the transformation implies the identity transformation.
- For a transformation $s$, the relation $s^{\infty}=1$ means that there is no positive integer $k$ such as $s^{k}=1$.
- If the subscript number is greater than the superscript number in the product symbol, 1 is assumed. For example,

1.4. Outline of the paper. This paper is organized as follows. In $\$ 2$ we introduce a system of partial difference equations with the CAC property and show its properties, a Lax representation, and transformations that keep the system invariant. In $\$ 3$ and $\$ 4$ we give proofs of Theorems 1.3 and 1.4 and those of Theorems 1.6 and 1.7 respectively. Some concluding remarks are given in $\$ 5$

## 2. A system of partial difference equations with the CAC property

Fix an integer $n \geq 2$. We consider the following system of partial difference equations:

We can easily verify that the system (2.5) has the consistency around a cube (CAC) property, which is known as a type of integrability (see [5] 37 41] 60] for the CAC property). Equation (2.5a) with fixed $i$ and $j$ is known as the lattice modified KdV equation [38]40] or the H3 equation in the study of the CAC property [2, 3], while Equation (2.5b) with fixed $k$ is known as Boll's D4 equation [6. 7].

The remainder of this section will discuss the properties of the system (2.1).
2.1. Symmetry of the system (2.1). We define the automorphisms of the lattice $\mathbb{Z}^{n+1}: s_{1}$, $\ldots, s_{n-1}, \pi, w_{1}$, by the following actions on the coordinates $\left(l_{1}, \ldots, l_{n}, l_{0}\right) \in \mathbb{Z}^{n+1}$ :

Moreover, as evident from the relations (2.16c), the transformation $r$ corresponds to reflections of two Dynkin diagrams of type $A_{1}^{(1)}$ associated with $\left\langle s_{0}, s_{1}\right\rangle$ and $\left\langle w_{0}, w_{1}\right\rangle$. Therefore, we refer to the transformation group $\left\langle s_{0}, s_{1}, w_{0}, w_{1}, r\right\rangle=W\left(\left(A_{1} \times A_{1}\right)^{(1)}\right) \rtimes\langle r\rangle$ as an extended affine Weyl group of type $\left(A_{1} \times A_{1}\right)^{(1)}$ and denote it as $\widetilde{W}\left(\left(A_{1} \times A_{1}\right)^{(1)}\right)$.
(ii) : When $n>2$, the transformation group $\left\langle s_{0}, \ldots, s_{n-1}, w_{0}, w_{1}, r\right\rangle$ satisfies the relations (2.18). Transformation groups $\left\langle s_{0}, \ldots, s_{n-1}\right\rangle$ and $\left\langle w_{0}, w_{1}\right\rangle$ form the affine Weyl group of type $A_{n-1}^{(1)}$ and that of type $A_{1}^{(1)}$, respectively. Therefore, we denote the transformation group $\left\langle s_{0}, \ldots, s_{n-1}, w_{0}, w_{1}\right\rangle=\left\langle s_{0}, \ldots, s_{n-1}\right\rangle \rtimes\left\langle w_{0}, w_{1}\right\rangle$ as $W\left(\left(A_{n-1} \rtimes A_{1}\right)^{(1)}\right)$. Moreover, as evident from the relations (2.18c), the transformation $r$ corresponds to reflections of the Dynkin diagram of type $A_{n-1}^{(1)}$ associated with $\left\langle s_{0}, \ldots, s_{n-1}\right\rangle$ and that of type $A_{1}^{(1)}$ associated with $\left\langle w_{0}, w_{1}\right\rangle$. Therefore, we refer to the transformation group $\left\langle s_{0}, \ldots, s_{n-1}, w_{0}, w_{1}, r\right\rangle=W\left(\left(A_{n-1} \rtimes A_{1}\right)^{(1)}\right) \rtimes\langle r\rangle$ as an extended affine Weyl group of type $\left(A_{n-1} \rtimes A_{1}\right)^{(1)}$ and denote it as $\widetilde{W}\left(\left(A_{n-1} \rtimes\right.\right.$ $\left.A_{1}\right)^{(1)}$ ).

Note that we sometimes write $\widetilde{W}\left(\left(A_{n-1} \rtimes A_{1}\right)^{(1)}\right)$, including the case $n=2$, for simplicity.

3. Reduction from the system (2.1) to the $q \mathrm{P}^{(2 N)}\left(A_{6}^{(1)}\right)$ (1.1) and the $q \mathrm{P}^{(2 N)}\left(A_{4}^{(1)}\right)$ (1.4)

In this section, we derive the systems (1.1) and (1.4) by imposing the periodic condition

Since the conditions for the parameters obtained by the periodic reduction depend on the parity of $n$ in the system (2.1), we consider the reduction in the cases of odd and even $n$ separately. In addition, since $n=2$ differs from other even-numbered cases, we further separate them. Note that the results for $n=2$ and $n=3$ are the same as those in [21] and [22], respectively.
3.1. Proof of Theorem 1.3 with $N=1$. Let us consider the periodic reduction of the system (2.1) when $n=2$. Imposing the ( $1,1,1$ )-periodic condition

The action of $\widetilde{W}\left(\left(A_{1} \times A_{1}\right)^{(1)}\right)=\left\langle s_{0}, s_{1}, w_{0}, w_{1}\right\rangle \rtimes\langle r\rangle$ on the parameters $\left\{a_{0}, a_{1}, b, q\right\}$ and the variables $\left\{f_{1}, f_{2}\right\}$ given by (3.7) corresponds to the action of $\widetilde{\boldsymbol{W}}\left(\left(A_{1} \times\right.\right.$ $\left.\left.A_{1}^{\prime}\right)^{(1)}\right)=\left\langle\boldsymbol{s}_{0}, \boldsymbol{s}_{1}, \boldsymbol{w}_{0}, \boldsymbol{w}_{1}\right\rangle \rtimes\langle\boldsymbol{\pi}\rangle$ on the parameters $\left\{\boldsymbol{a}_{0}, \boldsymbol{a}_{1}, \boldsymbol{b}, \boldsymbol{q}\right\}$ and the variables $\left\{\boldsymbol{f}_{0}, \boldsymbol{f}_{1}, \boldsymbol{f}_{2}\right\}$ given in [21] by the following correspondence:

As shown in [21], $\widetilde{\boldsymbol{W}}\left(\left(A_{1} \times A_{1}^{\prime}\right)^{(1)}\right)$ is the extended affine Weyl symmetry group for Sakai's $A_{6}^{(1)}$-surface, which gives the q-Painlevé II equation (1.3). Note that $\widetilde{\boldsymbol{W}}\left(\left(A_{1} \times A_{1}^{\prime}\right)^{(1)}\right)$ is an extension of the direct product of the transformation groups $\left\langle\boldsymbol{s}_{0}, \boldsymbol{s}_{1}\right\rangle$ and $\left\langle\boldsymbol{w}_{0}, \boldsymbol{w}_{1}\right\rangle$ by the transformation $\boldsymbol{\pi}$. Furthermore, both $\left\langle\boldsymbol{s}_{0}, \boldsymbol{s}_{1}\right\rangle$ and $\left\langle\boldsymbol{w}_{0}, \boldsymbol{w}_{1}\right\rangle$ form the affine Weyl group of type $A_{1}^{(1)}$, and the transformation $\boldsymbol{\pi}$ corresponds to reflections of the two Dynkin diagrams of type $A_{1}^{(1)}$ associated with $\left\langle\boldsymbol{s}_{0}, \boldsymbol{s}_{1}\right\rangle$ and $\left\langle\boldsymbol{w}_{0}, \boldsymbol{w}_{1}\right\rangle$.

Let us give the transformations corresponding to the shift operators $T_{1}, T_{2}, T_{0}$ in Remark 2.4 with $n=2$ using the elements of $\widetilde{W}\left(\left(A_{1} \times A_{1}\right)^{(1)}\right)$. As noted in (2.21), $T_{1}$ and $T_{2}$ are given by

Remark 3.4. We here consider the $q$-Painlevé equation given by $\hat{T}_{0}$. However, from the actions of $T_{1}$ and $T_{2}$, we can also obtain different $q$-Painlevé equations (see, for example [21] 36]). In general, various discrete dynamical systems of Painlevé type can be obtained from elements of infinite order, not necessarily translations, in an (extended) affine Weyl group [23] 24].
3.2. Proof of Theorem 1.3 with $N \in \mathbb{Z}_{\geq 2}$. In this subsection, we consider the periodic reduction of the system (2.1) in the case $n=2 N(N=2,3, \ldots)$. The discussion is the same as in $\S 3.1$, so the details are omitted.

Imposing the periodic condition

In this section, we prove Theorems 1.6 and 1.7 that is, we construct Lax pairs of the systems (1.1) and (1.4). For detailed construction methods of a Lax pair of a Painlevé type difference equation from a higher dimensional CAC system using a periodic-reduction, see, for example, [19, 22].
4.1. Proof of Theorem 1.6 with $N=1$. Under the conditions (3.2) and (3.4), we consider the Lax equations (2.22) when $n=2$. Define the column vector of length two $\Phi$, the spectral variable $x$, and the spectral operator $T_{x}$ as

\Phi=\left(\begin{array}{cc}
\omega_{0}^{-2} & 0  \tag{4.1}\\
0 & 1
\end{array}\right) \phi(0,0,0), \quad x=\alpha^{(1)}(0)^{-1 / 2} \alpha^{(2)}(0)^{-1 / 2} \mu, \quad T_{x}=T_{1} T_{2} T_{0}
$$

where $T_{i}, i=0,1,2$, are given in Remarks 2.4 and 2.6 and

$$
\begin{equation*}
\omega_{0}=U(0,0,0) . \tag{4.2}
\end{equation*}
$$

From (2.22), we have

$$
\begin{align*}
& T_{i}(\Phi)=\left(\begin{array}{cc}
\frac{\mu \omega_{0}}{\alpha^{(i)}(0) T_{i}\left(\omega_{0}\right)} & -1 \\
1 & -\frac{\mu T_{i}\left(\omega_{0}\right)}{\alpha^{(i)}(0) \omega_{0}}
\end{array}\right) \Phi, \quad i=1,2,  \tag{4.3a}\\
& T_{0}(\Phi)=\left(\begin{array}{cc}
-\frac{\mu \kappa(0) \omega_{0}}{T_{0}\left(\omega_{0}\right)} & -1 \\
1 & 0
\end{array}\right) \Phi . \tag{4.3b}
\end{align*}
$$

Therefore, we obtain

$$
\begin{align*}
& T_{x}(\Phi)=\left(\begin{array}{cc}
-\frac{b x}{f_{1} f_{2}} & -1 \\
1 & 0
\end{array}\right)\left(\begin{array}{cc}
\frac{x f_{2}}{a_{1}} & -1 \\
1 & -\frac{x}{a_{1} f_{2}}
\end{array}\right)\left(\begin{array}{cc}
a_{1} x f_{1} & -1 \\
1 & -\frac{a_{1} x}{f_{1}}
\end{array}\right) \Phi,  \tag{4.4a}\\
& T_{0}(\Phi)=\left(\begin{array}{cc}
-\frac{b x}{T_{0}\left(f_{1}\right) T_{0}\left(f_{2}\right)} & -1 \\
1 & 0
\end{array}\right) \Phi . \tag{4.4b}
\end{align*}
$$

The action of $T_{x}$ on $\left\{a_{0}, a_{1}, b, q, f_{1}, f_{2}\right\}$ is given by

$$
\begin{equation*}
T_{x}:\left(a_{0}, a_{1}, b, q, f_{1}, f_{2}\right) \rightarrow\left(a_{0}, a_{1}, b, q, f_{1}, f_{2}\right), \tag{4.5}
\end{equation*}
$$

which is trivial, but that on the spectral parameter $x$ is not trivial as the following:

$$
\begin{equation*}
T_{x}(x)=q^{-2} x \tag{4.6}
\end{equation*}
$$

On the other hand, the action of $T_{0}$ on $\left\{a_{0}, a_{1}, b, q, x\right\}$ is given by

$$
\begin{equation*}
T_{0}:\left(a_{0}, a_{1}, b, q, x\right) \rightarrow\left(a_{0}, a_{1}, q^{-2} b, q, x\right) \tag{4.7}
\end{equation*}
$$

and that on $\left\{f_{1}, f_{2}\right\}$ is given by (3.20). Therefore, Theorem 1.6 with $N=1$ follows from (3.21), (4.4) and the following correspondence:

$$
\begin{equation*}
\Phi(x, t)=\Phi, \quad \Phi(p x, t)=T_{x}(\Phi), \quad \Phi(x, p t)=T_{0}(\Phi) \tag{4.8}
\end{equation*}
$$

Remark 4.1. As mentioned in $\$ 3.1$ the action of $\hat{T}_{0}$ and that of $T_{0}$ on the parameters $\left\{a_{0}, a_{1}, b, q\right\}$ and the variables $\left\{f_{1}, f_{2}\right\}$ are same, but their actions on the parameters $\left\{\alpha^{(1)}(0), \alpha^{(2)}(0), \kappa(0)\right\}$ are different. This difference gives their different actions on the spectral parameter $x$ as follows.

$$
\begin{equation*}
\hat{T}_{0}(x)=q^{2} x, \quad T_{0}(x)=x, \tag{4.9}
\end{equation*}
$$

which leads to the spectral operator $T_{x}$. Indeed, $T_{x}$ can also be written as

$$
\begin{equation*}
T_{x}=\hat{T}_{0}^{-1} T_{0} \tag{4.10}
\end{equation*}
$$

This idea was proposed in [19]. It is an extension of the ideas presented in [8, 13 14 39], where Lax pairs of discrete Painlevé equations are constructed from two-dimensional partial difference equations by using staircase methods.
4.2. Proof of Theorem 1.6 with $N \in \mathbb{Z}_{\geq 2}$. Under the conditions (3.22) and (3.24), we consider the Lax equation (2.22) when $n=2 N(N=2,3, \ldots)$. The discussion is the same as in $\$ 4.1$, so the details are omitted.

We define the column vector of length two $\Phi$, the spectral variable $x$, and the spectral operator $T_{x}$ as

\Phi=\left(\begin{array}{cc}
\omega_{0}^{-2} & 0  \tag{4.11}\\
0 & 1
\end{array}\right) \phi(0, \ldots, 0), \quad x=\left(\prod_{k=1}^{2 N} \alpha^{(k)}(0)^{-1 /(2 N)}\right) \mu, \quad T_{x}=T_{1} \cdots T_{2 N} T_{0}
$$

where $T_{i}, i=0, \ldots, 2 N$, are given in Remarks 2.4 and 2.6 and

$$
\begin{equation*}
\omega_{0}=U(0, \ldots, 0) \tag{4.12}
\end{equation*}
$$

From (2.22), we have

$$
\begin{align*}
& T_{i}(\Phi)=\left(\begin{array}{cc}
\frac{\mu \omega_{0}}{\alpha^{(i)}(0) T_{i}\left(\omega_{0}\right)} & -1 \\
1 & -\frac{\mu T_{i}\left(\omega_{0}\right)}{\alpha^{(i)}(0) \omega_{0}}
\end{array}\right) \Phi, \quad i=1, \ldots, 2 N,  \tag{4.13a}\\
& T_{0}(\Phi)=\left(\begin{array}{cc}
-\frac{\mu \kappa(0) \omega_{0}}{T_{0}\left(\omega_{0}\right)} & -1 \\
1 & 0
\end{array}\right) \Phi . \tag{4.13b}
\end{align*}
$$

Therefore, we obtain

$$
T_{x}(\Phi)=\left(\begin{array}{cc}
-\frac{b x}{2 N} & -1  \tag{4.14}\\
\prod_{k=1}^{2 N} f_{k} & \\
1 & 0
\end{array}\right) L_{2 N} \ldots L_{1} \Phi, \quad T_{0}(\Phi)=\left(\begin{array}{cc}
-\frac{b x}{2 N} T_{k=1}^{2}\left(f_{k}\right) & -1 \\
1 & 0
\end{array}\right) \Phi,
$$

where

$$
L_{i}=\left(\begin{array}{cc}
\frac{\left(\prod_{k=1}^{2 N-i} a_{2 N-k}^{k}\right) x f_{i}}{} & -1  \tag{4.15}\\
\prod_{k=1}^{i-1} a_{k}^{k} & \left(\begin{array}{c}
\left(\prod_{k=1}^{2 N-i} a_{2 N-k}^{k}\right) x \\
1
\end{array}\right. \\
\left(\prod_{k=1}^{i-1} a_{k}^{k}\right) f_{i}
\end{array}\right), \quad i=1, \ldots, 2 N .
$$

The actions of $T_{x}$ and $T_{0}$ on the parameters $\left\{a_{0}, \ldots, a_{2 N-1}, b, x, q\right\}$ are given by

$$
\begin{align*}
& T_{x}:\left(a_{0}, \ldots, a_{2 N-1}, b, x, q\right) \rightarrow\left(a_{0}, \ldots, a_{2 N-1}, b, q^{-2 N} x, q\right),  \tag{4.16a}\\
& T_{0}:\left(a_{0}, \ldots, a_{2 N-1}, b, x, q\right) \rightarrow\left(a_{0}, \ldots, a_{2 N-1}, q^{-2 N} b, x, q\right) . \tag{4.16b}
\end{align*}
$$

Note that the action of $T_{x}$ on the $f$ variables is trivial, and that of $T_{0}$ is given by (3.33). Therefore, Theorem 1.6 with $N \in \mathbb{Z}_{\geq 2}$ follows from (4.14) and the correspondences (3.40) and (4.8).
4.3. Proof of Theorem 1.7. Under the conditions (3.41) and (3.43), we consider the Lax equation (2.22) when $n=2 N+1(N=1,2, \ldots)$. The discussion is the same as in $\$ 4.1$ so the details are omitted. Note that the result for $N=1$ is the same as that in [22].

We define the column vector of length two $\Phi$, the spectral variable $x$, and the spectral operator $T_{x}$ as

$$
\begin{align*}
& \Psi=\left(\begin{array}{cc}
\omega_{2 N+1}^{-1} & 0 \\
0 & \omega_{0}
\end{array}\right) \phi(0, \ldots, 0,-1), \quad x=\left(\prod_{k=1}^{2 N+1} \alpha^{(k)}(0)^{-1 /(2 N+1)}\right) \mu,  \tag{4.17a}\\
& T_{x}=T_{0} T_{1} \cdots T_{2 N+1}, \tag{4.17b}
\end{align*}
$$

where $T_{i}, i=0, \ldots, 2 N+1$, are given in Remarks 2.4 and 2.6 Here, the variables $\omega_{i}$, $i=0, \ldots, 2 N+1$, are given by (3.45). From (2.22), we have

$$
T_{i}(\Psi)=\left(\begin{array}{cc}
\frac{\mu}{\alpha^{(i)}(0)} & -\frac{c T_{i}\left(\omega_{2 N+1}\right)}{\omega_{0}}  \tag{4.18a}\\
\frac{T_{i}\left(\omega_{0}\right)}{c \omega_{2 N+1}} & -\frac{\mu T_{i}\left(\omega_{0}\right) T_{i}\left(\omega_{2 N+1}\right)}{\alpha^{(i)}(0) \omega_{0} \omega_{2 N+1}}
\end{array}\right) \Psi, \quad i=1, \ldots, 2 N+1,
$$

$$
T_{0}(\Psi)=\left(\begin{array}{cc}
-\mu \kappa(-1) & -\frac{1}{c^{2}}  \tag{4.18b}\\
\frac{c^{2} T_{0}\left(\omega_{0}\right)}{\omega_{2 N+1}} & 0
\end{array}\right) \Psi
$$

Therefore, we obtain

$$
\begin{equation*}
T_{x}(\Psi)=L_{2 N+1} \ldots L_{0} \Psi, \quad T_{0}(\Psi)=L_{0} \Psi \tag{4.19}
\end{equation*}
$$

where

$$
\begin{align*}
& L_{0}=\left(\begin{array}{cc}
-\mu \kappa(-1) & -\frac{1}{c^{2}} \\
\frac{c^{2} T_{0}\left(\omega_{0}\right)}{\omega_{2 N+1}} & 0
\end{array}\right)=-\left(\begin{array}{cc}
\frac{1}{c} & 0 \\
0 & -\frac{T_{0}\left(\omega_{0}\right)}{\omega_{1}}
\end{array}\right)\left(\begin{array}{cc}
\mu \kappa(-1) c & \frac{1}{c} \\
\frac{c^{2} \omega_{1}}{\omega_{2 N+1}} & 0
\end{array}\right),  \tag{4.20a}\\
& L_{i}=\left(\begin{array}{cc}
\frac{\mu}{\alpha^{(i)}(0)} & -\frac{c^{(-1)^{i}} \omega_{i}}{T_{0}\left(\omega_{i-1}\right)} \\
\frac{T_{0}\left(\omega_{i}\right)}{c^{(-1)^{i}} \omega_{i-1}} & -\frac{\mu \omega_{i} T_{0}\left(\omega_{i}\right)}{\alpha^{(i)}(0) \omega_{i-1} T_{0}\left(\omega_{i-1}\right)}

& =\left(\begin{array}{cc}
c^{(-1)^{i}} & 0 \\
0 & \frac{T_{0}\left(\omega_{i}\right)}{\omega_{i-1}}

1 & \frac{\mu}{\alpha^{(i)}(0)}
\end{array}\right)\left(\begin{array}{cc}
\frac{1}{c^{(-1)^{i}}} & 0 \\
0 & -\frac{\omega_{i}}{T_{0}\left(\omega_{i-1}\right)}
\end{array}\right), \\
& i=1, \ldots, 2 N+1 \text {. } \tag{4.20b}
\end{align*}

In the following, let us rewrite the equations above in notation with the parameters $\left\{a_{0}, \ldots, a_{2 N}, b, c, x\right\}$ and the $f$ variables. Letting

1 & \frac{\mu}{\alpha^{(i)}(0)}
\end{array}\right)=\left(\begin{array}{cc}
\prod_{k=i}^{2 N} a_{k}^{2 N+1} \\
\prod_{k=1}^{2 N} a_{k}^{k} & 1 \\
1 & \frac{\prod_{k=i}^{2 N} a_{k}^{2 N+1}}{2 N} x \\
\prod_{k=1}^{k} a_{k}^{k}
\end{array}\right), \quad i=1, \ldots, 2 N+1,  \tag{4.21a}\\
& K_{j}=\left(\begin{array}{cc}
c^{2(-1)^{j}} & 0 \\
0 & -\frac{\omega_{j+1}}{\omega_{j-1}}
\end{array}\right)=\left(\begin{array}{cc}
c^{2(-1)^{j}} & 0 \\
0 & -\frac{1}{f_{j}}
\end{array}\right), \tag{4.21b}
\end{align*}
$$

we obtain

$$
\begin{align*}
T_{x}(\Psi) & =-\left(\begin{array}{cc}
\frac{1}{c} & 0 \\
0 & \frac{\omega_{0}}{\omega_{2 N}}
\end{array}\right) M_{2 N+1} K_{2 N} M_{2 N} \ldots K_{1} M_{1}\left(\begin{array}{cc}
\mu \kappa(-1) c & \frac{1}{c} \\
\frac{c^{2} \omega_{1}}{\omega_{2 N+1}} & 0
\end{array}\right) \Psi \\
& =-\left(\begin{array}{cc}
\frac{1}{c} & 0 \\
0 & \prod_{k=1}^{N} f_{2 k-1}
\end{array}\right) M_{2 N+1} K_{2 N} M_{2 N} \ldots K_{1} M_{1}\left(\begin{array}{cc}
q^{2 N+1} b c x & \frac{1}{c} \\
c^{2}\left(\prod_{k=1}^{N} f_{2 k}\right) & 0
\end{array}\right) \Psi . \tag{4.22}
\end{align*}

Moreover, from (2.1b) we obtain

-\frac{T_{0}\left(\omega_{0}\right)}{\omega_{1}}=\frac{T_{0}\left(\omega_{1}\right)}{c^{4} \omega_{0}}+\frac{\alpha^{(1)}(0) \kappa(0)}{c^{3}}=\frac{1}{c^{4}}\left(\prod_{k=1}^{N} T_{0}\left(f_{2 k}\right)\right)+\frac{b}{c^{3}}\left(\prod_{k=1}^{2 N} a_{k}^{k-2 N-1}\right), \tag{4.23}
\end{equation*}
$$

which gives

T_{0}(\Psi)=-\left(\begin{array}{cc}
\frac{1}{c} & 0  \tag{4.24}\\
0 & \frac{1}{c^{4}}\left(\prod_{k=1}^{N} T_{0}\left(f_{2 k}\right)\right)+\frac{b}{c^{3}}\left(\prod_{k=1}^{2 N} a_{k}^{k-2 N-1}\right)
\end{array}\right)\left(\begin{array}{cc}
q^{2 N+1} b c x & \frac{1}{c} \\
c^{2}\left(\prod_{k=1}^{N} f_{2 k}\right) & 0
\end{array}\right) \Psi .
$$

The actions of $T_{x}$ and $T_{0}$ on the parameters $\left\{a_{0}, \ldots, a_{2 N}, b, c, x, q\right\}$ are given by

$$
\begin{align*}
& T_{x}:\left(a_{0}, \ldots, a_{2 N}, b, c, x, q\right) \rightarrow\left(a_{0}, \ldots, a_{2 N}, b, c, q^{-2 N-1} x, q\right),  \tag{4.25a}\\
& T_{0}:\left(a_{0}, \ldots, a_{2 N}, b, c, x, q\right) \rightarrow\left(a_{0}, \ldots, a_{2 N}, q^{-2 N-1} b, c^{-1}, x, q\right) . \tag{4.25b}
\end{align*}
$$

Note that the action of $T_{x}$ on the $f$ variables is trivial, and that of $T_{0}$ is given by (3.53). Therefore, Theorem 1.7 follows from (3.60), (4.22), (4.24) and the following correspondence:

$$
\begin{equation*}
\Psi(x, t)=\Psi, \quad \Psi(p x, t)=T_{x}(\Psi), \quad \Psi(x, p t)=T_{0}(\Psi) \tag{4.26}
\end{equation*}
$$

Note that the coefficient matrix in Theorem 1.7 is multiplied by $(-1)$ for simplicity. The following gauge transformation can explain this multiplication:

\Psi \rightarrow \frac{\Theta(-x t ; p)}{\Theta(x t ; p)} \Psi \tag{4.27}
\end{equation*}
$$

where $\Theta(a ; p)$ is the modified Jacobi theta function [11] satisfying

\frac{\Theta(p a ; p)}{\Theta(a ; p)}=-a^{-1} . \tag{4.28}
\end{equation*}
$$

## 5. Concluding remarks

In this paper, we have constructed the higher-order $q$-Painlevé systems (1.1) and (1.4), which include second-order $q$-Painlevé equations of $A_{6}^{(1)}$ - and $A_{4}^{(1)}$-surface type, respectively. We also obtained their extended affine Weyl group symmetries and Lax pairs.

KNY's representation is well known for giving a high-dimensional extension of $q$ Painlevé equations [25, 26]. As explained in $\S\left(1.2\right.$, it was extended from $\left(A_{m-1} \times A_{n-1}\right)^{(1)}$ type to $\left(A_{m-1} \times A_{n-1} \times A_{g-1}\right)^{(1)}$-type by using the theory of cluster algebra [30]32]. Similarly, it is expected that the symmetries of the systems (1.1) and (1.4) can be extended. From the perspective of this study, we consider that the multi-component extension of CAC systems [62] is effective. Other approaches based on cluster algebra [17, 30, 32, 45] and birational representation of affine Weyl group [25, 26, 29, 48, 59] also seem to be highly effective. Research on this extension is a subject for future study.
