# Well-foundedness proof for $\Pi_{1}^{1}$-reflection

#### Abstract

In 4 it is shown that an ordinal $\psi_{\Omega}\left(\varepsilon_{\mathbb{S}++1}\right)$ is an upper bound for the proof-theoretic ordinal of a set theory $\mathrm{KP} \omega+\left(M \prec \Sigma_{1} V\right)$. In this note we show that $\mathrm{KP} \omega+\left(M \prec \Sigma_{1} V\right)$ proves the well-foundedness up to $\psi_{\Omega}\left(\omega_{n}\left(\mathbb{S}^{+}+1\right)\right)$ for each $n$.


## 1 Introduction

In 4 the following theorem is shown, where $\mathrm{KP} \omega+\left(M \prec_{\Sigma_{1}} V\right)$ extends $\mathrm{KP} \omega$ with an axiom stating that 'there exists an non-empty and transitive set $M$ such that $M \prec_{\Sigma_{1}} V^{\prime}, ~ \Omega=\omega_{1}^{C K}$ and $\psi_{\Omega}$ is a collapsing function such that $\psi_{\Omega}(\alpha)<\Omega . \mathbb{S}$ is an ordinal term denoting a stable ordinal, and $\mathbb{S}^{+}$the least admissible ordinal above $\mathbb{S}$ in the theorems.

Theorem 1.1 Suppose $\mathrm{KP} \omega+\left(M \prec \Sigma_{1} V\right) \vdash \theta^{L_{\Omega}}$ for a $\Sigma_{1}$-sentence $\theta$. Then we can find an $n<\omega$ such that for $\alpha=\psi_{\Omega}\left(\omega_{n}\left(\mathbb{S}^{+}+1\right)\right), L_{\alpha} \models \theta$.
$O T$ denotes a computable notation system of ordinals in [2] for an ordinal analysis of $\mathrm{KP} \ell^{r}+\left(M \varsigma_{1} V\right)$, or equivalently of $\Sigma_{2}^{1-}-\mathrm{CA}+\Pi_{1}^{1}-\mathrm{CA}_{0} . O T_{N}$ is a restriction of $O T$ such that $O T=\bigcup_{0<N<\omega} O T_{N}$ and $\psi_{\Omega}\left(\varepsilon_{\Omega_{\mathrm{s}+N}+1}\right)$ denotes the order type of $O T_{N} \cap \Omega$. Let $O T\left(\Pi_{1}^{1}\right)=O T_{1}$. The aim of this paper is to show the following theorem, thereby the bound in Theorem 1.1 is seen to be tight.

Theorem 1.2 $\mathrm{KP} \omega+\left(M \prec_{1} V\right)$ proves the well-foundedness up to $\psi_{\Omega}\left(\omega_{n}\left(\mathbb{S}^{+}+\right.\right.$ 1)) for each $n$.

The ordinal $\psi_{\Omega}\left(\varepsilon_{\mathbb{S}^{+}+1}\right)$ is the proof-theoretic ordinal of $\mathrm{KP} \omega+\left(M \prec_{\Sigma_{1}} V\right)$.
Theorem $1.3 \psi_{\Omega}\left(\varepsilon_{\mathbb{S}^{+}+1}\right)=\left|\operatorname{KP} \omega+\left(M \prec_{\Sigma_{1}} V\right)\right|_{\Sigma_{1}^{\Omega}}$.
To prove the well-foundedness of a computable notation system, we utilize the distinguished class introduced by W. Buchholz [5].

A set theory $\mathrm{KP} \omega+\left(M \prec_{\Sigma_{1}} V\right)$ extends $\mathrm{KP} \omega$ by adding an individual constant $M$ and the axioms for the constant $M: M$ is non-empty $M \neq \emptyset$,
transitive $\forall x \in M \forall y \in x(y \in M)$, and stable $M \prec_{\Sigma_{1}} V$ for the universe $V$. $M \prec \Sigma_{1} V$ means that $\varphi\left(u_{1}, \ldots, u_{n}\right) \wedge\left\{u_{1}, \ldots, u_{n}\right\} \subset M \rightarrow \varphi^{M}\left(u_{1}, \ldots, u_{n}\right)$ for each $\Sigma_{1}$-formula $\varphi$ in the set-theoretic language.

Since the axiom $\beta$ does not hold in the theory $\operatorname{KP} \omega+\left(M \prec \Sigma_{1} V\right)$, we need to modify the proof in [2], cf. subsection [3.1] Proofs of propositions and lemmas are omitted when they are found in [1, 2].

## 2 Ordinals for one stable ordinal

In this section let us recall briefly ordinal notations systems in [2].
For ordinals $\alpha \geq \beta, \alpha-\beta$ denotes the ordinal $\gamma$ such that $\alpha=\beta+\gamma$. Let $\alpha$ and $\beta$ be ordinals. $\alpha \dot{+} \beta$ denotes the sum $\alpha+\beta$ when $\alpha+\beta$ equals to the commutative (natural) sum $\alpha \# \beta$, i.e., when either $\alpha=0$ or $\alpha=\alpha_{0}+\omega^{\alpha_{1}}$ with $\omega^{\alpha_{1}+1}>\beta$.
$\mathbb{S}$ denotes a weakly inaccessible cardinal, and $\Lambda=\mathbb{S}^{+}$the next regular cardinal above $\mathbb{S}$.

Definition 2.1 Let $\Lambda=\mathbb{S}^{+} . \varphi_{b}(\xi)$ denotes the binary Veblen function on $\Lambda^{+}$ with $\varphi_{0}(\xi)=\omega^{\xi}$, and $\tilde{\varphi}_{b}(\xi):=\varphi_{b}(\Lambda \cdot \xi)$ for the epsilon number $\Lambda$.

Let $b, \xi<\Lambda^{+} . \theta_{b}(\xi)\left[\tilde{\theta}_{b}(\xi)\right]$ denotes a $b$-th iterate of $\varphi_{0}(\xi)=\omega^{\xi}\left[\right.$ of $\tilde{\varphi}_{0}(\xi)=$ $\left.\Lambda^{\xi}\right]$, resp.

Definition 2.2 Let $\xi<\varphi_{\Lambda}(0)$ be a non-zero ordinal with its normal form:

where $\tilde{\theta}_{b_{i}}\left(\xi_{i}\right)>\xi_{i}, \tilde{\theta}_{b_{m}}\left(\xi_{m}\right)>\cdots>\tilde{\theta}_{b_{0}}\left(\xi_{0}\right), b_{i}=\omega^{c_{i}}<\Lambda$, and $0<a_{0}, \ldots, a_{m}<$几. $S C_{\Lambda}(\xi)=\bigcup_{i \leq m}\left(\left\{a_{i}\right\} \cup S C_{\Lambda}\left(\xi_{i}\right)\right)$.
$\tilde{\theta}_{b_{0}}\left(\xi_{0}\right)$ is said to be the tail of $\xi$, denoted $\tilde{\theta}_{b_{0}}\left(\xi_{0}\right)=\operatorname{tl}(\xi)$, and $\tilde{\theta}_{b_{m}}\left(\xi_{m}\right)$ the head of $\xi$, denoted $\tilde{\theta}_{b_{m}}\left(\xi_{m}\right)=h d(\xi)$.

1. $\zeta$ is a segment of $\xi$ iff there exists an $n(0 \leq n \leq m+1)$ such that $\zeta={ }_{N F} \sum_{i \geq n} \tilde{\theta}_{b_{i}}\left(\xi_{i}\right) \cdot a_{i}=\tilde{\theta}_{b_{m}}\left(\xi_{m}\right) \cdot a_{m}+\cdots+\tilde{\theta}_{b_{n}}\left(\overline{\xi_{n}}\right) \cdot a_{n}$ for $\xi$ in (11).
2. Let $\zeta={ }_{N F} \tilde{\theta}_{b}(\xi)$ with $\tilde{\theta}_{b}(\xi)>\xi$ and $b=\omega^{b_{0}}$, and $c$ be ordinals. An ordinal $\tilde{\theta}_{-c}(\zeta)$ is defined recursively as follows. If $b \geq c$, then $\tilde{\theta}_{-c}(\zeta)=\tilde{\theta}_{b-c}(\xi)$. Let $c>b$. If $\xi>0$, then $\tilde{\theta}_{-c}(\zeta)=\tilde{\theta}_{-(c-b)}\left(\tilde{\theta}_{b_{m}}\left(\xi_{m}\right)\right)$ for the head term $h d(\xi)=\tilde{\theta}_{b_{m}}\left(\xi_{m}\right)$ of $\xi$ in (11). If $\xi=0$, then let $\tilde{\theta}_{-c}(\zeta)=0$.

Definition 2.3 1. A function $f: \Lambda \rightarrow \varphi_{\Lambda}(0)$ with a finite $\operatorname{support} \operatorname{supp}(f)=$ $\{c<\Lambda: f(c) \neq 0\} \subset \Lambda$ is said to be a finite function if $\forall i>0\left(a_{i}=1\right)$ and $a_{0}=1$ when $b_{0}>1$ in $f(c)=_{N F} \tilde{\theta}_{b_{m}}\left(\xi_{m}\right) \cdot a_{m}+\cdots+\tilde{\theta}_{b_{0}}\left(\xi_{0}\right) \cdot a_{0}$ for any $c \in \operatorname{supp}(f)$.
It is identified with the finite function $f \upharpoonright \operatorname{supp}(f)$. When $c \notin \operatorname{supp}(f)$, let $\left.f(c):=0 . S C_{\Lambda}(f):=\bigcup\left\{\{c\} \cup S C_{\Lambda}(f(c))\right\}: c \in \operatorname{supp}(f)\right\} . f, g, h, \ldots$ range over finite functions.

For an ordinal $c, f_{c}$ and $f^{c}$ are restrictions of $f$ to the domains $\operatorname{supp}\left(f_{c}\right)=$ $\{d \in \operatorname{supp}(f): d<c\}$ and $\operatorname{supp}\left(f^{c}\right)=\{d \in \operatorname{supp}(f): d \geq c\} . g_{c} * f^{c}$ denotes the concatenated function $\operatorname{such}$ that $\operatorname{supp}\left(g_{c} * f^{c}\right)=\operatorname{supp}\left(g_{c}\right) \cup$ $\operatorname{supp}\left(f^{c}\right),\left(g_{c} * f^{c}\right)(a)=g(a)$ for $a<c$, and $\left(g_{c} * f^{c}\right)(a)=f(a)$ for $a \geq c$.
2. Let $f$ be a finite function and $c, \xi$ ordinals. A relation $f<^{c} \xi$ is defined by induction on the cardinality of the finite set $\{d \in \operatorname{supp}(f): d>c\}$ as follows. If $f^{c}=\emptyset$, then $f<^{c} \xi$ holds. For $f^{c} \neq \emptyset, f<^{c} \xi$ iff there exists a segment $\mu$ of $\xi$ such that $f(c)<\mu$ and $f<^{c+d} \tilde{\theta}_{-d}(t l(\mu))$ for $d=\min \{c+d \in \operatorname{supp}(f): d>0\}$.

Proposition $2.4 f<^{c} \xi \leq \zeta \Rightarrow f<^{c} \zeta$.
In the following Definition 2.5] $\varphi \alpha \beta=\varphi_{\alpha}(\beta)$ denotes the binary Veblen function on $\Lambda^{+}=\mathbb{S}^{++}, \tilde{\theta}_{b}(\xi)$ the function defined in Definition 2.1 for $\Lambda=\mathbb{S}^{+}$. For $\alpha<\mathbb{S}, \alpha^{+}$denotes the next regular cardinal above $\alpha$.

For $a<\varepsilon_{\Lambda+1}, c<\Lambda$, and $\xi<\Gamma_{\Lambda+1}$, define simultaneously classes $\mathcal{H}_{a}(X) \subset$ $\Gamma_{\Lambda+1}, M h_{c}^{a}(\xi) \subset(\mathbb{S}+1)$, and ordinals $\psi_{\kappa}^{f}(a) \leq \kappa$ by recursion on ordinals $a$ as follows.

Definition 2.5 Let $\Lambda=\mathbb{S}^{+}$. Let $a<\varepsilon_{\Lambda+1}$ and $X \subset \Gamma_{\Lambda+1}$.

1. (Inductive definition of $\mathcal{H}_{a}(X)$.)
(a) $\left\{0, \Omega_{1}, \mathbb{S}, \mathbb{S}^{+}\right\} \cup X \subset \mathcal{H}_{a}(X)$.
(b) If $x, y \in \mathcal{H}_{a}(X)$, then $x+y \in \mathcal{H}_{a}(X)$, and $\varphi x y \in \mathcal{H}_{a}(X)$.
(c) Let $\alpha \in \mathcal{H}_{a}(X) \cap \mathbb{S}$. Then $\alpha^{+} \in \mathcal{H}_{a}(X)$.
(d) Let $\alpha=\psi_{\pi}^{f}(b)$ with $\{\pi, b\} \subset \mathcal{H}_{a}(X), b<a$, and a finite function $f$ such that $S C_{\Lambda}(f) \subset \mathcal{H}_{a}(X) \cap \mathcal{H}_{b}(\alpha)$. Then $\alpha \in \mathcal{H}_{a}(X)$.
2. (Definitions of $M h_{c}^{a}(\xi)$ and $M h_{c}^{a}(f)$ )

The classes $M h_{c}^{a}(\xi)$ are defined for $c<\Lambda$, and ordinals $a<\varepsilon_{\Lambda+1}, \xi<$ $\Gamma_{\Lambda+1}$. Let $\pi$ be a regular ordinal $\leq \mathbb{S}$. Then by main induction on ordinals $\pi \leq \mathbb{S}$ with subsidiary induction on $c<\Lambda$ we define $\pi \in M h_{c}^{a}(\xi)$ iff $\{a, c, \xi\} \subset \mathcal{H}_{a}(\pi)$ and

where $f, g$ vary through finite functions, and

M h_{c}^{a}(f) & :=\bigcap\left\{M h_{d}^{a}(f(d)): d \in \operatorname{supp}\left(f^{c}\right)\right\} \\
& =\bigcap\left\{M h_{d}^{a}(f(d)): c \leq d \in \operatorname{supp}(f)\right\}
\end{aligned}
$$

In particular $M h_{0}^{a}\left(g_{c}\right)=\bigcap\left\{M h_{d}^{a}(g(d)): d \in \operatorname{supp}\left(g_{c}\right)\right\}=\bigcap\left\{M h_{d}^{a}(g(d)):\right.$ $c>d \in \operatorname{supp}(g)\}$. When $f=\emptyset$ or $f^{c}=\emptyset$, let $M h_{c}^{a}(\emptyset):=\Lambda$.
3. (Definition of $\left.\psi_{\pi}^{f}(a)\right)$

Let $a<\varepsilon_{\Lambda+1}$ be an ordinal, $\pi$ a regular ordinal and $f$ a finite function. Then let
$\psi_{\pi}^{f}(a):=\min \left(\{\pi\} \cup\left\{\kappa \in M h_{0}^{a}(f) \cap \pi: \mathcal{H}_{a}(\kappa) \cap \pi \subset \kappa,\{\pi, a\} \cup S C_{\Lambda}(f) \subset \mathcal{H}_{a}(\kappa)\right\}\right)$
For the empty function $\emptyset, \psi_{\pi}(a):=\psi_{\pi}^{\emptyset}(a)$.
4. For classes $A \subset(\mathbb{S}+1)$, let $\alpha \in M_{c}^{a}(A)$ iff $\alpha \in A$ and

Assuming an existence of a shrewd cardinal introduced by M. Rathjen 6], we show in 3 that $\psi_{\mathbb{S}}^{f}(a)<\mathbb{S}$ if $\{a, c, \xi\} \subset \mathcal{H}_{a}(\mathbb{S})$ with $c<\mathbb{S}^{+}, a, \xi<\varepsilon_{\mathbb{S}^{+}+1}$, and $\operatorname{supp}(f)=\{c\}$ and $f(c)=\xi$. Moreover $\psi_{\pi}^{g}(b)<\pi$ provided that $\pi \in M h_{0}^{b}(f)$, $S C_{\Lambda}(g) \cup\{\pi, b\} \subset \mathcal{H}_{b}(\pi)$, and $g$ is a finite function defined from a finite function $f$ and ordinals $d, c$ as follows. $d<c \in \operatorname{supp}(f)$ with $(d, c) \cap \operatorname{supp}(f)=(d, c) \cap$ $\operatorname{supp}(g)=\emptyset, g_{d}=f_{d}, g(d)<f(d)+\tilde{\theta}_{c-d}(f(c)) \cdot \omega$, and $g<^{c} f(c)$. Also the following Lemma 2.6 is shown in (3).

Lemma 2.6 Assume $\mathbb{S} \geq \pi \in M h_{d}^{a}(\xi) \cap M h_{c}^{a}\left(\xi_{0}\right), \xi_{0} \neq 0, d<c$, and $\{a, c, d\} \subset$ $\mathcal{H}_{a}(\pi)$. Moreover let $\tilde{\theta}_{c-d}\left(\xi_{0}\right) \geq \xi_{1} \in \mathcal{H}_{a}(\pi)$ and $t l(\xi)>\xi_{1}$ when $\xi \neq 0$. Then $\pi \in M h_{d}^{a}\left(\xi+\xi_{1}\right) \cap M_{d}^{a}\left(M h_{d}^{a}\left(\xi+\xi_{1}\right)\right)$.

### 2.1 Normal forms in ordinal notations

Definition 2.7 An irreducibility of finite functions $f$ is defined by induction on the cardinality $n$ of the finite set $\operatorname{supp}(f)$. If $n \leq 1, f$ is defined to be irreducible. Let $n \geq 2$ and $c<c+d$ be the largest two elements in $\operatorname{supp}(f)$, and let $g$ be a finite function such that $\operatorname{supp}(g)=\operatorname{supp}\left(f_{c}\right) \cup\{c\}, g_{c}=f_{c}$ and $g(c)=f(c)+\tilde{\theta}_{d}(f(c+d))$. Then $f$ is irreducible iff $t l(f(c))>\tilde{\theta}_{d}(f(c+d))$ and $g$ is irreducible.

Definition 2.8 Let $f, g$ be irreducible functions, and $b, a$ ordinals.

1. Let us define a relation $f<_{l x}^{b} g$ by induction on the cardinality of the finite set $\{e \in \operatorname{supp}(f) \cup \operatorname{supp}(g): e \geq b\}$ as follows. $f<_{l x}^{b} g$ holds iff $f^{b} \neq g^{b}$ and for the ordinal $c=\min \{c \geq b: f(c) \neq g(c)\}$, one of the following conditions is met:
(a) $f(c)<g(c)$ and let $\mu$ be the shortest segment of $g(c)$ such that $f(c)<\mu$. Then for any $c<c+d \in \operatorname{supp}(f)$, if $t l(\mu) \leq \tilde{\theta}_{d}(f(c+d))$, then $f<_{l x}^{c+d} g$ holds.
(b) $f(c)>g(c)$ and let $\nu$ be the shortest segment of $f(c)$ such that $\nu>g(c)$. Then there exist a $c<c+d \in \operatorname{supp}(g)$ such that $f<_{l x}^{c+d} g$ and $t l(\nu) \leq \tilde{\theta}_{d}(g(c+d))$.
2. $M h_{b}^{a}(f) \prec M h_{b}^{a}(g)$ holds iff

\forall \pi \in M h_{b}^{a}(g) \forall b_{0} \leq b\left(S C_{\Lambda}(f) \subset \mathcal{H}_{a}(\pi) \& \pi \in M h_{b_{0}}^{a}\left(f_{b}\right) \Rightarrow \pi \in M\left(M h_{b_{0}}^{a}(f)\right)\right)
$$

Lemma 2.9 Let $f, g$ be irreducible finite functions, and $b$ an ordinal such that $f^{b} \neq g^{b}$. If $f<_{l x}^{b} g$, then $M h_{b}^{a}(f) \prec M h_{b}^{a}(g)$ holds for every ordinal $a$.

Proposition 2.10 Let $f, g$ be irreducible finite functions, and assume that $\psi_{\pi}^{f}(b)<$ $\pi$ and $\psi_{\kappa}^{g}(a)<\kappa$.

Then $\psi_{\pi}^{f}(b)<\psi_{k}^{g}(a)$ iff one of the following cases holds:

1. $\pi \leq \psi_{\kappa}^{g}(a)$.
2. $b<a, \psi_{\pi}^{f}(b)<\kappa$ and $S C_{\Lambda}(f) \cup\{\pi, b\} \subset \mathcal{H}_{a}\left(\psi_{\kappa}^{g}(a)\right)$.
3. $b>a$ and $S C_{\Lambda}(g) \cup\{\kappa, a\} \not \subset \mathcal{H}_{b}\left(\psi_{\pi}^{f}(b)\right)$.
4. $b=a, \kappa<\pi$ and $\kappa \notin \mathcal{H}_{b}\left(\psi_{\pi}^{f}(b)\right)$.
5. $b=a, \pi=\kappa, S C_{\Lambda}(f) \subset \mathcal{H}_{a}\left(\psi_{\kappa}^{g}(a)\right)$, and $f<_{l x}^{0} g$.
6. $b=a, \pi=\kappa, S C_{\Lambda}(g) \not \subset \mathcal{H}_{b}\left(\psi_{\pi}^{f}(b)\right)$.

Definition 2.11 1. $a(\xi)$ denotes an ordinal defined recursively by $a(0)=0$, and $a(\xi)=\sum_{i \leq m} \tilde{\theta}_{b_{i}}\left(\omega \cdot a\left(\xi_{i}\right)\right)$ when $\xi={ }_{N F} \sum_{i \leq m} \tilde{\theta}_{b_{i}}\left(\xi_{i}\right) \cdot a_{i}$ in (1).
2. For irreducible functions $f$ let us associate ordinals $o(f)<\Gamma_{\mathbb{S}++1}$ as follows. $o(\emptyset)=0$ for the empty function $f=\emptyset$. Let $\{0\} \cup \operatorname{supp}(f)=\{0=$ $\left.c_{0}<c_{1}<\cdots<c_{n}\right\}, f\left(c_{i}\right)=\xi_{i}<\Gamma_{\mathbb{S}_{++1}}$ for $i>0$, and $\xi_{0}=0$. Define ordinals $\zeta_{i}=o\left(f ; c_{i}\right)$ by $\zeta_{n}=\omega \cdot a\left(\xi_{n}\right)$, and $\zeta_{i}=\omega \cdot a\left(\xi_{i}\right)+\tilde{\theta}_{c_{i+1}-c_{i}}\left(\zeta_{i+1}+1\right)$. Finally let $o(f)=\zeta_{0}=o\left(f ; c_{0}\right)$.
3. Let $S C_{\Lambda}(f)<\mu<\Lambda$ be an epsilon number. Then $o_{\mu}(f)$ is defined from $o(f)$ by replacing the base $\Lambda$ of $\tilde{\theta}$ in $f(c)$ by $\mu$. This means that $\Lambda$ is replaced by $\mu$, and $\tilde{\theta}_{1}(\xi)=\Lambda^{\xi}$ by $\mu^{\xi}$.

Moreover when $S C_{\Lambda}(f, g)<\mu<\Lambda, o_{\mu}(f)<o_{\mu}(g)$ holds.
Lemma 2.13 For irreducible finite functions $f$ and $g$, assume $f<_{l x}^{0} g$. Then $o(f)<o(g)$ holds.

Moreover when $S C_{\Lambda}(f, g)<\mu<\Lambda, o_{\mu}(f)<o_{\mu}(g)$ holds.
By Proposition 2.10 a notation system $O T\left(\Pi_{1}^{1}\right)=O T_{1}$ is defined.

Definition $2.14 O T\left(\Pi_{1}^{1}\right)$ is closed under $\mathbb{S}>\alpha \mapsto \alpha^{+}$. There are two cases when an ordinal term $\psi_{\pi}^{f}(a)$ is constructed in $O T\left(\Pi_{1}^{1}\right)$, from $\{\pi, a\} \subset O T\left(\Pi_{1}^{1}\right)$ and an irreducible function $f$ with $S C_{\Lambda}(f) \subset O T\left(\Pi_{1}^{1}\right)$ and $\Lambda=\mathbb{S}^{+} . E_{\mathbb{S}}(\alpha)$ denotes the set of subterms $<\mathbb{S}$ of $\alpha$.

1. Let $\xi, a, c \in O T\left(\Pi_{1}^{1}\right), \xi>0, c<\mathbb{S}^{+}$and $\{\xi, a, c\} \subset \mathcal{H}_{a}(\alpha)$. Let $f=m(\alpha)$.
2. Let $\{a, d, \pi\} \subset O T\left(\Pi_{1}^{1}\right), f=m(\pi), d<c \in \operatorname{supp}(f)$, and $(d, c) \cap \operatorname{supp}(f)=$ $\emptyset$. Let $g$ be an irreducible function such that $S C_{\Lambda}(g)=\bigcup\{\{c, g(c)\}$ : $\underset{\tilde{\theta}}{c} \in \operatorname{supp}(g)\} \subset O T\left(\Pi_{1}^{1}\right), g_{d}=f_{d},(d, c) \cap \operatorname{supp}(g)=\emptyset g(d)<f(d)+$ $\tilde{\theta}_{c-d}(f(c)) \cdot \omega$, and $g<^{c} f(c)$. Moreover if $\max \left(S C_{\Lambda}(f)\right)<\mu<\Lambda$ for an epsilon number $\mu$, then $\max \left(S C_{\Lambda}(g)\right)<\mu$.
Then $\alpha=\psi_{\pi}^{g}(a) \in O T\left(\Pi_{1}^{1}\right)$ and $\alpha^{+} \in O T\left(\Pi_{1}^{1}\right)$ if $\{\pi, a\} \cup S C_{\Lambda}(f, g) \subset$ $\mathcal{H}_{a}(\alpha)$, and, cf. Proposition 3.23,

Definition $2.16 M_{\rho}:=\mathcal{H}_{b}(\rho)$ for $b=\mathrm{p}_{0}(\rho)$ and $\rho \in \Psi_{\mathbb{S}}$.
Definition 2.17 For $\gamma \prec \mathbb{S}$, an epsilon number $\mathbb{S}<\mu=\Lambda(\gamma)<\mathbb{S}^{+}$is defined. Let $\gamma=\psi_{\sigma}^{f}(\alpha) \preceq \psi_{\mathbb{S}}^{g}(b)$ with $b=\mathrm{p}_{0}(\gamma)$. Then $\Lambda(\gamma)$ denotes the least epsilon number $\mathbb{S}<\mu<\mathbb{S}^{+}$such that $\max \left(S C_{\mathbb{S}^{+}}(b)\right)<\mu$.
From Definition 2.14 we see $\max \left(S C_{\mathbb{S}^{+}}(f)\right)<\Lambda(\gamma)$.
$O T\left(\Pi_{1}^{1}\right)$ is closed under $\alpha \mapsto \alpha[\rho / \mathbb{S}]$ for $\alpha \in M_{\rho}$. Specifically if $\{\alpha, \rho\} \subset$ $O T\left(\Pi_{1}^{1}\right)$ with $\alpha \in M_{\rho}$ and $\rho \in \Psi_{\mathbb{S}}$, then $\alpha[\rho / \mathbb{S}] \in O T\left(\Pi_{1}^{1}\right)$.

Definition 2.18 Let $\alpha \in M_{\rho}$ with $\rho \in \Psi_{\mathbb{S}}$. We define an ordinal $\alpha[\rho / \mathbb{S}]$ recursively as follows. $\alpha[\rho / \mathbb{S}]:=\alpha$ when $\alpha<\mathbb{S}$. In what follows assume $\alpha \geq \mathbb{S}$.

The map commutes with + and $\varphi$.

Lemma 2.19 For $\rho \in \Psi_{\mathbb{S}},\left\{\alpha[\rho / \mathbb{S}]: \alpha \in M_{\rho}\right\}$ is a transitive collapse of $M_{\rho}$ in the sense that $\beta<\alpha \Leftrightarrow \beta[\rho / \mathbb{S}]<\alpha[\rho / \mathbb{S}], \beta \in \mathcal{H}_{\alpha}(\gamma) \Leftrightarrow \beta[\rho / \mathbb{S}] \in$ $\left.\mathcal{H}_{\alpha[\rho / \mathbb{S}]}(\gamma[\rho / \mathbb{S}])\right)$ for $\gamma>\mathbb{S}$, and $O T\left(\Pi_{1}^{1}\right) \cap \alpha[\rho / \mathbb{S}]=\left\{\beta[\rho / \mathbb{S}]: \beta \in M_{\rho} \cap \alpha\right\}$ for $\alpha, \beta, \gamma \in M_{\rho}$.
Proposition 2.20 Let $\rho \in \Psi_{\mathbb{S}}$.

1. $\mathcal{H}_{\gamma}\left(M_{\rho}\right) \subset M_{\rho}$ if $\gamma \leq \mathrm{p}_{0}(\rho)$.
2. $M_{\rho} \cap \mathbb{S}=\rho$ and $\rho \notin M_{\rho}$.
3. If $\sigma<\rho$ and $\mathrm{p}_{0}(\sigma) \leq \mathrm{p}_{0}(\rho)$, then $M_{\sigma} \subset M_{\rho}$.

## 3 Well-foundedness proof with the maximal distinguished set

In this section working in the set theory $\mathrm{KP} \omega+\left(M \prec_{\Sigma_{1}} V\right)$, we show the wellfoundedness of the notation system $O T\left(\Pi_{1}^{1}\right)$ up to each $\psi_{\Omega}\left(\omega_{n}\left(\mathbb{S}^{+}+1\right)\right)$. Let us write $L_{\mathbb{S}}$ for $M$, i.e., $L_{\mathbb{S}} \prec_{\Sigma_{1}} L$. The proof is based on distinguished classes, which was first introduced by Buchholz (5).

### 3.1 Distinguished sets

$X, Y, \ldots$ range over subsets of $O T\left(\Pi_{1}^{1}\right)$. We define sets $\mathcal{C}^{\alpha}(X) \subset O T\left(\Pi_{1}^{1}\right)$ for $\alpha \in O T\left(\Pi_{1}^{1}\right)$ and $X \subset O T\left(\Pi_{1}^{1}\right)$ as follows.

Definition 3.1 Let $\alpha, \beta \in O T\left(\Pi_{1}^{1}\right)$ and $X \subset O T\left(\Pi_{1}^{1}\right)$.
$\mathcal{C}^{\alpha}(X)$ denotes the closure of $\left\{0, \Omega, \mathbb{S}, \mathbb{S}^{+}\right\} \cup(X \cap \alpha)$ under,$+ \sigma \mapsto \sigma^{+}$, $(\beta, \gamma) \mapsto \varphi \beta \gamma$, and $(\sigma, \beta, f) \mapsto \psi_{\sigma}^{f}(\beta)$ for $\sigma>\alpha$ in $O T\left(\Pi_{1}^{1}\right)$.

The last clause says that, $\psi_{\sigma}^{f}(\beta) \in \mathcal{C}^{\alpha}(X)$ if $\{\sigma, \beta\} \cup S C_{\Lambda}(f) \subset \mathcal{C}^{\alpha}(X)$ and $\sigma>\alpha$.

Proposition 3.2 Assume $\forall \gamma \in X\left[\gamma \in \mathcal{C}^{\gamma}(X)\right]$ for a set $X \subset O T\left(\Pi_{1}^{1}\right)$.

1. $\alpha \leq \beta \Rightarrow \mathcal{C}^{\beta}(X) \subset \mathcal{C}^{\alpha}(X)$.
2. $\alpha<\beta<\alpha^{+} \Rightarrow \mathcal{C}^{\beta}(X)=\mathcal{C}^{\alpha}(X)$.

Definition 3.3 1. $\operatorname{Prg}[X, Y]: \Leftrightarrow \forall \alpha \in X(X \cap \alpha \subset Y \rightarrow \alpha \in Y)$.
2. For a definable class $\mathcal{X}, T I[\mathcal{X}]$ denotes the schema:
$T I[\mathcal{X}]: \Leftrightarrow \operatorname{Prg}[\mathcal{X}, \mathcal{Y}] \rightarrow \mathcal{X} \subset \mathcal{Y}$ holds for any definable classes $\mathcal{Y}$.
3. For $X \subset O T\left(\Pi_{1}^{1}\right), W(X)$ denotes the well-founded part of $X$.
4. $W o[X]: \Leftrightarrow X \subset W(X)$.
5. $\alpha \in W_{\Sigma}(X)$ denotes a $\Sigma_{1}$-formula saying that $\alpha \in X$ and 'there exists an embedding $f: X \cap(\alpha+1) \rightarrow O N^{\prime}$, i.e., $\exists f \in{ }^{\omega} O N \forall \beta, \gamma \in X \cap(\alpha+1)(\beta<$ $\gamma \rightarrow f(\beta)<f(\gamma))$, where $O N$ is the class of all ordinals, $\beta<\gamma$ in $O T\left(\Pi_{1}^{1}\right)$ and $f(\beta)<f(\gamma)$ in $O N$.
6. $W o_{\Sigma}[X]$ denotes a $\Sigma_{1}$-formula saying that 'there exists an embedding $f: X \rightarrow O N^{\prime}$, i.e., $\exists f \in{ }^{\omega} O N \forall \beta, \gamma \in X(\beta<\gamma \rightarrow f(\beta)<f(\gamma))$.

Note that for $\alpha \in O T\left(\Pi_{1}^{1}\right), W(X) \cap \alpha=W(X \cap \alpha)$. Also $\mathrm{KP} \omega \vdash \alpha \in W_{\Sigma}(X) \Rightarrow$ $\alpha \in W(X)$, and KP $\ell \vdash \alpha \in W(X) \Rightarrow \alpha \in W_{\Sigma}(X)$.

Definition 3.4 For $X \subset O T\left(\Pi_{1}^{1}\right)$ and $\alpha \in O T\left(\Pi_{1}^{1}\right)$,

1. $D[X]: \Leftrightarrow \forall \alpha\left(\alpha \leq X \rightarrow W\left(\mathcal{C}^{\alpha}(X)\right) \cap \alpha^{+}=X \cap \alpha^{+}\right)$.

A set $X$ is said to be a distinguished set if $D[X]$.
2. $D_{\Sigma}[X]$ is a $\Sigma$-formula defined by

From $\mathrm{KP} \omega \vdash \alpha \in W_{\Sigma}(X) \Rightarrow \alpha \in W(X)$ we see $D_{\Sigma}[X] \Rightarrow D[X]$ for any $X$.
Let $\alpha \in X$ for a $\Sigma$-distinguished set $X$. Then $W\left(\mathcal{C}^{\alpha}(X)\right) \cap \alpha^{+}=X \cap \alpha^{+}$. Hence $X$ is a well order. Although $\bigcup\{X: D[X]\}$ might be a proper class, it turns out that $\mathcal{W}$ is a set.

Proposition 3.5 Let $X \in L_{\mathbb{S}}$.

1. $\alpha \in W(X) \Leftrightarrow L_{\mathbb{S}} \models \alpha \in W(X)$.
2. $\alpha \in W_{\Sigma}(X) \Leftrightarrow L_{\mathbb{S}} \models \alpha \in W_{\Sigma}(X)$.
3. $D_{\Sigma}[X] \Leftrightarrow L_{\mathbb{S}} \models D_{\Sigma}[X]$.
4. $D_{\Sigma}[X] \leftrightarrow D[X]$.
5. $\mathcal{W}=\bigcup\left\{X \in L_{\mathbb{S}}: D[X]\right\}$ and $\exists X(X=\mathcal{W})$.

Proof. 3.5T1 Since $\alpha \in W(X)$ is a $\Pi_{1}$-formula, it suffices to show $\alpha \in W(X)$ assuming $L_{\mathbb{S}} \models \alpha \in W(X)$. We obtain $L_{\mathbb{S}} \models\left(\alpha \in W(X) \leftrightarrow \alpha \in W_{\Sigma}(X)\right)$ by $L_{\mathbb{S}} \models \mathrm{KP} \ell$. Hence $\alpha \in W_{\Sigma}(X)$ and $\alpha \in W(X)$.

Assume $D[X]$, $\alpha \leq X$ and $\beta \in X \cap \alpha^{+}$. Then $\beta \in W\left(\mathcal{C}^{\alpha}(X)\right) \cap \alpha^{+}$by $D[X]$. We obtain $\beta \in$ $W_{\Sigma}\left(\mathcal{C}^{\alpha}(X)\right) \cap \alpha^{+}$by $L_{\mathbb{S}} \models \beta \in W\left(\mathcal{C}^{\alpha}(X)\right) \rightarrow \beta \in W_{\Sigma}\left(\mathcal{C}^{\alpha}(X)\right)$ and Propositions 3.511 and 3.512
3.55 By Proposition 3.514 we obtain $\bigcup\left\{X \in L_{\mathbb{S}}: D[X]\right\} \subset \mathcal{W}$. Let $\alpha \in \mathcal{W}$. This means a $\Sigma_{1}$-formula $\exists X\left(\alpha \in X \wedge D_{\Sigma}[X]\right)$ holds. We obtain $L_{\mathbb{S}} \models \exists X(\alpha \in$ $\left.X \wedge D_{\Sigma}[X]\right)$ by $L_{\mathbb{S}} \prec_{\Sigma_{1}} L$. By Propositions 3.53 and 3.54 we obtain $\alpha \in \bigcup\{X \in$ $\left.L_{\mathbb{S}}: L_{\mathbb{S}} \models D_{\Sigma}[X]\right\}=\bigcup\left\{X \in L_{\mathbb{S}}: D_{\Sigma}[X]\right\}=\bigcup\left\{X \in L_{\mathbb{S}}: D[X]\right\} . \Delta_{0}$-separation yields $\exists X(X=\mathcal{W})$.

Proposition 3.6 Let $X \in L_{\mathbb{S}}$ be a distinguished set. Then $\alpha \in X \Rightarrow \forall \beta[\alpha \in$ $\left.\mathcal{C}^{\beta}(X)\right]$.

Proposition 3.7 For any distinguished sets $X$ and $Y$ in $L_{\mathbb{S}}, X \cap \alpha=Y \cap \alpha \Rightarrow$ $\forall \beta<\alpha^{+}\left\{\mathcal{C}^{\beta}(X) \cap \beta^{+}=\mathcal{C}^{\beta}(Y) \cap \beta^{+}\right\}$holds

Proposition 3.8 For distinguished sets $X$ and $Y$ in $L_{\mathbb{S}}, \alpha \leq X \& \alpha \leq Y \Rightarrow$ $X \cap \alpha^{+}=Y \cap \alpha^{+}$.

Proposition 3.9 $\mathcal{W}$ is the maximal distinguished set, i.e., $D[\mathcal{W}]$ and $\exists X(X=$ $\mathcal{W})$.

Proof. First we show $\forall \gamma \in \mathcal{W}\left(\gamma \in \mathcal{C}^{\gamma}(\mathcal{W})\right)$. Let $\gamma \in \mathcal{W}$, and pick a distinguished set $X \in L_{\mathbb{S}}$ such that $\gamma \in X$ by Proposition 3.515. Then $\gamma \in \mathcal{C}^{\gamma}(X) \subset$ $\mathcal{C}^{\gamma}(\mathcal{W})$ by $X \subset \mathcal{W}$.

Let $\alpha \leq \mathcal{W}$. Pick a distinguished set $X \in L_{\mathbb{S}}$ such that $\alpha \leq X$. We claim that $\mathcal{W} \cap \alpha^{+}=X \cap \alpha^{+}$. Let $Y \in L_{\mathbb{S}}$ be a distinguished set and $\beta \in Y \cap \alpha^{+}$. Then $\beta \in Y \cap \beta^{+}=X \cap \beta^{+}$by Proposition 3.8. The claim yields $W\left(\mathcal{C}^{\alpha}(\mathcal{W})\right) \cap \alpha^{+}=W\left(\mathcal{C}^{\alpha}(X)\right) \cap \alpha^{+}=X \cap \alpha^{+}=\mathcal{W} \cap \alpha^{+}$. Hence $D[\mathcal{W}]$.

From $\mathcal{W} \cap \alpha^{+}=X \cap \alpha^{+}$for a $\Sigma$-distinguished set $X$, We see $\mathcal{W} \cap \alpha^{+}=$ $X \cap \alpha^{+} \subset W_{\Sigma}\left(\mathcal{C}^{\alpha}(X)\right) \cap \alpha^{+}=W_{\Sigma}\left(\mathcal{C}^{\alpha}(\mathcal{W})\right) \cap \alpha^{+}$. Hence $D_{\Sigma}[\mathcal{W}]$.

### 3.2 Sets $\mathcal{C}^{\alpha}\left(\mathcal{W}_{\mathbb{S}}\right)$ and $\mathcal{G}$

Definition 3.10 $\mathcal{G}(Y):=\left\{\alpha \in O T\left(\Pi_{1}^{1}\right): \alpha \in \mathcal{C}^{\alpha}(Y) \& \mathcal{C}^{\alpha}(Y) \cap \alpha \subset Y\right\}$.
Lemma 3.11 For $D[X], X \subset \mathcal{G}(X)$.
Lemma 3.12 Suppose $D[Y]$ and $\alpha \in \mathcal{G}(Y)$ for $Y \in L_{\mathbb{S}}$. Let $X=W\left(\mathcal{C}^{\alpha}(Y)\right) \cap$ $\alpha^{+} \in L_{\mathbb{S}}$. Assume that the following condition (7) is fulfilled. Then $\alpha \in X$ and $D[X]$.

2. Let either $\sigma=0$ or $\sigma=\psi_{\mathbb{S}}^{f}(a)$ or $\sigma=\psi_{\pi}^{f}(a)$. Assume $\sigma \in \mathcal{W}$. Then $\sigma^{+} \in \mathcal{W}$.

Proof. Each is seen from Lemma 3.12 as follows.

### 3.3 Mahlo universes

In this subsection we consider the maximal distinguished class $\mathcal{W}^{P}$ inside a set $P \in L_{\mathbb{S}}$ as in [1]. Let ad denote a $\Pi_{3}^{-}$-sentence such that a transitive set $z$ is admissible iff $(z ; \in) \models a d$. Let lmtad $: \Leftrightarrow \forall x \exists y\left(x \in y \wedge a d^{y}\right)$. Observe that lmtad is a $\Pi_{2}^{-}$-sentence.

Definition 3.16 1. By a universe we mean either $L_{\mathbb{S}}$ or a transitive set $Q \in L_{\mathbb{S}}$ with $\omega \in Q$. Universes are denoted by $P, Q, \ldots$
2. For a universe $P$ and a set-theoretic sentence $\varphi, P \models \varphi: \Leftrightarrow(P ; \in) \models \varphi$.
3. A universe $P$ is said to be a limit universe if $\operatorname{lmtad}{ }^{P}$ holds, i.e., $P$ is a limit of admissible sets. The class of limit universes is denoted by Lmtad.

Lemma 3.17 $W\left(\mathcal{C}^{\alpha}(X)\right)$ as well as $D[X]$ are absolute for limit universes $P$.
Definition 3.18 For a universe $P$, let $\mathcal{W}^{P}:=\bigcup\{X \in P: D[X]\}$.
We see $\mathcal{W}=\mathcal{W}^{L_{s}}$ from Proposition 3.5[5
Lemma 3.19 Let $P$ be a universe closed under finite unions, and $\alpha \in O T\left(\Pi_{1}^{1}\right)$.

There is a finite set $K(\alpha) \subset O T\left(\Pi_{1}^{1}\right)$ such that $\forall Y \in P \forall \gamma[K(\alpha) \cap Y=$ $\left.K(\alpha) \cap \mathcal{W}^{P} \Rightarrow\left(\alpha \in \mathcal{C}^{\gamma}\left(\mathcal{W}^{P}\right) \Leftrightarrow \alpha \in \mathcal{C}^{\gamma}(Y)\right)\right]$.
2. There exists a distinguished set $X \in P$ such that $\forall Y \in P \forall \gamma[X \subset Y \& D[Y] \Rightarrow$ $\left.\left(\alpha \in \mathcal{C}^{\gamma}\left(\mathcal{W}^{P}\right) \Leftrightarrow \alpha \in \mathcal{C}^{\gamma}(Y)\right)\right]$.

Proposition 3.20 For each limit universe $P, D\left[\mathcal{W}^{P}\right]$ holds, and $\exists X \in L_{\mathbb{S}}(X=$ $\mathcal{W}^{P}$ ) if $P \in L_{\mathbb{S}}$.

For a universal $\Pi_{n}$-formula $\Pi_{n}(a)(n>0)$ uniformly on admissibles, let
$P \in M_{2}(\mathcal{C}): \Leftrightarrow P \in$ Lmtad $\& \forall b \in P\left[P \models \Pi_{2}(b) \rightarrow \exists Q \in \mathcal{C} \cap P\left(Q \models \Pi_{2}(b)\right)\right]$.
Definition 3.21 Let $\gamma=\psi_{\sigma}^{f}(\alpha) \prec \mathbb{S}$ and $\mu=\Lambda(\gamma)<\mathbb{S}^{+}$be the ordinal in Definition 2.17. Let $O(\gamma)=o_{\mu}(f)<\mathbb{S}^{+}$, where $o_{\mu}(f)$ is the ordinal defined in Definition 2.11 from the epsilon number $\mu$.

Let $O(\Omega)=1, O(\mathbb{S})=\mathbb{S}^{+}$and $O(\gamma)=0$ else.

Lemma 3.22 Let $\mathcal{C}$ be a $\Pi_{0}^{1}$-class such that $\mathcal{C} \subset$ Lmtad. Suppose $P \in M_{2}(\mathcal{C})$, $\alpha \in \mathcal{G}\left(\mathcal{W}^{P}\right)$ and $O(\alpha) \in W\left(\mathcal{C}^{\mathbb{S}}\left(\mathcal{W}^{P}\right)\right)$ Then there exists a universe $Q \in \mathcal{C}$ such that $\alpha \in \mathcal{G}\left(\mathcal{W}^{Q}\right)$ and $O(\alpha) \in W\left(\mathcal{C}^{\mathbb{S}}\left(\mathcal{W}^{Q}\right)\right)$.

Proof. Suppose $P \in M_{2}(\mathcal{C}), \alpha \in \mathcal{G}\left(\mathcal{W}^{P}\right)$ and $O(\alpha) \in W\left(\mathcal{C}^{\mathbb{S}}\left(\mathcal{W}^{P}\right)\right)$. First by $\alpha \in \mathcal{C}^{\alpha}\left(\mathcal{W}^{P}\right), O(\alpha) \in \mathcal{C}^{\mathbb{S}}\left(\mathcal{W}^{P}\right)$ and Lemma 3.19 pick a distinguished set $X_{0} \in P$ such that $\alpha \in \mathcal{C}^{\alpha}\left(X_{0}\right), O(\alpha) \in \mathcal{C}^{\mathbb{S}}\left(X_{0}\right)$ and $K(\alpha) \cap \mathcal{W}^{P} \subset X_{0}$. Then for any universe $X_{0} \in Q \in P$, we obtain $O(\alpha) \in W\left(\mathcal{C}^{\mathbb{S}}\left(\mathcal{W}^{Q}\right)\right)$ by $\mathcal{W}^{Q} \subset \mathcal{W}^{P}$.

Next writing $\mathcal{C}^{\alpha}\left(\mathcal{W}^{P}\right) \cap \alpha \subset \mathcal{W}^{P}$ analytically we have

We obtain $S C_{\mathbb{S}^{+}}(f, b)<\mu=\Lambda(\gamma)$ by Definition 2.14 $E_{\mathbb{S}}\left(S C_{\mathbb{S}^{+}}(f, b)\right) \subset$ $\mathcal{C}^{\gamma}(Y)$ follows from $\gamma<\mathbb{S}$. On the other hand we have $S C_{\mathbb{S}^{+}}(f, b) \subset \mathcal{H}_{b}(\gamma)$ for $b=\mathrm{p}_{0}(\gamma)$ by (5). This yields $E_{\mathbb{S}}\left(S C_{\mathbb{S}^{+}}(f, b)\right) \subset \mathcal{H}_{b}(\gamma) \cap \mathbb{S} \subset \gamma$. We obtain $E_{\mathbb{S}}\left(S C_{\mathbb{S}^{+}}(f, b)\right) \subset \mathcal{C}^{\gamma}(Y) \cap \gamma \subset Y$. Hence $S C_{\mathbb{S}^{+}}(f, b) \subset \mathcal{C}^{\mathbb{S}}(Y)$. From $S C_{\mathbb{S}^{+}}(f, b) \subset \mathcal{C}^{\mathbb{S}}(Y)$ we see $O(\gamma)=o_{\mu}(f) \in \mathcal{C}^{\mathbb{S}}(Y)$ for $\gamma=\psi_{\sigma}^{f}(\alpha) \in \mathcal{G}(Y)$.

$$

We show $\beta_{1} \in \mathcal{W}$. We may assume that $\beta_{1}=\psi_{\pi}^{g}(b)$ for some $\pi, b, g$ such that $\{\pi, b\} \cup S C_{\mathbb{S}^{+}}(g) \subset \mathcal{C}^{\alpha_{1}}(\mathcal{W})$ and $\alpha_{1}<\pi \leq \mathbb{S}$.
Case 1. $b<a, \beta_{1}<\kappa$ and $\{\pi, b\} \cup S C_{\mathbb{S}^{+}}(g) \subset \mathcal{H}_{a}\left(\alpha_{1}\right)$ : Let $B$ denote a set of subterms of $\beta_{1}$ defined recursively as follows. First $\{\pi, b\} \cup S C_{\mathbb{S}^{+}}(g) \subset B$. Let $\alpha_{1} \leq \beta \in B$. If $\beta={ }_{N F} \gamma_{m}+\cdots+\gamma_{0}$, then $\left\{\gamma_{i}: i \leq m\right\} \subset B$. If $\beta={ }_{N F} \varphi \gamma \delta$, then $\{\gamma, \delta\} \subset B$. If $\beta={ }_{N F} \gamma^{+}$, then $\gamma \in B$. If $\beta=\psi_{\sigma}^{h}(c)$ with $\sigma>\alpha_{1}$, then $\{\sigma, c\} \cup S C_{\mathbb{S}^{+}}(h) \subset B$.

Then from $\{\pi, b\} \cup S C_{\mathbb{S}^{+}}(g) \subset \mathcal{C}^{\alpha_{1}}(\mathcal{W})$ we see inductively that $B \subset \mathcal{C}^{\alpha_{1}}(\mathcal{W})$. Hence by LIH we obtain $B \cap \alpha_{1} \subset \mathcal{W}$. Moreover if $\alpha_{1} \leq \psi_{\sigma}^{h}(c) \in B$, then $c<a$. We claim that

$$
\begin{equation*}
\forall \beta \in B\left(\beta \in \mathcal{C}^{\mathbb{S}^{+}}\left(\mathcal{W}_{1}\right)\right) \tag{13}
\end{equation*}
$$

Proof of (13) by induction on $\ell \beta$. Let $\beta \in B$. We can assume that $\alpha_{1} \leq$ $\beta=\psi_{\sigma}^{h}(c)$ by LIH. Then by induction hypothesis we have $\{\sigma, c\} \cup S C_{\mathbb{S}^{+}}(h) \subset$ $\mathcal{C}^{\mathbb{S}^{+}}\left(\mathcal{W}_{1}\right)$. On the other hand we have $c<a<\omega_{n}\left(\mathbb{S}^{+}+1\right)$. If $\sigma=\mathbb{S}^{+}$, then Lemma 3.30 yields $\beta=\psi_{\mathbb{S}^{+}}(c) \in \mathcal{W}_{1}$. Let $\sigma \leq \mathbb{S}$. Then $\{\sigma\} \cup S C_{\mathbb{S}^{+}}(h) \subset$ $\mathcal{C}^{\mathbb{S}^{+}}\left(\mathcal{W}_{1}\right) \cap \mathbb{S}^{+}=\mathcal{W}_{1} \cap \mathbb{S}^{+}$. Let $\alpha_{1} \leq \beta=\psi_{\sigma}^{h}(c) \preceq \psi_{\mathbb{S}}^{h_{0}}\left(c_{0}\right)$. Then $S C_{\mathbb{S}^{+}}\left(c_{0}\right) \subset B$ and $S C_{\mathbb{S}^{+}}\left(c_{0}\right) \subset \mathcal{W}_{1}$ by induction hypothesis on lengths. Hence $\Lambda(\beta) \in \mathcal{W}_{1}$ for the least epsilon number $\Lambda(\beta)>\max \left(S C_{\mathbb{S}^{+}}\left(c_{0}\right)\right)$. We obtain $O(\beta) \in \mathcal{W}_{1}$ by $S C_{\mathbb{S}^{+}}(h) \cup\{\Lambda(\beta)\} \subset \mathcal{W}_{1} . \operatorname{MIH}(a)$ yields $\beta \in \mathcal{W}$. Thus (13) is shown.

In particular we obtain $\left\{\pi, b, \Lambda\left(\beta_{1}\right)\right\} \cup S C_{\mathbb{S}^{+}}(g) \subset \mathcal{C}^{\mathbb{S}^{+}}\left(\mathcal{W}_{1}\right)$. Moreover we have $b<a$. Therefore once again $\operatorname{MIH}(a)$ yields $\beta_{1} \in \mathcal{W}$.
Case 2. $b=a, \pi=\kappa, S C_{\mathbb{S}^{+}}(g) \subset \mathcal{H}_{a}\left(\alpha_{1}\right)$ and $g<_{l x}^{0} f$ : As in (13) we see that $S C_{\mathbb{S}^{+}}(g) \subset \mathcal{W}_{1}$ from Lemma 3.30 and $\operatorname{MIH}(a) . \operatorname{SIH}(a, f)$ yields $\beta_{1} \in \mathcal{W}$.
Case 3. $a \leq b$ and $S C_{\mathbb{S}^{+}}(f) \cup\{\kappa, a\} \not \subset \mathcal{H}_{b}\left(\beta_{1}\right):$ As in as in [1,2] we see that there exists a $\gamma$ such that $\beta_{1} \leq \gamma \in \mathcal{W} \cap \alpha_{1}$. Then $\beta_{1} \in \mathcal{W}$ follows from $\beta_{1} \in \mathcal{C}^{\alpha_{1}}(\mathcal{W})$.

This completes a proof of (12) and of the lemma.
Lemma 3.33 For $\psi_{\kappa}^{f}(a) \in O T\left(\Pi_{1}^{1}\right)$, if $a \in \mathcal{C}^{\mathbb{S}^{+}}\left(\mathcal{W}_{1}\right) \cap \omega_{n}\left(\mathbb{S}^{+}+1\right), \quad\{\kappa\} \cup$ $S C_{\mathbb{S}^{+}}(f) \subset \mathcal{W}_{1} \cap \mathbb{S}^{+}$and $O\left(\psi_{\kappa}^{f}(a)\right) \in \mathcal{W}_{1}$, then $\psi_{\kappa}^{f}(a) \in \mathcal{W}$.

Proof. This is seen from Lemma 3.32 and Proposition 3.29] Note that if $\beta=\psi_{\kappa}^{g}(a)<\psi_{\kappa}^{f}(a)=\alpha$ by $g<_{l x}^{0} f$, then $\mathrm{p}_{0}(\beta)=\mathrm{p}_{0}(\alpha), \Lambda(\beta)=\Lambda(\alpha)$ and $O(\beta)<O(\alpha)$ by Lemma 2.13.

Lemma 3.34 For each $\alpha \in O T\left(\Pi_{1}^{1}\right), \alpha \in \mathcal{C}^{\mathbb{S}^{+}}\left(\mathcal{W}_{1}\right)$.
Proof. This is seen by meta-induction on $\ell \alpha$ using Propositions 3.13 and 3.14 and Lemmas 3.30 and 3.33 .

Proof of Theorem1.2. For each $\alpha \in O T\left(\Pi_{1}^{1}\right)$ we obtain $\alpha \in \mathcal{C}^{\mathbb{S}^{+}}\left(\mathcal{W}_{1}\right)$ by Lemma 3.34. Therefore by Proposition 3.2911 we obtain for each $n<\omega, \psi_{\Omega}\left(\omega_{n}\left(\mathbb{S}^{+}+\right.\right.$ 1) $) \in \mathcal{C}^{\mathbb{S}^{+}}\left(\mathcal{W}_{1}\right) \cap \Omega=\mathcal{W} \cap \Omega=W\left(\mathcal{C}^{0}(\emptyset)\right) \cap \Omega$, where $W\left(\mathcal{C}^{0}(\emptyset)\right)=W\left(O T\left(\Pi_{1}^{1}\right)\right)$.
