# Resonance free domain for Schrödinger operators with repulsive potential

#### Abstract

We study resonances for the Schrödinger operators with quadratic or subquadratic repulsive potential. In the present paper, we show the non-existence of resonances in some complex neighborhood of a fixed energy by employing schemes of Briet-Combes-Duclos and Hunziker and by introducing a proper distortion based on, but slightly modified, positive commutator method of Mourre.


## 1 Introduction

In the present paper we consider semiclassical repulsive Hamiltonians: For a fixed $s \in(0,1]$

$$
H=H_{0}+q(x) ; \quad H_{0}=-\frac{\hbar^{2}}{2} \Delta-\frac{1}{2}|x|^{2 s}
$$

on $L^{2}\left(\mathbb{R}^{d}\right)$, where $\hbar>0$ is the semiclassical parameter, $x \in \mathbb{R}^{d}$ and $q$ is a perturbation. If $s=1, H_{0}$ is called the inverted harmonic oscillator. We define resonances of $H$ as eigenvalues of complex distorted $H$, which is denoted by $H_{\theta}$ later, and show that for sufficiently small $\hbar>0, H$ has no resonances in some complex neighborhood of a fixed energy $E$ under a kind of non-trapping condition for potential $-\frac{1}{2}|x|^{2 s}+q$. For the case of perturbed Laplacian

$$
P=-\frac{1}{2} \Delta+V(x),
$$

where $V$ is a decaying real-valued smooth function, one assumes as a non-trapping condition that the quantity

$$
2(V-E)+x \cdot \partial V
$$

is bounded from above by a negative constant outside of classically forbidden region. Such a condition is called virial condition. This quantity comes from the Poisson bracket

$$
\left.\left\{x \cdot \xi, P^{\mathrm{cl}}\right\}\right|_{P^{\mathrm{cl}}=E},
$$

where $P^{\mathrm{cl}}=\frac{1}{2} \xi^{2}+V(x)$ is the classical Hamiltonian of $P$. The choice of $x \cdot \xi$ is related to positive commutator method of [12]. In fact, $\operatorname{Re}(x \cdot p)$ with $p=-\mathrm{i} \nabla$

[^0]plays a role of the conjugate operator for $P$. However $\operatorname{Re}(x \cdot p)$ is not the conjugate operator for the repulsive Hamiltonian $H$. By considering the classical orbit of the particle in the repulsive electric field, we can take the operator $\operatorname{Re}((\partial g) \cdot p)$ with
\[

g= $$
\begin{cases}\frac{1}{2(1-s)}|x|^{2-2 s} & \text { for } s<1 \\ \frac{1}{2}(\log |x|)^{2} & \text { for } s=1\end{cases}
$$
\]

as the conjugate operator for the repulsive Hamiltonian $H$. Therefore, it would be better to consider $(\partial g) \cdot \xi$ instead of $x \cdot \xi$, see also Remarks 2.6 (2).

In the proof of our main result, we employ schemes of $[2,6]$, which are used for a perturbed Laplacian. As the author mentioned above, we slightly modify the quantity $x \cdot \xi$ appeared in their schemes. We discuss eigenvalue of distorted $H$, not dilated, which is constructed by using a complex distortion related to the flow of $(\partial g) \cdot \nabla$.

There is a large body of literature on resonances for semiclassical Schrödinger operators with bounded potentials. We refer to $[1,2,6,8,11]$ for non-existence of resonances in a certain region. We study resonance free domain for $H$ by employing their methods. We also refer to $[3,10,13]$ for asymptotic behavior of resonances and to [16] in which many topics of resonances are dealt with. Resonances of the repulsive Hamiltonian $H$ can be treated in the framework of [4]. However, thanks to using our new distortion we can discuss resonances for $H$ with a large class of perturbations compared to [4], cf. Remarks 2.6 (3). The Stark potential is a kind of repulsive potential, although it is not spherically symmetric. Resonances in the Stark effect is studied for many authors, we refer to e.g. [5, 7, 9, 15].

## 2 Setting and Results

### 2.1 Setting

First we assume a long-range type condition on $q$.
Condition 2.1. The perturbation $q$ belongs to $C^{\infty}\left(\mathbb{R}^{d} ; \mathbb{R}\right)$. Moreover there exist $\rho \in(0,1)$ and $C_{k}>0$ for $k \in \mathbb{N} \cup\{0\}$ such that

$$
\left|\nabla^{k} q\right| \leq \begin{cases}C_{k}\langle x\rangle^{2 s-k-\rho} & \text { for } s<1 \\ C_{k}(\log \langle x\rangle)^{-1-\rho}\langle x\rangle^{2-k} & \text { for } s=1\end{cases}
$$

Although $H$ has a self-adjoint extension under Condition 2.1 by the Faris-Lavine theorem cf. [14], let us consider $H$ as the self-adjoint operator associated with the quadratic form on $H^{1} \cap \mathcal{D}\left(|x|^{s}\right)$

$$
t[u]:=\frac{\hbar^{2}}{2}\|\nabla u\|^{2}-\frac{1}{2}\left\||x|^{s} u\right\|^{2}+\langle u, q(x) u\rangle .
$$

In the study of resonances for perturbed Laplacian $P$, It would be standard to use the dilation $x \mapsto \mathrm{e}^{\theta} x=\left(\mathrm{e}^{\theta} r\right) \omega$ or slightly modified one. Here $r=|x|$ and $\omega=x / r$. We note that the dilation generates an operator $\operatorname{Re}(x \cdot p)$ which is the conjugate operator for perturbed Laplacian $P$ in the Mourre theory. As
for the case of sub-quadratic repulsive Hamiltonian, that is $s \in(0,1)$, an operator $\operatorname{Re}\left(|x|^{-2 s} x \cdot p\right)$ plays a role of the conjugate operator, and this is generated by a group $T(\theta): x \mapsto\left(r^{2 s}+2 s \theta\right)^{1 /(2 s)} \omega$ for $\theta \geq 0$. Therefore, in order to consider resonances for sub-quadratic repulsive Hamiltonian, it is natural to use such a transformation. As for the case of the inverted harmonic oscillator, that is $s=1$, an operator $\operatorname{Re}\left((\log |x|)|x|^{-2} x \cdot p\right)$ is chosen as the conjugate operator. In order to find a group which generates this operator we need to solve the equation

$$
\frac{\partial r(\theta)}{\partial \theta}=(\log r) r^{-1} \frac{\partial r(\theta)}{\partial r} .
$$

However it is difficult to find an exact solution to this equation. Here we note that we can discuss resonances of the inverted harmonic oscillator by using an approximate solution $r(\theta)=\left(r^{2}+2 \theta \log r\right)^{1 / 2}$ in the sense that this $r(\theta)$ satisfies

$$
\frac{\partial r(\theta)}{\partial \theta}-(\log r) r^{-1} \frac{\partial r(\theta)}{\partial r}=-\theta r^{-2} \log r .
$$

However we need an additional assumption on the classically forbidden region to control an error term.

Based on the above short discussion, let us define a complex distortion by mimicking an argument of [6]. We take a smooth cut-off function $\chi_{1}: \mathbb{R} \rightarrow[0,1]$ which satisfy

$$
\chi_{1}(t)= \begin{cases}0 & \text { for } t \leq 1 \\ 1 & \text { for } t \geq 2\end{cases}
$$

We note that $\chi_{1}$ is a Lipschitz continuous function, and we denote its Lipschitz constant by $L>0$ :

$$
\left|\chi_{1}\left(t_{1}\right)-\chi_{1}\left(t_{2}\right)\right| \leq L\left|t_{1}-t_{2}\right| .
$$

We set for $R>0$

$$
\chi_{R}(t):=\chi_{1}\left(t / R^{2 s}\right) .
$$

For $\theta \in \mathbb{R}$ we introduce the mappings

$$
r \mapsto r_{\theta}:= \begin{cases}\left(r^{2 s}+2 s \theta \chi_{R}\left(r^{2 s}\right)\right)^{1 /(2 s)} & \text { for } s<1,  \tag{2.1}\\ \left(r^{2}+2 \theta \chi_{R}\left(r^{2}\right) \log r\right)^{1 / 2} & \text { for } s=1 .\end{cases}
$$

By the Lipschitz continuity of $\chi_{R}$, the mapping $r \mapsto\left(r^{2 s}+2 s \theta \chi_{R}\left(r^{2 s}\right)\right)^{1 /(2 s)}$ is invertible for any $\theta \in \mathbb{R}$ with $|\theta|<(2 s)^{-1} R^{2 s} L^{-1}$. In fact, for any $\tilde{r} \in[0, \infty)$ we can construct $r \geq 0$ such that

$$
\begin{equation*}
\tilde{r}^{2 s}=r^{2 s}+2 s \theta \chi_{R}\left(r^{2 s}\right) . \tag{2.2}
\end{equation*}
$$

For any $\tilde{r} \in[0, \infty)$, let us consider the sequence $\left\{r_{n}\right\}_{n \in \mathbb{N}_{0}} \subset[0, \infty)$ defined by the recurrence formula

$$
r_{n}^{2 s}=\tilde{r}^{2 s}-2 s \theta \chi_{R}\left(r_{n-1}^{2 s}\right), \quad r_{0}=\tilde{r} .
$$

Noting that $\sup _{n \in \mathbb{N}_{0}} r_{n}^{2 s} \leq \tilde{r}^{2 s}+2 s|\theta|$ and for any $n, m \in \mathbb{N}_{0}, n \geq m$

$$
\begin{aligned}
\left|r_{n}^{2 s}-r_{m}^{2 s}\right| & =2 s|\theta|\left|\chi_{R}\left(r_{n-1}^{2 s}\right)-\chi_{R}\left(r_{m-1}^{2 s}\right)\right| \\
& \leq 2 s|\theta| R^{-2 s} L\left|r_{n-1}^{2 s}-r_{m-1}^{2 s}\right|
\end{aligned}
$$

$$
\leq\left(2 s|\theta| R^{-2 s} L\right)^{m}\left|r_{n-m}^{2 s}-r_{0}^{2 s}\right|
$$

we can see that $\left\{r_{n}\right\}_{n \in \mathbb{N}_{0}}$ is a Cauchy sequence, and thus it converges. By letting $r=\lim _{n \rightarrow \infty} r_{n}$, we have (2.2). Similarly, we can verify that there exists $L_{1}>0$ such that the lower mapping of (2.1) is invertible for any $\theta \in \mathbb{R}$ with $|\theta|<L_{1}$. For simplicity, we let $L_{s}=(2 s)^{-1} R^{2 s} L$ for $s \in(0,1)$.

For $\theta \in \mathbb{R}$ with $|\theta|<L_{s}$, we define unitary operator $U_{\theta}$ on $L^{2}\left(\mathbb{R}^{d}\right)$ as

$$
\begin{equation*}
\left(U_{\theta} u\right)(x)=\left(U_{\theta} u\right)(r \omega):=J^{1 / 2} u\left(r_{\theta} \omega\right), \tag{2.3}
\end{equation*}
$$

where

$$
J=J(\theta, r)= \begin{cases}\left(r_{\theta} / r\right)^{d-2 s}\left(1+2 s \theta \chi_{R}^{\prime}\left(r^{2 s}\right)\right) & \text { for } s<1 \\ \left(r_{\theta} / r\right)^{d-2}\left(1+\theta r^{-2} \chi_{R}\left(r^{2}\right)+2 \theta \log r \chi_{R}^{\prime}\left(r^{2}\right)\right) & \text { for } s=1\end{cases}
$$

Now we introduce an additional condition on $q$. For any $\theta \in \mathbb{R}$, we set

$$
q_{\theta}(x)=q_{\theta}(r \omega)=q\left(r_{\theta} \omega\right) .
$$

Condition 2.2. In addition to Condition 2.1, for a fixed $R>0, q_{\theta}$ has an analytic extension in a region $C_{\beta_{0}}:=\left\{\theta \in \mathbb{C}| | \operatorname{Im} \theta \mid<\beta_{0}\right\}$ for some $\beta_{0}>0$ uniformly in $x \in \mathbb{R}^{d}$.

In the statement of our main theorem, we fix $R>0$ depending on the situation and then assume Condition 2.2. We remark that, as we will see later, the resonance of $H$ does not depend on the choice of $R>0$.

We set for $\theta \in \mathbb{R}$ with $|\theta|<L_{s}$

$$
t_{\theta}[u]:=t\left[U_{\theta}^{-1} u\right]=\frac{\hbar^{2}}{2}\left\langle u, U_{\theta} p^{2} U_{\theta}^{-1} u\right\rangle-\frac{1}{2}\left\langle u, r_{\theta}^{2 s} u\right\rangle+\left\langle u, q_{\theta} u\right\rangle .
$$

We note that $U_{\theta}(-\Delta) U_{\theta}^{-1}$ is expressed as

$$
\begin{aligned}
U_{\theta}(-\Delta) U_{\theta}^{-1}= & U_{\theta}\left(-\partial_{r}^{2}-\frac{d-1}{r} \partial_{r}-r^{-2} \Delta_{\mathbb{S}^{d-1}}\right) U_{\theta}^{-1} \\
= & -J^{1 / 2}\left(\frac{\partial r_{\theta}}{\partial r}\right)^{-1} \partial_{r}\left(\frac{\partial r_{\theta}}{\partial r}\right)^{-1} \partial_{r} J^{-1 / 2}-(d-1) J^{1 / 2} r_{\theta}^{-1}\left(\frac{\partial r_{\theta}}{\partial r}\right)^{-1} \partial_{r} J^{-1 / 2} \\
& -r_{\theta}^{-2} \Delta_{\mathbb{S}^{d-1}} .
\end{aligned}
$$

Then we can see that $t_{\theta}[u]$ extends analytically to a complex region $\{\theta \in \mathbb{C}||\theta|<$ $\left.L_{s}\right\} \cap C_{\beta_{0}}$ and forms analytic family of operators

$$
H_{\theta}:=U_{\theta} H U_{\theta}^{-1}=\frac{\hbar^{2}}{2} U_{\theta}(-\Delta) U_{\theta}^{-1}-\frac{1}{2} r_{\theta}^{2 s}+q_{\theta} .
$$

Based on [6, Section 6], we consider a set of analytic vectors to characterize resonances of $H$. Let us introduce the set $F$ of entire function $f=f(z), z \in \mathbb{C}^{d}$, which vanishes faster than any inverse power of $|\operatorname{Re} z|$ as $|\operatorname{Re} z| \rightarrow \infty$ in any region

$$
|\operatorname{Im} z| \leq(1-\varepsilon)|\operatorname{Re} z|, \quad \varepsilon \in(0,1)
$$

We call $\psi \in L^{2}\left(\mathbb{R}^{d}\right)$ analytic vector if it holds that $\psi(x)=f(x)$ on $\mathbb{R}^{d}$ for some $f \in F$. We denote the set of analytic vectors by $\mathcal{A}$. Then we can see, similarly to
[6], that there exist $\tilde{L}_{s} \in\left(0, L_{s}\right]$ such that for any $\psi \in \mathcal{A}$ the mapping $\theta \rightarrow U_{\theta} \psi$ is an $L^{2}$-valued analytic function in $|\theta|<\tilde{L}_{s}$. Moreover for any $\theta \in \mathbb{C}$ with $|\theta|<\tilde{L}_{s}$, $\mathcal{A}$ and $U_{\theta} \mathcal{A}$ are dense in $L^{2}\left(\mathbb{R}^{d}\right)$. For any $z \in \mathbb{C}$ with $\operatorname{Im} z>0$ and any real $\theta$ with $|\theta|<L_{s}$ we have

$$
\begin{equation*}
\left\langle\phi,(H-z)^{-1} \psi\right\rangle=\left\langle U_{\bar{\theta}} \phi,\left(H_{\theta}-z\right)^{-1} U_{\theta} \psi\right\rangle, \quad \phi, \psi \in \mathcal{A} \tag{2.4}
\end{equation*}
$$

In particular it has a meromorphic continuation in $z$ to $\mathbb{C} \backslash \sigma_{\text {ess }}\left(H_{\theta}\right)$ and in $\theta$ to $\left\{\theta \in \mathbb{C}\left||\theta|<\tilde{L}_{s}\right\}\right.$. In general, resonance is defined as a pole of a meromorphic continuation of (2.4). In the present paper, we adopt the following definition of resonances, which is equivalent to it.

Definition 2.3. We call $z \in \mathbb{C}$ a resonance of $H$ if $z$ is an eigenvalue of $H_{\theta}$ for some $\theta \in i \mathbb{R}_{+}$.

We note that the resonances does not depend on the choice of the cut-off function $\chi_{R}$ by uniqueness of meromorphic continuation of (2.4). Moreover it does not depend on the value of $\theta=\mathrm{i} \beta, \beta>0$, in the sense that if $z$ is an eigenvalue of $H_{\mathrm{i} \beta_{1}}, z$ is also an eigenvalue of $H_{\mathrm{i} \beta_{2}}$ when $\beta_{2}>\beta_{1}$.

### 2.2 Resonance free domain

The following theorem is our main result and it asserts that $H$ has no resonances in some complex neighborhood of fixed energy $E$ for sufficiently small $\hbar>0$.

Theorem 2.4. Let $s \in(0,1]$ and take any $E \in \mathbb{R}$. Assume that there exist $\mu>0$ and smooth cut-off functions $\chi, \tilde{\chi} \in C^{1}([0, \infty) ;[0,1])$ such that
(i) $\chi^{2}+\tilde{\chi}^{2}=1$ on $\mathbb{R}^{d}$ and $\chi=1$ near 0 .

Moreover, if $s=1, \operatorname{supp} \tilde{\chi} \subset\{r \geq \sqrt{\mathrm{e}}\}$,
(ii) There exists $\alpha>0$ such that

$$
-\frac{1}{2} r^{2 s}+q-E \geq \alpha \text { on } \operatorname{supp} \chi
$$

(iii) There exists $\gamma>0$ such that

$$
\begin{cases}1-s-2(1-2 s) r^{-2 s}(q-E)-r^{1-2 s}\left(\partial_{r} q\right)-\mu \geq \gamma & \text { for } s<1 \\ 1+2 r^{-2}(\log r-1)(q-E)-r^{-1}(\log r)\left(\partial_{r} q\right)-\mu \geq \gamma & \text { for } s=1\end{cases}
$$

on $\operatorname{supp} \tilde{\chi}$.
Take any $R>0$ such that $\chi_{R}=1$ on supp $\tilde{\chi}$, and assume Condition 2.2. Let $\beta \in\left(0, \min \left\{\tilde{L}_{s}, \beta_{0}\right\}\right), \theta=\mathrm{i} \beta$ and $z=E-\mathrm{i} \beta \mu$. Then one has for any $u \in \mathcal{D}\left(H_{\theta}\right)$ and for any $\beta>0$ small enough

$$
\left\|\left(H_{\theta}-z\right) u\right\| \geq C_{\alpha, \beta, \gamma, \hbar}\|u\|
$$

with $C_{\alpha, \beta, \gamma, \hbar}=(1-c \beta) \min \{\alpha, \beta \gamma\}+O\left(\beta^{2}\right)+O\left(\hbar^{2}\right)$. Here $c>0$ is a certain constant which is independent of both $\hbar$ and $\beta$.

Corollary 2.5. Suppose all the assumptions of Theorem 2.4. Then there exists $\beta_{c}$ such that for any each $\beta \in\left(0, \beta_{c}\right)$ there exists $\hbar_{0}>0$ such that for any $\hbar \in\left(0, \hbar_{0}\right)$ the constant $C_{\alpha, \beta, \gamma, \hbar}$ is strictly positive, and hence, $z=E-\mathrm{i} \mu \beta$ is not a resonance of $H=-\frac{\hbar^{2}}{2} \Delta-\frac{1}{2}|x|^{2 s}+q(x)$.

Remarks 2.6. (1) Let us take the sequence $\left\{\phi_{s, \lambda, n}\right\}_{n \in \mathbb{N}} \subset L^{2}\left(\mathbb{R}^{d}\right)$ :

$$
\phi_{s, \lambda, n}=c_{s, n} \eta_{n}(f) r^{-(d+s-1) / 2} \exp \left\{\mathrm{i}\left(\frac{1}{1+s} r^{1+s}+\lambda f+\theta(r)\right) / \hbar\right\},
$$

where $\lambda \in \mathbb{R}, c_{s, n}$ is a normalizing constant, $\eta_{n}$ is a smooth cut-off function which is obeying supp $\eta_{n} \subset\left[2^{n}, 2^{n+1}\right]$ and

$$
f=f(r)= \begin{cases}\frac{1}{1-s}\left(r^{1-s}-1\right)+1 & \text { for } s<1 \\ \log r+1 & \text { for } s=1\end{cases}
$$

Moreover $\theta(r)$ is a certain smooth function which depends on $s$ and $\rho$, and satisfy

$$
\left(r^{s}+\lambda r^{-s}+\partial_{r} \theta(r)\right)^{2}-\left(r^{2 s}+\lambda-q\right)=o(1)
$$

as $r \rightarrow \infty$. For example, if $\rho>s$ it is sufficient to take $\theta(r)$ as

$$
\theta(r)=-\int_{2}^{r} q(\tilde{r} \omega) \tilde{r}^{-s} \mathrm{~d} \tilde{r} .
$$

Then we can see that for $\theta=\mathrm{i} \beta$ and for any $\lambda \in \mathbb{R}$

$$
\begin{aligned}
\left\|\left(H_{\theta}-(\lambda-(1-s) \beta \mathrm{i})\right) \phi_{s, \lambda, n}\right\| \rightarrow 0 & \text { for } s<1, \\
\left\|\left(H_{\theta}-(\lambda-\beta \mathrm{i})\right) \phi_{s, \lambda, n}\right\| \rightarrow 0 & \text { for } s=1
\end{aligned}
$$

as $n \rightarrow \infty$, and hence the essential spectrum of $H_{\theta}$ with $\theta=\mathrm{i} \beta$ is

$$
\sigma_{\text {ess }}\left(H_{\theta}\right)= \begin{cases}\{z \in \mathbb{C} \mid \operatorname{Im} z=-(1-s) \beta\} & \text { for } s<1 \\ \{z \in \mathbb{C} \mid \operatorname{Im} z=-\beta\} & \text { for } s=1\end{cases}
$$

The eigenvalues of $H_{\theta}$ would appear, if it exist, in the strip $\{z \in \mathbb{C} \mid 0<-\operatorname{Im} z<$ $(1-s) \beta\}$ for $s<1$, or $\{z \in \mathbb{C} \mid 0<-\operatorname{Im} z<\beta\}$ for $s=1$.
(2) The bound of (iii) is a virial type condition, and it comes from an estimate of the Poisson bracket

$$
\left.\{h, a\}\right|_{h=E}=\left.\left[\frac{\partial h}{\partial \xi} \cdot \frac{\partial a}{\partial x}-\frac{\partial h}{\partial x} \cdot \frac{\partial a}{\partial \xi}\right]\right|_{h=E},
$$

where $h=\frac{1}{2} \xi^{2}-\frac{1}{2}|x|^{2 s}+q(x)$ is the classical mechanics version of $H$ and

$$
a=(\partial g) \cdot \xi \text { with } g= \begin{cases}\frac{1}{2(1-s)} r^{2-2 s} & \text { for } s<1, \\ \frac{1}{2}(\log r)^{2} & \text { for } s=1 .\end{cases}
$$

Since $g$ is non-negative and $g=O\left(t^{2}\right)$ as $t \rightarrow \infty$ in the classical mechanics sense, the quantity $\left.\{h, a\}\right|_{h=E}$ is expected to be positive.
(3) Our $r_{\theta}$ has satisfies

$$
r_{\theta}=\left(r^{2 s}+2 s \theta \chi_{R}\left(r^{2 s}\right)\right)^{2 s} \rightarrow \mathrm{e}^{\theta} r \quad \text { as } \quad s \downarrow 0
$$

for any $r>2 R$. In this sense, we can regard our main result as a generalization of that for perturbed Laplacian. We can also discuss resonance free domain for the repulsive Hamiltonians $H$ by using the dilation. If we use the dilation we need to assume that $q_{\theta}$ is analytic in a sector $\left\{\left|\operatorname{Im~}^{\theta} x\right|<c_{1}\left|\operatorname{Re}^{\theta} x\right|\right\} \backslash\left\{\left|\operatorname{Re}^{\theta} x\right|<c_{2}\right\}$ for some $c_{1}, c_{2}>0$. However this sector is wider than the region in which analyticity of $q_{\theta}$ is required in Condition 2.2. In fact, since we have for large $r=|x|$

$$
r_{\theta} \sim r\left(1+\theta \chi_{R}\left(r^{2 s}\right) r^{-2 s}\right)
$$

$\operatorname{Im} r_{\theta}$ diverges slower than $\operatorname{Im} \mathrm{e}^{\theta} r$ as $r \rightarrow \infty$. Especially, if $s>1 / 2$, $\operatorname{Im} r_{\theta}$ decays as $r \rightarrow \infty$. Hence by using our distortion instead of the dilation we can deal with a large class of potentials. This is a novelty of the present paper.

We also mention the case of Stark Hamiltonian. Roughly speaking, Stark Hamiltonian is corresponding to the case of $s=1 / 2$. In [5, Section 23.1] and [7], they study resonances by introducing a distortion $x \mapsto x+\theta v(x)$ for $\theta \in \mathbb{C}$ with $|\theta| \ll 1$, where $v$ is a certain bounded smooth function. The size of both of the regions $\left\{x+\theta v(x) \mid x \in \mathbb{R}^{d}\right\}$ and $\left\{r_{\theta}(x) \mid x \in \mathbb{R}^{d}, s=1 / 2\right\}$ in $\mathbb{C}$ are almost the same.

## 3 Examples

This is a short section, which we discuss the choice of $\alpha, \gamma>0$ and $\chi, \tilde{\chi} \in C^{1}$ of the assumptions of the theorem for free semiclassical repulsive Hamiltonian $H=H_{0}$.

First we let $s \in(0,1)$. We take any $E<0$. If $s \geq 1 / 2$, the bound

$$
1-s+2(1-2 s) r^{-2 s} E-\mu \geq \gamma
$$

always hold for any $\mu \in(0,1-s)$ and $\gamma \in(0,1-s-\mu)$. Then for any $\alpha \in$ ( $0,-E$ ), we can easily construct functions $\chi$ and $\tilde{\chi}$ which obeying the assumptions of the theorem. Let us consider the case of $s<1 / 2$. For any $\mu \in(0, s)$ and $\alpha \in\left(0,-\left(1-\frac{1-2 s}{1-s-\mu}\right) E\right)$, we take and fix a constant $c \in\left(\frac{1-2 s}{1-s-\mu} \frac{E}{E+\alpha}, 1\right)$. Then by taking smooth cut-off functions $\chi$ and $\tilde{\chi}$ which satisfy

0 & \text { on }\left\{r=|x| \in \mathbb{R} \left\lvert\,-\frac{1}{2} r^{2 s}-E \leq \alpha\right.\right\},
\end{array} \quad \tilde{\chi}=\sqrt{1-\chi^{2}},\right.

we obtain on $\operatorname{supp} \tilde{\chi}$ that for some $\gamma>0$

1-s+2(1-2 s) r^{-2 s} E-\mu \geq 1-s-(1-2 s) \frac{E}{c(E+\alpha)}-\mu>\gamma
$$

Next we let $s=1$. In this case, we need restriction $E<-1 / 2$ to obtain the bound

1-2 r^{-2}(\log r-1) E-\mu \geq \gamma \text { on } \operatorname{supp} \tilde{\chi} \tag{3.1}
\end{equation*}

for some $\mu, \gamma>0$. For $\alpha \in(0,-(2 E+1) / 4)$ we introduce smooth functions $\chi$ and $\tilde{\chi}$ as

\end{array} \quad \tilde{\chi}=\sqrt{1-\chi^{2}} .\right.
$$

When $E<-\mathrm{e}^{2} / 2$, by retaking $\alpha \in\left(0,-\left(2 E+\mathrm{e}^{2}\right) / 4\right)$, we can see that the term $-2 r^{-2}(\log r-1) E$ is non-negative on supp $\tilde{\chi}$. Thus for any $\mu \in(0,1)$ and $\gamma \in(0,1-$ $\mu)$, the bound (3.1) holds. Let $E \in\left[-\mathrm{e}^{2} / 2,-1 / 2\right)$. Then for any $\mu \in\left(0, \frac{1}{2} \log (-2 E)\right)$ there exist $\alpha>0$ and $\gamma>0$ such that the bound (3.1) holds. In fact, for sufficiently small $\alpha>0$ we have on supp $\tilde{\chi}$

& \geq \frac{1}{2} \log (-2 E)-\mu+\frac{2 \alpha}{E+2 \alpha}+\frac{E}{2(E+2 \alpha)} \log \left(\frac{E+2 \alpha}{E}\right)-\frac{\alpha}{E+2 \alpha} \log (-2 E) \\
& >0
\end{aligned}
$$

## 4 Proof of the theorem

### 4.1 Sub-quadratic repulsive Hamiltonian

In this section we give a proof of Theorem 2.4 for $s \in(0,1)$.
Proof of Theorem 2.4 with $s \in(0,1)$. Let $\theta=\mathrm{i} \beta$. Take any $u \in \mathcal{D}\left(H_{\theta}\right),\|u\|=1$. Then we set $v={\left.\overline{\left(\frac{\partial r}{\partial r}\right.}\right)^{2}}^{2}\left(\chi^{2}-\mathrm{i} \tilde{\chi}^{2}\right) u$. Note that $\|v\| \leq(1+O(\beta))\|u\|$. We show that for $z=E-\mathrm{i} \beta \mu$

& \operatorname{Re}\left\langle v,\left(H_{\theta}-z\right) u\right\rangle \\
& \geq\left(\min \{\alpha, \beta \gamma\}+O\left(\hbar^{2}\right)+O\left(\beta^{2}\right)\right)\|u\|^{2}+\beta^{2} \operatorname{Re}\left\langle u, \psi(r)\left(H_{\theta}-z\right) u\right\rangle, \tag{4.1}
\end{align*}
$$

where $\psi(r)$ is a certain bounded function. Then by combining with the inequalities

(1+O(\beta))\|u\|\left\|\left(H_{\theta}-z\right) u\right\| & \geq\|v\|\left\|\left(H_{\theta}-z\right) u\right\| \geq \operatorname{Re}\left\langle v,\left(H_{\theta}-z\right) u\right\rangle \\
O\left(\beta^{2}\right)\|u\|\left\|\left(H_{\theta}-z\right) u\right\| & \geq-\beta^{2} \operatorname{Re}\left\langle u, \psi(r)\left(H_{\theta}-z\right) u\right\rangle
\end{aligned}
$$

we have the assertion.
The left-hand side of (4.1) is expressed as

& -\frac{\hbar^{2}}{2} \operatorname{Im}\left\langle\tilde{\chi}^{2} u,\left(\frac{\partial r_{\theta}}{\partial r}\right)^{2} U_{\theta}(-\Delta) U_{\theta}^{-1} u\right\rangle  \tag{4.2}\\
& +\operatorname{Re}\left\langle\chi u,\left(\frac{\partial r_{\theta}}{\partial r}\right)^{2}\left(-\frac{1}{2} r_{\theta}^{2 s}+q_{\theta}-z\right) \chi u\right\rangle \\
& -\operatorname{Im}\left\langle\tilde{\chi} u,\left(\frac{\partial r_{\theta}}{\partial r}\right)^{2}\left(-\frac{1}{2} r_{\theta}^{2 s}+q_{\theta}-z\right) \tilde{\chi} u\right\rangle .
\end{align*}

Let us further compute each term on the right-hand side of (4.2). First we compute the factor $\left(\frac{\partial r_{\theta}}{\partial r}\right)^{2} U_{\theta}(-\Delta) U_{\theta}^{-1}$.

We remark that $\phi$ is a complex-valued smooth function having bounded derivatives. By the identity

where $C_{1}>0$ is a certain constant which is independent of both $\hbar$ and $\beta$. In the following we frequently use the Cauchy-Schwarz inequality without mentioning.

As for the second term of (4.2), we evaluate it by using assumption (i) of the theorem. We have for any $\varepsilon \in(0,1)$

### 4.2 Inverted harmonic oscillator

This is the last section and we give a proof of Theorem 2.4 for $s=1$. Since the proof is quite similar to that for $s \in(0,1)$, we sometimes omit computations.

Proof of Theorem 2.4 with $s=1$. Let $\theta=\mathrm{i} \beta$. Take any $u \in \mathcal{D}\left(H_{\theta}\right),\|u\|=1$. Then we set $v={\overline{\left(\frac{\partial r \theta}{}\right.} \partial{ }^{2 r}}^{2}\left(\chi^{2}-\mathrm{i} \tilde{\chi}^{2}\right) u$. Note that $\|v\| \leq(1+O(\beta))\|u\|$. We show that for $z=E-\mathrm{i} \beta \mu$

& J^{-1}\left(\partial_{r} J\right)=-\theta(d-2)\left(r_{\theta} / r\right)^{-2} r^{-3}(2 \log r-1), \\
&\left(\frac{\partial r_{\theta}}{\partial)^{-1}\left(\frac{\partial^{2} r_{\theta}}{\partial r^{2}}\right)}=\theta\left(r_{\theta} / r\right)^{-2} r^{-3}(2 \log r-1)-2 r^{-3} \theta /\left(1+r^{-2} \theta\right),\right. \\
&\left(\frac{\partial r_{\theta}}{\partial r}\right)\left(r_{\theta} / r\right)^{-1}-1=\left(r_{\theta} / r\right)^{-2}\left(1+r^{-2} \theta\right)-1, \\
&\left(\frac{\partial r_{\theta}}{\partial r}\right)^{2}\left(r_{\theta} / r\right)^{-2}-1=\left(r_{\theta} / r\right)^{-4}\left(1+r^{-2} \theta\right)^{2}-1
\end{aligned}
$$

and

$$
\left(r_{\theta} / r\right)^{-2}=\frac{1}{1+2 \theta r^{-2} \log r}=\frac{1-\mathrm{i} 2 \beta r^{-2} \log r}{1+4 \beta^{2} r^{-4}(\log r)^{2}}
$$

we have

$$
\begin{aligned}
& -\frac{\hbar^{2}}{2} \operatorname{Im}\left\langle\tilde{\chi}^{2} u,\left[J^{-1}\left(\partial_{r} J\right)+\left(\frac{\partial r_{\theta}}{\partial r}\right)^{-1}\left(\frac{\partial^{2} r_{\theta}}{\partial r^{2}}\right)-(d-1)\left(\left(\frac{\partial r_{\theta}}{\partial r}\right)\left(r_{\theta} / r\right)^{-1}-1\right) r^{-1}\right] \partial_{r} u\right\rangle \\
& \geq-2 \hbar^{2} \beta^{2}\left|\left\langle\tilde{\chi} u, \frac{r^{-5} \log r(2 \log r-1)}{1+4 \beta^{2} r^{-4}(\log r)^{2}} \partial_{r} \tilde{\chi} u\right\rangle\right|-\hbar^{2} \beta^{2}\left|\left\langle\tilde{\chi} u, \frac{r^{-5}}{1+\beta^{2} r^{-4}} \partial_{r} \tilde{\chi} u\right\rangle\right|+O\left(\hbar^{2}\right)\|u\|^{2}
\end{aligned}
$$

and, by using assumption (i),

$$
\begin{aligned}
& -\frac{\hbar^{2}}{2} \operatorname{Im}\left\langle\tilde{\chi}^{2} u,-\left(\left(\frac{\partial r_{\theta}}{\partial r}\right)^{2}\left(r_{\theta} / r\right)^{-2}-1\right) r^{-2} \Delta_{\mathbb{S}^{d-1}} u\right\rangle \\
& \geq-C_{1} \hbar^{2} \beta^{3}\left\langle\tilde{\chi}^{2} u, r^{-6}(\log r)\left(-r^{-2} \Delta_{\mathbb{S}^{d-1}}\right) u\right\rangle .
\end{aligned}
$$

By a bootstrap argument we can obtain the bounds, for sufficiently small $\beta>0$,

$$
\begin{aligned}
& -2 \hbar^{2} \beta^{2}\left|\left\langle\tilde{\chi} u, \frac{r^{-5} \log r(2 \log r-1)}{1+4 \beta^{2}{ }^{2}-4(\log r)^{2}} \partial_{r} \tilde{\chi} u\right\rangle\right| \\
& \geq-\beta^{2} \operatorname{Re}\left\langle u, \psi_{1}(r)\left(H_{\theta}-z\right) u\right\rangle+O\left(\beta^{2}\right)\|u\|^{2}, \\
& -\hbar^{2} \beta^{2}\left|\left\langle\tilde{\chi} u, \frac{r^{-5}}{1+\beta^{2} r^{-4}} \partial_{r} \tilde{\chi} u\right\rangle\right| \\
& \geq-\beta^{2} \operatorname{Re}\left\langle u, \psi_{2}(r)\left(H_{\theta}-z\right) u\right\rangle+O\left(\beta^{2}\right)\|u\|^{2}
\end{aligned}
$$

and

$$
\begin{aligned}
& -C_{1} \hbar^{2} \beta^{3}\left\langle\tilde{\chi}^{2} u, r^{-6}(\log r)\left(-r^{-2} \Delta_{\mathbb{S}^{d-1}}\right) u\right\rangle \\
& \geq-\beta^{3} \operatorname{Re}\left\langle u, \psi_{3}(r)\left(H_{\theta}-z\right) u\right\rangle+O\left(\beta^{2}\right)\|u\|^{2} .
\end{aligned}
$$

Here $\psi_{j}$ 's are uniformly bounded smooth functions, although they depend on $\beta>0$. Therefore by (4.6) with $\varepsilon=1 / 4$, we have

$$
\begin{align*}
& -\frac{\hbar^{2}}{2} \operatorname{Im}\left\langle\tilde{\chi}^{2} u,\left(\frac{\partial r_{\theta}}{\partial r}\right)^{2} U_{\theta}(-\Delta) U_{\theta}^{-1} u\right\rangle \\
& \geq-\beta^{2} \operatorname{Re}\left\langle u, \psi_{4}(r)\left(H_{\theta}-z\right) u\right\rangle-\frac{\hbar^{2}}{4}\|\nabla(\chi u)\|^{2}+O\left(\hbar^{2}\right)\|u\|^{2}+O\left(\beta^{2}\right)\|u\|^{2}, \tag{4.16}
\end{align*}
$$

where $\psi_{4}=\psi_{1}+\psi_{2}+\beta \psi_{3}$. Let us bound the third and the fourth term of (4.14) by using the assumptions (ii) and (iii) of the theorem, respectively. Using the Taylor expansion of $q_{\theta}$ in $\theta$

$$
q_{\theta}=q+r^{-1} \log r \chi_{R}\left(r^{2}\right)\left(\partial_{r} q\right) \theta+O\left(\theta^{2}\right),
$$

we have

$$
\begin{align*}
\operatorname{Re}\left\langle\chi u,\left(\frac{\partial r_{\theta}}{\partial r}\right)^{2}\left(-\frac{1}{2} r_{\theta}^{2}+q_{\theta}-z\right) \chi u\right\rangle & =\left\langle\chi u,\left(-\frac{1}{2} r^{2}+q-E+O\left(\beta^{2}\right)\right) \chi u\right\rangle  \tag{4.17}\\
& \geq \alpha\|\chi u\|^{2}+O\left(\beta^{2}\right)\|u\|^{2} .
\end{align*}
$$

Similarly, we can see that

$$
\begin{align*}
& -\operatorname{Im}\left\langle\tilde{\chi} u,\left(\frac{\partial r_{\theta}}{\partial r}\right)^{2}\left(-\frac{1}{2} r_{\theta}^{2}+q_{\theta}-z\right) \tilde{\chi} u\right\rangle \\
& =-\left\langle\tilde{\chi} u,\left[-2 r^{-2} \log r\left(-\frac{1}{2} r^{2}+q-E\right)+2 r^{-2}\left(-\frac{1}{2} r^{2}+q-E\right)\right.\right. \\
& \left.\left.\quad \quad+\left(-\log r+r^{-1} \log r\left(\partial_{r} q\right)+\mu\right)\right] \beta \tilde{\chi} u\right\rangle+O\left(\beta^{2}\right)\|u\|^{2}  \tag{4.18}\\
& \geq \beta \gamma\|\tilde{\chi} u\|^{2}+O\left(\beta^{2}\right)\|u\|^{2} .
\end{align*}
$$

Hence by the expression (4.14) and the bounds (4.15)-(4.17) and (4.18), we finally have

$$
\begin{aligned}
\operatorname{Re}\left\langle v,\left(H_{\theta}-z\right) u\right\rangle \geq & \left(\min \{\alpha, \beta \gamma\}+O\left(\hbar^{2}\right)+O\left(\beta^{2}\right)\right)\|u\|^{2} \\
& -\beta^{2} \operatorname{Re}\left\langle u, \psi_{4}(r)\left(H_{\theta}-z\right) u\right\rangle
\end{aligned}
$$

for sufficiently small $\beta>0$, and then the assertion (4.13) follows.
